

## COLLISION OF TWO SOLITONS FOR $1d$ NONLINEAR SCHRÖDINGER EQUATION WITH THE SAME MASS

ABSTRACT. We study the global dynamics of the collision of two opposite solitons having the same mass for one-dimensional Nonlinear Schrödinger models with multi-power nonlinearity. For any natural number  $k$ , it is verified that if the incoming speed  $v$  between the two solitary waves is small enough, then, due to the interaction force between the solitons, the two solitary waves will move away with an outgoing speed  $v_f = v + O(v^k)$  after the collision and the remainder of the solution will also have energy and weighted norms of order  $O(v^k)$ . This is applied to the one-dimensional Nonlinear Schrödinger equations having an odd polynomial nonlinearity with stable solitons such as the cubic NLS, and cubic-quintic NLS.

### 1. INTRODUCTION

In this manuscript, we consider the following one-dimensional nonlinear Schrödinger model

$$(1.0.1) \quad \Lambda(u)(t) := iu_t + u_{xx} + F'(|u|^2)u = 0,$$

such that  $F$  is a real polynomial satisfying a real function satisfying

$$(H1) \quad F(0) = 0, F'(0) = 0.$$

One particular example of (1.0.1) corresponds to the one-dimensional cubic Schrödinger equation, which is given by

$$(Cubic NLS) \quad iu_t + u_{xx} + 2|u|^2u = 0.$$

The partial differential equation (Cubic NLS) is known to be completely integrable and that there are explicit formulas for its solutions including the multi-soliton solutions, see the classical work of [37]. Moreover, all the solutions of (Cubic NLS) with finite energy are invariant under infinite invariances including the following

- $u_\mu(t, x) = \mu u(\mu^2 t, \mu x)$  (dilation),
- $\tau_\zeta u(t, x) = u(t, x - \zeta)$  (space translation),
- $\iota_\delta u(t, x) = u(t + \delta, x)$  (time translation),
- $\sigma_\theta u(t, x) = e^{i\theta} u(t, x)$  (phase shift),
- $\Theta_v u(t, x) = u(t, x - vt) e^{i(\frac{vx}{2} - \frac{vt^2}{4})}$  (Galilean Transformation).

Moreover, It is standard to verify that any strong solution of (1.0.1) is invariant under space translation, time translation, and phase shift.

Furthermore, the integrability of (Cubic NLS) also implies that all the strong solutions of the cubic Schrödinger model satisfy infinite conserved quantities. However, since many models of the

form (1.0.1) are not integrable, we will only use the following conserved quantities

$$(Hamiltonian) \quad H(u) = \int_{\mathbb{R}} \frac{|u_x|^2}{2} - \frac{F(|u|^2)}{2}, dx,$$

$$(Mass) \quad Q(u) = \int_{\mathbb{R}} |u|^2 dx,$$

$$(Momentum) \quad M(u) = \text{Im} \int_{\mathbb{R}} \bar{u}u_x dx.$$

In addition, the partial differential equation (1.0.1) can be used to describe one-dimensional nonlinear Schrödinger with double power nonlinearity such as cubic-quintic models, which for real parameters  $a, b$  is given by the following partial differential equation

$$(1.0.2) \quad iu_t + u_{xx} + a|u|^2u + b|u|^4u = 0.$$

Different from (Cubic NLS), this model is non-integrable and we cannot use the inverse scattering transform to describe explicitly the strong solutions of (1.0.2) for all time  $t$ . The model (1.0.2) has many physical applications, see [12], [4], [13], [14], [34] and [11] for example.

Moreover, the partial differential equation (1.0.1) also includes the one-dimensional Schrödinger with triple power nonlinearity such as the following partial differential equation

$$(1.0.3) \quad iu_t + u_{xx} + a|u|^{2n}u + b|u|^{2m}u + c|u|^{2l}u = 0,$$

for real parameters  $a, b, c$ . The study of the dynamics of soliton and multi-solitons for the model (1.0.3) is of great interest to Optical Physics, see for example [1], [38]. Concerning one-dimensional Schrödinger with four-power nonlinearity, see also the article [33] of the field of Optical physics.

Next, concerning the existence of solutions (Standing wave) of the partial differential equation (1.0.1), we consider the Theorem 5 from the article [2] by Berestycki and Lions.

**Theorem 1.1.** *Let  $\omega > 0$ , if*

$$T_\omega(y) := -\omega \frac{y^2}{2} + \frac{F(|y|^2)}{2}$$

*satisfies for some  $y_0 > 0$*

$$(H2) \quad T(y_0) = 0,$$

$$(H3) \quad T'(y_0) > 0 \text{ and } T(y) > 0 \text{ for all } y > y_0,$$

*then the ordinary differential equation*

$$(1.0.4) \quad \begin{cases} -\phi_\omega'' = T_\omega'(\phi_\omega) = -\omega\phi_\omega + F'(\phi_\omega^2)\phi_\omega, \\ \phi_\omega(0) = y_0 \end{cases}$$

*has a unique positive solution  $\phi_\omega \in H^1(\mathbb{R})$ .*

**Remark 1.2.** *Indeed,  $\phi_\omega$  shall be an even function and under the assumption that  $F$  satisfies (H1), we can verify that there is a real number  $a_{+\infty} > 0$  satisfying*

$$\lim_{x \rightarrow \pm\infty} \phi_\omega(x) e^{\pm\sqrt{\omega}x} = a_{+\infty}.$$

**Remark 1.3.** *Furthermore, from the article [2],  $\phi_\omega$  shall satisfy for all  $x \geq 0$*

$$(1.0.5) \quad \phi_\omega'(x) = -\sqrt{\omega\phi_\omega(x)^2 - F(\phi_\omega^2)}.$$

*Consequently, using the change of variables  $y(x) = e^{-\sqrt{\omega}x}$  and considering  $\mathcal{G}_\omega(y) := e^{\sqrt{\omega}x}\phi_\omega(x)$ , the ordinary differential equation (1.0.5) can be rewritten for  $x > 1$  as*

$$(1.0.6) \quad \begin{cases} \frac{d}{dy} \mathcal{G}_\omega(y) = \frac{1}{y} \left( \left[ \mathcal{G}_\omega(y)^2 - \frac{F(\mathcal{G}_\omega(y)^2 y^2)}{y^2 \omega} \right]^{\frac{1}{2}} - \mathcal{G}_\omega(y) \right), \\ \mathcal{G}_\omega(0) = a_{+\infty}. \end{cases}$$

Consequently, since  $F$  satisfies (H1), the function

$$H(z, y) = \frac{1}{y} \left( \left[ z^2 - \frac{F(z^2 y^2)}{y^2 \omega} \right]^{\frac{1}{2}} - z \right)$$

has an analytic extension over some set of the form  $\{(z, y) \in \mathbb{C}^2 \mid |z - a_{+\infty}| + |y| < \delta\}$ , we can verify using Piccard-Lindelöf Theorem that there exists a unique holomorphic function  $\mathcal{G}_\omega(y)$  satisfying (1.0.6) over a set  $\{|y| \leq \delta\}$ . This implies for a  $\delta_\omega > 0$  depending on  $\omega$  and  $F$  the existence of a real analytic function  $\mathcal{P}$  satisfying  $\mathcal{P}(0) = 0$ ,  $\mathcal{P}'(0) \neq 0$  and

$$(1.0.7) \quad \phi_\omega(x) = \mathcal{P} \left( e^{-\sqrt{\omega}|x|} \right), \text{ if } |x| \geq \delta_{\delta_\omega}.$$

Moreover, since  $\phi_\omega$  also satisfies (1.0.4), we can verify by induction that  $\mathcal{P}$  is an odd analytic function.

In this paper, we are only going to consider the partial differential equations (1.0.1) such that there exists  $\omega > 0$  satisfying Theorem 1.1. As a consequence, if  $\omega > 0$  satisfies all the hypotheses in the statement of Theorem 1.1, then the following function

$$(Standing \ wave) \quad u(t, x) = e^{i\omega t} \phi_\omega(x)$$

is a strong solution of the partial differential equation (1.0.1) in the space  $C(\mathbb{R}, H^1(\mathbb{R}, \mathbb{C}))$ . Moreover, under the hypotheses of Theorem 1.1, we can obtain using the Galilean transformation in the solution (Standing wave) the following set of solutions

$$u(t, x) = \phi_\omega(x - vt - y) e^{i(\omega t + \gamma)} e^{i\left(\frac{vx}{2} - \frac{v^2 t}{4}\right)},$$

for any  $v, y, \gamma \in \mathbb{R}$ , which are denominated by solitary waves.

The stability theory of the solitons for Nonlinear Schrödinger models was studied by Grillakis, Shatah, and Strauss in the articles [6], [7]. In addition, there have been several research about the asymptotic stability of solitons for one-dimensional Nonlinear Schrödinger models. See for example [5], [3], [17], [15], [22], [21] and [31].

Moreover, it was proved the following proposition in article [6].

**Lemma 1.4.** *If the function  $\phi_\omega(x)$  satisfies*

$$(H4) \quad \frac{d}{d\omega} \int_{\mathbb{R}} |\phi_\omega(x)|^2 > 0,$$

for some  $\omega = \omega_1$ , then the soliton  $\phi_\omega(x)$  is orbital stable in the space  $H^1(\mathbb{R})$ . Otherwise, if

$$(1.0.8) \quad \frac{d}{d\omega} \int_{\mathbb{R}} |\phi_\omega(x)|^2 < 0,$$

then the soliton  $\phi_\omega$  is unstable.

Furthermore, in the article [28], using Lemma 1.4, Ohta studied the stability and instability of one-dimensional Nonlinear Schrödinger models with double-power nonlinearity such as the one-dimensional cubic-quintic Schrödinger equation given in (1.0.2).

We can now state our main theorems.

**Theorem 1.5.** *Let  $F$  be any real polynomial and  $\omega > 0$  both satisfying hypotheses (H1), (H2), (H3), (H4). There exists constants  $C > 0$ ,  $M > 1$  and, for any  $k \in \mathbb{N}$ , there is  $\delta_k \in (0, 1)$  such that for any  $v_1 \in \mathbb{R}$  if  $0 < v < \delta_k$ , and  $u$  is the unique solution of (1.0.1) satisfying*

$$(1.0.9) \quad \lim_{t \rightarrow +\infty} \left\| e^{-i\omega t} u(t, x) - \phi_\omega(x - (v + v_1)t) e^{i\left(\frac{(v+v_1)x}{2} - \frac{(v+v_1)^2 t}{4}\right)} + \phi_\omega(x + (v - v_1)t) e^{i\left(-\frac{(v-v_1)x}{2}\right) - \frac{(v-v_1)^2 t}{4}} \right\|_{H^1} e^{ct} = 0,$$

for a  $c > 0$ , then there are functions  $\gamma, \zeta$  of class  $C^1$  satisfying for all  $t < \frac{-2Ck|\ln v|}{v}$

$$(1.0.10) \quad \left\| e^{-i\gamma(t)}u(t) - \left[ \phi_\omega(x - \zeta(t) - v_1t)e^{i\left(-\frac{(v-v_1)x}{2} - \frac{v_1^2t}{4}\right)} - \phi_\omega(x + \zeta(t) - v_1t)e^{i\left(\frac{(v+v_1)x}{2} - \frac{v_1^2t}{4}\right)} \right] \right\|_{L^2} < v^k,$$

$$\left\| \frac{\partial}{\partial x} \left[ e^{-i\frac{v_1x}{2}}u(t) - \left( \phi_\omega(x - \zeta(t) - v_1t)e^{i\left(\gamma(t) - \frac{vx}{2} - \frac{v_1^2t}{4}\right)} - \phi_\omega(x + \zeta(t) - v_1t)e^{i\left(\gamma(t) + \frac{vx}{2} - \frac{v_1^2t}{4}\right)} \right) \right] \right\|_{L^2} < v^k,$$

and

$$(1.0.11) \quad \left| \dot{\gamma}(t) - \omega + \frac{v^2}{4} \right| + |\dot{\zeta}(t) + v| < v^k,$$

for all  $t \leq \frac{-|\ln v|^{\frac{4}{3}}}{v}$ .

Moreover, for any  $l \in \mathbb{N}$ , there exists  $0 < \delta_{k,l} < \delta_k$  such that if  $0 < v < \delta_{k,l}$ , then

$$(1.0.12) \quad \left\| (1 + |x|^l) \left[ e^{-i\gamma + \frac{v_1t^2}{4}}u(t) - \phi_\omega(x - \zeta(t) - v_1(t))e^{i\left(\frac{-(v+v_1)x}{2}\right)} + \phi_\omega(x + \zeta(t) - v_1t)e^{i\left(\frac{(v+v_1)x}{2}\right)} \right] \right\|_{L^2} < v^k$$

for any  $\frac{-2|\ln v|^{\frac{4}{3}}}{v} \leq t \leq \frac{-|\ln v|^{\frac{4}{3}}}{v}$ .

**Remark 1.6.** From Theorems 4.5, 3.1 and Lemma 3.0.14, we have that  $\zeta(t) = -vt + c_\omega \ln \frac{1}{v} + O(v^2)$  as  $t$  approach  $-\infty$  for some real constant  $c_\omega$ . The shift  $c_\omega \ln \frac{1}{v}$  follows from the repulsive force between the two solitons having opposite phases, see Lemma 3.0.14.

**Remark 1.7.** Concerning the case where the two solitons have a small difference in their masses, the behavior of the solution is expected to be different because of the symmetry break of the ordinary differential equations associated with the parameters  $\zeta, \gamma, \omega$  and  $v$ . This argument was used in [20] by Martel and Merle to describe the collision of two solitons for the quartic  $gKdV$ , see also the work [29] of Perelman to describe the collision of two different solitons for (1.0.1) in the case where  $F$  is  $C^2$  and  $F''(0) \neq 0$ .

**Remark 1.8.** From the estimates (1.0.12) considered in Theorem 1.5, we might expect to be able to verify new phenomena as the scattering of the remainder for example. In the article [5] of Collot and Germain, similar hypotheses in the weighted norm were considered for the proof of the asymptotic stability of a single soliton for (1.0.1).

**Remark 1.9.** Moreover, because of the Galilean Transformation invariance, it is enough to prove the Theorem 1.5 when  $v_1 = 0$ .

**Theorem 1.10.** There  $\delta_0 > 0$  such that if  $0 < v < \delta_0$ , then the solution of (1.0.1) satisfying for  $T > 1, c > 0$  and any  $t \geq T$

$$(1.0.13) \quad \left\| u(t, x) - \phi_\omega(x - vt)e^{i\left(\omega t + \frac{vx}{2} - \frac{v^2t}{4}\right)} + \phi_\omega(x + vt)e^{i\left(\omega t + \frac{-vx}{2} - \frac{v^2t}{4}\right)} \right\|_{H^1} = O(e^{-c|t|}),$$

is unique. Furthermore, there is  $\delta_{l,m} > 0$  such that if  $0 < v < \delta_{l,m}$ , then the solution  $u$  satisfies for any  $m, l \in \mathbb{N}$  and  $t \geq 10(l + m + 1)T$ , then

$$(1.0.14) \quad \left\| (1 + x^2)^{\frac{l}{2}} \left[ u(t, x) - \phi_\omega(x - vt)e^{i\left(\omega t + \frac{vx}{2} - \frac{v^2t}{4}\right)} + \phi_\omega(x + vt)e^{i\left(\omega t + \frac{-vx}{2} - \frac{v^2t}{4}\right)} \right] \right\|_{H^m} = O\left(e^{-c|t|}\right).$$

**Remark 1.11.** From the proof of Theorem 1.10, we obtain  $c = \frac{3\sqrt{\omega}v}{4}$  and  $T = \frac{4\ln\left(\frac{1}{v}\right)}{\sqrt{\omega}v}$ .

**Remark 1.12.** It is expected that we can repeat the argument used in the proof of Theorem 1.10 to verify the uniqueness of multi-solitons for (1.0.1) when the norm remainder has exponential decay. The existence of multi-solitons for one-dimensional Nonlinear Schrödinger models was already

verified in [18] by Martel and Merle. However, the parameters  $c, T$  obtained in the article [18] satisfying 1.0.13 are not good for our analysis of the long-time behavior of the collision of the two solitons. Therefore, we consider Theorem 1.10 for the collision of two solitons. Therefore, we consider Theorem 1.10 for our article.

The Theorem 1.5 describes globally the collision between two stable solitons with the same mass and opposite phases for any model of the form (1.0.1) such as the cubic (Cubic NLS), the cubic-quintic (1.0.2) which is non-integrable and also one-dimensional models with multi power nonlinearity such as the (1.0.3). Moreover, the estimates (1.0.10) and (1.0.11) imply that the collision between the two solitons is almost elastic, because, for any  $k \in \mathbb{N}$ , the energy norm in the remainder and the change in the size of the speed of propagation of each soliton after the collision can be of order  $O(v^k)$ . This conclusion is quite surprising since this is not much expected for non-integrable models of the form (1.0.10).

Concerning the study of the interaction between solitons for Nonlinear Schrödinger models, there exist previous works. In [29], Perelman studied the collision between a large soliton and a small soliton and concluded that the solution doesn't preserve the two solitons' structure during a finite long-time interval after the collision. In the article [9], Holmer and Lin studied the interaction between two solitons with the same mass for the model (Cubic NLS) having the same or opposite phase. Concerning collision between solitons of Nonlinear Schrödinger models having high speed, see the article [32] by Salem, Fröhlich, and Sigal.

In this paper, using the methods from [23], [24], we are going to analyze the collision of two identical stable solitons of (1.0.1) having low differences in their speeds.

Since similar methods were used by the author in [24] in a non-integrable one-dimensional nonlinear wave equation, we believe the method used in this paper has applications in a large set of one-dimensional nonlinear dispersive models.

The mathematical research of the collision phenomena between solitons hasn't been restricted only to Schrödinger models. In the articles [19] and [20], Martel and Merle studied the collision between two solitons for the quartic  $gKdV$ , they proved in [20] that no solution of the quartic  $gKdV$  is a pure two multi-soliton, and the collision is inelastic and the  $H^1$  norm of the error in the approximate two solitons solution is of order cubic in the speed of the two solitary waves before the collision, see Theorem 1 from [20]. Moreover, in [27], Muñoz studied the collision between two solitons of different sizes for  $gKdV$  models and obtained that the collision is inelastic when the model is non-integrable, see also [26] for information about the collision between solitons for slow-varying  $gKdV$ .

In [23] and [24], the author studied the collision between two solitons denominated kinks for the one-dimensional nonlinear wave equation known as the  $\phi^6$  model. Moreover, the main result of the paper [24] is similar to Theorem 1.5, the collision preserves the two solitons' structure and the energy norm of the defect can be of order  $O(v^k)$  for any  $k \in \mathbb{N}$  when  $v > 0$  is small enough, where  $v$  is the incoming speed of the solitons before the collision.

Furthermore in [30], we also cite the recent work of Pilod and Valet in the description of the collision of two nearly equal solitary waves for the Zakharov-Kuznetsov partial differential equation in dimensions 2 and 3.

Before, we move to the next section, we need to consider the following notation.

**Notation 1.13.** For any function  $f : \mathbb{R} \rightarrow \mathbb{C}$ , and any real functions  $\zeta, v, \gamma : \mathbb{R} \rightarrow \mathbb{R}$  we denote

$$f(v, \zeta, \gamma)$$

by the following function

$$e^{\frac{iv(t)(x - \frac{\zeta(t)}{2})}{2} + i\gamma(t) + \omega t} f(x - \zeta(t)),$$

for all  $(t, x) \in \mathbb{R}^2$ .

We also consider the following

$$(1.0.15) \quad \text{Sym}(f)(x) := f(x) - f(-x),$$

for any function  $f : \mathbb{R} \rightarrow \mathbb{C}$ . In addition, we for any two functions  $f, g : \mathbb{R} \rightarrow \mathbb{C}$ , we consider

$$(1.0.16) \quad \text{Sym}[f(\cdot)g(\cdot)](x) = f(x)g(x) - f(-x)g(-x).$$

In particular, we are going to use the notation (1.0.16) to describe many expressions in Section 3.

Next, for any  $\zeta \in \mathbb{R}$ , we consider the following notation for space translation:

$$\tau_\zeta f(x) := f(x - \zeta).$$

In this paper, we will only consider the following dot product restricted to the space  $L^2(\mathbb{R}, \mathbb{C})$

$$(1.0.17) \quad \langle f, g \rangle := \text{Re} \int_{\mathbb{R}} f(x)\bar{g}(x) dx.$$

Furthermore, in this manuscript, all the expressions with  $\sum$  only represent a finite sum, and, we say that a real or complex function  $f$  with a domain contained  $D$  in  $\mathbb{R}$  is of order  $O(g(t))$  for some real positive function  $g$  if there exists a  $C > 0$  satisfying

$$|f(t)| \leq Cg(t), \text{ for all } t \in D.$$

In all this manuscript, for any real function  $f(t) > 0$ , the partial differential inequality

$$i\partial_t r(t, x) + \partial_x^2 r(t, x) = F(t, x) + O(f(t)),$$

means for some  $C > 1$  that  $r$  is a strong solution of a partial differential equation

$$i\partial_t r(t, x) + \partial_x^2 r(t, x) = F(t, x) + G(t, x),$$

such that  $\|G(t)\|_{H^1} < Cf(t)$  for all  $t \in \mathbb{R}$  or all  $t$  in the domain of  $r(t, x)$ .

Finally, for any function  $f(t, r)$  over  $\mathbb{C}$  and defined for  $t \in \mathbb{R}$  and  $r \in \mathbb{H}$ ,  $\mathbb{H}$  being some Hilbert Space, we define the function  $\dot{f}(t, r)$  to be

$$\frac{\partial f(t, r)}{\partial t},$$

when the partial derivative above is well-defined on  $t$ .

**1.1. Resume of the proof.** The proof of Theorem 1.5 is similar to the demonstration of Theorem 1.2 from the paper [24], and it also requires the techniques from [23] which are going to be revised in Sections 2 and 3.

First, in Section 3, we focus on constructing a sequence of approximate solutions  $(\varphi_k)_{k \in \mathbb{N}}$  of (1.0.1) satisfying for any  $s \geq 0$

$$(1.1.1) \quad \left\| \frac{\partial^l}{\partial t^l} \Lambda(\varphi_k)(t, x) \right\|_{H_x^s(\mathbb{R})} \leq C(s, l)v^{2k+2+l} \left( |t|v + \ln \frac{1}{v} \right)^{c(k)} e^{-2\sqrt{\omega}|t|v},$$

for some  $t_k \in \mathbb{R}$ , and for  $v > 0$  small enough. The functions  $\varphi_k$  are of following form:

$$(1.1.2) \quad \varphi_k(t, x) = \left[ e^{i\frac{v\zeta_k}{2}(x - \frac{\zeta_k}{2}) + i\gamma_k} \phi_\omega(x - \zeta_k) - e^{-i\frac{v\zeta_k}{2}(x + \frac{\zeta_k}{2}) + i\gamma_k} \phi_\omega(-x - \zeta_k) \right] \\ + \sum_{j \in I_k} g_j(t) \left[ e^{i\frac{v\zeta_k}{2}(x - \frac{\zeta_k}{2}) + i\gamma_k} p_{j,\omega}(x - \zeta_k) - e^{-i\frac{v\zeta_k}{2}(x + \frac{\zeta_k}{2}) + i\gamma_k} p_{j,\omega}(-x - \zeta_k) \right],$$

such that  $\zeta_k(t) > \frac{1}{2\sqrt{\omega}} \ln \left( \frac{1}{v\omega^{\frac{1}{4}}} \right)$ , see Remark 3.3, and all the functions  $g_j, p_{j,\omega}$  are in  $\mathcal{S}(\mathbb{R}, \mathbb{C})$  having exponential decay. However, since the general formula of  $\varphi_k$  is slightly complicated, we shall explain briefly the method to obtain each function  $\varphi_k$ .

From the fact that the soliton  $e^{i\omega t} \phi_\omega(x)$  is a solution of (1.0.1), we consider our initial approximate solution satisfying (1.1.1) to be

$$\varphi_0(t, x) = e^{i\omega t} e^{i\frac{d(t)}{2}(x - \frac{d(t)}{2})} \phi_\omega(x - d(t)) - e^{i\omega t} e^{-i\frac{d(t)}{2}(x + \frac{d(t)}{2})} \phi_\omega(x + d(t)),$$

for some large function  $d(t) > 1$  to be chosen carefully. More precisely, it is possible to find a smooth function  $d(t) > 1$  such that  $\varphi_0$  satisfies (1.1.1) and

$$(1.1.3) \quad \left\langle \Lambda(\varphi_0(t, x)), i e^{i\omega t} e^{\frac{i\dot{d}(t)}{2}(\pm x - \frac{d(t)}{2})} \phi_\omega(x \mp d(t)) \right\rangle = O(v^4),$$

when  $v > 0$  is small enough. The estimate (1.1.3) happens when  $d(t)$  satisfies the following ordinary differential equation

$$\begin{cases} \ddot{d}(t) = C e^{-2\sqrt{\omega}d(t)}, \\ \lim_{t \rightarrow +\infty} |d(t) - vt - c_\omega \ln v| = 0, \lim_{t \rightarrow +\infty} |\dot{d}(t) - v| = 0, \end{cases}$$

see Lemma 3.0.15. From this choice of  $d(t)$ , we deduce that

$$(1.1.4) \quad \left\| \frac{\partial^l}{\partial t^l} \Lambda(\varphi_0)(t, x) \right\|_{H^1} = O(v^{2+l}).$$

The ordinary differential equation above was also studied in [23] to describe the collision between two kinks for the  $\phi^6$  model in [24].

Furthermore, using estimate (1.1.3), we can find a better approximate solution  $\varphi_1$  of (1.0.1). But, since the construction of  $\varphi_1$  from  $\varphi_0$  is similar to the process to obtain  $\varphi_{k+1}$  from  $\varphi_k$  for any  $k \in \mathbb{N}$ , we shall explain the construction of  $\varphi_k$  for general  $k \in \mathbb{N}$ .

Using the exponential decay of the functions  $g_j, p_j$  and that  $\zeta_k > 1$  is very large, we find a finite set of complex Schwartz functions  $r_j, \rho_j$  such that

$$\Lambda(\varphi_k)(t, x) = \sum r_j(t) \text{Sym} \left[ \rho_j(\cdot - \zeta_k(t)) e^{i\frac{v_k(t)}{2}(\cdot - \frac{\zeta_k(t)}{2})} e^{i\gamma_k(t)} \right] (x) + O(v^{2k+4}).$$

Next, we need the properties of the operator  $S_\omega$  defined by

$$S_\omega(\rho) := -\rho'' + \omega\rho - F'(\phi_\omega^2)\rho - F''(\phi_\omega^2)\phi_\omega^2[\rho + \bar{\rho}],$$

which is invertible in the orthogonal complement of  $\text{Span}\{\phi'_\omega, i\phi_\omega, \partial_\omega\phi_\omega, ix\phi_\omega\}$ , see Lemmas 4.7 and 2.15. The operator  $S_\omega$  comes from the linear part of equation (1.0.1) when  $u(t) = [\phi_\omega(x) + \rho(t, x)] e^{i\omega t}$ .

Next, using ordinary differential equation methods, we can replace the smooth parameters  $\zeta_k, v_k, \gamma_k$  with  $\zeta_{k+1}, v_{k+1}, \gamma_{k+1}$  such that the new function  $\varphi_{k,0}$  obtained satisfies for some  $c > 0$

$$(1.1.5) \quad \Lambda(\varphi_{k,0})(t, x) = \sum r_j(t) \text{Sym} \left[ \Pi^\perp(\rho_j)(\cdot - \zeta_{k+1}(t)) e^{i\frac{v_{k+1}(t)}{2}(\cdot - \frac{\zeta_{k+1}(t)}{2})} e^{i\gamma_{k+1}(t)} \right] (x) + O\left(v^{2k+4} \left(\ln \frac{1}{v}\right)^c\right),$$

where  $\Pi^\perp$  is the orthogonal projection operator in the orthogonal complement of the subspace  $\text{Span}\{\phi'_\omega, i\phi_\omega, \partial_\omega\phi_\omega, ix\phi_\omega\}$  in  $L^2(\mathbb{R})$ . More precisely, using the invertible property of  $S_\omega$ , we can consider the following function of correction

$$\begin{aligned} \text{Corr}(t, x) &= \sum r_j(t) \text{Sym} \left[ S_\omega^{-1}(\Pi^\perp(\rho_j))(\cdot - \zeta_{k+1}(t)) e^{i\frac{v_{k+1}(t)}{2}(\cdot - \frac{\zeta_{k+1}(t)}{2})} e^{i\gamma_{k+1}(t)} \right] (x) \\ &+ \sum \dot{r}_j(t) \text{Sym} \left[ S_\omega^{-1}(i\Pi^\perp(\rho_j))(\cdot - \zeta_{k+1}(t)) e^{i\frac{v_{k+1}(t)}{2}(\cdot - \frac{\zeta_{k+1}(t)}{2})} e^{i\gamma_{k+1}(t)} \right] (x) \end{aligned}$$

for the removal of the main estimate in (1.1.5), the function  $\text{Corr}$  is well define because of Lemma 2.15 from Section 2. Therefore, we conclude that the approximate solution  $\varphi_{k+1}(t, x) = \varphi_{k,0}(t, x) + \text{Corr}(t, x)$  satisfies

$$\left\| \frac{\partial^l}{\partial t^l} \Lambda(\varphi_{k+1})(t, x) \right\|_{H_x^s(\mathbb{R})} \leq C_1(s, l) v^{2k+4+l} \left( |t|v + \ln \frac{1}{v} \right)^{c(k+1)} e^{-2\sqrt{\omega}|t|v},$$

for any  $l \in \mathbb{N}$  if  $v > 0$  is small enough.

In Section 4, we study the long-time stability of the approximate solutions  $\varphi_k$  using energy estimate methods, this is very similar to the approach in [9] and [24]. In the remaining sections, we prove the main theorem from the results of Section 4. See also Section 2 for background information about the techniques used in this manuscript.

In Section 5, we study the orbital stability of two opposite solitary waves with the distance between their centers sufficiently large. The results in (5) will allow us to prove the estimate (1.0.10) for all  $t \leq \frac{-|\ln v|^{\frac{4}{3}}}{v}$  when  $v > 0$  is small enough.

The proof of Theorem 1.5 is written in Section 6. The proof of Theorem 1.10 is written in the Appendix Section, and it is completely similar to the approach in the article [10] by Jendrej and Chen to describe the uniqueness of kink Networks.

## 2. BACKGROUND

First, we consider the following lemma which we are going to use several times in the main body of this paper to compute our estimates.

**Lemma 2.1.** *For any real numbers  $x_2, x_1$ , such that  $\zeta = x_2 - x_1 > 0$  and  $\alpha, \beta, m > 0$  with  $\alpha \neq \beta$  the following bound holds:*

$$\int_{\mathbb{R}} |x - x_1|^m e^{-\alpha(x-x_1)_+} e^{-\beta(x_2-x)_+} \lesssim_{\alpha, \beta, m} \max((1 + \zeta^m) e^{-\alpha\zeta}, e^{-\beta\zeta}),$$

For any  $\alpha > 0$ , the following bound holds

$$\int_{\mathbb{R}} |x - x_1|^m e^{-\alpha(x-x_1)_+} e^{-\alpha(x_2-x)_+} \lesssim_{\alpha} [1 + \zeta^{m+1}] e^{-\alpha\zeta}.$$

*Proof.* Elementary computations. □

Next, we consider the following proposition obtained from Taylor's Expansion Theorem.

**Lemma 2.2.** *Let  $F$  be a smooth function satisfying (H1), if  $c > 0$  and  $u, v$  are real numbers satisfying  $|u| + |v| \leq c$ , then for any  $k \in \mathbb{N}$*

$$(2.0.1) \quad \left| F'(u+v) - F'(v) - F'(u) \right| \lesssim_c |uv|,$$

$$(2.0.2) \quad \left| F^{(k)}(u+v) - \sum_{m=1}^k \frac{F^{(k+l)}(u)v^m}{m!} \right| \lesssim_c |v^{l+1}|.$$

*Proof.* The inequality (2.0.2) is a direct consequence of Taylor's Expansion Theorem, so we only need to verify the first inequality.

From the hypothesis (H1), we have  $F'(0) = 0$ . In conclusion, since  $F$  is smooth, we obtain that

$$\begin{aligned} F'(u+v) - F'(u) - F'(v) &= F'(u+v) - F'(u) - F'(v) - F'(0) \\ &= \int_0^1 \left[ F''(u+\theta v) - F''(\theta v) \right] v d\theta \\ &= \left[ \int_0^1 \int_0^1 F^{(3)}(\alpha u + \theta v) d\theta d\alpha \right] uv \\ &\lesssim_c |uv|, \end{aligned}$$

and the last inequality above follows from  $F^{(3)}$  being a bounded function in any bounded interval  $[-c, c]$ . □

Based on the approach at [23], we consider the following space:



**Definition 2.3.** Let  $\delta_\omega > 0$  be the value defined in Remark (1.2) satisfying (1.0.7).  $\mathcal{S}^+$ ,  $\mathcal{S}^-$  are linear sub-spaces of  $L^\infty(\mathbb{R})$  such that  $f \in \mathcal{S}^+$ ,  $g \in \mathcal{S}^-$  if  $f, g \in C^\infty(\mathbb{R})$  and

$$\begin{aligned} f(x) &= \sum_{j=0}^{+\infty} a_j e^{(2j+1)x}, \text{ for all } x \leq -\delta_\omega, f(x) = \sum_{j=0}^{+\infty} b_j e^{-(2j+1)x}, \text{ for all } x \geq \delta_\omega, \\ g(x) &= \sum_{j=0}^{+\infty} c_j e^{2jx}, \text{ for all } x \leq -\delta_\omega, g(x) = \sum_{j=0}^{+\infty} q_j e^{-2jx}, \text{ for all } x \geq \delta_\omega, \end{aligned}$$

and the functions

$$A(z) = \sum_{j=0}^{+\infty} a_j z^{(2j+1)}, B(z) = \sum_{j=0}^{+\infty} b_j z^{(2j+1)}, C(z) = \sum_{j=1}^{+\infty} c_j z^{2j}, Q(z) = \sum_{j=1}^{+\infty} q_j z^{2j}$$

are analytic on the open unitary disk  $\mathbb{D} \subset \mathbb{C}$ .

**Remark 2.4.** If  $\phi_\omega$  satisfies Theorem 1.1, it is not difficult to verify using Remark 1.2 that the function  $\phi_\omega(x) := \phi_\omega(\frac{x}{\sqrt{\omega}})$  is an element of  $\mathcal{S}^+$ , therefore it satisfies

$$\left| \frac{d^l \phi_\omega(x)}{dx^l} \right| = O\left(e^{-\sqrt{\omega}|x|}\right),$$

for any  $l \in \mathbb{N}$ .

**Definition 2.5.** For any  $n \in \mathbb{N} \cup \{0\}$ , the linear spaces  $\mathcal{S}^{+,n} = \{x^n f(x) \mid f(x) \in \mathcal{S}^+ \cap \mathcal{S}(\mathbb{R})\}$  and  $\mathcal{S}^{-,n} = \{x^n f(x) \mid f(x) \in \mathcal{S}^- \cap \mathcal{S}(\mathbb{R})\}$ , and for any  $m \in \mathbb{N} \cup \{0\}$ , we define

$$\mathcal{S}_m^+ = \bigoplus_{n=0}^m \mathcal{S}^{+,n}, \mathcal{S}_m^- = \bigoplus_{n=0}^m \mathcal{S}^{-,n}, \mathcal{S}_\infty^+ = \bigoplus_{n=0}^{+\infty} \mathcal{S}^{+,n}, \mathcal{S}_\infty^- = \bigoplus_{n=0}^{+\infty} \mathcal{S}^{-,n}.$$

**Remark 2.6.** The spaces  $\mathcal{S}^+$  are going to be used to construct approximate solutions of (1.0.1) that behave like the function  $u$  satisfying the conclusion of Theorem 1.5.

Moreover, from the Definitions 2.3 and 2.5, we can verify the following elementary propositions.

**Lemma 2.7.** For any  $l \in \mathbb{N}$ , if  $f \in \mathcal{S}^+ \cup \mathcal{S}_\infty^+$  and  $g \in \mathcal{S}^- \cup \mathcal{S}_\infty^-$ , then

$$\frac{d^l f(x)}{dx^l} \in \mathcal{S}_\infty^+, \frac{d^l g(x)}{dx^l} \in \mathcal{S}_\infty^-,$$

for any natural number  $l \geq 1$ .

**Lemma 2.8.** For any  $l \in \mathbb{N}$ , if  $f_1, f_2, f_3 \in \mathcal{S}_\infty^+$  and  $g_1, g_2 \in \mathcal{S}_\infty^-$ , then

$$f_1(x)f_2(x)f_3(x) \in \mathcal{S}_\infty^+, g_1(x)g_2(x) \in \mathcal{S}_\infty^-.$$

In particular, if  $f \in \mathcal{S}_\infty^+$ , then for any natural number  $l \geq 1$

$$f(x)^{2l-1} \in \mathcal{S}_\infty^+, f(x)^{2l} \in \mathcal{S}_\infty^-.$$

Similarly to the proof of Proposition 2.4 from the article [23], we can verify the following proposition.

**Lemma 2.9.** If  $f \in \mathcal{S}^+$ ,  $g \in \mathcal{S}^-$  and  $l, m \in \mathbb{N}$ , then there exist a unique sequence of pairs  $(h_n, d_n)_{n \geq 1}$  and a set  $\Delta \subset \mathbb{N}$  such that  $(d_n)_{n \geq 1} \subset \mathbb{N}$  is a strictly increasing sequence, for all  $n \in \Delta$ ,  $h_n(-x)$  is in  $\mathcal{S}^+ \cap \mathcal{S}(\mathbb{R})$ , for all  $n \in \Omega = \mathbb{N} \setminus \Delta$   $h_n(x)$  is in  $\mathcal{S}^+ \cap \mathcal{S}(\mathbb{R})$ , and for any  $\mathcal{M} \in \mathbb{N}$  and any  $\zeta \geq 1$

$$(2.0.3) \quad f(x - \zeta)g(x) = \sum_{\substack{1 \leq n \leq \mathcal{M}, \\ n \in \Delta}} h_n(x - \zeta)e^{-d_n \zeta} + \sum_{\substack{1 \leq n \leq \mathcal{M}, \\ n \in \mathbb{N} \setminus \Delta}} h_n(x)e^{-d_n \zeta} + e^{-d_{\mathcal{M}} \zeta} f_{\mathcal{M}}(x - \zeta)g_{\mathcal{M}}(x),$$

where either  $f_{\mathcal{M}} \in \mathcal{S}^+ \cap \mathcal{S}(\mathbb{R})$ ,  $g_{\mathcal{M}} \in \mathcal{S}^-$  or  $f_{\mathcal{M}} \in \mathcal{S}^- \cap \mathcal{S}(\mathbb{R})$ ,  $g_{\mathcal{M}} \in \mathcal{S}^+$ .

**Remark 2.10.** Using Lemma 2.1 and interpolation, we can verify that

$$\|f_{\mathcal{M}}(x - \zeta)g_{\mathcal{M}}(x)\|_{H_x^s(\mathbb{R})} \lesssim_s (1 + \zeta)e^{-\zeta},$$

for any real number  $s$ .

From now on, we are going to study the properties of the following linear operator

$$(S_\omega) \quad S_\omega(\rho) := -\rho'' + \omega\rho - F'(\phi_\omega^2)\rho - F''(\phi_\omega^2)\phi_\omega^2[\rho + \bar{\rho}]$$

on the function space  $\mathcal{S}^+$ . Indeed, it is not difficult to verify that  $-e^{i\omega t}S_\omega(\rho)$  is the linear part of the expression

$$iu_t + u_{xx} + F'(|u|^2)u$$

around  $\rho$  for  $u(t, x) = (\phi_\omega(x) + \rho(x))e^{i\omega t}$ . Similarly to the approach in the article [9], we can verify the following property of  $S$ .

**Lemma 2.11.** Assuming that  $\omega > 0$  and  $\phi_\omega$  satisfy Theorem 1.1, the kernel of the map  $S_\omega$  is the following subspace of  $L^2(\mathbb{R})$

$$\ker S_\omega = \text{Span} \left\{ \phi'_\omega, i\phi_\omega \right\}.$$

Moreover, from the article [6], we also have the coercivity property satisfied by the operator  $S_\omega$ .

**Lemma 2.12.** There exists a constant  $c > 0$  such that if  $g \in H^1(\mathbb{R}, \mathbb{C})$  is orthogonal in  $L^2(\mathbb{R}, \mathbb{C})$  to the functions  $\phi'_\omega, i\phi_\omega, \partial_\omega\phi_\omega$ , then

$$\langle S_\omega(g), g \rangle \geq c \|g\|_{H^1}^2.$$

Moreover, for any  $g \in H^1(\mathbb{R}, \mathbb{C})$ , we have

$$\langle S_\omega(g), g \rangle \geq c \|g\|_{H^1}^2 - C \left[ \langle g, \phi'_\omega \rangle^2 + \langle g, i\phi_\omega \rangle^2 + \langle g, \partial_\omega\phi_\omega \rangle^2 \right],$$

for some constant  $C > 1$ .

**Remark 2.13.** Moreover, we also can verify for some constant  $c > 0$  that if  $g \in H^1(\mathbb{R}, \mathbb{C})$  is orthogonal in  $L^2(\mathbb{R}, \mathbb{C})$  to  $x\phi_\omega(x), i\partial_\omega\phi_\omega$  and  $\phi_\omega$ , then

$$(2.0.4) \quad \langle S_\omega(g), g \rangle \geq c \|g\|_{H^1}^2.$$

This follows because for  $g_1$  the orthogonal projection of  $g$  onto  $\text{Span}\{\phi'_\omega, i\phi_\omega, \partial_\omega\phi_\omega\}^\perp$ , we have that

$$(2.0.5) \quad g = g_1 + a_1\phi'_\omega + a_2i\phi_\omega + a_3\partial_\omega\phi_\omega,$$

and  $\langle S_\omega(g), g \rangle \geq c \|g_1\|_{H^1}^2$ .

Consequently, using equation (2.0.5) and the fact that  $\phi_\omega, \partial_\omega\phi_\omega$  are even functions, we deduce for some  $C > 0$  that

$$\begin{aligned} |\langle g, x\phi_\omega(x) \rangle|^2 + \|g_1\|_{H^1}^2 &\geq Ca_1^2, \\ |\langle g, i\partial_\omega\phi_\omega(x) \rangle|^2 + \|g_1\|_{H^1}^2 &\geq Ca_2^2, \\ |\langle g, \phi_\omega(x) \rangle|^2 + \|g_1\|_{H^1}^2 &\geq Ca_3^2. \end{aligned}$$

Therefore, we have for some  $K > 0$  that

$$\|g\|_{H^1}^2 \leq K \left[ \|g_1\|_{H^1}^2 + \|\Pi_1(g)\|_{L^2}^2 \right] = K \|g_1\|_{H^1}^2,$$

where  $\Pi_1$  is the orthogonal projection of  $L^2(\mathbb{R}, \mathbb{C})$  into  $\text{Span}\{x\phi_\omega(x), \phi_\omega(x), i\partial_\omega\phi_\omega(x)\}$ .

In conclusion, using Lemma 2.12 implies that

$$(2.0.6) \quad \langle S_\omega(g), g \rangle \geq c \|g_1\|_{H^1}^2 \geq \frac{c}{K} \|g\|_{H^1}^2 - \|\Pi_1(g)\|_{L^2}^2 = \frac{c}{K} \|g\|_{H^1}^2.$$

Next, we consider the following proposition which can be verified directly using the differential equations' formulas (1.0.1) and (1.0.4), see also Section 4 of the article in [9] for a proof restricted to (Cubic NLS).

**Lemma 2.14.** *Let  $\rho \in \mathcal{S}(\mathbb{R}; \mathbb{C})$  and  $h(x) = S_\omega(\rho)(x)$ . Then, for any real smooth functions  $f, \zeta, v, \gamma$  such that the functions*

$$\begin{aligned}\rho_\theta(t, x) &:= f(t)\rho(v(t), \zeta(t), \gamma(t)), \\ \rho_\sigma(t, x) &:= \rho(v(t), \zeta(t), \gamma(t)), \\ \phi_{\omega, \sigma}(t, x) &:= \phi_\omega(x - \zeta(t)) e^{i(\gamma(t) + \frac{v(t)}{2}(x - \frac{\zeta(t)}{2}) + \omega t)}\end{aligned}$$

satisfy

$$\begin{aligned}i\partial_t \rho_\theta + \partial_x^2 \rho_\theta + F'(|\phi_{\omega, \sigma}|^2) \rho_\theta + F''(|\phi_{\omega, \sigma}|^2) |\phi_{\omega, \sigma}|^2 \rho_\theta + F''(|\phi_{\omega, \sigma}|^2) \phi_{\omega, \sigma}^2 \overline{\rho_\theta} \\ = i\dot{f}(t)\rho_\sigma(t, x) - f(t)h(v(t), \zeta(t), \gamma(t)) + if(t)\dot{\gamma}(t)\partial_\gamma \rho_\sigma(t, x) \\ + i\dot{v}(t)f(t)\partial_v \rho_\sigma(t, x) + if(t)(\dot{\zeta}(t) - v(t))\partial_\zeta \rho_\sigma(t, x).\end{aligned}$$

We also need to consider the following statement.

**Lemma 2.15.** *There exist  $C, c, \delta > 0$  such that for any  $f \in L^2$  satisfying*

$$(2.0.7) \quad \left\langle f, \frac{\partial \phi_\omega(v, \zeta, \gamma)}{\partial \zeta} \Big|_{v=\zeta=\gamma=0} \right\rangle = 0,$$

$$(2.0.8) \quad \left\langle f, \frac{\partial \phi_\omega(v, \zeta, \gamma)}{\partial \gamma} \Big|_{v=\zeta=\gamma=0} \right\rangle = 0,$$

$S_\omega^{-1}f$  is defined and satisfies  $\|S_\omega^{-1}f\|_{H^1} < C\|f\|_{L^2}$ , and

$$\left\langle S_\omega^{-1}f, \frac{\partial \phi_\omega(v, \zeta, \gamma)}{\partial \zeta} \Big|_{v=\zeta=\gamma=0} \right\rangle = 0,$$

$$\left\langle S_\omega^{-1}f, \frac{\partial \phi_\omega(v, \zeta, \gamma)}{\partial \gamma} \Big|_{v=\zeta=\gamma=0} \right\rangle = 0.$$

Furthermore, if  $\omega > \delta$ ,  $f \in H_x^1(\mathbb{R}, \mathbb{C})$  and

$$(2.0.9) \quad \left\langle f, \frac{\partial \phi_\omega(v, \zeta, \gamma)}{\partial \omega} \Big|_{v=\zeta=\gamma=0} \right\rangle = 0,$$

$$(2.0.10) \quad \left\langle f, \frac{\partial \phi_\omega(v, \zeta, \gamma)}{\partial v} \Big|_{v=\zeta=\gamma=0} \right\rangle = 0,$$

(2.0.11)

and

$$(2.0.12) \quad \left\langle S_\omega^{-1}f, i \frac{\partial \phi_\omega(v, \zeta, \gamma)}{\partial \zeta} \Big|_{v=\zeta=\gamma=0} \right\rangle = 0,$$

$$(2.0.13) \quad \left\langle S_\omega^{-1}f, i \frac{\partial \phi_\omega(v, \zeta, \gamma)}{\partial \gamma} \Big|_{v=\zeta=\gamma=0} \right\rangle = 0.$$

*Proof of Lemma 2.15.* First, the operator  $S_\omega$  is self-adjoint in the Hilbert Space  $L^2(\mathbb{R}, \mathbb{C})$  having the dot product given in (1.0.17).

Since

$$\frac{d}{d\omega} \|\phi_\omega\|_{L^2}^2 > 0,$$

we have that  $S_\omega$  has a unique negative eigenvalue  $\lambda_\omega$  with its eigenspace being a one-dimensional subspace  $B_\omega = \{m\rho_\omega \mid m \in \mathbb{R}\}$  of  $L^2(\mathbb{R}, \mathbb{C})$  satisfying  $\langle \rho_\omega, \partial_\omega \phi_\omega \rangle \neq 0$ , this is a consequence of Theorem 3 from [6].

Furthermore, we have that

$$\ker S_\omega = \text{Span}\{i\phi_\omega, \phi'_\omega\},$$

see Theorem 3.3 from [6]. Moreover, since  $\phi_\omega$  has exponential decay, we have from Weyl's Theorem that  $\sigma_{ess}(S_\omega) = [\omega, +\infty)$ , see Theorem 14.6 from the book [8]. Therefore, for all  $f \in H^1(\mathbb{R}, \mathbb{C}) \cap (\ker S_\omega)^\perp$ , there exist  $f \in \mathbb{R}$  such that  $f = a\rho_\omega + f_1$ ,  $\langle f_1, \rho_\omega \rangle = 0$ .

Next, for any  $g_1 \in H^1(\mathbb{R}, \mathbb{C}) \cap (\ker S_\omega \oplus B_\omega)^\perp$ , we have

$$(2.0.14) \quad \langle S_\omega g_1, g_1 \rangle \geq c \|g_1\|_{L^2}^2,$$

for some constant  $c > 0$  depending only on  $\omega$ . Moreover, since  $\phi_\omega \in L^\infty$ , we have that there exists  $C > 1$  satisfying

$$(2.0.15) \quad \langle S_\omega g, g \rangle \geq \|g'\|_{L^2}^2 - C \|g\|_{L^2}^2,$$

for any  $g \in H^1(\mathbb{R}, \mathbb{C})$ .

As a consequence, we deduce from inequalities (2.0.14) and (2.0.15) that there exists  $c > 0$  depending only on  $\omega$  satisfying

$$\langle S_\omega g_1, g_1 \rangle \geq c \|g_1\|_{H^1}^2,$$

for all  $g_1 \in H^1(\mathbb{R}, \mathbb{C}) \cap (\ker S_\omega \oplus B_\omega)^\perp$ , and so  $\|g_1\|_{H^1} \leq \frac{1}{c} \|S_\omega g_1\| \leq \frac{1}{c} \|S_\omega g\|$ .

Therefore, we can verify the existence of a constant  $C > 1$  and a bounded linear map  $S_\omega^{-1}$  satisfying  $S_\omega^{-1} \left( (\ker S_\omega)^\perp \right) \subset (\ker S_\omega)^\perp$  and

$$\|S_\omega^{-1} f\|_{H^1} \leq C \|f\|_{L^2},$$

for all  $f \in (\ker S_\omega)^\perp$ .

The identities (2.0.12) and (2.0.13) follow from the fact that  $S_\omega$  is a self-adjoint operator and from the following identities

$$(2.0.16) \quad S_\omega \left( \frac{\partial \phi_\omega(v, \zeta, \gamma)}{\partial \omega} \Big|_{v=\zeta=\gamma=0} \right) = S_\omega(\partial_\omega \phi_\omega) = -\phi_\omega,$$

$$(2.0.17) \quad S_\omega \left( \frac{\partial \phi_\omega(v, \zeta, \gamma)}{\partial v} \Big|_{v=\zeta=\gamma=0} \right) = S_\omega \left( i \frac{x}{2} \phi_\omega(x) \right) = -i\phi'_\omega.$$

□

Moreover, we also consider the following standard lemmas to simplify our reasoning in the next sections.

**Lemma 2.16.** *There exist unique orthogonal projections  $\Pi, \Pi_1 : L_x^2(\mathbb{R}) \rightarrow L_x^2(\mathbb{R})$  such that the range of  $\Pi$  is equal to  $\text{Span}\{\phi'_\omega, ix\phi_\omega, i\phi_\omega, \partial_\omega \phi_\omega\}$ , the range of  $\Pi_1$  is equal to  $\text{Span}\{i\phi'_\omega, x\phi_\omega, \phi_\omega, i\partial_\omega \phi_\omega\}$ , and for any  $f \in L_x^2(\mathbb{R}, \mathbb{C})$*

$$\begin{aligned} \langle f - \Pi(f)(x), \phi'_\omega(x) \rangle &= 0, \quad \langle f - \Pi(f)(x), i\phi_\omega(x) \rangle = 0, \\ \langle f - \Pi(f)(x), ix\phi_\omega(x) \rangle &= 0, \quad \langle f - \Pi(f)(x), \partial_\omega \phi_\omega(x) \rangle = 0, \end{aligned}$$

and

$$\begin{aligned} \langle f - \Pi_1(f)(x), i\phi'_\omega(x) \rangle &= 0, \quad \langle f - \Pi_1(f)(x), \phi_\omega(x) \rangle = 0, \\ \langle f - \Pi_1(f)(x), x\phi_\omega(x) \rangle &= 0, \quad \langle f - \Pi_1(f)(x), i\partial_\omega \phi_\omega(x) \rangle = 0. \end{aligned}$$

**Remark 2.17.** *The orthogonal projection  $\Pi$  is going to be used in Section 3 to construct the approximate solutions. The projection  $\Pi_1$  is going to be used only in Section 4 to estimate the energy norm of the remainder of the approximate solution during a large time interval.*

Furthermore, similarly to the proof of Lemma 2.11 from [23], we can verify the following statement.

**Lemma 2.18.** For any  $n \in \mathbb{N} \cup \{0\}$ , there exists a natural number  $m_n \geq n$  such that if  $S_\omega(\rho) \left( \frac{\cdot}{\sqrt{\omega}} \right) \in \mathcal{S}_m^+$ , then  $\rho \left( \frac{\cdot}{\sqrt{\omega}} \right) \in \mathcal{S}_{m_n}^+$ .

**Remark 2.19.** Furthermore, since  $\phi_\omega$  is a real function, we can verify that if  $\rho$  is a real function in the domain of  $S_\omega^{-1}$ , then  $S_\omega^{-1}(\rho)$  is a real function. If  $i\rho$  is a real function, and  $\rho$  is in the domain of  $S_\omega^{-1}$ , then  $iS_\omega^{-1}(\rho)$  is a real function. From this fact, we can verify Lemma 2.18 similarly to the approach in the proof of Lemma 2.11 from [23].

**Remark 2.20.** Similarly to the Lemma 2.9 from [23], we can verify that the sum of the sets  $x^l \mathcal{S}^{+,0}$  has to be a direct sum.

### 3. APPROXIMATE SOLUTIONS

Following the approach made in [23], we are going to construct a sequence of approximate solutions of the following form

$$(3.0.1) \quad \varphi_k = \left[ e^{i\frac{v_k}{2}(x-\frac{\zeta_k}{2})+i\gamma_k} \phi_\omega(x-\zeta_k) - e^{-i\frac{v_k}{2}(x+\frac{\zeta_k}{2})+i\gamma_k} \phi_\omega(-x-\zeta_k) \right] \\ + f_{\omega,k}(t) \left[ e^{i\frac{v_k}{2}(x-\frac{\zeta_k}{2})+i\gamma_k} \partial_\omega \phi_\omega(x-\zeta_k) - e^{-i\frac{v_k}{2}(x+\frac{\zeta_k}{2})+i\gamma_k} \partial_\omega \phi_\omega(-x-\zeta_k) \right] \\ (3.0.2) \quad + \sum_{j \in J} g_j(t) \left[ e^{i\frac{v_k}{2}(x-\frac{\zeta_k}{2})+i\gamma_k} p_{j,\omega}(x-\zeta_k) - e^{-i\frac{v_k}{2}(x+\frac{\zeta_k}{2})+i\gamma_k} p_{j,\omega}(-x-\zeta_k) \right],$$

where the functions  $p_{1,\omega} \left( \frac{\cdot}{\sqrt{\omega}} \right)$ ,  $p_{2,\omega} \left( \frac{\cdot}{\sqrt{\omega}} \right)$ ,  $p_{3,\omega} \left( \frac{\cdot}{\sqrt{\omega}} \right)$  and  $p_{j,\omega} \left( \frac{\cdot}{\sqrt{\omega}} \right)$  are in  $\bigoplus_{l=0}^{+\infty} x^l \mathcal{S}^+$ . Moreover, all the functions  $g_j$  and  $f_{\omega,k}$  are Schwartz functions with exponential decay and  $J_k$  is a finite set with size depending on  $k$ .

More precisely:

**Theorem 3.1.** There exist a constant  $c > 0$ , and finite subsets  $J, I$  of  $\mathbb{N}$ , and for each  $k \in \mathbb{N}$ , there are finite sets  $J_k, I_k$  and  $\delta_k \in (0, 1)$ ,  $c(k) \in \mathbb{R}$  such that if  $0 < v < \delta_k$ , then  $e^{-2\zeta_k(v,t)} \leq c(k)v^2$  for all  $t$  and there exist functions  $\sigma_k(t) = (\zeta_k, v_k, \gamma_k, f_{\omega,k}) : (0, 1) \times \mathbb{R} \rightarrow \mathbb{R}^4$ ,  $f_j : (0, 1) \times \mathbb{R} \rightarrow \mathbb{C}$  and real functions  $p_j \in \mathcal{S}_\infty^+$  such that all functions  $f_j(v, \cdot)$  are Schwartz,  $\zeta_k, f_{\omega,k}$  are even on  $t$ ,  $v_k, \gamma_k$  are on odd  $t$ ,

$$\left| \frac{\partial^l f_{\omega,k}(v, t)}{\partial t^l} \right| \leq C(l)v^{2+l} \left( \ln \left( \frac{1}{v} \right) + |t| \right)^c e^{-2\sqrt{\omega}|t|v},$$

for a positive constants  $c$ , and the function  $\varphi_k(t, x) = P_k(t, x, \sigma_k(t))$  defined by

$$(3.0.3) \quad P_k(t, x, \sigma_k(t)) := \left[ e^{i\frac{v_k}{2}(x-\frac{\zeta_k}{2})+i\gamma_k} \phi_\omega(x-\zeta_k) - e^{-i\frac{v_k}{2}(x+\frac{\zeta_k}{2})+i\gamma_k} \phi_\omega(-x-\zeta_k) \right] \\ + f_{\omega,k}(t) \left[ e^{i\frac{v_k}{2}(x-\frac{\zeta_k}{2})+i\gamma_k} \partial_\omega \phi_\omega(x-\zeta_k) - e^{-i\frac{v_k}{2}(x+\frac{\zeta_k}{2})+i\gamma_k} \partial_\omega \phi_\omega(-x-\zeta_k) \right] \\ + e^{-2\sqrt{\omega}\zeta_0} \left[ e^{i\frac{v_k}{2}(x-\frac{\zeta_k}{2})+i\gamma_k} p_{1,\omega}(x-\zeta_k) - e^{-i\frac{v_k}{2}(x+\frac{\zeta_k}{2})+i\gamma_k} p_{1,\omega}(-x-\zeta_k) \right] \\ + \sum_{j \in J} i g_{\text{odd},j}(t) \left[ e^{i\frac{v_k}{2}(x-\frac{\zeta_k}{2})+i\gamma_k} p_{j,\omega}(x-\zeta_k) - e^{-i\frac{v_k}{2}(x+\frac{\zeta_k}{2})+i\gamma_k} p_{j,\omega}(-x-\zeta_k) \right] \\ + \sum_{j \in I} g_{\text{even},j}(t) \left[ e^{i\frac{v_k}{2}(x-\frac{\zeta_k}{2})+i\gamma_k} p_{j,\omega}(x-\zeta_k) - e^{-i\frac{v_k}{2}(x+\frac{\zeta_k}{2})+i\gamma_k} p_{j,\omega}(-x-\zeta_k) \right] \\ + \sum_{j \in J_k} i g_{\text{odd},j}(t) \left[ e^{i\frac{v_k}{2}(x-\frac{\zeta_k}{2})+i\gamma_k} p_{j,\omega}(x-\zeta_k) - e^{-i\frac{v_k}{2}(x+\frac{\zeta_k}{2})+i\gamma_k} p_{j,\omega}(-x-\zeta_k) \right] \\ + \sum_{j \in I_k} g_{\text{even},j}(t) \left[ e^{i\frac{v_k}{2}(x-\frac{\zeta_k}{2})+i\gamma_k} p_{j,\omega}(x-\zeta_k) - e^{-i\frac{v_k}{2}(x+\frac{\zeta_k}{2})+i\gamma_k} p_{j,\omega}(-x-\zeta_k) \right],$$

all functions  $g_{even,j}$  are even, all functions  $g_{odd,j}$  are odd, and

$$(3.0.4) \quad \left\| \frac{\partial^l}{\partial t^l} \Lambda(\varphi_k)(t, x) \right\|_{H_x^s(\mathbb{R})} \leq C(s, l) v^{2k+2+l} \left( |t|v + \ln \frac{1}{v} \right)^{c(k)} e^{-2\sqrt{\omega}|t|v},$$

for all  $l \in \mathbb{N}$  and  $t, s \in \mathbb{R}$ , and there is  $t_k = O\left(\frac{1}{v} \ln \frac{1}{v}\right)$  such that

$$\lim_{t \rightarrow +\infty} \left\| \varphi_k(t + t_k) - \phi_\omega(x - vt) e^{iv(x-vt) + i\omega t + i\frac{v^2 t}{2}} + \phi_\omega(x + vt) e^{-iv(x+vt) + i\omega t + i\frac{v^2 t}{2}} \right\|_{H_x^1(\mathbb{R})} = 0,$$

Moreover, there exist  $c > 0$ , and  $c_k > 0$  depending on  $k$  such that if  $v > 0$  is small enough, then

$$\begin{aligned} \max_{j \in J} \left| \frac{\partial^l}{\partial t^l} g_{odd,j}(v, t) \right| + \max_{j \in I} \left| \frac{\partial^l}{\partial t^l} g_{even,j}(v, t) \right| &\lesssim_{k,l} v^{2+l} \left( |t|v + \ln \frac{1}{v} \right)^c e^{-2\sqrt{\omega}|t|v}, \\ \max_{j \in J_k} \left| \frac{\partial^l}{\partial t^l} g_{odd,j}(v, t) \right| + \max_{j \in I_k} \left| \frac{\partial^l}{\partial t^l} g_{even,j}(v, t) \right| &\lesssim_{k,l} v^{4+l} \left( |t|v + \ln \frac{1}{v} \right)^{c_k} e^{-2\sqrt{\omega}|t|v}. \end{aligned}$$

**Remark 3.2.** Furthermore, we are going to verify that the functions  $f_{\omega,k}$ ,  $v_k$ ,  $\gamma_k$  and  $\zeta_k$  satisfy for some  $s_k > 0$  the following asymptotic expansion

$$\begin{aligned} f_{\omega,k}(v, t) &= f_{\omega,k-1}(v, t) + O\left(v^{2k+2} \left(\ln \frac{1}{v}\right)^{s_k}\right), \quad v_k(t) = v_{k-1}(v, t) + O\left(v^{2k+1} \left(\ln \frac{1}{v}\right)^{s_k}\right), \\ \gamma_k(v, t) &= \gamma_{k-1}(v, t) + O\left(v^{2k+1} \left(\ln \frac{1}{v}\right)^{s_k}\right), \quad \zeta_k(v, t) = \zeta_{k-1}(v, t) + O\left(v^{2k} \left(\ln \frac{1}{v}\right)^{s_k}\right), \end{aligned}$$

for any  $k \in \mathbb{N}_{\geq 1}$  if  $v > 0$  is small enough.

**Remark 3.3.** From the proof of Theorem 3.1, we have that there is  $c > 0$  such that  $\zeta_k(t) = d(t) + O(v^2 (\ln \frac{1}{v})^c)$ , for  $d(t)$  satisfying (3.0.22), and

$$(3.0.5) \quad v^4 \left| \frac{\partial^l}{\partial t^l} \zeta_k(v, t) \right| + v^3 \left| \frac{\partial^l}{\partial t^l} v_k(v, t) \right| + v^3 \left| \frac{\partial^l}{\partial t^l} [\gamma_k(v, t) - \omega t] \right| \leq C v^{4+l} \left( |t|v + \ln \frac{1}{v} \right)^c e^{-2\sqrt{\omega}|t|v},$$

for any  $l \in \mathbb{N}_{\geq 1}$  if  $v > 0$  is sufficiently small.

**Remark 3.4.** In the Section 4, we are going to use the notation  $P_k(t, x, \sigma_k(t))$  from the statement of Theorem 3.1 instead of  $\varphi_k(t, x)$ .

In the notation of Theorem 3.1, to simplify our reasoning, we consider for any smooth function  $\rho$  that

$$(3.0.6) \quad \rho_k(t, x) := e^{i\left(\gamma_k(t) + \frac{v_k(t)}{2} \left[x - \frac{\zeta_k(t)}{2}\right]\right)} \rho(x - \zeta_k(t)) = e^{i\alpha_k(t, x)} \rho(x - \zeta_k(t)).$$

Next, before we start the proof of Theorem 3.1, we state a useful proposition for us to estimate of  $\Lambda(u_k)$  with high precision for every  $k \in \mathbb{N}$  More precisely:

**Lemma 3.5.** In notation of Theorem 3.1, if there is  $c > 0$  such that  $\|\partial_t^l \Lambda(\varphi_k)(t, x)\|_{H^1(\mathbb{R})} = O\left(v^{2\mathcal{M}+l} \left(\ln \left(\frac{1}{v}\right) + |t|v\right)^c e^{-2\sqrt{\omega v}|t|}\right)$  for all  $v > 0$  sufficiently small, then there exist natural numbers  $N_1, N_2$  satisfying, for any  $0 < v \ll 1$ , the following estimate

$$\Lambda(\varphi_k)(t, x) = \sum_{i=1}^{N_1} s_i(v, t) \text{Sym}((\mathcal{R}_i)_k)(x) + \text{Rest}_v(t, x),$$

such that  $\text{Rest}_v(t, x)$  satisfies for some  $c_2 > 0$  and any  $l \in \mathbb{N}$

$$\|\partial_t^l \text{Rest}_v(t, x)\|_{H^1(\mathbb{R})} = O\left(v^{2\mathcal{M}+4+l} \left(\ln \left(\frac{1}{v}\right) + |t|v\right)^{c_2} e^{-2\sqrt{\omega v}|t|}\right),$$

and for all  $1 \leq i, j \leq N_1$  we have  $\langle \mathcal{R}_i, \mathcal{R}_j \rangle = \delta_{i,j}$ ,  $\mathcal{R}_i \in \mathcal{S}_\infty^+$ ,  $s_{i,v} \in C^\infty(\mathbb{R})$  satisfies, for all  $l \in \mathbb{N}$ ,  $\left| \frac{\partial^l}{\partial t^l} s_i(v, t) \right| \lesssim_l v^{2\mathcal{M}} [v|t| + \ln \left(\frac{1}{v^2}\right)]^{n_{\mathcal{M}}} e^{-2\sqrt{\omega v}|t|}$ , for all  $t \in \mathbb{R}$  and  $v \in (0, 1)$ , if  $0 < v \ll 1$ .

*Proof.* The proof of Lemma 3.5 is completely analogous to the proof of Lemma 5.3 from [23].  $\square$

From now on, to simplify more our notation, we are going to consider  $v \in (0, 1)$  small enough and denote the functions  $\zeta_k(v, t)$ ,  $v_k(v, t)$ ,  $\gamma_k(v, t)$ ,  $f_{\omega, k}(v, t)$  by  $\zeta_k(t)$ ,  $v_k(t)$ ,  $\gamma_k(t)$ ,  $f_{\omega, k}(t)$  respectively.

Next, we consider the following result which is going to be essential in the estimate of  $\lambda(u_k)(t, x)$  with high precision.

**Lemma 3.6.** *In notation of Theorem 3.1, let  $\rho : \mathbb{R}^2 \rightarrow \mathbb{C}$  be the following function*

$$(3.0.7) \quad \rho(t, x) = \text{Sym}(\phi_{\omega, k})(t, x) + i \sum_{j=1}^m f_{\text{odd}, j}(v, t) \text{sym}((q_j)_k)(t, x) + \sum_{j=1}^n f_{\text{even}, j}(v, t) \text{sym}((p_j)_k)(t, x),$$

where all the real functions  $q_j \left( \frac{\cdot}{\sqrt{\omega}} \right)$ ,  $p_j \left( \frac{\cdot}{\sqrt{\omega}} \right)$  are in  $\mathcal{S}_{\infty}^+$ , all the real functions  $f_{\text{odd}, j}$  are smooth and odd on the variable  $t$ , all the real functions  $f_{\text{even}, j}$  are smooth and even on the variable  $t$ , and

$$(3.0.8) \quad \left| \frac{\partial^l}{\partial t^l} f_{\text{odd}, j}(v, t) \right| \lesssim v^{2+l} \left( |t|v + \ln \frac{1}{v} \right)^{c_j} e^{-2\sqrt{\omega}|t|v},$$

$$(3.0.9) \quad \left| \frac{\partial^l}{\partial t^l} f_{\text{even}, j}(v, t) \right| \lesssim v^{2+l} \left( |t|v + \ln \frac{1}{v} \right)^{d_j} e^{-2\sqrt{\omega}|t|v},$$

for any  $l \in \mathbb{N}$  and  $v \in (0, 1)$  small enough, and  $c_j, d_j$  are positive numbers. Then, if  $e^{-2\sqrt{\omega}\zeta_k} = O(v^2)$ ,  $v_k = O(v)$ , for any  $l \in \mathbb{N}$

$$v^4 \left| \frac{\partial^l}{\partial t^l} \zeta_k(v, t) \right| + v^3 \left| \frac{\partial^l}{\partial t^l} v_k(v, t) \right| + v^3 \left| \frac{\partial^l}{\partial t^l} [\gamma_k(v, t) - \omega t] \right| \leq C v^{4+l} \left( |t|v + \ln \frac{1}{v} \right)^c e^{-2\sqrt{\omega}|t|v},$$

and the function  $\zeta_k$  is even on  $t$  and  $v_k, \gamma_k$  are odd on  $t$ , then, for any  $M \in \mathbb{N}$ , there exist numbers  $M_k, N_k \in \mathbb{N}$  such that

$$\Lambda(\rho_k)(t, x) = \sum_{j=1}^{M_k} i g_{\text{odd}, j}(v, t) \text{sym}((Q_j)_k)(t, x) + \sum_{j=1}^{N_k} g_{\text{even}, j}(v, t) \text{sym}((P_j)_k)(t, x) + O(v^{2M}),$$

where each real function  $g_{\text{odd}, j}$  satisfies (3.0.8), each real function  $g_{\text{even}}$  satisfies (3.0.9),  $P_j \left( \frac{\cdot}{\sqrt{\omega}} \right)$  and  $Q_j \left( \frac{\cdot}{\sqrt{\omega}} \right)$  are real functions in  $\mathcal{S}_{\infty}^+$ , and the term  $O(v^{2M})$  means a smooth function  $r(t, x)$  satisfying

$$(3.0.10) \quad \left\| \frac{\partial^l}{\partial t^l} r(t, x) \right\|_{H_x^s(\mathbb{R})} \lesssim_{s, l} v^{2M+l} \left( |t|v + \ln \frac{1}{v} \right)^{\sigma} e^{-2\sqrt{\omega}|t|v},$$

for some constant  $\sigma > 0$ , and any  $s \geq 0$ , any  $l \in \mathbb{N}$ .

*Proof.* First, we can verify by the definition (3.0.6) that

$$\begin{aligned} i \frac{\partial}{\partial t} \rho_k(t, x) &= -i e^{i(\gamma_k(t) + \frac{v_k(t)}{2} [x - \frac{\zeta_k(t)}{2}])} \dot{\zeta}_k(t) \rho'(x - \zeta_k(t)) \\ &\quad - (\dot{\gamma}_k(t) - \omega) e^{i(\gamma_k(t) + \frac{v_k(t)}{2} [x - \frac{\zeta_k(t)}{2}])} \rho(x - \zeta_k(t)) \\ &\quad - \frac{\dot{v}_k(t)}{2} e^{i(\gamma_k(t) + \frac{v_k(t)}{2} [x - \frac{\zeta_k(t)}{2}])} (x - \zeta_k(t)) \rho(x - \zeta_k(t)) \\ &\quad - \frac{\dot{v}_k(t) \zeta_k(t)}{4} e^{i(\gamma_k(t) + \frac{v_k(t)}{2} [x - \frac{\zeta_k(t)}{2}])} \rho(x - \zeta_k(t)). \end{aligned}$$

Consequently, using Lemma 2.14 for  $\rho = \phi_\omega$ , and the chain rule of the derivative, we can verify that  $[i\partial_t + \partial_x^2] \rho_k(t, x) + F'(|\phi_{\omega,k}(t, x)|^2)\phi_{\omega,k}(t, x) - F'(|\phi_{\omega,k}(t, -x)|^2)\phi_{\omega,k}(t, -x)$  is equal to the following finite sum

$$(3.0.11) \quad i \sum_{j=1}^N g_{odd,j}(v, t) \text{sym}((Q_j)_k)(t, x) + \sum_{j=1}^n g_{even,j}(v, t) \text{sym}((P_j)_k)(t, x),$$

for some functions  $g_{odd,j}$ ,  $g_{even,j}$ ,  $Q_j$ ,  $P_j$  satisfying all the properties of Lemma 3.6.

Moreover,  $F'(\phi^2)\phi$  is an odd polynomial. Consequently, since  $\rho_k$  is defined by (3.0.6) and

$$\alpha_k(t, x) - \alpha_k(t, -x) = v_k x,$$

we can verify using Lemma 2.8 and the hypotheses satisfied by  $f_{odd,j}$  and  $f_{even,j}$  that  $F'(|\rho_k|^2)\rho_k - F'(|\phi_{\omega,k}(t, x)|^2)\phi_{\omega,k}(t, x) + F'(|\phi_{\omega,k}(t, -x)|^2)\phi_{\omega,k}(t, -x)$  is a finite sum of terms having one of the following forms

$$\begin{aligned} & i\alpha_{odd,j}(t) \text{Sym}((Q_1)_k)(t, x), \\ & \alpha_{even,j}(t) \text{Sym}((Q_1)_k)(t, x), \\ & i\alpha_{odd}(t) \left[ Q_1(x - \zeta_k(t))Q_2(x + \zeta_k(t))e^{i\alpha_k(t,x)} - Q_1(-x - \zeta_k(t))Q_2(-x + \zeta_k(t))e^{i\alpha_k(t,-x)} \right], \\ & \alpha_{even}(t) \left[ Q_1(x - \zeta_k(t))Q_2(x + \zeta_k(t))e^{i\alpha_k(t,x)} - Q_1(-x - \zeta_k(t))Q_2(-x + \zeta_k(t))e^{i\alpha_k(t,-x)} \right], \\ & i\alpha_{odd}(t) \left[ Q_1(x - \zeta_k(t))Q_2(x + \zeta_k(t))e^{i\alpha_k(t,x)} \cos(mv_k x) \right. \\ & \quad \left. - Q_1(-x - \zeta_k(t))Q_2(-x + \zeta_k(t))e^{i\alpha_k(t,-x)} \cos(mv_k x) \right], \\ & \alpha_{even}(t) \left[ Q_1(x - \zeta_k(t))Q_2(x + \zeta_k(t))e^{i\alpha_k(t,x)} \cos(mv_k x) \right. \\ & \quad \left. - Q_1(-x - \zeta_k(t))Q_2(-x + \zeta_k(t))e^{i\alpha_k(t,-x)} \cos(mv_k x) \right], \\ & \alpha_{odd}(t) \left[ Q_1(x - \zeta_k(t))Q_2(x + \zeta_k(t))e^{i\alpha_k(t,x)} \sin(mv_k x) \right. \\ & \quad \left. + Q_1(-x - \zeta_k(t))Q_2(-x + \zeta_k(t))e^{i\alpha_k(t,-x)} \sin(mv_k x) \right], \\ & i\alpha_{even}(t) \left[ Q_1(x - \zeta_k(t))Q_2(x + \zeta_k(t))e^{i\alpha_k(t,x)} \sin(mv_k x) \right. \\ & \quad \left. + Q_1(-x - \zeta_k(t))Q_2(-x + \zeta_k(t))e^{i\alpha_k(t,-x)} \sin(mv_k x) \right] \end{aligned}$$

such that  $m$  and  $l$  are integers,  $Q_1 \in S_\infty^+$ ,  $Q_2 \in S_\infty^-$ ,  $\alpha_{even}$  is an even function,  $\alpha_{odd}$  is an odd function both satisfying estimates (3.0.8) and (3.0.9) respectively.

Furthermore, the functions  $\cos$ ,  $\sin$  are entire and we have

$$\begin{aligned} \cos(mv_k x) &= \cos(mv_k(x - \zeta_k)) \cos(mv_k \zeta_k) - \sin(mv_k(x - \zeta_k)) \sin(mv_k \zeta_k), \\ \sin(mv_k x) &= \sin(mv_k(x - \zeta_k)) \cos(mv_k \zeta_k) + \cos(mv_k(x - \zeta_k)) \sin(mv_k \zeta_k) \end{aligned}$$

Consequently, for any  $M \in \mathbb{N}$ , we can verify from Lemma 2.9 and Taylor's Expansion Theorem for the functions  $\sin$ ,  $\cos$  that  $F'(|\rho_k(t, x)|^2)\rho_k(t, x)$  is equal to a expression of the form (3.0.11) plus a remainder  $r(t, x)$  satisfying (3.0.10).  $\square$

From now on, we consider

$$(3.0.12) \quad \phi_{\omega,k}(t, x) := \phi_\omega(x - \zeta_k(t)) e^{i\frac{v_k(t)}{2}(x - \frac{\zeta_k(t)}{2})} e^{i\gamma_k(t)}.$$

We also use the following notation

$$(3.0.13) \quad \alpha_k(t) := \frac{v_k(t)}{2} \left[ x - \frac{\zeta_k(t)}{2} \right] + \gamma_k(t).$$



Using the identity

$$\phi_\omega'' - \omega\phi_\omega + F'(\phi_\omega^2)\phi_\omega = 0,$$

it is not difficult to verify that

$$(3.0.14) \quad \begin{aligned} \Lambda(\phi_{\omega,k})(t,x) &= i\dot{v}_k(t)\partial_{v_k}\phi_{\omega,k} + i(\dot{\zeta}_k(t) - v_k(t))\partial_{\zeta_k}\phi_{\omega,k} \\ &\quad + i(\dot{\gamma}_k(t) - \omega)\partial_{\gamma_k}\phi_{\omega,k}. \end{aligned}$$

Next, before we start to prove Theorem 3.1, we are going to consider the following proposition which is equivalent to the Theorem 3.1 when  $k = 1$ .

**Lemma 3.7.** *There exist constants  $C, \sigma > 0 \in \mathbb{R}$  such that for  $c_\omega = \frac{\sqrt{C}}{\omega^{\frac{1}{4}}}$  if  $0 < v \ll 1$  and  $d$  is the unique solution of*

$$(3.0.15) \quad \begin{cases} \ddot{d}(t) = Ce^{-2\sqrt{\omega}d(t)}, \\ \lim_{t \rightarrow +\infty} \left| d(t) - vt - \frac{1}{\sqrt{\omega}} \ln \frac{c_\omega}{v} \right| = 0, \quad \lim_{t \rightarrow +\infty} |d(t) - v| = 0, \end{cases}$$

then

$$(3.0.16) \quad u_1(t,x) = e^{i\omega t} e^{\frac{id(t)}{2}\left(x - \frac{d(t)}{2}\right)} \phi_\omega(x - d(t)) - e^{i\omega t} e^{-\frac{id(t)}{2}\left(x + \frac{d(t)}{2}\right)} \phi_\omega(x + d(t))$$

satisfies

$$\begin{aligned} \left\| \frac{\partial^l}{\partial t^l} \Lambda(u_1)(t,x) \right\|_{H_x^s(\mathbb{R})} &\leq C(s,l)v^{2+l}e^{-2\sqrt{\omega}|t|v}, \\ \left| \left\langle \frac{\partial^l}{\partial t^l} \Lambda(u_1)(t,x), \phi'_\omega(x \pm d(t))e^{i\alpha(t,\mp x)} \right\rangle \right| &\leq C(l)v^{4+l}(1 + |t|v)^\sigma e^{-2\sqrt{\omega}|t|v}. \end{aligned}$$

*Proof of Lemma 3.7.* First, to simplify the notation used in the proof, we consider for all  $(t,x) \in \mathbb{R}^2$

$$\alpha(t,x) = \omega t + \frac{\dot{d}(t)}{2} \left( x - \frac{d(t)}{2} \right),$$

using the identity

$$\phi_\omega''(x) - \omega\phi_\omega(x) + F'(\phi_\omega(x)^2)\phi_\omega(x) = 0,$$

we can verify that

$$(3.0.17) \quad \begin{aligned} \Lambda(u_1)(t,x) &= -\frac{\ddot{d}(t)}{2} \left[ \left( x - \frac{d(t)}{2} \right) \phi_\omega(x - d(t)) e^{i\alpha(t,x)} + \left( x + \frac{d(t)}{2} \right) \phi_\omega(x + d(t)) e^{i\alpha(t,-x)} \right] \\ &\quad + F'(|u_1(t,x)|^2)u_1(t,x) - F'(\phi_\omega(x - d(t))^2)\phi_\omega(x - d(t))e^{i\alpha(t,x)} \\ &\quad + F'(\phi_\omega(x + d(t))^2)\phi_\omega(x + d(t))e^{i\alpha(t,-x)}. \end{aligned}$$

The ordinary differential equation that  $d$  will satisfy is similar to the one obtained in the statement of Theorem 3.1 from [9]. Indeed, the ordinary differential equation obtained in [9] is equivalent to (3.0.15) when  $F'(z) \equiv z$ .

Before the construction of the ordinary differential equation (3.0.15), we need to estimate the contribution coming from the nonlinearity of (1.0.1). From Taylor's Expansion Theorem, we deduce

that

(3.0.18)

$$\begin{aligned}
& F' (|u_1(t, x)|^2) u_1(t, x) - F' (\phi_\omega(x - d(t))^2) \phi_\omega(x - d(t)) e^{i\alpha(t, x)} + F' (\phi_\omega(x + d(t))^2) \phi_\omega(x + d(t)) e^{i\alpha(t, -x)} \\
& = -2 \cos(\dot{d}(t)x) F'' (\phi_\omega(x + d(t))^2 + \phi_\omega(x - d(t))^2) u_1(t, x) \phi_\omega(x - d(t)) \phi_\omega(x + d(t)) \\
& \quad + F' (\phi_\omega(x + d(t))^2 + \phi_\omega(x - d(t))^2) u_1(t, x) - F' (\phi_\omega(x - d(t))^2) \phi_\omega(x - d(t)) e^{i\alpha(t, x)} \\
& \quad + F' (\phi_\omega(x + d(t))^2) \phi_\omega(x + d(t)) e^{i\alpha(t, -x)} \\
& \quad + O(\phi_\omega(x + d(t))^2 \phi_\omega(x - d(t))^2),
\end{aligned}$$

where the expression  $O(\phi_\omega(x + d(t))^2 \phi_\omega(x - d(t))^2)$  means a smooth function  $p(t, x)$  satisfying

$$|p(t, x)| \lesssim \phi_\omega(x + d(t))^2 \phi_\omega(x - d(t))^2.$$

Moreover, using estimate (2.0.1) from Lemma 5.0.9, we obtain from (3.0.18) that

(3.0.19)

$$\begin{aligned}
& F' (|u_1(t, x)|^2) u_1(t, x) - F' (\phi_\omega(x - d(t))^2) \phi_\omega(x - d(t)) e^{i\alpha(t, x)} + F' (\phi_\omega(x + d(t))^2) \phi_\omega(x + d(t)) e^{i\alpha(t, -x)} \\
& = -2 \cos(\dot{d}(t)x) F'' (\phi_\omega(x + d(t))^2 + \phi_\omega(x - d(t))^2) u_1(t, x) \phi_\omega(x - d(t)) \phi_\omega(x + d(t)) \\
& \quad - F' (\phi_\omega(x - d(t))^2) \phi_\omega(x + d(t)) e^{i\alpha(t, -x)} + F' (\phi_\omega(x + d(t))^2) \phi_\omega(x - d(t)) e^{i\alpha(t, x)} \\
& \quad + O(\phi_\omega(x + d(t))^2 \phi_\omega(x - d(t))^2),
\end{aligned}$$

Therefore, from Lemma 2.1, identity (3.0.17), estimate (3.0.19) and the inequalities

$$|\cos(\dot{d}(t)x) - 1| \lesssim |\dot{d}(t)|^2 |x|^2, \quad \left| F'(\phi_\omega(x)^2) \right| \lesssim |\phi_\omega(x)^2|,$$

we obtain using inequality (2.0.1) of Lemma 2.2 that there exists  $\sigma > 0$  satisfying

$$\begin{aligned}
\left\langle \Lambda(u_1)(t, x), \phi'_\omega(x - d(t)) e^{i\alpha(t, x)} \right\rangle &= \frac{\ddot{d}(t)}{4} \left[ \|\phi_\omega\|_{L^2}^2 + O\left((1 + |d(t)|)^2 e^{-2\sqrt{\omega}d(t)}\right) \right] \\
&\quad - 2 \int_{\mathbb{R}} F''(\phi_\omega(x)^2) \phi_\omega(x)^2 \phi'_\omega(x) \phi_\omega(x + 2d) dx \\
&\quad - \int_{\mathbb{R}} F'(\phi_\omega(x)^2) \phi'_\omega(x) \phi_\omega(x + 2d) dx \\
&\quad + O\left(e^{-4\sqrt{\omega}d} (1 + |d|)^\sigma + \dot{d}^2 e^{-2\sqrt{\omega}d} (1 + |d|)^\sigma\right).
\end{aligned}$$

In conclusion, we obtain using integration by parts that

$$\begin{aligned}
(3.0.20) \quad \left\langle \Lambda(u_1)(t, x), \phi'_\omega(x - d(t)) e^{i\alpha(t, x)} \right\rangle &= \frac{\ddot{d}(t)}{4} \left[ \|\phi_\omega\|_{L^2}^2 + O\left((1 + |d(t)|)^2 e^{-2\sqrt{\omega}d(t)}\right) \right] \\
&\quad + \int_{\mathbb{R}} F'(\phi_\omega(x)^2) \phi_\omega(x) \phi'_\omega(x + 2d) dx \\
&\quad + O\left(e^{-4\sqrt{\omega}d} (1 + |d|)^\sigma + \dot{d}^2 e^{-2\sqrt{\omega}d} (1 + |d|)^\sigma\right).
\end{aligned}$$

for a constant  $\sigma > 0$ .

Furthermore, since  $\phi_\omega\left(\frac{\cdot}{\sqrt{\omega}}\right) \in \mathcal{S}^+$ , we have for the  $a_{+\infty} > 0$  defined on Remark 1.2

$$\left| \phi'_\omega(x) + a_{+\infty} \sqrt{\omega} e^{-\sqrt{\omega}x} \right| \lesssim \min\left(e^{-\sqrt{\omega}x}, e^{-2\sqrt{\omega}x}\right).$$

Therefore, we can deduce from the estimate (3.0.20) that

$$\begin{aligned} \left\langle \Lambda(u_1)(t, x), \phi'_\omega(x - d(t))e^{i\alpha(t, x)} \right\rangle &= \frac{\dot{d}(t)}{4} \left[ \|\phi_\omega\|_{L^2}^2 + O\left((1 + |d(t)|)^2 e^{-2\sqrt{\omega}d(t)}\right) \right] \\ &\quad - a_{+\infty} \sqrt{\omega} e^{-2\sqrt{\omega}d} \int_{\mathbb{R}} F'(\phi_\omega(x)^2) \phi_\omega(x) e^{-\sqrt{\omega}x} dx \\ &\quad + O\left(e^{-4\sqrt{\omega}d} (1 + |d|)^\sigma + d^2 e^{-2\sqrt{\omega}d} (1 + |d|)^\sigma\right), \end{aligned}$$

Concerning the estimate above, we choose the following ordinary differential equation

$$(3.0.21) \quad \ddot{d}(t) = \frac{4a_{+\infty}}{\|\phi_\omega\|_{L^2}^2} \sqrt{\omega} e^{-2\sqrt{\omega}d} \int_{\mathbb{R}} F'(\phi_\omega(x)^2) \phi_\omega(x) e^{-\sqrt{\omega}x} dx = C e^{-2\sqrt{\omega}d}.$$

Moreover, since  $\phi''_\omega - \omega\phi_\omega = -F'(\phi_\omega^2)\phi_\omega$ , we have from integration by parts that

$$\int_{\mathbb{R}} F'(\phi_\omega(x)^2) \phi_\omega(x) e^{-\sqrt{\omega}x} dx = \lim_{x \rightarrow -\infty} \phi'_\omega(x) e^{-\sqrt{\omega}x} + \sqrt{\omega} \phi_\omega(x) e^{-\sqrt{\omega}x} = 2a_{+\infty} \sqrt{\omega},$$

so  $C$  is positive and depends only on  $\omega$ . Indeed, the function

$$(3.0.22) \quad d(t) = \frac{1}{\sqrt{\omega}} \ln \left[ \frac{\sqrt{C} (\cosh(\sqrt{\omega}vt))}{\omega^{\frac{1}{4}} v} \right],$$

satisfies (3.0.15) for  $c_\omega = \frac{\sqrt{C}}{\omega^{\frac{1}{4}}}$ . Similarly to the proof Lemma 3.1 from [23], we can verify by induction that if  $v > 0$  is small enough, then

$$(3.0.23) \quad |\dot{d}(t)| = O(v), \quad |d^{(l)}(t)| \lesssim_l v^l e^{-2\sqrt{\omega}v|t|} \text{ for all } l \geq 2.$$

In conclusion, similarly to the proof of Theorem 4.1 from [23], we can verify using Lemma 2.1, identity (3.0.17) and estimates (3.0.23) that  $u_1$  defined by (3.0.16) satisfies Theorem 3.1 for  $k = 0$ .  $\square$

**Remark 3.8.** Furthermore, applying Lemmas 2.1, 2.9 in estimate (3.0.19), we can verify that

$$(3.0.24) \quad \begin{aligned} &F'(|u_1(t, x)|^2) u_1(t, x) - F'(\phi_\omega(x - d(t))^2) \phi_\omega(x - d(t)) e^{i\alpha(t, x)} + F'(\phi_\omega(x + d(t))^2) \phi_\omega(x + d(t)) e^{i\alpha(t, -x)} \\ &= -2a_{+\infty} e^{-2\sqrt{\omega}d(t)} \text{Sym} \left[ F''(\phi_\omega(\cdot - d(t))^2) \phi_\omega(\cdot - d(t))^2 e^{i\alpha(t, \cdot)} e^{-\sqrt{\omega}(\cdot - d(t))} \right] (x) \\ &\quad - a_{+\infty} e^{-2\sqrt{\omega}d(t)} \text{Sym} \left[ F'(\phi_\omega(\cdot - d(t))^2) e^{-\sqrt{\omega}(\cdot - d(t))} e^{i\alpha(t, \cdot)} \right] (x) \\ &\quad + O(\phi_\omega(x + d(t))^2 \phi_\omega(x - d(t))^2) \\ &= \text{Forc}(t, x) + O(\phi_\omega(x + d(t))^2 \phi_\omega(x - d(t))^2). \end{aligned}$$

Consequently, for

$$\alpha_0(t, x) = \gamma_1(t) + \frac{\dot{d}(t)}{2} \left( x - \frac{d(t)}{2} \right)$$

we can verify that similarly to the proof of estimate (3.0.17) for any smooth functions  $f_{\omega,1}(t)$ ,  $f_\zeta$  satisfying

$$(3.0.25) \quad \left| \frac{d^l}{dt^l} f_\zeta(t) \right| + \left| \frac{d^l}{dt^l} f_{\omega,1}(t) \right| = O\left(v^{2+l} \left( |t|v + \ln \frac{1}{v} \right)^\sigma e^{-\sqrt{2}|t|v}\right)$$

that

$$\begin{aligned} u_2(t, x) &= e^{i\alpha_0(t, x)} \phi_\omega(x - d(t) - f_\zeta(t)) - e^{i\alpha_0(t, -x)} \phi_\omega(x + d(t) + f_\zeta(t)) \\ &\quad + f_{\omega,1}(t) \left[ e^{i\alpha_0(t, x)} \partial_\omega \phi_\omega(x - d(t) - f_\zeta(t)) - e^{i\alpha_0(t, -x)} \partial_\omega \phi_\omega(x + d(t) + f_\zeta(t)) \right] \end{aligned}$$

satisfies

$$\begin{aligned}
(3.0.26) \quad & \Lambda(u_2)(t, x) \\
&= -\frac{\ddot{d}(t)}{2} \text{Sym} \left[ \left( \cdot - \frac{d(t)}{2} \right) \phi_\omega(\cdot - d(t) - f_\zeta(t)) e^{i\alpha_0(t, \cdot)} \right] (x) \\
&\quad + i\dot{f}_{\omega,1}(t) \text{Sym} \left[ \partial_\omega \phi_\omega(\cdot - d(t) - f_\zeta(t)) e^{i\alpha_0(t, \cdot)} \right] (x) \\
&\quad - f_{\omega,1}(t) \text{Sym} \left[ S_\omega(\partial_\omega \phi_\omega)(\cdot - d(t) - f_\zeta(t)) e^{i\alpha_0(t, \cdot)} \right] (x) - (\dot{\gamma}_1(t) - \omega) \text{Sym} \left[ \phi_\omega(\cdot - d(t) - f_\zeta(t)) e^{i\alpha_0(t, \cdot)} \right] (x) \\
&\quad - i\dot{f}_\zeta(t) \text{Sym} \left[ \phi'_\omega(\cdot - d(t) - f_\zeta(t)) e^{i\alpha_0(t, \cdot)} \right] (x) + \text{Forc}(t, x) + O \left( v^4 \left( |t|v + \ln \frac{1}{v} \right)^\sigma e^{-\sqrt{2}|t|v} \right),
\end{aligned}$$

where the remainder above means a smooth function  $p(t, x)$  satisfying for any  $l \in \mathbb{N}$

$$\|\partial_t^l p(t, x)\|_{H^1} = O \left( v^{4+l} \left( |t|v + \ln \frac{1}{v} \right)^\sigma e^{-\sqrt{2}|t|v} \right),$$

the estimates above follow from Lemmas 2.1 and 2.9. Considering the following ordinary differential system

$$\begin{aligned}
\dot{f}_{\omega,1}(t) \langle \partial_\omega \phi_\omega, \phi_\omega \rangle &= -a_{+\infty} e^{-2\sqrt{\omega}d(t)} \dot{d}(t) \left\langle F'(\phi_\omega(x)^2) e^{-\sqrt{\omega}x}, x\phi_\omega(x) \right\rangle \\
&\quad - a_{+\infty} d(t) \dot{d}(t) e^{-2\sqrt{\omega}d(t)} \left\langle F'(\phi_\omega(x)^2) e^{-\sqrt{\omega}x}, \phi_\omega \right\rangle \\
(\dot{\gamma}_1(t) - \omega + \frac{\ddot{d}(t)d(t)}{4}) \langle \partial_\omega \phi_\omega, \phi_\omega \rangle &= -f_{\omega,1}(t) \langle S_\omega(\partial_\omega \phi_\omega), \phi_\omega \rangle \\
&\quad - 2a_{+\infty} e^{-2\sqrt{\omega}d(t)} \left\langle F''(\phi_\omega(x)^2) \phi_\omega(x)^2 e^{-\sqrt{\omega}x}, \partial_\omega \phi_\omega \right\rangle \\
&\quad - a_{+\infty} e^{-2\sqrt{\omega}d(t)} \left\langle F'(\phi_\omega(x)^2) e^{-\sqrt{\omega}x}, \partial_\omega \phi_\omega \right\rangle, \\
\frac{1}{2} \dot{f}_\zeta(t) \|\phi_\omega\|_{L^2}^2 &= -a_{+\infty} \dot{d}(t) e^{-2\sqrt{\omega}d(t)} \left\langle F'(\phi_\omega(x)^2) e^{-\sqrt{\omega}x}, x^2 \phi_\omega(x) \right\rangle \\
&\quad - a_{+\infty} d(t) \dot{d}(t) e^{-2\sqrt{\omega}d(t)} \left\langle F'(\phi_\omega(x)^2) e^{-\sqrt{\omega}x}, x\phi_\omega(x) \right\rangle, \\
\lim_{t \rightarrow +\infty} f_{\omega,1}(t) &= \lim_{t \rightarrow +\infty} f_\zeta(t) = \lim_{t \rightarrow +\infty} \gamma_1(t) - \omega t = 0,
\end{aligned}$$

it is not difficult to verify that (3.0.25) holds for some  $\sigma$ , because of (3.0.23) and the Fundamental Theorem of Calculus.

Furthermore, since we have from the estimate (3.0.26) that

$$\begin{aligned}
\left\langle \Lambda(u_2)(t, x), i\phi_\omega(x - d(t) - f_\zeta(t))e^{i\alpha_0(t, x)} \right\rangle &= \dot{f}_{\omega,1}(t) \langle \partial_\omega \phi_\omega, \phi_\omega \rangle \\
&\quad + \langle \text{Forc}(t, x), i\phi_\omega(x - d(t))e^{i\alpha_0(t, x)} \rangle \\
&\quad + O\left(v^4 \left(|t|v + \ln \frac{1}{v}\right)^\sigma e^{-2\sqrt{\omega}|t|v}\right), \\
\left\langle \Lambda(u_2)(t, x), \partial_\omega \phi_\omega(x - d(t) - f_\zeta(t))e^{i\alpha_1(t, x)} \right\rangle &= -(\dot{\gamma}_1(t) - \omega + \frac{\ddot{d}(t)d(t)}{4}) \langle \partial_\omega \phi_\omega, \phi_\omega \rangle \\
&\quad - f_{\omega,1}(t) \langle S_\omega(\partial_\omega \phi_\omega), \phi_\omega \rangle \\
&\quad + \langle \text{Forc}(t, x), \partial_\omega \phi_\omega(x - d(t) - f_\zeta(t))e^{i\alpha_0(t, x)} \rangle \\
&\quad + O\left(v^4 \left(|t|v + \ln \frac{1}{v}\right)^\sigma e^{-2\sqrt{\omega}|t|v}\right), \\
\left\langle \Lambda(u_2)(t, x), i(x - d(t) - f_\zeta(t))\phi_\omega(x - d(t) - f_\zeta(t))e^{i\alpha_0(t, x)} \right\rangle &= \frac{1}{2} f_\zeta(t) \|\phi'_\omega\|_{L^2}^2 \\
&\quad + \langle \text{Forc}(t, x), i(x - d(t))\phi_\omega(x - d(t))e^{i\alpha_0(t, x)} \rangle \\
&\quad + O\left(v^4 \left(|t|v + \ln \frac{1}{v}\right)^\sigma e^{-2\sqrt{\omega}|t|v}\right),
\end{aligned}$$

we can verify from the ordinary differential system above and Lemma 3.7 that

$$\begin{aligned}
\left| \frac{d^l}{dt^l} \left\langle \Lambda(u_2)(t, x), i(x - d(t))\phi_\omega(x - d(t))e^{i\alpha_0(t, x)} \right\rangle \right| &= O\left(v^{4+l} \left(|t|v + \ln \frac{1}{v}\right)^\sigma e^{-2\sqrt{\omega}|t|v}\right), \\
\left| \frac{d^l}{dt^l} \left\langle \Lambda(u_2)(t, x), i\phi_\omega(x - d(t))e^{i\alpha_0(t, x)} \right\rangle \right| &= O\left(v^{4+l} \left(|t|v + \ln \frac{1}{v}\right)^\sigma e^{-2\sqrt{\omega}|t|v}\right), \\
\left| \frac{d^l}{dt^l} \left\langle \Lambda(u_2)(t, x), \partial_\omega \phi_\omega(x - d(t))e^{i\alpha_0(t, x)} \right\rangle \right| &= O\left(v^{4+l} \left(|t|v + \ln \frac{1}{v}\right)^\sigma e^{-2\sqrt{\omega}|t|v}\right), \\
\left| \frac{d^l}{dt^l} \left\langle \Lambda(u_2)(t, x), \phi'_\omega(x - d(t))e^{i\alpha_0(t, x)} \right\rangle \right| &= O\left(v^{4+l} \left(|t|v + \ln \frac{1}{v}\right)^\sigma e^{-2\sqrt{\omega}|t|v}\right),
\end{aligned}$$

for any  $l \in \mathbb{N}$ .

*Proof of Theorem 3.1. Step 1.* (Construction of  $\varphi_1$ .) In notation of Lemma 3.7 and Remark 3.8, we consider

$$\alpha_1(t, x) = \gamma_1(t) + \frac{\dot{d}(t) + \dot{f}_\zeta(t)}{2} \left( x - \frac{d(t) + f_\zeta(t)}{2} \right),$$

and we recall the space translation function  $\tau_{d+f_\zeta}$  defined by

$$\tau_{d+f_\zeta} \rho(t, x) := \rho(t, x - d - f_\zeta).$$

In notation of Lemma 2.16, we consider  $\Pi^\perp := Id - \Pi$ , which is the projection in the orthogonal complement of  $\{\phi_\omega, i\phi'_\omega, i\partial_\omega \phi_\omega, x\phi_\omega\}$  in  $L^2(\mathbb{R}, \mathbb{C})$ . Moreover, we consider

$$\begin{aligned}
\varphi_{1,0}(t, x) &= e^{i\alpha_1(t, x)} \phi_\omega(x - d(t) - f_\zeta(t)) - e^{i\alpha_1(t, -x)} \phi_\omega(x + d(t) + f_\zeta(t)) \\
&\quad + f_{\omega,1}(t) \left[ e^{i\alpha_1(t, x)} \partial_\omega \phi_\omega(x - d(t) - f_\zeta(t)) - e^{i\alpha_1(t, -x)} \partial_\omega \phi_\omega(x + d(t) + f_\zeta(t)) \right]
\end{aligned}$$

From Lemma 3.7 and Remark 3.8, we obtain for any  $l \in \mathbb{N}$  that there exists  $\sigma > 0$  satisfying

$$\|\partial_t^l \Lambda(\varphi_{1,0})(t, x)\|_{H^1} v^{2+l} \left(|t|v + \ln \frac{1}{v}\right)^\sigma e^{-2\sqrt{\omega}|t|v}.$$

Furthermore, using Remark 3.8, estimates (3.0.25) and Lemma 3.6, it is not difficult to verify that there exist real functions  $p_j \in \mathcal{S}_\infty^+$ , and real functions  $f_{even,j}, f_{odd,j}$  satisfying

$$(3.0.27) \quad \begin{aligned} \Lambda(\varphi_{1,0}(t, x)) &= \sum_{j \in K_0} f_{even,j}(t) \text{Sym} \left[ \tau_{d(t)+f_\zeta(t)} p_j(\cdot) e^{i\alpha_1(t, \cdot)} \right] (x) \\ &\quad + \sum_{j \in M_0} f_{odd,j}(t) \text{Sym} \left[ \tau_{d(t)+f_\zeta(t)} i p_j(\cdot) e^{i\alpha_1(t, \cdot)} \right] (x) \\ &\quad + O \left( v^{20} \left( \ln \frac{1}{v} + |t|v \right)^\sigma e^{-2\sqrt{\omega}|t|v} \right), \end{aligned}$$

such that  $|\frac{d^l}{dt^l} f_{even,j}(t)| + |\frac{d^l}{dt^l} f_{odd,j}(t)| \lesssim_l v^{2+l} (|t|v + \ln \frac{1}{v})^\sigma e^{-2\sqrt{\omega}|t|v}$ , and

$$\left\| \sum_{j \in K_0} \frac{d^l}{dt^l} f_{even,j}(t) \Pi[p_j](x) + \sum_{j \in M_0} \frac{d^l}{dt^l} f_{odd,j}(t) \Pi[ip_j](x) \right\|_{H^1} \lesssim_l v^{4+l} \left( |t|v + \ln \frac{1}{v} \right)^\sigma e^{-2\sqrt{\omega}|t|v},$$

because of Remark 3.8.

Next, using Lemma 2.15, we can consider the following additional terms

$$\begin{aligned} \text{Corr}_{1,1}(t, x) &= \sum_{j \in K_0} f_{even,j}(t) \text{Sym} \left[ e^{\alpha_1(t, \cdot)} \tau_{d(t)+f_\zeta} S_\omega^{-1} \{ \Pi^\perp[p_j] \} (\cdot) \right] (x) \\ &\quad + \sum_{j \in M_0} f_{odd,j}(t) \text{Sym} \left[ e^{\alpha_1(t, \cdot)} \tau_{d(t)+f_\zeta} S_\omega^{-1} \{ \Pi^\perp[ip_j] \} (\cdot) \right] (x), \end{aligned}$$

and

$$\begin{aligned} \text{Corr}_{2,1}(t, x) &= \sum_{j \in K_0} \dot{f}_{even,j}(t) \text{Sym} \left[ e^{\alpha_1(t, \cdot)} \tau_{d(t)+f_\zeta} S_\omega^{-1} i S_\omega^{-1} \{ \Pi^\perp[p_j] \} (\cdot) \right] (x) \\ &\quad + \sum_{j \in M_0} \dot{f}_{odd,j}(t) \text{Sym} \left[ e^{\alpha_1(t, \cdot)} \tau_{d(t)+f_\zeta} S_\omega^{-1} i S_\omega^{-1} \{ \Pi^\perp[ip_j] \} (\cdot) \right] (x). \end{aligned}$$

For any function  $\rho$  with domain  $\mathbb{R}$ , let

$$(3.0.28) \quad \rho_1(t, x) := e^{i\alpha_1(t, x)} \rho(x - d(t) - f_\zeta(t)), \text{ for any } (t, x) \in \mathbb{R}^2.$$

Using Lemma 2.14, the estimates from Remark 3.8 and (3.0.23), we can verify for any  $j \in M_0 \cup K_0$  that

$$(3.0.29) \quad \begin{aligned} i\partial_t [f_j(t) S_\omega^{-1}(p_j)_1(t, x)] + \partial_x^2 [f_j(t) S_\omega^{-1}(p_j)_1(t, x)] + f_j(t) F''(|\phi_{\omega,1}|^2) f_j(t) S_\omega^{-1}(p_j)_1(t, x) \\ + f_j(t) F''(|\phi_{\omega,k}|^2) |\phi_{\omega,k}|^2 e^{2i\alpha_1(t)} \overline{S_\omega^{-1}(p_j)_1(t, x)} = -f_j(t) p_{j,1}(t) + i \dot{f}_j(t) S_\omega^{-1}(p_j)_1(t, x) \\ + O \left( v^4 \left( |t|v + \ln \left( \frac{1}{v} \right) \right)^\sigma e^{-2\sqrt{\omega}|t|v} \right), \end{aligned}$$

the remainder above means a smooth function  $\rho(t, x)$  satisfying

$$\|\partial_t^l \rho(t, x)\|_{H^1} \lesssim_l v^{4+l} \left( |t|v + \ln \left( \frac{1}{v} \right) \right)^\sigma e^{-2\sqrt{\omega}|t|v}.$$

Furthermore, Lemmas 2.1, 2.15 and (3.0.23) imply for any  $i, j \in \{1, 2, 3\}$  that there exists a constant  $\sigma > 0$  satisfying

$$\|p_{j,\omega}(x - d(t)) p_{i,\omega}(x + d(t))\|_{H_x^1(\mathbb{R})} + \|\phi_\omega(x \pm d) p_j(x \mp d)\|_{H_x^1(\mathbb{R})} = O \left( v^2 \left( |t|v + \ln \left( \frac{1}{v} \right) \right)^\sigma e^{-2\sqrt{\omega}|t|v} \right).$$

From now on, we choose the expression from equation (3.0.3) in the statement of Theorem 3.1

$$(3.0.30) \quad \sum_{j \in J} ig_{odd,j}(t) \left[ e^{i\alpha_1(t,x)} p_{j,\omega}(x - d(t) - f_\zeta(t)) - e^{-\alpha_1(t,x)} p_{j,\omega}(-x - d(t) - f_\zeta(t)) \right] \\ + \sum_{j \in I} g_{even,j}(t) \left[ e^{i\alpha_1(t,x)} p_{j,\omega}(x - d(t) - f_\zeta(t)) - e^{-\alpha_1(t,x)} p_{j,\omega}(-x - d(t) - f_\zeta(t)) \right]$$

to be equal to  $Corr_1(t,x) + Corr_2(t,x)$ .

Consequently, we deduce from estimates (3.0.17), (3.0.19), (3.0.27) and (3.0.29) that the function  $\varphi_1$  defined by

$$\varphi_1(t, x) := \varphi_{1,0}(t, x) + Corr_1(t, x) + Corr_2(t, x)$$

satisfies Theorem 3.1 for  $k = 1$ . The oddness and evenness of each real function  $f_{even,j}$ ,  $f_{odd,j}$  in  $Corr_1$  and  $Corr_2$  follows from Remark 2.19.

Furthermore, the estimates of Remark 3.8 imply for some  $\sigma > 0$  that

$$\left| \frac{d^l}{dt^l} \left\langle \Lambda(\varphi_1)(t, x), e^{i\alpha_1(t,\pm x)} \phi'_\omega(\pm x - d(t) - f_\zeta) \right\rangle \right| = O \left( v^{4+l} \left( |t|v + \ln \left( \frac{1}{v} \right) \right)^\sigma e^{-2\sqrt{\omega}v|t|} \right), \\ \left| \frac{d^l}{dt^l} \left\langle \Lambda(\varphi_1)(t, x), ie^{i\alpha_1(t,\pm x)} \phi_\omega(\pm x - d(t) - f_\zeta(t)) \right\rangle \right| = O \left( v^{4+l} \left( |t|v + \ln \left( \frac{1}{v} \right) \right)^\sigma e^{-2\sqrt{\omega}v|t|} \right), \\ \left| \frac{d^l}{dt^l} \left\langle \Lambda(\varphi_1)(t, x), e^{i\alpha_1(t,\pm x)} \partial_\omega \phi_\omega(\pm x - d(t) - f_\zeta) \right\rangle \right| = O \left( v^{4+l} \left( |t|v + \ln \left( \frac{1}{v} \right) \right)^\sigma e^{-2\sqrt{\omega}v|t|} \right), \\ \left| \frac{d^l}{dt^l} \left\langle \Lambda(\varphi_1)(t, x), e^{i\alpha_1(t,\pm x)} (\pm x - d(t) - f_\zeta) \phi_\omega(\pm x - d(t) - f_\zeta) \right\rangle \right| = O \left( v^{4+l} \left( |t|v + \ln \left( \frac{1}{v} \right) \right)^\sigma e^{-2\sqrt{\omega}v|t|} \right)$$

for all  $l \in \mathbb{N}$ , if  $v > 0$  is small enough.

**Step 2.** (Estimate of  $\Lambda(\varphi_k)$ .) From now on, we consider the existence of functions  $v_k$ ,  $\zeta_k$ ,  $\gamma_k$  and a smooth function  $\varphi_k : \mathbb{R}^2 \rightarrow \mathbb{R}$  satisfying all the properties of Theorem 3.1 until  $k = k_0 \geq 1$ . To simplify our notation, we consider

$$(3.0.31) \quad \alpha_k(t, x) = \gamma_k(t) + \frac{v_k(t)}{2} \left( x - \frac{\zeta_k(t)}{2} \right).$$

First, using Lemma 2.14, we can obtain the following identity for any smooth function  $\rho$

$$\left[ \frac{\partial^2}{\partial x^2} - \omega \right] \rho_k(t, x) + \left( F'(|\phi_{\omega,k}|^2) + F''(|\phi_{\omega,k}|^2) |\phi_{\omega,k}|^2 \right) \rho_k(t, x) + F''(|\phi_{\omega,k}|^2) |\phi_{\omega,k}|^2 e^{2i\alpha_k(t)} \bar{\rho}_k(t, x) \\ = - (S_\omega \rho)_k(t, x) - \frac{v_k(t)^2}{4} \rho_k(t, x) + i v_k(t) \left( \rho' \right)_k(t, x).$$

Consequently, we obtain that

$$(3.0.32) \quad i \frac{\partial \rho_k(t, x)}{\partial t} + \frac{\partial^2 \rho_k(t, x)}{\partial x^2} + \left( F'(|\phi_{\omega,k}|^2) + F''(|\phi_{\omega,k}|^2) |\phi_{\omega,k}|^2 \right) \rho_k(t, x) + F''(|\phi_{\omega,k}|^2) \phi_{\omega,k}^2 \bar{\rho}_k(t, x) \\ = - (S_\omega \rho)_k(t, x) - i [\dot{\zeta}_k(t) - v_k(t)] \left( \rho' \right)_k(t, x) \\ - \frac{\dot{v}_k(t)}{2} \left[ x - \frac{\zeta_k(t)}{2} \right] \rho_k(t, x) + [\dot{\zeta}_k(t) - v_k(t)] \frac{v_k(t)}{4} \rho_k(t, x) \\ - (\dot{\gamma}_k(t) - \omega) \rho_k(t, x).$$

Therefore, since  $F$  is a polynomial satisfying (H1), using the estimate (3.0.29) from Step 1, the fact that  $Corr_1(t, x) + Corr_2(t, x)$  is equal to (3.0.30), the estimate (3.0.24) and Lemmas 2.7, 2.8, and

2.9, we can verify the existence of a finite set of numbers  $a_l \in \mathbb{N}$ ,  $j_l \in \mathbb{Z}$  independent of  $v$ ,  $t$ ,  $x$  such that for any  $(t, x) \in \mathbb{R}^2$

(3.0.33)

$$\begin{aligned}
\Lambda(\varphi_k)(t, x) = & i\dot{v}_k(t) \left( \partial_v \phi_{\omega, k}(t, x) - \partial_v \phi_{\omega, k}(t, -x) + \sum_j f_j(t) \partial_v \text{Sym}(p_{j, k})(t, x) \right) \\
& + i\dot{v}_k(t) f_{\omega, k}(t) \partial_v \text{Sym}(\partial_\omega \phi_\omega)(t, x) \\
& + i(\dot{\zeta}_k(t) - v_k(t)) \left( \partial_\zeta \phi_{\omega, k}(t, x) - \partial_\zeta \phi_{\omega, k}(t, -x) + \sum_j f_j(t) \partial_\zeta \text{Sym}(p_{j, k})(t, x) \right) \\
& + i(\dot{\zeta}_k(t) - v_k(t)) f_{\omega, k}(t) \partial_\zeta \text{Sym}(\partial_\omega \phi_\omega)(t, x) \\
& + i(\dot{\gamma}_k(t) - \omega) \left( \partial_\gamma \phi_{\omega, k}(t, x) - \partial_\gamma \phi_{\omega, k}(t, -x) + \sum_j f_j(t) \partial_\gamma \text{Sym}(p_{j, k})(t, x) \right) \\
& + i(\dot{\gamma}_k(t) - \omega) f_{\omega, k}(t) \partial_\gamma \text{Sym}(\partial_\omega \phi_\omega)(t, x) \\
& + i\dot{f}_{\omega, k}(t) [\partial_\omega \phi_{\omega, k}(t, x) - \partial_\omega \phi_{\omega, k}(t, -x)] - f_{\omega, k}(t) [S_\omega(\partial_\omega \phi_\omega)_k(t, x) - S_\omega(\partial_\omega \phi_\omega)_k(t, -x)] \\
& - 2F'' \left( |\phi_{\omega, k}(t, x)|^2 + |\phi_{\omega, k}(t, -x)|^2 \right) [\text{Sym}(\phi_{\omega, k})(t, x)] |\phi_{\omega, k}(t, x) \phi_{\omega, k}(t, -x)| \\
& + F' \left( |\phi_{\omega, k}(t, -x)|^2 \right) \phi_{\omega, k}(t, x) - F' \left( |\phi_{\omega, k}(t, x)|^2 \right) \phi_{\omega, k}(t, -x) \\
& - \sum_{j \in K_0} f_{\text{even}, j}(t) \text{Sym} \left[ e^{i\alpha_k(t, \cdot)} \tau_{\zeta_k(t)} \Pi^\perp p_j(\cdot) \right] (x) \\
& - \sum_{j \in M_0} f_{\text{odd}, j}(t) \text{Sym} \left[ e^{i\alpha_k(t, \cdot)} \tau_{\zeta_k(t)} \Pi^\perp p_j(\cdot) \right] (x) \\
& + \sum_n f_n(v, t) f_{\omega, k}(t)^{a_n} e^{-2\sqrt{\omega} \zeta_k l_n} \text{Sym}(e^{ij_n v_k(t)(\cdot)} r_{n, k})(t, x) + O(e^{-20k\sqrt{\omega} \zeta_k}),
\end{aligned}$$

where  $l_n \in \mathbb{N} \setminus \{0\}$ , and all the sums above are finite and all the functions  $f_n$  depend only on  $v$  and  $t$  and satisfy

$$(3.0.34) \quad \max_n v^{2a_n + 2l_n} |f_n^{(j)}(v, t)| \lesssim_j v^{4+j} \left( v|t| + \ln \frac{1}{v} \right)^{c(k)} e^{-2\sqrt{\omega}|t|v},$$

for all  $t \in \mathbb{R}$  and  $v \in \mathbb{R}$  if  $v > 0$  is sufficiently small.



Furthermore, to simplify more our notation, we consider

$$\begin{aligned}
(3.0.35) \quad \text{Mod}_k(t, x) = & i\dot{v}_k \left( \partial_v \phi_{\omega, k}(t, x) - \partial_v \phi_{\omega, k}(t, -x) + \sum_j f_j(t) \partial_v \text{Sym}(p_{j, k})(t, x) \right) \\
& + i\dot{v}_k(t) f_{\omega, k}(t) \partial_v \text{Sym}(\partial_\omega \phi_\omega)(t, x) \\
& + i(\dot{\zeta}_k - v_k) \left( \partial_\zeta \phi_{\omega, k}(t, x) - \partial_\zeta \phi_{\omega, k}(t, -x) + \sum_j f_j(t) \partial_\zeta \text{Sym}(p_{j, k})(t, x) \right) \\
& + i(\dot{\zeta}_k - v_k) f_{\omega, k}(t) \partial_\zeta \text{Sym}(\partial_\omega \phi_\omega)(t, x) \\
& + i(\dot{\gamma}_k(t) - \omega) \left( \partial_\gamma \phi_{\omega, k}(t, x) - \partial_\gamma \phi_{\omega, k}(t, -x) + \sum_j f_j(t) \partial_\gamma \text{Sym}(p_{j, k})(t, x) \right) \\
& + i(\dot{\gamma}_k(t) - \omega) f_{\omega, k}(t) \partial_\gamma \text{Sym}(\partial_\omega \phi_\omega)(t, x) \\
& + i\dot{f}_{\omega, k}(t) [\partial_\omega \phi_{\omega, k}(t, x) - \partial_\omega \phi_{\omega, k}(t, -x)] \\
& - f_{\omega, k}(t) [S_\omega(\partial_\omega \phi_\omega)_k(t, x) - S_\omega(\partial_\omega \phi_\omega)_k(t, -x)],
\end{aligned}$$

for any  $(t, x) \in \mathbb{R}^2$ , and  $k \in \mathbb{N}$ .

Next, since  $F$  is a polynomial, we deduce applying Lemma 2.9 and using Remarks 1.2, 2.4 that

$$\begin{aligned}
(3.0.36) \quad -2F'' \left( |\phi_{\omega, k}(x)|^2 + |\phi_{\omega, k}(-x)|^2 \right) [\text{Sym}(\phi_{\omega, k})(t, x)] |\phi_{\omega, k}(t, x) \phi_{\omega, k}(t, -x)| \\
= -2a_{+\infty} e^{-2\sqrt{\omega}\zeta_k} \text{Sym} \left[ e^{i\alpha_k(t, \cdot)} F''(\phi_\omega(\cdot)^2) \phi_\omega(\cdot)^2 e^{-\sqrt{\omega}(\cdot)} \right] (x - \zeta_k) + O \left( e^{-4\sqrt{\omega}\zeta_k} \right),
\end{aligned}$$

where the term of order  $O \left( e^{-4\sqrt{\omega}\zeta_k} \right)$  above means a smooth function  $f(t, x)$  satisfying

$$\left\| \frac{\partial^l}{\partial t^l} f(t, x) \right\|_{H_x^s(\mathbb{R})} \lesssim_{l, s} v^l e^{-4\sqrt{\omega}\zeta_k}$$

for any  $l \in \mathbb{N}$  and  $s \geq 0$ . Indeed, from Lemma 2.9, we can also describe this function  $f(t, x)$  with more precision as a finite sum of elements of the form  $e^{-2d_m \sqrt{\omega}\zeta_k} r_m(\pm x - \zeta_k)$  such that  $r_m(\pm \cdot) \in \mathcal{S}^+$  plus a remainder function  $g(t, x)$  satisfying  $\left\| \frac{\partial^l}{\partial t^l} g(t, x) \right\|_{H^1} \lesssim_l v^{l+20k} e^{-4\sqrt{\omega}\zeta_k}$  for any  $l \in \mathbb{N}$ .

Similarly, we can verify that

$$\begin{aligned}
(3.0.37) \quad F' \left( |\phi_{\omega, k}(t, -x)|^2 \right) \phi_{\omega, k}(t, x) - F' \left( |\phi_{\omega, k}(t, x)|^2 \right) \phi_{\omega, k}(t, -x) \\
= -a_{+\infty} e^{-2\sqrt{\omega}\zeta_k(t)} \text{Sym} \left[ e^{-iv_k(\cdot)} \tau_{\zeta_k(t)} e^{i\alpha_k(t, \cdot)} F'(\phi_\omega(\cdot)^2) e^{-\sqrt{\omega}(\cdot)} \right] (x) + O \left( e^{-4\sqrt{\omega}\zeta_k} \right)
\end{aligned}$$

such that the term  $O \left( e^{-4\sqrt{\omega}\zeta_k} \right)$  also means a smooth function  $f(t, x)$  satisfying  $\left\| \frac{\partial^l}{\partial t^l} f(t, x) \right\|_{H^1} \lesssim_l v^l e^{-4\sqrt{\omega}\zeta_k}$  for any  $l \in \mathbb{N}$ . Analogously, using Lemma 2.9, we also can verify that  $f(t, x)$  can be estimated as a finite sum of functions  $e^{-2d_m \sqrt{\omega}\zeta_k} r_m(\pm x - \zeta_k(t))$  plus a remainder  $g(t, x)$  such that one of the functions  $r_m(\pm \cdot)$  is in  $\mathcal{S}^+$  and  $\left\| \frac{\partial^l}{\partial t^l} g(t, x) \right\|_{H_x^s(\mathbb{R})} \lesssim_{l, s} v^{l+20k} e^{-4\sqrt{\omega}\zeta_k}$  for any  $l \in \mathbb{N}$  and  $s \geq 0$ .

Consequently, using estimates (3.0.36) and (3.0.37), it is not difficult to verify from (3.0.33) that

$$\begin{aligned}
(3.0.38) \quad \Lambda(\varphi_k)(t, x) &= Mod_k(t, x) \\
&\quad -2a_{+\infty} e^{-2\sqrt{\omega}\zeta_k} Sym \left[ e^{i\alpha_k(t, \cdot)} \tau_{\zeta_k(t)} F''(\phi_\omega(\cdot)^2) \phi_\omega(\cdot)^2 e^{-\sqrt{\omega}(\cdot)} \right] (x) \\
&\quad -a_{+\infty} e^{-2\sqrt{\omega}\zeta_k(t)} Sym \left[ e^{-iv_k(\cdot)} e^{i\alpha_k(t, \cdot)} \tau_{\zeta_k(t)} F'(\phi_\omega(\cdot)^2) e^{-\sqrt{\omega}(\cdot)} \right] (x) \\
&\quad - \sum_{j \in K_0} f_{even, j}(t) Sym \left[ e^{i\alpha_k(t, \cdot)} \tau_{\zeta_k(t)} \Pi^\perp p_j(\cdot) \right] (x) \\
&\quad - \sum_{j \in M_0} f_{odd, j}(t) Sym \left[ e^{i\alpha_k(t, \cdot)} \tau_{\zeta_k(t)} \Pi^\perp p_j(\cdot) \right] (x) \\
&\quad + \sum_n f_n(v, t) f_{\omega, k}(t)^{a_n} e^{-2l_n \sqrt{\omega}\zeta_k} Sym(e^{ij_n v_k(t)(\cdot)} r_{n, k})(t, x) + O(e^{-20k\sqrt{\omega}\zeta_k}) \\
&= \sum_{j \in J_k} r_j(v, t) Sym(\rho_{j, k}(\cdot)) (x) + O(e^{-20k\sqrt{\omega}\zeta_k}),
\end{aligned}$$

such that the estimate (3.0.34) holds,  $J_k$  is a finite set depending only on  $k$  and all the functions  $\rho_j \left( \frac{\cdot}{\sqrt{\omega}} \right)$  are in  $\mathcal{S}_\infty^+$ , see Definition 2.5. The expression  $O(e^{-20k\sqrt{\omega}\zeta_k})$  in (3.0.38) means a smooth function  $g(t, x)$  satisfying

$$\left\| \partial_t^l g(t, x) \right\|_{H_x^s} \lesssim_{s, l} v^l e^{-20k\sqrt{\omega}\zeta_k(t)},$$

for any  $t \in \mathbb{R}$ , if  $v > 0$  is small enough.

Furthermore, since if  $\varphi_k$  satisfies the hypotheses of Theorem 3.1, using Lemmas 3.5 and 3.6, we can restrict to the case where all the functions  $r_j$  are real and

$$\begin{aligned}
(3.0.39) \quad r_j &\text{ is even on } t, \text{ if } \rho_j \text{ is a real function,} \\
r_j &\text{ is odd on } t, \text{ if } i\rho_j \text{ is a real function.}
\end{aligned}$$

**Step 3.** (Construction of parameters  $\zeta_{k_0+1}$ ,  $v_{k_0+1}$ ,  $\gamma_{k_0+1}$ ,  $f_{\omega, k_0+1}$ .) Furthermore, we are going to verify that for

$$\begin{aligned}
f_{\omega, k+1}(v, t) &= f_{\omega, k}(v, t) + \delta f_{\omega, k}(v, t), \quad v_{k+1}(v, t) = v_k(v, t) + \delta v_k(v, t), \\
\zeta_{k+1}(v, t) &= \zeta_k(v, t) + \delta \zeta_k(v, t), \quad \gamma_{k+1}(v, t) = \gamma_k(v, t) + \delta \gamma_k(v, t),
\end{aligned}$$

the functions  $\delta f_{\omega, k}$ ,  $\delta v_k$ ,  $\delta \zeta_k$ ,  $\delta \gamma_k$  shall satisfy for some  $c(k) > 0$  the following decay

$$\begin{aligned}
(3.0.40) \quad v \left| \frac{\partial^l}{\partial t^l} \delta f_{\omega, k}(v, t) \right| + v \left| \frac{\partial^l}{\partial t^l} \delta v_k(v, t) \right| + v^2 \left| \frac{\partial^l}{\partial t^l} \delta \zeta_k(v, t) \right| + v^2 \left| \frac{\partial^l}{\partial t^l} \delta \gamma_k(v, t) \right| \\
+ \left| \frac{\partial^l}{\partial t^l} (\delta \gamma_k(v, t) - f_{\omega, k}(v, t)) \right| \leq C(l) v^{2k+2+l} \left( \ln \frac{1}{v} + |t|v \right)^{c(k)} e^{-2|t|\sqrt{\omega}v},
\end{aligned}$$

for every  $l \in \mathbb{N}$ ,  $t \in \mathbb{R}$ ,  $C(l) > 0$  depending only on  $l$  and  $0 < v \ll 1$ . From Step 1, we have considered  $f_{\omega, 1}$ ,  $\zeta_{\omega, 1} = d(t) + f_\zeta(t)$ ,  $\gamma_1(t)$  and  $v_1(t)$  to be the same as the ones defined at Remark 3.8.

Moreover, considering  $f_{\omega, 0}(v, t) \equiv 0$ ,  $\gamma_0(v, t) = \omega t$ ,  $v_0(v, t) = \dot{d}(t)$ ,  $\zeta_0(v, t) = d(t)$ , we deduce from Remark 3.8 that the estimate (3.0.40) is true for  $k = 0$ . Therefore, we can assume that the existence of  $v_k$ ,  $\gamma_k$ ,  $\zeta_k$ ,  $f_{\omega, k}$  satisfying (3.0.40) until  $k = k_0 - 1 \in \mathbb{N}$ .

From now on, we consider  $f_{\omega, k_0+1}$ ,  $v_{k_0+1}$ ,  $\zeta_{k_0+1}$  and  $\gamma_{k_0+1}$  to be functions such that the estimates (3.0.40) are true for  $k = k_0$  for some  $c_{k_0} > 0$ , these functions will be chosen carefully later for the construction of  $\varphi_{k_0+1}$  satisfying Theorem 3.1.

Next, using Taylor's Expansion Theorem, we can verify for any  $l \in \mathbb{N}$  and  $v > 0$  sufficiently small the following estimate

$$(3.0.41) \quad -a_{+\infty} e^{-2\sqrt{\omega}\zeta_{k_0+1}(t)} = -a_{+\infty} e^{-2\sqrt{\omega}\zeta_{k_0}(t)} + 2a_{+\infty} \sqrt{\omega} \delta\zeta_{k_0}(t) e^{-2\sqrt{\omega}\zeta_{k_0}(t)} \\ + O\left(v^{4k_0} \left(\ln \frac{1}{v} + |t|v\right)^{2c(k_0)} e^{-4|t|\sqrt{\omega}v}\right),$$

and the term  $O\left(v^{4k_0} \left(\ln \left(\frac{1}{v}\right) + |t|v\right)^{2c(k_0)} e^{-4|t|\sqrt{\omega}v}\right)$  means a smooth function  $f(t, x)$  satisfying

$$\left\| \frac{\partial^l}{\partial t^l} f(t, x) \right\|_{H_x^s(\mathbb{R})} \lesssim_{l,s} v^{4k_0+l} \left(\ln \left(\frac{1}{v}\right) + |t|v\right)^{2c(k_0)} e^{-4|t|\sqrt{\omega}v},$$

for any  $l \in \mathbb{N}$ , if  $v > 0$  is sufficiently small. Indeed, using the estimates (3.0.40), identity  $\zeta_0(t) = d(t)$  and estimate (3.0.23), we can also obtain from (3.0.41) the existence of a new constant  $c_{k_0}$  such that

$$-a_{+\infty} e^{-2\sqrt{\omega}\zeta_{k_0+1}(t)} = -a_{+\infty} e^{-2\sqrt{\omega}\zeta_{k_0}(t)} + 2a_{+\infty} \sqrt{\omega} \delta\zeta_{k_0}(t) e^{-2\sqrt{\omega}d(t)} \\ + O\left(v^{2k_0+4} \left(\ln \frac{1}{v} + |t|v\right)^{2c(k_0)} e^{-2|t|\sqrt{\omega}v}\right).$$

From now on, using  $f_{\omega, k_0+1}$ ,  $\zeta_{k_0+1}$ ,  $v_{k_0+1}$ , we consider from (3.0.6) the following notation

$$\rho_{k_0+1}(t, x) := e^{i\left(\gamma_{k_0+1}(t) + \frac{v_{k_0+1}(t)}{2} \left[x - \frac{\zeta_{k_0+1}(t)}{2}\right]\right)} \rho(x - \zeta_{k_0+1}(t)),$$

for any real function  $\rho$  with domain  $\mathbb{R}$ .

Next, recalling the definition of  $Sym$  on (1.0.15) and using the definition of  $\varphi_k$  on (3.0.3), we consider the following function

$$(3.0.42) \quad \varphi_{k_0,0}(t, x) = \left[ e^{i\frac{v_{k_0+1}}{2} \left(x - \frac{\zeta_{k_0+1}}{2}\right) + i\gamma_{k_0+1}} \phi_\omega(x - \zeta_{k_0+1}) - e^{i\frac{v_{k_0+1}}{2} \left(-x - \frac{\zeta_{k_0+1}}{2}\right) + i\gamma_{k_0+1}} \phi_\omega(-x - \zeta_{k_0+1}) \right] \\ + f_{\omega, k_0+1}(t) Sym \left[ \tau_{\zeta_{k_0+1}} \left( e^{iv_{k_0+1} \frac{(\cdot)}{2} + i\gamma_{k_0+1}} \partial_\omega \phi_\omega(\cdot) \right) \right] (x) \\ + \sum_{j \in J} ig_{odd,j}(t) Sym [(p_{j,\omega})_{k_0+1}(t, \cdot)] (x) + \sum_{j \in I} g_{even,j}(t) Sym [(p_{j,\omega})_{k_0+1}(t, \cdot)] (x) \\ + \sum_{j \in J_{k_0}} ig_{odd,j}(t) Sym [(p_{j,\omega})_{k_0+1}(t, \cdot)] (x) + \sum_{j \in I_{k_0}} g_{even,j}(t) Sym [(p_{j,\omega})_{k_0+1}(t, \cdot)] (x)$$

Consequently, using the estimate (3.0.38) for  $\Lambda(\varphi_{k_0})$ , estimates (3.0.40) and estimate (3.0.41), we can verify for some  $c(k_0) > 0$  that

(3.0.43)

$$\begin{aligned}
\Lambda(\varphi_{k_0,0})(t, x) &= i\dot{\delta}v_{k_0}(t)Sym \left( \partial_v \phi_{\omega, k_0+1}(t, \cdot) + \sum_j f_j(t) \partial_v p_{j, k_0+1}(t, \cdot) \right) (x) \\
&+ i [\dot{\delta}\zeta_{k_0}(t) - \delta v_{k_0}(t)] Sym \left( \partial_\zeta \phi_{\omega, k_0+1}(t, \cdot) + \sum_j f_j(t) \partial_\zeta p_{j, k_0+1}(t, \cdot) \right) (x) \\
&+ i\dot{\delta}\gamma_{k_0}(t) Sym \left( \partial_\gamma \phi_{\omega, k_0+1}(t, \cdot) + \sum_j f_j(t) \partial_\gamma p_{j, k_0+1}(t, \cdot) \right) (x) \\
&+ i\dot{\delta}f_{\omega, k_0}(t) Sym (\partial_\omega \phi_{\omega, k_0+1}(t, \cdot)) (x) - \delta f_{\omega, k_0}(t) Sym (S_\omega (\partial_\omega \phi_\omega)_{k_0+1}(t, \cdot)) (x) \\
&+ 4a_{+\infty} \delta\zeta_{k_0}(t) \sqrt{\omega} e^{-2\sqrt{\omega}d(t)} Sym \left[ e^{i\alpha_{k_0+1}(t, \cdot)} \tau_{\zeta_{k_0+1}(t)} F''(\phi_\omega(\cdot)^2) \phi_\omega(\cdot)^2 e^{-\sqrt{\omega}(\cdot)} \right] (x) \\
&+ 2a_{+\infty} \delta\zeta_{k_0}(t) \sqrt{\omega} e^{-2\sqrt{\omega}d(t)} Sym \left[ e^{-iv_{k_0+1}(\cdot)} e^{i\alpha_{k_0+1}(t, \cdot)} \tau_{\zeta_{k_0+1}(t)} F'(\phi_\omega(\cdot)^2) e^{-\sqrt{\omega}(\cdot)} \right] (x) \\
&+ \sum_j r_j(v, t) Sym (\rho_{j, k_0+1}(t, \cdot)) (x) + O \left( v^{2k_0+4} \left[ |t|v + \ln \frac{1}{v} \right]^{c(k_0)} e^{-2\sqrt{\omega}|t|v} \right),
\end{aligned}$$

where the term above associated to  $O$  means a smooth function  $r(t, x)$  satisfying

$$\left\| \frac{\partial^l r(t, x)}{\partial t^l} \right\|_{H_x^s(\mathbb{R})} \lesssim_{s,l} v^{2k_0+4+l} \left[ |t|v + \ln \frac{1}{v} \right]^{c(k_0)} e^{-2\sqrt{\omega}|t|v},$$

for any  $l \in \mathbb{N}$  and  $s \geq 0$ .

Furthermore, from Lemma 3.5, we can restrict to the case where the functions  $\rho_j$  in estimate (3.0.43) satisfy  $\langle \rho_j, \rho_l \rangle = \delta_l^j$ . Consequently, using the estimate (3.0.38) with (3.0.4) for  $k = k_0$  and Lemma 2.1, we can deduce that

$$(3.0.44) \quad \max_j \left\| \frac{\partial^l}{\partial t^l} r_j(t, v) \right\| \lesssim_l v^{2k_0+2+l} \left( |t|v + \ln \left( \frac{1}{v} \right) \right)^{c(k_0)} e^{-2\sqrt{\omega}|t|v},$$

for all  $l \in \mathbb{N}$ , if  $v > 0$  is sufficiently small.

Moreover, if  $\dot{\delta}\zeta_{k_0}(t) = \delta v_{k_0}(t)$ , using estimates (3.0.23), (3.0.40), (3.0.43) and (3.0.44), we can verify the existence of a constant  $c(k_0) > 0$  satisfying

$$(3.0.45) \quad \left\| \frac{\partial^l}{\partial t^l} \Lambda(\varphi_{k_0,0})(t, x) \right\|_{H_x^s(\mathbb{R})} \lesssim_s v^{2k_0+2+l} \left[ |t|v + \ln \left( \frac{1}{v} \right) \right]^{c(k_0)} e^{-2\sqrt{\omega}|t|v},$$

for all  $l \in \mathbb{N}$ .

**Step 4.** (Ordinary differential equations for  $\delta\zeta_{k_0}, \delta v_{k_0}, \delta\gamma_{k_0}, \delta f_{\omega, k_0}$ .)

Similar to the reasoning used in Theorem 4.1 from [23], using (3.0.43), we are going to obtain a

system of ordinary differential equations for the parameters  $\delta\zeta_{k_0}$ ,  $\delta v_{k_0}$ ,  $\delta\gamma_{k_0}$ ,  $\delta f_{\omega, k_0}$  such that

$$(3.0.46) \quad \left| \frac{\partial^l}{\partial t^l} \left\langle \Lambda(\varphi_{k_0,0})(t, x), \left( \phi' \right)_{k_0+1}(t, x) \right\rangle \right| = O \left( v^{2k_0+4+l} \left( |t|v + \ln \left( \frac{1}{v} \right) \right)^{c(k_0)} e^{-2\sqrt{\omega}|t|v} \right),$$

$$(3.0.47) \quad \left| \frac{\partial^l}{\partial t^l} \left\langle \Lambda(\varphi_{k_0,0})(t, x), \partial_{\gamma_{k_0+1}} \phi_{k_0+1}(t, x) \right\rangle \right| = O \left( v^{2k_0+4+l} \left( |t|v + \ln \left( \frac{1}{v} \right) \right)^{c(k_0)} e^{-2\sqrt{\omega}|t|v} \right),$$

(3.0.48)

$$\left| \frac{\partial^l}{\partial t^l} \left\langle \Lambda(\varphi_{k_0,0})(t, x), i(x - \zeta_{k_0+1}(t)) \phi_{k_0+1}(t, x) \right\rangle \right| = O \left( v^{2k_0+4+l} \left( |t|v + \ln \left( \frac{1}{v} \right) \right)^{c(k_0)} e^{-2\sqrt{\omega}|t|v} \right),$$

$$(3.0.49) \quad \left| \frac{\partial^l}{\partial t^l} \left\langle \Lambda(\varphi_{k_0,0})(t, x), \partial_{\omega} \phi_{k_0+1}(t, x) \right\rangle \right| = O \left( v^{2k_0+4+l} \left( |t|v + \ln \left( \frac{1}{v} \right) \right)^{c(k_0)} e^{-2\sqrt{\omega}|t|v} \right),$$

for any  $l \in \mathbb{N}$ .

First, using Lemma 2.1 and estimates (3.0.40), we obtain from the estimate (3.0.43) that estimate (3.0.46) is equivalent to

$$\begin{aligned} \frac{\dot{\delta}v_{k_0}(t)}{4} \|\phi_{\omega}\|_{L^2}^2 &= -2a_{+\infty} \omega \delta\zeta_{k_0}(t) \left[ \int_{\mathbb{R}} F'(\phi_{\omega}(x)^2) \phi_{\omega}(x) e^{-\sqrt{\omega}x} dx \right] e^{-2\sqrt{\omega}d(t)} \\ &\quad - \sum_j r_j(v, t) \left\langle \rho_j(x), \phi'_{\omega}(x) \right\rangle + O \left( v^{2k_0+4} \left( |t|v + \ln \left( \frac{1}{v} \right) \right)^{c(k_0)} e^{-2\sqrt{\omega}|t|v} \right), \end{aligned}$$

and using  $C > 0$  defined in (3.0.21), this is equivalent to

$$(3.0.50) \quad \begin{aligned} \frac{\dot{\delta}v_{k_0}(t)}{4} \|\phi_{\omega}\|_{L^2}^2 &= -\frac{C\sqrt{\omega} \|\phi_{\omega}\|_{L^2}^2}{2} \delta\zeta_{k_0}(t) e^{-2\sqrt{\omega}d(t)} - \sum_j r_j(v, t) \left\langle \rho_j, \phi'_{\omega} \right\rangle \\ &\quad + O \left( v^{2k_0+4} \left( |t|v + \ln \left( \frac{1}{v} \right) \right)^{c(k_0)} e^{-2\sqrt{\omega}|t|v} \right). \end{aligned}$$

Next, we consider

$$(3.0.51) \quad \begin{aligned} \delta\zeta_{k_0}(t) &:= \delta\zeta_{k_0,0}(t) + f_{\zeta_{k_0}}(t) - \frac{2}{\|\phi_{\omega}\|_{L^2}^2} \sum_j \int_{-\infty}^t r_j(v, s) \langle \rho_j(x), ix\phi_{\omega}(x) \rangle ds \\ &= \delta\zeta_{k_0,0}(t) + f_{\zeta_{k_0}}(t) + R(t), \end{aligned}$$

such that we are going to define  $\delta\zeta_{k_0,0}$ , and  $f_{\zeta_{k_0}}(t)$  in the next paragraphs. We observe from (3.0.39), (3.0.44) and the inductive hypothesis on  $k_0$  that there exists  $\sigma > 0$  satisfying

$$\left| \frac{d^l}{dt^l} R(t) \right| = O \left( v^{2k_0+1+l} \left( |t|v + \ln \frac{1}{v} \right)^{\sigma} e^{-2\sqrt{\omega}|t|v} \right), \text{ for any } l \in \mathbb{N}.$$

Next, we define  $\delta\zeta_{k_0,0}$  as the unique solution of

$$(3.0.52) \quad \begin{aligned} \frac{\ddot{\delta}\zeta_{k_0,0}(t)}{4} \|\phi_{\omega}\|_{L^2}^2 &= -\frac{C\sqrt{\omega} \|\phi_{\omega}\|_{L^2}^2}{2} \delta\zeta_{k_0,0}(t) e^{-2\sqrt{\omega}d(t)} - \frac{C\sqrt{\omega} \|\phi_{\omega}\|_{L^2}^2}{2} R(t) e^{-2\sqrt{\omega}d(t)} \\ &\quad - \sum_j r_j(v, t) \left\langle \rho_j(x), \phi'_{\omega}(x) \right\rangle, \\ \delta\zeta_{k_0,0}(t) &= 0, \quad \lim_{t \rightarrow +\infty} \delta\zeta_{k_0,0}(t) = 0, \end{aligned}$$

and  $f_{\zeta_{k_0}}$  an even function to be chosen later satisfying

$$(3.0.53) \quad \left| \frac{d^l}{dt^l} f_{\zeta_0}(t) \right| = O \left( v^{2k_0+2+l} \left( |t|v + \ln \frac{1}{v} \right)^{\sigma} e^{-2\sqrt{\omega}|t|v} \right),$$

for some constant  $\sigma > 0$  and any  $l \in \mathbb{N}$ . In particular  $\delta\zeta_{k_0,0}$ , is an even function because of (3.0.39), and for any  $l \in \mathbb{N}$

$$(3.0.54) \quad \left| \frac{d^l}{dt^l} \delta\zeta_{k_0,0}(t) \right| = O \left( v^{2k_0+l} \left( |t|v + \ln \frac{1}{v} \right)^{c(k_0)} e^{-2\sqrt{\omega}|t|v} \right),$$

because of the variation of the parameters method and estimate (3.0.44).

Consequently, choosing  $\delta v_{k_0} = \delta\zeta_{k_0,0}$ , we deduce from the properties of  $\delta\zeta_{k_0,0}$  and estimate (3.0.50) that (3.0.46) holds and that  $\delta v_{k_0}$  is an odd function.

Furthermore, using the identity (3.0.51), estimates (3.0.43), (3.0.54) and Lemma 2.1, we can verify that both estimates (3.0.48) and (3.0.53) would be true if  $f_{\zeta_{k_0}}(t)$  is the unique solution of

$$(3.0.55) \quad \frac{\dot{f}_{\zeta_{k_0}}(t)}{2} \|\phi_\omega\|_{L^2}^2 = 2a_{+\infty} \delta\zeta_{k_0,0} \sqrt{\omega} e^{-2\sqrt{\omega}d(t)} \dot{d}(t) \left\langle (x+d(t))F'(\phi_\omega(x)^2)e^{-\sqrt{\omega}x}, x\phi_\omega(x) \right\rangle,$$

satisfying  $\lim_{t \rightarrow +\infty} f_{\zeta_{k_0}}(t) = 0$ , which is an even function satisfying (3.0.51). The equation (3.0.55) comes from the asymptotic estimate of (3.0.48) using the decays of  $\delta\zeta_{k_0,0}, f_{\zeta_{k_0}}$ .

Moreover, using formula (3.0.6) for  $\phi_\omega$ , we can verify that

$$\partial_v \phi_{\omega,k}(t, x) = \frac{i}{2} (x - \zeta_k(t)) \phi_{\omega,k}(t, x) + i \frac{\zeta_k(t)}{4} \phi_{\omega,k}(t, x),$$

we also observe that  $\phi_\omega$  and  $\partial_\omega \phi_\omega$  are even functions, and  $x\phi_\omega(x)$  is an odd function. Consequently, using estimates (3.0.42) and (3.0.40), we can verify that the estimate (3.0.49) is true only if

$$\begin{aligned} & \left( \dot{\delta}\gamma_{k_0}(t) + \frac{d(t)}{4} \dot{\delta}v_{k_0}(t) - \delta f_{\omega,k_0}(t) \right) \frac{d}{d\omega} \left[ \int_{\mathbb{R}} \frac{\phi_\omega(x)^2}{2} dx \right] \\ &= 2a_{+\infty} \delta\zeta_{k_0}(t) \sqrt{\omega} e^{-2\sqrt{\omega}d(t)} \left\langle F'(\phi_\omega(x)^2) e^{-\sqrt{\omega}x}, \partial_\omega \phi_\omega(x) \right\rangle \\ &+ 4a_{+\infty} \delta\zeta_{k_0}(t) \sqrt{\omega} e^{-2\sqrt{\omega}d(t)} \left\langle F''(\phi_\omega(x)^2) \phi_\omega(x)^2 e^{-\sqrt{\omega}x}, \partial_\omega \phi_\omega(x) \right\rangle \\ &+ \sum_j r_j(v, t) \langle \rho_j, \partial_\omega \phi_\omega \rangle \\ &+ O \left( v^{2k_0+4+l} \left( |t|v + \ln \left( \frac{1}{v} \right) \right)^{c(k_0)} e^{-2\sqrt{\omega}|t|v} \right). \end{aligned}$$

Consequently, since  $\delta v_{k_0} = \delta\zeta_{k_0,0}$ , we can verify from the ordinary equation satisfied by  $\delta\zeta_{k_0,0}$  that there exist real values  $C_{2,\omega}, C_{3,\omega}, C_{4,\omega}, C_{5,\omega}$  depending only on  $\omega$  such that (3.0.49) is true when  $\delta\gamma_{k_0}$  is the unique solution of

$$(3.0.56) \quad \begin{aligned} \dot{\delta}\gamma_{k_0}(t) &= \delta f_{\omega,k_0}(t) + C_{2,\omega} \delta\zeta_{k_0}(t) e^{-2\sqrt{\omega}d(t)} + C_{3,\omega} \frac{d(t)}{4} \delta\zeta_{k_0}(t) e^{-2\sqrt{\omega}d(t)} \\ &+ C_{4,\omega} \sum_j r_j(v, t) \langle \rho_j, \partial_\omega \phi_\omega \rangle + C_{5,\omega} \frac{d(t)}{4} \sum_j r_j(v, t) \langle \rho_j, \phi'_\omega \rangle, \\ \delta\gamma_{k_0}(0) &= 0, \end{aligned}$$

and when the estimates (3.0.40) hold.

Next, it remains to find the appropriate ordinary differential estimate that will imply estimate (3.0.47). We also observe that  $\partial_\gamma \phi_{\omega,k_0}(t, x) = i\gamma_0 \phi_{\omega,k_0}(t, x)$ ,  $\langle \phi'_\omega, \phi_\omega \rangle = 0$ , and the real part of  $\partial_{v_{k_0}} \phi_{\omega,k_0}(t, x)$  is zero. Consequently, using Lemmas 2.1, and estimates (3.0.40), we deduce that

(3.0.47) is true if

(3.0.57)

$$\begin{aligned} \dot{\delta}f_{\omega,k_0}(t) \langle \partial_\omega \phi_\omega, \phi_\omega \rangle &= -2a_{+\infty} \delta\zeta_{k_0}(t) \sqrt{\omega} e^{-2\sqrt{\omega}d(t)} \dot{d}(t) \left\langle (x+d(t))F'(\phi_\omega(x)^2)e^{-\sqrt{\omega}x}, \phi_\omega(x) \right\rangle \\ &\quad - \sum_j r_j(v,t) \langle \rho_j(x), i\phi_\omega(x) \rangle, \\ \lim_{t \rightarrow +\infty} \delta f_{\omega,k_0}(t) &= 0, \end{aligned}$$

because of the Fundamental Theorem of Calculus and the fact that  $\delta\zeta_{k_0}$  defined at (3.0.52) satisfies (3.0.40), the function  $\delta\zeta_{k_0}$  is also even because of the equation above.

Consequently, using (3.0.56) and the fact that  $f_{\omega,k_0}$  satisfies (3.0.40), we deduce that  $\delta\gamma_{k_0}$  satisfies all decays in (3.0.40) and it is an odd function. In conclusion, all the functions  $\delta\zeta_{k_0}$ ,  $\delta v_{k_0}$ ,  $\delta\gamma_{k_0}$  and  $\delta f_{\omega,k_0}$  constructed in this Step satisfy (3.0.40).

**Step 5.**(Construction of  $\varphi_{k+1}$  and conclusion.)

First, we recall that the function  $\varphi_{k_0,0}$  defined in (3.0.42) satisfies estimate (3.0.45) and the hypotheses of Lemma 3.6 for  $k = k_0$ .

Therefore, using Lemma 3.6, we can find a natural number  $n_0 \geq 0$  and real functions  $Q_j, P_j, f_{even,j}, f_{odd,j}$  such that all functions  $g_{even,j}$  are even, all functions  $g_{odd,j}$  are odd, and

$$(3.0.58) \quad \begin{aligned} \Lambda(\varphi_{k_0,0})(t,x) &= \sum_{j=1}^{M_{k_0}} i f_{odd,j}(v,t) \text{sym}((Q_j)_{k_0})(t,x) + \sum_{j=1}^{N_{k_0}} f_{even,j}(v,t) \text{sym}((P_j)_{k_0})(t,x) \\ &\quad + O\left(v^{2k_0} \left(|t|v + \ln \frac{1}{v}\right)^{n_0} e^{-2\sqrt{\omega}|t|v}\right), \end{aligned}$$

all the functions  $P_j\left(\frac{\cdot}{\sqrt{\omega}}\right), Q_j\left(\frac{\cdot}{\sqrt{\omega}}\right)$  are in  $\mathcal{S}_\infty^+$ , and the term  $O(v^{2k_0})$  in the equation means a smooth function  $r(t,x)$  satisfying

$$\left\| \frac{\partial^l r(t,x)}{\partial t^l} \right\|_{H_x^s(\mathbb{R})} \lesssim_{l,s} v^{2k_0+l} \left(|t|v + \ln \frac{1}{v}\right)^{n_0} e^{-2\sqrt{\omega}|t|v}.$$

Moreover, using the decay estimate (3.0.45), we can restrict to the case where all the functions  $f_{odd,j}$  and  $f_{even,j}$  satisfy

$$(3.0.59) \quad \left| \frac{\partial^l f_{even,j}(v,t)}{\partial t^l} \right| + \left| \frac{\partial^l f_{odd,j}(v,t)}{\partial t^l} \right| \lesssim_l v^{2k_0+2+l} \left[|t|v + \ln \left(\frac{1}{v}\right)\right]^{c(k_0)} e^{-2\sqrt{\omega}|t|v}.$$

Furthermore, using estimates (3.0.46), (3.0.47), (3.0.48) and (3.0.49) in Step 4, we can deduce from (3.0.58) using Lemma 2.1 that

$$(3.0.60) \quad \left\| \frac{\partial^l}{\partial t^l} \left[ \sum_{j=1}^{M_k} f_{odd,j}(v,t) \Pi(iQ_j)(x) + \sum_{j=1}^{N_k} f_{even,j}(v,t) \Pi(P_j)(x) \right] \right\|_{H_x^s(\mathbb{R})} \lesssim_s v^{2k_0+4+l} \left[|t|v + \ln \left(\frac{1}{v}\right)\right]^{c_1(k_0)} e^{-2\sqrt{\omega}|t|v},$$

for all  $l \in \mathbb{N}$  and  $c_1(k_0) > 0$  is a constant depending only on  $k_0$ .

Next, using Lemma 2.15, we can consider the following functions of correction

$$\begin{aligned} Cor_1(t, x) &:= S_\omega^{-1} \left[ \sum_{j=1}^{M_k} f_{odd,j}(v, t) \Pi^\perp(iQ_j)(x) + \sum_{j=1}^{N_k} f_{even,j}(v, t) \Pi^\perp(P_j)(x) \right], \\ Cor_2(t, x) &:= S_\omega^{-1} \left[ i S_\omega^{-1} \left[ \sum_{j=1}^{M_k} \partial_t f_{odd,j}(v, t) \Pi^\perp(iQ_j)(x) + \sum_{j=1}^{N_k} \partial_t f_{even,j}(v, t) \Pi^\perp(P_j)(x) \right] \right] \end{aligned}$$

whose main motivation is to remove the expressions in the sums on the left-hand side of (3.0.58), this approach was made similarly in Step 1 for  $k = 1$ . Based on this observation, we consider the following function

$$(3.0.61) \quad \varphi_{k_0+1}(t, x) := \varphi_{k_0,0}(t, x) + Sym \left[ \tau_{\zeta_{k_0+1}} e^{i\alpha_{k_0+1}(t, \cdot)} (Cor_1(t, \cdot) + Cor_2(t, \cdot)) \right](x),$$

which is a function of the same form as the right-hand side of the equation (3.0.3).

In conclusion, similarly to the approach made in Step 1, we can verify using Lemmas 2.1, 2.14, Remark 2.19 and Taylor's Expansion Theorem that the function (3.0.61) satisfies Theorem 3.1 for  $k = k_0 + 1$ .  $\square$

#### 4. ENERGY ESTIMATE

**4.1. Dynamics of the Modulation Parameters.** First, to simplify our ansatz, we recall the notation (3.0.6)

$$\rho_k(t, x) := e^{i\left(\gamma_k(t) + \frac{v_k(t)}{2} \left[ x - \frac{\zeta_k(t)}{2} \right] \right)} \rho(x - \zeta_k(t)).$$

In notation of Theorem 3.1, we recall the function  $\alpha_k$  denoted in (3.0.31) which is given by

$$\alpha_k(t, x) = \alpha(t, x, (\zeta_k, v_k, \gamma_k, f_{\omega, k})) := \gamma_k(t) + \frac{v_k(t)}{2} \left( x - \frac{\zeta_k(t)}{2} \right).$$

From now on, to simplify the notation used in the proof, we consider the following

$$(4.1.1) \quad \varphi_{\gamma, k}(t, x) = i e^{i\alpha_k(t, x, \sigma_u(t))} \phi_\omega(x - (\zeta_k + p_\zeta)),$$

$$(4.1.2) \quad \varphi_{\zeta, k}(t, x) = e^{i\alpha_k(t, x, \sigma_u(t))} \phi'_\omega(x - (\zeta_k + p_\zeta)),$$

$$(4.1.3) \quad \varphi_{\omega, k}(t, x) = e^{i\alpha_k(t, x, \sigma_u(t))} \partial_\omega \phi_\omega(x - (\zeta_k + p_\zeta)),$$

$$(4.1.4) \quad \varphi_{v, k}(t, x) = \frac{i}{2} e^{i\alpha_k(t, x, \sigma_u(t))} (x - (\zeta_k + p_\zeta)) \phi_\omega(x - (\zeta_k + p_\zeta)).$$

Moreover, using that  $\phi_\omega$  is an even smooth function and the dot product defined in (1.0.17), it is not difficult to verify that

$$(4.1.5) \quad \langle \varphi_{j, k}, \varphi_{l, k} \rangle = \delta_l^j,$$

for any  $j \neq l \in \{\zeta, v, \gamma, \omega\}$ .

Furthermore, using the Implicit Function Theorem for Banach Spaces and the identities (4.1.1), (4.1.2), (4.1.3), (4.1.4), we can verify the following proposition.

**Lemma 4.1** (Modulation Lemma). *Let  $\varphi_k(t, x)$  be the same as in Theorem 3.1. There are constants  $K, c > 0$  and a number  $\delta_k \in (0, 1)$  such that if  $0 < v < \delta_k$  and  $u(t, x)$  is an odd function on  $x$  in  $C([-T, T], H_x^1(\mathbb{R}))$  for any  $T \in \left[ 0, \frac{(\ln \frac{1}{v})^{\frac{4}{3}}}{v} \right]$  satisfying*

$$(4.1.6) \quad \|u(t) - \varphi_k(t)\|_{L^\infty([-T, T], H_x^1(\mathbb{R}))} < v^2,$$

then there exist continuous functions  $p_\zeta, p_v, p_\gamma, p_\omega$  such that for

$$\sigma_u(t) = \sigma_k(t) + (p_\zeta, p_v, p_\gamma, p_\omega),$$



the function  $P_k(t, x, \sigma_u(t))$  satisfies for any  $t \in [-T, T]$

$$(4.1.7) \quad \langle u(t, x) - P_k(t, x, \sigma_u(t)), i\varphi_{\gamma, k}(t, \pm x) \rangle = 0,$$

$$(4.1.8) \quad \langle u(t, x) - P_k(t, x, \sigma_u(t)), i\varphi_{\zeta, k}(t, \pm x) \rangle = 0,$$

$$(4.1.9) \quad \langle u(t, x) - P_k(t, x, \sigma_u(t)), i\varphi_{\omega, k}(t, \pm x) \rangle = 0,$$

$$(4.1.10) \quad \langle u(t, x) - P_k(t, x, \sigma_u(t)), i\varphi_{v, k}(t, \pm x) \rangle = 0,$$

and

$$\begin{aligned} |p_{\zeta}(t)| + |p_v(t)| + |p_{\omega}(t)| + |p_{\gamma}(t)| &\leq K \left( \ln \frac{1}{v} \right)^c \|u(t) - P_k(t, x, \sigma_u)\|_{H_x^1(\mathbb{R})}, \\ \|u(t) - P_k(t, x, \sigma_u(t))\|_{H_x^1(\mathbb{R})} &\leq K \left( \ln \frac{1}{v} \right)^c \|u(t) - \varphi_k(t, x)\|_{H_x^1(\mathbb{R})}. \end{aligned}$$

*Proof of Lemma 4.1.* The proof is completely analogous to the proof of Lemma 8.1 from [5], see also [36].  $\square$

**Remark 4.2.** The terms with  $(\ln \frac{1}{v})^{\frac{4}{3}}$  in the right-hand side of the inequalities of Lemma 4.1 are obtained using the identity

$$\partial_{p_v} P_k(t, x, \sigma_u) = \frac{1}{2} \varphi_{v, k}(t, x) + i \frac{\zeta_k + p_{\zeta}}{4} P_k(t, x, \sigma_u(t)),$$

with (3.3) and from the fact that

$$|P_k(t, x, \sigma_k(t)) - P_k(t, x, \sigma_u)| = DP_k(t, x, \sigma_k(t))(p_{\zeta}, p_v, p_{\gamma}, p_{\omega}) + O\left(\left(\ln \frac{1}{v}\right)^{\sigma} \max_{j \in \{\zeta, v, \gamma, \omega\}} |P_j(t, r)|^2\right).$$

In the notation of Lemma 4.1, we consider from now on the following representation for a solution  $u(t, x)$  of (1.0.1)

$$(4.1.11) \quad u(t, x) = P_k(t, x, \sigma_u(t)) + r(t, x) e^{i(\gamma_k + p_{\gamma})},$$

such that  $\sigma_u(t)$  and the function  $r$  satisfy all the properties of Lemma 4.1. Since  $u$  is a strong solution of (1.0.1), we can verify the following lemma.

Furthermore, using the formula (4.1.11) for the solution  $u(t, x)$  of the nonlinear Schrödinger equation and Taylor's Expansion Theorem, we can verify from Taylor's Expansion Theorem, Lemma 2.1 and estimates (3.0.5) of Theorem 3.1 that

$$\begin{aligned} (4.1.12) \quad & [i\partial_t r(t, x) + \partial_x^2 r(t, x) - \omega r(t, x)] e^{i(\gamma_k(t) + p_{\gamma}(t))} \\ &= -F'(\phi_{\omega}(x - (\zeta_k + p_{\zeta}))^2 + \phi_{\omega}(x + (\zeta_k + p_{\zeta}))^2) r(t, x) e^{i(\gamma_k(t) + p_{\gamma})} \\ &\quad - F''(\phi_{\omega}(x - (\zeta_k + p_{\zeta}))^2) \phi_{\omega}(x - (\zeta_k + p_{\zeta}))^2 r(t, x) e^{i(\gamma_k(t) + p_{\gamma})} \\ &\quad - F''(\phi_{\omega}(x + (\zeta_k + p_{\zeta}))^2) \phi_{\omega}(x + (\zeta_k + p_{\zeta}))^2 r(t, x) e^{i(\gamma_k(t) + p_{\gamma})} \\ &\quad - F''(\phi_{\omega}(x - (\zeta_k + p_{\zeta}))^2) \phi_{\omega}(x - (\zeta_k + p_{\zeta}))^2 \overline{r(t, x)} e^{2i\alpha(t, x, \sigma_u) - i(\gamma_k(t) + p_{\gamma}(t))} \\ &\quad - F''(\phi_{\omega}(x + (\zeta_k + p_{\zeta}))^2) \phi_{\omega}(x + (\zeta_k + p_{\zeta}))^2 \overline{r(t, x)} e^{2i\alpha(t, -x, \sigma_u) - i(\gamma_k(t) + p_{\gamma}(t))} \\ &\quad - \Lambda(P_k)(t, x, \sigma_u) + O\left(\|r(t)\|_{H_x^1(\mathbb{R})}^2 + \|r(t)\|_{H_x^1(\mathbb{R})} v^2 \left(\ln \frac{1}{v}\right)^c + \|r(t)\|_{H_x^1(\mathbb{R})} |\dot{p}_{\gamma}(t)|\right), \end{aligned}$$

for some constant  $c > 0$  not depending on  $k$ . Moreover, from estimates (3.0.36), (3.0.37) and Lemmas 3.5, 4.1, and Theorem 3.1, we can verify using Taylor's Expansion Theorem that

$$\begin{aligned}
(4.1.13) \quad \Lambda(P_k)(t, x, \sigma_u) &= \text{Mod}_{k,0}(t, x) \\
&+ 4a_{+\infty} p_\zeta(t) \sqrt{\omega} e^{-2\sqrt{\omega}d(t)} \text{Sym} \left[ e^{i\alpha(t, \cdot, \sigma_u(t))} \tau_{\zeta_k(t)+p_\zeta(t)} F''(\phi_\omega(\cdot)^2) \phi_\omega(\cdot)^2 e^{-\sqrt{\omega}(\cdot)} \right] (x) \\
&+ 2a_{+\infty} p_\zeta(t) \sqrt{\omega} e^{-2\sqrt{\omega}d(t)} \text{Sym} \left[ e^{-i(v_k+p_v)(\cdot)} e^{i\alpha(t, \cdot, \sigma_u)} \tau_{\zeta_k(t)+p_\zeta(t)} F'(\phi_\omega(\cdot)^2) e^{-\sqrt{\omega}(\cdot)} \right] (x) \\
&+ \sum_{j \in J_k} r_j(v, t) \text{Sym} \left( e^{\alpha(t, \cdot, \sigma_u(t))} \tau_{\zeta_k(t)+p_\zeta(t)} \rho_j(\cdot) \right) (x) \\
&+ O \left( e^{-20k\sqrt{\omega}\zeta_k} + \|r(t)\|_{H^1} v^2 \left( \ln \frac{1}{v} \right)^c \right),
\end{aligned}$$

such that all functions  $\rho_j$  are in  $\mathcal{S}_\infty^+$ , all functions  $r_j$  satisfy

$$(4.1.14) \quad \left| \frac{\partial^l}{\partial t^l} r_j(v, t) \right| \lesssim_l v^{2k+2+l} \left( |t|v + \ln \frac{1}{v} \right)^{c(k)} e^{-2\sqrt{\omega}|t|v},$$

for all  $l \in \mathbb{N}$ , and  $\text{Mod}_{k,0}(t, x)$  is given by

$$\begin{aligned}
(4.1.15) \quad \text{Mod}_{k,0}(t, x) &= i\dot{p}_v(t) \partial_v P_k(t, x, \sigma_u) + i(\dot{p}_\zeta(t) - p_v(t)) \partial_\zeta P_k(t, x, \sigma_u) \\
&+ i\dot{p}_\gamma(t) \partial_\gamma P_k(t, x, \sigma_u) + i\dot{p}_\omega(t) \text{Sym} \left( e^{i\alpha(t, \cdot, \sigma_u)} \tau_{\zeta_k+p_\zeta} \partial_\omega \phi_\omega(t, \cdot) \right) (x) \\
&- p_\omega(t) \text{Sym} \left( e^{i\alpha(t, \cdot, \sigma_u)} \tau_{\zeta_k(t)+p_\zeta(t)} S_\omega(\partial_\omega \phi_\omega(\cdot)) \right).
\end{aligned}$$

Moreover, to simplify our notation, we consider the following self-adjoint operator on the Hilbert Space  $L^2(\mathbb{R}, \mathbb{C})$  for the dot product (1.0.17)

$$\begin{aligned}
(4.1.16) \quad \mathcal{L}(\rho)(t, x) &= -\partial_x^2 \rho(t, x) + \omega \rho(t, x) \\
&- \left[ F'(\phi_\omega(x - (\zeta_k + p_\zeta))^2) + F'(\phi_\omega(x + (\zeta_k + p_\zeta))^2) \right] \rho(t, x) \\
&- F''(\phi_\omega(x - (\zeta_k + p_\zeta))^2) \phi_\omega(x - (\zeta_k + p_\zeta))^2 \rho(t, x) \\
&- F''(\phi_\omega(x + (\zeta_k + p_\zeta))^2) \phi_\omega(x + (\zeta_k + p_\zeta))^2 \rho(t, x) \\
&- F''(\phi_\omega(x - (\zeta_k + p_\zeta))^2) \phi_\omega(x - (\zeta_k + p_\zeta))^2 \overline{\rho(t, x)} e^{2i\alpha(t, x, \sigma_u)} \\
&- F''(\phi_\omega(x + (\zeta_k + p_\zeta))^2) \phi_\omega(x + (\zeta_k + p_\zeta))^2 \overline{\rho(t, x)} e^{2i\alpha(t, -x, \sigma_u)}.
\end{aligned}$$

Consequently, we have the following estimate

$$\begin{aligned}
(4.1.17) \quad &ie^{i(\gamma_k+p_\gamma)} \partial_t r(t, x) - \mathcal{L} \left( e^{i(\gamma_k+p_\gamma)} r(t, x) \right) \\
&= -\text{Mod}_{k,0}(t, x) \\
&- 4a_{+\infty} p_\zeta(t) \sqrt{\omega} e^{-2\sqrt{\omega}d(t)} \text{Sym} \left[ e^{i\alpha(t, \cdot, \sigma_u(t))} \tau_{\zeta_k(t)+p_\zeta(t)} F''(\phi_\omega(\cdot)^2) \phi_\omega(\cdot)^2 e^{-\sqrt{\omega}(\cdot)} \right] (x) \\
&- 2a_{+\infty} p_\zeta(t) \sqrt{\omega} e^{-2\sqrt{\omega}d(t)} \text{Sym} \left[ e^{-i(v_k+p_v)(\cdot)} e^{i\alpha(t, \cdot, \sigma_u)} \tau_{\zeta_k(t)+p_\zeta(t)} F'(\phi_\omega(\cdot)^2) e^{-\sqrt{\omega}(\cdot)} \right] (x) \\
&+ O \left( \|r(t)\|_{H_x^1(\mathbb{R})}^2 + \|r(t)\|_{H_x^1(\mathbb{R})} v^2 \left( \ln \frac{1}{v} \right)^c + \|r(t)\|_{H_x^1(\mathbb{R})} |\dot{p}_\gamma(t)| + v^{2k+2} \left( |t|v + \ln \frac{1}{v} \right)^{c(k)} e^{-2\sqrt{\omega}v|t|} \right).
\end{aligned}$$

Therefore, from Taylor's Expansion Theorem and Lemma 2.16, we deduce using identities (2.0.16), (4.1.15) that  $ie^{i(\gamma_k+p_\gamma)}\partial_t r(t, x) - \mathcal{L}(e^{i(\gamma_k+p_\gamma)}r(t, x))$  is equal to

$$(4.1.18) \quad \begin{aligned} & - \left( i\dot{p}_\gamma(t) + \frac{\zeta_k(t)}{4}i\dot{p}_v(t) \right) \text{Sym}(\varphi_{\gamma,k}(t, \cdot))(x) - i\dot{p}_v(t)\text{Sym}(\varphi_{v,k}(t, \cdot))(x) \\ & + i(\dot{p}_\zeta(t) - p_v(t))(\varphi_{\zeta,k}(t, \cdot))(x) - i\dot{p}_\omega(t)\text{Sym}(\varphi_{\omega,k}(t, \cdot))(x) + ip_\omega(t)\text{Sym}(\varphi_{\gamma,k}(t, \cdot))(x) \\ & - 4a_{+\infty}p_\zeta(t)\sqrt{\omega}e^{-2\sqrt{\omega}d(t)}\text{Sym}\left[e^{i\alpha(t, \cdot, \sigma_u(t))}\tau_{\zeta_k(t)+p_\zeta(t)}\left[F''(\phi_\omega(\cdot)^2)\phi_\omega(\cdot)^2e^{-\sqrt{\omega}(\cdot)}\right]\right](x) \\ & - 2a_{+\infty}p_\zeta(t)\sqrt{\omega}e^{-2\sqrt{\omega}d(t)}\text{Sym}\left[e^{i\alpha(t, \cdot, \sigma_u)}\tau_{\zeta_k(t)+p_\zeta(t)}\left[F'(\phi_\omega(\cdot)^2)e^{-\sqrt{\omega}(\cdot)}\right]\right](x) \\ & + 2a_{+\infty}p_\zeta(t)\sqrt{\omega}e^{-2\sqrt{\omega}d(t)}\text{Sym}\left[e^{i\alpha(t, \cdot, \sigma_u)}\tau_{\zeta_k(t)+p_\zeta(t)}\left[(i(v_k + p_v)(\cdot))F'(\phi_\omega(\cdot)^2)e^{-\sqrt{\omega}(\cdot)}\right]\right](x) \\ & + 2a_{+\infty}p_\zeta(t)\sqrt{\omega}e^{-2\sqrt{\omega}d(t)}v_k(t)\zeta_k(t)\text{Sym}\left[e^{i\alpha(t, \cdot, \sigma_u)}\tau_{\zeta_k(t)+p_\zeta(t)}\left[iF'(\phi_\omega(\cdot)^2)e^{-\sqrt{\omega}(\cdot)}\right]\right](x) \\ & + O\left(\|r(t)\|_{H_x^1(\mathbb{R})}^2 + \|r(t)\|_{H_x^1(\mathbb{R})}v^2\left(\ln\frac{1}{v}\right)^c + \|r(t)\|_{H_x^1(\mathbb{R})}|\dot{p}_\gamma(t)| + v^{2k+2}\left(|t|v + \ln\frac{1}{v}\right)^{c(k)}e^{-2\sqrt{\omega}v|t|}\right). \end{aligned}$$

Next, we are going to use the expression (4.1.17) and Lemma 4.1 to obtain high precision in the estimates of the derivatives of the modulation parameters  $p_\zeta$ ,  $p_v$ ,  $p_\gamma$  and  $p_\omega$ .

**Lemma 4.3.** *Let  $u, v \in (0, 1)$  and  $p_\zeta, p_v, p_\gamma, p_\omega, T$  be the same as in the statement of Lemma 4.1, and  $r$  be the unique function satisfying (4.1.11). There exist a positive constants  $K, c_0$  and values  $C_{1,\omega} > 0, C_{2,\omega}, C_{3,\omega}$  depending on  $\omega > 0$  such that if  $\|r(t)\|_{H^1} \leq v^2$  and  $|t| \leq T$  then, for*

$$D_k(t) = \left( \|r(t)\|_{H_x^1(\mathbb{R})}v^2\left(\ln\frac{1}{v}\right)^{c_0} + v^{2k+2}\left(\ln\frac{1}{v}\right)^{c(k)} \right)$$

and any  $0 < v < \delta_k$ , we have

$$(4.1.19) \quad \left| \dot{p}_v(t) + C_{1,\omega}p_\zeta(t)e^{-2\sqrt{\omega}d(t)} \right| \leq KD_k(t),$$

$$(4.1.20) \quad |\dot{p}_\zeta(t) - p_v(t)| \leq KD_k(t),$$

$$(4.1.21) \quad \left| \dot{p}_\gamma(t) - p_\omega(t) - C_{2,\omega}p_\zeta(t)e^{-2\sqrt{\omega}d(t)} - C_{3,\omega}d(t)p_\zeta(t)e^{-\sqrt{2}d(t)} \right| \leq KD_k(t),$$

$$(4.1.22) \quad |\dot{p}_\omega(t)| \leq KD_k(t).$$

The constants  $c_0, K$  do not depend on  $k$ , while  $c(k)$  depends only on  $k$ .

**Remark 4.4.** *Furthermore, since the expression  $ie^{i(\gamma_k+p_\gamma)}\partial_t r(t, x) - \mathcal{L}(e^{i(\gamma_k+p_\gamma)}r(t, x))$  is equal to (4.1.18), we can verify that the real numbers  $C_{1,\omega} > 0, C_{2,\omega}, C_{3,\omega}$  denoted in the statement of Lemma 4.3 satisfy*

$$\begin{aligned} & ie^{i(\gamma_k+p_\gamma)}\partial_t r(t, x) - \mathcal{L}(e^{i(\gamma_k+p_\gamma)}r(t, x)) \\ & = - \left[ \dot{p}_v(t) + C_{1,\omega}p_\zeta(t)e^{-2\sqrt{\omega}d(t)} \right] i\text{Sym}(\varphi_{v,k}(t, \cdot))(x) \\ & \quad + [\dot{p}_\zeta(t) - p_v(t)] i\text{Sym}(\varphi_{\zeta,k}(t, \cdot))(x) \\ & \quad - \left[ \dot{p}_\gamma(t) - p_\omega(t) - C_{2,\omega}p_\zeta(t)e^{-2\sqrt{\omega}d(t)} - C_{3,\omega}d(t)p_\zeta(t)e^{-\sqrt{2}d(t)} \right] i\text{Sym}(\varphi_{\gamma,k}(t, \cdot))(x) \\ & \quad - \dot{p}_\omega(t)i\text{Sym}(\varphi_{\omega,k}(t, \cdot))(x) + O(D_k(t)). \end{aligned}$$

The expression inside  $O$  means a function  $\rho(t, x)$  satisfying  $\|\rho(t, x)\|_{H_x^1(\mathbb{R})} \leq KD_k(t)$ , for some  $K > 0$ . This estimate will be useful in the energy estimate of the norm of the remainder of the approximate solution in the next subsection.

*Proof of Lemma 4.3.* The proof that the parameters  $p_\zeta, p_v, p_\gamma, p_\omega$  are of class  $C^1$  is similar to the proof of Theorem 11 from [25], this follows from the time derivative of the equations (4.1.7), (4.1.8), (4.1.9), (4.1.10) plus the fact that  $u$  is a strong solution of (1.0.1) satisfying (4.1.6).

Next, from Lemma 2.14 and Remark 3.3, we can verify using identities (2.0.16), (2.0.17) and Lemma 2.1 the existence of a  $c > 0$  satisfying

(4.1.23)

$$i\partial_t \varphi_{\gamma,k}(t, x) - \mathcal{L}(\varphi_{\gamma,k}(t, x)) + \omega \varphi_{\gamma,k}(t, x) = O\left(v^2 \left(\ln \frac{1}{v}\right)^c + \max_j |\dot{p}_j(t)|\right),$$

$$(4.1.24) \quad i\partial_t \varphi_{\zeta,k}(t, x) - \mathcal{L}(\varphi_{\zeta,k}(t, x)) + \omega \varphi_{\zeta,k}(t, x) = O\left(v^2 \left(\ln \frac{1}{v}\right)^c + \max_j |\dot{p}_j(t)|\right),$$

(4.1.25)

$$i\partial_t \varphi_{\omega,k}(t, x) - \mathcal{L}(\varphi_{\omega,k}(t, x)) + \omega \varphi_{\omega,k}(t, x) = -i\varphi_{\gamma,k}(t, x) + O\left(v^2 \left(\ln \frac{1}{v}\right)^c + \max_j |\dot{p}_j(t)|\right),$$

$$(4.1.26) \quad i\partial_t \varphi_{v,k}(t, x) - \mathcal{L}(\varphi_{v,k}(t, x)) + \omega \varphi_{v,k}(t, x) = i\varphi_{\zeta,k}(t, x) + O\left(v^2 \left(\ln \frac{1}{v}\right)^c + \max_j |\dot{p}_j(t)|\right),$$

for all  $v > 0$  sufficiently small.

Consequently, using integration by parts, Remark 3.3, and the modulation equations (4.1.7), (4.1.8), we obtain the following estimate

$$(4.1.27) \quad \frac{d}{dt} \left\langle e^{i(\gamma_k + p_\gamma)r(t)}, i\varphi_{j,k}(t, x) \right\rangle = \left\langle -ie^{i(\gamma_k + p_\gamma)} \partial_t r(t) + \mathcal{L}\left(e^{i(\gamma_k + p_\gamma)r(t)}\right), \varphi_{j,k}(t, x) \right\rangle \\ + O\left(\|r(t)\|_{H_x^1(\mathbb{R})} v^2 \left(\ln \frac{1}{v}\right)^c + \|r(t)\|_{H_x^1(\mathbb{R})} \max_j |\dot{p}_j(t)|\right),$$

for any  $j \in \{\zeta, v, \gamma, \omega\}$ .

Next, we recall the following estimate obtained from integration by parts

$$(4.1.28) \quad \int_{\mathbb{R}} 4\sqrt{\omega} F''(\phi_\omega(x)^2) \phi_\omega(x)^2 \phi'_\omega(x) e^{-\sqrt{\omega}x} dx + 2\sqrt{\omega} F'(\phi_\omega(x)^2) \phi'_\omega(x) e^{-\sqrt{\omega}x} dx \\ = 2\omega \int_{\mathbb{R}} F'(\phi_\omega(x)^2) \phi_\omega(x) e^{-\sqrt{\omega}x} dx = C_\omega > 0.$$

Consequently, using the identity above, the estimate (4.1.18), and (4.1.27) for  $j = \zeta$  with Lemma 2.1, we deduce the existence of positive constants  $C_{1,\omega}$  and  $c$  satisfying

$$(4.1.29) \quad \dot{p}_v(t) + C_{1,\omega} p_\zeta(t) e^{-2\sqrt{\omega}d(t)} = O\left(v^2 \left(\ln \frac{1}{v}\right)^c \max_j |\dot{p}_j(t)| + v^4 \left(\ln \frac{1}{v}\right)^c |p_\zeta(t)| + D_k(t)\right).$$

Similarly, we can verify using the estimate (4.1.18) or using the estimate 4.4 of  $ie^{i(\gamma_k + p_\gamma)} \partial_t r(t, x) - \mathcal{L}(e^{i(\gamma_k + p_\gamma)r(t, x)})$  from Remark 4.4, and the identity (4.1.27) for  $j = v$  with Lemma 2.1 that

$$(4.1.30) \quad \dot{p}_\zeta(t) - p_v(t) = O\left(v^2 \left(\ln \frac{1}{v}\right)^c \max_j |\dot{p}_j(t)| + v^3 \left(\ln \frac{1}{v}\right)^c |p_\zeta(t)| + D_k(t)\right),$$

and the term of order  $v^3 \left(\ln \frac{1}{v}\right)^c |p_\zeta(t)|$  in the estimate above was obtained using the elementary inequality

$$(4.1.31) \quad \operatorname{Re} \int_{\mathbb{R}} e^{i(v_k + p_v)x} i h(x) dx = O\left(v + \|r(t)\|_{H_x^1(\mathbb{R})}\right), \text{ for any real-valued Schwartz function } h,$$

which follows using Lemma 4.1.

Furthermore, using estimate (4.1.18) of  $ie^{i(\gamma_k+p_\gamma)}\partial_t r(t,x) - \mathcal{L}(e^{i(\gamma_k+p_\gamma)}r(t,x))$ , equation (4.1.27) for  $j = \omega$  and Lemma 2.1, we obtain the existence of a constant  $c > 0$  satisfying

$$(4.1.32) \quad \begin{aligned} \dot{p}_\gamma(t) - p_\omega(t) - C_{2,\omega}p_\zeta(t)e^{-2\sqrt{\omega}d(t)} - C_{3,\omega}d(t)p_\zeta(t)e^{-\sqrt{2}d(t)} \\ = O\left(v^2\left(\ln\frac{1}{v}\right)^c \max_j |\dot{p}_j(t)| + v^4\left(\ln\frac{1}{v}\right)^c |p_\zeta(t)| + D_k(t)\right). \end{aligned}$$

Finally, by similar reasoning to the estimate (4.1.29), using (4.1.27) for  $j = \gamma$  and estimate (4.1.18) of  $ie^{i(\gamma_k+p_\gamma)}\partial_t r(t,x) - \mathcal{L}(e^{i(\gamma_k+p_\gamma)}r(t,x))$ , we can verify the existence of a constant  $c > 0$  satisfying

$$(4.1.33) \quad \dot{p}_\omega(t) = O\left(v^2\left(\ln\frac{1}{v}\right)^c \max_j |\dot{p}_j(t)| + v^3\left(\ln\frac{1}{v}\right)^c |p_\zeta(t)| + D_k(t)\right).$$

In conclusion, the result of Lemma 4.3 follow from estimates (4.1.29), (4.1.30), (4.1.32), (4.1.33) and Lemma 4.1.  $\square$

**4.2. Energy Estimate Functional.** The main result of this subsection is the following theorem.

**Theorem 4.5.** *There exist  $C > 1$ , for any  $l \in \mathbb{N}$ ,  $k_0 \in \mathbb{N}$  there exist  $C_l > 1$ , and for any  $k \in \mathbb{N}_{\geq k_0}$ , there exist  $c(k)$ ,  $c(k,l) > 0$  and  $\delta_{k,l} \in (0,1)$  such that if  $0 < v < \delta_{k,l}$  and for  $\frac{30k \ln \frac{1}{v}}{\sqrt{\omega}v} < T_{0,k} < \frac{(\ln \frac{1}{v})^{\frac{4}{3}}}{v}$*

$$(4.2.1) \quad \left\| (1+x^{2l})^{\frac{1}{2}} [u(T_{0,k}) - P_k(T_{0,k}, x, \sigma_k(T_{0,k}))] \right\|_{H^{2l}} < v^{10k},$$

then the unique solution of

$$iu_t + u_{xx} + F'(|u|^2)u = 0$$

satisfies

$$(4.2.2) \quad \|u(t) - P_k(t, x, \sigma_k(t))\|_{H^1} \leq Cv^{2k} \left(\ln\frac{1}{v}\right)^{c(k)+1} \exp\left(\frac{Cv|t - T_{0,k}|}{\ln\frac{1}{v}}\right),$$

$$(4.2.3) \quad v^{2l} \|x^l [u(t) - P_k(t, x, \sigma_k(t))]\|_{H^1} \leq C_l v^{2k} \left(\ln\frac{1}{v}\right)^{c(k,l)} \exp\left(\frac{C_l v |t - T_{0,k}|}{\ln\frac{1}{v}}\right),$$

for all  $t$  satisfying  $|t - T_{0,k}| \leq \frac{(\ln \frac{1}{v})^{\frac{4}{3}}}{v}$ .

**Remark 4.6.** *The choosing of  $\frac{4}{3}$  in the exponent of  $\ln \frac{1}{v}$  for the time interval is arbitrary, the statement would still be true for any  $\theta$  slightly larger than 1 after selecting an appropriate small  $\delta_k > 0$ . Moreover, the constant  $c(k)$  depends only on the function  $\varphi_k$  and it is the same for all  $v$  sufficiently small.*

From now on, we denote the solution  $u(t,x)$  of the Schrödinger equation (1.0.1) satisfying the initial condition (1.0.9) by

$$(4.2.4) \quad u(t,x) = P_k(t,x,\sigma_u(t)) + e^{i\gamma_k(t)}r(t,x)$$

for all  $t$  satisfying  $|t - T_{0,k}| \leq \frac{(\ln \frac{1}{v})^{\frac{4}{3}}}{v}$ . such that  $r(t)$  satisfies the orthogonality conditions from (4.1.7) through (4.1.10).

The proof of Theorem 4.5 will follow from the study of a Lyapunov function obtained from a perturbation of the quadratic form

$$\begin{aligned}
(4.2.5) \quad L(t, r) &= \int_{\mathbb{R}} |\partial_x r(t, x)|^2 + \omega |r(t, x)|^2 dx \\
&\quad - \int_{\mathbb{R}} F'(\phi_\omega(x - \zeta_k(t))^2) |r(t, x)|^2 + F'(\phi_\omega(x + \zeta_k(t))^2) |r(t, x)|^2 dx \\
&\quad - \operatorname{Re} \int_{\mathbb{R}} F''(\phi_\omega(x - \zeta_k)^2) \phi_\omega(x - \zeta_k)^2 e^{2i\alpha_k(t, x)} \overline{r(t, x)^2} e^{-2i\gamma_k(t)} dx \\
&\quad - \operatorname{Re} \int_{\mathbb{R}} F''(\phi_\omega(x + \zeta_k)^2) \phi_\omega(x + \zeta_k)^2 e^{2i\alpha_k(t, -x)} \overline{r(t, x)^2} e^{-2i\gamma_k(t)} dx \\
&\quad - \int_{\mathbb{R}} F''(\phi_\omega(x - \zeta_k)^2) \phi_\omega(x - \zeta_k)^2 |r(t, x)|^2 dx \\
&\quad - \int_{\mathbb{R}} F''(\phi_\omega(x + \zeta_k)^2) \phi_\omega(x + \zeta_k)^2 |r(t, x)|^2 dx.
\end{aligned}$$

Since  $r$  satisfies the orthogonality conditions of Lemma 4.1, we can verify that the operator  $L$  is positive on  $r \in H_x^1(\mathbb{R}, \mathbb{C})$ .

Furthermore, to study the coercivity of  $L$  and the growth of its derivative, we consider from now on a cut-off smooth function  $\chi$  satisfying

$$(4.2.6) \quad \chi(x) = \begin{cases} 0, & x \geq \frac{6}{10}, \\ 1, & x \leq \frac{1}{2}, \end{cases} \quad \text{and } 0 < \chi(x) < 1, \text{ if } \frac{1}{2} < x < \frac{6}{10},$$

and we define the following two functions

$$(4.2.7) \quad \chi_1(t, x) := \chi\left(\frac{x + \zeta_k(t)}{2\zeta_k(t)}\right), \quad \chi_2(t, x) := 1 - \chi_1(t, x),$$

for all  $(t, x) \in \mathbb{R}^2$ .

**Lemma 4.7** (Coercivity Lemma). *There exist constants  $\delta, c > 0$  such that if  $0 < v < \delta_k$  and  $\|r\|_{H_x^1(\mathbb{R})} \leq \delta$  and the function  $r \in H_x^1(\mathbb{R}, \mathbb{C})$  satisfies the identities (4.1.7), (4.1.8), (4.1.9), (4.1.10), then*

$$(4.2.8) \quad L(t, r) \geq c \|r(t)\|_{H^1}^2.$$

*Proof.* First, we consider the functions

$$r_1(t, x) = r(t, x)\chi_1(t, x), \quad r_2(t, x) = r(t, x)\chi_2(t, x).$$

Moreover, using Remark 3.3, we also observe for any  $j \in \{1, 2\}$  that

$$|\partial_x \chi_j(t, x)| = O\left(\frac{1}{\ln \frac{1}{v}}\right).$$

Next, since the soliton  $\phi_\omega$  satisfies the inequality

$$|\phi_\omega(x)| = O\left(e^{-\sqrt{\omega}|x|}\right),$$

there is a constant  $K > 0$  such that

$$(4.2.9) \quad |\chi_1(t, x)\phi_\omega(x - \zeta_k(t))| + |\chi_2(t, x)\phi_\omega(x + \zeta_k(t))| \leq K e^{-\sqrt{\omega} \frac{4d(t)}{5}},$$

because  $\zeta_k(t)$  satisfies the Remark 3.3 when  $v > 0$  is small enough. Therefore, we can verify that the function  $L(t, r)$  can be estimated as

$$(4.2.10) \quad L(t, r) = L_1(t) + L_2(t) + 2 \int_{\mathbb{R}} \chi_1(t, x)\chi_2(t, x) [|\partial_x r(t, x)|^2 + |r(t, x)|^2] dx + O\left(\frac{1}{\ln \frac{1}{v}} \|r(t)\|_{H^1}^2\right),$$

such that

$$\begin{aligned}
L_j(t) &= \int_{\mathbb{R}} |\partial_x r_j(t, x)|^2 + \omega |r_j(t, x)|^2 dx \\
&\quad - \int_{\mathbb{R}} F'(\phi_\omega(x - (-1)^j \zeta_k(t))) |r_j(t, x)|^2 dx \\
&\quad - \operatorname{Re} \int_{\mathbb{R}} F''(\phi_\omega(x - (-1)^j \zeta_k(t))) \phi_\omega(x - \zeta_k)^2 e^{2i\alpha_k(t, (-1)^j x)} \overline{r_j(t, x)^2} e^{-2i\gamma_k(t)} dx \\
&\quad - \int_{\mathbb{R}} F''(\phi_\omega(x - (-1)^j \zeta_k(t))) \phi_\omega(x - (-1)^j \zeta_k)^2 |r_j(t, x)|^2 dx.
\end{aligned}$$

Moreover, since  $\chi_j \geq 0$  for any  $j \in \{1, 2\}$ , we have the following inequality

$$\int_{\mathbb{R}} \chi_1(t, x) \chi_2(t, x) [|\partial_x r(t, x)|^2 + |r(t, x)|^2] \geq 0.$$

Furthermore, using the definition (3.0.31) of  $\alpha$ , Remark 3.3 when  $v > 0$  is small enough, and estimate (4.2.9), it is not difficult to verify for any  $j \in \{1, 2\}$  that the function

$$\hat{r}_j(t, x - (-1)^j \zeta_k(t)) := e^{-i\alpha(t, (-1)^j x) + i\gamma_k(t)} r_j(t, x)$$

satisfies  $L_j(t) = \langle S_\omega(\hat{r}_j(t, x)), \hat{r}_j(t, x) \rangle + O(v \|r_j\|_{H^1}^2)$ ,  $\|\hat{r}_j(t)\|_{H^1}^2 = \|r_j(t)\|_{H^1}^2 + O(v \|r_j\|_{H^1}^2)$ , and

$$\langle \hat{r}_j(t, x), x \phi_\omega(x) \rangle = O\left(v^{\frac{3}{4}} \|r(t)\|_{H^1}\right), \quad \langle \hat{r}_j(t, x), i\partial_\omega \phi_\omega(x) \rangle = O\left(v^{\frac{3}{4}} \|r(t)\|_{H^1}\right).$$

Therefore, we obtain from Remark 2.13 of Lemma 2.12 using Young Inequality the existence of constants  $c, K > 0$  such that if  $v > 0$  is sufficiently small, then

$$(4.2.11) \quad L_j(t) \geq c \|r_j(t)\|_{H^1}^2 - K v^3 \|r(t)\|_{H^1}^2,$$

for any  $j \in \{1, 2\}$ .

In conclusion, since  $\chi_1 + \chi_2 = 1$ , (4.2.10) and (4.2.11) imply (4.2.8).  $\square$

Moreover, using the inequality (2.0.6) from Remark 2.13, we deduce the existence of a constant  $C > 1$  such that

$$(4.2.12) \quad L_j(t) \geq c \|r_j(t)\|_{H^1}^2 - C \|\Pi_1(r_j(t))\|_{L^2}^2.$$

Consequently, using (4.2.12) in the place of (4.2.11) in the proof of Lemma 4.7, we obtain the following proposition.

**Lemma 4.8.** *There exist constants  $\delta, c > 0, C > 1$  such that if  $0 < v < \delta_k$  and  $\|r(t)\|_{L^\infty[T_1, T_2], H_x^1(\mathbb{R})} \leq \delta$ , then for any  $t \in [T_1, T_2]$*

$$\begin{aligned}
L(t, r) &\geq c \|r(t)\|_{H^1}^2 - C \sum_{\pm} \langle r(t), i\varphi_{\gamma, k}(t, \pm x) \rangle^2 - C \sum_{\pm} \langle r(t), i\varphi_{\zeta, k}(t, \pm x) \rangle^2 \\
&\quad - C \sum_{\pm} \langle r(t), i\varphi_{\omega, k}(t, \pm x) \rangle^2 - C \sum_{\pm} \langle r(t), i\varphi_{v, k}(t, \pm x) \rangle^2.
\end{aligned}$$

Next, following the reasoning in [24], we are going to use the estimates of the modulation parameters from Lemmas 4.1, 4.3 and equation (4.1.17) to estimate  $|\partial_t L(t, r)|$  during a large time interval. More precisely, we are going to verify that the function  $L(t, r)$  satisfies the following proposition.

**Lemma 4.9.** *Let  $L(t, r)$  be the function defined at (4.2.5) and let  $c(k)$  be the same as in the statement of Theorem 3.1. There exists a constant  $c > 0$  and  $\delta_k \in (0, 1)$  such that if  $0 < v < \delta_k$  and*

$\|r(t)\|_{H^1} \leq v^2$ , then

$$\begin{aligned}
\partial_t L(t, r) = & 2\dot{\zeta}_k(t) \int_{\mathbb{R}} F'' (\phi_\omega(x - \zeta_k(t))^2) \phi'_\omega(x - \zeta_k) \phi_\omega(x - \zeta_k) |r(t, x)|^2 dx \\
& - 2\dot{\zeta}_k(t) \int_{\mathbb{R}} F'' (\phi_\omega(x + \zeta_k(t))^2) \phi'_\omega(x + \zeta_k) \phi_\omega(x + \zeta_k) |r(t, x)|^2 dx \\
& + \dot{\zeta}_k(t) \operatorname{Re} \int_{\mathbb{R}} \frac{\partial}{\partial x} \left[ F'' (\phi_\omega(x - \zeta_k)^2) \phi_\omega(x - \zeta_k)^2 \right] \overline{r(t, x)^2} dx \\
& - \dot{\zeta}_k(t) \operatorname{Re} \int_{\mathbb{R}} \frac{\partial}{\partial x} \left[ F'' (\phi_\omega(x + \zeta_k)^2) \phi_\omega(x + \zeta_k)^2 \right] \overline{r(t, x)^2} dx \\
& + \dot{\zeta}_k(t) \int_{\mathbb{R}} \frac{\partial}{\partial x} \left[ F'' (\phi_\omega(x - \zeta_k)^2) \phi_\omega(x - \zeta_k)^2 \right] |r(t, x)|^2 dx \\
& - \dot{\zeta}_k(t) \int_{\mathbb{R}} \frac{\partial}{\partial x} \left[ F'' (\phi_\omega(x + \zeta_k)^2) \phi_\omega(x + \zeta_k)^2 \right] |r(t, x)|^2 dx \\
& + O \left( v^2 \left( \ln \frac{1}{v} \right)^c \|r(t)\|_{H^1}^2 + \|r(t)\|_{H^1} v^{2k+2} \left( \ln \frac{1}{v} \right)^{c(k)} + \|r(t)\|_{H^1}^3 \right),
\end{aligned}$$

for all  $t$  satisfying  $\left| t - \frac{30k \ln \frac{1}{v}}{\sqrt{\omega} v} \right| \leq \frac{\left( \ln \frac{1}{v} \right)^{\frac{4}{3}}}{v}$ .

**Remark 4.10.** The constant  $c > 0$  does not depend on  $k$ , it comes from the first approximate solution when  $k = 2$ .

*Proof of Lemma 4.9.* First, using the definition of  $L(t, r)$  in (4.2.5) and estimates (3.3), we deduce from the derivative of  $L(t, r)$  that proving Lemma 4.9 is equivalent to verify that the following expression

$$\begin{aligned}
(4.2.13) \quad & 2 \operatorname{Re} \int_{\mathbb{R}} -\partial_x^2 r(t) \partial_t \overline{r(t)} + \omega r(t) \partial_t \overline{r(t)} dx \\
& - 2 \int_{\mathbb{R}} F' (\phi_\omega(x - \zeta_k(t))^2) r(t) \partial_t \overline{r(t)} + F' (\phi_\omega(x + \zeta_k(t))^2) r(t) \partial_t \overline{r(t)} dx \\
& - 2 \operatorname{Re} \int_{\mathbb{R}} F'' (\phi_\omega(x - \zeta_k)^2) \phi_\omega(x - \zeta_k)^2 e^{2i\alpha_k(t, x)} \overline{r(t)} \partial_t \overline{r(t)} e^{-2i\gamma_k(t)} dx \\
& - 2 \operatorname{Re} \int_{\mathbb{R}} F'' (\phi_\omega(x + \zeta_k)^2) \phi_\omega(x + \zeta_k)^2 e^{2i\alpha_k(t, -x)} \overline{r(t)} \partial_t \overline{r(t)} e^{-2i\gamma_k(t)} dx \\
& - 2 \operatorname{Re} \int_{\mathbb{R}} F'' (\phi_\omega(x - \zeta_k)^2) \phi_\omega(x - \zeta_k)^2 r(t) \partial_t \overline{r(t)} dx \\
& - 2 \operatorname{Re} \int_{\mathbb{R}} F'' (\phi_\omega(x + \zeta_k)^2) \phi_\omega(x + \zeta_k)^2 r(t) \partial_t \overline{r(t)} dx
\end{aligned}$$

has a modulus of order

$$O \left( v^2 \left( \ln \frac{1}{v} \right)^c \|r(t)\|_{H_x^1(\mathbb{R})}^2 + \|r(t)\|_{H_x^1(\mathbb{R})} v^{2k+2} \left( \ln \frac{1}{v} \right)^{c(k)} \right).$$

Moreover, using the operator  $\mathcal{L}$  defined in (4.1.16), we obtain using Lemmas 2.1 and 2.2 that the expression (4.2.13) is equal for some constant  $c > 0$

$$(4.2.14) \quad 2 \left\langle \mathcal{L} \left( e^{i\gamma_k(t)} r(t) \right), e^{i\gamma_k(t)} \partial_t r(t) \right\rangle + O \left( v^2 \left( \ln \frac{1}{v} \right)^c \|r(t)\|_{H^1}^2 \right),$$

if  $v > 0$  is small enough.



Furthermore, using Remark 4.4 and integration by parts, we can verify that

$$\begin{aligned}
(4.2.15) \quad & \left\langle \mathcal{L} \left( e^{i\gamma_k(t)} r(t) \right), e^{i\gamma_k(t)} \partial_t r(t) \right\rangle \\
&= - \left\langle \mathcal{L} \left( e^{i\gamma_k(t)} r(t) \right), \left[ \dot{p}_v(t) + C_{1,\omega} p_\zeta(t) e^{-2\sqrt{\omega}d(t)} \right] \text{Sym}(\varphi_{v,k}(t, \cdot))(x) \right\rangle \\
&\quad + \left\langle \mathcal{L} \left( e^{i\gamma_k(t)} r(t) \right), \left[ \dot{p}_\zeta(t) - p_v(t) \right] \text{Sym}(\varphi_{\zeta,k}(t, \cdot))(x) \right\rangle \\
&\quad - \left\langle \mathcal{L} \left( e^{i\gamma_k(t)} r(t) \right), \left[ \dot{p}_\gamma(t) - p_\omega(t) \right. \right. \\
&\quad \left. \left. - C_{2,\omega} p_\zeta(t) e^{-2\sqrt{\omega}d(t)} - C_{3,\omega} d(t) p_\zeta(t) e^{-2\sqrt{\omega}d(t)} \right] \text{Sym}(\varphi_{\gamma,k}(t, \cdot))(x) \right\rangle \\
&\quad - \left\langle \mathcal{L} \left( e^{i\gamma_k(t)} r(t) \right), \dot{p}_\omega(t) \text{Sym}(\varphi_{\omega,k}(t, \cdot))(x) \right\rangle \\
&\quad + O \left( \|r(t)\|_{H^1}^2 v^2 \left( \ln \frac{1}{v} \right)^c + \|r(t)\|_{H^1}^3 \right) \\
&\quad + O \left( \|r(t)\|_{H^1}^2 v^{2k+2} \left( \ln \frac{1}{v} \right)^{c(k)} \right)
\end{aligned}$$

In conclusion, we obtain from the estimate (4.2.15) and Lemma 4.3 that the expression (4.2.13) has a modulus of order

$$O \left( \|r(t)\|_{H^1} v^{2k+2} \left( \ln \frac{1}{v} \right)^{c(k)} + v^2 \left( \ln \frac{1}{v} \right)^c \|r(t)\|_{H_x^1(\mathbb{R})}^2 \right),$$

which implies the result of Lemma 4.9.  $\square$

In addition, it is possible to add functions of correction to  $L(t, r)$  and obtain a new Lyapunov function having a derivative with a size smaller than  $|\partial_t L(t, r)|$ , this approach was also used in the paper [24] for study the collision between two kinks for the  $\phi^6$  model. These functions of corrections are the following localized momentum quantities

$$(4.2.16) \quad P_1(t, r) := \text{Im} \int_{\mathbb{R}} \chi_1(t, x) \overline{r(t, x)} \partial_x r(t, x) dx, \quad P_2(t, r) := \text{Im} \int_{\mathbb{R}} \chi_2(t, x) \overline{r(t, x)} \partial_x r(t, x) dx.$$

However, before constructing the last Lyapunov function, we shall estimate the derivatives of  $P_1(t, r)$  and  $P_2(t, r)$ .

**Lemma 4.11.** *Let  $j \in \{1, 2\}$ , the function  $P_j(t, r)$  satisfies*

$$\begin{aligned}
(4.2.17) \quad & \partial_t P_j(t, r) = \text{Re} \int_{\mathbb{R}} \frac{\partial}{\partial x} \left[ F'(\phi_\omega(x + (-1)^{j+1}(\zeta_k + p_\zeta)^2)) \right] |r(t, x)|^2 dx \\
&\quad + \text{Re} \int_{\mathbb{R}} \frac{\partial}{\partial x} \left[ F''(\phi_\omega(x + (-1)^{j+1}(\zeta_k + p_\zeta)^2)) \phi_\omega(x + (-1)^{j+1}(\zeta_k + p_\zeta)^2) \right] |r(t, x)|^2 dx \\
&\quad + \text{Re} \int_{\mathbb{R}} \frac{\partial}{\partial x} \left[ F''(\phi_\omega(x + (-1)^{j+1}(\zeta_k + p_\zeta)^2)) \phi_\omega(x + (-1)^{j+1}(\zeta_k + p_\zeta)^2) \right] r(t, x)^2 dx \\
&\quad + O \left( v^{2k+2} \left( \ln \frac{1}{v} \right)^{c(k)} \|r(t)\|_{H^1} + \frac{1}{\ln \frac{1}{v}} \|r(t)\|_{H^1}^2 + \|r(t)\|_{H^1}^3 \right).
\end{aligned}$$

*Proof of Lemma 4.11.* It is enough to verify the statement of Lemma 4.11 for  $j = 1$ , the proof for the case when  $j = 2$  is completely analogous.

First, from the definition of  $P_1(t, r)$ , we can verify using integration by parts that

$$\frac{\partial P_1(t, r)}{\partial t} = 2 \operatorname{Im} \int_{\mathbb{R}} \chi_1(t, x) \overline{\partial_t r(t, x)} \partial_x r(t, x) dx + O\left(\frac{v \|r(t)\|_{H^1}^2}{\ln \frac{1}{v}}\right).$$

Furthermore, from Lemma 4.3 and Remark 4.4, we have that

$$(4.2.18) \quad \begin{aligned} \partial_t r(t, x) = & i \partial_x^2 r(t, x) - i \omega r(t, x) \\ & + i \left[ F'(\phi_\omega(x - (\zeta_k + p_\zeta))^2) + F'(\phi_\omega(x + (\zeta_k + p_\zeta))^2) \right] r(t, x) \\ & + i F''(\phi_\omega(x - (\zeta_k + p_\zeta))^2) \phi_\omega(x - (\zeta_k + p_\zeta))^2 r(t, x) \\ & + i F''(\phi_\omega(x + (\zeta_k + p_\zeta))^2) \phi_\omega(x + (\zeta_k + p_\zeta))^2 r(t, x) \\ & + i F''(\phi_\omega(x - (\zeta_k + p_\zeta))^2) \phi_\omega(x - (\zeta_k + p_\zeta))^2 \overline{r(t, x)} e^{2i\alpha_k(t, x, \sigma_u) - 2i\gamma_k(t)} \\ & + i F''(\phi_\omega(x + (\zeta_k + p_\zeta))^2) \phi_\omega(x + (\zeta_k + p_\zeta))^2 \overline{r(t, x)} e^{2i\alpha_k(t, -x, \sigma_u) - 2i\gamma_k(t)} \\ & + O\left(v^{2k+2} \left(\ln \frac{1}{v}\right)^{c(k)} + v^2 \left(\ln \frac{1}{v}\right)^c \|r(t)\|_{H^1} + \|r(t)\|_{H^1}^2\right). \end{aligned}$$

Consequently, using the definition of  $\alpha$  in 3.0.31 and Remark 3.2, we deduce

$$\begin{aligned} & 2 \operatorname{Im} \int_{\mathbb{R}} \chi_1(t, x) \overline{\partial_t r(t, x)} \partial_x r(t, x) dx \\ & = -2 \operatorname{Re} \int_{\mathbb{R}} \chi_1(t, x) \overline{\partial_x^2 r(t, x)} \partial_x r(t, x) dx \\ & \quad + 2\omega \operatorname{Re} \int_{\mathbb{R}} \chi_1(t, x) \overline{r(t, x)} \partial_x r(t, x) dx \\ & \quad - 2 \operatorname{Re} \int_{\mathbb{R}} \chi_1(t, x) \left[ F'(\phi_\omega(x - (\zeta_k + p_\zeta))^2) + F'(\phi_\omega(x + (\zeta_k + p_\zeta))^2) \right] \overline{r(t, x)} \partial_x r(t, x) dx \\ & \quad - 2 \operatorname{Re} \int_{\mathbb{R}} \chi_1(t, x) F''(\phi_\omega(x - (\zeta_k + p_\zeta))^2) \phi_\omega(x - (\zeta_k + p_\zeta))^2 \overline{r(t, x)} \partial_x r(t, x) dx \\ & \quad - 2 \operatorname{Re} \int_{\mathbb{R}} \chi_1(t, x) F''(\phi_\omega(x + (\zeta_k + p_\zeta))^2) \phi_\omega(x + (\zeta_k + p_\zeta))^2 \overline{r(t, x)} \partial_x r(t, x) dx \\ & \quad - 2 \operatorname{Re} \int_{\mathbb{R}} \chi_1(t, x) F''(\phi_\omega(x - (\zeta_k + p_\zeta))^2) \phi_\omega(x - (\zeta_k + p_\zeta))^2 r(t, x) \partial_x r(t, x) dx \\ & \quad - 2 \operatorname{Re} \int_{\mathbb{R}} \chi_1(t, x) F''(\phi_\omega(x + (\zeta_k + p_\zeta))^2) \phi_\omega(x + (\zeta_k + p_\zeta))^2 r(t, x) \partial_x r(t, x) dx \\ & \quad + O\left(\frac{1}{\ln \frac{1}{v}} \|r(t)\|_{H^1}^2 + v^{2k+2} \left(\ln \frac{1}{v}\right)^{c(k)} \|r(t)\|_{H^1} + \|r(t)\|_{H^1}^3\right), \end{aligned}$$

from which, using integration by parts and the estimates (4.2.9), we obtain that

$$\begin{aligned}
2 \operatorname{Im} \int_{\mathbb{R}} \chi_1(t, x) \overline{\partial_t r(t, x)} \partial_x r(t, x) dx \\
&= \operatorname{Re} \int_{\mathbb{R}} \frac{\partial}{\partial x} \left[ F'(\phi_\omega(x + (\zeta_k + p_\zeta))^2) \right] |r(t, x)|^2 dx \\
&\quad + \operatorname{Re} \int_{\mathbb{R}} \frac{\partial}{\partial x} \left[ F''(\phi_\omega(x + (\zeta_k + p_\zeta))^2) \phi_\omega(x + (\zeta_k + p_\zeta))^2 \right] |r(t, x)|^2 dx \\
&\quad + \operatorname{Re} \int_{\mathbb{R}} \frac{\partial}{\partial x} \left[ F''(\phi_\omega(x + (\zeta_k + p_\zeta))^2) \phi_\omega(x + (\zeta_k + p_\zeta))^2 \right] r(t, x)^2 dx \\
&\quad + O \left( v^{2k+2} \left( \ln \frac{1}{v} \right)^{c(k)} \|r(t)\|_{H^1} + \frac{1}{\ln \frac{1}{v}} \|r(t)\|_{H^1}^2 + \|r(t)\|_{H^1}^3 \right).
\end{aligned}$$

In conclusion, we have that (4.11) is true when  $v > 0$  is small enough.  $\square$

Furthermore, using the decay estimates (3.0.23), we can deduce from Lemma 4.11 the following proposition.

**Corollary 4.12.** *Let  $j \in \{1, 2\}$ . The function  $P_j(t, r)$  satisfies*

$$\begin{aligned}
(4.2.19) \quad &\frac{d}{dt} [\dot{d}(t) P_j(t, r)] \\
&= \dot{d}(t) \operatorname{Re} \int_{\mathbb{R}} \frac{\partial}{\partial x} \left[ F'(\phi_\omega(x + (-1)^{j+1}(\zeta_k + p_\zeta))^2) \right] |r(t, x)|^2 dx \\
&\quad + \dot{d}(t) \operatorname{Re} \int_{\mathbb{R}} \frac{\partial}{\partial x} \left[ F''(\phi_\omega(x + (-1)^{j+1}(\zeta_k + p_\zeta))^2) \phi_\omega(x + (-1)^{j+1}(\zeta_k + p_\zeta))^2 \right] |r(t, x)|^2 dx \\
&\quad + \dot{d}(t) \operatorname{Re} \int_{\mathbb{R}} \frac{\partial}{\partial x} \left[ F''(\phi_\omega(x + (-1)^{j+1}(\zeta_k + p_\zeta))^2) \phi_\omega(x + (-1)^{j+1}(\zeta_k + p_\zeta))^2 \right] r(t, x)^2 dx \\
&\quad + O \left( v^{2k+3} \left( \ln \frac{1}{v} \right)^{c(k)} \|r(t)\|_{H^1} + \frac{v}{\ln \frac{1}{v}} \|r(t)\|_{H^1}^2 + v \|r(t)\|_{H^1}^3 \right).
\end{aligned}$$

Next, we are going to consider the following Lyapunov Functional

$$(4.2.20) \quad E(t, r) = L(t, r) - \dot{d}(t) P_2(t, r) + \dot{d}(t) P_1(t, r),$$

and demonstrate Theorem 4.5 from the derivative of  $E(t, r)$  using Lemmas 4.7, 4.9, and Corollary 4.12.

*Proof of Theorem 4.5. Step 1.* (Proof of the estimate of  $\|r(t)\|_{H^1}$ .)

First, from Lemma 4.1, we have that if  $\|u(t) - P_k(t, x, \sigma_k(t))\| < v^2$ ,  $t$  satisfies  $|t - T_{0,k}| \leq \frac{(\ln \frac{1}{v})^{\frac{4}{3}}}{v}$ , and  $v > 0$  is small enough, then there exist  $K > 1$  and  $c > 0$  satisfying

$$\|r(t)\|_{H^1} \leq K \left( \ln \frac{1}{v} \right)^c \|u(t) - P_k(t, x, \sigma_k(t))\|,$$

for some  $c > 0$ , which is much smaller than  $v^{\frac{3}{2}}$ . We also recall from Remark 3.3 the following estimate

$$\dot{\zeta}_k(t) = \dot{d}(t) + O \left( v^2 \left( \ln \frac{1}{v} \right)^c \right),$$

if  $v > 0$  is small enough. Therefore, we deduce from Lemmas 4.1, 4.9 and Corollary 4.12 that

$$(4.2.21) \quad |\dot{E}(t, r)| = O \left( v^{2k+2} \left( \ln \frac{1}{v} \right)^{c(k)} \|r(t)\|_{H^1} + \frac{v}{\ln \frac{1}{v}} \|r(t)\|_{H^1}^2 + \|r(t)\|_{H^1}^3 \right).$$

Next, using Lemma 4.7, we can find a constant  $C > 0$  not depending on  $v$  and  $k$  such that if  $v > 0$  is small enough, then

$$(4.2.22) \quad C \|r(t)\|_{H^1}^2 \leq E(t, r).$$

Consequently, using the quantity

$$m(t) = \max \left( \|r(t)\|_{H^1}, v^{2k+1} \left( \ln \frac{1}{v} \right)^{c(k)+1} \right),$$

we obtain for some positive constant  $C_1$  that if  $\|r(t)\|_{H^1} > v^{2k+1} \left( \ln \frac{1}{v} \right)^{c(k)+1}$  and  $\|r(t)\|_{H^1} < \frac{v}{\ln \frac{1}{v}}$ , then

$$(4.2.23) \quad \dot{E}(t, r) \leq C_1 \frac{v}{\ln \frac{1}{v}} m(t)^2, \quad E(t, r) \geq \frac{C}{2} m(t)^2.$$

Consequently, using Gronwall Lemma and the assumption (1.0.9), we can verify while  $\|r(t)\|_{H^1} < v^2$  that

$$(4.2.24) \quad \|r(t)\|_{H^1} \leq m(t) \leq K v^{2k} \left( \ln \frac{1}{v} \right)^{c(k)} \exp \left( \frac{2C_1}{C} \frac{v}{\ln \frac{1}{v}} |t - T_{0,k}| \right),$$

for any  $T_{0,k}$  satisfying the assumptions of Theorem 4.5.

Next, from the Mean Value Theorem, the definition of  $P_k$  in Theorem 3.1, we can verify the existence of a  $c > 0$  such that if  $v > 0$  is sufficiently small, then

$$\|P_k(t, x, \sigma_k(t)) - P_k(t, x, \sigma_u(t))\|_{H^1} \leq K \left( \ln \frac{1}{v} \right)^c \max_{j \in \{\zeta, v, \gamma, \omega\}} |p_j(t, r)|,$$

for some constant  $K > 1$ . Consequently, using Lemma 4.1 and 4.2.24, we obtain estimate (4.2.2) from Minkowski inequality.

Moreover, the partial differential equation (1.0.1) is locally well-Posed in the space  $H^s(\mathbb{R})$  for any  $s \geq 0$ , and we are assuming  $u(T_{0,k}) \in H^l(\mathbb{R})$  from the hypotheses of Theorem 4.5. Consequently, we deduce that  $\partial_x^j r(t, x) \in H^1(\mathbb{R})$  if  $0 \leq j \leq l-1$  for all  $t \in \mathbb{R}$  satisfying  $|t - T_{0,k}| \leq \frac{(\ln \frac{1}{v})^{\frac{4}{3}}}{v}$ . Since  $u(T_{0,k})$  has sufficient regularity, we might use the same techniques of this step to estimate the higher Sobolev norms of  $r(t)$ , and also the weighted norms for  $r(t)$  in the next steps.

**Step 2.** (Estimate of  $\|r(t)\|_{H^l}$  for  $l > 1$ .)

First, using the partial differential equation (4.2.18) and estimate (1.1.1), we can verify for any  $m \in \mathbb{N}$  satisfying  $0 \leq m \leq l-1$ , that the function  $r_m(t, x) := \partial_x^m r(t, x)$  satisfies the following partial differential equation

$$(4.2.25) \quad \begin{aligned} \partial_t r_m(t, x) = & i \partial_x^2 r_m(t, x) - i \omega r_m(t, x) \\ & + \left[ i F'(\phi_\omega(x - (\zeta_k + p_\zeta))^2) + F(\phi_\omega(x + (\zeta_k + p_\zeta))^2) \right] r_m(t, x) \\ & + i F''(\phi_\omega(x - (\zeta_k + p_\zeta))^2) \phi_\omega(x - (\zeta_k + p_\zeta))^2 r_m(t, x) \\ & + i F''(\phi_\omega(x + (\zeta_k + p_\zeta))^2) \phi_\omega(x + (\zeta_k + p_\zeta))^2 r_m(t, x) \\ & + i F''(\phi_\omega(x - (\zeta_k + p_\zeta))^2) \phi_\omega(x - (\zeta_k + p_\zeta))^2 \overline{r_m(t, x)} e^{2i\alpha(t, x, \sigma_u) - 2i\gamma_k(t)} \\ & + i F''(\phi_\omega(x + (\zeta_k + p_\zeta))^2) \phi_\omega(x + (\zeta_k + p_\zeta))^2 \overline{r_m(t, x)} e^{2i\alpha(t, -x, \sigma_u) - 2i\gamma_k(t)} \\ & + O \left( \|r(t)\|_{H^m} + v^2 \left( \ln \frac{1}{v} \right)^c \|r(t)\|_{H^{m+1}} + \|r(t)\|_{H^{m+1}}^{2d_0-1} + v^{2k+2} \left( \ln \frac{1}{v} \right)^{c(k)} \right), \end{aligned}$$

such that  $d_0 \in \mathbb{N}_{\geq 1}$  is the degree of the polynomial  $F$  and the expression inside  $O$  means a function  $G(t, x)$  such that there exists a constant  $C > 1$  satisfying

$$\|G(t, x)\|_{H^1} \leq C \left[ \|r(t)\|_{H^m} + v^2 \left( \ln \frac{1}{v} \right)^c \|r(t)\|_{H^{m+1}} + \|r(t)\|_{H^{m+1}}^{2d_0-1} \right],$$

for all  $|t - T_{0,k}| \leq \frac{(\ln \frac{1}{v})^{\frac{4}{3}}}{v}$ , see the notation section in the introduction.

Moreover, using integration by parts and estimate (3.0.58), we can verify the existence of constants  $K, C > 1$  and parameter a  $c(k) > 0$  satisfying

$$|\langle r_m(t), \varphi_{k,\beta}(t, \pm x) \rangle| \leq K v^{2k} \left( \ln \frac{1}{v} \right)^{c(k)} \exp \left( \frac{Cv}{\ln \frac{1}{v}} |t - T_{0,k}| \right),$$

for any  $\beta \in \{\zeta, v, \gamma, \omega\}$ , while  $|t - T_{0,k}| \leq \frac{(\ln \frac{1}{v})^{\frac{4}{3}}}{v}$ . So, Lemma 4.8 implies the existence of  $c > 0$  and  $K > 1$  satisfying

$$(4.2.26) \quad L(r_m, t) \geq c \|r_m(t)\|_{H^1}^2 - K v^{4k} \left( \ln \frac{1}{v} \right)^{2c(k)} \exp \left( \frac{2Cv}{\ln \frac{1}{v}} |t - T_{0,k}| \right),$$

while  $|t - T_{0,k}| \leq \frac{(\ln \frac{1}{v})^{\frac{4}{3}}}{v}$ .

Furthermore, using the partial differential equation (4.2.25), we can verify similarly to the Step 1 for constants  $K > 1, c > 0$  that the function  $E(t, r_m)$  satisfies

$$(4.2.27) \quad E(t, r_m) + K v^{4k} \left( \ln \frac{1}{v} \right)^{2c(k)} \exp \left( \frac{2Cv}{\ln \frac{1}{v}} |t - T_{0,k}| \right) \geq c \|r_m(t)\|_{H^1}^2,$$

$$(4.2.28) \quad \dot{E}(t, r_m) \leq K \left[ \frac{v}{\ln \frac{1}{v}} \|r_m(t)\|_{H^1}^2 + \|r_m(t)\|_{H^1} \|r(t)\|_{H^m} + v^{2k+1} \|r_m(t)\|_{H^1} \right],$$

if  $v > 0$  is sufficiently small,  $\|r(t)\|_{H^m} < 1$  and  $|t - T_{0,k}| \leq \frac{(\ln \frac{1}{v})^{\frac{4}{3}}}{v}$ .

From the estimates above and the hypothesis (4.2.1), we can verify inductively for any natural number  $l_1 \leq l$  that there exist numbers  $C, C(l_1) > 1, c(l_1) > 0$  satisfying

$$(4.2.29) \quad \|r(t)\|_{H^{l_1}} \leq C(l_1) v^{2k+1-l_1} \left( \ln \frac{1}{v} \right)^{c(l_1)} \exp \left( \frac{2Cv}{\ln \frac{1}{v}} |t - T_{0,k}| \right),$$

for any  $|t - T_{0,k}| \leq \frac{(\ln \frac{1}{v})^{\frac{4}{3}}}{v}$ , if  $v > 0$  is small enough. Indeed, estimate (4.2.29) was verified for  $l_1 = 1$  in the first step.

Consequently, if (4.2.29) is true for  $1 \leq l_1 \leq m < l$ , then we can verify from the elementary estimate

$$\|r_m(t)\|_{H^1} \|r(t)\|_{H^m} \leq \frac{v}{\ln \frac{1}{v}} \max \left( \|r_m(t)\|_{H^1}, C(m) v^{2k-m} \left( \ln \frac{1}{v} \right)^{c(m)+1} \exp \left( \frac{2C|t - T_{0,k}|}{\ln \frac{1}{v}} \right) \right)^2$$

and estimates (4.2.27), (4.2.28) using Gronwall Lemma that there exist  $C > 1, c(j) > 0$  and  $C_1(m) > 1$  depending on  $j$  such that

$$c \|\partial_x^m r(t)\|_{H^1} \leq C_1(m) v^{2k-m} \left( \ln \frac{1}{v} \right)^{c(j)} \exp \left( \frac{2Cv}{\ln \frac{1}{v}} |t - T_{0,k}| \right),$$

if  $v > 0$  is sufficiently small and  $|t - T_{0,k}| \leq \frac{(\ln \frac{1}{v})^{\frac{4}{3}}}{v}$ . Therefore, since  $\|r(t)\|_{H^{j+1}}$  is equivalent to  $\|r_m(t)\|_{H^1} + \|r(t)\|_{H^m}$ , we conclude that there exists  $C_2(m) > 1$  depending only on  $m$  satisfying

$$\|r(t)\|_{H^{m+1}} \leq C_2(m)v^{2k-m} \left(\ln \frac{1}{v}\right)^{c(l)} \exp\left(\frac{2Cv}{\ln \frac{1}{v}}|t - T_{0,k}|\right),$$

for any  $|t - T_{0,k}| \leq \frac{(\ln \frac{1}{v})^{\frac{4}{3}}}{v}$ , if  $v > 0$  is small enough, and so (4.2.29) is true for any natural number  $l_1 \leq l$  when (4.2.1) is true.

**Step 3.**(Proof of the Weighted Estimates in  $H^1$ .) Let  $r_{j,m}(t, x) := \partial_x^m [x^j r(t, x)]$  for any  $j \in \mathbb{N}$ .

Furthermore, similarly to the proof of estimate (4.1.12), using Taylor's Expansion Theorem, identity

$$(4.2.30) \quad x^j \Lambda \left( P_k(t, x, \sigma_u(t)) + e^{i\gamma_k(t)} r(t, x) \right) = 0,$$

and the estimate  $\|f\|_{L^\infty} \leq K \|f\|_{H^1}$  in any function  $f \in H^1(\mathbb{R})$  for some  $K > 1$ , we can verify from (1.1.1) and the estimate (4.2.24) on  $\|r(t)\|_{H^1}$  that  $r_{j,0}$  satisfies for some constant  $c > 0$ , and a parameter  $c(k, j) > 0$  the following partial differential estimate

$$(4.2.31) \quad \begin{aligned} \partial_t r_{j,0}(t, x) = & i\partial_x^2 r_{j,0}(t, x) - i\omega r_{j,0}(t, x) - j(j-1)ir_{j-2,0}(t, x) + 2ji\partial_x r_{j-1,0}(t, x) \\ & + i \left[ F'(\phi_\omega(x - (\zeta_k + p_\zeta))^2) + F'(\phi_\omega(x + (\zeta_k + p_\zeta))^2) \right] r_{j,0}(t, x) \\ & + iF''(\phi_\omega(x - (\zeta_k + p_\zeta))^2) \phi_\omega(x - (\zeta_k + p_\zeta))^2 r_{j,0}(t, x) \\ & + iF''(\phi_\omega(x + (\zeta_k + p_\zeta))^2) \phi_\omega(x + (\zeta_k + p_\zeta))^2 r_{j,0}(t, x) \\ & + iF''(\phi_\omega(x - (\zeta_k + p_\zeta))^2) \phi_\omega(x - (\zeta_k + p_\zeta))^2 \overline{r_{j,0}(t, x)} e^{2i\alpha(t, x, \sigma_u) - 2i\gamma_k(t)} \\ & + iF''(\phi_\omega(x + (\zeta_k + p_\zeta))^2) \phi_\omega(x + (\zeta_k + p_\zeta))^2 \overline{r_{j,0}(t, x)} e^{2i\alpha(t, -x, \sigma_u) - 2i\gamma_k(t)} \\ & + O\left(v^{2k} \left(\ln \frac{1}{v}\right)^{c(k,j)} + v^2 \left(\ln \frac{1}{v}\right)^c \|r_{j,0}(t)\|_{H^1} + \|r(t)\|_{H^1} \|r_{j,0}(t)\|_{H^1}\right), \end{aligned}$$

for all natural number  $j \geq 1$  and all  $t$  satisfying  $|t - T_{0,k}| \leq \frac{(\ln \frac{1}{v})^{\frac{4}{3}}}{v}$ . The expression associated to  $O$  means a function  $G(t, x)$  satisfying for a  $C > 1$

$$\|G(t, x)\|_{H^1} \leq C \left[ v^{2k} \left(\ln \frac{1}{v}\right)^{c(k,j)} + v^2 \left(\ln \frac{1}{v}\right)^c \|r_{j,0}(t)\|_{H^1} + \|r(t)\|_{H^1} \|r_{j,0}(t)\|_{H^1} \right],$$

if  $|t - T_{0,k}| \leq \frac{(\ln \frac{1}{v})^{\frac{4}{3}}}{v}$  and  $v > 0$  is small enough. Indeed, estimate (4.2.31) is a elementary consequence of the product of  $x^j$  with estimate (4.2.18)

Moreover, from estimate (4.2.24) and identities (4.1.2), (4.1.1), (4.1.3), (4.1.4), we can verify from Cauchy-Schwarz inequality that

$$(4.2.32) \quad \max_{\beta \in \{\zeta, v, \gamma, \omega\}} |\langle r_{j,0}(t), \varphi_{\beta,k}(t, \pm x) \rangle| \leq K v^{2k} \left(\ln \frac{1}{v}\right)^{c_0(k,j)} \exp\left(\frac{Cv}{\ln \frac{1}{v}}|t - T_{0,k}|\right),$$

for some positive constants  $C, K > 1$ , and a number  $c_0(k, j) > 0$  depending only on  $j$  and  $k$ .

Next, considering the functions

$$\begin{aligned}
(4.2.33) \quad L(t, r_{j,0}) &= \int_{\mathbb{R}} |\partial_x r_{j,0}(t, x)|^2 + \omega |r_{j,0}(t, x)|^2 dx \\
&\quad - \int_{\mathbb{R}} F'(\phi_\omega(x - \zeta_k(t))^2) |r_{j,0}(t, x)|^2 + F'(\phi_\omega(x + \zeta_k(t))^2) |r_{j,0}(t, x)|^2 dx \\
&\quad - \operatorname{Re} \int_{\mathbb{R}} F''(\phi_\omega(x - \zeta_k(t))^2) \phi_\omega(x - \zeta_k(t))^2 e^{2i\alpha_k(t, x)} \overline{r_{j,0}(t, x)^2} e^{-2i\gamma_k(t)} dx \\
&\quad - \operatorname{Re} \int_{\mathbb{R}} F''(\phi_\omega(x + \zeta_k(t))^2) \phi_\omega(x + \zeta_k(t))^2 e^{2i\alpha_k(t, -x)} \overline{r_{j,0}(t, x)^2} e^{-2i\gamma_k(t)} dx \\
&\quad - \int_{\mathbb{R}} F''(\phi_\omega(x - \zeta_k(t))^2) \phi_\omega(x - \zeta_k(t))^2 |r_{j,0}(t, x)|^2 dx \\
&\quad - \int_{\mathbb{R}} F''(\phi_\omega(x + \zeta_k(t))^2) \phi_\omega(x + \zeta_k(t))^2 |r_{j,0}(t, x)|^2 dx,
\end{aligned}$$

and

$$(4.2.34) \quad P_1(t, r_{j,0}) := \operatorname{Im} \int_{\mathbb{R}} \chi_1(t, x) \overline{r_{j,0}(t, x)} \partial_x r_{j,0}(t, x) dx, \quad P_2(t, r_{j,0}) := \operatorname{Im} \int_{\mathbb{R}} \chi_2(t, x) \overline{r_{j,0}(t, x)} \partial_x r_{j,0}(t, x) dx,$$

we can verify similarly to the proof of estimate (4.2.21) that the Lyapunov function

$$E(t, r_{j,0}) = L(t, r_{j,0}) - \dot{d}(t)P_2(t, r_{j,0}) + \dot{d}(t)P_1(t, r_{j,0})$$

satisfies

$$\begin{aligned}
(4.2.35) \quad |\dot{E}(t, r_{j,0})| &= O\left(v^{2k} \left(\ln \frac{1}{v}\right)^{c(k,j)} \|r_{j,0}(t)\|_{H^1} + \frac{v}{\ln \frac{1}{v}} \|r_{j,0}(t)\|_{H^1}^2 + \|r_{j,0}(t)\|_{H^1} \|r(t)\|_{H^1}^2 \right. \\
&\quad \left. + j(j-1) \|r_{j,0}(t)\|_{H^1} \|r_{j-2,0}(t)\|_{H^1} + j \|r_{j,0}(t)\|_{H^1} \|r_{j-1,0}(t)\|_{H^2} \right),
\end{aligned}$$

if  $|t - T_{0,k}| \leq \frac{(\ln \frac{1}{v})^{\frac{4}{3}}}{v}$ ,  $0 \leq j \leq l$  and  $v > 0$  is small enough.

Moreover, using the estimates (4.2.32), we can verify similarly to the proof of Lemma 4.7 from Lemma 2.12 that there exists  $K > 1$  satisfying

$$(4.2.36) \quad E(t, r_{j,0}) + Kv^{4k} \left(\ln \frac{1}{v}\right)^{2c_0(k,j)} \exp\left(\frac{2Cv}{\ln \frac{1}{v}} |t - T_{0,k}|\right) \geq \|r_{j,0}(t)\|_{H^1}^2.$$

Furthermore, motivated by the estimates (4.2.35) and (4.2.36), we are going to verify in the next step by induction on  $j$  for any  $j \in \mathbb{N}_{\leq l+1}$ ,  $m \in \mathbb{N}_{\leq l+1-j}$  satisfying that there exist numbers  $C > 1$ ,  $C_{j+m} > 1$ ,  $c_{j+m} > 0$  satisfying

$$(4.2.37) \quad \|r_{j,0}(t)\|_{H^m} \leq C_{j+m} v^{2k - (2j+m)+1} \left(\ln \frac{1}{v}\right)^{c_{j+m}} \exp\left(C \frac{v|t - T_{0,k}|}{\ln \frac{1}{v}}\right),$$

for all  $|t - T_{0,k}| \leq \frac{(\ln \frac{1}{v})^{\frac{4}{3}}}{v}$ , if  $v > 0$  is sufficiently small.

Indeed if for a natural number  $j_0 < l$  the (4.2.37) is true for any  $0 \leq j \leq j_0$ , then, using estimate (4.2.35) for  $j = j_0 + 1$ , we obtain that

$$|\dot{E}(t, r_{j_0+1,0})| = O\left(\frac{v}{\ln \frac{1}{v}} \|r_{j_0+1,0}(t)\|_{H^1}^2 + v^{2k-2j_0-1} \left(\ln \frac{1}{v}\right)^{c_{j_0+2}} \exp\left(C \frac{v|t - T_{0,k}|}{\ln \frac{1}{v}}\right) \|r_{j_0+1,0}(t)\|_{H^1}\right),$$

from which we would obtain using Gronwall Lemma similarly to the approach in Step 1 that there exist  $K, C_2 > 1$  such that

$$(4.2.38) \quad \|x^{j_0+1}r(t, x)\|_{H^1} = \|r_{j,0}(t)\|_{H^1} \leq Kv^{2k-2j_0-2} \left(\ln \frac{1}{v}\right)^{c_{j_0+2+1}} \exp\left(C_2 \frac{v|t-T_{0,k}|}{\ln \frac{1}{v}}\right),$$

while  $|t - T_{0,k}| \leq \frac{(\ln \frac{1}{v})^{\frac{4}{3}}}{v}$ .

**Step 4.**(Proof of (4.2.37).) The estimate (4.2.37) for  $j = 0$  was already proved in Step 2, so we can assume that (4.2.37) is true when  $0 \leq j \leq j_0 < l$  for some natural number  $j_0 \geq 0$ . Indeed if it is true for any  $0 \leq j \leq l$ , there is nothing more to prove.

Moreover, from the last argument in Step 3, we verified that if (4.2.37) is true for all natural number  $j$  satisfying  $0 \leq j \leq j_0$ , then (4.2.38) is true for all  $|t - T_{0,k}| \leq \frac{(\ln \frac{1}{v})^{\frac{4}{3}}}{v}$ . Therefore, there is a maximum  $m_0 \geq 1$  such that

$$(4.2.39) \quad \|x^{j_0+1}r(t, x)\|_{H^m} = \|r_{j_0+1,0}(t)\|_{H^m} \leq Kv^{2k-2j_0-2-m+1} \left(\ln \frac{1}{v}\right)^{c_{j_0+2+1}} \exp\left(C_2 \frac{v|t-T_{0,k}|}{\ln \frac{1}{v}}\right),$$

is true while  $|t - T_{0,k}| \leq \frac{(\ln \frac{1}{v})^{\frac{4}{3}}}{v}$  for all natural  $m$  satisfying  $1 \leq m \leq m_0$ . If  $m_0 \geq l - j_0 + 1$ , then (1.0.12) would be true for any  $0 \leq j \leq j_0 + 1$ . Consequently, to prove (1.0.12) for any  $j = j_0 + 1$ , it is enough to verify that if (4.2.39) is true for any  $0 < m \leq m_0 < l - j_0 + 1$ , then it is true for  $m_0 + 1$ .

Next, we recall the function  $r_{j,m}(t, x) = \partial_x^m [x^j r(t, x)]$ . Since  $F$  is a polynomial satisfying (H1), using Taylor's Expansion Theorem, (1.1.1), and the product rule of derivative, we can verify from the derivative of (4.2.18) on  $x$  that

$$(4.2.40) \quad \begin{aligned} \partial_t r_{j_0+1, m_0}(t, x) = & i\partial_x^2 r_{j_0+1, m_0}(t, x) - i\omega r_{j_0+1, m_0}(t, x) \\ & - j_0(j_0 + 1)ir_{j_0-1, m_0}(t, x) + 2(j_0 + 1)i\partial_x r_{j_0, m_0}(t, x) \\ & + i \left[ F'(\phi_\omega(x - (\zeta_k + p_\zeta))^2) + F'(\phi_\omega(x + (\zeta_k + p_\zeta))^2) \right] r_{j_0+1, m_0}(t, x) \\ & + iF''(\phi_\omega(x - (\zeta_k + p_\zeta))^2) \phi_\omega(x - (\zeta_k + p_\zeta))^2 r_{j_0+1, m_0}(t, x) \\ & + iF''(\phi_\omega(x + (\zeta_k + p_\zeta))^2) \phi_\omega(x + (\zeta_k + p_\zeta))^2 r_{j_0+1, m_0}(t, x) \\ & + iF''(\phi_\omega(x - (\zeta_k + p_\zeta))^2) \phi_\omega(x - (\zeta_k + p_\zeta))^2 \overline{r_{j_0+1, m_0}(t, x)} e^{2i\alpha(t, x, \sigma_u) - 2i\gamma_k(t)} \\ & + iF''(\phi_\omega(x + (\zeta_k + p_\zeta))^2) \phi_\omega(x + (\zeta_k + p_\zeta))^2 \overline{r_{j_0+1, m_0}(t, x)} e^{2i\alpha(t, -x, \sigma_u) - 2i\gamma_k(t)} \\ & + O\left(v^{2k} \left(\ln \frac{1}{v}\right)^{c(k, j_0, m_0)} + v^2 \left(\ln \frac{1}{v}\right)^c \|r_{j_0+1, 0}(t)\|_{H^{m_0+1}}\right) \\ & + O\left(\max_{d_1+d_2=m_0+2, \min(d_1, d_2) \geq 1} \|r(t)\|_{H^{d_1}} \|r_{j_0+1, 0}(t)\|_{H^{d_2}} + \|r_{j_0+1, 0}(t)\|_{H^{m_0}}\right), \end{aligned}$$

where  $c(k, j_0, m_0) > 0$  is a number depending on  $k, j_0, m_0$ , while  $|t - T_{0,k}| \leq \frac{(\ln \frac{1}{v})^{\frac{4}{3}}}{v}$  and  $v > 0$  is small enough. The expression inside  $O$  in (4.2.31) means a function  $G(t, x)$  satisfying for some constant  $C > 1$

$$\begin{aligned} \|G(t, x)\|_{H^1} \leq & C \left[ v^{2k} \left(\ln \frac{1}{v}\right)^{c(k, j_0, m_0)} + v^2 \left(\ln \frac{1}{v}\right)^c \|r_{j_0+1, 0}(t)\|_{H^{m_0+1}} \right] \\ & + C \left[ \max_{d_1+d_2=m_0+2, \min(d_1, d_2) \geq 1} \|r(t)\|_{H^{d_1}} \|r_{j, 0}(t)\|_{H^{d_2}} + \|r_{j_0+1, 0}(t)\|_{H^{m_0}} \right], \end{aligned}$$



while  $|t - T_{0,k}| \leq \frac{(\ln \frac{1}{v})^{\frac{4}{3}}}{v}$ .

Therefore, if (4.2.39) is true for  $m = m_0$ , we deduce that there exists  $C > 1$  satisfying

$$\begin{aligned} \|G(t, x)\|_{H^1} &\leq C \left[ v^{2k} \left( \ln \frac{1}{v} \right)^{c(k, j_0, m_0)} + v^2 \left( \ln \frac{1}{v} \right)^c \|r_{j_0+1,0}(t)\|_{H^{m_0+1}} \right] \\ &\quad + C \left[ \max_{d_1+d_2=m_0+2, \min(d_1, d_2) \geq 1} \|r(t)\|_{H^{d_1}} \|r_{j,0}\|_{H^{d_2}} \right] \\ &\quad + C \left[ v^{2k-2j_0-1-m_0} \left( \ln \frac{1}{v} \right)^{c_{j_0+2}+1} \exp \left( C_2 \frac{v|t - T_{0,k}|}{\ln \frac{1}{v}} \right) \right], \end{aligned}$$

Consequently, similarly to the proof of estimates of (4.2.35), (4.2.36), if  $0 \leq m \leq l - j_0$ , we can verify using estimates (4.2.29), (4.2.37), and the partial differential equation (4.2.40) that if  $k \geq k_0$  is large enough, then

$$\begin{aligned} (4.2.41) \quad |\dot{E}(t, r_{j_0+1, m_0})| &= O \left( v^{2k-2j_0-1-m_0} \left( \ln \frac{1}{v} \right)^{c_{j_0+2}+1} \exp \left( C_2 \frac{v|t - T_{0,k}|}{\ln \frac{1}{v}} \right) \|r_{j_0+1, m_0}(t)\|_{H^1} \right. \\ &\quad \left. + \frac{v}{\ln \frac{1}{v}} \|r_{j_0+1, m_0}(t)\|_{H^1}^2 + j_0(j_0 + 1) \|r_{j_0-1, m_0}(t)\|_{H^1} \|r_{j_0+1, m_0}(t)\|_{H^1} \right. \\ (4.2.42) \quad &\quad \left. + (j_0 + 1) \|r_{j_0, m_0}(t)\|_{H^2} \|r_{j_0+1, m_0}(t)\|_{H^1} \right), \end{aligned}$$

and

$$(4.2.43) \quad E(t, r_{j_0+1, m_0}) + K v^{4k} \left( \ln \frac{1}{v} \right)^{2c(k, j_0+1)} \exp \left( \frac{2Cv}{\ln \frac{1}{v}} |t - T_{0,k}| \right) \geq \|r_{j_0+1, m_0}(t)\|_{H^1}^2,$$

for some number  $c(k, j_0 + 1) > 0$ , and all  $|t - T_{0,k}| \leq \frac{(\ln \frac{1}{v})^{\frac{4}{3}}}{v}$ , if  $v > 0$  is small enough.

Furthermore, from the estimates (4.2.37) for  $j \leq j_0$ , we deduce from (4.2.37) that

$$(4.2.44) \quad |\dot{E}(t, r_{j_0+1, m_0})| = O \left( \frac{v}{\ln \frac{1}{v}} \|r_{j_0+1, m_0}(t)\|_{H^1}^2 + \|r_{j_0+1, m_0}(t)\|_{H^1} v^{2k-2j_0-m_0-1} \left( \ln \frac{1}{v} \right)^{c_{j,m}} \exp \left( C \frac{v|t - T_{0,k}|}{\ln \frac{1}{v}} \right) \right),$$

for some constant  $c_{j_0, m}$  while  $|t - T_{0,k}| \leq \frac{(\ln \frac{1}{v})^{\frac{4}{3}}}{v}$ .

In conclusion, using the assumption (4.2.1), and estimates (4.2.43), (4.2.44), we obtain using Gronwall Lemma in the same way we used in Step 1 that there exist constants  $K_{m_0} > 1$ ,  $C_2 > 1$ ,  $c_{j_0, m_0} > 0$  satisfying

$$\left\| \partial_x^m [r(t)x^{j_0+1}] \right\|_{H^1} \leq K_{m_0} v^{2k-2j_0-m_0-2} \left( \ln \frac{1}{v} \right)^{c_{j_0, m_0}+1} \exp \left( C_2 \frac{v|t - T_{0,k}|}{\ln \frac{1}{v}} \right),$$

for any natural number  $m \leq m_0$ , if  $|t - T_{0,k}| \leq \frac{(\ln \frac{1}{v})^{\frac{4}{3}}}{v}$  and  $v > 0$  is small enough. The estimate above implies that (4.2.37) is true for  $j = j_0 + 1$ , so it is true for all  $j \in \mathbb{N}_{\leq l}$  when  $v > 0$  is sufficiently small, which implies (4.2.3) when  $j = l$  and  $m = 1$ .  $\square$

## 5. ORBITAL STABILITY OF TWO SOLITARY WAVES

The main objective of this section is to prove the following result.

**Theorem 5.1.** *There exists  $C > 1$  and  $\delta \in (0, 1)$  such that if  $0 < v_0 < \delta$ , and  $\zeta_0 > \frac{16}{\sqrt{\omega}} \ln \frac{1}{v}$ , and  $r_{j,1} \in H^1(\mathbb{R})$  is an odd function satisfying  $\|r_{j,1}\|_{H^1} < v_0^5$ , then the solution  $\psi(t, x)$  of the following*

*Initial Value Problem*

$$\begin{cases} i\psi_t + \psi_{xx} + F'(|\psi|^2)\psi = 0, \\ \psi(0, x) = e^{i\gamma_0} \left( e^{-iv_0 \frac{x}{2}} \phi_\omega(x - \zeta_0) - e^{iv_0 \frac{x}{2}} \phi_\omega(x + \zeta_0) \right) + r_{j,1}(x) \end{cases}$$

satisfies

$$(5.0.1) \quad \psi(t, x) = e^{i\left(\gamma(t) + \omega t - \frac{v_0 \zeta(t)}{4}\right)} \left( e^{-i\frac{v_0}{2}\left(x - \frac{\zeta(t)}{2}\right)} \phi_\omega(x - \zeta(t)) - e^{i\frac{v_0}{2}\left(x + \frac{\zeta(t)}{2}\right)} \phi_\omega(x + \zeta(t)) \right) + r(t, x),$$

such that

$$(5.0.2) \quad \begin{aligned} |\dot{\gamma}(t)| + |\dot{\zeta}(t) + v_0| &\leq C \left[ e^{-\sqrt{\omega}\zeta_0} + \|r_{j,1}\|_{H^1} \right], \\ \|r(t)\|_{H^1} &\leq C \left[ \|r_{j,1}\|_{H^1} + e^{-\frac{\sqrt{\omega}}{2}\zeta_0} \right], \end{aligned}$$

for any  $t \leq 0$ .

**Remark 5.2.** *The proof of Theorem 5.1 is completely similar to the demonstration of the Theorem 1.3 from the paper [24]. More precisely, we will use the monotonicity of the energy, mass, and momentum of the solution on the half-line as it was done in [24].*

The Theorem 5.1 will allow us to analyze the dynamics of the two colliding solitons when the time  $t$  approaches  $-\infty$ , and, consequently, we will be able to conclude the proof of Theorem 1.5.

**Lemma 5.3.** *Let*

$$\phi_{\omega,\pm}(x) = e^{i\omega t} e^{i\frac{\pm vx}{2}} \phi_\omega(x).$$

For any function  $r \in H^1(\mathbb{R}, \mathbb{C})$ , we have that

$$\left\langle H'(\phi_{\omega,\pm}) + \left(\omega + \frac{v^2}{4}\right) \frac{Q'(\phi_{\omega,\pm})}{2} \mp \frac{v}{2} M'(\phi_{\omega,\pm}), r \right\rangle = 0.$$

*Proof of Lemma 5.3.* It is enough to prove Lemma 5.3 for  $\phi_{\omega,+}$ , the proof for  $\phi_{\omega,-}$  is analogous. First, from the definition of  $\phi_{\omega,+}$ , we have the following identity

$$(5.0.3) \quad \begin{aligned} - \int_{\mathbb{R}} \partial_x^2 \phi_{\omega,+}(x) \overline{r(x)} dx &= - \int_{\mathbb{R}} e^{i\left(\omega t + \frac{vx}{2}\right)} \phi_\omega''(x) \overline{r(x)} dx - iv \int_{\mathbb{R}} e^{i\left(\omega t + \frac{vx}{2}\right)} \phi_\omega'(x) \overline{r(x)} dx \\ &\quad + \frac{v^2}{4} \int_{\mathbb{R}} \phi_{\omega,+}(x) \overline{r(x)} dx. \end{aligned}$$

Moreover, using the dot product (1.0.17), from the definitions of (Hamiltonian), (Mass) and (Momentum), we can verify using integration by parts for any  $r \in H^1(\mathbb{R}, \mathbb{C})$  that

$$\begin{aligned} \langle H'(\phi_{\omega,+}), r(x) \rangle &= \langle -\partial_x^2 \phi_{\omega,+}(x) - F'(\phi_\omega(x)^2) \phi_{\omega,+}, r(x) \rangle, \\ \langle Q'(\phi_{\omega,+}), r \rangle &= 2 \langle \phi_\omega(x) e^{i\left(\omega t + \frac{vx}{2}\right)}, r(x) \rangle, \\ \langle M'(\phi_{\omega,+}), r \rangle &= \langle -2i\phi_\omega'(x) e^{i\left(\omega t + \frac{vx}{2}\right)} + v\phi_\omega(x) e^{i\left(\omega t + \frac{vx}{2}\right)}, r(x) \rangle. \end{aligned}$$

Therefore, using

$$-\phi_\omega''(x) + \omega\phi_\omega(x) - F'(\phi_\omega(x)^2)\phi_\omega(x) = 0,$$

and the identities above, we obtain the result of Lemma 5.3.  $\square$

Furthermore, before the start of the proof of Theorem 5.1, we also need to analyze the properties of the following localized quantities:

$$\begin{aligned} \text{(Half-Mass)} \quad & Q^+(\psi) = \int_0^{+\infty} |\psi(x)|^2 dx, \\ \text{(Half-Energy)} \quad & H^+(\psi) = \int_0^{+\infty} \frac{|\psi_x(x)|^2}{2} - \frac{F(|\psi(x)|^2)}{2} dx, \\ \text{(Half-Momentum)} \quad & M^+(\psi) = \text{Im} \int_0^{+\infty} \psi_x \bar{\psi} dx. \end{aligned}$$

First, using the fact that we are considering odd solutions of the partial differential equation (1.0.1), we can verify that  $H^+(\psi(t)) = \frac{1}{2}H(\psi)$  and  $Q^+(\psi(t)) = \frac{1}{2}Q(\psi)$ , therefore they are constant functions on  $t$ . Moreover, the oddness of the function  $\psi$  also implies that  $M^+(\psi(t))$  is a non-decreasing function on  $t$ . Consequently, we have the following proposition:

**Lemma 5.4.** *The functions  $M^+$ ,  $H^+$ ,  $Q^+$  satisfy for every  $t \in \mathbb{R}$ :*

$$\begin{aligned} Q^+(\psi(t)) &= Q^+(\psi(0)), \quad H^+(\psi(t)) = H^+(\psi(0)), \\ \frac{d}{dt}M^+(\psi(t)) &\geq 0. \end{aligned}$$

*Proof.* The conservation of  $Q^+(\psi(t))$  and  $H^+(\psi(t))$  was already explained in the last paragraph. Next, using the time derivative of  $M^+(\psi(t))$ , identity  $\psi(t, 0) = 0$  and integration by parts, we deduce that if  $\psi(t)$  is an odd solution of (1.0.1) belonging to  $C(\mathbb{R}, H^2(\mathbb{R}))$ , then

$$\frac{d}{dt}M^+(\psi(t)) = \frac{|\psi_x(t, 0)|^2}{2} \geq 0.$$

Therefore,  $\frac{dM^+(\psi(t))}{dt} \geq 0$  follows from the density of  $H_x^2(\mathbb{R})$  in  $H_x^1(\mathbb{R})$  and the local well-posedness of the partial differential equation (1.0.1) in  $H_x^s(\mathbb{R})$  for  $s \geq 1$ .  $\square$

The next important results we need to prove Theorem 5.1 are the estimates of the functions  $M^+$ ,  $H^+$ ,  $Q^+$  around a small perturbation of two solitons separated with a large distance and each one of them moving with low speed.

Next, to simplify our notation, we consider the following bilinear form

$$\langle f, g \rangle_{L^2(0, +\infty)} := \text{Re} \int_0^{+\infty} f(x) \overline{g(x)} dx.$$

**Lemma 5.5.** *Let*

$$\begin{aligned} \psi(x) &= e^{i\gamma} \left( e^{-i\frac{\omega x}{2}} \phi_\omega(x - \zeta) - e^{i\frac{\omega x}{2}} \phi_\omega(x + \zeta) \right) + r(x) \\ &= \text{Sym}(\phi_{\omega, \sigma})(x) + r(x), \end{aligned}$$

such that  $r \in H_x^1(\mathbb{R})$  is an odd function, and  $\omega > 0$  satisfies

$$Q(\phi_\omega) = Q^+(\psi) = \frac{Q(\psi)}{2}.$$

Then, there exists  $\delta \in (0, 1)$  such that if  $0 < v < \delta$  and  $\zeta > \delta^{-1}$ , then

(5.0.4)

$$\langle r, \phi_{\omega, \sigma} \rangle_{L^2(0, +\infty)} = O(\zeta e^{-2\sqrt{\omega}\zeta} + \|r\|_{L^2}^2),$$

$$(5.0.5) \quad H^+(\psi) = H(\phi_{\omega, \sigma}) + \left\langle H'(\phi_{\omega, \sigma}), r \right\rangle_{L^2(0, +\infty)} + \frac{1}{2} \left\langle D^{(2)}H(\phi_{\omega, \sigma})r, r \right\rangle_{L^2(0, +\infty)} \\ + O\left(\|r\|_{H^1}^3 + e^{-\sqrt{\omega}\zeta} \|r\|_{H^1} + \zeta e^{-2\sqrt{\omega}\zeta}\right),$$

$$(5.0.6) \quad M^+(\psi) = \frac{v}{2} \|\phi_{\omega, \sigma}\|_{L^2}^2 + \left\langle M'(\phi_{\omega, \sigma}), r(x) \right\rangle_{L^2(0, +\infty)} + M^+(r) + O\left(e^{-\sqrt{\omega}\zeta} \|r\|_{H^1} + e^{-2\sqrt{\omega}\zeta}\right).$$

*Proof.* First, from the estimates

$$(5.0.7) \quad \left| \frac{d^l}{dx^l} \phi_{\omega}(x) \right| = O(e^{-\sqrt{\omega}|x|}),$$

we deduce that if  $x \geq 0$ , then

$$(5.0.8) \quad \left| \frac{\partial^l}{\partial x^l} \phi_{\omega}(x + \zeta) \right| = O\left(e^{-\sqrt{\omega}\zeta}\right).$$

Next, since  $r$  and  $\psi$  are odd functions, we can verify from the definition of (Half-Mass) the following identity

$$(5.0.9) \quad Q^+(\psi) = Q^+(Sym(\phi_{\omega, \sigma})) + 2 \langle Sym(\phi_{\omega, \sigma}), r \rangle_{L^2(0, +\infty)} + \frac{1}{2} \|r\|_{L^2}^2.$$

Moreover, using Lemma 2.1 and estimate (5.0.7), we have that

$$Q^+(Sym(\phi_{\omega, \sigma})) = Q(\phi_{\omega}) + O\left(\zeta e^{-2\sqrt{\omega}\zeta}\right).$$

Consequently, since we are assuming that  $Q(\phi_{\omega}) = Q(u)$ , the estimate (5.0.4) proceeds from the identity above with (5.0.9).

Next, from (5.0.8), we can also verify from the Fundamental Theorem of Calculus that

$$(5.0.10) \quad \int_0^{+\infty} |\phi_{\omega}(x + \zeta)|^2 + \left| \frac{d}{dx} \phi_{\omega}(x + \zeta) \right|^2 dx = O(e^{-2\sqrt{\omega}\zeta}).$$

There, we can verify using Cauchy-Schwarz inequality that

$$(5.0.11) \quad \left| \int_0^{+\infty} |r|^l \phi_{\omega}(x + \zeta)^m \right| = O(\|r\|_{H^1} e^{-\sqrt{\omega}\zeta}),$$

for all  $l$ , and  $m$  in  $\mathbb{N}_{\geq 1}$ . Consequently, using (5.0.10) and (5.0.11), we obtain the estimate (5.0.5) from Taylor's Expansion Theorem applied on  $H^+(u)$  around  $\eta_{\sigma}$ .

Finally, the estimates (5.0.6) and (5.0.5) follow from the Taylor's Expansion Theorem applied to  $M^+(u)$  and  $H^+(u)$  around  $\phi_{\omega, \sigma}$  and from the estimates (5.0.11), (5.0.10), (5.0.8).  $\square$

From now on, we are going to start the proof of the main result of the section.

*Proof of Theorem 5.1.* We can rewrite  $u(0, x)$  as

$$\psi(0, x) = e^{i\gamma_0} \left( e^{i\frac{-v_0 x}{2}} \phi_{\omega}(x - \zeta_0) - e^{i\frac{v_0 x}{2}} \phi_{\omega}(x + \zeta_0) \right) + r(x),$$

such that  $Q(\psi(0)) = 2Q(\phi_{\omega})$ , and  $r$  is an odd function in  $H^1(\mathbb{R})$  satisfying  $\|r\|_{H^1} \lesssim \|r_{j,1}\|_{H^1}$ .

Furthermore, since the partial differential equation (1.0.1) is locally well-posed in  $H^1(\mathbb{R})$ , see Chapter 3 of the book [35], we have that there exists  $T < 0$  such that

$$\psi(t, x) = e^{i\gamma_0} \left( e^{i\frac{-v_0 x}{2}} \phi_{\omega}(x - \zeta_0) - e^{i\frac{v_0 x}{2}} \phi_{\omega}(x + \zeta_0) \right) + r(t, x),$$

and  $\|r(t)\|_{H^1} < v^2$ , if  $t \in [T, 0]$ . Therefore, the following set

$$B = \left\{ t < 0 \mid \inf_{y > \frac{8}{\sqrt{\omega}} \ln \frac{1}{v_0}, \gamma \in \mathbb{R}} \left\| \psi(t) - \text{Sym} \left( e^{i(\gamma - \frac{v_0(\cdot)}{2})} \phi_\omega(\cdot - y) \right) (x) \right\|_{H^1(\mathbb{R})} < v_0^2 \right\}$$

is not empty.

Furthermore, using the Implicit Function Theorem for Banach spaces, see Section 3.1 from [16], if an interval  $(t, 0) \subset B$ , we can verify the existence of real functions of class  $C^1$   $\zeta(t) > \frac{8}{\sqrt{\omega}} \ln \frac{1}{v_0}$ ,  $\gamma(t)$  such that

$$\psi(s, x) = e^{i\gamma(s)} \left( e^{i\frac{-v_0x}{2}} \phi_\omega(x - \zeta(s)) - e^{i\frac{v_0x}{2}} \phi_\omega(x + \zeta(s)) \right) + r_1(s, x),$$

and  $r_1$  is an odd function in  $H_x^1(\mathbb{R})$  satisfying

$$(5.0.12) \quad \left\langle e^{i(\gamma(s) \mp \frac{v_0x}{2})} (x \mp \zeta(s)) \phi_\omega(x \mp \zeta(s)), r_1(s) \right\rangle = 0,$$

$$(5.0.13) \quad \left\langle i e^{i(\gamma(s) \mp \frac{v_0x}{2})} \partial_\omega \phi_\omega(x \mp \zeta(s)), r_1(s) \right\rangle = 0,$$

and

$$\|r_1(s)\|_{H^1(\mathbb{R})} \leq C \inf_{y \geq \frac{7}{\sqrt{\omega}} \ln \frac{1}{v}} \left\| \psi(t) - \text{Sym} \left( e^{i(\gamma(s) - \frac{v_0(\cdot)}{2})} \phi_\omega(\cdot - y) \right) \right\|_{H^1(\mathbb{R})},$$

for all  $s \in [t, 0)$ , where  $C > 1$  is a constant.

From now on, we are going to prove that  $B = \mathbb{R}_{<0}$ . Moreover, we consider for any  $t > 0$  the following function

$$\mathcal{M}(\psi)(t) := H^+(\psi)(-t) + \left( \omega + \frac{v_0^2}{4} \right) \frac{Q^+\psi(-t)}{2} - \frac{v_0}{2} M^+(\psi)(-t),$$

First, Lemma 5.4 implies that

$$\mathcal{M}(\psi)(t) \leq \mathcal{M}(\psi)(0).$$

Furthermore, using Lemma 5.3, estimates (5.0.10), (5.0.11) and Taylor's Expansion Theorem, we can verify that

$$(5.0.14) \quad \begin{aligned} \mathcal{M}(\psi)(t) = & \mathcal{M}(\phi_\omega(x)) + \left\langle -\partial_x^2 r_1(t, x) + \omega r_1 - F'(\phi_\omega(x - \zeta(t))^2) r_1(t, x) \right. \\ & - F''(\phi_\omega(x - \zeta(t))^2) \phi_\omega(x - \zeta(t)) e^{i(\gamma(t) - \frac{v_0x}{2})} \overline{r_1(t, x)} \\ & \left. - F''(\phi_\omega(x - \zeta(t))^2) \phi_\omega(x - \zeta(t)) e^{-i(\gamma(t) - \frac{v_0x}{2})} r_1(t, x) \right\rangle_{L^2(0, +\infty)} \\ & + O\left(\|r_1(t)\|_{H^1}^2 (e^{-\sqrt{\omega}\zeta(t)} + v_0) + \|r_1(t)\|_{H^1}^3 + \zeta(t) e^{-2\sqrt{\omega}\zeta(t)}\right), \end{aligned}$$

while  $t$  is in  $B$ . Consequently, since  $r_1$  satisfies the orthogonality conditions (5.0.12) and (5.0.13), and Lemma 5.5 implies that

$$\left\langle r_1(t), e^{i(\gamma(t) - \frac{v_0x}{2})} \phi_\omega(x - \zeta(t)) \right\rangle = O\left(\max\{\|r_1(t)\|_{H^1}^2, \zeta(t) e^{-2\sqrt{\omega}\zeta(t)}\}\right),$$

we can deduce from Remark 2.13 of Lemma 2.12 the existence of constants  $C, c > 0$  independent of  $v_0$  satisfying

$$\mathcal{M}(\psi)(t) + C\zeta(t) e^{-2\sqrt{\omega}\zeta(t)} \geq \mathcal{M}(\phi_\omega(x)) + c\|r_1(t)\|_{H^1}^2,$$

while  $t$  is in  $B$ . Therefore, since  $\mathcal{M}(\psi)(t) \leq \mathcal{M}(\psi)(0)$  and  $\psi(0)$  satisfies the hypotheses of Theorem 5.1, we obtain the following inequality

$$(5.0.15) \quad C\|r_{j,1}\|_{H^1}^2 + C e^{-\sqrt{\omega}\zeta_0} + C e^{-\sqrt{\omega}\zeta(t)} \geq \|r_1(t)\|_{H^1}^2,$$

for some constant  $C > 0$ , while  $t < 0$  is an element of  $B$ .

Moreover, using identity  $\Lambda(\psi) = 0$  and Lemma 2.1, we can verify that

$$\begin{aligned}
i\partial_t r_1 + \partial_x^2 r_1 &= \left( \dot{\gamma}(t) - \omega - \frac{v_0 \dot{\zeta}(t)}{4} \right) \text{Sym} \left( e^{i(\gamma(t) - \frac{v_0 \zeta(t)}{2})} \phi_\omega(\cdot - \zeta(t)) \right) (x) \\
&\quad + i(\dot{\zeta}(t) + v_0) \text{Sym} \left( e^{i(\gamma(t) - \frac{v_0 \zeta(t)}{2})} \phi'_\omega(\cdot - \zeta(t)) \right) (x) \\
&\quad - F'(\phi_\omega(x - \zeta(t))^2 + \phi_\omega(x + \zeta(t))^2) r_1(t, x) \\
&\quad - F''(\phi_\omega(x - \zeta(t))^2) \phi_\omega(x - \zeta(t)) e^{i(\gamma(t) - \frac{v_0 x}{2})} \overline{r_1(t, x)} \\
&\quad - F''(\phi_\omega(x - \zeta(t))^2) \phi_\omega(x - \zeta(t)) e^{-i(\gamma(t) - \frac{v_0 x}{2})} r_1(t) \\
&\quad + O \left( e^{-2\sqrt{\omega}y(t)} + \|r_1(t)\| \zeta(t) e^{-2\sqrt{\omega}\zeta(t)} + \|r_1(t)\|_{H^1}^2 \right).
\end{aligned}$$

Consequently, from the time derivative of the orthogonality conditions (5.0.12) and (5.0.13), we obtain the existence of a constant  $C > 0$  satisfying the following estimates

$$(5.0.16) \quad \left| \dot{\gamma}(t) - \omega + \frac{v_0^2}{4} \right| < C \left[ \|r_1(t)\|_{H^1} + e^{-2\sqrt{\omega}\zeta(t)} \right],$$

$$(5.0.17) \quad |\dot{\zeta}(t) + v_0| \leq C \left[ \|r_1(t)\|_{H^1} + e^{-2\sqrt{\omega}\zeta(t)} \right],$$

while  $t$  is in  $B$ .

In particular, from the definition of the set  $B$ , we have that if  $v_0 > 0$  is sufficiently small, the estimate (5.0.17) implies that  $\dot{\zeta}(t) > \frac{3}{4}v_0 > 0$ , while  $t$  is in  $B$ . Therefore  $\zeta(t) > \zeta(0)$  for any  $t < 0$  in  $B$ , from which, using estimate (5.0.15), we deduce that

$$(5.0.18) \quad \|r_1(t)\|_{H^1}^2 \leq C \|r_{j,1}\|_{H^1}^2 + C e^{-\sqrt{\omega}\zeta_0} < v_0^2,$$

$$\zeta(t) > \zeta(0) \geq \frac{8}{\sqrt{\omega}} \ln \frac{1}{v_0}.$$

Consequently, since  $\|r_1(t)\|_{H^1}$ ,  $\zeta(t)$  are continuous functions on  $t$ , we can verify similarly as in the Step 6 of the proof of Theorem 1.3 from [24] that  $B$  is equal to  $\mathbb{R}_{<0}$  and that estimate (5.0.18) is true for all  $t \leq 0$ . The estimates (5.0.2) follows from (5.0.16) and (4.3) using (5.0.18).  $\square$

## 6. PROOF OF THEOREM 1.5

From now on, let  $u$  be the unique solution of (1.0.1) satisfying (1.0.9) for  $v_1 = 0$ . From Theorems 1.10, 3.1 and Remark 1.10, we can verify for any  $l \in \mathbb{N}$  that there exist  $k \in \mathbb{N}$  sufficiently large and  $v > 0$  small enough that there exists  $T_{0,k} \in \mathbb{R}$  satisfying  $\frac{(\ln \frac{1}{v})^{\frac{4}{3}}}{20v} < T_{0,k} < \frac{(\ln \frac{1}{v})^{\frac{4}{3}}}{10v}$  and there exists  $t_0$  satisfying  $|t_0| \leq C_0 \frac{\ln \frac{1}{v}}{v}$  for some constant  $C_0 > 1$  independent of  $k$  such that

$$\left\| (1 + |x|^2)^l [u(T_{0,k} + t_0, x) - P_k(T_{0,k}, x, \sigma_k(T_{0,k}))] \right\|_{H^{2l}} < v^{10k}$$

Consequently, Theorem 4.5 implies that

$$(6.0.1) \quad \|u(t + t_0, x) - P_k(t, x, \sigma_k(t))\|_{H^1} < v^k,$$

$$(6.0.2) \quad \|x^l [u(t + t_0, x) - P_k(t, x, \sigma_k(t))]\|_{H^1} < v^k,$$

for any  $t$  satisfying  $-2 \frac{(\ln \frac{1}{v})^{\frac{4}{3}}}{v} \leq t \leq \frac{(\ln \frac{1}{v})^{\frac{4}{3}}}{v}$ . The estimate (6.0.2) and Theorem 3.1 imply the inequality (1.0.12) for  $v_1 = 0$  in Theorem 1.5. Consequently, it remains to prove the estimates (1.0.10) in Theorem 1.5, this will follow from estimate (6.0.1) and Theorem 5.1 from Section 5.

Moreover, for  $v_1 = 0$ ,  $u(t) \in H^1(\mathbb{R})$  is an odd function because of the uniqueness result of Theorem 1.10, and  $P_k(t, x, \sigma_k(t))$  is also odd functions on  $x$ . Therefore,  $u(t + t_0, x) - P_k(t, x, \sigma_k(t))$  is an odd function on  $x$  for any  $t \in \mathbb{R}$ .

Consequently, using the information of the asymptotics of  $P_k$  in Theorem 3.1, we can apply Theorem 5.1 for the initial data  $\psi(0, x) = u(-t_0 - \frac{10k \ln \frac{1}{v}}{v\sqrt{\omega}}, x)$ . From the local Well-Posedness of (1.0.1) in  $H^1$ , we have that  $\psi(t, x) = u(t - t_0 - \frac{10k \ln \frac{1}{v}}{v\sqrt{\omega}}, x)$ . Therefore, Theorem 5.1 implies that  $u(t, x)$  satisfies (1.0.10) and (1.0.11) for any  $t < \frac{-(\ln \frac{1}{v})^{\frac{4}{3}}}{v}$  when  $v > 0$  is sufficiently small. In conclusion, Theorem 1.5 is true when  $v_1 = 0$  and Remark 1.9 implies that Theorem 1.5 is true for any  $v_1 \in \mathbb{R}$ .

## APPENDIX A. PROOF OF THEOREM 1.10

Before we start the proof, we consider for any  $v, T > 0$  the following norms

$$\|f\|_{L_{v,T}^2} = \sup_{t \geq T} e^{vt} \|f(t, x)\|_{L_x^2(\mathbb{R})}, \quad \|f\|_{H_{v,T}^1} = \sup_{t \geq T} e^{vt} \|f(t, x)\|_{H_x^1(\mathbb{R})}.$$

It is not difficult to verify that the set of complex functions  $f(t, x)$  with domain  $[T, +\infty) \times \mathbb{R}$  having bounded norm  $\|\cdot\|_{L_{v,T}^2}$  is a Banach space  $L_{v,T}^2$  and the same happens for the norm  $\|\cdot\|_{H_{v,T}^1}$  which forms a Banach Space  $H_{v,T}^1$ .

Furthermore, Theorem 1.10 is a consequence of the following proposition.

**Lemma A.1.** *There exist  $C > 1$  and  $\delta > 0$  such that if  $0 < v < \delta$ ,  $T \geq \frac{4 \ln \frac{1}{v}}{\sqrt{\omega v}}$  and  $f(t, x)$  is any function odd on  $x$  satisfying*

$$\|f\|_{H_{T, \frac{3\sqrt{\omega v}}{4}}^1} < +\infty,$$

then there exists a unique function  $r(t, x) \in H_{T, \delta}^1$  odd on  $x$  satisfying

$$\begin{aligned} \text{(A.0.1)} \quad i\partial_t r + \partial_x^2 r - \omega r(t, x) + F'(\phi_\omega(x - vt)^2 + \phi_\omega(x + vt)^2) r(t, x) \\ + F''(\phi_\omega(x - vt)^2) \phi_\omega(x - vt) e^{i(-\frac{v^2 t}{2} + \frac{vx}{2})} \overline{r(t, x)} \\ - F''(\phi_\omega(x + vt)^2) \phi_\omega(x + vt) e^{i(-\frac{v^2 t}{2} - \frac{vx}{2})} \overline{r(t, x)} \\ + F''(\phi_\omega(x - vt)^2) \phi_\omega(x - vt) e^{-i(-\frac{v^2 t}{2} + \frac{vx}{2})} r(t, x) \\ - F''(\phi_\omega(x + vt)^2) \phi_\omega(x + vt) e^{-i(-\frac{v^2 t}{2} - \frac{vx}{2})} r(t, x) = e^{-i\omega t} f(t, x). \end{aligned}$$

Furthermore,

$$\text{(A.0.2)} \quad \|r(t)\|_{H_{T, \frac{3\sqrt{\omega v}}{4}}^1} < \frac{C}{v^2} \|f(t)\|_{H_{T, \frac{3\sqrt{\omega v}}{4}}^1},$$

and for any  $m \in \mathbb{N}$ , there is  $C_m$  such that

$$\text{(A.0.3)} \quad \|x^m r(t)\|_{H_{T, \frac{3\sqrt{\omega v}}{4}}^1} < \frac{C_m}{v^{2(2m+1)}} \max_{d_2 \leq m, d_1 + d_2 = m + 1} \|f(t)(1 + x^2)^{\frac{d_2}{2}}\|_{H_{T, \frac{3\sqrt{\omega v}}{4}}^{d_1}}$$

**Lemma A.2.** *Let  $r$  be a solution in  $C([T, +\infty], H^1)$  of (A.0.1), and let*

$$\begin{aligned} \text{Ort}_{1, \pm}(t) &= \left\langle r(t), i\phi'_\omega(\pm x - vt) e^{i(\frac{v(\pm x)}{2} - \frac{v^2 t}{4})} \right\rangle, \\ \text{Ort}_{2, \pm}(t) &= \left\langle r(t), \phi_\omega(\pm x - vt) e^{i(\frac{v(\pm x)}{2} - \frac{v^2 t}{4})} \right\rangle, \\ \text{Ort}_{3, \pm}(t) &= \left\langle r(t), (\pm x - vt) \phi_\omega(\pm x - vt) e^{i(\frac{v(\pm x)}{2} - \frac{v^2 t}{4})} \right\rangle, \\ \text{Ort}_{4, \pm}(t) &= \left\langle r(t), i\partial_\omega \phi_\omega(\pm x - vt) e^{i(\frac{v(\pm x)}{2} - \frac{v^2 t}{4})} \right\rangle. \end{aligned}$$

There exist  $c > 1$ ,  $\delta > 0$  such that if  $0 < v < \delta$ ,  $T \geq \frac{4 \ln(\frac{1}{v})}{\sqrt{\omega}v}$ , then the following estimates are true for any  $t \in [T, +\infty]$

$$\begin{aligned}\frac{dOrt_{1,\pm}(t)}{dt} &= O\left((1+vt)^c e^{-2\sqrt{\omega}v|t|} \|r(t)\|_{H^1} + \|f(t)\|_{L^2}\right), \\ \frac{dOrt_{2,\pm}(t)}{dt} &= O\left((1+vt)^c e^{-2\sqrt{\omega}v|t|} \|r(t)\|_{H^1} + \|f(t)\|_{L^2}\right), \\ \frac{dOrt_{3,\pm}(t)}{dt} &= \mp 2Ort_{1,\pm}(t) + O\left((1+vt)^c e^{-2\sqrt{\omega}v|t|} \|r(t)\|_{H^1} + \|f(t)\|_{L^2}\right), \\ \frac{dOrt_{4,\pm}(t)}{dt} &= Ort_{2,\pm}(t) + O\left((1+vt)^c e^{-2\sqrt{\omega}v|t|} \|r(t)\|_{H^1} + \|f(t)\|_{L^2}\right).\end{aligned}$$

*Proof of Lemma A.2.* Let  $\varphi_{\omega,\zeta}$ ,  $\varphi_{\omega,\gamma}$ ,  $\varphi_{\omega,v}$  and  $\varphi_{\omega,\omega}$  be the following functions

$$\begin{aligned}\varphi_{\omega,\zeta}(t, x) &= \phi'_\omega(x-vt) e^{i(\omega t + \frac{vx}{2} - \frac{v^2 t}{4})}, \quad \varphi_{\omega,\gamma}(t, x) = i\phi_\omega(x-vt) e^{i(\omega t + \frac{vx}{2} - \frac{v^2 t}{4})}, \\ \varphi_{\omega,v}(t, x) &= i(x-vt)\phi_\omega(x-vt) e^{i(\omega t + \frac{vx}{2} - \frac{v^2 t}{4})}, \quad \varphi_{\omega,\omega}(t, x) = \partial_\omega \phi_\omega(x-vt) e^{i(\omega t + \frac{vx}{2} - \frac{v^2 t}{4})}.\end{aligned}$$

From the formula A.0.1 and integration by parts, we deduce using Lemma 2.1 that

$$\begin{aligned}\frac{d}{dt} \langle r(t), i\varphi_{\omega,j}(t, x) \rangle &= - \left\langle r(t), S_\omega \left( \frac{\partial}{\partial j} \Big|_{t=0} \phi_\omega(\cdot - vt) e^{i(\omega t + \frac{vx}{2} - \frac{v^2 t}{4})} \right) (x-vt) e^{i(\frac{vx}{2} - \frac{v^2 t}{4})} \right\rangle \\ &\quad + O\left((1+vt)^c e^{-2\sqrt{\omega}v|t|} \|r(t)\|_{H^1} + \|f(t)\|_{L^2}\right),\end{aligned}$$

for some constant  $c > 1$  and any  $j \in \{\zeta, v, \gamma, \omega\}$ .

Consequently, using identities  $S_\omega(\phi'_\omega) = 0$ ,  $S_\omega(i\phi_\omega) = 0$ , (2.0.16) and (2.0.17), we conclude all the estimates above for each  $j \in \{\zeta, v, \gamma, \omega\}$ .  $\square$

*Proof of Lemma A.1.* We will divide the proof of Theorem 1.10 into two parts, first the existence part and later the uniqueness part.

**Step 1.** (Ansatz for the solution  $u$ .) First, it is not difficult to verify that the right-hand side of the equation (A.0.1) comes from the linearized equation (1.0.1) for a solution  $u(t)$  of the following form

$$(A.0.4) \quad u(t, x) = \phi_\omega(x-vt) e^{i(\omega t + \frac{vx}{2} - \frac{v^2 t}{4})} - \phi_\omega(x+vt) e^{i(\omega t + \frac{-vx}{2} - \frac{v^2 t}{4})} + e^{i\omega t} r(t, x),$$

such that  $Q(u) = 2Q(\phi_\omega)$ . We are going to apply a fixed-point method to prove the existence of a unique  $r$  having  $\|r\|_{H^1_{T,\delta}} < 1$  for some large  $T > 0$  and small  $\delta > 0$  such that  $u(t, x)$  in (A.0.4) is the unique solution of (1.0.1).

Furthermore, since  $Q(u) = 2Q(\phi_\omega)$ , we obtain from Lemma 5.5 that if  $t > 0$  is sufficiently large and  $\|r(t)\|_{H^1}$  is small enough, then

$$(A.0.5) \quad \left\langle e^{i\omega t} r(t, x), \phi_\omega(\pm x - vt) e^{i(\omega t + \frac{v(\pm x)}{2} - \frac{v^2 t}{4})} \right\rangle = O\left(\|r(t)\|_{H^1}^2 + e^{-2\sqrt{\omega}vt}\right).$$

**Step 2.** (Lyapunov function for energy Estimate.)

The energy estimate method used here is completely similar to the one used in the proof of Theorem 4.5.



First, we consider the Hessian of the energy  $H$  of the two solitary waves

$$\begin{aligned}
L_v(r, t) &= \int_{\mathbb{R}} |\partial_x r(t, x)|^2 + \omega |r(t, x)|^2 dx \\
&\quad - \int_{\mathbb{R}} F'(\phi_\omega(x - vt)^2) |r(t, x)|^2 + F'(\phi_\omega(x + vt)^2) |r(t, x)|^2 dx \\
&\quad - \operatorname{Re} \int_{\mathbb{R}} F''(\phi_\omega(x - vt)^2) \phi_\omega(x - vt)^2 e^{i(vx - \frac{v^2 t}{2})} \overline{r(t, x)^2} dx \\
&\quad - \operatorname{Re} \int_{\mathbb{R}} F''(\phi_\omega(x + vt)^2) \phi_\omega(x + vt)^2 e^{i(vx - \frac{v^2 t}{2})} \overline{r(t, x)^2} dx \\
&\quad - \int_{\mathbb{R}} F''(\phi_\omega(x - vt)^2) \phi_\omega(x - vt)^2 |r(t, x)|^2 dx \\
&\quad - \int_{\mathbb{R}} F''(\phi_\omega(x + vt)^2) \phi_\omega(x + vt)^2 |r(t, x)|^2 dx.
\end{aligned}$$

Moreover, using a smooth cut-off function  $\chi$  satisfying (4.2.6), we consider the localized momentum corrections

$$M_v(r, t) = v \operatorname{Im} \int_{\mathbb{R}} \chi\left(\frac{x + vt}{2vt}\right) \overline{r(t, x)} \partial_x r(t, x) dx - v \operatorname{Im} \int_{\mathbb{R}} \left[1 - \chi\left(\frac{x + vt}{2vt}\right)\right] \overline{r(t, x)} \partial_x r(t, x) dx.$$

From now on, we consider the Lyapunov function  $E_v(r, t) = L_v(r, t) + M_v(r, t)$  to estimate  $\|r\|_{H_{T, \delta}^1}$  for parameters  $\delta \in (0, 1)$  and  $T > 1$  to be chosen later.

First, using Lemma 2.12 and estimate (A.0.5), we can verify the existence of positive constants  $c, C$  such that if  $v > 0$  is small enough,  $t > 4 \frac{\ln(\frac{1}{v})}{v}$ , then

$$(A.0.6) \quad E_v(r, t) > c \|r(t)\|_{H^1}^2 - C \left[ \sum_{j=1}^4 \operatorname{Ort}_{j,+}(t)^2 + \operatorname{Ort}_{j,-}(t)^2 \right].$$

**Step 3.** (Derivative of  $E_v(r, t)$ .) Similarly to the proofs of Lemmas 4.9 and 4.11 but using  $\zeta(t) = vt$ ,  $\gamma(t) = 0$  in the place of  $\zeta_k(t)$  and  $\gamma_k(t)$ , we can verify the existence of a constant  $C > 1$  satisfying

$$(A.0.7) \quad |\dot{E}_v(r, t)| < C \left( \frac{1}{t} \|r(t)\|_{H^1}^2 + \|r(t)\|_{H^1} \|f(t)\|_{H^1} \right),$$

if  $\|r(t)\|_{H^1} < 1$ , and  $t$  is large enough, in this case the condition  $t \geq \frac{4 \ln \frac{1}{v}}{\sqrt{\omega v}}$  is sufficient when  $v > 0$  is small enough.

**Step 4.** (Estimate of the spectral projection of  $r(t)$  in non-positive part of  $S_\omega$ .)

In this step, we focus on the estimate of the expressions  $\operatorname{Ort}_{1,\pm}(t)$ ,  $\operatorname{Ort}_{2,\pm}(t)$ ,  $\operatorname{Ort}_{3,\pm}(t)$  and  $\operatorname{Ort}_{4,\pm}(t)$  defined in Lemma A.2 when  $t$  is close to  $+\infty$ .

If  $r \in H_{T, \delta}^1$ , we can verify that

$$\lim_{t \rightarrow +\infty} \operatorname{Ort}_{j,\pm}(t) = 0, \text{ for any } j \in \{1, 2, 3, 4\}.$$

Consequently, using Lemma A.2 and the Fundamental Theorem of Calculus, we deduce the existence of a constant  $C > 1$  satisfying

$$|\operatorname{Ort}_{j,\pm}(t)| \leq C \left[ \frac{e^{-\frac{7}{4}\sqrt{\omega}vt}}{v} \|r\|_{H^1_{T, \frac{\sqrt{3}\omega v}{4}}} + \frac{e^{-\frac{3}{4}\sqrt{\omega}vt}}{v} \|f\|_{H^1_{T, \frac{\sqrt{3}\omega v}{4}}} \right],$$

if  $j \in \{1, 2\}$  and  $t \geq T$ .

Therefore, using Lemma A.2 for  $j \in \{3, 4\}$  and the Fundamental Theorem of Calculus, we deduce from the estimate above that

$$|Ort_{j,\pm}(t)| \leq C \left[ \frac{e^{-\frac{7}{4}\sqrt{\omega}vt}}{v^2} \|r\|_{H^1_{T, \frac{\sqrt{3}\omega v}{4}}} + \frac{e^{-\frac{3}{4}\sqrt{\omega}vt}}{v^2} \|f\|_{H^1_{T, \frac{\sqrt{3}\omega v}{4}}} \right],$$

if  $t \geq T$ .

**Step 5.**(Estimate of  $\|r\|_{H^1_{T, \frac{\sqrt{3}\omega v}{4}}}$ .) First, from the estimate (A.0.6) of Step 2 and the estimates of Step 4, we can verify using  $\|f\|_{L^2_{T, \frac{3}{4}\sqrt{\omega}v}} < 1$  that if  $v > 0$  is small enough and  $\|r\|_{H^1_{T, \frac{3}{4}\sqrt{\omega}v}} < 1$  for a sufficiently large  $T \geq \frac{4 \ln(\frac{1}{v})}{\sqrt{\omega}v}$ , then there is a constant  $c > 0$  independent of  $v$  satisfying

$$(A.0.8) \quad \frac{1}{v^4} \|f\|_{H^1_{T, \frac{3}{4}\sqrt{\omega}v}}^2 + e^{\frac{3}{2}\sqrt{\omega}vt} E_v(r, t) > ce^{\frac{3}{2}\sqrt{\omega}vt} \|r(t)\|_{H^1}^2, \text{ for all } t \geq T.$$

Next, from the estimate (A.0.7) of Step 3, we deduce that if  $\|r\|_{H^1_{T, \frac{3}{4}\sqrt{\omega}v}} \leq 1$  for a  $T \geq \frac{4 \ln(\frac{1}{v})}{\sqrt{\omega}v}$ , then, for the same constant  $C > 1$  in (A.0.7), the estimate

$$(A.0.9) \quad |\dot{E}_v(r, t)| < C \left( \frac{e^{-\frac{3}{2}\sqrt{\omega}vt}}{t} \|r\|_{H^1_{T, \frac{3}{4}\sqrt{\omega}v}}^2 + e^{-\frac{3\sqrt{\omega}vt}{2}} \|r(t)\|_{H^1_{T, \frac{3}{4}\sqrt{\omega}v}} \|f(t)\|_{H^1_{T, \frac{3}{4}\sqrt{\omega}v}} \right)$$

holds for all  $t \geq T$ . Therefore, integrating estimate (A.0.9) from  $t \geq T$  through  $+\infty$ , we obtain the existence of a constant  $C > 1$  satisfying

$$(A.0.10) \quad |E_v(r, t)| \leq C \left( \frac{e^{-\frac{3}{2}\sqrt{\omega}vt}}{vt} \|r\|_{H^1_{T, \frac{3}{4}\sqrt{\omega}v}}^2 + \frac{e^{-\frac{3\sqrt{\omega}vt}{2}}}{v} \|r(t)\|_{H^1_{T, \frac{3}{4}\sqrt{\omega}v}} \|f(t)\|_{H^1_{T, \frac{3}{4}\sqrt{\omega}v}} \right),$$

for all  $t \geq T$ .

Consequently, using estimates (A.0.8), (A.0.10) and Young Inequality, we can deduce the existence of a constant  $C_\omega > 1$  satisfying

$$(A.0.11) \quad \|r\|_{H^1_{T, \frac{3}{4}\sqrt{\omega}v}} \leq \frac{C_\omega}{v^2} \|f\|_{H^1_{T, \frac{3}{4}\sqrt{\omega}v}}.$$

**Step 6.**(Existence of a solution  $r \in H^1_{T, \delta}$ .) The proof of existence of a solution  $r \in H^1_{T, \delta}$  of (A.0.1) is similar to the one in the demonstration of Lemma 3.1 of [10].

First, for some  $T_n > T$ , we consider a smooth cut-off function  $\chi_0$  such that

$$\chi_0(t) = \begin{cases} 1, & \text{if } t \leq -1, \\ 0, & \text{if } t \geq 0 \end{cases}.$$

Let  $r_n$  be the solution of

$$(A.0.12) \quad \begin{aligned} i\partial_t r_n + \partial_x^2 r_n - \omega r_n + F'(\phi_\omega(x-vt)^2 + \phi_\omega(x+vt)^2) r_n \\ + F''(\phi_\omega(x-vt)^2) \phi_\omega(x-vt) e^{i(-\frac{v^2 t}{2} + \frac{vx}{2})} \overline{r_n} \\ - F''(\phi_\omega(x+vt)^2) \phi_\omega(x+vt) e^{i(-\frac{v^2 t}{2} - \frac{vx}{2})} \overline{r_n} \\ + F''(\phi_\omega(x-vt)^2) \phi_\omega(x-vt) e^{-i(-\frac{v^2 t}{2} + \frac{vx}{2})} r_n \\ - F''(\phi_\omega(x+vt)^2) \phi_\omega(x+vt) e^{-i(-\frac{v^2 t}{2} - \frac{vx}{2})} r_n = e^{-i\omega t} \chi_0(t - T_n) f(t, x), \end{aligned}$$

with initial condition  $r_n(T_n) = 0$ . Since the partial differential equation above is locally Well-Posed in  $H^1(\mathbb{R})$ , there is a unique solution  $r_n$ . Moreover, since  $\chi_0(t - T_n) f(t, x) = 0$  for any  $t \geq T_n$ , we have that  $r_n(t) = 0$  for all  $t \geq T_n$ , so  $r_n$  is in  $H^1_{T, \frac{3\sqrt{\omega}v}{4}}$ .

Next, we consider a sequence  $T_n$  converging to  $+\infty$ . Since  $f \in H^1_{T, \frac{3\sqrt{\omega}v}{4}}$ , we have that

$$\lim_{n \rightarrow +\infty} \|f - \chi_0(t - T_n)f\|_{H^1_{T, \frac{3\sqrt{\omega}v}{4}}} = 0.$$

Consequently, from Step 5,  $r_n$  is a Cauchy-Sequence in  $H^1_{T, \frac{3\sqrt{\omega}v}{4}}$ . This Cauchy-Sequence converges to the solution  $r$  of (A.0.1), and this solution is unique because of the estimate (A.0.11) from the previous step.

**Step 7.**(Weighted estimates.) Furthermore, if for any  $l \in \mathbb{N}$

$$(A.0.13) \quad \sup_{t \geq T} e^{\frac{3\sqrt{\omega}t}{4}} [\|x^l f(t, x)\|_{H^1} + \|\partial_x^l f(t, x)\|_{H^1}] < +\infty,$$

the solution  $r_n$  of (A.0.12) with initial condition  $r_n(T_n) = 0$  shall be defined in  $C([T, +\infty), H^l(\mathbb{R})) \cap C([T, +\infty), x^l H^1(\mathbb{R}))$ , because of the Local Well-Posedness of the 1d linear Schrödinger equation in these weighted spaces, and since  $\phi_\omega \in \mathcal{S}(\mathbb{R})$  satisfies Remark 2.4.

First, since  $f$  satisfies (A.0.13) and the estimate (A.0.11) implies that

$$\|r_n\|_{H^1_{T, \frac{3\sqrt{\omega}v}{4}}} < \frac{C_\omega}{v^2} \|f\|_{H^1_{T, \frac{3\sqrt{\omega}v}{4}}},$$

we can verify after we differentiate the partial differential equation (A.0.12) on  $x$  using (A.0.11) the existence of a constant  $C_{2,\omega} > 1$  satisfying

$$\|\partial_x r_n\|_{H^1_{T, \frac{3\sqrt{\omega}v}{4}}} < \frac{C_{2,\omega}}{v^4} \|f\|_{H^2_{T, \frac{3\sqrt{\omega}v}{4}}},$$

for any  $n \in \mathbb{N}$ .

Similarly, we can verify by induction for any  $l \in \mathbb{N}$  the existence of a constant  $C_{l+1,\omega} > 1$  satisfying

$$(A.0.14) \quad \|r_n\|_{H^{l+1}_{T, \frac{3\sqrt{\omega}v}{4}}} < \frac{C_{l+1,\omega}}{v^{2(l+1)}} \|f\|_{H^{l+1}_{T, \frac{3\sqrt{\omega}v}{4}}},$$

for any  $n \in \mathbb{N}$ . Moreover, we are going to verify for any natural number  $m \geq 0$  that

$$(A.0.15) \quad \|x^m r_n\|_{H^{l+1}_{T, \frac{3\sqrt{\omega}v}{4}}} < \frac{C_{l+1,m,\omega}}{v^{2(2m+l+1)}} \max_{d_1+d_2=m+l+1, d_1 \leq m} \left\| (1+x^2)^{\frac{d_1}{2}} f \right\|_{H^{d_2}_{T, \frac{3\sqrt{\omega}v}{4}}},$$

for any  $n \in \mathbb{N}$  such that the constant  $C_{l+1,m,\omega} > 1$  does not depend on  $n$ . We already verified that (A.0.15) is true when  $m = 0$ , so we assume that is true from  $m = 0$  through  $m = m_1 \geq 0$

Furthermore, the function  $r_{n,m}(t, x) := x^m r_n(t, x)$  is a strong solution of the following partial differential equation

$$(A.0.16) \quad \begin{aligned} & i\partial_t r_{n,m} + \partial_x^2 r_{n,m} - \omega r_{n,m} + F'(\phi_\omega(x-vt)^2 + \phi_\omega(x+vt)^2) r_{n,m} \\ & + F''(\phi_\omega(x-vt)^2) \phi_\omega(x-vt) e^{i(-\frac{v^2 t}{2} + \frac{vx}{2})} \overline{r_{n,m}} \\ & - F''(\phi_\omega(x+vt)^2) \phi_\omega(x+vt) e^{i(\frac{-v^2 t}{2} - \frac{vx}{2})} \overline{r_{n,m}} \\ & + F''(\phi_\omega(x-vt)^2) \phi_\omega(x-vt) e^{-i(-\frac{v^2 t}{2} + \frac{vx}{2})} r_{n,m} \\ & - F''(\phi_\omega(x+vt)^2) \phi_\omega(x+vt) e^{-i(-\frac{v^2 t}{2} - \frac{vx}{2})} r_{n,m} \\ & = e^{-i\omega t} \chi_0(t - T_n) x^m f(t, x) \\ & + m(m-1) r_{n,m-2} - 2m \partial_x r_{n,m-1}, \end{aligned}$$

Consequently, from estimate (A.0.11), we deduce after we differentiate (A.0.16) on  $x$   $l$  times the existence of constants  $C_{\omega,m,l}$ ,  $C_{\omega,m,l,0} > 1$  satisfying

$$\begin{aligned} \|r_{n,1}\|_{H^1_{T, \frac{3\sqrt{\omega v}}{4}}} &< \frac{C_{\omega,m,0}}{v^2} \left[ \|xf\|_{H^1_{T, \frac{3\sqrt{\omega v}}{4}}} + \|r_n\|_{H^2_{T, \frac{3\sqrt{\omega v}}{4}}} \right], \\ \|r_{n,m}\|_{H^1_{T, \frac{3\sqrt{\omega v}}{4}}} &< \frac{C_{\omega,m,0}}{v^2} \left[ \|x^m f\|_{H^1_{T, \frac{3\sqrt{\omega v}}{4}}} + \|r_{n,m-2}\|_{H^1_{T, \frac{3\sqrt{\omega v}}{4}}} + \|r_{n,m-1}\|_{H^2_{T, \frac{3\sqrt{\omega v}}{4}}} \right] \\ \|\partial_x^l r_{n,m}\|_{H^1_{T, \frac{3\sqrt{\omega v}}{4}}} &< \frac{C_{\omega,m,l,0}}{v^2} \left[ \|\partial_x^l [x^m f]\|_{H^1_{T, \frac{3\sqrt{\omega v}}{4}}} + \|\partial_x^l r_{n,m-2}\|_{H^1_{T, \frac{3\sqrt{\omega v}}{4}}} + \|\partial_x^{l+1} r_{n,m-1}\|_{H^1_{T, \frac{3\sqrt{\omega v}}{4}}} \right. \\ &\quad \left. + \|r_{n,m}\|_{H^l_{T, \frac{3\sqrt{\omega v}}{4}}} \right], \end{aligned}$$

for any  $n \in \mathbb{N}$ ,  $l \in \mathbb{N}_{\geq 1}$  and  $m \in \mathbb{N}_{\geq 2}$ .

Therefore, for any  $l \in \mathbb{N}_{\geq 1}$ , the second and third estimates above imply the existence of a constant  $C_{\omega,m_1,l,1} > 1$  satisfying

$$(A.0.17) \quad \|r_{n,m}\|_{H^{l+1}_{T, \frac{3\sqrt{\omega v}}{4}}} < \frac{C_{\omega,m,l,1}}{v^2} \left[ \left\| (1+x^2)^{\frac{m}{2}} f \right\|_{H^{l+1}_{T, \frac{3\sqrt{\omega v}}{4}}} + \max(m-2, 0) \|r_{n,m-2}\|_{H^{l+1}_{T, \frac{3\sqrt{\omega v}}{4}}} \right. \\ \left. + \|r_{n,m-1}\|_{H^{l+2}_{T, \frac{3\sqrt{\omega v}}{4}}} + \|r_{n,m}\|_{H^l_{T, \frac{3\sqrt{\omega v}}{4}}} \right],$$

for any  $n \in \mathbb{N}$ .

Consequently, if (A.0.15) is true form  $m = m_1$ , then the estimate (A.0.17) implies that (A.0.15) is true for  $m = m_1 + 1$ , which finishes the proof by induction of the weighted norm of the remainder  $r_n$ .

Consequently, if (A.0.15) is true form  $m = m_1$ , then the estimate of  $\|r_{n,1}\|$  (A.0.17) imply that (A.0.15) is true for  $m = m_1 + 1$ , which finishes the proof by induction of the weighted norm of the remainder  $r_n$ .

In conclusion, since  $r_n$  converge to  $r$  in  $H^1_{T, \frac{3\sqrt{\omega v}}{4}}$ , we can verify from the estimates (A.0.15) and Banach-Alaoglu Theorem that

$$\|x^m r\|_{H^l_{T, \frac{3\sqrt{\omega v}}{4}}} < \frac{C_{\omega,m,l}}{v^{2(2m+l)}} \max_{d_1+d_2=m+l, d_1 \leq m} \left\| (1+x^2)^{\frac{d_1}{2}} f \right\|_{H^{d_2}_{T, \frac{3\sqrt{\omega v}}{4}}}.$$

□

*Proof of Theorem 1.10. Step 1.* (Exponential Decay of the remainder.) Let  $r(t) = e^{-i\omega t} u + \phi_\omega(x - vt)e^{i(\frac{vx}{2} - \frac{v^2 t}{4})} - \phi_\omega(x + vt)e^{i(\frac{-vx}{2} - \frac{v^2 t}{4})}$ . Since  $u$  is a solution of the partial differential equation (1.0.1), we have that

$$(A.0.18) \quad \begin{aligned} i\partial_t r + \partial_x^2 r - \omega r(t, x) + F'(\phi_\omega(x - vt)^2 + \phi_\omega(x + vt)^2) r(t, x) \\ + F''(\phi_\omega(x - vt)^2) \phi_\omega(x - vt) e^{i(-\frac{v^2 t}{2} + \frac{vx}{2})} \overline{r(t)} \\ - F''(\phi_\omega(x + vt)^2) \phi_\omega(x + vt) e^{i(\frac{-v^2 t}{2} - \frac{vx}{2})} \overline{r(t)} \\ + F''(\phi_\omega(x - vt)^2) \phi_\omega(x - vt) e^{-i(-\frac{v^2 t}{2} + \frac{vx}{2})} r(t) \\ - F''(\phi_\omega(x + vt)^2) \phi_\omega(x + vt) e^{-i(-\frac{v^2 t}{2} - \frac{vx}{2})} r(t) = [I(t) + N(r)], \end{aligned}$$

such that

$$I(t) = F' \left( \phi_\omega(x-vt)^2 + \phi_\omega(x+vt)^2 \right) \left[ \phi_\omega(x-vt) e^{i\frac{v\omega x}{2}} - \phi_\omega(x+vt) e^{-i\frac{v\omega x}{2}} \right] \\ - F' \left( \phi_\omega(x-vt)^2 \right) \phi_\omega(x-vt) e^{i\frac{v\omega x}{2}} + F' \left( \phi_\omega(x+vt)^2 \right) \phi_\omega(x+vt) e^{-i\frac{v\omega x}{2}},$$

and the function  $N(r)(t, x)$  is bounded in  $H^1(\mathbb{R})$  satisfying for some constant  $C$  any  $t \geq 1$

$$\|N(r)(t)\|_{H^1} \leq C \left[ \|r(t)\|_{H^1} e^{-2\sqrt{\omega}vt} (1 + |t|v) + \|r(t)\|_{H^1}^2 \right],$$

this follows from the fact that  $H^1(\mathbb{R})$  is an algebra and from the Lemma 2.1 with Remark 2.4.

Furthermore, for any two functions  $r_1, r_2 \in C([T, +\infty), H^1(\mathbb{R}))$ , we can verify from the partial differential equations (1.0.1) and (A.0.18) that

$$(A.0.19) \quad \|N(r_1)(t) - N(r_2)(t)\|_{H^1} \leq C \|r_1(t) - r_2(t)\|_{H^1} \left[ \max_{j \in \{1,2\}} \|r_j(t)\|_{H^1}^{2q-2} + \max_{j \in \{1,2\}} \|r_j(t)\|_{H^1} \right. \\ \left. + e^{-2\sqrt{\omega}vt} (1 + |t|v) \right],$$

for any  $t \geq 1$ , the number  $q \in \mathbb{N}_{\geq 2}$  is the degree of the polynomial  $F$ .

Consequently, since Lemma 2.1 and Remark 2.4 imply the existence of a constant  $C > 1$  such that

$$\|I(t)\|_{H^1} \leq C e^{-2\sqrt{\omega}vt},$$

for any  $t \geq 1$ , we deduce using Young Inequality that  $r$  is a solution of a partial differential equation (A.0.1) such that

$$\|f(t)\|_{H^1} \leq C \left[ \|r(t)\|_{H^1}^2 + e^{-2\sqrt{\omega}vt} \right],$$

for some constant  $C > 1$  when  $v > 0$  is sufficiently small and  $t \geq \frac{4 \ln(\frac{1}{v})}{\sqrt{\omega}v}$ .

Moreover, since  $F$  is a real polynomial satisfying (H1) and  $\phi_\omega$  satisfies Remark (1.1), we deduce using Lemma 2.1 the following estimate

$$(A.0.20) \quad \left\| (1+x^2)^{\frac{m}{2}} I(t) \right\|_{H^n} \leq C_{m,n} (1 + |t|v)^m e^{-2\sqrt{\omega}|t|v},$$

for any  $m, n \in \mathbb{N}$ , if  $t \geq 1$ .

Furthermore, since  $H^n(\mathbb{R})$  is an algebra for any  $n \geq 1$  and

$$\|fg\|_{H^n} \leq C_n \|f\|_{H^n} \|g\|_{H^n},$$

for any  $f, g \in H^n(\mathbb{R})$  for a constant  $C_n > 1$ , we can verify from Lemma 2.1, the definition of  $N$ , and the fact that  $F$  is a real polynomial satisfying (H1) the following estimate

$$(A.0.21) \quad \left\| (1+x^2)^{\frac{m}{2}} N(r) \right\|_{H^n} \leq C_{m,n} \left[ \left\| (1+x^2)^{\frac{m}{2}} r(t) \right\|_{H^n} e^{-2\sqrt{\omega}vt} (1 + |t|v) + \left\| (1+x^2)^{\frac{m}{2}} r(t) \right\|_{H^n} \|r(t)\|_{H^n} \right],$$

if  $\|r(t)\|_{H^n} \leq 1$  and  $t > 1$  is sufficiently large, for some constant  $C_{m,n} > 1$  depending only on  $m, n$ .

Consequently, using Lemma A.1 and estimates (A.0.20), (A.0.21), we conclude that there exists  $C_{m,n} > 1$  satisfying

$$(A.0.22) \quad \max_{d_1+d_2=m+n, d_1 \leq m} \left\| (1+|x|^2)^{\frac{d_1}{2}} r(t) \right\|_{H^{d_2}} \Big|_{T, \frac{3\sqrt{\omega}v}{4}} \leq \frac{C_{m,n}}{v^{2(2m+n)}} e^{-5\frac{\sqrt{\omega}|T|v}{4}} (1+vT)^m < 1,$$

for any  $T \geq \frac{4(m+n) \ln \frac{1}{v}}{\sqrt{\omega}v}$  when  $v > 0$  is small enough.

Next, using estimate (A.0.2) of Lemma A.1 and (A.0.19), we can verify using the Picard iteration method that there exists a unique solution  $u_0(t)$  of (1.0.1) satisfying (1.0.13) when  $c = \frac{3\sqrt{\omega}v}{4}$ , and from the estimate (A.0.22) we obtain (1.0.14).

**Step 2.**(Uniqueness of the two solitary waves solution.)

It remains to prove that if a solution  $u$  satisfies (1.0.13) for some  $c_1 > 0$ , then it satisfies (1.0.13) for  $c_1 \geq \frac{3\sqrt{\omega}v}{4}$ . We assume that there exists solution  $u_0$  of (1.0.1) satisfying (1.0.13) for  $0 < c < \frac{3\sqrt{\omega}v}{4}$ . Let  $u$  be the solution of (1.0.1) satisfying (1.0.13) constructed in Step 1. Obviously,  $u_0$  satisfies (1.0.13) for any  $c < \frac{3\sqrt{\omega}v}{4}$ , because  $u_0 \in H_{T, \frac{3\sqrt{\omega}v}{4}}^1$  for a  $T > 1$  large enough.

From now on, we consider the following partial differential equation satisfied by  $r_d(t) := e^{-i\omega t} (u(t) - u_0(t))$  when  $t > 0$  is sufficiently large.

$$\begin{aligned} i\partial_t r_d + \partial_x^2 r_d - \omega r_d + F'(\phi_\omega(x-vt)^2 + \phi_\omega(x+vt)^2) r_d \\ + F''(\phi_\omega(x-vt)^2) \phi_\omega(x-vt) e^{i(-\frac{v^2 t}{2} + \frac{v\pi}{2}) \frac{1}{T_d}} \\ - F''(\phi_\omega(x+vt)^2) \phi_\omega(x+vt) e^{i(-\frac{v^2 t}{2} - \frac{v\pi}{2}) \frac{1}{T_d}} \\ + F''(\phi_\omega(x-vt)^2) \phi_\omega(x-vt) e^{-i(-\frac{v^2 t}{2} + \frac{v\pi}{2}) r_d} \\ - F''(\phi_\omega(x+vt)^2) \phi_\omega(x+vt) e^{-i(-\frac{v^2 t}{2} - \frac{v\pi}{2}) r_d} = N(u) - N(u_0). \end{aligned}$$

The next steps are completely similar to the argument in the proof of Lemma A.0.1 for  $f = N(u) - N(u_0)$  but now considering the space  $H_{T,c}^1$  for a  $T > 1$  sufficiently large.

Since  $f = N(u) - N(u_0)$ , we deduce from (A.0.19) and triangle inequality that

$$(A.0.23) \quad \|f(t)\|_{H^1} \leq C \left[ \|r_d(t)\|_{H^1}^2 + \|r_d(t)\|_{H^1} \|r(t)\|_{H^1} + e^{-\frac{3\alpha}{20}\sqrt{\omega}vt} \|r_d(t)\|_{H^1} \right],$$

if  $v > 0$  is small enough,  $t \geq 1$  is sufficiently large, and  $r(t)$  is the remainder denoted in Step 1. From this, Lemma A.2, and estimate (A.0.6), we can verify from the Fundamental Theorem of Calculus the existence of constants  $k > 0$  satisfying for any  $T > 1$  large enough the following inequality

$$(A.0.24) \quad E_v(r_d, t) \geq k \|r_d\|_{H_{T,c}^1}^2 e^{-2cT}.$$

Next, using estimates (A.0.7), (A.0.23), (A.0.24), and the fact that  $\|r\|_{H_{T, \frac{3}{4}\sqrt{\omega}v}^1} < +\infty$ , we can verify from the Fundamental Theorem of Calculus and Minkowski inequality the existence of constants  $k > 0$ ,  $K > 1$  depending on  $c$  and  $v$  satisfying the following inequality

$$(A.0.25) \quad k \|r_d(t)\|_{H_{T,c}^1}^2 e^{-2cT} \leq K \|r_d(t)\|_{H_{T,c}^1}^2 e^{-\frac{3}{2}\sqrt{\omega}vT-2cT},$$

for all  $T > 1$  sufficiently large. Consequently,

$$\|r_d\|_{H_{T,c}^1} = 0,$$

when  $T > 1$  is large enough, since  $c, v > 0$ .

Therefore,  $\|r_d(t)\|_{H^1} \equiv 0$ , when  $t > 1$  is large enough. In conclusion, the uniqueness of (1.0.1) in  $H_{T, \frac{3}{4}\sqrt{\omega}v}^1$  implies that  $u(t) \equiv u_0(t)$ , which finishes the proof of Theorem 1.10.  $\square$
