# Sample Complexity of Offline Distributionally Robust Linear Markov Decision Processes

#### Abstract

In offline reinforcement learning (RL), the absence of active exploration calls for attention on the model robustness to tackle the sim-to-real gap, where the discrepancy between the simulated and deployed environments can significantly undermine the performance of the learned policy. To endow the learned policy with robustness in a sample-efficient manner in the presence of high-dimensional state-action space, this paper considers the sample complexity of distributionally robust linear Markov decision processes (MDPs) with an uncertainty set characterized by the total variation distance using offline data. We develop a pessimistic model-based algorithm and establish its sample complexity bound under minimal data coverage assumptions, which outperforms prior art by at least  $O(d)$ , where d is the feature dimension. We further improve the performance guarantee of the proposed algorithm by incorporating a carefullydesigned variance estimator.

## <span id="page-1-0"></span>1 Introduction

In reinforcement learning (RL), agents aim to learn an optimal policy that maximizes the expected total rewards, by actively interacting with an *unknown* environment. However, online data collection may be pro-hibitively expensive or potentially risky in many real-world applications, e.g., autonomous driving [\(Gu et al.,](#page-12-0) [2022\)](#page-12-0), healthcare [\(Yu et al.](#page-14-0), [2021](#page-14-0)), and wireless security [\(Uprety and Rawat](#page-13-0), [2020](#page-13-0)). This motivates the study of offline RL, which leverages existing historical data (aka batch data) collected in the past to improve policy learning, and has attracted growing attention [\(Levine et al.](#page-12-1), [2020](#page-12-1)). Nonetheless, the performance of the learned policy invoking standard offline RL techniques could drop dramatically when the deployed environment shifts from the one experienced by the historical data even slightly, necessitating the development of robust RL algorithms that are resilient against environmental uncertainty.

In response, recent years have witnessed a surge of interests in *distributionally robust offline RL* [\(Zhou et al.](#page-15-3), [2021b](#page-15-3); [Yang et al.,](#page-14-1) [2022](#page-14-1); [Shi and Chi](#page-13-1), [2022](#page-13-1); [Blanchet et al.,](#page-12-2) [2024](#page-12-2)). In particular, given only historical data from a nominal environment, *distributionally robust offline RL* aims to learn a policy that optimizes the worst-case performance when the environment falls into some prescribed uncertainty set around the nominal one. Such a framework ensures that the performance of the learned policy does not fail drastically, provided that the distribution shift between the nominal and deployment environments is not excessively large.

Nevertheless, most existing provable algorithms in distributionally robust offline RL only focus on the tabular setting with finite state and action spaces [\(Zhou et al.,](#page-15-3) [2021b](#page-15-3); [Yang et al.,](#page-14-1) [2022](#page-14-1); [Shi and Chi](#page-13-1), [2022\)](#page-13-1), where the sample complexity scales linearly with the size of the state-action space, which is prohibitive when the problem is high-dimensional. To expand the reach of distributionally robust offline RL, a few latest works [\(Ma et al.](#page-13-2), [2022;](#page-13-2) [Blanchet et al.,](#page-12-2) [2024\)](#page-12-2) attempt to develop sample-efficient solutions by leveraging linear function approximation [\(Bertsekas,](#page-12-3) [2012\)](#page-12-3), which is widely used in both theoretic [\(Jin et al.](#page-12-4), [2020,](#page-12-4) [2021;](#page-12-5) [Xiong et al.,](#page-14-2) [2023](#page-14-2)) and practical [\(Prashanth and Bhatnagar,](#page-13-3) [2010](#page-13-3); [Bellemare et al.](#page-12-6), [2019\)](#page-12-6) developments of standard RL. However, the existing sample complexity is still far from satisfactory and notably larger than the counterpart of standard offline RL [\(Jin et al.,](#page-12-5) [2021;](#page-12-5) [Xiong et al.](#page-14-2), [2023\)](#page-14-2) with linear function approximation, especially in terms of the dependency on the dimension of the feature space d. Therefore, it is natural to ask:

Can we design a provably sample-efficient algorithm for distributionally robust offline RL with linear representations?

## <span id="page-1-1"></span>1.1 Main contribution

To answer this question, we focus on learning a robust variant of linear Markov decision processes in the offline setting. Throughout this paper, we consider a class of finite-horizon distributionally robust linear MDPs (Lin-RMDPs), where the uncertainty set is characterized by the total variation (TV) distance between the feature representations in the latent space, motivated by its practical [\(Pan et al.](#page-13-4), [2024\)](#page-13-4) and theoretical appeals [\(Shi et al.,](#page-13-5) [2023\)](#page-13-5). The highlights of our contributions can be summarized as follows.

- We propose a distributionally robust variant of pessimistic least-squares value iteration, referred to as DROP, which incorporates linear representations of the MDP model and devises a data-driven penalty function to account for data scarcity in the offline setting. We also establish the sub-optimality bound for DROP under the minimal offline data assumption (cf. Theorem [1\)](#page-8-0).
- We introduce a clipped single-policy concentrability coefficient  $C_{\text{rob}}^* \geq 1$  tailored to characterize the partial feature coverage of the offline data in Lin-RMDPs, and demonstrate that DROP attains  $\epsilon$ -accuracy (for learning the robust optimal policy) as soon as the sample complexity is above  $O(C_{\text{rob}}^{\star}d^2H^4/\epsilon^2)$  (cf. Corollary [1\)](#page-8-1). Compared with the prior art [\(Blanchet et al.,](#page-12-2) [2024\)](#page-12-2), DROP improves the sample complexity by at least  $\tilde{O}(d)$ .
- We further develop a variance-weighted variant of DROP by integrating a carefully designed variance estimator, dubbed by DROP-V. Due to tighter control of the variance, DROP-V exhibits an improved sub-optimality gap under the full feature coverage assumption (see Section [4\)](#page-9-3).

Table 1: Our results and comparisons with prior art (up to log factors) in terms of sub-optimality gap, for learning robust linear MDPs with an uncertainty set measured by the TV distance. Here, d is the feature dimension, H is the horizon length, K is the number of trajectories,  $C_1^*, C_{\text{rob}}^* \in [1, \infty)$  are some concentrability coefficients (defined in Section [3.3.1\)](#page-8-2) satisfying  $C_{\text{rob}}^* \leq dC_1^*$ . In addition,  $\mathcal{P}^{\rho}(P^0)$  denotes the uncertainty set around the nominal kernel  $P^0$ ,  $\phi_i(s, a)$  is the *i*-th coordinate of the feature vector given any state-action pair  $(s, a) \in S \times A$ ,  $\Lambda_h$  and  $\Sigma_h^*$  are some sort of cumulative sample covariance matrix and variance-weighted cumulative sample covariance matrix, satisfying  $H\Lambda_h^{-1} \succeq (\Sigma_h^{\star})^{-1}$ .

### <span id="page-2-0"></span>1.2 Related works

In this section, we mainly discuss works that study sample complexity of linear MDPs and robust RL, which are closely related to this paper.

Finite-sample guarantees for linear MDPs. Considering linear function approximation in RL, a significant body of works study linear MDPs with linear transitions and rewards. Focusing on offline settings, [Jin et al.](#page-12-5) [\(2021](#page-12-5)) proposed Pessimistic Value Iteration (PEVI) for offline RL with finite-horizon linear MDPs, which incorporated linear function approximation together with the principle of pessimism [\(Rashidinejad et al.,](#page-13-6) [2021;](#page-13-6) [Shi et al.,](#page-13-7) [2022;](#page-13-7) [Yan et al.,](#page-14-3) [2023;](#page-14-3) [Woo et al.,](#page-14-4) [2024;](#page-14-4) [Li et al.](#page-12-7), [2024](#page-12-7)). However, the temporally statistical dependency arising from backward updates leads to an  $O(\sqrt{d})$  amplification in the suboptimality gap with comparison to the lower bound [\(Zanette et al.,](#page-15-4) [2021\)](#page-15-4). Subsequently, [Min et al.](#page-13-8) [\(2021](#page-13-8)) and [Yin et al.](#page-14-5) [\(2022](#page-14-5)) attempted to address this gap. The near-optimal sample complexity in [Xiong et al.](#page-14-2) [\(2023\)](#page-14-2) is achieved by applying variance estimation techniques, motivating us to explore variance information for robust offline RL. Beyond these works, there are many offline RL works that investigate model-free algorithms or the infinite-horizon setting that deviates from our focus [\(Zanette et al.,](#page-15-4) [2021;](#page-15-4) [Uehara and Sun,](#page-13-9) [2021;](#page-13-9) [Xie et al.,](#page-14-6) [2021\)](#page-14-6). In addition to the offline setting, linear MDPs are also widely explored in other settings such as generative model or online RL [\(Yang and Wang,](#page-14-7) [2020;](#page-14-7) [Jin et al.](#page-12-4), [2020;](#page-12-4) [Agarwal et al.](#page-11-3), [2023;](#page-11-3) [He et al.](#page-12-8), [2023\)](#page-12-8).

Distributionally robust RL with tabular MDPs. To promote robustness in the face of environmental uncertainty, a line of research known as distributionally robust RL incorporates distributionally robust optimization tools with RL to ensure robustness in a worst-case manner [\(Iyengar](#page-12-9), [2005](#page-12-9); [Xu and Mannor,](#page-14-8) [2012;](#page-14-8) [Wolff et al.](#page-14-9), [2012;](#page-14-9) [Kaufman and Schaefer,](#page-12-10) [2013;](#page-12-10) [Tamar et al.](#page-13-10), [2014](#page-13-10); [Ho et al.,](#page-12-11) [2018;](#page-12-11) [Smirnova et al.,](#page-13-11) [2019;](#page-13-11) [Derman and Mannor,](#page-12-12) [2020;](#page-12-12) [Ho et al.](#page-12-13), [2021;](#page-12-13) [Badrinath and Kalathil,](#page-11-4) [2021;](#page-11-4) [Goyal and Grand-Clement,](#page-12-14) [2022;](#page-12-14) [Ding et al.,](#page-12-15) [2024](#page-12-15)). Recently, a surge of works focus on understanding/improving sample complexity and computation complexity of RL algorithms in the tabular setting [\(Wang and Zou](#page-14-10), [2021;](#page-14-10) [Zhou et al.,](#page-15-3) [2021b](#page-15-3); [Dong et al.,](#page-12-16) [2022;](#page-12-16) [Yang et al.](#page-14-1), [2022;](#page-14-1) [Panaganti and Kalathil,](#page-13-12) [2022;](#page-13-12) [Liu et al.,](#page-13-13) [2022;](#page-13-13) [Li et al.,](#page-12-17) [2022;](#page-12-17) [Xu et al.](#page-14-11), [2023;](#page-14-11) [Wang et al.](#page-14-12), [2023a](#page-14-12)[,c;](#page-14-13) [Liang et al.](#page-12-18), [2023;](#page-12-18) [Wang et al.](#page-14-14), [2023b;](#page-14-14) [Li and Lan](#page-12-19), [2023;](#page-12-19) [Yang et al.,](#page-14-15) [2023;](#page-14-15) [Zhang et al.](#page-15-5), [2023](#page-15-5); [Kumar et al.](#page-12-20), [2024;](#page-12-20) [Blanchet et al.,](#page-12-2) [2024;](#page-12-2) [Shi et al.,](#page-13-14) [2024\)](#page-13-14). Among them, [Zhou et al.](#page-15-3) [\(2021b](#page-15-3)); [Yang et al.](#page-14-1) [\(2022\)](#page-14-1); [Shi and Chi](#page-13-1) [\(2022\)](#page-13-1); [Blanchet et al.](#page-12-2) [\(2024\)](#page-12-2) consider distributionally robust RL in the offline setting, which are most related to us. Different from the sample complexity achieved in the tabular setting that largely depends on the size of state and action spaces, this work advances beyond the tabular setting and develops a sample complexity guarantee that only depends on the feature dimension based on the linear MDP model assumption.

Distributionally robust RL with linear MDPs. The prior art [\(Blanchet et al.](#page-12-2), [2024\)](#page-12-2) studies the same robust linear MDP (Lin-RMDP) problem as this work, while the sample complexity dependency on the feature dimension  $d$  is still worse than that of standard linear MDPs in offline setting [\(Jin et al.](#page-12-5), [2021;](#page-12-5) [Xiong et al.,](#page-14-2) [2023\)](#page-14-2), highlighting gap for potential improvements. Besides TV distance considered herein, [Ma et al.](#page-13-2) [\(2022](#page-13-2)); [Blanchet et al.](#page-12-2) [\(2024\)](#page-12-2) consider the Kullback-Leibler (KL) divergence for the uncertainty set. Moreover, [Liu and Xu](#page-13-15) [\(2024a\)](#page-13-15) explores Lin-RMDPs with an additional structure assumption in the online setting, which diverges from our focus on the offline context. We also note that a concurrent work [\(Liu and Xu,](#page-13-16) [2024b\)](#page-13-16) studies offline Lin-RMDPs, which aligns with our interest. However, their focus is limited to the well-explored data coverage assumption. In addition to linear representations for robust MDPs, [Badrinath and Kalathil](#page-11-4) [\(2021\)](#page-11-4); [Ramesh et al.](#page-13-17) [\(2024\)](#page-13-17) consider other classes of function for model approximation.

Notation. Throughout this paper, we define  $\Delta(S)$  as the probability simplex over a set S, [H] :=  $\{1,\ldots,H\}$  and  $[d] := \{1,\ldots,d\}$  for some positive integer  $H, d > 0$ . We also denote  $\mathbb{1}_i$  as the vector with appropriate dimension, where the *i*-th coordinate is 1 and others are 0. We use  $I_d$  to represent the identity matrix of the size d. For any vector  $x \in \mathbb{R}^d$ , we use  $||x||_2$  and  $||x||_1$  to represent its  $l_2$  and  $l_1$  norm, respectively. In addition, we denote  $\sqrt{x^{\top}Ax}$  as  $||x||_A$  given any vector  $x \in \mathbb{R}^d$  and any semi-definite matrix  $A \in \mathbb{R}^{d \times d}$ . For any set  $D$ , we use  $|D|$  to represent the cardinality (i.e., the size) of the set  $D$ . Additionally, we use  $\min\{a, b\}$  to denote the minimum of a and b when  $a, b > 0$ , and 0 otherwise. We also let  $\lambda_{\min}(A)$ to denote the smallest eigenvalue of any matrix A.

## <span id="page-3-0"></span>2 Problem Setup

In this section, we introduce the formulation of finite-horizon distributionally robust linear MDPs (Lin-RMDPs), together with the batch data assumptions and the learning objective.

**Standard linear MDPs.** Consider a finite-horizon standard linear MDP  $\mathcal{M} = (\mathcal{S}, \mathcal{A}, H, P = \{P_h\}_{h=1}^H, r =$  ${r_h}_{h=1}^H$ , where S and A denote the state space and action space respectively, and H is the horizon length. At each step  $h \in [H]$ , we denote  $P_h : \mathcal{S} \times \mathcal{A} \to \Delta(\mathcal{S})$  as the transition kernel and  $r_h : \mathcal{S} \times \mathcal{A} \to [0,1]$  as the deterministic reward function, which satisfy the following assumption used in [Yang and Wang](#page-14-16) [\(2019\)](#page-14-16); [Jin et al.](#page-12-4) [\(2020\)](#page-12-4).

<span id="page-4-2"></span>Assumption 1 (Linear MDPs). A finite-horizon MDP  $\mathcal{M} = (\mathcal{S}, \mathcal{A}, H, P, r)$  is called a linear MDP if given a known feature map  $\phi: \mathcal{S} \times \mathcal{A} \to \mathbb{R}^d$ , there exist d unknown measures  $\mu_h^P = (\mu_{h,1}^P, \cdots, \mu_{h,d}^P)$  over the state space S and an unknown vector  $\theta_h \in \mathbb{R}^d$  at each step h such that

$$
r_h(s, a) = \phi(s, a)^\top \theta_h, \quad P_h(s' \mid s, a) = \phi(s, a)^\top \mu_h^P(s'), \qquad \forall (h, s, a, s') \in [H] \times S \times A \times S. \tag{1}
$$

Without loss of generality, we assume  $\|\phi(s, a)\|_2 \leq 1$  and  $\phi_i(s, a) \geq 0$  for any  $(s, a, i) \in S \times A \times [d]$ , and  $\max\{\int_{\mathcal{S}}\|\mu_h^R(s)\|_2ds,\|\theta_h\|_2\}\leq \sqrt{d}$  for all  $h\in[H]$ .

In addition, we denote  $\pi = {\pi_h}_{h=1}^H$  as the policy of the agent, where  $\pi_h : S \to \Delta(\mathcal{A})$  is the action selection probability over the action space A at time step h. Given the policy  $\pi$  and the transition kernel P, the value function  $V_h^{\pi,P}$  and the Q-function  $Q_h^{\pi,P}$  at the h-th step are defined as: for any  $(s, a) \in S \times A$ ,

$$
V_h^{\pi,P}(s) = \mathbb{E}_{\pi,P}\bigg[\sum_{t=h}^H r_t(s_t, a_t) \mid s_h = s\bigg], \quad Q_h^{\pi,P}(s,a) = r_h(s,a) + \mathbb{E}_{\pi,P}\bigg[\sum_{t=h+1}^H r_t(s_t, a_t) \mid s_h = s, a_h = a\bigg],
$$

where the expectation is taken over the randomness of the trajectory induced by the policy  $\pi$  and the transition kernel P.

Lin-RMDPs: distributionally robust linear MDPs. In this work, we consider distributionally robust linear MDPs (Lin-RMDPs), where the transition kernel can be an arbitrary one within an *uncertainty set* around the nominal kernel — an ensemble of probability transition kernels, rather than a fixed transition in standard linear MDPs [\(Jin et al.,](#page-12-5) [2021](#page-12-5); [Yin et al.](#page-14-5), [2022;](#page-14-5) [Xiong et al.,](#page-14-2) [2023](#page-14-2)). Formally, we denote it by  $\mathcal{M}_{\text{rob}} = (\mathcal{S}, \mathcal{A}, H, \mathcal{P}^{\rho}(P^0), r)$ , where  $P^0$  represents a nominal transition kernel and then  $\mathcal{P}^{\rho}(P^0)$  represents the uncertainty set (a ball) around the nominal  $P^0$  with some uncertainty level  $\rho \geq 0$ . For notational simplicity, we denote  $\mu_h^0 := \mu_h^{P^0}$  and according to [\(1\)](#page-4-0), we let

$$
\forall (h,s,a,s') \in [H] \times \mathcal{S} \times \mathcal{A} \times \mathcal{S} : \quad P^0_{h,s,a}(s') := P^0_h(s' \mid s,a) = \phi(s,a)^\top \mu^0_h(s').
$$

In this work, we consider the total variation (TV) distance [\(Tsybakov](#page-13-18), [2008\)](#page-13-18) as the divergence metric for the uncertainty set  $\mathcal{P}^{\rho}$  and we assume that Lin-RMDPs satisfy the following d-rectangular assumption [\(Ma et al.,](#page-13-2) [2022;](#page-13-2) [Blanchet et al.,](#page-12-2) [2024\)](#page-12-2).

<span id="page-4-1"></span>Assumption 2 (Lin-RMDPs). In Lin-RMDPs, the uncertainty set  $\mathcal{P}^{\rho}(P^0)$  is d-rectangular, i.e.,  $\mu_{h,i}^0 \in \Delta(\mathcal{S})$ for any  $(h, i) \in [H] \times [d]$  and

$$
\mathcal{P}^{\rho}(P^0) := \otimes_{[H],\mathcal{S},\mathcal{A}} \mathcal{P}^{\rho}(P^0_{h,s,a}), \quad \text{with } \mathcal{P}^{\rho}(P^0_{h,s,a}) := \left\{ \phi(s,a)^\top \mu_h(\cdot) : \mu_h \in \mathcal{U}^{\rho}(\mu^0_h) \right\},
$$
  
where  $\mathcal{U}^{\rho}(\mu^0_h) := \otimes_{[d]} \mathcal{U}^{\rho}(\mu^0_{h,i}), \quad \text{with } \mathcal{U}^{\rho}(\mu^0_{h,i}) := \left\{ \mu_{h,i} : D_{\text{TV}}(\mu_{h,i} \parallel \mu^0_{h,i}) \le \rho \text{ and } \mu_{h,i} \in \Delta(\mathcal{S}) \right\}.$ 

Here,  $D_{\text{TV}}(\mu_{h,i} \mid \mu_{h,i}^0)$  represents the TV-distance between two measures over the state space, i.e.

$$
D_{\rm TV}(\mu_{h,i}, \mu_{h,i}^0) = \frac{1}{2} ||\mu_{h,i} - \mu_{h,i}^0||_1,
$$

where  $\otimes_{[d]}$  (resp.  $\otimes_{[H],\mathcal{S},\mathcal{A}}$ ) denotes Cartesian products over [d] (resp. [H], S, and A).

Assumption [2](#page-4-1) indicates that the uncertainty set can be decoupled into each feature dimension  $i \in [d]$ independently, so called d-rectangularity. Note that by letting  $d = SA$  and  $\phi_i(s, a) = \mathbb{1}_i$  for any  $(i, s, a) \in$  $[d] \times S \times A$ , the Lin-RMDP is instantiated to the tabular RMDP and d rectangularity becomes the  $(s, a)$ rectangularity commonly used in prior literatures [\(Yang et al.](#page-14-1), [2022;](#page-14-1) [Shi et al.](#page-13-5), [2023\)](#page-13-5). Moreover, when the uncertainty level  $\rho = 0$ , Lin-RMDPs reduce to a subclass of standard linear MDPs satisfying Assumption [1.](#page-4-2) Robust value function and robust Bellman equations. Considering Lin-RMDPs with any given policy  $\pi$ , we define *robust value function* (resp. *robust Q-function*) to characterize the *worst-case* performance induced by all possible transition kernels over the uncertainty set, denoted as

$$
\forall (h,s,a) \in [H] \times S \times A: \quad V_h^{\pi,\rho}(s) := \inf_{P \in \mathcal{P}^{\rho}(P^0)} V_h^{\pi,P}(s), \qquad Q_h^{\pi,\rho}(s,a) = \inf_{P \in \mathcal{P}^{\rho}(P^0)} Q_h^{\pi,P}(s,a).
$$

They satisfy the following robust Bellman consistency equations:

$$
\forall (h, s, a) \in [H] \times \mathcal{S} \times \mathcal{A} : Q_h^{\pi, \rho}(s, a) = \mathbb{B}_h^{\rho} V_{h+1}^{\pi, \rho}(s, a), \text{ where } V_h^{\pi, \rho}(s) = \mathbb{E}_{a \sim \pi_h(\cdot | s)} [Q_h^{\pi, \rho}(s, a)], \tag{2}
$$

and the robust linear Bellman operator and transition operator for any function  $f : \mathcal{S} \to \mathbb{R}$  is defined by

[\mathbb{B}_h^{\rho} f](s, a) := r_h(s, a) + [\mathbb{P}_h^{\rho} f](s, a),\tag{3}

[\mathbb{P}_h^{\rho} f](s, a) := \inf_{\mu_h \in \mathcal{U}^{\rho}(\mu_h^0)} \int_{\mathcal{S}} \phi(s, a)^{\top} \mu_h(s') f(s') ds'. \tag{4}

Note that under Assumption [2,](#page-4-1) the robust Bellman operator inherits the linearity of the Bellman operator in standard linear MDPs [\(Jin et al.](#page-12-4), [2020](#page-12-4), Proposition 2.3), as shown in the following lemma. The proof is postponed to Appendix [A.1.](#page-15-1)

<span id="page-5-0"></span>Lemma 1 (Linearity of robust Bellman operators). Suppose that the finite-horizon Lin-RMDPs satisfies Assumption [1](#page-4-2) and [2.](#page-4-1) There exist weights  $w^{\rho} = \{w^{\rho}_h\}_{h=1}^H$ , where  $w^{\rho}_h := \theta_h + \inf_{\mu_h \in \mathcal{U}^{\rho}(\mu_h^0)} \int_{\mathcal{S}} \mu_h(s') f(s') ds'$  for any  $h \in [H]$ , such that  $\mathbb{B}_h^{\rho} f(s, a)$  is linear with respect to the feature map  $\phi$ , i.e.,  $\mathbb{B}_h^{\rho} f(s, a) = \phi(s, a)^{\top} w_h^{\rho}$ .

In addition, conditioned on some initial state distribution  $\zeta$ , we define the induced *occupancy distribution* w.r.t. any policy  $\pi$  and transition kernel P by

<span id="page-5-1"></span>
$$
\forall (h,s,a) \in [H] \times \mathcal{S} \times \mathcal{A} : d_h^{\pi,P}(s) := d_h^{\pi,P}(s;\zeta) = \mathbb{P}(s_h = s \mid \zeta, \pi, P), d_h^{\pi,P}(s,a) = d_h^{\pi,P}(s)\pi_h(a \mid s). \tag{5}
$$

To continue, we denote  $\pi^* = {\pi_h^*}_{h=1}^H$  as a deterministic *optimal robust policy* [\(Iyengar,](#page-12-9) [2005\)](#page-12-9). The resulting *optimal robust value function* and *optimal robust Q-function* are defined as:

$$
V_h^{\star,\rho}(s) := V_h^{\pi^{\star},\rho}(s) = \max_{\pi} V_h^{\pi,\rho}(s), \qquad \forall (h,s) \in [H] \times \mathcal{S},
$$
  

$$
Q_h^{\star,\rho}(s,a) := Q_h^{\pi^{\star},\rho}(s,a) = \max_{\pi} Q_h^{\pi,\rho}(s,a), \qquad \forall (h,s,a) \in [H] \times \mathcal{S} \times \mathcal{A}.
$$

Accordingly, we also have the following robust Bellman optimality equation:

<span id="page-5-5"></span>
$$
Q_h^{\star,\rho}(s,a) = [\mathbb{B}_h^{\rho} V_{h+1}^{\star,\rho}](s,a), \quad \forall (h,s,a) \in [H] \times S \times \mathcal{A}.
$$
 (6)

Similar to [\(5\)](#page-5-1), we also denote the occupancy distribution associated with the optimal robust policy  $\pi^*$  and some transition kernel  $P$  by

$$
\forall (h,s,a) \in [H] \times \mathcal{S} \times \mathcal{A} : d_h^{\star,P}(s) := d_h^{\pi^{\star},P}(s;\zeta), \qquad d_h^{\star,P}(s,a) := d_h^{\pi^{\star},P}(s)\pi_h^{\star}(a \mid s). \tag{7}
$$

**Offline data.** Suppose that we can access a batch dataset  $\mathcal{D} = \{(s_h^{\tau}, a_h^{\tau}, r_h^{\tau}, s_{h+1}^{\tau})\}_{h \in [H], \tau \in [K]}$ , which consists K i.i.d. trajectories that are generated by executing some (mixed) behavior policy  $\pi^{\mathbf{b}} = {\{\pi_h^{\mathbf{b}}\}_{h=1}^H}$  over sists R E.R. trajectories that are generated by executing some (inixed) behavior policy  $\Lambda^0 = \{\Lambda_h\}_{h=1}^n$  over<br>some nominal linear MDP  $\mathcal{M}^0 = (\mathcal{S}, \mathcal{A}, H, P^0, r)$ . Note that D contains KH transition-reward sample tu in total, where each sample tuple  $(s_h^{\tau}, a_h^{\tau}, r_h^{\tau}, s_{h+1}^{\tau})$  represents that the agent took the action  $a_h^{\tau}$  at the state  $s_h^{\tau}$ , received the reward  $r_h^{\tau} = r_h(s_h^{\tau}, a_h^{\tau})$ , and then observed the next state  $s_{h+1}^{\tau} \sim P_h^0(\cdot \mid s_h = s_h^{\tau}, a_h = a_h^{\tau})$ . To proceed, we define

$$
\mathcal{D}_h^0 = \{ (s_h^{\tau}, a_h^{\tau}, r_h^{\tau}, s_{h+1}^{\tau}) \}_{\tau \in [K]},
$$

which contains all samples at the h-th step in  $\mathcal{D}$ . For simplicity, we abuse the notation  $\tau \in \mathcal{D}_h^0$  to denote  $(s_h^{\tau}, a_h^{\tau}, r_h^{\tau}, s_{h+1}^{\tau}) \in \mathcal{D}_h^0$ . In addition, we define the induced occupancy distribution w.r.t. the behavior policy  $\pi^{\mathbf{b}}$  and the nominal transition kernel  $P^{\mathbf{0}}$  at each step h by

$$
\forall (h,s,a) \in [H] \times \mathcal{S} \times \mathcal{A} : d_h^b(s) := d_h^{\pi^b, P^0}(s;\zeta) \quad \text{and} \quad d_h^b(s,a) := d_h^{\pi^b, P^0}(s,a;\zeta),\tag{8}
$$

which is conditioned on the initial distribution  $\zeta$ .

**Learning goal.** Given the batch dataset  $\mathcal{D}$ , the goal of solving the Lin-RMDP  $\mathcal{M}_{\text{rob}}$  with a given initial state distribution  $\zeta$  is to learn an  $\epsilon$ -optimal robust policy  $\hat{\pi}$  such that the sub-optimality gap satisfies

<span id="page-6-8"></span>
$$
\text{SubOpt}(\hat{\pi}; \zeta, \mathcal{P}^{\rho}) := V_1^{\star, \rho}(\zeta) - V_1^{\hat{\pi}, \rho}(\zeta) \le \epsilon,\tag{9}
$$

using as few samples as possible, where  $\epsilon$  is the targeted accuracy level,

$$
V_1^{\star,\rho}(\zeta) = \mathbb{E}_{s_1 \sim \zeta} [V_1^{\star,\rho}(s_1)] \quad \text{and} \quad V_1^{\widehat{\pi},\rho}(\zeta) = \mathbb{E}_{s_1 \sim \zeta} [V_1^{\widehat{\pi},\rho}(s_1)].
$$

## <span id="page-6-0"></span>3 Algorithm and Performance Guarantees

In this section, we propose a model-based approach referred to as *Distributionally Robust Pessimistic Least*squares Value Iteration (DROP), by constructing an empirical Bellman operator for Lin-RMDPs in an offline fashion. Then we analyze the sub-optimality bound of the robust policy learned from DROP and discuss the sample complexity under different historical data quality scenarios.

### <span id="page-6-1"></span>3.1 Empirical robust Bellman operator and strong duality

Recalling the robust Bellman operator in [\(3\)](#page-5-2) gives that for any value function  $V : \mathcal{S} \to [0, H]$ ,

$$
(\mathbb{B}_h^{\rho} V)(s, a) = r_h(s, a) + \inf_{\mu_h \in \mathcal{U}^{\rho}(\mu_h^0)} \int_{\mathcal{S}} \phi(s, a)^{\top} \mu_h(s') V(s') ds',
$$

which can be equivalently rewritten as its dual form:

<span id="page-6-2"></span>
$$
(\mathbb{B}_h^{\rho} V)(s, a) = \phi(s, a)^{\top} \left(\theta_h + \nu_h^{\rho, V}\right),\tag{10}
$$

from the views of strong duality [\(Iyengar,](#page-12-9) [2005;](#page-12-9) [Shi et al.](#page-13-5), [2023\)](#page-13-5) (see the detailed proof in Appendix [B.1\)](#page-17-1). Here,  $\nu_h^{\rho,V} = [\nu_{h,1}^{\rho,V}, \nu_{h,2}^{\rho,V} \dots, \nu_{h,d}^{\rho,V}]^\top \in \mathbb{R}^d$  and its *i*-th coordinate is defined by

<span id="page-6-7"></span>
$$
\nu_{h,i}^{\rho,V} := \max_{\alpha \in [\min_s V(s), \max_s V(s)]} \{ \mathbb{E}_{s \sim \mu_{h,i}^0}[V]_{\alpha}(s) - \rho(\alpha - \min_{s'} [V]_{\alpha}(s')) \}, \text{ with } [V]_{\alpha}(s) = \begin{cases} \alpha, & \text{if } V(s) > \alpha, \\ V(s), & \text{otherwise.} \end{cases} \tag{11}
$$

However, notice that we cannot directly apply the above robust Bellman operator and perform value iterations since we cannot have access to the ground-truth nominal linear MDP  $\mathcal{M}^0$  (i.e.,  $\theta_h$  and  $\mu_h^0$ ). Therefore, for each time step h, we incorporate ridge regression to obtain the estimator  $\widehat{\theta}_h \in \mathbb{R}^d$  and  $\widehat{\nu}_h^{\rho, V} \in \mathbb{R}^d$ , based on the batch dataset  $\mathcal{D}_h^0$  that contains all the samples at h-th step collected in  $\mathcal{D}^0$ . In particular, for any value function  $V : \mathcal{S} \to [0, H]$  and any time step  $h \in [H]$ , the estimator  $\widehat{\theta}_h$  and the *i*-th coordinate of  $\widehat{\nu}_h^{\rho, V}$  are defined by

$$
\widehat{\theta}_h = \arg \min_{\theta \in \mathbb{R}^d} \sum_{\tau \in \mathcal{D}_h^0} \left( \phi(s_h^\tau, a_h^\tau)^\top \theta - r_h^\tau \right)^2 + \lambda_0 \|\theta\|_2^2 = \Lambda_h^{-1} \left( \sum_{\tau \in \mathcal{D}_h^0} \phi(s_h^\tau, a_h^\tau) r_h^\tau \right),\tag{12}
$$

$$
\widehat{\nu}_{h,i}^{\rho,V} = \max_{\alpha \in [\min_s V(s), \max_s V(s)]} \left\{ \bar{\nu}_{h,i}^V(\alpha) - \rho \left( \alpha - \min_{s'} [V]_{\alpha}(s') \right) \right\}, \qquad \forall i \in [d], \tag{13}
$$

where  $\lambda_0 > 0$  is the regularization coefficient,  $\bar{\nu}_{h,i}^V(\alpha)$  is the *i*-th coordinate of  $\bar{\nu}_h^V(\alpha)$  defined by

$$
\bar{\nu}_h^V(\alpha) = \arg \min_{\nu \in \mathbb{R}^d} \sum_{\tau \in \mathcal{D}_h^0} \left( \phi(s_h^{\tau}, a_h^{\tau})^{\top} \nu - [V]_{\alpha}(s_{h+1}^{\tau}) \right)^2 + \lambda_0 \|\nu\|_2^2 = \Lambda_h^{-1} \left( \sum_{\tau \in \mathcal{D}_h^0} \phi(s_h^{\tau}, a_h^{\tau}) [V]_{\alpha}(s_{h+1}^{\tau}) \right), \tag{14}
$$

and the cumulative sample covariance matrix is denoted as

<span id="page-6-9"></span><span id="page-6-6"></span><span id="page-6-4"></span><span id="page-6-3"></span>
$$
\Lambda_h = \sum_{\tau \in \mathcal{D}_h^0} \phi(s_h^{\tau}, a_h^{\tau}) \phi(s_h^{\tau}, a_h^{\tau})^{\top} + \lambda_0 I_d.
$$
\n(15)

Then following the linearity of the robust Bellman operator shown in Lemma [1,](#page-5-0) we construct the empirical robust Bellman operator  $\widehat{\mathbb{B}}_h^{\rho}$  to approximate  $\mathbb{B}_h^{\rho}$ , using the estimators obtained from [\(12\)](#page-6-3) and [\(13\)](#page-6-4): for any value function  $V : \mathcal{S} \to [0, H],$

$$
(\widehat{\mathbb{B}}_h^{\rho} V)(s, a) = \phi(s, a)^{\top} (\widehat{\theta}_h + \widehat{\nu}_h^{\rho, V}), \qquad \forall (s, a, h) \in \mathcal{S} \times \mathcal{A} \times [H].
$$
\n
$$
(16)
$$

### <span id="page-7-0"></span>3.2 DROP: distributionally robust pessimistic least-squares value iteration

To compute [\(16\)](#page-6-5) for all time steps  $h \in [H]$  recursively, we propose a distributionally robust pessimistic least-squares value iteration algorithm, referred to as DROP and summarized as Algorithm [1.](#page-7-2)

In Algorithm [1,](#page-7-2) we first construct a dataset  $\mathcal{D}_0$  by subsampling from  $\mathcal D$  by Two-fold-subsampling (cf. Al-gorithm [2\)](#page-18-1), inspired by [Li et al.](#page-12-7) [\(2024\)](#page-12-7) to tackle the statistical dependency between different time steps  $h \in$  $[H]$  in the original batch dataset  $D$ . As the space is limited, we defer the details of Two-fold-subsampling and the corresponding statistical independence property to Section [B.2.](#page-17-2) With  $\mathcal{D}_0$  in hand and initializations  $\hat{Q}_{H+1}(\cdot,\cdot) = 0$  and  $\hat{V}_{H+1}(\cdot) = 0$ , the updates at time step h in DROP can be boiled down to the following two steps. The first one is to construct the empirical robust Bellman operator via  $(12)-(16)$  $(12)-(16)$  conditioned on a fixed  $V_{h+1}$  from the previous iteration (see the line 3-8 in Algorithm [1\)](#page-7-2). Then we can estimate the robust Q-function from the pessimistic value iteration as below:

$$
\bar{Q}_h(s, a) = \widehat{\mathbb{B}}_h^{\rho}(\widehat{V}_{h+1})(s, a) - \underbrace{\gamma_0 \sum_{i=1}^d \|\phi_i(s, a)\mathbb{1}_i\|_{\Lambda_h^{-1}}}_{\text{penalty function } \Gamma_h: \mathcal{S} \times \mathcal{A} \to \mathbb{R}}, \quad \forall (s, a) \in \mathcal{S} \times \mathcal{A},
$$

where  $\gamma_0 > 0$  is the coefficient of the penalty term.

The above pessimistic principle is widely advocated in both standard and robust offline RL [\(Jin et al.,](#page-12-5) [2021;](#page-12-5) [Xiong et al.,](#page-14-2) [2023](#page-14-2); [Shi and Chi,](#page-13-1) [2022\)](#page-13-1). When dealing with the uncertainty set characterized by TV distance, previous penalty designs tailored for standard linear MDPs [\(Jin et al.,](#page-12-5) [2021;](#page-12-5) [Xiong et al.](#page-14-2), [2023](#page-14-2)) and robust linear MDPs specifically addressing KL divergence [\(Ma et al.](#page-13-2), [2022](#page-13-2)), are no longer applicable. To this end, we carefully devise the penalty function, denoted as  $\Gamma_h$ , for Lin-RMDPs with TV distance. Compared to the prior art [\(Blanchet et al.](#page-12-2), [2024\)](#page-12-2) which promotes pessimism by solving an inner constrained optimization problem, our proposed penalty function efficiently addresses the uncertainty in every feature dimension  $i \in [d]$ , which plays a crucial role in improving the sub-optimality gap.

### <span id="page-7-1"></span>3.3 Performance guarantees of DROP

Next, we provide the theoretical guarantees for DROP, under different assumptions on the batch data quality. We start without any coverage assumption on the batch dataset  $\mathcal{D}$ , where the proof is postponed to Appendix [B.3.](#page-18-0)

<span id="page-8-0"></span>**Theorem [1](#page-4-2).** Consider any  $\delta \in (0,1)$ . Suppose that Assumption 1 and [2](#page-4-1) hold. By setting

$$
\lambda_0 = 1
$$
,  $\gamma_0 = 6\sqrt{d\xi_0}H$ , where  $\xi_0 = \log(3HK/\delta)$ ,

one has with the probability at least  $1 - 3\delta$  $1 - 3\delta$ , the policy  $\hat{\pi}$  generated by Algorithm 1 satisfies

<span id="page-8-3"></span>
$$
\text{SubOpt}(\widehat{\pi}; \zeta, \mathcal{P}^{\rho}) \le \widetilde{O}(\sqrt{d}H) \sum_{h=1}^{H} \sum_{i=1}^{d} \max_{P \in \mathcal{P}^{\rho}(P^0)} \mathbb{E}_{\pi^{\star}, P} \left[ \|\phi_i(s_h, a_h)\mathbb{1}_i\|_{\Lambda_h^{-1}} \right]. \tag{17}
$$

Since we do not impose any coverage assumption on the batch data, Theorem [1](#page-8-0) demonstrates an "instancedependent" sub-optimality gap, which can be controlled by some general term (the right hand side of [\(17\)](#page-8-3)) and the confidence level  $\delta$ . The sub-optimality gap largely depends on the quality of the batch data – specifically, how well it explores the feature space within  $\mathbb{R}^d$ . Building upon the above foundational result, we proceed to examine the sample complexity required to achieve an  $\epsilon$ -optimal policy, considering different data qualities in the subsequent discussion.

#### <span id="page-8-2"></span>3.3.1 The case of partial feature coverage

We first consider the partial feature coverage, which only compares the behavior policy with the optimal policy, in terms of the ability to explore each feature dimension. To accommodate with our Lin-RMDPs, we propose a tailored partial data coverage assumption, which depicts the worst-case dissimilarity between the optimal robust policy  $\pi^*$  in any transition kernel  $P \in \mathcal{P}(\mathcal{P}^0)$  and the behavior policy  $\pi^{\text{b}}$  in the nominal kernel  $P^0$  over every feature space dimension  $i \in [d]$ , as follows.

<span id="page-8-4"></span>**Assumption 3** (Robust single-policy clipped concentrability). The behavior policy of the batch dataset  $D$ satisfies

<span id="page-8-5"></span>
$$
\max_{(u,h,i,P)\in\mathbb{R}^d\times[H]\times[H]\times\mathcal{P}^{\rho}(P^0)}\frac{u^\top\left(\min\{\mathbb{E}_{d_h^{*,P}}\phi_i^2(s,a),1/d\}\cdot\mathbb{1}_{i,i}\right)u}{u^\top\left(\mathbb{E}_{d_h^{\text{b}}}[\phi(s,a)\phi(s,a)^\top]\right)u} \leq \frac{C_{\text{rob}}^\star}{d},\tag{18}
$$

for some finite quantity  $C_{\text{rob}}^* \in [1,\infty)$ . In addition, we follow the convention  $0/0 = 0$ .

The quantity  $C_{\text{rob}}^{\star}$  measures the expected quality of batch data, by comparing to the desired dataset associated with the optimal robust policy. Intuitively,  $C_{\text{rob}}^{\star}$  decreases as the batch dataset contains more expert data, and increases when the quality of the dataset is poorer — generated from some policy far from the optimal policy. Note that prior knowledge of  $C_{\text{rob}}^{\star}$  is not required when implementing DROP in practice. Here, we assume  $C_{\text{rob}}^* < \infty$ , which requires that the behavior policy is able to explore the same feature dimensions as the optimal robust policy. Under Assumption [3,](#page-8-4) the following corollary provides the provable sample complexity of DROP to achieve an  $\epsilon$ -optimal robust policy. The proof is postponed to Appendix [B.4.](#page-26-0)

<span id="page-8-1"></span>**Corollary [1](#page-8-0)** (Partial feature coverage). With Theorem 1 and Assumption [3](#page-8-4) hold and consider any  $\delta \in (0,1)$ . Let  $d_{\text{min}}^{\text{b}} = \min_{h,s,a} \{d_h^{\text{b}}(s,a) : d_h^{\text{b}}(s,a) > 0\}$ . With probability exceeding  $1 - 4\delta$ , the policy  $\hat{\pi}$  returned by Algorithm [1](#page-7-2) achieves

$$
\textrm{SubOpt}(\widehat{\pi}; \zeta, \mathcal{P}^{\rho}) \leq 96\sqrt{\frac{d^2H^4C_{\rm rob}^{\star} \log(3HK/\delta)}{K}}
$$

as long as  $K \geq c_0 \log(KH/\delta)/d_{\min}^{\rm b}$  for some sufficiently large universal constant  $c_0 > 0$ . In other words, the learned policy  $\hat{\pi}$  is  $\epsilon$ -optimal if the total number of sample trajectories satisfies

<span id="page-8-6"></span>
$$
K \ge \tilde{O}\left(\frac{C_{\rm rob}^{\star} d^2 H^4}{\epsilon^2}\right). \tag{19}
$$

Notice that Corollary [1](#page-8-1) implies the sub-optimality bound of DROP is comparable to that of the prior art in standard linear MDPs [\(Jin et al.,](#page-12-5) [2021,](#page-12-5) Corollary 4.5), in terms of the feature dimension d and the horizon length  $H$ .

Comparisons to prior art for Lin-RMDPs. With high probability, the existing Assumption 6.2 proposed in [Blanchet et al.](#page-12-2) [\(2024\)](#page-12-2) can be transferred into the following condition (see [\(66\)](#page-26-1)-[\(68\)](#page-27-0) in Appendix [B.4\)](#page-26-0):

$$
\max_{(u,h,i,P)\in\mathbb{R}^d\times[H]\times[H]\times\mathcal{P}^\rho(P^0)}\frac{u^\top\left(\mathbb{E}_{d_h^{*,P}}\phi_i^2(s,a)\cdot\mathbb{1}_{i,i}\right)u}{u^\top\left(\mathbb{E}_{d_h^{\text{b}}}[\phi(s,a)\phi(s,a)^\top]\right)u}\leq C_1^{\star}\in[1,\infty). \tag{20}
$$

Thanks to the clipping operation in [\(18\)](#page-8-5),  $C_{\text{rob}}^* \leq d \cdot C_1^*$  for any given batch dataset  $\mathcal{D}$ . Notice that both  $C_{\text{rob}}^{\star}$  and  $C_{1}^{\star}$  are lower bounded by 1. The proposed algorithm in [Blanchet et al.](#page-12-2) [\(2024](#page-12-2)) can achieve  $\epsilon$ -accuracy provided that the total number of sample trajectories obeys

$$
K \ge \widetilde{O}\Big(\frac{C_1^{\star} d^4 H^4}{\epsilon^2}\Big).
$$

It shows that the sample complexity [\(19\)](#page-8-6) of DROP improves the one in [Blanchet et al.](#page-12-2) [\(2024\)](#page-12-2) by at least  $\tilde{O}(d)$ .

#### 3.3.2 The case of full feature coverage

Then, we introduce the following full feature coverage assumption that is also widely used in standard offline linear MDPs [\(Jin et al.](#page-12-5), [2021;](#page-12-5) [Xiong et al.](#page-14-2), [2023;](#page-14-2) [Yin et al.,](#page-14-5) [2022](#page-14-5); [Ma et al.](#page-13-2), [2022\)](#page-13-2), which requires the behavior policy exploring the feature space uniformly well.

<span id="page-9-3"></span>**Assumption 4** (Well-explored data coverage). We assume  $\kappa = \min_{h \in [H]} \lambda_{\min}(\mathbb{E}_{d_h^b}[\phi(s, a)\phi(s, a)^\top]) > 0$ .

Compared to Assumption [3,](#page-8-4) Assumption [4](#page-9-3) necessitates the behavior policy to be more exploratory to reach every feature dimension, which is a stronger assumption requiring full coverage of all feature dimensions. The following corollary provides the sample complexity guarantee of DROP under the full feature coverage, where the proof is postponed to Appendix [B.5.](#page-28-0)

<span id="page-9-2"></span>**Corollary 2** (Full feature coverage). With Theorem [1](#page-8-0) and Assumption [4](#page-9-3) hold and consider any  $\delta \in (0,1)$ . Let  $d_{\text{min}}^{\text{b}} = \min_{h,s,a} \{d_h^{\text{b}}(s,a) : d_h^{\text{b}}(s,a) > 0\}$ . With probability at least  $1-5\delta$ , the policy  $\hat{\pi}$  returned by Algorithm [1](#page-7-2) achieves

$$
\text{SubOpt}(\widehat{\pi}; \zeta, \mathcal{P}^{\rho}) \leq 96 \sqrt{\frac{d H^4 \log(3HK/\delta)}{\kappa K}},
$$

as long as  $K \ge \max\{c_0 \log(2Hd/\delta)/\kappa^2, c_0 \log(KH/\delta)/d_{\min}^b\}$  for some sufficiently large universal constant  $c_0$ . In other words, the learned policy  $\hat{\pi}$  is  $\epsilon$ -optimal if the total number of sample trajectories satisfies

<span id="page-9-4"></span>
$$
K \ge \tilde{O}\left(\frac{dH^4}{\kappa \epsilon^2}\right). \tag{21}
$$

Notice that the sample complexity in [\(21\)](#page-9-4) matches the prior arts in standard linear MDPs [\(Yin et al.,](#page-14-5) [2022;](#page-14-5) [Xiong et al.,](#page-14-2) [2023\)](#page-14-2) when robustness is not considered. A careful reader may observe that [\(21\)](#page-9-4) has better dependency on d compared to [\(19\)](#page-8-6). While noting that the upper bound of  $\kappa$  is  $1/d$  [\(Wang et al.,](#page-14-17) [2021\)](#page-14-17), the sample complexity of DROP (cf. [\(21\)](#page-9-4)) is at least  $\tilde{O}(d^2H^4/\epsilon^2)$ .

## <span id="page-9-0"></span>4 Tightening the Sample Complexity by Leveraging Variance Estimation

To tighten our results, we further explore the variance information to reweight the ridge regression in DROP and develop its variance-aware variant called DROP-V. The key idea is to design a tighter penalty term with the estimated variance, which is widely used in standard linear MDPs [\(Zhou et al.,](#page-15-6) [2021a;](#page-15-6) [Min et al.,](#page-13-8) [2021;](#page-13-8) [Yin et al.,](#page-14-5) [2022;](#page-14-5) [Xiong et al.](#page-14-2), [2023](#page-14-2)) to achieve near-optimal results.

#### <span id="page-9-1"></span>4.1 DROP-V: a variance-aware variant of DROP

We first highlight the design features of DROP-V that are different from DROP, which can boiled down to the following two steps.

Constructing a variance estimator. First, we run the Algorithm [1](#page-7-2) on a sub-dataset  $\tilde{\mathcal{D}}^0 \in \mathcal{D}$  to obtain the estimated value function  $\{\tilde{V}_h\}_{h=1}^{H+1}$ . Then with  $\{\tilde{V}_h\}_{h=1}^{H+1}$  at our hands, we design the variance estimator  $\widehat{\sigma}_h^2 : \mathcal{S} \times \mathcal{A} \to [1, H^2]$  by

<span id="page-10-0"></span>
$$
\widehat{\sigma}_h^2(s, a) = \max\{ [\phi(s, a)^\top \nu_{h, 1}]_{[0, H^2]} - ([\phi(s, a)^\top \nu_{h, 2}]_{[0, H]})^2, 1 \}, \quad \forall (s, a, h) \in \mathcal{S} \times \mathcal{A} \times [H],
$$
 (22)

where  $\nu_{h,1}$  and  $\nu_{h,2}$  are obtained from ridge regression as follows:

$$
\nu_{h,1} = \arg \min_{\nu \in \mathbb{R}^d} \sum_{\tau \in \tilde{\mathcal{D}}_h^0} \left( \phi(s_h^{\tau}, a_h^{\tau})^{\top} \nu - (\tilde{V}_{h+1}(s_{h+1}^{\tau}))^2 \right)^2 + ||\nu||_2^2, \tag{23}
$$

$$
\nu_{h,2} = \arg \min_{\nu \in \mathbb{R}^d} \sum_{\tau \in \tilde{\mathcal{D}}_h^0} \left( \phi(s_h^{\tau}, a_h^{\tau})^{\top} \nu - \tilde{V}_{h+1}(s_{h+1}^{\tau}) \right)^2 + ||\nu||_2^2.
$$
 (24)

Notice that the technique of variance estimation is also used in [Xiong et al.](#page-14-2) [\(2023\)](#page-14-2); [Yin et al.](#page-14-5) [\(2022\)](#page-14-5) for standard linear MDPs, while we address the temporal dependency via a carefully designed three-fold subsampling approach detailed in Appendix [C.2.](#page-30-0)

Variance-weighted ridge regression. Incorporating with the variance estimator  $\hat{\sigma}_h^2$  computed on  $\tilde{\mathcal{D}}^0$ , we replace the ridge regression updates (i.e.  $(12)$  and  $(14)$ ) by their variance-weighted counterparts as follows:

$$
\widehat{\theta}_{h}^{\sigma} = \arg\min_{\theta \in \mathbb{R}^{d}} \sum_{\tau \in \mathcal{D}_{h}^{0}} \frac{\left(\phi(s_{h}^{\tau}, a_{h}^{\tau})^{\top}\theta - r_{h}^{\tau}\right)^{2}}{\widehat{\sigma}_{h}^{2}(s_{h}^{\tau}, a_{h}^{\tau})} + \lambda_{1} \|\theta\|_{2}^{2} = \Sigma_{h}^{-1} \Big(\sum_{\tau \in \mathcal{D}_{h}^{0}} \frac{\phi(s_{h}^{\tau}, a_{h}^{\tau})r_{h}^{\tau}}{\widehat{\sigma}_{h}^{2}(s_{h}^{\tau}, a_{h}^{\tau})}\Big),\tag{25}
$$

$$
\bar{\nu}_h^{\rho,\sigma,V}(\alpha) = \arg\min_{\nu \in \mathbb{R}^d} \sum_{\tau \in \mathcal{D}_h^0} \frac{\left(\phi(s_h^{\tau}, a_h^{\tau})^{\top} \nu - [V]_{\alpha}(s_{h+1}^{\tau})\right)^2}{\hat{\sigma}_h^2(s_h^{\tau}, a_h^{\tau})} + \lambda_1 \|\nu\|_2^2 = \Sigma_h^{-1} \Big(\sum_{\tau \in \mathcal{D}_h^0} \frac{\phi(s_h^{\tau}, a_h^{\tau}) [V]_{\alpha}(s_{h+1}^{\tau})}{\hat{\sigma}_h^2(s_h^{\tau}, a_h^{\tau})}\Big),\tag{26}
$$

for any value function  $V : \mathcal{S} \to [0, H]$  and  $h \in [H]$ , where

<span id="page-10-3"></span><span id="page-10-2"></span>
$$
\Sigma_h := \sum_{\tau \in \mathcal{D}_h^0} \frac{\phi(s_h^{\tau}, a_h^{\tau}) \phi(s_h^{\tau}, a_h^{\tau})^{\top}}{\hat{\sigma}_h^2(s_h^{\tau}, a_h^{\tau})} + \lambda_1 I_d
$$

with the regularization coefficient  $\lambda_1$  and  $\mathcal{D}^0$  is another sub-dataset of  $\mathcal D$  that is independent of  $\tilde{\mathcal{D}}^0$ . Accordingly, DROP-V constructs an empirical variance-aware robust Bellman operator as

$$
(\widehat{\mathbb{B}}_h^{\rho,\sigma} V)(s,a) = \phi(s,a)^\top (\widehat{\theta}_h^{\sigma} + \widehat{\nu}_h^{\rho,\sigma,V}), \tag{27}
$$

where the *i*-th coordinate of  $\widehat{\nu}_h^{\rho,\sigma,V}$  is defined as

<span id="page-10-1"></span>
$$
\widehat{\nu}_{h,i}^{\rho,\sigma,V} = \max_{\alpha \in [\min_s V(s), \max_s V(s)]} \left\{ \bar{\nu}_{h,i}^{\rho,\sigma,V}(\alpha) - \rho(\alpha - \min_{s'} V(s')) \right\}.
$$
\n(28)

Similar to DROP, we also perform the pessimistic value iterations, where the estimated Q function is updated by

$$
\bar{Q}_h(s, a) = \widehat{\mathbb{B}}_h^{\rho, \sigma}(\widehat{V}_{h+1})(s, a) - \underbrace{\gamma_1 \sum_{i=1}^d \|\phi_i(s, a)\mathbb{1}_i\|_{\Sigma_h^{-1}}}_{\text{penalty function } \Gamma_h^{\sigma} : S \times A \to \mathbb{R}} , \quad \forall (s, a, h) \in S \times A \times [H],
$$

with a fixed, estimated  $\hat{V}_{h+1}$  obtained from previous iteration and some coefficient  $\gamma_1 > 0$ .

The rest of DROP-V follows the procedure described in Algorithm [1.](#page-7-2) To avoid redundancy, the detailed implementation of DROP-V is provided in Appendix [C.1.](#page-29-2)

#### <span id="page-11-0"></span>4.2 Performance guarantees of DROP-V

<span id="page-11-2"></span>Then, we are ready to present our improved results, where the proof is postponed to Appendix [C.3.](#page-33-0)

**Theorem 2.** Suppose that Assumption [1,](#page-4-2) [2,](#page-4-1) and [4](#page-9-3) hold and consider any  $\delta \in (0,1)$ . In DROP-V, we set

$$
\lambda_1 = 1/H^2, \gamma_1 = \xi_1 \sqrt{d}, \quad \text{where } \xi_1 = 66 \log(3HK/\delta).
$$

Provided that  $\sqrt{d} \geq H$  and  $K \geq \widetilde{O}\left(\frac{H^4 + H^6 d\kappa}{\kappa^2} + \frac{1}{d_{\min}^b}\right)$ , then with probability exceeding  $1 - \delta$ , the robust policy  $\hat{\pi}$  learned by DROP-V satisfies

$$
\text{SubOpt}(\widehat{\pi}; \zeta, \mathcal{P}^{\rho}) \le \widetilde{O}(\sqrt{d}) \sum_{h=1}^{H} \sum_{i=1}^{d} \max_{P \in \mathcal{P}^{\rho}(P^0)} \mathbb{E}_{\pi^\star, P} \left[ \|\phi_i(s_h, a_h) \mathbb{1}_i\|_{(\Sigma_h^\star)^{-1}} \right],\tag{29}
$$

where the variance-weighted cumulative sample covariance matrix  $\Sigma_h^{\star}$  is defined by

<span id="page-11-6"></span>
$$
\Sigma_h^* = \sum_{\tau \in \mathcal{D}_h^0} \frac{\phi(s_h^{\tau}, a_h^{\tau}) \phi(s_h^{\tau}, a_h^{\tau})^{\top}}{\max\{1, \text{Var}_{P_h^0}[V_{h+1}^{\star,\rho}](s_h^{\tau}, a_h^{\tau})\}} + \frac{1}{H^2} I_d,
$$
\n(30)

and  $\text{Var}_{P_h^0}[V](s, a) = \int_{\mathcal{S}} P_{h, s, a}^0(s') V^2(s') ds' - (\int_{\mathcal{S}} P_{h, s, a}^0(s') V(s') ds')^2$  represents the conditional variance for any value function  $V : \mathcal{S} \to [0, H]$  and any  $(s, a, h) \in \mathcal{S} \times \mathcal{A} \times [H]$ .

Compared to the instance-dependent sub-optimality bound of DROP (cf. Theorem [1\)](#page-8-0), the above guarantee for DROP-V is tighter since  $H^2 \Lambda_h^{-1} \succeq (\Sigma_h^*)^{-1}$ . The underlying reason for the improvement is the use of the variance estimator to control the conditional variance and the tighter penalty function designed via the Bernstein-type inequality, while that of DROP depends on the Hoeffding-type counterpart.

## <span id="page-11-1"></span>5 Conclusion

In this paper, we investigate the sample complexity for distributionally robust offline RL when the model has linear representations and the uncertainty set can be characterized by TV distance. We develop a robust variant of pessimistic value iteration with linear function approximation, called DROP. We establish the suboptimality guarantees for DROP under various offline data assumptions. Compared to the prior art, DROP notably improves the sample complexity by at least  $O(d)$ , under the partial feature coverage assumption. We further incorporate DROP with variance estimation to develop an enhanced DROP, referred to as DROP-V, which improves the sub-optimality bound of DROP. In the future, it will be of interest to consider different choices of the uncertainty sets and establish the lower bound for the entire range of the uncertainty level.

= \phi(s,a)^{\top} \underbrace{\left( \theta_{h} + \inf_{\mu_{h} \in \mathcal{U}^{\rho}(\mu_{h}^{0})} \int_{S} \mu_{h}(s')f(s')ds' \right)}_{:=w_{h}^{\rho}},
$$

where the second equality is due to Assumption [1.](#page-4-2)

According to Lemma [8,](#page-17-3) for any value function  $V : \mathcal{S} \to [0, H]$  and any uncertainty set  $\mathcal{U}^{\rho}(\mu_{h,i}^0), \forall (h,i) \in$  $[H] \times [d]$  that satisfies Assumption [2,](#page-4-1) one has

\inf_{\mu_{h,i}\in\mathcal{U}^{\rho}(\mu_{h,i}^0)}\int_{S}\mu_{h,i}(s')V(s')\mathrm{d} s'=\max_{\alpha\in[\min_{s}V(s),\max_{s}V(s)]}\big\{\int_{\mathcal{S}}\mu_{h,i}(s')[V]_{\alpha}(s')\mathrm{d} s'-\rho(\alpha-\min_{s'}[V]_{\alpha}(s'))\big\}.
$$

Denote  $\nu_{h}^{\rho,V} = [\nu_{h,1}^{\rho,V}, \nu_{h,2}^{\rho,V}, \dots, \nu_{h,d}^{\rho,V}]^{\top} \in \mathbb{R}^d$ , where  $\nu_{h,i}^{\rho,V} = \max_{\alpha \in [\min_s V(s), \max_s V(s)]} \left\{ \int_{\mathcal{S}} \mu_{h,i}(s') [V]_{\alpha}(s') ds' \rho(\alpha - \min_{s'} [V]_{\alpha}(s'))$  for any  $i \in [d]$ . Therefore,

$$
(\mathbb{B}_h^{\rho} V)(s, a) = \phi(s, a)^{\top} (\theta_h + \nu_h^{\rho, V}).

#### <span id="page-17-2"></span>B.2 Two-fold subsampling method

To tackle the temporal dependency in batch dataset  $\mathcal{D}$ , we apply the insights from the subsampling approach inspired by [Li et al.](#page-12-7) [\(2024](#page-12-7)). The key idea is to utilize half of the data to establish a valid lower bound of the number of samples, which is employed to achieve the statistical independence in the remaining half of the dataset. The detailed implementation of the two-fold subsampling can be summarized in the Algorithm [2.](#page-18-2)

Recall that we assume the sample trajectories in  $\mathcal D$  are generated independently. Then, the following lemma shows that [\(34\)](#page-18-1) is a valid lower bound of  $N_h^{\text{main}}(s)$  for any  $s \in \mathcal{S}$  and  $h \in [H]$ , which can be obtained by a slight modification on Lemma 3 and Lemma 7 in [Li et al.](#page-12-7) [\(2024\)](#page-12-7)

#### <span id="page-18-2"></span>Algorithm 2 Two-fold-subsampling

**Input:** Batch dataset  $\mathcal{D}$ ;

- 1: **Split Data:** Split  $D$  into two haves  $D^{\text{main}}$  and  $D^{\text{aux}}$ , where  $|\mathcal{D}^{\text{main}}| = |\mathcal{D}^{\text{aux}}| = N_h/2$ . Denote  $N_h^{\text{main}}(s)$ (resp.  $N_h^{\text{aux}}(s)$ ) as the number of sample transitions from state s at step h in  $\mathcal{D}^{\text{main}}$  (resp.  $\mathcal{D}^{\text{aux}}$ ).

3: Construct the almost temporally statistically independent  $\mathcal{D}^{\text{trim}}$ : Let  $\mathcal{D}_h^{\text{main}}(s)$  denote the dataset containing all transition-reward sample tuples at the current state s and step h from  $\mathcal{D}^{\text{main}}$ . For any  $(s, h) \in \mathcal{S} \times [H]$ , subsample  $\min\{N_h^{\text{trim}}(s), N_h^{\text{main}}(s)\}\)$  transition-reward sample tuples randomly from  $\mathcal{D}_h^{\text{main}}(s)$ , denoted as  $\mathcal{D}^{\text{main,sub}}$ .

**Ouput:**  $\mathcal{D}^0 = \mathcal{D}^{\text{main,sub}}$ .

<span id="page-18-6"></span>**Lemma 9.** With probability at least  $1-2\delta$ , if  $N_h^{\text{trim}}(s)$  satisfies [\(34\)](#page-18-1) for every  $s \in S$  and  $h \in [H]$ , then  $\mathcal{D}^0 :=$  $\mathcal{D}^{\text{main,sub}}$  contains temporally statistically independent samples and the following bound holds simultaneously, i.e.,

In addition, with probability at least  $1 - 3\delta$ , the following lower bound also holds, i.e.,

$$
N^{\text{trim}}_{h}(s, a) \geq \frac{K d^b_h(s, a)}{8} - 5\sqrt{K d^b_h(s, a) \log(\frac{KH}{\delta})}, \quad \forall (s, a, h) \in \mathcal{S} \times \mathcal{A} \times [H].
$$

*Proof.* Let  $S_D$  be the collection of all the states appearing in any batch dataset D, where  $|S_D| \leq K$ . By changing the union bound over S to  $S<sub>D</sub>$  in the proof of [Li et al.](#page-12-7) [\(2024](#page-12-7), Lemma 3), the remaining proof still holds, since  $N_h^{\text{trim}}(s) = N_h^{\text{main}}(s) = 0, \forall s \notin S_D$ . Together with [Li et al.](#page-12-7) [\(2024,](#page-12-7) Lemma 7),  $\mathcal{D}^0$  contains temporally statistically independent samples if  $N_h^{\text{trim}}(s) \le N_h^{\text{main}}(s)$ ,  $\forall (s, h) \in S \times [H]$ .  $\Box$

where  $\mathbb{1}(\cdot)$  is the indicator function. Accordingly, it holds that  $\bar{\nu}_h^{\hat{V}}(\alpha) = \int_{\mathcal{S}} \hat{\mu}_h(s')[\hat{V}_{h+1}(s')]_{\alpha}ds' \in \mathbb{R}^d$ . We denote the set of all the possible state occupancy distributions associated with the optimal policy  $\pi^*$  and any  $P \in \mathcal{P}^{\rho}(P^0)$  as

$$
\mathcal{D}_h^{\star} = \left\{ \left[ d_h^{\star, P}(s) \right]_{s \in \mathcal{S}} : P \in \mathcal{P}^{\rho}(P^0) \right\} = \left\{ \left[ d_h^{\star, P}(s, \pi_h^{\star}(s)) \right]_{s \in \mathcal{S}} : P \in \mathcal{P}^{\rho}(P^0) \right\},\tag{37}
$$

for any time step  $h \in [H]$ .

#### B.3.1 Proof sketch for Theorem [1](#page-8-0)

<span id="page-19-0"></span>We first claim that Theorem [1](#page-8-0) holds as long as the following theorem can be established.

**Theorem 3.** Consider  $\delta \in (0,1)$  $\delta \in (0,1)$  $\delta \in (0,1)$ . Suppose that the dataset  $\mathcal{D}_0$  in Algorithm 1 contains  $N_h \leq K$  transitionreward sample tuples at every  $h \in [H]$ . Assume that conditional on  $\{N_h\}_{h \in [H]}$ , all the sample tuples in  $\mathcal{D}_h^0$ are statistically independent. Suppose that Assumption [1](#page-4-2) and [2](#page-4-1) hold. In DROP, we set

<span id="page-19-1"></span>
$$
\lambda_0 = 1, \quad \gamma_0 = 6\sqrt{d\xi_0}H, \quad \text{where } \xi_0 = \log(3HK/\delta). \tag{38}
$$

Here,  $\delta \in (0,1)$  is the confidence parameter and K is the upper bound of  $N_h$  for any  $h \in [H]$ . Then,  $\{\hat{\pi}_h\}_{h=1}^H$ generated by Algorithm [1,](#page-7-2) with the probability at least  $1 - \delta$ , satisfies

$$
\text{SubOpt}(\widehat{\pi}; \zeta, \mathcal{P}^{\rho}) \le \tilde{O}(\sqrt{d}H) \sum_{h=1}^{H} \sum_{i=1}^{d} \max_{d_h^{\star} \in \mathcal{D}_h^{\star}} \mathbb{E}_{d_h^{\star}} \left[ \|\phi_i(s_h, a_h)1\!\!1_i\|_{\Lambda_h^{-1}} \right].
$$

As the construction in Algorithm [2,](#page-18-2)  $\{N_h^{\text{trim}}(s)\}_{s\in\mathcal{S},h\in[H]}$  is computed using  $\mathcal{D}^{\text{aux}}$  that is independent of  $\mathcal{D}^0$ . From Lemma [14,](#page-30-1)  $N_h^{\text{trim}}(s)$  is a valid sampling number for any  $s \in \mathcal{S}$  and  $h \in [H]$  such that  $|\mathcal{D}_h^0| = \sum_{s \in \mathcal{S}} N_h^{\text{trim}}(s) \leq K$ , and  $\mathcal{D}_h^0$  can be treated as containing temporally statistically independent samples with probability exceeding  $1-2\delta$ . Therefore, by invoking Theorem [3](#page-19-0) with  $N_h := |\mathcal{D}_h^0|$ , we have

$$
\text{SubOpt}(\widehat{\pi}; \zeta, \mathcal{P}^{\rho}) \le \widetilde{O}(\sqrt{d}H) \sum_{h=1}^H \sum_{i=1}^d \max_{d_h^{\star} \in \mathcal{D}_h^{\star}} \mathbb{E}_{d_h^{\star}} \left[ \|\phi_i(s_h, a_h) \mathbb{1}_i\|_{\Lambda_h^{-1}} \right],
$$

with probability exceeding  $1 - 3\delta$ .

#### <span id="page-19-6"></span>B.3.2 Proof of Theorem [3](#page-19-0)

The proof of Theorem [3](#page-19-0) can be summarized as following key steps.

Step 1: establishing the pessimistic property. To substantiate the pessimism, we heavily depend on the following lemma, where the proof is postponed to Appendix [B.3.3.](#page-21-0)

<span id="page-19-5"></span>Lemma 10. Suppose all the assumptions in Theorem [3](#page-19-0) hold and follow all the parameters setting in [\(38\)](#page-19-1). Then for any  $(s, a, h) \in S \times A \times [H]$ , with probability at least  $1 - \delta$ , the value function  $\{\hat{V}\}_{h=1}^H$  generated by DROP satisfies

<span id="page-19-2"></span>
$$
|(\widehat{\mathbb{B}}_h^{\rho}\widehat{V}_{h+1})(s,a) - (\mathbb{B}_h^{\rho}\widehat{V}_{h+1})(s,a)| \le \Gamma_h(s,a) := \gamma_0 \sum_{i=1}^d \|\phi_i(s,a)\mathbb{1}_i\|_{\Lambda_h^{-1}}.
$$
 (39)

In the following, we will show that the following relations hold:

<span id="page-19-4"></span>
$$
Q_h^{\star,\rho}(s,a) \ge Q_h^{\widehat{\pi},\rho}(s,a) \ge \widehat{Q}_h(s,a) \quad \text{and} \quad V_h^{\star,\rho}(s) \ge V_h^{\widehat{\pi},\rho}(s) \ge \widehat{V}_h(s), \quad \forall (s,a,h) \in \mathcal{S} \times \mathcal{A} \times [H], \tag{40}
$$

if the condition [\(39\)](#page-19-2) holds. It implies that  $\hat{Q}_h(s, a)$  and  $\hat{V}_h(s)$  is the pessimistic estimates of  $Q_h^{\hat{\pi}, \rho}(s, a)$ and  $V_h^{\hat{\pi},\rho}(s)$  for any  $s \in \mathcal{S}$ , respectively. Notice that if  $Q_h^{\hat{\pi},\rho}(s,a) \ge \hat{Q}_h(s,a)$  for all  $(s,a) \in \mathcal{S} \times \mathcal{A}$ , one simultaneously has the following relation:

$$
V_h^{\hat{\pi},\rho}(s) = Q_h^{\hat{\pi},\rho}(s,\hat{\pi}_h(s)) \ge \widehat{Q}_h(s,\hat{\pi}_h(s)) = \widehat{V}_h(s), \qquad \forall (s,h) \in \mathcal{S} \times [H].
$$

Therefore, we shall verify that

<span id="page-19-3"></span>
$$
Q_h^{\hat{\pi},\rho}(s,a) \ge \widehat{Q}_h(s,a), \quad \forall (s,a) \in \mathcal{S} \times \mathcal{A}, \tag{41}
$$

by induction, and  $V_h^{\hat{\pi},\rho}(s) \geq \hat{V}_h(s)$  will spontaneously hold for  $s \in \mathcal{S}$ .

• At step  $h = H + 1$ : From the initialization step in Algorithm [1,](#page-7-2) we have  $Q_{H+1}^{\hat{\pi}, \rho}(s, a) = \hat{Q}_{H+1}(s, a) = 0$ , for any  $(s, a) \in S \times A$ , and  $(41)$  holds.

• For any step  $h \leq H$ : Suppose  $Q_{h+1}^{\hat{\pi},\rho}(s,a) \geq \hat{Q}_{h+1}(s,a)$ . From [\(40\)](#page-19-4), we have  $V_{h+1}^{\hat{\pi},\rho}(s) \geq \hat{V}_{h+1}(s)$ . Therefore, if  $\widehat{Q}_h(s, a) = 0$ ,  $Q_h^{\widehat{\pi}, \rho}(s, a) \ge 0 = \widehat{Q}_h(s, a)$ , for any  $(s, a) \in S \times A$ . Otherwise,

$$
\begin{split}\n\widehat{Q}_{h}(s,a) &\leq (\widehat{\mathbb{B}}_{h}^{\rho}\widehat{V}_{h+1})(s,a) - \Gamma_{h}(s,a) \\
&= (\mathbb{B}_{h}^{\rho}\widehat{V}_{h+1})(s,a) + (\widehat{\mathbb{B}}_{h}^{\rho}\widehat{V}_{h+1})(s,a) - (\mathbb{B}_{h}^{\rho}\widehat{V}_{h+1})(s,a) - \Gamma_{h}(s,a) \\
&\leq (\mathbb{B}_{h}^{\rho}\widehat{V}_{h+1})(s,a) + |(\widehat{\mathbb{B}}_{h}^{\rho}\widehat{V}_{h+1})(s,a) - (\mathbb{B}_{h}^{\rho}\widehat{V}_{h+1})(s,a)| - \Gamma_{h}(s,a) \\
&\leq (\mathbb{B}_{h}^{\rho}\widehat{V}_{h+1})(s,a) + \Gamma_{h}(s,a) - \Gamma_{h}(s,a) \\
&\leq (\mathbb{B}_{h}^{\rho}\widehat{V}_{h+1})(s,a) \\
&\leq (\mathbb{B}_{h}^{\rho}\widehat{V}_{h+1})(s,a) \\
&\leq (\mathbb{B}_{h}^{\rho}\widehat{V}_{h+1}^{\widehat{\pi},\rho})(s,a) = Q_{h}^{\widehat{\pi},\rho}(s,a),\n\end{split}
$$

where the first inequality is from the definition of  $\hat{Q}_h(s, a)$  (cf. Line 10 in Algorithm [1\)](#page-7-2), and third inequality is based on the condition [\(39\)](#page-19-2).

Combining these two cases, for any  $h \in [H+1]$ , we could verify the pessimistic property, i.e. the equation  $(40).$  $(40).$ 

Step 2: bounding the suboptimality gap. Notice that for any  $h \in [H]$  and any  $s \in \mathcal{S}$ ,

$$
V_h^{*,\rho}(s) - V_h^{\hat{\pi},\rho}(s) = V_h^{*,\rho}(s) - \hat{V}_h(s) + \hat{V}_h(s) - V_h^{\hat{\pi},\rho}(s)
$$
  
 
$$
\leq V_h^{*,\rho}(s) - \hat{V}_h(s),
$$
 (42)

where the inequality is due to the pessimistic property in [\(40\)](#page-19-4).

In the following, we will control the value difference, i.e.,  $V_h^{*,\rho}(s) - \widehat{V}_h(s)$ , for any  $(s, h) \in S \times [H]$ . First, recall the definition of  $V_h$  (cf. Line 12 in Algorithm [1\)](#page-7-2) and the robust Bellman consistency equation [\(2\)](#page-5-4). For all  $s \in \mathcal{S}$ ,

V_h^{\star,\rho}(s) - \widehat{V}_h(s) = Q_h^{\star,\rho}(s, \pi_h^{\star}(s)) - \widehat{Q}_h(s, \widehat{\pi}_h(s))
$$
  
 
$$
\leq Q_h^{\star,\rho}(s, \pi_h^{\star}(s)) - \widehat{Q}_h(s, \pi_h^{\star}(s)),
$$
 (43)

where the last inequality is from  $\hat{\pi}_h$  is the greedy policy with respect to  $\hat{Q}_h$  (cf. Line 11 in Algorithm [1.](#page-7-2)) From the definition of the model evaluation error (i.e., equation [\(35\)](#page-18-3)) and the robust Bellman optimality equation  $(6)$ , we have

$$
\begin{aligned}\n\widehat{Q}_h(s, a) &= (\mathbb{B}_h^{\rho} \widehat{V}_{h+1})(s, a) - \iota_h(s, a), & \forall (s, a) \in \mathcal{S} \times \mathcal{A}, \\
Q_h^{\star, \rho}(s, a) &= (\mathbb{B}_h^{\rho} V_{h+1}^{\star, \rho})(s, a) & \forall (s, a) \in \mathcal{S} \times \mathcal{A},\n\end{aligned}
$$

which leads to

<span id="page-20-0"></span>
$$
Q_h^{\star,\rho}(s,\pi_h^{\star}(s)) - \widehat{Q}_h(s,\pi_h^{\star}(s)) = (\mathbb{P}_h^{\rho} V_{h+1}^{\star,\rho})(s,\pi_h^{\star}(s)) - (\mathbb{P}_h^{\rho} \widehat{V}_{h+1})(s,\pi_h^{\star}(s)) + \iota_h(s,\pi_h^{\star}(s)), \quad \forall s \in \mathcal{S}.
$$
 (44)

Denote

$$
P_{h,s,\pi_h^{\star}(s)}^{\text{inf},\widehat{V}}(\cdot) := \underset{P(\cdot) \in \mathcal{P}^{\rho}(P_{h,s,\pi_h^{\star}(s)}^0)}{\text{arg min}} \int_{S} P(s') \widehat{V}_{h+1}(s') \text{d}s'. \tag{45}
$$

Therefore, [\(44\)](#page-20-0) becomes

<span id="page-20-1"></span>
$$
Q_h^{\star,\rho}(s,\pi_h^{\star}(s)) - \widehat{Q}_h(s,\pi_h^{\star}(s)) \le \int_{\mathcal{S}} P_{h,s,\pi_h^{\star}(s)}^{\text{inf},\widehat{V}}(s') \left( V_{h+1}^{\star,\rho}(s') - \widehat{V}_{h+1}(s') \right) \mathrm{d}s' + \iota_h(s,\pi_h^{\star}(s)), \quad \forall (s,a) \in \mathcal{S} \times \mathcal{A}.\tag{46}
$$

Substituting  $(46)$  into  $(43)$ , one has

$$
V_h^{\star,\rho}(s) - \widehat{V}_h(s) \le \int_{\mathcal{S}} P_{h,s,\pi_h^{\star}}^{\inf,\widehat{V}}(s') \left( V_{h+1}^{\star,\rho}(s') - \widehat{V}_{h+1}(s') \right) \mathrm{d}s' + \iota_h(s,\pi_h^{\star}(s)). \tag{47}
$$

For any  $h \in [H]$ , define  $\widehat{P}_{h,s}^{\text{inf}} : S \to S$  and  $\iota_h^{\star} \in S \to \mathbb{R}$  by

$$
\widehat{P}_h^{\text{inf}}(s) = P_{h,s,\pi_h^{\star}(s)}^{\text{inf},\widehat{V}}(\cdot) \quad \text{and} \quad \text{and} \quad \iota_h^{\star}(s) := \iota_h(s,\pi^{\star}(s)), \quad \forall s \in \mathcal{S}.\tag{48}
$$

By telescoping sum, we finally obtain that for any  $s \in \mathcal{S}$ ,

$$
V_h^{\star,\rho}(s) - \widehat{V}_h(s) = \langle \mathbb{1}_s, V_h^{\star,\rho} - \widehat{V}_h \rangle \le \left( \prod_{t=h}^H \widehat{P}_j^{\text{inf}} \right) \left( V_{H+1}^{\star,\rho} - \widehat{V}_{H+1} \right)(s) + \sum_{t=h}^H \left( \prod_{j=h}^{t-1} \widehat{P}_j^{\text{inf}} \right) \iota_t^{\star}(s)
$$

$$
= \sum_{t=h}^H \left( \prod_{j=h}^{t-1} \widehat{P}_j^{\text{inf}} \right) \iota_t^{\star}(s),
$$

where the equality is from  $V_{H+1}^{\star,\rho}(s) = \widehat{V}_{H+1}(s) = 0$  and  $\left(\prod_{j=t}^{t-1} \widehat{P}_j^{\text{inf}}\right)(s) = \mathbb{1}_s$ .

**Step 3: finishing up.** For any  $d_h^* \in \mathcal{D}_h^*$ , denote

$$
d_{h:t}^{\star} = d_h^{\star} \left( \prod_{j=h}^{t-1} \widehat{P}_j^{\text{inf}} \right) \in \mathcal{D}_t^{\star}.
$$

Together with  $(42)$ , the sub-optimality gap defined in  $(9)$  satisfies

$$
\text{SubOpt}(\widehat{\pi}; \zeta, \mathcal{P}^{\rho}) \leq \mathbb{E}_{s_1 \sim \zeta} V_1^{\star, \rho}(s_1) - \mathbb{E}_{s_1 \sim \zeta} \widehat{V}_1(s_1) \leq \sum_{t=1}^H \mathbb{E}_{s_t \sim d_{1:t}^{\star}} \iota_t^{\star}(s_t). \tag{49}
$$

For any  $h \in [H]$ , we let  $\Gamma_h^{\star} : \mathcal{S} \to \mathbb{R}$  satisfy

$$
\Gamma_h^{\star}(s) = \Gamma_h(s, \pi_h^{\star}(s)), \quad \forall s \in \mathcal{S}.
$$
\n
$$
(50)
$$

,

Combining Lemma [5](#page-16-0) together with Lemma [10](#page-19-5) will lead to

$$
\mathrm{SubOpt}(\widehat{\pi}; \zeta, \mathcal{P}^{\rho}) \leq 2 \sum_{h=1}^{H} \mathbb{E}_{s_h \sim d_{1:h}^{\star}} \Gamma_h^{\star}(s_h).
$$

Note that  $\Gamma_h^{\star}(s) = \gamma_0 \sum_{i=1}^d \|\phi_i(s, \pi_h^{\star}(s))\mathbb{1}_i\|_{\Lambda_h^{-1}}$  for any  $(s, h) \in \mathcal{S} \times [H]$ . Following the definition [\(37\)](#page-18-4), we have  $d_{1:h}^* \in \mathcal{D}_h^*$  and correspondingly,

$$
\text{SubOpt}(\widehat{\pi}; \zeta, \mathcal{P}^{\rho}) \le 2 \sum_{h=1}^{H} \mathbb{E}_{s_h \sim d_{1:h}^{\star}} \Gamma_h^{\star}(s_h)
$$
  

$$
\le 2\gamma_0 \sum_{h=1}^{H} \max_{d_h^{\star} \in \mathcal{D}_h^{\star}} \mathbb{E}_{(s_h, a_h) \sim d_h^{\star}} \left[ \sum_{i=1}^{d} \|\phi_i(s_h, a_h) \mathbb{1}_i\|_{\Lambda_h^{-1}} \right]
$$

with probability exceeding  $1 - \delta$ .

### <span id="page-21-0"></span>B.3.3 Proof of Lemma [10](#page-19-5)

To control  $|(\widehat{\mathbb{B}}_h^{\rho} \widehat{V}_{h+1})(s, a) - (\mathbb{B}_h^{\rho} \widehat{V}_{h+1})(s, a)|$  for any  $(s, a, h) \in \mathcal{S} \times \mathcal{A} \times [H]$ , we first show the following lemma, where the proof can be found in Appendix [B.3.4.](#page-23-0)

<span id="page-22-4"></span>**Lemma [1](#page-4-2)1.** Suppose Assumption 1 and [2](#page-4-1) hold. Then, for any  $(s, a, h) \in S \times A \times [H]$ , the estimated value function  $V_{h+1}$  generated by DROP satisfies

<span id="page-22-0"></span>
$$
\leq \left(\sqrt{\lambda_0 d}H + \max_{\alpha \in [\min_s \widehat{V}_{h+1}(s), \max_s \widehat{V}_{h+1}(s)]} \|\sum_{\tau \in \mathcal{D}_h^0} \phi(s_h^{\tau}, a_h^{\tau}) \epsilon_h^{\tau}(\alpha, \widehat{V}_{h+1})\|_{\Lambda_h^{-1}}\right) \sum_{i=1}^d \|\phi_i(s, a)\mathbb{1}_i\|_{\Lambda_h^{-1}},
$$
\n(51)

where  $\epsilon_h^{\tau}(\alpha, V) = \int_{S} P_h^0(s'|s_h^{\tau}, a_h^{\tau})[V]_{\alpha}(s')ds' - [V]_{\alpha}(s_{h+1}^{\tau})$  for any value function  $V : S \to [0, H], \alpha \in$  $[\min_s V(s), \max_s V(s)]$  and  $\tau \in \mathcal{D}_h^0$ .

We observe that the second term (i.e.,  $T_{1,h}$ ) in [\(51\)](#page-22-0) will become dominating, as long as  $\lambda_0$  is sufficiently small. In the following analysis, we will control  $T_{1,h}$  via uniform concentration and the concentration of self-normalized process.

Notice that  $\alpha$  and  $V_{h+1}$  are coupled with each other, which makes controlling  $T_{1,h}$  intractable. To this end, we propose the minimal  $\epsilon_0$ -covering set for  $\alpha$ . Since  $V_{h+1}(s) \in [0, H]$  for any  $s \in \mathcal{S}$ , we construct  $\mathcal{N}(\epsilon_0, H)$  as the minimal  $\epsilon_0$ -cover of the  $[0, H]$  whose size satisfies  $|\mathcal{N}(\epsilon_0, H)| \leq \frac{3H}{\epsilon_0}$ . In other words, for any  $\alpha \in [0, H]$ , there exists  $\alpha^{\dagger} \in \mathcal{N}(\epsilon_0, H)$ , we have

<span id="page-22-5"></span><span id="page-22-2"></span>
$$
|\alpha - \alpha^{\dagger}| \le \epsilon_0. \tag{52}
$$

Then we can rewrite  $T_{1,h}^2$  as

$$
T_{1,h}^{2} = \max_{\alpha \in [\min_{s} \widehat{V}_{h+1}(s), \max_{s} \widehat{V}_{h+1}(s)]} \|\sum_{\tau \in \mathcal{D}_{h}^{0}} \phi(s_{h}^{\tau}, a_{h}^{\tau}) \left(\epsilon_{h}^{\tau}(\alpha, \widehat{V}_{h+1}) - \epsilon_{h}^{\tau}(\alpha^{\dagger}, \widehat{V}_{h+1}) + \epsilon_{h}^{\tau}(\alpha^{\dagger}, \widehat{V}_{h+1})\right)\|_{\Lambda_{h}^{-1}}^{2}
$$
  
\n
$$
\leq \max_{\alpha \in [0, H]} 2 \|\sum_{\tau \in \mathcal{D}_{h}^{0}} \phi(s_{h}^{\tau}, a_{h}^{\tau}) \left(\epsilon_{h}^{\tau}(\alpha, \widehat{V}_{h+1}) - \epsilon_{h}^{\tau}(\alpha^{\dagger}, \widehat{V}_{h+1})\right)\|_{\Lambda_{h}^{-1}}^{2} + 2 \|\sum_{\tau \in \mathcal{D}_{h}^{0}} \phi(s_{h}^{\tau}, a_{h}^{\tau}) \epsilon_{h}^{\tau}(\alpha^{\dagger}, \widehat{V}_{h+1})\|_{\Lambda_{h}^{-1}}^{2}
$$
  
\n
$$
\leq 8\epsilon_{0}^{2} K^{2} / \lambda_{0} + 2 \|\sum_{\tau \in \mathcal{D}_{h}^{0}} \phi(s_{h}^{\tau}, a_{h}^{\tau}) \epsilon_{h}^{\tau}(\alpha^{\dagger}, \widehat{V}_{h+1})\|_{\Lambda_{h}^{-1}}^{2},
$$
\n
$$
\xrightarrow{\tau \in \mathcal{D}_{h}^{0}}
$$
\n(53)

for some  $\alpha^{\dagger} \in \mathcal{N}(\epsilon_0, H)$ , where the proof of the last inequality is postponed to Appendix [B.3.5.](#page-25-0) Alternatively,

<span id="page-22-3"></span>
$$
T_{2,h} \leq \sup_{\alpha \in \mathcal{N}(\epsilon_0, H)} \|\sum_{\tau \in \mathcal{D}_h^0} \phi(s_h^{\tau}, a_h^{\tau}) \epsilon_h^{\tau}(\alpha, \widehat{V}_{h+1}) \|_{\Lambda_h^{-1}}^2. \tag{54}
$$

Noted that the samples in  $\mathcal{D}^0$  are temporally statistically independent, i.e.,  $\hat{V}_{h+1}$  is independent of  $\mathcal{D}_h^0$ , or to say,  $\hat{\mu}_h$ . Therefore, we can directly control  $T_{2,h}$  via the following lemma.

<span id="page-22-1"></span>**Lemma 12** (Concentration of self-normalized process). Let  $V : S \rightarrow [0, H]$  be any fixed vector that is independent with  $\hat{\mu}_h$  and  $\alpha \in [0, H]$  be a fixed constant. For any fixed  $h \in [H]$  and any  $\delta \in (0, 1)$ , we have

$$
P_{\mathcal{D}}\left(\|\sum_{\tau\in\mathcal{D}_h^0}\phi(s^\tau_h,a^\tau_h)\epsilon^\tau_h(\alpha,V)\|_{\Lambda_h^{-1}}^2>H^2\left(2\cdot\log(1/\delta)+d\cdot\log(1+N_h/\lambda_0)\right)\right)\leq\delta.
$$

The proof of Lemma [12](#page-22-1) is postponed to Appendix [B.3.6.](#page-25-1) Then applying Lemma [12](#page-22-1) and the union bound over  $\mathcal{N}(\epsilon_0, H)$ , we have

$$
P_{\mathcal{D}}\left(\sup_{\alpha\in\mathcal{N}(\epsilon_0,H)}\|\sum_{\tau\in\mathcal{D}_h^0}\phi(s_h^\tau,a_h^\tau)\epsilon_h^\tau(\alpha,\widehat{V}_{h+1})\|_{\Lambda_h^{-1}}^2\geq H^2(2\log(H|\mathcal{N}(\epsilon_0,H)|/\delta)+d\log(1+N_h/\lambda_0))\right)
$$

 $\leq \delta/H$ ,

for any fixed  $h \in [H]$ . According to [Vershynin](#page-14-18) [\(2018\)](#page-14-18), one has  $|\mathcal{N}(\epsilon_0, H)| \leq \frac{3H}{\epsilon_0}$ . Taking the union bound for any  $h \in [H]$ , we arrive at

<span id="page-23-1"></span>
$$
\sup_{\alpha \in \mathcal{N}(\epsilon_0, H)} \|\sum_{\tau \in \mathcal{D}_h^0} \phi(s_h^{\tau}, a_h^{\tau}) \epsilon_h^{\tau}(\alpha, \widehat{V}_{h+1})\|_{\Lambda_h^{-1}}^2 \le 2H^2 \log(\frac{3H^2}{\epsilon_0 \delta}) + H^2 d \log(1 + \frac{K}{\lambda_0}),\tag{55}
$$

with probability exceeding  $1 - \delta$ , where we utilize  $N_h \leq K$  for every  $h \in [H]$  on the right-hand side.

Combining  $(53)$ ,  $(54)$  and  $(55)$ , we have

$$
T_{1,h}^{2} \le 8\epsilon_0^2 K^2/\lambda_0 + 4H^2 \log(\frac{3H^2}{\epsilon_0 \delta}) + 2H^2 d \log(1 + \frac{K}{\lambda_0}),
$$

with probability at least  $1 - \delta$ . Let  $\epsilon_0 = H/K$  and  $\lambda_0 = 1$ . Then,

$$
T_{1,h}^2 \le 8H^2 + 4H^2 \log(\frac{3HK}{\delta}) + 2H^2 d \log(1+K)
$$
  

$$
\le 8H^2 + 4H^2 \log(3HK/\delta) + 2dH^2 \log(2K).
$$

Let  $\xi_0 = \log(3HK/\delta) \ge 1$ . Note that  $\log(2K) \le \log(3HK/\delta) = \xi_0$ . Then, we have

$$
T_{1,h}^2 \le 8H^2 + 4H^2\xi_0 + 2dH^2\xi_0 \le 16dH^2\xi_0.
$$

Therefore, with probability exceeding  $1 - \delta$ , one has

$$
\begin{aligned} |(\widehat{\mathbb{B}}_h^{\rho} \widehat{V}_{h+1})(s, a) - (\mathbb{B}_h^{\rho} \widehat{V}_{h+1})(s, a)| &\leq \left(\sqrt{d}H + 4\sqrt{d\xi_0}H\right) \sum_{i=1}^d \|\phi_i(s, a)\|_{\Lambda_h^{-1}} \\ &\leq \gamma_0 \sum_{i=1}^d \|\phi_i(s_h, a_h)\|_{\Lambda_h^{-1}} = \Gamma_h(s, a), \end{aligned}
$$

where  $\gamma_0 = 6\sqrt{d\xi_0}H$  and the above inequality satisfies [\(31\)](#page-16-1).

## <span id="page-23-0"></span>B.3.4 Proof of Lemma [11](#page-22-4)

It follows Lemma [1](#page-5-0) and [\(16\)](#page-6-5) that

$$
|(\widehat{\mathbb{B}}_h^{\rho}\widehat{V}_{h+1})(s,a) - (\mathbb{B}_h^{\rho}\widehat{V}_{h+1})(s,a)| = |\phi(s,a)^{\top}(\widehat{w}_h^{\rho,\widehat{V}} - w_h^{\rho,\widehat{V}})|
$$
  
= 
$$
|\phi(s,a)^{\top}(\widehat{\theta}_h - \theta_h)| + |\phi(s,a)^{\top}(\widehat{v}_h^{\rho,\widehat{V}} - v_h^{\rho,\widehat{V}})|, \qquad \forall (s,a,h) \times S \times A \times [H].
$$
 (56)

We first bound the term (i), for any  $h \in [H]$ . By the update  $(12)$ , we have

<span id="page-23-3"></span>
$$
\begin{aligned} \n\text{(i)} &= |\phi(s, a)^\top \Lambda_h^{-1} \left( \sum_{\tau \in \mathcal{D}_h^0} \phi(s_h^\tau, a_h^\tau) r_h^\tau \right) - \phi(s, a)^\top \theta_h| \\ \n&= |\phi(s, a)^\top \Lambda_h^{-1} \left( \Lambda_h - \lambda_0 I \right) \theta_h - \phi(s, a)^\top \theta_h| \\ \n&= |\lambda_0 \phi(s, a)^\top \Lambda_h^{-1} \theta_h|, \n\end{aligned}
$$

where the second equality is from Assumption [1](#page-4-2) and [\(15\)](#page-6-9). Applying the Cauchy-Schwarz inequality leads to

<span id="page-23-2"></span>
$$
\text{(i)} \leq \lambda_0 \left\| \phi(s, a) \right\|_{\Lambda_h^{-1}} \left\| \theta_h \right\|_{\Lambda_h^{-1}} \leq \sqrt{d\lambda_0} \sum_{i=1}^d \left\| \phi_i(s, a) \mathbb{1}_i \right\|_{\Lambda_h^{-1}},\tag{57}
$$

where the last inequality is  $\|\theta_h\| \leq \sqrt{d}$  and  $\|\Lambda_h^{-1}\| \leq 1/\lambda_0$  such that

$$
\|\theta_h\|_{\Lambda_h^{-1}} \le \|\Lambda_h^{-1}\|^{1/2} \|\theta_h\| \le \sqrt{d/\lambda_0}, \qquad \forall h \in [H].
$$

Next, to bound the term (ii), we define the following notations for simplicity. Let  $\epsilon_h^{\tau}(\alpha, V) = \int_{\mathcal{S}} P_h^0(s'|s_h^{\tau}, a_h^{\tau})[V]_{\alpha}(s')ds'$  $[V]_{\alpha}(s_{h+1}^{\tau})$  for any  $V : \mathcal{S} \to [0, H]$  and  $\alpha \in [\min_{s} V(s), \max_{s} V(s)]$ . Also, we define two auxiliary functions:

\widehat{g}_{h,i}(\alpha) = \int_{\mathcal{S}} \widehat{\mu}_{h,i}(s') [\widehat{V}_{h+1}]_{\alpha}(s') ds' - \rho(\alpha - \min_{s'} [\widehat{V}_{h+1}]_{\alpha}(s')),
$$

$$
g_{h,i}^{0}(\alpha) = \int_{\mathcal{S}} \mu_{h,i}^{0}(s') [\widehat{V}_{h+1}]_{\alpha}(s') ds' - \rho(\alpha - \min_{s'} [\widehat{V}_{h+1}]_{\alpha}(s')).
$$

With the new notations in hand, we can bound (ii) by

$$
\begin{split}\n\text{(ii)} &= \left| \sum_{i=1}^{d} \phi_i(s, a) \left( \widehat{\nu}_{h, i}^{\rho, \widehat{V}} - \nu_{h, i}^{\rho, \widehat{V}} \right) \right| \\
&\leq \sum_{i=1}^{d} \phi_i(s, a) \max_{\alpha \in [\min_s \widehat{V}_{h+1}(s), \max_s \widehat{V}_{h+1}(s)]} \left| \widehat{g}_{h, i}(\alpha) - g_{h, i}^0(\alpha) \right| \\
&\leq \sum_{i=1}^{d} \phi_i(s, a) \max_{\alpha \in [\min_s \widehat{V}_{h+1}(s), \max_s \widehat{V}_{h+1}(s)]} \left| \int_{\mathcal{S}} \left( \widehat{\mu}_{h, i}(s') - \mu_{h, i}^0(s') \right) [\widehat{V}_{h+1}]_{\alpha}(s') \, \mathrm{d}s' \right| \\
&\leq \sum_{i=1}^{d} \sum_{\alpha \in [\min_s \widehat{V}_{h+1}(s), \max_s \widehat{V}_{h+1}(s)]} \left| \phi_i(s, a) \int_{\mathcal{S}} \left( \widehat{\mu}_{h, i}(s') - \mu_{h, i}^0(s') \right) [\widehat{V}_{h+1}]_{\alpha}(s') \, \mathrm{d}s' \right|,\n\end{split} \tag{58}
$$

where the first inequality is due to  $(11)$ ,  $(13)$  as well as Lemma [6,](#page-16-2) and the last inequality is based on  $\phi_i(s, a) \geq 0$  for any  $(s, a) \in \mathcal{S} \times \mathcal{A}$  from Assumption [1.](#page-4-2) Moreover,

$$
\begin{split}\n&\left| \int_{S} \mu_{h,i}^{0}(s') [\hat{V}_{h+1}]_{\alpha}(s') ds' - \int_{S} \hat{\mu}_{h,i}(s') [\hat{V}_{h+1}]_{\alpha}(s') ds' \right| \\
&= \left| \int_{S} \mu_{h,i}^{0}(s') [\hat{V}_{h+1}]_{\alpha}(s') ds' - \mathbb{1}_{i}^{\top} \Lambda_{h}^{-1} \left( \sum_{\tau \in \mathcal{D}_{h}^{0}} \phi(s_{h}^{\tau}, a_{h}^{\tau}) [\hat{V}_{h+1}]_{\alpha}(s_{h+1}^{\tau}) \right) \right| \\
&= \left| \mathbb{1}_{i}^{\top} \Lambda_{h}^{-1} \left( \Lambda_{h} \int_{S} \mu_{h}^{0}(s') [\hat{V}_{h+1}]_{\alpha}(s') ds' - \sum_{\tau \in \mathcal{D}_{h}^{0}} \phi(s_{h}^{\tau}, a_{h}^{\tau}) [\hat{V}_{h+1}]_{\alpha}(s_{h+1}^{\tau}) \right) \right| \\
&= \left| \mathbb{1}_{i}^{\top} \Lambda_{h}^{-1} \left[ \lambda_{0} \int_{S} \mu_{h}^{0}(s') [\hat{V}_{h+1}]_{\alpha}(s') ds' + \sum_{\tau \in \mathcal{D}_{h}^{0}} \phi(s_{h}^{\tau}, a_{h}^{\tau}) \left( \int_{S} P_{h}^{0}(s'| s_{h}^{\tau}, a_{h}^{\tau}) [\hat{V}_{h+1}]_{\alpha}(s') ds' - [\hat{V}_{h+1}]_{\alpha}(s_{h+1}^{\tau}) \right) \right] \right| \\
&= \left| \mathbb{1}_{i}^{\top} \Lambda_{h}^{-1} \left[ \lambda_{0} \int_{S} \mu_{h}^{0}(s') [\hat{V}_{h+1}]_{\alpha}(s') ds' + \sum_{\tau \in \mathcal{D}_{h}^{0}} \phi(s_{h}^{\tau}, a_{h}^{\tau}) \epsilon_{h}^{\tau}(\alpha, \hat{V}_{h+1}) \right] \right| \n\end{split} \tag{59}
$$

where the first equality is from  $(36)$ , the third one is due to  $(15)$  and we let

<span id="page-24-1"></span>
$$
\epsilon_h^{\tau}(\alpha, V) = \int_{\mathcal{S}} P_h^0(s' | s_h^{\tau}, a_h^{\tau})[V]_{\alpha}(s') ds' - [V]_{\alpha}(s_{h+1}^{\tau}),
$$

for any  $V : \mathcal{S} \to [0, H]$  and  $\alpha \in [\min_s V(s), \max_s V(s)]$ . Then, we have

$$
\left| \phi_i(s, a) \cdot (\widehat{\mu}_{h,i} - \mu_{h,i}^0) [\widehat{V}_{h+1}]_{\alpha} \right|
$$
  
\n
$$
\leq \left| \phi_i(s, a) \mathbb{1}_i^\top \Lambda_h^{-1} \left( \lambda_0 \int_S \mu_h^0(s') [\widehat{V}_{h+1}]_{\alpha}(s') ds' + \sum_{\tau \in \mathcal{D}_h^0} \phi(s_h^\tau, a_h^\tau) \epsilon_h^\tau(\alpha, \widehat{V}_{h+1}) \right) \right|
$$

$$
\leq \|\phi_i(s,a)\mathbb{1}_i\|_{\Lambda_h^{-1}} \left( \lambda_0 \Big\| \int_{\mathcal{S}} \mu_h^0(s')[\widehat{V}_{h+1}]_{\alpha}(s')ds' \Big\|_{\Lambda_h^{-1}} + \Big\| \sum_{\tau \in \mathcal{D}_h^0} \phi(s_h^{\tau}, a_h^{\tau}) \epsilon_h^{\tau}(\alpha, \widehat{V}_{h+1}) \Big\|_{\Lambda_h^{-1}} \right), \tag{60}
$$

where the last inequality holds due to the Cauchy-Schwarz inequality.

Moreover, the term (iii) in  $(60)$  can be further simplified to

<span id="page-25-2"></span>
$$
(\texttt{iii}) \leq \lambda_0 \|\Lambda_h^{-1}\|^{\frac{1}{2}} \|\int_{\mathcal{S}} \mu_h^0(s')[\widehat{V}_{h+1}]_{\alpha}(s') \mathrm{d} s' \|\leq \sqrt{\lambda_0} H,
$$

since  $|\widehat{V}_{h+1}(s)| \leq H$  for any  $s \in \mathcal{S}$  and  $||\Lambda_h^{-1}|| \leq 1/\lambda_0$ . Then we have

<span id="page-25-3"></span>
$$
\text{(ii)} \leq \left(\sqrt{\lambda_0}H + \max_{\alpha \in [\min_s \widehat{V}_{h+1}(s), \max_s \widehat{V}_{h+1}(s)]} \|\sum_{\tau \in \mathcal{D}_h^0} \phi(s_h^{\tau}, a_h^{\tau}) \epsilon_h^{\tau}(\alpha, \widehat{V}_{h+1})\|_{\Lambda_h^{-1}}\right) \sum_{i=1}^d \|\phi_i(s, a)\mathbb{1}_i\|_{\Lambda_h^{-1}}, \tag{61}
$$

for any  $(s, a, h) \in S \times A \times [H]$ . Combining [\(61\)](#page-25-3) with [\(57\)](#page-23-2) finally leads to [\(51\)](#page-22-0), which completes our proof.

#### <span id="page-25-0"></span>B.3.5 Proof of [\(53\)](#page-22-2)

Since  $\epsilon_h^{\tau}(\alpha, V)$  is 2-Lipschitz with respect to  $\alpha$  for any  $V : \mathcal{S} \to [0, H]$ , i.e.

\begin{split}\n&\| \sum_{\tau \in \mathcal{D}_{h}^{0}} \phi(s_{h}^{\tau}, a_{h}^{\tau}) \left( \epsilon_{h}^{\tau}(\alpha, V) - \epsilon_{h}^{\tau}(\alpha^{\dagger}, V) \right) \|_{\Lambda_{h}^{-1}}^{2} \\
&= \sum_{\tau, \tau' \in \mathcal{D}_{h}^{0}} \phi(s_{h}^{\tau}, a_{h}^{\tau})^{\top} \Lambda_{h}^{-1} \phi(s_{h}^{\tau'}, a_{h}^{\tau'}) \left[ \left( \epsilon_{h}^{\tau}(\alpha, V) - \epsilon_{h}^{\tau}(\alpha^{\dagger}, V) \right) \left( \epsilon_{h}^{\tau'}(\alpha, V) - \epsilon_{h}^{\tau'}(\alpha^{\dagger}, V) \right) \right] \\
&\leq \sum_{\tau, \tau' \in \mathcal{D}_{h}^{0}} \phi(s_{h}, a_{h}^{\tau})^{\top} \Lambda_{h}^{-1} \phi(s_{h}^{\tau'}, a_{h}^{\tau'}) \cdot 4\epsilon_{0}^{2} \\
&\leq 4\epsilon_{0}^{2} N_{h}^{2} / \lambda_{0},\n\end{split}
$$

where the last inequality is based on  $\|\phi(s, a)\| \leq 1$  and  $\lambda_{\min}(\Lambda_h) \geq \lambda_0$  for any  $(s, a, h) \in S \times A \times [H]$  such that

$$
\sum_{\tau,\tau'\in\mathcal{D}_h^0} \phi(s_h^{\tau}, a_h^{\tau})^{\top} \Lambda_h^{-1} \phi(s_h^{\tau'}, a_h^{\tau'}) = \sum_{\tau,\tau'\in\mathcal{D}_h^0} \|\phi(s_h^{\tau}, a_h^{\tau})\|_2 \cdot \|\phi(s_h^{\tau'}, a_h^{\tau'})\|_2 \cdot \|\Lambda_h^{-1}\| \le N_h^2/\lambda_0. \tag{62}
$$

Thus,

$$
\max_{\alpha \in [0,H]} \|\sum_{\tau \in \mathcal{D}_h^0} \phi(s_h^{\tau}, a_h^{\tau}) \left( \epsilon_h^{\tau}(\alpha, \widehat{V}_{h+1}) - \epsilon_h^{\tau}(\alpha^{\dagger}, \widehat{V}_{h+1}) \right) \|_{\Lambda_h^{-1}}^2 \leq 4\epsilon_0^2 N_h^2 / \lambda_0 \leq 4\epsilon_0^2 K^2 / \lambda_0,
$$

due to the fact  $N_h \leq K$  for any  $h \in [H]$ , which completes the proof of [\(53\)](#page-22-2).

## <span id="page-25-1"></span>B.3.6 Proof of Lemma [12](#page-22-1)

For any fixed  $h \in [H]$  and  $\tau \in \mathcal{D}_h^0$ , we define the  $\sigma$ -algebra

$$
\mathcal{F}_{h,\tau} = \sigma(\{(s_h^j, a_h^j)\}_{j=1}^{(\tau+1)\wedge|N_h|}, \{r_h^j, s_{h+1}^j\}_{j=1}^{\tau}).
$$

As shown in [Jin et al.](#page-12-5) [\(2021](#page-12-5), Lemma B.2), for any  $\tau \in \mathcal{D}_h^0$ , we have  $\phi(s_h^{\tau}, a_h^{\tau})$  is  $\mathcal{F}_{h,\tau-1}$ -measurable and  $\epsilon_h^{\tau}(\alpha, V)$  is  $\mathcal{F}_{h,\tau-1}$ -measurable. Hence  $\{\epsilon_h^{\tau}(\alpha, V)\}_{\tau \in \mathcal{D}_h^0}$  is stochastic process adapted to the filtration  $\{\mathcal{F}_{h,\tau}\}_{\tau \in \mathcal{D}_h^0}$ . Then, we have

$$
\mathbb{E}_{\mathcal{D}_h^0}[\epsilon_h^{\tau}(\alpha, V)|\mathcal{F}] = \int_{\mathcal{S}} P_h^0(s'|s_h^{\tau}, a_h^{\tau})[V]_{\alpha} - \mathbb{E}_{\mathcal{D}_h^0} \left[ [V(s_{h+1}^{\tau})]_{\alpha} | \{(s_h^j, a_h^j)\}_{j=1}^{(\tau) \wedge N_h}, \{r_h^j, s_{h+1}^j\}_{j=1}^{\tau-1} \right]
$$

$$
= \int_{\mathcal{S}} P_h^0(s'|s_h^{\tau}, a_h^{\tau})[V]_{\alpha} - \mathbb{E}_{\mathcal{D}_h^0} \left[ [V(s_{h+1}^{\tau})]_{\alpha} \right] = 0.
$$

Note that  $\epsilon_h^{\tau}(\alpha, V) = \int_{\mathcal{S}} P_h^0(s'|s_h^{\tau}, a_h^{\tau})[V]_{\alpha} - [V(s_{h+1}^{\tau})]_{\alpha}$  for any  $V \in [0, H]^{\mathcal{S}}$  and  $\alpha \in [0, H]$ . Then, we have

 $|\epsilon_h^{\tau}(\alpha, V)| \leq H.$ 

Hence, for the fixed  $h \in [H]$  and all  $\tau \in [H]$ , the random variable  $\epsilon_h^{\tau}(\alpha, V)$  is mean-zero and H-sub-Gaussian conditioning on  $\mathcal{F}_{h,\tau-1}$ . Then, we invoke the Lemma [2](#page-15-7) with  $\eta_{\tau} = \epsilon_h^{\tau}(\alpha, V)$  and  $x_{\tau} = \phi(s_h^{\tau}, a_h^{\tau})$ . For any  $\delta > 0$ , we have

$$
P_{\mathcal{D}}\left(\|\sum_{\tau\in\mathcal{D}_h^0}\phi(s_h^\tau,a_h^\tau)\epsilon_h^\tau(\alpha,V)\|_{\Lambda_h^{-1}}^2>2H^2\log(\frac{\det(\Lambda_h^{1/2})}{\delta\det(\lambda_0I_d)^{1/2}})\right)\leq\delta.
$$

Together with the facts that  $\det(\Lambda_h^{1/2}) = (\lambda_0 + N_h)^{d/2}$  and  $\det(\lambda_0 I_d)^{1/2} = \lambda_0^{d/2}$ , we can conclude the proof of Lemma [12.](#page-22-1)

$$

$$
b_{h,i}^{\star}(s) = (\phi_i(s, \pi_h^{\star}(s)) \mathbb{1}_i)^{\top} \Lambda_h^{-1} (\phi_i(s, \pi_h^{\star}(s)) \mathbb{1}_i).
$$
 (64)

With these notations in hand and recalling  $(17)$  in Theorem [1,](#page-8-0) one has

$$
V_{1}^{\star,\rho}(\zeta) - V_{1}^{\hat{\pi},\rho}(\zeta) \le 2\gamma_{0} \sum_{h=1}^{H} \sum_{i=1}^{d} \sup_{d_{h}^{\star} \in \mathcal{D}_{h}^{\star}} \mathbb{E}_{s \sim d_{h}^{\star}} \sqrt{b_{h,i}^{\star}(s)}
$$
  

$$
\le 2\gamma_{0} \sum_{h=1}^{H} \sum_{i=1}^{d} \sup_{d_{h}^{\star} \in \mathcal{D}_{h}^{\star}} \sqrt{\mathbb{E}_{s \sim d_{h}^{\star}} b_{h,i}^{\star}(s)}
$$
  

$$
= 2\gamma_{0} \sum_{h=1}^{H} \sup_{d_{h}^{\star} \in \mathcal{D}_{h}^{\star}} \sum_{i=1}^{d} \sqrt{\mathbb{E}_{s \sim d_{h}^{\star}} b_{h,i}^{\star}(s)},
$$
(65)

where the second inequality is due to the Jensen's inequality and concavity.

In the following, we will control the key term  $\sum_{i=1}^d \sqrt{\mathbb{E}_{s \sim d_h^{\star}} b_{h,i}^{\star}(s)}$  for any  $d_h^{\star} \in \mathcal{D}_h^{\star}$ . Before continuing, we first denote

$$
\mathcal{C}_h^{\mathrm{b}} = \{ (s, a) : d_h^{\mathrm{b}}(s, a) > 0 \}.
$$

Considering any  $(s, a)$  s.t.  $d_h^b(s, a) > 0$  and from Lemma [9,](#page-18-6) the following lower bound holds with probability at least  $1 - 3\delta$ , i.e.,

$$
N_h(s, a) \ge \frac{K d_h^b(s, a)}{8} - 5\sqrt{K d_h^b(s, a) \log(\frac{KH}{\delta})} \ge \frac{K d_h^b(s, a)}{16},\tag{66}
$$

as long as

<span id="page-26-3"></span>
$$
K \ge c_0 \frac{\log(KH/\delta)}{d_{\min}^b} \ge c_0 \frac{\log(KH/\delta)}{d_h^b(s, a)}
$$
\n(67)

for some sufficiently large  $c_0$  and  $d_{\min}^b = \min_{h,s,a} \{d_h^b(s,a) : d_h^b(s,a) > 0\}$ . Therefore,

$$
\Lambda_h = \sum_{(s,a) \in \mathcal{C}_h^{\text{b}}} N_h(s,a) \phi(s,a) \phi(s,a)^\top + I_d
$$

$$
\geq \sum_{(s,a)\in \mathcal{C}_h^{\text{b}}} \frac{K d_h^{\text{b}}(s,a)}{16} \phi(s,a) \phi(s,a)^\top + I_d
$$
  

$$
\geq \frac{K}{16} \mathbb{E}_{d_h^{\text{b}}} [\phi(s,a) \phi(s,a)^\top] + I_d.
$$

From Assumption [3,](#page-8-4)

$$
\mathbb{E}_{d^{\mathrm{b}}_h}[\phi(s, a)\phi(s, a)^\top] \succeq \max_{P\in\mathcal{P}^\rho(P^0)} \frac{d\cdot\min\{\mathbb{E}_{d^{\star, P}_h}\phi_i^2(s, a), 1/d\}}{C_{\mathrm{rob}}^\star}\mathbbm{1}_{i, i}, \quad \forall i \in [d]

Thus, for any  $i \in [d]$ ,

Here,  $\mathbb{1}_{i,j}$  represents a matrix with the  $(i, j)$ -th coordinate as 1 and all other elements as 0. Consequently,

$$
\mathbb{E}_{s \sim d_h^{\star}} b_{h,i}^{\star}(s) = \mathbb{E}_{s \sim d_h^{\star}} \text{Tr}(\Phi_{h,i}^{\star}(s) \Lambda_h^{-1}) = \text{Tr}(\mathbb{E}_{s \sim d_h^{\star}} \Phi_{h,i}^{\star}(s) \Lambda_h^{-1})
$$

$$
\leq \frac{\mathbb{E}_{d_h^{\star}} \phi_i^2(s, \pi_h^{\star}(s))}{1 + Kd \cdot \min\{\mathbb{E}_{d_h^{\star}} \phi_i^2(s, \pi_h^{\star}(s)), 1/d\} / 16C_{\text{rob}}^{\star}},
$$
\n(69)

where the second equality is because the trace is a linear mapping and the last inequality holds by Lemma [7.](#page-16-3) We further define  $\mathcal{E}_{h,\text{larger}} = \{i : \mathbb{E}_{(s,a)\sim d_h^{\star}} \phi_i^2(s,a) \geq \frac{1}{d}\}\.$  Due to Assumption [1,](#page-4-2) we first claim that

• If  $i \in \mathcal{E}_{h,\text{larger}}, \text{ i.e., } \frac{1}{d} \leq \mathbb{E}_{(s,a)\sim d_h^{\star}} \phi_i^2(s,a) \leq 1$ , we have

(69) \le \frac{16C_{\rm rob}^{\star} \cdot \mathbb{E}_{d_h^{\star}} \phi_i^2(s, \pi_h^{\star}(s))}{K} \le \frac{16C_{\rm rob}^{\star}}{K},\tag{72}

where the last inequality holds due to  $\phi_i^2(s, \pi_h^*(s)) \leq 1$ . Summing up the above three cases and [\(70\)](#page-27-2), we have

\le 8\sqrt{C_{\text{rob}}^{\star}} \sqrt{\frac{d}{K}}.

• We first show that  $|\tilde{\mathcal{E}}_{h,\text{larger}}|$  should be no larger than  $\sqrt{d}$  by contradiction. Suppose  $|\tilde{\mathcal{E}}_{h,\text{larger}}| > \sqrt{d}$ . Then, there are more than  $\sqrt{d}$  coordinates of  $\mathbb{E}_{(s,a)\sim d^*_{h}}\phi(s,a) \in \mathbb{R}^d$  that is larger than  $1/\sqrt{d}$ . In other words,

1 = \int_{\mathcal{S}} P_h^0(s'|s, a) \mathrm{d}s' = \int_{\mathcal{S}} \phi(s, a)^\top \mu_h^0(s') \mathrm{d}s' = \sum_{i=1}^d \phi_i(s, a) \int_{\mathcal{S}} \mu_{h, i}^0(s') \mathrm{d}s' = \sum_{i=1}^d \phi_i(s, a),\tag{75}

where the last equality is implied by Assumption [2.](#page-4-1) Therefore,

The implementation of DROP-V is detailed in Algorithm [3,](#page-29-0) which can be divided into three steps. First, we carefully design Three-fold-subsampling (cf. Algorithm [4\)](#page-30-2), to generate two almost temporally statistically independent datasets,  $\tilde{\mathcal{D}}^0, \mathcal{D}^0$ , which are also independent from each other. The theoretical analysis of Three-fold-subsampling is postponed to Appendix [C.2.](#page-30-0) The second step is to construct a variance estimator  $\hat{\sigma}_h^2$  for any  $h \in [H]$  via  $\tilde{\mathcal{D}}^0$ , which is independent of  $\mathcal{D}_h^0$ . The key idea is to utilize the intermediate results  $\{\tilde{V}_h\}_{h=1}^{H+1}$  of running DROP on  $\tilde{D}^0$  to approximate the variance as [\(22\)](#page-10-0). With the variance estimator at our hands, the last step is to apply the weighted ridge regression to construct the empirical variance-aware robust Bellman operator via [\(25\)](#page-10-2)-[\(28\)](#page-10-1), which is slightly different from DROP.

Thus, we establish the following lemma to show that [\(76\)](#page-30-3) is a valid high-probability lower bound of  $N^{\text{main}}(s)$  for any  $s \in \mathcal{S}$  and  $h \in [H]$ , which follows the proof of Lemma 3 in [Li et al.](#page-12-7) [\(2024](#page-12-7)).

Let  $S_{\mathcal{D}^{\text{aux}}} \subset S$  be the collection of all the states appearing for the dataset  $\mathcal{D}^{\text{aux}}$ , where  $|\mathcal{S}_{\mathcal{D}^{\text{aux}}}|\leq K/3$ . Without loss of generality, we assume that  $\mathcal{D}^{\text{aux}}$  contains the first  $K/3$  trajectories and satisfies

\le \frac{2KH}{3}\exp\left(-\frac{t^2/2}{v_{s,h} + t/3}\right),
$$

for any  $t \geq 0$ , where

$$
v_{s,h} = \frac{K}{3} \operatorname{Var}[\mathbb{1}(s_h^k = s)] \le \frac{K d_h^b(s)}{3}.

Here, we abuse the notation Var to represent the variance of the Bernoulli distributed  $\mathbb{1}(s_h^k = s)$ . Then, with probability at least  $1 - 2\delta/3$ , we have

\left| N_h^{\mathrm{aux}}(s) - \frac{K}{3} d_h^b(s) \right| \le \sqrt{2v_{s,h} \log(\frac{KH}{\delta})} + \frac{2}{3} \log(\frac{KH}{\delta})
$$

$$
\leq \sqrt{Kd_h^b(s)\log(\frac{KH}{\delta})} + \log(\frac{KH}{\delta}), \ \forall (s, h) \in \mathcal{S} \times [H]. \tag{79}
$$

<span id="page-31-0"></span>,

Similarly, with probability at least  $1 - 2\delta/3$ , we have

<span id="page-31-1"></span>
$$
\left| N_h^{\text{main}}(s) - \frac{K}{3} d_h^b(s) \right| \le \sqrt{K d_h^b(s) \log(\frac{KH}{\delta})} + \log(\frac{KH}{\delta}), \quad \forall (s, h) \in \mathcal{S} \times [H]. \tag{80}
$$

Therefore, combining [\(79\)](#page-31-0) and [\(80\)](#page-31-1) leads to

<span id="page-31-2"></span>
$$
\left|N_h^{\text{main}}(s) - N_h^{\text{aux}}(s)\right| \le 2\sqrt{Kd_h^{\text{b}}(s)\log(\frac{KH}{\delta})} + 2\log(\frac{KH}{\delta}), \quad \forall (s, h) \in \mathcal{S} \times [H],\tag{81}
$$

with probability at least  $1 - 4\delta/3$ . Then, we consider the following two cases

• Case 1:  $N_h^{\text{aux}}(s) \leq 36 \log \frac{KH}{\delta}$ . One has

$$
N_h^{\text{trim}}(s) = \max\{N_h^{\text{aux}}(s) - 6\sqrt{N_h^{\text{aux}}(s)\log\frac{HK}{\delta}}, 0\} = 0 \le N_h^{\text{main}}(s).
$$

• Case 2:  $N_h^{\text{aux}}(s) > 36 \log \frac{KH}{\delta}$ . From [\(79\)](#page-31-0), we have

$$
\frac{K}{3}d_h^b(s) + \sqrt{Kd_h^b(s)\log(\frac{KH}{\delta})} + \log(\frac{KH}{\delta}) \ge N_h^{\text{aux}}(s) \ge 36\log\frac{KH}{\delta}
$$

implying

$$
Kd_h^{\mathrm{b}}(s) \ge 72 \log \frac{KH}{\delta}.
$$

Also from [\(79\)](#page-31-0),

$$
N^{\mathrm{aux}}_h(s) \geq \frac{K}{3}d^b_h(s) - \sqrt{K d^b_h(s) \log(\frac{KH}{\delta})} - \log(\frac{KH}{\delta}) \geq \frac{K}{6}d^b_h(s).
$$

Therefore, with probability exceeding  $1 - 4\delta/3$ 

$$
N_h^{\text{trim}}(s) = N_h^{\text{aux}}(s) - 6\sqrt{N_h^{\text{aux}}(s) \log \frac{HK}{\delta}} \le N_h^{\text{aux}}(s) - \sqrt{6}\sqrt{Kd_h^b(s) \log \frac{HK}{\delta}}
$$
  

$$
\le N_h^{\text{aux}}(s) - 2\sqrt{Kd_h^b(s) \log \frac{HK}{\delta}} - \frac{1}{3}\sqrt{Kd_h^b(s) \log \frac{HK}{\delta}}
$$
  

$$
\le N_h^{\text{aux}}(s) - 2\sqrt{Kd_h^b(s) \log \frac{HK}{\delta}} - 2\log \frac{HK}{\delta}
$$
  

$$
\le N_h^{\text{main}}(s),
$$

where the last inequality is from  $(81)$ .

Following the same arguments, we also have

$$
|N_h^{\text{var}}(s) - N_h^{\text{aux}}(s)| \le 2\sqrt{K d_h^{\text{b}}(s) \log(\frac{KH}{\delta})} + 2\log(\frac{KH}{\delta}), \quad \forall (s, h) \in \mathcal{S} \times [H].
$$
 (82)

holds, with probability at least  $1 - 4\delta/3$ . Therefore, we can also guarantee that  $N_h^{\text{trim}}(s) \le N_h^{\text{var}}(s)$  with probability at least  $1 - 4\delta/3$ , for any  $(s, h) \in S \times [H]$ .

Putting these two results together, we prove the first claim [\(77\)](#page-30-4).

Next, we will establish the second claim [\(78\)](#page-30-5). To begin with, we claim the following statement holds with probability exceeding  $1 - 2\delta/3$ ,

N_h^{\text{trim}}(s, a) \ge N_h^{\text{trim}}(s) \pi_h^{\text{b}}(a|s) - \sqrt{2N_h^{\text{trim}}(s) \pi_h^{\text{b}}(a|s) \log(\frac{KH}{\delta})} - \log \frac{KH}{\delta}, \quad \forall (s, a, h) \in \mathcal{S} \times \mathcal{A} \times [H], \tag{83}
$$

conditioned on the high-probability event that the first part [\(77\)](#page-30-4) holds. In the sequel, we discuss the following two cases, provided that the inequality [\(83\)](#page-31-3) holds.

• Case  $1:K_d^b(s, a) = K_d^b(s)\pi^b_h(a|s) > 864\log \frac{KH}{\delta}$ . From [\(79\)](#page-31-0), with probability exceeding  $1-2\delta/3$ , one has

$$
N_h^{\text{aux}}(s) \ge \frac{K}{3} d_h^b(s) - \sqrt{K d_h^b(s) \log(\frac{KH}{\delta})} - \log(\frac{KH}{\delta}) \ge \frac{K}{6} d_h^b(s) \ge 144 \log \frac{KH}{\delta}.
$$

Together with the definition [\(76\)](#page-30-3), we have

$$
N^{\text{trim}}_{h}(s) \geq N^{\text{aux}}_{h}(s) - 6\sqrt{N^{\text{aux}}_{h}(s)\log \frac{KH}{\delta}} \geq \frac{1}{2}N^{\text{aux}}_{h}(s) \geq \frac{K}{12}d^b_{h}(s).
$$

Therefore,

$$
N_h^{\text{trim}}(s)\pi_h^{\text{b}}(a|s) \geq \frac{K}{12}d_h^b(s)\pi_h^{\text{b}}(a|s) \geq 72\log\frac{KH}{\delta}
$$

.

Combining with [\(83\)](#page-31-3), one can derive

$$
N_h^{\text{trim}}(s, a) \ge \frac{K d_h^b(s, a)}{12} - \sqrt{\frac{1}{6} K d_h^b(s, a) \log(\frac{KH}{\delta})} - \log \frac{KH}{\delta}
$$
  

$$
\ge \frac{K d_h^b(s, a)}{12} - \sqrt{6K d_h^b(s, a) \log \frac{KH}{\delta}}.
$$

with probability exceeding  $1 - 4\delta/3$ 

• Case 2:  $K d_h^b(s, a) \leq 864 \log \frac{KH}{\delta}$ . From [\(76\)](#page-30-3), one has

$$
N^{\text{trim}}_h(s,a) \geq 0 \geq \frac{K d^b_h(s,a)}{12} - \sqrt{6K d^b_h(s,a) \log \frac{KH}{\delta}}.
$$

By integrating these two cases, we can claim [\(78\)](#page-30-5) is valid with probability exceeding  $1 - 4\delta/3$ , as long as the inequality [\(83\)](#page-31-3) holds under the condition of the high-probability event described in the the first part [\(77\)](#page-30-4). Thus, the second claim [\(78\)](#page-30-5) holds with probability at least  $1 - 4\delta$ .

**Proof of inequality** [\(83\)](#page-31-3). First, we can observe that the inequality  $(83)$  holds if  $N_h^{\text{trim}}(s) \pi_h^{\text{b}}(s, a) \leq$  $2\log \frac{KH}{\delta}$ . Thus, we focus on the other case that  $N_h^{\text{trim}}(s) \pi_h^{\text{b}}(s, a) > 2\log \frac{KH}{\delta}$ . Denote that

$$
\mathcal{E} = \{ (s, a, h) \in \mathcal{S} \times \mathcal{A} \times [H] | N_h^{\text{trim}}(s) \pi_h^{\text{b}}(a|s) > 2 \log(\frac{KH}{\delta}) \}.
$$

Noticed that from Algorithm [4,](#page-30-2) one has that  $|\mathcal{E}| \leq \frac{KH}{3}$ . Supposing that the first claim [\(77\)](#page-30-4) holds, one has  $N_h^{\text{trim}}(s) = \min \{N_h^{\text{trim}}(s), N_h^{\text{main}}(s), N_h^{\text{var}}(s)\}.$  Therefore,  $N_h^{\text{trim}}(s, a)$  can be viewed as the sum of  $N_h^{\text{trim}}(s)$ independent Bernoulli random variables, where each is with the mean  $\pi_h^b(a|s)$ . Then, by the union bound and the Bernstein inequality,

$$
P\left(\exists (s, a, h) \in \mathcal{E} : \left| N_h^{\text{trim}}(s, a) - N_h^{\text{trim}}(s) \pi_h^{\text{b}}(a|s) \right| \ge t\right)
$$
  

$$
\le \sum_{(s, a, h) \in \mathcal{E}} P\left(\left| N_h^{\text{trim}}(s, a) - N_h^{\text{trim}}(s) \pi_h^{\text{b}}(a|s) \right| \ge t\right) \le \frac{2KH}{3} \exp\left(-\frac{t^2/2}{v_{s, h} + t/3}\right),
$$

for any  $t \geq 0$ , where

$$
v_{s,h} = N_h^{\text{trim}}(s) \operatorname{Var}[\mathbb{1}((s_h^k, a_h^k) = (s, a))] \le N_h^{\text{trim}}(s) \pi_h^{\text{b}}(a|s)
$$

A little algebra yields that with probability at least  $1 - 2\delta/3$ , one can obtain

$$
\left| N_h^{\text{trim}}(s, a) - N_h^{\text{trim}}(s) \pi_h^{\text{b}}(a|s) \right| \leq \sqrt{2v_{s, h} \log(\frac{KH}{\delta})} + \frac{2}{3} \log(\frac{KH}{\delta})
$$
  

$$
\leq \sqrt{2N_h^{\text{trim}}(s) \pi_h^{\text{b}}(a|s) \log(\frac{KH}{\delta})} + \log(\frac{KH}{\delta}), \ \forall (s, h) \in \mathcal{S} \times [H].
$$
 (84)

Therefore, with probability  $1 - 2\delta/3$ , one can obtain

$$
N_h^{\text{trim}}(s, a) \ge N_h^{\text{trim}}(s) \pi_h^{\text{b}}(a|s) - \sqrt{2N_h^{\text{trim}}(s) \pi_h^{\text{b}}(a|s) \log(\frac{KH}{\delta})} - \log(\frac{KH}{\delta}),
$$

for any  $(s, a, h) \in \mathcal{E}$ , conditioned on the first claim [\(77\)](#page-30-4) holds.

In addition, the following lemma guarantees that the samples in  $\mathcal{D}^{\text{main,sub}}$  and  $\mathcal{D}^{\text{var,sub}}$  are statistically independent with probability exceeding  $1-3\delta$ . Before continuing, we denote  $\mathcal{D}^{\text{i.i.d.}}$  as the dataset containing  $N_h^{\text{trim}}(s)$  independent transition-reward sample tuples for every  $(s, h) \in S \times [H]$ , following  $\pi_h^{\text{b}}$  and  $P_h^0$ .

<span id="page-33-2"></span>**Lemma 15** (Modified Lemma 7, [Li et al.](#page-12-7) [\(2024](#page-12-7))). With probability exceeding  $1-3\delta$ ,  $\mathcal{D}^{\text{main,sub}}$  and  $\mathcal{D}^{\text{var,sub}}$ generated by Algorithm  $\frac{1}{4}$  $\frac{1}{4}$  $\frac{1}{4}$  as well as  $\mathcal{D}^{\text{i.i.d.}}$  have the same distributions.

## <span id="page-33-0"></span>C.3 Proof of Theorem [2](#page-11-2)

To show that Theorem [2](#page-11-2) holds, we first establish the following theorem that considers the temporally independent dataset, where the proof is deferred to the next subsection.

<span id="page-33-1"></span>**Theorem 4.** Consider the dataset  $\mathcal{D}_0$  and  $\tilde{D}^0$  used for constructing the variance estimator in DROP-V and  $\delta \in (0,1)$ . Suppose that both  $\mathcal{D}^0$  and  $\tilde{D}^0$  contain  $N_h \leq K$  sample tuples at every  $h \in [H]$ . Assume that conditional on  $\{N_h\}_{h\in[H]}$ , the sample tuples in  $\mathcal{D}^0$  and  $\tilde{\mathcal{D}}^0$  are statistically independent, where

$$
N_h(s,a) \ge \frac{K d_h^b(s,a)}{24}, \qquad \forall (s,a,h) \in \mathcal{S} \times \mathcal{A} \times [H].
$$

Suppose that Assumption [1,](#page-4-2) [2,](#page-4-1) and [3](#page-8-4) hold. In DROP-V, we set

<span id="page-33-3"></span>
$$
\lambda_1 = 1/H^2, \gamma_1 = \xi_1 \sqrt{d}, \quad \text{where } \xi_1 = 66 \log(3HK/\delta). \tag{85}
$$

Then, with probability at least  $1-7\delta$ ,  $\{\widehat{\pi}_h\}_{h=1}^H$  generated by DROP-V satisfies

SubOpt
$$
(\hat{\pi}; \zeta, \mathcal{P}^{\rho}) \leq \tilde{O}(\sqrt{d}) \sum_{h=1}^{H} \sum_{i=1}^{d} \max_{d_h^{\star} \in \mathcal{D}_h^{\star}} \mathbb{E}_{d_h^{\star}} \left[ \|\phi_i(s_h, a_h)\mathbb{1}_i\|_{(\Sigma_h^{\star})^{-1}} \right],
$$

if  $\sqrt{d} \ge H$  and  $K \ge \max{\{\tilde{O}(H^4/\kappa^2), \tilde{O}(H^6d/\kappa)\}}$ , where  $\Sigma_h^{\star}$  is defined in [\(30\)](#page-11-6).

As the construction in Algorithm [4,](#page-30-2)  $\{N_h^{\text{trim}}(s)\}_{s\in\mathcal{S},h\in[H]}$  is computed using  $\mathcal{D}^{\text{aux}}$  that is independent of  $\mathcal{D}^0 := \mathcal{D}^{\text{main,sub}}$  and  $\tilde{\mathcal{D}}^0 := \mathcal{D}^{\text{var,sub}}$ . Moreover, from Lemma [14](#page-30-1) and Lemma [15](#page-33-2) in the Section [C.2,](#page-30-0)  $\{N_h^{\text{trim}}(s)\}_{s\in\mathcal{S}}$  is a valid sampling number and  $\mathcal{D}_h^0$  and  $\tilde{\mathcal{D}}_h^0$  can be treated as being temporally statistically independent samples and

$$
\sum_{s \in \mathcal{S}} N_h^{\text{trim}}(s) \geq K/24,
$$

with probability exceeding  $1 - 4\delta$ , as long as  $K \geq c_1 \log \frac{KH}{\delta} / d_{\min}^{\rm b}$  for some sufficiently large  $c_1$ . Therefore, by invoking Theorem [3](#page-19-0) with  $N_h := \sum_{s \in \mathcal{S}} N^{\text{trim}}(s)$ , we have

$$
\text{SubOpt}(\widehat{\pi}; \zeta, \mathcal{P}^{\rho}) \leq \tilde{O}(\sqrt{d}) \sum_{h=1}^{H} \sum_{i=1}^{d} \max_{d_h^{\star} \in \mathcal{D}_h^{\star}} \mathbb{E}_{d_h^{\star}} \left[ \|\phi_i(s_h, a_h) 1\!\!1_i\|_{(\Sigma_h^{\star})^{-1}} \right],
$$

with probability exceeding  $1 - 11\delta$ , if  $\sqrt{d} \ge H$  and  $K \ge \max{\{\widetilde{O}(H^4/\kappa^2), \widetilde{O}(H^6d/\kappa), \widetilde{O}(1/d_{\min}^{\rm b})\}}$ .

 $\Box$

$$
\Gamma_h^{\star,\sigma}(s) = \Gamma_h^{\sigma}(s, \pi_h^{\star}(s)), \quad \forall s \in \mathcal{S}.
$$
\n
$$
(87)
$$

Also, denote  $\mathbb{V}_{P_h^0} V(s, a) = \max\{1, \text{Var}_{P_h^0}[V](s, a)\}\$  for any  $V : \mathcal{S} \to [0, H]$  and any  $(s, a, h) \in \mathcal{S} \times \mathcal{A} \times [H]$ . Similar to Lemma [10,](#page-19-5) we have the following key lemma, where the proof can be found in Appendix [C.5.](#page-34-2)

<span id="page-34-1"></span>**Lemma 16.** Suppose all the assumptions in Theorem [4](#page-33-1) hold and follow all the parameters setting in  $(85)$ . In addition, suppose that the number of trajectories  $K \geq \max{\{\tilde{O}(H^4/\kappa^2), \tilde{O}(H^6d/\kappa)\}}$ . Then for any  $(s, a, h) \in$  $S \times A \times [H]$ , with probability at least  $1 - 7\delta$ , one has

$$
|(\widehat{\mathbb{B}}_h^{\rho,\sigma}\widehat{V}_{h+1})(s,a) - (\mathbb{B}_h^{\rho}\widehat{V}_{h+1})(s,a)| \leq \Gamma_h^{\sigma}(s,a) := \gamma_1 \sum_{i=1}^d \|\phi_i(s,a)\mathbb{1}_i\|_{\Sigma_h^{-1}}.
$$
\n(88)

In addition,

$$
\gamma_1 \sum_{i=1}^d \|\phi_i(s, a)\mathbb{1}_i\|_{\Sigma_h^{-1}} \le 2\gamma_1 \sum_{i=1}^d \|\phi_i(s, a)\mathbb{1}_i\|_{(\Sigma_h^*)^{-1}}.
$$

Next, following the same steps in Appendix [B.3.2,](#page-19-6) with probability exceeding  $1 - 7\delta$ , one has

(\hat{\pi}; \zeta, \mathcal{P}^{\rho}) \leq 2\gamma_1 \sum_{h=1}^{H} \sum_{i=1}^{d} \max_{d_h^{\star} \in \mathcal{D}_h^{\star}} \mathbb{E}_{d_h^{\star}} \left[ \|\phi_i(s_h, a_h) \mathbb{1}_i\|_{\Sigma_h^{-1}} \right]
$$
  

$$
\leq 4\gamma_1 \sum_{h=1}^{H} \sum_{i=1}^{d} \max_{d_h^{\star} \in \mathcal{D}_h^{\star}} \mathbb{E}_{d_h^{\star}} \left[ \|\phi_i(s_h, a_h) \mathbb{1}_i\|_{(\Sigma_h^{\star})^{-1}} \right].
$$

$$

where  $\epsilon_h^{\tau,\sigma}(\alpha,V) = \frac{\int_{\mathcal{S}} P_h^0(s' | s_h^{\tau}, a_h^{\tau}) [V]_{\alpha}(s') ds' - [V]_{\alpha}(s_{h+1}^{\tau})}{\hat{\sigma}_h(s_h^{\tau}, a_h^{\tau})}$  $\frac{\partial\{V\}_{\alpha}(s) \text{d}s - V_{\alpha}(s_{h+1})}{\partial \hat{\sigma}_h(s_h^{\tau}, a_h^{\tau})}$  for any  $V : S \to [0, H]$ , any  $\tau \in \mathcal{D}_h^0$  and  $\alpha \in$  $[\min_s V(s), \max_s V(s)].$ 

Letting  $\lambda_1 = 1/H^2$  in [\(89\)](#page-34-3), then Lemma [17](#page-34-4) becomes

\leq \left(2\sqrt{d}+\max_{\alpha\in\left[\min_{s}\widehat{V}_{h+1}(s),\max_{s}\widehat{V}_{h+1}(s)\right]}\|\sum_{\tau\in\mathcal{D}_{h}^{0}}\frac{\phi(s_{h}^{\tau},a_{h}^{\tau})}{\widehat{\sigma}(s_{h}^{\tau},a_{h}^{\tau})}\epsilon_{h}^{\tau,\sigma}(\alpha,\widehat{V}_{h+1})\|_{\Sigma_{h}^{-1}}\right)\sum_{i=1}^{d} \|\phi_{i}(s,a)\mathbb{1}_{i}\|_{\Sigma_{h}^{-1}}.\tag{90}
$$

Due to the correlation between  $\alpha$  and  $\hat{V}_{h+1}$ , we also apply the uniform concentration with the minimal  $\epsilon_1$ -covering set  $\mathcal{N}(\epsilon_1, H)$  for  $\alpha$  defined in [\(52\)](#page-22-5). Similar to [\(53\)](#page-22-2), there exists  $\alpha^{\dagger} \in \mathcal{N}(\epsilon_1, H)$  s.t.

<span id="page-35-0"></span>
$$
M_{1,h}^2 \le 8\epsilon_1^2 H^2 K^2 + 2 \left\| \sum_{\tau \in \mathcal{D}_h^0} \frac{\phi(s_h^{\tau}, a_h^{\tau})}{\hat{\sigma}_h(s_h^{\tau}, a_h^{\tau})} \epsilon_h^{\tau, \sigma}(\alpha^{\dagger}, \hat{V}_{h+1}) \right\|_{\Sigma_h^{-1}}^2 \le 8 + 2M_{2,h},\tag{91}
$$

where the second inequality holds if  $\epsilon_1 \leq \frac{1}{HK}$ . Without the loss of generality, we let  $\epsilon_1 = \frac{1}{HK}$  in the following analysis. The detailed proof of [\(91\)](#page-35-0) is postponed to Appendix [C.5.2.](#page-37-0)

Next, we will focus on bound the term  $M_{2,h}$ . Before proceeding, we first define the  $\sigma$ -algebra

Noted that the samples in  $\mathcal{D}^0$  are temporally statistically independent, i.e.,  $\hat{V}_{h+1}$  is independent of  $\mathcal{D}_h^0$  for any  $h \in [H]$ . In addition,  $\{\hat{\sigma}_h^2\}_{h \in [H]}$  is constructed using an additional dataset  $\tilde{\mathcal{D}}^0$ , which is also independent of  $\mathcal{D}^0$ . Thus, for any  $h \in [H]$  and  $\tau \in \mathcal{D}_h^0$ , we have  $\frac{\phi(s_h^{\tau}, a_h^{\tau})}{\hat{\sigma}_h(s_h^{\tau}, a_h^{\tau})}$  $\frac{\varphi(s_h, a_h)}{\widehat{\sigma}_h(s_h^{\tau}, a_h^{\tau})}$  is  $\mathcal{F}_{h,\tau-1}$ -measurable and  $|\frac{\phi(s_h^{\tau},a_h^{\tau})}{\hat{\sigma}_h(s_h^{\tau},a_h^{\tau})}$  $\frac{\phi(s_h^{\tau}, a_h^{\tau})}{\hat{\sigma}_h(s_h^{\tau}, a_h^{\tau})} \leq 1$ . Also,  $\epsilon_h^{\tau, \sigma}(\alpha^{\dagger}, \hat{V}_{h+1})$  is  $\mathcal{F}_{h,\tau}$ -measurable,

$$

It follows the independence between  $\hat{\sigma}_h^2$  and  $\mathcal{D}_h^0$  that

$$
\operatorname{Var}_{P_h^0} \left[ \frac{\int_{\mathcal{S}} P_h^0(s'|s_h^{\tau}, a_h^{\tau})[\widehat{V}_{h+1}]_{\alpha}(s')ds' - [\widehat{V}_{h+1}]_{\alpha}(s)}{\widehat{\sigma}_h(s_h^{\tau}, a_h^{\tau})} \right] (s_h^{\tau}, a_h^{\tau}) = \frac{\operatorname{Var}_{P_h^0} [\widehat{V}_{h+1}]_{\alpha}(s_h^{\tau}, a_h^{\tau})}{\widehat{\sigma}_h^2(s_h^{\tau}, a_h^{\tau})}
$$
  

$$
\leq \frac{\mathbb{V}_{P_h^0} \widehat{V}_{h+1}(s_h^{\tau}, a_h^{\tau})}{\widehat{\sigma}_h^2(s_h^{\tau}, a_h^{\tau})}, \tag{92}
$$

for any  $h \in [H]$  and  $\tau \in \mathcal{D}_h^0$ , where the inequality is from  $\mathbb{V}_{P_n^0} \widehat{V}_{h+1}(s_h^{\tau}, a_h^{\tau}) = \max\{1, \text{Var}_{P_h^0}[\widehat{V}_{h+1}](s_h^{\tau}, a_h^{\tau})\}.$ 

The analysis of the improvement on sample complexity heavily relies on the following lemma about the variance estimation error, where the proof is deferred to Appendix [C.5.3.](#page-38-0)

<span id="page-35-1"></span>**Lemma 18.** Suppose that  $\mathcal{D}^0$  and  $\tilde{\mathcal{D}}^0$  satisfy all the conditions imposed in Theorem [4.](#page-33-1) Assume the Assump-tion [1,](#page-4-2) [2](#page-4-1) and [3](#page-8-4) hold. For any  $h \in [H]$  and given the nominal transition kernel  $P_h^0: S \times A \to S$ , the  $\widehat{V}_{h+1}$ generated by the DROP-V on  $\mathcal{D}^0$  and  $\widehat{\sigma}_h^2$  generated by DROP on  $\tilde{\mathcal{D}}^0$  satisfies

$$
\n(94)

where  $c_b = 12 \log(3HK/\delta)$  and  $K \ge c_1 \log(2Hd/\delta)H^4/\kappa^2$  for some sufficiently large universal constant  $c_1$ , with probability at least  $1 - 6\delta$ .

Notice that  $1 \leq \hat{\sigma}_h^2(s, a) \leq H^2$  for any  $(s, a, h) \in \mathcal{S} \times \mathcal{A} \times [H]$ . Invoking the Lemma [18,](#page-35-1) we have

where the penultimate inequality uses  $1 \leq \hat{\sigma}_h^2(s, a)$  for any  $(s, a, h) \in S \times A \times [H]$  and the last inequality holds as long as  $K \geq c_k H^6 d / \kappa$  for some sufficiently large universal constant  $c_k$ . Therefore, combining with

[\(92\)](#page-35-2) leads to  $\text{Var}[\epsilon_h^{\tau,\sigma}(\alpha^{\dagger}, V_{h+1}) | \mathcal{F}_{h,\tau-1}] \leq 2$ .<br>Suppose that  $\sqrt{d} \geq H$ . From [Vershynin](#page-14-18) [\(2018\)](#page-14-18), one has  $|\mathcal{N}(\epsilon_1, H)| \leq \frac{3H}{\epsilon_1} = 3H^2K$ . By the union bound and invoking Lemma [3,](#page-16-5) we have

with probability  $1 - 7\delta$  and for a fixed  $\alpha \in \mathcal{N}(\epsilon_1, \hat{V}_{h+1}),$  for  $c_1 = 40 \log(3HK/\delta)$ . Then, the equation [\(89\)](#page-34-3) becomes

where the last inequality is from  $\frac{70c_bH^3\sqrt{d}}{\sqrt{K\kappa}} \leq \frac{1}{2}$ . Then, we obtain  $\Sigma_h \succeq \frac{1}{2}\Sigma_h^{\star}$  for any  $h \in [H]$ , which completes the proof.

\begin{split} &\left|\mathbb{V}_{P_h^0}V_{h+1}^{\star,\rho}(s_h^\tau,a_h^\tau)-\widehat{\sigma}_h^2(s_h^\tau,a_h^\tau)\right|\\ &\leq \left|\mathbb{V}_{P_h^0}\tilde{V}_{h+1}(s_h^\tau,a_h^\tau)-\widehat{\sigma}_h^2(s_h^\tau,a_h^\tau)\right|+\left|\mathbb{V}_{P_h^0}V_{h+1}^{\star,\rho}(s_h^\tau,a_h^\tau)-\mathbb{V}_{P_h^0}\tilde{V}_{h+1}(s_h^\tau,a_h^\tau)\right|\\ &\leq \underbrace{\left|\text{Var}_{P_h^0}\tilde{V}_{h+1}(s_h^\tau,a_h^\tau)-\widehat{\text{Var}}_h\tilde{V}_{h+1}(s_h^\tau,a_h^\tau)\right|}_{(a)}+\underbrace{\left|\text{Var}_{P_h^0}V_{h+1}^{\star,\rho}(s_h^\tau,a_h^\tau)-\text{Var}_{P_h^0}\tilde{V}_{h+1}(s_h^\tau,a_h^\tau)\right|}_{(b)}, \end{split}
$$

for every  $h \in [H]$ , where the last inequality is based on the non-expansiveness of max $\{1, \cdot\}$ . Similarly,

$$
\bigg|\mathbb{V}_{P_h^0}\widehat{V}_{h+1}(s^\tau_h,a^\tau_h)-\mathbb{V}_{P_h^0}V^{\star,\rho}_{h+1}(s^\tau_h,a^\tau_h)\bigg|\leq \underbrace{\left|\text{Var}_{P_h^0}V^{\star,\rho}_{h+1}(s^\tau_h,a^\tau_h)-\text{Var}_{P_h^0}\widehat{V}_{h+1}(s^\tau_h,a^\tau_h)\right|}_{(c)}.
$$

In the sequel, we will control  $(a)$ ,  $(b)$  and  $(c)$  respectively.

**Step 1: controlling** (*a*). For each  $\tau \in \mathcal{D}_h^0$ , we decompose the term (*a*) by

$$
  
\n
$$
+ \left| \left( [\phi(s, a)^{\top} \nu_{h,2}]_{[0, H]} \right)^{2} - \left[ \int_{\mathcal{S}} P_{h, s_{h}^{\tau}, a_{h}^{\tau}}^{0}(s') \tilde{V}_{h+1}(s') ds' \right]^{2} \right|
$$
  
\n
$$
\leq \underbrace{\left| \phi(s_{h}^{\tau}, a_{h}^{\tau})^{\top} \left( \nu_{h,1} - \int_{\mathcal{S}} \mu_{h}^{0}(s') \tilde{V}_{h+1}^{2}(s') ds' \right) \right|}_{(a_{1})} + 2H \underbrace{\left| \phi(s_{h}^{\tau}, a_{h}^{\tau})^{\top} \left( \nu_{h,2} - \int_{\mathcal{S}} \mu_{h}^{0}(s') \tilde{V}_{h+1}(s') ds' \right) \right|}_{(a_{2})},
$$

where the last inequality is based on  $a^2 - b^2 = (a + b)(a - b)$  for any  $a, b \in \mathbb{R}$ . In the sequel, we control  $(a_1)$ and  $(a_2)$ , respectively. Before continuing, we first define  $\tilde{\mu}_{h,i} : \mathcal{S} \to \mathbb{R}$  is the *i*-th coordinate of

$$
\tilde{\mu}_h(s) = (\tilde{\Lambda}_h)^{-1} \left( \sum_{\tau' \in \tilde{\mathcal{D}}_h^0} \phi(s_h^{\tau'}, a_h^{\tau'}) \mathbb{1}(s = s_{h+1}^{\tau'}) \right) \in \mathbb{R}^d
$$

such that  $\nu_{h,1} = \int_{\mathcal{S}} \tilde{\mu}_h(s') \tilde{V}_{h+1}^2(s') ds' \in \mathbb{R}^d$  and  $\nu_{h,2} = \int_{\mathcal{S}} \tilde{\mu}_h(s') \tilde{V}_{h+1}(s') ds'.$  With this new notation, we reformulate  $(a_1)$  as

(a_1) \leq \left( H + \max_{\alpha \in [\min_s \tilde{V}_{h+1}(s), \max_s \tilde{V}_{h+1}(s)]} \|\sum_{\tau' \in \tilde{\mathcal{D}}_h^0} \phi(s_h^{\tau'}, a_h^{\tau'}) \epsilon_h^{\tau'}(\alpha, \tilde{V}_{h+1}^2) \|_{(\tilde{\Lambda}_h)^{-1}} \right) \sum_{i=1}^d \|\phi_i(s_h^{\tau}, a_h^{\tau})\mathbb{1}_i\|_{\tilde{\Lambda}_h^{-1}} \leq \left( H + 2\sqrt{2}H + \sqrt{2} \sup_{\alpha \in \mathcal{N}(\epsilon_0, H)} \|\sum_{\tau' \in \tilde{\mathcal{D}}_h^0} \phi(s_h^{\tau'}, a_h^{\tau'}) \epsilon_h^{\tau'}(\alpha, \tilde{V}_{h+1}^2) \|_{(\tilde{\Lambda}_h)^{-1}} \right) \sum_{i=1}^d \|\phi_i(s_h^{\tau}, a_h^{\tau})\mathbb{1}_i\|_{\tilde{\Lambda}_h^{-1}}, \tag{99}
$$

where  $\epsilon_h^{\tau}(\alpha, V) = \int_{\mathcal{S}} P_h^0(s'|s_{h}^{\tau}, a_h^{\tau})[V]_{\alpha}(s')ds' - [V]_{\alpha}(s_{h+1}^{\tau})$  for any  $V : \mathcal{S} \to [0, H], \tau' \in \tilde{\mathcal{D}}_h^0$  and  $\alpha \in$  $[\min_s V(s), \max_s V(s)]$ . Since  $\tilde{V}_{h+1}$  is independent of  $\tilde{\mathcal{D}}_h^0$ , we can directly apply Lemma [2](#page-15-7) following the same arguments in Lemma [12.](#page-22-1) Therefore, with probability exceeding  $1 - \delta$ , we have

Combining  $(99)$ ,  $(100)$ , and  $(101)$ , we can obtain

(a) \le (a_1) + 2H(a_2) \le 12c_a H^2 \sqrt{d} \sum_{i=1}^d \|\phi_i(s_h^\tau, a_h^\tau) \mathbb{1}_i\|_{\tilde{\Lambda}_h^{-1}}
$$

with probability exceeding  $1 - 2\delta$ .

Step 2: controlling  $(b)$ . Then,

$$
(b) = \left| \text{Var}_{P_h^0} V_{h+1}^{\star,\rho}(s_h^{\tau}, a_h^{\tau}) - \text{Var}_{P_h^0} \tilde{V}_{h+1}(s_h^{\tau}, a_h^{\tau}) \right|
$$
  
\n
$$
\leq \left| \int_{\mathcal{S}} P_{h, s_h^{\tau}, a_h^{\tau}}(s') \left( V_{h+1}^{\star,\rho}(s') - \tilde{V}_{h+1}(s') \right) \left( V_{h+1}^{\star,\rho}(s') + \tilde{V}_{h+1}(s') \right) ds' \right|
$$
  
\n
$$
+ \left| \int_{\mathcal{S}} P_{h, s_h^{\tau}, a_h^{\tau}}(s') \left( V_{h+1}^{\star,\rho}(s') - \tilde{V}_{h+1}(s') \right) ds' \right| \left| \int_{\mathcal{S}} P_{h, s_h^{\tau}, a_h^{\tau}}(s') \left( V_{h+1}^{\star,\rho}(s') + \tilde{V}_{h+1}(s') \right) ds' \right|
$$
  
\n
$$
\leq 4H \left| \int_{\mathcal{S}} P_{h, s_h^{\tau}, a_h^{\tau}}(s') \left( V_{h+1}^{\star,\rho}(s') - \tilde{V}_{h+1}(s') \right) ds' \right| \leq 4H \max_{s \in \mathcal{S}} V_{h+1}^{\star,\rho}(s) - \tilde{V}_{h+1}(s).
$$

Denote  $\tilde{\iota}_h(s, a) = \mathbb{B}_h^{\rho} \tilde{V}_{h+1}(s, a) - \tilde{Q}_h(s, a)$ , for any  $(s, a) \in \mathcal{S} \times \mathcal{A}$  and

$$
P_{h,s,\pi_h^{\star}(s)}^{\text{inf},\tilde{V}}(\cdot) := \underset{P(\cdot) \in \mathcal{P}^{\rho}(P_{h,s,\pi_h^{\star}(s)}^0)}{\operatorname{arg\,min}} \int_{\mathcal{S}} P(s')\tilde{V}_{h+1}(s')\mathrm{d}s'.\tag{102}
$$

For any  $h \in [H]$ , define  $\tilde{P}_h^{\text{inf}} : S \to S$  and  $\tilde{\iota}_h^{\star} \in S \to \mathbb{R}$  by

= \sum_{t=h}^H \left(\prod_{j=h}^{t-1} \tilde{P}_j^{\text{inf}}\right) \tilde{\iota}_t^{\star}(s)
$$

for any  $s \in \mathcal{S}$  and  $h \in [H]$ , where the equality is from  $V_{H+1}^{*,\rho}(s) = \tilde{V}_{H+1}(s) = 0$  for any  $s \in \mathcal{S}$  and we denote

$$
\left(\prod_{j=t}^{t-1} \tilde{P}_j^{\text{inf}}\right)(s) = \mathbb{1}_s \quad \text{and} \quad \tilde{d}_{h:t}^{\star} = d_h^{\star} \left(\prod_{j=h}^{t-1} \tilde{P}_j^{\text{inf}}\right) \in \mathcal{D}_t^{\star}.
$$

for any  $d_h^* \in \mathcal{D}_h^*$ . Therefore,

$$
\max_{s \in \mathcal{S}} V_{h+1}^{\star,\rho}(s) - \tilde{V}_{h+1}(s) \le \sum_{t=h+1}^{H} \max_{s \in \mathcal{S}} \mathbb{E}_{\tilde{d}_{h:t}^{\star}} \tilde{\iota}_t^{\star} \le \sum_{h=1}^{H} \max_{(s,a) \in \mathcal{S} \times \mathcal{A}} \tilde{\iota}_h(s,a). \tag{104}

**Step 3: controlling**  $(c)$ . Similarly,

(c) \le 4H \max_{s \in \mathcal{S}} V_{h+1}^{\star,\rho}(s) - \widehat{V}_{h+1}(s) \le \sum_{t=h+1}^{H} \sup_{(s,a) \in \mathcal{S} \times \mathcal{A}} | \iota_t^{\sigma}(s,a) | \tag{106}
$$

where

$$
|\iota_h^{\sigma}(s,a)| \le |(\widehat{\mathbb{B}}_h^{\rho,\sigma}\widehat{V}_{h+1})(s,a) - (\mathbb{B}_h^{\rho}\widehat{V}_{h+1})(s,a)| + \Gamma_h^{\sigma}(s,a). \tag{107}
$$

Following  $(90)$  and  $(91)$ , we have

where  $M_{3,h} := \sup_{\alpha^{\dagger} \in \mathcal{N}(\epsilon_1, H)} \left\| \sum_{\tau=1}^{N_h} \right\|$  $\phi(s_h^{\tau},a_h^{\tau})$  $\frac{\phi(s_h^{\tau}, a_h^{\tau})}{\hat{\sigma}_h(s_h^{\tau}, a_h^{\tau})} \epsilon_h^{\tau, \sigma}(\alpha^{\dagger}, \hat{V}_{h+1}) \Big\|_{\Sigma_h^{-1}}$ . Since  $\hat{\sigma}_h$  and  $\hat{V}_{h+1}$  are independent of  $\mathcal{D}_h^0$ , then we can directly apply Lemma [2](#page-15-7) following the same arguments in Lemma [12.](#page-22-1) Therefore, with probability exceeding  $1 - \delta$ , we have

with probability at least  $1 - \delta$ .

**Step 4: finishing up.** Then, with probability at least  $1 - 3\delta$ , we have

since  $c_b = 4c_a$ . With probability at least  $1 - \delta$ ,

\sum_{i=1}^{d} \|\phi_i(s, a)\mathbb{1}_i\|_{\Sigma_h^{-1}} \le \frac{2}{\sqrt{N_h \kappa}} \le \frac{10}{\sqrt{K\kappa}}, \quad \forall (s, a, h) \in \mathcal{S} \times \mathcal{A} \times [H], \tag{113}

as long as  $K \ge c_1 \log(2Hd/\delta)H^4/\kappa^2$  for some sufficient large universal constant  $c_1$ . Substituting [\(112\)](#page-41-3) and [\(113\)](#page-42-1) into [\(110\)](#page-41-4) and [\(111\)](#page-41-5) respectively, we finally arrive at

for any  $(s, a, h) \in S \times A \times [H]$ , with probability at least  $1 - 6\delta$ , which completes the proof as long as  $K \geq c_1 \log(2Hd/\delta)H^4/\kappa^2$  for some sufficient large universal constant  $c_1$ .

\|\phi_i(s,a)\mathbb{1}_i\|_{\Sigma_h^{-1}} \le \frac{2\phi_i(s,a)}{\sqrt{N_h\kappa}}, \quad \forall (i,s,a) \in [d] \times S \times \mathcal{A},
$$

as long as  $N_h \ge \max\{512H^4 \log(2Hd/\delta)/\kappa^2, 4/\kappa\}$ . In addition,

$$
1 = \int_{\mathcal{S}} P_h^0(s'|s, a) \mathrm{d}s' = \int_{\mathcal{S}} \phi(s, a)^\top \mu_h^0(s') \mathrm{d}s' = \sum_{i=1}^d \phi_i(s, a) \int_{\mathcal{S}} \mu_{h, i}^0(s') \mathrm{d}s' = \sum_{i=1}^d \phi_i(s, a), \tag{116}
$$

where the last equality is implied by Assumption [2.](#page-4-1) Therefore,

$$
\sum_{i=1}^d \|\phi_i(s, a)\mathbb{1}_i\|_{\Sigma_h^{-1}} \le \sum_{i=1}^d \frac{2\phi_i(s, a)}{\sqrt{N_h \kappa}} \le \frac{2}{\sqrt{N_h \kappa}}
$$
