# ON THE MATCHING COMPLEXES OF CATEGORICAL PRODUCT OF PATH GRAPHS

ABSTRACT. The matching complex  $M(G)$  of a graph G is a simplicial complex whose simplices are matchings in G. These complexes appears in various places and found applications in many areas of mathematics including; discrete geometry, representation theory, combinatorics, etc. In this article, we consider the matching complexes of categorical product  $P_n \times P_m$  of path graphs  $P_n$  and  $P_m$ . For  $m = 1, P_n \times P_m$  is a discrete graph and therefore its matching complex is the void complex. For  $m = 2$ ,  $M(P_n \times P_m)$  has been proved to be homotopy equivalent to a wedge of spheres by Kozlov. We show that for  $n \geq 2$  and  $3 \leq m \leq 5$ , the matching complex of  $P_n \times P_m$ is homotopy equivalent to a wedge of spheres. For  $m = 3$ , we give a closed form formula for the number and dimension of spheres appearing in the wedge. Further, for  $m \in \{4, 5\}$ , we give minimum and maximum dimension of spheres appearing in the wedge in the homotopy type of  $M(P_n \times P_m)$ .

## 1 Introduction

A matching in a simple graph G is a collection of pairwise disjoint edges. The matching complex  $M(G)$ , of a graph G is the simplicial complex whose vertices are the edges, and simplicies are the matchings in  $G$ . In topological combinatorics, it is an important problem to study the topology of matching complexes of graphs. Matching complexes appeared first time in the thesis of Garst [\[Gar79\]](#page-35-0), where they obtained the matching complexes of complete bipartite graphs  $K_{m,n}$  as special coset complexes of symmetric groups  $S_n$ . Thereafter, matching complexes appeared and found applications in various places. The matching complexes of complete graphs appeared in the paper of Bouc [\[Bou92\]](#page-35-1) in connection with Brown complexes and Quillen complexes. In  $[BLVv94]$ , Björner et al. described the matching complexes of complete bipartite graphs as chessboard complexes to study the geometry of admissible rook configurations on a general  $m \times n$  chessboard. In [\[vV92\]](#page-35-3),  $M(K_{m,n})$  appeared as the complex of all partial, injective functions between  $\{1, \ldots, m\}$  to  $\{1, \ldots, n\}$  in connection to the problem of estimating the number of halving hyperplanes of a finite set of points in Euclidean space. Other than the complete graphs and complete bipartite graphs, the classes of graphs for which matching complexes have been studied include; paths and cycles [\[Koz99\]](#page-35-4), trees [\[MT08,](#page-35-5) [MJMV22\]](#page-35-6), polygonal tilings [\[Mat22,](#page-35-7)[BJMV23\]](#page-35-8), honeycomb graphs [\[MT08\]](#page-35-5), etc. For more details on these complexes, we refer to a survey article by Wachs [\[Wac03\]](#page-35-9) and Chapter 11 of the book [\[Jon08\]](#page-35-10) by Jonsson.

**Definition 1.1.** The *cartesian product*  $G \Box H$  of graphs G and H is the graph with vertex set  $V(G) \times V(H)$  and any two vertices  $(u, v)$  and  $(u', v')$  form an edge if and only if either  $u = u'$  and  $vv' \in E(H)$ , or  $v = v'$  and  $uu' \in E(G)$ .

**Definition 1.2.** The *categorical product*  $G \times H$  of graphs G and H is the graph with vertex set  $V(G) \times V(H)$  and any two vertices  $(u, v)$  and  $(u', v')$  form an edge if and only if  $uu' \in E(G)$  and  $vv' \in E(H)$ .

For  $n \geq 1$ , let  $P_n$  denote the path graph on n vertices. The matching complexes of the cartesian product of path graphs have been studied by many authors. In [\[Koz99\]](#page-35-4), Kozlov

studied  $M(P_n \Box P_1)$ . In [\[Jon05\]](#page-35-11), Jonsson studied the homotopical depth and topological connectivity of matching complexes of the cartesian product of path graphs for certain cases. Further, the homology of  $M(P_n \Box P_2)$  has been studied by Braun and Hough in [\[BH17\]](#page-35-12), and their homotopy type by Matsushita in [\[Mat19\]](#page-35-13). In [\[GSS21\]](#page-35-14), Goyal et al. showed that  $M(P_n \Box P_3)$  is homotopy equivalent to a wedge of spheres. For  $m \geq 4$ , homotopy type of  $M(P_n \Box P_m)$  is not known.

Motivated from the cartesian product of path graphs, in this article, we consider the matching complexes of the categorical product  $P_n \times P_m$  of path graphs (see [Figure 1\)](#page-1-0). Since  $P_n \times P_1$  does not contain any edge,  $\mathsf{M}(P_n \times P_1)$  is a void complex. Further,  $P_n \times P_2$ is a disjoint union of two path graphs, and therefore  $M(P_n \times P_2)$  is homotopy equivalent to a wedge of spheres from [\[Koz99\]](#page-35-4). For  $3 \leq m \leq 5$ , we compute the homotopy type of the matching complexes of  $P_n \times P_m$ .

<span id="page-1-2"></span>**Theorem 1.3.** For  $n \geq 2$  and  $3 \leq m \leq 5$ ,  $M(P_n \times P_m)$  is homotopy equivalent to a wedge of spheres.

We explicitly compute the dimension and number of spheres in the homotopy type of  $M(P_n \times P_3)$  (see [Theorem 5.5\)](#page-34-0). For  $m \in \{4, 5\}$ , we give the minimum and maximum dimension of spheres appearing in the wedge in homotopy type of  $M(P_n \times P_m)$ .

<span id="page-1-3"></span>**Proposition 1.4.** For  $n \geq 3$ , let  $d_{max}M(P_n \times P_5)$  and  $d_{min}M(P_n \times P_5)$ , denote the maximum and minimum dimension of spheres appearing in the wedge in the homotopy type of  $M(P_n \times P_5)$ , respectively. Then  $d_{max}M(P_n \times P_5)$  and  $d_{min}M(P_n \times P_5)$  are given in [Table 1.](#page-1-1)

<span id="page-1-4"></span>**Proposition 1.5.** For  $n > 3$ , the minimum dimension of sphere in homotopy type of  $M(P_n \times P_4)$  is  $2k + 1$  if  $n = 2k + 2$ , and  $2(k + 1) + 1$  if  $n = 2k + 3$ . The maximum dimension of sphere in homotopy type of  $M(P_n \times P_4)$  is given in [Table 2.](#page-2-0)

The *line graph*  $L(G)$  of a graph G, is the graph whose vertices are the edges of G and any two distinct vertices  $uv$  and  $u'v'$  joined by an edge if and only if they have a common endpoint, *i.e.*, if  $\{u, v\} \cap \{u', v'\} \neq \emptyset$ . For a graph G, a subset  $A \subseteq V(G)$  is said to be independent if the induced subgraph on A does not contain any edge. The independence complex  $\text{Ind}(G)$  of G is a simplicial complex on  $V(G)$  whose simplices are the independent sets of G. Observe that  $M(G)$  is the same as the Ind( $L(G)$ ) for any graph G.

To prove [Theorem 1.3,](#page-1-2) we show that  $\text{Ind}(L(P_n \times P_m))$  is a wedge of spheres up to homotopy equivalence. The main idea used in this proof is to reduce the graph  $L(P_n \times$  $P_m$ ) into smaller graphs by the operations; deletions of vertices, deletions of edges, and additions of edges. During this process of reduction, we come across 13 new classes of graphs in the case  $m = 5$ , and 4 new classes of graphs in the case  $m = 4$ . We establish recursive relations among the independence complex of  $L(P_n \times P_m)$  and independence complexes of these new classes of graphs.

This paper is organized as follows: In [Section 2,](#page-2-1) we give necessary preliminaries related to graph theory and simplicial complexes, and results used in this article. [Section 3](#page-4-0) is majorly dedicated to the matching complexes of  $P_n \times P_5$  and it is divided into three subsections. The graph  $L(P_n \times P_5)$  is disconnected and has exactly two components. If  $n = 2k + 2$  is even, then  $L(P_n \times P_5)$  consists of two copies of the graph  $\Gamma_{k,5}$  (see [Figure 2\)](#page-5-0) and if  $n = 2k + 3$  is odd, then  $L(P_n \times P_5) = \Lambda_{n,5} \cup \tilde{\Gamma}_{n,5}$  (see [Figure 3](#page-5-1) and [Figure 4\)](#page-5-2). We start [Section 3](#page-4-0) with the definitions of the graphs  $\Gamma_{k,5}$ ,  $\Lambda_{k,5}$  and  $\tilde{\Gamma}_{k,5}$ . In [Section 3.1,](#page-5-3) we compute the independence complexes of  $\Gamma_{k,5}$  and  $\Lambda_{k,5}$ . We introduce 6 new classes of graphs (which we need in the computation of  $\text{Ind}(\Gamma_{k,5})$  and  $\text{Ind}(\Lambda_{k,5})$ ), and establish recursive relations among independence complexes of graphs  $\Gamma_{k,5}$ ,  $\Lambda_{k,5}$  and these 6 classes of graphs. In [Section 3.2,](#page-17-0) we compute independence complex of the graph  $\tilde{\Gamma}_{k,5}$ . Here again, we define another 7 class of graphs (which we need in the computation of  $\text{Ind}(\tilde{\Gamma}_{k,5})$ , and establish recursive relations among independence complexes of these 7 new classes of graphs and  $\text{Ind}(\tilde{\Gamma}_{k,5})$ . In [Section 3.3,](#page-21-0) we conclude the homotopy type of  $M(P_n \times P_5)$  and determine the minimum and maximum dimensions of spheres appearing in the wedge in  $M(P_n \times P_5)$ . In [Section 4](#page-24-0) and [Section 5,](#page-31-0) we compute the homotopy type of the matching complexes of  $P_n \times P_4$  and  $P_n \times P_3$ , respectively. Finally, in [Section 6,](#page-34-1) we pose a few questions and a conjecture, which naturally arise from the work done in this paper.

#### 2 Preliminaries

<span id="page-2-1"></span>A graph G is an ordered pair  $(V(G), E(G))$ , where  $V(G)$  is a finite set, called the set of vertices and  $E(G) \subseteq {V(G) \choose 2}$  $2^{(G)}$ , the 2-element subsets of  $V(G)$ , called the set of edges of G. For the sake of brevity, we denote an edge  $\{u, v\}$  by uv. Given a graph  $G = (V(G), E(G))$  and a vertex u in  $V(G)$ , the *open neighborhood* of u is defined as the collection  $\{v \in V(G) : uv \in E(G)\}\$ and it is denoted  $N(u)$ . The closed neighborhood of a vertex u in the graph G is defined as  $\{u\} \cup N(u)$  and it is denoted by N[u]. A map  $f: V(G) \to V(H)$  is said to be a *graph homomorphism* if  $f(v)f(w) \in E(H)$  for

all  $vw \in E(G)$ . An *isomorphism* is a graph homomorphism that is bijective, with its inverse also being a graph homomorphism. If such an isomorphism exists between two graphs G and H, they are called isomorphic, denoted as  $G \cong H$ . Let  $S = \{v_1, \ldots, v_r\}$ be a collection of vertices in  $V(G)$ . Then, by  $G \setminus S$  we mean the induced subgraph of G on the vertex set  $V(G) \setminus S$ . In particular, if S is the singleton set  $\{v_1\}$ , then we denote the graph  $G \setminus S$  by  $G \setminus v_1$ . Similarly, for a collection of edges  $T = \{e_1, e_2, \ldots, e_s\}$ , by  $G + T$  and  $G - T$  we mean the graphs on the vertex set  $V(G)$  with edge set  $E(G) \cup T$ and  $E(G) \setminus T$ , respectively. For more details about the graphs, one may refer to [\[Wes01\]](#page-35-15).

An *(abstract) simplicial complex*  $\Delta$  on a vertex set V is a collection of subsets of V such that if  $\sigma \in \Delta$  and  $\tau$  is a subset of  $\sigma$ , then  $\tau \in \Delta$ . If  $\sigma \in \Delta$  and  $|\sigma| = k + 1$ , then we say  $\sigma$  is a simplex of dimension k or a k-simplex. We further assume that the empty set is present in every simplicial complex as the only simplex of dimension  $-1$ . The 0-dimensional simplices are called the vertices of  $\Delta$ , and the set of all vertices of a simplicial complex  $\Delta$  is denoted by  $V(\Delta)$ .

A subcomplex of a simplicial complex is a sub-collection of simplices that itself forms a simplicial complex. If  $\Delta$  is a simplicial complex and  $\sigma$  is a simplex in  $\Delta$ , then the *link* and the deletion of  $\sigma$  is defined as the subcomplexes  $\{\tau \in \Delta : \sigma \cup \tau \in \Delta \}$  and  $\sigma \cap \tau = \emptyset$  and  ${\tau \in \Delta : \tau \nsubseteq \sigma}$ , respectively. The *join* of two simplicial complexes  $\Delta_1$  and  $\Delta_2$ , where  $V(\Delta_1) \cap V(\Delta_2) = \emptyset$ , is the simplicial complex  $\Delta_1 * \Delta_2 := \{ \sigma \sqcup \tau : \sigma \in \Delta_1 \text{ and } \tau \in \Delta_2 \}.$ In particular, if a, b are vertices that are not part of a simplicial complex  $\Delta$ , then the simplicial complexes  $\{a\}*\Delta$  and  $\{a\}*\Delta\cup\{b\}*\Delta$  are called the *cone* and the *suspension* of  $\Delta$  with the apexes a and  $\{a, b\}$ , respectively. We denote the suspension of  $\Delta$  with apex  $\{a, b\}$  by  $\Sigma_{a, b} \Delta$  (or  $\Sigma \Delta$ ).

In this article, we consider any simplicial complex as a topological space, namely its geometric realization. For the definition of geometric realization, we refer to [\[Koz08\]](#page-35-16). For details about homotopy and topological background, one may refer to [\[Hat02\]](#page-35-17).

<span id="page-3-3"></span>The following observation follows from the definition of the join of two simplicial complexes:

**Proposition 2.1.** Let  $G_1 \sqcup G_2$  denote the disjoint union of two graphs,  $G_1$  and  $G_2$ . Then

$$
Ind(G_1 \sqcup G_2) \simeq Ind(G_1) * Ind(G_2).
$$

Clearly, for each vertex  $v \in V(G)$ , the link and the deletion of the simplex  $\{v\}$ in Ind(G) are the same as Ind( $G \setminus N[v]$ ) and Ind( $G \setminus v$ ), respectively. Observe that Ind(G) is the same as the simplicial complex  $\{v\} * Ind(G \setminus N[v]) \cup Ind(G \setminus v)$ . Further, from [\[Ada12\]](#page-35-18), we have the following:

<span id="page-3-4"></span>**Proposition 2.2** (Proposition 3.1,  $[Ada12]$ ). Let v be a vertex of a graph G. If the inclusion  $\text{Ind}(G \setminus N[v]) \hookrightarrow \text{Ind}(G \setminus v)$  is null-homotopic, then we have

$$
Ind(G) \simeq Ind(G \setminus v) \vee \Sigma Ind(G \setminus N[v]).
$$

The following propositions exhibit homotopy equivalence between the independence complex of a graph G and the independence complexes of graphs derived from G through certain graph operations involving the deletion of vertices, edges, or vertexneighborhoods.

<span id="page-3-2"></span>**Proposition 2.3** (Lemma 2.4,  $[Eng 08]$ ). Let v and w be a pair of distinct vertices of G with  $N(v) \subseteq N(w)$ . Then

$$
Ind(G) \simeq Ind(G \setminus w).
$$

<span id="page-3-1"></span><span id="page-3-0"></span>**Proposition 2.4** (Lemma 2.5,  $[Eng 08]$ ). Let G be a graph and v be a simplicial vertex of G, that is, all neighbours of v are pairwise adjacent. Let  $N(v) = \{w_1, w_2, \ldots, w_k\}.$ Then

$$
\mathrm{Ind}(G) \simeq \bigvee_{i=1}^{k} \Sigma(\mathrm{Ind}(G \setminus N[w_i])).
$$

**Proposition 2.5** (Proposition 3.4,  $[Adal2]$ ). Let G be a graph and let uv be any edge in G. If  $\text{Ind}(G \setminus N[\{u, v\}])$  is contractible, then

$$
\mathrm{Ind}(G)\simeq \mathrm{Ind}(G\setminus uv)
$$

Based on the [Proposition 2.5,](#page-3-0) we have the following. Suppose  $G$  is a graph that consists vertices  $\{u, v\}$  and some vertex x (depending on u and v) such that  $x \notin N(u) \cup$  $N(v)$ , and  $N(x) \subseteq N(u) \cup N(v)$ . Then x is an isolated vertex in  $G \setminus N[u, v]$ , which implies  $\text{Ind}(G \setminus N[\{u, v\}])$  is contractible. Thus, we have

$$
Ind(G) \simeq Ind(G \triangle uv),
$$

where  $V(G \triangle uv) = V(G)$ , and  $E(G \triangle uv)$  is given by the symmetric difference  $E(G) \triangle \{uv\}$ .

**Definition 2.6.** A triplet of distinct vertices u, v and x in a graph G satisfying  $x \notin \mathbb{R}$  $N(u) \cup N(v)$  and  $N(x) \subseteq N(u) \cup N(v)$  is called an *edge-invariant triplet* in G, and denoted by  $[u, v; x]$ .

<span id="page-4-2"></span>For  $n \geq 1$ , the cycle graph  $\mathcal{C}_n$  is a graph with  $V(\mathcal{C}_n) = \{v_i \mid 1 \leq i \leq n\}$  and  $E(\mathcal{C}_n) = \{v_i v_{i+1} \mid 1 \leq i \leq n-1\} \cup \{v_1 v_n\}.$ 

**Proposition 2.7** (Proposition 5.2, [\[Koz99\]](#page-35-4)). For  $n \geq 3$ ,

$$
\operatorname{Ind}(\mathcal{C}_n) \simeq \begin{cases} \mathbb{S}^{k-1} \bigvee \mathbb{S}^{k-1} & \text{if } n = 3k, \\ \mathbb{S}^{k-1} & \text{if } n = 3k \pm 1. \end{cases}
$$

<span id="page-4-1"></span>For  $n \geq 1$ , the path graph  $P_n$  is a graph with  $V(P_n) = \{v_i \mid 1 \leq i \leq n\}$  and  $E(P_n) = \{v_i v_{i+1} \mid 1 \leq i \leq n-1\}.$ 

**Proposition 2.8** (Proposition 4.6, [\[Koz99\]](#page-35-4)). For  $n > 1$ ,

$$
\operatorname{Ind}(P_n) \simeq \begin{cases} \mathbb{S}^{k-1} & \text{if } n = 3k, \\ a \text{ point} & \text{if } n = 3k+1, \\ \mathbb{S}^k & \text{if } n = 3k+2. \end{cases}
$$

# 3 MATCHING COMPLEXES OF  $P_n \times P_5$

<span id="page-4-0"></span>In this section, we compute the homotopy type of the matching complex of the categorical product  $P_n \times P_5$ . Since  $P_n$  is bipartite,  $P_n \times P_5$  (and its line graph) is disconnected and contains exactly two connected components. When  $n$  is even, these components are isomorphic, whereas, for odd  $n$ , they are non-isomorphic.

For  $n \geq 0$ , we denote the connected component of the line graph of  $P_{2n+2} \times P_5$  by  $\Gamma_{n,5}$ (see [Figure 2\)](#page-5-0). Since the line graph  $L(P_{2n+2} \times P_5) = \Gamma_{n,5} \sqcup \Gamma_{n,5}$ , the matching complex

$$
\mathsf{M}(P_{2n+2}\times P_5)\simeq \mathrm{Ind}(L(P_{2n+2}\times P_5))\simeq \mathrm{Ind}(\Gamma_{n,5})\ast \mathrm{Ind}(\Gamma_{n,5}).
$$

Similarly, for  $n \geq 0$ , let  $\Lambda_{n,5}$  and  $\tilde{\Gamma}_{n,5}$  (see [Figures 3](#page-5-1) and [4\)](#page-5-2) denote the two non-isomorphic connected components of the line graph of  $P_{2n+3} \times P_5$ . Therefore, we have

$$
\mathsf{M}(P_{2n+3}\times P_5)=\mathrm{Ind}(L(P_{2n+3}\times P_5))\simeq \mathrm{Ind}(\Lambda_{n,5})\ast \mathrm{Ind}(\tilde{\Gamma}_{n,5}).
$$

We now define the graphs  $\Gamma_{n,5}$ ,  $\Lambda_{n,5}$  and  $\tilde{\Gamma}_{n,5}$ .

**Definition 3.1.** For  $n \geq 0$ , the graph  $\Gamma_{n,5}$  comprises of the vertex set

$$
V(\Gamma_{n,5}) = \{g_{ij} \mid i = 1, 2, 3, 4 \text{ and } j = 1, 2, \dots, 2n+1\},\
$$

where the vertices are arranged in 4 rows and  $2n + 1$  columns. The edge set of  $\Gamma_{n,5}$  is given by

$$
E(\Gamma_{n,5}) = \{g_{ij}g_{i+1 j} \mid i = 1, 2, 3, \text{ and } j = 1, 2, ..., 2n+1\}
$$
  

$$
\cup \{g_{ij}g_{i,j+1} \mid i = 1, 2, 3, 4, \text{ and } j = 1, 2, ..., 2n\}
$$
  

$$
\cup \{g_{ij}g_{i+1,j+1}, g_{ij+1}g_{i+1j} \mid i = 1, 2, 3, j = 1, 2, ..., 2n, \text{ and } i + j \equiv 1 \text{ (mod 2)}\}.
$$

**Definition 3.2.** For  $n \geq 0$ ,  $\Lambda_{n,5}$  is a graph whose vertex set and edge set is given by

<span id="page-5-1"></span> $V(\Lambda_{n,5}) = \{l_1, l_2, l_3, l_4\} \cup V(\Gamma_{n,5}),$  $E(\Lambda_{n,5}) = \{l_1l_2, l_2l_3, l_3l_4, g_{11}l_1, g_{11}l_2, g_{21}l_1, g_{21}l_2, g_{31}l_3, g_{31}l_4, g_{41}l_3, g_{41}l_4\} \cup E(\Gamma_{n,5}).$

**Definition 3.3.** For  $n \geq 0$ ,  $\tilde{\Gamma}_{n,5}$  is a graph whose vertex set and edge set is given by

<span id="page-5-3"></span>In the following section, we compute the homotopy type of  $\text{Ind}(\Gamma_{n,5})$  and  $\text{Ind}(\Lambda_{n,5})$ , and the homotopy type of  $\text{Ind}(\tilde{\Gamma}_{n,5})$  is computed in [Section 3.2.](#page-17-0) Finally, we give the minimum and maximum dimension of spheres in the homotopy type of  $M(P_n \times P_5)$  in [Section 3.3.](#page-21-0)

#### 3.1 Independence complexes of  $\Gamma_{n,5}$  and  $\Lambda_{n,5}$

In this section, we introduce 6 new classes of graphs, namely;  $A_{n,5}, B_{n,5}, C_{n,5}, D_{n,5}$  $E_{n,5}$ , and  $F_{n,5}$  for  $n \geq 0$ . We show that the independence complexes of  $\Gamma_{n,5}$  and  $\Lambda_{n,5}$ can be expressed in terms of the wedge of suspensions of independence complexes of these intermediary graphs. Through induction on  $n$ , we establish that the independence complexes of  $\Gamma_{n,5}$ ,  $\Lambda_{n,5}$ , and these intermediary graphs are homotopy equivalent to a wedge of spheres.

<span id="page-6-0"></span>We begin with the description of the intermediary graphs and compute the homotopy type of their independence complexes for  $n = 0$ .

# 3.1.1 Definitions of intermediary graphs and their independence complexes for  $n = 0$

<span id="page-6-1"></span>(i) Graph  $A_{n,5}$ . For  $n \geq 0$ , we define the graph  $A_{n,5}$  as follows:

V(A_{n,5}) = V(\Gamma_{n,5}) \cup \{a_1, a_2\},

E(A_{n,5}) = E(\Gamma_{n,5}) \cup \{a_1g_{11}, a_1g_{21}, a_2g_{31}, a_2g_{41}\}.
$$

<span id="page-6-2"></span>Claim 3.4.  $\text{Ind}(A_{0,5}) \simeq \mathbb{S}^1 \vee \mathbb{S}^1 \vee \mathbb{S}^1$ .

*Proof.* Since  $a_1$  is a simplicial vertex in the graph  $A_{0,5}$  with  $N(a_1) = \{g_{11}, g_{21}\}\text{, using }$ [Proposition 2.4](#page-3-1) we get

$$
Ind(A_{0,5}) \simeq \Sigma Ind(A_{0,5} \setminus N[g_{11}]) \vee \Sigma Ind(A_{0,5} \setminus N[g_{21}]).
$$

However,  $A_{0,5} \setminus N[g_{11}]$  is isomorphic to  $K_3$ , and  $A_{0,5} \setminus N[g_{21}]$  is isomorphic to  $K_2$ . Therefore,  $\text{Ind}(A_{0,5} \setminus N[g_{11}]) \simeq \mathbb{S}^0 \vee \mathbb{S}^0$  and  $\text{Ind}(A_{0,5} \setminus N[g_{21}]) \simeq \mathbb{S}^0$ . Hence, we have the stated conclusion.

(ii) **Graph**  $B_{n,5}$ . For  $n \geq 0$ , we define the graph  $B_{n,5}$  as follows:

$$
V(B_{n,5}) = V(\Gamma_{n,5}) \cup \{b_1, b_2, b_3, b_4, b_5, b_6\},
$$
  
\n
$$
E(B_{n,5}) = E(\Gamma_{n,5}) \cup \{b_1b_2, b_1b_4, b_1b_5, b_2b_6, b_3b_4, b_4b_5, b_5b_6\}
$$
  
\n
$$
\cup \{b_3g_{11}, b_3g_{21}, b_4g_{11}, b_4g_{21}, b_5g_{31}, b_5g_{41}, b_6g_{31}, b_6g_{41}\}.
$$

Furthermore, we define  $B_{-1}$  as a graph on vertex set  $\{b_1, b_2\}$ , and edge set  $\{b_1b_2\}$ . Thus,  $B_{-1} \cong K_2$ .

Claim 3.5.  $\text{Ind}(B_{0,5}) \simeq \mathbb{S}^1 \vee \mathbb{S}^2$ .

*Proof.* Since  $g_{41}$  is a simplicial vertex in graph  $B_{0,5}$  with  $N(g_{41}) = \{g_{31}, b_5, b_6\}$ , using [Proposition 2.4](#page-3-1) we get

 $\text{Ind}(B_{0.5}) \simeq \Sigma(\text{Ind}(B_{0.5} \setminus N[g_{31}])) \vee \Sigma(\text{Ind}(B_{0.5} \setminus N[b_6])) \vee \Sigma(\text{Ind}(B_{0.5} \setminus N[b_5])).$ 

Now,  $b_2$  is an isolated vertex in the graph  $B_{0,5} \setminus N[b_5]$ . Therefore, Ind $(B_{0,5} \setminus N[b_5])$  is contractible. Since  $N(b_2) \subseteq N(b_4)$  in the graph  $B_{0.5} \backslash N[g_{31}]$ , using [Proposition 2.5](#page-3-0) we get  $\text{Ind}(B_{0,5} \setminus N[g_{31}]) \simeq \text{Ind}(B_{0,5} \setminus \{N[g_{31}] \cup \{b_4\}\})$ . Since the graph  $B_{0,5} \setminus \{N[g_{31}] \cup \{b_4\}\}$

consists of two disjoint edges, we have  $\text{Ind}(B_{0,5} \setminus N[g_{31}]) \simeq \text{Ind}(K_2) * \text{Ind}(K_2)$ , i.e.,  $\text{Ind}(B_{0,5} \setminus N[g_{31}]) \simeq \mathbb{S}^1$ . Similarly,  $N(b_1) \subseteq N(b_3) \cap N(g_{11}) \cap N(g_{21})$  in the graph  $B_{0,5} \setminus N[b_6]$  implies that  $\text{Ind}(B_{0,5} \setminus N[b_6]) \simeq \text{Ind}(B_{0,5} \setminus \{N[b_6] \cup \{b_3, g_{11}, g_{21}\})$ . Since  $B_{0,5}\setminus\{N[b_6]\cup\{b_3, g_{11}, g_{21}\}\}\$ is isomorphic to the graph  $K_2$ , we have  $\text{Ind}(B_{0,5}\setminus N[b_6])\simeq\mathbb{S}^0$ . Therefore, using the fact that  $\text{Ind}(B_{0,5} \setminus N[g_{31}]) \simeq \mathbb{S}^1$  and  $\text{Ind}(B_{0,5} \setminus N[b_6]) \simeq \mathbb{S}^0$ , we get  $\mathrm{Ind}(B_{0,5})\simeq \mathbb{S}^1\vee \mathbb{S}^2$ .

<span id="page-7-1"></span>(iii) **Graph**  $C_{n,5}$ . For  $n \geq 0$ , we define the graph  $C_{n,5}$  as follows:

V(C_{n,5}) = V(\Gamma_{n,5}) \cup \{c_1\},

E(C_{n,5}) = E(\Gamma_{n,5}) \cup \{c_1g_{31}, c_1g_{41}\}.

<span id="page-7-2"></span>Claim 3.6. Ind $(C_{0,5}) \simeq \mathbb{S}^1$ .

*Proof.* Since  $N(g_{11}) \subseteq N(g_{31})$  in the graph  $C_{0,5}$ , using [Proposition 2.3,](#page-3-2) we conclude that  $Ind(C_{0,5}) \simeq Ind(C_{0,5} \setminus \{g_{31}\}).$  However, the graph  $C_{0,5} \setminus \{g_{31}\}\)$  consists of two disjoint edges. Therefore,  $\text{Ind}(C_{0,5}) \simeq \mathbb{S}^1$ .

(iv) Graph  $D_{n,5}$ . For  $n \geq 0$ , we define the graph  $D_{n,5}$  as follows:

$$
V(D_{n,5}) = V(\Gamma_{n,5}) \cup \{d_1, d_2\},
$$

E(D_{n,5}) = E(\Gamma_{n,5}) \cup \{d_1d_2, d_1g_{11}, d_1g_{21}, d_2g_{31}, d_2g_{41}\}.
$$

<span id="page-7-3"></span>Claim 3.7.  $\text{Ind}(D_{0,5}) \simeq \mathbb{S}^1 \vee \mathbb{S}^1$ .

*Proof.* Since  $g_{11}$  is a simplicial vertex in the graph  $D_{0,5}$  with  $N(g_{11}) = \{g_{21}, d_1\}$ , using [Proposition 2.4,](#page-3-1) we get  $\text{Ind}(D_{0.5}) \simeq \Sigma(\text{Ind}(D_{0.5}\backslash N[g_{21}]))\vee\Sigma(\text{Ind}(D_{0.5}\backslash N[d_1]))$ . However, both the graphs  $D_{0,5} \setminus N[g_{21}]$ , and  $D_{0,5} \setminus N[d_1]$  are isomorphic to the complete graph  $K_2$ . Therefore, both Ind( $D_{0.5} \setminus N[g_{21}]$ ) and Ind( $D_{0.5} \setminus N[d_1]$ ) are homotopy equivalent to  $\mathbb{S}^0$ . Hence the result.

V(E_{n,5}) = V(\Gamma_{n,5}) \cup \{e_1\},

E(E_{n,5}) = E(\Gamma_{n,5}) \cup \{e_1g_{11}, e_1g_{21}, e_1g_{31}, e_1g_{41}\}.

<span id="page-8-2"></span>Claim 3.8. Ind $(E_{0,5}) \simeq \mathbb{S}^0$ .

*Proof.* Since  $N(g_{11}) \subseteq N(g_{31})$  in the graph  $E_{0,5}$ , by [Proposition 2.3,](#page-3-2) we get Ind( $E_{0,5}$ )  $\simeq$ Ind( $E_{0,5} \setminus g_{31}$ ). Furthermore,  $N(g_{41}) \subseteq N(g_{11})$  in  $E_{n,5} \setminus g_{31}$ , and an application of [Proposition 2.3](#page-3-2) provides us with  $\text{Ind}(E_{0,5}) \simeq \text{Ind}(E_{0,5} \setminus \{g_{11}, g_{31}\})$ . Note that the graph  $E_{0,5} \setminus \{g_{11}, g_{31}\}\$ is a path on three vertices. Therefore, Ind $(E_{0,5}) \simeq \mathbb{S}^0$ . — Профессор <br>В профессор — Профессор —

<span id="page-8-4"></span>Claim 3.9. Ind $(F_{0,5}) \simeq \vee_4 {\mathbb S}^1$ .

*Proof.* Since  $g_{11}$  is a simplicial vertex in  $E_{0,5}$  with  $N(g_{11}) = \{g_{21}, f_1\}$ , using [Proposition 2.4](#page-3-1) we get  $\text{Ind}(F_{0,5}) \simeq \Sigma(\text{Ind}(F_{0,5} \setminus N[g_{21}])) \vee \Sigma(\text{Ind}(F_{0,5} \setminus N[f_1])).$  Since both the graphs  $F_{0.5} \setminus N[g_{21}]$  and  $F_{0.5} \setminus N[f_1]$  are isomorphic to the complete graph  $K_3$ , the result fol $l$  lows.

# <span id="page-9-2"></span>3.1.2 General case computation

In this section, we establish recursive relations among the independence complexes of the graphs in  $\{\Gamma_{n,5}, \Lambda_{n,5}, A_{n,5}, B_{n,5}, C_{n,5}, D_{n,5}, E_{n,5}, F_{n,5}\}$ . We proceed by induction on n to show that the homotopy type of independence complexes of  $\Gamma_{n,5}$ ,  $\Lambda_{n,5}$  and other intermediary graphs is a wedge of spheres. We have proved in [Section 3.1.1](#page-6-0) that independence complexes of graphs in  $\{\Gamma_{0,5}, \Lambda_{0,5}, A_{0,5}, B_{0,5}, C_{0,5}, D_{0,5}, E_{0,5}, F_{0,5}\}\)$  are homotopy equivalent to wedge of spheres. By induction hypothesis, assume that for all  $k < n$ , the independence complexes of graphs in  $\{\Gamma_{k,5}, \Lambda_{k,5}, A_{k,5}, B_{k,5}, C_{k,5}, D_{k,5}, E_{k,5}, F_{k,5}\}$  are wedge of spheres. We conclude the proof for  $n$  by induction and the recurrence relations among independence complexes of these graphs.

*Proof.* Since  $N(g_{11}) \subseteq N(g_{22})$  and  $N(g_{41}) \subseteq N(g_{32})$  in  $\Gamma_{n,5}$  and  $\Gamma_{n,5} \setminus g_{22}$ , respectively (see [Figure 2\)](#page-5-0), using [Proposition 2.3,](#page-3-2) we get that  $\text{Ind}(\Gamma_{n,5}) \simeq \text{Ind}(\Gamma_{n,5} \setminus \{g_{22}, g_{32}\}).$ Let  $\Gamma^1_{n,5} = \Gamma_{n,5} \setminus \{g_{22}, g_{32}\}.$  Since  $[g_{41}, g_{12}; g_{21}]$  forms an edge-invariant triplet in  $\Gamma^1_{n,5}$ (see [Figure 11\(a\)\)](#page-9-0), from [Proposition 2.5,](#page-3-0) we have  $\text{Ind}(\Gamma^1_{n,5}) \simeq \text{Ind}(\Gamma^1_{n,5} + \{g_{41}g_{12}\})$ . Let  $\Gamma^2_{n,5} = \Gamma^1_{n,5} + \{g_{41}g_{12}\}.$  Similarly,  $[g_{31}, g_{41}; g_{11}]$  forms an edge-invariant triplet in  $\Gamma^2_{n,5}$ (see [Figure 11\(b\)\)](#page-9-0), which allows us to delete edge  $g_{31}g_{41}$  from  $\Gamma^2_{n,5}$  without altering the homotopy type of  $\text{Ind}(\Gamma_{n,5}^2)$ . Now, since  $N(g_{31}) \subseteq N(g_{11})$  in  $\Gamma_{n,5}^2 - \{g_{31}g_{41}\}\$ , using [Proposition 2.3,](#page-3-2) we get that  $\text{Ind}(\Gamma_{n,5}^2 - \{g_{31}g_{41}\}) \simeq \text{Ind}((\Gamma_{n,5}^2 - \{g_{31}g_{41}\}) \setminus g_{11})$ . Let  $\Gamma_{n,5}^3 = (\Gamma_{n,5}^2 - \{g_{31}g_{41}\}) \setminus g_{11}$  (see [Figure 11\(c\)\)](#page-9-0). Observe that  $[g_{13}, g_{33}; g_{41}]$  is an edgeinvariant triplet in  $\Gamma_{n,5}^3$ ,  $[g_{13}, g_{43}; g_{41}]$  is an edge-invariant triplet in  $\Gamma_{n,5}^3 + \{g_{13}g_{33}\}\$ , and  $[g_{23}, g_{43}; g_{41}]$  is an edge-invariant triplet in  $\Gamma^3_{n,5} + \{g_{13}g_{33}, g_{13}g_{43}\}.$  Hence  $\text{Ind}(\Gamma^3_{n,5}) \simeq$  $\text{Ind}(\Gamma^3_{n,5} + \{g_{13}g_{33}, g_{13}g_{43}, g_{23}g_{43}\})$ . Furthermore,  $[g_{42}, g_{33}; g_{12}]$  is an edge-invariant triplet in  $\Gamma_{n,5}^3 + \{g_{13}g_{33}, g_{13}g_{43}, g_{23}g_{43}\}$ , and  $[g_{42}, g_{43}; g_{12}]$  is an edge-invariant triplet in  $\Gamma_{n,5}^3$  +

 ${g_{13}g_{33}, g_{13}g_{43}, g_{23}g_{43}}-{g_{33}g_{42}}.$  Let  $\Gamma_{n,5}^4 := \Gamma_{n,5}^3 + {g_{13}g_{33}, g_{13}g_{43}, g_{23}g_{43}}-{g_{33}g_{42}, g_{42}g_{43}}$ (see [Figure 11\(d\)\)](#page-9-0). Then, we have  $\text{Ind}(\Gamma_{n,5}^3) \simeq \text{Ind}(\Gamma_{n,5}^4)$ . In  $\Gamma_{n,5}^4$ , since  $N(g_{42}) \subseteq N(g_{12})$ , we have  $\text{Ind}(\Gamma^4_{n,5}) \simeq \text{Ind}(\Gamma^4_{n,5} \setminus g_{12})$ . The graph,  $\Gamma^4_{n,5} \setminus g_{12}$ , consists of three connected components, namely  $g_{21}g_{31}, g_{41}g_{42}$  and the third component denoted by  $\Gamma_{n,5}^5$  depicted in [Figure 11\(e\).](#page-9-0) From [Proposition 2.1,](#page-3-3) it follows that

$$
Ind(\Gamma_{n,5}) \simeq \Sigma^2 Ind(\Gamma_{n,5}^5).
$$

In particular, for  $\Gamma_{1,5}$ , the graph  $\Gamma_{1,5}^5$  is isomorphic to the complete graph  $K_4$ . Therefore,  $\text{Ind}(\Gamma_{1,5}) \simeq \Sigma^2 \text{Ind}(K_4) \simeq \mathbb{S}^2 \vee \mathbb{S}^2 \vee \mathbb{S}^2$ .

Now, let  $n \geq 2$ . Note that,  $\Gamma_{n,5}^5 \setminus N[g_{23}]$  is isomorphic to  $A_{n-2,5}$  (see [Figure 5\)](#page-6-1) and  $\text{Ind}(\Gamma^5_{n,5}\setminus N[g_{23}])\ast\{g_{33}\}\$ is a subcomplex of  $\text{Ind}(\Gamma^5_{n,5}\setminus g_{23})$ , which implies that  $\text{Ind}(\Gamma^5_{n,5}\setminus g_{23})$  $N[g_{23}]$ ) is contractible in  $\text{Ind}(\Gamma_{n,5}^5 \setminus g_{23})$ , that is,  $\text{Ind}(\Gamma_{n,5}^5 \setminus N[g_{23}]) \hookrightarrow \text{Ind}(\Gamma_{n,5}^5 \setminus g_{23})$  is null homotopic. Hence from [Proposition 2.2,](#page-3-4) we have

$$
\operatorname{Ind}(\Gamma_{n,5}) \simeq \Sigma^2 \left( \operatorname{Ind}(\Gamma_{n,5}^5 \setminus g_{23}) \vee \Sigma \operatorname{Ind}(A_{n-2,5}) \right). \tag{3.1}
$$

We now compute the homotopy type of  $\text{Ind}(\Gamma_{n,5}^5 \setminus g_{23})$ . Let  $\Gamma_{n,5}^6 := \Gamma_{n,5}^5 \setminus g_{23}$  and  $\Gamma_{n,5}^7 \coloneqq \Gamma_{n,5}^6 \setminus N[g_{14}]$  depicted in [Figures 11\(f\)](#page-9-0) and [11\(g\),](#page-9-0) respectively. We first show that Ind( $\Gamma_{n,5}^7$ ) is contractible in Ind( $\Gamma_{n,5}^6 \setminus g_{14}$ ).

Since  $[g_{34}, g_{45}; g_{43}]$  and  $[g_{35}, g_{44}; g_{33}]$  are edge-invariant triplets in  $\Gamma_{n,5}^7$  and  $\Gamma_{n,5}^7$  - ${g_{34}}g_{45}$ , respectively, using [Proposition 2.5,](#page-3-0) we have Ind( $\Gamma_{n,5}^7$ )  $\simeq$  Ind( $\Gamma_{n,5}^7 - {g_{35}}g_{44}$ ,  $(g_{34}g_{45})$ . Similarly,  $[g_{34}, g_{35}; g_{43}]$  and  $[g_{44}, g_{45}; g_{33}]$  form edge-invariant triplets in  $\Gamma_{n,5}^7$  –  ${g_{34}}g_{45}, g_{35}g_{44}$  and  $(\Gamma^7_{n,5} - {g_{34}}g_{45}, g_{35}g_{44}) - {g_{34}}g_{35}$ , respectively. Let  $\Gamma^8_{n,5} = (\Gamma^7_{n,5} {g_{34}}g_{45}, g_{35}g_{44}\})-{g_{34}}g_{35}, g_{44}g_{45}$  (see [Figure 11\(h\)\)](#page-9-0). Consequently, we have Ind( $\Gamma_{n,5}^{7}$ )  $\simeq$ Ind( $\Gamma_{n,5}^8$ ). Observe that the graph  $\Gamma_{n,5}^8$  contains a connected component that is isomorphic to a 4-cycle induced by vertices  $\{g_{33}, g_{34}, g_{43}, g_{44}\}$ , and another connected component isomorphic to  $B_{n-3,5}$  depicted in [Figure 6.](#page-7-0) Since  $N(g_{44}) \subseteq N(g_{33})$  and  $N(g_{34}) \subseteq N(g_{43})$ , we delete vertices  $g_{33}$  and  $g_{43}$  in  $\Gamma^8_{n,5}$  using [Proposition 2.3,](#page-3-2) and have  $\text{Ind}(\Gamma_{n,5}^8) \simeq \Sigma \text{Ind}(B_{n-3,5})$ . Furthermore, we have the following sequence

$$
\operatorname{Ind}(\Gamma_{n,5}^7)\xrightarrow{\simeq}\operatorname{Ind}(\Gamma_{n,5}^8\backslash\{g_{33},g_{43}\})\xrightarrow{\operatorname{Id}}\operatorname{Ind}((\Gamma_{n,5}^8\backslash\{g_{33},g_{43}\})\sqcup\{g_{13}\})\xrightarrow{\operatorname{Id}}\operatorname{Ind}(\Gamma_{n,5}^6\backslash g_{14}),
$$

where  $\text{Ind}((\Gamma^8_{n,5} \setminus \{g_{33}, g_{43}\}) \sqcup \{g_{13}\}) \simeq \text{Ind}(\Gamma^8_{n,5} \setminus \{g_{33}, g_{43}\}) * g_{13}$ , and hence contractible. This implies that  $\text{Ind}(\Gamma^7_{n,5}) \hookrightarrow \text{Ind}(\Gamma^6_{n,5} \setminus g_{14})$  is null homotopic. Therefore, by [Proposition 2.2,](#page-3-4) we have

$$
\operatorname{Ind}(\Gamma_{n,5}^6) \simeq \Sigma \operatorname{Ind}(\Gamma_{n,5}^7) \vee \operatorname{Ind}(\Gamma_{n,5}^6 \setminus g_{14}) \simeq \Sigma^2 \operatorname{Ind}(B_{n-3,5}) \vee \operatorname{Ind}(\Gamma_{n,5}^6 \setminus g_{14}),\tag{3.2}
$$

where the second equivalence follows from  $\text{Ind}(\Gamma^7_{n,5}) \simeq \text{Ind}(\Gamma^8_{n,5}) \simeq \text{Lind}(B_{n-3,5})$ . Finally, observe that  $g_{13}$  is a simplicial vertex in  $\Gamma_{n,5}^6 \setminus g_{14}$ , with  $N(g_{13}) = \{g_{33}, g_{43}\}.$ Therefore, applying [Proposition 2.4,](#page-3-1) we get

$$
\operatorname{Ind}(\Gamma_{n,5}^{6} \setminus g_{14}) \simeq \Sigma \operatorname{Ind}((\Gamma_{n,5}^{6} \setminus g_{14}) \setminus N[g_{33}]) \vee \Sigma \operatorname{Ind}((\Gamma_{n,5}^{6} \setminus g_{14}) \setminus N[g_{43}]).
$$

From [Figure 7](#page-7-1) and [Figure 8,](#page-8-0) we observe that  $(\Gamma_{n,5}^6 \setminus g_{14}) \setminus N[g_{33}] \simeq C_{n-2,5}$  and  $(\Gamma_{n,5}^6 \setminus g_{14})$  $g_{14}) \setminus N[g_{43}] \simeq D_{n-2,5}$ . Therefore,

$$
\operatorname{Ind}(\Gamma_{n,5}^{6} \setminus g_{14}) \simeq \Sigma \operatorname{Ind}(C_{n-2,5}) \vee \Sigma \operatorname{Ind}(D_{n-2,5}).\tag{3.3}
$$

Combining [\(3.1\)](#page-10-0), [\(3.2\)](#page-10-1), and [\(3.3\)](#page-10-2), we get the required recurrence for  $n \geq 3$ . However, for  $n = 2$ , we have  $\text{Ind}(\Gamma_{2,5}) \simeq \Sigma^3 \text{Ind}(A_{0,5}) \vee \Sigma^4 \text{Ind}(B_{-1}) \vee \Sigma^3 \text{Ind}(C_{0,5}) \vee \Sigma^3 \text{Ind}(D_{0,5}) \simeq \vee_7 \mathbb{S}^4$ using [Claims 3.4,](#page-6-2) [3.6](#page-7-2) and [3.7](#page-7-3) and the fact that  $B_{-1} \cong K_2$ .

<span id="page-10-3"></span>Claim 3.11. For  $n \ge 1$ , Ind( $A_{n,5}$ ) ≃  $\Sigma^2$ Ind( $C_{n-1,5}$ ) ∨  $\Sigma^2$ Ind( $C_{n-1,5}$ ) ∨  $\Sigma^2$ Ind( $D_{n-1,5}$ ).

*Proof.* Since  $a_1$  is a simplicial vertex in  $A_{n,5}$  (see [Figure 5\)](#page-6-1), with  $N(a_1) = \{g_{11}, g_{21}\},\$ using [Proposition 2.4,](#page-3-1) we have

$$
Ind(A_{n,5}) \simeq \Sigma Ind(A_{n,5} \setminus N[g_{11}]) \vee \Sigma Ind(A_{n,5} \setminus N[g_{21}]).
$$

Furthermore,  $a_2$  is a simplicial vertex in  $A_{n,5} \setminus N[g_{11}]$  with  $N(a_2) = \{g_{31}, g_{41}\}$ , and a simplicial vertex in  $A_{n,5} \backslash N[g_{21}]$  with  $N(a_2) = \{g_{41}\}\.$  Therefore, [Proposition 2.4](#page-3-1) provides us

$$
\text{Ind}(A_{n,5}) \simeq \Sigma^2 \text{Ind}(A_{n,5} \setminus N[g_{11}, g_{31}]) \vee \Sigma^2 \text{Ind}(A_{n,5} \setminus N[g_{11}, g_{41}])
$$
  

$$
\vee \Sigma^2 \text{Ind}(A_{n,5} \setminus N[g_{21}, g_{41}]).
$$

Note that the graphs  $A_{n,5} \setminus N[g_{11}, g_{31}]$  and  $A_{n,5} \setminus N[g_{21}, g_{41}]$  are isomorphic to  $C_{n-1,5}$ , whereas the graph  $A_{n,5} \setminus N[g_{11}, g_{41}]$  is isomorphic to  $D_{n-1,5}$  (refer to [Figures 5,](#page-6-1) [7](#page-7-1) and [8\)](#page-8-0). Therefore,  $\text{Ind}(A_{n,5}) \simeq \Sigma^2 \text{Ind}(C_{n-1,5}) \vee \Sigma^2 \text{Ind}(D_{n-1,5}) \vee \Sigma^2 \text{Ind}(C_{n-1,5}).$ 

<span id="page-11-1"></span>Claim 3.12. For  $n \geq 1$ ,  $\text{Ind}(B_{n,5}) \simeq \Sigma \text{Ind}(C_{n,5}) \vee \Sigma^2 \text{Ind}(\Lambda_{n-1,5}).$ 

<span id="page-11-0"></span>

*Proof.* Since  $N(b_2) \subseteq N(b_5)$  in the graph  $B_{n,5}$  (see [Figure 6\)](#page-7-0), using [Proposition 2.3,](#page-3-2) we get Ind $(B_{n,5}) \simeq \text{Ind}(B_{n,5} \setminus b_5)$ . Observe that  $[b_4, g_{41}; b_2]$  is an edge-invariant triplet in  $B_{n,5} \setminus b_5$ . Therefore, by [Proposition 2.5,](#page-3-0) we have  $\text{Ind}(B_{n,5}) \simeq \text{Ind}(B_{n,5}^1)$ , where  $B_{n,5}^1 = (B_{n,5} \setminus b_5) + \{b_4g_{41}\}\$  (see [Figure 13\(a\)\)](#page-11-0). Furthermore,  $[b_4, g_{31}; b_2]$  is an edgeinvariant triplet in  $B_{n,5}^1$ , and  $[b_1, b_4; b_6]$  is an edge-invariant triplet in  $B_{n,5}^1 + \{b_4g_{31}\}.$ Let  $B_{n,5}^2 \coloneqq (B_{n,5}^1 + \{b_4g_{31}\}) - \{b_1b_4\}$  (see [Figure 13\(b\)\)](#page-11-0). Then,  $\text{Ind}(B_{n,5}) \simeq \text{Ind}(B_{n,5}^2)$ . Since  $N(b_1) \subseteq N(b_6)$  in  $B_{n,5}^2$ , using [Proposition 2.3,](#page-3-2) we have  $\text{Ind}(B_{n,5}^2) \simeq \text{Ind}(B_{n,5}^2 \setminus b_6)$ . Note that the graph  $B_{n,5}^2 \setminus b_6$  comprises two connected components: an edge  $b_1b_2$  and another component that we call  $B_{n,5}^3$  (see [Figure 13\(c\)\)](#page-11-0). This implies that  $\text{Ind}(B_{n,5}) \simeq$  $\text{Ind}(B_{n,5}^2) \simeq \text{LInd}(B_{n,5}^3)$ . Observe that  $\text{Ind}(B_{n,5}^3 \setminus N[b_4)]) * \{b_3\}$  is a subcomplex of  $\text{Ind}(B_{n,5}^3 \setminus b_4)$ , which implies that the inclusion map  $\text{Ind}(B_{n,5}^3 \setminus N[b_4)]) \hookrightarrow \text{Ind}(B_{n,5}^3 \setminus b_4)$ is null homotopic. Therefore, by [Proposition 2.2,](#page-3-4) we get

$$
\operatorname{Ind}(B_{n,5}^3) \simeq \operatorname{Ind}(B_{n,5}^3 \setminus b_4) \vee \Sigma \operatorname{Ind}(B_{n,5}^3 \setminus N[b_4)]).
$$

Note that, the graph  $B_{n,5}^3 \setminus N[b_4]$  is isomorphic to the graph  $\Lambda_{n-1,5}$  and graph  $B_{n,5}^3 \setminus$  $b_4$  is isomorphic to  $C_{n,5}$  (refer to [Figure 3](#page-5-1) and [Figure 7\)](#page-7-1). Further, since Ind $(B_{n,5}) \simeq$  $\Sigma Ind(B_{n,5}^3)$ , we have  $Ind(B_{n,5}) \simeq \Sigma Ind(C_{n,5}) \vee \Sigma^2 Ind(\Lambda_{n-1,5})$ .

# <span id="page-12-3"></span>Claim 3.13. For  $n \geq 1$ ,

$$
\operatorname{Ind}(C_{n,5}) \simeq \begin{cases} \mathbb{S}^2 \vee \mathbb{S}^2 \vee \mathbb{S}^2 & \text{if } n = 1, \\ \Sigma^3 \operatorname{Ind}(A_{n-2,5}) \vee \Sigma^2 \operatorname{Ind}(E_{n-1,5}) \vee \Sigma^3 \operatorname{Ind}(F_{n-2,5}) & \text{if } n \ge 2. \end{cases}
$$

*Proof.* Since  $N(g_{11}) \subseteq N(g_{22})$  in the graph  $C_{n,5}$  (see [Figure 7\)](#page-7-1), by [Proposition 2.3,](#page-3-2) we have  $\text{Ind}(C_{n,5}) \simeq \text{Ind}(C_{n,5} \setminus g_{22})$ . We denote the graph  $C_{n,5} \setminus g_{22}$  by  $C_{n,5}^1$ . Since  $c_1$  is a simplicial vertex and  $N(c_1) = \{g_{31}, g_{41}\}\$ in  $C_{n,5}^1$ , using [Proposition 2.4,](#page-3-1) we get that

$$
\operatorname{Ind}(C_{n,5}^1) \simeq \Sigma \operatorname{Ind}(C_{n,5}^1 \setminus N[g_{31}]) \vee \Sigma \operatorname{Ind}(C_{n,5}^1 \setminus N[g_{41}]).
$$
\n(3.4)

Let  $C_{n,5}^2 \coloneqq C_{n,5}^1 \backslash N[g_{41}]$  (see [Figure 14\(a\)\)](#page-12-0). Since  $[g_{13}, g_{32}; g_{11}]$  and  $[g_{23}, g_{32}; g_{11}]$  are edgeinvariant triplets in  $C_{n,5}^2$  and  $C_{n,5}^2 + \{g_{13}g_{32}\}\$ , respectively,  $\text{Ind}(C_{n,5}^2) \simeq \text{Ind}(C_{n,5}^2 + \{g_{13}g_{32},\}$  $(g_{23}g_{32})$ ) using [Proposition 2.5.](#page-3-0) Analogously,  $[g_{12}, g_{13}; g_{21}]$  and  $[g_{12}, g_{23}; g_{21}]$  form edge invariant triplets in  $C_{n,5}^2 + \{g_{13}g_{32}, g_{32}g_{23}\}$  and  $C_{n,5}^2 + \{g_{13}g_{32}, g_{32}g_{23}\} - \{g_{12}g_{13}\}$ , respectively. Thus, we have  $\text{Ind}(C_{n,5}^2 + \{g_{13}g_{32}, g_{32}g_{23}\}) \simeq \text{Ind}(C_{n,5}^2 + \{g_{13}g_{32}, g_{32}g_{23}\} {g_{12}g_{13}, g_{12}g_{23}}$ . We denote the graph  $C_{n,5}^2 + {g_{13}g_{32}, g_{32}g_{23}} - {g_{12}g_{13}, g_{12}g_{23}}$  by  $C_{n,5}^3$ , depicted in [Figure 14\(b\).](#page-12-0) Then,  $\text{Ind}(C_{n,5}^2) \simeq \text{Ind}(C_{n,5}^3)$ . Furthermore,  $N(g_{12}) \subseteq N(g_{21})$ in  $C_{n,5}^3$ . Therefore, by [Proposition 2.3,](#page-3-2) we have  $\text{Ind}(C_{n,5}^3) \simeq \text{Ind}(C_{n,5}^3 \setminus g_{21})$ . Observe that the graph  $C_{n,5}^3 \setminus g_{21}$  consists of two connected components, one of which is an edge  $g_{11}g_{12}$  and the other connected component is isomorphic to  $E_{n-1,5}$  (see [Figure 9\)](#page-8-1). Thus, we have

$$
\operatorname{Ind}(C_{n,5}^2) \simeq \Sigma \operatorname{Ind}(E_{n-1,5}).\tag{3.5}
$$

On the other hand, let  $C_{n,5}^4 := C_{n,5}^1 \setminus N[g_{31}]$  (see [Figure 14\(c\)\)](#page-12-0). Since  $g_{11}$  is a pendant vertex in  $C_{n,5}^4$  with a unique neighbour  $g_{12}$ , by [Proposition 2.4,](#page-3-1) we have  $\text{Ind}(C_{n,5}^4) \simeq$  $\Sigma Ind(C_{n,5}^4 \setminus N[g_{12}])$ . Let  $C_{n,5}^5 \coloneqq C_{n,5}^4 \setminus N[g_{12}]$  (see [Figure 14\(d\)\)](#page-12-0). Now, for  $n=1$ , we have  $C_{1,5}^5 \simeq K_3$ . Therefore, from [Equation \(3.4\)](#page-12-1) and [Equation \(3.5\),](#page-12-2) we get that

$$
Ind(C_{1,5}) \simeq \Sigma^2 Ind(E_{0,5}) \vee \Sigma^2 Ind(K_3).
$$

Since Ind( $E_{0,5}$ )  $\simeq \mathbb{S}^0$  (using [Claim 3.8\)](#page-8-2) and Ind( $K_3$ )  $\simeq \mathbb{S}^0 \vee \mathbb{S}^0$ , we have Ind( $C_{1,5}$ )  $\simeq \vee_3 \mathbb{S}^2$ .

Let  $n \geq 2$ . Since  $g_{42}$  is a simplicial vertex and  $N(g_{42}) = \{g_{33}, g_{43}\}\$ in  $C_{n,5}^5$ , [Proposition 2.4](#page-3-1) provides us

Ind( $C_{n,5}^5$ ) ≃ ΣInd( $C_{n,5}^5 \setminus N[g_{33}]$ ) ∨ ΣInd( $C_{n,5}^5 \setminus N[g_{43}]$ ).

However, the graph  $C_{n,5}^5 \setminus N[g_{33}]$  is isomorphic to the graph  $A_{n-2,5}$  and the graph  $C_{n,5}^5 \setminus N[g_{43}]$  is isomorphic to  $F_{n-2,5}$  (refer to [Figure 5](#page-6-1) and [Figure 10\)](#page-8-3). Therefore, we have

$$
\text{Ind}(C_{n,5}^4) \simeq \Sigma \text{Ind}(C_{n,5}^5) \simeq \Sigma^2 \text{Ind}(A_{n-2,5}) \vee \Sigma^2 \text{Ind}(F_{n-2,5}),\tag{3.6}
$$

<span id="page-12-5"></span>which, along with Equation  $(3.4)$  and Equation  $(3.5)$  gives the required homotopy equivalence.  $\Box$ 

#### Claim 3.14. For  $n > 1$ ,

$$
\operatorname{Ind}(D_{n,5}) \simeq \begin{cases} \mathbb{S}^2 \vee \mathbb{S}^2 \vee \mathbb{S}^2 & \text{for } n = 1, \\ \Sigma^3 \operatorname{Ind}(\Lambda_{n-2,5}) \vee \Sigma^2 \operatorname{Ind}(E_{n-1,5}) \vee \Sigma^2 \operatorname{Ind}(E_{n-1,5}) & \text{for } n \ge 2. \end{cases}
$$

*Proof.* Observe that  $[g_{31}, g_{12}; d_1]$  and  $[g_{21}, g_{42}; d_2]$  are edge-invariant triplets in  $D_{n,5}$  (see [Figure 8\)](#page-8-0) and  $D_{n,5}+\{g_{31}g_{12}\}\,$  respectively. Hence by using [Proposition 2.5,](#page-3-0) we have  $\text{Ind}(D_{n,5}) \simeq \text{Ind}(D_{n,5}+\{g_{31}g_{12},g_{21}g_{42}\})$ . Furthermore,  $[d_1,g_{21};g_{41}]$  and  $[d_2,g_{31};g_{11}]$  are edge-invariant triplets in  $D_{n,5}+\{g_{31}g_{12},g_{21}g_{42}\}\text{ and } (D_{n,5}+\{g_{31}g_{12},g_{21}g_{42}\})-\{d_1g_{21}\}\text{, re-}$ spectively. Let  $D_{n,5}^1$  be the graph that we obtain after removing the edges  $d_1g_{21}$  and  $d_2g_{31}$ from  $D_{n,5}+\{g_{31}g_{12},g_{21}g_{42}\}\$  (see [Figure 15\(a\)\)](#page-13-0). Then, it follows from [Proposition 2.5](#page-3-0) that  $\text{Ind}(D_{n,5}) \simeq \text{Ind}(D_{n,5}^1).$ 

Now, we proceed with  $D_{n,5}^1$ . Observe that  $[g_{21}, g_{41}; d_1]$ ,  $[g_{12}, g_{41}; d_1]$ , and  $[d_2, g_{41}; g_{11}]$ are edge-invariant triplets in the graphs  $D_{n,5}^1$ ,  $D_{n,5}^1$  + {g<sub>21</sub>g<sub>41</sub>}, and  $D_{n,5}^1$  + {g<sub>21</sub>g<sub>41</sub>, g<sub>12</sub>g<sub>41</sub>}, respectively. Let  $D_{n,5}^2 = (D_{n,5}^1 + \{g_{21}g_{41}, g_{41}g_{12}\}) - \{d_2g_{41}\}\$  (see [Figure 15\(b\)\)](#page-13-0). Then [Proposition 2.5](#page-3-0) implies that  $\text{Ind}(D^1_{n,5}) \simeq \text{Ind}(D^2_{n,5})$ . Note that  $N(d_2) \subseteq N(g_{11})$  in the resultant graph  $D_{n,5}^2$ . Therefore, from [Proposition 2.3,](#page-3-2) we have  $\text{Ind}(D_{n,5}) \simeq \text{Ind}(D_{n,5}^2 \setminus$  $g_{11}$ ). Since  $[g_{12}, g_{33}; g_{21}]$ , and  $[g_{12}, g_{43}; g_{21}]$  are edge-invariant triplets in the graphs  $D_{n,5}^2 \setminus$  $g_{11}$  and  $(D_{n,5}^2 \setminus g_{11}) + \{g_{12}g_{33}\}\text{, respectively, we get }\text{Ind}(D_{n,5}^2 \setminus g_{11}) \simeq \text{Ind}((D_{n,5}^2 \setminus g_{11}) +$  ${g_{12}g_{33}, g_{12}g_{43}}$ . Let us take  $D_{n,5}^3 = (D_{n,5}^2 \setminus g_{11}) + {g_{12}g_{33}, g_{12}g_{43}}$  (see [Figure 15\(c\)\)](#page-13-0). Then,  $\text{Ind}(D_{n,5}^2) \simeq \text{Ind}(D_{n,5}^3)$ . Furthermore,  $[g_{31}, g_{12}; g_{42}]$ , and  $[g_{12}, g_{41}; g_{32}]$  are edgeinvariant triplets in the graphs  $D_{n,5}^3$ , and  $D_{n,5}^3 - g_{31}g_{12}$ , respectively. Hence  $\text{Ind}(D_{n,5}^3) \simeq$  $\text{Ind}(D_{n,5}^3 - \{g_{31}g_{12}, g_{12}g_{41}\})$ . Let us denote the graph  $D_{n,5}^3 - \{g_{31}g_{12}, g_{12}g_{41}\}$  by  $D_{n,5}^4$  (see [Figure 15\(d\)\)](#page-13-0). Then,  $\text{Ind}(D_{n,5}) \simeq \text{Ind}(D_{n,5}^4)$ .

Observe that  $(\text{Ind}(D_{n,5}^4 \setminus N[g_{21}]) * \{g_{41}\} \subseteq \text{Ind}(D_{n,5}^4 \setminus g_{21}), \text{ i.e., } \text{Ind}(D_{n,5}^4 \setminus N[g_{21}])$  is contractible in  $\text{Ind}(D_{n,5}^4 \setminus g_{21})$ . Therefore, [Proposition 2.2](#page-3-4) implies that

$$
\operatorname{Ind}(D_{n,5}^4) \simeq \operatorname{Ind}(D_{n,5}^4 \setminus g_{21}) \vee \operatorname{LInd}(D_{n,5}^4 \setminus N[g_{21}])
$$
  
\n
$$
\simeq \operatorname{Ind}(D_{n,5}^4 \setminus g_{21}) \vee \Sigma^2 \operatorname{Ind}(E_{n-1,5}),
$$
\n(3.7)

<span id="page-13-1"></span>where the second homotopy type is coming from the fact that the graph  $D_{n,5}^4 \setminus N[g_{21}]$  has two connected components, one component is an edge  $d_1d_2$ , and the other component is isomorphic to the graph  $E_{n-1,5}$  (see [Figure 9\)](#page-8-1).

Now, consider the graph  $D_{n,5}^4 \setminus g_{21}$ . Since  $N(g_{41}) \subseteq N(g_{32})$  in  $D_{n,5}^4 \setminus g_{21}$ , we have  $\text{Ind}(D_{n,5}^4 \setminus g_{21}) \simeq \text{Ind}(D_{n,5}^4 \setminus \{g_{21}, g_{32}\})$ . Furthermore,  $[g_{22}, g_{33}; g_{41}]$ , and  $[g_{22}, g_{43}; g_{41}]$  are edge-invariant triplets in the graphs  $D_{n,5}^4 \setminus \{g_{21}, g_{32}\}$  and  $(D_{n,5}^4 \setminus \{g_{21}, g_{32}\}) + \{g_{22}g_{33}\}\$ , respectively. Therefore, we have  $\text{Ind}(D_{n,5}^4 \setminus g_{21}) \simeq \text{Ind}((D_{n,5}^4 \setminus \{g_{21}, g_{32}\}) + \{g_{22}g_{33}, g_{22}g_{43}\}).$ Let  $D_{n,5}^5$  (see [Figure 15\(e\)\)](#page-13-0) denote the graph  $(D_{n,5}^4 \setminus {g_{21}, g_{32}}) + {g_{22}g_{33}, g_{22}g_{43}}$ . Then,  $\text{Ind}(D_{n,5}^4 \setminus g_{21}) \simeq \text{Ind}(D_{n,5}^5).$ 

Since  $[g_{22}, g_{31}; g_{42}]$  is an edge-invariant triplet in the graph  $D_{n,5}^5$ , we obtain that  $\text{Ind}(D_{n,5}^5) \simeq \text{Ind}(D_{n,5}^5 - \{g_{22}g_{31}\}).$  Moreover,  $N(g_{31}) \subseteq N(g_{42})$  in the graph  $D_{n,5}^5$  - ${g_{22}g_{31}}$  and therefore  $\text{Ind}(D_{n,5}^5 - {g_{22}g_{31}}) \simeq \text{Ind}(D_{n,5}^5 - {g_{22}g_{31}}) \setminus g_{42}$ . Let  $D_{n,5}^6$ denote the graph  $(D_{n,5}^5 - \{g_{22}g_{31}\}) \setminus g_{42}$ . Then,  $\text{Ind}(D_{n,5}^4 \setminus g_{21}) \simeq \text{Ind}(D_{n,5}^5) \simeq \text{Ind}(D_{n,5}^6)$ .

Suppose  $n = 1$ . Since  $N(g_{13}) \subseteq N(g_{33})$  in the graph  $D_{1,5}^6$ , we get  $\text{Ind}(D_{1,5}^6) \simeq$ Ind( $D_{1,5}^6$  \ {g<sub>33</sub>}</sub>). Furthermore,  $N(g_{43})$  ⊆  $N(g_{13})$  ∩  $N(g_{23})$  in the graph  $D_{1,5}^6$  \ {g<sub>33</sub>}. Therefore, a repeated application of [Proposition 2.3](#page-3-2) provides us with  $\text{Ind}(D_{1,5}^6) \simeq \text{Ind}(D_{1,5}^6)$  ${g_{33}, g_{13}, g_{23}}$ . Since the graph  $D_{1,5}^6 \setminus {g_{33}, g_{13}, g_{23}}$  is isomorphic to the disjoint union of  $K_3$  and two edges, we have,  $\text{Ind}(D_{1,5}^6) \simeq \mathbb{S}^2 \vee \mathbb{S}^2$ . Hence  $\text{Ind}(D_{1,5}^4 \setminus g_{21}) \simeq \text{Ind}(D_{1,5}^6) \simeq$  $\mathbb{S}^2 \vee \mathbb{S}^2$ . Moreover, from [Claim 3.8,](#page-8-2) it follows that  $\Sigma^2$ Ind( $E_{0,5}$ )  $\simeq$   $\mathbb{S}^2$ . Hence, Ind( $D_{1,5}$ )  $\simeq$  $\mathbb{S}^2 \vee \mathbb{S}^2 \vee \mathbb{S}^2$ .

Now, consider  $n \geq 2$ . Since  $\text{Ind}(D_{n,5}^6 \setminus N[g_{12}]) * \{g_{22}\} \subseteq \text{Ind}(D_{n,5}^6 \setminus g_{12})$ , from [Proposition 2.2,](#page-3-4) we have

$$
\text{Ind}(D_{n,5}^{6}) \simeq \text{Ind}(D_{n,5}^{6} \setminus g_{12}) \vee \Sigma \text{Ind}(D_{n,5}^{6} \setminus N[g_{12}]).
$$
\n(3.8)

<span id="page-14-0"></span>However, the graph  $D_{n,5}^6 \setminus g_{12}$  consists of three connected components, two of the components consist of a single edge, and the third component is isomorphic to  $E_{n-1,5}$ . Similarly, the graph  $D_{n,5}^6 \setminus N[g_{12}]$  has three connected components, two are distinct edges, and the third component is isomorphic to  $\Lambda_{n-2,5}$ . Therefore, from [Equation \(3.8\),](#page-14-0) we get  $\text{Ind}(D_{n,5}^6) \simeq \Sigma^2 \text{Ind}(E_{n-1,5}) \vee \Sigma^3 \text{Ind}(\Lambda_{n-2,5})$ . Hence, from [Equation \(3.7\),](#page-13-1) we get that  $\text{Ind}(D_{n,5}) \simeq \Sigma^2 \text{Ind}(E_{n-1,5}) \vee \Sigma^3 \text{Ind}(\Lambda_{n-2,5}) \vee \Sigma^2 \text{Ind}(E_{n-1,5}).$ 

<span id="page-14-4"></span>Claim 3.15. For  $n \geq 1$ , we have

$$
\operatorname{Ind}(\Lambda_{n,5}) \simeq \left(\bigvee_2 \Sigma^2 \operatorname{Ind}(A_{n-1,5})\right) \vee \left(\bigvee_2 \Sigma^2 \operatorname{Ind}(C_{n-1,5})\right)
$$

$$
\vee \left(\bigvee_2 \Sigma^2 \operatorname{Ind}(F_{n-1,5})\right) \vee \Sigma^2 \operatorname{Ind}(D_{n-1,5}).
$$

*Proof.* The proof follows primarily from the application of [Proposition 2.4.](#page-3-1) Since  $l_1$  is a simplicial vertex and  $N(l_1) = \{g_{11}, g_{21}, l_2\}$  in  $\Lambda_{n,5}$ , we have

\operatorname{Ind}(\Lambda_{n,5}) \simeq \Sigma \operatorname{Ind}(\Lambda_{n,5} \setminus N[g_{11}]) \vee \Sigma \operatorname{Ind}(\Lambda_{n,5} \setminus N[g_{21}]) \vee \Sigma \operatorname{Ind}(\Lambda_{n,5} \setminus N[l_2]). \tag{3.9}
$$

Note that  $\Lambda_{n,5} \setminus N[l_2]$  is isomorphic to  $C_{n+1}^5$  (see [Figure 14\(d\)](#page-12-0) in [Claim 3.13\)](#page-12-3). Therefore, it follows from [Equation \(3.6\)](#page-12-4) that

\operatorname{Ind}(\Lambda_{n,5} \setminus N[l_2]) \simeq \Sigma \operatorname{Ind}(A_{n-1,5}) \vee \Sigma \operatorname{Ind}(F_{n-1,5}).\tag{3.10}
$$

Let  $\Lambda_{n,5}^1 := \Lambda_{n,5} \setminus N[g_{11}]$  (see [Figure 16\(b\)\)](#page-14-1) and  $\Lambda_{n,5}^2 := \Lambda_{n,5} \setminus N[g_{21}]$  (see [Figure 16\(c\)\)](#page-14-1). Since  $l_4$  is a simplicial vetyex in  $\Lambda_{n,5}^1$ , with  $N(l_4) = \{l_3, g_{31}, g_{41}\}$ , using [Proposition 2.4,](#page-3-1) we have,

$$
\operatorname{Ind}(\Lambda_{n,5}^1) \simeq \Sigma \operatorname{Ind}(\Lambda_{n,5}^1 \setminus N[l_3]) \vee \Sigma \operatorname{Ind}(\Lambda_{n,5}^1 \setminus N[g_{31}]) \vee \Sigma \operatorname{Ind}(\Lambda_{n,5}^1 \setminus N[g_{41}]).
$$

Observe that the graphs  $\Lambda_{n,5}^1 \setminus N[l_3], \Lambda_{n,5}^1 \setminus N[g_{31}],$  and  $\Lambda_{n,5}^1 \setminus N[g_{41}]$  are isomorpphic to the graphs  $F_{n-1,5}$ ,  $C_{n-1,5}$  and  $D_{n-1,5}$ , respectively (see [Figure 10,](#page-8-3) [7](#page-7-1) and [8](#page-8-0) respectively). Thus, we have

$$
\operatorname{Ind}(\Lambda_{n,5}^1) \simeq \Sigma \operatorname{Ind}(F_{n-1,5}) \vee \Sigma \operatorname{Ind}(C_{n-1,5}) \vee \Sigma \operatorname{Ind}(D_{n-1,5}).\tag{3.11}
$$

<span id="page-15-0"></span>Further, for the simplicial vertex  $l_3$  with  $N(l_3) = \{l_4, g_{41}\}\$ in  $\Lambda_{n,5}^2$ , we have

$$
\text{Ind}(\Lambda_{n,5}^2) \simeq \text{Lind}(\Lambda_{n,5}^2 \setminus N[l_4]) \vee \text{Lind}(\Lambda_{n,5}^2 \setminus N[g_{41}])
$$
  

$$
\simeq \text{Lind}(A_{n-1,5}) \vee \text{Lind}(C_{n-1,5}),
$$
 (3.12)

<span id="page-15-1"></span>wherein the graphs  $\Lambda_{n,5}^2 \setminus N[l_4]$  and  $\Lambda_{n,5}^2 \setminus N[q_{41}]$  are isomorphic to graphs  $A_{n-1,5}$  and  $C_{n-1,5}$ , respectively. Combining [\(3.9\)](#page-14-2), [\(3.10\)](#page-14-3), [\(3.11\)](#page-15-0), and [\(3.12\)](#page-15-1), we get the desired  $result.$

\mathrm{Ind}(E_{n,5})\simeq \begin{cases} \bigvee_{10}\mathbb{S}^2 & \text{for } n=1,\\ \Sigma^3\left((\vee_2\mathrm{Ind}(A_{n-2,5}))\bigvee(\vee_2\mathrm{Ind}(F_{n-2,5}))\right)\bigvee\Sigma\mathrm{Ind}(A_{n-1,5})\bigvee\mathrm{Ind}(\Gamma_{n,5}) & \text{for } n\geq 2.\end{cases}
$$

*Proof.* Observe that  $[g_{21}, g_{32}; g_{41}]$  and  $[g_{22}, g_{31}; g_{11}]$  are edge-invariant triplets in the graphs  $E_{n,5}$  and  $E_{n,5} - \{g_{21}g_{32}\}\)$ , respectively. Thus, we have  $\text{Ind}(E_{n,5}) \simeq \text{Ind}(E_{n,5} - \{g_{11}g_{32}\})$  ${g_{21}}g_{32}, g_{22}g_{31}$ . Let  $E^1_{n,5} = E_{n,5} - {g_{21}}g_{32}, g_{22}g_{31}$  (see [Figure 17\(a\)\)](#page-15-2). Since  $[g_{11}, g_{32}; g_{41}]$ and  $[g_{41}, g_{32}; g_{21}]$  are edge-invariant triplets in  $E^1_{n,5}$  and  $E^1_{n,5}+\{g_{11}g_{32}\}\,$  respectively, we have  $\text{Ind}(E_{n,5}^1) \simeq \text{Ind}(E_{n,5}^1 + \{g_{11}g_{32}, g_{41}g_{32}\})$ . Let  $E_{n,5}^2 = E_{n,5}^1 + \{g_{11}g_{32}, g_{41}g_{32}\}$ (see [Figure 17\(b\)\)](#page-15-2). Note that  $Ind(E_{n,5}^2 \setminus N[g_{32}]) * \{g_{42}\}\$ is a subcomplex of  $Ind(E_{n,5}^2 \setminus N[g_{32}])$  $g_{32}$ ). This implies that  $\text{Ind}(E_{n,5}^2 \setminus N[g_{32}]) \hookrightarrow \text{Ind}(E_{n,5}^2 \setminus g_{32})$  is null homotopic, and by [Proposition 2.2,](#page-3-4) we have

\text{Ind}(E_{n,5}) \simeq \text{Ind}(E_{n,5}^2) \simeq \text{Ind}(E_{n,5}^2 \setminus g_{32}) \vee \Sigma \text{Ind}(E_{n,5}^2 \setminus N[g_{32}]). \tag{3.13}
$$

The graph  $E_{n,5}^2 \setminus N[g_{32}]$  has two connected components; one component consists of the edge  $e_1g_{21}$ , and the other component is isomorphic to  $C_{n,5}^5$  (see [Figure 14\(d\)\)](#page-12-0). Therefore,

$$
\text{Ind}(E_{n,5}^2 \setminus N[g_{32}]) \simeq \Sigma \text{Ind}(C_{n,5}^5). \tag{3.14}
$$

Let  $E_{n,5}^3 \coloneqq E_{n,5}^2 \setminus g_{32}$  (see [Figure 17\(c\)\)](#page-15-2). Using [Proposition 2.5,](#page-3-0) for the edge-invariant triplets  $[g_{22}, g_{41}; g_{11}]$  and  $[g_{22}, g_{11}; g_{31}]$  in  $E_{n,5}^3$  and  $E_{n,5}^3 + \{g_{22}g_{41}\}$ , respectively, we get  $\text{Ind}(E_{n,5}^3) \simeq \text{Ind}(E_{n,5}^3 + \{g_{22}g_{11}, g_{22}g_{41}\}).$  Let  $E_{n,5}^4 := E_{n,5}^3 + \{g_{22}g_{11}, g_{22}g_{41}\}$  (see [Figure 17\(d\)\)](#page-15-2). Then  $\text{Ind}(E_{n,5}^3) \simeq \text{Ind}(E_{n,5}^4)$ . Furthermore,  $\text{Ind}(E_{n,5}^4 \setminus N[g_{22}]) * \{g_{12}\}\$ is a subcomplex of  $\text{Ind}(E_{n,5}^4 \setminus g_{22})$ . Therefore, using [Proposition 2.2,](#page-3-4) we have

$$
\operatorname{Ind}(E_{n,5}^3) \simeq \operatorname{Ind}(E_{n,5}^4) \simeq \operatorname{Ind}(E_{n,5}^4 \setminus g_{22}) \vee \Sigma \operatorname{Ind}(E_{n,5}^4 \setminus N[g_{22}]).
$$

The graph  $E_{n,5}^4 \setminus N[g_{22}]$  has two connected components; one component consists of the edge  $e_1g_{31}$ , and the other component is a graph isomorphic to  $C_{n,5}^5$  (see [Figure 14\(d\)\)](#page-12-0). Hence

$$
\operatorname{Ind}(E_{n,5}^3) \simeq \operatorname{Ind}(E_{n,5}^4 \setminus g_{22}) \vee \Sigma^2 \operatorname{Ind}(C_{n,5}^5). \tag{3.15}
$$

Finally, let  $E_{n,5}^5 = E_{n,5}^4 \setminus g_{22}$ . Since  $\text{Ind}(E_{n,5}^5 \setminus N[e_1]) * \{g_{21}\} \subseteq \text{Ind}(E_{n,5}^5 \setminus e_1)$ , the inclusion map  $\text{Ind}(E_{n,5}^5 \setminus N[e_1]) * \{g_{21}\} \hookrightarrow \text{Ind}(E_{n,5}^5 \setminus e_1)$  is null homotopic. Therefore, by [Proposition 2.2,](#page-3-4) we have

$$
\operatorname{Ind}(E_{n,5}^{5}) \simeq \operatorname{Ind}(E_{n,5}^{5} \setminus e_{1}) \vee \Sigma \operatorname{Ind}(E_{n,5}^{5} \setminus N[e_{1}]).
$$

Further, observe that the graph  $E_{n,5}^5 \setminus e_1$  is isomorphic to  $\Gamma_{n,5} \setminus \{g_{22}, g_{32}\}$  (see [Figure 2,](#page-5-0) and [Figure 17\(e\)\)](#page-15-2), and the graph  $E_{n,5}^5 \setminus N[e_1]$  is isomorphic to  $A_{n-1,5}$  (see [Figure 5,](#page-6-1) and [Figure 17\(e\)\)](#page-15-2). Therefore,  $\text{Ind}(E_{n,5}^5 \setminus e_1) \simeq \text{Ind}(\Gamma_{n,5} \setminus \{g_{22}, g_{32}\})$  and  $\text{Ind}(E_{n,5}^5 \setminus e_1)$  $N[e_1]$ )  $\simeq$  Ind( $A_{n-1,5}$ ). Since  $N(g_{11}) \subseteq N(g_{22})$  and  $N(g_{41}) \subseteq N(g_{32})$  in  $\Gamma_{n,5}$  and  $\Gamma_{n,5}\backslash g_{22}$ , respectively (see [Figure 2\)](#page-5-0), we follow that  $\text{Ind}(\Gamma_{n,5}) \simeq \text{Ind}(\Gamma_{n,5} \setminus \{g_{22}, g_{33}\})$ . Therefore,

\operatorname{Ind}(E_{n,5}^5) \simeq \operatorname{Ind}(\Gamma_{n,5}) \vee \Sigma \operatorname{Ind}(A_{n-1,5}).\tag{3.16}
$$

Combining Equations  $(3.15)$  and  $(3.16)$ , we get

$$
\text{Ind}(E_{n,5}^3) \simeq \text{Ind}(\Gamma_{n,5}) \vee \Sigma \text{Ind}(A_{n-1,5}) \vee \Sigma^2 \text{Ind}(C_{n,5}^5). \tag{3.17}
$$

Thus, combining the homotopy equivalences in [Equations \(3.13\),](#page-15-3) [\(3.14\)](#page-15-4) and [\(3.17\),](#page-16-2) we get

\operatorname{Ind}(E_{n,5}) \simeq \Sigma^2 \left(\vee_2 \operatorname{Ind}(C_{n,5}^5)\right) \vee \Sigma \operatorname{Ind}(A_{n-1,5}) \vee \operatorname{Ind}(\Gamma_{n,5}).\tag{3.18}
$$

It follows from [Claims 3.4,](#page-6-2) [3.10](#page-9-1) and [3.13](#page-12-3) that  $\text{Ind}(A_{0,5}) \simeq \mathbb{S}^1 \vee \mathbb{S}^1 \vee \mathbb{S}^1$ ,  $\text{Ind}(\Gamma_{1,5}) \simeq$  $\mathbb{S}^2 \vee \mathbb{S}^2 \vee \mathbb{S}^2$  and  $\text{Ind}(C_{1,5}^5) \simeq \mathbb{S}^0 \vee \mathbb{S}^0$  (because  $C_{1,5}^5 \cong K_3$ ). Therefore,  $\text{Ind}(E_{1,5}) \simeq \bigvee_{10}^{\infty} \mathbb{S}^2$ .

For  $n \geq 2$ , we have  $\text{Ind}(C_{n,5}^5) \simeq \Sigma(\text{Ind}(A_{n-2,5}) \vee \text{Ind}(F_{n-2,5}))$  from [Equation \(3.6\).](#page-12-4) Therefore, from the homotopy equivalence in [Equation \(3.18\),](#page-16-3) we have for  $n \geq 2$ ,

$$
\operatorname{Ind}(E_{n,5}) \simeq \Sigma^3 \left( (\vee_2 \operatorname{Ind}(A_{n-2,5})) \bigvee (\vee_2 \operatorname{Ind}(F_{n-2,5})) \right) \vee \Sigma \operatorname{Ind}(A_{n-1,5}) \vee \operatorname{Ind}(\Gamma_{n,5}).
$$

<span id="page-16-6"></span>Claim 3.17. For  $n \ge 1$ , Ind( $F_{n,5}$ ) ≃  $\Sigma Ind(B_{n-1,5}) \bigvee_2 \Sigma^2 Ind(C_{n-1,5}) \bigvee \Sigma^2 Ind(D_{n-1,5})$ .

*Proof.* Since  $f_3$  is a simplicial vertex and  $N(f_3) = \{f_2, g_{31}, g_{41}\}\$ in the graph  $F_{n,5}$  (see [Figure 10\)](#page-8-3), from [Proposition 2.4,](#page-3-1) we get

<span id="page-16-5"></span> $\text{Ind}(F_{n,5}) \simeq \Sigma \text{Ind}(F_{n,5} \setminus N[f_2]) \vee \Sigma \text{Ind}(F_{n,5} \setminus N[g_{31}]) \vee \Sigma \text{Ind}(F_{n,5} \setminus N[g_{41}]).$  (3.19) Observe that the graph  $F_{n,5}\backslash N[f_2]$  is isomorphic to  $B_{n-1,5}$  (see [Figure 6](#page-7-0) and [Figure 18\(a\)\)](#page-16-4). Hence,  $\text{Ind}(F_{n,5} \setminus N[f_2]) \simeq \text{Ind}(B_{n-1,5}).$ 

Since  $N(f_1) = \{g_{11}\}\$ in  $F_{n,5} \setminus N[g_{31}]$  (see [Figure 18\(b\)\)](#page-16-4), using [Proposition 2.4,](#page-3-1) we have Ind $(F_{n,5} \setminus N[g_{31}]) \simeq \Sigma \text{Ind}(F_{n,5} \setminus N[g_{31}, g_{11}])$ . However, the graph  $F_{n,5} \setminus N[g_{31}, g_{11}]$ is isomorphic to  $C_{n-1,5}$  and therefore, Ind( $F_{n,5} \setminus N[g_{31}]$ )  $\simeq \Sigma \text{Ind}(C_{n-1,5})$ .

Finally, consider the graph  $F_{n,5} \backslash N[g_{41}]$ . Since  $f_1$  is a simplicial vertex in  $F_{n,5} \backslash N[g_{41}]$ , with  $N(f_1) = \{g_{11}, g_{21}\}\text{, from Proposition 2.4, we have}$  $N(f_1) = \{g_{11}, g_{21}\}\text{, from Proposition 2.4, we have}$  $N(f_1) = \{g_{11}, g_{21}\}\text{, from Proposition 2.4, we have}$ 

$$
\operatorname{Ind}(F_{n,5} \setminus N[g_{41}]) \simeq \Sigma \operatorname{Ind}(F_{n,5} \setminus N[g_{41}, g_{11}]) \vee \Sigma \operatorname{Ind}(F_{n,5} \setminus N[g_{41}, g_{21}]). \tag{3.20}
$$

Note that, the graphs  $F_{n,5} \setminus N[g_{41}, g_{11}]$  and  $F_{n,5} \setminus N[g_{41}, g_{21}]$  are isomorphic to  $D_{n-1,5}$ and  $C_{n-1,5}$ , respectively (refer to [Figures 7](#page-7-1) and [8\)](#page-8-0). Therefore, Ind( $F_{n,5} \setminus N[g_{41}]$ ) ≃  $\Sigma Ind(D_{n-1,5}) \vee \Sigma Ind(C_{n-1,5})$ . Now, the result follows from [Equation \(3.19\)](#page-16-5) by replacing all the associated homotopy equivalences.

<span id="page-17-1"></span>**Theorem 3.18.** For any graph  $G_{n,5} \in {\{\Gamma_{n,5}, \Lambda_{n,5}, A_{n,5}, B_{n,5}, C_{n,5}, D_{n,5}, E_{n,5}, F_{n,5} : n \geq 1\}$  $0\}$ , Ind( $G_{n,5}$ ) is homotopy equivalent to a wedge of spheres.

*Proof.* Since the graph  $\Gamma_{0,5}$  is a path on four vertices,  $\text{Ind}(\Gamma_{0,5})$  is contractible.

We now compute Ind( $\Lambda$ <sub>0</sub>). Since  $g_{11}$  is a simplicial vertex in the graph  $\Lambda$ <sub>0.5</sub>, with  $N(q_{11}) = \{q_{21}, l_1, l_2\}$ , using [Proposition 2.4,](#page-3-1) we get

 $\text{Ind}(\Lambda_{0.5}) \simeq \Sigma(\text{Ind}(\Lambda_{0.5} \setminus N[q_{21}])) \vee \Sigma(\text{Ind}(\Lambda_{0.5} \setminus N[l_1])) \vee \Sigma(\text{Ind}(\Lambda_{0.5} \setminus N[l_2])).$ 

However, both the graphs  $\Lambda_{0.5} \setminus N[g_{21}]$  and  $\Lambda_{0.5} \setminus N[b_2]$  are isomorphic to the complete graph  $K_3$  and the graph  $\Lambda_{0,5} \setminus N[l_1]$  is isomorphic to the complete graph  $K_4$ . Therefore,  $\text{Ind}(\Lambda_{0,5}) \simeq \Sigma(\text{Ind}(K_3)) \vee \Sigma(\text{Ind}(K_3)) \vee \Sigma(\text{Ind}(K_4)) \simeq \vee_7 {\mathbb S}^1.$ 

For any graph  $G_{n,5} \in \{A_{n,5}, B_{n,5}, C_{n,5}, D_{n,5}, E_{n,5}, F_{n,5} : n \ge 0\}$ , Ind $(G_{0,5})$  is homotopy equivalent to a wedge of spheres from [Claims 3.4](#page-6-2) to [3.9.](#page-8-4) Result follows from induction on *n* and [Claims 3.10](#page-9-1) to [3.17.](#page-16-6)

# <span id="page-17-0"></span>3.2 Independence complex of  $\tilde{\Gamma}_{n,5}$

Recall that for  $n \geq 0$ , the line graph of  $P_{2n+3} \times P_5$  comprises of connected components  $\Lambda_{n,5}$  and  $\tilde{\Gamma}_{n,5}$  (see [Figures 3](#page-5-1) and [4\)](#page-5-2). The computation of Ind( $\tilde{\Gamma}_{n,5}$ ) follows a similar approach as that of  $Ind(\Gamma_{n,5})$ . The intermediary graphs occurring during the computation of Ind( $\tilde{\Gamma}_{n,5}$ ) resemble those defined in [Section 3.1.1,](#page-6-0) with the inclusion of certain additional vertices and edges. For each  $H_{n,5} \in {\{\Gamma_{n,5}, \Lambda_{n,5}, A_{n,5}, B_{n,5}, C_{n,5}, D_{n,5}, E_{n,5}, F_{n,5}\}}$ where  $n \in \mathbb{N} \cup \{0\}$ , we define

$$
V(\tilde{H}_{n,5}) = V(H_{n,5}) \cup \{g_{1\,2n+2}, g_{2\,2n+2}, g_{3\,2n+2}, g_{4\,2n+2}\},
$$
  
\n
$$

In this section, we compute the independence complexes of graphs  $\tilde{\Gamma}_{n,5}$ ,  $\tilde{\Lambda}_{n,5}$ ,  $\tilde{A}_{n,5}$ ,  $\tilde{B}_{n,5}$ ,  $\tilde{C}_{n,5}, \tilde{D}_{n,5}, \tilde{E}_{n,5}$  and  $\tilde{F}_{n,5}$ . In computing the independence complexes of these graphs, as discussed in [Section 3.1.2,](#page-9-2) our approach focuses on performing computations primarily on one end (the leftmost part) of the graph while holding the other end (the rightmost part) fixed. Notably, for  $n \geq 1$ , we observe that the left ends of the graphs  $H_{n,5}$  and  $\tilde{H}_{n,5}$  coincide, where  $H_{n,5} \in {\{\Gamma_{n,5}, \Lambda_{n,5}, A_{n,5}, B_{n,5}, C_{n,5}, D_{n,5}, E_{n,5}, F_{n,5}\}}$ . This observation suggests a method for computing the independence complexes of graphs  $\tilde{\Gamma}_{n,5}, \tilde{\Lambda}_{n,5}, \tilde{A}_{n,5}, \tilde{B}_{n,5}, \tilde{C}_{n,5}, \tilde{D}_{n,5}, \tilde{E}_{n,5},$  and  $\tilde{F}_{n,5}$  using a similar strategy to that outlined in [Section 3.1.2.](#page-9-2) Furthermore, it is notable that for  $n \geq 1$ , these intermediary graphs adhere to a similar recurrence relation as those described in the preceding section. Since the base graphs of these intermediary graphs are completely different from the graphs in [Section 3.1.1,](#page-6-0) we give the complete computations for base cases. Also, we give the explicit recurrence relation for each graph and higher values of n.

• Ind $(\tilde{A}_{n,5})$ :

Since  $N(g_{12}) \subseteq N(g_{21})$  and  $N(g_{42}) \subseteq N(g_{31})$  in the graphs  $\tilde{A}_{0,5}$  and  $\tilde{A}_{0,5} \setminus g_{21}$ , respectively, using [Proposition 2.3,](#page-3-2) we get  $\text{Ind}(\tilde{A}_{0,5}) \simeq \text{Ind}(\tilde{A}_{0,5} \setminus \{g_{21}, g_{31}\})$ . Furthermore, the graph  $\tilde{A}_{0,5} \setminus \{g_{21}, g_{31}\}\$ is a path with 8 vertices, and hence  $\text{Ind}(\tilde{A}_{0,5}) \simeq \mathbb{S}^2$ by [Proposition 2.8.](#page-4-1) For  $n \geq 1$ , one can use the same procedures as in [Claim 3.11](#page-10-3) to obtain the independence complex of  $\tilde{A}_{n,5}$ . Therefore, we have the following:

\operatorname{Ind}(\tilde{A}_{n,5}) \simeq \begin{cases} \mathbb{S}^2 & \text{for } n = 0, \\ \bigvee_2 \Sigma^2 \operatorname{Ind}(\tilde{C}_{n-1,5}) \bigvee \Sigma^2 \operatorname{Ind}(\tilde{D}_{n-1,5}) & \text{for } n \ge 1. \end{cases} \tag{3.21}
$$

• Ind $(\tilde{B}_{n,5})$ :

Since  $N(g_{12}) \subseteq N(g_{21}), N(g_{42}) \subseteq N(g_{31})$  and  $N(b_2) \subseteq N(b_5)$  in  $\tilde{B}_{0,5}, \tilde{B}_{0,5} \setminus g_{21}$  and  $\tilde{B}_{0,5} \setminus \{g_{21}, g_{31}\},$  respectively, we get that  $\text{Ind}(\tilde{B}_{0,5}) \simeq \text{Ind}(\tilde{B}_{0,5} \setminus \{g_{21}, g_{31}, b_5\}).$  Note that  $b_3$  is a simplicial vertex and  $N(b_3) = \{g_{11}, b_4\}$  in the graph  $\tilde{B}_{0,5} \setminus \{g_{21}, g_{31}, b_5\}$ . Therefore,  $\mathrm{Ind}(\tilde{B}_{0,5} \setminus \{g_{21}, g_{31}, b_5\}) \simeq \Sigma \mathrm{Ind}((\tilde{B}_{0,5} \setminus \{g_{21}, g_{31}, b_5\}) \setminus N[g_{11}]) \vee \Sigma \mathrm{Ind}((\tilde{B}_{0,5} \setminus \{g_{31}, b_5\}) \setminus N[g_{11}])$  ${g_{21}, g_{31}, b_5} \ \setminus N[b_4]$ . However, both the graphs  $(\tilde{B}_{0,5} \setminus {g_{21}, g_{31}, b_5}) \setminus N[g_{11}]$  and  $(\tilde{B}_{0,5} \setminus \{g_{21}, g_{31}, b_5\}) \setminus N[b_4]$  are isomorphic to  $P_7$ . Therefore, using [Proposition 2.8,](#page-4-1) we find that  $\text{Ind}(\tilde{B}_{0,5})$  is contractible. For  $n \geq 1$ ,  $\text{Ind}(\tilde{B}_{n,5})$ , as mentioned below, can be computed using the same argument as in [Claim 3.12.](#page-11-1)

\operatorname{Ind}(\tilde{B}_{n,5}) \simeq \begin{cases} * & \text{for } n = 0, \\ \Sigma \operatorname{Ind}(\tilde{C}_{n,5}) \bigvee \Sigma^2 \operatorname{Ind}(\tilde{\Lambda}_{n-1,5}) & \text{for } n \ge 1. \end{cases}
$$

• Ind $(\tilde{C}_{n,5})$ :

Using [Proposition 2.3,](#page-3-2) we get  $\text{Ind}(\tilde{C}_{0,5}) \simeq \text{Ind}(\tilde{C}_{0,5} \setminus \{g_{21}, g_{31}\})$ . The graph  $\tilde{C}_{0,5} \setminus$  ${g_{21}, g_{31}}$  is a path on 7 vertices and hence Ind $(\tilde{C}_{0,5})$  is contractible.

Since  $N(g_{11}) \subseteq N(g_{22}), N(g_{14}) \subseteq N(g_{23})$  and  $N(g_{44}) \subseteq N(g_{33})$  in the graphs  $\tilde{C}_{1,5}$ (see [Figure 19\(e\)\)](#page-18-0),  $\tilde{C}_{1,5} \setminus g_{22}$  and  $\tilde{C}_{1,5} \setminus \{g_{22}, g_{23}\}\$ , respectively, we get  $\text{Ind}(\tilde{C}_{1,5}) \simeq$  $\text{Ind}(\tilde{C}_{1,5} \setminus \{g_{22}, g_{23}, g_{33}\})$ . Let  $\tilde{C}_{1,5}^1 = \tilde{C}_{1,5} \setminus \{g_{22}, g_{23}, g_{33}\}$ . Observe that  $c_1$  is a simlicial vertex in  $\tilde{C}_{1,5}^1$  with  $N(c_1) = \{g_{31}, g_{41}\}\$ . Thus, using [Proposition 2.4,](#page-3-1) we get  $\text{Ind}(\tilde{C}_{1,5}) \simeq$  $\Sigma \text{Ind}(\tilde{C}_{1,5}^1 \setminus N[g_{31}]) \vee \Sigma \text{Ind}(\tilde{C}_{1,5}^1 \setminus N[g_{41}])$ . Since the graph  $\tilde{C}_{1,5}^1 \setminus N[g_{31}]$  is isomorphic to  $P_9$  and  $\tilde{C}_{1,5}^1 \setminus N[g_{41}]$  is isomorphic to cycle graph  $C_{10}$ , using [Proposition 2.7,](#page-4-2) we get Ind $(\tilde{C}_{1,5}) \simeq \mathbb{S}^3 \vee \mathbb{S}^3$ . For  $n \geq 2$ , we use the same argument as in [Claim 3.13](#page-12-3) to get recurrence relations for Ind $(\tilde{C}_{n,5})$ . The homotopy type of Ind $(\tilde{C}_{n,5})$  is given by the following:

\operatorname{Ind}(\tilde{C}_{n,5}) \simeq \begin{cases} * & \text{for } n = 0, \\ \mathbb{S}^3 \vee \mathbb{S}^3 & \text{for } n = 1, \\ \Sigma^3 \operatorname{Ind}(\tilde{A}_{n-2,5}) \bigvee \Sigma^2 \operatorname{Ind}(\tilde{E}_{n-1,5}) \bigvee \Sigma^3 \operatorname{Ind}(\tilde{F}_{n-2,5}) & \text{for } n \ge 2. \end{cases}
$$

• Ind $(\tilde{D}_{n,5})$ :

Consider the graph  $\tilde{D}_{0,5}$ . Using [Proposition 2.3,](#page-3-2) we obtain  $\text{Ind}(\tilde{D}_{0,5}) \simeq \text{Ind}(\tilde{D}_{0,5} \setminus$  ${g_{21}, g_{31}}$ ). The graph  $\tilde{D}_{0,5} \setminus {g_{21}, g_{31}}$  is a cycle with 8 vertices. Therefore, using [Proposition 2.7,](#page-4-2) we get that  $\text{Ind}(\tilde{D}_{0,5}) \simeq \mathbb{S}^2$ .

For  $n \geq 1$ , we proceed in the same way as in [Claim 3.14](#page-12-5). We obtain the following relations :

- $-\text{Ind}(\tilde{D}_{n,5}) \simeq \text{Ind}(\tilde{D}_{n,5}^4) \simeq \text{Ind}(\tilde{D}_{n,5}^4 \setminus g_{21}) \vee \Sigma^2 \text{Ind}(\tilde{E}_{n-1,5}),$
- $-\operatorname{Ind}(\tilde{D}^6_{n,5}) \simeq \operatorname{Ind}(\tilde{D}^6_{n,5} \setminus g_{12}) \vee \Sigma \operatorname{Ind}(\tilde{D}^6_{n,5} \setminus N[g_{12}]),$
- $-\operatorname{Ind}(\tilde{D}^4_{n,5} \setminus g_{21}) \simeq \operatorname{Ind}(\tilde{D}^6_{n,5}).$

By combining all the above relations, we get  $\text{Ind}(\tilde{D}_{n,5}) \simeq \text{Ind}(\tilde{D}_{n,5}^6 \setminus g_{12}) \vee \Sigma \text{Ind}(\tilde{D}_{n,5}^6 \setminus g_{13})$  $N[g_{12}] \vee \Sigma^2 \text{Ind}(\tilde{E}_{n-1,5})$ . The graph  $\tilde{D}_{n,5}^6$  (see [Figure 20\(b\)\)](#page-18-1) is obtained from the graph  $D_{n,5}^6$  (see [Figure 15\(f\)\)](#page-13-0). In the case of  $n=1$ , we find that the graph  $\tilde{D}_1^6 \setminus N[g_{12}]$ consists of three components: two edges and one with a path on 4 vertices. Thus, using [Proposition 2.8,](#page-4-1) we get  $\text{Ind}(\tilde{D}_1^6 \setminus N[g_{12}])$  is contractible. On the other hand, the graph  $\tilde{D}_1^6 \setminus g_{12}$  is isomorphic to a three-component graph, where two are edges and the remaining one is a graph isomorphic to  $\tilde{E}_{0,5}$ . Therefore,  $\text{Ind}(\tilde{D}_{n,5}^6 \setminus g_{12}) \simeq \mathbb{S}^3$ . Hence, we get  $\text{Ind}(\tilde{D}_1) \simeq \mathbb{S}^3 \vee \mathbb{S}^3$ . For  $n \ge 2$ , the independence complexes of  $\tilde{D}_{n,5}$  follow the same pattern as those in [Claim 3.14.](#page-12-5) Thus, we have the following:

$$
\operatorname{Ind}(\tilde{D}_{n,5}) \simeq \begin{cases} \mathbb{S}^2 & \text{for } n = 0, \\ \mathbb{S}^3 \vee \mathbb{S}^3 & \text{for } n = 1, \\ \Sigma^3 \operatorname{Ind}(\tilde{\Lambda}_{n-2,5}) \vee \Sigma^2 \operatorname{Ind}(\tilde{E}_{n-1,5}) \vee \Sigma^2 \operatorname{Ind}(\tilde{E}_{n-1,5}) & \text{for } n \ge 2. \end{cases}
$$
(3.24)

• Ind $(\tilde{\Gamma}_{n,5})$ :

Since  $N(g_{11}) \subseteq N(g_{22})$  and  $N(g_{41}) \subseteq N(g_{32})$  in the graphs  $\tilde{\Gamma}_{0,5}$ , and  $\tilde{\Gamma}_{0,5} \setminus g_{22}$  using [Proposition 2.3,](#page-3-2) we get  $\text{Ind}(\tilde{\Gamma}_{0,5}) \simeq \text{Ind}(\tilde{\Gamma}_{0,5} \setminus \{g_{22}, g_{32}\})$ . The graph  $\tilde{\Gamma}_{0,5} \setminus \{g_{22}, g_{32}\}$ is a path with 6 vertices, and hence, using [Proposition 2.8,](#page-4-1) we get  $\text{Ind}(\tilde{\Gamma}_{0,5}) \simeq \mathbb{S}^1$ .

Now, consider  $n \geq 1$ . Application of the same procedure as that used in [Claim 3.10](#page-9-1) provides us with a graph  $\tilde{\Gamma}_{n,5}^5$  such that  $\text{Ind}(\tilde{\Gamma}_{n,5}) \simeq \Sigma^2 \text{Ind}(\tilde{\Gamma}_{n,5}^5)$ , where the graph  $\tilde{\Gamma}_{n,5}^5$ (see [Figure 21\(a\)\)](#page-20-0) is obtained from  $\Gamma_{n,5}^5$  (see [Figure 11\(e\),](#page-9-0) in the proof of [Claim 3.10\)](#page-9-1). If  $n = 1$ , then  $N(g_{14}) \subseteq N(g_{23})$  and  $N(g_{44}) \subseteq N(g_{33})$  in the graphs  $\tilde{\Gamma}_{1,5}^5$  and  $\tilde{\Gamma}_{1,5}^5 \setminus g_{23}$ , respectively. Thus,  $\text{Ind}(\tilde{\Gamma}_{1,5}^5) \simeq \text{Ind}(\tilde{\Gamma}_{1,5}^5 \setminus \{g_{23}, g_{33}\})$ . We can observe that the resultant graph is isomorphic to a cycle on 6 vertices. Now [Proposition 2.7](#page-4-2) implies that  $\text{Ind}(\mathcal{C}_6) \simeq \mathbb{S}^1 \vee \mathbb{S}^1$  and therefore  $\text{Ind}(\tilde{\Gamma}_{1,5}) \simeq \mathbb{S}^3 \vee \mathbb{S}^3$ .

Now, let  $n \geq 2$  and proceed with the similar methods as in [Claim 3.10.](#page-9-1) We obtain the following relations:

- \operatorname{Ind}(\tilde{\Gamma}_{n,5}^6 \setminus g_{14}) \simeq \Sigma \operatorname{Ind}((\tilde{\Gamma}_{n,5}^6 \setminus g_{14}) \setminus N[g_{33}]) \vee \Sigma \operatorname{Ind}((\tilde{\Gamma}_{n,5}^6 \setminus g_{14}) \setminus N[g_{43}]),
$$

- \operatorname{Ind}(\tilde{\Gamma}_{n,5}^7) \simeq \operatorname{Ind}(\tilde{\Gamma}_{n,5}^8).
$$

By combining all these relations, we find that

$$
\operatorname{Ind}(\tilde{\Gamma}_{n,5}) \simeq \Sigma^3(\operatorname{Ind}(\tilde{A}_{n-2,5})) \bigvee \Sigma^3 \operatorname{Ind}(\tilde{\Gamma}_{n,5}^8)) \bigvee \Sigma^2(\operatorname{Ind}(\tilde{\Gamma}_{n,5}^6 \setminus g_{14})).
$$

For  $n=2$ , we can observe that the graph  $\tilde{\Gamma}^8_{2,5}$  consists of two connected components, one is a cycle on 4 vertices and the other one is  $B_{-1}$  (see [Figure 21\(d\).](#page-20-0) Since  $N(b_3) \subseteq$  $N(b_1) \cap N(b_5)$  in graph  $B_{-1}$ , using [Proposition 2.3,](#page-3-2) Ind( $B_{-1}$ )  $\simeq$  Ind( $B_{-1} \setminus \{b_1, b_5\}$ )  $\simeq$  $\mathbb{S}^1$ . This implies that  $\text{Ind}(\tilde{\Gamma}^8_{2,5}) \simeq \mathbb{S}^2$ . On the other hand the graphs  $(\tilde{\Gamma}^6_{2,5} \setminus g_{14})$  $N[g_{33}]$  and  $(\tilde{\Gamma}_{2,5}^6 \setminus g_{14}) \setminus N[g_{43}]$  are isomorphic to the graphs  $\tilde{C}_{0,5}$  and  $\tilde{D}_{0,5}$ . Thus, we have  $\text{Ind}(\tilde{\Gamma}_{2,5}) \simeq \Sigma^3(\text{Ind}(\tilde{A}_{0,5})) \bigvee \Sigma^3(\mathbb{S}^2) \bigvee \Sigma^3(\text{Ind}(\tilde{C}_{0,5}) \vee \text{Ind}(\tilde{D}_{0,5}))$ . Hence, using the above computations of  $\text{Ind}(\tilde{A}_{0,5})$ ,  $\text{Ind}(\tilde{C}_{0,5})$ , and  $\text{Ind}(\tilde{D}_{0,5})$ , we get that  $\text{Ind}(\tilde{\Gamma}_{2,5}) \simeq$  $\mathbb{S}^5 \vee \mathbb{S}^5 \vee \mathbb{S}^5$ . For  $n \geq 3$ , one can use the same procedures as in [Claim 3.10](#page-9-1) to obtain the independence complex of  $\tilde{\Gamma}_{n,5}$ . Therefore, we have the following:

$$
\operatorname{Ind}(\tilde{\Gamma}_{n,5}) \simeq \begin{cases} \mathbb{S}^1 & \text{for } n = 0, \\ \mathbb{S}^3 \vee \mathbb{S}^3 & \text{for } n = 1, \\ \mathbb{S}^5 \vee \mathbb{S}^5 \vee \mathbb{S}^5 \\ \Sigma^3 \operatorname{Ind}(\tilde{A}_{n-2,5}) \vee \Sigma^4 \operatorname{Ind}(\tilde{B}_{n-3,5}) \vee \Sigma^3 \operatorname{Ind}(\tilde{C}_{n-2,5}) \vee \Sigma^3 \operatorname{Ind}(\tilde{D}_{n-2,5}) & \text{for } n \ge 3. \\ \end{cases}
$$

• Ind $(\tilde{\Lambda}_{n,5})$ :

Using [Proposition 2.3,](#page-3-2) we get  $\text{Ind}(\tilde{\Lambda}_{0,5}) \simeq \text{Ind}(\tilde{\Lambda}_{0,5} \setminus \{g_{21}, g_{31}\})$ . Observe that  $l_1$ is a simplicial vertex, and  $N(l_1) = \{g_{11}, l_2\}$  in the graph  $\tilde{\Lambda}_{0,5} \setminus \{g_{21}, g_{31}\}.$  Therefore, [Proposition 2.4](#page-3-1) implies that  $\text{Ind}(\tilde{\Lambda}_{0,5}) \simeq \Sigma \text{Ind}((\tilde{\Lambda}_{0,5} \setminus \{g_{21}, g_{31}\}) \setminus N[g_{11}]) \vee \Sigma \text{Ind}((\tilde{\Lambda}_{0,5} \setminus \{g_{11}, g_{31}\}) \setminus N[g_{11}])$  ${g_{21}, g_{31}} \ \setminus N[l_2]$ . The graph  $(\tilde{\Lambda}_{0,5} \setminus {g_{21}, g_{31}}) \setminus N[g_{11}]$  consists of two connected components; one component is an edge, and the other component is isomorphic to  $K_3$ . On the other hand,  $(\tilde{\Lambda}_{0,5} \setminus \{g_{21}, g_{31}\}) \setminus N[l_2]$  is a path with 6 vertices. Therefore, by [Proposition 2.7](#page-4-2) and [Proposition 2.8,](#page-4-1)  $\text{Ind}(\tilde{\Lambda}_{0,5}) \simeq \mathbb{S}^2 \vee \mathbb{S}^2$ . For  $n \geq 1$ ,  $\text{Ind}(\tilde{\Lambda}_{n,5})$  follow the same pattern as those in [Claim 3.15.](#page-14-4) Thus, we have the following:

\operatorname{Ind}(\tilde{\Lambda}_{n,5}) \simeq \begin{cases} \mathbb{S}^2 \vee \mathbb{S}^2 & \text{for } n = 0, \\ \Sigma^2 \left( \bigvee_2 (\operatorname{Ind}(\tilde{A}_{n-1,5})) \bigvee_2 (\operatorname{Ind}(\tilde{C}_{n-1,5})) \bigvee \operatorname{Ind}(\tilde{D}_{n-1,5}) \bigvee \operatorname{Ind}(\tilde{F}_{n-1,5}) \right) & \text{for } n \ge 1. \end{cases}
$$

• Ind $(\tilde{E}_{n,5})$ :

Using [Proposition 2.3,](#page-3-2) we get  $\text{Ind}(\tilde{E}_{0,5}) \simeq \text{Ind}(\tilde{E}_{0,5} \setminus \{g_{21}, g_{31}\})$ . Observe that the graph  $\tilde{E}_{0,5} \setminus \{g_{21}, g_{31}\}\$ is a cycle on 7 vertices. Thus,  $\text{Ind}(\tilde{E}_{0,5}) \simeq \mathbb{S}^1$ .

For  $n \geq 1$ , we proceed in the same way as in [Claim 3.16.](#page-15-5) Using [Equation \(3.18\),](#page-16-3) we get  $\text{Ind}(\tilde{E}_{n,5}) \simeq \Sigma^2 \left(\vee_2 \text{Ind}(\tilde{C}_{n,5}^5)\right) \vee \Sigma \text{Ind}(\tilde{A}_{n-1,5}) \vee \text{Ind}(\tilde{\Gamma}_{n,5}),$  where the graph

 $\tilde{C}_{n,5}^5$  (see [Figure 20\(a\)\)](#page-18-1) is obtained from the graph  $C_{n,5}^5$  (see [Figure 14\(d\)\)](#page-12-0). In case of  $n = 1$ ,  $N(g_{44}) \subseteq N(g_{33})$  in  $\tilde{C}_1^5$  and therefore  $\text{Ind}(\tilde{C}_1^5) \simeq \text{Ind}(\tilde{C}_1^5 \setminus g_{33})$ . Since the graph  $\tilde{C}_{n,5}^5 \setminus g_{33}$  is a graph on 6 vertices,  $\text{Ind}(\tilde{C}_1^5) \simeq \mathbb{S}^1$ . Now  $\text{Ind}(\tilde{A}_0) \simeq \mathbb{S}^2$  and  $\text{Ind}(\tilde{\Gamma}_{1,5}) \simeq \mathbb{S}^3 \vee \mathbb{S}^3$  imply that  $\text{Ind}(\tilde{E}_1) \simeq \bigvee_5 \mathbb{S}^3$ . For  $n \geq 2$ , one can use the same arguments as those in [Claim 3.13](#page-12-3) to get  $\text{Ind}(\tilde{C}_{n,5}^5) \simeq \Sigma \text{Ind}(\tilde{A}_{n-2,5}) \vee \Sigma \text{Ind}(\tilde{F}_{n-2,5}).$ Thus, combining all of these, we have the following:

$$
\operatorname{Ind}(\tilde{E}_{n,5}) \simeq \begin{cases} \mathbb{S}^1 & \text{for } n = 0, \\ \bigvee_5 \mathbb{S}^3 & \text{for } n = 1, \\ \Sigma^3 \left( \bigvee_2 \operatorname{Ind}(\tilde{A}_{n-2,5}) \bigvee_2 \operatorname{Ind}(\tilde{F}_{n-2,5}) \right) \vee \Sigma \operatorname{Ind}(\tilde{A}_{n-1,5}) \vee \operatorname{Ind}(\Gamma'_{n,5}) & \text{for } n \ge 2. \end{cases}
$$
\n(3.27)

• Ind $(\tilde{F}_{n,5})$ :

From [Proposition 2.3,](#page-3-2)  $\text{Ind}(\tilde{F}_{0,5}) \simeq \text{Ind}(\tilde{F}_{0,5} \setminus \{g_{21}, g_{31}\})$ . Since  $f_3$  is a simplicial vertex in  $\tilde{F}_{0,5} \setminus \{g_{21}, g_{31}\}$  with  $N(f_3) = \{g_{41}, f_2\}$ ,  $\text{Ind}(\tilde{F}_{0,5}) \simeq \Sigma \text{Ind}((\tilde{F}_{0,5} \setminus \{g_{21}, g_{31}\}) \setminus$  $N[g_{41}])\vee \Sigma \text{Ind}((\tilde{F}_{0,5} \setminus {g_{21}, g_{31}})\setminus N[f_2])$ . Both the graphs  $(\tilde{F}_{0,5} \setminus {g_{21}, g_{31}})\setminus N[g_{41}]$  and  $(\tilde{F}_{0,5} \setminus \{g_{21}, g_{31}\}) \setminus N[f_2]$  are isomorphic to  $P_5$ . Hence,  $\text{Ind}(\tilde{F}_{0,5}) \simeq \mathbb{S}^2 \vee \mathbb{S}^2$ . For  $n \ge 1$ , the relations for Ind $(\tilde{F}_{n,5})$  follows from a similar argument as those in [Claim 3.17.](#page-16-6) Thus,

$$
\operatorname{Ind}(\tilde{F}_{n,5}) \simeq \begin{cases} \mathbb{S}^2 \vee \mathbb{S}^2 & \text{for } n = 0, \\ \Sigma \operatorname{Ind}(\tilde{B}_{n-1,5}) \vee \Sigma^2 \operatorname{Ind}(\tilde{C}_{n-1,5}) \vee \Sigma^2 \operatorname{Ind}(\tilde{C}_{n-1,5}) \vee \Sigma^2 \operatorname{Ind}(\tilde{D}_{n-1,5}) & \text{for } n \ge 1. \end{cases}
$$
\n(3.28)

<span id="page-21-2"></span>**Theorem 3.19.** For any graph  $\tilde{G}_{n,5} \in \{\tilde{\Gamma}_{n,5}, \tilde{\Lambda}_{n,5}, \tilde{A}_{n,5}, \tilde{B}_{n,5}, \tilde{C}_{n,5}, \tilde{D}_{n,5}, \tilde{E}_{n,5}, \tilde{F}_{n,5} : n \geq 0\}$  $[0], \, \text{Ind}(\tilde{G}_{n,5})$  is homotopy equivalent to a wedge of spheres.

<span id="page-21-0"></span>*Proof.* The result follows from [Equations \(3.21\)](#page-18-2) to [\(3.28\),](#page-21-1) and the induction on n.  $\square$ 

# **3.3** Homotopy type of  $M(P_n \times P_5)$

In this section, we conclude the homotopy type of  $M(P_n \times P_5)$ . We also determine the maximum and minimum dimensions of the spheres occurring in the homotopy type of the independence complexes of the graphs in  $\{\Gamma_{n,5}, \Lambda_{n,5}, A_{n,5}, B_{n,5}, C_{n,5}, D_{n,5}, E_{n,5}, F_{n,5}\}.$ 

**Theorem 3.20.** For  $n \geq 2$ ,  $M(P_n \times P_5)$  is homotopy equivalent to a wedge of spheres.

*Proof.* Case 1: If n is even, i.e.  $n = 2k$  for some positive integer k, then  $P_n \times P_5$ comprises of two isomorphic connected components, whose line graph is isomorphic to  $\Gamma_{k-1,5}$ . Thus,

$$
M(P_n \times P_5) \simeq \mathrm{Ind}(\Gamma_{k-1,5}) * \mathrm{Ind}(\Gamma_{k-1,5}).
$$

Now, the result follows from [Theorem 3.18.](#page-17-1)

**Case 2:** If *n* is odd, i.e.  $n = 2k+1$  for some positive integer k, then  $P_n \times P_5$  comprises of two non-isomorphic connected components with corresponding line graphs isomorphic to  $\Lambda_{k-1,5}$  and  $\tilde{\Gamma}_{k-1,5}$ . Thus,

$$
M(P_n \times P_5) \simeq \text{Ind}(\Lambda_{k-1,5}) * \text{Ind}(\tilde{\Gamma}_{k-1,5}).
$$

Result follows from [Theorem 3.18](#page-17-1) and [Theorem 3.19.](#page-21-2)

For a graph G whose independence complex is homotopy equivalent to a wedge of spheres, let  $d_{max}(\text{Ind}(G))$  and  $d_{min}(\text{Ind}(G))$  denote the maximum and minimum dimension of spheres appearing in the homotopy type of  $\mathrm{Ind}(G)$ .

<span id="page-21-3"></span>**Proposition 3.21.** For  $n \geq 0$ , the maximum and minimum dimension of the spheres in the homotopy type of the independence complexes of graphs in  $\{\Gamma_{n,5}, \Lambda_{n,5}, A_{n,5}, B_{n,5}, C_{n,5},\}$  $D_{n,5}, E_{n,5}, F_{n,5}$  are given in [Table 3](#page-22-0) and [Table 4](#page-22-1) respectively.

*Proof.* We prove the statement by using induction on the graphs in  $\{\Gamma_{n,5}, \Lambda_{n,5}, A_{n,5}, B_{n,5}, \Pi_{n,5}, \Pi_{n,5$  $C_{n,5}, D_{n,5}, E_{n,5}, F_{n,5}$  for  $n \geq 0$ . The statement holds for  $n = 0$  from [Claims 3.4](#page-6-2) to [3.9](#page-8-4) and Ind( $\Lambda_{0,5}$ ). Assume that the statement holds for all integers less than n. For  $\Gamma_{n,5}$ , [Claim 3.10](#page-9-1) implies that the statement holds for  $n = 1, 2$  as well. Further, for  $n \ge 3$ , we have

$$
\text{Ind}(\Gamma_{n,5}) \simeq \Sigma^3 \text{Ind}(A_{n-2,5}) \vee \Sigma^4 \text{Ind}(B_{n-3,5}) \vee \Sigma^3 \text{Ind}(C_{n-2,5}) \vee \Sigma^3 \text{Ind}(D_{n-2,5}). \tag{3.29}
$$

Therefore,  $d_{max}(\text{Ind}(\Gamma_{n,5}))$  is given by

$$
\max\{3 + d_{max}(\text{Ind}(A_{n-2,5})), 4 + d_{max}(\text{Ind}(B_{n-3,5})),
$$
  

$$
3 + d_{max}(\text{Ind}(C_{n-2,5})), 3 + d_{max}(\text{Ind}(D_{n-2,5}))\}.
$$

Let  $n \equiv 0 \pmod{4}$ . Then  $n-2$  and  $n-3$  are congruent to 2 and 1 modulo 4, respectively. By the induction hypothesis, we have

$$
d_{max}(\text{Ind}(\Gamma_{n,5})) = \max\{3 + (7(n-4)/4 + 4), 4 + (7(n-4)/4 + 3), 3 + (7(n-4)/4 + 4), 3 + (7(n-4)/4 + 4)\}
$$

$$
= 7\left(\frac{n}{4}\right).
$$

For  $n \equiv 1 \pmod{4}$ ,  $n-2$  and  $n-3$  are congruent to 3 and 2 modulo 4, respectively. Thus by induction hypothesis, we have

$$
d_{max}(\text{Ind}(\Gamma_{n,5})) = \max\{3 + (7(n-5)/4 + 6), 4 + (7(n-5)/4 + 5), 3 + (7(n-4)/4 + 6)\}
$$

$$
= 7\left(\frac{n-5}{4}\right) + 9 = 7\left(\frac{n-1}{4}\right) + 2.
$$

For  $n \equiv 2 \pmod{4}$ ,  $n-2$  and  $n-3$  are congruent to 0 and 3 modulo 4, respectively. By induction hypothesis, we have

$$
d_{max}(\text{Ind}(\Gamma_{n,5})) = \max\{3 + (7(n-2)/4 + 1), 4 + (7(n-2)/4), 3 + (7(n-2)/4 + 1), 3 + (7(n-2)/4 + 1)\}
$$

$$
= 7\left(\frac{n-2}{4}\right) + 4.
$$

For  $n \equiv 3 \pmod{4}$ ,  $n-2$  and  $n-3$  are congruent to 1 and 0 modulo 4, respectively. By induction hypothesis, we have

$$
d_{max}(\text{Ind}(\Gamma_{n,5})) = \max\{3 + (7(n-3)/4 + 3), 4 + (7(n-3)/4) + 2, 3 + (7(n-3)/4 + 2), 3 + (7(n-3)/4 + 2)\}
$$

$$
= 7\left(\frac{n-3}{4}\right) + 6.
$$

On the other hand,  $d_{min}(\text{Ind}(\Gamma_{n,5}))$  is given by

$$
\min\{3 + d_{min}(\text{Ind}(A_{n-2,5})), 4 + d_{min}(\text{Ind}(B_{n-3,5})),
$$
  

$$
3 + d_{min}(\text{Ind}(C_{n-2,5})), 3 + d_{min}(\text{Ind}(D_{n-2,5}))\}.
$$

For  $n \equiv 0 \pmod{5}$ ,  $n-2$  and  $n-3$  are congruent to 3 and 2 modulo 5, respectively. Therefore, using induction hypothesis, we have

$$
d_{min}(\text{Ind}(\Gamma_{n,5})) = \min\{3 + (8(n-5)/5 + 6), 4 + (8(n-5)/5 + 5), 3 + (8(n-5)/5 + 5), 3 + (8(n-5)/5 + 6)\}
$$

$$
= 8\left(\frac{n-5}{5}\right) + 8 = 8\left(\frac{n}{5}\right).
$$

For  $n \equiv 1 \pmod{5}$ ,  $n-2$  and  $n-3$  are congruent to 4 and 3 modulo 5, respectively. Therefore, we have

$$
d_{min}(\text{Ind}(\Gamma_{n,5})) = \min\{3 + (8(n-6)/5 + 7), 4 + (8(n-6)/5 + 6), 3 + (8(n-6)/5 + 7), 3 + (8(n-6)/5 + 7)\}
$$

$$
= 8\left(\frac{n-6}{5}\right) + 10 = 8\left(\frac{n-1}{5}\right) + 2.
$$

For  $n \equiv 2 \pmod{5}$ ,  $n-2$  and  $n-3$  are congruent to 0 and 4 modulo 5, respectively. Therefore, we have

$$
d_{min}(\text{Ind}(\Gamma_{n,5})) = \min\{3 + (8(n-2)/5 + 1), 4 + (8(n-7)/5 + 8), 3 + (8(n-2)/5 + 1), 3 + (8(n-2)/5 + 1)\}
$$

$$
= 8\left(\frac{n-2}{5}\right) + 4.
$$

For  $n \equiv 3 \pmod{5}$ ,  $n-2$  and  $n-3$  are congruent to 1 and 0 modulo 5, respectively. Therefore, we have

$$
d_{min}(\text{Ind}(\Gamma_{n,5})) = \min\{3 + (8(n-3)/5 + 3), 4 + (8(n-3)/5 + 1), 3 + (8(n-3)/5 + 2), 3 + (8(n-3)/5 + 2)\}
$$

$$
= 8\left(\frac{n-3}{5}\right) + 5.
$$

For  $n \equiv 4 \pmod{5}$ ,  $n-2$  and  $n-3$  are congruent to 2 and 1 modulo 5, respectively. Therefore, we have

$$
d_{min}(\text{Ind}(\Gamma_{n,5})) = \min\{3 + (8(n-4)/5 + 4), 4 + (8(n-4)/5 + 3), 3 + (8(n-4)/5 + 4), 3 + (8(n-4)/5 + 4)\}
$$

$$
= 8\left(\frac{n-4}{5}\right) + 7.
$$

The proof follows similarly for the maximum and minimum dimension of the wedge in independence complexes of  $\Lambda_{n,5}$ ,  $A_{n,5}$ ,  $B_{n,5}$ ,  $C_{n,5}$ ,  $D_{n,5}$ ,  $E_{n,5}$  and  $F_{n,5}$ .

**Proposition 3.22.** For  $n \geq 0$ , the maximum and minimum dimension of the spheres in the homotopy type of the independence complexes of graphs in  $\{\tilde{\Gamma}_{n,5}, \tilde{\Lambda}_{n,5}, \tilde{A}_{n,5}, \tilde{B}_{n,5}, \tilde{C}_{n,5},\}$  $\tilde{D}_{n,5}, \tilde{E}_{n,5}, \tilde{F}_{n,5}$  are given in [Table 5](#page-24-1) and [Table 6](#page-24-2) respectively.

<span id="page-24-0"></span>Remark 3.23. The maximum and minimum dimension of spheres in the homotopy type of  $M(P_n \times P_5)$  as given in [Proposition 1.4](#page-1-3) can be concluded from [Tables 3](#page-22-0) to [6.](#page-24-2)

# 4 MATCHING COMPLEXES OF  $P_n \times P_4$

In this section, we aim to determine the homotopy type of the matching complex of the categorical product  $P_n \times P_4$ . The categorical product  $P_n \times P_4$  is characterized by being disconnected, comprising precisely two connected components. Notably, regardless of whether n is odd or even, these components are isomorphic. For  $n \geq 0$ , we denote the connected components of the line graphs of  $P_{2n+2} \times P_4$  and  $P_{2n+3} \times P_4$  by  $\Gamma_{n,4}$  (see [Figure 22\)](#page-25-0) and  $\Lambda_{n,4}$  (see [Figure 23\)](#page-25-1), respectively. Therefore, we have the following:

$$
M(P_{2n+2} \times P_4) \simeq \operatorname{Ind}(\Gamma_{n,4}) * \operatorname{Ind}(\Gamma_{n,5}),
$$

 $M(P_{2n+3} \times P_4) \simeq \text{Ind}(\Lambda_{n,5}) * \text{Ind}(\Lambda_{n,5}).$ 

During the computation of the homotopy type of the independence complexes of graphs  $\Gamma_{n,4}$  and  $\Lambda_{n,4}$  for  $n \geq 0$ , we encounter several intermediary graphs denoted as  $A_{n,4}, B_{n,4}, C_{n,4}$ , and  $D_{n,4}$ . We illustrate that the independence complexes of  $\Gamma_{n,4}$  and  $\Lambda_{n,4}$  can be represented as the wedge of suspensions of these intermediary graphs. By employing induction on n, we establish that the independence complexes of  $\Gamma_{n,4}$ ,  $\Lambda_{n,4}$ , and the intermediary graphs are homotopy equivalent to a wedge of spheres. The graphs  $A_{n,4}, B_{n,4}, C_{n,4}$ , and  $D_{n,4}$  are shown in [Figures 24,](#page-26-0) [26,](#page-27-0) [27](#page-28-0) and [29,](#page-29-0) respectively. In the subsequent subsections, we proceed to determine the homotopy type of the independence complexes of  $\Gamma_{n,4}$ ,  $\Lambda_{n,4}$  and the aforementioned intermediary graphs.

#### 4.1 Graph  $\Gamma_{n,4}$

<span id="page-25-0"></span>For  $n \geq 0$ , we define the graph  $\Gamma_{n,4}$  as follows:  $V(\Gamma_{n,4}) = \{g_{ij} : i = 1, 2, 3 \text{ and } j = 1, 2, \ldots, 2n+1\},\$  $E(\Gamma_{n,4}) = \{g_{ij}g_{i+1,j} : i = 1, 2 \text{ and } j = 1, 2, \ldots, 2n+1\}$  $\bigcup \{q_{ij}q_{i,j+1} : i = 1, 2, 3 \text{ and } j = 1, 2, \ldots, 2n\}$  $\cup \{g_{ij}g_{i+1,j+1}, g_{ij+1}g_{i+1,j} : i = 1, 2, j = 1, 2, \ldots, 2n \text{ and } i + j \equiv 1 \pmod{2}\}.$

<span id="page-25-2"></span>Claim 4.1. For  $n \geq 0$ ,

$$
\operatorname{Ind}(\Gamma_{n,4}) \simeq \begin{cases} \mathbb{S}^0 & \text{if } n = 0, \\ \mathbb{S}^1 \vee \mathbb{S}^1 & \text{if } n = 1, \\ \Sigma \operatorname{Ind}(A_{n-1,4}) \vee \Sigma^2 \operatorname{Ind}(\Lambda_{n-2,4}) & \text{if } n \ge 2. \end{cases}
$$

*Proof.* Since  $\Gamma_{0,4}$  is a path with three vertices (see [Figure 22\)](#page-25-0),  $\text{Ind}(\Gamma_{0,4}) \simeq \mathbb{S}^0$ . Now, consider  $n \geq 1$ . Since  $N(g_{11}) \subseteq N(g_{22})$  in the graph  $\Gamma_{n,4}$ , we have  $\text{Ind}(\Gamma_{n,4}) \simeq \text{Ind}(\Gamma_{n,4})$  $(g_{22})$ . Let  $\Gamma^1_{n,4} = \Gamma_{n,4} \setminus g_{22}$ . Since  $g_{31}$  is a simplicial vertex in  $\Gamma^1_{n,4}$  with  $N(g_{31}) =$  ${g_{21}, g_{32}}$ , [Proposition 2.4](#page-3-1) implies that  $Ind(\Gamma^1_{n,4}) \simeq \Sigma Ind(\Gamma^1_{n,4} \setminus N[g_{21}]) \vee \Sigma Ind(\Gamma^1_{n,4} \setminus N[g_{32}])$  $N[g_{32}]$ ). Observe that the graph  $\Gamma^1_{n,4} \setminus N[g_{21}]$  is isomorphic to  $A_{n-1,4}$  (see [Figure 24\)](#page-26-0). Therefore,  $\text{Ind}(\Gamma^1_{n,4}) \simeq \text{LInd}(A_{n-1,4}) \vee \text{LInd}(\Gamma^1_{n,4} \setminus N[g_{32}])$ . In case of  $n=1$ , the graph  $\Gamma^1_{1,4} \setminus N[g_{32}]$  is isomorphic to the graph  $A_{0,4}$  (see [Figure 24\)](#page-26-0). Therefore,  $\text{Ind}(\Gamma^1_{1,4}) \simeq$  $\Sigma \text{Ind}(A_{0,4}) \vee \Sigma \text{Ind}(A_{0,4})$ . This implies that  $\text{Ind}(\Gamma_{1,4}) \simeq \mathbb{S}^1 \vee \mathbb{S}^1$ .

Now, consider  $n \geq 2$ . Since  $g_{11}$  is a simplicial vertex and  $g_{12}$  is the only neighbor of  $g_{11}$  in the graph  $\Gamma^1_{n,4} \setminus N[g_{32}]$ , we get  $\text{Ind}(\Gamma^1_{n,4} \setminus N[g_{32}]) \simeq \Sigma \text{Ind}(\Gamma^1_{n,4} \setminus N[g_{32}, g_{12}])$ . Observe that the graph  $\Gamma_{n,4}^1 \setminus N[g_{32}, g_{12}]$  is isomorphic to  $\Lambda_{n-2,4}$  [\(Figure 23\)](#page-25-1) and therefore  $\text{Ind}(\Gamma^1_{n,4}\setminus N[g_{32}])\simeq \Sigma \text{Ind}(\Lambda_{n-2,4}).$  Thus,  $\text{Ind}(\Gamma_{n,4})\simeq \Sigma \text{Ind}(A_{n-1,4})\vee \Sigma^2 \text{Ind}(\Lambda_{n-2,4}).$   $\Box$ 

# 4.2 Graph  $\Lambda_{n,4}$

For  $n \geq 0$ , we define the graph  $\Lambda_{n,4}$  as follows:

$$
V(\Lambda_{n,4}) = V(\Gamma_{n,4}) \cup \{g'_1, g'_2, g'_3\},
$$
  
\n
$$
E(\Lambda_{n,4}) = E(\Gamma_{n,4}) \cup \{g'_1g'_2, g'_1g_{11}, g'_1g_{21}, g'_2g'_3, g'_2g_{21}, g'_2g_{11}, g'_3g_{31}\}.
$$

Claim 4.2. For  $n > 0$ ,

$$
\operatorname{Ind}(\Lambda_{n,4}) \simeq \begin{cases} \mathbb{S}^1 & \text{if } n = 0, \\ \sum \operatorname{Ind}(B_{n-1,4}) \vee \Sigma^2 \operatorname{Ind}(\Gamma_{n-1,4}) & \text{if } n \ge 1. \end{cases}
$$

*Proof.* Since  $N(g)$  $\Lambda_3'$ )  $\subseteq N(g_{21})$  in the graph  $\Lambda_{n,4}$  (see [Figure 23\)](#page-25-1),  $\text{Ind}(\Lambda_{n,4}) \simeq \text{Ind}(\Lambda_{n,4})$  $g_{21}$ ). If  $n = 0$ , then  $N(g_{31}) \subseteq N(g_2)$  $\mathcal{L}_2$ ) in  $\Lambda_{0,4} \setminus g_{21}$ . Hence  $\text{Ind}(\Lambda_{0,4}) \simeq \text{Ind}(\Lambda_{0,4})$  ${g_{21}, g'_2}$ ). Now, the graph  $\Lambda_{0,4} \setminus {g_{21}, g'_2}$  is the disjoint union of two edges  $g'_1$  $'_{1}g_{11}$  and  $g'_{\varepsilon}$  $S_3g_{31}$ . Therefore, Ind $(\Lambda_{0,4}) \simeq \mathbb{S}^1$ .

Now, let  $n \geq 1$ . Since  $g'_1$  $\Lambda'_{1}$  is a simplicial vertex in  $\Lambda_{n,4} \setminus g_{21}$ , with  $N(g'_{1})$  $\binom{1}{1} = \{g_2'$  $'_{2},g_{11}\},$ using [Proposition 2.4,](#page-3-1) we get

$$
Ind(\Lambda_{n,4}\setminus g_{21}) \simeq \Sigma Ind((\Lambda_{n,4}\setminus g_{21})\setminus N[g_2']) \vee \Sigma Ind((\Lambda_{n,4}\setminus g_{21})\setminus N[g_{11}]).
$$

However, the graph  $(\Lambda_{n,4}\backslash g_{21})\backslash N[g'_2]$  $Z_2$  is isomorphic to  $B_{n-1,4}$  (see [Figure 26\)](#page-27-0). Therefore,  $\text{Ind}(\Lambda_{n,4}\backslash g_{21})\simeq \text{LInd}(B_{n-1,4})\vee \text{LInd}((\Lambda_{n,4}\backslash g_{21})\backslash N[g_{11}]).$  Let  $\Lambda^1_{n,4}:=(\Lambda_{n,4}\backslash g_{21})\backslash N[g_{11}].$ Further, since  $g'$ <sup>'</sup><sub>3</sub> is a simplicial vertex in the graph  $\Lambda_{n,4}^1$  with  $N(g_3^0)$  $\mathcal{L}'_3$ ) = {g<sub>31</sub>}, Ind( $\Lambda^1_{n,4}$ )  $\simeq$  $\Sigma \text{Ind}(\Lambda_{n,4}^1 \setminus N[g_{31}])$ . Observe that the graph  $\Lambda_{n,4}^1 \setminus N[g_{31}]$  is isomorphic to  $\Gamma_{n-1,4}$ . Therefore,  $\text{Ind}(\Lambda_{n,4}^1) \simeq \Sigma \text{Ind}(\Gamma_{n-1,4})$ . This completes the proof.

#### 4.3 Graph  $A_{n,4}$

*Proof.* Since  $N(g_{31}) \subseteq N(a_1) \cap N(g_{11})$  in the graph  $A_{0,4}$  (see [Figure 24\)](#page-26-0), using [Proposition 2.3,](#page-3-2) we get  $\text{Ind}(A_{0,4}) \simeq \text{Ind}(A_{0,4} \setminus \{a_1, g_{11}\}) \simeq \mathbb{S}^0$ . So, we assume that  $n \geq 1$ . Since  $a_1$  is a simplicial vertex in  $A_{n,4}$  with  $N(a_1) = \{g_{11}, g_{21}\}\text{, from Proposition 2.4, we get}$  $N(a_1) = \{g_{11}, g_{21}\}\text{, from Proposition 2.4, we get}$  $N(a_1) = \{g_{11}, g_{21}\}\text{, from Proposition 2.4, we get}$ 

 $\text{Ind}(A_{n,4}) \simeq \Sigma \text{Ind}(A_{n,4} \setminus N[g_{11}]) \vee \Sigma \text{Ind}(A_{n,4} \setminus N[g_{21}])$ 

$$
\simeq \Sigma \text{Ind}(A_{n,4} \setminus N[g_{11}]) \vee \Sigma \text{Ind}(A_{n-1,4}), \tag{4.1}
$$

where the second homotopy equivalence from the observation that  $A_{n,4} \setminus N[g_{21}]$  is isomorphic to  $A_{n-1,4}$ . Let  $A_{n,4}^1 := A_{n,4} \setminus N[g_{11}]$  (see [Figure 25\(a\)\)](#page-26-1). Since  $g_{31}$  is a simplicial vertex in the graph  $A_{n,4}^1$  with  $N(g_{31}) = \{g_{22}, g_{32}\}\,$ , we have

$$
\operatorname{Ind}(A_{n,4}^1) \simeq \Sigma \operatorname{Ind}(A_{n,4}^1 \setminus N[g_{22}]) \vee \Sigma \operatorname{Ind}(A_{n,4}^1 \setminus N[g_{32}]). \tag{4.2}
$$

In particular, for  $n = 1$ , the graph  $A_{1,4}^1 \setminus N[g_{22}]$  consists of a single vertex  $g_{33}$ , and  $A_{1,4}^1 \setminus N[g_{32}]$  is a graph consisting of exactly one edge  $g_{13}g_{23}$ . Therefore,  $\text{Ind}(A_{1,4}^1) \simeq \mathbb{S}^1$ , and it follows that  $\text{Ind}(A_{1,4}) \simeq \mathbb{S}^1 \vee \mathbb{S}^2$ .

Now, consider  $n \geq 2$ . Observe that the graph  $A_{n,4}^1 \setminus N[g_{22}]$  is isomorphic to  $B_{n-2,4}$ (see [Figure 26\)](#page-27-0). Therefore,  $\text{Ind}(A_{n,4}^1) \simeq \Sigma \text{Ind}(B_{n-2,4}) \vee \Sigma \text{Ind}(A_{n,4}^1 \setminus N[g_{32}]).$ 

We now compute  $\text{Ind}(A_{n,4}^1 \setminus N[g_{32}])$ . Since  $N(g_{13}) \subseteq N(g_{24})$  in the graph  $A_{n,4}^1 \setminus N[g_{32}]$ .  $N[g_{32}]$  (see [Figure 25\(a\)\)](#page-26-1),  $\text{Ind}(A_{n,4}^1 \setminus N[g_{32}]) \simeq \text{Ind}((A_{n,4}^1 \setminus N[g_{32}]) \setminus g_{24})$ . Let  $A_{n,4}^2 =$  $(A_{n,4}^1 \setminus N[g_{32}]) \setminus g_{24}$ . Then  $\text{Ind}(A_{n,4}^1 \setminus N[g_{32}]) \simeq \text{Ind}(A_{n,4}^2)$ . Observe that  $[g_{34}, g_{25}; g_{13}]$ and  $[g_{34}, g_{15}; g_{13}]$  are edge-invariant triplets in the graphs  $A_{n,4}^2$  (see [Figure 25\(b\)\)](#page-26-1) and  $A_{n,4}^2 + \{g_{34}g_{25}\}\,$  respectively. Therefore,  $\text{Ind}(A_{n,4}^2) \simeq \text{Ind}(A_{n,4}^2 + \{g_{34}g_{25}, g_{34}g_{15}\})$ . Let the resultant graph that we obtain be  $A_{n,4}^3$  (see [Figure 25\(c\)\)](#page-26-1). Then  $\text{Ind}(A_{n,4}^2) \simeq \text{Ind}(A_{n,4}^3)$ . Since  $[g_{23}, g_{34}; g_{14}]$  is an edge-invariant triplet in the graph  $A_{n,4}^3$  (see [Figure 25\(c\)\)](#page-26-1), we find that  $\text{Ind}(A_{n,4}^3) \simeq \text{Ind}(A_{n,4}^3 - \{g_{23}g_{34}\})$ . Furthermore,  $N(g_{23}) \subseteq N(g_{14})$  in the graph  $A_{n,4}^3 - \{g_{23}g_{34}\}\$ implies that  $\text{Ind}(A_{n,4}^3) \simeq \text{Ind}((A_{n,4}^3 - \{g_{23}g_{34}\}) \setminus g_{14})$ . Since the graph  $(A_{n,4}^3 - \{g_{23}g_{34}\})\setminus g_{14}$  consists of two connected components: one isomorphic to  $K_2$  and the other component is isomorphic to the graph  $C_{n-2,4}$  (see [Figure 27\)](#page-28-0), we obtain the following

\operatorname{Ind}(A_{n,4}^1 \setminus N[g_{32}]) \simeq \operatorname{Ind}(A_{n,4}^2) \simeq \operatorname{Ind}(A_{n,4}^3) \simeq \Sigma \operatorname{Ind}(C_{n-2,4}).\tag{4.3}
$$
  
Now, the result follows from (4.1), (4.2) and (4.3).

## 4.4 Graph  $B_{n,4}$

For  $n \geq 0$ , we define the graph  $B_{n,4}$  as follows:

Claim 4.4. For  $n \geq 0$ ,

$$
\mathrm{Ind}(B_{n,4})\simeq \begin{cases} \mathbb{S}^1\vee \mathbb{S}^1 & \textit{if $n=0$,}\\ \vee_3\mathbb{S}^2 & \textit{if $n=1$,}\\ \Sigma\mathrm{Ind}(B_{n-1,4})\vee \Sigma^2\mathrm{Ind}(A_{n-1,4})\vee \Sigma^3\mathrm{Ind}(D_{n-2,4}) & \textit{if $n\geq 2$.} \end{cases}
$$

*Proof.* Since  $b_1$  is a simplicial vertex in  $B_{n,4}$  with  $N(b_1) = \{b_3, b_4\}$ , we get  $\text{Ind}(B_{n,4}) \simeq$  $\Sigma$ Ind( $B_{n,4} \setminus N[b_3]$ )  $\vee$   $\Sigma$ Ind( $B_{n,4} \setminus N[b_4]$ ). In the case of  $n = 0$ , the graph  $B_{0,4} \setminus N[b_3]$ consists of an isolated vertex,  $g_{31}$ , and  $B_{0,4} \setminus N[b_4]$  is isomorphic to the complete graph  $K_3$ . Therefore, Ind $(B_{0,4}) \simeq \mathbb{S}^1 \vee \mathbb{S}^1$ .

Let  $n = 1$ . In the case of  $B_{1,4}$ , the graph  $B_{1,4} \setminus N[b_3]$  is isomorphic to  $B_{0,4}$ . Hence,  $\text{Ind}(B_{1,4}\setminus N[b_3]) \simeq \mathbb{S}^1 \vee \mathbb{S}^1$ . Let  $B'_{1,4} = B_{1,4} \setminus N[b_4]$ . Then,  $b_2$  is a simplicial vertex in the graph  $B'_{1,4}$  with  $N(b_2) = \{g_{11}, g_{21}\}\$ , implying that  $\text{Ind}(B'_{1,4}) \simeq \Sigma \text{Ind}(B'_{1,4} \setminus N[g_{11}]) \vee$  $\Sigma$ Ind( $B'_{1,4} \setminus N[g_{21}]$ ). Since  $N(g_{32}) \subseteq N(g_{23})$  in the graph  $B'_{1,4} \setminus N[g_{11}]$ , we get Ind( $B'_{1,4} \setminus N[g_{21}]$ ).  $N[g_{11}]) \simeq \text{Ind}((B'_{1,4} \setminus N[g_{11}]) \setminus g_{23})$ . However, the graph  $(B'_{1,4} \setminus N[g_{11}]) \setminus g_{23}$  is a path on 4 vertices, implying that  $\text{Ind}(B'_{1,4} \setminus n[g_{11}])$  is contractible. On the other hand, the graph  $B'_{1,4} \setminus N[g_{21}]$  is isomorphic to  $A_{0,4}$ . Therefore,  $\text{Ind}(B'_{1,4}) \simeq \mathbb{S}^1$ , and it follows that Ind( $B_{1,4}$ )  $\simeq \vee_3$ S<sup>2</sup>. It is evident that the graphs  $B_{n,4}$  and  $A_{n,4}$  exhibit similarities. Additionally, the graph  $B_{n,4}$  can be derived from  $A_{n,4}$  by introducing four vertices, namely  $b_1$ ,  $b_2$ ,  $b_3$ , and  $b_4$ , with  $b_2$ ,  $b_3$ , and  $b_4$  forming a vertical line. Consequently, for  $n \geq 2$ , the proof proceeds analogously to the approach outlined in [Claim 4.3.](#page-26-2)

#### 4.5 Graph  $C_{n,4}$

V(C_{n,4}) = V(\Gamma_{n,4}) \cup \{c_1\},

E(B_{n,4}) = E(\Gamma_{n,4}) \cup \{c_1g_{11}, c_1g_{21}, c_1g_{31}\}.

\operatorname{Ind}(C_{n,4}) \simeq \begin{cases} \mathbb{S}^0 \vee \mathbb{S}^0 & \text{for } n = 0, \\ \mathbb{S}^1 & \text{for } n = 1, \\ \Sigma \operatorname{Ind}(A_{n-1,4}) \vee \Sigma^2 \operatorname{Ind}(B_{n-2,4}) \vee \Sigma^2 \operatorname{Ind}(D_{n-2,4}) & \text{for } n \ge 2. \end{cases}
$$

*Proof.* Since  $N(g_{11}) \subseteq N(g_{31})$  in the graph  $C_{0,4}$ , we get  $\text{Ind}(C_{0,4}) \simeq \text{Ind}(C_{0,4} \setminus g_{31})$ . However, the graph  $C_{0,4} \setminus g_{31}$  is isomorphic to a cycle with three vertices, and therefore  $\mathrm{Ind}(C_{0,4}) \simeq \mathbb{S}^0 \vee \mathbb{S}^0.$ 

For  $n \geq 1$ , the inclusion map  $\text{Ind}(C_{n,4} \setminus N[g_{21}]) \hookrightarrow \text{Ind}(C_{n,4} \setminus g_{21})$  is null homotopic, because Ind $(C_{n,4} \setminus N[g_{21}]) * \{c_1\} \subseteq \text{Ind}(C_{n,4} \setminus g_{21})$ . Since the graph  $C_{n,4} \setminus N[g_{21}]$  is isomorphic to  $A_{n-1,4}$ , from [Proposition 2.2,](#page-3-4) we get

$$
\operatorname{Ind}(C_{n,4}) \simeq \operatorname{Ind}(C_{n,4} \setminus g_{21}) \vee \Sigma \operatorname{Ind}(C_{n,4} \setminus N[g_{21}]) \simeq \operatorname{Ind}(C_{n,4} \setminus g_{21}) \vee \Sigma \operatorname{Ind}(A_{n-1,4}).
$$

Let  $C_{n,4}^1 = C_{n,4} \setminus g_{21}$ . Since  $[g_{31}, g_{22}; g_{11}]$  is an edge invariant triplet in the graph  $C_{n,4}^1$ ,  $\text{Ind}(C_{n,4}^1) \simeq \text{Ind}(C_{n,4}^1 - \{g_{31}g_{22}\})$ . Let  $C_{n,4}^2 \coloneqq C_{n,4}^1 - \{g_{31}g_{22}\}$ . Then  $\text{Ind}(C_{n,4}^1) \simeq$ Ind $(C_{n,4}^2)$ . Since  $[g_{12}, g_{32}; c_1]$  is an edge-invariant triplet in the graph  $C_{n,4}^2$ , Ind $(C_{n,4}^2) \simeq$ 

Ind $(C_{n,4}^2 + \{g_{12}g_{32}\})$ . Furthermore,  $[g_{31}, g_{32}; g_{11}]$  is an edge-invariant triplet in the graph  $C_{n,4}^2 + \{g_{12}g_{32}\}\.$  Therefore,  $\text{Ind}(C_{n,4}^2) \simeq \text{Ind}((C_{n,4}^2 + \{g_{12}g_{32}\}) - \{g_{31}g_{32}\})$ . Observe that  $N(g_{31})$  ⊆  $N(g_{11})$  in the graph  $(C_{n,4}^2 + {g_{12}g_{32}}) - {g_{31}g_{32}}$ . Then, using [Proposition 2.3,](#page-3-2) we get that  $\text{Ind}(C_{n,4}^2) \simeq \text{Ind}((C_{n,4}^2 + \{g_{12}g_{32}\}) - \{g_{31}g_{32}\}) \setminus g_{11})$ . The resultant graph we obtain has two connected components: one consists of the edge  $g_{31}c_1$ , and we denote the other component by  $C_{n,4}^3$  (see [Figure 28\(b\)\)](#page-28-1). This implies that  $\text{Ind}(C_{n,4}^2) \simeq \Sigma \text{Ind}(C_{n,4}^3)$ .

Since  $\text{Ind}(C_{n,4}^3 \setminus N[g_{12}]) * \{g_{22}\} \subseteq \text{Ind}(C_{n,4}^3 \setminus g_{12}),$  the inclusion map  $\text{Ind}(C_{n,4}^3 \setminus N[g_{12}]) \hookrightarrow$  $\text{Ind}(C_{n,4}^3 \setminus g_{12})$  is null-homotopic. Therefore, by [Proposition 2.2](#page-3-4) we get

$$
\text{Ind}(C_{n,4}^3) \simeq \text{Ind}(C_{n,4}^3 \setminus g_{12}) \vee \Sigma \text{Ind}(C_{n,4}^3 \setminus N[g_{12}]). \tag{4.4}
$$

Since  $g_{33}$  is an isolated vertex in  $C_{1,4}^3 \setminus N[g_{12}]$ ,  $\text{Ind}(C_{n,4}^3 \setminus N[g_{12}]$ ) is contractible. Observe that  $N(g_{32}) \subseteq N(g_{23})$  in the graph  $C_{1,4}^3 \setminus g_{12}$ . Thus, using [Proposition 2.3,](#page-3-2) we find that  $\text{Ind}(C_{1,4}^3 \setminus g_{12}) \simeq \text{Ind}(C_{1,4}^3 \setminus \{g_{12}, g_{23}\})$ . Since the graph  $C_{1,4}^3 \setminus \{g_{12}, g_{23}\}$  is a path on 4vertices,  $\text{Ind}(C_{1,4}^3 \setminus g_{12})$  is contractible. Therefore,  $\text{Ind}(C_{1,4}^3)$  is contractible. This implies that  $\text{Ind}(C_{1,4}^1)$  is contractible. Hence,  $\text{Ind}(C_{1,4}) \simeq \text{SInd}(A_{0,4}) \simeq \mathbb{S}^1$ .

Now, consider  $n \geq 2$ . We observe that the graph  $C_{n,4}^3 \setminus N[g_{12}]$  is isomorphic to the graph  $B_{n-2,4}$ . Thus,

$$
\operatorname{Ind}(C_{n,4}^3) \simeq \operatorname{Ind}(C_{n,4}^3 \setminus g_{12}) \vee \Sigma \operatorname{Ind}(B_{n-2,4}).
$$

Since  $N(g_{32}) \subseteq N(g_{23})$  in  $C_{n,4}^3 \setminus g_{12}$ , using [Proposition 2.3](#page-3-2) we get  $\text{Ind}(C_{n,4}^3 \setminus g_{12}) \simeq$  $\text{Ind}(C_{n,4}^3 \setminus \{g_{12}, g_{23}\})$ . Let  $C_{n,4}^4 \coloneqq C_{n,4}^3 \setminus \{g_{12}, g_{23}\}$ . Then  $\text{Ind}(C_{n,4}^3 \setminus g_{12}) \simeq \text{Ind}(C_{n,4}^4)$ . Since,  $[g_{33}, g_{14}; g_{22}]$  and  $[g_{13}, g_{14}; g_{32}]$  are edge-invariant triplets in graphs  $C_{n,4}^4$  and  $C_{n,4}^4$  +  ${g_{33}g_{14}}$ , respectively, [Proposition 2.5,](#page-3-0) provides us with  $C_{n,4}^4 \simeq \text{Ind}((C_{n,4}^4 + {g_{33}g_{14}}) {g_{13}g_{14}}$ ). Let  $C_{n,4}^5 = (C_{n,4}^4 + {g_{33}g_{14}}) - {g_{13}g_{14}}$ . Then,  $\text{Ind}(C_{n,4}^4) \simeq C_{n,4}^5$ . Since  $N(g_{13}) \subseteq N(g_{32})$  in the graph  $C_{n,4}^5$ , [Proposition 2.3](#page-3-2) implies that  $\text{Ind}(C_{n,4}^5) \simeq \text{Ind}(C_{n,4}^5)$  $g_{32}$ ). The graph  $C_{n,4}^5 \setminus g_{32}$  consists of two connected components: one component consists of the edge  $g_{22}g_{32}$ , and the other component is isomorphic to  $D_{n-2,4}$ . Therefore,  $\text{Ind}(C_{n,4}^4) \simeq \text{Ind}(C_{n,4}^5) \simeq \text{LInd}(D_{n-2,4}).$  Therefore,  $\text{Ind}(C_{n,4}^3 \setminus g_{12}) \simeq \text{LInd}(D_{n-2,4}).$ Hence, the result follows.

\operatorname{Ind}(D_{n,4}) \simeq \begin{cases} \mathbb{S}^1 \vee \mathbb{S}^1 & \text{if } n = 0, \\ \bigvee_5 \mathbb{S}^2 & \text{if } n = 1, \\ \Sigma \operatorname{Ind}(B_{n-1,4}) \vee \Sigma^2 \operatorname{Ind}(A_{n-1,4}) \vee \Sigma^2 \operatorname{Ind}(C_{n-1,4}) & \text{if } n \ge 2. \end{cases}
$$

*Proof.* Since  $g_{11}$  is a simplicial vertex in  $D_{0,4}$  with  $N(g_{11}) = \{d_2, d_3, g_{21}\}\text{, Ind}(D_{0,4}) \simeq$  $\Sigma \text{Ind}(D_{0,4} \setminus N[d_2]) \vee \Sigma \text{Ind}(D_{0,4} \setminus N[d_3]) \vee \Sigma (\text{Ind}(D_{0,4} \setminus N[g_{21}])).$ 

Observe that both the graphs  $D_{0,4} \backslash N[d_2]$  and  $D_{0,4} \backslash N[g_{21}]$  are paths with two vertices and the graph  $D_{0,4} \setminus N[d_3]$  consists of an isolated vertex  $g_{31}$ . Hence  $\text{Ind}(D_{0,4}) \simeq \mathbb{S}^1 \vee \mathbb{S}^1$ .

Now, we compute  $\text{Ind}(D_{1,4})$ . The inclusion map  $\text{Ind}(D_{1,4} \setminus N[d_3]) \hookrightarrow \text{Ind}(D_{1,4} \setminus d_3)$  is null homotopic because  $\text{Ind}(D_{1,4} \setminus N[d_3]) * \{d_1\}$  is a subcomplex of  $\text{Ind}(D_{1,4} \setminus d_3)$ . Thus, from [Proposition 2.2,](#page-3-4) we get  $\text{Ind}(D_{1,4}) \simeq \Sigma \text{Ind}(D_{1,4} \setminus N[d_3]) \vee \text{Ind}(D_{1,4} \setminus d_3)$ . Observe that the graph  $D_{1,4} \setminus N[d_3]$  is isomorphic to  $B_{0,4}$ . Therefore,  $\text{Ind}(B_{0,4}) \simeq \mathbb{S}^1 \vee \mathbb{S}^1$  implies that

$$
Ind(D_{1,4}) \simeq \mathbb{S}^2 \vee \mathbb{S}^2 \vee Ind(D_{1,4} \setminus d_3).
$$

Let  $D'_{1,4} = (D_{1,4} \setminus d_3)$ . Then  $g_{13}$  is a simplicial vertex in the graph  $D'_{1,4}$  with  $N(g_{13}) =$  ${g_{12}, g_{22}, g_{23}}$ . Using [Proposition 2.4,](#page-3-1) we find that  $\text{Ind}(D'_{1,4}) \simeq \text{LInd}(D'_{1,4} \setminus N[g_{12}]) \vee$  $\Sigma \text{Ind}(D'_{1,4} \setminus N[g_{22}]) \vee \Sigma \text{Ind}(D'_{1,4} \setminus N[g_{23}])$ . Since  $N(g_{33}) \subseteq N(g_{21}) \cap N(g_{31})$  in the graph  $D'_{1,4} \setminus N[g_{12}]$ ,  $\text{Ind}(D'_{1,4} \setminus N[g_{12}]) \simeq \text{Ind}((D'_{1,4} \setminus N[g_{12}]) \setminus \{g_{21}, g_{31}\})$ . Observe that the graph  $(D'_{1,4} \setminus N[g_{12}]) \setminus \{g_{21}, g_{31}\}\$  is a disjoint union of two paths with 2 and 3 vertices. Hence  $\text{Ind}(D'_{1,4} \setminus N[g_{12}]) \simeq \mathbb{S}^1$ .

Since the graph  $D'_{1,4} \setminus N[g_{22}]$  contains an isolated vertex  $g_{33}$ , Ind $(D'_{1,4} \setminus N[g_{22}])$  is contractible.

Let  $D''_{1,4} = D'_{1,4} \setminus N[g_{23}]$ . Since  $g_{32}$  is a simplicial vertex in  $D''_{1,4}$  with  $N(g_{32}) =$  ${g_{21}, g_{31}}$ , we have  $\text{Ind}(D''_{1,4}) \simeq \Sigma \text{Ind}(D''_{1,4} \setminus N[g_{21}]) \vee \Sigma \text{Ind}(D''_{1,4} \setminus N[g_{31}])$ . However, the graph  $D''_{1,4} \setminus N[g_{21}]$  is an edge  $d_1 d_4$  and the graph  $D''_{1,4} \setminus N[g_{31}]$  is a path on three vertices  $d_1, d_2$  and  $g_{11}$  and hence, using [Proposition 2.8,](#page-4-1) we get that  $\text{Ind}(D''_{1,4}) \simeq \mathbb{S}^1 \vee \mathbb{S}^1$ . Consequently, Ind $(D_{1,4}) \simeq \vee_5 {\mathbb S}^2$ . It is evident that the graphs  $C_{n,4}$  and  $D_{n,4}$  exhibit similarities. Additionally, the graph  $D_{n,4}$  can be derived from  $C_{n,4}$  by introducing four vertices, namely  $d_1$ ,  $d_2$ ,  $d_3$ , and  $d_4$ , with  $d_2$ ,  $d_3$ , and  $d_4$  forming an extra vertical line. Consequently, for  $n \geq 2$ , the proof proceeds analogously to the approach outlined in Claim  $4.5$ .

<span id="page-30-0"></span>**Theorem 4.7.** For any graph  $G_{n,4} \in {\{\Gamma_{n,4}, \Lambda_{n,4}, A_{n,4}, B_{n,4}, C_{n,4}, D_{n,4}\}}$ ,  $n \geq 0$ , the complex  $\text{Ind}(G_{n,4})$  is homotopy equivalent to a wedge of spheres.

*Proof.* The proof follows from [Claims 4.1](#page-25-2) to [4.6,](#page-29-1) and the induction hypothesis.  $\Box$ 

# 4.7 Homotopy type of  $M(P_n \times P_4)$

In this section, we conclude the homotopy type of  $M(P_n \times P_4)$  along with the minimum and maximum dimensions of the independence complexes of the graphs in  $\{\Gamma_{n,4}, \Lambda_{n,4}, A_{n,4}, \Lambda_{n,4}, \Lambda_{$  $B_{n,4}, C_{n,4}, D_{n,4}.$ 

**Theorem 4.8.** For  $n \geq 1$ ,  $M(P_n \times P_4)$  is homotopy equivalent to a wedge of spheres.

*Proof.* For  $n \geq 0$ , we have relations  $M(P_{2n+2} \times P_4) = \text{Ind}(\Gamma_{n,4}) \ast \text{Ind}(\Gamma_{n,4})$  and  $M(P_{2n+3} \times P_4)$  $P_4$ ) = Ind( $\Lambda_{n,4}$ ) \* Ind( $\Lambda_{n,4}$ ). Now, the result follows from [Theorem 4.7.](#page-30-0)

<span id="page-30-1"></span>**Proposition 4.9.** For  $n = 7q + r$  with  $q \ge 0$  and  $0 \le r \le 6$ , we

d_{max}(\text{Ind}(\Lambda_{n,4})) = \begin{cases} n+3q & \text{if } r = 0, \\ n+3q+1 & \text{if } r = 1,2, \\ n+3q+2 & \text{if } r = 3,4, \\ n+3q+3 & \text{if } r = 5,6. \end{cases}
$$

d_{min}(\text{Ind}(A_{n,4})) = n
$$
 and  $d_{max}(\text{Ind}(A_{n,4})) = \begin{cases} n+3q & \text{if } r = 0, \\ n+3q+1 & \text{if } r = 1,2,3, \\ n+3q+2 & \text{if } r = 4,5, \\ n+3q+3 & \text{if } r = 6. \end{cases}$   
\n•  $d_{min}(\text{Ind}(B_{n,4})) = n+1$  and  $d_{max}(\text{Ind}(B_{n,4})) = \begin{cases} n+3q+1 & \text{if } r = 0,1, \\ n+3q+2 & \text{if } r = 2,3, \\ n+3q+3 & \text{if } r = 4,5,6. \end{cases}$   
\n•  $d_{min}(\text{Ind}(C_{n,4})) = n$  and  $d_{max}(\text{Ind}(C_{n,4})) = \begin{cases} n+3q & \text{if } r = 0,1, \\ n+3q+1 & \text{if } r = 2,3, \\ n+3q+2 & \text{if } r = 4,5, \\ n+3q+3 & \text{if } r = 6. \end{cases}$   
\n•  $d_{min}(\text{Ind}(D_{n,4})) = n+1$  and  $d_{max}(\text{Ind}(D_{n,4})) = \begin{cases} n+3q+1 & \text{if } r = 0,1, \\ n+3q+3 & \text{if } r = 6. \\ n+3q+2 & \text{if } r = 2,3,4, \\ n+3q+3 & \text{if } r = 5,6. \end{cases}$ 

*Proof.* We prove the statement using induction on n. The base case for  $n = 0$  follows from [Claims 4.1](#page-25-2) to [4.6.](#page-29-1) Assume the statement is true for  $k < n$ . For  $\Gamma_{n,4}$ , we have

$$
\Gamma_{n,4} = \Sigma \text{Ind}(A_{n-1,4}) \vee \Sigma^2 \text{Ind}(\Lambda_{n-2,4}),\tag{4.5}
$$

which implies that

$$
d_{min}(\text{Ind}(\Gamma_{n,4})) = \min\{1 + d_{min}(\text{Ind}(A_{n-1,4})), 2 + d_{min}(\text{Ind}(\Lambda_{n-2,4}))\},\
$$

and

<span id="page-31-2"></span>
$$
d_{max}(\text{Ind}(\Gamma_{n,4})) = \max\{1 + d_{max}(\text{Ind}(A_{n-1,4})), 2 + d_{max}(\text{Ind}(\Lambda_{n-2,4}))\}.
$$
 (4.6)

In particular, using induction hypothesis, we have  $d_{min}(\text{Ind}(\Gamma_{n,4})) = \min\{1 + (n-1), 2+\}$  $(n-1)$ } = n. Further, for  $n = 7q + r$  with  $0 \le r \le 6$ , [\(4.5\)](#page-31-1) and [\(4.6\)](#page-31-2) yields the following.



By similar argument, we can conclude the maximum dimensions of  $\Lambda_{n,4}$ ,  $A_{n,4}$ ,  $B_{n,4}$ ,  $C_{n,4}$ and  $D_{n,4}$ .

<span id="page-31-0"></span>**Remark 4.10.** The maximum and minimum dimension of spheres in the homotopy type of  $M(P_n \times P_4)$  as given in [Proposition 1.5](#page-1-4) can be concluded from [Proposition 4.9.](#page-30-1)

# 5 MATCHING COMPLEXES OF  $P_n \times P_3$

In this section, we determine the homotopy type of the matching complex of  $P_n \times P_3$ . The graph  $P_n \times P_3$  is disconnected and has two connected components. Notably, if n is even, then these components are isomorphic. However, for  $n$  odd, the components are not isomorphic. For  $n \geq 0$ , we denote the (isomorphic) connected components of the line graphs of  $P_{2n+2} \times P_3$  by  $\Gamma_{n,3}$  (see [Figure 30\)](#page-32-0). Furthermore, for  $n \geq 0$ , we denote the (non-isomorphic) connected components of the line graphs of  $P_{2n+3} \times P_3$  by  $\Lambda_{n,3}$  and  $\tilde{\Lambda}_{n,3}$  (see [Figures 32](#page-33-0) and [33\)](#page-33-1), respectively. Therefore, we have the following:

$$
M(P_{2n+2} \times P_3) \simeq \text{Ind}(\Gamma_{n,3}) * \text{Ind}(\Gamma_{n,3}),
$$
  

$$
M(P_{2n+3} \times P_3) \simeq \text{Ind}(\Lambda_{n,3}) * \text{Ind}(\tilde{\Lambda}_{n,3}).
$$

During the computation of the homotopy type of the independence complexes of graphs  $\overline{\Gamma}_{n,3}, \Lambda_{n,3}$ , and  $\overline{\Lambda}_{n,3}$  for  $n \geq 0$ , we encounter an intermediary graph denoted as  $A_{n,3}$  (see [Figure 31\)](#page-32-1). Using the independence complex of  $A_{n,3}$ , we illustrate that the independence complexes of  $\Gamma_{n,3}$ ,  $\Lambda_{n,3}$ , and  $\tilde{\Lambda}_{n,3}$  are the wedges of spheres.

### 5.1 Graph  $\Gamma_{n,3}$

For  $n \geq 0$ , we define the graph  $\Gamma_{n,3}$  as follows:

V(\Gamma_{n,3}) = \{g_{ij} : i = 1, 2 \text{ and } j = 1, 2, \dots, 2n+1\},

# <span id="page-32-3"></span>Claim 5.1. For  $n \geq 0$ , Ind $(\Gamma_{n,3}) \simeq \mathbb{S}^n$ .

*Proof.* Since  $N(g_{11}) \subseteq N(g_{22})$  and  $N(g_{21}) \subseteq N(g_{12})$ ,  $\text{Ind}(\Gamma_{n,3}) \simeq \text{Ind}(\Gamma_{n,3} \setminus \{g_{12}, g_{22}\}).$ It is straightforward to see that  $\Gamma_{n,3} \setminus \{g_{12}, g_{22}\}\$  has two connected components; one component is an edge  $g_{11}g_{21}$ , and the other is isomorphic to  $\Gamma_{n-1,3}$ . Therefore, Ind( $\Gamma_{n,3}$ )  $\simeq$  $\Sigma Ind(\Gamma_{n-1,3})$ . Consequently, we get  $Ind(\Gamma_{n,3}) \simeq \Sigma^n Ind(\Gamma_{0,3})$ . Since  $\Gamma_{0,3}$  is isomorphic to  $K_2$ , we have Ind( $\Gamma_{0,3}$ )  $\simeq$   $\mathbb{S}^0$ , and result follows.

# 5.2 Graph  $A_{n,3}$

<span id="page-32-1"></span>For  $n \geq 0$ , we define the graph  $A_{n,3}$  as follows:

$$
V(A_{n,3}) = V(\Gamma_{n,3}) \cup \{a_1\},
$$
  
 
$$
E(A_{n,3}) = E(\Gamma_{n,3}) \cup \{a_1g_{11}, a_1g_{21}\}.
$$

<span id="page-32-2"></span>Claim 5.2. For  $n \geq 0$ ,  $\text{Ind}(A_{n,3}) \simeq \bigvee_2 \text{LInd}(A_{n-1,3}) \simeq \bigvee_{2^{n+1}} \mathbb{S}^n$ .

*Proof.* Since  $a_1$  is a simplicial vertex in the graph  $A_{n,3}$  (see [Figure 31\)](#page-32-1) with  $N(a_1)$  =  ${g_{11}, g_{21}}$ , Ind $(A_{n,3}) \simeq \Sigma \text{Ind}(A_{n,3} \setminus N[g_{11}]) \vee \Sigma \text{Ind}(A_{n,3} \setminus N[g_{21}])$ . Since both the graphs  $A_{n,3} \setminus N[g_{11}]$  and  $A_{n,3} \setminus N[g_{21}]$  are isomorphic to  $A_{n-1,3}$ ,  $\text{Ind}(A_{n,3}) \simeq \bigvee_2 \text{SInd}(A_{n-1,3})$ . Observe that the graph  $A_{0,3}$  is isomorphic to  $K_3$ , and hence Ind $(A_{0,3}) \simeq \mathbb{S}^0 \vee \mathbb{S}^0$ . Therefore, by induction, we get  $\text{Ind}(A_{n,3}) \simeq \bigvee_{2^n} (\mathbb{S}^n) \bigvee_{2^n} (\mathbb{S}^n)$ . This completes the proof.  $\square$ 

# 5.3 Graphs  $\Lambda_{n,3}$  and  $\tilde{\Lambda}_{n,3}$

For  $n \geq 0$ , we define the graphs  $\Lambda_{n,3}$  (see [Figure 32\)](#page-33-0) and  $\tilde{\Lambda}_{n,3}$  (see [Figure 33\)](#page-33-1) as follows:

$$
V(\Lambda_{n,3}) = V(\Gamma_{n,3}) \cup \{g'_1, g'_2\},
$$
  
 
$$
E(\Lambda_{n,3}) = E(\Gamma_{n,3}) \cup \{g'_1g_{11}, g'_2g_{21}, g'_1g'_2, g'_1g_{21}, g'_2g_{11}\},
$$

V(\tilde{\Lambda}_{n,3}) = V(\Gamma_{n,3}) \cup \{g_{12n+2}, g_{22n+2}\},

<span id="page-33-2"></span>Claim 5.3. For  $n \geq 0$ ,  $\text{Ind}(\Lambda_{n,3}) \simeq \bigvee_{2^{n+2}-1} \mathbb{S}^n$ .

*Proof.* The proof is by induction on n. Clearly,  $\text{Ind}(\Lambda_{0,3}) \simeq \bigvee_3 \mathbb{S}^0$ . Assume that  $n \geq 1$ and the [Claim 5.3](#page-33-2) holds for all  $0 \leq k < n$ . Since  $g'_1$  $\sum_{1}^{\infty}$  is a simplicial vertex and  $N(g_1')$  $'_{1}) =$  ${g'_2}$  $\{2, g_{11}, g_{21}\}\$ in the graph  $\Lambda_{n,3}$  (see [Figure 32\)](#page-33-0), we have

$$
\operatorname{Ind}(\Lambda_{n,3}) \simeq \Sigma \operatorname{Ind}(\Lambda_{n,3} \setminus N[g_2']) \vee \Sigma \operatorname{Ind}(\Lambda_{n,3} \setminus N[g_{11}]) \vee \Sigma \operatorname{Ind}(\Lambda_{n,3} \setminus N[g_{21}]).
$$

Observe that the graph  $\Lambda_{n,3} \setminus N[g_2]$  $\Lambda_{2}$  is isomorphic to  $\Lambda_{n-1,3}$ , whereas both the graphs  $\Lambda_{n,3} \setminus N[g_{11}]$  and  $\Lambda_{n,3} \setminus N[g_{21}]$  are isomorphic to  $A_{n-1,3}$ . Therefore, we get

$$
Ind(\Lambda_{n,3}) \simeq \Sigma Ind(\Lambda_{n-1,3}) \vee \Sigma Ind(A_{n-1,3}) \vee \Sigma Ind(A_{n-1,3}).
$$

Now, from the induction hypothesis and [Claim 5.2,](#page-32-2) we conclude the following:

$$
\operatorname{Ind}(\Lambda_{n,3}) \simeq \bigvee_{2^{n+1}-1} (\Sigma \mathbb{S}^{n-1}) \bigvee_{2^n} (\Sigma \mathbb{S}^{n-1}) \bigvee_{2^n} (\Sigma \mathbb{S}^{n-1}) \simeq \bigvee_{2^{n+2}-1} \mathbb{S}^n.
$$

<span id="page-33-3"></span>Claim 5.4. For  $n \geq 0$ ,  $\text{Ind}(\tilde{\Lambda}_{n,3}) \simeq \mathbb{S}^n$ .

 $\Box$ 

*Proof.* It is evident that the graphs  $\Gamma_{n,3}$  and  $\tilde{\Lambda}_{n,3}$  exhibit similarities (see [Figure 30](#page-32-0) and [Figure 33\)](#page-33-1). Moreover, it is clear from the edge set of  $\tilde{\Lambda}_{n,3}$  that the graph  $\tilde{\Lambda}_{n,3}$  can be obtained by the addition of three edges at rightmost end to the graph  $\Gamma_{n,3}$ . Therefore, the proof for  $\text{Ind}(\tilde{\Lambda}_{n,3})$  is verbatim to the proof of [Claim 5.1.](#page-32-3)

<span id="page-34-0"></span>**Theorem 5.5.** For 
$$
n \ge 0
$$
,  $M(P_{2n+2} \times P_3) \simeq \mathbb{S}^{2n+1}$  and  $M(P_{2n+3} \times P_3) \simeq \bigvee_{2^{n+2}-1} \mathbb{S}^{2n+1}$ .

*Proof.* Since the line graph of the categorical product  $P_{2n+2} \times P_3$  is the disjoint union of two copies of  $\Gamma_{n,3}$ , using [Proposition 2.1](#page-3-3) and [Claim 5.1,](#page-32-3) we get

$$
M(P_{2n+2} \times P_3) \simeq \text{Ind}(\Gamma_{n,3}) * \text{Ind}(\Gamma_{n,3}) \simeq \mathbb{S}^{2n+1}.
$$

Similarly, the line graph of the categorical product  $P_{2n+3} \times P_3$  is the disjoint union of  $\Lambda_{n,3}$  and  $\tilde{\Lambda}_{n,3}$ . Therefore, using [Proposition 2.1,](#page-3-3) [Claim 5.3,](#page-33-2) and [Claim 5.4](#page-33-3) we get

$$
M(P_{2n+3} \times P_3) \simeq \text{Ind}(\Lambda_{n,3}) * \text{Ind}(\tilde{\Lambda}_{n,3}) \simeq \bigvee_{2^{n+2}-1} \mathbb{S}^{2n+1}.
$$

#### 6 Future Directions

<span id="page-34-1"></span>We proved that for  $n \geq 3$  and  $3 \leq m \leq 5$ , the matching complex of  $P_n \times P_m$  is homotopy equivalent to a wedge of spheres. For  $m = 3$ , we have given a closed-form formula for the number and dimension of spheres appearing in the wedge. Further, for  $m \in \{4, 5\}$ , we have given the minimum and maximum dimension of spheres appearing in the wedge in  $M(P_n \times P_m)$ . This exploration naturally leads to the following question:

Question 6.1. Can we determine the dimensions of the spheres appearing in the wedge representing the homotopy types of the matching complexes of categorical products  $P_n \times P_4$ and  $P_n \times P_5$ ?

Based on the main result of this article and our computer-based computations, we propose the following:

**Conjecture 6.2.** For  $n \geq 3$  and  $m \geq 6$ , the matching complex of categorical product  $P_n \times P_m$  is homotopy equivalent to a wedge of spheres.

For odd m, n, one component of  $P_n \times P_m$  is an induced subgraph of  $P_n \Box P_m$  (see [Figure 1\)](#page-1-0). Since the homotopy type of the matching complexes of  $P_n \Box P_m$  is not known for  $m \geq 4$ , it will be interesting to see if there is any relation between the topology of  $M(P_n \times P_n)$  and  $M(P_n \Box P_m)$ .

Question 6.3. Is there any correlation between the matching complexes of the cartesian product of path graphs and those of the categorical product of path graphs?
