The role of rare-earth atoms in the anisotropy and antiferromagnetic exchange coupling at a hybrid metal-organic interface

Magnetic anisotropy and magnetic exchange interactions are crucial parameters that characterize the hybrid metal-organic interface, key component of an organic spintronic device. We show that the incorporation of 4f RE atoms to hybrid metal-organic interfaces of CuPc/REAu₂ type (RE= Gd, Ho) constitutes a feasible approach towards on-demand magnetic properties and functionalities. The GdAu₂ and HoAu₂ substrates differ in their magnetic anisotropy behavior. Remarkably, the HoAu₂ surface boosts the inherent out-of-plane anisotropy of CuPc, owing to the match between the anisotropy axis of substrate and molecule. Furthermore, the presence of RE atoms leads to a spontaneous antiferromagnetic (AFM) exchange coupling at the interface, induced by the 3d-4fsuperexchange interaction between the unpaired 3d electron of CuPc and the 4f electrons of the RE atoms. We show that 4f RE atoms with unquenched quantum orbital momentum (L), as it is the case of Ho, induce an anisotropic interfacial exchange coupling.

I. INTRODUCTION

Molecular spintronics is an emerging field that combines ferromagnetic materials with organic or metalorganic semiconductors. It benefits from the unique and exceptional properties of organic molecules, which go beyoud inorganics [1, 2]. Furthermore, the strong response of many organic molecules to electrical, optical or magnetic stimuli bring new potential functionalities to the spintronic device [3–5]. An effective spin tunneling between the ferromagnet and the organic molecule is governed by the so-called *spinterface* that is formed by the hybrid interface between both materials. The spinterface is defined on the one hand by the energy level alignment between molecule and ferromagnet, and on the other hand by its anisotropy and the interfacial magnetic exchange interaction [4, 6-11]. It is thus desirable to be able of controlling both energy level alignment and magnetic interaction. The former can be tuned by choosing the molecular species having convenient functional groups. Tailoring magnetic interactions is more difficult. Several authors have modified the interfacial exchange interaction between a ferromagnetic electrode and organic molecules by the incorporation of spacers like graphene, oxygen atoms or a Cu layer in systems formed by phtalocyanine or porphyrin molecules adsorbed on ferromagnetic Ni or Co surfaces [12–15]. Thus, the natural ferromagnetic (FM) interfacial exchange interaction has been turned to an antiferromagnetic (AFM) one, which is a relevant feature in the design of molecular spintronic devices [16]. Another strategy to get an interfacial AFM exchange coupling is to use 3d transition metal surfaces and RE-centered metal-organic molecules [17, 18].

In this work, we explore an alternative way of achieving an interfacial AFM exchange interaction combining a ferromagnetic single atom thick layer that incorporates RE atoms with a single monolayer of organic molecules that include transition metal atoms. For this purpose, we adsorb copper phthalocyanine (CuPc) molecules on ferromagnetic $GdAu_2$ and $HoAu_2$ single atomic layers [19–23]. A spontaneous antiparallel alignment between the CuPc spin and the magnetization of the REAu₂ surfaces is detected, which is induced by a superexchange interaction between the unpaired 3d electron of CuPc and the 4felectrons of the RE. Such interfacial AFM coupling has been already observed in different systems like Co nanodots grown on GdAu₂ MLs [24–27] or RE adatoms on Fe islands [28]. Campbell proposed a model [29] to explain the 4f-3d exchange found in RE-transition metal compounds, extensively studied in the past. This model featured an intra-atomic FM exchange interaction between the RE 4f and RE 5d spins and a subsequent AFM exchange coupling between the itinerant RE 5d and the 3dspins of the transition metal. Furthermore, we have observed in our system that the presence of 4f electrons with an unquenched quantum orbital momentum L, as it is the case of Ho, introduces strong spin-orbit effects that lead to an anisotropic exchange mechanism. This unconventional feature is of interest for the development of interfaces with improved functionalities, such as an anisotropic magnetoresistance behavior [30].

Both substrate formed by GdAu₂ and HoAu₂ monolayers (MLs) exhibit a RKKY exchange coupling between the RE atoms [21, 23] and a similar Curie temperature of $T_C = 19 \,\mathrm{K}$ and $22 \,\mathrm{K}$, respectively. However, these materials differ in their magnetic anisotropic behavior, which is defined by the RE atom. HoAu₂ has an out-of-plane (OOP) easy-axis of magnetization, while GdAu₂ has an in-plane (IP) one [21, 22, 25]. In the case of HoAu₂ the main anisotropy contribution arises from localized 4f electrons. On the contrary, in the case of GdAu₂, as Gd has an L = 0, the magnetocrystalline anisotropy originates from specific spin-orbit splittings that take place in the RE(d)-Au(s) hybrid bands of the GdAu₂ band structure [23]. In this work, we explore the magnetic anisotropy of the spinterfaces formed by the adsorption of CuPc on HoAu₂ and GdAu₂ MLs, finding that the inherent OOP anisotropy of the CuPc molecule is enhanced upon adsorption on the HoAu₂ substrate, while it is attenuated on GdAu₂.

In order to characterize comprehensively our hybrid interfaces and the effect of the Gd and Ho atoms on their magnetic properties, we resort to X-ray absorption spectroscopy (XAS), X-ray magnetic circular dichroism (XMCD) and multiplet simulations. The CuPc/REAu₂ systems emerge as excellent candidates for this investigation, due to the weak chemical interaction of CuPc with the mentioned substrates GdAu₂ and HoAu₂ [31]. Hence, we can discard strong hybridization effects and new spinpolarized interfacial states as the source for the observed robust and anisotropic AFM exchange coupling.

II. RESULTS AND DISCUSSION

Monolayers (MLs) of HoAu₂ and GdAu₂ are used as substrates for the adsorption of CuPc molecules. Figure 1 (a) and (b) display STM images of the pristine HoAu₂ surface and the same covered by 1ML of CuPc. The latter is characterized by a flat and commensurated growth on top of the REAu₂ surface compounds [31]. Moreover, upon CuPc adsorption the representative Moiré lattice of the REAu₂ surfaces, formed by the lattice mismatch between Au(111) and and REAu₂ layers is still visible. We investigate the magnetic properties of the formed hybrid metal-organic interfaces CuPc/REAu₂ (RE = Gd, Ho) by XAS and XMCD. With that in mind, 0.7ML of CuPc was grown on top of both surface compounds. Spectra were recorded with circularly polarized light at the Cu $L_{2,3}$ and RE $M_{4,5}$ absorption edges in both out-of-plane (OOP) and in-plane (IP) geometries. In OOP, both magnetic field and X-rays are perpendicular ($\theta = 0^{\circ}$) to the surface, while in IP the magnetic field and the X-rays are nearly parallel ($\theta = 70^{\circ}$) to the surface. Additionally, X-ray linear dichroism (XLD) measurements were carried out on the adsorbed CuPc to investigate its orientation with respect to the plane of the substrate (see Methods).

A. Magnetic robustness of REAu₂ monolayers upon CuPc adsorption

GdAu₂ and HoAu₂ MLs display IP and OOP magnetic anisotropy, respectively, as determined by XMCD measurements [22, 23]. The IP anisotropy of GdAu₂ arises from a band anisotropy, extensively explored by DFT calculations [23]. In contrast, HoAu₂ displays an OOP anisotropy that results from the ${}^{5}H_{8}$ configuration of the Ho 4f orbital, as previously determined [22]. Before turning our attention to the effect of the molecular layer, we delve further into the HoAu₂ anisotropy by performing multiplet simulations of the experimental XMCD spectra. To this end, we have used a single-ion Hamiltonian that includes on the same footing Coulomb, spinorbit and Zeeman terms, together with a 3-fold symmetric crystal field (CF). The methodology is described in the Methods section and the Supporting Information [32] sections S3 and S4. Figure 1(c) shows the lowest-lying energy levels of the Ho J = 8 multiplet obtained after fitting the CF parameters to the experimental spectra at $\theta = 0^{\circ}$ and 70° incidences. We find that the ground state Ψ_0 is a doublet with $\langle J_z \rangle = \pm 5.8$ and the first excited state Ψ_1 is another doublet with $\langle J_z \rangle = \pm 4.7$, with an energy difference of 4.9 meV between them. For the second excited state Ψ_2 , which lies at a high energy of 38.7 meV, the $\langle J_z \rangle$ value becomes quenched by the quantum tunneling allowed by the 3-fold symmetry of the CF. This energy value is a measure of the strong OOP magnetic anisotropy of this system. This scenario of symmetryprotected magnetic bistability is qualitatively similar to that of Ho adatoms on Cu(111) [33], with the difference that the $\langle J_z \rangle$ quenching occurs for an energy larger by one order of magnitude in the HoAu₂ case, which benefits the bistability preservation. The reason for this difference in the level splittings is the intense CF felt by the Ho^{3+} ion embedded in the two-dimensional alloy structure (see Table S2).

Upon CuPc adsorption, the XMCD magnetization curves of both REAu₂ MLs suffer small changes that consist mainly in a slight reduction of the magnetization signal, but without significant anisotropy variations. A similar behavior has been reported for organic nanowires grown on GdAu₂ surfaces [34], where a decrease of ~ 5 K in the Curie temperature (T_C) was detected as well. The XMCD magnetization is proportional to the magnetic moment of the sample, but as it is element sensitive, this

value gives the magnetic response from the measured element, i.e. from the RE atoms. Fig. 1 displays the XMCD loops measured at the Gd and Ho M₅ absorption edges at IP and OOP geometries, before and after adsorption of 0.7 ML of CuPc. As we know from previous studies, CuPc molecules grown on HoAu₂ and GdAu₂ surfaces form densely packed physisorbed monolayers [31]. Therefore, we do not expect that the CuPc ML significantly alters the energy levels of the Ho^{3+} multiplet (Fig. 1 (c)) or the J = 7/2 multiplet of Gd³⁺. Under this assumption, the differences observed in the REAu₂ XMCD loops upon CuPc physisorption can be attributed to (i) the presence of a Cu-RE magnetic exchange interaction and (ii) subtle changes in the RE-RE RKKY interaction. The first effect, namely the Cu-RE exchange coupling, will be analyzed and discussed in detail below using the Cu L₃ intensities measured on CuPc/REAu₂ interfaces. Concerning the second effect, we recall that the RKKY exchange is mediated by itinerant electrons. To model the RKKY interaction, we have considered an effective magnetic field $B_{\rm eff}$ acting on the RE atoms with $B_{\text{eff}} = B + \hat{\gamma} \cdot \langle \vec{\mu}_{J,\text{RE}} \rangle$. The first term B represents the external field and the second term is a self-consistent field (a Weiss-like field) that accounts for the exchange interactions between the expected total magnetic moments $\langle \vec{\mu}_{J,\text{RE}} \rangle$ of the RE atoms. The $\hat{\gamma}$ tensor is anisotropic, in the sense that its components differ for magnetic moments aligned parallel or perpendicular to the surface (see section S5 of [32] for a numerical analysis of $\hat{\gamma}$ in bare REAu₂ substrates). In a previous study, we detected a non-negligible impact of the CuPc adsorption on the electronic structure of HoAu₂ and GdAu₂ MLs [31]. In fact, CuPc is physisorbed on these surfaces, but there is an energy shift of the RE(d)-Au(s) surface states of about 35 meV towards the Fermi level upon CuPc adsorption. The qualitative net effect of CuPc physisorption is a reduction of the self-consistent field in both substrates, i.e., an attenuation of the RKKY coupling, which may imply a reduction of the Curie temperature. This behaviour is consistent with the modification of magnetization curves upon CuPc adsorption observed in Fig. 1(d).

B. CuPc magnetic anisotropy on REAu₂ monolayers

X-ray linear dichroism (XLD) measured at the N K (see Supporting Information section S1) and Cu $L_{2,3}$ edges confirms the planar adsorption of CuPc molecules on REAu₂ surface alloys. Fig. 2(a) discloses the Cu $L_{2,3}$ XLD measurements carried out on the CuPc/GdAu₂ system. Due to the high background intensity arising from the Au substrate, long range EXAFS fluctuations are induced. Therefore, the copper transition is located on

top of a sinus-like curve (see inset) that is subtracted for better visualization. The white line shows a clear linear dichroism with a much larger intensity when \vec{E} is parallel to the surface plane. The main peak of the XLD pattern is assigned to the transition from the Cu $2p_{x,y}$ localized orbital into the singly occupied molecular orbital (SOMO) Cu $3d_{x^2-y^2}$ with spin S = 1/2 [35].

Next we measured XAS and XMCD at the Cu $L_{2,3}$

edge at 6 T and 0.5 T. Figs. 2(b) and (c) show the XAS and XMCD spectra corresponding to CuPc/GdAu₂ and CuPc/HoAu₂, respectively. An inversion in the sign of the XMCD signal at 0.5 T is detected, which indicates an antiparallel ordering of the Cu magnetic moment to the underlying REAu₂ substrates at low fields. The application of larger applied magnetic fields forces the Cu magnetic moment to rotate in the direction of the field due to the Zeeman effect. In order to study the magnetic anisotropy of the CuPc/REAu₂ interfaces, we have performed various XAS/XMCD measurements at different incidence angles of applied magnetic field/light direction. Fig. 2(d) shows the angular dependence of the normalized L_3 XMCD intensities at 6 T. The original XAS curves were normalized by a multiplying factor such that the background at the L_3 peak has always the same intensity. The normalized XMCD intensity η is then calculated as

$$\eta = \frac{I_+ - I_-}{\frac{I_+ + I_-}{2} - 1}.$$

On both substrates, the highest L_3 XMCD intensity is measured at OOP geometry ($\theta = 0^{\circ}$), where the CuPc magnetization is maximum. The same behavior has been observed on CuPc MLs and submonolayers adsorbed on Ag(100) or Au(110) surfaces [36-39]. This is due to the fact that both the quantum orbital momentum L_z and the spin dipole moment T_z of CuPc show a strong OOP anisotropy [36]. In this regard, we have calculated T_z and L_z values for the bare CuPc molecule (see section S6 of the Supplementary Material), identifying unequivocally the intrinsic OOP anisotropy character of the free molecule. The strong L_3 intensity variation between $\theta = 0^{\circ}$ and $\theta = 70^{\circ}$ observed in CuPc/HoAu₂ is remarkable and it is shown in Fig. 2(d). In the CuPc/GdAu₂ system this variation is clearly reduced. A fit of the data points by the angular dependence

$$\eta = \eta_{\perp} \cos^2 \theta + \eta_{\parallel} \sin^2 \theta \tag{2}$$

allows to determine the relation $\eta_{\perp}/\eta_{\parallel}$ for both systems CuPc/HoAu₂ and CuPc/GdAu₂ [37]. In the case of the $HoAu_2$ substrate this ratio results to be 11.5, while in the case of $GdAu_2$ is reduced to 4.0. Thus, it is evident that the HoAu₂ ML enhances the Cu L_3 signal at OOP geometry ($\theta = 0^{\circ}$), and thus promotes the intrinsic OOP anisotropy of the molecule, while GdAu₂ attenuates it. The sum rule analysis allows to extract from the XMCD data measured at 6 T the μ_L and μ_S^{eff} values at OOP $(\theta = 0^{\circ})$ and IP geometry $(\theta = 70^{\circ})$. Table I summarizes those values and their respective ratios in comparison with the theoretical ones for bare CuPc. The resulting ratios $\mu_L(0^\circ)/\mu_L(70^\circ)$ and $\mu_S^{\text{eff}}(0^\circ)/\mu_S^{\text{eff}}(70^\circ)$ confirm the strong OOP anisotropy of the CuPc/HoAu₂ system, and the importance of the match between anisotropy axes of substrate and molecule in order to get a more efficient magnetization of the molecular layer.

C. Anisotropic exchange between CuPc and $REAu_2$ substrates

The XMCD magnetization curves measured at the Cu L_3 edge of the CuPc/REAu₂ samples are shown in Fig. 3. These measurements probe the Cu magnetic moment M_{Cu} . Both systems display a similar trend, but with particular features that depend on the substrate and the direction of the applied magnetic field. At OOP geometry and low fields (below 1 T) the already observed AFM coupling between Cu and RE atoms is confirmed. It is worth to note that, in the case of the $CuPc/GdAu_2$ interface, $M_{\rm Cu}$ is slightly reduced compared to CuPc/HoAu₂. The former is related to the magnetization of the GdAu₂ surface, which in OOP geometry has a reduced magnetization at low fields, as it is seen in the XMCD loops of Fig. 1(e). The XMCD magnetization curves measured in IP geometry reveal that between 0 T and $2 \text{ T} M_{Cu}$ is zero or smaller than the experimental error in both systems. This behavior points out the relatively strong perpendicular anisotropy of CuPc, which hinders the polarization of $M_{\rm Cu}$ in the IP direction on both substrates. Nevertheless, at higher applied fields there is a change in the magnetization behavior due to the Zeeman interaction that induces the gradual rotation of $M_{\rm Cu}$ and allows a larger projection of $M_{\rm Cu}$ along the applied field direction and REAu₂ magnetization, although not reaching a full saturation in either IP or OOP directions.

We have modelled the CuPc magnetization curves on both REAu₂ substrates neglecting the molecule-molecule magnetic interactions. The huge anisotropy of the spin dipole moment T_z and effective spin moment μ_S^{eff} of CuPc is reflected in a strong attenuation of the XMCD L_3 peak intensity at IP geometry. By treating Cu²⁺ as a S = 1/2 Zeeman-split two level system, we obtain the expectation value

$$\langle \mu_{S,z}^{\text{eff}} \rangle (\mu_0 H) = \frac{1}{2} \tanh \frac{\mu_{S,z}^{\text{eff}} (\mu_0 H + \mathcal{J}_{ex} \langle \mu_{J,\text{RE},z}^{\text{eff}} \rangle)}{k_B T} \quad (3)$$

Here, the quantities to be adjusted are \mathcal{J}_{ex} , which represents the magnetic exchange between the Cu and RE atoms, and $\mu_{S,z}^{\text{eff}}$, which is the Cu saturated effective spin moment projection on the applied field $(\mu_0 H)$ direction. The substrate magnetization as a function of the applied field $\mu_0 H$ enters in the model as the calculated RE expected effective spin moment projections $\langle \mu_{IBE z}^{\text{eff}} \rangle$, shown in Fig. S4. This way, the model accounts for the anisotropic features of HoAu₂ and GdAu₂ surfaces. The experimental data fits to this model and the resulting \mathcal{J}_{ex} values are included in Fig. 3 as solid lines for OOP and IP geometry. The intensities have been normalized to the μ_S^{eff} values extracted from the sum rules values of Table I. The field at which $\langle \mu_{S,z}^{\text{eff}} \rangle$ cancels out is proportional to the AFM exchange coupling constants \mathcal{J}_{ex} between Cu and RE atoms. The low orders of magnitude of the fitted \mathcal{J}_{ex} (~ 0.01 meV/ μ_B^2) are consistent with the weak physisorption of CuPc on $REAu_2$ [31] and similar to those reported in the literature for $TbPc_2$ on Ni substrates [17]. The fits show a pronounced anisotropic behavior of the Cu-Ho exchange. The ratio between the exchange constants for IP and OOP applied fields in this case is $\mathcal{J}_{ex}^{\parallel}/\mathcal{J}_{ex}^{\perp} = 4.2$, whereas the Cu-Gd exchange is more isotropic with $\mathcal{J}_{ex}^{\parallel}/\mathcal{J}_{ex}^{\perp} = 1.1$. Similar strongly anisotropic interactions between metal-organic molecules and ferromagnetic substrates have also been reported for

To compare the data, the experimental intensities are normalized to the experimental $\langle \mu_S^{\text{eff},z} \rangle$ values obtained by sum rules analysis at 6 T (see Table I). The labels \mathcal{J}_{ex} indicate the Cu-Ho and Cu-Gd exchange coupling constants obtained from fits to Eq. 3.

Cu-tetraazaporphyrin on Fe_3O_2 [40] and $TbPc_2$ on oxidized and reduced Ni thin films [17]. In these systems the coupling follows a superexchange mechanism, where the organic ligands play a determinant role as intermediate orbitals for hopping [41-43]. These superexchange interactions show anisotropy as a consequence of spinorbit coupling [44, 45] [46], and this anisotropy is facilitated by the presence of states with orbital degeneracies, a mechanism known as orbital dependent exchange (ODE) [47–50]. This mechanism is relevant in the case of 3d - 3d and 4f - 3d exchange interactions in crystals and molecular magnets [51, 52]. In particular, in systems where the RE orbital moment L is unquenched, ODE is enhanced [50, 53-55]. Indeed, the analysis of Fig. 3 shows that the ODE effect is smaller for CuPc on $GdAu_2$ (L = 0) than on HoAu₂ (L = 6).

III. CONCLUSION

We have confirmed the AFM coupling stablished at the hybrid metalorganic interface between a CuPc monolayer and a ferromagnetic single atomic layer of REAu₂ (RE=Gd, Ho). The latter is set by a 3d-4f superexchange interaction between Cu and RE atoms. Moreover, this AFM coupling across the interface seems to be robust up to approximately 1.5 T. The natural OOP anisotropy of a CuPc ML is enhanced upon adsorption on the HoAu₂ substrate, which shows an OOP easy-axis of magnetic anisotropy. It is worth noting that CuPc molecules are physisorbed on REAu₂ surfaces and do not display strong hybridization or chemical interaction with the substrate. In this context, the aforementioned magnetic properties cannot be ascribed to the generation of a new spin-polarized interfacial state, as it is often the case in strongly hybridized spinterfaces. The use of RE atoms introduces strong spin-orbit effects that may promote a large anisotropic exchange coupling between the Cu and RE atoms. This is the case of the hybrid spin interface CuPc/HoAu₂, which displays an exchange interaction that is four times stronger for magnetic fields applied in IP geometry than in the OOP one, whereas CuPc/GdAu₂ exhibits isotropic exchange coupling. We explain this behavior by the orbital dependent exchange mechanism, which appears in systems with an unquenched orbital moment L, this is, states with an orbital degeneracy. The effect of anisotropic exchange coupling found in the hybrid interface CuPc/HoAu₂ arises as a relevant result for the development of magneto-resistive devices with extended functionalities, allowing a modulation of the coupling strength upon a 90° rotation of the external field. In conclusion, the stable AFM coupling at the metal organic interfaces of CuPc/REAu₂ can show a tunable anisotropic character, depending on the RE atom of the substrate, which represents a step forward in the field of molecular spintronics.

IV. METHODS

Samples have been prepared in an ultra-high vacuum (UHV) chamber at a base pressure of 2×10^{-10} mbar. Several Au(111) single crystals were used as substrates, that were cleaned by cycles of Ar^+ ion sputtering (E_{kin}) = 1 keV) and annealing to 500°C. The different RE-Au₂ surface compounds were grown *in-situ* by evaporation of small amounts of RE atoms on the Au(111) surface, held at a fixed temperature. The optimal growth temperature for the substrate is of 420° C for HoAu₂ and varies between 400-450°C for GdAu₂. Below these temperatures the characteristic Moiré was not well formed, and above them the RE metals start to diffuse into the bulk or re-evaporate from the surface. CuPc molecules have been evaporated on the REAu₂ surface with deposition rates of 0.05 ML/min. The calibration of the CuPc laver thickness was carried out by gradual depositions of CuPc/Au(111) and the subsequent low energy electron diffraction (LEED) analysis. The coverage of the first visible diffraction spots of the molecules at RT was defined as 0.9 ML [56]. The substrate temperature during CuPc evaporation was set to room temperature.

XMCD and XLD experiments were realized at the BOREAS beamline of ALBA synchrotron radiation facility in Spain. Absorption spectra were acquired in total electron yield at the Cu $L_{2,3}$ as well as Ho and Gd $M_{4,5}$ edges. XLD spectra were collected at room temperature at a incidence angle of 70° , rotating the light polarization from vertical (\vec{E} in plane) to horizontal (\vec{E} out of plane). XMCD spectra were acquired at different photon and magnetic field incidence angles (from $\theta = 0^{\circ}$ to $\theta = 70^{\circ}$) in order to study the magnetic anisotropy of the different interfaces. In out-of-plane (OOP) geometry the light propagation vector and the applied magnetic field are normal to the sample surface, while in in-plane (IP) geometry the magnetic field is nearly parallel to the surface. For the case of CuPc, 99% of circularly polarized light was used at the Cu $L_{2,3}$ edge, while rare-earth edges were acquired with 90% polarization. XMCD measurements were carried out at or below 4K with a variable magnetic field up to ± 6 T. The XMCD spectrum is the difference between the two x-ray absorption spectroscopy (XAS) spectra recorded with opposite orientation of the magnetic field and/or the circular helicity of the light, which we call I_+ and I_- for simplicity. The XMCD signal is proportional to the projection of the magnetization in the direction of the applied magnetic field. Element sensitive magnetization loops were measured by sweeping the photon energies corresponding to the maximum of the XMCD asymmetry signal at the Cu L₃, Ho and Gd M_5 absorption edges and a pre-edge energy as a function of the magnetic field. The latter was used for normalization and accounts for possible instabilities of the light entering the experimental station. Sum rules were used

to obtain orbital μ_L and effective spin μ_S^{eff} moments of CuPc at $\mu_0 \text{H} = 6 \text{ T}$ [57, 58]. The effective spin moment μ_S^{eff} refers to the measurable value of the expectation values of total atomic spin (S) and spin dipole T_z operators with $\mu_{\text{eff}}^S = 2S + 7T_z$. Both orbital and effective dipole momenta depend on the number of electron holes n in the d and f shell. For the elements considered here Cu, Ho, and Gd, we set as electron holes n = 1 in the Cu d-shell and n = 4 and 7 for Ho and Gd holes in the f-shell, respectively. The sum $\mu_L + \mu_S^{\text{eff}}$ was used to normalize the XMCD magnetization curves.

For a given $4f^n$ occupancy of the Ho ion the XAS and XMCD $M_{4,5}$ absorption edges spectra of the bare $HoAu_2$ substrate are simulated with the code Xclaim [59] by considering electronic transitions $3d \rightarrow 4f$ in a model Hamiltonian for the 4f orbital, where hybridization of 4f electrons is neglected. In this work, the crystal field parameters are optimized to match the simulated and experimental lineshapes of the I_+, I_- measured intensities at normal and grazing $(70^{\circ} \text{ off-normal})$ incidences. Four data sets are simulateously fit in an automated procedured, which is described in the Supplementary Material section S3 along with further details of the hamiltonian parameterization. From the hamiltonian eigenergies and eigenstates the expectation values $\langle J_z \rangle$ of the Ho³⁺ total magnetic moment projection on the field direction are calculated, which provide a model of the HoAu₂ magnetization curves. Similarly, using suitable crystal field parameters [60], a single ion hamiltonian for Cu^{2+} in CuPchas been written and diagonalized (see Supplementary Material section S6).

S1. PLANAR ADSORPTION OF CUPC MOLECULES ON REAU₂ SURFACES

X-ray linear dichroism (XLD) measurements at the N K edge (see Fig. S1) certainly confirm the planar adsorption growth of CuPc molecules on the REAu₂ surface alloys.



FIG. S1. XLD at the N $L_{2,3}$ edge at RT on (a) CuPc/GdAu₂ and (b) CuPc/HoAu₂ samples. Spectra were recorded with both, vertical (in red) and horizontal (in blue) polarized light at a fixed incident angle of 70°. The green one is the difference between the signals measured with horizontal and vertical polarized light.

S2. ANGULAR DEPENDENCE OF THE L₃ XAS AND XMCD INTENSITIES

As for CuPc layers on Ag(100) or Au(110) [1, 2], also in the case of CuPc on REAu₂ surface compounds, the molecular orbital associated to the Cu L_{2,3} transition presents a C_4 symmetry, see Fig. S2(a). Note that for orbitals having a C₄ symmetry rotation axis perpendicular to the substrate, $I_{\theta}^+ + I_{\theta}^-$ is expected to follow a function $f(\theta) = (1 + \cos^2\theta)/2$, as given by the mixing of two orthogonal linearly polarized components, one in plane and the other tilted by θ with respect to the molecular plane.

Fig. S2(b) displays the angular dependence of the L_3 XMCD intensity peak measured at the Cu_{L₂,3} edge for CuPc/HoAu₂ and CuPc/GdAu₂ at 6 T. The normalized L_3 XMCD intensities are plotted as a function of the applied magnetic field/light incidence angle. For comparison we add the normalized values of a 5 ML thick CuPc film, which represents a thick CuPc film that should not have a strong influence of the substrate. Note that these XAS and XMCD values are very similar to those of the submonolayer of CuPc grown on nonmagnetic Ag(100) [2]. For normalization purposes the original XAS curves were multiplied by a factor in a way that the background at the L_3 peak has always the same intensity. The normalized XMCD intensity η is the integral value of the intensities I_+ (I_-) of the L₃ peak obtained for right (left) circularly polarized light applying $\eta = 2 \cdot (I_+ - I_-)/(I_+ + I_-)$.



FIG. S2. (a) Sum of L₃ and L₂ peak XAS values as a function of θ . For orbitals having a C₄ symmetry rotation axis perpendicular to the substrate, $I_{\theta}^{+} + I_{\theta}^{-}$ is expected to follow a function $f(\theta) = (1 + \cos^2\theta)/2$. Note that, in order to compare spectra recorded at different angles and compensate for changes in the total electron yield, the raw data were first normalized to a common intensity value [2]; (b) normalized L₃ XMCD peak values as a function of θ for CuPc adsorbed on HoAu₂, GdAu₂, Au(100) and multilayers of CuPc on SmAu₂.

S3. MULTIPLET SIMULATION METHODS

For a given $4f^n$ occupancy of the Ho ion the XAS and XMCD $M_{4,5}$ absorption edges spectra are simulated by considering electronic transitions $3d \rightarrow 4f$ in the model hamiltonian for the 4f orbital

$$\mathcal{H} = \mathcal{H}_{Coulomb} - \lambda \mathbf{L} \cdot \mathbf{S} + \mathcal{H}_{CF} + \mu_B (\mathbf{L} + 2\mathbf{S}) \cdot \mathbf{B}$$
(1)

where the terms account for the intraatomic Coulomb interactions, spin-orbit coupling (SOC), crystal field (CF) potential and Zeeman term, respectively. The latter term can be also expressed as $H_Z = \mu_B g_J \mathbf{J} \cdot \mathbf{B}$, where the external field \mathbf{B} acts on the total magnetic moment and g_J is the Landé factor ($g_J = 4/5$ for Ho³⁺). Hybridization of 4f electrons is neglected, as ARPES experiments show that 4f bands in HoAu₂ are non-interacting [3]. Each setting of parameters defines a hamiltonian for the 4f orbitals and thus determines the many-electron ground state (GS) and excited states (ES). These are obtained using the computer code Xclaim [4], together with the simulated XAS and XMCD spectra by applying the Fermi golden rule to the hamiltonian eigenstates after broadening the energy levels. The CF parameters are optimized by trial and error to match the simulated and experimental lineshapes.

In this work we express the CF parameters in the Wybourne (B_{kq}) and Stevens (B_q^k) conventions [5]. Other parameters used in the multiplet simulations (standard atomic Hartree-Fock data [6] and characteristic energies in the lineshapes) are given Table S1. Note that, in order to diagonalize the hamiltonian numerically, a small magnetic field is needed. We use 0.01 T.

In the HoAu₂ case the spectral lineshapes are governed by the CF to a great extent, as proven by the the strong dependence on the incidence direction. Taking advange of this observation, we use c+ and c- measured intensities instead of XAS and XMCD curves in the analysis. Thus, for a given set of the other parameters, we make an automated search of the CF parameters to minimize a cost function that *simultaneously* fits the four sets of data, namely the c+ and c- spectra obtained at normal and grazing (at 70° off-normal) incidences. This minimization is carried out by simulated annealing and simplex algorithms [7], where a cost function χ^2_{LD} is defined in terms of the logarithmic derivatives of the energy

Here $L^{\perp(\parallel)}$ are the logarithmic derivatives of the spectra for normal (grazing) incidences calculated numerically for each curve, the subindex e(t) indicates experimental (theoretical) spectra, $c^+(c^-)$ indicates right (left) handed light spectra, and E_i run over the discrete energy data points at the regions of the spectrum where the XAS peaks lie. The rationale behind the use logarithmic derivatives in the cost function is to account numerically for the coincidence of maxima, minima, and elbows in the spectra, rather than compare bare absolute intensities directly, in the same spirit as R-factors are used in the analysis of low-energy electron diffraction intensities [8]. In order to compare individual lineshape intensities, the spectra are first normalised by setting the maximum intensity out of the four theoretical and experimental spectra to a value equal to one. The magnetic field acting on the total quantum angular momentum **J** is an effective field contributed by the applied external field **B** and the internal exchange field due to interactions between the Ho magnetic moments in the HoAu₂ monolayer. The XAS lineshapes will be fitted without the internal field. This contribution will be determined later on by fitting the magnetization curves of $\text{Ho}^{3+} - 4f$.

Once the CF parameters are optimized, the expected total magnetic moment of Ho³⁺ projected on the applied field direction at the experimental temperature T = 4 K is given by

$$\langle \mu_z^J \rangle = \frac{1}{Z} \sum_i \mu_z^J e^{-E_i/k_B T} \tag{4}$$

where Z is the partition function and the sum runs over the eigenstates and eigenergies obtained from diagonalization of the hamiltonian Eq.1.

S4. X-RAY SPECTRAL ANALYSIS OF THE HoAu₂ SUBSTRATE: Ho³⁺ MULTI-PLETS

The possibility of a Ho^{2+} valence state can be dismissed, as the basic features of the X-ray spectra it yields differ from the observed ones (see Fig. S3 left-hand panels) [9]. Therefore, in the following we focus the analysis on Ho^{3+} . Since the D_{6h} symmetry of the HoAu₂ monolayer is broken by the moiré pattern formed on the substrate, the Ho atoms are subject to a C_{3v} CF that varies spatially with the local stacking. Being X-ray absorption spectroscopy a space-averaged technique, the fitted parameters are to be interpreted as those of an effective 3-fold symmetric CF. In particular, a trigonal symmetry implies that there are crossed CF terms, namely those corresponding to the B_{43} parameter. These terms provide the Eq. 1 eigenstates with a mixed $|J_z\rangle$ character that eventually makes magnetic moments unstable under quantum transitions [10]. In a initial run, the Wybourne B_{20}, B_{40} , and B_{43} parameters are fit according to the procedure described in section S3. An ampliation of the search space to the higher-order parameters B_{30}, B_{60}, B_{63} does not improve the quality of the fit and is thus not considered in the analysis. The best-fit CF parameters are listed in Table S2 (see also Table S1 for further parameters of the hamiltonian). The right-hand panels of Fig. S3 show that there is good agreement between the experimental and simulated spectra.

Diagonalization of the spin Hamiltonian for this CF at a small zero external field (0.01 T)

shows that the ground state Ψ_0 and the lowest-energy excited states $\Psi_i(i > 0)$ of Ho³⁺ belong to the J = 8 multiplet (states with $J \neq 8$ contribute < 5%). Their quantum numbers and decomposition into $|J_z\rangle$ states are summarized in Table S3 and the eigenenergies are shown in Fig. 1(c) of the main paper.

 Ψ_0 is a doublet with a configuration lead by ± 8 states and $\langle J_z \rangle \simeq \pm 6$, in agreement with previous sum rules analyses [3]. The first excited state Ψ_1 at 4.9 meV is another doublet lead by a ± 7 state. As the 3-fold symmetric CF terms mixes terms $|J_z \pm 3\rangle$, the projection $\langle J_z \rangle$ cannot be quenched by quantum tunneling transitions, as it is the case of Ho/Cu(111) [10]. Such quenching scenario occurs for Ψ_2 , which lies much higher in energy (38.7 meV).

This electronic structure conferes the HoAu₂ a strong out-of-plane anisotropy and magnetic bistability to individual $\operatorname{Ho}^{3+} - 4f$ momenta. Note that the $\langle J_z \rangle$ quenching, due to a $|\pm 6\rangle$ state, happens in Ho/Cu(111) at 2.4 meV in Ho/Cu(111) [10] and even at the GS of Ho/Pt(111) [10–12]. The main difference with respect to the adatom geometry is that the two-dimensional alloy structure conferes a more intense crystal field to Ho^{3+} (see Table S2). In particular, the anisotropy-related parameter B_{20} is larger by one order of magnitude and B_{43} by two orders.

S5. MAGNETIZATION CURVES OF THE PRISTINE HoAu₂ AND GdAu₂ SUB-STRATES

As described in the previous section, the 4f orbital of Ho³⁺ conferes a pronounced perpendicular single-ion anisotropy (SIA) character to the behaviour of HoAu₂. The HoAu₂ magnetization curve is modelled with Eq. 4 adding an extra Zeeman contribution to each eigenergy in the form of a self-consistent Weiss mean-field, which accounts for the RKKY exchange interactions between the Ho³⁺ total momenta **J** mediated by itinerant *d*-electrons. The effective field acting on them is

$$\mathbf{B}_{eff} = \mu_0 \mathbf{H} + \hat{\gamma} \cdot \langle \vec{\mu}_J \rangle \tag{5}$$

where the tensor $\hat{\gamma}$ is fitted to the M_5 peak intensity as a function of the applied field $\mu_0 \mathbf{H}$, which can be considered as the experimental magnetization curves. Due to the exchange interaction anisotropy within the HoAu₂ monolayer, the $\hat{\gamma}$ tensor components are different for moments aligned parallel and perpendicular to the surface (γ_{\parallel} and γ_{\perp} , respectively). These parameters are fitted to match overall the experimental curves, normalized to the $\mu_{J,z}$ values (the subindex z indicates the projection along the applied field direction) extracted from the XAS and XMCD sum rules in Ref. [3], 8.3 and 4.14 μ_B for perpendicular and grazing incidences, respectively. γ_{\perp} is extracted from the normal incidence data and kept fixed in the fit of the grazing incidence data, where γ_{\parallel} is obtained. The results are shown in Fig. S4. Although the *d*-band effect on the exchange is at play, too, the SIA effect is the dominant one, as reflected by the $\hat{\gamma} = 0$ result, shown by the dashed lines in Fig. S4.

For the GdAu₂ case we only consider the exchange anisotropy in the modelling. Here the magnetization curves are well described simply by the Brillouin function for B_{eff} fields (Eq. 5) and J = 7/2, albeit with significant exchange anisotropy: an intense ferromagnetic Weiss field is needed to fit the grazing incidence curve, while its contribution at normal incidence is almost negligible (see Fig. S4). Note that the linear regime in the experimental $\theta = 0^{\circ}$ curve persists until 2.5 T, where saturation is almost complete. This feature, not captured by our model, might be due to magnetic domain effects.

S6. ANISOTROPY OF THE BARE CuPc MOLECULE

The planar symmetry of the singly-occupied $d_{x^2-y^2}$ orbital of CuPc protects its spin S = 1/2 [13, 14] upon adsorption of monolayers or submonolayers of CuPc on several metallic surfaces. Despite the S = 1/2 character, both CuPc MLs and thin layers display a pronounced out-of-plane anisotropy, which is originated from the strong out-of-plane anisotropy of its orbital momentum and spin dipole operator projections on the field direction, L_z and T_z , respectively. This results in a significant attenuation of the spin effective moment $\mu_{eff}^S = 2S + 7T$ at grazing incidence [1, 2, 15].

The crystal field for the Cu²⁺ ion in CuPc is established by the *d*-orbital energy levels. For the free molecule, we take these levels from calculated optical transitions in Ref. [13]: $\epsilon(d_{x^2-y^2}) - \epsilon(d_{z^2}) = 3.48 \text{ eV}, \epsilon(d_{z^2}) - \epsilon(e_g) = 0.15 \text{ eV}, \text{ and } \epsilon(e_g) - \epsilon(d_{xy}) = 0.40 \text{ eV}.$ By exact diagonalization of the Cu²⁺ single-ion Hamiltonian with a CF given by these parameters, we find that the ground state with S = 1/2 has non-negligible L_z and, most important, a significant T_z at normal incidence. The variation of these quantum numbers with the

polar angle of incidence is shown in Fig. S5, both the T = 0 K saturation values and the expected ones at a 6 T field with T = 4 K. The bare molecule T_z and $\mu_{eff}^{S,z}$ values are larger than when adsorbed on Ag(001) [2], HoAu₂ and GdAu₂ (this work, Table I) which suggests that, although the CuPc anisotropy is reduced, the out-of-plane easy axis of magnetization is preserved upon adsorption in planar physisorbed configurations.

S7. MAGNETIC MOMENTS OF CuPc ADSORBED ON HoAu₂ AND GdAu₂
