Canonical Quantization of the U(1) Gauge Field in the Rindler Coordinates

Abstract

This paper describes the canonical quantization of the U(1) gauge field across all four regions in the Rindler coordinates in the Lorentz covariant gauge. In the four regions (future, past, left and right Rindler-wedges) in the Rindler coordinates, defining the gauge-fixed Lagrangian in the Lorentz covariant gauge, which is composed of the U(1) gauge field, the *B*-field and ghost fields. Since the U(1)gauge and *B*-fields are decoupled from the ghost fields by the property of the U(1)gauge theory, the U(1) gauge field and the *B*-field are examined in this study.

Then, by solving the equations of motion obtained from the gauge-fixed Lagrangian, the solutions of each mode of the U(1) gauge field and the *B*-field can be obtained. Following this, with the Klein-Gordon inner-product defined in the Rindler coordinates, the normalization constants of each of those mode-solutions are determined.

Subsequently, formulating the canonical commutation relations of the U(1) gauge field and its canonical conjugate momentum, the commutation relations of the coefficient of each mode-solution in each direction of the U(1) gauge field in each region of the Rindler coordinates are obtained. From these, it can be seen that those coefficients have physical meaning as creation/annihilation operators. The polarization vectors in each region of the Rindler coordinates are also given in this study.

From these, it is shown that the Minkowski ground state can be given as the outer-product of the quantum states multiplied by the creation operators of the U(1) gauge field in the left and right Rindler-wedge states. Then, obtaining the density matrix of the U(1) gauge theory in the right Rindler-wedge from that, it is shown that the U(1) gauge field in the constant accelerated system feels the Unruh temperature as well.

1 Introduction

From the analysis of the uniformly accelerated motion, the Unruh temperature is derived as $T_U = \hbar a/2\pi ck_B \approx 4 \times 10^{-23} a/(cm/s^2)$ [K] [1, 2, 3]. Since the Unruh temperature which can currently be produced is less than 3[K] CMB, its detection remains extremely challenging. While detecting the Unruh temperature is a technologically important issue. It is also important as experimental confirmation of Hawking radiation, and in terms of the problem of how an event which is observed in the accelerated systems can be observed in an inertial system.

Recent studies in the experimental field have touched upon the following topics: BEC [4], neutrino oscillation [5, 6, 7], anti-Unruh effect [8, 9, 10, 11], cold atoms [12, 13], Berry phases [14, 15], Casimir effect [16], classical analog [17] and others [18, 19].

In addition, the effects of the thermal excitation of the Unruh effect on the phenomena currently reproducible in the laboratory have been analyzed as follows: analysis of critical temperatures of the phase transitions [20, 21, 22, 23]; analysis of the thermal radiation from a particle in constant accelerated motion [24, 25][26, 27, 28]; analysis of the Schwinger effect in a constant accelerated systems [34, 35]; and analysis of quantum corrections in the energy-momentum tensors of gases in constant accelerated systems [29, 30, 31]. Additionally, the Hagedorn transition in string theory due to the Unruh effect has also been analyzed [36].

Theoretically, the coordinates of a constant accelerated motion are generalized to the Rindler coordinates, which is equivalent to the geometry in the neighborhood of the event-horizon of the Schwarzschild black hole, and in which the Killing horizons exist. Therefore, the thermal radiation and the entropy akin to the Hawking radiation and the Bekenstein-Hawking entropy, respectively, can be considered in the Rindler coordinates. In addition, since the Rindler coordinates is the issue of the coordinates, it can be considered at any points in the spacetime based on the general coordinate transformation invariance. Exploiting these properties of the Rindler coordinates, it can be shown that Einstein's equation can be derived as a state equation at any point in spacetime [37].

Furthermore, since spacetime is causally separated by the Killing horizon in the Rindler coordinates, quantum entanglement arises between those regions in the Rindler coordinates. Analysis of the entanglement entropy (EE) between the separated regions in the Rindler coordinates has been performed in many studies, and as a result, the area-proportional low is obtained, based on which the suggestion that the Bekenstein-Hawking entropy would be a kind of EE between the inside and outside of the black hole can be obtained [38, 39, 40].

In addition, the Rindler coordinates are extended to the AdS space: the Unruh temperature in the AdS space has been given in [41], and the AdS/CFT given with the AdS space patched by the Rindler coordinates has been studied in [42, 43, 44].

In terms of studies on the properties of the Rindler coordinates, the following studies seem particularly intriguing: the upper bound for acceleration [45] and another on inversion between the bosonic and fermionic statistics occurring in the odd dimensional Rindler coordinates [46]. A review of the literature shows that until now, the canonical quantization (CQ) of the gauge fields in the Rindler coordinates has not been properly performed yet, while that of scalar and spinor fields has been done [47][48, 49]. Studies treating the U(1) gauge field in the Rindler coordinates can be found as cited in [50]. However, in these studies, the normalization constants (NC) of the mode-solutions contain some speculation and have not been obtained exclusively from the analysis, or the discussion proceeds without the NC. Furthermore, it appears that the solutions for the gauge field in all of the directions in spacetime have not been explicitly obtained.

The NC have not been determined until now likely because the integrals in Appendix.B in this study could not be calculated. Since those integrals appear in the Klein-Gordon (KG) inner-products between the mode-solutions of the U(1) gauge field in the Rindler coordinates, what those integrals cannot be calculated leads to the following four situations; 1) their NC cannot be determined, 2) accordingly, the canonical commutation relations (CCR) cannot be robustly formulated (it is possible to formally write down the CCR, if the form of the KG inner-product is known^{*}; however, since the mode-solutions of the field are not completely determined due to the lack of the NC, the concrete CCR, the CCR for each mode-solution, cannot be completely known), 3) analysis performed using the KG inner-products cannot be done without ambiguities or speculation, and 4) the creation/annihilation operators cannot be taken out. All of these would finally lead to the first situation mentioned.

In these situations, we will calculate the integrals as demonstrated in Appendix.B. Subsequently, utilizing these integrals, we determine the normalization constants (NC) of the mode-solutions of the U(1) gauge field across all directions of spacetime within each of the four regions: future, past, left, and right Rindler-wedges (see Fig.1). This determination is based on the condition that all mode-solutions are mutually orthonormal under the Klein-Gordon (KG) inner-product. In this study, these mode-solutions of the U(1) gauge field are obtained by solving the equations of motion derived from the Lagrangian formulated in the Lorentz-covariant gauge within the Rindler coordinates.

Next, by formulating the CCR of the U(1) gauge field within each of the four regions in the Rindler coordinates, we examine the U(1) gauge field within these CCR using the mode-expanded form based on the normalized mode-solutions we have obtained. Subsequently, employing the Klein-Gordon (KG) inner-product, we derive the commutation relations of the creation/annihilation operators for the coefficients of the mode-solutions of the U(1) gauge field.

Subsequently, we demonstrate that the Minkowski ground state manifests as a quantum entangled state of the left and right Rindler-wedges, excited by the creation operators of the U(1) gauge field. By deriving the density matrix from this entangled state, we illustrate that the U(1) gauge field within a constant accelerated system will also experience the Unruh temperature.

The following section discusses the organization of this paper. In Sec.2, the Rindler

coordinates used in this study are reviewed. In Sec.3, the Lagrangian of the U(1) gauge theory in the Lorentz covariant gauge in the Rindler coordinates is obtained. In Sec.4, the mode-solutions of the U(1) gauge field and the *B*-field in each region in the Rindler coordinates and their normalization constants are obtained.

In Sec.5, the canonical quantization of the U(1) gauge field is computed for each region in the Rindler coordinates, through which the commutation relations which the coefficients of each mode-solution satisfy are finally obtained. From this, it can be confirmed that the coefficients of the each mode-solution have roles as creation/annihilation operators in each region in the Rindler coordinates.

In Sec.6, we address the creation/annihilation operators of the U(1) gauge field, providing the polarization vector for (S, L, \pm) -directions. From the expression of this vector, it becomes apparent that the region where the polarization vector can be defined is constrained within each region, as the norms of the 1-particle states in the S- and L-directions can potentially be negative. The origins of these restrictions and their implications are discussed.

In Sec.7, the density matrix of the U(1) gauge field in the right Rindler-wedge is obtained. Regarding each subsection, in Secs.7.1 and 7.2, $\boldsymbol{a}_{\vec{q}}^{(\mathrm{M})\perp}$ is obtained in terms of $\boldsymbol{a}_{\vec{q}}^{(\mathrm{R})\perp}$ and $(\boldsymbol{a}_{\vec{q}}^{(\mathrm{R})\perp})^{\dagger}$ by analyzing the Bogoliubov coefficients ($\boldsymbol{a}_{\vec{q}}^{(\mathrm{M})\perp}$ and $\boldsymbol{a}_{\vec{q}}^{(\mathrm{R})\perp}$ represent the annihilation operators in the Minkowski and Rindler coordinates, respectively). In Sec.7.3, from the condition $\boldsymbol{a}_{\vec{q}}^{(\mathrm{M})\perp}|0_{\mathrm{M}}\rangle = 0$, the ground state in the Minkowski coordinates is constituted by the Rindler states, from which in Sec.7.4, the density matrix is obtained and it is shown that the U(1) gauge field in a constant accelerated system will also feel the Unruh temperature.

In Sec.8, summarizing this study, the future directions of the study are discussed. In Appendix.A, the analysis from (42) of the Lagrangian to the Lagrangian in the Lorentz-covariant gauge (18) is noted. In Appendix.B, the integral formulas, which are essential for the calculations of the KG inner-products to obtain the NC in Sec.4.3, are given.

2 The Rindler coordinates used in this study

In this section, we review the Rindler coordinates used in this study.

2.1 ds^2 in the each region in the Rindler coordinates

We begin with the 4-dimensional Minkowski spacetime:

For the Minkowski coordinates in (1), we consider the following four coordinate transformations:

where

• the regions which are transformed to by (2a) and (2b) are the left and right Rindlerwedges (LRW and RRW), respectively, and the regions transformed to by (2c) and (2d) are the future and past Rindler-wedges (FRW and PRW), respectively.

On the left and right in Fig.1, the LRW/RRW and FRW/PRW are shown, respectively.

- We have used (τ, ξ) , $(\tilde{\tau}, \tilde{\xi})$, (ζ, η) and $(\tilde{\zeta}, \tilde{\eta})$ as the coordinates in the LRW, RRW, FRW and PRW respectively, as shown in Fig.1.
- In the Rindler coordinates, *a* is considered to be fixed.
- In the LRW and RRW, there are world-lines of the constant accelerated motion; ξ and $\tilde{\xi}$ label those, and τ and $\tilde{\tau}$ parametrize them.

On the other hand, in the FRW and PRW, it is assumed that there is no object performing constant accelerated motion. However, in the FRW and PRW, the lines labeled by η and $\tilde{\eta}$ and parametrized by ζ and $\tilde{\zeta}$ exist as lines analogous to the world-lines in the LRW and RRW, which are plotted in Fig.1.

Applying (2) to (1), ds^2 in each region can be obtained as follows:

where $x^{\perp} \equiv (x^2, x^3)$.



Figure 1: These figures represent the Rindler coordinates on the Minkowski coordinates. The coordinates in each region are defined in (3) and (5). On the left, those of LRW and RRW are represented, and in the right, those of the FRW and PRW are represented. (U, V) are the light-cone coordinates defined in (9), and "the $\xi \to -\infty$ line" (and other three) are defined in Sec.2.4, which are generally referred to as the Killing horizon.

Now, let us introduce ρ defined as follows:

Considering this ρ , ds^2 in (3) can be given as follows:

From the above expressions, it can be seen that the τ - and $\tilde{\tau}$ -directions are the Killing vectors in the RRW and LRW, and the ζ - and $\tilde{\zeta}$ -directions are the Killing vectors in the FRW and PRW. Therefore, in the RRW and LRW, the Hamiltonians are defined for the $\tilde{\tau}$ - and τ -constant surfaces and in the FRW and PRW, the Hamiltonians are defined for the ζ - and $\tilde{\zeta}$ -constant surfaces. Therefore, in the Rindler coordinates in the RRW and LRW, $\tilde{\tau}$ and τ coordinate play the roles of the time, and in the Rindler coordinates in the FRW and PRW, the FRW and PRW, the $\tilde{\zeta}$ and ζ coordinates play the roles of time.

As mentioned above, since ζ and τ play the role of time in the FRW and RRW, respectively, we perform the Euclideanization as $\tau \to -i\tau$ and $\zeta \to -i\zeta$ in (5). As a result, the ds^2 of the RRW and FRW in (5) are written as follows:

where $ds_{\rm E}^2 = -ds^2$. It can be seen that in (6), the τ - and ζ -directions are periodic by $\beta = 2\pi/a$, the inverse of which agrees with the Unruh temperature in the constant accelerated system with a. For the LRW and PRW, the Euclideanization is performed in the same way as for the RRW and FRW, and the same Unruh temperature can be obtained in the LRW and PRW.

2.2 Solutions in the LRW (PRW) from the solutions in the FRW (PRW)

If the solutions in the FRW and RRW are known, solutions in the LRW and PRW, which are parity-symmetric, can be immediately obtained. In this subsection, this is discussed.

If a vector solution in the FRW is known, denoting it as $f^{\mu}(\zeta, \eta)$, it can be seen from (2) and Fig.1 that the vector solution in the PRW being in a party-symmetric relation with $f^{\mu}(\zeta, \eta)$ for the $x^0 = 0$ line can be obtained simply by exchanging (ζ, η) to $(\tilde{\zeta}, \tilde{\eta})$ leaving the forms of the functions of the solutions as

For the solution in the FRW to obtain the solution in the PRW:

In the same way, denoting as $g^{\mu}(\tau,\xi)$ for a given vector solution in the RRW, the party-symmetric vector solutions in the LRW for $g^{\mu}(\zeta,\eta)$ for the $x^1 = 0$ line can be obtained simply by exchanging (τ,ξ) to $(\tilde{\tau},\tilde{\xi})$ as:

For the solution in the RRW to obtain the solution in the LRW:

2.3 Light-cone coordinates

We define the light-cone coordinates as:

where x^0 and x^1 are the Minkowski coordinates in (1). We show these in Fig.1, from which we can see that

Based on (2a) and (2b), we can represent U and V in terms of the LRW and RRW coordinates $(\tilde{\tau}, \tilde{\xi})$ and (τ, ξ) as follows:

2.4 The lines asymptotically approached to by taking ξ , η , $\tilde{\xi}$ and $\tilde{\eta}$ closer to $-\infty$

2.4.1 The lines at ξ closer to $-\infty$

Let us consider taking ξ in (2b) closer to $-\infty$. Then, let us take $|\tau|$ to ∞ and refer to the lines asymptotically approached to at that time as "the $\xi \to -\infty$ line". Note that the exact limit taking ξ to $-\infty$ is excluded by the definition of the Rindler coordinates.

Then, at any points on $x^0 > 0$ or $x^0 < 0$ on the $\xi \to -\infty$ line, it can be seen that τ and ξ in (2b) should be related as

$$|\tau| \sim |\xi|,\tag{12}$$

otherwise, on the $\xi \to -\infty$ line, neither t nor x^1 can be finite (therefore, the motion of the object on the $\xi \to -\infty$ line in the finite τ is all packed into the neighborhood of $x^0 = 0$). This can be seen from the forms of x^0 and x^1 in $(2b)^{\dagger}$.

Therefore, on the $\xi \to -\infty$ line, since $|\tau|$ approaches ∞ , $x^0/x^1 = \tanh(a\tau)$ approaches ± 1 . The lines obtained by the $x^0/x^1 = \pm 1$ are the ± 45 -degree straight diagonal lines in the $x^1 \ge 0$ region in Fig.1.

These ±45-degree straight diagonal lines are generally referred to as the past and future Killing horizons for $x^0 < 0$ and $x^0 > 0$, respectively. In this paper, we refer to the lines obtained by taking ξ closer to $-\infty$, which asymptote to those ±45-degree straight diagonal lines, as "the $\xi \to -\infty$ line", as noted on the lefthand side of Fig.1.

2.4.2 The lines at η closer to $-\infty$

By the same logic in Sec.2.4.1, when η in (2c) is taken closer to $-\infty$, it can be seen that η and ζ should be related as follows:

and $x^0/x^1 = \tanh(a\zeta)$ asymptotes to ± 1 .

The lines given by these $x^0/x^1 = \pm 1$ are the ± 45 -degree straight diagonal lines in the $x^0 \ge 0$ region in Fig.1, where -1 and +1 correspond to the left and right future Killing horizons respectively.

 $^{\dagger}x^{0}$ and x^{1} in (2b) can be roughly written as

Then, on the $\xi \to -\infty$ line, if (12) is satisfied, x^0 can take finite values behaves as follows:

where " $\xi \sim \mp \tau$ " mean that $|\xi|$ and $|\tau|$ are in the same order. x^1 also can take finite values on the $\xi \to -\infty$ line, if (12) is satisfied, by the same logic.

In this paper, we refer to the lines obtained by taking η closer to $-\infty$ as "the $\eta \to -\infty$ line", which asymptote to those ±45-degree straight diagonal lines, as noted on the righthand side of Fig.1.

2.4.3 The lines at $\tilde{\tau}$ or $\tilde{\eta}$ closer to $-\infty$

By the same logic in Secs.2.4.1 and 2.4.2, we refer to the lines obtained by taking $\tilde{\tau}$ and $\tilde{\eta}$ closer to $-\infty$ as "the $\tilde{\tau} \to -\infty$ line" and "the $\tilde{\eta} \to -\infty$ line", respectively, as noted in both sides of Fig.1.

3 The Lorentz covariant U(1) gauge field Lagrangians in the Rindler coordinates

In this section, the Lagrangian densities (referred to as the Lagrangian) of the U(1) gauge field in the Lorentz-covariant gauge in the four regions in the Rindler coordinates are obtained. Since the analysis to obtain the Lorentz covariant U(1) gauge field Lagrangian in the LRW and PRW can be performed in the same way as those in the FRW and RRW, this section mainly focuses on the analysis concerning the FRW and RRW. The result is noted in (18).

First, let us begin with the actions of the U(1) gauge field in each of the four regions in the Rindler coordinates:

where the integral region is the RRW, FRW, LRW or PRW given by the coordinates in (5), and ∇_{μ} are covariant derivatives given by the metrices (5), and $F_{\mu\nu} = \nabla_{\mu}A_{\nu} - \nabla_{\nu}A_{\mu} = \partial_{\mu}A_{\nu} - \partial_{\nu}A_{\mu}$.

The Lagrangian in the Lorentz-covariant gauge given by $\partial_{\mu}A^{\mu} = 0$ in the Minkowski coordinates is known to be given as

where B is the auxiliary field (the B-field) and c, \bar{c} are the ghost fields. From this, we are able to derive the Lagrangian in the Lorentz-covariant gauge in each of the four regions in the Rindler coordinates by replacing the differentials with the gravitational covariant derivatives as

$$\tilde{\mathcal{L}}_{U(1)}^{(R)} = \mathcal{L}_{U(1)} + B \,\nabla_{\mu} A^{\mu} + B^2 / 2 + i \, \bar{c} \,\nabla_{\mu} \nabla^{\mu} \, c, \tag{18}$$

where the coordinates in the one above refer to those in (5).

However, since (17) is derived through the Lagrangian gauge-fixed by the Coulomb gauge (a non-covariant gauge), we will check if (18) can be obtained in the Rindler coordinates in the following subsection. As noted earlier, in the following subsections, we mainly focus on the analysis concerning the FRW and RRW.

Upon performing the analysis to obtain (18) in the following subsections, we note the values of the Christoffel's in each region in the Rindler coordinates:

•
$$\Gamma_{01}^0 = \Gamma_{10}^0 = \rho^{-1}$$
, $\Gamma_{00}^1 = a^2 \rho$, others = 0 in the RRW and LRW, (19a)

Let us now evaluate the rationale behind solely considering A_{μ} and B in this study. In this study, the U(1) gauge field is considered. In such a case, the Faddeev-Popov determinant (FPd) does not include the gauge field (as indicated in (143)). As a result, the partition functions of the ghost and the gauge fields decouple each other as $Z = Z_{A_{\mu},B} Z_{c,\bar{c}}$. Therefore, we may consider only A_{μ} and B. With this in mind, let us focus only on A_{μ} and B in the subsequent discussion.

3.1 The Hamiltonian in the RRW and FRW

Beginning with $\mathcal{L}_{U(1)}$ in (16), the dynamical variables are A^{μ} , and x^{0} and x^{1} play the role of the time-coordinate in the FRW and RRW, respectively, as mentioned under (5). Therefore, the canonical conjugate momenta in the RRW and FRW are derived as follows:

where $k = 1, \perp$ in RRW and $k = 0, \perp$ in the FRW (in what follows, the indices written in lower case Latin alphabets refer to this). When π_k are defined as above, π^k are given as follows:

 π_k and π^k have physical meaning as the electric field:

• $\pi_k = E_k, \quad \pi^k = E^k$ in the RRW, (22a)

• $\pi_k = E_k, \quad \pi^k = E^k$ in the FRW. (22b)

As the electric fields have been defined, let us define the magnetic field in each region:

 in the FRW, (23b)

where k in B_k is the same as that in B^k in (23a) and (23b), respectively. Since $i, j, k = 1, \perp$ and $= 0, \perp$ in the RRW and FRW respectively, it can be seen that $\varepsilon^{ijk} = -\varepsilon_{ijk}$ in the RRW, and $\varepsilon^{ijk} = \varepsilon_{ijk}$ in the FRW.

Regarding (20)-(23), the Lagrangian (16) can be written as

•

where $B_k^2 = B_k B^k$ (E_k^2 , E_0^2 and E_{\perp}^2 are likewise), and g_{00} and g_{11} refer to those in (5). The first term in the r.h.s. of (24a) can be rewritten as

where in the calculation (25a), expressing E^k as F^{k0} , we have used $\nabla_k A^0 = (\sqrt{-g})^{-1} \partial_k (\sqrt{-g} A^0)$ and assumed the boundary condition that the fields vanish at the infinite far region which is given by ξ or η to ∞ . By that boundary condition, $\int_{\text{RRW}} d^4x \, \partial_k (F^k{}_0 \sqrt{-g} A^0)$ vanishes (note that as can be seen from (3), the coordinates of the RRW and FRW reduce to the Minkowski coordinates by $a \to 0$, but do not by ξ or η to ∞). The calculation of (25b) has been performed likewise. We perform these rewritings of (25) to change the coefficients of A_0 and A_1 to numbers for the convenience in the calculation (38).

With (25a) and (25b),

With (26), the Hamiltonian densities (referred to as the Hamiltonian) can be obtained as follows:

where π_0 in the RRW and π_1 in the FRW are vanished by the constraint conditions in Sec.3.2.

3.2 The constitution of path-integral in RRW and FRW

In the system with the Hamiltonians (27), there are two constraint conditions in each region, which we denote as $\phi^{(i)}$ (i = 1, 2):

where π_0 and π_1 above are defined in (20), which are always vanished as can be seen from (20); the value of $\phi^{(2)}$, as given above, can be seen from the condition that the time-development of $\phi^{(1)}$ generated by the Hamiltonians (27) should be vanished[‡].

For (28), we take the Coulomb gauge, and denote $\chi^{(i)}$ (i = 1, 2), as follows:

where the gauge considered as the Coulomb gauge in the Minkowski coordinates is $\partial_{\mu}A^{\mu}$, and $\chi^{(2)}$ in the ones above are the extension of this to the Rindler coordinates; therefore, ∇_{μ} in $\chi^{(2)}$ are the gravitational ones, which do not include the gauge field.

Denoting (28) and (30) together as $\tilde{\phi} \equiv \{\phi^{(1)}, \phi^{(2)}, \chi^{(1)}, \chi^{(2)}\} \equiv \{\tilde{\phi}^{(i)}\}\ (i = 1, 2, 3, 4),$ the Poisson bracket for $\tilde{\phi}$ can be derived for each x^0 in the RRW or x^1 in the FRW as follows:

X and Y represent fields, and t means x^0 and x^1 for the RRW and the FRW, respectively. Since $\text{Det}\left[\{\tilde{\phi}(x), \tilde{\phi}(y)\}_{\text{P.B.}}\right]$ is non-vanishing, $\tilde{\phi}$ forms a second-class constraint.

When the constraints in (28) and (30) are imposed in the phase space with (A^{μ}, π_{μ}) as its coordinates, the probability amplitude from the infinite-past ground state to the infinite-future ground state in the RRW and FRW can be written by the following path-

The terms $\phi^{(2)}A_0$ and $\phi^{(2)}A_1$ contribute to the time-developments of $\phi^{(1)}$ generated by the Hamiltonians (27a) and (27b) in the RRW and FRW, respectively.

[‡]The Hamiltonians (27a) and (27b) can be written using $\phi^{(2)}$ as

integrals:

$$\mathcal{L}_{\text{path}} \equiv \begin{cases} \nabla_0 A^{\mu} \, \pi_{\mu} - \mathcal{H} = \mathcal{L}_{\mathrm{U}(1)} & \text{for the RRW,} \\ \nabla_1 A^{\mu} \, \pi_{\mu} - \mathcal{H} = \mathcal{L}_{\mathrm{U}(1)} & \text{for the FRW,} \end{cases}$$

 \mathcal{H} is defined in (27a) and (27b), respectively, and $\mathcal{L}_{U(1)}$ is given in (26a) and (26b) respectively. M_c and $\mathcal{D}A \mathcal{D}\pi$ are defined as

where C means some constant and x refers to the coordinates in the RRW or FRW. Det is the functional determinant of the functions on the three-dimensional space at constant time in the RRW or FRW.

3.3 Analysis of path-integrals to obtain the Lagrangian in the Lorentz covariant gauge in the RRW and FRW

Let us integrate out π_0 in the RRW and π_1 in the FRW in (33). This can be performed readily as $\phi^{(1)} = \pi_0$ and π_1 in the RRW and FRW, respectively, as in (28), and as a result, (33) can be written as

Since $\mathcal{L}_{U(1)}$ in (35a) and (35b) do not include π_0 and π_1 , respectively, as can be seen in (26), we may write $\mathcal{L}_{U(1)}|_{\pi_0=0}$ and $\mathcal{L}_{U(1)}|_{\pi_1=0}$ as $\mathcal{L}_{U(1)}$. Therefore, in what follows, we write those as $\mathcal{L}_{U(1)}$.

In the equations above, we have written only the part which is important in the following analysis. Now we can integral out A^0 for the RRW in (37a). Then, since $\chi^{(1)} = A^0$ as in (30a), the term concerning A_0 in (38a) disappears. However, we can take η as A^0 , by which the term which has just disappeared is now reintroduced. In the same way, in the FRW in (37b), we integrate out A^1 and take η as A^1 . As a result, (37a) and (37b) can be given as follows:

Considering (26a) and (26b) as the expression of $\mathcal{L}_{U(1)}$ in (39a) and (39b), respectively, $\mathcal{L}_{U(1)}$ includes the terms $\partial_k E^k A_0$ and $\partial_k \pi^k A_1$, respectively. We can restate those terms back by rewriting (25a) and (25b) in reverse. As a result, the component of $\mathcal{L}_{U(1)}$ in

(39a) and (39b) are provided, respectively, as

where $B_k^2 = B_k B^k$ and $\pi_k^2 = \pi_k \pi^k$ as mentioned in (24). If A^{μ} and π_{μ} were not independent of each other and were in the relations (20a) and (20b) respectively, the r.h.s. of (40a) and (40b) reduce to $0 + \mathcal{L}_{U(1)}$.

Then, π_k in (39a) and (39b) can be integrated out (by redefining π_k). As a result,

Once we have obtained the form $\int DA \,\Omega_{\text{Coulomb}} e^{i \int d^4 x \mathcal{L}_{\text{U}(1)}}$ such as the ones above $(\Omega_{\text{Coulomb}} \text{ denotes the parts } \prod[\delta(\chi^{(2)})] \cdot \prod M_c$ in the ones above), by proceeding in the same way as the case of the Minkowski coordinates, we can replace the part of Ω_{Coulomb} with the one by the Lorentz-covariant gauge, and obtain the Lagrangian in Lorentz covariant gauge in the RRW and FRW, which is (18). Since the analysis in the Minkowski coordinates is well-known, we proceed with the analysis from (41) to (18) in Appendix.A.

3.4 The Lorentz covariant U(1) gauge field Lagrangians in the LRW and PRW

Since the metrices of the FRW (RRW) and PRW (LRW) are mathematically the same, as seen in (5), if the path-integrals in the FRW and RRW can be given as in (41), the path-integrals which correspond to those in the PRW and LRW can be given as

where the coordinates in (42a) and (42b) refer to the LRW and PRW given by (5); therefore, x^0 and x^1 mean $\tilde{\tau}$ and $\tilde{\zeta}$ in (5), respectively. Then, performing the analysis in the same way as (41a) and (41b), the Lagrangians of the U(1) gauge field in the Lorentz covariant gauge in the LRW and PRW can be obtained as (18).

4 The solutions of the U(1) gauge field and the *B*field in each region in the Rindler coordinates

In the previous section, the gauge-fixed Lagrangian was obtained as given in (17). In this section, by solving the equations of motion obtained from that Lagrangian, the mode-solutions of the U(1) gauge field and the *B*-field in the RRW and FRW can be obtained. The results are noted in (51) and (52), and the forms of fields as the solution are noted in (59) and (60). The method for solving the equations of motion is noted under (60). The forms of the U(1) gauge field and the *B*-field as the solutions in the LRW and PRW and their mode-solutions are given in Sec.4.2, while the normalization constants of the mode-solutions in the four regions are given in Sec.4.3.

4.1 The solution of the U(1) gauge field and the *B*-field in the RRW and FRW

From the Lagrangian (17), the equations of motion can be obtained as follows:

where, combining (43a) and (43b), $\nabla_{\nu}\nabla^{\nu}A^{\mu} = 0$ can be obtained, from which (44a)-(44c) can be obtained (in obtaining (44b), (44d) is used). From (43b), (44d) can be obtained. Multiplying the entire (43a) by ∇_{ν} , $\nabla_{\mu}\nabla^{\mu}B = 0$ can be obtained, from which (44e) can be obtained. Non-zero $\Gamma^{\mu}_{\nu\lambda}$ are noted in (19). The 0- and 1-directions correspond to τ - and ρ -directions, and \perp correspond to 2, 3-directions.

In the same way, the equations of motion for the fields in the FRW can be derived from (43) as follows:

- · $A^{\mu}(\tau, \rho, x^{\perp})$ and $B(\tau, \rho, x^{\perp})$ in this study are assumed to be real.
- · $\tilde{\mathcal{N}}_{k}^{(\mu)}$ and $\tilde{\mathcal{N}}_{k}^{(B)}$ are constants of each mode, which can take complex numbers. These will be denoted by decomposing them as

- ∂_1 and ∂_0 in (51c) and (52c) can be denoted as $\partial/\partial\rho$ congruent with the RRW and FRW. α in (51) and (52) are respectively defined as $\alpha \equiv k_0/a$ and $\alpha \equiv k_1/a$, and bis defined as $b \equiv \sqrt{k_2^2 + k_3^2}$ congruent with (51) and (52). $K_{i\alpha}(b\rho)$ is the modified Bessel function of the second kind, and $J_{i\alpha}(b\rho)$ is the Bessel function of the first kind. $K_{i\alpha}(b\rho)$ and $J_{i\alpha}(b\rho)$ are the real and imaginary functions, respectively.

Therefore, an identity such as $\chi_{1,k} = \chi_{2,k}$ under (54) is unclear in the RRW and FRW.

However, in the RRW and FRW, it is turned out that $\mathcal{N}_k^{(1)}$ and $\mathcal{N}_k^{(0)}$ are equivalent to each other as seen in (75b) and (76b). Therefore, it can be found from (56) that $\boldsymbol{a}_k^1 = \boldsymbol{a}_k^0$ at the classical level in the RRW and FRW, which is a conclusion which leads from the supposition of $\tilde{\mathcal{N}}_k^{(1)} = \tilde{\mathcal{N}}_k^{(0)}$.

• From what is mentioned above, it can be seen that $\mathcal{N}_k^{(\perp)}$ and $\mathcal{N}_k^{(B)}$ ($\mathcal{N}_k^{(1)}$ and $\mathcal{N}_k^{(0)}$) are not independent each other, therefore these can be denoted using a notation. Also, \boldsymbol{a}_k^{\perp} and \boldsymbol{b}_k (\boldsymbol{a}_k^1 and \boldsymbol{a}_k^0) can be denoted using a notation.

However, after the canonical quantization is performed, $\boldsymbol{a}_{k}^{\perp}$ and \boldsymbol{b}_{k} (\boldsymbol{a}_{k}^{1} and \boldsymbol{a}_{k}^{0}) become annihilation operators vanishing the excitations in different directions. In this sense, $\boldsymbol{a}_{k}^{(\perp)}$ and \boldsymbol{b}_{k} (\boldsymbol{a}_{k}^{1} and \boldsymbol{a}_{k}^{0}) are physically distinct from each other. Therefore, we distinctively denote those as $\boldsymbol{a}_{k}^{(\perp)}$ and \boldsymbol{b}_{k} (\boldsymbol{a}_{k}^{1} and \boldsymbol{a}_{k}^{0}).

Corresponding to this, we distinctively denote $\mathcal{N}_{k}^{(\perp)}$ and $\mathcal{N}_{k}^{(B)}$ ($\mathcal{N}_{k}^{(1)}$ and $\mathcal{N}_{k}^{(0)}$) as $\mathcal{N}_{k}^{(B)}$ and $\mathcal{N}_{k}^{(\perp)}$ ($\mathcal{N}_{k}^{(1)}$ and $\mathcal{N}_{k}^{(0)}$), as well.

Now that the mode-solutions have been obtained as given in (51) and (52), let us write as:

where the mode parts $\tilde{A}_k^{(\mu)}(\rho)$ and $\tilde{B}_k(\rho)$ are given by (51) and (52). The forms of (59) and (60) guarantee that A^{μ} and B in the FRW and FRW are real.

We will explain how we have solved (49) and obtained (51).

- · First, we obtain the solutions of \tilde{A}_k^{\perp} in the FRW and RRW.
 - We could solve (49c), and the general solution of \tilde{A}_k^{\perp} is given by the linear combination of $J_{i\alpha}(-ib\rho)$ and $Y_{i\alpha}(-ib\rho)$. However, we considered $K_{i\alpha}(b\rho)$, instead of $J_{i\alpha}(-ib\rho)$ and $Y_{i\alpha}(-ib\rho)$, and (51a) was obtained.

Since $K_{i\alpha}(b\rho)$ can be defined with $J_{i\alpha}(ib\rho)$, $K_{i\alpha}(b\rho)$ can satisfy (49c). Note that $K_{i\alpha}(b\rho)$ is finite real except at $\rho = 0^{\$}$ (however, $\rho = 0$ is not included in the definition of the Rindler coordinates as mentioned in Sec.2.4).

- Also, we can solve (50c), and the general solution of \tilde{A}_k^{\perp} is given by the linear combination of $J_{i\alpha}(b\rho)$ and $Y_{i\alpha}(b\rho)$.

 $J_{i\alpha}(b\rho)$ is finite complex except at $\rho = 0$ (as for this finiteness, see the discussion in the footnote above), but since $Y_{i\alpha}(b\rho)$ is singular at $\rho = 0$, the values of $Y_{i\alpha}(b\rho)$ for some ρ extremely near 0 are singular-like. Since \tilde{A}_k^{\perp} should be well-defined for ρ near 0, $J_{i\alpha}(b\rho)$ is considered as the solution of \tilde{A}_k^{\perp} .

• The solution of B_k satisfies (49e) and (50e), which are the same equations as (49c) and (50c). Therefore, we can give the solution of \tilde{B}_k in the same way as the solutions of \tilde{A}_k^{\perp} in (51a) and (52a). However, in fact, we obtained \tilde{B}_k from the following equations:

From (63a) and (63b), using the solutions of \tilde{A}_k^{\perp} in (51a) and (52a) and supposing $\tilde{\mathcal{N}}_k^{(B)} = \tilde{\mathcal{N}}_k^{(\perp)}$ (we discuss this in (53)), \tilde{B}_k can be obtained as seen in (51d) and (52d). It can be seen that these (51d) and (52d) can satisfy (49e) and (50d).

- Since we have supposed the r.h.s. of (49b) and (50b) as 0, we can now put the l.h.s. of these as 0, as well. Solving those, \tilde{A}_k^1 in the RRW can be obtained as seen in (51b), and \tilde{A}_k^0 in the FRW can be obtained as seen in (52b).
- The r.h.s. of (49d) and (50d) are essentially the same as the r.h.s. of (49b) and (50b), which are now being taken to 0 in (63). Therefore, we can put the r.h.s. of (49d) and (50d) as 0. From those, the following equations are obtained:

In our study, β is given as $i\alpha$ ($\alpha \geq 0$). Further, when the limit taking x to 0 is considered, by the definition of the Rindler coordinates, x is not considered to be exactly 0, but some x extremely near 0 is considered. In this case, for some x extremely near 0, x^i (i is the imaginary number, coming from $(x/2)^{2n+\beta}$ (now $\beta = i\alpha$)) is a finite complex number (this can be confirmed numerically), it can be seen from (62) that the values of $J_{i\alpha}(x)$ for such x are also finite complex; correspondingly, $K_{i\alpha}(x)$ at some x extremely near 0 is finite as well. Finally, since $K_{i\alpha}(x)$ is real, it can be concluded that $K_{i\alpha}(x)$ at some x extremely near 0 is finite real.

respectively. Then, from (64a) and (64b), using \tilde{A}_k^1 in (51b) and \tilde{A}_k^0 in (52b), and supposing $\tilde{\mathcal{N}}_k^{(0)} = \tilde{\mathcal{N}}_k^{(1)}$ (we discuss this in (56)), \tilde{A}_k^0 in the RRW can be obtained as seen in (51c), and \tilde{A}_k^1 in the FRW can be obtained as seen in (52c).

 \cdot Although (49a) and (50a) are not used in the process above, they are satisfied by the solutions obtained in the one above.

4.2 The solution of the U(1) gauge field and the *B*-field in the LRW and PRW

In the previous subsection, the mode-solutions in the RRW and FRW were obtained in (51) and (52), and the fields as the solutions have been given in (59) and (60). In the Rindler coordinates, if a solution in one region is known, the parity-symmetric solution for that in another side can be known according to (7) and (8). Therefore, in this subsection, the mode-solutions and the fields as the solutions in the LRW and PRW are given according to what was been obtained in the previous subsection with (7) and (8). The normalization constants of the mode-solutions in the LRW and PRW are obtained in Sec.4.3.

According to (7), the forms of the fields in the PRW, which are parity-symmetric solutions for the fields in FRW of (60) for the $x^0 = 0$ line, can be given from the fields in FRW of (60) as follows:

4.3 The normalization constants of the mode-solutions in each region

In this subsection, the normalization constants in all directions of the mode-solutions of the U(1) gauge field and the *B*-field in all four regions in the Rindler coordinates are obtained. First, the normalization constants of the mode-solutions in the FRW and RRW are derived from the explicit calculation based on the Klein-Gordon (KG) inner-product. Then, from the fact that the coordinates and the mode-solutions in the PRW and LRW can be considered to be the same as those in the FRW and RRW, the normalization constants of the mode-solutions in the FRW and RRW. Therefore, we immediately give the normalization constants in the PRW and LRW from the results of those in the FRW and RRW. These results are noted in (76).

We begin by defining the KG inner-product. Then, in general, an integral with regard to a vector on a three-dimensional (3D) hypersurface in four-dimensional (4D) spacetime can be written as

where V^{μ} represents some vector, and $d\Sigma_{\mu}$ are the components of the area element on the 3D hypersurface.

Let us suppose the form of ds^2 as $ds^2 = g_{ii}(dx^i)^2 + g_{jk}dx^jdx^k$ (*i* means one direction and the summation is not taken for *i*; on the other hand *j*, *k* mean all the directions except for the *i*-direction and the summations except for *i* are taken for *j*, *k*). Then, if we take the 3D hypersurface as a x^i -constant, the *i*-direction is perpendicular to the 3D hypersurface, and $V^{\mu} d\Sigma_{\mu}$ in (69) is given as

The calculation from (79a) and (79b) can be performed in the same way as (78), and $\mathcal{N}_k^{(1)}$ can be finally determined as noted in (75b) and (76b). To integrate out the ρ -integrals, (149c), (149d), (150c) and (150d) in Appendix.B were used.

5 The canonical quantization of the U(1) gauge field in the Rindler coordinates

In this section, formulating the canonical commutation relations (CCR) of the U(1) gauge field in the FRW and RRW, it is shown that the coefficients of each mode of the

U(1) gauge field in each region have physical meaning as creation/annihilation operators. Since we have explicitly obtained the mode-expanded solution of the U(1) gauge field in the FRW and RRW including the normalization constants as seen in (51), (52), (75) and (76), we can formulate the CCR without ambiguity or speculation. Then, by proceeding with calculation following the definition, we can obtain the results (94) and (95).

The CCR in the FRW:

Let us formulate the CCR of the fields in $\tilde{\mathcal{L}}_{U(1)}^{(R)}$ in (18) in the FRW as follows:

The ghost fields are not addressed for the reason mentioned previously in Sec.3.1.

When a is taken to 0, $a\rho$ in (81) become 1 (ρ is defined in (4)) and (81) can agree with the CCR in the Minkowski coordinates except for the difference of the sign. The difference of the sign can be considered to be due to the difference between the Killing vector at a = 0 in the FRW and the Killing vector in the Minkowski coordinates.

Therefore, from the results of (94) and (95), the coefficient of each mode of the U(1) gauge field in the PRW and LRW in (65a) and (67a), $\boldsymbol{a}_{k_1,k_{\perp}}^{\mu}$ and $\boldsymbol{a}_{k_1,k_{\perp}}^{\mu}$, satisfy the following commutation relations:

6 Polarization vectors

In the previous section, it was shown that the coefficient of each mode-solution in each direction of the U(1) gauge field within each region of Rindler coordinates has the physical meaning as the creation/annihilation operators. In general, the creation/annihilation operators in each direction are decomposed with the polarization directions. Therefore, in this section, polarization vectors in each region within the Rindler coordinates are given. As a result, the values of the coordinates of η and ξ in the FRW and RRW and $\tilde{\eta}$ and $\tilde{\xi}$ in the PRW and LRW are restricted, as the region where the norms of the 1-particle states in the scalar and longitudinal polarization directions are less than zero. Regarding the origin of those restrictions, it can be concluded that those can be

attributed to the non-covariance in the canonical quantization (85).

Let us decompose the annihilation operators in each region with the polarization vectors as follows:

$$\varepsilon_{\mu}^{(\rho)*} \varepsilon_{\nu}^{(\rho')} g^{(\mathrm{M})\mu\nu} = -\sum_{\sigma,\sigma'} \left(g_{\mu\lambda}^{(\mathrm{R})} \varepsilon^{(\sigma)\mu} \varepsilon^{(\rho)\lambda*} \right) \left(g_{\nu\tau}^{(\mathrm{R})} \varepsilon^{(\sigma')\nu*} \varepsilon^{(\rho')\tau} \right) \eta^{(\sigma\sigma')}, \tag{102}$$

where $g^{(R)\mu\nu}$ means the metric in the FRW, PRW, RRW or LRW in (5).

Let us express k_{μ} , the four-dimensional momentum of the U(1) gauge field, as follows:

$$k^{\mu} = (k, \omega, 0, 0)$$
with $\omega = \frac{|\vec{k}|}{\sqrt{|g_{11}|}} = \frac{|\vec{k}|}{|a\rho|}$ and $\vec{k} = (\underbrace{k}_{0}, \underbrace{0, 0}_{|})$ for the FRW and PRW, (103a)

$$k^{\mu} = (\omega, k, 0, 0)$$
with $\omega = \frac{|\vec{k}|}{\sqrt{|g_{00}|}} = \frac{|\vec{k}|}{|a\rho|} \text{ and } \vec{k} = (\underbrace{k}_{1}, \underbrace{0, 0}_{\perp}) \text{ for the RRW and LRW.}$ (103b)

where \vec{k} is the three-dimensional vector obtained from k^{μ} by removing ω from k^{μ} , and the indices of the under-breath's refer to the direction of those components. These k_{μ} satisfy the conditions as a massless field, as $0 = k_{\mu}k^{\mu}$, in the four regions within the Rindler coordinates.

Let us discuss how the (S, L, \pm) -directions of the polarization vectors correspond to the directions in the four-dimensional (4D) Rindler coordinates. First, from $0 = k_{\mu}k^{\mu}$, we can see that the direction of the world-line of the U(1) gauge field (the direction of travel in the four-dimensional Rindler coordinates) is either of parallel or perpendicular to the Killing horizon.

Then, since τ and $\tilde{\tau}$ play the role of time in the RRW and LRW, the world-line of the U(1) gauge field in the RRW and LRW should be parametrized by τ and $\tilde{\tau}$ (as noted under (5)). Then, since the direction parallel to the Killing horizon is parametrized by τ and $\tilde{\tau}$ (while the direction perpendicular to the Killing horizon is τ or $\tilde{\tau}$ constant), the direction of the world-line of the U(1) gauge field is supposed as parallel to the Killing horizon. In the same way, in the FRW and PRW, the direction of the world-line of the U(1) gauge field is assumed to be parallel to the Killing horizon.

Then, since the longitudinal direction in the polarization vector is the direction of the world-line of the U(1) gauge field, the (S, L)-directions of the polarization vectors agree with the (1, 0)-directions in the FRW and PRW (here, the \pm polarization-directions and \perp -directions in the RIndler coordinates do not agree with each other, although those have a common normal vector), and the (S, L)-directions of the polarization vectors agree with the (0, 1)-directions in the RRW and LRW.

Now, let us assume that,

when the polarization vectors are considered,
$$\rho$$
 is taken as constant. (104)

The definition of ρ is given in (4). It can be seen that this assumption means to take the acceleration of motion as constant in each region (to be exact, there is no accelerated motion in the FRW and PRW, and the lines ρ labels in the FRW and PRW are lines analogous to the world-lines of constant accelerated motion in the LRW and RRW). Since we are considering the constant accelerated motion, we can impose this assumption (104).

This assumption is crucial in defining the polarization vectors. This is because, as can be seen in (103), ω depends on a coordinate ρ . Then, as can be seen later, $\varepsilon^{(S)\mu}$ and $\varepsilon^{(L)\mu}$ depending on the coordinate ρ through ω are led, which means that $\boldsymbol{a}_{k_1,k_\perp}^{\mu}$ and $\boldsymbol{a}_{k_0,k_\perp}^{\mu}$ depend on the coordinate ρ are led. Then, the equations of motion become unsatisfied. In such a situation, if ρ is fixed by (104), ω becomes substantially coordinate-independent. Accordingly, $\varepsilon^{(S)\mu}$ and $\varepsilon^{(L)\mu}$ becomes substantially coordinate-independent as well, and the problem mentioned above does not occur.

In the situation where k^{μ} is given as (103), we can take the polarization vector for the *S*-, *L*-, and ±-directions, $\varepsilon^{(\sigma)\mu}$, as follows:

$$\varepsilon^{(+)\mu} = -(0, 0, 1, i)/\sqrt{2}, \quad \varepsilon^{(-)\mu} = \varepsilon^{(+)\mu*},$$

$$\varepsilon^{(S)\mu} = \begin{cases} i(-k,\omega,0,0)/2|\vec{k}|^2 & \text{for the FRW and PRW,} \\ i(\omega,-k,0,0)/2|\vec{k}|^2 & \text{for the RRW and LRW,} \end{cases}$$
 (105c)

where $\varepsilon^{(L)\mu}$ and $\varepsilon^{(S)\mu}$ are common across the four regions. By the assumption in (104), this $\varepsilon^{(\sigma)\mu}$ is substantially constant for the Rindler coordinates. Below, we mention how (105) was obtained.

- · If \vec{k} is given as (103), $\varepsilon^{(\pm)\mu}$ can be immediately determined as (105a) in the four regions in the Rindler coordinates.
- Due to the fact that the *L*-polarization direction is parallel to k^{μ} in the 4D Rindler coordinates, $\varepsilon^{(L)\mu}$ should be a constant multiplication of k^{μ} . In addition, it should be able to reduce to the one in the Minkowski coordinates, which is $\varepsilon_0^{(L)\mu}$ in (106)[¶], at a = 0. From these conditions, $\varepsilon^{(L)\mu}$ is fixed, as noted in (105b).

Actually, since g_{00} in the LRW and RRW in (5) reduce to 1 at a = 0, $\varepsilon^{(L)\mu}$ in the LRW and RRW reduce to -i(|k|, k, 0, 0) at a = 0, which is $\varepsilon_0^{(L)\mu}$ in (106).

On the other hand, as for $\varepsilon^{(L)\mu}$ in the FRW and PRW, g_{11} in the FRW and PRW reduces to 1 at a = 0 as well, but $\varepsilon^{(L)\mu}$ in the FRW and PRW reduces to -i(k, |k|, 0, 0) at a = 0, which does not agree with $\varepsilon_0^{(L)\mu} = -i(|k|, k, 0, 0)$ in (106).

As for this disagreement, from comparison of (2b) and (2c), it can be seen that in the FRW, x^0 is the direction of the constant accelerated motion, and x^1 is the timedirection for that constant accelerated motion. Therefore, in the alignment of the components of FRW vectors, the first component has the spatial meaning and the second component has time-like meaning. Considering this fact, the disagreement of (k, |k|, 0, 0) with $\varepsilon_0^{(L)\mu}$ at a = 0 does not pose a problem. The disagreement in the PRW is likewise.

$$\varepsilon_0^{(+)\mu} = -(0,0,1,i)/\sqrt{2}, \quad \varepsilon_0^{(-)\mu} = \varepsilon_0^{(+)\mu*}, \quad \varepsilon_0^{(L)\mu} = -ik^{\mu}, \quad \varepsilon_0^{(S)\mu} = i(\omega,-\vec{k})/2|\vec{k}|^2, \tag{106}$$

where k^{μ} here is $(\omega, k, 0, 0)$ with $\omega = |\vec{k}|$ (\vec{k} is the three-dimensional spatial vector, (k, 0, 0)). $\varepsilon_0^{(L)\mu}$ should be a constant multiplication of k^{μ} . The reason for the multiplication by -i is that $\eta^{(\sigma\sigma')}$ can be real by that.

[¶]The polarization vectors in the Minkowski coordinates which are referred to in the body of the text are the following one:

• Let us look at $\varepsilon^{(S)\mu}$. In the Minkowski case, $\varepsilon^{(S)\mu}$ is normally determined according to one of the equation of motion including A^{μ} and B (as B is a scalar field, the polarization vector for the scalar direction can be fixed^{||}), which in this study corresponds to (44d) and (45d), which lead to (49d) and (50d).

However, in this study, B is obtained not by the whole (49d) and (50d), but by the r.h.s. of (49d) = 0 and (50d) = 0 in the RRW and FRW, respectively. Then, now that $k_{\perp} = 0$, therefore those equations no longer work as the equations $\varepsilon^{(S)\mu}$ should adhere to.

However, this means that we can freely take $\varepsilon^{(S)\mu}$. Therefore, we have taken $\varepsilon^{(S)\mu}$ as noted in (105c), which can reduce to the Minkowski one $\varepsilon_0^{(S)\mu}$ as mentioned in (106). (In the FRW and PRW, there is a similar type of the disagreement as the one discussed above in the case of $\varepsilon^{(L)\mu}$; however, similar to the discussion mention here, those disagreements do not pose any problem either.)

Applying (105) to (102), we can obtain $\eta^{(\sigma\sigma')}$ as follows^{**}:

$$\eta^{(\sigma\sigma')} = - \begin{cases} S & L & + & - \\ L \\ \varepsilon_{\mu}^{(L)*} \varepsilon_{\nu}^{(L)} g^{(M)\mu\nu} & \varepsilon_{\mu}^{(L)*} \varepsilon_{\nu}^{(S)} g^{(M)\mu\nu} & 0 & 0 \\ \varepsilon_{\mu}^{(S)*} \varepsilon_{\nu}^{(L)} g^{(M)\mu\nu} & \varepsilon_{\mu}^{(S)*} \varepsilon_{\nu}^{(S)} g^{(M)\mu\nu} & 0 & 0 \\ 0 & 0 & \varepsilon_{\mu}^{(+)*} \varepsilon_{\nu}^{(+)} g^{(M)\mu\nu} & \varepsilon_{\mu}^{(+)*} \varepsilon_{\nu}^{(-)} g^{(M)\mu\nu} \\ 0 & 0 & \varepsilon_{\mu}^{(-)*} \varepsilon_{\nu}^{(+)} g^{(M)\mu\nu} & \varepsilon_{\mu}^{(-)*} \varepsilon_{\nu}^{(-)} g^{(M)\mu\nu} \end{pmatrix} \\ = \begin{cases} \left(\begin{array}{c} (|g_{11}| - 1)/4k_{1}^{2} & (1 + |g_{11}|)/2 & 0 & 0 \\ 0 & 0 & \varepsilon_{\mu}^{(-)*} \varepsilon_{\nu}^{(+)} g^{(M)\mu\nu} & \varepsilon_{\mu}^{(-)*} \varepsilon_{\nu}^{(-)} g^{(M)\mu\nu} \\ 0 & 0 & 0 & 1 \end{array} \right) \\ 0 & 0 & 0 & 1 \end{array} \right) & \text{for the FRW and PRW,} \\ \begin{cases} \left(\begin{array}{c} (|g_{11}| - 1)/4k_{1}^{2} & (1 + |g_{11}|)/2 & 0 & 0 \\ 0 & 0 & 0 & 1 \end{array} \right) \\ 0 & 0 & 0 & 1 \end{array} \right) \\ \left(\begin{array}{c} (1 - |g_{00}|)/4k_{0}^{2} & (1 + |g_{00}|)/2 & 0 & 0 \\ (1 + |g_{00}|)/2 & (1 - |g_{00}|)k_{0}^{2} & 0 & 0 \\ 0 & 0 & 0 & 1 \end{array} \right) \\ \text{for the RRW and LRW,} \end{cases}$$

where $\varepsilon_{\mu}^{(\sigma)} = g_{\mu\nu}^{(R)} \varepsilon^{(\sigma)\nu}$.

Then, it can be seen from (100) that the norms of the 1-particle states in the S- and

^IIn the Minkowski case, as one of the equations of motion, $\partial_{\mu}A^{\mu} + \alpha B = 0$ ($\alpha = 1$) is obtained. From this, an equation that $\varepsilon^{(S)\mu}$ should satisfy is obtained as $-k_{\mu}\varepsilon^{(\sigma)\mu} = \delta^{\sigma S}$, where $k_{\perp} = 0$. **If we assign as $\rho = \rho' = S$ in (102), (102) can be calculated as follows:

where (105) has been used. Performing this for each component, the first line in (108) can be obtained. The second line in (108) can be obtained by assigning (105) to each component in the first line. *L*-directions are given as follows:

Here, $\eta^{(SL)} = \eta^{(LS)} > 1/2$, which is the same situation with the Minkowski case in the sense that $\eta^{(SL)}$ and $\eta^{(LS)}$ are always positive and pose no problem.

To ensure that (109a) and (109b) are less than zero, the following conditions should be satisfied:

$$\cdot |g_{11}| - 1 \le 0 \quad \text{for the FRW and PRW}, \tag{110a}$$

$$\cdot 1 - |g_{00}| \le 0$$
 for the RRW and LRW. (110b)

Since $g_{11} = -a^2 \rho^2$ and $\rho = a^{-1} e^{a\eta}$ in the FRW and PRW and $g_{00} = a^2 \rho^2$ and $\rho = a^{-1} e^{a\xi}$ in the RRW and LRW, (110a) and (110b) can be rewritten as

 $e^{a\eta} \leq 1$ and $e^{a\tilde{\eta}} \leq 1$ for the FRW and PRW, respectively, and (111a)

From these, the region where the polarization vector (105) can be defined in the sense that the norms of the 1-particle states in the *S*- and *L*-directions are less than zero is restricted as follows:

for η , $\tilde{\eta}$, ξ , $\tilde{\xi} \in (-\infty, \infty)$. The regions restricted by (112) are shown in Fig.2.



Figure 2: In the left- and righthand figures, supposing the bold dashed lines as the $\tilde{\xi} = 0$ and $\xi = 0$ lines and the $\eta = 0$ and $\tilde{\eta} = 0$ lines, respectively, the regions restricted by (112), in which the norms of the 1-particle states in the *S*- and *L*- polarization directions are less than 0, are shown in the blue region.

As can be seen in (112), (112) are constraints which are irrelevant of the relativity. Below, we discuss why such constraints can appear.

First, (99a) and (99b) are the equations with regard to the quantities defined in the Rindler coordinates, but the metrices in the l.h.s. of those equations are not the Rindler metrices, but the Minkowski metrices; therefore, (99a) and (99b) are some noncovariant equations. Therefore, when some equation is derived based on (99a) or (99b), that equation is irrelevant of the relativity. Therefore, since $\eta^{(\sigma\sigma')}$ in (108) is obtained based on (99a) or (99b), constraints irrelevant of the relativity, such as (112), appears. (Therefore, if some polarization vector other than (105) is considered, some constraint different from (112) would appear from $\eta^{(\sigma\sigma')}$ at that time.)

Therefore, since the cause of (112) is the appearance of the Minkowski metrices in (99a) and (99b), let us consider the origin of those metrices. We can see that, in (85) and (90), the canonical commutation relations in the Rindler coordinates are defined with the Minkowski metrices; once (85) and (90) are given, (99a) and (99b) follow from (85) and (90) by proceeding with a calculation following the definition. Therefore, as long as (85) and (90) are considered, the appearance of the Minkowski metric in (99a) and (99b) is inevitable. Why the Minkowski metric appears in the equation considered in the Rindler coordinates can be considered as a general property of canonical quantization that the relativistic covariance is not maintained in canonical quantization.

In conclusion, the appearance of (112) can be attributed to the general property of canonical quantization mentioned above, and (112) is not a problem of the classical solutions obtained in Sec.4-4.3. In this sense, (112) is no more than what specifies the region where the polarization vector (105) can be defined in each region in the Rindler coordinates.

Lastly, when (112) is not satisfied, since all four directions are positive norm states, the U(1) gauge field should be massive. However, we could not find any effective mass term at that time. Yet, this is no problem because the relativistic consistency is not maintained in (112) for the reason mentioned above. Therefore, even if (112) is not satisfied and all four directions become positive norm states, it is not necessary that the effective mass term of the U(1) gauge field must occur.

The density matrix and Unruh temperature of the 7 U(1) gauge field in RRW

In this section, the density matrix of the U(1) gauge field in the RRW is obtained. For each quantity in the Minkowski, LRW or RRW coordinates, we will respectively attach (M)', (L)' and (R)' in its superscript; for example, we denote A^{\perp} given in the RRW as $A^{(R)\perp}$ in this section.

The expression of $oldsymbol{a}_{ec{a}}^{(\mathrm{M})\perp}$ 7.1

With V defined in (9) (but here defined in the *D*-dimension), we can denote this as follows:

$$A^{(M)\perp} = \begin{cases} A^{(L)\perp} & \text{in the LRW for } V < 0, \\ A^{(R)\perp} & \text{in the RRW for } V > 0, \end{cases}$$
(113)

where $A^{(M)\perp}$ is obtained by $\partial_{\mu} x^{(L)\perp} A^{(L)\mu}$ or $\partial_{\mu} x^{(R)\perp} A^{(R)\mu}$ for V < 0 or > 0 as a transformation of the contravariant vectors between the Minkowski and Rindler coordinates. However, this is trivial, and we can write $A^{(M)\perp}(V)$ in the following manner:

$$A^{(\mathrm{M})\perp} = \Theta(-V)A^{(\mathrm{L})\perp} + \Theta(V)A^{(\mathrm{R})\perp}, \qquad (114)$$

where $\Theta(x)$ is the step function.

We denote $A^{(L)\perp}$ and $A^{(R)\perp}$ as follows:

where $A^{(L,R)\perp}$ is the ellipsis notation of $A^{(L)\perp}$ and $A^{(R)\perp}$, using the results in (51) and (76), $f_{k_0k_\perp}^{(L,R)}$ are defined as

$$f_{k_0k_{\perp}}^{(L,R)} \equiv \mathcal{N}_{k_0} K_{i\alpha}(b|\rho|) e^{-ik_0\tau + ik_{\perp}x^{\perp}} = \sqrt{\frac{\sinh(\pi\alpha)}{a(2\pi^2)^2}} K_{i\alpha}(b|\rho|) e^{-ik_0\tau + ik_{\perp}x^{\perp}}, \quad (116)$$

where ρ is defined in (4) and α and b are defined under (51).

By the Bogoliubov transformation, we can denote $f_{k_0,k_{\perp}}^{(L,R)}$ in terms of modes in the Minkowski coordinates, $f_{q_1k_{\perp}}^{(M)} \equiv \frac{1}{\sqrt{(2\pi)^3 2q_0}} e^{-i(q_0t-q_1x^1-k_{\perp}x^{\perp})}$, as follows:

$$\Theta(-V) f_{k_0 k_\perp}^{(\mathrm{L})} = \int_{-\infty}^{\infty} dq_1 \left(\alpha_{k_0 q_1}^{(\mathrm{L})} f_{q_1 k_\perp}^{(\mathrm{M})} + \beta_{k_0 q_1}^{(\mathrm{L})} f_{q_1 k_\perp}^{(\mathrm{M})*} \right), \tag{117a}$$

$$\Theta(+V) f_{k_0 k_\perp}^{(\mathbf{R})} = \int_{-\infty}^{\infty} dq_1 \left(\alpha_{k_0 q_1}^{(\mathbf{R})} f_{q_1 k_\perp}^{(\mathbf{M})} + \beta_{k_0 q_1}^{(\mathbf{R})} f_{q_1 k_\perp}^{(\mathbf{M})*} \right), \tag{117b}$$

where $\alpha_{k_0k_1}^{(L,R)}$ and $\beta_{k_0k_1}^{(L,R)}$ are the Bogoliubov coefficients, which will be obtained in Sec.7.2. Applying (115) to (114), then with (117), we can represent $A^{(M)\perp}$ in (114) as follows:

where $\int d^3 \vec{q}$ means $\int_{-\infty}^{\infty} dq_1 \int_{-\infty}^{\infty} d^2 k_{\perp}$. From (118), we can express $\boldsymbol{a}_{\vec{q}}^{(M)\perp}$ as follows:

7.2 The Bogoliubov coefficients

We obtain the Bogoliubov coefficients $\alpha_{k_0q_1}^{(L,R)}$ and $\beta_{k_0q_1}^{(L,R)}$ in (119). For this purpose, we use the fact that these are independent of the coordinates and k_{\perp} . Then we can consider the KG inner-product by the integral on the future Killing horizon (FKH), which is the U = 0 hypersurface to be reached by $\rho \to 0$ (see Fig.1):

$$(f,g)_{\rm KG}^{\rm (FKH)} \equiv i \,\mathcal{V}^{-1} \int_0^\infty dV \int_{-\infty}^\infty d^2 x^\perp (f^* \,\partial_V g - \partial_V f^* g), \tag{120}$$

where $\mathcal{V} \equiv (2\pi)^{-2} \int_{-\infty}^{\infty} d^2 x^{\perp}$.

The points in taking the FKH are that **1**) $t = x^1$ (which leads to $x^0 = x^1 = V/2$ based on (9)), **2**) $\rho \to 0$ ($\xi \to -\infty$), and **3**) $k_{\perp} = 0$. Here, when **3**) is imposed, it follows that $k_0 = \pm k_1$; therefore, in what follows, we also use **3**) in the sense of $k_0 = \pm k_1$.

Therefore, now $f_{k_1,k_\perp}^{(M)}$ in (117) is given as follows:

$$f_{k_1,k_\perp}^{(\mathrm{M})}|_{\mathbf{1},\mathbf{3})} = \frac{1}{\sqrt{2k_0(2\pi)^3}} e^{-i(k_0-k_1)V/2 + ik_\perp x^\perp}|_{\mathbf{3})}.$$

With this,

$$(f_{q_1,q_{\perp}}^{(\mathrm{M})}, f_{k_1,k_{\perp}}^{(\mathrm{M})})_{\mathrm{KG}}^{(\mathrm{FKH})} \big|_{\mathbf{3}} = \frac{(q_0 - q_1) + (k_0 - k_1)}{2\sqrt{q_0k_0}} \delta((q_0 - q_1) - (k_0 - k_1)) \big|_{\mathbf{3}}$$
$$= \frac{(|q_1| - q_1) + (|k_1| - k_1)}{2\sqrt{|q_1||k_1|}} \delta((|q_1| - q_1) - (|k_1| - k_1)) \big|_{\mathbf{3}}. (122)$$

We evaluate (122) by dividing it into the following cases: i) $q_1 \ge 0$, $k_1 \ge 0$, ii) $q_1 \ge 0$, $k_1 \le 0$, iii) $q_1 \le 0$, $k_1 \ge 0$, iv) $q_1 \le 0$, $k_1 \le 0$. Then, in cases i), ii) and iii), (122) becomes zero, and from case iv) the following (123a) can be obtained:

where (123b) and (123c) are obtained in the same way as (123a). Therefore, we can take out the Bogoliubov coefficients $\alpha_{k_0,k_1}^{(R)}$ and $\beta_{k_0,k_1}^{(R)}$ as follows:

 $f_{k_0,k_{\perp}}^{(\mathrm{R})}$ is given with $K_{i\alpha}(b\rho)$ as seen in (116), and in general, $K_{i\alpha}(x) = \frac{i\pi}{2\sinh(\pi\alpha)} \left(\frac{(x/2)^{i\alpha}}{\Gamma(1+i\alpha)} - \frac{(x/2)^{-i\alpha}}{\Gamma(1-i\alpha)}\right) + \mathcal{O}(x^2)$. Therefore, by **2**), $f_{k_0,k_{\perp}}^{(\mathrm{R})}$ on the FKH can be given as

$$f_{k_{0},k_{\perp}}^{(\mathrm{R})}|_{\mathbf{2},\mathbf{3})} = \frac{i}{2} \frac{1}{(a\sinh(\pi\alpha))^{1/2}} \left(\frac{(b/2a)^{i\alpha}e^{-ik_{0}u}}{\Gamma(1+i\alpha)} - \frac{(b/2a)^{-i\alpha}e^{-ik_{0}v}}{\Gamma(1-i\alpha)}\right) \frac{e^{ik_{\perp}x^{\perp}}|_{k_{\perp}=0}}{2\pi}$$
$$= \frac{i}{2} \frac{1}{(a\sinh(\pi\alpha))^{1/2}} \left(\frac{(b/2a)^{i\alpha}(-aU)^{i\alpha}}{\Gamma(1+i\alpha)} - \frac{(b/2a)^{-i\alpha}(aV)^{-i\alpha}}{\Gamma(1-i\alpha)}\right) \frac{1}{2\pi}$$
$$= C_{+}(-aU)^{i\alpha} + C_{-}(aV)^{-i\alpha}, \tag{125}$$

where we have rewritten u and v to U and V using (11) and $C_{\pm} \equiv \frac{\pm i}{4\pi} (a \sinh(\pi \alpha))^{-1/2} \frac{(b/2a)^{\pm i\alpha}}{\Gamma(1\pm i\alpha)}$. With (121) and (125), we can have

where $C_1 \equiv 1/\sqrt{4\pi q_0}$. In (126), there is no term of C_+ in (125). This is because $u (= \tau - \xi)$ is always diverged on the FKH (on FKH, $-\xi \sim \tau \sim \infty$ as can be seen from (12)), while $v (= \tau + \xi)$ takes values from 0 to ∞ . Therefore, in the integration on the FKH in terms of τ in the KG inner-product (126), the term of C_+ oscillates hard, and can be ignored. In the same way, we can give (124b) as

We can calculate (126) and (127), which are the l.h.s. of (124a) and (124b). Integrals appearing in those can be performed (using the Mathematica, etc). Next, $b^2 = k_{\perp}^2$, and k_{\perp}^2 is common in the Minkowski and Rindler coordinates. Therefore, as the fourdimensional momentum of the massless field, $0 = (a\rho)^2 q_0^2 - q_1^2 - k_{\perp}^2 = k_0^2 - k_1^2 - k_{\perp}^2$. From this, $b^2 = k_0^2 - k_1^2$, supposing **3**). Using this, we can finally obtain $\alpha_{k_0,+k_1}^{(R)}$ as follows:

where the integrals appearing in the computations can be performed and become delta-functions by $\frac{1}{2\pi a} \int_{-\infty}^{\infty} dq_3 \frac{1}{q_0} (\frac{q_0-q_1}{q_0+q_1})^{i(p_0-k_0)/2a} = \frac{1}{2\pi a} \int_{-\infty}^{\infty} d\theta \, e^{i\theta(p_0-k_0)/a} = \delta(p_0-k_0) \ (\theta \equiv \frac{1}{2} \log(\frac{k_0+k_1}{k_0-k_1})|_{\mathbf{3}}) = \frac{1}{2} \log(\frac{\sqrt{k_1^2+k_\perp^2+k_1}}{\sqrt{k_1^2+k_\perp^2-k_1}})|_{\mathbf{3}}).$ Using (130) and $\mathbf{a}_{\vec{q}}^{(\mathrm{M})\perp}$ given in (119), we can obtain the following result:

Therefore, from the identity $a_{\vec{k}\perp}^{(M)\perp}|0_M\rangle = 0$, we can obtain the following identity:

Then, by $(\boldsymbol{a}_{p_0k_{\perp}}^{(\mathrm{L})\perp})^{\dagger} \times (132) - (\boldsymbol{a}_{p_0k_{\perp}}^{(\mathrm{R})\perp})^{\dagger} \times (132)$, we can get the following relation:

(133) means that the Minkowski ground state constitutes a linear combination of the outer-product of the left and right Rindler states which have the same excited numbers as each other, namely,

7.4 The density matrix and Unruh temperature of the U(1) gauge field in the RRW

In (138), putting all \mathcal{J}_{0_i} as 1, we can obtain the density matrix in the RRW as^{‡‡}

$$\hat{\rho}_{\mathrm{R}} = \mathrm{Tr}_{\mathrm{L}} \left[|0_{\mathrm{M}}\rangle \langle 0_{\mathrm{M}}| \right] = \frac{e^{-\beta H_{\mathrm{R}}}}{\mathrm{Tr}_{\mathrm{R}}(e^{-\beta \hat{H}_{\mathrm{R}}})},\tag{140}$$

where $\beta = 2\pi/a$. From this, we can see that the Minkowski ground state in the RRW is the density matrix in temperature β^{-1} . Therefore, we can conclude that the U(1) gauge field in a constant accelerated system with the acceleration *a* will feel the Unruh temperature $\beta^{-1} = a/2\pi$ as well.

8 Summary

To briefly summarize this study, since the Unruh temperature has been described around 1975 [1, 2, 3] up until the present, while the canonical quantizations of the scalar and spinor fields have been performed, that of the gauge field has not been done, in the Rindler coordinates. As those three fields are the fundamental fields in the expression of the Lorentz group, it is desirable that the canonical quantization of the gauge field are also performed. Therefore, we have tackled this problem in this study.

It can be considered that the integrals appearing in the KG inner-product of the mode-solutions of the U(1) gauge field in the Rindler coordinates have remained unclear (those integrals are not even included in [51]). This means that the KG inner-product cannot be concretely performed and the normalization constants of the mode-solutions cannot be determined, which are crucial in actually performing the canonical quantization of the U(1) gauge field in the Rindler coordinates.

In this study, calculating those integrals, the normalized mode-solutions of the U(1) gauge field have been obtained in the Lorentz-covariant gauge in all directions of space-

by

where roughly $[a_i^{(R)}, a_i^{(R)\dagger}] \sim 1$. Using (132), (136a) - (136b) = $(a_i^{(R)} - a_i^{(L)\dagger}e^{-\pi p}) |0_L\rangle \otimes |0_R\rangle = 0$, while

time within the Rindler coordinates, and the canonical quantization of the U(1) gauge field in the Rindler coordinates has been performed.

Based on those calculations, we have shown that the coefficients of the normalized mode-solutions of the U(1) gauge field have the role of the creation/annihilation operators in the Rindler coordinates. Therefore, the U(1) gauge field in the constant accelerated system will feel the Unruh temperature as well.

Regarding the future directions which can be immediately derived from this study, extending this study to the non-Abelian gauge theory is considered. However, it is well known that in the non-Abelian gauge theory in the Minkowski coordinates, the BRST invariant Lagrangian can be formulated, but the equations of motion cannot be analytically solved. Therefore, in the case that this study is extended to the non-Abelian gauge theory, it would be probably possible to formulate the BRST invariant Lagrangian, however it would be impossible to obtain the classical solutions of the gauge fields. As a study in which the creation/annihilation operators of the U(1) gauge field in the Rindler coordinates are active, issues concerning photon antibunching can be considered. Currently, many ways to detect the Unruh effect have been investigated, and this would be interesting as one of those new ways.

A Analysis of path-integrals from (41) by replacing the Coulomb gauge to a Lorentz covariant gauge

Let us replace the Coulomb gauge in (41), which is the part Ω_{Coulomb} in the text under (41), to the Lorentz-covariant gauge. The Lorentz-covariant gauge which we will consider is

$$f[A^{\mu}(x)] = \mathcal{C}(x), \quad f[A^{\mu}(x)] \equiv \nabla_{\mu}A^{\mu}(x), \tag{141}$$

where the gauge to be considered as the Lorentz-covariant gauge in the Minkowski coordinates is usually $\partial_{\mu}A^{\mu}$, and this f is the extension of this to the Rindler coordinates; therefore ∇_{μ} in this f is the gravitational one, which does not include the gauge field. Cis some real function (since C is finally integrated out as seen in (148), there is no need to specify C).

Then, the inverse of the Faddeev-Popov determinant is given as

$$\Delta_{\rm FP}[A^{\mu}]^{-1} = \int \mathcal{D}U \prod_{x \in {\rm RRW}/{\rm FRW}} \delta(f[A^{U\mu}] - \mathcal{C}), \qquad (142)$$

where $A^{U\mu}$ denotes a gauge transformed A^{μ} such as $A^{\mu} + \partial^{\mu}U$. Under the assumption that A^{U} satisfying f = C exists only in the neighborhood of U = 1, $\Delta_{\text{FP}}[A^{\mu}]$ can be given as follows:

where this Det is the functional determinant of the functions in the RRW or FRW. Here, note that since ∇_{μ} in f does not include the gauge fields if the gauge field is the U(1), accordingly $\Delta_{\rm FP}[A]$ does not include the gauge fields if the gauge field is the U(1), which leads to a situation where the gauge and ghost fields do not couple each other (as can be seen from (147)). Therefore, we denote $\Delta_{\rm FP}[A^{\mu}]$ as $\Delta_{\rm FP}$ in what follows.

Then, inserting the unity obtained from (142) into (41), and exploiting the gauge invariance, (41a) and (41b) can be given as follows:

$$\int \mathcal{D}U \prod_{x \in \text{FRW}} \left[\delta(\chi^{(2)}) \right] = \prod_{x^1} \left(\text{Det} \left[\nabla_k \partial^k \, \delta^3(\vec{x} - \vec{y}) \right] \right)^{-1}, \tag{145b}$$

where it is assumed that $A^{U\mu}$ satisfying $\chi^{(2)} = 0$ exists only in the neighborhood of U = 1; $\delta^3(\vec{x} - \vec{y})$ are defined in (31). Since (145a) and (145b) are the inverse of $\prod_{x^0/x^1} M_c$ given in (33a) and (33b) respectively, (144a) and (144b) can be given as follows:

$$\cdot (144a) = \int \mathcal{D}A \, \Delta_{\rm FP} \prod_{x \in \rm RRW} \left[\delta(f[A^{\mu}] - \mathcal{C}) \right] \cdot \exp\left[i \int_{\rm RRW} d^4x \, \sqrt{-g} \, \mathcal{L}_{\rm U(1)} \right].$$
(146a)

$$\cdot (144b) = \int \mathcal{D}A \, \Delta_{\mathrm{FP}} \prod_{x \in \mathrm{RRW}} \left[\delta(f[A^{\mu}] - \mathcal{C}) \right] \cdot \exp\left[i \int_{\mathrm{RRW}} d^4x \, \sqrt{-g} \, \mathcal{L}_{\mathrm{U}(1)} \right].$$
(146b)

Reweighting $\Delta_{\rm FP}[A]$ in (146a) and (146b) using the ghost and anti-ghost fields c and \bar{c} as

$$\Delta_{\rm FP} = \int \mathcal{D}c \,\mathcal{D}\bar{c} \,\exp\left[i \int_{\rm RRW/FRW} d^4x \,\sqrt{-g} \,i \,\bar{c} \,\nabla_\mu \partial^\mu c\right],\tag{147}$$

we incorporate the contribution of $\Delta_{\rm FP}$ into the Lagrangian. Then, inserting the unity defined as

$$1 = \int \mathcal{D}B \,\mathcal{D}\mathcal{C} \exp\left[\int_{\text{RRW/FRW}} d^4x \sqrt{-g} \left(B \,\mathcal{C} + B^2/2\right)\right],\tag{148}$$

we integrate out C, where C in (148) is identified with C in the Lorentz-covariant gauge in (141). From the form of the path-integral obtained performing these, we can obtain the Lagrangian of the U(1) gauge field in the Lorentz-covariant gauge in the Rindler coordinates given in (18).

B Integral formulas

In this Appendix, we give the integral formulas used in Sec.4.3 to determine the normalization constants in the mode-solutions of the U(1) gauge field in the four regions in the Rindler coordinates. The integral formulas in this Appendix are essential in the calculation of the KG inner-product between those mode-solutions. We have obtained those in this study to calculate those KG inner-products.

First, we note the integrals and their results in the following:

$$\int_{0}^{\infty} dx \, x^{-1} J_{iu}(x) J_{iv}(x) = \frac{\sinh(\pi u)}{u} \delta(u+v), \qquad (149a)$$

$$\int_{0}^{\infty} dx \, x^{-3} J_{iu}(x) J_{iv}(x) = -\frac{\sinh(\pi u)}{2u(1+u^2)} \delta(u+v), \quad (149b)$$

$$\int_{0}^{\infty} dx \, x^{-2} J_{iu}(x) (J_{-1+iv}(x) - J_{1+iv}(x)) = -\frac{\sinh(\pi u)}{u(1+u^2)} \delta(u+v), \quad (149c)$$

$$\int_0^\infty dx \, x^{-1} (J_{-1+iu}(x) - J_{1+iu}(x))(u \leftrightarrow v) = \frac{2u \sinh(\pi u)}{1+u^2} \delta(u+v). \tag{149d}$$

$$\int_{0}^{\infty} dx \, x^{-1} K_{iu}(x) K_{iv}(x) = \frac{1}{2u} \frac{\pi^2}{\sinh(\pi u)} \delta(u-v), \qquad (150a)$$

$$\int_{0}^{\infty} dx \, x^{-3} K_{iu}(x) K_{iv}(x) = \frac{1}{4u(1+u^2)} \frac{\pi^2}{\sinh(\pi u)} \delta(u-v), \qquad (150b)$$

$$\int_0^\infty dx \, x^{-2} K_{iu}(x) (K_{-1+iv}(x) + K_{1+iv}(x)) = -\frac{1}{2u(1+u^2)} \frac{\pi^2}{\sinh(\pi u)} \delta(u-v), \quad (150c)$$

$$\int_0^\infty dx \, x^{-1} (K_{-1+iu}(x) + K_{1+iu}(x))(u \leftrightarrow v) = -\frac{u}{1+u^2} \frac{\pi^2}{\sinh(\pi u)} \delta(u-v), \quad (150d)$$

where $J_{iu}(x)$ and $K_{iu}(x)$ are the Bessel function of the first kind and the modified Bessel function of the second kind, respectively. (149) and (150) are used to determine the normalization constants of the mode-solutions in the FRW and RRW, respectively.

The equations same as (149a) and (150a) can be found in [51] (2 of 6.574 and 4 of 6.576), however the definition ranges of those and (149a) and (150a) are different [51]. Regarding the remaining (149b)-(149d) and (150b)-(150d), those are not included in [51].

In what follows, how we have obtained (149a) and (150a) is shown. The remaining (150b)-(149d) and (150b)-(150d) can be obtained in the same way.

Using the formula in [51], (149a) can be written as follows:

$$\int_{0}^{\infty} dx \, x^{-1} J_{iu}(x) J_{iv}(x) = \frac{\Gamma(1-\omega) \, \Gamma(\frac{i(u+v)}{2})}{2\Gamma(\frac{i(-u+v)}{2}+1) \, \Gamma(\frac{i(u+v)}{2}+1) \, \Gamma(\frac{i(u-v)}{2}+1)} \\ = \frac{-2i}{u^{2}-v^{2}} \frac{\sinh(\pi \frac{u-v}{2})}{\pi}$$
(151)

We put as $u + v = i\varepsilon$, then perform the expansion around $\varepsilon = 0$ to the leading-order.

$$(153) = \frac{1}{u\sinh(\pi u)} \frac{1}{i\pi i\varepsilon},\tag{152}$$

 $\frac{1}{i\pi}\frac{1}{i\varepsilon}$ in the last line can be put as $\delta(u+v)$. As a result, (149a) can be obtained. Next, using the formula in [51], (150a) can be written as follows:

$$\int_{0}^{\infty} dx \, x^{-(1-\omega)} K_{iu}(x) K_{iv}(x)$$

$$= \frac{2^{-2-(1-\omega)}}{\Gamma(1-(1-\omega))} \Gamma(\frac{1-(1-\omega)+i(u+v)}{2}) \Gamma(\frac{1-(1-\omega)+i(-u+v)}{2})$$

$$\times \Gamma(\frac{1-(1-\omega)+i(u-v)}{2}) \Gamma(\frac{1-(1-\omega)-i(u+v)}{2}), \quad (153)$$

where ω represents some infinitesimal quantity. We can equate all ω to zero except for that in $\Gamma(\omega)$. As a result, (153) can be expressed as follows:

$$(153) = \frac{2^{-3}}{\Gamma(\omega)} \Gamma(\frac{i(u+v)}{2}) \Gamma(\frac{i(-u+v)}{2}) \Gamma(\frac{i(u-v)}{2}) \Gamma(\frac{-i(u+v)}{2})$$
$$= \frac{2^{-3}}{\Gamma(\omega)} \frac{2\pi}{i\varepsilon \sinh(\frac{\pi}{2}i\varepsilon)} \frac{\pi}{u \sinh(\pi u)}$$
$$= \frac{1}{i\pi} \frac{1}{i\varepsilon} \frac{\pi^2}{2u \sinh(\pi u)},$$
(154)

where we put as $u - v = i\varepsilon$, then performed the expansions around $\omega = 0$ and $\varepsilon = 0$ to the leading-order, respectively, and identified ω with ε . $\frac{1}{i\pi} \frac{1}{i\varepsilon}$ can be put as $\delta(u - v)$. As a result, (150a) can be obtained.
