A NEW INVARIANT FOR A CYCLE OF AN INTERVAL MAP

ABSTRACT. We propose a new invariant for a cycle of an interval map $f : [0, 1] \rightarrow [0, 1]$, called its unfolding number.

1. INTRODUCTION

In his 1964 legendary paper [\[19\]](#page-19-0) (see [\[20\]](#page-19-1) for English Translation), O.M. Sharkovsky unveiled an elegant *rule* governing the *co-existence* of periods of periodic orbits (also known as cycles) of a continuous interval map. He introduced the following *order* among all *natural numbers*:

and proved the following theorem:

Theorem 1.1 ([\[19,](#page-19-0)[20\]](#page-19-1)). If $m, n \in \mathbb{N}$ with $m \geq n$, then if a continuous mapping $f : [0,1] \rightarrow [0,1]$ has a cycle of period m, then f must also have a cycle of period n.

Theorem [1.1](#page-0-0) reveals an intricate and concealed combinatorial framework that *governs* the *disposition* of cycles of a continuous interval map and led to the inception of a new direction of research in the theory of dynamical systems called combinatorial dynamics.

Future research stemming from Theorem [1.1](#page-0-0) could branch out in numerous directions. For instance, one might *replace* the *interval* with a more general space or replace periodic orbits with more general orbits (e.g., homoclinic trajectories). Additionally, one could strive to discover a more "refined" rule for the *coexistence* of *periodic orbits* in a given continuous interval map than that provided by Theorem [1.1.](#page-0-0) For an extensive list of references and a comprehensive survey of the evolution of Theorem [1.1,](#page-0-0) its historical context, subsequent advancements, and implications in the *theory of dynamical systems*, one could refer to the books $[1]$ and $[11]$ and the paper $[9]$.

In this paper, we pursue the latter mentioned approach for *refining* Theorem [1.1.](#page-0-0) Let us discuss in details. Observe that Theorem [1.1](#page-0-0) elucidates how certain "type" of dynamical behaviour (here period) once exhibited by a map, forces some other "type" (period) and thus, the

question of "*co-existence*" among "*types*" becomes a question of "*forc*ing" among "types". However, "periods" offer only a coarse depiction of a cycle, as numerous cycles share the same period. A more nuanced approach to characterizing cycles, involves examining their cyclic permutations: cyclic permutation we get when we look at how the map acts on the points of the cycle, ordered from the left to the right; we identify cycles having the same underlying cyclic permutations and call the corresponding equivalence classes: patterns.

As it turns out (see [\[3\]](#page-18-3)), the *rule* for *co-existence* using this "*type*" is rather too detailed and doesn't allow for a transparent description. This motivates one to look for a, middle-of-the-road way of describing cycles: rotation theory, a way not as crude as periods but not as fine as permutations, which would still allow for a transparent description.

The concept of *rotation numbers* was historically first introduced by Poincaré for *circle homeomorphisms* (See [\[18\]](#page-19-2)). It was extended to circle maps of degree one by Newhouse, Palis and Takens (see [\[17\]](#page-19-3)), and then studied, e.g., in [\[2](#page-18-4)[,4](#page-18-5)[,12](#page-18-6)[,14–](#page-18-7)[16\]](#page-19-4). In a general setting, rotation numbers can be defined as follows: Let X be a *compact metric space* with a Borel σ -algebra, $\phi: X \to \mathbb{R}$ be a *bounded measurable function* (often called an *observable*) and $f : X \rightarrow X$ be a *continuous* map. Then for any $x \in X$ the set $I_{f,\phi}(x)$, of all sub-sequential limits of the sequence $\left\{\frac{1}{n}\sum_{i=0}^{n-1}\phi(f^i(x))\right\}$ is called the ϕ -rotation set of x. If $I_{f,\phi}(x) = {\rho_{\phi}(x)}$ is a singleton, then the number $\rho_{\phi}(x)$ is called the ϕ -rotation number of x. It is easy to see that the ϕ -rotation set, $I_{f,\phi}(x)$ is a closed interval for all $x \in X$. The union of all ϕ -rotation sets of all points of X is called the ϕ -rotation set of the map f and is denoted by $I_f(\phi)$. If x is an f-periodic point of period n, then its ϕ -rotation number $\rho_{\phi}(x)$ is well-defined, and a related concept of the ϕ -rotation pair of x can be introduced: the pair $\left(\frac{1}{n}\sum_{i=0}^{n-1}\phi(f^i(x)),n\right)$ is the ϕ -rotation pair of x .

The use of *rotation theory* in the study of *dynamical systems* is useful when our *rotation theory* is *complete*. This means that:

- (1) rotation set is convex;
- (2) rotation number of a cycle of period n is of the form $\frac{m}{n}$ where $m, n \in \mathbb{N}$;
- (3) if $\frac{m}{n}$ belongs to the *interior* of the *rotation set*, then there exists a cycle of period kn and rotation pair (km, kn) for every $k \in \mathbb{N}$.

Another way of looking at *rotation theory* is through *ergodic invari*-ant measures ([\[13\]](#page-18-8), [\[1\]](#page-18-0)). If P is a cycle of $f : [0,1] \rightarrow [0,1]$, we can look at the *ergodic measure* μ_P , *equidistributed* on P, that is, such that $\mu_P(\lbrace x \rbrace) = \frac{1}{n}$ for all $x \in P$, where *n* is the *period* of *P*. Let us call μ_P , a *CO-measure* [\[13\]](#page-18-8) (comes from "closed orbit"). Recall that for Borel measures on compact spaces one normally considers their weak topology defined by the continuous functions [\[13\]](#page-18-8). The following result follows:

Theorem 1.2 ([\[6\]](#page-18-9)). Suppose that $f : [0,1] \rightarrow [0,1]$ is a continuous interval map or a circle map with non-empty set of periodic points. Then any invariant probability measure μ for whom there exists a point x with $\mu(\omega_f(x)) = 1$, where $\omega_f(x)$ denotes omega limit set of x under f can be approximated by CO-measures arbitrary well. In particular, CO-measures are dense in the set of all ergodic invariant measures of f.

If the *dynamics* of f and the *observable* ϕ are related we can further deduce additional informations about ϕ -rotation sets, for instance, in the case of *circle degree one* case (see [\[15\]](#page-18-10), [\[1\]](#page-18-0)). Consider the circle $\mathbb{S} =$ \mathbb{R}/\mathbb{Z} with the natural projection $\pi : \mathbb{R} \to \mathbb{S}$. If $f : \mathbb{S} \to \mathbb{S}$ is continuous, then there is a *continuous map* $F_f : \mathbb{R} \to \mathbb{R}$ such that $F_f \circ \pi = \pi \circ f$. Such a map F_f is called a *lifting* of f. It is unique up to translation by an integer. An integer d with $F_f(X+1) = F_f(X) + d$ for all $X \in \mathbb{R}$ is called the *degree* of the map f and is independent of the choice of F . Conversely, maps $G : \mathbb{R} \to \mathbb{R}$ such that $G(X+1) = G(X) + d$ for every real X are said to be maps of the real line of degree d , can be defined independently, and are *semi-conjugate* by the same map $\pi : \mathbb{R} \to \mathbb{S}$ to the circle maps of degree d. In this paper we consider both maps of the circle and maps of the real line of degree one. Denote by \mathcal{L}_1 the set of all liftings of continuous degree one self-mappings of S endowed with the sup norm.

Given, a *continuous map*, $f : \mathbb{S} \to \mathbb{S}$, consider its *lifting* $F_f \in \mathcal{L}_1$. Define an *observable* $\phi_f : \mathbb{S} \to \mathbb{R}$ so that $\phi_f(x) = F_f(X) - X$ for any $x \in \mathbb{S}$ and $X \in \pi^{-1}(x) \in \mathbb{R}$; then ϕ_f is well-defined, the classical rotation set of a point $x \in \mathbb{S}$ is simply the ϕ_f -rotation set $I_{f, \phi_f}(x) = I_f(x)$. It is easy to see that $I_f(x) = \left\{ \overline{\rho_{F_f}}(X), \rho_{F_f}(X) \right\}$ where $\overline{\rho_{F_f}}(X) = \limsup$ n→∞ $F_f^n(X) - X$ $\frac{\rho_{F_f}(X)}{n}$ and $\rho_{F_f}(X) = \liminf_{n \to \infty}$ $F_f^n(X) - X$ n . The numbers: $\overline{\rho_{F_f}}(X)$ and $\rho_{F_f}(X)$ are respectively called upper and lower rotation numbers of $X \in \mathbb{R}$ under $F_f : \mathbb{R} \to \mathbb{R}$ (equivalently of $x \in \mathbb{S}$ under $f : \mathbb{S} \to \mathbb{S}$. If $\overline{\rho_{F_f}}(X) = \rho_{F_f}(X) = \rho_{F_f}(X)$, we write $\rho_{F_f}(X)$, the *rotation number* of X under F_f (equivalently of x under $f : \mathbb{S} \to \mathbb{S}$).

Suppose $f^{n}(y) = y, y \in \mathbb{S}$, that is, y is a periodic point of $f : \mathbb{S} \to \mathbb{S}$ of period n. Then, for any $Y \in \pi^{-1}(y)$, $F_f^n(Y) = Y + m$ for some $m \in \mathbb{N}$ and hence $\overline{\rho_{F_f}}(Y) = \rho_{F_f}(Y) = \frac{m}{n}$. We call $\frac{m}{n}$, the *rotation number* of $Y \in \mathbb{R}$ under $F_f : \mathbb{R} \to \mathbb{R}$ (equivalently of $y \in \mathbb{S}$ under $f : \mathbb{S} \to \mathbb{S}$) and (m, n) the rotation pair of $Y \in \mathbb{R}$ under $F_f : \mathbb{R} \to \mathbb{R}$ (equivalently of $y \in \mathbb{S}$ under $f : \mathbb{S} \to \mathbb{S}$.

Rotation pairs can be represented in an interesting way using the notations used in [\[8\]](#page-18-11). We represent the *rotation pair* $rp(x) = (mp, mq)$ with p, q coprime and m being some natural number as a pair (t, m) where $t = \frac{p}{q}$ $\frac{p}{q}$. We call the later pair a *modified-rotation pair* (*mrp*) and write $mrp(x) = (t, m)$. We then think of the real line with a prong attached at each rational point and the set $\mathbb{N} \cup \{2^{\infty}\}\$ marked on this prong in the *Sharkovsky ordering* $\frac{1}{8}$ with 1 *closest* to the *real line* and 3 farthest from it. All points of the real line are marked 0; at irrational points we can think of degenerate prongs with only 0 on them. The union of all *prongs* and the *real line* is denoted by M. Thus, a modified rotation pair (t, m) corresponds to the specific element of M, namely to the number m on the *prong* attached at t . However, no *rotation pair* corresponds to $(t, 2^{\infty})$ or to $(t, 0)$. Then, for (t_1, m_1) and (t_2, m_2) , in M, the convex hull $[(t_1, m_1), (t_2, m_2)]$ consists of all modified rotation *pairs* (t, m) with t strictly between t_1 and t_2 or $t = t_i$ and $m \in Sh(m_i)$ for $i = 1, 2$ (See Figure [1\)](#page-3-0).

Let $F \in \mathcal{L}_1$. Let $mrp(F)$ be the set of modified rotation pairs of all *lifted cycles* of F. Clearly, $mrp(F) \subset M$. The following theorem holds:

Theorem 1.3 ([\[15\]](#page-18-10)). Let $F \in \mathcal{L}_1$. Then there are elements (t_1, m_1) and (t_2, m_2) of \overline{M} such that $mrp(F) = [(t_1, m_1), (t_2, m_2)]$ and if t_i is rational, then $m_i \neq 0$ for $i = 1, 2$. Moreover, for any set of the above form there exists $F \in \mathcal{L}_1$ with $mrp(F)$ equal to this set.

Results similar to Theorem [1.3](#page-3-1) were also proven for maps of intervals in [\[7\]](#page-18-12) when a version of rotation numbers for interval maps called over*rotation numbers* was introduced using a special *observable* χ . Let $f : [0,1] \rightarrow [0,1]$ be a continuous interval map, $Per(f)$ be its set of periodic points, and $Fix(f)$ be its set of fixed points. It is easy to see that if $Per(f) = Fix(f)$, then the *omega limit set*, $\omega(y)$ is a fixed point for any y. So, we can assume that $Per(f) \neq Fix(f)$. Now, define:

$$
\chi(x) = \begin{cases} \frac{1}{2} & \text{if } (f(x) - x)(f^2(x) - f(x)) \leq 0, \\ 0 & \text{if } (f(x) - x)(f^2(x) - f(x)) > 0. \end{cases}
$$

For any non-fixed periodic point y of period $p(y)$, the integer $l(y)$ = p(\sum $y) - 1$ $\chi(f^i(y))$ is at most $\frac{p(y)}{2}$ and is the same for all points from the orbit

 $i=0$ of y. The quantity $\frac{l(y)}{p(y)} = \text{orn}(y)$ is called the *over-rotation number* of y and the pair $\text{or } p(y) = (l(y), p(y))$ is called the *over-rotation pair* of y. In an over-rotation pair (p, q) , p and q are integers and $0 < \frac{p}{q} \leq \frac{1}{2}$ $\frac{1}{2}$.

Like before, we can transform all *over-rotation pairs* of *cycles* of a given

map f into modified over-rotation pairs of f and denote the modified over-rotation pair of a cycle P and the set of all modified over-rotation *pairs* of cycles of f by $mop(P)$ and $mop(f)$ respectively. Then, again $mop(f) \subset M$ and the following theorem holds:

Theorem 1.4 ([\[7\]](#page-18-12)). If $f : [0,1] \rightarrow [0,1]$ is a continuous interval map with a non-fixed periodic point, then $mop(f) = [(t_1, m_1), (\frac{1}{2})]$ $(\frac{1}{2},3)]$ for some $(t_1, m_1) \in \mathbb{M}$. Moreover, for every $(t_1, m_1) \in \mathbb{M}$, there exists a continuous map $f : [0,1] \to [0,1]$ with $mop(f) = [(t_1, m_1), (\frac{1}{2})]$ $(\frac{1}{2}, 3)].$

Given an interval map f, denote by I_f , the *closure of the union of* over-rotation numbers of f-periodic points, and call I_f the over-rotation interval of f . By Theorem [1.1,](#page-0-0) any map f with a non-fixed periodic points has a cycle of period 2 and such as cycle has over-rotation number 1 $\frac{1}{2}$; by Theorem [1.4,](#page-4-0) if $\rho(P) = \frac{p}{q}$ for a cycle P then $\left[\frac{p}{q},\frac{1}{2}\right]$ $\frac{1}{2}$ $\subset I_f$; hence for any interval map f there exists a number r_f , $0 \leq r_f < \frac{1}{2}$ $\frac{1}{2}$, such that $I_f = [r_f, \frac{1}{2}]$ $\frac{1}{2}$. A cycle P is called over-twist if it does not force other cycles with the same over-rotation number. They are the analogues of twist cycles for interval maps. By [\[7\]](#page-18-12) and by properties of forcing *relation*, for any $\frac{p}{q} \in (r_f, \frac{1}{2})$ $\frac{1}{2}$, f has an *over-twist cycle* of *over-rotation* number $\frac{p}{q}$. We call a pattern π , an over-twist pattern if any cycle which *exhibits* it is an *over-twist* cycle. Now we discuss our plans for the paper.

In the papers [\[5\]](#page-18-13) and [\[10\]](#page-18-14), an *algorithm* to find out *over-rotation* interval of an interval map of modality less than or equal to 2 was concocted and the complete description of the dynamics of unimodal and bimodal over-twist patterns was corroborated. However, the task of determining the *over-rotation interval* for an *interval map* $f : [0, 1] \rightarrow$ $[0, 1]$ with modality greater than or equal to 3, along with elucidating over-twist patterns of the same modality, presents significant challenges.

This maneuvered us to develop a new *invariant* for a cycle of an interval map, amalgamating the essence of over-rotation theory of interval maps and rotation theory of degree one circle maps. We call this new invariant: unfolding numbers. The basic idea is as follows. Given a *continuous map* $f : [0,1] \rightarrow [0,1]$, we construct the map g_f : $[0, \frac{1}{2}]$ $\frac{1}{2}] \rightarrow [0, \frac{1}{2}]$ $\frac{1}{2}$ which is *conjugate* to the map f via the *linear* contraction $\lambda : [0,1] \rightarrow [0,\frac{1}{2}]$ $\frac{1}{2}$ defined by $\lambda(x) = \frac{x}{2}$. We call g_f , the miniature model map corresponding to the map f . We fold the unit square $[0, \frac{1}{2}]$ $\frac{1}{2} \times [0, \frac{1}{2}]$ $\frac{1}{2}$ containing the *graph* of g_f vertically across the line $y = \frac{1}{2}$ $\frac{1}{2}$. This yields a map p_f in $[0, \frac{1}{2}]$ $\frac{1}{2}]\times\left[\frac{1}{2}\right]$ $\frac{1}{2}$, 1]. The *unit square* $[0, \frac{1}{2}]$ $\frac{1}{2} \times \left[\frac{1}{2}\right]$ $\frac{1}{2}$, 1 is now *folded horizontally* across $x = \frac{1}{2}$ $\frac{1}{2}$ to obtain a map q_f in $\left[\frac{1}{2}, 1\right] \times \left[\frac{1}{2}\right]$ $\frac{1}{2}$, 1]. Finally, the *unit square* $\left[\frac{1}{2}\right]$ $\frac{1}{2}$, 1 \times $\left[\frac{1}{2}\right]$ $\frac{1}{2}$, 1] is folded vertically across $y = 1$ to obtain a map r_f in $\left[\frac{1}{2}, 1\right] \times \left[1, \frac{3}{2}\right]$ $\frac{3}{2}$. Selecting parts of graph of the maps: g_f , p_f , q_f and r_f yields a *degree one map* $F_f : \mathbb{R} \to \mathbb{R}$ of the real line (for details see Section [3\)](#page-8-0). The unfolding number of a periodic orbit P of the map $f : [0, 1] \rightarrow [0, 1]$ is defined to to be rotation number of the lifted periodic orbit P' of F_f corresponding to P. We begin study of unfolding numbers for interval maps in this paper.

The paper is divided into 8 sections. The manuscript "*unfolds*" as follows:

- (1) Section [1,](#page-0-1) serves as the introductory segment of the paper, providing an initial *overview* and context for the subsequent content.
- (2) Section [2,](#page-5-0) lays the groundwork with essential preliminaries.
- (3) In Section [3](#page-8-0) ,we define unfolding numbers and enact the consistency of the theory.
- (4) In Section [4,](#page-11-0) we portray that, that the closure of the set of unfolding numbers of periodic orbits of a given interval map f forms an interval of the form $Unf(f) = [u_f, \frac{1}{2}]$ $\frac{1}{2}$ for some $u_f \geq 0$, called its *unfolding interval*. The *existence* of a *point* $z \in [0, 1]$ such that the map f restricted on the omega limit set $Z_f =$ $\omega_f(z)$ of z is *strictly ergodic*, and such that for any point $y \in Z_f$, the *unfolding number* of y under f coincides with u_f is also revealed.
- (5) It is a natural question to ask: can we characterize the *dynamics* of a periodic orbit of f given its unfolding number? For this, at the outset it is vital to see whether *unfolding number* of P can be read directly from the combinatorics of P without the need to construct the map F_f . We take precisely these questions in Section [5.](#page-14-0)
- (6) In Section [6,](#page-15-0) we introduce the idea of forced unfolding interval. We elucidate *patterns* for whom the *forced unfolding interval* is $[0, \frac{1}{2}]$ $\frac{1}{2}$.
- (7) In Section [7,](#page-16-0) we forge comparison between unfolding numbers and *over-rotation numbers*: we show that while these two *rota*tion numbers are disparate in flavor, there exists special patterns π_s called *sheer patterns*, for whom *unfolding numbers* equals over-rotation numbers!

From the form of unfolding interval $Unf(f)$, of a given interval map f, it is evident that a *single number*, u_f , encapsulates concealed information about the *dynamical complexity* of f. Further u_f can be computed using a straightforward algorithm for interval maps of any modality. Thus, unfolding numbers provides a "new" effective means of computing the dynamical complexity of an interval map which is invariant under topological conjugacy.

2. Preliminaries

2.1. **Notations.** In this paper, we specifically consider *continuous maps* $f : [0, 1] \rightarrow [0, 1]$ characterized by a unique point of absolute maximum, denoted by M_f , and a *unique point* of *absolute minimum*, denoted by m_f . Moreover, for any *periodic orbit* P of f, its *leftmost endpoint* is

represented by $le(P)$ and its *right end point* is denoted by $ri(P)$. Furthermore, for any *point* x and a map g , the *trajectory* of x under g , that is, the set $\{x, g(x), g^2(x), \dots\}$ is symbolized as $T_g(x)$. Clearly, if $T_q(x)$ is finite with q elements, x is periodic under g with period q and $P = T_q(x)$ is its periodic orbit. For a set A, let \overline{A} denotes its closure. Additionally, given a map $f : [0,1] \rightarrow [0,1], g_f : [0, \frac{1}{2}]$ $\frac{1}{2}] \rightarrow [0, \frac{1}{2}]$ $\frac{1}{2}$ and $F_f : \mathbb{R} \to \mathbb{R}$, respectively signify *miniature model map* and *heaved map* corresponding to the map f (as defined in Section [3\)](#page-8-0).

2.2. Forcing among patterns.

Definition 2.1. A pattern A forces pattern B if every continuous map having a cycle of pattern A has a cycle of pattern B. By [\[3\]](#page-18-3), forcing among patterns is a partial ordering.

A useful algorithm allows one to describe all patterns forced by a given pattern A . Namely, consider a cycle P of pattern A ; assume that *leftmost* and *rightmost points* of P are a and b respectively. Every component of $[a, b] \setminus P$ is said to be a P-basic interval. Extend the map from P to the interval $[a, b]$ by defining it *linearly* on each P-basic *interval* and call the resulting map f_P , the P-linear map. The following result follows:

Theorem 2.2 ([\[1,](#page-18-0)[3\]](#page-18-3)). The patterns of all cycles of f_P are exactly the patterns forced by the pattern of P

2.3. Loops of intervals.

Definition 2.3. Let $\{I_n\}$, $n \geq 0$ be a sequence of closed intervals such that $f(I_i) \supset I_{i+1}$ for $j \geq 0$; then we say that $\{I_n\}, n \geq 0$ is an f−chain or simply a chain of intervals. If a finite chain of intervals $\alpha = \{I_0, I_1, \ldots, I_{k-1}\}\$ is such that $f(I_{k-1}) \supset I_0$, then we call $\alpha =$ $\{I_0, I_1, \ldots, I_{k-1}\},$ an f-loop or simply a loop of intervals.

Lemma 2.4 ([\[1\]](#page-18-0)). Let $\alpha = \{I_0, I_1, \ldots, I_{k-1}\}\$ be a loop of intervals. Then there is a periodic point $x \in I_0$ such that $f^j(x) \in I_j$ for $0 \leqslant j \leqslant j$ $k-1$ and $f^k(x) = x$. $Q = \{x, f(x), f^2(x), \ldots, f^{k-1}(x)\}$ is called the periodic orbit associated with the loop α .

2.4. Results on Degree one circle maps. Let's examine some properties of degree one circle maps that are pertinent to our discussion in this paper. Let \mathcal{L}_1 represents the *collection* of all *liftings* of *continu*ous degree one self-mappings of S under the sup norm, while $\mathcal{L}_1' \subset \mathcal{L}_1$ consists of *non-decreasing elements* of \mathcal{L}_1 . Subsequently, the ensuing result follows:

Theorem 2.5 ([\[1,](#page-18-0)[15\]](#page-18-10)). If $F_f \in \mathcal{L}'_1$ is a lifting of a circle map $f : \mathbb{S} \to \mathbb{S}$ then $\rho_{F_f}(x)$ exists for all $x \in \mathbb{R}$ and is independent of x. Moreover, it is rational if and only if $f : \mathbb{S} \to \mathbb{S}$ has a periodic point.

This number is called the rotation number of the map F_f and denoted by $\rho(F_f)$. Further, we can show:

Lemma 2.6 ([\[1,](#page-18-0)[15\]](#page-18-10)). The function $\chi : \mathcal{L}'_1 \to \mathbb{R}$ defined by $\chi(F) = \rho(F)$ for all $F \in \mathcal{L}'_1$ is continuous.

Definition 2.7 ([\[1,](#page-18-0)[15\]](#page-18-10)). For $F \in \mathcal{L}_1$, we define maps $F_l, F_u \in \mathcal{L}'_1$ by "pouring water" from below and above respectively on the graph of F respectively as follows: $F_{\ell}(x) = \inf\{F(y) : y \geq x\}$ and $F_u(x) =$ $\sup\{F(y): y \leq x\}$. We call the maps: F_{ℓ} and F_{u} , lower bound map and upper bound map, corresponding to the *degree one* map F respectively.

Let $Const(G)$ be the union of all *open intervals* on which G is constant.

Theorem 2.8 ([\[1](#page-18-0)[,15\]](#page-18-10)). Then the following statements are true:

- (1) Let $F \in \mathcal{L}_1$. Then, $F_{\ell}(x) \leq F(x) \leq F_u(x)$ for every $x \in \mathbb{R}$.
- (2) Let $F, G \in \mathcal{L}_1$ with $F \leq G$, then $F_\ell \leq G_\ell$ and $F_u \leq G_u$.
- (3) Let $F \in \mathcal{L}'_1$. Then, $F_\ell = F_u = F$.
- (4) The maps $F \mapsto F_{\ell}$ and $F \mapsto F_u$ are Lipschitz continuous with constant 1 in the sup norm.
- (5) If $F_{\ell}(x) \neq F(x)$ for some $x \in \mathbb{R}$, then $x \in Const(F_{\ell})$; similarly for F_u ,
- (6) $Const(F) \subset Const(F_{\ell}) \cap Const(F_u)$

Definition 2.9. Given, a *continuous map*, $f : \mathbb{S} \to \mathbb{S}$, its lifting $F_f \in$ \mathcal{L}_1 and point $y \in \mathbb{S}$, periodic with rotation number $\frac{m}{n}$ and rotation pair (m, n) , the set $P' = \pi^{-1}(P) \subset \mathbb{R}$, where $P \subset \mathbb{S}$ is the periodic orbit of $y \in \mathbb{S}$ and $\pi : \mathbb{R} \to \mathbb{S}$ is the natural projection, is called lifted periodic *orbit* of P (equivalently of $y \in \mathbb{S}$) under $F_f : \mathbb{R} \to \mathbb{R}$.

We call $\frac{m}{n}$ and (m, n) respectively *rotation number* and *rotation pair* of $P \subset \mathbb{S}$ under $f : \mathbb{S} \to \mathbb{S}$ (equivalently of P' under $F_f : \mathbb{R} \to \mathbb{R}$).

Conversely, *lifted periodic orbits* can also defined independently: a set $Q' \subset \mathbb{R}$ is a lifted periodic orbit of a degree one map F with period q and rotation number $\frac{p}{q}$ if for any $z \in Q'$, $F^q(z) = z + p$. In such a case, there always exists a *periodic orbit* $Q \subset \mathbb{S}$ of $f : \mathbb{S} \to \mathbb{S}$ period q and *rotation number* $\frac{p}{q}$ such that: $Q' = \pi^{-1}(Q)$.

Theorem 2.10 ([\[1](#page-18-0)[,15\]](#page-18-10)). If $F \in \mathcal{L}'_1$ is a lifting of a circle map $f : \mathbb{S} \to \mathbb{S}$ and $\rho(F) = \frac{k}{n}$ for coprime integers k, n, then f has a cycle P of period n such that the lifted cycle $\pi^{-1}(P)$ of F is disjoint from Const (F) .

Theorem 2.11 ([\[1,](#page-18-0)[15\]](#page-18-10)). Let $F \in \mathcal{L}_1$.

Define: $F_{\mu} = (\min(F, F_{\ell} + \mu))_u$, for $\mu \in [0, \lambda]$ and $\lambda = \sup_{x \in \mathbb{R}} (F F_{\ell}(x)$.

Then the following results follow:

- (1) $F_{\mu} \in \mathcal{L}'_1$ for all $\mu \in [0, \lambda],$
- (2) $F_0 = F_\ell$ and $F_\lambda = F_u$
- (3) the map $\mu \mapsto F_{\mu}$ is Lipschitz continuous with constant 1,
- (4) the map $\mu \mapsto \rho(F_{\mu})$ is continuous,
- (5) if $\mu \leq \lambda$, then $F_{\mu} \leq F_{\lambda}$,
- (6) each F_{μ} coincides with F outside Const (F_{μ}) ,
- (7) $Const(F) \subset Const(F_u)$ for each μ .

Definition 2.12 ([\[1](#page-18-0)[,15\]](#page-18-10)). Let $F \in \mathcal{L}_1$. Then, define upper-rotation set of F by $Rot(F) = \{\rho_F(x) : x \in \mathbb{R}\};$ lower-rotation set of F by $Rot(F) = \{\rho_F(x) : x \in \mathbb{R}\}.$ Also, define *rotation set* of F by $Rot(F) =$

 $\{\rho_F(x): x \in \mathbb{R} \text{ such that } \rho_F(x) = \rho_F(x) = \rho_F(x)\}\$ are respectively the lower bound map and upper bound map corresponding to the *degree* one map F.

Theorem 2.13 ([\[1,](#page-18-0)[15\]](#page-18-10)). Let $F \in \mathcal{L}_1$. Then, $\overline{Rot(F)} = Rot(F)$ $Rot(F) = [\rho(F_{\ell}), \rho(F_u)]$ where $F_{\ell}(x) = \inf\{F(y) : y \geq x\}$ and $\overline{F_u(x)} =$ $\sup\{F(y): y \leqslant x\}$

Corollary 2.14 ([\[1](#page-18-0)[,15\]](#page-18-10)). The endpoints of $Rot(F)$ depend continuously on $F \in \mathcal{L}_1$.

3. Unfolding numbers: Definition and Consistency

We begin by defining *unfolding numbers* in details. Consider a *con*tinuous map $f : [0, 1] \rightarrow [0, 1]$ with a unique point of absolute maximum M_f and a *unique point* of *absolute minimum* m_f with $f(M_f) = 1$ and $f(m_f) = 0$; assume for definiteness that $M_f < m_f$. Observe that from the standpoint of co-existence of cycles of interval maps, this is the most important case. Indeed, $m_f > M_f$ implies that there exists two disjoint open intervals whose closures contain their union in their *images* ("1-dimensional horseshoe"), f has the entropy at least $\ln 2$, cycles of all periods. So, f is a chaotic map. Thus, the case $M_f < m_f$ is the only interesting case (even though our construction stated below works in the case $M_f > m_f$ too).

Consider the *map* $g_f : [0, \frac{1}{2}]$ $\frac{1}{2}] \to [0, \frac{1}{2}]$ $\frac{1}{2}$, which is *conjugate* to the map $f:[0,1] \to [0,1]$ via the linear contraction $\lambda:[0,1] \to [0,\frac{1}{2}]$ $\frac{1}{2}$, defined by $\lambda(x) = \frac{x}{2} \in [0, \frac{1}{2}]$ $\frac{1}{2}$. We call g_f , the *miniature model map* corresponding to the map f. Let $g_f(0) = c_g, g_f(\frac{1}{2})$ $(\frac{1}{2}) = d_g$. Then, the map g_f also has a unique point of absolute maximum M_g and a unique point of absolute minimum m_g with $f(M_g) = \frac{1}{2}$ and $\tilde{f}(m_g) = 0$; also $M_g < m_g$ (See Figure [2\)](#page-9-0).

Define $p_f : [0, \frac{1}{2}]$ $\frac{1}{2}$ \rightarrow $\left[\frac{1}{2}\right]$ $\frac{1}{2}$, 1] by $p_f(x) = 1 - g_f(x)$. Clearly, $p_f(0) = 1 - c_g$, $p_f(M_g) = \frac{1}{2}, p_f(m_g) = 1, p_f(\frac{1}{2})$ $(\frac{1}{2}) = 1 - d_g$. The graph of $p_f(x)$ is obtained by reflecting vertically, the graph of $g_f(x)$ with the respect with the line $y=\frac{1}{2}$ $\frac{1}{2}$.

Define $q_f : [\frac{1}{2}, 1] \rightarrow [\frac{1}{2}]$ $\frac{1}{2}$, 1] by $q_f(x) = p_f(1-x) = 1-f(1-x)$. Clearly, $q_f(\frac{1}{2})$ $(\frac{1}{2}) = 1 - d_g$, $q_f(1 - m_g) = 1$, $q_f(1 - M_g) = \frac{1}{2}$, $q_f(1) = 1 - c_g$. The graph of $q_f(x)$ is obtained by reflecting horizontally, the graph of $p_f(x)$ across the line $x=\frac{1}{2}$ $rac{1}{2}$.

Define $r_f : [\frac{1}{2}, 1] \rightarrow [1, \frac{3}{2}]$ $\frac{3}{2}$ by $r_f(x) = 2 - q_f(x) = 1 + f(1-x)$. Clearly, $r_f(\frac{1}{2})$ $\frac{1}{2}$) = 1+d_g, r_f(1-m_g) = 1, r_f(1-M_g) = $\frac{3}{2}$, r_f(1) = 1+c_g. Thus, the graph of r_f is obtained from the graph of $q_f(x)$ by reflecting *vertically* across the line $y = 1$.

We now *construct* a map $F_f : [0,1] \rightarrow [1,\frac{3}{2}]$ $\frac{3}{2}$] as follows (See Figure [2\)](#page-9-0):

$$
F_f(x) = \begin{cases} g_f(x) & \text{if } 0 \leq x \leq M_g \\ p_f(x) & \text{if } M_g \leq x \leq \frac{1}{2}. \\ q_f(x) & \text{if } \frac{1}{2} \leq x \leq 1 - m_g. \\ r_f(x) & \text{if } 1 - m_g \leq x \leq 1. \end{cases}
$$

Observe that $F_f(1) = F_f(0) + 1$. Extend $F_f : \mathbb{R} \to \mathbb{R}$ by $F_f(x+1) =$ $F_f(x) + 1$ for all $x \in \mathbb{R}$. We shall call the map F_f , the heaved map corresponding to the map f. By construction $F_f(x)$ is a degree one map of the real line (See Figure [2\)](#page-9-0).

Definition 3.1. For $x \in [0, 1]$, the upper unfolding number of x under $f : [0,1] \rightarrow [0,1],$ denoted by $\overline{u_f(x)}$, is defined as the upper rotation *number* of $\lambda(x) = \frac{x}{2} \in [0, \frac{1}{2}]$ $\frac{1}{2}$ under $F_f : \mathbb{R} \to \mathbb{R}$, that is, $\overline{u_f(x)} =$ $\rho_{F_f}(\lambda(x)) = \lim_{n \to \infty} \sup$ $F^{n}(\lambda(x)) - \lambda(x)$ \overline{n} .

Similarly, the *lower unfolding number* of $x \in [0, 1]$ under $f : [0, 1] \rightarrow$ $[0, 1]$, denoted by $u_f(x)$, is defined as the *lower rotation number* of $\lambda(x) = \frac{x}{2} \in [0, \frac{1}{2}]$ $\frac{1}{2}$ under $F_f : \mathbb{R} \to \mathbb{R}$, that is, $u_f(x) = \rho_{F_f}(\lambda(x)) =$ $\lim_{n\to\infty}$ inf $\frac{F^n(\lambda(x))-\lambda(x)}{n}$ n .

Clearly, $u_f(x) \leq \overline{u_f(x)}$ for all $x \in [0, 1]$. The set $\mathcal{U}_f(x) = \{u_f(x), \overline{u_f(x)}\}$ is called the unfolding set of x under $f : [0,1] \rightarrow [0,1]$. If $u_f(x) =$

 $u_f(x) = u_f(x)$ for some $x \in [0,1]$, we call: $u_f(x)$, the unfolding number of $x \in [0, 1]$ under $f : [0, 1] \to [0, 1]$.

Definition 3.2. Let $f : [0,1] \rightarrow [0,1]$. Then, define upper-unfolding set of f by $\overline{Unf(f)} = {\overline{u_f(x)} : x \in [0,1]}$; lower-unfolding set of f by $Unf(f) = {u_f(x) : x \in [0,1]}$. Also, define unfolding set of f by $Unf(f) = \{u_f(x) : x \in \mathbb{R} \text{ such that } \overline{u_f(x)} = u_f(x) = u_f(x)\}.$

We now establish the *consistency* of the theory of *unfolding numbers*. We begin with a simple *lemma*:

Lemma 3.3. Given any $z \in \mathbb{R}$, there exists $x \in [0, \frac{1}{2}]$ $\frac{1}{2}$ such that $F_f^n(x) = z$ for some $n \in \mathbb{N}$.

Proof. Construction of the map F_f reveals that for any $\ell \in \lceil n \rceil$ π 2 $(n + 1)\frac{\pi}{2}$ 2 i , $n \in \mathbb{Z}$, there exists $\ell' \in [(n-1)\frac{\pi}{2}]$ 2 , n π 2 such that $F_f(\ell') = \ell$. Hence, the result follows. \Box

Definition 3.4. Let $F \in \mathcal{L}_1$ and $y, z \in \mathbb{R}$. The trajectories $T_F(y)$ and $T_F(z)$ are said to be *coincident*, if $F^i(y) = F^i(z)$ for all $i \geq 0$, and eventually coincident if $F^{i}(y) = F^{i}(z)$ for all $i \geq n_0$ for some $n_0 \in \mathbb{N}$.

The following *result* follows easily and its *proof* is left to the reader:

Lemma 3.5. Let $F \in \mathcal{L}_1$ and $y, z \in \mathbb{R}$. Suppose the trajectories $T_F(y)$ and $T_F(z)$ are coincident or eventually coincident, then the following holds:

- (1) $\overline{\rho_F(y)} = \overline{\rho_F(z)}$ and $\rho_F(y) = \rho_F(z)$.
- (2) if the trajectories $T_F(y)$ and $T_F(z)$ are lifted periodic orbits under F, they have the same period, same rotation pair and same modified rotation pair.

Theorem 3.6. If P is a periodic orbit of $f : [0, 1] \rightarrow [0, 1]$ of period q, then the unfolding number of each point of P is same and is of the form $\frac{p}{q}$ for $p, q \in \mathbb{N}$.

Proof. Let $x \in P$. Then, $\lambda(x) \in [0, \frac{1}{2}]$ $\frac{1}{2}$] is *periodic* under $g_f : [0, \frac{1}{2}]$ $\frac{1}{2}$ \rightarrow $[0, \frac{1}{2}]$ $\frac{1}{2}$ with same period q. Construction of the map $F_f : \mathbb{R} \to \mathbb{R}$, then implies that, the *trajectory* $T_{F_f}(\lambda(x))$ of $\lambda(x)$ under F_f is a lifted periodic orbit of F_f of the same period q. Suppose the rotation number of $\lambda(x)$ under F_f is $\frac{p}{q}$, then, definition [3.1,](#page-9-1) implies that, the *unfolding number* of x under \overrightarrow{f} is $\frac{p}{q}$, and hence the result follows. \Box

Definition 3.7. We call $\frac{p}{q}$, $p, q \in \mathbb{N}$ (from Theorem [3.6\)](#page-10-0), the *unfolding* number of the periodic orbit $P = T_f(x)$ of f and the ordered pair (p, q) , the unfolding pair of P; we write: $un(P) = \frac{p}{q}$ and $up(P) = (p, q)$. If $\frac{p}{q} = \frac{r}{s}$ $\frac{r}{s}$, where r and s are *coprime* and $\frac{p}{r} = \frac{q}{s} = m \in \mathbb{N}$, then we call the *ordered pair* $(\frac{r}{s})$ $(\frac{r}{s}, m)$, the modified unfolding pair of P (similar to rotation theory for degree one circle maps, see Section [1\)](#page-0-1); we write $mup(P) = (\frac{r}{s}, m)$. Let $mup(f)$ be the set of all modified unfolding pairs of cycles of f.

Theorem 3.8. The set of modified unfolding pairs of cycles of the interval map $f : [0, 1] \rightarrow [0, 1]$ is equal to the set of modified rotation pairs of lifted cycles of the degree one circle map $F_f : \mathbb{R} \to \mathbb{R}$, that is, $mup(f) = mrp(F_f)$.

Proof. Let P be a cycle of $f : [0,1] \rightarrow [0,1]$ with period mq with unfolding number $\frac{p}{q}$, with p, q co-prime and modified unfolding pair $\left(\frac{p}{q}\right)$ $(\frac{p}{q}, m)$ for some $m \in \mathbb{N}$. Let $x \in P$. Then, $\lambda(x) \in [0, \frac{1}{2})$ $\frac{1}{2}$ is a periodic point of $g_f : [0, \frac{1}{2}]$ $\frac{1}{2}] \rightarrow [0, \frac{1}{2}]$ $\frac{1}{2}$ of same *period mq*. Construction of the map $F_f : \mathbb{R} \to \mathbb{R}$, then stipulates that the *trajectory* $T_{F_f}(\lambda(x))$ of $\lambda(x)$ under F_f is a *lifted periodic orbit* of F_f . Moreover, definitions [3.1](#page-9-1) and [3.7](#page-10-1) entails that modified rotation pair of $T_{F_f}(\lambda(x))$ is $(\frac{p}{q}, m)$. Hence, $\left(\frac{p}{q}\right)$ $(\frac{p}{q}, m) \in mrp(F_f).$

Conversely, suppose $(\frac{p}{q}, m)$ be the modified rotation pair of a lifted cycle P' of F_f . Choose $z \in P'$. By Lemma [3.3,](#page-10-2) there exists $x \in [0, \frac{1}{2}]$ $\frac{1}{2}]$ and $n \in \mathbb{N}$ such that $F_f^n(x) = z$. Since, the *trajectories* $T_{F_f}(z)$ and $T_{F_f}(x)$ are eventually coincident, by Lemma [3.5,](#page-10-3) the modified rotation pair of $T_{F_f}(x)$ is also $(\frac{p}{q}, m)$. Connection between the maps $g_f : [0, \frac{1}{2}]$ $\frac{1}{2}$ \rightarrow $[0, \frac{1}{2}]$ $\frac{1}{2}$ and $F_f : \mathbb{R} \to \mathbb{R}$, warrants that $x \in [0, \frac{1}{2}]$ $\frac{1}{2}$ is a *periodic point* of g_f of period mq and hence, $\lambda^{-1}(x) = y \in [0,1]$ is a periodic point of f of the same period mq. Definitions [3.1](#page-9-1) and [3.7,](#page-10-1) now yields that, the modified unfolding pair of $P = T_f(y)$ is equal to $(\frac{p}{q}, m)$, and hence $\left(\frac{p}{q}\right)$ $(\frac{p}{q}, m) \in mup(f)$ establishing the reverse inclusion. \Box

Theorem 3.9. There exists $t_1, t_2 \in \mathbb{R}$ and $m_1, m_2 \in \mathbb{N}$ such that $mup(f) = [(t_1, m_1), (t_2, m_2)].$

Proof. By Theorem [1.3,](#page-3-1) there exists modified rotation pairs (t_1, m_1) and (t_2, m_2) where $t_1, t_2 \in \mathbb{R}$ and $m_1, m_2 \in \mathbb{N}$ such that the set of all modified rotation pairs of cycles of the degree one map $F_f : \mathbb{R} \to \mathbb{R}$ is given by $mrp(F_f) = [(t_1, m_1), (t_2, m_2)]$. Now, the result follows from Theorem [3.8.](#page-11-1) \Box

Theorems [3.6](#page-10-0) and [3.9](#page-11-2) guarantees the completeness of the unfolding numbers.

4. Unfolding Interval and its realization

In this section, we analyze the *structure* of the set of unfolding numbers of points under a given interval map $f : [0,1] \rightarrow [0,1]$.

Theorem 4.1. Let $f : [0,1] \rightarrow [0,1]$ be a given continuous interval map. Then,

 $\overline{Unf(f)} = Unf(f) = Unf(f) = [u_f, \frac{1}{2}]$ $\frac{1}{2}$, where $u_f = \rho((F_f)_{\ell})$ where $(F_f)_{\ell}$ represents the lower bound map corresponding to the degree one map F_f .

Proof. We begin by showing: $Unf(f) = Rot(F_f)$. Choose $x \in [0,1]$ and $u_f(x) \in Unf(f)$. Then, $\lambda(x) \in [0, \frac{1}{2}]$ $\frac{1}{2}$ and hence, by definition [3.1,](#page-9-1) $u_f(x) = \rho_{F_f}(\lambda(x)) \in Rot(F_f)$, and hence $Unf(f) \subseteq Rot(F_f)$. Now, take $y \in \overline{\mathbb{R}$ and $\rho_{F_f}(y) \in Rot(F_f)$. By Lemma [3.3,](#page-10-2) there exists a point

 $z \in [0, \frac{1}{2}]$ $\frac{1}{2}$ such that $F_f^n(z) = y$ for some $n \in \mathbb{N}$. Then, the trajectories $T_{F_f}(z)$ and $T_{F_f}(y)$ are eventually coinciding and hence, by Lemma [3.5:](#page-10-3) $\rho_{F_f}(y) = \rho_{F_f}(z)$. Let $\lambda^{-1}(z) = x \in [0,1]$. Then, by Definition [3.1,](#page-9-1) $\rho_{F_f}(y) = \rho_{F_f}(z) = u_f(x) \in Unf(f)$ implying the reverse inclusion.

Similarly, it can be shown that: $\overline{Unf(f)} = \overline{Rot(F_f)}$. Now, Theorem [2.13](#page-8-1) and Definition [3.2,](#page-10-4) yields that: $\overline{Unf(f)} = Unf(f) = Unf(f)$ $[\rho((F_f)_{\ell}), \rho((F_f)_{u})]$, where $(F_f)_{\ell}$ and $(F_f)_{u}$ are respectively the lower bound map and upper bound map corresponding to the *degree one* map F_f . It remains to show $\rho((F_f)_u) = \frac{1}{2}$.

It is easy to see that $(F_f)_u(x) = \frac{1}{2}$ in $[0, M_g]$, $(F_f)_u(x) = F_f(x)$ in $[M_g, m_g]$ and $(F_f)_u(x) = 1$ in the interval $[m_g, 1 - m_g]$. It follows that $(F_f)_u(0) = \frac{1}{2}$ and $(F_f)_u(\frac{1}{2})$ $\frac{1}{2}$) = 1 and hence the *trajectory*: $T_{(F_f)_u}(0)$ of 0 under the map $(F_f)_u$, has *rotation number* $\frac{1}{2}$. Hence, the result follows. \Box

Definition 4.2. The *interval* $Unf(f) = [u_f, \frac{1}{2}]$ $\frac{1}{2}$ from Theorem [4.1](#page-11-3) is called the *unfolding interval* of the interval map $f : [0, 1] \rightarrow [0, 1]$.

Definition 4.3. Given a map $f : [0,1] \rightarrow [0,1]$, a set $A \subset [0,1]$ and a *point* $y \in [0, 1]$, we define:

- (1) $\eta_A(y) = \sup\{x \in A : f(x) = f(y)\}\$ (2) $\xi_A(y) = \inf\{x \in A : f(x) = f(y)\}\$
- (3) $Y_f = \eta_{[0,M_f]}([0,M_f]) \cup \eta_{[0,1]}([M_f,m_f]) \cup \xi_{[0,1]}([M_f,m_f]) \cup \eta_{[m_f,1]}([m_f,1]).$

Let us denote by \mathcal{C} , the set of *open subsets* of \mathbb{R} where the *lower* bound function: $(F_f)_{\ell}(x)$ is constant and let U to be the union of open intervals from C.

Theorem 4.4. Let $f : [0, 1] \rightarrow [0, 1]$ be a continuous map with unfolding interval $[u_f, \frac{1}{2}]$ $\frac{1}{2}$. Then for any point $y \in [0,1]$ whose trajectory is contained in Y_f , the unfolding set, $\mathcal{U}_f(y) = \{u_f\}.$

Proof. Construction of the maps g_f and F_f reveals that for $y \in [0, 1]$, if the trajectory $T_f(y)$ of y under f is disjoint from Y_f , then the trajectory $T_{F_f}(\lambda(y))$ of $\lambda(y)$ under F_f is disjoint from U. From Theorem [2.8\(](#page-7-0)5), this means that, the *trajectory* $T_{F_f}(\lambda(y))$ of $\lambda(y)$ under F_f and the trajectory $T_{(F_f)_\ell}(\lambda(y))$ of $\lambda(y)$ under the lower bound map $(F_f)_\ell$ are are coincident. So, Theorem [4.1](#page-11-3) and Lemma [3.5,](#page-10-3) entails that rotation number of $\lambda(y)$ under F_f exists and equals u_f : the rotation number of $\lambda(y)$ under the *lower bound map* $(F_f)_{\ell}$. Finally, definition [3.1,](#page-9-1) furnishes that the *unfolding set* $\mathcal{U}_f(y)$ of y is precisely equal to $\{u_f\}.$

By a *minimal* set of a map h of a *compact space* to *itself*, we mean an *invariant compact set* Z all of whose points have *dense trajectories* in Z (thus, a *compact invariant subset* of Z *coincides* with Z). Let us call a maximal (in terms of set inclusion) open set where a continuous function h is constant, a flat spot of h. The following result follows:

Theorem 4.5. Let $f : [0,1] \rightarrow [0,1]$ be a continuous map with unfolding interval $[u_f, \frac{1}{2}]$ $\frac{1}{2}$]. Then, there exists a minimal f-invariant set $Z_f \subset Y_f$ such that for any point $y \in Z_f$, we have $\mathcal{U}_f(y) = \{u_f\}$ and there are two possibilities :

- (1) u_f is rational, Z_f is a periodic orbit, and $f|_{Z_f}$ is canonically conjugate to the circle rotation by u_f restricted on one of its cycles.
- (2) u_f is irrational, Z_f is a Cantor set, and $f|_{Z_f}$ is canonically semi-conjugate to the circle rotation by u_f .

Proof. The natural projection map $\pi : \mathbb{R} \to \mathbb{S}$ monotonically semiconjugates (F_f) _l to a degree one map $\tau_f : \mathbb{S} \to \mathbb{S}$. Further, since (F_f) _l is monotonically non-decreasing, $\tau_f : \mathbb{S} \to \mathbb{S}$ preserves cyclic orientation in the non-strict sense. From Theorem [2.10,](#page-7-1) it follows that there exists a point $z \in \mathbb{R}$, such that, the trajectory $T_{F_f}(z)$ of z under F_f is disjoint from U, (that is, the trajectories $T_{F_f}(z)$ and $T_{(F_f)_\ell}(z)$ are coincident), such that $\rho_{F_f}(z) = \rho_{(F_f)_{\ell}}(z) = \rho((F_f)_{\ell}) = u_f$. We have two cases here:

- (1) If $u_f = \frac{p}{q}$ $\frac{p}{q}$ is rational, then $\pi(z) \in \mathbb{S}$ is periodic under τ_f of period q. If P_f be the *orbit* of $\pi(z)$, under τ_f , then the map τ restricted on P_f acts as *circle rotation* by angle $\frac{p}{q}$.
- (2) If u_f is irrational, then $\pi(z) \in \mathbb{S}$ belongs to the omega limit set $\omega_{\tau_f}(\pi(z)) = Q_f \subset \mathbb{S}$ of $\pi(z)$ under τ_f . It is minimal (that is, τ_f orbits of all points of Q_f are dense in Q_f) such that collapsing arcs of S complementary to Q_f , we can semi-conjugate τ_f : $\mathbb{S} \to \mathbb{S}$ to *irrational rotation* of \mathbb{S} by the *angle u_f*. In this case, clearly, Q_f is a *cantor set*.

We need to now find the appropriate f-invariant set $Z_f \subset [0, 1]$ whose existence is claimed in the theorem. The correspondence between the maps involved in our construction, Lemma [3.3,](#page-10-2) implies the existence of a *continuous conjugacy* $\psi_f : \mathbb{S} \to [0,1]$ between the maps $\tau : \mathbb{S} \to \mathbb{S}$ and $f : [0, 1] \to [0, 1]$ applicable outside $\pi(\mathcal{U}) \subset \mathbb{S}$.

If u_f is *irrational*, then clearly, we can easily find a point $y \in Q_f \subset \mathbb{S}$ such that $T_{\tau_f}(y) \cap \pi(\overline{\mathcal{U}}) = \phi$. Then, it follows that there is a *continuous* conjugacy between $\tau|_{T_{\tau_f}(y)}$ and $f|_{Z_f}$ where Z_f is the omega limit set $\omega_f(\psi_f(y))$ of $\psi_f(y)$ under f. It is then easy to see that Z_f is a Cantor Set and has all the desired properties.

Suppose $u_f = \frac{p}{q}$ q^p is rational. Since, by definition, $T_{F_f}(z) \cap \mathcal{U} = \phi$, it follows that, $P_f \cap \pi(\mathcal{U}) = \phi$, but, it is not guaranteed that $P_f \cap \pi(\mathcal{U}) = \phi$. However, as we now show, the specifics of the construction helps us to elude this problem. If $P_f \cap \pi(\overline{\mathcal{U}}) = \phi$, then we are done by the arguments similar to the ones from the previous paragraph. Suppose that P_f passes through an *endpoint* η of a *flat spot* of τ_f . Choose a *point* y very close to η avoiding flat spots of τ_f . Then, the finite segment of the τ_f orbit of y consisting of points $y, \tau_f(y), \ldots, \tau_f^q$ $f_f^q(y) \approx y$ is transformed by ψ_f into a *finite segment* $\psi_f(y), f(\psi_f(y)), \dots f^q(\psi_f(y)) \approx \psi_f(y)$ which converges to an f-periodic orbit as $y \to \eta$. The limit periodic orbit Z_f consisting of $\psi_f(y), f(\psi_f(y)), \dots f^q(\psi_f(y)) \approx \psi_f(y)$ has all the desired properties.

Theorem [4.5](#page-12-0) leads us to the following result:

□

Theorem 4.6. Let $f : [0, 1] \rightarrow [0, 1]$ be a continuous map with unfolding interval $[u_f, \frac{1}{2}]$ $\frac{1}{2}$. Then, there exists a point $z \in [0,1]$ such that the map $f|_{Z_f}$ where $\overline{Z}_f = \omega_f(z)$ is strictly ergodic.

Proof. It follows from Theorem [4.5,](#page-12-0) that there exists a *point* $z \in [0, 1]$ such that the map $f|_{Z_f}$ where $Z_f = \omega_f(z)$ has a unique *invariant* measure μ_f such that the measure μ_f can be transformed in a canonical fashion to a specific *invariant measure* related to *circle rotation* by angle u_f . If u_f is rational, the measure μ_f is simply the CO-measure concentrated on the *f-periodic orbit* of z (see Section [1\)](#page-0-1) whereas if u_f is *irrational*, μ_f corresponds in a canonical fashion to the *Lebesgue* measure on $\mathcal S$ invariant under irrational rotation on angle u_f . Hence, the result follows. \Box

5. Characterizing dynamics of a cycle with a given unfolding number

As demonstrated in Section [3,](#page-8-0) computing *unfolding number* of a periodic orbit P typically requires first constructing, the heaved map F_f , where f is the *P*-linear map corresponding to the periodic orbit P . In this section, we reveal that unfolding number of a periodic orbit P can be read directly from the combinatorics of the permutation corresponding to P eliminating need to construct F_f .

We commence by introducing a few notions which would be used throughout this section: Let P be a *periodic orbit* of *period* q . Let $f:[0,1] \rightarrow [0,1]$ be a P-linear map such that the left-end point and right-end point of P are $le(P) = 0$ and $ri(P) = 1$ respectively. Let m_f and M_f be points of *absolute minimum* and *absolute maximum* of f such that $f(m_f) = 0$ and $f(M_f) = 1$. Likewise, m_g and M_g are points of absolute minimum and absolute maximum of the miniature model map g_f , corresponding to f, such that $f(m_g) = 0$ and $f(M_g) = \frac{1}{2}$.

Definition 5.1. By unfolding index set of P , we mean the maximal (in terms of set inclusion) set $\mathcal{N}(P) = \{n_1, n_2, \ldots n_k\}$ of non-negative integers satisfying the following properties:

- (1) $0 \leq n_i < n_{i+1} < q$, for all $i \in \{0, 1, 2, \ldots k-1\}$.
- (2) n_1 is the *smallest non-negative integer* such that $f^{n_1-1}(0) < m_f$ and $f^{n_1-2}(0) > M_f$.
- (3) n_{i+1} is the smallest non-negative integer, greater than or equal to $n_i + 2$ but strictly less than q such that: $f^{n_{i+1}-1}(0) < m_f$ and $f^{n_{i+1}-2}(0) > M_f$, for all $i \in \{0, 1, 2, \ldots k-1\}$.

The points $f^{n_i}(0) \in P$, $n_i \in \mathcal{N}(P)$ are called unfolding points of P.

Theorem 5.2. If P has p unfolding points, then, the unfolding number of P is $\frac{p}{q}$.

Proof. Definition of $\mathcal{N}(P)$ coupled with the construction of the maps g_f and F_f reveals that the *trajectory* of 0 under g_f and *trajectory* of 0 under F_f are the *same* till the first $n_1 - 2$ *iterates*, that is, $g_f^i(0) =$ $F_f^i(0)$, for $i \in \{0, 1, 2, ..., n_1 - 2\}$. Furthermore, since $f^{n_1-2}(0) > M_f$, we have: $g_f^{n_1-2}(0) = F_f^{n_1-2}(0) > M_g$. Consequently, $F_f^{n_1-1}(0) > \frac{1}{2}$ $\frac{1}{2}$.

Moreover, since, $f^{n_1-1}(0) < m_f$, we must have: $g_f^{n_1-1}(0) < m_g$. So, $1 - m_g < F_f^{n_1-1}(0) < 1$ and hence, $F_f^{n_1}(0) \geq 1$.

The above mentioned scheme persists with $F_f^i(0) \in (1, 2)$, for n_1 < $i \leq n_2 - 1$ and $F_f^{n_2}(0) \geq 2$; then, $F_f^{i}(0) \in (2, 3)$ for $n_2 < i \leq n_3 - 1$ and $F_f^{n_3}(0) \geq 3$, and so forth, leading to $F_f^{n_p}$ $f_f^{n_p}(0) \geqslant p$. We assert that F_f^q $f_f^q(0) = 0 + p$. Indeed, since $T_f(0) = P$ is a periodic orbit of f of period q, $T_{F_f}(0)$ is a *lifted periodic orbit* of 0 of same *period* q. Thus, F_f^q $f_q^q(0) = 0 + \ell$ for some $\ell \in \mathbb{N}$. Since, $n_p \leqslant q$, it follows that, $\ell \geqslant p$. If $\ell \geqslant p+1$, then there exists $m \in \mathbb{N}, m > n_p$ such that $F_f^m(0) > 1$. However, this is feasible only if, there exists $m \in \mathbb{N}, m > n_p$ such that $f^{m-1}(0) < m_f$ and $f^{m-2}(0) > M_f$, contradicting the maximality of $\mathcal{N}(P)$. Thus, $\ell = p$, establishing the result. \Box

Theorem [5.2](#page-14-1) enables us to define *unfolding numbers* in a manner reminiscent of the traditional approach used for defining *rotation num*-bers, as expounded in Section [3.](#page-8-0) We define an *observable* $\Phi: P \to \mathbb{R}$ as follows. For each $i \in \mathbb{N}$ define:

$$
\Phi(f^i(0)) = \begin{cases} 1 & \text{if } i \in \mathcal{N} \\ 0 & \text{if } i \notin \mathcal{N} \end{cases}
$$

Then the following easily follows from Theorem [5.2.](#page-14-1)

Corollary 5.3. The unfolding number of P is $\frac{1}{q} \sum_{i=1}^{q} \Phi(f^i(0))$ and the unfolding pair of P is: $\left(\sum_{i=1}^q \Phi(f^i(0)), q\right)$.

6. Forced Unfolding Interval

In this section we introduce the idea of *forced unfolding interval*. We define: unfolding number, unfolding pair and modified unfolding pair of a pattern π to be the unfolding pair, unfolding pair and modified unfolding pair of any cycle P which exhibits π . The unfolding number, unfolding pair and modified unfolding pair of a pattern π are respectively denoted by $un(\pi), up(\pi)$ and $mup(\pi)$. We now introduce the notion of forced unfolding interval:

Definition 6.1. We say that a pattern π forces the unfolding interval U_{π} , if $U_{\pi} = [u_{\pi}, \frac{1}{2}]$ $\frac{1}{2}$ is the *unfolding interval* of the *P*-linear map f where P exhibits π .

It follows that: if $\rho(\pi)$ is the unfolding number of π , then, $u_{\pi} \leqslant \rho(\pi)$.

Definition 6.2. We call a cycle P divergent (or the pattern π it exhibits) if there are points x, y, z of P such that:

(1) $x < y < z$

(2) $f(x) < x$, $f(y) \geq z$ and $f(z) \leq x$.

where f is the P-linear map. We call a pattern π divergent, if any cycle P which exhibits it is divergent.

It is well known that if a *pattern* π is *divergent* then for any cycle P of this pattern, the P-linear map f has a horseshoe and has cycles of all possible *periods*. We show that in fact, in such a case, f has cycles of all possible unfolding pairs.

A cycle P (or the pattern π it exhibits) is called convergent, if it is not *divergent*. There is another equivalent way to define *convergent* pattern Namely, let U be the family of all interval maps with a unique fixed point. If f is a P-linear map for a cycle P , then P is convergent if and only if $f \in \mathcal{U}$.

Theorem 6.3. If f has a divergent cycle, then the unfolding interval of f is $[0, \frac{1}{2}]$ $\frac{1}{2}$.

Proof. Let x, y, z be defined as in Definition [6.2.](#page-15-1) Then, there exists a fixed point a between x and y and a fixed point b between y and z. Also, there exists a point c between a and y such that $f(c) = b$. Let $J = [a, c], K_1 = [c, y], K_2 = [y, b] \text{ and } L = [b, z].$ Then, the interval J f-covers the interval J, K_1 and K_2 ; the interval K_1 f-covers L; the interval K_2 f-covers L and the interval L f-covers J, K_1, K_2 . Consider the loop $\alpha: J \to J \to \ldots J \to K_2 \to L \to J \to K_1 \to L \to J \to$ $K_1 \to L \to J \to K_1 \to L \to \ldots L \to J \to K_1 \to L \to J$ consisting of $q-3p-3$ J's followed by K_2 , then p blocks $L \to J \to K_1$, then the block $L \to J$. Let Q be the periodic orbit associated with α (Lemma [2.4\)](#page-6-0). From the *location* of the *intervals*: J, K_1, K_2 and L , it is clear that the point of *absolute minimum* m_Q of Q , lies in the interval L and the point of absolute maximum M_Q of Q , lies in $K_1 \cup K_2$. Let us start at the *left end point le(Q)* of Q and travel along the *loop* α . Clearly, $le(Q) \in J$. Construction of the *loop* α reveals that, during our *motion* along the *loop*: α , the only time we can possibly encounter an *unfolding point* is when we *pass* through the block $L \to J \to K_1$ in α ; also, each time we pass through the block $L \to J \to K_1$, we confront one "new" unfolding point. It follows, that the number of unfolding points of Q is p. Thus, from Theorem [5.2,](#page-14-1) the *unfolding number* of \tilde{Q} is $\frac{p}{q}$ and the unfolding pair of Q is (p, q) . Since, p and q are arbitrary, f has cycles of all possible *unfolding pairs* and hence the result follows. \Box

7. Comparison with over-rotation numbers

From Theorem [6.3,](#page-16-1) it is evident that, for the purpose of studying coexistence of cycles with different unfolding pairs, it is sufficient to study *convergent patterns*, and hence only consider maps $f \in \mathcal{U}$. Further as discussed in the beginning of Section [3,](#page-8-0) it is sufficient to consider the case $m_{\pi} > M_{\pi}$, where m_{π} and M_{π} are the *points* of *absolute mini*mum and *absolute maximum* of π . We begin this section by providing an example to illustrate that, in general, over-rotation numbers and unfolding numbers are different entities (See Figure [3\)](#page-18-15).

Example 7.1. Consider the *trimodal pattern* characterised by the *per*mutation $\Pi = (1, 2, 5, 7, 10, 3, 6, 8, 9, 4, 11)$. It has over-rotation number $\frac{3}{11}$, but *unfolding number* $\frac{5}{11}$ (See Figure [3\)](#page-18-15).

In the end, we now portray the existence of a peculiar *patterns* for which *over-rotation number* equals *unfolding number!*

Definition 7.2. A convergent pattern π is called *sheer*, if it is conver*gent* and is *decreasing* in $[M_{\pi}, m_{\pi}].$

Theorem 7.3. Let π be a convergent pattern with over-rotation number orn(π) and unfolding number un(π). Then, orn(π) \leq un(π). Further, if π is sheer, $orn(\pi) = un(\pi)$.

Proof. Let P be any cycle which exhibits π and let $f \in \mathcal{U}$ be the Plinear map with unique fixed point a_f . Let m_f and M_f be points of absolute minimum and absolute maximum of f. We assume M_f < $a_f < m_f$ and thus *points* of P to the *left* of a_f map to the *right* of *itself* while *points* of P to the right of a_f map to the *left* of *itself*. Let the *over-rotation number* of P be $\frac{p}{q}$, indicating that there are *exactly* p points to the *right of the fixed point* a_f which are mapped to the *left* of a_f . Let these p points be denoted as: $x_1 > x_2 > x_3 > \cdots > x_p$. It's easy to see that for each $i \in \{1, 2, \ldots p\}$, precisely one of $f^2(x_i)$ and $f(x_i)$ is an unfolding point: let us denote this unfolding point by ξ_i , $\xi_i \in \{f^2(x_i), f(x_i)\}\$ for $i \in \{1, 2, \ldots p\}$. This indicates that the number of unfolding points of P is at-least p . Theorem [5.2,](#page-14-1) now yields that unfolding number of P is at-least $\frac{p}{q}$, establishing the first result.

Let us now assume that π is *sheer*. With this assumption, let us exhibit that number of *unfolding points* of P is precisely p . By way of contradiction, let's entertain the possibility of an unfolding point η of P such that: $\eta \notin {\xi_i : i = 1, 2, \ldots p}$. We can then encounter four potential cases:

- (1) $f(m_f) \leq M_f \leq f^{-2}(\eta) \leq a_f \leq f^{-1}(\eta) \leq m_f \leq f(M_f)$.
- (2) $f(m_f) \leqslant M_f \leqslant f^{-2}(\eta) \leqslant f^{-1}(\eta) \leqslant a_f \leqslant m_f \leqslant f(M_f).$
- (3) $f(m_f) \leq M_f \leq f^{-1}(\eta) \leq a_f \leq f^{-2}(\eta) \leq f(M_f)$.
- (4) $f(m_f) \leq M_f \leq a_f \leq f^{-1}(\eta) \leq f^{-2}(\eta) \leq f(M_f)$ and $f^{-1}(\eta) \leq$ m_f

We illustrate, that all these *four cases* leads us to a contradiction. Let's first examine the *first case*. We claim $a_f \leq \eta \leq f^{-1}(\eta)$. Indeed, $\eta \leqslant a_f$ means that $f^{-1}(\eta) \in \{x_i : i = 1, 2, \ldots p\}$, and hence $\eta \in \{f(x_i) :$ $i = 1, 2, \ldots p$ contradicting the fact that $\eta \notin \{\xi_i : i = 1, 2, \ldots p\}$. Consequently, $a_f \leqslant \eta \leqslant f^{-1}(\eta)$. But, this in turn means, f first decreases in the interval $[M_f, a_f]$, then *increases* in the interval $[a_f, f^{-1}(\eta)]$ and then *decreases* in $[f^{-1}(\eta), m_f]$ which contradicts the fact that π is a sheer pattern.

In the second case, since, $\eta \geqslant f^{-1}(\eta)$, f first decreases in the *interval* $[M_f, f^{-2}(\eta)]$, then *increases* in the interval $[f^{-2}(\eta), f^{-1}(\eta)]$, and finally decreases in $[f^{-1}(\eta), m_f]$, again contradicting the assumption that π is a sheer pattern.

In the *third case*, $f^{-2}(\eta) \in \{x_i : i = 1, 2, \dots p\}$ and hence, $\eta \in$ ${f²(x_i) : i = 1, 2, ... p}$ again, contradicting the fact that $\eta \notin {\xi_i : i =$ $1, 2, \ldots, p$. Lastly, the arguments for the *fourth case* exactly mirror that of the *first*. Thus, *number* of *unfolding points* of P is precisely p and hence from Theorem [5.2,](#page-14-1) unfolding number of P is $\frac{p}{q}$. □

Notice, that every unimodal or bimodal pattern π inherently qualifies as a sheer pattern, leading us to the subsequent corollary:

Corollary 7.4. If π has modality less than or equal to 2, then overrotation number of π = unfolding number of π .
