# AN ADDITIVE VARIANT OF THE DIFFERENTIAL SYMBOL MAPS 

TOSHIRO HIRANOUCHI


#### Abstract

Our investigation focuses on an additive analogue of the Bloch-GabberKato theorem which establishes a relation between the Milnor $K$-group of a field of positive characteristic and a Galois cohomology group of the field. Extending the Aritin-Schreier-Witt theory, we present an isomorphism from the Mackey product associated with the Witt group and the multiplicative groups to a Galois cohomology group. As a result, we give a new expression for the torsion subgroup of the Brauer group of a field, and more generally, the Kato homology groups.


## 1. Introduction

For an arbitrary field $k$ and any positive integer $m$ prime to the characteristic of $k$, the norm residue isomorphism theorem ([Voe11], see also [Wei09]) is relating the Milnor $K$-group $K_{n}^{M}(k)$ of the field $k$ and the Galois cohomology group $H^{n}(k, \mathbb{Z} / m \mathbb{Z}(n))=$ $H_{\mathrm{et}}^{n}\left(\operatorname{Spec}(k), \mu_{m}^{\otimes n}\right)$. Precisely, for any $n \geq 0$, the Galois symbol map

K_{n}^{M}(k) / m K_{n}^{M}(k) \xrightarrow{\simeq} H^{n}(k, \mathbb{Z} / m \mathbb{Z}(n)) \tag{1.1}
\end{equation*}
$$

is bijective. The Milnor $K$-group $K_{n}^{M}(k)$ can be replaced by the Somekawa $K$-group associated to the multiplicative groups $\mathbb{G}_{m}$ by using the canonical isomorphism

\end{equation*}

([Som90, Thm. 1.4]). The aim of this note is to study the "additive analogue" of the norm residue isomorphism theorem by replacing the first $\mathbb{G}_{m}$ in the Somekawa $K$-group $K\left(k ; \mathbb{G}_{m}, \ldots, \mathbb{G}_{m}\right)$ with the additive group $\mathbb{G}_{a}$ or the Witt group $W_{r}$ more generally. For the case $n=1$, the Galois symbol map is the Kummer theory

k^{\times} /\left(k^{\times}\right)^{m} \xrightarrow{\simeq} H^{1}(k, \mathbb{Z} / m \mathbb{Z}(1)) .

The additive analogue should be the Artin-Schreier-Witt theory

$$

W_{r}(k) / \wp\left(W_{r}(k)\right) \xrightarrow{\simeq} H^{1}\left(k, \mathbb{Z} / p^{r} \mathbb{Z}\right) \tag{1.3}
\end{equation*}
$$

for a field $k$ of characteristic $p>0$, where $\wp\left(\left(x_{0}, \ldots, x_{r-1}\right)\right)=\left(x_{0}^{p}, \ldots, x_{r-1}^{p}\right)-\left(x_{0}, \ldots, x_{r-1}\right)$. Unfortunately, it has not been given that the Somekawa type $K$-group associated to $W_{r}$ and $\mathbb{G}_{m}$ 's over an arbitrary field $k$ (cf. [Hir14], [IR17], [RSY22]). However, after tensoring with $\mathbb{Z} / m \mathbb{Z}$, for the expression of the Milnor $K$-group in (1.2) there is no need to use the Somekawa $K$-group. To explain this fact, we recall that the Somekawa $K$-group is defined to be the quotient of $\bigoplus_{K / k: \text { finite }}\left(K^{\times}\right)^{\otimes_{\mathbb{Z}} n}$ by two kind of relations, resembling the projection formula and the Weil reciprocity law of the Milnor $K$-groups:

\end{aligned}

The Mackey product $\mathbb{G}^{M}{ }^{M n}(k)=\overbrace{\left(\mathbb{G}_{m} \quad M \quad M\right.}^{n}$ generators as the Somekawa $K$-group with the relation concerning the projection formula only:

\mathbb{G}_{m}^{M} \stackrel{M}{\otimes n}(k):=\left(\bigoplus_{K / k: \text { finite }}\left(K^{\times}\right)^{\otimes_{\mathbb{Z}} n}\right) /(\text { projection formula) }) \tag{1.4}
\end{equation*}

(for the precise definition, see Definition 2.3). By the very definition, the Somekawa $K$ group is a quotient of the Mackey product $\mathbb{G}_{m}^{\otimes \otimes n}(k) \rightarrow K\left(k ; \mathbb{G}_{m}, \ldots, \mathbb{G}_{m}\right)$. This quotient map becomes bijective

$$
\mathbb{G}_{m}^{M n}(k) / m \stackrel{\simeq}{\leftrightarrows} K(k ; \overbrace{\mathbb{G}_{m}, \ldots, \mathbb{G}_{m}}^{n}) / m
$$

after considering modulo $m$ (Kahn's theorem, cf. Theorem 4.5). It is important to note here that the Mackey product $\left(W_{r} \otimes_{\otimes}^{M} \mathbb{G}_{m}^{M(n-1)}\right)(k)$ is defined for an arbitrary field $k$ in the same way as in (1.4). Using this, we present an isomorphism below which extends the Artin-Schreier-Witt theory (1.3).

Theorem 1.1 (Theorem 5.8). Let $k$ be an arbitrary field of characteristic $p>0$. For $r \geq 1$ and $n \geq 1$, there is an isomorphism

\left(W_{r} \stackrel{M}{\otimes} \mathbb{G}_{m}^{M}(n-1)\right)(k) / \wp \xrightarrow{\simeq} H^{n}\left(k, \mathbb{Z} / p^{r} \mathbb{Z}(n-1)\right)=H_{\mathrm{et}}^{1}\left(\operatorname{Spec}(k), W_{r} \Omega_{\log }^{n-1}\right),
$$

where $\left(W_{r} \stackrel{M}{\otimes} \mathbb{G}_{m}^{\stackrel{M}{\otimes}(n-1)}\right)(k) / \wp$ is the cokernel of a map $\wp:\left(W_{r} \stackrel{M}{\otimes} \mathbb{G}_{m}^{\stackrel{M}{\otimes}(n-1)}\right)(k) \rightarrow\left(W_{r} \stackrel{M}{\otimes}\right.$ $\left.\mathbb{G}_{m}^{M(n-1)}\right)(k)$ defined by $\wp: W_{r}(K) \rightarrow W_{r}(K)$ on the Witt groups used in (1.3).

The above theorem should be compared to the Bloch-Gabber-Kato theorem which is a $p$-analogue of the norm residue isomorphism theorem.

Theorem 1.2 (Bloch-Gabber-Kato, [BK86, Cor. 2.8]). Let $k$ be an arbitrary field of characteristic $p>0$. For any $r \geq 1$ and $n \geq 0$, the differential symbol map (cf. (3.6))

K_{n}^{M}(k) / p^{r} K_{n}^{M}(k) \xrightarrow{\simeq} H^{n}\left(k, \mathbb{Z} / p^{r} \mathbb{Z}(n)\right)=W_{r} \Omega_{k, \log }^{n}
$$

is an isomorphism.
Put $H_{p^{r}}^{n}(k):=H^{n}\left(k, \mathbb{Z} / p^{r} \mathbb{Z}(n-1)\right)$. In the case $n=2$, we have an isomorphism $H_{p^{r}}^{2}(k) \simeq \operatorname{Br}(k)\left[p^{r}\right]$, where $\operatorname{Br}(k)\left[p^{r}\right]$ is the $p^{r}$-torsion part of the Brauer group $\operatorname{Br}(k)$. Our theorem (Theorem 1.1) above gives an expression for the Brauer group $\operatorname{Br}(k)\left[p^{r}\right]$. More generally, for an excellent scheme $X$ over a field $k$ of characteristic $p>0$ with $\left[k: k^{p}\right] \leq p^{n}$ for some $n$, there is a homological complex $K C_{\bullet}^{n}\left(X, \mathbb{Z} / p^{r} \mathbb{Z}\right)$ of Bloch-Ogus type:

\cdots \rightarrow \bigoplus_{x \in X_{j}} H_{p^{r}}^{n+j+1}(k(x)) \rightarrow \cdots \rightarrow \bigoplus_{x \in X_{1}} H_{p^{r}}^{n+2}(k(x)) \rightarrow \bigoplus_{x \in X_{0}} H_{p^{r}}^{n+1}(k(x))
$$

where $X_{j}$ is the set of points $x$ in $X$ with $\operatorname{dim}(\overline{\{x\}})=j$ and $k(x)$ is the residue field at $x$ ([Kat86]). Here, the term $\bigoplus_{x \in X_{j}} H_{p^{r}}^{n+j+1}(k(x))$ is placed in degree $j$. The Kato homology group of $X$ (with coefficients in $\mathbb{Z} / p^{r} \mathbb{Z}$ ) is defined to be the homology group $K H_{j}\left(X, \mathbb{Z} / p^{r} \mathbb{Z}\right):=H_{j}\left(K C_{\bullet}^{n}\left(X, \mathbb{Z} / p^{r} \mathbb{Z}\right)\right)$. Theorem 1.1 gives an alternative expression of $K C_{\bullet}^{n}\left(X, \mathbb{Z} / p^{r} \mathbb{Z}\right)$ (for recent progress on the Kato homology groups, see [Sai10]).

Notation. Throughout this note, for an abelian group $G$ and $m \in \mathbb{Z}_{\geq 1}$, we write $G[m]$ and $G / m$ for the kernel and cokernel of the multiplication by $m$ on $G$ respectively.

## 2. Mackey functors

In this section, we recall the notion of Mackey functors, and their product following [Kah92, Sect. 5] (see also [IR17, Rem. 1.3.3], [RS00, Sect. 3]). Throughout this section, let $k$ be a field, and $\operatorname{Ext}_{k}$ the category of field extensions of $k$.

Definition 2.1. A Mackey functor $\mathscr{M}$ over a field $k$ (a cohomological finite Mackey functor over $k$ in the sense of [Kah92]) is a covariant functor $\mathscr{M}: \operatorname{Ext}_{k} \rightarrow \mathrm{Ab}$ from $\operatorname{Ext}_{k}$ to the category of abelian groups Ab equipped with a contravariant structure for finite extensions $L / K$ in Ext $_{k}$ satisfying the following conditions: For any finite field extension $L / K$ in $\operatorname{Ext}_{k}$ and a field extension $K^{\prime} / K$ in $\operatorname{Ext}_{k}$, the following diagram is commutative:

where $L \otimes_{K} K^{\prime}=\bigoplus_{i=1}^{n} A_{i}$ for some local Artinian algebras $A_{i}$ of dimension $e_{i}$ over the residue field $L_{i}^{\prime}:=A_{i} / \mathfrak{m}_{A_{i}}$. Here, for an extension $L / K$ in $\operatorname{Ext}_{k}$, the map $\operatorname{res}_{L / K}: \mathscr{M}(K) \rightarrow$ $\mathscr{M}(L)$ is defined by the covariant structure of $\mathscr{M}$ and the contravariant structure gives $\operatorname{tr}_{L / K}: \mathscr{M}(K) \rightarrow \mathscr{M}(L)$ if $[L: K]<\infty$.

The category of Mackey functors forms a Grothendieck abelian category (cf. [KY13, Appendix A]) and hence any morphism of Mackey functor $f: \mathscr{M} \rightarrow \mathscr{N}$, that is, a natural transformation, gives the image $\operatorname{Im}(f)$, the cokernel $\operatorname{Coker}(f)$ and so on.

Example 2.2. (i) For any endomorphism $f: \mathscr{M} \rightarrow \mathscr{M}$ of a Mackey functor $\mathscr{M}$, we denote the cokernel by $\mathscr{M} / f:=\operatorname{Coker}(f)$. This Mackey functor is given by

$$
(\mathscr{M} / f)(K)=\operatorname{Coker}(f(K): \mathscr{M}(K) \rightarrow \mathscr{M}(K)) .
$$

(ii) A commutative algebraic group $G$ over $k$ induces a Mackey functor by defining $K / k \mapsto G(K)$ for any field extension $K / k$ (cf. [Som90, (1.3)], [IR17, Prop. 2.2.2]). In particular, the multiplicative group $\mathbb{G}_{m}$ is a Mackey functor given by $\mathbb{G}_{m}(K)=$ $K^{\times}$for any field extension $K / k$. The translation maps are the norm $N_{L / K}: L^{\times} \rightarrow$ $K^{\times}$and the inclusion $K^{\times} \rightarrow L^{\times}$. For the additive group $\mathbb{G}_{a}$, the translation maps are the trace map $\operatorname{Tr}_{L / K}: L \rightarrow K$ and the inclusion $K \hookrightarrow L$.
(iii) Recall that, for $n \geq 1$, the Milnor $K$-group $K_{n}^{M}(k)$ of a field $k$ is the quotient group of $\left(k^{\times}\right)^{\otimes_{Z} n}$ by the subgroup generated by all elements of the form $a_{1} \otimes \cdots \otimes a_{n}$ with $a_{i}+a_{j}=1$ for some $i \neq j$. We also put $K_{0}^{M}(k)=\mathbb{Z}$. The class of $a_{1} \otimes \cdots \otimes a_{n}$ in $K_{n}^{M}(k)$ is denoted by $\left\{a_{1}, \ldots, a_{n}\right\}_{k}$. For an extension $L / K$ in $\operatorname{Ext}_{k}$, the restriction map $\operatorname{res}_{L / K}: K_{n}^{M}(K) \rightarrow K_{n}^{M}(L)$ and the norm map $N_{L / K}: K_{n}^{M}(L) \rightarrow K_{n}^{M}(K)$ when $[L: K]<\infty$ gives the structure of the Mackey functor $K_{n}^{M}$.

Definition 2.3. For Mackey functors $\mathscr{M}_{1}, \ldots, \mathscr{M}_{n}$ over $k$, the Mackey product $\mathscr{M}_{1}{ }_{Q}^{M}$ $\cdots \stackrel{M}{\otimes} \mathscr{M}_{n}$ is defined as follows: For any field extension $k^{\prime} / k$,

\left(\mathscr{M}_{1} \stackrel{M}{\otimes} \cdots \stackrel{M}{\otimes} \mathscr{M}_{n}\right)\left(k^{\prime}\right):=\left(\bigoplus_{K / k^{\prime}: \text { finite }} \mathscr{M}_{1}(K) \otimes_{\mathbb{Z}} \cdots \otimes_{\mathbb{Z}} \mathscr{M}_{n}(K)\right) /(\mathbf{P F})
$$

where ( $\mathbf{P F}$ ) stands for the subgroup generated by elements of the following form:
(PF) For a finite field extension $L / K$ in $\operatorname{Ext}_{k^{\prime}}$,

x_{1} \otimes \cdots \otimes \operatorname{tr}_{L / K}\left(\xi_{i_{0}}\right) \otimes \cdots \otimes x_{n}-\operatorname{res}_{L / K}\left(x_{1}\right) \otimes \cdots \otimes \xi_{i_{0}} \otimes \cdots \otimes \operatorname{res}_{L / K}\left(x_{n}\right)
$$

for $\xi_{i_{0}} \in \mathscr{M}_{i_{0}}(L)$ and $x_{i} \in \mathscr{M}_{i}(K)$ for $i \neq i_{0}$.
For the Mackey product $\mathscr{M}_{1} \stackrel{M}{\otimes} \cdots \stackrel{M}{\otimes} \mathscr{M}_{n}$, we write $\left\{x_{1}, \ldots, x_{n}\right\}_{K / k^{\prime}}$ for the image of $x_{1} \otimes \cdots \otimes x_{n} \in \mathscr{M}_{1}(K) \otimes_{\mathbb{Z}} \cdots \otimes_{\mathbb{Z}} \mathscr{M}_{n}(K)$ in the product $\left(\mathscr{M}_{1}{ }^{M} \cdots{ }_{\otimes}^{M} \mathscr{M}_{n}\right)\left(k^{\prime}\right)$. The translation maps $\operatorname{tr}_{K^{\prime} / K}:\left(\mathscr{M}_{1} \stackrel{M}{\otimes} \cdots \stackrel{M}{\otimes} \mathscr{M}_{n}\right)(K) \rightarrow\left(\mathscr{M}_{1}{ }_{Q}^{M} \cdots \stackrel{M}{\otimes} \mathscr{M}_{n}\right)\left(K^{\prime}\right)$ and $\operatorname{res}_{K^{\prime} / K}:\left(\mathscr{M}_{1}{ }^{M} \cdots{ }_{\otimes}^{M}\right.$ $\left.\mathscr{M}_{n}\right)(K) \rightarrow\left(\mathscr{M}_{1}{ }^{M} \cdots \stackrel{M}{\otimes} \mathscr{M}_{n}\right)\left(K^{\prime}\right)$ are defined as follows (cf. [IR17, Lem. 4.1.2], [Akh00, Sect. 3.4]):

\operatorname{tr}_{K^{\prime} / K}\left(\left\{x_{1}, \ldots, x_{n}\right\}_{L^{\prime} / K^{\prime}}\right) & =\left\{x_{1}, \ldots, x_{n}\right\}_{L^{\prime} / K}, \quad \text { and } \\
\operatorname{res}_{K^{\prime} / K}\left(\left\{x_{1}, \ldots, x_{n}\right\}_{L / K}\right) & =\sum_{i=1}^{n} e_{i}\left\{\operatorname{res}_{L_{i}^{\prime} / L}\left(x_{1}\right), \ldots, \operatorname{res}_{L_{i}^{\prime} / L}\left(x_{n}\right)\right\}_{L_{i}^{\prime} / K^{\prime}}
\end{aligned}
$$

where $L \otimes_{K} K^{\prime}=\bigoplus_{i=1}^{n} A_{i}$ for some local Artinian algebras $A_{i}$ of dimension $e_{i}$ over the residue field $L_{i}^{\prime}:=A_{i} / \mathfrak{m}_{A_{i}}$.
Remark 2.4. The Mackey product $\mathscr{M}_{1} \stackrel{M}{\otimes} \cdots \stackrel{M}{\otimes} \mathscr{M}_{n}$ is a Mackey functor with translation maps defined above ([IR17, Lem. 4.1.2]). For Mackey functors $\mathscr{M}_{1}, \mathscr{M}_{2}, \mathscr{M}_{3}$ over $k, \mathscr{M}_{1}{ }_{Q}{ }_{Q}$ $\left(\mathscr{M}_{2} \oplus \mathscr{M}_{3}\right) \simeq\left(\mathscr{M}_{1} \stackrel{M}{\otimes} \mathscr{M}_{2}\right) \oplus\left(\mathscr{M}_{1} \stackrel{M}{\otimes} \mathscr{M}_{3}\right)$ by the same proof of [Akh00, Prop. 3.5.6] (Note that the Somekawa $K$-group used in [Akh00] is a quotient of the Mackey product). Moreover, we have

$$
\mathscr{M}_{1} \stackrel{M}{\otimes} \mathscr{M}_{2} \stackrel{M}{\otimes} \mathscr{M}_{3} \simeq\left(\mathscr{M}_{1} \stackrel{M}{\otimes} \mathscr{M}_{2}\right)^{M} \mathscr{M}_{3} \simeq \mathscr{M}_{1} \stackrel{M}{\otimes}\left(\mathscr{M}_{2}{ }^{M} \mathscr{M}_{3}\right)
$$

## 3. de Rham-Witt complex

In this section, we recall the notion of the de Rham-Witt complex and its properties following [Rül07]. Let $k$ be a field of characteristic $p \geq 0$. A truncation set $S \subset$ $\mathbb{N}:=\mathbb{Z}_{>0}$ is a nonempty subset such that if $s \in S$ and $t \mid s$ then $t \in S$. For each truncation set $S$, let $\mathbb{W}_{S}(k)$ be the ring of Witt vectors (cf. [Rül07, Appendix]). The trace map $\operatorname{Tr}_{L / K}: \mathbb{W}_{S}(L) \rightarrow \mathbb{W}_{S}(K)$ and the restriction $\operatorname{res}_{L / K}: \mathbb{W}_{S}(K) \rightarrow \mathbb{W}_{S}(L)$ make the structure of the Mackey functor on $\mathbb{W}_{S}([$ Rül07, Prop. A.9]). For a finite truncation set $S$, the de Rham-Witt complex $\mathbb{W}_{S} \Omega_{k}^{\bullet}$ is a quotient of the differential graded algebra $\Omega_{\mathbb{W}_{S}(k) / \mathbb{Z}} \boldsymbol{L}$ satisfying

\mathbb{W}_{\{1\}} \Omega_{k}^{\bullet} \simeq \Omega_{k / \mathbb{Z}}^{\bullet}, \quad \text { and } \quad \mathbb{W}_{S} \Omega_{k}^{0} \simeq \mathbb{W}_{S}(k),
$$

and has some natural maps

$$
V_{n}: \mathbb{W}_{S / n} \Omega_{k}^{\bullet} \rightarrow \mathbb{W}_{S} \Omega_{k}^{\bullet}, \quad \text { and } \quad F_{n}: \mathbb{W}_{S} \Omega_{k}^{\bullet} \rightarrow \mathbb{W}_{S / n} \Omega_{k}^{\bullet},
$$

where $S / n:=\{s \in \mathbb{N} \mid n s \in S\}$ (cf. [Rül07, Prop. 1.2]). For a truncation set $T \subset S$, the restriction map $\mathbb{W}_{S}(k) \rightarrow \mathbb{W}_{T}(k) ; \mathbf{a}=\left.\left(a_{s}\right)_{s \in S} \mapsto \mathbf{a}\right|_{T}:=\left(a_{s}\right)_{s \in T}$ induces a map of differential graded algebras

$$
\begin{equation*}
R_{T}^{S}: \mathbb{W}_{S} \Omega_{k}^{\bullet} \rightarrow \mathbb{W}_{T} \Omega_{k}^{\bullet} \tag{3.1}
\end{equation*}
$$

For an arbitrary truncation set $S$, the restriction (3.1) gives the inverse system $\left(\mathbb{W}_{S_{0}} \Omega_{k}^{*}\right)_{S_{0} \subset S}$, where $S_{0}$ runs through the set of all finite truncation set contained in $S$. We define

$$
\mathbb{W}_{S} \Omega_{k}^{\bullet}:=\lim _{S_{0} \subset S} \mathbb{W}_{S_{0}} \Omega_{k}^{\bullet}
$$

For any extension $L / K$ in the category $\operatorname{Ext}_{k}$, the natural homomorphism $\mathbb{W}_{S}(K) \rightarrow$ $\mathbb{W}_{S}(L)$ of rings (cf. [Rü107, A.1]) induces $\Omega_{\mathbb{W}_{S}(K)}^{\bullet} \rightarrow \Omega_{\mathbb{W}_{S}(L)}^{\bullet}$ and hence the restriction map

$$
\operatorname{res}_{L / K}: \mathbb{W}_{S} \Omega_{K}^{\bullet} \rightarrow \mathbb{W}_{S} \Omega_{L}^{\bullet}
$$

Define $p S:=S \cup\{p s \mid s \in S\}$. There is a map of differential graded algebras

$$
\underline{p}: \mathbb{W}_{S} \Omega_{K}^{\bullet} \rightarrow \mathbb{W}_{p S} \Omega_{L}^{\bullet} ; \omega \mapsto p \widetilde{\omega},
$$

where $\widetilde{\omega}$ is a lift of $\omega$ to $\mathbb{W}_{p S} \Omega_{L}^{\bullet}$ with respect to the map $R_{S}^{p S}$ (3.1) ([Rü107, Def. 2.5]). For a finite truncation set $S$, the correspondence $K / k \mapsto \mathbb{W}_{S} \Omega_{K}^{n}$ forms a Mackey functor using the trace map below ([Rü107, Prop. 2.7]).

Theorem 3.1 ([Riul07, Thm. 2.6], [KP21, Thm. A.2]). Let L/K be a finite field extension in $\operatorname{Ext}_{k}$ and $S$ a finite truncation set. Then, there is a map of differential graded $\mathbb{W}_{S} \Omega_{K^{-}}^{\bullet}$ modules

$$
\operatorname{Tr}_{L / K}: \mathbb{W}_{S} \Omega_{L}^{\bullet} \rightarrow \mathbb{W}_{S} \Omega_{K}^{\bullet}
$$

satisfying the following properties:
(a) If the extension $L / K$ is separable, then the isomorphism $\mathbb{W}_{S}(L) \otimes_{\mathbb{W}_{S}(K)} \mathbb{W}_{S} \Omega_{K}^{n} \xrightarrow{\simeq}$ $\mathbb{W}_{S} \Omega_{L}^{n} ; \boldsymbol{\alpha} \otimes \omega \mapsto \boldsymbol{\alpha} \omega$ gives the map $\operatorname{Tr}_{L / K}$ by

$$
\mathbb{W}_{S} \Omega_{L}^{n} \cong \mathbb{W}_{S}(L) \otimes \mathbb{W}_{S} \Omega_{K}^{n} \xrightarrow{\operatorname{Tr}_{L / K} \otimes \mathrm{id}} \mathbb{W}_{S}(K) \otimes_{\mathbb{W}_{S}(K)} \mathbb{W}_{S} \Omega_{K}^{n} \simeq \mathbb{W}_{S} \Omega_{K}^{n} .
$$

(b) If $L / K$ is purely inseparable of degree $p$ and $\omega \in \mathbb{W}_{S} \Omega_{L}^{n}$, then $\operatorname{Tr}_{L / K}(\omega)=R_{S}^{p S}(\eta)$, where $\operatorname{res}_{L / K}(\eta)=\underline{p}(\omega)$ for some $\eta \in \mathbb{W}_{p S} \Omega_{K}^{n}$.
(c) If $K \subset M \subset L$ are finite field extensions, then we have $\operatorname{Tr}_{L / K}=\operatorname{Tr}_{M / K} \circ \operatorname{Tr}_{L / M}$.
(d) The map $\operatorname{Tr}_{L / K}$ commutes with $V_{n}, F_{n}$ and the restriction $R_{T}^{S}$.

In the case where $k$ has positive characteristic $p>0$, taking the truncation set $P_{r}:=$ $\left\{1, p, p^{2}, \ldots, p^{r-1}\right\}$ for $r \geq 1$, we define $W_{r} \Omega_{k}^{\bullet}:=\mathbb{W}_{P_{r}} \Omega_{k}^{\bullet}$. This is the classical $p$-typical de Rham-Witt complex of $k$ ([T1179]). In particular, $W_{r} \Omega_{k}^{0}=W_{r}(k)$ is the ring of $p$-typical Witt vectors of length $r$ in $k$. It is customary to write

F & :=F_{p}: W_{r+1} \Omega_{k}^{\bullet} \rightarrow W_{r} \Omega_{k}^{\bullet}, \quad \text { and }  \tag{3.2}\\
R & :=R_{P_{r}}^{P_{r+1}}: W_{r+1} \Omega_{k}^{\bullet} \rightarrow W_{r} \Omega_{k}^{\bullet} .
\end{align*}
$$

Furthermore, the map $F: W_{r+1} \Omega_{k}^{\bullet} \rightarrow W_{r} \Omega_{k}^{\bullet}$ induces

$$
\begin{equation*}
F: W_{r} \Omega_{k}^{n} \rightarrow W_{r} \Omega_{k}^{n} / \mathrm{d} V^{r-1} \Omega_{k}^{n-1} \tag{3.3}
\end{equation*}
$$

([11179, Prop. 3.3], [Shi07, Lem. 2.7]). By [Rül07, Thm. 1.11], for a finite truncation set $S$, there is a canonical decomposition (with respect to $S$ )

\mathbb{W}_{S} \Omega_{k}^{n} \simeq \prod_{(m, p)=1} W_{r_{m}} \Omega_{k}^{n} \tag{3.4}
\end{equation*}
$$

where $r_{m}:=\#\left(S / m \cap\left\{1, p, p^{2}, \ldots\right\}\right)+1$. There is a natural homomorphism

\mathrm{dlog}: k^{\times} \rightarrow W_{r} \Omega_{k}^{1} ; b \mapsto \operatorname{dlog}[b]:=\mathrm{d}[b] /[b],
$$

where $[b]:=(b, 0, \ldots, 0) \in W_{r} \Omega_{k}^{1}$.
Lemma 3.2. For any $r \geq 1$, and for any finite field extension $L / K$ in $\operatorname{Ext}_{k}$, the following diagram is commutative:


Proof. For any $\beta \in L^{\times}$, we show the equality

$$
\begin{equation*}
\operatorname{Tr}_{L / K}(\mathrm{~d} \log [\beta])=\mathrm{d} \log \left[N_{L / K} \beta\right] . \tag{3.5}
\end{equation*}
$$

By taking the separable closure of $L / K$, the extension $L / K$ is written as a finite separable extension followed by a purely inseparable extension. Since every finite purely inseparable extension is decomposed as a sequence of extensions of prime degree $p$, it suffices to show the assertion in the cases where the extension $L / K$ is either separable or purely inseparable of degree $p$. In the former case, the equality (3.5) follows from the construction of the trace map ([Rül07, Proof of Thm. 2.6]). Next, we assume that the extension $L / K$ is purely inseparable of degree $p$. Denoting the Teichmüller map as $[-]_{r, K}: K^{\times} \rightarrow W_{r} \Omega_{K}^{1}$ in this proof, we obtain

& =\operatorname{dlog}\left(\left[\beta^{p}\right]_{r+1, L}\right) \\
& =\operatorname{res}_{L / K}\left(\operatorname{dlog}\left(\left[N_{L / K} \beta\right]_{r+1, K}\right)\right) \quad\left(\text { by } N_{L / K}(\beta)=\beta^{p}\right)
\end{aligned}
$$

By Theorem 3.1 (b), we have

$$
\operatorname{Tr}_{L / K}\left(\operatorname{dlog}\left([\beta]_{r, L}\right)\right)=R\left(\operatorname{dlog}\left(\left[N_{L / K} \beta\right]_{r+1, K}\right)\right)=\operatorname{dlog}\left(\left[N_{L / K} \beta\right]_{r, K}\right)
$$

where $R=R_{P_{r}}^{P_{r+1}}$ (cf. (3.2)).
The subgroup of $W_{r} \Omega_{k}^{n}$ generated by $\operatorname{dlog}\left[b_{1}\right] \cdots \mathrm{d} \log \left[b_{n}\right]$ for $b_{1}, \ldots, b_{n} \in k^{\times}$is denoted by $W_{r} \Omega_{k, \log }^{n}$. We put

$$
H^{n}\left(k, \mathbb{Z} / p^{r}(m)\right)=H^{n-m}\left(k, W_{r} \Omega_{k^{\text {sep }}, \log }^{m}\right)
$$

For any $r \in \mathbb{Z}_{>0}$ and $n \in \mathbb{Z}_{\geq 0}$, the differential symbol map

s_{k, p^{r}}^{n}: K_{n}^{M}(k) / p^{r} \xrightarrow{\simeq} H^{n}\left(k, \mathbb{Z} / p^{r}(n)\right)=W_{r} \Omega_{k, \log }^{n} \tag{3.6}
\end{equation*}
$$

introduced in Theorem 1.2 is given by $\left\{a_{1}, \ldots, a_{n}\right\}_{k} \mapsto \operatorname{dlog}\left[a_{1}\right] \cdots \operatorname{dlog}\left[a_{n}\right]$.

## 4. Mackey products and the Milnor $K$-groups

Let $k$ be a field of characteristic $p \geq 0$. As referred in Introduction, B. Kahn gives an isomorphism $\mathbb{G}_{m}^{M}{ }^{\otimes n}(k) / m \simeq K_{n}^{M}(k) / m$ between the Mackey product of $\mathbb{G}_{m}$ 's (Definition 2.3) and the Milnor $K$-group modulo $m$ (Example 2.2 (iii)) which is announced in [RS00, Rem. 4.2.5 (b)] without proof. In this section, we give a proof of this theorem (Theorem 4.5).
Proposition 4.1. For any $n \geq 0$, and any $m \geq 1$, there is a surjective homomorphism $\pi_{k, m}^{n}: \mathbb{G}_{m}^{\otimes n}(k) / m \rightarrow K_{n}^{M}(k) / m$.

Proof. By [Som90, Thm. 1.4], we have a canonical isomorphism $K\left(k ; \mathbb{G}_{m}, \ldots, \mathbb{G}_{m}\right) \simeq$ $K_{n}^{M}(k)$. As the Somekawa $K$-group is a quotient of the Mackey product $\mathbb{G}_{m}^{M} n(k)$, there is a surjective homomorphism $\pi_{k, m}^{n}: \mathbb{G}_{m}^{M n}(k) / m \rightarrow K_{n}^{M}(k) / m$ which is given by $\pi_{k, m}\left(\left\{a_{1}, \ldots, a_{n}\right\}_{K / k}\right)=$ $N_{K / k}\left(\left\{a_{1}, \ldots, a_{n}\right\}_{K}\right)$, where $N_{K / k}: K_{n}^{M}(K) \rightarrow K_{n}^{M}(k)$ is the norm map on the Milnor $K$-groups.

For simplicity, we often abbreviate $\operatorname{res}_{L / K}(x)$ in $\mathbb{G}_{m}(L) / m=L^{\times} / m$ as $x$ for $x \in$ $\mathbb{G}_{m}(K) / m=K^{\times} / m$. For a fixed prime number $l$, we denote by $\operatorname{Symb}_{l}(k)$ the subgroup of $\mathbb{G}_{m}^{M n}(k) / l$ generated by the symbols of the form $\left\{a_{1}, \ldots, a_{n}\right\}_{k / k}$ for $a_{i} \in k^{\times}$.

Lemma 4.2. For a prime number $l$, the map $\pi_{k, l}^{n}: \mathbb{G}_{m}^{\otimes n}(k) / l \rightarrow K_{n}^{M}(k) / l$ induces an isomorphism $\operatorname{Symb}_{l}(k) \xrightarrow{\simeq} K_{n}^{M}(k) / l$.
Proof. To show that $\varphi_{k}: K_{n}^{M}(k) / l \rightarrow \mathbb{G}_{m}^{M M}(k) / l ;\left\{a_{1}, \ldots, a_{n}\right\}_{k} \mapsto\left\{a_{1}, \ldots, a_{n}\right\}_{k / k}$ is welldefined, we prove $\left\{a, 1-a, a_{2}, \ldots, a_{n}\right\}_{k / k}=0$ in $\mathbb{G}_{m}^{M n}(k) / l$ for some $a \notin\left(k^{\times}\right)^{l}$. First, we consider the case $l \neq p$ (this is a direct consequence of [RS00, Lem. 4.2.6]). Let $T^{l}-a=\prod_{i} f_{i}(T)$ be the decomposition with monic and irreducible polynomials $f_{i}(T)$ in $k[T]$. For each $i$, let $\alpha_{i} \in k^{\text {sep }}$ be a root of $f_{i}(T)$ and put $K_{i}=k\left(\alpha_{i}\right)$. Then,

$$
1-a=\prod_{i} f_{i}(1)=\prod_{i} N_{K_{i} / k}\left(1-\alpha_{i}\right) .
$$

We have

$$
\begin{aligned}
& \left\{a, 1-a, a_{2}, \ldots, a_{n}\right\}_{k / k} \\
& =\sum_{i}\left\{a, N_{K_{i} / k}\left(\alpha_{i}\right), a_{2}, \ldots, a_{n}\right\}_{k / k} \\
& =\sum_{i}\left\{a, \alpha_{i}, a_{2}, \ldots, a_{n}\right\}_{K_{i} / k}(\text { by }(\mathbf{P F})) \\
& =\sum_{i}\left\{\left(\alpha_{i}\right)^{l}, \alpha_{i}, a_{2}, \ldots, a_{n}\right\}_{K_{i} / k} \quad\left(\text { by }\left(\alpha_{i}\right)^{l}-a=\prod_{j} f_{j}\left(\alpha_{i}\right)=0\right) \\
& =0 \quad \text { in } \mathbb{G}_{m}^{M}(k) / l .
\end{aligned}
$$

Next, we treat the case $p>0$ and $l=p$. Let us consider the purely inseparable extension $K:=k(\sqrt[p]{a}) / k$ of degree $p$. The norm map gives $N_{K / k}(\sqrt[p]{a})=(\sqrt[p]{a})^{p}=a$. Therefore, by the projection formula ( $\mathbf{P F}$ ), we have

$$
\begin{aligned}
\left\{a, 1-a, a_{2}, \ldots, a_{n}\right\}_{k / k} & =\left\{N_{K / k}(\sqrt[p]{a}), 1-a, a_{2}, \ldots, a_{n}\right\}_{k / k} \\
& =\left\{\sqrt[p]{a}, 1-a, a_{2}, \ldots, a_{n}\right\}_{K / k}
\end{aligned}
$$

The equality $1-a=(1-\sqrt[p]{a})^{p}$ in $K$, gives $\left\{a, 1-a, a_{2}, \ldots, a_{n}\right\}_{k / k}=0$.
Theorem 4.3. Let $l$ be a prime number. We assume that $k$ contains a primitive l-th root of unity when $l \neq p$. Then, for any $n \geq 1$, the map $\pi_{k, l}^{n}: \mathbb{G}_{m}^{M n}(k) / l \rightarrow K_{n}^{M}(k) / l$ is bijective.

Proof. Put $\pi_{k}:=\pi_{k, l}^{n}$. From Lemma 4.2, we have a map $\varphi_{k}: K_{n}^{M}(k) / l \rightarrow \mathbb{G}_{m}^{\otimes n}(k) / l$ defined by $\varphi_{k}\left(\left\{a_{1}, \ldots, a_{n}\right\}_{k}\right)=\left\{a_{1}, \ldots, a_{n}\right\}_{k / k}$ and this gives $\pi_{k} \circ \varphi_{k}=\mathrm{id}$. To show Theorem 4.3, it is sufficient to prove that $\varphi_{k}$ is surjective or $\pi_{k}$ is injective.

Let $k^{(l)} / k$ be the field extension corresponding to the $l$-Sylow subgroup of $\operatorname{Gal}\left(k^{\text {sep }} / k\right)$. The following diagram is commutative:

$$
\begin{array}{cc}
\mathbb{G}_{m}^{\otimes n}\left(k^{(l)}\right) / l l & \xrightarrow{\pi_{k}(l)} \\
\operatorname{res}_{k}(l) / k & K_{n}^{M}\left(k^{(l)}\right) / l \\
& \uparrow{ }^{\operatorname{res}_{k}(l) / k} \\
\mathbb{G}_{m}^{\otimes n}(k) / l \xrightarrow{M} & \xrightarrow{\pi_{k}} \\
K_{n}^{M}(k) / l .
\end{array}
$$

To show that $\pi_{k}$ is injective, take any $\xi \in \mathbb{G}_{m}^{M}(k) / l$ with $\pi_{k}(\xi)=0$. If we assume that $\pi_{k^{(l)}}$ is bijective, we have $\operatorname{res}_{k^{(l)} / k}(\xi)=0$ in $\mathbb{G}_{m}^{M n}\left(k^{(l)}\right) / l$. One can write $\mathbb{G}_{m}^{M n}\left(k^{(l)}\right) / l \simeq$ $\underset{\longrightarrow}{\lim }\left(\mathbb{G}_{m}^{M n} / l\right)(K)$, where $K$ runs through all finite extension $K / k$ within $k^{(l)}$ (for the proof, see [Akh00, Lem. 3.6.4]). There exists a subextension $k \subset K \subset k^{(l)}$ such that $[K: k$ ] is finite and $\operatorname{res}_{K / k}(\xi)=0$. This implies $[K: k] \xi=\operatorname{tr}_{K / k} \circ \operatorname{res}_{K / k}(\xi)=0$. Since $[K: k]$ is prime to $l$, the restriction $\operatorname{res}_{K / k}$ is injective so that we obtain $\xi=0$. Consequently, we may assume $k=k^{(l)}$ and it is left to show that $\varphi_{k}$ is surjective. Take any symbol $\left\{\alpha_{1}, \ldots, \alpha_{n}\right\}_{K / k}$ in $\mathbb{G}_{m}^{M n}(k) / l$ and we show that this is in $\operatorname{Symb}_{l}(k)$. There exists a tower of fields $k=k_{0} \subset k_{1} \subset k_{2} \subset \cdots \subset k_{r}=K$ such that $\left[k_{i}: k_{i-1}\right]=l$. By induction on $r$, we may assume $[K: k]=l$. It is known that $\left\{\alpha_{1}, \ldots, \alpha_{n}\right\}_{K} \in K_{n}^{M}(K)$ is written as a sum of elements of the form $\left\{\xi, x_{2}, \ldots, x_{n}\right\}_{K}$ for some $\xi \in K^{\times}$and $x_{2}, \ldots, x_{n} \in k^{\times}$ (Proposition 4.4 below). From Lemma 4.2, we have

$$
\left\{\alpha_{1}, \ldots, \alpha_{n}\right\}_{K / K}=\sum_{i}\left\{\xi^{(i)}, x_{2}^{(i)}, \ldots, x_{n}^{(i)}\right\}_{K / K}
$$

for some $\xi^{(i)} \in K^{\times}$and $x_{2}^{(i)}, \ldots, x_{n}^{(i)} \in k^{\times}$. By the projection formula (PF), we obtain

$$
\begin{aligned}
\left\{\alpha_{1}, \ldots, \alpha_{n}\right\}_{K / k} & =\operatorname{tr}_{K / k}\left(\left\{\alpha_{1}, \ldots, \alpha_{n}\right\}_{K / K}\right) \\
& =\sum_{i} \operatorname{tr}_{K / k}\left(\left\{\xi^{(i)}, x_{2}^{(i)}, \ldots, x_{n}^{(i)}\right\}_{K / K}\right) \\
& =\sum_{i}\left\{\xi^{(i)}, x_{2}^{(i)}, \ldots, x_{n}^{(i)}\right\}_{K / k} \\
& =\sum_{i}\left\{N_{K / k}\left(\xi^{(i)}\right), x_{2}^{(i)}, \ldots, x_{n}^{(i)}\right\}_{k / k} .
\end{aligned}
$$

Namely, $\left\{\alpha_{1}, \ldots, \alpha_{n}\right\}_{K / k}$ is in $\operatorname{Symb}_{l}(k)$ and the map $\varphi_{k}$ is surjective.
Proposition 4.4 ([BT73, Chap. I, Cor. 5.3], [Akh00, Prop. 2.2.3]). Let $k$ be a field and $l$ a prime number. Suppose that every finite extension of $k$ is of degree $l^{r}$ for some $r \geq 0$. Then, for an extension $K / k$ of degree $l$, the group $K_{n}^{M}(K)$ is generated by symbols of the form $\left\{\xi, x_{2}, \ldots, x_{n}\right\}_{K}$ where $\xi \in K^{\times}$and $x_{2}, \ldots, x_{n} \in k^{\times}$.

Theorem 4.5. Let $k$ be an arbitrary field of characteristic $p \geq 0$. For any $m \geq 1$ and $n \geq 0$, the map $\pi_{k, m}^{n}: \mathbb{G}_{m}^{M n}(k) / m \xrightarrow{\simeq} K_{n}^{M}(k) / m$ is bijective. Moreover, this gives an isomorphism of Mackey functors $\mathbb{G}_{m}^{\otimes \otimes} / m \simeq K_{n}^{M} / m$.
Proof. Putting $\mathbb{G}_{m}^{\mathbb{D}^{\otimes 0}}(k)=\mathbb{Z}$, for the cases $n=0$ and $n=1$, there is nothing to show so that we assume $n \geq 2$. Put $m=m^{\prime} p^{r}$ with an integer $m^{\prime}>0$ prime to $p$. The Galois
symbol map (1.1) and the differential symbol map (Theorem 1.2) give an isomorphism

$$
s_{k, m}^{n}: K_{n}^{M}(k) / m \xrightarrow{\simeq} H^{n}\left(k, \mathbb{Z} / m^{\prime}(n)\right) \oplus H^{n}\left(k, \mathbb{Z} / p^{r}(n)\right) .
$$

In the following, we often identify $K_{n}^{M}(k) / m$ and $H^{n}(k, \mathbb{Z} / m(n))$ through this isomorphism. By Proposition 4.1, $\pi_{k, m}^{n}$ is surjective which is given by $\pi_{k, m}\left(\left\{a_{1}, \ldots, a_{n}\right\}_{K / k}\right)=$ $N_{K / k}\left(\left\{a_{1}, \ldots, a_{n}\right\}_{K}\right)$. It is enough to show that $\pi_{k, l^{r}}^{n}: \mathbb{G}_{m}^{\otimes n}(k) / l^{r} \rightarrow K_{n}^{M}(k) / l^{r}$ is injective for any prime $l$ and $r \geq 1$. Now, we divide the proof into the two cases (a) $l \neq p$, and (b) $l=p>0$.

In the case (a): $l \neq p$, by the standard arguments, we will reduce to showing the case that $k$ contains a primitive $l$-th root of unity (e.g., [Kah97, Sect. 1.2], [Sus99, Sect. 1]). Take a primitive $l$-th root of unity $\zeta_{l} \in k^{\text {sep }}$ and put $k^{\prime}:=k\left(\zeta_{l}\right)$ which is a field extension of $k$ of degree prime to $l$. There is a commutative diagram:

$$
\begin{array}{cc}
\mathbb{G}_{m}^{\otimes n}\left(k^{\prime}\right) / l^{r} & \xrightarrow{\pi_{k^{\prime}, l^{r}}^{n}} K_{n}^{M}\left(k^{\prime}\right) / l^{r} \\
\operatorname{res}_{k^{\prime} / k} \uparrow & \uparrow \operatorname{res}_{k^{\prime} / k} \\
\mathbb{G}_{m}^{M}(k) / l^{r} & \xrightarrow{\pi_{k, l^{r}}^{n}}
\end{array} K_{n}^{M}(k) / l^{r} .
$$

Since $\left[k^{\prime}: k\right]$ is prime to $l$, the restriction maps are injective. If $\pi_{k^{\prime}, l^{r}}^{n}$ is injective, so is $\pi_{k, l^{r}}^{n}$. Accordingly, we may assume $\zeta_{l} \in k$. Next, we consider the commutative diagram below:

$$
\begin{aligned}
& \mathbb{G}_{m}^{\stackrel{M}{\otimes}(n-1)}(k) / l \xrightarrow{\left\{\zeta_{l},-, \ldots,-\right\}_{k / k}} \mathbb{G}_{m}^{\otimes \otimes n}(k) / l^{r} \longrightarrow \mathbb{G}_{m}^{M n}(k) / l^{r+1} \longrightarrow \mathbb{G}_{m}^{M n}(k) / l \longrightarrow 0 \\
& \downarrow \pi_{k, l}^{n-1} \quad \int_{k, l^{r}} \quad \operatorname{\pi }_{k, l r+1}^{n} \quad \downarrow \pi_{k, l}^{n} \\
& H^{n-1}(k, \mathbb{Z} / l(n-1)) \xrightarrow{\zeta_{i} \cup-} H^{n}\left(k, \mathbb{Z} / l^{r}(n)\right) \longrightarrow H^{n}\left(k, \mathbb{Z} / l^{r+1}(n)\right) \longrightarrow H^{n}(k, \mathbb{Z} / l(n)) .
\end{aligned}
$$

In the above diagram, the lower sequence is a part of the long exact sequence induced from the short exact sequence $0 \rightarrow \mu_{l^{r}}^{\otimes n} \rightarrow \mu_{l^{r+1}}^{\otimes n} \rightarrow \mu_{l}^{\otimes n} \rightarrow 0$. The upper one is a complex and exact except the term $\mathbb{G}_{m}^{M n}(k) / l^{r}$. By the induction on $r$ and Theorem 4.3, $\pi_{k, l^{r+1}}^{n}$ is bijective.

Consider the case (b): $l=p>0$. As in the proof of [BK86, Cor. 2.8], we have the following commutative diagram with exact rows:

$$
\begin{align*}
& \mathbb{G}_{m}^{\stackrel{M}{\otimes} n}(k) / p \longrightarrow \mathbb{G}_{m}^{\stackrel{M}{\otimes n} n}(k) / p^{r+1} \longrightarrow \mathbb{G}_{m}^{\stackrel{M}{\otimes} n}(k) / p^{r} \longrightarrow 0 \\
& \downarrow_{k, p}^{\pi_{k, p}^{n}} \not \overbrace{k, p^{r+1}}^{n} \quad \pi_{k, p^{r}}^{n}  \tag{4.1}\\
& 0 \longrightarrow K_{n}^{M}(k) / p \longrightarrow K_{n}^{M}(k) / p^{r+1} \longrightarrow K_{n}^{M}(k) / p^{r} \longrightarrow 0 .
\end{align*}
$$

In fact, the exactness of the lower horizontal sequence follows from

$$
\begin{aligned}
& K_{n}^{M}(k) / p \longrightarrow K_{n}^{M}(k) / p^{r+1} \longrightarrow K_{n}^{M}(k) / p^{r} \longrightarrow 0 \\
& \downarrow s_{k, p}^{n} \quad \downarrow s_{k, p^{r+1}}^{n} \quad \downarrow s_{k, p^{n}}^{n} \\
& 0 \longrightarrow H^{n}(k, \mathbb{Z} / p(n)) \longrightarrow H^{n}\left(k, \mathbb{Z} / p^{r+1}(n)\right) \longrightarrow H^{n}\left(k, \mathbb{Z} / p^{r}(n)\right)
\end{aligned}
$$

and the Bloch-Gabber-Kato theorem (Theorem 1.2). By the induction on $r$ and the digram (4.1), Theorem 4.5 follows from Theorem 4.3.

## 5. Mackey products and the de Rham-Witt complex

Let $k$ be a field of positive characteristic $p>0$ and $k^{\text {sep }}$ the separable closure of $k$ in an algebraic closure of $k$. For an extension $K / k$, we consider the $p$-th power Frobenius $\phi: K \rightarrow K ; a \mapsto a^{p}$. The induced homomorphism $W_{r}(\phi): W_{r+1}(k) \rightarrow W_{r}(k)$ coincides with $F: W_{r}(k) \rightarrow W_{r}(k)$ (cf. (3.3)). For any $r \geq 1$ and any field extension $K / k$, we consider the homomorphism

$$
\wp=F-\mathrm{id}: W_{r}(K) \rightarrow W_{r}(K)
$$

The map $\wp$ also induces the map $\wp: W_{r} \rightarrow W_{r}$ of Mackey functors ([Rül07, Prop. A. 9 (v)]). For any Mackey functor $\mathscr{M}$, we define a map

$$
\begin{equation*}
\wp:=\wp \stackrel{M}{\otimes} \mathrm{id}: W_{r} \stackrel{M}{\otimes} \mathscr{M} \rightarrow W_{r} \stackrel{M}{\otimes} \mathscr{M} . \tag{5.1}
\end{equation*}
$$

For simplicity, we denote also the induced map $\wp(k):\left(W_{r}{ }^{M} \mathscr{M}\right)(k) \rightarrow\left(W_{r} \stackrel{M}{\otimes} \mathscr{M}\right)(k)$ by $\wp$.
Lemma 5.1. For any Mackey functor $\mathscr{M}$ over $k$, We have isomorphisms

$$
\left(W_{r} \stackrel{M}{\otimes} \mathscr{M}\right) / \wp \simeq W_{r} / \wp \stackrel{M}{\otimes} \mathscr{M} \simeq W_{r} / \wp \stackrel{M}{\otimes} \mathscr{M} / p^{r} .
$$

Proof. Recalling from Example 2.2 (i), $\left(W_{r} \stackrel{M}{\otimes} \mathscr{M}\right) / \wp$ is the cokernel of $\wp: W_{r}{ }^{M} \mathscr{M} \rightarrow$ $W_{r}{ }^{M} \mathscr{Q} \mathscr{M}$ defined in (5.1). The isomorphism $\left(W_{r}{ }^{M} \mathscr{Q}\right) / \wp \simeq W_{r} / \wp{ }^{M}{ }_{Q}^{M} \mathscr{M}$ follows from the right exactness of the product $-\stackrel{M}{\otimes} \mathscr{M}$. Since the Witt ring $W_{r}(K)$ is annihilated by $p^{r}$, we obtain $W_{r} / \wp \stackrel{M}{\otimes} \mathscr{M} \simeq W_{r} / \wp \stackrel{M}{\otimes} \mathscr{M} / p^{r}$.

For any $n \geq 1$, the cokernel of the extended $\wp$ with respect to the product $\mathbb{G}_{m}^{\stackrel{M}{\otimes}(n-1)}$ (cf. (5.1)) is denoted by

$$
M_{p^{r}}^{n}:=\left(W_{r} \stackrel{M}{\otimes} \mathbb{G}_{m}^{M(n-1)}\right) / \wp .
$$

Corollary 5.2. If $k$ is perfect and $n \geq 2$, then $M_{p^{r}}^{n}(k)=0$.
Proof. This follows from Lemma 5.1 and $\left(\mathbb{G}_{m} / p^{r}\right)(k)=0$.
We put

$$
H_{p^{r}}^{n}(k):=H^{n}\left(k, \mathbb{Z} / p^{r}(n-1)\right)=H^{1}\left(k, W_{r} \Omega_{\log }^{n-1}\right) .
$$

The map $F: W_{r} \Omega_{k}^{n-1} \rightarrow W_{r} \Omega_{k}^{n-1} / \mathrm{d} V^{r-1} \Omega_{k}^{n-2}$ (cf. (3.3)) induces the following short exact sequence:

$$
\begin{equation*}
0 \rightarrow H^{n-1}\left(k, \mathbb{Z} / p^{r}(n-1)\right) \rightarrow W_{r} \Omega_{k}^{n-1} \xrightarrow{\wp} W_{r} \Omega_{k}^{n-1} / \mathrm{d} V^{r-1} \Omega_{k}^{n-2} \rightarrow H_{p^{r}}^{n}(k) \rightarrow 0 \tag{5.2}
\end{equation*}
$$

where $\wp:=F$-id (cf. [Shi07, Prop. 2.8], [Izh00, Sect. A.1.3]). Since $F$ is a ring homomorphism of $W_{r} \Omega_{k}^{\bullet}$ and satisfies $F(\mathrm{~d}[b])=[b]^{p-1} \mathrm{~d}[b]$, the map $\wp$ is given by $\wp\left(\mathbf{a} \operatorname{d} \log \left[b_{1}\right] \cdots \mathrm{d} \log \left[b_{n-1}\right]\right)=$ $\wp(\mathbf{a}) \mathrm{d} \log \left[b_{1}\right] \cdots \mathrm{d} \log \left[b_{n-1}\right]$. Moreover, we have the following explicit description of $H_{p^{r}}^{n}(k)$.
Theorem 5.3 ([Kat80, Sect. 2, Cor. 4 to Prop. 2], see also [Izh00, Sect. A.1.3]). The natural homomorphism $\mathbf{a} \otimes b_{1} \otimes \cdots \otimes b_{n-1} \mapsto\left[\mathbf{a}, b_{1}, \ldots, b_{n-1}\right)_{k}:=\mathbf{a} \operatorname{dlog}\left[b_{1}\right] \cdots \operatorname{dlog}\left[b_{n-1}\right]$ induces an isomorphism

$$
\left(W_{r}(k) \otimes_{\mathbb{Z}}\left(k^{\times}\right)^{\otimes_{\mathbb{Z}}(n-1)}\right) / J \xrightarrow{\simeq} H_{p^{r}}^{n}(k),
$$

where $J$ is the subgroup generated by all elements of the form:
(a) $\mathbf{a} \otimes b_{1} \otimes \cdots \otimes b_{n-1}$ with $b_{i}=b_{j}$ for some $i \neq j$.
(b) $(0, \ldots, 0, a, 0, \ldots, 0) \otimes a \otimes b_{2} \otimes \cdots \otimes b_{n-1}$ for some $a \in k$.
(c) $\wp(\mathbf{a}) \otimes b_{1} \otimes \cdots \otimes b_{n-1}$.

From the sequence (5.2), we regard $H_{p^{r}}^{n}(k)$ as a quotient of $W_{r} \Omega_{k}^{n-1}$. For any finite field extension $K / k$, the trace map $\operatorname{Tr}_{K / k}: W_{r} \Omega_{K}^{\bullet} \rightarrow W_{r} \Omega_{k}^{\bullet}$ is a map of differential graded modules commutes with $V$ and $F$ (Theorem 3.1). The trace map $\operatorname{Tr}_{K / k}: W_{r} \Omega_{K}^{n-1} \rightarrow$ $W_{r} \Omega_{k}^{n-1}$ induces a map $H_{p^{r}}^{n}(K) \rightarrow H_{p^{r}}^{n}(k)$ which we also write $\operatorname{Tr}_{K / k}$.

Proposition 5.4. There is a surjective homomorphism $t_{k, p^{r}}^{n}: M_{p^{r}}^{n}(k) \rightarrow H_{p^{r}}^{n}(k)$ which is given by

$$
\begin{equation*}
\left\{\mathbf{a}, b_{1}, \ldots, b_{n-1}\right\}_{K / k} \mapsto \operatorname{Tr}_{K / k}\left(\left[\mathbf{a}, b_{1}, \ldots, b_{n-1}\right)_{K}\right) \tag{5.3}
\end{equation*}
$$

Proof. We define $t_{k, p^{r}}^{n}:\left(W_{r} \stackrel{M}{\otimes} \mathbb{G}_{m}^{M(n-1)}\right)(k) \rightarrow H_{p^{r}}^{n}(k)$ by the corresponding given in (5.3). To show that $t_{k, p^{r}}^{n}$ is well-defined, take finite field extensions $k \subset K \subset L$.
Case (a): For $\beta_{i_{0}} \in \mathbb{G}_{m}(L), b_{i} \in \mathbb{G}_{m}(K)$ with $i \neq i_{0}$, and $\mathbf{a} \in W_{r}(K)$, the relation (PF) implies the equality:

$$
\left\{\mathbf{a}, b_{1}, \ldots, N_{L / K}\left(\beta_{i_{0}}\right), \ldots, b_{n-1}\right\}_{K / k}=\left\{\mathbf{a}, b_{1}, \ldots, \beta_{i_{0}}, \ldots, b_{n-1}\right\}_{L / k}
$$

Here, we omit the restriction maps $\operatorname{res}_{L / K}$ in the right. By the transitivity of the trace map $\operatorname{Tr}_{L / k}=\operatorname{Tr}_{K / k} \circ \operatorname{Tr}_{L / K}$ (Theorem 3.1 (c)), it is sufficient to show the equality

$$
\begin{equation*}
\left[\mathbf{a}, b_{1}, \ldots, N_{L / K}\left(\beta_{i_{0}}\right), \ldots, b_{n-1}\right)_{K}=\operatorname{Tr}_{L / K}\left(\left[\mathbf{a}, b_{1}, \ldots, \beta_{i_{0}}, \ldots, b_{n-1}\right)_{L}\right) \tag{5.4}
\end{equation*}
$$

The $W_{r} \Omega_{K}^{n-1}$-linearity of the trace map $\operatorname{Tr}_{L / K}$, and Lemma 3.2 imply the equality (5.4). Case (b): For $\boldsymbol{\alpha} \in W_{r}(L)$ and $b_{i} \in \mathbb{G}_{m}(K)$ for $1 \leq i \leq n-1$, the relation (PF) implies the equality:

$$
\left\{\operatorname{Tr}_{L / K}(\boldsymbol{\alpha}), b_{1}, \ldots, b_{n-1}\right\}_{K / k}=\left\{\boldsymbol{\alpha}, b_{1}, \ldots, b_{n-1}\right\}_{L / k}
$$

By the $W_{r} \Omega_{K}^{n-1}$-linearity of the trace map $\operatorname{Tr}_{L / K}$, we have

$$
\left[\operatorname{Tr}_{L / K}(\boldsymbol{\alpha}), b_{1}, \ldots, b_{n-1}\right)_{K}=\operatorname{Tr}_{L / K}\left(\left[\boldsymbol{\alpha}, b_{1}, \ldots, b_{n-1}\right)_{L}\right)
$$

Hence, $t_{k, p^{n}}^{n}$ is well-defined.
By Theorem 5.3, the map $t_{k, p^{r}}^{n}$ is surjective and factors through the quotient $M_{p^{r}}^{n}(k)$. The induced homomorphism $M_{p^{r}}^{n}(k) \rightarrow H_{p^{r}}^{n}(k)$ is the required one.

Let $\operatorname{Symb}_{p}(k)$ be the subgroup of $M_{p}^{n}(k)=\left(\mathbb{G}_{a} \stackrel{M}{\otimes} \mathbb{G}_{m}^{M(n-1)}\right)(k) / \wp$ generated by the symbols of the form $\left\{a, b_{1}, \ldots, b_{n-1}\right\}_{k / k}$. First we show that the map $t_{k, p}^{n}$ is bijective on the subgroup $\operatorname{Symb}_{p}(k)$.

Lemma 5.5. The map $t_{k, p}^{n}: M_{p}^{n}(k) \rightarrow H_{p}^{n}(k)$ induces an isomorphism $\operatorname{Symb}_{p}(k) \xrightarrow{\simeq}$ $H_{p}^{n}(k)$.

Proof. By using Theorem 5.3, we define a map $\varphi_{k}: H_{p}^{n}(k) \rightarrow \operatorname{Symb}_{p}(k)$ by $\varphi_{k}\left(\left[a, b_{1}, \ldots, b_{n-1}\right)_{k}\right):=$ $\left\{a, b_{1}, \ldots, b_{n-1}\right\}_{k / k}$. To show that $\varphi$ is well-defined, it is left to prove $\left\{a, b_{1}, \ldots, b_{n-1}\right\}_{k / k}=$ 0 if $b_{i}=b_{j}$ for some $i \neq j$, and $\left\{a, a, b_{2}, \ldots, b_{n-1}\right\}_{k / k}=0$ in $M_{p}^{n}(k)$ for some $a \neq 0$. For the first equality, put $b:=b_{i}=b_{j}$. We may assume $b \notin\left(k^{\times}\right)^{p}$. Consider the purely
inseparable extension $K:=k(\sqrt[p]{b})$ of $k$. Since we have $N_{K / k}(\sqrt[p]{b})=(\sqrt[p]{b})^{p}=b_{i}$, the projection formula (PF) gives

$$
\begin{aligned}
\left\{a, b_{1}, \ldots, b_{i}, \ldots, b_{j}, \ldots, b_{n-1}\right\}_{k / k} & =\left\{a, b_{1}, \ldots, N_{K / k}(\sqrt[p]{b}), \ldots, b_{j}, \ldots, b_{n-1}\right\}_{k / k} \\
& =\left\{a, b_{1}, \ldots, \sqrt[p]{b}, \ldots, b_{j}, \ldots, b_{n-1}\right\}_{K / k}
\end{aligned}
$$

By $b_{j}=(\sqrt[p]{b})^{p}$ in $K$, we obtain $\left\{a, b_{1}, \ldots, b_{n-1}\right\}_{k / k}=0$ in $M_{p}^{n}(k)$.
To show the equality $\left\{a, a, b_{2}, \ldots, b_{n-1}\right\}_{k / k}=0$. Consider the polynomial $f(T)=$ $T^{p}-T-a$ in $k[T]$ and take a root $\alpha \in k^{\text {sep }}$ of $f(T)$. In the case $\alpha \in k$, we derive $\wp(\alpha)=\alpha^{p}-\alpha=a$, and hence $\left\{a, a, b_{2}, \ldots, b_{n-1}\right\}_{k / k}=0$ in $M_{p}^{n}(k)$. When $\alpha \notin k$, the polynomial $f(T)$ is irreducible. In fact, the remaining roots of $f(T)$ can be expressed as $\alpha+i$ for $i \in \mathbb{F}_{p}^{\times}$. If $g(T)$ is an irreducible factor of degree $r \leq p$, then the coefficient of $T^{r-1}$ in $g(T)$ is $-\sum_{j=1}^{r}\left(\alpha+i_{j}\right)$ for some $i_{1}, \ldots, i_{r} \in \mathbb{F}_{p}$. Since this coefficient belongs to $k$, we conclude $r=p$ implying $f(T)=g(T)$. Now, let us put $K=k(\alpha)$. Then,

$$
-a=f(0)=(-1)^{p} N_{K / k}(\alpha) .
$$

This yields $a=N_{K / k}(\alpha)$. Thus, we have

$$
\begin{aligned}
\left\{a, a, b_{2}, \ldots, b_{n-1}\right\}_{k / k} & =\left\{a, N_{K / k}(\alpha), b_{2}, \ldots, b_{n-1}\right\}_{k / k} \\
& =\left\{a, \alpha, b_{2}, \ldots, b_{n-1}\right\}_{K / k} \quad(\text { by }(\mathbf{P F})) \\
& =\left\{\wp(\alpha), \alpha, b_{2}, \ldots, b_{n-1}\right\}_{K / k} \quad\left(\text { by } \alpha^{p}-\alpha-a=f(\alpha)=0\right) \\
& =0 \quad \text { in } M_{p}^{n}(k) .
\end{aligned}
$$

Clearly, we have $\varphi_{k} \circ t_{k, p}^{n}=\operatorname{id}$ on $\operatorname{Symb}_{p}(k)$. The map $t_{k, p}^{n}$ induces a bijection $\operatorname{Symb}_{p}(k) \xrightarrow{\simeq}$ $H_{p}^{n}(k)$.
Proposition 5.6. Let $k$ be a field of characteristic $p>0$. Suppose that every finite extension of $k$ is of degree $p^{r}$ for some $r \geq 0$. Then, for $n \geq 2$ and for an extension $K / k$ of degree $p$, the quotient group $\Omega_{K}^{n-1} / \mathrm{d} \Omega_{K}^{n-2}$ is generated by differentials of the forms
$\xi \operatorname{dlog} y_{1} \cdots \operatorname{dlog} y_{n-1}$, where $\xi \in K$ and $y_{1}, \ldots, y_{n-1} \in k^{\times}$, and $x \mathrm{~d} \log \eta \mathrm{~d} \log y_{2} \cdots \mathrm{~d} \log y_{n-1}$, where $x \in k, \eta \in K^{\times}$and $y_{2}, \ldots, y_{n} \in k^{\times}$.

Proof. Take any $\omega=\alpha \operatorname{dlog} \beta_{1} \cdots \operatorname{dlog} \beta_{n-1}$ in $\Omega_{K}^{n-1}$ for some $\alpha \in K, \beta_{1}, \ldots, \beta_{n-1} \in K^{\times}$ with $\alpha \neq 0$. The differential form $\alpha^{-1} \omega=d \log \beta_{1} \cdots d \log \beta_{n-1}$ is in the image of the differential symbol map (3.6)

$$
\operatorname{dlog}: K_{n-1}^{M}(K) \rightarrow \Omega_{K}^{n-1} ;\left\{\xi_{1}, \ldots, \xi_{n-1}\right\}_{K} \mapsto \operatorname{dlog} \xi_{1} \cdots \operatorname{dlog} \xi_{n-1} .
$$

By Proposition 4.4, the given $\omega$ is a sum of differentials of the form $\alpha \operatorname{dlog} \beta \operatorname{dlog} y_{2} \cdots \operatorname{dlog} y_{n-1}$ for some $\beta \in K^{\times}$and $y_{2}, \ldots, y_{n-1} \in k^{\times}$. Therefore, the assertion is reduced to the case $n=2$. Namely, it is enough to show that any non-trivial differential form $\omega=\alpha \operatorname{dog} \beta \in$ $\Omega_{K}^{1} / \mathrm{d} K$ with $\alpha \in K, \beta \in K^{\times}$is a finite sum of the differentials of the forms

$$
\begin{equation*}
\xi \operatorname{dlog} y \quad\left(\xi \in K, y \in k^{\times}\right) \quad \text { and } \quad x \operatorname{dlog} \eta \quad\left(x \in k^{\times}, \eta \in K^{\times}\right) . \tag{5.5}
\end{equation*}
$$

Write $K=k(\theta)=k[T] /(\pi(T))$ using an irreducible monic polynomial $\pi(T) \in k[T]$ of degree $p$. If $\beta$ is in $k^{\times}$, there is nothing to show. We assume $\beta \notin k^{\times}$. The element $\beta \in K^{\times}$is the image of a polynomial $B(T) \in k[T]$ of degree $<p$ by the evaluation map $k[T] \rightarrow k(\theta)=k[T] /(\pi(T))$. Consider the irreducible decomposition $B(T)=y \prod_{i} B_{i}(T)$ for some $y \in k^{\times}$and irreducible monic polynomials $B_{i}(T) \in k[T]$. From the assumption on $k$, the polynomial $B_{i}(T)$ which has degree $<p$ should be of the form $B_{i}(T)=T-b_{i}$
for some $b_{i} \in k$. Therefore, we have $\beta=y \prod_{i}\left(\theta-b_{i}\right)$. Write $\alpha=\sum_{j=0}^{p-1} a_{j} \theta^{j}$ with $a_{j} \in k$. The differential form $\omega$ is further decomposed as a sum of differentials of the forms

$$
\alpha \operatorname{dlog} y, \quad \text { and } \quad \omega_{j}:=a \theta^{j} \operatorname{dlog}(\theta-b)
$$

with $a, b \in k$. The former differential is of the required form (5.5). For the later $\omega_{j}$, if $j=0$ or $a=0$, the assertion holds. For $0<j<p$ with $a \neq 0$, put $\tau:=\theta-b$. Expanding $\theta^{j}=(\tau+b)^{j}$, the differential form $\omega_{j}$ is a sum of $\omega^{\prime}:=y \tau^{i} \operatorname{dlog} \tau$ for some $y \in k^{\times}$and $0 \leq i<p$. The assertion follows in the case $i=0$. For $i>0$, we have $i \omega^{\prime}=y \tau^{i} \operatorname{dog}\left(\tau^{i}\right)=$ $-y \tau^{i} \operatorname{dlog} y$ modulo $\mathrm{d} K$, because $0=\mathrm{d}\left(y \tau^{i}\right)=y \tau^{i} \operatorname{dlog}\left(y \tau^{i}\right)=y \tau^{i} \operatorname{dlog} y+y \tau^{i} \operatorname{dlog}\left(\tau^{i}\right)$ in $\Omega_{K}^{1} / \mathrm{d} K$. For this reason, any differential $\omega=\alpha \operatorname{dog} \beta$ modulo $d K$ is written by the differentials of the forms given in (5.5).

Theorem 5.7. For any $n \geq 1$, the map $t_{k, p}^{n}: M_{p}^{n}(k) \xrightarrow{\simeq} H_{p}^{n}(k)$ is bijective.
Proof. By Lemma 5.5, it is enough to show that the map $t_{k}=t_{k, p}^{n}: M_{p}^{n}(k) \rightarrow H_{p}^{n}(k)$ is injective or $\varphi_{k}: H_{p}^{n}(k) \rightarrow M_{p}^{n}(k)$ which is given by $\varphi_{k}\left(\left[a, b_{1}, \ldots, b_{n-1}\right)_{k}\right)=\left\{a, b_{1}, \ldots, b_{n-1}\right\}_{k / k}$ is surjective. First, let $k^{(p)} / k$ be the field extension corresponding to the $p$-Sylow subgroup of $\operatorname{Gal}\left(k^{\mathrm{sep}} / k\right)$. The following diagram is commutative:


Recall that $H_{p}^{n}(k)$ is a quotient of $\Omega_{k}^{n-1}$. Since the correspondence $\Omega_{-}^{n-1}: K \mapsto \Omega_{K}^{n-1}$ forms a Mackey functor, the commutativity of the above diagram comes from the definition of the restriction map of the Mackey product $\mathbb{G}_{a}{ }_{\otimes}^{M} \mathbb{G}_{m}^{M(n-1)}$. Furthermore, for any subextension $k \subset K \subset k^{(p)}$ with $[K: k]<\infty$, the extension degree $[K: k]$ is prime to $p$. Therefore, $\operatorname{tr}_{K / k} \circ \operatorname{res}_{K / k}=[K: k]$ implies that $\operatorname{res}_{K / k}: M_{p}^{n}(k) \rightarrow M_{p}^{n}(K)$ is injective. By $M_{p}^{n}\left(k^{(p)}\right) \simeq \lim _{K} M_{p}^{n}(K)$ (for the proof, see [Akh00, Lem. 3.6.4]), the left vertical map $\operatorname{res}_{k^{(p)} / k}$ in the above diagram is injective. To show that $t_{k}$ is injective, take any $\xi \in M_{p}^{n}(k)$ with $t_{k}(\xi)=0$. If we assume that $t_{k^{(p)}}$ is bijective, we have $\operatorname{res}_{k^{(p)} / k}(\xi)=0$ in $M_{p}^{n}(k)$ and hence $\xi=0$. Thus, we may assume $k=k^{(p)}$. In particular, every finite extension of $k$ is of degree $p^{r}$ for some $r \geq 0$.

We show that the map $\varphi_{k}$ is surjective by proving the equality $M_{p}^{n}(k)=\operatorname{Symb}_{p}(k)$. Take any non-zero symbol $\left\{\alpha, \beta_{1}, \ldots, \beta_{n-1}\right\}_{K / k}$ in $M_{p}^{n}(k)$ with $[K: k]=p^{r}$. There exists a tower of fields $k=k_{0} \subset k_{1} \subset k_{2} \subset \cdots \subset k_{r}=K$ such that $\left[k_{i}: k_{i-1}\right]=p$. By induction on $r$, we may assume $[K: k]=p$. By Proposition 5.6, the symbol $\left[\alpha, \beta_{1}, \ldots, \beta_{n-1}\right)_{K}=$ $\alpha \operatorname{dlog} \beta_{1} \cdots \operatorname{dlog} \beta_{n-1}$ is written as a sum of elements of the forms

$$
\begin{aligned}
& {\left[\xi, y_{1}, \ldots, y_{n-1}\right)_{K} \text { for some } \xi \in K, y_{1}, \ldots, y_{n-1} \in k^{\times} \text {, and }} \\
& {\left[x, \eta, y_{2}, \ldots, y_{n-1}\right)_{K} \text { for some } x \in k, y_{2}, \ldots, y_{n-1} \in k^{\times}, \eta \in K^{\times} .}
\end{aligned}
$$

From Lemma 5.5, the symbol $\left\{\alpha, \beta_{1}, \ldots, \beta_{n-1}\right\}_{K / K}$ is a sum of symbols of the forms $\left\{\xi, y_{1}, \ldots, y_{n-1}\right\}_{K / K}$ and $\left\{x, \eta, y_{2}, \ldots, y_{n-1}\right\}_{K / K}$. Hence,

$$
\left\{\alpha, \beta_{1}, \ldots, \beta_{n-1}\right\}_{K / k}=\operatorname{tr}_{K / k}\left(\left\{\alpha, \beta_{1}, \ldots, \beta_{n-1}\right\}_{K / K}\right)
$$

is a sum of symbols of the form $\left\{\xi, y_{1}, \ldots, y_{n-1}\right\}_{K / k}$ and $\left\{x, \eta, y_{2}, \ldots, y_{n-1}\right\}_{K / k}$. By the projection formula (PF), we have

$$
\begin{aligned}
\left\{\xi, y_{1}, \ldots, y_{n-1}\right\}_{K / k} & =\left\{\operatorname{Tr}_{K / k}(\xi), y_{1}, \ldots, y_{n-1}\right\}_{k / k} \\
\left\{x, \eta, y_{2}, \ldots, y_{n-1}\right\}_{K / k} & =\left\{x, N_{K / k}(\eta), y_{2}, \ldots, y_{n-1}\right\}_{k / k} .
\end{aligned}
$$

Because of this, $\left\{\alpha, \beta_{1}, \ldots, \beta_{n-1}\right\}_{K / k}$ is in $\operatorname{Symb}_{p}(k)$ and the map $\varphi_{k}$ is surjective.
Theorem 5.8. Let $k$ be an arbitrary field of characteristic $p>0$. For $r \geq 1$ and $n \geq 1$, the map $t_{k, p^{r}}^{n}: M_{p^{r}}^{n}(k) \xrightarrow{\simeq} H_{p^{r}}^{n}(k)$ is bijective.

Proof. We show the assertion by induction on $r$. The case $r=1$ follows from Theorem 5.7. For $r \geq 1$, we assume that $t_{k, p^{r}}^{n}$ is bijective. The short exact sequence $0 \rightarrow W_{r} \rightarrow W_{r+1} \rightarrow$ $\mathbb{G}_{a} \rightarrow 0$ induces a commutative diagram with exact rows:


The diagram above induces the following commutative diagram:

$$
\begin{align*}
& M_{p^{r}}^{n}(k) \longrightarrow M_{p^{r+1}}^{n}(k) \longrightarrow M_{p}^{n}(k) \\
& \simeq \downarrow_{p^{n}} \quad \downarrow^{t_{p^{r+1}}^{n}} \quad \simeq \downarrow_{p}^{t_{p}^{n}}  \tag{5.6}\\
& H^{n-1}(k, \mathbb{Z} / p(n-1)) \xrightarrow{\delta} H_{p^{r}}^{n}(k) \longrightarrow H_{p^{r+1}}^{n}(k) \longrightarrow H_{p}^{n}(k) \text {. }
\end{align*}
$$

Here, the bottom sequence is a part of the long exact sequence induced from the short exact sequence

$$
0 \rightarrow W_{r} \Omega_{k \text { sep }, \log }^{n-1} \rightarrow W_{r+1} \Omega_{k^{\text {sep }, \log }}^{n-1} \rightarrow \Omega_{k \operatorname{sep}, \log }^{n-1} \rightarrow 0
$$

([11179, Chap. I, Thm. 5.7.2], [Shi07, Prop. 2.12]). By the inductive hypothesis, the vertical maps $t_{k, p^{r}}^{n}$ and $t_{k, p}^{n}$ are bijective. The lower horizontal sequence in the above diagram (5.6) continues further to the left as

$$
\begin{aligned}
& K_{n-1}^{M}(k) / p^{r+1} \xrightarrow[\bmod p]{\longrightarrow} K_{n-1}^{M}(k) / p \\
&\left.\simeq\right|_{k, p^{r+1}} ^{n-1}\left.\simeq\right|_{k, p} ^{s_{k-1}^{n-1}} \\
& H^{n-1}\left(k, \mathbb{Z} / p^{r+1}(n-1)\right) \longrightarrow H^{n-1}(k, \mathbb{Z} / p(n-1)) \xrightarrow{\delta} H_{p^{r}}^{n}(k) .
\end{aligned}
$$

By Theorem 1.2, the vertical maps in the above diagram are bijective and hence $\delta$ is the 0 map. Thus, $t_{k, p^{r+1}}^{n}$ is injective by the diagram chase in (5.6).

For a truncation set $S$, we have a homomorphism $\wp=\mathbb{W}_{S}(\phi)-\mathrm{id}: \mathbb{W}_{S}(K) \rightarrow \mathbb{W}_{S}(K)$ and this induces a map $\wp: \mathbb{W}_{S} \stackrel{M}{\otimes} \mathbb{G}_{m}^{M(n-1)} \rightarrow \mathbb{W}_{S} \stackrel{M}{\otimes} \mathbb{G}_{m}^{M(n-1)}$ of Mackey functors as in (5.1). We denote by $M_{S}^{n}:=\left(\mathbb{W}_{S} \stackrel{M}{\otimes} \mathbb{G}_{m}^{M(n-1)}\right) / \wp$ the cokernel of $\wp$. When $S$ is finite, we have $\mathbb{W}_{S}(K) \simeq \prod_{(m, p)=1} W_{r_{m}}(K)$ for any field extension $K / k$ as in (3.4). This gives
the decomposition $\mathbb{W}_{S}=\bigoplus_{(m, p)=1} W_{r_{m}}$ as Mackey functors. Since the Mackey product commutes with the direct sum, we have

$$
M_{S}^{n}(k) \simeq \prod_{(m, p)=1} M_{p^{r_{m}}}^{n}(k)
$$

According to (5.2), we define

$$
H_{S}^{n}(k):=\operatorname{Coker}\left(\mathbb{W}_{S} \Omega_{k}^{n-1} \stackrel{(3.4)}{\sim} \prod_{(m, p)=1} W_{r_{m}} \Omega_{k}^{n} \xrightarrow{\prod_{\wp}} \prod_{(m, p)=1} W_{r_{m}} \Omega_{k}^{n-1} / \mathrm{d} V^{r_{m}-1} \Omega_{k}^{n-2}\right)
$$

Theorem 5.8 extends to any finite truncation set as follows:
Corollary 5.9. Let $k$ be a field of characteristic $p>0$. For any finite truncation set $S$ and $n \geq 1$, we have an isomorphism $M_{S}^{n}(k) \simeq H_{S}^{n}(k)$.
Corollary 5.10. Let $k$ be a field of characteristic $p>0$. For a truncation set $S$ and $n \geq 1$, we have an isomorphism

$$
M_{S}^{n}(k) \simeq \lim _{S_{0} \subset S} H_{S_{0}}^{n}(k)
$$

where $S_{0}$ runs the set of all finite truncation set contained in $S$.
Proof. By the definition, we have $\mathbb{W}_{S}(K)=\lim _{S_{0}} \mathbb{W}_{S_{0}}(K)$. Since the restriction map $R_{S_{0}^{\prime}}^{S_{0}}: \mathbb{W}_{S_{0}}(K) \rightarrow \mathbb{W}_{S_{0}^{\prime}}(K)$ is surjective, for any finite truncation sets $S_{0}^{\prime} \subset S_{0}$, the MittagLeffler condition holds. We obtain $\left(\mathbb{W}_{S} \stackrel{M}{\otimes} \mathbb{G}_{m}^{M(n-1)}\right)(k) / \wp \simeq \lim _{S_{0}}\left(\mathbb{W}_{S_{0}} \stackrel{M}{\otimes} \mathbb{G}_{m}^{M(n-1)}\right)(k) / \wp$. The assertion follows from Corollary 5.9.

Corollary 5.11. Let $k$ be a field of characteristic $p>0$. For any finite truncation set $S$ and $n \geq 1$, we have an isomorphism

$$
\left(\mathbb{W}_{S} \stackrel{M}{\otimes} K_{n-1}^{M}\right)(k) / \wp \simeq H_{S}^{n}(k),
$$

where $\wp:\left(\mathbb{W}_{S} \stackrel{M}{\otimes} K_{n-1}^{M}\right)(k) \rightarrow\left(\mathbb{W}_{S} \stackrel{M}{\otimes} K_{n-1}^{M}\right)(k)$ is given by $\wp\left(\{\mathbf{a}, \mathbf{b}\}_{K / k}\right)=\{\wp(\mathbf{a}), \mathbf{b}\}_{K / k}$. Proof. By the decomposition $\mathbb{W}_{S}=\bigoplus_{(m, p)=1} W_{r_{m}}$ as Mackey functors, we have

$$
\begin{aligned}
\left(\mathbb{W}_{S}{ }^{M} \otimes K_{n-1}^{M}\right)(k) / \wp & \simeq \bigoplus_{(p, m)=1}\left(W_{r_{m}}{ }_{\otimes}^{M} K_{n-1}^{M}\right)(k) / \wp \\
& \simeq \bigoplus_{(m, p)=1}\left(W_{r_{m}} / \wp \stackrel{M}{\otimes} K_{n-1}^{M} / p^{r_{m}}\right)(k) \quad(\text { by Lemma 5.1) } \\
& \left.\simeq \bigoplus_{(m, p)=1}\left(W_{r_{m}} / \wp \stackrel{M}{\otimes} \mathbb{G}_{m}^{M} \otimes(n-1) / p^{r_{m}}\right)(k) \quad \text { (by Theorem } 5.8\right) \\
& \simeq \bigoplus_{(m, p)=1}\left(W_{r_{m}} \stackrel{M}{\otimes} \mathbb{G}_{m}^{M \otimes(n-1)}\right)(k) / \wp \quad \quad \text { (by Lemma 5.1) } \\
& =M_{S}^{n}(k) .
\end{aligned}
$$

Corollary 5.9 gives the assertion.
