## AN ADDITIVE VARIANT OF THE DIFFERENTIAL SYMBOL MAPS

#### TOSHIRO HIRANOUCHI

ABSTRACT. Our investigation focuses on an additive analogue of the Bloch-Gabber-Kato theorem which establishes a relation between the Milnor K-group of a field of positive characteristic and a Galois cohomology group of the field. Extending the Aritin-Schreier-Witt theory, we present an isomorphism from the Mackey product associated with the Witt group and the multiplicative groups to a Galois cohomology group. As a result, we give a new expression for the torsion subgroup of the Brauer group of a field, and more generally, the Kato homology groups.

# 1. Introduction

For an arbitrary field k and any positive integer m prime to the characteristic of k, the **norm residue isomorphism theorem** ([Voe11], see also [Wei09]) is relating the Milnor K-group  $K_n^M(k)$  of the field k and the Galois cohomology group  $H^n(k, \mathbb{Z}/m\mathbb{Z}(n)) = H_{\text{et}}^n(\operatorname{Spec}(k), \mu_m^{\otimes n})$ . Precisely, for any  $n \geq 0$ , the **Galois symbol map** 

(1.1) 
$$K_n^M(k)/mK_n^M(k) \xrightarrow{\simeq} H^n(k, \mathbb{Z}/m\mathbb{Z}(n))$$

is bijective. The Milnor K-group  $K_n^M(k)$  can be replaced by the **Somekawa** K-group associated to the multiplicative groups  $\mathbb{G}_m$  by using the canonical isomorphism

(1.2) 
$$K(k; \widehat{\mathbb{G}_m, \dots, \mathbb{G}_m}) \simeq K_n^M(k)$$

([Som90, Thm. 1.4]). The aim of this note is to study the "additive analogue" of the norm residue isomorphism theorem by replacing the first  $\mathbb{G}_m$  in the Somekawa K-group  $K(k; \mathbb{G}_m, \ldots, \mathbb{G}_m)$  with the additive group  $\mathbb{G}_a$  or the Witt group  $W_r$  more generally. For the case n = 1, the Galois symbol map is the Kummer theory

$$k^{\times}/(k^{\times})^m \xrightarrow{\simeq} H^1(k, \mathbb{Z}/m\mathbb{Z}(1)).$$

The additive analogue should be the Artin-Schreier-Witt theory

$$(1.3) W_r(k)/\wp(W_r(k)) \xrightarrow{\simeq} H^1(k, \mathbb{Z}/p^r\mathbb{Z})$$

for a field k of characteristic p > 0, where  $\wp((x_0, \ldots, x_{r-1})) = (x_0^p, \ldots, x_{r-1}^p) - (x_0, \ldots, x_{r-1})$ . Unfortunately, it has not been given that the Somekawa type K-group associated to  $W_r$  and  $\mathbb{G}_m$ 's over an arbitrary field k (cf. [Hir14], [IR17], [RSY22]). However, after tensoring with  $\mathbb{Z}/m\mathbb{Z}$ , for the expression of the Milnor K-group in (1.2) there is no need to use the Somekawa K-group. To explain this fact, we recall that the Somekawa K-group is defined to be the quotient of  $\bigoplus_{K/k: \text{finite}} (K^{\times})^{\otimes_{\mathbb{Z}} n}$  by two kind of relations, resembling the projection formula and the Weil reciprocity law of the Milnor K-groups:

$$K(k; \underbrace{\mathbb{G}_m, \dots, \mathbb{G}_m}^n) := \left( \bigoplus_{K/k: \text{finite}} (K^{\times})^{\otimes_{\mathbb{Z}} n} \right) / \text{ (projection formula)}$$
 & (Weil reciprocity).

The Mackey product  $\mathbb{G}_m^{\stackrel{M}{\otimes}n}(k) = (\mathbb{G}_m \stackrel{M}{\otimes} \cdots \stackrel{M}{\otimes} \mathbb{G}_m)(k)$  of  $\mathbb{G}_m$ 's defined upon the same generators as the Somekawa K-group with the relation concerning the projection formula only:

(1.4) 
$$\mathbb{G}_m^{\otimes n}(k) := \left( \bigoplus_{K/k: \text{finite}} (K^{\times})^{\otimes_{\mathbb{Z}} n} \right) / \text{(projection formula)}.$$

(for the precise definition, see Definition 2.3). By the very definition, the Somekawa K-group is a quotient of the Mackey product  $\mathbb{G}_m^{\otimes n}(k) \to K(k; \mathbb{G}_m, \dots, \mathbb{G}_m)$ . This quotient map becomes bijective

$$\mathbb{G}_m^{\stackrel{M}{\otimes} n}(k)/m \xrightarrow{\simeq} K(k; \overbrace{\mathbb{G}_m, \dots, \mathbb{G}_m}^n)/m$$

after considering modulo m (Kahn's theorem, cf. Theorem 4.5). It is important to note here that the Mackey product  $(W_r \otimes \mathbb{G}_m^{\stackrel{M}{\otimes} (n-1)})(k)$  is defined for an arbitrary field k in the same way as in (1.4). Using this, we present an isomorphism below which extends the Artin-Schreier-Witt theory (1.3).

**Theorem 1.1** (Theorem 5.8). Let k be an arbitrary field of characteristic p > 0. For  $r \ge 1$  and  $n \ge 1$ , there is an isomorphism

$$(W_r \overset{M}{\otimes} \mathbb{G}_m^{\overset{M}{\otimes} (n-1)})(k)/\wp \xrightarrow{\simeq} H^n(k, \mathbb{Z}/p^r\mathbb{Z}(n-1)) = H^1_{\text{\rm et}}(\operatorname{Spec}(k), W_r\Omega_{\log}^{n-1}),$$

where  $(W_r \overset{M}{\otimes} \mathbb{G}_m^{\overset{M}{\otimes} (n-1)})(k)/\wp$  is the cokernel of a map  $\wp : (W_r \overset{M}{\otimes} \mathbb{G}_m^{\overset{M}{\otimes} (n-1)})(k) \to (W_r \overset{M}{\otimes} \mathbb{G}_m^{\overset{M}{\otimes} (n-1)})(k)$  defined by  $\wp : W_r(K) \to W_r(K)$  on the Witt groups used in (1.3).

The above theorem should be compared to the Bloch-Gabber-Kato theorem which is a p-analogue of the norm residue isomorphism theorem.

**Theorem 1.2** (Bloch-Gabber-Kato, [BK86, Cor. 2.8]). Let k be an arbitrary field of characteristic p > 0. For any  $r \ge 1$  and  $n \ge 0$ , the **differential symbol map** (cf. (3.6))

$$K_n^M(k)/p^r K_n^M(k) \xrightarrow{\simeq} H^n(k, \mathbb{Z}/p^r \mathbb{Z}(n)) = W_r \Omega_{k,\log}^n$$

is an isomorphism.

Put  $H^n_{p^r}(k) := H^n(k, \mathbb{Z}/p^r\mathbb{Z}(n-1))$ . In the case n=2, we have an isomorphism  $H^2_{p^r}(k) \simeq \operatorname{Br}(k)[p^r]$ , where  $\operatorname{Br}(k)[p^r]$  is the  $p^r$ -torsion part of the Brauer group  $\operatorname{Br}(k)$ . Our theorem (Theorem 1.1) above gives an expression for the Brauer group  $\operatorname{Br}(k)[p^r]$ . More generally, for an excellent scheme X over a field k of characteristic p>0 with  $[k:k^p] \leq p^n$  for some n, there is a homological complex  $KC^n_{\bullet}(X,\mathbb{Z}/p^r\mathbb{Z})$  of Bloch-Ogus type:

$$\cdots \to \bigoplus_{x \in X_j} H_{p^r}^{n+j+1}(k(x)) \to \cdots \to \bigoplus_{x \in X_1} H_{p^r}^{n+2}(k(x)) \to \bigoplus_{x \in X_0} H_{p^r}^{n+1}(k(x)),$$

where  $X_j$  is the set of points x in X with  $\dim(\overline{\{x\}}) = j$  and k(x) is the residue field at x ([Kat86]). Here, the term  $\bigoplus_{x \in X_j} H_{p^r}^{n+j+1}(k(x))$  is placed in degree j. The **Kato homology group** of X (with coefficients in  $\mathbb{Z}/p^r\mathbb{Z}$ ) is defined to be the homology group  $KH_j(X, \mathbb{Z}/p^r\mathbb{Z}) := H_j(KC^n_{\bullet}(X, \mathbb{Z}/p^r\mathbb{Z}))$ . Theorem 1.1 gives an alternative expression of  $KC^n_{\bullet}(X, \mathbb{Z}/p^r\mathbb{Z})$  (for recent progress on the Kato homology groups, see [Sai10]).

**Notation.** Throughout this note, for an abelian group G and  $m \in \mathbb{Z}_{\geq 1}$ , we write G[m] and G/m for the kernel and cokernel of the multiplication by m on G respectively.

### 2. Mackey functors

In this section, we recall the notion of Mackey functors, and their product following [Kah92, Sect. 5] (see also [IR17, Rem. 1.3.3], [RS00, Sect. 3]). Throughout this section, let k be a field, and  $\operatorname{Ext}_k$  the category of field extensions of k.

**Definition 2.1.** A Mackey functor  $\mathscr{M}$  over a field k (a cohomological finite Mackey functor over k in the sense of [Kah92]) is a covariant functor  $\mathscr{M} : \operatorname{Ext}_k \to \operatorname{Ab}$  from  $\operatorname{Ext}_k$  to the category of abelian groups Ab equipped with a contravariant structure for finite extensions L/K in  $\operatorname{Ext}_k$  satisfying the following conditions: For any finite field extension L/K in  $\operatorname{Ext}_k$  and a field extension K'/K in  $\operatorname{Ext}_k$ , the following diagram is commutative:

$$\mathcal{M}(L) \xrightarrow{\bigoplus e_i \operatorname{res}_{L'_i/L}} \bigoplus_{i=1}^n \mathcal{M}(L'_i) 
\operatorname{tr}_{L/K} \downarrow \qquad \qquad \downarrow^{\sum \operatorname{tr}_{L'_i/K'}} 
\mathcal{M}(K) \xrightarrow{\operatorname{res}_{K'/K}} \mathcal{M}(K'),$$

where  $L \otimes_K K' = \bigoplus_{i=1}^n A_i$  for some local Artinian algebras  $A_i$  of dimension  $e_i$  over the residue field  $L'_i := A_i/\mathfrak{m}_{A_i}$ . Here, for an extension L/K in  $\operatorname{Ext}_k$ , the map  $\operatorname{res}_{L/K} : \mathscr{M}(K) \to \mathscr{M}(L)$  is defined by the covariant structure of  $\mathscr{M}$  and the contravariant structure gives  $\operatorname{tr}_{L/K} : \mathscr{M}(K) \to \mathscr{M}(L)$  if  $[L : K] < \infty$ .

The category of Mackey functors forms a Grothendieck abelian category (cf. [KY13, Appendix A]) and hence any morphism of Mackey functor  $f: \mathcal{M} \to \mathcal{N}$ , that is, a natural transformation, gives the image Im(f), the cokernel Coker(f) and so on.

**Example 2.2.** (i) For any endomorphism  $f: \mathcal{M} \to \mathcal{M}$  of a Mackey functor  $\mathcal{M}$ , we denote the cokernel by  $\mathcal{M}/f := \operatorname{Coker}(f)$ . This Mackey functor is given by

$$(\mathcal{M}/f)(K) = \operatorname{Coker}(f(K): \mathcal{M}(K) \to \mathcal{M}(K)).$$

- (ii) A commutative algebraic group G over k induces a Mackey functor by defining  $K/k \mapsto G(K)$  for any field extension K/k (cf. [Som90, (1.3)], [IR17, Prop. 2.2.2]). In particular, the multiplicative group  $\mathbb{G}_m$  is a Mackey functor given by  $\mathbb{G}_m(K) = K^{\times}$  for any field extension K/k. The translation maps are the norm  $N_{L/K} \colon L^{\times} \to K^{\times}$  and the inclusion  $K^{\times} \to L^{\times}$ . For the additive group  $\mathbb{G}_a$ , the translation maps are the trace map  $\mathrm{Tr}_{L/K} \colon L \to K$  and the inclusion  $K \hookrightarrow L$ .
- (iii) Recall that, for  $n \geq 1$ , the Milnor K-group  $K_n^M(k)$  of a field k is the quotient group of  $(k^{\times})^{\otimes_{\mathbb{Z}^n}}$  by the subgroup generated by all elements of the form  $a_1 \otimes \cdots \otimes a_n$  with  $a_i + a_j = 1$  for some  $i \neq j$ . We also put  $K_0^M(k) = \mathbb{Z}$ . The class of  $a_1 \otimes \cdots \otimes a_n$  in  $K_n^M(k)$  is denoted by  $\{a_1, \ldots, a_n\}_k$ . For an extension L/K in  $\operatorname{Ext}_k$ , the restriction map  $\operatorname{res}_{L/K}: K_n^M(K) \to K_n^M(L)$  and the norm map  $N_{L/K}: K_n^M(L) \to K_n^M(K)$  when  $[L:K] < \infty$  gives the structure of the Mackey functor  $K_n^M$ .

**Definition 2.3.** For Mackey functors  $\mathcal{M}_1, \ldots, \mathcal{M}_n$  over k, the **Mackey product**  $\mathcal{M}_1 \overset{M}{\otimes} \cdots \overset{M}{\otimes} \mathcal{M}_n$  is defined as follows: For any field extension k'/k,

$$(\mathscr{M}_1 \overset{M}{\otimes} \cdots \overset{M}{\otimes} \mathscr{M}_n)(k') := \left( \bigoplus_{K/k': \text{ finite}} \mathscr{M}_1(K) \otimes_{\mathbb{Z}} \cdots \otimes_{\mathbb{Z}} \mathscr{M}_n(K) \right) / (\mathbf{PF}),$$

where (PF) stands for the subgroup generated by elements of the following form:

(**PF**) For a finite field extension L/K in  $\operatorname{Ext}_{k'}$ ,

$$x_1 \otimes \cdots \otimes \operatorname{tr}_{L/K}(\xi_{i_0}) \otimes \cdots \otimes x_n - \operatorname{res}_{L/K}(x_1) \otimes \cdots \otimes \xi_{i_0} \otimes \cdots \otimes \operatorname{res}_{L/K}(x_n)$$
  
for  $\xi_{i_0} \in \mathscr{M}_{i_0}(L)$  and  $x_i \in \mathscr{M}_i(K)$  for  $i \neq i_0$ .

For the Mackey product  $\mathscr{M}_1 \overset{M}{\otimes} \cdots \overset{M}{\otimes} \mathscr{M}_n$ , we write  $\{x_1, \ldots, x_n\}_{K/k'}$  for the image of  $x_1 \otimes \cdots \otimes x_n \in \mathscr{M}_1(K) \otimes_{\mathbb{Z}} \cdots \otimes_{\mathbb{Z}} \mathscr{M}_n(K)$  in the product  $(\mathscr{M}_1 \overset{M}{\otimes} \cdots \overset{M}{\otimes} \mathscr{M}_n)(k')$ . The translation maps  $\operatorname{tr}_{K'/K} : (\mathscr{M}_1 \overset{M}{\otimes} \cdots \overset{M}{\otimes} \mathscr{M}_n)(K) \to (\mathscr{M}_1 \overset{M}{\otimes} \cdots \overset{M}{\otimes} \mathscr{M}_n)(K')$  and  $\operatorname{res}_{K'/K} : (\mathscr{M}_1 \overset{M}{\otimes} \cdots \overset{M}{\otimes} \mathscr{M}_n)(K') \to (\mathscr{M}_1 \overset{M}{\otimes} \cdots \overset{M}{\otimes} \mathscr{M}_n)(K')$  are defined as follows (cf. [IR17, Lem. 4.1.2], [Akh00, Sect. 3.4]):

$$\operatorname{tr}_{K'/K}(\{x_1, \dots, x_n\}_{L'/K'}) = \{x_1, \dots, x_n\}_{L'/K}, \text{ and}$$

$$\operatorname{res}_{K'/K}(\{x_1, \dots, x_n\}_{L/K}) = \sum_{i=1}^n e_i \{\operatorname{res}_{L'_i/L}(x_1), \dots, \operatorname{res}_{L'_i/L}(x_n)\}_{L'_i/K'},$$

where  $L \otimes_K K' = \bigoplus_{i=1}^n A_i$  for some local Artinian algebras  $A_i$  of dimension  $e_i$  over the residue field  $L'_i := A_i/\mathfrak{m}_{A_i}$ .

**Remark 2.4.** The Mackey product  $\mathcal{M}_1 \overset{M}{\otimes} \cdots \overset{M}{\otimes} \mathcal{M}_n$  is a Mackey functor with translation maps defined above ([IR17, Lem. 4.1.2]). For Mackey functors  $\mathcal{M}_1, \mathcal{M}_2, \mathcal{M}_3$  over  $k, \mathcal{M}_1 \overset{M}{\otimes} (\mathcal{M}_2 \oplus \mathcal{M}_3) \simeq (\mathcal{M}_1 \overset{M}{\otimes} \mathcal{M}_2) \oplus (\mathcal{M}_1 \overset{M}{\otimes} \mathcal{M}_3)$  by the same proof of [Akh00, Prop. 3.5.6] (Note that the Somekawa K-group used in [Akh00] is a quotient of the Mackey product). Moreover, we have

$$\mathcal{M}_1 \overset{M}{\otimes} \mathcal{M}_2 \overset{M}{\otimes} \mathcal{M}_3 \simeq (\mathcal{M}_1 \overset{M}{\otimes} \mathcal{M}_2) \overset{M}{\otimes} \mathcal{M}_3 \simeq \mathcal{M}_1 \overset{M}{\otimes} (\mathcal{M}_2 \overset{M}{\otimes} \mathcal{M}_3).$$

### 3. DE RHAM-WITT COMPLEX

In this section, we recall the notion of the de Rham-Witt complex and its properties following [Rül07]. Let k be a field of characteristic  $p \geq 0$ . A **truncation set**  $S \subset \mathbb{N} := \mathbb{Z}_{>0}$  is a nonempty subset such that if  $s \in S$  and  $t \mid s$  then  $t \in S$ . For each truncation set S, let  $\mathbb{W}_S(k)$  be the ring of Witt vectors (cf. [Rül07, Appendix]). The trace map  $\mathrm{Tr}_{L/K} : \mathbb{W}_S(L) \to \mathbb{W}_S(K)$  and the restriction  $\mathrm{res}_{L/K} : \mathbb{W}_S(K) \to \mathbb{W}_S(L)$  make the structure of the Mackey functor on  $\mathbb{W}_S$  ([Rül07, Prop. A.9]). For a finite truncation set S, the de Rham-Witt complex  $\mathbb{W}_S\Omega_k^{\bullet}$  is a quotient of the differential graded algebra  $\Omega_{\mathbb{W}_S(k)/\mathbb{Z}}^{\bullet}$  satisfying

$$\mathbb{W}_{\{\,1\,\}}\Omega_k^\bullet \simeq \Omega_{k/\mathbb{Z}}^\bullet, \quad \text{and} \quad \mathbb{W}_S\Omega_k^0 \simeq \mathbb{W}_S(k),$$

and has some natural maps

$$V_n: \mathbb{W}_{S/n}\Omega_k^{\bullet} \to \mathbb{W}_S\Omega_k^{\bullet}, \text{ and } F_n: \mathbb{W}_S\Omega_k^{\bullet} \to \mathbb{W}_{S/n}\Omega_k^{\bullet},$$

where  $S/n := \{ s \in \mathbb{N} \mid ns \in S \}$  (cf. [Rül07, Prop. 1.2]). For a truncation set  $T \subset S$ , the restriction map  $\mathbb{W}_S(k) \to \mathbb{W}_T(k)$ ;  $\mathbf{a} = (a_s)_{s \in S} \mapsto \mathbf{a}|_T := (a_s)_{s \in T}$  induces a map of differential graded algebras

$$(3.1) R_T^S \colon \mathbb{W}_S \Omega_k^{\bullet} \to \mathbb{W}_T \Omega_k^{\bullet}$$

For an arbitrary truncation set S, the restriction (3.1) gives the inverse system  $(\mathbb{W}_{S_0}\Omega_k^{\bullet})_{S_0\subset S}$ , where  $S_0$  runs through the set of all finite truncation set contained in S. We define

$$\mathbb{W}_S\Omega_k^{\bullet} := \varprojlim_{S_0 \subset S} \mathbb{W}_{S_0}\Omega_k^{\bullet}.$$

For any extension L/K in the category  $\operatorname{Ext}_k$ , the natural homomorphism  $W_S(K) \to W_S(L)$  of rings (cf. [Rül07, A.1]) induces  $\Omega^{\bullet}_{W_S(K)} \to \Omega^{\bullet}_{W_S(L)}$  and hence the restriction map

$$\operatorname{res}_{L/K} \colon \mathbb{W}_S \Omega_K^{\bullet} \to \mathbb{W}_S \Omega_L^{\bullet}.$$

Define  $pS := S \cup \{ ps \mid s \in S \}$ . There is a map of differential graded algebras

$$p: \mathbb{W}_S \Omega_K^{\bullet} \to \mathbb{W}_{pS} \Omega_L^{\bullet}; \omega \mapsto p\widetilde{\omega},$$

where  $\widetilde{\omega}$  is a lift of  $\omega$  to  $\mathbb{W}_{pS}\Omega_L^{\bullet}$  with respect to the map  $R_S^{pS}$  (3.1) ([Rül07, Def. 2.5]). For a finite truncation set S, the correspondence  $K/k \mapsto \mathbb{W}_S\Omega_K^n$  forms a Mackey functor using the trace map below ([Rül07, Prop. 2.7]).

**Theorem 3.1** ([Rül07, Thm. 2.6], [KP21, Thm. A.2]). Let L/K be a finite field extension in  $\operatorname{Ext}_k$  and S a finite truncation set. Then, there is a map of differential graded  $W_S\Omega_K^{\bullet}$ -modules

$$\operatorname{Tr}_{L/K} \colon \mathbb{W}_S \Omega_L^{\bullet} \to \mathbb{W}_S \Omega_K^{\bullet}$$

satisfying the following properties:

(a) If the extension L/K is separable, then the isomorphism  $\mathbb{W}_S(L) \otimes_{\mathbb{W}_S(K)} \mathbb{W}_S \Omega_K^n \xrightarrow{\simeq} \mathbb{W}_S \Omega_L^n$ ;  $\alpha \otimes \omega \mapsto \alpha \omega$  gives the map  $\mathrm{Tr}_{L/K}$  by

$$\mathbb{W}_{S}\Omega_{L}^{n} \stackrel{\cong}{\leftarrow} \mathbb{W}_{S}(L) \otimes \mathbb{W}_{S}\Omega_{K}^{n} \xrightarrow{\operatorname{Tr}_{L/K} \otimes \operatorname{id}} \mathbb{W}_{S}(K) \otimes_{\mathbb{W}_{S}(K)} \mathbb{W}_{S}\Omega_{K}^{n} \simeq \mathbb{W}_{S}\Omega_{K}^{n}$$

- (b) If L/K is purely inseparable of degree p and  $\omega \in \mathbb{W}_S\Omega_L^n$ , then  $\operatorname{Tr}_{L/K}(\omega) = R_S^{pS}(\eta)$ , where  $\operatorname{res}_{L/K}(\eta) = p(\omega)$  for some  $\eta \in \mathbb{W}_{pS}\Omega_K^n$ .
- (c) If  $K \subset M \subset L$  are finite field extensions, then we have  $\operatorname{Tr}_{L/K} = \operatorname{Tr}_{M/K} \circ \operatorname{Tr}_{L/M}$ .
- (d) The map  $\operatorname{Tr}_{L/K}$  commutes with  $V_n, F_n$  and the restriction  $R_T^S$ .

In the case where k has positive characteristic p > 0, taking the truncation set  $P_r := \{1, p, p^2, \dots, p^{r-1}\}$  for  $r \geq 1$ , we define  $W_r\Omega_k^{\bullet} := \mathbb{W}_{P_r}\Omega_k^{\bullet}$ . This is the classical p-typical de Rham-Witt complex of k ([III79]). In particular,  $W_r\Omega_k^0 = W_r(k)$  is the ring of p-typical Witt vectors of length r in k. It is customary to write

$$V := V_p \colon W_r \Omega_k^{\bullet} \to W_{r+1} \Omega_k^{\bullet},$$

$$F := F_p \colon W_{r+1} \Omega_k^{\bullet} \to W_r \Omega_k^{\bullet}, \quad \text{and}$$

$$R := R_{P_r}^{P_{r+1}} \colon W_{r+1} \Omega_k^{\bullet} \to W_r \Omega_k^{\bullet}.$$

Furthermore, the map  $F \colon W_{r+1}\Omega_k^{\bullet} \to W_r\Omega_k^{\bullet}$  induces

(3.3) 
$$F: W_r \Omega_k^n \to W_r \Omega_k^n / dV^{r-1} \Omega_k^{n-1}$$

([Ill79, Prop. 3.3], [Shi07, Lem. 2.7]). By [Rül07, Thm. 1.11], for a finite truncation set S, there is a canonical decomposition (with respect to S)

$$(3.4) W_S \Omega_k^n \simeq \prod_{(m,p)=1} W_{r_m} \Omega_k^n,$$

where  $r_m := \#(S/m \cap \{1, p, p^2, \dots\}) + 1$ . There is a natural homomorphism

$$\operatorname{dlog}: k^{\times} \to W_r\Omega_k^1; b \mapsto \operatorname{dlog}[b] := \operatorname{d}[b]/[b],$$

where  $[b] := (b, 0, \dots, 0) \in W_r \Omega_k^1$ .

**Lemma 3.2.** For any  $r \ge 1$ , and for any finite field extension L/K in  $\operatorname{Ext}_k$ , the following diagram is commutative:

$$L^{\times} \xrightarrow{\operatorname{dlog}} W_r \Omega_L^1$$

$$N_{L/K} \downarrow \qquad \qquad \downarrow \operatorname{Tr}_{L/K}$$

$$K^{\times} \xrightarrow{\operatorname{dlog}} W_r \Omega_K^1.$$

*Proof.* For any  $\beta \in L^{\times}$ , we show the equality

(3.5) 
$$\operatorname{Tr}_{L/K}(\operatorname{dlog}[\beta]) = \operatorname{dlog}[N_{L/K}\beta].$$

By taking the separable closure of L/K, the extension L/K is written as a finite separable extension followed by a purely inseparable extension. Since every finite purely inseparable extension is decomposed as a sequence of extensions of prime degree p, it suffices to show the assertion in the cases where the extension L/K is either separable or purely inseparable of degree p. In the former case, the equality (3.5) follows from the construction of the trace map ([Rül07, Proof of Thm. 2.6]). Next, we assume that the extension L/K is purely inseparable of degree p. Denoting the Teichmüller map as  $[-]_{r,K}: K^{\times} \to W_r\Omega_K^1$  in this proof, we obtain

$$\underline{p}(\operatorname{dlog}([\beta]_{r,L})) = p \operatorname{dlog}([\beta]_{r+1,L}) 
= \operatorname{dlog}([\beta^p]_{r+1,L}) 
= \operatorname{res}_{L/K}(\operatorname{dlog}([N_{L/K}\beta]_{r+1,K})) \quad (\text{by } N_{L/K}(\beta) = \beta^p).$$

By Theorem 3.1 (b), we have

$$\operatorname{Tr}_{L/K}(\operatorname{dlog}([\beta]_{r,L})) = R(\operatorname{dlog}([N_{L/K}\beta]_{r+1,K})) = \operatorname{dlog}([N_{L/K}\beta]_{r,K}),$$
 where  $R = R_{P_-}^{P_{r+1}}$  (cf. (3.2)).

The subgroup of  $W_r\Omega_k^n$  generated by  $\operatorname{dlog}[b_1]\cdots\operatorname{dlog}[b_n]$  for  $b_1,\ldots,b_n\in k^\times$  is denoted by  $W_r\Omega_{k,\log}^n$ . We put

$$H^n(k, \mathbb{Z}/p^r(m)) = H^{n-m}(k, W_r\Omega^m_{k^{\text{sep}}, \log}).$$

For any  $r \in \mathbb{Z}_{>0}$  and  $n \in \mathbb{Z}_{>0}$ , the differential symbol map

(3.6) 
$$s_{k,p^r}^n: K_n^M(k)/p^r \xrightarrow{\simeq} H^n(k, \mathbb{Z}/p^r(n)) = W_r \Omega_{k,\log}^n$$

introduced in Theorem 1.2 is given by  $\{a_1, \ldots, a_n\}_k \mapsto d\log[a_1] \cdots d\log[a_n]$ .

# 4. Mackey products and the Milnor K-groups

Let k be a field of characteristic  $p \ge 0$ . As referred in Introduction, B. Kahn gives an isomorphism  $\mathbb{G}_m^{\otimes n}(k)/m \simeq K_n^M(k)/m$  between the Mackey product of  $\mathbb{G}_m$ 's (Definition 2.3) and the Milnor K-group modulo m (Example 2.2 (iii)) which is announced in [RS00, Rem. 4.2.5 (b)] without proof. In this section, we give a proof of this theorem (Theorem 4.5).

**Proposition 4.1.** For any  $n \geq 0$ , and any  $m \geq 1$ , there is a surjective homomorphism  $\pi_{k,m}^n : \mathbb{G}_m^{\otimes n}(k)/m \to K_n^M(k)/m$ .

*Proof.* By [Som90, Thm. 1.4], we have a canonical isomorphism  $K(k; \mathbb{G}_m, \ldots, \mathbb{G}_m) \simeq K_n^M(k)$ . As the Somekawa K-group is a quotient of the Mackey product  $\mathbb{G}_m^{\stackrel{M}{\otimes} n}(k)$ , there is a surjective homomorphism  $\pi_{k,m}^n: \mathbb{G}_m^{\stackrel{M}{\otimes} n}(k)/m \to K_n^M(k)/m$  which is given by  $\pi_{k,m}(\{a_1,\ldots,a_n\}_{K/k}) = N_{K/k}(\{a_1,\ldots,a_n\}_K)$ , where  $N_{K/k}\colon K_n^M(K)\to K_n^M(k)$  is the norm map on the Milnor K-groups.

For simplicity, we often abbreviate  $\operatorname{res}_{L/K}(x)$  in  $\mathbb{G}_m(L)/m = L^\times/m$  as x for  $x \in \mathbb{G}_m(K)/m = K^\times/m$ . For a fixed prime number l, we denote by  $\operatorname{Symb}_l(k)$  the subgroup of  $\mathbb{G}_m^{\stackrel{M}{\otimes}n}(k)/l$  generated by the symbols of the form  $\{a_1,\ldots,a_n\}_{k/k}$  for  $a_i \in k^\times$ .

**Lemma 4.2.** For a prime number l, the map  $\pi_{k,l}^n \colon \mathbb{G}_m^{\stackrel{M}{\otimes} n}(k)/l \to K_n^M(k)/l$  induces an isomorphism  $\operatorname{Symb}_l(k) \xrightarrow{\simeq} K_n^M(k)/l$ .

Proof. To show that  $\varphi_k: K_n^M(k)/l \to \mathbb{G}_m^{\stackrel{M}{\otimes} n}(k)/l$ ;  $\{a_1,\ldots,a_n\}_k \mapsto \{a_1,\ldots,a_n\}_{k/k}$  is well-defined, we prove  $\{a,1-a,a_2,\ldots,a_n\}_{k/k}=0$  in  $\mathbb{G}_m^{\stackrel{M}{\otimes} n}(k)/l$  for some  $a \notin (k^{\times})^l$ . First, we consider the case  $l \neq p$  (this is a direct consequence of [RS00, Lem. 4.2.6]). Let  $T^l - a = \prod_i f_i(T)$  be the decomposition with monic and irreducible polynomials  $f_i(T)$  in k[T]. For each i, let  $\alpha_i \in k^{\text{sep}}$  be a root of  $f_i(T)$  and put  $K_i = k(\alpha_i)$ . Then,

$$1 - a = \prod_{i} f_i(1) = \prod_{i} N_{K_i/k} (1 - \alpha_i).$$

We have

$$\{a, 1 - a, a_2, \dots, a_n\}_{k/k}$$

$$= \sum_{i} \{a, N_{K_i/k}(\alpha_i), a_2, \dots, a_n\}_{k/k}$$

$$= \sum_{i} \{a, \alpha_i, a_2, \dots, a_n\}_{K_i/k} \text{ (by (PF))}$$

$$= \sum_{i} \{(\alpha_i)^l, \alpha_i, a_2, \dots, a_n\}_{K_i/k} \text{ (by } (\alpha_i)^l - a = \prod_{j} f_j(\alpha_i) = 0)$$

$$= 0 \text{ in } \mathbb{G}_m^{M_n}(k)/l.$$

Next, we treat the case p > 0 and l = p. Let us consider the purely inseparable extension  $K := k(\sqrt[p]{a})/k$  of degree p. The norm map gives  $N_{K/k}(\sqrt[p]{a}) = (\sqrt[p]{a})^p = a$ . Therefore, by the projection formula  $(\mathbf{PF})$ , we have

$$\{ a, 1 - a, a_2, \dots, a_n \}_{k/k} = \{ N_{K/k}(\sqrt[p]{a}), 1 - a, a_2, \dots, a_n \}_{k/k}$$

$$= \{ \sqrt[p]{a}, 1 - a, a_2, \dots, a_n \}_{K/k} .$$

The equality  $1 - a = (1 - \sqrt[p]{a})^p$  in K, gives  $\{a, 1 - a, a_2, \dots, a_n\}_{k/k} = 0$ .

**Theorem 4.3.** Let l be a prime number. We assume that k contains a primitive l-th root of unity when  $l \neq p$ . Then, for any  $n \geq 1$ , the map  $\pi_{k,l}^n \colon \mathbb{G}_m^{\otimes n}(k)/l \to K_n^M(k)/l$  is bijective.

*Proof.* Put  $\pi_k := \pi_{k,l}^n$ . From Lemma 4.2, we have a map  $\varphi_k : K_n^M(k)/l \to \mathbb{G}_m^{\stackrel{M}{\otimes}n}(k)/l$  defined by  $\varphi_k(\{a_1,\ldots,a_n\}_k) = \{a_1,\ldots,a_n\}_{k/k}$  and this gives  $\pi_k \circ \varphi_k = \text{id}$ . To show Theorem 4.3, it is sufficient to prove that  $\varphi_k$  is surjective or  $\pi_k$  is injective.

Let  $k^{(l)}/k$  be the field extension corresponding to the l-Sylow subgroup of  $Gal(k^{sep}/k)$ . The following diagram is commutative:

$$\mathbb{G}_{m}^{\stackrel{M}{\otimes}n}(k^{(l)})/l \xrightarrow{\pi_{k^{(l)}}} K_{n}^{M}(k^{(l)})/l$$

$$\operatorname{res}_{k^{(l)}/k} \qquad \qquad \uparrow \operatorname{res}_{k^{(l)}/k}$$

$$\mathbb{G}_{m}^{\stackrel{M}{\otimes}n}(k)/l \xrightarrow{\pi_{k}} K_{n}^{M}(k)/l.$$

To show that  $\pi_k$  is injective, take any  $\xi \in \mathbb{G}_m^{\stackrel{M}{\otimes} n}(k)/l$  with  $\pi_k(\xi) = 0$ . If we assume that  $\pi_{k^{(l)}}$  is bijective, we have  $\operatorname{res}_{k^{(l)}/k}(\xi) = 0$  in  $\mathbb{G}_m^{\stackrel{M}{\otimes} n}(k^{(l)})/l$ . One can write  $\mathbb{G}_m^{\stackrel{M}{\otimes} n}(k^{(l)})/l \simeq \varinjlim_K (\mathbb{G}_m^{\stackrel{M}{\otimes} n}/l)(K)$ , where K runs through all finite extension K/k within  $k^{(l)}$  (for the proof, see [Akh00, Lem. 3.6.4]). There exists a subextension  $k \subset K \subset k^{(l)}$  such that [K:k] is finite and  $\operatorname{res}_{K/k}(\xi) = 0$ . This implies  $[K:k]\xi = \operatorname{tr}_{K/k} \circ \operatorname{res}_{K/k}(\xi) = 0$ . Since [K:k] is prime to l, the restriction  $\operatorname{res}_{K/k}$  is injective so that we obtain  $\xi = 0$ . Consequently, we may assume  $k = k^{(l)}$  and it is left to show that  $\varphi_k$  is surjective. Take any symbol  $\{\alpha_1,\ldots,\alpha_n\}_{K/k}$  in  $\mathbb{G}_m^{\stackrel{M}{\otimes} n}(k)/l$  and we show that this is in  $\operatorname{Symb}_l(k)$ . There exists a tower of fields  $k = k_0 \subset k_1 \subset k_2 \subset \cdots \subset k_r = K$  such that  $[k_i:k_{i-1}] = l$ . By induction on r, we may assume [K:k] = l. It is known that  $\{\alpha_1,\ldots,\alpha_n\}_K \in K_n^M(K)$  is written as a sum of elements of the form  $\{\xi,x_2,\ldots,x_n\}_K$  for some  $\xi \in K^\times$  and  $x_2,\ldots,x_n \in k^\times$  (Proposition 4.4 below). From Lemma 4.2, we have

$$\{\alpha_1, \dots, \alpha_n\}_{K/K} = \sum_i \{\xi^{(i)}, x_2^{(i)}, \dots, x_n^{(i)}\}_{K/K}$$

for some  $\xi^{(i)} \in K^{\times}$  and  $x_2^{(i)}, \dots, x_n^{(i)} \in k^{\times}$ . By the projection formula (**PF**), we obtain

$$\{\alpha_{1}, \dots, \alpha_{n}\}_{K/k} = \operatorname{tr}_{K/k}(\{\alpha_{1}, \dots, \alpha_{n}\}_{K/K})$$

$$= \sum_{i} \operatorname{tr}_{K/k}(\{\xi^{(i)}, x_{2}^{(i)}, \dots, x_{n}^{(i)}\}_{K/K})$$

$$= \sum_{i} \{\xi^{(i)}, x_{2}^{(i)}, \dots, x_{n}^{(i)}\}_{K/k}$$

$$= \sum_{i} \{N_{K/k}(\xi^{(i)}), x_{2}^{(i)}, \dots, x_{n}^{(i)}\}_{k/k}.$$

Namely,  $\{\alpha_1, \ldots, \alpha_n\}_{K/k}$  is in  $\mathrm{Symb}_l(k)$  and the map  $\varphi_k$  is surjective.  $\square$ 

**Proposition 4.4** ([BT73, Chap. I, Cor. 5.3], [Akh00, Prop. 2.2.3]). Let k be a field and l a prime number. Suppose that every finite extension of k is of degree  $l^r$  for some  $r \ge 0$ . Then, for an extension K/k of degree l, the group  $K_n^M(K)$  is generated by symbols of the form  $\{\xi, x_2, \ldots, x_n\}_K$  where  $\xi \in K^{\times}$  and  $x_2, \ldots, x_n \in k^{\times}$ .

**Theorem 4.5.** Let k be an arbitrary field of characteristic  $p \geq 0$ . For any  $m \geq 1$  and  $n \geq 0$ , the map  $\pi_{k,m}^n \colon \mathbb{G}_m^{\otimes n}(k)/m \xrightarrow{\cong} K_n^M(k)/m$  is bijective. Moreover, this gives an isomorphism of Mackey functors  $\mathbb{G}_m^{\otimes n}/m \simeq K_n^M/m$ .

*Proof.* Putting  $\mathbb{G}_m^{\stackrel{M}{\otimes} 0}(k) = \mathbb{Z}$ , for the cases n = 0 and n = 1, there is nothing to show so that we assume  $n \geq 2$ . Put  $m = m'p^r$  with an integer m' > 0 prime to p. The Galois

symbol map (1.1) and the differential symbol map (Theorem 1.2) give an isomorphism

$$s_{k,m}^n: K_n^M(k)/m \xrightarrow{\simeq} H^n(k, \mathbb{Z}/m'(n)) \oplus H^n(k, \mathbb{Z}/p^r(n)).$$

In the following, we often identify  $K_n^M(k)/m$  and  $H^n(k,\mathbb{Z}/m(n))$  through this isomorphism. By Proposition 4.1,  $\pi_{k,m}^n$  is surjective which is given by  $\pi_{k,m}(\{a_1,\ldots,a_n\}_{K/k})=$ 

 $N_{K/k}(\{a_1,\ldots,a_n\}_K)$ . It is enough to show that  $\pi_{k,l^r}^n:\mathbb{G}_m^{\stackrel{M}{\otimes}n}(k)/l^r\to K_n^M(k)/l^r$  is injective for any prime l and  $r\geq 1$ . Now, we divide the proof into the two cases (a)  $l\neq p$ , and (b) l=p>0.

In the case (a):  $l \neq p$ , by the standard arguments, we will reduce to showing the case that k contains a primitive l-th root of unity (e.g., [Kah97, Sect. 1.2], [Sus99, Sect. 1]). Take a primitive l-th root of unity  $\zeta_l \in k^{\text{sep}}$  and put  $k' := k(\zeta_l)$  which is a field extension of k of degree prime to l. There is a commutative diagram:

$$\mathbb{G}_{m}^{\stackrel{M}{\otimes}n}(k')/l^{r} \xrightarrow{\pi_{k',l^{r}}^{n}} K_{n}^{M}(k')/l^{r}$$

$$\operatorname{res}_{k'/k} \qquad \qquad \qquad \uparrow \operatorname{res}_{k'/k}$$

$$\mathbb{G}_{m}^{\stackrel{M}{\otimes}n}(k)/l^{r} \xrightarrow{\pi_{k,l^{r}}^{n}} K_{n}^{M}(k)/l^{r}.$$

Since [k':k] is prime to l, the restriction maps are injective. If  $\pi^n_{k',l^r}$  is injective, so is  $\pi^n_{k,l^r}$ . Accordingly, we may assume  $\zeta_l \in k$ . Next, we consider the commutative diagram below:

$$\mathbb{G}_{m}^{\stackrel{M}{\otimes}(n-1)}(k)/l \xrightarrow{\{\zeta_{l},-,\dots,-\}_{k/k}} \mathbb{G}_{m}^{\stackrel{M}{\otimes}n}(k)/l^{r} \longrightarrow \mathbb{G}_{m}^{\stackrel{M}{\otimes}n}(k)/l^{r+1} \longrightarrow \mathbb{G}_{m}^{\stackrel{M}{\otimes}n}(k)/l \longrightarrow 0$$

$$\downarrow \pi_{k,l}^{n-1} \qquad \qquad \downarrow \pi_{k,lr}^{n} \qquad \qquad \downarrow \pi_{k,lr+1}^{n} \qquad \qquad \downarrow \pi_{k,l}^{n}$$

$$H^{n-1}(k,\mathbb{Z}/l(n-1)) \xrightarrow{\zeta_{l}\cup-} H^{n}(k,\mathbb{Z}/l^{r}(n)) \longrightarrow H^{n}(k,\mathbb{Z}/l^{r+1}(n)) \longrightarrow H^{n}(k,\mathbb{Z}/l(n)).$$

In the above diagram, the lower sequence is a part of the long exact sequence induced from the short exact sequence  $0 \to \mu_{lr}^{\otimes n} \to \mu_{lr+1}^{\otimes n} \to \mu_{l}^{\otimes n} \to 0$ . The upper one is a complex and exact except the term  $\mathbb{G}_m^{\otimes n}(k)/l^r$ . By the induction on r and Theorem 4.3,  $\pi_{k,l^{r+1}}^n$  is bijective.

Consider the case (b): l = p > 0. As in the proof of [BK86, Cor. 2.8], we have the following commutative diagram with exact rows:

$$\mathbb{G}_{m}^{M}(k)/p \longrightarrow \mathbb{G}_{m}^{M}(k)/p^{r+1} \longrightarrow \mathbb{G}_{m}^{M}(k)/p^{r} \longrightarrow 0$$

$$\downarrow \pi_{k,p}^{n} \qquad \qquad \downarrow \pi_{k,p^{r+1}}^{n} \qquad \qquad \downarrow \pi_{k,p^{r}}^{n}$$

$$0 \longrightarrow K_{n}^{M}(k)/p \longrightarrow K_{n}^{M}(k)/p^{r+1} \longrightarrow K_{n}^{M}(k)/p^{r} \longrightarrow 0.$$

In fact, the exactness of the lower horizontal sequence follows from

$$K_n^M(k)/p \xrightarrow{} K_n^M(k)/p^{r+1} \xrightarrow{} K_n^M(k)/p^r \xrightarrow{} 0$$

$$\downarrow s_{k,p}^n \qquad \qquad \downarrow s_{k,p^{r+1}}^n \qquad \qquad \downarrow s_{k,p^r}^n$$

$$0 \xrightarrow{} H^n(k, \mathbb{Z}/p(n)) \xrightarrow{} H^n(k, \mathbb{Z}/p^{r+1}(n)) \xrightarrow{} H^n(k, \mathbb{Z}/p^r(n))$$

and the Bloch-Gabber-Kato theorem (Theorem 1.2). By the induction on r and the digram (4.1), Theorem 4.5 follows from Theorem 4.3.

# 5. Mackey products and the De Rham-Witt complex

Let k be a field of positive characteristic p > 0 and  $k^{\text{sep}}$  the separable closure of k in an algebraic closure of k. For an extension K/k, we consider the p-th power Frobenius  $\phi \colon K \to K; a \mapsto a^p$ . The induced homomorphism  $W_r(\phi) \colon W_{r+1}(k) \to W_r(k)$  coincides with  $F \colon W_r(k) \to W_r(k)$  (cf. (3.3)). For any  $r \geq 1$  and any field extension K/k, we consider the homomorphism

$$\wp = F - \mathrm{id} : W_r(K) \to W_r(K).$$

The map  $\wp$  also induces the map  $\wp: W_r \to W_r$  of Mackey functors ([Rül07, Prop. A.9 (v)]). For any Mackey functor  $\mathscr{M}$ , we define a map

(5.1) 
$$\wp := \wp \overset{M}{\otimes} \operatorname{id} : W_r \overset{M}{\otimes} \mathscr{M} \to W_r \overset{M}{\otimes} \mathscr{M}.$$

For simplicity, we denote also the induced map  $\wp(k) \colon (W_r \overset{M}{\otimes} \mathscr{M})(k) \to (W_r \overset{M}{\otimes} \mathscr{M})(k)$  by  $\wp$ .

**Lemma 5.1.** For any Mackey functor  $\mathcal{M}$  over k, We have isomorphisms

$$(W_r \overset{M}{\otimes} \mathscr{M})/\wp \simeq W_r/\wp \overset{M}{\otimes} \mathscr{M} \simeq W_r/\wp \overset{M}{\otimes} \mathscr{M}/p^r.$$

Proof. Recalling from Example 2.2 (i),  $(W_r \overset{M}{\otimes} \mathscr{M})/\wp$  is the cokernel of  $\wp: W_r \overset{M}{\otimes} \mathscr{M} \to W_r \overset{M}{\otimes} \mathscr{M}$  defined in (5.1). The isomorphism  $(W_r \overset{M}{\otimes} \mathscr{M})/\wp \simeq W_r/\wp \overset{M}{\otimes} \mathscr{M}$  follows from the right exactness of the product  $-\overset{M}{\otimes} \mathscr{M}$ . Since the Witt ring  $W_r(K)$  is annihilated by  $p^r$ , we obtain  $W_r/\wp \overset{M}{\otimes} \mathscr{M} \simeq W_r/\wp \overset{M}{\otimes} \mathscr{M}/p^r$ .

For any  $n \geq 1$ , the cokernel of the extended  $\wp$  with respect to the product  $\mathbb{G}_m^{\stackrel{M}{\otimes}(n-1)}$  (cf. (5.1)) is denoted by

$$M_{n^r}^n := (W_r \overset{M}{\otimes} \mathbb{G}_m^{\overset{M}{\otimes}(n-1)})/\wp.$$

Corollary 5.2. If k is perfect and  $n \geq 2$ , then  $M_{n^r}^n(k) = 0$ .

*Proof.* This follows from Lemma 5.1 and  $(\mathbb{G}_m/p^r)(k) = 0$ .

We put

$$H_{p^r}^n(k) := H^n(k, \mathbb{Z}/p^r(n-1)) = H^1(k, W_r\Omega_{\log}^{n-1}).$$

The map  $F: W_r\Omega_k^{n-1} \to W_r\Omega_k^{n-1}/\mathrm{d}V^{r-1}\Omega_k^{n-2}$  (cf. (3.3)) induces the following short exact sequence:

$$(5.2) \quad 0 \to H^{n-1}(k, \mathbb{Z}/p^r(n-1)) \to W_r\Omega_k^{n-1} \xrightarrow{\wp} W_r\Omega_k^{n-1}/\mathrm{d}V^{r-1}\Omega_k^{n-2} \to H_{p^r}^n(k) \to 0,$$

where  $\wp := F - \mathrm{id}$  (cf. [Shi07, Prop. 2.8], [Izh00, Sect. A.1.3]). Since F is a ring homomorphism of  $W_r\Omega_k^{\bullet}$  and satisfies  $F(\mathrm{d}[b]) = [b]^{p-1}\mathrm{d}[b]$ , the map  $\wp$  is given by  $\wp(\mathbf{a} \operatorname{dlog}[b_1] \cdots \operatorname{dlog}[b_{n-1}]) = \wp(\mathbf{a}) \operatorname{dlog}[b_1] \cdots \operatorname{dlog}[b_{n-1}]$ . Moreover, we have the following explicit description of  $H_{n^r}^n(k)$ .

**Theorem 5.3** ([Kat80, Sect. 2, Cor. 4 to Prop. 2], see also [Izh00, Sect. A.1.3]). The natural homomorphism  $\mathbf{a} \otimes b_1 \otimes \cdots \otimes b_{n-1} \mapsto [\mathbf{a}, b_1, \dots, b_{n-1})_k := \mathbf{a} \operatorname{dlog}[b_1] \cdots \operatorname{dlog}[b_{n-1}]$  induces an isomorphism

$$\left(W_r(k) \otimes_{\mathbb{Z}} (k^{\times})^{\otimes_{\mathbb{Z}}(n-1)}\right)/J \xrightarrow{\simeq} H_{p^r}^n(k),$$

where J is the subgroup generated by all elements of the form:

- (a)  $\mathbf{a} \otimes b_1 \otimes \cdots \otimes b_{n-1}$  with  $b_i = b_j$  for some  $i \neq j$ .
- (b)  $(0, \ldots, 0, a, 0, \ldots, 0) \otimes a \otimes b_2 \otimes \cdots \otimes b_{n-1}$  for some  $a \in k$ .
- (c)  $\wp(\mathbf{a}) \otimes b_1 \otimes \cdots \otimes b_{n-1}$ .

From the sequence (5.2), we regard  $H_{p^r}^n(k)$  as a quotient of  $W_r\Omega_k^{n-1}$ . For any finite field extension K/k, the trace map  $\operatorname{Tr}_{K/k}:W_r\Omega_K^{\bullet}\to W_r\Omega_k^{\bullet}$  is a map of differential graded modules commutes with V and F (Theorem 3.1). The trace map  $\operatorname{Tr}_{K/k}:W_r\Omega_K^{n-1}\to W_r\Omega_k^{n-1}$  induces a map  $H_{p^r}^n(K)\to H_{p^r}^n(k)$  which we also write  $\operatorname{Tr}_{K/k}$ .

**Proposition 5.4.** There is a surjective homomorphism  $t_{k,p^r}^n: M_{p^r}^n(k) \to H_{p^r}^n(k)$  which is given by

(5.3) 
$$\{\mathbf{a}, b_1, \dots, b_{n-1}\}_{K/k} \mapsto \operatorname{Tr}_{K/k}([\mathbf{a}, b_1, \dots, b_{n-1})_K).$$

*Proof.* We define  $t_{k,p^r}^n : (W_r \overset{M}{\otimes} \mathbb{G}_m^{\overset{M}{\otimes} (n-1)})(k) \to H_{p^r}^n(k)$  by the corresponding given in (5.3). To show that  $t_{k,p^r}^n$  is well-defined, take finite field extensions  $k \subset K \subset L$ .

Case (a): For  $\beta_{i_0} \in \mathbb{G}_m(L)$ ,  $b_i \in \mathbb{G}_m(K)$  with  $i \neq i_0$ , and  $\mathbf{a} \in W_r(K)$ , the relation (**PF**) implies the equality:

$$\{\mathbf{a}, b_1, \dots, N_{L/K}(\beta_{i_0}), \dots, b_{n-1}\}_{K/k} = \{\mathbf{a}, b_1, \dots, \beta_{i_0}, \dots, b_{n-1}\}_{L/k}.$$

Here, we omit the restriction maps  $\operatorname{res}_{L/K}$  in the right. By the transitivity of the trace map  $\operatorname{Tr}_{L/k} = \operatorname{Tr}_{K/k} \circ \operatorname{Tr}_{L/K}$  (Theorem 3.1 (c)), it is sufficient to show the equality

(5.4) 
$$[\mathbf{a}, b_1, \dots, N_{L/K}(\beta_{i_0}), \dots, b_{n-1}]_K = \operatorname{Tr}_{L/K}([\mathbf{a}, b_1, \dots, \beta_{i_0}, \dots, b_{n-1}]_L).$$

The  $W_r\Omega_K^{n-1}$ -linearity of the trace map  $\operatorname{Tr}_{L/K}$ , and Lemma 3.2 imply the equality (5.4). Case (b): For  $\alpha \in W_r(L)$  and  $b_i \in \mathbb{G}_m(K)$  for  $1 \leq i \leq n-1$ , the relation (**PF**) implies the equality:

$$\{\operatorname{Tr}_{L/K}(\boldsymbol{\alpha}), b_1, \dots, b_{n-1}\}_{K/k} = \{\boldsymbol{\alpha}, b_1, \dots, b_{n-1}\}_{L/k}.$$

By the  $W_r\Omega_K^{n-1}$ -linearity of the trace map  $\mathrm{Tr}_{L/K}$ , we have

$$[\operatorname{Tr}_{L/K}(\boldsymbol{\alpha}), b_1, \dots, b_{n-1})_K = \operatorname{Tr}_{L/K}([\boldsymbol{\alpha}, b_1, \dots, b_{n-1})_L).$$

Hence,  $t_{k,p^r}^n$  is well-defined.

By Theorem 5.3, the map  $t_{k,p^r}^n$  is surjective and factors through the quotient  $M_{p^r}^n(k)$ . The induced homomorphism  $M_{p^r}^n(k) \to H_{p^r}^n(k)$  is the required one.

Let  $\operatorname{Symb}_p(k)$  be the subgroup of  $M_p^n(k) = (\mathbb{G}_a \otimes \mathbb{G}_m^M(n-1))(k)/\wp$  generated by the symbols of the form  $\{a, b_1, \ldots, b_{n-1}\}_{k/k}$ . First we show that the map  $t_{k,p}^n$  is bijective on the subgroup  $\operatorname{Symb}_p(k)$ .

**Lemma 5.5.** The map  $t_{k,p}^n \colon M_p^n(k) \to H_p^n(k)$  induces an isomorphism  $\operatorname{Symb}_p(k) \xrightarrow{\simeq} H_p^n(k)$ .

Proof. By using Theorem 5.3, we define a map  $\varphi_k: H_p^n(k) \to \operatorname{Symb}_p(k)$  by  $\varphi_k([a, b_1, \dots, b_{n-1})_k) := \{a, b_1, \dots, b_{n-1}\}_{k/k}$ . To show that  $\varphi$  is well-defined, it is left to prove  $\{a, b_1, \dots, b_{n-1}\}_{k/k} = 0$  if  $b_i = b_j$  for some  $i \neq j$ , and  $\{a, a, b_2, \dots, b_{n-1}\}_{k/k} = 0$  in  $M_p^n(k)$  for some  $a \neq 0$ . For the first equality, put  $b := b_i = b_j$ . We may assume  $b \notin (k^{\times})^p$ . Consider the purely

inseparable extension  $K := k(\sqrt[p]{b})$  of k. Since we have  $N_{K/k}(\sqrt[p]{b}) = (\sqrt[p]{b})^p = b_i$ , the projection formula  $(\mathbf{PF})$  gives

$$\{a, b_1, \dots, b_i, \dots, b_j, \dots, b_{n-1}\}_{k/k} = \{a, b_1, \dots, N_{K/k}(\sqrt[p]{b}), \dots, b_j, \dots, b_{n-1}\}_{k/k}$$

$$= \{a, b_1, \dots, \sqrt[p]{b}, \dots, b_j, \dots, b_{n-1}\}_{K/k} .$$

By  $b_j = (\sqrt[p]{b})^p$  in K, we obtain  $\{a, b_1, \dots, b_{n-1}\}_{k/k} = 0$  in  $M_p^n(k)$ .

To show the equality  $\{a, a, b_2, \ldots, b_{n-1}\}_{k/k} = 0$ . Consider the polynomial  $f(T) = T^p - T - a$  in k[T] and take a root  $\alpha \in k^{\text{sep}}$  of f(T). In the case  $\alpha \in k$ , we derive  $\wp(\alpha) = \alpha^p - \alpha = a$ , and hence  $\{a, a, b_2, \ldots, b_{n-1}\}_{k/k} = 0$  in  $M_p^n(k)$ . When  $\alpha \notin k$ , the polynomial f(T) is irreducible. In fact, the remaining roots of f(T) can be expressed as  $\alpha + i$  for  $i \in \mathbb{F}_p^{\times}$ . If g(T) is an irreducible factor of degree  $r \leq p$ , then the coefficient of  $T^{r-1}$  in g(T) is  $-\sum_{j=1}^r (\alpha + i_j)$  for some  $i_1, \ldots, i_r \in \mathbb{F}_p$ . Since this coefficient belongs to k, we conclude r = p implying f(T) = g(T). Now, let us put  $K = k(\alpha)$ . Then,

$$-a = f(0) = (-1)^p N_{K/k}(\alpha).$$

This yields  $a = N_{K/k}(\alpha)$ . Thus, we have

$$\{a, a, b_2, \dots, b_{n-1}\}_{k/k} = \{a, N_{K/k}(\alpha), b_2, \dots, b_{n-1}\}_{k/k}$$

$$= \{a, \alpha, b_2, \dots, b_{n-1}\}_{K/k} \quad \text{(by } (\mathbf{PF}))$$

$$= \{\wp(\alpha), \alpha, b_2, \dots, b_{n-1}\}_{K/k} \quad \text{(by } \alpha^p - \alpha - a = f(\alpha) = 0)$$

$$= 0 \quad \text{in } M_p^n(k).$$

Clearly, we have  $\varphi_k \circ t_{k,p}^n = \text{id on Symb}_p(k)$ . The map  $t_{k,p}^n$  induces a bijection  $\text{Symb}_p(k) \xrightarrow{\simeq} H_p^n(k)$ .

**Proposition 5.6.** Let k be a field of characteristic p > 0. Suppose that every finite extension of k is of degree  $p^r$  for some  $r \ge 0$ . Then, for  $n \ge 2$  and for an extension K/k of degree p, the quotient group  $\Omega_K^{n-1}/\mathrm{d}\Omega_K^{n-2}$  is generated by differentials of the forms

$$\xi \operatorname{dlog} y_1 \cdots \operatorname{dlog} y_{n-1}$$
, where  $\xi \in K$  and  $y_1, \ldots, y_{n-1} \in k^{\times}$ , and  $x \operatorname{dlog} \eta \operatorname{dlog} y_2 \cdots \operatorname{dlog} y_{n-1}$ , where  $x \in k, \eta \in K^{\times}$  and  $y_2, \ldots, y_n \in k^{\times}$ .

*Proof.* Take any  $\omega = \alpha \operatorname{dlog} \beta_1 \cdots \operatorname{dlog} \beta_{n-1}$  in  $\Omega_K^{n-1}$  for some  $\alpha \in K, \beta_1, \ldots, \beta_{n-1} \in K^{\times}$  with  $\alpha \neq 0$ . The differential form  $\alpha^{-1}\omega = \operatorname{dlog} \beta_1 \cdots \operatorname{dlog} \beta_{n-1}$  is in the image of the differential symbol map (3.6)

$$\operatorname{dlog} \colon K_{n-1}^{M}(K) \to \Omega_{K}^{n-1}; \{ \xi_{1}, \dots, \xi_{n-1} \}_{K} \mapsto \operatorname{dlog} \xi_{1} \cdots \operatorname{dlog} \xi_{n-1}.$$

By Proposition 4.4, the given  $\omega$  is a sum of differentials of the form  $\alpha$  dlog  $\beta$  dlog  $y_2 \cdots$  dlog  $y_{n-1}$  for some  $\beta \in K^{\times}$  and  $y_2, \ldots, y_{n-1} \in k^{\times}$ . Therefore, the assertion is reduced to the case n=2. Namely, it is enough to show that any non-trivial differential form  $\omega = \alpha$  dlog  $\beta \in \Omega^1_K/dK$  with  $\alpha \in K, \beta \in K^{\times}$  is a finite sum of the differentials of the forms

$$(5.5) \xi \operatorname{dlog} y \quad (\xi \in K, y \in k^{\times}) \quad \text{and} \quad x \operatorname{dlog} \eta \quad (x \in k^{\times}, \eta \in K^{\times}).$$

Write  $K = k(\theta) = k[T]/(\pi(T))$  using an irreducible monic polynomial  $\pi(T) \in k[T]$  of degree p. If  $\beta$  is in  $k^{\times}$ , there is nothing to show. We assume  $\beta \notin k^{\times}$ . The element  $\beta \in K^{\times}$  is the image of a polynomial  $B(T) \in k[T]$  of degree < p by the evaluation map  $k[T] \to k(\theta) = k[T]/(\pi(T))$ . Consider the irreducible decomposition  $B(T) = y \prod_i B_i(T)$  for some  $y \in k^{\times}$  and irreducible monic polynomials  $B_i(T) \in k[T]$ . From the assumption on k, the polynomial  $B_i(T)$  which has degree < p should be of the form  $B_i(T) = T - b_i$ 

for some  $b_i \in k$ . Therefore, we have  $\beta = y \prod_i (\theta - b_i)$ . Write  $\alpha = \sum_{j=0}^{p-1} a_j \theta^j$  with  $a_j \in k$ . The differential form  $\omega$  is further decomposed as a sum of differentials of the forms

$$\alpha \operatorname{dlog} y$$
, and  $\omega_j := a\theta^j \operatorname{dlog}(\theta - b)$ 

with  $a,b \in k$ . The former differential is of the required form (5.5). For the later  $\omega_j$ , if j=0 or a=0, the assertion holds. For 0 < j < p with  $a \neq 0$ , put  $\tau := \theta - b$ . Expanding  $\theta^j = (\tau + b)^j$ , the differential form  $\omega_j$  is a sum of  $\omega' := y\tau^i \operatorname{dlog} \tau$  for some  $y \in k^\times$  and  $0 \leq i < p$ . The assertion follows in the case i=0. For i>0, we have  $i\omega' = y\tau^i \operatorname{dlog}(\tau^i) = -y\tau^i \operatorname{dlog} y$  modulo  $\mathrm{d} K$ , because  $0 = \mathrm{d}(y\tau^i) = y\tau^i \operatorname{dlog}(y\tau^i) = y\tau^i \operatorname{dlog} y + y\tau^i \operatorname{dlog}(\tau^i)$  in  $\Omega^1_K/\mathrm{d} K$ . For this reason, any differential  $\omega = \alpha \operatorname{dlog} \beta$  modulo dK is written by the differentials of the forms given in (5.5).

**Theorem 5.7.** For any  $n \geq 1$ , the map  $t_{k,p}^n \colon M_p^n(k) \xrightarrow{\simeq} H_p^n(k)$  is bijective.

Proof. By Lemma 5.5, it is enough to show that the map  $t_k = t_{k,p}^n \colon M_p^n(k) \to H_p^n(k)$  is injective or  $\varphi_k \colon H_p^n(k) \to M_p^n(k)$  which is given by  $\varphi_k([a, b_1, \ldots, b_{n-1})_k) = \{a, b_1, \ldots, b_{n-1}\}_{k/k}$  is surjective. First, let  $k^{(p)}/k$  be the field extension corresponding to the p-Sylow subgroup of  $\operatorname{Gal}(k^{\operatorname{sep}}/k)$ . The following diagram is commutative:

$$M_p^n(k^{(p)}) \xrightarrow{t_{k^{(p)}}} H_p^n(k^{(p)})$$

$$\underset{k^{(p)}/k}{\operatorname{res}_{k^{(p)}/k}} \qquad \qquad \uparrow \underset{k^{(p)}/k}{\operatorname{res}_{k^{(p)}/k}}$$

$$M_p^n(k) \xrightarrow{t_k} H_p^n(k).$$

Recall that  $H_p^n(k)$  is a quotient of  $\Omega_k^{n-1}$ . Since the correspondence  $\Omega_-^{n-1} \colon K \mapsto \Omega_K^{n-1}$  forms a Mackey functor, the commutativity of the above diagram comes from the definition of the restriction map of the Mackey product  $\mathbb{G}_a \overset{M}{\otimes} \mathbb{G}_m^{\overset{M}{\otimes}(n-1)}$ . Furthermore, for any subextension  $k \subset K \subset k^{(p)}$  with  $[K:k] < \infty$ , the extension degree [K:k] is prime to p. Therefore,  $\operatorname{tr}_{K/k} \circ \operatorname{res}_{K/k} = [K:k]$  implies that  $\operatorname{res}_{K/k} \colon M_p^n(k) \to M_p^n(K)$  is injective. By  $M_p^n(k^{(p)}) \simeq \varinjlim_K M_p^n(K)$  (for the proof, see [Akh00, Lem. 3.6.4]), the left vertical map  $\operatorname{res}_{k^{(p)}/k}$  in the above diagram is injective. To show that  $t_k$  is injective, take any  $\xi \in M_p^n(k)$  with  $t_k(\xi) = 0$ . If we assume that  $t_{k^{(p)}}$  is bijective, we have  $\operatorname{res}_{k^{(p)}/k}(\xi) = 0$  in  $M_p^n(k)$  and hence  $\xi = 0$ . Thus, we may assume  $k = k^{(p)}$ . In particular, every finite extension of k is of degree  $p^r$  for some  $r \geq 0$ .

We show that the map  $\varphi_k$  is surjective by proving the equality  $M_p^n(k) = \operatorname{Symb}_p(k)$ . Take any non-zero symbol  $\{\alpha, \beta_1, \ldots, \beta_{n-1}\}_{K/k}$  in  $M_p^n(k)$  with  $[K:k] = p^r$ . There exists a tower of fields  $k = k_0 \subset k_1 \subset k_2 \subset \cdots \subset k_r = K$  such that  $[k_i:k_{i-1}] = p$ . By induction on r, we may assume [K:k] = p. By Proposition 5.6, the symbol  $[\alpha, \beta_1, \ldots, \beta_{n-1})_K = \alpha \operatorname{dlog} \beta_1 \cdots \operatorname{dlog} \beta_{n-1}$  is written as a sum of elements of the forms

$$[\xi, y_1, \dots, y_{n-1}]_K$$
 for some  $\xi \in K, y_1, \dots, y_{n-1} \in k^{\times}, and$   
 $[x, \eta, y_2, \dots, y_{n-1}]_K$  for some  $x \in k, y_2, \dots, y_{n-1} \in k^{\times}, \eta \in K^{\times}.$ 

From Lemma 5.5, the symbol  $\{\alpha, \beta_1, \ldots, \beta_{n-1}\}_{K/K}$  is a sum of symbols of the forms  $\{\xi, y_1, \ldots, y_{n-1}\}_{K/K}$  and  $\{x, \eta, y_2, \ldots, y_{n-1}\}_{K/K}$ . Hence,

$$\{\alpha, \beta_1, \dots, \beta_{n-1}\}_{K/k} = \operatorname{tr}_{K/k}(\{\alpha, \beta_1, \dots, \beta_{n-1}\}_{K/K})$$

is a sum of symbols of the form  $\{\xi, y_1, \dots, y_{n-1}\}_{K/k}$  and  $\{x, \eta, y_2, \dots, y_{n-1}\}_{K/k}$ . By the projection formula  $(\mathbf{PF})$ , we have

$$\{\xi, y_1, \dots, y_{n-1}\}_{K/k} = \{\operatorname{Tr}_{K/k}(\xi), y_1, \dots, y_{n-1}\}_{k/k},$$
$$\{x, \eta, y_2, \dots, y_{n-1}\}_{K/k} = \{x, N_{K/k}(\eta), y_2, \dots, y_{n-1}\}_{k/k}.$$

Because of this,  $\{\alpha, \beta_1, \dots, \beta_{n-1}\}_{K/k}$  is in  $\operatorname{Symb}_p(k)$  and the map  $\varphi_k$  is surjective.  $\square$ 

**Theorem 5.8.** Let k be an arbitrary field of characteristic p > 0. For  $r \ge 1$  and  $n \ge 1$ , the map  $t_{k,p^r}^n \colon M_{p^r}^n(k) \xrightarrow{\simeq} H_{p^r}^n(k)$  is bijective.

*Proof.* We show the assertion by induction on r. The case r=1 follows from Theorem 5.7. For  $r\geq 1$ , we assume that  $t^n_{k,p^r}$  is bijective. The short exact sequence  $0\to W_r\to W_{r+1}\to \mathbb{G}_a\to 0$  induces a commutative diagram with exact rows:

$$(W_r \overset{M}{\otimes} \mathbb{G}_m^{\overset{M}{\otimes}(n-1)})(k) \longrightarrow (W_{r+1} \overset{M}{\otimes} \mathbb{G}_m^{\overset{M}{\otimes}(n-1)})(k) \longrightarrow (\mathbb{G}_a \overset{M}{\otimes} \mathbb{G}_m^{\overset{M}{\otimes}(n-1)})(k) \longrightarrow 0$$

$$\downarrow^{\wp} \qquad \qquad \downarrow^{\wp} \qquad \qquad \downarrow^{\wp}$$

$$(W_r \overset{M}{\otimes} \mathbb{G}_m^{\overset{M}{\otimes}(n-1)})(k) \longrightarrow (W_{r+1} \overset{M}{\otimes} \mathbb{G}_m^{\overset{M}{\otimes}(n-1)})(k) \longrightarrow (\mathbb{G}_a \overset{M}{\otimes} \mathbb{G}_m^{\overset{M}{\otimes}(n-1)})(k) \longrightarrow 0.$$

The diagram above induces the following commutative diagram:

$$(5.6) M_{p^r}^n(k) \longrightarrow M_{p^{r+1}}^n(k) \longrightarrow M_p^n(k)$$

$$\simeq \downarrow^{t_{p^r}^n} \qquad \qquad \downarrow^{t_{p^{r+1}}^n} \qquad \simeq \downarrow^{t_p^n}$$

$$H^{n-1}(k, \mathbb{Z}/p(n-1)) \stackrel{\delta}{\longrightarrow} H_{p^r}^n(k) \longrightarrow H_{p^{r+1}}^n(k) \longrightarrow H_p^n(k).$$

Here, the bottom sequence is a part of the long exact sequence induced from the short exact sequence

$$0 \to W_r \Omega_{k^{\text{sep}},\log}^{n-1} \to W_{r+1} \Omega_{k^{\text{sep}},\log}^{n-1} \to \Omega_{k^{\text{sep}},\log}^{n-1} \to 0$$

([Ill79, Chap. I, Thm. 5.7.2], [Shi07, Prop. 2.12]). By the inductive hypothesis, the vertical maps  $t_{k,p^r}^n$  and  $t_{k,p}^n$  are bijective. The lower horizontal sequence in the above diagram (5.6) continues further to the left as

$$K_{n-1}^{M}(k)/p^{r+1} \xrightarrow{\mod p} K_{n-1}^{M}(k)/p$$

$$\simeq \downarrow s_{k,p}^{n-1} \qquad \qquad \simeq \downarrow s_{k,p}^{n-1}$$

$$H^{n-1}(k, \mathbb{Z}/p^{r+1}(n-1)) \xrightarrow{\delta} H_{n}^{n}(k).$$

By Theorem 1.2, the vertical maps in the above diagram are bijective and hence  $\delta$  is the 0 map. Thus,  $t_{k,v^{r+1}}^n$  is injective by the diagram chase in (5.6).

For a truncation set S, we have a homomorphism  $\wp = \mathbb{W}_S(\phi) - \mathrm{id} : \mathbb{W}_S(K) \to \mathbb{W}_S(K)$  and this induces a map  $\wp : \mathbb{W}_S \overset{M}{\otimes} \mathbb{G}_m^{\overset{M}{\otimes} (n-1)} \to \mathbb{W}_S \overset{M}{\otimes} \mathbb{G}_m^{\overset{M}{\otimes} (n-1)}$  of Mackey functors as in (5.1). We denote by  $M_S^n := (\mathbb{W}_S \overset{M}{\otimes} \mathbb{G}_m^{\overset{M}{\otimes} (n-1)})/\wp$  the cokernel of  $\wp$ . When S is finite, we have  $\mathbb{W}_S(K) \simeq \prod_{(m,p)=1} W_{r_m}(K)$  for any field extension K/k as in (3.4). This gives

the decomposition  $\mathbb{W}_S = \bigoplus_{(m,p)=1} W_{r_m}$  as Mackey functors. Since the Mackey product commutes with the direct sum, we have

$$M_S^n(k) \simeq \prod_{(m,p)=1} M_{p^{r_m}}^n(k).$$

According to (5.2), we define

$$H_S^n(k) := \operatorname{Coker} \left( \mathbb{W}_S \Omega_k^{n-1} \overset{(3.4)}{\simeq} \prod_{(m,p)=1} W_{r_m} \Omega_k^n \xrightarrow{\prod \wp} \prod_{(m,p)=1} W_{r_m} \Omega_k^{n-1} / dV^{r_m-1} \Omega_k^{n-2} \right).$$

Theorem 5.8 extends to any finite truncation set as follows:

Corollary 5.9. Let k be a field of characteristic p > 0. For any finite truncation set S and  $n \ge 1$ , we have an isomorphism  $M_S^n(k) \simeq H_S^n(k)$ .

Corollary 5.10. Let k be a field of characteristic p > 0. For a truncation set S and  $n \ge 1$ , we have an isomorphism

$$M_S^n(k) \simeq \varprojlim_{S_0 \subset S} H_{S_0}^n(k),$$

where  $S_0$  runs the set of all finite truncation set contained in S.

Proof. By the definition, we have  $\mathbb{W}_S(K) = \varprojlim_{S_0} \mathbb{W}_{S_0}(K)$ . Since the restriction map  $R_{S_0'}^{S_0} \colon \mathbb{W}_{S_0}(K) \to \mathbb{W}_{S_0'}(K)$  is surjective, for any finite truncation sets  $S_0' \subset S_0$ , the Mittag-Leffler condition holds. We obtain  $(\mathbb{W}_S \overset{M}{\otimes} \mathbb{G}_m^{\overset{M}{\otimes} (n-1)})(k)/\wp \simeq \varprojlim_{S_0} (\mathbb{W}_{S_0} \overset{M}{\otimes} \mathbb{G}_m^{\overset{M}{\otimes} (n-1)})(k)/\wp$ . The assertion follows from Corollary 5.9.

**Corollary 5.11.** Let k be a field of characteristic p > 0. For any finite truncation set S and  $n \ge 1$ , we have an isomorphism

$$(\mathbb{W}_S \overset{M}{\otimes} K_{n-1}^M)(k)/\wp \simeq H_S^n(k),$$

where  $\wp: (\mathbb{W}_S \overset{M}{\otimes} K_{n-1}^M)(k) \to (\mathbb{W}_S \overset{M}{\otimes} K_{n-1}^M)(k)$  is given by  $\wp(\{\mathbf{a}, \mathbf{b}\}_{K/k}) = \{\wp(\mathbf{a}), \mathbf{b}\}_{K/k}$ .

*Proof.* By the decomposition  $\mathbb{W}_S = \bigoplus_{(m,p)=1} W_{r_m}$  as Mackey functors, we have

$$(\mathbb{W}_{S} \overset{M}{\otimes} K_{n-1}^{M})(k)/\wp \simeq \bigoplus_{(p,m)=1} (W_{r_{m}} \overset{M}{\otimes} K_{n-1}^{M})(k)/\wp$$

$$\simeq \bigoplus_{(m,p)=1} (W_{r_{m}}/\wp \overset{M}{\otimes} K_{n-1}^{M}/p^{r_{m}})(k) \quad \text{(by Lemma 5.1)}$$

$$\simeq \bigoplus_{(m,p)=1} (W_{r_{m}}/\wp \overset{M}{\otimes} \mathbb{G}_{m}^{\overset{M}{\otimes}(n-1)}/p^{r_{m}})(k) \quad \text{(by Theorem 5.8)}$$

$$\simeq \bigoplus_{(m,p)=1} (W_{r_{m}} \overset{M}{\otimes} \mathbb{G}_{m}^{\overset{M}{\otimes}(n-1)})(k)/\wp \quad \text{(by Lemma 5.1)}$$

$$= M_{S}^{n}(k).$$

Corollary 5.9 gives the assertion.
