Every locally compact group is the outer automorphism group of a II_1 factor

Abstract

We prove that every locally compact second countable group G arises as the outer automorphism group Out M of a Π_1 factor, which was so far only known for totally disconnected groups, compact groups and a few isolated examples. We obtain this result by proving that every locally compact second countable group is a *centralizer group*, a class of Polish groups that arise naturally in ergodic theory and that may all be realized as Out M.

1 Introduction and main results

The outer automorphism group Out M of a II₁ factor M is the quotient of the group Aut M of all *-automorphisms of M by the normal subgroup Inn M of inner automorphisms, of the form Ad u with $u \in \mathcal{U}(M)$. In [IPP05] answering a question of Connes from the 1970s, it was proven that there exist II₁ factors M with trivial outer automorphism group. This provided at the same time the first complete computation of the outer automorphism group of any II₁ factor.

A II_1 factor M is called full if Inn M is a closed subgroup of Aut M. This is equivalent with M not having property Gamma in the sense of Murray and von Neumann. If M is full and has separable predual, Out M is a Polish group. It is a natural and by now well-studied question which Polish groups arise as the outer automorphism group of a full II_1 factor with separable predual. The following families of Polish groups could be realized in this way: compact abelian groups in [IPP05], countable discrete groups in [PV06, Vae07], arbitrary compact groups in [FV07] and several families of non locally compact groups in [PV21], including all closed subgroups of the group of all permutations of a countably infinite set.

All this however left open the question if all locally compact second countable groups, in particular Lie groups, can be realized as $\operatorname{Out} M$. We solve this problem here and the following is our main result.

Theorem A. Every locally compact second countable group G arises as the outer automorphism group $Out\ M$ of a full II_1 factor M with separable predual.

Denote by (X, μ) the standard nonatomic probability space. We consider the Polish group $\operatorname{Aut}(X, \mu)$ of all nonsingular automorphisms of (X, μ) , identifying two automorphisms that coincide almost everywhere. The measure preserving automorphisms form a closed subgroup $\operatorname{Aut}_{\mathrm{mp}}(X, \mu)$. In [Dep10, Theorem E], it was proven that for every countable subgroup $\Lambda < \operatorname{Aut}_{\mathrm{mp}}(X, \mu)$, the centralizer $C(\Lambda)$ of Λ inside $\operatorname{Aut}_{\mathrm{mp}}(X, \mu)$ is a Polish group that arises as the outer automorphism group $\operatorname{Out} M$ of a full II_1 factor M with separable predual. A more direct proof of this result was given in [PV21, Proposition 8.5].

To prove Theorem A, it thus suffices to realize every locally compact second countable group as a centralizer inside $\operatorname{Aut}_{\operatorname{mp}}(X,\mu)$. Note here that a subgroup $G < \operatorname{Aut}_{\operatorname{mp}}(X,\mu)$ is of the

form $C(\Lambda)$ for a subgroup $\Lambda < \operatorname{Aut}_{\mathrm{mp}}(X,\mu)$ if and only if G equals its double centralizer C(C(G)).

Definition B. We say that a Polish group G is a *centralizer group* if there exists an ergodic probability measure preserving action $\Lambda \curvearrowright (X, \mu)$ of a countable group Λ on a standard probability space (X, μ) such that G is isomorphic with the centralizer of Λ inside $\operatorname{Aut}_{mp}(X, \mu)$.

So as explained above, by [Dep10, PV21] for every centralizer group G, there exists a full II₁ factor M with separable predual such that $G \cong \operatorname{Out} M$. Since every locally compact group G is the centralizer of G acting on itself (by transformations that are not probability measure preserving), Theorem A is thus a consequence of the following result, which also shows that the class of centralizer groups is quite natural.

Theorem C. The following Polish groups are centralizer groups.

- (i) The centralizer of any subgroup of the Polish group $\operatorname{Aut}_{mp}(X,\mu)$ of measure preserving automorphisms of a possibly infinite σ -finite standard measure space (X,μ) .
- (ii) The centralizer of any subgroup of the Polish group $\operatorname{Aut}(X,\mu)$ of nonsingular automorphisms of a standard probability space (X,μ) .

To prove the first statement, we make use of *Poisson suspensions*, while we deduce the second statement from the first by using the *Maharam extension*. In Sections 4 and 5, we prove a few permanence properties for the class of centralizer groups, we reprove that every closed subgroup of the group S_{∞} of all permutations of a countably infinite set is a centralizer group (cf. [PV21, Corollary 8.2]) and that Aut K is a centralizer group for all compact second countable groups K.

Remark D. To summarize, we then get the following list of centralizer groups, which can all be realized as the outer automorphism group of a full II_1 factors with separable predual.

- (i) Locally compact second countable groups and their direct integrals (Theorem A and Proposition 4.2).
- (ii) Closed subgroups of S_{∞} , the group of all permutations of a countably infinite set ([PV21, Corollary 8.2] and Theorem 5.1).
- (iii) The automorphism group $\operatorname{Aut} K$ of a compact second countable group K (Proposition 5.3).
- (iv) The unitary group $\mathcal{U}(N)$ of a von Neumann algebra N with separable predual ([PV21, Corollary 8.2]).
- (v) A direct product of a countable family of centralizer groups (Proposition 4.1).

2 Preliminaries

We start by recalling the concept of *Poisson suspensions* and refer to [JRD20] for details and further references. Let (Y,η) be a standard σ -finite measure space. A measure on Y of the form $\sum_{i\in I} \delta_{y_i}$, where $(y_i)_{i\in I}$ is a countable set of points in Y, is called a *counting measure*. Write $\overline{\mathbb{N}} = \mathbb{N} \cup \{0, +\infty\}$. The set X of all counting measures ν on Y has a unique standard Borel structure such that the maps

$$N_A:X\to \overline{\mathbb{N}}:\nu\mapsto \nu(A)$$

are Borel for every Borel set $A \subset Y$. There is a unique probability measure μ on X such that for every Borel set $A \subset Y$ with $0 < \eta(A) < +\infty$, the random variable N_A has a Poisson distribution with intensity $\eta(A)$, i.e.

$$\mu(N_A^{-1}(\{k\})) = \exp(-\eta(A)) \frac{\eta(A)^k}{k!}$$
 for all $k \in \mathbb{N} \cup \{0\}$,

and such that the random variables N_{A_1}, \ldots, N_{A_n} are mutually independent for all disjoint Borel sets $A_i \subset Y$ with $0 < \eta(A_i) < +\infty$. Also note that $N_A + N_B = N_{A \cup B}$ when $A, B \subset Y$ are disjoint Borel sets.

There then is a unique isometric real linear map

$$\theta: L^2_{\mathbb{R}}(Y, \eta) \to L^2_{\mathbb{R}}(X, \mu): \theta(1_A) = N_A - \eta(A)1$$
 (2.1)

for all Borel sets $A \subset Y$ with $\eta(A) < +\infty$. One checks that

$$E_{\mu}(\exp(it\theta(\xi))) = \exp\left(\int_{Y} (\exp(it\xi) - it\xi - 1) \, d\eta\right) \quad \text{for all } \xi \in L_{\mathbb{R}}^{2}(Y, \eta), \tag{2.2}$$

where the right hand side is well-defined because $|\exp(ir) - ir - 1| \le r^2$ for all $r \in \mathbb{R}$.

Denote by $L^2_{\mathbb{R}}(Y,\eta)^{\otimes_{\text{symm}}^n}$ the closed subspace of symmetric vectors in $L^2_{\mathbb{R}}(Y,\eta)^{\otimes^n}$. Consider the symmetric Fock space

$$\mathcal{F}_s(L^2_{\mathbb{R}}(Y,\eta)) = \mathbb{R}1 \oplus \bigoplus_{n=1}^{\infty} L^2_{\mathbb{R}}(Y,\eta)^{\otimes_{\mathrm{symm}}^n}$$

and define for every $\xi \in L^2_{\mathbb{R}}(Y, \eta)$ the vector $\text{Exp}(\xi) \in \mathcal{F}_s(L^2_{\mathbb{R}}(Y, \eta))$ by

$$\operatorname{Exp}(\xi) = 1 \oplus \bigoplus_{n=1}^{\infty} \frac{1}{\sqrt{n!}} \xi^{\otimes n} .$$

Note that $\langle \text{Exp}(\xi), \text{Exp}(\zeta) \rangle = \exp(\langle \xi, \zeta \rangle)$.

Then $\theta: L^2_{\mathbb{R}}(Y,\eta) \to L^2_{\mathbb{R}}(X,\mu)$ uniquely extends to an isometric, bijective, real linear map

$$\Theta: \mathcal{F}_s(L^2_{\mathbb{R}}(Y,\eta)) \to L^2_{\mathbb{R}}(X,\mu): \Theta(\exp(\xi)-1)) = E_{\mu}(\exp(\theta(\xi)))^{-1} \exp(\theta(\xi))$$
 (2.3)

for all simple functions $\xi \in L^2_{\mathbb{R}}(Y, \eta)$, i.e. finite linear combinations of 1_A with $A \subset Y$ Borel and $\eta(A) < +\infty$.

To every $\alpha \in \operatorname{Aut}_{\mathrm{mp}}(Y, \eta)$ corresponds the Poisson suspension $\widehat{\alpha} \in \operatorname{Aut}_{\mathrm{mp}}(X, \mu)$ defined by $\widehat{\alpha}(\nu) = \alpha_*(\nu)$ for every counting measure ν on Y. Every measure preserving automorphism β of a σ -finite standard measure space (Z, ζ) , also gives rise to the canonical orthogonal transformation U_{β} of $L^2_{\mathbb{R}}(Z, \zeta)$. We then get that

$$U_{\widehat{\alpha}} \circ \Theta = \Theta \circ \left(\operatorname{id} \oplus \bigoplus_{n=1}^{\infty} U_{\alpha}^{\otimes_{\operatorname{symm}}^{n}} \right) \quad \text{for all } \alpha \in \operatorname{Aut}_{\operatorname{mp}}(Y, \eta).$$
 (2.4)

3 Centralizer groups, proof of Theorems A and C

The following is the key technical lemma showing that in certain cases, the centralizer of a Poisson suspension equals the Poisson suspension of the centralizer.

Lemma 3.1. Let (Y, η) be a standard σ -finite measure space and $\Lambda < \operatorname{Aut}_{\mathrm{mp}}(Y, \eta)$ a subgroup. Denote by (X, μ) the Poisson suspension of (Y, η) and consider $\widehat{\Lambda} < \operatorname{Aut}_{\mathrm{mp}}(X, \mu)$ given by $\widehat{\Lambda} = \{\widehat{\beta} \mid \beta \in \Lambda\}$. Assume that there exists a sequence $\beta_n \in \Lambda$ such that the orthogonal transformations U_{β_n} of $L^2_{\mathbb{R}}(Y, \eta)$ satisfy $U_{\beta_n} \to \rho \cdot \operatorname{id}$ weakly for some $0 < \rho < 1$.

Then $\widehat{\Lambda} < \operatorname{Aut_{mp}}(X, \mu)$ is ergodic and the map $\alpha \mapsto \widehat{\alpha}$ is a bijection between the centralizer of $\widehat{\Lambda}$ inside $\operatorname{Aut_{mp}}(Y, \eta)$ and the centralizer of $\widehat{\Lambda}$ inside $\operatorname{Aut_{mp}}(X, \mu)$.

Proof. Consider the symmetric Fock space $\mathcal{F}_s(L^2_{\mathbb{R}}(Y,\eta))$ and the isometry $\Theta: \mathcal{F}_s(L^2_{\mathbb{R}}(Y,\eta)) \to L^2_{\mathbb{R}}(X,\mu)$ given by (2.3). By (2.4) and the assumption that $U_{\beta_n} \to \rho \cdot \mathrm{id}$ weakly,

$$\Theta^* \circ U_{\widehat{\beta_n}} \circ \Theta \to T := \mathrm{id} \oplus \bigoplus_{n=1}^\infty \rho^n \cdot \mathrm{id} \quad \mathrm{weakly}.$$

So if $\xi \in L^2_{\mathbb{R}}(X,\mu)$ is $\widehat{\Lambda}$ -invariant, it follows that $\Theta^*(\xi) \in \mathbb{R}1$ and thus $\xi \in \mathbb{R}1$, proving the ergodicity of $\widehat{\Lambda} < \operatorname{Aut}_{\mathrm{mp}}(X,\mu)$.

Take $\varphi \in \operatorname{Aut}_{\mathrm{mp}}(X,\mu)$ centralizing $\widehat{\Lambda}$. It follows that $\Theta^* \circ U_{\varphi} \circ \Theta$ commutes with T, and thus globally preserves the eigenspace $L^2_{\mathbb{R}}(Y,\eta)$, so that U_{φ} globally preserves $\theta(L^2_{\mathbb{R}}(Y,\eta))$, with θ defined by (2.1). It follows from [Roy08, Proposition 4.4] that $\varphi = \widehat{\alpha}$ for a uniquely defined $\alpha \in \operatorname{Aut}_{\mathrm{mp}}(Y,\eta)$. For completeness, we provide the following easy argument to obtain this result.

Define the orthogonal transformation U of $L^2_{\mathbb{R}}(Y,\eta)$ such that $U_{\varphi} \circ \theta = \theta \circ U$. Take an arbitrary $\xi \in L^2_{\mathbb{R}}(Y,\eta)$. The characteristic function of the random variable $\theta(\xi)$ is given by (2.2). This is saying that $\theta(\xi)$ is infinitely divisible with Lévy measure ρ_{ξ} given by $\rho_{\xi}(U) = \eta(\xi^{-1}(U))$ for all Borel sets $U \subset \mathbb{R} \setminus \{0\}$. Since φ is measure preserving, $\theta(\xi)$ and $U_{\varphi}(\theta(\xi))$ have the same distribution and hence, the same Lévy measure. Since $U_{\varphi}(\theta(\xi)) = \theta(U(\xi))$, it follows that $\rho_{\xi} = \rho_{U(\xi)}$ for all $\xi \in L^2_{\mathbb{R}}(Y,\eta)$.

Since $\xi \geq 0$ a.e. if and only if $\rho_{\xi}(-\infty,0) = 0$ and since $\xi \leq 1$ a.e. if and only if $\rho_{\xi}(1,+\infty) = 0$, we conclude that the orthogonal transformation $U \in \mathcal{O}(L^2_{\mathbb{R}}(Y,\eta))$ maps positive functions to positive functions and maps functions $0 \leq \xi \leq 1$ to functions $0 \leq U(\xi) \leq 1$. This is only possible if $U = V_{\alpha}$ for some $\alpha \in \operatorname{Aut}_{mp}(Y,\eta)$. So, $\varphi = \widehat{\alpha}$.

Since φ commutes with $\widehat{\Lambda}$, we get that α commutes with Λ and the lemma is proven.

Lemma 3.2. Let Y be a standard Borel space and η an infinite, σ -finite, nonatomic Borel measure on Y. There exists a sequence $\beta_n \in \operatorname{Aut}_{\mathrm{mp}}(Y,\eta)$ such that the orthogonal transformations U_{β_n} of $L^2_{\mathbb{R}}(Y,\eta)$ satisfy $U_{\beta_n} \to (1/2)$ id weakly.

Proof. Since all such (Y, η) are isomorphic, we may realize $(Y, \eta) = (X \times \mathbb{Z}, \mu \times \lambda)$ with $(X, \mu) = (\{0, 1\}^{\mathbb{N}}, \mu_0^{\mathbb{N}}), \ \mu_0(0) = \mu_0(1) = 1/2$, and λ the counting measure on \mathbb{Z} . We define $\beta_n \in \operatorname{Aut}_{mp}(Y, \eta)$ by

$$\beta_n(x,k) = \begin{cases} (x,k+n) & \text{if } x_n = 0, \\ (x,k) & \text{if } x_n = 1. \end{cases}$$

Take $N \in \mathbb{N}$, $A_0, A_1 \in \{0,1\}^N$ and $B_0, B_1 \subset [-N, N] \cap \mathbb{Z}$. Write $C_i = A_i \times \{0,1\}^{>N} \subset X$. When n > 2N, we have that

$$\langle U_{\beta_n}(1_{C_0} \otimes 1_{B_0}), 1_{C_1} \otimes 1_{B_1} \rangle = \frac{1}{2} \langle 1_{C_0} \otimes 1_{B_0}, 1_{C_1} \otimes 1_{B_1} \rangle.$$

Since these vectors $1_C \otimes 1_B$ are total in $L^2_{\mathbb{R}}(Y,\eta)$, it follows that $U_{\beta_n} \to (1/2)$ id weakly. \square

Proof of Theorem C. To prove (i), take a standard σ -finite measure space (Y_0, η_0) and a subgroup $\Lambda_0 < \operatorname{Aut}_{\mathrm{mp}}(Y_0, \eta_0)$. Denote by G the centralizer of Λ_0 inside $\operatorname{Aut}_{\mathrm{mp}}(Y_0, \eta_0)$. We have to prove that G is a centralizer group in the sense of Definition B.

Take an arbitrary nonatomic, infinite, σ -finite standard measure space (Y_1, η_1) . By Lemma 3.2, take a sequence $\beta_n \in \operatorname{Aut}_{\mathrm{mp}}(Y_1, \eta_1)$ such that $U_{\beta_n} \to (1/2) \cdot \operatorname{id}$ weakly. Denote $(Y, \eta) = (Y_0 \times Y_1, \eta_0 \times \eta_1)$. Define $\Lambda_1 < \operatorname{Aut}_{\mathrm{mp}}(Y, \eta)$ by $\Lambda_1 = \Lambda_0 \times \operatorname{Aut}_{\mathrm{mp}}(Y_1, \eta_1)$.

The centralizer of Λ_1 inside $\operatorname{Aut_{mp}}(Y,\eta)$ equals $G \times \operatorname{id}$. The sequence $\operatorname{id} \times \beta_n \in \Lambda$ satisfies $U_{\operatorname{id} \times \beta_n} \to (1/2) \cdot \operatorname{id}$ weakly. Denote by (X,μ) the Poisson suspension of (Y,η) and denote by $\widehat{\Lambda_1} < \operatorname{Aut}(X,\mu)$ the Poisson suspension Λ_1 . By Lemma 3.1, the subgroup $\widehat{\Lambda_1} < \operatorname{Aut_{mp}}(X,\mu)$ is ergodic and its centralizer inside $\operatorname{Aut_{mp}}(X,\mu)$ is isomorphic with G.

Since $\operatorname{Aut}_{\mathrm{mp}}(X,\mu)$ is a Polish group, we can choose a countable subgroup Λ of $\operatorname{Aut}_{\mathrm{mp}}(X,\mu)$ whose closure equals the closure of $\widehat{\Lambda_1}$. Since the centralizer of Λ equals the centralizer of $\widehat{\Lambda_1}$, it follows that G is a centralizer group in the sense of Definition B.

To prove (ii), take a standard probability space (Y_0, η_0) and a subgroup $\Lambda_0 < \operatorname{Aut}(Y_0, \eta_0)$ of nonsingular transformations. Denote by G the centralizer of Λ_0 inside $\operatorname{Aut}(Y_0, \eta_0)$. We have to prove that G is a centralizer group.

Denote by γ the measure on \mathbb{R} given by $d\gamma(t) = \exp(-t) dt$. Write $(Y_1, \eta_1) = (Y_0 \times \mathbb{R}, \eta_0 \times \gamma)$. For every $\beta \in \operatorname{Aut}(Y_0, \eta_0)$, denote its *Maharam extension* by

$$\widetilde{\beta} \in \operatorname{Aut}_{\mathrm{mp}}(Y_1, \eta_1) : \widetilde{\beta}(y, t) = (\beta(y), t + \log \frac{d(\beta_*^{-1}(\eta))}{d\eta}(y)).$$

For every $s \in \mathbb{R}$, denote by λ_s the measure scaling automorphism $\lambda_s(y,t) = (y,t+s)$. Then

$$\Psi: \operatorname{Aut}(Y_0, \eta_0) \to \operatorname{Aut}_{\operatorname{mp}}(Y_1, \eta_1): \Psi(\beta) = \widetilde{\beta}$$

is a group homomorphism whose image is equal to

$$\{\zeta \in \operatorname{Aut}_{mp}(Y_1, \eta_1) \mid \forall s \in \mathbb{R} : \zeta \circ \lambda_s = \lambda_s \circ \zeta \text{ a.e.} \}$$
.

The image of Ψ is closed and Ψ is a homeomorphism between $\operatorname{Aut}(Y_0, \eta_0)$ and the image of Ψ .

Then define $(Y, \eta) = (Y_1 \times \mathbb{R}, \eta_1 \times \gamma) = (Y_0 \times \mathbb{R} \times \mathbb{R}, \eta_0 \times \gamma \times \gamma)$. For every $s \in \mathbb{R}$, define $\rho_s \in \operatorname{Aut}_{\operatorname{mp}}(Y, \eta)$ by $\rho_s(y, t_1, t_2) = (y, t_1 + s, t_2 - s)$. Denote by $\Lambda < \operatorname{Aut}_{\operatorname{mp}}(Y, \eta)$ the subgroup generated by $\widetilde{\beta} \times \operatorname{id}$, $\beta \in \Lambda_0$, ρ_s , $s \in \mathbb{R}$, and $\operatorname{id} \times \operatorname{Aut}_{\operatorname{mp}}(\mathbb{R}, \gamma)$. Denote by G_1 the centralizer of Λ inside $\operatorname{Aut}_{\operatorname{mp}}(Y, \eta)$. Since we have already proven (i), it suffices to prove that $G \cong G_1$.

Take $\varphi \in G_1$. Since φ commutes with $\mathrm{id} \times \mathrm{id} \times \mathrm{Aut}_{\mathrm{mp}}(\mathbb{R}, \gamma)$, we get that $\varphi = \psi \times \mathrm{id}$ for some $\psi \in \mathrm{Aut}_{\mathrm{mp}}(Y_1, \eta_1)$. Since φ commutes with all ρ_s , we get that ψ commutes with all λ_s . Since ψ is measure preserving, we get that $\psi = \widetilde{\alpha}$ for a unique $\alpha \in G$. So the map $\alpha \mapsto \Psi(\alpha) \times \mathrm{id}$ implements the isomorphism $G \cong G_1$.

Proof of Theorem A. Choose a probability measure μ that is equivalent with the Haar measure on G. View $G < \operatorname{Aut}(G, \mu)$ by right translations. Then the centralizer of G equals the copy of G in $\operatorname{Aut}(G, \mu)$ by left translations. By Theorem C.(ii), the group G is a centralizer group. By [Dep10, Theorem E] (see also [PV21, Proposition 8.5]), there exists a full II₁ factor M with separable predual such that $\operatorname{Out} M \cong G$.

4 Permanence properties

When $(G_i)_{i\in I}$ is a countable family of Polish groups, the product $\prod_{i\in I} G_i$ with the topology of pointwise convergence is again a Polish group. We start with the following elementary

observation.

Proposition 4.1. If $(G_i)_{i \in I}$ is a countable family of centralizer groups, the product $\prod_i G_i$ also is a centralizer group.

Proof. Choose standard probability spaces (X_i, μ_i) and ergodic subgroups $\Lambda_i < \operatorname{Aut}_{\mathrm{mp}}(X_i, \mu_i)$ whose centralizers are isomorphic with G_i for all $i \in I$. Define the standard probability $(X, \mu) = \prod_{i \in I} (X_i, \mu_i)$. For every $i \in I$, denote by $\Gamma_i < \operatorname{Aut}_{\mathrm{mp}}(X, \mu)$ the group Λ_i acting in the i'th coordinate. Define $\Gamma < \operatorname{Aut}_{\mathrm{mp}}(X, \mu)$ as the subgroup generated by all the Γ_i , $i \in I$. Since each $\Lambda_i < \operatorname{Aut}_{\mathrm{mp}}(X_i, \mu_i)$ is ergodic, any element $\alpha \in \operatorname{Aut}_{\mathrm{mp}}(X, \mu)$ that centralizes Γ must be of the form $\prod_i \alpha_i$ with $\alpha_i \in \operatorname{Aut}_{\mathrm{mp}}(X_i, \mu_i)$. From this the result follows immediately. \square

With some more care, we also have the following continuous variant of Proposition 4.1.

Recall from [VW24, Definition 7.3] (see also [Sut85]) the concept of a measured field $(G_x)_{x \in X}$ of Polish groups. In a nutshell, this means that (X, μ) is a standard probability space and that, after discarding from X a Borel set of measure zero, we are given a standard Borel structure on the disjoint union $G = \sqcup_{x \in X} G_x$ such that the following holds: the natural factor map $\pi: G \to X$ is Borel, there exists a dense sequence of Borel sections $\varphi_n: X \to G$ and, writing $G \times_{\pi} G = \{(g,h) \mid \pi(g) = \pi(h)\}$, the multiplication map $G \times_{\pi} G \to G$ and the inverse map $G \to G$ are Borel.

Given such a measured field $(G_x)_{x\in X}$ over (X,μ) , we consider the group \mathcal{G} of all Borel sections $\psi: X\to G$, where we identify sections that are equal a.e. With pointwise multiplication and with the topology of convergence in measure, where $\psi_k\to\psi$ if and only if $\mu(\{x\in X\mid d(\psi_k(x),\psi(x))>\varepsilon\})\to 0$ for all $\varepsilon>0$, we get that \mathcal{G} is a Polish group.

Note that when X is a countable set and μ is an atomic probability measure that assigns a positive value to each atom, then $\mathcal{G} = \prod_{i \in X} G_i$ as above. In that sense, \mathcal{G} is a "direct integral" version of the usual product of Polish groups.

Proposition 4.2. Let (X, μ) be a standard probability space and let $(G_x)_{x \in X}$ be a measured field of second countable locally compact groups. As above, denote by \mathcal{G} the Polish group of measurable sections of this field, identifying sections that are equal a.e. and using the topology of convergence in measure. Then \mathcal{G} is a centralizer group.

Proof. We discard from X a Borel set of measure zero, so that $G = \sqcup_{x \in X} G_x$ is equipped with a standard Borel structure satisfying the conditions explained above (see [VW24, Definition 7.3]). Using [VW24, Proposition 10.2], we may choose probability measures γ_x on G_x such that for every $x \in X$, γ_x is equivalent with the Haar measure of G_x and such that for every positive Borel function $F: G \to [0, +\infty)$, the map

$$X \to [0, +\infty] : x \mapsto \int_{G_x} F \, d\gamma_x$$

is Borel. We then denote by γ the probability measure on the Borel σ -algebra of G given by

$$\gamma(\mathcal{U}) = \int_X \gamma_x(\mathcal{U} \cap G_x) \, d\mu(x) = \int_X \left(\int_{G_x} 1_{\mathcal{U}} \, d\gamma_x \right) d\mu(x) \quad \text{for every Borel set } \mathcal{U} \subset G.$$

By construction, $\pi_*(\gamma) = \mu$. For every Borel section $\varphi: X \to G$, define the Borel bijections

$$\alpha_{\varphi}: G \to G: \alpha_{\varphi}(g) = \varphi(\pi(g))g$$
 and $\beta_{\varphi}: G \to G: \beta_{\varphi}(g) = g\varphi(\pi(g))^{-1}$.

Since every γ_x is equivalent with the Haar measure of G_x , it follows that all α_{φ} and β_{φ} are nonsingular automorphisms of (G, γ) . By construction,

$$\alpha: \mathcal{G} \to \operatorname{Aut}(G, \gamma): \varphi \mapsto \alpha_{\varphi} \quad \text{and} \quad \beta: \mathcal{G} \to \operatorname{Aut}(G, \gamma): \varphi \mapsto \beta_{\varphi}$$

are faithful continuous group homomorphisms.

Note that whenever G_0 is a locally compact second countable group and γ_0 is a probability measure on G_0 that is equivalent with the Haar measure of G, then the embedding $G_0 \hookrightarrow \operatorname{Aut}(G_0, \gamma_0)$ given by left translation has a closed image and is a homeomorphism of G_0 onto this image. It follows that the same holds for $\alpha : \mathcal{G} \to \operatorname{Aut}(G, \gamma)$.

We claim that $\Delta \in \operatorname{Aut}(G, \gamma)$ belongs to $\alpha(\mathcal{G})$ if and only if Δ commutes with $\beta(\mathcal{G})$ and satisfies $\pi(\Delta(g)) = \pi(g)$ for a.e. $g \in G$. One implication being obvious, assume that $\Delta \in \operatorname{Aut}(G, \gamma)$ commutes with $\beta(\mathcal{G})$ and satisfies $\pi(\Delta(g)) = \pi(g)$ for a.e. $g \in G$. Choose a dense sequence of Borel sections $\varphi_n : X \to G$. Take a conull Borel set $X_0 \subset X$ such that for every $x \in X_0$, the following holds:

$$\pi(\Delta(g)) = x$$
 for γ_x -a.e. $g \in G_x$, and $(\Delta \circ \beta_{\varphi_n})(g) = (\beta_{\varphi_n} \circ \Delta)(g)$ for all $n \in \mathbb{N}$ and γ_x -a.e. $g \in G_x$.

So for every $x \in X_0$, there is a unique $\varphi(x) \in G_x$ such that $\Delta(g) = \varphi(x)g$ for γ_x -a.e. $g \in G_x$. It follows that $\varphi \in \mathcal{G}$ and $\Delta = \alpha(\varphi)$. So the claim is proven.

Take any nonatomic standard probability space (Y_1, η_1) . Choose an injective Borel map $\rho: X \to \operatorname{Aut}_{\mathrm{mp}}(Y_1, \eta_1)$. Write $(Y, \eta) = (G \times Y_1, \gamma \times \eta_1)$ and define $\delta \in \operatorname{Aut}_{\mathrm{mp}}(Y, \eta)$ by $\delta(g, y) = (g, \rho(\pi(g))(y))$.

Define $\Lambda < \operatorname{Aut}(Y, \eta)$ as the subgroup generated by $\Lambda_0 \times \operatorname{Aut}_{\mathrm{mp}}(Y_1, \eta_1)$ and δ . We prove that the centralizer of Λ inside $\operatorname{Aut}(Y, \eta)$ is given by $\alpha(\mathcal{G}) \times \operatorname{id}$. The proposition then follows from Theorem C.(ii).

Choose $\Delta \in \operatorname{Aut}(Y, \eta)$ that commutes with Λ . Since Δ commutes with $\operatorname{id} \times \operatorname{Aut}_{\operatorname{mp}}(Y_1, \eta_1)$, we get that $\Delta = \Delta_0 \times \operatorname{id}$ for some $\Delta_0 \in \operatorname{Aut}(G, \gamma)$. Since Δ commutes with δ and ρ is injective, it follows that $\pi \circ \Delta_0 = \pi$. Since Δ_0 also commutes with Λ_0 , the result follows from the claim above.

Remark 4.3. It is plausible that for any measured field $(G_x)_{x\in X}$ of Polish groups with the property that a.e. G_x is a centralizer group, also the Polish group \mathcal{G} of measurable sections is a centralizer group. To prove such a result, one would need to make a measurable choice of $\Lambda_x < \operatorname{Aut}(Y_x, \eta_x)$ such that G_x is the centralizer of Λ_x inside $\operatorname{Aut}(Y_x, \eta_x)$. While it sounds plausible that such a measurable choice always exists, we were unable to prove this.

5 Closed groups of permutations of a countable set

We denote by S_{∞} the Polish group of all permutations of \mathbb{N} , equipped with the topology of pointwise convergence. The following result was already proven in [PV21, Corollary 8.2], but with the spectral methods of Section 3, we can give a considerably easier proof.

Theorem 5.1. Every closed subgroup of S_{∞} is a centralizer group.

The main point in proving Theorem 5.1 is the following lemma, which was obtained as [PV21, Lemma 8.6] and for which we give an easy spectral proof.

Lemma 5.2. Let (X_0, μ_0) be a standard nonatomic probability space. Put $(X, \mu) = (X_0, \mu_0)^{\mathbb{N}}$. We view $S_{\infty} < \operatorname{Aut}(X, \mu)$ by permuting the indices and we view $\operatorname{Aut}_{\operatorname{mp}}(X_0, \mu_0) < \operatorname{Aut}(X, \mu)$ as diagonal transformations.

In this way, S_{∞} and $\operatorname{Aut}_{\operatorname{mp}}(X_0, \mu_0)$ are ergodic subgroups of $\operatorname{Aut}(X, \mu)$ that are each other's centralizer inside $\operatorname{Aut}(X, \mu)$.

Proof. For ever $\alpha \in \operatorname{Aut}_{\mathrm{mp}}(X_0, \mu_0)$, we denote by $\varphi_{\alpha} \in \operatorname{Aut}_{\mathrm{mp}}(X, \mu)$ the diagonal transformation $(\varphi_{\alpha}(x))_n = \alpha(x_n)$. When α is a mixing transformation, φ_{α} is mixing. So, $\operatorname{Aut}_{\mathrm{mp}}(X_0, \mu_0)$ is an ergodic subgroup of $\operatorname{Aut}(X, \mu)$. Since $S_{\infty} < \operatorname{Aut}_{\mathrm{mp}}(X, \mu)$ contains a Bernoulli shift, also $S_{\infty} < \operatorname{Aut}_{\mathrm{mp}}(X, \mu)$ is an ergodic subgroup. To prove the lemma, it thus suffices to prove that S_{∞} and $\operatorname{Aut}_{\mathrm{mp}}(X_0, \mu_0)$ are each other's centralizer inside $\operatorname{Aut}_{\mathrm{mp}}(X, \mu)$.

First assume that $\varphi \in \operatorname{Aut}_{\mathrm{mp}}(X,\mu)$ commutes with S_{∞} . For every $k \in \mathbb{N}$, denote by $S_{\infty,k} < S_{\infty}$ the stabilizer of $k \in \mathbb{N}$. Since the action of $S_{\infty,k}$ on $(X_0,\mu_0)^{\mathbb{N}\setminus\{k\}}$ is ergodic and since φ commutes with all $S_{\infty,k}$, it follows that $\varphi = \prod_{k \in \mathbb{N}} \alpha_k$, where $\alpha_k \in \operatorname{Aut}_{\mathrm{mp}}(X_0,\mu_0)$. Since φ commutes with S_{∞} , it then follows that all α_k are equal. So, $\varphi = \varphi_{\alpha}$ for some $\alpha \in \operatorname{Aut}_{\mathrm{mp}}(X_0,\mu_0)$.

Conversely, assume that $\psi \in \operatorname{Aut}_{\mathrm{mp}}(X,\mu)$ commutes with all φ_{α} , $\alpha \in \operatorname{Aut}_{\mathrm{mp}}(X_0,\mu_0)$. For every $\beta \in \operatorname{Aut}_{\mathrm{mp}}(X,\mu)$, we denote by $U_{\beta} \in \mathcal{U}(L^2(X,\mu))$ the corresponding unitary operator. Below we prove that we may choose a sequence $\alpha_n \in \operatorname{Aut}_{\mathrm{mp}}(X_0,\mu_0)$ such that

$$U_{\alpha_n} \to P_{\mathbb{C}\cdot 1} + \frac{1}{2}P_{(\mathbb{C}\cdot 1)^{\perp}}$$
 weakly in $B(L^2(X_0, \mu_0))$. (5.1)

Write $\varphi_n = \varphi_{\alpha_n}$. We identity $L^2(X, \mu)$ with the infinite tensor product of the Hilbert spaces $L^2(X_0, \mu_0)$ w.r.t. the vector $1 \in L^2(X_0, \mu_0)$. For every finite subset $\mathcal{F} \subset \mathbb{N}$, we define the closed subspace $H_{\mathcal{F}} \subset L^2(X, \mu)$ by

$$H_{\mathcal{F}} = \overline{\operatorname{span}}\Big(\bigotimes_{i \in \mathcal{F}} (L^2(X_0, \mu_0) \ominus \mathbb{C}1)\Big) \subset L^2(X, \mu) .$$

Note that $H_{\mathcal{F}} \perp H_{\mathcal{F}'}$ when $\mathcal{F} \neq \mathcal{F}'$. For every $k \in \mathbb{N}$, we write

$$L_k = \bigoplus_{\mathcal{F}: |\mathcal{F}| = k} H_{\mathcal{F}}$$

with the convention that $L_0 = \mathbb{C}1$. It then follows from (5.1) that

$$U_{\varphi_n} \to \sum_{k=0}^{\infty} 2^{-k} P_{L_k}$$
 weakly in $B(L^2(X, \mu))$.

Since ψ commutes with all φ_{α} , we get that U_{ψ} commutes with all U_{φ_n} and hence also with its weak limit. It follows that $U_{\psi}(L_1) = L_1$.

Choose a Haar unitary $v: X_0 \to \mathbb{T}$ that generates $L^{\infty}(X_0, \mu_0)$, meaning that $v: X_0 \to \mathbb{T}$ is a measure preserving isomorphism from (X_0, μ_0) onto the circle with the Lebesgue measure. Denote by $\pi_i: L^2(X_0, \mu_0) \to L^2(X, \mu)$ the embedding as functions only depending on the *i*-th coordinate. Fix $i \in \mathbb{N}$. Define $w: X \to \mathbb{T}$ by $w(x) = v((\psi^{-1}(x))_i)$. So, $w = U_{\psi}(\pi_i(v))$ and because $U_{\psi}(L_1) = L_1$, we can uniquely write

$$w = \sum_{j \in \mathbb{N}} \pi_j(v_j)$$
 with $v_j \in L^2(X_0, \mu_0) \ominus \mathbb{C}1$ and L^2 -convergence.

Since $w^2 = U_{\psi}(\pi_i(v^2)) \in L_1$, it follows that for all $j \neq k$, $\pi_j(v_j)\pi_k(v_k) = 0$. Taking the $\|\cdot\|_2$ -norm, we get that $\|v_j\|_2 \|v_k\|_2 = \|\pi_j(v_j)\pi_k(v_k)\|_2 = 0$ for all $j \neq k$. We conclude that at

most one of the v_j is nonzero. So there is a unique $j \in \mathbb{N}$ and $v_j \in L^2(X_0, \mu_0) \oplus \mathbb{C}1$ such that $U_{\psi}(\pi_i(v)) = w = \pi_j(v_j)$. Since v generates $L^{\infty}(X_0, \mu_0)$, we get that $U_{\psi}(\pi_i(L^{\infty}(X_0, \mu_0))) \subset \pi_j(L^{\infty}(X_0, \mu_0))$. Since a similar argument holds for ψ^{-1} , we find a permutation $\sigma \in S_{\infty}$ and a family $\beta_i \in \operatorname{Aut}_{\mathrm{mp}}(X_0, \mu_0)$ such that $U_{\psi}(\pi_i(v)) = \pi_{\sigma(i)}(U_{\beta_i}(v))$ for all $i \in \mathbb{N}$ and $v \in L^{\infty}(X_0, \mu_0)$.

Expressing that ψ commutes with all φ_{α} , it follows that every β_i commutes with every $\alpha \in \operatorname{Aut}_{\mathrm{mp}}(X_0, \mu_0)$. So, $\beta_i = \operatorname{id}$ and we have proven that $\psi = \sigma$.

We still need to construct $\alpha_n \in \operatorname{Aut}_{\operatorname{mp}}(X_0, \mu_0)$ satisfying (5.1). We may realize (X_0, μ_0) as $(X_1 \times X_2, \mu_1 \times \mu_2)$, where $(X_1, \mu_1) = (\{0, 1\}^{\mathbb{Z}}, \nu^{\mathbb{Z}}), \ \nu(0) = \nu(1) = 1/2$ and (X_2, μ_2) is a nonatomic standard probability space. Choose a mixing $\gamma \in \operatorname{Aut}_{\operatorname{mp}}(X_2, \mu_2)$. Then define $\alpha_n \in \operatorname{Aut}_{\operatorname{mp}}(X_1 \times X_2, \mu_1 \times \mu_2)$ by

$$\alpha_n(x,y) = (x',y') \quad \text{with} \quad \begin{cases} (x',y') = (x,y) \text{ if } x_n = 0, \\ x'_k = x_{2n-k} \text{ for all } k \in \mathbb{Z} \text{ and } y' = \gamma^n(y) \text{ if } x_n = 1. \end{cases}$$

One easily checks (5.1).

We now repeat part of the proof of [PV21, Proposition 8.11] to prove Theorem 5.1 and use the opportunity to give a more self-contained argument.

Proof of Theorem 5.1. Fix a closed subgroup $G < S_{\infty}$. For every integer $n \geq 1$, denote by $I_{n,k} \subset \mathbb{N}^n$ an enumeration of the orbits of the diagonal action $G \cap \mathbb{N}^n$. Denote by λ the Lebesgue measure on the circle \mathbb{T} and define

$$(X,\mu) = (\mathbb{T},\lambda)^{\mathbb{N}} \times \prod_{n,k} (\mathbb{T},\lambda)^{I_{n,k}}.$$

Define the subgroup $\Lambda_0 < \operatorname{Aut_{mp}}(X,\mu)$ consisting of the diagonal transformations $\alpha^{\mathbb{N}} \times \operatorname{id}$, $\alpha \in \operatorname{Aut_{mp}}(\mathbb{T},\lambda)$, acting in the first factor of (X,μ) . Define $\Lambda_{n,k} < \operatorname{Aut_{mp}}(X,\mu)$ as the subgroup of all diagonal transformations $\alpha^{I_{n,k}}$, with $\alpha \in \operatorname{Aut_{mp}}(\mathbb{T},\lambda)$, that only act in the factor $(\mathbb{T},\lambda)^{I_{n,k}}$ and act as the identity elsewhere.

For every $x \in X$, we denote by $x_0 \in \mathbb{T}^{\mathbb{N}}$ and $x_{n,k} \in \mathbb{T}^{I_{n,k}}$ its natural coordinates. For every n, k and $1 \leq j \leq n$, define the transformation $\theta_{n,k,j} \in \operatorname{Aut}_{mp}(X,\mu)$ by

$$\theta_{n,k,j}(x_0,(x_{n',k'})_{n',k'}) = (x_0,(y_{n',k'})_{n',k'})$$

with
$$(y_{n',k'})_i = \begin{cases} (x_0)_{i_j} \cdot (x_{n,k})_i & \text{if } (n',k') = (n,k), \\ (x_{n',k'})_i & \text{if } (n',k') \neq (n,k). \end{cases}$$

Define $\Lambda < \operatorname{Aut}_{\mathrm{mp}}(X, \mu)$ as the subgroup generated by Λ_0 , all $\Lambda_{n,k}$ and all $\theta_{n,k,j}$. We prove the centralizer of Λ inside $\operatorname{Aut}_{\mathrm{mp}}(X, \mu)$ is isomorphic with G.

Fix a $\psi \in \operatorname{Aut}_{\mathrm{mp}}(X,\mu)$ that commutes with Λ . Since ψ commutes with all Λ_0 and $\Lambda_{n,k}$, by Lemma 5.2, we find permutations σ_0 of $\mathbb N$ and $\sigma_{n,k}$ of $I_{n,k}$ such that $\psi = \sigma_0 \times \prod_{n,k} \sigma_{n,k}$. Expressing that ψ commutes with all $\theta_{n,k,j}$, we get that $(\sigma_{n,k}(i))_j = \sigma_0(i_j)$ for all $i \in I_{n,k}$ and $1 \le j \le n$. This means that σ_0 is a permutation of $\mathbb N$ with the property that the permutation σ_0^n of $\mathbb N^n$ globally preserves all orbits of $G \curvearrowright \mathbb N^n$, for all $n \ge 1$, and that

$$\psi = \sigma_0 \times \prod_{n,k} \sigma_0^n |_{I_{n,k}} .$$

To conclude the proof of the theorem, it thus suffices to prove that such a permutation σ_0 must belong to G.

Take $i_1, \ldots, i_n \in \mathbb{N}$. Since σ_0^n globally preserves the orbits of $G \curvearrowright \mathbb{N}^n$, there exists a $g \in G$ such that $\sigma_0^n(i) = g \cdot i$. This means that $\sigma_0(i_j) = g \cdot i_j$ for all $j \in \{1, \ldots, n\}$. We have proven that σ_0 lies in the closure of G inside S_{∞} . Since G is a closed subgroup, it follows that $\sigma_0 \in G$.

Lemma 5.2 also gives immediately the following result. Given a compact second countable group K, recall that the group $\operatorname{Aut} K$ of automorphisms of K is a Polish group as a closed subgroup of the group of homeomorphisms of K.

Proposition 5.3. For every compact second countable group K, the automorphism group $\operatorname{Aut} K$ is a centralizer group.

Proof. Denote by λ the Haar probability measure on K. Write $(X, \mu) = (K, \lambda)^{\mathbb{N}}$. Denote by $\Lambda < \operatorname{Aut}_{\mathrm{mp}}(X, \mu)$ the subgroup generated by S_{∞} , acting by permuting the coordinates, and $\theta \in \operatorname{Aut}_{\mathrm{mp}}(X, \mu)$ given by

$$(\theta(x))_n = \begin{cases} x_1 x_2 & \text{if } n = 1, \\ x_n & \text{if } n \neq 1. \end{cases}$$

We prove that the centralizer of Λ inside $\operatorname{Aut_{mp}}(X,\mu)$ is isomorphic with $\operatorname{Aut} K$. Take $\psi \in \operatorname{Aut_{mp}}(X,\mu)$ that commutes with Λ . For every $\alpha \in \operatorname{Aut_{mp}}(K,\lambda)$ denote by $\varphi_{\alpha} \in \operatorname{Aut_{mp}}(X,\mu)$ its diagonal product. Since ψ commutes with S_{∞} by Lemma 5.2, we find $\alpha \in \operatorname{Aut_{mp}}(K,\Lambda)$ such that $\psi = \varphi_{\alpha}$. Since ψ commutes with θ , we get that $\alpha(xy) = \alpha(x)\alpha(y)$ for a.e. $(x,y) \in K \times K$. By [Zim84, Theorems B.2 and B.3], there is a unique $\beta \in \operatorname{Aut} K$ such that $\alpha(x) = \beta(x)$ for a.e. $x \in K$. Since conversely every automorphism of K preserves λ , we have identified the centralizer of Λ with $\operatorname{Aut} K$.
