# Extremal problems for star forests and cliques*

#### Abstract

Given a family of graphs $\mathcal{F}$, the Turán number $\operatorname{ex}(n, \mathcal{F})$ denotes the maximum number of edges in any $\mathcal{F}$-free graph on $n$ vertices. Recently, Alon and Frankl studied of maximum number of edges in an $n$-vertex $\left\{K_{k+1}, M_{s+1}\right\}$-free graph, where $K_{k+1}$ is a complete graph on $k+1$ vertices and $M_{s+1}$ is a matching of $s+1$ edges. They determined the exact value of $e x\left(n,\left\{K_{k+1}, M_{s+1}\right\}\right)$. In this paper, we extend the matching $M_{s+1}$ to star forest $(s+1) S_{l}$, and determine the exact value of $\operatorname{ex}\left(n,\left\{K_{k+1},(s+1) S_{l}\right\}\right)$ for sufficiently large enough $n$. Furthermore, all the extremal graphs are obtained.

## 1 Introduction

Let $G=(V, E)$ be a simple graph with vertex set $V=V(G)$ and edge set $E=E(G)$. Set $e(G)=|E(G)|$. If $u, v \in V(G)$ and $u v \in E(G)$, we say $u$ and $v$ are adjacent. Denote by $G[S]$ the graph induced by $S$, and denote by $G \backslash S$ the graph obtained from $G$ by deleting all vertices of $S$ and all edges incident with $S$. For $V_{1}, V_{2} \subseteq V(G), E\left(V_{1}, V_{2}\right)$ denotes the set of edges between $V_{1}$ and $V_{2}$ in $G$, and $e\left(V_{1}, V_{2}\right)=\left|E\left(V_{1}, V_{2}\right)\right|$.

Given a family of graphs $\mathcal{F}$, a graph $G$ is called $\mathcal{F}$-free if $G$ does not contain any copy of a graph in $\mathcal{F}$ as a subgraph. The Turán number of a family of graphs $\mathcal{F}$, denoted as ex $(n, \mathcal{F})$, is the maximum number of edges in an $\mathcal{F}$-free graph $G$ of order $n$. Denote by $\operatorname{EX}(n, \mathcal{F})$ the set of $\mathcal{F}$-free graphs with $\operatorname{ex}(n, \mathcal{F})$ edges and call a graph in $\operatorname{EX}(n, \mathcal{F})$ an extremal graph for $\mathcal{F}$.

[^0]Let $K_{r}$ denote the complete graph on $r$ vertices. A complete subgraph is called a clique. The $r$-vertex independent set is denoted by $\overline{K_{r}}$. Let $M_{s}$ denote the matching of $s$ edges, and $S_{l}$ denote the star on $l+1$ vertices. The Turán graph $T_{k}(n)$ is a complete multipartite graph formed by partitioning the set of $n$ vertices into $k$ subsets with size as equal as possible, and connecting two vertices by an edge if and only if they belong to different subsets. For two vertex disjoint graphs $G$ and $H$, we write $G \cup H$ for the union of $G$ and $H$. The join of $G$ and $H$, denoted by $G \vee H$, is the graph obtained by joining every vertex of $G$ to every vertex of $H$. We write $k$ disjoint copies of $H$ as $k H$.

Erdős and Gallai [2] determined $e x\left(n, M_{s+1}\right)$ for all positive integers $k$ and $n$. Lidický et al. [9] investigated the Turán number of a star forest, and determined the Turán number of a star forest for sufficiently large $n$. Lan et al. [7] gave $e x\left(n,(s+1) S_{l}\right)$ for $k, l \geq 1$ and $n$ is sufficiently large. Li et al. [8] determined $e x\left(n,(s+1) S_{l}\right)$ for all positive integers $k, l$ and $n$. Recently, Alon and Frankl [1] determined the exact value of $\operatorname{ex}\left(n,\left\{K_{k+1}, M_{s+1}\right\}\right)$.

Theorem 1.1. ([1]) For $n \geq 2 s+1$ and $k \geq 2$, $\operatorname{ex}\left(n,\left\{K_{k+1}, M_{s+1}\right\}\right)=\max \left\{e\left(T_{k}(2 s+\right.\right.$ 1)), $e(G(n, k))\}$ where $G(n, k)=T_{k-1}(s) \vee \overline{K_{n-s}}$.

Katona and Xiao [4] determined ex $\left(n,\left\{K_{k+1}, P_{l}\right\}\right)$ if $l>2 k+1$. For a graph $H$ with $\chi(H)>2$, Gerbner [3] determined ex $\left(n,\left\{H, M_{k+1}\right\}\right)$ apart from a constant additive term. Liu and Kang [6] obtained asymptotical result for $\operatorname{ex}\left(n,\left\{H, P_{l}\right\}\right)$.

In this paper, we extend $M_{s+1}$ to the star forest $(s+1) S_{l}$, we determine the exact value of $\operatorname{ex}\left(n,\left\{K_{k+1},(s+1) S_{l}\right\}\right)$. We will show the following lemma which claims that there exists a $K_{3}$-free extremal graph for $S_{l+1}$ on $n$ vertices.

Lemma 1.1. Let $l \geq 1$ and $n \geq l^{2}+2$.
(1) If $n$ is even, there exists an l-regular bipartite graph $\mathcal{R}$ on $n$ vertices whose two parts $V_{1}, V_{2}$ have size $\frac{n}{2}$.
(2) If $n$ is odd, there exists a $K_{3}$-free l-regular graph or a $K_{3}$-free almost l-regular graph $\mathcal{R}$ on $n$ vertices, and there is a partition $V(\mathcal{R})=V_{1} \cup V_{2}$ and a vertex $v_{0} \in V_{2}$ such that $\left|V_{1}\right|=\left\lfloor\frac{n}{2}\right\rfloor,\left|V_{2}\right|=\left\lceil\frac{n}{2}\right\rceil$ and $\mathcal{R}\left[V \backslash v_{0}\right]$ is a bipartite graph.

The partition $V(\mathcal{R})=V_{1} \cup V_{2}$ in Lemma 1.1 is called a good partition of $\mathcal{R}$ and $v_{0}$ is called an exceptional vertex of $\mathcal{R}$ when $n$ is odd. We construct two families of graphs $\mathcal{G}_{1}(s)$ and $\mathcal{G}_{2}(s)$ as follows. Let $\mathcal{R}$ be an $(n-s)$-vertex $(l-1)$-regular graph or almost $(l-1)$-regular graph in Lemma 1.1, $V_{1}, V_{2}$ be a good-partition of $\mathcal{R}$ and $v_{0}$ be the exceptional vertex of $\mathcal{R}$ when $n-s$ is odd. A graph in $\mathcal{G}_{1}(s)$ is obtained from $T_{2}(s)$ and $\mathcal{R}$ by joining every vertex in the larger part of $T_{2}(s)$ to every vertex in $V_{1}$ and joining every vertex in the other part of $T_{2}(s)$ to every
vertex in $V_{2}\left(V_{2} \backslash\left\{v_{0}\right\}\right)$ when $n-s$ is even (odd). Let $\mathcal{R}_{1}$ be a bipartite graph on $n-s$ vertices with bipartition $S, T$, where $|S|=\left\lceil\frac{n-s}{2}\right\rceil$ and $|T|=\left\lfloor\frac{n-s}{2}\right\rfloor$, and the degree of each vertex in $T$ is $l-1$ and the degree of each vertex in $S$ is not exceeding $l-1$. It is easily seen that graph $\mathcal{R}_{1}$ always exists from the proof of Lemma 1.1. A graph in $\mathcal{G}_{2}(s)$ is obtained from $T_{2}(s)$ and $\mathcal{R}_{1}$ by joining every vertex in the larger part of $T_{2}(s)$ to every vertex in $S$ and joining every vertex in the other part of $T_{2}(s)$ to every vertex in $T$.

Our main results are the following.
Theorem 1.2. Let $k \geq 3, l \geq 2, s \geq 0$ be integers and $n \geq k s^{2}+(s+1)(l+1)^{2}$. Then

$$
e x\left(n,\left\{K_{k+1},(s+1) S_{l}\right\}\right)=e\left(T_{k-2}(s)\right)+s(n-s)+\left\lfloor\frac{(l-1)(n-s)}{2}\right\rfloor .
$$

The graphs $T_{k-2}(s) \vee \mathcal{R}$ are the extremal graphs for $\left\{K_{k+1},(s+1) S_{l}\right\}$, where $\mathcal{R}$ is a $K_{3}$-free extremal graph for $S_{l}$ on $n-s$ vertices.

Theorem 1.3. Let $k=2$ and $n$ is large enough.
(1) If $l<s+1$, then

$$
\operatorname{ex}\left(n,\left\{K_{k+1},(s+1) S_{l}\right\}\right)=s(n-s)
$$

and $K_{s, n-s}$ is the unique extremal graph.
(2) If $l \geq s+1, n-s$ is even, then

$$
\operatorname{ex}\left(n,\left\{K_{k+1},(s+1) S_{l}\right\}\right)=\left\lceil\frac{s}{2}\right\rceil\left\lfloor\frac{s}{2}\right\rfloor+s\left\lfloor\frac{n-s}{2}\right\rfloor+\left\lfloor\frac{(l-1)(n-s)}{2}\right\rfloor,
$$

and $E X\left(n,\left\{K_{k+1},(s+1) S_{l}\right\}\right)=\mathcal{G}_{1}(s)$.
If $l \geq s+1, n-s$ is odd, then

$$
\begin{aligned}
\operatorname{ex}\left(n,\left\{K_{k+1},(s+1) S_{l}\right\}\right)= & \max \left\{\left\lceil\frac{s}{2}\right\rceil\left\lfloor\frac{s}{2}\right\rfloor+s\left\lfloor\frac{n-s}{2}\right\rfloor+\left\lfloor\frac{(l-1)(n-s)}{2}\right\rfloor,\right. \\
& \left.\left\lceil\frac{s}{2}\right\rceil\left\lfloor\frac{s}{2}\right\rfloor+s\left\lfloor\frac{n-s}{2}\right\rfloor+(l-1)\left\lfloor\frac{n-s}{2}\right\rfloor+\left\lceil\frac{s}{2}\right\rceil\right\},
\end{aligned}
$$

any extremal graph for $\left\{K_{k+1},(s+1) S_{l}\right\}$ is in $\mathcal{G}_{1}(s)$ or in $\mathcal{G}_{2}(s)$.

## 2 The Turán number of $\left\{K_{k+1},(s+1) S_{l}\right\}(k \geq 3)$

The following lemma is trivial.
Lemma 2.1. For any $l$ and $n \geq l^{2}+2$, ex $\left(n, S_{l+1}\right)=\left\lfloor\frac{l n}{2}\right\rfloor$. The $l$-regular graph or almost $l$-regular graph on $n$ vertices is an extremal graph for $S_{l+1}$.

Proof of Lemma 1.1. Given a vertex set $V$ of size $n$, we divide the vertex set $V$ into 2 balanced parts $V_{1}$ and $V_{2}$, where $\left|V_{1}\right|=\left\lfloor\frac{n}{2}\right\rfloor,\left|V_{2}\right|=\left\lceil\frac{n}{2}\right\rceil$. Let $\left\lfloor\frac{n}{2}\right\rfloor=m l+r,\left\lceil\frac{n}{2}\right\rceil=m l+r+c$, where $c=0$ if $n$ is even and $c=1$ if $n$ is odd, $0 \leq r<l$. Then we divide both $V_{1}$ and $V_{2}$ into $m+1$ parts, where each of the first $m$ parts contains $l$ vertices while the last part contains $r$ and $r+c$ vertices respectively. Let the parts be $V_{1,1}, \cdots, V_{1, m+1}$ and $V_{2,1}, \cdots, V_{2, m+1}$, i.e. $\left|V_{1, i}\right|=\left|V_{2, i}\right|=l, i \in[m]$ and $\left|V_{1, m+1}\right|=r,\left|V_{2, m+1}\right|=r+c$. We label the vertices in $V_{1, m+1}$ be $a_{1}, \cdots, a_{r}$, label the vertices in $V_{2, m+1}$ be $b_{1}, \cdots, b_{r}$ if $c=0$ and label the vertices in $V_{2, m+1}$ be $b_{1}, \cdots, b_{r}, v_{0}$ if $c=1$. Then we connect every vertex in $V_{1, i}$ to every vertex in $V_{2, i}$ for $i \in[m]$ and connect every $a_{i}, i=1, \cdots, r$ to every $b_{j}, j=1, \cdots, r$. Then for any $i \in[m], V_{1, i}$ and $V_{2, i}$ form an $l$-regular bipartite graph, $\left\{a_{1}, a_{2}, \cdots, a_{r}\right\}$ and $\left\{b_{1}, \cdots, b_{r}\right\}$ form an $r$-regular bipartite graph. Next we apply some changes to construct a $K_{3}$-free $l$-regular graph or a $K_{3}$-free almost $l$-regular graph.
(1) If $n$ is even, we select an edge $x y$ between $V_{1, i_{0}}$ and $V_{2, i_{0}}$ where $x \in V_{1, i_{0}}, y \in V_{2, i_{0}}$, $i_{0} \in[m]$. We delete $x y$ and add two edges $x b_{1}, y a_{1}$, then $x$ and $y$ remain degree $l$, the degrees of both $a_{1}$ and $b_{1}$ increase by 1 . By applying such an operation $l-r$ times, we change the degrees of both $a_{1}$ and $b_{1}$ from $r$ to $l$, and the degrees of other vertices remain the same. Since $n \geq l^{2}+2$, applying the similar operation for $\left(a_{i}, b_{i}\right), 2 \leq i \leq r$, we get an $l$-regular bipartite graph $\mathcal{R}$ on the vertex set $V_{1} \cup V_{2}$.
(2) If $n$ is odd, we choose an edge $x_{1} y_{1}$ between $V_{1, i_{1}}$ and $V_{2, i_{1}}, i_{1} \in[m]$, delete it and add two edges $x_{1} v_{0}$ and $y_{1} v_{0}$. Then $x_{1}$ and $y_{1}$ remain degree $l$, the degree of $v_{0}$ increases by 2 . If $l-2>2$, we choose an edge $x_{2} y_{2}$ between $V_{1, i_{2}}$ and $V_{2, i_{2}}$, where $i_{2} \in[m], i_{2} \neq i_{1}$. Since $n \geq l^{2}+2$, continue this operation $\left\lfloor\frac{l}{2}\right\rfloor$ times, we change the degree of $v_{0}$ from 0 to $l-1$ or $l$, and the degrees of other vertices remain the same. It is easy to check that the resulting graph $\mathcal{R}$ is a $K_{3}$-free $l$-regular graph or a $K_{3}$-free almost $l$-regular graph and $\mathcal{R}\left[V \backslash v_{0}\right]$ is a bipartite graph.

Proof of Theorem 1.2, We use induction on $s$. If $s=0$, by Lemmas 2.1 and 1.1 , $e x\left(n,\left\{K_{k+1}, S_{l}\right\}\right)=e x\left(n, S_{l}\right)=\left\lfloor\frac{(l-1) n}{2}\right\rfloor$, and a $K_{3}$-free $(l-1)$-regular graph or a $K_{3}$-free almost ( $l-1$ )-regular graph on $n$ vertices is an extremal graph for $\left\{K_{k+1}, S_{l}\right\}$. Now suppose the conclusion is true for $0 \leq s^{\prime} \leq s$. One can verify that $T_{k-2}(s) \vee \mathcal{R}$ is $\left\{K_{k+1},(s+1) S_{l}\right\}$-free, where $\mathcal{R}$ is a $K_{3}$-free $(l-1)$-regular graph or a $K_{3}$-free almost $(l-1)$-regular graph on $n-s$ vertices. Thus

$$
\begin{align*}
e x\left(n,\left\{K_{k+1},(s+1) S_{l}\right\}\right) & \geq e\left(T_{k-2}(s) \vee \mathcal{R}\right) \\
& =e\left(T_{k-2}(s)\right)+s(n-s)+\left\lfloor\frac{(l-1)(n-s)}{2}\right\rfloor . \tag{2.1}
\end{align*}
$$

Next we prove the upper bound. Let $\mathcal{G}$ be the set of $n$-vertex $\left\{K_{k+1},(s+1) S_{l}\right\}$-free graphs
which maximize the number of edges. For any graph $G$ in $\mathcal{G}$, we have the following claim.
Claim 1. There exists a vertex set $U \subseteq V(G)$ with size s such that $G[V \backslash U]$ is $S_{l}$-free.
Proof. By (2.1) and $n \geq k s^{2}+(s+1)(l+1)^{2}$, we have

$$
\begin{aligned}
e(G) & \geq e\left(T_{k-2}(s)\right)+s(n-s)+\left\lfloor\frac{(l-1)(n-s)}{2}\right\rfloor \\
& >e\left(T_{k-2}(s-1)\right)+(s-1)(n-s+1)+\left\lfloor\frac{(l-1)(n-s+1)}{2}\right\rfloor
\end{aligned}
$$

Combining with the induction hypothesis, we conclude that $G$ must contain a copy of $s S_{l}$. We denote it by $T_{0}$.

We choose an arbitrary copy of $S_{l}$ in $T_{0}$, say $K$. Note that $G \backslash V(K)$ is $s S_{l}$-free. By the induction hypothesis

$$
e(G \backslash V(K)) \leq e\left(T_{k-2}(s-1)\right)+(s-1)(n-s-l)+\left\lfloor\frac{(l-1)(n-s-l)}{2}\right\rfloor .
$$

Let $m_{0}$ be the number of edges incident to $V(K)$ in $G$. Then

$$
\begin{aligned}
m_{0}= & e(G)-e(G \backslash V(K)) \\
\geq & e\left(T_{k-2}(s)\right)+s(n-s)+\left\lfloor\frac{(l-1)(n-s)}{2}\right\rfloor \\
& -\left(e\left(T_{k-2}(s-1)\right)+(s-1)(n-s-l)+\left\lfloor\frac{(l-1)(n-s-l)}{2}\right\rfloor\right) \\
\geq & n-s
\end{aligned}
$$

which implies that each copy of $S_{l}$ in $T_{0}$ must contain a vertex of degree at least $\frac{n-s}{l+1}$. Let $U$ be the set of such a vertex from each $S_{l}$ in $T_{0}$, then $|U|=s$. We claim that $G[V \backslash U]$ is $S_{l}$-free. Otherwise, $G[V \backslash U]$ contains a copy of $S_{l}$, say $T$. Since $d(u) \geq \frac{n-s}{l+1}$ for any $u$ in $U$ and $n \geq k s^{2}+(s+1)(l+1)^{2}, G \backslash V(T)$ must contain a copy of $s S_{l}$. Then $G$ contains a copy of $(s+1) S_{l}$, a contradiction.

For two non-adjacent vertices $u$ and $v$ in $G$, if we delete the edges connecting $u$ to $N_{G}(u)$ and add new edges connecting $u$ to $N_{G}(v)$, we call such an operation as symmetrization and we say symmetrize $u$ to $v$. Let the resulting graph be $G_{u \rightarrow v}$. Then $V\left(G_{u \rightarrow v}\right)=V(G)$ and $E\left(G_{u \rightarrow v}\right)=\left(E(G) \backslash E\left(u, N_{G}(u)\right) \cup E\left(u, N_{G}(v)\right)\right.$.

We call two vertices $u$ and $v$ in $V(G)$ are equivalent if and only if $N_{G}(u)=N_{G}(v)$. Obviously, it is an equivalent relation. So the vertices in $U$ can be partitioned into equivalent classes and every equivalent class is an independent set. Among $\mathcal{G}$, we choose the graphs that minimize the
number of equivalent classes of $U$, and denote the family of such graphs by $\mathcal{G}^{\prime}$. For any graph $G$ in $\mathcal{G}^{\prime}$, we have the following claim.

Claim 2. Any two non-adjacent vertices of $U$ have the same neighborhood in $G$.

Proof. We first prove that when we do symmetrization for non-adjacent vertices in $U$, the resulting graph is still $\left\{K_{k+1},(s+1) S_{l}\right\}$-free. Suppose $u$ and $v$ are non-adjacent vertices in $U$, and we symmetrize $u$ to $v$, then $G_{u \rightarrow v}[V \backslash U]=G[V \backslash U]$. By Claim 四, $G_{u \rightarrow v}[V \backslash U]$ is $S_{l}$-free, then $G_{u \rightarrow v}$ is $(s+1) S_{l}$-free. Moreover, $G_{u \rightarrow v}$ is $K_{k+1}$-free. If $G_{u \rightarrow v}$ contains a copy of $K_{k+1}$, say $T$, then $T$ must contain $u$. Since $u$ and $v$ are non-adjacent, $(V(T) \backslash\{u\}) \cup\{v\}$ will induce a copy of $K_{k+1}$ in $G$, which contradicts the assumption that $G$ is $K_{k+1}$-free.

Next we claim that any non-adjacent vertices in $U$ have the same degree. Otherwise, without loss of generality, suppose $u$ and $v$ are non-adjacent vertices in $U$ but $d(u)<d(v)$. Then we symmetrize $u$ to $v, G_{u \rightarrow v}$ is still $\left\{K_{k+1},(s+1) S_{l}\right\}$-free and $e\left(G_{u \rightarrow v}\right)=e(G)-d(u)+d(v)>e(G)$, which contradicts the assumption that $G \in \mathcal{G}$.

Suppose there exists non-adjacent vertices $u$ and $v$ in $U$ with $N_{G}(u) \neq N_{G}(v)$, then $u$ and $v$ must belong to different equivalent classes $W_{1}$ and $W_{2}$. Since $W_{1}$ is an independent set, for any vertex $w$ in $W_{1}, d(w)=d(u)=d(v)$. We symmetrize all the vertices in $W_{1}$ to $v$ one by one, and denote the resulting graph by $G^{\prime}$, then $e(G)=e\left(G^{\prime}\right)$ and $G^{\prime}$ is still $\left\{K_{k+1},(s+1) S_{l}\right\}$-free. However, in this case $W_{1}$ and $W_{2}$ become one equivalent class in $G^{\prime}$, so the number of equivalent classes decreases, which contradicts the assumption that $G \in \mathcal{G}^{\prime}$.

By Claim 2, we conclude that $G[U]$ is a complete $m$-partite graph. Let the vertex partition of $G[U]$ be $V_{1}, \cdots, V_{m}$, and $\left|V_{1}\right| \geq \cdots \geq\left|V_{m}\right|>0$. Since $G[U]$ is $K_{k+1}$-free, $m \leq k$. For any vertex $v$ in $V \backslash U$, if $v$ is adjacent to one vertex in some $V_{i}, i \in[m]$, then $v$ is adjacent to all the vertices in $V_{i}$ by Claim 2, For each $V_{i}$, we denote by $N_{G[V \backslash U]}\left(V_{i}\right)$ the common neighborhood of vertices of $V_{i}$ in $G[V \backslash U]$, and $d_{G[V \backslash U]}\left(V_{i}\right)=\left|N_{G[V \backslash U]}\left(V_{i}\right)\right|$.

Next we show that $m=k-2$.
Claim 3. $m=k-2$.

Proof. We first show that $m \geq k-2$. Otherwise, $m \leq k-3$. By Claim $\mathbb{1}, e(G[V \backslash U]) \leq$
$\left\lfloor\frac{(l-1)(n-s)}{2}\right\rfloor$. Then we have

$$
\begin{aligned}
e(G) & =e(G[U])+e(U, V \backslash U)+e(G[V \backslash U]) \\
& \leq e\left(T_{m}(s)\right)+s(n-s)+\left\lfloor\frac{(l-1)(n-s)}{2}\right\rfloor \\
& \leq e\left(T_{k-3}(s)\right)+s(n-s)+\left\lfloor\frac{(l-1)(n-s)}{2}\right\rfloor \\
& <e\left(T_{k-2}(s)\right)+s(n-s)+\left\lfloor\frac{(l-1)(n-s)}{2}\right\rfloor \\
& \leq e(G)
\end{aligned}
$$

a contradiction.
If $m=k-1$, we claim that there exists a part $V_{i_{0}}$ in $U$ such that $d_{G[V \backslash U]}\left(V_{i_{0}}\right) \leq \frac{k-1}{k}(n-s)$. Otherwise, for any $j \in[m-1], d_{G[V \backslash U]}\left(V_{j}\right)>\frac{k-1}{k}(n-s)$. This implies that for each $V_{j}$, there are at most $\frac{1}{k}(n-s)$ vertices in $V \backslash U$ which are not the common neighbor of $V_{j}$. Then the fact $m=k-1$ implies that there are at least $\frac{1}{k}(n-s)$ vertices in $V \backslash U$ which are adjacent to all vertices in $U$. Let the set of such vertices be $Q$. So $|Q| \geq \frac{1}{k}(n-s)$. We claim that $Q$ is an independent set of $G$. Otherwise, an edge from $G[Q]$ and a vertex in each $V_{j}, j \in[k-1]$ will form a copy of $K_{k+1}$, a contradiction. So $e(G[Q])=0$. Next we show that $|Q| \leq \frac{k-1}{k}(n-s)$. Otherwise, $V \backslash U$ can be partitioned into two parts, one is $Q$ with size at least $\frac{k-1}{k}(n-s)$ and another is $V \backslash(U \cup Q)$ with size at most $\frac{1}{k}(n-s)$. According to Claim 1 and the fact $Q$ is an independent set of $G$, we get

$$
\begin{aligned}
e(G) & =e(G[U])+e(U, V \backslash U)+e(G[V \backslash U]) \\
& \leq e\left(T_{k-1}(s)\right)+s(n-s)+\frac{1}{k}(l-1)(n-s) \\
& <e\left(T_{k-2}(s)\right)+s(n-s)+\left\lfloor\frac{(l-1)(n-s)}{2}\right\rfloor \\
& \leq e(G)
\end{aligned}
$$

for $n \geq k s^{2}+(s+1)(l+1)^{2}$, a contradiction. So $\frac{1}{k}(n-s) \leq|Q| \leq \frac{k-1}{k}(n-s)$. Thus

$$
\begin{aligned}
e(G) & =e(G[U])+e(U, V \backslash U)+e(G[V \backslash U]) \\
& =e(G[U])+e(U, V \backslash(U \cup Q))+e(U, Q)+e(G[V \backslash U]) \\
& \leq e\left(T_{k-1}(s)\right)+\left(s-\left|V_{k-1}\right|\right)(n-s-|Q|)+s|Q|+e x\left(n-s, S_{l}\right) \\
& \leq e\left(T_{k-1}(s)\right)+\left(s-\left|V_{k-1}\right|\right)(n-s)+\left|V_{k-1}\right||Q|+\left\lfloor\frac{(l-1)(n-s)}{2}\right\rfloor \\
& <e\left(T_{k-2}(s)\right)+s(n-s)+\left\lfloor\frac{(l-1)(n-s)}{2}\right\rfloor \\
& \leq e(G)
\end{aligned}
$$

for $n \geq k s^{2}+(s+1)(l+1)^{2}$, a contradiction. Therefore there exists a $V_{i_{0}}, 1 \leq i_{0} \leq m-1$, such that $d_{G[V \backslash U]}\left(V_{i_{0}}\right) \leq \frac{k-1}{k}(n-s)$. Then

$$
\begin{aligned}
e(G) & =e(G[U])+e(U, V \backslash U)+e(G[V \backslash U]) \\
& \leq e\left(T_{k-1}(s)\right)+\left(s-\left|V_{i_{0}}\right|\right)(n-s)+\frac{k-1}{k}\left|V_{i_{0}}\right|(n-s)+\left\lfloor\frac{(l-1)(n-s)}{2}\right\rfloor \\
& <e\left(T_{k-2}(s)\right)+s(n-s)+\left\lfloor\frac{(l-1)(n-s)}{2}\right\rfloor \\
& \leq e(G)
\end{aligned}
$$

for $n \geq k s^{2}+(s+1)(l+1)^{2}$, a contradiction.
If $m=k$, we claim that there exists a part $V_{i_{0}}, 1 \leq i_{0} \leq m$, in $U$ such that $d_{G[V \backslash U]}\left(V_{i_{0}}\right) \leq$ $\frac{k}{k+1}(n-s)$. Otherwise, $d_{G[V \backslash U]}\left(V_{j}\right)>\frac{k}{k+1}(n-s)$ for any $j \in[k]$. This implies that for each $V_{j}$, there are at most $\frac{1}{k+1}(n-s)$ vertices in $V \backslash U$ which are not the common neighbor of $V_{j}$. Then the fact $m=k$ implies that there are at least $\frac{1}{k+1}(n-s)$ vertices in $V \backslash U$ which are adjacent to all vertices in $U$. Let the set of such vertices be $Q$. So $|Q| \geq \frac{1}{k+1}(n-s)$. However, a vertex in $Q$ and a vertex from each $V_{j}, j \in[k]$ will form a copy of $K_{k+1}$, a contradiction. Therefore there exists a $V_{i_{0}}$ in $U$ such that $d_{G[V \backslash U]}\left(V_{i_{0}}\right) \leq \frac{k}{k+1}(n-s)$. Then

$$
\begin{aligned}
e(G) & =e(G[U])+e(U, V \backslash U)+e(G[V \backslash U]) \\
& \leq e\left(T_{k}(s)\right)+\left(s-\left|V_{i_{0}}\right|\right)(n-s)+\frac{k}{k+1}\left|V_{i_{0}}\right|(n-s)+\left\lfloor\frac{(l-1)(n-s)}{2}\right\rfloor \\
& <e\left(T_{k-2}(s)\right)+s(n-s)+\left\lfloor\frac{(l-1)(n-s)}{2}\right\rfloor \\
& \leq e(G)
\end{aligned}
$$

for $n \geq k s^{2}+(s+1)(l+1)^{2}$, a contradiction.
By Claim 3 and (2.1), we conclude that $e x\left(n,\left\{K_{k+1},(s+1) S_{l}\right\}\right)=e\left(T_{k-2}(s)\right)+s(n-s)+$ $\left\lfloor\frac{(l-1)(n-s)}{2}\right\rfloor$, and $T_{k-2}(s) \vee \mathcal{R}$ are extremal graphs for $\left\{K_{k+1},(s+1) S_{l}\right\}$, where $\mathcal{R}$ is a $K_{3}$-free extremal graph for $S_{l}$ on $n-s$ vertices. This finishes the proof.

## 3 The Turán number of $\left\{K_{3},(s+1) S_{l}\right\}$

Let $G_{1}(s)$ and $G_{2}(s)$ be graphs in $\mathcal{G}_{1}(s)$ and $\mathcal{G}_{2}(s)$ respectively. Obviously, graphs $K_{s, n-s}, G_{1}(s)$ and $G_{2}(s)$ all are $\left\{K_{3},(s+1) S_{l}\right\}$-free,

$$
\begin{aligned}
& e\left(G_{1}(s)\right)=\left\lceil\frac{s}{2}\right\rceil\left\lfloor\frac{s}{2}\right\rfloor+s\left\lfloor\frac{n-s}{2}\right\rfloor+\left\lfloor\frac{(l-1)(n-s)}{2}\right\rfloor, \\
& e\left(G_{2}(s)\right)=\left\lceil\frac{s}{2}\right\rceil\left\lfloor\frac{s}{2}\right\rfloor+(l-1)\left\lfloor\frac{n-s}{2}\right\rfloor+\left\lfloor\frac{s}{2}\right\rfloor\left\lfloor\frac{n-s}{2}\right\rfloor+\left\lceil\frac{s}{2}\right\rceil\left\lceil\frac{n-s}{2}\right\rceil,
\end{aligned}
$$

and $\mathcal{G}_{1}(s)=\mathcal{G}_{2}(s)$ if $n-s$ is even.
Proof of Theorem 1.3. We will show $\operatorname{ex}\left(n,\left\{K_{3},(s+1) S_{l}\right\}\right)=\max \left\{e\left(K_{s, n-s}\right), e\left(G_{1}(s)\right), e\left(G_{2}(s)\right)\right\}$. Since $K_{s, n-s}, G_{1}(s)$ and $G_{2}(s)$ are $\left\{K_{3},(s+1) S_{l}\right\}$-free,

$$
\begin{equation*}
\operatorname{ex}\left(n,\left\{K_{3},(s+1) S_{l}\right\}\right) \geq \max \left\{e\left(K_{s, n-s}\right), e\left(G_{1}(s)\right), e\left(G_{2}(s)\right)\right\} . \tag{3.1}
\end{equation*}
$$

Next we use induction on $s$ to prove ex $\left(n,\left\{K_{3},(s+1) S_{l}\right\}\right) \leq \max \left\{e\left(K_{s, n-s}\right), e\left(G_{1}(s)\right), e\left(G_{2}(s)\right)\right\}$. If $s=0$, by Lemmas 2.1 and 1.1,

$$
\operatorname{ex}\left(n,\left\{K_{3},(s+1) S_{l}\right\}\right)=e\left(G_{1}(0)\right) \leq \max \left\{e\left(K_{0, n}\right), e\left(G_{1}(0)\right), e\left(G_{2}(0)\right)\right\}
$$

Now suppose the conclusion is true for $0 \leq s^{\prime} \leq s$.
Let $\mathcal{G}$ be the set of $n$-vertex $\left\{K_{3},(s+1) S_{l}\right\}$-free graphs which maximize the number of edges. For any graph $G$ in $\mathcal{G}$, we have the following claim.

Claim 4. There exists a vertex set $U \subseteq V(G)$ with size s such that $G[V \backslash U]$ is $S_{l}$-free.

Proof. By (3.1) and the induction hypothesis, we have

$$
\begin{aligned}
e(G) & \geq \max \left\{e\left(K_{s, n-s}\right), e\left(G_{1}(s)\right), e\left(G_{2}(s)\right)\right\} \\
& >\max \left\{e\left(K_{s-1, n-s+1}\right), e\left(G_{1}(s-1)\right), e\left(G_{2}(s-1)\right)\right\} \\
& \geq \operatorname{ex}\left(n,\left\{K_{3}, s S_{l}\right\}\right)
\end{aligned}
$$

Then $G$ contains a copy of $s S_{l}$. We denote it by $T_{1}$.
We choose an arbitrary copy of $S_{l}$ in $T_{1}$, say $K_{1}$. Note that $G \backslash V\left(K_{1}\right)$ is $\left\{K_{3}, s S_{l}\right\}$-free. By the induction hypothesis, we have

$$
\begin{equation*}
e\left(G \backslash V\left(K_{1}\right)\right) \leq \max \left\{e\left(K_{s-1, n-s+1}\right), e\left(G_{1}(s-1)\right), e\left(G_{2}(s-1)\right)\right\} \tag{3.2}
\end{equation*}
$$

Let $m_{1}$ be the number of edges incident to $V\left(K_{1}\right)$ in $G$. Combining (3.1) and (3.2), we get

$$
\begin{aligned}
m_{1} & =e(G)-e\left(G \backslash V\left(K_{1}\right)\right) \\
& \geq \max \left\{e\left(K_{s, n-s}\right), e\left(G_{1}(s)\right), e\left(G_{2}(s)\right)\right\}-\max \left\{e\left(K_{s-1, n-s+1}\right), e\left(G_{1}(s-1)\right), e\left(G_{2}(s-1)\right)\right\} \\
& \geq \min \left\{e\left(K_{s, n-s}\right)-e\left(K_{s-1, n-s+1}\right), e\left(G_{1}(s)\right)-e\left(G_{1}(s-1)\right), e\left(G_{2}(s)\right)-e\left(G_{2}(s-1)\right)\right\} \\
& \geq \frac{n}{2}+O(1),
\end{aligned}
$$

which implies that each copy of $S_{l}$ in $T_{1}$ must contain a vertex of degree at least $q=\frac{1}{2(l+1)} n+$ $O(1)$. Let $U$ be the set of such a vertex from each copy of $S_{l}$ in $T_{1}$. Then $|U|=s$ and $G[V \backslash U]$ is $S_{l}$-free.

Using the approach of Symmetrization as in the proof of Theorem 1.2, we can prove that $G[U]$ is a complete $m$-partite graph. Moreover, since $G[U]$ is $K_{3}$-free, $m \leq 2$. Let $U_{1}$ be the larger part in $G[U]$ and $U_{2}=U \backslash U_{1},\left|U_{1}\right|=x$ and $\left|U_{2}\right|=y$. Obviously, $\left\lfloor\frac{s}{2}\right\rfloor \geq y \geq 0$. We use $I$ to denote the maximum independent set in $G[V \backslash U]$.

Claim 5. If $|I| \leq\left\lfloor\frac{n-s}{2}\right\rfloor$, then $e(G) \leq e\left(G_{1}(s)\right)$.
Proof. Since $G$ is $K_{3}$-free, the neighborhood of each vertex in $U$ is an independent set. Thus the number of edges between $U$ and $V \backslash U$ is at most $s|I|$. Notice that $G[V \backslash U]$ is $S_{l}$-free, we have $e(G[V \backslash U]) \leq\left\lfloor\frac{(l-1)(n-s)}{2}\right\rfloor$ by Lemma 2.1. Hence

$$
\begin{align*}
e(G) & \leq e(G[U])+e(U, V \backslash U)+e(G[V \backslash U]) \\
& \leq\left\lceil\frac{s}{2}\right\rceil\left\lfloor\frac{s}{2}\right\rfloor+s|I|+\left\lfloor\frac{(l-1)(n-s)}{2}\right\rfloor \\
& \leq\left\lceil\frac{s}{2}\right\rceil\left\lfloor\frac{s}{2}\right\rfloor+s\left\lfloor\frac{n-s}{2}\right\rfloor+\left\lfloor\frac{(l-1)(n-s)}{2}\right\rfloor \\
& =e\left(G_{1}(s)\right) . \tag{3.3}
\end{align*}
$$

Claim 6. If $|I|>\left\lfloor\frac{n-s}{2}\right\rfloor$, then

$$
e(G) \leq s|I|+(l-1)(n-s-|I|)+y(n-2|I|-y) .
$$

Proof. Since $I$ is the maximum independent set in $G[V \backslash U]$ and $G[V \backslash U]$ is $S_{l}$-free,

$$
\begin{equation*}
e(G[V \backslash U]) \leq(l-1)(n-s-|I|) \tag{3.4}
\end{equation*}
$$

Let $I_{u}$ be the neighborhood of vertex $u \in U$ in $G[V \backslash U]$. Then $I_{u_{1}} \bigcap I_{u_{2}}=\emptyset$ for any vertex $u_{1}$ in $U_{1}$ and any vertex $u_{2}$ in $U_{2}$. Otherwise, we can find a $K_{3}$ copy, a contradiction. This implies that $\left|I_{u_{1}}\right|+\left|I_{u_{2}}\right| \leq n-s$. Let $\left|I_{1}\right|=\max _{u \in U_{1}} I_{u}$ and $\left|I_{2}\right|=\max _{u \in U_{2}} I_{u}$. Then $\left|I_{1}\right|+\left|I_{2}\right| \leq n-s$. So

$$
\begin{align*}
e(U, V \backslash U) & =\sum_{u \in U_{1}} d_{G[V \backslash U]}(u)+\sum_{v \in U_{2}} d_{G[V \backslash U]}(v) \\
& =\sum_{u \in U_{1}}\left|I_{u}\right|+\sum_{v \in U_{2}}\left|I_{v}\right| \\
& \leq x\left|I_{1}\right|+y\left|I_{2}\right| \\
& \leq x\left|I_{1}\right|+y\left(n-s-\left|I_{1}\right|\right) \\
& \leq(x-y)|I|+y(n-s) . \tag{3.5}
\end{align*}
$$

By (3.4) and (3.5), we get

$$
\begin{aligned}
e(G) & \leq e(G[U])+e(U, V \backslash U)+e(G[V \backslash U]) \\
& \leq x y+(x-y)|I|+y(n-s)+(l-1)(n-s-|I|) \\
& =s|I|+(l-1)(n-s-|I|)+y(n-2|I|-y)
\end{aligned}
$$

Claim 7. If $|I|>\left\lfloor\frac{n-s}{2}\right\rfloor$ and $n$ is large enough, then the following statements holds.
(1) If $l \geq s+1$ and $n-s$ is even, then

$$
\operatorname{ex}\left(n,\left\{K_{3},(s+1) S_{l}\right\}\right) \leq e\left(G_{1}(s)\right)
$$

If $l \geq s+1$ and $n-s$ is odd, then

$$
\operatorname{ex}\left(n,\left\{K_{3},(s+1) S_{l}\right\}\right) \leq e\left(G_{2}(s)\right)
$$

(2) If $l<s+1$, then

$$
\operatorname{ex}\left(n,\left\{K_{3},(s+1) S_{l}\right\}\right) \leq e\left(K_{s, n-s}\right)
$$

Proof. Let $t=n-2|I|$. Applying Claim 6, we obtain

$$
\begin{equation*}
e(G) \leq s|I|+(l-1)(n-s-|I|)+y(t-y) \tag{3.6}
\end{equation*}
$$

Invoking the facts $|I|>\left\lfloor\frac{n-s}{2}\right\rfloor$ and $n \geq s+|I|$, we get $-n+2 s \leq t \leq s-1$.
(1) For the case $l \geq s+1$, if $t<0$, we obtain from (3.6) that

$$
\begin{aligned}
e(G) & \leq s|I|+(l-1)(n-s-|I|) \\
& \leq(l-1)(n-s)+(s-l+1)\left(\left\lfloor\frac{n-s}{2}\right\rfloor+1\right) \\
& <e\left(G_{2}(s)\right)
\end{aligned}
$$

If $0 \leq t \leq s-1$ and $n-s$ is even, by (3.6), we get

$$
\begin{aligned}
e(G) & \leq(l-1)(n-s)+(s-l+1)|I|+\left\lceil\frac{t}{2}\right\rceil\left\lfloor\frac{t}{2}\right\rfloor \\
& <\left\lceil\frac{s}{2}\right\rceil\left\lfloor\frac{s}{2}\right\rfloor+(l-1)(n-s)+(s-l+1)\left(\frac{n-s}{2}+1\right) \\
& =\left\lceil\frac{s}{2}\right\rceil\left\lfloor\frac{s}{2}\right\rfloor+s \frac{n-s}{2}+(l-1) \frac{n-s}{2}+(s-l+1) \\
& \leq\left\lceil\frac{s}{2}\right\rceil\left\lfloor\frac{s}{2}\right\rfloor+s \frac{n-s}{2}+\frac{(l-1)(n-s)}{2} \\
& =e\left(G_{1}(s)\right)
\end{aligned}
$$

If $0 \leq t \leq s-1$ and $n-s$ is odd, combining with (3.6), we deduce

$$
\begin{align*}
e(G) & \leq(l-1)(n-s)+(s-l+1)\left(\left\lfloor\frac{n-s}{2}\right\rfloor+1\right)+\left\lceil\frac{s-1}{2}\right\rceil\left\lfloor\frac{s-1}{2}\right\rfloor \\
& =\left\lceil\frac{s}{2}\right\rceil\left\lfloor\frac{s}{2}\right\rfloor+s-\left\lfloor\frac{s}{2}\right\rfloor+s\left\lfloor\frac{n-s}{2}\right\rfloor+(l-1)\left(n-s-\left\lfloor\frac{n-s}{2}\right\rfloor-1\right) \\
& =\left\lceil\frac{s}{2}\right\rceil\left\lfloor\frac{s}{2}\right\rfloor+s\left\lfloor\frac{n-s}{2}\right\rfloor+(l-1)\left\lfloor\frac{n-s}{2}\right\rfloor+\left\lceil\frac{s}{2}\right\rceil \\
& =e\left(G_{2}(s)\right) . \tag{3.7}
\end{align*}
$$

(2) For the case $l<s+1$, if $t<0$, it follows from (3.6) that

$$
\begin{align*}
e(G) & \leq(l-1)(n-s)+(s-l+1)|I| \\
& \leq s(n-s) . \tag{3.8}
\end{align*}
$$

If $0 \leq t \leq s-1$, notice that $|I|=\frac{n-t}{2}$, we obtain

$$
\begin{aligned}
e(G) & \leq(l-1)(n-s)+(s-l+1) \frac{n-t}{2}+\left\lceil\frac{s}{2}\right\rceil\left\lfloor\frac{s}{2}\right\rfloor \\
& \leq \frac{s+l-1}{2} n+\left\lceil\frac{s}{2}\right\rceil\left\lfloor\frac{s}{2}\right\rfloor \\
& <s(n-s)
\end{aligned}
$$

for sufficiently large $n$.

Using Claims 5 and 7, we deduce

$$
\operatorname{ex}\left(n,\left\{K_{3},(s+1) S_{l}\right\}\right) \leq \max \left\{e\left(K_{s, n-s}\right), e\left(G_{1}(s)\right), e\left(G_{2}(s)\right)\right\}
$$

Combining with (3.1), we get

$$
\operatorname{ex}\left(n,\left\{K_{3},(s+1) S_{l}\right\}\right)=\max \left\{e\left(K_{s, n-s}\right), e\left(G_{1}(s)\right), e\left(G_{2}(s)\right)\right\} .
$$

To be more specific,
(1) If $l<s+1$ and $n$ is large enough, then

$$
\begin{aligned}
\operatorname{ex}\left(n,\left\{K_{3},(s+1) S_{l}\right\}\right) & =\max \left\{e\left(K_{s, n-s}\right), e\left(G_{1}(s)\right), e\left(G_{2}(s)\right)\right\} \\
& =s(n-s)
\end{aligned}
$$

Furthermore, according to the proofs of Claims 5and 7 we deduce that $e(G)=s(n-s)$ if and only if the equality in (3.8) holds, which implies that $|I|=n-s$ and $y=0$. Then $G \cong K_{s, n-s}$, hence $K_{s, n-s}$ is the unique extremal graph.
(2) If $l \geq s+1$ and $n$ is large enough, then

$$
\begin{aligned}
\operatorname{ex}\left(n,\left\{K_{3},(s+1) S_{l}\right\}\right) & =\max \left\{e\left(K_{s, n-s}\right), e\left(G_{1}(s)\right), e\left(G_{2}(s)\right)\right\} \\
& =\max \left\{e\left(G_{1}(s)\right), e\left(G_{2}(s)\right)\right\} .
\end{aligned}
$$

When $n-s$ is even, then

$$
\begin{aligned}
\operatorname{ex}\left(n,\left\{K_{3},(s+1) S_{l}\right\}\right) & =\max \left\{e\left(G_{1}(s)\right), e\left(G_{2}(s)\right)\right\} \\
& =e\left(G_{1}(s)\right)=e\left(G_{2}(s)\right)
\end{aligned}
$$

Furthermore, we can see from the proofs of Claims 5 and 7 that $e(G)=e\left(G_{1}(s)\right)$ if and only if the equality in (3.3) holds, which implies that $G$ is a graph in $\mathcal{G}_{1}(s)$.

When $n-s$ is odd, then

$$
\operatorname{ex}\left(n,\left\{K_{3},(s+1) S_{l}\right\}\right)=\max \left\{e\left(G_{1}(s)\right), e\left(G_{2}(s)\right)\right\} .
$$

Furthermore, it follows from the proofs of Claims 5 and 7 that $e(G)=\max \left\{e\left(G_{1}(s)\right), e\left(G_{2}(s)\right)\right\}$ if and only if the equality in (3.3) or the equality in (3.7) holds, which implies that $G$ is a graph in $\mathcal{G}_{1}(s)$ or a graph in $\mathcal{G}_{2}(s)$. The proof is finished.
