

POLYNOMIAL FOURIER DECAY FOR PATTERSON-SULLIVAN MEASURES

ABSTRACT. We show that the Fourier transform of Patterson-Sullivan measures associated to convex cocompact groups of isometries of real hyperbolic space decays polynomially quickly at infinity. The proof is based on the L^2 -flattening theorem obtained in [16] combined with a method based on dynamical self-similarity for ruling out the sparse set of potential frequencies where the Fourier transform can be large.

1. INTRODUCTION

1.1. Background. The Fourier transform of a Borel probability measure μ on \mathbb{R}^d is defined as follows:

$$\hat{\mu}(\xi) := \int_{\mathbb{R}^d} e^{2\pi i \langle \xi, x \rangle} d\mu(x), \quad \xi \in \mathbb{R}^d. \quad (1.1)$$

We say μ has *polynomial Fourier decay* if $|\hat{\mu}(\xi)| = O(\|\xi\|^{-\kappa})$ for some $\kappa > 0$ as $\|\xi\| \rightarrow \infty$.

Rates of decay of Fourier transforms of dynamically defined measures have been extensively studied in recent years. Beyond its intrinsic interest, this question has found many applications in other areas of mathematics; e.g. essential spectral gaps on hyperbolic manifolds [14, 8, 19], the uniqueness problem [21], quantum chaos and fractal uncertainty principles [13], Diophantine approximation [12], and geometric measure theory [33, 22] to name a few.

Moreover, the problem has motivated the development of many methods drawing on a wide varying tools ranging from spectral gaps of the underlying dynamics [4, 7], to renewal theory [18], sum-product phenomena [8, 19, 17], large deviation estimates for Fourier transforms [23, 1, 6], as well as many related developments; cf. [3, 2, 15, 32, 21, 20, 35, 10] for a non-exhaustive list. We refer the reader to the survey [31] for a comprehensive account of the history and recent developments in the subject.

A common strategy that is implicit in many of the aforementioned results proceeds as follows:

- (1) Find a mechanism to show that the Fourier transform has the desired rate of decay for a large set of frequencies ξ .
- (2) Use the dynamics (or the multiscale/convolution structure of μ) to express the Fourier transform of μ at frequency ξ as an *average* of Fourier transforms of (scaled copies of) μ at images of ξ by the dynamics.
- (3) Show (through non-linearity of/Diophantine conditions on the dynamics) that images of ξ by the dynamics are reasonably well-distributed in the space in such a way that they avoid the potential exceptional set of frequencies arising in Step 1.

To demonstrate this strategy, consider the following basic estimate towards Step 1: if μ satisfies the Frostman condition $\mu(B(x, r)) \lesssim r^\alpha$ for some $\alpha > 0$ and all balls of radius $r \geq 0$, then the Fourier transform decays like $\|\xi\|^{-\alpha/2}$ *on average*, i.e.

$$\int_{\|\xi\| \leq R} |\hat{\mu}(\xi)|^2 d\xi \lesssim R^{d-\alpha}, \quad \forall R \geq 1. \quad (1.2)$$

This estimate roughly means that the exceptional set of potentially problematic frequencies have (box) dimension at most $d - \alpha$; cf. [22, Section 3.8]. Hence, we can obtain Fourier decay as soon as we can show that the frequencies produced in Step 2 have dimension $> d - \alpha$. Since the image of ξ

under the dynamics tends to have a similar dimension to the support of μ itself, this procedure is sufficient for establishing Fourier decay in many situations when the dimension of the support of μ is $> d/2$.

However, in general, the estimate (1.2) is rather weak when $\alpha \leq d/2$. In that case, more involved methods are necessary to either produce stronger estimates in Step 1 (e.g. large deviations methods) or to produce better averaging and well-distribution schemes in Steps 2 and 3 (e.g. spectral gap and renewal theory methods).

Recently, a very general estimate towards Step 1 was obtained in [16, Corollary 11.5] under natural non-concentration hypotheses on the (not necessarily dynamically defined) measure μ . Namely, it is shown¹ that if μ does not concentrate near proper affine subspaces of \mathbb{R}^d at many scales, then its Fourier transform decays polynomially outside of a very sparse set of frequencies, i.e. for all $\varepsilon > 0$, there is $\delta > 0$ such that:

$$\left| \left\{ \|\xi\| \leq R : |\hat{\mu}(\xi)| > R^{-\delta} \right\} \right| = O(R^\varepsilon). \quad (1.3)$$

The goal of this article is to show that (1.3) can be used in conjunction with the strategy outlined above to give efficient proofs of quantitative Fourier decay of dynamically defined measures. We apply our method to a particular class of interest in applications, namely that of Patterson-Sullivan measures for convex cocompact groups of isometries of real hyperbolic space. Since the non-concentration conditions implying (1.3) are known to hold for large classes of dynamically-defined measures², we hope the simplicity of the method presented here will allow it to be extended to yield Fourier decay results in much broader contexts.

1.2. Main result. Let Γ be a discrete, Zariski-dense, convex cocompact, group of isometries of real hyperbolic space \mathbb{H}^{d+1} , $d \geq 1$. Let Λ_Γ be the limit set of Γ on $\partial\mathbb{H}^{d+1}$ and μ be the Patterson-Sullivan probability measure on Λ_Γ associated to Γ ; cf. Section 2 for detailed definitions. The following is the main result of this article.

Theorem 1.1. *There exists $\kappa > 0$ such that the following holds for all $\varphi \in C^2$, $\psi \in C^1$ satisfying*

$$\|\varphi\|_{C^2} + \|\psi\|_{C^1} \leq A, \quad \inf_{x \in \Lambda_\Gamma} \|\nabla_x \varphi\| > a,$$

for some constants $a > 0$ and $A \geq 1$. There exists a constant $C = C(A, a, \mu) \geq 1$, so that for all $\lambda \neq 0$, we have

$$\left| \int_{\Lambda_\Gamma} e^{2\pi i \lambda \varphi(x)} \psi(x) d\mu(x) \right| \leq C |\lambda|^{-\kappa}.$$

Remark 1.2. Our proof shows that the rate κ provided by Theorem 1.1 depends only on non-concentration parameters of μ ; cf. Section 2.6 for the precise definition of non-concentration. In particular, the rate of decay does not change upon replacing Γ by a finite index subgroup since the measure μ remains the same in this case [29].

Theorem 1.1 generalizes prior work of Bourgain and Dyatlov in the case of hyperbolic surfaces [8] and of Li, Naud, and Pan in the case of Schottky hyperbolic 3-manifolds [19]. These prior results are based on Bourgain's sum-product theorem, while the proof of Theorem 1.1 is based on the estimate (1.3), which was obtained using purely additive methods.

To keep the presentation clear, we restricted our setup to the case of convex cocompact groups. Using the recurrence results obtained in [16], the proof of Theorem 1.1 can be adapted to handle the general case of geometrically finite manifolds.

By the work of Dyatlov and Zahl [14], Theorem 1.1 is known to imply spectral bounds on the resolvent of the Laplace operator which yield an *essential spectral gap*³ for the resolvent as well as Selberg’s zeta function. Moreover, the size of the essential spectral gap obtained this way depends explicitly on the decay rate κ in Theorem 1.1. In particular, Theorem 1.1 implies that the resolvent admits a uniform essential spectral gap over all finite covers of \mathbb{H}^{d+1}/Γ ; cf. Remark 1.2. We note that this essential spectral gap result was obtained independently in [5] by different methods and an essential gap of size depending on Γ was obtained previously in [24, 27].

2. PRELIMINARIES

2.1. Convex cocompact manifolds. The standard reference for the material in this section is [9]. Let G denote the group of orientation preserving isometries of real hyperbolic space, denoted \mathbb{H}^{d+1} , of dimension $d \geq 1$. In particular, $G \cong \mathrm{SO}(d+1, 1)^0$.

Fix a basepoint $o \in \mathbb{H}^{d+1}$. Then, G acts transitively on \mathbb{H}^{d+1} and the stabilizer K of o is a maximal compact subgroup of G . We shall identify \mathbb{H}^{d+1} with $K \backslash G$. Denote by $A = \{g_t : t \in \mathbb{R}\}$ a one parameter subgroup of G inducing the geodesic flow on the unit tangent bundle of \mathbb{H}^{d+1} . Let $M < K$ denote the centralizer of A inside K so that the unit tangent bundle $T^1\mathbb{H}^{d+1}$ may be identified with $M \backslash G$. In Hopf coordinates, we can identify $T^1\mathbb{H}^{d+1}$ with $\mathbb{R} \times (\partial\mathbb{H}^{d+1} \times \partial\mathbb{H}^{d+1} \setminus \Delta)$, where $\partial\mathbb{H}^{d+1}$ denotes the boundary at infinity and Δ denotes the diagonal.

Let $\Gamma < G$ be an infinite discrete subgroup of G . The limit set of Γ , denoted Λ_Γ , is the set of limit points of the orbit $\Gamma \cdot o$ on $\partial\mathbb{H}^{d+1}$. Note that the discreteness of Γ implies that all such limit points belong to the boundary. Moreover, this definition is independent of the choice of o in view of the negative curvature of \mathbb{H}^{d+1} . We often use Λ to denote Λ_Γ when Γ is understood from context. We say Γ is *non-elementary* if Λ_Γ is infinite.

The *non-wandering set* for the geodesic flow is the closure of the set of vectors in the unit tangent bundle whose orbit accumulates on itself. In Hopf coordinates, this set, denoted Ω , coincides with the projection of $\mathbb{R} \times (\Lambda_\Gamma \times \Lambda_\Gamma - \Delta) \bmod \Gamma$. We say \mathbb{H}^{d+1}/Γ is *convex cocompact* if Ω is compact, cf. [9]. Denote by N^+ the expanding horospherical subgroup of G associated to g_t , $t \geq 0$.

Given $g \in G$, we denote by g^+ the coset of P^-g in the quotient $P^- \backslash G$, where $P^- = N^-AM$ is the stable parabolic group associated to $\{g_t : t \geq 0\}$. Similarly, g^- denotes the coset P^+g in $P^+ \backslash G$. Since M is contained in P^\pm , such a definition makes sense for vectors in the unit tangent bundle $M \backslash G$. Geometrically, for $v \in M \backslash G$, v^+ (resp. v^-) is the forward (resp. backward) endpoint of the geodesic determined by v on the boundary of \mathbb{H}^{d+1} . Given $x \in G/\Gamma$, we say x^\pm belongs to Λ if the same holds for any representative of x in G ; this notion being well-defined since Λ is Γ invariant.

Notation. Throughout the remainder of the article, we fix a discrete, Zariski-dense, convex cocompact group Γ of isometries of \mathbb{H}^{d+1} .

2.2. Patterson-Sullivan measures. The *critical exponent*, denoted δ_Γ , is defined to be the infimum over all real number $s \geq 0$ such that the Poincaré series

$$P_\Gamma(s, o) := \sum_{\gamma \in \Gamma} e^{-sd(o, \gamma \cdot o)} \tag{2.1}$$

converges. This exponent coincides with the Hausdorff dimension of the limit set as well as the topological entropy of the geodesic flow on the quotient orbifold \mathbb{H}^{d+1}/Γ . We shall simply write δ for δ_Γ when Γ is understood from context.

The *Busemann function* is defined as follows: given $x, y \in \mathbb{H}^{d+1}$ and $\xi \in \partial\mathbb{H}^{d+1}$, let $\gamma : [0, \infty) \rightarrow \mathbb{H}^{d+1}$ denote a geodesic ray terminating at ξ and define

$$\beta_\xi(x, y) = \lim_{t \rightarrow \infty} \text{dist}(x, \gamma(t)) - \text{dist}(y, \gamma(t)).$$

A Γ -invariant conformal density of dimension s is a collection of Radon measures $\{\nu_x\}$ on the boundary indexed by $x \in \mathbb{H}^{d+1}$ which satisfy the following equivariance property:

$$\gamma_*\nu_x = \nu_{\gamma x}, \quad \text{and} \quad \frac{d\nu_y}{d\nu_x}(\xi) = e^{-s\beta_\xi(x, y)}, \quad \forall x, y \in \mathbb{H}^{d+1}, \xi \in \partial\mathbb{H}^{d+1}, \gamma \in \Gamma.$$

Patterson [25] and Sullivan [34] showed the existence of a unique (up to scaling) Γ -invariant conformal density of dimension δ_Γ , denoted $\{\mu_x^{\text{PS}} : x \in \mathbb{H}^{d+1}\}$. These measures are known as the *Patterson-Sullivan measures*. We refer the reader to [28] and [26] and references therein for details of the construction in much greater generality.

2.3. Stable and unstable foliations and leafwise measures. Recall that we fixed a basepoint $o \in \mathbb{H}^{d+1}$. In what follows, we use the following notation for pullbacks of the Patterson-Sullivan measures to orbits of N^+ under the visual map:

$$d\mu_x^u(n) = e^{\delta_\Gamma \beta_{(nx)^+}(o, nx)} d\mu_o^{\text{PS}}((nx)^+). \quad (2.2)$$

These measures have simpler transformation formulas under the action of the geodesic flow and N^+ which makes them relatively easier to analyze than the Patterson-Sullivan measures directly. In particular, they satisfy the following equivariance property under the geodesic flow:

$$\mu_{g_t x}^u = e^{\delta t} \text{Ad}(g_t)_* \mu_x^u. \quad (2.3)$$

Moreover, it follows readily from the definitions that for all $n \in N^+$,

$$(n)_* \mu_{nx}^u = \mu_x^u, \quad (2.4)$$

where $(n)_* \mu_{nx}^u$ is the pushforward of μ_{nx}^u under the map $u \mapsto un$ from N^+ to itself. Finally, since M normalizes N^+ , these conditionals are $\text{Ad}(M)$ -invariant in the sense that for all $m \in M$,

$$\mu_{mx}^u = \text{Ad}(m)_* \mu_x^u. \quad (2.5)$$

2.4. Local stable holonomy. In this Section, we recall the definition of (stable) holonomy maps which are essential for our arguments. We give a simplified discussion of this topic which is sufficient in our homogeneous setting homogeneous. Let $x = u^- y$ for some $y \in \Omega$ and $u^- \in N_2^-$. Since the product map $N^- \times A \times M \times N^+ \rightarrow G$ is a diffeomorphism near identity, we can choose the norm on the Lie algebra so that the following holds. We can find maps $p^- : N_1^+ \rightarrow P^- = N^- AM$ and $u^+ : N_2^+ \rightarrow N^+$ so that

$$nu^- = p^-(n)u^+(n), \quad \forall n \in N_2^+. \quad (2.6)$$

Then, it follows by (2.2) that for all $n \in N_2^+$, we have

$$d\mu_y^u(u^+(n)) = e^{\delta \beta_{(nx)^+}(u^+(n)y, nx)} d\mu_x^u(n).$$

Moreover, by further scaling the metrics if necessary, we can ensure that these maps are diffeomorphisms onto their images. In particular, writing $\Phi(nx) = u^+(n)y$, we obtain the following change of variables formula: for all $f \in C(N_2^+)$,

$$\int f(n) d\mu_x^u(n) = \int f((u^+)^{-1}(n)) e^{-\delta \beta_{\Phi^{-1}(ny)}(ny, \Phi^{-1}(ny))} d\mu_y^u(n). \quad (2.7)$$

Remark 2.1. To avoid cluttering the notation with auxiliary constants, we shall assume that the N^- component of $p^-(n)$ belongs to N_2^- for all $n \in N_2^+$ whenever u^- belongs to N_1^- .

2.5. Notational convention. Throughout the article, given two quantities A and B , we use the Vinogradov notation $A \ll B$ to mean that there exists a constant $C \geq 1$, possibly depending on Γ and the dimension of G , such that $|A| \leq CB$. In particular, this dependence on Γ is suppressed in all of our implicit constants, except when we wish to emphasize it. The dependence on Γ may include for instance the diameter of the complement of our choice of cusp neighborhoods inside Ω and the volume of the unit neighborhood of Ω . We write $A \ll_{x,y} B$ to indicate that the implicit constant depends parameters x and y . We also write $A = O_x(B)$ to mean $A \ll_x B$.

2.6. The L^2 -flattening theorem. In light of the formula (2.2), Theorem 1.1 amounts to studying the Fourier transform of the measures μ_x^u . Moreover, the isomorphism $N^+ \cong \mathbb{R}^d$ allows us to view these measures as living on Euclidean space.

The key ingredient in the proof of Theorem 1.1 is [16, Corollary 1.8] which relates Fourier decay properties of measures on Euclidean space to the non-concentration properties of such measures near proper affine subspaces. This result in particular implies that PS measures enjoy polynomial Fourier decay outside of a very sparse set of frequencies.

We formulate here a special case of the aforementioned result which suffices for convex cocompact manifolds and refer the reader to [16, Theorem 11.5] for a more general result that holds in the presence of cusps.

Definition 2.2. We say that Borel measure μ on \mathbb{R}^d is *uniformly affinely non-concentrated* if for every $\varepsilon > 0$, there exists $\delta(\varepsilon) > 0$ so that $\delta(\varepsilon) \rightarrow 0$ as $\varepsilon \rightarrow 0$ and for all $x \in \mathbb{R}^d$, $0 < r \leq 1$, and every affine hyperplane $W < \mathbb{R}^d$, we have

$$\mu(W^{(\varepsilon r)} \cap B(x, r)) \leq \delta(\varepsilon)\mu(B(x, r)), \tag{2.8}$$

where $W^{(r)}$ and $B(x, r)$ denote the r -neighborhood of W and the r -ball around x respectively. We refer to $\delta(\varepsilon)$ as *the non-concentration parameters* of μ .

Theorem 2.3 ([16, Corollary 1.8]). *Let μ be a compactly supported Borel probability measure on \mathbb{R}^d which is uniformly affinely non-concentrated and denote by $\hat{\mu}$ its Fourier transform. Then, for every $\varepsilon > 0$, there is $\delta > 0$ such that for all $T \geq 1$,*

$$\left| \left\{ \|\xi\| \leq T : |\hat{\mu}(\xi)| > T^{-\delta} \right\} \right| = O_\varepsilon(T^\varepsilon),$$

where $|\cdot|$ denotes the Lebesgue measure on \mathbb{R}^d . The implicit constant depends only on the non-concentration parameters of μ and the diameter of its support.

We note that Theorem 2.3 was obtained by different methods for measures on the real line in [30].

We will be able to apply Theorem 1.1 to PS measures (or, more precisely, their shadows μ_x^u) thanks to the following proposition.

Proposition 2.4 ([16, Corollary 12.2]). *For every $x \in N_1^- \Omega$, the measure $\mu_x^u \Big|_{N_1^+}$ is uniformly affinely non-concentrated in the sense of Definition 2.2, with uniform parameters in x .*

Remark 2.5. It is shown in [16, Corollary 12.2] that the non-concentration parameters of μ_x^u depend only on the injectivity radius at x , which is in turn uniformly bounded above and below on a neighborhood of the non-wandering set Ω due to convex cocompactness of Γ .

3. PROOF OF THEOREM 1.1

The goal of this section is to provide the proof of Theorem 1.1. In light of the formula (2.2), it suffices to prove polynomial Fourier decay for the measures μ_x^u for x in the non-wandering set Ω .

Norms and Lie algebras. In what follows, we denote by \mathfrak{n}^+ and \mathfrak{n}^- the Lie algebras of N^+ and N^- respectively. We fix an isomorphism of \mathfrak{n}^+ and \mathfrak{n}^- using a Cartan involution sending g_t to g_{-t} . Moreover, we fix an isomorphism of \mathfrak{n}^+ (and hence of \mathfrak{n}^-) with \mathbb{R}^d . Finally, we fix a Euclidean inner product on $\mathbb{R}^d \cong \mathfrak{n}^+ \cong \mathfrak{n}^-$ denoted with $\langle \cdot, \cdot \rangle$ which is invariant by the Adjoint action of the group $M \cong \mathrm{SO}_d(\mathbb{R})$.

Reduction to linear phases. We begin with the following elementary lemma which reduces the proof to the study of linear phase functions. Its proof based on using a partition of unity on the support of the integral and Taylor expanding the phase function. The details are left to the reader.

Lemma 3.1. *To prove Theorem 1.1, it suffices to show that there exists $\kappa > 0$ so that for all $0 \neq \xi \in \mathbb{R}^d$, $x \in \Omega$, and $\psi \in C_c^1(N_1^+)$, we have*

$$\int_{N_1^+} e^{i\langle \xi, n \rangle} \psi(n) d\mu_x^u(n) \ll_{\Gamma} \|\psi\|_{C^1} \|\xi\|^{-\kappa}, \quad (3.1)$$

where, by abuse of notation, if $n = \exp(v)$ for some $v \in \mathfrak{n}^+ \cong \mathbb{R}^d$, we let $\langle \xi, n \rangle := \langle \xi, v \rangle$.

In the remainder of this section, we fix $\xi \in \mathbb{R}^d$ and $\psi \in C_c^1(N_1^+)$. Our goal is to prove the estimate (3.1).

Partitions of unity and flow boxes. Let ι denote the smaller of 1 and the injectivity radius of Ω and set

$$\iota_{\xi} := \iota / \|\xi\|^{1/3}. \quad (3.2)$$

We let \mathcal{P}_{ξ} denote a partition of unity of the unit neighborhood of Ω so that each $\rho \in \mathcal{P}_{\xi}$ is M -invariant and supported inside a flow box B_{ρ} of radius⁴ ι_{ξ} . With the aid of the Vitali covering lemma, we can arrange for the collection $\{B_{\rho}\}$ to have a uniformly bounded multiplicity, depending only on the dimension of G . We can choose such a partition of unity so that for all $\rho \in \mathcal{P}_{\xi}$,

$$\|\rho\|_{C^1} \ll \iota_{\xi}^{-1}. \quad (3.3)$$

We also introduce the following subcollection of \mathcal{P}_{ξ} :

$$\mathcal{P}_{\xi}^0 := \left\{ \rho \in \mathcal{P}_{\xi} : B_{\rho} \cap N_{1/2}^- \Omega \neq \emptyset \right\}. \quad (3.4)$$

Note that the cardinality of \mathcal{P}_{ξ}^0 can be bounded as follows. Indeed, since Γ is geometrically finite, the unit neighborhood of Ω has finite volume. Moreover, the flow boxes B_{ρ} with $\rho \in \mathcal{P}_{\xi}^0$ are all contained in such a unit neighborhood and have uniformly bounded multiplicity; cf. (3.4). Finally, each B_{ρ} has radius ι_{ξ} for all $\rho \in \mathcal{P}_{\xi}$. Thus, letting $D \in \mathbb{N}$ be such that the Lebesgue measure of B_{ρ} is $\asymp \iota_{\xi}^D$, we see that

$$\#\mathcal{P}_{\xi}^0 \ll_{\Gamma} \iota_{\xi}^{-(2D+1)}. \quad (3.5)$$

Note that the dimension of X is $2D + 1 + \dim(M)$, however the bound above involves $2D + 1$ only since each flow box is M -invariant.

Transversals. We fix a system of transversals $\{T_{\rho}\}$ to the strong unstable foliation inside the boxes B_{ρ} . Since B_{ρ} meets $N_{1/2}^- \Omega$ for all $\rho \in \mathcal{P}_{\xi}^0$, we fix some y_{ρ} in the intersection $B_{\rho} \cap N_{1/2}^- \Omega$. In this notation, we can find neighborhoods of identity $P_{\rho}^- \subset P^- = MAN^-$ and $N_{\rho}^+ \subset N^+$ such that

$$B_{\rho} = N_{\rho}^+ P_{\rho}^- \cdot y_{\rho}, \quad T_{\rho} = P_{\rho}^- \cdot y_{\rho}. \quad (3.6)$$

We also let M_{ρ}, A_{ρ} , and N_{ρ}^- be neighborhoods of identity in M, A and N^- respectively so that $P_{\rho}^- = M_{\rho} A_{\rho} N_{\rho}^-$.

Time smoothing. Let $T > 0$ be a large parameter to be chosen depending on $\|\xi\|$. Let $q : \mathbb{R} \rightarrow [0, 1]$ be a smooth bump function supported in the interval $(T - 1, T + 1)$ and having the property

$$\int_{\mathbb{R}} q(t) dt = 1. \quad (3.7)$$

Using our partition of unity, we can write

$$\int_{N_1^+} e^{i\langle \xi, n \rangle} \psi(n) d\mu_x^u(n) = \int_{\mathbb{R}} q(t) \sum_{\rho \in \mathcal{P}_\xi} \int_{N_1^+} e^{i\langle \xi, n \rangle} \psi(n) \rho(g_t n x) d\mu_x^u(n) dt. \quad (3.8)$$

Saturation and post-localization. Fix some arbitrary $t > 0$. Our first step is to partition the integral in (3.8) over N_1^+ into pieces according to the flow box they land in under flowing by g_t . To simplify notation, we write

$$x_t := g_t x. \quad (3.9)$$

We denote by $N_1^+(t)$ a neighborhood of N_1^+ defined by the property that the intersection

$$B_\rho \cap (\text{Ad}(g_t)(N_1^+(t)) \cdot x_t)$$

consists entirely of full local strong unstable leaves in B_ρ . We note that since $\text{Ad}(g_t)$ expands N^+ and B_ρ has radius < 1 , $N_1^+(t)$ is contained inside N_2^+ . Since ϕ is supported inside N_1^+ , we have

$$\chi_{N_1^+}(n) \psi(n) = \chi_{N_1^+(t)}(n) \psi(n), \quad \forall n \in N^+. \quad (3.10)$$

For simplicity, we set

$$\xi_t := e^{-t} \xi, \quad \psi_t(n) := \psi(\text{Ad}(g_t)^{-1} n), \quad \mathcal{A}_t := \text{Ad}(g_t)(N_1^+(t)).$$

For $\rho \in \mathcal{P}_\xi$, we let $\mathcal{W}_{\rho, t}$ denote the collection of connected components of the set

$$\{n \in \mathcal{A}_t : n x_t \in B_\rho\}.$$

Moreover, since $x \in \Omega$, we see that the the restriction of the support of μ_x^u to N_1^+ consists of points $n \in N^+$ with $n x \in \Omega$. This implies that the non-zero summands in the right side of (3.8) necessarily correspond to those ρ in \mathcal{P}_ξ^0 .

In view of (3.10), changing variables using (2.3) yields

$$\begin{aligned} \sum_{\rho \in \mathcal{P}_\xi} \int_{N_1^+} e^{i\langle \xi, n \rangle} \psi(n) \rho(g_{s+t} n x) d\mu_x^u(n) \\ = e^{-\delta t} \sum_{\rho \in \mathcal{P}_\xi^0, W \in \mathcal{W}_{\rho, t}} \int_{n \in W} e^{i\langle \xi_t, n \rangle} \psi_t(n) \rho(n x_t) d\mu_{x_t}^u(n). \end{aligned} \quad (3.11)$$

Centering the integrals. It will be convenient to center all the integrals in (3.11) so that their basepoints belong to the transversals T_ρ of the respective flow box B_ρ ; cf. (3.6).

Let $I_{\rho, t}$ denote an index set for $\mathcal{W}_{\rho, t}$. For $W \in \mathcal{W}_{\rho, t}$ with index $\ell \in I_{\rho, t}$, let $n_{\rho, \ell} \in W$, $m_{\rho, \ell} \in M_\rho$, $n_{\rho, \ell}^- \in N_\rho^-$, and $t_{\rho, \ell} \in (-\iota_\xi, \iota_\xi)$ be such that

$$x_{\rho, \ell} := n_{\rho, \ell} \cdot x_t = n_{\rho, \ell}^- m_{\rho, \ell} g_{t_{\rho, \ell}} \cdot y_\rho \in T_\rho. \quad (3.12)$$

Note that since x belongs to Ω and $y_\rho \in N_{1/2}^- \Omega$, we have that

$$x_{\rho, \ell} \in \Omega. \quad (3.13)$$

For each such ℓ and W , let us denote $W_\ell = W n_{\rho, \ell}^{-1}$ and set

$$\tilde{\psi}_{\rho, \ell}(t, n) := \psi_t(n n_{\rho, \ell}), \quad \tilde{\chi}_{\rho, \ell}(t, n) := \exp(i\langle \xi_t, n n_{\rho, \ell} \rangle). \quad (3.14)$$

Changing variables using (2.3) and (2.4), we can rewrite the right side of (3.11) as follows:

$$\begin{aligned} e^{-\delta t} \sum_{\rho \in \mathcal{P}_\xi^0, W \in \mathcal{W}_{\rho,t}} \int_{n \in W} e^{i\langle \xi t, n \rangle} \psi_t(n) \rho(nx_t) d\mu_{x_t}^u(n) \\ = e^{-\delta t} \sum_{\rho \in \mathcal{P}_\xi^0} \sum_{\ell \in I_{\rho,t}} \int_{n \in W_\ell} \tilde{\chi}_{\rho,\ell}(t,n) \tilde{\psi}_{\rho,\ell}(t,n) \rho(nx_{\rho,\ell}) d\mu_{x_{\rho,\ell}}^u(n). \end{aligned} \quad (3.15)$$

Weak-stable holonomy. Fix some $\rho \in \mathcal{P}_\xi^0$. Recall the points $y_\rho \in T_\rho$ and $n_{\rho,\ell}^- \in N_\rho^-$ satisfying (3.12). Let

$$p_{\rho,\ell}^- := n_{\rho,\ell}^- m_{\rho,\ell} g_{t_{\rho,\ell}}. \quad (3.16)$$

The product map $M \times N^- \times A \times N^+ \rightarrow G$ is a diffeomorphism on a ball of radius 1 around identity; cf. Section 2.4. Hence, given $\ell \in I_{\rho,t}$, we can define maps ϕ_ℓ and \tilde{p}_ℓ^- from W_ℓ to N^+ and P^- respectively by the following formula

$$np_{\rho,\ell}^- = \tilde{p}_\ell^-(n) \phi_\ell(n). \quad (3.17)$$

We suppress the dependence on ρ and t to ease notation. Then, ϕ_ℓ induces a map between the strong unstable manifolds of $x_{\rho,\ell}$ and y_ρ , also denoted ϕ_ℓ , and defined by

$$\phi_\ell(nx_{\rho,\ell}) = \phi_\ell(n)y_\rho.$$

In particular, this induced map coincides with the local weak stable holonomy map inside B_ρ .

Note that we can find a neighborhood $W_\rho \subset N^+$ of identity of radius $\asymp \iota_\xi$ such that

$$\phi_\ell(W_\ell) \subseteq W_\rho, \quad (3.18)$$

for all $\ell \in I_{\rho,t}$. Moreover, by shrinking the radius ι_ξ of the flow boxes by an absolute amount (depending only on the metric on G) if necessary, we may assume that all the maps ϕ_ℓ are invertible on W_ρ . Hence, we can define the following:

$$\begin{aligned} p_\ell^-(n) &:= \tilde{p}_\ell^-(\phi_\ell^{-1}(n)) \in P^-, & \tilde{\psi}_{\rho,\ell}(t,n) &:= J\phi_\ell(n) \times \tilde{\psi}_{\rho,\ell}(t, \phi_\ell^{-1}(n)), \\ \chi_{\rho,\ell}(t,n) &:= \tilde{\chi}_{\rho,\ell}(t, \phi_\ell^{-1}(n)), & \rho_\ell(n) &:= \rho(p_\ell^-(n) n y_\rho), \end{aligned} \quad (3.19)$$

where $J\phi_\ell$ denotes the Jacobian of the change of variable ϕ_ℓ ; cf. (2.7).

Changing variables in the right side of (3.15), we obtain

$$\sum_{\ell \in I_{\rho,t}} \int_{n \in W_\ell} \tilde{\chi}_{\rho,\ell}(t,n) \tilde{\psi}_{\rho,\ell}(t,n) \rho(nx_{\rho,\ell}) d\mu_{x_{\rho,\ell}}^u(n) = \sum_{\ell \in I_{\rho,t}} \int_{W_\rho} \chi_{\rho,\ell}(t,n) \tilde{\psi}_{\rho,\ell}(t,n) \rho_\ell(n) d\mu_{y_\rho}^u(n). \quad (3.20)$$

Linearizing the phase. We have the following formula for the functions ϕ_ℓ which are responsible for the oscillation of $\chi_{\rho,\ell}$ along N^+ . The elementary proof of this lemma is given in Section 4.

Lemma 3.2. *Let $p_{\rho,\ell}^-$ be as in (3.16) and let $w_{\rho,\ell} \in \mathfrak{n}^-$ be such that $n_{\rho,\ell}^- = \exp(w_{\rho,\ell})$. Then, for every $n = \exp(v) \in N_{1/2}^+$, we have*

$$\log \phi_\ell(n) = \frac{1}{e^{t_{\rho,\ell}} \tilde{\lambda}_\ell(v)} m_{\rho,\ell}^{-1} \cdot \left(v + \frac{\|v\|^2}{2} w_{\rho,\ell} \right),$$

where $\log \phi_\ell(n)$ is viewed as an element of \mathfrak{n}^+ and $\lambda_\ell : N_{1/2}^+ \rightarrow \mathbb{R}_+$ is given by

$$\tilde{\lambda}_\ell(v) = 1 + \langle v, w_{\rho,\ell} \rangle + \frac{\|v\|^2 \|w_{\rho,\ell}\|^2}{4}.$$

This lemma implies the following linearization estimate.

Corollary 3.3. *With the same notation as in Lemma 3.2, we have for all $n = \exp(v) \in W_\rho$ that*

$$\chi_{\rho,\ell}(t, n) = \alpha_{\rho,\ell}(t - t_{\rho,\ell}, n) + O(e^{-t}),$$

where

$$\alpha_{\rho,\ell}(t, n) := \exp(i\lambda_\ell(v)\langle \xi_t, m_{\rho,\ell} \cdot v \rangle), \quad \lambda_\ell(v) = 1 + \langle v, w_{\rho,\ell} \rangle. \quad (3.21)$$

Proof. Indeed, Lemma 3.2 implies that

$$v = \frac{1}{e^{t_{\rho,\ell}} \tilde{\lambda}_\ell(v)} m_{\rho,\ell}^{-1} \cdot \left(\phi_\ell^{-1}(v) + \frac{\|\phi_\ell^{-1}(v)\|^2}{2} w_{\rho,\ell} \right),$$

where we use $\phi_\ell^{-1}(v)$ to denote $\log \phi_\ell^{-1}(\exp(v))$ for simplicity. Since W_ρ and the flow boxes B_ρ have radii $\asymp \iota_\xi$, we have that $\phi_\ell^{-1}(v)$ and $w_{\rho,\ell}$ both have size $\ll \iota_\xi$. Similarly, we see that $\tilde{\lambda}_\ell(v) = \lambda_\ell(v) + O(e^{-t})$. Remembering that $\xi_t = e^{-t}\xi$ so that $e^{t_{\rho,\ell}}\xi_t = \xi_{t-t_{\rho,\ell}}$, the corollary follows in view of (3.2) providing the size of ι_ξ . \square

Let us summarize our progress so far. In light of (3.8), (3.11), (3.15), (3.20), and Corollary 3.3, we find that

$$\begin{aligned} & \int_{N_1^+} e^{i\langle \xi, n \rangle} \psi(n) d\mu_x^u \\ &= \sum_{\rho \in \mathcal{P}_\xi^0} \int_{\mathbb{R}} q(t) e^{-\delta t} \int_{W_\rho} \sum_{\ell \in I_{\rho,t}} \alpha_{\rho,\ell}(t - t_{\rho,\ell}, n) \overline{\psi}_{\rho,\ell}(t, n) \rho_\ell(n) d\mu_{y_\rho}^u dt + O\left(\int_{\mathbb{R}} q(t) e^{-t} dt\right). \end{aligned}$$

Recall that $q(t)$ was supported in the interval $(T-1, T)$ and satisfies (3.7). Hence, changing variables in $t \mapsto t + t_{\rho,\ell}$ and letting

$$\psi_{\rho,\ell}(t, n) := e^{-\delta t_{\rho,\ell}} \times q(t + t_{\rho,\ell}) \times \overline{\psi}_{\rho,\ell}(t + t_{\rho,\ell}, n), \quad (3.22)$$

we obtain

$$\begin{aligned} & \int_{N_1^+} e^{i\langle \xi, n \rangle} \psi(n) d\mu_x^u \\ & \ll e^{-\delta T} \sum_{\rho \in \mathcal{P}_\xi^0} \left| \int_{\mathbb{R} \times W_\rho} \sum_{\ell \in I_{\rho,t}} \alpha_{\rho,\ell}(t, n) \psi_{\rho,\ell}(t, n) \rho_\ell(n) d\mu_{y_\rho}^u dt \right| + O(e^{-T}). \end{aligned} \quad (3.23)$$

Cauchy-Schwarz. In light of (3.23), we are left with estimating integrals of the form:

$$\int_{\mathbb{R} \times W_\rho} \Psi_\rho(t, n) d\mu_{y_\rho}^u dt, \quad \Psi_\rho(t, n) := \sum_{\ell \in I_{\rho,t}} \alpha_{\rho,\ell}(t, n) \psi_{\rho,\ell}(t, n) \rho_\ell(n). \quad (3.24)$$

We begin by giving an apriori bound on Ψ_ρ . Denote by $J_\rho \subset \mathbb{R}$ the bounded support of the integrand in t coordinate of the above integrals. One then checks that

$$\|\psi_{\rho,\ell}\|_{L^\infty(J_\rho \times W_\rho)} \ll 1, \quad \|\Psi_\rho\|_{L^\infty(J_\rho \times W_\rho)} \ll \#I_{\rho,T}. \quad (3.25)$$

By Cauchy-Schwarz, we get

$$\left| \int_{J_\rho \times W_\rho} \Psi_\rho(t, n) d\mu_{y_\rho}^u dt \right|^2 \leq |J_\rho| \mu_{y_\rho}^u(W_\rho) \int_{J_\rho \times W_\rho} |\Psi_\rho(t, n)|^2 d\mu_{y_\rho}^u dt$$

We frequently use the following bounds

$$|J_\rho| \ll 1, \quad \mu_{y_\rho}^u(W_\rho) \ll_\Gamma 1,$$

where the latter follows from convex cocompactness of Γ and the fact that $y_\rho \in N_{1/2}^- \Omega$; cf. discussion above (3.6).

Linearizing the amplitude. Fix some $t \in J_\rho$. Let $r > 0$ to be chosen a small negative power of $\|\xi\|$. Using [16, Proposition 9.9], we can find a cover $\{A_j\}$ of W_ρ with balls of radius $r\iota_\xi$ centered around $u_j \in W_\rho \cap \text{supp}(\mu_{y_\rho}^u)$ and satisfying $\sum_j \mu_{y_\rho}^u(A_j) \ll \mu_{y_\rho}^u(W_\rho)$. In particular, by the triangle inequality we have

$$\int_{W_\rho} |\Psi_\rho(t, n)|^2 d\mu_{y_\rho}^u(n) \leq \sum_j \int_{A_j} |\Psi_\rho(t, n)|^2 d\mu_{y_\rho}^u(n). \quad (3.26)$$

We now turn to estimating the sum of oscillatory integrals in (3.26). For $k, \ell \in I_{\rho, t}$, we let

$$\psi_{k, \ell}(t, n) := \psi_{\rho, k}(t, n) \overline{\rho_k(n) \psi_{\rho, \ell}(t, n) \rho_\ell(n)}, \quad \alpha_{k, \ell}(t, n) := \alpha_{\rho, k}(t, n) \overline{\alpha_{\rho, \ell}(t, n)}.$$

Expanding the square, we get

$$\sum_j \int_{A_j} |\Psi_\rho(t, n)|^2 d\mu_{y_\rho}^u = \sum_j \sum_{k, \ell \in I_{\rho, t}} \int_{A_j} \alpha_{k, \ell}(t, n) \psi_{k, \ell}(t, n) d\mu_{y_\rho}^u.$$

Using (2.3) and (2.4), we change variables in the integrals using the maps taking each A_j onto N_1^+ . More precisely, recall that A_j is a ball of radius $r\iota_\xi$ around u_j such that $u_j y_\rho \in \Omega$. Letting

$$\begin{aligned} \tau = -\log r\iota_\xi, \quad y_\rho^j = g_\tau u_j y_\rho, \quad \alpha_{k, \ell}^j(t, n) &= \alpha_{k, \ell}(t, \text{Ad}(g_{-\tau})(n) u_j), \\ \psi_{k, \ell}^j(t, n) &= \psi_{k, \ell}(t, \text{Ad}(g_{-\tau})(n) u_j), \end{aligned} \quad (3.27)$$

we can rewrite the above sum as

$$\sum_j \sum_{k, \ell \in I_{\rho, t}} \int_{A_j} \alpha_{k, \ell}(t, n) \psi_{k, \ell}(t, n) d\mu_{y_\rho}^u \leq e^{-\delta\tau} \sum_j \sum_{k, \ell \in I_{\rho, t}} \left| \int_{N_1^+} \alpha_{k, \ell}^j(t, n) \psi_{k, \ell}^j(t, n) d\mu_{y_\rho^j}^u \right|. \quad (3.28)$$

One advantage of flowing forward by g_τ is that it provides smoothing of the amplitude functions $\psi_{k, \ell}$. In particular, it follows by (3.3) that

$$\left\| \psi_{k, \ell}^j \right\|_{C^1} \ll \|\psi\|_{C^1} e^{-\tau} \iota_\xi^{-1} = O(\|\psi\|_{C^1} r).$$

Applied to the right side of (3.28), we obtain

$$\int_{W_\rho} |\Psi_\rho(t, n)|^2 d\mu_{y_\rho}^u = e^{-\delta\tau} \sum_j \sum_{k, \ell \in I_{\rho, t}} \left| \int_{N_1^+} \alpha_{k, \ell}^j(t, n) d\mu_{y_\rho^j}^u \right| + O(\|\psi\|_{C^1} r \# I_{\rho, t}^2). \quad (3.29)$$

Separation of frequencies. Recall that u_j denotes the center of the ball A_j for each j and let $v_j \in \mathfrak{n}^+$ be such that

$$u_j = \exp(v_j).$$

Then, given $n = \exp(v) \in N_1^+$, we observe using (3.21) that

$$\alpha_{\rho, k}(t, \text{Ad}(g_{-\tau})(n) u_j) = \exp(i\lambda_\ell(v_j) \langle \xi_t, m_{\rho, \ell} \cdot (v_j + e^{-\tau} v) \rangle) + O(e^{-\tau} \|\xi_t\| \|e^{-\tau} v + v_j\|).$$

We note that $\exp(e^{-\tau} v + v_j)$ belongs to the ball A_j (an element of the cover of W_ρ). Since A_j meets the ball W_ρ , we have that $\|e^{-\tau} v + v_j\| \ll \iota_\xi(1+r) \ll \|\xi\|^{2/3}$.

Letting $\xi_{t+\tau} = e^{-t-\tau} \xi$ and

$$\beta_{k, \ell}^j := \xi_{t+\tau} \cdot (\lambda_k(v_j) m_{\rho, k} - \lambda_\ell(v_j) m_{\rho, \ell}), \quad (3.30)$$

it follows that

$$\left| \int_{N_1^+} \alpha_{k,\ell}^j(t, n) d\mu_{y_\rho}^u \right| \leq \left| \int_{N_1^+} \exp(i \langle \beta_{k,\ell}^j, n \rangle) d\mu_{y_\rho}^u \right| + O(e^{-t-\tau} \|\xi\|^{2/3}), \quad (3.31)$$

where we absorbed the constant term of the phase into the absolute values.

To apply the flattening theorem, it will be important to understand the distribution of the frequencies $\beta_{k,\ell}^j$. To this end, we have the following lemma.

Lemma 3.4. *For all j, k, ℓ , we have*

$$\left\| \beta_{k,\ell}^j \right\| \gg \|\xi_{t+\tau}\| |\langle v_j, w_{\rho,k} - w_{\rho,\ell} \rangle|,$$

where $w_{\rho,k}$ and $w_{\rho,\ell}$ are the vectors corresponding to the transverse intersection points defined in Lemma 3.2.

Proof. In light of Corollary 3.3, it suffices to prove that

$$\left\| \beta_{k,\ell}^j \right\| \gg \|\xi_{t+\tau}\| |\lambda_k(v_j) - \lambda_\ell(v_j)|.$$

The estimate is evident when $\lambda_k(v_j) = \lambda_\ell(v_j)$. Hence, we may assume without loss of generality that $\lambda_k(v_j) > \lambda_\ell(v_j)$, and recall that these functions are non-negative by definition; cf. (3.21). We may also assume that our norm is invariant by $O_d(\mathbb{R})$. In what follows, let

$$m_k := m_{\rho,k}, \quad c_k := \lambda_k(v_j), \quad A_k := c_k m_k$$

to simplify notation with the similar notation for the index ℓ in place of k defined analogously.

Recall the elementary estimate $\|g \cdot v\| \geq \|v\| / \|g^{-1}\|$ for any invertible linear map g and any vector $v \in \mathbb{R}^d$. This estimate implies the following lower bound for $\left\| \beta_{k,\ell}^j \right\|$:

$$\left\| \beta_{k,\ell}^j \right\| \geq \frac{\|\xi_{t+\tau}\|}{\|(A_k - A_\ell)^{-1}\|} = \frac{\|\xi_{t+\tau}\| c_k}{\|(\text{Id} - \frac{c_\ell}{c_k} m_\ell m_k^{-1})^{-1}\|}.$$

That $\text{Id} - \frac{c_\ell}{c_k} m_\ell m_k^{-1}$ (and hence $A_k - A_\ell$) is invertible follows at once from the following estimate on the norm of its inverse. Using the power series expansion of $\text{Id} - Q$, for matrices Q with $\|Q\| < 1$, we see that

$$\left\| (\text{Id} - \frac{c_\ell}{c_k} m_\ell m_k^{-1})^{-1} \right\| \leq \sum_{n \geq 0} \left(\frac{c_\ell}{c_k} \right)^n = \frac{c_k}{c_k - c_\ell}.$$

The lemma follows by combining the above two estimates. \square

This lemma motivates the definition of the following subset of $I_{\rho,t}^2$ parametrizing pairs (k, ℓ) for which the vectors $\beta_{k,\ell}^j$ are too small. Namely, we set

$$C_{\rho,t}^j = \left\{ (k, \ell) \in I_{\rho,t}^2 : |\langle v_j, w_{\rho,k} - w_{\rho,\ell} \rangle| < \|\xi_{t+\tau}\|^{-1/10} \right\}. \quad (3.32)$$

Roughly speaking, elements of $C_{\rho,t}^j$ correspond to points that concentrate near affine subspaces orthogonal to v_j .

The following proposition allows us to trivially estimate over the pairs in $C_{\rho,t}^j$ by showing that the points $y_{\rho,\ell}$ do not typically concentrate near proper affine linear subspaces.

Proposition 3.5. *There exists $\eta > 0$, depending only on the Patterson-Sullivan measure of Γ , such that for all $k \in I_{\rho,t}$, we have*

$$\# \left\{ \ell \in I_{\rho,t} : (k, \ell) \in C_{\rho,t}^j \right\} \ll 1 + \|\xi_{t+\tau}\|^{-\eta/10} \|v_j\|^{-\eta} e^{\delta t}.$$

Proof. The deduction of the above estimate from [16, Theorem 11.7] is similar to the proof of [16, Proposition 9.13], but we include a sketch of the proof for completeness. For a given $k \in I_{\rho,t}$, the condition $(k, \ell) \in C_{\rho,t}^j$ implies that $w_{\rho,\ell}$ is contained in the $\|\xi_{t+\tau}\|^{-1/10} / \|v_j\|$ -neighborhood of the affine subspace $v_j^\perp + w_{\rho,k}$, where v_j^\perp is the orthocomplement of v_j with respect to our inner product. Moreover, the points $w_{\rho,\ell}$ are separated by an amount $\gg e^{-t}$; cf. [16, Proof of Proposition 9.13]. Finally, by [16, Theorem 11.7] implies that any ε -neighborhood of a proper affine subspace has measure $O(\varepsilon^\eta)$. In particular, such neighborhood contains at most $O(\varepsilon^\eta e^{\delta t})$, since each ball of radius e^{-t} with center in Ω has measure $\asymp e^{-\delta t}$. \square

To apply Proposition 3.5, we first estimate trivially on the terms where $\|v_j\| < \|\xi_{t+\tau}\|^{-1/20}$. We note that the union

$$\bigcup_{j: \|v_j\| < \|\xi_{t+\tau}\|^{-1/20}} A_j$$

is contained in a ball of radius $\asymp \|\xi_{t+\tau}\|^{-1/20}$. It follows that

$$e^{-\delta\tau} \sum_{j: \|v_j\| < \|\xi_{t+\tau}\|^{-1/20}} \mu_{y_\rho}^u(A_j) \ll \|\xi_{t+\tau}\|^{-\delta/20}.$$

Let $S_{\rho,t}^j = I_{\rho,t}^2 \setminus C_{\rho,t}^j$. Combined with (3.29) and (3.31), we obtain

$$\begin{aligned} & \int_{W_\rho} |\Psi_\rho(t, n)|^2 d\mu_{y_\rho}^u \\ & \ll e^{-\delta\tau} \sum_{j: \|v_j\| \geq \|\xi_{t+\tau}\|^{-1/20}} \sum_{(k,\ell) \in S_{\rho,t}^j} \left| \int_{N_1^+} \exp(i\langle \beta_{k,\ell}^j, n \rangle) d\mu_{y_\rho}^u \right| \\ & + O\left(\left(\|\psi\|_{C^1} r + e^{-t-\tau} \|\xi\|^{2/3} + \|\xi_{t+\tau}\|^{-\delta/20}\right) \#I_{\rho,t}^2 + \left(1 + \|\xi_{t+\tau}\|^{-\eta/20} e^{\delta t}\right) \#I_{\rho,t}\right). \end{aligned} \quad (3.33)$$

3.1. The role of additive combinatorics. For each j , the sum on the right side of the above estimate can be viewed as an average, when properly normalized, over Fourier coefficients of the measure μ_\bullet^u . Moreover, the frequencies $\beta_{k,\ell}^j$ are sampled from a well-separated set. Hence, this average can be estimated using the L^2 -Flattening Theorem, Theorem 2.3.

To simplify notation, for $w \in \mathbb{R}^d$, we let

$$\nu_j := \mu_{y_\rho}^u \Big|_{N_1^+}, \quad \hat{\nu}_j(w) := \int_{N^+} e^{-i\langle w, n \rangle} d\nu_j(n). \quad (3.34)$$

Note that the total mass of ν_j , denoted $|\nu_j|$, is $\mu_{y_\rho}^u(N_1^+)$. Let $\eta_2 > 0$ be a small parameter to be chosen using Proposition 3.6 below. Define the following set of frequencies where $\hat{\nu}_j$ is large:

$$B(j, k, \eta_2) := \left\{ \ell \in I_{\rho,t} : (k, \ell) \in S_{\rho,t}^j \text{ and } |\hat{\nu}_j(\beta_{k,\ell}^j)| > \|\xi_{t+\tau}\|^{-\eta_2} |\nu_j| \right\}. \quad (3.35)$$

Then, splitting the sum over frequencies according to the size of the Fourier transform $\hat{\nu}_j$ and reversing our change variables to go back to integrating over A_j , we obtain

$$\begin{aligned} & e^{-\delta\tau} \sum_{j: \|v_j\| \geq \|\xi_{t+\tau}\|^{-1/20}} \sum_{(k,\ell) \in S_{\rho,t}^j} \int e^{-i\langle \beta_{k,\ell}^j, n \rangle} d\nu_j(n) \\ & \ll \left(\max_{j,k} \#B(j, k, \eta_2) + \|\xi_{t+\tau}\|^{-\eta_2} \#I_{\rho,t} \right) \#I_{\rho,t} \mu_{y_\rho}^u(N_1^+), \end{aligned} \quad (3.36)$$

The following key counting estimate for $B(j, k, \eta_2)$ is a consequence of the L^2 -flattening theorem, Theorem 2.3.

Proposition 3.6 (cf. [16, Proposition 9.16]). *For every $\varepsilon > 0$, there is $\eta_2 > 0$ such that for all j and $k \in I_\rho$, we have*

$$\#B(j, k, \eta_2) \ll_\varepsilon \|\xi\|^\varepsilon \left(1 + e^{\delta t} \|\xi_{t+\tau}\|^{-\eta_1}\right),$$

where $\eta_1 > 0$ is the constant provided by Proposition 3.5.

Proof. Recall the definition of the frequencies $\beta_{k,\ell}^j$ in (3.30) and the sets $S_{\rho,t}^j = I_{\rho,t}^2 \setminus C_{\rho,t}^j$, where $C_{\rho,t}^j$ was defined in (3.32). The rough idea behind the proof is that, by Lemma 3.4, $S_{\rho,t}^j$ parametrize pairs of frequencies which are sufficiently separated. This allows us to apply Theorem 2.3 on the Lebesgue measure of the set of frequencies where the Fourier transform is large to conclude that the sets $B(j, k, \eta_2)$ are relatively small in size.

More precisely, Proposition 2.4 and Theorem 2.3 imply that the set $B(j, k, \eta_2)$ can be covered by $O_\varepsilon(\|\xi\|^\varepsilon)$ balls of radius 1, provided η_2 is small enough, depending only on ε . By Lemma 3.4 and Proposition 3.5, each such ball contains at most $O(1 + e^{\delta t} \|\xi_{t+\tau}\|^{-\eta_1})$. This concludes the proof. \square

By choosing r^{-1} and e^T to be suitably small positive powers of $\|\xi\|$, the theorem now follows upon combining (3.33), (3.36), and Proposition 3.6.

4. EXPLICIT FORMULA FOR STABLE HOLONOMY MAPS

In this section, we give explicit formulas for the commutation relations between stable and unstable subgroups which we need for the proof of Lemma 3.2.

4.1. Proof of Lemma 3.2. Consider the following quadratic form on \mathbb{R}^{d+2} : for $x = (x_i) \in \mathbb{R}^{d+2}$,

$$Q(x) = 2x_0x_{d+1} - |x_1|^2 - \dots - |x_d|^2.$$

Let $\text{SO}_\mathbb{R}(Q) \cong \text{SO}(d+1, 1)$ be the orthogonal group of Q ; i.e. the subgroup of $\text{SL}_{d+2}(\mathbb{R})$ preserving Q . Then, we have a surjective homomorphism $\text{SO}_\mathbb{R}(Q) \rightarrow G = \text{Isom}^+(\mathbb{H}^{d+1})$ with finite kernel. The geodesic flow is induced by the diagonal group

$$A = \{g_t = \text{diag}(e^t, I_d, e^{-t}) : t \in \mathbb{R}\},$$

where I_d denotes the identity matrix in dimension d . Recall that $M = \text{SO}_d(\mathbb{R})$ denotes the centralizer of A inside the standard maximal compact subgroup $K \cong \text{SO}_{d+1}(\mathbb{R})$ of G .

For $x \in \mathbb{R}^d$, viewed as a row vector, we write x^t for its transpose. We let $\|x\|^2 := x \cdot x$, and $x \cdot x$ denotes the sum of coordinate-wise products. Hence, N^+ can be parametrized as follows:

$$N^+ = \left\{ n^+(x) := \begin{pmatrix} 1 & x & \frac{\|x\|^2}{2} \\ \mathbf{0} & I_{d-1} & x^t \\ 0 & \mathbf{0} & 1 \end{pmatrix} : x \in \mathbb{R}^d \right\}. \quad (4.1)$$

The group N^- is parametrized by the transpose of the elements of N^+ .

Note that the product map $M \times A \times N^+ \times N^- \rightarrow G$ is a diffeomorphism near identity. In particular, given $\tau \in \mathbb{R}$, $m \in M$, and small enough⁵ $x, y \in \mathbb{R}^d$, we can find $\phi_y(x) \in \mathbb{R}^d$ and $\tau(x) \in \mathbb{R}$ such that

$$n^+(x)n^-(y)g_\tau m \in N^- M g_{\tau(x)} n^+(\phi(x)).$$

The coordinates (τ, x) parametrize every local weak stable leaf in our manifold. In particular, the function $(\tau(x), \phi(x))$ parametrize the image of such leaf under local strong stable holonomy. To compute the function $\phi(x)$, let

$$\lambda(x) = 1 + x \cdot y + \frac{\|x\|^2 \|y\|^2}{4}.$$

⁵It suffices to have $\|x\|$ and $\|y\|$ at most 1/2 for instance.

Then, by examining the first row of $n^+(x)n^-(y)$ in the above parametrization, we find that

$$\tau(x) = \tau - \log \lambda(x), \quad \phi(x) = \frac{1}{e^\tau \lambda(x)} m^{-1} \cdot \left(x + \frac{\|x\|^2}{2} y \right),$$

where for $m \in M$ and $v \in \mathbb{R}^d$, we use the notation $m \cdot v$ to denote the standard action of M on \mathbb{R}^d . This concludes the proof Lemma 3.2 follows by taking $x = v$, $y = w_{\rho, \ell}$, and $\tau = t_{\rho, \ell}$ in the notation of the statement.
