# Conjugate Operators of 1D-harmonic Oscillator

#### Abstract

Conjugate operator $T$ of 1D-harmonic oscillator $N=\frac{1}{2}\left(p^{2}+q^{2}-\mathbb{1}\right)$ is defined by an operator satisfying canonical commutation relation $[N, T]=-i \mathbb{1}$ on some domain but not necessarily dense. The angle operator $T_{A}=\frac{1}{2}\left(\arctan q^{-1} p+\arctan p q^{-1}\right)$ and Galapon operator $T_{G}=i \sum_{n=0}^{\infty}\left(\sum_{m \neq n} \frac{\left(v_{m}, \cdot\right)}{n-m} v_{n}\right)$ are examples of conjugate operators, where $\left\{v_{n}\right\}$ denotes the set of normalized eigenvectors of $N$. Let $\mathscr{T}$ be a subset of conjugate operators of $N$. A classification of $\mathscr{T}$ are given as $\mathscr{T}=\mathscr{T}_{\{0\}} \cup \mathscr{T}_{\mathbb{D}} \backslash\{0\} \cup \mathscr{T}_{\partial \mathbb{D}}$, and $T_{A} \in \mathscr{T}_{\{0\}}$ and $T_{G} \in \mathscr{T}_{\partial \mathbb{D}}$ are shown. Here the classification is specified by a pair of parameters $(\omega, m) \in \mathbb{C} \times \mathbb{N}$. Finally the time evolution $T_{\omega, m}(t)=e^{i t N} T_{\omega, m} e^{-i t N}$ for $T_{\omega, m} \in \mathscr{T}$ is investigated, and show that $T_{\omega, m}(t)$ is periodic.


## 1 Introduction

Let us consider conjugate operator $T$ of 1D-harmonic oscillator

$$
N=\frac{1}{2}\left(p^{2}+q^{2}-\mathbb{1}\right) .
$$

Here $p=-i \frac{d}{d x}$ and $q=M_{x}$ be the multiplication by $x$. Both are self-adjoint operators on $L^{2}(\mathbb{R})$. It satisfies that $[N, T]=-i \mathbb{1}$. The commutator $[A, B]$ of linear operators $A$ and $B$ is a linear operator defined by

$$
[A, B]=A B-B A
$$

on $\mathrm{D}(A B) \cap \mathrm{D}(B A)$. Here $\mathrm{D}(A)$ denotes the domain of $A$. In physics, the relationship between position and momentum and that between energy and time are believed to be formally complementary. Since the quantized position and momentum, $q$ and $p$, satisfy the canonical commutation relation $[q, p]=-i \mathbb{1}$, if $N$ is regarded as the energy of a quantum

[^0]system, $T$ seems to be a quantization of time. Then $T$ is often times called the time operator associated with $N$. This paper does not however give any philosophical discussions on time. It should be emphasized that time operator is just a name of convenience. We give mathematical definitions of time operators and conjugate operators in Definition 1.1.

In the previous paper [10] we consider two special conjugate operators, angle operator $T_{A}$ and Galapon operator $T_{G}$, of $N$ from a mathematical point of view. $T_{A}$ and $T_{G}$ have been mainly investigated so far from a physical point of view, e.g., $[13,1,18,7,6,11,12,17]$ and as far as we know, there is no firm and robust results on relationships between $T_{A}$ and $T_{G}$ in a purely mathematical setting. In this paper we comprehensively investigate conjugate operators including $T_{A}$ and $T_{G}$, and give a relationship between $T_{A}$ and $T_{G}$. Furthermore we classify conjugate operators by the pair of parameters $(\omega, m) \in \mathbb{C} \times \mathbb{N}$ and define disjoint three classes of conjugate operators.

### 1.1 Angle operators and Galapon operators

Define the annihilation operator $a$ and the creation operator $a^{*}$ in $L^{2}(\mathbb{R})$ by

$$
a=\frac{1}{\sqrt{2}}(q+i p), \quad a^{*}=\frac{1}{\sqrt{2}}(q-i p)
$$

respectively. The canonical commutation relation (CCR)

$$
\begin{equation*}
\left[a, a^{*}\right]=\mathbb{1}, \quad[a, a]=0=\left[a^{*}, a^{*}\right] \tag{1.1}
\end{equation*}
$$

holds true on a dense subspace of $L^{2}(\mathbb{R})$. The number operator is defined by $a^{*} a$ which is actually the harmonic oscillator

$$
a^{*} a=N
$$

and $N$ is self-adjoint on $\mathrm{D}(N)=\mathrm{D}\left(p^{2}\right) \cap \mathrm{D}\left(q^{2}\right)$. The normalized ground state of $N$ is given by

$$
v(x)=\pi^{-1 / 4} e^{-x^{2} / 2}
$$

Note that $a v=0$ and $N v=0$. The normalized eigenvectors $v_{n}$ are given by

$$
\begin{equation*}
v_{n}=\frac{1}{\sqrt{n!}} a^{* n} v \quad n \geq 1 \tag{1.2}
\end{equation*}
$$

Here we write $a^{* n}$ for $\left(a^{*}\right)^{n}$. It satisfies that $N v_{n}=n v_{n}$ and $\operatorname{Spec}(N)=\mathbb{N}$. Here $\operatorname{Spec}(N)$ denotes the spectrum of $N$. Note that notation $\mathbb{N}$ describes $\{0,1,2, \ldots$,$\} including zero in$ this paper.

We recall the definitions of conjugate operators and time operators.
Definition 1.1 (Conjugate operators and time operators) If a self-adjoint operator $A$ in Hilbert space $\mathcal{H}$ admits an operator $B$ satisfying the canonical commutation relation:

$$
\begin{equation*}
[A, B]=-i \mathbb{1} \tag{1.3}
\end{equation*}
$$

on $D_{A, B} \subset \mathrm{D}(A B) \cap \mathrm{D}(B A)$ but $D_{A, B} \neq\{0\}$, then $B$ is called a conjugate operator of $A$ and $D_{A, B}$ a $C C R$-domain of (1.3). Furthermore if $B$ is symmetric, then $B$ is called a time operator of $A$.

Remark 1.2 By the definitions, conjugate operators are not necessarily densely defined, but the time operators are densely defined.

We shall construct a conjugate operator $T$ of $N$, i.e.,

$$
\begin{equation*}
[N, T]=-i \mathbb{1} \tag{1.4}
\end{equation*}
$$

on some domain. In the previous paper [10] we investigate the angle operator e.g., [15] given by

$$
T_{A}=-\frac{1}{2}\left(\arctan \left(q^{-1} p\right) \oplus \arctan \left(p q^{-1}\right)\right)
$$

and the so-called Galapon operator $[5,3,9,8]$ defined by

$$
T_{G}=i \sum_{n=0}^{\infty}\left(\sum_{m \neq n} \frac{\left(v_{m}, \cdot\right)}{n-m} v_{n}\right) .
$$

It is known that $T_{G}$ is a bounded self-adjoint operator, and hence $T_{G}$ is a time operator of $N$. However $T_{A}$ is unbounded and not densely defined. In particular it is not symmetric. Moreover $\left[N, T_{G}\right]=-i \mathbb{1}$ holds on a dense domain, but $\left[N, T_{A}\right]=-i \mathbb{1}$ on a non-dense domain.

Lots of conjugate operators of $N$ appeared in this paper are not densely defined and hence not symmetric. So, we extend relation (1.4) to the so-called ultra-weak canonical commutation relation. See Definition 4.6. For the sesqui-linear form $\mathcal{T}$, the ultra-weak canonical commutation relation is defined by

$$
\begin{equation*}
\mathcal{T}[N \psi, \varphi]-\overline{\mathcal{T}[N \varphi, \psi]}=-i(\psi, \varphi) \tag{1.5}
\end{equation*}
$$

Here $\mathcal{T}[\psi, \varphi]$ is linear in $\varphi$ and anti-linear in $\psi$, and $\mathcal{T}$ is not necessarily densely defined on $L^{2}(\mathbb{R}) \oplus L^{2}(\mathbb{R})$. We can define an ultra-weak time operator $\mathcal{T}_{A}$ associated with $T_{A}$, and it is shown in [10] that $\mathcal{T}_{A}$ satisfies (1.5) on a dense domain. See (4.6).

### 1.2 Outline of the paper

In this paper, for notational simplicity, we use symbol $\ell^{2}$ to denote the space $\ell^{2}(\mathbb{N})$ of square-summable complex-valued sequences on $\mathbb{N}$. We also identify $L^{2}(\mathbb{R})$ with $\ell^{2}$ and consider conjugate operators of $N$ not on $L^{2}(\mathbb{R})$ but on $\ell^{2}$. The key ingredients are shift operators $L$ and $L^{*}$ on $\ell^{2}$. Here $L$ denotes the left shift, and $L^{*}$ is the adjoint of $L$ and hence the right shift on $\ell^{2}$. The main part of this paper is Sections 4-7, where we investigate
(1)-(5) below.
(1) We show that $T_{A}$ and $T_{G}$ can be represented in terms of $L, L^{*}$ and $N$ as

$$
\begin{aligned}
& T_{G}=i\left\{\log (\mathbb{1}-L)+\log \left(\mathbb{1}-L^{*}\right)\right\}, \\
& T_{A}=\frac{i}{2}\left\{\log \left(\sqrt{\frac{N+2 \mathbb{1}}{N+\mathbb{1}}} L^{2}\right) \oplus \log \left(\sqrt{\frac{N+\mathbb{1}}{N+2 \mathbb{1}}} L^{2}\right)\right\}
\end{aligned}
$$

in Theorems 4.9 and 5.4.
(2) We generalize $T_{G}$ and $T_{A}$ as

$$
\begin{aligned}
& i\left\{\log \left(\mathbb{1}-g_{N} L\right)+\log \left(\mathbb{1}-L^{*} g_{N}^{-1}\right)\right\}, \\
& \frac{i}{2}\left\{\log \left(g_{N+2} L^{2}\right) \oplus \log \left(\tilde{g}_{N+2} L^{2}\right)\right\},
\end{aligned}
$$

respectively, in Sections 4 and 5 . Here $g$. is a map from $\mathbb{N}$ to $\mathbb{C}$.
(3) We construct a general class of conjugate operators in Section 6. Let

$$
L_{\omega, m}=\omega \mathbb{1}-L^{m}, \quad(\omega, m) \in \mathbb{C} \times \mathbb{N} .
$$

We define $T_{\omega, m}$ by

$$
\begin{equation*}
T_{\omega, m}=\frac{i}{m} \log L_{\omega, m} . \tag{1.6}
\end{equation*}
$$

We can see that $T_{\omega, m}$ is conjugate operators of $N$. Let $\mathbb{D}$ be the open unit disc on the complex plan $\mathbb{C}$. We can see that $T_{\omega, m}$ with $\omega \in \partial \mathbb{D}$ is bounded and there exists a dense CCR-domain, and we say that

$$
T_{\omega, m}, \quad m \geq 1, \omega \in \partial \mathbb{D}
$$

are general Galapon operators. It is actually seen that $T_{G}=T_{1,1}+T_{1,1}^{*}$. On the other hand general angle operators are introduced by

$$
\begin{equation*}
T_{\omega, m}, \quad m \geq 1, \omega=0 \tag{1.7}
\end{equation*}
$$

Let

$$
\mathscr{T}=\left\{T_{\omega, m} \mid \omega \in \overline{\mathbb{D}}, m \geq 1\right\}
$$

We divide $\mathscr{T}$ into three disjoint families by $\omega \in \overline{\mathbb{D}}$. We have

$$
\mathscr{T}=\mathscr{T}_{\{0\}} \cup \mathscr{T}_{\mathbb{D} \backslash\{0\}} \cup \mathscr{T}_{\partial \mathbb{D}} .
$$

Here

$$
\begin{aligned}
& \mathscr{T}_{\{0\}}=\left\{T_{\omega, m} \mid \omega=0, m \geq 1\right\}, \\
& \mathscr{T}_{\mathbb{D} \backslash\{0\}}=\left\{T_{\omega, m}|0<|\omega|<1, m \geq 1\},\right. \\
& \mathscr{T}_{\partial \mathbb{D}}=\left\{T_{\omega, m}| | \omega \mid=1, m \geq 1\right\} .
\end{aligned}
$$

We study CCR-domains for each conjugate operators in $\mathscr{T}$.
(5) Let $H$ be a self-adjoint operator. Then the strong time operator $T_{H}$ is defined by the weak Weyl relation

$$
T_{H} e^{-i t H} \supset e^{-i t H}\left(T_{H}+t\right), \quad t \in \mathbb{R}
$$

It is established that if $T_{H}$ is a strong time operator for $H$, then the spectrum of $H$ is purely continuous spectrum. We can show that conjugate operators in $\mathscr{T}$ satisfies a discrete version of weak Weyl relations in Section 7. Furthermore we show that $T_{\omega, m}(t)=$ $e^{i t N} T_{\omega, m} e^{-i t N}$ is periodic with period $2 \pi / m$.

## 2 Technical tools

### 2.1 Super coherent vectors

We define the exponent operator $e^{A}$ for a non self-adjoint operator $A$ in a Hilbert space $\mathcal{H}$ by the geometric series:

$$
\begin{aligned}
& \mathrm{D}\left(e^{A}\right)=\left\{f \in \bigcap_{k=0}^{\infty} \mathrm{D}\left(A^{k}\right) \left\lvert\, \lim _{K \rightarrow \infty} \sum_{k=0}^{K} \frac{1}{k!} A^{k} f\right. \text { exists }\right\}, \\
& e^{A} f=\sum_{k=0}^{\infty} \frac{1}{k!} A^{k} f, \quad f \in \mathrm{D}\left(e^{A}\right) .
\end{aligned}
$$

It should be written as $\sum_{k \in \mathbb{N}} \frac{1}{k!} A^{k}$ for $e^{A}$, but we write $e^{A}$ for the notational simplicity. We define the set $\mathcal{C}$ consisting of coherent vectors by

$$
\mathcal{C}=\operatorname{LH}\left\{e^{\beta a^{*}} v \mid \beta \in \mathbb{C}\right\}
$$

Note that $e^{\beta a^{*}}$ is an unbounded operator, but $v \in \mathrm{D}\left(e^{\beta a^{*}}\right)$ for any $\beta \in \mathbb{C}$, and it is given by

$$
e^{\beta a^{*}} v(x)=\pi^{-1 / 4} e^{\beta^{2} / 2} \exp \left(-\frac{(x-\sqrt{2} \beta)^{2}}{2}\right)
$$

It is well known that $\mathcal{C}$ is dense in $L^{2}(\mathbb{R})$. We set $w_{\beta}=e^{-|\beta|^{2} / 2} e^{\beta a^{*}} v$, where $e^{-|\beta|^{2} / 2}$ is the normalize constant such that $\left\|w_{\beta}\right\|=1$. It is shown that $w_{\beta} \in \mathrm{D}\left(a^{* n}\right)$ and $a^{* n} w_{\beta}=$ $e^{-|\beta|^{2} / 2} e^{\beta a^{*}} a^{* n} v$. Moreover one obtains that

$$
a w_{\beta}=\beta w_{\beta}
$$

Thus $w_{\beta}$ is an eigenvector of $a$ with eigenvalue $\beta \in \mathbb{C}$. We also see that $e^{\gamma a} w_{\beta}=e^{\gamma \beta} w_{\beta}$ for any $\beta, \gamma \in \mathbb{C}$.

Next let us consider vectors of the form $e^{\beta a^{* 2} / 2} v$. Exponent of $a^{* 2}$ is also unbounded. Although $e^{\beta a^{*}} v \in L^{2}(\mathbb{R})$ for any $\beta \in \mathbb{C}$, it is not clear that $e^{\beta a^{* 2} / 2} v \in L^{2}(\mathbb{R})$.

Lemma 2.1 Let $\beta \in \mathbb{C}$. Then $v \in \mathrm{D}\left(e^{\beta a^{* 2} / 2}\right)$ if and only if $|\beta|<1$. Moreover, $e^{\beta a^{* 2} / 2} v \in$ $\mathrm{D}\left(a^{* n}\right)$ for any $|\beta|<1$ and $n \in \mathbb{N}$.

Proof: Let $|\beta|<1$. By the Rodrigues formula and orthogonality of the Hermite polynomials $H_{k}$,

$$
\left\|\sum_{k=0}^{K} \frac{1}{k!}\left(\frac{\beta}{2}\right)^{k} a^{* 2 k} v\right\|^{2}=\left\|\sum_{k=0}^{K} \frac{\beta^{k}}{2^{2 k} k!} H_{2 k} v\right\|^{2}=\sum_{k=0}^{K} \frac{|\beta|^{2 k}}{\left(2^{2 k} k!\right)^{2}} 2^{2 k}(2 k)!=\sum_{k=0}^{K} \frac{(2 k-1)!!}{(2 k)!!}|\beta|^{2 k} .
$$

Let $K \rightarrow \infty$. Then $\left\|e^{\beta a^{* 2} / 2} v\right\|^{2}=\left(1-|\beta|^{2}\right)^{-1 / 2}$ holds. This shows that $v \in \mathrm{D}\left(e^{\beta a^{* 2} / 2}\right)$ if and only if $|\beta|<1$. The statement that $e^{\beta a^{* 2} / 2} v \in \mathrm{D}\left(a^{* n}\right)$ is similarly proven.

We call $e^{\beta a^{* 2} / 2} v$ a super coherent vector and denote the linear hull of super coherent vectors by

$$
\mathcal{S}=\mathrm{LH}\left\{e^{\beta a^{* 2} / 2} v| | \beta \mid<1\right\} .
$$

The vectors contained in $\mathcal{S}$ play an important role for studying the angle operator.

### 2.2 Wiener-Itô decomposition

As is mentioned in Section 1 we shall investigate conjugate operators on $\ell^{2}$ for $L^{2}(\mathbb{R})$. The first task is to make the identification between $\ell^{2}$ and $L^{2}(\mathbb{R})$ clear, and we transform $a$ and $a^{*}$ on $L^{2}(\mathbb{R})$ to operators on $\ell^{2}$. By the Wiener-Itô decomposition we have

$$
L^{2}(\mathbb{R})=\bigoplus_{n=0}^{\infty} L_{n},
$$

where $L_{n}=\operatorname{LH}\left\{v_{n}\right\}$ is the one-dimensional linear subspace spanned by eigenvectors $v_{n}$ of $N$ with eigenvalue $n \in \mathbb{N}$. For each $f \in L^{2}(\mathbb{R})$, there exists $\left(c_{n}\right)_{n \in \mathbb{N}} \in \ell^{2}$ so that $f=\sum_{n=0}^{\infty} c_{n} v_{n}$. Actually it is given by $c_{n}=\left(v_{n}, f\right)$. We often use $\left(c_{0}, c_{1}, c_{2}, \ldots\right)$ for $\left(c_{n}\right)_{n \in \mathbb{N}}$. By the unitary map

$$
\begin{equation*}
U f=\left(c_{n}\right)_{n \in \mathbb{N}} \tag{2.1}
\end{equation*}
$$

we can identify $L^{2}(\mathbb{R})$ with $\ell^{2}$. We set $\xi_{n}=U v_{n} \in \ell^{2}$. It is seen that

$$
\begin{aligned}
& U a U^{*}: \xi_{n} \mapsto \sqrt{n} \xi_{n-1}, \quad n \geq 1, \\
& U a^{*} U^{*}: \xi_{n} \mapsto \sqrt{n+1} \xi_{n+1}, \quad n \geq 0
\end{aligned}
$$

For the notational convenience, we write $a$ for $U a U^{*}$. Furthermore $U v$ is denoted by $\Omega$. Then $\Omega=(1,0,0, \ldots)$ and $\xi_{n}=\left(0, \ldots, 0,{ }_{1}^{n+1_{\text {th }}}, 0, \ldots\right)$ for $n \geq 0$. Note that $\xi_{0}=\Omega$. In the
following, our investigation is transformed on $\ell^{2}$ instead of on $L^{2}(\mathbb{R})$ and we fix $\left\{\xi_{n}\right\}_{n \in \mathbb{N}}$ as a complete orthonormal system of $\ell^{2}$. Let $\ell_{\text {fin }}^{2}$ be the finite particle subspace defined by

$$
\ell_{\mathrm{fin}}^{2}=\left\{\sum_{n=0}^{m} c_{n} \xi_{n} \mid m \in \mathbb{N}, c_{n} \in \mathbb{C}\right\} .
$$

It is dense, and commutator $\left[a, a^{*}\right]$ and polynomials in $a$ and $a^{*}$ are well defined on this space. Thus algebraic computations on $a$ and $a^{*}$ can be done on $\ell_{\text {fin }}^{2}$.

### 2.3 Shift operators $L$ and $L^{*}$ on $\ell^{2}$

Let $L$ be the left-shift and the adjoint $L^{*}$ the right-shift on $\ell^{2}$, which are defined by

$$
\begin{aligned}
& L \xi_{n}= \begin{cases}\xi_{n-1} & n \geq 1 \\
0 & n=0\end{cases} \\
& L^{*} \xi_{n}=\xi_{n+1} .
\end{aligned}
$$

We can see that

$$
\begin{aligned}
L L^{*} & =\mathbb{1} \\
L^{*} L & =\mathbb{1}-P_{\{\Omega\}}
\end{aligned}
$$

where $P_{\{\Omega\}}$ is the projection to the one-dimensional subspace spanned by $\Omega$. In general an arbitrary closed operator $A$ can be decomposed as $A=V|A|$, where $|A|=\left(A^{*} A\right)^{1 / 2}$ is a positive self-adjoint operator and $V$ a partial isometry such that the initial space is $(\operatorname{Ker} A)^{\perp}$ and the final space $\overline{\operatorname{Ran} A} . \quad A=V|A|$ is called the polar decomposition of A. $V$ is uniquely determined by these properties together with the addition condition $\operatorname{Ker}|A|=\operatorname{Ker} V$. In terms of $L, L^{*}$ and $N$, both of $a$ and $a^{*}$ can be represented as

$$
\begin{aligned}
& a=L \sqrt{N}=\sqrt{N+\mathbb{1}} L \\
& a^{*}=L^{*} \sqrt{N+\mathbb{1}}=\sqrt{N} L^{*}
\end{aligned}
$$

Note that $N=a^{*} a$ and $N+\mathbb{1}=a a^{*}$. These are just the polar decompositions of closed operators $a$ and $a^{*}$. Note that

$$
\begin{aligned}
& \operatorname{Ker} a=\{c \Omega \mid c \in \mathbb{C}\}=\operatorname{Ker} \sqrt{N}, \\
& \operatorname{Ker} a^{*}=\{0\}=\operatorname{Ker} \sqrt{N+\mathbb{1}} .
\end{aligned}
$$

$L$ is a partial isometry such that the initial space is $(\operatorname{Ker} a)^{\perp}=\{c \Omega \mid c \in \mathbb{C}\}^{\perp} \cong \bigoplus_{n=1}^{\infty} L_{n}$ and the final space $\ell^{2}$. We also see that

$$
\begin{equation*}
\left[N, L^{*}\right] \subset L^{*}, \quad[N, L] \subset-L \tag{2.2}
\end{equation*}
$$

Then $\left[N, L^{* k}\right] \subset k L^{* k}$ and $\left[N, L^{k}\right] \subset-k L^{k}$ hold true. Let $\mathbb{D}=\{z \in \mathbb{C}| | z \mid<1\}$ be the open unit disc in $\mathbb{C}$. Notice that

$$
e^{\alpha N L^{*}} \Omega=\left(1, \alpha, \alpha^{2}, \alpha^{3}, \ldots\right), \quad \alpha \in \mathbb{D} .
$$

It can be seen that

$$
\begin{equation*}
L e^{\alpha N L^{*}} \Omega=\alpha e^{\alpha N L^{*}} \Omega, \quad \alpha \in \mathbb{D} . \tag{2.3}
\end{equation*}
$$

Thus $e^{\alpha N L^{*}} \Omega$ is an eigenvector of $L$ with the eigenvalue $\alpha$.
Lemma 2.2 We have $\operatorname{Spec}(L)=\operatorname{Spec}\left(L^{*}\right)=\overline{\mathbb{D}}, \operatorname{Spec}_{\mathrm{p}}(L)=\mathbb{D}$ and $\operatorname{Spec}_{\mathrm{p}}\left(L^{*}\right)=\emptyset$.
Proof: Since $\|L\| \leq 1, \operatorname{Spec}(L) \cup \operatorname{Spec}\left(L^{*}\right) \subset \overline{\mathbb{D}}$. By (2.3), we see that $\mathbb{D} \subset \operatorname{Spec}_{\mathrm{p}}(L)$ and $\operatorname{Spec}(L)=\operatorname{Spec}\left(L^{*}\right)=\overline{\mathbb{D}}$. Let $|\alpha|=1$. The relation $L \varphi=\alpha \varphi$ implies $\varphi=\left(\alpha^{n}\right)_{n \in \mathbb{N}}$ but $\varphi \notin \ell^{2}$. Hence $\operatorname{Spec}_{\mathrm{p}}(L)=\mathbb{D}$. Let $|\alpha| \leq 1$ and $L^{*} \varphi=\alpha \varphi$. Then $\left(L^{*} \varphi\right)_{0}=0=\alpha \varphi_{0}$ and hence $\left(L^{*} \varphi\right)_{1}=0$. Repeating this procedure, we see that $\varphi=0$. Thus we have $\operatorname{Spec}_{\mathrm{p}}\left(L^{*}\right)=\emptyset$.

Let $k \in \mathbb{N}$. Similarly to the proof of Lemma 2.2 we can see that, for any $k \alpha \in \mathbb{D}$, $e^{\alpha N L^{* k}} \Omega$ is an eigenvector of $L^{k}$. Since

$$
e^{\alpha N L^{* k}} \Omega=(1, \underbrace{0, \ldots, 0}_{k-1}, k \alpha, \underbrace{0, \ldots, 0}_{k-1},(k \alpha)^{2}, \underbrace{0, \ldots, 0}_{k-1},(k \alpha)^{3}, \ldots),
$$

it is actually given by

$$
\begin{equation*}
L^{k} e^{\alpha N L^{* k}} \Omega=k \alpha e^{\alpha N L^{* k}} \Omega . \tag{2.4}
\end{equation*}
$$

We can also extend this to a general version. Let $f$ be a complex-valued function on $\mathbb{N}$. Set $f(N)=f_{N}$. Then

$$
\begin{equation*}
e^{\alpha f_{N} L^{* k}} \Omega=(1, \underbrace{0, \ldots, 0}_{k-1}, f(k) \alpha, \underbrace{0, \ldots, 0}_{k-1}, \frac{f(2 k) f(k)}{2!} \alpha^{2}, \underbrace{0, \ldots, 0}_{k-1}, \frac{f(3 k) f(2 k) f(k)}{3!} \alpha^{3}, \ldots) . \tag{2.5}
\end{equation*}
$$

For a given function $f$, we shall find $g$ such that $e^{\alpha f_{N} L^{* k}} \Omega$ is an eigenvector of $g_{N+k} L^{k}$ in Sections 4 and 5.

## 3 Phase operators

We give the definition of $\log A$ for a linear operator $A$. It is emphasised that $A$ is not necessarily self-adjoint.

Definition $3.1(\log A)$ Let $A$ be a linear operator on a Hilbert space $\mathcal{H}$. We define $\log A$ by

$$
\begin{aligned}
& \mathrm{D}(\log A)=\left\{f \in \bigcap_{k=0}^{\infty} \mathrm{D}\left(A^{k}\right) \left\lvert\, \lim _{K \rightarrow \infty} \sum_{k=1}^{K} \frac{1}{k}(\mathbb{1}-A)^{k} f\right. \text { exists }\right\}, \\
& \log A f=-\sum_{k=1}^{\infty} \frac{1}{k}(\mathbb{1}-A)^{k} f, \quad f \in \mathrm{D}(\log A) .
\end{aligned}
$$

Note that in general

$$
\begin{align*}
& \log (A B) \neq \log A+\log B  \tag{3.1}\\
& \log \alpha A \neq \log \alpha+\log A, \quad \alpha \in \mathbb{C} \tag{3.2}
\end{align*}
$$

We define the so-called phase operator $\rho$ on $\ell^{2}$ by

$$
\begin{equation*}
\rho=-\frac{i}{2}\left(\log a-\log a^{*}\right) \tag{3.3}
\end{equation*}
$$

The phase operator $\rho$ has been studied in the large number of literatures e.g., $[18,11,16]$ as the conjugate operator of $N$, but it does not appear to be obvious in the definition of $\log a$ and $\log a^{*}$.

Lemma 3.2 We have $\mathrm{D}(\log a) \cap \ell_{\mathrm{fin}}^{2}=\{0\}$ and $\mathrm{D}\left(\log a^{*}\right)=\{0\}$. In particular, $\mathrm{D}(\rho)=\{0\}$.
Proof: Let $\psi=\sum_{l=0}^{m} c_{l} \xi_{l} \in \ell_{\text {fin }}^{2}$ with $c_{m} \neq 0$. Since
$\lim _{K \rightarrow \infty}\left|\left(\xi_{m}, \sum_{k=1}^{K} \frac{1}{k}(\mathbb{1}-a)^{k} \psi\right)\right|=\lim _{K \rightarrow \infty}\left|\sum_{k=1}^{K} \frac{1}{k}\left(\left(\mathbb{1}-a^{*}\right)^{k} \xi_{m}, \psi\right)\right|=\lim _{K \rightarrow \infty}\left|\left(\xi_{m}, \psi\right)\right| \sum_{k=1}^{K} \frac{1}{k}=\infty$,
we see that $\mathrm{D}(\log a) \cap \ell_{\text {fin }}^{2}=\{0\}$. Let $\psi^{\prime}=\sum_{l=m^{\prime}}^{\infty} c_{l} \xi_{l} \in \ell^{2}$ with $c_{m^{\prime}} \neq 0$. Similarly, it follows that

$$
\lim _{K \rightarrow \infty}\left|\left(\xi_{m^{\prime}}, \sum_{k=1}^{K} \frac{1}{k}\left(\mathbb{1}-a^{*}\right)^{k} \psi^{\prime}\right)\right|=\lim _{K \rightarrow \infty}\left|\left(\xi_{m^{\prime}}, \psi^{\prime}\right)\right| \sum_{k=1}^{K} \frac{1}{k}=\infty .
$$

Hence $\mathrm{D}\left(\log a^{*}\right)=\{0\}$.
From Lemma 3.2 we can see that $\rho$ is not well defined on $\ell_{\mathrm{fin}}^{2}$. This fact is fatal to consider the phase operator $\rho$ on $\ell^{2}$. Therefore, when we investigate $\rho$, we have to consider the domain of $\rho$ carefully.

## 4 Angle operators

### 4.1 Angle operators by $a$ and $a^{*}$

It is said that a relationship between the angle operator $T_{A}$ and the phase operator $\rho$ is given as $T_{A}=(\pi / 2) \mathbb{1}-\rho+G(N)$ in e.g., [11, (32)]. However it seems to be formal and as was seen in Lemma 3.2 the phase operator $\rho$ is not well defined on $\ell_{\text {fin }}^{2}$.

In order to see a rigorous relationship between phase operator $\rho$ and the angle operator $T_{A}$, we express $T_{A}$ in terms of the creation operators and the annihilation operators. Define

$$
\phi=\frac{1}{\sqrt{2}}\left(a+a^{*}\right)
$$

We also define two disjoint subspaces of $L^{2}(\mathbb{R})$ by

$$
\begin{aligned}
& \mathcal{C}_{0}=\operatorname{LH}\left\{e^{-\alpha x^{2} / 2} \mid \alpha \in(0,1)\right\} \\
& \mathcal{C}_{1}=\operatorname{LH}\left\{x e^{-\alpha x^{2} / 2} \mid \alpha \in(0,1)\right\}
\end{aligned}
$$

Note that $\mathcal{C}_{0} \perp \mathcal{C}_{1}$ and $\mathcal{C}_{0}+\mathcal{C}_{1}$ is dense. In this paper, \# denotes 0 or 1 . We transform $\mathcal{C}_{\#}$ to the subspaces of $\ell^{2}$ by $U$ defined by (2.1).
Lemma 4.1 Suppose that $0<\alpha<1$. Then

$$
\begin{aligned}
& U e^{-\alpha x^{2} / 2}=\pi^{1 / 4} \sqrt{\frac{2}{1+\alpha}} \exp \left(\frac{1-\alpha}{1+\alpha} \frac{a^{* 2}}{2}\right) \Omega \\
& U x e^{-\alpha x^{2} / 2}=\pi^{1 / 4} \sqrt{\frac{2}{1+\alpha}} \frac{\sqrt{2}}{1+\alpha} a^{*} \exp \left(\frac{1-\alpha}{1+\alpha} \frac{a^{* 2}}{2}\right) \Omega
\end{aligned}
$$

Proof: We set $\beta=(1-\alpha) / 2$. Since $U x U^{*}=\phi$ and $U e^{-x^{2} / 2}=\pi^{1 / 4} \Omega$, we have

$$
\begin{aligned}
U e^{-\alpha x^{2} / 2} & =U e^{-(\alpha-1) x^{2} / 2} U^{*} U e^{-x^{2} / 2}=\pi^{1 / 4} \sum_{n=0}^{\infty} \frac{1}{n!} \beta^{n} \phi^{2 n} \Omega \\
& =\pi^{1 / 4} \sum_{k=0}^{\infty}\left(\sum_{n \geq k} \frac{1}{(n-k)!} \frac{(2 n-1)!!}{2^{n-k}(2 k-1)!!} \beta^{n}\right) \frac{1}{k!} \frac{a^{* 2 k}}{2^{k}} \Omega \\
& =\pi^{1 / 4} \sum_{k=0}^{\infty} \frac{1}{\sqrt{1-\beta}}\left(\frac{\beta}{1-\beta}\right)^{k} \frac{1}{k!} \frac{a^{* 2 k}}{2^{k}} \Omega \\
& =\pi^{1 / 4} \sqrt{\frac{2}{1+\alpha}} \exp \left(\frac{1-\alpha}{1+\alpha} \frac{a^{* 2}}{2}\right) \Omega .
\end{aligned}
$$

Hence we have
$U x e^{-\alpha x^{2} / 2}=\pi^{1 / 4} \sqrt{\frac{2}{1+\alpha}} \phi \exp \left(\frac{1-\alpha}{1+\alpha} \frac{a^{* 2}}{2}\right) \Omega=\pi^{1 / 4} \sqrt{\frac{2}{1+\alpha}} \frac{\sqrt{2}}{1+\alpha} a^{*} \exp \left(\frac{1-\alpha}{1+\alpha} \frac{a^{* 2}}{2}\right) \Omega$.

Then the lemma is proven.
Disjoint sets of super coherent vectors is defined by

$$
\begin{aligned}
& \mathcal{S}_{0}=\operatorname{LH}\left\{e^{\beta a^{* 2} / 2} \Omega \mid \beta \in(0,1)\right\} \\
& \mathcal{S}_{1}=\operatorname{LH}\left\{a^{*} e^{\beta a^{* 2} / 2} \Omega \mid \beta \in(0,1)\right\} .
\end{aligned}
$$

Note that $\mathcal{S}_{0} \perp \mathcal{S}_{1}$ and $\mathcal{S}_{0} \cup \mathcal{S}_{1}$ is dense. Lemma 4.1 also shows that $U \mathcal{C}_{\#}=\mathcal{S}_{\#}$. In order to express $T_{A}$ in terms of $a$ and $a^{*}$, we need the inverse of $a^{*}$. The operator $a^{*-1}$ is defined by

$$
\begin{aligned}
& \mathrm{D}\left(a^{*-1}\right)=\left\{\sum_{n=0}^{\infty} c_{n} \xi_{n} \in \ell^{2} \mid c_{0}=0\right\}, \\
& a^{*-1} \sum_{n=1}^{\infty} c_{n} \xi_{n}=\sum_{n=1}^{\infty} \frac{c_{n}}{\sqrt{n}} \xi_{n-1} .
\end{aligned}
$$

We consider $\log \left(a^{*-1} a\right)$ and $\log \left(a a^{*-1}\right)$. Note that $a^{*-1}$ is well defined on $\operatorname{Ran} L^{*}$.
Lemma 4.2 We have (1) and (2).
(1) $\mathcal{S}_{0} \subset \mathrm{D}\left(\log \left(a^{*-1} a\right)\right)$ and

$$
\log \left(a^{*-1} a\right) e^{\beta a^{* 2} / 2} \Omega=(\log \beta) e^{\beta a^{* 2} / 2} \Omega, \quad 0<\beta<1
$$

(2) $\mathcal{S}_{1} \subset \mathrm{D}\left(\log \left(a a^{*-1}\right)\right)$ and

$$
\log \left(a a^{*-1}\right) a^{*} e^{\beta a^{* 2} / 2} \Omega=(\log \beta) a^{*} e^{\beta a^{* 2} / 2} \Omega, \quad 0<\beta<1
$$

Proof: Since $e^{\beta a^{* 2} / 2} \Omega$ is an eigenvector of $a^{*-1} a$ with the eigenvalue $\beta$, for all $n \in \mathbb{N}$, we see that $\left(\mathbb{1}-a^{*-1} a\right)^{n} e^{\beta a^{* 2} / 2} \Omega=(1-\beta)^{n} e^{\beta a^{* 2} / 2} \Omega$. Hence by the definition of $\log \left(a^{*-1} a\right)$ we obtain that $\log \left(a^{*-1} a\right) e^{\beta a^{* 2} / 2} \Omega=(\log \beta) e^{\beta a^{* 2} / 2} \Omega$. The proof of (2) is the same as that of (1).

Lemma 4.3 Both $\log \left(a^{*-1} a\right)$ and $\log \left(a a^{*-1}\right)$ are unbounded.
Proof: By Lemma 4.2, we can see that $e^{\beta a^{* 2} / 2} \Omega$ is an eigenvector of $\log \left(a^{*-1} a\right)$ with eigenvalues $\log \beta$. Similarly $a^{*} e^{\beta a^{* 2} / 2} \Omega$ is an eigenvector of $\log \left(a a^{*-1}\right)$ with eigenvalues $\log \beta$. Since $0<\beta<1$, we have

$$
\operatorname{Spec}\left(\log \left(a^{*-1} a\right)\right) \cap \operatorname{Spec}\left(\log \left(a a^{*-1}\right)\right) \supset(-\infty, 0)
$$

Hence the lemma follows.
We recall a definition of $\arctan (A)$ for a linear operator $A$.

Definition 4.4 Let $A$ be a linear operator on a Hilbert space $\mathcal{H}$. We define a linear operator $\arctan (A)$ as follows:

$$
\begin{aligned}
& \mathrm{D}(\arctan (A))=\left\{\varphi \in \bigcap_{k=0}^{\infty} \mathrm{D}\left(A^{2 k+1}\right) \left\lvert\, \lim _{K \rightarrow \infty} \sum_{k=0}^{K} \frac{(-1)^{k}}{2 k+1} A^{2 k+1} \varphi\right. \text { exists }\right\}, \\
& \arctan (A) \varphi=-\sum_{k=0}^{\infty} \frac{(-1)^{k}}{2 k+1} A^{2 k+1} \varphi, \quad \varphi \in \mathrm{D}(\arctan (A))
\end{aligned}
$$

Now we transform $T_{A}$ to an operator on $\ell^{2}$. Let

$$
\begin{aligned}
& \mathcal{M}_{0}=\operatorname{LH}\left\{x^{2 n} e^{-\alpha x^{2} / 2} \in L^{2}(\mathbb{R}) \mid n \in \mathbb{N}, \alpha \in(0,1)\right\} \\
& \mathcal{M}_{1}=\operatorname{LH}\left\{x^{2 n+1} e^{-\alpha x^{2} / 2} \in L^{2}(\mathbb{R}) \mid n \in \mathbb{N}, \alpha \in(0,1)\right\} .
\end{aligned}
$$

Subspaces $\mathcal{M}_{\#}$ are useful subspaces to consider the commutation relation between the harmonic oscillator and the angle operator:

$$
\begin{aligned}
& {\left[N,-\arctan \left(q^{-1} p\right)\right]=-i \mathbb{1} \quad \text { on } \mathcal{M}_{0},} \\
& {\left[N,-\arctan \left(p q^{-1}\right)\right]=-i \mathbb{1} \quad \text { on } \mathcal{M}_{1} .}
\end{aligned}
$$

We define $\mathcal{N}_{\#} \subset \ell^{2}$ by

$$
\begin{aligned}
& \mathcal{N}_{0}=\mathrm{LH}\left\{a^{* 2 n} e^{-\beta a^{* 2} / 2} \Omega \in \ell^{2} \mid n \in \mathbb{N}, \beta \in(0,1)\right\} \\
& \mathcal{N}_{1}=\mathrm{LH}\left\{a^{* 2 n+1} e^{-\beta a^{* 2} / 2} \Omega \in \ell^{2} \mid n \in \mathbb{N}, \beta \in(0,1)\right\}
\end{aligned}
$$

It is immediate to see that $U \mathcal{M}_{\#}=\mathcal{N}_{\#}$. We show algebraic relations we used often in this paper. Let $A$ and $B$ be linear operators. Then the algebraic relation

$$
A B f=B A f-\operatorname{ad}_{B}(A) f=\left(B-\operatorname{ad}_{B}\right) A f
$$

holds for $f \in \mathrm{D}(A B) \cap \mathrm{D}(B A)$. Hence $A B^{2}=\left(B-\mathrm{ad}_{B}\right)^{2} A$ on $\mathrm{D}\left(A B^{2}\right) \cap \mathrm{D}(B A B) \cap \mathrm{D}\left(B^{2} A\right)$ and then for any $n \in \mathbb{N}$ and any $f \in \bigcap_{k=0}^{n} \mathrm{D}\left(B^{k} A B^{n-k}\right)$,

$$
\begin{equation*}
A B^{n} f=\left(B-\operatorname{ad}_{B}\right)^{n} A f \tag{4.1}
\end{equation*}
$$

Lemma 4.5 The following relations hold:

$$
\begin{array}{ll}
U \arctan \left(q^{-1} p\right) U^{*}=-\frac{i}{2} \log \left(a^{*-1} a\right) & \text { on } \mathcal{N}_{0} \\
U \arctan \left(p q^{-1}\right) U^{*}=-\frac{i}{2} \log \left(a a^{*-1}\right) & \text { on } \mathcal{N}_{1}
\end{array}
$$

Proof: We see that by [10, Lemma 3.6]

$$
\arctan \left(q^{-1} p\right) x^{2 n} e^{-\alpha x^{2} / 2}=\frac{i}{2}\left\{\left(x^{2}-2 \frac{d}{d \alpha}\right)^{n} \log \left(\frac{1+\alpha}{1-\alpha}\right)\right\} e^{-\alpha x^{2} / 2}
$$

Then, by Lemma 4.1,

$$
\begin{align*}
& U \arctan \left(q^{-1} p\right) x^{2 n} e^{-\alpha x^{2} / 2} \\
& =-\frac{i}{2}\left\{\left(\phi^{2}-2 \frac{d}{d \alpha}\right)^{n} \log \left(\frac{1-\alpha}{1+\alpha}\right)\right\} \pi^{1 / 4} \sqrt{\frac{2}{1+\alpha}} \exp \left(\frac{1-\alpha}{1+\alpha} \frac{a^{* 2}}{2}\right) \Omega . \tag{4.2}
\end{align*}
$$

Let $Z=a^{*-1} a$. Since $\operatorname{ad}_{\phi^{2}}(Z)=-(1+Z)^{2}$ on $\mathcal{N}_{0}$, we have for any $m \in \mathbb{N}$ and any analytic function $F$,

$$
\operatorname{ad}_{\phi^{2}}^{m}(F(Z))=\left.\left\{\left(-(1+x)^{2} \frac{d}{d x}\right)^{m} F(x)\right\}\right|_{x=Z}
$$

on $\mathcal{N}_{0}$. Since $Z \exp \left(\beta a^{* 2} / 2\right) \Omega=\beta \exp \left(\beta a^{* 2} / 2\right) \Omega$, we see that $\exp \left(\beta a^{* 2} / 2\right) \Omega$ is also an eigenvector of $\operatorname{ad}_{\phi^{2}}^{m}(F(Z))$ and

$$
\left(\operatorname{ad}_{\phi^{2}}^{m} F(Z)\right) \exp \left(\frac{\beta}{2} a^{* 2}\right) \Omega=\left\{\left(-(1+\beta)^{2} \frac{d}{d \beta}\right)^{m} F(\beta)\right\} \exp \left(\frac{\beta}{2} a^{* 2}\right) \Omega .
$$

In particular

$$
\left(\operatorname{ad}_{\phi^{2}}^{m} F(Z)\right) \exp \left(\frac{1-\alpha}{1+\alpha} \frac{a^{* 2}}{2}\right) \Omega=\left\{\left(2 \frac{d}{d \alpha}\right)^{m} F\left(\frac{1-\alpha}{1+\alpha}\right)\right\} \exp \left(\frac{1-\alpha}{1+\alpha} \frac{a^{* 2}}{2}\right) \Omega .
$$

Moreover replacing $F(Z)$ with $\log Z$, it is obtained that

$$
\begin{equation*}
\left(\operatorname{ad}_{\phi^{2}}^{m} \log Z\right) \exp \left(\frac{1-\alpha}{1+\alpha} \frac{a^{* 2}}{2}\right) \Omega=\left\{\left(2 \frac{d}{d \alpha}\right)^{m} \log \left(\frac{1-\alpha}{1+\alpha}\right)\right\} \exp \left(\frac{1-\alpha}{1+\alpha} \frac{a^{* 2}}{2}\right) \Omega \tag{4.3}
\end{equation*}
$$

By (4.2) and (4.3), we have

$$
U \arctan \left(q^{-1} p\right) x^{2 n} e^{-\alpha x^{2} / 2}=-\frac{i}{2}\left\{\left(\phi^{2}-\operatorname{ad}_{\phi^{2}}\right)^{n} \log Z\right\} \pi^{1 / 4} \sqrt{\frac{2}{1+\alpha}} \exp \left(\frac{1-\alpha}{1+\alpha} \frac{a^{* 2}}{2}\right) \Omega
$$

From (4.1), we can furthermore see that

$$
\begin{aligned}
U \arctan \left(q^{-1} p\right) x^{2 n} e^{-\alpha x^{2} / 2} & =-\frac{i}{2}(\log Z) \phi^{2 n} \pi^{1 / 4} \sqrt{\frac{2}{1+\alpha}} \exp \left(\frac{1-\alpha}{1+\alpha} \frac{a^{* 2}}{2}\right) \Omega \\
& =-\frac{i}{2}(\log Z) U\left(x^{2 n} e^{-\alpha x^{2} / 2}\right)
\end{aligned}
$$

Then the first equality is proven. The second equality is similarly proven.

Let

$$
\begin{aligned}
S_{0} & =\frac{i}{2} \log \left(a^{*-1} a\right), \\
S_{1} & =\frac{i}{2} \log \left(a a^{*-1}\right)
\end{aligned}
$$

It is clear that $\mathrm{D}\left(S_{0}\right) \cap \mathrm{D}\left(S_{1}\right)=\{0\}$, and hence $\mathrm{D}\left(S_{0}+S_{1}\right)=\{0\}$. Then we define the ultra-weak time operator of $S_{0}+S_{1}$. For the self-consistency we show the definition of ultra-weak time operators below.

Definition 4.6 (Ultra-weak time operator [4]) Let $H$ be a self-adjoint operator on $\mathcal{H}$ and $D_{1}$ and $D_{2}$ be non-zero subspaces of $\mathcal{H}$. A sesqui-linear form

$$
\mathcal{T}: D_{1} \times D_{2} \rightarrow \mathbb{C}, \quad D_{1} \times D_{2} \ni(\varphi, \psi) \mapsto \mathcal{T}[\varphi, \psi] \in \mathbb{C}
$$

with domain $\mathrm{D}(\mathcal{T})=D_{1} \times D_{2}(\mathcal{T}[\varphi, \psi]$ is antilinear in $\varphi$ and linear in $\psi)$ is called an ultra-weak time operator of $H$ if there exist non-zero subspaces $D$ and $E$ of $D_{1} \cap D_{2}$ such that (1)-(3) below hold:
(1) $E \subset \mathrm{D}(H) \cap D$.
(2) $\overline{\mathcal{T}[\varphi, \psi]}=\mathcal{T}[\psi, \varphi]$ for all $\varphi, \psi \in D$.
(3) $H E \subset D_{1}$ and, for all $\psi, \varphi \in E$,

$$
\begin{equation*}
\mathcal{T}[H \varphi, \psi]-\overline{\mathcal{T}[H \psi, \varphi]}=-i(\varphi, \psi) \tag{4.4}
\end{equation*}
$$

We call $E$ an ultra-weak CCR-domain and $D$ a symmetric domain of $\mathcal{T}$.
Let us define an ultra-weak time operator of $N$ through $S_{0}$ and $S_{1}$. We define

$$
\begin{array}{ll}
\mathcal{T}_{0}[\varphi, \psi]=\frac{1}{2}\left\{\left(S_{0} \varphi, \psi\right)+\left(\varphi, S_{0} \psi\right)\right\}, & \varphi, \psi \in \mathcal{N}_{0} \\

\end{array}

and

\mathcal{T}=\mathcal{T}_{0} \oplus \mathcal{T}_{1} \tag{4.5}
\end{equation*}
$$

with symmetric domain $\left(\mathrm{D}\left(S_{0}\right) \times \mathrm{D}\left(S_{0}\right)\right) \oplus\left(\mathrm{D}\left(S_{1}\right) \times \mathrm{D}\left(S_{1}\right)\right)$. On the other hand let us define the ultra-weak time operator $\mathcal{T}_{A}$ associated with angle operator $T_{A}$ below. Let $h_{0}=\arctan \left(q^{-1} p\right)$ and $h_{1}=\arctan \left(p q^{-1}\right)$. We define

\mathcal{T}_{A 0}[\varphi, \psi]=\frac{1}{2}\left\{\left(h_{0} \varphi, \psi\right)+\left(\varphi, h_{0} \psi\right)\right\}, & \varphi, \psi \in \mathcal{N}_{0} \\
\mathcal{T}_{A 1}[\varphi, \psi]=\frac{1}{2}\left\{\left(h_{1} \varphi, \psi\right)+\left(\psi, h_{1} \varphi\right)\right\}, & \varphi, \psi \in \mathcal{N}_{1}
\end{array}
$$

and

$$
\begin{equation*}
\mathcal{T}_{A}=\mathcal{T}_{A 0} \oplus \mathcal{T}_{A 1} \tag{4.6}
\end{equation*}
$$

with symmetric domain $\left(\mathrm{D}\left(h_{0}\right) \times \mathrm{D}\left(h_{0}\right)\right) \oplus\left(\mathrm{D}\left(h_{1}\right) \times \mathrm{D}\left(h_{1}\right)\right)$.
Theorem 4.7 The ultra-weak time operator $\mathcal{T}_{A}$ of the harmonic oscillator on $L^{2}(\mathbb{R})$ is unitary equivalent to $\mathcal{T}$ on $\ell^{2}$ :

Proof: This follows from Lemma 4.5.

Remark 4.8 (4.7) in Theorem 4.9 can be interpreted as a rigorous justification of

The right-hand side can not be however defined as an operator by Lemma 3.2. Even if it is a formal argument, it is dangerous to base the argument on this equivalent relation.

### 4.2 Angle operator by shift operators

Let $L$ be the left shift operator defined in Section 2.3. The angle operator $T_{A}$ can be represented by $L$ and $N$. Let us define

Theorem 4.9 We have

S_{1}=L_{A 1} & \text { on } \mathcal{N}_{1} . \tag{4.9}
\end{array}

In particular

U \arctan \left(q^{-1} p\right) U^{*}=L_{A 0} & \text { on } \mathcal{N}_{0} \\
U \arctan \left(p q^{-1}\right) U^{*}=L_{A 1} & \text { on } \mathcal{N}_{1} \tag{4.11}
\end{array}
$$

Proof: We see that

a^{*-1} a=\left(\sqrt{N} L^{*}\right)^{-1} \sqrt{N+\mathbb{1}} L=L \sqrt{\frac{N+\mathbb{1}}{N}} L=\sqrt{\frac{N+2 \mathbb{1}}{N+\mathbb{1}}} L^{2}

on $\operatorname{Ran}\left(\mathbb{1}-P_{\left\{a^{*} \Omega\right\}}\right)$. Similarly

on $\operatorname{Ran}\left(\mathbb{1}-P_{\{\Omega\}}\right)$. From this we have (4.8) and (4.9). Relations (4.10) and (4.11) follow from Theorem 4.5.

### 4.3 Generalization of angle operator $\boldsymbol{T}_{\boldsymbol{A}}$

We generalize $L_{A 0}$ and $L_{A 1}$ to the form of $i \log \left(g(N) L^{2}\right)$. A fundamental idea is to find eigenvectors $\varphi$ of linear operator $\operatorname{ad}_{N}\left(\log \left(g(N) L^{2}\right)\right)$ so that $\operatorname{ad}_{N}\left(\log \left(g(N) L^{2}\right)\right) \varphi=a \varphi$ with $a \neq 0$. Then it follows that

on CCR-domain LH\{eigenvectors $\varphi\}$. Hereafter we write $g_{N}$ for $g(N)$. Let $P_{\geq 2}$ be the projection onto $\overline{\mathrm{LH}\left\{\xi_{n} \mid n \geq 2\right\}}$, and $P_{0}$ the projection onto $\overline{\mathrm{LH}\left\{\xi_{2 n} \mid n \in \mathbb{N}\right\}}$.

Lemma 4.10 Let $f$ and $g$ be complex-valued functions on $\mathbb{N}$, and $\alpha \in \mathbb{C}$. Suppose that there exists a constant $\beta \in \mathbb{C}$ such that

Proof: The relation (4.12) is equivalent to $\left[g_{N+2} L^{2}, f_{N} L^{* 2}\right]=\beta \mathbb{1}$ on $P_{0} \ell_{\mathrm{fin}}^{2}$. This implies that $\operatorname{ad}_{g_{N+2} L^{2}}\left(f_{N} L^{* 2}\right)^{n}=n \beta\left(f_{N} L^{* 2}\right)^{n-1}$ on $P_{0} \ell_{\text {fin }}^{2}$.

Lemma 4.11 Let $f$ be a complex-valued function on $\mathbb{N}$. Suppose that $|f(2 n)|>0$ for all natural number $n \geq 1$ and there exists a limit (including infinity)

Proof: Note that

$$

the radius of the convergence of above infinite series is given by $\left.\lim _{n \rightarrow \infty} n / \mid f(2 n+2 m)\right) \mid=$ $M_{f}$. Then the lemma follows.

g_{N+2} L^{2} e^{\alpha f_{N} L^{* 2}} \Omega=\alpha \beta e^{\alpha f_{N} L^{* 2}} \Omega \tag{4.13}
\end{equation*}

Proof: We have

\left\|\left(g_{N+2} L^{2}\right)^{l} N^{m}\left(f_{N} L^{* 2}\right)^{m} e^{\alpha f_{N} L^{* 2}} \Omega\right\|^{2}=\sum_{n=0}^{\infty} \frac{|\alpha|^{2 n}}{(n!)^{2}}\left\|\left(g_{N+2} L^{2}\right)^{l} N^{m}\left(f_{N} L^{* 2}\right)^{(n+m)} \Omega\right\|^{2}
$$

Since

& \left(g_{N+2} L^{2}\right)^{l} N^{m}\left(f_{N} L^{* 2}\right)^{(n+m)} \Omega \\
& = \begin{cases}\left(\prod_{j=n+m-l+1}^{n+m} g_{2 j}\right)(2(n+m))^{m}\left(\prod_{j=1}^{n+m} f_{2 j}\right) L^{* 2(n+m-l)} \Omega, & n+m \geq l \\
0, & n+m<l\end{cases}
\end{aligned}
$$

the right-hand side above converges for $\alpha \in \mathbb{C}$ such that $|\alpha|<M_{f}$. From Lemma 4.10, we can also see that $e^{\alpha f_{N} L^{* 2}} \Omega$ is an eigenvector of $g_{N+2} L^{2}$ and (4.13) follows.

We define the super coherent vector $\xi_{\alpha, f}$ by

Lemma 4.13 Let $f$ and $g$ be complex-valued functions on $\mathbb{N}$ such that (4.12) is satisfied. Then for all $n \in \mathbb{N}$ and $\alpha \in \mathbb{D}_{f, \beta}$, we have $\left(f_{N} L^{* 2}\right)^{n} \xi_{\alpha, f} \in \mathrm{D}\left(\log \left(g_{N+2} L^{2}\right)\right)$ and

\log \left(g_{N+2} L^{2}\right)\left(f_{N} L^{* 2}\right)^{n} \xi_{\alpha, f}=\left\{\left(f_{N} L^{* 2}+\frac{d}{d \alpha}\right)^{n}(\log \alpha \beta)\right\} \xi_{\alpha, f}
$$

Proof: By Lemma 4.12 we have $\left(f_{N} L^{* 2}\right)^{n} \xi_{\alpha, f} \in \bigcap_{m=0}^{\infty} \mathrm{D}\left(\left(1-g_{N+2} L^{2}\right)^{m}\right)$. From (4.1) and (4.3) it follows that

& \quad=-\sum_{k=1}^{K} \frac{1}{k}\left\{\left(f_{N} L^{* 2}-\operatorname{ad}_{f_{N} L^{* 2}}\right)^{n}\left(1-g_{N+2} L^{2}\right)^{k}\right\} \xi_{\alpha, f} \\
& \quad=-\sum_{k=1}^{K} \frac{1}{k}\left\{\left(f_{N} L^{* 2}+\frac{d}{d \alpha}\right)^{n}(1-\alpha \beta)^{k}\right\} \xi_{\alpha, f} \rightarrow\left\{\left(f_{N} L^{* 2}+\frac{d}{d \alpha}\right)^{n}(\log \alpha \beta)\right\} \xi_{\alpha, f}
\end{aligned}
$$

as $K \rightarrow \infty$. Then the proof is complete.
The next theorem is a generalization of (1) of Lemma 4.2.
Theorem 4.14 Let $f$ and $g$ be complex-valued functions on $\mathbb{N}$ such that (4.12) is satisfied. Then,

holds on CCR-domain $\operatorname{LH}\left\{\left(f_{N} L^{* 2}\right)^{n} \xi_{\alpha, f} \mid n \in \mathbb{N}, \alpha \in \mathbb{D}_{f, \beta}\right\}$.
Proof: In this proof we set $X=f_{N} L^{* 2}$ and $Y=g_{N+2} L^{2}$. From Lemmas 4.11, 4.12 and 4.13, we see that, for all $n \in \mathbb{N}$,

& =\left\{N(\log Y) X^{n}-\frac{2}{\beta} Y\left(X-\operatorname{ad}_{X}\right)^{n} \operatorname{ad}_{X}(\log Y)\right\} \xi_{\alpha, f} \\
& =\left\{N(\log Y) X^{n}-\frac{2}{\beta}\left(X-\operatorname{ad}_{X}\right)^{n} Y \operatorname{ad}_{X}(\log Y)\right\} \xi_{\alpha, f}
\end{aligned}
$$

Here we used $Y\left(X-\operatorname{ad}_{X}\right) Z \varphi=\left(X-\operatorname{ad}_{X}\right) Y Z \varphi$ for any linear operator $Z$ and any $\varphi \in$ $\mathrm{D}(X Y Z) \cap \mathrm{D}(Y X Z) \cap \mathrm{D}(Y Z X)$. In a similar way to (4.3), we can obtain that

Hence $\left[N, \frac{i}{2} \log Y\right] X^{n} \xi_{\alpha, f}=-i X^{n} \xi_{\alpha, f}$ follows and (4.15) is proven.
We can also see a generalization of (2) of Lemma 4.2.
Theorem 4.15 Let $\tilde{h}$ be a complex-valued function on $\mathbb{N}$ such that $\tilde{h}_{N+1}^{-1}$ is bounded and $\tilde{f}$ and $\tilde{g}$ be complex-valued functions on $\mathbb{N}$ such that

on $P_{0} \ell_{\mathrm{fin}}^{2}$ with some $\tilde{\beta} \in \mathbb{C}$. Let

\mathbb{D}_{\tilde{f}, \tilde{h}, \tilde{\beta}}=\left\{\alpha \in \mathbb{C} \mid \alpha \in \mathbb{D}_{\tilde{f}, \tilde{\beta}}, \xi_{\alpha, \tilde{f}} \in \bigcap_{n=0}^{\infty} \mathrm{D}\left(\tilde{g}_{N+3} \tilde{h}_{N+3}\left(\tilde{f}_{N} L^{* 2}\right)^{n}\right)\right\} \tag{4.16}
\end{equation*}
$$

Then $\tilde{h}_{N} L^{*} \xi_{\alpha, \tilde{f}}$ is an eigenvector of $\tilde{g}_{N+2} L^{2}$ such that

\begin{equation*}
\tilde{g}_{N+2} L^{2} \tilde{h}_{N} L^{*} \xi_{\alpha, \tilde{f}}=\alpha \tilde{\beta} \tilde{h}_{N} L^{*} \xi_{\alpha, \tilde{f}} . \tag{4.17}
\end{equation*}
$$

Furthermore it follows that

\end{equation*}

on CCR-domain $\operatorname{LH}\left\{\tilde{h}_{N} L^{*}\left(\tilde{f}_{N} L^{* 2}\right)^{n} \xi_{\alpha, \tilde{f}} \mid n \in \mathbb{N}, \alpha \in \mathbb{D}_{\tilde{f}, \tilde{h}, \tilde{\beta}}\right\}$.

Proof: By the following equalities

on $P_{0} \ell^{2} \cap \mathrm{D}\left(\tilde{g}_{N+1} \tilde{h}_{N+1}\right)$, one can show (4.17) in a similar manner to the proof of (4.12) by replacing $g_{N+2}$ of (4.12) with $\tilde{h}_{N+1}^{-1} \tilde{g}_{N+3} \tilde{h}_{N+3}$. The proof of (4.18) is also similar to those of Lemma 4.12 and Theorem 4.14.

By Theorems 4.14 and 4.15 we can also construct an ultra-weak time operator of $N$. This is a generarization of $\mathcal{T}$ in (4.5). Let $f, \tilde{f}, g, \tilde{g}$ and $h$ be functions on $\mathbb{N}$ given in Theorems 4.14 and 4.15. Let

& \mathcal{K}_{1}=\mathrm{LH}\left\{\tilde{h}_{N} L^{*}\left(\tilde{f}_{N} L^{* 2}\right)^{n} \xi_{\alpha, \tilde{f}} \mid n \in \mathbb{N}, \alpha \in \mathbb{D}_{\tilde{f}, \tilde{h}, \tilde{\beta}}\right\} .
\end{aligned}
$$

Note that $\mathcal{K}_{0} \oplus \mathcal{K}_{1}$ is dense if $\mathbb{D}_{f, \beta} \neq \emptyset$ and $\mathbb{D}_{\tilde{f}, \tilde{h}, \tilde{\beta}} \neq \emptyset$. Let

\mathcal{T}_{1 \tilde{g}}[\varphi, \psi]=\frac{1}{2}\left\{\left(S_{1 \tilde{g}} \varphi, \psi\right)+\left(\varphi, S_{1 \tilde{g}} \psi\right)\right\}, & \varphi, \psi \in \mathcal{K}_{1}
\end{array}
$$

and set

$$
\begin{equation*}
\mathcal{T}_{g, \tilde{g}}=\mathcal{T}_{0 g} \oplus \mathcal{T}_{1 \tilde{g}} \tag{4.19}
\end{equation*}
$$

Theorem 4.16 Suppose that $f, \tilde{f}, g, \tilde{g}$ and $\tilde{h}$ satisfy the assumptions given in Theorem 4.14 and Lemma 4.15. We also assume that $\mathbb{D}_{f, \beta} \neq \emptyset$ and $\mathbb{D}_{\tilde{f}, \tilde{h}, \tilde{\beta}} \neq \emptyset$. Then $\mathcal{T}_{g, \tilde{g}}$ is an ultra-weak time operator of $N$ with a dense CCR-domain $\mathcal{K}_{0} \oplus \mathcal{K}_{1}$.

Proof: This follows from (4.15) and (4.18).

### 4.4 Conjugate operators of the form $\log p(L)$

In the previous section we consider the conjugate operator of the form $\log \left(g_{N} L^{2}\right)$. Another direction of generalizations is to consider conjugate operators of the form $\log \left(g_{N} L^{n}\right)$. In
special cases it can be reduced to consider conjugate operators of $\log \left(g_{N} L^{n}\right)$ to those of $\log \left(L^{n}\right)$. See Lemma 4.17 below. Let $f$ be a function on $\mathbb{N}$ and

f!_{k}(N) \xi_{n}=\left(\prod_{m=0}^{[n / k]} f_{n-k m}\right) \xi_{n}, \quad n \in \mathbb{N}
$$

We extend $f!_{k}(N)$ to $\ell_{\text {fin }}^{2}$ by the linearity and denote the closure of $f!_{k}(N) \Gamma_{\ell_{\text {fin }}^{2}}$ by the same symbol $f!_{k}(N)$.

Lemma 4.17 Let $f$ and $g$ be complex-valued functions on $\mathbb{N}$ such that $f_{n} g_{n}=n$ for all $n \in \mathbb{N}$. Suppose that $\alpha \in(0,1)$ and $\Omega \in \mathrm{D}\left(e^{\alpha f_{N} L^{* k}}\right)$. Then

$$
\begin{equation*}
\log \left(g_{N+k} L^{k}\right) e^{\alpha f_{N} L^{* k}} \Omega=f!_{k}(N) \log \left((N+k \mathbb{1}) L^{k}\right) e^{\alpha L^{* k}} \Omega \tag{4.20}
\end{equation*}
$$

In particular, setting $h_{n}=n$ for all $n \in \mathbb{N}$, we have

$$
\begin{align*}
& \left(\log L^{k}\right) e^{\alpha N L^{* k}} \Omega=h!_{k}(N) \log \left((N+k \mathbb{1}) L^{k}\right) e^{\alpha L^{* k}} \Omega  \tag{4.21}\\
& \log \left(g_{N+k} L^{k}\right) e^{\alpha f_{N} L^{* k}} \Omega=h!_{k}(N)^{-1} f!_{k}(N)\left(\log L^{k}\right) e^{\alpha N L^{* k}} \Omega \tag{4.22}
\end{align*}
$$

Proof: It is straightforward to see that

$$
\begin{aligned}
\log \left(g_{N+k} L^{k}\right) e^{\alpha f_{N} L^{* k}} \Omega & =\log \left(g_{N+k} L^{k}\right) f!_{k}(N) e^{\alpha L^{* k}} \Omega \\
& =f!_{k}(N) \log \left(g_{N+k} f_{N+k} L^{k}\right) e^{\alpha L^{* k}} \Omega \\
& =f!_{k}(N) \log \left((N+k \mathbb{1}) L^{k}\right) e^{\alpha L^{* k}} \Omega .
\end{aligned}
$$

Putting $g_{n}=1$ for all $n \in \mathbb{N}$ in (4.20), we can derive (4.21). Combining (4.20) and (4.21) we can also see (4.22). Then the lemma follows.

By (4.22), $\log \left(g_{N+k} L^{k}\right)$ can be represented as $C(N) \log L^{k}$ on $\operatorname{LH}\left\{e^{\alpha N L^{* k}} \Omega\right\}$ with

$$
C(N)=h!_{k}(N)^{-1} f!_{k}(N)
$$

Since the operator $C(N)$ commutes with $N$, the investigation of conjugate operators of the form $\log \left(g_{N+k} L^{k}\right)$ can be reduced to that of $\log L^{k}$ on $\operatorname{LH}\left\{L^{* n k} e^{\alpha N L^{* k}} \Omega|n \in \mathbb{N},|\alpha|<1\}\right.$.

Example 4.18 We see that $T_{A} \cong L_{A 0} \oplus L_{A 1}$ with $L_{A 0}=\frac{i}{2} \log \left(\sqrt{\frac{N+2 \mathbb{1}}{N+\mathbb{1}}} L^{2}\right)$ and $L_{A 1}=$ $\frac{i}{2} \log \left(\sqrt{\frac{N+11}{N+21}} L^{2}\right)$. By Lemma 4.17 to investigate the $C C R$-domain of $L_{A 0}$ and $L_{A 1}$ can be reduced to investigate the CCR-domain of $\frac{i}{2} \log L^{2}$.

Thus from now on we study the conjugate operator of the form $\log p(L)$. The idea to find a CCR-domain of $\log p(L)$ is similar to that of the previous subsection. Formally

$$
[N, \log p(L)] \subset-p(L)^{-1} p^{\prime}(L) L
$$

and $e^{\alpha N L^{*}} \Omega$ is an eigenvector of $L$ and that of $p(L)$. Thus $[N, \log p(L)]=-p(\alpha)^{-1} p^{\prime}(\alpha) \alpha$ on $\operatorname{LH}\left\{e^{\alpha N L^{*}} \Omega\right\}$. To solve $[N, \log p(L)]=c$ we study the algebraic equation of the form

$$
\alpha p^{\prime}(\alpha)+c p(\alpha)=0
$$

with some $c \in \mathbb{C}$. Then we set

$$
\begin{aligned}
& \mathrm{D}(p, c) \\
& =\operatorname{LH}\left\{\varphi \in \mathrm{D}(N) \mid \exists \alpha \in \mathbb{C} \text { s.t. }|p(\alpha)-1|<1, \alpha p^{\prime}(\alpha)+c p(\alpha)=0, \varphi \in \operatorname{Ker}(L-\alpha \mathbb{1})\right\} .
\end{aligned}
$$

It may be possibly $\mathrm{D}(p, c)=\{0\}$.
Theorem 4.19 Let $p$ be a polynomial and $c \in \mathbb{C} \backslash\{0\}$. If there exists $\alpha \in \mathbb{C}$ such that $|\alpha|<1, \alpha p^{\prime}(\alpha)+c p(\alpha)=0$ and $|p(\alpha)-1|<1$, then $\mathrm{D}(p, c) \neq\{0\}$ and

$$
\left[N,-\frac{i}{c} \log p(L)\right]=-i \mathbb{1}
$$

with CCR-domain $\mathrm{D}(p, c)$. Moreover, in $\mathrm{D}\left(\sum k^{-1} N(\mathbb{1}-p(L))^{k}\right)$, there is no infinite dimensional CCR-domain for $N$ and $c \log p(L)$ unless $p(x)=c x^{m}$ for some $c \in \mathbb{C}$ and $m \in \mathbb{N}$.

Proof: We can see that

$$
\begin{equation*}
[N, \log p(L)]=-\sum_{k=1}^{\infty} \frac{1}{k}\left[N,(\mathbb{1}-p(L))^{k}\right]=-\sum_{k=1}^{\infty}(\mathbb{1}-p(L))^{k-1} L p^{\prime}(L) \tag{4.23}
\end{equation*}
$$

on $\mathrm{D}\left(\sum k^{-1} N(\mathbb{1}-p(L))^{k}\right) \cap \mathrm{D}(N \log p(L)) \cap \mathrm{D}(\log p(L) N)$. Let $\varphi \in \operatorname{Ker}(L-\alpha \mathbb{1})$. Then

$$
[N, \log p(L)] \varphi=-\alpha p^{\prime}(\alpha) p(\alpha)^{-1} \varphi
$$

By $\alpha p^{\prime}(\alpha)+c p(\alpha)=0$ we see that

$$
[N, \log p(L)] \varphi=c \varphi
$$

Next we shall show that the dimension of the CCR-domain in $\operatorname{Ran}(p(L))$ is finite. For any

$$
\varphi \in \mathrm{D}\left(\sum_{k \geq 1} \frac{1}{k} N(\mathbb{1}-p(L))^{k}\right)
$$

in the CCR-domain, there exists $c \in \mathbb{C}$ such that $[N, \log p(L)] \varphi=c \varphi$. From (4.23), we see that $\lim _{k \rightarrow \infty}(\mathbb{1}-p(L))^{k} L p^{\prime}(L) \varphi=0$. Therefore,

$$
c p(L) \varphi=p(L)[N, \log p(L)] \varphi=-\sum_{k=1}^{\infty} p(L)(\mathbb{1}-p(L))^{k-1} L p^{\prime}(L) \varphi=-L p^{\prime}(L) \varphi
$$

Thus $\varphi \in \operatorname{Ker}\left(L p^{\prime}(L)+c p(L)\right)$. This implies that the CCR-domain is at most finite dimensional space, since $\operatorname{dim} \operatorname{Ker}(L-\lambda \mathbb{1})^{k} \leq k$ for all $\lambda \in \mathbb{C}$ and $k \in \mathbb{N}$, and $p$ is a polynomial with $L p^{\prime}(L)+c p(L) \neq 0$. This fact can be derived from a fundamental lemma below. Then the theorem follows.

Lemma 4.20 Let $A$ be a bounded operator on a Banach space $\mathcal{K}$. Let $\left\{n_{1}, \ldots, n_{k}\right\} \subset \mathbb{N}$, $\left\{\lambda_{1}, \ldots, \lambda_{k}\right\} \subset \mathbb{C}$ such that $\lambda_{i} \neq \lambda_{j}$ for $i \neq j$. Then it follows that

$$
\operatorname{Ker}\left(\prod_{j=1}^{k}\left(\lambda_{j} \mathbb{1}-A\right)^{n_{j}}\right)=\bigoplus_{j=1}^{k} \operatorname{Ker}\left(\lambda_{j} \mathbb{1}-A\right)^{n_{j}}
$$

Proof: We refer to [2, Lemma 1.76].

## 5 Galapon operators

### 5.1 Galapon operators by shift operators

In this section we investigate Galapon operator which is a bounded self-adjoint time operator. Recall that $\operatorname{Spec}(N)=\{n\}_{n \in \mathbb{N}}$ and $\left\{v_{n}\right\}_{n \in \mathbb{N}}$ the set of normalized eigenvectors of $N$ in $L^{2}(\mathbb{R})$. We define $T_{G}$ by

$$
\begin{align*}
& \mathrm{D}\left(T_{G}\right)=\mathrm{LH}\left\{v_{n} \mid n \in \mathbb{N}\right\}, \\
& T_{G} \varphi=i \sum_{n=0}^{\infty}\left(\sum_{m \neq n} \frac{\left(v_{m}, \varphi\right)}{n-m} v_{n}\right), \quad \varphi \in \mathrm{D}\left(T_{G}\right) . \tag{5.1}
\end{align*}
$$

It is known that $T_{G}$ is bounded and

$$
\begin{equation*}
\left[N, T_{G}\right]=-i \mathbb{1} \tag{5.2}
\end{equation*}
$$

on a dense CCR-domain $\operatorname{LH}\left\{v_{n}-v_{m} \mid n, m \in \mathbb{N}\right\}$ (see [5]). In particular, $T_{G}$ is not equal to the angle operator $T_{A}$. The angle operator $T_{A}$ is expressed on $\ell^{2}$ by Theorem 4.9. On the other hand the Galapon operator is given by (5.1). As it is, no comparison of $T_{A}$ and $T_{G}$ can be made, so we shall transform $T_{G}$ to an operator on $\ell^{2}$. Let us consider $\log (\mathbb{1}-L)$ and $\log \left(\mathbb{1}-L^{*}\right)$.

Lemma 5.1 We have $\ell_{\mathrm{fin}}^{2} \subset \mathrm{D}(\log (\mathbb{1}-L)) \cap \mathrm{D}\left(\log \left(\mathbb{1}-L^{*}\right)\right)$.
Proof: By the definition of $\log (\mathbb{1}-L)$, we see that

$$
\log (\mathbb{1}-L) \xi_{n}=-\sum_{k=1}^{\infty} \frac{1}{k} L^{k} \xi_{n}=-\sum_{k=1}^{n} \frac{1}{k} \xi_{n-k} .
$$

Thus $\xi_{n} \in \mathrm{D}(\log (\mathbb{1}-L))$ and hence $\ell_{\mathrm{fin}}^{2} \subset \mathrm{D}(\log (\mathbb{1}-L))$. We also see that

$$
\log \left(\mathbb{1}-L^{*}\right) \xi_{n}=-\sum_{k=1}^{\infty} \frac{1}{k} L^{* k} \xi_{n}=-\sum_{k=1}^{\infty} \frac{1}{k} \xi_{n+k}
$$

and

$$
\left\|\log \left(\mathbb{1}-L^{*}\right) \xi_{n}\right\|^{2}=\sum_{k=1}^{\infty} \frac{1}{k^{2}}<\infty
$$

Thus $\xi_{n} \in \mathrm{D}\left(\log \left(\mathbb{1}-L^{*}\right)\right)$ and $\ell_{\mathrm{fin}}^{2} \subset \mathrm{D}\left(\log \left(\mathbb{1}-L^{*}\right)\right)$.

Remark 5.2 By the proof of Lemma 5.1 we see that
(1) $\ell_{\mathrm{fin}}^{2} \subset \mathrm{D}\left(\log \left(\mathbb{1}-L^{*}\right)\right)$, but $\mathrm{D}\left(\log L^{*}\right) \cap \ell_{\mathrm{fin}}^{2}=\{0\}$,
(2) $\log (\mathbb{1}-L) \ell_{\mathrm{fin}}^{2} \subset \ell_{\mathrm{fin}}^{2}$.

We consider the following operator $L_{G}$.
Definition 5.3 We define a linear operator $L_{G}$ on $\ell^{2}$ by

$$
\begin{aligned}
& \mathrm{D}\left(L_{G}\right)=\left\{\varphi \in \ell^{2} \left\lvert\, \lim _{K \rightarrow \infty} \sum_{k=1}^{K} \frac{1}{k}\left(L^{* k}-L^{k}\right) \varphi\right. \text { exists }\right\}, \\
& L_{G} \varphi=i \sum_{k=1}^{\infty} \frac{1}{k}\left(L^{* k}-L^{k}\right) \varphi, \quad \varphi \in \mathrm{D}\left(L_{G}\right) .
\end{aligned}
$$

Note that $\ell_{\text {fin }}^{2} \subset \mathrm{D}\left(L_{G}\right)$ and $i\left\{\log (\mathbb{1}-L)-\log \left(\mathbb{1}-L^{*}\right)\right\} \subset L_{G}$.
Theorem 5.4 (1) It holds that $L_{G} \cong T_{G}$ on $\ell_{\text {fin }}^{2}$.
(2) $L_{G}$ is a bounded operator.

Proof: (1) Let $U$ be the unitary operaotr defined by $U v_{n}=\xi_{n}$ for each $n \in \mathbb{N}$. For arbitrary $\varphi \in \mathrm{D}\left(T_{G}\right)$, we see that

$$
\begin{aligned}
U T_{G} \varphi & =i \sum_{n=0}^{\infty}\left(\sum_{m<n} \frac{\left(\xi_{m}, U \varphi\right)}{n-m}+\sum_{m>n} \frac{\left(\xi_{m}, U \varphi\right)}{n-m}\right) \xi_{n} \\
& =i \sum_{n=0}^{\infty}\left(\sum_{m<n} \frac{\left(L^{n-m} \xi_{n}, \varphi\right)}{n-m}-\sum_{m>n} \frac{\left(L^{* m-n} \xi_{n}, U \varphi\right)}{m-n}\right) \xi_{n} \\
& =i \sum_{n=0}^{\infty}\left(\sum_{k=1}^{\infty} \frac{\left(L^{k} \xi_{n}, U \varphi\right)}{k}-\sum_{k=1}^{\infty} \frac{\left(L^{* k} \xi_{n}, U \varphi\right)}{k}\right) \xi_{n} .
\end{aligned}
$$

From Lemma 5.1, we have $U \mathrm{D}\left(T_{G}\right)=\ell_{\text {fin }}^{2} \subset \mathrm{D}\left(L_{G}\right)$. Then

$$
U T_{G} \varphi=i \sum_{n=0}^{\infty}\left(\sum_{k=1}^{\infty} \frac{1}{k}\left(L^{k}-L^{* k}\right) \xi_{n}, U \varphi\right) \xi_{n}=\sum_{n=0}^{\infty}\left(\xi_{n}, i \sum_{k=1}^{\infty} \frac{1}{k}\left(L^{* k}-L^{k}\right) U \varphi\right) \xi_{n}
$$

This implies that $U T_{G} \varphi=L_{G} U \varphi$ for $\varphi \in \mathrm{D}\left(T_{G}\right)$.
(2) From the Hilbert inequality, we see that, for any $\varphi=\sum_{n} c_{n} \xi_{n} \in \mathrm{D}\left(L_{G}\right)$,

$$
\left|\left(\varphi, L_{G} \varphi\right)\right|=\left|\sum_{n=0}^{\infty} \sum_{m \neq n} \frac{c_{n} c_{m}}{n-m}\right| \leq \pi\|\varphi\|^{2}
$$

Thus we have $\left\|L_{G} \varphi\right\| \leq \pi\|\varphi\|$. Then the theorem is proven.

Theorem 5.5 We have $\left[N, L_{G}\right]=-i \mathbb{1}$ on $\mathrm{D}\left(N L_{G}\right) \cap \mathrm{D}\left(L_{G} N\right)$.
Proof: We obtain that, for any $\varphi \in \mathrm{D}\left(N L_{G}\right) \cap \mathrm{D}\left(L_{G} N\right)$,

$$
\begin{align*}
{\left[N, L_{G}\right] \varphi } & =\sum_{n=0}^{\infty}\left(\xi_{n},\left(N L_{G}-L_{G} N\right) \varphi\right) \xi_{n} \\
& =i \sum_{n=0}^{\infty} \sum_{k=1}^{\infty} \frac{1}{k}\left(\xi_{n},\left(\left[N, L^{* k}\right]-\left[N, L^{k}\right]\right) \varphi\right) \xi_{n} \\
& =i \sum_{n=0}^{\infty} \sum_{k=1}^{\infty}\left(\xi_{n},\left(L^{* k}+L^{k}\right) \varphi\right) \xi_{n} \tag{5.3}
\end{align*}
$$

Let $\varphi=\sum_{n=0}^{\infty} c_{n} \xi_{n}$. Since $\sum_{n=0}^{\infty} \sum_{k=1}^{\infty}\left(\xi_{n},\left(L^{* k}+L^{k}\right) \varphi\right) \xi_{n}=\sum_{n=0}^{\infty}\left(\sum_{m \neq n} c_{m}\right) \xi_{n}$, we have

$$
\infty>\left\|\left[N, L_{G}\right] \varphi\right\|^{2}=\sum_{n=0}^{\infty}\left|\left(\sum_{m \neq n} c_{m}\right)\right|^{2}
$$

In particular

$$
\left\|\sum_{n=0}^{\infty}\left(\sum_{m \neq n} c_{m}\right) \xi_{n}+\varphi\right\|^{2}=\sum_{n=0}^{\infty}\left|\sum_{m=0}^{\infty} c_{m}\right|^{2}<\infty
$$

which implies that $\varphi \in\left\{\sum_{n=0}^{\infty} c_{n} \xi_{n} \in \ell^{2} \mid \sum_{n=0}^{\infty} c_{n}=0\right\}$, and

$$
\sum_{n=0}^{\infty} \sum_{k=1}^{\infty}\left(\xi_{n},\left(L^{* k}+L^{k}\right) \varphi\right) \xi_{n}=-\varphi
$$

Hence $\left[N, L_{G}\right] \varphi=-i \varphi$ and the theorem is proven.
It is immediate to see that $\left[N, T_{G}\right] \phi=-i \phi$ does not hold true for $\phi=v_{n}, n \in \mathbb{N}$. It is however shown in [9] that a CCR-domain of $T_{G}$ is $\operatorname{LH}\left\{v_{n}-v_{m} \mid n, m \in \mathbb{N}\right\}$. Note that

$$
U\left(\operatorname{LH}\left\{v_{n}-v_{m} \mid n, m \in \mathbb{N}\right\}\right)=\left(\mathbb{1}-L^{*}\right) \ell_{\mathrm{fin}}^{2}
$$

Hence $\left[N, L_{G}\right]=-i \mathbb{1}$ holds on $\left(\mathbb{1}-L^{*}\right) \ell_{\text {fin }}^{2}$ and $\left(\mathbb{1}-L^{*}\right) \ell_{\text {fin }}^{2} \subset \mathrm{D}\left(N L_{G}\right) \cap \mathrm{D}\left(L_{G} N\right)$.

Remark 5.6 To our knowledge, it was previously unknown that $\left[N, L_{G}\right]=-i \mathbb{1}$ holds on a strictly larger subspace than $\left(\mathbb{1}-L^{*}\right) \ell_{\text {fin }}^{2}$. It can be shown however that the CCR-domain $\mathrm{D}\left(N L_{G}\right) \cap \mathrm{D}\left(L_{G} N\right)$ of $L_{G}$ is strictly larger than $\left(\mathbb{1}-L^{*}\right) \ell_{\mathrm{fin}}^{2}$. It can be actually seen that $\left(\mathbb{1}-L^{*}\right) e^{\alpha L^{*}} \Omega \in\left(\mathrm{D}\left(L_{G} N\right) \cap \mathrm{D}\left(N L_{G}\right)\right) \backslash\left(\mathbb{1}-L^{*}\right) \ell_{\text {fin }}^{2}$ for $\alpha \neq 0$.

Remark 5.7 In (5.3), if $\varphi \in \operatorname{Ran}\left(\mathbb{1}-L^{*}\right)$, then we have

$$
\begin{equation*}
\left[N, L_{G}\right] \varphi=i \sum_{n=0}^{\infty} \sum_{k=1}^{\infty}\left(\xi_{n},\left(L^{* k}+L^{k}\right) \varphi\right) \xi_{n}=i\left(\left(\mathbb{1}-L^{*}\right)^{-1}+(\mathbb{1}-L)^{-1}-2 \mathbb{1}\right) \varphi . \tag{5.4}
\end{equation*}
$$

(5.4) can be extended in (5.8).

### 5.2 Generalization of Galapon operator $T_{G}$

In Theorem 5.4 we show that $T_{G}$ can be expressed as $i\left\{\log (\mathbb{1}-L)-\log \left(\mathbb{1}-L^{*}\right)\right\}$ on $\ell_{\text {fin }}^{2}$. We shall generalize this. We set

$$
L_{g}=i\left\{\log \left(\mathbb{1}-g_{N} L\right)-\log \left(\mathbb{1}-L^{*} g_{N}^{-1}\right)\right\} .
$$

Lemma 5.8 Let $g$ be a complex-valued function on $\mathbb{N}$ such that $\left|g_{n}\right|=1$ for all $n \in \mathbb{N}$. Then $L_{g}$ is unitary equivalent to $L_{G}$ on $\ell_{\text {fin }}^{2}$.
Proof: We can construct the unitary operator $V$ on $\ell^{2}$ such that $g_{N} L=V^{*} L V$. It is actually given by

$$
V\left(c_{0}, c_{1}, c_{2}, c_{3}, \ldots,\right)=\left(c_{0}, g_{0} c_{1}, g_{0} g_{1} c_{2}, g_{0} g_{1} g_{2} c_{3}, \ldots,\right)
$$

Since $\left|g_{n}\right|=1, V$ is unitary. Thus $L_{g}$ is unitary equivalent to $L_{G}$.
Let $\ell_{1}^{2}(g)=\left\{\sum_{n=0}^{\infty} c_{n} \xi_{n} \in \ell^{2} \mid \sum_{n=0}^{\infty} g!(n) c_{n}=0\right\}$, where $g!(n)=\prod_{k \leq n} g_{k}$.
Theorem 5.9 Let $g$ be a complex-valued function on $\mathbb{N}$.
(1) Suppose that $\left|g_{n}\right|>0$ for all $n \in \mathbb{N}$. Then $\left[N, L_{g}\right]=-i \mathbb{1}$ on $\mathrm{D}\left(N L_{g}\right) \cap \mathrm{D}\left(L_{g} N\right)$.
(2) Suppose that $\left|g_{n}\right|=1$ for all $n \in \mathbb{N}$. Then $L_{g}$ is a bounded time operator with CCRdomain $\mathrm{D}\left(N L_{g}\right) \cap \mathrm{D}\left(L_{g} N\right)$.
Proof: As in the proof of Theorem 5.5, we see that $\mathrm{D}\left(N L_{g}\right) \cap \mathrm{D}\left(L_{g} N\right) \subset \ell_{1}^{2}(g)$. For any $\varphi \in \mathrm{D}\left(N L_{g}\right) \cap \mathrm{D}\left(L_{g} N\right)$, we have

$$
\left[N, L_{g}\right] \varphi=i \sum_{n=0}^{\infty} \sum_{k=1}^{\infty}\left(\xi_{n},\left(\left(L^{*} g_{N}^{-1}\right)^{k}+\left(g_{N} L\right)^{k}\right) \varphi\right) \xi_{n}=-i \varphi
$$

Then (1) is proven. Since $L_{G}$ is self-adjoint and bounded, $\overline{L_{g}}$ is also self-adjoint and bounded from Lemma 5.8. By (1) $L_{g}$ satisfies the canonical commutation relation.
$L_{g}$ is no longer a symmetric operator when $|g| \neq 1$. Therefore, in order to construct a time operator from $L_{g}$ with $|g| \neq 1$, we need to symmetrize it.

Corollary 5.10 Let $g$ be a complex-valued function on $\mathbb{N}$. Suppose that there exist $n_{0} \in \mathbb{N}$, $c_{1}, c_{2} \in(0, \infty)$ and $d_{1}, d_{2} \in(0,1 / 2)$ such that, for all $n>n_{0}$,

$$
\begin{equation*}
c_{1} n^{-d_{1}} \leq \prod_{k=0}^{n}\left|g_{k}\right| \leq c_{2} n^{d_{2}} \tag{5.5}
\end{equation*}
$$

Then $\left(L_{g}+L_{\bar{g}^{-1}}\right) / 2$ is a time operator of $N$.
Proof: The assumption $c_{1} n^{-d_{1}} \leq \prod_{k \leq n}\left|g_{k}\right|$ implies that for any $m \in \mathbb{N}$

$$
\begin{aligned}
\left\|\sum_{k \geq 1} \frac{1}{k}\left(L^{*} g_{N}^{-1}\right)^{k} \xi_{m}\right\| & =\left\|\sum_{k \geq 1} \frac{1}{k}\left(\prod_{l=0}^{k-1} g_{m+l}\right)^{-1} \xi_{m+k}\right\| \\
& \leq\left(\sum_{1 \leq k \leq n_{0}} \frac{1}{k^{2}}\left|\prod_{l=0}^{k-1} g_{m+l}\right|^{-2}+\left|c_{1}^{-1} g!(m-1)\right|^{2} \sum_{k>n_{0}} k^{-2\left(1-d_{1}\right)}\right)^{1 / 2}<\infty .
\end{aligned}
$$

Thus $\xi_{m} \in \mathrm{D}\left(\log \left(\mathbb{1}-L^{*} g_{N}^{-1}\right)\right)$ and $\xi_{m} \in \mathrm{D}\left(L_{g}\right)$. In the same way, $\prod_{k=0}^{n}\left|g_{k}\right| \leq c_{2} n^{d_{2}}$ implies that $\xi_{n} \in \mathrm{D}\left(\log \left(\mathbb{1}-L^{*} \bar{g}_{N}\right)\right)$ and then $\xi_{n} \in \mathrm{D}\left(L_{\bar{g}^{-1}}\right)$. Thus (5.5) implies that $\xi_{n} \in$ $\mathrm{D}\left(L_{g}\right) \cap \mathrm{D}\left(L_{\bar{g}^{-1}}\right)$. Since $L_{g}^{*} \supset-i\left\{\log \left(\mathbb{1}-L^{*} \bar{g}_{N}\right)-\log \left(\mathbb{1}-\bar{g}_{N}^{-1} L\right)\right\}=L_{\bar{g}^{-1}}$, the operator $L_{g}+L_{\bar{g}^{-1}}$ is symmetric. The canonical commutation relation $\left[N,\left(L_{g}+L_{\bar{g}^{-1}}\right) / 2\right]=-i \mathbb{1}$ is proven in the same way as Theorem 5.9.

### 5.3 Conjugate operators of the form $\log (\mathbb{1}-p(L))-\log \left(\mathbb{1}-p\left(L^{*}\right)\right)$

In Section 4.4 conjugate operators of the form $\log p(L)$ is considered. Let $Y_{p}=\mathbb{1}-p(L)$. In this section we consider conjugate operators of the form

$$
X_{p}=\log \left(Y_{p}\right)-\log \left(Y_{p}^{*}\right)
$$

under some conditions on polynomials $p . X_{p}$ is a generalization of $L_{G}$. Note that $\operatorname{Ker}\left(Y_{p}^{*}\right)=$ $\{0\}$ if $p \neq 1$. Hence the inverse of $Y_{p}^{*}$ exists.

Lemma 5.11 Let $p$ be a polynomial. Suppose that $Y_{p}$ is injective and $\lim _{k \rightarrow \infty} p(L)^{k}=0$. Then

$$
\begin{equation*}
\left[N, \log Y_{p}\right]=L p^{\prime}(L) Y_{p}^{-1} \tag{5.6}
\end{equation*}
$$

on $\operatorname{Ran}\left(Y_{p}\right) \cap \mathrm{D}\left(N \log Y_{p}\right) \cap \mathrm{D}\left(\log \left(Y_{p}\right) N\right)$ and

$$
\begin{equation*}
\left[N, \log \left(Y_{p}^{*}\right)\right]=-L^{*} p^{\prime}\left(L^{*}\right)\left(Y_{p}^{*}\right)^{-1} \tag{5.7}
\end{equation*}
$$

on $\operatorname{Ran}\left(Y_{p}^{*}\right) \cap \mathrm{D}\left(N \log \left(Y_{p}^{*}\right)\right) \cap \mathrm{D}\left(\log \left(Y_{p}^{*}\right) N\right)$.

Proof: Let $\varphi \in \mathrm{D}\left(N \log Y_{p}\right) \cap \mathrm{D}\left(\log \left(Y_{p}\right) N\right)$ and $\varphi=Y_{p} \psi$. Inserting the expansion $\varphi=$ $\sum_{n=0}^{\infty}\left(\xi_{n}, \varphi\right) \xi_{n}$ to $\left[N, \log Y_{p}\right] \varphi$, we see that

$$
\left[N, \log Y_{p}\right] \varphi=-\sum_{n=0}^{\infty} \sum_{k=1}^{\infty} \frac{1}{k}\left(\xi_{n},\left[N, p(L)^{k}\right] \varphi\right) \xi_{n}
$$

Since $\left[N, p(L)^{k}\right] \subset-k L p^{\prime}(L) p(L)^{k-1}$, we have

$$
\begin{aligned}
{\left[N, \log Y_{p}\right] \varphi } & =\sum_{n=0}^{\infty} \sum_{k=1}^{\infty}\left(\xi_{n}, L p^{\prime}(L) p(L)^{k-1} \varphi\right) \xi_{n} \\
& =\sum_{n=0}^{\infty} \sum_{k=1}^{\infty}\left(\xi_{n}, L p^{\prime}(L) p(L)^{k-1}(\mathbb{1}-p(L)) \psi\right) \xi_{n}
\end{aligned}
$$

By assumption $\lim _{k \rightarrow \infty} p(L)^{k}=0$, we have

$$
\left[N, \log Y_{p}\right] \varphi=-\sum_{n=0}^{\infty} \lim _{k \rightarrow \infty}\left(\xi_{n}, L p^{\prime}(L) p(L)^{k} \psi\right) \xi_{n}+\sum_{n=0}^{\infty}\left(\xi_{n}, L p^{\prime}(L) \psi\right) \xi_{n}=L p^{\prime}(L) Y_{p}^{-1} \varphi
$$

Then (5.6) follows. (5.7) can be shown in a similar way to (5.6).
From Lemma 5.11, if $L p^{\prime}(L) Y_{p}^{-1}+L^{*} p^{\prime}\left(L^{*}\right)\left(Y_{p}^{*}\right)^{-1}$ has a non-zero eigenvalue, then $N$ has a conjugate operator on the eigenvector space. Let $\mathbb{S}^{1}=\{\alpha \in \mathbb{C}| | \alpha \mid=1\}$. Thus, we have the following theorem.

Theorem 5.12 Let $p$ be a polynomial with degree $m$ such that

$$
\begin{aligned}
& \text { (1) } \mathbb{1}-p(L) \text { is injective, } \\
& \text { (2) } \lim _{k \rightarrow \infty} p(L)^{k}=0, \\
& \text { (3) }\{z \in \mathbb{C} \mid 1-p(z)=0\} \subset \mathbb{S}^{1} .
\end{aligned}
$$

Let $\alpha_{1}, \ldots, \alpha_{m} \in \mathbb{C}$ be all roots of $1-p(\alpha)=0$ within the multiplicity. Then

$$
\left[N, \frac{i}{m} X_{p}\right]=-i \mathbb{1}
$$

with CCR-domain $\operatorname{Ran}\left(\prod_{i=1}^{m}\left(\alpha_{i} L^{*}-\mathbb{1}\right)\right) \cap \mathrm{D}\left(X_{p} N\right) \cap \mathrm{D}\left(N X_{p}\right)$.
Proof: By Lemma 5.11 we have

$$
\begin{align*}
{\left[N, X_{p}\right] } & =L p^{\prime}(L) Y_{p}^{-1}+L^{*} p^{\prime}\left(L^{*}\right)\left(Y_{p}^{*}\right)^{-1} \\
& =\sum_{i=1}^{m}\left(\alpha_{i}\left(\alpha_{i} \mathbb{1}-L\right)^{-1}+\alpha_{i}\left(\alpha_{i} \mathbb{1}-L^{*}\right)^{-1}-2 \mathbb{1}\right) . \tag{5.8}
\end{align*}
$$

Note that (5.8) corresponds to (5.4). It suffices to show that the right-hand side above has an eigenvector in $\mathrm{D}\left(N X_{p}\right) \cap \mathrm{D}\left(X_{p} N\right)$. Since $\alpha_{i} \in \mathbb{S}^{1}$, we see that

$$
\sum_{i=1}^{m}\left(\alpha_{i}\left(\alpha_{i} \mathbb{1}-L\right)^{-1}+\alpha_{i}\left(\alpha_{i} \mathbb{1}-L^{*}\right)^{-1}\right)=\sum_{i=1}^{m}\left(\alpha_{i}\left(\alpha_{i} \mathbb{1}-L\right)^{-1}+\alpha_{i}^{-1}\left(\alpha_{i}^{-1} \mathbb{1}-L^{*}\right)^{-1}\right) .
$$

Let $\psi \in \ell^{2} \backslash\{0\}$ and $\varphi=\left(\alpha L^{*}-\mathbb{1}\right) \psi$. Since

$$
\left(\alpha(\alpha \mathbb{1}-L)^{-1}+\alpha^{-1}\left(\alpha^{-1} \mathbb{1}-L^{*}\right)^{-1}\right) \varphi=\alpha L^{*} \psi-\psi=\varphi,
$$

$\varphi$ is an eigenvector of $\alpha(\alpha \mathbb{1}-L)^{-1}+\alpha^{-1}\left(\alpha^{-1} \mathbb{1}-L^{*}\right)^{-1}$ with an eigenvalue 1. Hence $\prod_{i=1}^{m}\left(\alpha_{i} L^{*}-\mathbb{1}\right) \psi$ is an eigenvector of $L p^{\prime}(L) Y_{p}^{-1}+L^{*} p^{\prime}\left(L^{*}\right)\left(Y_{p}^{*}\right)^{-1}$ with the eigenvalue -1 and

$$
\left[N, X_{p}\right] \prod_{i=1}^{m}\left(\alpha_{i} L^{*}-\mathbb{1}\right) \psi=-m \prod_{i=1}^{m}\left(\alpha_{i} L^{*}-\mathbb{1}\right) \psi .
$$

Then a CCR-domain is given by $\operatorname{Ran}\left(\prod_{i=1}^{m}\left(\alpha_{i} L^{*}-\mathbb{1}\right)\right) \cap \mathrm{D}\left(X_{p} N\right) \cap \mathrm{D}\left(N X_{p}\right)$, and the theorem is proven.

Corollary 5.13 Let $|\omega|=1$. Then $i m^{-1}\left\{\log \left(\mathbb{1}-\omega L^{m}\right)-\log \left(\mathbb{1}-\omega^{*} L^{* m}\right)\right\}$ is a time operator of $N$.

Proof: Let $p(z)=\omega z^{m}$. Then the corollary follows from Theorem 5.12.

## 6 Classification of conjugate operators

In this section we focus on investigating conjugate operators of the form

$$
T_{\omega, m}=\frac{i}{m} \log \left(\omega \mathbb{1}-L^{m}\right) \quad(\omega, m) \in \overline{\mathbb{D}} \times(\mathbb{N} \backslash\{0\})
$$

This type of operators have appeared in Lemma 5.1 and Corollary 5.13. Furthermore note that $T_{A} \cong L_{A 0} \oplus L_{A 1}$. In Example 4.18 we mentioned that to investigate the CCR-domain of $L_{A 0}$ and $L_{A 1}$ can be reduced to investigate the CCR-domain of

$$
\frac{i}{2} \log L^{2}=T_{0,2}
$$

Let us define the family of operators with parameters $\omega$ and $m$ by

$$
\mathscr{T}=\left\{T_{\omega, m} \mid \omega \in \overline{\mathbb{D}}, m \geq 1\right\} .
$$

We divide $\mathscr{T}$ into three disjoint families:

$$
\mathscr{T}=\mathscr{T}_{\{0\}} \cup \mathscr{T}_{\mathbb{D} \backslash\{0\}} \cup \mathscr{T}_{\partial \mathbb{D}} .
$$

Here

$$
\begin{aligned}
& \mathscr{T}_{\{0\}}=\left\{T_{\omega, m} \mid \omega=0, m \geq 1\right\}, \\
& \mathscr{T}_{\mathbb{D} \backslash\{0\}}=\left\{T_{\omega, m}|0<|\omega|<1, m \geq 1\},\right. \\
& \mathscr{T}_{\partial \mathbb{D}}=\left\{T_{\omega, m}| | \omega \mid=1, m \geq 1\right\} .
\end{aligned}
$$

In what follows we discuss CCR-domains of $T_{\omega, m}$.
We define

$$
\ell_{m}^{2}=\left\{\varphi \in \ell^{2} \mid \lim _{k \rightarrow \infty}\left(\mathbb{1}-L^{m}\right)^{k} \varphi=0\right\},
$$

Theorem $6.1\left(\mathscr{T}_{\{0\}}\right)$ We have

$$
\left[N, \frac{i}{m} \log L^{m}\right]=-i \mathbb{1}
$$

on $\ell_{m}^{2} \cap \mathrm{D}\left(N \log L^{m}\right) \cap \mathrm{D}\left(\log \left(L^{m}\right) N\right)$, and $\operatorname{dim}\left(\ell_{m}^{2} \cap \mathrm{D}\left(N \log L^{m}\right) \cap \mathrm{D}\left(\log \left(L^{m}\right) N\right)\right)=\infty$.
Proof: This is a special case of Theorem 4.19. Let $p(z)=z^{m}$. Then $z p^{\prime}(z)-m p(z)=0$ for all $z \in \mathbb{C}$. In a similar way of the proof of Theorem 4.19, for any $\varphi \in \ell_{m}^{2} \cap \mathrm{D}\left(N \log L^{m}\right) \cap$ $\mathrm{D}\left(\log \left(L^{m}\right) N\right)$, we see that $\left[N, \log L^{m}\right] \varphi=-m \sum_{k=1}^{\infty}\left(\mathbb{1}-L^{m}\right)^{k-1} L^{m} \varphi=-m \varphi$. Then the theorem follows.

Next we consider $\mathscr{T} \backslash\{0\}$. Let $c \in \mathbb{C}$ and we recall that

$$
\begin{aligned}
& \mathrm{D}\left(\omega-z^{m}, c\right) \\
& =\operatorname{LH}\left\{\varphi \mid \exists \alpha \in \mathbb{C} \text { s.t. }\left|1-\omega+\alpha^{m}\right|<1, \alpha^{m}=c(m+c)^{-1} \omega, \varphi \in \operatorname{Ker}(L-\alpha \mathbb{1})\right\} .
\end{aligned}
$$

Theorem $6.2(\mathscr{T} \backslash\{0\})$ Let $\omega \in \mathbb{D} \backslash\{0\}$. Then for $c \in \mathbb{C} \backslash\{0\}$ such that $|c|$ is sufficiently small, we see that $\mathrm{D}\left(\omega-z^{m}, c\right) \neq\{0\}$, $\operatorname{dim} \mathrm{D}\left(\omega-z^{m}, c\right)<\infty$ and

$$
\left[N,-\frac{i}{c} \log \left(\omega \mathbb{1}-L^{m}\right)\right]=-i \mathbb{1}
$$

on $\mathrm{D}\left(\omega-z^{m}, c\right)$. Moreover, for any $c \in \mathbb{C} \backslash\{0\}$, there is no infinite dimensional $C C R$ domain for $N$ and $c \log \left(\omega-L^{m}\right)$

Proof: Let $p(z)=\omega-z^{m}$ with $|\omega|<1$ and $|\omega-1|<1$. Suppose that $c$ is a sufficiently small positive number. Then $z p^{\prime}(z)+c p(z)=-(c+m) z^{m}+c \omega=0$ has the roots

$$
\alpha_{k}=\left|\frac{c}{c+m}\right| \omega^{1 / m} e^{2 \pi i k / m}, \quad k=0, \ldots, m-1 .
$$

By Theorem 4.19, since $\left|p\left(\alpha_{k}\right)-1\right|=\left|\omega-1-\alpha_{k}^{m}\right|<1$ and $\left|\alpha_{k}\right|<1, k=0, \ldots, m-1$, we have $\left[N, \frac{i}{c} \log \left(\omega \mathbb{1}-L^{m}\right)\right]=i \mathbb{1}$ on $\operatorname{Ker}\left(L-\alpha_{k} \mathbb{1}\right)$ for $k=0, \ldots, m-1$. Moreover the dimension of the CCR-domain $\operatorname{LH}\left\{\operatorname{Ker}\left(L-\alpha_{k} \mathbb{1}\right), k=0, \ldots, m-1\right\}$ is finite.

We consider conjugate operators of the form $i\left\{\log (\omega \mathbb{1}-L)-\log \left(\bar{\omega} \mathbb{1}-L^{*}\right)\right\}$ with $\omega \in \partial \mathbb{D}$. We consider $\log (\omega \mathbb{1}-A)$ for $\log (\omega \mathbb{1}-A)$ to avoid a singularity.

Definition $6.3(\log (\omega \mathbb{1}-A))$ Let $A$ be a linear operator on a Hilbert space $\mathcal{H}$. We define

$$
\begin{align*}
& \mathrm{D}(\log (\omega \mathbb{1}-A))=\left\{\varphi \in \bigcap_{k=0}^{\infty} \mathrm{D}\left(A^{k}\right) \left\lvert\, \lim _{K \rightarrow \infty} \sum_{k=1}^{K} \frac{1}{k}\left(\frac{1}{\omega} A\right)^{k} \varphi\right. \text { exists }\right\} \\
& \log (\omega \mathbb{1}-A) \varphi=\log (\omega) \varphi-\sum_{k=1}^{\infty} \frac{1}{k}\left(\frac{1}{\omega} A\right)^{k} \varphi, \quad \varphi \in \mathrm{D}(\log (\omega \mathbb{1}-A)) . \tag{6.1}
\end{align*}
$$

Theorem $6.4\left(\mathscr{T}_{\partial \mathbb{D}}\right)$ Let $\omega \in \partial \mathbb{D}$. Then $L_{m, \omega}=\operatorname{im}^{-1}\left(\log \left(\omega \mathbb{1}-L^{m}\right)-\log \left(\bar{\omega} \mathbb{1}-L^{* m}\right)\right)$ is a time operator with the dense CCR-domain $\mathrm{D}\left(N L_{m, \omega}\right) \cap \mathrm{D}\left(L_{m, \omega} N\right)$.

Proof: As in the proof of Theorem 5.5, we see that

$$
\mathrm{D}\left(N L_{m, \omega}\right) \cap \mathrm{D}\left(L_{m, \omega} N\right) \subset\left\{\sum_{n=0}^{\infty} c_{n} \xi_{n} \mid \sum_{n=0}^{\infty} \bar{\omega}^{n} c_{l+m n}=0 \text { for all } l<m\right\}
$$

and for any $\varphi \in \mathrm{D}\left(N L_{m, \omega}\right) \cap \mathrm{D}\left(L_{m, \omega} N\right)$,

$$
\left[N, L_{m, \omega}\right] \varphi=i \sum_{n=0}^{\infty} \sum_{k=1}^{\infty}\left(\xi_{n},\left(\left(\bar{\omega} L^{m}\right)^{k}+\left(\omega L^{* m}\right)^{k}\right) \varphi\right) \xi_{n}=-i \varphi
$$

Then the theorem follows.

We can also introduce operator $T_{\omega, m}$ with $|\omega|>1$ by a Dunford integral. See (A.1) in Appendix.

## 7 Weak Wyle relations for $N$

In this section we consider the time evolution of conjugate operators. The Weyl relation [19]

$$
e^{-i s p} e^{-i t q}=e^{i s t} e^{-i t q} e^{-i s p}, \quad s, t \in \mathbb{R}
$$

holds true. From this we can derive the so-called weak Weyl relation [14]:

$$
\begin{equation*}
q e^{-i t p}=e^{-i t p}(q+t), \quad t \in \mathbb{R} \tag{7.1}
\end{equation*}
$$

on $\mathrm{D}(q)$. The strong time operator $T$ is defined as an operator satisfying (7.1) with $q$ and $p$ replaced by $T$ and Hamiltonian $H$, respectively. More precisely, we explain the weak Weyl relation (7.1) as follows.

Definition 7.1 We say that the pair $(H, A)$ consisting of a self-adjoint operator $H$ and $a$ symmetric operator $A$ on a Hilbert space $\mathcal{H}$ obeys the weak Weyl relation if for all $t \in \mathbb{R}$,

$$
\text { (1) } e^{-i t H} \mathrm{D}(A) \subset \mathrm{D}(A) \text {; }
$$

(2) $A e^{-i t H} \varphi=e^{-i t H}(A+t) \varphi$ for all $\varphi \in \mathrm{D}(A)$.

Here $A$ is referred to as a strong time operator associated with $H$. Note that a strong time operator is not unique. If strong time operator $A$ is self-adjoint, then it is known that

$$
e^{-i s A} e^{-i t H}=e^{-i s t} e^{-i t H} e^{-i s A}, \quad s, t \in \mathbb{R}
$$

holds. In particular when Hilbert space is separable, by the von Neumann uniqueness theorem the Weyl relation above implies that $H$ and $A$ are unitarily equivalent to $\oplus^{n} p$ and $\oplus^{n} q$ with some $n \leq \infty$, respectively. As was mentioned above, although a strong time operator is automatically a time operator, the converse is not true. It is remarkable that when the pair $(H, A)$ obeys the weak Weyl relation, $H$ has purely absolutely continuous spectrum. For example since the spectrum of $N$ is purely discrete, there is no strong time operator associated with $N$. Weak Weyl relation can be understood as the time evolution of $A$ :

$$
\begin{equation*}
e^{i t H} A e^{-i t H} \supset A+t \tag{7.2}
\end{equation*}
$$

We can see the time evolution of the Galapon operator directly. It can be seen that

$$
T_{G}(t) \varphi=i \sum_{n=0}^{\infty} \sum_{m \neq n} \frac{e^{+i t(n-m)}\left(v_{m}, \varphi\right)}{n-m} v_{n} .
$$

Hence $T_{G}(t)$ is periodic so that

$$
T_{G}(t+2 \pi n)=T_{G}(t), \quad n \in \mathbb{N}, t \in \mathbb{R}
$$

Let us consider the time evolutions of general conjugate operators. We define

$$
T_{\omega, m}(t)=e^{i t N} T_{\omega, m} e^{-i t N}
$$

Theorem 7.2 Let $T_{\omega, m} \in \mathscr{T}$. Then

$$
T_{\omega, m}(t)=\frac{i}{m} \log \left(\omega-e^{-i t m} L^{m}\right)
$$

and $T_{\omega, m}(t)$ is periodic with period $2 \pi / m$, i.e.,

$$
T_{\omega, m}(t)=T_{\omega, m}(t+(2 \pi / m) n), \quad n \in \mathbb{N}, t \in \mathbb{R}
$$

Proof: Since $e^{i t N} L e^{-i t N}=e^{-i t} L$, we see that $e^{i t N} \log \left(\omega \mathbb{1}-L^{m}\right) e^{-i t N}=\log \left(\omega-e^{-i t m} L^{m}\right)$.

Example 7.3 It is shown that the angle operator $T_{A}=\frac{1}{2}\left(\arctan q^{-1} p \oplus \arctan p q^{-1}\right)$ can be represented as

$$
\begin{aligned}
& \frac{1}{2} \arctan \left(q^{-1} p\right) \cong \frac{i}{2} \log \left(\sqrt{\frac{N+2 \mathbb{1}}{N+\mathbb{1}}} L^{2}\right) \\
& \frac{1}{2} \arctan \left(p q^{-1}\right) \cong \frac{i}{2} \log \left(\sqrt{\frac{N+\mathbb{1}}{N+2 \mathbb{1}}} L^{2}\right)
\end{aligned}
$$

in Theorem 4.9. Thus the period of the time evolutions of both of $\arctan \left(q^{-1} p\right)$ and $\arctan \left(p q^{-1}\right)$ are $\pi$.

Finally we show an example of (3.2). Let $\omega=0$ and consider the time evolution of $T_{0, m}(t)$.

Corollary 7.4 Let $m \in \mathbb{N}$ and $\arg e^{-i t m} \neq 0$. Then

$$
\log \left(-e^{-i t m} L^{m}\right) \neq \log \left(e^{-i t m}\right)+\log \left(-L^{m}\right)
$$

Proof: Suppose that $\log \left(-e^{-i t m} L^{m}\right)=\log \left(e^{-i t m}\right)+\log \left(-L^{m}\right)$. Then we see that $e^{i t N} T_{0, m} e^{-i t N}=\frac{i}{m} \log \left(-e^{-i t m} L^{m}\right)=-\frac{1}{m} \arg e^{-i t m}+\frac{i}{m} \log \left(-L^{m}\right)=-\frac{1}{m} \arg e^{-i t m}+T_{0, m}$. Hence we see that for any eigenvecotr $v_{n}$ of $N$

$$
\begin{equation*}
\left(v_{n}, T_{0, m} v_{n}\right)=\left(v_{n}, e^{i t N} T_{0, m} e^{-i t N} v_{n}\right)=-\frac{1}{m}\left(v_{n}, \arg e^{-i t m} v_{n}\right)+\left(v_{n}, T_{0, m} v_{n}\right) \tag{7.3}
\end{equation*}
$$

Since $\left(v_{n}, \arg e^{-i t m} v_{n}\right) \neq 0,(7.3)$ is contradiction. Then the corollary follows.

## A CCR domains for $\mathscr{T}^{\text {D}}{ }^{c}$

We consider conjugate operators of the form $i \log \left(\omega \mathbb{1}-L^{m}\right)$ with $|\omega|>1$. To avoid a singularity, we need to modify the definition of $i \log \left(\omega \mathbb{1}-L^{m}\right)$. Let $r \mathbb{D}=\{r z \mid z \in \mathbb{D}\}$ for $r>0$ and $f$ be an analytic function such that $f(\overline{r \mathbb{D}}) \not \ngtr 0$ for some $r>1$. Then $\log f$ is analytic on $r \mathbb{D}$. Let $\|A\|<1$. Since $(z-A)^{-1}$ is bounded for any $z \notin \overline{\mathbb{D}}$, it can be seen that the Dunford integral $\oint_{r \partial \mathbb{D}} \log f(z)(z-A) d z$ defines the sesquilinear form

$$
\begin{equation*}
(\varphi, \psi) \mapsto Q(\varphi, \psi)=\oint_{r \partial \mathbb{D}} \log f(z)\left(\varphi,(z-A)^{-1} \psi\right) d z \tag{A.1}
\end{equation*}
$$

(A.1) also defines the bounded operator such that $Q(\varphi, \psi)=(\varphi, B \psi) . B$ is also denoted by the same symbol $\log f(A)$ as that of Definition 3.1. Set $f(z)=\omega-z^{m}$ and $A=L$. Then we can define $\log \left(\omega \mathbb{1}-L^{m}\right)$ by (A.1).

Lemma A. 1 There is no polynomial p satisfying the following conditions:
(1) $0 \notin \operatorname{Spec}(p(L))$,
(2) $\left[N, i\left\{\log p(L)-\log p\left(L^{*}\right)\right\}\right]=-i \mathbb{1}$ on some infinite dimenstional subspace $\mathcal{D}$.

Proof: Let $p(x)=\sum_{k=0}^{n} a_{k} x^{k}$ be a real-valued polynomial with $a_{n} \neq 0$. We see that

$$
\begin{equation*}
p(L) p\left(L^{*}\right) L^{* n}=\left(\sum_{k=0}^{n} a_{k} L^{* n-k}\right)\left(\sum_{k=0}^{n} a_{k} L^{* k}\right)=\sum_{k, l \geq 0}^{n} a_{k} a_{l} L^{* n-l+k} . \tag{A.2}
\end{equation*}
$$

It is easy to see that

$$
\begin{equation*}
\left[N, \log p(L)-\log p\left(L^{*}\right)\right] \subset-L p^{\prime}(L) p(L)^{-1}-L^{*} p^{\prime}\left(L^{*}\right) p\left(L^{*}\right)^{-1} \tag{A.3}
\end{equation*}
$$

Note that $\operatorname{Ran}\left(L^{* n}\right)=\left\{\left(c_{k}\right)_{k \in \mathbb{N}} \in \ell^{2} \mid c_{0}=\cdots=c_{n-1}=0\right\}$. Hence $\mathcal{D} \cap \operatorname{Ran}\left(L^{* n}\right)=\{0\}$ implies that $\operatorname{dim} \mathcal{D}<\infty$. Then $\mathcal{D} \cap \operatorname{Ran}\left(L^{* n}\right) \neq\{0\}$, since $\operatorname{dim} \mathcal{D}=\infty$. Notice that, for any $k \leq n, L^{k} L^{* k}=L^{* k} L^{k}=\mathbb{1}$ on $\operatorname{Ran}\left(L^{* n}\right)$. Thus we also have the following relation on the non-trivial domain by (A.3):

$$
\begin{align*}
& p(L) p\left(L^{*}\right) L^{* n} \\
& =-p(L) p\left(L^{*}\right)\left[N, \log p(L)-\log p\left(L^{*}\right)\right] L^{* n} \\
& =L p^{\prime}(L) p\left(L^{*}\right) L^{* n}+L^{*} p^{\prime}\left(L^{*}\right) p(L) L^{* n} \\
& =\left(\sum_{k=1}^{n} k a_{k} L^{* n-k}\right)\left(\sum_{k=0}^{n} a_{k} L^{* k}\right)+\left(\sum_{k=1}^{n} k a_{k} L^{* k}\right)\left(\sum_{k=0}^{n} a_{k} L^{* n-k}\right) \\
& =\sum_{k, l \geq 1}^{n}\left(k a_{k} a_{l}+l a_{l} a_{k}\right) L^{* n-l+k}+\sum_{k=1}^{n} k a_{k} a_{0} L^{* n-k}+\sum_{k=1}^{n} k a_{k} a_{0} L^{* n+k} . \tag{A.4}
\end{align*}
$$

Let $L^{* n} \varphi \in \mathcal{D} \backslash\{0\}$ and $n_{0}=\inf \operatorname{supp}(\varphi)$. Comparing the coefficients of $L^{* 0}$ in (A.2) and (A.4), we have $n a_{0} a_{n}=a_{0} a_{n}$. From (1) we have $a_{0} \neq 0$. Since $a_{0} a_{n} \neq 0$, we see that $n=1$. Hence $p(x)=a x+b$. By (A.4) we also have $a= \pm b$, and then $p(x)=a(1 \pm x)$. We conclude that $p(L)=a(\mathbb{1} \pm L)$ and $\operatorname{Spec}(p(L))=p(\operatorname{Spec}(L)) \ni 0$. This contradicts $0 \notin \operatorname{Spec}(p(L))$. Then the lemma follows.

Theorem A. 2 Let $|\omega|>1$. The operator $i\left\{\log \left(\omega \mathbb{1}-L^{m}\right)-\log \left(\bar{\omega} \mathbb{1}-L^{* m}\right)\right\}$ has no infinite dimensional CCR-domain for $N$.

Proof: Let $p(z)=\omega-z^{m}$ with $|\omega|>1$. Then $\operatorname{Spec}(p(L)) \not \supset 0$. Thus the theorem follows from Lemma A.1.

Remark A. 3 The existence of a non zero $C C R$ domain of $i\left\{\log (\omega \mathbb{1}-L)-\log \left(\bar{\omega} \mathbb{1}-L^{*}\right)\right\}$ with $|\omega|>1$ is unknown.
