Abstract

In this paper, we first establish asymptotic expansions of the Humbert function Ψ_1 for one large variable. The resulting expansions are then used to derive an asymptotic expansion of Saran's hypergeometric function F_K when two of its variables become simultaneously large.

Keywords: Asymptotic expansion, Humbert function, Saran's function.

1 Introduction

Saran's hypergeometric function F_K is defined by [22, p. 294, Eq. (2.4)]

$$F_{K}[\alpha_{1},\alpha_{2},\alpha_{2},\beta_{1},\beta_{2},\beta_{1};\gamma_{1},\gamma_{2},\gamma_{3};x,y,z] = \sum_{m,n,p=0}^{\infty} \frac{(\alpha_{1})_{m}(\alpha_{2})_{n+p}(\beta_{1})_{m+p}(\beta_{2})_{n}}{(\gamma_{1})_{m}(\gamma_{2})_{n}(\gamma_{3})_{p}} \frac{x^{m}}{m!} \frac{y^{n}}{m!} \frac{z^{p}}{p!}, \quad (1.1)$$

where $(x, y, z) \in \mathbb{D}_K := \{(x, y, z) \in \mathbb{C}^3 : |x| < 1, |y| < 1, |z| < (1 - |x|)(1 - |y|)\}$. It has been shown in [16, p. 1] that \mathbb{D}_K is a complete Reinhardt domain. Using the series manipulation technique, we can obtain the following equivalent forms of (1.1):

$$F_{K}[\alpha_{1},\alpha_{2},\alpha_{2},\beta_{1},\beta_{2},\beta_{1};\gamma_{1},\gamma_{2},\gamma_{3};x,y,z] = \sum_{p=0}^{\infty} \frac{(\alpha_{2})_{p}(\beta_{1})_{p}}{p!(\gamma_{3})_{p}} {}_{2}F_{1} \begin{bmatrix} \beta_{1}+p,\alpha_{1}\\\gamma_{1} \end{bmatrix} {}_{2}F_{1} \begin{bmatrix} \alpha_{2}+p,\beta_{2}\\\gamma_{2} \end{bmatrix} {}_{2}F_{1} \end{bmatrix} {}_{2}F_{1} \end{bmatrix} {}_{2}F_{1} \begin{bmatrix} \alpha_{2}+p,\beta_{2}\\\gamma_{2} \end{bmatrix} {}_{2}F_{1} \end{bmatrix} {}_{2}F_{1} \end{bmatrix} {}_{2}F_{1} \begin{bmatrix} \alpha_{2}+p,\beta_{2}\\\gamma_{2} \end{bmatrix} {}_{2}F_{1} \end{bmatrix} {}_{2}$$

where $_2F_1$ denotes the familiar Gauss hypergeometric function and F_2 denotes the second Appell hypergeometric function (see [24, p. 23, Eq. (3)]). Over the past few years, more and more attention has been given to various properties and applications of this function (see [7], [8], [15] and [16] and the references therein).

As a special function in several complex variables, the asymptotic behaviour of F_K is rather complicated. Recently, Luo and Raina [15] obtain the complete asymptotic formulas for F_K when one of its variables is large. So it is natural to study the asymptotic behaviour of F_K when two variables are large. In fact, as a special case, Garcia and López [10] have deduced the behaviour of F_2 when $x, y \to \infty$ with |x|/|y| bounded. Their approach is based on the asymptotic method introduced in [14] and a suitable Laplace integral representation for F_2 . In view of the expression (1.2), where y and z appear together as variables of F_2 , we shall study the asymptotic behaviour of F_K when $y, z \to \infty$ with |y|/|z| bounded. Note also that since

$$F_{K}[\alpha_{1},\alpha_{2},\alpha_{2},\beta_{1},\beta_{2},\beta_{1};\gamma_{1},\gamma_{2},\gamma_{3};x,y,z] = F_{K}[\beta_{2},\beta_{1},\beta_{1},\alpha_{2},\alpha_{1},\alpha_{2};\gamma_{2},\gamma_{1},\gamma_{3};y,x,z],$$

the behaviour for large *x*, *z* is equivalent to that for large *y*, *z*.

To accomplish this, we need to first study the asymptotics of the Humbert function Ψ_1 defined by [24, p. 26, Eq. (21)]

$$\Psi_1[a,b;c,c';x,y] := \sum_{m,n=0}^{\infty} \frac{(a)_{m+n}(b)_m}{(c)_m(c')_n} \frac{x^m}{m!} \frac{y^n}{n!} (|x| < 1, |y| < \infty).$$

The motivation of considering Ψ_1 is that F_K possesses the following Laplace integral representation [23, p. 134, Eq. (3)]:

$$F_{K}[\alpha_{1}, \alpha_{2}, \alpha_{2}, \beta_{1}, \beta_{2}, \beta_{1}; \gamma_{1}, \gamma_{2}, \gamma_{3}; x, y, z] = \frac{1}{\Gamma(\alpha_{2})} \int_{0}^{\infty} e^{-s} s^{\alpha_{2}-1} {}_{1}F_{1} \begin{bmatrix} \beta_{2} \\ \gamma_{2} \end{bmatrix} ys \Psi_{1}[\beta_{1}, \alpha_{1}; \gamma_{1}, \gamma_{3}; x, zs] ds,$$
(1.4)

where Ψ_1 is given by (1.3) and $_1F_1$ is Kummer's confluent hypergeometric function. The convergence condition of (1.4)

$$\Re(\alpha_2) > 0, \ \Re((1-x)(1-y)) > \Re(z),$$

given in Saran's paper, is incorrect for it is derived from an incomplete estimate about Ψ_1 (see [23, p. 143, Eq. (3)]). To clarify the convergence condition, we must derive the correct estimate of Ψ_1 .

The paper is organized as follows:

In Section 2, we provide some necessary information about the Gauss hypergeometric function ${}_2F_1$, the Humbert function Ψ_1 and the Kampé de Fériet function $F_{0:1:2}^{1:1;2}$.

Section 3 devotes to the asymptotics of Ψ_1 . We first establish a contour integral representation for Ψ_1 , from which an asymptotic expansion of Ψ_1 for large *y* is obtained in the left half-plane. Then, by making use of a result of Olver [19], we obtain under certain restrictions the complete asymptotic expansions of Ψ_1 for large *y* in the right half-plane. Finally, we obtain the asymptotic expansion of Ψ_1 for large *x*.

Section 4 offers a comprehensive proof of the main result. First we convert the integral representation (1.4) into the form of the Mellin convolution. The desired approximation of F_K is then obtained by applying López's theorem [14] to that Mellin convolution integral.

In Appendix A, we compute an important Mellin transform of a product of $_1F_1$ and Ψ_1 . Finding different proofs of it may have independent interest.

2 Preliminaries

2.1 Asymptotics of the Gauss hypergeometric function $_2F_1$

Wagner [25, p. 2, Satz 1] proved that

$$\frac{1}{\Gamma(c)} {}_{2}F_{1} \begin{bmatrix} a, b \\ c \end{bmatrix} = \frac{(-az)^{-b}}{\Gamma(c-b)} [1+o(1)] + \frac{e^{\pm \pi i (b-c)}}{\Gamma(b)} (1-z)^{c-a-b} (-az)^{b-c} [1+o(1)], \text{ as } |a| \to \infty$$
(2.1)

with *b* and c ($c \notin \mathbb{Z}_{\leq 0}$) fixed complex numbers, $z \neq 0$ and $|\arg(1-z)| < \pi$. The choice of the sign \pm in the exponent and the determination of the range of $\arg(-az)$ depend on the conditions satisfied by the parameters. For convenience, we present some corollaries of Wagner's formula (2.1) which we shall use in the sequel. Similar analysis of [15, Eq. (12)] gives that for $n \in \mathbb{Z}_{>0}$,

$$\left|{}_{2}F_{1}\left[{a+n,b\atop c};z\right]\right| = \mathcal{O}\left(n^{-\omega}\rho_{z}^{n}\right), \text{ as } n \to \infty,$$
(2.2)

where

$$\omega := \min\{\Re(b), \Re(c-b)\} \text{ and } \rho_z := \max\{1, |1-z|^{-1}\}.$$
(2.3)

We use Landau's notation $f = \mathcal{O}(g)$ to mean that $|f| \le C|g|$ for a suitable positive number *C*, which may be absolute or depend on various parameters, in which case the dependence may be indicated in a subscript.

We need the following estimate [15, p. 4]:

$$\left| {}_{2}F_{1} \begin{bmatrix} a+\mathrm{i}t, b\\ c \end{bmatrix} \right| = \mathcal{O}\left(|t|^{-\omega} \mathrm{e}^{|t| \max\{0, \mp \arg(1-z)\}} \right), \quad t \to \pm \infty,$$

$$(2.4)$$

where ω is given in (2.3). We also need the behaviour of

$$\left|_{2}F_{1}\left[\frac{a+s,b}{c};z\right]\right|, s \in \mathfrak{C},$$

where \mathfrak{C} is the semi-circle $s = (N + 1/2)e^{i\theta}$ ($|\theta| \le \pi/2$) and $N \to \infty$ is taken through integral values.

Note that for $s \in \mathfrak{C}$,

$$|(1-z)^{-s}| = e^{(N+1/2)(\sin\theta \arg(1-z) - \cos\theta \log|1-z|)}.$$

This together with (2.1) implies that for $s \in \mathfrak{C}$,

$$\left|{}_{2}F_{1}\left[\frac{a+s,b}{c};z\right]\right| = \mathcal{O}\left(N^{-\omega}\mathrm{e}^{(N+1/2)(|\sin\theta||\arg(1-z)|-\cos\theta\log(1-|z|))}\right), N \to \infty,$$
(2.5)

where |z| < 1 and ω is given in (2.3).

2.2 Properties of the Humbert function Ψ_1

We have (see [12, p. 75] and [4, p. 118, Eq. (83)])

$$\Psi_1[a,b;c,c';x,y] = \sum_{n=0}^{\infty} \frac{(a)_n}{(c')_n} {}_2F_1\left[\begin{array}{c} a+n,b\\c \end{array};x \right] \frac{y^n}{n!}, \ |x|<1, \ |y|<\infty.$$
(2.6)

Taking (2.2) into account, the summand in (2.6) has the order of magnitude

$$\mathscr{O}\left(n^{\Re(a-c')-\omega}\frac{(\rho_x|y|)^n}{n!}\right), \ n \to \infty$$

which implies that the series converges absolutely in the region

$$\mathbb{D}_{\Psi_1} := \left\{ (x, y) \in \mathbb{C}^2 : x \neq 1, \, |\arg(1-x)| < \pi, \, |y| < \infty \right\}.$$

So the series in (2.6) provides an analytic continuation of Ψ_1 to \mathbb{D}_{Ψ_1} .

We also have [4, p. 115, Eq. (38)]

$$\Psi_1[a,b;c,c';x,y] = \frac{\Gamma(c)}{\Gamma(b)\Gamma(c-b)} \int_0^1 u^{b-1} (1-u)^{c-b-1} (1-ux)^{-a} {}_1F_1\left[\frac{a}{c'};\frac{y}{1-ux}\right] \mathrm{d}u, \qquad (2.7)$$

which is valid for $\Re(c) > \Re(b) > 0$ and $(x, y) \in \mathbb{D}_{\Psi_1}$. The integral representation (2.7) follows from the series representation (2.6) and Euler integral representation for $_2F_1$ (see [20, p. 388, Eq. (15.6.1)]).

We shall also use the Kummer transformation of Ψ_1 [6, Eq. (2.54)]

$$\Psi_1[a,b;c,c';x,y] = (1-x)^{-a} \Psi_1\left[a,c-b;c,c';\frac{x}{x-1},\frac{y}{1-x}\right].$$
(2.8)

There are some useful identities about Ψ_1 in the literature (see [4], [6], [12] and [17]). But we still know very little about its asymptotics. Joshi and Arya [13] established a set of bilateral inequalities for Ψ_1 under certain rather restrictive conditions. By using a Taubarian theorem for Laplace transform, Wald and Henkel [26] found the leading asymptotic behaviour of the Humbert functions Φ_2 , Φ_3 and Ξ_2 when the absolute values of the two independent variables become simultaneously large. They also considered Ψ_1 and pointed out that their technique can not handle Ψ_1 (see [26, p. 99]). Therefore, our work in Section 3 may help advance the research in this direction.

2.3 Kampé de Fériet function $F_{0:1:2}^{1:1;2}$

We need the following special case of the Kampé de Fériet function [24, p. 27]:

$$F_{0:1;2}^{1:1;2} \begin{bmatrix} a_1 : b_1; d_1, d_2 \\ - : c_1; e_1, e_2; x, y \end{bmatrix} = \sum_{m,n=0}^{\infty} \frac{(a_1)_{m+n} (b_1)_m (d_1)_n (d_2)_n}{(c_1)_m (e_1)_n (e_2)_n} \frac{x^m}{m!} \frac{y^n}{n!}, \ |x|+|y|<1.$$
(2.9)

In view of $(a_1)_{n+m} = (a_1)_n (a_1 + n)_m$, we have from (2.9) that

$$F_{0:1;2}^{1:1;2} \begin{bmatrix} a_1 : b_1; d_1, d_2 \\ -: c_1; e_1, e_2; x, y \end{bmatrix} = \sum_{n=0}^{\infty} \frac{(a_1)_n (d_1)_n (d_2)_n}{(e_1)_n (e_2)_n} {}_2F_1 \begin{bmatrix} a_1 + n, b_1 \\ c_1; x \end{bmatrix} \frac{y^n}{n!}.$$
 (2.10)

Denote by F_n the summand of the series (2.10). Using the estimate (2.2) gives

$$|F_n| = \mathcal{O}\left(n^{\Re(a_1+d_1+d_2-e_1-e_2)-\omega'-1}(\rho_x|y|)^n\right),\,$$

where $\omega' := \min\{\Re(b_1), \Re(c_1 - b_1)\}$. Then (2.10) converges absolutely in the region

$$\mathbb{D}_F := \left\{ (x, y) \in \mathbb{C}^2 : x \neq 1, |\arg(1 - x)| < \pi, |y| < \min\{1, |1 - x|\} \right\}$$

and thus gives an analytic continuation of $F_{0:1;2}^{1:1;2}$ to \mathbb{D}_F . Replacing $_2F_1$ with its Euler integral representation in (2.10) and then interchanging the order of summation and integration we obtain (initially with $\Re(c_1) > \Re(b_1) > 0$ and |x| + |y| < 1)

$$F_{0:1;2}^{1:1;2} \begin{bmatrix} a_1 : b_1; d_1, d_2 \\ -: c_1; e_1, e_2; x, y \end{bmatrix} = \frac{\Gamma(c_1)}{\Gamma(b_1)\Gamma(c_1 - b_1)} \int_0^1 u^{b_1 - 1} (1 - u)^{c_1 - b_1 - 1} \times (1 - ux)^{-a_1} {}_3F_2 \begin{bmatrix} d_1, d_2, a_1 \\ e_1, e_2; \frac{y}{1 - ux} \end{bmatrix} du,$$
(2.11)

where

$$\Re(c_1) > \Re(b_1) > 0$$
, $|\arg(1-x)| < \pi$ and $\left|\arg\left(1 - \frac{y}{1-ux}\right)\right| < \pi \ (\forall u \in [0,1]).$

A simpler condition under which (2.11) holds is given by

$$\Re(c_1) > \Re(b_1) > 0, \ x < 1, \ |\arg(1 - y)| < \pi \text{ and } \left|\arg\left(1 - \frac{y}{1 - x}\right)\right| < \pi.$$
 (2.12)

The integral (2.11) provides another analytic continuation of $F_{0:1:2}^{1:1;2}$.

2.4 Other functions

The asymptotic expansions of $_1F_1$ are given by ([2, p. 193])

$${}_{1}F_{1}\left[\frac{a}{c};z\right] \sim \frac{\Gamma(c)}{\Gamma(c-a)} \sum_{n=0}^{\infty} \frac{(a)_{n} (1+a-c)_{n}}{n!} (-z)^{-a-n}, \text{ as } z \to \infty \text{ with } \Re(z) < 0;$$
(2.13)

$${}_{1}F_{1}\begin{bmatrix}a\\c\end{bmatrix}\sim\frac{\Gamma(c)}{\Gamma(a)}e^{z}\cdot\sum_{n=0}^{\infty}\frac{(1-a)_{n}(c-a)_{n}}{n!}z^{a-c-n}, \text{ as } z\to\infty \text{ with } \Re(z)>0.$$

$$(2.14)$$

As $z \to \infty$ in the sector $|\arg(z)| \le \pi - \delta(<\pi)$,

$$\Gamma(az+b) \sim \sqrt{2\pi} e^{-az} (az)^{az+b-(1/2)},$$
 (2.15)

where a(>0) and $b(\in \mathbb{C})$ are both fixed (see [20, p. 141, Eq. (5.11.7)]). When $y \to \pm \infty$,

$$|\Gamma(x+iy)| \sim \sqrt{2\pi} |y|^{x-(1/2)} e^{-\pi |y|/2},$$
(2.16)

uniformly for bounded real values of *x* (see [20, p. 141, Eq. (5.11.9)]).

The Laurent expansion of $\Gamma(z)$ at its pole z = -n ($n \in \mathbb{Z}_{>0}$) is given by ([9, p. 29])

$$\Gamma(z-n) = \frac{(-1)^n}{n!} \left[z^{-1} + \psi(n+1) \right] + \mathcal{O}(z), \text{ as } z \to 0,$$

where $\psi(x)$ is the digamma function. Hence for $m, n \in \mathbb{Z}_{\geq 0}$, we have

$$\lim_{z \to 0} \left[a \Gamma(z-m) + b \Gamma(-z-n) \right] = \frac{(-1)^m}{m!} \psi(m+1) a + \frac{(-1)^n}{n!} \psi(n+1) b, \tag{2.17}$$

with *a* and *b* chosen such that this limit exsits.

Luo and Raina [15] extended Saran's function F_K to the region

$$\mathbb{V}_{K} = \left\{ \begin{array}{ll} x \neq 1, \ y \neq 1, \ |\arg(1-x)| < \pi, \ |\arg(1-y)| < \pi, \\ (x, y, z) \in \mathbb{C}^{3} : & z \neq 0, \ |\arg(-z)| < \pi, \\ & \max\left\{0, \mp \arg(1-x)\right\} + \max\left\{0, \mp \arg(1-y)\right\} < \pi \pm \arg(-z) \end{array} \right\}.$$

3 Asymptotics of Ψ_1

3.1 Asymptotics for large *y*

Following [15], we shall use the Mellin-Barnes contour integral representation of Ψ_1 to obtain the asymptotic expansion of Ψ_1 for large *y*. The starting point is (2.6). Define

$$\lambda(n) := \frac{\Gamma(a+n)\Gamma(c')}{\Gamma(a)\Gamma(c'+n)} {}_2F_1\left[\begin{matrix} a+n,b\\c \end{matrix}; x \right]$$

so that

$$\Psi_1[a,b;c,c';x,-y] = \sum_{n=0}^{\infty} \frac{\lambda(n)}{n!} (-y)^n.$$

Using Ramanujan's master theorem [1, p. 107], we formally have the following Mellin transform of the function Ψ_1 with respect to *y*:

$$\int_{0}^{\infty} y^{s-1} \Psi_{1}[a,b;c,c';x,-y] dy = \Gamma(s)\lambda(-s).$$
(3.1)

Applying the inverse Mellin transform to (3.1), we arrive at

$$\Psi_1[a,b;c,c';x,-y] = \frac{1}{2\pi i} \frac{\Gamma(c')}{\Gamma(a)} \int_{\sigma-i\infty}^{\sigma+i\infty} {}_2F_1\left[\begin{array}{c} a-s,b\\c \end{array};x \right] \frac{\Gamma(a-s)}{\Gamma(c'-s)} \Gamma(s) y^{-s} \mathrm{d}s,$$

where $\sigma := \Re(s)$ satisfies: (i) if $\Re(a) > 0$ then $0 < \sigma < \Re(a)$; (ii) if $\Re(a) \le 0$ then $\sigma = 0$.

Theorem 3.1. Let

$$\mathbb{V}_{\Psi_1} = \left\{ (x, y) \in \mathbb{C}^2 : \begin{array}{c} x \neq 1, \ y \neq 0, \ |\arg(1-x)| < \pi, \ |\arg(-y)| < \pi, \\ \max\left\{0, \mp \arg(1-x)\right\} < \frac{\pi}{2} \pm \arg(-y) \end{array} \right\}$$

Then

$$\Psi_1[a,b;c,c';x,y] = \frac{1}{2\pi i} \frac{\Gamma(c')}{\Gamma(a)} \int_{\mathfrak{L}_{i\sigma\infty}} {}_2F_1\left[\begin{array}{c} a+s,b\\c \end{array}; x \right] \frac{\Gamma(a+s)}{\Gamma(c'+s)} \Gamma(-s)(-y)^s \mathrm{d}s, \tag{3.2}$$

where the path of integration $\mathfrak{L}_{i\sigma\infty}$, starting at $\sigma - i\infty$ and ending at $\sigma + i\infty$, is a straight line parallel to the imaginary axis intended if necessary to separate the poles of $\Gamma(a + s)$ from the poles of $\Gamma(-s)$.

Proof. The proof will be divided into two parts. Firstly, we prove the integral exists for $(x, y) \in \mathbb{V}_{\Psi_1}$. Secondly, we show by using Cauchy's residue theorem that the integral is equal to Ψ_1 when x and y are appropriately restricted.

Denote by $\Psi(s)$ the integrand in (3.2), namely,

$$\Psi(s) := {}_2F_1 \begin{bmatrix} a+s, b \\ c \end{bmatrix} \frac{\Gamma(a+s)}{\Gamma(c'+s)} \Gamma(-s)(-y)^s.$$
(3.3)

It follows from (2.4) and (2.16) that as $t \to \pm \infty$,

$$\left|\frac{\Gamma(a+\sigma+\mathrm{i}t)}{\Gamma(c'+\sigma+\mathrm{i}t)}\Gamma(-\sigma-\mathrm{i}t)(-y)^{\sigma+\mathrm{i}t}\right| = \mathcal{O}\left(|t|^{\Re(a-c')-\sigma-\frac{1}{2}}\mathrm{e}^{-\left(\frac{\pi}{2}\pm\mathrm{arg}(-y)\right)|t|}\right),$$

$$\left|_{2}F_{1}\left[a+\sigma+\mathrm{i}t,b\atop c;x\right]\right| = \mathcal{O}\left(|t|^{-\omega}\,\mathrm{e}^{|t|\max\{0,\mp\arg(1-x)\}}\right),$$
(3.4)

where $\omega = \min\{\Re(b), \Re(c-b)\}$. Now we can conclude that when

$$\max\{0, \mp \arg(1-x)\} < \frac{\pi}{2} \pm \arg(-y), \tag{3.5}$$

the integrand $|\Psi(s)|$ ($s = \sigma + it$) decays exponentially as $|s| \to \infty$ along the path $\mathcal{L}_{i\sigma\infty}$.

The inequality (3.5) implies that $|\arg(1-x) + \arg(-y)| < \pi/2$. Thus, if we define

$$\widetilde{\mathbb{V}}_{\Psi_1} := \left\{ (x, y) \in \mathbb{C}^2 : |x| < 1, \ y \neq 0, \ |\arg(1-x)| + |\arg(-y)| < \frac{\pi}{2}, \ |y| < \frac{1}{e}(1-|x|) \right\},\$$

then we have $\widetilde{\mathbb{V}}_{\Psi_1} \subset \mathbb{V}_{\Psi_1}$.

Next we show that when $(x, y) \in \widetilde{\mathbb{V}}_{\Psi_1}$, the integral in (3.2) yields the series representation (2.6) of Ψ_1 . We close the contour by the semi-circle \mathfrak{C} in the right-hand side of the complex plane. The semi-circle \mathfrak{C} is parametrized by $s = (N + 1/2)e^{i\theta}$ ($|\theta| \le \pi/2$) and $N \to \infty$ through integral values.

From (2.15), we have immediately

$$\left|\frac{\Gamma(a+s)}{\Gamma(c'+s)}\right| = \mathcal{O}\left(N^{\Re(a-c')}\right),\,$$

as $N \to \infty$. Since $|\sin \pi s| \ge |\sinh \Im(\pi s)| = |\sinh(\pi (N + 1/2) \sin \theta)|$, we have

$$|\Gamma(-s)| = \left|\frac{\pi}{\sin \pi s} \frac{1}{\Gamma(1+s)}\right| = \mathcal{O}\left(N^{-\frac{1}{2} - \left(N + \frac{1}{2}\right)\cos\theta} e^{\left(N + \frac{1}{2}\right)(\cos\theta + \theta\sin\theta - \pi|\sin\theta|)}\right),$$

as $N \rightarrow \infty$. Thus

$$\left|\frac{\Gamma(a+s)}{\Gamma(c'+s)}\Gamma(-s)(-y)^{s}\right| = \mathcal{O}\left(N^{\Re(a-c')-\frac{1}{2}-\left(N+\frac{1}{2}\right)\cos\theta}\mathrm{e}^{\left(N+\frac{1}{2}\right)(\cos\theta+\theta\sin\theta+\cos\theta\ln|y|-\sin\theta\arg(-y)-\pi|\sin\theta|)}\right),$$

as $N \rightarrow \infty$. Combining this with (2.5), we obtain

$$\begin{split} \Psi(s) &= \mathcal{O}\left(N^{\Re(a-c')-\frac{1}{2}-\left(N+\frac{1}{2}\right)\cos\theta}\mathbf{e}^{\left(N+\frac{1}{2}\right)\left(\cos\theta+|\theta||\sin\theta|+\cos\theta\ln|y|+|\sin\theta||\arg(-y)|-\pi|\sin\theta|\right)} \right. \\ & \left.\cdot\mathcal{O}\left(N^{-\omega}\mathbf{e}^{(N+1/2)(|\sin\theta||\arg(1-x)|-\cos\theta\ln(1-|x|))}\right) \\ &= \mathcal{O}\left(N^{\Re(a-c')-\omega-\frac{1}{2}-\left(N+\frac{1}{2}\right)\cos\theta}\mathbf{e}^{\left(N+\frac{1}{2}\right)\left(\delta_{1}|\sin\theta|+\delta_{2}\cos\theta\right)}\right), \end{split}$$

where $\delta_1 := |\theta| + |\arg(-y)| + |\arg(1-x)| - \pi < 0$ and $\delta_2 := 1 + \ln|y| - \ln(1-|x|) < 0$. It follows that the integral on the semi-circle \mathfrak{C} tends to zero as $N \to \infty$.

Finally, by Cauchy's residue theorem and the assertion that ([2, p. 7])

$$\operatorname{Res}_{s=-n} \Gamma(-s) = \frac{(-1)^n}{n!},$$

we get the representation (2.6). This completes the proof.

Corollary 3.2. When $(x, y) \in \mathbb{V}_{\Psi_1}$ and $|y| \to \infty$, then

$$\Psi_1[a,b;c,c';x,y] \sim \frac{\Gamma(c')}{\Gamma(c'-a)} \sum_{n=0}^{\infty} {}_2F_1\left[\frac{-n,b}{c};x \right] \frac{(a)_n (1+a-c')_n}{n!} (-y)^{-n-a}.$$
(3.6)

Proof. Let *I* denote the right-hand side of (3.2), and let $\Psi(s)$ denote the integrand as defined in (3.3). Choose the positive integer $M \ge \max\{1, \Re(-a)\}$ and shift the integration contour to the left (which is permissible on account of the exponential decay of the integrand).

Note that s = -a - n ($n \in \mathbb{Z}_{\geq 0}$) are the only poles of $\Psi(s)$ because the principal branch of ${}_2F_1[a, b; c; z]$ is an entire function in *a* (see [20, p. 384]). Therefore,

$$\operatorname{Res}_{s=-a-n}\Psi(s) = {}_2F_1\left[\begin{array}{c} -n, b\\ c \end{array} ; x \right] \frac{\Gamma(a+n)}{\Gamma(c'-a-n)} \frac{(-1)^n}{n!} (-y)^{-a-n}.$$

By Cauchy's residue theorem, we obtain

$$\frac{\Gamma(a)}{\Gamma(c')}I = \sum_{n=0}^{M} {}_{2}F_{1}\left[\frac{-n,b}{c};x\right] \frac{\Gamma(a+n)}{\Gamma(c'-a-n)} \frac{(-1)^{n}}{n!} (-y)^{-n-a} + R_{M}(y),$$
(3.7)

where

$$R_M(y) := \frac{1}{2\pi i} \int_{C_M} \Psi(s) ds$$
(3.8)

and C_M denotes the vertical line $\Re(s) = \Re(-a) - M - 1/2$. Using (3.4) can get

$$|\Psi(s)| = \mathcal{O}\left(|\gamma|^{\Re(-a) - M - \frac{1}{2}} |t|^{\Re(2a - c') + M - \omega} e^{-\chi|t|}\right), \ t = \Im(s),$$

where ω is given in (2.3) and

$$\chi := \frac{\pi}{2} \pm \arg(-y) - \max\{0, \mp \arg(1-x)\} > 0.$$

Thus the integral (3.8) converges when $(x, y) \in \mathbb{V}_{\Psi_1}$. It follows that

$$R_M(y) = \mathcal{O}_M\left(|y|^{\Re(-a) - M - \frac{1}{2}}\right),$$

which shows that (3.7) is an asymptotic expansion of Poincaré type. Simplifying (3.7) with the help of the identities $\Gamma(a + n) = \Gamma(a) (a)_n$ and

$$\Gamma(c'-a-n) = (-1)^n \frac{\Gamma(c'-a)}{(1+a-c')_n}$$

gives the desired expansion (3.6).

Remark 3.3. *The region* V_{Ψ_1} *has an equivalent form:*

$$\mathbb{V}_{\Psi_1} = \left\{ (x, y) \in \mathbb{C}^2 : x \neq 1, \ y \neq 0, \ |\arg(-y)| < \frac{\pi}{2}, \ |\arg(1-x) + \arg(-y)| < \frac{\pi}{2} \right\}$$

which suggests that (3.6) is an asymptotic expansion for y on the left half-plane. If we further let x = 0 in (3.6), we get the expansion of ${}_1F_1[a;c';y]$ for $\Re(y) < 0$, viz. the formula (2.13).

In the rest of this subsection, we establish the asymptotics of Ψ_1 for *y* on the right half-plane by applying Olver's result [19, Theorem 1], which adapts Laplace's method to the complex parameter.

We restrict ourselves to the following three cases:

- (i) $\Re(c) > \Re(b) > 0, x = 0, y \in S;$
- (ii) $\Re(c) > \Re(b) > 0, x < 0, y \in S;$
- (iii) $\Re(c) > \Re(b) > 0, 0 < x < 1, y \in \mathbb{S},$

where $\mathbb{S} := \{y \in \mathbb{C} : |\arg y| \le \frac{\pi}{2} - \delta\}$ with $\delta \in (0, \frac{\pi}{2})$ fixed.

3.1.1 Case (i)

In this case, the asymptotics follows from

$$\Psi_1[a,b;c,c';0,y] = {}_1F_1\left[\begin{array}{c}a\\c';y\end{array}\right]$$

and (2.14).

3.1.2 Case (ii)

In this case, if $u \in (0, 1)$ then $1 - ux \in (1, 1 - x)$. Denote

$$\Psi_1 \equiv \Psi_1[a,b;c,c';x,y], g(u) := u^{b-1} (1-u)^{c-b-1} (1-ux)^{-a}.$$

The expansion (2.14) implies that there exists a constant C > 0 such that

$$\left| {}_{1}F_{1} \left[\begin{matrix} a \\ c'' \end{matrix}; \frac{y}{1 - ux} \end{matrix} \right] - h(u) \right| \le CR(u), \quad y \in \mathbb{S},$$

$$(3.9)$$

where

$$h(u) = \frac{\Gamma(c')}{\Gamma(a)} e^{\frac{y}{1-ux}} \left(\frac{y}{1-ux}\right)^{a-c'}, \ R(u) = e^{\frac{\Re(y)}{1-ux}} \left(\frac{|y|}{1-ux}\right)^{\Re(a-c')-1}.$$

For $\Re(\alpha) > 0$ and $\Re(\beta) > 0$, we define

$$I_{y}(\alpha,\beta,\gamma) := \int_{0}^{1} q(u) \mathrm{e}^{-yp(u)} \mathrm{d}u,$$

where $q(u) := u^{\alpha-1} (1-u)^{\beta-1} (1-ux)^{\gamma}$ and p(u) := 1/(ux-1). Obviously, p(u) and q(u) satisfy the conditions [19, p. 229]. Then applying Olver's result to $I_{\gamma}(\alpha, \beta, \gamma)$, we obtain

$$I_{y}(\alpha,\beta,\gamma) \sim \Gamma(\alpha) y^{-\alpha} e^{y} \cdot \sum_{n=0}^{\infty} \frac{(\alpha)_{n} \lambda_{n}}{y^{n}}, \quad y \to \infty, \ y \in \mathbb{S},$$
(3.10)

where $\lambda_0 = (-x)^{-\alpha}$ and

$$\lambda_n := \operatorname{Res}_{u=0} \frac{q(u)}{\left(p(u)+1\right)^{\alpha+n}}, \ n = 0, 1, 2, \cdots.$$
(3.11)

Take the leading term of the expansion (3.10) and then

$$I_{y}(\alpha,\beta,\gamma) = \Gamma(\alpha) (-x)^{-\alpha} y^{-\alpha} e^{y} \left[1 + \mathcal{O}\left(y^{-1}\right)\right], \quad y \to \infty, \ y \in \mathbb{S}$$

Using (2.7) and (3.9), we get that as $y \to \infty$ in \mathbb{S} ,

$$\begin{split} \Psi_{1} &= \frac{\Gamma(c)}{\Gamma(b)\Gamma(c-b)} \int_{0}^{1} g(u)h(u)du + \mathcal{O}\left(\int_{0}^{1} |g(u)|R(u)du\right) \\ &= \frac{\Gamma(c)\Gamma(c')}{\Gamma(a)\Gamma(b)\Gamma(c-b)} y^{a-c'} I_{y}(b,c-b,c'-2a) + \mathcal{O}\left(\left|y\right|^{\Re(a-c')-1} I_{\Re(y)}\left(\Re(b),\Re(c-b),\Re(c'-2a)+1\right)\right) \\ &= \frac{\Gamma(c)\Gamma(c')}{\Gamma(a)\Gamma(c-b)} (-x)^{-b} y^{a-b-c'} e^{y} + \mathcal{O}_{x}\left(\left|y\right|^{\Re(a-b-c')-1} e^{\Re(y)}\right). \end{split}$$

Hence, we have the following theorem.

Theorem 3.4. When x < 0 and $y \rightarrow \infty$ with $y \in S$, then

$$\Psi_1[a,b;c,c';x,y] \sim \frac{\Gamma(c)\Gamma(c')}{\Gamma(a)\Gamma(c-b)} (-x)^{-b} y^{a-b-c'} \mathrm{e}^y.$$

3.1.3 Case (iii)

In this case, the pair

$$(x', y') = \left(\frac{x}{x-1}, \frac{y}{1-x}\right)$$

satisfies **Case (ii)**. We can apply the Kummer transformation (2.8) to the pair (x', y'). Hence we get the following corollary.

Corollary 3.5. When 0 < x < 1 and $y \rightarrow \infty$ with $y \in S$, then

$$\Psi_1[a,b;c,c';x,y] \sim \frac{\Gamma(c)\Gamma(c')}{\Gamma(a)\Gamma(b)} x^{b-c} (1-x)^{c'+2(c-a-b)} y^{a+b-c-c'} e^{\frac{y}{1-x}}.$$
(3.12)

We can obtain the complete asymptotic expansion of Ψ_1 in **Case (ii)**. Indeed, in (3.10), take h(u) as the first N + 1 terms of (2.14) and take R(u) as the corresponding reminder term. Using (2.7) and (3.10), we get that as $y \to \infty$ in \mathbb{S} ,

$$\begin{split} \Psi_{1} &= \frac{\Gamma(c)}{\Gamma(b)\Gamma(c-b)} \int_{0}^{1} g(u)h(u)du + \mathcal{O}\left(\int_{0}^{1} |g(u)|R(u)du\right) \\ &= \frac{\Gamma(c)\Gamma(c')}{\Gamma(a)\Gamma(b)\Gamma(c-b)} y^{a-c'} \sum_{n=0}^{N} \frac{(1-a)_{n}(c'-a)_{n}}{n! y^{n}} I_{y}(b,c-b,n+c'-2a) + \mathcal{O}_{x}\left(|y|^{\Re(a-b-c')-N-1} e^{\Re(y)}\right) \\ &= \frac{\Gamma(c)\Gamma(c')}{\Gamma(a)\Gamma(c-b)} y^{a-b-c'} e^{y} \sum_{n=0}^{N} \frac{(1-a)_{n}(c'-a)_{n}}{n! y^{n}} \sum_{n=0}^{N} \frac{(b)_{n}\lambda_{n}}{y^{n}} + \mathcal{O}_{x}\left(|y|^{\Re(a-b-c')-N-1} e^{\Re(y)}\right) \\ &= \frac{\Gamma(c)\Gamma(c')}{\Gamma(a)\Gamma(c-b)} y^{a-b-c'} e^{y} \left\{ \sum_{n=0}^{N} \psi_{n} y^{-n} + \mathcal{O}_{x}\left(|y|^{-N-1}\right) \right\}, \end{split}$$

where

$$\psi_n := \sum_{k=0}^n \frac{(1-a)_k (c'-a)_k}{k!} (b)_{n-k} \lambda_{n-k}, \ n = 0, 1, 2, \cdots,$$
(3.13)

and $\lambda_n = \lambda_n(x)$ is given by (3.11). In particular, $\psi_0 := (-x)^{-b}$. Hence, we get the following theorem.

Theorem 3.6. When x < 0 and $y \to \infty$ with $y \in S$, the complete expansion of Ψ_1 is given by

$$\Psi_1[a,b;c,c';x,y] \sim \frac{\Gamma(c)\Gamma(c')}{\Gamma(a)\Gamma(c-b)} y^{a-b-c'} \mathrm{e}^y \sum_{n=0}^{\infty} \psi_n y^{-n}, \tag{3.14}$$

where $\psi_n = \psi_n(x)$ is given by (3.13). In particular, $\psi_0 = (-x)^{-b}$.

Remark 3.7. The coefficients in Laplace's method, such as λ_n in (3.11), were explicitly determined by G. Nemes; see [18, p. 477, Eq. (2.6)]. To get the complete asymptotic expansion of Ψ_1 in **Case (iii)**, we may insert (3.14) into (2.8), but the resulting expansion is terribly complicated.

3.2 Asymptotics for large *x*

In this subsection, we consider the behaviour of Ψ_1 for large *x* and derive the complete asymptotic expansion without using the contour integrals and the residue theorem.

The connection formula for the Gauss hypergeometric function is given by ([20, p. 390, Eq. (15.8.2)])

$${}_{2}F_{1}\begin{bmatrix}a,b\\c\end{bmatrix} = \mathfrak{f}_{c}(b,a)(-z)^{-a}{}_{2}F_{1}\begin{bmatrix}1-c+a,a;\frac{1}{z}\\1-b+a;\frac{1}{z}\end{bmatrix} + \mathfrak{f}_{c}(a,b)(-z)^{-b}{}_{2}F_{1}\begin{bmatrix}1-c+b,b;\frac{1}{z}\\1-a+b;\frac{1}{z}\end{bmatrix}, |\arg(-z)| < \pi.$$
(3.15)

where

$$\mathfrak{f}_{\gamma}(a,b) := \frac{\Gamma(\gamma)\Gamma(a-b)}{\Gamma(a)\Gamma(\gamma-b)}.$$
(3.16)

Applying (3.15) to (2.6), we get

$$\Psi_1[a,b;c,c';x,y] = f_c(b,a) (-x)^{-a} \mathbf{U}_1(x,y) + f_c(a,b) (-x)^{-b} \mathbf{U}_2(x,y),$$
(3.17)

where

$$\begin{aligned} \mathbf{U}_{1}(x,y) &:= \sum_{n=0}^{\infty} \frac{(a)_{n}}{n!(c')_{n}} \frac{(1-c+a)_{n}}{(1-b+a)_{n}} {}_{2}F_{1} \left[\begin{array}{c} 1-c+a+n,a+n \\ 1-b+a+n \end{array}; \frac{1}{x} \right] \left(-\frac{y}{x} \right)^{n}, \\ \mathbf{U}_{2}(x,y) &:= \sum_{n=0}^{\infty} \frac{(a-b)_{n}}{n!(c')_{n}} {}_{2}F_{1} \left[\begin{array}{c} 1-c+b,b \\ 1-a-n+b \end{cases}; \frac{1}{x} \right] y^{n} \end{aligned}$$

and $f_{\gamma}(a, b)$ is given by (3.16).

The series \mathbf{U}_1 is a special case of the Kampé de Fériet function. In fact, we have

$$\begin{aligned} \mathbf{U}_{1}(x,y) &= \sum_{n=0}^{\infty} \sum_{m=0}^{\infty} \frac{(a)_{n+m} (1-c+a)_{n+m}}{(1-b+a)_{n+m} (c')_{n} m! n!} \frac{(-y)^{n}}{x^{n+m}} \\ &= F_{1:0;1}^{2:0;0} \begin{bmatrix} a, 1-c+1:-;-\\ 1-b+a:-;c''; \frac{1}{x}, -\frac{y}{x} \end{bmatrix}, \end{aligned}$$

which suggests that the double series converges absolutely for |x| > 1 and $|y| < \infty$. Further calculation gives

$$\mathbf{U}_{1}(x,y) = \sum_{k=0}^{\infty} \frac{(a)_{k}(1-c+a)_{k}}{(1-b+a)_{k}k!} \frac{1}{x^{k}} \sum_{n=0}^{k} \frac{(-k)_{n}}{(c')_{n}} \frac{y^{n}}{n!}$$
$$= \sum_{k=0}^{\infty} {}_{1}F_{1} \begin{bmatrix} -k \\ c' \end{bmatrix} \frac{(a)_{k}(1-c+a)_{k}}{(1-b+a)_{k}k!} \frac{1}{x^{k}}, |x| > 1, |y| < \infty.$$
(3.18)

For the series \mathbf{U}_2 , we first note that

$$\begin{aligned} \mathbf{U}_{2}(x,y) &= \sum_{\ell,n=0}^{\infty} \frac{(1-c+b)_{\ell}(b)_{\ell}}{(1-a+b-n)_{\ell}\ell!} \frac{(a-b)_{n}}{(c')_{n}} \frac{1}{x^{\ell}} \frac{y^{n}}{n!} \\ &= \sum_{n,\ell=0}^{\infty} (a-b)_{n-\ell} \frac{(1-c+b)_{\ell}(b)_{\ell}}{(c')_{n}} \frac{(-1/x)^{\ell}}{\ell!} \frac{y^{n}}{n!} \\ &= H_{11} \left[a-b, b, 1-c+b, c'; y, -\frac{1}{x} \right], \ |x| > 1, |y| < \infty, \end{aligned}$$

where H_{11} defined by

$$H_{11}\left[a, b, c, d; x, y\right] := \sum_{m, n=0}^{\infty} \frac{(a)_{m-n}(b)_n(c)_n}{(d)_m} \frac{x^m}{m!} \frac{y^n}{n!}, \ |x| < \infty, |y| < 1$$

is one member of Horn's list (see [9, Eq. (39), p. 227] and [5]). In addition, we have

$$\mathbf{U}_{2}(x,y) = \sum_{\ell,n=0}^{\infty} \frac{(1-c+b)_{\ell}(b)_{\ell}}{(1-a+b)_{\ell}\ell!} \frac{1}{x^{\ell}} \cdot \frac{(a-b-\ell)_{n}}{(c')_{n}} \frac{y^{n}}{n!}$$
$$= \sum_{\ell=0}^{\infty} {}_{1}F_{1} \left[\frac{a-b-\ell}{c'}; y \right] \frac{(1-c+b)_{\ell}(b)_{\ell}}{(1-a+b)_{\ell}\ell!} \frac{1}{x^{\ell}}, |x| > 1, |y| < \infty.$$
(3.19)

The previous derivations are summarized in the following theorem.

Theorem 3.8. When $|\arg(-x)| < \pi$ and $|x| \to \infty$, we have

$$\Psi_1[a,b;c,c';x,y] \sim f_c(b,a) (-x)^{-a} + f_c(a,b) (-x)^{-b} {}_1F_1\begin{bmatrix} a-b\\c';y \end{bmatrix},$$

where f_{γ} is given by (3.16). The complete expansion is obtained by combining (3.17), (3.18) and (3.19).

4 Asymptotics of F_K

Using (2.13) and (3.6), we get a sufficient condition of convergence for the integral (1.4):

$$\Re(\alpha_2) > 0, |\arg(-y)| < \frac{\pi}{2} \text{ and } (x, z) \in \mathbb{V}_{\Psi_1}.$$

Under this condition, we also have $(x, y, z) \in \mathbb{V}_K$. So the integral (1.4) makes sense.

After the change of the variables $s = \tilde{\gamma}t$, with $\tilde{\gamma} = 1/|\gamma|$, and defining $\gamma := \tilde{z}/\tilde{\gamma} := |\gamma|/|z|$, the integral (1.4) reads

$$F_{K}[\alpha_{1},\alpha_{2},\alpha_{2},\beta_{1},\beta_{2},\beta_{1};\gamma_{1},\gamma_{2},\gamma_{3};x,y,z] = \frac{\tilde{\gamma}}{\Gamma(\alpha_{2})} \int_{0}^{\infty} e^{-\tilde{\gamma}t} \left(\tilde{\gamma}t\right)^{\alpha_{2}-1} {}_{1}F_{1}\begin{bmatrix}\beta_{2}\\\gamma_{2}\end{bmatrix} t e^{i\alpha} \Psi_{1}[\beta_{1},\alpha_{1};\gamma_{1},\gamma_{3};x,te^{i\beta}/\gamma]dt,$$
(4.1)

where α and β are the principal arguments of the respective variables y and z: $y = |y|e^{i\alpha}$ and $z = |z|e^{i\beta}$.

We are interested in the approximation of F_K for large y and z uniformly in γ with

$$0 < \rho_1 < \gamma < \rho_2 < \infty.$$

This means that \tilde{y} is small, γ is bounded, and the remaining parameters $\alpha_1, \alpha_2, \beta_1, \beta_2, \gamma_1, \gamma_2, \gamma_3, x$ are fixed. In order to apply López's theorem [14], we also require that

$$\alpha_2 > 0$$
 and $\beta_1 + \beta_2 > 0$.

Throughout this section, we define

$$f(t) := {}_{1}F_{1} \begin{bmatrix} \beta_{2} \\ \gamma_{2} \end{bmatrix} \Psi_{1} [\beta_{1}, \alpha_{1}; \gamma_{1}, \gamma_{3}; x, te^{i\beta} / \gamma], \ h(t) := e^{-t} t^{\alpha_{2} - 1}.$$
(4.2)

Then the integral (4.1) is of the form of the Mellin integrals considered in [14]:

$$F_{K}[\alpha_{1},\alpha_{2},\alpha_{2},\beta_{1},\beta_{2},\beta_{1};\gamma_{1},\gamma_{2},\gamma_{3};x,y,z] = \frac{\widetilde{\gamma}}{\Gamma(\alpha_{2})} \int_{0}^{\infty} h(\widetilde{\gamma}t)f(t)dt.$$
(4.3)

The functions f(t) and h(t) are locally integrable on $[0,\infty)$, a property required by the technique introduced in [14] to obtain an asymptotic expansion of the integral (4.3) for small \tilde{y} . That technique also requires the asymptotic behaviours of these functions given below and is valid for $\Re(y) < 0$ and $\Re(z) < 0$ ($\pi/2 < |\alpha|, |\beta| < \pi$):

(i) A power asymptotic expansion of h(t) at t = 0:

$$h(t) = \sum_{k=0}^{m-1} A_k t^{k+\alpha_2-1} + h_m(t), \ A_k := \frac{(-1)^k}{k!},$$

with $h_m(t) = \mathcal{O}(t^{m+\alpha_2-1})$ when $t \to 0^+$;

(ii) An inverse power asymptotic expansion of f(t) at $t = \infty$:

$$f(t) = \sum_{k=0}^{n-1} B_k t^{-k-\beta_1-\beta_2} + f_n(t),$$

with $B_k = (-y\widetilde{y})^{-k-\beta_1-\beta_2}\widetilde{B}_k$,

$$\begin{split} \widetilde{B}_k &:= \frac{\Gamma(\gamma_2)\Gamma(\gamma_3)}{\Gamma(\gamma_2 - \beta_2)\Gamma(\gamma_3 - \beta_1)} \left(\frac{y}{z}\right)^{\beta_1} \\ &\times \sum_{j=0}^k \frac{(\beta_2)_j (1 + \beta_2 - \gamma_2)_j (\beta_1)_{k-j} (1 + \beta_1 - \gamma_3)_{k-j}}{j! (k-j)!} {}_2F_1 \left[\frac{j - k, \alpha_1}{\gamma_1}; x\right] \left(\frac{y}{z}\right)^{k-j}, \end{split}$$

and $f_n(t) = \mathcal{O}(t^{-\beta_1 - \beta_2 - n})$ when $t \to \infty$. The above expansion follows from (2.13) and (3.6); (iii) $h(t) = \mathcal{O}(t^{-N})$ when $t \to \infty$ for any positive integer N and $f(t) = 1 + \mathcal{O}(t)$ when $t \to 0^+$.

Following [14], we denote by $\mathfrak{M}[g; s]$ the Mellin transform of *g*. Clearly, $\mathfrak{M}[h; s] = \Gamma(s + \alpha_2 - 1)$. Using (A.3), we can readily get

where

$$C_1^*(s) := \frac{\Gamma(\gamma_2)\Gamma(\gamma_3)\Gamma(s-\beta_2)\Gamma(\beta_1+\beta_2-s)}{\Gamma(\beta_1)\Gamma(\gamma_2-\beta_2)\Gamma(\beta_2+\gamma_3-s)}, \quad C_2^*(s) := \frac{\Gamma(\gamma_2)\Gamma(s)\Gamma(\beta_2-s)}{\Gamma(\beta_2)\Gamma(\gamma_2-s)}, \tag{4.4}$$

 $\Re(y) < 0, (x, z) \in \mathbb{V}_{\Psi_1} \text{ and } \rho_x < |y|/|z|.$

Let us summarize the conditions needed in our further derivation as follows

$$\alpha_2 > 0, \ \beta_1 + \beta_2 > 0, \ |\arg(-y)| < \frac{\pi}{2}, \ (x, z) \in \mathbb{V}_{\Psi_1} \text{ and } \rho_x < \frac{|y|}{|z|} < \rho_2 < \infty.$$
 (4.5)

4.1 The nonlogarithmic case

When $\beta_1 + \beta_2 - \alpha_2 \notin \mathbb{Z}$, from [14, Theorem 1] we have the following asymptotic expansion of F_K for small \tilde{y} . For any $n \in \mathbb{Z}_{>0}$,

$$\Gamma(\alpha_{2})F_{K}[\alpha_{1},\alpha_{2},\alpha_{2},\beta_{1},\beta_{2},\beta_{1};\gamma_{1},\gamma_{2},\gamma_{3};x,y,z] = \sum_{k=0}^{n-1} B_{k}\mathfrak{M}[h;1-k-\beta_{1}-\beta_{2}]\tilde{y}^{k+\beta_{1}+\beta_{2}} + \sum_{k=0}^{m-1} A_{k}\mathfrak{M}[f;k+\alpha_{2}]\tilde{y}^{k+\alpha_{2}} + R_{n}(\tilde{y}),$$

$$(4.6)$$

where $m = n + \lfloor 1 - \alpha_2 + \beta_1 + \beta_2 \rfloor$ and the reminder $R_n(\tilde{y}) = \mathcal{O}(\tilde{y}^{n+\beta_1+\beta_2})$ when $\tilde{y} \to 0$.

Computing the Mellin transforms involved in (4.6), we obtain that, under the condition (4.5),

$$F_{K}[\alpha_{1},\alpha_{2},\alpha_{2},\beta_{1},\beta_{2},\beta_{1};\gamma_{1},\gamma_{2},\gamma_{3};x,y,z] = \sum_{k=0}^{n-1} \frac{\widehat{B}_{k}(y/z)}{y^{k+\beta_{1}+\beta_{2}}} + \sum_{k=0}^{m-1} \frac{\widehat{A}_{k}(y/z)}{y^{k+\alpha_{2}}} + R_{n}(y),$$
(4.7)

with

$$\begin{aligned} \widehat{A}_{k}(y/z) &:= \frac{(-1)^{-k-\alpha_{2}}}{\Gamma(\alpha_{2})} \Gamma(\gamma_{2}) A_{k} \left\{ \frac{\Gamma(\gamma_{3})\Gamma(k+\alpha_{2}-\beta_{2})\Gamma(\beta_{1}+\beta_{2}-\alpha_{2}-k)}{\Gamma(\beta_{1})\Gamma(\gamma_{2}-\beta_{2})\Gamma(\beta_{2}+\gamma_{3}-\alpha_{2}-k)} \left(\frac{y}{z}\right)^{k+\alpha_{2}-\beta_{2}} \right. \\ &\times F_{0:1;2}^{1:1;2} \left[\frac{\beta_{1}+\beta_{2}-\alpha_{2}-k; \ \alpha_{1}; \ \beta_{2}, \beta_{2}-\gamma_{2}+1}{\vdots \ \gamma_{1}; \ \beta_{2}+1-\alpha_{2}-k, \ \beta_{2}+\gamma_{3}-\alpha_{2}-k; \ x, -\frac{z}{y} \right] \\ &+ \frac{\Gamma(k+\alpha_{2})\Gamma(\beta_{2}-\alpha_{2}-k)}{\Gamma(\beta_{2})\Gamma(\gamma_{2}-\alpha_{2}-k)} F_{0:1;2}^{1:1;2} \left[\frac{\beta_{1}: \ \alpha_{1}; \ k+\alpha_{2}, k+\alpha_{2}-\gamma_{2}+1}{; \ \gamma_{3}, k+\alpha_{2}-\beta_{2}+1}; x, -\frac{z}{y} \right] \end{aligned}$$
(4.8)

and

$$\widehat{B}_k(y/z) := \frac{\Gamma(\alpha_2 - \beta_1 - \beta_2 - k)}{\Gamma(\alpha_2)} \left(-1\right)^{-k - \beta_1 - \beta_2} \widetilde{B}_k.$$
(4.9)

The reminder $R_n(y)$ verifies $R_n(y) = \mathcal{O}(y^{-n-\beta_1-\beta_2})$ when $|y| \to \infty$ uniformly in |z| with y/z bounded.

4.2 The logarithmic case I

When $1 + \beta_1 + \beta_2 - \alpha_2 \in \mathbb{Z}_{>0}$, from [14, Theorem 1] we have the following asymptotic expansion for small \tilde{y} . For any $n \in \mathbb{Z}_{>0}$,

$$\Gamma(\alpha_{2})F_{K}[\alpha_{1},\alpha_{2},\alpha_{2},\beta_{1},\beta_{2},\beta_{1};\gamma_{1},\gamma_{2},\gamma_{3};x,y,z] = \sum_{k=0}^{\beta_{1}+\beta_{2}-\alpha_{2}-1} A_{k}\mathfrak{M}[f;k+\alpha_{2}]\widetilde{y}^{k+\alpha_{2}}$$

$$+\sum_{k=0}^{n-1}\widetilde{y}^{k+\beta_{1}+\beta_{2}}\left\{-B_{k}A_{k-\alpha_{2}+\beta_{1}+\beta_{2}}\log\widetilde{y}+\lim_{s\to0}\left(B_{k}\mathfrak{M}[h;s+1-k-\beta_{1}-\beta_{2}]\right)\right\}$$

$$+A_{k-\alpha_{2}+\beta_{1}+\beta_{2}}\mathfrak{M}[f;s+k+\beta_{1}+\beta_{2}]\right\}+R_{n}(\widetilde{y}),$$
(4.10)

where $m = n - \alpha_2 + \beta_1 + \beta_2$ and the reminder $R_n(\tilde{y}) = \mathcal{O}(\tilde{y}^{n+\beta_1+\beta_2}\log\tilde{y})$ when $\tilde{y} \to 0$.

To compute the limit involved in (4.10), we follow [14, Eq. (9) and (10)]. Write

$$\mathfrak{M}[f; s+k+\beta_1+\beta_2] = C_f - \frac{B_k}{s}, \ \mathfrak{M}[h; s+1-k-\beta_1-\beta_2] = C_h + \frac{A_{k-\alpha_2+\beta_1+\beta_2}}{s}, \ \text{as } s \to 0.$$

Thus, that limit exsits. Further, observing that only the factor $\Gamma(\beta_1 + \beta_2 - s)$ of $C_1^*(s)$ (see (4.4)) and $\mathfrak{M}[h; s]$ have poles at $1 - k - \beta_1 - \beta_2$, that limit can be reduced to the form as described in (2.17). Therefore, using (2.17) and after some calculations, we obtain that, under the condition (4.5),

$$F_{K}[\alpha_{1},\alpha_{2},\alpha_{2},\beta_{1},\beta_{2},\beta_{1};\gamma_{1},\gamma_{2},\gamma_{3};x,y,z] = \sum_{k=0}^{\beta_{1}+\beta_{2}-\alpha_{2}-1} \frac{\widehat{A}_{k}(y/z)}{y^{k+\alpha_{2}}} + \sum_{k=0}^{n-1} \frac{\widehat{C}_{k}(y/z) + B_{k}^{\times}(y/z)\log|y|}{y^{k+\beta_{1}+\beta_{2}}} + R_{n}(y),$$
(4.11)

with $\widehat{A}_k(y/z)$ given in (4.8),

$$B_{k}^{\times}(y/z) := \frac{(-1)^{-k-\beta_{1}-\beta_{2}}}{\Gamma(\alpha_{2})} \widetilde{B}_{k} A_{k-\alpha_{2}+\beta_{1}+\beta_{2}}$$
(4.12)

and

$$\begin{aligned} \widehat{C}_{k}(y/z) &:= \frac{(-1)^{-k-\beta_{1}-\beta_{2}}}{\Gamma(\alpha_{2})} \bigg\{ \frac{\widetilde{B}_{k}(-1)^{k-\alpha_{2}+\beta_{1}+\beta_{2}}\psi(k-\alpha_{2}+\beta_{1}+\beta_{2}+1)}{(k-\alpha_{2}+\beta_{1}+\beta_{2})!} \\ &+ A_{k-\alpha_{2}+\beta_{1}+\beta_{2}}\Gamma(\gamma_{2}) \bigg[\frac{(y/z)^{k+\beta_{1}}(-1)^{k}\psi(k+1)\Gamma(\gamma_{3})\Gamma(k+\beta_{1})}{\Gamma(\beta_{1})\Gamma(\gamma_{2}-\beta_{2})\Gamma(\gamma_{3}-\beta_{1}-k)k!} \\ &\times F_{0:1;2}^{1:1;2} \bigg[\frac{-k:\ \alpha_{1};\ \beta_{2},\ \beta_{2}-\gamma_{2}+1}{\vdots\ \gamma_{1};\ 1-\beta_{1}-k,\ \gamma_{3}-\beta_{1}-k};\ x,-\frac{z}{y} \bigg] \\ &+ \frac{\Gamma(-\beta_{1}-k)\Gamma(k+\beta_{1}+\beta_{2})}{\Gamma(\beta_{2})\Gamma(\gamma_{2}-\beta_{1}-\beta_{2}-k)} F_{0:1;2}^{1:1;2} \bigg[\frac{\beta_{1}:\ \alpha_{1};\ k+\beta_{1}+\beta_{2},\ k+\beta_{1}+\beta_{2}-\gamma_{2}+1}{\gamma_{3},\ k+\beta_{1}+1};\ x,-\frac{z}{y} \bigg] \bigg] \bigg\}, \quad (4.13) \end{aligned}$$

where $\psi(s)$ is the digamma function.

4.3 The logarithmic case II

When $\alpha_2 - \beta_1 - \beta_2 \in \mathbb{Z}_{>0}$, from [14, Theorem 1] we have the following asymptotic expansion for small \tilde{y} . For any $n \in \mathbb{Z}_{>0}$,

$$\Gamma(\alpha_{2})F_{K}[\alpha_{1},\alpha_{2},\alpha_{2},\beta_{1},\beta_{2},\beta_{1};\gamma_{1},\gamma_{2},\gamma_{3};x,y,z] = \sum_{k=0}^{\alpha_{2}-\beta_{1}-\beta_{2}-1} B_{k}\mathfrak{M}[h;1-k-\beta_{1}-\beta_{2}]\tilde{y}^{k+\beta_{1}+\beta_{2}} + \sum_{k=0}^{m-1} \tilde{y}^{k+\alpha_{2}} \left\{ -A_{k}B_{k+\alpha_{2}-\beta_{1}-\beta_{2}}\log\tilde{y} + \lim_{s\to 0} \left(A_{k}\mathfrak{M}[f;s+k+\alpha_{2}] + B_{k+\alpha_{2}-\beta_{1}-\beta_{2}}\mathfrak{M}[h;s+1-\alpha_{2}-k] \right) \right\} + R_{n}(\tilde{y}),$$

$$(4.14)$$

where $n = m + \alpha_2 - \beta_1 - \beta_2$ and the reminder $R_n(\tilde{y}) = \mathcal{O}(\tilde{y}^{n+\beta_1+\beta_2}\log\tilde{y})$ when $\tilde{y} \to 0$. Computing the limit involved in (4.14) and after some calculations, we obtain that, under the condition (4.5),

$$F_{K}[\alpha_{1},\alpha_{2},\alpha_{2},\beta_{1},\beta_{2},\beta_{1};\gamma_{1},\gamma_{2},\gamma_{3};x,y,z] = \sum_{k=0}^{\alpha_{2}-\beta_{1}-\beta_{2}-1} \frac{\widehat{B}_{k}(y/z)}{y^{k+\beta_{1}+\beta_{2}}} + \sum_{k=0}^{m-1} \frac{\widehat{C}_{k+\alpha_{2}-\beta_{1}-\beta_{2}}(y/z) + B_{k+\alpha_{2}-\beta_{1}-\beta_{2}}^{\times}(y/z)\log|y|}{y^{k+\alpha_{2}}} + R_{n}(y),$$
(4.15)

with $\widehat{B}_k(y/z)$, $B_k^{\times}(y/z)$ and $\widehat{C}_k(y/z)$ given in (4.9), (4.12) and (4.13), respectively. In (4.11) and (4.15), the reminder term $R_n(y) = \mathcal{O}(y^{-m-\alpha_2} \log y)$ when $|y| \to \infty$ uniformly in |z| with y/z bounded.

Remark 4.1. When x < 1, in view of (2.12), the condition (4.5) attached to the functions f and h defined in (4.2) can be replaced by

$$\begin{aligned} \alpha_2 > 0, \ \beta_1 + \beta_2 > 0, \ |\arg(-y)| < \frac{\pi}{2}, \ |\arg(-z)| < \frac{\pi}{2}, \\ \Re(\gamma_1) > \Re(\alpha_1) > 0, \ x < 1, \ \left|\arg\left(1 - \frac{y}{1 - x}\right)\right| < \pi, \ 0 < \rho_1 < \frac{|y|}{|z|} < \rho_2 < \infty. \end{aligned}$$

Under this condition, the asymptotic expansions (4.7), (4.11) and (4.15) and the corresponding error estimates remain true. In addition, by letting x = 0 in (4.3), we obtain

$$F_2[\alpha_2,\beta_2,\beta_1;\gamma_2,\gamma_3;y,z] = \frac{\widetilde{y}}{\Gamma(\alpha_2)} \int_0^\infty h(\widetilde{y}t)f(t)dt,$$

where

$$f(t) = {}_{1}F_{1}\begin{bmatrix} \beta_{2} \\ \gamma_{2} \end{bmatrix} {}_{1}F_{1}\begin{bmatrix} \beta_{1} \\ \gamma_{3} \end{bmatrix} {}_{1}te^{i\beta}/\gamma \end{bmatrix}, \ h(t) = e^{-t}t^{\alpha_{2}-1}$$

and F_2 is the second Appell hypergeometric function. The integral shares the same form with the Mellin integral considered by Garcia and López in [10, Eq. (1.4)]. Therefore, our results contain Garcia and López's results as special cases.

A Calculation of a Mellin transform

Here we calculate a Mellin transform needed in Section 4. As in Section 4, the symbol $\mathfrak{M}[g;s]$ denotes the Mellin transform of *g* when it exists, or its analytic continuation as a function of *s*.

When $\Re(\lambda) < 0$ and $(x, \mu) \in \mathbb{V}_{\Psi_1}$, we define

$$\Psi_F(t) := {}_1F_1\begin{bmatrix}\xi\\\eta;\lambda t\end{bmatrix}\Psi_1[a,b;c,c';x,\mu t].$$

In view of (2.13) and (3.6), $\Psi_F(t) = 1 + o(1)$ as $t \to 0^+$ and Ψ_F has an inverse power asymptotic expansion as $t \to +\infty$. Moreover, $\Psi_F \in L^1_{\text{loc}}(0,\infty)$. Thanks to [14, p. 278, Remark 1], the Mellin transform $\mathfrak{M}[\Psi_F; s]$ exists and defines a meromorphic function of *s* in the half plane $\Re(s) > 0$.

Using (2.7) and swapping the order of integrations, we obtain

$$\mathfrak{M}[\Psi_F;s] = \frac{\Gamma(c)}{\Gamma(b)\Gamma(c-b)} \int_0^1 u^{b-1} (1-u)^{c-b-1} (1-ux)^{-a} \\ \times \mathfrak{M}\left[{}_1F_1\left[\xi;\lambda t\right]{}_1F_1\left[a;\frac{\mu t}{1-ux}\right];s\right] \mathrm{d}u.$$
(A.1)

The Mellin transform in right-hand side of (A.1) is given by [3, p. 436, Eq. (1)]

$$\mathfrak{M}\left[{}_{1}F_{1}\left[\begin{matrix}a\\b\end{smallmatrix};-\omega t\end{matrix}\right]{}_{1}F_{1}\left[\begin{matrix}c\\d\end{smallmatrix};-\sigma t\end{matrix}\right];s\right] = \omega^{-s}\frac{\Gamma(b)\Gamma(s)\Gamma(a-s)}{\Gamma(a)\Gamma(b-s)}{}_{3}F_{2}\left[\begin{matrix}c,s,s-b+1\\d,s-a+1\end{matrix};-\frac{\sigma}{\omega}\right] + \sigma^{a-s}\omega^{-a}\frac{\Gamma(b)\Gamma(d)\Gamma(s-a)\Gamma(a+c-s)}{\Gamma(d)\Gamma(b-a)\Gamma(a+d-s)}{}_{3}F_{2}\left[\begin{matrix}a,a-b+1,a+c-s\\a-s+1,a+d-s\end{matrix};-\frac{\sigma}{\omega}\right], \quad (A.2)$$

where $\Re(\sigma) > 0$, $\Re(\omega) > 0$ and $0 < \Re(s) < \Re(a + c)$. In order to apply (A.2) to (A.1), we need the restriction $\Re(\mu/(1 - ux)) < 0$. Here for convenience, we require that x < 1 so that

$$\Re\left(\frac{\mu}{1-ux}\right) = \frac{1}{1-ux}\Re(\mu) = -\frac{1}{1-ux}|\mu|\cos\left(\arg(-\mu)\right) < 0.$$

Taking $\omega = -\lambda$ and $\sigma = \mu/(ux-1)$ in (A.2) and inserting (A.2) into (A.1), we obtain

$$\mathfrak{M}[\Psi_F;s] = C_1(s)(-\mu)^{-s} \left(\frac{\mu}{\lambda}\right)^{\xi} I_1(s) + C_2(s)(-\lambda)^{-s} I_2(s),$$

where

$$C_{1}(s) := \frac{\Gamma(\eta)\Gamma(c')\Gamma(s-\xi)\Gamma(a+\xi-s)}{\Gamma(a)\Gamma(\eta-\xi)\Gamma(\xi+c'-s)}, \quad C_{2}(s) := \frac{\Gamma(\eta)\Gamma(s)\Gamma(\xi-s)}{\Gamma(\xi)\Gamma(\eta-s)},$$
$$I_{1}(s) := \frac{\Gamma(c)}{\Gamma(b)\Gamma(c-b)} \int_{0}^{1} u^{b-1} (1-u)^{c-b-1} (1-ux)^{s-a-\xi} \times {}_{3}F_{2} \begin{bmatrix} \xi, \xi-\eta+1, a+\xi-s \\ \xi+1-s, \xi+c'-s \end{bmatrix} \frac{1}{\lambda} \frac{1}{ux-1} du$$

and

$$I_{2}(s) := \frac{\Gamma(c)}{\Gamma(b)\Gamma(c-b)} \int_{0}^{1} u^{b-1} (1-u)^{c-b-1} (1-ux)^{-a} \\ \times {}_{3}F_{2} \left[\begin{matrix} a,s,s-\eta+1\\c',s-\xi+1 \end{matrix}; \frac{\mu}{\lambda} \frac{1}{ux-1} \end{matrix} \right] \mathrm{d}u.$$

With the help of (2.11), $I_1(s)$ and $I_2(s)$ can be evaluated in terms of the Kampé de Fériet function $F_{0:1;2}^{1:1;2}$.

Theorem A.1.

$$\mathfrak{M}[\Psi_{F};s] = C_{1}(s)(-\mu)^{-s} \left(\frac{\mu}{\lambda}\right)^{\xi} F_{0:1;2}^{1:1;2} \left[\frac{a+\xi-s:\ b;\ \xi,\xi-\eta+1}{:\ c;\ \xi+1-s,\xi+c'-s};x,-\frac{\mu}{\lambda}\right] + C_{2}(s)(-\lambda)^{-s} F_{0:1;2}^{1:1;2} \left[\frac{a:\ b;\ s,s-\eta+1}{-:\ c;\ c',s-\xi+1};x,-\frac{\mu}{\lambda}\right].$$
(A.3)

By continuation of $F_{0:1;2}^{1:1;2}$, (A.3) is valid for

$$\Re(\lambda) < 0, \ (x,\mu) \in \mathbb{V}_{\Psi_1} \text{ and } \left(x,-\frac{\mu}{\lambda}\right) \in \mathbb{D}_F.$$
 (A.4)

Remark A.2. There are several different proofs of (A.2), which makes it of particular interest. A classical approach is to replace the second $_1F_1$ function with its Mellin-Barnes integral representation and then interchange the order of integration to obtain a single contour integral. The use of Cauchy's residue theorem will do the rest. A more interesting proof requires the method of brackets (see, for example, [1] and [11]).
