# Exterior stability of Minkowski spacetime with borderline decay

#### Abstract

In 1993, the global stability of Minkowski spacetime has been proven in the celebrated work of Christodoulou and Klainerman [5]. In 2003, Klainerman and Nicolò [13] revisited Minkowski stability in the exterior of an outgoing null cone. In [22], the author extended the results of [5] to minimal decay assumptions. In this paper, we prove that the exterior stability of Minkowski holds with decay which is borderline compared to the minimal decay considered in [22].

## 1 Introduction

### 1.1 Einstein vacuum equations and the Cauchy problem

A Lorentzian 4-manifold $(\mathcal{M}, \mathbf{g})$ is called a vacuum spacetime if it solves the Einstein vacuum equations:

$$
\begin{equation*}
\boldsymbol{\operatorname { R i c }}(\mathbf{g})=0 \quad \text { in } \mathcal{M} \tag{1.1}
\end{equation*}
$$

where Ric denotes the Ricci tensor of the Lorentzian metric $\mathbf{g}$. The Einstein vacuum equations are invariant under diffeomorphisms, and therefore one considers equivalence classes of solutions. Expressed in general coordinates, (1.1) is a non-linear geometric coupled system of partial differential equations of order 2 for $\mathbf{g}$. In suitable coordinates, for example so-called wave coordinates, it can be shown that (1.1) is hyperbolic and hence admits an initial value formulation.

The corresponding initial data for the Einstein vacuum equations is given by specifying a triplet $(\Sigma, g, k)$ where $(\Sigma, g)$ is a Riemannian 3 -manifold and $k$ is the traceless symmetric 2-tensor on $\Sigma$ satisfying the constraint equations:

D^{j} k_{i j} & =D_{i}(\operatorname{tr} k),

where $R$ denotes the scalar curvature of $g, D$ denotes the Levi-Civita connection of $g$ and

$$
|k|^{2}:=g^{a d} g^{b c} k_{a b} k_{c d}, \quad \operatorname{tr} k:=g^{i j} k_{i j} .
$$

[^0]In the future development $(\mathcal{M}, \mathbf{g})$ of such initial data $(\Sigma, g, k), \Sigma \subset \mathcal{M}$ is a spacelike hypersurface with induced metric $g$ and second fundamental form $k$.

The seminal well-posedness results for the Cauchy problem obtained in [3,4] ensure that for any smooth Cauchy data, there exists a unique smooth maximal globally hyperbolic development $(\mathcal{M}, \mathbf{g})$ solution of Einstein equations (1.1) such that $\Sigma \subset \mathcal{M}$ and $g, k$ are respectively the first and second fundamental forms of $\Sigma$ in $\mathcal{M}$.

The prime example of a vacuum spacetime is Minkowski spacetime:

$$
\mathcal{M}=\mathbb{R}^{4}, \quad \mathbf{g}=-d t^{2}+\left(d x^{1}\right)^{2}+\left(d x^{2}\right)^{2}+\left(d x^{3}\right)^{2}
$$

for which Cauchy data are given by

$$
\Sigma=\mathbb{R}^{3}, \quad g=\left(d x^{1}\right)^{2}+\left(d x^{2}\right)^{2}+\left(d x^{3}\right)^{2}, \quad k=0
$$

In the present work, we consider the problem of the stability of Minkowski spacetime and start with reviewing the literature on this problem.

### 1.2 Previous works of the stability of Minkowski spacetime

In 1993, Christodoulou and Klainerman [5] proved the global stability of Minkowski for the Einstein-vacuum equations, a milestone in the domain of mathematical general relativity. In 2003, Klainerman and Nicolò [13] proved the Minkowski stability in the exterior of an outgoing cone using the double null foliation. Moreover, Klainerman and Nicolò [14] showed that under stronger asymptotic decay and regularity properties than those used in [5, 13], asymptotically flat initial data sets lead to solutions of the Einstein vacuum equations which have strong peeling properties. Given that the goal of this paper is to extend the result of [13], we will state the results of $[5,13]$ in Section 1.3.

We now mention other proofs of Minkowski stability. In 2007, Bieri [2] gave a new proof of global stability of Minkowski requiring one less derivative and less vectorfields compared to [5]. Lindblad and Rodnianski $[18,19]$ gave a new proof of the stability of the Minkowski spacetime using wave-coordinates and showing that the Einstein equations verify the so called weak null structure in that gauge. Huneau [11] proved the nonlinear stability of Minkowski spacetime with a translation Killing field using generalised wave-coordinates. Using the framework of Melrose's b-analysis, Hintz and Vasy [9] reproved the stability of Minkowski space. Graf [7] proved the global nonlinear stability of Minkowski space in the context of the spacelike-characteristic Cauchy problem for Einstein vacuum equations, which together with [13] allows to reobtain [5]. Under the framework of [13] and using $r^{p}$-weighted estimates of Dafermos and Rodnianski [6], the author [21] reproved the Minkowski stability in exterior regions. More recently, Hintz [8] reproved the Minkowski stability in exterior regions by using the framework of [9]. Using $r^{p_{-}}$ weighted estimates, the author [22] extends the results of [2] to minimal decay assumption.

There are also stability results concerning Einstein's equations coupled with non trivial matter fields, see for example the introduction of $[21,22]$.

### 1.3 Minkowski Stability in [5, 13]

We recall in this section the results in $[5,13]$. First, we recall the definition of a maximal hypersurface, which plays an important role in the statements of the main theorems in $[5,13]$.

Definition 1.1. An initial data $(\Sigma, g, k)$ is posed on a maximal hypersurface if it satisfies

$$
\begin{equation*}
\operatorname{tr} k=0 . \tag{1.3}
\end{equation*}
$$

In this case, we say that $(\Sigma, g, k)$ is a maximal initial data set, and the constraint equations (1.2) reduce to

$$
\begin{equation*}
R=|k|^{2}, \quad \operatorname{div} k=0, \quad \operatorname{tr} k=0 \tag{1.4}
\end{equation*}
$$

We introduce the notion of $s$-asymptotically flat initial data.
Definition 1.2. Given $s \geq 1$ and $q \geq 0$, we say that a data set $\left(\Sigma_{0}, g, k\right)$ is $(s, q)$-asymptotically flat if there exists a coordinate system $\left(x^{1}, x^{2}, x^{3}\right)$ defined outside a sufficiently large compact set such that:

- In the case of $s \geq 3^{1}$

$$
\begin{equation*}
g_{i j}=\left(1-\frac{2 M}{r}\right)^{-1} d r^{2}+r^{2} d \sigma_{\mathbb{S}^{2}}+o_{q+1}\left(r^{-\frac{s-1}{2}}\right), \quad k_{i j}=o_{q}\left(r^{-\frac{s+1}{2}}\right) . \tag{1.5}
\end{equation*}
$$

- In the case of $1 \leq s<3$

$$
\begin{equation*}
g_{i j}=\delta_{i j}+o_{q+1}\left(r^{-\frac{s-1}{2}}\right), \quad k_{i j}=o_{q}\left(r^{-\frac{s+1}{2}}\right) . \tag{1.6}
\end{equation*}
$$

We also introduce the following functional:

$$
J_{0}\left(\Sigma_{0}, g, k\right):=\sup _{\Sigma_{0}}\left(\left(d_{0}^{2}+1\right)^{3}|\operatorname{Ric}|^{2}\right)+\int_{\Sigma_{0}} \sum_{l=0}^{3}\left(d_{0}^{2}+1\right)^{l+1}\left|D^{l} k\right|^{2}+\int_{\Sigma_{0}} \sum_{l=0}^{1}\left(d_{0}^{2}+1\right)^{l+3}\left|D^{l} B\right|^{2},
$$

where $d_{0}$ is the geodesic distance from a fixed point $O \in \Sigma_{0}$, and $B_{i j}:=(\operatorname{curl} \widehat{R})_{i j}$ is the Bach tensor, $\widehat{R}$ is the traceless part of Ric. Now, we can state the main theorems of [5] and [13].

Theorem 1.3 (Global stability of Minkowski space [5]). There exists an $\varepsilon_{0}>0$ sufficiently small such that if $J_{0}\left(\Sigma_{0}, g, k\right) \leq \varepsilon_{0}^{2}$, then the initial data set $\left(\Sigma_{0}, g, k\right),(4,3)$-asymptotically flat (in the sense of Definition 1.2) and maximal, has a unique, globally hyperbolic, smooth, geodesically complete solution. This development is globally asymptotically flat, i.e. the Riemann curvature tensor tends to zero along any causal or spacelike geodesic. Moreover, there exists a global maximal time function $t$ and a optical function $u^{2}$ defined everywhere in an external region.

Theorem 1.4 (Exterior stability of Minkowski [13]). Consider an initial data set $\left(\Sigma_{0}, g, k\right)$, (4,3)-asymptotically flat and maximal, and assume $J_{0}\left(\Sigma_{0}, g, k\right)$ is bounded. Then, given a sufficiently large compact set $K \subset \Sigma_{0}$ such that $\Sigma_{0} \backslash K$ is diffeomorphic to $\mathbb{R}^{3} \backslash \bar{B}_{1}$, and under additional smallness assumptions, there exists a unique future development $(\mathcal{M}, \mathbf{g})$ of $\Sigma_{0} \backslash K$ with the following properties:

- $(\mathcal{M}, \mathbf{g})$ can be foliated by a double null foliation $\left\{C_{u}\right\}$ and $\left\{\underline{C}_{u}\right\}$ whose outgoing leaves $C_{u}$ are complete.
- We have detailed control of all the quantities associated with the double null foliations of the spacetime, see Theorem 3.7.1 in [13].

[^1]Remark 1.5. Various choices of the parameter $s$ in Definition 1.2 have been made in the literature. In particular: ${ }^{3}$

- $s=4$ is used for example in [5, 7, 13].
- $s=3+\delta^{4}$ is used for example in [8, 9, 19].
- $s=3-\delta$ is used in [12] for the Einstein-Klein-Gordon system.
- $s \in(2,3]$ is used in [17] for the Einstein-Klein-Gordon system.
- $s=2$ is used in [2].
- $s \in(1,2]$ is used in [22].

The goal of this paper is to extend the results of $[13,21]$ to $s=1$ which is borderline compared to the range considered in [22]. More precisely, we prove the exterior stability of Minkowski spacetime for (1,3)-asymptotically flat initial data.

### 1.4 Rough version of the main theorem

In this section, we state a simple version of our main theorem. For the explicit statement, see Theorem 3.3.

Theorem 1.6 (Main Theorem (first version)). Let an initial data set $\left(\Sigma_{0}, g, k\right)$ which is $(1,3)-$ asymptotically flat in the sense of Definition 1.2. Let a sufficiently large compact set $K \subset \Sigma_{0}$ such that $\Sigma_{0} \backslash K$ is diffeomorphic to $\mathbb{R}^{3} \backslash \bar{B}_{1}$. Assume that we have a smallness condition on $\Sigma_{0} \backslash K$. Then, there exists a unique future development $(\mathcal{M}, \mathbf{g})$ in its future domain of dependence with the following properties:

- $(\mathcal{M}, \mathbf{g})$ can be foliated by a double null foliation $\left(C_{u}, \underline{C}_{u}\right)$ whose outgoing leaves $C_{u}$ are complete for all $u \leq u_{0}$.
- We have detailed control of all the quantities associated with the double null foliations of the spacetime, see Theorem 3.3.


### 1.5 Structure of the paper

- In Section 2, we recall the fundamental notions and the basic equations.
- In Section 3, we present the main theorem. We then state intermediate results, and prove the main theorem. The rest of the paper focuses on the proof of these intermediary results.
- In Section 4, we make bootstrap assumptions and prove first consequences. These consequences will be used frequently in the rest of the paper.
- In Section 5, we apply $r^{p}$-weighted estimates to Bianchi equations to control the flux of curvature.
- In Section 6, we estimate the $L^{p}(S)$-norms of curvature components and Ricci coefficients using the null structure equations and Bianchi equations.

## 2 Preliminaries

### 2.1 Geometry set-up

Let $\Sigma_{0}$ be a spacelike hypersurface. Let $K \subset \Sigma_{0}$ be a compact subset such that $\Sigma_{0} \backslash K$ is diffeomorphic to $\mathbb{R}^{3} \backslash \overline{B_{1}}$ where $\overline{B_{1}}$ is the unit closed ball in $\mathbb{R}^{3}$. We fix a radial foliation on the initial hypersurface $\Sigma_{0} \backslash K$ by the level sets of a scalar function $w$. The leaves are denoted by

$$
\begin{equation*}
S_{(0)}\left(w_{1}\right)=\left\{p \in \Sigma_{0} / w(p)=w_{1}\right\}, \tag{2.1}
\end{equation*}
$$

where $w_{1} \in \mathbb{R}$. We assume that

$$
\begin{equation*}
\partial K=\left\{p \in \Sigma_{0} / w(p)=w_{0}\right\}, \quad K=\left\{p \in \Sigma_{0} / w(p) \leq w_{0}\right\}, \tag{2.2}
\end{equation*}
$$

where $w_{0}$ is the area radius of $\partial K$ defined by

$$
\begin{equation*}
w_{0}:=\sqrt{\frac{|\partial K|}{4 \pi}} . \tag{2.3}
\end{equation*}
$$

We now construct a double null foliation in the future of $\Sigma_{0} \backslash K$. For this, we denote $T$ the normal vectorfield of $\Sigma_{0}$ oriented towards the future and $N$ the unit vectorfield tangent to $\Sigma_{0}$, oriented towards infinity and orthogonal to the leaves $S_{0}(w)$. We define two null vectors on $\Sigma_{0} \backslash K$ by

$$
\begin{equation*}
L:=N(w)(T+N), \quad \underline{L}:=N(w)(T-N) . \tag{2.4}
\end{equation*}
$$

We extend the definition of $L$ and $\underline{L}$ to the future of $\Sigma_{0} \backslash K$ by the geodesic equations:

$$
\begin{equation*}
\mathbf{D}_{L} L=0, \quad \mathbf{D}_{\underline{L}} \underline{L}=0 \tag{2.5}
\end{equation*}
$$

We define a positive function $\Omega$ by the formula

$$
\begin{equation*}
\mathbf{g}(L, \underline{L})=-\frac{1}{2 \Omega^{2}}, \tag{2.6}
\end{equation*}
$$

where $\Omega$ is called the null lapse function. We then define two optical functions $u$ and $\underline{u}$ in the future of $\Sigma_{0} \backslash K$ by the Eikonal equations

$$
L=-\operatorname{grad} u, \quad \underline{L}=-\operatorname{grad} \underline{u},
$$

and the initial conditions

$$
\left.u\right|_{\Sigma_{0} \backslash K}=-w,\left.\quad \underline{u}\right|_{\Sigma_{0} \backslash K}=w .
$$

We then define the normalized null pair $\left(e_{3}, e_{4}\right)$ by

$$
\begin{equation*}
e_{3}=2 \underline{L}, \quad e_{4}=2 \Omega^{2} L . \tag{2.7}
\end{equation*}
$$

The spacetime in the future of $\Sigma_{0} \backslash K$ is then foliated by the level sets of $u$ and $\underline{u}$ respectively. We use $C_{u}$ to denote the outgoing null hypersurfaces which are the level sets of $u$ and use $\underline{C}_{\underline{u}}$ to denote the incoming null hypersurfaces which are the level sets of $\underline{u}$. We also denote

$$
S(u, \underline{u}):=C_{u} \cap \underline{C}_{\underline{u}},
$$

which are spacelike 2 -spheres. On a given two sphere $S(u, \underline{u})$, we choose a local frame $\left(e_{1}, e_{2}\right)$, we call $\left(e_{1}, e_{2}, e_{3}, e_{4}\right)$ a null frame. As a convention, throughout the paper, we use capital Latin letters $A, B, C, \ldots$ to denote an index from 1 to 2 and Greek letters $\alpha, \beta, \gamma, \ldots$ to denote an index from 1 to 4 , e.g. $e_{A}$ denotes either $e_{1}$ or $e_{2}$.

For any sphere $S(u, \underline{u})$ of the double null foliation $(u, \underline{u})$, we denote its causal past by

$$
V(u, \underline{u}):=J^{-}(S(u, \underline{u})) \cap D^{+}\left(\Sigma_{0} \backslash K\right) .
$$

Denoting $u_{0}=-w_{0}$ and taking $\underline{u}_{*}>w_{0}$, we define the bootstrap region by:

$$
\mathcal{K}:=V\left(u_{0}, \underline{u}_{*}\right) .
$$

By local existence theorem, the spacetime $\mathcal{K}$ exists if $\underline{u}_{*}$ is sufficiently close to $w_{0}$. We now introduce a local coordinate system $\left(u, \underline{u}, \phi^{A}\right)$ in $\mathcal{K}$ with $e_{4}\left(\phi^{A}\right)=0$. In this coordinates system, the spacetime metric $\mathbf{g}$ takes the following form:

$$
\begin{equation*}
\mathbf{g}=-2 \Omega^{2}(d \underline{u} \otimes d u+d u \otimes d \underline{u})+\gamma_{A B}\left(d \phi^{A}-\underline{b}^{A} d u\right) \otimes\left(d \phi^{B}-\underline{b}^{B} d u\right), \tag{2.8}
\end{equation*}
$$

where $\gamma$ denotes the induced metric on $S(u, \underline{u})$ and $\underline{b}:=\underline{b}^{A} \partial_{\phi^{A}}$ denotes the null shift. Note that

$$
\Omega^{2} e_{3}=\partial_{u}+\underline{b}, \quad e_{4}=\partial_{\underline{u}} .
$$

We recall the null decomposition of the Ricci coefficients and curvature components of the null frame $\left(e_{1}, e_{2}, e_{3}, e_{4}\right)$ as follows:

$$
\begin{align*}
\underline{\chi}_{A B} & =\mathbf{g}\left(\mathbf{D}_{A} e_{3}, e_{B}\right), & \chi_{A B} & =\mathbf{g}\left(\mathbf{D}_{A} e_{4}, e_{B}\right), \\
\underline{\xi}_{A} & =\frac{1}{2} \mathbf{g}\left(\mathbf{D}_{3} e_{3}, e_{A}\right), & \xi_{A} & =\frac{1}{2} \mathbf{g}\left(\mathbf{D}_{4} e_{4}, e_{A}\right), \\
\underline{\omega} & =\frac{1}{4} \mathbf{g}\left(\mathbf{D}_{3} e_{3}, e_{4}\right), & \omega & =\frac{1}{4} \mathbf{g}\left(\mathbf{D}_{4} e_{4}, e_{3}\right),  \tag{2.9}\\
\underline{\eta}_{A} & =\frac{1}{2} \mathbf{g}\left(\mathbf{D}_{4} e_{3}, e_{A}\right), & \eta_{A} & =\frac{1}{2} \mathbf{g}\left(\mathbf{D}_{3} e_{4}, e_{A}\right), \\
\zeta_{A} & =\frac{1}{2} \mathbf{g}\left(\mathbf{D}_{e_{A}} e_{4}, e_{3}\right), & &
\end{align*}
$$

and

$$
\begin{align*}
\alpha_{A B} & =\mathbf{R}\left(e_{A}, e_{4}, e_{B}, e_{4}\right), & \underline{\alpha}_{A B} & =\mathbf{R}\left(e_{A}, e_{3}, e_{B}, e_{3}\right), \\
\beta_{A} & =\frac{1}{2} \mathbf{R}\left(e_{A}, e_{4}, e_{3}, e_{4}\right), & \underline{\beta}_{A} & =\frac{1}{2} \mathbf{R}\left(e_{A}, e_{3}, e_{3}, e_{4}\right),  \tag{2.10}\\
\rho & =\frac{1}{4} \mathbf{R}\left(e_{3}, e_{4}, e_{3}, e_{4}\right), & \sigma & =\frac{1}{4} * \mathbf{R}\left(e_{3}, e_{4}, e_{3}, e_{4}\right),
\end{align*}
$$

where ${ }^{*} \mathbf{R}$ denotes the Hodge dual of $\mathbf{R}$. The null second fundamental forms $\chi, \underline{\chi}$ are further decomposed in their $\operatorname{traces} \operatorname{tr} \chi$ and $\operatorname{tr} \underline{\chi}$, and traceless parts $\widehat{\chi}$ and $\underline{\widehat{\chi}}$ :

$$
\begin{array}{ll}
\operatorname{tr} \chi:=\delta^{A B} \chi_{A B}, & \widehat{\chi}_{A B}:=\chi_{A B}-\frac{1}{2} \delta_{A B} \operatorname{tr} \chi, \\
\operatorname{tr} \underline{\chi}:=\delta^{A B} \underline{\chi}_{A B}, & \underline{\widehat{\chi}}_{A B}:=\underline{\chi}_{A B}-\frac{1}{2} \delta_{A B} \operatorname{tr} \underline{\chi} .
\end{array}

We define the horizontal covariant operator $\nabla$ as follows:

$$
\nabla_{X} Y:=\mathbf{D}_{X} Y-\frac{1}{2} \underline{\chi}(X, Y) e_{4}-\frac{1}{2} \chi(X, Y) e_{3} .
$$

We also define $\nabla_{4} X$ and $\nabla_{3} X$ to be the horizontal projections:

$$
\begin{aligned}
\nabla_{4} X & :=\mathbf{D}_{4} X-\frac{1}{2} \mathbf{g}\left(X, \mathbf{D}_{4} e_{3}\right) e_{4}-\frac{1}{2} \mathbf{g}\left(X, \mathbf{D}_{4} e_{4}\right) e_{3} \\
\nabla_{3} X & :=\mathbf{D}_{3} X-\frac{1}{2} \mathbf{g}\left(X, \mathbf{D}_{3} e_{3}\right) e_{3}-\frac{1}{2} \mathbf{g}\left(X, \mathbf{D}_{3} e_{4}\right) e_{4}
\end{aligned}

A tensor field $\psi$ defined on $\mathcal{M}$ is called tangent to $S$ if it is a priori defined on the spacetime $\mathcal{M}$ and all the possible contractions of $\psi$ with either $e_{3}$ or $e_{4}$ are zero. We use $\nabla_{3} \psi$ and $\nabla_{4} \psi$ to denote the projection to $S(u, \underline{u})$ of usual derivatives $\mathbf{D}_{3} \psi$ and $\mathbf{D}_{4} \psi$. As a direct consequence of (2.9), we have the following Ricci formulae:

\mathbf{D}_{A} e_{3} & =\underline{\chi}_{A B} e_{B}+\zeta_{A} e_{3}, & \mathbf{D}_{A} e_{4} & =\chi_{A B} e_{B}-\zeta_{A} e_{4}, \\
\mathbf{D}_{3} e_{A} & =\nabla_{3} e_{A}+\eta_{A} e_{3}+\underline{\xi}_{A} e_{4}, & \mathbf{D}_{4} e_{A} & =\nabla_{4} e_{A}+\underline{\eta}_{A} e_{4}+\xi_{A} e_{4}, \\
\mathbf{D}_{3} e_{3} & =-2 \underline{\omega} e_{3}+2 \underline{\xi}_{B} e_{B}, & \mathbf{D}_{3} e_{4} & =2 \underline{\omega} e_{4}+2 \eta_{B} e_{B}, \\

The following identities hold for the null frame (2.7):

$$
\begin{align*}
\nabla \log \Omega & =\frac{1}{2}(\eta+\underline{\eta}), & \omega & =-\nabla_{4}(\log \Omega),  \tag{2.12}\\
\eta & =\zeta+\nabla \log \Omega, & \underline{\eta} & =-\zeta+\nabla \log \Omega,
\end{align*}
$$

see for example (6) in [16].

### 2.2 Integral formulae

Definition 2.1. Given a scalar function $f$ on $S:=S(u, \underline{u})$, we denote its average and its average free part by

$$
\bar{f}:=\frac{1}{|S|} \int_{S} f d \gamma, \quad \check{f}:=f-\bar{f}
$$

### 3.1 Fundamental norms

We proceed to define our main norms on a given bootstrap spacetime $\mathcal{K}=V\left(u_{0}, \underline{u}_{*}\right)$.

### 3.1.1 Schematic notation $\Gamma_{g}, \Gamma_{b}$ and $\Gamma_{w}$

Definition 3.1. We divide the Ricci coefficients into three parts:

Remark 3.2. The justification of Definition 3.1 has to do with the expected decay properties of the Ricci coefficients and curvature components, see Section 3.1.3 and Lemma 4.2 below.

\mathcal{O}_{a}:=\sup _{\mathcal{K}}\left\|r^{3-\delta-\delta_{0}}|u|^{\delta+\delta_{0}} \nabla \underline{\beta}\right\|_{2, S}+\sup _{\mathcal{K}}\left\|r^{2-\delta_{0}}|u|^{1+\delta_{0}} \nabla \underline{\alpha}\right\|_{2, S} .
$$

Moreover, we define

$$
\mathcal{O}_{\gamma}:=\sup _{\mathcal{K}} \frac{|\log (2 \Omega)|}{\log \left(\frac{3 r}{|u|}\right)}+\sup _{\mathcal{K}}\left|1-\frac{u-u}{2 r}\right| .
$$

Finally, we denote

$$
\mathcal{O}:=\mathcal{O}_{[2]}+\mathcal{O}_{3}+\mathcal{O}_{a}+\mathcal{O}_{\gamma} .
$$

### 3.1.4 $\mathcal{I}_{(0)}$ norm (Initial data)

We introduce the following norm on initial hypersurface $\Sigma_{0}$ :

$$
\mathcal{I}_{(0)}:=\sup _{\Sigma_{0} \backslash K}\left\{\sum_{q=0}^{3} r\left\|\mathfrak{d}^{q}\left(\Gamma_{g}, \Gamma_{b}, \Gamma_{w}\right)\right\|_{2, S_{(0)}(w)}+\sum_{q=0}^{2} r^{2}\left\|\mathfrak{d}^{q}(\alpha, \underline{\alpha})\right\|_{2, S_{(0)}(w)}+\left|1-\frac{u-u}{2 r}\right|\right\},
$$

where

$$
\mathfrak{d} \in\left\{r \nabla_{3}, r \nabla_{4}, r \nabla\right\} .
$$

### 3.2 Statement of the main theorem

The goal of this paper is to prove the following theorem.
Theorem 3.3 (Main Theorem). Consider an initial data set $\left(\Sigma_{0}, g, k\right)$ which is ( 1,3 )-asymptotically flat in the sense of Definition 1.2. Assume that we have on $\Sigma_{0} \backslash K$ :

$$
\begin{equation*}
\mathcal{I}_{(0)} \leq \varepsilon_{0} \tag{3.3}
\end{equation*}
$$

where $\varepsilon_{0}>0$ is a constant small enough. Then, $\Sigma_{0} \backslash K$ has a unique development $(\mathcal{M}, \mathbf{g})$ in its future domain of dependence with the following properties:

1. $(\mathcal{M}, \mathbf{g})$ can be foliated by a double null foliation $(u, \underline{u})$. Moreover, the outgoing cones $C_{u}$ are complete for all $u \leq u_{0}$.
2. The norms $\mathcal{O}$ and $\mathcal{R}$ defined in Section 3.1 satisfy

$$
\begin{equation*}
\mathcal{O} \lesssim \varepsilon_{0}, \quad \mathcal{R} \lesssim \varepsilon_{0} . \tag{3.4}
\end{equation*}
$$

The proof of Theorem 3.3 is given in Section 3.4. It hinges on two basic theorems stated in Section 3.3, concerning estimates for $\mathcal{O}$ and $\mathcal{R}$ norms.

We choose $\varepsilon_{0}$ and $\varepsilon$ small enough such that

$$
\varepsilon \ll \delta_{0} \ll \delta \ll 1, \quad \varepsilon:=\varepsilon_{0}^{\frac{2}{3}} .
$$

Here, $A \ll B$ means that $C A<B$ where $C$ is the largest universal constant among all the constants involved in the proof via $\lesssim$.

### 3.3 Main intermediate results

Theorem 3.4. Assume that

$$
\begin{equation*}
\mathcal{I}_{(0)} \leq \varepsilon_{0}, \quad \mathcal{O} \leq \varepsilon, \quad \mathcal{R} \leq \varepsilon . \tag{3.5}
\end{equation*}
$$

Then, we have

$$
\begin{equation*}
\mathcal{R} \lesssim \varepsilon_{0} . \tag{3.6}
\end{equation*}
$$

Theorem 3.4 is proved in Section 5. The proof is based on the $r^{p}$-weighted method introduced by Dafermos and Rodnianski in [6].

Theorem 3.5. Assume that

$$
\begin{equation*}
\mathcal{I}_{(0)} \leq \varepsilon_{0}, \quad \mathcal{O} \leq \varepsilon, \quad \mathcal{R} \lesssim \varepsilon_{0} . \tag{3.7}
\end{equation*}
$$

Then, we have

$$
\begin{equation*}
\mathcal{O} \lesssim \varepsilon_{0} . \tag{3.8}
\end{equation*}
$$

Theorem 3.5 is proved in Section 6. The proof is done by integrating the transport equations along the outgoing and incoming null cones and applying elliptic estimate on 2 -spheres of the double null foliation of the spacetime $\mathcal{K}$.

### 3.4 Proof of the main theorem

We now use Theorems 3.4 and 3.5 to prove Theorem 3.3.
Definition 3.6. Let $\aleph\left(\underline{u}_{*}\right)$ the set of spacetimes $\mathcal{K}=V\left(u_{0}, \underline{u}_{*}\right)$ associated with a double null foliation $(u, \underline{u})$ in which we have the following bounds:

$$
\begin{equation*}
\mathcal{O} \leq \varepsilon, \quad \mathcal{R} \leq \varepsilon . \tag{3.9}
\end{equation*}
$$

Definition 3.7. We denote $\mathcal{U}$ the set of values $\underline{u}_{*}$ such that $\aleph\left(\underline{u}_{*}\right) \neq \emptyset$.
The assumption $\mathcal{I}_{(0)} \leq \varepsilon_{0}$ and the local existence theorem imply that (3.9) holds if $\underline{u}_{*}$ is sufficiently close to $\left|u_{0}\right|$. So, we have $\mathcal{U} \neq \emptyset$.

Define $\underline{u}_{*}$ to be the supremum of the set $\mathcal{U}$. We want to prove $\underline{u}_{*}=+\infty$. We assume by contradiction that $\underline{u}_{*}$ is finite. In particular we may assume $\underline{u}_{*} \in \mathcal{U}$. We consider the region $\mathcal{K}=V\left(u_{0}, \underline{u}_{*}\right)$. Recall that we have

$$
\mathcal{I}_{(0)} \leq \varepsilon_{0}
$$

according to the assumption of Theorem 3.3. Applying Theorem 3.4, we obtain

$$
\mathcal{R} \lesssim \varepsilon_{0} .
$$

Then, we apply Theorem 3.5 to obtain

$$
\mathcal{O} \lesssim \varepsilon_{0}
$$

Applying local existence results, ${ }^{5}$ we can extend $\mathcal{K}$ to $\widetilde{\mathcal{K}}:=V\left(u_{0}, \underline{u}_{*}+\nu\right)$ for a $\nu$ sufficiently small. We denote $\widetilde{\mathcal{O}}$ and $\widetilde{\mathcal{R}}$ the norms in the extended region $\widetilde{\mathcal{K}}$. We have

$$
\widetilde{\mathcal{O}} \lesssim \varepsilon_{0}, \quad \widetilde{\mathcal{R}} \lesssim \varepsilon_{0},
$$

as a consequence of continuity. We deduce that $V\left(u_{0}, \underline{u}_{*}+\nu\right)$ satisfies all the properties in Definition 3.6, and so $\aleph\left(\underline{u}_{*}+\nu\right) \neq \emptyset$, which is a contradiction. Thus, we have $\underline{u}_{*}=+\infty$, which implies property 1 of Theorem 3.3. Moreover, we have

$$
\mathcal{O} \lesssim \varepsilon_{0}, \quad \mathcal{R} \lesssim \varepsilon_{0},
$$

in the whole exterior region, which implies property 2 of Theorem 3.3. This concludes the proof of Theorem 3.3.

Remark 3.8. We have from (3.4)

$$
\left\|\operatorname{tr} \chi-\frac{1}{r}\right\|_{\infty, S} \lesssim \frac{\varepsilon_{0}}{r}, \quad \forall S \subseteq V\left(u_{0},+\infty\right)
$$

which implies for $\varepsilon_{0}$ small enough that $\operatorname{tr} \chi>0$. Hence, we deduce that there is no trapped surface in the exterior region $D^{+}\left(\Sigma_{0} \backslash K\right)=V\left(u_{0},+\infty\right)$.

## 4 Bootstrap assumptions and first consequences

In the rest of the paper, we always make the following bootstrap assumptions:

$$
\begin{equation*}
\mathcal{O} \leq \varepsilon, \quad \mathcal{R} \leq \varepsilon . \tag{4.1}
\end{equation*}
$$

### 4.1 First consequences of bootstrap assumptions

In this section, we derive first consequences of (4.1) in the region $\mathcal{K}=V\left(u_{0}, \underline{u}_{*}\right)$. In the sequel, the results of this section will be used frequently without explicitly mentioning them.
Remark 4.1. According to $\mathcal{O}_{\gamma} \leq \varepsilon$, we have in the bootstrap region $\mathcal{K}$

$$
\begin{equation*}
\left|r-\frac{\underline{u}-u}{2}\right| \lesssim \varepsilon \underline{u} . \tag{4.2}
\end{equation*}
$$

Combining with $|u| \leq \underline{u}$ and $u<0$, this yields

$$
\begin{equation*}
|u| \leq \underline{u} \simeq r \quad \text { in } \mathcal{K} . \tag{4.3}
\end{equation*}
$$

Lemma 4.2. Under the assumption (4.1), we have the following bounds:

\left\|\Gamma_{g}\right\|_{4, S} & \lesssim \frac{\varepsilon}{r}, & \left\|\Gamma_{g}^{(1)}\right\|_{4, S} \lesssim \frac{\varepsilon}{r}, & \left\|\Gamma_{g}^{(2)}\right\|_{4, S} \lesssim \frac{\varepsilon}{r^{1-\delta}|u|^{\delta}}, \\
\left\|\Gamma_{b}\right\|_{4, S} & \lesssim \frac{\varepsilon}{r^{1-\delta_{0}}|u|^{\delta_{0}}}, & \left\|\Gamma_{b}^{(1)}\right\|_{4, S} \lesssim \frac{\varepsilon}{r^{1-3 \delta_{0}}|u|^{3 \delta_{0}}}, & \left\|\Gamma_{b}^{(2)}\right\|_{4, S} \lesssim \frac{\varepsilon}{r^{1-\delta-2 \delta_{0}}|u|^{\delta+2 \delta_{0}}}, \\

Proof. It follows directly from Definition 3.1 and (4.1).

\Gamma_{g} \cdot \Gamma_{g} \preceq r^{-1} \Gamma_{g}, \quad \Gamma_{g} \cdot \Gamma_{w} \preceq r^{-1} \Gamma_{w}, \quad \Gamma_{w} \preceq \Gamma_{b}^{(1)}, \quad r^{-1} \Gamma_{w}^{(1)} \preceq \underline{\alpha}^{(0)} .
$$

Proof. It follows directly from Definition 3.1, (4.1) and Lemma 4.2.
Remark 4.4. In the sequel, we choose the following conventions:

- Let $q \in\{0,1,2,3\}$, for a quantity $h$ satisfying the same or even better decay and regularity as $\Gamma_{i}^{(q)}$, for $i=g, b, w$, we write

h \in \Gamma_{i}^{(q)}, \quad i=g, b, w .
$$

- For a sum of schematic notations, we write

X_{(1)}+X_{(2)}=X_{(2)},
$$

if $X_{(1)} \preceq X_{(2)}$. For example, we write

\Gamma_{g}+\Gamma_{b}=\Gamma_{b}, \quad r^{-1} \Gamma_{b} \cdot \Gamma_{w}^{(1)}+\Gamma_{b} \cdot \underline{\alpha}=\Gamma_{b} \cdot \underline{\alpha}, \quad \Gamma_{g} \cdot \Gamma_{w}=\Gamma_{g} \cdot \Gamma_{b}^{(1)} .
$$

Proposition 4.5. For any scalar function $f$, we have:

\end{aligned}

Proof. See Proposition 4.8 .1 in [13] and Corollary 2.22 in [21].
Proposition 4.6. We have the following schematic commutator identities

\begin{aligned}
{\left[\nabla_{4}, r \nabla\right] } & =\Gamma_{g} \cdot r \nabla+\Gamma_{g}^{(1)}, \\
{\left[\Omega^{2} \nabla_{3}, r \nabla\right] } & =\Omega^{2} \Gamma_{w} \cdot r \nabla+\Omega^{2} \Gamma_{w}^{(1)} .
\end{aligned}

Proof. See Lemma 7.3.3 in [5] and Proposition 2.24 in [21].

3. Let $U \in \mathfrak{s}_{2}$ be a solution of $d_{2} U=f$. Then we have

\|\nabla U\|_{p, S}+r^{-1}\|U\|_{p, S} \lesssim\|f\|_{p, S}
$$

Proof. See Corollary 2.3.1.1 in [5].

## 5 Hyperbolic estimates (proof of Theorem 3.4)

In this section, we prove Theorem 3.4 by the $r^{p}$-weighted estimate method introduced in [6] and applied to Bianchi equations in $[10,21,22]$.

### 5.1 Schematic notation $\mathbb{E}_{q}, \mathbb{F}_{q}$ and $\mathbb{O}_{\ell}$

We introduce the following schematic notations as in [22].
Definition 5.1. For a quantity $X$, we denote

\left\|r^{\frac{q}{2}} X^{(2)}\right\|_{2, C_{u}^{V}} \leq \frac{\varepsilon}{|u|^{\frac{1-q}{2}}}, \quad\left\|X^{(1)}\right\|_{4, S} \leq \frac{\varepsilon}{r^{\frac{q+3}{2}}|u|^{\frac{1-q}{2}}} .
$$

Similarly, we denote

X \in \mathbb{F}_{q},
$$

if $X$ satisfies the following estimates:

$$
\left\|r^{\frac{q}{2}} X^{(2)}\right\|_{2, \underline{C}_{\underline{u}}^{V}} \leq \frac{\varepsilon}{|u|^{\frac{1-q}{2}}}, \quad\left\|\Omega X^{(1)}\right\|_{4, S} \leq \frac{\varepsilon}{r^{\frac{q+2}{2}}|u|^{\frac{2-q}{2}}} .
$$

Moreover, we denote

X \in \mathbb{O}_{\ell},
$$

if $X$ satisfies the following estimate:

$$
\left\|X^{(2)}\right\|_{4, S} \leq \frac{\varepsilon}{r^{\frac{\ell+1}{2}}|u|^{\frac{1-\ell}{2}}} .

For $\mathbb{X} \in\{\mathbb{E}, \mathbb{F}, \mathbb{O}\}$, we also denote $X \in \mathbb{X}_{q}^{(i)}$, for $i=0,1,2$, if $X$ satisfies the same or even better decay and regularity properties as $\mathbb{X}_{q}^{(i)}$.

Lemma 5.2. Under the assumption (4.1), the following hold:

The following theorem provides a unified treatment of all the nonlinear error terms in curvature estimates.

Remark 5.5. Note that the Bianchi equations can be written as systems of equations of the type (5.7) and (5.9). In particular

- the Bianchi pair $(\alpha, \beta)$ satisfies (5.7) with $k=2, a_{(1)}=\frac{1}{2}, a_{(2)}=2$,
- the Bianchi pair $(\beta,(\widehat{\rho},-\widehat{\sigma}))$ satisfies (5.7) with $k=1, a_{(1)}=1, a_{(2)}=\frac{3}{2}$,
- the Bianchi pair $((\widehat{\rho}, \widehat{\sigma}), \underline{\beta})$ satisfies (5.9) with $k=1, a_{(1)}=\frac{3}{2}, a_{(2)}=1$,
- the Bianchi pair $(\underline{\beta}, \underline{\alpha})$ satisfies (5.9) with $k=2, a_{(1)}=2, a_{(2)}=\frac{1}{2}$.

The following lemma allows us to obtain $|u|$-decay of curvature flux along $\Sigma_{0} \cap V(u, \underline{u})$.
Lemma 5.6. For any $R \in\{\alpha, \beta, \widehat{\rho}, \widehat{\sigma}, \underline{\beta}, \underline{\alpha}\}$, we have the following estimate for $p<1$ :

\mathcal{N}_{-4 \delta}^{1}\left[\mathbb{F}_{1-2 \delta}^{(1)}, \mathbb{O}_{1-2 \delta}^{(1)} \cdot \mathbb{F}_{-4 \delta}^{(1)}\right]+\mathcal{N}_{-4 \delta}^{1}\left[\mathbb{F}_{-4 \delta}^{(1)}, \mathbb{O}_{1-2 \delta}^{(1)} \cdot \mathbb{F}_{-2 \delta_{0}}^{(1)}\right] \lesssim \frac{\varepsilon^{3}}{|u|^{1+4 \delta}}
$$

Moreover, we have from $r\left|\Gamma_{g}\right| \lesssim \varepsilon$ and Proposition 4.11

\mathcal{N}_{-4 \delta}^{0}\left[\underline{\alpha}^{(2)}, \Gamma_{g} \cdot \underline{\alpha}^{(2)}\right]=\int_{V} r^{-4 \delta}\left|\Gamma_{g}\right|\left|\underline{\alpha}^{(2)}\right|^{2} \lesssim \varepsilon \int_{V} r^{-1-4 \delta}\left|\chi^{2} \underline{\alpha}\right|^{2} .

## 6 Transport and $2 D$-elliptic estimates (proof of Theorem 3.5)

The goal of this section is to prove Theorem 3.5. Throughout this section, we use the following shorthand notations:

This concludes the proof of Lemma 6.2.

[\bar{\mu}]=\underline{\mu}-\underline{\bar{\mu}}+\frac{1}{4} \overline{\operatorname{tr} \chi \operatorname{tr} \underline{\chi}}=\underline{\mu}+\overline{\bar{\rho}}+\frac{1}{2 r} \overline{\operatorname{tr} \underline{\chi}}-\frac{1}{2 r} \overline{\operatorname{tr} \chi}+\Gamma_{g} \cdot \Gamma_{g},
$$

we have from Propositions 6.9 and 6.10 that

$$
\left\|\underline{\mu}^{(1)}\right\|_{4, S} \lesssim \frac{\varepsilon_{0}}{r^{2}}, \quad\left\|\grave{\phi}^{2} \underline{\mu}\right\|_{2, S} \lesssim \frac{\varepsilon_{0}}{r^{2-\delta}|u|^{\delta}} .
$$

This concludes the proof of Proposition 6.12.

### 6.6 Estimates for $\eta, \underline{\eta}, \widehat{\chi}$ and $\underline{\hat{\chi}}$

Proposition 6.13. We have the following estimates:

\begin{equation*}
\left\|\eta^{(1)}\right\|_{4, S} \lesssim \frac{\varepsilon_{0}}{r^{1-3 \delta_{0}}|u|^{3 \delta_{0}}}, \quad\left\|\eta^{(2)}\right\|_{4, S} \lesssim \frac{\varepsilon_{0}}{r^{1-\delta-2 \delta_{0}}|u|^{2 \delta_{0}}}, \quad\left\|\underline{\eta}^{(2)}\right\|_{4, S} \lesssim \frac{\varepsilon_{0}}{r} . \tag{6.22}
\end{equation*}
$$

We also have

$$
\begin{equation*}
\|\eta\|_{4, S} \lesssim \frac{\varepsilon_{0}}{r^{1-\delta_{0}}|u|^{\delta_{0}}} . \tag{6.23}
\end{equation*}
$$

Proof. We recall from Proposition 4.7

$$
d_{1} \eta=(-\mu-\widehat{\rho}, \widehat{\sigma}), \quad d_{1} \underline{\eta}=(-\underline{\mu}-\widehat{\rho}, \widehat{\sigma}) .
$$

Applying Propositions 4.11, we obtain for $q=1,2$

$$
\left\|\eta^{(q)}\right\|_{4, S} \lesssim r\left\|(\mu, \widehat{\rho}, \widehat{\sigma})^{(q-1)}\right\|_{4, S}, \quad\left\|\underline{( }^{(q)}\right\|_{4, S} \lesssim r\left\|(\underline{\mu}, \widehat{\rho}, \widehat{\sigma})^{(q-1)}\right\|_{4, S}
$$

Combining with Propositions 6.3, 6.4, 6.11 and 6.12 , we obtain (6.22) as stated.
Next, we have from Proposition 2.11

$$
\begin{equation*}
\nabla_{4} \eta+\frac{1}{2} \operatorname{tr} \chi \eta=r^{-1} \underline{\eta}-\beta+\Gamma_{g} \cdot \Gamma_{b} . \tag{6.24}
\end{equation*}
$$

Applying Lemma 6.1, (6.22) and Proposition 6.4, we obtain

$$
\begin{aligned}
\|r \eta\|_{4, S} & \lesssim\|r \eta\|_{4, S(u,|u|)}+\int_{|u|}^{\underline{u}}\|\underline{\eta}\|_{4, S}+r\|\beta\|_{4, S}+r\left\|\Gamma_{g} \cdot \Gamma_{b}\right\|_{4, S} \\
& \lesssim \varepsilon_{0}+\int_{|u|}^{\underline{u}} \frac{\varepsilon_{0}}{r}+\frac{\varepsilon^{2}}{r^{1-\delta_{0}}|u|^{\delta_{0}}} \\
& \lesssim \varepsilon_{0} \frac{r^{\delta_{0}}}{|u|^{\delta_{0}}},
\end{aligned}
$$

which implies (6.23). This concludes the proof of Proposition 6.13.
Proposition 6.14. We have the following estimates:

$$
\begin{array}{ll}
\left\|\widehat{\chi}^{(1)}\right\|_{4, S} \lesssim \frac{\varepsilon_{0}}{r}, & \left\|\widehat{\chi}^{(2)}\right\|_{4, S} \lesssim \frac{\varepsilon_{0}}{r^{1-\delta}|u|^{\delta}}, \\
\left\|\underline{\widehat{\chi}}^{(1)}\right\|_{4, S} \lesssim \frac{\varepsilon_{0}}{r^{1-\delta}|u|^{\delta}}, & \left\|\widehat{\underline{\chi}}^{(2)}\right\|_{4, S} \lesssim \frac{\varepsilon_{0}}{r^{\frac{1}{2}-\delta-\delta_{0}}|u|^{\frac{1}{2}+\delta+\delta_{0}}} .
\end{array}
$$

Proof. We recall the following Codazzi equations from Proposition 4.7

$$
\begin{aligned}
& \operatorname{div} \widehat{\chi}=\frac{1}{2} \nabla \operatorname{tr} \chi-r^{-1} \underline{\eta}-\beta+\Gamma_{g} \cdot \Gamma_{g}, \\
& \operatorname{div} \underline{\hat{\chi}}=\frac{1}{2} \nabla \operatorname{tr} \underline{\chi}-r^{-1} \underline{\eta}+\underline{\beta}+\Gamma_{g} \cdot \Gamma_{w} .
\end{aligned}
$$

Applying Propositions 4.11, 6.4, 6.9, 6.10 and 6.22 , we obtain

$$
\begin{aligned}
& \left\|\widehat{\chi}^{(1)}\right\|_{4, S} \lesssim r\left\|\left(\nabla \operatorname{tr} \chi, r^{-1} \underline{\eta}, \beta\right)\right\|_{4, S}+\left\|r \Gamma_{g} \cdot \Gamma_{g}\right\|_{4, S} \lesssim \frac{\varepsilon_{0}}{r} \\
& \left\|\underline{\widehat{\chi}}^{(1)}\right\|_{4, S} \lesssim r\left\|\left(\nabla \operatorname{tr} \underline{\chi}, r^{-1} \underline{\eta}, \underline{\beta}\right)\right\|_{4, S}+\left\|r \Gamma_{g} \cdot \Gamma_{w}\right\|_{4, S} \lesssim \frac{\varepsilon_{0}}{r^{1-\delta}|u|^{\delta}} .
\end{aligned}
$$

We also have from Propositions 4.11, 6.3, 6.9, 6.10 and 6.22

$$
\begin{aligned}
& \left\|\widehat{\chi}^{(2)}\right\|_{4, S} \lesssim r\left\|\left(\nabla \operatorname{tr} \chi, r^{-1} \underline{\eta}, \beta\right)^{(1)}\right\|_{4, S}+r\left\|\left(\Gamma_{g} \cdot \Gamma_{g}\right)^{(1)}\right\|_{4, S} \lesssim \frac{\varepsilon_{0}}{r^{1-\delta}|u|^{\delta}}, \\
& \left\|\underline{\widehat{\chi}}^{(2)}\right\|_{4, S} \lesssim r\left\|\left(\nabla \operatorname{tr} \underline{\chi}, r^{-1} \underline{\eta}, \underline{\beta}\right)^{(1)}\right\|_{4, S}+r\left\|\left(\Gamma_{g} \cdot \Gamma_{w}\right)^{(1)}\right\|_{4, S} \lesssim \frac{\varepsilon_{0}}{r^{\frac{1}{2}-\delta-\delta_{0}}|u|^{\frac{1}{2}+\delta+\delta_{0}}} .
\end{aligned}
$$

This concludes the proof of Proposition 6.14.

### 6.7 End of the proof of Theorem 3.5

Proposition 6.15. We have the following estimates:

$$
\begin{equation*}
\sup _{\mathcal{K}} r\left|\operatorname{tr} \chi-\frac{1}{r}\right| \lesssim \varepsilon_{0}, \quad \sup _{\mathcal{K}} r\left|\operatorname{tr} \underline{\chi}+\frac{4}{r}\right| \lesssim \varepsilon_{0} . \tag{6.25}
\end{equation*}
$$

Proof. Applying Lemma 2.2, we obtain

$$
\begin{equation*}
\Omega^{2} \nabla_{3}\left(\frac{1}{r}\right)=-r^{-2} \Omega^{2} e_{3}(r)=-\frac{1}{2 r} \overline{\Omega^{2} \operatorname{tr} \underline{\chi}}=-\frac{\Omega^{2} \operatorname{tr} \underline{\chi}}{2 r}+\frac{\overline{\Omega^{2} \operatorname{tr} \underline{\chi}}}{2 r} \tag{6.26}
\end{equation*}
$$

We recall from Proposition 2.11

$$
\Omega^{2} \nabla_{3} \operatorname{tr} \chi+\frac{1}{2} \Omega^{2} \operatorname{tr} \underline{\chi} \operatorname{tr} \chi=-2 \Omega^{2} \mu+2|\Omega \eta|^{2} .
$$

Hence, we deduce

\begin{equation*}
\Omega^{2} \nabla_{3}\left(\operatorname{tr} \chi-\frac{1}{r}\right)+\frac{1}{2} \Omega^{2} \operatorname{tr} \underline{\chi}\left(\operatorname{tr} \chi-\frac{1}{r}\right)=\Omega^{2}\left(\mu, r^{-1} \overline{\operatorname{tr} \underline{\chi}}\right)^{(0)}+\Omega^{2} \Gamma_{b} \cdot \Gamma_{b} . \tag{6.27}
\end{equation*}
$$

Applying Lemma 6.1, we have from Propositions 6.7 and 6.9

$$
\begin{aligned}
\left\|r\left(\operatorname{tr} \chi-\frac{1}{r}\right)\right\|_{\infty, S} & \lesssim\left\|r\left(\operatorname{tr} \chi-\frac{1}{r}\right)\right\|_{\infty, S(-\underline{u}, \underline{u})}+\int_{-\underline{u}}^{u} \frac{\varepsilon_{0}}{r^{1-\delta_{0}}|u|^{\delta_{0}}}+\left\|r \Omega^{2} \Gamma_{b} \cdot \Gamma_{b}\right\|_{\infty, S} \\
& \lesssim \varepsilon_{0}+\int_{|u|}^{\underline{u}} \frac{\varepsilon_{0}}{r^{1-\delta_{0}}|u|^{\delta_{0}}}+\frac{\varepsilon^{2}}{r^{1-2 \delta-4 \delta_{0}}|u|^{2 \delta+4 \delta_{0}}} \\
& \lesssim \varepsilon_{0}
\end{aligned}
$$

Similarly, we have from Proposition 2.11 and (6.26)

$$
\nabla_{3}\left(\operatorname{tr} \underline{\chi}+\frac{4}{r}\right)+\frac{1}{2} \operatorname{tr} \underline{\chi}\left(\operatorname{tr} \underline{\chi}+\frac{4}{r}\right)=r^{-1}{\widetilde{\operatorname{tr}} \underline{\chi}^{(0)}+\Gamma_{w} \cdot \Gamma_{w} . . . . ~}_{\text {. }}
$$

Applying Lemma 6.1, we infer

$$
\begin{aligned}
r\left\|\operatorname{tr} \underline{\chi}+\frac{4}{r}\right\|_{\infty, S} & \lesssim r\left\|\operatorname{tr} \underline{\chi}+\frac{4}{r}\right\|_{\infty, S(-\underline{u}, \underline{u})}+\int_{-\underline{u}}^{u} \Omega^{2}\left(\|\overline{\operatorname{tr} \underline{\chi}}\|_{\infty, S}+\left\|r \Gamma_{w} \cdot \Gamma_{w}\right\|_{\infty, S}\right) \\
& \lesssim \varepsilon_{0}+\int_{-\underline{u}}^{u} \frac{\varepsilon_{0}}{r^{1-\delta_{0}}|u|^{\delta_{0}}}+\frac{\varepsilon^{2}}{r^{1-2 \delta-\delta_{0}}|u|^{2 \delta+\delta_{0}}} \\
& \lesssim \varepsilon_{0} .
\end{aligned}
$$

This concludes the proof of Proposition 6.15.

Proposition 6.16. We have the following estimate:

$$
\sup _{\mathcal{K}}\left|1-\frac{\underline{u}-u}{2 r}\right| \lesssim \varepsilon_{0}
$$

Proof. We have from Lemma 2.2 and Proposition 6.15

$$
e_{4}\left(r-\frac{u}{2}\right)=\frac{r}{2} \overline{\operatorname{tr} \chi}-\frac{1}{2}=\frac{r}{2} \overline{\left(\operatorname{tr} \chi-\frac{1}{r}\right)}=O\left(\varepsilon_{0}\right) .
$$

Applying Lemma 6.1, we obtain

$$
\left\|r-\frac{\underline{u}-u}{2}\right\|_{\infty, S} \lesssim\left\|r-\frac{\underline{u}-u}{2}\right\|_{\infty, S(u,|u|)}+\int_{|u|}^{\underline{u}} \varepsilon_{0} d u \lesssim \varepsilon_{0} r
$$

This concludes the proof of Proposition 6.16.
Proposition 6.17. We have the following estimates:

$$
\left\|\mathbf{K}-\frac{1}{r^{2}}\right\|_{4, S} \lesssim \frac{\varepsilon_{0}}{r^{2}}, \quad\|r \nabla \mathbf{K}\|_{4, S} \lesssim \frac{\varepsilon_{0}}{r^{2-\delta}|u|^{\delta}}
$$

Remark 6.18. Proposition 6.17 implies that the spheres $S=S(u, \underline{u})$ are only almost round at future null infinity $\mathcal{I}_{+}$.

Proof. We have from (2.21) and Propositions 6.3 and 6.15

$$
\begin{aligned}
\left\|\mathbf{K}-\frac{1}{r^{2}}\right\|_{4, S} & =\left\|\mathbf{K}+\frac{1}{4} \operatorname{tr} \chi \operatorname{tr} \underline{\chi}-\left(\frac{1}{4} \operatorname{tr} \chi \operatorname{tr} \underline{\chi}+\frac{1}{r^{2}}\right)\right\|_{4, S} \\
& \lesssim\|\widehat{\rho}\|_{4, S}+r^{-1}\left\|\operatorname{tr} \chi-\frac{1}{r}\right\|_{4, S}+r^{-1}\left\|\operatorname{tr} \underline{\chi}+\frac{4}{r}\right\|_{4, S} \\
& \lesssim \frac{\varepsilon_{0}}{r^{2}}
\end{aligned}
$$

Similarly, we have

$$
\|r \nabla \mathbf{K}\|_{4, S} \lesssim\|r \nabla \widehat{\rho}\|_{4, S}+\|\nabla \operatorname{tr} \chi\|_{4, S}+\|\nabla \operatorname{tr} \underline{\chi}\|_{4, S} \lesssim \frac{\varepsilon_{0}}{r^{2-\delta}|u|^{\delta}}
$$

This concludes the proof of Proposition 6.17.
Combining Propositions 6.3-6.17, this concludes the proof of Theorem 3.5.
