# CARLESON OPERATORS ON DOUBLING METRIC MEASURE SPACES

#### Abstract

We prove a new generalization of a theorem of Carleson, namely bounds for a generalized Carleson operator on doubling metric measure spaces. Additionally, we explicitly reduce Carleson's classical result on pointwise convergence of Fourier series to this new theorem. Both proofs are presented in great detail, suitable as a blueprint for computer verification using the current capabilities of the software package Lean. Note that even Carleson's classical result has not yet been computer-verified.

## 1. Introduction

This preprint is associated with a distributed Lean project accessible under https://florisvandoorn.com/carleson/.

In [Car66], L. Carleson addressed a classical question regarding the convergence of Fourier series of continuous functions by proving their pointwise convergence almost everywhere. Theorem 1.1 represents a version of this result.

Let $f$ be a complex-valued, $2 \pi$-periodic bounded Borel measurable function on the real line, and for an integer $n$, define the Fourier coefficient as

\begin{equation*}
\widehat{f}_{n}:=\frac{1}{2 \pi} \int_{0}^{2 \pi} f(x) e^{-i n x} d x \tag{1.1}
\end{equation*}
$$

Define the partial Fourier sum for $N \geq 0$ as

$$
\begin{equation*}
S_{N} f(x):=\sum_{n=-N}^{N} \widehat{f}_{n} e^{i n x} \tag{1.2}
\end{equation*}
$$

Theorem 1.1 (classical Carleson). Let $f$ be a $2 \pi$-periodic complex-valued uniformly continuous function on $\mathbb{R}$ satisfying the bound $|f(x)| \leq 1$ for all $x \in \mathbb{R}$. For all $0<\epsilon<1$, there exists a Borel set $E \subset[0,2 \pi]$ with Lebesgue measure $|E| \leq \epsilon$ and a positive integer $N_{0}$ such that for all $x \in[0,2 \pi] \backslash E$ and all integers $N>N_{0}$, we have

$$
\begin{equation*}
\left|f(x)-S_{N} f(x)\right| \leq \epsilon \tag{1.3}
\end{equation*}
$$

Note that mere continuity implies uniform continuity in the setting of this theorem. By applying this theorem with a sequence of $\epsilon_{n}:=2^{-n} \delta$ for $n \geq 1$ and taking the union of corresponding exceptional sets $E_{n}$, we see that outside a set of measure $\delta$, the partial Fourier sums converge pointwise for $N \rightarrow \infty$. Applying this with a sequence of $\delta$ shrinking to zero and taking the intersection of the corresponding exceptional sets, which has measure zero, we see that the Fourier series converges outside a set of measure zero.

The purpose of this paper is twofold. On the one hand, it prepares computer verification of Theorem 1.1 by presenting a very detailed proof as a blueprint for coding in Lean. We pass through a bound for a generalization of the so-called Carleson operator to doubling metric measure spaces.

This generalization is new, and proving these bounds constitutes the second purpose of this paper. This generalization incorporates several results from the recent literature, most prominently bounds for the polynomial Carleson operator of V. Lie [Lie20] as well as its generalization [Zor21]. A computer verification of our theorem will also entail a computer verification for the bulk of the work in these results.

We proceed to introduce the setup for our general theorem. We carry a multi purpose parameter, a natural number

in our notation that as it gets larger will allow more general applications but will worsen the constants in the estimates.

A doubling metric measure space $(X, \rho, \mu, a)$ is a complete and locally compact metric space ( $X, \rho$ ) equipped with a $\sigma$-finite non-zero Radon-Borel measure $\mu$ that satisfies the doubling condition that for all $x \in X$ and all $R>0$ we have

\begin{equation*}
\mu(B(x, 2 R)) \leq 2^{a} \mu(B(x, R)) \tag{1.5}
\end{equation*}
$$

where we have denoted by $B(x, R)$ the open ball of radius $R$ centred at $x$ :

$$
\begin{equation*}
B(x, R):=\{y \in X: \rho(x, y)<R\} . \tag{1.6}
\end{equation*}
$$

A collection $\Theta$ of real valued continuous functions on the doubling metric measure space ( $X, \rho, \mu, a$ ) is called compatible, if there is a point $o \in X$ where all the functions are equal to 0 , and if there exists for each ball $B \subset X$ a metric $d_{B}$ on $\Theta$, such that the following five properties (1.7), (1.8), (1.9), (1.10), and (1.11) are satisfied. For every ball $B \subset X$

$$
\begin{equation*}
\sup _{x, y \in B}|\vartheta(x)-\vartheta(y)-\theta(x)+\theta(y)| \leq d_{B}(\vartheta, \theta) . \tag{1.7}
\end{equation*}
$$

For any two balls $B_{1}=B\left(x_{1}, R\right), B_{2}=B\left(x_{2}, 2 R\right)$ in $X$ with $x_{1} \in B_{2}$ and any $\vartheta, \theta \in \Theta$,

$$
\begin{equation*}
d_{B_{2}}(\vartheta, \theta) \leq 2^{a} d_{B_{1}}(\vartheta, \theta) . \tag{1.8}
\end{equation*}
$$

For any two balls $B_{1}, B_{2}$ in $X$ with $B_{1} \subset B_{2}$ and any $\vartheta, \theta \in \Theta$

$$
\begin{equation*}
d_{B_{1}}(\vartheta, \theta) \leq d_{B_{2}}(\vartheta, \theta) \tag{1.9}
\end{equation*}
$$

and for any two balls $B_{1}=B\left(x_{1}, R\right), B_{2}=B\left(x_{2}, 2^{a} R\right)$ with $B_{1} \subset B_{2}$, and $\vartheta, \theta \in \Theta$,

$$
\begin{equation*}
2 d_{B_{1}}(\vartheta, \theta) \leq d_{B_{2}}(\vartheta, \theta) . \tag{1.10}
\end{equation*}
$$

For every ball $B$ in $X$ and every $d_{B}$-ball $\tilde{B}$ of radius $2 R$ in $\Theta$, there is a collection $\mathcal{B}$ of at most $2^{a}$ many $d_{B}$-balls of radius $R$ covering $\tilde{B}$, that is,

$$
\begin{equation*}
\tilde{B} \subset \bigcup \mathcal{B} . \tag{1.11}
\end{equation*}
$$

Further, a compatible collection $\Theta$ is called cancellative, if for any ball $B$ in $X$ of radius $R$, any Lipschitz function $\varphi: X \rightarrow \mathbb{C}$ supported on $B$, and any $\vartheta, \theta \in \Theta$ we have

$$
\begin{equation*}
\left|\int_{B} e(\vartheta(x)-\theta(x)) \varphi(x) d \mu(x)\right| \leq 2^{a} \mu(B)\|\varphi\|_{\operatorname{Lip}(B)}\left(1+d_{B}(\vartheta, \theta)\right)^{-\frac{1}{a}}, \tag{1.12}
\end{equation*}
$$

where $\|\cdot\|_{\operatorname{Lip}(B)}$ denotes the inhomogeneous Lipschitz norm on $B$ :

$$
\|\varphi\|_{\operatorname{Lip}(B)}=\sup _{x \in B}|\varphi(x)|+R \sup _{x, y \in B, x \neq y} \frac{|\varphi(x)-\varphi(y)|}{\rho(x, y)} .
$$

A one-sided Calderón-Zygmund kernel $K$ on the doubling metric measure space $(X, \rho, \mu, a)$ is a measurable function

$$
\begin{equation*}
K: X \times X \rightarrow \mathbb{C} \tag{1.13}
\end{equation*}
$$

such that for all $x, y^{\prime}, y \in X$ with $x \neq y$, we have

$$
\begin{equation*}
|K(x, y)| \leq \frac{2^{a^{3}}}{V(x, y)} \tag{1.14}
\end{equation*}
$$

and if $2 \rho\left(y, y^{\prime}\right) \leq \rho(x, y)$, then

$$
\begin{equation*}
\left|K(x, y)-K\left(x, y^{\prime}\right)\right| \leq\left(\frac{\rho\left(y, y^{\prime}\right)}{\rho(x, y)}\right)^{\frac{1}{a}} \frac{2^{a^{3}}}{V(x, y)} \tag{1.15}
\end{equation*}
$$

where

$$
V(x, y):=\mu(B(x, \rho(x, y))) .
$$

Define the maximally truncated non-tangential singular integral $T_{*}$ associated with $K$ by

$$
\begin{equation*}
T_{*} f(x):=\sup _{R_{1}<R_{2} \rho\left(x, x^{\prime}\right)<R_{1}} \sup \left|\int_{R_{1}<\rho\left(x^{\prime}, y\right)<R_{2}} K\left(x^{\prime}, y\right) f(y) \mathrm{d} \mu(y)\right| . \tag{1.16}
\end{equation*}
$$

We define the generalized Carleson operator $T$ by

$$
\begin{equation*}
T f(x):=\sup _{\vartheta \in \Theta} \sup _{0<R_{1}<R_{2}}\left|\int_{R_{1}<\rho(x, y)<R_{2}} K(x, y) f(y) e(\vartheta(y)) \mathrm{d} \mu(y)\right|, \tag{1.17}
\end{equation*}
$$

where $e(r)=e^{i r}$.
Our main result is the following restricted weak type estimate for $T$ in the range $1<q \leq 2$, which by interpolation techniques recovers $L^{q}$ estimates for the open range $1<q<2$.
Theorem 1.2 (metric space Carleson). For all integers $a \geq 4$ and real numbers $1<q \leq 2$ the following holds. Let $(X, \rho, \mu, a)$ be a doubling metric measure space. Let $\Theta$ be a cancellative compatible collection of functions and let $K$ be a one-sided Calderón-Zygmund kernel on ( $X, \rho, \mu, a$ ). Assume that for every bounded measurable function $g$ on $X$ supported on a set of finite measure we have

$$
\begin{equation*}
\left\|T_{*} g\right\|_{2} \leq 2^{a^{3}}\|g\|_{2} \tag{1.18}
\end{equation*}
$$

where $T_{*}$ is defined in (1.16). Then for all Borel sets $F$ and $G$ in $X$ and all Borel functions $f: X \rightarrow \mathbb{C}$ with $|f| \leq \mathbf{1}_{F}$, we have, with $T$ defined in (1.17),

$$
\begin{equation*}
\left|\int_{G} T f \mathrm{~d} \mu\right| \leq \frac{2^{450 a^{3}}}{(q-1)^{5}} \mu(G)^{1-\frac{1}{q}} \mu(F)^{\frac{1}{q}} . \tag{1.19}
\end{equation*}
$$

In the one-dimensional Euclidean setting, with $K$ representing the Hilbert kernel:

$$
K(x, y)=(x-y)^{-1}
$$

and $\Theta$ denoting the class of linear functions, the operator (1.17) is the classical Carleson operator, which plays a crucial role in proving the almost
everywhere convergence of Fourier series [Car66], [Fef73], [LT00]. The supremum in $R_{1}$ and $R_{2}$ is often omitted in classical treatments, but considering the maximal truncations can easily be reduced to the case without these truncations.

By replacing $\Theta$ with the class of polynomials vanishing at 0 up to some fixed but arbitrary degree, we obtain the polynomial Carleson operator of Lie [Lie09] (quadratic case) and [Lie20]. The case of the class of polynomials with vanishing linear coefficient is simpler and was estimated in [SW01]. The polynomial Carleson operator was generalized to the high-dimensional Euclidean setting in [Zor21] for $K$ being a Calderón-Zygmund kernel with some Hölder regularity.

Doubling metric measure spaces are instances of spaces of homogeneous type. Indeed, by changing from a quasi-metric to an equivalent metric, every space of homogeneous type can be viewed as a doubling metric measure space (cf. [MS79]). Spaces of homogeneous type were introduced by [CW71] as a natural setting for Calderón-Zygmund theory. We refer to the textbook [Ste93] for an account of these spaces.

Our concept of a compatible collection $\Theta$ as a natural class of phase functions on a doubling metric measure space does not appear in [Ste93] but is implicitly anticipated in [Zor21] and subsequent work of [Mna22], who proves a Carleson-type theorem for the Malmquist-Takenaka series, which leads to classes of phases related to Blaschke products. A generalization of (1.17) from the previously mentioned Euclidean setting into the anisotropic setting that was suggested in [Zor21] is included in our theory. The polynomial Carleson operator also plays a role in the study of maximally modulated singular Radon transforms along the parabola, see [Ram21] and [Bec24].

For the proof of Theorem 1.2, we largely follow [Zor21], which in turn was inspired by [Lie20]. We make suitable modifications to adapt to our more general setting and have made a few technical improvements in the proof. In particular, in Section 2, we explicitly divide the main work of the proof into mutually independent sections $3,4,5,6,7,8$, and 9 . Some of these sections follow a similar pattern, starting with a subsection dividing the proof into further mutually independent subsections. This modularization of our proof was strongly endorsed in personal communication by the author of [Zor21]. Acknowledgement. ## 2. Proof of metric space Carleson (Thm 1.2), overview

This section organizes the proof of Theorem 1.2 into sections $3,4,5,6$, 7,8 , and 9 . These sections are mutually independent except for referring to the statements formulated in the present section. Section 3 proves the main Theorem 1.2, while sections $4,5,6,7,8$, and 9 each prove one proposition that is stated in the present section. The present section also introduces all definitions used across these sections.

Subsection 2.1 proves some auxiliary lemmas that are used in more than one of the sections 3-9.

Let $a, q$ be given as in Theorem 1.2.
Define

$$
\begin{align*}
D & :=2^{100 a^{2}}  \tag{2.1}\\
\kappa & :=2^{-10 a} \tag{2.2}
\end{align*}
$$

and

$$
\begin{equation*}
Z:=2^{12 a} \tag{2.3}
\end{equation*}
$$

Let $\psi: \mathbb{R} \rightarrow \mathbb{R}$ be the unique compactly supported, piece-wise linear, continuous function with corners precisely at $\frac{1}{4 D}, \frac{1}{2 D}, \frac{1}{4}$ and $\frac{1}{2}$ which satisfies

$$
\begin{equation*}
\sum_{s \in \mathbb{Z}} \psi\left(D^{-s} x\right)=1 \tag{2.4}
\end{equation*}
$$

for all $x>0$. This function vanishes outside $\left[\frac{1}{4 D}, \frac{1}{2}\right]$, is constant one on $\left[\frac{1}{2 D}, \frac{1}{4}\right]$, and is Lipschitz with constant $4 D$.

Let a doubling metric measure space $(X, \rho, \mu, a)$ be given. Let a cancellative compatible collection $\Theta$ of functions on $X$ be given. Let $o \in X$ be a point such that $\vartheta(o)=0$ for all $\vartheta \in \Theta$.

Let a one-sided Calderón-Zygmund kernel $K$ on $X$ be given so that the operator $T_{*}$ defined in (1.16) satisfies (1.18). Let $T$ be the corresponding operator as defined in (1.17).

For $s \in \mathbb{Z}$, we define

$$
\begin{equation*}
K_{s}(x, y):=K(x, y) \psi\left(D^{-s} \rho(x, y)\right) \tag{2.5}
\end{equation*}
$$

so that for each $x, y \in X$ with $x \neq y$ we have

$$
K(x, y)=\sum_{s \in \mathbb{Z}} K_{s}(x, y)
$$

In Section 3, we prove Theorem 1.2 from its finitary version, Proposition 2.1 below. Recall that a function from a measure space to a finite set is measurable if the pre-image of each of the elements in the range is measurable.

Proposition 2.1 (finitary Carleson). Let $\sigma_{1}, \sigma_{2}: X \rightarrow \mathbb{Z}$ be measurable functions with finite range and $\sigma_{1} \leq \sigma_{2}$. Let $Q: X \rightarrow \Theta$ be a measurable function with finite range. Let $F, G$ be bounded Borel sets in $X$. Then there is a Borel set $G^{\prime}$ in $X$ with $2 \mu\left(G^{\prime}\right) \leq \mu(G)$ such that for all Borel functions $f: X \rightarrow \mathbb{C}$ with $|f| \leq \mathbf{1}_{F}$.

$$
\begin{gather*}
\int_{G \backslash G^{\prime}}\left|\sum_{s=\sigma_{1}(x)}^{\sigma_{2}(x)} \int K_{s}(x, y) f(y) e(Q(x)(y)) \mathrm{d} \mu(y)\right| \mathrm{d} \mu(x) \\
\leq \frac{2^{440 a^{3}}}{(q-1)^{4}} \mu(G)^{1-\frac{1}{q}} \mu(F)^{\frac{1}{q}} \tag{2.6}
\end{gather*}
$$

Let measurable functions $\sigma_{1} \leq \sigma_{2}: X \rightarrow \mathbb{Z}$ with finite range be given. Let a measurable function $Q: X \rightarrow \Theta$ with finite range be given. Let bounded Borel sets $F, G$ in $X$ be given. Let $S$ be the smallest integer such that the ranges of $\sigma_{1}$ and $\sigma_{2}$ are contained in $[-S, S]$ and $F$ and $G$ are contained in the ball $B\left(o, D^{S}\right)$.

In Section 4, we prove Proposition 2.1 using a bound for a dyadic model formulated in Proposition 2.2 below.

A grid structure ( $\mathcal{D}, c, s$ ) on $X$ consists of a finite collection $\mathcal{D}$ of Borel sets in $X$ called dyadic cubes, a surjective function $s: \mathcal{D} \rightarrow[-S, S]$ called scale function, and a function $c: \mathcal{D} \rightarrow X$ called center function such that the five properties (2.7), (2.8), (2.9), (2.10), and (2.11) hold.

For each dyadic cube $I$ and each $-S \leq k<s(I)$ we have

$$
\begin{equation*}
I \subset \bigcup_{J \in \mathcal{D}: s(J)=k} J \tag{2.7}
\end{equation*}
$$

Any two non-disjoint dyadic cubes $I, J$ with $s(I) \leq s(J)$ satisfy

$$
\begin{equation*}
I \subset J . \tag{2.8}
\end{equation*}
$$

For any $x \in B\left(o, D^{S}\right)$, and every $k \in[-S, S]$, there is a dyadic cube $I$ with $s(I)=k$ and

\begin{equation*}
x \in I . \tag{2.9}
\end{equation*}
$$

For any dyadic cube $I$,

$$
\begin{equation*}
c(I) \in B\left(c(I), \frac{1}{4} D^{s(I)}\right) \subset I \subset B\left(c(I), 4 D^{s(I)}\right) . \tag{2.10}
\end{equation*}
$$

For any dyadic cube $I$ and any $t$ with $t D^{s(I)} \geq D^{-S}$,

$$
\begin{equation*}
\mu\left(\left\{x \in I: \rho(x, X \backslash I) \leq t D^{s(I)}\right\}\right) \leq 2^{100 a^{2}} t^{\kappa} \mu(I) \tag{2.11}
\end{equation*}
$$

A tile structure $(\mathfrak{P}, \mathcal{I}, \Omega, \mathcal{Q}, \mathrm{c}, \mathrm{s})$ for a given grid structure $(\mathcal{D}, c, s)$ is a finite set $\mathfrak{P}$ of elements called tiles with five maps

$$
\begin{aligned}
\mathcal{I}: \mathfrak{P} & \rightarrow \mathcal{D} \\
\Omega: \mathfrak{P} & \rightarrow \mathcal{P}(\Theta) \\
\mathcal{Q}: \mathfrak{P} & \rightarrow \Theta \\
\mathrm{c}: \mathfrak{P} & \rightarrow X \\
\mathrm{~s}: \mathfrak{P} & \rightarrow \mathbb{Z}
\end{aligned}
$$

with $\mathcal{I}$ surjective and $\mathcal{P}(\Theta)$ denoting the power set of $\Theta$ such that the five properties (2.13), (2.14), (2.15), (2.18), and (2.19) hold. For each dyadic cube $I$, the restriction of the map $\Omega$ to the set

\begin{equation*}
\mathfrak{P}(I)=\{\mathfrak{p}: \mathcal{I}(\mathfrak{p})=I\} \tag{2.12}
\end{equation*}
$$

is injective and we have the disjoint covering property (we use the union symbol with dot on top to denote a disjoint union)

$$
\begin{equation*}
Q(X) \subset \bigcup_{\mathfrak{p} \in \mathfrak{P}(I)} \Omega(\mathfrak{p}) \tag{2.13}
\end{equation*}
$$

For any tiles $\mathfrak{p}, \mathfrak{q}$ with $\mathcal{I}(\mathfrak{p}) \subset \mathcal{I}(\mathfrak{q})$ and $\Omega(\mathfrak{p}) \cap \Omega(\mathfrak{q}) \neq \emptyset$ we have

\begin{equation*}
\Omega(\mathfrak{q}) \subset \Omega(\mathfrak{p}) . \tag{2.14}
\end{equation*}
$$

For each tile $\mathfrak{p}$,

\mathcal{Q}(\mathfrak{p}) \in B_{\mathfrak{p}}(\mathcal{Q}(\mathfrak{p}), 0.2) \subset \Omega(\mathfrak{p}) \subset B_{\mathfrak{p}}(\mathcal{Q}(\mathfrak{p}), 1), \tag{2.15}
\end{equation*}
$$

where

$$
\begin{equation*}
B_{\mathfrak{p}}(\vartheta, R):=\left\{\theta \in \Theta: d_{\mathfrak{p}}(\vartheta, \theta)<R\right\}, \tag{2.16}
\end{equation*}
$$

and

$$
\begin{equation*}
d_{\mathfrak{p}}:=d_{B\left(c(\mathfrak{p}), \frac{1}{4} D^{s(p)}\right)} . \tag{2.17}
\end{equation*}
$$

We have for each tile $\mathfrak{p}$

\begin{align*}
\mathrm{c}(\mathfrak{p}) & =c(\mathcal{I}(\mathfrak{p})),  \tag{2.18}\\
\mathrm{s}(\mathfrak{p}) & =s(\mathcal{I}(\mathfrak{p})) . \tag{2.19}
\end{align*}
$$

Theorem 1.2 is formulated at the level of generality for general kernels satisfying the mere Hölder regularity condition (1.15). On the other hand, the cancellative condition (1.12) is a testing condition against more regular, namely Lipschitz functions. To bridge the gap, we follow [Zor21] to observe a variant of (1.12) that we formulate in the following proposition proved in Section 8.

2.1. Auxiliary lemmas. We close this section by recording some auxiliary lemmas about the objects defined in Section 2, which will be used in multiple sections to follow.

First, we record an estimate for the metrical entropy numbers of balls in the space $\Theta$ equipped with any of the metrics $d_{B}$, following from the doubling property (1.11).

Lemma 2.7 (ball metric entropy). Let $B^{\prime} \subset X$ be a ball. Let $r>0, \vartheta \in \Theta$ and $k \in \mathbb{N}$. Suppose that $\mathcal{Z} \subset B_{B^{\prime}}\left(\vartheta, r 2^{k}\right)$ satisfies that for all $z, z^{\prime} \in \mathcal{Z}$ with $z \neq z^{\prime}$, we have $d_{B^{\prime}}\left(z, z^{\prime}\right) \geq r$. The next lemma concerns monotonicity of the metrics $d_{B\left(c(I), \frac{1}{4} D^{s(I)}\right)}$ with respect to inclusion of cubes $I$ in a grid.

Lemma 2.8 (monotone cube metrics). Let ( $\mathcal{D}, c, s$ ) be a grid structure. Denote for cubes $I \in \mathcal{D}$

## 3. Proof of metric space Carleson (Thm 1.2)

Let Borel sets $F, G$ in $X$ be given. We have that

We first show how Lemma 3.1 implies Theorem 1.2. As $R$ tends to $\infty$, the integrand of the left-hand side of (3.2) grows monotonically toward the integrand of the left-hand side of (1.19) for all $x$. By Lebesgue's monotone convergence theorem, the left-hand side of (3.2) converges to the left-hand side of (1.19). This verifies Theorem 1.2.

It remains to prove Lemma 3.1. Fix an integer $R>0$. By replacing $G$ with $G \cap B(o, R)$ if necessary, it suffices to show (3.2) under the assumption that $G$ is contained in $B(o, R)$. We make this assumption. For every $x \in G$, the domain of integration in (3.3) is contained in $B(o, 2 R)$. By replacing $F$ with $F \cap B(o, 2 R)$ if necessary, it suffices to show (3.2) under the assumption that $F$ is contained in $B(o, 2 R)$. We make this assumption.

Using the definition (2.5) of $K_{s}$ and the partition of unity (2.4), we express (3.3) as the sum of

T_{1, s_{1}, s_{2}, \vartheta} f(x):=\sum_{s_{1} \leq s \leq s_{2}} \int K_{s}(x, y) f(y) e(\vartheta(y)) \mathrm{d} \mu(y) \tag{3.4}
\end{equation*}
$$

and

$$
\begin{equation*}
\sum_{s=s_{1}-2, s_{1}-1, s_{2}+1, s_{2}+2} \int_{R_{1}<\rho(x, y)<R_{2}} K_{s}(x, y) f(y) e(\vartheta(y)) \mathrm{d} \mu(y) \tag{3.5}
\end{equation*}
$$

where $s_{1}$ is the smallest integer such that $D^{s_{1}-2} R_{2}>\frac{1}{4 D}$ and $s_{2}$ is the largest integer such that $D^{s_{2}+2} R_{1}<\frac{1}{2}$. We restrict the summation index $s$ by excluding summands with $s<s_{1}-2$ or $s>s_{2}+2$ because for these summands, the function $K_{s}$ vanishes on the domain of integration. We also omit the restriction in the integral for the summands in (3.4) because in these summands, the support of $K_{s}$ is contained in the set described by this restriction.

We apply the triangle inequality and estimate the versions of (3.2) separately with $T_{R_{1}, R_{2}, \vartheta}$ replaced by (3.4) and by each summand of (3.5). To handle the case (3.4), we employ the following lemma. Here, we utilize the fact that if $\frac{1}{R} \leq R_{1} \leq R_{2} \leq R$, then $s_{1}$ and $s_{2}$ as in (3.4) are in an interval $[-S, S]$ for some sufficiently large $S$ depending on $R$.

Lemma 3.2 (S truncation). For all integers $S>0$

\leq \frac{2^{446 a^{3}}}{(q-1)^{5}} \mu(G)^{1-\frac{1}{q}} \mu(F)^{\frac{1}{q}} \tag{3.6}
\end{gather*}
$$

where $T_{1, s_{1}, s_{2}, \vartheta}$ is defined in (3.4).
To reduce Lemma 3.1 to Lemma 3.2, we need estimates for the summands in (3.5). Using Lemma 2.9, we obtain for arbitrary $s$ the inequality

\end{align*}

where $M \mathbf{1}_{F}$ is as defined in Proposition 2.6. Now, the left-hand side of (3.2), with $T_{R_{1}, R_{2}, \vartheta}$ replaced by a summand of (3.5), can be estimated using Hölder's inequality and Proposition 2.6 by

Applying the triangle inequality to estimate the left-hand side of (3.2) by contributions from the summands in (3.4) and (3.5), using Lemma 3.2 to control the first term, and the above to estimate the contribution from the four summands in (3.5), combined with $a \geq 4$ and $q<2$, completes the reduction of Lemma 3.1 to Lemma 3.2.

It remains to prove Lemma 3.2. Fix $S>0$.
Lemma 3.3 (finitary $S$ truncation). For all finite sets $\tilde{\Theta} \subset \Theta$

We reduce Lemma 3.2 to Lemma 3.3. By the Lebesgue monotone convergence theorem, applied to an increasing sequence of finite sets $\tilde{\Theta}$, inequality (3.8) continues to hold for countable $\tilde{\Theta}$.

Let $\epsilon=\frac{1}{2 S+1}$. Pick some $\vartheta_{0} \in \Theta$. For $k \geq 0$, let the set $\tilde{\Theta}_{k}$ be a subset of $B_{B(o, 2 R)}\left(\vartheta_{0}, k\right)$ of maximal size, such that for all $\vartheta, \theta \in \tilde{\Theta}_{k}$, it holds that $d_{B(o, 2 R)}(\vartheta, \theta) \geq \epsilon$. Such a set exists, since by Lemma 2.7 there exists an upper bound for the size of such subsets in $B_{B(o, 2 R)}\left(\vartheta_{0}, k\right)$. Define

Then the set $\tilde{\Theta}$ is at most countable, and it has the property that for any $\theta \in \Theta$, there exists $\vartheta \in \tilde{\Theta}$ with

Moreover, there is a $\tilde{\vartheta} \in \tilde{\Theta}$ with $d_{B(o, 2 R)}(\vartheta, \tilde{\vartheta}) \leq \epsilon$. Hence,

& \leq \sum_{s_{1} \leq s \leq s_{2}} \int\left|K_{s}(x, y)\right| \mathbf{1}_{F}(y)|e(\vartheta(y)-\vartheta(x))-e(\tilde{\vartheta}(y)-\tilde{\vartheta}(x))| \mathrm{d} \mu(y) \\
& \leq \sum_{s_{1} \leq s \leq s_{2}} \epsilon \int\left|K_{s}(x, y)\right| \mathbf{1}_{F}(y) \mathrm{d} \mu(y)
\end{aligned}
$$

Using Lemma 2.9, we can estimate the above expression by

\begin{aligned}
& \sum_{s_{1} \leq s \leq s_{2}} \frac{2^{102 a^{3}}}{\mu\left(B\left(x, D^{s}\right)\right)} \epsilon \int_{B\left(x, D^{s}\right)} \mathbf{1}_{F}(y) \mathrm{d} \mu(y) \\
& \leq(2 S+1) \epsilon 2^{102 a^{3}} M \mathbf{1}_{F}(x) \leq 2^{102 a^{3}} M \mathbf{1}_{F}(x)
\end{aligned}
$$

We estimate the left-hand-side of (3.6) by the sum of left-hand-side of (3.8) and

\int \mathbf{1}_{G}(x) \max _{-S<s_{1} \leq s_{2}<S} \sup _{\vartheta \in \Theta} \inf _{\tilde{\vartheta} \in \tilde{\Theta}}\left(\left|T_{1, s_{1}, s_{2}, \vartheta}\right|-\left|T_{1, s_{1}, s_{2}, \tilde{\vartheta}}\right|\right) \mathbf{1}_{F}(x) d \mu(x)
$$

which, as we have just shown, is estimated by

$$

By Hölder's inequality and Proposition 2.6 (more precisely, (2.46) with $p=$ $q$ ), the above is no greater than

Combining this with Lemma 3.3 and the fact that

It remains to prove Lemma 3.3. Fix a finite set $\tilde{\Theta}$.
Lemma 3.4 (linearized truncation). Let $\sigma_{1}, \sigma_{2}: X \rightarrow \mathbb{Z}$ be measurable functions with finite range $[-S, S]$ and $\sigma_{1} \leq \sigma_{2}$. Let $Q: X \rightarrow \tilde{\Theta}$ be a measurable function. Then we have

\end{equation*}
$$

with

$$
\begin{equation*}
T_{2, \sigma_{1}, \sigma_{2}, Q} f(x)=\sum_{\sigma_{1}(x) \leq s \leq \sigma_{2}(x)} \int K_{s}(x, y) f(y) e(Q(x)(y)-Q(x)(x)) \mathrm{d} \mu(y) . \tag{3.11}
\end{equation*}
$$

We reduce Lemma 3.3 to Lemma 3.4. For each $x$, let $\sigma_{1}(x)$ be the minimal element $s^{\prime} \in[-S, S]$ such that

\max _{s^{\prime} \leq s_{2}<S} \max _{\vartheta \in \tilde{\Theta}}\left|T_{1, s^{\prime}, s_{2}, \vartheta} \mathbf{1}_{F}(x)\right|=\max _{-S<s_{1} \leq s_{2}<S} \max _{\vartheta \in \tilde{\Theta}}\left|T_{1, s_{1}, s_{2}, \vartheta} \mathbf{1}_{F}(x)\right|:=T_{1, x}
$$

Similarly, let $\sigma_{2}(x)$ be the minimal element $s^{\prime \prime} \in[-S, S]$ such that

\max _{\vartheta \in \tilde{\Theta}}\left|T_{1, \sigma_{1}(x), s^{\prime \prime}, \vartheta} \mathbf{1}_{F}(x)\right|=T_{1, x}
$$

Finally, choose a total order of the finite set $\tilde{\Theta}$ and let $Q(x)$ be the minimal element $\vartheta$ with respect to this order such that

It remains to prove Lemma 3.4. Fix $\sigma_{1}, \sigma_{2}$, and $Q$ as in the lemma. Applying Proposition 2.1 recursively, we obtain a sequence of sets $G_{n}$ with $G_{0}=G$ and, for each $n \geq 0, \mu\left(G_{n}\right) \leq 2^{-n} \mu(G)$ and

\int \mathbf{1}_{G_{n} \backslash G_{n+1}}(x)\left|T_{2, \sigma_{1}, \sigma_{2}, Q} \mathbf{1}_{F}(x)\right| d \mu(x) \\
\quad \leq \frac{2^{440 a^{3}}}{(q-1)^{4}} \mu\left(G_{n}\right)^{1-\frac{1}{q}} \mu(F)^{\frac{1}{q}} \tag{3.12}
\end{gather*}
$$

Adding the first $n$ of these inequalities, we obtain by bounding a geometric series

\int \mathbf{1}_{G \backslash G_{n}}(x)\left|T_{2, \sigma_{1}, \sigma_{2}, Q} \mathbf{1}_{F}(x)\right| d \mu(x) \leq \frac{2^{445 a^{3}}}{(q-1)^{5}} \mu(G)^{1-\frac{1}{q}} \mu(F)^{\frac{1}{q}} \tag{3.13}
\end{equation*}
$$

As the integrand is bounded by

\mathbf{1}_{G \backslash G_{n}}(x) \sum_{-S<s_{1} \leq s_{2}<S} \sum_{\vartheta \in \tilde{\Theta}}\left|T_{1, s_{1}, s_{2}, \vartheta} \mathbf{1}_{F}(x)\right| \tag{3.14}
\end{equation*}
$$

which by interchange of summation and integration is seen to be integrable, we obtain by Lebesgue's dominated convergence theorem

\int \mathbf{1}_{G}(x)\left|T_{2, \sigma_{1}, \sigma_{2}, Q} \mathbf{1}_{F}(x)\right| d \mu(x) \leq \frac{2^{445 a^{3}}}{(q-1)^{5}} \mu(G)^{1-\frac{1}{q}} \mu(F)^{\frac{1}{q}} \tag{3.15}
\end{equation*}
$$

This completes the proof of Lemma 3.4 and thus Theorem 1.2.

## 4. Proof of finitary Carleson (Prop 2.1)

To prove Proposition 2.1, we already fixed in Section 2 measurable functions $\sigma_{1}, \sigma_{2}, Q$ and Borel sets $F, G$. We have also defined $S$ to be the smallest integer such that the ranges of $\sigma_{1}$ and $\sigma_{2}$ are contained in $[-S, S]$ and $F$ and $G$ are contained in the ball $B\left(o, D^{S}\right)$.

The proof of the next lemma is done in Subsection 4.1, following the construction of dyadic cubes in [Chr90, §3].

Lemma 4.1 (grid existence). There exists a grid structure ( $\mathcal{D}, c, s$ ).
The next lemma, which we prove in Subsection 4.2, should be compared with the construction in [Zor21, Lemma 2.12].
Lemma 4.2 (tile structure). For a given grid structure ( $\mathcal{D}, c, s$ ), there exists a tile structure $(\mathfrak{P}, \mathcal{I}, \Omega, \mathcal{Q}, \mathrm{c}, \mathrm{s})$.

Choose a grid structure $(\mathcal{D}, c, s)$ with Lemma 4.1 and a tile structure for this grid structure $(\mathfrak{P}, \mathcal{I}, \Omega, \mathcal{Q}, \mathrm{c}, \mathrm{s})$ with Lemma 4.2. Applying Proposition 2.2, we obtain a Borel set $G^{\prime}$ in $X$ with $2 \mu\left(G^{\prime}\right) \leq \mu(G)$ such that for all Borel functions $f: X \rightarrow \mathbb{C}$ with $|f| \leq \mathbf{1}_{F}$ we have (2.22).
Lemma 4.3 (tile sum operator). We have for all $x \in G \backslash G^{\prime}$

$$
\begin{equation*}
\sum_{\mathfrak{p} \in \mathfrak{P}} T_{\mathfrak{p}} f(x)=\sum_{s=\sigma_{1}(x)}^{\sigma_{2}(x)} \int K_{s}(x, y) f(y) e(Q(x)(y)-Q(x)(x)) d \mu(y) \tag{4.1}
\end{equation*}
$$

Proof. Fix $x \in G \backslash G^{\prime}$. Sorting the tiles $\mathfrak{p}$ on the left-hand-side of (4.1) by the value $\mathrm{s}(\mathfrak{p}) \in[-S, S]$, it suffices to prove for every $-S \leq s \leq S$ that

\sum_{\mathfrak{p} \in \mathfrak{P}: s(\mathfrak{p})=s} T_{\mathfrak{p}} f(x)=0 \tag{4.2}
\end{equation*}
$$

if $s \notin\left[\sigma_{1}(x), \sigma_{2}(x)\right]$ and

$$
\begin{equation*}
\sum_{\mathfrak{p} \in \mathfrak{P}: s(\mathfrak{p})=s} T_{\mathfrak{p}} f(x)=\int K_{s}(x, y) f(y) e(Q(x)(y)-Q(x)(x)) d \mu(y) \tag{4.3}
\end{equation*}
$$

if $s \in\left[\sigma_{1}(x), \sigma_{2}(x)\right]$. If $s \notin\left[\sigma_{1}(x), \sigma_{2}(x)\right]$, then by definition of $E(\mathfrak{p})$ we have $x \notin E(\mathfrak{p})$ for any $\mathfrak{p}$ with $\mathrm{s}(\mathfrak{p})=s$ and thus $T_{\mathfrak{p}} f(x)=0$. This proves (4.2).

Now assume $s \in\left[\sigma_{1}(x), \sigma_{2}(x)\right]$. By (2.9) and $G \subset B\left(o, D^{S}\right)$, there is at least one $I \in \mathcal{D}$ with $s(I)=s$ and $x \in I$. By (2.8), this $I$ is unique. By (2.13), there is precisely one $\mathfrak{p} \in \mathfrak{P}(I)$ such that $Q(x) \in \Omega(\mathfrak{p})$. Hence there is precisely one $\mathfrak{p} \in \mathfrak{P}$ with $\mathrm{s}(\mathfrak{p})=s$ such that $x \in E(\mathfrak{p})$. For this $\mathfrak{p}$, the value $T_{\mathfrak{p}}(x)$ by its definition in (2.21) equals the right-hand side of (4.3). This proves the lemma.

We now estimate with Lemma 4.3 and Proposition 2.2

& \int_{G \backslash G^{\prime}}\left|\sum_{s=\sigma_{1}(x)}^{\sigma_{2}(x)} \int K_{s}(x, y) f(y) e(Q(x)(y)) \mathrm{d} \mu(y)\right| \mathrm{d} \mu(x)  \tag{4.4}\\
= & \int_{G \backslash G^{\prime}}\left|\sum_{s=\sigma_{1}(x)}^{\sigma_{2}(x)} \int K_{s}(x, y) f(y) e(Q(x)(y)-Q(x)(x)) \mathrm{d} \mu(y)\right| \mathrm{d} \mu(x) \tag{4.5}
\end{align*}
$$

$$
\begin{equation*}
=\int_{G \backslash G^{\prime}}\left|\sum_{\mathfrak{p} \in \mathfrak{P}} T_{\mathfrak{p}} f(x)\right| \mathrm{d} \mu(x) \leq \frac{2^{440 a^{3}}}{(q-1)^{4}} \mu(G)^{1-\frac{1}{q}} \mu(F)^{\frac{1}{q}} . \tag{4.6}
\end{equation*}
$$

This proves (2.6) for the chosen set $G^{\prime}$ and arbitrary $f$ and thus completes the proof of Proposition 2.1.
4.1. Proof of Lemma 4.1, dyadic structure. We begin with the construction of the centers of the dyadic cubes.

Lemma 4.4 (counting balls). Let $-S \leq k \leq S$. Consider $Y \subset X$ such that for any $y \in Y$, we have

Proof. Let $k$ and $Y$ be given. By applying the doubling property (1.5) inductively, we have for each integer $j \geq 0$

Since $X$ is the union of the balls $B\left(y, 2^{j} D^{k}\right)$ and $\mu$ is not zero, at least one of the balls $B\left(y, 2^{j} D^{k}\right)$ has positive measure, thus $B\left(y, D^{k}\right)$ has positive measure.

Applying (4.10) for $j^{\prime}=\ln _{2}\left(8 D^{2 S}\right)=3+2 S \cdot 100 a^{2}$ by (2.1), using $-S \leq k \leq S, y \in B\left(o, 4 D^{S}\right)$, and the triangle inequality, we have

Using the disjointedness of the balls in (4.8), (4.7), and the triangle inequality for $\rho$, we obtain

& \leq 2^{j^{\prime} a} \mu\left(\bigcup_{y \in Y} B\left(y, D^{k}\right)\right) \leq 2^{j^{\prime} a} \mu\left(o, 4 D^{S}\right) \tag{4.13}
\end{align*}
$$

As $\mu\left(o, 4 D^{S}\right)$ is not zero, the lemma follows.
For each $-S \leq k \leq S$, let $Y_{k}$ be a set of maximal cardinality in $X$ such that $Y=Y_{k}$ satisfies the properties (4.7) and (4.8). By the upper bound of Lemma 4.4, such a set exists.

For each $-S \leq k \leq S$, choose an enumeration of the points in the finite set $Y_{k}$ and thus a total order $<$ on $Y_{k}$.

Lemma 4.5 (cover big ball). For each $-S \leq k \leq S$, the ball $B\left(o, 4 D^{S}-D^{k}\right)$ is contained in the union of the balls $B\left(y, 2 D^{k}\right)$ with $y \in Y_{k}$.

Proof. Let $x$ be any point of $B\left(o, 4 D^{S}-D^{k}\right)$. By maximality of $\left|Y_{k}\right|$, the ball $B\left(x, D^{k}\right)$ intersects one of the balls $B\left(y, D^{k}\right)$ with $y \in Y_{k}$. By the triangle inequality, $x \in B\left(y, 2 D^{k}\right)$.

Define the set

$$
\begin{equation*}
\mathcal{C}:=\left\{(y, k):-S \leq k \leq S, y \in Y_{k}\right\} \tag{4.14}
\end{equation*}
$$

We totally order the set $\mathcal{C}$ lexicographically by setting $(y, k)<\left(y^{\prime}, k^{\prime}\right)$ if $k<k^{\prime}$ or both $k=k^{\prime}$ and $y<y^{\prime}$. In what follows, we define recursively in the sense of this order a function

\left(I_{1}, I_{2}, I_{3}\right): \mathcal{C} \rightarrow \mathcal{P}(X) \times \mathcal{P}(X) \times \mathcal{P}(X) . \tag{4.15}
\end{equation*}

Assume the sets $I_{j}\left(y^{\prime}, k^{\prime}\right)$ have already been defined for $j=1,2,3$ if $k^{\prime}<k$ and if $k=k^{\prime}$ and $y^{\prime}<y$.

If $k=-S$, define for $j \in\{1,2\}$ the set $I_{j}(y, k)$ to be $B\left(y, j D^{-S}\right)$. If $-S<k$, define for $j \in\{1,2\}$ and $y \in Y_{k}$ the set $I_{j}(y, k)$ to be

\begin{equation*}

Lemma 4.6 (basic grid structure). For each $-S \leq k \leq S$ and $1 \leq j \leq 3$ the following holds.

If $j \neq 2$ and for some $x \in X$ and $y_{1}, y_{2} \in Y_{k}$ we have

Proof. We prove these statements simultaneously by induction on the ordered set of pairs $(y, k)$. Let $-S \leq k \leq S$.
We first consider (4.19) for $j=1$. If $k=-S$, disjointedness of the sets $I_{1}(y,-S)$ follows by definition of $I_{1}$ and $Y_{k}$. We next consider (4.19) for $j=3$. Assume $x$ is in $I_{3}\left(y_{m}, k\right)$ for $m=1,2$ and $y_{m} \in Y_{k}$. If $x$ is in $X_{k}$, then by definition (4.17), $x \in I_{1}\left(y_{m}, k\right)$ for $m=1,2$. As we have already shown (4.19) for $j=1$, we conclude $y_{1}=y_{2}$. We show (4.20) for $j=2$. In case $k=-S$, this follows from Lemma 4.5. Assume $k>-S$. Let $x$ be a point of $B\left(o, 4 D^{S}-2 D^{k}\right)$. By induction, there is $y^{\prime} \in Y_{k-1}$ such that $x \in I_{3}\left(y^{\prime}, k-1\right)$. Using the inductive statement (4.21), we obtain $x \in B\left(y^{\prime}, 4 D^{k-1}\right)$. Let $x \in B\left(o, D^{S}\right)$. We show properties (2.7), (2.8) and (2.9) for ( $\mathcal{D}, c, s$ ) and $x$.

We first show (2.7) by contradiction. Then there is an $I$ violating the conclusion of (2.7). Pick such $I=I_{3}(y, l)$ such that $l$ is minimal. By assumption, we have $-S \leq k<l$; in particular $-S<l$. By definition, $I_{3}(y, l)$ is contained in $I_{1}(y, l) \cup I_{2}(y, l)$, which is contained in the union of $I_{3}\left(y^{\prime}, l-1\right)$ with $y^{\prime} \in Y_{l-1}$. By minimality of $l$, each such $I_{3}\left(y^{\prime}, l-1\right)$ is contained in the union of all $I_{3}(z, k)$ with $z \in Y_{k}$. This proves (2.7).

We now show (2.8). Assume to get a contradiction that there are nondisjoint $I, J \in \mathcal{D}$ with $s(I) \leq s(J)$ and $I \not \subset J$. We may assume the existence of such $I$ and $J$ with minimal $s(J)-s(I)$. Let $k=s(I)$. Assume first $s(J)=k$. Let $I=I_{3}\left(y_{1}, k\right)$ and $J=I_{3}\left(y_{2}, k\right)$ with $y_{1}, y_{2} \in Y_{k}$. If $y_{1}=y_{2}$, then $I=J$, a contradiction to $I \not \subset J$. If $y_{1} \neq y_{2}$, then $I \cap J=\emptyset$ by (4.19), a contradiction to the non-disjointedness of $I, J$. Assume now $s(J)>k$. Choose $y \in I \cap J$. By property (2.7), there is $K \in \mathcal{D}$ with $s(K)=s(J)-1$ and $y \in K$. By construction of $J$, and pairwise disjointedness of all $I_{3}(w, s(J)-1)$ that we have already seen, we have $K \subset J$. By minimality of $s(J)$, we have $I \subset K$. This proves $I \subset J$ and thus (2.8).

We next establish (2.9). Let $-S \leq k \leq S$. Using (4.20) for $j=3$, we get

$$
\begin{equation*}
x \in B\left(o, D^{S}\right) \subset B\left(o, 4 D^{S}-2 D^{k}\right) \subset \bigcup_{y \in Y_{k}} I_{3}(y, k) \tag{4.45}
\end{equation*}
$$

Thus, there exists a dyadic cube $I=I_{3}(y, k)$ with $s(I)=k$ and $x \in I$. This proves (2.9).
4.2. Proof of Lemma 4.2, tile structure. Choose a grid structure ( $\mathcal{D}, c, s$ ) with Lemma 4.1 Let $I \in \mathcal{D}$. Suppose that

\begin{equation*}
\mathcal{Z} \subset \bigcup_{\vartheta \in Q(X)} B_{I^{\circ}}(\vartheta, 1) \tag{4.46}
\end{equation*}
$$

is such that for any $\vartheta, \theta \in \mathcal{Z}$ we have

$$
\begin{equation*}
B_{I^{\circ}}(\vartheta, 0.3) \cap B_{I^{\circ}}(\theta, 0.3)=\emptyset \tag{4.47}
\end{equation*}
$$

By Lemma 2.7 applied to each of the balls $B_{I^{\circ}}(\vartheta, 1), \vartheta \in Q(X)$, we have

$$
|\mathcal{Z}| \leq 2^{2 a}|Q(X)|
$$

In particular, there exists a set $\mathcal{Z}$ satisfying both (4.46) and (4.47) of maximal cardinality among all such sets. We pick for each $I \in \mathcal{D}$ such a set $\mathcal{Z}(I)$.

Lemma 4.13 (frequency ball cover). For each $I \in \mathcal{D}$, we have

$$
\begin{equation*}
Q(X) \subset \bigcup_{\vartheta \in Q(X)} B_{I^{\circ}}(\vartheta, 1) \subset \bigcup_{z \in \mathcal{Z}(I)} B_{I^{\circ}}(z, 0.7) \tag{4.48}
\end{equation*}
$$

Proof. To show (4.48) note that the first inclusion is obvious. For the second inclusion let $\theta \in \bigcup_{\vartheta \in Q(X)} B_{I^{\circ}}(\vartheta, 1)$. By maximality of $\mathcal{Z}(I)$, there must be a point $z \in \mathcal{Z}(I)$ such that $B_{I^{\circ}}(z, 0.3) \cap B_{I^{\circ}}(\theta, 0.3) \neq \emptyset$. Else, $\mathcal{Z}(I) \cup\{\theta\}$ would be a set of larger cardinality than $\mathcal{Z}(I)$ satisfying (4.46) and (4.47). Fix such $z$, and fix a point $z_{1} \in B_{I^{\circ}}(z, 0.3) \cap B_{I^{\circ}}(\theta, 0.3)$. By the triangle inequality, we deduce that

$$
d_{I^{\circ}}(z, \theta) \leq d_{I^{\circ}}\left(z, z_{1}\right)+d_{I^{\circ}}\left(\theta, z_{1}\right)<0.3+0.3=0.6
$$

and hence $\theta \in B_{I^{\circ}}(z, 0.7)$.
We define

\mathfrak{P}=\{(I, z) \quad: \quad I \in \mathcal{D}, z \in \mathcal{Z}(I)\} \\
\mathcal{I}((I, z))=I \quad \text { and } \quad \mathcal{Q}((I, z))=z
\end{gathered}
$$

We further set

$$
\mathrm{s}(\mathfrak{p})=s(\mathcal{I}(\mathfrak{p})), \quad \mathrm{c}(\mathfrak{p})=c(\mathcal{I}(\mathfrak{p}))
$$

Then (2.18), (2.19) hold by definition.
It remains to construct the map $\Omega$, and verify properties (2.13), (2.14) and (2.15). We first construct an auxiliary map $\Omega_{1}$. For each $I \in \mathcal{D}$, we pick an enumeration of the finite set $\mathcal{Z}(I)$

\mathcal{Z}(I)=\left\{z_{1}, \ldots, z_{M}\right\} .
$$

We define $\Omega_{1}: \mathfrak{P} \mapsto \mathcal{P}(\Theta)$ as below. Set

\Omega_{1}\left(\left(I, z_{1}\right)\right)=B_{I^{\circ}}\left(z_{1}, 0.7\right) \backslash \bigcup_{z \in \mathcal{Z}(I) \backslash\left\{z_{1}\right\}} B_{I^{\circ}}(z, 0.3)
$$

and then define iteratively

$$
\begin{equation*}
\Omega_{1}\left(\left(I, z_{k}\right)\right)=B_{I^{\circ}}\left(z_{k}, 0.7\right) \backslash \bigcup_{z \in \mathcal{Z}(I) \backslash\left\{z_{k}\right\}} B_{I^{\circ}}(z, 0.3) \backslash \bigcup_{i=1}^{k-1} \Omega_{1}\left(\left(I, z_{i}\right)\right) . \tag{4.49}
\end{equation*}
$$

Lemma 4.14 (disjoint frequency cubes). For each $I \in \mathcal{D}$, and $\mathfrak{p}_{1}, \mathfrak{p}_{2} \in \mathfrak{P}(I)$, if

$$
\Omega_{1}\left(\mathfrak{p}_{1}\right) \cap \Omega_{1}\left(\mathfrak{p}_{2}\right) \neq \emptyset,
$$

then $\mathfrak{p}_{1}=\mathfrak{p}_{2}$.
Proof. By the definition of the map $\mathcal{I}$, we have

$$
\mathfrak{P}(I)=\{(I, z): z \in \mathcal{Z}(I)\} .
$$

By (4.49), the set $\Omega_{1}\left(\left(I, z_{k}\right)\right)$ is disjoint from each $\Omega_{1}\left(\left(I, z_{i}\right)\right)$ with $i<k$. Thus the sets $\Omega_{1}(\mathfrak{p}), \mathfrak{p} \in \mathfrak{P}(I)$ are pairwise disjoint.
Lemma 4.15 (frequency cube cover). For each $I \in \mathcal{D}$, it holds that

$$
\begin{equation*}
\bigcup_{z \in \mathcal{Z}(I)} B_{I^{\circ}}(z, 0.7) \subset \bigcup_{\mathfrak{p} \in \mathfrak{P}(I)} \Omega_{1}(\mathfrak{p}) . \tag{4.50}
\end{equation*}
$$

For every $\mathfrak{p} \in \mathfrak{P}$, it holds that

$$
\begin{equation*}
B_{\mathfrak{p}}(\mathcal{Q}(\mathfrak{p}), 0.3) \subset \Omega_{1}(\mathfrak{p}) \subset B_{\mathfrak{p}}(\mathcal{Q}(\mathfrak{p}), 0.7) \tag{4.51}
\end{equation*}
$$

Proof. For (4.51) let $\mathfrak{p}=(I, z)$. The second inclusion in (4.51) then follows from (4.49) and the equality $B_{\mathfrak{p}}(\mathcal{Q}(\mathfrak{p}), 0.7)=B_{I^{\circ}}(z, 0.7)$, which is true by definition. For the first inclusion in (4.51) let $\vartheta \in B_{\mathfrak{p}}(\mathcal{Q}(\mathfrak{p}), 0.3)$. Let $k$ be such that $z=z_{k}$ in the enumeration we chose above. It follows immediately from (4.49) and (4.47) that $\vartheta \notin \Omega_{1}\left(\left(I, z_{i}\right)\right)$ for all $i<k$. Thus, again from (4.49), we have $\vartheta \in \Omega_{1}\left(\left(I, z_{k}\right)\right)$.

To show (4.50) let $\vartheta \in \bigcup_{z \in \mathcal{Z}(I)} B_{I^{\circ}}(z, 0.7)$. If there exists $z \in \mathcal{Z}(I)$ with $\vartheta \in B_{I^{\circ}}(z, 0.3)$, then

$$
z \in \Omega_{1}((I, z)) \subset \bigcup_{\mathfrak{p} \in \mathfrak{P}(I)} \Omega_{1}(\mathfrak{p})
$$

by the first inclusion in (4.51).
Now suppose that there exists no $z \in \mathcal{Z}(I)$ with $\vartheta \in B_{I^{\circ}}(z, 0.3)$. Let $k$ be minimal such that $\vartheta \in B_{I^{\circ}}\left(z_{k}, 0.7\right)$. Since $\Omega_{1}\left(\left(I, z_{i}\right)\right) \subset B_{I^{\circ}}\left(z_{i}, 0.7\right)$ for each $i$ by (4.49), we have that $\vartheta \notin \Omega_{1}\left(\left(I, z_{i}\right)\right)$ for all $i<k$. Hence $\vartheta \in \Omega_{1}\left(\left(I, z_{k}\right)\right)$, again by (4.49).

Now we are ready to define the function $\Omega$. For all cubes $I \in \mathcal{D}$ such that there exists no $J \in \mathcal{D}$ with $I \subset J$ and $I \neq J$, we define for all $\mathfrak{p} \in \mathfrak{P}(I)$

$$
\begin{equation*}
\Omega(\mathfrak{p})=\Omega_{1}(\mathfrak{p}) \tag{4.52}
\end{equation*}
$$

For cubes $I \in \mathcal{D}$ for which there exists $J \in \mathcal{D}$ with $I \subset J$ and $I \neq J$, we define $\Omega$ by recursion. We can pick an inclusion minimal $J \in \mathcal{D}$ among the finitely many cubes such that $I \subset J$ and $I \neq J$. This $J$ is unique: Suppose that $J^{\prime}$ is another inclusion minimal cube with $I \subset J^{\prime}$ and $I \neq J^{\prime}$. Without loss of generality, we have that $s(J) \leq s\left(J^{\prime}\right)$. By (2.8), it follows that $J \subset J^{\prime}$. Since $J^{\prime}$ is minimal with respect to inclusion, it follows that $J=J^{\prime}$. Then we define

$$
\begin{equation*}
\Omega(\mathfrak{p})=\bigcup_{z \in \mathcal{Z}(J) \cap \Omega_{1}(\mathfrak{p})} \Omega((J, z)) \cup B_{\mathfrak{p}}(\mathcal{Q}(\mathfrak{p}), 0.2) . \tag{4.53}
\end{equation*}
$$

Lemma 4.16 (dyadic frequency cubes). With this definition, (2.13), (2.14) and (2.15) hold.

Proof. First, we prove (2.15). If $I \in \mathcal{D}$ is maximal in $\mathcal{D}$ with respect to set inclusion, then (2.15) holds for all $\mathfrak{p} \in \mathfrak{P}(I)$ by (4.52) and (4.51). Now suppose that $I$ is not maximal in $\mathcal{D}$ with respect to set inclusion. Then we may assume by induction that for all $J \in \mathcal{D}$ with $I \subset J$ and all $\mathfrak{p}^{\prime} \in \mathfrak{P}(J)$, (2.15) holds. Let $J$ be the unique minimal cube in $\mathcal{D}$ with $I \subsetneq J$.

Suppose that $\vartheta \in \Omega(\mathfrak{p})$. If $\vartheta \in B_{\mathfrak{p}}(\mathcal{Q}(\mathfrak{p}), 0.2)$, then since

$$
B_{\mathfrak{p}}(\mathcal{Q}(\mathfrak{p}), 0.2) \subset B_{\mathfrak{p}}(\mathcal{Q}(\mathfrak{p}), 1),
$$

we conclude that $\vartheta \in B_{\mathfrak{p}}(\mathcal{Q}(\mathfrak{p}), 0.7)$. If not, by (4.53), there exists $z \in$ $\mathcal{Z}(J) \cap \Omega_{1}(\mathfrak{p})$ with $\vartheta \in \Omega(J, z)$. Using the triangle inequality and (4.51), we obtain

$$
d_{I^{\circ}}(\mathcal{Q}(\mathfrak{p}), \vartheta) \leq d_{I^{\circ}}(\mathcal{Q}(\mathfrak{p}), z)+d_{I^{\circ}}(z, \vartheta) \leq 0.7+d_{I^{\circ}}(z, \vartheta)
$$

By Lemma 2.8 and the induction hypothesis, this is estimated by

$$
\leq 0.7+2^{-95 a} d_{J^{\circ}}(z, \vartheta) \leq 0.7+2^{-95 a} \cdot 1<1
$$

This shows the second inclusion in (2.15). The first inclusion is immediate from (4.53).

Next, we show (2.13). Let $I \in \mathcal{D}$.
If $I$ is maximal with respect to inclusion, then disjointedness of the sets $\Omega(\mathfrak{p})$ for $\mathfrak{p} \in \mathfrak{P}(I)$ follows from the definition (4.52) and Lemma 4.14. To obtain the inclusion in (2.13) one combines the inclusions (4.48) and (4.50) of Lemma 4.15 with (4.52).

Now we turn to the case where there exists $J \in \mathcal{D}$ with $I \subset J$ and $I \neq J$. In this case we use induction: It suffices to show (2.13) under the assumption that it holds for all cubes $J \in \mathcal{D}$ with $I \subset J$. As shown before definition (4.53), we may choose the unique inclusion minimal such $J$. To show disjointedness of the sets $\Omega(\mathfrak{p}), \mathfrak{p} \in \mathfrak{P}(I)$ we pick two tiles $\mathfrak{p}, \mathfrak{p}^{\prime} \in \mathfrak{P}(I)$ and $\vartheta \in \Omega(\mathfrak{p}) \cap \Omega\left(\mathfrak{p}^{\prime}\right)$. Then we are by (4.53) in one of the following four cases.

1. There exist $z \in \mathcal{Z}(J) \cap \Omega_{1}(\mathfrak{p})$ such that $\vartheta \in \Omega(J, z)$, and there exists $z^{\prime} \in \mathcal{Z}(J) \cap \Omega_{1}\left(\mathfrak{p}^{\prime}\right)$ such that $\vartheta \in \Omega\left(J, z^{\prime}\right)$. By the induction hypothesis, that (2.13) holds for $J$, we must have $z=z^{\prime}$. By Lemma 4.14, we must then have $\mathfrak{p}=\mathfrak{p}^{\prime}$.
2. There exists $z \in \mathcal{Z}(J) \cap \Omega_{1}(\mathfrak{p})$ such that $\vartheta \in \Omega(J, z)$, and $\vartheta \in$ $B_{\mathfrak{p}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{p}^{\prime}\right), 0.2\right)$. Using the triangle inequality, Lemma 2.8 and (2.15), we obtain

$$
d_{\mathfrak{p}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{p}^{\prime}\right), z\right) \leq d_{\mathfrak{p}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{p}^{\prime}\right), \vartheta\right)+d_{\mathfrak{p}^{\prime}}(z, \vartheta) \leq 0.2+2^{-95 a} \cdot 1<0.3
$$

Thus $z \in \Omega_{1}\left(\mathfrak{p}^{\prime}\right)$ by (4.51). By Lemma 4.14, it follows that $\mathfrak{p}=\mathfrak{p}^{\prime}$.
3. There exists $z^{\prime} \in \mathcal{Z}(J) \cap \Omega_{1}\left(\mathfrak{p}^{\prime}\right)$ such that $\vartheta \in \Omega\left(J, z^{\prime}\right)$, and $\vartheta \in$ $B_{\mathfrak{p}}(\mathcal{Q}(\mathfrak{p}), 0.2)$. This case is the same as case 2., after swapping $\mathfrak{p}$ and $\mathfrak{p}^{\prime}$.
4. We have $\vartheta \in B_{\mathfrak{p}}(\mathcal{Q}(\mathfrak{p}), 0.2) \cap B_{\mathfrak{p}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{p}^{\prime}\right), 0.2\right)$. In this case it follows that $\mathfrak{p}=\mathfrak{p}^{\prime}$ since the sets $B_{\mathfrak{p}}(\mathcal{Q}(\mathfrak{p}), 0.2)$ are pairwise disjoint by the inclusion (4.51) and Lemma 4.14.

To show the inclusion in (2.13), let $\vartheta \in Q(X)$. By the induction hypothesis, there exists $\mathfrak{p} \in \mathfrak{P}(J)$ such that $\vartheta \in \Omega(\mathfrak{p})$. By definition of the set $\mathfrak{P}$, we have $\mathfrak{p}=(J, z)$ for some $z \in \mathcal{Z}(J)$. By (4.46), there exists $x \in X$ with $d_{J^{\circ}}(Q(x), z) \leq 1$. By Lemma 2.8, it follows that $d_{I^{\circ}}(Q(x), z) \leq 1$. Thus, by (4.48), there exists $z^{\prime} \in \mathcal{Z}(I)$ with $z \in B_{I^{\circ}}\left(z^{\prime}, 0.7\right)$. Then by Lemma (4.15) there exists $\mathfrak{p}^{\prime} \in \mathfrak{P}(I)$ with $z \in \mathcal{Z}(J) \cap \Omega_{1}\left(\mathfrak{p}^{\prime}\right)$. Consequently, by (4.53), $\vartheta \in \Omega\left(\mathfrak{p}^{\prime}\right)$. This completes the proof of (2.13).

Finally, we show (2.14). Let $\mathfrak{p}, \mathfrak{q} \in \mathfrak{P}$ with $\mathcal{I}(\mathfrak{p}) \subset \mathcal{I}(\mathfrak{p})$ and $\Omega(\mathfrak{p}) \cap \Omega(\mathfrak{q}) \neq$ $\emptyset$. If we have $\mathrm{s}(\mathfrak{p}) \geq \mathrm{s}(\mathfrak{q})$, then it follows from (2.8) that $I=J$, thus $\mathfrak{p}, \mathfrak{q} \in \mathfrak{P}(I)$. By (2.13) we have then either $\Omega(\mathfrak{p}) \cap \Omega(\mathfrak{q})=\emptyset$ or $\Omega(\mathfrak{p})=\Omega(\mathfrak{q})$. By the assumption in (2.14) we have $\Omega(\mathfrak{p}) \cap \Omega(\mathfrak{q}) \neq \emptyset$, so we must have $\Omega(\mathfrak{p})=\Omega(\mathfrak{q})$ and in particular $\Omega(\mathfrak{q}) \subset \Omega(\mathfrak{p})$.

So it remains to show (2.14) under the additional assumption that $s(\mathfrak{q})>$ $\mathrm{s}(\mathfrak{p})$. In this case, we argue by induction on $\mathrm{s}(\mathfrak{q})-\mathrm{s}(\mathfrak{p})$. By (2.7), there exists a cube $J \in \mathcal{D}$ with $s(J)=\mathrm{s}(\mathfrak{q})-1$ and $J \cap \mathcal{I}(\mathfrak{p}) \neq \emptyset$. We pick one such $J$. By (2.8), we have $\mathcal{I}(\mathfrak{p}) \subset J \subset \mathcal{I}(\mathfrak{q})$.

By (4.46), there exists $x \in X$ with $d_{\mathfrak{q}}(Q(x), \mathcal{Q}(\mathfrak{q})) \leq 1$. By Lemma 2.8, it follows that $d_{J^{\circ}}(Q(x), \mathcal{Q}(\mathfrak{q})) \leq 1$. Thus, by (4.48), there exists $z^{\prime} \in \mathcal{Z}(J)$ with $\mathcal{Q}(\mathfrak{q}) \in B_{J^{\circ}}\left(z^{\prime}, 0.7\right)$. Then by Lemma 4.15 there exists $\mathfrak{q}^{\prime} \in \mathfrak{P}(J)$ with $\mathcal{Q}(\mathfrak{q}) \in \Omega_{1}\left(\mathfrak{q}^{\prime}\right)$. By $(4.53)$, it follows that $\Omega(\mathfrak{q}) \subset \Omega\left(\mathfrak{q}^{\prime}\right)$. Note that then $\mathcal{I}(\mathfrak{p}) \subset \mathcal{I}\left(\mathfrak{q}^{\prime}\right)$ and $\Omega(\mathfrak{p}) \cap \Omega\left(\mathfrak{q}^{\prime}\right) \neq \emptyset$ and $\mathrm{s}\left(\mathfrak{q}^{\prime}\right)-\mathrm{s}(\mathfrak{p})=\mathrm{s}(\mathfrak{q})-\mathrm{s}(\mathfrak{p})-1$. Thus, we have by the induction hypothesis that $\Omega\left(\mathfrak{q}^{\prime}\right) \subset \Omega(\mathfrak{p})$. This completes the proof.

## 5. Proof of discrete Carleson (Prop. 2.2)

Let a grid structure $(\mathcal{D}, c, s)$ and a tile structure $(\mathfrak{P}, \mathcal{I}, \Omega, \mathcal{Q})$ for this grid structure be given. In Subsection 5.1, we decompose the set $\mathfrak{P}$ of tiles into subsets. Each subset will be controlled by one of three methods. The guiding principle of the decomposition is to be able to apply the forest estimate of Proposition 2.4 to the final subsets defined in (5.23). This application is done in Subsection 5.4. The miscellaneous subsets along the construction of the forests will either be thrown into exceptional sets, which are defined and controlled in Subsection 5.2, or will be controlled by the antichain estimate of Proposition 2.3, which is done in Subsection 5.5. Subsection 5.3 contains some auxiliary lemmas needed for the proofs in Subsections 5.4-5.5.
5.1. Organisation of the tiles. In the following definitions, $k, n$, and $j$ will be nonnegative integers. Define $\mathcal{C}(G, k)$ to be the set of $I \in \mathcal{D}$ such that
there exists a $J \in \mathcal{D}$ with $I \subset J$ and

\mu(G \cap J)>2^{-k-1} \mu(J) \tag{5.1}
\end{equation*}
$$

but there does not exist a $J \in \mathcal{D}$ with $I \subset J$ and

\end{equation*}
$$

Let

$$
\begin{equation*}
\mathfrak{P}(k)=\{\mathfrak{p} \in \mathfrak{P}: \mathcal{I}(\mathfrak{p}) \in \mathcal{C}(G, k)\} \tag{5.3}
\end{equation*}
$$

Define $\mathfrak{M}(k, n)$ to be the set of $\mathfrak{p} \in \mathfrak{P}(k)$ such that

$$
\begin{equation*}
\mu\left(E_{1}(\mathfrak{p})\right)>2^{-n} \mu(\mathcal{I}(\mathfrak{p})) \tag{5.4}
\end{equation*}
$$

and there does not exist $\mathfrak{p}^{\prime} \in \mathfrak{P}(k)$ with $\mathfrak{p}^{\prime} \neq \mathfrak{p}$ and $\mathfrak{p} \leq \mathfrak{p}^{\prime}$ such that

$$
\begin{equation*}
\mu\left(E_{1}\left(\mathfrak{p}^{\prime}\right)\right)>2^{-n} \mu\left(\mathcal{I}\left(\mathfrak{p}^{\prime}\right)\right) \tag{5.5}
\end{equation*}
$$

Define for a collection $\mathfrak{P}^{\prime} \subset \mathfrak{P}(k)$

$$
\begin{equation*}

\mathbf{1}_{\mathcal{I}(\mathfrak{u})}(x) \leq 2^{-j} \sum_{\mathfrak{m} \in \mathfrak{M}(k, n): 100 \mathfrak{u} \leq \mathfrak{m}} \mathbf{1}_{\mathcal{I}(\mathfrak{m})}(x) \tag{5.53}
\end{equation*}
$$

Conversely, for each $\mathfrak{m} \in \mathfrak{M}(k, n)$ with $x \in \mathcal{I}(\mathfrak{m})$, let $\mathfrak{U}(\mathfrak{m})$ be the set of $\mathfrak{u} \in \mathfrak{U}_{1}(k, n, j)$ with $x \in \mathcal{I}(\mathfrak{u})$ and $100 \mathfrak{u} \lesssim \mathfrak{m}$. Summing (5.53) over $\mathfrak{u}$ and counting the pairs $(\mathfrak{u}, \mathfrak{m})$ with $100 \mathfrak{u} \lesssim \mathfrak{m}$ differently gives

$$
\begin{equation*}
\sum_{\mathfrak{u} \in \mathfrak{U}_{1}(k, n, j)} \mathbf{1}_{\mathcal{I}(\mathfrak{u})}(x) \leq 2^{-j} \sum_{\mathfrak{m} \in \mathfrak{M}(k, n)} \sum_{\mathfrak{u} \in \mathfrak{U}(\mathfrak{m})} \mathbf{1}_{\mathcal{I}(\mathfrak{m})}(x) \tag{5.54}
\end{equation*}
$$

We estimate the number of elements in $\mathfrak{U}(\mathfrak{m})$. Let $\mathfrak{u} \in \mathfrak{U}(\mathfrak{m})$. Then by definition of $\mathfrak{U}(\mathfrak{m})$

$$
\begin{equation*}
d_{\mathfrak{u}}(\mathcal{Q}(\mathfrak{u}), \mathcal{Q}(\mathfrak{m})) \leq 100 \tag{5.55}
\end{equation*}
$$

If $\mathfrak{u}^{\prime}$ is a further element in $\mathfrak{U}(\mathfrak{m})$ with $\mathfrak{u} \neq \mathfrak{u}^{\prime}$, then

$$
\begin{equation*}
\mathcal{Q}(\mathfrak{m}) \in B_{\mathfrak{u}}(\mathcal{Q}(\mathfrak{u}), 100) \cap B_{\mathfrak{u}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{u}^{\prime}\right), 100\right) \tag{5.56}
\end{equation*}
$$

By the last display and definition of $\mathfrak{U}_{1}(k, n, j)$, none of $\mathcal{I}(\mathfrak{u}), \mathcal{I}\left(\mathfrak{u}^{\prime}\right)$ is strictly contained in the other. As both contain $x$, we have $\mathcal{I}(\mathfrak{u})=\mathcal{I}\left(\mathfrak{u}^{\prime}\right)$. We then have $d_{\mathfrak{u}}=d_{\mathfrak{u}^{\prime}}$.

By (2.15), the balls $B_{\mathfrak{u}}(\mathcal{Q}(\mathfrak{u}), 0.2)$ and $B_{\mathfrak{u}}\left(\mathcal{Q}\left(\mathfrak{u}^{\prime}\right), 0.2\right)$ are contained respectively in $\Omega(\mathfrak{u})$ and $\Omega\left(\mathfrak{u}^{\prime}\right)$ and thus are disjoint by (2.13). By (5.55) and the triangle inequality, both balls are contained in $B_{\mathfrak{u}}(\mathcal{Q}(\mathfrak{m}), 100.2)$.

By (1.11) applied nine times, there is a collection of at most $2^{9 a}$ balls of radius 0.2 with respect to the metric $d_{\mathfrak{u}}$ which cover the ball $B_{\mathfrak{u}}(\mathcal{Q}(\mathfrak{m}), 100.2)$. Let $B^{\prime}$ be a ball in this cover. As the center of $B^{\prime}$ can be in at most one of the disjoint balls $B_{\mathfrak{u}}(\mathcal{Q}(\mathfrak{u}), 0.2)$ and $B_{\mathfrak{u}}\left(\mathcal{Q}\left(\mathfrak{u}^{\prime}\right), 0.2\right)$, the ball $B^{\prime}$ can contain at most one of the points $\mathfrak{u}, \mathfrak{u}^{\prime}$.

Hence the set $\mathfrak{U}(\mathfrak{m})$ has at most $2^{9 a}$ many elements. Inserting this into (5.54) proves the lemma.

Lemma 5.12 (boundary exception). Let $\mathcal{L}(\mathfrak{u})$ be as defined in (5.20). We have for each $\mathfrak{u} \in \mathfrak{U}_{1}(k, n, l)$,

\begin{equation*}
\mu\left(\bigcup_{I \in \mathcal{L}(\mathfrak{u})} I\right) \leq 2^{100 a^{2}} D^{-\kappa Z(n+1)} \mu(\mathcal{I}(\mathfrak{u})) \tag{5.57}
\end{equation*}
$$

Proof. Let $\mathfrak{u} \in \mathfrak{U}_{1}(k, n, l)$. Let $I \in \mathcal{L}(\mathfrak{u})$. Then we have $s(I)=\mathrm{s}(\mathfrak{u})-$ $Z(n+1)-1$ and $I \subset \mathcal{I}(\mathfrak{u})$ and $B\left(c(I), 8 D^{s(I)}\right) \not \subset \mathcal{I}(\mathfrak{u})$. By (2.10), the set $I$ is contained in $B\left(c(I), 4 D^{s(I)}\right)$. By the triangle inequality, the set $I$ is contained in

$$
\begin{equation*}
X(\mathfrak{u}):=\left\{x \in \mathcal{I}(\mathfrak{u}): \rho(x, X \backslash \mathcal{I}(\mathfrak{u})) \leq 12 D^{\mathrm{s}(\mathfrak{u})-Z(n+1)-1}\right\} \tag{5.58}
\end{equation*}
$$

By the small boundary property (2.11), noting that

$$
12 D^{\mathrm{s}(\mathfrak{u})-Z(n+1)-1}=12 D^{s(I)}>D^{-S}
$$

we have

$$
\mu(X(\mathfrak{u})) \leq 2^{100 a^{2}}\left(12 D^{-Z(n+1)-1}\right)^{\kappa} \mu(\mathcal{I}(\mathfrak{u}))
$$

Using $\kappa<1$ and $D \geq 12$, this proves the lemma.
Lemma 5.13 (third exception). We have

$$
\begin{equation*}
\mu\left(G_{3}\right) \leq 2^{-4} \mu(G) \tag{5.59}
\end{equation*}
$$

Proof. As each $\mathfrak{p} \in \mathfrak{L}_{4}(k, n, j)$ is contained in $\cup \mathcal{L}(\mathfrak{u})$ for some $\mathfrak{u} \in \mathfrak{U}_{1}(k, n, l)$, we have

$$
\begin{equation*}
\mu\left(\bigcup_{\mathfrak{p} \in \mathfrak{L}_{4}(k, n, j)} \mathcal{I}(\mathfrak{p})\right) \leq \sum_{\mathfrak{u} \in \mathfrak{U}_{1}(k, n, j)} \mu\left(\bigcup_{I \in \mathcal{L}(\mathfrak{u})} I\right) \tag{5.60}
\end{equation*}
$$

Using Lemma 5.12 and then Lemma 5.11, we estimate this further by

$$
\begin{gather*}
\leq \sum_{\mathfrak{u} \in \mathfrak{U}_{1}(k, n, j)} 2^{100 a^{2}} D^{-\kappa Z(n+1)} \mu(\mathcal{I}(\mathfrak{u}))  \tag{5.61}\\
\leq 2^{100 a^{2}+9 a+1-j} \sum_{\mathfrak{m} \in \mathfrak{M}(k, n)} D^{-\kappa Z(n+1)} \mu(\mathcal{I}(\mathfrak{m})) . \tag{5.62}
\end{gather*}
$$

Using Lemma 5.10, we estimate this by

$$
\begin{equation*}
\leq 2^{100 a^{2}+9 a+1-j} D^{-\kappa Z(n+1)} 2^{n+1} 2^{k+1} \mu(G) \tag{5.63}
\end{equation*}
$$

Now we estimate $G_{3}$ defined in (5.28) by

$$
\begin{equation*}
\mu\left(G_{3}\right) \leq \sum_{k \geq 0} \sum_{n \geq k} \sum_{0 \leq j \leq 2 n+3} \mu\left(\bigcup_{\mathfrak{p} \in \mathfrak{I}_{4}(k, n, j)} \mathcal{I}(\mathfrak{p})\right) \tag{5.64}
\end{equation*}
$$

$$
\begin{equation*}
\leq \sum_{k \geq 0} \sum_{n \geq k} \sum_{0 \leq j \leq 2 n+3} 2^{100 a^{2}+9 a+3+n+k-j} D^{-\kappa Z(n+1)} \mu(G) \tag{5.65}
\end{equation*}
$$

Summing geometric series, using that $D^{\kappa Z} \geq 8$ by (2.1), (2.2) and (2.3), we estimate this by

$$
\begin{gather*}
\leq \sum_{k \geq 0} \sum_{n \geq k} 2^{100 a^{2}+9 a+4+n+k} D^{-\kappa Z(n+1)} \mu(G)  \tag{5.66}\\
=\sum_{k \geq 0} 2^{100 a^{2}+9 a+4+2 k} D^{-\kappa Z(k+1)} \sum_{n \geq k} 2^{n-k} D^{-\kappa Z(n-k)} \mu(G)  \tag{5.67}\\
\leq \sum_{k \geq 0} 2^{100 a^{2}+9 a+5+2 k} D^{-\kappa Z(k+1)} \mu(G)  \tag{5.68}\\
\leq 2^{100 a^{2}+9 a+6} D^{-\kappa Z} \mu(G) \tag{5.69}
\end{gather*}
$$

Using $D=2^{100 a^{2}}$ and $a \geq 4$ and $\kappa Z \geq 2$ by (2.1) and (2.2) proves the lemma.
5.3. Auxiliary lemmas. Before proving Lemma 5.2 and Lemma 5.3, we collect some useful properties of $\lesssim$.

Lemma 5.14 (wiggle order 1). If $n \mathfrak{p} \lesssim m \mathfrak{p}^{\prime}$ and $n^{\prime} \geq n$ and $m \geq m^{\prime}$ then $n^{\prime} \mathfrak{p} \lesssim m^{\prime} \mathfrak{p}^{\prime}$.

Proof. This follows immediately from the definition (2.24) of $\lesssim$ and the two inclusions $B_{\mathfrak{p}}(\mathcal{Q}(\mathfrak{p}), n) \subset B_{\mathfrak{p}}\left(\mathcal{Q}(\mathfrak{p}), n^{\prime}\right)$ and $B_{\mathfrak{p}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{p}^{\prime}\right), m^{\prime}\right) \subset B_{\mathfrak{p}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{p}^{\prime}\right), m\right)$.

Lemma 5.15 (wiggle order 2).
Let $n, m \geq 1$. If $\mathfrak{p}, \mathfrak{p}^{\prime} \in \mathfrak{P}$ with $\mathcal{I}(\mathfrak{p}) \neq \mathcal{I}\left(\mathfrak{p}^{\prime}\right)$ and

$$
\begin{equation*}
n \mathfrak{p} \lesssim \mathfrak{p}^{\prime} \tag{5.70}
\end{equation*}
$$

then

$$
\begin{equation*}
\left(n+2^{-95 a} m\right) \mathfrak{p} \lesssim m \mathfrak{p}^{\prime} \tag{5.71}
\end{equation*}
$$

Proof. The assumption (5.70) together with the definition (2.24) of $\lesssim$ implies that $\mathcal{I}(\mathfrak{p}) \subsetneq \mathcal{I}\left(\mathfrak{p}^{\prime}\right)$. Let $\vartheta \in B_{\mathfrak{p}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{p}^{\prime}\right), m\right)$. Then we have by the triangle inequality

$$
d_{\mathfrak{p}}(\mathcal{Q}(\mathfrak{p}), \vartheta) \leq d_{\mathfrak{p}}\left(\mathcal{Q}(\mathfrak{p}), \mathcal{Q}\left(\mathfrak{p}^{\prime}\right)\right)+d_{\mathfrak{p}}\left(\mathcal{Q}\left(\mathfrak{p}^{\prime}\right), \vartheta\right)
$$

Using (5.70) and (2.24) for the first summand, and Lemma 2.8 for the second summand, this is estimated by

$$
n+2^{-95 a} d_{\mathfrak{p}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{p}^{\prime}\right), \vartheta\right)<n+2^{-95 a} m
$$

Thus $B_{\mathfrak{p}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{p}^{\prime}\right), m\right) \subset B_{\mathfrak{p}}\left(\mathcal{Q}(\mathfrak{p}), n+2^{-95 a} m\right)$. Combined with $\mathcal{I}(\mathfrak{p}) \subset \mathcal{I}\left(\mathfrak{p}^{\prime}\right)$, this yields (5.71).
Lemma 5.16 (wiggle order 3). The following implications hold for all $\mathfrak{q}, \mathfrak{q}^{\prime} \in$ $\mathfrak{P}$ :

\mathfrak{q} \lesssim \mathfrak{q}^{\prime} \text { and } \lambda \geq 1 \Longrightarrow \lambda \mathfrak{q} \lesssim \lambda \mathfrak{q}^{\prime},  \tag{5.72}\\
10 \mathfrak{q} \lesssim \mathfrak{q}^{\prime} \text { and } \mathfrak{q} \neq \mathfrak{q}^{\prime} \Longrightarrow 100 \mathfrak{q} \lesssim 100 \mathfrak{q}^{\prime},  \tag{5.73}\\
2 \mathfrak{q} \lesssim \mathfrak{q}^{\prime} \text { and } \mathfrak{q} \neq \mathfrak{q}^{\prime} \Longrightarrow 4 \mathfrak{q} \lesssim 500 \mathfrak{q}^{\prime} . \tag{5.74}
\end{gather*}
$$

Proof. All three implications are easy consequences of Lemma 5.14, Lemma 5.15 and the fact that $a \geq 4$.

We call a collection $\mathfrak{A}$ of tiles convex if

$$
\begin{equation*}
\mathfrak{p} \leq \mathfrak{p}^{\prime} \leq \mathfrak{p}^{\prime \prime} \text { and } \mathfrak{p}, \mathfrak{p}^{\prime \prime} \in \mathfrak{A} \Longrightarrow \mathfrak{p}^{\prime} \in \mathfrak{A} \tag{5.75}
\end{equation*}
$$

Lemma 5.17 (P convex). For each $k$, the collection $\mathfrak{P}(k)$ is convex.
Proof. Suppose that $\mathfrak{p} \leq \mathfrak{p}^{\prime} \leq \mathfrak{p}^{\prime \prime}$ and $\mathfrak{p}, \mathfrak{p}^{\prime \prime} \in \mathfrak{P}(k)$. By (5.3) we have $\mathcal{I}(\mathfrak{p}), \mathcal{I}\left(\mathfrak{p}^{\prime \prime}\right) \in \mathcal{C}(G, k)$, so there exists by (5.1) some $J \in \mathcal{D}$ with

$$
\mathcal{I}\left(\mathfrak{p}^{\prime}\right) \subset \mathcal{I}\left(\mathfrak{p}^{\prime \prime}\right) \subset J
$$

and $\mu(G \cap J)>2^{-k-1} \mu(J)$. Thus (5.1) holds for $\mathcal{I}\left(\mathfrak{p}^{\prime}\right)$. On the other hand, by (5.2), there exists no $J \in \mathcal{D}$ with $\mathcal{I}(\mathfrak{p}) \subset J$ and $\mu(G \cap J)>2^{-k} \mu(J)$. Since $\mathcal{I}(\mathfrak{p}) \subset \mathcal{I}\left(\mathfrak{p}^{\prime}\right)$, this implies that (5.2) holds for $\mathcal{I}\left(\mathfrak{p}^{\prime}\right)$. Hence $\mathcal{I}\left(\mathfrak{p}^{\prime}\right) \in \mathcal{C}(G, k)$, and therefore by (5.3) $\mathfrak{p}^{\prime} \in \mathfrak{P}(k)$.
Lemma 5.18 (C convex). For each $k, n$, the collection $\mathfrak{C}(k, n)$ is convex.
Proof. Let $\mathfrak{p} \leq \mathfrak{p}^{\prime} \leq \mathfrak{p}^{\prime \prime}$ with $\mathfrak{p}, \mathfrak{p}^{\prime \prime} \in \mathfrak{C}(k, n)$. Then, in particular, $\mathfrak{p}, \mathfrak{p}^{\prime \prime} \in$ $\mathfrak{P}(k)$, so, by Lemma $5.17, \mathfrak{p}^{\prime} \in \mathfrak{P}(k)$. Next, we show that if $\mathfrak{q} \leq \mathfrak{q}^{\prime} \in \mathfrak{P}(k)$ then $\operatorname{dens}_{k}^{\prime}(\{\mathfrak{q}\}) \geq \operatorname{dens}_{k}^{\prime}\left(\left\{\mathfrak{q}^{\prime}\right\}\right)$. If $\mathfrak{p} \in \mathfrak{P}(k)$ and $\lambda \geq 2$ with $\lambda \mathfrak{q}^{\prime} \lesssim \lambda \mathfrak{p}$, then it follows from $\mathfrak{q} \leq \mathfrak{q}^{\prime}$, (5.72) of Lemma 5.16 and transitivity of $\lesssim$ that $\lambda \mathfrak{q} \lesssim \lambda \mathfrak{p}$. Thus the supremum in the definition (5.6) of $\operatorname{dens}_{k}^{\prime}(\{\mathfrak{q}\})$ is over a superset of the set the supremum in the definition of $\operatorname{dens}_{k}^{\prime}\left(\left\{\mathfrak{q}^{\prime}\right\}\right)$ is taken over, which shows $\operatorname{dens}_{k}^{\prime}(\{\mathfrak{q}\}) \geq \operatorname{dens}_{k}^{\prime}\left(\left\{\mathfrak{q}^{\prime}\right\}\right)$. From $\mathfrak{p}^{\prime} \leq \mathfrak{p}^{\prime \prime}, \mathfrak{p}^{\prime \prime} \in \mathfrak{C}(k, n)$ and (5.7) it then follows that

$$
2^{4 a} 2^{-n}<\operatorname{dens}_{k}^{\prime}\left(\left\{\mathfrak{p}^{\prime \prime}\right\}\right) \leq \operatorname{dens}_{k}^{\prime}\left(\left\{\mathfrak{p}^{\prime}\right\}\right)
$$

Similarly, it follows from $\mathfrak{p} \leq \mathfrak{p}^{\prime}, \mathfrak{p} \in \mathfrak{C}(k, n)$ and (5.7) that

$$
\operatorname{dens}_{k}^{\prime}\left(\left\{\mathfrak{p}^{\prime}\right\}\right) \leq \operatorname{dens}_{k}^{\prime}(\{\mathfrak{p}\}) \leq 2^{4 a} 2^{-n+1}
$$

Thus $\mathfrak{p}^{\prime} \in \mathfrak{C}(k, n)$.
Lemma 5.19 (C1 convex). For each $k, n, j$, the collection $\mathfrak{C}_{1}(k, n, j)$ is convex.
Proof. Let $\mathfrak{p} \leq \mathfrak{p}^{\prime} \leq \mathfrak{p}^{\prime \prime}$ with $\mathfrak{p}, \mathfrak{p}^{\prime \prime} \in \mathfrak{C}_{1}(k, n, j)$. By Lemma 5.18 and the inclusion $\mathfrak{C}_{1}(k, n, j) \subset \mathfrak{C}(k, n)$, which holds by definition (5.9), we have $\mathfrak{p}^{\prime} \in$ $\mathfrak{C}(k, n)$. By (5.72) and transitivity of $\lesssim$ we have that $\mathfrak{q} \leq \mathfrak{q}^{\prime}$ and $100 \mathfrak{q}^{\prime} \lesssim \mathfrak{m}$ imply $100 \mathfrak{q} \lesssim \mathfrak{m}$. So, by (5.8), $\mathfrak{B}\left(\mathfrak{p}^{\prime \prime}\right) \subset \mathfrak{B}\left(\mathfrak{p}^{\prime}\right) \subset \mathfrak{B}(\mathfrak{p})$. Consequently, by (5.9)

$$
2^{j} \leq\left|\mathfrak{B}\left(\mathfrak{p}^{\prime \prime}\right)\right| \leq\left|\mathfrak{B}\left(\mathfrak{p}^{\prime}\right)\right| \leq|\mathfrak{B}(\mathfrak{p})|<2^{j+1},
$$

thus $\mathfrak{p}^{\prime} \in \mathfrak{C}_{1}(k, n, j)$.
Lemma 5.20 (C2 convex). For each $k, n, j$, the collection $\mathfrak{C}_{2}(k, n, j)$ is convex.

Proof. Let $\mathfrak{p} \leq \mathfrak{p}^{\prime} \leq \mathfrak{p}^{\prime \prime}$ with $\mathfrak{p}, \mathfrak{p}^{\prime \prime} \in \mathfrak{C}_{2}(k, n, j)$. By (5.13), we have

$$
\mathfrak{C}_{2}(k, n, j) \subset \mathfrak{C}_{1}(k, n, j) .
$$

Combined with Lemma 5.19, it follows that $\mathfrak{p}^{\prime} \in \mathfrak{C}_{1}(k, n, j)$. Suppose that $\mathfrak{p}^{\prime} \notin \mathfrak{C}_{2}(k, n, j)$. By (5.13), this implies that there exists $0 \leq l^{\prime} \leq Z(n+1)$ with $\mathfrak{p}^{\prime} \in \mathfrak{L}_{1}\left(k, n, j, l^{\prime}\right)$. By the definition (5.11) of $\mathfrak{L}_{1}\left(k, n, j, l^{\prime}\right)$, this implies that $\mathfrak{p}$ is minimal with respect to $\leq$ in $\mathfrak{C}_{1}(k, n, j) \backslash \bigcup_{l<l^{\prime}} \mathfrak{L}_{1}(k, n, j, l)$. Since $\mathfrak{p} \in \mathfrak{C}_{2}(k, n, j)$ we must have $\mathfrak{p} \neq \mathfrak{p}^{\prime}$. Thus $\mathfrak{p} \leq \mathfrak{p}^{\prime}$ and $\mathfrak{p} \neq \mathfrak{p}^{\prime}$. By minimality
of $\mathfrak{p}^{\prime}$ it follows that $\mathfrak{p} \notin \mathfrak{C}_{1}(k, n, j) \backslash \bigcup_{l<l^{\prime}} \mathfrak{L}_{1}(k, n, j, l)$. But by (5.13) this implies $\mathfrak{p} \notin \mathfrak{C}_{2}(k, n, j)$, a contradiction.
Lemma 5.21 (C3 convex). For each $k, n, j$, the collection $\mathfrak{C}_{3}(k, n, j)$ is convex.
Proof. Let $\mathfrak{p} \leq \mathfrak{p}^{\prime} \leq \mathfrak{p}^{\prime \prime}$ with $\mathfrak{p}, \mathfrak{p}^{\prime \prime} \in \mathfrak{C}_{3}(k, n, j)$. By (5.16) and Lemma 5.20 it follows that $\mathfrak{p}^{\prime} \in \mathfrak{C}_{2}(k, n, j)$. Suppose that $\mathfrak{p}^{\prime} \notin \mathfrak{C}_{3}(k, n, j)$. Then, by (5.16) and (5.15), there exists $\mathfrak{u} \in \mathfrak{U}_{1}(k, n, j)$ with $2 \mathfrak{p}^{\prime} \lesssim \mathfrak{u}$ and $\mathcal{I}\left(\mathfrak{p}^{\prime}\right) \neq \mathcal{I}(\mathfrak{u})$. Together this gives $\mathcal{I}\left(\mathfrak{p}^{\prime}\right) \subsetneq \mathcal{I}(\mathfrak{u})$. From $\mathfrak{p}^{\prime} \leq \mathfrak{p},(5.72)$ and transitivity of $\lesssim$ we then have $2 \mathfrak{p} \lesssim \mathfrak{u}$. Also, $\mathcal{I}(\mathfrak{p}) \subset \mathcal{I}\left(\mathfrak{p}^{\prime}\right) \subsetneq \mathcal{I}(\mathfrak{u})$, so $\mathcal{I}(\mathfrak{p}) \neq \mathcal{I}(\mathfrak{u})$. But then $\mathfrak{p} \in \mathfrak{L}_{2}(k, n, j)$, contradicting by (5.16) the assumption $\mathfrak{p} \in \mathfrak{C}_{3}(k, n, j)$.

Lemma 5.22 (C4 convex). For each $k, n, j$, the collection $\mathfrak{C}_{4}(k, n, j)$ is convex.
Proof. Let $\mathfrak{p} \leq \mathfrak{p}^{\prime} \leq \mathfrak{p}^{\prime \prime}$ with $\mathfrak{p}, \mathfrak{p}^{\prime \prime} \in \mathfrak{C}_{4}(k, n, j)$. As before we obtain from the inclusion $\mathfrak{C}_{4}(k, n, j) \subset \mathfrak{C}_{3}(k, n, j)$ and Lemma 5.21 that $\mathfrak{p}^{\prime} \in \mathfrak{C}_{3}(k, n, j)$. Thus, if $\mathfrak{p}^{\prime} \notin \mathfrak{C}_{4}(k, n, j)$ then by (5.17) there exists $l$ such that $\mathfrak{p}^{\prime} \in \mathfrak{L}_{3}(k, n, j, l)$. Thus $\mathfrak{p}^{\prime}$ is maximal with respect to $\leq$ in $\mathfrak{C}_{3}(k, n, j) \backslash \bigcup_{0 \leq l^{\prime}<l} \mathfrak{L}_{3}\left(k, n, j, l^{\prime}\right)$. Since $\mathfrak{p}^{\prime \prime} \in \mathfrak{C}_{4}(k, n, j)$ we must have $\mathfrak{p}^{\prime} \neq \mathfrak{p}^{\prime \prime}$. Thus $\mathfrak{p}^{\prime} \leq \mathfrak{p}^{\prime \prime}$ and $\mathfrak{p}^{\prime} \neq \mathfrak{p}^{\prime \prime}$. By minimality of $\mathfrak{p}^{\prime}$ it follows that $\mathfrak{p}^{\prime \prime} \notin \mathfrak{C}_{3}(k, n, j) \backslash \bigcup_{l<l^{\prime}} \mathfrak{L}_{3}(k, n, j, l)$. But by (5.19) this implies $\mathfrak{p}^{\prime \prime} \notin \mathfrak{C}_{4}(k, n, j)$, a contradiction.

Lemma 5.23 (C5 convex). For each $k, n, j$, the collection $\mathfrak{C}_{5}(k, n, j)$ is convex.

Proof. Let $\mathfrak{p} \leq \mathfrak{p}^{\prime} \leq \mathfrak{p}^{\prime \prime}$ with $\mathfrak{p}, \mathfrak{p}^{\prime \prime} \in \mathfrak{C}_{5}(k, n, j)$. Then $\mathfrak{p}, \mathfrak{p}^{\prime \prime} \in \mathfrak{C}_{4}(k, n, j)$ by (5.23), and thus by Lemma 5.22 also $\mathfrak{p}^{\prime} \in \mathfrak{C}_{4}(k, n, j)$. Suppose that $\mathfrak{p}^{\prime} \notin \mathfrak{C}_{5}(k, n, j)$. By (5.23), it follows that $\mathfrak{p}^{\prime} \in \mathfrak{L}_{4}(k, n, j)$. By (5.22), there exists $\mathfrak{u} \in \mathfrak{U}_{1}(k, n, j)$ with $\mathcal{I}\left(\mathfrak{p}^{\prime}\right) \subset \bigcup \mathcal{L}(\mathfrak{u})$. Then also $\mathcal{I}(\mathfrak{p}) \subset \bigcup \mathcal{L}(\mathfrak{u})$, a contradiction.
Lemma 5.24 (dens compare). We have for every $k \geq 0$ and $\mathfrak{P}^{\prime} \subset \mathfrak{P}(k)$

$$
\begin{equation*}
\operatorname{dens}_{1}\left(\mathfrak{P}^{\prime}\right) \leq \operatorname{dens}_{k}^{\prime}\left(\mathfrak{P}^{\prime}\right) . \tag{5.76}
\end{equation*}
$$

Proof. It suffices to show that for all $\mathfrak{p}^{\prime} \in \mathfrak{P}^{\prime}$ and $\lambda \geq 2$ and $\mathfrak{p} \in \mathfrak{P}\left(\mathfrak{P}^{\prime}\right)$ with $\lambda \mathfrak{p}^{\prime} \lesssim \lambda \mathfrak{p}$ we have

$$
\begin{equation*}
\frac{\mu\left(E_{2}(\lambda, \mathfrak{p})\right)}{\mu(\mathcal{I}(\mathfrak{p}))} \leq \sup _{\mathfrak{p}^{\prime \prime} \in \mathfrak{P}(k): \lambda \mathfrak{p}^{\prime} \lesssim \lambda \mathfrak{p}^{\prime \prime}} \frac{\mu\left(E_{2}\left(\lambda, \mathfrak{p}^{\prime \prime}\right)\right)}{\mu\left(\mathcal{I}\left(\mathfrak{p}^{\prime \prime}\right)\right)} . \tag{5.77}
\end{equation*}
$$

Let such $\mathfrak{p}^{\prime}, \lambda, \mathfrak{p}$ be given. It suffices to show that $\mathfrak{p} \in \mathfrak{P}(k)$, that is, it satisfies (5.1) and (5.2).
We show (5.1). As $\mathfrak{p} \in \mathfrak{P}\left(\mathfrak{P}^{\prime}\right)$, there exists $\mathfrak{p}^{\prime \prime} \in \mathfrak{P}^{\prime}$ with $\mathcal{I}\left(\mathfrak{p}^{\prime}\right) \subset \mathcal{I}\left(\mathfrak{p}^{\prime \prime}\right)$. By assumption on $\mathfrak{P}^{\prime}$, we have $\mathfrak{p}^{\prime \prime} \in \mathfrak{P}(k)$ and there exists $J \in \mathcal{D}$ with $\mathcal{I}\left(\mathfrak{p}^{\prime \prime}\right) \subset J$ and

$$
\begin{equation*}
\mu(G \cap J)>2^{-k-1} \mu(J) . \tag{5.78}
\end{equation*}
$$

Then also $\mathcal{I}\left(\mathfrak{p}^{\prime}\right) \subset J$, which proves (5.1) for $\mathfrak{p}$.
We show (5.2). Assume to get a contradiction that there exists $J \in \mathcal{D}$ with $\mathcal{I}(\mathfrak{p}) \subset J$ and

$$
\begin{equation*}
\mu(G \cap J)>2^{-k} \mu(J) \tag{5.79}
\end{equation*}
$$

As $\lambda \mathfrak{p}^{\prime} \lesssim \lambda \mathfrak{p}$, we have $\mathcal{I}\left(\mathfrak{p}^{\prime}\right) \subset \mathcal{I}(\mathfrak{p})$, and therefore $\mathcal{I}\left(\mathfrak{p}^{\prime}\right) \subset J$. This contradicts $\mathfrak{p}^{\prime} \in \mathfrak{P}^{\prime} \subset \mathfrak{P}(k)$. This proves (5.2) for $\mathfrak{p}$.

Lemma 5.25 (C dens1). For each set $\mathfrak{A} \subset \mathfrak{C}(k, n)$, we have

$$
\operatorname{dens}_{1}(\mathfrak{A}) \leq 2^{4 a} 2^{-n+1}
$$

Proof. We have by Lemma 5.24 that $\operatorname{dens}_{1}(\mathfrak{A}) \leq \operatorname{dens}_{k}^{\prime}(\mathfrak{A})$. Since $\mathfrak{A} \subset$ $\mathfrak{C}(k, n)$, it follows from monotonicity of suprema and the definition (5.6) that $\operatorname{dens}_{k}^{\prime}(\mathfrak{A}) \leq \operatorname{dens}_{k}^{\prime}(\mathfrak{C}(k, n))$. By (5.6) and (5.7), we have

$$
\operatorname{dens}_{k}^{\prime}(\mathfrak{C}(k, n))=\sup _{\mathfrak{p} \in \mathfrak{C}(k, n)} \operatorname{dens}_{k}^{\prime}(\{\mathfrak{p}\}) \leq 2^{4 a} 2^{-n+1}
$$

### 5.4. Proof of Lemma 5.2, the forests. Fix $k, n, j \geq 0$. Define

$$
\mathfrak{C}_{6}(k, n, j)
$$

to be the set of all tiles $\mathfrak{p} \in \mathfrak{C}_{5}(k, n, j)$ such that $\mathcal{I}(\mathfrak{p}) \not \subset G^{\prime}$. The following chain of lemmas establishes that the set $\mathfrak{C}_{6}(k, n, j)$ can be written as a union of a small number of $n$-forests.

For $\mathfrak{u} \in \mathfrak{U}_{1}(k, n, j)$, define

$$
\begin{equation*}
\mathfrak{T}_{1}(\mathfrak{u}):=\left\{\mathfrak{p} \in \mathfrak{C}_{1}(k, n, j): \mathcal{I}(\mathfrak{p}) \neq \mathcal{I}(\mathfrak{u}), 2 \mathfrak{p} \lesssim \mathfrak{u}\right\} \tag{5.80}
\end{equation*}
$$

Define

$$
\begin{equation*}
\mathfrak{U}_{2}(k, n, j):=\left\{\mathfrak{u} \in \mathfrak{U}_{1}(k, n, j): \mathfrak{T}_{1}(\mathfrak{u}) \cap \mathfrak{C}_{6}(k, n, j) \neq \emptyset\right\} \tag{5.81}
\end{equation*}
$$

Define a relation $\sim$ on $\mathfrak{U}_{2}(k, n, j)$ by setting $\mathfrak{u} \sim \mathfrak{u}^{\prime}$ for $\mathfrak{u}, \mathfrak{u}^{\prime} \in \mathfrak{U}_{2}(k, n, j)$ if $\mathfrak{u}=\mathfrak{u}^{\prime}$ or there exists $\mathfrak{p}$ in $\mathfrak{T}_{1}(\mathfrak{u})$ with $10 \mathfrak{p} \lesssim \mathfrak{u}^{\prime}$.

Lemma 5.26 (relation geometry). If $\mathfrak{u} \sim \mathfrak{u}^{\prime}$, then $\mathcal{I}(u)=\mathcal{I}\left(u^{\prime}\right)$ and

$$
B_{\mathfrak{u}}(\mathcal{Q}(\mathfrak{u}), 100) \cap B_{\mathfrak{u}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{u}^{\prime}\right), 100\right) \neq \emptyset
$$

Proof. Let $\mathfrak{u}, \mathfrak{u}^{\prime} \in \mathfrak{U}_{2}(k, n, j)$ with $\mathfrak{u} \sim \mathfrak{u}^{\prime}$. If $\mathfrak{u}=\mathfrak{u}^{\prime}$ then the conclusion of the Lemma clearly holds. Else, there exists $\mathfrak{p} \in \mathfrak{C}_{1}(k, n, j)$ such that $\mathcal{I}(\mathfrak{p}) \neq \mathcal{I}(\mathfrak{u})$ and $2 \mathfrak{p} \lesssim \mathfrak{u}$ and $10 \mathfrak{p} \lesssim \mathfrak{u}^{\prime}$. Using Lemma 5.14 and (5.73) of Lemma 5.16, we deduce that

$$
\begin{equation*}
100 \mathfrak{p} \lesssim 100 \mathfrak{u}, \quad 100 \mathfrak{p} \lesssim 100 \mathfrak{u}^{\prime} \tag{5.82}
\end{equation*}
$$

Now suppose that $B_{\mathfrak{u}}(\mathcal{Q}(\mathfrak{u}), 100) \cap B_{\mathfrak{u}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{u}^{\prime}\right), 100\right)=\emptyset$. Then we have $\mathfrak{B}(\mathfrak{u}) \cap$ $\mathfrak{B}\left(\mathfrak{u}^{\prime}\right)=\emptyset$, by the definition (5.8) of $\mathfrak{B}$ and the definition (2.24) of $\lesssim$, but also $\mathfrak{B}(\mathfrak{u}) \subset \mathfrak{B}(\mathfrak{p})$ and $\mathfrak{B}\left(\mathfrak{u}^{\prime}\right) \subset \mathfrak{B}(\mathfrak{p})$, by (5.8), (2.24) and (5.82) Hence,

$$
|\mathfrak{B}(\mathfrak{p})| \geq|\mathfrak{B}(\mathfrak{u})|+\left|\mathfrak{B}\left(\mathfrak{u}^{\prime}\right)\right| \geq 2^{j}+2^{j}=2^{j+1}
$$

which contradicts $\mathfrak{p} \in \mathfrak{C}_{1}(k, n, j)$. Therefore we must have

$$
B_{\mathfrak{u}}(\mathcal{Q}(\mathfrak{u}), 100) \cap B_{\mathfrak{u}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{u}^{\prime}\right), 100\right) \neq \emptyset
$$

It follows from $2 \mathfrak{p} \lesssim \mathfrak{u}$ and $10 \mathfrak{p} \lesssim \mathfrak{u}^{\prime}$ that $\mathcal{I}(\mathfrak{p}) \subset \mathcal{I}(\mathfrak{u})$ and $\mathcal{I}(\mathfrak{p}) \subset \mathcal{I}\left(\mathfrak{u}^{\prime}\right)$. By (2.8), it follows that $\mathcal{I}(\mathfrak{u})$ and $\mathcal{I}\left(\mathfrak{u}^{\prime}\right)$ are nested. Combining this with the conclusion of the last paragraph and definition (5.14) of $\mathfrak{U}_{1}(k, n, j)$, we obtain that $\mathcal{I}(\mathfrak{u})=\mathcal{I}\left(\mathfrak{u}^{\prime}\right)$.

Lemma 5.27 (equivalence relation). For each $k, n, j$, the relation $\sim$ on $\mathfrak{U}_{2}(k, n, j)$ is an equivalence relation.

Proof. Reflexivity holds by definition. For transitivity, suppose that

$$
\mathfrak{u}, \mathfrak{u}^{\prime}, \mathfrak{u}^{\prime \prime} \in \mathfrak{U}_{1}(k, n, j)
$$

and $\mathfrak{u} \sim \mathfrak{u}^{\prime}, \mathfrak{u}^{\prime} \sim \mathfrak{u}^{\prime \prime}$. By Lemma 5.26, it follows that $\mathcal{I}(\mathfrak{u})=\mathcal{I}\left(\mathfrak{u}^{\prime}\right)=\mathcal{I}\left(\mathfrak{u}^{\prime \prime}\right)$, that there exists

$$
\vartheta \in B_{\mathfrak{u}}(\mathcal{Q}(\mathfrak{u}), 100) \cap B_{\mathfrak{u}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{u}^{\prime}\right), 100\right)
$$

and that there exists

$$
\theta \in B_{\mathfrak{u}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{u}^{\prime}\right), 100\right) \cap B_{\mathfrak{u}^{\prime \prime}}\left(\mathcal{Q}\left(\mathfrak{u}^{\prime \prime}\right), 100\right)
$$

If $\mathfrak{u}=\mathfrak{u}^{\prime}$, then $\mathfrak{u} \sim \mathfrak{u}^{\prime \prime}$ holds by assumption. Else, there exists by the definition of $\sim$ some $\mathfrak{p} \in \mathfrak{T}_{1}(\mathfrak{u})$ with $10 \mathfrak{p} \lesssim \mathfrak{u}^{\prime}$. Then we have $2 \mathfrak{p} \lesssim \mathfrak{u}$ and $\mathfrak{p} \neq \mathfrak{u}$ by definition of $\mathfrak{T}_{1}(\mathfrak{u})$, so $4 \mathfrak{p} \lesssim 500 \mathfrak{u}$ by (5.74). For $q \in B_{\mathfrak{u}^{\prime \prime}}\left(\widetilde{\mathcal{Q}}\left(\mathfrak{u}^{\prime \prime}\right), 1\right)$ it follows by the triangle inequality that

$$
\begin{aligned}
d_{\mathfrak{u}}(\mathcal{Q}(\mathfrak{u}), q) \leq & d_{\mathfrak{u}}(\mathcal{Q}(\mathfrak{u}), \vartheta)+d_{\mathfrak{u}}\left(\vartheta, \mathcal{Q}\left(\mathfrak{u}^{\prime}\right)\right) \\
& +d_{\mathfrak{u}}\left(\mathcal{Q}\left(\mathfrak{u}^{\prime}\right), \theta\right)+d_{\mathfrak{u}}\left(\theta, \mathcal{Q}\left(\mathfrak{u}^{\prime \prime}\right)\right)+d_{\mathfrak{u}}\left(\mathcal{Q}\left(\mathfrak{u}^{\prime \prime}\right), q\right)
\end{aligned}
$$

Using (2.17) and the fact that $\mathcal{I}(\mathfrak{u})=\mathcal{I}\left(\mathfrak{u}^{\prime}\right)=\mathcal{I}\left(\mathfrak{u}^{\prime \prime}\right)$ this equals

$$
\begin{aligned}
& \quad d_{\mathfrak{u}}(\mathcal{Q}(\mathfrak{u}), \vartheta)+d_{\mathfrak{u}^{\prime}}\left(\vartheta, \mathcal{Q}\left(\mathfrak{u}^{\prime}\right)\right) \\
& \quad+d_{\mathfrak{u}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{u}^{\prime}\right), \theta\right)+d_{\mathfrak{u}^{\prime \prime}}\left(\theta, \mathcal{Q}\left(\mathfrak{u}^{\prime \prime}\right)\right)+d_{\mathfrak{u}^{\prime \prime}}\left(\mathcal{Q}\left(\mathfrak{u}^{\prime \prime}\right), q\right) \\
& <100+100+100+100+1<500
\end{aligned}
$$

Since $4 \mathfrak{p} \lesssim 500 \mathfrak{u}$, it follows that $d_{\mathfrak{p}}(\mathcal{Q}(\mathfrak{p}), q)<4<10$. We have shown that $B_{\mathfrak{u}^{\prime \prime}}\left(\mathcal{Q}\left(\mathfrak{u}^{\prime \prime}\right), 1\right) \subset B_{\mathfrak{p}}(\mathcal{Q}(\mathfrak{p}), 10)$, combining this with $\mathcal{I}\left(\mathfrak{u}^{\prime \prime}\right)=\mathcal{I}(\mathfrak{u})$ gives $\mathfrak{u} \sim \mathfrak{u}^{\prime \prime}$.

For symmetry suppose that $\mathfrak{u} \sim \mathfrak{u}^{\prime}$. By Lemma (5.26), it follows that $\mathcal{I}(\mathfrak{u})=\mathcal{I}\left(\mathfrak{u}^{\prime}\right)$ and that there exists $\vartheta \in B_{\mathfrak{u}}(\mathcal{Q}(\mathfrak{u}), 100) \cap B_{\mathfrak{u}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{u}^{\prime}\right), 100\right)$. Again, for $\mathfrak{u}=\mathfrak{u}^{\prime}$ symmetry is obvious. If $\mathfrak{u} \neq \mathfrak{u}^{\prime}$, then there exists $\mathfrak{p} \in \mathfrak{T}_{1}\left(\mathfrak{u}^{\prime}\right)$ with $10 \mathfrak{p} \lesssim \mathfrak{u}$. By definition of $\mathfrak{T}_{1}\left(\mathfrak{u}^{\prime}\right)$, Lemma 5.14 and (5.74), it follows that

$$
\begin{equation*}
10 \mathfrak{p} \lesssim 4 \mathfrak{p} \lesssim 500 \mathfrak{u}^{\prime} \tag{5.83}
\end{equation*}
$$

If $q \in B_{\mathfrak{u}}(\mathcal{Q}(\mathfrak{u}), 1)$ then we have from the triangle inequality and the fact that $\mathcal{I}(\mathfrak{u})=\mathcal{I}\left(\mathfrak{u}^{\prime}\right)$ :

$$
\begin{aligned}
d_{\mathfrak{u}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{u}^{\prime}\right), q\right) & \leq d_{\mathfrak{u}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{u}^{\prime}\right), \vartheta\right)+d_{\mathfrak{u}^{\prime}}(\vartheta, \mathcal{Q}(\mathfrak{u}))+d_{\mathfrak{u}^{\prime}}(\mathcal{Q}(\mathfrak{u}), q) \\
& =d_{\mathfrak{u}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{u}^{\prime}\right), \vartheta\right)+d_{\mathfrak{u}}(\vartheta, \mathcal{Q}(\mathfrak{u}))+d_{\mathfrak{u}}(\mathcal{Q}(\mathfrak{u}), q) \\
& <100+100+1<500 .
\end{aligned}
$$

Combining this with (5.83) and (2.24), we get

$$
B_{\mathfrak{u}}(\mathcal{Q}(\mathfrak{u}), 1) \subset B_{\mathfrak{p}}(\mathcal{Q}(\mathfrak{p}), 10)
$$

Since $2 \mathfrak{p} \lesssim \mathfrak{u}^{\prime}$, we have $\mathcal{I}(\mathfrak{p}) \subset \mathcal{I}\left(\mathfrak{u}^{\prime}\right)=\mathcal{I}(\mathfrak{u})$. Thus, $10 \mathfrak{p} \lesssim \mathfrak{u}$ which completes the proof of $\mathfrak{u}^{\prime} \sim \mathfrak{u}$.

Choose a set $\mathfrak{U}_{3}(k, n, j)$ of representatives for the equivalence classes of $\sim$ in $\mathfrak{U}_{2}(k, n, j)$. Define for each $\mathfrak{u} \in \mathfrak{U}_{3}(k, n, j)$

$$
\begin{equation*}
\mathfrak{T}_{2}(\mathfrak{u}):=\bigcup_{\mathfrak{u} \sim \mathfrak{u}^{\prime}} \mathfrak{T}_{1}\left(\mathfrak{u}^{\prime}\right) \cap \mathfrak{C}_{6}(k, n, j) \tag{5.84}
\end{equation*}
$$

Lemma 5.28 (C6 forest). We have

$$
\begin{equation*}
\mathfrak{C}_{6}(k, n, j)=\bigcup_{\mathfrak{u} \in \mathfrak{U}_{3}(k, n, j)} \mathfrak{T}_{2}(\mathfrak{u}) \tag{5.85}
\end{equation*}
$$

Proof. Let $\mathfrak{p} \in \mathfrak{C}_{6}(k, n, j)$. By (5.19) and (5.23), we have $\mathfrak{p} \in \mathfrak{C}_{3}(k, n, j)$. By (5.15) and (5.16), there exists $\mathfrak{u} \in \mathfrak{U}_{1}(k, n, j)$ with $2 \mathfrak{p} \lesssim \mathfrak{u}$ and $\mathcal{I}(\mathfrak{p}) \neq \mathcal{I}(\mathfrak{u})$, that is, with $\mathfrak{p} \in \mathfrak{T}_{1}(\mathfrak{u})$. Then $\mathfrak{T}_{1}(\mathfrak{u})$ is clearly nonempty, so $\mathfrak{u} \in \mathfrak{U}_{2}(k, n, j)$. By the definition of $\mathfrak{U}_{3}(k, n, j)$, there exists $\mathfrak{u}^{\prime} \in \mathfrak{U}_{3}(k, n, j)$ with $\mathfrak{u} \sim \mathfrak{u}^{\prime}$. By (5.84), we have $\mathfrak{p} \in \mathfrak{T}_{2}\left(\mathfrak{u}^{\prime}\right)$.

Lemma 5.29 (C6 convex). Let $\mathfrak{u} \in \mathfrak{U}_{3}(k, n, j)$. If $\mathfrak{p} \leq \mathfrak{p}^{\prime} \leq \mathfrak{p}^{\prime \prime}$ and $\mathfrak{p}, \mathfrak{p}^{\prime \prime} \in$ $\mathfrak{T}_{2}(\mathfrak{u})$, then $\mathfrak{p}^{\prime} \in \mathfrak{T}_{2}(\mathfrak{u})$.
Proof. Suppose that $\mathfrak{p}, \mathfrak{p}^{\prime \prime} \in \mathfrak{T}_{2}(\mathfrak{u})$. Then by Lemma 5.23 , we have $\mathfrak{p}^{\prime} \in$ $\mathfrak{C}_{5}(k, n, j)$. Since $\mathfrak{p} \in \mathfrak{C}_{6}(k, n, j)$ we have $\mathcal{I}(\mathfrak{p}) \not \subset G^{\prime}$, hence $\mathcal{I}\left(\mathfrak{p}^{\prime}\right) \not \subset G^{\prime}$. This implies $\mathfrak{p}^{\prime} \in \mathfrak{C}_{6}(k, n, j)$. Since $\mathfrak{p}^{\prime \prime} \in \mathfrak{T}_{2}(\mathfrak{u})$, we have $2 \mathfrak{p}^{\prime \prime} \lesssim \mathfrak{u}^{\prime}$ and $\mathcal{I}\left(\mathfrak{p}^{\prime \prime}\right) \neq$ $\mathcal{I}\left(\mathfrak{u}^{\prime}\right)$ for some $\mathfrak{u}^{\prime} \sim \mathfrak{p}^{\prime \prime}$. By (5.72), we have $2 \mathfrak{p}^{\prime} \lesssim 2 \mathfrak{p}^{\prime \prime}$, so by transitivity of $\lesssim$ we have $2 \mathfrak{p}^{\prime} \lesssim \mathfrak{u}^{\prime}$. Finally, $\mathcal{I}\left(\mathfrak{p}^{\prime}\right) \subset \mathcal{I}\left(\mathfrak{p}^{\prime \prime}\right)$ implies $\mathcal{I}\left(\mathfrak{p}^{\prime}\right) \neq \mathcal{I}\left(\mathfrak{u}^{\prime}\right)$, thus $\mathfrak{p}^{\prime} \in \mathfrak{T}_{1}\left(\mathfrak{u}^{\prime}\right) \subset \mathfrak{T}_{2}(\mathfrak{u})$.
Lemma 5.30 (forest geometry). For each $\mathfrak{u} \in \mathfrak{U}_{3}(k, n, j)$, the set $\mathfrak{T}_{2}(\mathfrak{u})$ satisfies (2.32).

Proof. Let $\mathfrak{p} \in \mathfrak{T}_{2}(\mathfrak{u})$. By (5.84), there exists $\mathfrak{u}^{\prime} \sim \mathfrak{u}$ with $\mathfrak{p} \in \mathfrak{T}_{1}\left(\mathfrak{u}^{\prime}\right)$. Then we have $2 \mathfrak{p} \lesssim \mathfrak{u}^{\prime}$ and $\mathcal{I}(\mathfrak{p}) \neq \mathcal{I}\left(\mathfrak{u}^{\prime}\right)$, so by (5.74) $4 \mathfrak{p} \lesssim 500 \mathfrak{u}^{\prime}$. Further, by Lemma 5.26 , we have that $\mathcal{I}\left(\mathfrak{u}^{\prime}\right)=\mathcal{I}(\mathfrak{u})$ and there exists $\vartheta \in$ $B_{\mathfrak{u}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{u}^{\prime}\right), 100\right) \cap B_{\mathfrak{u}}(\mathcal{Q}(\mathfrak{u}), 100)$. Let $\theta \in B_{\mathfrak{u}}(\mathcal{Q}(\mathfrak{u}), 1)$. Using the triangle inequality and the fact that $\mathcal{I}\left(\mathfrak{u}^{\prime}\right)=\mathcal{I}(\mathfrak{u})$, we obtain

d_{\mathfrak{u}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{u}^{\prime}\right), \theta\right) & \leq d_{\mathfrak{u}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{u}^{\prime}\right), \vartheta\right)+d_{\mathfrak{u}^{\prime}}(\mathcal{Q}(\mathfrak{u}), \vartheta)+d_{\mathfrak{u}^{\prime}}(\mathcal{Q}(\mathfrak{u}), \theta) \\
& =d_{\mathfrak{u}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{u}^{\prime}\right), \vartheta\right)+d_{\mathfrak{u}}(\mathcal{Q}(\mathfrak{u}), \vartheta)+d_{\mathfrak{u}}(\mathcal{Q}(\mathfrak{u}), \theta) \\
& <100+100+1<500
\end{aligned}
$$

Combining this with $4 \mathfrak{p} \lesssim 500 \mathfrak{u}^{\prime}$, we obtain

$$
B_{\mathfrak{u}}(\mathcal{Q}(\mathfrak{u}), 1) \subset B_{\mathfrak{u}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{u}^{\prime}\right), 500\right) \subset B_{\mathfrak{p}}(\mathcal{Q}(\mathfrak{p}), 4)
$$

Together with $\mathcal{I}(\mathfrak{p}) \subset \mathcal{I}\left(\mathfrak{u}^{\prime}\right)=\mathcal{I}(\mathfrak{u})$, this gives $4 \mathfrak{p} \lesssim 1 \mathfrak{u}$, which is (2.32).
Lemma 5.31 (forest convex). For each $\mathfrak{u} \in \mathfrak{U}_{3}(k, n, j)$, the set $\mathfrak{T}_{2}(\mathfrak{u})$ satisfies the convexity condition (2.33).
Proof. Let $\mathfrak{p}, \mathfrak{p}^{\prime \prime} \in \mathfrak{T}_{2}(\mathfrak{u})$ and $\mathfrak{p}^{\prime} \in \mathfrak{P}$ with $\mathfrak{p} \leq \mathfrak{p}^{\prime} \leq \mathfrak{p}^{\prime \prime}$. By (5.84) we have $\mathfrak{p}, \mathfrak{p}^{\prime \prime} \in \mathfrak{C}_{6}(k, n, j) \subset \mathfrak{C}_{5}(k, n, j)$. By Lemma 5.23 , we have $\mathfrak{p}^{\prime} \in \mathfrak{C}_{5}(k, n, j)$. Since $\mathfrak{p} \in \mathfrak{C}_{6}(k, n, j)$ we have $\mathcal{I}(\mathfrak{p}) \not \subset G^{\prime}$, so $\mathcal{I}\left(\mathfrak{p}^{\prime}\right) \not \subset G^{\prime}$ and therefore also $\mathfrak{p}^{\prime} \in \mathfrak{C}_{6}(k, n, j)$.

By (5.84) there exists $\mathfrak{u}^{\prime} \in \mathfrak{U}_{2}(k, n, j)$ with $\mathfrak{p}^{\prime \prime} \in \mathfrak{T}_{1}\left(\mathfrak{u}^{\prime}\right)$ and hence $2 \mathfrak{p}^{\prime \prime} \lesssim \mathfrak{u}^{\prime}$ and $\mathcal{I}\left(\mathfrak{p}^{\prime \prime}\right) \neq \mathcal{I}\left(\mathfrak{u}^{\prime}\right)$. Together this implies $\mathcal{I}\left(\mathfrak{p}^{\prime \prime}\right) \subsetneq \mathcal{I}\left(\mathfrak{u}^{\prime}\right)$. With the inclusion $\mathcal{I}\left(\mathfrak{p}^{\prime}\right) \subset \mathcal{I}\left(\mathfrak{p}^{\prime \prime}\right)$ from $\mathfrak{p}^{\prime} \leq \mathfrak{p}^{\prime \prime}$, it follows that $\mathcal{I}\left(\mathfrak{p}^{\prime}\right) \subsetneq \mathcal{I}\left(\mathfrak{u}^{\prime}\right)$ and hence $\mathcal{I}\left(\mathfrak{p}^{\prime}\right) \neq$ $\mathcal{I}\left(\mathfrak{u}^{\prime}\right)$. By (5.72) and transitivity of $\lesssim$ we further have $2 \mathfrak{p}^{\prime} \lesssim \mathfrak{u}^{\prime}$, so $\mathfrak{p}^{\prime} \in \mathfrak{T}_{1}\left(\mathfrak{u}^{\prime}\right)$. It follows that $\mathfrak{p}^{\prime} \in \mathfrak{T}_{2}(\mathfrak{u})$, which shows (2.33).
Lemma 5.32 (forest separation). For each $\mathfrak{u}, \mathfrak{u}^{\prime} \in \mathfrak{U}_{3}(k, n, j)$ with $\mathfrak{u} \neq \mathfrak{u}^{\prime}$ and each $\mathfrak{p} \in \mathfrak{T}_{2}(\mathfrak{u})$ with $\mathcal{I}(\mathfrak{p}) \subset \mathcal{I}\left(\mathfrak{u}^{\prime}\right)$ we have

$$
\begin{equation*}
d_{\mathfrak{p}}\left(\mathcal{Q}(\mathfrak{p}), \mathcal{Q}\left(\mathfrak{u}^{\prime}\right)\right)>2^{Z(n+1)} . \tag{5.86}
\end{equation*}
$$

Proof. By the definition (5.13) of $\mathfrak{C}_{2}(k, n, j)$, there exists a tile $\mathfrak{p}^{\prime} \in \mathfrak{C}_{1}(k, n, j)$ with $\mathfrak{p}^{\prime} \leq \mathfrak{p}$ and $\mathrm{s}\left(\mathfrak{p}^{\prime}\right)=\mathrm{s}(\mathfrak{p})-Z(n+1)$. By Lemma 2.8 we have

$$
d_{\mathfrak{p}}\left(\mathcal{Q}(\mathfrak{p}), \mathcal{Q}\left(\mathfrak{u}^{\prime}\right)\right) \geq 2^{95 a Z(n+1)} d_{\mathfrak{p}^{\prime}}\left(\mathcal{Q}(\mathfrak{p}), \mathcal{Q}\left(\mathfrak{u}^{\prime}\right)\right) .
$$

By (5.72) we have $2 \mathfrak{p}^{\prime} \lesssim 2 \mathfrak{p}$, so by transitivity of $\lesssim$ there exists $\mathfrak{v} \sim \mathfrak{u}$ with $2 \mathfrak{p}^{\prime} \lesssim \mathfrak{v}$ and $\mathcal{I}\left(\mathfrak{p}^{\prime}\right) \neq \mathcal{I}(\mathfrak{v})$. Since $\mathfrak{u}, \mathfrak{u}^{\prime}$ are not equivalent under $\sim$, we have $\mathfrak{v} \nsim \mathfrak{u}^{\prime}$, thus $10 \mathfrak{p}^{\prime} \mathbb{Z} \mathfrak{u}^{\prime}$. This implies that there exists $q \in B_{\mathfrak{u}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{u}^{\prime}\right), 1\right) \backslash$ $B_{p^{\prime}}\left(\mathcal{Q}\left(\mathfrak{p}^{\prime}\right), 10\right)$.
From $\mathfrak{p}^{\prime} \leq \mathfrak{p}, \mathcal{I}\left(\mathfrak{p}^{\prime}\right) \subset \mathcal{I}(\mathfrak{p}) \subset \mathcal{I}\left(\mathfrak{u}^{\prime}\right)$ and Lemma 2.8 it then follows that

$$
\begin{aligned}
& d_{\mathfrak{p}^{\prime}}\left(\mathcal{Q}(\mathfrak{p}), \mathcal{Q}\left(\mathfrak{u}^{\prime}\right)\right) \\
\geq & -d_{\mathfrak{p}^{\prime}}\left(\mathcal{Q}(\mathfrak{p}), \mathcal{Q}\left(\mathfrak{p}^{\prime}\right)\right)+d_{\mathfrak{p}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{p}^{\prime}\right), q\right)-d_{\mathfrak{p}^{\prime}}\left(q, \mathcal{Q}\left(\mathfrak{u}^{\prime}\right)\right) \\
\geq & -d_{\mathfrak{p}^{\prime}}\left(\mathcal{Q}(\mathfrak{p}), \mathcal{Q}\left(\mathfrak{p}^{\prime}\right)\right)+d_{\mathfrak{p}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{p}^{\prime}\right), q\right)-d_{\mathfrak{u}^{\prime}}\left(q, \mathcal{Q}\left(\mathfrak{u}^{\prime}\right)\right) \\
> & -1+10-1=8 .
\end{aligned}
$$

The lemma follows by combining the two displays with the fact that $95 a \geq$ 1.

Lemma 5.33 (forest inner). For each $\mathfrak{u} \in \mathfrak{U}_{3}(k, n, j)$ and each $\mathfrak{p} \in \mathfrak{T}_{2}(\mathfrak{u})$ we have

Proof. Let $\mathfrak{p} \in \mathfrak{T}_{2}(\mathfrak{u})$. Let

\begin{equation*}
\mathfrak{q} \in \bigcup_{\mathfrak{u} \sim \mathfrak{u}^{\prime}} \mathfrak{T}_{1}\left(\mathfrak{u}^{\prime}\right) \cap \mathfrak{C}_{3}(k, n, j) \tag{5.88}
\end{equation*}
$$

be a maximal element of this set with respect to $\leq$ such that $\mathfrak{p} \leq \mathfrak{q}$. We show that there is no $\mathfrak{q}^{\prime} \in \mathfrak{C}_{3}(k, n, j)$ with $\mathfrak{q} \leq \mathfrak{q}^{\prime}$ and $\mathfrak{q} \neq \mathfrak{q}^{\prime}$. Indeed, suppose $\mathfrak{q}^{\prime}$ was such a tile. By (5.16) there exists $\mathfrak{u}^{\prime \prime} \in \mathfrak{U}_{1}(k, n, j)$ with $2 \mathfrak{q}^{\prime} \lesssim \mathfrak{u}^{\prime \prime}$. Then we have in particular by Lemma 5.14 that $10 \mathfrak{p} \lesssim \mathfrak{u}^{\prime \prime}$. Let $\mathfrak{u}^{\prime} \sim \mathfrak{u}$ be such that $\mathfrak{p} \in \mathfrak{T}_{1}\left(\mathfrak{u}^{\prime}\right)$. By definition of $\sim$, we have $\mathfrak{u}^{\prime} \sim \mathfrak{u}^{\prime \prime}$, hence $\mathfrak{u} \sim \mathfrak{u}^{\prime \prime}$. This implies that $\mathfrak{q}^{\prime}$ is in the set in (5.88), contradicting maximality of $\mathfrak{q}$.

Let $\mathfrak{u}^{\prime} \sim \mathfrak{u}$ with $\mathfrak{q} \in \mathfrak{T}_{1}\left(\mathfrak{u}^{\prime}\right)$. By the definition (5.80) of $\mathfrak{T}_{1}$, we have $\mathrm{s}(\mathfrak{p})<\mathrm{s}\left(\mathfrak{u}^{\prime}\right)$. By Lemma 5.26, we have $\mathrm{s}(\mathfrak{u})=\mathrm{s}\left(\mathfrak{u}^{\prime}\right)$, hence $\mathrm{s}(\mathfrak{q})<\mathrm{s}(\mathfrak{u})$. By definition of $\mathfrak{C}_{4}(k, n, j), \mathfrak{p}$ is not in any of the maximal $Z(n+1)$ layers of tiles in $\mathfrak{C}_{3}(k, n, j)$, and hence $\mathrm{s}(\mathfrak{p}) \leq \mathrm{s}(\mathfrak{q})-Z(n+1) \leq \mathrm{s}(\mathfrak{u})-Z(n+1)-1$.

Thus, there exists some cube $I \in \mathcal{D}$ with $s(I)=\mathrm{s}(\mathfrak{u})-Z(n+1)-1$ and $I \subset \mathcal{I}(\mathfrak{u})$ and $\mathcal{I}(\mathfrak{p}) \subset I$. Since $\mathfrak{p} \in \mathfrak{C}_{5}(k, n, j)$, we have that $I \notin \mathcal{L}(\mathfrak{u})$, so $B\left(c(I), 8 D^{s(I)}\right) \subset \mathcal{I}(\mathfrak{u})$. By the triangle inequality, (2.1) and $a \geq 4$, the same then holds for the subcube $\mathcal{I}(\mathfrak{p}) \subset I$.

Lemma 5.34 (forest stacking). It holds that

Proof. Suppose that a point $x$ is contained in more than $1+(4 n+12) 2^{n}$ cubes $\mathcal{I}(\mathfrak{u})$ with $\mathfrak{u} \in \mathfrak{U}_{3}(k, n, j)$. Since $\mathfrak{U}_{3}(k, n, j) \subset \mathfrak{C}_{1}(k, n, j)$ for each such $\mathfrak{u}$, there exists $\mathfrak{m} \in \mathfrak{M}(k, n)$ such that $100 \mathfrak{u} \lesssim \mathfrak{m}$. We fix such an $\mathfrak{m}(\mathfrak{u}):=\mathfrak{m}$ for each $\mathfrak{u}$, and claim that the map $\mathfrak{u} \mapsto \mathfrak{m}(\mathfrak{u})$ is injective. Indeed, assume for $\mathfrak{u} \neq \mathfrak{u}^{\prime}$ there is $\mathfrak{m} \in \mathfrak{M}(k, n)$ such that $100 \mathfrak{u} \lesssim \mathfrak{m}$ and $100 \mathfrak{u}^{\prime} \lesssim \mathfrak{m}$. By (2.8), either $\mathcal{I}(\mathfrak{u}) \subset \mathcal{I}\left(\mathfrak{u}^{\prime}\right)$ or $\mathcal{I}\left(\mathfrak{u}^{\prime}\right) \subset \mathcal{I}(\mathfrak{u})$. By $(5.14), B_{\mathfrak{u}}(\mathcal{Q}(\mathfrak{u}), 100) \cap B_{\mathfrak{u}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{u}^{\prime}\right), 100\right)=$
$\emptyset$. This contradicts $\Omega(\mathfrak{m})$ being contained in both sets by (2.15). Thus $x$ is contained in more than $1+(4 n+12) 2^{n}$ cubes $\mathcal{I}(\mathfrak{m})$, $\mathfrak{m} \in \mathfrak{M}(k, n)$. Consequently, we have by (5.26) that $x \in A(2 n+6, k, n) \subset G_{2}$. Let $\mathcal{I}(\mathfrak{u})$ be an inclusion minimal cube among the $\mathcal{I}\left(\mathfrak{u}^{\prime}\right), \mathfrak{u}^{\prime} \in \mathfrak{U}_{3}(k, n, j)$ with $x \in \mathcal{I}(\mathfrak{u})$. By the dyadic property (2.8), we have $\mathcal{I}(\mathfrak{u}) \subset \mathcal{I}\left(\mathfrak{u}^{\prime}\right)$ for all cubes $\mathcal{I}\left(\mathfrak{u}^{\prime}\right)$ containing $x$. Thus

\mathcal{I}(\mathfrak{u}) \subset\left\{y: \sum_{\mathfrak{u} \in \mathfrak{U}_{3}(k, n, j)} \mathbf{1}_{\mathcal{I}(\mathfrak{u})}(y)>1+(4 n+12) 2^{n}\right\} \subset G_{2} .
$$

Thus $\mathfrak{T}_{1}(\mathfrak{u}) \cap \mathfrak{C}_{6}(k, n, j)=\emptyset$. This contradicts $\mathfrak{u} \in \mathfrak{U}_{2}(k, n, j)$.
Proof of Lemma 5.2. We first fix $k, n, j$. By (2.21) and (2.20), we have that $\mathbf{1}_{\mathcal{I}(\mathfrak{p})} T_{\mathfrak{p}} f(x)=T_{\mathfrak{p}} f(x)$ and hence $\mathbf{1}_{G \backslash G^{\prime}} T_{\mathfrak{p}} f(x)=0$ for all $\mathfrak{p} \in \mathfrak{C}_{5}(k, n, j) \backslash$ $\mathfrak{C}_{6}(k, n, j)$. Thus it suffices to estimate the contribution of the sets $\mathfrak{C}_{6}(k, n, j)$. By Lemma 5.34, we can decompose $\mathfrak{U}_{3}(k, n, j)$ as a disjoint union of at most $4 n+13$ collections $\mathfrak{U}_{4}(k, n, j, l), 1 \leq l \leq 4 n+13$, each satisfying

\sum_{\mathfrak{u} \in \mathfrak{U}_{4}(k, n, j, l)} \mathbf{1}_{\mathcal{I}(\mathfrak{u})} \leq 2^{n}
$$

By Lemmas $5.30,5.31,5.32,5.33$ and 5.25 , the pairs

$$
\left(\mathfrak{U}_{4}(k, n, j, l),\left.\mathfrak{T}_{2}\right|_{\mathfrak{U}_{4}(k, n, j, l)}\right)
$$

are $n$-forests for each $k, n, j, l$, and by Lemma 5.28 , we have

$$
\mathfrak{C}_{6}(k, n, j)=\bigcup_{l=1}^{4 n+13} \bigcup_{\mathfrak{u} \in \mathfrak{U}_{4}(k, n, j, l)} \mathfrak{T}_{2}(\mathfrak{u}) .
$$

Since $\mathcal{I}(\mathfrak{p}) \not \subset G_{1}$ for all $\mathfrak{p} \in \mathfrak{C}_{6}(k, n, j)$, we have $\mathfrak{C}_{6}(k, n, j) \cap \mathfrak{P}_{F, G}=\emptyset$ and hence

$$
\operatorname{dens}_{2}\left(\bigcup_{\mathfrak{u} \in \mathfrak{U}_{4}(k, n, j, l)} \mathfrak{T}_{2}(\mathfrak{u})\right) \leq 2^{2 a+5} \frac{\mu(F)}{\mu(G)}
$$

Using the triangle inequality according to the splitting by $k, n, j$ and $l$ in (5.31) and applying Proposition 2.4 to each term, we obtain the estimate

$$
\sum_{k \geq 0} \sum_{n \geq k}(2 n+3)(4 n+13) 2^{432 a^{3}} 2^{-\left(1-\frac{1}{q}\right) n}\left(2^{2 a+5} \frac{\mu(F)}{\mu(G)}\right)^{\frac{1}{q}-\frac{1}{2}}\|f\|_{2}\left\|\mathbf{1}_{G \backslash G^{\prime}}\right\|_{2}
$$

for the left hand side of (5.31). Since $|f| \leq \mathbf{1}_{F}$, we have $\|f\|_{2} \leq \mu(F)^{1 / 2}$, and we have $\left\|\mathbf{1}_{G \backslash G^{\prime}}\right\|_{2} \leq \mu(G)^{1 / 2}$. Combining this with $a \geq 4$, we estimate by

Interchanging the order of summation, the sum equals

which completes the proof of the lemma.

Lemma 5.35 (antichain decomposition). We have that

= & \bigcup_{k \geq 0} \bigcup_{n \geq k} \mathfrak{L}_{0}(k, n) \cap \mathfrak{P}_{X \backslash G^{\prime}}  \tag{5.91}\\
& \cup \bigcup_{k \geq 0} \bigcup_{n \geq k} \bigcup_{0 \leq j \leq 2 n+3} \mathfrak{L}_{2}(k, n, j) \cap \mathfrak{P}_{X \backslash G^{\prime}}  \tag{5.92}\\
& \cup \bigcup_{k \geq 0} \bigcup_{n \geq k} \bigcup_{0 \leq j \leq 2 n+3} \bigcup_{0 \leq l \leq Z(n+1)} \mathfrak{L}_{1}(k, n, j, l) \cap \mathfrak{P}_{X \backslash G^{\prime}}  \tag{5.93}\\
& \cup \bigcup_{k \geq 0} \bigcup_{n \geq k} \bigcup_{0 \leq j \leq 2 n+3} \bigcup_{0 \leq l \leq Z(n+1)} \mathfrak{L}_{3}(k, n, j, l) \cap \mathfrak{P}_{X \backslash G^{\prime}} . \tag{5.94}
\end{align*}
$$

Proof. Let $\mathfrak{p} \in \mathfrak{P}_{2} \cap \mathfrak{P}_{X \backslash G^{\prime}}$. Clearly, for every cube $J \in \mathcal{D}$ there exists some $k \geq 0$ such that (5.1) holds, and for no cube $J \in \mathcal{D}$ and no $k<0$ does (5.2) hold. Thus $\mathfrak{p} \in \mathfrak{P}(k)$ for some $k \geq 0$.

Next, since $E_{2}\left(\lambda, \mathfrak{p}^{\prime}\right) \subset \mathcal{I}\left(\mathfrak{p}^{\prime}\right) \cap G$ for every $\lambda \geq 2$ and every tile $\mathfrak{p}^{\prime} \in \mathfrak{P}(k)$ with $\lambda \mathfrak{p} \lesssim \lambda \mathfrak{p}^{\prime}$, it follows from (5.2) that $\mu\left(E_{2}\left(\lambda, \mathfrak{p}^{\prime}\right)\right) \leq 2^{-k} \mu\left(\mathcal{I}\left(\mathfrak{p}^{\prime}\right)\right)$ for every such $\mathfrak{p}^{\prime}$, so dens ${ }_{k}^{\prime}(\{\mathfrak{p}\}) \leq 2^{-k}$. Combining this with $a \geq 0$, it follows from (5.7) that there exists $n \geq k$ with $\mathfrak{p} \in \mathfrak{C}(k, n)$.

Since $\mathfrak{p} \in \mathfrak{P}_{X \backslash G^{\prime}}$, we have in particular $\mathcal{I}(\mathfrak{p}) \not \subset A(2 n+6, k, n)$, so there exist at most $1+(4 n+12) 2^{n}<2^{2 n+4}$ tiles $\mathfrak{m} \in \mathfrak{M}(k, n)$ with $\mathfrak{p} \leq \mathfrak{m}$. It follows that $\mathfrak{p} \in \mathfrak{L}_{0}(k, n)$ or $\mathfrak{p} \in \mathfrak{C}_{1}(k, n, j)$ for some $1 \leq j \leq 2 n+3$. In the former case we are done, in the latter case the inclusion to be shown follows immediately from the definitions of the collections $\mathfrak{C}_{i}$ and $\mathfrak{L}_{i}$.

Lemma 5.36 (L0 antichain). We have that

Suppose that we had such a chain $\mathfrak{p}_{0} \leq \mathfrak{p}_{1} \leq \cdots \leq \mathfrak{p}_{n}$ with $\mathfrak{p}_{i} \neq \mathfrak{p}_{i+1}$ for $i=0, \ldots, n-1$. By (5.7), we have that $\operatorname{dens}_{k}^{\prime}\left(\left\{\mathfrak{p}_{n}\right\}\right)>2^{-n}$. Thus, by (5.6), there exists $\mathfrak{p}^{\prime} \in \mathfrak{P}(k)$ and $\lambda \geq 2$ with $\lambda \mathfrak{p}_{n} \leq \lambda \mathfrak{p}^{\prime}$ and

Let $\mathfrak{O}$ be the set of all $\mathfrak{p}^{\prime \prime} \in \mathfrak{P}(k)$ such that we have $\mathcal{I}\left(\mathfrak{p}^{\prime \prime}\right)=\mathcal{I}\left(\mathfrak{p}^{\prime}\right)$ and $B_{\mathfrak{p}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{p}^{\prime}\right), \lambda\right) \cap \Omega\left(\mathfrak{p}^{\prime \prime}\right) \neq \emptyset$. We now show that

The balls $B_{\mathfrak{p}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{p}^{\prime \prime}\right), 0.2\right), \mathfrak{p}^{\prime \prime} \in \mathfrak{O}$ are disjoint by (2.15), and by the triangle inequality contained in $B_{\mathfrak{p}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{p}^{\prime}\right), \lambda+1\right)$. By assumption (1.11) on $\Theta$, this ball can be covered with

many $d_{\mathfrak{p}^{\prime}}$-balls of radius $1 / 4$. By the triangle inequality, each such ball contains at most one $\mathcal{Q}\left(\mathfrak{p}^{\prime \prime}\right)$, and each $\mathcal{Q}\left(\mathfrak{p}^{\prime \prime}\right)$ is contained in one of the balls. Thus we get (5.96).

By (2.26) and (2.27) we have $E_{2}\left(\lambda, \mathfrak{p}^{\prime}\right) \subset \bigcup_{\mathfrak{p}^{\prime \prime} \in \mathfrak{D}} E_{1}\left(\mathfrak{p}^{\prime \prime}\right)$, thus

Hence there exists a tile $\mathfrak{p}^{\prime \prime} \in \mathfrak{O}$ with

By the definition (5.5) of $\mathfrak{M}(k, n)$, there exists a tile $\mathfrak{m} \in \mathfrak{M}(k, n)$ with $\mathfrak{p}^{\prime} \leq \mathfrak{m}$. From (5.95), the inclusion $E_{2}\left(\lambda, \mathfrak{p}^{\prime}\right) \subset \mathcal{I}\left(\mathfrak{p}^{\prime}\right)$ and $a \geq 1$ we obtain

From the triangle inequality, Lemma 2.8 and $a \geq 1$, we now obtain for all $\vartheta \in B_{\mathfrak{m}}(\mathcal{Q}(\mathfrak{m}), 1)$ that

& \leq d_{\mathfrak{p}_{0}}\left(\mathcal{Q}\left(\mathfrak{p}_{0}\right), \mathcal{Q}\left(\mathfrak{p}_{n}\right)\right)+d_{\mathfrak{p}_{0}}\left(\mathcal{Q}\left(\mathfrak{p}_{n}\right), \mathcal{Q}\left(\mathfrak{p}^{\prime}\right)\right)+d_{\mathfrak{p}_{0}}\left(\mathcal{Q}\left(\mathfrak{p}^{\prime}\right), \mathcal{Q}\left(\mathfrak{p}^{\prime \prime}\right)\right) \\
& \quad+d_{\mathfrak{p}_{0}}\left(\mathcal{Q}\left(\mathfrak{p}^{\prime \prime}\right), \mathcal{Q}(\mathfrak{m})\right)+d_{\mathfrak{p}_{0}}(\mathcal{Q}(\mathfrak{m}), \vartheta) \\
& \leq 1+2^{-95 a n}\left(d_{\mathfrak{p}_{n}}\left(\mathcal{Q}\left(\mathfrak{p}_{n}\right), \mathcal{Q}\left(\mathfrak{p}^{\prime}\right)\right)+d_{\mathfrak{p}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{p}^{\prime}\right), \mathcal{Q}\left(\mathfrak{p}^{\prime \prime}\right)\right)\right. \\
&\left.\quad+d_{\mathfrak{p}^{\prime \prime}}\left(\mathcal{Q}\left(\mathfrak{p}^{\prime \prime}\right), \mathcal{Q}(\mathfrak{m})\right)+d_{\mathfrak{m}}(\mathcal{Q}(\mathfrak{m}), \vartheta)\right) \\
& \leq 1+2^{-95 a n}(\lambda+(\lambda+1)+1+1) \leq 100
\end{aligned}
$$

Thus, by (2.23), $100 \mathfrak{p}_{0} \lesssim \mathfrak{m}$, a contradiction to $\mathfrak{p}_{0} \notin \mathfrak{C}(k, n)$.
Lemma 5.37 (L2 antichain). Each of the sets $\mathfrak{L}_{2}(k, n, j)$ is an antichain.
Proof. Suppose that there are $\mathfrak{p}_{0}, \mathfrak{p}_{1} \in \mathfrak{L}_{2}(k, n, j)$ with $\mathfrak{p}_{0} \neq \mathfrak{p}_{1}$ and $\mathfrak{p}_{0} \leq \mathfrak{p}_{1}$. By Lemma 5.14 and Lemma 5.15, it follows that $2 \mathfrak{p}_{0} \lesssim 200 \mathfrak{p}_{1}$. Since $\mathfrak{L}_{2}(k, n, j)$ is finite, there exists a maximal $l \geq 1$ such that there exists a chain $2 \mathfrak{p}_{0} \lesssim 200 \mathfrak{p}_{1} \lesssim \cdots \lesssim 200 \mathfrak{p}_{l}$ with $\mathfrak{p}_{i} \neq \mathfrak{p}_{i+1}$ for $i=0, \ldots, l-1$. If we have $\mathfrak{p}_{l} \in \mathfrak{U}_{1}(k, n, j)$, then it follows from $2 \mathfrak{p}_{0} \lesssim 200 \mathfrak{p}_{l} \lesssim \mathfrak{p}_{l}$ and (5.15) that $\mathfrak{p}_{0} \notin \mathfrak{L}_{2}(k, n, j)$, a contradiction. Thus, by the definition (5.14) of $\mathfrak{U}_{1}(k, n, j)$, there exists $\mathfrak{p}_{l+1} \in \mathfrak{C}_{1}(k, n, j)$ with $\mathcal{I}\left(\mathfrak{p}_{l}\right) \subsetneq \mathcal{I}\left(\mathfrak{p}_{l+1}\right)$ and $\vartheta \in B_{\mathfrak{p}_{l}}\left(\mathcal{Q}\left(\mathfrak{p}_{l}\right), 100\right) \cap B_{\mathfrak{p}_{l+1}}\left(\mathcal{Q}\left(\mathfrak{p}_{l+1}\right), 100\right)$. Using the triangle inequality and Lemma 2.8, one deduces that $200 \mathfrak{p}_{l} \lesssim 200 \mathfrak{p}_{l+1}$. This contradicts maximality of $l$.

Lemma 5.38 (L1 L3 antichain). Each of the sets $\mathfrak{L}_{1}(k, n, j, l)$ and $\mathfrak{L}_{3}(k, n, j, l)$ is an antichain.

Proof. By its definition (5.11), each set $\mathfrak{L}_{1}(k, n, j, l)$ is a set of minimal elements in some set of tiles with respect to $\leq$. If there were distinct $\mathfrak{p}, \mathfrak{q} \in$ $\mathfrak{L}_{1}(k, n, j, l)$ with $\mathfrak{p} \leq \mathfrak{q}$, then $\mathfrak{q}$ would not be minimal. Hence such $\mathfrak{p}, \mathfrak{q}$ do not exist. Similarly, by (5.17), each set $\mathfrak{L}_{3}(k, n, j, l)$ is a set of maximal elements in some set of tiles with respect to $\leq$. If there were distinct $\mathfrak{p}, \mathfrak{q} \in \mathfrak{L}_{3}(k, n, j, l)$ with $\mathfrak{p} \leq \mathfrak{q}$, then $\mathfrak{p}$ would not be maximal.

Proof of Lemma 5.3. If $\mathfrak{p} \notin \mathfrak{P}_{X \backslash G^{\prime}}$, then $\mathcal{I}(\mathfrak{p}) \subset G^{\prime}$. By (2.21) and (2.26), it follows that $\mathbf{1}_{G \backslash G^{\prime}} T_{\mathfrak{p}} f(x)=0$. We thus have

Let $\mathfrak{L}(k, n)$ denote any of the terms $\mathfrak{L}_{i}(k, n, j, l) \cap \mathfrak{P}_{X \backslash \mathfrak{P}_{2}}$ on the right hand side of (5.90), where the indices $j, l$ may be void. Then $\mathfrak{L}(k, n)$ is an antichain, by Lemmas $5.36,5.37,5.38$. Further, we have

Applying now the triangle inequality according to the decomposition in Lemma 5.35, and then applying Proposition 2.3 to each term, we obtain the estimate

Because $|f| \leq \mathbf{1}_{F}$, we have $\|f\|_{2} \leq \mu(F)^{1 / 2}$, and we have $\left\|\mathbf{1}_{G \backslash G^{\prime}}\right\|_{2} \leq$ $\mu(G)^{1 / 2}$. Using this and (2.3), we bound

## 6. Proof of Proposition 2.3

Let an antichain $\mathfrak{A}$ and functions $f, g$ as in Proposition 2.3 be given. We prove (2.30) in Subsection 6.1 as the geometric mean of two inequalities, each involving one of the two densities. One of these two inequalities will need a careful estimate formulated in Lemma 6.5 of the $T T^{*}$ correlation between two tile operators. Lemma 6.5 will be proven in Subsection 6.2. The summation of the contributions of these individual correlations will require a geometric Lemma 6.6 counting the relevant tile pairs. Lemma 6.6 will be proven in Subsection 6.3.
6.1. The density arguments. We begin with the following crucial disjointedness property of the sets $E(\mathfrak{p})$ with $\mathfrak{p} \in \mathfrak{A}$.

Lemma 6.1 (tile disjointness). Let $\mathfrak{p}, \mathfrak{p}^{\prime} \in \mathfrak{A}$. If there exists an $x \in X$ with $x \in E(\mathfrak{p}) \cap E\left(\mathfrak{p}^{\prime}\right)$, then $\mathfrak{p}=\mathfrak{p}^{\prime}$.

Proof. Let $\mathfrak{p}, \mathfrak{p}^{\prime}$ and $x$ be given. Assume without loss of generality that $\mathrm{s}(\mathfrak{p}) \leq$ $\mathrm{s}\left(\mathfrak{p}^{\prime}\right)$. As we have $x \in E(\mathfrak{p}) \subset \mathcal{I}(\mathfrak{p})$ and $x \in E\left(\mathfrak{p}^{\prime}\right) \subset \mathcal{I}\left(\mathfrak{p}^{\prime}\right)$ by Definition (2.20), we conclude for $i=1,2$ that $Q(x) \in \Omega(\mathfrak{p})$ and $Q(x) \in \Omega\left(\mathfrak{p}^{\prime}\right)$. By (2.14) we have $\Omega\left(\mathfrak{p}^{\prime}\right) \subset \Omega(\mathfrak{p})$. By Definition (2.23), we conclude $\mathfrak{p} \leq \mathfrak{p}^{\prime}$. As $\mathfrak{A}$ is an antichain, we conclude $\mathfrak{p}=\mathfrak{p}^{\prime}$. This proves the lemma.

Let $\mathcal{B}$ be the collection of balls

with $\mathfrak{p} \in \mathfrak{A}$ and recall the definition of $M_{\mathcal{B}}$ from Definition 2.41.
Lemma 6.2 (maximal bound antichain). Let $x \in X$. Then

Proof. Fix $x \in X$. By Lemma 6.1, there is at most one $\mathfrak{p} \in \mathfrak{A}$ such that $T_{\mathfrak{p}} f(x)$ is not zero. If there is no such $\mathfrak{p}$, the estimate (6.2) follows.

Assume there is such a $\mathfrak{p}$. By definition of $T_{\mathfrak{p}}$ we have $x \in E(\mathfrak{p}) \subset \mathcal{I}(\mathfrak{p})$ and by the squeezing property (2.10)

Using $D=2^{100 a^{2}}$ and the doubling property (1.5) $5+100 a^{2}$ times estimates the last display by

Using that $|e(\vartheta)|$ is bounded by 1 for every $\vartheta \in \Theta$, we estimate with the triangle inequality and the above information

\end{equation*}

This together with $a \geq 1$ proves the Lemma.

Set

Lemma 6.3 (dens2 antichain). We have that

Proof. We have $f=\mathbf{1}_{F} f$. Using Hölder's inequality, we obtain for each $x \in B^{\prime}$ and each $B^{\prime} \in \mathcal{B}$ using $1<\tilde{q} \leq 2$

\leq\left(M_{\mathcal{B}}\left(|f|^{\frac{2 \tilde{q}}{3 \tilde{q}-2}}\right)(x)\right)^{\frac{3}{2}-\frac{1}{\tilde{q}}} \operatorname{dens}_{2}(\mathfrak{A})^{\frac{1}{\tilde{q}}-\frac{1}{2}} \tag{6.13}
\end{gather*}
$$

dyadic property that $L^{\prime} \subset \mathcal{I}\left(\mathfrak{p}^{\prime}\right)$. By maximality of $L$, we have $L^{\prime} \notin \mathcal{L}$. This together with the existence of the given $\mathfrak{p}^{\prime} \in \mathfrak{A}$ with $L^{\prime} \subset \mathcal{I}\left(\mathfrak{p}^{\prime}\right)$ shows by definition of $\mathcal{L}$ that there exists $\mathfrak{p}^{\prime \prime} \in \mathfrak{A}^{\prime}$ with $\mathcal{I}\left(\mathfrak{p}^{\prime \prime}\right) \subset L^{\prime}$.

By the covering property (2.13), there exists a unique $\mathfrak{p}_{\vartheta}$ with

$$
\mathcal{I}\left(\mathfrak{p}_{\vartheta}\right)=L^{\prime}
$$

such that $\vartheta \in \Omega\left(\mathfrak{p}_{\vartheta}\right)$. Note that

$$
\begin{equation*}
\vartheta \in B\left(\mathcal{Q}\left(\mathfrak{p}_{\vartheta}\right), 1\right) \tag{6.118}
\end{equation*}
$$

and as $\mathfrak{p}^{\prime \prime} \in \mathfrak{A}_{\vartheta, N}$ that

$$
\begin{equation*}
\vartheta \in B\left(\mathcal{Q}\left(\mathfrak{p}^{\prime \prime}\right), 2^{N+1}\right) . \tag{6.119}
\end{equation*}
$$

By Lemma 6.10 , we conclude

$$
\begin{equation*}
2^{N+3} \mathfrak{p}^{\prime \prime} \lesssim 2^{N+3} \mathfrak{p}_{\vartheta} \tag{6.120}
\end{equation*}
$$

As $\mathfrak{p}^{\prime \prime} \in \mathfrak{A}^{\prime}$, we have by Definition (2.28) of dens $s_{1}$ that

$$
\begin{equation*}
\mu\left(E_{2}\left(2^{N+3}, \mathfrak{p}_{\vartheta}\right)\right) \leq 2^{N a+3 a} \operatorname{dens}_{1}(\mathfrak{A}) \mu\left(L^{\prime}\right) \tag{6.121}
\end{equation*}
$$

Now let $\mathfrak{p}$ be any tile in the summation set in (6.116), that is, $\mathfrak{p} \in \mathfrak{A}^{\prime}$ and $\mathcal{I}(\mathfrak{p}) \neq L^{\prime}$. Then $\mathcal{I}(\mathfrak{p}) \cap L \neq \emptyset$. It follows by the dyadic property (2.8) and the definition of $L$ that $L \subset \mathcal{I}(\mathfrak{p})$ and $L \neq \mathcal{I}(\mathfrak{p})$. By the dyadic property (2.8), we have $s(L)<\mathrm{s}(\mathfrak{p})$ and thus $s\left(L^{\prime}\right) \leq \mathrm{s}(\mathfrak{p})$. By the dyadic property (2.8) again, we have $L^{\prime} \subset \mathcal{I}(\mathfrak{p})$. As $L^{\prime} \neq \mathcal{I}(\mathfrak{p})$, we conclude $s(L)<\mathrm{s}(\mathfrak{p})$. By Lemma 6.12, we can thus estimate (6.116) by

$$
\begin{equation*}
\sum_{\mathfrak{p} \in \mathfrak{\mathcal { A } ^ { \prime } : \mathcal { I } ( \mathfrak { p } ) \neq L ^ { \prime }}} \mu\left(E(\mathfrak{p}) \cap G \cap L^{\prime}\right) \leq \mu\left(E_{2}\left(2^{N+3}, \mathfrak{p}_{\vartheta}\right)\right) \tag{6.122}
\end{equation*}
$$

Using the decomposition into (6.115) and (6.116) and the estimates (6.117), (6.104), (6.121) we obtain the estimate

$$
\begin{equation*}
\sum_{\mathfrak{p} \in \mathfrak{A}^{\prime}} \mu(E(\mathfrak{p}) \cap G \cap L) \leq\left(2^{a(N+5)}+2^{N a+3 a}\right) \operatorname{dens}_{1}(\mathfrak{A}) \mu\left(L^{\prime}\right) . \tag{6.123}
\end{equation*}
$$

Using $s\left(L^{\prime}\right)=s(L)+1$ and $D=2^{100 a^{2}}$ and the squeezing property (2.10) and the doubling property (1.5) $100 a^{2}+4$ times, we obtain

$$
\begin{equation*}
\mu\left(L^{\prime}\right) \leq 2^{100 a^{3}+4 a} \mu(L) \tag{6.124}
\end{equation*}
$$

Inserting in (6.123) and using $a \geq 4$ gives (6.113). This completes the proof of the lemma.

We turn to the proof of Lemma 6.6.
Proof. Using that $\mathfrak{A}$ is the union of the $\mathfrak{A}_{\vartheta, N}$ with $N \geq 0$, we estimate the left-hand side (6.36) with the triangle inequality by

$$
\begin{equation*}
\leq \sum_{N \geq 0}\left\|\sum_{\mathfrak{p} \in \mathfrak{A}_{\vartheta, N}} 2^{-N /\left(2 a^{2}+a^{3}\right)} \mathbf{1}_{E(\mathfrak{p})} \mathbf{1}_{G}\right\|_{p} \tag{6.125}
\end{equation*}
$$

We consider each individual term in this sum and estimate it's $p$-th power. Using that for each $x \in X$ by Lemma 6.13 there is at most one $\mathfrak{p} \in \mathfrak{A}$ with $x \in E(\mathfrak{p})$, we have

$$
\begin{gather*}
\left\|\sum_{\mathfrak{p} \in \mathfrak{A}_{v, N}} 2^{-N /\left(2 a^{2}+a^{3}\right)} \mathbf{1}_{E(\mathfrak{p})} \mathbf{1}_{G}\right\|_{p}^{p}  \tag{6.126}\\
=\int_{G}\left(\sum_{\mathfrak{p} \in \mathfrak{A}_{v, N}} 2^{-N /\left(2 a^{2}+a^{3}\right)} \mathbf{1}_{E(\mathfrak{p})}(x)\right)^{p} d \mu(x)  \tag{6.127}\\
=\int_{G} \sum_{\mathfrak{p} \in \mathfrak{A}_{\vartheta, N}} 2^{-p N /\left(2 a^{2}+a^{3}\right)} \mathbf{1}_{E(\mathfrak{p})}(x) d \mu(x)  \tag{6.128}\\
=2^{-p N /\left(2 a^{2}+a^{3}\right)} \sum_{\mathfrak{p} \in \mathfrak{R}_{v, N}} \mu(E(\mathfrak{p}) \cap G) \tag{6.129}
\end{gather*}
$$

Using Lemma 6.13, we estimate the last display by

$$
\begin{equation*}
\leq 2^{-p N /\left(2 a^{2}+a^{3}\right)+101 a^{3}+N a} \operatorname{dens}_{1}(\mathfrak{A}) \mu\left(\cup_{\mathfrak{p} \in \mathfrak{A}} \mathcal{I}(\mathfrak{p})\right) \tag{6.130}
\end{equation*}
$$

Using that with $a \geq 4$ and since $p=4 a^{4}$, we have

$$
\begin{equation*}
p N /\left(2 a^{2}+a^{3}\right) \geq 4 a^{4} N /\left(3 a^{3}\right) \geq N a+N \tag{6.131}
\end{equation*}
$$

Hence we have for (6.130) the upper bound

$$
\begin{equation*}
\leq 2^{101 a^{3}-N} \operatorname{dens}_{1}(\mathfrak{A}) \mu\left(\cup_{\mathfrak{p} \in \mathfrak{A}} \mathcal{I}(\mathfrak{p})\right) \tag{6.132}
\end{equation*}
$$

Taking th $p$-th root and summing over $N \geq 0$ gives for (6.125) the upper bound

$$
\begin{align*}
& \leq\left(\sum_{N \geq 0} 2^{-N / p}\right) 2^{101 a^{3} / p} \operatorname{dens}_{1}(\mathfrak{A})^{\frac{1}{p}} \mu\left(\cup_{\mathfrak{p} \in \mathfrak{A}} \mathcal{I}(\mathfrak{p})\right)^{\frac{1}{p}}  \tag{6.133}\\
& \leq\left(1-2^{-1 / p}\right)^{-1} 2^{101 a^{3} / p} \operatorname{dens}_{1}(\mathfrak{A})^{\frac{1}{p}} \mu\left(\cup_{\mathfrak{p} \in \mathfrak{A}} \mathcal{I}(\mathfrak{p})\right)^{\frac{1}{p}} \tag{6.134}
\end{align*}
$$

Using that $p=4 a^{4}$ and $a \geq 4$, this proves the lemma.

## 7. Proof of Proposition 2.4

7.1. The pointwise tree estimate. Fix a forest $(\mathfrak{U}, \mathfrak{T})$. The main result of this subsection is Lemma 7.3, we begin this section with some definitions necessary to state the lemma.

For $\mathfrak{u} \in \mathfrak{U}$ and $x \in X$, we define

$$
\sigma(\mathfrak{u}, x):=\{\mathrm{s}(\mathfrak{p}): \mathfrak{p} \in \mathfrak{T}(\mathfrak{u}), x \in E(\mathfrak{p})\}
$$

This is a subset of $\mathbb{Z} \cap[-S, S]$, so has a minimum and a maximum. We set

$$
\begin{aligned}
\bar{\sigma}(\mathfrak{u}, x) & :=\max \sigma(\mathfrak{T}(\mathfrak{u}), x) \\
\underline{\sigma}(\mathfrak{u}, x) & :=\min \sigma(\mathfrak{T}(\mathfrak{u}), x) .
\end{aligned}
$$

Lemma 7.1 (convex scales). For each $\mathfrak{u} \in \mathfrak{U}$, we have

$$
\sigma(\mathfrak{u}, x)=\mathbb{Z} \cap[\underline{\sigma}(\mathfrak{u}, x), \bar{\sigma}(\mathfrak{u}, x)] .
$$

Proof. Let $s \in \mathbb{Z}$ with $\underline{\sigma}(\mathfrak{u}, x) \leq s \leq \bar{\sigma}(\mathfrak{u}, x)$. By definition of $\sigma$, there exists $\mathfrak{p} \in \mathfrak{T}(\mathfrak{u})$ with $\mathrm{s}(\mathfrak{p})=\underline{\sigma}(\mathfrak{u}, x)$ and $x \in E(\mathfrak{p})$, and there exists $\mathfrak{p}^{\prime \prime} \in \mathfrak{T}(\mathfrak{u})$ with $\mathrm{s}\left(\mathfrak{p}^{\prime \prime}\right)=\bar{\sigma}(\mathfrak{u}, x)$ and $x \in E\left(\mathfrak{p}^{\prime \prime}\right) \subset \mathcal{I}\left(\mathfrak{p}^{\prime \prime}\right)$. By property (2.7) of the dyadic grid, there exists a cube $I \in \mathcal{D}$ of scale $s$ with $x \in I$. By property (2.13), there exists a tile $\mathfrak{p}^{\prime} \in \mathfrak{P}(I)$ with $Q(x) \in \Omega\left(\mathfrak{p}^{\prime}\right)$. By the dyadic property (2.8) we have $\mathcal{I}(\mathfrak{p}) \subset \mathcal{I}\left(\mathfrak{p}^{\prime}\right) \subset \mathcal{I}\left(\mathfrak{p}^{\prime \prime}\right)$, and by (2.14), we have $\Omega\left(\mathfrak{p}^{\prime \prime}\right) \subset \Omega\left(\mathfrak{p}^{\prime}\right) \subset \Omega(\mathfrak{p})$. Thus $\mathfrak{p} \leq \mathfrak{p}^{\prime} \leq \mathfrak{p}^{\prime \prime}$, which gives with the convexity property (2.33) of $\mathfrak{T}(\mathfrak{u})$ that $\mathfrak{p}^{\prime} \in \mathfrak{T}(\mathfrak{u})$, so $s \in \sigma(\mathfrak{u}, x)$.

For a nonempty collection of tiles $\mathfrak{S} \subset \mathfrak{P}$ we define

$$
\mathcal{J}_{0}(\mathfrak{S})
$$

to be the collection of all dyadic cubes $J \in \mathcal{D}$ such that $s(J)=-S$ or

$$
\mathcal{I}(\mathfrak{p}) \not \subset B\left(c(J), 100 D^{s(J)+1}\right)
$$

for all $\mathfrak{p} \in \mathfrak{S}$. We define $\mathcal{J}(\mathfrak{S})$ to be the collection of inclusion maximal cubes in $\mathcal{J}_{0}(\mathfrak{S})$.

We further define

$$
\mathcal{L}_{0}(\mathfrak{S})
$$

to be the collection of dyadic cubes $L \in \mathcal{D}$ such that $s(L)=-S$, or there exists $\mathfrak{p} \in \mathfrak{S}$ with $L \subset \mathcal{I}(\mathfrak{p})$ and there exists no $\mathfrak{p} \in \mathfrak{S}$ with $\mathcal{I}(\mathfrak{p}) \subset L$. We define $\mathcal{L}(\mathfrak{S})$ to be the collection of inclusion maximal cubes in $\mathcal{L}_{0}(\mathfrak{S})$.

Lemma 7.2 (dyadic partitions). For each $\mathfrak{S} \subset \mathfrak{P}$, we have

$$
\begin{equation*}
\bigcup_{I \in \mathcal{D}} I=\bigcup_{J \in \mathcal{J}(\mathfrak{S})} J \tag{7.1}
\end{equation*}
$$

and

$$
\begin{equation*}
\bigcup_{\mathfrak{p} \in \mathfrak{S}} \mathcal{I}(\mathfrak{p})=\bigcup_{L \in \mathcal{L}(\mathfrak{S})} L \tag{7.2}
\end{equation*}
$$

Proof. Since $\mathcal{J}(\mathfrak{S})$ is the set of inclusion maximal cubes in $\mathcal{J}_{0}(\mathfrak{S})$, cubes in $\mathcal{J}(\mathfrak{S})$ are pairwise disjoint by (2.8). The same applies to $\mathcal{L}(\mathfrak{S})$.

If $x \in \bigcup_{I \in \mathcal{D}} I$, then there exists by (2.7) a cube $I \in \mathcal{D}$ with $x \in I$ and $s(I)=-S$. Then $I \in \mathcal{J}_{0}(\mathfrak{S})$. There exists an inclusion maximal cube in $\mathcal{J}_{0}(\mathfrak{S})$ containing $I$. This cube contains $x$ and is contained in $\mathcal{J}(\mathfrak{S})$. This shows one inclusion in (7.1), the other one follows from $\mathcal{J}(\mathfrak{S}) \subset \mathcal{D}$.

The proof of the two inclusions in (7.2) is similar.
For a finite collection of pairwise disjoint cubes $\mathcal{C}$, define the projection operator

$$
P_{\mathcal{C}} f(x):=\sum_{J \in \mathcal{C}} \mathbf{1}_{J}(x) \frac{1}{\mu(J)} \int_{J} f(y) \mathrm{d} \mu(y)
$$

Given a scale $-S \leq s \leq S$ and a point $x \in \bigcup_{I \in \mathcal{D}, s(I)=s} I$, there exists a unique cube in $\mathcal{D}$ of scale $s$ containing $x$ by (2.7). We denote it by $I_{s}(x)$. Define the nontangential maximal operator

$$
\begin{equation*}
T_{\mathcal{N}} f(x):=\sup _{-S \leq s_{1}<s_{2} \leq S} \sup _{x^{\prime} \in I_{s_{1}}(x)}\left|\sum_{s=s_{1}}^{s_{2}} \int K_{s}\left(x^{\prime}, y\right) f(y) \mathrm{d} \mu(y)\right| \tag{7.3}
\end{equation*}
$$

Define for each $\mathfrak{u} \in \mathfrak{U}$ the auxiliary operator

$$
:=\sum_{I \in \mathcal{D}} \mathbf{1}_{I}(x) \sum_{\substack{J \in \mathcal{J}(\mathfrak{T}(u)) \\ J \subset B\left(c(I), 16 D^{s(I)}\right)}} \frac{S_{1, \mathfrak{u}} f(x)}{\mu\left(B\left(c(I), 16 D^{s(I)}\right)\right)} \int_{J}|f(y)| \mathrm{d} \mu(y) .
$$

Define also the collection of balls

$$
\mathcal{B}=\left\{B\left(c(I), D^{s+s(I)}\right): I \in \mathcal{D}, 0 \leq s \leq S+5\right\}
$$

The following pointwise estimate for operators associated to sets $\mathfrak{T}(\mathfrak{u})$ is the main result of this subsection.

Lemma 7.3 (pointwise tree estimate). Let $\mathfrak{u} \in \mathfrak{U}$ and $L \in \mathcal{L}(\mathfrak{T}(\mathfrak{u}))$. Let $x, x^{\prime} \in L$. Then for all bounded functions $f$ with bounded support

$$
\begin{align*}
& \left|\sum_{\mathfrak{p} \in \mathfrak{T}(\mathfrak{u})} T_{\mathfrak{p}}[e(\mathcal{Q}(\mathfrak{u})) f](x)\right| \\
& \leq 2^{151 a^{3}}\left(M_{\mathcal{B}, 1}+S_{1, \mathfrak{u}}\right) P_{\mathcal{J}(\mathfrak{T}(\mathfrak{u}))}|f|\left(x^{\prime}\right)+\left|T_{\mathcal{N}} P_{\mathcal{J}(\mathfrak{T}(\mathfrak{u}))} f\left(x^{\prime}\right)\right|, \tag{7.5}
\end{align*}
$$

Proof. By (2.21), if $T_{\mathfrak{p}}[e(-\mathcal{Q}(\mathfrak{u})) f](x) \neq 0$, then $x \in E(\mathfrak{p})$. Combining this with $|e(\mathcal{Q}(\mathfrak{u})(x)-Q(x)(x))|=1$, we obtain

$$
\begin{gathered}
\left|\sum_{\mathfrak{p} \in \mathfrak{T}(\mathfrak{u})} T_{\mathfrak{p}}[e(\mathcal{Q}(\mathfrak{u})) f](x)\right| \\
=\mid \sum_{s \in \sigma(\mathfrak{u}, x)} \int e(-\mathcal{Q}(\mathfrak{u})(y)+Q(x)(y)+\mathcal{Q}(\mathfrak{u})(x)-Q(x)(x)) \times \\
K_{s}(x, y) f(y) \mathrm{d} \mu(y) \mid .
\end{gathered}
$$

Using the triangle inequality, we bound this by the sum of three terms:

$$
\begin{array}{r}
\leq \mid \sum_{s \in \sigma(\mathfrak{u}, x)} \int(e(-\mathcal{Q}(\mathfrak{u})(y)+Q(x)(y)+\mathcal{Q}(\mathfrak{u})(x)-Q(x)(x))-1) \times \\
\quad+\left|\sum_{s}(x, y) f(y) \mathrm{d} \mu(y)\right| \\
+\left|\sum_{s \in \sigma(\mathfrak{u}, x)} \int K_{s}(x, y) P_{\mathcal{J}(\mathfrak{T}(\mathfrak{u}))} f(y) \mathrm{d} \mu(y)\right| \\ \tag{7.8}
\end{array}
$$

The proof is completed using the bounds for these three terms proven in Lemma 7.4, Lemma 7.5 and Lemma 7.6.

Lemma 7.4 (first tree pointwise). For all $\mathfrak{u} \in \mathfrak{U}$, all $L \in \mathcal{L}(\mathfrak{T}(\mathfrak{u})$ ), all $x, x^{\prime} \in L$ and all bounded $f$ with bounded support, we have

$$
(7.6) \leq 10 \cdot 2^{105 a^{3}} M_{\mathcal{B}, 1} P_{\mathcal{J}(\mathfrak{T}(\mathfrak{u}))}|f|\left(x^{\prime}\right)
$$

Proof. Let $s \in \sigma(\mathfrak{u}, x)$. If $x, y \in X$ are such that $K_{s}(x, y) \neq 0$, then, by (2.48), we have $\rho(x, y) \leq 1 / 2 D^{s}$. By 1-Lipschitz continuity of the function $t \mapsto \exp (i t)=e(t)$ and the property (1.7) of the metrics $d_{B}$, it follows that

$$
\begin{aligned}
\mid e(-\mathcal{Q}(\mathfrak{u})(y)+Q(x)(y)+\mathcal{Q}(\mathfrak{u})(x)-Q(x)(x)) & -1 \mid \\
& \leq d_{B\left(x, 1 / 2 D^{s}\right)}(\mathcal{Q}(\mathfrak{u}), Q(x))
\end{aligned}
$$

Let $\mathfrak{p}_{s} \in \mathfrak{T}(\mathfrak{u})$ be a tile with $\mathrm{s}\left(\mathfrak{p}_{s}\right)=s$ and $x \in E\left(\mathfrak{p}_{s}\right)$, and let $\mathfrak{p}^{\prime}$ be a tile with $\mathrm{s}\left(\mathfrak{p}^{\prime}\right)=\bar{\sigma}(\mathfrak{u}, x)$ and $x \in E\left(\mathfrak{p}^{\prime}\right)$. Using the doubling property (1.8), the definition of $d_{\mathfrak{p}}$ and Lemma 2.8, we can bound the previous display by

$$
2^{a} d_{\mathfrak{p}_{s}}(\mathcal{Q}(\mathfrak{u}), Q(x)) \leq 2^{a} 2^{s-\bar{\sigma}(\mathfrak{u}, x)} d_{\mathfrak{p}^{\prime}}(\mathcal{Q}(\mathfrak{u}), Q(x))
$$

Since $\mathcal{Q}(\mathfrak{u}) \in B_{\mathfrak{p}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{p}^{\prime}\right), 4\right)$ by (2.32) and $Q(x) \in \Omega\left(\mathfrak{p}^{\prime}\right) \subset B_{\mathfrak{p}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{p}^{\prime}\right), 1\right)$ by (2.15), this is estimated by

$$
\leq 5 \cdot 2^{a} 2^{s-\bar{\sigma}(\mathfrak{u}, x)}
$$

Using (2.49), it follows that

$$
(7.6) \leq 5 \cdot 2^{103 a^{3}} \sum_{s \in \sigma(x)} 2^{s-\bar{\sigma}(\mathfrak{u}, x)} \frac{1}{\mu\left(B\left(x, D^{s}\right)\right)} \int_{B\left(x, 0.5 D^{s}\right)}|f(y)| \mathrm{d} \mu(y) .
$$

By (7.1), the collection $\mathcal{J}$ is a partition of $X$, so this is estimated by

$$
5 \cdot 2^{103 a^{3}} \sum_{s \in \sigma(x)} 2^{s-\bar{\sigma}(\mathfrak{u}, x)} \frac{1}{\mu\left(B\left(x, D^{s}\right)\right)} \sum_{\substack{J \in \mathcal{J}(\mathfrak{T}(\mathfrak{u})) \\ J \cap B\left(x, 0.5 D^{s}\right) \neq \emptyset}} \int_{J}|f(y)| \mathrm{d} \mu(y) .
$$

This expression does not change if we replace $|f|$ by $P_{\mathcal{J}(\mathfrak{T}(\mathfrak{u}))}|f|$.
Let $J \in \mathcal{J}(\mathfrak{T}(\mathfrak{u}))$ with $B\left(x, 0.5 D^{s}\right) \cap J \neq \emptyset$. By the triangle inequality and since $x \in E\left(\mathfrak{p}_{s}\right) \subset B\left(\mathrm{c}\left(\mathfrak{p}_{s}\right), 4 D^{s}\right)$, it follows that $B\left(\mathrm{c}\left(\mathfrak{p}_{s}\right), 4.5 D^{s}\right) \cap J \neq \emptyset$. If $s(J) \geq s$ and $s(J)>-S$, then it follows from the triangle inequality, (2.10) and (2.1) that $\mathcal{I}\left(\mathfrak{p}_{s}\right) \subset B\left(c(J), 100 D^{s(J)+1}\right)$, contradicting $J \in \mathcal{J}(\mathfrak{T}(\mathfrak{u}))$. Thus $s(J) \leq s-1$ or $s(J)=-S$. If $s(J)=-S$ and $s(J)>s-1$, then $s=-S$. Thus we always have $s(J) \leq s$. It then follows from the triangle inequality and (2.10) that $J \subset B\left(\mathrm{c}\left(\mathfrak{p}_{s}\right), 16 D^{s}\right)$.

Thus we can continue our chain of estimates with

$$
5 \cdot 2^{103 a^{3}} \sum_{s \in \sigma(x)} 2^{s-\bar{\sigma}(\mathfrak{u}, x)} \frac{1}{\mu\left(B\left(x, D^{s}\right)\right)} \int_{B\left(\mathrm{c}\left(\mathfrak{p}_{s}\right), 16 D^{s}\right)} P_{\mathcal{J}(\mathfrak{T}(\mathfrak{u}))}|f(y)| \mathrm{d} \mu(y) .
$$

We have $\left.B\left(\mathrm{c}\left(\mathfrak{p}_{s}\right), 16 D^{s}\right)\right) \subset B\left(x, 32 D^{s}\right)$, by $(2.10)$ and the triangle inequality, since $x \in \mathcal{I}(\mathfrak{p})$. Combining this with the doubling property (1.5), we obtain

& \quad\left(\left(M_{\mathcal{B}, 1}+S_{1, \mathfrak{u}}\right) P_{\mathcal{J}(\mathfrak{I}(u))}|f|(y)+\left|T_{\mathcal{N}} P_{\mathcal{J}(\mathfrak{I}(u))} f(y)\right|\right) \mathrm{d} \mu(y) .
\end{aligned}
$$

By (2.21), we have $T_{\mathfrak{p}} f=\mathbf{1}_{\mathcal{I}(\mathfrak{p})} T_{\mathfrak{p}} f$ for all $\mathfrak{p} \in \mathfrak{P}$, so

Applying Cauchy-Schwarz and Minkowski's inequality, this is bounded by

2^{6 a+a^{3}} M_{\mathcal{B}, 1} f(x)
$$

Using $a \geq 4$, taking a supremum over all $x^{\prime} \in I_{s_{1}}(x)$ and then a supremum over all $-S \leq s_{1}<s_{2} \leq S$, we obtain

$$
T_{\mathcal{N}} f(x) \leq T_{*} f(x)+2^{102 a^{3}} M_{\mathcal{B}, 1} f(x)
$$

The lemma now follows from assumption (1.18), Proposition 2.6and $a \geq$ 4.

We need the following lemma to prepare the $L^{2}$-estimate for the auxiliary operators $S_{1, \mathfrak{u}}$.
Lemma 7.10 (boundary overlap). For every cube $I \in \mathcal{D}$, there exist at most $2^{8 a}$ cubes $J \in \mathcal{D}$ with $s(J)=s(I)$ and $B\left(c(I), 16 D^{s(I)}\right) \cap B\left(c(J), 16 D^{s(J)}\right) \neq$ $\emptyset$.
Proof. Suppose that $B\left(c(I), 16 D^{s(I)}\right) \cap B\left(c(J), 16 D^{s(J)}\right) \neq \emptyset$ and $s(I)=$ $s(J)$. Then $B\left(c(I), 32 D^{s(I)}\right) \subset B\left(c(J), 64 D^{s(J)}\right)$. Hence by the doubling property (1.5)

$$
2^{8 a} \mu\left(B\left(c(J), \frac{1}{4} D^{s(J)}\right)\right) \geq \mu\left(B\left(c(I), 32 D^{s(I)}\right)\right)
$$

and by the triangle inequality, the ball $B\left(c(J), \frac{1}{4} D^{s(J)}\right)$ is contained in $B\left(c(I), 32 D^{s(I)}\right)$.

If $\mathcal{C}$ is any finite collection of cubes $J \in \mathcal{D}$ satisfying $s(J)=s(I)$ and

B\left(c(I), 16 D^{s(I)}\right) \cap B\left(c(J), 16 D^{s(J)}\right) \neq \emptyset
$$

then it follows from (2.10) and pairwise disjointedness of cubes of the same scale (2.8) that the balls $B\left(c(J), \frac{1}{4} D^{s(J)}\right)$ are pairwise disjoint. Hence

\begin{aligned}
\mu\left(B\left(c(I), 32 D^{s(I)}\right)\right) & \geq \sum_{J \in \mathcal{C}} \mu\left(B\left(c(J), \frac{1}{4} D^{s(J)}\right)\right) \\
& \geq|\mathcal{C}| 2^{-8 a} \mu\left(B\left(c(I), 32 D^{s(I)}\right)\right) .
\end{aligned}
$$

Since $\mu$ is doubling and $\mu \neq 0$, we have $\mu\left(B\left(c(I), 32 D^{s(I)}\right)\right)>0$. The lemma follows after dividing by $2^{-8 a} \mu\left(B\left(c(I), 32 D^{s(I)}\right)\right)$.

Now we can bound the operators $S_{1, \mathfrak{u}}$.
Proof of Lemma 7.9. Note that by definition, $S_{1, \mathfrak{u}} f$ is a finite sum of indicator functions of cubes $I \in \mathcal{D}$ for each locally integrable $f$, and hence is bounded, has bounded support and is integrable. Let $g$ be another function with the same three properties. Then $\bar{g} S_{1, \mathfrak{u}} f$ is integrable, and we have

\left|\int \bar{g}(y) S_{1, \mathfrak{u}} f(y) \mathrm{d} \mu(y)\right| \\
=\left\lvert\, \sum_{I \in \mathcal{D}} \frac{1}{\mu\left(B\left(c(I), 16 D^{s(I)}\right)\right)} \int_{I} \bar{g}(y) \mathrm{d} \mu(y)\right. \\
\times \sum_{J \in \mathcal{J}: J \subseteq B\left(c(I), 16 D^{s(I)}\right)} D^{(s(J)-s(I)) / a} \int_{J}|f(y)| \mathrm{d} \mu(y) \mid \\
\leq \sum_{I \in \mathcal{D}} \frac{1}{\mu\left(B\left(c(I), 16 D^{s(I)}\right)\right)} \int_{B\left(c(I), 16 D^{s(I)}\right)}|g(y)| \mathrm{d} \mu(y) \\
\times \sum_{J \in \mathcal{J}: J \subseteq B\left(c(I), 16 D^{s(I)}\right)} D^{(s(J)-s(I)) / a} \int_{J}|f(y)| \mathrm{d} \mu(y) .
\end{gathered}
$$

Changing the order of summation and using $J \subset B\left(c(I), 16 D^{s(I)}\right)$ to bound the first average integral by $M_{\mathcal{B}, 1}|g|(y)$ for any $y \in J$, we obtain

$$
\begin{equation*}
\leq \sum_{J \in \mathcal{J}} \int_{J}|f(y)| M_{\mathcal{B}, 1}|g|(y) \mathrm{d} \mu(y) \sum_{I \in \mathcal{D}: J \subset B\left(c(I), 16 D^{s(I)}\right)} D^{(s(J)-s(I)) / a} \tag{7.18}
\end{equation*}
$$

By (2.10) and (2.1) the condition $J \subset B\left(c(I), 16 D^{s(I)}\right)$ implies $s(I) \geq s(J)$. By Lemma 7.10, there are at most $2^{8 a}$ cubes $I$ at each scale with $J \subset$ $B\left(c(I), D^{s(I)}\right)$. By convexity of $t \mapsto D^{t}$ and since $D \geq 2$, we have for all $-1 \leq t \leq 0$

D^{t} \leq 1+t\left(1-\frac{1}{D}\right) \leq 1+\frac{1}{2} t
$$

so $\left(1-D^{-1 / a}\right)^{-1} \leq 2 a \leq 2^{a}$. Using this estimate for the sum of the geometric series, we conclude that (7.18) is at most

The collection $\mathcal{J}$ is a partition of $X$, so this equals

2^{9 a} \int_{X}|f(y)| M_{\mathcal{B}, 1}|g|(y) \mathrm{d} \mu(y)
$$

Using Cauchy-Schwarz and Proposition 2.6we conclude

$$
\left|\int \bar{g} S_{1, \mathfrak{u}} f \mathrm{~d} \mu\right| \leq 2^{11 a+1}\|g\|_{2}\|f\|_{2}
$$

The lemma now follows by choosing $g=S_{1, \mathfrak{u}} f$ and dividing on both sides by the finite $\left\|S_{1, \mathfrak{u}} f\right\|_{2}$.
7.3. The quantitative $L^{2}$ tree estimate. The main result of this subsection is the following quantitative bound for operators associated to trees, with decay in the densities dens $_{1}$ and dens ${ }_{2}$.

Lemma 7.11 (densities tree bound). Let $\mathfrak{u} \in \mathfrak{U}$. Then for all $f, g$ bounded with bounded support

\begin{equation*}
\left|\int_{X} \bar{g} \sum_{\mathfrak{p} \in \mathfrak{T}(\mathfrak{u})} T_{\mathfrak{p}} f \mathrm{~d} \mu\right| \leq 2^{155 a^{3}} \operatorname{dens}_{1}(\mathfrak{T}(\mathfrak{u}))^{1 / 2}\|f\|_{2}\|g\|_{2} . \tag{7.19}
\end{equation*}
$$

If $|f| \leq \mathbf{1}_{F}$, then we have

$$
\begin{equation*}
\left|\int_{X} \bar{g} \sum_{\mathfrak{p} \in \mathfrak{T}(\mathfrak{u})} T_{\mathfrak{p}} f \mathrm{~d} \mu\right| \leq 2^{256 a^{3}} \operatorname{dens}_{1}(\mathfrak{T}(\mathfrak{u}))^{1 / 2} \operatorname{dens}_{2}(\mathfrak{T}(\mathfrak{u}))^{1 / 2}\|f\|_{2}\|g\|_{2} . \tag{7.20}
\end{equation*}
$$

Below, we deduce this lemma from Lemma 7.7 and the following two estimates controlling the size of support of the operator and its adjoint.

Lemma 7.12 (local dens1 tree bound). Let $\mathfrak{u} \in \mathfrak{U}$ and $L \in \mathcal{L}(\mathfrak{T}(\mathfrak{u}))$. Then

\mu\left(L \cap \bigcup_{\mathfrak{p} \in \mathfrak{T}(\mathfrak{u})} E(\mathfrak{p})\right) \leq 2^{101 a^{3}} \operatorname{dens}_{1}(\mathfrak{T}(\mathfrak{u})) \mu(L) \tag{7.21}
\end{equation*}
$$

Lemma 7.13 (local dens2 tree bound). Let $J \in \mathcal{J}(\mathfrak{T}(\mathfrak{u}))$ be such that there exist $\mathfrak{q} \in \mathfrak{T}(\mathfrak{u})$ with $J \cap \mathcal{I}(\mathfrak{q}) \neq \emptyset$. Then

$$
\mu(F \cap J) \leq 2^{200 a^{3}+19} \operatorname{dens}_{2}(\mathfrak{T}(\mathfrak{u}))
$$

Proof of Lemma 7.11. Denote

$$
\mathcal{E}(\mathfrak{u})=\bigcup_{\mathfrak{p} \in \mathfrak{T}(\mathfrak{u})} E(\mathfrak{p}) .
$$

Then we have

$$
\left|\int_{X} \bar{g} \sum_{\mathfrak{p} \in \mathfrak{T}(\mathfrak{u})} T_{\mathfrak{p}} f \mathrm{~d} \mu\right|=\left|\int_{X} \overline{g \mathbf{1}_{\mathcal{E}(\mathfrak{u})}} \sum_{\mathfrak{p} \in \mathfrak{T}(\mathfrak{u})} T_{\mathfrak{p}} f \mathrm{~d} \mu\right| .
$$

By Lemma 7.7, this is bounded by

$$
\begin{equation*}
\leq 2^{104 a^{3}}\left\|P_{\mathcal{J}(\mathfrak{T}(\mathfrak{u}))}|f|\right\|_{2}\left\|P_{\mathcal{L}(\mathfrak{T}(\mathfrak{u}))}\left|\mathbf{1}_{\mathcal{E}(\mathfrak{u})} g\right|\right\|_{2} \tag{7.22}
\end{equation*}
$$

We bound the two factors separately. We have

$$
\left\|P_{\mathcal{L}(\mathfrak{T}(\mathfrak{u}))}\left|\mathbf{1}_{\mathcal{E}(\mathfrak{u})} g\right|\right\|_{2}=\left(\sum_{L \in \mathcal{L}(\mathfrak{T}(\mathfrak{u}))} \frac{1}{\mu(L)}\left(\int_{L \cap \mathcal{E}(\mathfrak{u})}|g(y)| \mathrm{d} \mu(y)\right)^{2}\right)^{1 / 2} .
$$

By Cauchy-Schwarz and Lemma 7.12 this is at most

$$
\leq\left(\sum_{L \in \mathcal{L}(\mathfrak{T}(\mathfrak{u}))} 2^{101 a^{3}} \operatorname{dens}_{1}(\mathfrak{T}(\mathfrak{u})) \int_{L \cap \mathcal{E}(\mathfrak{u})}|g(y)|^{2} \mathrm{~d} \mu(y)\right)^{1 / 2}
$$

Since cubes $L \in \mathcal{L}(\mathfrak{T}(\mathfrak{u}))$ are pairwise disjoint by Lemma 7.2, this is

$$
\begin{equation*}
\leq 2^{51 a^{3}} \operatorname{dens}_{1}(\mathfrak{T}(\mathfrak{u}))^{1 / 2}\|g\|_{2} \tag{7.23}
\end{equation*}
$$

Similarly, we have

$$
\begin{equation*}
\left\|P_{\mathcal{J}(\mathfrak{F}(u))}|f|\right\|_{2}=\left(\sum_{J \in \mathcal{J}(\mathfrak{F}(u))} \frac{1}{\mu(J)}\left(\int_{J}|f(y)| \mathrm{d} \mu(y)\right)^{2}\right)^{1 / 2} . \tag{7.24}
\end{equation*}
$$

By Cauchy-Schwarz, this is

$$
\leq\left(\sum_{J \in \mathcal{J}(\mathfrak{z}(u))} \int_{J}|f(y)|^{2} \mathrm{~d} \mu(y)\right)^{1 / 2}
$$

Since cubes in $\mathcal{J}(\mathfrak{T}(\mathfrak{u}))$ are pairwise disjoint by Lemma 7.2 , this at most

$$
\begin{equation*}
\|f\|_{2} \tag{7.25}
\end{equation*}
$$

Combining (7.22), (7.23) and (7.25) and using $a \geq 4$ gives (7.19).
If $f \leq \mathbf{1}_{F}$ then $f=f \mathbf{1}_{F}$, so

$$
\left(\sum_{J \in \mathcal{J}(\mathfrak{Z}(u))} \int_{J}|f(y)|^{2} \mathrm{~d} \mu(y)\right)^{1 / 2}=\left(\sum_{J \in \mathcal{J}(\mathfrak{F}(u))} \int_{J \cap F}|f(y)|^{2} \mathrm{~d} \mu(y)\right)^{1 / 2} .
$$

We estimate as before, using now Lemma 7.13 and Cauchy-Schwarz, and obtain that this is

$$
\leq 2^{100 a^{3}+10} \operatorname{dens}_{2}(\mathfrak{T}(\mathfrak{u}))^{1 / 2}\|f\|_{2} .
$$

Combining this with (7.22), (7.23) and $a \geq 4$ gives (7.20).
Now we prove the two auxiliary estimates.
Proof of Lemma 7.12. If the set on the right hand side is empty, then (7.21) holds. If not, then there exists $\mathfrak{p} \in \mathfrak{T}(\mathfrak{u})$ with $L \cap \mathcal{I}(\mathfrak{p}) \neq \emptyset$.

Suppose first that there exists such $\mathfrak{p}$ with $\mathrm{s}(\mathfrak{p}) \leq s(L)$. Then by (2.8) $\mathcal{I}(\mathfrak{p}) \subset L$, which gives by the definition of $\mathcal{L}(\mathfrak{T}(\mathfrak{u}))$ that $s(L)=-S$ and hence $L=\mathcal{I}(\mathfrak{p})$. Let $\mathfrak{q} \in \mathfrak{T}(\mathfrak{u})$ with $E(\mathfrak{q}) \cap L \neq \emptyset$. Since $s(L)=-S \leq \mathrm{s}(\mathfrak{q})$ it follows from (2.8) that $\mathcal{I}(\mathfrak{p})=L \subset \mathcal{I}(\mathfrak{q})$. We have then by Lemma 2.8

\begin{aligned}
d_{\mathfrak{p}}(\mathcal{Q}(\mathfrak{p}), \mathcal{Q}(\mathfrak{q})) & \leq d_{\mathfrak{p}}(\mathcal{Q}(\mathfrak{p}), \mathcal{Q}(\mathfrak{u}))+d_{\mathfrak{p}}(\mathcal{Q}(\mathfrak{q}), \mathcal{Q}(\mathfrak{u})) \\
& \leq d_{\mathfrak{p}}(\mathcal{Q}(\mathfrak{p}), \mathcal{Q}(\mathfrak{u}))+d_{\mathfrak{q}}(\mathcal{Q}(\mathfrak{q}), \mathcal{Q}(\mathfrak{u})) .
\end{aligned}
$$

Using that $\mathfrak{p}, \mathfrak{q} \in \mathfrak{T}(\mathfrak{u})$ and (2.32), this is at most 8. Using again the triangle inequality and Lemma 2.8, we obtain that for each $q \in B_{\mathfrak{q}}(\mathcal{Q}(\mathfrak{q}), 1)$

$$
d_{\mathfrak{p}}(\mathcal{Q}(\mathfrak{p}), q) \leq d_{\mathfrak{p}}(\mathcal{Q}(\mathfrak{p}), \mathcal{Q}(\mathfrak{q}))+d_{\mathfrak{q}}(\mathcal{Q}(\mathfrak{q}), q) \leq 9 .
$$

Thus $L \cap E(\mathfrak{q}) \subset E_{2}(9, \mathfrak{p})$. We obtain

$$
\mu\left(L \cap \bigcup_{\mathfrak{q} \in \mathfrak{T}(\mathfrak{u})} E(\mathfrak{q})\right) \leq \mu\left(E_{2}(9, \mathfrak{p})\right) .
$$

By the definition of dens ${ }_{1}$, this is bounded by

$$
9^{a} \operatorname{dens}_{1}(\mathfrak{T}(\mathfrak{u})) \mu(\mathcal{I}(\mathfrak{p}))=9^{a} \operatorname{dens}_{1}(\mathfrak{T}(\mathfrak{u})) \mu(L) .
$$

Since $a \geq 4$, (7.21) follows in this case.
Now suppose that for each $\mathfrak{p} \in \mathfrak{T}(\mathfrak{u})$ with $L \cap E(\mathfrak{p}) \neq \emptyset$, we have $s(\mathfrak{p})>$ $s(L)$. Since there exists at least one such $\mathfrak{p}$, there exists in particular at least one cube $L^{\prime \prime} \in \mathcal{D}$ with $L \subset L^{\prime \prime}$ and $s\left(L^{\prime \prime}\right)>s(L)$. By (2.7), there
exists $L^{\prime} \in \mathcal{D}$ with $L \subset L^{\prime}$ and $s\left(L^{\prime}\right)=s(L)+1$. By the definition of $\mathcal{L}(\mathfrak{T}(\mathfrak{u}))$ there exists a tile $\mathfrak{p}^{\prime \prime} \in \mathfrak{T}(\mathfrak{u})$ with $\mathcal{I}\left(\mathfrak{p}^{\prime \prime}\right) \subset L^{\prime}$. Let $\mathfrak{p}^{\prime}$ be the unique tile such that $\mathcal{I}\left(\mathfrak{p}^{\prime}\right)=L^{\prime}$ and such that $\Omega(\mathfrak{u}) \cap \Omega\left(\mathfrak{p}^{\prime}\right) \neq \emptyset$. Since by (2.32) $\mathrm{s}\left(\mathfrak{p}^{\prime}\right)=s\left(L^{\prime}\right) \leq \mathrm{s}(\mathfrak{p})<\mathrm{s}(\mathfrak{u})$, we have by (2.8) and (2.14) that $\Omega(\mathfrak{u}) \subset \Omega\left(\mathfrak{p}^{\prime}\right)$. Let $\mathfrak{q} \in \mathfrak{T}(\mathfrak{u})$ with $L \cap E(\mathfrak{q}) \neq \emptyset$. As shown above, this implies $s(\mathfrak{q}) \geq s\left(L^{\prime}\right)$, so by $(2.8) L^{\prime} \subset \mathcal{I}(\mathfrak{q})$. If $q \in B_{\mathfrak{q}}(\mathcal{Q}(\mathfrak{q}), 1)$, then by a similar calculation as above, using the triangle inequality, Lemma 2.8 and (2.32), we obtain

d_{\mathfrak{p}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{p}^{\prime}\right), q\right) \leq d_{\mathfrak{p}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{p}^{\prime}\right), \mathcal{Q}(\mathfrak{q})\right)+d_{\mathfrak{q}}(\mathcal{Q}(\mathfrak{q}), q) \leq 6
$$

Thus $L \cap E(\mathfrak{q}) \subset E_{2}\left(6, \mathfrak{p}^{\prime}\right)$. Since $\mathcal{I}\left(\mathfrak{p}^{\prime \prime}\right) \subset \mathcal{I}\left(\mathfrak{p}^{\prime}\right) \subset \mathcal{I}(\mathfrak{p})$ and $\mathfrak{p}^{\prime \prime}, \mathfrak{p} \in \mathfrak{T}(\mathfrak{u})$, we have $\mathfrak{p}^{\prime} \in \mathfrak{P}(\mathfrak{T}(\mathfrak{u}))$. We deduce using the definition (2.28) of dens

$$
\mu\left(L \cap \bigcup_{\mathfrak{q} \in \mathfrak{T}(\mathfrak{u})} E(\mathfrak{q})\right) \leq \mu\left(E_{2}\left(6, \mathfrak{q}^{\prime}\right)\right) \leq 6^{a} \operatorname{dens}_{1}(\mathfrak{T}(\mathfrak{u})) \mu\left(L^{\prime}\right)
$$

Using the doubling property (1.5), (2.10), and $a \geq 4$ this is estimated by

$$
6^{a} 2^{100 a^{3}+5} \operatorname{dens}_{1}(\mathfrak{T}(\mathfrak{u})) \mu(L) \leq 2^{101 a^{3}} \operatorname{dens}_{1}(\mathfrak{T}(\mathfrak{u})) \mu(L)
$$

This completes the proof.
Proof of Lemma 7.13. Suppose first that there exists a tile $\mathfrak{p} \in \mathfrak{T}(\mathfrak{u})$ with $\mathcal{I}(\mathfrak{p}) \subset B\left(c(J), 100 D^{s(J)+1}\right)$. By the definition of $\mathcal{J}(\mathfrak{T}(\mathfrak{u}))$, this implies that $s(J)=-S$, and in particular $\mathrm{s}(\mathfrak{p}) \geq s(J)$. Using the triangle inequality and (2.10) it follows that $J \subset B\left(\mathrm{c}(\mathfrak{p}), 200 D^{\mathrm{s}(\mathfrak{p})+1}\right)$. From the doubling property (1.5), $D=2^{100 a^{2}}$ and (2.10), we obtain

$$
\mu(\mathcal{I}(\mathfrak{p})) \leq 2^{100 a^{3}+9} \mu(J)
$$

and hence

$$
\mu\left(B\left(\mathrm{c}(\mathfrak{p}), 200 D^{\mathrm{s}(\mathfrak{p})+1}\right)\right) \leq 2^{200 a^{3}+19} \mu(J)
$$

With the definition (2.29) of $\mathrm{dens}_{2}$ it follows that

$$
\begin{gathered}
\mu(J \cap F) \leq \mu\left(B\left(\mathrm{c}(\mathfrak{p}), 200 D^{\mathrm{s}(\mathfrak{p})+1}\right) \cap F\right) \\
\leq \operatorname{dens}_{2}(\mathfrak{T}(\mathfrak{u})) \mu\left(B\left(\mathrm{c}(\mathfrak{p}), 200 D^{\mathrm{s}(\mathfrak{p})+1}\right)\right) \leq 2^{200 a^{3}+19} \operatorname{dens}_{2}(\mathfrak{T}(\mathfrak{u})) \mu(J)
\end{gathered}
$$

completing the proof in this case.
Now suppose that there does not exist a tile $\mathfrak{p} \in \mathfrak{T}(\mathfrak{u})$ with $\mathcal{I}(\mathfrak{p}) \subset$ $B\left(c(J), 100 D^{s(J)+1}\right)$. If we had $\mathrm{s}(\mathfrak{q}) \leq s(J)$, then by (2.8) and (2.10) $\mathcal{I}(\mathfrak{q}) \subset J \subset B\left(c(J), 100 D^{s(J)+1}\right)$, contradicting our assumption. Thus $\mathrm{s}(\mathfrak{q})>s(J)$. Then, by (2.7) and (2.8), there exists some cube $J^{\prime} \in \mathcal{D}$ with $s\left(J^{\prime}\right)=s(J)+1$ and $J \subset J^{\prime}$. By definition of $\mathcal{J}(\mathfrak{T}(\mathfrak{u}))$ there exists some $\mathfrak{p} \in \mathfrak{T}(\mathfrak{u})$ such that $\mathcal{I}(\mathfrak{p}) \subset B\left(c\left(J^{\prime}\right), 100 D^{s\left(J^{\prime}\right)+1}\right)$. From the doubling property (1.5), $D=2^{100 a^{2}}$ and (2.10), we obtain

$$
\begin{equation*}
\mu\left(B\left(\mathrm{c}(\mathfrak{p}), 4 D^{\mathrm{s}(\mathfrak{p})}\right)\right) \leq 2^{4 a} \mu(\mathcal{I}(\mathfrak{p})) \leq 2^{200 a^{3}+14} \mu(J) \tag{7.26}
\end{equation*}
$$

If $J \subset B\left(\mathrm{c}(\mathfrak{p}), 4 D^{\mathrm{s}(\mathfrak{p})}\right)$, then we bound

$$
\mu(J \cap F) \leq \mu\left(B\left(\mathrm{c}(\mathfrak{p}), 4 D^{\mathrm{s}(\mathfrak{p})}\right) \cap F\right)
$$

and use the definition (2.29)

\leq \operatorname{dens}_{2}(\mathfrak{T}(\mathfrak{u})) \mu\left(B\left(\mathrm{c}(\mathfrak{p}), 4 D^{\mathrm{s}(\mathfrak{p})}\right)\right) \leq 2^{200 a^{3}+14} \mu(J)
$$

From now on we assume $J \not \subset B\left(\mathrm{c}(\mathfrak{p}), 4 D^{\mathrm{s}(\mathfrak{p})}\right)$. Since

$$
\mathrm{c}(\mathfrak{p}) \in \mathcal{I}(\mathfrak{p}) \subset B\left(c\left(J^{\prime}\right), 100 D^{s\left(J^{\prime}\right)+1}\right)
$$

we have by (2.10) and the triangle inequality

In particular this implies $104 D^{s\left(J^{\prime}\right)+1}>4 D^{s(\mathfrak{p})}$. By the triangle inequality we also have

From here one completes the proof as in the other cases.
7.4. Almost orthogonality of separated trees. The main result of this subsection is the almost orthogonality estimate for operators associated to distinct trees in a forest in Lemma 7.17 below. We will deduce it from Lemmas 7.18 and 7.19, which are proven in Subsections 7.5 and 7.6 , respectively. Before stating it, we introduce some relevant notation.

The adjoint of the operator $T_{\mathfrak{p}}$ defined in (2.21) is given by

Lemma 7.14 (adjoint tile support). For each $\mathfrak{p} \in \mathfrak{P}$, we have

For each $\mathfrak{u} \in \mathfrak{U}$ and each $\mathfrak{p} \in \mathfrak{T}(\mathfrak{u})$, we have

T_{\mathfrak{p}}^{*} g=\mathbf{1}_{\mathcal{I}(\mathfrak{u})} T_{\mathfrak{p}}^{*} \mathbf{1}_{\mathcal{I}(\mathfrak{u})} g .

Proof. By (2.32), $E(\mathfrak{p}) \subset \mathcal{I}(\mathfrak{p}) \subset \mathcal{I}(\mathfrak{u})$. Thus by (7.27)

T_{\mathfrak{p}}^{*} g(x)=T_{\mathfrak{p}}^{*}\left(\mathbf{1}_{\mathcal{I}(\mathfrak{p})} g\right)(x) \\
=\int_{E(\mathfrak{p})} \overline{K_{\mathrm{s}(\mathfrak{p})}(y, x)} e(-Q(y)(x)+Q(y)(y)) \mathbf{1}_{\mathcal{I}(\mathfrak{p})}(y) g(y) \mathrm{d} \mu(y)
\end{gathered}
$$

If this integral is not 0 , then there exists $y \in \mathcal{I}(\mathfrak{p})$ such that $K_{\mathrm{s}(\mathfrak{p})}(y, x) \neq 0$. By (2.48), (2.10) and the triangle inequality, it follows that

x \in B\left(\mathrm{c}(\mathfrak{p}), 5 D^{\mathrm{s}(\mathfrak{p})}\right) .

Thus

T_{\mathfrak{p}}^{*} g(x)=\mathbf{1}_{B\left(c(\mathfrak{p}), 5 D^{\mathrm{s}(\mathfrak{p})}\right)}(x) T_{\mathfrak{p}}^{*}\left(\mathbf{1}_{\mathcal{I}(\mathfrak{p})} g\right)(x) .
$$

The second claimed equation follows now since $\mathcal{I}(\mathfrak{p}) \subset \mathcal{I}(\mathfrak{u})$ and by (2.37) $B\left(\mathrm{c}(\mathfrak{p}), 5 D^{\mathrm{s}(\mathfrak{p})}\right) \subset \mathcal{I}(\mathfrak{u})$.
Lemma 7.15 (adjoint tree estimate). For all bounded $g$ with bounded support, we have that

\left\|\sum_{\mathfrak{p} \in \mathfrak{T}(\mathfrak{u})} T_{\mathfrak{p}}^{*} g\right\|_{2} \leq 2^{155 a^{3}} \operatorname{dens}_{1}(\mathfrak{T}(\mathfrak{u}))^{1 / 2}\|g\|_{2} .
$$

Proof. By Cauchy-Schwarz and Lemma 7.11, we have for all bounded $f, g$ with bounded support that

$$
\begin{align*}
& \left|\int_{X} \overline{\sum_{\mathfrak{p} \in \mathfrak{T}(\mathfrak{u})} T_{\mathfrak{p}}^{*} g} f \mathrm{~d} \mu\right|=\left|\int_{X} g \sum_{\mathfrak{p} \in \mathfrak{T}(\mathfrak{u})} T_{\mathfrak{p}} f \mathrm{~d} \mu\right| \\
& \quad \leq 2^{155 a^{3}} \operatorname{dens}_{1}(\mathfrak{T}(\mathfrak{u}))^{1 / 2}\|g\|_{2}\|f\|_{2} . \tag{7.28}
\end{align*}
$$

Let $f=\sum_{\mathfrak{p} \in \mathfrak{T}(\mathfrak{u})} T_{\mathfrak{p}}^{*} g$. If $g$ is bounded and has bounded support, then the same is true for $f$. In particular $\|f\|_{2}<\infty$. Dividing (7.28) by $\|f\|_{2}$ completes the proof.

We define

S_{2, \mathfrak{u}} g:=\left|\sum_{\mathfrak{p} \in \mathfrak{T}(\mathfrak{u})} T_{\mathfrak{p}}^{*} g\right|+M_{\mathcal{B}, 1} g+|g|

Lemma 7.16 (adjoint tree control). We have for all bounded $g$ with bounded support

$$
\left\|S_{2, u} g\right\|_{2} \leq 2^{156 a^{3}}\|g\|_{2}
$$

Proof. This follows immediately from Minkowski's inequality, Proposition 2.6and Lemma 7.15, using that $a \geq 4$.

Now we are ready to state the main result of this subsection.
Lemma 7.17 (correlation separated trees). For any $\mathfrak{u}_{1} \neq \mathfrak{u}_{2} \in \mathfrak{U}$ and all bounded $g_{1}, g_{2}$ with bounded support, we have

& \leq 2^{550 a^{3}-3 n} \prod_{j=1}^{2}\left\|S_{2, \mathfrak{u}_{j}} g_{j}\right\|_{L^{2}\left(\mathcal{I}\left(u_{1}\right) \cap \mathcal{I}\left(u_{2}\right)\right)} . \tag{7.30}
\end{align*}
$$

Proof of Lemma 7.17. By Lemma 7.14 and (2.8), the left hand side (7.29) is 0 unless $\mathcal{I}\left(\mathfrak{u}_{1}\right) \subset \mathcal{I}\left(\mathfrak{u}_{2}\right)$ or $\mathcal{I}\left(\mathfrak{u}_{2}\right) \subset \mathcal{I}\left(\mathfrak{u}_{1}\right)$. Without loss of generality we assume that $\mathcal{I}\left(\mathfrak{u}_{1}\right) \subset \mathcal{I}\left(\mathfrak{u}_{2}\right)$.

Define

Lemma 7.17 follows by combining the definition (2.3) of $Z$ with the following two lemmas.

Lemma 7.18 (correlation distant tree parts). We have for all $\mathfrak{u}_{1} \neq \mathfrak{u}_{2} \in \mathfrak{U}$ with $\mathcal{I}\left(\mathfrak{u}_{1}\right) \subset \mathcal{I}\left(\mathfrak{u}_{2}\right)$ and all bounded $g_{1}, g_{2}$ with bounded support

\begin{align*}
& \quad\left|\int_{X} \sum_{\mathfrak{p}_{1} \in \mathfrak{T}\left(\mathfrak{u}_{1}\right)} \sum_{\mathfrak{p}_{2} \in \mathfrak{T}\left(\mathfrak{u}_{2}\right) \cap \mathfrak{S}} T_{\mathfrak{p}_{1}}^{*} g_{1} \overline{T_{\mathfrak{p}_{2}}^{*} g_{2}} \mathrm{~d} \mu\right|  \tag{7.32}\\
& \leq 2^{541 a^{3}} 2^{-Z n /\left(4 a^{2}+2 a^{3}\right)} \prod_{j=1}^{2}\left\|S_{2, \mathfrak{u}_{j}} g_{j}\right\|_{L^{2}\left(\mathcal{I}\left(\mathfrak{u}_{1}\right)\right)} . \tag{7.33}
\end{align*}
$$

Lemma 7.19 (correlation near tree parts). We have for all $\mathfrak{u}_{1} \neq \mathfrak{u}_{2} \in \mathfrak{U}$ with $\mathcal{I}\left(\mathfrak{u}_{1}\right) \subset \mathcal{I}\left(\mathfrak{u}_{2}\right)$ and all bounded $g_{1}, g_{2}$ with bounded support

$$
\begin{align*}
& \mid \int_{X_{\mathfrak{p}_{1} \in \mathfrak{Z}\left(u_{1}\right)} \sum_{\mathfrak{p}_{2} \in \mathfrak{Z}\left(\mathfrak{u}_{2}\right) \backslash \mathfrak{S}} T_{\mathfrak{p}_{1}}^{*} g_{1} \overline{T_{\mathfrak{p}_{2}}^{*} g_{2}} \mathrm{~d} \mu \mid}^{\leq 2^{222 a^{3}} 2^{-Z n 2^{-10 a}} \prod_{j=1}^{2}\left\|S_{2, \mathfrak{u}_{j}} g_{j}\right\|_{L^{2}\left(\mathcal{I}\left(\mathfrak{u}_{1}\right)\right.} .} \tag{7.34}
\end{align*}
$$

In the proofs of both lemmas, we will need the following observation.
Lemma 7.20 (overlap implies distance). Let $\mathfrak{u}_{1} \neq \mathfrak{u}_{2} \in \mathfrak{U}$ with $\mathcal{I}\left(\mathfrak{u}_{1}\right) \subset$ $\mathcal{I}\left(\mathfrak{u}_{2}\right)$. If $\mathfrak{p} \in \mathfrak{T}\left(\mathfrak{u}_{1}\right) \cup \mathfrak{T}\left(\mathfrak{u}_{2}\right)$ with $\mathcal{I}(\mathfrak{p}) \cap \mathcal{I}\left(\mathfrak{u}_{1}\right) \neq \emptyset$, then $\mathfrak{p} \in \mathfrak{S}$. In particular, we have $\mathfrak{T}\left(\mathfrak{u}_{1}\right) \subset \mathfrak{S}$.

Proof. Suppose first that $\mathfrak{p} \in \mathfrak{T}\left(\mathfrak{u}_{1}\right)$. Then $\mathcal{I}(\mathfrak{p}) \subset \mathcal{I}\left(\mathfrak{u}_{1}\right) \subset \mathcal{I}\left(\mathfrak{u}_{2}\right)$, by (2.32). Thus we have by the separation condition (2.36), (2.15), (2.32) and the triangle inequality

& \geq 2^{Z(n+1)}-4 \\
& \geq 2^{Z n},
\end{aligned}
$$

using that $Z=2^{12 a} \geq 4$. Hence $\mathfrak{p} \in \mathfrak{S}$.
Suppose now that $\mathfrak{p} \in \mathfrak{T}\left(\mathfrak{u}_{2}\right)$. If $\mathcal{I}(\mathfrak{p}) \subset \mathcal{I}\left(\mathfrak{u}_{1}\right)$, then the same argument as above with $\mathfrak{u}_{1}$ and $\mathfrak{u}_{2}$ swapped shows $\mathfrak{p} \in \mathfrak{S}$. If $\mathcal{I}(\mathfrak{p}) \not \subset \mathcal{I}\left(\mathfrak{u}_{1}\right)$ then, by (2.8), $\mathcal{I}\left(\mathfrak{u}_{1}\right) \subset \mathcal{I}(\mathfrak{p})$. Pick $\mathfrak{p}^{\prime} \in \mathfrak{T}\left(\mathfrak{u}_{1}\right)$, we have $\mathcal{I}\left(\mathfrak{p}^{\prime}\right) \subset \mathcal{I}\left(\mathfrak{u}_{1}\right) \subset \mathcal{I}(\mathfrak{p})$. Hence, by Lemma 2.8 and the first paragraph

To simplify the notation, we will write at various places throughout the proof of Lemmas 7.18 and 7.19 for a subset $\mathfrak{C} \subset \mathfrak{P}$

7.5. Proof of Lemma 7.18: Tiles with large separation. Lemma 7.18 follows from the van der Corput estimate in Proposition 2.5. We apply this proposition in Subsubsection 7.5.3. To prepare this application, we first, in Subsubsection 7.5.1, construct a suitable partition of unity, and show then, in Subsubsection 7.5.2 the Hölder estimates needed to apply Proposition 2.5.
7.5.1. A partition of unity. Define

But if $J \notin \mathcal{J}^{\prime}$, then by (2.8) $\mathcal{I}\left(\mathfrak{u}_{1}\right) \subsetneq J$. Pick $\mathfrak{p} \in \mathfrak{T}\left(\mathfrak{u}_{1}\right) \subset \mathfrak{S}$. Then $\mathcal{I}(\mathfrak{p}) \subsetneq J$. This contradicts the definition of $\mathcal{J}(\mathfrak{S})$.

For cubes $J \in \mathcal{D}$, denote

The main result of this subsubsection is the following.

0 \leq \chi_{J}(y) \leq \mathbf{1}_{B(J)}(y)  \tag{7.38}\\
\left|\chi_{J}(y)-\chi_{J}\left(y^{\prime}\right)\right| \leq 2^{226 a^{3}} \frac{\rho\left(y, y^{\prime}\right)}{D^{s(J)}} \tag{7.39}
\end{gather*}
$$

In the proof, we will use the following auxiliary lemma.
Lemma 7.23 (moderate scale change). If $J, J^{\prime} \in \mathcal{J}^{\prime}$ with

then $\left|s(J)-s\left(J^{\prime}\right)\right| \leq 1$.
Proof of Lemma 7.22. For each cube $J \in \mathcal{J}$ let

Then, due to (2.37) and (7.36), the properties (7.37) and (7.38) are clearly true. Estimate (7.39) follows from (7.38) if $y, y^{\prime} \notin B(J)$. Thus we can assume that $y \in B(J)$. We have by the triangle inequality

Since $\tilde{\chi}_{J}(z) \geq 4$ for all $z \in B(c(J), 4) \supset J$ and by Lemma 7.21 , we have that $a(z) \geq 4$ for all $z \in \mathcal{I}\left(\mathfrak{u}_{1}\right)$. So we can estimate the above further by

If $y^{\prime} \notin B\left(\mathrm{c}(\mathfrak{p}), 8 D^{\mathrm{s}(\mathfrak{p})}\right)$ then the second summand vanishes. Else, we can estimate the above, using also that $\left|\tilde{\chi}_{J}\left(y^{\prime}\right)\right| \leq 8$, by

\leq 2^{-2}\left|\tilde{\chi}_{J}(y)-\tilde{\chi}_{J}\left(y^{\prime}\right)\right|+2 \sum_{\substack{J^{\prime} \in \mathcal{J}^{\prime} \\ B\left(c\left(J^{\prime}\right), 8 D^{s\left(J^{\prime}\right)}\right) \cap B\left(c(J), 8 D^{s(J)}\right) \neq \emptyset}}\left|\tilde{\chi}_{J^{\prime}}(y)-\tilde{\chi}_{J^{\prime}}\left(y^{\prime}\right)\right|
$$

By the triangle inequality, we have for all dyadic cubes $I \in \mathcal{J}^{\prime}$

\left|\tilde{\chi}_{I}(y)-\tilde{\chi}_{I}\left(y^{\prime}\right)\right| \leq \rho\left(y, y^{\prime}\right) D^{-s(I)}
$$

Using this above, we obtain

\left|\chi_{J}(y)-\chi_{J}\left(y^{\prime}\right)\right| \leq \rho\left(y, y^{\prime}\right)\left(\frac{1}{4} D^{-s(J)}+2 \sum_{\substack{J^{\prime} \in \mathcal{J}^{\prime} \\ B\left(J^{\prime}\right) \cap B(J) \neq \emptyset}} D^{-s\left(J^{\prime}\right)}\right)
$$

By Lemma 7.23, this is at most

By (2.10) and Lemma 7.21, the balls $B\left(c\left(J^{\prime}\right), \frac{1}{4} D^{s\left(J^{\prime}\right)}\right)$ are pairwise disjoint, so by Lemma 7.23 the balls $B\left(c\left(J^{\prime}\right), \frac{1}{4} D^{s(J)-1}\right)$ are also disjoint. By the triangle inequality and Lemma 7.23 , each such ball for $J^{\prime}$ in the set of the last display is contained in

By the doubling property (1.5), we further have

\left|\left\{J^{\prime} \in \mathcal{J}^{\prime}: B\left(J^{\prime}\right) \cap B(J) \neq \emptyset\right\}\right| \leq 2^{200 a^{3}+6}
$$

Recalling that $D=2^{100 a^{2}}$, we obtain

\frac{1}{4}+2 D\left|\left\{J^{\prime} \in \mathcal{J}^{\prime}: B\left(J^{\prime}\right) \cap B(J) \neq \emptyset\right\}\right| \leq 2^{200 a^{3}+100 a^{2}+8}
$$

Since $a \geq 4$, (7.39) follows.
Proof of Lemma 7.23. Suppose that $s\left(J^{\prime}\right)<s(J)-1$. Then $s(J)>-S$. Thus, by the definition of $\mathcal{J}^{\prime}$ there exists no $\mathfrak{p} \in \mathfrak{S}$ with

Since $s\left(J^{\prime}\right)<s(J)$ and $J^{\prime}, J \subset \mathcal{I}\left(\mathfrak{u}_{1}\right)$, we have $J^{\prime} \subsetneq \mathcal{I}\left(\mathfrak{u}_{1}\right)$. By (2.7), (2.8) there exists a cube $J^{\prime \prime} \in \mathcal{D}$ with $J \subset J^{\prime \prime}$ and $s\left(J^{\prime \prime}\right)=s\left(J^{\prime}\right)+1$. By the definition of $\mathcal{J}^{\prime}$, there exists a tile $\mathfrak{p} \in \mathfrak{S}$ with

$$
\begin{equation*}
\mathcal{I}(\mathfrak{p}) \subset B\left(c\left(J^{\prime \prime}\right), 100 D^{s\left(J^{\prime}\right)+2}\right) \tag{7.41}
\end{equation*}
$$

But by the triangle inequality and (2.1), we have

$$
B\left(c\left(J^{\prime \prime}\right), 100 D^{s\left(J^{\prime}\right)+2}\right) \subset B\left(c(J), 100 D^{s(J)+1}\right)
$$

which contradicts (7.40) and (7.41).
7.5.2. Hölder estimates for adjoint tree operators. Let $g_{1}, g_{2}: X \rightarrow \mathbb{C}$ be bounded with bounded support. Define for $J \in \mathcal{J}^{\prime}$

$$
\begin{equation*}
h_{J}(y):=\chi_{J}(y) \cdot\left(e\left(\mathcal{Q}\left(\mathfrak{u}_{1}\right)(y)\right) T_{\mathfrak{T}\left(\mathfrak{u}_{1}\right)}^{*} g_{1}(y)\right) \cdot \overline{\left(e\left(\mathcal{Q}\left(\mathfrak{u}_{2}\right)(y)\right) T_{\mathfrak{T}\left(\mathfrak{u}_{2}\right) \cap \mathfrak{S}}^{*} g_{2}(y)\right)} . \tag{7.42}
\end{equation*}
$$

The main result of this subsubsection is the following $\tau$-Hölder estimate for $h_{J}$, where $\tau=1 / a$.

Lemma 7.24 (Holder correlation tree). We have for all $J \in \mathcal{J}^{\prime}$ that

$$
\begin{equation*}
\left\|h_{J}\right\|_{C^{\tau}\left(B\left(c(J), 8 D^{s(J)}\right)\right)} \leq 2^{535 a^{3}} \prod_{j=1,2}\left(\inf _{B\left(c(J), \frac{1}{8} D^{s(J)}\right)}\left|T_{\mathfrak{Z}\left(u_{j}\right)}^{*} g_{j}\right|+\inf _{J} M_{\mathcal{B}, 1}\left|g_{j}\right|\right) . \tag{7.43}
\end{equation*}
$$

We will prove this lemma at the end of this section, after establishing several auxiliary results.

We begin with the following Hölder continuity estimate for adjoints of operators associated to tiles.

Lemma 7.25 (Holder correlation tile). Let $\mathfrak{u} \in \mathfrak{U}$ and $\mathfrak{p} \in \mathfrak{T}(\mathfrak{u})$. Then for all $y, y^{\prime} \in X$ and all bounded $g$ with bounded support, we have

$$
\begin{gather*}
\left|e(\mathcal{Q}(\mathfrak{u})(y)) T_{\mathfrak{p}}^{*} g(y)-e\left(\mathcal{Q}(\mathfrak{u})\left(y^{\prime}\right)\right) T_{\mathfrak{p}}^{*} g\left(y^{\prime}\right)\right| \\
\leq \frac{2^{151 a^{3}}}{\mu\left(B\left(\mathrm{c}(\mathfrak{p}), 4 D^{\mathrm{s}(\mathfrak{p})}\right)\right)}\left(\frac{\rho\left(y, y^{\prime}\right)}{D^{\mathrm{s}(\mathfrak{p})}}\right)^{1 / a} \int_{E(\mathfrak{p})}|g(x)| \mathrm{d} \mu(x) . \tag{7.44}
\end{gather*}
$$

Proof. By (7.27), we have

$$
\begin{gather*}
\left|e(\mathcal{Q}(\mathfrak{u})(y)) T_{\mathfrak{p}}^{*} g(y)-e\left(\mathcal{Q}(\mathfrak{u})\left(y^{\prime}\right)\right) T_{\mathfrak{p}}^{*} g\left(y^{\prime}\right)\right| \\
=\mid \int_{E(\mathfrak{p})} e(Q(x)(x)-Q(x)(y)+\mathcal{Q}(\mathfrak{u})(y)) \overline{K_{\mathbf{s}(\mathfrak{p})}(x, y)} g(x) \\
-e\left(Q(x)(x)-Q(x)\left(y^{\prime}\right)+\mathcal{Q}(\mathfrak{u})\left(y^{\prime}\right)\right) \overline{K_{\mathrm{s}(\mathfrak{p})}\left(x, y^{\prime}\right)} g(x) \mathrm{d} \mu(x) \mid \\
\leq \int_{E(\mathfrak{p})}|g(x)| \mid e\left(Q(x)(y)-Q(x)\left(y^{\prime}\right)-\mathcal{Q}(\mathfrak{u})(y)+\mathcal{Q}(\mathfrak{u})\left(y^{\prime}\right)\right) \overline{K_{\mathbf{s}(\mathfrak{p})}(x, y)} \\
\quad-\overline{K_{\mathrm{s}(\mathfrak{p})}\left(x, y^{\prime}\right) \mid} \mathrm{d} \mu(x) \\
\leq \int_{E(\mathfrak{p})}|g(x)|\left|e\left(-Q(x)(y)+Q(x)\left(y^{\prime}\right)+\mathcal{Q}(\mathfrak{u})(y)-\mathcal{Q}(\mathfrak{u})\left(y^{\prime}\right)\right)-1\right| \\
\quad+\int_{E(\mathfrak{p})}^{|g(x)|\left|\overline{K_{\mathrm{s}(\mathfrak{p})}(x, y)}-\overline{K_{\mathrm{s}(\mathfrak{p})}\left(x, y^{\prime}\right)}\right| \mathrm{d} \mu(x) .} \tag{7.45}
\end{gather*}
$$

By the oscillation estimate (1.7), we have

$$
\begin{gather*}
\left|-Q(x)(y)+Q(x)\left(y^{\prime}\right)+\mathcal{Q}(\mathfrak{u})(y)-\mathcal{Q}(\mathfrak{u})\left(y^{\prime}\right)\right| \\
\leq d_{B\left(y, \rho\left(y, y^{\prime}\right)\right)}(Q(x), \mathcal{Q}(\mathfrak{u})) . \tag{7.47}
\end{gather*}
$$

Suppose that $y, y^{\prime} \in B\left(\mathrm{c}(\mathfrak{p}), 5 D^{\mathrm{s}(\mathfrak{p})}\right)$, so that $\rho\left(y, y^{\prime}\right) \leq 10 D^{\mathrm{s}(\mathfrak{p})}$. Let $k \in \mathbb{Z}$ be such that $2^{a k} \rho\left(y, y^{\prime}\right) \leq 10 D^{\mathrm{s}(\mathfrak{p})}$ but $2^{a(k+1)} \rho\left(y, y^{\prime}\right)>10 D^{\mathrm{s}(\mathfrak{p})}$. In particular, $k \geq 0$. Then, using (1.8), we can bound (7.47) from above by

$$
2^{-k} d_{B\left(c(\mathfrak{p}), 10 D^{s(\mathfrak{p})}\right)}(Q(x), \mathcal{Q}(\mathfrak{u})) \leq 2^{6 a-k} d_{\mathfrak{p}}(Q(x), \mathcal{Q}(\mathfrak{u})) .
$$

Since $x \in E(\mathfrak{p})$ we have $Q(x) \in \Omega(\mathfrak{p}) \subset B_{\mathfrak{p}}(\mathcal{Q}(\mathfrak{p}), 1)$, and since $\mathfrak{p} \in \mathfrak{T}(\mathfrak{u})$ we have $\mathcal{Q}(\mathfrak{u}) \in B_{\mathfrak{p}}(\mathcal{Q}(\mathfrak{p}), 4)$, so this is estimated by

\leq 5 \cdot 2^{6 a-k}
$$

By definition of $k$, we have

$$
k \leq \frac{1}{a} \log _{2}\left(\frac{10 D^{\mathrm{s}(\mathfrak{p})}}{\rho\left(y, y^{\prime}\right)}\right)
$$

which gives

$$
\begin{equation*}
\left|-Q(x)(y)+Q(x)\left(y^{\prime}\right)+\mathcal{Q}(\mathfrak{u})(y)-\mathcal{Q}(\mathfrak{u})\left(y^{\prime}\right)\right| \leq 5 \cdot 2^{6 a}\left(\frac{\rho\left(y, y^{\prime}\right)}{10 D^{\mathrm{s}(\mathfrak{p})}}\right)^{1 / a} \tag{7.48}
\end{equation*}
$$

For all $x \in \mathcal{I}(\mathfrak{p})$, we have by (1.5) that

$$
\mu\left(B\left(x, D^{\mathrm{s}(\mathfrak{p})}\right)\right) \geq 2^{-3 a} \mu\left(B\left(\mathrm{c}(\mathfrak{p}), 4 D^{\mathrm{s}(\mathfrak{p})}\right)\right)
$$

Combining the above with $(2.49),(2.50)$ and (7.48), we obtain

$$
\begin{gathered}
(7.45)+(7.46) \leq \frac{2^{3 a}}{\mu\left(B\left(\mathrm{c}(\mathfrak{p}), 4 D^{\mathrm{s}(\mathfrak{p})}\right)\right)} \int_{E(\mathfrak{p})}|g(x)| \mathrm{d} \mu(x) \times \\
\left(2^{102 a^{3}} \cdot 5 \cdot 2^{6 a}\left(\frac{\rho\left(y, y^{\prime}\right)}{D^{\mathrm{s}(\mathfrak{p})}}\right)^{1 / a}+2^{150 a^{3}}\left(\frac{\rho\left(y, y^{\prime}\right)}{D^{\mathrm{s}(\mathfrak{p})}}\right)^{1 / a}\right)
\end{gathered}
$$

Since $\rho\left(y, y^{\prime}\right) \leq 10 D^{\mathbf{s}(\mathfrak{p})}$, we conclude

$$
(7.45)+(7.46) \leq \frac{2^{151 a^{3}}}{\mu\left(B\left(\mathrm{c}(\mathfrak{p}), 4 D^{\mathrm{s}(\mathfrak{p})}\right)\right)}\left(\frac{\rho\left(y, y^{\prime}\right)}{D^{\mathrm{s}(\mathfrak{p})}}\right)^{1 / a} \int_{E(\mathfrak{p})}|g(x)| \mathrm{d} \mu(x) .
$$

Next, if $y, y^{\prime} \notin B\left(\mathrm{c}(\mathfrak{p}), 5 D^{\mathrm{s}(\mathfrak{p})}\right)$, then $T_{\mathfrak{p}}^{*} g(y)=T_{\mathfrak{p}}^{*} g\left(y^{\prime}\right)=0$, by Lemma 7.14. Then (7.44) holds.

Finally, if $y \in B\left(\mathrm{c}(\mathfrak{p}), 5 D^{\mathrm{s}(\mathfrak{p})}\right)$ and $y^{\prime} \notin B\left(\mathrm{c}(\mathfrak{p}), 5 D^{\mathrm{s}(\mathfrak{p})}\right)$, then

$$
\begin{aligned}
& \left|e(\mathcal{Q}(\mathfrak{u})(y)) T_{\mathfrak{p}}^{*} g(y)-e\left(\mathcal{Q}(\mathfrak{u})\left(y^{\prime}\right)\right) T_{\mathfrak{p}}^{*} g\left(y^{\prime}\right)\right|=\left|T_{\mathfrak{p}}^{*} g(y)\right| \\
& \quad \leq \int_{E(\mathfrak{p})}\left|K_{\mathrm{s}(\mathfrak{p})}(x, y)\right||g(x)| \mathrm{d} \mu(x)
\end{aligned}
$$

By the same argument used to prove (2.52), this is bounded by

$$
\begin{equation*}
\leq 2^{102 a^{3}} \int_{E(\mathfrak{p})} \frac{1}{\mu\left(B\left(x, D^{s}\right)\right)} \psi\left(D^{-s} \rho(x, y)\right)|g(x)| \mathrm{d} \mu(x) . \tag{7.49}
\end{equation*}
$$

It follows from the definition of $\psi$ that

$$
\psi(x) \leq \max \left\{0,(2-4 x)^{1 / a}\right\}
$$

Now for all $x \in E(\mathfrak{p})$, it follows by the triangle inequality and (2.10) that

$$
\begin{aligned}
2-4 D^{-\mathrm{s}(\mathfrak{p})} \rho(x, y) \leq 2- & 4 D^{-\mathrm{s}(\mathfrak{p})} \rho(y, \mathrm{c}(\mathfrak{p}))+4 D^{-\mathrm{s}(\mathfrak{p})} \rho(x, \mathrm{c}(\mathfrak{p})) \\
& \leq 18-4 D^{-\mathrm{s}(\mathfrak{p})} \rho(y, \mathrm{c}(\mathfrak{p})) \leq 4 D^{-\mathrm{s}(\mathfrak{p})} \rho\left(y, y^{\prime}\right)-2
\end{aligned}
$$

Combining the above with the previous estimate on $\psi$, we get

$$
\psi\left(D^{-\mathrm{s}(\mathfrak{p})} \rho(x, y)\right) \leq 4\left(D^{-\mathrm{s}(\mathfrak{p})} \rho\left(y, y^{\prime}\right)\right)^{1 / a}
$$

Further, we obtain from the doubling property (1.5) and (2.10) that

\mu\left(B\left(x, D^{s}\right)\right) \geq 2^{-2 a} \mu\left(\mathrm{c}(\mathfrak{p}), 4 D^{s}\right)
$$

Plugging this into (7.49) and using $a \geq 4$, we get

\left|T_{\mathfrak{p}}^{*} g(y)\right| \leq \frac{2^{103 a^{3}}}{\mu\left(B\left(\mathrm{c}(\mathfrak{p}), 4 D^{\mathrm{s}(\mathfrak{p})}\right)\right)}\left(\frac{\rho\left(y, y^{\prime}\right)}{D^{\mathrm{s}(\mathfrak{p})}}\right)^{1 / a} \int_{E(\mathfrak{p})}|g(x)| \mathrm{d} \mu(y)
$$

which completes the proof of the lemma.
Recall that

$$
B(J):=B\left(c(J), 8 D^{s(J)}\right)
$$

We also denote

$$
B^{\circ}(J):=B\left(c(J), \frac{1}{8} D^{s(J)}\right)
$$

Lemma 7.26 (limited scale impact). Let $\mathfrak{p} \in \mathfrak{T}_{2} \backslash \mathfrak{S}, J \in \mathcal{J}^{\prime}$ and suppose that

$$
B(\mathcal{I}(\mathfrak{p})) \cap B^{\circ}(J) \neq \emptyset
$$

Then

$$
s(J) \leq \mathrm{s}(\mathfrak{p}) \leq s(J)+10 a^{2}+2
$$

Proof. For the first estimate, assume that $\mathrm{s}(\mathfrak{p})<s(J)$, then in particular $\mathrm{s}(\mathfrak{p}) \leq \mathrm{s}\left(\mathfrak{u}_{1}\right)$. Since $\mathfrak{p} \notin \mathfrak{S}$, we have by Lemma 7.20 that $\mathcal{I}(\mathfrak{p}) \cap \mathcal{I}\left(\mathfrak{u}_{1}\right)=\emptyset$. Since $B\left(c(J), \frac{1}{4} D^{s(J)}\right) \subset \mathcal{I}(J) \subset \mathcal{I}\left(\mathfrak{u}_{1}\right)$, this implies

\rho(c(J), \mathrm{c}(\mathfrak{p})) \geq \frac{1}{4} D^{s(J)} .
$$

On the other hand

by our assumption. Thus $D^{s(\mathfrak{p})} \geq 64 D^{s(J)}$, which contradicts (2.1) and $a \geq 4$.

For the second estimate, assume that $\mathrm{s}(\mathfrak{p})>s(J)+10 a^{2}+2$. Since $J \in \mathcal{J}^{\prime}$, we have $J \subsetneq \mathcal{I}\left(\mathfrak{u}_{1}\right)$. Thus there exists $J^{\prime} \in \mathcal{D}$ with $J \subset J^{\prime}$ and $s\left(J^{\prime}\right)=s(J)+1$, by (2.7) and (2.8). By definition of $\mathcal{J}^{\prime}$, there exists some $\mathfrak{p}^{\prime} \in \mathfrak{S}$ such that $\mathcal{I}\left(\mathfrak{p}^{\prime}\right) \subset B\left(c\left(J^{\prime}\right), 100 D^{s(J)+2}\right)$. On the other hand, since $B(\mathcal{I}(\mathfrak{p})) \cap B^{\circ}(J) \neq \emptyset$, by the triangle inequality it holds that

Using the definition of $\mathfrak{S}$, we have

2^{Z n / 2} \leq d_{\mathfrak{p}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{u}_{1}\right), \mathcal{Q}\left(\mathfrak{u}_{2}\right)\right) \leq d_{B\left(c\left(J^{\prime}\right), 100 D^{s(J)+2}\right)}\left(\mathcal{Q}\left(\mathfrak{u}_{1}\right), \mathcal{Q}\left(\mathfrak{u}_{2}\right)\right)
$$

By (1.10), this is

$$
\begin{aligned}
& \leq 2^{-10 a} d_{B\left(c\left(J^{\prime}\right), 100 D^{\left.s(J)+10 a^{2}+2\right)}\right.}\left(\mathcal{Q}\left(\mathfrak{u}_{1}\right), \mathcal{Q}\left(\mathfrak{u}_{2}\right)\right) \\
& \leq 2^{-10 a} d_{B\left(c(\mathfrak{p}), 10 D^{s(p)}\right)}\left(\mathcal{Q}\left(\mathfrak{u}_{1}\right), \mathcal{Q}\left(\mathfrak{u}_{2}\right)\right)
\end{aligned}
$$

and by (1.8) and the definition of $\mathfrak{S}$

$$
\leq 2^{-4 a} d_{\mathfrak{p}}\left(\mathcal{Q}\left(\mathfrak{u}_{1}\right), \mathcal{Q}\left(\mathfrak{u}_{2}\right)\right) \leq 2^{-4 a} 2^{Z n / 2}
$$

This is a contradiction, the second estimate follows.
Lemma 7.27 (local tree control). For all $J \in \mathcal{J}^{\prime}$ and all bounded $g$ with bounded support

$$
\sup _{B^{\circ}(J)}\left|T_{\mathfrak{T}\left(\mathbf{u}_{2}\right) \backslash \mathfrak{G}}^{*} g\right| \leq 2^{104 a^{3}} \inf _{J} M_{\mathcal{B}, 1}|g|
$$

Proof. By the triangle inequality and since $T_{\mathfrak{p}}^{*} g=\mathbf{1}_{B\left(\mathrm{c}(\mathfrak{p}), 5 D^{\mathrm{s}(\mathfrak{p})}\right)} T_{\mathfrak{p}}^{*} g$, we have

$$
\sup _{B^{\circ}(J)}\left|T_{\mathfrak{T}\left(\mathfrak{u}_{2}\right) \backslash \mathfrak{S}}^{*} g\right| \leq \sup _{B^{\circ}(J)} \sum_{\substack{\mathfrak{p} \in \mathfrak{T}\left(\mathfrak{u}_{2}\right) \backslash \mathfrak{S} \\ B(\mathcal{I}(\mathfrak{p})) \cap B^{\circ}(J) \neq \emptyset}}\left|T_{\mathfrak{p}}^{*} g\right|
$$

By Lemma 7.26, this is at most

$$
\begin{equation*}
\sum_{s=s(J)}^{s(J)+10 a^{2}+2} \sum_{\substack{\mathfrak{p} \in \mathfrak{P}, \mathrm{s}(\mathfrak{p})=s \\ B(\mathcal{I}(\mathfrak{p})) \cap B^{\circ}(J) \neq \emptyset}} \sup _{B^{\circ}(J)}\left|T_{\mathfrak{p}}^{*} g\right| . \tag{7.50}
\end{equation*}
$$

If $x \in E(\mathfrak{p})$ and $B(\mathcal{I}(\mathfrak{p})) \cap B^{\circ}(J) \neq \emptyset$, then

$$
B\left(c(J), 16 D^{\mathrm{s}(\mathfrak{p})}\right) \subset B\left(x, 32 D^{\mathrm{s}(\mathfrak{p})}\right)
$$

by (2.10) and the triangle inequality. Using the doubling property (1.5), it follows that

$$
\mu\left(B\left(x, D^{\mathrm{s}(\mathfrak{p})}\right)\right) \geq 2^{-5 a} \mu\left(B\left(c(J), 16 D^{\mathrm{s}(\mathfrak{p})}\right)\right)
$$

Using (7.27), (2.49) and that $a \geq 4$, we bound (7.50) by

$$
2^{103 a^{3}} \sum_{s=s(J)}^{s(J)+10 a^{2}+2} \sum_{\substack{\mathfrak{p} \in \mathfrak{P}, \mathrm{s}(\mathfrak{p})=s \\ B(\mathcal{I}(\mathfrak{p})) \cap B^{\circ}(J) \neq \emptyset}} \frac{1}{\mu\left(B\left(c(J), 16 D^{s}\right)\right.} \int_{E(\mathfrak{p})}|g| \mathrm{d} \mu
$$

For each $I \in \mathcal{D}$, the sets $E(\mathfrak{p})$ for $\mathfrak{p} \in \mathfrak{P}$ with $\mathcal{I}(\mathfrak{p})=I$ are pairwise disjoint by $(2.20)$ and (2.13). Further, if $B(\mathcal{I}(\mathfrak{p})) \cap B^{\circ}(J) \neq \emptyset$ and $\mathrm{s}(\mathfrak{p}) \geq s(J)$, then $E(\mathfrak{p}) \subset B\left(c(J), 32 D^{\mathrm{s}(\mathfrak{p})}\right)$. Thus the last display is bounded by

$$
\begin{aligned}
& 2^{103 a^{3}} \sum_{s=s(J)}^{s(J)+10 a^{2}+2} \frac{1}{\mu\left(B\left(c(J), 32 D^{s}\right)\right)} \int_{B\left(c(J), 16 D^{s}\right)}|g| \mathrm{d} \mu \\
& \quad \leq \inf _{x^{\prime} \in J} 2^{103 a^{3}}\left(10 a^{2}+3\right) M_{\mathcal{B}, 1}|g|
\end{aligned}
$$

The lemma follows since for $a \geq 4$ it holds that $10 a^{2}+3 \leq 2^{a^{3}}$.
Lemma 7.28 (scales impacting interval). Let $\mathfrak{C}=\mathfrak{T}\left(\mathfrak{u}_{1}\right)$ or $\mathfrak{C}=\mathfrak{T}\left(\mathfrak{u}_{2}\right) \cap \mathfrak{S}$. Then for each $J \in \mathcal{J}^{\prime}$ and $\mathfrak{p} \in \mathfrak{C}$ with $B(\mathcal{I}(\mathfrak{p})) \cap B(J) \neq \emptyset$, we have $\mathrm{s}(\mathfrak{p}) \geq$ $s(J)$.
Proof. By Lemma 7.20, we have that in both cases, $\mathfrak{C} \subset \mathfrak{S}$. If $\mathfrak{p} \in \mathfrak{C}$ with $B(\mathcal{I}(\mathfrak{p})) \cap B(J) \neq \emptyset$ and $\mathrm{s}(\mathfrak{p})<s(J)$, then $\mathcal{I}(\mathfrak{p}) \subset B\left(c(J), 100 D^{s(J)+1}\right)$. Since $\mathfrak{p} \in \mathfrak{S}$, it follows from the definition of $\mathcal{J}^{\prime}$ that $s(J)=-S$, which contradicts $\mathrm{s}(\mathfrak{p})<s(J)$.
Lemma 7.29 (global tree control 1). Let $\mathfrak{C}=\mathfrak{T}\left(\mathfrak{u}_{1}\right)$ or $\mathfrak{C}=\mathfrak{T}\left(\mathfrak{u}_{2}\right) \cap \mathfrak{S}$. Then for each $J \in \mathcal{J}^{\prime}$ and all bounded $g$ with bounded support, we have

& +\left|\chi_{J}\left(y^{\prime}\right)\right|\left|T_{\mathfrak{T}\left(\mathbf{u}_{1}\right)}^{*} g_{1}\left(y^{\prime}\right)\right|\left|T_{\mathfrak{T}\left(\mathbf{u}_{2}\right) \cap \mathfrak{S}} g_{2}(y)-T_{\mathfrak{T}\left(u_{2}\right) \cap \mathfrak{S}}^{*} g_{2}\left(y^{\prime}\right)\right| . \tag{7.56}

\leq 2^{6 a} \int_{B^{\circ}(J)} \prod_{j=1}^{2}\left(\left|T_{\mathfrak{T}\left(\mathfrak{u}_{j}\right)}^{*} g_{j}\right|(x)+M_{\mathcal{B}, 1} g_{j}(x)\right) \mathrm{d} \mu(x) \\
\leq 2^{6 a} \int_{J} \prod_{j=1}^{2}\left(\left|T_{\mathfrak{T}\left(\mathfrak{u}_{j}\right)}^{*} g_{j}\right|(x)+M_{\mathcal{B}, 1} g_{j}(x)\right) \mathrm{d} \mu(x) .

Thus $\mathcal{I}\left(\mathfrak{u}_{1}\right) \notin \mathcal{J}^{\prime}$. It follows that $J \subsetneq \mathcal{I}\left(\mathfrak{u}_{1}\right)$. By (2.7) and (2.8), there exists a cube $J^{\prime} \in \mathcal{D}$ with $J \subset J^{\prime}$ and $s\left(J^{\prime}\right)=s(J)+1$. By definition of $\mathcal{J}^{\prime}$, there exists a tile $\mathfrak{p}^{\prime} \in \mathfrak{T}\left(\mathfrak{u}_{1}\right)$ with

7.7. Forests. In this subsection, we complete the proof of Proposition 2.4 from the results of the previous subsections.

Define an $n$-row to be an $n$-forest ( $\mathfrak{U}, \mathfrak{T}$ ), i.e. satisfying conditions (2.32) - (2.37), such that in addition the sets $\mathcal{I}(\mathfrak{u}), \mathfrak{u} \in \mathfrak{U}$ are pairwise disjoint.

Lemma 7.36 (forest row decomposition). Let $(\mathfrak{U}, \mathfrak{T})$ be an $n$-forest. Then there exists a decomposition

Now we show by induction on $j$ that each point is contained in at most $2^{n}-j$ cubes $\mathcal{I}(\mathfrak{u})$ with $\mathfrak{u} \in \mathfrak{U} \backslash \bigcup_{j^{\prime} \leq j} \mathfrak{U}_{j^{\prime}}$. This implies that $\bigcup_{j=1}^{2^{n}} \mathfrak{U}_{j}=\mathfrak{U}$, which completes the proof of the Lemma. For $j=0$ each point is contained in at most $2^{n}$ cubes by (2.34). For larger $j$, if $x$ is contained in any cube $\mathcal{I}(\mathfrak{u})$ with $\mathfrak{u} \in \mathfrak{U} \backslash \bigcup_{j^{\prime}<j} \mathfrak{U}_{j^{\prime}}$, then it is contained in a maximal such cube. Thus it is contained in a cube in $\mathcal{I}(\mathfrak{u})$ with $\mathfrak{u} \in \mathfrak{U}_{j}$. Thus the number $\mathfrak{u} \in \mathfrak{U} \backslash \bigcup_{j^{\prime} \leq j} \mathfrak{U}_{j^{\prime}}$ with $x \in \mathcal{I}(\mathfrak{u})$ is zero, or is less than the number of $\mathfrak{u} \in \mathfrak{U} \backslash \bigcup_{j^{\prime} \leq j-1} \mathfrak{U}_{j^{\prime}}$ with $x \in \mathcal{I}(\mathfrak{u})$ by at least one.

We pick a decomposition of the forest $(\mathfrak{U}, \mathfrak{T})$ into $2^{n} n$-rows

\sum_{i \in M} a_{i} b_{i} \leq\left(\sum_{i \in M} a_{i}^{2}\right)^{1 / 2}\left(\sum_{i \in M} b_{i}^{2}\right)^{1 / 2}
$$

to the outer two sums:

$$
\begin{gathered}
\leq 2^{550 a^{3}-3 n}\left(\sum_{\mathfrak{u} \in \mathfrak{U}_{j}} \sum_{\mathfrak{u}^{\prime} \in \mathfrak{U}_{j^{\prime}}}\left\|S_{2, \mathfrak{u}} g_{1}\right\|_{L^{2}\left(\mathcal{I}\left(\mathfrak{u}^{\prime}\right) \cap \mathcal{I}(\mathfrak{u})\right)}^{2}\right)^{1 / 2} \\
\left(\sum_{\mathfrak{u} \in \mathfrak{U}_{j}} \sum_{\mathfrak{u}^{\prime} \in \mathfrak{U}_{j^{\prime}}}\left\|S_{2, \mathfrak{u}^{\prime}} g_{2}\right\|_{L^{2}\left(\mathcal{I}\left(\mathfrak{u}^{\prime}\right) \cap \mathcal{I}(\mathfrak{u})\right)}^{2}\right)^{1 / 2}
\end{gathered}
$$

By pairwise disjointedness of the sets $\mathcal{I}(\mathfrak{u})$ for $\mathfrak{u} \in \mathfrak{U}_{j}$ and of the sets $\mathcal{I}\left(\mathfrak{u}^{\prime}\right)$ for $\mathfrak{u}^{\prime} \in \mathfrak{U}_{j^{\prime}}$, we have

\sum_{\mathfrak{u} \in \mathfrak{U}_{j}} \sum_{\mathfrak{u}^{\prime} \in \mathfrak{U}_{j^{\prime}}}\left\|S_{2, \mathfrak{u}} g_{1}\right\|_{L^{2}\left(\mathcal{I}\left(\mathfrak{u}^{\prime}\right) \cap \mathcal{I}(\mathfrak{u})\right)}^{2}=\sum_{\mathfrak{u} \in \mathfrak{U}_{j}} \sum_{\mathfrak{u}^{\prime} \in \mathfrak{U}_{j^{\prime}}} \int_{\mathcal{I}(\mathfrak{u}) \cap \mathcal{I}\left(\mathfrak{u}^{\prime}\right)}\left|S_{2, \mathfrak{u}} g_{1}(y)\right|^{2} \mathrm{~d} \mu(y)
$$

$$
\leq \int_{X}\left|S_{2, u} g_{1}(y)\right|^{2} \mathrm{~d} \mu(y)=\left\|S_{2, u} g_{1}\right\|_{2}^{2}
$$

Arguing similar for $g_{2}$, we can estimate (7.66) to be

\leq 2^{550 a^{3}-3 n}\left\|S_{2, u} g_{1}\right\|_{2}\left\|S_{2, \mathfrak{u}^{\prime}} g_{2}\right\|_{2} .
$$

The lemma now follows from Lemma 7.16.
Define for $1 \leq j \leq 2^{n}$

E_{j}:=\bigcup_{\mathfrak{u} \in \mathfrak{U}_{j}} \bigcup_{\mathfrak{p} \in \mathfrak{T}(\mathfrak{u})} E(\mathfrak{p}) .
$$

Lemma 7.39 (disjoint row support). The sets $E_{j}, 1 \leq j \leq 2^{n}$ are pairwise disjoint.
Proof. Suppose that $\mathfrak{p} \in \mathfrak{T}(\mathfrak{u})$ and $\mathfrak{p}^{\prime} \in \mathfrak{T}\left(\mathfrak{u}^{\prime}\right)$ with $\mathfrak{u} \neq \mathfrak{u}^{\prime}$ and $x \in E(\mathfrak{p}) \cap$ $E\left(\mathfrak{p}^{\prime}\right)$. Suppose without loss of generality that $\mathrm{s}(\mathfrak{p}) \leq \mathrm{s}\left(\mathfrak{p}^{\prime}\right)$. Then $x \in$ $\mathcal{I}(\mathfrak{p}) \cap \mathcal{I}\left(\mathfrak{p}^{\prime}\right) \subset \mathcal{I}\left(\mathfrak{u}^{\prime}\right)$. By (2.8) it follows that $\mathcal{I}(\mathfrak{p}) \subset \mathcal{I}\left(\mathfrak{u}^{\prime}\right)$. By (2.36), it follows that

d_{\mathfrak{p}}\left(\mathcal{Q}(\mathfrak{p}), \mathcal{Q}\left(\mathfrak{u}^{\prime}\right)\right)>2^{Z(n+1)} .

By the triangle inequality. Lemma 2.8 and (2.32) it follows that

d_{\mathfrak{p}}\left(\mathcal{Q}(\mathfrak{p}), \mathcal{Q}\left(\mathfrak{p}^{\prime}\right)\right) & \geq d_{\mathfrak{p}}\left(\mathcal{Q}(\mathfrak{p}), \mathcal{Q}\left(\mathfrak{u}^{\prime}\right)\right)-d_{\mathfrak{p}}\left(\mathcal{Q}\left(\mathfrak{p}^{\prime}\right), \mathcal{Q}\left(\mathfrak{u}^{\prime}\right)\right) \\
& >2^{Z(n+1)}-d_{\mathfrak{p}^{\prime}}\left(\mathcal{Q}\left(\mathfrak{p}^{\prime}\right), \mathcal{Q}\left(\mathfrak{u}^{\prime}\right)\right) \\
& \geq 2^{Z(n+1)}-4
\end{aligned}
$$

Since $Z \geq 3$ by (2.3), it follows that $\mathcal{Q}\left(\mathfrak{p}^{\prime}\right) \notin B_{\mathfrak{p}}(\mathcal{Q}(\mathfrak{p}), 1)$, so $\Omega\left(\mathfrak{p}^{\prime}\right) \not \subset \Omega(\mathfrak{p})$ by (2.15). Hence, by (2.14), $\Omega(\mathfrak{p}) \cap \Omega\left(\mathfrak{p}^{\prime}\right)=\emptyset$. But if $x \in E(\mathfrak{p}) \cap E\left(\mathfrak{p}^{\prime}\right)$ then $Q(x) \in \Omega(\mathfrak{p}) \cap \Omega\left(\mathfrak{p}^{\prime}\right)$. This is a contradiction, and the lemma follows.

Now we prove Proposition 2.4.
Proof of Proposition 2.4. To save some space, we will write

T_{\mathfrak{R}_{j}}^{*} g=\sum_{\mathfrak{u} \in \mathfrak{U}_{j}} \sum_{\mathfrak{p} \in \mathfrak{T}(\mathfrak{u})} T_{\mathfrak{p}}^{*} g=\sum_{\mathfrak{u} \in \mathfrak{U}_{j}} \sum_{\mathfrak{p} \in \mathfrak{T}(\mathfrak{u})} T_{\mathfrak{p}}^{*} \mathbf{1}_{E_{j}} g=T_{\mathfrak{R}_{j}}^{*} \mathbf{1}_{E_{j}} g .
$$

Hence, by Lemma 7.36,

$$
\begin{gathered}
\left\|\sum_{\mathfrak{u} \in \mathfrak{U}} \sum_{\mathfrak{p} \in \mathfrak{T}(\mathfrak{u})} T_{\mathfrak{p}}^{*} g\right\|_{2}^{2}=\left\|\sum_{j=1}^{2^{n}} T_{\mathfrak{R}_{j}}^{*} g\right\|_{2}^{2}=\left\|\sum_{j=1}^{2^{n}} T_{\mathfrak{R}_{j}}^{*} \mathbf{1}_{E_{j}} g\right\|_{2}^{2} \\
=\int_{X}\left|\sum_{j=1}^{2^{n}} T_{\mathfrak{\Re}_{j}}^{*} \mathbf{1}_{E_{j}} g\right|^{2} \mathrm{~d} \mu \\
=\sum_{j=1}^{2^{n}} \int_{X}\left|T_{\mathfrak{R}_{j}}^{*} \mathbf{1}_{E_{j}} g\right|^{2}+\sum_{\substack{2}}^{2^{n}} \sum_{\substack{j^{\prime}=1 \\
j^{\prime} \neq j}}^{2^{n}} \int_{X} \overline{T_{\mathfrak{R}_{j}}^{*} \mathbf{1}_{E_{j}} g} T_{\mathfrak{R}_{j^{\prime}}}^{*} \mathbf{1}_{E_{j^{\prime}}} g \mathrm{~d} \mu .
\end{gathered}
$$

We use Lemma 7.37 to estimate each term in the first sum, and Lemma 7.38 to bound each term in the second sum:

\leq 2^{312 a^{3}-n} \sum_{j=1}^{2^{n}}\left\|\mathbf{1}_{E_{j}} g\right\|_{2}^{2}+2^{862 a^{3}-3 n} \sum_{j=1}^{2^{n}} \sum_{j^{\prime}=1}^{2^{n}}\left\|\mathbf{1}_{E_{j}} g\right\|_{2}\left\|\mathbf{1}_{E_{j^{\prime}}} g\right\|_{2}
$$

By Cauchy-Schwarz in the second two sums, this is at most

2^{862 a^{3}}\left(2^{-n}+2^{n} 2^{-3 n}\right) \sum_{j=1}^{n}\left\|\mathbf{1}_{E_{j}} g\right\|_{2}^{2}
$$

and by disjointedness of the sets $E_{j}$, this is at most

2^{863 a^{3}-n}\|g\|_{2}^{2}
$$

Taking adjoints and square roots, it follows that for all $f$

$$
\begin{equation*}
\left\|\sum_{\mathfrak{u} \in \mathfrak{U}} \sum_{\mathfrak{p} \in \mathfrak{T}(\mathfrak{u})} T_{\mathfrak{p}} f\right\|_{2} \leq 2^{432 a^{3}-\frac{n}{2}}\|f\|_{2} \tag{7.67}
\end{equation*}
$$

On the other hand, we have by disjointedness of the sets $E_{j}$ from Lemma 7.39

$$
\left\|\sum_{\mathfrak{u} \in \mathfrak{U}} \sum_{\mathfrak{p} \in \mathfrak{T}(\mathfrak{u})} T_{\mathfrak{p}} f\right\|_{2}^{2}=\left\|\sum_{j=1}^{2^{n}} \mathbf{1}_{E_{j}} T_{\mathfrak{R}_{j}} f\right\|_{2}^{2}=\sum_{j=1}^{2^{n}}\left\|\mathbf{1}_{E_{j}} T_{\mathfrak{R}_{j}} f\right\|_{2}^{2}
$$

If $|f| \leq \mathbf{1}_{F}$ then we obtain from Lemma 7.37 and taking square roots that

\begin{gather*}
\leq 2^{257 a^{3}} \operatorname{dens}_{2}\left(\bigcup_{\mathfrak{u} \in \mathfrak{U}} \mathfrak{T}(\mathfrak{u})\right)^{\frac{1}{2}} 2^{-\frac{n}{2}}\left(\sum_{j=1}^{2^{n}}\|f\|_{2}^{2}\right)^{\frac{1}{2}} \\
=2^{257 a^{3}} \operatorname{dens}_{2}\left(\bigcup_{\mathfrak{u} \in \mathfrak{U}} \mathfrak{T}(\mathfrak{u})\right)^{\frac{1}{2}}\|f\|_{2} \tag{7.68}
\end{gather*}
$$

Proposition 2.4 follows by taking the product of the $\left(2-\frac{2}{q}\right)$-th power of (7.67) and the $\left(\frac{2}{q}-1\right)$-st power of (7.68).

## 8. Proof of Prop. 2.5, the Hölder cancellative condition

We need the following auxiliary lemma. Recall that $\tau=1 / a$.
Lemma 8.1 (Lipschitz Holder approximation). Let $z \in X$ and $R>0$. Let $\varphi: X \rightarrow \mathbb{C}$ be a function supported in the ball $B:=B(z, R)$ with finite norm $\|\varphi\|_{C^{\tau}(B)}$. Let $0<t \leq 1$. There exists a function $\tilde{\varphi}: X \rightarrow \mathbb{C}$, supported in $B(z, 2 R)$, such that for every $x \in X$

|\varphi(x)-\tilde{\varphi}(x)| \leq t^{\tau}\|\varphi\|_{C^{\tau}(B)} \tag{8.1}
\end{equation*}
$$

and

$$
\begin{equation*}
\|\tilde{\varphi}\|_{\operatorname{Lip}(B(z, 2 R))} \leq 2^{4 a} t^{-1-a}\|\varphi\|_{C^{\tau}(B)} \tag{8.2}
\end{equation*}
$$

Proof. Define for $x, y \in X$ the Lipschitz and thus measurable function

L(x, y):=\max \left\{0,1-\frac{\rho(x, y)}{t R}\right\} \tag{8.3}
\end{equation*}
$$

We have that $L(x, y) \neq 0$ implies

y \in B(x, t R) \tag{8.4}
\end{equation*}
$$

We have for $y \in B\left(x, 2^{-1} t R\right)$ that

$$
\begin{equation*}
|L(x, y)| \geq 2^{-1} \tag{8.5}
\end{equation*}
$$

Hence

$$
\begin{equation*}
\int L(x, y) \mathrm{d} \mu(y) \geq 2^{-1} \mu\left(B\left(x, 2^{-1} R t\right)\right) \tag{8.6}
\end{equation*}
$$

Let $n$ be the smallest integer so that

$$
\begin{equation*}
2^{n} t \geq 1 \tag{8.7}
\end{equation*}
$$

Iterating $n+2$ times the doubling condition (1.5), we obtain

$$
\begin{equation*}
\int L(x, y) \mathrm{d} \mu(y) \geq 2^{-1-a(n+2)} \mu(B(x, 2 R)) \tag{8.8}
\end{equation*}
$$

Now define

$$
\tilde{\varphi}(x):=\left(\int L(x, y) \mathrm{d} \mu(y)\right)^{-1} \int L(x, y) \varphi(y) \mathrm{d} \mu(y)
$$

Using that $\varphi$ is supported in $B(z, R)$ and (8.4), we have that $\tilde{\varphi}$ is supported in $B(z, 2 R)$.

We prove (8.1). For any $x \in X$, using that $L$ is nonnegative,

$$
\begin{align*}
& \left(\int L(x, y) \mathrm{d} \mu(y)\right)|\varphi(x)-\tilde{\varphi}(x)|  \tag{8.9}\\
= & \left|\int L(x, y)(\varphi(x)-\varphi(y)) \mathrm{d} \mu(y)\right| . \tag{8.10}
\end{align*}
$$

Using (8.4), we estimate the last display by

$$
\begin{equation*}
\leq \int_{B(x, t R)} L(x, y)|\varphi(x)-\varphi(y)| \mathrm{d} \mu(y) \tag{8.11}
\end{equation*}
$$

Using the definition of $\|\varphi\|_{C^{\tau}(B)}$, we estimate the last display further by

$$
\begin{equation*}
\leq\left(\int_{B(x, t R)} L(x, y) \rho(x, y)^{\tau} \mathrm{d} \mu(y)\right)\|\varphi\|_{C^{\tau}(B)} R^{-\tau} \tag{8.12}
\end{equation*}
$$

Using the condition on the domain of integration to estimate $\rho(x, y)$ by $t R$ and then expanding the domain by positivity of the integrand, we estimate this further by

$$
\begin{equation*}
\leq\left(\int L(x, y) \mathrm{d} \mu(y)\right)\|\varphi\|_{C^{\tau}(B)} t^{\tau} \tag{8.13}
\end{equation*}
$$

Dividing the string of inequalities from (8.9) to (8.13) by the positive integral of $L$ proves (8.1).

We turn to (8.2). For every $x \in X$, we have

\begin{gather*}
\left|\int L(x, y) \mathrm{d} \mu(y)\right||\tilde{\varphi}(x)|=\left|\int L(x, y) \varphi(y) \mathrm{d} \mu(y)\right|  \tag{8.14}\\
\leq\left|\int L(x, y) \mathrm{d} \mu(y)\right| \sup _{x^{\prime} \in X}\left|\varphi\left(x^{\prime}\right)\right| \tag{8.15}
\end{gather*}
$$

As $\varphi$ is supported on $B$, dividing by the integral of $L$, we obtain

$$
\begin{equation*}
|\tilde{\varphi}(x)| \leq \sup _{x^{\prime} \in B}\left|\varphi\left(x^{\prime}\right)\right| \leq\|\varphi\|_{C^{\tau}(B)} \tag{8.16}
\end{equation*}
$$

If $\rho\left(x, x^{\prime}\right) \geq R$, then we have by the triangle inequality

$$
\begin{equation*}
R \frac{\left|\tilde{\varphi}\left(x^{\prime}\right)-\tilde{\varphi}(x)\right|}{\rho\left(x, x^{\prime}\right)} \leq 2 \sup _{x^{\prime \prime} \in X}\left|\tilde{\varphi}\left(x^{\prime \prime}\right)\right| \leq 2\|\varphi\|_{C^{\tau}(B)} \tag{8.17}
\end{equation*}
$$

Now assume $\rho\left(x, x^{\prime}\right)<R$. For $y \in X$ we have by the triangle inequality and a two fold case distinction for the maximum in the definition of $L$,

\left|L(x, y)-L\left(x^{\prime}, y\right)\right| \leq \frac{\rho\left(x, x^{\prime}\right)}{t R} \tag{8.18}
\end{equation*}

We compute with (8.18), first adding and subtracting a term in the integral,

\left|\int L(x, y) \tilde{\varphi}\left(x^{\prime}\right)-L(x, y) \tilde{\varphi}(x)+L\left(x^{\prime}, y\right) \tilde{\varphi}\left(x^{\prime}\right)-L\left(x^{\prime}, y\right) \tilde{\varphi}\left(x^{\prime}\right) \mathrm{d} \mu(y)\right| \tag{8.20}
\end{gather*}
$$

Grouping the second and third and the first and fourth term, we obtain using the definition of $\tilde{\varphi}$ and Fubini,

$$
\begin{gather*}
\leq\left|\int\left(L\left(x^{\prime}, y\right)-L(x, y)\right) \varphi(y) \mathrm{d} \mu(y)\right|  \tag{8.21}\\
+\left|\int L(x, y) \mathrm{d} \mu(y)-\int L\left(x^{\prime}, y\right) \mathrm{d} \mu(y)\right|\left|\tilde{\varphi}\left(x^{\prime}\right)\right|  \tag{8.22}\\
\leq  \tag{8.23}\\
\leq \int\left|L(x, y)-L\left(x^{\prime}, y\right)\right| \mathrm{d} \mu(y)\|\varphi\|_{C^{\tau}(B)}
\end{gather*}
$$

where in the last inequality we have used (8.16). Using further (8.18) and the support of $L$, we estimate the last display by

$$
\begin{equation*}
\leq 2 \frac{\rho\left(x, x^{\prime}\right)}{t R} \mu\left(B(x, t R) \cup B\left(x^{\prime}, t R\right)\right)\|\varphi\|_{C^{\tau}(B)} \tag{8.24}
\end{equation*}
$$

Using $\rho\left(x, x^{\prime}\right)<R$ and the triangle inequality, we estimate the last display by

$$
\begin{equation*}
\leq 2 \frac{\rho\left(x, x^{\prime}\right)}{t R} \mu(B(x, 2 R))\|\varphi\|_{C^{\tau}(B)} \tag{8.25}
\end{equation*}
$$

Dividing by the integral over $L$ and using (8.8) and (8.7), we obtain

$$
\begin{equation*}
\frac{R\left|\tilde{\varphi}\left(x^{\prime}\right)-\tilde{\varphi}(x)\right|}{\rho\left(x, x^{\prime}\right)} \leq 2^{2+a(n+2)} t^{-1}\|\varphi\|_{C^{\tau}(B)} \leq 2^{2+3 a} t^{-1-a}\|\varphi\|_{C^{\tau}(B)} \tag{8.26}
\end{equation*}
$$

Combining (8.17) and (8.26) using $a \geq 4$ and $t \leq 1$ and adding (8.16) proves (8.2) and completes the proof of Lemma 8.1.

We turn to the proof of Proposition 2.5. Let $z \in X$ and $R>0$ and set $B=B(z, R)$. Let $\varphi$ be given as in Proposition 2.5. Set

t:=\left(1+d_{B}(\vartheta, \theta)\right)^{-\frac{\tau}{2+a}} \tag{8.27}
\end{equation*}
$$

and define $\tilde{\varphi}$ as in Lemma 8.1. Let $\vartheta$ and $\theta$ be in $\Theta$. Then

$$
\begin{gather*}
\left|\int e(\vartheta(x)-\theta(x)) \varphi(x) \mathrm{d} \mu(x)\right|  \tag{8.28}\\
\leq\left|\int e(\vartheta(x)-\theta(x)) \tilde{\varphi}(x) \mathrm{d} \mu(x)\right|  \tag{8.29}\\
+\left|\int e(\vartheta(x)-\theta(x))(\varphi(x)-\tilde{\varphi}(x)) \mathrm{d} \mu(x)\right| \tag{8.30}
\end{gather*}
$$

Using the cancellative condition (1.12) of $\Theta$ on the ball $B(z, 2 R)$, the term (8.29) is bounded above by

$$
\begin{equation*}
2^{a} \mu(B(z, 2 R))\|\tilde{\varphi}\|_{\operatorname{Lip}(B(z, 2 R))}\left(1+d_{B(z, 2 R)}(\vartheta, \theta)\right)^{-\tau} . \tag{8.31}
\end{equation*}
$$

Using the doubling condition (1.5), the inequality (8.2), and the estimate $d_{B} \leq d_{B(z, 2 R)}$ from the definition, we estimate (8.31) from above by

$$
\begin{equation*}
2^{6 a} t^{-1-a} \mu(B)\|\varphi\|_{C^{\tau}(B)}\left(1+d_{B}(\vartheta, \theta)\right)^{-\tau} . \tag{8.32}
\end{equation*}
$$

The term (8.30) we estimate using (8.1) and that $\vartheta$ and $\theta$ are real and thus $e(\vartheta)$ and $e(\theta)$ bounded in absolute value by 1 . We obtain for (8.30) with (1.5) the upper bound

$$
\begin{equation*}
\mu(B(z, 2 R)) t^{\tau}\|\varphi\|_{C^{\tau}(B)} \leq 2^{a} \mu(B) t^{\tau}\|\varphi\|_{C^{\tau}(B)} . \tag{8.33}
\end{equation*}
$$

Using the definition (8.27) of $t$ and adding (8.32) and (8.33) estimates (8.28) from above by

$$
\begin{gather*}
2^{6 a} \mu(B)\|\varphi\|_{C^{\tau}(B)}\left(1+d_{B}(\vartheta, \theta)\right)^{-\frac{\tau}{2+a}}  \tag{8.34}\\
+2^{a} \mu(B)\|\varphi\|_{C^{\tau}(B)}\left(1+d_{B}(\vartheta, \theta)\right)^{-\frac{\tau^{2}}{2+a}} .  \tag{8.35}\\
\leq 2^{1+6 a} \mu(B)\|\varphi\|_{C^{\tau}(B)}\left(1+d_{B}(\vartheta, \theta)\right)^{-\frac{\tau^{2}}{2+a}}, \tag{8.36}
\end{gather*}
$$

where we used $\tau \leq 1$. This completes the proof of Proposition 2.5.

## 9. Proof of Prop. 2.6, Vitali covering and Hardy-Littlewood

We begin with a classical representation of the Lebesgue norm.
Lemma 9.1 (layer cake representation). Let $1 \leq p<\infty$. Then for any measurable function $u: X \rightarrow[0, \infty)$ on the measure space $X$ relative to the measure $\mu$ we have

\int_{X} u(x)^{p} d \mu(x) . \tag{9.2}
\end{equation*}
$$

Writing $u(x)$ as an elementary integral in $\lambda$ and then using Fubini, we write for the last display

$$
\begin{gather*}
=\int_{X} \int_{0}^{u(x)} p \lambda^{p-1} d \lambda d \mu(x)  \tag{9.3}\\
=p \int_{0}^{\infty} \lambda^{p-1} \mu(\{x: u(x) \geq \lambda\}) d \lambda . \tag{9.4}
\end{gather*}
$$

This proves the lemma.

We turn to the proof of Proposition 2.6. Let the collection $\mathcal{B}$ be given. We first show (2.43).

We recursively choose a finite sequence $B_{i} \in \mathcal{B}$ for $i \geq 0$ as follows. Assume $B_{i^{\prime}}$ is already chosen for $0 \leq i^{\prime}<i$. If there exists a ball $B_{i} \in \mathcal{B}$ so that $B_{i}$ is disjoint from all $B_{i^{\prime}}$ with $0 \leq i^{\prime}<i$, then choose such a ball $B_{i}=B\left(x_{i}, r_{i}\right)$ with maximal $r_{i}$.

If there is no such ball, stop the selection and set $i^{\prime \prime}:=i$.
By disjointedness of the chosen balls and since $0 \leq u$, we have

$$
\begin{equation*}
\sum_{0 \leq i<i^{\prime \prime}} \int_{B_{i}} u(x) d \mu(x) \leq \int_{X} u(x) d \mu(x) . \tag{9.5}
\end{equation*}
$$

By (2.42), we conclude

$$
\begin{equation*}
\lambda \sum_{0 \leq i<i^{\prime \prime}} \mu\left(B_{i}\right) \leq \int_{X} u(x) d \mu(x) . \tag{9.6}
\end{equation*}
$$

Let $x \in \bigcup \mathcal{B}$. Choose a ball $B^{\prime}=B\left(x^{\prime}, r^{\prime}\right) \in \mathcal{B}$ such that $x \in B^{\prime}$. If $B^{\prime}$ is one of the selected balls, then

$$
\begin{equation*}
x \in \bigcup_{0 \leq i<i^{\prime \prime}} B_{i} \subset \bigcup_{0 \leq i<i^{\prime \prime}} B\left(x_{i}, 3 r_{i}\right) . \tag{9.7}
\end{equation*}
$$

If $B^{\prime}$ is not one of the selected balls, then as it is not selected at time $i^{\prime \prime}$, there is a selected ball $B_{i}$ with $B^{\prime} \cap B_{i} \neq \emptyset$. Choose such $B_{i}$ with minimal index $i$. As $B^{\prime}$ is therefore disjoint from all balls $B_{i^{\prime}}$ with $i^{\prime}<i$ and as it was not selected in place of $B_{i}$, we have $r_{i} \geq r^{\prime}$.

Using a point $y$ in the intersection of $B_{i}$ and $B^{\prime}$, we conclude by the triangle inequality

$$
\begin{equation*}
\rho\left(x_{i}, x^{\prime}\right) \leq \rho\left(x_{i}, y\right)+\rho\left(x^{\prime}, y\right) \leq r_{i}+r^{\prime} \leq 2 r_{i} \tag{9.8}
\end{equation*}
$$

By the triangle inequality again, we further conclude

\begin{equation*}
\rho\left(x_{i}, x\right) \leq \rho\left(x_{i}, x^{\prime}\right)+\rho\left(x^{\prime}, x\right) \leq 2 r_{i}+r^{\prime} \leq 3 r_{i} . \tag{9.9}
\end{equation*}
$$

It follows that

\begin{equation*}
x \in \bigcup_{0 \leq i<i^{\prime \prime}} B\left(x_{i}, 3 r_{i}\right) \tag{9.10}
\end{equation*}
$$

With (9.7) and (9.10), we conclude

$$
\begin{equation*}
\bigcup \mathcal{B} \subset \bigcup_{0 \leq i<i^{\prime \prime}} B\left(x_{i}, 3 r_{i}\right) \tag{9.11}
\end{equation*}
$$

With the doubling property (1.5) applied twice, we conclude

$$
\begin{equation*}
\mu(\bigcup \mathcal{B}) \leq \sum_{0 \leq i<i^{\prime \prime}} \mu\left(B\left(x_{i}, 3 r_{i}\right)\right) \leq 2^{2 a} \sum_{0 \leq i<i^{\prime \prime}} \mu\left(B_{i}\right) . \tag{9.12}
\end{equation*}
$$

With (9.6) and (9.12) we conclude (2.43).
We turn to the proof of (2.44). We first consider the case $p_{1}=1$ and recall $M_{\mathcal{B}}=M_{\mathcal{B}, 1}$. We write for the $p_{2}$-th power of left-hand side of (2.44) with Lemma 9.1 and a change of variables

\begin{equation*}
\left\|M_{\mathcal{B}} u(x)\right\|_{p_{2}}^{p_{2}}=p_{2} \int_{0}^{\infty} \lambda^{p_{2}-1} \mu\left(\left\{x: M_{\mathcal{B}} u(x) \geq \lambda\right\}\right) d \lambda \tag{9.13}
\end{equation*}
$$

$$
\begin{equation*}
=2^{p_{2}} p_{2} \int_{0}^{\infty} \lambda^{p_{2}-1} \mu\left(\left\{x: M_{\mathcal{B}} u(x) \geq 2 \lambda\right\}\right) d \lambda . \tag{9.14}
\end{equation*}
$$

Fix $\lambda \geq 0$ and let $x \in X$ satisfy $M_{\mathcal{B}} u(x) \geq 2 \lambda$. By definition of $M_{\mathcal{B}}$, there is a ball $B^{\prime} \in \mathcal{B}$ such that $x \in B^{\prime}$ and

$$
\begin{equation*}
\int_{B^{\prime}} u(y) d \mu(y) \geq 2 \lambda \mu\left(B^{\prime}\right) \tag{9.15}
\end{equation*}
$$

Define $u_{\lambda}(y):=0$ if $|u(y)|<\lambda$ and $u_{\lambda}(y):=u(y)$ if $|u(y)| \geq \lambda$. Then with (9.15)

$$
\begin{gather*}
\int_{B^{\prime}} u_{\lambda}(y) d \mu(y)=\int_{B^{\prime}} u(y) d \mu(y)-\int_{B^{\prime}}\left(u-u_{\lambda}\right)(y) d \mu(y)  \tag{9.16}\\
\geq 2 \lambda \mu\left(B^{\prime}\right)-\int_{B^{\prime}}\left(u-u_{\lambda}\right)(y) d \mu(y) \tag{9.17}
\end{gather*}
$$

As $\left(u-u_{\lambda}\right)(y) \leq \lambda$ by definition, we can estimate the last display by

$$
\begin{equation*}
\geq 2 \lambda \mu\left(B^{\prime}\right)-\int_{B^{\prime}} \lambda d \mu(y)=\lambda \mu\left(B^{\prime}\right) \tag{9.18}
\end{equation*}
$$

Hence $x$ is contained in $\bigcup\left(\mathcal{B}_{\lambda}\right)$, where $\mathcal{B}_{\lambda}$ is the collection of balls $B^{\prime \prime}$ in $\mathcal{B}$ such that

$$
\begin{equation*}
\int_{B^{\prime \prime}} u_{\lambda}(y) d \mu(y) \geq \lambda \mu\left(B^{\prime \prime}\right) \tag{9.19}
\end{equation*}
$$

We have thus seen

$$
\begin{equation*}
\left\{x: M_{\mathcal{B}} u(x) \geq 2 \lambda\right\} \subset \bigcup \mathcal{B}_{\lambda} \tag{9.20}
\end{equation*}
$$

Applying (2.43) to the collection $\mathcal{B}_{\lambda}$ gives

$$
\begin{equation*}
\lambda \mu\left(\left\{x: M_{\mathcal{B}} u(x) \geq 2 \lambda\right\}\right) \leq 2^{2 a} \int u_{\lambda}(x) d x \tag{9.21}
\end{equation*}
$$

With Lemma 9.1,

$$
\begin{equation*}
\lambda \mu\left(\left\{x: M_{\mathcal{B}} u(x) \geq 2 \lambda\right\}\right) \leq 2^{2 a} \int_{0}^{\infty} \mu\left(\left\{x:\left|u_{\lambda}(x)\right| \geq \lambda^{\prime}\right\}\right) d \lambda^{\prime} \tag{9.22}
\end{equation*}
$$

By definition of $h_{\lambda}$, making a case distinction between $\lambda \geq \lambda^{\prime}$ and $\lambda<\lambda^{\prime}$, we see that

$$
\begin{equation*}
\mu\left(\left\{x:\left|u_{\lambda}(x)\right| \geq \lambda^{\prime}\right\}\right) \leq \mu\left(\left\{x:|u(x)| \geq \max \left(\lambda, \lambda^{\prime}\right)\right\}\right) \tag{9.23}
\end{equation*}
$$

We obtain with $(9.14)$, (9.22), and (9.23)

$$
\begin{gather*}
\left\|M_{\mathcal{B}} u(x)\right\|_{p_{2}}^{p_{2}}  \tag{9.24}\\
\leq 2^{p_{2}+2 a} p_{2} \int_{0}^{\infty} \lambda^{p_{2}-2} \int_{0}^{\infty} \mu\left(\left\{x:|u(x)| \geq \max \left(\lambda, \lambda^{\prime}\right)\right\}\right) d \lambda^{\prime} d \lambda \tag{9.25}
\end{gather*}
$$

We split the integral into $\lambda \geq \lambda^{\prime}$ and $\lambda<\lambda^{\prime}$ and resolve the maximum correspondingly. We have for $\lambda \geq \lambda^{\prime}$ with Lemma 9.1

$$
\begin{gather*}
\int_{0}^{\infty} \lambda^{p_{2}-2} \int_{0}^{\lambda} \mu(\{x:|u(x)| \geq \lambda\}) d \lambda^{\prime} d \lambda  \tag{9.26}\\
=\int_{0}^{\infty} \lambda^{p_{2}-1} \mu(\{x:|u(x)| \geq \lambda\}) d \lambda  \tag{9.27}\\
=p_{2}^{-1}\|u\|_{p_{2}}^{p_{2}} \tag{9.28}
\end{gather*}
$$

We have for $\lambda<\lambda^{\prime}$ with Fubini and Lemma 9.1

$$
\begin{gather*}
\int_{0}^{\infty} \lambda^{p_{2}-2} \int_{\lambda}^{\infty} \mu\left(\left\{x:|u(x)| \geq \lambda^{\prime}\right\}\right) d \lambda^{\prime} d \lambda  \tag{9.29}\\
=\int_{0}^{\infty} \int_{0}^{\lambda^{\prime}} \lambda^{p_{2}-2} \mu\left(\left\{x:|u(x)| \geq \lambda^{\prime}\right\}\right) d \lambda d \lambda^{\prime}  \tag{9.30}\\
=\left(p_{2}-1\right)^{-1} \int_{0}^{\infty}\left(\lambda^{\prime}\right)^{p_{2}-1} \mu\left(\left\{x:|u(x)| \geq \lambda^{\prime}\right\}\right) d \lambda^{\prime} .  \tag{9.31}\\
=\left(p_{2}-1\right)^{-1} p_{2}^{-1}\|u\|_{p_{2}}^{p_{2}} . \tag{9.32}
\end{gather*}
$$

Adding the two estimates (9.28) and (9.32) gives

$$
\begin{equation*}
\left\|M_{\mathcal{B}} u(x)\right\|_{p_{2}}^{p_{2}} \leq 2^{p_{2}+2 a}\left(1+\left(p_{2}-1\right)^{-1}\right)\|u\|_{p_{2}}^{p_{2}}=2^{p_{2}+2 a} p_{2}\left(p_{2}-1\right)^{-1}\|u\|_{p_{2}}^{p_{2}} . \tag{9.33}
\end{equation*}
$$

With $a \geq 1$ and $p_{2}>1$, taking the $p_{2}$-th root, we obtain (2.44). We turn to the case of general $1 \leq p_{1}<p_{2}$. We have

$$
\begin{equation*}
M_{\mathcal{B}, p_{1}} u=\left(M_{\mathcal{B}}\left(|u|^{p_{1}}\right)\right)^{\frac{1}{p_{1}}} \tag{9.34}
\end{equation*}
$$

Applying the special case of $(2.44)$ for $M_{\mathcal{B}}$ gives

$$
\begin{gather*}
\left\|M_{\mathcal{B}, p_{1}} u\right\|_{p_{2}}=\left\|M_{\mathcal{B}}\left(|u|^{p_{1}}\right)\right\|_{p_{2} / p_{1}}^{\frac{1}{p_{1}}}  \tag{9.35}\\
\leq 2^{2 a}\left(p_{2} / p_{1}\right)\left(p_{2} / p_{1}-1\right)^{-1}\left\|\left(|u|^{p_{1}}\right)\right\|_{p_{2} / p_{1}}^{\frac{1}{p_{1}}}=2^{2 a} p_{2}\left(p_{2}-p_{1}\right)^{-1}\|u\|_{p_{2}} \tag{9.36}
\end{gather*}
$$

This proves (2.44) in general.
Now we construct the operator $M$ satisfying (2.45) and (2.46).
Lemma 9.2 (covering separable space). For each $r>0$, there exists a countable collection $C(r) \subset X$ of points such that

$$
X \subset \bigcup_{c \in C(r)} B(c, r)
$$

Proof. It clearly suffices to construct finite collections $C(r, k)$ such that

$$
B\left(o, r 2^{k}\right) \subset \bigcup_{c \in C(r, k)} B(c, r)
$$

since then the collection $C(r)=\bigcup_{k \in \mathbb{N}} C(r, k)$ has the desired property.
Suppose that $Y \subset B\left(o, r 2^{k}\right)$ is a collection of points such that for all $y, y^{\prime} \in Y$ with $y \neq y^{\prime}$, we have $\rho\left(y, y^{\prime}\right) \geq r$. Then the balls $B(y, r / 2)$ are pairwise disjoint and contained in $B\left(o, r 2^{k+1}\right)$. If $y \in B(o, r)$, then $B\left(o, r 2^{k+1}\right) \subset B\left(y, r 2^{k+2}\right)$. Thus, by the doubling property (1.5),

$$
\mu\left(B\left(y, \frac{r}{2}\right)\right) \geq 2^{-(k+2) a} \mu\left(B\left(o, r 2^{k+1}\right)\right)
$$

Thus, we have

$$
\mu\left(B\left(o, r 2^{k+1}\right)\right) \geq \sum_{y \in Y} \mu\left(B\left(y, \frac{r}{2}\right)\right) \geq|Y| 2^{-(k+2) a} \mu\left(B\left(o, r 2^{k+1}\right)\right)
$$

We conclude that $|Y| \leq 2^{(k+2) a}$. In particular, there exists a set $Y$ of maximal cardinality. Define $C(r, k)$ to be such a set.

If $x \in B\left(o, r 2^{k}\right)$ and $x \notin C(r, k)$, then there must exist $y \in C(r, k)$ with $\rho(x, y)<r$. Thus $C(r, k)$ has the desired property.

For each $k \in \mathbb{N}$ we choose a countable set $C\left(2^{k}\right)$ as in the lemma. Define

$$
\mathcal{B}_{\infty}=\left\{B\left(c, 2^{k}\right): c \in C\left(2^{k}\right), k \in \mathbb{N}\right\} .
$$

By Lemma 9.2, this is a countable collection of balls. We choose an enumeration $\mathcal{B}_{\infty}=\left\{B_{1}, \ldots\right\}$ and define

$$
\mathcal{B}_{n}=\left\{B_{1}, \ldots, B_{n}\right\} .
$$

We define

$$
M w:=2^{2 a} \sup _{n \in \mathbb{N}} M_{\mathcal{B}_{n}} w .
$$

This function is measurable for each measurable $w$, since it is a countable supremum of measurable functions. Estimate (2.46) follows immediately from (2.44) and the monotone convergence theorem.

It remains to show (2.45). Let $B=B(x, r) \subset X$. Let $k$ be the smallest integer such that $2^{k} \geq r$, in particular we have $2^{k}<2 r$. By definition of $C\left(2^{k}\right)$, there exists $c \in C\left(2^{k}\right)$ with $x \in B\left(c, 2^{k}\right)$. By the triangle inequality, we have $B\left(c, 2^{k}\right) \subset B(x, 4 r)$, and hence by the doubling property (1.5)

$$
\mu\left(B\left(c, 2^{k}\right)\right) \leq 2^{2 a} \mu(B(x, r))
$$

It follows that for each $z \in B(x, r)$

$$
\begin{aligned}
\frac{1}{\mu(B(x, r))} \int_{B(x, r)}|w(y)| \mathrm{d} \mu(y) & \leq \frac{2^{2 a}}{\mu\left(B\left(c, 2^{k}\right)\right)} \int_{B\left(c, 2^{k}\right)}|w(y)| \mathrm{d} \mu(y) \\
& \leq M w(z) .
\end{aligned}
$$

This completes the proof.

## 10. Proof of Theorem 1.1

The convergence of partial Fourier sums is proved in Subsection 10.1 in two steps. In the first step, we establish convergence on a suitable dense subclass of functions. We choose piece-wise constant functions as subclass, the convergence is stated in Lemma 10.2 and proved in Subsection 10.2. In the second step, one controls the relevant error of approximating a general function by a function in the subclass. This is stated in Lemma 10.3 and proved in Subsection 10.8. The proof relies on a bound on the real Carleson maximal operator stated in Lemma 10.4 and proved in Subsection 10.9. This latter proof refers to the main Carleson Theorem 1.2. Two assumptions in Theorem 1.2 require more work. The boundedness of the nontangential maximal operator $T^{*}$ defined in (1.16) is established in Lemma 10.5 using $L^{2}$ and weak $L^{1}$ bounds for the Hilbert transform, Lemmas 10.6 and 10.7. These lemmas are proved in Subsections 10.3, 10.4 and 10.5. The cancellative property is verified by Lemma 10.8, which is proved in Subsection 10.6. Several further auxiliary lemmas are stated and proved in Subsection 10.1, the proof of one of these auxiliary lemmas, Lemma 10.12, is done in Subsection 10.7.

All subsections past Subsection 10.1 are mutually independent.
Subsections 10.3 uses bounds for the Hardy-Littlewood maximal function on the real line. There may be a better path through Lean than we choose here. We refer to Proposition 2.6 , the assumptions of it, namely that the real line fits into the setting of Section 2, is done in Subsection 10.9.
10.1. The classical Carleson theorem. Let a uniformly continuous $2 \pi$ periodic function $f: \mathbb{R} \rightarrow \mathbb{C}$, bounded in absolute value by 1 , be given. Let $0<\epsilon<1$ be given.

By uniform continuity of $f$, there is a $0<\delta<\pi$ such that for all $x, x^{\prime} \in \mathbb{R}$ with $\left|x-x^{\prime}\right| \leq \delta$ we have

$$
\begin{equation*}
\left|f(x)-f\left(x^{\prime}\right)\right| \leq 2^{-2^{50}} \epsilon^{2} \tag{10.1}
\end{equation*}
$$

Let $K$ be the Gaussian bracket of $\frac{2 \pi}{\delta}+1$, that is the unique integer with

$$
\begin{equation*}
K \leq \frac{2 \pi}{\delta}+1<K+1 \tag{10.2}
\end{equation*}
$$

and note that $K>2$ by assumption on $\delta$. For each $x \in \mathbb{R}$, let $k(x)$ be the Gaussian bracket of $K x / 2 \pi$, that is the unique integer such that

$$
\begin{equation*}
k(x) \leq \frac{K x}{2 \pi}<k(x)+1 . \tag{10.3}
\end{equation*}
$$

Define

$$
\begin{equation*}
f_{0}(x):=f\left(\frac{2 \pi k(x)}{K}\right) . \tag{10.4}
\end{equation*}
$$

Lemma 10.1 (piecewise constant approximation). The function $f_{0}$ is measurable. The function $f_{0}$ is $2 \pi$-periodic. The function $f_{0}$ satisfies for all $x \in \mathbb{R}$ :

$$
\begin{gather*}
\left|f(x)-f_{0}(x)\right| \leq 2^{-2^{50}} \epsilon^{2},  \tag{10.5}\\
\left|f_{0}(x)\right| \leq 1 \tag{10.6}
\end{gather*}
$$

Proof. Let $F$ be any set in $\mathbb{C}$. We show that $f_{0}^{-1}(F)$ is measurable. As $Z:=\{2 \pi k / K, k \in \mathbb{Z}\}$ is countable, it suffices to show that $f_{0}^{-1}(F) \backslash Z$ is measurable. It then suffices to show that $f_{0}^{-1}(F) \backslash Z$ is open. Let $x \in$ $f_{0}^{-1}(F) \backslash Z$. There is a $k$ such that $x \in[2 \pi k / K, 2 \pi(k+1))$. As $x \notin Z$, we have that $x \in(2 \pi k / K, 2 \pi(k+1))$. But $f_{0}$ is constant on $(2 \pi k / K, 2 \pi(k+1))$, hence $(2 \pi k / K, 2 \pi(k+1))$ is a subset of $f_{0}^{-1}(F) \backslash Z$. This proves that $f_{0}^{-1}(F) \backslash Z$ is open and completes the proof of measurability of $f_{0}$.

To see that $f_{0}$ is $2 \pi$-periodic, we observe by applying (10.3) to $x+2 \pi$ and subtracting $K$ that

$$
\begin{equation*}
k(x+2 \pi)-K \leq \frac{K x}{2 \pi}<k(x+2 \pi)-K+1 \tag{10.7}
\end{equation*}
$$

and hence

$$
\begin{equation*}
k(x+2 \pi)-K=k(x) \tag{10.8}
\end{equation*}
$$

and hence by Definition (10.4)

$$
\begin{equation*}
f_{0}(x+2 \pi)=f\left(\frac{2 \pi k(x+2 \pi)}{K}\right)=f\left(\frac{2 \pi(k(x)+K)}{K}\right)=f\left(\frac{2 \pi k(x)}{K}+2 \pi\right), \tag{10.9}
\end{equation*}
$$

which by $2 \pi$-periodicity of $f$ is equal to

$$
\begin{equation*}
=f\left(\frac{2 \pi k(x)}{K}\right)=f_{0}(x) . \tag{10.10}
\end{equation*}
$$

This proves that $f_{0}$ is $2 \pi$ - periodic

To see (10.5), observe that by (10.3) used twice and then by definition of $K$ we have

$$
\begin{equation*}
0 \leq x-\frac{2 \pi k(x)}{K} \leq \frac{2 \pi}{K} \leq \delta \tag{10.11}
\end{equation*}
$$

Hence, by choice of $\delta$, for all $x \in \mathbb{R}$, we obtain (10.5).
Finally (10.5) follows because $|f|$ by assumption is bounded by 1. This completes the proof of the lemma.

Define the set $E_{1}$ to be

$$
\begin{equation*}
E_{1}=\bigcup_{k=0}^{K}\left[\frac{2 \pi}{K}\left(k-\frac{\epsilon}{16 \pi}\right), \frac{2 \pi}{K}\left(k+\frac{\epsilon}{16 \pi}\right)\right] . \tag{10.12}
\end{equation*}
$$

Then we have for the Lebesgue measure of $E_{1}$, using $K>1$,

$$
\begin{equation*}
\left|E_{1}\right| \leq \sum_{k=0}^{K} \frac{\epsilon}{4 K}=\frac{\epsilon}{4}\left(1+\frac{1}{K}\right) \leq \frac{\epsilon}{2} \tag{10.13}
\end{equation*}
$$

We prove in Subsection 10.2:
Lemma 10.2 (convergence for piecewise constant). For all $N>\frac{2^{25} K^{2}}{\epsilon^{3}}$ and

$$
\begin{equation*}
x \in[0,2 \pi) \backslash E_{1} \tag{10.14}
\end{equation*}
$$

we have

$$
\begin{equation*}
\left|S_{N} f_{0}(x)-f_{0}(x)\right| \leq \frac{\epsilon}{4} \tag{10.15}
\end{equation*}
$$

We prove in Subsection 10.8:
Lemma 10.3 (control approximation effect). There is a set $E_{2} \subset \mathbb{R}$ with Lebesgue measure $\left|E_{2}\right| \leq \frac{\epsilon}{2}$ such that for all

$$
\begin{equation*}
x \in[0,2 \pi) \backslash E_{2} \tag{10.16}
\end{equation*}
$$

we have

$$
\begin{equation*}
\sup _{N \geq 0}\left|S_{N} f(x)-S_{N} f_{0}(x)\right| \leq \frac{\epsilon}{4} \tag{10.17}
\end{equation*}
$$

Define

$$
\begin{equation*}
E:=E_{1} \cup E_{2} \tag{10.18}
\end{equation*}
$$

Then

$$
\begin{equation*}
|E| \leq\left|E_{1}\right|+\left|E_{2}\right| \leq \frac{\epsilon}{2}+\frac{\epsilon}{2} \leq \epsilon . \tag{10.19}
\end{equation*}
$$

Let $N_{0}$ be the unique integer such that

$$
\begin{equation*}
N_{0}-1 \leq 2^{25} K^{2} \epsilon^{-3}<N_{0} \tag{10.20}
\end{equation*}
$$

For every

$$
\begin{equation*}
x \in[0,1) \backslash E \tag{10.21}
\end{equation*}
$$

and every $N>N_{0}$ we have by the triangle inequality

$$
\begin{gather*}
\left|f(x)-S_{N} f(x)\right| \\
\leq\left|f(x)-f_{0}(x)\right|+\left|f_{0}(x)-S_{N} f_{0}(x)\right|+\left|S_{N} f_{0}(x)-S_{N} f(x)\right| \tag{10.22}
\end{gather*}
$$

Using (10.1) and Lemmas 10.2 and 10.3, we estimate (10.22) by

$$
\begin{equation*}
\leq 2^{-2^{50}} \epsilon^{2}+\frac{\epsilon}{4}+\frac{\epsilon}{4} \leq \epsilon \tag{10.23}
\end{equation*}
$$

This shows (1.3) for the given $E$ and $N_{0}$ and completes the proof of Theorem 1.1.

Let $\kappa: \mathbb{R} \rightarrow \mathbb{R}$ be the function defined by $\kappa(0)=0$ and for $0<|x|<1$

$$
\begin{equation*}
\kappa(x)=\frac{1-|x|}{1-e^{i x}} \tag{10.24}
\end{equation*}
$$

and for $|x| \geq 1$

$$
\begin{equation*}
\kappa(x)=0 \tag{10.25}
\end{equation*}
$$

Note that this function is continuous at every point $x$ with $|x|>0$.
The proof of Lemma 10.3 will use the following Lemma 10.4, which itself is proven in Subsection 10.9 as an application of Theorem 1.2.

Lemma 10.4 (real Carleson). Let $F, G$ be Borel subsets of $\mathbb{R}$ with finite measure. Let $f$ be a bounded measurable function on $\mathbb{R}$ with $|f| \leq \mathbf{1}_{F}$. Then

\begin{equation*}
\left|\int_{G} T f(x) d x\right| \leq 2^{2^{40}}|F|^{\frac{1}{2}}|G|^{\frac{1}{2}} \tag{10.26}
\end{equation*}
$$

where

$$
\begin{equation*}
T f(x)=\sup _{n \in \mathbb{Z}} \sup _{r>0}\left|\int_{r<|x-y|<1} f(y) \kappa(x-y) e^{i n y} d y\right| \tag{10.27}
\end{equation*}
$$

One of the main assumption of Theorem 1.2, concerning the operator $T_{*}$ defined in (1.16), is verified by the following lemma, which is proved in Subsection 10.3.

Lemma 10.5 (nontangential Hilbert). For every bounded measurable function $g$ with bounded support we have

\begin{equation*}
\left\|T_{*} g\right\|_{2} \leq 2^{43}\|g\|_{2} \tag{10.28}
\end{equation*}
$$

where

$$
\begin{equation*}
T_{*} g(x):=\sup _{0<r_{1}<r_{2}<1} \sup _{\left|x-x^{\prime}\right|<r_{1}} \frac{1}{2 \pi}\left|\int_{r_{1}<\left|x^{\prime}-y\right|<r_{2}} g(y) \kappa\left(x^{\prime}-y\right) d y\right| \tag{10.29}
\end{equation*}
$$

The proof of Lemma 10.5 relies on the next two auxiliary Lemmas.
For $r \in(0,1), x \in \mathbb{R}$ and a bounded, measurable function $g$ on $\mathbb{R}$ with bounded support, we define

$$
\begin{equation*}
H_{r} g(x):=\int_{r<|x-y|<1} g(y) \kappa(x-y) d y \tag{10.30}
\end{equation*}
$$

The following Lemma is proved in Section 10.4
Lemma 10.6 (Hilbert strong 2 2). Let $0<r<1$. Let $f$ be a bounded, measurable function on $\mathbb{R}$ with bounded support. Then

$$
\begin{equation*}
\left\|H_{r} f\right\|_{2} \leq 2^{13}\|f\|_{2} \tag{10.31}
\end{equation*}
$$

The following Lemma is proved in Subsection 10.5
Lemma 10.7 (Hilbert weak 1 1). Let $f$ be a bounded measurable function on $\mathbb{R}$ with bounded support. Let $\alpha>0$. Then for all $r \in(0,1)$, we have

$$
\begin{equation*}
\mu\left(\left\{x \in \mathbb{R}:\left|H_{r} f(x)\right|>\alpha\right\}\right) \leq \frac{2^{19}}{\alpha} \int|f(y)| d y \tag{10.32}
\end{equation*}
$$

The next lemma will be used to verify that the collection $\Theta$ of modulation functions in our application of Theorem 1.2 satisfies the condition (1.12). It is proved in Subsection 10.6.

Lemma 10.8 (van der Corput). Let $\alpha<\beta$ be real numbers. Let $g: \mathbb{R} \rightarrow \mathbb{C}$ be a measurable function and assume

\|g\|_{L i p(\alpha, \beta)}:=\sup _{\alpha \leq x \leq \beta}|g(x)|+|\beta-\alpha| \sup _{\alpha \leq x<y \leq \beta} \frac{|g(y)-g(x)|}{|y-x|}<\infty . \tag{10.33}
\end{equation*}
$$

Then for any $0 \leq \alpha<\beta \leq 2 \pi$ we have

$$
\begin{equation*}
\int_{\alpha}^{\beta} g(x) e^{-i n x} d x \leq 2 \pi|\beta-\alpha|\|g\|_{L i p(\alpha, \beta)}(1+|n \| \beta-\alpha|)^{-1} . \tag{10.34}
\end{equation*}
$$

We close this section with six lemmas that are used across the following subsections.

Lemma 10.9 (mean zero oscillation). Let $n \in \mathbb{Z}$ with $n \neq 0$, then

$$
\begin{equation*}
\int_{0}^{2 \pi} e^{i n x} d x=0 \tag{10.35}
\end{equation*}
$$

Proof. We have

$$
\int_{0}^{2 \pi} e^{i n x} d x=\left[\frac{1}{i n} e^{i n x}\right]_{0}^{2 \pi}=\frac{1}{i n}\left(e^{2 \pi i n}-e^{2 \pi i 0}\right)=\frac{1}{i n}(1-1)=0 .
$$

Lemma 10.10 (Dirichlet kernel). We have for every $2 \pi$-periodic bounded measurable $f$ and every $N \geq 0$

$$
\begin{equation*}
S_{N} f(x)=\frac{1}{2 \pi} \int_{-\pi}^{\pi} f(y) K_{N}(x-y) d y \tag{10.36}
\end{equation*}
$$

where $K_{N}$ is the $2 \pi$-periodic continuous function of $\mathbb{R}$ given by

$$
\begin{equation*}
\sum_{n=-N}^{N} e^{i n x^{\prime}} \tag{10.37}
\end{equation*}
$$

We have for $e^{i x^{\prime}} \neq 1$ that

$$
\begin{equation*}
K_{N}\left(x^{\prime}\right)=\frac{e^{i N x^{\prime}}}{1-e^{-i x^{\prime}}}+\frac{e^{-i N x^{\prime}}}{1-e^{i x^{\prime}}} . \tag{10.38}
\end{equation*}
$$

Proof. We have by definitions and interchanging sum and integral

$$
\begin{align*}
& S_{N} f(x)=\sum_{n=-N}^{N} \widehat{f}_{n} e^{i n x} \\
= & \sum_{n=-N}^{N} \frac{1}{2 \pi} \int_{-\pi}^{\pi} f(x) e^{i n(x-y)} d y \\
= & \frac{1}{2 \pi} \int_{-\pi}^{\pi} f(y) \sum_{n=-N}^{N} e^{i n(x-y)} d y . \tag{10.39}
\end{align*}
$$

This proves the first statement of the lemma. By a telescoping sum, we have for every $x^{\prime} \in \mathbb{R}$

$$
\begin{equation*}
\left(e^{\frac{1}{2} i x^{\prime}}-e^{-\frac{1}{2} i x^{\prime}}\right) \sum_{n=-N}^{N} e^{i n x^{\prime}}=e^{\left(N+\frac{1}{2}\right) i x^{\prime}}-e^{-\left(N+\frac{1}{2}\right) i x^{\prime}} \tag{10.40}
\end{equation*}
$$

If $e^{i x^{\prime}} \neq 1$, the first factor on the left-hand side is not 0 and we may divide by this factor to obtain

$$
\begin{equation*}
\sum_{n=-N}^{N} e^{i n x^{\prime}}=\frac{e^{i\left(N+\frac{1}{2}\right) x^{\prime}}}{e^{\frac{1}{2} i x^{\prime}}-e^{-\frac{1}{2} i x^{\prime}}}-\frac{e^{-i\left(N+\frac{1}{2}\right) x^{\prime}}}{e^{\frac{1}{2} i x^{\prime}}-e^{-\frac{1}{2} i x^{\prime}}}=\frac{e^{i N x^{\prime}}}{1-e^{-i x^{\prime}}}+\frac{e^{-i N x^{\prime}}}{1-e^{i x^{\prime}}} . \tag{10.41}
\end{equation*}
$$

This proves the second part of the lemma.
Lemma 10.11 (lower secant bound). Let $\eta>0$ and $-2 \pi+\eta \leq x \leq 2 \pi-\eta$ with $|x| \geq \eta$. Then

$$
\begin{equation*}
\left|1-e^{i x}\right| \geq \frac{\eta}{8} \tag{10.42}
\end{equation*}
$$

Proof. We have

$$
\left|1-e^{i x}\right|=\sqrt{(1-\cos (x))^{2}+\sin ^{2}(x)} \geq|\sin (x)|
$$

If $0 \leq x \leq \frac{\pi}{2}$, then we have from concavity of $\sin$ on $[0, \pi]$ and $\sin (0)=0$ and $\sin \left(\frac{\pi}{2}\right)=1$

$$
|\sin (x)| \geq \frac{2}{\pi} x \geq \frac{2}{\pi} \eta
$$

When $x \in \frac{m \pi}{2}+\left[0, \frac{\pi}{2}\right]$ for $m \in\{-4,-3,-2,-1,1,2,3\}$ one can argue similarly.

The following lemma will be proved in Subsection 10.7.
Lemma 10.12 (spectral projection bound). Let $f$ be a bounded $2 \pi$-periodic measurable function. Then, for all $N \geq 0$

$$
\begin{equation*}
\left\|S_{N} f\right\|_{L^{2}[-\pi, \pi]} \leq\|f\|_{L^{2}[-\pi, \pi]} . \tag{10.43}
\end{equation*}
$$

Lemma 10.13 (Hilbert kernel bound). For $x, y \in \mathbb{R}$ with $x \neq y$ we have

$$
\begin{equation*}
|\kappa(x-y)| \leq 2^{4}(2|x-y|)^{-1} . \tag{10.44}
\end{equation*}
$$

Proof. Fix $x \neq y$. If $\kappa(x-y)$ is zero, then (10.44) is evident. Assume $\kappa(x-y)$ is not zero, then $0<|x-y|<1$. We have

$$
\begin{equation*}
|\kappa(x-y)|=\left|\frac{1-|x-y|}{1-e^{i(x-y)}}\right| \tag{10.45}
\end{equation*}
$$

We estimate with Lemma 10.11

$$
\begin{equation*}
|\kappa(x-y)| \leq \frac{1}{\left|1-e^{i(x-y)}\right|} \leq \frac{8}{|x-y|} . \tag{10.46}
\end{equation*}
$$

This proves (10.44) in the given case and completes the proof of the lemma.

Lemma 10.14 (Hilbert kernel regularity). For $x, y, y^{\prime} \in \mathbb{R}$ with $x \neq y, y^{\prime}$ and

2\left|y-y^{\prime}\right| \leq|x-y| \tag{10.47}
\end{equation*}
$$

we have

$$
\begin{equation*}
\left|\kappa(x-y)-\kappa\left(x-y^{\prime}\right)\right| \leq 2^{10} \frac{1}{|x-y|} \frac{\left|y-y^{\prime}\right|}{|x-y|} \tag{10.48}
\end{equation*}
$$

Proof. Upon replacing $y$ by $y-x$ and $y^{\prime}$ by $y^{\prime}-x$ on the left-hand side of (10.47), we can assume that $x=0$. Then the assumption (10.47) implies that $y$ and $y^{\prime}$ have the same sign. Since $\kappa(y)=\bar{\kappa}(-y)$ we can assume that they are both positive. Then it follows from (10.47) that

$$
\frac{y}{2} \leq y^{\prime}
$$

We distinguish four cases. If $y, y^{\prime} \leq 1$, then we have

$$
\left|\kappa(-y)-\kappa\left(-y^{\prime}\right)\right|=\left|\frac{1-y}{1-e^{-i y}}-\frac{1-y^{\prime}}{1-e^{-i y^{\prime}}}\right|
$$

and by the fundamental theorem of calculus

$$
=\left|\int_{y^{\prime}}^{y} \frac{-1+e^{-i t}+i(1-t) e^{i t}}{\left(1-e^{-i t}\right)^{2}} d t\right|
$$

Using $y^{\prime} \geq \frac{y}{2}$ and Lemma 10.11, we bound this by

$$
\leq\left|y-y^{\prime}\right| \sup _{\frac{y}{2} \leq t \leq 1} \frac{3}{\left|1-e^{-i t}\right|^{2}} \leq 3\left|y-y^{\prime}\right|\left(8 \frac{2}{y}\right)^{2} \leq 2^{10} \frac{\left|y-y^{\prime}\right|}{|y|^{2}}
$$

If $y \leq 1$ and $y^{\prime}>1$, then $\kappa\left(-y^{\prime}\right)=0$ and we have from the first case

$$
\left|\kappa(-y)-\kappa\left(-y^{\prime}\right)\right|=|\kappa(-y)-\kappa(-1)| \leq 2^{10} \frac{|y-1|}{|y|^{2}} \leq 2^{10} \frac{\left|y-y^{\prime}\right|}{|y|^{2}}
$$

Similarly, if $y>1$ and $y^{\prime} \leq 1$, then $\kappa(-y)=0$ and we have by the same computation as for the first case

$$
\left|\kappa(-y)-\kappa\left(-y^{\prime}\right)\right|=\left|\kappa\left(-y^{\prime}\right)-\kappa(-1)\right| \leq 2^{10} \frac{|y-1|}{|y|^{2}} \leq 2^{10} \frac{\left|y-y^{\prime}\right|}{|y|^{2}}
$$

Finally, if $y, y^{\prime}>1$ then

$$
\left|\kappa(-y)-\kappa\left(-y^{\prime}\right)\right|=0 \leq 2^{10} \frac{\left|y-y^{\prime}\right|}{|y|^{2}}
$$

10.2. Piecewise constant functions. We first compute the partial Fourier sums for constant functions.

Lemma 10.15 (constant function). If $h$ satisfies $h(x)=h(0)$ for all $x \in \mathbb{R}$, then for all $N \geq 0$ we have $S_{N} h=h$.

Proof. We compute with Lemma 10.9 for $n \in \mathbb{Z}$ with $n \neq 0$,

$$
\begin{equation*}
\widehat{h}_{n}=\frac{1}{2 \pi} \int_{0}^{2 \pi} h(y) e^{-i n y} d y=\frac{h(0)}{2 \pi} \int_{0}^{2 \pi} e^{-i n y} d y=0 \tag{10.49}
\end{equation*}
$$

hence for $N \geq 0$

$$
\begin{equation*}
S_{n} h(x)=\sum_{n=-N}^{N} \widehat{h}_{n} e^{i n x}=\widehat{h_{0}}=\frac{1}{2 \pi} \int_{0}^{2 \pi} h(y) d y=\frac{h(0)}{2 \pi} \int_{0}^{2 \pi} d y=h(x) \tag{10.50}
\end{equation*}
$$

This proves the lemma.
Lemma 10.16 (Dirichlet kernel bound). Let $\eta>0$. Let

$$
\begin{equation*}
-2 \pi+\eta \leq \alpha<\beta \leq 2 \pi-\eta \tag{10.51}
\end{equation*}
$$

and assume

$$
\begin{equation*}
[\alpha, \beta] \cap[-\eta, \eta]=\emptyset \tag{10.52}
\end{equation*}
$$

Then

$$
\begin{equation*}
\left|\int_{\alpha}^{\beta} \frac{e^{i N x}}{1-e^{-i x}} d x\right| \leq \frac{64}{N}\left(\frac{|\beta-\alpha|}{\eta^{2}}+\frac{1}{\eta}\right) \tag{10.53}
\end{equation*}
$$

Proof. Note first that the integral in (10.53) is well defined as the denominator of the integrand is bounded away from zero by Lemma 10.11 and thus the integrand is continuous. We have with partial integration

$$
\begin{gather*}
\int_{\alpha}^{\beta} \frac{e^{-i N x}}{1-e^{i x}} d x \\
=\frac{1}{-i N} \int_{\alpha}^{\beta} e^{-i N x} \frac{i e^{i x}}{\left(1-e^{i x}\right)^{2}} d x+\left[\frac{1}{-i N} \frac{e^{-i N x}}{1-e^{i x}}\right]_{\alpha}^{\beta} \tag{10.54}
\end{gather*}
$$

We estimate the two summands in (10.54) separately. We have for the first summand in (10.54) with Lemma 10.11,

$$
\begin{gather*}
\left|\frac{1}{-i N} \int_{\alpha}^{\beta} e^{-i N x} \frac{i e^{i x}}{\left(1-e^{i x}\right)^{2}} d x\right| \\
\leq \frac{1}{N} \int_{\alpha}^{\beta}\left|1-e^{-i x}\right|^{-2} d x \leq \frac{|\beta-\alpha|}{N} \sup _{x \in[\alpha, \beta]}\left|1-e^{-i x}\right|^{-2}  \tag{10.55}\\
\leq \frac{64|\beta-\alpha|}{\eta^{2} N} \tag{10.56}
\end{gather*}
$$

We have for the second summand in (10.54) with Lemma 10.11 again

$$
\begin{gather*}
\left|\left[\frac{1}{-i N} \frac{e^{-i N x}}{1-e^{i x}}\right]_{\alpha}^{\beta}\right| \\
\leq \frac{1}{N}\left(\left|1-e^{i \alpha}\right|^{-1}+\left|1-e^{i \beta}\right|^{-1}\right) \leq \frac{16}{\eta N} \tag{10.57}
\end{gather*}
$$

Using the triangle inequality in (10.54) and applying the estimates (10.55) and (10.57) proves the lemma.

Let $\mathcal{G}$ be the class of $2 \pi$-periodic measurable functions $g$ which satisfy for all $x \in \mathbb{R}$

$$
\begin{equation*}
g\left(\frac{2 \pi k(x)}{K}\right)=g(x) \tag{10.58}
\end{equation*}
$$

and

$$
\begin{equation*}
|g(x)| \leq 2 \tag{10.59}
\end{equation*}
$$

Lemma 10.17 (flat interval partial sum). Let $g \in \mathcal{G}$. Assume $x \in[0,2 \pi) \backslash$ $E_{1}$ and $g(x)=0$. Then for all $N>\frac{2^{25} K^{2}}{\epsilon^{3}}$

$$
\begin{equation*}
\left|S_{N} g(x)\right| \leq \frac{\epsilon}{4} \tag{10.60}
\end{equation*}
$$

Proof. With Lemma 10.10, breaking up the domain of integration into a partition of subintervals,

$$
\begin{align*}
& \left|S_{N}(g)\right|=\frac{1}{2 \pi}\left|\int_{-\pi}^{\pi} g(y) K_{N}(x-y) d y\right| \\
= & \frac{1}{2 \pi}\left|\sum_{k=0}^{K-1} \int_{\frac{2 \pi k}{K}}^{\frac{2 \pi(k+1)}{K}} g(y) K_{N}(x-y) d y\right| . \tag{10.61}
\end{align*}
$$

Using $g \in \mathcal{G}$ and that $k(y)=k$ for each

$$
\begin{equation*}
y \in\left[\frac{2 \pi k}{K}, \frac{2 \pi(k+1)}{K}\right) \tag{10.62}
\end{equation*}
$$

and then applying the triangle inequality with the upper bound on $|g|$ and the identity $g(x)=g(2 \pi k(x) / K)=0$, we estimate (10.61) by

$$
\begin{align*}
& =\frac{1}{2 \pi}\left|\sum_{k=0}^{K-1} g\left(\frac{2 \pi k}{K}\right) \int_{\frac{2 \pi k}{K}}^{\frac{2 \pi(k+1)}{K}} K_{N}(x-y) d y\right| \\
& \leq \frac{1}{\pi} \sum_{0 \leq k<K, k \neq k(x)}\left|\int_{\frac{2 \pi k}{K} \frac{2 \pi(k+1)}{K}} K_{N}(x-y) d y\right| . \tag{10.63}
\end{align*}
$$

Doing a variable substitution, we obtain for (10.63)

$$
\begin{equation*}
\frac{1}{\pi} \sum_{0 \leq k<K, k \neq k(x)}\left|\int_{x-2 \pi(k+1) / K}^{x-2 \pi k / K} K_{N}(y) d y\right| \tag{10.64}
\end{equation*}
$$

Fix $0 \leq k<K$ with $k \neq k(x)$ and set

$$
\begin{gather*}
\alpha=x-2 \pi(k+1) / K  \tag{10.65}\\
\beta=x-2 \pi k / K \tag{10.66}
\end{gather*}
$$

As $x \in[0,2 \pi) \backslash E_{1}$, we have with $\eta=\epsilon /(8 K)$

$$
\begin{gather*}
\alpha \geq x-2 \pi \geq-2 \pi+\eta  \tag{10.67}\\
\beta \leq x \leq 2 \pi-\eta \tag{10.68}
\end{gather*}
$$

If $\beta<0$, then $2 \pi k / K>x$ and as $x \notin E_{1}$ also $2 \pi k-\eta \geq x$. Hence $\beta \leq-\eta$. If $\beta \geq 0$, then $2 \pi k / K \leq x$. As $k \neq k(x)$, we also have $2 \pi(k+1) / K \leq x$. As $x \notin E_{1}$, we have $2 \pi(k+1) / K+\eta \leq x$. It follows that $0<\alpha$. In both cases, we have seen (10.52).

With Lemma 10.10 and the triangle inequality, it follows that

$$
\begin{equation*}
\left|\int_{x-2 \pi(k+1) / K}^{x-2 \pi k / K} K_{N}(y) d y\right| \leq\left|\int_{\alpha}^{\beta} \frac{e^{i N y}}{1-e^{-i y}} d y\right|+\left|\int_{\alpha}^{\beta} \frac{e^{-i N y}}{1-e^{i y}} d y\right| \tag{10.69}
\end{equation*}
$$

Using that the two integrals on the right-hand side are complex conjugates of each other, and using Lemma 10.16 and $\epsilon<2 \pi$, this is bounded by

$$
\begin{equation*}
\leq 2\left|\int_{\alpha}^{\beta} \frac{e^{i N y}}{1-e^{-i y}} d y\right| \leq \frac{128}{N}\left(\frac{|\beta-\alpha|}{\eta^{2}}+\frac{1}{\eta}\right) \leq \frac{2^{20} K}{N \epsilon^{2}} \leq 2^{-3} \epsilon K^{-1} \tag{10.70}
\end{equation*}
$$

Inserting this in (10.63) and adding up proves the lemma.
We now prove Lemma 10.2.
Let $x \in[0,2 \pi) \backslash E_{1}$ and $N>\frac{2^{25} K^{2}}{\epsilon^{3}}$. Let $h$ be the function which is constant equal to $f_{0}(x)$ and let $g=f_{0}-h$. By the bound on $f$ and the triangle inequality, $|g|$ is bounded by 2. Hence $g$ is in the class $\mathcal{G}$. We also have $g(x)=0$. Using Lemma 10.15, we obtain

\begin{equation*}
S_{N} f_{0}(x)-f_{0}(x)=S_{N}(g+h)(x)-S_{N} h(x)=S_{N} g(x) \tag{10.71}
\end{equation*}
$$

Lemma 10.2 now follows by Lemma 10.17.

### 10.3. Proof of Cotlar's Inequality.

Lemma 10.18 (estimate x shift). Let $0<r<1$ and $x \in \mathbb{R}$. Let $g$ be a bounded measurable function with bounded support on $\mathbb{R}$. Let $M g$ be the Hardy-Littlewood function defined in Proposition 2.6. Then for all $x^{\prime}$ with $\left|x-x^{\prime}\right|<r$.

$$
\begin{equation*}
\left|\int_{r<|x-y|<1} g(y) \kappa(x-y) d y-\int_{r<\left|x^{\prime}-y\right|<1} g(y) \kappa\left(x^{\prime}-y\right) d y\right| \leq 2^{13} M g(x) \tag{10.72}
\end{equation*}
$$

Proof. First note that the conditions $|x-y|<1$ and $\left|x^{\prime}-y\right|<1$ may be removed as the factor containing $\kappa$ vanishes without these conditions.

We split the first integral in (10.72) into the domains $r<|x-y| \leq 2 r$ and $2 r<|x-y|$. The integral over the first domain we estimate by (10.73) below. For the second domain, we observe with $\left|x-x^{\prime}\right|<r$ and the triangle inequality that $r<\left|x^{\prime}-y\right|$. We therefore combine on this domain with the corresponding part of the second integral in (10.72) and estimate that by (10.74) below. The remaining part of the second integral in (10.72) we estimate by (10.75). Overall, we have estimated (10.72) by

\int_{r<|x-y| \leq 2 r}|g(y)||\kappa(x-y)| d y  \tag{10.73}\\
+\left|\int_{2 r<|x-y|} g(y)\left(\kappa\left(x^{\prime}-y\right)-\kappa(x-y)\right) d y\right|  \tag{10.74}\\
+\left|\int_{r<\left|x^{\prime}-y\right|, r<|x-y|<2 r}\right| g(y) \kappa\left(x^{\prime}-y\right)|d y| \tag{10.75}
\end{gather*}
$$

Using the bound on $\kappa$ in Lemma 10.13, we estimate (10.73) by

\frac{8}{r} \int_{|x-y|<2 r}|g(y)| d y \tag{10.76}
\end{equation*}
$$

Using the definition of $M g$, we estimate (10.76) by

\leq 32 M g(x) \tag{10.77}
\end{equation*}
$$

Similarly, in the domain of (10.75) we note by the triangle inequality and assumption on $x^{\prime}$ that $\left|x^{\prime}-y\right| \leq 3 r$ and thus we estimate (10.75) by

We turn to the term (10.74). Let $\nu$ be the smallest integer such that $2^{\nu}>2 / r$. Using that the kernel vanishes unless $|x-y|<2$, we decompose and estimate (10.74) with the triangle inequality by

Using Lemma 10.14, we estimate (10.79) by

& 2^{10} \sum_{j=1}^{\nu} \int_{2^{j} r<|x-y| \leq 2^{j+1} r}|g(y)| \frac{\left|x-x^{\prime}\right|}{|x-y|^{2}} d y \\
& \leq 2^{10} \sum_{j=1}^{\nu} \frac{1}{2^{2 j} r} \int_{2^{j} r<|x-y| \leq 2^{j+1} r}|g(y)| d y \\
& \quad \leq 2^{10} \sum_{j=1}^{\nu} 2^{1-j} M g(x) \tag{10.80}
\end{align*}
$$

Using a geometric series, we estimate (10.80) by

\leq 2^{11} M g(x) \tag{10.81}
\end{equation*}
$$

Summing the estimates for $(10.73),(10.74)$, and (10.75) proves the lemma.

On the domain $r_{1}<\left|x^{\prime}-y\right|$, we have $\frac{r_{1}}{2}<|x-y|$. Hence we may write for (10.84)

\end{align*}

Combining the estimate (10.83) with the identification (10.85), we obtain

\left|H_{r_{1}} g(x)\right| \leq\left|H_{r_{1}}\left(g-g \mathbf{1}_{\left[x-\frac{r_{1}}{2}, x+\frac{\left.r_{1}\right]}{2}\right.}\right)\left(x^{\prime}\right)\right|+2^{13} M g(x) \tag{10.86}
\end{equation*}
$$

We have

\begin{gather*}
\left(H_{r}-H_{r_{1}}\right)\left(g-g \mathbf{1}_{\left[x-\frac{r_{1}}{2}, x+\frac{\left.r_{1}\right]}{2}\right.}\right)\left(x^{\prime}\right) \\
=\int_{r<\left|x^{\prime}-y\right|<r_{1}}\left(g-g \mathbf{1}_{\left[x-\frac{r_{1}}{2}, x+\frac{r_{1}}{2}\right]}\right)(y) k\left(x^{\prime}-y\right) d y . \tag{10.87}
\end{gather*}
$$

Assume first $r \geq \frac{r_{1}}{4}$. Then we estimate (10.87) with Lemma 10.13 by

& \int_{\frac{r_{1}}{4}<\left|x^{\prime}-y\right|<r_{1}}\left|g(y) k\left(x^{\prime}-y\right)\right| d y \\
\leq & \frac{32}{r_{1}} \int_{\left|x^{\prime}-y\right|<r_{1}}|g(y)| d y \leq 64 M g\left(x^{\prime}\right) . \tag{10.88}

Assume now $r \leq \frac{r_{1}}{4}$. As $\left|x^{\prime}-y\right| \leq \frac{r_{1}}{4}$ implies $|x-y| \leq \frac{r_{1}}{2}$, we see that (10.87) equals

Then the measure $\left|F_{1}\right|$ of the set $F_{1}$ of all $x^{\prime} \in\left[x-\frac{r_{1}}{4}, x+\frac{r_{1}}{4}\right]$ such that

is less than or equal to $r_{1} / 8$. Moreover, the measure $\left|F_{2}\right|$ of the set $F_{2}$ of all $x^{\prime} \in\left[x-\frac{r_{1}}{4}, x+\frac{r_{1}}{4}\right]$ such that

\left|H_{r}\left(g \mathbf{1}_{\left[x-\frac{r_{1}}{2}, x+\frac{r_{1}}{2}\right]}\right)\right|>2^{22} M g(x) \tag{10.90}

is less than $r_{1} / 8$.
Proof. Let $r, r_{1}, x$ and $g$ be given. If $M\left(H_{r} g\right)(x)=0$, then $H_{r} g$ is constant zero and $F_{1}$ is empty and the estimate on $F_{1}$ trivial. Assume $M\left(H_{r} g\right)(x)>$ 0 . We have with (10.89)

\geq \frac{2}{r_{1}} \int_{F_{1}} 4 M\left(H_{r} g\right)(x) d x^{\prime} \tag{10.92}
\end{gather*}

Dividing by $M\left(H_{r} g\right)(x)$ gives

This gives the desired bound for the measure of $F_{1}$.
We turn to the set $F_{2}$. Similarly as above we may assume $\operatorname{Mg}(x)>0$. The set $F_{2}$ is then estimated with Lemma 10.7 by

This gives the desired bound for the measure of $F_{2}$.
Lemma 10.21 (Cotlar estimate). Let $0<r<r_{1}<1$ and $x \in \mathbb{R}$. Let $g$ be a bounded measurable function with bounded support on $\mathbb{R}$. Let $M g$ and $M\left(H_{r} g\right)$ be the respective Hardy-Littlewood maximal functions defined in Proposition 2.6. Then for all $x \in \mathbb{R}$

& \left|\int_{r_{1}<|x-y|<1} g(y) \kappa(x-y) d y\right|  \tag{10.96}\\
& \leq 2^{2} M\left(H_{r} g\right)(x)+2^{23} M g(x) \tag{10.97}
\end{align*}

Proof. By Lemma 10.19, the measure of the set of all $x^{\prime} \in\left[x-\frac{r_{1}}{4}, x+\frac{r_{1}}{4}\right]$ such that at least one of the conditions (10.89) and (10.90) is satisfied is at most $r_{1} / 4$ and hence not all of $x^{\prime} \in\left[x-\frac{r_{1}}{4}, x+\frac{r_{1}}{4}\right]$. Pick an $x^{\prime} \in\left[x-\frac{r_{1}}{4}, x+\frac{r_{1}}{4}\right]$ such that both conditions are not satisfied. Applying Lemma 10.19 for this $x^{\prime}$ and using the triangle inequality estimates the left-hand side of (10.96) by

\end{equation*}

Proof. With Lemma 10.18 and the triangle inequality, we estimate for every $x \in \mathbb{R}$

T_{r} g(x) \leq 2^{13} M g(x)+\sup _{r<r_{1}<1} \frac{1}{2 \pi}\left|\int_{r_{1}<|x-y|<1} g(y) \kappa(x-y) d y\right| \tag{10.101}

Using further Lemma 10.21, we estimate

Taking the $L^{2}$ norm and using Proposition 2.6 with $a=4$ and $p_{2}=2$ and $p_{1}=1$, we obtain

& \leq 2^{41}\|g\|_{2}+2^{19}\left\|H_{r}(g)\right\|_{2} \tag{10.104}
\end{align*}
$$

Applying Lemma 10.6, gives

& +\sup _{0<r_{1}<r_{2}<1} \sup _{\left|x-x^{\prime}\right|<r_{1}} \frac{1}{2 \pi}\left|\int_{r_{2}<\left|x^{\prime}-y\right|<1} g(y) \kappa\left(x^{\prime}-y\right) d y\right|
\end{align*}
$$

Noting that the first integral does not depend on $r_{2}$ and estimating the second integral by the larger supremum over all $\left|x-x^{\prime}\right|<r_{2}$, at which time the integral does not depend on $r_{1}$, we estimate $(10.108)$ by

\end{equation*}
$$

Proof. We have

\left\|M_{n} g\right\|_{L^{2}[-\pi, \pi]}^{2}=\int_{-\pi}^{\pi}\left|e^{i n x} g(x)\right|^{2} d x=\int_{-\pi}^{\pi}|g(x)|^{2} d x=\|g\|_{L^{2}[-\pi, \pi]}^{2} \tag{10.113}
\end{equation*}
$$

We have by the triangle inequality, the square root of the identity in (10.113), and Lemma 10.12

\left\|L_{n} g\right\|_{L^{2}[-\pi, \pi]}=\left\|\frac{1}{N} \sum_{n=0}^{N-1} M_{-n-N} S_{N+n} M_{N+n} g\right\|_{L^{2}[-\pi, \pi]} \\
\leq \frac{1}{N} \sum_{n=0}^{N-1}\left\|M_{-n-N} S_{N+n} M_{N+n} g\right\|_{L^{2}[-\pi, \pi]}=\frac{1}{N} \sum_{n=0}^{N-1}\left\|S_{N+n} M_{N+n} g\right\|_{L^{2}[-\pi, \pi]}
\end{gathered}
$$

$$
\begin{equation*}
\leq \frac{1}{N} \sum_{n=0}^{N-1}\left\|M_{N+n} g\right\|_{L^{2}[-\pi, \pi]}=\frac{1}{N} \sum_{n=0}^{N-1}\|g\|_{L^{2}[-\pi, \pi]}=\|g\|_{L^{2}[-\pi, \pi]} \tag{10.114}
\end{equation*}
$$

This proves (10.113) and completes the proof of the lemma.
Lemma 10.24 (periodic domain shift). Let $f$ be a bounded $2 \pi$-periodic function. We have for any $0 \leq x \leq 2 \pi$ that

& =\int_{-\pi}^{\pi} f(y)^{2} \int_{-\pi}^{\pi} g(x) d x d y=\|f\|_{L^{2}[-\pi, \pi]}^{2}\|g\|_{L^{1}[-\pi, \pi]} . \tag{10.119}
\end{align*}
$$

Let $h$ be the nonnegative square root of $g$, then $h$ is bounded and $2 \pi$-periodic with $h^{2}=g$. We estimate the square of the left-hand side of (10.118) with Cauchy-Schwarz and then with (10.119) by

\int_{-\pi}^{\pi}\left(\int_{-\pi}^{\pi} f(y) h(x-y) h(x-y) d y\right)^{2} d x \\
\leq \int_{-\pi}^{\pi}\left(\int_{-\pi}^{\pi} f(y)^{2} g(x-y) d y\right)\left(\int_{-\pi}^{\pi} g(x-y) d y\right) d x \\
=\|f\|_{L^{2}[-\pi, \pi]}^{2}\|g\|_{L^{1}[-\pi, \pi]}^{2}

Taking square roots, this proves the lemma.
For $0<r<1$, Define the kernel $k_{r}$ to be the $2 \pi$-periodic function

= & 2 \int_{0}^{\pi} \min \left(\frac{1}{r}, 1+\frac{r}{\left|1-e^{i x}\right|^{2}}\right) d x \\
& \leq 2 \int_{0}^{r} \frac{1}{r} d x+2 \int_{r}^{\pi} 1+\frac{64 r}{x^{2}} d x \\
& \leq 2+2 \pi+2\left(\frac{64 r}{r}-\frac{64 r}{\pi}\right) \leq 2^{5} \tag{10.125}
\end{align*}
$$

Together with Lemma 10.25, this proves the lemma.
Lemma 10.27 (dirichlet approximation). Let $0<r<1$. Let $N$ be the smallest integer larger than $\frac{1}{r}$. There is a $2 \pi$-periodic continuous function $L^{\prime}$ on $\mathbb{R}$ that satisfies for all $-\pi \leq x \leq \pi$ and all $2 \pi$-periodic bounded measurable functions $f$ on $\mathbb{R}$

$$
\begin{equation*}
L_{N} f(x)=\frac{1}{2 \pi} \int_{-\pi}^{\pi} f(y) L^{\prime}(x-y) d y \tag{10.126}
\end{equation*}
$$

and

$$
\begin{equation*}
\left|L^{\prime}(x)-\mathbf{1}_{\{y: r<|y|<1\}} \kappa(x)\right| \leq 2^{5} k_{r}(x) . \tag{10.127}
\end{equation*}
$$

Proof. We have by definition and Lemma 10.10

$$
\begin{equation*}
L_{N} g(x)=\frac{1}{N} \sum_{n=0}^{N-1} \int_{-\pi}^{\pi} e^{-i(N+n) x} K_{N+n}(x-y) e^{i(N+n) y} g(y) d y \tag{10.128}
\end{equation*}
$$

This is of the form (10.126) with the continuous function

$$
\begin{equation*}
L^{\prime}(x)=\frac{1}{N} \sum_{n=0}^{N-1} K_{N+n}(x) e^{-i(N+n) x} \tag{10.129}
\end{equation*}
$$

With (10.37) of Lemma 10.10 we have $\left|K_{N}(x)\right| \leq N$ for every $x$ and thus

$$
\begin{equation*}
\left|L^{\prime}(x)\right| \leq \frac{1}{N} \sum_{n=0}^{N-1}(N+n) \leq 2 N \leq 2^{2} r^{-1} \tag{10.130}
\end{equation*}
$$

Therefore, for $|x| \in[0, r) \cup(1, \pi]$, we have

$$
\begin{equation*}
\left|L^{\prime}(x)-\mathbf{1}_{\{y: r<|y|<1\}}(x) \kappa(x)\right|=\left|L^{\prime}(x)\right| \leq 2^{2} r^{-1} . \tag{10.131}
\end{equation*}
$$

This proves (10.127) for $|x| \in[0, r)$ since $k_{r}(x)=r^{-1}$ in this case.
For $e^{i x^{\prime}} \neq 1$ and may use the expression (10.38) for $K_{N}$ in Lemma 10.10 to obtain

$$
\begin{align*}
L^{\prime}(x)= & \frac{1}{N} \sum_{n=0}^{N-1}\left(\frac{e^{i(N+n) x}}{1-e^{-i x}}+\frac{e^{-i(N+n) x}}{1-e^{i x}}\right) e^{-i(N+n) x} \\
& =\frac{1}{N} \sum_{n=0}^{N-1}\left(\frac{1}{1-e^{-i x}}+\frac{e^{-i 2(N+n) x}}{1-e^{i x}}\right) \\
& =\frac{1}{1-e^{-i x}}+\frac{1}{N} \frac{e^{-i 2 N x}}{1-e^{i x}} \sum_{n=0}^{N-1} e^{-i 2 n x} \tag{10.132}
\end{align*}
$$

and thus

$$
\begin{equation*}
L^{\prime}(x)-\mathbf{1}_{\{y: r<|y|<1\}} \kappa(x)=L^{\prime \prime}(x)+\frac{1-\mathbf{1}_{\{y: r<|y|<1\}}(x)(1-|x|)}{1-e^{-i x}}, \tag{10.133}
\end{equation*}
$$

where

$$
L^{\prime \prime}(x):=\frac{1}{N} \frac{e^{-i 2 N x}}{1-e^{i x}} \sum_{n=0}^{N-1} e^{-i 2 n x} .
$$

For $x \in[-\pi, r] \cup[r, \pi]$, we have using Lemma 10.11 that

$$
\begin{gather*}
\left|\frac{1-\mathbf{1}_{\{y: r<|y|<1\}}(x)(1-|x|)}{1-e^{-i x}}\right|=\left|\frac{\min (|x|, 1)}{1-e^{-i x}}\right| \leq \frac{8 \min (|x|, 1)}{|x|} \\
\leq 2^{3} \cdot 1 \leq 2^{3} k_{r}(x) . \tag{10.134}
\end{gather*}
$$

Next, we need to estimate $L^{\prime \prime}(x)$. If the real part of $e^{i x}$ is negative, we have

$$
\begin{equation*}
1 \leq\left|1-e^{i x}\right| \leq 2 \tag{10.135}
\end{equation*}
$$

and hence

$$
\begin{equation*}
\left|L^{\prime \prime}(x)\right| \leq \frac{1}{N} \sum_{n=0}^{N-1} 1=1 \leq 1+\frac{r}{\left|1-e^{i x}\right|^{2}} . \tag{10.136}
\end{equation*}
$$

If the real part of $e^{i x}$ is positive and in particular while still $e^{i x} \neq \pm 1$, then we have by telescoping

$$
\begin{equation*}
\left(1-e^{-2 i x}\right) \sum_{n=0}^{N-1} e^{-i 2 n x}=1-e^{-i 2 N x} . \tag{10.137}
\end{equation*}
$$

As $e^{-2 i x} \neq 1$, we may divide by $1-e^{-2 i x}$ and insert this into (10.132) to obtain

$$
\begin{equation*}
L^{\prime \prime}(x)=\frac{1}{N} \frac{e^{-i 2 N x}}{1-e^{i x}} \frac{1-e^{-i 2 N x}}{1-e^{-2 i x}} . \tag{10.138}
\end{equation*}
$$

Hence, with Lemma 10.11 and nonnegativity of the real part of $e^{i x}$

$$
\begin{gather*}
\left|L^{\prime \prime}(x)\right| \leq \frac{2}{N} \frac{1}{\left|1-e^{i x}\right|} \frac{1}{\left|1-e^{-2 i x}\right|} \\
=\frac{2}{N} \frac{1}{\left|1-e^{i x}\right|^{2}} \frac{1}{\left|1+e^{i x}\right|} \leq \frac{4 r}{\left|1-e^{i x}\right|^{2}} \leq 2^{2}\left(1+\frac{r}{\left|1-e^{i x}\right|^{2}}\right) \tag{10.139}
\end{gather*}
$$

Inequalities (10.130), (10.131), (10.133), (10.134), (10.136), and (10.139) prove (10.127). This completes the proof of the lemma.

We now prove Lemma 10.6.
Proof of Lemma 10.6. We first show that if $f$ is supported in $[-3 / 2,3 / 2]$, then

\left\|H_{r} f\right\|_{L^{2}(\mathbb{R})} \leq 2^{16}\|f\|_{L^{2}(\mathbb{R})} \tag{10.140}
\end{equation*}
$$

Let $\tilde{f}$ be the $2 \pi$-periodic extension of $f$ to $\mathbb{R}$. Let $N$ be the smallest integer larger than $\frac{1}{r}$. Then, by Lemma 10.27 and the triangle inequality, for $x \in$ $[-\pi, \pi]$ we have

$$
\left|H_{r} \tilde{f}(x)\right| \leq 2 \pi\left|L_{N} \tilde{f}(x)\right|+2^{5}\left|\int_{-\pi}^{\pi} k_{r}(x-y) \tilde{f}(y) d y\right|
$$

Taking $L^{2}$ norm over the interval $[-\pi, \pi]$ and using its sub-additivity, we get

$$
\begin{gathered}
\left\|H_{r} \tilde{f}\right\|_{L^{2}([-\pi, \pi])} \\
\leq 2 \pi\left\|L_{N} \tilde{f}\right\|_{L^{2}([-\pi, \pi])}+2^{5}\left(\int_{-\pi}^{\pi}\left|\int_{-\pi}^{\pi} k_{r}(x-y) \tilde{f}(y) d y\right|^{2} d x\right)^{\frac{1}{2}}
\end{gathered}
$$

Since $k_{r}$ is supported in $[-1,1]$, we have that $H_{r} f$ is supported in $[-5 / 2,5 / 2]$ and agrees there with $H_{r} \tilde{f}(x)$. Using Lemma 10.23 and Lemma 10.26, we conclude

$$
\begin{equation*}
\left\|H_{r} f\right\|_{L^{2}(\mathbb{R})} \leq\left\|H_{r} \tilde{f}\right\|_{L^{2}([-\pi, \pi])} \leq 2 \pi\|f\|_{L^{2}(\mathbb{R})}+2^{10}\|f\|_{L^{2}(\mathbb{R})} \tag{10.141}
\end{equation*}
$$

which gives (10.140).
Suppose now that $f$ is supported in $[c, c+3]$ for some $c \in \mathbb{R}$. Then the function $g(x)=f\left(c+\frac{3}{2}+x\right)$ is supported in $[-3 / 2,3 / 2]$. By a change of variables in (10.30), we have $H_{r} g(x)=H_{r} f(c+3 / 2+x)$. Thus, by (10.140)

$$
\begin{equation*}
\left\|H_{r} g\right\|_{2}=\left\|H_{r} f\right\|_{2} \leq 2^{11}\|f\|_{2}=\|g\|_{2} \tag{10.142}
\end{equation*}
$$

Let now $f$ be arbitrary. Since $\kappa(x)=0$ for $|x|>1$, we have for all $x \in[c+1, c+2]$

$$
H_{r} f(x)=H_{r}\left(f \mathbf{1}_{[c, c+3]}\right)(x)
$$

Thus

$$
\int_{c+1}^{c+2}\left|H_{r} f(x)\right|^{2} \mathrm{~d} x \leq \int_{\mathbb{R}}\left|H_{r}\left(f \mathbf{1}_{[c, c+3]}\right)(x)\right|^{2} \mathrm{~d} x
$$

Applying the bound (10.142), this is

$$
\leq 2^{11} \int_{c}^{c+3}|f(x)|^{2} \mathrm{~d} x
$$

Summing over all $c \in \mathbb{Z}$, we obtain

$$
\int_{\mathbb{R}}\left|H_{r} f(x)\right|^{2} \mathrm{~d} x \leq 3 \cdot 2^{11} \int_{\mathbb{R}}|f(x)|^{2} \mathrm{~d} x
$$

This completes the proof.
10.5. Calderón-Zygmund Decomposition. For $I=[s, t) \subset \mathbb{R}$, we define

$$
\begin{equation*}
\operatorname{bi}(I):=\left\{\left[s, \frac{s+t}{2}\right),\left[\frac{s+t}{2}, t\right)\right\} . \tag{10.143}
\end{equation*}
$$

In what follows, we write $\mu$ for the Lebesgue measure on $\mathbb{R}$.
Lemma 10.28 (interval bisection). Let $I=[s, t) \subset \mathbb{R}$ be a bounded, rightopen interval. Let $I_{1}, I_{2} \in b i(I)$ with $I_{1} \neq I_{2}$. Then

$$
\begin{equation*}
\mu\left(I_{1}\right)=\mu\left(I_{2}\right)=\frac{\mu(I)}{2} . \tag{10.144}
\end{equation*}
$$

Further,

$$
\begin{equation*}
I=I_{1} \cup I_{2}, \tag{10.145}
\end{equation*}
$$

and the intervals $I_{1}$ and $I_{2}$ are disjoint.
Proof. This in some form can be taken from the Lean library.
For a bounded interval $I=[a, b) \subset \mathbb{R}$ and a non-negative integer $n$, we inductively define

$$
\begin{equation*}
\operatorname{ch}_{0}(I):=\{I\}, \quad \operatorname{ch}_{n}(I)=\cup_{J \in \operatorname{ch}_{n-1}(J)} \operatorname{bi}(J) . \tag{10.146}
\end{equation*}
$$

Lemma 10.29 (bisection children). Let $I=[s, t)$ and let $n$ be a nonnegative integer. Then the intervals in $c_{n}(I)$ are pairwise disjoint. For any $J \in c h_{n}(I)$,

$$
\begin{equation*}
\mu(J)=\frac{\mu(I)}{2^{n}}=\frac{t-s}{2^{n}} . \tag{10.147}
\end{equation*}
$$

Further,

$$
\begin{equation*}
I=\cup_{J \in c h_{n}(I)} J \tag{10.148}
\end{equation*}
$$

and

$$
\begin{equation*}
\left|c h_{n}(I)\right|=2^{n+1} . \tag{10.149}
\end{equation*}
$$

Proof. This follows by induction on $n$, using Lemma 10.28.
Lemma 10.30 (Lebesgue differentiation). Let $f$ be a bounded measurable function with bounded support. Then for $\mu$ almost every $x$, we have

$$
\frac{1}{\mu\left(I_{n}\right)} \int_{I_{n}} f(y) d y=f(x)
$$

where $\left\{I_{n}\right\}_{n \geq 1}$ is a sequence of intervals such that $x \in I_{n}$ for each $n \geq 1$ and

$$
\lim _{n \rightarrow \infty} \mu\left(I_{n}\right)=0 .
$$

Proof. This follows from the Lebesgue differentiation theorem, which is already formalized in Lean.
Lemma 10.31 (stopping time). Let $f$ be a bounded, measurable function with bounded support on $\mathbb{R}$. Let $\alpha>0$. Then there exists $A \subset \mathbb{R}$ such that the following properties (10.150), (10.151), (10.152), (10.153), and (10.154) are satisfied. For all $x \in A$

$$
\begin{equation*}
|f(x)| \leq \alpha \tag{10.150}
\end{equation*}
$$

The set $\mathbb{R} \backslash A$ can be decomposed into a countable union of intervals

$$
\begin{equation*}
\mathbb{R} \backslash A=\cup_{j} I_{j}=\cup_{j}\left[s_{j}, t_{j}\right), \tag{10.151}
\end{equation*}
$$

such that

$$
\begin{equation*}
\left[s_{j}, t_{j}\right) \cap\left[s_{j^{\prime}}, t_{j^{\prime}}\right)=\emptyset \text { for } j \neq j^{\prime} . \tag{10.152}
\end{equation*}
$$

For each j,

$$
\begin{equation*}
\frac{\alpha}{2} \leq \frac{1}{t_{j}-s_{j}} \int_{s_{j}}^{t_{j}}|f(y)| d y \leq \alpha \tag{10.153}
\end{equation*}
$$

Further,

$$
\begin{equation*}
\sum_{j}\left(t_{j}-s_{j}\right) \leq \frac{2}{\alpha} \int|f(y)| d y \tag{10.154}
\end{equation*}
$$

Proof. Since $f$ is bounded with bounded support, there exists a non-negative integer $\ell$ such that

$$
\begin{equation*}
f(x)=0 \text { for } x \notin\left[-2^{\ell-1}, 2^{\ell-1}\right) \tag{10.155}
\end{equation*}
$$

and

$$
2^{-\ell} \int_{-2^{\ell-1}}^{2^{\ell-1}}|f(y)| d y<\alpha
$$

Let

$$
I_{0}:=\left[-2^{\ell}, 2^{\ell}\right), \quad \mathcal{Q}_{0}:=\left\{I_{0}\right\}
$$

and

$$
\tilde{\mathcal{Q}}_{1}:=\operatorname{bi}\left(I_{0}\right) .
$$

For $n \geq 1$, we inductively define

$$
\mathcal{Q}_{n}:=\left\{I \in \tilde{\mathcal{Q}}_{n}: \frac{1}{\mu(I)} \int_{I}|f(y)| d y>\frac{\alpha}{2}\right\}
$$

and

$$
\tilde{\mathcal{Q}}_{n+1}:=\cup_{I \in \tilde{\mathcal{Q}}_{n} \backslash \mathcal{Q}_{n}} \operatorname{bi}(I)
$$

Finally, let

$$
\mathcal{Q}:=\cup_{n \geq 1} \mathcal{Q}_{n}
$$

For each $n$ we have

$$
\mathcal{Q}_{n} \subseteq \operatorname{ch}_{n}\left(I_{0}\right)
$$

Therefore, by Lemma 10.29,

$$
\left|\mathcal{Q}_{n}\right| \leq \frac{\mu\left(I_{0}\right)}{2^{n}}=2^{\ell+1-n}
$$

It follows that $\mathcal{Q}$ is a countable union of finite sets and hence, is countable itself. Let $\left\{I_{j}\right\}_{j \geq 1}$ be an enumeration of this set, with

$$
I_{j}:=\left[s_{j}, t_{j}\right)
$$

for $s_{j}, t_{j} \in I_{0}$ and $s_{j}<t_{j}$. We set

$$
A:=\mathbb{R} \backslash \cup_{j \geq 1}\left[s_{j}, t_{j}\right)
$$

Then (10.151) holds by definition. We next show (10.152). Let $I_{j}, I_{j^{\prime}} \in \mathcal{Q}$. Then, there exist $1 \leq n, n^{\prime}$ such that $I_{j} \in \mathcal{Q}_{n}$ and $I_{j^{\prime}} \in \mathcal{Q}_{n^{\prime}}$. If $n=n^{\prime}$, (10.152) follows from Lemma 10.29 since $\mathcal{Q}_{n} \subseteq \operatorname{ch}_{n}\left(I_{0}\right)$. Otherwise, assume without loss of generality that $n<n^{\prime}$. Then by construction, there exists $J \in \tilde{\mathcal{Q}}_{n} \backslash \mathcal{Q}_{n}$ such that $I_{j^{\prime}} \subset J$. Since $I_{j} \in \mathcal{Q}_{n}$, it follows that $I_{j} \neq J$. Since $I_{j}, J \in \tilde{\mathcal{Q}}_{n} \subset \operatorname{ch}_{n}\left(I_{0}\right)$, by Lemma 10.29 , we deduce that they are disjoint. Since $I_{j^{\prime}} \subset J$, we conclude that $I_{j}$ and $I_{j^{\prime}}$ are disjoint as well. This proves (10.152).

To see $(10.153)$, let $I_{j}=\left(s_{j}, t_{j}\right) \in \mathcal{Q}$. Then $I_{j} \in \mathcal{Q}_{n}$ for some $n \geq 1$. By definition of $\mathcal{Q}_{n}$, we have

$$
\frac{\alpha}{2}<\frac{1}{\mu(I)} \int_{I}|f(y)| d y=\frac{1}{t_{j}-s_{j}} \int_{s_{j}}^{t_{j}}|f(y)| d y
$$

As $I_{j} \in \mathcal{Q}_{n} \subseteq \tilde{\mathcal{Q}}_{n}$, by definition of the latter set, there exists $J \in \tilde{\mathcal{Q}}_{n-1} \backslash \mathcal{Q}_{n-1}$ with $I \in \operatorname{bi}(J)$. Since $J \notin \mathcal{Q}_{n-1}$, we conclude that

$$
\frac{1}{\mu(J)} \int_{J}|f(y)| d y \leq \frac{\alpha}{2}
$$

Using Lemma 10.28 and the above, we get

$$
\frac{1}{t_{j}-s_{j}} \int_{s_{j}}^{t_{j}}|f(y)| d y=\frac{1}{\mu(I)} \int_{I}|f(y)| d y \leq \frac{2}{\mu(J)} \int_{J}|f(y)| d y \leq \alpha
$$

This establishes (10.153). Using this, we see that for each $j$, we have

$$
t_{j}-s_{j} \leq \frac{2}{\alpha} \int_{s_{j}}^{t_{j}}|f(y)| d y
$$

Summing up in $j$ and using the disjointedness property (10.152), we get

$$
\sum_{j}\left(t_{j}-s_{j}\right) \leq \frac{2}{\alpha} \int_{s_{j}}^{t_{j}}|f(y)| d y=\frac{2}{\alpha} \int|f(y)| d y
$$

Finally, we show (10.150). Let $x \in A$. If $x \notin\left[-2^{\ell}, 2^{\ell}\right]$, then by (10.155) that $f(x)=0$. Thus (10.150) is true in this case. Alternately, let $x \in I_{0} \cap A$. Then for each $n$, there exists $I(n) \in \tilde{\mathcal{Q}}_{n}$ such that $x \in I(n)$ and

$$
\begin{equation*}
\frac{1}{\mu(I(n))} \int_{I(n)}|f(y)| d y \leq \alpha \tag{10.156}
\end{equation*}
$$

Since $\mu(I(n))=2^{\ell+1-n}$, we have

$$
\lim _{n \rightarrow \infty} \mu(I(n))=0
$$

By Lemma 10.30, we also have

$$
\lim _{n \rightarrow \infty} \frac{1}{\mu(I(n))} \int_{I(n)}|f(y)| d y=|f(x)|
$$

for almost every $x \in A$. Combining the above with (10.156), we conclude that

$$
|f(x)| \leq \alpha
$$

This finishes the proof of (10.150), and hence the lemma.
Calderón-Zygmund decomposition is a tool to extend $L^{2}$ bounds to $L^{p}$ bounds with $p<2$ or to the so-called weak $(1,1)$ type endpoint bound. It is classical and can be found in [Ste93].

Lemma 10.32 (Calderon Zygmund decomposition). Let $f$ be a bounded, measurable function with bounded support. Let $\alpha>0$ and $\gamma \in(0,1)$. Then there exists a measurable functions $g$, a countable family of disjoint intervals
$I_{j}=\left[s_{j}, t_{j}\right)$, and a countable family of measurable functions $\left\{g_{j}\right\}_{j \geq 1}$ such that for almost every $x \in \mathbb{R}$

$$
\begin{equation*}
f(x)=g(x)+\sum_{j \geq 1} b_{j}(x) \tag{10.157}
\end{equation*}
$$

and such that the following holds. For almost every $x \in \mathbb{R}$,

$$
\begin{equation*}
|g(x)| \leq \gamma \alpha \tag{10.158}
\end{equation*}
$$

We have

$$
\begin{equation*}
\int|g(y)| d y \leq \int|f(y)| d y \tag{10.159}
\end{equation*}
$$

For every $j$

$$
\begin{equation*}
\operatorname{supp} b_{j} \subset I_{j} \tag{10.160}
\end{equation*}
$$

For every $j$

$$
\begin{equation*}
\int_{I_{j}} b_{j}(x) d x=0 \tag{10.161}
\end{equation*}
$$

and

$$
\begin{equation*}
\int_{I_{j}}\left|b_{j}(x)\right| d x \leq 2 \gamma \alpha \tag{10.162}
\end{equation*}
$$

We have

$$
\begin{equation*}
\sum_{j}\left(t_{j}-s_{j}\right) \leq \frac{2}{\gamma \alpha} \int|f(y)| d y \tag{10.163}
\end{equation*}
$$

and

$$
\begin{equation*}
\sum_{j} \int_{I_{j}}\left|b_{j}(y)\right| d y \leq 2 \int|f(y)| d y \tag{10.164}
\end{equation*}
$$

Proof. Applying Lemma 10.31 to $f$ and $\gamma \alpha$, we obtain a collection $I_{j}$ of intervals such that the conditions (10.150)-(10.154) are satisfied. We set $A=\mathbb{R} \backslash \cup_{j} I_{j}$ and

$$
g(x):= \begin{cases}f(x), & x \in A  \tag{10.165}\\ \frac{1}{\mu\left(I_{j}\right)} \int_{I_{j}} f(y) d y, & x \in\left(s_{j}, t_{j}\right) \\ 0, & x \in\left[s_{j}, t_{j}\right] \backslash\left(s_{j}, t_{j}\right)\end{cases}
$$

and, for each $j$,

$$
b_{j}(x):= \begin{cases}f(x)-\frac{1}{\mu\left(I_{j}\right)} \int_{I_{j}} f(y) d y, & x \in\left(s_{j}, t_{j}\right)  \tag{10.166}\\ 0, & x \notin\left(s_{j}, t_{j}\right)\end{cases}
$$

Then (10.160) and (10.163) are true by construction and Lemma 10.31. Further, let $b(x)=\sum_{j} b_{j}(x)$. Then

$$
f(x)=g(x)+b(x)=g(x)+\sum_{j} b_{j}(x)
$$

for all $x$ not in the measure zero set $\cup_{j}\left\{s_{j}, t_{j}\right\}$.
For almost every $x \in A$, we get using (10.150)

$$
|g(x)| \leq \gamma \alpha
$$

In the case when neither of the above is true, we have $g(x)=0$ by definition. Thus, we obtain (10.158).

To prove (10.159), we estimate

$$
\int|g(y)| d y \leq \int_{A}|f(y)| d y+\sum_{j} \int_{I_{j}} \frac{1}{\mu\left(I_{j}\right)} \int_{I_{j}}|f(y)| d y
$$

Since the intervals $I_{j}$ are disjoint, and $A=\mathbb{R} \backslash \cup_{j} I_{j}$, we conclude

$$
\int|g(y)| d y \leq \int_{A}|f(y)| d y+\sum_{j} \int_{I_{j}}|f(y)| d y=\int|f(y)| d y
$$

This establishes (10.159). If $x \in I_{j}$ for some $j,(10.153)$ yields

$$
|g(x)| \leq \frac{1}{\mu\left(I_{j}\right)} \int_{I_{j}}|f(y)| d y \leq \gamma \alpha
$$

Further, for each $j$, it follows from the definition of $t_{j}$ that

$$
\begin{gathered}
\int_{I_{j}} b_{j}(x) d x=\int_{I_{j}} f(x) d x-\int_{I_{j}} \frac{1}{\mu\left(I_{j}\right)} \int_{I_{j}} f(y) d y d x \\
=\int_{I_{j}} f(x) d x-\int_{I_{j}} f(y) d y=0
\end{gathered}
$$

This establishes (10.161).
Using the triangle inequality, we have that

$$
\begin{gather*}
\int_{I_{j}}\left|b_{j}(y)\right| d y \leq \int_{I_{j}}|f(y)| d y+\int_{I_{j}} \frac{1}{\mu\left(I_{j}\right)} \int_{I_{j}}|f(x)| d x d y \\
=2 \int_{I_{j}}|f(y)| d y \tag{10.167}
\end{gather*}
$$

Dividing both sides by $\mu\left(I_{j}\right)$ and using (10.153), we obtain (10.162).
Further, summing up (10.167) in $j$ yields

$$
\sum_{j} \int_{I_{j}}\left|b_{j}(y)\right| d y \leq \sum_{j} \int_{I_{j}}|f(y)| d y+\sum_{j} \int_{I_{j}} \frac{1}{\mu\left(I_{j}\right)} \int_{I_{j}}|f(x)| d x d y
$$

Using the disjointedness of $\left(s_{j}, t_{j}\right)$, we get

\sum_{j} \int_{I_{j}}\left|b_{j}(y)\right| d y \leq 2 \int|f(y)| d y
$$

This proves (10.164), and completes the proof.
Proof of Lemma 10.7. Using Lemma 10.32 for $f$ and $2^{-10} \alpha$, we obtain the decomposition

f=g+b=g+\sum_{j} b_{j}
$$

such that the properties (10.157)-(10.164) are satisfied with $\gamma=2^{-10}$. For each $j$, let

I_{j}=\left[s_{j}, t_{j}\right), \quad c_{j}:=\frac{s_{j}+t_{j}}{2} \tag{10.168}
\end{equation*}
$$

and

$$
\begin{equation*}
I_{j}^{*}=\left[s_{j}-2\left(t_{j}-s_{j}\right), t_{j}+2\left(t_{j}-s_{j}\right)\right] \tag{10.169}
\end{equation*}
$$

Then $I_{j}^{*}$ is an interval with the same center as $I_{j}$ but with

$$
\begin{equation*}
\mu\left(I_{j}^{*}\right)=5\left(t_{j}-s_{j}\right)=5 \mu\left(I_{j}\right) \tag{10.170}
\end{equation*}
$$

Let

$$
\begin{equation*}
\Omega:=\cup_{j} I_{j}^{*} \tag{10.171}
\end{equation*}
$$

By definition, for each $x \in \mathbb{R} \backslash \Omega$ and $y \in I_{j}$,

$$
\begin{equation*}
\left|x-c_{j}\right|>\frac{5\left(t_{j}-s_{j}\right)}{2} \geq 5\left|y-c_{j}\right| \tag{10.172}
\end{equation*}
$$

and

$$
\begin{equation*}
|x-y|>2\left(t_{j}-s_{j}\right) \tag{10.173}
\end{equation*}
$$

It follows by the triangle inequality and subadditivity of $\mu$ that

$$
\begin{gather*}
\mu\left(\left\{x \in \mathbb{R}:\left|H_{r} f(x)\right|>\alpha\right\}\right) \\
\leq \mu\left(\left\{x \in \mathbb{R}:\left|H_{r} g(x)\right|>\alpha / 2\right\}\right)+\mu\left(\left\{x \in \mathbb{R}:\left|H_{r} b(x)\right|>\alpha / 2\right\}\right) \tag{10.174}
\end{gather*}
$$

We estimate using monotonicity of the integral

$$
\mu\left(\left\{x \in \mathbb{R}:\left|H_{r} g(x)\right|>\alpha / 2\right\}\right) \leq \frac{4}{\alpha^{2}} \int\left|H_{r} g(y)\right|^{2} d y
$$

Using Lemma 10.6 followed by (10.158) and (10.159), we estimate the right hand side above by

$$
\leq 2^{26} \frac{4}{\alpha^{2}} \int|g(y)|^{2} d y \leq \frac{2^{18}}{\alpha} \int|g(y)| d y \leq \frac{2^{18}}{\alpha} \int|f(y)| d y
$$

Thus, we conclude

$$
\begin{equation*}
\mu\left(\left\{x \in \mathbb{R}:\left|H_{r} g(x)\right|>\alpha / 2\right\}\right) \leq \frac{2^{18}}{\alpha} \int|f(y)| d y \tag{10.175}
\end{equation*}
$$

Next, we estimate

$$
\begin{gathered}
\mu\left(\left\{x \in \mathbb{R}:\left|H_{r} b(x)\right|>\alpha / 2\right\}\right) \\
\leq \mu(\Omega)+\mu\left(\left\{x \in \mathbb{R} \backslash \Omega:\left|H_{r} b(x)\right|>\alpha / 2\right\}\right)
\end{gathered}
$$

Using (10.170) and (10.163), we conclude that

$$
\begin{equation*}
\mu(\Omega) \leq \sum_{j} \mu\left(I_{j}^{*}\right)=5 \sum_{j}\left(t_{j}-s_{j}\right) \leq \frac{2^{13}}{\alpha} \int|f(y)| d y \tag{10.176}
\end{equation*}
$$

We now focus on estimating the remaining term

$$
\mu\left(\left\{x \in \mathbb{R} \backslash \Omega:\left|H_{r} b(x)\right|>\alpha / 2\right\}\right)
$$

For $x \in \mathbb{R} \backslash \Omega$, define

$$
\begin{aligned}
\mathcal{J}_{1}(x) & :=\left\{j:\left[s_{j}, t_{j}\right) \cap[x-r, x+r]=\emptyset\right\} \\
\mathcal{J}_{2}(x) & :=\left\{j:|y-x|=r \text { for some } y \in\left[s_{j}, t_{j}\right)\right\} \\
\mathcal{J}_{3}(x) & :=\left\{j:\left[s_{j}, t_{j}\right) \subset[x-r, x+r]\right\}
\end{aligned}
$$

Since $H_{r} b_{j}(x)=0$ for all $j \in \mathcal{J}_{3}(x)$, using the triangle inequality and the decomposition above, we get

$$
\begin{equation*}
\left|H_{r} b(x)\right| \leq \sum_{j \in \mathcal{J}_{1}(x)}\left|H_{r} b_{j}(x)\right|+\sum_{j \in \mathcal{J}_{2}(x)}\left|H_{r} b_{j}(x)\right| \tag{10.177}
\end{equation*}
$$

Further, for $j \in \mathcal{J}_{1}(x)$, we have

H_{r} b_{j}(x)=\int_{I_{j}} \kappa(x-y) \mathbf{1}_{\{z: r<|z|<1\}}(x-y) b_{j}(y) d y=\int_{I_{j}} \kappa(x-y) b_{j}(y) d y
$$

Using (10.161), the above is equal to

\int_{I_{j}}\left(\kappa(x-y)-\kappa\left(x-c_{j}\right)\right) b_{j}(y) .
$$

Thus, using the triangle inequality, (10.172), (10.173) and Lemma 10.14, we can estimate

\begin{gather*}
\sum_{j \in \mathcal{J}_{1}(x)}\left|H_{r} b_{j}(x)\right| \leq \sum_{j \in \mathcal{J}_{1}(x)} 2^{10} \int_{I_{j}} \frac{\left|y-c_{j}\right|}{\left|x-c_{j}\right|^{2}}\left|b_{j}(y)\right| d y \\
\leq 2^{10} \sum_{j} \frac{\left(t_{j}-s_{j}\right)}{\left|x-c_{j}\right|^{2}} \int_{I_{j}}\left|b_{j}(y)\right| d y:=F_{1}(x) . \tag{10.178}
\end{gather*}
$$

Next, we estimate the second sum in (10.177). For each $j \in \mathcal{J}_{2}(x)$, set

$$
d_{j}:=\frac{1}{t_{j}-s_{j}} \int_{I_{j}} \mathbf{1}_{\{z: r<|z|<1\}}(x-y) b_{j}(y) d y
$$

Then by (10.162)

$$
\begin{equation*}
\left|d_{j}\right| \leq 2 \cdot 2^{-10} \alpha=2^{-9} \alpha \tag{10.179}
\end{equation*}
$$

For each $j \in \mathcal{J}_{2}(x)$, we have

$$
\begin{gathered}
H_{r} b_{j}(x)=\int_{I_{j}} \kappa(x-y)\left(\mathbf{1}_{\{z: r<|z|<1\}}(x-y) b_{j}(y)-d_{j}\right) d y \\
\quad+\int_{I_{j}} d_{j} \kappa(x-y) d y \\
=\int_{I_{j}}\left(\kappa(x-y)-\kappa\left(x-c_{j}\right)\right)\left(\mathbf{1}_{\{z: r<|z|<1\}}(x-y) b_{j}(y)-d_{j}\right) d y \\
+\int_{I_{j}} d_{j} \kappa(x-y) d y
\end{gathered}
$$

Thus, using the triangle inequality, the estimate above and (10.179), we obtain

$$
\begin{gather*}
\left|H_{r} b_{j}(x)\right| \leq \\
\int_{I_{j}}\left|\left(\kappa(x-y)-\kappa\left(x-c_{j}\right)\right)\left(\left|b_{j}(y)\right|+2^{-9} \alpha\right) d y+2^{-9} \alpha \int_{I_{j}}\right| \kappa(x-y) \mid d y \tag{10.180}
\end{gather*}
$$

Using (10.172), (10.173) and Lemma 10.14, and arguing as in (10.178), we get the the first term above can be estimated by

$$
\begin{equation*}
2^{10} \sum_{j} \frac{\left(t_{j}-s_{j}\right)}{\left|x-c_{j}\right|^{2}}\left(\int_{I_{j}}\left|b_{j}(y)\right|+2^{-9} \alpha\left(t_{j}-s_{j}\right)\right)=F_{1}(x)+F_{2}(x) \tag{10.181}
\end{equation*}
$$

with $F_{1}$ as in (10.178) and

$$
\begin{equation*}
F_{2}(x):=2 \sum_{j} \frac{\left(t_{j}-s_{j}\right)}{\left|x-c_{j}\right|^{2}} \alpha\left(t_{j}-s_{j}\right) \tag{10.182}
\end{equation*}
$$

For each $j \in \mathcal{J}_{2}(x)$, let $y_{j} \in\left[s_{j}, t_{j}\right)$ be such that

$$
\left|x-y_{j}\right|=r
$$

Using (10.173), we have

$$
r=\left|x-y_{j}\right|>2\left(t_{j}-s_{j}\right)
$$

Further, using the triangle inequality, for each $y \in I_{j}$, we obtain

$$
|x-y| \leq\left|x-y_{j}\right|+\left|y-y_{j}\right| \leq r+\left(t_{j}-s_{j}\right)<\frac{3 r}{2}
$$

and

$$
|x-y| \geq\left|x-y_{j}\right|-\left|y-y_{j}\right| \geq r-\left(t_{j}-s_{j}\right)>\frac{r}{2}
$$

We conclude that

$$
\left[s_{j}, t_{j}\right) \subset\left\{y: \frac{r}{2}<|x-y|<\frac{3 r}{2}\right\}
$$

Using this and Lemma 10.13, we get

$$
\begin{equation*}
\int_{I_{j}}|\kappa(x-y)| d y \leq \int_{\left\{y: \frac{r}{2}<|x-y|<\frac{3 r}{2}\right\}} \frac{8}{|x-y|} d y \leq 32 \tag{10.183}
\end{equation*}
$$

Combining (10.177), (10.178), (10.180), (10.181) and (10.183), we get

\left|H_{r} b(x)\right| \leq 2 F_{1}(x)+F_{2}(x)+2^{-4} \alpha .
$$

Using the triangle inequality, we deduce that

\begin{gather*}
\mu\left(\left\{x \in \Omega:\left|H_{r} b(x)\right|>\alpha / 4\right\}\right) \leq \\
\mu\left(\left\{x \in \Omega:\left|F_{1}(x)\right|>2^{-4} \alpha\right\}\right)+\mu\left(\left\{x \in \Omega:\left|F_{2}(x)\right|>2^{-4} \alpha\right\}\right) \tag{10.184}
\end{gather*}
$$

We estimate

$$
\begin{equation*}
\mu\left(\left\{x \in \Omega:\left|F_{1}(x)\right|>2^{-4} \alpha\right\}\right) \leq \frac{2^{14}}{\alpha} \sum_{j} \int_{I_{j}}\left|b_{j}(y)\right| d y \int_{\Omega} \frac{\left(t_{j}-s_{j}\right)}{\left|x-c_{j}\right|^{2}} d x \tag{10.185}
\end{equation*}
$$

Using (10.172), we can bound

$$
\begin{equation*}
\int_{\Omega} \frac{\left(t_{j}-s_{j}\right)}{\left|x-c_{j}\right|^{2}} d x \leq 2\left(t_{j}-s_{j}\right) \int_{5\left|t_{j}-s_{j}\right|}^{\infty} \frac{1}{t^{2}} \mathrm{~d} t=\frac{2}{5} \tag{10.186}
\end{equation*}
$$

Plugging (10.186) into (10.185) and using (10.164), we conclude that

\begin{equation*}
\mu\left(\left\{x \in \Omega:\left|F_{1}(x)\right|>2^{-4} \alpha\right\}\right) \leq \frac{2^{14}}{\alpha} \int|f(y)| d y \tag{10.187}
\end{equation*}
$$

Similarly, we estimate

\mu\left(\left\{x \in \Omega:\left|F_{2}(x)\right|>2^{-4} \alpha\right\}\right) \leq \frac{2^{5}}{\alpha} \sum_{j} \alpha\left(t_{j}-s_{j}\right) \int_{\Omega} \frac{\left(t_{j}-s_{j}\right)}{\left|x-c_{j}\right|^{2}} d x
$$

Using (10.186) and (10.163), this is bounded by

2^{4} \sum_{j}\left(t_{j}-s_{j}\right) \leq \frac{2^{15}}{\alpha} \int|f(y)| d y \tag{10.188}
\end{equation*}
$$

Combining estimates (10.174), (10.175), (10.176), (10.184), (10.187) and (10.188) yields (10.32).
10.6. The proof of the van der Corput Lemma 10.8. Let $g$ be a Lipschitz continuous function as in the lemma. We have

e^{i n(x+\pi / n)}=-e^{i n x}
$$

Using this, we write

\left.\int_{\alpha}^{\beta} g(x) e^{-i n x} \mathrm{~d} x=\frac{1}{2} \int_{\alpha}^{\beta} g(x) e^{i n x} \mathrm{~d} x-\frac{1}{2} \int_{\alpha}^{\beta} g(x) e^{i n(x+\pi / n)}\right) \mathrm{d} x .
$$

We split the the first integral at $\alpha+\frac{\pi}{n}$ and the second one at $\beta-\frac{\pi}{n}$, and make a change of variables in the second part of the first integral to obtain

$$
\begin{gathered}
=\frac{1}{2} \int_{\alpha}^{\alpha+\frac{\pi}{n}} g(x) e^{i n x} \mathrm{~d} x-\frac{1}{2} \int_{\beta-\frac{\pi}{n}}^{\beta} g(x) e^{i n(x+\pi / n)} \mathrm{d} x \\
+\frac{1}{2} \int_{\alpha+\frac{\pi}{n}}^{\beta}\left(g(x)-g\left(x-\frac{\pi}{n}\right)\right) e^{i n x} \mathrm{~d} x
\end{gathered}
$$

The sum of the first two terms is by the triangle inequality bounded by

$$
\frac{\pi}{n} \sup _{x \in[\alpha, \beta]}|g(x)| .
$$

The third term is by the triangle inequality at most

$$
\begin{aligned}
& \frac{1}{2} \int_{\alpha+\frac{\pi}{n}}^{\beta}\left|g(x)-g\left(x-\frac{\pi}{n}\right)\right| \mathrm{d} x \\
\leq & \frac{\pi}{2 n} \sup _{\alpha \leq x<y \leq \beta} \frac{|g(x)-g(y)|}{|x-y|}|\beta-\alpha| .
\end{aligned}
$$

Adding the two terms, we obtain

$$
\left|\int_{\alpha}^{\beta} g(x) e^{-i n x} \mathrm{~d} x\right| \leq \frac{\pi}{n}\|g\|_{\operatorname{Lip}(\alpha, \beta)} .
$$

By the triangle inequality, we also have

$$
\left|\int_{\alpha}^{\beta} g(x) e^{-i n x} \mathrm{~d} x\right| \leq|\beta-\alpha| \sup _{x \in[\alpha, \beta]}|g(x)| \leq|\beta-\alpha|\|g\|_{\operatorname{Lip}(\alpha, \beta)} .
$$

This completes the proof of the lemma, using that

$$
\min \left\{|\beta-\alpha|, \frac{\pi}{n}\right\} \leq 2 \pi|\beta-\alpha|(1+n|\beta-\alpha|)^{-1} .
$$

10.7. Partial sums as orthogonal projections. This subsection proves Lemma 10.12

Lemma 10.33 (partial sum projection). Let $f$ be a bounded $2 \pi$-periodic measurable function. Then, for all $N \geq 0$

\begin{equation*}
S_{N}\left(S_{N} f\right)=S_{N} f \tag{10.189}
\end{equation*}
$$

Proof. Let $N>0$ be given. With $K_{N}$ as in Lemma 10.10,

$$
\begin{array}{r}
S_{N}\left(S_{N} f\right)(x)=\frac{1}{2 \pi} \int_{0}^{2 \pi} S_{N} f(y) K_{N}(x-y) d y \\
=\frac{1}{(2 \pi)^{2}} \int_{0}^{2 \pi} \int_{0}^{2 \pi} f\left(y^{\prime}\right) K_{N}\left(y-y^{\prime}\right) K_{N}(x-y) d y^{\prime} d y \tag{10.190}
\end{array}
$$

We have by Lemma 10.10

$$
\begin{gather*}
\frac{1}{2 \pi} \int_{0}^{2 \pi} K_{N}\left(y-y^{\prime}\right) K_{N}(x-y) d y \\
=\frac{1}{2 \pi} \sum_{n=-N}^{N} \sum_{n^{\prime}=-N}^{N} \int_{0}^{2 \pi} e^{i n\left(y-y^{\prime}\right)} e^{i n^{\prime}(x-y)} d y \\
=\frac{1}{2 \pi} \sum_{n=-N}^{N} \sum_{n^{\prime}=-N}^{N} e^{i\left(n^{\prime} x-n y^{\prime}\right)} \int_{0}^{2 \pi} e^{i\left(n-n^{\prime}\right) y} d y \tag{10.191}
\end{gather*}
$$

By Lemma 10.9, the summands for $n \neq n^{\prime}$ vanish. We obtain for (10.191)

$$
\begin{equation*}
=\frac{1}{2 \pi} \sum_{n=-N}^{N} e^{i n\left(x-y^{\prime}\right)} \int_{0}^{2 \pi} d y=K_{N}\left(x-y^{\prime}\right) \tag{10.192}
\end{equation*}
$$

Applying Fubini in (10.190) and using (10.192) gives

$$
\begin{equation*}
S_{N}\left(S_{N} f\right)(x)=\frac{1}{2 \pi} \int_{0}^{2 \pi} f\left(y^{\prime}\right) K\left(x-y^{\prime}\right) d y^{\prime}=S_{N} f(x) \tag{10.193}
\end{equation*}
$$

This proves the lemma.
Lemma 10.34 (partial sum selfadjoint). We have for any $2 \pi$-periodic bounded measurable $g$, $f$ that

$$
\begin{equation*}
\int_{0}^{2 \pi} \overline{S_{N} f(x)} g(x)=\int_{0}^{2 \pi} \overline{f(x)} S_{N} g(x) d x \tag{10.194}
\end{equation*}
$$

Proof. We have with $K_{N}$ as in Lemma 10.10 for every $x$

$$
\begin{equation*}
\overline{K_{N}(x)}=\sum_{n=-N}^{N} \overline{e^{i n x}}=\sum_{n=-N}^{N} e^{-i n x}=K_{N}(-x) \tag{10.195}
\end{equation*}
$$

Further, with Lemma 10.10 and Fubini

$$
\begin{align*}
& \int_{0}^{2 \pi} \overline{S_{N} f(x)} g(x)=\frac{1}{2 \pi} \int_{0}^{2 \pi} \int_{-\pi}^{\pi} \overline{f(y) K_{N}(x-y)} g(x) d y d x \\
= & \frac{1}{2 \pi} \int_{0}^{2 \pi} \int_{-\pi}^{\pi} \overline{f(y)} K_{N}(y-x) g(x) d x d y=\int_{0}^{2 \pi} \overline{f(x)} S_{N} g(x) d x \tag{10.196}
\end{align*}
$$

This proves the lemma.
We turn to the proof of Lemma 10.12.
We have with Lemma 10.34, then Lemma 10.33 and the Lemma 10.34 again

$$
\begin{align*}
& \int_{0}^{2 \pi} S_{N} f(x) \overline{S_{N} f(x)} d x \int_{0}^{2 \pi} f(x) \overline{S_{N}\left(S_{N} f\right)(x)} d x \\
= & \int_{0}^{2 \pi} f(x) \overline{S_{N} f(x)} d x=\int_{0}^{2 \pi} S_{N} f(x) \overline{f(x)} d x \tag{10.197}
\end{align*}
$$

We have by the distributive law

$$
\begin{equation*}
\int_{0}^{2 \pi}\left(f(x)-S_{N} f(x)\right)\left(\overline{f(x)-S_{N} f(x)}\right) d x= \tag{10.198}
\end{equation*}
$$

$$
\int_{0}^{2 \pi} f(x) \overline{f(x)}-S_{N} f(x) \overline{f(x)}-f(x) \overline{S_{N} f(x)}+S_{N} f(x) \overline{S_{N} f(x)} d x
$$

Using the various identities expressed in (10.197), this becomes

$$
\begin{equation*}
=\int_{0}^{2 \pi} f(x) \overline{f(x)} d x-\int_{0}^{2 \pi} S_{N} f(x) \overline{S_{N} f(x)} d x \tag{10.199}
\end{equation*}
$$

As (10.198) has nonnegative integrand and is thus nonnegative, we conclude

$$
\begin{equation*}
\left.\int_{0}^{2 \pi} S_{N} f(x) \overline{S_{N} f(x)} d x \leq \int_{0}^{2 \pi} f(x) \overline{f(x)}\right) d x \tag{10.200}
\end{equation*}
$$

As both sides are positive, we may take the square root of this inequality. This completes the proof of the lemma.
10.8. The error bound. We prove Lemma 10.3. Define

$$
E_{2}:=\left\{x \in[0,2 \pi): \sup _{N>0}\left|S_{N} f(x)-S_{N} f_{0}(x)\right|>\frac{\epsilon}{4}\right\} .
$$

Then (10.17) clearly holds, and it remains to show that $\left|E_{2}\right| \leq \frac{\epsilon}{2}$. This will follow from Lemma 10.4.

Let $x \in E_{2}$. Then there exists $N>0$ with

\left|S_{N} f(x)-S_{N} f_{0}(x)\right|>\frac{\epsilon}{4}
$$

pick such $N$. We have with Lemma 10.10

\frac{\epsilon}{4}<\left|S_{N} f(x)-S_{N} f_{0}(x)\right|=\frac{1}{2 \pi}\left|\int_{0}^{2 \pi}\left(f(y)-f_{0}(y)\right) K_{N}(x-y) d y\right|
$$

We make a change of variables, replacing $y$ by $x-y$. Then we use $2 \pi$ periodicity of $f, f_{0}$ and $K_{N}$ to shift the domain of integration to obtain

$$
=\frac{1}{2 \pi}\left|\int_{-\pi}^{\pi}\left(f(x-y)-f_{0}(x-y)\right) K_{N}(y) d y\right| .
$$

Using the triangle inequality, we split this as

$$
\begin{aligned}
\leq & \frac{1}{2 \pi}\left|\int_{-\pi}^{\pi}\left(f(x-y)-f_{0}(x-y)\right) \max (1-|y|, 0) K_{N}(y) d y\right| \\
& +\frac{1}{2 \pi}\left|\int_{-\pi}^{\pi}\left(f(x-y)-f_{0}(x-y)\right) \min (|y|, 1) K_{N}(y) d y\right|
\end{aligned}
$$

Note that all integrals are well defined, since $K_{N}$ is by (10.37) bounded by $2 N+1$. Using (10.38) and the definition (10.24) of $\kappa$, we rewrite the two terms and obtain

$$
\begin{align*}
\frac{\epsilon}{4}<\frac{1}{2 \pi}\left|\int_{-\pi}^{\pi}\left(f(x-y)-f_{0}(x-y)\right)\left(e^{i N y} \bar{\kappa}(y)+e^{-i N y} \kappa(y)\right) d y\right|  \tag{10.201}\\
+\frac{1}{2 \pi}\left|\int_{-\pi}^{\pi}\left(f(x-y)-f_{0}(x-y)\right)\left(e^{i N y} \frac{\min \{|y|, 1\}}{1-e^{-i y}}+e^{-i N y} \frac{\min \{|y|, 1\}}{1-e^{i y}}\right) d y\right| .
\end{align*}
$$

By Lemma 10.11 with $\eta=|y|$, we have for $-1 \leq y \leq 1$

$$
\left|e^{i N y} \frac{\min \{|y|, 1\}}{1-e^{-i y}}\right|=\frac{|y|}{\left|1-e^{i y}\right|} \leq 8
$$

By Lemma 10.11 with $\eta=1$, we have for $1 \leq|y| \leq \pi$

$$
\left|e^{i N y} \frac{\min \{|y|, 1\}}{1-e^{-i y}}\right|=\frac{1}{\left|1-e^{i y}\right|} \leq 8
$$

Thus we obtain using the triangle inequality and (10.5)

$$
(10.202) \leq \frac{16}{2 \pi} \int_{-\pi}^{\pi}\left|f(x-y)-f_{0}(x-y)\right| d y \leq 2^{4-2^{50}} \epsilon^{2}
$$

Consequently, we have that

$$
\frac{\epsilon}{8} \leq \frac{1}{2 \pi}\left|\int_{-\pi}^{\pi}\left(f(x-y)-f_{0}(x-y)\right)\left(e^{i N y} \bar{\kappa}(y)+e^{-i N y} \kappa(y)\right) d y\right|
$$

By dominated convergence and since $\kappa(y)=0$ for $|y|>1$, this equals

$$
=\frac{1}{2 \pi} \lim _{r \rightarrow 0^{+}}\left|\int_{r<|y|<1}\left(f(x-y)-f_{0}(x-y)\right)\left(e^{i N y} \bar{\kappa}(y)+e^{-i N y} \kappa(y)\right) d y\right| .
$$

Let $h=\left(f-f_{0}\right) \mathbf{1}_{[-\pi, 3 \pi]}$. Since $x \in[0,2 \pi]$, the above integral does not change if we replace $\left(f-f_{0}\right)$ by $h$. We do that, apply the triangle inequality and bound the limits by suprema

$$
\begin{aligned}
& \leq \frac{1}{2 \pi} \sup _{r>0}\left|\int_{r<|y|<1} h(x-y) e^{-i N y} \kappa(y) d y\right| \\
& +\frac{1}{2 \pi} \sup _{r>0}\left|\int_{r<|y|<1} \bar{h}(x-y) e^{-i N y} \kappa(y) d y\right| .
\end{aligned}
$$

By the definition (10.27) of $T$, this is

$$
\leq \frac{1}{2 \pi}(T h(x)+T \bar{h}(x))
$$

Thus for each $x \in E_{2}$, at least one of $T h(x)$ and $T \bar{h}(x)$ is larger than $\frac{\epsilon}{16}$. Thus at least one of $T h$ and $T \bar{h}$ is $\geq \frac{\epsilon}{16}$ on a subset $E_{2}^{\prime}$ of $E_{2}$ with $2\left|E_{2}^{\prime}\right| \geq\left|E_{2}\right|$. Without loss of generality this is $T h$. By assumption (10.5), we have $\left|2^{2^{50}} \epsilon^{-2} h\right| \leq \mathbf{1}_{[-\pi, 3 \pi]}$. Applying Lemma 10.4 with $F=[-\pi, 3 \pi]$ and $G=E_{2}^{\prime}$, it follows that

$$
\begin{aligned}
\frac{\epsilon}{16}\left|E_{2}^{\prime}\right| & \leq \int_{E_{2}^{\prime}} T h(x) d x=2^{-2^{50}} \epsilon^{2} \int_{E_{2}^{\prime}} T\left(2^{2^{50}} \epsilon^{-2} h\right)(x) d x \\
& \leq 2^{-2^{50}} \epsilon^{2} \cdot 2^{2^{40}}|F|^{\frac{1}{2}}\left|E_{2}^{\prime}\right|^{\frac{1}{2}} \leq 2^{-2^{40}} \frac{\epsilon^{2}}{16}\left|E_{2}^{\prime}\right|^{\frac{1}{2}}
\end{aligned}
$$

Rearranging, we obtain

$$
\left|E_{2}^{\prime}\right| \leq 2^{-2^{41}} \epsilon^{2} \leq \frac{\epsilon}{4}
$$

This completes the proof using $\left|E_{2}\right| \leq 2\left|E_{2}^{\prime}\right|$.
10.9. Carleson on the real line. We prove Lemma 10.4.

Consider the standard distance function

$$
\begin{equation*}
\rho(x, y)=|x-y| \tag{10.203}
\end{equation*}
$$

on the real line $\mathbb{R}$.
Lemma 10.35 (real line metric). The space $(\mathbb{R}, \rho)$ is a complete locally compact metric space.

Proof. This is part of the Lean library.
Lemma 10.36 (real line ball). For $x \in R$ and $R>0$, the ball $B(x, R)$ is the interval $(x-R, x+R)$

Proof. Let $x^{\prime} \in B(x, R)$. By definition of the ball, $\left|x^{\prime}-x\right|<R$. It follows that $x^{\prime}-x<R$ and $x-x^{\prime}<R$. It follows $x^{\prime}<x+R$ and $x^{\prime}>x-R$. This implies $x^{\prime} \in(x-R, x+R)$. Conversely, let $x^{\prime} \in(x-R, x+R)$. Then $x^{\prime}<x+R$ and $x^{\prime}>x-R$. It follows that $x^{\prime}-x<R$ and $x-x^{\prime}<R$. It follows that $\left|x^{\prime}-x\right|<R$, hence $x^{\prime} \in B(x, R)$. This proves the lemma.

We consider the Lebesgue measure $\mu$ on $\mathbb{R}$.
Lemma 10.37 (real line measure). The measure $\mu$ is a sigma-finite nonzero Radon-Borel measure on $\mathbb{R}$.

Proof. This is part of the Lean library.
Lemma 10.38 (real line ball measure). We have for every $x \in \mathbb{R}$ and $R>0$

$$
\begin{equation*}
\mu(B(x, R))=2 R . \tag{10.204}
\end{equation*}
$$

Proof. We have with Lemma 10.36

$$
\begin{equation*}
\mu(B(x, R))=\mu((x-R, x+R))=2 R . \tag{10.205}
\end{equation*}
$$

Lemma 10.39 (real line doubling). We have for every $x \in \mathbb{R}$ and $R>0$

$$
\begin{equation*}
\mu(B(x, 2 R))=2 \mu(B(x, R)) . \tag{10.206}
\end{equation*}
$$

Proof. We have with Lemma 10.38

$$
\begin{equation*}
\mu(B(x, 2 R)=4 R=2 \mu(B(x, R) . \tag{10.207}
\end{equation*}
$$

This proves the lemma.
The preceding four lemmas show that $(\mathbb{R}, \rho, \mu, 4)$ is a doubling metric measure space. Indeed, we even show that ( $\mathbb{R}, \rho, \mu, 1$ ) is a doubling metric measure space, but we may relax the estimate in Lemma 10.39 to conclude that $(\mathbb{R}, \rho, \mu, 4)$ is a doubling metric measure space.

For each $n \in \mathbb{Z}$ define $\vartheta_{n}: \mathbb{R} \rightarrow \mathbb{R}$ by

$$
\begin{equation*}
\vartheta_{n}(x)=n x . \tag{10.208}
\end{equation*}
$$

Let $\Theta$ be the collection $\left\{\vartheta_{n}, n \in \mathbb{Z}\right\}$. Note that for every $n \in \mathbb{Z}$ we have $\vartheta_{n}(0)=0$. Define

$$
\begin{equation*}
d_{B(x, R)}\left(\vartheta_{n}, \vartheta_{m}\right):=2 R|n-m| . \tag{10.209}
\end{equation*}
$$

Lemma 10.40 (frequency metric). For every $R>0$ and $x \in X$, the function $d_{B(x, R)}$ is a metric on $\Theta$.

Proof. This follows immediately from the fact that the standard metric on $\mathbb{Z}$ is a metric.

Lemma 10.41 (oscillation control). For every $R>0$ and $x \in X$, and for all $n, m \in \mathbb{Z}$, we have

$$
\begin{equation*}
\sup _{y, y^{\prime} \in B(x, R)}\left|n y-n y^{\prime}-m y+m y^{\prime}\right| \leq 2|n-m| R \tag{10.210}
\end{equation*}
$$

Proof. The right hand side of (10.210) equals

$$
\sup _{y, y^{\prime} \in B(x, R)}\left|(n-m)(y-x)-(n-m)\left(y^{\prime}-x\right)\right| .
$$

The lemma then follows from the triangle inequality.
Lemma 10.42 (frequency monotone). For any $x, x^{\prime} \in X$ and $R, R^{\prime}>0$ with $B(x, R) \subset B\left(x, R^{\prime}\right)$, and for any $n, m \in \mathbb{Z}$

$$
d_{B(x, R)}\left(\vartheta_{n}, \vartheta_{m}\right) \leq d_{B\left(x^{\prime}, R^{\prime}\right)}\left(\vartheta_{n}, \vartheta_{m}\right)
$$

Proof. This follows immediately from the definition (10.209) and $R \leq R^{\prime}$.

Lemma 10.43 (frequency ball doubling). For any $x, x^{\prime} \in \mathbb{R}$ and $R>0$ with $x \in B\left(x^{\prime}, 2 R\right)$ and any $n, m \in \mathbb{Z}$, we have

$$
\begin{equation*}
d_{B\left(x^{\prime}, 2 R\right)}\left(\vartheta_{n}, \vartheta_{m}\right) \leq 2 d_{B(x, R)}\left(\vartheta_{n}, \vartheta_{m}\right) \tag{10.211}
\end{equation*}
$$

Proof. With (10.209), both sides of (10.211) are equal to $4 R|n-m|$. This proves the lemma.
Lemma 10.44 (frequency ball growth). For any $x, x^{\prime} \in \mathbb{R}$ and $R>0$ with $B(x, R) \subset B\left(x^{\prime}, 2 R\right)$ and any $n, m \in \mathbb{Z}$, we have

$$
\begin{equation*}
2 d_{B(x, R)}\left(\vartheta_{n}, \vartheta_{m}\right) \leq d_{B\left(x^{\prime}, 2 R\right)}\left(\vartheta_{n}, \vartheta_{m}\right) \tag{10.212}
\end{equation*}
$$

Proof. With (10.209), both sides of (10.211) are equal to $4 R|n-m|$. This proves the lemma.

Lemma 10.45 (integer ball cover). For every $x \in \mathbb{R}$ and $R>0$ and every $n \in \mathbb{Z}$ and $R^{\prime}>0$, there exist $m_{1}, m_{2}, m_{3} \in \mathbb{Z}$ such that

$$
\begin{equation*}
B^{\prime} \subset B_{1} \cup B_{2} \cup B_{3} \tag{10.213}
\end{equation*}
$$

where

$$
\begin{equation*}
B^{\prime}=\left\{\vartheta \in \Theta: d_{B(x, R)}\left(\vartheta, \vartheta_{n}\right)<2 R^{\prime}\right\} \tag{10.214}
\end{equation*}
$$

and for $j=1,2,3$

$$
\begin{equation*}
B_{j}=\left\{\vartheta \in \Theta: d_{B(x, R)}\left(\vartheta, \vartheta_{m_{j}}\right)<R^{\prime}\right\} . \tag{10.215}
\end{equation*}
$$

Proof. Let $m_{1}$ be the largest integer smaller than or equal to $n-R^{\prime} / 2$. Let $m_{2}=n$. Let $m_{3}$ be the smallest integer larger than or equal to $n+R^{\prime} / 2$.

Let $\vartheta_{n^{\prime}} \in B^{\prime}$, then with (10.209), we have

$$
\begin{equation*}
2 R\left|n-n^{\prime}\right|<2 R^{\prime} \tag{10.216}
\end{equation*}
$$

Assume first $n^{\prime} \leq n-R^{\prime} / 2$. By definition of $m_{1}$, we have $n^{\prime} \leq m_{1}$. With (10.216) we have

$$
R\left|m_{1}-n^{\prime}\right|=R\left(m_{1}-n^{\prime}\right)=R\left(m_{1}-n\right)+R\left(n-n^{\prime}\right)
$$

$$
\begin{equation*}
<-\frac{R^{\prime}}{2}+R^{\prime}=-\frac{R^{\prime}}{2} \tag{10.217}
\end{equation*}
$$

We conclude $\vartheta_{n^{\prime}} \in B_{1}$.
Assume next $n-R^{\prime} / 2<n^{\prime}<n+R^{\prime} / 2$. Then $\vartheta_{n^{\prime}} \in B_{2}$.
Assume finally that $n+R^{\prime} / 2 \leq n^{\prime}$ By definition of $m_{3}$, we have $m_{3} \leq n^{\prime}$. With (10.216) we have

$$
\begin{align*}
R\left|m_{3}-n^{\prime}\right|=R & \left(n^{\prime}-m_{3}\right)=R\left(n^{\prime}-n\right)+R\left(n-m_{3}\right) \\
& <R^{\prime}-\frac{R^{\prime}}{2}=-\frac{R^{\prime}}{2} . \tag{10.218}
\end{align*}
$$

We conclude $\vartheta_{n^{\prime}} \in B_{1}$. This completes the proof of the lemma.
Lemma 10.46 (real van der Corput). For any $x \in \mathbb{R}$ and $R>0$ and any function $\varphi: X \rightarrow \mathbb{C}$ supported on $B^{\prime}=B(x, R)$ such that

$$
\begin{equation*}
\|\varphi\|_{\operatorname{Lip}\left(B^{\prime}\right)}=\sup _{x \in B^{\prime}}|\varphi(x)|+R \sup _{x, y \in B^{\prime}, x \neq y} \frac{|\varphi(x)-\varphi(y)|}{\rho(x, y)} \tag{10.219}
\end{equation*}
$$

is finite and for any $n, m \in \mathbb{Z}$, we have

$$
\begin{equation*}
\left|\int_{B^{\prime}} e\left(\vartheta_{n}(x)-\vartheta_{m}(x)\right) \varphi(x) d \mu(x)\right| \leq 2 \pi \mu\left(B^{\prime}\right) \frac{\|\varphi\|_{\operatorname{Lip}\left(B^{\prime}\right)}}{1+d_{B^{\prime}}\left(\vartheta_{n}, \vartheta_{m}\right)} \tag{10.220}
\end{equation*}
$$

Proof. Set $n^{\prime}=n-m$. Then we have to prove

$$
\begin{equation*}
\left|\int_{x-R}^{x+R} e^{i n^{\prime} y} \varphi(y) d y\right| \leq 4 \pi R\|\varphi\|_{\operatorname{Lip}\left(B^{\prime}\right)}\left(1+2 R\left|n^{\prime}\right|\right)^{-1} \tag{10.221}
\end{equation*}
$$

This follows from Lemma 10.8 with $\alpha=x-R$ and $\beta=x+R$.
The preceding chain of lemmas establish that $\Theta$ is a cancellative, compatible collection of functions on $(\mathbb{R}, \rho, \mu, 4)$. Again, some of the statements in these lemmas are stronger than what is needed for $a=4$, but can be relaxed to give the desired conclusion for $a=4$.

With $\kappa$ as near (10.24), define the function $K: \mathbb{R} \times \mathbb{R} \rightarrow \mathbb{C}$ as in Theorem 1.2 by

$$
\begin{equation*}
K(x, y):=\kappa(x-y) . \tag{10.222}
\end{equation*}
$$

The function $K$ is continuous outside the diagonal $x=y$ and vanishes on the diagonal. Hence it is measurable.

By the Lemmas 10.13 and 10.14, it follows that $K$ is a one-sided CalderónZygmund kernel on ( $\mathbb{R}, \rho, \mu, 4$ ).

The operator $T^{*}$ defined in (1.16) coincides in our setting with the operator $T^{*}$ defined in (10.29). By Lemma 10.5, this operator satisfies the bound (1.18).

Thus the assumptions of Theorem 1.2 are all satisfied. Applying the Theorem, Lemma 10.4 follows.
