Note on the Taub-NUT Instanton Metric

It is shown that a complex coordinate transformation maps the Taub-NUT instanton metric to a Kerr-Schild metric. This metric involves a semi-infinite line defect as a gravitational analog of the Dirac string, much like the original metric. Also, it corresponds to self-dual dyon in electromagnetism through three versions of classical double copy, one of them being a novel nonlocal operator form. The relevance to Newman-Janis algorithm is briefly noted.

Introduction.—Recently, an exciting program dubbed classical double copy $[1-17]$ $[1-17]$ has refined analogies between gravity and electromagnetism into concrete mappings between classical solutions while being rooted in the study of scattering amplitudes [\[17–](#page-6-1)[21\]](#page-6-2). The prime example is the Kerr-Schild classical double copy, established in the seminal work [\[1\]](#page-6-0). Namely, it is shown that a stationary Kerr-Schild solution $q = \eta + \Phi \ell \otimes \ell$ in general relativity maps to a stationary solution in Maxwell theory described by the gauge potential $A = \Phi \ell$, by taking a "single copy" of the null one-form ℓ . Conversely, one envisions a gravitational counterpart $q = \eta + \Phi \ell \otimes \ell$ of a stationary solution $A = \Phi \ell$ in electromagnetism, by taking a "double copy" of ℓ . Well-known instances of this correspondence are Schwarzschild to point charge and Kerr respondence are Schwarzschild to point char
to a rotating solution dubbed $\sqrt{\text{Kerr}}$ [\[1,](#page-6-0) [22\]](#page-6-3).

From this angle, it is natural to expect that the Taub-NUT solution [\[23,](#page-6-4) [24\]](#page-6-5) will correspond to a dyon, given the interpretation of the NUT charge as the gravitomagnetic monopole [\[16,](#page-6-6) [25–](#page-6-7)[31\]](#page-6-8). However, only a "*double* Kerr-Schild" metric $g = \eta + \Phi_1 \ell_1 \otimes \ell_1 + \Phi_2 \ell_2 \otimes \ell_2$ has been explicitly known for Taub-NUT [\[32,](#page-6-9) [33\]](#page-6-10). Thus, a mapping to electromagnetic dyons had to be achieved by a variant of the Kerr-Schild double copy [\[6,](#page-6-11) [16\]](#page-6-6), which yet offered an intriguing new perspective.

Remarkably, in the present note we point out that the straightforward application of the original Kerr-Schild double copy is in fact possible for the self-dual Taub-NUT (SDTN) solution, which is an extremal case of the Taub-NUT solution that is gaining a revived interest [\[34–](#page-7-0) [38\]](#page-7-1) due to its intriguing physical properties [\[39,](#page-7-2) [40\]](#page-7-3). The crucial fact is that the SDTN solution remarkably admits a Kerr-Schild metric in the ordinary sense: $g = \eta + \Phi \ell \otimes \ell$.

Firstly, a Kerr-Schild metric is obtained by Kerr-Schild double copying the gauge potential of a self-dual dyon (SDD) in electromagnetism. Then we show that it describes the SDTN solution by explicitly constructing a coordinate transformation to the instanton metric of Gibbons and Hawking [\[41–](#page-7-4)[45\]](#page-7-5). Curiously, this change of coordinates turns out to be inherently complex-geometrical in Lorentzian signature, which is consistent with the identification of the SDTN solution as a complex saddle.

Secondly, the physical interpretation of the solution as a gravitational dyon is established within the Kerr-Schild description. Most importantly, we confirm the characteristic Misner string geometry—the gravitational analog [\[25,](#page-6-7) [26\]](#page-6-12) of the Dirac string [\[46,](#page-7-6) [47\]](#page-7-7). Notably, finding its

distributional source [\[26,](#page-6-12) [27\]](#page-6-13) becomes a simple problem in Kerr-Schild coordinates, thanks to a linearization [\[48\]](#page-7-8).

Thirdly, the classical double copy is established in two more ways. We first show that the Weyl double copy relations given by Refs. [\[2–](#page-6-14)[4\]](#page-6-15), established directly in terms of curvature tensors without referencing an explicit gauge potential nor metric, are concretely reproduced in our explicit Kerr-Schild description. This check clarifies a subtlety in the previous constructions [\[3,](#page-6-16) [4\]](#page-6-15) and also illustrates that our Kerr-Schild coordinates are secretly the "Cartesian" coordinates used in the twistor theory context $[3, 4, 34, 49-55]$ $[3, 4, 34, 49-55]$ $[3, 4, 34, 49-55]$ $[3, 4, 34, 49-55]$ $[3, 4, 34, 49-55]$. Next, we propose an exotic new form of classical double copy employing a nonlocal operator, which implements the Dirac strings and traces back to propagators between dyonic sources [\[56](#page-7-11)[–60\]](#page-7-12).

Lastly, we briefly remark on how we originally arrived at this metric, which was by deciphering the Newman-Janis shift—the magical property of spinning black holes noticed in the curious "Note on the Kerr Spinning Particle Metric" [\[61\]](#page-7-13).

Derivation of SDTN metric from double copy.—The gauge potential of a dyon carrying electric and magnetic charges $(q, -iq)$ is given by

$$
A = \frac{q}{4\pi r} \left(-dt - ir(1 - \cos \theta) d\phi \right), \tag{1}
$$

where we have set up spherical coordinates and oriented the Dirac string $[46, 47]$ $[46, 47]$ along the negative z-axis (south pole). This describes a complexified solution where the field strength $F = dA$ is self-dual: $*F = +iF$ [\[62\]](#page-7-14).

Now adding a total derivative $(q/4\pi)d\log(r+z)$ gauge transforms this to a Kerr-Schild form:

$$
A = \frac{q}{4\pi r} \left(-dt + \frac{x+iy}{r+z} dx + \frac{y-ix}{r+z} dy + dz \right), \quad (2)
$$

where $x = r \sin \theta \cos \phi$, $y = r \sin \theta \sin \phi$, $z = r \cos \theta$ are the Cartesian coordinates. Importantly, the terms inside the bracket comprise a null one-form.

With this understanding, the Kerr-Schild classical double copy [\[1\]](#page-6-0) maps Eq. [\(2\)](#page-0-0) to the following line element, by literally taking "two copies" of the null one-form:

$$
ds^{2} = -dt^{2} + dx^{2} + dy^{2} + dz^{2}
$$

$$
+ \frac{m}{4\pi r} \left(-dt + \frac{x+iy}{r+z} dx + \frac{y-ix}{r+z} dy + dz \right)^{2}.
$$

Here we have adopted $8\pi G = 1$ units and replaced the charge q with the mass m. Remarkably, Eq. (3) is a metric of the SDTN solution whose mass and NUT charge are m and $-im$, where complexified vacuum Einstein's equations are satisfied off the negative z-axis.

The diffeomorphism.—To show this, we simply construct an explicit coordinate transformation to the known metric of the SDTN solution. It is convenient to employ complex coordinates $\zeta = (x+iy)/(r+z)$, $\zeta =$ $(x - iy)/(r + z)$ that arise from stereographically projecting the two-sphere with respect to the south pole so that Eq. [\(3\)](#page-0-1) translates to

$$
ds^{2} = -dt^{2} + dr^{2} + r^{2} \frac{4d\tilde{\zeta}d\zeta}{(1 + \tilde{\zeta}\zeta)^{2}} + \frac{m}{4\pi r} \left(-dt + dr - r \frac{2\tilde{\zeta}d\zeta}{1 + \tilde{\zeta}\zeta} \right)^{2}.
$$
 (4)

Amusingly, applying a diffeomorphism given by

$$
t \mapsto t, \quad r \mapsto r + \frac{m}{4\pi},
$$

$$
\zeta \mapsto \zeta, \quad \tilde{\zeta} \mapsto \frac{1}{1 + (m/4\pi r)(1 + \tilde{\zeta}\zeta)} \tilde{\zeta},
$$

(5)

we obtain

$$
ds^{2} = -\left(1 + \frac{m}{4\pi r}\right)^{-1} \left(dt + \frac{m}{4\pi r} \left(dr - r\frac{2\tilde{\zeta}d\zeta}{1 + \tilde{\zeta}\zeta}\right)\right)^{2} + \left(1 + \frac{m}{4\pi r}\right) \left(dr^{2} + r^{2}\frac{4d\tilde{\zeta}d\zeta}{(1 + \tilde{\zeta}\zeta)^{2}}\right),
$$
(6)

which is the Gibbons-Hawking metric [\[41,](#page-7-4) [42\]](#page-7-15) [\[63\]](#page-7-16) of the SDTN solution with mass and NUT charge m and $-i$ m!

This diffeomorphism is surely invertible. In fact, as is elaborated on in the appendix, it turns out that Eq. [\(5\)](#page-1-0) traces back to the flow along the null geodesic congruence associated with the Kerr-Schild metric. As a result, the inverse map is simply Eq. [\(5\)](#page-1-0) with m replaced with $-m$.

This completes our proof that the Kerr-Schild and Gibbons-Hawking metrics in Eqs. [\(3\)](#page-0-1) and [\(6\)](#page-1-1) are diffeomorphic. In turn, we establish that the SDTN solution admits a construction from the Kerr-Schild classical double copy. Previously, these facts had been only *conjec*tured by Ref. [\[64\]](#page-7-17) in split signature: see the note added.

Meanwhile, the astute reader may have noticed an unusual feature of the diffeomorphism in Eq. [\(5\)](#page-1-0). Namely, it describes a genuine complexified diffeomorphism, since ζ is frozen while $\tilde{\zeta}$ gets scrambled; hence the notation $\tilde{\zeta}$ instead of $\overline{\zeta}$. However crucially, this is a legitimate operation because the Lorentzian signature SDTN solution is inherently a complexified solution as a self-dual solution. In fact, the SDD gauge potential described in Eq. [\(2\)](#page-0-0) is a solution to complexified Maxwell's equations, due to the imaginary magnetic charge $-iq$. In the precise same sense, the SDTN spacetime is a solution to "complex general relativity" as a holomorphic field theory governing

holomorphic metrics of complex four-manifolds [\[54,](#page-7-18) [65–](#page-7-19) [67\]](#page-7-20) (i.e., belongs to the "holomorphic, complexified cate-gory" [\[34\]](#page-7-0)). Especially, the imaginary NUT charge $-i*m*$ essentially makes the metric complex-valued. As a consequence of this interpretation, ζ and ζ can be transformed independently as holomorphic coordinates.

Physical interpretation.—We shall now examine the physical validity of the Kerr-Schild metric in Eq. [\(3\)](#page-0-1). To begin with, we point out that Eq. (3) *itself* is unusual as a Kerr-Schild metric, in fact. While the Kerr-Schild potential is simply $\Phi = m/4\pi r$, the null one-form ℓ involves a semi-infinite line defect along the negative z-axis, which is exactly how the gravitomagnetic charge is encoded:

$$
\ell = -dt + \frac{x+iy}{r+z} dx + \frac{y-ix}{r+z} dy + dz.
$$
 (7)

This is intriguing because the null one-form is usually regular wherever the Kerr-Schild potential is regular, which is especially true for the double Kerr-Schild construction of Taub-NUT in Ref. [\[6\]](#page-6-11).

Crucially, as in the original metric in Eq. [\(6\)](#page-1-1), the interpretation of this line defect should be the Misner string [\[25,](#page-6-7) [26\]](#page-6-12): the gravitational analog of the Dirac string, inputting a gravitomagnetic flux of $-i*m*$ at the origin. To show this, we recall that there are at least three senses in which the Taub-NUT metric [\[25,](#page-6-7) [26\]](#page-6-12) is a gravitational analog of a dyon: (a) the Misner string is invisible as a coordinate artifact if the gravitational analog of the Dirac quantization condition holds [\[25\]](#page-6-7), (b) the Misner string implements a flux tube of time monodromy [\[16,](#page-6-6) [28,](#page-6-17) [29\]](#page-6-18), and (c) the distributional stress-energy of the string describes an energy-less thin solenoid of mass current [\[26,](#page-6-12) [27\]](#page-6-13). Our goal now is to show that all of these properties hold in the Kerr-Schild description as well.

First, we derive the Dirac quantization condition. As a primer, consider the SDD gauge potential in Eq. [\(2\)](#page-0-0). Adding a term $(q/2\pi)d\log\zeta$ repositions its Dirac string along the positive z-axis (north pole). This encodes the complexified group-valued transition function $\zeta^{i\neq q/2\pi}$, where e is the electromagnetic coupling [\[16\]](#page-6-6). Demanding its single-valuedness within the overlap of the two patches covering either north or south poles [\[68\]](#page-7-21) implies $ieq \in 2\pi\mathbb{Z}$, which is precisely the Dirac quantization condition from the imaginary magnetic charge $-iq$.

The gravitational Dirac quantization has been derived in a similar fashion, namely by hiding the string with overlapping coordinate patches [\[25\]](#page-6-7). In the Kerr-Schild description, we find that the diffeomorphism

$$
t \mapsto t + \frac{m}{2\pi} \log \zeta, \quad \tilde{\zeta} \mapsto \frac{1 - (m/4\pi r)(1 + \tilde{\zeta}\zeta)/\tilde{\zeta}\zeta}{1 + (m/4\pi r)(1 + \tilde{\zeta}\zeta)} \quad (8)
$$

with r and ζ fixed transforms Eq. [\(4\)](#page-1-2) to

$$
ds^{2} = -dt^{2} + dr^{2} + r^{2} \frac{4d\tilde{\zeta}d\zeta}{(1 + \tilde{\zeta}\zeta)^{2}} + \frac{m}{4\pi r} \left(-dt + dr + r \frac{2d\zeta}{\zeta(1 + \tilde{\zeta}\zeta)} \right)^{2},
$$
\n(9)

which develops a string defect along the positive z -axis (north pole) [\[69\]](#page-7-22). For this diffeomorphism to be singlevalued within the overlapping region, the time coordinate should be periodic as $t \sim t + im\mathbb{Z}$, given the $2\pi i$ periodicity of $\log \zeta$. As a result, the energy e [\[70\]](#page-7-23) of a test particle is quantized as $iem \in 2\pi\mathbb{Z}$. This is precisely the gravitational analog of the Dirac quantization condition in the presence of the imaginary NUT charge $-i\pi$ [\[16,](#page-6-6) [28,](#page-6-17) [29\]](#page-6-18).

Second, we study the near-string geometries in an explicit manner. Let $\xi := x + iy$, $\tilde{\xi} := x - iy$ be complex coordinates for the (complexified) $x-y$ plane, and suppose a positive infinitesimal ϵ . Applying the replacement $z \mapsto -1/\epsilon + z$ to the gauge potential in Eq. [\(2\)](#page-0-0) and then taking the limit $\epsilon \to 0$, we obtain $A = (q/2\pi) d \log \xi$. This precisely describes an infinite Dirac string as a thin tube of magnetic flux iq flowing in the $-z$ direction, which should be clear from its field strength $F = dA$:

$$
F = \frac{q}{2\pi} dd \log \tilde{\xi} = iq \delta^{(2)}(\tilde{\xi}, \bar{\tilde{\xi}}) d\bar{\tilde{\xi}} \wedge d\tilde{\xi}.
$$
 (10)

Here $\delta^{(2)}(\tilde{\xi},\bar{\tilde{\xi}}) = (1/2\pi i)\partial(1/\tilde{\xi})/\partial \bar{\tilde{\xi}}$ describes the Dirac delta distribution peaked at $\xi = 0$ [\[71\]](#page-7-24).

For the line element in Eq. [\(3\)](#page-0-1), the same limiting procedure leaves out a divergent part, which interestingly can be compensated by a shift $\xi \mapsto \xi + ((m/\pi) (1/\epsilon - z) \frac{3m^2}{4\pi^2}$, $\frac{\tilde{\xi}}{\tilde{\xi}}$. Amusingly, the metric then becomes simply Minkowski, $ds^2 = -dt^2 + dz^2 + d\tilde{\xi} d\xi$, but with multivalued time:

$$
t' = t + \frac{m}{2\pi} \log \tilde{\xi}, \quad z' = z - \frac{m}{\pi} \log \tilde{\xi}.
$$
 (11)

In other words, in the vicinity of the string the geometry approaches to the image of empty spacetime upon a periodically multivalued diffeomorphism (large gauge transformation [\[72,](#page-7-25) [73\]](#page-7-26)). In this geometry, a Sagnac interferometer measures the "time translation monodromy" $\oint dt' = im$ as the gravitational Aharanov-Bohm phase $[29, 30, 74, 75]$ $[29, 30, 74, 75]$ $[29, 30, 74, 75]$ $[29, 30, 74, 75]$ [\[76\]](#page-7-29). Clearly, the flux of this monodromy is localized along $\tilde{\xi} = 0$:

$$
ddt' = \frac{m}{2\pi} dd \log \tilde{\xi} = im \delta^{(2)}(\tilde{\xi}, \bar{\tilde{\xi}}) d\bar{\tilde{\xi}} \wedge d\tilde{\xi}, \qquad (12)
$$

which is curiously the "double copy" of Eq. [\(10\)](#page-2-0) [\[77\]](#page-7-30). Therefore, we conclude that the string defect of Eq. [\(3\)](#page-0-1) indeed describes a thin flux tube of time monodromy.

Finally, we explicitly derive the distributional stressenergy tensor of this string. In general one can take various approaches [\[78–](#page-7-31)[80\]](#page-7-32), but here we particularly consider the distributional stress-energy that follows from the "harmonic-gauge linearization" of Ref. [\[48\]](#page-7-8) which the Kerr-Schild description enables as a luxury.

The harmonic-gauge linearization employs a crucial property that the congruence of $\ell^{\mu}\partial_{\mu}$ can enjoy: geodesic and shear-free (GSF). Given such assumptions, it follows that $T^{\mu\nu} = u^{(\mu} J^{\nu)}$ can be identified as the source for the gravitational solution [\[48\]](#page-7-8). Here J^{μ} denotes the source for the electromagnetic solution, and $u^{\mu} = \delta^{\mu}{}_{0}$ is the unit timelike Killing vector. Applying this formula, we immediately reproduce Bonnor's stress-energy tensor [\[26,](#page-6-12) [27\]](#page-6-13),

describing a point mass m attached to an energy-less [\[81\]](#page-7-33) half-infinite rotating rod! The GSF property of our null one-form in Eq. [\(7\)](#page-1-3) can be shown from an identity $\partial_{\mu} \ell_{\nu} = (1/2r) (\eta_{\mu\nu} + u_{\mu} u_{\nu} - (\ell - u)_{\mu} (\ell - u)_{\nu} + i \varepsilon_{\mu\nu\rho\sigma} u^{\rho} \ell^{\sigma}),$ while the single copy source J^{μ} easily follows by acting on the Laplacian $\Box := -\eta^{\mu\nu}\partial_{\mu}\partial_{\nu}$ to Eq. [\(1\)](#page-0-2) This shows that the string defect of Eq. [\(3\)](#page-0-1) indeed describes a thin solenoid of mass current.

To sum up, we have convinced ourselves from multiple angles that the Kerr-Schild metric in Eq. [\(3\)](#page-0-1) indeed exhibits the geometrical and physical characteristics of a Taub-NUT spacetime arising from the Misner string. This analysis demonstrates that the Kerr-Schild description of the solution is not merely a formal construct but physical. Moreover, the quick derivation of the distributional source demonstrates its usefulness as well.

Weyl double copy in position space.—Finally, let us unlock more classical double copy relations for the SDTN solution. First of all, we consider the Weyl double copy and explicate how the Kerr-Schild metric in Eq. [\(3\)](#page-0-1) resolves a subtlety in the previous constructions [\[3,](#page-6-16) [4\]](#page-6-15).

We begin with a brief review. The Weyl double copy directly constructs the Weyl curvatures of algebraically special spacetimes by "squaring" electromagnetic field strengths [\[2](#page-6-14)[–5\]](#page-6-20), while not necessarily referencing a metric or a gauge potential. For example, take the Coulomb and Schwarzschild solutions. In the spinor language, their field strength and Weyl tensor are given as the following:

$$
F_{\dot{\alpha}\dot{\beta}} = \frac{2q}{4\pi r^2} \,\tilde{o}_{(\dot{\alpha}\tilde{\iota}\dot{\beta})} \,, \quad C_{\dot{\alpha}\dot{\beta}\dot{\gamma}\dot{\delta}} = -\frac{6m}{4\pi r^3} \,\tilde{o}_{(\dot{\alpha}\tilde{\iota}\dot{\beta}\dot{\tilde{\iota}}\dot{\gamma}\tilde{\iota}\dot{\delta})} \,, \quad (13)
$$

where we have omitted the anti-self-dual counterparts. The Weyl double copy is the squaring relation $C_{\dot{\alpha}\dot{\beta}\dot{\gamma}\dot{\delta}} =$ $F_{(\dot{\alpha}\dot{\beta}}F_{\dot{\gamma}\dot{\delta}})/S$ [\[2\]](#page-6-14), which holds with $S \propto 1/r$.

The Weyl double copy correspondences between the SDD and SDTN solutions are established in Refs. [\[3,](#page-6-16) [4\]](#page-6-15) as the "self-dual parts" of the Coulomb and Schwarzschild solutions. That is, the self-dual Weyl curvature (and the principal spinors) of the SDD/SDTN solution is simply postulated to be that of the Coulomb/Schwarzschild solution. This physical anticipation, however, may appear a little nontrivial if one recalls the nonlinearity of gravity [\[82\]](#page-7-34). Especially, the spin-2 field $\phi_{\dot{\alpha}\dot{\beta}\dot{\gamma}\dot{\delta}}$ obtained from the Penrose transform describes only the linearized Weyl tensor in the flat background [\[50\]](#page-7-35). To promote it to the fully nonlinear solution one necessarily has to appeal to a linearization, which is famously possible in the Kerr-Schild gauge [\[48,](#page-7-8) [83,](#page-7-36) [84\]](#page-7-37).

Certainly, the explicit Kerr-Schild metric we have established clearly resolves this subtlety and concretely validates the Weyl double copy constructions in Refs. [\[3,](#page-6-16) [4\]](#page-6-15). Through a straightforward computation of spin connection coefficients in a tetrad frame, we explicitly checked that the self-dual Weyl tensor of the nonlinear SDTN solution as defined in Eq. [\(3\)](#page-0-1) indeed is equal to that of the Schwarzschild solution with the same principal spinors. Specifically, the null one-form in Eq. [\(7\)](#page-1-3) boils down to

$$
-\frac{1}{2}\ell_{\mu}(\sigma^{\mu})_{\alpha\dot{\alpha}} = o_{\alpha}\tilde{o}_{\dot{\alpha}}, \quad \tilde{o}^{\dot{\alpha}} = \begin{pmatrix} 1\\ \zeta \end{pmatrix}, \quad o^{\alpha} = \begin{pmatrix} 1\\ 0 \end{pmatrix}, (14)
$$

where $\tilde{o}^{\dot{\alpha}}$ is one of the principal spinors in Eq. [\(13\)](#page-2-1). Computing the Weyl tensor then reveals the other principal spinor, $\tilde{\iota}^{\dot{\alpha}} = (-\tilde{\zeta}, 1)/(1 + \tilde{\zeta}\zeta)$. Crucially, the real combinations $[\tilde{o}_{\dot{\alpha}}]^* \tilde{o}_{\dot{\beta}}, [\tilde{\iota}_{\dot{\alpha}}]^* \tilde{\iota}_{\dot{\beta}}$ of these principal spinors exactly reproduce the null one-forms $-dt \pm dr$ associated with the Kerr-Schild metrics of the Schwarzschild solution [\[3,](#page-6-16) [4\]](#page-6-15), hence confirming the statement that SDTN is the "selfdual part" of Schwarzschild.

Note that this relationship between SDTN and Schwarzschild could be traced back to the fact that the condition for a null vector field $\tilde{\pi}^{\dot{\alpha}}(x) \pi^{\alpha}(x)$ to be GSF is given by a chiral equation for each copy of the spinors: in flat background, the equation for the right-handed reads [\[50,](#page-7-35) [85\]](#page-7-38)

$$
\tilde{\pi}^{\dot{\alpha}}(x)\tilde{\pi}^{\dot{\beta}}(x)\left(\partial_{\alpha\dot{\alpha}}\tilde{\pi}_{\dot{\beta}}(x)\right) = 0.
$$
\n(15)

If $\tilde{\pi}^{\dot{\alpha}}(x)$ is a solution to Eq. [\(15\)](#page-3-0), then both the *complexified, self-dual* combination $o_{\alpha} \tilde{\pi}_{\beta}(x)$ (with constant o_{α}) and the real, non-self-dual combination $[\tilde{\pi}_{\alpha}(x)]^* \tilde{\pi}_{\beta}(x)$ define null GSF one-forms, from which the idea of taking the "self-dual part" is validated [\[86\]](#page-8-0).

Weyl double copy in twistor space.—Next, let us revisit the Weyl couble copy from twistor space [\[3,](#page-6-16) [4\]](#page-6-15), which eventually illuminates how the Kerr-Schild coordinates have been secretly used in the twistor theory context.

To smoothly motivate the twistor space, we consider a curious theorem due to Kerr [\[50,](#page-7-35) [87,](#page-8-1) [88\]](#page-8-2): any solution to Eq. [\(15\)](#page-3-0) arises as a zero locus of a holomorphic function $f(Z)$ homogeneous in its four complex arguments $\tilde{Z}^{A} = (\tilde{\pi}_{\alpha}, \tilde{\omega}^{\alpha})$ upon plugging in the "incidence relation" $\tilde{\omega}^{\alpha} = \tilde{\pi}_{\dot{\alpha}} \tilde{x}^{\dot{\alpha}\alpha}$ [\[87\]](#page-8-1). This curious complex variable \tilde{Z}^{A} is called a twistor [\[87\]](#page-8-1) and is known to represent a null ray in complexified Minkowski space [\[87\]](#page-8-1).

Taking inspirations from Refs. [\[89](#page-8-3)[–91\]](#page-8-4), Ref. [\[4\]](#page-6-15) proposed the following function for constructing the GSF congruences associated with the SDTN solution [\[92\]](#page-8-5):

$$
f(\tilde{Z}) = -\tilde{\omega}^{\alpha} u_{\alpha \dot{\alpha}} \tilde{\pi}^{\dot{\alpha}}, \quad u_{\alpha \dot{\alpha}} := u_{\mu} (\sigma^{\mu})_{\alpha \dot{\alpha}}.
$$
 (16)

Indeed, $f(\tilde{\pi}, \tilde{\pi}x) = 0$ with the above function exactly yields our principal spinors $\tilde{o}_{\dot{\alpha}}, \tilde{\iota}_{\dot{\alpha}}$ as $\tilde{\pi}_{\dot{\alpha}}(x) \propto \tilde{o}_{\dot{\alpha}}, \tilde{\iota}_{\dot{\alpha}}$.

Remarkably, this twistor function turns out to encode not only the congruences but the entire geometry of the (linearized) SDTN spacetime through a contour integral formula known as Penrose transform [\[93,](#page-8-6) [94\]](#page-8-7), where the "localization" of $\tilde{\pi}_{\alpha}$ to zeroes of $f(\tilde{\pi}, \tilde{\pi}x)$ arises from a residue computation [\[3,](#page-6-16) [4,](#page-6-15) [50\]](#page-7-35):

$$
\phi_{\dot{\alpha}_1\cdots\dot{\alpha}_{2h}}(x) = \oint \frac{\tilde{\pi}_{\dot{\gamma}}d\tilde{\pi}^{\dot{\gamma}}}{2\pi i} \frac{\tilde{\pi}_{\dot{\alpha}_1}\cdots\tilde{\pi}_{\dot{\alpha}_{2h}}}{(f(\tilde{\pi},\tilde{\pi}x))^{h+1}}.
$$
 (17)

Evaluating these contour integrals for $h = 1, 2$ readily reproduces the spin-1 and spin-2 fields in Eq. [\(13\)](#page-2-1). The calculations are almost immediate if one notes that $f(\tilde{\pi}, \tilde{\pi}x) = -\tilde{\pi}_{\dot{\alpha}} \tilde{\chi}^{\dot{\alpha}}{}_{\dot{\beta}} \tilde{\pi}^{\dot{\beta}} = -r\sigma \text{ with } \tilde{\chi}_{\dot{\alpha}\dot{\beta}} = r \tilde{o}_{(\dot{\alpha}} \tilde{\iota}_{\dot{\beta}}) \text{ when}$ the contour is parameterized as $\tilde{\pi}_{\dot{\alpha}} = \tilde{o}_{\dot{\alpha}} + \sigma \tilde{\iota}_{\dot{\alpha}}$, where

$$
\tilde{\chi}^{\dot{\alpha}}{}_{\dot{\beta}} = -x^{\mu}u^{\nu}(\tilde{\sigma}_{\mu\nu})^{\dot{\alpha}}{}_{\dot{\beta}} = -\frac{1}{2}(\vec{x}\cdot\vec{\sigma})^{\dot{\alpha}}{}_{\dot{\beta}} \tag{18}
$$

describes the self-dual part of the bivector $2x^{[\mu}u^{\nu]}$.

In this manner, the curvature tensors arise as the Penrose transform of functions $\mathcal{M}_h(\tilde{Z}) = (f(\tilde{Z}))^{-h-1}$ in twistor space, which are in fact scattering amplitudes of a massive object absorbing a negative-helicity force carrier [\[49\]](#page-7-9) [\[95\]](#page-8-8). The twistor-space Weyl double copy is the squaring relation $\mathcal{M}_2(\tilde{Z}) = (\mathcal{M}_1(\tilde{Z}))^2/\mathcal{M}_0(\tilde{Z})$ between these "twistor-space amplitudes."

Crucially, this rederivation of the twistor-space construction of the SDTN solution is not merely a review. Throughout, the coordinates $x^{\mu} = (\sigma^{\mu})_{\alpha\dot{\alpha}} x^{\dot{\alpha}\alpha}$ have always referred to the Kerr-Schild coordinates defined by the metric in Eq. [\(3\)](#page-0-1). This explicitly shows that our Kerr-Schild coordinates are exactly the Cartesian coordinates which the twistor-space construction of the SDTN solution employs in terms of Penrose transform. In fact, this may not be surprising because our Kerr-Schild coordi-nates turn out to be just Plebański's coordinates [\[54,](#page-7-18) [55\]](#page-7-10) leading to the second heavenly equation. To conclude, twistor-theoretic perspectives on the SDTN solution have presumed the Kerr-Schild coordinates, even if the explicit metric may have not been written down as in Eq. [\(3\)](#page-0-1) or shown to be equivalent to the previously documented form (Gibbons-Hawking [\[41\]](#page-7-4) or Taub-NUT [\[23,](#page-6-4) [24\]](#page-6-5)).

As a side note, we also remark that $\tilde{\chi}^{\dot{\alpha}}{}_{\dot{\beta}}$ in Eq. [\(18\)](#page-3-1) is in fact the Killing spinor [\[50–](#page-7-35)[53\]](#page-7-39) of the SDTN solution, from which a "position vector" \vec{x} is identified [\[34\]](#page-7-0). The identity of this \vec{x} should be evident now.

Operator Kerr-Schild double copy.—Lastly, we propose a nonlocal operator Kerr-Schild double copy as a new result, which interestingly differs from the self-dual double copy previously established in Refs. [\[1,](#page-6-0) [17\]](#page-6-1).

In operator Kerr-Schild double copy, the null one-form ℓ_{μ} in the Kerr-Schild ansatz is promoted to a differential operator \hat{k}_{μ} . Especially, it can factorize as $(\sigma^{\mu})_{\alpha\dot{\alpha}}\hat{k}_{\mu}$ = $-2o_{\alpha}\hat{k}_{\dot{\alpha}}$ so that the fields are manifestly described in the lightcone gauge [\[1,](#page-6-0) [7,](#page-6-21) [8\]](#page-6-22). Intriguingly, we find that the gauge potential in Eq. (2) and the metric in Eq. (3) precisely arise in this way if the operator $\hat{k}_{\dot{\alpha}}$ is given by

$$
\hat{k}_{\dot{\alpha}} = \left(-\frac{\partial_x + i\partial_y}{\partial_z}, 1 \right),\tag{19}
$$

which is *nonlocal*. Specifically, direct computation shows that $\hat{k}_{\dot{\alpha}}(1/r) = (1/r)\tilde{o}_{\dot{\alpha}}$ and $\hat{k}_{\dot{\alpha}}\hat{k}_{\dot{\beta}}(1/r) = (1/r)\tilde{o}_{\dot{\alpha}}\tilde{o}_{\dot{\beta}},$ so a classical double copy correspondence between SDD and SDTN is realized in the following form:

$$
A_{\alpha\dot{\alpha}} = -2 o_{\alpha} \hat{k}_{\dot{\alpha}} \frac{q}{4\pi r}, \quad h_{\alpha\dot{\alpha}\beta\dot{\beta}} = 4 o_{\alpha} o_{\beta} \hat{k}_{\dot{\alpha}} \hat{k}_{\dot{\beta}} \frac{m}{4\pi r}, \tag{20}
$$

where $h_{\mu\nu} := g_{\mu\nu} - \eta_{\mu\nu}$ denotes the "graviton field."

Interestingly, we find that this exotic new form of classical double copy is demystified from an electric-magnetic dual perturbation theory of dyons [\[56](#page-7-11)[–60\]](#page-7-12). Note first that the distributional source of the SDD is explicitly given by

$$
J^{\mu} = \partial_{\nu} F^{\mu \nu} = \left(1, -i \frac{\vec{n} \times \vec{\partial}}{\vec{n} \cdot \vec{\partial}} \right) q \delta^{(3)}(\vec{x}), \qquad (21)
$$

where \vec{n} is the unit vector along the z-axis [\[96\]](#page-8-9). This describes an extended object: the anti-derivative $(-\vec{n}\cdot\vec{\partial})^{-1}$ $=(-\partial_z)^{-1}$ stacks magnetic dipoles $(-\vec{n}\times\vec{\partial})(-iq\,\delta^{(3)}(\vec{x}))$ along the negative z-axis, implementing a thin solenoid. On the other hand, physically we know that this extended object mimics an isolated point dyon $(q, -iq)$ localized at the origin, which is described by the following source:

$$
J^{\mu} = \partial_{\nu} F^{\mu\nu} = qu^{\mu} \delta^{(3)}(\vec{x}),
$$

\n
$$
J^{\star\mu} = -\partial_{\nu} * F^{\mu\nu} = -iqu^{\mu} \delta^{(3)}(\vec{x}).
$$
\n(22)

Specifically, $F_{\mu\nu}$ sourced by Eq. [\(21\)](#page-4-0) is identical to $F_{\mu\nu}$ sourced by Eq. [\(22\)](#page-4-1) at all points outside the solenoid [\[97\]](#page-8-10). Yet crucially, Eq. [\(22\)](#page-4-1) involves a bonafide violation of the Bianchi identity: $\partial_{\lbrack\rho}F_{\mu\nu\rbrack}\neq0$. Hence it does not define a source in the Maxwell theory but instead belongs to its extension admitting both electric and magnetic sources considered by Dirac [\[98\]](#page-8-11).

As a dynamical field theory, a Lagrangian formulation of this extended Maxwell theory is given by Zwanziger's "two-potential electrodynamics" where the dual photon field A^{\star}_{μ} is employed to incorporate the Bianchi violation [\[56,](#page-7-11) [99\]](#page-8-12). This means the gauge potential of the SDD could have been derived from the dyonic source in Eq. [\(22\)](#page-4-1) by using the propagators of Zwanziger theory!

The Zwanziger propagators can be found in Refs. [\[56–](#page-7-11) [59\]](#page-7-40). Here, we note that a single spinor equation succinctly summarizes them [\[100\]](#page-8-13):

$$
\hat{\Delta}_{\alpha\dot{\alpha}\beta\dot{\beta}}^{+-} = \frac{n_{\alpha\dot{\beta}}\partial_{\beta\dot{\alpha}}}{-n\cdot\partial} \frac{1}{\Box},\tag{23}
$$

where $n_{\alpha\dot{\alpha}}$ is an auxiliary four-vector that traces back to the Dirac string. Eq. [\(23\)](#page-4-2) describes the position-space propagator from A_{μ}^- to A_{μ}^+ where $A_{\mu}^{\pm} := \frac{1}{2}(A_{\mu} \pm iA_{\mu}^*),$ while other propagators between A^{\pm}_{μ} vanish. Meanwhile, the sources coupling to A^{\pm}_{μ} are given by $J^{\mu}_{\pm} = J^{\mu} \mp i J^{\mu}$, which are $J^{\mu}_{+} = 0$, $J^{\mu}_{-} = 2qqu^{\mu} \delta^{(3)}(\vec{x})$ for Eq. [\(22\)](#page-4-1). As a result, the photon field $A_{\mu} = A_{\mu}^{+} + A_{\mu}^{-}$ sourced by Eq. [\(22\)](#page-4-1) is found as

$$
A_{\alpha\dot{\alpha}} = A_{\alpha\dot{\alpha}}^{+} = \frac{n_{\alpha\dot{\beta}}u^{\dot{\beta}\beta}\partial_{\beta\dot{\alpha}}}{n \cdot \partial} \frac{q}{4\pi r} \,. \tag{24}
$$

Then a simple calculation shows that Eqs. [\(19\)](#page-3-2) and [\(20\)](#page-4-3) are exactly reproduced when the auxiliary vector is taken to be null as $n_{\alpha\dot{\alpha}} = -o_{\alpha}\bar{o}_{\dot{\alpha}}$, yielding $\hat{k}_{\dot{\alpha}} = -\partial_{1\dot{\alpha}}/\partial_{0\dot{\alpha}}$.

Amusingly, the graviton field arises in the same fashion by using the linearized gravity equivalent of Zwanziger propagator, which is simply given by double copying Eq. [\(23\)](#page-4-2) as is advocated in Ref. [\[60\]](#page-7-12)! In the gravitational case the source dual to $T^{\mu\nu} = u^{(\mu} J^{\nu)}$ is given by $T^{\mu\nu}_+ = 0$ and $T_{-}^{\mu\nu} = 2mu^{\mu}u^{\nu}\delta^{(3)}(\vec{x})$ [\[101\]](#page-8-14), describing a static selfdual gravitational dyon. As a result, the linearized graviton field $h_{\mu\nu} = h_{\mu\nu}^+ + h_{\mu\nu}^-$ is found as

$$
h_{\alpha\dot{\alpha}\beta\dot{\beta}} = h_{\alpha\dot{\alpha}\beta\dot{\beta}}^{+} = \frac{n_{\alpha\dot{\gamma}}u^{\dot{\gamma}\gamma}\partial_{\gamma\dot{\alpha}}}{n\cdot\partial} \frac{n_{\beta\dot{\delta}}u^{\dot{\delta}\delta}\partial_{\delta\dot{\beta}}}{n\cdot\partial} \frac{m}{4\pi r}, \quad (25)
$$

which is in turn identified as the full metric perturbation $g_{\mu\nu} - \eta_{\mu\nu}$ by virtue of the linearization in the Kerr-Schild gauge [\[48,](#page-7-8) [83,](#page-7-36) [84\]](#page-7-37). This precisely explains the double copy structure proposed in Eq. [\(20\)](#page-4-3) as we claimed earlier.

A few comments are in order. Firstly, it is instructive to revisit this construction from the on-shell perspective. It is easy to check that the "numerator factor" of the offshell propagator in Eq. [\(23\)](#page-4-2) correctly factorizes into the null polarization vectors with $n_{\alpha\dot{\alpha}} = -o_{\alpha}\bar{o}_{\dot{\alpha}}$, from which its double copy can be argued [\[60\]](#page-7-12). The double copy of sources from $J^{\mu}_{-} = 2qu^{\mu}\delta^{(3)}(\vec{x})$ to $T^{\mu\nu}_{-} = 2mu^{\mu}u^{\nu}\delta^{(3)}(\vec{x})$ realizes the squaring relation of the massive on-shell amplitudes in terms of the x-factor [\[60,](#page-7-12) [102–](#page-8-15)[104\]](#page-8-16). Further, one may also explicitly connect the off-shell constructed fields in Eqs. [\(24\)](#page-4-4) and [\(25\)](#page-4-5) to the Penrose transform in Eq. [\(17\)](#page-3-3) through a parameterization of off-shell momentum employed in Ref. [\[49\]](#page-7-9).

Secondly, it will be interesting to examine whether this "Zwanziger double copy" persists for generic Taub-NUT [\[105\]](#page-8-17). Its failure would signal the significance of not only linearization by Kerr-Schild gauge but also self-duality.

Lastly, we report a strange fact that the SDTN solution fails to be the self-dual double copy [\[1,](#page-6-0) [7,](#page-6-21) [17\]](#page-6-1) of SDD. Such a dissonance is disturbing, especially since the selfdual double copy is arguably the most natural option for self-dual solutions and will imply fascinating conclusions such as "SDTN black hole is a large- N dyon" by be-ing rooted on Moyal deformation [\[106–](#page-8-18)[109\]](#page-8-19) of Plebański [\[54\]](#page-7-18)'s second heavenly equation [\[110,](#page-8-20) [111\]](#page-8-21). Specifically, the *local* operator $k_{\dot{\alpha}} = \partial_{0\dot{\alpha}}$ of the self-dual double copy makes the Plebański scalar field different for each helicity: $A_{\alpha\dot{\alpha}} = -2 o_{\alpha} \partial_{0\dot{\alpha}} (q\zeta/4\pi), h_{\alpha\dot{\alpha}\beta\dot{\beta}} = 4 o_{\alpha} o_{\beta} \partial_{0\dot{\alpha}} \partial_{0\dot{\beta}}$ $(m(2r+z)\zeta^2/24\pi)$ [\[112\]](#page-8-22). This puzzle seems to deserve a further investigation, possibly by comparing with the case of Eguchi-Hanson instanton [\[7\]](#page-6-21).

Conclusions.—In this note, we have shown that a complexified diffeomorphism reveals a Kerr-Schild metric for the SDTN solution. Crucially, the validity of this diffeomorphism and the metric is verified by highlighting their intrinsically complex nature. Especially, we have verified that the Kerr-Schild metric also exhibits the Misner string defect, supporting its physical interpretation as a gravitational dyon. Further explicitly, we have established three concrete senses in which the SDTN solution is precisely the gravitational counterpart of a SDD in electromagnetism: Kerr-Schild, Weyl, and operator Kerr-Schild classical double copy. Notably, the last one adds to the inventory of classical double copies as a new entry. We have identified its physical origin as the double copy of propagators between dyonic sources.

It is interesting to realize that the Gibbons-Hawking ansatz had already suggested a sense in which self-dual electromagnetic objects correspond to self-dual gravitational objects, far before the advent of the classical double copy program. It is amusing to see how this correspondence has become strengthened for SDTN and SDD from three new perspectives. Especially, the idea that the Misner string is a gravitational analog of Dirac string is concretely confirmed in the first and third double copy constructions. On a related note, we can also frame this work from the angle of "classical double copy constructions of gravitational instantons." A noteworthy example has been given by Ref. [\[7\]](#page-6-21), where the Eguchi-Hanson instanton [\[113](#page-8-23)[–115\]](#page-8-24) is constructed from the self-dual double copy (cf. Ref. [\[116\]](#page-8-25)). This work adds another instance to the discourse, i.e., the "Taub-NUT instanton."

The Kerr-Schild metric of the SDTN solution conveys an aesthetic elegance in terms of its minimalist and spinorial nature as manifested in Eq. [\(14\)](#page-3-4). To investigate what facilitates this remarkable gem, we could examine its relation to the self-dual limit of the double Kerr-Schild metric employed in Ref. [\[6\]](#page-6-11). Finding a diffeomorphism bridging between the two would shed an insight [\[117\]](#page-8-26).

Meanwhile, as we have clarified the Kerr-Schild coordinates themselves have been already employed in the spinorial/twistorial formalisms. In this light, the metric in Eq. [\(3\)](#page-0-1) can be thought of as providing an explicit construction of a "potential" for the Weyl curvature which the Penrose transform or Killing spinor has described.

Yet, we believe there is a value in having a more explicit description. In particular, it will be interesting to explore further consequences and applications of our Kerr-Schild metric: asymptotic symmetries [\[118,](#page-8-27) [119\]](#page-8-28) [\[120\]](#page-8-29), revisiting the integrability of test-particle motion [\[39,](#page-7-2) [40\]](#page-7-3), black hole perturbation theory [\[34,](#page-7-0) [35,](#page-7-41) [121,](#page-8-30) [122\]](#page-8-31), or finding exact graviton propagators [\[123–](#page-8-32)[125\]](#page-8-33) to carry out self-force calculations [\[126–](#page-8-34)[128\]](#page-8-35) in an idealized set-up, to list a few directions. Especially, explorations in the scattering context are likely to shed insights on Kerr black hole scattering as a certain integrable sector on account of the Newman-Janis shift: the "self-dual part" of the Kerr solution is a SDTN solution displaced along an imaginary direction [\[1,](#page-6-0) [22,](#page-6-3) [34](#page-7-0)[–36,](#page-7-42) [61,](#page-7-13) [129](#page-8-36)[–133\]](#page-9-0).

Amusingly, about a year ago we found a vivid physical picture that explains this fact explicitly by means of complex diffeomorphisms. Namely, as depicted in Fig. [2,](#page-5-0) we realized that a simple complex coordinate transformation maps the Kerr metric in Kerr-Schild coordinates to another Kerr-Schild metric describing two point masses joined by a Misner string. By zooming into the upper tip of the string, we obtained—by construction—a Kerr-Schild metric, which was precisely the metric in Eq. [\(3\)](#page-0-1).

And crucially, this had to be describing a Taub-NUT instanton according to the Newman-Janis shift. The complex diffeomorphism in Eq. [\(5\)](#page-1-0) was precisely a result of explicitly verifying this strong conviction. This is how we originally derived the Kerr-Schild metric reported in this note. We hope to release more details soon [\[134\]](#page-9-1).

Note added. Shortly after the initial release of this work, the author was informed that a split-signature version of the Kerr-Schild metric in Eq. [\(3\)](#page-0-1) was previously conjectured in Ref. [\[64\]](#page-7-17). Then, about a week after this notice, Ref. [\[135\]](#page-9-2) appeared, providing an existence proof for a real diffeomorphism in split signature but "without determining an explicit diffeomorphism carrying one line element to the other" [\[135\]](#page-9-2). In contrast, this work directly provides a concrete constructive proof in the form of an explicit diffeomorphism, for all signatures by taking the complexified point of view [\[136\]](#page-9-3). Especially, it is interesting to observe that our constructive proof in fact resolves the question left by Ref. [\[135\]](#page-9-2): taking the real slice $t, x, iy, z \in \mathbb{R}$ makes the two metrics in Eqs. [\(3\)](#page-0-1) and [\(6\)](#page-1-1) as well as the diffeomorphism in [\(5\)](#page-1-0) all real for real mass $m \in \mathbb{R}$, while also exactly reproducing Ref. [\[64\]](#page-7-17)'s conjectured metric, Eq. (6.16) [\[137\]](#page-9-4).

Appendix: Kerr-Schild to Gibbons-Hawking by the null geodesic flow

Suppose a vector field ℓ^{μ} in complexified Minkowski space that defines a geodesic congruence: $\ell^{\mu}{}_{,\nu}\ell^{\nu} = 0$. The time- ϵ flow generated by this vector field is simply $x^{\mu} \mapsto x^{\mu} + \epsilon \ell^{\mu}(x)$, as geodesics are straight lines in flat space. The pull-back of the flat metric $\eta = \eta_{\mu\nu} dx^{\mu} \otimes dx^{\nu}$ is $\eta + 2\epsilon \ell_{(\mu,\nu)} dx^{\mu} \otimes dx^{\nu} + \epsilon^2 \eta_{\rho\sigma} \ell^{\rho}{}_{,\mu} \ell^{\sigma}{}_{,\nu} dx^{\mu} \otimes dx^{\nu}$.

The null vector field associated with the Kerr-Schild metric of the SDTN solution, $\ell^{\mu} = (1, \zeta, -i\zeta, 1)$, is stationary, geodesic, and shear-free. With the selfduality condition, they together implies that $2\partial_{\nu}\ell^{\mu}$ = $\rho \tilde{m}^{\mu} m_{\nu}$, when described with a null tetrad (l^{μ}, n^{μ}) $(2u^{\mu} - \ell^{\mu}, m^{\mu}, \tilde{m}^{\mu})$ where $u^{\mu} := \delta^{\mu}{}_{0}$. The complex expansion computes to $\rho = 1/r$.

As a result, it follows that the flat metric transforms to $\eta + \epsilon \rho \tilde{m} \odot m$ if the geodesic flow $x^{\mu} \mapsto x^{\mu} + \epsilon \ell^{\mu}(x)$ is used as a diffeomorphism, where ⊙ denotes the symmetrized tensor product. In turn, the Kerr-Schild metric $\eta + \phi \ell^2$ transforms to

$$
\eta + \epsilon \rho \tilde{m} \odot m + \phi' \ell^2, \qquad (26)
$$

where $\phi'(x) := \phi(x + \epsilon \ell(x)).$

Meanwhile, using $\eta = -2u \odot \ell + \ell^2 + \tilde{m} \odot m$, the Gibbons-Hawking metric $-(1+\phi)^{-1}(u-\phi(\ell-u))^2$ +

 $(1+\phi)(u^2+\eta)$ boils down to

$$
\eta + \phi \tilde{m} \odot m + (\phi^{-1} + 1)^{-1} \ell^2. \tag{27}
$$

Therefore, if we can flow along the geodesic congruence such that $\phi^{-1} + 1 = \phi'^{-1}$ and $\epsilon \rho = \phi$, then the Kerr-Schild metric is mapped to the Gibbons-Hawking metric. Evidently, $\epsilon = m/4\pi$ satisfies both of these conditions. Thus the diffeomorphism from the Kerr-Schild to Gibbons-Hawking metrics is given by $t \mapsto t + m/4\pi$, $x \mapsto x + m\zeta/4\pi$, $y \mapsto y - im\zeta/4\pi$, $z \mapsto z + m/4\pi$, which is equivalent to Eq. (5) up to dropping the constant shift in the time coordinate. It could be interesting if this "trick" also proves to be useful for more general cases such as non-self-dual solutions or multi-centered Gibbons-Hawking metrics.
