# A SIMPLE PROOF OF A THEOREM OF SENSITIVITY II

ABSTRACT. Let S be a topological semigroup and consider the dynamical system  $(S, X, \Phi)$ , where X is locally compact metric space with a countable base. When  $(S, X, \Phi)$  is transitive, dense of minimal set and non minimal the dynamical system is sensitive.

#### 1. INTRODUCTION.

The goal of this paper is to generalize [IP2] and [Z] which in turn are generalizations of the works [BBCDS], [AAK], [KM] and [IP1]. In [IP2] the compactness of the space X is strongly used and in this new work locally compact and countable basis is requested. These new results are based on the ideas used in [Z].

1.1. **Basic definitions and notations.** The dynamical system that we will consider is formally defined as a triplet  $(S, X, \Phi)$  where S is a topological semigroup and  $\Phi : S \times X \to X$  is a continuous function with  $\Phi(s_1, \Phi(s_2, x)) = \Phi(s_1s_2, x)$  for all  $s_1, s_2 \in S$  and for all  $x \in X$  and X is a metric space, where X is infinite and has no isolated points. The map  $\Phi$  is called an action of S on X. We will denote  $\Phi(s, x)$  by  $\Phi_s(x)$ .

For any  $x \in X$  we define the orbit of x as  $O(x) = \{\Phi_s(x) : s \in S\}$ . A non-empty set  $Y \subset X$ , is minimal if  $\overline{O(y)} = Y$  for any  $y \in Y$ . A point  $x \in X$  is minimal if the set  $\overline{O(x)}$  is a minimal set. We denote by  $\mathcal{M}$  the set of minimal points. We say that the dynamical system  $(\mathcal{S}, X, \Phi)$  is minimal if there exists a minimal point  $x \in X$ such that  $\overline{O(x)} = X$ .

The dynamical system  $(\mathcal{S}, X, \Phi)$  is point transitive (PT) if there exists  $x \in X$ such that  $\overline{O(x)} = X$ , it is topologically transitive (TT) if given two opene (= open and non-empty) sets  $U, V \subset X$  there exists  $s \in \mathcal{S}$  such that  $\Phi_s(U) \cap V \neq \emptyset$  and it is densely point transitive (DPT) if there exists a dense set  $Y \subset X$  of transitive points. Denote by Trans(X) the set of transitive points and by  $Trans(X)^*$  the set  $\{x \in Trans(X) : \Phi_s(x) \in Trans(X), \forall s \in S\}$ . If X is a Polish space (i.e. separable completely metrizable topological space) or X is locally compact metric space with a countable base, then TT implies DPT.

We say that a dynamical system  $(\mathcal{S}, X, \Phi)$  is sensitive if there exists  $\varepsilon > 0$  such that for all  $x \in X$  and for all  $\delta > 0$  there exists  $y \in B(x, \delta)$  and  $s \in \mathcal{S}$  such that  $d(\Phi_s(x), \Phi_s(y)) > \varepsilon$ .

We will now state our main results:

**Theorem 1.1.** Let X be a locally compact metric space with a countable base and  $(S, X, \Phi)$  that satisfy the following conditions: (1) is PT, (2)  $\mathcal{M}$  is dense and (3) non minimal.

Then  $(\mathcal{S}, X, \Phi)$  is sensitive to any metric d metrizing X.

Let  $\mathcal{F}$  be the union of points having closed orbits.

**Theorem 1.2.** Let X be a locally compact metric space with a countable base and  $(S, X, \Phi)$  that satisfy the following conditions: (1)  $Trans(X)^* \neq \emptyset$ , (2)  $\mathcal{F}$  is a dense subset in X and (3) there exists  $x \in X$  such that  $\overline{O(x)} \neq X$  Then  $(S, X, \Phi)$  is sensitive to any metric

(3) there exists  $x \in X$  such that  $O(x) \neq X$  Then  $(S, X, \Phi)$  is sensitive to any metric d metrizing X.

If  $Trans(X)^* \neq \emptyset$ , we obtain a generalization of the Theorem 1.1. Denote by  $\mathcal{M}^{-1} = \bigcup_{s \in \mathcal{S}} \Phi_s^{-1}(\mathcal{M}).$ 

**Theorem 1.3.** Let X be a locally compact metric space with a countable base and  $(S, X, \Phi)$  that satisfy the following conditions:

(1)  $Trans(X)^* \neq \emptyset;$ 

(2)  $\mathcal{M}^{-1}$  is dense in X and

(3) non minimal.

Then  $(\mathcal{S}, X, \Phi)$  is sensitive to any metric d metrizing X.

2. Proof of Theorems 1.1 and 1.2.

For the proof of the main theorems we need the following lemma:

**Lemma 2.1.** Assume that  $(S, X, \Phi)$  is PT and  $\mathcal{M}$  is dense. Then:

- (1)  $(\mathcal{S}, X, \Phi)$  is TT.
- (2) If X is locally compact metric space with a countable base,  $(\mathcal{S}, X, \Phi)$  is DPT.

**Proof item (1).** Let U and V be opene sets and  $z \in X$  such that  $\overline{O(z)} = X$ . Then there exist  $\Phi_s, \Phi_{s_1}$  and  $W_z$  a neighbourhood of z such that  $\Phi_s(W_z) \subset U$  and  $\Phi_{s_1}(W_z) \subset V$ . As  $\mathcal{M}$  is dense there exists  $y \in \mathcal{M} \cap W_z$ . Then  $\Phi_s(y) \in U$  and  $\Phi_{s_1}(y) \in V$ . As y is a minimal point then there exists  $\Phi_{s_2}$  such that  $\Phi_{s_2}\Phi_s(y) \in V$ . Then  $\Phi_{s_2}(U) \cap V \neq \emptyset$ .

**Proof item (2).** Let  $\{U_k\}_{k \in \mathbb{N}}$  be a countable base. By item 1), given  $k, m \in \mathbb{N}$  there exists  $s(k,m) \in S$  such that  $\Phi_{s(k,m)}(U_m) \cap U_k \neq \emptyset$ . So, by Baire's Theorem,

$$R = \bigcap_{k \ge 0} \bigcup_{m \ge 0} \Phi_{s(k,m)}^{-1}(U_k) \text{ is a residual of dense orbits.}$$

It follows, from the definition of sensitivity, that:

**Remark 1.** If  $(S, X, \Phi)$  is nonsensitive then for all  $k \in \mathbb{N}$  there exists an opene set  $V_k$  such that  $diam(\Phi_s(V_k)) \leq 1/k$  for all  $s \in S$ .

#### Proof of Theorem 1.1:

Suppose that  $(\mathcal{S}, X, \Phi)$  is nonsensitive. Given  $x \in X$ , we will prove that  $\overline{O(x)} = X$ (this is a contradiction because  $(\mathcal{S}, X, \Phi)$  is non minimal). Let  $w \in X$  and consider B(w, r), r > 0. Let  $k_0$  be such that  $1/k_0 < r/4$ . As  $(\mathcal{S}, X, \Phi)$  is nonsensitive, by Remark 1, there exists an opene  $V_{k_0}$  such that  $diam(\Phi_s(V_{k_0})) \leq 1/k_0$  for all  $s \in \mathcal{S}$ . As  $(\mathcal{S}, X, \Phi)$  is PT and  $\mathcal{M}$  is dense, then (by Lemma 2.1)  $(\mathcal{S}, X, \Phi)$  is DPT. So, there exists  $z \in V_{k_0}$  be such that  $\overline{O(z)} = X$ .

Let  $s_0 \in \mathcal{S}$  and  $\varepsilon > 0$  be such that

(2.1) 
$$B(z,\varepsilon) \subset V_{k_0} \text{ and } \Phi_{s_0}(B(z,\varepsilon)) \subset B(w,r/8).$$

As  $\overline{O(z)} = X$ , there exists a sequence  $\{s'_n\}, s'_n \in \mathcal{S}$  such that  $\Phi_{s'_n}(z) \to x$ . As  $\mathcal{M}$  is dense, there exists a minimal set  $M_1$  and  $y \in M_1$  such that  $y \in B(z, \varepsilon) \subset U_{k_0}$ . Without loss of generality we can assume that  $\Phi_{s'_n}(y) \to y_0$  (here we are using that X locally compact). As  $y_0 \in M_1$  there exist  $s_1 \in \mathcal{S}$  such that  $\Phi_{s_1}(y_0) \in B(z, \varepsilon)$ .

Since  $z, y \in V_{k_0}$  then  $d(\Phi_{s_0}\Phi_{s_1}\Phi_{s'_n}(z), \Phi_{s_0}\Phi_{s_1}\Phi_{s'_n}(y)) \leq 1/k_0$ . As  $\Phi_{s'_n}(z) \to x$ and  $\Phi_{s'_n}(y) \to y_0$  we obtain

$$(2.2) \quad d(\Phi_{s_0}\Phi_{s_1}(x), \Phi_{s_0}\Phi_{s_1}(y_0)) = \lim_{n \to +\infty} d(\Phi_{s_0}\Phi_{s_1}\Phi_{s_n'}(z), \Phi_{s_0}\Phi_{s_1}\Phi_{s_n'}(y)) \le 1/k_0 \cdot$$

As  $d(w, \Phi_{s_0} \Phi_{s_1}(y_0)) \leq r/8$  and  $d(\Phi_{s_0} \Phi_{s_1}(x), \Phi_{s_0} \Phi_{s_1}(y_0)) \leq 1/k_0 < r/4$  then  $d(w, \Phi_{s_0} \Phi_{s_1}(x)) < r$ .

## **Proof of Theorem 1.2:**

Suppose that  $(\mathcal{S}, X, \Phi)$  is nonsensitive. Let  $x \in X$  be as by item (3) of hypothesis. We will prove that  $\overline{O(x)} = X$  and this is a contradiction. Let  $w \in X$  and consider B(w, r), r > 0. Let  $k_0$  be such that  $1/k_0 < r/4$ . As  $(\mathcal{S}, X, \Phi)$  is nonsensitive, by Remark 1, there exists an opene  $V_{k_0}$  such that  $diam(\Phi_s(V_{k_0})) \leq 1/k_0$  for all  $s \in \mathcal{S}$ . Let  $z \in Trans(X)^* \cap V_{k_0}$  be and a sequence  $\{s'_n\}, s'_n \in \mathcal{S}$ , such that  $\Phi_{s'_n}(z) \to x$ .

As  $\mathcal{F}$  is dense, there exists  $y \in V_{k_0} \cap \mathcal{F}$ . Without loss of generality we can assume that  $\Phi_{s'_n}(y) \to y_0$  (here we are using that X locally compact). As  $y \in \mathcal{F}$ , then there exists  $s_0$  such that  $y_0 = \Phi_{s_0}(y)$ .

As  $z \in Trans(X)^*$  there exists  $s_1$  such that  $\Phi_{s_1}\Phi_{s_0}(z) \in B(w, r/8)$ . Since  $y, z \in V_{k_0}$  then:

- (1)  $d(\Phi_{s_1}\Phi_{s_0}(z), \Phi_{s_1}\Phi_{s_0}(y)) \le 1/k_0 < r/4.$
- (2) As  $y_0 = \Phi_{s_0}(y)$  then  $d(\Phi_{s_1}\Phi_{s_0}(z), \Phi_{s_1}(y_0)) \le 1/k_0 < r/4$ .
- (3)  $d(\Phi_{s_1}(y_0), \Phi_{s_1}(x)) = \lim_{n \to +\infty} d(\Phi_{s_1} \Phi_{s'_n}(y), \Phi_{s_1} \Phi_{s'_n}(z)) \le 1/k_0 < r/4.$
- (4) From (2) and (3,) we obtain that  $d(\Phi_{s_1}(x), \Phi_{s_1}\Phi_{s_0}(z)) < r/2$ .

As  $\Phi_{s_1}\Phi_{s_0}(z) \in B(w, r/8)$ , from (4) we have that  $\Phi_{s_1}(x) \in B(w, r)$ .  $\Box$ 

Let  $M \subset X$  be a subset of X. We define  $M^{-1} := \bigcup_{s \in S} \Phi_s^{-1}(M) \cup M$ , where  $\Phi_s^{-1}(M) = \{x \in X : \Phi_s(x) \in M\}.$ 

**Proposition 1.** Let X be a locally compact metric space with a countable base and  $(S, X, \Phi)$  that satisfy the following two conditions:

(1)  $Trans(X)^* \neq \emptyset$ ,

(2) There exists an invariant no dense set M such that  $M^{-1}$  is dense in X. Then  $(\mathcal{S}, X, \Phi)$  is sensitive to any metric d metrizing X.

Proof. As M is no dense, there exists  $w \in X$  and r > 0 such that  $M \cap B(w, r) = \emptyset$ . We will show that the dynamical system  $(\mathcal{S}, X, \Phi)$  is sensitive with constant  $\delta = r/4$ . Let  $x \in X$  and U a neighbourhood of x. As  $M^{-1}$  is dense in X there exists  $y \in M^{-1} \cap U$ . Then there exists  $s_0 \in \mathcal{S}$  that  $\Phi_{s_0}(y) \in M$ . Let  $z \in Trans(X)^* \cap U$ . As  $z \in Trans(X)^*$  there exist  $s_1 \in \mathcal{S}$  that  $\Phi_{s_1} \Phi_{s_0}(z) \in B(w, r/2)$ . As  $\Phi_{s_1} \Phi_{s_0}(y) \in M$ , then  $d(\Phi_{s_1} \Phi_{s_0}(y), \Phi_{s_1} \Phi_{s_0}(z)) > r/2 > \delta$ .

Recall that  $\mathcal{M}$  is the set of minimal points.

## Proof of Theorem 1.3:

If  $\mathcal{M}$  is dense, by Theorem 1.1,  $(\mathcal{S}, X, \Phi)$  is sensitive. If  $\mathcal{M}$  is no dense, by Proposition 1,  $(\mathcal{S}, X, \Phi)$  is sensitive.

The following example shows that in Proposition 1 it is not possible to changed the hypothesis  $Trans(X)^* \neq \emptyset$  by hypothesis TT.



Let  $f_1, f_2, f_3 : [0, 1] \to [0, 1]$  be as in Figure 1 and S the semigroup generated by  $f_1, f_2$  and  $f_3$ . The following was proved in [IP1]:

- $\mathcal{M} = \{0\}$  and  $f_1^{-1}(0) = [0, 1] = X$ , therefore  $\mathcal{M}^{-1}$  is dense.
- $(\mathcal{S}, X, \Phi)$  is TT and non-minimal.
- $(\mathcal{S}, X, \Phi)$  is non-sensitive.
