# Sections of Submonoids of Nilpotent Groups

#### Abstract

We show that every product of f.g. submonoids of a group $G$ is a section of a f.g. submonoid of $G \times H_{5}(\mathbb{Z})$, where $H_{5}(\mathbb{Z})$ is a Heisenberg group. This gives us a converse of a reduction of Bodart, and a new simple proof of the existence of a submonoid of a nilpotent group of class 2 with undecidable membership problem.


## 1 Background and Overview

Romankov showed in [Rom99] that the rational subset membership problem in undecidable in some group $G \in \mathcal{N}_{2}$, where $\mathcal{N}_{2}$ is the class of nilpotent groups of class 2. Later, [Loh15; KLZ16] showed undecidability in the same class $\mathcal{N}_{2}$ for more specific types of rational sets, such as products of subgroups. More recently, Romankov showed the existence of an $\mathcal{N}_{2}$ group with a submonoid with undecidable membership problem [Rom23]. All of the above results rely on the negative solution to Hilbert's 10th problem. There are also some recent positive decidability results in nilpotent groups [Bod24; Sha24a]. In this work, we show that if $G$ is any f.g. group and $A \subset G$ is a product of f.g. submonoids of $G$, then $A$ is a section of some submonoid $M$ of $G \times H_{5}(\mathbb{Z})$, that is, for some $h \in H_{5}(\mathbb{Z})$ we have $g \in A$ iff $(g, h) \in M$. The proof uses simple geometric constructions in the plane. Besides being interesting in its own right, this allows us to reduce the membership problem in $A$ to submonoid membership in $G \times H_{5}(\mathbb{Z})$. Using the existence of products of submonoids of some $G \in \mathcal{N}_{2}$ with undecidable membership problem [KLZ16], we get a new, simple proof of the existence of an undecidable submonoid of a group $G \in \mathcal{N}_{2}$. The method of sections was also used in [Sha24b] to show that any rational subset of $G$ is a section of a submonoid of $G \times H$ where $H$ is virtually Abelian. This paper deals exclusively with sections where the second group $H$ is in $\mathcal{N}_{2}$. We first show that for $H=H_{3}(\mathbb{Z})$ we can get products of 2 submonoids as sections, then we show that for groups of type $H=H_{3}(\mathbb{Z}) /\left\langle z^{e}\right\rangle$ we can get products of conjugate submonoids as sections. For arbitrary products of submonoids we need a larger group $H=H_{5}(\mathbb{Z})$. In [Bod24], Bodart showed that submonoid membership in a nilpotent group $G$ can be reduced to membership in products of submonoids in subgroups $H<G$ with $h([H, H])<h([G, G])$. Our result gives a tight converse to this reduction: it gives a reduction from membership in products of submonoids of $G$ to submonoid membership in a larger group $K=G \times H_{5}(\mathbb{Z})$ satisfying $h([K, K])=h([G, G])+1$.

### 1.1 Notations

We define $\mathbb{N}_{0}=\{0,1,2 \ldots\}, \mathbb{N}_{+}=\{1,2, \ldots\}$. If $G$ is a group and $S \subset G,\langle S\rangle$ and $S^{*}$ are the subgroup and submonoid generated by $S$ respectively. $\mathcal{N}_{2}$ denotes the class of nilpotent groups of class 2 . All of our groups and submonoids are finitely generated. If $A \subset G \times H$ and $h \in H$, we define $\left.A\right|_{h}=\{g \in G \mid(g, h) \in A\}$, and call $\left.A\right|_{h}$ the $h$-section of $A$. We view $G, H$ as subgroups of $G \times H$, and therefore $A \cap G=\left.A\right|_{1_{H}}$. For any $d \in \mathbb{N}_{+}$, the discrete Heisenberg group $H_{2 d+1}(\mathbb{Z})$ is the group generated by $x_{1}, \ldots, x_{d}, y_{1}, \ldots, y_{d}, z$ with the relations $\left[x_{i}, y_{i}\right]=z$ for all $i$, and all other generators commute. In $H_{3}(\mathbb{Z})$, we use $x, y, z$ instead of $x_{1}, y_{1}, z$.

For notational convenience, for any vector $v \in \mathbb{Z}^{d}$, we define $\boldsymbol{x}^{v}=x_{1}^{v_{1}} \cdots x_{d}^{v_{d}}$ and similarly for $\boldsymbol{y}^{v}$. From $\left[x_{i}, y_{j}\right]=z^{\delta_{i j}}$ and bi-linearity of the commutator in $\mathcal{N}_{2}$, we get $\left[\boldsymbol{x}^{u}, \boldsymbol{y}^{v}\right]=z^{\langle u, v\rangle}$ for any $u, v \in \mathbb{Z}^{d}$ where $\langle u, v\rangle$ is the standard inner product. This allows us to use plane geometry in our calculations in $H_{5}(\mathbb{Z})$.

## 2 Sections with $H_{3}(\mathbb{Z})$

### 2.1 Product of a pair of submonoids

The following Proposition also appears in [Rom23, Lemma 3.1].
Proposition 1. Let $t=x^{-1} z$. Let $w \in\{t, y, x\}^{<\omega}$ be any word (without inverses) in $t, y, x$. Then, $\operatorname{val}(w)=y$ iff $w=t^{n} y x^{n}$ for some $n \in \mathbb{N}_{0}$.

Proof. By projecting $H_{3}(\mathbb{Z}) \rightarrow H_{3}(\mathbb{Z}) /\langle x, z\rangle \simeq \mathbb{Z}$ we see that $y$ appears only once in $w$. Using $[t, x]=1$ and $x^{ \pm 1} y=y x^{ \pm 1} z^{ \pm 1}$ we get:

$$
\operatorname{val}(w)=\left(t^{a} x^{b}\right) y\left(t^{c} x^{d}\right)=y x^{-a}(x z)^{b}\left(x^{-1} z\right)^{c} x^{d}=y x^{-a+b-c+d} z^{b+c}
$$

Where $a, b, c, d \geq 0$. For the value to be $y$, we must have $b=c=0, a=d$ as needed.
The existence of elements with the above property implies:
Theorem 2. If $A, B \leq G$ are f.g. submonoids, there is a f.g. submonoid $C \leq G \times H_{3}(\mathbb{Z})$ such that $A \cdot B$ is a section of $C$. Therefore, the membership problem in products of 2 submonoids of $G$ can be reduced to submonoid membership in $G \times H_{3}(\mathbb{Z})$.

For a proof see [Sha24b, Proposition 2].

### 2.2 Product of conjugate submonoids

We first need a technical lemma, about the existence of finite sequences in $H_{3}(\mathbb{Z}) /\left\langle z^{e}\right\rangle$, whose product has a unique value among all words in the sequence elements. We start with a simple claim about vectors with unique sum.

Proposition 3. Let $0<b_{1}<\ldots<b_{n}$ such that $b_{i}>i b_{i-1}$ for every $2 \leq i \leq n$, and let $v_{i}=\left(1, b_{i}\right) \in \mathbb{Z}^{2}$. If $\alpha_{i} \in \mathbb{N}_{0}$ satisfy $\sum_{i=1}^{n} \alpha_{i} v_{i}=\sum_{i=1}^{n} v_{i}$ then $\alpha_{1}=\alpha_{2}=\cdots=\alpha_{n}=1$.

Proof. We use induction on $n$. The first coordinate gives $\sum \alpha_{i}=n$. If $\alpha_{n}=0$ then $\sum \alpha_{i} b_{i} \leq n b_{n-1}<b_{n}<$ $\sum b_{i}$ so the second coordinate of $\sum_{i=1}^{n} \alpha_{i} v_{i}$ is smaller than that of $\sum_{i=1}^{n} v_{i}$. If $\alpha_{n} \geq 2$ then $\sum \alpha_{i} b_{i} \geq 2 b_{n}>b_{n}+$ $n b_{n-1}>\sum b_{i}$ and again the second coordinate doesn't match. Therefore $\alpha_{n}=1$ and $\sum_{i=1}^{n-1} \alpha_{i} v_{i}=\sum_{i=1}^{n-1} v_{i}$, and we can use induction.

Proposition 4. For any $n$, there is $e \in \mathbb{N}$ and $h_{1}, \ldots, h_{n} \in H_{3}(\mathbb{Z}) /\left\langle z^{e}\right\rangle$ such that the word $h_{1} h_{2} \ldots h_{n}$ has a unique value among all words in $\left\{h_{1}, . ., h_{n}\right\}$ (without inverses).

Proof. Let $h_{i}=x^{b_{i}} y \in H_{3}(\mathbb{Z})$ where $b_{i}>i b_{i-1}$ as above. Let $v=h_{1} \cdot h_{2} \cdots h_{n}$ and let $w$ be a word in $h_{1}, \ldots, h_{n}$ with value $v$. By applying Proposition 3 on the projection of $h_{i}$ to $H_{3}(\mathbb{Z}) /\langle z\rangle \simeq \mathbb{Z}^{2}$, where $\alpha_{i}$ is the number of appearances of $h_{i}$ in $w$, we get that each $h_{i}$ appears exactly once in $w$, so $w=h_{\sigma(1)} \ldots h_{\sigma(n)}$ for some permutation $\sigma \in S_{n}$. For any $i, j$ we have $\left[h_{i}, h_{j}\right]=\left[x^{b_{i}} y, x^{b_{j}} y\right]=z^{b_{i}-b_{j}}$ and $h_{i} h_{j}=h_{j} h_{i} z^{b_{i}-b_{j}}$. Assume that $\sigma \neq I d$. We take $h_{n}$ and swap it with the next element until it's at the end of $w$, adding a correction factor of $z^{b_{n}-b_{i}}$ in each swap, a positive power of $z$. Then swap $h_{n-1}$ with the next letter until $w$ ends with
$h_{n-1} h_{n}$, and so on. Eventually we get $\operatorname{val}(w)=v z^{f}$ where $0<f \leq \sum_{i<j}\left(b_{j}-b_{i}\right)$. The maximal value of $f$ is attained for $w=h_{n} \ldots h_{2} h_{1}$. It is now clear that the value $v$ is attained only by the word $h_{1} \ldots h_{n}$, and that this uniqueness is maintained in the quotient $H_{3}(\mathbb{Z}) /\left\langle z^{e}\right\rangle$ if we choose $e>\sum_{i<j}\left(b_{j}-b_{i}\right)$.

Geometrically, the exponent $f$ in $z^{f}=\left(h_{1} \cdots h_{n}\right)^{-1}\left(h_{\sigma(1)} \cdots h_{\sigma(n)}\right)$ equals the (signed) area between the paths $0 \rightarrow v_{1} \rightarrow v_{1}+v_{2} \rightarrow \cdots \sum v_{i}$ and $0 \rightarrow v_{\sigma(1)} \rightarrow v_{\sigma(1)}+v_{\sigma(2)} \rightarrow \cdots \sum v_{i}$. It is clear from the definition of $v_{i}$ that the former path lies below the latter for $\sigma \neq I d$ (with possible partial overlap).

Proposition 5. If $M \leq G$ is a f.g. submonoid, $g_{1}, . ., g_{n} \in G$, then $M g_{1} M g_{2} \cdots M g_{n} M$ is a section of $G \times H$ where $H=H_{3}(\mathbb{Z}) /\left\langle z^{e}\right\rangle$ for some $e \in \mathbb{N}$.

Proof. Let $S \subset G$ be a finite set generating $M$. Let $e \in N, h_{1}, \ldots, h_{n} \in H=H_{3}(\mathbb{Z}) /\left\langle z^{e}\right\rangle$ and $v=h_{1} \cdots h_{n}$ be as in Proposition 4. Define:

$$
T=S \times\left\{1_{H}\right\} \cup\left\{\left(g_{i}, h_{i}\right) \mid 1 \leq i \leq n\right\}
$$

If $(g, v) \in T^{*}$, then by Proposition 4 applied on last coordinate, the elements $\left(g_{i}, h_{i}\right)$ are each used once and in order (but can be far apart). In the first coordinate we get a product of the type $S^{*} g_{1} S^{*} \cdots g_{n} S^{*}$ as needed, and it is easy to see any such product is attainable.

We immediately get:
Theorem 6. Let $G$ be a f.g. group, $n \in \mathbb{N}$. The membership problem in products of $n$ conjugate f.g. submonoids of $G$ can be reduced to submonoid membership in $G \times H$ where $H=H_{3}(\mathbb{Z}) /\left\langle z^{e}\right\rangle$ for some e depending on $n$.

Proof. We have $g \in M^{g_{1}} M^{g_{2}} \cdots M^{g_{n}}$ iff $g_{1} g g_{n}^{-1} \in M g_{1} g_{2}^{-1} M g_{2} g_{3}^{-1} M \cdots g_{n-1} g_{n}^{-1} M$ iff $\left(g_{1} g g_{n}^{-1}, v\right) \in T^{*}$ for $T, v$ we get by applying Proposition 5 .

We give a simple example of an application of Theorem 6:
Corollary 7. The membership problem in products of conjugate f.g. submonoids in nilpotent groups $G$ with $h([G, G]) \leq 2$ is decidable, where $h(\cdot)$ is the Hirsch length.

Proof. We have to decide $g \in M^{g_{0}} M^{g_{1}} \cdots M^{g_{n}}$, and by Theorem 6 we can reduce this problem to submonoid membership in $K=G \times\left(H_{3}(\mathbb{Z}) /\left\langle z^{e}\right\rangle\right)$. Since $h([K, K])=h([G, G]) \leq 2$, submonoid membership is decidable in $K$ by [Sha24a].

The proof of [Sha24a] relies on a reduction [Bod24] from submonoid membership in a nilpotent f.g. group $G$ to membership in products of submonoids of a subgroup $H$ with $h([H, H])<h([G, G])$. It may seem artificial to pass through the larger group $G \times\left(H_{3}(\mathbb{Z}) /\left\langle z^{e}\right\rangle\right)$ before going to a subgroup, and indeed, it is straightforward to generalize Bodart's reduction to deal with products of conjugate submonoids directly. The use of sections is more natural for negative results, as we see next.

## 3 Arbitrary products of submonoids as sections

We now prove that every product of f.g. submonoids of a group $G$ is a section of a f.g. submonoid of $G \times H$, where $H \in \mathcal{N}_{2}$. We give 2 proofs. The first proof is with $H=H_{5}(\mathbb{Z}) \times\left(H_{3}(\mathbb{Z}) /\left\langle z^{e}\right\rangle\right)$. It relies on Theorem 6 , and is conceptually simpler. The second proof has $H=H_{5}(\mathbb{Z})$, so it is stronger, but it is a bit harder. Since $h([H, H])=1$ in both cases, both are enough for the main theorems in the next section.

### 3.1 First proof using conjugate submonoids

Theorem 8. Let $M_{1}, \ldots, M_{n}$ be f.g. submonoids of $G$. Then, there is a f.g. submonoid $M$ of $G \times H_{5}(\mathbb{Z})$ and elements $h_{1}, \ldots, h_{n} \in H_{5}(\mathbb{Z})$ such that $\left(M^{h_{1}} M^{h_{2}} \cdots M^{h_{n}}\right) \cap G=M_{1} \cdots M_{n}$.

Proof. We start with a simple geometric construction. Let $u_{i} \in \mathbb{Z}^{2}, 1 \leq i \leq n$, be the vertices of a convex polygon such that $\sum_{i} u_{i}=(0,0)$. Let $v_{i} \in \mathbb{Z}^{2}$ be such that the maximum value of $\left\langle x, v_{i}\right\rangle$ over the polygon is attained on the single point $x=u_{i}$. Geometrically, $v_{i}$ can be chosen perpendicular to any line whose intersection with the polygon is $\left\{u_{i}\right\}$. Define: $\boldsymbol{u}_{i}=\boldsymbol{x}^{u_{i}} z^{\left\langle u_{i}, v_{i}\right\rangle}, h_{i}=\left(1_{G}, \boldsymbol{y}^{-v_{i}}\right)$. Observe that

$$
\boldsymbol{u}_{i}^{\boldsymbol{y}^{-v_{j}}}=\boldsymbol{x}^{u_{i}} z^{\left\langle u_{i}, v_{i}\right\rangle}\left[\boldsymbol{x}^{u_{i}}, \boldsymbol{y}^{-v_{j}}\right]=\boldsymbol{x}^{u_{i}} z^{\left\langle u_{i}, v_{i}\right\rangle-\left\langle u_{i}, v_{j}\right\rangle}
$$

By choice of $v_{i}$, we have $\left\langle u_{i}, v_{i}\right\rangle \geq\left\langle u_{i}, v_{j}\right\rangle$ with equality iff $i=j$, and therefore the exponent of $z$ is nonnegative, and 0 iff $i=j$.

Let $S_{i}$ be a finite generating set for $M_{i}$, where WLOG $1_{G} \in S_{i}$. Define $T=\bigcup_{i} S_{i} \times\left\{\boldsymbol{u}_{i}\right\}$ and $M=T^{*}$. We claim that $\left(M^{h_{1}} M^{h_{2}} \cdots M^{h_{n}}\right) \cap G=M_{1} \cdots M_{n}$. For one side, let $g_{i} \in M_{i}$, we need to show $\left(g_{1} \cdots g_{n}, 1\right) \in M$. We can express $g_{i}=s_{i, 1} s_{i, 2} \cdots s_{i, l_{i}}$ where $l_{i} \in \mathbb{N}, s_{i, j} \in S_{i}$. Set $l=\max _{i} l_{i}$. Since $1_{G} \in S_{i}$, we may assume $l=l_{1} \cdots=l_{n}$ by padding the shorter sequences with $1_{G}$. We have $\left(s_{i, j}, \boldsymbol{u}_{i}\right)^{h_{i}}=\left(s_{i, j}, \boldsymbol{x}^{u_{i}}\right) \in T^{h_{i}}$, and by taking product over $j$ we get $\left(g_{i}, \boldsymbol{x}^{l u_{i}}\right) \in M^{h_{i}}$. By taking product now over $i$ we get

$$
\left(g_{1} \cdots g_{n}, \boldsymbol{x}^{l u_{1}} \cdots \boldsymbol{x}^{l u_{n}}\right) \in M^{h_{1}} \cdots M^{h_{n}}
$$

but the second coordinate is $\boldsymbol{x}^{l u_{1}} \cdots \boldsymbol{x}^{l u_{n}}=\boldsymbol{x}^{l \sum u_{i}}=1$ since $\sum_{i} u_{i}=(0,0)$. Conversely, assume $(g, 1) \in$ $M^{h_{1}} M^{h_{2}} \cdots M^{h_{n}}$. We note that in the second coordinate we have values of type $\boldsymbol{u}_{i}^{y^{-v_{j}}}=\boldsymbol{x}^{u_{i}} z^{e}$ where $e \geq 0$ always holds, and $e=0$ iff $i=j$. Now, $\left\langle x_{1}, x_{2}, z\right\rangle \simeq \mathbb{Z}^{3}$, and for the product to be the identity, we must always have $e=0$ in the exponent of $z$, meaning the from each $M^{h_{i}}$ only $S_{i} \times\left\{\boldsymbol{u}_{i}\right\}$ is used. This implies that in the first coordinate $S_{i}$ are used in order, so $g \in M_{1} \cdots M_{n}$.

A natural choice can be $u_{k}=v_{k} \simeq(N \cos (2 \pi k / n), N \sin (2 \pi k / n))$ for a large $N$ while making sure $\sum u_{k}=$ $(0,0)$. We may also relax the requirement $\sum u_{k}=(0,0)$ and only require that $(0,0)$ is in the interior of the polygon, which implies $\sum \alpha_{i} u_{i}=0$ for some $\alpha_{i} \in \mathbb{N}_{+}$, and then the proof works by padding $g_{i, j}$ so that $l_{i}=c \alpha_{i}$ for some $c$. We can visualise $\left\langle x_{1}, x_{2}, z\right\rangle=\left\{\boldsymbol{x}^{u} z^{e} \mid u \in \mathbb{Z}^{2}, e \in \mathbb{Z}\right\} \simeq \mathbb{Z}^{3}$ as 3 dimensional space, where $e$ is the height, and $e=0$ is the floor. The vectors $\boldsymbol{u}_{i}$ can then be seen as an inverted pyramid standing on its vertex (or as the lower part of a spinning dreidel), and each conjugation tilts the pyramid so that a single edge touches the ground (this "tilt" is linear but not orthogonal). For the sum of such conjugated vectors to be $(0,0)$ they must all touch the ground, so in each conjugate $M^{h_{i}}$ only one edge is active, allowing the use of $S_{i}$. We now easily get:

Theorem 9. Any product of f.g. submonoids of $G$ is a section of a submonoid of $G \times H_{5}(\mathbb{Z}) \times\left(H_{3}(\mathbb{Z}) /\left\langle z^{e}\right\rangle\right)$
Proof. Given such product $M_{1} \cdots M_{n}$ in $G$, by Theorem 8 there is a f.g. submonoid $M \leq G \times H_{5}(\mathbb{Z})$ and $h_{1}, \ldots, h_{n} \in H_{5}(\mathbb{Z})$ such that $M^{h_{1}} \cdots M^{h_{n}} \cap G=M$. We get that for every $g \in G, g \in M_{1} \cdots M_{n}$ iff $\left(g, h_{1} h_{n}^{-1}\right) \in A \doteqdot M h_{1} h_{2}^{-1} M \cdots h_{n-1} h_{n}^{-1} M$, and therefore $M_{1} \cdots M_{n}=\left.A\right|_{h_{1} h_{n}^{-1}}$. By Proposition 5, there is a f.g. submonoid $N \leq G \times H_{5}(\mathbb{Z}) \times\left(H_{3}(\mathbb{Z}) /\left\langle z^{e}\right\rangle\right)$ and $v \in H_{3}(\mathbb{Z}) /\left\langle z^{e}\right\rangle$ such that $\left.N\right|_{v}=A$, and together we get $\left.N\right|_{\left(h_{1} h_{n}^{-1}, v\right)}=M_{1} \cdots M_{n}$ as needed.

### 3.2 The second proof

In this proof, instead of going first to a product of conjugate subsubmonoids and then to a submonoid, we unite both steps, giving a more efficient result. First we need a geometric construction.

Proposition 10. For any $n$, there are vectors $u_{1}, \ldots u_{n}, v_{1}, \ldots, v_{n-1} \in \mathbb{Z}^{2}$ with the following properties:

1. $\left\langle u_{i}, v_{j}\right\rangle<0$ when $i \leq j$, and $\left\langle u_{i}, v_{j}\right\rangle>0$ when $i>j$
2. If $\alpha_{1}, \ldots, \alpha_{n-1} \in \mathbb{N}_{0}$ satisfy $\sum_{j=1}^{n-1} \alpha_{j} v_{j}=\sum_{j=1}^{n-1} v_{j}$, then $\alpha_{1}=\alpha_{2}=\ldots=\alpha_{n-1}=1$.
3. $\sum_{i=1}^{n} u_{i}=(0,0)$

A useful reformulation of item 1 is: If $u_{i}$ appears before $v_{j}$ in the word $u_{1} v_{1} u_{2} v_{2} \ldots v_{n-1} u_{n}$, then $\left\langle u_{i}, v_{j}\right\rangle<0$, otherwise $\left\langle u_{i}, v_{j}\right\rangle>0$.

Proof. Choose $0<a_{1}<b_{1}<a_{2}<b_{2}<\ldots<b_{n-1}<a_{n}$ such that $b_{i}>i b_{i-1}$ for every $i$, and define $v_{j}=\left(1, b_{j}\right)$ for $1 \leq j \leq n-1, u_{i}=\left(a_{i},-1\right)$ for $1<i<n$, and finally $u_{1}=\left(-\sum a_{i}, 0\right)$, and $u_{n}=(0, n-2)$. Item 2 is satisfied by Proposition 3, item 3 is satisfied by the choice of $u_{1}, u_{n}$, and item 1 can be checked directly.

It may be easier to understand the conditions of Proposition 10 by rotating $u_{i}$ by $\pi / 2$ (so $\left(a_{i},-1\right) \mapsto\left(1, a_{i}\right)$ in the specific vectors chosen in the proof). Then, instead of the inner product $\left\langle u_{i}, v_{j}\right\rangle$ we would get the orientation of $u_{i}, v_{j}$, i.e. the sign of the determinant of $\left(u_{i} ; v_{j}\right)$. This implies that scanning the vectors counterclockwise from $u_{1}$ we would see them in order $u_{1} v_{1} u_{2} v_{2} \ldots v_{n-1} u_{n}$. In addition, item 2 can be shown to imply that $v_{j}$ are all in the same half-plane, while item 3 implies that $u_{i}$ are not all on the same half-plane. This implies that the orientation of each 2 vectors of $u_{1} v_{1} u_{2} v_{2} \ldots v_{n-1} u_{n}$ conforms with their order in the word, except $u_{1} u_{n}$ which have the opposite orientation, so the angle between them in the scan must exceed $\pi$ (it is $3 \pi / 2$ for the chosen vectors).

Proposition 11. For any $n$ there are elements $\boldsymbol{u}_{1}, . ., \boldsymbol{u}_{n}, \boldsymbol{v}_{1}, . ., \boldsymbol{v}_{n-1} \in H_{5}(\mathbb{Z})$ with the following properties:

1. $\boldsymbol{u}_{1}^{l} \boldsymbol{v}_{1} \boldsymbol{u}_{2}^{l} \boldsymbol{v}_{2} \cdots \boldsymbol{v}_{n-1} \boldsymbol{u}_{n}^{l}=\boldsymbol{v}_{1} \cdots \boldsymbol{v}_{n-1}$ for any $l \in \mathbb{N}$
2. In any word $w$ without inverses in $\boldsymbol{u}_{1}, . ., \boldsymbol{u}_{n}, \boldsymbol{v}_{1}, . ., \boldsymbol{v}_{n-1}$ with value $\boldsymbol{v}_{1} \cdots \boldsymbol{v}_{n-1}$, the $\boldsymbol{u}_{i}$ 's appear in order: the last $\boldsymbol{u}_{i}$ is located before the first $\boldsymbol{u}_{i+1}$ for every $i$.

Proof. Let $u_{1}, u_{2}, \ldots u_{n}, v_{1}, . ., v_{n-1}$ be as in proposition 10, and define $e_{i j}=\left\langle u_{i}, v_{j}\right\rangle$. Define $\boldsymbol{u}_{i}=\boldsymbol{x}^{u_{i}} z^{\sum_{i>j} e_{i j}}$ and $\boldsymbol{v}_{i}=\boldsymbol{y}^{v_{i}}$. We first show:

$$
\begin{equation*}
\boldsymbol{u}_{1}^{l} \boldsymbol{v}_{1} \boldsymbol{u}_{2}^{l} \boldsymbol{v}_{2} \ldots \boldsymbol{v}_{n-1} \boldsymbol{u}_{n}^{l}=\boldsymbol{v}_{1} \boldsymbol{v}_{2} \ldots \boldsymbol{v}_{n-1} \tag{1}
\end{equation*}
$$

To see why Equation (1) holds, we swap each $\boldsymbol{u}_{i}$ left to the beginning of the word. We have $\boldsymbol{v}_{j} \boldsymbol{u}_{i}=$ $\boldsymbol{u}_{i} \boldsymbol{v}_{j} z^{-e_{i j}}$ and $\left[\boldsymbol{u}_{i}, \boldsymbol{u}_{j}\right]=1$, so during the entire journey to the beginning of the word, a factor of $z^{-\sum_{j<i} e_{i j}}$ is added for each $\boldsymbol{u}_{i}$. This cancels out the $z$ power in $\boldsymbol{u}_{i}=\boldsymbol{x}^{u_{i}} z^{\sum_{j<i} e_{i j}}$, and we are left with $\boldsymbol{x}^{l u_{1}} \cdots \boldsymbol{x}^{l u_{n}} \boldsymbol{v}_{1} \cdots \boldsymbol{v}_{n-1}$. But we have $\boldsymbol{x}^{l u_{1}} \cdots \boldsymbol{x}^{l u_{n}}=\boldsymbol{x}^{l \sum_{i} u_{i}}=\boldsymbol{x}^{(0,0)}=1$ by item 3 . Conversely, assume $w$ is a word in $\boldsymbol{u}_{1}, . ., \boldsymbol{u}_{n}, \boldsymbol{v}_{1}, . ., \boldsymbol{v}_{n-1}$ with value $\boldsymbol{v}_{1} \cdots \boldsymbol{v}_{n-1}$. By applying Proposition 3 to the projection of $w$ to $H_{5}(\mathbb{Z}) /\left\langle x_{1}, x_{2}, z\right\rangle \simeq \mathbb{Z}^{2}$, we get that each $\boldsymbol{v}_{j}$ appears exactly once, not necessarily in order. We now swap each $\boldsymbol{u}_{i}$ to the beginning of $w$, just like before. Since each $\boldsymbol{v}_{j}$ appears once in $w$, this contributes $z^{-\sum_{j \in J} e_{i j}}$ where $J$ is the set of indices of $\boldsymbol{v}_{j}$ that appear before the $\boldsymbol{u}_{i}$ we are swapping. Now, by item 1 we have $\sum_{j \in J} e_{i j} \leq \sum_{j<i} e_{i j}$, and equality holds iff $J=\{1, \ldots, i-1\}$. Therefore after moving $\boldsymbol{u}_{i}=\boldsymbol{x}^{u_{i}} z^{\sum_{i>j} e_{i j}}$ to the beginning of the word, we are left with $\boldsymbol{x}^{u_{i}} z^{e}$ where $e=\sum_{j<i} e_{i j}-\sum_{j \in J} e_{i j} \geq 0$, and $e=0$ iff $\boldsymbol{u}_{i}$ appears after $\boldsymbol{v}_{1}, \ldots, \boldsymbol{v}_{i-1}$ but before $\boldsymbol{v}_{i}, \ldots, \boldsymbol{v}_{n-1}$. After moving all $\boldsymbol{u}_{i}$ for every $i$ to the beginning, we get a word of the form $\boldsymbol{x}^{u} \boldsymbol{y}^{v} z^{e}$ for some $u, v \in \mathbb{Z}^{2}, e \geq 0$. Since elements of $H_{5}(\mathbb{Z})$ have a unique such form, and since the value of $w$ is assumed to be $\boldsymbol{y}^{\sum_{j} v_{j}}$, we get that $e=0$, and therefore each $\boldsymbol{u}_{i}$ appears after $\boldsymbol{v}_{1}, \ldots, \boldsymbol{v}_{i-1}$ but before $\boldsymbol{v}_{i}, \ldots, \boldsymbol{v}_{n-1}$. In particular, each $\boldsymbol{u}_{i}$ appears before the single occurrence of $\boldsymbol{v}_{i}$, and each $\boldsymbol{u}_{i+1}$ appears after it, so the $\boldsymbol{u}_{i}$ appear in order, as required.

Now we are ready for the main theorem.
Theorem 12. Let $M_{1}, \ldots, M_{n}$ be f.g. submonoids of any group $G$. Then, the product $M_{1} \cdots M_{n}$ is a section of some f.g. submonoid of $G \times H_{5}(\mathbb{Z})$.

Proof. Let $S_{i} \subseteq G$ be finite sets generating $M_{i}$, WLOG $1_{G} \in S_{i}$ for every $i$. Let $\boldsymbol{u}_{i}, \boldsymbol{v}_{j}$ be as in Proposition 11, and define:

$$
T=\bigcup_{i \leq n}\left(S_{i} \times\left\{\boldsymbol{u}_{i}\right\}\right) \cup\left\{\left(1_{G}, \boldsymbol{v}_{j}\right) \mid j<n\right\}
$$

and set $h=\boldsymbol{v}_{1} \cdots \boldsymbol{v}_{n-1}$. We claim that $\left.T^{*}\right|_{h}=M_{1} \cdots M_{n}$. For one side, let $g_{i} \in M_{i}$, we need to show $\left(g_{1} \cdots g_{n}, h\right) \in T^{*}$. We can express $g_{i}=s_{i, 1} s_{i, 2} \cdots s_{i, l_{i}}$ where $l_{i} \in \mathbb{N}, s_{i, j} \in S_{i}$. By padding with $1_{G} \in S_{i}$ we may assume $l=l_{1} \cdots=l_{n}$. Since $\left(s_{i, j}, \boldsymbol{u}_{i}\right) \in T$ we get $\left(g_{i}, \boldsymbol{u}_{i}^{l}\right) \in T^{*}$. Therefore:

$$
\left(g_{1}, \boldsymbol{u}_{1}^{l}\right)\left(1_{G}, \boldsymbol{v}_{1}\right)\left(g_{2}, \boldsymbol{u}_{2}^{l}\right)\left(1_{G}, \boldsymbol{v}_{2}\right) \cdots\left(g_{n}, \boldsymbol{u}_{n}^{l}\right)=\left(g_{1} \cdots g_{n}, \boldsymbol{u}_{1}^{l} \boldsymbol{v}_{1} \cdots \boldsymbol{v}_{n-1} \boldsymbol{u}_{n}^{l}\right)=\left(g_{1} \cdots g_{n}, h\right) \in T^{*}
$$

Where we used Proposition 11. Conversely, assume $(g, h)=t_{1} \cdots t_{l} \in T^{*}$. Looking at the second coordinate of $t_{i}$, we get by Proposition 11 that the $\boldsymbol{u}_{i}$ appear in order, which implies that the in the first coordinate the elements of $S_{i}$ appear in order, so $g \in S_{1}{ }^{*} \cdots S_{n}{ }^{*}=M_{1} \cdots M_{n}$ as needed.

## 4 Decidability

Theorem 13. Let $G$ be any f.g. group.

1. Membership in a fixed product $M_{1} \cdots M_{n}$ of f.g. submonoids of $G$ can be reduced to membership in a fixed submonoid of $G \times H_{5}(\mathbb{Z})$
2. Membership in all finite products of f.g. submonoids of $G$ can be reduced to the uniform submonoid membership problem in $G \times H_{5}(\mathbb{Z})$

The proof is immediate from Theorem 12. We get a new, simple proof of a theorem of Romankov [Rom23]:
Theorem 14. There is a group $G \in \mathcal{N}_{2}$ and a fixed f.g. submonoid $M \leq G$, such that membership in $M$ is undecidable.

Proof. From [KLZ16], there is a group $G \in \mathcal{N}_{2}$ with 4 subgroups $A_{1}, \ldots, A_{4}$ such that membership in $A_{1} \cdots A_{4}$ is undecidable. By Theorem 13 we are done.

We also get the following interesting converse to a reduction of Bodart [Bod24]:
Theorem 15. Let $k \geq 1$. The following problems are Turing equivalent:

1. The submonoid membership problem, uniformly for all $G \in \mathcal{N}_{2}$ with $h([G, G])=k$.
2. Deciding membership in products of submonoids, uniformly for all $G \in \mathcal{N}_{2}$ with $h([G, G])=k-1$.

Proof. One side is given by $[\operatorname{Bod} 24]$, and for the other side, we note that if $h([G, G])=k-1$ and $K=G \times H_{5}(\mathbb{Z})$ then $h([K, K])=h([G, G])+1=k$.
