# REGULARITY OF THE SEMIGROUP OF TRANSFORMATIONS PRESERVING A LENGTH

#### Abstract

Let $X_{n}=\{1,2, \ldots, n\}$ be a finite set $(n \geq 2)$ and $T_{n}$ the full transformation semigroup on $X_{n}$. For a positive integer $l \leq n-1$, we define $$
T_{n}(l)=\left\{\alpha \in T_{n}: \forall x, y \in X_{n},|x-y|=l \Rightarrow|x \alpha-y \alpha|=l\right\}
$$ and $$
T_{n}^{*}(l)=\left\{\alpha \in T_{n}: \forall x, y \in X_{n},|x-y|=l \Leftrightarrow|x \alpha-y \alpha|=l\right\} .
$$

Then $T_{n}(l)$ and $T_{n}^{*}(l)$ are subsemigroups of $T_{n}$. In this paper, we give a necessary and sufficient condition for $T_{n}(l)$ to be regular. Moreover, we prove that $T_{n}^{*}(l)$ is a regular semigroup.

## 1 Introduction and Preliminaries

Regularity has played an important role in the development of semigroup theory. For a concept of regularity and transformation semigroups, we refer the reader to [2].

The full transformation semigroup is the collection of functions from a set $X$ into $X$ with composition, which is denoted by $T(X)$. It is well-known that $T(X)$ is a regular semigroup with identity element $\mathrm{id}_{X}$, the identity function on $X$ (see [3]). The regularity of various subsemigroups of $T(X)$ have been studied over a long period (see, for example [1, 15, 7, 8, 9, 10, 11, 12]).

For $x \in X$ and $\alpha \in T(X)$, the image of $x$ under $\alpha$ is written as $x \alpha$. By the corresponding notation, we will compose functions from left to right: $x(\alpha \beta)=(x \alpha) \beta$. For a non-empty subset $A$ of $X$, the image of a subset $A$ of $X$ under $\alpha$ is denoted by $A \alpha$. If $A=X$, then $X \alpha$ is the range (image) of $\alpha$. We denote by $x \alpha^{-1}$ the set of all inverse images of $x$ under $\alpha$, that is, $x \alpha^{-1}=\{z \in X: z \alpha=x\}$. Here, $|A|$ denotes the cardinality of a set $A$.

Throughout the paper, we let $X_{n}=\{1,2, \ldots, n\}(n \geq 2)$ and $l$ an integer such that $1 \leq l \leq n-1$. We write $T_{n}$ instead of $T\left(X_{n}\right)$. Define

$$
T_{n}(l)=\left\{\alpha \in T_{n}: \forall x, y \in X_{n},|x-y|=l \Rightarrow|x \alpha-y \alpha|=l\right\}
$$

and

$$
T_{n}^{*}(l)=\left\{\alpha \in T_{n}: \forall x, y \in X_{n},|x-y|=l \Leftrightarrow|x \alpha-y \alpha|=l\right\}
$$

where $|x-y|$ is the absolute difference of numbers $x$ and $y$. Obviously, $\mathrm{id}_{X_{n}} \in T_{n}^{*}(l)$ and $T_{n}^{*}(l) \subseteq T_{n}(l)$. Note that if $\alpha \in T_{n}(l)$, then we say that $\alpha$ preserves the length $l$. Let $\alpha, \beta \in T_{n}(l)$ and $x, y \in X_{n}$ such that $|x-y|=l$. Then $|x \alpha-y \alpha|=l$. Since $x \alpha, y \alpha \in X_{n}$ and $\beta$ preserves the length $l$, we obtain $|(x \alpha) \beta-(y \alpha) \beta|=l$. Hence $\alpha \beta \in T_{n}(l)$ and so $T_{n}(l)$ is a subsemigroup of $T_{n}$. We call $T_{n}(l)$ the semigroup of transformations preserving a length $l$. Similarly, if $\alpha, \beta \in T_{n}^{*}(l)$, we can show that

$$
|x(\alpha \beta)-y(\alpha \beta)|=l \Leftrightarrow|(x \alpha) \beta-(y \alpha) \beta|=l \Leftrightarrow|x \alpha-y \alpha|=l \Leftrightarrow|x-y|=l .
$$

Hence $\alpha \beta \in T_{n}^{*}(l)$ and so $T_{n}^{*}(l)$ is a subsemigroup of $T_{n}$. It is also clear that $T_{n}^{*}(l)$ is a subsemigroup of $T_{n}(l)$.

Here, in Section we present the new transformation semigroups $T_{n}(l)$ and $T_{n}^{*}(l)$. Moreover, we also introduce basic results for the semigroups $T_{n}(l)$ and $T_{n}^{*}(l)$. In Sections 2 and 3, we give a necessary and sufficient condition for $T_{n}(l)$ to be regular. Finally, in Section [4, we prove that $T_{n}^{*}(l)$ is a regular semigroup.

As in Clifford and Preston [2, page 2], if $a_{1}, a_{2}, \ldots, a_{n} \in X_{n}$ (not necessarily distinct), we shall use the notation

$$
\alpha=\left(\begin{array}{cccc}
1 & 2 & \cdots & n \\
a_{1} & a_{2} & \cdots & a_{n}
\end{array}\right)
$$

to mean $\alpha \in T_{n}$ defined by $i \alpha=a_{i}$ for all $i=1,2, \ldots, n$.
The following remark will be useful in the paper.
Remark 1.1. The following hold:

1. If ( $n \geq 3$ is odd and $l \geq \frac{n+1}{2}$ ) or ( $n \geq 4$ is even and $l>\frac{n}{2}$ ), then $n-l<l$. For each $x \in\{1,2, \ldots, n-l\}$, there exists unique $y=x+l \in X_{n}$ such that $|x-y|=l$. On the other hand, for each $x \in\{l+1, l+2, \ldots, n\}$, there exists unique $y=x-l \in X_{n}$ such that $|x-y|=l$. Moreover, $|x-y| \neq l$ for all $x \in\{(n-l)+1,(n-l)+2, \ldots, l\}$ and all $y \in X_{n}$. Indeed, for $1 \leq k \leq 2 l-n$, if $|[(n-l)+k]-y|=l$ for some $y \in X_{n}$, we get that $[(n-l)+k]-y=l$ or $[(n-l)+k]-y=-l$. In the former, we obtain $n-2 l+k=y>0$, which implies that $k>2 l-n$, a contradiction. In the latter, we have $y=n+k \notin X_{n}$. So in this case, we can write

$$
X_{n}=\{1,2, \ldots, n-l,(n-l)+1, \ldots, l-1, l, l+1, l+2, \ldots, n\}
$$

or

$$
X_{n}=\{1, l+1\} \cup\{2, l+2\} \cup \cdots \cup\{n-l, n\} \cup\{(n-l)+1,(n-l)+2, \ldots, l-1, l\} .
$$

2. If ( $n \geq 3$ is odd and $l<\frac{n+1}{2}$ ) or ( $n \geq 4$ is even and $l \leq \frac{n}{2}$ ), then $2 l \leq n$. So, we can write

$$
X_{n}=\{1,2, \ldots, l, l+1, l+2, \ldots, 2 l, 2 l+1,2 l+2, \ldots, 3 l, 3 l+1,3 l+2, \ldots, n\}
$$

or

$$
\begin{aligned}
X_{n}= & \left\{1,1+l, 1+2 l, \ldots, 1+m_{1} l\right\} \cup\left\{2,2+l, 2+2 l, \ldots, 2+m_{2} l\right\} \cup \cdots \cup \\
& \left\{l, 2 l, 3 l, \ldots,\left(1+m_{l}\right) l\right\}
\end{aligned}
$$

where $m_{i} \geq 1$ is the maximum integer such that $i+m_{i} l \leq n$ for all $i=1,2, \ldots, l$. It is clear that for each $x \in X_{n}$, there exists $y \in X_{n}$ such that $|x-y|=l$.

Proposition 1.1. $T_{n}(l)$ is never equal to $T_{n}$.
Proof. Let $\kappa \in T_{n}$ be the constant function with range $\{1\}$. Then $\kappa \notin T_{n}(l)$ since $|1-(l+1)|=l$ but $|1 \kappa-(l+1) \kappa|=|1-1|=0 \neq l$. Hence, $T_{n}(l) \neq T_{n}$.

Proposition 1.2. $T_{n}(l)=T_{n}^{*}(l)$ if and only if $n=2$ or $(n=3$ and $l=1)$.
Proof. If $n=2$, then $l=1$ and

$$
T_{2}(1)=\left\{\left(\begin{array}{ll}
1 & 2 \\
1 & 2
\end{array}\right),\left(\begin{array}{ll}
1 & 2 \\
2 & 1
\end{array}\right)\right\}=T_{2}^{*}(1) .
$$

If $n=3$ and $l=1$, then

$$
\begin{aligned}
T_{3}(1) & =\left\{\left(\begin{array}{lll}
1 & 2 & 3 \\
1 & 2 & 1
\end{array}\right),\left(\begin{array}{lll}
1 & 2 & 3 \\
1 & 2 & 3
\end{array}\right),\left(\begin{array}{lll}
1 & 2 & 3 \\
2 & 1 & 2
\end{array}\right),\left(\begin{array}{lll}
1 & 2 & 3 \\
2 & 3 & 2
\end{array}\right),\left(\begin{array}{lll}
1 & 2 & 3 \\
3 & 2 & 1
\end{array}\right),\left(\begin{array}{lll}
1 & 2 & 3 \\
3 & 2 & 3
\end{array}\right)\right\} \\
& =T_{3}^{*}(1) .
\end{aligned}
$$

Conversely, assume $n \geq 4$ or ( $n=3$ and $l=2$ ). We show $T_{n}(l) \neq T_{n}^{*}(l)$. Let $\alpha=$ $\left(\begin{array}{lll}1 & 2 & 3 \\ 1 & 1 & 3\end{array}\right)$. Then $\alpha \in T_{3}(2) \backslash T_{3}^{*}(2)$, since $|2 \alpha-3 \alpha|=|1-3|=2$ but $|2-3|=1 \neq 2$. Thus, $T_{3}(2) \neq T_{3}^{*}(2)$. Now, suppose that $n \geq 4$. We consider four cases: (i) $n$ is even and $l>\frac{n}{2}$; (ii) $n$ is odd and $l \geq \frac{n+1}{2}$; (iii) $n$ is even and $l \leq \frac{n}{2}$; (iv) $n$ is odd and $l<\frac{n+1}{2}$. Cases (i) \& (ii). Using Remark 1.1(1), we define $\alpha \in T_{n}(l)$ by

$$
\alpha=\left(\begin{array}{cccccccccccc}
1 & l+1 & 2 & l+2 & \cdots & n-l & n & (n-l)+1 & (n-l)+2 & \cdots & l-1 & l \\
1 & l+1 & 1 & l+1 & \cdots & 1 & l+1 & 1 & 1 & \cdots & 1 & 1
\end{array}\right) .
$$

We see that $|l \alpha-(l+1) \alpha|=|1-(l+1)|=l$ while $|l-(l+1)|=1 \neq l\left(\right.$ since $\left.l>\frac{n}{2} \geq 2\right)$.
Hence $\alpha \notin T_{n}^{*}(l)$.
Cases (iii) \& (iv). Using Remark 1.1(2), we can define $\alpha \in T_{n}(1)$ by

$$
\alpha=\left(\begin{array}{cccccc}
1 & 2 & 3 & 4 & \cdots & n \\
1 & 2 & 1 & 2 & \cdots & n \alpha
\end{array}\right)
$$

where $\quad n \alpha= \begin{cases}1 & \text { if } n \text { is odd, } \\ 2 & \text { if } n \text { is even. }\end{cases}$
Since $|1 \alpha-4 \alpha|=|1-2|=1$ but $|1-4|=3 \neq 1$, thus $\alpha \notin T_{n}^{*}(l)$. For $l \geq 2$, we define $\alpha \in T_{n}(l)$ by

$$
\alpha=\left(\begin{array}{ccccccccccccccc}
1 & \cdots & l & l+1 & \cdots & 2 l & 2 l+1 & \cdots & 3 l & 3 l+1 & \cdots & 4 l & 4 l+1 & \cdots & n \\
1 & \cdots & 1 & l+1 & \cdots & l+1 & 1 & \cdots & 1 & l+1 & \cdots & l+1 & 1 & \cdots & n \alpha
\end{array}\right)
$$

where

$$
n \alpha= \begin{cases}1 & \text { if } n \in\{k l+t: k \geq 2 \text { is even and } 1 \leq t \leq l\}, \\ l+1 & \text { if } n \in\{k l+t: k \geq 3 \text { is odd and } 1 \leq t \leq l\}\end{cases}
$$

It is easy to see that $|2 \alpha-(l+1) \alpha|=|1-(l+1)|=l$ such that $|2-(l+1)|=|1-l| \neq l$. Hence $\alpha \notin T_{n}^{*}(l)$. Therefore, $T_{n}(l) \neq T_{n}^{*}(l)$.

## 2 Regularity of $T_{n}(1)$

We would like to acknowledge the use of GAP [4, a system for computational discrete algebra with the MONOID package.

Remark 2.1. Recall that the subsemigroup generated by $A$ denoted by $\langle A\rangle$. Using the commands gapi Semigroup(); and gapi IsRegularSemigroup(); of GAP, we have the following facts.
(1) $T_{2}(1)=\left\langle\left(\begin{array}{ll}1 & 2 \\ 2 & 1\end{array}\right)\right\rangle$ is regular,
(2) $T_{3}(1)=\left\langle\left(\begin{array}{lll}1 & 2 & 3 \\ 2 & 1 & 2\end{array}\right),\left(\begin{array}{lll}1 & 2 & 3 \\ 3 & 2 & 1\end{array}\right)\right\rangle$ is regular,
(3) $T_{4}(1)=\left\langle\left(\begin{array}{llll}1 & 2 & 3 & 4 \\ 2 & 3 & 2 & 1\end{array}\right),\left(\begin{array}{llll}1 & 2 & 3 & 4 \\ 3 & 4 & 3 & 2\end{array}\right),\left(\begin{array}{llll}1 & 2 & 3 & 4 \\ 4 & 3 & 2 & 1\end{array}\right)\right\rangle$ is regular,
(4) $T_{5}(1)=\left\langle\left(\begin{array}{lllll}1 & 2 & 3 & 4 & 5 \\ 2 & 3 & 4 & 5 & 4\end{array}\right),\left(\begin{array}{lllll}1 & 2 & 3 & 4 & 5 \\ 3 & 2 & 1 & 2 & 3\end{array}\right),\left(\begin{array}{lllll}1 & 2 & 3 & 4 & 5 \\ 4 & 3 & 2 & 1 & 2\end{array}\right),\left(\begin{array}{lllll}1 & 2 & 3 & 4 & 5 \\ 5 & 4 & 3 & 2 & 1\end{array}\right)\right\rangle$ is regular.

Theorem 2.1. $T_{n}(1)$ is a regular semigroup if and only if $n \in\{2,3,4,5\}$.
Proof. By Remark [2.1, we have $T_{n}(1)$ is a regular semigroup when $n \in\{2,3,4,5\}$.
Conversely, let $n \geq 6$ and assume that $T_{n}(1)$ is regular. There are four cases to consider.
Case 1. Suppose that $n \in\{6,10,14,18, \ldots\}$. Then $\left|\left\{1,2,3, \ldots, \frac{n}{2}\right\}\right|=\mid\{n, n-1, \ldots$, $\left.\frac{n}{2}+1\right\} \left\lvert\,=\frac{n}{2}\right.$ is odd. Define

$$
\alpha=\left(\begin{array}{ccccccccccccc}
1 & 2 & \cdots & \frac{n}{2}-1 & \frac{n}{2} & \frac{n}{2}+1 & \frac{n}{2}+2 & \frac{n}{2}+3 & \frac{n}{2}+4 & \cdots & n-2 & n-1 & n \\
n & n-1 & \cdots & \frac{n}{2}+2 & \frac{n}{2}+1 & \frac{n}{2}+2 & \frac{n}{2}+1 & \frac{n}{2}+2 & \frac{n}{2}+1 & \cdots & \frac{n}{2}+2 & \frac{n}{2}+1 & \frac{n}{2}
\end{array}\right) .
$$

It is easy to check that $\alpha \in T_{n}(1)$. Since $T_{n}(1)$ is regular, there exists $\beta \in T_{n}(1)$ such that $\alpha=\alpha \beta \alpha$. We have $\frac{n}{2}=n \alpha=(n \alpha \beta) \alpha=\left(\frac{n}{2} \beta\right) \alpha$. Then we obtain $\left(\frac{n}{2}\right) \beta=n$ and it follows that $\left(\frac{n}{2}+1\right) \beta=n-1$. Since $\frac{n}{2}+2=\left(\frac{n}{2}+1\right) \alpha=\left(\left(\frac{n}{2}+1\right) \alpha \beta\right) \alpha=\left(\left(\frac{n}{2}+2\right) \beta\right) \alpha$, we get $\left(\frac{n}{2}+2\right) \beta \in\left\{\frac{n}{2}-1, \frac{n}{2}+1, \frac{n}{2}+3, \ldots, n-2\right\}$. We see that $\left(\frac{n}{2}+2\right) \beta \in\{n, n-2\}$, so $\left(\frac{n}{2}+2\right) \beta=n-2$. Next, we consider $\frac{n}{2}+3=\left(\frac{n}{2}-2\right) \alpha=\left(\left(\frac{n}{2}-2\right) \alpha \beta\right) \alpha=\left(\left(\frac{n}{2}+3\right) \beta\right) \alpha$. Thus $\left(\frac{n}{2}+3\right) \beta=\frac{n}{2}-2$. Since $\left|\left(\frac{n}{2}+3\right)-\left(\frac{n}{2}+2\right)\right|=1$ but $\left|\left(\frac{n}{2}+3\right) \beta-\left(\frac{n}{2}+2\right) \beta\right|=$ $\left|\left(\frac{n}{2}-2\right)-(n-2)\right|=\frac{n}{2} \neq 1$, this is a contradiction.
Case 2. Suppose that $n \in\{8,12,16,20, \ldots\}$. We note that $\left\lvert\,\left\{\frac{n}{2}+1, \frac{n}{2}+2, \ldots\right.$, \right. $n-3, n-2, n-1, n\} \left\lvert\,=\frac{n}{2}\right.$ is even. Define

$$
\alpha=\left(\begin{array}{cccccccccccc}
1 & 2 & \cdots & \frac{n}{2}-1 & \frac{n}{2} & \frac{n}{2}+1 & \frac{n}{2}+2 & \cdots & n-3 & n-2 & n-1 & n \\
n & n-1 & \cdots & \frac{n}{2}+2 & \frac{n}{2}+1 & \frac{n}{2}+2 & \frac{n}{2}+1 & \cdots & \frac{n}{2}+2 & \frac{n}{2}+1 & \frac{n}{2} & \frac{n}{2}-1
\end{array}\right) .
$$

It is obvious that $\alpha \in T_{n}(1)$. Since $T_{n}(1)$ is regular, there exists $\beta \in T_{n}(1)$ such that $\alpha=\alpha \beta \alpha$. Consider $\frac{n}{2}=(n-1) \alpha=((n-1) \alpha \beta) \alpha=\left(\frac{n}{2} \beta\right) \alpha$. Then we obtain $\frac{n}{2} \beta=n-1$. Since $\frac{n}{2}+1=(n-2) \alpha=((n-2) \alpha \beta) \alpha=\left(\left(\frac{n}{2}+1\right) \beta\right) \alpha$, we get $\left(\frac{n}{2}+1\right) \beta \in\left\{\frac{n}{2}, \frac{n}{2}+2\right.$, $\left.\frac{n}{2}+4, \ldots, n-4, n-2\right\}$ and so $\left(\frac{n}{2}+1\right) \beta=n-2$. Since $\left(\left(\frac{n}{2}+2\right) \beta\right) \alpha=((n-3) \alpha) \beta \alpha=$ $(n-3) \alpha=\frac{n}{2}+2$, which implies that $\left(\frac{n}{2}+2\right) \beta \in\left\{\frac{n}{2}-1, \frac{n}{2}+1, \frac{n}{2}+3, \ldots, n-3\right\}$. But $\left(\frac{n}{2}+2\right) \beta \in\{n-1, n-3\}$, whence $\left(\frac{n}{2}+2\right) \beta=n-3$. Next, we consider $\frac{n}{2}+3=\left(\frac{n}{2}-2\right) \alpha=$ $\left(\left(\frac{n}{2}-2\right) \alpha \beta\right) \alpha=\left(\left(\frac{n}{2}+3\right) \beta\right) \alpha$. Thus $\left(\frac{n}{2}+3\right) \beta=\frac{n}{2}-2$. We see that $\left|\left(\frac{n}{2}+3\right)-\left(\frac{n}{2}+2\right)\right|=1$ but $\left|\left(\frac{n}{2}+3\right) \beta-\left(\frac{n}{2}+2\right) \beta\right|=\left|\left(\frac{n}{2}-2\right)-(n-3)\right|=\frac{n}{2}-1 \neq 1$. This is a contradiction.
Case 3. Suppose that $n \in\{7,11,15,19, \ldots\}$. Then $\left|\left\{2,3, \ldots, \frac{n+1}{2}\right\}\right|=\mid\{n, n-1$, $\left.n-2, \ldots, \frac{n+5}{2}, \frac{n+3}{2}\right\} \mid$ and $\left|\left\{\frac{n+3}{2}, \frac{n+5}{2}, \ldots, n-2, n-1\right\}\right|=\frac{n-3}{2}$ is even. Define

$$
\alpha=\left(\begin{array}{ccccccccccccc}
1 & 2 & 3 & \cdots & \frac{n-3}{2} & \frac{n-1}{2} & \frac{n+1}{2} & \frac{n+3}{2} & \frac{n+5}{2} & \cdots & n-2 & n-1 & n \\
n-1 & n & n-1 & \cdots & \frac{n+7}{2} & \frac{n+5}{2} & \frac{n+3}{2} & \frac{n+5}{2} & \frac{n+3}{2} & \cdots & \frac{n+5}{2} & \frac{n+3}{2} & \frac{n+1}{2}
\end{array}\right) .
$$

It is easy to see that $\alpha \in T_{n}(1)$. Since $T_{n}(1)$ is regular, there exists $\beta \in T_{n}(1)$ such that $\alpha=\alpha \beta \alpha$. Consider $\frac{n+1}{2}=n \alpha=(n \alpha \beta) \alpha=\left(\left(\frac{n+1}{2}\right) \beta\right) \alpha$. Then we obtain $\left(\frac{n+1}{2}\right) \beta=n$ and it follows that $\left(\frac{n+3}{2}\right) \beta=n-1$. Since $\frac{n+5}{2}=\left(\frac{n+3}{2}\right) \alpha=\left(\left(\frac{n+3}{2}\right) \alpha \beta\right) \alpha=\left(\left(\frac{n+5}{2}\right) \beta\right) \alpha$, we get $\left(\frac{n+5}{2}\right) \beta \in\left\{\frac{n-1}{2}, \frac{n+3}{2}, \frac{n+7}{2}, \ldots, n-2\right\}$ and so $\left(\frac{n+5}{2}\right) \beta=n-2$. Next, we consider $\frac{n+7}{2}=$ $\left(\frac{n-3}{2}\right) \alpha=\left(\left(\frac{n-3}{2}\right) \alpha \beta\right) \alpha=\left(\left(\frac{n+7}{2}\right) \beta\right) \alpha$. Thus $\left(\frac{n+7}{2}\right) \beta=\frac{n-3}{2}$. We see that $\left|\frac{n+7}{2}-\frac{n+5}{2}\right|=1$ but $\left|\left(\frac{n+7}{2}\right) \beta-\left(\frac{n+5}{2}\right) \beta\right|=\left|\frac{n-3}{2}-(n-2)\right|=\frac{n-1}{2} \neq 1$. This is a contradiction.
Case 4. Suppose that $n \in\{9,13,17,21, \ldots\}$. Define

$$
\alpha=\left(\begin{array}{ccccccccccccc}
1 & 2 & 3 & \cdots & \frac{n-5}{2} & \frac{n-3}{2} & \frac{n-1}{2} & \frac{n+1}{2} & \frac{n+3}{2} & \cdots & n-2 & n-1 & n \\
n & n-1 & n-2 & \cdots & \frac{n+7}{2} & \frac{n+5}{2} & \frac{n+3}{2} & \frac{n+5}{2} & \frac{n+3}{2} & \cdots & \frac{n+5}{2} & \frac{n+3}{2} & \frac{n+1}{2}
\end{array}\right) .
$$

We note that $\left|\left\{1,2, \ldots, \frac{n-3}{2}, \frac{n-1}{2}\right\}\right|=\left|\left\{n, n-1, \ldots, \frac{n+5}{2}, \frac{n+3}{2}\right\}\right|$ and $\left\lvert\,\left\{\frac{n+1}{2}, \frac{n+3}{2}, \ldots\right.$, \right. $n-2, n-1\} \left\lvert\,=\frac{n-1}{2}\right.$ is even. It is clear that $\alpha \in T_{n}(1)$. Since $T_{n}(1)$ is regular, there exists $\beta \in T_{n}(1)$ such that $\alpha=\alpha \beta \alpha$. Consider $\frac{n+1}{2}=n \alpha=(n \alpha \beta) \alpha=\left(\left(\frac{n+1}{2}\right) \beta\right) \alpha$. Then we obtain $\left(\frac{n+1}{2}\right) \beta=n$ and it follows that $\left(\frac{n+3}{2}\right) \beta=n-1$. Since $\frac{n+5}{2}=(n-2) \alpha=$ $((n-2) \alpha \beta) \alpha=\left(\left(\frac{n+5}{2}\right) \beta\right) \alpha$, we get $\left(\frac{n+5}{2}\right) \beta \in\left\{\frac{n-3}{2}, \frac{n+1}{2}, \frac{n+5}{2}, \ldots, n-2\right\}$ and so $\left(\frac{n+5}{2}\right) \beta=$ $n-2$. Next, we consider $\frac{n+7}{2}=\left(\frac{n-5}{2}\right) \alpha=\left(\left(\frac{n-5}{2}\right) \alpha \beta\right) \alpha=\left(\left(\frac{n+7}{2}\right) \beta\right) \alpha$. Thus $\left(\frac{n+7}{2}\right) \beta=$ $\frac{n-5}{2}$. Since $\left|\frac{n+7}{2}-\frac{n+5}{2}\right|=1$, this implies that $\left|\left(\frac{n+7}{2}\right) \beta-\left(\frac{n+5}{2}\right) \beta\right|=\left|\frac{n-5}{2}-(n-2)\right|=$ $\frac{n+1}{2} \neq 1$. This is a contradiction. Therefore $T_{n}(1)$ is not regular.

## 3 Regularity of $T_{n}(l)$ for $2 \leq l \leq n-1$

For the case $l=n-1$, we have

$$
\begin{aligned}
T_{n}(n-1) & =\left\{\alpha \in T_{n}: 1 \alpha=1 \text { and } n \alpha=n\right\} \cup\left\{\alpha \in T_{n}: 1 \alpha=n \text { and } n \alpha=1\right\} \\
& =P G_{\{1, n\}}\left(X_{n}\right) \text { as defined in 6]. }
\end{aligned}
$$

It follows from [6, Theorem 2.2] that $T_{n}(n-1)$ is a regular semigroup.
From now on, we let $n \geq 4$ and $2 \leq l \leq n-2$. Note that $2 \leq n-l$ and $l+2 \leq n$.
Lemma 3.1. If $n \geq 5$ is odd, then $T_{n}(l)$ is not regular.
Proof. Let $n \geq 5$ be an odd integer. We consider two cases: $l \geq \frac{n+1}{2}$ or $l<\frac{n+1}{2}$.
Case 1. Assume that $l \geq \frac{n+1}{2}$. Using Remark 1.1(1), we can define

$$
\alpha=\left(\begin{array}{cccccccccccc}
1 & 2 & \cdots & n-l & (n-l)+1 & \cdots & l-1 & l & l+1 & l+2 & \cdots & n \\
1 & 1 & \cdots & 1 & 1 & \cdots & 1 & 2 & l+1 & l+1 & \cdots & l+1
\end{array}\right) .
$$

It is easy to verify that $\alpha \in T_{n}(l)$. If $T_{n}(l)$ is regular, then there exists $\beta \in T_{n}(l)$ such that $\alpha=\alpha \beta \alpha$. It follows that $2=l \alpha=(l \alpha \beta) \alpha=(2 \beta) \alpha$ and so $2 \beta=l$. Since $|2-(l+2)|=l$, this implies that $|l-(l+2) \beta|=|2 \beta-(l+2) \beta|=l$. Hence $(l+2) \beta=0$ or $(l+2) \beta=2 l>n$, this is a contradiction. Therefore, $T_{n}(l)$ is not regular.
Case 2. Assume that $l<\frac{n+1}{2}$. Then $l \leq \frac{n+1}{2}-1=\frac{n-1}{2}$, whence $2 l+1 \leq n$. Using Remark 1.1(2), we can define $\alpha \in T_{n}(l)$ by

$$
\alpha=\left(\begin{array}{ccccccccccccc}
1 & 2 & 3 & \cdots & l+1 & l+2 & l+3 & \cdots & k l+1 & k l+2 & k l+3 & \cdots & n \\
l+1 & l+1 & 3 & \cdots & 2 l+1 & 1 & l+3 & \cdots & u_{k} & v_{k} & k l+3 & \cdots & n \alpha
\end{array}\right)
$$

where for $k \geq 2$,

$$
\begin{gathered}
u_{k}=(k l+1) \alpha= \begin{cases}(k+1) l+1 & \text { if }(k+1) l+1 \leq n, \\
(k-1) l+1 & \text { if }(k+1) l+1>n,\end{cases} \\
v_{k}=(k l+2) \alpha=\left\{\begin{array}{ll}
1 & \text { if } k \text { is odd, } \\
l+1 & \text { if } k \text { is even, }
\end{array} \quad \text { and } \quad n \alpha= \begin{cases}n-l & \text { if } r=0, \\
1 & \text { if } r=1, \\
n & \text { if } 2 \leq r \leq l-1\end{cases} \right.
\end{gathered}
$$

when $r$ is the remainder of a division of $n-1$ by $l$. Note that if $n \alpha=1$ (that is, $r=1$ ), then $n=k l+2$ for some a positive odd integer $k$. Suppose that there is an element $\beta \in T_{n}(l)$ such that $\alpha=\alpha \beta \alpha$. Consider $1=(l+2) \alpha=((l+2) \alpha) \beta \alpha=(1 \beta) \alpha$ and $2 l+1=(l+1) \alpha=((l+1) \alpha) \beta \alpha=((2 l+1) \beta) \alpha$. By the definition of $\alpha$, we obtain $1 \beta=k l+2$ for some $k \in\{1,3,5,7, \ldots\}$ and $(2 l+1) \beta \in\{l+1,3 l+1\}$. Let $(l+1) \beta=z \in X_{n}$. Assume that $(2 l+1) \beta=l+1$. Since $|(l+1)-1|=l$ and $|(2 l+1)-(l+1)|=l$, whence $|(l+1) \beta-1 \beta|=l$ and $|(2 l+1) \beta-(l+1) \beta|=l$. That is, $|z-(k l+2)|=l$ and $|l+1-z|=l$ where $k \geq 1$ is odd. Thus there are four possible cases to consider:
(i) $z-(k l+2)=l$ and $l+1-z=l$,
(ii) $z-(k l+2)=l$ and $l+1-z=-l$,
(iii) $z-(k l+2)=-l$ and $l+1-z=l$,
(iv) $z-(k l+2)=-l$ and $l+1-z=-l$.

For the cases (i) and (iv), we get that $2 z=(k+1) l+3$, this is a contradiction since $2 z$ is even while $(k+1) l+3$ is odd. For the cases (ii) and (iii), we obtain $(k-1) l=-1$, this is a contradiction since $(k-1) l$ is even. And if $(2 l+1) \beta=3 l+1$, then a contradiction is obtained using an analogous argument. Therefore, $\alpha$ is not a regular element of $T_{n}(l)$.

Lemma 3.2. If $n \geq 6$ is even such that $l \neq \frac{n}{2}$, then $T_{n}(l)$ is not regular.
Proof. Assume that $n \geq 6$ is even such that $l \neq \frac{n}{2}$. If $l>\frac{n}{2}$, we let $\alpha$ be as defined in Case 1 of Lemma 3.1. By using the same proof, we obtain $\alpha$ is not a regular element in $T_{n}(l)$. Next, suppose that $l<\frac{n}{2}$. Then $2 l+1 \leq n$. Let $u_{k}$ and $v_{k}$ be as defined in Case 2 of Lemma 3.1. Define $\alpha \in T_{n}(l)$ by

$$
\alpha=\left(\begin{array}{ccccccccccccc}
1 & 2 & 3 & \cdots & l+1 & l+2 & l+3 & \cdots & k l+1 & k l+2 & k l+3 & \cdots & n \\
l+1 & l+1 & 3 & \cdots & 2 l+1 & 1 & l+3 & \cdots & u_{k} & v_{k} & k l+3 & \cdots & n \alpha
\end{array}\right)
$$

where

$$
n \alpha= \begin{cases}n-l & \text { if } r=0 \\ 1 & \text { if } q \text { is odd and } r=1 \\ l+1 & \text { if } q \text { is even and } r=1 \\ n & \text { if } 2 \leq r \leq l-1\end{cases}
$$

such that $q$ is the quotient and $r$ is the remainder of a division of $n-1$ by $l$. Note that if $n \alpha=1$ (that is, $q$ is odd and $r=1$ ), then $n=q l+2$ where $q$ is odd. By the same proof as given for Case 2 of Lemma 3.1, we obtain $\alpha$ is not a regular element in $T_{n}(l)$.

Remark 3.1. If $n$ is even and $l=\frac{n}{2}$, then $n=2 l$ and $n-l=l$. We note that $x+l \notin X_{n}$ for all $x \in\{l+1, l+2, \ldots, n\}$. Of importance is the fact that for each $x \in\{1,2, \ldots, l\}$, there exists unique $y=x+l \in X_{n}$ such that $|x-y|=l$. And, for each $x \in\{l+1, l+2, \ldots, n\}$, there exists unique $y=x-l \in X_{n}$ such that $|x-y|=l$. Moreover, for any $\alpha \in T_{n}\left(\frac{n}{2}\right)$ we can write

$$
\alpha=\left(\begin{array}{ccccccc}
1 & l+1 & 2 & l+2 & \cdots & l & 2 l \\
1 \alpha & (l+1) \alpha & 2 \alpha & (l+2) \alpha & \cdots & l \alpha & (2 l) \alpha
\end{array}\right)
$$

where for each $1 \leq x \leq l$,

$$
(x \alpha,(l+x) \alpha) \in\{(i, l+i): 1 \leq i \leq l\} \cup\{(l+i, i): 1 \leq i \leq l\} .
$$

Theorem 3.3. Let $n \geq 4$ and $2 \leq l \leq n-2$. Then $T_{n}(l)$ is regular if and only if $n$ is even and $l=\frac{n}{2}$.

Proof. It follows from Lemmas 3.1, 3.2 that $T_{n}(l)$ is not regular when $n$ is odd or $l \neq \frac{n}{2}$. Conversely, assume that $n$ is even and $l=\frac{n}{2}$. We prove $T_{n}(l)$ is regular. Let $\alpha$ be any element in $T_{n}(l)$ and $u \in X_{n} \alpha$. By Remark 3.1, there exists unique $v \in X_{n} \alpha$ such that $|u-v|=l$. In fact, $(u, v) \in\{(i, l+i),(l+i, i): 1 \leq i \leq l\}$. We choose and fix $d_{u} \in u \alpha^{-1}$ and $d_{v} \in v \alpha^{-1}$ such that $\left|d_{u}-d_{v}\right|=l$. Define

$$
\beta=\left(\begin{array}{ccc}
u & v & z \\
d_{u} & d_{v} & z
\end{array}\right)
$$

where $z \in X_{n} \backslash X_{n} \alpha$. Then $\beta$ is well-defined and belongs to $T_{n}(l)$. Let $x \in X_{n}$. Thus $x \alpha \in X_{n} \alpha$ and $\left(d_{x \alpha}\right) \alpha=x \alpha$. Accordingly, $((x \alpha) \beta) \alpha=\left(d_{x \alpha}\right) \alpha=x \alpha$, that is, $\alpha \beta \alpha=\alpha$. Therefore $\alpha$ is regular.

## $4 \quad$ Regularity of $T_{n}^{*}(l)$

In this section, we prove that $T_{n}^{*}(l)$ is a regular semigroup.
For $n=2$, we have $l=1$. It is easy to see that $T_{2}^{*}(1)=\left\{\left(\begin{array}{ll}1 & 2 \\ 1 & 2\end{array}\right),\left(\begin{array}{ll}1 & 2 \\ 2 & 1\end{array}\right)\right\}$ is regular. Now, we suppose that $n \geq 3$.

Lemma 4.1. Assume that ( $n \geq 3$ is an odd integer and $l \geq \frac{n+1}{2}$ ) or ( $n \geq 4$ is an even integer and $\left.l>\frac{n}{2}\right)$. Let $\alpha \in T_{n}^{*}(l)$. Then

$$
\alpha=\left(\begin{array}{cccccccccc}
1 & l+1 & 2 & l+2 & \cdots & n-l & n & (n-l)+1 & \cdots & l \\
1 \alpha & (l+1) \alpha & 2 \alpha & (l+2) \alpha & \cdots & (n-l) \alpha & n \alpha & ((n-l)+1) \alpha & \cdots & l \alpha
\end{array}\right)
$$

where $\{(n-l)+1,(n-l)+2, \ldots, l\} \alpha \subseteq\{(n-l)+1,(n-l)+2, \ldots, l\}$, and for each $1 \leq x \leq n-l$,

$$
(x \alpha,(l+x) \alpha) \in\{(i, l+i): 1 \leq i \leq n-l\} \cup\{(l+i, i): 1 \leq i \leq n-l\}
$$

such that $\{x \alpha,(l+x) \alpha\} \cap\{y \alpha,(l+y) \alpha\}=\emptyset$ for all $x \neq y \in\{1,2, \ldots, n-l\}$.
Proof. By Remark [1.1(1) and $\alpha$ preserves the length $l$, we can write

$$
\alpha=\left(\begin{array}{cccccccccc}
1 & l+1 & 2 & l+2 & \cdots & n-l & n & (n-l)+1 & \cdots & l \\
1 \alpha & (l+1) \alpha & 2 \alpha & (l+2) \alpha & \cdots & (n-l) \alpha & n \alpha & ((n-l)+1) \alpha & \cdots & l \alpha
\end{array}\right)
$$

where for each $1 \leq x \leq n-l$,

$$
(x \alpha,(l+x) \alpha) \in\{(i, l+i): 1 \leq i \leq n-l\} \cup\{(l+i, i): 1 \leq i \leq n-l\}
$$

Suppose that there exist $x, y \in\{1,2, \ldots, n-l\}$ such that $x \neq y$ but $\{x \alpha,(l+x) \alpha\} \cap$ $\{y \alpha,(l+y) \alpha\} \neq \emptyset$. There are three possible cases to consider.
Case 1. $x \alpha=y \alpha$. Since $|(l+x)-x|=l$, it follows that $l=|(l+x) \alpha-x \alpha|=|(l+x) \alpha-y \alpha|$. Hence $|(l+x)-y|=l$. Then by Remark 1.1(1), we get $x=y$, a contradiction.
Case 2. $x \alpha=(l+y) \alpha$. Since $|(l+y)-y|=l$, this implies that

$$
l=|(l+y) \alpha-y \alpha|=|x \alpha-y \alpha| .
$$

Thus $|x-y|=l$, which is impossible because $|x-y| \leq(n-l)-1<l-1<l$.
Case 3. $(l+x) \alpha=(l+y) \alpha$. Since $|(l+y)-y|=l, l=|(l+y) \alpha-y \alpha|=|(l+x) \alpha-y \alpha|$. Hence $|(l+x)-y|=l$. Then by Remark 1.1(1), we get $x=y$, a contradiction.
Therefore $\{x \alpha,(l+x) \alpha\} \cap\{y \alpha,(l+y) \alpha\}=\emptyset$ for all $x \neq y \in\{1, \ldots, n-l\}$ and so $\{1, \ldots, n-l, l+1, l+2, \ldots, n\} \alpha=\{1,2, \ldots, n-l, l+1, l+2, \ldots, n\}$. If there is an element $x \in\{(n-l)+1,(n-l)+2, \ldots, l\}$ such that $x \alpha \in\{1,2, \ldots, n-l, l+1, l+2, \ldots, n\}$, then there exists $y \in\{1,2, \ldots, n-l, l+1, l+2, \ldots, n\}$ such that $|x \alpha-y \alpha|=l$. Thus $|x-y|=l$, contrary to Remark $1.1(1)$. Therefore $\{(n-l)+1,(n-l)+2, \ldots, l\} \alpha \subseteq$ $\{(n-l)+1,(n-l)+2, \ldots, l\}$.

Theorem 4.2. If ( $n \geq 3$ is an odd integer and $l \geq \frac{n+1}{2}$ ) or ( $n \geq 4$ is an even integer and $l>\frac{n}{2}$ ), then $T_{n}^{*}(l)$ is a regular semigroup.

Proof. Assume that ( $n \geq 3$ is an odd integer and $l \geq \frac{n+1}{2}$ ) or ( $n \geq 4$ is an even integer and $l>\frac{n}{2}$ ). Let $\alpha$ be any element in $T_{n}^{*}(l)$. Then by Lemma 4.1, we can write

$$
\alpha=\left(\begin{array}{cccccccccc}
1 & l+1 & 2 & l+2 & \cdots & n-l & n & (n-l)+1 & \cdots & l \\
1 \alpha & (l+1) \alpha & 2 \alpha & (l+2) \alpha & \cdots & (n-l) \alpha & n \alpha & ((n-l)+1) \alpha & \cdots & l \alpha
\end{array}\right)
$$

where $\{(n-l)+1,(n-l)+2, \ldots, l\} \alpha \subseteq\{(n-l)+1,(n-l)+2, \ldots, l\}$, and for each $1 \leq x \leq n-l$,

$$
(x \alpha,(l+x) \alpha) \in\{(i, l+i): 1 \leq i \leq n-l\} \cup\{(l+i, i): 1 \leq i \leq n-l\}
$$

such that $\{x \alpha,(l+x) \alpha\} \cap\{y \alpha,(l+y) \alpha\}=\emptyset$ for all $x \neq y \in\{1, \ldots, n-l\}$. For $z \alpha \in\{(n-l)+1,(n-l)+2, \ldots, l\} \alpha$, let $d_{z \alpha} \in(z \alpha) \alpha^{-1} \subseteq\{(n-l)+1,(n-l)+2, \ldots, l\}$. Define

$$
\beta=\left(\begin{array}{ccccccccc}
1 \alpha & (l+1) \alpha & 2 \alpha & (l+2) \alpha & \cdots & (n-l) \alpha & n \alpha & z \alpha & w \\
1 & l+1 & 2 & l+2 & \cdots & n-l & n & d_{z \alpha} & w
\end{array}\right)
$$

where $w \in\{(n-l)+1,(n-l)+2, \ldots, l\} \backslash X_{n} \alpha$. It is easy to verify that $\beta \in T_{n}^{*}(l)$. Let $a \in X_{n}$. If $a \in\{1,2, \ldots, n-l, l+1, l+2, \ldots, n\}$, then $a(\alpha \beta \alpha)=((a \alpha) \beta) \alpha=a \alpha$. If $a \in\{(n-l)+1,(n-l)+2, \ldots, l\}$, then $a \alpha \in\{(n-l)+1,(n-l)+2, \ldots, l\} \alpha$ and so $a(\alpha \beta \alpha)=((a \alpha) \beta) \alpha=\left(d_{a \alpha}\right) \alpha=a \alpha$. Thus $\alpha \beta \alpha=\alpha$. Therefore $\alpha$ is regular.

From now on, we assume that ( $n \geq 3$ is an odd integer and $l<\frac{n+1}{2}$ ) or ( $n \geq 4$ is an even integer and $\left.l \leq \frac{n}{2}\right)$. To prove $T_{n}^{*}(l)$ is regular, we need the following seven lemmas.

Lemma 4.3. Let $\alpha \in T_{n}^{*}(l)$. If $x, y \in X_{n}$ such that $x<y$ and $x \alpha=y \alpha$, then $y=x+2 l$.
Proof. Assume $x, y \in X_{n}$ such that $x<y$ and $x \alpha=y \alpha$. By Remark 1.1(2), there exists $x+l \in X_{n}$ or $x-l \in X_{n}$. Since $|x-(x \pm l)|=l$, we obtain $|x \alpha-(x \pm l) \alpha|=l$. It follows that $(x \pm l) \alpha=x \alpha \pm l$. Using our assumption, we have

$$
|(x \alpha \pm l)-x \alpha|=l \Rightarrow|(x \pm l) \alpha-y \alpha|=l \Rightarrow|(x \pm l)-y|=l \Rightarrow y=x \text { or } y=x \pm 2 l
$$

If $y=x$ or $y=x-2 l$, then $y \leq x$, a contradiction. Thus $y=x+2 l$.
For $i \in\{1,2, \ldots, l\}$, let $A_{i}=\left\{i, i+l, i+2 l, \ldots, i+m_{i} l\right\}$ when $m_{i}$ is the maximum positive integer such that $i+m_{i} l \leq n$. By Remark 1.1(2), we can write

$$
X_{n}=\bigcup_{i=1}^{l} A_{i}
$$

where $A_{i} \cap A_{j}=\emptyset$ for all $i \neq j \in\{1,2, \ldots, l\}$. Moreover, if $x \in A_{i}$ and $y \in A_{j}$ for some $i \neq j \in\{1,2, \ldots, l\}$, then $|x-y| \neq l$. Note that $m_{l} \leq m_{l-1} \leq \cdots \leq m_{2} \leq m_{1}$ and $\left|A_{i}\right|=m_{i}+1$ for all $1 \leq i \leq l$.

Lemma 4.4. Let $\alpha \in T_{n}^{*}(l)$ and $i \in\{1,2, \ldots, l\}$. If $x \in A_{i}$ and $x \alpha \in A_{j}$ for some $j \in\{1,2, \ldots, l\}$, then $A_{i} \alpha \subseteq A_{j}$.

Proof. Let $x \in A_{i}$ be such that $x \alpha \in A_{j}$ for some $j \in\{1,2, \ldots, l\}$. Suppose that $A_{i} \alpha \nsubseteq A_{j}$. Then there exits $y \in A_{i}$ such that $y \alpha \notin A_{j}$. If $y>x$, we let $u$ is the first element of $A_{i}$ such that $u>x$ and $u \alpha \notin A_{j}$. It follows that $u \leq y, u-l \in A_{i}$ and $(u-l) \alpha \in A_{j}$. Since $|(u-l) \alpha-u \alpha| \neq l$, which implies that $|(u-l)-u| \neq l$, a contradiction. If $y<x$, we let $v$ is the last element of $A_{i}$ such that $v<x$ and $v \alpha \notin A_{j}$. It follows that $y \leq v, v+l \in A_{i}$ and $(v+l) \alpha \in A_{j}$. Since $|v \alpha-(v+l) \alpha| \neq l$, this implies that $|v-(v+l)| \neq l$, a contradiction. Therefore $A_{i} \alpha \subseteq A_{j}$.

Lemma 4.5. Let $\alpha \in T_{n}^{*}(l)$ and $i, j \in\{1,2, \ldots, l\}$ such that $x \in A_{i}$ and $y \in A_{j}$. If $i \neq j$, then $x \alpha \neq y \alpha$.

Proof. Assume that $i \neq j$. Thus $A_{i} \cap A_{j}=\emptyset$. This implies that $y \notin A_{i}$ and $x \neq y$. We assume that $x<y$ and $x \alpha=y \alpha$. Let $x=i+k l$ for some $k \in\left\{0,1, \ldots, m_{i}\right\}$. By Lemma 4.3, we get

$$
i+(k+2) l=(i+k l)+2 l=x+2 l=y \leq n
$$

Hence $y=i+(k+2) l \in A_{i}$, a contradiction. Therefore $x \alpha \neq y \alpha$.
The next remark follows directly from Lemma 4.5,
Remark 4.1. Let $\alpha \in T_{n}^{*}(l)$ and $x \in X_{n}$. If $x \in A_{i} \alpha$ for some $i \in\{1,2, \ldots, l\}$, then $x \notin A_{j} \alpha$ for all $j \in\{1,2, \ldots, l\}, j \neq i$.

Lemma 4.6. Let $i \in\{1,2, \ldots, l\}$ and $\alpha \in T_{n}^{*}(l)$. If $m_{i} \geq 3$, then either $i \alpha<(i+l) \alpha<$ $(i+2 l) \alpha<\cdots<\left(i+m_{i} l\right) \alpha$ or $i \alpha>(i+l) \alpha>(i+2 l) \alpha>\cdots>\left(i+m_{i} l\right) \alpha$.

Proof. Suppose that $m_{i} \geq 3$. That is, $i, i+l, i+2 l, i+3 l \in X_{n}$. We see that $(i \alpha,(i+l) \alpha,(i+2 l) \alpha,(i+3 l) \alpha) \in\{(i \alpha, i \alpha+l, i \alpha+2 l, i \alpha+3 l),(i \alpha, i \alpha+l, i \alpha+2 l$, $i \alpha+l),(i \alpha, i \alpha+l, i \alpha, i \alpha+l),(i \alpha, i \alpha+l, i \alpha, i \alpha-l),(i \alpha, i \alpha-l, i \alpha, i \alpha+l),(i \alpha, i \alpha-l, i \alpha$, $i \alpha-l),(i \alpha, i \alpha-l, i \alpha-2 l, i \alpha-l),(i \alpha, i \alpha-l, i \alpha-2 l, i \alpha-3 l)\}$. If $(i+3 l) \alpha \notin\{i \alpha+3 l, i \alpha-3 l\}$, then $(i+3 l) \alpha \in\{i \alpha+l, i \alpha-l\}$ and so $|i \alpha-(i+3 l) \alpha|=|i \alpha-(i \alpha \pm l)|=l$ but $|i-(i+3 l)|=3 l \neq l$, a contradiction. Hence $(i+3 l) \alpha \in\{i \alpha+3 l, i \alpha-3 l\}$. It follows that $(i \alpha,(i+l) \alpha,(i+2 l) \alpha,(i+3 l) \alpha) \in\{(i \alpha, i \alpha+l, i \alpha+2 l, i \alpha+3 l),(i \alpha, i \alpha-l, i \alpha-2 l, i \alpha-3 l)\}$. For the case $(i \alpha,(i+l) \alpha,(i+2 l) \alpha,(i+3 l) \alpha)=(i \alpha, i \alpha+l, i \alpha+2 l, i \alpha+3 l)$. It is clear that either $(i+4 l) \alpha=i \alpha+2 l$ or $(i+4 l) \alpha=i \alpha+4 l$. If $(i+4 l) \alpha=i \alpha+2 l$, then $|(i+l) \alpha-(i+4 l) \alpha|=|(i \alpha+l)-(i \alpha+2 l)|=l$ but $|(i+l)-(i+4 l)|=3 l \neq l$, a contradiction. Thus $(i+4 l) \alpha=i \alpha+4 l$. We finally obtain that $(i+k l) \alpha=i \alpha+k l$ for all $0 \leq k \leq m_{i}$. Therefore

$$
i \alpha<(i+l) \alpha<(i+2 l) \alpha<\cdots<\left(i+m_{i} l\right) \alpha
$$

For the case $(i \alpha,(i+l) \alpha,(i+2 l) \alpha,(i+3 l) \alpha)=(i \alpha, i \alpha-l, i \alpha-2 l, i \alpha-3 l)\}$. It is obvious that either $(i+4 l) \alpha=i \alpha-2 l$ or $(i+4 l) \alpha=i \alpha-4 l$. If $(i+4 l) \alpha=i \alpha-2 l$, then $|(i+l) \alpha-(i+4 l) \alpha|=|(i \alpha-l)-(i \alpha-2 l)|=l$ while $|(i+l)-(i+4 l)|=3 l \neq l$, a contradiction. Thus $(i+4 l) \alpha=i \alpha-4 l$. Similarly, we obtain $(i+k l) \alpha=i \alpha-k l$ for all $0 \leq k \leq m_{i}$. Therefore

$$
i \alpha>(i+l) \alpha>(i+2 l) \alpha>\cdots>\left(i+m_{i} l\right) \alpha
$$

Lemma 4.6 yields the following remark directly.
Remark 4.2. $\left|A_{i} \alpha\right|=\left|A_{i}\right|$ for all $\alpha \in T_{n}^{*}(l)$ and all $m_{i} \geq 3$.
Lemma 4.7. Let $\alpha \in T_{n}^{*}(l)$ and $i, j \in\{1,2, \ldots, l\}$ such that $m_{j} \geq 3$. If $m_{i}<m_{j}$, then $x \notin A_{j} \alpha$ for all $x \in A_{i}$.

Proof. Let $m_{i}<m_{j}$. Assume that $x \in A_{j} \alpha$ for some $x \in A_{i}$. Then by Lemma 4.4, we get $A_{j} \alpha \subseteq A_{i}$. It follows that $\left|A_{j} \alpha\right| \leq\left|A_{i}\right|=m_{i}+1<m_{j}+1=\left|A_{j}\right|$. That is, $\left|A_{j} \alpha\right|<\left|A_{j}\right|$, which contradicts Remark 4.2. Hence $x \notin A_{j} \alpha$ for all $x \in A_{i}$.

Lemma 4.8. Let $\alpha \in T_{n}^{*}(l)$ and $i \in\{1,2, \ldots, l\}$ such that $m_{i} \geq 3$. Let $Z_{m_{i}}=\{j \in$ $\left.\{1,2, \ldots, l\}: m_{j}=m_{i}\right\}$. Then $A_{j} \alpha=A_{j \sigma}$ for all $j \in Z_{m_{i}}$ and for some $\sigma \in G\left(Z_{m_{i}}\right)$, the permutation group on $Z_{m_{i}}$.

Proof. Let $d$ be an integer such that $d \geq 0$ and $m_{1}-d \geq 3$. Consider the proposition

$$
P(d): A_{j} \alpha=A_{j \sigma} \text { for all } j \in Z_{m_{1}-d} \text { and for some } \sigma \in G\left(Z_{m_{1}-d}\right)
$$

We shall prove this by a strong induction on $d$.
First, we prove that $P(0)$ holds. That is, $A_{j} \alpha=A_{j \sigma}$ for all $j \in Z_{m_{1}}$ and for some $\sigma \in G\left(Z_{m_{1}}\right)$. Note that $m_{1} \geq m_{k}$ for all $1 \leq k \leq l$. Suppose that $Z_{m_{1}}=\left\{j_{1}, j_{2}, \ldots, j_{r}\right\}$ such that $j_{1} \neq j_{2} \neq \cdots \neq j_{r}$. It is obvious that $1 \in Z_{m_{1}}$. For convenience, we assume that $j_{1}=1$. That is, $j_{2}, j_{3}, \ldots, j_{r} \in\{2,3, \ldots, l\}$ where $m_{j_{2}}=m_{j_{2}}=\cdots=m_{j_{r}}=$ $m_{1} \geq 3$. It follows from Lemma 4.6 and Lemma 4.7 that $A_{j_{1}} \alpha=A_{1} \alpha=A_{k_{1}}$ for some $k_{1} \in Z_{m_{1}}$. Similarly, we have $A_{j_{2}} \alpha=A_{k_{2}}$ for some $k_{2} \in Z_{m_{1}}$. If $k_{2}=k_{1}$, we obtain $A_{1} \alpha=A_{j_{2}} \alpha$, that is, there exist $x \in A_{1}, y \in A_{j_{2}}$ such that $x \alpha=y \alpha$. Then by Lemma 4.5, we get $j_{2}=1=j_{1}$, a contradiction. Hence $k_{2} \neq k_{1}$. We also can show that $A_{j_{3}} \alpha=A_{k_{3}}$ for some $k_{3} \in Z_{m_{1}} \backslash\left\{k_{1}, k_{2}\right\}$. At the end of this process we obtain $A_{j_{r}} \alpha=A_{k_{r}}$ for some $k_{r} \in Z_{m_{1}} \backslash\left\{k_{1}, k_{2}, \ldots, k_{r-1}\right\}$. Since $\left\{k_{1}, k_{2}, \ldots, k_{r}\right\} \subseteq Z_{m_{1}}$ and $\left|Z_{m_{1}}\right|=\left|\left\{k_{1}, k_{2}, \ldots, k_{r}\right\}\right|=r$, which implies that $Z_{m_{1}}=\left\{k_{1}, k_{2}, \ldots, k_{r}\right\}$. We define $j_{t} \sigma=k_{t}$ for all $1 \leq t \leq r$. It is clear that $\sigma: Z_{m_{1}} \rightarrow Z_{m_{1}}$ is a bijection. Thus $\sigma \in G\left(Z_{m_{1}}\right)$ and $A_{j_{t}} \alpha=A_{j_{t} \sigma}$ for all $1 \leq t \leq r$. Therefore $P(0)$ holds.

Now, assume that $P(d)$ holds for all $0 \leq d \leq k-1$ where $m_{1}-(k-1) \geq 3$. Then $m_{1}-d \geq m_{1}-(k-1) \geq 3$ for all $0 \leq d \leq k-1$. We prove $P(k)$ holds where $m_{1}-k \geq 3$. Suppose that $Z_{m_{1}-k}=\left\{q_{1}, q_{2}, \ldots, q_{s}\right\}$ such that $q_{1} \neq q_{2} \neq \cdots \neq q_{s}$. Since $k>0$, which implies that $1 \notin Z_{m_{1}-k}$ and so $q_{1}, q_{2}, \ldots, q_{s} \in\{2,3, \ldots, l\}$ where $m_{q_{1}}=m_{q_{2}}=\cdots=m_{q_{s}}=m_{1}-k \geq 3$. We show that if $x \in A_{p}$ where $m_{1}-k<$ $m_{p}$, then $x \notin A_{q_{t}} \alpha$ for all $1 \leq t \leq s$. Let $x \in A_{p}$ such that $m_{1}-k<m_{p}$. Then $m_{p}=m_{1}-d$ for some $d \in\{0,1, \ldots, k-1\}$, that is, $p \in Z_{m_{1}-d}$. If $x \in A_{q_{t}} \alpha$ for some $q_{t} \in Z_{m_{1}-k}$, then $x=y \alpha$ for some $y \in A_{q_{t}}$. By our induction hypothesis, we have $A_{j} \alpha=A_{j \sigma}$ for all $j \in Z_{m_{1}-d}$ where $\sigma \in G\left(Z_{m_{1}-d}\right)$. Since $p \in Z_{m_{1}-d}$, there exists
unique $u \in Z_{m_{1}-d}$ such that $u \sigma=p$. Thus we get $A_{u} \alpha=A_{u \sigma}=A_{p}$ and so $x=z \alpha$ for some $z \in A_{u}$. Since $q_{t} \neq u$, we obtain $y \alpha \neq z \alpha$ by Lemma 4.5, this is a contradiction. Therefore $x \notin A_{q_{t}} \alpha$ for all $1 \leq t \leq s$. It follows from Lemma 4.6 and Lemma 4.7 that for each $q_{t} \in Z_{m_{1}-k}, A_{q_{t}} \alpha=A_{q_{t}^{\prime}}$ for some $q_{t}^{\prime} \in Z_{m_{1}-k}$. If $q_{t}^{\prime}=q_{j}^{\prime}$ where $q_{t}, q_{j} \in Z_{m_{1}-k}$, we obtain $A_{q_{t}} \alpha=A_{q_{t}^{\prime}}=A_{q_{j}^{\prime}}=A_{q_{j}} \alpha$. Thus there exist $v \in A_{q_{t}}, w \in A_{q_{j}}$ such that $v \alpha=w \alpha$, we get $q_{t}=q_{j}$ by Lemma 4.5. This implies that $Z_{m_{1}-k}=\left\{q_{1}^{\prime}, q_{2}^{\prime}, \ldots, q_{s}^{\prime}\right\}$. We define $\delta: Z_{m_{1}-k} \rightarrow Z_{m_{1}-k}$ by $q_{t} \delta=q_{t}^{\prime}$ for all $1 \leq t \leq s$. It is clear that $\delta \in G\left(Z_{m_{1}-k}\right)$ and $A_{q_{t}} \alpha=A_{q_{t}^{\prime}}=A_{q_{t} \delta}$ for all $1 \leq t \leq s$. So $P(k)$ holds.

Remark 4.3. Let $\alpha \in T_{n}^{*}(l)$ and $i, j \in\{1,2, \ldots, l\}$ such that $m_{j} \geq 3$. If $m_{i}<m_{j}$, then $x \notin A_{i} \alpha$ for all $x \in A_{j}$. Indeed, if there is $x \in A_{i} \alpha$ for some $x \in A_{j}$ where $m_{i}<m_{j}$, then $x=y \alpha$ for some $y \in A_{i}$. Since $m_{j} \geq 3, A_{j}=A_{k} \alpha$ for some $m_{k}=m_{j} \geq 3$ by Lemma 4.8. Thus $x=z \alpha$ for some $z \in A_{k}$. Now, we have $y \alpha=z \alpha$ where $y \in A_{i}$ and $z \in A_{k}$ such that $m_{i}<m_{k}$. It follows from Lemma 4.5 that $i=k$, which is a contradiction.

Lemma 4.9. Let $\alpha \in T_{n}^{*}(l)$ and $X_{n} \alpha \neq X_{n}$. If $u \in X_{n} \backslash X_{n} \alpha$, then $(u=j \in\{1,2, \ldots, l\}$ such that $m_{j}=2$ and $\left.j+2 l \in X_{n} \alpha\right)$ or $(u=j+2 l$ where $j \in\{1,2, \ldots, l\}$ such that $m_{j}=2$ and $j \in X_{n} \alpha$ ). In particular, $j+l \in X_{n} \alpha$ for all $j \in\{1,2, \ldots, l\}$ such that $m_{j}=2$.

Proof. Assume that $u \in X_{n} \backslash X_{n} \alpha$. For $i \in\{1,2, \ldots, l\}$ with $m_{i} \geq 3$, by Lemma 4.8 we have $A_{i}=A_{j} \alpha \subseteq X_{n} \alpha$ for some $j \in\{1,2, \ldots, l\}$ such that $m_{j}=m_{i}$. Hence $u \notin A_{i}$ for all $i \in\{1,2, \ldots, l\}$ such that $m_{i} \geq 3$. That is, $u \in A_{i}$ for some $i \in\{1,2, \ldots, l\}$ such that $m_{i} \in\{1,2\}$. Let $i_{1}, i_{2}, \ldots, i_{r} \in\{1,2, \ldots, l\}$ such that $m_{i_{1}}=m_{i_{2}}=\cdots=m_{i_{r}}=1$ and $j_{1}, j_{2}, \ldots, j_{s} \in\{1,2, \ldots, l\}$ such that $m_{j_{1}}=m_{j_{2}}=\cdots=m_{j_{s}}=2$. Note that $i_{t}+q l \notin X_{n}$ for all $1 \leq t \leq r$ and all $q \geq 2$. There are two possible cases to consider.
Case 1. $\left\{i_{1}, i_{2} \ldots, i_{r}\right\}=\emptyset$ or $\left[\left\{i_{1}, i_{2}, \ldots, i_{r}\right\} \neq \emptyset\right.$ and $\left(i_{t} \alpha,\left(i_{t}+l\right) \alpha\right) \in\left\{\left(i_{k}, i_{k}+l\right)\right.$, $\left.\left(i_{k}+l, i_{k}\right): k \in\{1,2, \ldots, r\}\right\}$ for all $\left.1 \leq t \leq r\right]$. Since $X_{n} \alpha \neq X_{n}$, by Lemma 4.4 and Remark 4.1 there exists $j_{p} \in\left\{j_{1}, j_{2}, \ldots, j_{s}\right\}$ such that $\left(j_{p} \alpha,\left(j_{p}+l\right) \alpha,\left(j_{p}+2 l\right) \alpha\right) \in$ $\left\{\left(j_{q}, j_{q}+l, j_{q}\right),\left(j_{q}+l, j_{q}, j_{q}+l\right),\left(j_{q}+l, j_{q}+2 l, j_{q}+l\right),\left(j_{q}+2 l, j_{q}+l, j_{q}+2 l\right): q \in\right.$ $\{1,2, \ldots, s\}\}$.

If $\left(j_{p} \alpha,\left(j_{p}+l\right) \alpha,\left(j_{p}+2 l\right) \alpha\right) \in\left\{\left(j_{q}, j_{q}+l, j_{q}\right),\left(j_{q}+l, j_{q}, j_{q}+l\right): q \in\{1,2, \ldots, s\}\right\}$, it is easy to see that $j_{q}+2 l \notin X_{n} \alpha$ where $j_{q}+l \in X_{n} \alpha$ and $m_{j_{q}}=2$. In this case, we have $u=j_{q}+2 l$ such that $m_{j_{q}}=2$ and $j_{q} \in X_{n} \alpha$.

If $\left(j_{p} \alpha,\left(j_{p}+l\right) \alpha,\left(j_{p}+2 l\right) \alpha\right) \in\left\{\left(j_{q}+l, j_{q}+2 l, j_{q}+l\right),\left(j_{q}+2 l, j_{q}+l, j_{q}+2 l\right): q \in\right.$ $\{1,2, \ldots, s\}\}$, then we get $j_{q} \notin X_{n} \alpha$ and $j_{q}+l \in X_{n} \alpha$ such that $m_{j_{q}}=2$. In this case, we have $u=j_{q}$ such that $m_{j_{q}}=2$ and $j_{q}+2 l \in X_{n} \alpha$.
Case 2. $\left\{i_{1}, i_{2}, \ldots, i_{r}\right\} \neq \emptyset$ and $\left(i_{t} \alpha,\left(i_{t}+l\right) \alpha\right) \in\left\{\left(j_{k}, j_{k}+l\right),\left(j_{k}+l, j_{k}\right),\left(j_{k}+l, j_{k}+\right.\right.$ $\left.2 l),\left(j_{k}+2 l, j_{k}+l\right): k \in\{1,2, \ldots, s\}\right\}$ for some $t \in\{1,2, \ldots, r\}$. Clearly, $j_{k}+l \in X_{n} \alpha$ when $k \in\{1,2, \ldots, s\}$. Now, we partition into four subcases as follows:

Subcase $2.1\left(i_{t} \alpha,\left(i_{t}+l\right) \alpha\right)=\left(j_{k}, j_{k}+l\right)$ for some $k \in\{1,2, \ldots, s\}$. Suppose that $j_{k}+2 l \in X_{n} \alpha$. That is, there exists $x \in X_{n}$ such that $x \alpha=j_{k}+2 l$. Since $\left|\left(i_{t}+l\right) \alpha-x \alpha\right|=\left|\left(j_{k}+l\right)-\left(j_{k}+2 l\right)\right|=l$, we obtain $\left|\left(i_{t}+l\right)-x\right|=l$. It follows that $x=i_{t}$ or $x=i_{t}+2 l$. If $x=i_{t}$, then $j_{k}+2 l=x \alpha=i_{t} \alpha=j_{k}$. Hence $2 l=0$, this is impossible. If $x=i_{t}+2 l$, then $x \notin X_{n}$, a contradiction. Therefore $j_{k}+2 l \notin X_{n} \alpha$.

Subcase $2.2\left(i_{t} \alpha,\left(i_{t}+l\right) \alpha\right)=\left(j_{k}+l, j_{k}\right)$ for some $k \in\{1,2, \ldots, s\}$. Suppose that $j_{k}+2 l \in X_{n} \alpha$. That is, there exists $x \in X_{n}$ such that $x \alpha=j_{k}+2 l$. Since $\left|i_{t} \alpha-x \alpha\right|=\left|\left(j_{k}+l\right)-\left(j_{k}+2 l\right)\right|=l$, we obtain $\left|i_{t}-x\right|=l$. Thus $x=i_{t} \pm l$. If $x=i_{t}+l$, then $j_{k}+2 l=x \alpha=\left(i_{t}+l\right) \alpha=j_{k}$. Hence $2 l=0$, this is impossible. If $x=i_{t}-l$, then $x \notin X_{n}$ (since $1 \leq i_{t} \leq l$ ), a contradiction. Therefore $j_{k}+2 l \notin X_{n} \alpha$.

Subcase $2.3\left(i_{t} \alpha,\left(i_{t}+l\right) \alpha\right)=\left(j_{k}+l, j_{k}+2 l\right)$ for some $k \in\{1,2, \ldots, s\}$. Suppose that $j_{k} \in X_{n} \alpha$. That is, there exists $x \in X_{n}$ such that $x \alpha=j_{k}$. Since $\left|i_{t} \alpha-x \alpha\right|=$ $\left|\left(j_{k}+l\right)-j_{k}\right|=l$, we obtain $\left|i_{t}-x\right|=l$. Thus $x=i_{t} \pm l$. Since $i_{t}-l \notin X_{n}$, we have $x=i_{t}+l$. It follows that $j_{k}=x \alpha=\left(i_{t}+l\right) \alpha=j_{k}+2 l$. Hence $2 l=0$, this is impossible. Therefore $j_{k} \notin X_{n} \alpha$.

Subcase $2.4\left(i_{t} \alpha,\left(i_{t}+l\right) \alpha\right)=\left(j_{k}+2 l, j_{k}+l\right)$ for some $k \in\{1,2, \ldots, s\}$. Suppose that $j_{k} \in X_{n} \alpha$. That is, there exists $x \in X_{n}$ such that $x \alpha=j_{k}$. Since $\left|\left(i_{t}+l\right) \alpha-x \alpha\right|=$ $\left|\left(j_{k}+l\right)-j_{k}\right|=l$, we obtain $\left|\left(i_{t}+l\right)-x\right|=l$. This implies that that $x=i_{t}$ or $x=i_{t}+2 l$. Since $i_{t}+2 l \notin X_{n}$, we have $x=i_{t}$. It follows that $j_{k}=x \alpha=i_{t} \alpha=j_{k}+2 l$ and so $2 l=0$, this is impossible. Hence $j_{k} \notin X_{n} \alpha$.

From Subcases 2.1 and 2.2, we have $u=j_{k}+2 l$ such that $m_{j_{k}}=2$ and $j_{k} \in X_{n} \alpha$. And from Subcases 2.3 and 2.4, we have $u=j_{k}$ such that $m_{j_{k}}=2$ and $j_{k}+2 l \in X_{n} \alpha$.

Theorem 4.10. If ( $n \geq 3$ is an odd integer and $l<\frac{n+1}{2}$ ) or ( $n \geq 4$ is an even integer and $l \leq \frac{n}{2}$ ), then $T_{n}^{*}(l)$ is a regular semigroup.

Proof. Suppose ( $n \geq 3$ is odd integer and $l<\frac{n+1}{2}$ ) or ( $n \geq 4$ is an even integer and $\left.l \leq \frac{n}{2}\right)$. Let $\alpha \in T_{n}^{*}(l)$.
Case 1. $X_{n} \alpha=X_{n}$. Then $\alpha$ is bijective. Since $T_{n}$ is a regular semigroup and $\alpha \in$ $T_{n}^{*}(l) \subseteq T_{n}$, there exists $\beta \in T_{n}$ such that $\alpha=\alpha \beta \alpha$. We prove that $\beta \in T_{n}^{*}(l)$. Let $x, y \in X_{n}$. Then there are $u, v \in X_{n}$ such that $u \alpha=x$ and $v \alpha=y$. Consider

$$
\begin{aligned}
|x-y|=l & \Leftrightarrow|u \alpha-v \alpha|=l \\
& \Leftrightarrow|u(\alpha \beta \alpha)-v(\alpha \beta \alpha)|=l \\
& \Leftrightarrow|(u \alpha \beta) \alpha-(v \alpha \beta) \alpha|=l \\
& \Leftrightarrow|(u \alpha) \beta-(v \alpha) \beta|=l \\
& \Leftrightarrow|x \beta-y \beta|=l .
\end{aligned}
$$

Hence $\beta \in T_{n}^{*}(l)$.
Case 2. $X_{n} \alpha \neq X_{n}$. For $x \in X_{n} \alpha$, we choose and fix $d_{x} \in x \alpha^{-1}$. Thus $d_{x} \alpha=x$ for all $x \in X_{n} \alpha$. For $x \notin X_{n} \alpha$, by Lemma 4.9, we have $\left(x=j \in\{1,2, \ldots, l\}\right.$ such that $m_{j}=2$ and $\left.j+l, j+2 l \in X_{n} \alpha\right)$ or $\left(x=k+2 l\right.$ where $k \in\{1,2, \ldots, l\}$ such that $m_{k}=2$ and $k, k+l \in X_{n} \alpha$ ). Define $\beta \in T_{n}$ by

$$
\beta=\left(\begin{array}{ccccccccc}
v & \cdots & j & j+l & j+2 l & \cdots & k & k+l & k+2 l \\
d_{v} & \cdots & d_{j+2 l} & d_{j+l} & d_{j+2 l} & \cdots & d_{k} & d_{k+l} & d_{k}
\end{array}\right)
$$

where $v \in X_{n} \alpha \backslash\left[\left\{j, j+l, j+2 l: j \notin X_{n} \alpha\right.\right.$ and $\left.m_{j}=2\right\} \cup\{k, k+l, k+2 l: k+2 l \notin$ $X_{n} \alpha$ and $\left.\left.m_{k}=2\right\}\right]$. Let $z \in X_{n}$. Then $z \alpha \in X_{n} \alpha$ and $z(\alpha \beta \alpha)=((z \alpha) \beta) \alpha=\left(d_{z \alpha}\right) \alpha=$ $z \alpha$. Hence $\alpha \beta \alpha=\alpha$. We prove that $\beta \in T_{n}^{*}(l)$. Let $x, y \in X_{n}$. If $x, y \in X_{n} \alpha$, by the same proof as given for Case 1 then is

$$
|x-y|=l \Leftrightarrow|x \beta-y \beta|=l .
$$

Assume that $x \notin X_{n} \alpha$ (or $y \notin X_{n} \alpha$ ). Let $x=j \in\{1,2, \ldots, l\}$ such that $m_{j}=2$ and $j+l, j+2 l \in X_{n} \alpha$. From the proof of Cases 1,2 we have $\left(d_{j+l}, d_{j+2 l}\right) \in\{(a, a+l)$, $(a+l, a),(a+l, a+2 l),(a+2 l, a+l)\} \cup\{(b, b+l),(b+l, b)\}$ for some $a, b \in\{1,2, \ldots, l\}$ such that $m_{a}=2$ and $m_{b}=1$. Thus $\left|d_{j+2 l}-d_{j+l}\right|=l$ where $d_{j+l}, d_{j+2 l} \in A_{a}$ or
$d_{j+l}, d_{j+2 l} \in A_{b}$ such that $m_{a}=2$ and $m_{b}=1$. Then we obtain

$$
\begin{aligned}
|x-y|=l & \Rightarrow|j-y|=l \\
& \Rightarrow y=j+l \\
& \Rightarrow|x \beta-y \beta|=|j \beta-(j+l) \beta|=\left|d_{j+2 l}-d_{j+l}\right|=l .
\end{aligned}
$$

Conversely,

$$
\begin{aligned}
|x \beta-y \beta|=l & \Rightarrow|j \beta-y \beta|=l \\
& \Rightarrow\left|d_{j+2 l}-y \beta\right|=l \\
& \Rightarrow y \beta=d_{j+l} \\
& \Rightarrow y=j+l \\
& \Rightarrow|x-y|=l
\end{aligned}
$$

Let $x=k+2 l$ for some $k \in\{1,2, \ldots, l\}$ such that $m_{k}=2$ and $k, k+l \in X_{n} \alpha$. From the proof of Cases 1, 2 we have $\left(d_{k}, d_{k+l}\right) \in\{(a, a+l),(a+l, a),(a+l, a+2 l)$, $(a+2 l, a+l)\} \cup\{(b, b+l),(b+l, b)\}$ for some $a, b \in\{1,2, \ldots, l\}$ such that $m_{a}=2$ and $m_{b}=1$. Hence $\left|d_{k}-d_{k+l}\right|=l$ where $d_{k}, d_{k+l} \in A_{a}$ or $d_{k}, d_{k+l} \in A_{b}$ such that $m_{a}=2$ and $m_{b}=1$. Then we have

$$
|x-y|=l \Rightarrow|(k+2 l)-y|=l \Rightarrow y=k+l \Rightarrow|x \beta-y \beta|=\left|d_{k}-d_{k+l}\right|=l .
$$

On the other hand,

$$
\begin{aligned}
|x \beta-y \beta|=l & \Rightarrow|(k+2 l) \beta-y \beta|=l \\
& \Rightarrow\left|d_{k}-y \beta\right|=l \\
& \Rightarrow y \beta=d_{k+l} \\
& \Rightarrow y=k+l \\
& \Rightarrow|x-y|=l .
\end{aligned}
$$

Therefore $\beta \in T_{n}^{*}(l)$.

We end this section by showing that $T_{n}^{*}(l)$ is not the largest regular subsemigroup of $T_{n}(l)$.
(a) Let $n=5$ and $l=3$. That is, $l \geq \frac{5+1}{2}$. We define $\alpha=\left(\begin{array}{ccccc}1 & 2 & 3 & 4 & 5 \\ 1 & 1 & 3 & 4 & 4\end{array}\right)$. It is obvious that $\alpha \in T_{5}(3)$ and $\alpha=\alpha \alpha \alpha$. Hence $\alpha$ is a regular element in $T_{5}(3)$ but $\alpha \notin T_{5}^{*}(3)$.
(b) Let $n=6$ and $l=2$. Then $l \leq \frac{6}{2}$. We define $\alpha=\left(\begin{array}{llllll}1 & 2 & 3 & 4 & 5 & 6 \\ 1 & 1 & 3 & 3 & 5 & 5\end{array}\right)$. It is clear that $\alpha \in T_{6}(2)$ and $\alpha=\alpha \alpha \alpha$. Thus $\alpha$ is a regular element in $T_{6}(2)$ but $\alpha \notin T_{6}^{*}(2)$.
