COMPOSITIONS OF RESOLVENTS: FIXED POINTS SETS AND SET OF CYCLES

Abstract

In this paper, we investigate the cycles and fixed point sets of compositions of resolvents using Attouch–Théra duality. We demonstrate that the cycles defined by the resolvent operators can be formulated in Hilbert space as the solution to a fixed point equation. Furthermore, we introduce the relationship between these cycles and the fixed point sets of the composition of resolvents.

1 Introduction

Throughout, we assume that

X is a real Hilbert space with inner product $\langle \cdot, \cdot \rangle : X \times X \to \mathbb{R}$,

and induced norm $\|\cdot\|: X \to \mathbb{R}: x \mapsto \sqrt{\langle x, x \rangle}$. For more details about Hilbert space we refere the redear to [17] and [15]. An operator $T: X \to X$ is *nonexpansive* if it is Lipschitz continuous with constant 1, i.e.,

$$(\forall x \in X) (\forall y \in X) ||Tx - Ty|| \le ||x - y||.$$

Nonexpansive operators have a major role in optimization because of the set of fixed points Fix $R := \{x \in X \mid x = Rx\}$ usually represents solutions to inclusion problems and optimization. For more details about the nonexpansive operators and the fixed point set we refer the reader to [15, 6, 3, 4, 5, 9, 10, 6, 11, 14, 18, 25] and [1, Chapter 3 and Chapter 6]. Moreover, $T : D \to X$ is *firmly nonexpansive* if

$$(\forall x \in D) (\forall y \in D) ||Tx - Ty||^2 + ||(Id - T)x - (Id - T)y||^2 \le ||x - y||^2.$$
 (2)

Firmly nonexpansive operators are also central because of nice convergence properties for iterates and their correspondence with maximal monotone operators. Recall that a set-valued operator $A : X \rightrightarrows X$ with graph gra A is *monotone* if

$$(\forall (x,u) \in \operatorname{gra} A) (\forall (y,v) \in \operatorname{gra} A) \quad \langle x-y,u-v \rangle \geq 0.$$

Furthermore, *A* is *maximally monotone* if there exists no monotone operator $B : X \rightrightarrows X$ such that gra *B* properly contains gra *A*, i.e., for every $(x, u) \in X \times X$,

$$(x,u) \in \operatorname{gra} A \iff (\forall (y,v) \in \operatorname{gra} A) \ \langle x-y,u-v \rangle \ge 0$$

It is well known that monotone and maximally monotone operators have central roles in various areas of modern nonlinear analysis, see [15], [16], [19], [20], [21], [22], [23], [24], and [26] for background meterial. Let $A : X \rightrightarrows X$ be maximally monotone operator and denote the associated *resolvent* by

$$J_A := (\mathrm{Id} + A)^{-1}.$$
 (3)

In [12], Minty observed that J_A is a firmly nonexpansive operators from X to X. For more information about the relation between firmly nonexpansive mappings and maximally monotone operators, see [13]. The Hilber product space,

$$\mathbf{X} = \Big\{ \mathbf{x} = (x_i)_{i \in I} \ \Big| \ (\forall i \in I) \ x_i \in X \Big\},$$

where $m \in \{2, 3, ...\}$ and $i = \{1, 2, ..., m\}$. Let

$$A_i: X \rightrightarrows X \text{ be maximally monotone operators,}$$
(4)

with resolvents $J_{A_1}, J_{A_2}, \ldots, J_{A_m}$ which we also write more simply as J_1, J_2, \ldots, J_m . Set

$$\mathbf{A} = A_1 \times A_2 \times \cdots \times A_m. \tag{5}$$

Then

$$\mathbf{J}_{\mathbf{A}}: \mathbf{X} \to \mathbf{X}: (x_1, x_2, \dots, x_m) \mapsto (\mathbf{J}_1 x_1, \mathbf{J}_2 x_2, \dots, \mathbf{J}_m x_m).$$
(6)

Define the *circular right-shift operator*

$$\mathbf{R}: (x_1, x_2, \ldots, x_m) \mapsto (x_m, x_1, x_2, \ldots, x_{m-1}).$$
(7)

Define the *fixed point sets of the cyclic compositions of resolvants*:

:

$$F_1 := \operatorname{Fix}(J_1 J_m \dots J_2), \tag{8}$$

$$F_2 := \operatorname{Fix}(J_2 J_1 J_m \dots J_3), \tag{9}$$

$$F_m := \operatorname{Fix}(J_m J_{m-1} \dots J_1). \tag{11}$$

Definition 1.1. [1, Definition 5.1] Let $z_1 \in F_1$. Set $z_2 := J_2 z_1, z_3 := J_3 z_2, \dots, z_{m-1} := J_{m-1} z_{m-2}$, and $z_m := J_m z_{m-1}$. The truple $\mathbf{z} = (z_1, z_2, \dots, z_m) \in \mathbf{X}$ is called *a cycle*.

2 Aim and outline of this paper

Our main results can be summarized as follows

- Theorem 4.1 and Theorem 4.3 sketche the relationship between the cycles and the fixed point sets of the composition of resolvants.
- The cycles that are defined by the resolvant operators can be formulated in Hilbert product space as a solution to a fixed point equation (see Lemma 4.2 and Lemma 4.6).
- We study the set of classical cycles that are defined by using resolvant operators and the set of classical gap vectors see Theorem 5.4.
- If one of the fixed point sets of composition of resolvents is not empty, then the individuals fixed point sets are equal and their intersection is not empty (see Lemma 4.7).
- In Section 5, we use Attouch–Théra duality to study the cycles and the fixed point sets of compositions of resolvents operators.

3 Attouch–Théra duality

Let *A* and *B* be two maximally monotone operators on *X*. The *primal problem* associated with (A, B) is to

find
$$x \in X$$
 such that $0 \in Ax + Bx$. (12)

The set of *primal solutions* associated with (A, B) are the solutions to the corresponding sum problem (12) are defined as

$$psol(A,B) := zer(A,B) = (A,B)^{-1}(0) = \left\{ x \in X \mid 0 \in (A+B)x \right\}$$
(13)

Now define $B^{\otimes} := (-\operatorname{Id}) \circ B \circ (-\operatorname{Id})$ and $B^{-\otimes} := (B^{-1})^{\otimes} = (B^{\otimes})^{-1}$. This allows us to define the *dual pair* of (A, B):

$$(A,B)^* := (A^{-1}, B^{-\emptyset}).$$
(14)

Then the *dual problem* associated with (A, B) is defined to be the primal problem associated with the dual pair $(A^{-1}, B^{-\otimes})$:

find
$$y \in X$$
 such that $0 \in A^{-1}y + B^{-0}y = A^{-1}y - B^{-1}(-y)$. (15)

The set of of *dual solutions* associated with (A, B) are the solutions to the corresponding sum problem (15):

$$dsol(A,B) := psol(A,B)^* = zer (A^{-1} + B^{-\otimes}) = \left\{ y \in X \mid 0 \in (A^{-1} + B^{-\otimes})y \right\}.$$
(16)

Because $(A^{-1})^{-1} = A$, $(A^{\odot})^{\odot} = A$, and $(A^{-\odot})^{-\odot} = A$, we have

$$(A, B)^{**} = (A, B).$$
(17)

Lemma 3.1. Let *A* and *B* be maximally monotone on *X*. Let *x* and *y* in *X*. Then the following hold:

(i) If $psol(A, B) = \{x\}$, then

$$\operatorname{dsol}(A,B) = Ax \cap (-Bx),$$

and

$$\operatorname{dsol}(A,B) = Ax \cap B^{\odot}(-x).$$

(ii) If $dsol(A, B) = \{y\}$, then

$$psol(A, B) = (A^{-1}y) \cap B^{-1}(-y),$$

and

$$\operatorname{psol}(A,B) = (A^{-1}y) \cap (-B^{-\emptyset}(y)).$$

(iii) If $psol(A, B) = \{x\}$ and Ax is a singular then dsol(A, B) = Ax.

(iv) If $psol(A, B) = \{x\}$ and Bx and $B^{\odot}(-x)$ are singular, then

$$\operatorname{dsol}(A,B) = -Bx,$$

and

$$\operatorname{dsol}(A,B) = B^{\mathbb{Q}}(-x).$$

(v) If $dsol(A, B) = \{y\}$ and $A^{-1}y$ is a singelton, then $psol(A, B) = A^{-1}y$. (vi) If $dsol(A, B) = \{y\}$ and $B^{-1}(-y)$ and $(-B^{-0}(y))$ are a singelton, then

$$\operatorname{psol}(A,B) = B^{-1}(-y),$$

and

$$\operatorname{psol}(A,B) = (-B^{-\otimes}(y)).$$

Proof. (i): From (13), we have

$$\begin{aligned} x \in \mathrm{psol}(A, B) \Leftrightarrow (A + B)^{-1}(0) \neq \emptyset \\ \Leftrightarrow \emptyset \neq Ax \cap (-Bx) \\ \Leftrightarrow \emptyset \neq Ax \cap \left((-\mathrm{Id}) \circ B \circ (-\mathrm{Id})(-x) \right) \\ \Leftrightarrow \emptyset \neq Ax \cap B^{\otimes}(-x) \\ \Leftrightarrow \emptyset \neq Ax \cap B^{\otimes}(-x) \subseteq \mathrm{dsol}(A, B). \\ \Leftrightarrow \emptyset \neq Ax \cap (-Bx) \subseteq \mathrm{dsol}(A, B). \end{aligned}$$

Since $psol(A, B) = \{x\}$ and by using (13), we obtain $Ax \cap (-Bx) = dsol(A, B)$, and $Ax \cap B^{\odot}(-x) = dsol(A, B)$. (ii): From (16), we have

$$\begin{split} y \in \operatorname{dsol}(A,B) \Leftrightarrow (A^{-1} + B^{-\heartsuit})^{-1}(0) \neq \varnothing \\ \Leftrightarrow A^{-1}(y) \cap (-B^{-\heartsuit}(y)) \neq \varnothing \\ \Leftrightarrow A^{-1}(y) \cap B^{-1}(-y) \neq \varnothing \\ \Leftrightarrow \varnothing \neq A^{-1}(y) \cap B^{-1}(-y) \subseteq \operatorname{psol}(A,B) \end{split}$$

Since $dsol(A, B) = \{y\}$ and by using (16), we obtain

$$A^{-1}(y) \cap B^{-1}(-y) = \text{psol}(A, B),$$

(iii): From (i), we have $Ax \cap (-Bx) = dsol(A, B)$, and $Ax \cap B^{\odot}(-x) = dsol(A, B)$. Since Ax is a singelton then we obtain

$$\operatorname{dsol}(A,B) = Ax \cap (-Bx) = Ax,$$

and

$$\operatorname{dsol}(A, B) = Ax \cap B^{\odot}(-x) = Ax.$$

(iv): From (i), we have $Ax \cap (-Bx) = dsol(A, B)$, and $Ax \cap B^{\otimes}(-x) = dsol(A, B)$. Since Bx and $B^{\otimes}(-x)$ are singleton then we obtain

$$\operatorname{dsol}(A,B) = Ax \cap (-Bx) = -Bx,$$

and

$$\operatorname{dsol}(A,B) = Ax \cap B^{\odot}(-x) = B^{\odot}(-x).$$

(v): From (ii), we have $(A^{-1}y) \cap B^{-1}(-y) = \text{psol}(A, B)$, and $(A^{-1}y) \cap (-B^{-\emptyset}(y)) = \text{dsol}(A, B)$. Since $A^{-1}y$ is a singleton then we obtain

$$psol(A, B) = (A^{-1}y) \cap B^{-1}(-y) = A^{-1}y,$$

and

$$psol(A, B) = (A^{-1}y) \cap (-B^{-\emptyset}(y)) = A^{-1}y.$$

(vi): From (ii), we have $(A^{-1}y) \cap B^{-1}(-y) = \text{psol}(A, B)$, and $(A^{-1}y) \cap (-B^{-\emptyset}(y)) = \text{dsol}(A, B)$. Since $B^{-1}(-y)$ and $(-B^{-\emptyset}(y))$ are singelton then we obtain

$$psol(A, B) = (A^{-1}y) \cap B^{-1}(-y) = B^{-1}(-y),$$

and

$$\operatorname{psol}(A,B) = (A^{-1}y) \cap (-B^{-\varpi}(y)) = -B^{-\varpi}(y).$$

For more information about the Attouch–Théra duality, we refer the reader to [8].

4 Correspondence of Properties and Results

Theorem 4.1. The following are equivalent

- (i) Cycle exists.
- (ii) The fixed point sets of cyclic compositions of resolvants $F_i \neq \emptyset$ for all $1 \le i \le m$.

Proof. "(i) \Rightarrow (ii)": Let $\mathbf{z} = (z_1, z_2, \dots, z_{m-1}, z_m)$ be a cycle. Then by Definition 1.1, we have $z_1 = J_1 z_m, z_2 = J_2 z_1, z_3 = J_3 z_2, \dots, z_{m-1} = J_{m-1} z_{m-2}$, and $z_m = J_m z_{m-1}$. This gives that

$$z_1 = J_1 J_m \dots J_3 J_2 z_1$$

$$z_2 = J_2 J_1 \dots J_4 J_3 z_2$$

_ _

$$\vdots$$

$$z_i = J_i J_{i-1} \dots J_1 J_m \dots J_{i+1} z_i$$

$$\vdots$$

$$z_m = J_m J_{m-1} \dots J_2 J_1 z_m.$$

Therefore, $z_1 \in F_1, z_2 \in F_2, \ldots, z_i \in F_i, \ldots, z_m \in F_m$ by (8)-(11). This implies that $F_1 \neq \emptyset$, $F_2 \neq \emptyset, \ldots, F_i \neq \emptyset, \ldots, F_m \neq \emptyset$. " (ii) \Rightarrow (i)": Let $F_m \neq \emptyset$ and $z_m \in F_m$. Then

$$z_m \in \operatorname{Fix}\left(\operatorname{J}_m\operatorname{J}_{m-1}\ldots\operatorname{J}_2\operatorname{J}_1\right)z_m$$
,

by (11). Therefore,

$$z_m = \mathbf{J}_m \mathbf{J}_{m-1} \dots \mathbf{J}_2 \mathbf{J}_1 z_m$$

Next, Applying J_1 we obtain

$$\mathbf{J}_1 \mathbf{z}_m = \mathbf{J}_1 \left(\mathbf{J}_m \mathbf{J}_{m-1} \dots \mathbf{J}_2 \right) \left(\mathbf{J}_1 \mathbf{z}_m \right),$$

which is equivalent to $J_1 z_m \in Fix (J_1 J_m J_{m-1} \dots J_3 J_2) \Leftrightarrow J_1 z_m \in F_1 \neq \emptyset$. Additionally, let $z_2 \in F_2$ such that $z_2 = J_2 z_1$. Keep doing this we obtain,

$$z_{m-2} = \mathbf{J}_{m-2}\mathbf{J}_{m-3}\dots\mathbf{J}_1\mathbf{J}_m\mathbf{J}_{m-1}z_{m-2}.$$

Then,

$$\mathbf{J}_{m-1}z_{m-2} = \mathbf{J}_{m-1}(\mathbf{J}_{m-2}\mathbf{J}_{m-3}\dots\mathbf{J}_{1}\mathbf{J}_{m})(\mathbf{J}_{m-1}z_{m-2}),$$

and $J_{m-1}z_{m-2} \in \text{Fix} (J_{m-1}J_{m-2}J_{m-3}...J_1J_m)$, which is equivalent to $J_{m-1}J_{m-2} \in F_{m-1} \neq \emptyset$. Moreover, let $z_{m-1} \in F_{m-1}$ such that $z_{m-1} = J_{m-1}z_{m-2}$. Then we obtain

$$z_{m-1} = \mathbf{J}_{m-1}\mathbf{J}_{m-2}\mathbf{J}_{m-3}\dots\mathbf{J}_{1}\mathbf{J}_{m}z_{m-1}$$

and

$$J_m z_{m-1} = J_m (J_{m-1} J_{m-2} J_{m-3} \dots J_1) J_m z_{m-1}$$

Therefore,

$$\mathbf{J}_m \mathbf{z}_{m-1} \in \mathrm{Fix} \left(\mathbf{J}_m \mathbf{J}_{m-1} \mathbf{J}_{m-2} \mathbf{J}_{m-3} \dots \mathbf{J}_1 \right).$$

This is equivalent to $J_m z_{m-1} \in Fix F_m \neq \emptyset$. All these together give $(z_1, z_2, ..., z_{m-1}, z_m) \in \mathbf{X}$ satisfying that

$$(z_1, z_2, \ldots, z_{m-1}, z_m) = (J_1 z_m, J_2 z_1, \ldots, J_{m-1} z_{m-2}, J_m z_{m-1}).$$

Lemma 4.2. Let $z \in X$ is a cycle. Then

$$\mathbf{z} = \mathbf{J}_{\mathbf{A}}(\mathbf{R}\mathbf{z}),\tag{18}$$

and solving (18) is equivalent to solve

$$0 \in \mathbf{A}(\mathbf{z}) + (\mathrm{Id} - \mathbf{R})(\mathbf{z}). \tag{19}$$

Proof. Given that $\mathbf{z} = (z_1, z_2, ..., z_m) \in \mathbf{X}$ is a cycle. Then Definition 1.1 gives that $z_1 = J_1 z_m, z_2 = J_2 z_1, z_3 = J_3 z_2, ..., z_{m-1} = J_{m-1} z_{m-2}$, and $z_m = J_m z_{m-1}$. Hence,

$$\mathbf{z} = (z_1, z_2, \dots, z_{m-1}, z_m) = (J_1 z_m, J_2 z_1, \dots, J_{m-1} z_{m-2}, J_m z_{m-1})$$

= $(J_1, J_2, \dots, J_{m-1}, J_m) (z_m, z_1, \dots, z_{m-2}, z_{m-1})$
= $J_{\mathbf{A}} (\mathbf{R}(z_1, z_2, \dots, z_{m-1}, z_m))$
= $J_{\mathbf{A}} (\mathbf{Rz}).$

Note that $\mathbf{z} = \mathbf{J}_{\mathbf{A}}(\mathbf{R}\mathbf{z}) \Leftrightarrow \mathbf{z} = (\mathbf{Id} + \mathbf{A})^{-1}(\mathbf{R}\mathbf{z})$ by (3). Therefore, we obtain

 $\mathbf{R}\mathbf{z} \in \mathbf{z} + \mathbf{A}(\mathbf{z}) \Leftrightarrow \mathbf{0} \in \mathbf{A}(\mathbf{z}) + (\mathbf{Id} - \mathbf{R})(\mathbf{z}).$

Define the set of all cycles by

$$\mathbf{Z} := \operatorname{Fix}(\mathbf{J}_{\mathbf{A}}\mathbf{R}). \tag{20}$$

Define

$$F_i := \{ z \in X \mid z = J_i \dots J_1 J_m \dots J_{i+1} z \}.$$
(21)

Moreover,

÷

$$Q_i: \mathbf{X} \to X: \mathbf{z} \mapsto z_i. \tag{22}$$

The relationship between the fixed point set of composition of *m* resolvants F_i 's and the set of all cycles **Z** are given in the following theorem.

Theorem 4.3. For every $1 \le i, j \le m$, the following hold;

(i) F_i are closed and convex. Moreover,

$$F_m = (J_m J_{m-1} \dots J_3 J_2)(F_1) = (J_m J_{m-1} \dots J_3)(F_2) = \dots = J_m J_{m-1}(F_{m-2}) = J_m(F_{m-1}).$$
(23)

$$F_{m-1} = (J_{m-1} \dots J_3 J_2 J_1)(F_m) = (J_{m-1} \dots J_3 J_2)(F_1) = \dots = J_{m-1}(F_{m-2}).$$
(24)

$$F_{2} = (J_{2}J_{1}J_{m}\dots J_{4})(F_{3}) = (J_{2}J_{1}J_{m}\dots J_{5})(F_{4}) = \dots = J_{2}J_{1}(F_{m}) = J_{2}(F_{1}).$$
(26)

$$F_{1} = (J_{1}J_{m}\dots J_{4}J_{3})(F_{2}) = (J_{1}J_{m}\dots J_{4})(F_{3}) = \dots = (J_{1}J_{m})(F_{m-1}) = J_{1}(F_{m}).$$
(27)

(ii) $\cap_{i=1}^{m} \operatorname{Fix} J_i \subseteq \cap_{i=1}^{m} F_i$ and if $F_i = \emptyset$, then $\cap_{i=1}^{m} \operatorname{Fix} J_i = \emptyset$.

(iii) For $1 \le i \le m - 1$, $J_{i+1}(F_i) = (F_{i+1})$, and $J_1(F_m) = F_1$. Therefore,

$$\mathbf{J}_{\mathbf{A}}\mathbf{R}(F_1 \times F_2 \times \cdots \times F_m) = F_1 \times F_2 \times \cdots \times F_m.$$
(28)

- (iv) $F_i \neq \emptyset$ if and only if $F_j \neq \emptyset$ if and only if $\mathbf{Z} = \emptyset$.
- (v) **Z** is closed and convex, and $\mathbf{Z} \subseteq F_1 \times F_2 \times \cdots \times F_m$.
- (vi) The mapping $Q_i|_{\mathbf{Z}} : \mathbf{Z} \to F_i$ is bijective and $Q_i(\mathbf{Z}) = F_i$.

Proof. (i): Since each J_i is firmly nonexpansive, so nonexpansive, then by [18, Lemma 2.1.12 (ii)], the composition

$$J_i \dots J_1 J_m \dots J_{i+1}$$

is nonexpansive. Then by [18, Proposition 2.1.11] F_i is closed and convex. Let $x \in F_m \Leftrightarrow x \in \text{Fix} (J_m J_{m-1} \dots J_3 J_2 J_1) \Leftrightarrow x = J_m J_{m-1} \dots J_3 J_2 J_1 x$. Then,

$$J_1 x = J_1 (J_m J_{m-1} \dots J_3 J_2 J_1) x = (J_1 J_m J_{m-1} \dots J_3 J_2) (J_1 x)$$

Therefore, $J_1 x \in Fix (J_1 J_m J_{m-1} \dots J_3 J_2) \Leftrightarrow J_1 x \in F_1$. It follows that

$$\mathbf{J}_1(F_m) \subseteq F_1 \tag{29}$$

Moreover,

$$(J_{2}J_{1})(F_{m}) = (J_{2}J_{1})(\operatorname{Fix}(J_{m}J_{m-1}\dots J_{2}J_{1})) \subseteq J_{2}(\operatorname{Fix}(J_{1}J_{m}J_{m-1}\dots J_{3}J_{2}))$$
(30)

$$\subseteq \operatorname{Fix}\left(J_2J_1J_mJ_{m-1}\ldots J_4J_3\right) = F_2, \quad (31)$$

hence

$$(J_{3}J_{2}J_{1})(F_{m}) = (J_{3}J_{2}J_{1})(\operatorname{Fix}(J_{m}J_{m-1}\dots J_{2}J_{1})) \subseteq (J_{3}J_{2})(\operatorname{Fix}(J_{1}J_{m}J_{m-1}\dots J_{3}J_{2}))$$
(32)

$$\subseteq J_3(\operatorname{Fix}(J_2J_1J_mJ_{m-1}\dots J_4J_3)) \tag{33}$$

$$\subseteq \operatorname{Fix}\left(J_3 J_2 J_1 J_m J_{m-1} \dots J_5 J_4\right) = F_3, \quad (34)$$

until finally

$$F_m = \operatorname{Fix}\left(J_m J_{m-1} \dots J_2 J_1 = \left(J_m J_{m-1} \dots J_2 J_1\right)\left(\operatorname{Fix}\left(J_m J_{m-1} \dots J_2 J_1\right)\right)$$
(35)

$$\subseteq (J_m J_{m-1} \dots J_2) (\operatorname{Fix} (J_1 J_m \dots J_3 J_2))$$
(36)

$$\subseteq J_m(\operatorname{Fix}(J_{m-1}J_{m-2}\dots J_2J_1J_m)) = J_m(F_{m-1})$$
(38)

$$\subseteq \operatorname{Fix}\left(\mathbf{J}_{m}\mathbf{J}_{m-1}\dots\mathbf{J}_{2}\mathbf{J}_{1}\right) = F_{m}.$$
(39)

÷

Hence, equality holds throughout (35)-(39) and we are done. The same approach will verify (24)-(27).

(ii): It is well known that $\bigcap_{i=1}^{m} \operatorname{Fix} J_i \subseteq F_1$, $\bigcap_{i=1}^{m} \operatorname{Fix} J_i \subseteq F_2$, \cdots , $\bigcap_{i=1}^{m} \operatorname{Fix} J_i \subseteq F_m$. Hence

$$\bigcap_{i=1}^m \operatorname{Fix} \operatorname{J}_i \subseteq \bigcap_{i=1}^m F_i.$$

This also implies that $\bigcap_{i=1}^{m} \operatorname{Fix} J_i = \emptyset$ if $F_i = \emptyset$. (iii): From (i), we have

$$J_1(F_m) = F_1, \quad J_2(F_1) = F_2, \quad \dots, \quad J_m(F_{m-1}) = F_m.$$
 (40)

Using (6), (7) and (40), we obtain

$$J_{\mathbf{A}}\mathbf{R}(F_1 \times F_2 \times \cdots \times F_{m-1} \times F_m) = J_{\mathbf{A}}(F_m \times F_1 \times F_2 \times \cdots \times F_{m-1})$$

= $(J_1, J_2, \cdots, J_m)(F_m \times F_1 \times F_2 \times \cdots \times F_{m-1})$
= $F_1 \times F_2 \times \cdots \times F_{m-1} \times F_m.$

(iv): Clear from the definition of F_i , F_j and **Z**.

(v): Since $J_A \mathbf{R}$ is nonexpansive and because $\mathbf{Z} = \text{Fix } J_A \mathbf{R}$, by [18, Proposition 2.1.11], \mathbf{Z} is closed and convex. Moreover, let $\mathbf{z} = (z_1, z_2, \dots, z_m) \in \text{Fix } J_A \mathbf{R} \Leftrightarrow \mathbf{z} = J_A \mathbf{R} \mathbf{z}$. This implies

$$z_{1} = J_{1}J_{m} \dots J_{2}z_{1},$$

$$\vdots$$

$$z_{i} = J_{i}J_{i-1} \dots J_{1}J_{m} \dots J_{i+1}z_{i},$$

$$\vdots$$

$$z_{m} = J_{m}J_{m-1} \dots J_{1}z_{m}.$$

Hence, $\mathbf{z} = (z_1, z_2, ..., z_m) \in F_1 \times F_2 \times \cdots \times F_{m-1} \times F_m$. Since this is true for all $\mathbf{z} \in \mathbf{Z}$, therefore,

$$\mathbf{Z} \subseteq F_1 \times F_2 \times \cdots \times F_{m-1} \times F_m.$$

(vi): It is clear that (i) that $Q_i : \mathbf{Z} \to F_i$ is surjective. To show Q_i is injective, suppose $\mathbf{z} = (z_1, z_2, ..., z_m), \, \widetilde{\mathbf{z}} = (\widetilde{z}_1, \widetilde{z}_2, ..., \widetilde{z}_m) \in \mathbf{Z}$ and $Q_i(\mathbf{z}) = Q_i(\widetilde{\mathbf{z}}) \Rightarrow z_i = \widetilde{z}_i$. Because \mathbf{z} and $\widetilde{\mathbf{z}}$ are cycles then we obtain

$$z_{i+1} = \mathbf{J}_{i+1} z_i = \mathbf{J}_{i+1} \widetilde{z}_i = \widetilde{z}_{i+1}$$

$$\tag{41}$$

$$z_m = J_m z_{m-1} = J_m \widetilde{z}_{m-1} = \widetilde{z}_m \tag{43}$$

$$z_1 = \mathbf{J}_1 z_m = \mathbf{J}_1 \widetilde{z}_m = \widetilde{z}_1 \tag{44}$$

$$z_2 = J_2 z_1 = J_2 \widetilde{z}_1 = \widetilde{z}_2 \tag{45}$$

$$z_{i-1} = J_{i-1} z_{i-2} = J_{i-1} \tilde{z}_{i-2} = \tilde{z}_{i-1},$$
(47)

hence from (41)-(47), we have

 $\mathbf{z} = \widetilde{\mathbf{z}}.$

Lemma 4.4. Let $\bigcap_{i=1}^{m} \operatorname{Fix} J_i \neq \emptyset := D$. Then the following are hold:

- (i) We have $F_i = D$ for every $1 \le i \le m$. (ii) $\mathbf{Z} = \{(z, z, \cdots, z) \mid z \in D\} = D^m \cap \Delta$.

Proof. (i): J_i is firmly nonexpansive for every $1 \le i \le m$, then by [15, Corollary 4.51], we have <...))

$$(\forall (1 \leq i \leq m)), \text{ Fix } (J_i J_{i-1} \cdots J_1 J_m \cdots J_{i+1}) = D.$$

(ii): Let $\mathbf{z} = (z_1, z_2, \cdots, z_m) \in \mathbf{Z}$. Then,

$$z_{1} = J_{1}J_{m}J_{m-1}\cdots J_{2}z_{1} \Leftrightarrow z_{1} \in F_{1} = D$$

$$z_{2} = J_{2}J_{1}J_{m}\cdots J_{3}z_{2} \Leftrightarrow z_{2} \in F_{2} = D$$

$$\vdots$$

$$z_{m} = J_{m}J_{m-1}J_{m-2}\cdots J_{1}z_{m} \Leftrightarrow z_{m} \in F_{m} = D,$$

hence,

$$\mathbf{z} = (z_1, z_2, \cdots, z_m) \in F_1 \times F_2 \times \cdots \times F_m = D \times U \times D \times \cdots \times D = D^m.$$

Moreover,

$$\mathbf{z} = (z_1, z_2, \cdots, z_m) = (z, z, \cdots, z) \in \mathbf{D}.$$

Therefore,

$$\mathbf{z} \in D^m \cap \mathbf{D}.$$

Remark 4.5. When m = 2, we have $J_1(F_2) = F_1$, and $J_2(F_1) = F_2$.

Proof. Let $z \in F_1$ and $\tilde{z} \in F_2$, then we have $z = J_1J_2z$ and $J_2z = J_2J_1(J_2z)$. Therefore,

$$J_2(F_1) \subseteq F_2 \tag{48}$$

Moreover, $\tilde{z} \in F_2$, then we have $\tilde{z} = J_2 J_1 \tilde{z}$ and $J_1 \tilde{z} = J_1 J_2 (J_1 \tilde{z})$. Thus,

$$\mathbf{J}_1(F_2) \subseteq F_1 \tag{49}$$

Now apply J_1 and J_2 to (48) and (49) respectively, we get

$$F_1 \subseteq J_1(F_2)$$
 and $F_2 \subseteq J_2(F_1)$

Hence, we have $F_1 = J_1(F_2)$ and $F_2 = J_2(F_1)$.

Lemma 4.6. Recall from (20) that $\mathbf{Z} = \text{Fix } J_{\mathbf{A}} \mathbf{R}$. Then we have

$$\mathbf{Z} = \operatorname{Fix} J_{\mathbf{A}} \mathbf{R} = \operatorname{Fix} J_{\frac{1}{2}\mathbf{A}} \left(\frac{\mathbf{Id} + \mathbf{R}}{2} \right).$$

Proof. Let $\mathbf{x} \in \text{Fix}(\mathbf{J}_A \mathbf{R})$, then

$$\begin{split} \mathbf{x} &= J_A \mathbf{R} \mathbf{x} \Leftrightarrow \mathbf{R} \mathbf{x} \in \mathbf{x} + \mathbf{A} \mathbf{x} \Leftrightarrow \mathbf{0} \in (\mathbf{x} - \mathbf{R} \mathbf{x}) + \mathbf{A}(\mathbf{x}) \\ & \Leftrightarrow \mathbf{0} \in \frac{(\mathbf{x} - \mathbf{R} \mathbf{x})}{2} + \frac{\mathbf{A}(\mathbf{x})}{2} \\ & \Leftrightarrow \mathbf{0} \in \mathbf{x} - \left(\frac{\mathbf{I} \mathbf{d} + \mathbf{R}}{2}\right) \mathbf{x} + \frac{\mathbf{A}(\mathbf{x})}{2} \quad \text{adding and subtracting } \frac{\mathbf{x}}{2} \\ & \Leftrightarrow \left(\frac{\mathbf{I} \mathbf{d} + \mathbf{R}}{2}\right) \mathbf{x} \in \left(\mathbf{I} \mathbf{d} + \frac{1}{2} \mathbf{A}\right)(\mathbf{x}) \\ & \Leftrightarrow \mathbf{x} = J_{\frac{1}{2}\mathbf{A}} \left(\frac{\mathbf{I} \mathbf{d} + \mathbf{R}}{2}\right)(\mathbf{x}) \\ & \Leftrightarrow \mathbf{x} \in \operatorname{Fix} J_{\frac{1}{2}\mathbf{A}} \left(\frac{\mathbf{I} \mathbf{d} + \mathbf{R}}{2}\right). \end{split}$$

Lemma 4.7. Suppose that Fix $J_i \neq \emptyset$ for each $1 \le i \le m$. Then, the following are equivalent

(i) $\cap_{i=1}^{m} \operatorname{Fix} \mathbf{J}_{i} \neq \emptyset$. (ii) $F_{1} = F_{2} = \cdots = F_{m} \neq \emptyset$.

Proof. (i): Let $\bigcap_{i=1}^{m}$ Fix $J_i \neq \emptyset \Rightarrow F_1 \neq \emptyset$, $F_2 \neq \emptyset$, \cdots , $F_m \neq \emptyset$ and from Lemma 4.4(i), we have

$$F_1 = F_2 = \cdots = F_m = \bigcap_{i=1}^m \operatorname{Fix} \operatorname{J}_i.$$

(ii): Let $F_1 = F_2 = \cdots = F_m \neq \emptyset$. Then, by Theorem 4.3 (iv) we have $\mathbf{Z} \neq \emptyset$

5 Consequences of Attouch-Théra duality

Recall (5) that

$$\mathbf{A} = A_1 \times A_2 \times \cdots \times A_m$$

From now on, suppose that

A is maximally monotone on **X**,
$$(50)$$

and

$$\mathbf{C} := \operatorname{zer} \mathbf{A} \text{ is not empty.}$$
(51)

Recall (20) that

$$\mathbf{Z} := \operatorname{Fix}(\mathbf{J}_{\mathbf{A}}\mathbf{R}).$$

Proposition 5.1. The following holds:

(i) $\mathbf{Z} = \operatorname{psol}(\mathbf{Id} - \mathbf{R})$.

(ii) $\mathbf{A} + \mathbf{Id} - \mathbf{R}$ is maximally monotone.

(iii) Z is closed and convex.

Proof. (i): Combine Lemma 4.2 and (13). (ii): Note that Id - R is linear, full domain, and maximally monotone by [1, Theorem 7.1]. Moreover, **A** is maximally monotone by assumption. Therefore, the sum is maximally monotone by [15, Corollary 25.5 (i)] (iii): It follows directly from (i) and Theorem 4.3 (v).

Theorem 5.2. Recall from Lemma 4.2, the primal (Attouch-Théra) problem,

 $0 \in \mathbf{A}(\mathbf{z}) + (\mathbf{Id} - \mathbf{R})(\mathbf{z}),$

for the pair (A, Id - R). Then the Attouch-Théra dual problem is

$$0 \in \mathbf{A}^{-1}(\mathbf{y}) + (\mathbf{Id} - \mathbf{R})^{-1}(\mathbf{y})$$
(52)

or,

$$0 \in \left(\mathbf{A}^{-1} + N_{\mathbf{D}^{\perp}}\right)(\mathbf{y}) + \left(\frac{1}{2}\mathbf{Id} + \mathbf{T}\right)(\mathbf{y})$$
(53)

Moreover,

$$\operatorname{dsol}(\mathbf{A}, \mathbf{Id} - \mathbf{R}) = \operatorname{zer}\left(\mathbf{A}^{-1} + N_{\mathbf{D}^{\perp}} + \frac{1}{2}\mathbf{Id} + \mathbf{T}\right).$$
(54)

Proof. The dual pair of $(\mathbf{A}, (\mathbf{Id} - \mathbf{R}))$ is

$$(\mathbf{A}, (\mathbf{Id} - \mathbf{R}))^* = (\mathbf{A}^{-1}, (\mathbf{Id} - \mathbf{R})^{-\mathbb{Q}}).$$

Because of the linearity of **R**, we have

$$(\mathbf{Id} - \mathbf{R})^{- \odot} = (-\mathbf{Id}) \circ (\mathbf{Id} - \mathbf{R})^{-1} \circ (-\mathbf{Id}) = (\mathbf{Id} - \mathbf{R})^{-1}.$$

Hence, Attouch-Théra dual problem simplifies to

$$0 \in \mathbf{A}^{-1}(\mathbf{y}) + (\mathbf{Id} - \mathbf{R})^{-1}(\mathbf{y}).$$

From [2, Theorem 2.8 (i)], we have

$$\begin{split} 0 \in \mathbf{A}^{-1}\big(\mathbf{y}\big) + \big(\mathbf{Id} - \mathbf{R}\big)^{-1}\big(\mathbf{y}\big) &\Leftrightarrow 0 \in \mathbf{A}^{-1}\big(\mathbf{y}\big) + \Big(\mathbf{N}_{\mathbf{D}^{\perp}} + \frac{1}{2}\mathbf{Id} + \mathbf{T}\Big)\big(\mathbf{y}\big) \\ &\Leftrightarrow 0 \in \big(\mathbf{A}^{-1} + \mathbf{N}_{\mathbf{D}^{\perp}}\big)(\mathbf{y}) + \Big(\frac{1}{2}\mathbf{Id} + \mathbf{T}\Big)(\mathbf{y}), \end{split}$$

which verifies (53). Next, by (16), (52), and (53), we have

$$dsol(\mathbf{A}, \mathbf{Id} - \mathbf{R}) = zer \left(\mathbf{A}^{-1} + \left(\mathbf{Id} - \mathbf{R} \right)^{-1} \right)$$
$$= zer \left(\mathbf{A}^{-1} + \mathbf{N}_{\mathbf{D}^{\perp}} + \frac{1}{2}\mathbf{Id} + \mathbf{T} \right).$$

Proposition 5.3. The solution set of (52) is at most a tmost a sigleton and possibly empty.

Proof. See [1, Proposition 9.2].

Theorem 5.4. Let psol(A, Id - R) = Z and recall from (54) that

$$\operatorname{dsol}(\mathbf{A}, \mathbf{Id} - \mathbf{R}) = \operatorname{zer}\left(\mathbf{A}^{-1} + \mathbf{N}_{\mathbf{D}^{\perp}} + \frac{1}{2}\mathbf{Id} + \mathbf{T}\right).$$

Then

$$dsol(Id - R) = (R - Id)Z = \begin{cases} \left\{ J_{2(A^{-1} + N_{D^{\perp}} + T)}(0) \right\}, & \text{if } Z \neq \emptyset \\ \emptyset, & \text{if } Z = \emptyset \end{cases}$$
(55)

Moreover, if $y^*:=J_{2(A^{-1}+N_{D^\perp}+T)}(0)$ exists, then the following are hold:

- (i) $\mathbf{y}^* \in \mathbf{D}^{\perp}$. (ii) \mathbf{y}^* is the only vector that makes $\mathbf{A}^{-1}\mathbf{y} \cap -(\mathbf{N}_{\mathbf{D}^{\perp}}\mathbf{y} + \frac{1}{2}\mathbf{y} + \mathbf{T}\mathbf{y})$, nonempty

(iii)
$$\mathbf{Z} = \mathbf{A}^{-1}\mathbf{y}^* \cap (-\frac{1}{2}\mathbf{y}^* - \mathbf{T}\mathbf{y}^* - \mathbf{D})$$

Proof. By using (16), we have $\mathbf{y} \in dsol(\mathbf{A}, \mathbf{Id} - \mathbf{R})$ gives

$$\begin{split} \mathbf{0} &\in \mathbf{A}^{-1}(\mathbf{y}) + (\mathbf{Id} - \mathbf{R})^{-1}(\mathbf{y}) \quad (\forall \mathbf{z} \in \mathbf{Z}) \\ \Leftrightarrow \mathbf{z} &\in \mathbf{A}^{-1}(\mathbf{y}) \text{ and } -\mathbf{z} \in (\mathbf{Id} - \mathbf{R})^{-1}(\mathbf{y}) \quad (\forall \mathbf{z} \in \mathbf{Z}) \\ \Leftrightarrow \mathbf{y} &\in \mathbf{A}(\mathbf{z}) \text{ and } \mathbf{y} = (\mathbf{Id} - \mathbf{R})(-\mathbf{z}) \quad (\forall \mathbf{z} \in \mathbf{Z}), \end{split}$$

hence, for all $z \in Z$, we obtain

$$\mathbf{y} = \mathbf{R}\mathbf{z} - \mathbf{z}$$

and

$$\mathrm{dsol}ig(\mathrm{Id}-\mathbf{R}ig) = \cup_{\mathbf{z}\in\mathbf{Z}}\{\mathbf{Rz}-\mathbf{z}\mid\mathbf{z}\in\mathbf{Z}\}\ = (\mathbf{R}-\mathrm{Id})\mathbf{Z}.$$

Additionally, if $\mathbf{Z} \neq \emptyset$, then using [2, Theorem 2.4] and (3) gives

$$\begin{split} \mathbf{0} &\in \mathbf{A}^{-1}(\mathbf{y}) + (\mathbf{Id} - \mathbf{R})^{-1}(\mathbf{y}) \\ \Leftrightarrow \mathbf{0} &\in \mathbf{A}^{-1}(\mathbf{y}) + \left(\frac{1}{2}\mathbf{Id} + \mathbf{T} + \mathbf{N}_{\mathbf{D}^{\perp}}\right)(\mathbf{y}) \\ \Leftrightarrow \mathbf{0} &\in \left(\mathbf{Id} + 2\left(\mathbf{A}^{-1} + \mathbf{T} + \mathbf{N}_{\mathbf{D}^{\perp}}\right)\right)(\mathbf{y}) \\ \Leftrightarrow \mathbf{y} &= \left(\mathbf{Id} + 2\left(\mathbf{A}^{-1} + \mathbf{T} + \mathbf{N}_{\mathbf{D}^{\perp}}\right)\right)^{-1}(\mathbf{0}) \\ \Leftrightarrow \mathbf{y} &= \mathbf{J}_{2(\mathbf{A}^{-1} + \mathbf{T} + \mathbf{N}_{\mathbf{D}^{\perp}})}(\mathbf{0}) \end{split}$$

However, if $\mathbf{Z} = \emptyset$, then using [7, Proposition 2.4 (v)]

$$\emptyset = \operatorname{dsol}(\mathbf{A}, \mathbf{Id} - \mathbf{R}) = \operatorname{dsol}(\mathbf{Id} - \mathbf{R}).$$

(i): By [2, Theorem 2.7], we have dom $(\mathbf{Id} - \mathbf{R})^{-1} = \mathbf{D}^{\perp}$. This implies that

$$\mathbf{y} \in \mathbf{D}^{\perp}$$
.

(ii): Combine Proposition 5.3 and [7, Proposition 2.4].

(iii): Combine (i), (ii), and [1, Proposition 9.3 (i)] where N_{C}^{-1} is replaced by A^{-1} .

Lemma 5.5. Denote by $\mathbf{y}^* = (y_1, y_2, \dots, y_m)$ the unique solution of (53). Then the following hold:

(i) The mapping $J_1 : F_m \to F_1$ is bijective on F_m and it is given by $J_1(z) = z - y_1$. Moreover, for $1 \le i \le m - 1$ the mapping $J_{i+1} : F_i \to F_{i+1}$ is bijective and is given by $J_{i+1}(z) = z - y_{i+1}$. (ii) The fixed point sets $F_1 = F_m - y_1$ and $F_{i+1} = F_i - y_{i+1}$.

Proof. (i): Let z and \tilde{z} be in F_m satisfying that $J_1 z = J_1 \tilde{z}$. Our goal is to show that J_1 is injective on F_m . Then, we have

$$z = \mathbf{J}_m \mathbf{J}_{m-1} \cdots \mathbf{J}_i \mathbf{J}_{i-1} \cdots \mathbf{J}_1 z$$

and

$$\widetilde{z} = \mathbf{J}_m \mathbf{J}_{m-1} \cdots \mathbf{J}_i \mathbf{J}_{i-1} \cdots \mathbf{J}_1 \widetilde{z}.$$

Since $J_1z = J_1\tilde{z}$, then we obtain $z = \tilde{z}$. Thus, J_1 is an injective mapping on F_m . Moreover, Remark 4.5 shows that J_1 is a surjective mapping on F_m . Therefore, J_1 is a bijective mapping on F_m . For every $z \in F_m$, we have

$$z = J_m J_{m-1} \cdots J_i J_{i-1} \cdots J_1 z.$$
(56)

Set $z_1 = J_1 z$, $z_2 = J_2 z_1$, \cdots , $z_{m-1} = J_{m-1} z_{m-2}$, $z_m = J_m z_{m-1}$. Therefore, using (56), we have $z = J_m z_{m-1}$ and $\mathbf{z} = (z_1, z_2, \cdots, z_{m-1}, z)$. Therefore, Theorem 5.4 gives

$$(y_1, y_2, \cdots, y_m) = (z, z_1, z_2, \cdots, z_{m-1}) - (z_1, z_2, \cdots, z_{m-1}, z_m)$$

and therefore, $y_1 = z - z_1 \Rightarrow z_1 = z - y_1 \Rightarrow J_1 z = z - y_1$. The proof of J_i is the same as J_1 . (ii): It follows from (i) that for every $z \in F_m$, we obtain $J_1 z = z - y_1$. Then by Theorem 4.3(iii) we have $F_1 = F_m - y_1$. The proof for $F_{i+1} = F_i - y_{i+1}$ is the same as F_1 .
