# Compositions of Resolvents: Fixed Points Sets and Set of Cycles

#### Abstract

In this paper, we investigate the cycles and fixed point sets of compositions of resolvents using Attouch-Théra duality. We demonstrate that the cycles defined by the resolvent operators can be formulated in Hilbert space as the solution to a fixed point equation. Furthermore, we introduce the relationship between these cycles and the fixed point sets of the composition of resolvents.

## 1 Introduction

Throughout, we assume that

$$
X \text { is a real Hilbert space with inner product }\langle\cdot, \cdot\rangle: X \times X \rightarrow \mathbb{R},
$$

and induced norm $\|\cdot\|: X \rightarrow \mathbb{R}: x \mapsto \sqrt{\langle x, x\rangle}$. For more details about Hilbert space we refere the redear to [17] and [15]. An operator $T: X \rightarrow X$ is nonexpansive if it is Lipschitz continuous with constant 1, i.e.,

$$
\begin{equation*}
(\forall x \in X)(\forall y \in X) \quad\|T x-T y\| \leq\|x-y\| \tag{1}
\end{equation*}
$$

[^0]Nonexpansive operators have a major role in optimization because of the set of fixed points Fix $R:=\{x \in X \mid x=R x\}$ usually represents solutions to inclusion problems and optimization. For more details about the nonexpansive operators and the fixed point set we refer the reader to $[15,6,3,4,5,9,10,6,11,14,18,25]$ and $[1$, Chapter 3 and Chapter 6]. Moreover, $T: D \rightarrow X$ is firmly nonexpansive if

(\forall x \in D)(\forall y \in D)\|T x-T y\|^{2}+\|(\operatorname{Id}-T) x-(\operatorname{Id}-T) y\|^{2} \leq\|x-y\|^{2} \tag{2}
\end{equation*}
$$

Firmly nonexpansive operators are also central because of nice convergence properties for iterates and their correspndence with maximal monotone operators. Recall that a setvalued operator $A: X \rightrightarrows X$ with graph gra $A$ is monotone if

$$
(\forall(x, u) \in \operatorname{gra} A)(\forall(y, v) \in \operatorname{gra} A) \quad\langle x-y, u-v\rangle \geq 0 .
$$

Furthermore, $A$ is maximally monotone if there exists no monotone operator $B: X \rightrightarrows X$ such that gra $B$ properly contains gra $A$, i.e., for every $(x, u) \in X \times X$,

$$
(x, u) \in \operatorname{gra} A \Leftrightarrow(\forall(y, v) \in \operatorname{gra} A)\langle x-y, u-v\rangle \geq 0 .
$$

It is well known that monotone and maximally monotone operators have central roles in various areas of modern nonlinear analysis, see [15], [16], [19], [20], [21], [22], [23], [24], and [26] for background meterial. Let $A: X \rightrightarrows X$ be maximally monotone operator and denote the associated resolvent by

$$
\begin{equation*}
J_{A}:=(\operatorname{Id}+A)^{-1} \tag{3}
\end{equation*}
$$

In [12], Minty observed that $J_{A}$ is a firmly nonexpansive operators from $X$ to $X$. For more information about the relation between firmly nonexpansive mappings and maximally monotone operators, see [13]. The Hilber product space,

$$
\mathbf{X}=\left\{\mathbf{x}=\left(x_{i}\right)_{i \in I} \mid(\forall i \in I) x_{i} \in X\right\}
$$

where $m \in\{2,3, \ldots\}$ and $i=\{1,2, \ldots, m\}$. Let

$$
\begin{equation*}
A_{i}: X \rightrightarrows X \text { be maximally monotone operators, } \tag{4}
\end{equation*}
$$

with resolvents $\mathrm{J}_{A_{1}}, \mathrm{~J}_{A_{2}}, \ldots, \mathrm{~J}_{A_{m}}$ which we also write more simply as $\mathrm{J}_{1}, \mathrm{~J}_{2}, \ldots, \mathrm{~J}_{m}$. Set

$$
\begin{equation*}
\mathbf{A}=A_{1} \times A_{2} \times \cdots \times A_{m} \tag{5}
\end{equation*}
$$

Then

$$
\begin{equation*}
\mathrm{J}_{\mathbf{A}}: \mathbf{X} \rightarrow \mathbf{X}:\left(x_{1}, x_{2}, \ldots, x_{m}\right) \mapsto\left(\mathrm{J}_{1} x_{1}, \mathrm{~J}_{2} x_{2}, \ldots, \mathrm{~J}_{m} x_{m}\right) \tag{6}
\end{equation*}
$$

Define the circular right-shift operator

$$
\begin{equation*}
\mathbf{R}:\left(x_{1}, x_{2}, \ldots, x_{m}\right) \mapsto\left(x_{m}, x_{1}, x_{2}, \ldots, x_{m-1}\right) \tag{7}
\end{equation*}
$$

Define the fixed point sets of the cyclic compositions of resolvants:

$$
\begin{align*}
F_{1} & :=\operatorname{Fix}\left(\mathrm{J}_{1} \mathrm{~J}_{m} \ldots \mathrm{~J}_{2}\right),  \tag{8}\\
F_{2} & :=\operatorname{Fix}\left(\mathrm{J}_{2} \mathrm{~J}_{1} \mathrm{~J}_{m} \ldots \mathrm{~J}_{3}\right),  \tag{9}\\
& \vdots  \tag{10}\\
F_{m} & :=\operatorname{Fix}\left(\mathrm{J}_{m} \mathrm{~J}_{m-1} \ldots \mathrm{~J}_{1}\right) . \tag{11}
\end{align*}
$$

Definition 1.1. [1, Definition 5.1] Let $z_{1} \in F_{1}$. Set $z_{2}:=J_{2} z_{1}, z_{3}:=\mathrm{J}_{3} z_{2}, \cdots, z_{m-1}:=$ $\mathrm{J}_{m-1} z_{m-2}$, and $z_{m}:=\mathrm{J}_{m} z_{m-1}$. The truple $\mathbf{z}=\left(z_{1}, z_{2}, \ldots, z_{m}\right) \in \mathbf{X}$ is called a cycle.

## 2 Aim and outline of this paper

Our main results can be summarized as follows

- Theorem 4.1 and Theorem 4.3 sketche the relationship between the cycles and the fixed point sets of the composition of resolvants.
- The cycles that are defined by the resolvant operators can be formulated in Hilbert product space as a solution to a fixed point equation (see Lemma 4.2 and Lemma 4.6).
- We study the set of classical cycles that are defined by using resolvant operators and the set of classical gap vectors see Theorem 5.4.
- If one of the fixed point sets of composition of resolvents is not empty, then the individuals fixed point sets are equal and their intersection is not empty (see Lemma 4.7).
- In Section 5, we use Attouch-Théra duality to study the cycles and the fixed point sets of compositions of resolvents operators.


## 3 Attouch-Théra duality

Let $A$ and $B$ be two maximally monotone operators on $X$. The primal problem associated with $(A, B)$ is to

$$
\begin{equation*}
\text { find } x \in X \text { such that } 0 \in A x+B x \tag{12}
\end{equation*}
$$

The set of primal solutions associated with $(A, B)$ are the solutions to the corresponding sum problem (12) are defined as

$$
\begin{equation*}
\operatorname{psol}(A, B):=\operatorname{zer}(A, B)=(A, B)^{-1}(0)=\{x \in X \mid 0 \in(A+B) x\} \tag{13}
\end{equation*}
$$

Now define $B^{\oplus}:=(-\mathrm{Id}) \circ B \circ(-\mathrm{Id})$ and $B^{-®}:=\left(B^{-1}\right)^{\varnothing}=\left(B^{\varnothing}\right)^{-1}$. This allows us to define the dual pair of $(A, B)$ :

$$
\begin{equation*}
(A, B)^{*}:=\left(A^{-1}, B^{-\otimes}\right) \tag{14}
\end{equation*}
$$

Then the dual problem associated with $(A, B)$ is defined to be the primal problem associated with the dual pair $\left(A^{-1}, B^{-\varnothing}\right)$ :

$$
\begin{equation*}
\text { find } y \in X \text { such that } 0 \in A^{-1} y+B^{-\otimes} y=A^{-1} y-B^{-1}(-y) \tag{15}
\end{equation*}
$$

The set of of dual solutions associated with $(A, B)$ are the solutions to the corresponding sum problem (15):

$$
\begin{equation*}
\operatorname{dsol}(A, B):=\operatorname{psol}(A, B)^{*}=\operatorname{zer}\left(A^{-1}+B^{-\varnothing}\right)=\left\{y \in X \mid 0 \in\left(A^{-1}+B^{-\varnothing}\right) y\right\} \tag{16}
\end{equation*}
$$

Because $\left(A^{-1}\right)^{-1}=A,\left(A^{\varnothing}\right)^{\oplus}=A$, and $\left(A^{-®}\right)^{-®}=A$, we have

$$
\begin{equation*}
(A, B)^{* *}=(A, B) \tag{17}
\end{equation*}
$$

Lemma 3.1. Let $A$ and $B$ be maximally monotone on $X$. Let $x$ and $y$ in $X$. Then the following hold:
(i) If $\operatorname{psol}(A, B)=\{x\}$, then

$$
\mathrm{dsol}(A, B)=A x \cap(-B x)
$$

and

$$
\operatorname{dsol}(A, B)=A x \cap B^{\otimes}(-x)
$$

(ii) If $\operatorname{dsol}(A, B)=\{y\}$, then

$$
\operatorname{psol}(A, B)=\left(A^{-1} y\right) \cap B^{-1}(-y)
$$

and

$$
\operatorname{psol}(A, B)=\left(A^{-1} y\right) \cap\left(-B^{-®}(y)\right)
$$

(iii) If $\operatorname{psol}(A, B)=\{x\}$ and $A x$ is a singelton, then $\operatorname{dsol}(A, B)=A x$.
(iv) If $\operatorname{psol}(A, B)=\{x\}$ and $B x$ and $B^{\otimes}(-x)$ are singelton, then

$$
\operatorname{dsol}(A, B)=-B x
$$

and

$$
\operatorname{dsol}(A, B)=B^{\otimes}(-x)
$$

(v) If $\operatorname{dsol}(A, B)=\{y\}$ and $A^{-1} y$ is a singelton, then $\operatorname{psol}(A, B)=A^{-1} y$.
(vi) If $\operatorname{dsol}(A, B)=\{y\}$ and $B^{-1}(-y)$ and $\left(-B^{-\otimes}(y)\right)$ are a singelton, then

$$
\operatorname{psol}(A, B)=B^{-1}(-y)
$$

and

$$
\operatorname{psol}(A, B)=\left(-B^{-\oplus}(y)\right)
$$

Proof. (i): From (13), we have

$$
\begin{aligned}
x \in \operatorname{psol}(A, B) & \Leftrightarrow(A+B)^{-1}(0) \neq \varnothing \\
& \Leftrightarrow \varnothing \neq A x \cap(-B x) \\
& \Leftrightarrow \varnothing \neq A x \cap((-\mathrm{Id}) \circ B \circ(-\mathrm{Id})(-x)) \\
& \Leftrightarrow \varnothing \neq A x \cap B^{\otimes}(-x) \\
& \Leftrightarrow \varnothing \neq A x \cap B^{\otimes}(-x) \subseteq \operatorname{dsol}(A, B) . \\
& \Leftrightarrow \varnothing \neq A x \cap(-B x) \subseteq \operatorname{dsol}(A, B) .
\end{aligned}
$$

Since $\operatorname{psol}(A, B)=\{x\}$ and by using (13), we obtain $A x \cap(-B x)=\operatorname{dsol}(A, B)$, and $A x \cap B^{\varnothing}(-x)=\operatorname{dsol}(A, B)$.
(ii): From (16), we have

$$
\begin{aligned}
y \in \operatorname{dsol}(A, B) & \Leftrightarrow\left(A^{-1}+B^{-\varnothing}\right)^{-1}(0) \neq \varnothing \\
& \Leftrightarrow A^{-1}(y) \cap\left(-B^{-\varnothing}(y)\right) \neq \varnothing \\
& \Leftrightarrow A^{-1}(y) \cap B^{-1}(-y) \neq \varnothing \\
& \Leftrightarrow \varnothing \neq A^{-1}(y) \cap B^{-1}(-y) \subseteq \operatorname{psol}(A, B)
\end{aligned}
$$

Since $\operatorname{dsol}(A, B)=\{y\}$ and by using (16), we obtain

$$
A^{-1}(y) \cap B^{-1}(-y)=\operatorname{psol}(A, B)
$$

(iii): From (i), we have $A x \cap(-B x)=\operatorname{dsol}(A, B)$, and $A x \cap B^{\otimes}(-x)=\operatorname{dsol}(A, B)$. Since $A x$ is a singelton then we obtain

$$
\operatorname{dsol}(A, B)=A x \cap(-B x)=A x
$$

and

$$
\operatorname{dsol}(A, B)=A x \cap B^{\oplus}(-x)=A x
$$

(iv): From (i), we have $A x \cap(-B x)=\operatorname{dsol}(A, B)$, and $A x \cap B^{\otimes}(-x)=\operatorname{dsol}(A, B)$. Since $B x$ and $B^{\otimes}(-x)$ are singelton then we obtain

$$
\operatorname{dsol}(A, B)=A x \cap(-B x)=-B x
$$

and

$$
\operatorname{dsol}(A, B)=A x \cap B^{\oplus}(-x)=B^{\oplus}(-x)
$$

(v): From (ii), we have $\left(A^{-1} y\right) \cap B^{-1}(-y)=\operatorname{psol}(A, B)$, and $\left(A^{-1} y\right) \cap\left(-B^{-\otimes}(y)\right)=$ $\mathrm{dsol}(A, B)$. Since $A^{-1} y$ is a singelton then we obtain

$$
\operatorname{psol}(A, B)=\left(A^{-1} y\right) \cap B^{-1}(-y)=A^{-1} y
$$

and

$$
\operatorname{psol}(A, B)=\left(A^{-1} y\right) \cap\left(-B^{-\otimes}(y)\right)=A^{-1} y .
$$

(vi): From (ii), we have $\left(A^{-1} y\right) \cap B^{-1}(-y)=\operatorname{psol}(A, B)$, and $\left(A^{-1} y\right) \cap\left(-B^{-\otimes}(y)\right)=$ $\mathrm{dsol}(A, B)$. Since $B^{-1}(-y)$ and $\left(-B^{-\otimes}(y)\right)$ are singelton then we obtain

$$
\operatorname{psol}(A, B)=\left(A^{-1} y\right) \cap B^{-1}(-y)=B^{-1}(-y)
$$

and

$$
\operatorname{psol}(A, B)=\left(A^{-1} y\right) \cap\left(-B^{-®}(y)\right)=-B^{-\otimes}(y)
$$

For more information about the Attouch-Théra duality, we refer the reader to [8].

## 4 Correspondence of Properties and Results

Theorem 4.1. The following are equivalent
(i) Cycle exists.
(ii) The fixed point sets of cyclic compositions of resolvants $F_{i} \neq \varnothing$ for all $1 \leq i \leq m$.

Proof. " (i) $\Rightarrow$ (ii)": Let $\mathbf{z}=\left(z_{1}, z_{2}, \ldots, z_{m-1}, z_{m}\right)$ be a cycle. Then by Definition 1.1, we have $z_{1}=\mathrm{J}_{1} z_{m}, z_{2}=\mathrm{J}_{2} z_{1}, z_{3}=\mathrm{J}_{3} z_{2}, \cdots, z_{m-1}=\mathrm{J}_{m-1} z_{m-2}$, and $z_{m}=\mathrm{J}_{m} z_{m-1}$. This gives that

$$
\begin{aligned}
& z_{1}=\mathrm{J}_{1} \mathrm{~J}_{m} \ldots \mathrm{~J}_{3} \mathrm{~J}_{2} z_{1} \\
& z_{2}=\mathrm{J}_{2} \mathrm{~J}_{1} \ldots \mathrm{~J}_{4} \mathrm{~J}_{3} z_{2}
\end{aligned}
$$

$$
\begin{gathered}
\vdots \\
z_{i}=\mathrm{J}_{i} \mathrm{~J}_{i-1} \ldots \mathrm{~J}_{1} \mathrm{~J}_{m} \ldots \mathrm{~J}_{i+1} z_{i} \\
\vdots \\
z_{m}=\mathrm{J}_{m} \mathrm{~J}_{m-1} \ldots \mathrm{~J}_{2} \mathrm{~J}_{1} z_{m} .
\end{gathered}
$$

Therefore, $z_{1} \in F_{1}, z_{2} \in F_{2}, \ldots, z_{i} \in F_{i}, \ldots, z_{m} \in F_{m}$ by (8)-(11). This implies that $F_{1} \neq \varnothing$, $F_{2} \neq \varnothing, \ldots, F_{i} \neq \varnothing, \ldots, F_{m} \neq \varnothing$.
$"($ ii $) \Rightarrow($ i $) ":$ Let $F_{m} \neq \varnothing$ and $z_{m} \in F_{m}$. Then

$$
z_{m} \in \operatorname{Fix}\left(\mathrm{~J}_{m} \mathrm{~J}_{m-1} \ldots \mathrm{~J}_{2} \mathrm{~J}_{1}\right) z_{m}
$$

by (11). Therefore,

$$
z_{m}=\mathrm{J}_{m} \mathrm{~J}_{m-1} \ldots \mathrm{~J}_{2} \mathrm{~J}_{1} z_{m}
$$

Next, Applying $\mathrm{J}_{1}$ we obtain

$$
\mathrm{J}_{1} z_{m}=\mathrm{J}_{1}\left(\mathrm{~J}_{m} \mathrm{~J}_{m-1} \ldots \mathrm{~J}_{2}\right)\left(\mathrm{J}_{1} z_{m}\right),
$$

which is equivalent to $\mathrm{J}_{1} z_{m} \in \operatorname{Fix}\left(\mathrm{~J}_{1} \mathrm{~J}_{m} \mathrm{~J}_{m-1} \ldots \mathrm{~J}_{3} \mathrm{~J}_{2}\right) \Leftrightarrow \mathrm{J}_{1} z_{m} \in F_{1} \neq \varnothing$. Additionaly, let $z_{2} \in F_{2}$ such taht $z_{2}=\mathrm{J}_{2} z_{1}$. Keep doing this we obtain,

$$
z_{m-2}=\mathrm{J}_{m-2} \mathrm{~J}_{m-3} \ldots \mathrm{~J}_{1} \mathrm{~J}_{m} \mathrm{~J}_{m-1} z_{m-2} .
$$

Then,

$$
\mathrm{J}_{m-1} z_{m-2}=\mathrm{J}_{m-1}\left(\mathrm{~J}_{m-2} \mathrm{~J}_{m-3} \ldots \mathrm{~J}_{1} \mathrm{~J}_{m}\right)\left(\mathrm{J}_{m-1} z_{m-2}\right),
$$

and $\mathrm{J}_{m-1} z_{m-2} \in \operatorname{Fix}\left(\mathrm{~J}_{m-1} \mathrm{~J}_{m-2} \mathrm{~J}_{m-3} \ldots \mathrm{~J}_{1} \mathrm{~J}_{m}\right)$, which is equivalent to $\mathrm{J}_{m-1} \mathrm{~J}_{m-2} \in F_{m-1} \neq \varnothing$. Moreover, let $z_{m-1} \in F_{m-1}$ such that $z_{m-1}=\mathrm{J}_{m-1} z_{m-2}$. Then we obtain

$$
z_{m-1}=\mathrm{J}_{m-1} \mathrm{~J}_{m-2} \mathrm{~J}_{m-3} \ldots \mathrm{~J}_{1} \mathrm{~J}_{m} z_{m-1},
$$

and

$$
\mathrm{J}_{m} z_{m-1}=\mathrm{J}_{m}\left(\mathrm{~J}_{m-1} \mathrm{~J}_{m-2} \mathrm{~J}_{m-3} \ldots \mathrm{~J}_{1}\right) \mathrm{J}_{m} z_{m-1}
$$

Therefore,

$$
\mathrm{J}_{m} z_{m-1} \in \operatorname{Fix}\left(\mathrm{~J}_{m} \mathrm{~J}_{m-1} \mathrm{~J}_{m-2} \mathrm{~J}_{m-3} \ldots \mathrm{~J}_{1}\right)
$$

This is equivalent to $\mathrm{J}_{m} z_{m-1} \in \operatorname{Fix} F_{m} \neq \varnothing$. All these together give $\left(z_{1}, z_{2}, \ldots, z_{m-1}, z_{m}\right) \in$ $\mathbf{X}$ satisfying that

$$
\left(z_{1}, z_{2}, \ldots, z_{m-1}, z_{m}\right)=\left(\mathrm{J}_{1} z_{m}, \mathrm{~J}_{2} z_{1}, \ldots, \mathrm{~J}_{m-1} z_{m-2}, \mathrm{~J}_{m} z_{m-1}\right)
$$

Lemma 4.2. Let $\mathbf{z} \in \mathbf{X}$ is a cycle. Then

$$
\begin{equation*}
\mathbf{z}=\mathbf{J}_{\mathbf{A}}(\mathbf{R z}), \tag{18}
\end{equation*}
$$

and solving (18) is equivalent to solve

$$
\begin{equation*}
0 \in \mathbf{A}(\mathbf{z})+(\operatorname{Id}-\mathbf{R})(\mathbf{z}) \tag{19}
\end{equation*}
$$

Proof. Given that $\mathbf{z}=\left(z_{1}, z_{2}, \ldots, z_{m}\right) \in \mathbf{X}$ is a cycle. Then Definition 1.1 gives that $z_{1}=$ $\mathrm{J}_{1} z_{m}, z_{2}=\mathrm{J}_{2} z_{1}, z_{3}=\mathrm{J}_{3} z_{2}, \cdots, z_{m-1}=\mathrm{J}_{m-1} z_{m-2}$, and $z_{m}=\mathrm{J}_{m} z_{m-1}$. Hence,

$$
\begin{aligned}
\mathbf{z}=\left(z_{1}, z_{2}, \ldots, z_{m-1}, z_{m}\right) & =\left(\mathrm{J}_{1} z_{m}, \mathrm{~J}_{2} z_{1}, \ldots, \mathrm{~J}_{m-1} z_{m-2}, \mathrm{~J}_{m} z_{m-1}\right) \\
& =\left(\mathrm{J}_{1}, \mathrm{~J}_{2}, \ldots, \mathrm{~J}_{m-1}, \mathrm{~J}_{m}\right)\left(z_{m}, z_{1}, \ldots, z_{m-2}, z_{m-1}\right) \\
& =\mathbf{J}_{\mathbf{A}}\left(\mathbf{R}\left(z_{1}, z_{2}, \ldots, z_{m-1}, z_{m}\right)\right) \\
& =\mathbf{J}_{\mathbf{A}}(\mathbf{R z}) .
\end{aligned}
$$

Note that $\mathbf{z}=\mathbf{J}_{\mathbf{A}}(\mathbf{R z}) \Leftrightarrow \mathbf{z}=(\mathbf{I d}+\mathbf{A})^{-1}(\mathbf{R z})$ by (3). Therefore, we obtain

$$
\mathbf{R z} \in \mathbf{z}+\mathbf{A}(\mathbf{z}) \Leftrightarrow 0 \in \mathbf{A}(\mathbf{z})+(\mathbf{I d}-\mathbf{R})(\mathbf{z})
$$

Define the set of all cycles by

$$
\begin{equation*}
\mathbf{Z}:=\operatorname{Fix}\left(\mathbf{J}_{\mathbf{A}} \mathbf{R}\right) \tag{20}
\end{equation*}
$$

Define

$$
\begin{equation*}
F_{i}:=\left\{z \in X \mid z=\mathrm{J}_{i} \ldots \mathrm{~J}_{1} \mathrm{~J}_{m} \ldots \mathrm{~J}_{i+1} z\right\} \tag{21}
\end{equation*}
$$

Moreover,

$$
\begin{equation*}
Q_{i}: \mathbf{X} \rightarrow X: \mathbf{z} \mapsto z_{i} . \tag{22}
\end{equation*}
$$

The relationship between the fixed point set of composition of $m$ resolvants $F_{i}$ 's and the set of all cycles $\mathbf{Z}$ are given in the following theorem.
Theorem 4.3. For every $1 \leq i, j \leq m$, the following hold;
(i) $F_{i}$ are closed and convex. Moreover,

$$
\begin{align*}

& F_{m-1}=\left(\mathrm{J}_{m-1} \cdots \mathrm{~J}_{3} \mathrm{~J}_{2} \mathrm{~J}_{1}\right)\left(F_{m}\right)=\left(\mathrm{J}_{m-1} \cdots \mathrm{~J}_{3} \mathrm{~J}_{2}\right)\left(F_{1}\right)=\cdots=\mathrm{J}_{m-1}\left(F_{m-2}\right)  \tag{24}\\
& \vdots  \tag{25}\\
& F_{2}=\left(\mathrm{J}_{2} \mathrm{~J}_{1} \mathrm{~J}_{m} \ldots \mathrm{~J}_{4}\right)\left(F_{3}\right)=\left(\mathrm{J}_{2} \mathrm{~J}_{1} \mathrm{~J}_{m} \ldots \mathrm{~J}_{5}\right)\left(F_{4}\right)=\cdots=\mathrm{J}_{2} \mathrm{~J}_{1}\left(F_{m}\right)=\mathrm{J}_{2}\left(F_{1}\right)  \tag{26}\\

(iii) For $1 \leq i \leq m-1, \mathrm{~J}_{i+1}\left(F_{i}\right)=\left(F_{i+1}\right)$, and $\mathrm{J}_{1}\left(F_{m}\right)=F_{1}$. Therefore,

Therefore, $\mathrm{J}_{1} x \in \operatorname{Fix}\left(\mathrm{~J}_{1} \mathrm{~J}_{m} \mathrm{~J}_{m-1} \ldots \mathrm{~J}_{3} \mathrm{~J}_{2}\right) \Leftrightarrow \mathrm{J}_{1} x \in F_{1}$. It follows that

& \subseteq\left(\mathrm{J}_{m} \mathrm{~J}_{m-1} \ldots \mathrm{~J}_{2}\right)\left(\operatorname{Fix}\left(\mathrm{J}_{1} \mathrm{~J}_{m} \ldots \mathrm{~J}_{3} \mathrm{~J}_{2}\right)\right)  \tag{36}\\

(iv): Clear from the definition of $F_{i}, F_{j}$ and $\mathbf{Z}$.
(v): Since $J_{\mathbf{A}} \mathbf{R}$ is nonexpansive and because $\mathbf{Z}=\operatorname{Fix}_{\mathbf{A}} \mathbf{R}$, by [18, Proposition 2.1.11], $\mathbf{Z}$ is closed and convex. Moreover, let $\mathbf{z}=\left(z_{1}, z_{2}, \ldots, z_{m}\right) \in \operatorname{Fix}_{\mathbf{A}} \mathbf{R} \Leftrightarrow \mathbf{z}=\mathrm{J}_{\mathbf{A}} \mathbf{R z}$. This implies

(i) We have $F_{i}=D$ for every $1 \leq i \leq m$.
(ii) $\mathbf{Z}=\{(z, z, \cdots, z) \mid z \in D\}=D^{m} \cap \Delta$.

Proof. (i): $\mathrm{J}_{i}$ is firmly nonexpansive for every $1 \leq i \leq m$, then by [15, Corollary 4.51], we have

\end{aligned}

hence,

Remark 4.5. When $m=2$, we have $\mathrm{J}_{1}\left(F_{2}\right)=F_{1}$, and $\mathrm{J}_{2}\left(F_{1}\right)=F_{2}$.

Proof. Let $z \in F_{1}$ and $\widetilde{z} \in F_{2}$, then we have $z=\mathrm{J}_{1} \mathrm{~J}_{2} z$ and $\mathrm{J}_{2} z=\mathrm{J}_{2} \mathrm{~J}_{1}\left(\mathrm{~J}_{2} z\right)$. Therefore,

\begin{equation*}
\mathrm{J}_{2}\left(F_{1}\right) \subseteq F_{2} \tag{48}
\end{equation*}
$$

Moreover, $\widetilde{z} \in F_{2}$, then we have $\widetilde{z}=\mathrm{J}_{2} \mathrm{~J}_{1} \widetilde{z}$ and $\mathrm{J}_{1} \widetilde{z}=\mathrm{J}_{1} \mathrm{~J}_{2}\left(\mathrm{~J}_{1} \widetilde{z}\right)$. Thus,

& \Leftrightarrow\left(\frac{\mathbf{I d}+\mathbf{R}}{2}\right) \mathbf{x} \in\left(\mathbf{I d}+\frac{1}{2} \mathbf{A}\right)(\mathbf{x}) \\
& \Leftrightarrow \mathbf{x}=\mathrm{J}_{\frac{1}{2} \mathbf{A}}\left(\frac{\mathbf{I d}+\mathbf{R}}{2}\right)(\mathbf{x}) \\
& \Leftrightarrow \mathbf{x} \in \operatorname{Fix}_{\frac{1}{2} \mathbf{A}}\left(\frac{\mathbf{I d}+\mathbf{R}}{2}\right)
\end{aligned}
$$

Lemma 4.7. Suppose that $\operatorname{Fix} \mathrm{J}_{i} \neq \varnothing$ for each $1 \leq i \leq m$. Then, the following are equivalent
(i) $\cap_{i=1}^{m} \operatorname{Fix~}_{i} \neq \varnothing$.
(ii) $F_{1}=F_{2}=\cdots=F_{m} \neq \varnothing$.

Proof. (i): Let $\cap_{i=1}^{m} \operatorname{Fix}_{i} \neq \varnothing \Rightarrow F_{1} \neq \varnothing, F_{2} \neq \varnothing, \cdots, F_{m} \neq \varnothing$ and from Lemma 4.4(i), we have

F_{1}=F_{2}=\cdots=F_{m}=\cap_{i=1}^{m} \operatorname{Fix}_{i} .
$$

(ii): Let $F_{1}=F_{2}=\cdots=F_{m} \neq \varnothing$. Then, by Theorem 4.3 (iv) we have $\mathbf{Z} \neq \varnothing$

## 5 Consequences of Attouch-Théra duality

Recall (5) that

$$
\mathbf{A}=A_{1} \times A_{2} \times \cdots \times A_{m}
$$

From now on, suppose that

\end{equation*}

$$

Recall (20) that

\mathbf{Z}:=\operatorname{Fix}\left(\mathbf{J}_{\mathbf{A}} \mathbf{R}\right) .
$$

Proposition 5.1. The following holds:
(i) $\mathbf{Z}=\operatorname{psol}(\mathbf{I d}-\mathbf{R})$.
(ii) $\mathbf{A}+\mathbf{I d}-\mathbf{R}$ is maximally monotone.
(iii) $\mathbf{Z}$ is closed and convex.

Proof. (i): Combine Lemma 4.2 and (13). (ii): Note that $\mathbf{I d}-\mathbf{R}$ is linear, full domain, and maximally monotone by [1, Theorem 7.1]. Moreover, $\mathbf{A}$ is maximally monotone by assumption. Therefore, the sum is maximally monotone by [15, Corollary 25.5 (i)] (iii): It follows directly from (i) and Theorem 4.3 (v).

Theorem 5.2. Recall from Lemma 4.2, the primal (Attouch-Théra) problem,

for the pair $(\mathbf{A}, \mathbf{I d}-\mathbf{R})$. Then the Attouch-Théra dual problem is

Moreover,

\operatorname{dsol}(\mathbf{A}, \mathbf{I d}-\mathbf{R})=\operatorname{zer}\left(\mathbf{A}^{-1}+N_{\mathbf{D}^{\perp}}+\frac{1}{2} \mathbf{I d}+\mathbf{T}\right) . \tag{54}
\end{equation*}
$$

Proof. The dual pair of $(\mathbf{A},(\mathbf{I d}-\mathbf{R}))$ is

$$
(\mathbf{A},(\mathbf{I d}-\mathbf{R}))^{*}=\left(\mathbf{A}^{-1},(\mathbf{I d}-\mathbf{R})^{-\mathbb{Q}}\right)
$$

Because of the linearity of $\mathbf{R}$, we have

$$
(\mathbf{I d}-\mathbf{R})^{-\varnothing}=(-\mathbf{I d}) \circ(\mathbf{I d}-\mathbf{R})^{-1} \circ(-\mathbf{I d})=(\mathbf{I d}-\mathbf{R})^{-1}
$$

Hence, Attouch-Théra dual problem simplifies to

$$
0 \in \mathbf{A}^{-1}(\mathbf{y})+(\mathbf{I d}-\mathbf{R})^{-1}(\mathbf{y})
$$

From [2, Theorem 2.8 (i)], we have

$$
\begin{aligned}
0 \in \mathbf{A}^{-1}(\mathbf{y})+(\mathbf{I d}-\mathbf{R})^{-1}(\mathbf{y}) & \Leftrightarrow 0 \in \mathbf{A}^{-1}(\mathbf{y})+\left(\mathbf{N}_{\mathbf{D}^{\perp}}+\frac{1}{2} \mathbf{I d}+\mathbf{T}\right)(\mathbf{y}) \\
& \Leftrightarrow 0 \in\left(\mathbf{A}^{-1}+\mathbf{N}_{\mathbf{D}^{\perp}}\right)(\mathbf{y})+\left(\frac{1}{2} \mathbf{I d}+\mathbf{T}\right)(\mathbf{y})
\end{aligned}
$$

which verifies (53). Next, by (16), (52), and (53), we have

$$
\begin{aligned}
\operatorname{dsol}(\mathbf{A}, \mathbf{I d}-\mathbf{R}) & =\operatorname{zer}\left(\mathbf{A}^{-1}+(\mathbf{I d}-\mathbf{R})^{-1}\right) \\
& =\operatorname{zer}\left(\mathbf{A}^{-1}+\mathbf{N}_{\mathbf{D}^{\perp}}+\frac{1}{2} \mathbf{I d}+\mathbf{T}\right) .
\end{aligned}
$$

Proposition 5.3. The solution set of (52) is at most a at most a sigleton and possibly empty.

Proof. See [1, Proposition 9.2].
Theorem 5.4. Let $\operatorname{psol}(\mathbf{A}, \mathbf{I d}-\mathbf{R})=\mathbf{Z}$ and recall from (54) that

$$
\operatorname{dsol}(\mathbf{A}, \mathbf{I d}-\mathbf{R})=\operatorname{zer}\left(\mathbf{A}^{-1}+\mathbf{N}_{\mathbf{D}^{\perp}}+\frac{1}{2} \mathbf{I d}+\mathbf{T}\right)
$$

Then

$$
\operatorname{dsol}(\mathbf{I d}-\mathbf{R})=(\mathbf{R}-\mathbf{I d}) \mathbf{Z}= \begin{cases}\left\{\mathbf{J}_{2\left(\mathbf{A}^{-1}+\mathbf{N}_{\mathbf{D}^{\perp}}+\mathbf{T}\right)}(\mathbf{0})\right\}, & \text { if } \mathbf{Z} \neq \varnothing  \tag{55}\\ \varnothing, & \text { if } \mathbf{Z}=\varnothing\end{cases}
$$

Moreover, if $\mathbf{y}^{*}:=\mathbf{J}_{2\left(\mathbf{A}^{-1}+\mathbf{N}_{\mathbf{D}^{\perp}}+\mathbf{T}\right)}(\mathbf{0})$ exists, then the following are hold:
(i) $\mathbf{y}^{*} \in \mathbf{D}^{\perp}$.
(ii) $\mathbf{y}^{*}$ is the only vector that makes $\mathbf{A}^{-1} \mathbf{y} \cap-\left(\mathbf{N}_{\mathbf{D}^{\perp}} \mathbf{y}+\frac{1}{2} \mathbf{y}+\mathbf{T y}\right)$, nonempty
(iii) $\mathbf{Z}=\mathbf{A}^{-1} \mathbf{y}^{*} \cap\left(-\frac{1}{2} \mathbf{y}^{*}-\mathbf{T y}^{*}-\mathbf{D}\right)$

Proof. By using (16), we have $\mathbf{y} \in \operatorname{dsol}(\mathbf{A}, \mathbf{I d}-\mathbf{R})$ gives

$$
\begin{aligned}
& \mathbf{0} \in \mathbf{A}^{-1}(\mathbf{y})+(\mathbf{I d}-\mathbf{R})^{-1}(\mathbf{y}) \quad(\forall \mathbf{z} \in \mathbf{Z}) \\
\Leftrightarrow & \mathbf{z} \in \mathbf{A}^{-1}(\mathbf{y}) \text { and }-\mathbf{z} \in(\mathbf{I d}-\mathbf{R})^{-1}(\mathbf{y}) \quad(\forall \mathbf{z} \in \mathbf{Z}) \\
\Leftrightarrow & \mathbf{y} \in \mathbf{A}(\mathbf{z}) \text { and } \mathbf{y}=(\mathbf{I d}-\mathbf{R})(-\mathbf{z}) \quad(\forall \mathbf{z} \in \mathbf{Z}),
\end{aligned}
$$

hence, for all $\mathbf{z} \in \mathbf{Z}$, we obtain

$$
\mathbf{y}=\mathbf{R z}-\mathbf{z}
$$

and

$$
\begin{aligned}
\operatorname{dsol}(\mathbf{I d}-\mathbf{R}) & =\cup_{\mathbf{z} \in \mathbf{Z}}\{\mathbf{R} \mathbf{z}-\mathbf{z} \mid \mathbf{z} \in \mathbf{Z}\} \\
& =(\mathbf{R}-\mathbf{I d}) \mathbf{Z}
\end{aligned}
$$

Additionally, if $\mathbf{Z} \neq \varnothing$, then using [2, Theorem 2.4] and (3) gives

$$
\begin{aligned}
& \mathbf{0} \in \mathbf{A}^{-1}(\mathbf{y})+(\mathbf{I d}-\mathbf{R})^{-1}(\mathbf{y}) \\
\Leftrightarrow & \mathbf{0} \in \mathbf{A}^{-1}(\mathbf{y})+\left(\frac{1}{2} \mathbf{I d}+\mathbf{T}+\mathbf{N}_{\mathbf{D}^{\perp}}\right)(\mathbf{y}) \\
\Leftrightarrow & \mathbf{0} \in\left(\mathbf{I d}+2\left(\mathbf{A}^{-1}+\mathbf{T}+\mathbf{N}_{\mathbf{D}^{\perp}}\right)\right)(\mathbf{y}) \\
\Leftrightarrow & \mathbf{y} \\
\Leftrightarrow & =\left(\mathbf{I d}+2\left(\mathbf{A}^{-1}+\mathbf{T}+\mathbf{N}_{\mathbf{D}^{\perp}}\right)\right)^{-1}(\mathbf{0}) \\
\Leftrightarrow & =\mathbf{J}_{2\left(\mathbf{A}^{-1}+\mathbf{T}+\mathbf{N}_{\mathbf{D}^{\perp}}\right)}(\mathbf{0})
\end{aligned}
$$

However, if $\mathbf{Z}=\varnothing$, then using [7, Proposition 2.4 (v)]

$$
\varnothing=\mathrm{dsol}(\mathbf{A}, \mathbf{I d}-\mathbf{R})=\mathrm{dsol}(\mathbf{I d}-\mathbf{R})
$$

(i): By [2, Theorem 2.7], we have dom $(\mathbf{I d}-\mathbf{R})^{-1}=\mathbf{D}^{\perp}$. This implies that

$$
\mathbf{y} \in \mathbf{D}^{\perp} .
$$

(ii): Combine Proposition 5.3 and [7, Proposition 2.4].
(iii): Combine (i), (ii), and [1, Proposition 9.3 (i)] where $\mathbf{N}_{\mathbf{C}}^{-1}$ is replaced by $\mathbf{A}^{-1}$.

Lemma 5.5. Denote by $\mathbf{y}^{*}=\left(y_{1}, y_{2}, \cdots, y_{m}\right)$ the unique solution of (53). Then the following hold:
(i) The mapping $\mathrm{J}_{1}: F_{m} \rightarrow F_{1}$ is bijective on $F_{m}$ and it is given by $\mathrm{J}_{1}(z)=z-y_{1}$. Moreover, for $1 \leq i \leq m-1$ the mapping $\mathrm{J}_{i+1}: F_{i} \rightarrow F_{i+1}$ is bijective and is given by $\mathrm{J}_{i+1}(z)=z-y_{i+1}$.
(ii) The fixed point sets $F_{1}=F_{m}-y_{1}$ and $F_{i+1}=F_{i}-y_{i+1}$.

Proof. (i): Let $z$ and $\widetilde{z}$ be in $F_{m}$ satisfying that $\mathrm{J}_{1} z=\mathrm{J}_{1} \widetilde{z}$. Our goal is to show that $\mathrm{J}_{1}$ is injective on $F_{m}$. Then, we have

$$
z=\mathrm{J}_{m} \mathrm{~J}_{m-1} \cdots \mathrm{~J}_{i} \mathrm{~J}_{i-1} \cdots \mathrm{~J}_{1} z
$$

and

$$
\widetilde{z}=\mathrm{J}_{m} \mathrm{~J}_{m-1} \cdots \mathrm{~J}_{i} \mathrm{~J}_{i-1} \cdots \mathrm{~J}_{1} \widetilde{z}
$$

Since $\mathrm{J}_{1} z=\mathrm{J}_{1} \widetilde{z}$, then we obtain $z=\widetilde{z}$. Thus, $\mathrm{J}_{1}$ is an injective mapping on $F_{m}$. Moreover, Remark 4.5 shows that $\mathrm{J}_{1}$ is a surjective mapping on $F_{m}$. Therefore, $\mathrm{J}_{1}$ is a bijective mapping on $F_{m}$. For every $z \in F_{m}$, we have

$$
\begin{equation*}
z=\mathrm{J}_{m} \mathrm{~J}_{m-1} \cdots \mathrm{~J}_{i} \mathrm{~J}_{i-1} \cdots \mathrm{~J}_{1} z \tag{56}
\end{equation*}
$$

Set $z_{1}=\mathrm{J}_{1} z, z_{2}=\mathrm{J}_{2} z_{1}, \cdots, z_{m-1}=\mathrm{J}_{m-1} z_{m-2}, z_{m}=\mathrm{J}_{m} z_{m-1}$. Therefore, using (56), we have $z=\mathrm{J}_{m} z_{m-1}$ and $\mathbf{z}=\left(z_{1}, z_{2}, \cdots, z_{m-1}, z\right)$. Therefore, Theorem 5.4 gives

$$
\left(y_{1}, y_{2}, \cdots, y_{m}\right)=\left(z, z_{1}, z_{2}, \cdots, z_{m-1}\right)-\left(z_{1}, z_{2}, \cdots, z_{m-1}, z_{m}\right)
$$

and therefore, $y_{1}=z-z_{1} \Rightarrow z_{1}=z-y_{1} \Rightarrow \mathrm{~J}_{1} z=z-y_{1}$. The proof of $\mathrm{J}_{i}$ is the same as $\mathrm{J}_{1}$. (ii): It follows from (i) that for every $z \in F_{m}$, we obtain $\mathrm{J}_{1} z=z-y_{1}$. Then by Theorem 4.3(iii) we have $F_{1}=F_{m}-y_{1}$. The proof for $F_{i+1}=F_{i}-y_{i+1}$ is the same as $F_{1}$.
