# Strict refinement property of connected loop-free categories

#### Abstract

In this paper we study the strict refinement property for connected partial orders also known as Hashimoto's Theorem. This property implies that any isomorphism between products of irreducible structures is determined is uniquely determined as a product of isomorphisms between the factors. This refinement implies a sort of smallest possible decomposition for such structures. After a brief recall of the necessary notion we prove that Hashimoto's theorem can be extended to connected loop-free categories, i.e. categories with no non-trivial morphisms endomorphisms. A special case of such categories is the category of connected components, for concurrent programs without loops.

Connected posets (i.e. those in which for all elements $x$ and $y$ we have a sequence $x=z_{0}, z_{1}, \ldots, z_{n}=y$ such that $z_{i}$ and $z_{i-1}$ are comparable for every $\left.i \in\{1, \ldots, n\}\right)$ satisfy the strict refinement property [1]: if the following isomorphism holds in the category of posets (Pos)

\prod_{\alpha \in A} X_{\alpha} \cong \prod_{\beta \in B} Y_{\beta}
$$

then we have a family of posets $\left\{Z_{\alpha, \beta} \mid \alpha \in A ; \beta \in B\right\}$ such that the following isomorphisms hold for every $\alpha \in A$ and every $\beta \in B$.

$$
X_{\alpha} \cong \prod_{b \in B} Z_{\alpha, b} \quad \text { and } \quad Y_{\beta} \cong \prod_{a \in A} Z_{a, \beta}
$$

A (small) category is said to be loop-free when any two of its morphisms whose composite is an endomorphism are identities. The category of loop-free categories (LFCat), which is a full subcategory of the category of small categories (Cat), contains Pos as a full subcategory. The embedding Pos $\hookrightarrow$ LFCat has a left adjoint obtained by identifying any two arrows with the same source and the same target. The purpose of this article is to prove that connected loop-free categories also satisfy the strict refinement property:

Theorem A. Given a connected loop-free category $\mathcal{C}$, for any two decompositions $\Psi_{A}: \mathcal{C} \rightarrow \prod_{\alpha \in A} X_{\alpha}$ and $\Psi_{B}: \mathcal{C} \rightarrow \prod_{\beta \in B} Y_{\beta}$, there exists a family of loop-free categories $Z_{\alpha, \beta}$ with $\alpha \in A$ and $\beta \in B$, and for every $\alpha \in A$ and $\beta \in B$, decompositions

$$
a_{\alpha}: X_{\alpha} \rightarrow \prod_{\beta \in B} Z_{\alpha, \beta} \quad \text { and } \quad b_{\beta}: Y_{\beta} \rightarrow \prod_{\alpha \in A} Z_{\alpha, \beta}
$$

such that the following diagram commutes:

where $\gamma: \prod_{\alpha \in A} \prod_{\beta \in B} Z_{\alpha, \beta} \rightarrow \prod_{\beta \in B} \prod_{\alpha \in A} Z_{\alpha, \beta}$ is the natural isomorphism sending $\left(\left(z_{\alpha, \beta}\right)_{\beta \in B}\right)_{\alpha \in A}$ to $\left(\left(z_{\alpha, \beta}\right)_{\alpha \in A}\right)_{\beta \in B}$.

The structure of our proof diverges from Hashimoto's original paper [2] and instead follows more closely the presentation found in [1, Chapter 10] which has the added advantage of also constructing the elements of the refinement.

Beyond its pure theoretical interest, this problem is related to the study of programs made of several sequential processes running in parallel [3] (in the sequel we just write 'program'). The geometric model $\llbracket P \rrbracket$ of a program $P$ is locally ordered [4, Corollary 6.1], so each of its points has a neighborhood whose fundamental category [ $5,4.37$, p.73] is loop-free. The crucial facts are:

1. the functor $\vec{\pi}_{1}: \mathbf{C} \rightarrow \mathbf{C a t}$, which assigns to every object of $\mathbf{C}$ its fundamental category, preserves finite products, and
2. two programs $P$ and $Q$ do not interact with each other when we have $\llbracket P \mid Q \rrbracket \cong$ $\llbracket P \rrbracket \times \llbracket Q \rrbracket($ in $\mathbf{C})[4$, Theorem 6.2].

Hence splitting a program $P$ into subprograms that are executed independently of each other is somewhat related to writing the loop-free categories $\vec{\pi}_{1}(V)$ as finite product, for $V$ partially ordered open subspace of $\llbracket P \rrbracket$. We expect that these local decompositions actually induce a global decomposition of $\vec{\pi}_{1}(\llbracket P \rrbracket)$; our hope is based on the van Kampen theorem [5, 4.52, p.80].

## 1 Definitions

Given an object $X$ of a category $\mathcal{C}$, we write $\mathrm{id}_{X}$ for the identity morphism on $X$. We generally omit the subscript when clear from the context. Given a morphism $f: X \rightarrow Y$, we write $\bar{f}=X$ (resp. $\underline{f}=Y$ ) for its source (resp. target).
Definition 1. A morphism $f: x \rightarrow y$ in a category $\mathcal{C}$ is said to be without return when the hom-set $\mathcal{C}(y, x)$ is empty. Otherwise, we say that $f$ admits a return. A category $\mathcal{C}$ is said to be loop-free when all its morphisms, except identities, are without return. We write LFCat for the category of all small loop-free categories.
Definition 2. In LFCat, consider a family $\left\{f_{\alpha}: X_{\alpha} \rightarrow Y_{\alpha}\right\}_{\alpha \in A}$ of morphisms. The product map $f: \prod_{\alpha \in A} X_{\alpha} \rightarrow \prod_{\alpha \in A} Y_{\alpha}$ is the unique morphism such that $\pi_{\alpha} f=f_{\alpha}$ for every $\alpha \in A$.

For the rest of the chapter we will often write $f=\left(f_{\alpha}\right)_{\alpha \in A}$ for the product map of the family $\left\{f_{\alpha}: X_{\alpha} \rightarrow Y_{\alpha}\right\}_{\alpha \in A}$. For binary products, we write $(f, g)$ the product map of $f$ and $g$.
Definition 3. A fence is a family $\left(f_{i}\right)_{1 \leq i \leq n}$ of morphisms of $\mathcal{C}$ such that:

- $\underline{f_{2 i}}=\underline{f_{2 i+1}}$ and $\overline{f_{2 i-1}}=\overline{f_{2 i}}$
- $\overline{\text { or }} \overline{f_{2 i}}=\overline{f_{2 i+1}}$ and $\underline{f_{2 i-1}}=\underline{f_{2 i}}$

The length of a fence $\left(f_{i}\right)_{1 \leq i \leq n}$ is its cardinal $n$
Definition 4. Two morphisms $f$ and $g$ of a category $\mathcal{C}$ are said to be connected if there exists a fence $\left(f_{i}\right)_{i \in[1, n]}$ such that $f=f_{1}$ and $f_{n}=g$. A category $\mathcal{C}$ is said to be connected if all its morphisms are connected.
Definition 5. A (product) decomposition of a loop-free category $\mathcal{C}$ is an isomorphism $\Psi$ from $\mathcal{C}$ to a product $\prod_{\alpha \in A} X_{\alpha}$ of loop-free categories $X_{\alpha}$ for $\alpha \in A$.

Note that if $\mathcal{C}$ is non-empty, connected, and loop-free, then so are the categories $X_{\alpha}$.

## 2 Hashimoto's theorem for loop-free categories

Hashimoto's Theorem [2] states that every connected partial order has the strict refinement property; in this article, we generalize this result to all connected loop-free categories in Theorem A.

As previously stated, we will follow the proof from [1], generalizing the key lemmas to the case of connected loop-free categories. We will first give a rough idea of the different steps of the proofs, before introducing the details and technical lemmas necesssary for the proof in Section 3.

To prove Theorem A we will need to find the decompositions $\left(a_{\alpha}\right)_{\alpha \in A}$ and $\left(b_{\beta}\right)_{\beta \in B}$ of Eq. (1). For this we will first define some notions, that will be used in the presentation of the proof.

Definition 6. Given an element $s$ of a set product $\prod_{i \in I} S_{i}$, an index $j \in I$, and an element $x_{j} \in S_{j}$, we define $\left(s, x_{j}, j\right)_{i \in I}$ as the element of $\prod_{i \in I} S_{i}$ obtained by substituting $x_{j}$ to $s_{j}$ in $s$; in other words:

$$
\left(s, x_{j}, j\right)_{i}= \begin{cases}x_{j} & \text { if } i=j \\ s_{i} & \text { otherwise }\end{cases}
$$

Definition 7. Given an object $s$ of a loop-free category $\prod_{\alpha \in A} X_{\alpha}$, and an index $\lambda \in A$, the $\lambda$-section at $s$ is the functor from $X_{\lambda}$ to $\prod_{\alpha \in A} X_{\alpha}$ defined by

$$
\left\{\begin{array}{l}
x_{\lambda} \mapsto\left(s, x_{\lambda}, \lambda\right) \quad \text { if } x_{\lambda} \text { is an object } \\
f_{\lambda} \mapsto\left(\operatorname{id}_{s}, f_{\lambda}, \lambda\right) \text { if } f_{\lambda} \text { is a morphism }
\end{array}\right.
$$

We denote by $\Xi_{\lambda}^{s}: X_{\lambda} \cong X_{\lambda}^{s}$ the isomorphism induced by the $\lambda$-section at $s$ on its image. We denote by $\Phi_{\lambda}^{s}$ the restriction of $\Phi$ to $X_{\lambda}^{s}$ for every functor $\Phi$ defined over $\prod_{\alpha \in A} X_{\alpha}$.
Definition 8. Given an isomorphism $\Phi: \prod_{\alpha \in A} X_{\alpha} \rightarrow \prod_{\beta \in B} Y_{\beta}$, indexes $\lambda \in A$, $\mu \in B$, and an object $s \in \prod_{\alpha \in A} X_{\alpha}$, we define

$$
X_{\lambda}^{\mu}:=\pi_{\lambda} \Phi^{-1} \Xi_{\mu}^{\Phi(s)}\left(Y_{\mu}\right) \quad \text { and } \quad Y_{\mu}^{\lambda}:=\pi_{\mu} \Phi \Xi_{\lambda}^{s}\left(X_{\lambda}\right)
$$

with $\pi_{\lambda}: \prod_{\alpha \in A} X_{\alpha} \rightarrow X_{\lambda}$ and $\pi_{\mu}: \prod_{\beta \in A} X_{\beta} \rightarrow X_{\mu}$ the projections.
As we will see, the refinement (but not its existence) $Z_{\alpha, \beta}$ (with $\alpha \in A$ and $\beta \in B$ ) depends on an object $s \in \prod_{\alpha \in A} X_{\alpha}$ that we arbitrarily fix now if the product is nonempty. In [1], which proves the strict refinement property for connected posets, the isomorphisms $\left(a_{\alpha}\right)_{\alpha \in A}$ and $\left(b_{\beta}\right)_{\beta \in B}$ of Diagram 1 are obtained by decomposing the expected isomorphisms into smaller morphisms, obtained with the notation introduced above, which gives the Diagram 2 below.


The first part of the proof is to prove that all the introduced morphisms, are in fact isomorphisms and to prove that they are indeed product maps of isomorphisms. That is to say that we have $\Psi_{2}=\prod_{\alpha \in A} a_{\alpha}$ and $\Psi_{1}=\prod_{\beta \in B} b_{\beta}$ with

$$
a_{\alpha}=\left(\pi_{\alpha} \Phi^{-1} \Xi_{\beta}^{\Phi(s)} \pi_{\beta} \Phi \Xi_{\alpha}^{s}\right)_{\beta \in B} \quad \text { and } \quad b_{\beta}=\Phi^{-1} \Xi_{\beta}^{\Phi(s)}
$$

Most of the proofs rely heavily on the following proposition, which allows us to restrain the coordinates of composite images.
Lemma 8. Let $\Phi: \mathcal{P} \times \mathcal{Q} \rightarrow \mathcal{U} \times \mathcal{V}$ an isomorphism of connected loop-free categories. Let $(u, v)$ and $\left(u^{\prime}, v^{\prime}\right)$ two morphisms of $\mathcal{U} \times \mathcal{V}$ and $p$ a morphism of $\mathcal{P}$. Then $\pi_{\mathcal{P}} \Phi^{-1}(u, v)=\pi_{\mathcal{P}} \Phi^{-1}\left(u^{\prime}, v^{\prime}\right)=p$ implies $\pi_{\mathcal{P}} \Phi^{-1}\left(u, v^{\prime}\right)=p$.

Then, once this has been achieved, we need to prove that the diagram commutes to conclude the proof. To do this, we will first prove the commutation on a restriction of the diagram, by replacing for each $\alpha \in A$ the starting category $X_{\alpha}$ by the subcategory $X_{\alpha}^{\mu}$ as in Definition 8, for an arbitrary $\mu \in \beta$, giving us the diagram below.


Then using the following Lemma 10, the commutation is extended along a given $\lambda \in A$.

Lemma 10. Let $\Phi: \mathcal{P} \times \mathcal{Q} \rightarrow \mathcal{U} \times \mathcal{V}$ be an isomorphism of connected loop-free categories. Let $\mathcal{Q}^{\prime}$ a connected subcategory of $\mathcal{Q}$. Let $p$ a morphism of $\mathcal{P}$. Then $\pi_{U} \Phi(p, q)=$ $\pi_{U} \Phi\left(p, q^{\prime}\right)$ for all $q, q^{\prime} \in \mathcal{Q}^{\prime}$ implies, for all $p^{\prime} \in \mathcal{P}, \pi_{U} \Phi\left(p^{\prime}, q\right)=\pi_{U} \Phi\left(p^{\prime}, q^{\prime}\right)$ for all $q, q^{\prime} \in \mathcal{Q}^{\prime}$.

This leads to the commutation of the Diagram 4 below.


Using Lemma 10 once more the commutativity can be extended to the full domain $\prod_{\alpha \in A} X_{\alpha}$, thus ending the proof.

In our case a few necessary conditions that are less trivial will need to be detailed in Lemma 18 to perform the last steps of the proof, but the broad strokes will remain the same.

## 3 Preliminary results

As announced the proof of Theorem A relies on a few technical results and properties of loop-free categories that we will first present in this section. The Corollary 9 and Lemma 10 are especially important pieces of the inner working of the proof.

### 3.1 Properties of loop-free categories

We remind the reader of a few properties of loop-free categories that we will use in the following proofs, as well as two usefull properties specific to loop-free categories.
Proposition 2. LFCat has all products.
Proof. LFCat is an epireflective subcategory of Cat ([6, Proposition 1.8]), a cartesian closed category. Thus, it has all products.

By the adjunction between LFCat and Pos, we have the following result:
Proposition 3. Let $\Phi: \mathcal{C} \rightarrow \mathcal{D}$ be a morphism of connected loop-free categories. Then the restriction

$$
\left.\Phi\right|_{\text {Obj }}:(\operatorname{Obj}(\mathcal{C}), \leq) \rightarrow(\operatorname{Obj}(\mathcal{D}), \leq)
$$

is an order-preserving morphism of connected posets with the canonical partial order $\leq$ defined by

$$
X \leq Y \Longleftrightarrow \mathcal{C}(X, Y) \neq \emptyset
$$

Furthermore, if $\Phi$ is an isomorphism, so is $\left.\Phi\right|_{\mathrm{Obj}}$.
Lemma 4. Given two morphisms $f, g$ of a loop-free category $\mathcal{C}$, we have that $f \circ g=\mathrm{id}$ implies $f=g=\mathrm{id}$

Proof. If $f \circ g=\mathrm{id}$, then both $f$ and $g$ have a return; it follows that both are identities because $\mathcal{C}$ is loop-free.

Lemma 5. Given an isomorphism of small, loop-free categories $\Phi: \mathcal{C}_{1} \times \mathcal{C}_{2} \rightarrow \mathcal{D}_{1} \times \mathcal{D}_{2}$ and an object $X$ of $\mathcal{C}_{1}$, for all morphisms $(f, g)$ of $\mathcal{D}_{1} \times \mathcal{D}_{2}$ such that $\pi_{1} \Phi^{-1}(f, g)=\mathrm{id}_{X}$, we have:

$$
\pi_{1} \Phi^{-1}\left(f, \operatorname{id}_{\underline{g}}\right)=\pi_{1} \Phi^{-1}\left(f, \operatorname{id}_{\bar{g}}\right)=\pi_{1} \Phi^{-1}\left(\operatorname{id}_{\underline{f}}, g\right)=\pi_{1} \Phi^{-1}\left(\mathrm{id}_{\bar{f}}, g\right)=\operatorname{id}_{X}
$$

Proof. By definition of the product, the following diagram on the left commutes:


The category $\mathcal{P}$ is loop-free, thus by applying Lemma 4 we have

$$
\pi_{1} \Phi^{-1}\left(\mathrm{id}_{\bar{f}}, g\right)=\pi_{1} \Phi^{-1}\left(f, \mathrm{id}_{\underline{g}}\right)=\mathrm{id}
$$

We prove in the same way that $\pi_{1} \Phi^{-1}\left(\mathrm{id}_{\underline{f}}, g\right)=\pi_{1} \Phi^{-1}\left(f, \mathrm{id}_{\bar{g}}\right)=\mathrm{id}$.

### 3.2 Technical lemmas

The proof of Hashimoto's theorem in [1] makes extensive use of the Proposition 6 and Proposition 7 , which we will respectively extend to connected elements of LFCat in Lemma 8 and Lemma 10. As we have changed the formulation to make the proofs easier to follow, we give them here and refer to the original work for the proof.

These lemmas are at the core of the proof and are where the hypothesis that we are using loop-free and connected categories really comes into play, so it is important to keep them in mind.
Proposition 6. Given $\Phi: P \times Q \rightarrow U \times V$ an isomorphism of connected posets and $p \in P$,

$$
\pi_{\mathcal{P}} \Phi^{-1}(u, v)=\pi_{\mathcal{P}} \Phi^{-1}\left(u^{\prime}, v^{\prime}\right)=p \text { implies } \pi_{\mathcal{P}} \Phi^{-1}\left(u, v^{\prime}\right)=p
$$

Proof. [1, Lemma 10.4.5].
Proposition 7. Given $\Phi: P \times Q \rightarrow U \times V$ an isomorphism of connected posets, if there exists $p \in P$ such that $\pi_{U} \Phi(p, q)=\pi_{U} \Phi\left(p, q^{\prime}\right)$, then for each $p^{\prime} \in P$,

$$
\pi_{U} \Phi\left(p^{\prime}, q\right)=\pi_{U} \Phi\left(p^{\prime}, q^{\prime}\right)
$$

Proof. [1, Lemma 10.4.8]
In the two following proofs, as the objects in the commutative diagrams are of no importance, we have omitted them, replacing them by $\bullet$ when not necessary.

Lemma 8. Let $\Phi: \mathcal{P} \times \mathcal{Q} \rightarrow \mathcal{U} \times \mathcal{V}$ an isomorphism of connected loop-free categories. Let $(u, v)$ and $\left(u^{\prime}, v^{\prime}\right)$ two morphisms of $\mathcal{U} \times \mathcal{V}$ and $p$ a morphism of $\mathcal{P}$. Then $\pi_{\mathcal{P}} \Phi^{-1}(u, v)=\pi_{\mathcal{P}} \Phi^{-1}\left(u^{\prime}, v^{\prime}\right)=p$ implies $\pi_{\mathcal{P}} \Phi^{-1}\left(u, v^{\prime}\right)=p$.

Proof. Given $p, q, q^{\prime}$ such that $\Phi(p, q)=(u, v)$ and $\Phi\left(p, q^{\prime}\right)=\left(u^{\prime}, v^{\prime}\right)$. Let us prove that $\pi_{\mathcal{P}} \Phi^{-1}\left(u, v^{\prime}\right)=p$. We proceed by induction on the length of the fence between $q$ and $q^{\prime}$.

- A fence of length 2 implies $\underline{q}=\underline{q}^{\prime}$ or $\bar{q}=\overline{q^{\prime}}$. First, let us suppose $\underline{q}=\underline{q}^{\prime}$, the other case being solved dually.
Let us prove that $\pi_{\mathcal{P}} \Phi^{-1}\left(u, v^{\prime}\right)=p$.
First, let us define

$$
\begin{equation*}
\Phi\left(p, \mathrm{id}_{\underline{q}}\right):=\left(u^{*}, v^{*}\right) \quad \Phi\left(\mathrm{id}_{\bar{p}}, q\right):=\left(u_{q}, v_{q}\right) \quad \Phi\left(\mathrm{id}_{\bar{p}}, q^{\prime}\right):=\left(u_{q}^{\prime}, v_{q}^{\prime}\right) \tag{5}
\end{equation*}
$$

such that:

$$
\begin{aligned}
u & =u_{q} \circ u^{*} & u^{\prime} & =u_{q}^{\prime} \circ u^{*} \\
v & =v_{q} \circ v^{*} & v^{\prime} & =v_{q}^{\prime} \circ v^{*}
\end{aligned}
$$

By the ??, the following diagram commutes:


Following the outer arrows, we get

$$
\left(u, v^{\prime}\right)=\left(u_{q}, v_{q}^{\prime}\right) \circ\left(u^{*}, v^{*}\right)
$$

By Eq. (5), $\pi_{\mathcal{P}} \Phi^{-1}\left(u^{*}, v^{*}\right)=p$. We are thus left to prove $\pi_{\mathcal{P}} \Phi^{-1}\left(u_{q}, v_{q}^{\prime}\right)=$ id. By construction $\underline{v_{q}}=\underline{v_{q}^{\prime}}=\overline{v^{*}}$ such that by functoriality:

$$
\underline{\pi_{\mathcal{P}} \Phi^{-1}\left(u_{q}, v_{q}^{\prime}\right)}=\pi_{\mathcal{P}} \Phi^{-1}\left(\underline{u_{q}}, \underline{v_{q}^{\prime}}\right)
$$

$$
\begin{aligned}
& =\pi_{\mathcal{P}} \Phi^{-1}\left(\underline{u_{q}}, \underline{v_{q}}\right) \\
& =\pi_{\mathcal{P}} \Phi^{-1}\left(u_{q}, v_{q}\right) \\
\pi_{\mathcal{P}} \Phi^{-1}\left(u_{q}, v_{q}^{\prime}\right) & =\overline{\bar{p}}
\end{aligned}
$$

By Proposition 3, $\Phi: \operatorname{Obj}(\mathcal{P}) \times \operatorname{Obj}(\mathcal{Q}) \rightarrow \operatorname{Obj}(\mathcal{U}) \times \operatorname{Obj}(\mathcal{V})$ is an order-preserving isomorphism of connected posets and such that $\pi_{\mathcal{P}} \Phi^{-1}\left(\overline{u_{q}}, \overline{v_{q}}\right)=\pi_{\mathcal{P}} \Phi^{-1}\left(\overline{u_{q}^{\prime}}, \overline{v_{q}^{\prime}}\right)=\bar{p}$. Hence,

$$
\begin{array}{lr}
\bar{p}=\pi_{\mathcal{P}} \Phi^{-1}\left(\overline{u_{q}}, \overline{v_{q}^{\prime}}\right) & \text { Proposition } 6 \\
\bar{p}=\overline{\pi_{\mathcal{P}} \Phi^{-1}\left(u_{q}, v_{q}^{\prime}\right)} & \text { by functoriality }
\end{array}
$$

Thus, $\pi_{\mathcal{P}} \Phi^{-1}\left(u_{q}, v_{q}^{\prime}\right) \in \mathcal{P}(\bar{p}, \bar{p})$, with $\mathcal{P}$ loop-free. This implies $\pi_{\mathcal{P}} \Phi^{-1}\left(u_{q}, v_{q}^{\prime}\right)=\operatorname{id}_{\bar{p}}$, such that

$$
\begin{aligned}
& \pi_{\mathcal{P}} \Phi^{-1}\left(u, v^{\prime}\right)=\pi_{\mathcal{P}} \Phi^{-1}\left(u_{q}, v_{q}^{\prime}\right) \circ \pi_{\mathcal{P}} \Phi^{-1}\left(u^{*}, v^{*}\right) \\
& \pi_{\mathcal{P}} \Phi^{-1}\left(u, v^{\prime}\right)=p
\end{aligned}
$$

- Now let us suppose a fence $\cdot \xrightarrow{q^{\prime}} \cdot \stackrel{r}{\leftarrow} \cdot \xrightarrow{q} \cdot$ of length $n=3$ between $q$ and $q^{\prime}$. Let

We are going to use the same method as before, working on each 2-fence inside the 3 -fence above. For that we'll decompose ( $u, v^{\prime}$ ) using the Diagram 7. By the ??, the following diagram commutes:

such that

\left(u, v^{\prime}\right)=\left(u_{q}, \mathrm{id}_{\overline{v_{r}}}\right) \circ\left(u^{*}, y^{*}\right) \circ\left(\operatorname{id}_{\underline{u_{r}^{\prime}}}, v_{q}^{\prime}\right) & \text { By the Diagram } 7
\end{array}

- Working on the 2-fence $\stackrel{q}{\leftarrow} \cdot \xrightarrow{r}$, let us prove $\pi_{\mathcal{P}} \Phi^{-1}\left(u_{q}, \mathrm{id}_{\overline{v_{r}}}\right)=\mathrm{id}$

By Eq. (6) we have $\pi_{\mathcal{P}} \Phi^{-1}(u, v)=\pi_{\mathcal{P}} \Phi^{-1}(x, y)=p$. Thus, as proved for 2-fences above

p & =\pi_{\mathcal{P}} \Phi^{-1}(u, y) & & \\
& =\pi_{\mathcal{P}} \Phi^{-1}\left(\left(u_{q}, v_{r}\right) \circ\left(u^{*}, v^{*}\right)\right) & & \text { Diagram } 7 \\
& =\pi_{\mathcal{P}} \Phi^{-1}\left(u_{q}, v_{r}\right) \circ \pi_{\mathcal{P}} \Phi^{-1}\left(u^{*}, v^{*}\right) & & \text { Functoriality } \\
p & =\pi_{\mathcal{P}} \Phi^{-1}\left(u_{q}, v_{r}\right) \circ p & & \text { Diagram } 7
\end{aligned}
$$

By loop-free property of $\mathcal{P}, \pi_{\mathcal{P}} \Phi^{-1}\left(u_{q}, v_{r}\right)=\mathrm{id}_{\bar{p}}$. Which implies by Lemma 5 ,

Similarly, $\pi_{\mathcal{P}} \Phi^{-1}\left(\mathrm{id}_{\underline{u_{r}^{\prime}}}, v_{q}^{\prime}\right)=\operatorname{id}_{\underline{p}}$. Hence

& =\operatorname{id}_{\bar{p}} \circ \pi_{\mathcal{P}} \Phi^{-1}\left(u^{*}, y^{*}\right) \circ \operatorname{id}_{\underline{p}} \\
\pi_{\mathcal{P}} \Phi^{-1}\left(u, v^{\prime}\right) & =\pi_{\mathcal{P}} \Phi^{-1}\left(u^{*}, y^{*}\right)
\end{aligned}
$$

- Let us prove now $\pi_{\mathcal{P}} \Phi^{-1}\left(u^{*}, y^{*}\right)=p$. By commutativity of both projections the central square:

(x, y) & =\left(u_{r}, \mathrm{id}_{\underline{v_{r}}}\right) \circ\left(u^{*}, y^{*}\right) \circ\left(\mathrm{id}_{\underline{u_{r}^{\prime}}}, v_{r}^{\prime}\right)
\end{aligned}
$$

As $\pi_{\mathcal{P}} \Phi^{-1}\left(u_{r}, v_{r}\right)=\operatorname{id}_{\bar{p}}$, by Lemma $5, \pi_{\mathcal{P}} \Phi^{-1}\left(u_{r}, \mathrm{id}_{\overline{v_{r}}}\right)=\operatorname{id}_{\bar{p}}$. Similarly, we have $\pi_{\mathcal{P}} \Phi^{-1}\left(\mathrm{id}_{\underline{u_{r}^{\prime}}}, v_{r}^{\prime}\right)=\mathrm{id}_{\underline{p}}$. Thus

p=\pi_{\mathcal{P}} \Phi^{-1}(x, y)=\pi_{\mathcal{P}} \Phi^{-1}\left(u^{*}, y^{*}\right)

Such that

- Now let us suppose that the property holds for all fences of length $1 \leq k<n$, with $n>3$. Let us suppose given $q, q^{\prime}$, connected by a fence $\left(q_{i}\right)_{1 \leq i \leq n}$. We define $\left(u_{i}, v_{i}\right):=\Phi\left(p, q_{i}\right)$, for each $1 \leq i \leq n$ and

(u, v):=\left(u_{1}, v_{1}\right)=\Phi\left(p, q_{1}\right)=\Phi(p, q) \\
\left(u^{\prime}, v^{\prime}\right):=\left(u_{n}, v_{n}\right)=\Phi\left(p, q_{n}\right)=\Phi\left(p, q^{\prime}\right)
\end{gathered}
$$

By definition, $\left(\left(p, q_{i}\right)\right)_{1 \leq i \leq n-1}$ and $\left(\left(p, q_{i}\right)\right)_{2 \leq i \leq n}$ are fences of length $n-1$ respectively connecting $\left(p, q_{1}\right),\left(p, q_{n-1}\right)$ and $\left(p, q_{2}\right),\left(p, q_{n}\right)$. By definition of $\left(u_{i}, v_{i}\right)$ we have,

& p=\pi_{\mathcal{P}} \Phi^{-1}\left(u_{1}, v_{1}\right)=\pi_{\mathcal{P}} \Phi^{-1}\left(u_{n-1}, v_{n-1}\right) \\
& p=\pi_{\mathcal{P}} \Phi^{-1}\left(u_{2}, v_{2}\right)=\pi_{\mathcal{P}} \Phi^{-1}\left(u_{n}, v_{n}\right)
\end{aligned}
$$

Thus, by induction hypothesis, this implies

$$

p=\pi_{\mathcal{P}} \Phi^{-1}\left(u_{1}, v_{n-1}\right) \quad p=\pi_{\mathcal{P}} \Phi^{-1}\left(u_{2}, v_{n}\right) \tag{8}
\end{equation*}
$$

Now we suppose $\overline{q_{1}}=\overline{q_{2}}$ ( $\underline{q_{1}}=\underline{q_{2}}$ can be treated dually). We'll have to proceed differently depending on the symmetry of the fence.

- If $\overline{q_{n-1}}=\overline{q_{n}}$, by functoriality of $\Phi, \overline{u_{n-1}}, \overline{v_{n-1}}=\overline{u_{n}}, \overline{v_{n}}$, such that $\overline{u_{2}}, \overline{v_{n}}=$ $\overline{u_{1}}, \overline{v_{n-1}}$. This implies that $\left(u_{1}, v_{n-1}\right)$ and $\left(u_{2}, v_{n}\right)$ are connected by a fence of length 2. Thus, $\pi_{\mathcal{Q}} \Phi^{-1}\left(u_{1}, v_{n-1}\right)$ and $\pi_{\mathcal{Q}} \Phi^{-1}\left(u_{2}, v_{n}\right)$ are connected by a fence of length 2. By Eq. (8), we have $p=\pi_{\mathcal{P}} \Phi^{-1}\left(u_{2}, v_{n}\right)=\pi_{\mathcal{P}} \Phi^{-1}\left(u_{1}, v_{n-1}\right)$. We can then apply our induction hypothesis, such that

- If $\underline{q_{n-1}}=\underline{q_{n}}$, by functoriality of $\Phi, \underline{u_{n-1}}, \underline{v_{n-1}}=\underline{u_{n}}, \underline{v_{n}}$. Thus, if we define $q_{2, n}=\pi_{\mathcal{Q}} \Phi^{-1}\left(u_{2}, v_{n}\right)$ and $q_{1, n-1}=\pi_{\mathcal{Q}} \Phi^{-1}\left(u_{1}, v_{n-1}\right)$, we get the following fences:


Thus, $q_{2, n}$ et $q_{1, n-1}$ are connected by a fence of length 3 . We can apply our induction case for $k=3$ with the fence $\left(p, q_{1, n-1}\right),\left(p, \pi_{\mathcal{Q}} \Phi^{-1}\left(u_{1}, v_{n}\right)\right)$, $\left(p, q_{2, n}\right)$. Indeed, we have $\Phi\left(p, q_{1, n-1}\right)=\left(u_{1}, v_{n-1}\right)$ and $\Phi\left(p, q_{2, n}\right)=\left(u_{2}, v_{n}\right)$ (Eq. (8)). Thus, we get

\pi_{\mathcal{P}} \Phi^{-1}\left(u_{1}, v_{n}\right)=p
$$

Thus, $\pi_{\mathcal{P}} \Phi^{-1}(u, v)=\pi_{\mathcal{P}} \Phi^{-1}\left(u^{\prime}, v^{\prime}\right)=p$ implies $\pi_{\mathcal{P}} \Phi^{-1}\left(u, v^{\prime}\right)=p$, proving the induction step.

This Lemma 8 is not restricted to binary product and easily extends to arbitrary products as shown in the following lemma.
Corollary 9. Let $\Phi: \prod_{\alpha \in A} X_{\alpha} \rightarrow \prod_{\beta \in B} Y_{\beta}$ an isomorphism of connected categories. Let $f^{i}=\left(f_{\alpha}^{i}\right)_{\alpha \in A}$ a morphism of $\prod_{\alpha \in A} X_{\alpha}$ for $i=1,2$. Then for all $\lambda \in A$ and all $\mu \in B$ such that $\pi_{\lambda} f^{1}=\pi_{\lambda} f^{2}$

$$
\pi_{\lambda} \Phi^{-1}\left(\Phi\left(f^{1}\right), \Phi\left(f^{2}\right)_{\mu}, \mu\right)=\pi_{\lambda} f^{1}=\pi_{\lambda} f^{2}
$$

Proof. This follows directly from Lemma 8 by defining:

\end{aligned}

With $\delta_{\lambda}$ and $\delta_{\mu}$ the natural isomorphisms:

\delta_{\lambda}: X_{\lambda} \times \prod_{\alpha \in A, \alpha \neq \lambda} X_{\alpha} \rightarrow \prod_{\alpha \in A} X_{\alpha} \quad \delta_{\beta}: Y_{\mu} \times \prod_{\beta \in B, \mu \neq \beta} Y_{\beta} \rightarrow \prod_{\beta \in B} Y_{\beta}
$$

We get an isomorphisms $\Psi=\delta_{\beta}^{-1} \circ \Phi \circ \delta_{\lambda}: P \times Q \rightarrow U \times V$. Such that $f_{\lambda}^{i}=\pi_{\mathcal{P}} \Psi^{-1}\left(u, v^{\prime}\right)$ for $i=1,2$.

Lemma 10. Let $\Phi: \mathcal{P} \times \mathcal{Q} \rightarrow \mathcal{U} \times \mathcal{V}$ be an isomorphism of connected loop-free categories. Let $\mathcal{Q}^{\prime}$ a connected subcategory of $\mathcal{Q}$. Let $p$ a morphism of $\mathcal{P}$. Then $\pi_{U} \Phi(p, q)=$ $\pi_{U} \Phi\left(p, q^{\prime}\right)$ for all $q, q^{\prime} \in \mathcal{Q}^{\prime}$ implies, for all $p^{\prime} \in \mathcal{P}, \pi_{U} \Phi\left(p^{\prime}, q\right)=\pi_{U} \Phi\left(p^{\prime}, q^{\prime}\right)$ for all $q, q^{\prime} \in \mathcal{Q}^{\prime}$.

Proof. Let $p$ a morphism of $\mathcal{P}$ Let $\mathcal{Q}^{\prime}$ a connected sub-category of $\mathcal{Q}$, such that for all morphisms $q, q^{\prime}$ in $\mathcal{Q}^{\prime}, \pi_{U} \Phi(p, q)=\pi_{U} \Phi\left(p, q^{\prime}\right)$. Let us prove that for all $p^{\prime}$ morphism of $\mathcal{P}, \pi_{U} \Phi\left(p^{\prime}, q^{\prime}\right)=\pi_{U} \Phi\left(p^{\prime}, q\right)$ by induction on the length $n$ of a given fence connecting $q, q^{\prime}$.

- $n=1$. Trivial.
- $n=2$. $\pi_{U} \Phi(p, q)=\pi_{U} \Phi\left(p, q^{\prime}\right)$ for all morphisms $q, q^{\prime}$ in $\mathcal{Q}^{\prime}$ implies

$$
\begin{array}{rlrl}
\frac{\pi_{U} \Phi(p, q)}{\pi_{U} \Phi(\underline{p}, \underline{q})} & =\underline{\pi_{U} \Phi\left(p, q^{\prime}\right)} & & \\
\pi_{U} \Phi\left(\underline{p}, q^{\prime}\right) & & \text { for all } q, q^{\prime} \in \operatorname{Mor}(\mathcal{Q}) \\
& =\pi_{U} \Phi\left(\underline{p}, Q^{\prime}\right) & & \text { for all } Q, Q^{\prime} \in \operatorname{Obj}(\mathcal{Q})
\end{array}
$$

By Proposition $\left.3 \Phi\right|_{\text {obj }}$ is an isomorphism between $\operatorname{Obj}(\mathcal{P}) \times \operatorname{Obj}(\mathcal{Q})$ and $\operatorname{Obj}(\mathcal{U}) \times$ $\operatorname{Obj}(\mathcal{V})$. By Proposition 7

$$

\text { for all } Q, Q^{\prime} \in \operatorname{Obj}(\mathcal{Q}), \pi_{U} \Phi\left(\underline{p^{\prime}}, Q\right)=\pi_{U} \Phi\left(\underline{p^{\prime}}, Q^{\prime}\right) \tag{9}
\end{equation*}
$$

Thus for $q \in \operatorname{Mor}\left(\mathcal{Q}^{\prime}\right)$ we have

\pi_{U} \Phi\left(\mathrm{id}_{\underline{p^{\prime}}}, q\right) & =\pi_{U} \Phi\left(\underline{p^{\prime}}, \underline{q}\right) \\
& =\pi_{U} \Phi\left(\underline{p^{\prime}}, \bar{q}\right)  \tag{9}\\
& =\pi_{U} \Phi\left(\overline{\mathrm{id}_{\underline{p^{\prime}}}}, \bar{q}\right) \\
\pi_{U} \Phi\left(\mathrm{id}_{\underline{p^{\prime}}}, q\right) & =\overline{\pi_{U} \Phi\left(\mathrm{id}_{\underline{p^{\prime}}}, q\right)}
\end{align*}
$$

As $\mathcal{Q}^{\prime}$ is loop-free, this implies $\pi_{U} \Phi\left(\operatorname{id}_{\underline{p^{\prime}}}, q\right)=\mathrm{id}$. Similarly, $\pi_{U} \Phi\left(\mathrm{id}_{\underline{p^{\prime}}}, q^{\prime}\right)=\mathrm{id}$.
Let us suppose that $\bar{q}=\overline{q^{\prime}}$, the other case being dual. By the above argument, the following diagrams commute


Therefore, $\pi_{U} \Phi\left(p^{\prime}, q^{\prime}\right)=\pi_{U} \Phi\left(p^{\prime}, \operatorname{id}_{\bar{q}}\right)=\pi_{U} \Phi\left(p^{\prime}, q\right)$.

- Now suppose a fence $\left(q=q_{0}, q_{1} \cdots, q_{n}=q^{\prime}\right)$ and the property true for all integers strictly smaller than $n$. Then there is a $n$-1-fence $\left(q_{1}, \cdots, q_{n}\right)$ and a 1-fence $\left(q_{0}, q_{1}\right)$. By induction hypothesis, $\pi_{U} \Phi\left(p^{\prime}, q_{n}\right)=\pi_{U} \Phi\left(p^{\prime}, q_{1}\right)=\pi_{U} \Phi\left(p^{\prime}, q_{0}\right)$.
$\mathcal{Q}^{\prime}$ is connected so for all $p^{\prime} \in \mathcal{P}$, for all $q, q^{\prime} \in \mathcal{Q}^{\prime}, \pi_{U} \Phi\left(p^{\prime}, q^{\prime}\right)=\pi_{U} \Phi\left(p^{\prime}, q^{\prime}\right)$.


## 4 Proof of Theorem A

For the remainder of section, we will consider that $\Phi$ is an isomorphism of connected loop-free categories, $\left(X_{\alpha}\right)_{\alpha \in A}$ and $\left(Y_{\beta}\right)_{\beta \in B}$ families of connected loop-free categories.

As stated before, we will first prove that all the morphisms of the Diagram 2 are isomorphisms.

Lemma 11. Given a category $X=\prod_{\alpha \in A} X_{\alpha}, \lambda \in A$, s a morphism of $X$ and $\Xi_{\lambda}^{s}$ as defined in Definition 7, then

$$
\pi_{\lambda} \circ \Xi_{\lambda}^{s}=\operatorname{id}_{X_{\lambda}}
$$

We say that $\Xi_{\lambda}^{s}$ is a section of the canonical projection $\pi_{\lambda}: \prod_{\alpha \in A} X_{\alpha} \rightarrow X_{\lambda}$. Furthermore, $\Xi_{\lambda}^{s}$ is a full and faithful functor

Proof. Let $f \in \prod_{\alpha \in A} X_{\alpha}\left(\left(s, x_{\lambda}, \lambda\right),\left(s, y_{\lambda}, \lambda\right)\right)$. Then $X_{\alpha}$ loop-free implies, $\pi_{\alpha} f=\operatorname{id}_{s_{\alpha}}$ if $\alpha \neq \lambda$ and $\pi_{\lambda} f:=f_{\lambda} \in X_{\lambda}\left(x_{\lambda}, y_{\lambda}\right)$. Such that $f=\Xi_{\lambda}^{s}\left(f_{\lambda}\right)$. This proves that $\Xi_{\lambda}^{s}$ is full. Furthermore, it is clearly faithful.

Corollary 12. Given a category $X=\prod_{\alpha \in A} X_{\alpha}, \lambda \in A$, s a morphism of $X$ then $X_{\lambda}^{s}=\Xi_{\lambda}^{s}(X)$ is a connected, loop-free full sub-category of $X$ isomorphic to $X_{\lambda}$. Furthermore

$$
\pi_{\lambda} \circ \Xi_{\lambda}^{s}=\left.\operatorname{id}_{X_{\lambda}} \quad \Xi_{\lambda}^{s} \circ \pi_{\lambda}\right|_{X_{\lambda}^{s}}=\operatorname{id}_{X_{\lambda}^{s}}
$$

One last proposition that we will need from [1] is the fact that for any $\lambda \in A, s_{\lambda}$ object of $X_{\lambda}$, the object part of the functor $\left.\Phi\right|_{X_{\lambda}^{s}}: X_{\lambda}^{s} \rightarrow \prod_{\beta \in B} Y_{\beta}^{\lambda}$ is an isomorphism of the underlying objects of the category.

Proposition 13. [1, Lemma 10.4.7]
Let $\Phi: \prod_{\alpha \in A} X_{\alpha} \rightarrow \prod_{\beta \in B} Y_{\beta}$ be an isomorphism of connected posets. Let $s \in$ $\prod_{\alpha \in A} X_{\alpha}$ and $\lambda \in A$ and $X_{\lambda}^{s}$ be as in Lemma 11. Let $Y_{\beta}^{\lambda}=\pi_{\beta} \Phi\left[X_{\lambda}^{s}\right]$, then

$$
\left.\Phi\right|_{X_{\lambda}^{s}}: X_{\lambda}^{s} \rightarrow \prod_{\beta \in B} Y_{\beta}^{\lambda}
$$

is an isomorphism of posets.
This proposition also translates to an isomorphism of connected categories.
Proposition 14. Let $\Phi: \prod_{\alpha \in A} X_{\alpha} \rightarrow \prod_{\beta \in B} Y_{\beta}$ be an isomorphism of connected loop-free categories. Let $s \in \prod_{\alpha \in A} X_{\alpha}$ and $\lambda \in A$ and $X_{\lambda}^{s}$ be as in Lemma 11. Let $Y_{\beta}^{\lambda}=\pi_{\beta} \Phi\left[X_{\lambda}^{s}\right]$, then

$$
\left.\Phi\right|_{X_{\lambda}^{s}}: X_{\lambda}^{s} \rightarrow \prod_{\beta \in B} Y_{\beta}^{\lambda}
$$

is an isomorphism of connected loop-free categories.
Proof. Let us show that $\left.\Phi\right|_{X_{\lambda}^{s}}: X_{\lambda}^{s} \rightarrow \prod_{\beta \in B} Y_{\beta}^{\lambda}$ is essentially surjective. By Proposition 3, $\left.\Phi_{\mathrm{Obj}}\right|_{X \lambda} ^{s}$ is an isomorphism of posets. Thus, by Proposition 13,

$$
\Phi_{\mathrm{Obj}}\left[X_{\lambda}^{s}\right]=\prod_{\beta \in B} \pi_{\beta} \Phi_{\mathrm{Obj}}\left[\operatorname{Obj}\left(X_{\lambda}^{s}\right)\right]
$$

$$
\begin{aligned}
& =\prod_{\beta \in B} \operatorname{Obj}\left(\pi_{\beta} \Phi\left[X_{\lambda}^{s}\right]\right) \\
\Phi_{\text {Obj }}\left[X_{\lambda}^{s}\right] & =\operatorname{Obj}\left(\prod_{\beta \in B} \pi_{\beta} \Phi\left[X_{\lambda}^{s}\right]\right)
\end{aligned}
$$

Thus $\left.\Phi\right|_{X_{\lambda}^{s}}$ is essentially surjective. \pi_{\alpha} \Psi^{-1}\left(\Psi\left(g^{\mu}\right), \Psi_{\lambda}\left(f_{\lambda}\right), \lambda\right)=g_{\alpha}^{\mu} \tag{12}
\end{equation*}
$$

- For $\lambda$, By Eq. (12), $\Psi^{-1}\left(\Psi\left(g^{\mu}\right), \Psi_{\lambda}\left(f_{\lambda}\right), \lambda\right) \in\left(X_{\alpha}^{\mu}, X_{\lambda}, \lambda\right)$, such that by Eq. (11)

$$
\begin{align*}
\pi_{\lambda} \Psi \Xi_{\lambda}^{s}\left(\pi_{\lambda} \Psi^{-1}\left(\Psi\left(g^{\mu}\right), \Psi_{\lambda}\left(f_{\lambda}\right), \lambda\right)\right) & =\pi_{\lambda} \Psi \Psi^{-1}\left(\Psi\left(g^{\mu}\right), \Psi_{\lambda}\left(f_{\lambda}\right), \lambda\right) \\
& =\Psi_{\lambda}\left(f_{\lambda}\right) \\
\pi_{\lambda} \Psi \Xi_{\lambda}^{s}\left(\pi_{\lambda} \Psi^{-1}\left(\Psi\left(g^{\mu}\right), \Psi_{\lambda}\left(f_{\lambda}\right), \lambda\right)\right) & =\pi_{\lambda} \Psi \Xi_{\lambda}^{s}\left(f_{\lambda}\right) \tag{11}
\end{align*}
$$

By faithfulness of $\pi_{\lambda} \Psi \Xi_{\lambda}^{s}$ (Lemma 18),

$$
\begin{equation*}
\pi_{\lambda} \Psi^{-1}\left(\Psi\left(g^{\mu}\right), \Psi_{\lambda}\left(f_{\lambda}\right), \lambda\right)=f_{\lambda} \tag{13}
\end{equation*}
$$

By Eq. (12) and Eq. (13), we have $\left(g^{\mu}, f_{\lambda}, \lambda\right)=\Psi^{-1}\left(\Psi\left(g^{\mu}\right), \Psi_{\lambda}\left(f_{\lambda}\right), \lambda\right)$ i.e.

$$
\begin{equation*}
\Psi\left(g^{\mu}, f_{\lambda}, \lambda\right)=\left(\Psi\left(g^{\mu}\right), \Psi_{\lambda}\left(f_{\lambda}\right), \lambda\right) \tag{14}
\end{equation*}
$$

So far Eq. (14) only holds when $g^{\mu} \in \prod_{\alpha \in A} X_{\alpha}^{\mu}$. Let us prove that it is in fact valid for all $g \in \prod_{\alpha \in A} X_{\alpha}$, i.e. for all $\lambda \in A$ and for all $f_{\lambda} \in X_{\lambda}$

$$
\Psi\left(g, f_{\lambda}, \lambda\right)=\left(\Psi(g), \Psi_{\lambda}\left(f_{\lambda}\right), \lambda\right)
$$

Let $\rho \in A, \rho \neq \lambda$. By Eq. (14), for all $f_{\lambda} \in X_{\lambda}, \pi_{\rho} \Psi\left(g^{\mu}, f_{\lambda}, \lambda\right)=\pi_{\rho} \Psi\left(g^{\mu}\right)$. By Lemma 10 this implies, for all $g \in \prod_{\alpha \in A} X_{\alpha}$, for all $f_{\lambda} \in X_{\lambda}$

$$
\begin{equation*}
\pi_{\bar{\lambda}} \Psi\left(g, f_{\lambda}, \lambda\right)=\pi_{\bar{\lambda}} \Psi(g):=\Psi_{\bar{\lambda}}(g) \tag{15}
\end{equation*}
$$

where $\pi_{\bar{\lambda}}$ is the projection on $A \backslash\{\lambda\}$.
Thus, proving $\Psi\left(g, f_{\lambda}, \lambda\right)=\left(\Psi(g), \Psi_{\lambda}\left(f_{\lambda}\right), \lambda\right)$ is equivalent to proving,

$$
\left(\Psi\left(g, f_{\lambda}, \lambda\right), \Psi_{\lambda}\left(f_{\lambda}\right), \lambda\right)=\Psi\left(g, f_{\lambda}, \lambda\right)
$$

i.e.

$$
\Psi^{-1}\left(\Psi\left(g, f_{\lambda}, \lambda\right), \Psi_{\lambda}\left(f_{\lambda}\right), \lambda\right)=\left(g, f_{\lambda}, \lambda\right)
$$

Let us look at the different projections

- On $X_{\lambda}$.
$\pi_{\lambda} \Psi^{-1}\left(\Psi\left(g, f_{\lambda}, \lambda\right)\right)=\pi_{\lambda} \Psi^{-1}\left(\Psi \Xi_{\lambda}^{s}\left(f_{\lambda}\right)\right)=f_{\lambda}$ implies by Corollary 9

$$
\begin{aligned}
\pi_{\lambda} \Psi^{-1}\left(\Psi\left(g, f_{\lambda}, \lambda\right), \pi_{\lambda} \Psi \Xi_{\lambda}^{s}\left(f_{\lambda}\right), \lambda\right) & =f_{\lambda} \\
\pi_{\lambda} \Psi^{-1}\left(\Psi\left(g, f_{\lambda}, \lambda\right), \Psi_{\lambda}\left(f_{\lambda}\right), \lambda\right) & =f_{\lambda} \quad \text { Eq. (11) }
\end{aligned}
$$

- On $\prod \alpha \neq \lambda X_{\alpha}$

By Eq. (15), for all $h \in \prod_{\alpha \in A} X_{\alpha}, \pi_{\bar{\lambda}} \Psi\left(h, \operatorname{id}_{s_{\lambda}}, \lambda\right)=\pi_{\bar{\lambda}} \Psi(h)$. Applying this to the element $h=\Psi^{-1}\left(\Psi\left(g, f_{\lambda}, \lambda\right), \Psi_{\lambda}\left(f_{\lambda}\right), \lambda\right)$ we get

$$
\begin{align*}
\pi_{\bar{\lambda}} \Psi\left(\Psi^{-1}\left(\Psi\left(g, f_{\lambda}, \lambda\right), \Psi_{\lambda}\left(f_{\lambda}\right), \lambda\right), \operatorname{id}_{s \lambda}, \lambda\right) & =\pi_{\bar{\lambda}} \Psi \Psi^{-1}\left(\Psi\left(g, f_{\lambda}, \lambda\right), \Psi_{\lambda}\left(f_{\lambda}\right), \lambda\right) \\
& =\pi_{\bar{\lambda}}\left(\Psi\left(g, f_{\lambda}, \lambda\right), \Psi_{\lambda}\left(f_{\lambda}\right), \lambda\right) \\
& =\pi_{\bar{\lambda}} \Psi\left(g, f_{\lambda}, \lambda\right) \tag{15}
\end{align*}
$$

$\pi_{\bar{\lambda}} \Psi\left(\Psi^{-1}\left(\Psi\left(g, f_{\lambda}, \lambda\right), \Psi_{\lambda}\left(f_{\lambda}\right), \lambda\right), \operatorname{id}_{s \lambda}, \lambda\right)=\pi_{\bar{\lambda}} \Psi\left(g, \mathrm{id}_{s \lambda}, \lambda\right)$
By faithfulness of $\left.\pi_{\bar{\lambda}} \Psi\right|_{\left(\prod_{\alpha \in A} X_{\alpha}, \tilde{s_{\lambda}}, \lambda\right)}$ (Lemma 18),

$$
\begin{aligned}
\left(\Psi^{-1}\left(\Psi\left(g, f_{\lambda}, \lambda\right), \Psi_{\lambda}\left(f_{\lambda}\right), \lambda\right), \operatorname{id}_{s_{\lambda}}, \lambda\right) & =\left(g, \operatorname{id}_{s_{\lambda}}, \lambda\right) \\
\pi_{\bar{\lambda}} \Psi^{-1}\left(\Psi\left(g, f_{\lambda}, \lambda\right), \Psi_{\lambda}\left(f_{\lambda}\right)\right) & =\pi_{\bar{\lambda}} g
\end{aligned}
$$

Thus $\Psi^{-1}\left(\Psi\left(g, f_{\lambda}, \lambda\right), \Psi_{\lambda}\left(f_{\lambda}\right), \lambda\right)=\left(g, f_{\lambda}, \lambda\right)$ and as such, for all $f_{\lambda} \in \lambda$, for all $g \in$ $\prod_{\alpha \in A} X_{\alpha}$,

$$
\Psi\left(g, f_{\lambda}, \lambda\right)=\left(\Psi(g), \Psi_{\lambda}\left(f_{\lambda}\right), \lambda\right)
$$

As this is true for any $f, g \in \prod_{\alpha \in A} X_{\alpha}$, and any $\lambda$, we get

$$
\Psi(f)=\left(\Psi_{\alpha}\left(f_{\alpha}\right)\right)_{\alpha \in A}
$$

All that is left to do is to prove that $\Psi_{\alpha}\left(f_{\alpha}\right)$ is the same whether $\Psi=\Psi_{2}$ or $\Psi=$ $\gamma^{-1} \circ \Psi_{1} \circ \Phi$. By Eq. (11)

$$
\Psi_{\lambda}\left(f_{\lambda}\right)=\pi_{\lambda} \Psi \Xi_{\lambda}^{s}\left(f_{\lambda}\right)
$$

But, by definition

$$
\begin{aligned}
\pi_{\beta} \pi_{\lambda} \Psi_{2}\left(\Xi_{\lambda}^{s} f_{\lambda}\right) & =\pi_{\beta} \pi_{\lambda}\left(\Phi^{-1} \circ \Xi_{\beta}^{\Phi(s)} \circ \pi_{\beta} \circ \Phi \circ \Xi_{\lambda}^{s}\right)\left(\pi_{\lambda}\left(\Xi_{\lambda}^{s} f_{\lambda}\right)\right) & & \\
& =\pi_{\beta} \pi_{\lambda}\left(\Phi^{-1} \circ \Xi_{\beta}^{\Phi(s)} \circ \pi_{\beta} \circ \Phi \circ \Xi_{\lambda}^{s}\right)\left(f_{\lambda}\right) & & \text { Lemma 11 } \\
& =\pi_{\beta} \pi_{\lambda}\left(\Phi^{-1} \Xi_{\beta}^{\Phi(s)}\right)\left(\pi_{\beta} \Phi\right)\left(\Xi_{\lambda}^{s} f_{\lambda}\right) & & \\
\pi_{\beta} \pi_{\lambda} \Psi_{2}\left(\Xi_{\lambda}^{s} f_{\lambda}\right) & =\pi_{\beta} \pi_{\lambda} \gamma^{-1} \circ \Psi_{1} \circ \Phi\left(\Xi_{\lambda}^{s} f_{\lambda}\right) & & \text { by Definition of } \Psi_{1}
\end{aligned}
$$

This is true for all $\lambda$ and $\beta$, thus $\Psi_{2}=\gamma^{-1} \circ \Psi_{1} \circ \Phi$

This concludes the proof of the commutativity of the diagram in Theorem A.
