Preface

The following is a collection of 12 exercises picked from the exam tests of the course *Elements of Quantum Field Theory*, teached by professor Mauro Moretti in the academic year 2021-22 for the Master's Degree in Physics at the University of Ferrara.

The goal of this review is to provide a general method to approach the main types of calculations in Quantum Field Theory. The topics that will be treated are: applications of Noether's theorem, checking of Ward identities, computations of cross sections and decay rates. In order to be as clear as possible in the solutions we preferred to be very explicit in the calculations, at the risk of being tedious. We must thank Thomas Lovo, for the constant help and suggestions given, and dr. Alessandro Greco, whose lecture notes of the course proved to be essential in order to write these ones.

Chapter 1

Noether's Theorem and Conserved Charges

1.1 Complex Klein-Gordon field

Text. Given a complex Klein-Gordon field, described by the Lagrangian

$$\mathcal{L} = \partial_{\mu}\phi\partial^{\mu}\phi^* - m^2\phi\phi^*$$

determine the conserved charges of the theory.

Solution. First of all, remember that for every lagrangian theory we distinguish symmetries in *space-time* symmetries (resulting from transformations of space-time coordinates) and *internal* symmetries (resulting from field transformations which leave the coordinates untouched). The former type is common to all Lagrangians that are invariant under space-time translations, and its associated Noether currents correspond to the stress-energy tensor

$$T^{\mu\nu} = \frac{\partial \mathcal{L}}{\partial(\partial_{\mu}\phi)} \partial^{\nu}\phi - \mathcal{L}g^{\mu\nu}$$
(1.1.1)

where $g^{\mu\nu}$ is the metric tensor; the following ones are the conserved charges

$$P^{\nu} = \int d^3 x T^{0\nu}$$
 (1.1.2)

This Lagrangian has also a *phase* symmetry

$$\phi \to \phi' = e^{i\varepsilon}\phi \sim (1+i\varepsilon)\phi$$

$$\phi^* \to \phi'^* = e^{-i\varepsilon}\phi^* \sim (1-i\varepsilon)\phi^*$$
(1.1.3)

where ε is an arbitrary small parameter. The total variations of the fields are

$$\varepsilon \overline{\delta} \phi \stackrel{def}{=} \phi' - \phi = i \varepsilon \phi$$

$$\varepsilon \overline{\delta} \phi^* \stackrel{def}{=} \phi'^* - \phi^* = -i \varepsilon \phi^*$$
(1.1.4)

so the Noether currents are

$$j^{\mu} = \frac{\partial \mathcal{L}}{\partial(\partial_{\mu}\phi)}\overline{\delta}\phi + \frac{\partial \mathcal{L}}{\partial(\partial_{\mu}\phi^{*})}\overline{\delta}\phi^{*} = i\left[\phi\partial_{\mu}\phi^{*} - \phi\partial_{\mu}\phi\right]$$
(1.1.5)

therefore its associated conserved charge is

$$Q = \int d^3x j^0 = i \int d^3x \left[\phi \partial_0 \phi^* - \phi^* \partial_0 \phi \right] =: Q_1 + Q_2$$
(1.1.6)

The *real* Klein-Gordon field can be written as a combination of the ladder operators a^{\dagger} and a; in the case of a *complex* scalar field we must treat ϕ and ϕ^* as two separate fields, so that we have two distinct types of ladder operators, a and b, associated to two different types of particles. Being the two fields simply related by complex conjugation, we can write them as follows

$$\phi(x) = \int \frac{d^3p}{(2\pi)^3} \frac{1}{\sqrt{2E_{\mathbf{p}}}} \left[a_{\mathbf{p}} e^{-iE_{\mathbf{p}}t} e^{i\mathbf{p}\cdot\mathbf{x}} + b_{\mathbf{p}}^{\dagger} e^{iE_{\mathbf{p}}t} e^{-i\mathbf{p}\cdot\mathbf{x}} \right]$$

$$\phi^*(x) = \int \frac{d^3p}{(2\pi)^3} \frac{1}{\sqrt{2E_{\mathbf{p}}}} \left[a_{\mathbf{p}}^{\dagger} e^{iE_{\mathbf{p}}t} e^{-i\mathbf{p}\cdot\mathbf{x}} + b_{\mathbf{p}} e^{-iE_{\mathbf{p}}t} e^{i\mathbf{p}\cdot\mathbf{x}} \right]$$
(1.1.7)

We reobtain the case of a real Klein-Gordon field by setting $b_{\mathbf{p}} = a_{\mathbf{p}}$. Let's now calculate $Q_1 = i \int d^3x \phi \partial_0 \phi^*$

$$\partial_0 \phi^*(x) = \int \frac{d^3 p}{(2\pi)^3} \frac{1}{\sqrt{2E_{\mathbf{p}}}} \left[iE_{\mathbf{p}} a_{\mathbf{p}}^{\dagger} e^{iE_{\mathbf{p}}t} e^{-i\mathbf{p}\cdot\mathbf{x}} - iE_{\mathbf{p}} b_{\mathbf{p}} e^{-iE_{\mathbf{p}}t} e^{i\mathbf{p}\cdot\mathbf{x}} \right]$$
(1.1.8)

$$\phi(x)\partial_0\phi^*(x) = \int \frac{d^3p}{(2\pi)^3} \frac{1}{\sqrt{2E_{\mathbf{p}}}} \frac{d^3q}{(2\pi)^3} \frac{1}{\sqrt{2E_{\mathbf{q}}}} (iE_{\mathbf{p}}) \left[a_{\mathbf{p}}e^{-iE_{\mathbf{p}}t}e^{i\mathbf{p}\cdot\mathbf{x}} + b_{\mathbf{p}}^{\dagger}e^{iE_{\mathbf{p}}t}e^{-i\mathbf{p}\cdot\mathbf{x}} \right] \\ \left[iE_{\mathbf{p}}a_{\mathbf{p}}^{\dagger}e^{iE_{\mathbf{p}}t}e^{-i\mathbf{p}\cdot\mathbf{x}} - iE_{\mathbf{p}}b_{\mathbf{p}}e^{-iE_{\mathbf{p}}t}e^{i\mathbf{p}\cdot\mathbf{x}} \right]$$
(1.1.9)

so that

$$Q_{1} = i \frac{1}{(2\pi)^{3}} \frac{1}{2\sqrt{E_{\mathbf{q}}E_{\mathbf{p}}}} (iE_{\mathbf{p}}) \int d^{3}x d^{3}p d^{3}q \left[a_{\mathbf{q}}a_{\mathbf{p}}^{\dagger}e^{i(E_{\mathbf{q}}-E_{\mathbf{p}})t}e^{i(\mathbf{q}-\mathbf{p})\cdot\mathbf{x}} + -a_{\mathbf{q}}b_{\mathbf{p}}e^{-i(E_{\mathbf{q}}+E_{\mathbf{p}})t}e^{i(\mathbf{p}+\mathbf{q})\cdot\mathbf{x}} + b_{\mathbf{q}}^{\dagger}a_{\mathbf{p}}^{\dagger}e^{i(E_{\mathbf{q}}+E_{\mathbf{p}})t}e^{-i(\mathbf{p}+\mathbf{q})\cdot\mathbf{x}} + -b_{\mathbf{q}}^{\dagger}b_{\mathbf{p}}e^{i(E_{\mathbf{q}}-E_{\mathbf{p}})t}e^{i(\mathbf{p}-\mathbf{q})\cdot\mathbf{x}} \right]$$

$$(1.1.10a)$$

1.1. Complex Klein-Gordon field

$$Q_{1} = i \frac{1}{(2\pi)^{3}} \frac{1}{2\sqrt{E_{\mathbf{q}}E_{\mathbf{p}}}} (iE_{\mathbf{p}}) \int d^{3}p d^{3}q \left[a_{\mathbf{q}} a_{\mathbf{p}}^{\dagger} e^{i(E_{\mathbf{p}}-E_{\mathbf{q}})t} (2\pi)^{3} \delta(\mathbf{q}-\mathbf{p}) + -a_{\mathbf{q}} b_{\mathbf{p}} e^{-i(E_{\mathbf{q}}+E_{\mathbf{p}})t} (2\pi)^{3} \delta(\mathbf{p}+\mathbf{q}) + +b_{\mathbf{q}}^{\dagger} a_{\mathbf{p}}^{\dagger} e^{i(E_{\mathbf{q}}+E_{\mathbf{p}})t} (2\pi)^{3} \delta(\mathbf{p}+\mathbf{q}) + -b_{\mathbf{q}}^{\dagger} a_{\mathbf{p}}^{\dagger} e^{i(E_{\mathbf{q}}-E_{\mathbf{p}})t} (2\pi)^{3} \delta(\mathbf{p}-\mathbf{q}) \right]$$

$$Q_{1} = i \frac{1}{(2\pi)^{3}} \frac{1}{2\sqrt{E_{\mathbf{q}}E_{\mathbf{p}}}} (iE_{\mathbf{p}}) (2\pi)^{3} \int d^{3}p \left[a_{\mathbf{p}} a_{\mathbf{p}}^{\dagger} - a_{-\mathbf{p}} b_{\mathbf{p}} e^{-2iE_{\mathbf{p}}t} + b_{-\mathbf{p}}^{\dagger} a_{\mathbf{p}}^{\dagger} e^{2iE_{\mathbf{p}}t} - b_{\mathbf{p}}^{\dagger} b_{\mathbf{p}} \right]$$

$$(1.1.10c)$$

By naming $\varphi = 2E_{\mathbf{p}}t$, we have

$$Q_{1} = -\frac{1}{2} \frac{1}{(2\pi)^{3}} \int d^{3}p \left[a_{\mathbf{p}} a_{\mathbf{p}}^{\dagger} - a_{-\mathbf{p}} b_{\mathbf{p}} e^{-i\varphi} + b_{-\mathbf{p}}^{\dagger} a_{\mathbf{p}}^{\dagger} e^{i\varphi} - b_{\mathbf{p}}^{\dagger} b_{\mathbf{p}} \right]$$
(1.1.11)

An analogous calculation holds for $Q_2 = -i \int d^3x \phi^* \partial_0 \phi$

$$\phi^* \partial_0 \phi = (\phi \partial_0 \phi^*)^* = \dots \tag{1.1.12}$$

$$Q_{2} = -\frac{1}{2} \frac{1}{(2\pi)^{3}} \int d^{3}p \left[a_{\mathbf{p}}^{\dagger} a_{\mathbf{p}} - a_{-\mathbf{p}}^{\dagger} b_{\mathbf{p}}^{\dagger} e^{i\varphi} + b_{-\mathbf{p}} a_{\mathbf{p}} e^{-i\varphi} - b_{\mathbf{p}} b_{\mathbf{p}}^{\dagger} \right]$$
(1.1.13)

Finally

$$Q = -\frac{1}{2} \frac{1}{(2\pi)^3} \int d^3p \left[a_{\mathbf{p}} a_{\mathbf{p}}^{\dagger} + a_{\mathbf{p}}^{\dagger} a_{\mathbf{p}} - b_{\mathbf{p}}^{\dagger} b_{\mathbf{p}} - b_{\mathbf{p}} b_{\mathbf{p}}^{\dagger} + e^{-i\varphi} \left(-a_{-\mathbf{p}} b_{\mathbf{p}} + b_{-\mathbf{p}} a_{\mathbf{p}} \right) + e^{i\varphi} \left(b_{-\mathbf{p}}^{\dagger} a_{\mathbf{p}}^{\dagger} - a_{-\mathbf{p}}^{\dagger} b_{\mathbf{p}}^{\dagger} \right) \right]$$

$$(1.1.14)$$

The first two terms in (1.1.14) can be written as

$$a_{\mathbf{p}}a_{\mathbf{p}}^{\dagger} + a_{\mathbf{p}}^{\dagger}a_{\mathbf{p}} = 2a_{\mathbf{p}}^{\dagger}a_{\mathbf{p}} + [a_{\mathbf{p}}, a_{\mathbf{p}}^{\dagger}] = 2N_{\mathbf{p}}^{a} + (2\pi)^{3}\delta(\mathbf{0})$$
(1.1.15)

where we ignored the infinite c-number given by the Dirac delta. For what concerns the term containing the phase we have instead

$$I = \int_{-\infty}^{+\infty} d^3 p \left(-a_{-\mathbf{p}} b_{\mathbf{p}} + b_{-\mathbf{p}} a_{\mathbf{p}} \right)$$
(1.1.16)

$$\begin{cases} p' = -p \\ d^3 p' = d^3 p \end{cases}$$
(1.1.17)

$$I = \int_{+\infty}^{-\infty} -d^{3}p' \left(-a_{\mathbf{p}'}b_{-\mathbf{p}'} + b_{\mathbf{p}'}a_{-\mathbf{p}'} \right) =$$

= $\int_{-\infty}^{+\infty} d^{3}p' \left(a_{-\mathbf{p}'}b_{\mathbf{p}'} - b_{-\mathbf{p}'}a_{\mathbf{p}'} \right) = -I \Rightarrow I = 0$ (1.1.18)

where we used the commutation rules between ladder operators of different particles.

The conserved charge associated with the phase symmetry therefore is

$$Q = \int \frac{d^3 p}{(2\pi)^3} \left[N^b_{\mathbf{p}} - N^a_{\mathbf{p}} \right]$$
(1.1.19)

where the number operators $N_{\mathbf{p}}^{a} \in N_{\mathbf{p}}^{b}$ tell us the number of particles of type a and b. It is worth noting that $Q_{1} = -Q_{2}$, so that the fields ϕ and ϕ^{*} describe particles with the same mass but opposite charge; we then identify particles of type b as the antiparticles of type a (and viceversa).

1.2 Yukawa Lagrangian

Text. Consider the following Lagrangian

$$\mathcal{L} = i\overline{\psi}\gamma^{\mu}\partial_{\mu}\psi - m\overline{\psi}\psi + \frac{1}{2}\partial_{\mu}\phi\partial^{\mu}\phi - m^{2}\phi^{2} + y\overline{\psi}\psi\phi$$

where ψ is a Dirac spinor field and ϕ is a real Klein-Gordon field.

- Determine the conserved charges of the theory.
- For each conserved charge determine its associated operator as a function of the ladder operators and verify their action on single particle states.

Solution. Besides the stress-energy tensor, the Lagrangian produces another Noether current, associated with phase symmetries of the Dirac spinor fields

$$\begin{split} \psi &\to \psi' = e^{i\varepsilon}\psi \sim (1+i\varepsilon)\psi \\ \overline{\psi} &\to \overline{\psi}' = e^{-i\varepsilon}\overline{\psi} \sim (1-i\varepsilon)\overline{\psi} \end{split} \tag{1.2.1}$$

$$\begin{aligned} \varepsilon \overline{\delta} \psi &= \psi' - \psi = i\varepsilon \\ \varepsilon \overline{\delta} \overline{\psi} &= \overline{\psi}' - \overline{\psi} = -i\varepsilon \end{aligned} \Rightarrow \\ \overline{\delta} \overline{\psi} &= i\overline{\psi} \end{aligned} \tag{1.2.2}$$

The Noether current associated with this symmetry is

$$j^{\mu} = \frac{\partial \mathcal{L}}{\partial (\partial_{\mu} \psi)} \overline{\delta} \psi + \frac{\partial \mathcal{L}}{\partial (\partial_{\mu} \overline{\psi})} \overline{\delta} \overline{\psi} = -\overline{\psi} \gamma^{\mu} \psi \qquad (1.2.3)$$

with Noether charge

$$Q = \int d^3x j^0 = -\int d^3x \overline{\psi} \gamma^0 \psi \qquad (1.2.4)$$

We write the charge Q as a function of the number operators

$$Q = -\frac{1}{(2\pi)^6} \frac{1}{2\sqrt{E_{\mathbf{p}}E_{\mathbf{q}}}} \int d^3x d^3p d^3q \left[e^{-i\mathbf{q}\cdot\mathbf{x}} \left(\sum_r \overline{u}^r(\mathbf{q})a_{\mathbf{q}}^{r^{\dagger}}\right) + e^{i\mathbf{q}\cdot\mathbf{x}} \left(\sum_r \overline{v}^r(\mathbf{q})b_{\mathbf{q}}^r\right) \right]$$
$$\gamma^0 \left[e^{i\mathbf{p}\cdot\mathbf{x}} \left(\sum_s u^s(\mathbf{p})a_{\mathbf{p}}^s\right) + e^{-i\mathbf{p}\cdot\mathbf{x}} \left(\sum_s v^s(\mathbf{p})b_{\mathbf{p}}^{s^{\dagger}}\right) \right]$$
(1.2.5)

Expanding the products we can make use of the Dirac delta in the form

$$\int d^3x e^{i(\mathbf{p}-\mathbf{q})\cdot\mathbf{x}} = (2\pi)^3 \delta(\mathbf{p}-\mathbf{q})$$
(1.2.6)

so the charge Q becomes

$$Q = -\frac{1}{(2\pi)^{6}} \frac{1}{2E_{\mathbf{p}}} \int d^{3}p \left(\sum_{r} u^{r^{\dagger}}(\mathbf{p}) a^{r^{\dagger}}_{\mathbf{p}} \right) \left(\sum_{s} u^{s}(\mathbf{p}) a^{s}_{\mathbf{p}} \right) + \\ + \left(\sum_{r} u^{r^{\dagger}}(-\mathbf{p}) a^{r^{\dagger}}_{-\mathbf{p}} \right) \left(\sum_{s} v^{s}(\mathbf{p}) b^{s^{\dagger}}_{\mathbf{p}} \right) + \\ + \left(\sum_{r} v^{r^{\dagger}}(-\mathbf{p}) b^{r}_{-\mathbf{p}} \right) \left(\sum_{s} u^{s}(\mathbf{p}) a^{s}_{\mathbf{p}} \right) + \\ + \left(\sum_{r} v^{r^{\dagger}}(\mathbf{p}) b^{r}_{\mathbf{p}} \right) \left(\sum_{s} v^{s}(\mathbf{p}) b^{s^{\dagger}}_{\mathbf{p}} \right)$$

$$(1.2.7)$$

where we made explicit the dependence on the 3-momenta (since the time components do not get affected by the action of the Dirac delta) and exploited the following identities $\overline{u} = u^{\dagger}\gamma^{0}$, $\overline{v} = v^{\dagger}\gamma^{0}$. Thanks to (A.36) the second and third term are both equal to zero, while the first and the fourth one become

$$\left(\sum_{r} u^{r^{\dagger}}(\mathbf{p}) a^{r^{\dagger}}_{\mathbf{p}}\right) \left(\sum_{s} u^{s}(\mathbf{p}) a^{s}_{\mathbf{p}}\right) = 2E_{\mathbf{p}} a^{1^{\dagger}}_{\mathbf{p}} a^{1}_{\mathbf{p}} + 2E_{\mathbf{p}} a^{2^{\dagger}}_{\mathbf{p}} a^{2}_{\mathbf{p}}$$

$$\left(\sum_{r} v^{r^{\dagger}}(\mathbf{p}) b^{r}_{\mathbf{p}}\right) \left(\sum_{s} v^{s}(\mathbf{p}) b^{s^{\dagger}}_{\mathbf{p}}\right) = 2E_{\mathbf{p}} b^{1}_{\mathbf{p}} b^{1^{\dagger}}_{\mathbf{p}} + 2E_{\mathbf{p}} b^{2}_{\mathbf{p}} b^{2^{\dagger}}_{\mathbf{p}}$$
(1.2.8)

so that

$$Q = -\frac{1}{(2\pi)^3} \int d^3 p \left(a_{\mathbf{p}}^{1^{\dagger}} a_{\mathbf{p}}^1 + a_{\mathbf{p}}^{2^{\dagger}} a_{\mathbf{p}}^2 \right) + \left(b_{\mathbf{p}}^1 b_{\mathbf{p}}^{1^{\dagger}} + b_{\mathbf{p}}^2 b_{\mathbf{p}}^{2^{\dagger}} \right) = \\ = -\frac{1}{(2\pi)^3} \int d^3 p \left(a_{\mathbf{p}}^{1^{\dagger}} a_{\mathbf{p}}^1 + a_{\mathbf{p}}^{2^{\dagger}} a_{\mathbf{p}}^2 \right) - \left(b_{\mathbf{p}}^{1^{\dagger}} b_{\mathbf{p}}^1 + b_{\mathbf{p}}^{2^{\dagger}} b_{\mathbf{p}}^2 \right) + \{ b_{\mathbf{p}}^1, b_{\mathbf{p}}^{1^{\dagger}} \} + \{ b_{\mathbf{p}}^2, b_{\mathbf{p}}^{2^{\dagger}} \}$$
(1.2.9)

As usual we ignore the term proportional to $\delta(\mathbf{0})$ (see exercise 1.1) and the Noether charge becomes

$$Q = \int \frac{d^3 p}{(2\pi)^3} \left[N^b_{\mathbf{p}} - N^a_{\mathbf{p}} \right]$$
(1.2.10)

where the number operators contain both spin contributions. As expected, we have that the conserved charge is defined through the difference between the numbers of particles and antiparticles.

Chapter 2

Cross Sections and Decay Rates

2.1 Higgs boson decay

Text. The Higgs boson is a scalar particle whose interaction with the electromagnetic field is described by the following Lagrangian

$$\mathcal{L} = \frac{1}{2} \partial_{\mu} \phi \partial^{\mu} \phi - m^2 \phi - \frac{1}{4} F_{\alpha\beta} F^{\alpha\beta} + \lambda \phi F_{\alpha\beta} F^{\alpha\beta}$$

where $F_{\alpha\beta}$ is the electromagnetic stress tensor, defined as

$$F_{\alpha\beta} = \partial_{\alpha}A_{\beta} - \partial_{\beta}A_{\alpha}$$

Compute the decay rate of the Higgs boson ϕ .

Solution. We start by deriving the Feynman rules of the theory. The complete Lagrangian is the sum of the Klein-Gordon Lagragian, the electromagnetic Lagrangian and the interaction one, which is given by

$$\mathcal{L}_{INT} = \lambda \phi F_{\alpha\beta} F^{\alpha\beta} \tag{2.1.1}$$

Explicitly

$$\mathcal{L}_{INT} = \lambda \phi (\partial_{\alpha} A_{\beta} - \partial_{\beta} A_{\alpha}) (\partial^{\alpha} A^{\beta} - \partial^{\beta} A^{\alpha}) =$$

$$= \lambda \phi (\partial_{\alpha} A_{\beta} \partial^{\alpha} A^{\beta} - \partial_{\alpha} A_{\beta} \partial^{\beta} A^{\alpha} - \partial_{\beta} A_{\alpha} \partial^{\alpha} A^{\beta} + \partial_{\beta} A_{\alpha} \partial^{\beta} A^{\alpha}) =$$

$$= \lambda \phi (2 \partial_{\alpha} A_{\beta} \partial^{\alpha} A^{\beta} - 2 \partial_{\alpha} A_{\beta} \partial^{\beta} A^{\alpha}) =$$

The factor *i* comes from the first order expansion, while the further factor of 2 is added in order to consider the indistinguishability of the photons. Our goal is to compute the decay rate of the ϕ boson: $\phi \to \gamma \gamma$; at first order the process is described by the following diagram



The scattering amplitude is given by

Compute the differential cross section for the process

Solution. First of all, we derive the Feynman rules in the momentum space, taking into account that the gauge-fixing term $\frac{1}{2\xi}(\partial_{\alpha}A^{\alpha})^2$ does not modify the interactions

$$\mathcal{L}_{INT} = ie[A_{\mu}\phi^{*}\partial^{\mu}\phi - A_{\mu}\phi\partial^{\mu}\phi^{*}] + e^{2}A_{\mu}A^{\mu}\phi\phi^{*} =$$

$$= ie[A_{\mu}\phi^{*}\partial^{\mu}\phi - A^{\mu}\phi\partial_{\mu}\phi^{*}] + e^{2}g_{\mu\nu}A_{\mu}A_{\nu}\phi\phi^{*} \rightarrow$$

$$\to -e[p_{1}^{\mu} + p_{2}^{\mu}]A_{\mu}\phi\phi^{*} + e^{2}g^{\mu\nu}A_{\mu}A_{\nu}\phi\phi^{*} \qquad (2.2.1)$$





where we have added, as usual, a factor i due to the first order expansion of the S-matrix and a factor 2 in the last diagram to account for the exchange of the two photons; these rules will be used together with the usual rules for QED and the ones for the Klein-Gordon field (the former interaction is usually known as *scalar QED*).

Solution. Since the gauge-fixing term does not affect the scattering amplitude, we can use the Feynman rules already derived in Exercise 2.1. At first order we have the following Feynman diagram (t-channel)



where $q = k_1 - p_1 = p_2 - k_2$, and a second one with the final state photons exchanged (*u*-channel)



where $q = k_2 - p_1 = p_2 - k_1$.

Setting $|p_1; p_2\rangle \rightarrow |k_1, \lambda_1; k_2, \lambda_2\rangle$, the scattering amplitude of the first diagram is

Chapter 3 Ward Indentities

3.1 Radiative corrections for $\phi \phi^* \to \phi \phi^* \gamma$

Text. Given the following Lagrangian

$$\mathcal{L} = (D_{\mu}\phi)^{*}(D^{\mu}\phi) - m^{2}|\phi|^{2} + \overline{\psi}(i\not\!\!D - m_{e})\psi - \frac{1}{4}F_{\alpha\beta}F^{\alpha\beta}$$

Show that the amplitude for the process

$$\phi \phi^* \to \phi \phi^* \gamma$$

vanishes after replacing $\varepsilon(k) \to k$.

Solution. Using the vertices derived the exercise 2.2 we can build the following diagrams



Notice that the amplitudes are proportional to e^3 , where e is the coupling constant of the interaction.

In order to verify the Ward identity we need to include all possible Feynman diagrams proportional to e^3 . By attaching a 3-lines vertex to external lines, which means taking into account the *radiative corrections*, we can build the following diagrams



The total scattering amplitude is the sum of these six amplitudes; the Ward identity predicts that once we make the substitution $\varepsilon^*_{\sigma}(q) \to q_{\sigma}$, the total amplitude vanishes.

3.1. Radiative corrections for $\phi \phi^* \rightarrow \phi \phi^* \gamma$

Explicitly the amplitudes are

where we have exploited the fact that external particles are on-shell, so that $p_1^2 = p_2^2 = p_3^2 = p_4^2 = m^2$ and $q^2 = 0$ for a real photon. In the end \mathcal{A}_3 becomes

Solution. The Feynman rules for this Lagrangian are given by the usual rules for QED and for scalar QED (see exercise 2.2).
