ABSTRACT. In this paper, we first obtain an estimate of the coefficients for α harmonic mappings. By applying these coefficient estimates, we prove the Landau type theorem for α -harmonic mappings defined on the unit disc \mathbb{D} .

1. INTRODUCTION

Let $\mathbb{D} = \{z \in \mathbb{C} : |z| < 1\}$ represents the unit disc in the complex plane \mathbb{C} . We denote the complex differential operators

$$
\frac{\partial}{\partial z} = \frac{1}{2} \left(\frac{\partial}{\partial x} - i \frac{\partial}{\partial y} \right) \text{ and } \frac{\partial}{\partial \bar{z}} = \frac{1}{2} \left(\frac{\partial}{\partial x} + i \frac{\partial}{\partial y} \right)
$$

for $z = x + iy \in \mathbb{C}$ where x and y are real. For a continuously differentiable function f, denote

$$
\Lambda_f = \max_{0 \le \theta \le 2\pi} |f_z + e^{-2i\theta} f_{\bar{z}}| = |f_z| + |f_{\bar{z}}|
$$

and

$$
\lambda_f = \min_{0 \le \theta \le 2\pi} |f_z + e^{-2i\theta} f_{\bar{z}}| = ||f_z| - |f_{\bar{z}}||,
$$

where $f_z = \partial f / \partial z$ and $f_{\bar{z}} = \partial f / \partial \bar{z}$. Throughout this paper, we denote by $C^n(\mathbb{D})$ the set of all *n*-times continuously differentiable complex-valued functions in D , where $n \in \{1, 2, \dots\}.$

For $\alpha \in \mathbb{R}$ and $z \in \mathbb{D}$, let

$$
T_{\alpha} = -\frac{\alpha^2}{4} \left(1 - |z|^2 \right)^{-\alpha - 1} + \frac{\alpha}{2} \left(1 - |z|^2 \right)^{-\alpha - 1} \left(z \frac{\partial}{\partial z} + \bar{z} \frac{\partial}{\partial \bar{z}} \right) + \frac{1}{4} \left(1 - |z|^2 \right)^{-\alpha} \Delta
$$

be the second order elliptic partial differential operator, where Δ is the usual complex Laplacian operator

$$
\Delta := 4 \frac{\partial^2}{\partial z \partial \bar{z}} = \frac{\partial^2}{\partial x^2} + \frac{\partial^2}{\partial y^2}
$$

The corresponding homogeneous differential equation is

$$
T_{\alpha}(f) = 0 \quad \text{in } \mathbb{D}.\tag{1.1}
$$

and its associated Dirichlet boundary value problem is as follows

$$
\begin{cases}\nT_{\alpha}(f) = 0 & \text{in } \mathbb{D}, \\
f = f^* & \text{on } \partial \mathbb{D}.\n\end{cases}
$$
\n(1.2)

Here, the boundary data $f^* \in \mathfrak{D}'(\partial \mathbb{D})$ is a distribution on the boundary $\partial \mathbb{D}$ of \mathbb{D} , and the boundary condition in [\(1.2\)](#page-1-0) is interpreted in the distributional sense that $f_r \to f^*$ in $\mathfrak{D}'(\partial \mathbb{D})$ as $r \to 1^-$, where

$$
f_r(e^{i\theta}) = f(re^{i\theta}), e^{i\theta} \in \partial \mathbb{D},
$$

for $r \in [0, 1)$. In 2014, Olofsson [\[26\]](#page-11-0) proved that, for parameter values $\alpha > -1$, if a function $f \in C^2(\mathbb{D})$ satisfies [\(1.1\)](#page-0-0) with $\lim_{r\to 1^-} f_r = f^* \in \mathfrak{D}'(\partial \mathbb{D})$, then it has the form of a Poisson type integral

$$
f(z) = \frac{1}{2\pi} \int_0^{2\pi} K_\alpha \left(z e^{-i\tau} \right) f^* \left(e^{i\tau} \right) d\tau \quad \text{for } z \in \mathbb{D},
$$

where

$$
K_{\alpha}(z) = c_{\alpha} \frac{(1 - |z|^2)^{\alpha + 1}}{|1 - z|^{\alpha + 2}},
$$

 $c_{\alpha} = (\Gamma(\alpha/2+1))^2/\Gamma(1+\alpha)$ and $\Gamma(s) = \int_0^{\infty} t^{s-1}e^{-t}dt$ for $s > 0$ is the standard Gamma function.

If we take $\alpha = 2(n-1)$, then f is polyharmonic (or n-harmonic), where $n \in$ $\{1, 2, 3, \ldots\}$. For a detailed study on polyharmonic mappings, we refer to [\[5,](#page-10-0) [11,](#page-10-1) [16,](#page-10-2) [17,](#page-10-3) [23,](#page-11-1) [24,](#page-11-2) [25,](#page-11-3) [26\]](#page-11-0). In particular, if $\alpha = 0$, then f is harmonic. Thus, f is a kind of generalization of classical harmonic mappings.

The Gauss hypergeometric function is defined by the following series

$$
F(a, b; c; x) = \sum_{n=0}^{\infty} \frac{(a)_n (b)_n}{(c)_n} \frac{x^n}{n!}
$$

for $|x| < 1$, where $(a)_0 = 1$ and $(a)_n = a(a + 1) \cdots (a + n - 1)$ for $n = 1, 2, \ldots$ are the Pochhammer symbols. Obviously, for $n = 0, 1, 2, ..., (a)_n = \Gamma(a+n)/\Gamma(a)$. It is easy to see that

$$
\frac{d}{dx}F(a, b; c; x) = \frac{ab}{c}F(a + 1, b + 1; c + 1; x).
$$

Furthermore, for $\text{Re}(c - a - b) > 0$, we have (see [\[4,](#page-10-4) Theorem 2.2.2])

$$
F(a, b; c; 1) = \lim_{x \to 1} F(a, b; c; x) = \frac{\Gamma(c)\Gamma(c - a - b)}{\Gamma(c - a)\Gamma(c - b)}.
$$
 (1.3)

The following result concerns the solution to the equation [\(1.1\)](#page-0-0).

Theorem A. [\[26\]](#page-11-0) Let $\alpha \in \mathbb{R}$ and $f \in C^2(\mathbb{D})$. Then f satisfies [\(1.1\)](#page-0-0) if, and only if, it has a series expansion of the form

$$
f(z) = \sum_{k=0}^{\infty} c_k F\left(-\frac{\alpha}{2}, k - \frac{\alpha}{2}; k + 1; |z|^2\right) z^k + \sum_{k=1}^{\infty} c_{-k} F\left(-\frac{\alpha}{2}, k - \frac{\alpha}{2}; k + 1; |z|^2\right) \bar{z}^k,
$$
\n(1.4)

for some sequence $\left\{ c_{k}\right\} _{-\infty}^{\infty}$ of complex number satisfying

$$
\lim_{|k| \to \infty} \sup |c_k|^{\frac{1}{|k|}} \le 1. \tag{1.5}
$$

In particular, the expansion [\(1.4\)](#page-1-1), subject to the condition [\(1.5\)](#page-2-0), converges in $C^{\infty}(\mathbb{D})$, and every solution f of (1.1) is $C^{\infty}(\mathbb{D})$ in the unit disc \mathbb{D} .

In 2014, Olofsson [\[26\]](#page-11-0) pointed out that if $\alpha \leq -1, f \in C^2(\mathbb{D})$ satisfies (1.1), and the boundary limit $f^* = \lim_{r \to 1^-} f_r$ exists in $\mathfrak{D}'(\partial \mathbb{D})$, then $f(z) = 0$ for all $z \in \mathbb{D}$. Therefore, in this paper, we always assume that $\alpha > -1$.

The classical Landau theorem (see [\[15\]](#page-10-5)) asserts that if f is a holomorphic mapping with $f(0) = 0$, $f'(0) = 1$ and $|f(z)| < M$ for $z \in \mathbb{D}$, then f is univalent in \mathbb{D}_{r_0} , and $f(\mathbb{D}_{r_0})$ contains a disc \mathbb{D}_{σ_0} , where

$$
r_0 = \frac{1}{M + \sqrt{M^2 - 1}}
$$
 and $\sigma_0 = Mr_0^2$.

The quantities r_0 and σ_0 can't be improved as the function $f_0(z) = Mz \left(\frac{1-Mz}{M-z} \right)$ $\frac{1-Mz}{M-z}$ shows the sharpness of the quantities r_0 and σ_0 .

In 2000, Chen et al. [\[6\]](#page-10-6) obtained the Landau type theorems for harmonic mappings in the unit disc D.

Theorem B. [\[6\]](#page-10-6) Let f be a harmonic mapping of the unit disc \mathbb{D} such that $f(0) = 0$, $f_{\bar{z}}(0) = 0, f_z(0) = 1$, and $|f(z)| < M$ for $z \in \mathbb{D}$. Then, f is univalent on a disc \mathbb{D}_{ρ_0} with

$$
\rho_0 = \frac{\pi^2}{16mM},
$$

and $f(\mathbb{D}_{\rho_0})$ contains a schlicht disc \mathbb{D}_{R_0} with

$$
R_0 = \rho_0/2 = \frac{\pi^2}{32mM},
$$

where $m \approx 6.85$ is the minimum of the function $(3 - r^2)/(r(1 - r^2))$ for $0 < r < 1$.

Theorem C. [\[6\]](#page-10-6) Let f be a harmonic mapping of the unit disc \mathbb{D} such that $f(0) = 0$, $\lambda_f(0) = 1$ and $\Lambda_f(z) \leq \Lambda$ for $z \in \mathbb{D}$. Then, f is univalent on a disc \mathbb{D}_{ρ_0} with

$$
\rho_0 = \frac{\pi}{4(1+\Lambda)},
$$

and $f(\mathbb{D}_{\rho_0})$ contains a schlicht disc \mathbb{D}_{R_0} with

$$
R_0 = \frac{1}{2}\rho_0 = \frac{\pi}{8(1+\Lambda)}.
$$

The radii ρ_o and R_0 in Theorem [B](#page-2-1) and Theorem [C](#page-2-2) are not sharp. These results have been improved by Chen *et al.* [\[9\]](#page-10-7), Dorff and Nowak [\[12\]](#page-10-8), Grigoryan [\[13\]](#page-10-9), Huang [\[14\]](#page-10-10), Liu [\[19,](#page-11-4) [20\]](#page-11-5), Liu and Chen [\[21\]](#page-11-6) and Zhu [\[28\]](#page-11-7). In particular, Liu [\[20\]](#page-11-5) has proved that under the hypothesis of Theorem [C,](#page-2-2) $\Lambda \geq 1$, and when $\Lambda = 1$, f is univalent in the disc \mathbb{D}_{ρ} and $f(\mathbb{D}_{\rho})$ contains a schlicht disc \mathbb{D}_{R} with $\rho = R = 1$ being sharp. In 2018, Liu and Chen [\[21\]](#page-11-6) established the sharp version of Theorem [C](#page-2-2) for $\Lambda > 1$ by applying geometric method. The Landau type theorem has also been studied for elliptic harmonic mappings [\[3\]](#page-10-11), logharmonic mappings [\[2\]](#page-10-12) and log-p-harmonic mappings [\[22\]](#page-11-8).

In 2008, Abdulhadi and Muhanna [\[1\]](#page-10-13) established two versions of Landau-type theorems for certain bounded biharmonic mappings. After that, the Landau type theorem for functions f satisfying [\(1.1\)](#page-0-0) with $\alpha = 2(n-1)$, where $n \in \{1, 2, 3, \ldots\}$, has been extensively studied by many authors (see [\[1,](#page-10-13) [7,](#page-10-14) [10,](#page-10-15) [18,](#page-11-9) [27\]](#page-11-10)).

2. Coefficient Estimates

There have been many discussions in the literature regarding the coefficient es-timates of the functions f satisfying [\(1.1\)](#page-0-0) with $\alpha = 0$ and $\alpha = 2$. In 2015, Chen and Vuorinen [\[11\]](#page-10-1) proved the coefficient estimates for bounded functions satisfying [\(1.1\)](#page-0-0) with $\alpha > -1$. In this section, we prove a different coefficient estimates for α -harmonic mappings when $\alpha > 0$.

Theorem 2.1. For $\alpha > 0$, let $f \in C^2(\mathbb{D})$ be the solution of [\(1.1\)](#page-0-0) with series expansion of the form [\(1.4\)](#page-1-1) and $\Lambda_f(z) \leq \Lambda$ for each $z \in \mathbb{D}$, where Λ is a positive number. Then, for $k \in \{1, 2, 3, ...\}$,

$$
\frac{\alpha|2k-\alpha|}{2(k+1)} \bigg(\Big| c_k F\left(-\frac{\alpha}{2}+1, k-\frac{\alpha}{2}+1; k+2; 1\right) \Big| + \Big| c_{-k} F\left(-\frac{\alpha}{2}+1, k-\frac{\alpha}{2}+1; k+2; 1\right) \Big| \bigg) \leq \Lambda.
$$

Proof. We know that

$$
F\left(-\frac{\alpha}{2}, k - \frac{\alpha}{2}; k + 1; |z|^2\right) = \sum_{n=0}^{\infty} \frac{(-\frac{\alpha}{2})_n (k - \frac{\alpha}{2})_n}{(k + 1)_n} \frac{|z|^{2n}}{n!}.
$$
 (2.1)

Differentiating (2.1) partially with respect to z, we obtain

$$
\frac{\partial}{\partial z} F\left(-\frac{\alpha}{2}, k - \frac{\alpha}{2}; k + 1; |z|^2\right) = \bar{z} \sum_{n=1}^{\infty} \frac{(-\frac{\alpha}{2})_n (k - \frac{\alpha}{2})_n}{(k + 1)_n} \frac{|z|^{2(n-1)}}{(n-1)!}
$$

$$
= \bar{z} \frac{-\frac{\alpha}{2} (k - \frac{\alpha}{2})}{k + 1} F\left(-\frac{\alpha}{2} + 1, k - \frac{\alpha}{2} + 1; k + 2; |z|^2\right).
$$

Similarly, we have

$$
\frac{\partial}{\partial \bar{z}} F\left(-\frac{\alpha}{2}, k - \frac{\alpha}{2}; k + 1; |z|^2\right) = z \frac{-\frac{\alpha}{2}(k - \frac{\alpha}{2})}{k + 1} F\left(-\frac{\alpha}{2} + 1, k - \frac{\alpha}{2} + 1; k + 2; |z|^2\right).
$$

For $r \in [0,1)$, let

$$
G_k(r,\alpha) = \frac{-\frac{\alpha}{2}(k-\frac{\alpha}{2})}{k+1}F\left(-\frac{\alpha}{2}+1, k-\frac{\alpha}{2}+1; k+2; r^2\right).
$$

A simple computation shows that

$$
f_z(re^{i\theta}) = \sum_{k=1}^{\infty} c_k r^{k+1} G_k(r, \alpha) e^{i(k-1)\theta} + \sum_{k=1}^{\infty} k c_k F\left(-\frac{\alpha}{2}, k - \frac{\alpha}{2}; k + 1; r^2\right) r^{k-1} e^{i(k-1)\theta}
$$

$$
+\sum_{k=1}^{\infty} c_{-k} r^{k+1} G_k(r,\alpha) e^{-i(k+1)\theta}
$$
\n(2.2)

and

$$
f_{\bar{z}}(re^{i\theta}) = \sum_{k=1}^{\infty} c_k r^{k+1} G_k(r, \alpha) e^{i(k+1)\theta} + \sum_{k=1}^{\infty} k c_{-k} F\left(-\frac{\alpha}{2}, k - \frac{\alpha}{2}; k+1; r^2\right) r^{k-1} e^{-i(k-1)\theta} + \sum_{k=1}^{\infty} c_{-k} r^{k+1} G_k(r, \alpha) e^{-i(k-1)\theta},
$$
\n(2.3)

where $z = re^{i\theta}$. By multiplying [\(2.2\)](#page-4-0) by $e^{i(k+1)\theta}$ and then integrating from 0 to 2π , we obtain

$$
c_{-k}r^{k+1}G_k(r,\alpha) = \frac{1}{2\pi} \int_0^{2\pi} f_z(re^{i\theta})e^{i(k+1)\theta}d\theta.
$$
 (2.4)

Similarly, multiplying [\(2.3\)](#page-4-1) by $e^{-i(k+1)\theta}$ and then integrating from 0 to 2π , we obtain

$$
c_k r^{k+1} G_k(r, \alpha) = \frac{1}{2\pi} \int_0^{2\pi} f_{\bar{z}}(re^{i\theta}) e^{-i(k+1)\theta} d\theta.
$$
 (2.5)

Since $\Lambda_f(z) \leq \Lambda$, we may conclude from equations [\(2.4\)](#page-4-2) and [\(2.5\)](#page-4-3) that

$$
\left(|c_k G_k(r, \alpha)| + |c_{-k} G_k(r, \alpha)| \right) r^{k+1} \le \frac{1}{2\pi} \int_0^{2\pi} \left(|f_z(re^{i\theta})| + |f_{\bar{z}}(re^{i\theta})| \right) d\theta
$$

$$
= \frac{1}{2\pi} \int_0^{2\pi} \Lambda_f(re^{i\theta}) d\theta \le \Lambda. \tag{2.6}
$$

By letting $r \to 1^-$ and using [\(1.3\)](#page-1-2), we obtain

$$
|c_k G_k(1,\alpha)| + |c_{-k} G_k(1,\alpha)| \leq \Lambda.
$$

This completes the proof.

We obtain the following corollary from Theorem [2.1.](#page-3-1)

Corollary 2.1. Let $\alpha > 0$ and not an even integer. Let $f \in C^2(\mathbb{D})$ be the solution of [\(1.1\)](#page-0-0) with series expansion of the form (1.4) and $\Lambda_f(z) \leq \Lambda$ for each $z \in \mathbb{D}$. Then, for $k \in \{1, 2, 3, ...\}$,

$$
|c_k| + |c_{-k}| \le \frac{2\Lambda \Gamma(1 + \frac{\alpha}{2})\Gamma(k + 1 + \frac{\alpha}{2})}{k!\Gamma(\alpha + 1)|2k - \alpha|}.
$$
 (2.7)

Proof. Since $\alpha > 0$ and α is not a positive even integer, by using Theorem [2.1](#page-3-1) and [\(1.3\)](#page-1-2), we obtain the following inequality

$$
\frac{\Gamma(k+2)\Gamma(\alpha)}{\Gamma(k+1+\frac{\alpha}{2})\Gamma(1+\frac{\alpha}{2})}\left(|c_k|+|c_{-k}|\right) \le \frac{2\Lambda(k+1)}{\alpha|2k-\alpha|}.
$$

This implies that

$$
|c_k| + |c_{-k}| \le \frac{2\Lambda \Gamma(1 + \frac{\alpha}{2})\Gamma(k + 1 + \frac{\alpha}{2})}{k!\Gamma(\alpha + 1)|2k - \alpha|},
$$

which completes the proof. \Box

3. The Landau Type Theorem

In 2015, Chen and Vuorinen^{[\[11\]](#page-10-1)} obtained the Landau type theorem for α -harmoinc mappings when $\alpha \in (-1, 0]$ and in 2021, Long and Wang [\[23\]](#page-11-1) obtained it when $\alpha \in (0, 2)$. In this section, we derive another Landau type theorem for α -harmonic mappings when $\alpha \in (0, 2)$.

We first prove the following lemma, which is vital to the proof of the main result. **Lemma 3.1.** For $x \in [0, 1)$, let

$$
\varphi(x) = \beta - \frac{2\Lambda}{2 - \alpha} \left((2 - \alpha) \frac{x^2}{1 - x} + \frac{2a}{(1 - x)^3} - 2a + (2a - 1) \frac{x^2}{1 - x^2} \right),
$$

where $\alpha \in (0, 2)$, $\beta > 0$ and $\Lambda > 0$ are constants and $a = \frac{\Gamma(1+\frac{\alpha}{2})}{\Gamma(1+\alpha)}$ $\frac{\Gamma(1+\frac{1}{2})}{\Gamma(1+\alpha)}$. Then φ is strictly decreasing and there is a unique $x_0 \in (0,1)$ such that $\varphi(x_0) = 0$.

Proof. It is easy to see that $1/2 < a < 1$ for $\alpha \in (0, 2)$ (see [\[23,](#page-11-1) Lemma 3.1]). Let

$$
f_1(x) = (2 - \alpha) \frac{x^2}{1 - x},
$$

$$
f_2(x) = \frac{2a}{(1 - x)^3} - 2a,
$$

and

$$
f_3(x) = (2a - 1)\frac{x^2}{1 - x^2}.
$$

Clearly,

$$
\varphi(x) = \beta - \frac{2\Lambda}{2 - \alpha} \Big(f_1(x) + f_2(x) + f_3(x) \Big).
$$

A simple computation shows that $f'_1(x) > 0, f'_2(x) > 0$ and $f'_3(x) > 0$ for $x \in (0, 1)$. This implies that $\varphi(x)$ is strictly decreasing in [0, 1).

Furthermore, we can observe that

$$
\lim_{x \to 0} \varphi(x) = \beta > 0 \quad \text{and} \quad \lim_{x \to 1^{-}} \varphi(x) = -\infty.
$$

Therefore, there exists a unique $x_0 \in (0, 1)$ such that $\varphi(x_0) = 0$. This completes the proof of this lemma. proof of this lemma.

Theorem 3.1. For $\alpha \in (0,2)$, let $a = \Gamma(\alpha/2 + 1)/\Gamma(1 + \alpha)$, $f \in C^2(\mathbb{D})$ be the solution of [\(1.1\)](#page-0-0) satisfying $f(0) = 0, \lambda_f(0) \geq \beta$ and $\Lambda_f(z) \leq \Lambda$ for each $z \in \mathbb{D}$, where Λ , β are positive constants. Then f is univalent on a disc \mathbb{D}_{ρ_0} , where ρ_0 satisfies the following equation

$$
\beta - \frac{2\Lambda}{2 - \alpha} \left((2 - \alpha) \frac{\rho_0^2}{1 - \rho_0} + \frac{2a}{(1 - \rho_0)^3} - 2a + (2a - 1) \frac{\rho_0^2}{1 - \rho_0^2} \right) = 0.
$$

Morever, $f(\mathbb{D}_{\rho_0})$ contains a schlicht disc of radius

$$
R_0 \ge \rho_0 \left(\beta - \frac{2\Lambda}{2-\alpha} \left(\frac{2-\alpha}{1-\rho_0} \frac{{\rho_0}^2}{3} + \frac{2a}{(1-\rho_0)^3} - 2a + \frac{2a-1}{1-\rho_0^2} \frac{{\rho_0}^2}{3} \right) \right).
$$

Proof. By Theorem [A,](#page-1-3) we may assume that

$$
f(z) = \sum_{k=0}^{\infty} c_k F\left(-\frac{\alpha}{2}, k - \frac{\alpha}{2}; k + 1; |z|^2\right) z^k
$$

+
$$
\sum_{k=1}^{\infty} c_{-k} F\left(-\frac{\alpha}{2}, k - \frac{\alpha}{2}; k + 1; |z|^2\right) \bar{z}^k, \ z \in \mathbb{D},
$$

for some sequence ${c_k}_{k=-\infty}^{\infty}$ of complex numbers satisfying

$$
\lim_{|k|\to\infty} \sup |c_k|^{\frac{1}{k!}} \le 1.
$$

For $\alpha \in (0, 2)$ and $k \in \{1, 2, 3, ...\}$, we observe that

$$
\frac{d}{dt}F\left(-\frac{\alpha}{2},k-\frac{\alpha}{2};k+1;t\right) = \frac{\left(-\frac{\alpha}{2}\right)(k-\frac{\alpha}{2})}{k+1}F\left(1-\frac{\alpha}{2},k+1-\frac{\alpha}{2};k+2;t\right) < 0.
$$

This shows that $F\left(-\frac{\alpha}{2}\right)$ $\frac{\alpha}{2}, k - \frac{\alpha}{2}$ $(\frac{\alpha}{2}; k+1; t)$ is decreasing on $t \in [0, 1)$. Therefore, we have

$$
F\left(-\frac{\alpha}{2}, k - \frac{\alpha}{2}; k + 1; t\right) \le F\left(-\frac{\alpha}{2}, k - \frac{\alpha}{2}; k + 1; 0\right) = 1.
$$
\n(3.1)

Further, for $\alpha \in (0, 2)$ and $k \in \{1, 2, 3, ...\}$, we have

$$
\frac{d}{dt}F\left(-\frac{\alpha}{2} + 1, k - \frac{\alpha}{2} + 1; k + 2; t\right) \n= \frac{(-\frac{\alpha}{2} + 1)(k - \frac{\alpha}{2} + 1)}{k + 2}F\left(-\frac{\alpha}{2} + 2, k - \frac{\alpha}{2} + 2; k + 3; t\right) > 0
$$

which implies that $F\left(-\frac{\alpha}{2}+1, k-\frac{\alpha}{2}+1; k+2; t\right)$ is increasing function on [0, 1).

Note that the function $F\left(-\frac{\alpha}{2}+1, k-\frac{\alpha}{2}+1; k+2; t\right)$ is nonnegative as its parameters are nonnegative. Therefore, we have

$$
\left| F(-\frac{\alpha}{2} + 1, k - \frac{\alpha}{2} + 1; k + 2; t) \right| \le \left| F(-\frac{\alpha}{2} + 1, k - \frac{\alpha}{2} + 1; k + 2; 1) \right|.
$$

From Theorem [2.1,](#page-3-1) we have

$$
\frac{\alpha(2k-\alpha)}{2(k+1)}(|c_k|+|c_{-k}|)|F(-\frac{\alpha}{2}+1,k-\frac{\alpha}{2}+1;k+2;t)|
$$
\n
$$
\leq \frac{\alpha(2k-\alpha)}{2(k+1)}(|c_k|+|c_{-k}|)|F(-\frac{\alpha}{2}+1,k-\frac{\alpha}{2}+1;k+2;1)| \leq \Lambda. \quad (3.2)
$$

For $k \in \{1, 2, 3, ...\}$ and $\alpha \in (0, 2)$, Long and Wang [\[23\]](#page-11-1) have proved the following inequality.

$$
\left| \frac{(-\frac{\alpha}{2})_n (k - \frac{\alpha}{2})_n}{(k+1)_n} \frac{1}{n!} \right| \le 1 - \frac{\Gamma(k+1)\Gamma(1+\alpha)}{\Gamma(k+1+\frac{\alpha}{2})\Gamma(1+\frac{\alpha}{2})}.
$$
(3.3)

Using [\(3.3\)](#page-6-0) and Corollary [2.1,](#page-4-4) we obtain

$$
(|c_{1}| + |c_{-1}|) \left| \frac{(-\frac{\alpha}{2})_{n}(k - \frac{\alpha}{2})_{n}}{(k + 1)_{n}} \frac{1}{n!} \right| \leq \frac{2\Lambda}{2 - \alpha} \left(\frac{\Gamma(1 + \frac{\alpha}{2})\Gamma(2 + \frac{\alpha}{2})}{\Gamma(2)\Gamma(\alpha + 1)} - 1 \right) < \frac{2\Lambda}{2 - \alpha} (2a - 1),
$$
 (3.4)

where $a = \Gamma(\alpha/2 + 1)/\Gamma(1 + \alpha)$ and $\alpha \in (0, 2)$. Since $f(0) = c_0 = 0$, a simple computation shows that

$$
f_z(z) - f_z(0) = \sum_{k=1}^{\infty} c_k \frac{-\frac{\alpha}{2} (k - \frac{\alpha}{2})}{k+1} F\left(-\frac{\alpha}{2} + 1; k - \frac{\alpha}{2} + 1; k + 2; |z|^2\right) \bar{z} z^k
$$

+
$$
\sum_{k=1}^{\infty} c_{-k} \frac{-\frac{\alpha}{2} (k - \frac{\alpha}{2})}{k+1} F\left(-\frac{\alpha}{2} + 1; k - \frac{\alpha}{2} + 1; k + 2; |z|^2\right) \bar{z}^{k+1}
$$

+
$$
\sum_{k=2}^{\infty} k c_k F\left(-\frac{\alpha}{2}; k - \frac{\alpha}{2}; k + 1; |z|^2\right) z^{k-1}
$$

+
$$
c_1 \left(F\left(-\frac{\alpha}{2}; 1 - \frac{\alpha}{2}; 2; |z|^2\right) - 1\right)
$$

and

$$
f_{\bar{z}}(z) - f_{\bar{z}}(0) = \sum_{k=1}^{\infty} c_k \frac{-\frac{\alpha}{2} (k - \frac{\alpha}{2})}{k+1} F\left(-\frac{\alpha}{2} + 1; k - \frac{\alpha}{2} + 1; k + 2; |z|^2\right) z^{k+1} + \sum_{k=1}^{\infty} c_{-k} \frac{-\frac{\alpha}{2} (k - \frac{\alpha}{2})}{k+1} F\left(-\frac{\alpha}{2} + 1; k - \frac{\alpha}{2} + 1; k + 2; |z|^2\right) z \bar{z}^k + \sum_{k=2}^{\infty} k c_{-k} F\left(-\frac{\alpha}{2}; k - \frac{\alpha}{2}; k + 1; |z|^2\right) \bar{z}^{k-1} + c_{-1} \left(F\left(-\frac{\alpha}{2}; 1 - \frac{\alpha}{2}; 2; |z|^2\right) - 1\right).
$$
 (3.6)

For $|z| = r$, in view of [\(3.5\)](#page-7-0) and [\(3.6\)](#page-7-1), we obtain

|f_z(z) - f_z(0)| + |f_{\bar{z}}(z) - f_{\bar{z}}(0)|
$$

\leq 2 \sum_{k=1}^{\infty} (|c_k| + |c_{-k}|) \frac{\alpha(2k - \alpha)}{2(k+1)} \left| F\left(-\frac{\alpha}{2} + 1, k - \frac{\alpha}{2} + 1; k + 2; r^2\right) \right| r^{k+1}
$$

\n
$$
+ \sum_{k=2}^{\infty} k(|c_k| + |c_{-k}|) \left| F\left(-\frac{\alpha}{2}; k - \frac{\alpha}{2}; k + 1; r^2\right) \right| r^{k-1}
$$

\n
$$
+ (|c_1| + |c_{-1}|) \left| F\left(-\frac{\alpha}{2}; 1 - \frac{\alpha}{2}; 2; r^2\right) - 1 \right|.
$$

Applying (3.1) , (3.2) , (3.4) and Corollary [2.1,](#page-4-4) we obtain $|f_z(z) - f_z(0)| + |f_{\bar{z}}(z) - f_{\bar{z}}(0)|$

\leq 2\Lambda \sum_{k=1}^{\infty} r^{k+1} + \sum_{k=2}^{\infty} k(|c_k| + |c_{-k}|)r^{k-1} + (|c_1| + |c_{-1}|) \sum_{n=1}^{\infty} \left| \frac{(-\frac{\alpha}{2})_n(k - \frac{\alpha}{2})_n}{(k+1)_n} \frac{r^{2n}}{n!} \right|
$$

$$
\leq 2\Lambda \sum_{k=1}^{\infty} r^{k+1} + \sum_{k=2}^{\infty} \frac{2\Lambda a \Gamma(k+1+\frac{\alpha}{2})}{\Gamma(k+1)(2k-\alpha)} r^{k-1} + \frac{2\Lambda}{2-\alpha} (2a-1) \sum_{n=1}^{\infty} r^{2n}
$$

< 2\Lambda \sum_{k=1}^{\infty} r^{k+1} + \frac{2\Lambda}{2-\alpha} a \sum_{k=2}^{\infty} k(k+1)r^{k-1} + \frac{2\Lambda}{2-\alpha} (2a-1) \sum_{n=1}^{\infty} r^{2n}
$$

= $\frac{2\Lambda}{2-\alpha} \left((2-\alpha) \frac{r^2}{1-r} + \frac{2a}{(1-r)^3} - 2a + (2a-1) \frac{r^2}{1-r^2} \right).$ (3.7)

To prove the univalence of f in \mathbb{D}_{ρ_0} , we choose two distinct points $z_1, z_2 \in \mathbb{D}_{\rho_0}$ and let $[z_1, z_2]$ denote the line segment from z_1 to z_2 with ends points z_1 and z_2 , where ρ_0 satisfies the following equation

$$
\beta - \frac{2\Lambda}{2 - \alpha} \left((2 - \alpha) \frac{\rho_0^2}{1 - \rho_0} + \frac{2a}{(1 - \rho_0)^3} - 2a + (2a - 1) \frac{\rho_0^2}{1 - \rho_0^2} \right) = 0.
$$

By using [\(3.7\)](#page-8-0) and Lemma [3.1,](#page-5-0) we have

$$
|f(z_2) - f(z_1)| = \left| \int_{[z_1, z_2]} f_z(z) dz + f_{\bar{z}}(z) d\bar{z} \right|
$$

= \left| \int_{[z_1, z_2]} f_z(0) dz + f_{\bar{z}}(0) d\bar{z} \right|

- \left| \int_{[z_1, z_2]} (f_z(z) - f_z(0)) dz + (f_{\bar{z}}(z) - f_{\bar{z}}(0)) d\bar{z} \right|

\n= 0.

Therefore, $f(z_1) \neq f(z_2)$. This shows that f is univalent in the ball \mathbb{D}_{ρ_0} .

To prove the second part of the theorem, let $\zeta = \rho_0 e^{i\theta} \in \partial \mathbb{D}_{\rho_0}$, then we have

$$
|f(\zeta) - f(0)| = \left| \int_{[0,\zeta]} f_z(z)dz + f_{\bar{z}}(z)d\bar{z} \right|
$$

= \left| \int_{[0,\zeta]} f_z(0)dz + f_{\bar{z}}(0)d\bar{z} \right|

\geq \beta \rho_0 - \frac{2\Lambda}{2 - \alpha} \int_0^{\rho_0} \left((2 - \alpha) \frac{r^2}{1 - r} + \frac{2a}{(1 - r)^3} - 2a \right)

\n $= \rho_0 \left(\beta - \frac{2\Lambda}{2 - \alpha} \left(\frac{2 - \alpha}{1 - \rho_0} \frac{\rho_0^2}{3} + \frac{2a}{(1 - \rho_0)^3} - 2a + \frac{2a - 1}{1 - \rho_0^2} \frac{\rho_0^2}{3} \right) \right).$

Hence $f(\mathbb{D}_{\rho_0})$ contains a Schlicht disc of radius R_0 with

$$
R_0 \ge \rho_0 \left(\beta - \frac{2\Lambda}{2 - \alpha} \left(\frac{2 - \alpha}{1 - \rho_0} \frac{\rho_0^2}{3} + \frac{2a}{(1 - \rho_0)^3} - 2a + \frac{2a - 1}{1 - \rho_0^2} \frac{\rho_0^2}{3} \right) \right).
$$

This completes the proof.

Corollary 3.1. For $\alpha \in (0,2)$, let $a = \Gamma(\alpha/2 + 1)/\Gamma(1 + \alpha)$, $f \in C^2(\mathbb{D})$ be the solution of [\(1.1\)](#page-0-0) satisfying $f(0) = |J_f(0)| - \beta = 0$ and $\Lambda_f(z) \leq \Lambda$ for each $z \in \mathbb{D}$, where Λ , β are positive constants and J_f is the Jaccobian of f. Then f is univalent on a disc \mathbb{D}_{ρ_1} , where ρ_1 satisfies the following equation

$$
\frac{\beta}{\Lambda} - \frac{2\Lambda}{2 - \alpha} \left((2 - \alpha) \frac{\rho_1^2}{1 - \rho_1} + \frac{2a}{(1 - \rho_1)^3} - 2a + (2a - 1) \frac{\rho_1^2}{1 - \rho_1^2} \right) = 0.
$$

Morever, $f(\mathbb{D}_{\rho_1})$ contains a schlicht disc of radius

$$
R_1 \ge \rho_1 \left(\frac{\beta}{\Lambda} - \frac{2\Lambda}{2-\alpha} \left(\frac{2-\alpha}{1-\rho_1} \frac{\rho_1^2}{3} + \frac{2a}{(1-\rho_1)^3} - 2a + \frac{2a-1}{1-\rho_1^2} \frac{\rho_1^2}{3} \right) \right).
$$

Proof. Since, $|J_f(0)| = \beta$, we have

$$
\beta = |J_f(0)| = |\det D_f(0)| = \Lambda_f(0)\lambda_f(0) \le \Lambda \lambda_f(0),
$$

which gives

$$
\lambda_f(0) = ||f_z(0)| - |f_{\bar{z}}(0)|| \geq \frac{\beta}{\Lambda}.
$$

Let $z_1, z_2 \in \mathbb{D}_{\rho_1}$, then by using the proof of Theorem [3.1](#page-5-1) and Lemma [3.1,](#page-5-0) we have

$$
|f(z_1) - f(z_2)| > |z_1 - z_2| \left\{ \frac{\beta}{\Lambda} - \frac{2\Lambda}{2 - \alpha} \left((2 - \alpha) \frac{\rho_1^2}{1 - \rho_1} + \frac{2a}{(1 - \rho_1)^3} - 2a + (2a - 1) \frac{\rho_1^2}{1 - \rho_1^2} \right) \right\} = 0.
$$

Therefore, $f(z_1) \neq f(z_2)$. This shows that f is univalent in the ball \mathbb{D}_{ρ_1} .

To prove the second part of the corollary, let $\zeta = \rho_1 e^{i\theta} \in \partial \mathbb{D}_{\rho_1}$. By using the proof of Theorem [3.1,](#page-5-1) we obtain

$$
|f(\zeta)| \ge \rho_1 \left(\frac{\beta}{\Lambda} - \frac{2\Lambda}{2-\alpha} \left(\frac{2-\alpha}{1-\rho_1} \frac{\rho_1^2}{3} + \frac{2a}{(1-\rho_1)^3} - 2a + \frac{2a-1}{1-\rho_1^2} \frac{\rho_1^2}{3}\right)\right).
$$

Hence $f(\mathbb{D}_{\rho_1})$ contains a Schlicht disc of radius R_1 with

$$
R_1 \ge \rho_1 \left(\frac{\beta}{\Lambda} - \frac{2\Lambda}{2-\alpha} \left(\frac{2-\alpha}{1-\rho_1} \frac{\rho_1^2}{3} + \frac{2a}{(1-\rho_1)^3} - 2a + \frac{2a-1}{1-\rho_1^2} \frac{\rho_1^2}{3} \right) \right).
$$

This completes the proof.
