# Canonical coordinates for Yang-Mills-Chern-Simons theory

#### Abstract

: We consider the classical field theory of 2+1-dimensional Yang-Mills-ChernSimons theory on an arbitrary spatial manifold. We first define a gauge covariant transverse electric field strength, which together with the gauge covariant scalar magnetic field strength can be taken as coordinates on the classical phase space. We then determine the Poisson-Dirac bracket and find that these coordinates are canonically conjugate to each other. The Hamiltonian is non-polynomial when expressed in terms of these coordinates, but can be expanded in a power series in the coupling constant with polynomial coefficients.


## 1 Introduction

Three-dimensional Yang-Mills-Chern-Simons theory [1] 2 [3] with coupling constant ${ }^{11} \lambda$ and integer level $k$ is governed by the action $2^{2} \sqrt[3]{3}$

The Bianchi identity and the equations of motion read

D_{\mu} F_{\nu \rho}+D_{\nu} F_{\rho \mu}+D_{\rho} F_{\mu \nu} & =0 \\
\frac{1}{2 \lambda^{2}} D_{\nu} F^{\mu \nu}+\frac{k}{4 \pi} \epsilon^{\mu \nu \rho} F_{\nu \rho} & =0 . \tag{2}
\end{align*}

It follows from these equations that a current of the form $J^{\mu}=T^{\mu \nu} K_{\nu}$, where

\end{equation*}

is the energy momentum tensor and the vector field $K_{\mu}$ obeys the Killing condition $\nabla_{\mu} K_{\nu}+\nabla_{\nu} K_{\mu}=0$, is conserved, i.e. $\nabla_{\mu} J^{\mu}=0$.

In this note, we will be concerned with the case where the space-time metric $G_{\mu \nu}$ admits a time-like Killing vector field, which by a choice of spacetime coordinates $x^{\mu}, \mu=0,1,2$ can be taken as $K_{0}=1, K_{i}=0, i=1,2.4$ The space-time metric then takes the form $G_{\mu \nu} d x^{\mu} d x^{\nu}=-(d t)^{2}+g_{i j} d x^{i} d x^{j}$, and the equations (2) can be rewritten in a $2+1$-dimensional notation:

where

B & =\frac{1}{2} \hat{\epsilon}^{i j} F_{i j} \\
E_{i} & =F_{0 i} \tag{6}
\end{align*}

are the magnetic and electric field strengths respectively. 5 The equations (4) determine the time development of $B$ and $E^{i}$ respectively, while equation (5) is a constraint that needs to be imposed on the data at some initial time. The time component of the current constructed from the time-like Killing vector is the Hamiltonian density

the spatial integral of which is the Hamiltonian

\end{equation*}

The phase space of the theory is given by the space of solutions to the equations (4) and (5) modulo (infinitesimal) gauge transformations acting as

with a Lie algebra-valued parameter $\Lambda$. The phase space is endowed with a symplectic structure, i.e. a closed, non-degenerate two-form given by a Poisson-Dirac bracket $\{.,$.$\} . The equations of motion (4) can then be cast in$ Hamiltonian form:

where we have included a possible infinitesimal gauge transformation with parameter $\Lambda$.

The aim of this note is to describe a convenient set of coordinates to parametrise this phase space. We will then compute the symplectic structure by giving the Poisson-Dirac bracket between these coordinates. We will see that our coordinates are canonically conjugate to each other, i.e. they are Darboux coordinates. Finally, we will express the Hamiltonian in terms of these coordinates. The Hamiltonian is non-polynomial, but can be expanded in a power-series in the coupling constant $\lambda$ with coefficients that are polynomial in the (rescaled) coordinates.

For another, somewhat unrelated, approach to a Hamilton treatment of Yang-Mills-Chern-Simons theory, see (4].

We hope that these observations and constructions may prove useful for the purpose of canonical quantization of Yang-Mills-Chern-Simons theory.

## 2 The coordinates

The electric field strength $E_{i}$ may, as any vector field in two dimensions, be decomposed into its longitudinal and transverse scalar components $E_{\|}$and $E_{\perp}: 6^{6}$

In principle, this equation may be inverted to express $E_{\|}$and $E_{\perp}$ in terms of the vector components $E_{i}$, but not in closed form.

The constraint (5) can now be written a. $7^{7} 8$

and can be solved by expressing $E_{\|}$in terms of $E_{\perp}$ and the connection $A_{i}$ :

[^2]We will take the transverse electric field $E_{\perp}$ together with the magnetic field $B$ as our phase space coordinates. They are gauge covariant, but of course not gauge invariant, so to determine a point in the phase space, they must be supplemented by a gauge condition

Here the Lie algebra-valued scalar field $\phi_{A}$ is some fairly arbitrary (linear) functional of the spatial gauge connection $A_{i}$ chosen so that this equation determines a single point on each orbit of the group of gauge transformations. This allows us to express $A_{i}$ in terms of $B$. For many purposes, it will e.g. be convenient to use the Coulomb gauge condition $\phi_{A}=\nabla_{i} A^{i}=0$. The general solution is then $A_{i}=\epsilon_{i}{ }^{j} \nabla_{j} A$, where $A$ is a Lie algebra-valued scalar field. This gives $B=-\nabla^{2} A-\frac{i}{2} \hat{\epsilon}^{i j}\left[\nabla_{i} A, \nabla_{j} A\right]$, which may be inverted to express $A$, and thus $A_{i}$, as a power series in $B$ :

Finally, we note that the time component $A_{0}$ of the gauge connection is not an independent variable: The constraint (5) can be written as

and solved for $A_{0}$ in terms of the spatial components $A_{i}$ :

To summarize, once a choice of gauge has been made, the phase space can be parametrized by the scalar fields $E_{\perp}$ and $B$. The quantities $A_{i}, E_{i}$ and $E_{\|}$are then not independent variables, but are defined in terms of $E_{\perp}$ and $B$ by the gauge condition (14), the decomposition (11) and equation (13) respectively. Also the temporal component $A_{0}$ of the gauge connection is a dependent variable given by the expression (17).

## 3 The symplectic structure

The most familiar route to determining the symplectic structure of a theory with constraints, like the Yang-Mills-Chern-Simons theory, is to identify a set
of configuration space coordinates like $A_{\mu}$ and determine the corresponding canonical momenta $\Pi^{\mu}=\frac{\partial \mathcal{L}}{\partial \dot{\mu}_{\mu}}$ from the Lagrangian $\mathcal{L}$. However, the canonical Poisson bracket $\left\{\Pi^{\mu}(x), A_{\nu}\left(x^{\prime}\right)\right\}_{\mathrm{PB}}=\delta_{\nu}^{\mu} \delta\left(x-x^{\prime}\right)$ between the coordinates and the momenta would not be consistent because of the constraints on the latter. This can be dealt with by imposing additional constraints (i.e. a gauge condition $\phi_{A}=0$ ), chosen so that the Poisson bracket is non-degenerate on the space spanned by the constraints. There is then an explicit procedure for constructing the Dirac modification $\{.,$.$\} of the Poisson bracket \{., .\}_{\mathrm{PB}}$, so that it will be consistent with the constraints and fullfil all the other requirements on the symplectic structure on the phase space [5].

This procedure is not obvious to implement in the present case because of the implicit definition (11) of our coordinate $E_{\perp}$. We will therefore follow a different strategy and determine the Dirac bracket \{.,.\} 'directly' by requiring that it reproduces the correct Hamiltonian equations of motion (10).

Clearly

for any c-number Lie algebra-valued scalar fields $S$ and $S^{\prime} .9$ The rest of the symplectic structure can now be described by giving the bilinear functionals $f$ and $g$ defined by

& g\left[S ; S^{\prime}\right]=\left\{\int d^{2} x \sqrt{g} \operatorname{Tr}\left(S E_{\perp}\right), \int d^{2} x \sqrt{g} \operatorname{Tr}\left(S^{\prime} E_{\perp}\right)\right\} . \tag{19}
\end{align*}

To determine $f$, we start by rewriting

& -\frac{\lambda^{2} k}{\pi} \int d^{2} x \sqrt{g} \operatorname{Tr}\left(D_{i} V^{i} D^{-2} B\right) \tag{20}
\end{align*}
$$

where

\mathcal{W}=\hat{\epsilon}^{i j} D_{i} V_{j}-i\left[D^{-2} D_{i} V^{i}, B\right] \tag{21}
\end{equation*}
$$

[^3]for any c-number Lie algebra-valued vector field $V^{i}$. Thus

\left\{\int d^{2} x \sqrt{g} \operatorname{Tr}\left(V^{i} E_{i}\right), \int d^{2} x \sqrt{g} \operatorname{Tr}\left(S^{\prime} B\right)\right\}=f\left[\mathcal{W} ; S^{\prime}\right] \tag{22}
\end{equation*}

If we now apply this with $V_{i}=E_{i}$ (although this is not a c-number field), we get $\mathcal{W}=\mathcal{W}_{E}$, where

& =\hat{\epsilon}^{i j} D_{i} E_{j}+\frac{\lambda^{2} k}{\pi} i\left[B, D^{-2} B\right] . \tag{23}
\end{align*}

Here we have used the constraint (5) in the last step. This gives

where the prefactor $\frac{1}{2}$ in the first argument of the Dirac bracket compensates for the integrand being of order 2 in $E_{i}$. Since

we see that

\end{equation*}

as required provided that the functional $f$ is given by

f\left[S ; S^{\prime}\right] & =\left\{\int d^{2} x \sqrt{g} \operatorname{Tr}\left(S E_{\perp}, \int d^{2} x \sqrt{g} \operatorname{Tr}\left(S^{\prime} B\right)\right\}\right. \\
& =\lambda^{2} \int d^{2} x \sqrt{g} \operatorname{Tr}\left(S S^{\prime}\right) \tag{27}
\end{align*}
$$

and

\Lambda=\frac{\lambda^{2} k}{\pi} D^{-2} B \tag{28}
\end{equation*}
$$

The functional $g$ is now constrained by the requirement that the symplectic structure obey the Jacobi identity, i.e. that it is given by a closed two-form on the phase space. This forces $g$ to vanish identically so that

The equations (18), (27) and (29) define the symplectic structure on the phase space. The Poisson-Dirac bracket for quantities involving covariant derivatives can be found by choosing a gauge and expressing the connection $A_{i}$ in terms of the magnetic field strength $B$. An alternative gauge invariant argument is to use the relation

for the variation of $B$ induced by an arbitrary variation $\delta A_{j}$. It follows that the equations (18) and (27) are consistent with

& \left\{\int d^{2} x \sqrt{g} \operatorname{Tr}\left(S E_{\perp}\right), \int d^{2} x \sqrt{g} \operatorname{Tr}\left(V^{\prime j} A_{j}\right)\right\}=\int d^{2} x \sqrt{g} \hat{\epsilon}^{i j} \operatorname{Tr}\left(V_{j}^{\prime} D_{i} D^{-2} S\right) \\
& \left\{\int d^{2} x \sqrt{g} \operatorname{Tr}\left(V^{i} A_{i}\right), \int d^{2} x \sqrt{g} \operatorname{Tr}\left(V^{\prime j} A_{j}\right)\right\}=0 \tag{31}
\end{align*}
$$

for any c-number Lie algebra-valued scalar and vector fields $S, V^{i}$ and $V^{\prime i}$.
As a check of the above results for the symplectic structure, it would be gratifying to verify that also the second equation in (10) comes out correctly. It follows from equation (22) that

= & -\lambda^{2} \int d^{2} x \sqrt{g} \operatorname{Tr}\left(\left(\hat{\epsilon}^{i j} D_{i} V_{j}^{\prime}-i\left[D^{-2} D_{i} V^{\prime i}, B\right]\right) B\right) \\
= & -\lambda^{2} \int d^{2} x \sqrt{g} \hat{\epsilon}^{i j} \operatorname{Tr}\left(V_{i}^{\prime} D_{j} B\right) \tag{32}
\end{align*}
$$

If we now define the auxiliary functional $c$ as

c\left[V ; V^{\prime}\right]=\left\{\int d^{2} x \sqrt{g} \operatorname{Tr}\left(V^{i} E_{i}\right), \int d^{2} x \sqrt{g} \operatorname{Tr}\left(V^{\prime j} E_{j}\right)\right\} \tag{33}
\end{equation*}
$$

for arbitrary c-number Lie algebra-valued vector fields $V$ and $V^{\prime}$ and apply this with $V^{i}=E^{i}$ (although this again is not a c-number field) we have

\left\{\frac{1}{2} \int d^{2} x \sqrt{g} \operatorname{Tr}\left(E^{i} E_{i}\right), \int d^{2} x \sqrt{g} \operatorname{Tr}\left(V^{\prime j} E_{j}\right)\right\}=c\left[E ; V^{\prime}\right] \tag{34}
\end{equation*}
$$

and thus

$$
\begin{equation*}
\left\{H, \int d^{2} x \sqrt{g} \operatorname{Tr}\left(V^{\prime j} E_{j}\right)\right\}=-\int d^{2} x \sqrt{g} \hat{\epsilon}^{i j} \operatorname{Tr}\left(V_{i}^{\prime} D_{j} B\right)+\frac{1}{\lambda^{2}} c\left[E ; V^{\prime}\right] . \tag{35}
\end{equation*}
$$

So to reproduce the second equation in (10), we must have

c\left[E ; V^{\prime}\right]=-\frac{\lambda^{4} k}{\pi} \int d^{2} x \sqrt{g} \operatorname{Tr}\left(\hat{\epsilon}^{i j} E_{i} V_{j}^{\prime}\right)+i \lambda^{2} \int d^{2} x \sqrt{g} \operatorname{Tr}\left(\left[\Lambda, E^{i} V_{i}^{\prime}\right]\right) \tag{36}
\end{equation*}
$$

with $\Lambda$ given by equation (28).
Unfortunately, while in principle determined by our previous results, a direct computation of the functional $c$ appears tedious. We will therefore content ourselves with the abelian case. Here

E_{i}=\hat{\epsilon}_{i}^{j} \nabla_{j} E_{\perp}+\frac{\lambda^{2} k}{\pi} \nabla^{-2} \nabla_{i} B \tag{37}
\end{equation*}
$$

which gives

c\left[V ; V^{\prime}\right]=-\frac{\lambda^{4} k}{\pi} \int d^{2} x \sqrt{g} \hat{\epsilon}^{i j} \operatorname{Tr}\left(V_{i} V_{j}^{\prime}\right) \tag{38}
\end{equation*}
$$

so that

c\left[E ; V^{\prime}\right]=-\frac{\lambda^{4} k}{\pi} \int d^{2} x \sqrt{g} \hat{\epsilon}^{i j} \operatorname{Tr}\left(E_{i} V_{j}^{\prime}\right) \tag{39}
\end{equation*}
$$

in agreement with the abelian version of equation (36).

## 4 The Hamiltonian

By using equations (11), (12) and (13) and partial integrations, the Hamiltonian $H$ can be written in terms of the variables $E_{\perp}$ and $B$ as

H= & \frac{1}{2 \lambda^{2}} \int d^{2} x \sqrt{g} \operatorname{Tr}\left(B B+E_{i} E^{i}\right) \\
= & \frac{1}{2 \lambda^{2}} \int d^{2} x \sqrt{g} \operatorname{Tr}\left(B B-E_{\perp} D^{2} E_{\perp}\right. \\
& \left.\quad-\left[E_{\perp}, B\right] D^{-2}\left[E_{\perp}, B\right]-\frac{\lambda^{4} k^{2}}{\pi^{2}} B D^{-2} B\right) . \tag{40}
\end{align*}
$$

This is non-polynomial in $B$, which enters implicitly through the connection $A_{i}$ in the covariant derivative $D_{i}$. To expand the Hamiltonian as a power series in the coupling constant $\lambda$, we introduce the canonically normalized variables $b$ and $e$ through

Just like $B$ and $E_{\perp}$, the rescaled variables $b$ and $e$ are Darboux coordinates on the phase space:

& \left\{\int d^{2} x \sqrt{g} \operatorname{Tr}(S e), \int d^{2} x \sqrt{g}\left(S^{\prime} b\right)\right\}=\int d^{2} x \sqrt{g} \operatorname{Tr}\left(S S^{\prime}\right) \\
& \left\{\int d^{2} x \sqrt{g} \operatorname{Tr}(S b), \int d^{2} x \sqrt{g}\left(S^{\prime} b\right)\right\}=0 \\
& \left\{\int d^{2} x \sqrt{g} \operatorname{Tr}(S e), \int d^{2} x \sqrt{g}\left(S^{\prime} e\right)\right\}=0 \tag{42}
\end{align*}
$$

for any c-number Lie algebra-valued scalar fields $S$ and $S^{\prime}$.
We can now express the Hamiltonian as a power series in $\lambda$. Choosing e.g. Coulomb gauge we have from equation (15) that

A_{i}=\hat{\epsilon}_{i}{ }^{j} \nabla_{j}\left(-\lambda \nabla^{-2} b-\frac{i \lambda^{2}}{2} \hat{\epsilon}^{k l} \nabla^{-2}\left[\nabla_{k} \nabla^{-2} b, \nabla_{l} \nabla^{-2} b\right]+\mathcal{O}\left(\lambda^{3}\right)\right) . \tag{43}
\end{equation*}
$$

This gives

$$
\begin{align*}
H= & \frac{1}{2} \int d^{2} x \sqrt{g} \operatorname{Tr}\left(b b-e \nabla^{2} e\right) \\
& +i \lambda \int d^{2} x \sqrt{g} \hat{\epsilon}^{i j} \operatorname{Tr}\left(\left[\nabla_{i} e, \nabla_{j} e\right] \nabla^{-2} b\right) \\
& +\frac{\lambda^{2}}{2} \int d^{2} x \sqrt{g} \operatorname{Tr}\left(-[e, b] \nabla^{-2}[e, b]-\left[e, \nabla_{i} \nabla^{-2} b\right]\left[e, \nabla^{i} \nabla^{-2} b\right]\right. \\
& +\mathcal{O}\left(\lambda^{3}\right) .
\end{align*}
$$

The Chern-Simons level $k$ will only affect terms of order $\lambda^{4}$ or higher.
The abelian theory is of course free and has the bilinear harmonic oscillator Hamiltonian

$$
\begin{equation*}
H=\frac{1}{2} \int d^{2} x \sqrt{g} \operatorname{Tr}\left(b\left(1-\frac{\lambda^{4} k^{2}}{\pi^{2}} \nabla^{-2}\right) b+e\left(-\nabla^{2}\right) e\right) . \tag{45}
\end{equation*}
$$

Excitations which are eigenfunctions to the spatial Laplacian $-\nabla^{2}$ with eigenvalue $p^{2}$ then have energy

$$
E=\sqrt{\left(1-\frac{\lambda^{4} k^{2}}{\pi^{2}} \nabla^{-2}\right)\left(-\nabla^{2}\right)}
$$

$$
\begin{equation*}
=\sqrt{p^{2}+m^{2}} \tag{46}
\end{equation*}
$$

with the mass gap

$$
\begin{equation*}
m=\frac{\lambda^{2} k}{\pi} \tag{47}
\end{equation*}
$$

as expected.

    ${ }^{2}$ Our conventions for the gauge covariant derivate $D_{\mu}$ of a field $X$ in the adjoint representation and the curvature $F_{\mu \nu}$ of the Yang-Mills connection $A_{\mu}$ are $D_{\mu} X=$ $\nabla_{\mu} X+i\left[X, A_{\mu}\right]$ and $F_{\mu \nu}=\nabla_{\mu} A_{\nu}-\nabla_{\nu} A_{\mu}-i\left[A_{\mu}, A_{\nu}\right]$, with $\nabla_{\mu}$ being the covariant derivative constructed out of the spin-connection on the space-time manifold. This gives the commutator of gauge covariant derivatives $\left[D_{\mu}, D_{\nu}\right] X=i\left[X, F_{\mu \nu}\right]$. These conventions are compatible with $X, A_{\mu}$ and $F_{\mu \nu}$ all being Hermitian.
    ${ }^{3}$ With an $S U(N)$ gauge group, Tr is the trace in the fundamental $N$-dimensional representation.
    ${ }^{4}$ The spatial metric $g_{i j}$ may admits further Killing vector fields, that would give rise to additional conserved currents.

    ${ }^{8}$ By the identity $\hat{\epsilon}^{i j} D_{i} D_{j} E_{\perp}=i\left[E_{\perp}, B\right]$.

[^3]:    ${ }^{9}$ This would come out of the Dirac procedure since the Poisson bracket between $A_{i}$ and a gauge condition formulated purely in terms of the connection vanishes. The Dirac bracket thus agrees with the Poisson bracket and vanishes when evaluted between functionals of $A_{i}$ only.
