PROJECTION SCHEME FOR A PERFECT PLASTICITY MODEL WITH A TIME-DEPENDENT CONSTRAINT SET

Abstract. This paper introduces a new numerical scheme for a system that includes evolution equations describing a perfect plasticity model with a time-dependent yield surface. We demonstrate that the solution to the proposed scheme is stable under suitable norms. Moreover, the stability leads to the existence of an exact solution, and we also prove that the solution to the proposed scheme converges strongly to the exact solution under suitable norms.

1. Introduction

When a force is applied to materials like metals, they undergo elastic deformation and then shift to plastic deformation. This behavior is described by a relation between stress and strain. In engineering, the following simple model of perfect plasticity is often used [\[11\]](#page-21-0):

where $\sigma \in \mathcal{S}_d$ $(2 \leq d \in \mathbb{N})$ is the stress, \mathcal{S}_d is the space of symmetric matrices of order d, $C = (C_{ijkl})_{i,j,k,l}$ is the fourth-order elasticity tensor, $u \in \mathbb{R}^d$ is the displacement, $\mathcal{E}(u) \coloneqq (\nabla u + (\nabla u)^T)/2 \in \mathcal{S}_d$ is the strain, $\varepsilon_p \in \mathcal{S}_d$ is the plastic part of $\mathcal{E}(u)$, $K \subset \mathcal{S}_d$ is a given closed convex set, I_K is the indicator function on K, and ∂I_K is the subdifferential of I_K . The set K is called the constraint set, and the boundary of K is known as the yield surface. In this paper, we consider the von Mises yield surface (yield criterion) [\[11\]](#page-21-0):

where $\tau^D := \tau - ((\text{tr} \tau)/d)E_d$ is the deviatoric part of τ , $|\cdot|$ is the Frobenius norm for matrices, E_d is the identity matrix of size d, and $p \in S_d$ and $g \in \mathbb{R}$ are given. This paper adopts the settings of [\[1\]](#page-20-0), where g depends on time (and space) (cf. [\[5,](#page-21-1) [21\]](#page-21-2)). See Definition [2.1](#page-3-0) for the details of K and g. The equation (1.1) is closely related to the Moreau sweeping process [\[19,](#page-21-3) [20\]](#page-21-4). The Moreau sweeping process is a problem of finding $\sigma : [0, T] \to H$ in a real Hilbert space H with $T > 0$, where $K(t)$ is a time-dependent

closed convex constraint, and

$$
\frac{d\sigma}{dt} \in -\partial I_K(\sigma) \quad \text{in } H
$$

is satisfied. This problem, modeling dynamic behavior under time-dependent constraints, has been studied in various scenarios by numerous researchers (refer to [\[8,](#page-21-5) [13,](#page-21-6) [14,](#page-21-7) [15,](#page-21-8) [17,](#page-21-9) [18,](#page-21-10) [21,](#page-21-2) [22,](#page-21-11) [23,](#page-21-12) [33\]](#page-22-0)).

1.1. Problem. Let $T > 0$, and consider a bounded Lipschitz domain Ω in \mathbb{R}^d . We assume the existence of two subsets Γ_1 and Γ_2 of the boundary $\Gamma := \partial\Omega$, with $|\Gamma_1| > 0$ and $\Gamma_2 = \Gamma \setminus \Gamma_1$. Here, $|\Gamma_1|$ denotes the $(d-1)$ -dimensional Hausdorff measure of Γ_1 . In this paper, we focus on a problem incorporating Kelvin–Voigt viscosity, aiming to find the displacement $u:[0,T] \times \Omega \to \mathbb{R}^d$ and stress $\sigma_{st}:[0,T] \times \Omega \to \mathcal{S}_d$ that satisfy

where $\rho > 0$ is the density, $\nu > 0$ is the viscosity coefficient, $\varepsilon_p : (0, T) \times \Omega \to \mathcal{S}_d$ is the plastic part of $\mathcal{E}(u)$, $f:(0,T)\times\Omega\to\mathbb{R}^d$ is the external force, $v_{\rm b}:(0,T)\times\Gamma_1\to\mathbb{R}^d$ and $\sigma_{\rm b}:(0,T)\times\Gamma_2\to\mathbb{R}^d$ are the boundary values, $(u_0,v_0,\sigma_0)\in\mathbb{R}^d\times\mathbb{R}^d\times\mathcal{S}_d$ are the initial values with $\sigma_0 \in K(0)$, and are given. Additionally, *n* represents the outward unit normal vector to the boundary Γ.

The first equation in (1.2) represents the motion equation, while the second, third, and fourth equations correspond to a rheological model depicted in Figure [1,](#page-2-0) which addresses small deformations. Equations five and six define boundary conditions on Γ_1 and Γ_2 , respectively, while the seventh, eighth, and ninth equations set the initial conditions. The model depicted in Figure [1](#page-2-0) is used in engineering fields. It finds applications in areas such as construction materials [\[29\]](#page-21-13), concrete flow analysis [\[27\]](#page-21-14), and concrete slump testing [\[26\]](#page-21-15).

In subsequent discussions, we simplify by assuming $\rho = 1$ and $C_{ijkl} = (\delta_{ik}\delta_{jl} +$ $\delta_i \delta_j$)/2, where δ_{ij} is the Kronecker delta. By defining $v := \partial u / \partial t$, obtaining v also yields $u(t,x) = u_0(x) + \int_0^t v(s,x)ds$. Thus, solving the following problem suffices:

Problem 1.1. Find $v : [0, T] \times \Omega \to \mathbb{R}^d$ and $\sigma : [0, T] \times \Omega \to S_d$ that satisfy:

v = 0 & \text{on } (0, T) \times \Gamma_1, \\
(\nu \mathcal{E}(v) + \sigma) n = 0 & \text{on } (0, T) \times \Gamma_2, \\
v(0, \cdot) = v_0 & \text{in } \Omega, \\
\sigma(0, \cdot) = \sigma_0 & \text{in } \Omega,\n\end{cases}

where $h : (0, T) \times \Omega \rightarrow S_d$ is a function arising from converting non-homogeneous boundary conditions to homogeneous ones.

The problem with time-dependent threshold functions was proposed in [\[1\]](#page-20-0). For cases without time-dependent threshold functions, similar challenges incorporating heat trans-fer are addressed in [\[16\]](#page-21-16) (cf. $[3, 4, 10, 24, 2, 25]$ $[3, 4, 10, 24, 2, 25]$ $[3, 4, 10, 24, 2, 25]$ $[3, 4, 10, 24, 2, 25]$ $[3, 4, 10, 24, 2, 25]$ $[3, 4, 10, 24, 2, 25]$). In general, for solving elastoplastic problems numerically, it is necessary to employ nonlinear problem-solving algorithms, such as the Newton–Raphson method [\[30\]](#page-21-21). The scheme proposed in [\[4\]](#page-21-17) also employs the semismooth Newton method.

In this paper, we propose a new numerical scheme for Problem [1.1.](#page-2-1) The proposed scheme is stable under suitable norms regardless of the time step size and allows us to solve without the use of nonlinear problem-solving algorithms. The solutions of the proposed scheme satisfy the yield criterion for each time step. Furthermore, using this stability, we can show the existence of an exact solution (in the sense of Definition [2.1\)](#page-3-0). While spatial continuity and a positive lower bound of g are assumed due to technical reasons for obtaining a well-posedness of Problem [1.1](#page-2-1) in [\[1\]](#page-20-0), we obtain the existence and uniqueness of the solution of Problem [1.1](#page-2-1) without these assumptions. Additionally, we also show that the solutions of the proposed scheme strongly converge to the exact solutions under suitable norms.

This paper is organized as follows. Section [2](#page-3-1) defines the notation and the solutions to Problem [1.1.](#page-2-1) In Section [3,](#page-4-0) we discretize Problem [1.1](#page-2-1) in the time direction and discuss the challenges of naively solving it either explicitly or implicitly, before introducing our proposed scheme. The main results are compiled in Section [4.](#page-5-0) Proofs of the main results are detailed in Section [5.](#page-6-0) Finally, Section [6](#page-20-3) contains our conclusions.

2. Notations and definition of a solution of Problem [1.1](#page-2-1)

2.1. Notations. For a Banach space X , the dual pairing between X and the dual space X^* is denoted by $\langle \cdot, \cdot \rangle_{X^*,X}$, and we simply write $L^2(X)$, $L^\infty(X)$, and $H^1(X)$ as $L^2(0,T;X)$, $L^{\infty}(0,T;X)$, and $H^1(0,T;X)$, respectively. We say that a function $u:[0,T] \to X$ is weakly continuous if, for all $f \in X^*$, the function defined by $[0,T] \ni t \mapsto$ $\langle f, u(t) \rangle_{X^*,X} \in \mathbb{R}$ is continuous. We denote by $C^0([0,T]; X_w)$ the set of functions defined on $[0, T]$ with values in X which are weakly continuous. For two sequences $(x_k)_{k=0}^N$ and $(y_k)_{k=1}^N$ in X, we define a piecewise linear interpolant $\hat{x}_{\Delta t} \in W^{1,\infty}(0,T;X)$ of $(x_k)_{k=0}^N$ and a piecewise constant interpolant $\bar{y}_{\Delta t} \in L^{\infty}(0,T;X)$ of $(y_k)_{k=1}^N$, respectively, by

We define a backward difference operator by

$$
D_{\Delta t} x_k := \frac{x_k - x_{k-1}}{\Delta t}, \qquad D_{\Delta t} y_l := \frac{y_l - y_{l-1}}{\Delta t}

for $k = 1, 2, ..., N$ and $l = 2, 3, ..., N$. Then, the sequence $(D_{\Delta t}x)_k := D_{\Delta t}x_k$ satisfies $\frac{\partial \hat{x}_{\Delta t}}{\partial t} = (\overline{D_{\Delta t}x})_{\Delta t}$ on (t_{k-1}, t_k) for all $k = 1, 2, ..., N$.

2.2. Definition of a solution of Problem [1.1.](#page-2-1) We define the function spaces $H =$ $L^2(\Omega;\mathbb{R}^d), H \coloneqq L^2(\Omega; \mathcal{S}_d), \, \boldsymbol{V} \coloneqq \{\varphi \in H^1(\Omega;\mathbb{R}^d): \varphi = 0 \text{ on } \Gamma_1\}, \text{and let } \boldsymbol{V^*} \text{ be the dual }$ space of V . The solution to Problem [1.1](#page-2-1) is defined by using the following variational inequality:

Definition 2.1. Given $\nu > 0$, $v_0 \in H$, $\sigma_0 \in H$, $f \in L^2(0,T;V^*)$, $h \in L^2(0,T;H)$, $p \in H^1(0,T;H)$, $g \in H^1(0,T;L^2(\Omega))$, and assume that for almost every $t \in [0,T]$ and almost every $x \in \Omega$, $g(t, x) \geq 0$. We call the pair $(v, \sigma) \in (H^1(0, T; V^*) \cap L^2(0, T; V)) \times$ $H^1(0,T;H)$ a solution to Problem [1.1](#page-2-1) if: $v(0) = v_0$, $\sigma(0) = \sigma_0$ and for all $t \in [0,T]$,

is satisfied, and for almost every $t \in (0,T)$ and all $\varphi \in V$ and $\tau \in K(t)$

holds. Here, $K(t)$ is a time-dependent function space defined as:

$$
K(t) := \tilde{K}(t) - p(t), \quad \tilde{K}(t) := \left\{ \tau \in H : |\tau^D| \le g(t) \text{ a.e. in } \Omega \right\}.
$$

The discussions in [\[1\]](#page-20-0) focus on solvability and parameter dependency in Problem [1.1,](#page-2-1) with the following proven results:

Theorem 2.2 ([\[1\]](#page-20-0)). Under the following three conditions, there exists a unique solution to Problem [1.1.](#page-2-1)

- (A1) $f \in L^2(0, T; H)$,
- $(A2)$ $g \in H^1(0,T;C(\overline{\Omega})),$
- (A3) there exists a constant $C > 0$ such that

3. Numerical scheme

3.1. Time discretization. We consider numerical methods for solving Problem [1.1.](#page-2-1) Let $\Delta t = T/N$ ($N \in \mathbb{N}$) and let

f_n := \frac{1}{\Delta t} \int_{t_{n-1}}^{t_n} f dt, \ h_n := \frac{1}{\Delta t} \int_{t_{n-1}}^{t_n} h dt, \ p_n := p(t_n), \ g_n := g(t_n), \ K_n := K(t_n)

for all $n = 1, 2, ..., N$, where $t_n = n\Delta t$. Formally discretizing Problem [1.1](#page-2-1) implicitly yields the following.

for all $\varphi \in V$, where $\mathcal{P}_R : \mathcal{S}_d \to \mathcal{S}_d$ is defined for $A \in \mathcal{S}_d$,

\mathcal{P}_R(A) := \begin{cases} \frac{\text{tr}\,A}{d} E_d + R\Phi\left(\frac{A^D}{R}\right) & \text{if } R > 0, \\ \frac{\text{tr}\,A}{d} E_d & \text{if } R = 0. \end{cases} \qquad \Phi(A) := \begin{cases} A & \text{if } |A| \le 1, \\ \frac{A}{|A|} & \text{if } |A| > 1. \end{cases}

Here, we remark that the second equation of [\(3.1\)](#page-4-1) is equivalent to

$$
\left(\frac{\sigma_n - \sigma_{n-1}}{\Delta t} - \mathcal{E}(v_n), \sigma_n - \tau\right)_H \le (h_n, \sigma_n - \tau)_H \quad \text{for all } \tau \in K_n. \tag{3.2}
$$

See Theorem [A.4](#page-24-0) for the equivalence of [\(3.2\)](#page-4-2) and the second equation of [\(3.1\)](#page-4-1).

To solve [\(3.1\)](#page-4-1), it is necessary to use nonlinear problem-solving algorithms, such as the Newton–Raphson method or the semismooth Newton method, at each step to solve the nonlinear problem $[30, 4]$ $[30, 4]$. While it is possible to treat the third term of (3.1) as $(\sigma_{n-1}, \mathcal{E}(\varphi))_H$ explicitly, this leads to conditional stability and necessitates taking sufficiently small time steps.

3.2. Proposed scheme. We consider the following numerical scheme: Find $v_n \in V$ and $\sigma_n^*, \sigma_n \in H$ such that for all $\varphi \in V$

The first and second equations correspond to the discretization of the first and second equations of [\(1.3\)](#page-2-2), with the $-\partial I_K(\sigma)$ term removed. Since $\sigma_n^* \notin K_n$ in general, the third equation involves projecting σ_n^* onto the closed convex set K_n to obtain $\sigma_n \in$ K_n . This strategy is similar to the projection method used in numerical methods for incompressible viscous flow. In the projection method [\[9,](#page-21-22) [31\]](#page-22-1), the velocity is solved without imposing the incompressibility condition, and then projected onto a divergencefree space to meet the incompressibility condition. As a projection method-like approach for hypo-elastoplastic problems, there is [\[28\]](#page-21-23), but this also involves projecting onto a linear space, similar to the projection method.

4. Main results

Theorem 4.1. (i) There exists a constant $c_1 > 0$ independent of Δt such that for all $\Delta t \leq 1$,

In particular, $(\|\hat{v}_{\Delta t}\|_{H^1(V^*)})_{0<\Delta t<1}$, $(\|\bar{v}_{\Delta t}\|_{L^{\infty}(H)})_{0<\Delta t<1}$, $(\|\bar{v}_{\Delta t}\|_{L^2(V)})_{0<\Delta t<1}$, $(\|\bar{\sigma}_{\Delta t}^*\|_{L^{\infty}(H)})_{0<\Delta t<1}$, and $(\|\bar{\sigma}_{\Delta t}\|_{L^{\infty}(H)})_{0<\Delta t<1}$ are bounded and $\|\hat{v}_{\Delta t} - \bar{v}_{\Delta t}\|_{L^2(H)}$ and $\|\bar{\sigma}_{\Delta t} - \bar{\sigma}_{\Delta t}^{*}\|_{L^{2}(H)}$ converge to 0 as $\Delta t \to 0$.

(ii) There exists a constant $c_2 > 0$ independent of Δt such that for all $\Delta t \leq 1$, $\|\hat{\sigma}_{\Delta t}\|_{H^1(H)} \leq c_2(\|v_0\|_H + \|\sigma_0\|_H + \|f\|_{L^2(\mathbf{V}^*)} + \|p\|_{H^1(H)} + \|h\|_{L^2(H)} + \|g\|_{H^1(L^2(\Omega))}).$ In particular, $(\hat{\sigma}_{\Delta t})_{0 < \Delta t < 1}$ is bounded in $H^1(H)$.

Remark 4.2. If g is not in $H^1(L^2(\Omega))$ but in $C([0,T];L^2(\Omega))$, we can show that the sequence $(\hat{\sigma}_{\Delta t})_{0<\Delta t<1}$ is equicontinuous.

From the boundedness obtained in Theorem [4.1,](#page-5-1) we obtain that the sequences $(\hat{v}_{\Delta t})_{0<\Delta t<1}, (\overline{v}_{\Delta t})_{0<\Delta t<1}, (\overline{\sigma}_{\Delta t}^*)_{0<\Delta t<1}, (\overline{\sigma}_{\Delta t})_{0<\Delta t<1}$ have subsequences that converge weakly. Since the resulting limit (v, σ) is a solution to Problem [1.1,](#page-2-1) the following theorem can be established without assumptions $(A1)$, $(A2)$, and $(A3)$ of Theorem [2.2.](#page-4-3)

Theorem 4.3. For all $\nu > 0$, $f \in L^2(\mathbf{V}^*)$, $p \in H^1(H)$, $v_0 \in H$, $\sigma_0 \in K(0)$, $g \in$ $H^1(L^2(\Omega))$ with $g \geq 0$ a.e on Ω for all $t \in [0,T]$, there exists a unique solution $(v, \sigma) \in$ $(H^1(V^*)\cap L^2(V))\times H^1(H)$ to Problem [1.1.](#page-2-1)

Remark 4.4. If g is not in $H^1(L^2(\Omega))$ but in $C([0,T];L^2(\Omega))$, by Remark [4.2](#page-5-2) and $the Ascoli-Arzel\`a theorem, one shows existence (and uniqueness) of a weak solution$ $(v, \sigma) \in (H^1(\mathbf{V}^*) \cap L^2(\mathbf{V})) \times C([0, T]; H)$ to Problem [1.1](#page-2-1) in the sense of [\[1,](#page-20-0) Definition 2.2] using the same way as the proof of Theorem [4.3.](#page-6-1)

Furthermore, by assuming smoothness, one can show that the solutions to [\(3.3\)](#page-5-3) strongly converge to the solution to Problem [1.1.](#page-2-1)

Theorem 4.5. Under the assumption of Theorem [\(4.3\)](#page-6-1), if $v_0 \in V$ and $f \in L^2(H)$, then we have

\hat{\sigma}_{\Delta t} \to \sigma \quad strongly \ in \ L^{\infty}(H),

\hat{v}_{\Delta t} \to v \quad strongly \ in \ L^{\infty}(\mathbf{H}),

as $\Delta t \rightarrow 0$.

5. Proofs of main results

5.1. Preliminary result. We recall the Korn inequality and the discrete Gronwall inequality.

Lemma 5.1. [\[32,](#page-22-2) Lemma 5.4.18] There exists a constant $c_K > 0$ such that

where $C := \Delta t \sum_{k=0}^{N} \frac{\alpha_k}{1-\alpha_k}$ $\frac{\alpha_k}{1-\alpha_k\Delta t}$.

We prepare the following lemma, which is derived using the Ascoli–Arzelà theorem.

Lemma 5.3. Let X be a Banach space such that X^* is separable. If the sequence $(u_n)_{n\in\mathbb{N}}\subset C([0,T];X)$ satisfies the following two conditions:

(i) there exists a constant $c > 0$ such that for all $n \in \mathbb{N}$ and $t \in [0, T]$, $||u_n(t)||_X < c$,

(ii) (u_n) is equicontinuous, i.e., for all $t \in [0,T]$ and $\varepsilon > 0$, there exists $\delta > 0$ such that if $s \in [0,T]$ satisfies $|s-t| < \delta$, then $||u_n(s) - u_n(t)||_X < \varepsilon$ for all $n \in \mathbb{N}$,

then there exist a subsequence $(n_k)_{k\in\mathbb{N}}$ and $u \in C([0,T]; X_w)$ such that for all $t \in [0,T]$,

 $u_{n_k}(t) \rightarrow u(t)$ weakly in X

as $k \to \infty$.

Proof. Let $B \coloneqq \{v \in X : ||v||_X \le c\}$. There exists a metric $d : B \times B \to \mathbb{R}$, which induces the weak topology on X and satisfies $d(v, w) \leq ||v - w||_X$ for all $v, w \in B$ [\[7,](#page-21-25) Theorem 3.29]. Given the conditions (i) and (ii), the sequence $(u_n)_{n\in\mathbb{N}}$ belongs to $C([0,T]; (B, d))$ and is equicontinuous in the metric space (B, d) . Moreover, the metric space (B, d) is compact. By the Ascoli–Arzelà theorem [\[7,](#page-21-25) Theorem 4.25], there exist a subsequence $(n_k)_{k\in\mathbb{N}}\subset\mathbb{N}$ and $u\in C([0,T];(B,d))$ such that for all $t\in[0,T]$,

We show some properties of the function $\mathcal{P}_R, \Phi : \mathcal{S}_d \to \mathcal{S}_d$.

$$

= \left|\frac{\text{tr}\,A}{d}E_d\right|^2 + \left|R\Phi\left(\frac{A^D}{R}\right)\right|^2.

(ii) It holds that for all $R_1, R_2 \geq 0$ and $A \in \mathcal{S}_d$,

|\mathcal{P}_{R_1}(A) - \mathcal{P}_{R_2}(A)| = \left| R_1 \Phi\left(\frac{A^D}{R_1}\right) - R_2 \Phi\left(\frac{A^D}{R_2}\right) \right| \le |R_1 - R_2|.

(iii) If $A \in \mathcal{S}_d$ and $R \geq 0$ satisfy the condition that $|A^D| \leq R$, it follows that $\mathcal{P}_R(A) = A$ and for all $B \in \mathcal{S}_d$,

\leq \frac{\Delta t}{2} \sum_{n=1}^m ||\sigma_n^* + p_n||_H^2 + c_1 \Delta t \sum_{n=1}^m (||f_n||_{V^*}^2 + ||p_n||_H^2 + ||\frac{p_n - p_{n-1}}{\Delta t}||_H^2 + ||h_n||_H^2),

5.3. Existence and uniqueness of solution to Problem [1.1.](#page-2-1)

Proof of Theorem [4.3.](#page-6-1) (Existence) According to Theorem [4.1,](#page-5-1) it can be shown that there exist a sequence $(\Delta t_k)_{k \in \mathbb{N}}$ and two functions $v \in H^1(\mathbf{V}^*) \cap L^2(\mathbf{V})$ (in particular, $v \in C([0, T]; H))$ and $\sigma \in H^1(L^2(\Omega))$ such that $\Delta t_k \to 0$ and for all $t \in [0, T]$

It should be noted that $(\hat{v}_{\Delta t_k})_{k \in \mathbb{N}}$ and $(\bar{v}_{\Delta t_k})_{k \in \mathbb{N}}$ possess a common limit function v and $(\bar{\sigma}_{\Delta t_k})_{k \in \mathbb{N}}$ and $(\bar{\sigma}_{\Delta t_k})_{k \in \mathbb{N}}$ possess a common limit function σ . Indeed, the weak convergences [\(5.6\)](#page-11-0), [\(5.7\)](#page-11-1), [\(5.9\)](#page-11-2), [\(5.10\)](#page-11-3), [\(5.11\)](#page-11-4), [\(5.12\)](#page-11-5), and [\(5.13\)](#page-11-6) immediately follows by Theorem [4.1](#page-5-1) and Lemma [5.3.](#page-6-2) If we define $\hat{v}_{\Delta t}^{\circ} \in C([0, T]; V)$ by

then we obtain that $(\hat{v}_{\Delta t}^{\circ})_{0<\Delta t<1}$ is bounded in $H^1(\bm{V}^*)$ and $L^{\infty}(\bm{H})$, and hence,

Next, we demonstrate that the limit functions (v, σ) satisfy (2.1) and $\sigma(t) \in K(t)$ for all $t \in [0, T]$.

By the Riesz-Fischer theorem, $\hat{g}_{\Delta t}(t) \to g(t)$ a.e. on Ω for all $t \in [0, T]$. For fixed $k \in \mathbb{N}$ and $t \in [0, T]$, since

6. Conclusion

For Problem [1.1](#page-2-1) of a perfect plasticity model with a time-dependent yield surface, we proposed a new numerical scheme [\(3.3\)](#page-5-3) and proved its stability in Theorem [4.1.](#page-5-1) Establishing the stability, without the need for continuity and a positive lower bound of the threshold function, allowed us to demonstrate the existence of an exact solution under weaker assumptions than those in Theorem [2.2,](#page-4-3) namely without assumptions (A1), (A2), and (A3) (Theorem [4.3\)](#page-6-1). Moreover, Theorem [4.5](#page-6-3) proved that solutions obtained through this scheme strongly converge to the exact solutions under the specified norms.

In this paper, we exclusively addressed the case where K represents the von Mises model. For future work, it is necessary to investigate whether the proposed scheme can be adapted for cases where K is a general convex set or applied to models such as the Drucker–Prager model [\[30\]](#page-21-21). While this paper focused on time discretization, exploring fully discretized cases, which involve both time and spatial discretization, is an important next step in numerical computations. Specifically, when applying the finite element method, selecting the appropriate finite element spaces for v and σ becomes a pivotal step. Additionally, conducting numerical calculations and comparing them with existing methods and experimental results is essential. Addressing convergence in numerical analysis is crucial. This first requires discussing the regularity of the exact solution, which is currently an open problem.

APPENDIX A. EXPLICIT REPRESENTATION OF $K(t)$

For the case of $d = 3$, it is well known in engineering that the von Mises yield surface becomes a super-cylinder. In this appendix, we discuss the general case for $2 \le d \in \mathbb{N}$.

We introduce the characterization of the closed set $K_R \subset \mathbb{R}^{d \times d}$ defined by $K_R \coloneqq$ $\{\sigma \in \mathbb{R}^{d \times d} : |\sigma^D| \leq R\}$. To achieve this, we define linear, distance-preserving maps Ψ_1 and Ψ_2 that transform $\mathbb R$ and $\mathbb R^{d \times d-1}$ into appropriate subspaces. These maps allow us to decompose elements in K_R and show the uniqueness of this decomposition. Finally, we prove that for all $F \in \mathbb{R}^{d \times d}$, the mapping $K_R \ni \sigma \mapsto |\sigma - F|^2 \in \mathbb{R}$ achieves its minimum on K_R at a specific point, facilitating further analysis of yield conditions. Lastly, we show that [\(3.2\)](#page-4-2) can be explicitly calculated using \mathcal{P}_{g_n} in the form of the second equation of [\(3.1\)](#page-4-1).

First of all, we prepare Assumption [A.1.](#page-22-3)

Assumption A.1. Maps $\Psi_1 : \mathbb{R} \to \mathbb{R}^{d \times d}$ and $\Psi_2 : \mathbb{R}^{d \times d-1} \to \mathbb{R}^{d \times d}$ satisfy the following conditions.

- (i) Ψ_1 and Ψ_2 are linear.
- (ii) Ψ_1 and Ψ_2 are distance preserving maps, i.e., Ψ_1 and Ψ_2 satisfy that

for all $\lambda \in \mathbb{R}$ and $x \in \mathbb{R}^{d \times d-1}$.

(iii) $\Psi_1(\mathbb{R}) = E_d \mathbb{R} (= {\mu E_d : \mu \in \mathbb{R}})$ and $\Psi_2(\mathbb{R}^{d \times d-1}) = {A \in \mathbb{R}^{d \times d} : \text{tr } A = 0}.$

For example, if we define $\Psi_1 : \mathbb{R} \to \mathbb{R}^{d \times d}$ and $\Psi_2 : \mathbb{R}^{d \times d-1} \to \mathbb{R}^{d \times d}$ as follows; for $\lambda \in \mathbb{R}$ and $x = ((a_i)_{i=1,\dots,d-1}, (b_{ij})_{i,j=1,\dots,d}$ with $i \neq j) \in \mathbb{R}^{d \times d}$,

\Psi_1(\lambda) = \frac{\lambda}{\sqrt{d}} E_d, \quad \Psi_2(x) = \sum_{i=1}^{d-1} a_i e_i + \sum_{i \neq j} b_{ij} E_{ij},
$$

where $e_i \in \mathbb{R}^{d \times d}$ $(i = 1, \ldots, d - 1)$ is defined by

$$
e_i := \frac{1}{\sqrt{i(i+1)}} \operatorname{diag}(\underbrace{1, \dots, 1}_{i}, -i, 0, \dots, 0),
$$

and E_{ij} $(i, j = 1, ..., d)$ is defined as the $d \times d$ matrix where the (i, j) -entry is 1 and all other entries are 0, then Ψ_1 and Ψ_2 satisfy Assumption [A.1.](#page-22-3)

Proposition A.2. We assume that the maps $\Psi_1 : \mathbb{R} \to \mathbb{R}^{d \times d}$ and $\Psi_2 : \mathbb{R}^{d \times d-1} \to \mathbb{R}^{d \times d}$ satisfy Assumption [A.1.](#page-22-3) Let $R > 0$ and let $K_R := \{ \sigma \in \mathbb{R}^{d \times d} : |\sigma^D| \leq R \}$. Then we have that

$$
K_R = \{ \Psi_1(\lambda) + \Psi_2(x) : \lambda \in \mathbb{R}, x \in \mathbb{R}^{d \times d - 1}, |x| \le R \}. \tag{A.1}
$$

Furthermore, for all $\sigma \in K_R$, there exist unique $\lambda \in \mathbb{R}$ and $x \in \mathbb{R}^{d \times d-1}$ such that $\sigma = \Psi_1(\lambda) + \Psi_2(x).$

Proof. First, we show that

$$
R^{d \times d} = \Psi_1(\mathbb{R}) \oplus \Psi_2(\mathbb{R}^{d \times d-1}) = \{\Psi_1(\lambda) + \Psi_2(x) : \lambda \in \mathbb{R}, x \in \mathbb{R}^{d \times d-1}\}.
$$
 (A.2)

The map \mathcal{P}_0 : $\mathbb{R}^{d \times d} \ni A \mapsto (\text{tr } A/d)E_d \in \mathbb{R}^{d \times d}$ is a linear map and satisfies that $\mathcal{P}_0^2 = \mathcal{P}_0$. Hence, it holds that

$$
\mathbb{R}^{d\times d}=\mathrm{Im}(\mathcal{P}_0)\oplus \mathrm{Ker}(\mathcal{P}_0),
$$

where Im(\mathcal{P}_0) and Ker(\mathcal{P}_0) is the image and the kernel of \mathcal{P}_0 , respectively. Since it holds that

$$
\operatorname{Im}(\mathcal{P}_0) = E_d \mathbb{R} = \Psi_1(\mathbb{R}), \quad \operatorname{Ker}(\mathcal{P}_0) = \{ A \in \mathbb{R}^{d \times d} : \operatorname{tr} A = 0 \} = \Psi_2(\mathbb{R}^{d \times d-1}),
$$

we obtain [\(A.2\)](#page-23-0).

We have that

$$
K_R = (\text{Im}(\mathcal{P}_0) \cap K_R) \oplus (\text{Ker}(\mathcal{P}_0) \cap K_R),
$$

and, by Assumption [A.1](#page-22-3) (ii) and (iii),

$$
(\text{Im}(\mathcal{P}_0) \cap K_R) = E_d \mathbb{R} = \Psi_1(\mathbb{R}),
$$

\n
$$
(\text{Ker}(\mathcal{P}_0) \cap K_R) = \{ A \in \mathbb{R}^{d \times d} : \text{tr } A = 0, |A^D| \le R \} = \{ A \in \mathbb{R}^{d \times d} : \text{tr } A = 0, |A| \le R \}
$$

\n
$$
= \{ \Psi_2(x) : x \in \mathbb{R}^{d \times d-1}, |x| < R \},
$$

which implies that

$$
K_R = \Psi_1(\mathbb{R}) \oplus \{ \Psi_2(x) : x \in \mathbb{R}^{d \times d-1}, |x| < R \}
$$
\n
$$
= \{ \Psi_1(\lambda) + \Psi_2(x) : \lambda \in \mathbb{R}, x \in \mathbb{R}^{d \times d-1}, |x| \le R \}.
$$

Lemma A.3. We assume that maps $\Psi_1 : \mathbb{R} \to \mathbb{R}^{d \times d}$ and $\Psi_2 : \mathbb{R}^{d \times d-1} \to \mathbb{R}^{d \times d}$ satisfy Assumption [A.1.](#page-22-3) For $R > 0$ and $F \in \mathbb{R}^{d \times d}$, the mapping $K_R \ni \sigma \mapsto |\sigma - F|^2 \in \mathbb{R}$ achieves its minimum at $\sigma = \mathcal{P}_R(F)$.

Proof. First, we consider the case where $F \in K_R$. The mapping $\mathbb{R}^{3\times3} \ni \sigma \mapsto |\sigma - F|^2 \in$ R achieves its minimum value of 0 at $\sigma = F$. Hence, if $F \in K_R$, then the mapping $K_R \ni \sigma \mapsto |\sigma - F|^2 \in \mathbb{R}$ achieves its minimum at $\sigma = F$.

Next, we consider the case where $F \notin K_R$. By Proposition [A.2,](#page-23-1) for all $\tau \in K_R$, there exist unique $\mu \in \mathbb{R}$ and $y \in \mathbb{R}^{d \times d-1}$ such that $\tau = \Psi_1(\mu) + \Psi_2(y)$ and $|y| \le R$.

$$
|\tau - F|^2 = \left| \Psi_1(\mu) + \Psi_2(y) - \frac{\text{tr } F}{d} E_d - F^D \right|^2
$$

=
$$
\left| \Psi_1(\mu) - \frac{\text{tr } F}{d} E_d \right|^2 + \left| \Psi_2(y) - F^D \right|^2,
$$

where we have used $\Psi_1(\mu) - (\text{tr } F/d)E_d \in E_d \mathbb{R}$ and $\Psi_2(y) - F^D \in \{A \in \mathbb{R}^{d \times d} : \text{tr } A = 0\}.$ Here, $|\Psi_1(\mu) - (\text{tr } F/d)E_d|^2$ depends on only μ and $|\Psi_2(y) - F^D|^2$ depends on only y.

By Assumption [A.1](#page-22-3) (iii), there exist $\lambda \in \mathbb{R}$ and $z \in \mathbb{R}^{d \times d-1}$ such that $\Psi_1(\lambda) =$ $(\text{tr } F/d)E_d$ and $\Psi_2(z) = F^D$. The mapping $\mathbb{R} \ni \mu \mapsto |\Psi_1(\mu) - (\text{tr } F/d)E_d|^2 \in \mathbb{R}$ achieves its minimum at $\mu = \lambda$. By Assumption [A.1](#page-22-3) (i), the mapping $\{y \in \mathbb{R}^{d \times d-1}$. $|y| \le R$ \Rightarrow $y \mapsto |\Psi_2(y) - F^D|^2 = |\Psi_2(y) - \Psi_2(z)|^2 = |y - z|^2$ achieves its minimum at $y = (R/|z|)z.$

Hence, if $F \notin K_R$, then the mapping $K_R \ni \sigma \mapsto |\sigma - F|^2 \in \mathbb{R}$ achieves its minimum at

$$
\sigma = \Psi_1(\lambda) + \Psi_2\left(\frac{R}{|z|}z\right) = \frac{\operatorname{tr} F}{d}E_d + \frac{R}{|\Psi_2(z)|}\Psi_2(z) = \frac{\operatorname{tr} F}{d}E_d + \frac{R}{|F^D|}F^D.
$$

Therefore, the mapping $K_R \ni \sigma \mapsto |\sigma - F|^2 \in \mathbb{R}$ achieves its minimum at

$$
\sigma = \begin{cases} F & \text{if } |F^D| \le R \\ \frac{\text{tr } F}{d} E_d + \frac{R}{|F^D|} F^D & \text{if } |F^D| > R \end{cases}
$$

i.e. $\sigma = \mathcal{P}_R(F)$

From Lemma [A.3,](#page-23-2) one can obtain the following result.

Theorem A.4. Let $\Delta t > 0$, σ_a , σ_b , $h, p \in H$, $v \in V$, and $g \in L^2(\Omega)$. It holds that

$$
\frac{\sigma_b - \sigma_a}{\Delta t} \in \mathcal{E}(v) + h - \partial I_K(\sigma_b) \Leftrightarrow \sigma_b + p = \mathcal{P}_g(\sigma_a + \Delta t(\mathcal{E}(v) + h) + p),
$$

where $K \coloneqq \tilde{K} - p$ and

$$
\tilde{K} \coloneqq \left\{ \tau \in H : |\tau^D| \le g \text{ a.e. in } \Omega \right\}.
$$

Proof. We put $F \coloneqq \sigma_a + \Delta t(\mathcal{E}(v) + h)$. By the definition of subdifferential, it holds that

$$
\frac{\sigma_b - \sigma_a}{\Delta t} \in \mathcal{E}(v) + h - \partial I_K(\sigma_b)
$$

\n
$$
\Leftrightarrow I_K(\tau) - I_K(\sigma_b) \ge \left(\mathcal{E}(v) + h - \frac{\sigma_b - \sigma_a}{\Delta t}, \tau - \sigma_b\right) \text{ for all } \tau \in H
$$

\n
$$
\Leftrightarrow \sigma_b \in K \text{ and } 0 \ge (F - \sigma_b, \tau - \sigma_b) \text{ for all } \tau \in K
$$

\n
$$
\Leftrightarrow \sigma_b \in K \text{ and } \|\sigma_b - F\|_H \le \|\tau - F\|_H \text{ for all } \tau \in K.
$$

Since $\tau \in K = \tilde{K} - p \Leftrightarrow \tau + p \in \tilde{K}$, we have

$$
\frac{\sigma_b - \sigma_a}{\Delta t} \in \mathcal{E}(v) + h - \partial I_K(\sigma_b)
$$

$$
\Leftrightarrow \sigma_b \in K \text{ and } \|\sigma_b - (F + p)\|_H \le \|\tau - (F + p)\|_H \text{ for all } \tau \in \tilde{K}.
$$

Therefore, by Lemma [A.3,](#page-23-2)

$$
\frac{\sigma_b - \sigma_a}{\Delta t} \in \mathcal{E}(v) + h - \partial I_K(\sigma_b) \Leftrightarrow \sigma_b = \mathcal{P}_g(F + p) = \mathcal{P}_g(\sigma_a + \Delta t(\mathcal{E}(v) + h) + p).
$$
