# NUMERICAL APPROXIMATION FOR VARIABLE-EXPONENT FRACTIONAL DIFFUSION-WAVE EQUATION

#### Abstract

This work considers the variable-exponent fractional diffusion-wave equation, which describes, e.g. the propagation of mechanical diffusive waves in viscoelastic media with varying material properties. Rigorous mathematical and numerical analysis for this model is not available in the literature, partly because the variable-exponent Abel kernel may not be positive definite or monotonic. We overcome these difficulties to design two numerical schemes and derive their stability and error estimate based on the proved solution regularity, with $\alpha(0)$-order and second-order accuracy in time, respectively. Numerical experiments are presented to substantiate the theoretical findings.


Key words. fractional, variable exponent, well-posedness and regularity, error estimate, second order

1. Introduction. We consider the fractional diffusion-wave model of variable exponent $1<\alpha(t)<2$

equipped with initial and boundary conditions

Here $\Omega \subset \mathbb{R}^{d}$ is a simply-connected bounded domain with the piecewise smooth boundary $\partial \Omega$ with convex corners, $\boldsymbol{x}:=\left(x_{1}, \cdots, x_{d}\right)$ with $1 \leq d \leq 3$ denotes the spatial variables, $f$ and $u_{0}$ refer to the source term and the initial value, respectively, and the fractional derivative of order $1<\alpha(t)<2$ is defined by the symbol $*$ of convolution [12]

In general, the $-\Delta u$ in (1.1) could be extended to $-\nabla(K(\boldsymbol{x}) \nabla u)+c(\boldsymbol{x}) u$ for the symmetric, positive definite diffusivity tensor $K(\boldsymbol{x})$ and the non-negative reaction coefficient $c(\boldsymbol{x})$ without affecting the analysis, and we use $-\Delta u$ for simplicity.

For the constant-exponent case, that is, $\alpha(t) \equiv \alpha$ for some $1<\alpha<2$, model (1.1) (1.2) has been used in various fields. For instance, it is pointed out in [15, (16) that model (1.1)-(1.2) with $\alpha(t) \equiv \alpha$ governs the propagation of mechanical diffusive waves in viscoelastic media which exhibit a power-law creep. Thus, there exist significant progresses on the mathematical and numerical studies of model (1.1)-(1.2) with $\alpha(t) \equiv$ $\alpha$, see e.g. [2, [5, 10, 18, [25]. The variable exponent could accommodate the change of the media properties [3] [22] such that the variable-exponent model (1.1)-(1.2) may be more practical.

[^0]There exist sophisticated numerical studies on variable-exponent time/spacefractional diffusion problems [19, 24, [26, 29, while rigorous analysis for diffusionwave type equations such as model (1.1)-(1.2) is not available in the literature. For variable-exponent fractional diffusion-wave models containing an additional temporal leading term $\partial_{t}^{2} u$, the mathematical analysis and a first-order-in-time scheme are recently proposed in 28, and a second-order finite difference scheme is analyzed in 3]. For model (1.1)-(1.2) where ${ }^{c} \partial_{t}^{\alpha(t)} u$ serves as the leading term, the existing methods do not apply directly. The inherent reason is that the variable-exponent Abel kernel $k(t)$ could not be analytically treated by, e.g. the integral transform, and may not be positive definite or monotonic. Indeed, it is commented in 9 that the analysis of variable-exponent subdiffusion remains an open problem, and so does the variableexponent fractional diffusion-wave equation.

Recently, a convolution method is developed in [27], which converts the variableexponent subdiffusion to more feasible formulations such that the corresponding analysis becomes tractable. We employ this idea to convert model (1.1)-(1.2) to a transformed equation, based on which we address its well-posedness and solution regularity. For numerical analysis, a main difficulty is that a convolution term in the transformed model involves a complicated convolution kernel that may not be positive definite or monotonic, which restricts the choice of quadrature rules in constructing high-order schemes and introduces non-monotonic or even variable-sign coefficients that deteriorates the structures of numerical schemes. In [27], an exponential factor is introduced to resolve this issue in Volterra integro-differential equations, while for models involving temporal derivatives, this method does not work.

To circumvent the difficulty, we approximate this intricate term with the help of piecewise linear interpolation. Then we design suitable combinations of different discretization methods to approximate multiple terms in the transformed equation such that the $\alpha(0)$-order and second-order accuracy in time could be achieved and proved under a very weak constraint on $\alpha(t)$. Numerical experiments indicate that both methods exhibit the desired accuracy, even the imposed constraint on $\alpha(t)$ is not satisfied.

The rest of the work is organized as follows: In Section 2 we introduce preliminary results and the mathematical analysis of the proposed model. In Sections 3-4, the $\alpha(0)$-order and second-order schemes are developed and analyzed, respectively, and their accuracy is substantiated in the last section.

## 2. Mathematical analysis.

2.1. Notations. For the sake of clear presentation, we introduce the following spaces and notations. Let $L^{p}(\Omega)$ with $1 \leq p \leq \infty$ be the Banach space of $p$ th power Lebesgue integrable functions on $\Omega$. Denote the inner product of $L^{2}(\Omega)$ as $(\cdot, \cdot)$. For a positive integer $m$, let $W^{m, p}(\Omega)$ be the Sobolev space of $L^{p}$ functions with $m$ th weakly derivatives in $L^{p}(\Omega)$ (similarly defined with $\Omega$ replaced by an interval $\mathcal{I}$ ). Let $H^{m}(\Omega):=W^{m, 2}(\Omega)$ and $H_{0}^{m}(\Omega)$ be its subspace with the zero boundary condition up to order $m-1$. For a non-integer $s \geq 0, H^{s}(\Omega)$ is defined via interpolation [1]. Let $\left\{\lambda_{i}, \phi_{i}\right\}_{i=1}^{\infty}$ be eigen-pairs of the problem $-\Delta \phi_{i}=\lambda_{i} \phi_{i}$ with the zero boundary condition. We introduce the Sobolev space $\check{H}^{s}(\Omega)$ for $s \geq 0$ by

which is a subspace of $H^{s}(\Omega)$ satisfying $\check{H}^{0}(\Omega)=L^{2}(\Omega)$ and $\check{H}^{2}(\Omega)=H^{2}(\Omega) \cap H_{0}^{1}(\Omega)$ 23]. For a Banach space $\mathcal{X}$, let $W^{m, p}(0, T ; \mathcal{X})$ be the space of functions in $W^{m, p}(0, T)$ with respect to $\|\cdot\|_{\mathcal{X}}$. All spaces are equipped with standard norms [1, 4].

We use $Q$ to denote a generic positive constant that may assume different values at different occurrences. We use $\|\cdot\|$ to denote the $L^{2}$ norm of functions or operators in $L^{2}(\Omega)$, set $L^{p}(\mathcal{X})$ for $L^{p}(0, T ; \mathcal{X})$ for brevity, and drop the notation $\Omega$ in the spaces and norms if no confusion occurs. For instance, $L^{2}\left(L^{2}\right)$ implies $L^{2}\left(0, T ; L^{2}(\Omega)\right)$. Furthermore, we will drop the space variable $\boldsymbol{x}$ in functions, e.g. we denote $q(\boldsymbol{x}, t)$ as $q(t)$, when no confusion occurs.

For $\frac{\pi}{2}<\theta<\min \left\{\pi, \frac{\pi}{\alpha_{0}}\right\}$ and $\delta>0$, let $\Gamma_{\theta}$ be the contour in the complex plane defined by

For any $w \in L_{l o c}^{1}(\mathcal{I})$, the Laplace transform $\mathcal{L}$ of its extension $\tilde{w}(t)$ to zero outside $\mathcal{I}$ and the corresponding inverse transform $\mathcal{L}^{-1}$ are denoted by $\mathcal{L} w(z):=\int_{0}^{\infty} \tilde{w}(t) e^{-t z} d t$ and $\mathcal{L}^{-1}(\mathcal{L} w(z)):=\frac{1}{2 \pi \mathrm{i}} \int_{\Gamma_{\theta}} e^{t z} \mathcal{L} w(z) d z=w(t)$. The following inequalities hold for $0<\mu<1$ or $\mu=\alpha_{0}$ and $Q$ independent from $z$ [7, 13]

and we have $\mathcal{L}\left(\partial_{t}^{\mu} w\right)=z^{\mu} \mathcal{L} w-\left(I_{t}^{1-\mu} w\right)(0)$, see [6].
Finally we introduce the concept of positive definiteness. A kernel $\beta(t)$ is said to be positive definite if $\int_{0}^{\bar{t}} q(t)(\beta * q)(t) d t \geq 0$ for any $q \in C[0, \bar{t}]$ and for each $0<\bar{t} \leq T$, and $\beta_{\mu}(t):=\frac{t^{\mu-1}}{\Gamma(\mu)}$ with $0<\mu<1$ is positive definite, see e.g. [20].

Throughout this work, we consider smooth $\alpha(t)$. Specifically, we assume $\alpha(t)$ is three times differentiable with $\left|\alpha^{\prime}(t)\right|+\left|\alpha^{\prime \prime}(t)\right|+\left|\alpha^{\prime \prime \prime}(t)\right| \leq L$ for some $L>0$. We also denote $\alpha_{0}=\alpha(0), I_{t}^{\mu} w:=\beta_{\mu} * w$ and $\partial_{t}^{\mu} w=\partial_{t}\left(\beta_{1-\mu} * w\right)$.
2.2. Well-posedness and regularity. We apply the convolution method proposed in [27] to convert model (1.1) to a more feasible formulation. For this purpose, we apply the variable substitution $z=s / t$ to perform calculations as follows

where $g(t)$ is called a generalized identity function. It is shown in 27] that $g(0)=1$, $|g| \leq Q$ for $t \in[0, T]$ and $\left|g^{\prime}\right| \leq Q(|\ln t|+1)$. Then we calculate the convolution of (1.1) and $\beta_{\alpha_{0}-1}$ as

We invoke (2.2) to obtain

An application of the integration by parts leads to the transformed model

equipped with the initial and boundary conditions (1.2).
We take the Laplace transform of (2.5) to obtain $z \mathcal{L} u-u_{0}-z^{1-\alpha_{0}} \Delta \mathcal{L} u=\mathcal{L}\left(p_{u}+\right.$ $\left.g(t) \bar{u}_{0}\right)$, that is, $\mathcal{L} u=z^{\alpha_{0}-1}\left(z^{\alpha_{0}}-\Delta\right)^{-1}\left(u_{0}+\mathcal{L}\left(p_{u}+g(t) \bar{u}_{0}\right)\right)$. We take the inverse Laplace transform to obtain

where the operator $F(\cdot)$ is defined as $F(t) w:=\frac{1}{2 \pi \mathrm{i}} \int_{\Gamma_{\theta}} e^{t z} z^{\alpha_{0}-1}\left(z^{\alpha_{0}}-\Delta\right)^{-1} w d z$.
We show the well-posedness of model (1.1)-(1.2) in the following theorem, the proof of which can be found in the Appendix.

TheOrem 2.1. Suppose $f \in W^{1,1}\left(L^{2}\right)$ and $u_{0}, \bar{u}_{0} \in \check{H}^{2}$, then model (1.1)-(1.2) admits a unique solution in $W^{2, p}\left(L^{2}\right) \cap L^{p}\left(\check{H}^{2}\right)$ for $1<p<\frac{1}{2-\alpha_{0}}$ and

From the derivations (2.3)-(2.5) we find that a solution in $W^{2, p}\left(L^{2}\right) \cap L^{p}\left(\check{H}^{2}\right)$ to (1.1)-(1.2) is also a solution to (2.5)-(1.2). Conversely, it is shown by the derivations around (5.8) that a solution in $W^{2, p}\left(L^{2}\right) \cap L^{p}\left(\check{H}^{2}\right)$ to (2.5)-(1.2) is also a solution to (1.1)-(1.2). Thus, the models (2.5)-(1.2) and (1.1)-(1.2) are indeed equivalent and it suffices to focus the attention on (2.5)-(1.2).

REMARK 2.1. Under suitable smoothness assumptions on the data, one could follow [27, Theorems 3 and 4] to prove the following regularity results for $n=1,2$ and $m=0,1$

We omit the proof of the above results due to the similarity to [27, Theorems 3 and $4]$ and focus the attention on the numerical approximation.
3. An $\alpha_{0}$-order scheme. From this section we turn the attention to the numerical approximation. As mentioned at the end of the last section, it suffices to consider the numerical approximation of (2.5)-(1.2). If we denote $\bar{\alpha}=\alpha_{0}-1 \in(0,1)$, (2.5) could be rewritten as

where $\bar{f}(t)=\int_{0}^{t} \beta_{\bar{\alpha}}(t-s) f(s) d s+g(t) \bar{u}_{0}$. If we further define $\tilde{u}(t)=u(t)-u_{0}$, equation (3.1) becomes

In this section, we propose and analyze an $\alpha_{0}$-order-in-time scheme for problem (3.2)-(3.3).
3.1. A weak constraint on $\alpha(t)$. The numerical analysis in the current and the next sections depends on an additional constraint on $\alpha(t)$ :

The reason of imposing this condition is to improve the properties of the generalized identity function $g$, cf. Lemma 3.1, to facilitate the numerical analysis. It is worth mentioning that this is a very weak constraint since for any smooth $\alpha(t)$, one could find a sequence of smooth functions $\left\{\alpha_{\sigma}(t)\right\}_{\sigma>0}$ satisfying $\alpha_{\sigma}^{\prime}(0)=\alpha_{\sigma}^{\prime \prime}(0)=0$ for any $\sigma>0$ such that $\max _{t \in[0, T]}\left|\alpha(t)-\alpha_{\sigma}(t)\right| \rightarrow 0$ as $\sigma \rightarrow 0$. Consequently, one could replace the smooth $\alpha(t)$ in the model by an approximate function $\tilde{\alpha}(t)$ (satisfying $\tilde{\alpha}^{\prime}(0)=\tilde{\alpha}^{\prime \prime}(0)=0$ ) whose error could be arbitrarily small such that the constraint of the condition (3.4) on $\alpha(t)$ could be arbitrarily weak.

To prove this claim, we construct $\alpha_{\sigma}(t)$ by setting $\alpha_{\sigma}(t)=\alpha_{0}$ on $t \in[0, \sigma]$, $\alpha_{\sigma}(t)=\alpha(t)$ on $t \in[2 \sigma, T]$ and $\alpha_{\sigma}(t)=\alpha_{s}(t)$ for $t \in[\sigma, 2 \sigma]$ for some smooth function $1<\alpha_{s}(t)<2$ satisfying

\alpha_{s}^{\prime,-}(2 \sigma)=\alpha^{\prime,+}(2 \sigma), \quad \alpha_{s}^{\prime \prime,-}(2 \sigma)=\alpha^{\prime \prime,+}(2 \sigma), \quad \alpha_{s}^{\prime \prime \prime},-(2 \sigma)=\alpha^{\prime \prime \prime},+(2 \sigma) \tag{3.6}

where - and + imply the left-hand and right-hand derivatives, respectively. By this construction, $\alpha_{\sigma}(t)$ is a three times continuously differentiable function and satisfies $\alpha_{\sigma}^{\prime}(0)=\alpha_{\sigma}^{\prime \prime}(0)=0$ and

By $\alpha(t)-\alpha_{0}=\alpha^{\prime}(\xi) t$ we have $\left|\alpha(t)-\alpha_{0}\right| \leq L t$, while $\alpha(2 \sigma)=\alpha_{s}(2 \sigma)$ implies

Combine the above estimates to get $\max _{t \in[0, T]}\left|\alpha(t)-\alpha_{\sigma}(t)\right| \leq Q \sigma \rightarrow 0^{+}$as $\sigma \rightarrow 0^{+}$.
With the condition (3.4), we analyze the properties of $g(t)$.
Lemma 3.1. Under the condition (3.4), $\left|g^{(j)}(t)\right| \leq Q$ for $t \in[0, T]$ and $j=1,2$ where $g(t)$ is given by (2.2).

Proof. From (2.2) it is clear that it suffices to show $\left|B^{(j)}(t)\right| \leq Q$ where $B(t)=$ $(t z)^{\alpha(0)-\alpha(t z)}$. If $\alpha^{\prime}(0)=0$, the Taylor expansion gives $B(t)=e^{-\int_{0}^{t z}(t z-s) \alpha^{\prime \prime}(s) d s \ln (t z)}$ such that we have for $\bar{p}=t z$

& =\left|-B(t) z\left[\ln (\bar{p}) \int_{0}^{\bar{p}} \alpha^{\prime \prime}(s) d s+\frac{1}{\bar{p}} \int_{0}^{\bar{p}}(\bar{p}-s) \alpha^{\prime \prime}(s) d s\right]\right| \leq Q(|\bar{p} \ln \bar{p}|+1) \leq Q
\end{aligned}

The estimate of $B^{\prime \prime}$ could be obtained similarly based on $\left|\ln (\bar{p}) \alpha^{\prime \prime}(\bar{p})\right| \leq Q$ derived from $\alpha^{\prime \prime}(0)=0$ and $\left|\alpha^{\prime \prime \prime}\right| \leq L$. $\square$

3.3. Analysis of semi-discrete scheme. We first establish the stability of the semi-discrete scheme.

4. A second-order scheme. We propose and analyze a second-order-in-time scheme for problem (3.2)-(3.3).

\tau \sum_{n=1}^{m}\left\|\left(R_{4}\right)^{n}\right\| \leq Q\left[\tau \int_{0}^{t_{1 / 2}} t^{\alpha_{0}-1} d t+\tau^{2} \int_{t_{1 / 2}}^{t_{1}} t^{\alpha_{0}-2} d t+\tau^{2} \sum_{n=2}^{m} \int_{t_{n-1}}^{t_{n}} t^{\alpha_{0}-2} d t\right] \leq Q \tau^{2}
$$

To bound $\left(R_{5}\right)^{n}$, define

Then, following from [18, Lemma 3.2 and Eq. (3.19)], we have

We finally invoke the above estimates in (4.12) and apply the discrete Grönwall's lemma to complete the proof.
4.3. Analysis of fully-discrete scheme. Based on the notations in Section 3.4, the weak formulation of (4.6) reads for any $\chi_{3} \in H_{0}^{1}(\Omega)$

and the fully-discrete numerical scheme aims to find $\widetilde{U}_{h}^{n} \in S_{h}$ such that $\widetilde{U}_{h}^{0}=0$ and

Then, the fully-discrete numerical approximation $U_{h}^{n}$ to (3.1) is given by (3.38) with $\widetilde{U}_{h}^{n}$ defined by (4.15).

Similar to the proof of Theorem4.1, we could derive the following stability result

We choose $\chi_{3}=\tau \widetilde{\xi}^{1}$ and $\chi_{3}=\tau \widetilde{\xi}^{n-1 / 2}$ with $2 \leq n \leq m$ in (4.16), respectively, and sum the resulting equations from 1 to $m$ to get

& \quad+\tau\left(I_{\bar{\alpha}}^{1 / 2}(\nabla \widetilde{\xi}), \nabla \widetilde{\xi}^{1}\right)+\tau \sum_{n=2}^{m}\left(I_{\bar{\alpha}}^{n-1 / 2}(\nabla \widetilde{\xi}), \nabla \widetilde{\xi}^{n-1 / 2}\right) \\
& \quad=\tau\left(\left(R_{*}\right)^{1}, \widetilde{\xi}^{1}\right)+\tau \sum_{n=2}^{m}\left(\left(R_{*}\right)^{n}, \widetilde{\xi}^{n-1 / 2}\right)+\tau\left(\delta_{t} \widetilde{\eta}^{1}, \widetilde{\xi}^{1}\right)+\tau \sum_{n=2}^{m}\left(\delta_{t} \widetilde{\eta}^{n}, \widetilde{\xi}^{n-1 / 2}\right) \\
& \quad+w_{0}\left(\widetilde{\eta}^{\frac{1}{2}}, \widetilde{\xi}^{1}\right)+\sum_{n=2}^{m}\left[w_{0}\left(\widetilde{\eta}^{n-\frac{1}{2}}, \widetilde{\xi}^{n-1 / 2}\right)-\sum_{k=1}^{n-1}\left(w_{k-1}-w_{k}\right)\left(\widetilde{\eta}^{n-k-\frac{1}{2}}, \widetilde{\xi}^{n-1 / 2}\right)\right]

Invoking (4.18)-(4.19) in (4.17) and using the discrete Gronwall's lemma we have $\left\|\widetilde{\xi}^{m}\right\| \leq Q\left(h^{2}+\tau^{2}\right)$, which, together with $\left\|\widetilde{\eta}^{m}\right\| \leq Q h^{2}\|u\|_{L^{\infty}\left(H^{2}\right)}$, completes the proof.
5. Numerical experiments. We provide numerical examples to verify the theoretical analysis of two fully-discrete schemes. Let $\Omega=(0,1)$ and $h=\frac{1}{J}$ for some $J>0$. We measure the temporal and special convergence rates by rate ${ }^{t}=\log _{2}\left(\frac{E_{1}(2 \tau, h)}{E_{1}(\tau, h)}\right)$ and rate ${ }^{x}=\log _{2}\left(\frac{G_{1}(\tau, 2 h)}{G_{1}(\tau, h)}\right)$ with errors computed by $E_{1}(\tau, h)=\left(h \sum_{j=1}^{J-1} \mid U_{h, j}^{N}(\tau, h)-\right.$ $\left.\left.U_{h, j}^{2 N}(\tau / 2, h)\right|^{2}\right)^{\frac{1}{2}}$ and $G_{1}(\tau, h)=\left(h \sum_{j=1}^{J-1}\left|U_{h, j}^{N}(\tau, h)-U_{h, 2 j}^{N}(\tau, h / 2)\right|^{2}\right)^{\frac{1}{2}}$. Here the notation $U_{h, j}^{N}(\tau, h)$ refers to the numerical solution at the last time step computed under the time step size $\tau$ and the spacial mesh size $h$.

Example 1: Convergence of $\alpha_{0}$-order scheme. Let $T=1 / 2, u_{0}=\sin (\pi x)$, $\bar{u}_{0}=\sin (2 \pi x)$ and $f=0$. We choose $\alpha(t)=\alpha_{0}+\frac{1}{2} t^{3}$ such that the condition (3.4) is satisfied. We present errors and convergence rates in Tables 5.1-5.2 under different values of $\alpha_{0}$, which justify the $O\left(\tau^{\alpha_{0}}+h^{2}\right)$ accuracy of the $\alpha_{0}$-order scheme proved in Theorem 3.4.

Example 2: Convergence of second-order scheme. Let $T=1, u_{0}=$ $x^{4}(1-x)^{4} \in \check{H}^{4}, \bar{u}_{0}=x^{2}(1-x)^{2} \in \check{H}^{2}$ and $f=0$. We select $\alpha(t)=\alpha_{0}+\frac{1}{4} t^{3}$ such that the condition (3.4) is satisfied. We present errors and convergence rates in Tables 5.35 .4 with different choices of $\alpha_{0}$, which indicate the $O\left(\tau^{2}+h^{2}\right)$ accuracy of the second-order scheme second-order accuracy as proved in Theorem 4.3.

Example 3: Convergence without condition (3.4). Let $T=1, u_{0}(x)=$ $\sin (\pi x), \bar{u}_{0}(x)=x^{2}(1-x)^{2}$ and $f(x, t)=1$. We select $\alpha(t)=\alpha_{0}+\frac{1}{8} \sin (t)$ such that the condition (3.4) is not satisfied. Nevertheless, Table 5.5 shows that both methods still exhibit the desired convergence rates. Thus, it is interesting to investigate the error estimate of both schemes without the condition (3.4) that will be studied in the near future.

Define a mapping $\mathcal{M}: \tilde{W}^{2, p}\left(L^{2}\right) \rightarrow \tilde{W}^{2, p}\left(L^{2}\right)$ by $w=\mathcal{M} v$ where $w$ satisfies

Then we apply (5.2), the Young's convolution inequality, $C\left([0, T] ; L^{2}\right) \subset W^{1,1}\left(L^{2}\right)$ [1], $\beta_{\alpha_{0}-1} \in L^{p}(0, T)$ and $v \in \tilde{W}^{2, p}\left(L^{2}\right)$ to bound $\partial_{t} p_{v}$ as

$$
\begin{aligned}
&\left\|\partial_{t} p_{v}\right\|_{\tilde{W}^{2, p}\left(L^{2}\right)} \leq Q\|f\|_{W^{1,1}\left(L^{2}\right)}+Q\left\|e^{-\lambda t} g^{\prime} \mid *\right\| e^{-\lambda t} \partial_{t}^{2} v\| \|_{L^{p}(0, T)} \\
& \leq Q\|f\|_{W^{1,1}\left(L^{2}\right)}+Q\left\|e^{-\lambda t} t^{-\varepsilon}\right\|_{L^{1}}\|v\|_{\tilde{W}^{2, p}\left(L^{2}\right)} \leq Q\|f\|_{W^{1,1}\left(L^{2}\right)}+Q \sigma^{\varepsilon-1}\|v\|_{\tilde{W}^{2, p}\left(L^{2}\right)}
\end{aligned}
$$

where we used the fact that $\left\|e^{-\sigma t} t^{-\varepsilon}\right\|_{L^{1}(0, T)}=\int_{0}^{T} e^{-\sigma t} t^{-\varepsilon} d t \leq \sigma^{\varepsilon-1} \int_{0}^{\infty} e^{-t} t^{-\varepsilon} d t \leq$ $Q \sigma^{\varepsilon-1}$. We use the Laplace transform to evaluate

$$
\begin{equation*}
\mathcal{L}\left[\int_{0}^{t} F^{\prime}(t-s) \partial_{s} p_{v}(s) d s\right]=\left(z^{\alpha_{0}-\varepsilon}\left(z^{\alpha_{0}}-\Delta\right)^{-1}\right)\left(z^{\varepsilon} \mathcal{L}\left(\partial_{s} p_{v}\right)\right) \tag{5.5}
\end{equation*}
$$

Take the inverse Laplace transform of (5.5) to get $\int_{0}^{t} F^{\prime}(t-s) p_{v}(s) d s=\int_{0}^{t} \mathcal{R}(t-$ s) $\partial_{s}^{\varepsilon} \partial_{s} p_{v}(s) d s$ where $\mathcal{R}(t):=\frac{1}{2 \pi \mathrm{i}} \int_{\Gamma_{\theta}} z^{\alpha_{0}-\varepsilon}\left(z^{\alpha_{0}}-\Delta\right)^{-1} e^{z t} \mathrm{~d} z$. Use (2.1) to bound $\mathcal{R}$ by

$$
\|\mathcal{R}(t-s)\| \leq Q \int_{\Gamma_{\theta}}|z|^{\alpha_{0}-\varepsilon}|z|^{-\alpha_{0}}\left|e^{z(t-s)} \| d z\right| \leq \frac{Q}{(t-s)^{1-\varepsilon}}
$$

We invoke this and apply (5.3) and (5.4) to bound

$$
\begin{aligned}
& \| \int_{0}^{t} \\
& \quad F^{\prime}(t-s) \partial_{s} p_{v}(s) d s \| \\
& \quad \leq Q t^{\varepsilon-1} *\left[\beta_{\alpha_{0}-\varepsilon-1}\|f(0)\|+\beta_{\alpha_{0}-\varepsilon-1} *\left\|\partial_{t} f\right\|+t^{-2 \varepsilon} *\left\|\partial_{t}^{2} v\right\|\right] \\
& \quad \leq Q \beta_{\alpha_{0}-1}\|f(0)\|+Q \beta_{\alpha_{0}-1} *\left\|\partial_{t} f\right\|+Q \beta_{1-\varepsilon} *\left\|\partial_{t}^{2} v\right\|,
\end{aligned}
$$

which gives $\left\|e^{-\sigma t}\right\| \int_{0}^{t} F^{\prime}(t-s) \partial_{s} p_{v}(s) d s\| \|_{L^{p}(0, T)} \leq Q\left(\|f\|_{W^{1,1}\left(L^{2}\right)}+\sigma^{\varepsilon-1}\|v\|_{\tilde{W}^{2, p}\left(L^{2}\right)}\right)$.
We summarize the above estimates to conclude that

$$
\begin{equation*}
\|w\|_{\tilde{W}^{2, p}\left(L^{2}\right)} \leq Q\left(\|f\|_{W^{1,1}\left(L^{2}\right)}+\sigma^{\varepsilon-1}\|v\|_{\tilde{W}^{2, p}\left(L^{2}\right)}\right) \tag{5.6}
\end{equation*}
$$

which implies that $w \in \tilde{W}^{2, p}\left(L^{2}\right)$ such that $\mathcal{M}$ is well-posed. To show the contractivity of $\mathcal{M}$, let $w_{1}=\mathcal{M} v_{1}$ and $w_{2}=\mathcal{M} v_{2}$ such that $w_{1}-w_{2}$ satisfies (5.1) with $v=v_{1}-v_{2}$ and $f \equiv 0$. Thus (5.6) implies $\left\|w_{1}-w_{2}\right\|_{\tilde{W}^{2, p}\left(L^{2}\right)} \leq Q \sigma^{\varepsilon-1}\left\|v_{1}-v_{2}\right\|_{\tilde{W}^{2, p}\left(L^{2}\right)}$. Choose $\sigma$ large enough such that $Q \sigma^{\varepsilon-1}<1$, that is, $\mathcal{M}$ is a contraction mapping such that there exists a unique solution $u \in \tilde{W}^{2, p}\left(L^{2}\right)$ for model (2.5)-(1.2) with $u_{0}=\bar{u}_{0} \equiv 0$, and the stability estimate could be derived directly from (5.6) with $v=w=u$ and large $\sigma$ and the equivalence between two norms $\|\cdot\|_{\tilde{W}^{2, p}\left(L^{2}\right)}$ and $\|\cdot\|_{W^{2, p}\left(L^{2}\right)}$ for $u \in \tilde{W}^{2, p}\left(L^{2}\right)$

$$
\begin{equation*}
\|u\|_{W^{2, p}\left(L^{2}\right)} \leq Q\|f\|_{W^{1,1}\left(L^{2}\right)} . \tag{5.7}
\end{equation*}
$$

For (2.5)-(1.2) with non-zero initial conditions, a variable substitution $v=u-$ $u_{0}-t \bar{u}_{0}$ could be used to reach the same model with $u, f, u_{0}, \bar{u}_{0}$ replaced by $v$, $f+\Delta u_{0}+t \Delta \bar{u}_{0}, 0$ and 0 , respectively. As $u_{0}, \bar{u}_{0} \in H^{2}$, we apply the well-posedness of (2.5)-(1.2) with $u_{0}$ to find that there exists a unique solution $v \in \tilde{W}^{2, p}\left(L^{2}\right)$ with the stability estimate $\|v\|_{W^{2, p}\left(L^{2}\right)} \leq Q\left\|f+\Delta u_{0}+t \Delta \bar{u}_{0}\right\|_{W^{1,1}\left(L^{2}\right)}$ derived from (5.7). By $v=u-u_{0}-t \bar{u}_{0}$, we finally conclude that $u=v+u_{0}+t \bar{u}_{0}$ is a solution to (2.5)-(1.2) in $W^{2, p}\left(L^{2}\right)$ with the estimate $\|u\|_{W^{2, p}\left(L^{2}\right)} \leq Q\|f\|_{W^{1,1}\left(L^{2}\right)}+Q\left\|u_{0}\right\|_{H^{2}}+Q\left\|\bar{u}_{0}\right\|_{H^{2}}$. The uniqueness of the solutions to (2.5)-(1.2) follows from that to this model with $u_{0}=\bar{u}_{0} \equiv 0$.

Then we show that the solution to (2.5)-(1.2) is also a solution to (1.1)-(1.2). Note that (2.5) implies (2.4) by integration by parts, which, together with $g=\beta_{\alpha_{0}-1} * k$, leads to $\beta_{\alpha_{0}-1} *\left[k * \partial_{t}^{2} u-\Delta u-f\right]=0$. The convolution of this equation with $\beta_{2-\alpha_{0}}$ is

$$
\begin{equation*}
\beta_{1} *\left[k * \partial_{t}^{2} u-\Delta u-f\right]=\int_{0}^{t}\left(k * \partial_{s}^{2} u-\Delta u-f\right) d s=0 \tag{5.8}
\end{equation*}
$$

Differentiate this equation leads to the original governing equation (1.1), which implies the existence. The uniqueness of the solutions to (1.1)-(1.2) in $W^{2, p}\left(L^{2}\right)$ follows from that of (2.5)-(1.2). Finally, we apply the governing equation (1.1) to find

$$
\|\Delta u\|_{L^{p}\left(L^{2}\right)}=\left\|k * \partial_{t}^{2} u-f\right\|_{L^{p}\left(L^{2}\right)} \leq Q\|f\|_{W^{1,1}\left(L^{2}\right)}+Q\left\|u_{0}\right\|_{H^{2}}+Q\left\|\bar{u}_{0}\right\|_{H^{2}}
$$

which completes the proof.
