# HARNACK INEQUALITY FOR DOUBLY NONLINEAR MIXED LOCAL AND NONLOCAL PARABOLIC EQUATIONS

#### Abstract

In this paper, we establish the Harnack inequality of nonnegative weak solutions to the doubly nonlinear mixed local and nonlocal parabolic equations. This result is obtained by combining a related comparison principle, a local boundedness estimate, and an integral Harnack-type inequality. Our proof is based on the expansion of positivity together with a comparison argument.


## 1. Introduction

Let $E_{T}:=E \times(0, T)$ be an open bounded set $E \subset \mathbb{R}^{N}$ and $T>0$. In this paper, we discuss the Harnack-type estimate for nonnegative weak solutions to the following doubly nonlinear parabolic equation

$$
\begin{equation*}
\partial_{t}\left(|u|^{q-1} u\right)-\operatorname{div}\left(|\nabla u|^{p-2} \nabla u\right)+\mathcal{L} u=0 \quad \text { in } E_{T}, \tag{1.1}
\end{equation*}
$$

where $p>1, q>0$ and the operator $\mathcal{L}$ is given by

$$
\begin{equation*}
\mathcal{L} u(x, t)=\mathrm{P} . \mathrm{V} . \int_{\mathbb{R}^{N}} K(x, y, t)|u(x, t)-u(y, t)|^{p-2}(u(x, t)-u(y, t)) d y \tag{1.2}
\end{equation*}
$$

Here, P.V. means the Cauchy principal value and $K(x, y, t): \mathbb{R}^{N} \times \mathbb{R}^{N} \times(0, T] \rightarrow[0, \infty)$ is the symmetric kernel function satisfying

\frac{\Lambda^{-1}}{|x-y|^{N+s p}} \leq K(x, y, t) \equiv K(y, x, t) \leq \frac{\Lambda}{|x-y|^{N+s p}} \quad \text { a.e. } x, y \in \mathbb{R}^{N}
$$

for some $\Lambda \geq 1$ and $s \in(0,1)$.
To state the definition of weak solutions, we denote by $W_{0}^{1, p}(E)$ the Sobolev space with zero boundary values, namely

W_{0}^{1, p}(E):=\left\{u \in W^{1, p}(E): u=0 \text { in } \mathbb{R}^{N} \backslash E\right\}
$$

Moreover, we introduce the tail space

$$
L_{\alpha}^{m}\left(\mathbb{R}^{N}\right):=\left\{v \in L_{\operatorname{loc}}^{m}\left(\mathbb{R}^{N}\right): \int_{\mathbb{R}^{N}} \frac{|v(x)|^{m}}{1+|x|^{N+\alpha}} d x<+\infty\right\}, \quad m>0 \text { and } \alpha>0 .
$$

[^0]The parabolic nonlocal tail is of the form

$$
\operatorname{Tail}_{\infty}\left(v ; x_{0}, R ; t_{0}-S, t_{0}\right):=\underset{t_{0}-S<t<t_{0}}{\operatorname{ess} \sup ^{2}}\left(R^{p} \int_{\mathbb{R}^{N} \backslash B_{R}\left(x_{0}\right)} \frac{|v(x, t)|^{p-1}}{\left|x-x_{0}\right|^{N+s p}} d x\right)^{\frac{1}{p-1}}
$$

Note that $\operatorname{Tail}_{\infty}\left(v ; x_{0}, R ; t_{0}-S, t_{0}\right)$ is well-defined for any $v \in L^{\infty}\left(t_{0}-S, t_{0} ; L_{s p}^{p-1}\left(\mathbb{R}^{N}\right)\right)$.
Eq. (1.1) can be seen as a mixed version of the doubly nonlinear parabolic equation

$$
\begin{equation*}
\partial_{t}\left(|u|^{q-1} u\right)-\operatorname{div}\left(|\nabla u|^{p-2} \nabla u\right)=0 \quad \text { in } E_{T} \tag{1.3}
\end{equation*}
$$

which attracts lots of interest both in light of its mathematical structure and its significance to describe many physical phenomena including shallow water flows [3 and glacier dynamics [24], see also [21,36] for other classical applications. It is well-known that Eq. (1.3) covers Trudinger's equation $(q=p-1)$, the evolutionary $p$-Laplace equation $(q=1)$, and the porous medium equation $(p=2)$. There have been fruitful achievements on Eq. (1.3), such as the existence of solutions [8, 26], Hölder regularity [9, 39], higher integrability [7, 28], and Harnack type estimate [6, 11, 38, 40. We refer the readers to [16, 19, 25, 27] and reference therein for more related results.

For the doubly nonlinear nonlocal parabolic equation

$$
\begin{equation*}
\partial_{t}\left(|u|^{q-1} u\right)+(-\Delta)_{p}^{s} u=0 \quad \text { in } E_{T} \tag{1.4}
\end{equation*}
$$

the pointwise behavior of weak solutions was shown in [4] with $p>1$ and $q>0$. For what concerns the nonlocal Trudinger equation, Banerjee-Garain-Kinnunen 5 investigated the local boundedness of weak subsolutions by De Giorgi's method. Meanwhile, they also provide a crucial algebraic inequality to deal with the nonlocal term in obtaining a reverse Hölder inequality for positive weak supersolutions under the assumption that $p>2$. In particular, a weak Harnack inequality for globally bounded positive weak solutions to the nonlocal Trudinger equation was derived by Prasad [32]. Taking into account the fractional $p$-Laplace parabolic equation, the local boundedness $(p>1)$ and the Hölder regularity $(p>2)$ for local weak solutions were explored in [14]. Moreover, [22] generalized the regularity results to the region $1<p<\infty$ by means of the intrinsic scaling method, but avoids using any comparison principle. Further results can be found in [12, 35, 37.

Regarding the homogeneous scenario of (1.1), i.e., $q=p-1$, the local boundedness of sign-changing weak solutions for $p \geq 2$ was achieved by Nakamura 30. Later, the author considered Harnack's inequality for globally bounded positive weak solutions through some quantitative estimates in [29]. When $q=1$, Eq. (1.1) becomes the mixed local and nonlocal parabolic $p$-Laplace equation

\begin{equation*}
\partial_{t} u-\operatorname{div}\left(|\nabla u|^{p-2} \nabla u\right)+\mathcal{L} u=0 \quad \text { in } E_{T} \tag{1.5}
\end{equation*}
$$

some regularity properties of sign-changing weak solutions involving the local boundedness, the semicontinuity, and the pointwise behavior were discussed in [15]. By employing the expansion of positivity, Shang-Zhang studied Harnack's estimate and the Hölder continuity for weak solutions to (1.5) in [33] and [34, respectively. Very recently, Adimurthi-PrasadTewary [2] developed the $C^{1, \alpha}$ regularity of weak solutions to (1.5) by suitable comparison estimates.

To the best of our knowledge, there are no results concerning Eq. (1.1) for the general case $q \neq p-1$. Motivated by the works [6, 29, our purpose in this paper is to study the Harnack inequality of globally bounded nonnegative weak solutions to problem (1.1) under the assumptions that $0<p-1<q<p^{2}-1$ and $p>N$. Different from the homogeneous case,
the solutions to Eq. (1.1) in the fast diffusion range can not be scaled by multiplying any scale factor. Exactly for this, we adopt the approach called the expansion of positivity and choose suitable geometries to overcome the non-homogeneity. In addition, we remark that the assumptions proposed on $p$ and $q$ address another difficulty stemming from the nonlocal feature. To investigate the Harnack inequality, we also establish the local boundedness, a comparison principle, and an integral-type Harnack inequality as byproducts.

We now state the notion of weak solutions to problem (1.1).
Definition 1.1. We identify a function $u$ is a weak subsolution (super-) to the doubly nonlinear mixed local and nonlocal parabolic equation (1.1) if

u \in C\left(0, T ; L^{q+1}(E)\right) \cap L^{p}\left(0, T ; W^{1, p}(E)\right) \cap L^{\infty}\left(0, T ; L_{s p}^{p-1}\left(\mathbb{R}^{N}\right)\right)
$$

such that there holds the integral inequality

$$
\begin{equation*}
\iint_{E_{T}}-|u|^{q-1} u \partial_{t} \varphi+|\nabla u|^{p-2} \nabla u \cdot \nabla \varphi d x d t+\int_{0}^{T} \mathcal{E}(u, \varphi, t) d t \leq(\geq) 0 \tag{1.6}
\end{equation*}
$$

for all nonnegative test functions $\varphi \in W_{0}^{1, q+1}\left(0, T ; L^{q+1}(E)\right) \cap L^{p}\left(0, T ; W_{0}^{1, p}(E)\right)$, where
$\mathcal{E}(u, \varphi, t):=\int_{\mathbb{R}^{N}} \int_{\mathbb{R}^{N}} K(x, y, t)|u(x, t)-u(y, t)|^{p-2}(u(x, t)-u(y, t))(\varphi(x, t)-\varphi(y, t)) d y d x$.
A function $u$ is called a weak solution to (1.1) if it is both a weak subsolution and a weak supersolution.

At this stage, we present our results as follows. The first one is about the local boundedness of weak subsolutions.

Theorem 1.2. Let $0<p-1<q$ and let $r \geq 1$ such that

$$
\begin{equation*}
\lambda_{r}:=N(p-q-1)+r p>0 . \tag{1.7}
\end{equation*}
$$

Suppose that $u$ is a nonnegative, weak subsolution to (1.1). For $r>m:=p \frac{N+q+1}{N}$, we further assume that $u$ is qualitatively locally bounded. Let $Q_{\rho, s}=K_{\rho}\left(x_{0}\right) \times\left(t_{0}-s, t_{0}\right] \subset \subset E_{T}$. Then there holds

$$
\begin{aligned}
\underset{Q_{\frac{1}{2} \rho, \frac{1}{2} s}^{\operatorname{ess} s u p}}{ } u \leq & \gamma\left(\frac{\rho^{p}}{s}\right)^{\frac{N}{\lambda_{r}}}\left(\iint_{Q_{\rho, s}} u^{r} d x d t\right)^{\frac{p}{\lambda_{r}}}+\gamma\left(\frac{s}{\rho^{p}}\right)^{\frac{1}{q+1-p}} \\
& +\gamma\left(\frac{s}{\rho^{p}}\left[\operatorname{Tail}_{\infty}\left(u ; x_{0}, \rho / 2 ; t_{0}-s, t_{0}\right)\right]^{p-1}\right)^{\frac{1}{q}}
\end{aligned}
$$

where $\gamma$ is a constant depending only on $N, p, s, q, \Lambda$.
Remark 1.3. We will discuss the local boundedness result in three cases. The first two cases care about the exponent $r \leq m$, in which $u \in L_{\mathrm{loc}}^{m}\left(E_{T}\right)$ can be ensured by Sobolev embedding in Lemma 2.7. For $r>m$, we further assume that the weak subsolutions of (1.1) are locally bounded because Lemma 2.7 is generally not true. Notice that there exists some $r \geq 1$ satisfying $r \leq m$ and $\lambda_{r}>0$, if and only if $\lambda_{m}>0$. Owing to

$$
\lambda_{m}=(N+p)(m-q-1)=\frac{N+p}{N} \lambda_{q+1}
$$

$\lambda_{m}>0$ asking for $m>q+1$ or $\lambda_{q+1}>0$, which is equal to

$$
q<\frac{N(p-1)+p}{(N-p)_{+}}
$$

Consequently, we can apply Theorem 1.2 for $r=q+1$ without assuming a prior that $u$ is locally bounded in this case.

From Remark 1.3 we get a corollary of Theorem 1.2
Corollary 1.4. Let $0<p-1<q<\frac{N(p-1)+p}{(N-p)_{+}}$. Then we know that every nonnegative weak subsolution to (1.1) is locally bounded.

Based on the boundedness result, we can derive the Harnack inequality in an integraltype, which is a key ingredient to obtain the Harnack inequality.
Theorem 1.5. Let $0<p-1<q<\min \left\{p^{2}-1, \frac{N(p-1)}{(N-p)_{+}}\right\}$and $\lambda_{q}:=N(p-1-q)+q p>0$. Suppose that $u$ is a nonnegative, weak solution to (1.1), and the cylinder $Q_{\rho, s}=K_{\rho}\left(x_{0}\right) \times$ $\left(t_{0}-s, t_{0}\right] \subset E_{T}$ with $\rho \in(0,1]$. Then there holds

$$
\begin{aligned}
\operatorname{ess~sup}_{Q_{\frac{1}{2} \rho, \frac{1}{2} s}} u \leq & \gamma\left(\frac{\rho^{p}}{s}\right)^{\frac{N}{\lambda q}}\left(\inf _{t \in\left[t_{0}-s, t_{0}\right]} f_{K_{\rho}\left(x_{0}\right) \times\{t\}} u^{q} d x\right)^{\frac{p}{\lambda_{q}}}+\gamma\left(\frac{s}{\rho^{p}}\right)^{\frac{1}{q+1-p}} \\
& +\gamma\left(\frac{s}{\rho^{p}}\left[\operatorname{Tail}_{\infty}\left(u ; x_{0}, \rho / 2 ; t_{0}-s, t_{0}\right)\right]^{p-1}\right)^{\frac{1}{q}} \\
& +\gamma\left(\frac{s}{\rho^{p}}\right)^{\frac{p-N}{\lambda_{q}}}\left[\operatorname{Tail}_{\infty}\left(u ; x_{0}, \rho / 2 ; t_{0}-s, t_{0}\right)\right]^{\frac{p(p-1)}{\lambda_{q}}}
\end{aligned}
$$

with constant $\gamma$ depending only on $N, p, s, q, \Lambda$.
The last theorem is our main result regarding the Harnack inequality of nonnegative weak solutions while we additionally assume that the weak solutions are globally bounded.

Theorem 1.6. Let $p>N, 0<p-1<q<p^{2}-1$ and let $\rho \in(0,1]$. Suppose that $u \in L^{\infty}\left(\mathbb{R}^{N} \times(0, T)\right)$ is a nonnegative, continuous, weak solution to (1.1), and $u\left(x_{0}, t_{0}\right)>0$. There exist constants $\gamma>1$ and $\sigma \in(0,1)$ depending only on $N, p, s, q, \Lambda,\|u\|_{L^{\infty}\left(\mathbb{R}^{N} \times(0, T)\right)}$, such that for any

$$
(x, t) \in K_{\rho}\left(x_{0}\right) \times\left(t_{0}-\sigma\left[u\left(x_{0}, t_{0}\right)\right]^{q+1-p} \rho^{p}, t_{0}+\sigma\left[u\left(x_{0}, t_{0}\right)\right]^{q+1-p} \rho^{p}\right),
$$

we have

$$
\gamma^{-1} u\left(x_{0}, t_{0}\right) \leq u(x, t) \leq \gamma u\left(x_{0}, t_{0}\right)
$$

provided

$$
K_{8 \rho}\left(x_{0}\right) \times\left(t_{0}-\gamma\left[u\left(x_{0}, t_{0}\right)\right]^{q+1-p}(8 \rho)^{p}, t_{0}+\gamma\left[u\left(x_{0}, t_{0}\right)\right]^{q+1-p}(8 \rho)^{p}\right) \subset E_{T} .
$$

The range where Theorem 1.6 holds is shown in Figure 1. The Harnack inequality we established above distinguishes from the normal parabolic Harnack inequality in two aspects. First, we obtain the pointwise information in an intrinsic cylinder since we perform a specific scaling of the equation. Second, the effect of time in this Harnack inequality is weakened, so that it presents a "elliptic" feature.

Remark 1.7. In the statement of Theorem 1.6, we assume that $u$ is a continuous function for giving a clear sense to $u\left(x_{0}, t_{0}\right)$. In fact, this property can be proved by using De Giorgitype Lemma 6.2 in the forthcoming context together with Theorem 2.1 in [23], and the detailed proof can be found in [4].

This paper is organized as follows. In Section 2, we display some basic notations and give several preliminary materials. Section 3 is devoted to deriving a comparison principle. In Section 4 we will provide the Caccioppoli-type inequality first, and then discuss the local boundedness result Theorem 1.2 The integral-type Harnack inequality Theorem 1.5 will be proved in Section 5. In Section 6, we will develop the expansion of positivity of weak solutions. Finally, we complete the proof of main result (Theorem 1.6) in Section 7.

## 2. Preliminaries

2.1. Notation. First, we collect some notations used throughout the paper. We shall denote $K_{\rho}\left(x_{0}\right)$ is a cube centered at $x_{0} \in \mathbb{R}^{N}$, whose side length $2 \rho>0$, and whose faces are parallel to the coordinate planes in $\mathbb{R}^{N}$. As is customary, we write the general backward parabolic cylinders as

$$
\left(x_{0}, t_{0}\right)+Q_{R, S}:=K_{R}\left(x_{0}\right) \times\left(t_{0}-S, t_{0}\right] .
$$

We will omit $\left(x_{0}, t_{0}\right)$ if the context is clear or $\left(x_{0}, t_{0}\right)=(0,0)$.
For fixed $k \in \mathbb{R}$, define

$$
(u-k)_{+}=\max \{u-k, 0\} \quad \text { and } \quad(u-k)_{-}=\max \{-(u-k), 0\}
$$

For a function $u$ defined in $E$ and a real number $l$, we denote

$$
[u>l]=\{x \in E: u(x)>l\}
$$

We also use the shorthand notations

$$
d \mu=d \mu(x, y, t)=K(x, y, t) d x d y
$$

and

$$
U(x, y, t):=|u(x, t)-u(y, t)|^{p-2}(u(x, t)-u(y, t))
$$

We denote by $\gamma$ some generic constants, that may vary from each other even in the same line.
2.2. Technical lemmas. We give an algebraic inequality, see Lemma 2.2 in [1] for $0<\alpha<1$ and inequality (2.4) in [17] for $\alpha>1$.

Lemma 2.1. For every $\alpha>0$, there is a constant $\gamma$ depending only on $\alpha$ such that

$$
\left.\frac{1}{\gamma}\left||b|^{\alpha-1} b-|a|^{\alpha-1} a\right| \leq(|a|+|b|)^{\alpha-1}|b-a| \leq\left.\gamma| | b\right|^{\alpha-1} b-|a|^{\alpha-1} a \right\rvert\,
$$

for all $a, b \in \mathbb{R}$.
To work with the term involving the time derivative, we shall use auxiliary functions $\boldsymbol{h}_{ \pm}$ defined as

$$
\begin{equation*}
\boldsymbol{h}_{ \pm}(w, k):= \pm q \int_{k}^{w}|s|^{q-1}(s-k)_{ \pm} d s \tag{2.1}
\end{equation*}
$$

for $k, w \in \mathbb{R}$ and $q>0$. It is easy to check that $\boldsymbol{h}_{ \pm}(w, k) \geq 0$. We also write

$$
\boldsymbol{h}(w, k):=q \int_{k}^{w}|s|^{q-1}(s-k) d s
$$

The next lemma can be deduced with the help of Lemma 2.1.
Lemma 2.2 (Lemma 2.2, [9). Let $q>0$. There exists a constant $\gamma=\gamma(q)>0$ such that for all $a, b \in \mathbb{R}$, there holds

$$
\frac{1}{\gamma}(|a|+|b|)^{q-1}|a-b|^{2} \leq \boldsymbol{h}(a, b) \leq \gamma(|a|+|b|)^{q-1}|a-b|^{2}
$$

and

$$
\frac{1}{\gamma}(|a|+|b|)^{q-1}(a-b)_{ \pm}^{2} \leq \boldsymbol{h}_{ \pm}(a, b) \leq \gamma(|a|+|b|)^{q-1}(a-b)_{ \pm}^{2}
$$

What follows is a necessary tool for dealing with the nonlocal term to discuss the integraltype Harnack inequality.

Lemma 2.3 (Lemma 2.9, [5]). Let $a, b>0, \tau_{1}, \tau_{2} \geq 0$ and $p>1$. Then there exists $a$ constant $\gamma=\gamma(p)>1$ such that

$$
\begin{aligned}
|b-a|^{p-2}(b-a)\left(\tau_{1}^{p} a^{-\varepsilon}-\tau_{2}^{p} b^{-\varepsilon}\right) \geq & \gamma \xi(\varepsilon)\left|\tau_{2} b^{\frac{\alpha}{p}}-\tau_{1} a^{\frac{\alpha}{p}}\right|^{p} \\
& -\left(\xi(\varepsilon)+1+\varepsilon^{-(p-1)}\right)\left|\tau_{2}-\tau_{1}\right|^{p}\left(b^{\alpha}+a^{\alpha}\right)
\end{aligned}
$$

where $\varepsilon \in(0, p-1), \alpha:=p-1-\varepsilon, \xi(\varepsilon)=\frac{\varepsilon p^{p}}{\alpha}$ if $0<\alpha<1$, and $\xi(\varepsilon)=\varepsilon\left(\frac{p}{\alpha}\right)^{p}$ otherwise.
We give a fast geometric convergence lemma from [13, Lemma 4.1].
Lemma 2.4. Let $\left\{Y_{j}\right\}_{j=0}^{\infty}$ be a sequence of positive numbers satisfying

$$
Y_{j+1} \leq K b^{j} Y_{j}^{1+\delta}, \quad j=0,1,2, \ldots
$$

for some constants $K, b>1$ and $\delta>0$. If

$$
Y_{0} \leq K^{-\frac{1}{\delta}} b^{-\frac{1}{\delta^{2}}}
$$

then we have $Y_{j} \rightarrow 0$ as $j \rightarrow 0$.
The following iteration lemma is displayed in [18, Lemma 6.1].

Lemma 2.5. Let constants $A, B, C \geq 0, \alpha>\beta \geq 0$ and $\theta \in(0,1)$. Suppose that $f:[r, \rho] \rightarrow$ $[0, \infty)$ is a bounded function that satisfies

$$
f\left(R_{1}\right) \leq \theta f\left(R_{2}\right)+\frac{A}{\left(R_{2}-R_{1}\right)^{\alpha}}+\frac{B}{\left(R_{2}-R_{1}\right)^{\beta}}+C
$$

for all $r<R_{1}<R_{2}<\rho$. Then we have

$$
f(r) \leq \gamma(\alpha, \theta)\left[\frac{A}{(\rho-r)^{\alpha}}+\frac{B}{(\rho-r)^{\beta}}+C\right]
$$

We now present a Poincaré-type inequality from [13, Chapter I, Proposition 2.1].
Lemma 2.6. Suppose that $\Omega \subset \mathbb{R}^{N}$ is a bounded convex set. Let $\varphi \in C(\bar{\Omega})$ satisfy $0 \leq \varphi \leq 1$, and the sets $[\varphi>k]$ are convex for any $k \in(0,1)$. Let $v \in W^{1, p}(\Omega)$, and the set

$$
\mathcal{E}:=[v=0] \cap[\varphi=1]
$$

has positive measure. Then we have

$$
\left(\int_{\Omega} \varphi|v|^{p} d x\right)^{\frac{1}{p}} \leq \gamma \frac{(\operatorname{diam} \Omega)^{N}}{|\mathcal{E}|^{\frac{N-1}{N}}}\left(\int_{\Omega} \varphi|\nabla v|^{p} d x\right)^{\frac{1}{p}}
$$

where $\gamma>0$ depends only on $N$ and $p$, but independent of $v$ and $\varphi$.
We finally state a parabolic Sobolev embedding lemma.
Lemma 2.7 (Chapter I, Proposition 3.1, [13]). Suppose that $E \subset \mathbb{R}^{N}$ is a bounded domain. Let $m, p>1$ and $q=p \frac{N+m}{N}$. Then for every

$$
u \in L^{\infty}\left(0, T ; L^{m}(E)\right) \cap L^{p}\left(0, T ; W_{0}^{1, p}(E)\right)
$$

we have

$$
\iint_{E_{T}}|u|^{q} d x d t \leq \gamma \iint_{E_{T}}|\nabla u|^{p} d x d t\left(\underset{t \in[0, T]}{\operatorname{ess} \sup } \int_{E \times\{t\}}|u|^{m} d x\right)^{\frac{p}{N}}
$$

where $\gamma>0$ only depends on $N, p$ and $q$.
2.3. Time mollification. The exponential mollification in time will be introduced in this subsection to solve the difficulty that weak solutions do not have a time derivation generally. This technique is extracted from [20]. For any $v \in L^{1}\left(E_{T}\right)$ and $h>0$, define

$$
\llbracket v \rrbracket_{h}(x, t):=\frac{1}{h} \int_{0}^{t} e^{\frac{s-t}{h}} v(x, s) d s
$$

and

$$
\llbracket v \rrbracket_{\bar{h}}(x, t):=\frac{1}{h} \int_{t}^{T} e^{\frac{t-s}{h}} v(x, s) d s
$$

The following fundamental properties of mollified functions are given in [10, Appendix].
Lemma 2.8. Let $r \geq 1$. Then the following conclusions hold.
(i) If $v \in L^{r}\left(E_{T}\right)$, then $\llbracket v \rrbracket_{h} \in L^{r}\left(E_{T}\right)$ and $\left\|\llbracket v \rrbracket_{h}\right\|_{L^{r}\left(E_{T}\right)} \leq\|v\|_{L^{r}\left(E_{T}\right)}$. In addition, we have $\llbracket v \rrbracket_{h} \rightarrow v$ strongly in $L^{r}\left(E_{T}\right)$ and almost everywhere on $E_{T}$ as $h \rightarrow 0$.
(ii) There almost everywhere on $E_{T}$ holds

$$
\partial_{t} \llbracket v \rrbracket_{h}=\frac{1}{h}\left(v-\llbracket v \rrbracket_{h}\right), \quad \partial_{t} \llbracket v \rrbracket_{\bar{h}}=\frac{1}{h}\left(\llbracket v \rrbracket_{\bar{h}}-v\right) .
$$

(iii) If $v \in L^{r}\left(E_{T}\right)$, then $\llbracket v \rrbracket_{h}$ and $\llbracket v \rrbracket_{\bar{h}}$ belong to $C\left([0, T] ; L^{r}(E)\right)$.
(iv) If $D u \in L^{r}\left(E_{T}\right)$, then $D \llbracket v \rrbracket_{h}=\llbracket D v \rrbracket_{h} \rightarrow D v$ strongly in $L^{r}\left(E_{T}\right)$ and almost everywhere on $E_{T}$ as $h \rightarrow 0$.
(v) If $v \in C\left([0, T] ; L^{r}(E)\right)$, then $\llbracket v \rrbracket_{h}(\cdot, t) \rightarrow v(\cdot, t)$ strongly in $L^{r}(E)$ and almost everywhere on $E$ for any $t \in(0, T]$ as $h \rightarrow 0$.
The same statements of (i), (iv) and (v) also apply to $\llbracket v \rrbracket_{\bar{h}}$.

## 3. Comparison principles

In this part, we will consider the continuity with respect to the time variable of weak solutions and establish a comparison principle. We introduce the Cauchy-Dirichlet problem

u=0 & \text { in } \mathbb{R}^{N} \backslash E \times(0, T] \\
u(\cdot, 0)=u_{0} & \text { in } E
\end{array}\right.
$$

where $p>1, q>0, \mathcal{L}$ is defined as in (1.2), and $u_{0} \in L^{q+1}(E)$.
We give the definition of weak solutions to (3.1) as below.
Definition 3.1. We say a function

$$
u \in C\left([0, T] ; L^{q+1}\right) \cap L^{p}\left(0, T ; W_{0}^{1, p}(E)\right) \cap L^{\infty}\left(0, T ; L_{s p}^{p-1}\left(\mathbb{R}^{N}\right)\right)
$$

is a weak solution to (3.1), if there holds

$$
\begin{equation*}
\iint_{E_{T}}\left(\left|u_{0}\right|^{q-1} u_{0}-|u|^{q-1} u\right) \partial_{t} \zeta+|\nabla u|^{p-2} \nabla u \cdot \nabla \zeta d x d t+\int_{0}^{T} \mathcal{E}(u, \zeta, t) d t=0 \tag{3.2}
\end{equation*}
$$

for any test function $\zeta \in W^{1, q+1}\left(0, T ; L^{q+1}(E)\right) \cap L^{p}\left(0, T ; W_{0}^{1, p}(E)\right)$ with $\zeta(\cdot, T)=0$, where $\mathcal{E}(u, \zeta, t):=\int_{\mathbb{R}^{N}} \int_{\mathbb{R}^{N}} K(x, y, t)|u(x, t)-u(y, t)|^{p-2}(u(x, t)-u(y, t))(\zeta(x, t)-\zeta(y, t)) d y d x$.
3.1. Parabolicity. In what follows, we show Eq. (1.1) is parabolicity, which describes the property that if $u$ is a weak subsolution (super-) to (1.1), then the corresponding truncation function is also a weak subsolution (super-) to (1.1).

Proposition 3.2. Let $p>1$ and $q>0$. If $u$ is a weak subsolution (super-) to (1.1), then the truncation function $u_{k}=k+(u-k)_{+}, u_{k}=k-(u-k)_{-}$with $k \in \mathbb{R}$ is a weak subsolution (super-) to (1.1).

Proof. We verify this result holds for subsolutions, while the claim for supersolutions can proceed in the same way. For $\sigma>0$, test the weak formulation (1.6) with function

where $\zeta \in W_{0}^{1, q+1}\left(0, T ; L^{q+1}(E)\right) \cap L^{p}\left(0, T ; W_{0}^{1, p}(E)\right.$. The term including the time derivative, and the local term can be dealt with the same as in [6, Proposition 4.7], we only concentrate on the nonlocal term. Letting $h \rightarrow 0$ and using Lemma 2.8(i), we have

=\int_{0}^{T} \int_{\mathbb{R}^{N}} \int_{\mathbb{R}^{N}} U(x, y, t)\left[\frac{\zeta(u-k)_{+}(x, t)}{(u-k)_{+}(x, t)+\sigma}-\frac{\zeta(u-k)_{+}(y, t)}{(u-k)_{+}(y, t)+\sigma}\right] d \mu d t
$$

We shall send $\sigma \rightarrow 0$, and get

\begin{aligned}
& -\iint_{E_{T}}\left|u_{k}\right|^{q-1} u_{k} \partial_{t} \zeta d x d t+\iint_{E_{T}}|\nabla u|^{p-2} \nabla u \cdot \nabla \zeta \chi_{[u>k]} d x d t \\
& \quad+\int_{0}^{T} \int_{\mathbb{R}^{N}} \int_{\mathbb{R}^{N}} U(x, y, t)\left[\zeta(x, t) \chi_{[u(x, t)>k]}-\zeta(y, t) \chi_{[u(y, t)>k]}\right] d \mu d t \leq 0
\end{aligned}
$$

Moreover, one can check that

$$
\begin{aligned}
& \int_{0}^{T} \int_{\mathbb{R}^{N}} \int_{\mathbb{R}^{N}}\left|u_{k}(x, t)-u_{k}(y, t)\right|^{p-2}\left(u_{k}(x, t)-u_{k}(y, t)\right)(\zeta(x, t)-\zeta(y, t)) d \mu d t \\
\leq & \int_{0}^{T} \int_{\mathbb{R}^{N}} \int_{\mathbb{R}^{N}} U(x, y, t)\left[\zeta(x, t) \chi_{[u(x, t)>k]}-\zeta(y, t) \chi_{[u(y, t)>k]}\right] d \mu d t .
\end{aligned}
$$

Thus, we conclude that

$$
\begin{aligned}
& -\iint_{E_{T}}\left|u_{k}\right|^{q-1} u_{k} \partial_{t} \zeta d x d t+\iint_{E_{T}}\left|\nabla u_{k}\right|^{p-2} \nabla u_{k} \cdot \nabla \zeta d x d t \\
& \quad+\int_{0}^{T} \int_{\mathbb{R}^{N}} \int_{\mathbb{R}^{N}}\left|u_{k}(x, t)-u_{k}(y, t)\right|^{p-2}\left(u_{k}(x, t)-u_{k}(y, t)\right)(\zeta(x, t)-\zeta(y, t)) d \mu d t \leq 0
\end{aligned}
$$

for every nonnegative $\zeta \in W_{0}^{1, q+1}\left(0, T ; L^{q+1}(E)\right) \cap L^{p}\left(0, T ; W_{0}^{1, p}(E)\right)$.
3.2. Time continuity of weak solutions. The forthcoming proposition tells the weak solutions of (1.1) belong to $C\left([0, T] ; L^{q+1}(E)\right)$. We refer the readers to [30 for details.

Proposition 3.3. Let $p>1, q>0$ and let $u \in L^{\infty}\left(0, T ; L^{q+1}(E)\right) \cap L^{p}\left(0, T ; W_{0}^{1, p}(E)\right) \cap$ $L^{\infty}\left(0, T ; L_{s p}^{p-1}\left(\mathbb{R}^{N}\right)\right)$ satisfy the weak formula (3.2) for some $u_{0} \in L^{q+1}(E)$. Then there is a representative $u \in C\left([0, T] ; L^{q+1}(E)\right)$, indicating that

\lim _{t \rightarrow 0} \int_{E}\left|u(\cdot, t)-u_{0}\right|^{q+1} d x=0
$$

3.3. Comparison principle. Let us denote the Lipschitz function $H_{\delta}(s)$ by

1, & \text { for } s \geq \delta \\
\frac{1}{\delta} s, & \text { for } 0<s<\delta \\
0, & \text { for } s \leq 0
\end{array}\right.
$$

Define the functions

& h_{\delta}\left(z, z_{0}\right):=\int_{z_{0}}^{z} H_{\delta}\left(s-z_{0}\right) q s^{q-1} d s \quad \text { for } z, z_{0} \in \mathbb{R}_{\geq 0} \\
& \widehat{h}_{\delta}\left(z, z_{0}\right):=\int_{z_{0}}^{z} \widehat{H}_{\delta}\left(s-z_{0}\right) q s^{q-1} d s \quad \text { for } z, z_{0} \in \mathbb{R}_{\geq 0}
\end{aligned}
$$

where $\widehat{H}_{\delta}(s):=-H_{\delta}(-s)$ is the odd reflection of $H_{\delta}$. In the rest of this section, we write

$$
\begin{aligned}
& V(x, y, t)=|v(x, t)-v(y, t)|^{p-2}(v(x, t)-v(y, t)) \\
& W(x, y, t)=|w(x, t)-w(y, t)|^{p-2}(w(x, t)-w(y, t))
\end{aligned}
$$

Now, we provide a comparison principle for nonnegative weak solutions to (1.1) and (3.1). The comparison of two weak solutions in $\mathbb{R}^{N} \backslash E \times(0, T)$ can be directly checked through the boundary value of (3.1) and the non-negativity of weak solutions to (1.1). Hence, we just need to give the assumption on the initial value to develop the comparison principle on cylinders.

Proposition 3.4. Let $p>1, q>0$, and let $w$ be a nonnegative weak solution to (1.1) and $v$ be a nonnegative weak solution to (3.1) with $v_{0} \geq 0$. If $v_{0} \leq w(\cdot, 0)$ a.e. in $E$, then $v \leq w$ a.e. in $E_{T}$.

For proving Proposition 3.4 we discuss the result for the function $v$ first.
Lemma 3.5. Let $p>1, q>0$, and let $v$ be a nonnegative weak solution to (3.1) with $v_{0} \geq 0$. Suppose that $\widetilde{v} \in L^{q+1}(E) \cap W_{0}^{1, p}(E)$ is a nonnegative function. For any $\psi \in$ $C_{0}^{\infty}\left(\mathbb{R}^{N} \times(0, T)\right)$, there holds that

\begin{aligned}
& \iint_{E_{T}}-h_{\delta}(v, \widetilde{v}) \partial_{t} \psi+|\nabla v|^{p-2} \nabla v \cdot \nabla\left[H_{\delta}(v-\widetilde{v}) \psi\right] d x d t \\
& +\int_{0}^{T} \int_{\mathbb{R}^{N}} \int_{\mathbb{R}^{N}} V(x, y, t)\left[H_{\delta}(v(x, t)-\widetilde{v}(x)) \psi(x, t)-H_{\delta}(v(y, t)-\widetilde{v}(y)) \psi(y, t)\right] d \mu d t=0
\end{aligned}
$$

Proof. According to $v=0$ in $\mathbb{R}^{N} \backslash E \times(0, T)$ along with $\widetilde{v}=0$ in $\mathbb{R}^{N} \backslash E$, we get

H_{\delta}(v(\cdot, t)-\widetilde{v}(\cdot))=0 \quad \text { in } \mathbb{R}^{N} \backslash E
$$

for a.e. $t \in(0, T)$, which implies $\zeta=H_{\delta}\left(\llbracket v \rrbracket_{h}-\widetilde{v}\right) \psi$ is a admissible test function in (3.2). Due to $\zeta(\cdot, 0)=0$, the term including $v_{0}$ vanishes. In light of Lemma 2.8 (i) and (iv), we have

H_{\delta}\left(\llbracket v \rrbracket_{h}-\widetilde{v}\right) \psi \rightarrow H_{\delta}(v-\widetilde{v}) \psi \quad \text { as } h \rightarrow 0
$$

and

\nabla\left[H_{\delta}\left(\llbracket v \rrbracket_{h}-\widetilde{v}\right) \psi\right] \rightarrow \nabla\left[H_{\delta}(v-\widetilde{v}) \psi\right] \quad \text { as } h \rightarrow 0
$$

Then we obtain

\lim _{h \rightarrow 0} \iint_{E_{T}}|\nabla v|^{p-2} \nabla v \cdot \nabla \zeta d x d t=\iint_{E_{T}}|\nabla v|^{p-2} \nabla v \cdot \nabla\left[H_{\delta}(v-\widetilde{v}) \psi\right] d x d t
$$

and

$$
\begin{aligned}
& \lim _{h \rightarrow 0} \int_{0}^{T} \int_{\mathbb{R}^{N}} \int_{\mathbb{R}^{N}} V(x, y, t)(\zeta(x, t)-\zeta(y, t)) d \mu d t \\
= & \int_{0}^{T} \int_{\mathbb{R}^{N}} \int_{\mathbb{R}^{N}} V(x, y, t)\left[H_{\delta}(v(x, t)-\widetilde{v}(x)) \psi(x, t)-H_{\delta}(v(y, t)-\widetilde{v}(y)) \psi(y, t)\right] d \mu d t .
\end{aligned}
$$

Thanks to Lemma 2.8 (ii), we estimate the time part as

\begin{aligned}
\iint_{E_{T}} & -v^{q} \partial_{t} \zeta d x d t=\iint_{E_{T}}\left(-\llbracket v \rrbracket_{h}^{q}+\llbracket v \rrbracket_{h}^{q}-v^{q}\right) \partial_{t} \zeta d x d t \\
= & -\iint_{E_{T}} \llbracket v \rrbracket_{h}^{q} \partial_{t} \zeta d x d t+\iint_{E_{T}}\left(\llbracket v \rrbracket_{h}^{q}-v^{q}\right) H_{\delta}\left(\llbracket v \rrbracket_{h}-\widetilde{v}\right) \partial_{t} \psi d x d t \\
& +\iint_{E_{T}}\left(\llbracket v \rrbracket_{h}^{q}-v^{q}\right) H_{\delta}^{\prime}\left(\llbracket v \rrbracket_{h}-\widetilde{v}\right) \frac{1}{h}\left(v-\llbracket v \rrbracket_{h}\right) \psi d x d t
\end{aligned}
$$

$$
\begin{align*}
& \leq \iint_{E_{T}} \partial_{t} \llbracket v \rrbracket_{h}^{q} \zeta d x d t+\iint_{E_{T}}\left(\llbracket v \rrbracket_{h}^{q}-v^{q}\right) H_{\delta}\left(\llbracket v \rrbracket_{h}-\widetilde{v}\right) \partial_{t} \psi d x d t \\
& =-\iint_{E_{T}} h_{\delta}\left(\llbracket v \rrbracket_{h}, \widetilde{v}\right) \partial_{t} \psi d x d t+\iint_{E_{T}}\left(\llbracket v \rrbracket_{h}^{q}-v^{q}\right) H_{\delta}\left(\llbracket v \rrbracket_{h}-\widetilde{v}\right) \partial_{t} \psi d x d t . \tag{3.3}
\end{align*}
$$

Observe that the second term on the right-hand side of (3.3) vanishes as $h \rightarrow 0$ by Lemma 2.8 (i). In addition, we can find

which combines with Lemma 2.8 (i) leads to

So far, we get the desired result with " $\geq$ " by collecting the above estimates. Analogously, we can prove the reverse inequality by choosing $\zeta=H_{\delta}\left(\llbracket v \rrbracket_{\bar{h}}-\widetilde{v}\right) \psi$ as a test function.

Indeed, if taking $\zeta=\widehat{H}_{\delta}\left(\llbracket w \rrbracket_{h}-\widetilde{w}\right) \psi$ as a test function in (3.2) and running similarly, we can obtain the result for the function $w$.

Lemma 3.6. Let $p>1, q>0$, and let $w$ be a nonnegative weak solution to (1.1). Suppose that $\widetilde{w} \in L^{q+1}(E) \cap W_{0}^{1, p}(E)$ is a nonnegative function. For any $\psi \in C_{0}^{\infty}\left(\mathbb{R}^{N} \times(0, T)\right)$, there holds that

& \iint_{E_{T}}-\widehat{h}_{\delta}(w, \widetilde{w}) \partial_{t} \psi+|\nabla w|^{p-2} \nabla w \cdot \nabla\left(\widehat{H}_{\delta}(w-\widetilde{w}) \psi\right) d x d t \\
& +\int_{0}^{T} \int_{\mathbb{R}^{N}} \int_{\mathbb{R}^{N}} W(x, y, t)\left(\widehat{H}_{\delta}(w(x, t)-\widetilde{w}(x)) \psi(x, t)-\widehat{H}_{\delta}(w(y, t)-\widetilde{w}(y)) \psi(y, t)\right) d \mu d t=0 .
\end{aligned}
$$

Now we are ready to prove Proposition 3.4 by using the argument proposed in 31.
Proof of Proposition 3.4. We set

Let $0 \leq \psi \in C_{0}^{\infty}\left((0, T)^{2}\right)$, and extend functions $v$ and $w$ to $\widetilde{Q}$ with

For fixed $\delta>0$ and a.e. $t_{2} \in(0, T)$, we note that $H_{\delta}, \widetilde{v}(x)=w\left(x, t_{2}\right)=$ : $w_{t_{2}}(x), \widetilde{v}(y)=$ $w\left(y, t_{2}\right)=: w_{t_{2}}(y)$, and $\psi_{t_{2}}\left(t_{1}\right):=\psi\left(t_{1}, t_{2}\right)$ for $t_{1} \in(0, T)$ are allowed in Lemma 3.5 based on the fact $v=0$ in $\mathbb{R}^{N} \backslash E \times(0, T]$. Thus, it holds that

& \iint_{E_{T}}-h_{\delta}\left(v, w_{t_{2}}\right) \partial_{t_{1}} \psi_{t_{2}}+|\nabla v|^{p-2} \nabla v \cdot \nabla\left[H_{\delta}\left(v\left(x, t_{1}\right)-w_{t_{2}}\right) \psi_{t_{2}}\right] d x d t_{1} \\
& +\int_{0}^{T} \int_{\mathbb{R}^{N}} \int_{\mathbb{R}^{N}} V\left(x, y, t_{1}\right)\left[H_{\delta}\left(v\left(x, t_{1}\right)-w_{t_{2}}\right)-H_{\delta}\left(v\left(y, t_{1}\right)-w_{t_{2}}\right)\right] \psi_{t_{2}} d \mu d t_{1}=0 \tag{3.4}
\end{align*}
$$

Likewise, for fixed $\delta>0$ and a.e. $t_{1} \in(0, T)$, we note that $\widehat{\mathcal{H}}_{\delta}, \widetilde{w}(x)=v\left(x, t_{1}\right)=: v_{t_{1}}(x)$, $\widetilde{w}(y)=v\left(y, t_{1}\right)=: v_{t_{1}}(y)$, and $\psi_{t_{1}}\left(t_{2}\right):=\psi\left(t_{1}, t_{2}\right)$ for $t_{2} \in(0, T)$ are permitted in Lemma 3.6 due to $v=0$ in $\mathbb{R}^{N} \backslash E \times(0, T]$. Subsequently, we get

\iint_{E_{T}}-\widehat{h}_{\delta}\left(w, v_{t_{1}}\right) \partial_{t_{2}} \psi_{t_{1}}+|\nabla w|^{p-2} \nabla w \cdot \nabla\left(\widehat{H}_{\delta}\left(w\left(x, t_{2}\right)-v_{t_{1}}\right) \psi_{t_{1}}\right) d x d t_{2}
$$

$$
\begin{equation*}
+\int_{0}^{T} \int_{\mathbb{R}^{N}} \int_{\mathbb{R}^{N}} W\left(x, y, t_{2}\right)\left(\widehat{H}_{\delta}\left(w\left(x, t_{2}\right)-v_{t_{1}}\right)-\widehat{H}_{\delta}\left(w\left(y, t_{2}\right)-v_{t_{1}}\right)\right) \psi_{t_{1}} d \mu d t_{2}=0 \tag{3.5}
\end{equation*}
$$

Integrating (3.4) over $t_{2} \in(0, T)$, (3.5) over $t_{1} \in(0, T)$, and adding two integral equalities yields that

& \iiint_{\widetilde{Q}}-\left(h_{\delta}(v, w) \partial_{t_{1}} \psi+\widehat{h}_{\delta}(w, v) \partial_{t_{2}} \psi\right) d x d t_{1} d t_{2} \\
& +\iiint_{\widetilde{Q}}\left(|\nabla v|^{p-2} \nabla v-|\nabla w|^{p-2} \nabla w\right) \cdot \nabla\left[H_{\delta}(v-w)\right] \psi d x d t_{1} d t_{2} \\
& +\int_{0}^{T} \int_{0}^{T} \int_{\mathbb{R}^{N}} \int_{\mathbb{R}^{N}}\left[V\left(x, y, t_{1}, t_{2}\right)-W\left(x, y, t_{1}, t_{2}\right)\right] \\
& \quad \times\left[H_{\delta}(v-w)\left(x, t_{1}, t_{2}\right)-H_{\delta}(v-w)\left(y, t_{1}, t_{2}\right)\right] \psi d \mu d t_{1} d t_{2}=0 \tag{3.6}
\end{align*}
$$

where we employed the property $H_{\delta}(z)=-\widehat{H}_{\delta}(-z)$. Before sending $\delta \rightarrow 0$, we treat the local and nonlocal terms that do not possess a regular limit. For the second term in (3.6), recalling the algebraic inequality

For the nonlocal term, it infers from the Mean Value Theorem that there exists a function $\xi$ which lies between $(v-w)\left(x, t_{1}, t_{2}\right)$ and $(v-w)\left(y, t_{1}, t_{2}\right)$ such that

## 4. Energy estimate and local boundedness

4.1. Energy estimate. In this section, we first present the Caccioppoli-type inequality which can proceed similarly as in [4].
Lemma 4.1. Let $p>1$ and $q>0$. Let $u$ be a nonnegative weak subsolution to (1.1) and let $Q_{\rho, s}=K_{\rho}\left(x_{0}\right) \times\left(t_{0}-s, t_{0}\right] \subset \subset E_{T}$. For any nonnegative, piecewise smooth cutoff function $\psi$ vanishing on $\partial K_{\rho}\left(x_{0}\right) \times\left(t_{0}-s, t_{0}\right)$, there exists a constant $\gamma(N, p, s, q, \Lambda)>0$ such that

4.2. Local boundedness. In the following, we devote to showing the quantitative $L^{\infty}$ bound of weak solutions to (1.1) presented in Theorem [1.2] To start with, we deduce an iterative inequality.
4.2.1. An iterative inequality for $r \geq q+1$. Let $\left(x_{0}, t_{0}\right)=(0,0)$. For $\sigma \in(0,1)$, define decreasing sequences

4.2.3. The case $r \leq m$ and $r<q+1$. Since $r<q+1$, it is not hard to find $0<\lambda_{r}<\lambda_{q+1}$, from which we can deduce that $q+1<m$. Hence, we can exploit estimate (4.15) in the first case directly by replacing $q+1$ with $r$. For any $\sigma \in(0,1)$, we have

4.2.4. The case $r>m$. According to the assumption $\lambda_{r}>0$, we can see $r>q+1$ from $r>m$. If not, there will hold $0<\lambda_{r} \leq \lambda_{q+1}=N(m-q-1)$, which implies that $q+1<m$, and this would yield a contradiction. In this case, we assume a prior that $u \in L_{\mathrm{loc}}^{\infty}\left(E_{T}\right)$ due to the embedding Lemma 2.7 generally not true. By iterative inequality (4.13) and the definition of $Y_{j}$, we have

## 5. Integral-type Harnack inequality

In this section, we will derive Theorem 1.5 which is a direct result from Theorem 1.2 and the following integral-type Harnack inequality

Proposition 5.1. Let $0<p-1<q<p^{2}-1, \rho \in(0,1]$ and $K_{2 \rho}(\bar{y}) \times[s, \tau] \subset \subset E_{T}$. Assume that $u$ is a nonnegative weak solution to (1.1). Then there exists a constant $\gamma>0$ depending only on $N, p, s, q, \Lambda$ such that

& \leq \frac{\gamma \rho}{(1-\sigma)^{p}}\left(\frac{\tau}{\rho^{\lambda}}\right)^{\frac{1}{p}}\left(\sup _{t \in[0, \tau]} \int_{K_{\rho} \times\{t\}} u^{q} d x+\kappa^{q} \rho^{N}\right)^{\frac{(p-1)(q+1)}{p q}} \tag{5.6}
\end{align*}
$$

Estimate of $I_{4}$ : Notice that

$$
\frac{|y|}{|y-x|} \leq 1+\frac{|x|}{|y-x|} \leq 1+\frac{1+\sigma}{1-\sigma} \leq \frac{2}{1-\sigma}
$$

for any $|x| \leq \frac{(1+\sigma) \rho}{2}$ and $|y| \geq \rho$, thus there holds

$$
\begin{align*}
I_{4} & \leq \frac{\gamma 2^{N+s p}}{(1-\sigma)^{N+s p} \rho^{s p}} \int_{0}^{\tau} \int_{K_{\rho}} t^{\frac{1}{p}}(u(x, t)+\kappa)^{\frac{p^{2}-1-q}{p}} d x d t \\
& \leq \frac{\gamma 2^{N+s p} \rho}{(1-\sigma)^{N+s p}}\left(\frac{\tau}{\rho^{\lambda}}\right)^{\frac{1}{p}}\left(\sup _{t \in[0, \tau]} \int_{K_{\rho} \times\{t\}} u^{q} d x+\kappa^{q} \rho^{N}\right)^{\frac{(p-1)(q+1)}{p q}} \tag{5.7}
\end{align*}
$$

On the other hand, the left-hand side of (5.3) can be estimated by utilizing Lemma 2.1 with $\alpha=\frac{p^{2}-q-1}{p^{2}}>0$ and the property $\zeta=1$ in $K_{\sigma \rho}$, it gives

& \int_{0}^{\tau} \int_{K_{\rho}} \int_{K_{\rho}} t^{\frac{1}{p}} \frac{\left|\zeta(x)(u(x, t)+\kappa)^{\frac{p^{2}-q-1}{p^{2}}}-\zeta(y)(u(y, t)+\kappa)^{\frac{p^{2}-q-1}{p^{2}}}\right|^{p}}{|x-y|^{N+s p}} d x d y d t \\
\geq & \int_{0}^{\tau} \int_{K_{\sigma \rho}} \int_{K_{\sigma \rho}} t^{\frac{1}{p}} \frac{\left\lvert\,(u(x, t)+\kappa)^{\frac{p^{2}-q-1}{p^{2}}}-(u(y, t)+\kappa)^{\left.\frac{p^{2}-q-1}{p^{2}}\right|^{p}}\right.}{|x-y|^{N+s p}} d x d y d t \\
\geq & \int_{0}^{\tau} \int_{K_{\sigma \rho}} \int_{K_{\sigma \rho}} t^{\frac{1}{p}}(|u(x, t)+\kappa|+|u(y, t)+\kappa|)^{-\frac{q+1}{p}} \frac{|u(x, t)-u(y, t)|^{p}}{|x-y|^{N+s p}} d x d y d t . \tag{5.8}
\end{align*}
$$

Combining estimates (5.3)-(5.8), we get the conclusion.

Given Lemma 5.3, we can explore the following result.
Lemma 5.4. Let $0<p-1<q<p^{2}-1, \rho \in(0,1]$ and $K_{\rho}(\bar{y}) \times[s, \tau] \subset \subset E_{T}$. Assume that $u$ is a nonnegative weak supersolution to (1.1). For all $\delta, \sigma \in(0,1)$, there exists a constant $\gamma>0$ depending only on $N, p, s, q, \Lambda$ such that

& \quad \leq \delta \sup _{t \in[s, \tau]} \int_{K_{\rho}(\bar{y}) \times\{t\}} u^{q} d x+\frac{\gamma}{\left[\delta^{q+1}(1-\sigma)^{p q}\right]^{\frac{N+p}{q+1-p}}}\left(\frac{\tau-s}{\rho^{\lambda}}\right)^{\frac{q}{q+1-p}},
\end{aligned}
$$

where $\lambda$ and $\kappa$ defined in (5.1).
Proof. Let $(\bar{y}, s)=(0,0)$. We derive from Hölder's inequality that

& \times\left(\int_{0}^{\tau} \int_{K_{\sigma \rho}}(u+\kappa)^{\frac{(p-1)(q+1)}{p}} t^{\frac{1-p}{p}} d x d t\right)^{\frac{1}{p}} \tag{5.9}
\end{align*}
$$

The estimate of the first integral on the right-hand side of (5.9) yields from Lemma 5.3 Coming to estimate the second integral, there holds by using Hölder's inequality that

& \int_{0}^{\tau} \int_{K_{\sigma \rho}}(u+\kappa)^{\frac{(p-1)(q+1)}{p}} t^{\frac{1-p}{p}} d x d t \\
& \leq \int_{0}^{\tau} t^{\frac{1-p}{p}} d t \times \sup _{t \in[0, \tau]} \int_{K_{\sigma \rho} \times\{t\}}(u+\kappa)^{\frac{(p-1)(q+1)}{p}} d x \\
& \leq \gamma \rho\left(\frac{\tau}{\rho^{\lambda}}\right)^{\frac{1}{p}}\left(\sup _{t \in[0, \tau]} \int_{K_{\sigma \rho} \times\{t\}} u^{q} d x+\kappa^{q} \rho^{N}\right)^{\frac{(p-1)(q+1)}{p q}} \tag{5.10}
\end{align*}
$$

Still by Hölder's inequality, we compute

& \int_{0}^{\tau} \int_{K_{\sigma \rho}} \int_{K_{\sigma \rho}} \frac{|u(x, t)-u(y, t)|^{p-1}}{|x-y|^{N+s p-1}} d x d y d t \\
\leq & \left(\int_{0}^{\tau} \int_{K_{\sigma \rho}} \int_{K_{\sigma \rho}} \frac{|u(x, t)-u(y, t)|^{p}}{|x-y|^{N+s p}}(u(x, t)+\kappa)^{-\frac{q+1}{p}} t^{\frac{1}{p}} d x d y d t\right)^{\frac{p-1}{p}} \\
& \times\left(\int_{0}^{\tau} \int_{K_{\sigma \rho}} \int_{K_{\sigma \rho}} \frac{(u(x, t)+\kappa)^{\frac{(p-1)(q+1)}{p}}}{|x-y|^{N+s p-p}} t^{\frac{1-p}{p}} d x d y d t\right)^{\frac{1}{p}} . \tag{5.11}
\end{align*}
$$

The first integral on the right-hand side of (5.11) has been provided in Lemma 5.3. We deal with the second integral as in (5.10) and obtain

\int_{0}^{\tau} \int_{K_{\sigma \rho}} \int_{K_{\sigma \rho}} \frac{(u(x, t)+\kappa)^{\frac{(p-1)(q+1)}{p}}}{|x-y|^{N+s p-p}} t^{\frac{1-p}{p}} d x d y d t

$$
\leq \gamma \rho\left(\frac{\tau}{\rho^{\lambda}}\right)^{\frac{1}{p}}\left(\sup _{t \in[0, \tau]} \int_{K_{\sigma \rho} \times\{t\}} u^{q} d x+\kappa^{q} \rho^{N}\right)^{\frac{(p-1)(q+1)}{p q}}
$$

where we used the assumption $\sigma \in(0,1)$, and the radius $\rho \in(0,1]$. Putting the above estimates together, employing Young's inequality as well as the definition of $\kappa$ in (5.1), we infer that

& \int_{0}^{\tau} \int_{K_{\sigma \rho}}|\nabla u|^{p-1} d x d t+\int_{0}^{\tau} \int_{K_{\sigma \rho}} \int_{K_{\sigma \rho}} \frac{|u(x, t)-u(y, t)|^{p-1}}{|x-y|^{N+s p-1}} d x d y d t \\
& \leq \frac{\gamma \rho}{(1-\sigma)^{N+p}}\left(\frac{\tau}{\rho^{\lambda}}\right)^{\frac{1}{p}}\left(\sup _{t \in[0, \tau]} \int_{K_{\rho} \times\{t\}} u^{q} d x+\kappa^{q} \rho^{N}\right)^{\frac{(p-1)(q+1)}{p q}} \\
& \leq \delta \rho \sup _{t \in[0, \tau]} \int_{K_{\rho} \times\{t\}} u^{q} d x+\frac{\gamma \rho}{\left[\delta^{q+1}(1-\sigma)^{p q}\right]^{\frac{N+p}{q+1-p}}}\left(\frac{\tau}{\rho^{\lambda}}\right)^{\frac{q}{q+1-p}}
\end{aligned}
$$

where the constant $\delta \in(0,1)$ depends on $p, q$. Diving both sides by $\rho$, we arrive at the claim.

Hereafter, we give the proof of Proposition 5.1.
Proof of Proposition 5.1. Assume that $(\bar{y}, s)=(0,0)$. Denote

Consider the function $\zeta \in C_{0}^{1}\left(\widetilde{K}_{j} ;[0,1]\right)$ that vanishes outside $\widehat{K}_{j}$, equals to 1 in $K_{j}$ such that $|\nabla \zeta| \leq 2^{j+3} / \rho$. Testing (1.6) with $\zeta$, there holds for any $t_{1}, t_{2} \in[0, \tau]$ that

\int_{\widetilde{K}_{j} \times\left\{t_{1}\right\}} u^{q} \zeta d x \leq & \int_{\widetilde{K}_{j} \times\left\{t_{2}\right\}} u^{q} \zeta d x+\frac{2^{j+3}}{\rho} \int_{t_{1}}^{t_{2}} \int_{\widetilde{K}_{j}}|\nabla u|^{p-1} d x d t \\
& +\frac{2^{j+3}}{\rho} \int_{t_{1}}^{t_{2}} \int_{\widetilde{K}_{j}} \int_{\widetilde{K}_{j}} \frac{|u(x, t)-u(y, t)|^{p-1}}{|x-y|^{N+s p-1}} d x d y d t \\
& +2 \int_{t_{1}}^{t_{2}} \int_{\widetilde{K}_{j}} \int_{\mathbb{R}^{N} \backslash \widetilde{K}_{j}} \frac{|u(x, t)-u(y, t)|^{p-1}}{|x-y|^{N+s p}} \zeta(x) d x d y d t . \tag{5.12}
\end{align*}
$$

Through direct computation,

$$
\frac{|y|}{|y-x|} \leq 1+\frac{|x|}{|y-x|} \leq 1+\frac{\widehat{\rho}_{j}}{\widetilde{\rho}_{j}-\widehat{\rho}_{j}} \leq 2^{j+3}
$$

for any $|x| \leq \widehat{\rho}_{j}$ and $|y| \geq \widetilde{\rho}_{j}$, thus the last term in (5.12) can be estimated as

& \int_{t_{1}}^{t_{2}} \int_{\widetilde{K}_{j}} \int_{\mathbb{R}^{N} \backslash \widetilde{K}_{j}} \frac{|u(x, t)-u(y, t)|^{p-1}}{|x-y|^{N+s p}} \zeta(x) d x d y d t \\
\leq & \frac{\tau 2^{(j+3)(N+s p)}}{\rho^{p-N}}\left[\operatorname{Tail}_{\infty}(u ; 0, \rho ; 0, \tau)\right]^{p-1} . \tag{5.13}
\end{align*}

For $t_{1}>t_{2}$, we may test (1.6) by $-\zeta$ instead of $\zeta$. To proceed, we set

S_{j} \leq & A+\frac{2^{j+3}}{\rho} \int_{0}^{\tau} \int_{\widetilde{K}_{j}}|\nabla u|^{p-1} d x d t+\frac{2^{j+3}}{\rho} \int_{0}^{\tau} \int_{\widetilde{K}_{j}} \int_{\widetilde{K}_{j}} \frac{|u(x, t)-u(y, t)|^{p-1}}{|x-y|^{N+s p-1}} d x d y d t \\
& +\frac{\tau 2^{(j+4)(N+s p)}}{\rho^{p-N}}\left[\operatorname{Tail}_{\infty}(u ; 0, \rho ; 0, \tau)\right]^{p-1} \tag{5.14}
\end{align*}
$$

From the definition of $\rho_{j}$, we can get $\rho \leq \rho_{j}<2 \rho$. Selecting $\sigma$ small enough such that $1-\sigma \geq 2^{-(j+4)}$, and we deduce from Lemma 5.4 that

\begin{aligned}
& \frac{1}{2 \rho} \int_{0}^{\tau} \int_{\widetilde{K}_{j}}|\nabla u|^{p-1} d x d t+\frac{1}{2 \rho} \int_{0}^{\tau} \int_{\widetilde{K}_{j}} \int_{\widetilde{K}_{j}} \frac{|u(x, t)-u(y, t)|^{p-1}}{|x-y|^{N+s p-1}} d x d y d t \\
\leq & \frac{1}{\rho_{j+1}} \int_{0}^{\tau} \int_{\widetilde{K}_{j}}|\nabla u|^{p-1} d x d t+\frac{1}{\rho_{j+1}} \int_{0}^{\tau} \int_{\widetilde{K}_{j}} \int_{\widetilde{K}_{j}} \frac{|u(x, t)-u(y, t)|^{p-1}}{|x-y|^{N+s p-1}} d x d y d t \\
\leq & \delta \sup _{t \in[0, \tau]} \int_{K_{j+1} \times\{t\}} u^{q} d x+\frac{\gamma}{\left[\delta^{q+1}(1-\sigma)^{p q}\right]^{\frac{N+p}{q+1-p}}}\left(\frac{\tau}{\rho_{j+1}^{\lambda}}\right)^{\frac{q}{q+1-p}} \\
\leq & \delta S_{j+1}+\frac{\gamma 2^{j \frac{p q(N+p)}{q+1-p}}}{\delta^{\frac{(q+1)(N+p)}{q+1-p}}}\left(\frac{\tau}{\rho^{\lambda}}\right)^{\frac{q}{q+1-p}} .
\end{aligned}
$$

Multiplying both sides of the above inequality by $2^{j+4}$ leads to

& \frac{2^{j+3}}{\rho} \int_{0}^{\tau} \int_{\widetilde{K}_{j}}|\nabla u|^{p-1} d x d t+\frac{2^{j+3}}{\rho} \int_{0}^{\tau} \int_{\widetilde{K}_{j}} \int_{\widetilde{K}_{j}} \frac{|u(x, t)-u(y, t)|^{p-1}}{|x-y|^{N+s p-1}} d x d y d t \\
\leq & \delta 2^{j+4} S_{j+1}+\frac{\gamma 2^{j\left[1+\frac{p q(N+p)}{q+1-p]}\right.}}{\delta^{\frac{(q+1)(N+p)}{q+1-p}}}\left(\frac{\tau}{\rho^{\lambda}}\right)^{\frac{q}{q+1-p}}
\end{aligned}
$$

For some $\varepsilon \in(0,1)$, letting $\delta=\varepsilon / 2^{j+4}$ to get

$$
\begin{align*}
& \frac{2^{j+3}}{\rho} \int_{0}^{\tau} \int_{\widetilde{K}_{j}}|\nabla u|^{p-1} d x d t+\frac{2^{j+3}}{\rho} \int_{0}^{\tau} \int_{\widetilde{K}_{j}} \int_{\widetilde{K}_{j}} \frac{|u(x, t)-u(y, t)|^{p-1}}{|x-y|^{N+s p-1}} d x d y d t \\
\leq & \varepsilon S_{j+1}+\gamma(\varepsilon) b^{j}\left(\frac{\tau}{\rho^{\lambda}}\right)^{\frac{q}{q+1-p}} \tag{5.15}
\end{align*}
$$

with $b=b(p, q, N)>1$. By virtue of (5.14) and (5.15), we have for any $j \in \mathbb{N} \cup\{0\}$ that

$$
\begin{equation*}
S_{j} \leq \varepsilon S_{j+1}+\gamma(\varepsilon) b^{j}\left(A+\left(\frac{\tau}{\rho^{\lambda}}\right)^{\frac{q}{q+1-p}}+\tau \rho^{N-p}\left[\operatorname{Tail}_{\infty}(u ; 0, \rho ; 0, \tau)\right]^{p-1}\right) \tag{5.16}
\end{equation*}
$$

Iterating inequality (5.16) gives that

S_{0} \leq \varepsilon^{j} S_{j}+\gamma(\varepsilon)\left(A+\left(\frac{\tau}{\rho^{\lambda}}\right)^{\frac{q}{q+1-p}}+\tau \rho^{N-p}\left[\operatorname{Tail}_{\infty}(u ; 0, \rho ; 0, \tau)\right]^{p-1}\right) \sum_{i=0}^{j-1}(\varepsilon b)^{i}
$$

Then, by letting $\varepsilon=1 / 2 b$, we get $\sum_{i=0}^{j-1}(\varepsilon b)^{i} \leq 2$, and meanwhile $\varepsilon^{j} S_{j} \rightarrow 0$ as $j \rightarrow \infty$. The proof is completed by recalling the definitions of $S_{j}$ and $A$.

Finally, Theorem 1.5 follows from a combination of Theorem 1.2 and Proposition 5.1 .

## 6. Expansion of positivity

This section aims to obtain the following result regarding the expansion of positivity, which derives the pointwise estimate for weak supersolutions from the measure theoretical condition.
Proposition 6.1. Let $0<p-1 \leq q$. Assume that $u \in L^{\infty}\left(\mathbb{R}^{N} \times(0, T)\right)$ is a nonnegative, weak supersolution to (1.1). If for some constants $M>0, \alpha \in(0,1)$ we have

$$
\begin{equation*}
\left|\left[u\left(\cdot, t_{0}\right) \geq M\right] \cap K_{\rho}\left(x_{0}\right)\right| \geq \alpha\left|K_{\rho}\right|, \tag{6.1}
\end{equation*}
$$

then there exist parameters $\delta, \eta \in(0,1)$ depending only on $N, p, s, q, \Lambda, \alpha$ such that

$$
u \geq \eta M \quad \text { a.e. in } K_{2 \rho}\left(x_{0}\right) \times\left(t_{0}+\frac{1}{2} \delta M^{q+1-p} \rho^{p}, t_{0}+\delta M^{q+1-p} \rho^{p}\right]
$$

provided

$$
K_{8 \rho}\left(x_{0}\right) \times\left(t_{0}, t_{0}+\delta M^{q+1-p} \rho^{p}\right] \subset E_{T}
$$

Before proving Proposition 6.1 we give several preparatory estimates. The first one is a De Giorgi-type lemma.

Lemma 6.2. Let $q>0, p>1$, and let $u \in L^{\infty}\left(\mathbb{R}^{N} \times(0, T)\right)$ be a nonnegative, weak supersolution to (1.1). For some constants $M>0$ and $\delta \in(0,1)$, assume that $\rho \in(0,1]$ and $\left(x_{0}, t_{0}\right)+Q_{\rho}(\theta) \subset E_{T}$, where $\theta=\delta M^{q+1-p}$. If there is a constant $\nu \in(0,1)$ only depending on $N, p, s, q, \Lambda$ and $\delta$ such that

$$
\left|[u \leq M] \cap\left(x_{0}, t_{0}\right)+Q_{\rho}(\theta)\right| \leq \nu\left|Q_{\rho}(\theta)\right|,
$$

then we have

$$
u \geq \frac{1}{2} M \quad \text { a.e. in }\left(x_{0}, t_{0}\right)+Q_{\frac{1}{2} \rho}(\theta)
$$

Proof. Let $\left(x_{0}, t_{0}\right)=(0,0)$. Take decreasing sequences

$$
k_{j}=\frac{M}{2}+\frac{M}{2^{j+1}}, \quad j=0,1,2 \ldots
$$

Denote

$$
\rho_{j}=\frac{\rho}{2}+\frac{\rho}{2^{j+1}}, \quad \widetilde{\rho}_{j}=\frac{\rho_{j}+\rho_{j+1}}{2}, \quad \widehat{\rho}_{j}=\frac{3 \rho_{j}+\rho_{j+1}}{4}, \quad j=0,1,2 \ldots
$$

Set the domains

$$
K_{j}=K_{\rho_{j}}, \quad \widetilde{K}_{j}=K_{\widetilde{\rho}_{j}}, \quad \widehat{K}_{j}=K_{\widehat{\rho}_{j}}, \quad j=0,1,2 \ldots
$$

and

$$
Q_{j}=K_{j} \times\left(-\theta \rho_{j}^{p}, 0\right], \quad \widetilde{Q}_{j}=\widetilde{K}_{j} \times\left(-\theta \widetilde{\rho}_{j}^{p}, 0\right], \quad \widehat{Q}_{j}=\widehat{K}_{j} \times\left(-\theta \widehat{\rho}_{j}^{p}, 0\right], \quad j=0,1,2 \ldots
$$

Consider the cutoff function $0 \leq \zeta \leq 1$ in $Q_{j}$ vanishing outside $\widehat{Q}_{j}$, and equals to 1 in $\widetilde{Q}_{j}$, such that

$$
|\nabla \zeta| \leq \frac{2^{j+4}}{\rho} \quad \text { and } \quad\left|\partial_{t} \zeta\right| \leq \frac{2^{p(j+4)}}{\theta \rho^{p}}
$$

An application of the energy estimate (4.1) and Lemma 2.2 in this setting leads to

\begin{align*}
& \quad \underset{-\theta \rho_{j}^{p}<t<0}{\operatorname{ess} \sup _{K_{j}}} \int_{K_{j}} \zeta^{p}\left(u+k_{j}\right)^{q-1}\left(u-k_{j}\right)_{-}^{2} d x+\iint_{Q_{j}} \zeta^{p}\left|\nabla\left(u-k_{j}\right)_{-}\right|^{p} d x d t \\
& \leq \gamma \iint_{Q_{j}}\left(u+k_{j}\right)^{q-1}\left(u-k_{j}\right)_{-}^{2}\left|\partial_{t} \zeta\right| d x d t+\gamma \iint_{Q_{j}}\left(u-k_{j}\right)_{-}^{p}|\nabla \zeta|^{p} d x d t \\
& \quad+\gamma \int_{-\theta \rho_{j}^{p}}^{0} \int_{K_{j}} \int_{K_{j}} \max \left\{\left(u-k_{j}\right)_{-}(x, t),\left(u-k_{j}\right)_{-}(y, t)\right\}^{p}|\zeta(x, t)-\zeta(y, t)|^{p} d \mu d t \\
& \quad+\gamma{\operatorname{ess} \sup _{\substack{p \\
-\theta \rho_{j}^{p}<t<0 \\

With the help of (6.18), we can employ Lemma 6.4 to derive that for given $\nu \in(0,1)$, there exists $\xi \in(0,1)$ depending only on $N, p, s, q, \Lambda, \nu, \delta, \alpha$ such that

$$
\left|[u(\cdot, t) \leq \xi \varepsilon M] \cap K_{4 \rho}\left(x_{0}\right)\right| \leq \nu\left|K_{4 \rho}\right|
$$

for

$$
t \in\left(t_{0}+\frac{1}{2} \delta(\varepsilon M)^{q+1-p}(4 \rho)^{p}, t_{0}+\delta(\varepsilon M)^{q+1-p}(4 \rho)^{p}\right]
$$

Notice for every time

$$
\bar{t} \in\left(t_{0}+\frac{3}{4} \delta(\varepsilon M)^{q+1-p}(4 \rho)^{p}, t_{0}+\delta(\varepsilon M)^{q+1-p}(4 \rho)^{p}\right]
$$

we have

$$
\left(x_{0}, \bar{t}\right)+Q_{4 \rho}(\theta) \subset K_{4 \rho}\left(x_{0}\right) \times\left(t_{0}+\frac{1}{2} \delta(\varepsilon M)^{q+1-p}(4 \rho)^{p}, t_{0}+\delta(\varepsilon M)^{q+1-p}(4 \rho)^{p}\right]
$$

with $\theta=\frac{1}{4} \delta(\xi \varepsilon M)^{q-1+p}$. Thus, we deduce for any $\bar{t}$ that

$$
\begin{equation*}
\left|[u \leq \xi \varepsilon M] \cap\left(x_{0}, \bar{t}\right)+Q_{4 \rho}(\theta)\right| \leq \nu\left|Q_{4 \rho}(\theta)\right| . \tag{6.19}
\end{equation*}
$$

Thanks to the measure information (6.19), it permits us to exploit the De Giorgi-type Lemma 6.2 in $\left.\left(x_{0}, \bar{t}\right)+Q_{4 \rho}(\theta)\right)$ with $M$ replaced by $\xi \varepsilon M$, we also choose $\nu$ from Lemma 6.2, then we deduce that

$$
u \geq \frac{1}{2} \xi \varepsilon M \quad \text { a.e. } \operatorname{in}\left(x_{0}, \bar{t}\right)+Q_{2 \rho}(\theta)
$$

Due to the arbitrariness of $\bar{t}$, we get the desired results.

## 7. Harnack inequality

In this section, we devote to establishing the Harnack inequality in Theorem 1.6. The first step is going to scale functions.
7.1. Scaling functions. Change the variables

$$
z \rightarrow \frac{x-x_{0}}{\rho}, \quad z^{\prime} \rightarrow \frac{y-x_{0}}{\rho}, \quad \tau \rightarrow\left[u\left(x_{0}, t_{0}\right)\right]^{p-q-1} \frac{t-t_{0}}{\rho^{p}} .
$$

Consider the following rescaled function

$$
\begin{equation*}
v(z, \tau):=\frac{u\left(x_{0}+\rho z, t_{0}+\left[u\left(x_{0}, t_{0}\right)\right]^{q+1-p} \rho^{p} \tau\right)}{u\left(x_{0}, t_{0}\right)} \quad \text { in } \widetilde{Q}_{8}=K_{8} \times\left(-8^{p}, 8^{p}\right) \tag{7.1}
\end{equation*}
$$

Via formula calculation, we can check that $v(0,0)=1$ and $v$ is a bounded continuous nonnegative solution to

$$
\begin{align*}
& \partial_{\tau} v^{q}-\operatorname{div}\left(|\nabla v|^{p-2} \nabla v\right) \\
& \quad+\text { P.V. } \int_{\mathbb{R}^{N}} \widetilde{K}\left(z, z^{\prime}, \tau\right)\left|v(z, \tau)-v\left(z^{\prime}, \tau\right)\right|^{p-2}\left(v(z, \tau)-v\left(z^{\prime}, \tau\right)\right) d z^{\prime}=0 \quad \text { in } \widetilde{Q}_{8} \tag{7.2}
\end{align*}
$$

with

$$
\widetilde{K}\left(z, z^{\prime}, \tau\right)=\rho^{N+p} K\left(x_{0}+\rho z, x_{0}+\rho z^{\prime}, t_{0}+\left[u\left(x_{0}, t_{0}\right)\right]^{q+1-p} \rho^{p} \tau\right)
$$

satisfying

$$
\frac{\rho^{p-s p} \Lambda^{-1}}{\left|z-z^{\prime}\right|^{N+s p}} \leq \widetilde{K}\left(z, z^{\prime}, \tau\right) \leq \frac{\rho^{p-s p} \Lambda}{\left|z-z^{\prime}\right|^{N+s p}}
$$

Now, our intention turns to demonstrate there exist $\gamma>1$ and $\sigma \in(0,1)$ depending only on $N, p, s, q, \Lambda$ and $\|u\|_{L^{\infty}\left(\mathbb{R}^{N} \times(0, T)\right)}$ such that

$$
\begin{equation*}
v \geq \gamma^{-1} \quad \text { in } K_{1} \times(-\sigma, \sigma) \tag{7.3}
\end{equation*}
$$

Notice the Harnack inequality on the left-hand side is a straightforward consequence of (7.3).
7.2. The supremum of function $v$ in $K_{1}$. For $\tau \in(0,1)$, define

$$
M_{\tau}:=\sup _{K_{\tau}} v(\cdot, 0), \quad N_{\tau}:=(1-\tau)^{-\beta}, \quad \text { where } \beta=\frac{p}{q+1-p}
$$

Observe that $M_{0}=N_{0}=1, N_{\tau} \rightarrow \infty$ as $\tau \rightarrow 1$, and $M_{\tau}$ is bounded due to $v$ is a bounded function. Therefore, due to $M_{\tau}=N_{\tau}$ must have roots, we denote the largest one by $\tau_{*}$, specifically,

$$
M_{\tau_{*}}=N_{\tau_{*}} \quad \text { and } \quad M_{\tau} \leq N_{\tau} \quad \text { for all } \tau \geq \tau_{*}
$$

Pick $\bar{\tau} \in\left(\tau_{*}, 1\right)$ such that

$$
N_{\bar{\tau}}=(1-\bar{\tau})^{-\beta}=4\left(1-\tau_{*}\right)^{-\beta}, \quad \text { i.e., } \quad \bar{\tau}=1-4^{-\frac{1}{\beta}}\left(1-\tau_{*}\right),
$$

and let

$$
2 r:=\bar{\tau}-\tau_{*}=\left(1-4^{-\frac{1}{\beta}}\right)\left(1-\tau_{*}\right) .
$$

Clearly, $M_{\tau_{*}}$ can be achieved at some $\bar{x} \in K_{\tau_{*}}$ because $v$ is a continuous function. Hence, there holds $K_{2 r}(\bar{x}) \subset K_{\bar{\tau}}, M_{\bar{\tau}} \leq N_{\bar{\tau}}$, and

$$
\sup _{K_{\tau_{*}}} v(\cdot, 0)=M_{\tau_{*}}=v(\bar{x}, 0) \leq \sup _{K_{2 r}(\bar{x})} v(\cdot, 0)
$$

$$
\begin{equation*}
\leq \sup _{K_{\bar{\tau}}} v(\cdot, 0)=M_{\bar{\tau}} \leq N_{\bar{\tau}}=4\left(1-\tau_{*}\right)^{-\beta} . \tag{7.4}
\end{equation*}
$$

7.3. Expanding of positivity of $v$. Set the cylinder

$$
\widetilde{Q}_{r}\left(\theta_{*}\right):=K_{r}(\bar{x}) \times\left(-\theta_{*} r^{p}, \theta_{*} r^{p}\right), \quad \theta_{*}:=\left(1-\tau_{*}\right)^{-\beta(q+1-p)}
$$

with center $(\bar{x}, 0)$. By the choices of $\beta$ and $r$, we compute

$$
\begin{equation*}
\theta_{*} r^{p}=\left(1-\tau_{*}\right)^{-p} r^{p}=2^{-p}\left(1-4^{-\frac{1}{\beta}}\right)^{p}=: c, \tag{7.5}
\end{equation*}
$$

which implies that

$$
\widetilde{Q}_{2 r}\left(\theta_{*}\right)=K_{2 r}(\bar{x}) \times\left(-2^{p} c, 2^{p} c\right) .
$$

Obviously,

$$
\begin{equation*}
r=c^{\frac{1}{p}}\left(1-\tau_{*}\right) \tag{7.6}
\end{equation*}
$$

We next discuss the estimate of the supremum of $v$ in $\widetilde{Q}_{r}\left(\theta_{*}\right)$.
Lemma 7.1. Let $v$ be defined as in (7.1) and $0<p-1<q<\min \left\{p^{2}-1, \frac{N(p-1)}{(N-p)_{+}}\right\}$. There exists a constant $\gamma$ depending only on $N, p, s, q, \Lambda,\|u\|_{L^{\infty}\left(\mathbb{R}^{N} \times(0, T)\right)}$ such that

$$
\sup _{\widetilde{Q}_{r}\left(\theta_{*}\right)} v \leq \gamma\left(1-\tau_{*}\right)^{-\beta} .
$$

Proof. An application of Theorem 1.5 to $v$ over the cylinder $\widetilde{Q}_{r}\left(\theta_{*}\right) \subset \widetilde{Q}_{2 r}\left(\theta_{*}\right)$ leads to

$$
\begin{align*}
\sup _{\widetilde{Q}_{r}\left(\theta_{*}\right)} v^{q} \leq & \frac{\gamma}{c^{\frac{N}{\lambda}}}\left(\int_{K_{2 r}(\bar{x})} v^{q}(x, 0) d x\right)^{\frac{p}{\lambda}}+\gamma\left(\frac{c}{r^{p}}\right)^{\frac{q}{q+1-p}} \\
& +\gamma \frac{c}{r^{p}}\left[\operatorname{Tail}_{\infty}\left(u ; \bar{x}, r ;-2^{p} c, 2^{p} c\right)\right]^{p-1}+\gamma\left(\frac{c}{r^{p}}\right)^{\frac{p-N}{\lambda}}\left[\operatorname{Tail}_{\infty}\left(u ; \bar{x}, r ;-2^{p} c, 2^{p} c\right) \frac{\frac{p(p-1)}{\lambda}}{\frac{p}{\lambda}}+\gamma\left(\frac{c}{\frac{q}{q+1-p}}+\gamma \frac{c}{r^{p}}+\gamma\left(\frac{c}{r^{p}}\right)^{\frac{p-N}{\lambda}}\right.\right. \\
\leq & \left.\frac{\gamma}{c^{\frac{N}{\lambda}}}\left(\int_{K_{2 r}(\bar{x})} v^{q}(x, 0) d x\right)^{-\frac{p q}{1}}+\left(1-\tau_{*}\right)^{-p}+\left(1-\tau_{*}\right)^{\frac{-p(p-N)}{\lambda}}\right] \\
& \leq \gamma\left[\left(1-\tau_{*}\right)^{\frac{-a}{q+1-p}}\right] \tag{7.7}
\end{align*}
$$

where $\gamma$ depends only on $N, p, s, q, \Lambda,\|u\|_{L^{\infty}\left(\mathbb{R}^{N} \times(0, T)\right)}$. In the last step of (7.7), we used (7.4) and (7.6).

By the definitions of $\beta, \lambda$ and the assumption $0<p-1<q$, we compute

$$
\begin{equation*}
-p \geq \frac{-p q}{q+1-p}=-\beta q \tag{7.8}
\end{equation*}
$$

and

$$
\begin{equation*}
\frac{-p(p-N)}{\lambda}=\frac{p q(p-N)}{N(q+1-p)-p q} \geq \frac{-p q N}{N(q+1-p)}=-\beta q . \tag{7.9}
\end{equation*}
$$

Since $\tau_{*} \in(0,1)$, the claim follows from (7.7)-(7.9).
With Lemma 7.1 we present the following result which provides the condition of the expansion of positivity.

Lemma 7.2. Let $v$ be defined as in (7.1). Let $p>N$ and $0<p-1<q<p^{2}-1$. There exist constants $\delta, \bar{c}, \alpha \in(0,1)$ just depending on $N, p, s, q, \Lambda,\|u\|_{L^{\infty}\left(\mathbb{R}^{N} \times(0, T)\right)}$ such that

$$
\left|\left[v(\cdot, t) \geq \bar{c}\left(1-\tau_{*}\right)^{-\beta}\right] \cap K_{r}(\bar{x})\right| \geq \alpha\left|K_{r}\right| \quad \text { for all } t \in\left[-\delta \theta_{*} r^{p}, \delta \theta_{*} r^{p}\right]
$$

Proof. By using Theorem 1.5 to function $v$ over the cylinder $\widetilde{Q}_{\frac{1}{2} r}\left(\delta \theta_{*}\right) \subset \widetilde{Q}_{r}\left(\delta \theta_{*}\right)$ yields

$$
\begin{aligned}
\left(1-\tau_{*}\right)^{-\beta q}= & v^{q}(\bar{x}, 0) \leq \sup _{K_{\frac{1}{2} r}(\bar{x})} v^{q}(\cdot, 0) \\
\leq & \frac{\gamma}{\left(\delta \theta_{*} r^{p}\right)^{\frac{N}{\lambda}}}\left(\int_{K_{r}(\bar{x})} v^{q}(x, t) d x\right)^{\frac{p}{\lambda}}+\gamma\left(\delta \theta_{*}\right)^{\frac{q}{q+1-p}}+\gamma \delta \theta_{*}+\gamma\left(\delta \theta_{*}\right)^{\frac{p-N}{\lambda}} \\
\leq & \frac{\gamma}{\left(\delta \theta_{*} r^{p}\right)^{\frac{N}{\lambda}}}\left(\int_{K_{r}(\bar{x})} v^{q}(x, t) d x\right)^{\frac{p}{\lambda}}+\gamma \delta^{\frac{q}{q+1-p}}\left(1-\tau_{*}\right)^{-\beta q} \\
& +\gamma \delta\left(1-\tau_{*}\right)^{-\beta(q+1-p)}+\gamma \delta^{\frac{p-N}{\lambda}}\left(1-\tau_{*}\right)^{-\beta(q+1-p)^{\frac{p-N}{\lambda}}} \\
\leq & \frac{\gamma}{\left(\delta \theta_{*} r^{p}\right)^{\frac{N}{\lambda}}}\left(\int_{K_{r}(\bar{x})} v^{q}(x, t) d x\right)^{\frac{p}{\lambda}}+\gamma \delta^{\frac{p-N}{\lambda}}\left(1-\tau_{*}\right)^{-\beta q}
\end{aligned}
$$

for all $t \in\left[-\delta \theta_{*} r^{p}, \delta \theta_{*} r^{p}\right]$. In the above display, we also employed the definition of $\theta_{*}$ and the fact $0<(p-N) / \lambda<1$. With taking $\delta$ such that $\delta \frac{p-N}{\lambda} \leq \frac{1}{2}$, we have

$$
\left(1-\tau_{*}\right)^{-\beta q} \leq \gamma\left(\int_{K_{r}(\bar{x})} v^{q}(x, t) d x\right)^{\frac{p}{\lambda}}
$$

where $\gamma$ depends only on $N, p, s, q, \Lambda$ and $\|u\|_{L^{\infty}\left(\mathbb{R}^{N} \times(0, T)\right)}$, since $\theta_{*} r^{p}=c$ depends only on $p$ and $q$. In addition, we deduce from Lemma 7.1 that

$$
\begin{aligned}
\int_{K_{r}(\bar{x})} v^{q}(x, t) d x & =\int_{K_{r}(\bar{x})} v^{q}(x, t) \chi_{\left[v<\bar{c}\left(1-\tau_{*}\right)^{-\beta}\right]} d x+\int_{K_{r}(\bar{x})} v^{q}(x, t) \chi_{\left[v \geq \bar{c}\left(1-\tau_{*}\right)^{-\beta}\right]} d x \\
& \leq \bar{c}^{q}\left(1-\tau_{*}\right)^{-\beta q}(2 r)^{N}+\gamma^{q}\left(1-\tau_{*}\right)^{-\beta q}\left|\left[v \geq \bar{c}\left(1-\tau_{*}\right)^{-\beta}\right] \cap K_{r}(\bar{x})\right|
\end{aligned}
$$

with $\bar{c} \in(0,1)$ to be specified. In light of the convexity of $s^{\frac{p}{\lambda}}$, we can derive

$$
\begin{aligned}
\left(1-\tau_{*}\right)^{-\beta q} & \leq \gamma\left[\bar{c}^{q}\left(1-\tau_{*}\right)^{-\beta q}(2 r)^{N}\right]^{\frac{p}{\lambda}}+\gamma\left(1-\tau_{*}\right)^{-\beta q \frac{p}{\lambda}}\left|\left[v \geq \bar{c}\left(1-\tau_{*}\right)^{-\beta}\right] \cap K_{r}(\bar{x})\right|^{\frac{p}{\lambda}} \\
& \leq \gamma \bar{c}^{q \frac{p}{\lambda}}\left(1-\tau_{*}\right)^{-\beta q}+\gamma\left(1-\tau_{*}\right)^{-\beta q \frac{p}{\lambda}}\left|\left[v \geq \bar{c}\left(1-\tau_{*}\right)^{-\beta}\right] \cap K_{r}(\bar{x})\right|^{\frac{p}{\lambda}} .
\end{aligned}
$$

Fixing $\bar{c}$ such that $\gamma \bar{c}^{q \frac{p}{\lambda}}=\frac{1}{2}$, we obtain

$$
\left(1-\tau_{*}\right)^{-\beta q} \leq \gamma\left(1-\tau_{*}\right)^{-\beta q \frac{p}{\lambda}}\left|\left[v \geq \bar{c}\left(1-\tau_{*}\right)^{-\beta}\right] \cap K_{r}(\bar{x})\right|^{\frac{p}{\lambda}}
$$

with $\gamma$ depending only on $N, p, s, q, \Lambda$ and $\|u\|_{L^{\infty}\left(\mathbb{R}^{N} \times(0, T)\right)}$. Thus, we complete the proof based on the definitions of $r, \beta$ and $\lambda$.

The next pointwise estimate is a direct consequence of Proposition 6.1 and Lemma 7.2 ,
Lemma 7.3. Let $v$ be defined as in (7.1). Let $p>N$ and $0<p-1<q<p^{2}-1$. There exist constants $\eta, \delta \in(0,1)$ only depending on $N, p, s, q, \Lambda,\|u\|_{L^{\infty}\left(\mathbb{R}^{N} \times(0, T)\right)}$, such that

$$
v \geq \eta\left(1-\tau_{*}\right)^{-\beta} \quad \text { in } K_{2 r}(\bar{x}) \times\left[-\frac{1}{2} \delta \theta_{*} r^{p}, \delta \theta_{*} r^{p}\right]
$$

In the next step, we expand the pointwise positivity of $v$ defined as in (7.1) to $K_{2}(\bar{x})$, and thus justify (7.3). This proof proceeds by a comparison argument.
7.4. A comparison argument. We give the following initial-boundary value problem

$$
\left\{\begin{array}{cl}
\partial_{t} w^{q}-\operatorname{div}\left(|\nabla w|^{p-2} \nabla w\right)+\mathcal{L} w=0 & \text { in } K_{4}(\bar{x}) \times(-\sigma, 1]  \tag{7.10}\\
w=0 & \text { in } \mathbb{R}^{N} \backslash K_{4}(\bar{x}) \times(-\sigma, 1] \\
w^{q}(\cdot,-\sigma)=\eta\left(1-\tau_{*}\right)^{-N} \chi_{K_{2 r}(\bar{x})}(\cdot) & \text { in } K_{4}(\bar{x})
\end{array}\right.
$$

where $\mathcal{L}$ is given by (1.2), $\eta$ is defined as in Lemma 7.3, $\sigma \in\left(0, \frac{1}{2} \delta c\right)$ to be determined and $c$ is defined as in (7.5).

Lemma 7.4. Let $0<p-1<q$ and $p>N$. Let $v$ defined as in (7.1) be a nonnegative weak solution to (7.2) and $w$ be a nonnegative weak solution to (7.10). Then we have $w \leq v$ a.e. in $K_{4}(\bar{x}) \times[-\sigma, 1]$.
Proof. Since $v$ is a nonnegative solution to (7.2), we know that $w \leq v$ in $\mathbb{R}^{N} \backslash K_{4}(\bar{x}) \times(-\sigma, 1]$. Thanks to the assumptions on $p, q$, we have $\beta q>N$, this combines with Lemma 7.3 gives $w(\cdot,-\sigma) \leq v(\cdot,-\sigma)$ a.e. in $K_{4}(\bar{x})$, and thus we derive from Proposition 3.4 that $w \leq v$ a.e. in $K_{4}(\bar{x}) \times[-\sigma, 1]$.

Finally, we end this section with proving Theorem 1.6.
Proof of Theorem 1.6. In view of Lemma 7.4 we only need to obtain the pointwise positivity of $w$ as below,

$$
\begin{equation*}
w \geq \gamma^{-1} \quad \text { in } K_{2}(\bar{x}) \times\left[-\frac{1}{4} \sigma, \frac{1}{4} \sigma\right] \tag{7.11}
\end{equation*}
$$

with $\gamma>1$ and $\sigma \in\left(0, \frac{1}{2} \delta c\right)$ depending only on $N, p, s, q, \Lambda,\|u\|_{L^{\infty}\left(\mathbb{R}^{N} \times(0, T)\right)}$. In order to get (7.11), we utilize Proposition 5.1 over the cylinder $K_{2}(\bar{x}) \times[-\sigma, \sigma]$. Then for all $t \in[-\sigma, \sigma]$, there holds

$$
\begin{align*}
\int_{K_{1}(\bar{x})} w^{q}(x,-\sigma) d x & \leq \gamma \int_{K_{2}(\bar{x})} w^{q}(x, t) d x+\gamma \sigma^{\frac{q}{q+1-p}}+\gamma \sigma\left[\operatorname{Tail}_{\infty}(w ; \bar{x}, 1 ;-\sigma, \sigma)\right]^{p-1} \\
& \leq \gamma \int_{K_{2}(\bar{x})} w^{q}(x, t) d x+\gamma \sigma \tag{7.12}
\end{align*}
$$

where we used $\sigma \in(0,1)$ and $p>1$. Then, by virtue of the initial data in (7.10), we evaluate the left-hand side of (7.12) as

$$
\begin{equation*}
\int_{K_{1}(\bar{x})} w^{q}(x,-\sigma) d x=\eta\left(1-\tau_{*}\right)^{-N}(4 r)^{N}=2^{N} \eta\left(1-4^{-\frac{1}{\beta}}\right)^{N}=: \eta c_{0} \tag{7.13}
\end{equation*}
$$

Now, we pick $\sigma$ such that $\gamma \sigma=\frac{1}{2} \eta c_{0}$, a combination of (7.12) and (7.13) leads to

$$
\frac{1}{2} \eta c_{0} \leq \gamma \int_{K_{2}(\bar{x})} w^{q}(x, t) d x \quad \text { for all } t \in[-\sigma, \sigma]
$$

Applying Theorem 1.5 in $K_{2}(\bar{x}) \times\left[-\frac{1}{4} \sigma, \frac{1}{4} \sigma\right] \subset K_{4}(\bar{x}) \times\left[-\sigma, \frac{1}{2} \sigma\right]$ along with the initial data in (7.10) gives

$$
\begin{align*}
\sup _{K_{2}(\bar{x}) \times\left[-\frac{1}{4} \sigma, \frac{1}{4} \sigma\right]} w^{q} & \leq \frac{\gamma}{\sigma^{\frac{N}{\lambda}}}\left(\eta c_{0}\right)^{\frac{p}{\lambda}}+\gamma \sigma^{\frac{q}{q+1-p}}+\gamma \sigma+\gamma \sigma^{\frac{p-N}{\lambda}} \\
& \leq \frac{\gamma}{\sigma^{\frac{N}{\lambda}}}\left(\eta c_{0}\right)^{\frac{p}{\lambda}}+\gamma \sigma^{\frac{p-N}{\lambda}}=\gamma \sigma \times \sigma^{\frac{p-N}{\lambda}-1} \leq \gamma_{1} \sigma \tag{7.14}
\end{align*}
$$

where $\gamma_{1}$ depends only on $N, p, s, q, \Lambda,\|u\|_{L^{\infty}\left(\mathbb{R}^{N} \times(0, T)\right)}$ due to the choice of $\sigma$. In light of (7.14), we derive for all $t \in\left[-\frac{1}{4} \sigma, \frac{1}{4} \sigma\right]$ that

$$
\begin{align*}
\frac{1}{2} \eta c_{0} & \leq \gamma \int_{K_{2}(\bar{x})} w^{q}(x, t) d x \\
& =\gamma \int_{K_{2}(\bar{x}) \cap[w<b]} w^{q}(x, t) d x+\gamma \int_{K_{2}(\bar{x}) \cap[w \geq b]} w^{q}(x, t) d x \\
& \leq \gamma b^{q}\left|K_{2}\right|+\gamma \gamma_{1} \eta c_{0}\left|[w(\cdot, t) \geq b] \cap K_{2}(\bar{x})\right| \tag{7.15}
\end{align*}
$$

with some $b>0$. In fact, we can choose $b$ such that $\gamma b^{q}\left|K_{2}\right|=\frac{1}{4} \eta c_{0}$, which together with (7.15) indicates

$$
\left|[w(\cdot, t) \geq b] \cap K_{2}(\bar{x})\right| \geq \frac{1}{4 \gamma_{2}} \quad \text { for all } t \in\left[-\frac{1}{4} \sigma, \frac{1}{4} \sigma\right]
$$

with $\gamma_{2}=\gamma \gamma_{1}>1$ only depending on $N, p, s, q, \Lambda$ and $\|u\|_{L^{\infty}\left(\mathbb{R}^{N} \times(0, T)\right)}$. With the above measure information at hand, the pointwise estimate of the function $w$ follows from Proposition 6.1 consequently, the estimate of $v$. Finally, we establish the left-hand side Harnack inequality in Theorem 1.6 by the definition of $v$, and by choosing $\gamma, \sigma$ properly.

The argument to obtain Harnack inequality on the right-hand side is standard by using the continuity of weak solutions together with the Harnack inequality on the left-hand side, we refer the readers to [6, pages $85-86]$. Up to now, we have finished the proof.
