# On the Diameter of Undirected Cayley Graphs of Finite Abelian Groups

#### Abstract

Let $s$ be a positive integer. Our goal is to find all finite abelian groups $G$ that contain a 2 -subset $A$ for which the undirected Cayley graph $\Gamma(G, A)$ has diameter at most $s$. We provide a complete answer when $G$ is cyclic, and a conjecture and some partial answers when $G$ is noncyclic.

## 1 Introduction

Throughout this paper we let $G$ be an additively written finite abelian group. When $G$ is cyclic and of order $n$, we identify it with $\mathbb{Z}_{n}=\mathbb{Z} / n \mathbb{Z}$; we consider $0,1, \ldots, n-1$ interchangeably as integers and as elements of $\mathbb{Z}_{n}$. Below we use standard terminology and notation of additive combinatorics (see [1]).

Given a finite abelian group $G$ and a subset $A \subseteq G$, the undirected Cayley graph $\Gamma(G, A)$ has its vertex set formed by the elements of $G$, and has an edge between two vertices whenever their difference is an element of $A$, that is, $g_{1} \in G$ and $g_{2} \in G$ are connected when $g_{2}=g_{1}+a$ or $g_{1}=g_{2}+a$ for some $a \in A$. If $A$ is a generating set of $G$, then $\Gamma(G, A)$ is connected; in particular, if $A$ is an $s$-spanning set of $G$, meaning that every element of $G$ can be written as the signed sum of at most $s$ (not-necessarily distinct) elements of $A$, then $\Gamma(G, A)$ has diameter at most $s$.

Suppose now that $A$ is an $m$-subset of $G$. It is easy to compute that there are at most $\sum_{i \geq 0}\binom{m}{i}\binom{h-1}{i-1} 2^{i}$ vertices of $\Gamma(G, A)$ that are of distance $h$ away from any given vertex, and thus if $A$ is an $s$-spanning set in $G$, then the order of $G$ can be at most

$$
\sum_{h=0}^{s} \sum_{i \geq 0}\binom{m}{i}\binom{h-1}{i-1} 2^{i}=\sum_{i \geq 0}\binom{m}{i}\binom{s}{i} 2^{i}
$$

Therefore, we have the following bound.

Proposition 1.1 For positive integers $m$ and $s$, define

$$
\begin{equation*}
a(m, s)=\sum_{i \geq 0}\binom{m}{i}\binom{s}{i} 2^{i} \tag{1}
\end{equation*}
$$

If an abelian group $G$ has an m-subset $A$ for which the diameter of $\Gamma(G, A)$ is $s$, then the order of $G$ is at most a $(m, s)$.

[^0]We note, in passing, that the values of $a(m, s)$ are known as Delannoy numbers (see [3]), and that they satisfy the recursion

$$
a(m, s)=a(m, s-1)+a(m-1, s)+a(m-1, s-1)
$$

It is a natural question to ask for the largest possible order of a group $G$ with an $m$-subset $A$ for which the diameter of $\Gamma(G, A)$ is at most $s$. Before we discuss our results on this question, let us review the analogous question in the directed case.

Given a finite abelian group $G$ and a subset $A \subseteq G$, the directed Cayley graph $\vec{\Gamma}(G, A)$ has its vertex set formed by the elements of $G$, and has a directed edge from $g_{1} \in G$ to $g_{2} \in G$ when $g_{2}=g_{1}+a$ for some $a \in A$. We say that $A$ is an $s$-basis of $G$ if every element of $G$ can be written as the sum of at most $s$ (not-necessarily distinct) elements of $A$; in this case, the diameter of $\vec{\Gamma}(G, A)$ is at most $s$.

For an $m$-subset $A$ of $G$, we see that there are at most $\binom{m+h-1}{h}$ vertices of $\vec{\Gamma}(G, A)$ that are of distance $h$ away from any given vertex, so if $A$ is an $s$-basis of $G$, then we must have

$$
|G| \leq \sum_{h=0}^{s}\binom{m+h-1}{h}=\binom{m+s}{s}
$$

When equality holds, we say that $A$ is a perfect s-basis of $G$ : in this case, every element of $G$ arises as the sum of at most $s$ (not-necessarily distinct) elements of $A$ in a unique way. Trivially, the set of nonzero elements is a perfect 1-basis in any group $G$, and the 1-element set consisting of a generator of $G$ is a perfect $s$-basis in the cyclic group of order $s+1$. It turns out that there are no others:

Theorem 1.2 (Bajnok, Berson, and Just; cf. [2]) If a subset $A$ of a finite abelian group $G$ is a perfect s-basis, then $s=1$ and $A=G \backslash\{0\}$, or $G \cong \mathbb{Z}_{s+1}$ and $|A|=1$.

Given the scarcity of perfect bases, it is natural to ask for the largest groups with a given diameter and size of generating set. The paper [9] asks the following questions:

- What is the largest possible order of an abelian group $G$ with an $m$-subset $A$ for which the diameter of $\vec{\Gamma}(G, A)$ is at most $s$ ?
- What is the largest possible order of a cyclic group $G$ with an $m$-subset $A$ for which the diameter of $\vec{\Gamma}(G, A)$ is at most $s ?$

After a series of papers [10, 5, 8, 9, 4], these two questions have been completely solved for the case of $m=2$. We have the following two results.

Theorem 1.3 (Morillo, Fiol, and Fàbrega; cf. [10]) Let $s$ be a positive integer. The largest possible order of a cyclic group $G$ with a 2-subset for which the diameter of $\vec{\Gamma}(G, A)$ is at most $s$ is given by $\left\lfloor\left(s^{2}+4 s+3\right) / 3\right\rfloor$.

Theorem 1.4 (Fiol; cf. [4]) Let s be any positive integer. The largest possible order of an abelian group $G$ with a 2-subset for which the diameter of $\vec{\Gamma}(G, A)$ is at most $s$ is given by $\left\lfloor\left(s^{2}+4 s+4\right) / 3\right\rfloor$.

Observe that the quantities in Theorems 1.3 and 1.4 agree, unless $s \equiv 1 \bmod 3$; for that case one can verify that the group $G=\mathbb{Z}_{k} \times \mathbb{Z}_{3 k}$ has the $s$-basis $\{(0,1),(1,3 k-1)\}$, where $k=(s+2) / 3$. However, the question specifically for noncyclic groups is still open when $s \not \equiv 1 \bmod 3$.

Let us now return to the undirected case. When equality occurs in Proposition 1.1, then $A$ is called a perfect s-spanning set in $G$. Perfect spanning sets can be easily characterized for $m=1$ and $s=1$. Note that $a(1, s)=2 s+1$ and, clearly, for
any $a \in \mathbb{Z}_{2 s+1}$ with $\operatorname{gcd}(a, 2 s+1)=1$, the set $\{a\}$ is a perfect $s$-spanning set in $\mathbb{Z}_{2 s+1}$. Also, $a(m, 1)=2 m+1$, and for any group $G$ of order $2 m+1$, every asymmetric subset of size $m$ (that is, a set containing exactly one of any nonzero element or its inverse) is a perfect 1 -spanning set in $G$.

From (11) we get $a(2, s)=2 s^{2}+2 s+1$, and below we establish the following result.

Theorem 1.5 Let s be a positive integer. The largest possible order of a cyclic group $G$ with a 2-subset for which the diameter of $\Gamma(G, A)$ is at most $s$ is given by $2 s^{2}+2 s+1$.

For noncyclic groups the situation seems a bit more nuanced. We have the following conjecture.

Conjecture 1.6 Let $s \geq 3$ be an integer.

- If $2 s+1$ is prime, then the largest noncyclic group with an s-spanning set of size 2 has order $2 s^{2}$.
- If $2 s+1$ is composite and $p$ is its smallest prime divisor, then the largest noncyclic group with an s-spanning set of size 2 has order $2 s^{2}+2 s-\left(p^{2}-1\right) / 2$.

In particular, for any noncyclic group $G$ with an $s$-spanning set of size 2 we have $|G| \leq 2 s^{2}+2 s-4$.
(We add that the largest noncyclic group with a 2 -spanning set of size 2 is $\mathbb{Z}_{3} \times \mathbb{Z}_{3}$.)
Below we prove that the quantities in Conjecture 1.6 are lower bounds.

Theorem 1.7 Let $s$ be a positive integer.

- The largest noncyclic group with an s-spanning set of size 2 has order at least $2 s^{2}$.
- If $2 s+1$ is composite and $p$ is any prime divisor of $2 s+1$, then the largest noncyclic group with an s-spanning set of size 2 has order at least $2 s^{2}+2 s-\left(p^{2}-1\right) / 2$.

Establishing upper bounds appears to be more difficult, and we only have the partial results that we summarize here. We first note that a noncyclic group that has a spanning set of size 2 must have rank 2 and thus is isomorphic to $\mathbb{Z}_{c} \times \mathbb{Z}_{k c}$ for some integers $c \geq 2$ and $k \geq 1$.

We say that the group $\mathbb{Z}_{c} \times \mathbb{Z}_{k c}$ is s-regular for some positive integer $s$, if it possesses an $s$-spanning set of the form $\{(1, u),(1, v)\}$ for some $u, v \in \mathbb{Z}_{k c}$. While we have no precise count on the number of $s$-regular groups, it appears that most groups of rank 2 that have an $s$-spanning set of size 2 are $s$-regular. For example, for $s=10$, of the 105 groups of rank 2 that have an $s$-spanning set of size 2,103 are $s$-regular. (The two exceptions are $\mathbb{Z}_{8} \times \mathbb{Z}_{16}$ and $\mathbb{Z}_{10} \times \mathbb{Z}_{20}$.) In Theorem 3.1 below we prove for every odd prime $c$ and positive integer $k$ that if $\mathbb{Z}_{c} \times \mathbb{Z}_{k c}$ has an $s$-spanning set at all, then it is $s$-regular.

Our results for upper bounds can be summarized as follows.

Theorem 1.8 Let $s$ be a positive integer, and let $G=\mathbb{Z}_{c} \times \mathbb{Z}_{k c}$ be an s-regular group for some integers $c \geq 2$ and $k \geq 1$.

- If $c=3$ and $s+1$ is divisible by 3 , then $|G| \leq 2 s^{2}+1$.
- If $c$ is odd and $s$ is divisible by $c$, then $|G| \leq 2 s^{2}+s$, and if $2 s+1$ is divisible by $c$, then $|G| \leq 2 s^{2}+2 s-\left(c^{2}-1\right) / 2$.
- In all other cases, $|G| \leq 2 s^{2}$.

As a consequence of our results, we can prove that for $s \geq 3$, every $s$-regular abelian group of rank 2 has order at most $2 s^{2}+2 s-4$, with equality if, and only if, it is isomorphic to $\mathbb{Z}_{3} \times \mathbb{Z}_{\left(2 s^{2}+2 s-4\right) / 3}$ for some $s \equiv 1 \bmod 3$ (See Theorem 3.3 below).

For $c=2$ we have exact results, even without the assumption that the group is $s$-regular:

Theorem 1.9 Let $k$ and $s$ be positive integers. The largest possible order of a group of the form $\mathbb{Z}_{2} \times \mathbb{Z}_{2 k}$ that has an $s$-spanning set of size 2 is $2 s^{2}$ when $s$ is even and $2 s^{2}-2$ when $s$ is odd.

In Section 4 below we provide some further results on groups of the form $\mathbb{Z}_{2} \times \mathbb{Z}_{2 k}$.
For $m \geq 3$, the largest order of abelian groups with an $m$-subset for which the diameter of their Cayley graphs is at most $s$ is generally unknown, though some small cases for cyclic groups were displayed by Haanpää in [7], by Hsu and Jia in [8, and by Graham and Sloane in 6.

Of particular interest are perfect spanning sets. An $m$-subset $A$ of $G$ is called a perfect s-spanning set, if every element of $G$ arises as a signed sum of at most $s$ terms in a unique way; in this case we have $|G|=a(m, s)$. Above we mentioned perfect spanning sets for $m=1$, for $s=1$, and for $m=2$; we believe that there are no others.

Conjecture 1.10 If an m-subset $A$ of a finite abelian group $G$ is a perfect s-spanning set, then one of the following holds:

- $m=1, G \cong \mathbb{Z}_{2 s+1}$, and $A=\{a\}$ for some $a \in \mathbb{Z}_{2 s+1}$ with $\operatorname{gcd}(a, 2 s+1)=1$;
- $s=1$, and $G$ is the disjoint union of $\{0\}, A$, and $-A$; or
- $m=2, G \cong \mathbb{Z}_{2 s^{2}+2 s+1}$, and $A=d \cdot\{s, s+1\}$ for some $d \in \mathbb{Z}_{2 s+1}$ with $\operatorname{gcd}\left(d, 2 s^{2}+2 s+1\right)=1$.

In Sections 2 and 3 below, we present our results on lower bounds and upper bounds, respectively. In Section 4 we treat the case of the groups $\mathbb{Z}_{2} \times \mathbb{Z}_{2 k}$ in more detail.

## 2 Constructions and lower bounds

In this section we provide some explicit constructions for $s$-spanning sets of size 2 . We denote the $s$-span of a 2 -subset $A=\left\{a_{1}, a_{2}\right\}$ of $G$ by

$$
\langle A\rangle_{s}=\left\{\lambda_{1} a_{1}+\lambda_{2} a_{2}\left|\lambda_{1}, \lambda_{2} \in \mathbb{Z},\left|\lambda_{1}\right|+\left|\lambda_{2}\right| \leq s\right\}\right.
$$

It will be helpful to have the following facts available.

Lemma 2.1 For a given positive integer s, let

$$
I(s)=\left\{\left(\lambda_{1}, \lambda_{2}\right)\left|\lambda_{1}, \lambda_{2} \in \mathbb{Z},\left|\lambda_{1}\right|+\left|\lambda_{2}\right| \leq s\right\}\right.
$$

1. For a given integer $h$ with $|h| \leq s$, the number of ordered pairs $\left(\lambda_{1}, \lambda_{2}\right) \in I(s)$ with $\lambda_{1}+\lambda_{2}=h$ equals $s+1$ when $s$ and $h$ have the same parity, and $s$ otherwise.
2. There are $(s+1)^{2}$ ordered pairs $\left(\lambda_{1}, \lambda_{2}\right) \in I(s)$ where $\lambda_{1}+\lambda_{2}$ and $s$ have the same parity, and $s^{2}$ where $\lambda_{1}+\lambda_{2}$ and $s$ have opposite parity.
3. There are $2 s^{2}+2 s+1$ elements in $I(s)$.

Proof. By symmetry, we may assume that $h \geq 0$. Observe that the 'leftmost' integer point $\left(\lambda_{1}, \lambda_{2}\right)$ on the line $x+y=h$ within $\left|\lambda_{1}\right|+\left|\lambda_{2}\right| \leq s$ is

$$
(-\lfloor(s-h) / 2\rfloor, h+\lfloor(s-h) / 2\rfloor),
$$

and the 'rightmost' such point is

$$
(\lfloor(s+h) / 2\rfloor, h-\lfloor(s+h) / 2\rfloor)
$$

a set of $s+1$ points when $s$ and $h$ have the same parity, and $s$ points otherwise. This establishes the first claim, from which our other two claims follow easily.

Proposition 2.2 For all positive integers $s$ and $n$ with

$$
2 \leq n \leq 2 s^{2}+2 s+1
$$

the set $\{s, s+1\}$ is an s-spanning set in $\mathbb{Z}_{n}$.

Proof. The fact that $n$ cannot be larger than $2 s^{2}+2 s+1$ follows from Proposition 1.1 We verify that for every $n$ in the range given above, we have $\langle\{s, s+1\}\rangle_{s}=\mathbb{Z}_{n}$.

Considering the elements of

$$
S=\left\{\lambda_{1} s+\lambda_{2}(s+1)\left|\lambda_{1}, \lambda_{2} \in \mathbb{Z},\left|\lambda_{1}\right|+\left|\lambda_{2}\right| \leq s\right\}\right.
$$

in $\mathbb{Z}$ (rather than $\left.\mathbb{Z}_{n}\right)$, we see that they lie in the interval $\left[-\left(s^{2}+s\right),\left(s^{2}+s\right)\right]$. Since the index set

$$
I(s)=\left\{\left(\lambda_{1}, \lambda_{2}\right)\left|\lambda_{1}, \lambda_{2} \in \mathbb{Z},\left|\lambda_{1}\right|+\left|\lambda_{2}\right| \leq s\right\}\right.
$$

contains exactly $2 s^{2}+2 s+1$ elements (see Lemma 2.1), it suffices to prove that no integer in $\left[-\left(s^{2}+s\right),\left(s^{2}+s\right)\right]$ can be written as an element of $S$ in two different ways.

For that, suppose that

$$
\lambda_{1} s+\lambda_{2}(s+1)=\lambda_{1}^{\prime} s+\lambda_{2}^{\prime}(s+1)
$$

for some $\left(\lambda_{1}, \lambda_{2}\right) \in I(s)$ and $\left(\lambda_{1}^{\prime}, \lambda_{2}^{\prime}\right) \in I(s)$; without loss of generality, we can assume that $\lambda_{2} \geq \lambda_{2}^{\prime}$. Our equation implies that $\lambda_{2}-\lambda_{2}^{\prime}$ is divisible by $s$ and is, therefore, equal to $0, s$, or $2 s$.

If $\lambda_{2}-\lambda_{2}^{\prime}=2 s$, then $\lambda_{2}=s$ and $\lambda_{2}^{\prime}=-s$; since $\left|\lambda_{1}\right|+\left|\lambda_{2}\right| \leq s$ and $\left|\lambda_{1}^{\prime}\right|+\left|\lambda_{2}^{\prime}\right| \leq s$, this can only happen if $\lambda_{1}=\lambda_{1}^{\prime}=0$, but this case leads to a contradiction with our equation.

Assume, next, that $\lambda_{2}-\lambda_{2}^{\prime}=s$. Our equation then yields $\lambda_{1}-\lambda_{1}^{\prime}=-s-1$. In this case, we have $\lambda_{1} \leq 0, \lambda_{1}^{\prime} \geq 0, \lambda_{2} \geq 0$, and $\lambda_{2}^{\prime} \leq 0$, and we see that

$$
\left|\lambda_{1}\right|+\left|\lambda_{2}\right|=-\lambda_{1}+\lambda_{2}=\left(s+1-\lambda_{1}^{\prime}\right)+\left(s+\lambda_{2}^{\prime}\right)=2 s+1-\left(\left|\lambda_{1}^{\prime}\right|+\left|\lambda_{2}^{\prime}\right|\right) \geq s+1
$$

but that is a contradiction.
This leaves us with the case that $\lambda_{2}=\lambda_{2}^{\prime}$, which implies $\lambda_{1}=\lambda_{1}^{\prime}$, as claimed, and therefore the set $\{s, s+1\}$ is $s$-spanning in $\mathbb{Z}_{n}$.

Proposition 2.3 For every positive integer $s$, the set $\{(0,1),(1,1)\}$ is an s-spanning set in $\mathbb{Z}_{s} \times \mathbb{Z}_{2 s}$.

Proof. We need to prove that for any $(a, b) \in \mathbb{Z}_{s} \times \mathbb{Z}_{2 s}$, we have $(a, b) \in\langle\{(0,1),(1,1)\}\rangle_{s}$. Note that by symmetry we may assume that $0 \leq b \leq s$. We consider three subcases.

When $b \geq a$, we let $\lambda_{1}=b-a$ and $\lambda_{2}=a$. We then have

$$
\lambda_{1}(0,1)+\lambda_{2}(1,1)=(a, b)
$$

and

$$
\left|\lambda_{1}\right|+\left|\lambda_{2}\right|=\lambda_{1}+\lambda_{2}=b \leq s
$$

so $(a, b) \in\langle\{(0,1),(1,1)\}\rangle_{s}$.
Next, when $2 a-s \leq b<a$, we again let $\lambda_{1}=b-a$ and $\lambda_{2}=a$. In this case, we have

$$
\left|\lambda_{1}\right|+\left|\lambda_{2}\right|=-\lambda_{1}+\lambda_{2}=2 a-b \leq s
$$

so again $(a, b) \in\langle\{(0,1),(1,1)\}\rangle_{s}$.
Finally, when $b<2 a-s$, we let $\lambda_{1}=b-a+s$ and $\lambda_{2}=a-s$. Here we have

$$
\lambda_{1}(0,1)+\lambda_{2}(1,1)=(a-s, b)
$$

where $a-s \equiv a \bmod s$. Furthermore,

$$
\left|\lambda_{1}\right|+\left|\lambda_{2}\right|=\lambda_{1}-\lambda_{2}=(b-a+s)+(s-a)<s
$$

so again $(a, b) \in\langle\{(0,1),(1,1)\}\rangle_{s}$. This completes our proof.

Theorem 2.4 Let $c$ and $s$ be positive integers so that the remainder of $s$ mod $c$ is at least $(c-1) / 2$. Let $u=\lfloor s / c\rfloor, v=\lceil s / c\rceil$, and $k=2 u v$. Then $A=\{(1, u),(1, v)\}$ is an s-spanning set in $G=\mathbb{Z}_{c} \times \mathbb{Z}_{c k}$.

Proof. Let $H=\langle(1, u)\rangle$ be the subgroup of $G$ generated by the element $(1, u)$. Since $H$ has order $2 c v$, it has $c u$ cosets in $G$. We claim that these cosets are $\lambda_{2} \cdot(1, v)+H$, where $\lambda_{2}=0,1, \ldots, c u-1$. In order to prove this, we need to show that these $c u$ cosets are pairwise distinct.

Suppose, then, that $\mu_{1}(1, v)$ and $\mu_{2}(1, v)$ are in the same coset of $H$ for some $0 \leq \mu_{1}, \mu_{2} \leq c u-1$. This implies that $\left(\mu_{2}-\mu_{1}\right) \cdot(1, v)$ is an element of $H$, so there exists an integer $\mu$ for which

$$
\left(\mu_{2}-\mu_{1}\right) \cdot(1, v)=\mu \cdot(1, u)
$$

From the first coordinates, this means that $\mu_{2}-\mu_{1}-\mu$ is divisible by $c$, and from the second coordinates we see that $\left(\mu_{2}-\mu_{1}\right) v-\mu u$, which, since $v=u+1$, equals $\left(\mu_{2}-\mu_{1}-\mu\right) u+\left(\mu_{2}-\mu_{1}\right)$, is divisible by $c k$ and thus by $c u$. Combining these, we get that $\mu_{2}-\mu_{1}$ must also be divisible by $c u$, but that is only possible if $\mu_{1}=\mu_{2}$.

Let $g \in G$ be arbitrary. According to our claim, we have integers $\lambda_{1} \in[-c v+1, c v]$ and $\lambda_{2} \in[0, c u-1]$ for which

$$
g=\lambda_{1}(1, u)+\lambda_{2}(1, v)
$$

By assumption, we have integers $q$ (quotient) and $r$ (remainder) with $(c-1) / 2 \leq r \leq c-1$ for which $s=q c+r$. We then have

$$
\begin{equation*}
\left|\lambda_{1}\right|+\left|\lambda_{2}\right| \leq c v+(c u-1)=c(q+1)+(c q-1)=2 c q+c-1=2 s+(c-2 r-1) \leq 2 s \tag{2}
\end{equation*}
$$

If $\left|\lambda_{1}\right|+\left|\lambda_{2}\right| \leq s$, then $g \in\langle A\rangle_{s}$, and we are done.
Assume then that $\left|\lambda_{1}\right|+\left|\lambda_{2}\right| \geq s+1$. In this case, let $\lambda_{1}^{\prime}=\lambda_{1}-\epsilon c v$ and $\lambda_{2}^{\prime}=\lambda_{2}-c u$, where $\epsilon$ equals 1 when $\lambda_{1} \geq 0$, and -1 when $\lambda_{1}<0$. We can compute that

$$
\lambda_{1}^{\prime}(1, u)+\lambda_{2}^{\prime}(1, v)=\left(\lambda_{1}-\epsilon c v\right)(1, u)+\left(\lambda_{2}-c u\right)(1, v)=\lambda_{1}(1, u)+\lambda_{2}(1, v)-(\epsilon c v+c u,(\epsilon+1) c u v)
$$

and since $\epsilon+1$ equals 0 or 2 , in $G$ we have

$$
\lambda_{1}^{\prime}(1, u)+\lambda_{2}^{\prime}(1, v)=\lambda_{1}(1, u)+\lambda_{2}(1, v)=g
$$

Finally, we show that $\left|\lambda_{1}^{\prime}\right|+\left|\lambda_{2}^{\prime}\right| \leq s$. Indeed, we have

$$
\left|\lambda_{1}^{\prime}\right|+\left|\lambda_{2}^{\prime}\right|=\left|\lambda_{1}-\epsilon c v\right|+\left|\lambda_{2}-c u\right|=c v-\left|\lambda_{1}\right|+c u-\left|\lambda_{2}\right| .
$$

From (2) above we see that $c v+c u \leq 2 s+1$, and by our current assumption we have $\left|\lambda_{1}\right|+\left|\lambda_{2}\right| \geq s+1$. Therefore, $\left|\lambda_{1}^{\prime}\right|+\left|\lambda_{2}^{\prime}\right| \leq s$, as claimed, and our proof is now complete.

Corollary 2.5 Let $s$ be a positive integer for which $2 s+1$ is composite, and let $p$ be any prime divisor of $2 s+1$. Then the largest noncyclic group with an s-spanning set of size 2 has order at least $2 s^{2}+2 s-\left(p^{2}-1\right) / 2$.

Proof. Let us write $2 s+1=p t$ for some integer $t \geq 2$. Note that $p$ and $t$ must be odd, and we have

$$
s=\frac{t-1}{2} p+\frac{p-1}{2}
$$

$\lfloor s / p\rfloor=(t-1) / 2$, and $\lceil s / p\rceil=(t+1) / 2$. Let $G=\mathbb{Z}_{p} \times \mathbb{Z}_{p k}$ where $k=\left(t^{2}-1\right) / 2$. Then $G$ has order $2 s^{2}+2 s-\left(p^{2}-1\right) / 2$ and, according to Theorem [2.4] it has an $s$-spanning set of size 2 .

## $3 s$-regular groups and upper bounds

Recall that we say that the group $\mathbb{Z}_{c} \times \mathbb{Z}_{k c}$ is s-regular for some positive integer $s$, if it possesses an $s$-spanning set of the form $\{(1, u),(1, v)\}$ for some $u, v \in \mathbb{Z}_{k c}$. In this section we provide some upper bounds for the largest possible order of an $s$-regular group.

Theorem 3.1 Let $G=\mathbb{Z}_{c} \times \mathbb{Z}_{c k}$ for some integers $c \geq 2$ and $k \geq 1$ that has an s-spanning set for some positive integer $s$. If $c$ is an odd prime, then $G$ is s-regular.

Proof. First, we prove that $G$ has an $s$-spanning set of the form $A=\{(a, u),(b, v)\}$ for some $a, b \in \mathbb{Z}_{c}$ and $u, v \in \mathbb{Z}_{c k}$ with $u \not \equiv v \bmod c$. Note that if $\{(a, u),(b, v)\}$ is an $s$-spanning set, then so is $\{(a, u),(-b,-v)\}$, so if our claim were false, then we would have $u \equiv v \equiv-v \bmod c$ for each $s$-spanning set $A=\{(a, u),(b, v)\}$ of $G$. But since $c$ is an odd prime, that would imply that $u \equiv v \equiv 0 \bmod c$, and that is a contradiction with $A$ being a spanning set.

Suppose then that $A=\{(a, u),(b, v)\}$ is an $s$-spanning in $G$ with $u \not \equiv v \bmod c$. We will prove that, in this case, $B=\{(1, u),(1, v)\}$ is also an $s$-spanning in $G$.

Let

$$
I(s)=\left\{\left(\lambda_{1}, \lambda_{2}\right)\left|\lambda_{1}, \lambda_{2} \in \mathbb{Z},\left|\lambda_{1}\right|+\left|\lambda_{2}\right| \leq s\right\}\right.
$$

and consider the function $f: I(s) \rightarrow G$, given by

$$
\left(\lambda_{1}, \lambda_{2}\right) \mapsto \lambda_{1}(a, u)+\lambda_{2}(b, v)
$$

Since $A$ is an s-spanning set, $f$ is surjective; we can thus find a subset $I_{0}$ of $I(s)$ on which the restriction $f_{0}: I_{0} \rightarrow G$ of $f$ is bijective. We will prove that $g_{0}: I_{0} \rightarrow G$, given by

$$
\left(\lambda_{1}, \lambda_{2}\right) \mapsto \lambda_{1}(1, u)+\lambda_{2}(1, v)
$$

is also bijective. It suffices to show that $g_{0}$ is injective. In order to do so, let us assume that the equation

$$
\lambda_{1}(1, u)+\lambda_{2}(1, v)=\mu_{1}(1, u)+\mu_{2}(1, v)
$$

holds in $G$ for some $\left(\lambda_{1}, \lambda_{2}\right)$ and $\left(\mu_{1}, \mu_{2}\right)$ of $I_{0}$. We then have

$$
\begin{equation*}
\lambda_{1}+\lambda_{2} \equiv \mu_{1}+\mu_{2} \bmod c \tag{3}
\end{equation*}
$$

and

$$
\begin{equation*}
\lambda_{1} u+\lambda_{2} v \equiv \mu_{1} u+\mu_{2} v \bmod c k \tag{4}
\end{equation*}
$$

From (4) we find that

$$
\left(\lambda_{1}+\lambda_{2}\right) u+\lambda_{2}(v-u) \equiv\left(\mu_{1}+\mu_{2}\right) u+\mu_{2}(v-u) \bmod c k
$$

considering (3), this gives us that

$$
\lambda_{2}(v-u) \equiv \mu_{2}(v-u) \bmod c
$$

Therefore, since $c$ is prime and $u \not \equiv v \bmod c$, we get that $\lambda_{2} \equiv \mu_{2} \bmod c$. From (3) then we get $\lambda_{1} \equiv \mu_{1} \bmod c$, and thus

$$
\begin{equation*}
\lambda_{1} a+\lambda_{2} b \equiv \mu_{1} a+\mu_{2} b \bmod c \tag{5}
\end{equation*}
$$

But $f_{0}$ is an injection, so (51) and (4) can hold together only when $\left(\lambda_{1}, \lambda_{2}\right)=\left(\mu_{1}, \mu_{2}\right)$. This completes our proof.

Theorem 3.2 Let $G=\mathbb{Z}_{c} \times \mathbb{Z}_{c k}$ for some integers $c \geq 2$ and $k \geq 1$, and suppose that $G$ is s-regular for some positive integer $s$.

1. If $c$ is even, then $|G| \leq 2 s^{2}$, and equality may occur only when $s \equiv 0 \bmod c$.
2. If $c$ is odd and

- $s \equiv 0 \bmod c$, then $|G| \leq 2 s^{2}+s$;
- $s \equiv(c-1) / 2 \bmod c$, then $|G| \leq 2 s^{2}+2 s-\left(c^{2}-1\right) / 2$;
- $c=3$ and $s \equiv 2 \bmod 3$, then $|G| \leq 2 s^{2}+1$.

In all other cases, $|G|<2 s^{2}$.

Proof. Let $A=\{(1, u),(1, v)\}$ be an $s$-spanning set in $G$, in which case

$$
\left\{\left(\lambda_{1}+\lambda_{2}, \lambda_{1} u+\lambda_{2} v\right)\left|\left(\lambda_{1}, \lambda_{2}\right) \in \mathbb{Z}^{2},\left|\lambda_{1}\right|+\left|\lambda_{2}\right| \leq s\right\}=G\right.
$$

Recall from Lemma 2.1 that, for a given integer $h$ with $|h| \leq s$, the number $\Lambda(h)$ of ordered pairs $\left(\lambda_{1}, \lambda_{2}\right) \in \mathbb{Z}^{2}$ with $\left|\lambda_{1}\right|+\left|\lambda_{2}\right| \leq s$ and $\lambda_{1}+\lambda_{2}=h$ equals $s+1$ when $s$ and $h$ have the same parity, and $s$ otherwise. For each $i=0,1, \ldots, c-1$, we let $N(i)$ denote the sum of all $\Lambda(h)$ with $|h| \leq s$ and $h \equiv i \bmod c$. Since $A$ is an $s$-spanning set in $G$, we must have

$$
\left\{\left(\lambda_{1}+\lambda_{2}, \lambda_{1} u+\lambda_{2} v\right)\left|\left(\lambda_{1}, \lambda_{2}\right) \in \mathbb{Z}^{2},\left|\lambda_{1}\right|+\left|\lambda_{2}\right| \leq s\right\}=\mathbb{Z}_{c} \times \mathbb{Z}_{c k}\right.
$$

and thus for each $i=0,1, \ldots, c-1$,

$$
\left\{\left(\lambda_{1}+\lambda_{2}, \lambda_{1} u+\lambda_{2} v\right)\left|\left(\lambda_{1}, \lambda_{2}\right) \in \mathbb{Z}^{2},\left|\lambda_{1}\right|+\left|\lambda_{2}\right| \leq s, \lambda_{1}+\lambda_{2} \equiv i \bmod c\right\}=\{i\} \times \mathbb{Z}_{c k}\right.
$$

In particular,

$$
\begin{equation*}
|G| \leq c N(i) \tag{6}
\end{equation*}
$$

must hold for each $i=0,1, \ldots, c-1$. We now inspect (6) in several cases.

When $c$ is even, we consider $i=r+1$, where $r$ is the nonnegative remainder of $s \bmod c$ (with $r+1$ understood to be 0 when $r=c-1$ ). To compute $N(r+1)$, we need to identify the values of $h$ for which $|h| \leq s$ and $h \equiv r+1 \bmod c$, and these values are $h=s+1-j c$ for $j=1,2, \ldots, j_{\max }$, where

$$
j_{\max }=\lfloor(2 s+1) / c\rfloor=(2 s-2 r) / c+\lfloor(2 r+1) / c\rfloor .
$$

Note that $\lfloor(2 r+1) / c\rfloor$ equals 0 when $0 \leq r \leq c / 2-1$, and 1 when $c / 2 \leq r \leq c-1$. Since $s$ and $h=s+1-j c$ have different parity, and thus $\Lambda(h)=s$ for each $j$, we have

$$
c N(r+1)=(2 s-2 r+c\lfloor(2 r+1) / c\rfloor) s
$$

and we see that this quantity is at most $2 s^{2}$, with equality when $r=0$ or $r=c / 2$. But $|G|$ must be divisible by $c^{2}$, so $|G|=2 s^{2}$ may only occur when $r=0$.

When $c$ is odd and $r \leq c-2$, we consider $i=r+2$ (where $r+2$ is understood to be 0 when $r=c-2$ ). In this case the values of $h$ with $|h| \leq s$ and $h \equiv r+2 \bmod c$ are $h=s+2-t c$ for $t=1,2, \ldots, t_{\max }$, where

$$
t_{\max }=\lfloor(2 s+2) / c\rfloor=(2 s-2 r) / c+\lfloor(2 r+2) / c\rfloor .
$$

Note that $\lfloor(2 r+2) / c\rfloor$ equals 0 when $0 \leq r \leq(c-3) / 2$, and 1 when $(c-1) / 2 \leq r \leq c-2$. Since $s$ and $h=s+2-t c$ have the same parity when $t$ is even and different parity when $t$ is odd, we have

$$
c N(r+2)=(s-r+c\lfloor(2 r+2) / c\rfloor) s+(s-r)(s+1)
$$

We consider four subcases. For $r=0$, this quantity equals $2 s^{2}+s$, and when $1 \leq r \leq(c-3) / 2$, it equals $(s-r) s+(s-r)(s+1)$, which is less than $2 s^{2}$. When $(c+1) / 2 \leq r \leq c-2$, we have

$$
c N(r+2)=(s-r+c) s+(s-r)(s+1)=(s-r)(2 s+1)+c s \leq(s-(c+1) / 2)(2 s+1)+c s
$$

which again is less than $2 s^{2}$. Our last subcase is when $r=(c-1) / 2$, when we have

$$
c N(r+2)=(s-(c-1) / 2)(2 s+1)+c s=2 s^{2}+2 s-(c-1) / 2
$$

Observe that when $s \equiv(c-1) / 2 \bmod c$, then $2 s^{2}+2 s-\left(c^{2}-1\right) / 2 \equiv 0 \bmod c^{2}$, and since $|G|$ must be divisible by $c^{2}$, this is the largest it can then be.

Our final case is when $c$ is odd and $r=c-1$; we consider $i=0$. In this case the values of $h$ with $|h| \leq s$ and $h \equiv 0 \bmod$ $c$ are $h=s+1-z c$ for $z=1,2, \ldots, z_{\max }$, where

$$
z_{\max }=\lfloor(2 s+1) / c\rfloor=(2 s+2-c) / c
$$

Note that $z_{\max }$ is odd. Since $s$ and $h=s+1-z c$ have the same parity when $z$ is odd and different parity when $z$ is even, we have

$$
N(0)=\left(z_{\max }-1\right) / 2 \cdot s+\left(z_{\max }+1\right) / 2 \cdot(s+1)
$$

and thus

$$
c N(0)=(s+1-c) s+(s+1)(s+1)=2 s^{2}-(c-3) s+1
$$

which is less than $2 s^{2}$, unless $c=3$. This completes our proof.
Theorem 3.3 For $s \geq 3$, every s-regular abelian group of rank 2 has order at most $2 s^{2}+2 s-4$, with equality if, and only if, it is isomorphic to $\mathbb{Z}_{3} \times \mathbb{Z}_{\left(2 s^{2}+2 s-4\right) / 3}$ for some $s \equiv 1 \bmod 3$.

Proof. Suppose that $G=\mathbb{Z}_{c} \times \mathbb{Z}_{c k}$ is an $s$-regular group of order at least $2 s^{2}+2 s-4$ for some integers $s \geq 3, c \geq 2$, and $k \geq 1$. Then, by Theorem 3.2, $c$ is odd; furthermore,

- $s \equiv 0 \bmod c$, and $2 s^{2}+2 s-4 \leq c^{2} k \leq 2 s^{2}+s$, or
- $s \equiv(c-1) / 2 \bmod c$, and $2 s^{2}+2 s-4 \leq c^{2} k \leq 2 s^{2}+2 s-\left(c^{2}-1\right) / 2$.

Since the first possibility leads to no solutions, our claim is established.

## 4 The groups $\mathbb{Z}_{2} \times \mathbb{Z}_{2 k}$

In this section we provide some results for $s$-spanning sets in groups of the form $\mathbb{Z}_{2} \times \mathbb{Z}_{2 k}$, including the exact value of the largest possible order of such groups. Our general conjecture is as follows.

Conjecture 4.1 Let $k$ and $s$ be positive integers. The group $\mathbb{Z}_{2} \times \mathbb{Z}_{2 k}$ has an s-spanning set of size $2 i f$, and only if, one of the following holds:

- $s$ is odd and $k \leq\left(s^{2}-1\right) / 2$;
- $s$ is even and $k \leq\left(s^{2}-s\right) / 2$;
- $s \equiv 0 \bmod 4, k$ is even, and $\left(s^{2}-s\right) / 2<k \leq s^{2} / 2$; or
- $s \equiv 2 \bmod 4, k \equiv 2 \bmod 4$, and $\left(s^{2}-s\right) / 2<k \leq s^{2} / 2$.

Theorem 4.2 Let $k$ and $s$ be positive integers. If the group $G=\mathbb{Z}_{2} \times \mathbb{Z}_{2 k}$ has an s-spanning set of size 2, then it has order at most $2 s^{2}$.

Proof. If $G$ is $s$-regular, that is, it has an $s$-spanning set of the form $\{(1, u),(1, v)\}$ for some $u, v \in \mathbb{Z}_{2 k}$, then our claim follows from Theorem [3.2. Since no set of the form $\{(0, u),(0, v)\}$ can be a spanning set, we can suppose that $G$ has an $s$ spanning set of the form $A=\{(0, u),(1, v)\}$ for some $u, v \in \mathbb{Z}_{2 k}$. Therefore, each element in $\langle A\rangle_{s}$ has the form $\left(\lambda_{2}, \lambda_{1} u+\lambda_{2} v\right)$ for some integers $\lambda_{1}$ and $\lambda_{2}$ with $\left|\lambda_{1}\right|+\left|\lambda_{2}\right| \leq s$.

Clearly, if $u$ and $v$ are both even, then $A$ can only generate elements of $G$ with an even second component, and thus it cannot be a spanning set.

Now if $u$ and $v$ are both odd, then $\lambda_{1} u+\lambda_{2} v$ has the same parity as $\lambda_{1}+\lambda_{2}$ does. According to Lemma 2.1] the parity of $\lambda_{1}+\lambda_{2}$ differs from the parity of $s$ exactly $s^{2}$ times (and agrees with it $(s+1)^{2}$ times) within $\left|\lambda_{1}\right|+\left|\lambda_{2}\right| \leq s$. This means that $A$ cannot generate more than $s^{2}$ elements in $\mathbb{Z}_{2} \times \mathbb{Z}_{2 k}$ whose second coordinate has different parity than $s$ does, so if it is an $s$-spanning set, then we must have $|G| \leq 2 s^{2}$.

Next, if $u$ is even and $v$ is odd, then for each element of $G$ that $A$ generates, its two components will have the same parity (namely, the parity of $\lambda_{2}$ ). Therefore, $A$ cannot be a spanning set.

Finally, we prove that if $A=\{(0, u),(1, v)\}$ is an $s$-spanning set of $G$ with $u$ odd and $v$ even, then $A^{\prime}=\{(1, u),(1, v)\}$ is an $s$-spanning set as well, meaning that $G$ is $s$-regular and thus has order at most $2 s^{2}$ by Theorem 3.2,

Let $a \in \mathbb{Z}_{2}$ and $b \in \mathbb{Z}_{2 k}$. Since $\langle A\rangle_{s}=G$, there are integers $\lambda_{1}$ and $\lambda_{2}$ with $\left|\lambda_{1}\right|+\left|\lambda_{2}\right| \leq s$ for which

$$
\lambda_{1}(0, u)+\lambda_{2}(1, v)=\left(\lambda_{2}, \lambda_{1} u+\lambda_{2} v\right)=\left(a^{\prime}, b\right),
$$

where $a^{\prime}=a$ if $b$ is even and $a^{\prime}=1+a$ when $b$ is odd. Observe that when $b$ is even, then (since $u$ is odd and $v$ is even), $\lambda_{1}$ must be even, and thus

$$
\lambda_{1}(1, u)+\lambda_{2}(1, v)=\left(\lambda_{1}+\lambda_{2}, \lambda_{1} u+\lambda_{2} v\right)=\left(\lambda_{2}, \lambda_{1} u+\lambda_{2} v\right)=\left(a^{\prime}, b\right)=(a, b) .
$$

Similarly, when $b$ is odd, $\lambda_{1}$ must be odd, and

$$
\lambda_{1}(1, u)+\lambda_{2}(1, v)=\left(1+a^{\prime}, b\right)=(a, b) .
$$

Therefore, $\left\langle A^{\prime}\right\rangle_{s}=G$, as claimed, which completes our proof.

Theorem 4.3 Let $k$ and $s$ be positive integers with $s$ odd. Then the group $G=\mathbb{Z}_{2} \times \mathbb{Z}_{2 k}$ has an s-spanning set of size 2 if, and only if, $k \leq\left(s^{2}-1\right) / 2$.

Proof. The fact that $k \leq\left(s^{2}-1\right) / 2$ is necessary follows from Theorem 4.2, We may also recall that Theorem 2.4, applied with $c=2$ and odd $s$, yields that with $u=(s-1) / 2$ and $v=(s+1) / 2$, the set $\{(1, u),(1, v)\}$ is an $s$-spanning set in $\mathbb{Z}_{2} \times \mathbb{Z}_{s^{2}-1}$. This takes care of the case $k=\left(s^{2}-1\right) / 2$.

Our goal below is to show that the same values of $u=(s-1) / 2$ and $v=(s+1) / 2$ as integers provide an $s$-span for the set $\mathbb{Z}_{2} \times\{0,1,2, \ldots, k\}$ when $k \leq\left(s^{2}-3\right) / 2$. (Here we consider the operation in the first component in $\mathbb{Z}_{2}$ and in the second component in $\mathbb{Z}$.) By symmetry, we can then conclude that $\mathbb{Z}_{2} \times \mathbb{Z}_{2 k}$ has an $s$-spanning set of size 2 for $k \leq\left(s^{2}-3\right) / 2$ as well.

We thus need to establish that for every $a \in \mathbb{Z}_{2}$ and $b \in\{0,1,2, \ldots, k\}$, there are integers $\mu_{1}$ and $\mu_{2}$ with $\left|\mu_{1}\right|+\left|\mu_{2}\right| \leq s$ for which

$$
\begin{equation*}
\mu_{1}(1,(s-1) / 2)+\mu_{2}(1,(s+1) / 2)=(a, b) \tag{7}
\end{equation*}
$$

holds in $\mathbb{Z}_{2} \times\{0,1,2, \ldots, k\}$.
Let us recall from the proof of Theorem 2.4 (applied again for odd $s$ and $c=2$ ) that there are integers $\lambda_{1} \in[-s, s+1]$ and $\lambda_{2} \in[0, s-2]$ for which one of the following two sets of conditions holds:
(i) $\left|\lambda_{1}\right|+\left|\lambda_{2}\right| \leq s$, and equation (7) is satisfied in $\mathbb{Z}_{2} \times \mathbb{Z}_{s^{2}-1}$ with $\left(\mu_{1}, \mu_{2}\right)=\left(\lambda_{1}, \lambda_{2}\right)$; or
(ii) $\left|\lambda_{1}\right|+\left|\lambda_{2}\right| \geq s+1$, and equation (77) is satisfied in $\mathbb{Z}_{2} \times \mathbb{Z}_{s^{2}-1}$ with $\left(\mu_{1}, \mu_{2}\right)=\left(\lambda_{1}-\epsilon(s+1), \lambda_{2}-s+1\right)$, where $\epsilon$ equals 1 when $\lambda_{1} \geq 0$, and -1 when $\lambda_{1}<0$.

To complete our proof, we will show that, considering

$$
B=\mu_{1}(s-1) / 2+\mu_{2}(s+1) / 2
$$

as an integer (rather than as an element of $\mathbb{Z}_{s^{2}-1}$ ), we have $B=b$. Since $0 \leq b \leq k<\left(s^{2}-1\right) / 2$, it suffices to prove that

$$
\begin{equation*}
-\left(s^{2}-1\right) / 2 \leq B<s^{2}-1 \tag{8}
\end{equation*}
$$

In case (i), we have $\mu_{1}=\lambda_{1} \in[-s, s+1]$ and $\mu_{2}=\lambda_{2} \in[0, s-2]$, from which (8) readily follows. For case (ii), we find that

$$
\left|\mu_{1}\right|+\left|\mu_{2}\right|=\left(s+1-\left|\lambda_{1}\right|\right)+\left(s-1-\left|\lambda_{2}\right|\right) \leq 2 s-(s+1)=s-1
$$

and thus

$$
|B|=\left|\mu_{1}(s-1) / 2+\mu_{2}(s+1) / 2\right| \leq\left|\mu_{1}\right|(s-1) / 2+\left|\mu_{2}\right|(s+1) / 2 \leq\left(\left|\mu_{1}\right|+\left|\mu_{2}\right|\right)(s+1) / 2 \leq\left(s^{2}-1\right) / 2
$$

so (8) holds again. This completes our proof.
Theorem 4.4 Let $k$ and $s$ be positive integers with $s$ even. Then the group $G=\mathbb{Z}_{2} \times \mathbb{Z}_{2 k}$ has an s-spanning set of size 2 if $k \leq\left(s^{2}-s\right) / 2$.

Proof. Like in the proof of Theorem 4.3, we will prove that there are integers $u$ and $v$ for which the $s$-span of $A=$ $\{(1, u),(1, v)\}$ contains the set $\mathbb{Z}_{2} \times\{0,1,2, \ldots, k\}$. (Here too we consider the operation in the first component in $\mathbb{Z}_{2}$ and in the second component in $\mathbb{Z}$.)

Since $s-1$ is odd, from the proof of Theorem4.3 we see that with $u=(s-2) / 2$ and $v=s / 2,\langle A\rangle_{s-1}$ contains the set $\mathbb{Z}_{2} \times\{0,1,2, \ldots, k\}$ when $k \leq\left((s-1)^{2}-1\right) / 2$. Therefore, $(1, v)+\langle A\rangle_{s-1}$ contains $\mathbb{Z}_{2} \times\{s / 2, s / 2+1, \ldots, s / 2+k\}$ for each $k \leq\left(s^{2}-2 s\right) / 2$, and since $(1, v)+\langle A\rangle_{s-1} \subseteq\langle A\rangle_{s}$, our claim follows for all $k \leq\left(s^{2}-s\right) / 2$.
