ON g-FINITENESS IN THE CATEGORY OF PROJECTIVE PRESENTATIONS

ABSTRACT. We provide new equivalent conditions for an algebra Λ to be gfinite, analogous to those established by L. Demonet, O. Iyama, and G. Jasso, but within the category of projective presentations $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$. We show that an algebra has finitely many isomorphism classes of basic 2-term silting objects if and only if all cotorsion pairs in $\mathcal{K}^{[-1,0]}(proj\Lambda)$ are complete. Furthermore, we establish that this criterion is also equivalent to all thick subcategories in $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$ having enough injective and projective objects. Keywords. Projective presentation, g-finite algebra, thick subcategory, cotorsion pair, silting object.

1. INTRODUCTION

The notion of support τ -tilting module [\[AIR14\]](#page-24-1) was inspired in part by the additive categorification of cluster algebras (see $[Ami09, BMR⁺06]$ $[Ami09, BMR⁺06]$ $[Ami09, BMR⁺06]$ or survey papers [\[Kel11,](#page-25-0) [Ami11\]](#page-24-4)). When Λ is the Jacobi algebra $\mathcal{J}(Q, W)$ associated with a quiver Q with non-degenerate potential W , the set of reachable basic 2-term silting complexes is in bijection with the set of clusters of the cluster algebra \mathcal{A}_{Q} associated to (Q, W) . One of the first questions to be settled when cluster algebras were introduced is whether the set of clusters of a given cluster algebra A_Q is finite. This turned out to be equivalent to Q being mutation-equivalent to a quiver of Dynkin type [\[FZ03\]](#page-24-5). Since Dynkin quivers are representation finite, $\mathcal{K}^{[-1,0]}(\text{proj }J(Q, W))$ has only finitely many isoclasses of indecomposable objects and thus finitely many

isoclasses of basic 2-term silting objects. For a general finite-dimensional k-algebra Λ, this does not have to be the case, prompting the introduction of the following definition.

Definition 1.1. [\[DIJ19\]](#page-24-6) Let Λ be a finite-dimensional k-algebra. We say that Λ is g-finite if it admits only finitely many isomorphism classes of basic 2-term silting objects.

The study of g-finite algebras was introduced by L. Demonet, O. Iyama and G. Jasso in [\[DIJ19\]](#page-24-6), who showed that an algebra Λ being g-finite has deep implications on the structure of mod Λ .

Theorem 1.2. [\[DIJ19,](#page-24-6) Theorems 3.8 and 4.2] Let Λ be a finite-dimensional kalgebra. The following are equivalent:

(1) Λ is q-finite.

(2) There exist finitely many functorially finite torsion classes in mod Λ .

- (3) All torsion classes in mod Λ are functorially finite.
- (4) There exist finitely many isomorphism classes of bricks in mod Λ .

Recall that functorially finite torsion classes are in one-to-one correspondence with left finite wide subcategories $[MS17, IT09]$ $[MS17, IT09]$. Since left finite wide subcategories are defined as those such the smallest torsion class containing them is functorially finite, the following corollary is immediate.

Corollary 1.3. Let Λ be a finite-dimensional k-algebra. If Λ is g-finite, then all wide subcategories are left finite.

In this article, we study the consequences that being g -finite has on the correspondences between complete cotorsion pairs, 2-term silting objects and thick subcategories with enough injectives in $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$ introduced in [\[Gar23\]](#page-24-8). Specifically, we provide analogs of Theorem [1.2](#page-1-0) and Corollary [1.3.](#page-1-1)

Theorem 1.4. Let Λ be a finite-dimensional k-algebra. The following are equivalent:

- (1) Λ is g-finite.
- (2) There exist finitely many complete cotorsion pairs in $\mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$.
- (3) All cotorsion pairs in $\mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$ are complete.
- (4) There exist finitely many thick subcategories in $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$.

Theorem [\(4.22\)](#page-23-0). Suppose Λ is g-finite. Then all thick subcategories of $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$ have enough injectives.

To show condition (3) of Theorem [1.4](#page-1-2) we extend a result of D. Pauksztello and A. Zvonareva [\[PZ23\]](#page-25-2).

Theorem [\(4.3\)](#page-12-2). Let Λ be a finite-dimensional k-algebra. Then the functor H^0 : $\mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda) \to \text{mod}\,\Lambda$ *induces a bijection*

$$
H^0: \mathrm{cotor}\,\Lambda \to \mathrm{tors}\,\Lambda
$$

$$
(\mathcal{X}, \mathcal{Y}) \mapsto H^0(\mathcal{Y}).
$$

Recall that the set of torsion classes of mod Λ equipped with the inclusion forms a lattice, that is, a poset in which any two elements have an unique least upper bound (or *join*), and an unique greatest lower bound (or *meet*) (see for instance [\[Tho21\]](#page-25-3)).

In a similar way, we can equip the set of cotorsion pairs in $\mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$ with a poset structure: for any $(\mathcal{X}, \mathcal{Y})$ and $(\mathcal{X}', \mathcal{Y}') \in \text{cotor}\,\Lambda$ we say that $(\mathcal{X}, \mathcal{Y}) \leq (\mathcal{X}', \mathcal{Y}')$ if $Y ⊂ Y'$. Since H^0 preserves inclusions, Theorem [4.3](#page-12-2) gives the following corollary.

Corollary 1.5. Let Λ be a finite-dimensional k-algebra. Then the set cotor Λ of cotorsion pairs in $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$ forms a lattice which is isomorphic to the lattice tors Λ of torsion classes in mod Λ .

To establish the equivalence between being g-finite and condition (4) , we show that when Λ is g-finite, then all thick subcategories in $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$ contain a presilting object. The proof of this fact relies on geometric results on the degeneration of objects of the triangulated category \mathcal{K}^b (proj Λ) [\[JSZ05\]](#page-24-9). We also develop a reduction argument by explicitly computing the silting reduction of the extriangulated category $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$ by a presilting object in the manner of that developed by O. Iyama and D. Yang for triangulated categories in [\[IY18\]](#page-24-10). Moreover, we show that the categories obtained after reduction are equivalent to the extriagnulated category per^[-1,0](Γ) of 2-term complexes over a certain non positive dg-algebra Γ.

2. Preliminaries

The goal of this section is to introduce the necessary preliminaries for Sections [3](#page-7-0) and [4.](#page-12-0) We recall the definition of the extriangulated category of 2-term perfect complexes per^[-1,0](Λ) over a dg algebra Γ, of which $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$ is a special case. For a broader introduction to dg categories see [\[Kel94,](#page-24-12) [Kel06\]](#page-24-13). Most of the results in this section are taken from [\[BY13,](#page-24-14) [KY14\]](#page-25-4). Throughout this paper, we fix a field k.

2.1. dg algebras and dg categories. Recall that a differential graded algebra, or dg algebra for short, is a graded k-algebra $\Gamma = \bigoplus_{i \in \mathbb{Z}} \Gamma^i$ equipped with a homogeneous k-linear map of degree one $d_{\Gamma}: \Gamma \to \Gamma$ such that

i) $d_{\Gamma}(ab) = d_{\Gamma}(a)b + (-1)^i ad_{\Gamma}(b) \quad \forall a \in \Gamma^i$ and $b \in \Gamma$; ii) $d_{\Gamma} \circ d_{\Gamma} = 0$.

We call d_{Γ} the *differential* of Γ. We say a a dg algebra Γ is non-positive if $\Gamma^{i} = 0$ for all $i \geq 1$. We say that Γ it is *finite-dimensional* if it is finite-dimensional as a k-vector space. A dg Γ-module is a graded right Γ-module $X = \bigoplus_{i \in \mathbb{Z}} X^i$ equipped with a homogeneous k-linear map of degree one $d_X : X \to X$ such that

$$
d_X(xa) = d_X(x)a + (-1)^i x d_{\Gamma}(a) \,\forall a \in \Gamma \text{ and } x \in X^i.
$$

For a given dg Γ-module X, we denote by $H^{i}(X) = \text{Ker} d_X^{i}/\text{Im} d_X^{i-1}$. Recall that for any X and Y dg Γ -modules we have the dg k-module

$$
\mathcal{H}om_{\Gamma}(X,Y)=\bigoplus_{i\in\mathbb{Z}}\mathcal{H}om_{\Gamma}^{i}(X,Y)
$$

where \mathcal{H} om^{*i*}(*X,Y*) is the subset of $\prod \text{Hom}_{\Gamma}(X^j, Y^{j+i})$ of elements $(f_j)_{j\in\mathbb{Z}}$ such j∈Z

that

$$
f_j(x)a = f_{j+n}(xa)
$$
 for all $x \in X^j$ and $a \in \Gamma^n$;

whose differential is given by the map

$$
f \in \mathcal{H}om_{\Gamma}^{i}(X, Y) \mapsto f \circ d_{X} - (-1)^{i} d_{Y} \circ f.
$$

When $X = Y$, we will write $\mathcal{H}_{\text{om}_\Gamma}(X, Y) = \mathcal{E}_{\text{nd}_\Gamma}(X)$. Note that given two dg Γmodules X and Y, the kernel of d^0 , which we denote by $Z^0(\mathcal{H}_{\text{OM}_\Gamma}(X,Y))$, is nothing but the set of Γ -linear maps that commute with the differentials of X and Y . For any dg Γ-module X with differential d_X and $i \in \mathbb{Z}$, let $X[i]$ be the dg module whose underlying graded Γ-module is $\bigoplus_{j\in\mathbb{Z}} X^{i+j}$ equipped with the differential $(-1)^id_X$, then the sets $H^i(\mathcal{H}om_{\Gamma}(X,Y))$ correspond to the sets $Z^0(\mathcal{H}om_{\Gamma}(X,Y[i]))$ modulo the homotopy relation.

Definition 2.1. Let Γ be a dg algebra. We denote by $\mathcal{C}(\Gamma)$ the category whose objects are dg Γ-modules and whose morphism spaces are given by

$$
\operatorname{Hom}_{\mathcal{C}(\Gamma)}(X, Y) = Z^0(\mathcal{H}om_{\Gamma}(X, Y)).
$$

We will denote by $\mathcal{K}(\Lambda)$ the category whose objects are the same as those of $\mathcal{C}(\Gamma)$ but whose morphism spaces are given by

$$
\operatorname{Hom}_{\mathcal{K}(\Gamma)}(X, Y) = H^0(\mathcal{H}om_{\Gamma}(X, Y)).
$$

The *derived category* associated to Γ is the triangulated quotient

$$
\mathcal{D}(\Gamma) = \mathcal{K}(\Gamma)/\mathcal{N},
$$

where $\mathcal N$ is the thick subcategory of objects whose cohomologies are all 0. In other words, $\mathcal{D}(\Gamma)$ is the Verdier localisation of $\mathcal{K}(\Gamma)$ by quasi-isomorphisms.

We will denote by $\mathcal{D}_{fd}(\Gamma)$ the full subcategory of $\mathcal{D}(\Gamma)$ of dg Γ-modules whose total cohomology is finite-dimensional. We will consider as well the category $per(\Gamma) = \text{thick}_{\mathcal{D}(\Gamma)}(\Gamma) \subset \mathcal{D}(\Gamma)$, know as the *category of perfect complexes* over Γ.

Example 2.2. Let Λ be a finite-dimensional k-algebra. Seen as a dg algebra concentrated in degree 0, then $\mathcal{C}(\Lambda)$ is precisely the category $\mathcal{C}(\text{Mod }\Lambda)$ of complexes of (not necessarily finite-dimensional) Λ -modules, $\mathcal{D}(\Lambda)$ is $\mathcal{D}(\text{Mod }\Lambda)$, $\mathcal{D}_{fd}(\Lambda)$ corresponds to $\mathcal{D}^b(\text{mod }\Lambda)$ and $\text{per}(\Lambda)$ is equivalent to $\mathcal{K}^b(\text{proj }\Lambda)$.

Theorem 2.3. [\[KY14,](#page-25-4) Lemma 4.1] [\[Kel06,](#page-24-13) Theorem 3.8 b)] Let C be an algebraic triangulated category, that is, equivalent to the stable category of a Frobenius category. Suppose that C has split idempotents and a silting object $X \in \mathcal{C}$. Then there exists a non-positive dg algebra Γ and a triangle equivalence

$$
\mathrm{per}(\Gamma) \xrightarrow{\simeq} \mathcal{C}
$$

which takes Γ to X. In particular $H^0(\Gamma) \simeq \text{Hom}_{\text{per}(\Gamma)}(\Gamma, \Gamma) \simeq \text{Hom}_{\mathcal{C}}(X, X)$.

2.2. 2-term silting objects and 2-term simple-minded collections. Let $\mathcal D$ be a triangulated category which is essentially small, Krull–Schmidt, k-linear and Hom-finite with shift functor Σ . Recall that a silting object V of D is an object that satisfying $\text{Hom}_{\mathcal{D}}(V, \Sigma^i V) = 0$ for all $i > 0$ and such that thick $_{\mathcal{D}}(V) = \mathcal{D}$. Let V be a silting object in D, we say that an object $X \in \mathcal{D}$ is 2-term with respect to V if there exist $Y, Y' \in \text{add}(V)$ and a triangle

$$
Y' \to Y \to X \dashrightarrow Y'[1].
$$

We will denote by $V * \Sigma V$ the full subcategory of 2-term objects with respect to V. When $\mathcal{D} = \text{per}(\Gamma)$, where Γ is a finite-dimensional non-positive dg algebra, then $Γ$ is itself a silting object in per(Γ), since $Hom_{per(Γ)}(Γ, Γ[*i*]) \simeq Hⁱ(Γ) = 0$ for all $i > 0$. We write per^[-1,0](Γ) := Γ * Γ[1] for the full subcategory of 2-term objects of per Γ with respect to Γ. We will refer to per^[-1,0](Γ) simply as the category of 2-term objects of Γ and denote by 2-silt Γ the set isomorphism classes of basic 2-term silting objects in per (Γ) .

Lemma 2.4 (Bongartz Completion). [\[IJY14,](#page-24-15) Lemma 4.2] Let \mathcal{D} be a triangulated category which is essentially small, Krull–Schmidt, k-linear and Hom-finite with shift functor Σ . Suppose that D possesses a silting object $V \in \mathcal{D}$. Let $U \in \mathcal{D}$ be a presilting object in $V * \Sigma V$, then there exists and object $U' \in V * \Sigma V$ such that $U \oplus U'$ is a silting object in D .

The following consequence of Lemma [2.4](#page-4-1) is of particular importance. It allows us to ascertain whether a 2-term presilting object U in a triangulated category $\mathcal D$ is silting by examining its number of non-isomorphic direct summands, which we denote by $|U|$.

Proposition 2.5. [\[IJY14,](#page-24-15) Proposition 4.3] Let \mathcal{D} be as in Lemma [2.4](#page-4-1) and let U be a presilting object in $V * \Sigma V$. Then U is silting if and only if $|V| = |U|$.

Definition 2.6. Let C be a triangulated category with shift functor Σ . A collection of objects $X_1, X_2, \cdots X_r$ is said to be *simple-minded* if the following conditions hold for any $1 \leq i, j \leq n$:

- i) Hom $_{\mathcal{C}}(X_i, \Sigma^m X_j) = 0$ for all $m < 0$,
- ii) End $_c(X_i)$ is a division algebra and $\text{Hom}_c(X_i, X_j) = 0$ when $i \neq j$.
- iii) thick_C({ $X_1, \cdots X_r$ }) = C.

We denote by smc Γ the set of isomorphism classes of simple-minded collections of $\mathcal{D}_{fd}(\Gamma)$.

If Γ is a finite-dimensional non-positive dg algebra, then the set $\{S_1, \dots S_n\}$ of pairwise non-isomorphic simple $H^0(\Gamma)$ -modules is a simple-minded collection in $\mathcal{D}_{fd}(\Gamma)$ [\[BY13,](#page-24-14) Appendix A.1]. We say that a simple-minded collection of $\mathcal{D}_{fd}(\Gamma)$ is 2-term if $H^j(X_i) = 0$ for all $j \neq 0, 1$ and all $1 \leq i \leq n$. We denote by 2-smc Γ the set of isomorphism classes of 2-term simple-minded collections.

Remark 2.7. [\[BY13,](#page-24-14) Remark 4.11] Let Λ be a finite-dimensional k-algebra. Suppose that $\{X_1, \dots, X_n\}$ is a 2-term simple-minded collection in $\mathcal{D}^b(\text{mod }\Lambda)$, then for any $1 \leq i \leq n$ the object X_i belongs to either mod Λ or $(\text{mod }\Lambda)[1]$.

Theorem 2.8. [\[KN13,](#page-25-5) [KY14\]](#page-25-4) [\[BY13,](#page-24-14) Corollary 4.1] Let Γ be a homologically smooth non-positive dg algebra or a finite-dimensional \Bbbk -algebra. Then there exists a bijection

$$
\Omega:\operatorname{silt}\Gamma\to\operatorname{smc}\Gamma
$$

that restricts to a bijection $\Omega: 2$ -silt $\Gamma \to 2$ -smc Γ between the set of 2-term silting objects and 2-term simple-minded collections.

When $\Gamma = \Lambda$ is a finite-dimensional k-algebra, the bijection in Theorem [2.8](#page-4-2) is given in the following way. Let U be a silting object in per Λ . By Theorem [2.3,](#page-3-0) there exists a non-positive dg algebra B together with a triangle equivalence $\mathcal{D}(B) \rightarrow$ $\mathcal{D}(\Lambda)$ that takes B to U. The simple-minded collection $\{X_1, \cdots X_n\}$ corresponding to U under the map Ω is the image under the equivalence $\mathcal{D}(B) \to \mathcal{D}(\Lambda)$ of a complete collection of non-isomorphic simple $H^0(B)$ -modules. In particular, any simple-minded collection has $n = |U| = |\Lambda|$ elements.

2.3. 0-Asulander extriangulated categories. Extriangulated categories were introduced by H. Nakaoka and Y. Palu in [\[NP19\]](#page-25-6) as a mean to generalize both triangulated and exact categories. Examples of extriangulated categories include extension-closed full subcategories of an extriangulated category. In particular, for any given dg algebra Γ, the category $per^{[-1,0]}(\Gamma)$ of 2-term complexes is extriangulated when equipped with the extension functor given by $\mathbb{E}(X, Y) = \text{Hom}_{\text{per}(\Lambda)}(X, Y[1])$ for any $X, Y \in \text{per}^{[-1,0]}(\Gamma)$.

We say that a sequence $X \stackrel{f}{\rightarrow} Y \stackrel{g}{\rightarrow} Z$ in per^[-1,0](Γ) is a *conflation* if there exists $\delta \in \text{Hom}_{\text{per}(\Lambda)}(Z, X[1])$ such that (f, g, δ) is a triangle in per(Γ). In such cases, we say that f is an *inflation*, which we denote by $X \stackrel{f}{\rightarrow} Y$, and we write that $Z =$ Cone(f). Similarly, we say that g is a deflation, which we denote by $Y \stackrel{g}{\rightarrow} Z$, and we write $X = \text{Cocone}(q)$. The following definition is due to M. Gorsky, H. Nakaoka and Y. Palu.

Definition 2.9. [\[GNP23\]](#page-24-16)[Definition 3.7] An extriangulated category is a 0-Auslander if it has enough projectives, enough injectives, global dimension at most one, dominant dimension at least one, and codominant dimension at least one.

When Γ is a non-positive dg algebra, $per^{[-1,0]}(\Gamma)$ is an example of a 0-Auslander extriangulated category. Indeed, by definition for any $X \in \text{per}^{[-1,0]}(\Gamma)$ there exists a conflation $U' \rightarrowtail U \rightarrowtail X$ where $U, U' \in add(\Gamma)$ are projective objects in per^[-1,0]. Similarly, there is a conflation $X \rightarrowtail V \rightarrowtail V'$, where $V, V' \in add(\Gamma[1])$ are injective objects. To see that $per^{[-1,0]}(proj \Lambda)$ has dominant and codominant dimension at least one([\[GNP23\]](#page-24-16)[Definition 3.5]), remark that all projective objects in per^[−1,0](Γ) lie in add(Γ), all injective objects lie in add(Γ[1]) and for all $U \in \text{add}(\Gamma)$ we have a conflation $U \rightarrow 0 \rightarrow U[1]$.

Proposition 2.10. [\[FGP](#page-24-17)+23, Proposition 3.2, Corollary 3.3] Let C be a 0-Auslander extriangulated category and let J be an ideal generated by morphisms with injective domain and projective codomain. Then the ideal quotient C/J is a 0-Auslander extriangulated category.

We now recall the relation between 2-term silting objects of a finite-dimensional non-positive dg algebra Γ and those of the finite-dimensional algebra $H^0(\Gamma)$. Let $\bar{\Gamma} = H^0(\Gamma)$ and $p: \Gamma \to \bar{\Gamma}$ the canonical projection. The map p gives rise to the triangulated functor

$$
p_* : \text{per}(\Gamma) \longrightarrow \text{per}(\overline{\Gamma})
$$

 $X \longmapsto X \otimes_{\Lambda} H^0(\Lambda),$

which we refer to as the *induction functor*. Since $\text{Hom}_{\text{per}(\Gamma)}(\Gamma,\Gamma) = \overline{\Gamma} = \text{Hom}_{\overline{\Gamma}}(\overline{\Gamma},\overline{\Gamma}),$ then p_* induces an equivalence $\mathrm{add}_{\mathrm{per}(\Gamma)}(\Gamma) \simeq \mathrm{add}_{\mathrm{per}(\overline{\Gamma})}(\overline{\Gamma}),$ where $\mathrm{per}(\overline{\Gamma}) \simeq \mathcal{K}^b(\mathrm{proj}\,\overline{\Gamma}).$

Proposition 2.11. [\[BY13,](#page-24-14) Proposition A.5] Let *I* be the ideal of per^[−1,0](Γ) consisting of morphisms factoring through morphisms $X[1] \rightarrow Y$ with $X, Y \in$ $add_{per(\Gamma)}(\Gamma)$. Then $\mathcal{I}^2 = 0$ and p_* induces an equivalence of k-linear categories $per^{[-1,0]}(\Gamma)/\mathcal{I} \to \mathcal{K}^b$ (proj $\overline{\Gamma}$). In particular, p_* is full, detects isomorphisms, preserves indecomposability and induces a bijection between isomorphism classes of *objects of* per^[-1,0](Γ) and \mathcal{K}^b (proj $\bar{\Gamma}$).

Remark 2.12. By the previous proposition and Proposition [2.10,](#page-5-1) we know that the induction functor is an extriangulated functor and that the equivalence in Proposition [2.11](#page-6-0) is an equivalence of 0-Auslander extriangulated categories.

The following result will be useful in what follows.

Corollary 2.13. Let $X, Z \in \text{per}^{[-1,0]}(\Gamma)$ and suppose there is a conflation

$$
(2.1) \t\t p_*(X) \rightarrow \bar{Y} \rightarrow p_*(Z) \xrightarrow{f} \rightarrow
$$

where $\overline{Y} \in \text{per}^{[-1,0]}(H^0(\Gamma)).$ Then there exists $Y \in \text{per}^{[-1,0]}(\Gamma)$ and a conflation

$$
X \rightarrowtail Y \rightarrow Z \xrightarrow{F}
$$

whose image by p_* is the conflation [2.1.](#page-6-1)

Proof. Let $\bar{X} = p_*(X)$, $\bar{Z} = p_*(Z)$ and $f \in \text{Hom}_{\text{per}(H^0(\Gamma))}(\bar{Z}, \bar{X}[1])$. Given that $\bar{X} \in \text{per}^{[-1,0]}(H^0(\Gamma)),$ there exists a conflation

$$
\bar{X}^{-1} \rightarrowtail \bar{X}^0 \stackrel{i}{\rightarrow} \bar{X}
$$

where $\bar{X}^{-1}, \bar{X}^0 \in \text{add}(H^0(\Gamma)).$ Since $\text{Hom}_{\text{per}(H^0(\Gamma))}(\bar{Z}, \bar{X}^{-1}[2]) = 0$, there exists $h : \bar{Z} \to \bar{X}^0[1]$ such that $f = i[1]h$. But p_* induces and equivalence between add(Γ) and add($H^0(\Lambda)$), so there exists $X^0 \in \text{add}(\Gamma)$ such that $p_*(X^0) \simeq \overline{X}^0$. Since p_* induces an equivalence between per^[-1,0](Γ)/*I* and \mathcal{K}^b (proj Γ), it is in particular a full functor and hence there exists $I \in Hom_{per(\Lambda)}(X^0, X)$ and $H \in$ $\text{Hom}_{\text{per}(\Gamma)}(Z, X^0[1])$ such that $p_*(I) = i$ and $p_*(H) = h$. Then the morphism $F = I[1]$ $H \in \text{Hom}_{\text{per}(\Gamma)}(Z, X[1])$ satisfies that

$$
p_*(F) = p_*(I[1]H) = p_*(I[1])p_*(H) = p_*(I)[1]p_*(H) = i[1]h = f,
$$

and that $p_*(\text{Cocone}(F)) \simeq \overline{Y}$. By letting $Y = \text{Cocone}(F)$ we get the result. \Box

We end this section with the following result by T . Brüstle and D . Yang, which relates the set of isomorphism classes of 2-term silting objects in per $[-1,0](\Gamma)$ and that of per^[-1,0]($\bar{\Gamma}$).

Proposition 2.14. [\[BY13,](#page-24-14) Proposition A.3] The induction functor $p_* : \text{per}(\Gamma) \rightarrow$ \mathcal{K}^b (proj $\bar{\Gamma}$) induces a bijection between the sets of isomorphism classes of 2-term silting objects 2-silt Γ and 2-silt $\overline{\Gamma}$.

3. SILTING REDUCTION IN $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$

The goal of this section is to explicitly describe the reduction of $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$ with respect to a presilting object U . Reductions for hereditary extriangulated categories were treated in general in [\[GNP23,](#page-24-16) Section 2.2.3]. In our setting, we show that the reduction of $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$ by a 2-term presilting complex is equivalent to the 2-term category of perfect complexes over a non-positive dg algebra. This is done using Iyama-Yoshino reduction in \mathcal{K}^b (proj Λ) [\[IY08\]](#page-24-18) as well as Iyama-Yang's results showing that the Verdier localisation by a presilting object is a reduction [\[IY18\]](#page-24-10). We show that both operations are compatible with those in [\[GNP23\]](#page-24-16). This is a particular case of the reduction of a 0-Auslander triangulated category K with respect to a presilting object U being equivalent to the Verdier localization $\mathcal{K}/\text{thick}(U)$, which was shown in general in [\[Bør24\]](#page-24-11).

3.1. Thick subcategories generated by 2-term presilting complexes. Let H be a full subcategory of an extriangulated category $\mathcal K$. We say that H is closed under extensions if for every conflation $X \stackrel{f}{\rightarrow} Y \stackrel{g}{\rightarrow} Z$ such that $X, Z \in \mathcal{H}$, then $Y \in \mathcal{H}$ as well. We say that \mathcal{H} is closed under cones (resp. closed under cocones) if for any inflation $X \stackrel{f}{\rightarrow} Y$ (resp. deflation $X \stackrel{g}{\rightarrow} Y$) with $X, Y \in \mathcal{H}$ we have that $Cone(f) \in \mathcal{H}$ (resp. $Cocene(g) \in \mathcal{H}$).

Definition 3.1. [\[NOS22\]](#page-25-7) Let K be an extriangulated category. We say that a full subcategory $\mathcal{H} \subset \mathcal{K}$ is thick if it is stable under finite direct sums and direct summands, and closed under extensions, cones and cocones.

If D is a triangulated category with shift functor Σ , then a full subcategory $\mathcal T$ of $\mathcal D$ is thick (with respect to the previous definition) if and only if it is a triangulated subcategory which is stable under direct summands. Recall that if $K \subset \mathcal{D}$ is a full and closed under extensions, then it is extriangulated [\[NP19\]](#page-25-6) with respect to $\Sigma|_{\mathcal{K}}$. The next proposition follows from the definitions.

Proposition 3.2. Let $\mathcal{T} \subset \mathcal{D}$ be a thick subcategory of \mathcal{D} and let $\mathcal{K} \subset \mathcal{D}$ be closed under extensions and direct summands. Then $\mathcal{T} \cap \mathcal{K}$ is a thick subcategory of the extriangulated category K.

In what follows, $\mathcal{D} = \mathcal{K}^b(\text{proj}\,\Lambda)$ and $\mathcal{K} = \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$. Since we will work with the notion of thick subcategory in the triangulated category \mathcal{K}^b (proj Λ) as well as the notion of thick subcategory in the extriangulated category $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$, to avoid confusion, for any subcategories $\mathcal{C} \in \mathcal{K}^b(\text{proj}\,\Lambda)$ and $\mathcal{H} \in \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$ we will denote thick_b(C) the smallest (triangulated) thick subcategory in \mathcal{K}^b (proj Λ) containing C, and by thick_[−1,0](H) the smallest (extringulated) thick subcategory of $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$ that contains \mathcal{H} . The following proposition relates both notions.

Lemma 3.3. Let $U \in \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$ be a 2-term presilting object and $\mathcal{U} = \text{add}(U)$, then

thick_[-1,0](U) = thick_b(U) ∩ K^[-1,0](proj Λ) = (U[-1] * U * U[1]) ∩ K^[-1,0](proj Λ).

In order to prove Lemma [3.3](#page-7-2) we will make use of the following proposition.

Proposition 3.4. Let D be a Hom-finite, Krull-Schmidt triangulated category. If $\mathcal{U} = \text{add}(\mathcal{U})$ is a presilting subcategory of C, then

(i) [\[IY18,](#page-24-10) Propositions 2.7] For all $n \leq 0$,

$$
\mathcal{U} * \mathcal{U}[1] * \cdots \mathcal{U}[n] = \mathrm{add}(\mathcal{U} * \mathcal{U}[1] * \cdots \mathcal{U}[n]).
$$

 (ii) [\[AI12,](#page-24-19) Propositions 2.15]

$$
\operatorname{thick}_{\mathcal{D}}(\mathcal{U}) = \bigcup_{n \geq 0} \operatorname{add} (\mathcal{U}[-n] * \mathcal{U}[1-n] * \cdots * \mathcal{U}[n-1] * \mathcal{U}[n])
$$

$$
= \bigcup_{n \geq 0} \mathcal{U}[-n] * \mathcal{U}[1-n] * \cdots * \mathcal{U}[n-1] * \mathcal{U}[n].
$$

Proof of Lemma [3.3.](#page-7-2) It follows from the definitions that thick_[−1,0](U) ⊂ thick_b(U)∩ $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$. Let $X \in (\mathcal{U}[-1] * \mathcal{U} * \mathcal{U}[1]) \cap \mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$, then there exists a triangle

$$
(3.1) \t\t V[-1] \to X \to Y \dashrightarrow V
$$

where $V \in \mathcal{U}$ and $Y \in \mathcal{U} * \mathcal{U}[1]$. In particular Y is a 2-term complex in $\mathcal{U} * \mathcal{U}[1]$. By definition, there exists a triangle

$$
(3.2) \qquad \qquad \bar{U}' \to Y \to \bar{U}[1] \dashrightarrow \bar{U}'[1]
$$

with $\bar{U}, \bar{U}' \in \mathcal{U}$. A rotation of the previous triangle gives a conflation $\bar{U} \rightarrowtail \bar{U}' \rightarrowtail Y$ in $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$, which implies that $Y \in \text{thick}_{[-1,0]}(U)$. By rotating the triangle [3.1,](#page-8-0) we get $X \rightarrow Y \rightarrow V$, implying that $X \in \text{thick}_{[-1,0]}(U)$. Thus

$$
(\mathcal{U}[-1]*\mathcal{U} * \mathcal{U}[1]) \cap \mathcal{K}^{[-1,0]}(\operatorname{proj}\Lambda) \subset \operatorname{thick}_{[-1,0]}(U).
$$

We show now that thick_b $(U) \cap \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda) \subset \mathcal{U}[-1] * \mathcal{U} * \mathcal{U}[1]$. Since \mathcal{U} is presilting, by Proposition [3.4](#page-7-3) we have that

$$
\begin{aligned} \operatorname{thick}_b(U) &= \operatorname{thick}_b(\mathcal{U}) = \\ &= \bigcup_{n \geq 0} \mathcal{U}[-n] * \mathcal{U}[1-n] * \cdots * \mathcal{U}[n-1] * \mathcal{U}[n]. \end{aligned}
$$

Let $X \in \text{thick}_b(U) \cap \mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$. Then there exists n such that $X \in \mathcal{U}[-n]$ * $\mathcal{U}[1-n] * \cdots * \mathcal{U}[n-1] * \mathcal{U}[n]$. Since taking extensions is an associative operation, we can find a triangle

$$
U'[-n] \xrightarrow{f} X \to X' \dashrightarrow U'[1-n]
$$

where $U' \in \mathcal{U}$ and $X' \in \mathcal{U}[1-n] * \cdots * \mathcal{U}[n-1] * \mathcal{U}[n]$. Suppose that $n > 1$. Since both X and U are 2-term complexes, $X \in {}^{\perp} \mathcal{U} \leq 2 \cap \mathcal{U} \geq 2 \rvert$. This implies that $f = 0$ and thus, X is a direct summand of X'. By Proposition [3.4](#page-7-3) i), we know that $\mathcal{U}[1-n] * \cdots * \mathcal{U}[n-1] * \mathcal{U}[n] = \text{add}(\mathcal{U}[1-n] * \cdots * \mathcal{U}[n-1] * \mathcal{U}[n])$ and thus $X \in \mathcal{U}[1-n] * \cdots * \mathcal{U}[n-1] * \mathcal{U}[n]$. By applying the previous argument whenever $i - n < -1$, we can deduce that $X \in \mathcal{U}[-1] * \mathcal{U} * \cdots * \mathcal{U}[n-1] * \mathcal{U}[n]$. Using again the associativity of taking extension, we can find a triangle

$$
X'' \to X \xrightarrow{g} U''[n] \dashrightarrow X''[1].
$$

where $X'' \in \mathcal{U}[-1] * \mathcal{U} * \cdots * \mathcal{U}[n-1]$ and $U'' \in \mathcal{U}$. Once more, if $n > 1$ we deduce that $g = 0$, since both X and U'' are 2-term complexes, and thus X is a direct summand of $X'' \in \mathcal{U}[-1] * \mathcal{U} * \cdots * \mathcal{U}[n-1] = \text{add}(\mathcal{U}[-1] * \mathcal{U} * \cdots * \mathcal{U}[n-1])$. We

conclude that $X \in \mathcal{U}[-1] * \mathcal{U} * \cdots * \mathcal{U}[n-1]$. Applying this argument recursively whenever $n - i > 1$, we finally get that $X \in \mathcal{U}[-1] * \mathcal{U} * \mathcal{U}[1]$. We conclude that

$$
\begin{aligned} (\mathcal{U}[-1]*\mathcal{U} * \mathcal{U}[1]) \cap \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda) &\subset \text{thick}_{[-1,0]}(U) \\ &\subset \text{thick}_{b}(U) \cap \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda) \subset (\mathcal{U}[-1]*\mathcal{U} * \mathcal{U}[1]) \cap \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda), \end{aligned}
$$

which gives the result.

□

Corollary 3.5. Let $\mathcal{H} \subset \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$ be a thick subcategory and consider $U \in \mathcal{H}$ a 2-term presilting object. If thick_b (U) = thick_b (\mathcal{H}) , then thick_[-1,0] $(U) = \mathcal{H}$.

Proof. Suppose thick_b(U) = thick_b(H) and let $\mathcal{U} = \text{add}(U)$. Since $U \in \mathcal{H}$ and since H is thick, we have that thick_[-1,0] $(U) \subset H$. For the other inclusion note that $\mathcal{H} \subset \text{thick}_b(\mathcal{H}) \cap \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda) = \text{thick}_b(U) \cap \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$. By Lemma [3.3,](#page-7-2) thick_b(U) ∩ K^[-1,0](proj Λ) = thick_[-1,0](U), which gives the result. \Box

3.2. Silting reduction in $\mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$. Before introducing the notion of reduction in $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$, let us first recall O. Iyama and D. Yang's additive description of the reduction of a triangulated category with respect to a presilting subcategory.

Theorem 3.6. [\[IY18,](#page-24-10) Theorem 1.1] Let D be a triangulated category and let U be a presilting subcategory of D satisfying certain mild assumptions^{[1](#page-9-1)}. Let \mathcal{J}_U = $\mathcal{D}/\text{thick}_{\mathcal{D}}(\mathcal{U})$ the triangle quotient of D with respect to U. Let $\mathcal{Z}_{\mathcal{U}} = (\perp_{\mathcal{D}} \mathcal{U})$ 0]) $\cap U$ (< 0]^{\perp} ∞). Then the additive quotient $\mathcal{Z}_U/[U]$ has a natural structure of a triangulated category and we have a triangle equivalence

$$
\mathcal{Z}_{\mathcal{U}}/[\mathcal{U}] \stackrel{\bar{\rho}}{\longrightarrow} \mathcal{J}_{\mathcal{U}},
$$

where $\bar{\rho}$ is induced by the functor $\mathcal{Z}_{\mathcal{U}} \subset \mathcal{D} \stackrel{\rho}{\to} \mathcal{D}/\text{thick}_{\mathcal{D}}(\mathcal{U}) = \mathcal{J}_{\mathcal{U}}$.

Theorem 3.7. [\[IY18,](#page-24-10) Theorem 3.7] Under the assumptions of Theorem [3.6,](#page-9-2) the functor $\rho : \mathcal{D} \to \mathcal{J}_\mathcal{U}$ induces a bijection between the sets of presilting subcategories in \mathcal{J}_U and presilting subcategories in D containing U. Moreover, a subcategory $\mathcal{P} \subset \mathcal{D}$ containing U is silting if and only if $\rho(\mathcal{P})$ is silting in \mathcal{J}_U .

From now on $\mathcal{D} = \mathcal{K}^b(\text{proj}\,\Lambda)$ and $\mathcal{U} = \text{add}(U)$ where U is a 2-term presilting object in \mathcal{K}^b (proj Λ). In this setting, the category $\mathcal{J}_\mathcal{U}$ of Theorem [3.6](#page-9-2) has the following explicit description.

Proposition 3.8. [\[Nee92,](#page-25-8) [Bør21\]](#page-24-20) Let Λ be a finite-dimensional algebra and let U be a basic 2-term presilting complex in $\mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$ with Bongartz completion T_U . Then $\mathcal{J}_\mathcal{U} = \mathcal{K}^b(\text{proj}\,\Lambda)/\text{thick}_b(\mathcal{U})$ is equivalent to the category of perfect complexes $per(C_U)$ where C_U is the dg algebra $\mathcal{E}nd_{\mathcal{D}}(T_U)/\langle e_U \rangle$.

Remark 3.9. The choice of C_U as notation is intentional. Let (M, P) be the support τ -rigid pair associated to U, then by [\[Jas15,](#page-24-21) Theorem 4.12 b)]

$$
H^{0}(C_{U}) = \text{End}_{\mathcal{J}_{U}}(T_{U}) \simeq \text{End}_{\Lambda}(H^{0}(T_{U})) / \langle e_{H^{0}(U)} \rangle,
$$

¹These assumptions are satisfied if, for instance, \mathcal{D} is Hom-finite over a field and $\mathcal{U} = \text{add}(U)$ for certain $U \in \mathcal{D}$ that can be completed into a silting object. Since we are working in the context where K is an algebraic 0-Auslander reduced extriangulated category, and thus equivalent to $\mathcal{K}^{[-1,0]}$ (proj Λ) for certain finite-dimensional algebra Λ [\[Che23\]](#page-24-22), the needed assumptions hold (for more on these hypotheses, see [\[IY18,](#page-24-10) Section 3.1]).

where $\text{End}_{\Lambda}(H^0(T_U))/\langle e_{H^0(U)}\rangle = C_{(M,P)}$ is the algebra associated to the τ -tilting reduction of mod Λ by (M, P) as described by G. Jasso in [\[Jas15\]](#page-24-21).

The following result is a weaker version of [\[IY18,](#page-24-10) Lemma 3.4] which will be essential four our results.

Proposition 3.10. [\[IY18,](#page-24-10) Lemma 3.4] The functor K^b (proj Λ) $\stackrel{\rho}{\rightarrow}$ \mathcal{J}_U induces a bijective map

$$
\operatorname{Hom}_{\mathcal{D}}(X, Y[i]) \to \operatorname{Hom}_{\mathcal{J}_{\mathcal{U}}}(X, Y[i])
$$

for every $i > 0$ and $X, Y \in \mathcal{Z}_{\mathcal{U}}$.

We denote by $\langle 1 \rangle$ the shift functor in \mathcal{J}_U induced by [1]. It is the case that any triangle $X \stackrel{\bar{f}}{\rightarrow} Y \stackrel{\bar{g}}{\rightarrow} Z \dashrightarrow X\langle 1 \rangle$ in $\mathcal{J}_{\mathcal{U}}$ is the image of a triangle in $\mathcal{Z}_{\mathcal{U}}/[\mathcal{U}]$, which is in turn isomorphic to triangles obtained from a commutative diagram of the form

$$
X \xrightarrow{f} Y \xrightarrow{g} Z \xrightarrow{---} X[1]
$$

\n
$$
\downarrow \qquad \qquad \downarrow \qquad \qquad \parallel
$$

\n
$$
X \xrightarrow{p_U} U_X \xrightarrow{g} X\langle 1 \rangle \xrightarrow{---} X[1],
$$

where p_U is a minimal left U-approximation of X. This fact says in particular that if $C \subset \mathcal{Z}_{\mathcal{U}}$ is thick in $\mathcal{Z}_{\mathcal{U}}$, this remains true for $\mathcal{C}/|U|$ in $\mathcal{Z}_{\mathcal{U}}/|U|$ and thus for $\rho(\mathcal{C}) \subset \rho(\mathcal{Z}_{\mathcal{U}}).$

The following lemma was originally shown by O. Iyama and D. Yang as a step towards proving Theorem [3.6.](#page-9-2) In their context, they establish that for any $X \in \mathcal{D}$ there exists $Y \in \mathcal{Z}_{\mathcal{U}}$ such that $X \simeq Y$ in $\mathcal{J}_{\mathcal{U}}$. In the following lemma, we adapt their arguments to show that if $\mathcal{D} = \mathcal{K}^b(\text{proj}\,\Lambda)$, and $X \in \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$, then Y can be chosen from $\mathcal{Z}_{\mathcal{U}} \cap \mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$.

Lemma 3.11. [\[IY18,](#page-24-10) Lemma 3.3] Let Λ be a finite-dimensional algebra and let U be a basic 2-term presilting object in $\mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$. For any $X \in \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$ there exists $Y \in \mathcal{Z}_{\mathcal{U}}^{[-1,0]} = \mathcal{Z}_{\mathcal{U}} \cap \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$ satisfying $X \simeq Y$ in $\mathcal{J}_{\mathcal{U}}$.

Proof. Let $\mathcal{U} = \text{add}(U)$, with U basic and presilting. First note that

$$
\mathcal{Z}_{\mathcal{U}} = \{ X \in \mathcal{D} \mid \operatorname{Hom}_{\mathcal{D}}(X, U[i]) = 0 = \operatorname{Hom}_{\mathcal{D}}(U[-i], X) \,\forall i > 0 \}.
$$

Since $\text{Hom}_{\mathcal{D}}(Y, Y[i]) = \text{Hom}_{\mathcal{D}}(Y[-i], Y) = 0$ for all $i \geq 2$ and all $Y \in \mathcal{K}^{[-1,0]}(\text{proj } \Lambda)$, then

$$
\mathcal{Z}_{\mathcal{U}}^{[-1,0]} = \{ X \in \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda) \mid \mathbb{E}(X,U) = 0 = \mathbb{E}(U,X) \}.
$$

Recall that $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda) = \Lambda * \Lambda[1]$ and that Λ and T_U are isomorphic in $\mathcal{J}_{\mathcal{U}}$ where T_U is the Bongartz completion of U into a silting complex in $\mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$, which by definition lies in $\mathcal{Z}_{\mathcal{U}}^{[-1,0]}$ $\mathcal{U}^{[-1,0]}$. We will show that we can find $H \in \mathcal{Z}_{\mathcal{U}}^{[-1,0]}$ such that $T_U[1] \simeq H$ in \mathcal{J}_U . Consider the conflation $\Lambda \rightarrow U' \twoheadrightarrow V \longrightarrow \Lambda[1]$ where the first morphism is a minimal right U -approximation of Λ , then by definition $V \in$ $\mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$ and $V \simeq \Lambda[1] \simeq T_U[1]$ in $\mathcal{J}_\mathcal{U}$. In fact, $V \simeq T_U^c$ inside $\mathcal{J}_\mathcal{U}$, where T_U^c is the Bongartz co-completion of U , that is, the basic silting complex satisfying that $add(T_U^c) = add(V \oplus U)$. Since $T_U^c \in \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$ and $\mathbb{E}(T_U^c, U) = 0 = \mathbb{E}(U, T_U^c)$, we have that $T_U^c \in \mathcal{Z}_{\mathcal{U}}^{[-1,0]}$ and that $T_U * T_U^c \subset \mathcal{Z}_{\mathcal{U}}^{[-1,0]}$. Since the functor $\bar{\rho}$ is a triangle equivalence, by Proposition [3.10](#page-10-0) we have that

$$
\mathcal{Z}_{\mathcal{U}}^{[-1,0]}/[\mathcal{U}] \supseteq (T_U * T_U^c)/[\mathcal{U}] \stackrel{\bar{\rho}}{\rightarrow} \rho(\Lambda) *_{\mathcal{J}} \rho(\Lambda) \langle 1 \rangle \simeq \rho(\Lambda * \Lambda[1]) = \subseteq \mathcal{J}_{\mathcal{U}}.
$$

In particular, for each $X \in \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$ there exists $X' \in T_U * T_U^c$ such that $\rho(X) \simeq \rho(X')$.). □

Remark 3.12. We note that the full extension-closed subcategory $\mathcal{Z}_{\mathcal{U}}^{[-1,0]}$ $\mathcal{U}^{[-1,0]}$ is precisely the subcategory considered by M. Gorsky, H. Nakaoka and Y. Palu in [\[GNP23,](#page-24-16) Definition 2.7] to define the reduction of an extriangulated category with respect to a presilting object.

Lemma 3.13. Let $U \in \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$ be a 2-term presilting complex and U its additive closure. Consider $\mathcal{Z}_{\mathcal{U}}$ and $\rho : \mathcal{D} \to \mathcal{D}/\text{thick}_{b}(\mathcal{U})$ as in Theorem [3.6.](#page-9-2) Let $\mathcal{H} \subset \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$ be a thick subcategory such that $U \in \mathcal{H}$. Then

$$
\frac{\mathcal{H}\cap \mathcal{Z}_{\mathcal{U}}}{[U]}\simeq \rho(\mathcal{H}).
$$

In particular, $\rho(\mathcal{H})$ is thick inside the extriangulated category

$$
\rho(\mathcal{K}^{[-1,0]}(\operatorname{proj}\Lambda)) \simeq \operatorname{per}^{[-1,0]}(C_U).
$$

Proof. The following argument follows closely the those in [\[IY18,](#page-24-10) Proposition 3.2, Lemma 3.3]. We are going to show that for every $X \in \mathcal{H}$ there exists and object $Z \in \mathcal{H} \cap \mathcal{Z}_{\mathcal{U}} \subset \mathcal{Z}_{\mathcal{U}}^{[-1,0]}$ such that $\rho(X) \simeq \rho(Z)$. Let $X \in \mathcal{H}$ and take $X \xrightarrow{f} U'[1]$ a minimal left $\mathcal{U}[1]$ -approximation of X and let $Y = \text{Cocone}(f)$. We then can construct a conflation

$$
U' \rightarrowtail Y \twoheadrightarrow X \xrightarrow{f} \star,
$$

which implies that $Y \in \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$ and $\text{Hom}(Y, U[n]) = 0$ for all $n \geq 2$. Moreover, applying the functor $\text{Hom}_{\mathcal{D}}(-, U[1])$ to the previous triangle we obtain an exact sequence

$$
\operatorname{Hom}_{\mathcal{D}}(U'[1], U[1]) \xrightarrow{\operatorname{Hom}_{\mathcal{D}}(-, f)} \operatorname{Hom}_{\mathcal{D}}(X, U[1]) \to \operatorname{Hom}_{\mathcal{D}}(Y, U[1]) \to \operatorname{Hom}_{\mathcal{D}}(U', U[1]).
$$

Given that $\text{Hom}_{\mathcal{D}}(U', U[1]) = 0$, since U is presilting and since $\text{Hom}_{\mathcal{D}}(-, f)$ is surjective because f is a left $\mathcal{U}[1]$ -approximation, we deduce that $\text{Hom}_{\mathcal{D}}(Y, U[1]) =$ 0, Now, consider $U''[-1] \stackrel{g}{\rightarrow} Y$ a minimal right $\mathcal{U}[-1]$ -approximation and let $Z =$ $Cone(g)$, then there exists a conflation

$$
Y \rightarrowtail Z \twoheadrightarrow U'' \stackrel{g[1]}{\dashrightarrow}.
$$

In particular, $Z \in \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$ and $Z \in U\leq -1]^{\perp}$. As before, by applying the functor Hom_D(U[−1], −), and using that g is a right $\mathcal{U}[-1]$ -approximation and U silting, we can deduce that $Z \in U[-1]^{\perp}$. But Z is an extension between two objects in [⊥]U[1], which implies that $Z \in \mathcal{U}$ [> 0] ∩ \mathcal{U} [< 0][⊥] = $\mathcal{Z}_{\mathcal{U}}$. Moreover, under the assumption that $U \in \mathcal{H}$, both previous conflations give that both Y and Z lie in H. We get that

$$
\rho(X) \simeq \rho(Y) \simeq \rho(Z),
$$

with $Z \in \mathcal{H} \cap \mathcal{Z}_{\mathcal{U}}$. Since $\mathcal{H} \cap \mathcal{Z}_{\mathcal{U}}$ is thick in $\mathcal{Z}_{\mathcal{U}}^{[-1,0]}$ $\mathcal{U}^{[-1,0]}$ by Proposition [3.2,](#page-7-4) we get that

$$
\rho(\mathcal{H}) \simeq \bar{\rho}(\mathcal{H} \cap \mathcal{Z}_{\mathcal{U}}) \subset \bar{\rho}(\mathcal{Z}_{\mathcal{U}}^{[-1,0]}) \simeq \rho(\mathcal{K}^{[-1,0]}(\operatorname{proj}\Lambda))
$$

is thick in $\rho(\mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)) \simeq \text{per}^{[-1,0]}(C_U)$.

4. THICK SUBCATEGORIES AND COTORSION PAIRS OF q -FINITE ALGEBRAS

In this section we assume that Λ is a *g*-finite algebra and study the maps between cotorsion pairs, thick subcategories and presilting objects in $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$ introduced in [\[Gar23\]](#page-24-8).

4.1. Bijection between cotorsion and torsion classes.

Definition 4.1. [\[PZ23,](#page-25-2) Definition 1.7] Let K be an extriangulated category with extension bifunctor E. We say that a pair of subcategories $(\mathcal{X}, \mathcal{Y})$ is a *cotorsion* pair if they are both full and additive and they satisfy

- (1) $\mathcal{Y} = \mathcal{X}^{\perp_1} = \{ Y \in \mathcal{K} \mid \mathbb{E}(X, Y) = 0 \ \forall \ X \in \mathcal{X} \}.$
- (2) $\mathcal{X} = {}^{\perp_1}\mathcal{Y} = \{X \in \mathcal{K} \mid \mathbb{E}(X, Y) = 0 \ \forall \ Y \in \mathcal{Y}\}.$

We say that $(\mathcal{X}, \mathcal{Y})$ is *complete* [\[NP19,](#page-25-6) Definition 4.1], if additionally

$$
\mathcal{K} = \text{Cone}(\mathcal{Y}, \mathcal{X}) = \text{Cocone}(\mathcal{Y}, \mathcal{X}).
$$

When $\mathcal{K} = \mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$, we will denote by cotor Λ the set of all cotorsion pairs in $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$ and by c-cotor Λ the subset of cotorsion pairs of $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$ which are complete.

In [\[PZ23\]](#page-25-2), D. Pauksztello and A. Zvonareva showed that the functor H^0 : $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda) \rightarrow \text{mod }\Lambda$ induces a map between the set of cotorsion pairs in $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$ and that of torsion classes in mod Λ , which we denote by tors Λ .

Theorem 4.2. [\[PZ23,](#page-25-2) Proposition 3.6 and Theorem 3.7] Let Λ be a finite-dimensional k-algebra. Then the functor $H^0 : \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda) \to \text{mod }\Lambda$ induces a well-defined map

$$
\psi : \operatorname{cotor} \Lambda \to \operatorname{tors} \Lambda
$$

$$
(\mathcal{X}, \mathcal{Y}) \mapsto H^0(\mathcal{Y}).
$$

Moreover, ψ induces a bijection between the sets of complete cotorsion pairs in $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$ and functorially finite torsion classes in mod Λ .

The following is an extension of Theorem [4.2.](#page-12-3)

Theorem 4.3. Let Λ be a finite-dimensional k-algebra. Then the functor H^0 : $\mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda) \to \Lambda$ induces a bijection

$$
\psi : \text{cotor } \Lambda \to \text{tors } \Lambda
$$

$$
(\mathcal{X}, \mathcal{Y}) \mapsto H^0(\mathcal{Y}).
$$

Proof. By Theorem [4.2,](#page-12-3) the only thing left to proof is that ψ is always a bijection whose inverse map is given by

$$
\mathcal{T}\mapsto \left(^{\bot _{1}}\mathcal{Y}_{\mathcal{T}},\mathcal{Y}_{\mathcal{T}}\right)
$$

where $\mathcal{Y}_{\mathcal{T}} = \{X \in \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda) \mid H^0(X) \in \mathcal{T}\}.$ It suffices to show that $({}^{\perp_1}\mathcal{Y}_\mathcal{T})^{\perp_1} = \mathcal{Y}_\mathcal{T}$. Remark that for any $X \in \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$, $X \simeq X_M \oplus Q[1]$, where X_M is the minimal projective presentation of $M = H^0(X)$ and $Q \in \text{proj}\,\Lambda$. By [\[Pla13,](#page-25-9) Lemma 2.6], for any $Y \in \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$ we have that $\mathbb{E}(X_M, Y) \simeq$ $D\operatorname{Hom}_{\Lambda}(H^{0}(Y), \tau M)$. We deduce that for any $X, Y \in \mathcal{K}^{[-1,0]}(\operatorname{proj}\Lambda)$,

$$
\mathbb{E}(X,Y) \simeq \mathbb{E}(X_M, Y) \oplus \mathbb{E}(Q[1], Y) \simeq D \operatorname{Hom}_{\Lambda}(H^0(Y), \tau M) \oplus \operatorname{Hom}_{[-1,0]}(Q, Y)
$$

$$
\simeq D \operatorname{Hom}_{\Lambda}(H^0(Y), \tau M) \oplus \operatorname{Hom}_{\Lambda}(Q, H^0(Y)).
$$

This implies that for any additive subcategory $\mathcal{H} \subset \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$, we have that

$$
\mathcal{H}^{\perp_1} = \{ X \in \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda) \mid \mathbb{E}(\mathcal{H}, X) = 0 \}
$$

= add $\left(\left\{ X_N \mid N \in {}^{\perp} \tau H^0(\mathcal{H}) \cap (\mathcal{H} \cap \text{add}(\Lambda[1]))[-1]^\perp \right\} \cup \text{add}(\Lambda[1]) \right)$

$$
{}^{\perp_1} \mathcal{H} = \{ X \in \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda) \mid \mathbb{E}(X, \mathcal{H}) = 0 \}
$$

= add $\left(\left\{ X_M \mid \tau M \in H^0(\mathcal{H})^\perp \right\} \cup \left(\text{add}(\Lambda) \cap {}^{\perp} H^0(\mathcal{H}) \right)[1] \right).$

Now let $\mathcal{T} \subset \text{mod } \Lambda$ be a torsion class and let $\mathcal{Y}_{\mathcal{T}} = \{X \in \mathcal{K}^{[-1,0]}(\text{proj }\Lambda) \mid H^0(X) \in$ T}. Since $\mathcal T$ is closed under direct summands and for every $X, Y \in \mathcal K^{[-1,0]}(\text{proj}\,\Lambda)$, $H^0(X \oplus Y) \simeq H^0(X) \oplus H^0(Y)$, we readily see that $\mathcal{Y}_{\mathcal{T}}$ is additive. This implies that

$$
{}^{\perp_1} \mathcal{Y}_{\mathcal{T}} = \mathrm{add}\left(\left\{ X_M \mid \tau M \in \mathcal{T}^{\perp} \right\} \cup \left(\mathrm{add}(\Lambda) \cap {}^{\perp} \mathcal{T} \right)[1] \right).
$$

Hence

$$
H^{0}({}^{\perp_1}\mathcal{Y}_{\mathcal{T}}) = \{ M \in \operatorname{mod} \Lambda \mid \tau M \in \mathcal{T}^{\perp} \} = \operatorname{add} \left(\tau^{-1}(\mathcal{T}^{\perp}) \cup \operatorname{add}(\Lambda) \right)
$$

and

$$
{}^{\perp_1} {\mathcal Y}_{\mathcal T} \cap \operatorname{add}(\Lambda[1]) = \left(\operatorname{add}(\Lambda) \cap {}^{\perp} {\mathcal T}\right)[1].
$$

Finally, we get that

$$
\begin{aligned}\n(^{\perp_1} \mathcal{Y}_{\mathcal{T}})^{\perp_1} &= \\
&= \operatorname{add}\left(\left\{ X_N \mid N \in {}^{\perp_{\tau}} \mathcal{H}^0({}^{\perp_1} \mathcal{Y}_{\mathcal{T}}) \cap \left({}^{\perp_1} \mathcal{Y}_{\mathcal{T}} \cap \operatorname{add}(\Lambda[1]) \right)[-1]^{\perp} \right\} \cup \operatorname{add}(\Lambda[1]) \right) \\
&= \operatorname{add}\left(\left\{ X_N \mid N \in {}^{\perp_{\tau}} (\tau^{-1}(\mathcal{T}^{\perp}) \cup \operatorname{add}(\Lambda)) \cap \left(\operatorname{add}(\Lambda) \cap {}^{\perp_{\tau}} \mathcal{T} \right)^{\perp} \right\} \cup \operatorname{add}(\Lambda[1]) \right)\n\end{aligned}
$$

The only thing left to prove is that

$$
^{\perp_{}}\tau_{\tau_{\tau_{\tau_{\tau}}}(\tau^{-1}(\mathcal{T}^{\perp})\cup \mathrm{add}(\Lambda))}\cap \left(\mathrm{add}(\Lambda)\cap {^{\perp_{}}\mathcal{T}}\right)^{\perp}=\mathcal{T}.
$$

Note that $\tau(\tau^{-1}(\mathcal{T}^{\perp}) \cup \mathrm{add}(\Lambda)) = \tau(\tau^{-1}(\mathcal{T}^{\perp}))$. Since $\tau(\tau^{-1}(\mathcal{T}^{\perp}))$ and $\mathcal{T}^{\perp} \setminus$ $(\mathcal{T}^{\perp} \cap \text{inj }\Lambda)$ have the same indecomposables, we get that

$$
^{\perp}_{\tau} \left(\tau^{-1}(\mathcal{T}^{\perp}) \cup \mathrm{add}(\Lambda) \right) = {^{\perp}_{\cdot}} (\mathcal{T}^{\perp} \setminus (\mathcal{T}^{\perp} \cap \mathrm{inj} \, \Lambda)).
$$

Given that $\mathcal T$ is a torsion class and hence $\mathcal T = {}^{\perp}(\mathcal T^{\perp})$, we have that

$$
\mathcal{T} \subset {}^{\perp}\left(\mathcal{T}^{\perp} \setminus (\mathcal{T}^{\perp} \cap \operatorname{inj}\Lambda)\right) \cap \left(\operatorname{add}(\Lambda) \cap {}^{\perp}\mathcal{T}\right)^{\perp}.
$$

For the other inclusion, let M in $\perp^{\perp}(\mathcal{T}^{\perp} \setminus (\mathcal{T}^{\perp} \cap \text{inj }\Lambda)) \cap (\text{add}(\Lambda) \cap \perp \mathcal{T})^{\perp}$. We want to prove that $M \in {}^{\perp}(\mathcal{T}^{\perp})$. Let L be an indecomposable in \mathcal{T}^{\perp} . If L is not injective, then $\text{Hom}_{\Lambda}(M, L) = 0$ by definition of M. Assume thus that $L = I_i$, where $I_i \in \mathcal{T}^{\perp} \cap \text{inj }\Lambda$ is the injective envelope of the simple S_i . Recall that for any $N \in \text{mod }\Lambda$, $\text{Hom}(N, I_i) = 0$ if and only if $\text{Hom}_{\Lambda}(P_i, N) = 0$, where P_i is the

projective cover of S_i . Thus $I_i \in \mathcal{T}^{\perp} \cap \text{inj}\,\Lambda$ if and only if $\text{Hom}_{\Lambda}(\mathcal{T}, I_i) = 0$ $\text{Hom}_{\Lambda}(P_i,\mathcal{T}),$ which is equivalent to $P_i \in \text{add}(\Lambda) \cap \perp \mathcal{T}$. But $M \in (\text{add}(\Lambda) \cap \perp \mathcal{T})$ as well, so we have that

$$
\operatorname{Hom}_{\Lambda}(P_i, M) = 0 = \operatorname{Hom}_{\Lambda}(M, I_i).
$$

We conclude that $M \in {}^{\perp}(\mathcal{T}^{\perp}) = \mathcal{T}$. In particular we get that

$$
({}^{\perp_1}\mathcal{Y}_\mathcal{T})^{\perp_1} = \mathrm{add}\left(\{X_N \mid N \in \mathcal{T} \mid \cup \mathrm{add}(\Lambda[1])\right) = \mathcal{Y}_\mathcal{T}
$$

which implies that $({}^{\perp_1} \mathcal{Y}_\mathcal{T}, \mathcal{Y}_\mathcal{T})$ is a cotorsion pair. \Box

Theorem [4.3](#page-12-2) induces a "mirror" of Theorem [1.2](#page-1-0) in the category of projective presentations:

Corollary 4.4. Let Λ be a finite-dimensional k-algebra. The following are equivalent:

- (1) Λ is q-finite.
- (2) There exist finitely many complete cotorsion pairs in $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$.
- (3) All cotorsion pairs in $\mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$ are complete.

Proof. The implications follow from Theorem [4.3,](#page-12-2) Theorem [4.2](#page-12-3) and Theorem [1.2.](#page-1-0) □

Example 4.5 (Kronecker Quiver). Consider Λ to be the path algebra the Kronecker quiver

$$
1 \xrightarrow{\alpha} 2.
$$

Recall that all torsion classes of Λ can be described as the additive closure of one of the following four types of subsets of indecomposable modules :

- (1) Any final part of the preinjective component of the Auslander-Reiten quiver of mod Λ .
- (2) All preinjectives and a subset of the tubes of the Auslander-Reiten quiver of mod Λ .
- (3) All preinjectives, all tubes and a final part of the postprojective component of the Auslander-Reiten quiver of mod Λ
- (4) The module P_1 whose dimension vector is $(1, 0)$.

FIGURE 1. Example of a non-complete cotorsion pair $(\mathcal{X}, \mathcal{Y})$ in $\mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$ when Λ is the Kronecker algebra. Here λ and λ' lie in two disjoint parts of $\mathbb{P}(\mathbb{k})$. The object at the base of the tube corresponding to the point at infinity is $P_1 \xrightarrow{\alpha} P_2$.

From these torsion classes, all are functorially finite with the exception of those of type (2). As a result of Theorem [4.3,](#page-12-2) we can explicitly describe all cotorsion pairs of $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$. All complete ones are easily described by the results of T. Adachi and M. Tsukamoto in [\[AT22\]](#page-24-23), who showed that any complete cotorsion

pair $(\mathcal{X}, \mathcal{Y})$ in $\mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$ satisfies that $\mathcal{X} = \text{Cocone}(\text{add}(U), \text{add}(U))$ and $\mathcal{Y} =$ Cone(add(U), add(U)) for a certain two-term silting object $U \in \mathcal{K}^{[-1,0]}$ (proj Λ) satisfying $\mathcal{X} \cap \mathcal{Y} = \text{add}(U)$. A non-complete cotorsion pair $(\mathcal{X}, \mathcal{Y})$ is presented in Figure [1.](#page-14-0) Note that in this case $\mathcal{X} \cap \mathcal{Y}$ is always trivial.

4.2. All thick subcategories have enough injectives and projectives. Let $Λ$ be a finite-dimensional k-algebra. A *wide subcategory* of mod $Λ$ is a full additive subcategory of mod Λ that is closed under extensions, kernels and cokernels. We say that a wide subcategory is left finite, if the smallest torsion class containing it is functorially finite. Left finite wide subcategories were defined by F. Marks and J. Stoviček in $[M\ddot{S}17]$, where it was shown that they are in bijection with functorially finite torsion classes. Given that the definition of a left finite wide subcategory is given by a condition on its associated torsion class, the following results follows immediately from Theorem [1.2.](#page-1-0)

Corollary 4.6. [\[DIJ19,](#page-24-6) MŠ17] If Λ is a g-finite finite-dimensional k-algebra, then all wide subcategories are left finite.

In [\[Gar23\]](#page-24-8), new maps between cotorsion pairs, thick subcategories and silting complexes in $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$ were introduced. These maps mirror the maps between torsion classes, wide subcategories and support τ -tilting pairs of mod Λ introduced in $[AIR14]$, $[IT09]$ and $[MS17]$; and restrict to bijections for certain subsets of these sets of objects. We denote by thick Λ the set of thick subcategories of $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$ and by inj-thick Λ the set of those thick subcategories that have enough injectives with respect to the extriangulated structure inherited of $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$.

Theorem 4.7. [\[Gar23,](#page-24-8) Theorem 3.1] Let Λ be a finite-dimensional k-algebra. There exists a well defined map

$$
\operatorname{cotor} \Lambda \stackrel{\beta}{\longrightarrow} \operatorname{thick} \Lambda
$$

given by

 $\beta(\mathcal{X}, \mathcal{Y}) = \{ X \in \mathcal{X} \mid \forall \text{ configuration } X \rightarrowtail X' \rightarrowtail X'' \text{ such that } X' \in \mathcal{X}, \text{ then } X'' \in \mathcal{X} \}.$ for any $(X, Y) \in \text{cotor } \Lambda$. Moreover, β induces a bijection between the set of complete cotorsion pairs and that of thick subcategories with enough injectives.

Theorem 4.8. [\[Gar23,](#page-24-8) Theorem 3.15] Let Λ be a finite-dimensional k-algebra. There exists a well defined map

$$
\text{thick }\Lambda \stackrel{\mathscr{W}}{\longrightarrow} \text{wide }\Lambda
$$

such that, when restricted to thick subcategories with enough injectives and left finite wide subcategories, it fits in the following commutative diagram

In particular, W and the map taking any $U \in 2$ -silt Λ to the thick category thick $(U_0) \in$ inj-thick Λ are bijective. Here, U_{ρ} is the basic direct summand of U satisfying $add(U_{\rho}) = add(U')$, where U' is such that $U' \to \Lambda[1]$ is a minimal right $add(U)$ approximation of $\Lambda[1]$.

Corollary 4.9. [\[Gar23,](#page-24-8) Corollary 1.1] There are explicit bijections between:

- (i) Isomorphism classes of basic silting objects in $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$.
- (ii) Complete cotorsion pairs in $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$.

(iii) Thick subcategories in $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$ with enough injectives.

These bijections fit in the following commutative diagram:

Unlike being a left finite wide subcategory, having enough injectives is a characteristic of thick subcategories that is inherent to them. In this section, we establish an equivalence between being g-finite and having finitely many thick subcategories. Furthermore, we will show that if Λ is g-finite, then every thick subcategory in $\mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$ is generated by a 2-term presilting complex, and that we can choose it to be injective in the thick subcategory it generates.

First, we will need to show that if Λ is a *g*-finite algebra, then all non-trivial thick subcategories in $\mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$ contain a non-zero presilting complex. For any $X \in \mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$, we denote by [X] the class of X in the Grothendieck group $K_0(\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)).$

Proposition 4.10. Let Λ be a finite-dimensional k-algebra. Suppose that Λ is gfinite and let $\mathcal{H} \subset \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$ be a full additive subcategory that is closed under extensions. If $X \in \mathcal{H}$, then \mathcal{H} contains a presilting object $0 \neq U$ such that $[X] = [U]$ or H contains a non-zero $P \in \text{proj}\,\Lambda$ and its shift $P[1]$.

To establish [4.10,](#page-16-0) we will employ an algebraic-geometric result concerning the varieties of bounded complexes of projective modules over a finite-dimensional algebra. Let $p < q \in \mathbb{Z}$ and consider $\mathcal{C}^{[p,q]}(\text{proj}\,\Lambda) \subset \mathcal{C}^b(\text{proj}\,\Lambda)$ the category of complexes of projective Λ -modules concentrated in degrees in the interval $[p, q]$. Fix a set of representatives $\{P_i\}_{0\leq i\leq n}$ of the isoclasses of indecomposable projective Λ-modules, then for any choice of $\bar{l} = (l_p, \dots, l_{p+j}, \dots, l_q) \in (\mathbb{Z}_{\geq 0}^n)^{q-p+1}$ where $l_j = (l_{j,1}, l_{j,2}, \dots, l_{j,n})$, we define $R_{\bar{l}}$ to be the closed subvariety

$$
R_{\bar{l}} \subset \prod_{j=0}^{q-p-1} \text{Hom}_{\Lambda} \left(\bigoplus_{i=1}^{n} P_{i}^{\oplus l_{p+j,i}}, \bigoplus_{i=1}^{n} P_{i}^{\oplus l_{p+j+1,i}} \right)
$$

defined by the relation $f_{p+i+1} \circ f_{p+i} = 0$ for all $0 \le i \le p - q - 2$. In other words, $R_{\bar{l}}$ parametrizes all complexes in $\mathcal{C}^{[p,q]}$ (proj Λ) with $\bigoplus_{i=1}^n P_i^{\oplus l_{p+j,i}}$ in position $p+j$. The variety $R_{\bar{l}}$ is equipped with a group action of

$$
G_{\bar{l}} = \prod_{j=0}^{q-p} \mathrm{Aut}_{\Lambda} \left(\bigoplus_{i=1}^{n} P_{i}^{\oplus l_{p+j,i}} \right)
$$

given by

$$
(g_{p+j})_{0\leq j\leq p-q} \cdot (f_{p+i})_{0\leq i\leq p-q-1} = (g_{p+i+1}f_{p+i}g_{p+i}^{-1})_{0\leq i\leq p-q-1}.
$$

Theorem 4.11. [\[JSZ05,](#page-24-9) Theorem 2] Let Λ be a finite-dimensional k-algebra and suppose that that $\mathbb{k} = \overline{\mathbb{k}}$. Let $\overline{l} = (l_p, \dots, l_{p+j}, \dots, l_q) \in (\mathbb{Z}_{\geq 0}^n)^{q-p+1}$ for some $p < q \in \mathbb{Z}$. Let $N, M \in R_{\bar{l}}$ such that $N \in \overline{G_{\bar{l}} \cdot M}$. Then there exists $m \in \mathbb{N}$ and exact sequences in \mathcal{C}^b (proj Λ)

$$
0 \to N_0 \to N_{i+1} \to N_i \to 0
$$

for any $0 \leq i \leq m-1$ such that $N_0 = N$ and $N_m \simeq M \oplus N'$ for some $N' \in$ $\mathcal{C}^{[p,q]}(\operatorname{proj}\Lambda).$

We will also make use of the following known result, which follows from [\[DIJ19\]](#page-24-6).

Proposition 4.12. [\[DIJ19\]](#page-24-6) Suppose that Λ is g-finite. Then for any $\theta \in K_0(\mathcal{K}^{[-1,0]}(\text{proj } \Lambda))$ there exists a presilting object $X \in \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$ such that $[X] = \theta$.

Theorem 4.13. [\[DIJ19,](#page-24-6) Theorem 6.5] Let Λ be a finite-dimensional algebra and let U and V be 2-term presilting complexes in $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$. Then $|U| = |V|$ if and only if $U \simeq V$.

Proof of Proposition [4.10.](#page-16-0) Note that if $\mathcal{H} = \{0\}$ then the propositions follows immediately. Suppose then that there is $0 \neq X \in \mathcal{H}$.

Case $[X] = 0$: If $[X] = 0$, given that the only 2-term presilting complex with zero g -vector is $\overline{0}$, we have to show that there exists a non-zero projective module P such that $\begin{array}{c} P \\ \downarrow \in \mathcal{H} \end{array}$. Since $[X] = 0$, there exists $P \in \text{proj}\,\Lambda$ such that $X \simeq \begin{array}{c} P \\ \downarrow f \end{array}$. 0 P

If f is not radical, then X is isomorphic to some $P' \oplus P''$ $P'\oplus\check{P}$ $\begin{pmatrix} f' & 0 \\ 0 & a \end{pmatrix}$ with a invertible.

Since H is additive we can assume that $\frac{P}{P}$ ′ P ′ $f \in \mathcal{H}$. Thus we can suppose that f is radical and hence there exists $m \geq 1$ such that $f^m = 0$. Consider the morphism $\delta \in \text{Hom}(X, X[1])$ given by the commutative diagram

Since f is radical, then $\delta \neq 0$ and its mapping cone $P \oplus P$ $P \oplus P$ $\begin{pmatrix} -f & 0 \\ 1_P & f \end{pmatrix}$ is isomorphic to the complex in the rightmost column of the following diagram

$$
P \oplus P \xrightarrow{\begin{pmatrix} 1_P & f \\ 0 & 1_P \end{pmatrix}} P \oplus P
$$

$$
\begin{pmatrix} -f & 0 \\ 1_P & f \end{pmatrix} \downarrow \begin{pmatrix} 0 & f^2 \\ 0 & 0 \end{pmatrix} \downarrow \qquad P \oplus P
$$

$$
P \oplus P \xrightarrow{\simeq} P \oplus P.
$$

This implies that $X^{(1)} = \text{Cone}(\delta)[-1] \simeq \frac{P}{\delta}$ since it is an self-extension of X . By repeating this argument we can construct $f²$ belongs to the thick subcategory \mathcal{H} objects $X^{(i)} \simeq \frac{F}{\Box}$ P f^{2i} for every $i \geq 1$. By choosing i such that $2i \geq m$ we conclude that $P \oplus P[1] \simeq \bigcap_{n=1}^{n} P$ P $_{0=f^{2i}}$ is in H, and since H is closed under direct summands, then both P and $P[1]$ are in \mathcal{H} . Case $[X] \neq 0$: First suppose that $\mathbb{k} = \overline{\mathbb{k}}$. Let $X \in \mathcal{H}$ such that $[X] \neq 0$, then $X = \begin{bmatrix} X^{-1} \\ f, \end{bmatrix}$, where $[X^{-1}] \neq [X^0]$. Recall that we can decompose the g-vector of X as X^0 $[X] = \overline{\theta_X^+} - \theta_X^-$, where $\theta_X^+ = (\max\{0, \theta_{X,i}\})_{1 \leq i \leq n}$ and $\theta_X^- = (\max\{0, -\theta_{X,i}\})_{1 \leq i \leq n}$. By Proposition [4.12](#page-17-0) there exist a 2-term presilting complex U whose g-vector is [X]. Take u the point in $\text{Hom}(P^{\theta_X}, P^{\theta_X^+})$ corresponding to U, which has an open dense orbit (see for instance [\[Pla13,](#page-25-9) Lemma 2.16]). Choose $Q \in \text{proj}\,\Lambda$ such that $P^{\theta_X^-} \oplus Q = X^{-1}$ and $P^{\theta_X^+} \oplus Q = X^0$, then $u \oplus 1_Q$ still has an open dense orbit in Hom (X^{-1}, X^0) . Hence $\overline{G \cdot u \oplus 1_Q} = \text{Hom}(X^{-1}, X^0)$, and $X \in G \cdot U \oplus$ \it{Q} \it{Q} . From \it{Q}

Theorem [4.11](#page-17-1) we deduce that $U \oplus$ \it{Q} can be constructed as a direct summand of a

sequence of self-extensions of X in $\mathcal{C}^{[-1,0]}(\text{proj}\,\Lambda)$. In particular, U is contained in \mathcal{H} and $[U] = [X]$. This proves the result over an algebraically closed field.

Now let k be any field and let $\mathbb{K} = \bar{k}$. We have a fully faithful functor $\mathcal{C}^b(\text{proj}\,\Lambda)\otimes_{\Bbbk}$ $\mathbb{K} \hookrightarrow \mathcal{C}^b$ (proj $\Lambda \otimes_{\mathbb{K}} \mathbb{K}$) induced by $-\otimes_{\mathbb{K}} \mathbb{K}$. Let $X \in \mathcal{H}$ be as before and consider $\bar{X} = X \otimes_{\Bbbk} \bar{\Bbbk} \in \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda \otimes_{\Bbbk} \bar{\Bbbk})$. By the previous argument we can find a 2-term presilting complex $\bar{U} \in \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda\otimes_{\Bbbk} \mathbb{K})$ that is a direct summand of an object obtained by a sequence of self-extensions of \overline{X} . Explicitly, there are exact

sequences in $\mathcal{C}^{[-1,0]}(\text{proj}\,\Lambda\otimes_{\Bbbk}\mathbb{K})$

(4.1)
\n
$$
\begin{array}{ccc}\n & 0 \longrightarrow \bar{X}_0^{-1} \longrightarrow \bar{X}_{i+1}^{-1} \longrightarrow \bar{X}_i^{-1} \longrightarrow 0 \\
 & \downarrow \bar{f}_0 & \downarrow \bar{f}_{i+1} & \downarrow \bar{f}_i \\
 & 0 \longrightarrow \bar{X}_0^0 \longrightarrow \bar{X}_{i+1}^0 \longrightarrow \bar{X}_i^0 \longrightarrow 0\n\end{array}

for $0 \leq i \leq m-1$ where $\bar{X} =$ $X^{-1}\otimes_{\Bbbk}\mathbb{K}$ $X^0\otimes_{\Bbbk} \mathbb{K}$ $f \otimes_\Bbbk \mathbb{K}$ = \bar{X}_0^{-1} \bar{X}_0^0 \bar{f}_0 and such that \bar{U} is a direct

summand of $\bar{X}_m =$ \bar{X}_m^{-1} \bar{X}_m^0 \overline{f}_m . In particular, for $i = 0$ we get

(4.2) 0 X¯ [−]¹ ⁰ ^X¯ [−]¹ ¹ ^X¯ [−]¹ 0 0 . 0 X¯ ⁰ ⁰ ^X¯ ⁰ ¹ ^X¯ ⁰ ⁰ 0 . f¯⁰ f¯¹ f¯⁰

By definition, both lines in the commutative diagram [4.2](#page-19-0) are short exact sequences. Since $\bar{X}_0^{-1} = X_0^{-1} \otimes_{\Bbbk} \mathbb{K}$ and $\bar{X}_0^0 = X_0^0 \otimes_{\Bbbk} \mathbb{K}$ are projective modules in proj $\Lambda \otimes_{\Bbbk} \mathbb{K}$, both exact sequences split. In particular

$$
\bar{X}_1^{-1} \simeq (X_0^{-1} \otimes_{\mathbb{k}} \mathbb{K}) \oplus (X_0^{-1} \otimes_{\mathbb{k}} \mathbb{K}) \simeq (X_0^{-1} \oplus X_0^{-1}) \otimes_{\mathbb{k}} \mathbb{K}
$$

$$
\bar{X}_1^0 \simeq (X_0^0 \otimes_{\mathbb{k}} \mathbb{K}) \oplus (X_0^0 \otimes_{\mathbb{k}} \mathbb{K}) \simeq (X_0^0 \oplus X_0^0) \otimes_{\mathbb{k}} \mathbb{K}
$$

and thus

$$
\bar{f}_1 \in \text{Hom}_{\Lambda \otimes_{\mathbb{k}} \mathbb{K}} \left(\left(X_0^{-1} \oplus X_0^{-1} \right) \otimes_{\mathbb{k}} \mathbb{K}, \left(X_0^0 \oplus X_0^0 \right) \otimes_{\mathbb{k}} \mathbb{K} \right) \\ \simeq \text{Hom}_{\Lambda} \left(X_0^{-1} \oplus X_0^{-1}, X_0^0 \oplus X_0^0 \right) \otimes_{\mathbb{k}} \mathbb{K}.
$$

We deduce that the exact sequence of complexes [4.2](#page-19-0) is induced by an exact sequence of complexes in $\mathcal{C}^{[-1,0]}(\text{proj}\,\Lambda)$ under the functor $-\otimes_{\Bbbk} \mathbb{K}$. By applying the same argument for every $0 \le i \le m-1$ and its respective exact sequence [4.1,](#page-19-1) we deduce that all self-extensions of $\overline{X} = X \otimes_{\mathbb{k}} \mathbb{K}$ lie in \mathcal{C}^b (proj Λ) $\otimes_{\mathbb{k}} \mathbb{K}$. In particular, there exists $U \in \mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$ which is a direct summand of a sequence of self-extensions of X such that $\bar{U} \simeq U \otimes_{\Bbbk} \mathbb{K}$. Moreover, U is presilting if and only if \bar{U} is (see for instance [\[DIJ19,](#page-24-6) Proposition 6.6 b)]), and $[X] = [\overline{X}] = [\overline{U}] = [U]$, which finishes the proof. \Box

Theorem 4.14. Let Λ be a g-finite, finite-dimensional k-algebra. Let $\mathcal H$ be any thick subcategory of $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$, then there exists a presilting complex $U \in$ $\mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$ such that $\mathcal{H} = \text{thick}_{[-1,0]}(U)$.

Proof. Let Λ be any g-finite finite-dimensional k-algebra and let $\mathcal H$ be a thick subcategory of $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$. If $\mathcal{H} = \{0\}$ then we are done. If not, take $0 \neq X \in$ H. By Proposition [4.10](#page-16-0) there exists a presilting $0 \neq U$ in H and we let thick_b(U) be the thick subcategory of \mathcal{K}^b (proj Λ) generated by U. By Lemma [3.3](#page-7-2) we know that thick_[-1,0] $(U) = \text{thick}_b(U) \cap \mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$. Consider $\mathcal{J}_U = \mathcal{K}^b(\text{proj }\Lambda) / \text{thick}_b(U)$ and $\rho : \mathcal{K}^b(\text{proj}\,\Lambda) \to \mathcal{J}_U$ as in Theorem [3.6.](#page-9-2) By Lemma [3.13,](#page-11-0) we know that $\mathcal{H}' = \rho(\mathcal{H})$ is a thick subcategory of $\rho(\mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)) \simeq \text{per}^{[-1,0]}(C_U)$.

Now consider the functor

$$
p_* : \text{per}^{[-1,0]}(C_U) \to \mathcal{K}^{[-1,0]}(\text{proj } H^0(C_U))
$$

induced by the canonical projection $p: C_U \to H^0(C_U)$ as in Proposition [2.11.](#page-6-0) This functor induces an equivalence $p_* : \text{per}^{[-.1,0]}(C_U)/\mathcal{I} \to \mathcal{K}^{[-1,0]}(\text{proj } H^0(C_U))$ where If is the ideal of morphisms that factor trough a morphism $X[1] \to Y$ for $X, Y \in$ add(C_U). By Corollary [2.13,](#page-6-2) $p_*(\mathcal{H}')$ is closed under extensions and direct summands. Moreover, if $\mathcal{H}' \neq \{0\}$ then $p_*(\mathcal{H}') \neq \{0\}$ since p_* preserves isomorphism classes. As recalled in Remark [3.9,](#page-9-3) $mod(H^0(C_U))$ is equivalent to the τ -tilting reduction of mod Λ associated to U, in particular $H^0(C_U)$ is g-finite by [\[Jas15,](#page-24-21) Theorem 3.16]. By applying [4.10](#page-16-0) to the category $p_*(\mathcal{H}') \subset \mathcal{K}^{[-1,0]}(\text{proj } H^0(C_U)),$ we can find a 2-term presilting object $0 \neq V' \in p_*(\mathcal{H}')$, and thus there exists $V \in \mathcal{H}'$ such that $V' = p_*(V)$ which is itself presilting by Proposition [2.14.](#page-6-3) Moreover, $V \in \rho(\mathcal{H}) \simeq \bar{\rho}(\mathcal{H} \cap \mathcal{Z}_{\mathcal{U}})$, thus by Theorem [3.7](#page-9-4) we know that $V = W \oplus U \in$ $\mathcal{H} \cap \mathcal{Z}_U \subset \mathcal{H}$, where $W \neq 0$ since we supposed V' and thus V to be non zero in \mathcal{J}_U . By substituting U by V in the previous argument, we can find a sequence of 2-term presilting complexes $(V_i)_{i\in\mathbb{N}}$ such that $\text{add}(V_i) \subsetneq \text{add}(V_{i+1})$. Since the number of indecomposables of a presilting 2-term complex is bounded by $|\Lambda|$, the sequence must stabilize, that is for $i \gg 0$

$$
add(V_i) = add(V_{i+1}) = add(\bar{U}),
$$

where $\bar{U} \in \mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$ is a basic presilting complex. Then $\mathcal{H} = \text{thick}_{[-1,0]}(\bar{U}),$ which gives the result.

Corollary 4.15. Let Λ be a finite-dimensional algebra, then Λ is g-finite if and only if there exist finitely many thick subcategories in $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$.

Proof. Suppose Λ is q-finite. By Theorem [4.14,](#page-19-2) any thick subcategory is generated by a presilting complex $U \in \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$, and since there are finitely many isomorphism classes of such U , then there exist finitely many thick subcategories. Conversely, if there are finitely many thick subcategories, then there are also finitely many of them with enough injectives. Given that Corollary [4.9](#page-16-1) establishes a bijection between isomorphism classes 2-term silting complexes and thick subcategories with enough injectives, we conclude that Λ is *q*-finite. \Box

Example 4.16. Consider Λ to be the path algebra the Kronecker quiver

$$
Q = 1 \xrightarrow{\alpha} 2.
$$

Theorem [4.14](#page-19-2) provides yet another illustration of the fact that Λ is *g*-infinite. Indeed, the tubes in $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$ provide a family of thick subcategories which do not contain a non-zero presilting object and that have no non-zero object whose q-vector coincides with that of a presilting object of $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$.

Before moving on to prove Theorem [4.22,](#page-23-0) we first recall the definition of the map $\mathscr W$ introduced in Proposition [4.10.](#page-16-0)

Definition 4.17. Let $\mathcal{C} \subset \text{mod }\Lambda$ and $\mathcal{H} \subset \mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$ be subcategories of mod Λ and $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$ respectively. We define $\mathcal{I}(\mathcal{C})$ to be the full subcategory

of $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$ whose objects are all complexes $X = \frac{X^{-1}}{|x|}$ X^0 x such that the k-linear map

$$
Hom_{\Lambda}(x, M) : Hom_{\Lambda}(X^{0}, M) \to Hom_{\Lambda}(X^{-1}, M)
$$

is an isomorphism. Similarly, we define $\mathscr{W}(\mathcal{H})$ as the full subcategory of modules M such that $\text{Hom}_{\Lambda}(x, M)$ is an isomorphism for all complexes $X =$ X^{-1} X^0 $_x \in \mathcal{H}.$

Proposition 4.18. Let $C \subset \text{mod }\Lambda$ and $\mathcal{H} \subset \mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$ be subcategories, then

$$
\mathscr{W}(\mathcal{H})=\mathcal{H}^{\perp_{\mathbb{Z}}}\cap\mathrm{mod}\,\Lambda
$$

$$
\mathscr{T}(\mathcal{C})=^{\perp_{\mathbb{Z}}}\mathcal{C}\cap\mathcal{K}^{[-1,0]}(\mathrm{proj}\,\Lambda)
$$

where

$$
\mathcal{H}^{\perp_{\mathbb{Z}}} = \{ Y \in \mathcal{D} \mid \text{Hom}_{\mathcal{D}}(\mathcal{H}, Y[i]) = 0 \ \forall \ i \in \mathbb{Z} \}
$$

$$
^{\perp_{\mathbb{Z}}} \mathcal{C} = \{ Y \in \mathcal{D} \mid \text{Hom}_{\mathcal{D}}(Y[i], \mathcal{C}) = 0 \ \forall \ i \in \mathbb{Z} \}
$$

and $\mathcal{D} = \mathcal{D}^b(\text{mod }\Lambda).$

Proof. Let $M \in \text{mod }\Lambda$ and $X = \bigcup_{\downarrow f}^{X-1} \in \mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$. Then $M \in \mathscr{W}(X)$ (or equivalently $X \in \mathcal{T}(M)$ if and only if the k-linear map

$$
\operatorname{Hom}\nolimits_{\Lambda}(X^0, M) \xrightarrow{\operatorname{Hom}\nolimits_{\Lambda}(f, M)} \operatorname{Hom}\nolimits_{\Lambda}(X^{-1}, M)
$$

is an isomorphism. By definition, $X \in {}^{\perp}M[i]$ (or equivalently $M \in X[-i]^{\perp}$) for any $i \neq 0, 1$, so the only thing left to prove is the case when $i = 0$ or 1. Consider the triangle

$$
X[-1] \dashrightarrow X^{-1} \xrightarrow{f} X^0 \to X.
$$

Then by applying $\text{Hom}_{\mathcal{D}}(-, M)$ we get an exact sequence

$$
\text{Hom}_{\mathcal{D}}(X, M) \longrightarrow \text{Hom}_{\mathcal{D}}(X^0, M) \xrightarrow{\text{Hom}_{\mathcal{D}}(f, M)} \text{Hom}_{\mathcal{D}}(X^{-1}, M) \longrightarrow \text{Hom}_{\mathcal{D}}(X[-1], M)
$$

\text{Hom}_{\Lambda}(X^0, M) \xrightarrow{\text{Hom}_{\Lambda}(f, M)} \text{Hom}_{\Lambda}(X^{-1}, M)

This implies that $\text{Hom}_{\Lambda}(f, M)$ is an isomorphism if and only if $\text{Hom}_{\mathcal{D}}(X[-1], M) \simeq$ $0 \simeq \text{Hom}_{\mathcal{D}}(X, M)$, which is equivalent to $M \in X^{\perp_{\mathbb{Z}}}$ (and $X \in {}^{\perp_{\mathbb{Z}}}M$).

Remark 4.19. The wide subcategories $\mathcal{W}(H)$ were already considered in work of L. Angeleri Hügel, F. Marks and J. Vitória [\[AHMV16a,](#page-24-24) [AHMV16b\]](#page-24-25). In their work, they are defined with respect to a morphism between two (not necessarily finitedimensional) projective Λ -modules, and are key to their generalization of large tilting modules and support τ -tilting modules.

Lemma 4.20. Let Γ be a non-positive dg algebra over k such that $H^0(\Gamma)$ is finitedimensional. Let S be a simple module in the heart of the standard t-structure $\{X \in \mathcal{D}(\Gamma) \mid H^i(X) = 0 \text{ for } i \neq 0\} \subset \mathcal{D}(\Gamma)$. Then $X \in \text{per}(\Gamma)$ belongs to $\perp z S$ if and only if $X \in \operatorname{thick}_{\operatorname{per}\Gamma}(\operatorname{add}(\Gamma) \setminus \operatorname{add}(P))$ where P is the direct summand of Γ satisfying that $\text{Hom}_{\mathcal{D}(\Gamma)}(P, S[i])$ is a division algebra if $i = 0$ and is 0 otherwise.

Proof. We are going to prove that if $X \in {}^{\perp_{\mathbb{Z}}}\mathbb{S} \cap \text{per }\Gamma$ then $X \in \text{thick}_{\text{per }\Gamma}(\text{add}(\Gamma) \setminus \Gamma)$ add(P)). The other direction is straightforward. Let $X \in \text{per } \Gamma$, then by [\[Pla11,](#page-25-10) Lemma 2.14] X is quasi-isomorphic to a *twisted complex* in $\mathcal{D}(\Gamma)$, that is, its underlying graded module is of the form

$$
\bigoplus_{i=1}^l Q_i
$$

where $Q_i \in \text{add}(\Gamma)[n_i]$ for some $n_i \in \mathbb{Z}$ and its differential is given by

$$
\begin{pmatrix} d_1 & f_{12} & \cdots & f_{1l} \\ 0 & d_2 & \cdots & f_{2l} \\ \vdots & \vdots & \ddots & \vdots \\ 0 & 0 & \cdots & d_l \end{pmatrix}
$$

where d_i is the differential corresponding to Q_i . Recall that for any $Q \in \text{add}(\Gamma)[n],$ then $\text{Hom}(Q, S[i]) = 0$ if and only if $Q \notin \text{add}(P)$ or $i \neq n$. Since $\text{Hom}(X, S[i]) = 0$ for all $i \in \mathbb{Z}$, we conclude that none of the Q_l are shifts of P. In particular, $X \in \operatorname{thick}_{\operatorname{per}\Gamma}(\operatorname{add}(\Gamma) \setminus \operatorname{add}(P)).$

Proposition 4.21. Let

$$
\mathscr{W}: \text{thick }\Lambda \to \text{wide }\Lambda
$$

$$
\mathscr{T}: \text{wide }\Lambda \to \text{thick }\Lambda
$$

be the maps defined in Proposition [4.18.](#page-21-0) Then $\mathscr W$ and $\mathscr T$ induce mutually inverse bijections between the set of left finite wide subcategories in $mod \Lambda$ and thick subcategories with enough injectives in $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$.

Proof. Let $\mathcal{H} = \text{thick}_{[-1,0]}(U)$ where U a basic injective generator of \mathcal{H} . Then by Proposition [4.18](#page-21-0) we know that $\mathscr{W}(\mathcal{H}) = \mathscr{W}(U) = U^{\perp_{\mathbb{Z}}} \cap \text{mod }\Lambda$. By Theorem [4.8,](#page-15-1) we know that $\mathscr{W}(\mathcal{H}) = \mathcal{W}_{(M,P)}$ where (M, P) is the support τ -tilting pair associated to the presilting complex U. The only thing we need to prove is that $\mathscr{T}(W_{(M,P)}) \subset$ thick_[-1,0](U), since the other inclusion is always satisfied.

Recall that since U is a 2-term presilting complex, it can be completed into a 2-term silting complex. Let T_U the Bongartz completion of U. Since U is injective in $\mathcal{H} = \text{thick}_{[-1,0]}(U)$, then $T_U = U \oplus V$ where V is the Bongartz complement of U satisfying that $add(V) \cap add(U)$ [\[Gar23,](#page-24-8) Lemma 3.11]. Let $S \subset \mathcal{D}^{[-1,0]}(\text{mod }\Lambda)$ be the simple-minded collection associated to T_U , then $S = S_U \sqcup S_V$ where $S_U =$ $U^{\perp_{\mathbb{Z}}}\cap\mathcal{S}$ and $\mathcal{S}_V=V^{\perp_{\mathbb{Z}}}\cap\mathcal{S}$. By [\[Asa20,](#page-24-26) Theorem 2.3], we know that $\mathcal{S}_U\subset \text{mod }\Lambda$ and that $\mathscr{W}(U) = \mathcal{W}_{(M,P)} = \text{Filt}(\mathcal{S}_U)$. Thus $\mathscr{T}(\mathscr{W}(\mathcal{H})) = {}^{\perp_{\mathbb{Z}}} \mathcal{S}_U \cap \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$. Recall that there exists a non-positive dg algebra Γ_U and triangulated equivalences

$$
\mathcal{D}_{fd}(\Gamma_U) \xrightarrow[\overline{\phi}]{\simeq} \mathcal{D}^b(\text{mod }\Lambda)
$$

$$
\uparrow \qquad \qquad \uparrow
$$

$$
\text{per}(\Gamma_U) \xrightarrow[\overline{\phi}]{\simeq} \mathcal{K}^b(\text{proj }\Lambda)
$$

which take Γ_U to T_U and all simple $H^0(\Gamma_U)$ -modules to the simple-minded collection S (Theorem [2.8\)](#page-4-2). Let $\bar{U} \in \text{add}(\Gamma_U)$ be the perfect complex sent to U and $\overline{\mathcal{S}_U}$ the

set of simple $H^0(\Gamma_U)$ -modules that are perpendicular to \overline{U} . Then $\phi(\overline{\mathcal{S}_U}) = \mathcal{S}_U$ and thus

$$
\mathscr{T}(\mathscr{W}(\mathcal{H})) = {}^{\perp_{\mathbb{Z}}}S_{U} \cap \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)
$$

= ${}^{\perp_{\mathbb{Z}}}\phi(\overline{S_{U}}) \cap \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$
= $\phi\left({}^{\perp_{\mathbb{Z}}}\overline{S_{U}}\right) \cap \mathcal{K}^{[-1,0]}(\text{proj}\,\Lambda)$

By Lemma [4.20,](#page-21-1) we know that $\frac{1}{\sqrt{2\sigma}}$ = thick_{per(Γu)}(\overline{U}). Since ϕ is a triangle equivalence $\phi(\text{thick}_{per(\Gamma_U)}(\overline{U})) = \text{thick}_b(U)$. This implies that $\mathscr{T}(\mathscr{W}(\mathcal{H})) =$ thick_b(U) ∩ K^[-1,0](proj Λ). By applying Lemma [3.3](#page-7-2) we get that

$$
\mathcal{F}(\mathscr{W}(\mathcal{H})) = \text{thick}_{[-1,0]}(U) = \mathcal{H}.
$$

Theorem 4.22. Suppose Λ is g-finite. Then all thick subcategories of $\mathcal{K}^{[-1,0]}(\text{proj } \Lambda)$ have enough injectives.

Proof. Let H be a thick subcategory of $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$, by Theorem [4.14](#page-19-2) we know that there exists a 2-term presilting complex U such that $\mathcal{H} = \text{thick}_{[-1,0]}(U)$. Since Λ is g-finite, then $\mathscr{W}(H)$ is left finite and by Proposition [4.21](#page-22-0) $\mathscr{T}(\mathscr{W}(H))$ has enough injectives. Let V be an injective generator of $\mathscr{T}(\mathscr{W}(\mathcal{H}))$, then

$$
\operatorname{thick}_{[-1,0]}(U) \subset \mathcal{F}(\mathscr{W}(\operatorname{thick}_{[-1,0]}(U))) = \operatorname{thick}_{[-1,0]}(V).
$$

Since $U \in \text{thick}_{[-1,0]}(V) = \text{Cocone}(V, V)$ [\[Gar23,](#page-24-8) Lemma 3.9], there exists a conflation $U \rightarrow V' \rightarrow V''$ with $V', V'' \in \text{add}(V)$ and thus U is 2-term presilting in thick_b(V) with respect to V [−1]. By Lemma [2.4,](#page-4-1) we know that U can be completed into a silting complex in thick_b (V) . Since U and V give rise to the same τ -perpendicular category $\mathscr{W}(\mathcal{H})$, we deduce that $|U| = |V| = |V| - 1|$, which in turn implies by Proposition [2.5](#page-4-3) that U is already silting in thick $_b(V)$ and thus thick_b(V) = thick_b(U). By Corollary [3.5](#page-9-5) this implies that

$$
\mathcal{H} = \text{thick}_{[-1,0]}(U) = \text{thick}_{[-1,0]}(V).
$$

Remark 4.23. The arguments used both in Proposition [4.21](#page-22-0) and Theorem [4.22](#page-23-0) can be adapted to show that the results hold if we substitute left finite for right finite wide subcategories [\[Asa20,](#page-24-26) Definition 1.2]. That is, $\mathscr W$ and $\mathscr T$ are inverse of each other if restricted to the set of right-finite wide subcategories and thick subcategories with enough projectives. Moreover, if Λ is g-finite, the dual statement of Theorem [4.22](#page-23-0) also holds.

Theorem 4.24. Suppose Λ is g-finite. Then all thick subcategories of $\mathcal{K}^{[-1,0]}(\text{proj }\Lambda)$ have enough projectives.

Corollary 4.25. Suppose Λ is g-finite. Then all thick subcategories of $\mathcal{K}^{[-1,0]}(\text{proj } \Lambda)$ have enough projectives and enough injectives.
