STABILITY OF EQUILIBRIA AND BIFURCATIONS FOR A FLUID-SOLID INTERACTION PROBLEM

Abstract. We study certain significant properties of the equilibrium configurations of a rigid body subject to an undamped elastic restoring force, in the stream of a viscous liquid in an unbounded 3D domain. The motion of the coupled system is driven by a uniform flow at spatial infinity, with constant dimensionless velocity λ . We show that if λ is below a critical value, λ_c (say), there is a unique and stable time-independent configuration, where the body is in equilibrium and the flow is steady. We also prove that, if $\lambda < \lambda_c$, no oscillatory flow may occur. Successively, we investigate possible loss of uniqueness by providing necessary and sufficient conditions for the occurrence of a steady bifurcation at some $\lambda_s \geq \lambda_c$.

1. Introduction

Problems involving the flow of a viscous fluid around solids are the focus of the broad research area of Fluid-Solid Interactions (FSI). In particular, also due to their fundamental importance in many practical situations, the oscillations of structures induced by the flow of a viscous liquid occupy a rather significant position within them. It is thus not surprising that the problem of flowinduced oscillations has received all along a plethora of contributions by the engineering community, from experimental, numerical and theoretical viewpoints; see, e.g., the monographs [\[4,](#page-28-1) [9,](#page-28-2) [25\]](#page-28-3), the review article [\[28\]](#page-28-4) and the references therein. The structure model typically adopted by engineers for this study consists of a rigid body subject to a linear restoring elastic force, while the fluid is modeled by the Navier-Stokes equations [\[4\]](#page-28-1).

Notwithstanding, the problem has not yet received a similar, systematic attention from the mathematical community. In this regard, in [\[2,](#page-28-5) [6\]](#page-28-6) we started a rigorous investigation of flowinduced oscillations. There, we dealt with the model problem where a two-dimensional rectangular solid is subject to a unidirectional restoring elastic force, while immersed in the two-dimensional channel flow of a Navier-Stokes liquid, driven by a time-independent Poiseuille flow. The main objective concerns the existence and uniqueness of equilibrium configurations of the FSI system, at least for "small" flow-rate. Successively, several other works have been dedicated to the investigation of further relevant properties of this model, such as explicit thresholds for uniqueness

of the equilibrium configuration [\[21,](#page-28-7) [22\]](#page-28-8), non-symmetric configurations [\[5\]](#page-28-9), well-posedness of the associated initial-boundary value problem [\[26\]](#page-28-10), large-time behavior [\[8\]](#page-28-11) and existence of a global attractor [\[20\]](#page-28-12).

Objective of the current paper is to furnish a further contribution to the area of flow-induced oscillations, and consists in the study of the very fundamental properties of the stability of equilibrium configurations and possible loss of their uniqueness via steady-state bifurcations. The model we shall consider –inspired by $[4]$ – is somewhat more general than that in $[6]$, and consists of a rigid (finite) body, \mathscr{B} , of arbitrary shape, subject to a linear undamped restoring force and immersed in the stream of a Navier–Stokes liquid, \mathscr{L} , that fills the entire three-dimensional space outside \mathscr{B} . The motion of the coupled system is driven by a uniform flow at spatial infinity, characterized by a constant dimensionless velocity λ (Reynolds number). The choice of an unbounded (exterior) domain for the flow region is due to the fact that the interaction of $\mathscr L$ and $\mathscr B$ should not be spoiled by possible "wall effects".

We are interested in the existence, uniqueness, stability and steady bifurcation of equilibria, where, by "equilibrium" we mean a state where $\mathscr L$ is in a steady regime and $\mathscr B$ occupies a corresponding fixed region at all times.

Our first goal is to establish the existence of such equilibria, a property that we prove to be valid for all values of λ ; see Theorem [6.](#page-19-1) We then provide a variational characterization of their uniqueness by showing the existence of a critical value $\lambda_1 = \lambda_1(\lambda) > 0$ such that the equilibrium is unique if $\lambda - \lambda_1(\lambda) < 0$; see Theorem [6.](#page-19-1) As usual, this is merely a sufficient condition for uniqueness which we show to be satisfied (at least) for "small" λ ; see Proposition [7.](#page-7-0)

Successively, we investigate the asymptotic stability (in suitable norms) of the equilibria: our study is complicated by the fact that the region occupied by the fluid is 3D, unbounded (exterior domain) and, contrary to [\[6\]](#page-28-6), no Poincaré-type inequalities hold. One relevant consequence is that we are not in a position to furnish a time-decay rate of the perturbations which, very likely, is just algebraic and not exponential as in [\[20\]](#page-28-12). To set up the stability analysis, we define a second threshold $\lambda_2 = \lambda_2(\lambda) \geq 0$ such that the stability of the equilibrium is guaranteed if $\lambda - \lambda_2(\lambda) < 0$; see Theorem [8.](#page-20-0) However, we are not able to characterize the equilibria for which the request $\lambda_2(\lambda) > 0$ is secured and this condition should be viewed as an assumption which could possibly only hold for certain equilibria. In any case, since $\lambda_2(\lambda) \leq \lambda_1(\lambda)$, if $\lambda - \lambda_2(\lambda) < 0$ the equilibrium is unique and asymptotically stable. The proof of the latter is carried out by a generalization of the "invading domains" technique used in [\[18\]](#page-28-13). The main difficulty, in our case, consists in showing that the perturbation to the elongation of the spring eventually tends to 0. Actually, this property is by no means obvious at the outset, since the spring is assumed to be undamped.

Also in view of its importance in the problem of flow-induced oscillations, one may wonder if, in the range $\lambda - \lambda_2(\lambda) < 0$, regimes of oscillatory nature are indeed possible. The answer to this question is given in Theorem [13](#page-18-0) where we prove that, in that range of λ 's, no oscillatory regime can take place. Existence of oscillatory motions can, therefore, take place only for $\lambda > \lambda_2$ as a result of Hopf bifurcation, a question investigated in the forthcoming article [\[7\]](#page-28-14).

The last part the paper is dedicated to steady bifurcation, namely, the existence of possible multiple equilibria for "sufficiently large" λ (and, certainly, such that $\lambda - \lambda_1(\lambda) \geq 0$). In this regard, we show necessary and sufficient conditions for this phenomenon to occur; see Theorem [21.](#page-26-0) All these findings are proved by reformulating the equilibrium problem as an operator equation in suitable Banach spaces that allows us to employ known results of abstract bifurcation theory. We emphasize further that, in order to avoid the notorious question of 0 being in the essential spectrum of the linearized operator [\[1,](#page-28-15) [11\]](#page-28-16), for the functional setting we use *homogeneous* (rather than classical) Sobolev spaces, according to the approach introduced in [\[14\]](#page-28-17).

The plan of the paper is as follows. In Section [2](#page-2-0) we present the relevant equations and furnish the mathematical formulation of the problem. In Section [3](#page-3-0) we introduce the appropriate functional spaces and collect some of their important properties. Section [4](#page-6-0) contains our main results and is devoted to the study of the equilibria of the FSI problem. Precisely, in Section [4.1](#page-6-1) we first prove existence of such equilibria in a class of homogeneous Sobolev spaces, for arbitrary values of the Reynolds number $\lambda > 0$. Successively, we provide the variational formulation of their uniqueness mentioned above. In the following Section [4.2,](#page-8-0) we study the asymptotic stability of equilibria, whereas the last Section [4.4](#page-19-0) is dedicated to the occurrence of steady-state bifurcation.

2. Formulation of the Problem

Let \mathscr{B} be a rigid body moving in a Navier-Stokes liquid that fills the region $\Omega \subset \mathbb{R}^3$ outside \mathscr{B} and whose flow becomes uniform at "large" distances from \mathscr{B} , characterized by a constant velocity $V \in \mathbb{R}^3$. On \mathscr{B} an elastic restoring force \bm{F} acts, applied to its center of mass G , while a suitable active torque prevents it from rotating. Therefore, the motion of $\mathscr B$ is translatory. In this situation, the governing equations of motion of the coupled system body-liquid when referred to a body-fixed frame $\mathcal{F} \equiv \{G, e_i\}$ are given by [\[13,](#page-28-18) Section 1]

In [\(2.0.1\)](#page-2-1), v and p represent velocity and pressure fields of the liquid, ρ and ν its density and kinematic viscosity, while M and $\gamma = \gamma(t)$ denote mass of $\mathscr B$ and velocity of G, respectively. Here and in the sequel, \mathbb{T}_{ν} denotes the Cauchy stress tensor

where I is the 3 × 3 identity matrix and n is the unit outer normal at $\partial\Omega$, i.e. directed inside \mathscr{B} .

We assume that F depends linearly on the displacement $\chi(t) := \int \gamma(s) ds = \vec{GO}$, with O fixed point, namely

Without loss of generality we take $V = -Ve_1$, $V > 0$.

Remark 1. The choice of the linear constitutive equation $(2.0.2)$ is made just for simplicity of presentation. As will become clear from their proof, our findings (appropriately modified) continue to hold if, more generally, we assume $\mathbf{F} = \mathbb{A} \cdot \chi + g(\chi)$, where \mathbb{A} is a symmetric, positive definite matrix (stiffness matrix), and $g(\chi)$ is sufficiently smooth, with $|g(\chi)| = o(|\chi|)$ as $|\chi| \to 0$.

Writing $v = u - Ve_1$, we are led to

Scaling velocity with V, length with $L := \text{diam } \mathscr{B}$, time with L^2/ν , and setting $u := v + e_1$, we may rewrite [\(2.0.3\)](#page-2-3) in the following form

All the involved quantities are now non-dimensional; in the sequel, we just write $\mathbb T$ instead of $\mathbb T_1$.

Let $s_0 = (u_0, p_0, \chi_0)$ be a steady-state solution to [\(2.0.4\)](#page-2-4) corresponding to a given λ , namely,

From the physical viewpoint, χ_0 represents the (non-dimensional and rescaled) elongation of the spring necessary to keep β in place. In Sections [4.1](#page-6-1) and [4.2,](#page-8-0) for any $\lambda > 0$, we show that [\(2.0.5\)](#page-3-2) has at least one solution

 $\mathsf{s}_0(\lambda) := (\boldsymbol{u}_0(\lambda), p_0(\lambda), \boldsymbol{\chi}_0(\lambda))$

that is unique and stable provided λ remains below a definite value λ_c that we characterize in Theorem [8.](#page-20-0) The uniqueness threshold does only depend on Ω , see Proposition [7,](#page-7-0) whereas the stability threshold λ_c depends on the solution itself and basically on its decay at spatial infinity, see Remark [4.](#page-20-1) Moreover, we prove that as long as $\lambda < \lambda_c$, no oscillatory regime can branch out of $s_0(\lambda)$; see Section [4.3.](#page-16-0) Therefore, non-uniqueness of, as well as bifurcation from $s_0(\lambda)$ may occur only at some $\lambda \geq \lambda_c$. In this regard, we next investigate the occurrence of steady-state bifurcation at some $\lambda = \lambda_s \geq \lambda_c$. More precisely, we furnish necessary and sufficient conditions for the existence of a bifurcation point λ_s and a family of solutions $s(\lambda)$ to [\(2.0.5\)](#page-3-2), with $s(\lambda) \neq s_0(\lambda)$, $\lambda \in U(\lambda_s)$, such that $s(\lambda) \to s_0(\lambda_s)$, as $\lambda \to \lambda_s$. This is accomplished by formulating the problem in a functional setting that is suitable to employ the abstract results of bifurcation theory; see Section [4.4.](#page-19-0)

3. Functional framework

3.1. Notations and Relevant Functional Spaces. Let $\Omega_0 \subset \mathbb{R}^3$ be the closure of a bounded domain of class C^2 , representing the region occupied by \mathscr{B} . Let $\Omega = \mathbb{R}^3 \setminus \Omega_0$ be the unbounded exterior domain containing the fluid L. With the origin of coordinates in the interior of Ω_0 , we set

By $(,)_A$ we indicate the $L^2(A)$ -scalar product. Furthermore, $D^{m,q} = D^{m,q}(A)$ is the homogeneous Sobolev space with semi-norm $\sum_{|l|=m} ||D^l u||_{q,A}$, whereas $D_0^{1,2} = D_0^{1,2}(A)$ is the completion of $C_0^{\infty}(A)$ in the norm $\|\nabla(\cdot)\|_{2,A}$. The dual space of $D_0^{1,2}(A)$ will be indicated by $D_0^{-1,2}(A)$. In all the above notation we shall typically omit the subscript "A", unless confusion arises.

If M is a map between two Banach spaces X and Y, we denote by $D[M] \subseteq X$ and $R[M] \subseteq Y$ its domain and range, respectively, and by $N[M] := \{x \in X : M(x) = 0\}$ its null space.

We shall now introduce certain function classes characterized by the property that their elements are solenoidal. Their most important properties will be collected later on in Section [3.2.](#page-5-0) Let

whenever the integral is meaningful. Let B be a function space with seminorm $\|\cdot\|_B$. By $L^2(0, 2\pi; B)$ we denote the class of functions $u : (0, 2\pi) \to B$ such that

3.2. Basic Properties of the Relevant Functional Spaces. The \mathcal{L}^2 -spaces have two main properties.

Lemma 1. The following characterizations hold

\mathcal{L}^2(\mathbb{R}^3) = \{ \mathbf{u} \in L^2(\mathbb{R}^3) : \ \mathbf{u} = \widehat{\mathbf{u}} \text{ in } \Omega_0, \text{ for some } \widehat{\mathbf{u}} \in \mathbb{R}^3 \}, \quad \mathcal{H}(\mathbb{R}^3) = \{ \mathbf{u} \in \mathcal{L}^2(\mathbb{R}^3) : \ \text{div} \ \mathbf{u} = 0 \} \, .
$$

Proof. See [\[27,](#page-28-20) Theorem 3.1 and Lemma 3.2].

We also have

Lemma 2. With the scalar product $(3.1.1)$, the following orthogonal decomposition holds $\mathcal{L}^2(\mathbb{R}^3) = \mathcal{H}(\mathbb{R}^3) \oplus \mathcal{G}(\mathbb{R}^3)$.

Proof. A proof can be deduced from [\[27,](#page-28-20) Theorem 3.2]. However, for completeness and since this result plays a major role in our analysis, we reproduce it here. Let $u \in \mathcal{H}$ and $h \in \mathcal{G}$. Then,

$$
\langle \boldsymbol{u}, \boldsymbol{h} \rangle = \int_{\Omega} \boldsymbol{u} \cdot \nabla p - \int_{\partial \Omega} p \, \widehat{\boldsymbol{u}} \cdot \boldsymbol{n} \, .

Therefore, integrating by parts and using div $u = 0$ we deduce

which proves $\mathcal{H}^{\perp} \supset \mathcal{G}$. Conversely, assume $v \in \mathcal{H}^{\perp}$, i.e.

so that, by well-known results on the Helmholtz decomposition [\[15,](#page-28-21) Lemma III.1.1], we infer $v = \nabla p$ with $p \in D^{1,2}(\Omega)$. Replacing the latter into [\(3.2.7\)](#page-5-1) and integrating by parts, we get

from which we conclude that $v \in \mathcal{G}$, that is, $\mathcal{H}^{\perp} \subset \mathcal{G}$. The proof of the lemma is completed. \square Concerning the properties of $\mathcal{D}^{1,2}$ -spaces, we state

Lemma 3. Let $\widehat{\mathcal{D}^{1,2}}$ denote either $\mathcal{D}^{1,2}$ or $\mathcal{D}_0^{1,2}$. Then, $\widehat{\mathcal{D}^{1,2}}$ is a separable Hilbert space when equipped with the scalar product

Moreover, we have the characterization:

\widehat{\mathcal{D}^{1,2}} = \left\{ \bm{u} \in L^{6}(\mathbb{R}^{3}) \cap D^{1,2}(\mathbb{R}^{3}) ; \ \text{div } \bm{u} = 0 ; \ \bm{u} = \widehat{\bm{u}} \ \text{in} \ \Omega_{0} \right\},
$$

with some $\hat{u} \in \mathbb{R}^3$ if $\widehat{\mathcal{D}^{1,2}} \equiv \mathcal{D}^{1,2}$, and $\hat{u} = 0$ if $\widehat{\mathcal{D}^{1,2}} \equiv \mathcal{D}_0^{1,2}$. Also, for each $u \in \widehat{\mathcal{D}^{1,2}}$, it holds √

(3.2.9)
$$
\|\nabla u\|_2 = \sqrt{2} \|\mathbb{D}(u)\|_2,
$$

and

(3.2.10) ^kuk⁶ [≤] ^κ⁰ ^kD(u)k² ,

for some $\kappa_0 > 0$. Finally, there is another positive constant κ_1 such that

Proof. See [\[13,](#page-28-18) Lemmas 9–11].

Remark 2. The space $\mathcal{D}^{1,2}(B_R)$ can be viewed as a subspace of $\mathcal{D}^{1,2}(\mathbb{R}^3)$, by extending to 0 in $\mathbb{R}^3\backslash B_R$ its generic element. Therefore, all the properties mentioned in Lemma [3](#page-6-2) continue to hold for $\mathcal{D}^{1,2}(B_R)$.

The X-spaces also have a number of relevant properties that we collect in the next statements.

Lemma 4. The following continuous embedding properties hold

 $(3.2.12)$ $(\Omega) \subset W^{2,2}(\Omega_R)$ for all $R > R_*$, $X^2(\Omega) \subset L^\infty(\Omega) \cap D^{1,q}(\Omega)$ for all $q \in [2,6]$.

Proof. By Lemma [3,](#page-6-2) the first property is obvious. From [\[15,](#page-28-21) Theorem II.6.1(i)] it follows that $X^2(\Omega) \subset D^{1,6}(\Omega)$ which, in turn, by [\[15,](#page-28-21) Theorem II.9.1] and simple interpolation allows us to deduce also the second stated property.

We conclude this section with the following embedding result, whose proof is given in [\[17,](#page-28-22) Lemma 2].

Lemma 5. The space $X(\Omega)$ is continuously embedded in $L^4(\Omega)$.

4. Main results on the equilibrium configurations

4.1. Existence and Uniqueness. We begin with a general existence result in a suitable function class, followed by a corresponding uniqueness result. Both findings are, in fact, obtained as a corollary to classical results regarding steady-state Navier-Stokes problems in exterior domains. Precisely, we have the following theorem.

Theorem 6. For any $\lambda > 0$, problem [\(2.0.5\)](#page-3-2) has at least one solution

$$
\mathsf{s}_0(\lambda):=(\boldsymbol{u}_0(\lambda),p_0(\lambda),\boldsymbol{\chi}_0(\lambda))
$$

such that

(4.1.1)
$$
s_0(\lambda) \in [L^q(\Omega) \cap D^{1,r}(\Omega) \cap D^{2,s}(\Omega)] \times [L^{\sigma}(\Omega) \cap D^{1,s}(\Omega)] \times \mathbb{R}^3,
$$

for all $q \in (2,\infty]$, $r \in (\frac{4}{3},\infty]$, $s \in (\frac{3}{2},\infty]$, $\sigma \in (1,\infty)$. Moreover, the quantity

(4.1.2)
$$
\sup_{\mathbf{u} \in \mathcal{D}_0^{1,2}(\Omega)} \frac{(\mathbf{u} \cdot \nabla \mathbf{u}, \mathbf{u}_0)}{\|\nabla \mathbf{u}\|_2^2} =: \frac{1}{\lambda_1}
$$

is finite, strictly positive, and achieved and, if $\lambda < \lambda_1$, the solution $s_0(\lambda)$ is unique.

Proof. From [\[15,](#page-28-21) Theorem X.6.4] we know that for any $\lambda > 0$ problem $(2.0.5)_{1-4}$ has one corresponding solution (u_0, p_0) in the class [\(4.1.1\)](#page-19-2). We then set

(4.1.3)
$$
\chi_0 := -\frac{\varpi}{\omega_n^2} \int_{\partial \Omega} \mathbb{T}(\boldsymbol{u}_0, p_0) \cdot \boldsymbol{n},
$$

which is well defined by standard trace theorems. This completes the proof of the existence.

We now turn to the uniqueness part. The existence and achievement of $1/\lambda_1$ follows from the summability properties of u_0 given in [\(4.1.1\)](#page-19-2) and standard arguments about maxima of quadratic forms in exterior domains [\[12\]](#page-28-23). In order to prove that $\lambda_1 > 0$, take any $w \in C_0^{\infty}(\mathbb{R}^3)$ with supp $w \cap \Omega_0 = \emptyset$. Then let $u = \text{curl } w$ so that $u \in \mathcal{D}_0^{1,2}(\Omega)$. By translating rigidly u and moving its support towards infinity, we see that $(u \cdot \nabla u, u_0) \to 0$ due to the decay properties of u_0 . Therefore, by its characterization in [\(4.1.2\)](#page-19-1), $\lambda_1^{-1} \geq 0$; in fact, $\lambda_1^{-1} > 0$ since the supremum in $(4.1.2)$ is achieved.

Finally, let $(u+u_0, p+p_0, \chi+\chi_0)$ be another solution to $(2.0.5)$ in the class $(4.1.1)$ corresponding to the same λ . Then (u, p, χ) satisfies the following equations

(4.1.4) −∆u + ∇p = λ [∂1u − (u⁰ + u) · ∇u − u · ∇u0] div ^u = 0) in Ω , u(x) = 0 , x ∈ ∂Ω , lim |x|→∞ u(x) = 0 , ω 2 ⁿχ + ̟ Z ∂Ω ^T(u, p) · ⁿ ⁼ ⁰ .

Dot-multiplying $(4.1.4)_1$ by u , integrating by parts over Ω and using $(4.1.1)$, $(4.1.4)_{2.3}$ and $(4.1.2)$ we find

$$
\|\nabla \boldsymbol{u}\|_2^2 = \lambda(\boldsymbol{u} \cdot \nabla \boldsymbol{u}, \boldsymbol{u}_0) \leq \frac{\lambda}{\lambda_1} \|\nabla \boldsymbol{u}\|_2^2,
$$

from which it follows that $\lambda \geq \lambda_1$ or $\|\nabla u\|_2 = 0$. The latter implies $u = 0$, $\chi = 0$ (and therefore $n = 0$) by Lemma 3. $p = 0$) by Lemma [3.](#page-6-2)

Remark 3. The value λ_1 defined in [\(4.1.2\)](#page-19-1) plays the role of a weighted Poincaré constant. Indeed, it may be equivalently characterized by

$$
\lambda_1 = \min_{\boldsymbol{u} \in \mathcal{D}_0^{1,2}(\Omega)} \frac{\|\nabla \boldsymbol{u}\|_2^2}{(\boldsymbol{u} \cdot \nabla \boldsymbol{u}, \boldsymbol{u}_0)} = \min_{\boldsymbol{u} \in \mathcal{D}_0^{1,2}(\Omega)} \frac{\|\nabla \boldsymbol{u}\|_2^2}{(\boldsymbol{u} \cdot \nabla(-\boldsymbol{u}_0), \boldsymbol{u})}
$$

with the weight $\nabla(-\mathbf{u}_0)$ vanishing at infinity and bringing enough compactness to ensure that the minimum is achieved.

Since λ_1 depends on u_0 which in turn depends on λ , it is natural to wonder whether the condition $\lambda < \lambda_1$ (ensuring uniqueness) can be reached. The next statement shows that this is the case.

Proposition 7. There exists $\gamma = \gamma(\Omega) > 0$ such that, if $\lambda < \gamma$, then problem [\(2.0.5\)](#page-3-2) admits a unique solution.

Proof. As already noticed in the existence proof, the fluid equations $(2.0.5)_{1-4}$ decouple from the one in $(2.0.5)_5$, representing the balance of forces on \mathscr{B} . Therefore, uniqueness for the whole problem [\(2.0.5\)](#page-3-2) is reduced to establish the same property just for the Navier-Stokes problem $(2.0.5)_{1-4}$ $(2.0.5)_{1-4}$. However, the latter is well known [\[15,](#page-28-21) Theorem X.7.3] and is achieved exactly under the condition stated in the proposition.

From Proposition [7](#page-7-0) and Theorem [6,](#page-19-1) we infer, in particular, that uniqueness is ensured for "small" $\lambda > 0$ and may fail only at some λ such that

(4.1.5)
$$
\frac{1}{\lambda} \leq \max_{\mathbf{u} \in \mathcal{D}_0^{1,2}(\Omega)} \frac{(\mathbf{u} \cdot \nabla \mathbf{u}, \mathbf{u}_0(\lambda))}{\|\nabla \mathbf{u}\|_2^2}.
$$

This reveals that either we have uniqueness for all $\lambda > 0$ or there exists $\tilde{\lambda} > 0$ such that $\lambda_1(\tilde{\lambda}) = \tilde{\lambda}$. This $\tilde{\lambda} \in (0, \infty]$ can be defined as

$$
\lambda = \sup\{\lambda > 0 : \nu < \lambda_1(\nu), \forall \nu \in (0, \lambda)\}.
$$

If $\tilde{\lambda} < \infty$, then there exists a non trivial solution u of the linear equation

(4.1.6)
\n
$$
\begin{aligned}\n\Delta \mathbf{u} - \nabla p &= \widetilde{\lambda} (\mathbf{u}_0(\widetilde{\lambda}) \cdot \nabla \mathbf{u} + \mathbf{u} \cdot \nabla \mathbf{u}_0(\widetilde{\lambda})) \\
\text{div } \mathbf{u} &= 0 \\
\mathbf{u}(x) &= \mathbf{0}, \quad x \in \partial \Omega, \lim_{|x| \to \infty} \mathbf{u}(x) = \mathbf{0}.\n\end{aligned}
$$

This condition is, in general, only necessary to get multiple equilibria (i.e. for $\lambda > \tilde{\lambda}$), as discussed in detail later on in the bifurcation context; see Theorem [16](#page-22-0) and Corollary [17.](#page-23-0)

From a physical point of view, one expects that $u_0 = u_0(\lambda)$ becomes "larger" as λ grows, although a precise definition of "larger" appears out of reach. From a mathematical point of view, this could be translated into the fact that some norms of $u_0(\lambda)$ are expected to grow with λ . If this were true, then equality in [\(4.1.5\)](#page-19-4) would hold for a unique value $\lambda > 0$ and this would imply that

$$
\lambda_1(\lambda) > \lambda \text{ if } \lambda < \overline{\lambda}, \quad \lambda_1(\lambda) < \lambda \text{ if } \lambda > \overline{\lambda}.
$$

Clearly, this *would not* allow us to conclude that uniqueness for $(2.0.5)$ is ensured if and only if $\lambda < \overline{\lambda}$.

4.2. Asymptotic stability.

4.2.1. A sufficient condition for stability. Our next task is to find sufficient conditions for the stability of solutions determined in Theorem [6,](#page-19-1) in a suitable class of "perturbations". In this regard, let $\mathsf{s}_0(\lambda) = (\boldsymbol{u}_0(\lambda), p_0(\lambda), \boldsymbol{\chi}_0(\lambda))$ be a steady-state solution given in [\(4.1.1\)](#page-19-2) and let $(\boldsymbol{u}, p, \boldsymbol{\chi})$ be a corresponding time-dependent perturbation. By [\(2.0.4\)](#page-2-4), we then have that (u, p, χ) satisfies the following set of equations

$$
(4.2.1)
$$

$$
\partial_t \mathbf{u} - \Delta \mathbf{u} + \nabla p = \lambda \left[\partial_1 \mathbf{u} - \mathbf{u}_0 \cdot \nabla \mathbf{u} + (\dot{\mathbf{x}} - \mathbf{u}) \cdot \nabla \mathbf{u}_0 - (\dot{\mathbf{x}} - \mathbf{u}) \cdot \nabla \mathbf{u} \right] \quad \text{in } \Omega \times (0, \infty),
$$
\n
$$
\mathbf{u}(x, t) = \dot{\mathbf{x}}(t), \quad (x, t) \in \partial \Omega \times (0, \infty),
$$
\n
$$
\ddot{\mathbf{x}} + \omega_n^2 \mathbf{x} + \omega \int_{\partial \Omega} \mathbb{T}(\mathbf{u}, p) \cdot \mathbf{n} = \mathbf{0}, \quad \text{in } (0, \infty)
$$
\n
$$
\mathbf{u}(x, 0) = \mathbf{u}^0, \quad x \in \Omega, \quad \mathbf{x}(0) = \mathbf{x}^0, \quad \dot{\mathbf{x}}(0) = \mathbf{x}^1.
$$

Given $\lambda > 0$ and some $\mathsf{s}_0(\lambda)$ solving problem [\(2.0.5\)](#page-3-2) (see Theorem [6\)](#page-19-1) we define

(4.2.2)
$$
\frac{1}{\lambda_2} = \frac{1}{\lambda_2(\lambda)} := \sup_{\mathbf{u} \in \mathcal{D}^{1,2}(\mathbb{R}^3)} \frac{((\mathbf{u} - \widehat{\mathbf{u}}) \cdot \nabla \mathbf{u}, \mathbf{u}_0(\lambda))}{\|\nabla \mathbf{u}\|_2^2}
$$

From Theorem [6](#page-19-1) we know that

$$
\frac{1}{\lambda_1} = \frac{(\widetilde{\boldsymbol{u}}\cdot\nabla\widetilde{\boldsymbol{u}}, \boldsymbol{u}_0)}{\|\nabla\widetilde{\boldsymbol{u}}\|_2^2},
$$

for some $\widetilde{u} \in \mathcal{D}_0^{1,2}(\Omega)$. Moreover, as $\mathcal{D}_0^{1,2}(\Omega) \subset \mathcal{D}^{1,2}(\mathbb{R}^3)$ (see Section [3\)](#page-3-0), and since \widetilde{u} vanishes on ∂Ω, we infer that

$$
\frac{1}{\lambda_1} = \frac{(\widetilde{\boldsymbol{u}} \cdot \nabla \widetilde{\boldsymbol{u}}, \boldsymbol{u}_0)}{\|\nabla \widetilde{\boldsymbol{u}}\|_2^2} \leq \sup_{\boldsymbol{u} \in \mathcal{D}^{1,2}(\mathbb{R}^3)} \frac{((\boldsymbol{u} - \widehat{\boldsymbol{u}}) \cdot \nabla \boldsymbol{u}, \boldsymbol{u}_0)}{\|\nabla \boldsymbol{u}\|_2^2} = \frac{1}{\lambda_2}.
$$

Therefore, we infer

$$
(4.2.3) \t\t 0 \leq \lambda_2 \leq \lambda_1.
$$

We can now state a stability result for $(4.2.1)$.

Theorem 8. Let $\lambda > 0$ and let $s_0(\lambda)$ be a solution of problem [\(2.0.5\)](#page-3-2). Suppose $u_0(\lambda)$ is such that $\lambda_2^{-1}(\lambda) < \infty$ and that $\lambda < \lambda_2$. Then, there exists $\varepsilon = \varepsilon(\Omega, \lambda, \omega_{\mathsf{n}}, \varpi) > 0$ such that, if

(4.2.4)
$$
\|u^0\|_{1,2} + |\chi^0| + |\chi^1| \leq \varepsilon,
$$

then problem [\(4.2.1\)](#page-19-2) has one and only one solution such that

(4.2.5)
$$
\mathbf{u} \in C([0,T]; \mathcal{D}^{1,2}(\mathbb{R}^3)) \cap L^2(0,T; W^{2,2}(\Omega)) \cap W^{1,2}(0,T; \mathcal{L}^2(\mathbb{R}^3)),
$$

$$
p \in L^2(0,T; D^{1,2}(\Omega)), \quad \mathbf{\chi} \in W^{2,2}(0,T),
$$

for all $T > 0$. Moreover,

(4.2.6)
$$
\lim_{t \to \infty} (||\nabla \boldsymbol{u}(t)||_2 + ||\boldsymbol{u}(t)||_6 + |\dot{\boldsymbol{\chi}}(t)| + |\boldsymbol{\chi}(t)|) = 0.
$$

Before giving the (lengthy) proof of Theorem [8,](#page-20-0) postponed until Sections [4.2.2](#page-10-0) and [4.2.3,](#page-11-0) several comments are in order.

Remark 4. We first point out that the initial datum in [\(4.2.1\)](#page-19-2) is assumed to satisfy $u^0 \in W^{1,2}(\Omega)$. Overall, the statement may appear unsatisfactory since it assumes that

(4.2.7)
$$
\lambda_2^{-1}(\lambda) < \infty \quad \text{and} \quad \lambda < \lambda_2
$$

but, as we now discuss, a stronger result appears in general out of reach. It is readily seen that the first assumption of [\(4.2.7\)](#page-20-2) is satisfied whenever

(4.2.8) u0(λ) ∈ L 2 (Ω).

Actually, by the triangle and Hölder inequalities we get

\begin{array}{rcl}\n\frac{1}{\lambda_2(\lambda)} & = & \sup\limits_{\boldsymbol{u} \,\in\, \mathcal{D}^{1,2}(\mathbb{R}^3)} \frac{(\boldsymbol{u} \cdot \nabla \boldsymbol{u}, \boldsymbol{u}_0(\lambda)) - (\widehat{\boldsymbol{u}} \cdot \nabla \boldsymbol{u}, \boldsymbol{u}_0(\lambda))}{\|\nabla \boldsymbol{u}\|_2^2} \\
& \leq & \sup\limits_{\boldsymbol{u} \,\in\, \mathcal{D}^{1,2}(\mathbb{R}^3)} \frac{\|\boldsymbol{u}\|_6 \cdot \|\boldsymbol{u}_0(\lambda)\|_3 + |\widehat{\boldsymbol{u}}| \cdot \|\boldsymbol{u}_0(\lambda)\|_2}{\|\nabla \boldsymbol{u}\|_2} < \infty\n\end{array}
$$

since $\|\nabla u\|_2$ bounds both $\|u\|_6$ and \hat{u} (by Lemma [3](#page-6-2)). This proves the first of [\(4.2.7\)](#page-20-2) whenever [\(4.2.8\)](#page-20-3) holds. However, Theorem [6](#page-19-1) ensures in general only that $u_0(\lambda) \in L^q(\Omega)$ for all $q > 2$, plus some integrability conditions on its derivatives. At the same time, we can readily show that

Actually, take $u \in \mathcal{D}^{1,2}(\mathbb{R}^3)$ and u_0 such that, as $|x| \to \infty$,

If we split the fraction as

by the Hölder inequality as above, and $(4.2.10)$ we find that

On the other hand, we also have

This proves [\(4.2.9\)](#page-20-4). Incidentally, we notice that the derivatives of the above u_0 satisfy

so that $(4.1.1)$ is fulfilled (in fact, we even have larger intervals for r and s). In conclusion, we just saw that $(4.2.8)$ gives a sufficient condition for the validity of the first of $(4.2.7)$. This condition may not be necessary but the above example suggests that $(4.2.7)_1$ $(4.2.7)_1$ could fail if $(4.2.2)$ is evaluated along a generic solution u_0 .

Remark 5. Once the first condition in $(4.2.7)$ is satisfied, in order to apply Theorem [8](#page-20-0) one needs to check the second condition. We already observed that, in general, [\(4.2.3\)](#page-19-5) holds. The assumptions of Theorem [8](#page-20-0) require slightly more, namely

$$
0 < \lambda_2(\lambda) \leq \lambda_1(\lambda).
$$

This means that if $0 < \lambda < \lambda_2(\lambda)$, then the corresponding steady-state solution $s_0(\lambda)$ determined in Theorem [6](#page-19-1) is unique and stable.

4.2.2. Some technical lemmas. We prove here some preliminary results. Recall that $\Omega = \mathbb{R}^3 \setminus \Omega_0$ and $\Omega_R = \Omega \cap B_R$.

Lemma 9. Let $(u, p) \in [D^{1,2}(A) \cap W^{2,2}(D)] \times D^{1,2}(D)$ be such that $u|_{\Omega_0} = \hat{u}$ for some $\hat{u} \in \mathbb{R}^3$ with either $\{A, D\} \equiv \{\mathbb{R}^3, \Omega\}$ or $\{A, D\} \equiv \{B_R, \Omega_R\}$. Then, there exists a constant $C > 0$, depending only on the regularity of Ω , such that

Proof. See [\[24,](#page-28-24) Lemma 1] where the domain is requested to be of class C^3 . However, C^2 suffices. \Box

Lemma 10. Let $u \in \mathcal{D}^{1,2}(A) \cap W^{2,2}(D)$, with $u|_{\Omega_0} = \hat{u}$ for some $\hat{u} \in \mathbb{R}^3$, A and D as in Lemma [9](#page-10-1), and let $v \in L^2(D)$. Then, for any $\varepsilon > 0$ there exists a positive constant C (depending only on ε , u_0 , and the regularity of Ω) such that

\begin{aligned} \left| \left(\partial_1 \boldsymbol{u} - \boldsymbol{u}_0 \cdot \nabla \boldsymbol{u} + (\widehat{\boldsymbol{u}} - \boldsymbol{u}) \cdot \nabla (\boldsymbol{u}_0 - \boldsymbol{u}), \boldsymbol{v} \right)_D \right| \\ & \leq C \left(\| \nabla \boldsymbol{u} \|_{2,D}^2 + \| \nabla \boldsymbol{u} \|_{2,D}^4 + \| \nabla \boldsymbol{u} \|_{2,D}^6 \right) + \varepsilon (\| D^2 \boldsymbol{u} \|_{2,D}^2 + \| \boldsymbol{v} \|_{2,D}^2). \end{aligned}
$$

Proof. Let us denote by I_i , $i = 1, \ldots, 6$, in the order, the six terms in the scalar product. Taking into account that, by Theorem [6,](#page-19-1) $u_0 \in L^{\infty}(\Omega) \cap D^{1,q}(\Omega)$, $q = 2, 3$, and using [\(3.2.10\)](#page-6-3), [\(3.2.11\)](#page-6-2), Hölder and Cauchy-Schwarz inequalities we readily get

$$

The lemma is proved.

We will also need the following technical result.

Lemma 11. Let $y : [0, \infty) \mapsto [0, \infty)$, be absolutely continuous and satisfying

Part 1: existence. To prove the existence of a solution to $(4.2.1)$, we follow the arguments introduced and developed in [\[18,](#page-28-13) [19\]](#page-28-25). Let $\{\Omega_R\}, R \in \mathbb{N}$, be an increasing sequence such that $\Omega = \bigcup_{R \in \mathbb{N}} \Omega_R$ and, for each fixed R, consider the problem

\n

\mathbf{u}_R(x, 0) = \mathbf{u}^0, \quad x \in \Omega_R, \quad \chi_R(0) = \chi^0, \quad \boldsymbol{\sigma}_R(0) = \chi^1.

Our approach to existence develops in two steps. In the first step, by the classical Galerkin method we show that $(4.2.15)$ has a solution in the class $(4.2.5)$. This is accomplished with the help of a suitable base, constituted by eigenvectors of a modified Stokes problem. This procedure also leads to the proof of estimates for (u_R, p_R, χ_R) with bounds that are independent of R. In this way, in the second step, we will pass to the limit $R \to \infty$ and show that the limit functions (u, p, χ) solve the original problem [\(4.2.1\)](#page-19-2) along with the asymptotic property [\(4.2.6\)](#page-20-0).

We start putting [\(4.2.15\)](#page-21-3) in a "weak" form. If we multiply $(4.2.15)_1$ by $\psi \in \mathcal{D}^{1,2}(B_R)$, integrate by parts and use $(4.2.15)_{2,3,4}$, we deduce

where $\sigma = \dot{\chi}$ and, for simplicity, the subscript "R" has been omitted and $(\cdot, \cdot) \equiv (\cdot, \cdot)_{\Omega_R}$. Using standard procedures [\[13\]](#page-28-18), one finds that if (u, p, χ, σ) is a smooth solution to [\(4.2.16\)](#page-21-4), then it also

satisfies $(4.2.15)_{1-6}$. In [\[18\]](#page-28-13) it is shown that the problem

with the natural extension $\psi(x) = \hat{\psi}$ in Ω_0 , admits a denumerable number of positive eigenvalues $\{\mu_{Ri}\}\right\}$ clustering at infinity, and corresponding eigenfunctions $\{\psi_{Ri}\}_{i} \subset \mathcal{D}^{1,2}(B_R) \cap W^{2,2}(\Omega_R)$ forming an orthonormal basis of $\mathcal{H}(B_R)$ that is also orthogonal in $\mathcal{D}^{1,2}(\Omega_R)$. Also, the correspondent "pressures" satisfy $\phi_{Ri} \in W^{1,2}(\Omega_R)$, $i \in \mathbb{N}$. Thus, for each fixed $R \in \mathbb{N}$, we look for "approximated" solutions to [\(4.2.16\)](#page-21-4) of the form

Finally, we multiply both sides of $(4.2.19)₁$ by $\lambda_{Ri}c_{iN}$ and sum over i. Integrating by parts over Ω_R and employing [\(4.2.17\)](#page-22-4) and, one more time, [\(4.2.1\)](#page-19-2), [\(3.2.9\)](#page-6-5), and Remark [2](#page-6-4) we show

We shall now derive a number of estimates for the approximated solutions, paying attention that the constants involved are independent of N and R . Such generic constants will be denoted by C, which can thus depend, at most, on Ω , u_0 and the physical constants involved in the problem. Moreover, without specification, its value may change from a line to the next one (e.g. $2C \leq C$). From [\(4.2.25\)](#page-23-1), [\(4.2.23\)](#page-23-0) and [\(3.2.11\)](#page-6-2) we get

Such an estimate implies, in particular, that the initial-value problem $(4.2.21)$ – $(4.2.22)$ has a (unique) solution in the whole interval $(0, \infty)$. Moreover, from $(4.2.27)$, Cauchy-Schwarz inequality and Lemma [10](#page-10-2) with $v \equiv \partial_t u_N$ and $\varepsilon \equiv \varepsilon_1 < \frac{1}{2}$, we infer

Likewise, employing Lemma [10,](#page-10-2) this time with $v \equiv \text{div } \mathbb{T}(u_N, p_N)$, from [\(4.2.28\)](#page-23-4) we obtain

The demonstration of this convergence is rather typical and we omit it, referring to [\[18,](#page-28-13) Step 3 at p. 141] for details. Thus, the proof of existence is completed.

Part 2: uniqueness. This part of the proof is quite standard and we only sketch it here. Let (u_i, p_i, χ_i) , $i = 1, 2$, be two solutions to [\(4.2.1\)](#page-19-2) corresponding to the same initial data, and set

We dot-multiply $(4.2.38)₁$ by u, integrate by parts over Ω and use $(4.2.38)_{2−4}$ to obtain

4.3. Absence of Oscillatory Solutions below the Stability Threshold. As remarked in the previous subsection, if $\lambda_2 > 0$ and $\lambda < \lambda_2$, the steady solution of Theorem [6](#page-19-1) is unique *and* stable. The objective of this subsection is to show, in addition, that, if $\lambda_2 > 0$, no oscillatory motion can stem out of the steady-state branch in a suitable function class of solutions Γ as long as $\lambda < \lambda_2$. As a direct consequence, a time-periodic bifurcation may occur only at some $\lambda_o > \lambda_2$. More precisely, let $s_0(\lambda)$ be the steady-state solution given in [\(4.1.1\)](#page-19-2). A generic T-periodic solution to [\(2.0.4\)](#page-2-4) can then always be written as

$$

and

(4.3.3)
$$
\zeta^2 \ddot{\xi} + \omega_n^2 (\overline{\chi} + \xi) + \varpi \int_{\partial \Omega} \mathbb{T}(\overline{u}, \overline{p}) \cdot \mathbf{n} + \varpi \int_{\partial \Omega} \mathbb{T}(\mathbf{w}, \mathbf{p}) \cdot \mathbf{n} = \mathbf{0}, \text{ in } (0, 2\pi).

Since we assume $\bar{\mathsf{p}}=0$, we have

\omega_n^2 \overline{\chi} + \varpi \int_{\partial\Omega} \mathbb{T}(\overline{u}, \overline{p}) \cdot n = 0\,,
$$

and

In the proof of the main finding of this subsection given below, we need to use a specific "cut-off" function, whose properties are collected in the following lemma.

Lemma 12. There exists $\psi_R \in C_0^{\infty}(\mathbb{R}^3)$, $R \in (0, \infty)$, with the following properties

- (i) $\psi_R(x) \in [0,1]$, for all $x \in \mathbb{R}^3$ and $R > 0$;
- (ii) $\lim_{R \to \infty} \psi_R(x) = 1$ for all $x \in \mathbb{R}^3$;
- (iii) $\psi_R(x) = 1$ for all $x \in B_R$, and supp $(\psi_R) \subset B_{2R^2}$, $R \ge 1$;
- (iv) $\text{supp } (\nabla \psi_R) \subset B_{2R^2} \backslash B_R =: S_R, R \geq 1;$

 (v) $\|\boldsymbol{u}|\nabla \psi_R\|_2 \leq c \|\nabla \boldsymbol{u}\|_{2,\Omega^{\frac{R}{\sqrt{2}}}}$, with c independent of R;

$$
(vi) \ \partial_1 \psi_R \in L^2(\Omega) .
$$

Proof. Let $\psi = \psi(r)$, $r \in (0, \infty)$, be a smooth, non-increasing function that is 1 if $r < 1/2$ and 0 if $r > 1$, and set

Theorem 13. Let $(u, p, \chi) \in \Gamma$ be a solution of [\(4.3.1\)](#page-19-2). If $\lambda < \lambda_2$, necessarily $(u, p, \chi) \equiv (0, 0, 0)$.

Proof. Recall that we use the decomposition

Using (iv) – (vi) in Lemma [12](#page-17-0) along with Hölder inequality, we show

|I_5| \leq ||\overline{\boldsymbol{u}}|\nabla \psi_R||_2 ||\overline{p}||_{2, S_R} \leq c ||\nabla \overline{\boldsymbol{u}}||_2 ||\overline{p}||_{2, S_R}.

We now pass to the limit $R \to \infty$ in [\(4.3.8\)](#page-20-3). With the help of the last two displayed inequalities along with Lemma [12-](#page-17-0)(ii), the fact that $u, w \in \Gamma$ and the definition of λ_1 , we obtain

4.4. Steady-State Bifurcation. We shall now undertake the study of loss of uniqueness and occurrence of bifurcation for the family of solutions $s_0(\lambda)$, $\lambda > 0$, whose existence was established in Theorem [6.](#page-19-1) More precisely, in this subsection we will furnish necessary and sufficient conditions for the occurrence of steady bifurcation.

Let $\lambda_s > 0$, $U(\lambda_s)$ be a neighborhood of λ_s , and denote by

s_0(\lambda) := (\boldsymbol{u}_0(\lambda), p_0(\lambda), \boldsymbol{\chi}_0(\lambda)), \quad \lambda \in U(\lambda_s),

a first solution to [\(2.0.5\)](#page-3-2) determined in Theorem [6.](#page-19-1) Next, let

(\boldsymbol{u}_0(\lambda)+\boldsymbol{u}(\lambda),p_0(\lambda)+p(\lambda),\boldsymbol{\chi}_0(\lambda)+\boldsymbol{\chi}(\lambda)), \lambda\in U(\lambda_s),

be another solution to [\(2.0.5\)](#page-3-2) so that $(u(\lambda), p(\lambda), \chi(\lambda))$ solves the following homogeneous boundaryvalue problem

Then, formally, steady-state bifurcation reduces to show that

- (i) $(\mathbf{u}(\lambda), p(\lambda), \chi(\lambda)) \not\equiv (\mathbf{0}, 0, \mathbf{0}), \lambda \in U(\lambda_s),$
- (ii) $(\mathbf{u}(\lambda), p(\lambda), \chi(\lambda)) \to (\mathbf{0}, 0, \mathbf{0})$ as $\lambda \to \lambda_s$,

in which case, $(\lambda_s, s_0(\lambda_s))$ is called a bifurcation point for problem [\(2.0.5\)](#page-3-2) (or, equivalently, $(\lambda_s, \mathbf{0})$ a bifurcation point for [\(4.4.2\)](#page-19-1)). The above properties should be, of course, rigorously formulated and their validity properly ascertained in an appropriate functional setting.

Remark 6. We observe that, in order to prove (i) - (ii) it is enough to prove

- (i)' $(\mathbf{u}(\lambda), p(\lambda)) \not\equiv (\mathbf{0}, 0), \lambda \in U(\lambda_s),$
- (ii)' $(\mathbf{u}(\lambda), p(\lambda)) \to (\mathbf{0}, 0) \text{ as } \lambda \to \lambda_s,$

provided the existence of the bifurcating branch is obtained in a function class that allows the control of $\chi(\lambda)$, namely, the right-hand side of $(4.4.2)_5$ $(4.4.2)_5$. We could thus restrict ourselves to prove such a type of existence. However, also in view of the analysis of time-periodic bifurcation that we shall develop in [\[7\]](#page-28-14), we prefer to study problem [\(4.4.2\)](#page-19-1) as a whole.

Let

and set $\widehat{\mathscr{A}} := \mathscr{P} \widehat{\Delta}$, where \mathscr{P} is the self-adjoint orthogonal projection of $\mathcal{L}^2(\mathbb{R}^3)$ onto $\mathcal{H}(\mathbb{R}^3)$. We thus have

for some $p \in \mathcal{G}(\Omega)$.

The following result holds.

Lemma 14. The operator $\widehat{\mathscr{A}}: \mathcal{Z} \to \mathcal{Y}$ is a homeomorphism.

Proof. We have to show that, for any $(f, F) \in [D_0^{-1,2}(\Omega) \cap L^2(\Omega)] \times \mathbb{R}^3$ there exists one and only one $(\boldsymbol{u}, \boldsymbol{\chi}) \in [D^{2,2}(\Omega) \cap \mathcal{D}_0^{1,2}(\Omega)] \times \mathbb{R}^3$ satisfying

The result will then follow by the open mapping theorem. It is well-known that for any $f \in \mathcal{D}_0^{-1,2}(\Omega)$ there exists a unique $(u, p) \in \mathcal{D}_0^{1,2}(\Omega) \times L^2(\Omega)$ satisfying $(4.4.7)_{1,2,3}$ in distributional sense, see for instance [\[15,](#page-28-21) Theorem V.2.1]. Moreover, since $f \in L^2(\Omega)$, we also have $(u, p) \in D^{2,2}(\Omega) \times D^{1,2}(\Omega)$ [\[15,](#page-28-21) Theorems IV.5.1 and V.5.3]. By the trace theorem, for a fixed $R > R_*$,

It is readily checked that, as stated, $\widehat{\partial}_1(\mathbf{U}) \in \mathcal{H}(\mathbb{R}^3)$. By Lemma [2](#page-5-2) and [\(4.4.8\)](#page-20-3), this amounts to show that

Lemma 15. For any $\lambda \neq 0$, the operator $\mathcal{L}_{\lambda} : \mathcal{X} \to \mathcal{Y}$ is Fredholm of index 0.

Proof. We first show that \mathscr{L}_{λ} is well defined. Clearly $\mathscr{P}\varphi = \varphi$, for $\varphi \in C_0(\Omega)$. Therefore, for any such a φ , integrating by parts we get

Since $u \in X^2(\Omega)$, by Lemma [4](#page-6-7) and Theorem [6,](#page-19-1) we conclude that $\mathscr{L}_\lambda(\mathbf{U}) \in \mathcal{H}(\mathbb{R}^3)$ as claimed.

We now turn to the verification of the Fredholmness of \mathscr{L}_{λ} . We decompose \mathscr{L}_{λ} as follows

We start by showing $\mathscr{L}_{\lambda}^{0}$ is a homeomorphism, that is, for any $(f, F) \in [\mathcal{D}_{0}^{-1,2}(\Omega) \cap L^{2}(\Omega)] \times \mathbb{R}^{3}$ there exists unique $(\boldsymbol{u}, \boldsymbol{\chi}) \in X^2(\Omega) \times \mathbb{R}^3$ solving

(4.4.12)
\n
$$
\begin{aligned}\n\lambda \partial_1 \mathbf{u} + \Delta \mathbf{u} &= \nabla p + \mathbf{f} \\
\text{div } \mathbf{u} &= 0\n\end{aligned}\n\bigg\} \text{ in } \Omega,
$$
\n
$$
\begin{aligned}\n\mathbf{u}(x) &= \mathbf{0} \text{ on } \partial \Omega, \\
\omega_n^2 \chi + \varpi \int_{\partial \Omega} \mathbb{T}(\mathbf{u}, p) \cdot \mathbf{n} &= \mathbf{F}.\n\end{aligned}
$$

To show the validity of this property, we notice that corresponding to the given f , from [\[10,](#page-28-26) Theorem 2.1] we know that there exists a unique solution $(u, p) \in X^2(\Omega) \times W^{1,2}(\Omega)$ to $(4.4.12)_{1,2,3}$. By the trace theorem we get

(4.4.13)
$$
\left|\int_{\partial\Omega} \mathbb{T}(\boldsymbol{u},p)\cdot \boldsymbol{n}\right| \leq c \left(\|\boldsymbol{u}\|_{2,2,\Omega_R} + \|p\|_{1,2,\Omega_R}\right) < \infty.
$$

The associated and uniquely determined displacement χ is then obtained from $(4.4.12)_4$, which concludes the proof of the homeomorphism property of \mathcal{L}^0_λ by the open mapping theorem.

We next show that the operator $\mathscr C$ is compact. To this end, consider a sequence

$$
\{\mathbf U_k\}_k\equiv\{(\boldsymbol u_k,\boldsymbol \chi_k)\}\subset\mathcal X
$$

with

(4.4.14) kukkX² + |χ^k | ≤ M ,

and M independent of $k \in \mathbb{N}$. This implies the existence of $u_* \in L^4(\Omega) \cap D^{1,2}(\Omega) \cap D^{2,2}(\Omega)$ and $\chi_* \in \mathbb{R}^3$ such that along a subsequence (that we continue to denote by $\{(u_k, \chi_k)\}\)$

(4.4.15)
$$
\mathbf{x}_k - \mathbf{x}_* \to 0, \text{ in } \mathbb{R}^3
$$

$$
\mathbf{w}_k := \mathbf{u}_k - \mathbf{u}_* \to 0, \text{ weakly in } L^4(\Omega),
$$

$$
\nabla \mathbf{w}_k \to 0, \text{ weakly in } W^{1,2}(\Omega).
$$

Moreover, by Lemma [4](#page-6-7) and compact embedding results, we also have

(4.4.16)
$$
\mathbf{w}_k \to 0, \text{ strongly in } W^{1,2}(\Omega_R), \text{ for all } R > R_*.
$$

Observe that

$$
|u_0\cdot \nabla w_k + w_k\cdot \nabla u_0|_{-1,2} \leq \|u_0\otimes w_k\|_2 \leq \|u_0\|_\infty \|w_k\|_{2,\Omega_R} + \|u_0\|_{4,\Omega^R} \|w_k\|_4\,,
$$

where we recall $\Omega^R = \Omega \backslash \overline{\Omega_R} = \mathbb{R}^3 \setminus \overline{B_R}$, and

$$
\|\bm{u}_0\cdot\nabla \bm{w}_k+\bm{w}_k\cdot\nabla \bm{u}_0\|_2\leq \|\bm{u}_0\|_{1,\infty}\|\bm{w}_k\|_{1,2,\Omega_R}+\|\bm{u}_0\|_{1,4,\Omega^R}\|\bm{w}_k\|_{1,4}\,.
$$

From Theorem [6,](#page-19-1) we know that $u_0 \in W^{1,\infty}(\Omega) \cap W^{1,4}(\Omega)$, so that letting first $k \to \infty$ in the above two inequalities and using $(4.4.14)$ – $(4.4.16)$, and then $R \to \infty$, we deduce

$$
\lim_{k\to\infty} \left(| \mathbf{u}_0\cdot\nabla \mathbf{w}_k + \mathbf{w}_k\cdot\nabla \mathbf{u}_0 |_{-1,2} + \| \mathbf{u}_0\cdot\nabla \mathbf{w}_k + \mathbf{w}_k\cdot\nabla \mathbf{u}_0 \|_2 \right) = 0.
$$

In view of $(4.4.10)$, this proves that $\mathscr C$ is compact and finishes the proof.

From Theorem [6,](#page-19-1) we know that the solution $s_0(\lambda) := (\boldsymbol{u}_0(\lambda), p_0(\lambda), \boldsymbol{\chi}_0(\lambda))$ to problem [\(2.0.5\)](#page-3-2) is unique, provided that $\lambda < \lambda_1(\lambda)$, as defined in [\(4.1.2\)](#page-19-1). Our next concern is to furnish a sufficient condition for local uniqueness of $s_0(\overline{\lambda})$ whenever $\overline{\lambda} \geq \lambda_1(\overline{\lambda})$ if this situation occurs. Let

$$
(\mathbf{u}_0, \mathbf{p}_0, \boldsymbol{\tau}_0) := (\boldsymbol{u}_0(\overline{\lambda}), p_0(\overline{\lambda}), \boldsymbol{\chi}_0(\overline{\lambda}))
$$

be a given solution of the problem

$$
-\Delta u_0 + \nabla p_0 = \overline{\lambda} (\partial_1 u_0 - u_0 \cdot \nabla u_0)
$$

div $u_0 = 0$

$$
u_0(x) = e_1, \quad x \in \partial \Omega; \quad \lim_{|x| \to \infty} u_0(x) = 0,
$$

$$
\omega_n^2 \chi_0 + \varpi \int_{\partial \Omega} \mathbb{T}(u_0, p_0) \cdot \mathbf{n} = 0.
$$

We will write any solution $(\mathbf{u}_0(\lambda), p_0(\lambda), \mathbf{\chi}_0(\lambda))$ to $(2.0.5)$ as

$$
(\textbf{\textit{u}}(\lambda)+\textbf{\textit{u}}_0, p(\lambda)+p_0, \chi(\lambda)+\boldsymbol{\tau}_0).
$$

Then $(\boldsymbol{u}, p, \boldsymbol{\chi}) = (\boldsymbol{u}(\lambda), p(\lambda), \boldsymbol{\chi}(\lambda))$ solves

$$
-\Delta u + \nabla p - \overline{\lambda} \partial_1 u + \overline{\lambda} (u_0 \cdot \nabla u + u \cdot \nabla u_0)
$$

\n
$$
= \mu \left(\partial_1 (u_0 + u) - (u_0 + u) \cdot \nabla (u_0 + u) - \overline{\lambda} \mu^{-1} u \cdot \nabla u \right) \text{ div } u = 0
$$

\n
$$
u(x) = 0, \text{ for } x \in \partial \Omega, \lim_{|x| \to \infty} u(x) = 0,
$$

\n
$$
\omega_n^2 \chi + \varpi \int_{\partial \Omega} \mathbb{T} (u, p) \cdot n = 0,
$$

where we have set $\mu := \lambda - \overline{\lambda}$. To rewrite [\(4.4.18\)](#page-22-2) in a suitable way, we define one more operator:

$$
\mathscr{O}: \mathbf{U} \in \mathcal{X} \mapsto \mathscr{O}(\mathbf{U}) \in Y
$$

where

(4.4.19)
$$
\mathscr{O}(\mathbf{U}) = \begin{cases} -\partial_1(\mathbf{u}_0 + \mathbf{u}) + (\mathbf{u}_0 + \mathbf{u}) \cdot \nabla(\mathbf{u}_0 + \mathbf{u}) + \overline{\lambda} \mu^{-1} \mathbf{u} \cdot \nabla \mathbf{u} & \text{in } \Omega, \\ 0 & \text{in } \Omega_0. \end{cases}
$$

It is clear that [\(4.4.18\)](#page-22-2) is formally equivalent to

$$
\mathscr{L}_{\overline{\lambda}}(\mathbf{U}) + \mu \mathscr{P} \mathscr{O}(\mathbf{U}) = 0.
$$

We claim that the map $\mathscr O$ is well defined. Indeed, taking into account Theorem [6](#page-19-1) and the fact that $u \in X^2(\Omega)$, by arguments similar to those employed previously we easily show that, with a, b being either u_0 or u ,

(4.4.20)
$$
\partial_1 \mathbf{u}, \mathbf{a} \cdot \nabla \mathbf{b} \in \mathcal{D}_0^{-1,2}(\Omega) \cap L^2(\Omega), \quad \partial_1 \mathbf{u}_0 \in L^2(\Omega).
$$

Moreover, testing $(2.0.5)_1$ (with $u_0 \equiv u_0$, $p_0 \equiv p_0$, $\lambda \equiv \overline{\lambda}$) by $\varphi \in C_0(\Omega)$ and integrating by parts, we get

$$
\lambda_s(\partial_1\mathbf{u}_0,\boldsymbol{\varphi})=-(\mathbf{u}_0\otimes\mathbf{u}_0,\nabla\boldsymbol{\varphi})+(\nabla\mathbf{u}_0,\nabla\boldsymbol{\varphi})\,.
$$

Since $\mathbf{u}_0 \in L^4(\Omega) \cap D^{1,2}(\Omega)$, from the latter we deduce $\partial_1 \mathbf{u}_0 \in \mathcal{D}_0^{-1,2}(\Omega)$, which, along with $(4.4.20)$ proves that $\mathscr O$ is well defined.

We are now in position to give a sufficient condition for local uniqueness.

Theorem 16. Let $(\mathbf{u}_0, \mathbf{p}_0, \boldsymbol{\tau}_0) := (\boldsymbol{u}_0(\overline{\lambda}), p_0(\overline{\lambda}), \boldsymbol{\chi}_0(\overline{\lambda}))$, and assume that the equation

$$
(4.4.21)\t\t\t\t\mathscr{L}_{\overline{\lambda}}(\mathbf{U}) = \mathbf{0}
$$

has only the solution $\mathbf{U} \equiv \mathbf{0}$. Then, there exists a neighborhood $U(\overline{\lambda}) \supset {\overline{\lambda}}$ such that for $\lambda \in U(\overline{\lambda})$, $\mathsf{s}_0(\lambda) := (\boldsymbol{u}(\lambda), p_0(\lambda), \boldsymbol{\chi}_0(\lambda))$ is the only solution to [\(2.0.5\)](#page-3-2). Moreover, $\lambda \mapsto \mathsf{s}_0(\lambda)$ is analytic at $\lambda = \overline{\lambda}$, and

$$
(\boldsymbol{u}_0(\lambda),p_0(\lambda),\boldsymbol{\chi}_0(\lambda))\to(\boldsymbol{u}_0,p_0,\boldsymbol{\tau}_0)\ \ \text{as}\ \lambda\to\overline{\lambda}.
$$

Proof. Let

$$
\mathcal{F}:(\mathbf{U},\mu)\in\Xi(0)\times\mathcal{I}(0)\mapsto\mathscr{L}_{\overline{\lambda}}(\mathbf{U})+\mu\mathscr{P}\mathscr{O}(\mathbf{U})\in\mathcal{Y}\,,
$$

where $\Xi(0) \times \mathcal{I}(0)$ is a neighborhood of $(0, 0) \in \mathcal{X} \times \mathbb{R}$. We have seen that $(2.0.5)$ translates in [\(4.4.18\)](#page-22-2) which is equivalent to

(4.4.22)
$$
\mathcal{F}(\mathbf{U}, \mu) = \mathbf{0} \in \mathcal{Y}.
$$

Clearly, [\(4.4.22\)](#page-23-2) has the solution $(U = 0, \mu = 0)$. Moreover, it is standard to verify that F is Frechét-differentiable with derivative $D_{\mathbf{U}}\mathcal{F}(\mathbf{0},0) = \mathscr{L}_{\overline{\lambda}}$. Since $\mathscr{L}_{\overline{\lambda}}$ is Fredholm of index 0, the assumption made in [\(4.4.21\)](#page-22-0) implies that $\mathscr{L}_{\overline{\lambda}}$ is a homeomorphism. In addition, $\mathcal F$ is polynomial in (U, μ) . As a consequence, by the analytic version of the implicit function theorem we show the property stated in the theorem, which is thus completely established. \square

Theorem [16](#page-22-0) tells us, in particular, that $s_0(\overline{\lambda})$, $\overline{\lambda} \geq \lambda_1$, is unique as long as the corresponding linearization satisfies [\(4.4.21\)](#page-22-0). Moreover, this solution can be analytically (and uniquely) continued up to the first value of $\overline{\lambda}$, say, λ_s , where [\(4.4.21\)](#page-22-0) is violated.

We thus have:

Corollary 17. A necessary condition for $(\lambda_s, s_0(\lambda_s))$ to be a steady-state bifurcation point is (4.4.23) $\dim \mathsf{N}[\mathscr{L}_{\lambda_s}] > 0$.

Remark 7. Recalling the definition of \mathscr{L}_{λ} in [\(4.4.11\)](#page-20-5), we have that condition [\(4.4.23\)](#page-23-0) is equivalent to the request that the linear problem

$$
-\Delta u + \nabla p = \lambda_s (\partial_1 u - u_0(\lambda_s) \cdot \nabla u - u \cdot \nabla u_0(\lambda_s))
$$

div $u = 0$

$$
u(x) = 0, \quad x \in \partial \Omega; \qquad \lim_{|x| \to \infty} u(x) = 0,
$$

$$
\omega_n^2 \chi + \varpi \int_{\partial \Omega} \mathbb{T}(u, p) \cdot n = 0,
$$

has at least one solution $(\mathbf{u}, \chi) \in X^2(\Omega) \times \mathbb{R} \setminus \{0, 0\}$. This is, in turn, equivalent to the condition that $(4.4.24)_{1,2,3,4}$ $(4.4.24)_{1,2,3,4}$ has a non-identically zero solution $u \in X^2(\Omega)$. We may then conclude that the necessary condition for bifurcation in absence of compatibility condition $(4.4.24)_5$ $(4.4.24)_5$ remains such also in its presence; see also Remark [6](#page-19-6).

Our next goal is to find sufficient conditions for the occurrence of steady bifurcation. For this, we shall rewrite [\(4.4.2\)](#page-19-1) as an equation in a suitable Banach space, and establish some basic properties of the involved operators. After that, we will be able to apply abstract bifurcation results to our case and derive the desired conditions.

To reach these purposes, we need to introduce another operator, namely

$$
\mathscr{N}: \mathbf{U} \in \mathcal{X} \mapsto \mathscr{N}(\mathbf{U}) \in Y
$$

where

(4.4.25)
$$
\mathcal{N}(\mathbf{U}) = \begin{cases} u \cdot \nabla u \text{ in } \Omega, \\ 0 \text{ in } \Omega_0. \end{cases}
$$

By arguing as we did for the map $\mathscr O$ in Theorem [16,](#page-22-0) we show that $\mathscr N$ is well defined. Thus, from $(4.4.25)$ and $(4.4.11)$, we deduce that problem $(4.4.2)$ is equivalent to the following equation

(4.4.26)
$$
\widehat{\mathscr{A}}(\mathbf{U}) + \lambda[\widehat{\partial}_1(\mathbf{U}) + \mathscr{P}\mathscr{C}(\lambda)(\mathbf{U}) + \mathscr{P}\mathscr{N}(\mathbf{U})] = \mathbf{0} \text{ in } \mathcal{Y}, \lambda \in U(\lambda_s),
$$

where we have emphasized that the operator $\mathscr C$ depends on λ through u_0 . In view of Lemma [14,](#page-20-6) we may operate on both sides of $(4.4.26)$ with $\widehat{\mathscr{A}}^{-1}$, so that $(4.4.26)$ becomes:

(4.4.27) $\mathscr{F}(\mathbf{U}, \lambda) = \mathbf{0}, \text{ in } \mathcal{Z}, \lambda \in U(\lambda_s)$

where

$$
\mathscr{F} := I + \lambda \mathscr{M}(\lambda) + \lambda \mathscr{R}
$$

with I identity in Z , and

$$
\mathcal{M}(\lambda) : \mathbf{U} \in \mathcal{X} \equiv \mathsf{D}[\mathcal{M}(\lambda)] \subset \mathcal{Z} \mapsto \widehat{\mathscr{A}}^{-1}[\widehat{\partial}_1(\mathbf{U}) + \mathscr{P}\mathscr{C}(\lambda)(\mathbf{U})] \in \mathcal{Z},
$$

$$
\mathcal{R} : \mathbf{U} \in \mathcal{X} \equiv \mathsf{D}[\mathcal{R}] \mapsto \widehat{\mathcal{A}}^{-1} \mathcal{N}(\mathbf{U}) \in \mathcal{Z}.
$$

Remark 8. Since \mathcal{R} is bilinear in **U**, for each fixed λ , the map \mathcal{F} is analytic in **U**.

We shall now establish some important properties of the operator $\mathscr{M}(\lambda)$.

Lemma 18. For each fixed $\lambda > 0$, the operator $\mathcal{M} = \mathcal{M}(\lambda)$ is densely defined and closed.^{[\(1\)](#page-24-5)}

Proof. Recalling the definitions given in $(4.4.3)$ and $(4.4.4)$, the density property means that, given arbitrary $u \in D^{2,2}(\Omega) \cap \mathcal{D}_0^{1,2}(\Omega)$ and $\varepsilon > 0$, there exists $u_{\varepsilon} \in X^2(\Omega) \cap \mathcal{D}_0^{1,2}(\Omega)$ such that

$$
||\nabla(\mathbf{u}-\mathbf{u}_{\varepsilon})||_{1,2}<\varepsilon.
$$

Let ϕ_R , $R > R_*$, be a smooth, non-increasing function of $|x| \in [0,\infty)$, such that $\phi_R(x) = 1$, if $|x| \leq R$, $\phi_R(x) = 0$, if $|x| \geq 2R$, and

$$
|\nabla \phi_R(x)| \leq c R^{-1}, \quad |\nabla (\nabla \phi_R(x))| \leq c R^{-2}, \quad \text{for all } x \in \mathbb{R}^3,
$$

with c independent of R . Consider the problem

$$
\operatorname{div} \mathbf{v} = \nabla \phi_R \cdot \mathbf{u}, \quad \text{in } B_{R,2R} := \{ x \in \Omega : |x| \in (R, 2R) \}, \quad \mathbf{v} \in W_0^{2,2}(B_{R,2R}).
$$

It is well known that the field v exists and that there exists a positive constant c_0 , independent of R, such that

$$
\|\nabla \boldsymbol{v}\|_2 \leq c_0 \|\nabla \phi_R \cdot \boldsymbol{u}\|_2, \ \ \|D^2 \boldsymbol{v}\|_2 \leq c_0 \|\nabla (\nabla \phi_R \cdot \boldsymbol{u})\|_2.
$$

We refer to [\[15,](#page-28-21) Theorem III.3.3 and Lemma III.3.3]. Extending v by 0 outside Ω_R , we deduce, in particular, $\mathbf{v} \in W_0^{2,2}(\Omega)$. Moreover, by Hölder inequality and the properties of ϕ_R ,

(4.4.30)
$$
\|\nabla \mathbf{v}\|_2 \le cR^{-1} \|\mathbf{u}\|_2 \le c_2 \|\mathbf{u}\|_{6, B_{R, 2R}},
$$

$$
\|D^2 \mathbf{v}\|_2 \le c \left(R^{-2} \|\mathbf{u}\|_{2, B_{R, 2R}} + R^{-1} \|\nabla \mathbf{u}\|_2\right) \le c R^{-1} \left(\|\mathbf{u}\|_6 + \|\nabla \mathbf{u}\|_2\right),
$$

where, here and in the rest of the proof, c denotes a positive constant independent of R . Setting

$$
\boldsymbol{u}_R:=\phi_R\boldsymbol{u}-\boldsymbol{v}\,,
$$

we establish at once with the help of Lemma [2](#page-5-2) that $u_R \in X^2(\Omega) \cap \mathcal{D}_0^{1,2}(\Omega)$. Also, again by the properties of ϕ_R , Hölder inequality and [\(4.4.30\)](#page-24-0) we show, in a similar manner,

(4.4.31)
$$
\|\nabla(\mathbf{u}-\mathbf{u}_R)\|_2 \leq \| (1-\phi_R)\nabla \mathbf{u} \|_2 + c \|\mathbf{u}\|_{6, B_{R, 2R}} \| D^2(\mathbf{u}-\mathbf{u}_R)\|_2 \leq \| (1-\phi_R)D^2\mathbf{u} \|_2 + cR^{-1} (\|\mathbf{u}\|_6 + \|\nabla \mathbf{u} \|_2).
$$

Since, by Lemma [2,](#page-5-2) $u \in L^{6}(\Omega)$, [\(4.4.29\)](#page-24-3) follows from [\(4.4.31\)](#page-24-1), by taking R sufficiently large.

To prove *M* is closed, we take $\{U_k \equiv (u_k, \chi_k)\} \subset \mathcal{X}$, $(U \equiv (u, \chi), V \equiv (v, \zeta)) \in \mathcal{Z}$ such that

(4.4.32)
$$
\|\nabla(\boldsymbol{u}_k - \boldsymbol{u})\|_{1,2} + |\boldsymbol{\chi}_k - \boldsymbol{\chi}| \to 0 \quad \text{as } k \to \infty,
$$

$$
\mathscr{M}(\boldsymbol{U}_k) \to \boldsymbol{V} \text{ in } \mathcal{Z} \qquad (4.4.32)
$$

where, for simplicity, we have omitted the dependence of $\mathcal M$ on λ . We need to show

- (a) $\mathbf{u} \in X(\Omega)$:
- (b) $\mathscr{M}(\mathbf{U}) = \mathbf{V}$.

Let $(\boldsymbol{v}_k, \boldsymbol{\zeta}_k) \equiv \mathbf{V}_k := \mathscr{M}(\mathbf{U}_k)$, and set $\boldsymbol{v}_{kk'} = \boldsymbol{v}_k - \boldsymbol{v}_{k'}$, $\boldsymbol{\zeta}_{kk'} = \boldsymbol{\zeta}_k - \boldsymbol{\zeta}_{k'}$, $\boldsymbol{u}_{kk'} = \boldsymbol{u}_k - \boldsymbol{u}_{k'}$ and $p_{kk'} = p_k - p_{k'}$. Then,

$$
-\Delta v_{kk'} + \nabla p_{kk'} = \lambda \left(\partial_1 u_{kk'} - u_0 \cdot \nabla u_{kk'} - u_{kk'} \cdot \nabla u_0 \right) \quad \text{in } \Omega \,,
$$

div $u_{kk'} = 0$
 $u_{kk'} = 0 \quad \text{on } \partial \Omega \,,$

(4.4.33)

$$
\omega_{\mathsf{n}}^2 \zeta_{kk'} + \varpi \int_{\partial\Omega} \mathbb{T}(v_{kk'}, p_{kk'}) \cdot \boldsymbol{n} = \boldsymbol{0}.
$$

⁽¹⁾In fact, the result holds for all $\lambda \neq 0$, but this generalization is irrelevant to our aims.

Testing $(4.4.33)_1$ with $\varphi \in \mathcal{C}_0(\Omega)$, integrating by parts, and using Hölder inequality we infer that

$$
\lambda |(\partial_1 \boldsymbol{u}_{kk'},\boldsymbol{\varphi})| = \| (\nabla \boldsymbol{v}_{kk'} - \lambda (\boldsymbol{u}_0 \otimes \boldsymbol{u}_{kk'} + \boldsymbol{u}_{kk'} \otimes \boldsymbol{u}_0), \nabla \boldsymbol{\varphi}) \| \\ \leq (\| \nabla \boldsymbol{v}_{kk'} \|_2 + 2\lambda \| \boldsymbol{u}_0 \|_3 \| \boldsymbol{u}_{kk'} \|_6) \| \nabla \boldsymbol{\varphi} \|_2 \, .
$$

Now, $\|\nabla \mathbf{v}_{kk'}\|_2 \to 0$ (by $(4.4.32)_2$), $\|\mathbf{u}_{kk'}\|_6 \to 0$ (by $(3.2.10)$ and $(4.4.32)_1$) and $\mathbf{u}_0 \in L^3(\Omega)$ (by Theorem [6\)](#page-19-1), and so we conclude that $(u_k)_k$ is converging also in $X(\Omega)$, which proves (a).

Writing [\(4.4.33\)](#page-24-2) with $v_{kk'} \equiv v_k$, $u_{kk'} \equiv u_k$, etc., passing to the limit $k \to \infty$, and employing [\(4.4.32\)](#page-24-4) along with the trace theorem, we get

$$
-\Delta v + \nabla p = \lambda (\partial_1 u - u_0 \cdot \nabla u - u \cdot \nabla u_0)
$$

div $u = 0$ on $\partial \Omega$,

$$
u = 0 \text{ on } \partial \Omega,
$$

$$
\omega_n^2 \zeta + \varpi \int_{\partial \Omega} \mathbb{T}(v, p) \cdot n = 0.
$$
which proves (b).

Next, we prove

Lemma 19. For any fixed $\lambda > 0$ and $\mu \neq 0$ the operator

$$
\mathcal{H}_{\mu} = \mu \mathop{\rm I} - \lambda \mathcal{M}(\lambda)
$$

is Fredholm of index 0. Furthermore, denoting by $\sigma(\mathcal{M})$ the spectrum of \mathcal{M} , we have that $\sigma(\mathcal{M}) \cap (0,\infty)$ consists at most of a countable number of eigenvalues of finite algebraic multiplicity that can only cluster at 0.

Proof. Let us define \mathscr{T}_{μ} through

(4.4.34)
$$
\mathscr{H}_{\mu} = \mu \widehat{\mathscr{A}}^{-1} \big(\widehat{\mathscr{A}} + \frac{\lambda}{\mu} (\widehat{\partial}_1 + \mathscr{P} \mathscr{C}(\lambda)) := \widehat{\mathscr{A}}^{-1} \mathscr{T}_{\mu}.
$$

Since the operator $\widehat{\mathscr{A}}$ is a homeomorphism by Lemma [14](#page-20-6) and \mathscr{T}_{μ} is Fredholm of index 0 by Lemma [15,](#page-20-7) we have

$$
\dim \mathsf{N}[\mathscr{H}_\mu]=\dim \mathsf{N}[\mathscr{T}_\mu]=m<\infty\,.
$$

Moreover, from

 $(4.4.35)$

$$
\mathcal{Y} = \mathsf{R}(\mathscr{T}_\mu) \oplus S_m
$$

with S_m m-dimensional subspace, we deduce that for every $\mathbf{U} \in \mathcal{Z}$, we have $\widehat{\mathscr{A}}\mathbf{U} = \mathbf{U}_1 + \mathbf{U}_2$, $\mathbf{U}_1 \in \mathsf{R}(\mathscr{T}_u), \mathbf{U}_2 \in S_m$. Therefore, we infer

$$
\mathbf{U} = \widehat{\mathscr{A}}^{-1}\mathbf{U}_1 + \widehat{\mathscr{A}}^{-1}\mathbf{U}_2
$$
, with $\widehat{\mathscr{A}}^{-1}\mathbf{U}_1 \in R(\mathscr{H}_\mu)$, and $\widehat{\mathscr{A}}^{-1}\mathbf{U}_2 \in \widehat{\mathscr{A}}^{-1}S_m$.

It then follows, in particular, that the essential spectrum $\sigma_{\rm ess}(\mathcal{M})$ of \mathcal{M} –defined as the set of μ where \mathcal{H}_{μ} is not Fredholm– has empty intersection with $(0,\infty)$.

We shall next show that the resolvent set $P(\mathcal{M})$ of \mathcal{M} has a non-empty intersection with $(0, \infty)$. Since \mathcal{H}_{μ} is Fredholm of index 0, it is enough to show that, for sufficiently large $\mu > 0$, it is $N[\mathcal{H}_{\mu}] = \{0\}$. From [\(4.4.34\)](#page-25-0), we see that the latter is equivalent to show that the equation $\mathcal{T}_{\mu}(\mathbf{U}) = 0$ has only the solution $\mathbf{U} = \mathbf{0} \ni \mathcal{X}$, for sufficiently large $\mu > 0$. From [\(4.4.11\)](#page-20-5), in turn, this means that the following problem $(\mathbf{U} \equiv (\boldsymbol{u}, \boldsymbol{\chi}))$

$$
-\mu \Delta u + \nabla p = \lambda (\partial_1 u - u_0 \cdot \nabla u - u \cdot \nabla u_0)
$$

div $u = 0$

$$
u(x) = 0, \quad x \in \partial \Omega,
$$

$$
\omega_n^2 \chi + \varpi \int_{\partial \Omega} \mathbb{T}(u, p) \cdot n = 0,
$$

has only the solution $u = \chi = 0$. To show that this is indeed the case, we begin to observe that, since $u_0, u \in L^4(\Omega)$, it follows that $(u_0 \cdot \nabla u + u \cdot \nabla u_0) \in D_0^{-1,2}$. Therefore, from [\[15,](#page-28-21) Theorem VII.7.2] we deduce, in particular,

$$
(4.4.36) \t\t\t p \in L^2(\Omega).
$$

Let ψ_R be the cut-off function introduced in Theorem [13.](#page-18-0) Testing $(4.4.35)_1$ with $\psi_R u$ and integrating by parts, we get

$$
(4.4.37) \qquad \|\psi_R^{\frac{1}{2}} \nabla \mathbf{u}\|_2^2 = -\tfrac{1}{2}\lambda \left[(\partial_1 \psi_R \mathbf{u}, \mathbf{u}) - (|\mathbf{u}|^2 \mathbf{u}_0, \nabla \psi_R) \right] - \lambda(\psi_R \mathbf{u} \cdot \nabla \mathbf{u}_0, \mathbf{u}) + (p \mathbf{u}, \nabla \psi_R).
$$

Thus, passing to the limit $R \to \infty$ in [\(4.4.37\)](#page-26-2), using [\(4.4.36\)](#page-26-1) and arguing as in the proof of Theorem [13,](#page-18-0) we obtain

$$
\mu \|\nabla \boldsymbol{u}\|_2^2 = -\lambda(\boldsymbol{u}.\nabla \boldsymbol{u}_0,\boldsymbol{u}).
$$

By Theorem [6,](#page-19-1) $(3.2.10)$ and Hölder inequality, we deduce

$$
\mu \|\nabla {\boldsymbol u}\|_2^2 \leq \lambda \|{\boldsymbol u}\|_6^2 \|\nabla {\boldsymbol u}_0\|_{\frac{3}{2}} \leq c\, \lambda \|\nabla {\boldsymbol u}\|_2^2 \|\nabla {\boldsymbol u}_0\|_{\frac{3}{2}}\,.
$$

As a result, if $\mu > c\lambda \|\nabla u_0\|_{\frac{3}{2}} := \overline{\mu}$, we conclude $u \equiv 0$, which, by $(4.4.35)_2$, implies $U \equiv 0$, namely, $P(\mathscr{M}) \cap (\overline{\mu}, \infty) \neq \emptyset$. Summarizing, we have shown that $\sigma_{\text{ess}}(\mathscr{M}) \cap (0, \infty) = \emptyset$ while $P(\mathcal{M}) \cap (\overline{\mu}, \infty) \neq \emptyset$. Therefore, the stated property about eigenvalues is a consequence of classical results in spectral theory [23. Theorem XVII.2]. results in spectral theory [\[23,](#page-28-27) Theorem XVII.2].

We now make the following assumption:

(H) the map
$$
\lambda \in U(\lambda_s) \mapsto \mathbf{u}_0(\lambda)
$$
 is of class C^2 .

This assumption, along with Remark [8,](#page-24-6) implies that $\mathscr F$ is of class C^2 in $U \times \mathcal X$. Next, by Lemma [19](#page-25-2) and [\[29,](#page-28-28) Definition 79.14], for a fixed $\lambda > 0$, we call $\mu \neq 0$ simple eigenvalue if

(4.4.36)
$$
\dim \mathsf{N}[\mu] - \lambda \mathscr{M}(\lambda)] = 1;
$$

$$
N[\mu I - \lambda \mathcal{M}(\lambda)] \cap R[I - \lambda \mathcal{M}(\lambda)] = \{0\}.
$$

As is known, $(4.4.36)_2$ can be equivalently reformulated as follows. Let \mathcal{M}^* , be the adjoint of \mathcal{M} . Then, from $(4.4.36)₁$ and Lemma [19](#page-25-2) we deduce that

$$
\dim \mathsf{N}[\mu \, \mathsf{I} - \lambda \, \mathscr{M}^*(\lambda)] = \operatorname{codim} \mathsf{R}[\mu \, \mathsf{I} - \lambda \, \mathscr{M}(\lambda)] = 1.
$$

Indicating by $\mathbf{W}_1 \in \mathcal{Z}$ and $\mathbf{W}_1^* \in \mathcal{Z}^{-1}$ two non-zero elements of respectively $\mathsf{N}[\mu \mid -\lambda \mathcal{M}(\lambda)]$ and $\mathsf{N}[\mu] - \lambda \mathcal{M}^*(\lambda)],$ [\(4.4.36\)](#page-26-1)₂ is equivalent (after suitable normalization) to

$$
(4.4.37) \t \langle \mathbf{W}_1^*, \mathbf{W}_1 \rangle = 1 ,
$$

where $\langle \cdot, \cdot \rangle$ denotes the duality pairing $\mathcal{Z} \to \mathcal{Z}^{-1}$.

The following result holds.

Lemma 20. Suppose that 1 is a simple eigenvalue of $\lambda_s \mathcal{M}(\lambda_s)$ and that [\(H\)](#page-26-3) holds. Then, there is $U_0 \subseteq U(\lambda_s)$ such that the eigenvalue $\mu = \mu(\lambda)$ of $\lambda \mathcal{M}(\lambda)$, $\lambda \in U_0$, is simple and of class C^2 . Moreover,

(4.4.38)
$$
\mu'(\lambda_s) = -\langle \mathbf{W}_1^*, (\mathcal{M}(\lambda_s) + \lambda_s \mathcal{M}'(\lambda_s))(\mathbf{W}_1) \rangle,
$$

where the prime denotes differentiation with respect to λ .

Proof. It can be obtained as a consequence of $(4.4.27)-(4.4.28)$ $(4.4.27)-(4.4.28)$ and [\[29,](#page-28-28) Corollary 79.16]. \square We are now in a position to prove the main result of this subsection.

Theorem 21. Suppose that [\(H\)](#page-26-3) holds. If $(\lambda_s, \mathbf{0})$ is a bifurcation point of [\(4.4.28\)](#page-23-4), then the equation

(4.4.39)
$$
\mathbf{W} - \lambda_s \mathscr{M}(\lambda_s)(\mathbf{W}) = \mathbf{0}
$$

has at least one non-trivial solution W_1 . Conversely, assume that 1 is a simple eigenvalue of $\lambda_s \mathcal{M}(\lambda_s)$, namely, [\(4.4.36\)](#page-26-1) holds with $\mu = 1$. Then, if $\mu'(\lambda_s) \neq 0$ (transversality condition), there exists exactly one continuous curve of nontrivial solutions to $(4.4.27)$, $(\mathbf{U}(\lambda), \lambda) \in \mathcal{X} \times U(\lambda_s)$, with $(\mathbf{U}(\lambda_s), \lambda_s) = (\mathbf{0}, \lambda_s).$

Proof. Taking into account that [\(4.4.39\)](#page-26-0) is equivalent to dim $N[\mathscr{L}_s] > 0$, the necessary con-dition follows from Corollary [17;](#page-23-0) see also Remark [7.](#page-23-5) Moreover, from $(4.4.27)$ – $(4.4.28)$ we have $D_{\mathbf{U}}\mathscr{F}(\lambda_{s},\mathbf{0})=1-\lambda_{s}\mathscr{M}(\lambda_{s}),$ which, by Lemma [19,](#page-25-2) is Fredholm of index 0. Therefore, under the assumption dim $N[1-\lambda_s\mathcal{M}(\lambda_s)]=1$, a classical bifurcation result [\[3,](#page-28-29) Theorem 4.1.12] ensures the stated sufficient property provided

$$
D_{\lambda\mathbf{u}}^{2}\mathscr{F}(\lambda_{s},\mathbf{0})\left(\mathbf{W}_{1}\right)\notin\mathsf{R}[D_{\mathbf{u}}\mathscr{F}(\lambda_{s},\mathbf{0})],
$$

or, equivalently,

(4.4.40)
$$
\langle \mathbf{W}_1^*, D^2_{\lambda} \mathbf{U} \mathscr{F}(\lambda_s, \mathbf{0}) (\mathbf{W}_1) \rangle \neq 0.
$$

By a straightforward computation, from $(4.4.27)$ – $(4.4.28)$ we show that

$$
D^2_{\lambda\mathbf{U}}\mathscr{F}(\lambda_s,\mathbf{0})(\mathbf{W}_1)=\mathscr{M}(\lambda_s)(\mathbf{W}_1)+\lambda_s\,\mathscr{M}'(\lambda_s)(\mathbf{W}_1)\,,
$$

so that, if 1 is a simple eigenvalue, by Lemma [20,](#page-26-3) condition [\(4.4.40\)](#page-27-0) is equivalent to $\mu'(\lambda_s) \neq 0$, which concludes the proof of the theorem.

Remark 9. An equivalent way of expressing [\(4.4.36\)](#page-26-1) is to say that the equation

$$
\mathbf{W} - \lambda_s \mathscr{M}(\lambda_s)(\mathbf{W}) = \mathbf{W}_1\,,
$$

has no solution. In turn, the latter is equivalent to the condition that the equation

$$
\mathscr{L}_{\lambda_s}(\textbf{W})=\mathscr{A}(\textbf{W}_1)
$$

has no solution.

Remark 10. Should the basic flow $u_0(\lambda)$ not depend on $\lambda \in U(\lambda_s)$, then [\(4.4.38\)](#page-26-3) reduces to

$$
\mu'(\lambda_s) = -\langle \mathbf{W}_1^*, \mathcal{M}(\lambda_s)(\mathbf{W}_1) \rangle \,,
$$

which, combined with with [\(4.4.39\)](#page-26-0) and [\(4.4.37\)](#page-26-2), furnishes

$$
\mu'(\lambda_s) = -\lambda_s^{-1}.
$$

As a result, under the above assumption, the transversality condition is no longer an extra requirement and becomes a consequence of the fact that $\mu = 1$ is simple.

Remark 11. Also in the light of the previous remarks, we would like to present in more explicit terms the conditions stated in Theorem [21](#page-26-0), ensuring the occurrence of bifurcation. Consider the eigenvalue problem

$$
-\mu(\lambda)\Delta u + \nabla p = \lambda (\partial_1 u - u_0(\lambda) \cdot \nabla u - u \cdot \nabla u_0(\lambda))
$$

div $u = 0$

$$
u(x) = 0, \quad x \in \partial\Omega; \quad \lim_{|x| \to \infty} u(x) = 0,
$$

$$
\omega_n^2 \chi + \varpi \int_{\partial\Omega} \mathbb{T}(u, p) \cdot n = 0.
$$

in the class $(\boldsymbol{u}, \boldsymbol{\chi}) \in X^2(\Omega) \times \mathbb{R}^3$. Then, $(\boldsymbol{u}_0(\lambda_s), \lambda_s)$ is a bifurcation point if the following conditions are met:

- (i) $\mu(\lambda_s) = 1$ and the corresponding eigenspace is one-dimensional, spanned by $(\mathbf{u}_1, \mathbf{\chi}_1)$;
- (ii) the problem

$$
-\Delta u + \nabla p - \lambda_s (\partial_1 u - u_0(\lambda_s) \cdot \nabla u - u \cdot \nabla u_0(\lambda_s)) = \Delta u_1
$$

div $u = 0$

$$
u(x) = 0, \quad x \in \partial \Omega;
$$

$$
\omega_n^2 \chi + \varpi \int_{\partial \Omega} \mathbb{T}(u, p) \cdot n = \omega_n^2 \chi_1 + \varpi \int_{\partial \Omega} \mathbb{T}(u_1, p_1) \cdot n,
$$

has no solution in the class $(\boldsymbol{u}, \boldsymbol{\chi}) \in X^2(\Omega) \times \mathbb{R}^3$; (iii) $\mu'(\lambda)$ satisfies the transversality condition.

The last requirement is automatically satisfied if $u_0(\lambda)$, $\lambda \in U(\lambda_s)$, is independent of λ .
