The non-Abelian two-dimensional Toda lattice and matrix sine-Gordon equations with self-consistent sources

Abstract

The non-Abelian two-dimensional Toda lattice and matrix sine-Gordon equations with self-consistent sources are established and solved. Two families of quasideterminant solutions are presented for the non-Abelian two-dimensional Toda lattice with self-consistent sources. By employing periodic and quasi-periodic reductions, a matrix sine-Gordon equation with self-consistent sources is constructed for the first time, for which exact solutions in terms of quasideterminants are derived.

Keyword: The non-Abelian two-dimensional Toda lattice with self-consistent sources; matrix sine-Gordon equation with self-consistent sources; quasideterminant solutions; periodic reduction.

1 Introduction

As one of the main organizing tools in noncommutative (NC) algebra, quasideterminants were first introduced by Gelfand and Retakh in [1] and have been found applications in many areas including NC symmetric functions, NC integrable systems, quantum algebra and Yangians. Quasideterminants play crucial roles in the NC soliton theory. They can be used to treat NC integrable systems in a unified way without regard to the reasons for noncommutativity and greatly simplify proofs in commutative theories as well. In particular, NC extensions of integrable systems have received much attention and various integrability has been revealed [2–14].

As one of the most notable examples, the non-Abelian two-dimensional Toda lattice (2DTL) was first studied in [15] with its Darboux transformation given in [16]. Later on,

the following generalized non-Abelian 2DTL was proposed

$$U_{n,x} + U_n V_{n+1} - V_n U_n = 0, (1.1)$$

$$V_{n,t} + \alpha_n U_{n-1} - U_n \alpha_{n+1} = 0 \tag{1.2}$$

and Darboux and binary Darboux transformations were obtained [17]. Under the transformations

$$U_n = X_n X_{n+1}^{-1}, \quad V_n = X_{n,x} X_n^{-1},$$

the generalized non-Abelian 2DTL (1.1) and (1.2) transform into

$$(X_{n,x}X_n^{-1})_t + \alpha_n X_{n-1}X_n^{-1} - X_n X_{n+1}^{-1}\alpha_{n+1} = 0.$$
(1.3)

In [18], both quasiwronskian and quasigrammian solutions were constructed for (1.3) by Darboux and binary Darboux transformations. Consequently, a matrix sine-Gordon (sG) equation together with its exact solutions in term of quasideterminants were derived as the 2-periodic reductions.

Soliton equations with self-consistent sources (SESCSs) have important applications in physics. In general, the existence of sources can result in solitary waves moving with nonconstant velocity or cause a great variety of dynamics of soliton solutions. In literature, some meaningful SESCSs haven been studied by different ways [19–24]. As far as we are concerned, the 2DTL ESCS as well as its integrability are derived in [25] by source generation method. Later on, an extended 2DTL hierarchy is obtained by its squared eigenfunction symmetries which includes the 2DTL ESCS as its special case [26]. As is well known that the 2-periodic reduction of the standard 2DTL leads to the scalar sG equation. It has been also shown that the 2-periodic reduction of the 2DTL ESCS leads to the sG equation with self-consistent sources [27]. In this paper, we are going to explore how to establish the non-Abelian 2DTL ESCS, what integrability the non-Abelian 2DTL ESCS possesses and the corresponding periodic reductions.

The paper is organized as follows. The non-Abelian 2DTL ESCS is established and solved in Section 2. A matrix sG ESCS and its exact solutions in terms of quasideterminant are derived by period reductions in Section 3. Section 4 is devoted to conclusions and discussions.

2 The non-Abelian 2DTL ESCS

In this section, we will construct and solve the non-Abelian 2DTL ESCS equation by source generation method based on the existing quasiwronskian and quasigrammian solutions of the non-Abelian 2DTL equation. Consequently, both quasiwronskian and quasigrammian solutions are presented for the non-Abelian 2DTL ESCS. The connections of the non-Abelian 2DTL ESCS with the nonlinear 2DTL ESCS derived by two different ways are clarified as well, which implies the advantage of dealing with NC integrable systems over commutative integrable systems. As for the properties of quasideterminants, one can refer to [1, 8] for details.

2.1 Quasiwronskian solutions

It has been proved that the non-Abelian 2DTL equation (1.3) has the quasiwronskian solution [18]

$$Q_n = \begin{vmatrix} \Theta_n & 0 \\ \tilde{\Theta}_n & e_N \end{vmatrix},$$

where e_i is the column vector of length N with 1 in the *i*th row and 0 elsewhere, and $\tilde{\Theta}_n = (\Theta_{n+1}, \Theta_{n+2}, \cdots, \Theta_{n+N})^T$, $\Theta_n = (\theta_{1,n}, \ldots, \theta_{N,n})$ with $\theta_{i,n}$ $(i = 1, 2, \ldots, N)$ satisfying the dispersion relations

$$(\theta_{i,n})_x = \theta_{i,n-1}, \quad (\theta_{i,n})_t = \theta_{i,n+1}.$$
 (2.1)

It is obvious that

$$\Theta_{n,x} = \Theta_{n-1}, \quad \Theta_{n,t} = \Theta_{n+1}. \tag{2.2}$$

According to the source generation procedure, we assume that

$$\theta_{i,n} = f_{i,n} + (-1)^{i-1} g_{i,n} C_i(t),$$

where $f_{i,n}$ and $g_{i,n}$ satisfy the dispersion relations (2.1) and

$$C_{i}(t) = \begin{cases} c_{i}(t), & 1 \leq i \leq K \leq N, K \in Z^{+}, \\ C_{i}, & otherwise. \end{cases}$$

Then we have

$$(\theta_{i,n})_x = \theta_{i,n-1}, \quad (\theta_{i,n})_t = \theta_{i,n+1} + (-1)^{i-1} g_{i,n} C'_i(t),$$

where $C'_i(t)$ denotes the *t*-derivative of $C_i(t)$.

Denote $h_{i,n} = (-1)^{i-1}g_{i,n}$ and $H_n = (h_{1,n}c'_1(t), h_{2,n}c'_2(t), \cdots, h_{K,n}c'_K(t), 0, \cdots, 0)$, it follows that

$$\Theta_{n,x} = \Theta_{n-1}, \quad \Theta_{n,t} = \Theta_{n+1} + H_n.$$

It is obvious that $X_n = Q_n$ no longer satisfies the non-Abelian 2DTL equation. As the expressions for other derivatives of Q_n remain the same as in the case of the non-Abelian 2DTL equation (1.3), it is sufficient to compute $(Q_{n,x}Q_n^{-1})_t$. Notice that

$$Q_{n,x} = \left(\begin{vmatrix} \Theta_{n-1} & 0 \\ \tilde{\Theta}_n & e_N \end{vmatrix} + \begin{vmatrix} \Theta_n & 0 \\ \tilde{\Theta}_n & e_1 \end{vmatrix} \begin{vmatrix} \Theta_n & 0 \\ \tilde{\Theta}_n & e_N \end{vmatrix} \right),$$

Then we have

$$(Q_{n,x}Q_n^{-1})_t = Q_n Q_{n+1}^{-1} - Q_{n-1}Q_n^{-1} + \begin{vmatrix} H_n & 0 \\ \tilde{\Theta}_n & e_1 \end{vmatrix} + \sum_{i=1}^N \begin{vmatrix} \Theta_n & 0 \\ \tilde{\Theta}_n & e_i \end{vmatrix} \begin{vmatrix} H_{n+i} & 0 \\ \tilde{\Theta}_n & e_1 \end{vmatrix} \\ - \begin{vmatrix} H_{n-1} & 0 \\ \tilde{\Theta}_{n-1} & e_1 \end{vmatrix} - \sum_{i=1}^{N-1} \begin{vmatrix} \Theta_{n-1} & 0 \\ \tilde{\Theta}_{n-1} & e_i \end{vmatrix} \begin{vmatrix} H_{n+i-1} & 0 \\ \tilde{\Theta}_{n-1} & e_1 \end{vmatrix}.$$

Further assume that $c'_i(t) = \beta_i(t)\eta_i(t)$ and introduce functions $q_{i,n}$ and $r_{i,n}$ as follows

$$q_{i,n} = \begin{vmatrix} \Theta_n & \overline{h_{i,n}} \\ \tilde{\Theta}_n & \overline{G_{i,n}} \end{vmatrix} \beta_i(t), \quad r_{i,n} = \eta_i(t) \begin{vmatrix} e_i^T & \overline{0} \\ \tilde{\Theta}_{n-1} & e_1 \end{vmatrix},$$

where $G_{i,n} = (h_{i,n+1}, h_{i,n+2}, \dots, h_{i,n+K}, 0, \dots, 0)^T$. Then we can derive the non-Abelian 2DTL ESCS, which is stated in the following proposition. One can refer to Appendix A for the proof of the proposition.

Proposition 2.1. The non-Abelian 2DTL ESCS takes the following form

$$(X_{n,x}X_n^{-1})_t + X_{n-1}X_n^{-1} - X_nX_{n+1}^{-1} = \sum_{i=1}^K (q_{i,n}r_{i,n+1} - q_{i,n-1}r_{i,n}),$$
(2.3)

$$q_{i,n,x} = X_{n,x} X_n^{-1} q_{i,n} + q_{i,n-1}, \qquad i = 1, 2, \cdots, K,$$
(2.4)

$$r_{i,n,x} = -r_{i,n}X_{n,x}X_n^{-1} - r_{i,n+1}, \qquad i = 1, 2, \cdots, K.$$
(2.5)

2.2 Quasigrammian solutions

The non-Abelian 2DTL equation has been shown to have quasigrammian solutions expressed as [18]

$$R_n = - \begin{vmatrix} \Omega_n & P_n^{\dagger} \\ \Theta_n & -I \end{vmatrix}$$

where Θ_n satisfies the same linear equations as in (2.2), $P_n = (\rho_{1,n}, \dots, \rho_{N,n})$ with $\rho_{i,n}$ satisfying the dispersion relations

$$(\rho_{i,n})_x = -\rho_{i,n+1}, \quad (\rho_{i,n})_t = -\rho_{i,n-1},$$

The potential $\Omega_n = \Omega(\Theta_n, P_n)$ satisfies the following relations

$$\Omega_{n,x} = P_{n+1}^{\dagger} \Theta_n, \quad \Omega_{n,t} = -P_n^{\dagger} \Theta_{n+1}, \quad \Omega_n - \Omega_{n-1} = -P_n^{\dagger} \Theta_n, \tag{2.6}$$

which lead to

$$\Omega_n = C_{i,j} + \int P_{n+1}^{\dagger} \Theta_n dx$$

Next we assume that $C_{i,j}$ are no longer constants, but rather

$$C_{i,j}(t) = \begin{cases} c_i(t), & i = j \text{ and } 1 \le i \le K \le N, \\ C_{i,j}, & otherwise. \end{cases}$$

Then we can obtain

$$\Omega_{n,x} = P_{n+1}^{\dagger} \Theta_n, \quad \Omega_{n,t} = C_{i,j}'(t) - P_n^{\dagger} \Theta_{n+1}, \quad \Omega_n - \Omega_{n-1} = -P_n^{\dagger} \Theta_n.$$

In this case, $X_n = R_n$ no longer satisfies the non-Abelian 2DTL equation. Since the expressions for other derivatives of R_n remain the same as in the case of the non-Abelian 2DTL equation (1.3), we only need to calculate $(R_{n,x}R_n^{-1})_t$. Notice that

$$R_n^{-1} = \begin{vmatrix} \Omega_{n-1} & P_n^{\dagger} \\ \Theta_n & \boxed{I} \end{vmatrix} = I - \Theta_n \Omega_{n-1}^{-1} P_n^{\dagger},$$

Then we get

$$(R_{n,x}R_n^{-1})_t = R_{n-1}R_n^{-1} - R_nR_{n+1}^{-1} + \sum_{i=1}^K (\Theta_n\Omega_n^{-1}c_i'(t)\Omega_n^{-1}P_{n+1}^{\dagger} - \Theta_{n-1}\Omega_{n-1}^{-1}c_i'(t)\Omega_{n-1}^{-1}P_n^{\dagger}).$$

Introduce two sets of novel functions

$$q_{i,n} = \begin{vmatrix} \Omega_n & e_i^T \\ \Theta_n & \boxed{0} \end{vmatrix} \beta_i(t), \quad r_{i,n} = \eta_i(t) \begin{vmatrix} \Omega_{n-1} & P_n^\dagger \\ e_i & \boxed{0} \end{vmatrix}$$

It can be proved that R_n , $q_{i,n}$ and $r_{i,n}$ form a set of quasigrammian solutions of the non-Abelian 2DTL ESCS. (2.3)-(2.5). One can refer to Appendix B for detailed calculations.

2.3 From the non-Abelian 2DTL ESCS to the 2DTL ESCS

Quasideterminants are closely related to determinants. In commutative setting, a quasideterminant is nothing but the ratio of two determinants. For this reason, the non-Abelian 2DTL ESCS and the corresponding quasideterminant solutions can be used to yield the nonlinear 2DTL ESCS and its determinant solutions.

In commutative setting, the non-Abelian 2DTL ESCS (2.3)-(2.5) turns into

$$(\ln X_n)_{xt} + X_{n-1}X_n^{-1} - X_nX_{n+1}^{-1} = \sum_{i=1}^K (q_{i,n}r_{i,n})_x),$$
(2.7)

$$q_{i,n,x} = (\ln X_n)_x q_{i,n} + q_{i,n-1}, \qquad i = 1, 2, \cdots, K,$$
 (2.8)

$$r_{i,n,x} = -r_{i,n}(\ln X_n)_x - r_{i,n+1}, \qquad i = 1, 2, \cdots, K.$$
(2.9)

On one hand, under the transformation

 $x \to -x, \quad t \to -t, \quad X_n \to \exp(-X_n), \quad q_{i,n} \to -q_{i,n},$

(2.7)-(2.9) becomes the nonlinear 2DTL ECSC obtained by squared eigenfunction symmetries [26]

$$(X_n)_{xt} = e^{X_n - X_{n-1}} - e^{X_{n+1} - X_n} + \sum_{i=1}^K (q_{i,n} r_{i,n})_x,$$
$$q_{i,n,x} = -X_{n,x} q_{i,n} - q_{i,n-1}, \quad i = 1, 2, \cdots, K,$$
$$r_{i,n,x} = r_{i,n} X_{n,x} + r_{i,n+1}, \qquad i = 1, 2, \cdots, K,$$

On the other hand, under the transformation

$$x \to -x$$
, $X_n = e^{-u_n}$, $q_{i,n} = -\frac{1}{\sqrt{2}}w_{i,n}e^{-u_n}$, $r_{i,n} = \frac{1}{\sqrt{2}}v_{i,n+1}e^{u_n}$,

(2.7)-(2.9) becomes the nonlinear 2DTL ESCS obtained by source generation method [25]

$$u_{n,xt} + e^{u_n - u_{n-1}} - e^{u_{n+1} - u_n} = -\frac{1}{2} \sum_{i=1}^K (w_{i,n} v_{n+2,i} e^{u_{n+1} - u_n} - w_{n-1} v_{n+1} e^{u_n - u_{n-1}}), \quad (2.10)$$

$$\frac{w_{i,n,x}}{w_{i,n}} + \frac{w_{i,n-1}}{w_{i,n}} e^{u_n - u_{n-1}} = \frac{w_{i,n+1,x}}{w_{i,n+1}} + \frac{w_{i,n}}{w_{i,n+1}} e^{u_{n+1} - u_n},$$
(2.11)

$$\frac{v_{i,n,x}}{v_{i,n}} - \frac{v_{i,n+1}}{v_{i,n}} e^{u_n - u_{n-1}} = \frac{v_{i,n+1,x}}{v_{i,n+1}} - \frac{v_{n+2,i}}{v_{i,n+1}} e^{u_{n+1} - u_n}.$$
(2.12)

It is noted that NC integrable systems can be treated in a unified way no matter what the reasons for noncommutativity are and results for NC integrable systems can produce the ones for the corresponding commutative integrable systems which reaveals the advantage of dealing with NC integrable systems rather than commutative integrable systems.

3 The matrix sG ESCS and solutions

In [18], by imposing the 2-periodic reductions on the non-Abelian 2DTL equation, the matrix sG equation and its exact solutions were derived. In this section, we shall apply periodic and quasi-periodic reductions to the non-Abelian 2DTL ESCS and its quasigrammian solutions to deduce a matrix sG ESCS as well as its exact solutions in terms of quasideterminants.

Starting from the quasigrammian solutions R_n , $q_{i,n}$ and $r_{i,n}$ given in Section 2.2, exact solutions of the non-Abelian 2DTL ESCS can be constructed as follows. For

$$(\theta_{i,n})_x = \theta_{i,n-1}, \quad (\theta_{i,n})_t = \theta_{i,n+1}, \quad (\rho_{i,n})_x = -\rho_{i,n+1}, \quad (\rho_{i,n})_t = -\rho_{i,n-1}, \quad (3.1)$$

and Ω_n is defined by (2.6). We choose the simplest non-trivial solutions of (3.1)

$$\theta_{k,n} = B_k b_k^{-n} \exp\left(b_k x + \frac{1}{b_k} t\right), \qquad \rho_{j,n} = A_j a_j^n \exp\left(-a_j x - \frac{1}{a_j} t\right),$$

where A_j and B_k are $d \times d$ matrices and then we obtain

$$\Omega_n(\theta_{k,n},\rho_{j,n}) = \left(\frac{a_j}{b_k}\right)^n \left(\delta_{j,k}C_{j,k}(t)\left(\frac{b_k}{a_k}\right)^n + \frac{A_k^t B_k a_k}{b_k - a_k}\exp\left((b_k - a_k)x + \left(\frac{1}{b_k} - \frac{1}{a_k}\right)t\right)\right).$$

The choice of $\delta_{j,k}C_{j,k}(t)$ is needed to effect the periodic reduction. Now using the invariance of a quasi-determinant to scaling of its rows and columns [1], we get

where $\xi_k = b_k x + \frac{1}{b_k} t$ and $\hat{\xi}_j = -a_j x - \frac{1}{a_j} t$. If we further set $a_k = -b_k = \lambda_k$ with λ_k being real scalars, which means that $(\frac{b_1}{a_1})^2 = \cdots = (\frac{b_N}{a_N})^2 = 1$, we find that R_n and $q_{i,n}r_{i,n+1}$ exhibit 2-periodicity with $R_{n+2} = R_n$, $q_{i,n+2}r_{i,n+3} = q_{i,n}r_{i,n+1}$. However, $q_{i,n}$ and $r_{i,n}$ are quasi-periodic with

$$q_{i,0} = \lambda_i^2 q_{i,2} = \dots = \lambda_i^{2n} q_{i,2n}, \qquad q_{i,1} = \lambda_i^2 q_{i,3} = \dots = \lambda_i^{2n} q_{i,2n+1},$$

$$r_{i,0} = \lambda_i^{-2} r_{i,2} = \dots = \lambda_i^{-2n} r_{i,2n}, \qquad r_{i,1} = \lambda_i^{-2} r_{i,3} = \dots = \lambda_i^{-2n} r_{i,2n+1}$$

Under the above assumptions, the non-Abelian 2DTL ESCS (2.3)-(2.5) transforms into

$$(X_{0,x}X_{0}^{-1})_{t} + X_{1}X_{0}^{-1} - X_{0}X_{1}^{-1} = \sum_{i=1}^{K} (q_{i,0}r_{i,1} - q_{i,1}r_{i,2}),$$

$$(X_{1,x}X_{1}^{-1})_{t} + X_{0}X_{1}^{-1} - X_{1}X_{0}^{-1} = \sum_{i=1}^{K} (q_{i,1}r_{i,2} - q_{i,0}r_{i,1}),$$

$$q_{i,0,x} = X_{0,x}X_{0}^{-1}q_{0} + \lambda_{i}^{2}q_{i,1} \qquad q_{i,1,x} = X_{1,x}X_{1}^{-1}q_{i,1} + q_{i,0},$$

$$r_{i,1,x} = -r_{i,1}X_{1,x}X_{1}^{-1} - r_{i,2}, \qquad r_{i,2,x} = -r_{i,2}X_{0,x}X_{0}^{-1} - \lambda_{i}^{2}r_{i,1}$$
(3.2)

with solutions given by

$$\begin{split} R_{0} &= - \left| \begin{pmatrix} \delta_{j,k}C_{j,k}(t) - \frac{A_{j}^{t}B_{k}\lambda_{j}}{\lambda_{j} + \lambda_{k}}\exp\left(\zeta_{j} + \zeta_{k}\right) \end{pmatrix} \begin{array}{c} (A_{j}\exp\left(\zeta_{j}\right))^{\dagger} \\ (B_{k}\exp\left(\zeta_{k}\right)) & \boxed{-I} \\ \end{array} \right|, \\ R_{1} &= - \left| \begin{pmatrix} -\delta_{j,k}C_{j,k}(t) - \frac{A_{j}^{t}B_{k}\lambda_{k}}{\lambda_{j} + \lambda_{k}}\exp\left(\zeta_{j} + \zeta_{k}\right) \end{pmatrix} \begin{array}{c} (A_{j}\exp\left(\zeta_{j}\right))^{\dagger} \\ (B_{k}\exp\left(\zeta_{k}\right)) & \boxed{-I} \\ \end{array} \right|, \\ q_{i,0} &= \left| \begin{pmatrix} \delta_{j,k}C_{j,k}(t) - \frac{A_{j}^{t}B_{k}\lambda_{k}}{\lambda_{j} + \lambda_{k}}\exp\left(\zeta_{j} + \zeta_{k}\right) \end{pmatrix} \begin{array}{c} e_{i}^{\dagger} \\ \beta_{i}, \\ (B_{k}\exp\left(\zeta_{k}\right)) & \boxed{0} \\ \end{array} \right|, \\ q_{i,1} &= \left| \begin{pmatrix} \lambda_{j} \left(-\delta_{j,k}C_{j,k}(t) - \frac{A_{j}^{t}B_{k}\lambda_{k}}{\lambda_{j} + \lambda_{k}}\exp\left(\zeta_{j} + \zeta_{k}\right) \end{pmatrix} \right) \begin{array}{c} e_{i}^{\dagger} \\ \beta_{i}, \\ (B_{k}\exp\left(\zeta_{k}\right)) & \boxed{0} \\ \end{array} \right|, \\ r_{i,1} &= \eta_{i} \\ \left| \begin{pmatrix} -\frac{1}{\lambda_{k}} \left(-\delta_{j,k}C_{j,k}(t) + \frac{A_{j}^{t}B_{k}}{\lambda_{k}(\lambda_{j} + \lambda_{k})}\exp\left(\zeta_{j} + \zeta_{k}\right) \end{pmatrix} \right) \right| \begin{array}{c} (A_{j}\exp\left(\zeta_{j}\right))^{\dagger} \\ e_{i} \\ \end{array} \right|, \\ r_{i,2} &= \eta_{i} \\ \left| \begin{pmatrix} \frac{1}{\lambda_{k}^{2}} \left(\delta_{j,k}C_{j,k}(t) + \frac{A_{j}^{t}B_{k}}{\lambda_{k}(\lambda_{j} + \lambda_{k})}\exp\left(\zeta_{j} + \zeta_{k}\right) \end{pmatrix} \right) \right| \begin{array}{c} (A_{j}\exp\left(\zeta_{j}\right))^{\dagger} \\ e_{i} \\ \end{array} \right|, \\ \hline \end{split}$$

where $\zeta_j = -\lambda_j x - \frac{1}{\lambda_j} t$. From now on, we will assume that $A_j = I$ are real and B_k is purely imaginary written as $ir_k P_k$, where r_k are real scalars. In this case, we have

$$R_0 = R_1^*, \quad q_i = q_{i,0} = \lambda_i q_{i,1}^*, \quad r_i = r_{i,1} = \lambda_i^{-1} r_{i,2}^*,$$

where * means complex conjugate. By taking $X = R_0$, (3.2) are reduced to

$$(X_x X^{-1})_t + X^* X^{-1} - X X^{*-1} = \sum_{i=1}^K (q_i r_i - q_i^* r_i^*),$$

$$q_{i,x} = X_x X^{-1} q_i + \lambda_i q_i^*,$$

$$r_{i,x} = -r_i X_x^* X^{*-1} - \lambda_i r_i^*$$
(3.3)

which we call a matrix sG ESCS henceforth. Actually, in the commutative case, by taking

$$u = -2i \log(X),$$
 $q_i = \lambda_i (\phi_i - i\psi_i),$ $r_i = i\phi_i + \psi_i,$

we have from the matrix sG ESCS (3.3) that

$$u_{xt} = 4 \sin u + 2 \sum_{i=1}^{K} (\phi_i^2 + \psi_i^2)_x,$$

$$\phi_{i,x} = \frac{1}{2} u_x \psi_i + \lambda_i \phi_i,$$

$$\psi_{i,x} = -\frac{1}{2} u_x \phi_i - \lambda_i \psi_i,$$

(3.4)

which is nothing but the sG ESCS.

Remark 3.1. It is worthy pointing out that (3.4) is equivalent to sG ESCS studied in [28]

$$u_{xt} = \sin u + 2\sum_{i=1}^{K} (\phi_i^2 + \psi_i^2)_x$$
$$\phi_{i,x} = \frac{1}{2} u_x \psi_i - \lambda_i \phi_i,$$
$$\psi_{i,x} = -\frac{1}{2} u_x \phi_i + \lambda_i \psi_i$$

under the scaling transformations

$$x \to x, \quad t \to \frac{1}{4}t, \quad \phi_i \to 2\phi_i, \quad \psi_i \to 2\psi_i, \quad \lambda_i \to -\lambda_i.$$

4 Conclusions and discussions

In this paper, we succeed in constructing and solving the non-Abelian 2DTL ESCS by generalizing the source generation procedure to NC integrable systems. Two types of quasideterminant solutions for the non-Abelian 2DTL ESCS are presented. In the case that $C_i(t)$ is independent of t, the non-Abelian 2DTL ESCS reduces to the non-Abelian 2DTL equation identically. By considering periodic and quasi-periodic reductions on the non-Abelian 2DTL ESCS and its quasigrammian solutions, a matrix sG ESCS is proposed for the first time whose exact solutions in terms of quasideterminants are presented as well. As mentioned before, sources in SESCSs can result in solitary waves moving with nonconstant velocity or cause a great variety of dynamics of soliton solutions, it is interesting to study dynamics of soliton solutions for NC versions of SESCSs.

A Proof of the Proposition 2.1

Given Q_n , $q_{i,n}$ and $r_{i,n}$ as defined in Section 2.1, we have

$$\begin{split} Q_{n,x} &= \left(\begin{vmatrix} \Theta_{n-1} & 0 \\ \tilde{\Theta}_n & e_N \end{vmatrix} + \begin{vmatrix} \Theta_n & 0 \\ \tilde{\Theta}_n & e_1 \end{vmatrix} \begin{vmatrix} \Theta_n & 0 \\ \tilde{\Theta}_n & e_N \end{vmatrix} \right), \\ (Q_{n,x}Q_n^{-1})_t &= \left(\begin{vmatrix} \Theta_n + H_{n-1} & 0 \\ \tilde{\Theta}_n & e_1 \end{vmatrix} + \sum_{i=1}^N \begin{vmatrix} \Theta_{n-1} & 0 \\ \tilde{\Theta}_n & e_i \end{vmatrix} \begin{vmatrix} \Theta_{n+i+1} + H_{n+i} & 0 \\ \tilde{\Theta}_n & e_N \end{vmatrix} \right) \begin{vmatrix} \Theta_n & 0 \\ \tilde{\Theta}_n & e_N \end{vmatrix} \\ &- \begin{vmatrix} \Theta_{n-1} & 0 \\ \tilde{\Theta}_n & e_N \end{vmatrix} \begin{vmatrix} \Theta_n & 0 \\ \tilde{\Theta}_n & e_N \end{vmatrix} \left(\begin{vmatrix} \Theta_{n+1} + H_n & 0 \\ \tilde{\Theta}_n & e_N \end{vmatrix} + \sum_{i=1}^N \begin{vmatrix} \Theta_n & 0 \\ \tilde{\Theta}_n & e_i \end{vmatrix} \begin{vmatrix} \Theta_{n+i+1} & 0 \\ \tilde{\Theta}_n & e_N \end{vmatrix} \\ &+ \sum_{i=1}^N \begin{vmatrix} \Theta_n & 0 \\ \tilde{\Theta}_n & e_i \end{vmatrix} \begin{vmatrix} H_{n+i} & 0 \\ \tilde{\Theta}_n & e_N \end{vmatrix} \right) \begin{vmatrix} \Theta_n & 0 \\ \tilde{\Theta}_n & e_N \end{vmatrix} + \begin{vmatrix} \Theta_{n+1} + H_n & 0 \\ \tilde{\Theta}_n & e_i \end{vmatrix} \\ &+ \sum_{i=1}^N \begin{vmatrix} \Theta_n & 0 \\ \tilde{\Theta}_n & e_i \end{vmatrix} \begin{vmatrix} H_{n+i} & 0 \\ \tilde{\Theta}_n & e_N \end{vmatrix} \\ &= Q_n Q_{n+1}^{-1} - Q_{n-1} Q_n^{-1} + \begin{vmatrix} H_n & 0 \\ \tilde{\Theta}_n & e_1 \end{vmatrix} + \sum_{i=1}^N \begin{vmatrix} \Theta_n & 0 \\ \tilde{\Theta}_n & e_i \end{vmatrix} \begin{vmatrix} H_{n+i} & 0 \\ \tilde{\Theta}_n & e_1 \end{vmatrix} \\ &= Q_n Q_{n+1}^{-1} - Q_{n-1} Q_n^{-1} + \begin{vmatrix} H_n & 0 \\ \tilde{\Theta}_n & e_1 \end{vmatrix} + \sum_{i=1}^N \begin{vmatrix} \Theta_n & 0 \\ \tilde{\Theta}_n & e_i \end{vmatrix} \begin{vmatrix} H_{n+i} & 0 \\ \tilde{\Theta}_n & e_1 \end{vmatrix} \\ &- \begin{vmatrix} H_{n-1} & 0 \\ \tilde{\Theta}_{n-1} & e_1 \end{vmatrix} - \sum_{i=0}^{N-1} \begin{vmatrix} \Theta_{n-1} & 0 \\ \tilde{\Theta}_{n-1} & e_i \end{vmatrix} \begin{vmatrix} H_{n+i-1} & 0 \\ \tilde{\Theta}_{n-1} & e_1 \end{vmatrix}.$$

Notice the fact that $\beta(t)$ does not affect the proof concerning (2.4), we omit $\beta(t)$

$$\begin{split} q_{i,n,x} &= \begin{vmatrix} \Theta_n & \boxed{h_{i,n}} \\ \tilde{\Theta}_n & G_{i,n} \end{vmatrix}_x = \begin{vmatrix} \Theta_{n-1} & \boxed{h_{i,n-1}} \\ \tilde{\Theta}_n & G_{i,n} \end{vmatrix} + \sum_{j=1}^N \begin{vmatrix} \Theta_n & \boxed{0} \\ \tilde{\Theta}_n & e_j \end{vmatrix} \begin{vmatrix} \Theta_{n-1+j} & \boxed{h_{i,n-1+j}} \\ \tilde{\Theta}_n & \boxed{G}_{n,i} \end{vmatrix} \\ &= \begin{vmatrix} \Theta_{n-1} & \boxed{h_{i,n-1}} \\ \tilde{\Theta}_n & G_{i,n} \end{vmatrix} + \begin{vmatrix} \Theta_n & \boxed{0} \\ \tilde{\Theta}_n & e_1 \end{vmatrix} \begin{vmatrix} \Theta_n & \boxed{h_{i,n}} \\ \tilde{\Theta}_n & G_{i,n} \end{vmatrix} \\ Q_{n,x}Q_n^{-1}q_{i,n} + q_{i,n-1} = \left(\begin{vmatrix} \Theta_{n-1} & \boxed{0} \\ \tilde{\Theta}_n & e_N \end{vmatrix} \begin{vmatrix} \Theta_n & \boxed{0} \\ \tilde{\Theta}_n & e_N \end{vmatrix}^{-1} + \begin{vmatrix} \Theta_n & \boxed{0} \\ \tilde{\Theta}_n & e_1 \end{vmatrix} \right) \begin{vmatrix} \Theta_n & \boxed{h_{i,n}} \\ \tilde{\Theta}_n & \boxed{G}_{i,n} \end{vmatrix} \\ &+ \begin{vmatrix} \Theta_{n-1} & \boxed{h_{i,n-1}} \\ \tilde{\Theta}_{n-1} & G_{i,n-1} \end{vmatrix}. \end{split}$$

By making use of the NC Jacobi identity for quasi-determinants, we can obtain

$$\begin{vmatrix} \Theta_{n-1} & \underline{h_{i,n-1}} \\ \tilde{\Theta}_n & \overline{G_{i,n}} \end{vmatrix} - \begin{vmatrix} \Theta_{n-1} & \underline{0} \\ \tilde{\Theta}_n & e_N \end{vmatrix} \begin{vmatrix} \Theta_n & \underline{0} \\ \tilde{\Theta}_n & e_N \end{vmatrix}^{-1} \begin{vmatrix} \Theta_n & \underline{h_{i,n}} \\ \tilde{\Theta}_n & \overline{G_{i,n}} \end{vmatrix} = \begin{vmatrix} \tilde{\Theta}_n & e_N & \overline{G_{i,n}} \\ \Theta_n & 0 & h_{i,n} \\ \Theta_{n-1} & 0 & \underline{h_{i,n-1}} \end{vmatrix}.$$

Notice that

$$\begin{vmatrix} \tilde{\Theta}_n & G_{i,n} & e_N \\ \Theta_n & \boxed{h_{i,n-1}} & 0 \\ \Theta_{n-1} & h_{i,n} & 0 \end{vmatrix} = \begin{vmatrix} \tilde{\Theta}_{n-1} & G_{i,n-1} & 0 \\ \Theta_{n-1} & \boxed{h_{i,n-1}} & 0 \\ \Theta_{n+1} & h_{i,n+N} & 1 \end{vmatrix} = \begin{vmatrix} \tilde{\Theta}_{n-1} & G_{i,n-1} \\ \Theta_{n-1} & \boxed{h_{i,n-1}} \end{vmatrix},$$

it is clear that (2.4) holds true. It is not difficult to prove (2.5) by noticing

$$\begin{vmatrix} e_i^T & \boxed{0} \\ \tilde{\Theta}_{n-1} & e_2 \end{vmatrix} = \begin{vmatrix} e_i^T & \boxed{0} \\ \tilde{\Theta}_{n-1} & e_1 \end{vmatrix} \begin{vmatrix} \Theta_n & \boxed{0} \\ \tilde{\Theta}_n & e_1 \end{vmatrix} + \begin{vmatrix} e_i^T & \boxed{0} \\ \tilde{\Theta}_n & e_1 \end{vmatrix},$$
(A.1)

and

$$r_{i,n,x} = \sum_{j=1}^{N} \begin{vmatrix} e_i^I & \boxed{0} \\ \widetilde{\Theta}_{n-1} & e_j \end{vmatrix} \begin{vmatrix} \Theta_{n-2+j} & \boxed{0} \\ \widetilde{\Theta}_{n-1} & e_1 \end{vmatrix} = \begin{vmatrix} e_i^t & \boxed{0} \\ \widetilde{\Theta}_{n-1} & e_1 \end{vmatrix} \begin{vmatrix} \Theta_{n-1} & \boxed{0} \\ \widetilde{\Theta}_{n-1} & e_1 \end{vmatrix} - \begin{vmatrix} e_i^T & \boxed{0} \\ \widetilde{\Theta}_{n-1} & e_2 \end{vmatrix},$$

$$r_{i,n}Q_{n,x}Q_n^{-1} + r_{i,n+1} = \begin{vmatrix} e_i^t & \boxed{0} \\ \widetilde{\Theta}_{n-1} & e_1 \end{vmatrix} \left(\begin{vmatrix} \Theta_{n-1} & \boxed{0} \\ \widetilde{\Theta}_n & e_N \end{vmatrix} \begin{vmatrix} \Theta_n & \boxed{0} \\ \widetilde{\Theta}_n & e_N \end{vmatrix}^{-1} + \begin{vmatrix} \Theta_n & \boxed{0} \\ \widetilde{\Theta}_n & e_1 \end{vmatrix} \right) + \begin{vmatrix} e_i^T & \boxed{0} \\ \widetilde{\Theta}_n & e_1 \end{vmatrix}$$

B Proof of the quasigrammian solutions

By detailed calculations, we have the following derivative formulae for R_n , $q_{i,n}$ and $r_{i,n}$ as defined in Section 2.2,

$$\begin{split} R_n^{-1} &= \begin{vmatrix} \Omega_{n-1} & P_n^{\dagger} \\ \Theta_n & \boxed{I} \end{vmatrix} = I - \Theta_n \Omega_{n-1}^{-1} P_n^{\dagger}, \\ (R_{n,x} R_n^{-1})_t &= I - \Theta_n \Omega_{n-1}^{-1} P_n^{\dagger} + \Theta_{n-1} \Omega_{n-1}^{-1} P_{n-1}^{\dagger} - \Theta_{n-1} \Omega_{n-1}^{-1} P_{n-1}^{\dagger} \Theta_n \Omega_{n-1}^{-1} P_n^{\dagger} \\ &- I + \Theta_{n+1} \Omega_n^{-1} P_{n+1}^{\dagger} + \Theta_n^{-1} \Omega_n^{-1} P_n^{\dagger} + \Theta_n \Omega_n^{-1} P_n^{\dagger} \Theta_{n+1} \Omega_n^{-1} P_{n+1}^{\dagger} \\ &+ \sum_{i=1}^K (\Theta_n \Omega_n^{-1} c_i' \Omega_n^{-1} P_{n+1}^{\dagger} - \Theta_{n-1} \Omega_{n-1}^{-1} c_i' \Omega_{n-1}^{-1} P_n^{\dagger}), \\ R_{n-1} R_n^{-1} &= I - \Theta_n \Omega_{n-1}^{-1} P_n^{\dagger} + \Theta_{n-1} \Omega_{n-1}^{-1} P_{n-1}^{\dagger} - \Theta_{n-1} \Omega_{n-1}^{-1} P_{n-1}^{\dagger} \Theta_n \Omega_{n-1}^{-1} P_n^{\dagger}, \\ R_n R_{n+1}^{-1} &= I - \Theta_{n+1} \Omega_n^{-1} P_{n+1}^{\dagger} - \Theta_n^{-1} \Omega_n^{-1} P_n^{\dagger} - \Theta_n \Omega_n^{-1} P_n^{\dagger} \Theta_{n+1} \Omega_n^{-1} P_{n+1}^{\dagger}, \\ q_{i,n,x} &= \begin{vmatrix} \Omega_n & e_i \\ \Theta_n & \boxed{\Theta} \end{vmatrix}_x = -(\Theta_n \Omega_n^{-1} e_i)_x = -\Theta_{n-1} \Omega_n^{-1} e_i + \Theta_n \Omega_n^{-1} P_{n+1}^{\dagger} \Theta_n \Omega_n^{-1} e_i, \\ R_{n,x} R_n^{-1} q_{i,n} &= \Theta_n \Omega_n^{-1} P_{n+1}^{\dagger} \Theta_n \Omega_n^{-1} e_i - \Theta_{n-1} \Omega_{n-1}^{-1} P_n^{\dagger} \Theta_n \Omega_n^{-1} e_i, \\ r_{i,n,x} &= \begin{vmatrix} \Omega_{n-1} & P_n^{\dagger} \\ \Theta_n & \boxed{\Theta} \end{vmatrix}_x = -(e_i^{\dagger} \Omega_{n-1}^{-1} P_n^{\dagger})_x = e_i^{\dagger} \Omega_{n-1}^{-1} P_{n+1}^{\dagger} - e_i^{\dagger} \Omega_{n-1}^{-1} P_n^{\dagger}, \\ r_{i,n,x} R_n^{-1} &= -e_i^{\dagger} \Omega_{n-1}^{-1} P_n^{\dagger} \Theta_n \Omega_n^{-1} P_{n+1}^{\dagger} + e_i^{\dagger} \Omega_{n-1}^{-1} P_n^{\dagger} \Theta_{n-1} \Omega_{n-1}^{-1} P_n^{\dagger}, \\ r_{i,n} R_{i,n,x} R_n^{-1} &= -e_i^{\dagger} \Omega_{n-1}^{-1} P_n^{\dagger} \Theta_n \Omega_n^{-1} P_{n+1}^{\dagger} + e_i^{\dagger} \Omega_{n-1}^{-1} P_n^{\dagger} \Theta_{n-1} \Omega_{n-1}^{-1} P_n^{\dagger}, \\ = e_i^{\dagger} \Omega_{n-1}^{-1} P_n^{\dagger} \Theta_n \Omega_n^{-1} P_{n+1}^{\dagger} + e_i^{\dagger} \Omega_{n-1}^{-1} P_n^{\dagger} \Theta_{n-1} \Omega_{n-1}^{-1} P_n^{\dagger}, \\ \end{cases}$$

which are sufficient to prove that R_n , $q_{i,n}$ and $r_{i,n}$ provide quasigrammian solutions of the non-Abelian 2DTL ESCS.
