# Takagi-van der Waerden functions in metric spaces and its Lipschitz derivatives<sup>\*</sup>

## Abstract

We introduce the Takagi-van der Waerden function with parameters a > b > 0by setting  $f_{a,b}(x) = \sum_{n=1}^{\infty} b^n d(x, S_n)$ , where  $S_n$  is a maximal  $\frac{1}{a^n}$ -separated set in a metric space X without isolated points. So, if  $X = \mathbb{R}$  and  $S_n = \frac{1}{a^n}\mathbb{Z}$  then  $f_{2,1}$  is the Takagi function and  $f_{10,1}$  is the van der Waerden function which are the famous examples of nowhere differentiable functions. Then we prove that the big Lipschitz derivative  $\text{Lip}f_{a,b} = +\infty$  if a > b > 2. Moreover, if X is a normed space then the little Lipschitz derivative  $\text{lip}f_{a,b} = +\infty$  for large enough a > b. Thus, we prove that for any open set A in a metric (normed) space X there exists a continuous function f such that  $\text{Lip}f(x) = +\infty$  (and  $\text{lip}f(x) = +\infty$ ) exactly on A.

### 1. Introduction

The classical Rademacher theorem [6, Theorem 3.2] asserts that every Lipschitz mapping  $f: \mathbb{R}^m \to \mathbb{R}^n$  is differentiable almost everywhere. Actually, Rademacher's result [12, Satz I] and its generalization [14] concern the two-dimensional case but they are applicable not only for Lipschitz functions. In particular, the Stepanoff theorem [14, Satz] asserts that a continuous function f is almost everywhere differentiable on the complement of the set  $L^{\infty}(f) = \left\{ x : \operatorname{Lip} f(x) = \infty \right\} \text{ where } \operatorname{Lip} f(x) = \limsup_{u \to x} \frac{1}{\|u - x\|} \left| f(u) - f(x) \right|$ is the, so called, big Lipschitz derivative. Malý [9] gave a simple proof of the Stepanoff theorem for a function  $f: X \to \mathbb{R}^n$ , where  $X \subseteq \mathbb{R}^m$ . Besides, there are many generalizations of the Rademacher theorem for Banach spaces (see, for example, [8, 10]). If we consider the *little Lipschitz* derivative  $\lim_{r \to 0} \inf_{\|u-x\| < r} \frac{1}{r} |f(u) - f(x)|$  instead of  $\lim_{r \to 0} f$  then f need not to be almost everywhere differentiable on the complement of  $\ell^{\infty}(f) = \{x : \lim f(x) = \infty\}$  (see [2, Theorem 1.4]). It is well-known that every differentiable function is *pointwise Lipschitz* (that is  $\operatorname{Lip} f < +\infty$ ). But  $C^1$ -functions have a stronger property. Every such function is *locally Lipschitz*, that is  $\operatorname{Lip} f(x) = \limsup_{u,v \to 0} \frac{1}{\|u-v\|} |f(u) - f(v)| < +\infty$  for any x. So, the set  $\mathbb{L}^{\infty}(f) = \{x : \mathbb{L}ip = \infty\}$  is also interesting for us.

In this paper we deals with the following general problem.

**Problem 1** ( $\ell$ -*L*- $\mathbb{L}$ -*problem*). Let *X* be a metric space. For which sets  $A, B, C \subseteq X$  does there exists a continuous function  $f: X \to \mathbb{R}$  such that  $\ell^{\infty}(f) = A, L^{\infty}(f) = B$  and  $\mathbb{L}^{\infty}(f) = C$ ?

Also we may consider some partial versions of this problem by omitting one or two of the sets  $\ell^{\infty}(f)$ ,  $L^{\infty}(f)$  and  $\mathbb{L}^{\infty}(f)$ . For example, the  $\ell$ -problem means the description of the set  $\ell^{\infty}(f)$  for a continuous function f; the  $\ell$ -Lproblem means the description of the sets  $\ell^{\infty}(f)$  and  $L^{\infty}(f)$  and so on. In the case where  $X = \mathbb{R}$  the L-problem was solved in [4, Theorem 3.35 and Lemma 2.4] where the authors proved that A has the property  $A = L^{\infty}(f)$ (even  $A = \ell^{\infty}(f) = L^{\infty}(f)$ ) for some continuous function f if and only if Ais a  $G_{\delta}$ -set. Moreover, they proved in [4, Theorem 3.1] that for any  $F_{\sigma}$ -set Athere is a continuous function f with  $\ell^{\infty}(f) = A$ . But the obvious necessary condition is that  $\ell^{\infty}(f)$  is  $F_{\sigma\delta}$ . So, the  $\ell$ -problem is still open even for  $\mathbb{R}$ . Hanson [7] solved  $\ell$ -L-problem in the case where  $A = \ell^{\infty}(f) = \emptyset$ . Another partial answer to the  $\ell$ -problem one can find in the recent paper [11] where the author proved that for any  $F_{\sigma\delta}$ -set  $A \subseteq \mathbb{R}$  of Lebesgue measure zero the is an increasing absolutely continuous function  $f \colon \mathbb{R} \to \mathbb{R}$  such that  $\ell^{\infty}(f) = A$ .

**Problem 2** (lip-Lip-Lip-*problem*). Let X be a metric space. For which functions  $u, v, w: X \to \mathbb{R}$  does there exists a continuous function  $f: X \to \mathbb{R}$  such that lip f = u, Lip f = v and Lip f = w?

Of course, we may omit some of the functions  $\lim f$ ,  $\lim f$ ,  $\lim f$ ,  $\lim f$  and consider simpler versions of the previous problem like  $\lim$ -problem,  $\lim$ -Lip-problem and so on. In [3] the authors solved the lip-problem for a function  $u = \mathbf{1}_E$  where  $E \subseteq \mathbb{R}$  and characterized the, so called,  $\lim 1$  subsets of  $\mathbb{R}$ .

As we have seen, the main results in this direction concern to the case  $X = \mathbb{R}$ . Therefore, we are going to extend some of the previous results to general metric spaces. Our approach to this problem is based on a generalization of the Takagi-van der Waerden function to a metric space. The *classical* Takagi-van der Waerden function of type a > 1 (see, for example, [1]) is, by definition, the function  $f_a(x) = \sum_{n=1}^{\infty} d\left(x, \frac{1}{a^n}\mathbb{Z}\right)$ , where  $d(x, E) = \inf_{y \in E} |x - y|$  for any  $x \in \mathbb{R}$  and  $E \subseteq \mathbb{R}$ . In the case a = 2 or a = 10 we obtain two famous examples of nowhere differentiable functions which are constructed independently by Takagi and van der Waerden. We replace the set  $\frac{1}{a^n}\mathbb{Z}$  to a maximal  $\frac{1}{a^n}$ -separated set  $S_n$  in a metric space X, add a parameter b < a and define a Takagi-van der Waerden function of type (a,b) as  $f_{a,b}(x) = \sum_{n=1}^{\infty} b^n d(x, S_n)$ ,  $x \in X$ . Then we prove that Lip  $f_{a,b} = +\infty$  if a > b > 2 and X does not have an isolated point. To calculate the little Lipschitz derivatives we need some special property of o metric space. We introduce the notion of the defect D(X) of a metric space X such that, for example, D(X) = 1 for an arbitrary normed space X. The we prove that if D(X) > 0 then there are a > b > 1such that lip  $f = +\infty$ . So, in the last section we give a partial answer to the  $\ell$ -L-L-problem if D(X) > 0, A = B is open and  $C = \overline{A}$ .

#### 2. Lipschitz derivatives

Let X be a metric space,  $a \in X$  and  $\varepsilon > 0$ . We always denote the metric on X by  $| \cdot - \cdot |_X$  and

$$B(a,\varepsilon) = B_X(a,\varepsilon) = \{x \in X : |x-a|_X < \varepsilon\},\$$
  
$$B[a,\varepsilon] = B_X[a,\varepsilon] = \{x \in X : |x-a|_X \le \varepsilon\}.$$

**Definition 1.** Let X and Y be metric spaces,  $f : X \to Y$  be a function,  $x \in X$ , E be a nonempty subset of X and r > 0. Denote

- $||f||_{\text{lip}} = \sup_{u \neq v \in X} \frac{1}{|u-v|_X} |f(u) f(v)|_Y$
- $\operatorname{Lip}^r f(x) = \left\| f|_{B(x,r)} \right\|_{\operatorname{lip}} = \sup_{u \neq v \in B(x,r)} \frac{1}{|u-v|_X} \left| f(u) f(v) \right|_Y$
- $\operatorname{Lip} f(x) = \inf_{r>0} \operatorname{Lip}^r f(x) = \limsup_{u,v \to x} \frac{1}{|u-v|_X} |f(u) f(v)|_Y$
- $\operatorname{Lip}^{r} f(x) = \sup_{u \in B(x,r)} \frac{1}{r} |f(u) f(x)|_{Y}$
- $\operatorname{Lip} f(x) = \limsup_{r \to 0^+} \operatorname{Lip}^r f(x);$
- $\lim_{r \to 0^+} \operatorname{Lip}^r f(x);$
- $\operatorname{Lip}_r f(x) = \sup_{0 < \varrho < r} \operatorname{Lip}^{\varrho} f(x);$
- $\lim_{r \to 0} f(x) = \inf_{0 < \varrho < r} \operatorname{Lip}^{r} f(x);$

The Lipschitz constant of f is, by definition, the number  $||f||_{\text{lip}}$ . The functions Lip f, Lip f and lip f are called the *local*, *big and little Lipschitz derivative* respectively.

Obviously, if Y is a normed space then  $\|\cdot\|_{\text{lip}}$  is an extended seminorm on  $Y^X$  in the sense [13]. Moreover,  $\|\cdot\|_{\text{lip}}$  is a norm on the space all Lipschitz functions  $f: X \to Y$  vanishing at some fixed point in X.

Some authors (see, for example, [7, 3, 4]) define Lip f and lip f using the function

$$\operatorname{Lip}_{+}^{r} f(x) = \sup_{u \in B[x,r]} \frac{1}{r} |f(u) - f(x)|_{Y}, \ x \in X, \ r > 0,$$

instead of the function  $\operatorname{Lip}^r f$ . In the case where X is a normed space we have that  $B[x,r] = \overline{B(x,r)}$ . Therefore,  $\operatorname{Lip}^r f(x) = \operatorname{Lip}^r_+ f(x)$  for a continuous function f. But the previous equality does not hold for the discrete metric on X, non-constant f and r = 1. On the other hand, for an arbitrary metric space X,  $x \in X$  and r > 0 we have that

$$r \operatorname{Lip}^{r} f(x) = \sup_{u \in B(x,r)} |f(u) - f(x)|_{Y}$$
$$= \sup_{0 < \varrho < r} \sup_{u \in B(x,\varrho)} |f(u) - f(x)|_{Y}$$
$$= \sup_{0 < \varrho < r} \varrho \operatorname{Lip}^{\varrho} f(x).$$

Therefore,

$$\varrho \operatorname{Lip}^{\varrho} f(x) \leq \sup_{u \in B[x,\varrho]} \left| f(u) - f(x) \right|_{Y} = \varrho \operatorname{Lip}^{\varrho}_{+} f(x) \leq r \operatorname{Lip}^{r} f(x)$$

for any  $0 < \rho < r$  and  $\lim_{\rho \to r^-} \rho \operatorname{Lip}^{\rho} f(x) = r \operatorname{Lip}^{r} f(x)$ . Consequently,

$$\lim_{\varrho \to r^-} \operatorname{Lip}_+^{\varrho} f(x) = \operatorname{Lip}_r^r f(x) \le \operatorname{Lip}_+^r f(x)$$

for any r > 0. Thus, we can easily prove that the following assertions for any metric spaces X and Y,  $f : X \to Y$  and  $x \in X$ :

$$\operatorname{Lip} f(x) = \limsup_{r \to 0^+} \operatorname{Lip}_{+}^{r} f(x) \text{ and } \operatorname{lip} f(x) = \liminf_{r \to 0^+} \operatorname{Lip}_{+}^{r} f(x), \quad (1)$$

$$\operatorname{Lip}_{r} f(x) = \sup_{0 < |u-x|_{X} < r} \frac{1}{|u-x|_{X}} \left| f(u) - f(x) \right|_{Y} \text{ for any } r > 0,$$
(2)

$$\operatorname{Lip} f(x) = \inf_{r>0} \operatorname{Lip}_r f(x) = \limsup_{u \to x} \frac{1}{|u-x|_X} |f(u) - f(x)|_Y,$$
(3)

$$\lim_{r>0} f(x) = \sup_{r>0} \lim_{r>0} f(x), \tag{4}$$

$$\operatorname{Lip}_{r} f(x) \le \operatorname{Lip}_{r'} f(x) \text{ and } \operatorname{lip}_{r} f(x) \ge \operatorname{lip}_{r'} f(x) \text{ if } 0 < r < r', \qquad (5)$$

$$\lim_{r} f(x) \le \operatorname{Lip}_{r} f(x) \le \operatorname{Lip}^{r} f(x) \text{ for any } r > 0, \tag{6}$$

$$\lim f(x) \le \operatorname{Lip} f(x) \le \operatorname{Lip} f(x).$$

**Definition 2.** Let X and Y be metric spaces and  $\gamma \ge 0$ . A function  $f: X \to Y$  is called

- $\gamma$ -Lipschitz if  $||f||_{\text{lip}} \leq \gamma$ ;
- Lipschitz if  $||f||_{\text{lip}} < \infty$ ;
- locally Lipschitz if  $\operatorname{Lip} f < \infty$ .

- pointwise Lipschitz if  $\operatorname{Lip} f < \infty$ ;
- weakly pointwise Lipschitz if  $\lim f < \infty$ .

# Denote

- $\mathbb{L}(f) = \{x \in X : \operatorname{Lip} f(x) < \infty\};$
- $\mathbb{L}^{\infty}(f) = \{x \in X : \mathbb{L}ip f(x) = \infty\} = X \setminus \mathbb{L}(f);$
- $L(f) = \left\{ x \in X : \operatorname{Lip} f(x) < \infty \right\};$
- $L^{\infty}(f) = \{x \in X : \operatorname{Lip} f(x) = \infty\} = X \setminus L(f);$
- $\ell(f) = \{x \in X : \lim f(x) < \infty\};$
- $\ell^{\infty}(f) = \left\{ x \in X : \lim f(x) = \infty \right\} = X \setminus \ell(f);$

The inequalities (7) yield the next assertion.

**Proposition 2.1.** Let X and Y be a metric space,  $f : X \to Y$  be a function. Then  $\mathbb{L}(f) \subseteq L(f) \subseteq \ell(f)$  and  $\ell^{\infty}(f) \subseteq L^{\infty}(f) \subseteq \mathbb{L}^{\infty}(f)$ .

# 3. Classification of the Lipschitz derivatives and pairs of Hahn of second class

Now we pass to the investigation of the type semicontinuity of Lipschitz derivatives of continuous functions. In [4] semicontinuity of Lipschitz derivatives of a continuous function  $f : \mathbb{R} \to \mathbb{R}$  was obtained from the continuity of Lip<sup>r</sup> f. But in the general situation this function need not be continuous. Therefore, we prove semicontinuity of Lipschitz derivatives directly by the definitions.

**Definition 3.** Let X be a topological space and  $f, g: X \to \overline{\mathbb{R}}$ . We say that

- f is lower semicontinuous if  $f^{-1}((\gamma; +\infty))$  is an open set for any  $\gamma \in \overline{\mathbb{R}}$ ;
- f is upper semicontinuous if  $f^{-1}([-\infty; \gamma))$  is an open set for any  $\gamma \in \overline{\mathbb{R}}$ ;
- f is  $F_{\sigma}$ -lower semicontinuous if  $f^{-1}((\gamma; +\infty))$  is an  $F_{\sigma}$ -set for any  $\gamma \in \overline{\mathbb{R}}$ ;

- f is  $F_{\sigma}$ -upper semicontinuous if  $f^{-1}([-\infty;\gamma))$  is an  $F_{\sigma}$ -set for any  $\gamma \in \overline{\mathbb{R}}$ ;
- (f,g) is a pair of Hahn if  $f \leq g$ , f is upper semicontinuous and g is lower semicontinuous;
- (f,g) is an  $F_{\sigma}$ -pair of Hahn if  $f \leq g$ , f is  $F_{\sigma}$ -lower semicontinuous and g is  $F_{\sigma}$ -upper semicontinuous;

**Proposition 3.1.** Let X be a topological space,  $f : X \to \mathbb{R}$  be an  $(F_{\sigma})$ -upper semicontinuous,  $g : X \to \overline{\mathbb{R}}$  be an  $(F_{\sigma})$ -lower semicontinuous and  $\gamma \in \overline{\mathbb{R}}$ . Then  $f^{-1}([-\infty, \gamma])$ ,  $g^{-1}([\gamma, +\infty])$  are  $G_{\delta}$ -sets (resp.  $F_{\sigma\delta}$ -sets) and  $f^{-1}((\gamma, +\infty))$ ,  $g^{-1}([-\infty, \gamma))$  are  $F_{\sigma}$ -sets (resp.  $G_{\delta\sigma}$ -sets).

Proof. Let  $\gamma < +\infty$  and  $\gamma_n \downarrow \gamma$ . Since  $f^{-1}([\gamma_n; +\infty])$  are closed (resp.  $G_{\delta}$ -set), we conclude that  $f^{-1}((\gamma; +\infty]) = \bigcup_{n=1}^{\infty} f^{-1}([\gamma_n; +\infty])$  is  $F_{\sigma}$ -sets (resp.  $G_{\delta\sigma}$ -sets). The proof of the rest assertions is analogical.

**Proposition 3.2.** Let X be a topological space,  $f_n : X \to \overline{\mathbb{R}}$  be an upper (lower) semicontinuous function for any  $n \in \mathbb{N}$  and  $f : X \to \overline{\mathbb{R}}$  be a function such that  $f(x) = \sup_{n \in \mathbb{N}} f_n(x)$  (resp.  $f(x) = \inf_{n \in \mathbb{N}} f_n(x)$ ) for any  $x \in X$ . Then fis an  $F_{\sigma}$ -lower (resp.  $F_{\sigma}$ -upper) semicontinuous function.

Proof. Let  $f(x) = \sup_{n \in \mathbb{N}} f_n(x)$  and  $f_n$ 's are upper semicontinuous. Consider  $\gamma < +\infty$ . Then  $f_n^{-1}((\gamma + \infty))$  is an  $F_{\sigma}$ -set by Proposition 3.2. Consequently,  $f^{-1}((\gamma, +\infty)) = \bigcup_{n=1}^{\infty} f_n^{-1}((\gamma + \infty))$  is an  $F_{\sigma}$ -set as well. Thus, f is  $F_{\sigma}$ -lower semicontinuous. The proof of the second case is analogical.  $\Box$ 

**Proposition 3.3.** Let X and Y be a metric space,  $f : X \to Y$  be a continuous function and r > 0. Then

- (i)  $\operatorname{Lip}_r f: X \to [0; +\infty]$  is a lower semicontinuous function;
- (ii)  $\lim_r f: X \to [0; +\infty]$  is an upper semicontinuous function;
- (*iii*)  $(\lim_{r} f, \lim_{r} f)$  is a pair of Hahn (of the first class);
- (iv) Lip  $f: X \to [0; +\infty]$  is an  $F_{\sigma}$ -upper semicontinuous function;

- (v) lip  $f: X \to [0; +\infty]$  is a  $F_{\sigma}$ -lower semicontinuous function;
- (vi)  $(\lim f, \lim f)$  is an  $F_{\sigma}$ -pair of Hahn;
- (vii)  $\operatorname{Lip} f: X \to [0; +\infty]$  is an upper semicontinuous function.
- *Proof.* (i). Fix r > 0. Let  $x_0 \in X$  and  $\gamma < \operatorname{Lip}_r f(x_0)$ . Then

$$\sup_{\varrho < r} \operatorname{Lip}^{\varrho} f(x_0) = \operatorname{Lip}_r f(x_0) > \gamma.$$

So, there is  $\rho < r$  such that  $\operatorname{Lip}^{\rho} f(x_0) > \gamma$ . Pick  $\gamma_1$  such that  $\gamma < \gamma_1 < \operatorname{Lip}^{\rho} f(x_0)$ . Then we chose  $\rho_1$  such that  $\rho < \rho_1 < r$  and  $\gamma \rho_1 < \gamma_1 \rho$ . Therefore,

$$\sup_{u \in B(x_0,\varrho)} \left| f(u) - f(x_0) \right|_X = \varrho \operatorname{Lip}^{\varrho} f(x_0) > \gamma_1 \varrho.$$

Thus, there is  $u \in B(x_0, \varrho)$  with

$$\left\|f(u) - f(x_0)\right\|_X > \gamma_1 \varrho.$$

By the continuity of f at  $x_0$  there exists  $\delta > 0$  such that  $\rho + \delta < \rho_1$  and

$$|f(x) - f(x_0)|_X < \gamma_1 \varrho - \gamma \varrho_1 \quad \text{for any} \quad x \in U = B(x_0, \delta)$$

Consider  $x \in U$ . Then

$$|u - x|_X \le |u - x_0|_X + |x_0 - x|_X < \varrho + \delta < \varrho_1,$$

and, so,  $u \in B(x, \rho_1)$ . Consequently,

$$|f(u) - f(x)|_X \ge |f(u) - f(x_0)|_X - |f(x) - f(x_0)|_X > \gamma_1 \varrho - (\gamma_1 \varrho - \gamma \varrho_1) = \gamma \varrho_1.$$

Hence,  $\operatorname{Lip}^{\varrho_1} f(x) > \gamma$ . But  $0 < \varrho_1 < r$ . Therefore,  $\operatorname{Lip}_r f(x) > \gamma$  for any  $x \in U$ . Thus,  $\operatorname{Lip}_r f$  is lower semicontinuous at  $x_0$ .

(*ii*). Fix r > 0. Let  $x_0 \in X$  and  $\gamma > \lim_r f(x_0)$ . Then

$$\inf_{\varrho < r} \operatorname{Lip}^{\varrho} f(x_0) = \operatorname{lip}_{\varepsilon} f(x_0) < \gamma.$$

So, there is  $\rho < r$  such that  $\operatorname{Lip}^{\rho} f(x_0) < \gamma$ . Pick  $\gamma_1$  such that  $\operatorname{Lip}^{\rho} f(x_0) < \gamma_1 < \gamma$ . Then we chose  $\rho_1$  such that  $0 < \rho_1 < \rho$  and  $\gamma \rho_1 > \gamma_1 \rho$ . Therefore,

$$\sup_{u \in B(x_0,\varrho)} \left| f(u) - f(x_0) \right|_X = \varrho \operatorname{Lip}^{\varrho} f(x_0) < \gamma_1 \varrho.$$

Then

$$|f(u) - f(x_0)|_X < \gamma_1 \varrho$$
 for any  $u \in B(x_0, \varrho)$ .

By the continuity of f at  $x_0$  there exists  $\delta > 0$  such that  $\rho_1 + \delta < \rho$  and

$$|f(x) - f(x_0)|_X < \gamma \varrho_1 - \gamma_1 \varrho$$
 for any  $x \in U = B(x_0, \delta)$ .

Consider  $x \in U$  and  $u \in B(x, \varrho_1)$ . Then

$$|u - x_0|_X \le |u - x|_X + |x - x_0|_X < \varrho_1 + \delta < \varrho,$$

and so,  $u \in B(x_0, \varrho)$ . Therefore,

$$|f(u) - f(x)|_{X} \le |f(u) - f(x_{0})|_{X} + |f(x_{0}) - f(x)|_{X} < \gamma_{1}\varrho + (\gamma_{0} - \gamma_{1}\varrho) = \gamma_{0}\varrho_{1}$$

Thus,  $\frac{1}{\varrho_1} |f(u) - f(x)|_X \leq \gamma$  for any  $u \in B(x, \varrho_1)$ . Hence,  $\operatorname{Lip}^{\varrho_1} f(x) \leq \gamma$ . But  $0 < \varrho_1 < r$ . Therefore,  $\operatorname{lip}_r f(x) \leq \gamma$  for any  $x \in U$ . Thus,  $\operatorname{lip}_r f$  is upper semicontinuous at  $x_0$ .

(iii). It is implied from (i) and (ii).

(iv), (v), (vi). By (3), (4) and (5) we conclude that  $\operatorname{Lip}^{\frac{1}{n}} f(x) \downarrow \operatorname{Lip} f(x)$ and  $\operatorname{lip}^{\frac{1}{n}} f(x) \uparrow \operatorname{lip} f(x)$  for any  $x \in X$ . Thus, the needed assertions is implied from (i), (ii) and Proposition 3.2.

(vii). Fix  $x_0 \in X$  and  $\gamma > \operatorname{Lip} f(x_0)$ . Since  $\operatorname{Lip} f(x_0) = \inf_{r>0} \operatorname{Lip}^r f(x_0)$ , there exists r > 0 such that  $\operatorname{Lip}^r f(x_0) < \gamma$ . Set  $\rho = \frac{r}{2}$  and consider  $ax \in B(x_0, \rho)$ . Then  $B(x, \rho) \subseteq B(x, r)$ . Consequently,

$$\begin{split} \operatorname{Lip} f(x) &\leq \operatorname{Lip}^{\varrho} f(x) = \sup_{u \neq v \in B(x,\varrho)} \frac{1}{|u-v|_X} \big| f(u) - f(v) \big|_Y \\ &\leq \sup_{u \neq v \in B(x_0,r)} \frac{1}{|u-v|_X} \big| f(u) - f(v) \big|_Y = \operatorname{Lip}^r f(x_0) < \gamma \end{split}$$

and, hence,  $\operatorname{Lip} f$  is upper semicontinuous.

Proposition 3.1 and 3.3 yield the following assertions.

**Proposition 3.4.** Let X and Y be a metric space,  $f : X \to Y$  be a continuous function,  $x \in X$ ,  $\varepsilon > 0$  and  $\gamma \ge 0$ . Then

- (i) L(f) is an  $F_{\sigma}$ -set;
- (ii)  $L^{\infty}(f)$  is a  $G_{\delta}$ -set;

- (iii)  $\ell(f)$  is a  $G_{\delta\sigma}$ -set;
- (iv)  $\ell^{\infty}(f)$  is an  $F_{\sigma\delta}$ -set;
- (v)  $\mathbb{L}(f)$  is an open set;
- (vi)  $\mathbb{L}^{\infty}(f)$  is a closed set;

#### 4. Takagi-van der Waerden functions for general metric spaces

**Definition 4.** Let X be a metric space and  $\varepsilon > 0$ . A set  $S \subseteq X$  is called

- $\varepsilon$ -separated in X if for any distinct point  $x, y \in S$  we have  $|x y|_X \ge \varepsilon$ ;
- maximal  $\varepsilon$ -separated if it is  $\varepsilon$ -separated and for any  $\varepsilon$ -separated set T in X such that  $S \subseteq T$  we have S = T;
- $\varepsilon$ -dense if for any  $x \in X$  there is  $s \in S$  with  $|x s|_X < \varepsilon$ .

**Proposition 4.1.** Let X be a metric space and  $\varepsilon > 0$ . Then

- (i) for any  $\varepsilon$ -separated set  $S_0$  there is a maximal  $\varepsilon$ -separated set S with  $S_0 \subseteq S$ ;
- (ii) for any a > 1 there is an increasing sequence  $(S_n)_{n=0}^{\infty}$  of maximal  $\frac{1}{a^n}$ -separated sets  $S_n$  in X.
- (iii) an  $\varepsilon$ -separated set S is maximal  $\varepsilon$ -separated if and only if S is  $\varepsilon$ -dense;
- (iv) for any  $\varepsilon$ -dense set S (in particular, for any maximal  $\varepsilon$ -separated set) we have that  $d(x, S) < \varepsilon$  for any  $x \in X$  and the function  $d(\cdot, S)$  is 1-Lipschitz.

*Proof.* Part (i) can be deduced immediately from the Teichmüller-Tukey lemma [5, p.9]. Add then we obtain (ii) by induction. Part (iii) can be obtained by standard considerations of maximality. Part (iv) implies from the definitions and (ii).

**Definition 5.** Let X be a metric space and a > b > 0. A function  $f : X \to \mathbb{R}$  is called a Takagi-van der Waerden function of type (a, b) (or TW-function

of type (a, b) in short) if there exist a sequence of maximal  $\frac{1}{a^n}$ -separated sets  $S_n$  such that

$$f(x) = \sum_{n=0}^{\infty} b^n \varphi_n(x)$$
, where  $\varphi_n(x) = d(x, S_n)$ ,  $x \in X$ .

Moreover, if  $S_{n+1} \subseteq S_n$  for any n, then f is called *TW*-function of monotonic type (a, b). The *n*-th partial sum and the *n*-th remainder of f is defined as

$$s_n(x) = \sum_{k=0}^{n-1} b^k \varphi_k(x), \quad r_n(x) = \sum_{k=n}^{\infty} b^k \varphi_k(x), \quad x \in X.$$

In the case  $S_n = \frac{1}{a^n} \mathbb{Z}$  and  $X = \mathbb{R}$  we obtain the standard Takagi-van der Waerden function of type (a, b)  $f_{a,b} : \mathbb{R} \to \mathbb{R}$ ,

$$f_{a,b}(x) = \sum_{n=1}^{\infty} b^n d\left(x, \frac{1}{a^n} \mathbb{Z}\right) = \sum_{n=1}^{\infty} \left(\frac{b}{a}\right)^n d(a^n x, \mathbb{Z}), \quad x \in \mathbb{R}.$$

In the case  $a \in \mathbb{N}$  this function is TW-function of monotonic type (a, b). In particular, if a = r > 1 and b = 1 we obtain the standard Takagi-van der Waerden function of type  $r f_r : \mathbb{R} \to \mathbb{R}$ ,

$$f_r(x) = f_{r,1}(x) = \sum_{n=1}^{\infty} \frac{1}{r^n} d(r^n x, \mathbb{Z}), \quad x \in \mathbb{R},$$

which was considered, for example, in [1]. If we put r = 2 or r = 10 then we obtain the classical nowhere differentiable *Takagi function*  $f_2$  or *van der Waerden function*  $f_{10}$  (see Introduction in [1]).

**Proposition 4.2.** Let X be a metric space and a > b > 0 and f is TW-function of type (a,b),  $n \in \mathbb{N}$ ,  $s_n$  and  $r_n$  be the n-th partial sum and the n-th reminder of f. Then  $f, s_n, r_n$  are continuous functions on X and the following conditions hold:

- (i)  $f: X \to \mathbb{R}$  is a continuous function such that  $0 \le f(x) \le \frac{a}{a-b}, x \in X$ ;
- (ii)  $r_n: X \to \mathbb{R}$  is a continuous function such that  $0 \le r_n(x) \le \frac{b^n}{(a-b)a^{n-1}}$ ,  $x \in X$ ;
- (iii) if b > 1 then  $s_n : X \to \mathbb{R}$  is a Lipschitz function with the constant  $\frac{b^n}{b-1}$ .

*Proof.* (*ii*). By Proposition 4.1(*iv*) we conclude that  $b^k d(x, S_k) \leq \left(\frac{b}{a}\right)^k$ . Therefore, the series from Definition 5 is uniformly convergent. Thus,  $r_n$  is a continuous function and

$$0 \le r_n(x) \le \sum_{k=n}^{\infty} \left(\frac{b}{a}\right)^k = \frac{\left(\frac{b}{a}\right)^n}{1-\frac{b}{a}} = \frac{b^n}{(a-b)a^{n-1}}$$

for any  $x \in X$ .

(i). Since  $f = r_0$ , we conclude that  $(i) \to (ii)$ .

(iii). By Proposition 4.1(iii) we obtain that

$$|s_n(x) - s_n(y)| \le \sum_{k=0}^{n-1} b^k |d(x, S_k) - d(y, S_k)| \le \\ \le \sum_{k=0}^{n-1} b^k |x - y|_X = \frac{b^n - 1}{b - 1} |x - y|_X \le \frac{b^n}{b - 1} |x - y|_X \\ \in X$$

for any  $x, y \in X$ .

## 5. Big Lipschitz derivative of Takagi - van der Waerden functions

**Theorem 5.1.** Let X be a metric space, a > b > 2 and f be a TW-function of monotonic type (a, b). Then  $\operatorname{Lip} f(x) = \infty$  for any  $x \in X^d$ . Moreover, if  $(S_n)_{n=0}^{\infty}$  is such as in Definition 5 then for any  $x \in X^d \cap \bigcup_{n=1}^{\infty} S_n$  we have that  $\operatorname{lip} f(x) = \infty$ 

*Proof.* Let  $S_n, \varphi_n, s_n, r_n$  be such as in Definition 5. Fix  $x \in X^d$ . Let us prove that Lip  $f(x) = \infty$ 

Firstly, we consider the case  $x \in \bigcup_{n=1}^{\infty} S_n$  and prove that  $\operatorname{Lip} f(x) = \lim_{n \to \infty} f(x) = \infty$ . Then there is  $n_0 \in \mathbb{N}$  such that  $x \in S_{n_0}$ . Fix  $n \geq n_0$ . Therefore,  $x \in S_{n_0} \subseteq S_n \subseteq S_m$  and so  $\varphi_m(x) = 0$  for any  $m \geq n$ . Thus,  $r_n(x) = 0$ . Consider  $u \in B(x, \frac{1}{2a^n})$ . Then  $\varrho = |u - x|_X < \frac{1}{2a^n}$ . Since  $S_n$  is  $\frac{1}{a^n}$ -separated, we conclude that  $\varphi_n(u) = d(u, S_n) = \varrho$ , and then  $r_n(u) \geq b^n \varphi_n(u) = b^n \varrho$ .

Therefore,  $|r_n(u) - r_n(x)| = r_n(u) \ge b^n \varrho$ . On the other hand, Proposition 4.2(*iii*) implies that  $|s_n(u) - s_n(x)| < \frac{b^n}{b-1}|u - x|_X = \frac{b^n \varrho}{b-1}$ . Thus,

$$|f(u) - f(x)| = \left| \left( r_n(u) - r_n(x) \right) + \left( s_n(u) - s_n(x) \right) \right|$$
  

$$\geq \left| r_n(u) - r_n(x) \right| - \left| s_n(u) - s_n(x) \right|$$
  

$$\geq b^n \varrho - \frac{b^n \varrho}{b^{-1}} = b^n \varrho \alpha, \quad \text{where } \alpha = \frac{b^{-2}}{b^{-1}} > 0.$$

Consider r > 0 such that  $r < \frac{1}{2a^n}$ . Then

$$\operatorname{Lip}^{r} f(x) = \frac{1}{r} \sup_{u \in B(x,r)} \left| f(u) - f(x) \right| \ge \frac{1}{r} \sup_{|u-x|_{X} = \varrho < r} b^{n} \varrho \alpha = b^{n} \alpha.$$

Thus,

$$\operatorname{Lip} f(x) \ge \operatorname{lip} f(x) = \liminf_{r \to 0^+} \operatorname{Lip}^r f(x) \ge b^n \alpha \to \infty \quad \text{as} \quad n \to \infty.$$

Consider  $x \notin \bigcup_{n=1}^{\infty} S_n$  and prove that  $\operatorname{Lip} f(x) = \infty$ . By (3) it is enough to prove that there exists a sequence of points  $u_n \to x$  such that  $u_n \neq x$ and  $\frac{1}{\varrho_n} |f(u_n) - f(x)| \to \infty$  as  $n \to \infty$ , where  $\varrho_n = |u_n - x|_X$ . Fix  $n \in \mathbb{N}$ . Therefore,  $x \notin S_n$ , and so  $\varphi_n(x) = d(x, S_n) > 0$ . Since  $\frac{b}{2} > 1$ ,  $d(x, S_n) = \varphi_n(x) < \frac{b}{2}\varphi_n(x)$ . So, there is  $u_n \in S_n$  with  $\varrho_n = |u_n - x|_X < \frac{b}{2}\varphi_n(x)$ . Hence,  $\varphi_n(x) > \frac{2\varrho_n}{b}$ . Proposition 4.2(*iii*) implies  $\varphi_n(x) < \frac{1}{a^n}$ , an then  $\varrho_n \to 0$ . Since  $u_n \in S_n \subseteq S_m$  for any  $m \ge n$ , we have that  $r_n(u_n) = 0$ . Hence, by Proposition 4.2(*iii*) we conclude

$$\begin{aligned} \left| f(x) - f(u_n) \right| &= \left| r_n(x) + s_n(x) - s_n(u_n) \right| \\ &\geq r_n(x) - \left| s_n(x) - s_n(u_n) \right| \\ &\geq b^n \varphi_n(x) - \frac{b^n}{b-1} |u_n - x|_X \\ &\geq b^n \frac{2\varrho_n}{b} - \frac{b^n \varrho_n}{b-1} = b^n \varrho_n \beta, \text{ where } \beta = \frac{b-2}{b(b-1)}. \end{aligned}$$
Thus,  $\frac{1}{\varrho_n} \left| f(u_n) - f(x) \right| \geq b^n \beta \to \infty$ , and so,  $\operatorname{Lip} f(x) = \infty.$ 

# 6. Defect of a metric spaces and small Lipschitz derivative of Takagi - van der Waerden functions

**Definition 6.** Let X be a metric space and  $x \in X$ . The *defect of* X *at* x is, by definition, the number

$$D(X, x) = \liminf_{r \to 0^+} \frac{1}{r} \sup_{u \in B(x, r)} |u - x|_X.$$

Let  $X^d$  denotes the set of all non-isolated points of X. Obviously, D(X, x) = 0 for any  $x \in X \setminus X^d$ . The *defect of* X is, by definition, the number

$$D(X) = \inf_{x \in X^d} D(X, x).$$

Obviously,  $0 \le D(X, x) \le 1$ . If we consider the function  $d_x(u) = |u - x|_X$ ,  $u \in X$ , then

$$D(X, x) = \lim_{\varepsilon \to 0^+} \lim_{\varepsilon \to 0^+} \lim_{\varepsilon \to 0^+} \lim_{\varepsilon \to 0^+} d_x(x).$$

**Definition 7.** Let X be a metric space,  $x \in X$  and  $\lambda < D(X, x)$ . The radius of the defect of X at x is defined to de

$$RD_{\lambda}(X, x) = \sup\left\{\varepsilon > 0 : \lim_{\varepsilon} d_x(x) > \lambda\right\}$$

Obviously  $RD_{\lambda}(X, x) > 0$  for any  $\lambda < D(X, x)$ . The proof of the following propositions is straightforward.

**Proposition 6.1.** Let X be a metric space,  $x \in X$  and  $\lambda \ge 0$ . If  $\lambda < D(X, x)$  then for any  $0 \le r < RD_{\lambda}(X, x)$  there exists  $u \in X$  such that

$$\lambda r \le |x - u|_X \le r \tag{8}$$

Conversely, if there is  $\varepsilon > 0$  such that for any  $0 \le r < \varepsilon$  there is  $u \in X$  with (8) then  $D(X, x) \ge \lambda$  and  $RD_{\lambda}(X, x) \ge \varepsilon$ .

**Proposition 6.2.** Let M be a metric subspace of some normed space X such that  $M \subseteq \operatorname{Int} \overline{M} \neq \emptyset$ . Therefore, D(M, x) = 1 for any  $x \in M$ .

**Lemma 6.3.** Let X be a metric space,  $x \in X^d$ ,  $0 < \lambda < D(X, x)$ ,  $0 < \varepsilon < RD_{\lambda}(X, x)$ , S be a maximal  $\varepsilon$ -separated set in X and  $\varphi(\cdot) = d(\cdot, S)$ . Then there exist  $u \in B[x, \varepsilon]$  such that

$$|\varphi(u) - \varphi(x)| \ge \frac{\lambda\varepsilon}{8}$$

*Proof.* Set  $\alpha = \frac{\lambda}{8}$  and prove that  $|\varphi(u) - \varphi(x)| \ge \alpha \varepsilon$  for some  $u \in B[x, \varepsilon]$ .

Firstly, we consider the case  $\varphi(x) \geq \alpha \varepsilon$ . Since  $\varphi(x) = d(x, S) < \varepsilon$ by Proposition 4.2(*iii*), we conclude that there is a point  $u \in S$  such that  $|u - x|_X < \varepsilon$ . Therefore,  $\varphi(u) = 0$  and then

$$|\varphi(u) - \varphi(x)| = \varphi(x) \ge \alpha \varepsilon.$$

Secondly, we consider the case  $\varphi(x) < \alpha \varepsilon$ . Then there exists  $s \in X$  such that  $|s-x|_X < \alpha \varepsilon$ . Set  $r = \frac{3\varepsilon}{8}$ . Since  $0 < r < \varepsilon < RD_{\lambda}(X, x)$ , there is  $u \in X$  with

$$\lambda r \le |u - x|_X \le r$$

by Proposition 6.1. Observe that  $\lambda < D(X, x) \leq 1$ . Then  $\alpha = \frac{\lambda}{8} < \frac{1}{8}$ . Therefore,

$$|u - s|_X \le |u - x|_X + |x - s|_X < r + \alpha \varepsilon < r + \frac{\varepsilon}{8} = \frac{3\varepsilon}{8} + \frac{\varepsilon}{8} = \frac{\varepsilon}{2}.$$

Let us consider some  $t \in S \setminus \{s\}$ . Since S is  $\varepsilon$ -separated,  $|s - t|_X \ge \varepsilon$ . Hence,

$$|u-t|_X \ge |t-s|_X - |u-s|_X \ge \varepsilon - \frac{\varepsilon}{2} = \frac{\varepsilon}{2} \ge |u-s|_X.$$

Thus,  $\varphi(u) = d(u, S) = |u - s|_X$ . Therefore,

$$\varphi(u) = |u - s|_X \ge |u - x|_X - |s - x|_X \ge \lambda r - \alpha \varepsilon = \frac{3\lambda\varepsilon}{8} - \alpha \varepsilon = 3\alpha\varepsilon - \alpha\varepsilon = 2\alpha\varepsilon,$$

and then

$$|\varphi(u) - \varphi(x)| \ge \varphi(u) - \varphi(x) \ge 2\alpha\varepsilon - \alpha\varepsilon = \alpha\varepsilon.$$

Thus, in the both cases we have that  $|\varphi(u) - \varphi(x)| \ge \alpha \varepsilon$  for some  $u \in B[x, \varepsilon]$ .

**Theorem 6.4.** Let X be a metric space with D(X) > 0, a > b > 1 such that

$$\frac{2b}{a-b} + \frac{1}{b-1} < \frac{D(X)}{8},\tag{9}$$

and f be TW-function of type (a, b). Then lip  $f(x) = \infty$  for any  $x \in X^d$ .

*Proof.* Let  $S_n$ ,  $\varphi_n$ ,  $s_n$ ,  $r_n$  be such as in Definition 5. Fix  $x \in X^d$ . Let us prove that  $\lim f(x) = \infty$ . Since (9), we can peek  $\lambda > 0$  such that  $\lambda < D(X)$  and

$$\gamma := \frac{\lambda}{8} - \frac{2b}{a-b} - \frac{1}{b-1} > 0.$$
(10)

Therefore,  $RD_{\lambda}(X, x) > 0$ . Put  $\delta = \min \left\{ 1, RD_{\lambda}(X, x) \right\}$  and fix  $0 < r < \delta$ . Set  $\varepsilon_n = \frac{1}{a^n}$ . Since  $\varepsilon_0 = 1 \ge \delta$  and  $\varepsilon_n \downarrow 0$ , there exists  $n = n(r) \in \mathbb{N}$  such that  $\varepsilon_n \le r < \varepsilon_{n-1}$ . Put  $\varepsilon = \varepsilon(r) = \varepsilon_n$ . Observe that  $\varepsilon(r) \to 0$  and then  $n(r) \to \infty$  as  $r \to 0^+$ . Since  $\varepsilon = \varepsilon_n \le r < \delta \le RD_{\lambda}(X, x)$  we can us Lemma 6.3 for the set  $S = S_n$  and the function  $\varphi = \varphi_n$ . So, there is  $u \in B[x, \varepsilon]$  with

$$\left|\varphi(u) - \varphi(x)\right| \ge \frac{\lambda\varepsilon}{8}.$$

Denote  $g = s_n$  and  $h = r_{n+1}$ . Then

$$f = g + b^n \varphi + h$$

By Proposition 4.2 the function g is Lipschitz with the constant  $\frac{b^n}{b-1}$  and  $0 \le h \le \frac{b^{n+1}}{(a-b)a^n}$ . Therefore,

$$\begin{aligned} \left|g(u) - g(x)\right| &\leq \frac{b^n}{b-1} |u - x|_X \leq \frac{1}{b-1} b^n \varepsilon, \\ \left|h(u) - h(x)\right| &\leq \left|h(u)\right| + \left|h(x)\right| \leq \frac{2b^{n+1}}{(a-b)a^n}, = \frac{2b}{a-b} b^n \varepsilon \\ \left|b^n \varphi(u) - b^n \varphi(x)\right| &\leq b^n \frac{\lambda \varepsilon}{8} = \frac{\lambda}{8} b^n \varepsilon. \end{aligned}$$

Thus,

$$\begin{split} \left| f(u) - f(x) \right| &\geq \left| b^n \varphi(u) - b^n \varphi(x) \right| - \left| g(u) - g(x) \right| - \left| h(u) - h(x) \right| \geq \\ &\geq \frac{\lambda}{8} b^n \varepsilon - \frac{1}{b-1} b^n \varepsilon - \frac{2b}{a-b} b^n \varepsilon = \left( \frac{\lambda}{8} - \frac{1}{b-1} - \frac{2b}{a-b} \right) b^n \varepsilon = \gamma b^n \varepsilon = \\ &= \gamma b^n \varepsilon_n = \frac{\gamma b^n}{a^n} = \frac{\gamma}{a} b^n \varepsilon_{n-1} \geq \frac{\gamma}{a} b^n r. \end{split}$$

Hence,

 $\operatorname{Lip}^{r} f(x) \geq \frac{\gamma}{a} b^{n}$ , for any  $r < \delta$ .

But  $n = n(r) \to \infty$  as  $r \to 0^+$  and b > 1. Thus,

$$\lim_{r \to 0^+} f(x) = \liminf_{r \to 0^+} \operatorname{Lip}^r f(x) \ge \lim_{r \to 0^+} \frac{\gamma}{a} b^{n(r)} = \infty.$$

So,  $\lim f(x) = \infty$  for any  $x \in X^d$ .

**Lemma 6.5.** Let X be a metric space, G be an open subset of X,  $F = X \setminus G$ and  $\alpha > 0$ . Then there exist  $\alpha$ -Lipschitz functions  $g : X \to [0; \alpha]$  such that  $F = g^{-1}(0)$ .

*Proof.* If  $F = \emptyset$  then we put  $g(x) = \alpha$  for any  $x \in X$ . Suppose that  $F \neq \emptyset$ . Define

$$d(x,F) = \inf_{y \in F} |x - y|_X, \quad x \in X.$$

For any  $x, y \in X$  we have that

$$d(x,F) = \inf_{z \in F} |x - z|_X \le \inf_{z \in F} \left( |x - y|_X + |y - z|_X \right) = |x - y|_X + d(y,F).$$

Let us define a function g as

$$g(x) = \alpha \min \left\{ 1, d(x, F) \right\}, \quad x \in X.$$

Therefore, for any  $x, y \in X$  we have that

$$g(x) = \alpha \min\{1, d(x, F)\} \le \alpha \min\{1, |x - y|_X + d(y, F)\}$$
  
$$\le \alpha |x - y|_X + \alpha \min\{1, d(y, F)\} = \alpha |x - y|_X + g(y).$$

Replacing x to y we obtain that  $g(y) \leq \alpha |x - y|_X + g(x)$ . Thus,

$$|g(x) - g(y)| \le \alpha |x - y|_X$$
, for any  $x, y \in X$ ,

and then g is  $\alpha$ -Lipschitz. On the other hand, since F is closed,

$$g(x) = 0 \Leftrightarrow d(x, F) = 0 \Leftrightarrow x \in F, \quad x \in X.$$

Hence,  $F = g^{-1}(0)$ , and then g is such as we need.

**Theorem 6.6.** Let X be a metric space without isolated point such that D(X) > 0 and G be an open subset of X. Then there exists a continuous function  $f: X \to \mathbb{R}$  such that  $L^{\infty}(f) = \ell^{\infty}(f) = G$  and  $\mathbb{L}^{\infty}(f) = \overline{G}$ .

*Proof.* Since

$$\lim_{b \to \infty} \lim_{a \to \infty} \left( \frac{2b}{a-b} + \frac{1}{b-1} \right) = 0 < \frac{D(X)}{8},$$

we can chose b > 1 and then a > b such that inequality (9) holds. Let h be a TW-function of type (a, b). By Theorem 6.4 and Proposition 4.2 we have that  $\lim h(x) = \infty$  and  $0 \le h(x) \le \frac{a}{a-b}$  for any  $x \in X$ . Let  $F = X \setminus G$ ,  $U = \operatorname{Int} F = X \setminus \overline{G}$  and  $\alpha = \frac{a-b}{a}$ . We construct g by Lemma 6.5 and define the function  $f: X \to [0; 1]$  by f(x) = g(x)h(x) for any  $x \in X$ .

Consider  $x \in F$  and  $u \in X$ . Therefore,

$$\begin{aligned} \left| f(u) - f(x) \right| &= \left| g(u)h(u) - g(x)h(x) \right| = g(u)h(u) \le \frac{1}{\alpha}g(u) \\ &= \frac{1}{\alpha} \big( g(u) - g(x) \big) \le \frac{1}{\alpha} \cdot \alpha \big| u - x \big|_X = \big| u - x \big|_X, \end{aligned}$$

and so,  $\operatorname{Lip} f(x) \leq 1$ . Moreover,  $\operatorname{Lip} f(x) \leq 1$  for any  $x \in U$ .

Now we consider  $x \in G$  and prove  $\operatorname{Lip} f(x) = \operatorname{lip} f(x) = +\infty$ . For any r > 0 and  $u \in B(x, r)$  we have that

$$\begin{aligned} f(u) - f(x) &| = |g(u)h(u) - g(x)h(x)| \\ &= |g(x)(h(x) - h(u)) - h(u)(g(u) - g(x))| \\ &\geq g(x)|h(x) - h(u)| - h(u)|g(u) - g(x)| \\ &\geq g(x)|h(x) - h(u)| - \frac{1}{\alpha} \cdot \alpha |x - u| \\ &\geq g(x)|h(x) - h(u)| - r. \end{aligned}$$

Hence,

$$\operatorname{Lip}^{r} f(x) = \sup_{u \in B(x,r)} \frac{1}{r} |f(u) - f(x)|$$
  

$$\geq g(x) \sup_{u \in B(x,r)} \frac{1}{r} |h(u) - h(x)| - 1$$
  

$$= g(x) \operatorname{Lip}^{r} h(x) - 1.$$

Consequently, since g(x) > 0, we conclude that

$$\begin{split} \operatorname{Lip} f(x) &\geq \operatorname{Lip} f(x) \geq \operatorname{lip} f(x) = \liminf_{r \to 0^+} \operatorname{Lip}^r f(x) \\ &\geq g(x) \liminf_{r \to 0^+} \operatorname{Lip}^r h(x) - 1 \\ &= g(x) \operatorname{lip} h(x) - 1 = +\infty. \end{split}$$

Hence,  $\lim f(x) = \operatorname{Lip} f(x) = \operatorname{Lip} f(x)$  on G. Thus,  $\ell^{\infty}(f) = L^{\infty}(f) = G$  and  $G \subseteq \mathbb{L}^{\infty}(f) \subseteq X \setminus U = \overline{G}$ . Finally, since  $\mathbb{L}^{\infty}(f)$  is closed,  $\mathbb{L}^{\infty}(f) = \overline{G}$   $\Box$ 

Using Theorem 5.1 instead of Theorem 6.4 in the previous proof we obtain the following result.

**Theorem 6.7.** Let X be a metric space without isolated point and G be an open subset of X. Then there exists a continuous function  $f: X \to \mathbb{R}$  such that  $L^{\infty}(f) = G$  and  $\mathbb{L}^{\infty}(f) = \overline{G}$ .
