# HIGHER ORDER FRACTIONAL WEIGHTED HOMOGENEOUS SPACES: CHARACTERIZATION AND FINER EMBEDDINGS

Abstract. In this article, for $N \geq 2, s \in(1,2), p \in\left(1, \frac{N}{s}\right), \sigma=s-1$ and $a \in\left[0, \frac{N-s p}{2}\right)$, we establish an isometric isomorphism between the higher order fractional weighted Beppo-Levi space

\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right):=\overline{\left.\mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right)^{[\cdot]} \cdot\right]_{s, p, a}} \text { where }[u]_{s, p, a}:=\left(\iint_{\mathbb{R}^{N} \times \mathbb{R}^{N}} \frac{|\nabla u(x)-\nabla u(y)|^{p}}{|x-y|^{N+\sigma p}} \frac{\mathrm{~d} x}{|x|^{a}} \frac{\mathrm{~d} y}{|y|^{a}}\right)^{\frac{1}{p}}
$$

and higher order fractional weighted homogeneous space

$$
\stackrel{\circ}{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right):=\left\{u \in L_{a}^{p_{s}^{*}}\left(\mathbb{R}^{N}\right):\|\nabla u\|_{L_{a}^{p_{\sigma}^{*}}\left(\mathbb{R}^{N}\right)}+[u]_{s, p, a}<\infty\right\}
$$

with the weighted Lebesgue norm

$$
\|u\|_{L_{a}^{p_{\alpha}^{*}}\left(\mathbb{R}^{N}\right)}:=\left(\int_{\mathbb{R}^{N}} \frac{|u(x)|^{p_{\alpha}^{*}}}{|x|^{\frac{2 a p_{\alpha}^{*}}{p}}} \mathrm{~d} x\right)^{\frac{1}{p_{\alpha}^{*}}}, \text { where } p_{\alpha}^{*}=\frac{N p}{N-\alpha p} \text { for } \alpha=s, \sigma
$$

To achieve this, we prove that $\mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right)$ is dense in $\stackrel{\circ}{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ with respect to $[\cdot]_{s, p, a}$, and $[\cdot]_{s, p, a}$ is an equivalent norm on $\dot{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$. Further, we obtain a finer embedding of $\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ into the Lorentz space $L^{\frac{N p}{N-s p-2 a}, p}\left(\mathbb{R}^{N}\right)$, where $L^{\frac{N p}{N-s p-2 a}, p}\left(\mathbb{R}^{N}\right) \subsetneq L_{a}^{p_{s}^{*}}\left(\mathbb{R}^{N}\right)$.

## 1. Introduction

For $a \geq 0, s=1+\sigma, \sigma \in(0,1), p \in(1, \infty)$ and $N \geq 2$, we define the higher order fractional weighted- $p$ Laplace operator of order $s$, up to a normalizing constant as

\left\langle(-\Delta)_{p, a}^{s} u, \varphi\right\rangle=\iint_{\mathbb{R}^{N} \times \mathbb{R}^{N}} \frac{|\nabla u(x)-\nabla u(y)|^{p-2}(\nabla u(x)-\nabla u(y)) \cdot(\nabla \varphi(x)-\nabla \varphi(y))}{|x-y|^{N+\sigma p}} \frac{\mathrm{~d} x}{|x|^{a}} \frac{\mathrm{~d} y}{|y|^{a}},
$$

for $u, \varphi \in \mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right)$. We define the following Gagliardo seminorm

$$
[u]_{s, p, a}:=\left(\iint_{\mathbb{R}^{N} \times \mathbb{R}^{N}} \frac{|\nabla u(x)-\nabla u(y)|^{p}}{|x-y|^{N+\sigma p}} \frac{\mathrm{~d} x}{|x|^{a}} \frac{\mathrm{~d} y}{|y|^{a}}\right)^{\frac{1}{p}} .
$$

For $a>0$, we consider the higher order fractional weighted Sobolev space $W_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ as

$$
\begin{equation*}
W_{a}^{s, p}\left(\mathbb{R}^{N}\right):=\left\{u \text { is measurable }:\|u\|_{p, a}+\|\nabla u\|_{p, a}+[u]_{s, p, a}<\infty\right\} \tag{1.1}
\end{equation*}
$$

where

$$
\|u\|_{p, a}:=\left(\int_{\mathbb{R}^{N}}|u(x)|^{p} \frac{\mathrm{~d} x}{|x|^{a}}\right)^{\frac{1}{p}} \text { and }\|\nabla u\|_{p, a}:=\left(\int_{\mathbb{R}^{N}}|\nabla u(x)|^{p} \frac{\mathrm{~d} x}{|x|^{a}}\right)^{\frac{1}{p}}
$$

[^0]For $a=0$, the corresponding higher order fractional Sobolev space $W_{0}^{s, p}\left(\mathbb{R}^{N}\right)$ is defined in [14, Chapter 11]. We refer to [14] for more details on this space. Now we consider the following non-local elliptic problem

$$
\begin{equation*}
(-\Delta)_{p, a}^{s} u=f, \text { in } \mathbb{R}^{N}, \tag{1.2}
\end{equation*}
$$

under suitable assumptions on the source term $f$. For the existence of a weak solution to (1.2), an obvious choice is to apply the Direct Method in the Calculus of Variations. Consequently, the problem reduces to minimizing the associated energy functional $\mathcal{J}$ given by

\begin{equation*}
\mathcal{J}(u)=\frac{1}{p} \iint_{\mathbb{R}^{N} \times \mathbb{R}^{N}} \frac{|\nabla u(x)-\nabla u(y)|^{p}}{|x-y|^{N+\sigma p}} \frac{\mathrm{~d} x}{|x|^{a}} \frac{\mathrm{~d} y}{|y|^{a}}-\int_{\mathbb{R}^{N}} f(x) u(x) \mathrm{d} x . \tag{1.3}
\end{equation*}
$$

Suppose, we consider the solution space for $(1.2)$ as $W_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ where $f \not \equiv 0$ and $f \in\left(W_{a}^{s, p}\left(\mathbb{R}^{N}\right)\right)^{*}$ (dual space of $W_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ ). Observe that one can not have any control over $\|\cdot\|_{p, a}$ of minimizing sequences because the following weighted Poincaré type inequality

$$
\begin{equation*}
\int_{\mathbb{R}^{N}}|u(x)|^{p} \frac{\mathrm{~d} x}{|x|^{a}} \leq C[u]_{s, p, a}^{p}, \forall u \in W_{a}^{s, p}\left(\mathbb{R}^{N}\right), \tag{1.4}
\end{equation*}
$$

does not hold for any $C>0$. Suppose (1.4) holds for some $C_{1}>0$. For $\lambda>0$ taking $u_{\lambda}(x)=u(\lambda x)$, we get

$$
\left[u_{\lambda}\right]_{s, p, a}^{p}=\lambda^{2 a-N+(\sigma+1) p}[u]_{s, p, a}^{p} \text { and }\left\|u_{\lambda}\right\|_{p, a}^{p}=\lambda^{a-N}\|u\|_{p, a}^{p},
$$

which in turn implies

$$
\begin{equation*}
\int_{\mathbb{R}^{N}}|u(x)|^{p} \frac{\mathrm{~d} x}{|x|^{a}} \leq C_{1} \lambda^{a+(\sigma+1) p}[u]_{s, p, a}^{p}, \text { for every } \lambda>0 . \tag{1.5}
\end{equation*}
$$

Dividing (1.5) by $\lambda^{a+(\sigma+1) p}$ and taking $\lambda \rightarrow 0$ we get $[u]_{s, p, a}=\infty$. In a similar way, one can verify that the following inequality

$$
\int_{\mathbb{R}^{N}} \frac{|\nabla u(x)|^{p}}{|x|^{a}} \mathrm{~d} x \leq C[u]_{s, p, a}^{p}, \forall u \in W_{a}^{s, p}\left(\mathbb{R}^{N}\right)
$$

does not hold for any $C>0$. This phenomenon conveys the fact that $W_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ is not an appropriate function space to look for the weak solution for (1.2) as $\mathcal{J}$ is not coercive on $W_{a}^{s, p}\left(\mathbb{R}^{N}\right)$.

The natural spaces to look for the existence of weak solutions for (1.2) are the higher order fractional weighted Beppo-Levi spaces $\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$, which are defined by

$$
\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right):=\text { closure of } \mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right) \text { with respect to }[\cdot]_{s, p, a} .
$$

The notation $\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ is reminiscent of the historical one introduced by Deny and Lions in their seminal paper [8], where the authors first studied homogeneous spaces obtained by the completion of $\mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right)$ with respect to a given seminorm. Notice that for $f \in\left(\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)\right)^{*}, \mathcal{J}$ is well defined and

$$
\mathcal{J}(u) \geq \frac{[u]_{s, p, a}^{p}}{p}-\|f\|_{\left(\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)\right)^{*}}[u]_{s, p, a}, \forall u \in \mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right) .
$$

The above inequality conveys that $\mathcal{J}$ is coercive on $\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$. Hence, the existence of a solution for (1.2) can be assured in $\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ if one verifies other qualitative properties of $\mathcal{J}$; for example, the weak lower semicontinuity of $\mathcal{J}$ in $\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$. The main focus of this article is to characterize $\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ as a function space. Verifying that a function $u \in \mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ can be challenging, as it is not always feasible to find a sequence $\left\{u_{n}\right\} \subset \mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right)$ that converges to $u$ with respect to $[\cdot]_{s, p, a}$. To address this difficulty, we study an equivalent characterization of $\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$. For $s=1+\sigma, \sigma \in(0,1), a \in\left[0, \frac{N-s p}{2}\right)$ and $p \in\left(1, \frac{N}{s}\right)$, we define the higher order fractional weighted homogeneous space $\dot{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ as

\begin{equation*}
\check{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right):=\left\{u \in L_{a}^{p_{s}^{*}}\left(\mathbb{R}^{N}\right):\|u\|_{\hat{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right)}<\infty\right\} \tag{1.6}
\end{equation*}
$$

where

$$
\|u\|_{\hat{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right)}:=\|\nabla u\|_{L_{a}^{p_{\sigma}^{*}}\left(\mathbb{R}^{N}\right)}+[u]_{s, p, a},
$$

where the weighted Lebesgue space $L_{a}^{p_{\alpha}^{*}}\left(\mathbb{R}^{N}\right)$, for $\alpha=s, \sigma$, is given by

$$
L_{a}^{p_{\alpha}^{*}}\left(\mathbb{R}^{N}\right):=\left\{u \text { is measurable }:\|u\|_{L_{a}^{p_{\alpha}^{*}}\left(\mathbb{R}^{N}\right)}<\infty\right\} \text {, where }\|u\|_{L_{a}^{p_{\alpha}^{*}\left(\mathbb{R}^{N}\right)}}^{p^{*}}:=\int_{\mathbb{R}^{N}} \frac{\mid u(x)}{|x|^{\frac{2 p_{\alpha}^{*}}{p}}} \mathrm{p} x,
$$

and the fractional critical exponent $p_{\alpha}^{*}$ is defined as $p_{\alpha}^{*}:=\frac{N p}{N-\alpha p}$. The name 'homogeneous' is due to the fact that

$$
\left\|u_{\lambda}\right\|_{\dot{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right)}=\|u\|_{\dot{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right)}, \text { for } u_{\lambda}(x)=\lambda^{\frac{N-s p-2 a}{p}} u(\lambda x), \text { where } \lambda>0
$$

In the first part of this article, we aim to establish the existence of an isometric isomorphism between $\stackrel{\circ}{a}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ and $\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$. For that we investigate certain qualitative properties of $\dot{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$, such as the density of $\mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right)$ in $\dot{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ and the equivalence between $[\cdot] s, p, a$ and $\|\cdot\|_{\dot{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right)}$.

For $s \in(0,1]$, a similar characterization for the fractional Beppo Levi space is recently studied in [5]. For $a=0, s \in(0,1]$ and $p \in\left(1, \frac{N}{s}\right)$, the fractional Beppo-Levi space $\mathcal{D}^{s, p}\left(\mathbb{R}^{N}\right)$ is defined as the completion of $\mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right)$ with respect to the seminorms

$$
\|u\|_{s, p}:= \begin{cases}\left(\iint_{\mathbb{R}^{N} \times \mathbb{R}^{N}} \frac{|u(x)-u(y)|^{p}}{|x-y|^{N+s p}} \mathrm{~d} x \mathrm{~d} y\right)^{\frac{1}{p}}, & \text { for } s \in(0,1), \\ \left(\int_{\mathbb{R}^{N}}|\nabla u|^{p} \mathrm{~d} x\right)^{\frac{1}{p}}, & \text { for } s=1 .\end{cases}
$$

From [17, Theorem 10.2.1] and [6, Theorem 9.9], the following Sobolev inequality holds

$$
\begin{equation*}
\|u\|_{L^{p_{s}^{*}}\left(\mathbb{R}^{N}\right)} \leq C(N, p, s)\|u\|_{s, p}, \forall u \in \mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right) \tag{1.7}
\end{equation*}
$$

In [5, Theorem 3.1], using (1.7), Brasco et al. characterize the fractional Beppo-Levi space $\mathcal{D}^{s, p}\left(\mathbb{R}^{N}\right)$ as

$$
\mathcal{D}^{s, p}\left(\mathbb{R}^{N}\right)=\left\{u \in L^{p_{s}^{*}}\left(\mathbb{R}^{N}\right):\|u\|_{s, p}<\infty\right\} .
$$

For $a \in\left(0, \frac{N-s p}{2}\right)$ the following weighted Sobolev inequality holds (see [1, Theorem 1.5]):

$$
\begin{equation*}
\|u\|_{L_{a}^{p_{s}^{*}}\left(\mathbb{R}^{N}\right)} \leq C(N, p, s, a)\|u\|_{s, p, a}, \forall u \in \mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right), \tag{1.8}
\end{equation*}
$$

where $\|\cdot\|_{s, p, a}$ is defined as

$$
\|u\|_{s, p, a}:=\left(\iint_{\mathbb{R}^{N} \times \mathbb{R}^{N}} \frac{|u(x)-u(y)|^{p}}{|x-y|^{N+s p}} \frac{\mathrm{~d} x}{|x|^{a}} \frac{\mathrm{~d} y}{|y|^{a}}\right)^{\frac{1}{p}} .
$$

Motivated by (1.8), the authors in [10] define $W_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ endowed with the following norm

$$
\|u\|_{\hat{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right)}:=\|u\|_{s, p, a}+\|u\|_{L_{a}^{p_{s}^{*}}\left(\mathbb{R}^{N}\right)}
$$

In [10, Theorem 1.1], the authors proved that $\mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right)$ is dense in $\dot{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$. Clearly, this density result and (1.8) infer that $\|\cdot\|_{s, p, a}$ is an equivalent norm in $\stackrel{\circ}{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$. The appearance of the space $\dot{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ is seen in some literature; for example, Hardy-Lieb-Thirring inequalities (see [12]) and the non-local critical problems involving the Hardy-Leray potential (see [9]).

For $s \in(0,1), a \in\left[0, \frac{N-s p}{2}\right)$ and $p \in\left(1, \frac{N}{s}\right)$, from [1, Theorem 2.7] we now recall the following weighted Hardy inequality

$$
\begin{equation*}
\int_{\mathbb{R}^{N}} \frac{|u(x)|^{p}}{|x|^{s p+2 a}} \mathrm{~d} x \leq C \iint_{\mathbb{R}^{N} \times \mathbb{R}^{N}} \frac{|u(x)-u(y)|^{p}}{|x-y|^{N+s p}} \frac{\mathrm{~d} x}{|x|^{a}} \frac{\mathrm{~d} y}{|y|^{a}}, \forall u \in \mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right), \tag{1.9}
\end{equation*}
$$

where $C=C(N, p, s, a)>0$. For $a=0$, (1.9) reduces to the classical Hardy inequality derived by Frank-Seiringer in [13] with the best constant. Further, using this inequality the authors in [13, Lemma 4.3] established an embedding of $\mathcal{D}^{s, p}\left(\mathbb{R}^{N}\right)$ into the Lorentz space $L^{p_{s}^{*}, p}\left(\mathbb{R}^{N}\right)$, namely $\|u\|_{p_{s}^{*}, p} \leq C(N, p, s)[u]_{s, p}$, for all $u \in \mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$. This embedding is finer than the fractional Sobolev embedding $\mathcal{D}^{s, p}\left(\mathbb{R}^{N}\right) \hookrightarrow L^{p_{s}^{*}}\left(\mathbb{R}^{N}\right)$ due to the fact that $L^{p_{s}^{*}, p}\left(\mathbb{R}^{N}\right) \subsetneq L^{p_{s}^{*}, p_{s}^{*}}\left(\mathbb{R}^{N}\right)=L^{p_{s}^{*}}\left(\mathbb{R}^{N}\right)$. In the local case $s=1$, the Lorentz Sobolev embeddings are studied for $W^{1, p}\left(\mathbb{R}^{N}\right)$ and $\mathcal{D}^{1, p}\left(\mathbb{R}^{N}\right)$. For example, the authors in $[2,19,20]$ independently demonstrated that $W^{1, p}\left(\mathbb{R}^{N}\right) \hookrightarrow L^{p^{*}, p}\left(\mathbb{R}^{N}\right)$ where
$p^{*}=\frac{N p}{N-p}$ for $N>p$. In [3], the authors showed that $\mathcal{D}^{1, p}\left(\mathbb{R}^{N}\right) \hookrightarrow L^{p^{*}, p}\left(\mathbb{R}^{N}\right)$. For $s \in(1,2)$, the corresponding fractional Lorentz Sobolev embedding is not known. However, for $s=2$, in [18] the authors showed that the Beppo Levi space $\mathcal{D}^{2,2}\left(\mathbb{R}^{N}\right)$ (which is a completion of $\mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right)$ with respect to $\left.\|\Delta u\|_{L^{2}\left(\mathbb{R}^{N}\right)}\right)$ is continuously embedded into the Lorentz space $L^{2^{* *}, 2}\left(\mathbb{R}^{N}\right)$ where $2^{* *}=\frac{2 N}{N-4}$.

In the second part of this article, for $s \in(1,2)$, we establish an embedding $\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ into the Lorentz space $L^{p^{\star}, p}\left(\mathbb{R}^{N}\right)$, where $p^{\star}=\frac{N p}{N-s p-2 a}$. This embedding is finer since $L^{p^{\star}, p}\left(\mathbb{R}^{N}\right) \subsetneq L_{a}^{p_{s}^{*}}\left(\mathbb{R}^{N}\right)$ (see Proposition 5.3). Moreover, $p^{\star}$ is an appropriate exponent in this case, since for $s=p=2$ and $a=0, p^{\star}$ becomes $\frac{2 N}{N-4}$. For this finer embedding, we derive a fractional weighted Rellich inequality in Proposition 5.2. For $a=0$ and $p=2$, a similar inequality has been obtained in [11, Corollary 7.5].

The following theorem collects the main results of this article.
Theorem 1.1. Let $N \geq 2, s \in(1,2), \sigma=s-1, p \in\left(1, \frac{N}{s}\right)$, and $a \in\left[0, \frac{N-s p}{2}\right)$. Then the following hold:
(i) (Density of smooth functions) For every $u \in \dot{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$, there exists $u_{n} \in \mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right)$ such that

$$
\left[u-u_{n}\right]_{s, p, a} \rightarrow 0, \text { as } n \rightarrow \infty,
$$

namely $\mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right)$ is dense in $\stackrel{\circ}{a}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ with respect to the seminorm $[\cdot]_{s, p, a}$.
(ii) (Equivalent norm) There exists $C=C(N, p, \sigma, a)>0$ such that

$$
\|\nabla u\|_{L_{a}^{p_{\sigma}^{*}}\left(\mathbb{R}^{N}\right)} \leq C[u]_{s, p, a}, \forall u \in{\stackrel{\circ}{W_{a}^{s, p}}\left(\mathbb{R}^{N}\right) . . . .}
$$

(iii) (Characterization) $\stackrel{W}{a}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ is a Banach space with respect to the norm $[\cdot]_{s, p, a}$. Further, there exists an isometric isomorphism

$$
\mathcal{J}: \mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right) \rightarrow \dot{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right)
$$

i.e., the space $\stackrel{\circ}{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ is identified with $\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$.
(iv) (Finer embeddings) Denote $p^{\star}=\frac{N p}{N-s p-2 a}$. Then

$$
\begin{equation*}
|u|_{p^{\star}, p} \leq C(N, s, p, a)[u]_{s, p, a}, \forall u \in \mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right) \tag{1.10}
\end{equation*}
$$

i.e., $\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right) \hookrightarrow L^{p^{\star}, p}\left(\mathbb{R}^{N}\right)$.

The rest of the article is organized as follows. In Section 2, we state mollifier and cut-off functions and define Lorentz spaces, weak Young's inequality. In Section 3, we prove the approximations with smooth functions and norm equivalence in $\grave{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$. Section 4 is devoted to study the characterization between $\overleftarrow{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ and $\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$. In the final section, we prove fractional weighted Rellich inequality and finer embeddings of $\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$.

## 2. Preliminaries

We begin by proving several basic inequalities to be used frequently in the subsequent sections. Next, we introduce the mollifier and cut-off functions essential for establishing the density results. Subsequently, we define the Lorentz spaces and state the weak Young's inequality. The following notations will be used throughout this paper.

## Notation:

(i) For $p \in[1, \infty], L^{p}\left(\mathbb{R}^{N}\right)$-norm of $f$ is denoted as $\|f\|_{p}$.
(ii) $B_{r}:=B_{r}(0) \subset \mathbb{R}^{N}$ denotes a ball of radius $r$ with centre at the origin.
(iii) The convolution $f \star g$ is defined as $(f \star g)(x)=\int_{\mathbb{R}^{N}} f(x-z) g(z) \mathrm{d} z$.
(iv) For $\rho_{n}$ defined in (2.5), we denote

$$
u_{n}=u \star \rho_{n} \text { and } \frac{\partial u_{n}}{\partial x_{i}}=\frac{\partial u}{\partial x_{i}} \star \rho_{n},
$$

for $i=1, \cdot, \cdot, \cdot, N$.
(v) For $A \subset \mathbb{R}^{N}$, it's complement $\mathbb{R}^{N} \backslash A$ is denoted as $A^{c}$.
(vi) $C$ denotes generic positive constant.

Lemma 2.1. Let $a_{i} \geq 0$, for $i=1,2, \cdot, \cdot, \cdot, N$ and $0<q<\infty$. Then
(i) $\left(a_{1}+a_{2}+\ldots+a_{N}\right)^{q} \leq A(N, q)\left(a_{1}^{q}+a_{2}^{q}+\ldots+a_{N}^{q}\right)$,
(ii) $\left(a_{1}+a_{2}+\ldots+a_{N}\right)^{q} \geq B(N, q)\left(a_{1}^{q}+a_{2}^{q}+\ldots+a_{N}^{q}\right)$,
where

$$
A(N, q)=1, B(N, q)=\left\{\begin{array}{ll}
\left(\frac{q}{2}\right)^{\frac{N+1}{2}}, & \text { if } N \text { is odd } \\
\left(\frac{q}{2}\right)^{\frac{N}{2}}, & \text { if } N \text { is even }
\end{array}, \text { for } 0<q<1\right.
$$

and

$$
B(N, q)=1, A(N, q)=\left\{\begin{array}{ll}
\left(2^{q-1}\right)^{\frac{N+1}{2}}, & \text { if } N \text { is odd } \\
\left(2^{q-1}\right)^{\frac{N}{2}}, & \text { if } N \text { is even }
\end{array}, \text { for } 1 \leq q<\infty\right.
$$

Proof. (i) For $\mathbf{0}<\boldsymbol{q}<\mathbf{1}$ : In this case, $\left(a_{1}+a_{2}\right)^{q} \leq a_{1}^{q}+a_{2}^{q}$ and generalising this inequality we get

$$
\left(a_{1}+a_{2}+\ldots+a_{N}\right)^{q} \leq\left(a_{1}^{q}+a_{2}^{q}+\ldots+a_{N}^{q}\right) .
$$

For $1 \leq \boldsymbol{q}<\infty$ : In this case, using the convexity of $x \mapsto|x|^{q}$, we have $\left(a_{1}+a_{2}\right)^{q} \leq 2^{q-1}\left(a_{1}^{q}+a_{2}^{q}\right)$ for any $a_{1}, a_{2} \geq 0$. Using it, we find

$$
\left(a_{1}+a_{2}+a_{3}\right)^{q} \leq 2^{q-1}\left(a_{1}+a_{2}\right)^{q}+2^{q-1} a_{3}^{q} \leq\left(2^{q-1}\right)^{2}\left(a_{1}^{q}+a_{2}^{q}+a_{3}^{q}\right)
$$

and

$$
\left(a_{1}+a_{2}+a_{3}+a_{4}\right)^{q} \leq 2^{q-1}\left(a_{1}+a_{2}\right)^{q}+2^{q-1}\left(a_{3}+a_{4}\right)^{q} \leq\left(2^{q-1}\right)^{2}\left(a_{1}^{q}+a_{2}^{q}+a_{3}^{q}+a_{4}^{q}\right)
$$

Hence, upon generalization,

$$
\left(a_{1}+a_{2}+\ldots+a_{N}\right)^{q} \leq A(N, q)\left(a_{1}^{q}+a_{2}^{q}+\ldots+a_{N}^{q}\right) .
$$

(ii) For $\mathbf{0}<\boldsymbol{q}<\mathbf{1}$ : We first prove that

$$
\begin{equation*}
\left(a_{1}+a_{2}\right)^{q} \geq \frac{q}{2}\left(a_{1}^{q}+a_{2}^{q}\right) \tag{2.1}
\end{equation*}
$$

We define $f_{1}:[1, \infty) \rightarrow \mathbb{R}$ by $f_{1}(t)=(t+1)^{q}-\frac{q}{2}\left(t^{q}+1\right)$. Then $f_{1}(t) \geq\left(1-\frac{q}{2}\right) t^{q}-\frac{q}{2} \geq 1-\frac{q}{2}-\frac{q}{2}>0$, which implies

$$
\begin{equation*}
(t+1)^{q}>\frac{q}{2}\left(t^{q}+1\right), \text { for all } t \geq 1 \tag{2.2}
\end{equation*}
$$

Now (2.1) is trivial if either $a_{1}=0$ or $a_{2}=0$. So, we assume $a_{1}, a_{2} \neq 0$. If $a_{1} \geq a_{2}$, then for $t=\frac{a_{1}}{a_{2}}$ in (2.2) we get (2.1). If $a_{1} \leq a_{2}$, then for $t=\frac{a_{2}}{a_{1}}$ in (2.2) we get (2.1). From (2.1) we deduce that

\left(a_{1}+a_{2}+a_{3}\right)^{q} \geq \frac{q}{2}\left(a_{1}+a_{2}\right)^{q}+\frac{q}{2} a_{3}^{q} \geq\left(\frac{q}{2}\right)^{2}\left(a_{1}^{q}+a_{2}^{q}+a_{3}^{q}\right)
$$

and

$$
\left(a_{1}+a_{2}+a_{3}+a_{4}\right)^{q} \geq \frac{q}{2}\left(a_{1}+a_{2}\right)^{q}+\frac{q}{2}\left(a_{3}+a_{4}\right)^{q} \geq\left(\frac{q}{2}\right)^{2}\left(a_{1}^{q}+a_{2}^{q}+a_{3}^{q}+a_{4}^{q}\right)
$$

Upon generalization, we obtain

$$
\left(a_{1}+a_{2}+\ldots+a_{N}\right)^{q} \geq B(N, q)\left(a_{1}^{q}+a_{2}^{q}+\ldots+a_{N}^{q}\right)
$$

For $1 \leq \boldsymbol{q}<\infty$ : We consider a function $f_{2}:[1, \infty) \rightarrow \mathbb{R}$ by $f_{2}(t)=(t+1)^{q}-t^{q}-1$. Then $f_{2}^{\prime}(t)=q\left[(t+1)^{q-1}-t^{q-1}\right] \geq 0$. Thus, $f(t) \geq f(1)$ for all $t \geq 1$, which implies $(t+1)^{q}-t^{q}-1 \geq$ $2^{q}-2 \geq 0$ as $q \geq 1$. Thus,

$$
\begin{equation*}
(t+1)^{q} \geq t^{q}+1, \text { for all } t \geq 1 \tag{2.3}
\end{equation*}
$$

By substituting $t=\frac{a_{1}}{a_{2}}$ if $a_{1} \geq a_{2}$ or $t=\frac{a_{2}}{a_{1}}$ if $a_{1} \leq a_{2}$ into (2.3), we get

$$
\begin{equation*}
\left(a_{1}+a_{2}\right)^{q} \geq a_{1}^{q}+a_{2}^{q} \tag{2.4}
\end{equation*}
$$

Generalizing (2.4), $\left(a_{1}+a_{2}+\ldots+a_{N}\right)^{q} \geq a_{1}^{q}+a_{2}^{q}+\ldots+a_{N}^{q}$.

Definition 2.2 (Mollifier functions). Consider a radially symmetric and decreasing function $\rho \in$ $\mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right)$ such that $\rho \geq 0$ on $\mathbb{R}^{N}$, supp $(\rho) \subset \overline{B_{1}}$ and $\int_{\mathbb{R}^{N}} \rho(x) d x=1$. For each $n \in \mathbb{N}$, define

$$
\begin{equation*}
\rho_{n}(x)=n^{N} \rho(n x), \text { for } x \in \mathbb{R}^{N} \text {. } \tag{2.5}
\end{equation*}
$$

Then $\rho_{n}$ satisfies

$$
\rho_{n} \in \mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right), \operatorname{supp}\left(\rho_{n}\right) \subset \overline{B_{\frac{1}{n}}}, \int_{\mathbb{R}^{N}} \rho_{n}(x) d x=1, \rho_{n} \geq 0 \text { in } \mathbb{R}^{N} .
$$

The sequence $\left\{\rho_{n}\right\}$ is called a sequence of mollifiers.
Definition 2.3 (Cut-off functions). Fix a function $\zeta \in \mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right)$ such that $0 \leq \zeta \leq 1$ and

$$
\zeta(x)= \begin{cases}1 & \text { if }|x|<1 \\ 0 & \text { if }|x| \geq 2\end{cases}
$$

For each $n \in \mathbb{N}$, define

$$
\begin{equation*}
\zeta_{n}(x):=\zeta\left(\frac{x}{n}\right) . \tag{2.6}
\end{equation*}
$$

The sequence $\left\{\zeta_{n}\right\}$ is called the cut-off function. Observe that

$$
\begin{equation*}
\left\|\nabla \zeta_{n}\right\|_{\infty} \leq \frac{C}{n}, \text { and }\left\|\nabla^{2} \zeta_{n}\right\|_{\infty} \leq \frac{C}{n^{2}} \tag{2.7}
\end{equation*}
$$

where $C=C(N)$ and $\nabla^{2}$ represents the Hessian matrix.
Now, we recall the definition of Lorentz space introduced by Lorentz in [16]. For an open set $\Omega \subset \mathbb{R}^{N}$, let $M(\Omega)$ be the set of all extended real-valued Lebesgue measurable functions that are finite a.e. in $\Omega$. For $t>0$ and $f \in M(\Omega)$, define $E_{f}(t):=\{x \in \Omega:|f(x)|>t\}$. The distribution function $\mu_{f}$ of $f$ is defined as $\mu_{f}(t):=\left|E_{f}(t)\right|$. For $(p, q) \in(0, \infty) \times(0, \infty]$ we consider the following quantity

$$
|f|_{p, q}:= \begin{cases}\left(p \int_{0}^{\infty} t^{q-1} \mu_{f}(t)^{\frac{q}{p}} \mathrm{~d} t\right)^{\frac{1}{q}}, & q<\infty ; \\ \sup _{t>0} t \mu_{f}(t)^{\frac{1}{p}}, & q=\infty .\end{cases}
$$

The Lorentz space $L^{p, q}(\Omega)$ is defined as

$$
L^{p, q}(\Omega):=\left\{f \in M(\Omega):|f|_{p, q}<\infty\right\},
$$

where $|f|_{p, q}$ is a quasi norm on $L^{p, q}(\Omega)$. Notice that $L^{p, p}\left(\mathbb{R}^{N}\right)=L^{p}\left(\mathbb{R}^{N}\right)$ and $L^{p, q_{1}}\left(\mathbb{R}^{N}\right) \subsetneq L^{p, q_{2}}\left(\mathbb{R}^{N}\right)$ provided $q_{1}<q_{2}$ (see [11, Proposition 3.4.3]). For details about this space, we refer to [11].
Example 2.4. For $d<N$, consider the function $g(x)=|x|^{-d}$ where $x \in \mathbb{R}^{N}$. Using [4, Example 2.2.5] we get $g \in L^{\frac{N}{d}, \infty}\left(\mathbb{R}^{N}\right)$.

In the following proposition, we state the weak Young's inequality. For more details and proofs of this inequality, we refer [15].
Proposition 2.5. Let $1<p, q, r<\infty$ be such that $1+\frac{1}{r}=\frac{1}{p}+\frac{1}{q}$. Let $f \in L^{p, \infty}\left(\mathbb{R}^{N}\right)$ and $h \in L^{q}\left(\mathbb{R}^{N}\right)$. Then $f \star h \in L^{r}\left(\mathbb{R}^{N}\right)$, and

$$
\|f \star h\|_{r} \leq C(N, p, q)|f|_{p, \infty}\|h\|_{q} .
$$

## 3. Approximations by smooth functions with compact support

This section is devoted to proving the density of smooth functions in $W_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ and the equivalence of $[\cdot]_{s, p, a}$ with the $\stackrel{\circ}{a}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ norm. Given a measurable function $w: \mathbb{R}^{2 N} \rightarrow \mathbb{R}$, define

$$
w * \rho_{n}(x, y):=\int_{\mathbb{R}^{N}} w(x-z, y-z) \rho_{n}(z) \mathrm{d} z .
$$

Then the following hold.

Proposition 3.1. (i) For every measurable function $w_{1}: \mathbb{R}^{2 N} \rightarrow \mathbb{R}$,

$$
\iint_{\mathbb{R}^{N} \times \mathbb{R}^{N}}\left|w_{1} * \rho_{n}(x, y)\right|^{p} \frac{\mathrm{~d} x}{|x|^{a}} \frac{\mathrm{~d} y}{|y|^{a}} \leq C \iint_{\mathbb{R}^{N} \times \mathbb{R}^{N}}\left|w_{1}(x, y)\right|^{p} \frac{\mathrm{~d} x}{|x|^{a}} \frac{\mathrm{~d} y}{|y|^{a}},
$$

where $C$ is independent of $n$.
(ii) Let $\alpha=s, \sigma$. For every measurable function $w_{2}: \mathbb{R}^{N} \rightarrow \mathbb{R}$,

$$
\int_{\mathbb{R}^{N}} \frac{\left|w_{2} \star \rho_{n}(x)\right|^{p_{\alpha}^{*}}}{|x|^{\frac{2 a p_{\alpha}^{*}}{p}}} \mathrm{~d} x \leq C \int_{\mathbb{R}^{N}} \frac{\left|w_{2}(x)\right|^{p_{\alpha}^{*}}}{\left\lvert\, x^{\frac{2 a p_{\alpha}^{*}}{p}}\right.} \mathrm{~d} x
$$

where $C$ is independent of $n$.
Proof. Proof follows using [10, Proposition 4.4 and Proposition 4.5] and the fact that for each $n \in \mathbb{N}$, $\operatorname{supp}\left(\rho_{n}\right) \subset B_{1}$.

For $u \in \mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right)$, it follows from [10, Lemma 2.1] with $\frac{\partial u}{\partial x_{i}}$ that $[u]_{s, p, a}<\infty$. Moreover, using $a \in\left[0, \frac{N-s p}{2}\right)$ and $\sigma<s$,

$$
\begin{aligned}
& \|u\|_{L_{a}^{p_{s}^{*}\left(\mathbb{R}^{N}\right)}}^{p_{*}^{*}}=\int_{\mathbb{R}^{N}} \frac{|u(x)|^{p_{s}^{*}}}{\left\lvert\, x^{\frac{2 p_{s}^{*}}{p}}\right.} \mathrm{~d} x \leq\|u\|_{\infty}^{p_{s}^{*}} \int_{\operatorname{supp}(u)} \frac{\mathrm{d} x}{|x|^{\frac{2 p_{s}^{*}}{p}}}<\infty, \\
& \|\nabla u\|_{L_{a}^{p}\left(\mathbb{R}^{N}\right)}^{\|_{\sigma}^{*}}=\int_{\mathbb{R}^{N}} \frac{|\nabla u(x)|^{p_{\sigma}^{*}}}{|x|^{\frac{2 a p_{\sigma}^{*}}{p}}} \mathrm{~d} x \leq\|\nabla u\|_{\infty}^{p_{\sigma}^{*}} \int_{\operatorname{supp}(u)} \frac{\mathrm{d} x}{\left\lvert\, x^{\frac{2 a p_{\sigma}^{*}}{p}}\right.}<\infty .
\end{aligned}
$$

Thus we observe that $\mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right) \subset \grave{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$.
Proposition 3.2. Let $N \geq 2, s \in(1,2), \sigma=s-1, p \in\left(1, \frac{N}{s}\right)$, and $a \in\left[0, \frac{N-s p}{2}\right)$. Let $\rho_{n}$ and $\zeta_{n}$ be defined as in (2.5) and (2.6) respectively. Then for every $u \in \stackrel{\circ}{a}_{s, p}^{\left(\mathbb{R}^{N}\right) \text {, }}$

$$
\left[u-\left(u \star \rho_{n}\right) \zeta_{n}\right]_{s, p, a} \rightarrow 0, \text { as } n \rightarrow \infty .
$$

Proof. For $u \in \dot{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ and $\rho_{n} \in \mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right)$, we have $u \star \rho_{n} \in \mathcal{C}^{\infty}\left(\mathbb{R}^{N}\right)$ and $\left(u \star \rho_{n}\right) \zeta_{n} \in \mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right)$ (see [6, Proposition 4.20]). Using the triangle inequality, we write

$$
\begin{equation*}
\left[u-\left(u \star \rho_{n}\right) \zeta_{n}\right]_{s, p, a} \leq\left[u-u \star \rho_{n}\right]_{s, p, a}+\left[u \star \rho_{n}-\left(u \star \rho_{n}\right) \zeta_{n}\right]_{s, p, a} . \tag{3.1}
\end{equation*}
$$

We now estimate the first term of (3.1). Since $|\nabla u| \in L_{a}^{p_{\sigma}^{*}}\left(\mathbb{R}^{N}\right)$, interchange of differentiation and integration gives $\nabla\left(u \star \rho_{n}\right)=\nabla u \star \rho_{n} \in\left(L_{a}^{p_{\sigma}^{*}}\left(\mathbb{R}^{N}\right)\right)^{N}$ (applying Proposition 3.1-(ii) with $\frac{\partial u}{\partial x_{i}}$ ). Using Lemma 2.1-(i), we estimate

$$
\begin{align*}
{\left[u-u \star \rho_{n}\right]_{s, p, a}^{p} } & =\iint_{\mathbb{R}^{N} \times \mathbb{R}^{N}} \frac{\left|(\nabla u(x)-\nabla u(y))-\left(\left(\nabla u \star \rho_{n}\right)(x)-\left(\nabla u \star \rho_{n}\right)(y)\right)\right|^{p}}{|x-y|^{N+\sigma p}} \frac{\mathrm{~d} x}{|x|^{a}} \frac{\mathrm{~d} y}{|y|^{a}} \\
& =\iint_{\mathbb{R}^{N} \times \mathbb{R}^{N}} \frac{\left(\sum_{i=1}^{N}\left(\frac{\partial u}{\partial x_{i}}(x)-\frac{\partial u}{\partial x_{i}}(y)-\left(\frac{\partial u_{n}}{\partial x_{i}}(x)-\frac{\partial u_{n}}{\partial x_{i}}(y)\right)\right)^{2}\right)^{\frac{p}{2}}}{|x-y|^{N+\sigma p}} \frac{\mathrm{~d} x}{|x|^{a}} \frac{\mathrm{~d} y}{|y|^{a}} \\
& \leq C(N, p) \iint_{\mathbb{R}^{N} \times \mathbb{R}^{N}} \frac{\sum_{i=1}^{N}\left|\frac{\partial u}{\partial x_{i}}(x)-\frac{\partial u}{\partial x_{i}}(y)-\left(\frac{\partial u_{n}}{\partial x_{i}}(x)-\frac{\partial u_{n}}{\partial x_{i}}(y)\right)\right|^{p}}{|x-y|^{N+\sigma p}} \frac{\mathrm{~d} x}{|x|^{a}} \frac{\mathrm{~d} y}{|y|^{a}} \\
& =C(N, p) \sum_{i=1}^{N} \iint_{\mathbb{R}^{N} \times \mathbb{R}^{N}} \frac{\left|\frac{\partial u}{\partial x_{i}}(x)-\frac{\partial u}{\partial x_{i}}(y)-\left(\frac{\partial u_{n}}{\partial x_{i}}(x)-\frac{\partial u_{n}}{\partial x_{i}}(y)\right)\right|^{p}}{|x-y|^{N+\sigma p}} \frac{\mathrm{~d} x}{|x|^{a}} \frac{\mathrm{~d} y}{|y|^{a}} . \tag{3.2}
\end{align*}
$$

Further, using Lemma 2.1-(ii), we find

$$
[u]_{s, p, a}^{p}=\iint_{\mathbb{R}^{N} \times \mathbb{R}^{N}} \frac{|\nabla u(x)-\nabla u(y)|^{p}}{|x-y|^{N+\sigma p}} \frac{\mathrm{~d} x}{|x|^{a}} \frac{\mathrm{~d} y}{|y|^{a}} \geq C(N, p) \sum_{i=1}^{N} \iint_{\mathbb{R}^{N} \times \mathbb{R}^{N}} \frac{\frac{\partial u}{\partial x_{i}}(x)-\left.\frac{\partial u}{\partial x_{i}}(y)\right|^{p}}{|x-y|^{N+\sigma p}} \frac{\mathrm{~d} x}{|x|^{a}} \frac{\mathrm{~d} y}{|y|^{a}},
$$

which implies that for each $i=1, \cdot, \cdot, \cdot, N$,

$$
\begin{equation*}
\iint_{\mathbb{R}^{N} \times \mathbb{R}^{N}}\left|w_{i}(x, y)\right|^{p} \frac{\mathrm{~d} x}{|x|^{a}} \frac{\mathrm{~d} y}{|y|^{a}}<\infty, \tag{3.3}
\end{equation*}
$$

where

$$
\begin{equation*}
w_{i}(x, y)=\frac{\frac{\partial u}{\partial x_{i}}(x)-\frac{\partial u}{\partial x_{i}}(y)}{|x-y|^{\frac{N}{p}+\sigma}}, \text { for } x, y \in \mathbb{R}^{N} \tag{3.4}
\end{equation*}
$$

For each $i=1, \cdot, \cdot, \cdot, N$, now we apply [10, Lemma 6.1] with $\frac{\partial u}{\partial x_{i}}$ to obtain

$$
\begin{equation*}

& \leq C \frac{n^{p-\sigma p}}{n^{2 a}}\left(\int_{B_{2 n} \backslash B_{n}} \frac{\left|u_{n}(y)\right|^{p_{s}^{*}}}{|y|^{\frac{2 a p_{s}^{*}}{p}}} \mathrm{~d} y\right)^{\frac{p}{p_{s}^{*}}}\left(\int_{B_{2 n} \backslash B_{n}}^{|y|^{\frac{2 a N}{s p}}} \mathrm{~d} y\right)^{\frac{s p}{N}}(\text { by Hölder's inequality) } \\
& \leq C \frac{n^{p-\sigma p+2 a+s p}}{n^{2 a}}\left(\int_{B_{2 n} \backslash B_{n}} \frac{\left|u_{n}(y)\right|^{p_{s}^{*}}}{|y|^{\frac{2 p_{s}^{*}}{p}}} \mathrm{~d} y\right)^{\frac{p}{p_{s}^{*}}}=C n^{2 p}\left(\int_{B_{2 n} \backslash B_{n}} \frac{\left|u_{n}(y)\right|^{p_{s}^{*}}}{|y|^{\frac{2 a p_{s}^{*}}{p}}} \mathrm{~d} y\right)^{\frac{p}{p_{s}^{*}}}, \tag{3.19}

\end{equation*}

From (3.17), (3.18) and (3.20), we get the following inequality

& \leq \underbrace{\frac{C}{n^{p}} \iint_{\left(B_{2 n} \backslash B_{n}\right) \times\left(B_{3 n}^{c}\right)} \frac{\mid u_{n}\left(\left.x\right|^{p}\right.}{|x-y|^{N+\sigma p}} \frac{\mathrm{~d} x}{|x|^{a}} \frac{\mathrm{~d} y}{|y|^{a}}}_{A_{n, i}}+\underbrace{\frac{C}{n^{2 p}} \iint_{\left(B_{2 n} \backslash B_{n}\right) \times\left(B_{3 n} \backslash B_{2 n}\right)} \frac{\left|u_{n}(x)\right|^{p}}{|x-y|^{N+\sigma p-p}} \frac{\mathrm{~d} x}{|x|^{a}} \frac{\mathrm{~d} y}{|y|^{a}}}_{B_{n, i}},
\end{aligned}

\end{aligned}

& \leq \frac{C(N, p)}{n^{p+2 a}} \iint_{\left(B_{2 n} \backslash B_{n}\right) \times\left(B_{2 n} \backslash B_{n}\right)}\left(\int_{B_{\frac{1}{n}}}\left(\int_{0}^{1}|\nabla u(\theta)|^{p} \mathrm{~d} t\right) \rho_{n}(z) \mathrm{d} z\right) \frac{\mathrm{d} x \mathrm{~d} y}{|x-y|^{N+\sigma p-p}} \tag{3.27}
\end{align*}

where $\theta=t(x-z)+(1-t)(y-z)$. Consider the following function

& \leq C(N, p) c_{1}(n) n^{p} \int_{B_{\frac{1}{n}}} \rho_{n}(z) \mathrm{d} z=C(N, p) c_{1}(n) n^{p}
\end{aligned}
$$

and $\int_{0}^{1} f(t) \mathrm{d} t \leq C(N, p) c_{1}(n) n^{p}$. Hence for $n \geq n_{0}$ using Tonneli's theorem,

A \in L^{1}\left(\left(B_{2 n} \backslash B_{n}\right) \times\left(B_{2 n} \backslash B_{n}\right) \times B_{\frac{1}{n}} \times(0,1)\right)

and subsequently using Fubini's theorem, from (3.27) we obtain

\end{equation*}
$$

Take $\epsilon>0$. Then using the convergence in (3.32) there exists $n_{1}\left(\geq n_{0}\right) \in \mathbb{N}$ such that for $n \geq n_{1}$, using (3.31) and (3.33), we conclude

& \leq C(N, p) \int_{0}^{1}\left(\int_{B_{\frac{1}{n}}}\left(\int_{B_{n}^{c}} h_{1}(t, \cdot, z)^{r} \mathrm{~d} x\right)^{\frac{1}{r}} \rho_{n}(z) \mathrm{d} z\right) \mathrm{d} t<C(N, p) \epsilon
\end{aligned}
$$

Therefore, $\lim _{n \rightarrow \infty} F_{n, i}=0$. In conclusion, we get $\lim _{n \rightarrow \infty} I_{n, i, 3}=0$.
Finally, taking limit as $n \rightarrow \infty$ in (3.16) and using the convergence of $I_{n, i, k}, k=1, \cdot, \cdot, \cdot, 5$, we get

Remark 3.3. In view of Proposition 3.2 and the definition of $\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$, we infer that $\dot{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right) \subset$ $\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$. More precisely, if $u \in \grave{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$, then using Proposition 3.2 there exists $\left\{u_{n}\right\} \subset \mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right)$ such that $\left[u-u_{n}\right]_{s, p, a} \rightarrow 0$ as $n \rightarrow \infty$, which implies that $u \in \mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$.

In the following proposition, we prove that the seminorm $[\cdot]_{s, p, a}$ is an equivalent norm in $\dot{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$.
Proposition 3.4. Let $N \geq 2, s \in(1,2), \sigma=s-1, p \in\left(1, \frac{N}{s}\right)$, and $a \in\left[0, \frac{N-s p}{2}\right)$. Then there exists $C=C(N, p, \sigma, a)>0$ such that

For $u \in \stackrel{\circ}{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$, we consider the same sequence $v_{n}=\left(u \star \rho_{n}\right) \zeta_{n}$ for $n \in \mathbb{N}$ as in Proposition 3.2. Then $v_{n} \in \mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right)$. Using [1, Theorem 1.5] with $\frac{\partial v_{n}}{\partial x_{i}}$ and Lemma 2.1, we get

& =\left\|\nabla u-\left(\nabla u \star \rho_{n}\right) \zeta_{n}-\left(u \star \rho_{n}\right) \nabla \zeta_{n}\right\|_{L_{o}^{p_{\sigma}^{*}}\left(\mathbb{R}^{N}\right)} \leq \underbrace{\left\|\nabla u \star \rho_{n}-\left(\nabla u \star \rho_{n}\right) \zeta_{n}\right\|_{L_{a}^{p_{\sigma}^{*}}\left(\mathbb{R}^{N}\right)}}_{A_{n}}+\underbrace{\left\|\nabla u-\nabla u \star \rho_{n}\right\|_{L_{a}^{p_{\sigma}^{*}}\left(\mathbb{R}^{N}\right)}}_{B_{n}}+\underbrace{\left\|\left(u \star \rho_{n}\right) \nabla \zeta_{n}\right\|_{L_{a}^{p_{o}^{*}}\left(\mathbb{R}^{N}\right)}}_{C_{n}} .
\end{align*}
$$

As before, we define $\varphi_{n}=1-\zeta_{n}$. By noticing $0 \leq \varphi_{n} \leq 1$, we deduce

& \leq A\left(N, \frac{p_{\sigma}^{*}}{2}\right) \sum_{i=1}^{N} \int_{\mathbb{R}^{N}}\left|\frac{\partial u_{n}}{\partial x_{i}} \varphi_{n}\right|^{p_{\sigma}^{*}} \frac{\mathrm{~d} x}{|x|^{\frac{2 a p_{\sigma}^{*}}{p}}}(\text { using Lemma 2.1-(i)) } \\
& \leq 2^{p_{\sigma}^{*}-1} A\left(N, \frac{p_{\sigma}^{*}}{2}\right)\left(\sum_{i=1}^{N} \int_{\mathbb{R}^{N}}\left|\left(\frac{\partial u_{n}}{\partial x_{i}}-\frac{\partial u}{\partial x_{i}}\right) \varphi_{n}\right|^{p_{\sigma}^{*}} \frac{\mathrm{~d} x}{|x|^{\frac{2 a p_{\sigma}^{*}}{p}}}+\sum_{i=1}^{N} \int_{\mathbb{R}^{N}}\left|\frac{\partial u}{\partial x_{i}} \varphi_{n}\right|^{p_{\sigma}^{*}} \frac{\mathrm{~d} x}{|x|^{\frac{2 a p_{\sigma}^{*}}{p}}}\right) \\
& \leq 2^{p_{\sigma}^{*}-1} A\left(N, \frac{p_{\sigma}^{*}}{2}\right)\left(\sum_{i=1}^{N} \int_{\mathbb{R}^{N}}\left|\frac{\partial u}{\partial x_{i}}-\frac{\partial u_{n}}{\partial x_{i}}\right|^{p_{\sigma}^{*}} \frac{\mathrm{~d} x}{\left.|x|^{\frac{2 p_{\sigma}^{*}}{p}}+\sum_{i=1}^{N} \int_{\mathbb{R}^{N}}\left|\frac{\partial u}{\partial x_{i}} \varphi_{n}\right|^{p_{\sigma}^{*}} \frac{\mathrm{~d} x}{|x|^{\frac{2 p_{p}^{*}}{p}}}\right) .}\right. \tag{3.39}
\end{align*}
$$

Since $|\nabla u| \in L_{a}^{p_{\sigma}^{*}}\left(\mathbb{R}^{N}\right)$, we get $\frac{\partial u}{\partial x_{i}} \in L_{a}^{p_{\sigma}^{*}}\left(\mathbb{R}^{N}\right)$. Thus, applying [10, Lemma 6.1] with $\frac{\partial u}{\partial x_{i}}$, we have

By noticing that $\operatorname{supp}\left(\zeta_{n}\right) \subset \overline{B_{2 n}}$ and $\operatorname{supp}\left(\varphi_{n}\right) \subset B_{n}^{c}$, the dominated convergence theorem yields

& \leq A\left(N, \frac{p_{\sigma}^{*}}{2}\right) \sum_{i=1}^{N} \int_{\mathbb{R}^{N}}\left|\frac{\partial u}{\partial x_{i}}-\frac{\partial u_{n}}{\partial x_{i}}\right|^{p_{\sigma}^{*}} \frac{\mathrm{~d} x}{\left\lvert\, x^{\frac{2 a p_{\sigma}^{*}}{p}}\right.} .
\end{aligned}
$$

We use (3.40) in the above inequality to get

& \leq \frac{C(N, p, \sigma)}{n^{p_{\sigma}^{*}}} \int_{B_{2 n} \backslash B_{n}}\left|u \star \rho_{n}\right|^{p_{\sigma}^{*}} \frac{\mathrm{~d} x}{\left.\left|x^{\frac{2 a p_{\sigma}^{*}}{p}} \leq \frac{C(N, p, \sigma)}{n^{p_{\sigma}^{*}+\frac{2 a p_{\sigma}^{*}}{p}}} \int_{B_{2 n} \backslash B_{n}}\right| \int_{B_{\frac{1}{n}}} u(x-z) \rho_{n}(z) \mathrm{d} z\right|^{p_{\sigma}^{*}} \mathrm{~d} x} \\
& \leq \frac{C(N, p, \sigma)}{n^{p_{\sigma}^{*}+\frac{2 a p_{\sigma}^{*}}{p}}} \int_{B_{2 n} \backslash B_{n}}\left(\int_{B_{\frac{1}{n}}}|u(x-z)|^{p_{\sigma}^{*}} \rho_{n}(z) \mathrm{d} z\right) \mathrm{d} x . \tag{3.44}
\end{align*}
$$

The last inequality follows using Jensen's inequality ( $\rho_{n} \mathrm{~d} z$ is a probability measure and $\operatorname{supp}\left(\rho_{n}\right) \subset$ $\overline{B_{\frac{1}{n}}}$. For $x \in B_{2 n} \backslash B_{n}$ and $z \in B_{\frac{1}{n}}$, we have

& \leq c_{2}(n) \rho_{n}(z) \int_{B_{2 n} \backslash B_{n}} \frac{|u(x-z)|^{p_{\sigma}^{*}}}{|x-z|^{\frac{2 p_{\sigma}^{*}}{p}}} \mathrm{~d} x \text {, where } c_{2}(n)=\left(2 n+\frac{1}{n}\right)^{\frac{2 a p_{\sigma}^{*}}{p}} \\
& \leq c_{2}(n) \rho_{n}(z)\left(\int_{B_{2 n} \backslash B_{n}} \frac{|u(x-z)|^{p_{s}^{*}}}{|x-z|^{\frac{2 p_{p}^{*}}{p}}} \mathrm{~d} x\right)^{\frac{p_{\sigma}^{*}}{p_{s}^{*}}}\left(\int_{B_{2 n} \backslash B_{n}} \mathrm{~d} x\right)^{\frac{p}{N-\sigma p}}
\end{aligned}
$$

Thus we obtain

Since $u \in L_{a}^{p_{s}^{*}}\left(\mathbb{R}^{N}\right)$, for arbitrary $0<\epsilon<1$, there exists $n_{\epsilon} \in \mathbb{N}$ such that

\left(\int_{B_{n}^{c}} \frac{|u(x-z)|^{p_{s}^{*}}}{|x-z|^{\frac{2 a p_{s}^{*}}{p}}} \mathrm{~d} x\right)^{\frac{p_{*}^{*}}{p_{s}^{s}}}<\epsilon, \forall n \geq n_{\epsilon} . \tag{3.46}
\end{equation*}
$$

Using (3.46), for $n \geq n_{\epsilon}$ we obtain

\int_{B_{2 n} \backslash B_{n}} F(x, z) \mathrm{d} x \leq C(N, p, \sigma) c_{3}(n) \rho_{n}(z) \epsilon,
$$

where $c_{3}(n)=n^{\frac{2 a p_{\sigma}^{*}}{p}}+p_{\sigma}^{*}$. Further, we see that for every $n \geq n_{\epsilon}$,

\end{equation*}

Therefore, Tonelli's theorem yields $F \in L^{1}\left(\left(B_{2 n} \backslash B_{n}\right) \times B_{\frac{1}{n}}\right)$. Subsequently, applying Fubini's theorem in (3.44) and then using (3.47) we get

Therefore,

\end{equation*}
$$

From (3.38), (3.42), (3.43) and (3.48), we obtain (3.37). Moreover, we know from Proposition 3.2 that

Proof of Theorem 1.1-((i) and (ii)): The proof of part-(i) and part-(ii) is followed from Proposition 3.2 and Proposition 3.4, respectively.

## 4. Characterization of fractional weighted homogeneous spaces

Now, we proceed to characterize the function space $\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$. In the following proposition, we show that every Cauchy sequence in $\mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right)$ converges to a function in $\dot{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ with respect to the Gagliardo seminorm $[\cdot]_{s, p, a}$.

Proposition 4.1. Let $N \geq 2, s \in(1,2), \sigma=s-1, p \in\left(1, \frac{N}{s}\right)$, and $a \in\left[0, \frac{N-s p}{2}\right)$. Let $\left\{w_{n}\right\} \subset$ $\mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right)$ be a Cauchy sequence with respect to $[\cdot]_{s, p, a}$. Then there exists $w \in \grave{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ such that

$$
\left[w-w_{n}\right]_{s, p, a} \rightarrow 0, \text { as } n \rightarrow \infty,
$$

Proof. Let $\epsilon>0$ be given. By hypothesis, there exists $n_{\epsilon} \in \mathbb{N}$ such that

\left[w_{n}-w_{m}\right]_{s, p, a}<\epsilon, \forall m, n \geq n_{\epsilon} . \tag{4.1}
\end{equation*}
$$

By [7, Theorem 1], we have

\|u\|_{L_{a}^{p_{s}^{*}\left(\mathbb{R}^{N}\right)}} \leq C_{1}(N, p, \sigma, a)\|\nabla u\|_{L_{a}^{p_{a}^{*}}\left(\mathbb{R}^{N}\right)}, \forall u \in \mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right) . \tag{4.2}
\end{equation*}
$$

Further, by Proposition 3.4,

\|\nabla u\|_{L_{a}^{p_{\sigma}^{*}}\left(\mathbb{R}^{N}\right)} \leq C_{2}(N, p, \sigma, a)[u]_{s, p, a}, \forall u \in \mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right), \tag{4.3}
\end{equation*}
$$

From (4.1), (4.2), (4.3), and the fact that $\left\{w_{n}\right\} \subset \mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right)$, we get $\left\{w_{n}\right\}$ is Cauchy in $L_{a}^{p_{s}^{*}}\left(\mathbb{R}^{N}\right)$ and $\left\{\frac{\partial w_{n}}{\partial x_{i}}\right\}$ is Cauchy in $L_{a}^{p_{\sigma}^{*}}\left(\mathbb{R}^{N}\right)$. Consequently, $w_{n} \rightarrow w$ in $L_{a}^{p_{s}^{*}}\left(\mathbb{R}^{N}\right)$ and $\frac{\partial w_{n}}{\partial x_{i}} \rightarrow v_{i}$ in $L_{a}^{p_{\sigma}^{*}}\left(\mathbb{R}^{N}\right)$. Moreover, up to a subsequence, $w_{n} \rightarrow w$ and $\frac{\partial w_{n}}{\partial x_{i}} \rightarrow v_{i}$ a.e. in $\mathbb{R}^{N}$. To show $v_{i}=\frac{\partial w}{\partial x_{i}}$, we consider $\varphi \in \mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right)$ with $\operatorname{supp}(\varphi) \subset K$, where $K$ is a bounded open set of class $\mathcal{C}^{1,1}$. The integration by parts formula yields

$$
\begin{equation*}
\int_{\mathbb{R}^{N}} w_{n} \frac{\partial \varphi}{\partial x_{i}} \mathrm{~d} x=\int_{K} w_{n} \frac{\partial \varphi}{\partial x_{i}} \mathrm{~d} x=-\int_{K} \frac{\partial w_{n}}{\partial x_{i}} \varphi \mathrm{~d} x=-\int_{\mathbb{R}^{N}} \frac{\partial w_{n}}{\partial x_{i}} \varphi \mathrm{~d} x . \tag{4.4}
\end{equation*}
$$

Using Hölder's inequality and $w_{n} \rightarrow w$ in $L_{a}^{p_{s}^{*}}\left(\mathbb{R}^{N}\right)$, we get

$$
\begin{align*}
& \left|\int_{\mathbb{R}^{N}}\left(w-w_{n}\right) \frac{\partial \varphi}{\partial x_{i}} \mathrm{~d} x\right| \leq\left\|\frac{\partial \varphi}{\partial x_{i}}\right\|_{\infty} \int_{K}\left|w-w_{n}\right| \mathrm{d} x \\
& =\left\|\frac{\partial \varphi}{\partial x_{i}}\right\|_{\infty} \int_{K} \frac{\left|w-w_{n}\right|}{|x|^{\frac{2 a}{p}}} \cdot|x|^{\frac{2 a}{p}} \mathrm{~d} x \leq\left\|\frac{\partial \varphi}{\partial x_{i}}\right\|_{\infty}\left(\int_{K} \frac{\left|w-w_{n}\right|^{p_{s}^{*}}}{|x|^{\frac{2 a p_{s}^{*}}{p}}} \mathrm{~d} x\right)^{\frac{1}{p_{s}^{*}}}\left(\int _ { K } \left(|x|^{\left.\left.\frac{2 a}{p}\right)^{\frac{p_{s}^{*}}{p_{s}^{*}-1}} \mathrm{~d} x\right)^{\frac{p_{s}^{*}-1}{p_{s}^{*}}}}\right.\right. \\
& \leq C(N, p, \sigma, a, K)\left\|\frac{\partial \varphi}{\partial x_{i}}\right\|_{\infty}\left\|w-w_{n}\right\|_{L_{a}^{p_{s}^{*}\left(\mathbb{R}^{N}\right)}} \rightarrow 0, \text { as } n \rightarrow \infty . \tag{4.5}
\end{align*}
$$

Using $\frac{\partial w_{n}}{\partial x_{i}} \rightarrow v_{i}$ in $L_{a}^{p_{\sigma}^{*}}\left(\mathbb{R}^{N}\right)$ and similar calculations as in (4.5), we also get

$$
\begin{equation*}
\left|\int_{\mathbb{R}^{N}}\left(v_{i}-\frac{\partial w_{n}}{\partial x_{i}}\right) \varphi \mathrm{d} x\right| \rightarrow 0, \text { as } n \rightarrow \infty \tag{4.6}
\end{equation*}
$$

Taking the limit as $n \rightarrow \infty$ in (4.4), and using (4.5) and (4.6),

$$
\int_{\mathbb{R}^{N}} w \frac{\partial \varphi}{\partial x_{i}} \mathrm{~d} x=-\int_{\mathbb{R}^{N}} v_{i} \varphi \mathrm{~d} x, \forall \varphi \in \mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right),
$$

which implies $\frac{\partial w}{\partial x_{i}}=v_{i} \in L_{a}^{p_{\sigma}^{*}}\left(\mathbb{R}^{N}\right)$, and hence $|\nabla w| \in L_{a}^{p_{\sigma}^{*}}\left(\mathbb{R}^{N}\right)$ (by Lemma 2.1-(i)). For $n \geq n_{\epsilon}$, the triangle inequality and (4.1) give

$$
\begin{equation*}
\left[w_{n}\right]_{s, p, a} \leq\left[w_{n}-w_{n_{\epsilon}}\right]_{s, p, a}+\left[w_{n_{\epsilon}}\right]_{s, p, a}<\epsilon+\left[w_{n_{\epsilon}}\right]_{s, p, a} . \tag{4.7}
\end{equation*}
$$

For a.e. $(x, y) \in \mathbb{R}^{N} \times \mathbb{R}^{N}$, we define

$$
\begin{equation*}
V_{n}(x, y)=\frac{\left|\nabla w_{n}(x)-\nabla w_{n}(y)\right|^{p}}{|x-y|^{N+\sigma p}|x|^{a}|y|^{a}} \text { and } V(x, y)=\frac{|\nabla w(x)-\nabla w(y)|^{p}}{|x-y|^{N+\sigma p}|x|^{a}|y|^{a}} . \tag{4.8}
\end{equation*}
$$

Using (4.7), $\left\{V_{n}\right\}$ is bounded in $L^{1}\left(\mathbb{R}^{N} \times \mathbb{R}^{N}\right)$. Since $\frac{\partial w_{n}}{\partial x_{i}} \rightarrow \frac{\partial w}{\partial x_{i}}$ a.e. in $\mathbb{R}^{N}$, we get $V_{n} \rightarrow V$ a.e. in $\mathbb{R}^{N} \times \mathbb{R}^{N}$. Hence the Fatou's Lemma yields

$$
[w]_{s, p, a}^{p}=\iint_{\mathbb{R}^{N} \times \mathbb{R}^{N}} V(x, y) \mathrm{d} x \mathrm{~d} y \leq \liminf _{n \rightarrow \infty} \iint_{\mathbb{R}^{N} \times \mathbb{R}^{N}} V_{n}(x, y) \mathrm{d} x \mathrm{~d} y<\infty .
$$

Therefore, $w \in \stackrel{\circ}{a}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$. Now we show that $w_{n} \rightarrow w$ in $\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$. We define

$$
V_{n, i}(x, y)=\frac{\frac{\partial w_{n}}{\partial x_{i}}(x)-\frac{\partial w_{n}}{\partial x_{i}}(y)}{|x-y|^{\frac{N}{p} p \sigma}|x|^{\frac{a}{p}}|y|^{\frac{a}{p}}} \text {, for a.e. }(x, y) \in \mathbb{R}^{N} \times \mathbb{R}^{N} .
$$

Using Lemma 2.1-(ii), we have

$$
\begin{align*}
& {\left[w_{n}-w_{m}\right]_{s, p, a}^{p}=\iint_{\mathbb{R}^{N} \times \mathbb{R}^{N}} \frac{\left|\left(\nabla w_{n}(x)-\nabla w_{n}(y)\right)-\left(\nabla w_{m}(x)-\nabla w_{m}(y)\right)\right|^{p}}{|x-y|^{N+\sigma p}} \frac{\mathrm{~d} x}{|x|^{N}} \frac{\mathrm{~d} y}{|y|^{a}}} \\
& \geq B\left(N, \frac{p}{2}\right)\left(\sum_{i=1}^{N} \iint_{\mathbb{R}^{N} \times \mathbb{R}^{N}} \frac{\left|\left(\frac{\partial w_{n}}{\partial x_{i}}(x)-\frac{\partial w_{n}}{\partial x_{i}}(y)\right)-\left(\frac{\partial w_{m}}{\partial x_{i}}(x)-\frac{\partial w_{m}}{\partial x_{i}}(y)\right)\right|^{p}}{|x-y|^{N+\sigma p}} \frac{\mathrm{~d} x}{|x|^{a}} \frac{\mathrm{~d} y}{|y|^{a}}\right) \\
& =B\left(N, \frac{p}{2}\right) \sum_{i=1}^{N}\left\|V_{n, i}-V_{m, i}\right\|_{L^{p}\left(\mathbb{R}^{N} \times \mathbb{R}^{N}\right)}^{p} . \tag{4.9}
\end{align*}
$$

From (4.1) and (4.9), we deduce that for each $i$, the sequence $\left\{V_{n, i}\right\}$ is Cauchy in $L^{p}\left(\mathbb{R}^{N} \times \mathbb{R}^{N}\right)$. By completeness of $L^{p}\left(\mathbb{R}^{N} \times \mathbb{R}^{N}\right)$, there exists $V_{i} \in L^{p}\left(\mathbb{R}^{N} \times \mathbb{R}^{N}\right)$ such that $V_{n, i} \rightarrow V_{i}$ in $L^{p}\left(\mathbb{R}^{N} \times \mathbb{R}^{N}\right)$. Also, $\frac{\partial w_{n}}{\partial x_{i}} \rightarrow \frac{\partial w}{\partial x_{i}}$ a.e. in $\mathbb{R}^{N}$. Therefore, to the uniqueness of the limit,

$$
V_{i}(x, y)=\frac{\frac{\partial w}{\partial x_{i}}(x)-\frac{\partial w}{\partial x_{i}}(y)}{|x-y|^{\frac{N}{p}+\sigma}|x|^{\frac{\alpha}{p}}|y|^{\frac{a}{p}}} \text {, for a.e. }(x, y) \in \mathbb{R}^{N} \times \mathbb{R}^{N} \text {. }
$$

Therefore,

$$
\begin{aligned}
{\left[w-w_{n}\right]_{s, p, a}^{p} } & =\iint_{\mathbb{R}^{N} \times \mathbb{R}^{N}} \frac{\left|(\nabla w(x)-\nabla w(y))-\left(\nabla w_{n}(x)-\nabla w_{n}(y)\right)\right|^{p}}{|x-y|^{N+\sigma p}} \frac{\mathrm{~d} x}{|x|^{a}} \frac{\mathrm{~d} y}{|y|^{a}} \\
& \leq A\left(N, \frac{p}{2}\right)\left(\sum_{i=1}^{N} \iint_{\mathbb{R}^{N} \times \mathbb{R}^{N}} \frac{\left|\left(\frac{\partial w}{\partial x_{i}}(x)-\frac{\partial w}{\partial x_{i}}(y)\right)-\left(\frac{\partial w_{n}}{\partial x_{i}}(x)-\frac{\partial w_{n}}{\partial x_{i}}(y)\right)\right|^{p}}{|x-y|^{N+\sigma p}} \frac{\mathrm{~d} x}{|x|^{a}} \frac{\mathrm{~d} y}{|y|^{a}}\right) \\
& =A\left(N, \frac{p}{2}\right) \sum_{i=1}^{N}\left\|V_{i}-V_{n, i}\right\|_{L^{p}\left(\mathbb{R}^{N} \times \mathbb{R}^{N}\right)}^{p} \rightarrow 0, \text { as } n \rightarrow \infty .
\end{aligned}
$$

This completes the proof.

Completions. From Proposition 3.4, the seminorm $[\cdot]_{s, p, a}$ becomes a norm in the space $\mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right)$. However, $\mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right)$ is not complete with respect to this norm. This leads us to define the completion of $\mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right)$ with respect to $[\cdot]_{s, p, a}$. Let $V$ be the vector space of Cauchy sequences in $\mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right)$ and $V_{0}$ be the subspace of $V$ consisting of the sequences converging to zero. We define an equivalence relation on $V$ by

$$
\boldsymbol{u} \sim \boldsymbol{v} \Longleftrightarrow \boldsymbol{u}-\boldsymbol{v} \in V_{0}
$$

i.e., two sequences $\boldsymbol{u}=\left\{u_{n}\right\}$ and $\boldsymbol{v}=\left\{v_{n}\right\}$ in $V$ are said to be equivalent if and only if

$$
\begin{equation*}
\lim _{n \rightarrow \infty}\left[u_{n}-v_{n}\right]_{s, p, a}=0 . \tag{4.10}
\end{equation*}
$$

The equivalence class containing a vector $\boldsymbol{u} \in V$ is called a coset, and it is denoted as $\boldsymbol{u}+V_{0}$ and defined by

$$
\boldsymbol{u}+V_{0}:=\left\{\boldsymbol{u}+\boldsymbol{w}: \boldsymbol{w} \in V_{0}\right\} .
$$

The set of all cosets forms a quotient space and is defined as

$$
V / V_{0}:=\left\{\boldsymbol{u}+V_{0}: \boldsymbol{u} \in V\right\},
$$

and it becomes a vector space under the following addition and scalar multiplication:

$$
\left(\boldsymbol{u}+V_{0}\right)+\left(\boldsymbol{v}+V_{0}\right)=(\boldsymbol{u}+\boldsymbol{v})+V_{0} \text { and } \alpha\left(\boldsymbol{u}+V_{0}\right)=\alpha \boldsymbol{u}+V_{0}, \forall \boldsymbol{u}, \boldsymbol{v} \in V, \alpha \in \mathbb{R} .
$$

We define

$$
\begin{equation*}
\left\|\boldsymbol{u}+V_{0}\right\|:=\lim _{n \rightarrow \infty}\left[u_{n}\right]_{s, p, a} \tag{4.11}
\end{equation*}
$$

Since $\boldsymbol{u} \in V$, the sequence $\boldsymbol{u}=\left\{u_{n}\right\}$ is Cauchy with respect to $[\cdot]_{s, p, a}$ and therefore the sequence $\left\{\left[u_{n}\right]_{s, p, a}\right\}$ is Cauchy in $\mathbb{R}$ by the following inequality

$$
\left|\left[u_{n}\right]_{s, p, a}-\left[u_{m}\right]_{s, p, a}\right| \leq\left[u_{n}-u_{m}\right]_{s, p, a} .
$$

By completeness of $\mathbb{R}$, the sequence $\left\{\left[u_{n}\right]_{s, p, a}\right\}$ converges in $\mathbb{R}$ and hence the right hand quantity in (4.11) is well defined. Further, if $\boldsymbol{u}=\left\{u_{n}\right\}$ and $\boldsymbol{v}=\left\{v_{n}\right\}$ are Cauchy sequences such that $\left\{u_{n}-v_{n}\right\} \in V_{0}$, then by the following inequalities

$$
\left[u_{n}\right]_{s, p, a} \leq\left[u_{n}-v_{n}\right]_{s, p, a}+\left[v_{n}\right]_{s, p, a} \text { and }\left[v_{n}\right]_{s, p, a} \leq\left[u_{n}-v_{n}\right]_{s, p, a}+\left[u_{n}\right]_{s, p, a},
$$

it follows that $\lim _{n \rightarrow \infty}\left[u_{n}\right]_{s, p, a}=\lim _{n \rightarrow \infty}\left[v_{n}\right]_{s, p, a}$. Thus, (4.11) is well defined, and it is independent of the choice of a representative of the coset.

Remark 4.2. Using [21, Section 10, Page 56], we can verify that $\|\cdot\|$ becomes a norm on $V / V_{0}$ and $V / V_{0}$ forms a Banach space with respect to $\|\cdot\|$ and this space is unique upto isometric isomorphism.
Since $\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ is a completion of $\left(\mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right),[\cdot]_{s, p, a}\right)$, we can identify the spaces $V / V_{0}$ and $\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$. Each element of $\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ is considered as an equivalence class $U=\left\langle\left\{u_{n}\right\}\right\rangle$, where the Cauchy sequence $\left\{u_{n}\right\}$ in $\mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right)$ is a representative of the class. Due to the isometric isomorphism between $\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ and $V / V_{0}$, the norm on $\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ in terms of its representative is given by

$$
\|U\|_{\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)}=\lim _{n \rightarrow \infty}\left[u_{n}\right]_{s, p, a} .
$$

Proof of Theorem 1.1-(iii): Using Proposition 3.4, it follows that $[\cdot]_{s, p, a}$ defines a norm on $\dot{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$. Now, we will show the existence of an isometric isomorphism between $\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ and $\check{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$, thereby establishing that $\stackrel{\circ}{a}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ is a Banach space. Let $U=\left\langle\left\{u_{n}\right\}\right\rangle \in \mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$. By Proposition 4.1, $u_{n} \rightarrow u$ with respect to $[\cdot]_{s, p, a}$ for some $u \in \stackrel{\circ}{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$. We define a map $\mathcal{J}: \mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right) \rightarrow \grave{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ as

$$
\mathcal{J}(U)=u
$$

If $\left\{v_{n}\right\}$ is another representative of the equivalence class $U$, then using the equivalence relation (4.10), we have

$$
\lim _{n \rightarrow \infty}\left[u-v_{n}\right]_{s, p, a} \leq \lim _{n \rightarrow \infty}\left[u-u_{n}\right]_{s, p, a}+\lim _{n \rightarrow \infty}\left[u_{n}-v_{n}\right]_{s, p, a}=0 .
$$

Thus, the map $\mathcal{J}$ is well-defined, and one can verify that it is linear. Further, the map $\mathcal{J}$ is an isometry by Proposition 4.1 i.e.,

$$
\|U\|_{\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)}=\lim _{n \rightarrow \infty}\left[u_{n}\right]_{s, p, a}=[u]_{s, p, a}
$$

Now we claim that $\mathcal{J}$ is surjective. It follows from Proposition 3.2 that for every $w \in \dot{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$, there exists $\left\{w_{n}\right\} \subset \mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right)$ such that

$$
\lim _{n \rightarrow \infty}\left[w-w_{n}\right]_{s, p, a}=0 .
$$

Since $\left\{w_{n}\right\}$ is Cauchy with respect to $[\cdot]_{s, p, a}$, it is a representative of some equivalence class $W$ i.e., $W=\left\langle\left\{w_{n}\right\}\right\rangle$. Thus, we obtain

$$
\mathcal{J}(W)=w
$$

which implies $\mathcal{J}$ is surjective. Hence, $\mathcal{J}$ is a linear surjective isometry.

## 5. Fractional weighted Rellich inequality and finer embeddings

First, we recall the Caffarelli-Kohn-Nirenberg inequality [7].
Theorem 5.1 (Caffarelli-Kohn-Nirenberg). Let $p, q, r, \alpha, \beta, \gamma$ and $l$ be real numbers such that $p, q \geq$ $1, r>0,0 \leq l \leq 1$, and

$$
\frac{1}{p}+\frac{\alpha}{N}, \frac{1}{q}+\frac{\beta}{N}, \frac{1}{r}+\frac{m}{N}>0
$$

where $m=l \gamma+(1-l) \beta$. Then there exists a positive constant $C$ such that

$$
\left(\int_{\mathbb{R}^{N}}|x|^{m r}|u(x)|^{r} \mathrm{~d} x\right)^{\frac{1}{r}} \leq C\left(\int_{\mathbb{R}^{N}}|x|^{\alpha p}|\nabla u(x)|^{p} \mathrm{~d} x\right)^{\frac{l}{p}}\left(\int_{\mathbb{R}^{N}}|x|^{\beta q}|u(x)|^{q} \mathrm{~d} x\right)^{\frac{1-l}{q}}, \forall u \in \mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right),
$$

if and only if the following relations hold

$$
\frac{1}{r}+\frac{m}{N}=l\left(\frac{1}{p}+\frac{\alpha-1}{N}\right)+(1-l)\left(\frac{1}{q}+\frac{\beta}{N}\right)
$$

with

$$
0 \leq \alpha-\gamma \text { if } l>0,
$$

and

$$
\alpha-\gamma \leq 1 \text { if } l>0 \text { and } \frac{1}{r}+\frac{m}{N}=\frac{1}{p}+\frac{\alpha-1}{N} .
$$

For $s \in(1,2), \sigma=s-1, p \in\left(1, \frac{N}{s}\right)$ and $a \in\left[0, \frac{N-s p}{2}\right)$, we consider

$$
\begin{equation*}
r=p, l=1, \alpha=-\frac{\sigma p+2 a}{p}, \text { and } \gamma=-\frac{s p+2 a}{p} . \tag{5.1}
\end{equation*}
$$

Then, we notice that $m=\gamma=\alpha-1$ and $\frac{1}{r}+\frac{m}{N}=\frac{1}{p}-\frac{s p+2 a}{N p}=\frac{1}{p}+\frac{\alpha-1}{N}$. Moreover,

$$
\frac{1}{p}+\frac{\alpha}{N}=\frac{N-\sigma p-2 a}{N p}>0 \text { and } \frac{1}{r}+\frac{m}{N}=\frac{N-s p-2 a}{N p}>0 .
$$

Hence the assumptions of Theorem 5.1 are verified, and we get

$$
\begin{equation*}
C(N, p, \sigma, a) \int_{\mathbb{R}^{N}} \frac{|u(x)|^{p}}{|x|^{s p+2 a}} \mathrm{~d} x \leq \int_{\mathbb{R}^{N}} \frac{|\nabla u(x)|^{p}}{|x|^{\sigma p+2 a}} \mathrm{~d} x \tag{5.2}
\end{equation*}
$$

Moreover, by [1, Theorem 2.7],

$$
\begin{equation*}
C(N, p, \sigma, a) \int_{\mathbb{R}^{N}} \frac{|u(x)|^{p}}{|x|^{\mid \sigma p+2 a}} \mathrm{~d} x \leq \iint_{\mathbb{R}^{N} \times \mathbb{R}^{N}} \frac{|u(x)-u(y)|^{p}}{|x-y|^{N+\sigma p}} \frac{\mathrm{~d} x}{|x|^{a}} \frac{\mathrm{~d} y}{|y|^{a}}, \forall u \in \mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right) . \tag{5.3}
\end{equation*}
$$

Now observe that

$$
\begin{aligned}
& \iint_{\mathbb{R}^{N} \times \mathbb{R}^{N}} \frac{|\nabla u(x)-\nabla u(y)|^{p}}{|x-y|^{N+\sigma p}} \frac{\mathrm{~d} x}{|x|^{a}} \frac{\mathrm{~d} y}{|y|^{a}} \\
& \geq B\left(N, \frac{p}{2}\right)\left(\sum_{i=1}^{N} \iint_{\mathbb{R}^{N} \times \mathbb{R}^{N}} \frac{\left|\frac{\partial u}{\partial x_{i}}(x)-\frac{\partial u}{\partial x_{i}}(y)\right|^{p}}{|x-y|^{N+\sigma p}} \frac{\mathrm{~d} x}{|x|^{a}} \frac{\mathrm{~d} y}{|y|^{a}}\right) \quad \text { (using Lemma 2.1-(ii)) } \\
& \left.\geq B\left(N, \frac{p}{2}\right) C\left(\sum_{i=1}^{N} \int_{\mathbb{R}^{N}} \frac{\left|\frac{\partial u}{\partial x_{i}}(x)\right|^{p}}{|x|^{\sigma p+2 a}} \mathrm{~d} x\right) \quad \text { (using (5.3) with } \frac{\partial u}{\partial x_{i}}\right) \\
& \geq \frac{B\left(N, \frac{p}{2}\right)}{A\left(N, \frac{p}{2}\right)} C \int_{\mathbb{R}^{N}} \frac{|\nabla u(x)|^{p}}{|x|^{\sigma p+2 a}} \mathrm{~d} x \text { (using Lemma 2.1-(i)) } \\
& \geq \frac{B\left(N, \frac{p}{2}\right)}{A\left(N, \frac{p}{2}\right)} C \int_{\mathbb{R}^{N}} \frac{|u(x)|^{p}}{|x|^{s p+2 a}} \mathrm{~d} x, \quad(\text { using (5.2)). }
\end{aligned}
$$

Therefore, we have
Proposition 5.2. Let $N \geq 2, s \in(1,2), \sigma=s-1, p \in\left(1, \frac{N}{s}\right)$, and $a \in\left[0, \frac{N-s p}{2}\right)$. Then

$$
\begin{equation*}
\iint_{\mathbb{R}^{N} \times \mathbb{R}^{N}} \frac{|\nabla u(x)-\nabla u(y)|^{p}}{|x-y|^{N+\sigma p}} \frac{\mathrm{~d} x}{|x|^{a}} \frac{\mathrm{~d} y}{|y|^{a}} \geq C \int_{\mathbb{R}^{N}} \frac{|u(x)|^{p}}{|x|^{s p+2 a}} \mathrm{~d} x, \forall u \in \mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right) \tag{5.4}
\end{equation*}
$$

where $C=C(N, p, \sigma, a)$.
Next, using (5.4), we study the finer embeddings of $\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$. Let $\Omega$ be an open set in $\mathbb{R}^{N}$. For $f \in M(\Omega)$ we define the one dimensional decreasing rearrangement $f^{*}$ of $f$ as $f^{*}(\tau)=\inf \{t>0$ : $\left.\mu_{f}(t)<\tau\right\}$ for $\tau>0$. Then, the following identity holds (see [11])

$$
\begin{equation*}
\int_{\Omega} f(x) \mathrm{d} x=\int_{0}^{|\Omega|} f^{*}(t) \mathrm{d} t \tag{5.5}
\end{equation*}
$$

Proof of Theorem 1.1-(iv): For $u \in \mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right)$, consider the set $A_{t}=\left\{x \in \mathbb{R}^{N}:|u(x)|^{p}>t\right\}$ and we write

$$
|u(x)|^{p}=\int_{0}^{|u(x)|^{p}} \mathrm{~d} t=\int_{0}^{\infty} \chi_{t}(x) \mathrm{d} t, \text { where } \chi_{t}(x)=1, \text { if } x \in A_{t}, \text { and } \chi_{t}(x)=0, \text { if } x \in A_{t}^{c}
$$

Using Fubini's theorem, we write

$$
\int_{\mathbb{R}^{N}} \frac{|u(x)|^{p}}{|x|^{s p+2 a}} \mathrm{~d} x=\int_{\mathbb{R}^{N}}\left(\int_{0}^{\infty} \chi_{t}(x) \mathrm{d} t\right) \frac{\mathrm{d} x}{|x|^{s p+2 a}}=\int_{0}^{\infty}\left(\int_{\mathbb{R}^{N}} \frac{\chi_{t}(x)}{|x|^{s p+2 a}} \mathrm{~d} x\right) \mathrm{d} t
$$

Denote $f(x)=|x|^{-(s p+2 a)}$ for $x \in \mathbb{R}^{N}$. Using (5.5),

$$
\int_{\mathbb{R}^{N}} f(x) \chi_{t}(x) \mathrm{d} x=\int_{A_{t}} f(x) \mathrm{d} x=\int_{0}^{\left|A_{t}\right|} f^{*}(t) \mathrm{d} t
$$

By [4, Example 2.1.2], we see that $f^{*}(t)=\left(\frac{\omega_{N}}{t}\right)^{\frac{s p+2 a}{N}}$, were $\omega_{N}$ is the measure of a unit ball in $\mathbb{R}^{N}$. This implies

$$
\int_{\mathbb{R}^{N}} f(x) \chi_{t}(x) \mathrm{d} x=\omega_{N}^{\frac{s p+2 a}{N}} \int_{0}^{\left|A_{t}\right|} \frac{\mathrm{d} t}{t^{\frac{s p+2 a}{N}}}=\frac{N \omega_{N}^{\frac{s p+2 a}{N}}}{N-s p-2 a}\left|A_{t}\right|^{\frac{N-s p-2 a}{N}}
$$

Observe that $\left|A_{t}\right|=\mu_{|u|^{p}}(t)$ for $t>0$. Therefore,

$$
\int_{\mathbb{R}^{N}} \frac{|u(x)|^{p}}{|x|^{s p+2 a}} \mathrm{~d} x=\frac{N \omega_{N}^{\frac{s p+2 a}{N}}}{N-s p-2 a} \int_{0}^{\infty} \mu_{|u|^{p}(t)^{\frac{p}{p^{\star}}} \mathrm{d} t=\omega_{N}^{\frac{s p+2 a}{N}} \|\left.\left. u\right|^{p}\right|_{\frac{p^{\star}}{p}, 1}=\omega_{N}^{\frac{s p+2 a}{N}}|u|_{p^{\star}, p}^{p} . . . \quad{ }^{p} .}
$$

Hence using (5.4) we obtain

$$
\begin{equation*}
|u|_{p^{\star}, p} \leq C(N, s, p, a)[u]_{s, p, a}, \forall u \in \mathcal{C}_{c}^{\infty}\left(\mathbb{R}^{N}\right) \tag{5.6}
\end{equation*}
$$

Thus, (5.6) with the definition of $\mathcal{D}_{a}^{s, p}\left(\mathbb{R}^{N}\right)$ yields (1.10).
In the following proposition, using a similar layer cake decomposition technique, we show that $L^{p^{\star}, p}\left(\mathbb{R}^{N}\right)$ is strictly contained in $L_{a}^{p_{s}^{*}}\left(\mathbb{R}^{N}\right)$.

Proposition 5.3. Let $N \geq 2, s \in(1,2), \sigma=s-1, p \in\left(1, \frac{N}{s}\right)$, and $a \in\left[0, \frac{N-s p}{2}\right)$. Then $L^{p^{\star}, p}\left(\mathbb{R}^{N}\right) \subsetneq$ $L_{a}^{p_{s}^{*}}\left(\mathbb{R}^{N}\right)$, where $p^{\star}=\frac{N p}{N-s p-2 a}$.
Proof. For $t>0$, we consider the set $A_{t}=\left\{x \in \mathbb{R}^{N}:|u(x)|^{p_{s}^{*}}>t\right\}$, and write

$$
|u(x)|^{p_{s}^{*}}=\int_{0}^{|u(x)|^{p_{s}^{*}}} \mathrm{~d} t=\int_{0}^{\infty} \chi_{t}(x) \mathrm{d} t, \text { where } \chi_{t}(x)=1, \text { if } x \in A_{t}, \text { and } \chi_{t}(x)=0 \text {, if } x \in A_{t}^{c} \text {. }
$$

Using Fubini's theorem,

$$
\int_{\mathbb{R}^{N}} \frac{|u(x)|^{p_{s}^{*}}}{|x|^{\frac{2 a p_{s}^{*}}{p}}} \mathrm{~d} x=\int_{\mathbb{R}^{N}}\left(\int_{0}^{\infty} \chi_{t}(x) \mathrm{d} t\right) \frac{\mathrm{d} x}{|x|^{\frac{2 p_{s}^{*}}{p}}}=\int_{0}^{\infty}\left(\int_{\mathbb{R}^{N}} \frac{\chi_{t}(x)}{|x|^{\frac{2 a p_{s}^{*}}{p}}} \mathrm{~d} x\right) \mathrm{d} t .
$$

Denote $f(x)=|x|^{-\frac{2 a p_{s}^{*}}{p}}$ for $x \in \mathbb{R}^{N}$. Using (5.5),

$$
\int_{\mathbb{R}^{N}} f(x) \chi_{t}(x) \mathrm{d} x=\int_{A_{t}} f(x) \mathrm{d} x=\int_{0}^{\left|A_{t}\right|} f^{*}(t) \mathrm{d} t .
$$

By [4, Example 2.1.2], $f^{*}(t)=\left(\frac{\omega_{N}}{t}\right)^{\frac{2 a}{N-s p}}$ and hence

$$
\int_{\mathbb{R}^{N}} f(x) \chi_{t}(x) \mathrm{d} x=\omega_{N}^{\frac{2 a}{N-s p}} \int_{0}^{\left|A_{t}\right|} \frac{\mathrm{d} t}{t^{\frac{2 a}{N-s p}}}=\frac{\omega_{N}^{\frac{2 a}{N-s p}}(N-s p)}{N-s p-2 a}\left|A_{t}\right|^{\frac{N-s p-2 a}{N-s p}},
$$

where $\left|A_{t}\right|=\mu_{|u|_{s}^{p_{s}^{*}}}(t)$ for $t>0$. Therefore,

$$
\int_{\mathbb{R}^{N}} \frac{|u(x)|^{p_{s}^{*}}}{|x|^{\frac{2 a p_{s}^{*}}{p}}} \mathrm{~d} x=\frac{\omega_{N}^{\frac{2 a}{N-s p}}(N-s p)}{N-s p-2 a} \int_{0}^{\infty} \mu_{|u|^{p_{s}^{*}}}(t)^{\frac{p^{*}}{p^{*}}} \mathrm{~d} t=\left.\left.\omega_{N}^{\frac{2 a}{N-s p}}| | u\right|^{p_{s}^{*}}\right|_{p_{p}^{*}, 1}=\omega_{N}^{\frac{2 a}{p_{s}^{*}-s p}}|u|_{p^{*}, p_{s}^{*}}^{p_{s}^{*}}
$$

We know that $L^{q, r}\left(\mathbb{R}^{N}\right) \subsetneq L^{q, s}\left(\mathbb{R}^{N}\right)$ for $r<s$. Taking $q=p^{\star}, s=p_{s}^{*}$ and $r=p$ yields

$$
\begin{equation*}
L^{p^{\star}, p}\left(\mathbb{R}^{N}\right) \subsetneq L^{p^{\star}, p_{s}^{*}}\left(\mathbb{R}^{N}\right)=L_{a}^{p_{s}^{*}}\left(\mathbb{R}^{N}\right) . \tag{5.7}
\end{equation*}
$$

Hence the strict inclusion holds.
Remark 5.4. From Remark 3.3 and Theorem 1.1-(iv), we have

$$
\check{W}_{a}^{s, p}\left(\mathbb{R}^{N}\right) \subset L^{p^{\star}, p}\left(\mathbb{R}^{N}\right), \text { for } s \in(1,2) \text { and } p \in\left(1, \frac{N}{s}\right) \text {. }
$$
