# ABSOLUTE DILATIONS OF UCP SELF-ADJOINT FOURIER MULTIPLIERS: THE NON UNIMODULAR CASE

#### Abstract

Let $\varphi$ be a normal semi-finite faithful weight on a von Neumann algebra $A$, let $\left(\sigma_{r}^{\varphi}\right)_{r \in \mathbb{R}}$ denote the modular automorphism group of $\varphi$, and let $T: A \rightarrow A$ be a linear map. We say that $T$ admits an absolute dilation if there exist another von Neumann algebra $M$ equipped with a normal semi-finite faithful weight $\psi$, a $w^{*}$-continuous, unital and weight-preserving $*$-homomorphism $J: A \rightarrow M$ such that $\sigma^{\psi} \circ J=J \circ \sigma^{\varphi}$, as well as a weight-preserving *-automorphism $U: M \rightarrow M$ such that $T^{k}=\mathbb{E}_{J} U^{k} J$ for all integer $k \geq 0$, where $\mathbb{E}_{J}: M \rightarrow A$ is the conditional expectation associated with $J$. Given any locally compact group $G$ and any real valued function $u \in C_{b}(G)$, we prove that if $u$ induces a unital completely positive Fourier multiplier $M_{u}: V N(G) \rightarrow V N(G)$, then $M_{u}$ admits an absolute dilation. Here $V N(G)$ is equiped with its Plangherel weight $\varphi_{G}$. This result had been settled by the first named author in the case when $G$ is unimodular so the salient point in this paper is that $G$ may be non unimodular, and hence $\varphi_{G}$ may not be a trace. The absolute dilation of $M_{u}$ implies that for any $1<p<\infty$, the $L^{p}$-realization of $M_{u}$ can be dilated into an isometry acting on a non-commutative $L^{p}$-space. We further prove that if $u$ is valued in $[0,1]$, then the $L^{p}$-realization of $M_{u}$ is a Ritt operator with a bounded $H^{\infty}$-functional calculus.

## 1. Introduction

Let $(\Omega, \mu)$ be any measure space, let $1<p<\infty$ and let $T: L^{p}(\Omega) \rightarrow L^{p}(\Omega)$ be a positive contraction. Akcoglu's dilation theorem [1, 2] asserts that $T$ admits an isometric dilation, that is, there exist a second measure space $\left(\Omega^{\prime}, \mu^{\prime}\right)$, an isometry $J: L^{p}(\Omega) \rightarrow L^{p}\left(\Omega^{\prime}\right)$, an isometry $U: L^{p}\left(\Omega^{\prime}\right) \rightarrow L^{p}\left(\Omega^{\prime}\right)$ and a contraction $Q: L^{p}\left(\Omega^{\prime}\right) \rightarrow L^{p}(\Omega)$ such that $T^{k}=Q U^{k} J$ for all integer $k \geq 0$. This $L^{p}$-analogue of Nagy's dilation theorem has been instrumental in various topics concerning $L^{p}$-operators, such as functional calculus, harmonic analysis and ergodic theory. We refer to [8, 28, 34, 36] and the references therein for specific results.

Turning to non-commutative analysis, we note that Akcoglu's theorem does not extend to non-commutative $L^{p}$-spaces [29]. This obstacle led to new, interesting difficulties in the development of operator theory and harmonic analysis on non-commutative $L^{p}$-spaces. Also, it became important to exhibit classes of completely positive contractions on non-commutative $L^{p}$-spaces which do admit a dilation into an isometry acting on a second non-commutative

[^0]$L^{p}$-space. We refer to [4, 5, 6, 16, 17, 27, 30] for various results of this type. In all these papers (except [27]), the construction of an isometric dilation of a map $T: L^{p}(A) \rightarrow L^{p}(A)$ relies on the existence of a trace (or weight) preserving dilation of $T$ on the underlying von Neumann algebra $A$. This leads us to introduce the following definition, which extends [17, Definition 2.1]. Let $\varphi$ be a normal semi-finite faithful weight on $A$ (we say that $(A, \varphi)$ is a weighted von Neumann algebra in this case). Let $\left(\sigma_{r}^{\varphi}\right)_{r \in \mathbb{R}}$ denote the modular automorphism group of $\varphi$. We say that a linear map $T: A \rightarrow A$ admits an absolute dilation if there exist another weighted von Neumann algebra $(M, \psi)$, a $w^{*}$-continuous, unital and weight-preserving *-homomorphism $J: A \rightarrow M$ such that $\sigma^{\psi} \circ J=J \circ \sigma^{\varphi}$, as well as a weight-preserving *automorphism $U: M \rightarrow M$ such that $T^{k}=\mathbb{E}_{J} U^{k} J$ for all integer $k \geq 0$, where $\mathbb{E}_{J}: M \rightarrow A$ is the conditional expectation associated with $J$. This dilation property implies that $T$ is unital, completely postive and weight-preserving, that $T$ has a natural extension to $L^{p}(A)$ and that the latter admits a dilation into an isometry acting on another non-commutative $L^{p}$-space (see Proposition (2.7).

In [17], we gave a characterization of bounded Schur multipliers which admit an absolute dilation. In [16], the first named author showed that for any unimodular locally compact group $G$, every unital completely positive Fourier multiplier $V N(G) \rightarrow V N(G)$ (in the sense of [14]) whose symbol is real-valued admits an absolute dilation. The case when $G$ is discrete had been settled in [4]. (The discrete case also follows from [38, Corollary] and [22, Theorem 4.4]). The objective of this paper is to extend the above mentioned result to the non unimodular case. Let $G$ be any locally compact group, let $u: G \rightarrow \mathbb{R}$ be a continuous function and assume that $u$ induces a unital completely positive Fourier multiplier $M_{u}: V N(G) \rightarrow V N(G)$. We show that $M_{u}$ admits an absolute dilation, see Theorem 4.1,

In the previous paragraph, the group von Neumann algebra $A=V N(G)$ is equipped with its Plancherel weight $\varphi=\varphi_{G}$ (see Section 3 for background). This specific weight is a trace if and only if $G$ is unimodular. This is the reason why passing from the unimodular case (considered in [16]) to the non unimodular case (considered in the present paper) requires new arguments. When $\varphi_{G}$ is a non tracial weight, we need to consider the Haagerup noncommutative $L^{p}$-spaces associated with $\left(V N(G), \varphi_{G}\right)$ (see Subsection 2.2 for background). In particular, the space $L^{1}\left(V N(G), \varphi_{G}\right)$ plays a key role in the proof of Theorem 4.1.

We note that a dilation theorem for semigroups of unital completely positive Fourier multiplier with real symbols was established in [6]. However it cannot be applied to our case. Indeed there is no known way to pass from a dilation result for semigroups to a dilation result for single operators.

In the last part of the paper (Section 5), we give an application of our dilation result to functional calculus. We consider a unital completely positive Fourier multiplier $M_{u}: V N(G) \rightarrow V N(G)$ and we assume that $u$ is valued in $[0,1]$. Then we show that for any $1<p<\infty$, the $L^{p}$-realization of $T$ on $L^{p}\left(V N(G), \varphi_{G}\right)$ is a Ritt operator which admits a bounded $H^{\infty}$-functional calculus in the sense of [7, 35].

## 2. Absolute dilations and isometric p-Dilations in the weighted case

We refer the reader to 41 for general information on von Neumann algebras. Given any von Neumann algebra $A$, we let $A_{*}$ denote its predual. We let $A^{+}$and $A_{*}^{+}$denote the positive
cones of $A$ and $A_{*}$, respectively. A map $V: A \rightarrow A^{\prime}$ between two von Neumann algebras is called positive if $V\left(A^{+}\right) \subset A^{\prime+}$. We will use the stronger notion of completely positive map, for which we refer to [41, Section IV.3].
2.1. Absolute dilations. We refer to [39, 42] for general information on weights. Let $A$ be a von Neumann algebra equipped with a normal semi-finite faithful weight $\varphi$. In this situation, we say that $(A, \varphi)$ is a weighted von Neumann algebra. We let $\left(\sigma_{r}^{\varphi}\right)_{r \in \mathbb{R}}$ denote the modular automorphism group of $\varphi$. Then we set

$$
\mathcal{N}_{\varphi}=\left\{x \in A: \varphi\left(x^{*} x\right)<\infty\right\}
$$

and

$$
\mathcal{M}_{\varphi}=\operatorname{Span}\left\{y^{*} x: x, y \in \mathcal{N}_{\varphi}\right\} .
$$

We recall that $\mathcal{N}_{\varphi}$ is a $w^{*}$-dense left ideal of $A$ and that $\mathcal{M}_{\varphi}$ is a $w^{*}$-dense $*$-subalgebra of $A$. Further $\mathcal{M}_{\varphi}=\operatorname{Span}\left\{x^{*} x: x \in \mathcal{N}_{\varphi}\right\}$ and the restriction of $\varphi$ to the set $\left\{x^{*} x: x \in \mathcal{N}_{\varphi}\right\}$ uniquely extends to a functional (still denoted by)

$$
\varphi: \mathcal{M}_{\varphi} \longrightarrow \mathbb{C}
$$

Let $(M, \psi)$ be a second weighted von Neumann algebra and let $T: A \rightarrow M$ be any positive map. We say that $T$ is weight-preserving provided that

$$
\psi \circ T=\varphi \quad \text { on } A^{+} .
$$

Let $J: A \rightarrow M$ be a $w^{*}$-continuous, unital and weight-preserving $*$-homomorphism such that

$$
\sigma^{\psi} \circ J=J \circ \sigma^{\varphi}
$$

Here and thereafter, this identity means that $\sigma_{r}^{\psi} \circ J=J \circ \sigma_{r}^{\varphi}$ on $A$ for all $r \in \mathbb{R}$. According to either [39, Theorem 10.1] or [42, Theorem IX.4.2], there exists a unique weight-preserving conditional expectation

$$
\begin{equation*}
\mathbb{E}_{J}: M \longrightarrow A \tag{2.1}
\end{equation*}
$$

That is, $\mathbb{E}_{J}: M \rightarrow A$ is the unique linear map satisfying $\mathbb{E}_{J} \circ J=I_{A},\left\|\mathbb{E}_{J}\right\|=1$ and $\varphi \circ \mathbb{E}_{J}=\mathbb{E}_{J} \circ \psi$. We note that we further have $\sigma^{\varphi} \circ \mathbb{E}_{J}=\mathbb{E}_{J} \circ \sigma^{\psi}$, see [39, Corollary 10.5], and that $\mathbb{E}_{J}$ is $w^{*}$-continuous (see also Lemma (2.12).

Definition 2.1. Let $(A, \varphi)$ be a weighted von Neumann algebra and let $T: A \rightarrow A$ be a bounded map. We say that $T$ admits an absolute dilation if there exist another weighted von Neumann algebra $(M, \psi)$, a $w^{*}$-continuous, unital and weight-preserving $*$-homomorphism $J: A \rightarrow M$ such that $\sigma^{\psi} \circ J=J \circ \sigma^{\varphi}$, as well as a weight-preserving $*$-automorphism $U: M \rightarrow M$ such that

$$
\begin{equation*}
\forall k \geq 0, \quad T^{k}=\mathbb{E}_{J} U^{k} J \tag{2.2}
\end{equation*}
$$

## Remark 2.2.

(1) Assume that $T:(A, \varphi) \rightarrow(A, \varphi)$ admits an absolute dilation and consider $(M, \psi), J$ and $U$ as in Definition [2.1. In particular, we have $T=\mathbb{E}_{J} U J$. We observe that $J, U$ and $\mathbb{E}_{J}$ are both unital, completely positive and weight-preserving. Further $\sigma^{\psi} \circ U=U \circ \sigma^{\psi}$, by
[42, Corollary VIII.1.4]. Since $\sigma^{\psi} \circ J=J \circ \sigma^{\varphi}$ and $\sigma^{\varphi} \circ \mathbb{E}_{J}=\mathbb{E}_{J} \circ \sigma^{\psi}$, we deduce that $T$ is unital, completely positive, weight-preserving and that $\sigma^{\varphi} \circ T=T \circ \sigma^{\varphi}$.
(2) Assume that $\varphi$ is a state and consider $T:(A, \varphi) \rightarrow(A, \varphi)$. If $T$ admits an absolute dilation and if $(M, \psi)$ and $J: A \rightarrow M$ are given by Definition 2.1, then $\psi(1)=\psi(J(1))=$ $\varphi(1)=1$, hence $\psi$ is a state. It therefore follows from [22, Theorem 4.4], that $T$ admits an absolute dilation if and only if $T$ is factorizable in the sense of [3, 38]. Absolute dilations in the state case go back to [33]. We refer to [5] for various examples.
(3) Assume that $\varphi$ is a trace and that $T:(A, \varphi) \rightarrow(A, \varphi)$ admits an absolute dilation. Then the weighted von Neumann algebra $(M, \psi)$ from Definition 2.1 can be chosen in such a way that $\psi$ is a trace.

Indeed, assume that $T$ satisfies Definition 2.1 and let $M_{0}$ be the centralizer of $\psi$, that is, $M_{0}=\left\{m \in M: \sigma_{r}^{\psi}(x)=x\right.$ for all $\left.r \in \mathbb{R}\right\}$. Let

$$
\mathcal{B}=\operatorname{Span}\left\{\sum_{k=1}^{m} U^{k_{1}} J\left(x_{1}\right) U^{k_{2}} J\left(x_{2}\right) \cdots U^{k_{m}} J\left(x_{m}\right): m \geq 1, k_{1}, \ldots, k_{m} \in \mathbb{Z}, x_{1}, \ldots x_{m} \in A\right\}
$$

and let $B=\overline{\mathcal{B}}^{w^{*}}$. Since $\sigma^{\varphi}$ is trivial, $U^{k} J(x) \in M_{0}$ for all $x \in A$ and $k \in \mathbb{Z}$. Hence $B$ is a sub-von Neumann algebra of $M_{0}$. Therefore, the restriction $\psi_{B}$ of $\psi$ to $B^{+}$is a normal faithful trace. Let us show its semi-finiteness. For any $x \in \mathcal{N}_{\varphi}$ and any $k \in \mathbb{Z}$, we have

$$
\psi\left(\left(U^{k} J(x)\right)^{*}\left(U^{k} J(x)\right)\right)=\psi\left(U^{k} J\left(x^{*} x\right)\right)=\varphi\left(x^{*} x\right)<\infty
$$

that is, $U^{k} J(x) \in \mathcal{N}_{\psi}$. Since $\mathcal{N}_{\psi}$ is $w^{*}$-dense in $A$ and $J, U$ are $w^{*}$-continuous, $U^{k} J\left(\mathcal{N}_{\varphi}\right)$ is $w^{*}$-dense in $U^{k} J(A)$. Since $\mathcal{N}_{\psi}$ is a left ideal, we deduce that $\mathcal{N}_{\psi} \cap \mathcal{B}$ is $w^{*}$-dense in $\mathcal{B}$. Consequently, $\mathcal{N}_{\psi} \cap B$ is $w^{*}$-dense in $B$. Thus, $\psi_{B}$ is semi-finite. Consequently, $(M, \psi)$ can be replaced by $\left(B, \psi_{B}\right)$ in the dilation of $T$.

In the paper [17], we considered absolute dilations in the tracial case. The above paragraph shows that in the case when $\varphi$ is a trace, $T:(A, \varphi) \rightarrow(A, \varphi)$ admits an absolute dilation in the sense of Definition 2.1 if and only if it admits an absolute dilation in the sense of [17].
(4) Combining [22, Section 3] with (3) above, we obtain examples of unital, completely positive, weight-preserving maps $T:(A, \varphi) \rightarrow(A, \varphi)$ such that $\sigma^{\varphi} \circ T=T \circ \sigma^{\varphi}$, without any absolute dilation (see [17, Remark 7.3] for details).

We record for further use the so-called Pedersen-Takesaki theorem (see [39, Theorem 6.2]).
Lemma 2.3. Let $(A, \varphi)$ be a weithed von Neumann algebra and let $B \subset \mathcal{N}_{\varphi}$ be a $w^{*}$-dense *-algebra such that $\sigma_{r}^{\varphi}(B) \subset B$ for all $r \in \mathbb{R}$. Let $\gamma$ be a normal semi-finite weight on $A$ such that $\gamma \circ \sigma^{\varphi}=\gamma$ and $\gamma\left(x^{*} x\right)=\varphi\left(x^{*} x\right)$ for all $x \in B$. Then $\gamma=\varphi$.
2.2. Haagerup non-commutative $L^{p}$-spaces. Let $(A, \varphi)$ be a weighted von Neumann algebra. We recall the definition of the Haagerup non-commutative $L^{p}$-spaces $L^{p}(A, \varphi)$, as well as some of their properties. We refer the reader to [20], [23, Section 1], [26, Chapter 9], [37] and [44] for details and complements. Assume that $A$ acts on some Hibert space $H$ and let

$$
\mathcal{R}=A \rtimes_{\sigma^{\varphi}} \mathbb{R} \subset B\left(L^{2}(\mathbb{R})\right) \bar{\otimes} A \subset B\left(L^{2}(\mathbb{R} ; H)\right)
$$

be the crossed product associated with $\sigma^{\varphi}: \mathbb{R} \rightarrow \operatorname{Aut}(A)$, see e.g. [39, Chapter IV] or [42, Chapter X]. We regard $A$ as a sub-von Neumann algebra of $\mathcal{R}$ in the natural way. Let $\widehat{\sigma}^{\varphi}: \mathbb{R} \simeq \widehat{\mathbb{R}} \rightarrow \operatorname{Aut}(\mathcal{R})$ be the dual action of $\sigma^{\varphi}$ and note that $\widehat{\sigma}_{r}^{\varphi}(x)=x$ for all $r \in \mathbb{R}$ if and only if $x \in A$.

There exists a unique normal semi-finite faithful trace $\tau_{0}$ on $\mathcal{R}$ such that

$$
\tau_{0} \circ \widehat{\sigma}_{r}^{\varphi}=e^{-r} \tau_{0}, \quad r \in \mathbb{R} .
$$

This trace gives rise to the $*$-algebra $L^{0}\left(\mathcal{R}, \tau_{0}\right)$ of $\tau_{0}$-measurable operators [26, Chapter 4]. Then for any $1 \leq p \leq \infty$, the Haagerup $L^{p}$-space $L^{p}(A, \varphi)$ is defined as

$$
L^{p}(A, \varphi)=\left\{y \in L^{0}\left(\mathcal{R}, \tau_{0}\right): \widehat{\sigma}_{r}^{\varphi}(y)=e^{-\frac{r}{p}} y \text { for all } r \in \mathbb{R}\right\}
$$

In particular, $L^{\infty}(A, \varphi)=A \subset \mathcal{R}$. For all $1 \leq p<\infty, L^{p}(A, \varphi)^{+}=L^{p}(A, \varphi) \cap L^{0}\left(\mathcal{R}, \tau_{0}\right)^{+}$is a positive cone on $L^{p}(A, \varphi)$.

For any normal semi-finite weight $\gamma$ on $A$, let $\widehat{\gamma}$ denote the dual weight on $\mathcal{R}$, see e.g. [39, Section 19] or [42, Section 10.1]. Let $h_{\gamma}$ denote the Radon-Nikodym derivative of $\gamma$ with respect to $\tau_{0}$. This is the unique positive operator on $L^{2}(\mathbb{R} ; H)$ affiliated with $\mathcal{R}$, such that $\widehat{\gamma}(y)=\tau_{0}\left(h_{\gamma}^{\frac{1}{2}} y h_{\gamma}^{\frac{1}{2}}\right)$, for all $y \in \mathcal{R}^{+}$. It turns out that $h_{\gamma}$ belongs to $L^{1}(A, \varphi)^{+}$if and only if $\gamma \in A_{*}^{+}$. Further the mapping $\gamma \mapsto h_{\gamma}$ on $A_{*}^{+}$extends to a linear isomorphism from $A_{*}$ onto $L^{1}(A, \varphi)$, still denoted by $\gamma \mapsto h_{\gamma}$. With this isomorphism in hands, we equip $L^{1}(A, \varphi)$ with the norm $\|\cdot\|_{1}$ inherited from $A_{*}$, that is, $\left\|h_{\gamma}\right\|_{1}=\|\gamma\|_{A_{*}}$ for all $\gamma \in A_{*}$. Next, for any $1 \leq p<\infty$ and any $y \in L^{p}(A, \varphi)$, the positive operator $|y|$ belongs to $L^{p}(A, \varphi)$ as well and hence $|y|^{p}$ belongs to $L^{1}(A, \varphi)$. This allows to define $\|y\|_{p}=\left\||y|^{p}\right\|^{\frac{1}{p}}$ for all $y \in L^{p}(A, \varphi)$. Then $\|\cdot\|_{p}$ is a complete norm on $L^{p}(A, \varphi)$.

The Banach spaces $L^{p}(A, \varphi)$ satisfy the following version of Hölder's inequality (see e.g. [26, Proposition 9.17]). For any $1 \leq p, p^{\prime} \leq \infty$ such that $p^{-1}+p^{\prime-1}=1$ and for any $x \in L^{p}(A, \varphi)$ and $y \in L^{p^{\prime}}(A, \varphi)$, the product $x y$ belongs to $L^{1}(A, \varphi)$ and we have

$$
\|x y\|_{1} \leq\|x\|_{p}\|y\|_{p^{\prime}}
$$

We let $\operatorname{Tr}_{\varphi}: L^{1}(A, \varphi) \rightarrow \mathbb{C}$ be defined by $\operatorname{Tr}_{\varphi}\left(h_{\gamma}\right)=\gamma(1)$ for all $\gamma \in A_{*}$. This functional has two remarkable properties. First, for any $x \in L^{p}(A, \varphi)$ and $y \in L^{p^{\prime}}(A, \varphi)$ with $p^{-1}+p^{\prime-1}=1$, we have $\operatorname{Tr}_{\varphi}(x y)=\operatorname{Tr}_{\varphi}(y x)$. Second,

$$
\operatorname{Tr}_{\varphi}\left(h_{\gamma} x\right)=\gamma(x),
$$

for all $\gamma \in A_{*}$ and $x \in A$. It follows from this identity and the definition of $\|\cdot\|_{1}$ that the duality pairing $\langle x, y\rangle=\operatorname{Tr}_{\varphi}(x y)$ for $x \in A$ and $y \in L^{1}(A, \varphi)$ yields an isometric isomorphism

$$
\begin{equation*}
L^{1}(A, \varphi)^{*} \simeq A \tag{2.3}
\end{equation*}
$$

We also note that $L^{2}(A, \varphi)$ is a Hilbert space for the inner product

$$
\begin{equation*}
(x \mid y)_{L^{2}(A)}=\operatorname{Tr}_{\varphi}\left(y^{*} x\right), \quad x, y \in L^{2}(A, \varphi) \tag{2.4}
\end{equation*}
$$

We let $D_{\varphi}=h_{\varphi}$ be the Radon-Nikodym derivative of $\varphi$ with respect to $\tau_{0}$. This operator is called the density of $\varphi$. Note that it belongs to $L^{1}(A, \varphi)$ if and only if $\varphi$ is finite. It
was shown in [18, Section 2] that for any $1 \leq p<\infty, D_{\varphi}^{\frac{1}{2 p}} x D_{\varphi}^{\frac{1}{2 p}}$ belongs to $L^{p}(A, \varphi)$ for all $x \in \mathcal{M}_{\varphi}$, and that $D_{\varphi}^{\frac{1}{2 p}} \mathcal{M}_{\varphi} D_{\varphi}^{\frac{1}{2 p}}$ is dense in $L^{p}(A, \varphi)$. In the case $p=1$, we further have

$$
\begin{equation*}
\varphi(x)=\operatorname{Tr}_{\varphi}\left(D_{\varphi}^{\frac{1}{2}} x D_{\varphi}^{\frac{1}{2}}\right), \quad x \in \mathcal{M}_{\varphi} \tag{2.5}
\end{equation*}
$$

see [18, Proposition 2.13]. We refer to [18, Section 1] for the precise meaning of the above products.
2.3. The Haagerup-Junge-Xu extension property and $p$-dilations. Consider two weighted von Neumann algebras $(A, \varphi)$ and $\left(A^{\prime}, \varphi^{\prime}\right)$, and let $V: A \rightarrow A^{\prime}$ be any weightpreserving positive operator. If $x \in \mathcal{N}_{\varphi}$, then $\varphi^{\prime}\left(V\left(x^{*} x\right)\right)=\varphi\left(x^{*} x\right)<\infty$, hence $V\left(x^{*} x\right) \in$ $\mathcal{M}_{\varphi^{\prime}}$. Consequently, $V$ maps $\mathcal{M}_{\varphi}$ into $\mathcal{M}_{\varphi^{\prime}}$. Hence for any $1 \leq p<\infty$, one may define

$$
V_{p}: D_{\varphi}^{\frac{1}{2 p}} \mathcal{M}_{\varphi} D_{\varphi}^{\frac{1}{2 p}} \longrightarrow L^{p}\left(A^{\prime}, \varphi^{\prime}\right), \quad V_{p}\left(D_{\varphi}^{\frac{1}{2 p}} x D_{\varphi}^{\frac{1}{2 p}}\right)=D_{\psi}^{\frac{1}{2 p}} V(x) D_{\psi}^{\frac{1}{2 p}}, \quad \text { for all } x \in \mathcal{M}_{\varphi}
$$

The following extension result is due to Haageup-Junge-Xu.
Proposition 2.4. [23, Proposition 5.4 \& Remark 5.6] For any weight-preserving positive map $V:(A, \varphi) \rightarrow\left(A^{\prime}, \varphi^{\prime}\right)$ and any $1 \leq p<\infty, V_{p}$ extends to a (necessarily unique) bounded map from $L^{p}(A, \varphi)$ into $L^{p}\left(A^{\prime}, \varphi^{\prime}\right)$. If further $\|V\| \leq 1$, then we have

$$
\left\|V_{p}: L^{p}(A, \varphi) \longrightarrow L^{p}\left(A^{\prime}, \varphi^{\prime}\right)\right\| \leq 1, \quad 1 \leq p<\infty
$$

Remark 2.5. Consider $V:(A, \varphi) \rightarrow\left(A^{\prime}, \varphi^{\prime}\right)$ as in Proposition 2.4 and assume that $V$ is an isometric isomorphism. Then for all $1 \leq p<\infty, V_{p}: L^{p}(A, \varphi) \rightarrow L^{p}\left(A^{\prime}, \varphi^{\prime}\right)$ is an isometric isomorphism as well. To prove this, it suffices to apply Proposition 2.4 to $V$ and to $V^{-1}$, and to observe that $\left\{V^{-1}\right\}_{p}=\left\{V_{p}\right\}^{-1}$.
Definition 2.6. Let $(A, \varphi)$ be a weighted von Neumann algebra and let $T: L^{p}(A, \varphi) \rightarrow$ $L^{p}(A, \varphi)$ be a contraction. We say that $T$ admits an isometric $p$-dilation if there exist another weighted von Neumann algebra $(M, \psi)$, an isometric isomorphism $U: L^{p}(M, \psi) \rightarrow L^{p}(M, \psi)$ and two contractions $J: L^{p}(A, \varphi) \rightarrow L^{p}(M, \psi)$ and $Q: L^{p}(M, \psi) \rightarrow L^{p}(A, \varphi)$ such that

$$
\forall k \geq 0, \quad T^{k}=Q U^{k} J
$$

The following is a straightforward application of Proposition 2.4 and Remark [2.5. It extends [17, Proposition 2.3] which was concerned by the tracial case only (see also [5, p. 2281] for the state case).

Proposition 2.7. Let $T:(A, \varphi) \rightarrow(A, \varphi)$ be a positive weight-preserving contraction. For any $1 \leq p<\infty$, let $T_{p}: L^{p}(A, \varphi) \rightarrow L^{p}(A, \varphi)$ be the contraction provided by Proposition 2.4. If $T$ admits an absolute dilation, then $T_{p}$ admits an isometric $p$-dilation.
2.4. The use of analytic elements. Let $(A, \varphi)$ be a weighted von Neumann algebra. We let $A_{a} \subset A$ be the subset of all $x \in A$ such that $r \mapsto \sigma_{r}^{\varphi}(x)$ extends to an entire function $z \in \mathbb{C} \mapsto \sigma_{z}^{\varphi}(x) \in A$. Such elements are called analytic. They play a key role in the study of absolute dilations. Following [18, p.46], we introduce

$$
\mathcal{N}_{\varphi}^{\infty}=\left\{x \in A_{a}: \sigma_{z}^{\varphi}(x) \in \mathcal{N}_{\varphi} \cap \mathcal{N}_{\varphi}^{*} \text { for all } z \in \mathbb{C}\right\}
$$

and

$$
\mathcal{M}_{\varphi}^{\infty}=\operatorname{Span}\left\{y^{*} x: x, y \in \mathcal{N}_{\varphi}^{\infty}\right\}
$$

It is easy to check that $\mathcal{M}_{\varphi}^{\infty} \subset \mathcal{N}_{\varphi}^{\infty}$. According to [18, Theorem 2.4,(a)], $\mathcal{M}_{\varphi}^{\infty}$ is a $w^{*}$-dense *-subalgebra of $A$ and by [18, Theorem 2.4,(b)], we have the following.
Lemma 2.8. The space $D_{\varphi}^{\frac{1}{2}} \mathcal{M}_{\varphi}^{\infty} D_{\varphi}^{\frac{1}{2}} \subset L^{1}(A, \varphi)$ is dense in $L^{1}(A, \varphi)$.
The following commutation property is given by [18, Lemma 2.5].
Lemma 2.9. For all $x \in \mathcal{M}_{\varphi}^{\infty}$, we have $x D_{\varphi}^{\frac{1}{4}}=D_{\varphi}^{\frac{1}{4}} \sigma_{\frac{i}{4}}^{\varphi}(x)$.
Next we record a variant of (2.5), based on Lemma 2.9, for which we refer to [18, Proposition 2.13].
Lemma 2.10. For any $x \in \mathcal{N}_{\varphi}^{*}$ and any $y \in \mathcal{M}_{\varphi}^{\infty}$, x $\sigma_{-\frac{i}{2}}^{\varphi}(y)$ belongs to $\mathcal{M}_{\varphi}$ and we have

$$
\operatorname{Tr}_{\varphi}\left(x D_{\varphi}^{\frac{1}{2}} y D_{\varphi}^{\frac{1}{2}}\right)=\varphi\left(x \sigma_{-\frac{i}{2}}^{\varphi}(y)\right)
$$

Remark 2.11. Consider $V:(A, \varphi) \rightarrow\left(A^{\prime}, \varphi^{\prime}\right)$ as in Proposition 2.4. Using (2.3) both for $A$ and for $A^{\prime}$, we may consider $V_{1}^{*}: A^{\prime} \rightarrow A$. Then $V_{1}^{*}$ is a weight-preserving positive map. This is proved in [23, Proposition 5.4] in the case when the weights $\varphi$ and $\varphi^{\prime}$ are finite. This actually extends to the general case [47]. The proof uses the space $\mathcal{N}_{\varphi}^{\infty}$.
Lemma 2.12. Let $J:(A, \varphi) \rightarrow(M, \psi)$ be a $w^{*}$-continuous, unital and weight-preserving *-homomorphism such that $\sigma^{\psi} \circ J=J \circ \sigma^{\varphi}$. Let $\mathbb{E}_{J}$ be the conditional expectation associated with $J$, see (2.1). Then

$$
\mathbb{E}_{J}=J_{1}^{*}
$$

Proof. We know that $J_{1}^{*}$ is a contraction. Furthermore, $J_{1}^{*}$ is a weight-preserving positive map, by Remark 2.11. Hence it remains to prove that $J_{1}^{*} \circ J=I_{A}$.

Let $x \in \mathcal{M}_{\varphi}$ and let $y \in \mathcal{M}_{\varphi}^{\infty}$. Then

$$
\left\langle J_{1}^{*} \circ J(x), D_{\varphi}^{\frac{1}{2}} y D_{\varphi}^{\frac{1}{2}}\right\rangle_{A, L^{1}(A)}=\left\langle J(x), J_{1}\left(D_{\varphi}^{\frac{1}{2}} y D_{\varphi}^{\frac{1}{2}}\right)\right\rangle_{M, L^{1}(M)}=\left\langle J(x), D_{\psi}^{\frac{1}{2}} J(y) D_{\psi}^{\frac{1}{2}}\right\rangle_{M, L^{1}(M)}
$$

Since $J$ is a $*$-homomorphism, we have $J\left(\mathcal{N}_{\varphi}\right) \subset \mathcal{N}_{\psi}$. Using the commutation property $\sigma^{\psi} \circ J=J \circ \sigma^{\varphi}$, we deduce that $J\left(\mathcal{N}_{\varphi}^{\infty}\right) \subset \mathcal{N}_{\psi}^{\infty}$. Using again that $J$ is a $*$-homomorphism, we deduce that

$$
J\left(\mathcal{M}_{\varphi}^{\infty}\right) \subset \mathcal{M}_{\psi}^{\infty}
$$

Likewise,

$$
J\left(\mathcal{M}_{\varphi}\right) \subset \mathcal{M}_{\psi}
$$

Hence $J(y) \in \mathcal{M}_{\psi}^{\infty}$ and $J(x) \in \mathcal{M}_{\psi} \subset \mathcal{N}_{\psi}^{*}$. By Lemma 2.10 (applied to $\psi$ ), we deduce that

$$
\left\langle J_{1}^{*} \circ J(x), D_{\varphi}^{\frac{1}{2}} y D_{\varphi}^{\frac{1}{2}}\right\rangle_{A, L^{1}(A)}=\operatorname{Tr}_{\psi}\left(J(x) D_{\psi}^{\frac{1}{2}} J(y) D_{\psi}^{\frac{1}{2}}\right)=\psi\left(J(x) \sigma_{-\frac{i}{2}}^{\psi}(J(y))\right)
$$

Moreover, $J(x) \sigma_{-\frac{i}{2}}^{\psi}(J(y))=J\left(x \sigma_{-\frac{i}{2}}^{\varphi}(y)\right)$ and $\psi \circ J=\varphi$, hence

$$
\left\langle J_{1}^{*} \circ J(x), D_{\varphi}^{\frac{1}{2}} y D_{\varphi}^{\frac{1}{2}}\right\rangle_{A, L^{1}(A)}=\varphi\left(x \sigma_{-\frac{i}{2}}^{\varphi}(y)\right)
$$

Thus, by Lemma 2.10 again, we obtain that

$$
\left\langle J_{1}^{*} \circ J(x), D_{\varphi}^{\frac{1}{2}} y D_{\varphi}^{\frac{1}{2}}\right\rangle_{A, L^{1}(A)}=\left\langle x, D_{\varphi}^{\frac{1}{2}} y D_{\varphi}^{\frac{1}{2}}\right\rangle_{A, L^{1}(A)}
$$

Since $J, J_{1}^{*}$ are $w^{*}$-continuous and $\mathcal{M}_{\varphi}$ is $w^{*}$-dense, the result follows from Lemma 2.8,

## 3. Background on Fourier multipliers

Let $G$ be a locally compact group equipped with a fixed left Haar measure $d g$. We let $\epsilon$ denote the unit of $G$. Let $\lambda: G \rightarrow B\left(L^{2}(G)\right)$ be the left regular representation of $G$, i.e.

$$
[\lambda(g) h](t)=h\left(g^{-1} t\right), \quad h \in L^{2}(G), g, t \in G
$$

Let $V N(G) \subset B\left(L^{2}(G)\right)$ be the von Neumann algebra generated by $\{\lambda(g): g \in G\}$. For any $f \in L^{1}(G)$, we set

$$
\lambda(f)=\int_{G} f(g) \lambda(g) d g
$$

where the integral is defined in the strong sense. The operators $\lambda(f)$ belong to $V N(G)$ and $\lambda\left(L^{1}(G)\right)$ is actually a $w^{*}$-dense $*$-subalgebra of $V N(G)$. Further for all $f_{1}, f_{2} \in L^{1}(G)$, we have $\lambda\left(f_{1} * f_{2}\right)=\lambda\left(f_{1}\right) \lambda\left(f_{2}\right)$.

Let $\Delta_{G}: G \rightarrow(0, \infty)$ be the modular function of $G$ and recall that it is characterized by the identity

$$
\int_{G} f\left(g^{-1}\right) d g=\int_{G} f(g) \Delta_{G}(g)^{-1} d g
$$

For any $f \in L^{1}(G)$, let $f^{*} \in L^{1}(G)$ be defined by

$$
f^{*}(g)=\Delta_{G}(g)^{-1} \overline{f\left(g^{-1}\right)}, \quad g \in G
$$

Then it is easy to check that $\lambda(f)^{*}=\lambda\left(f^{*}\right)$.
Let $K(G)$ be the space of all continuous functions $G \rightarrow \mathbb{C}$ with compact support. It follows from above that $\lambda(K(G))$ is a $*$-subalgebra of $V N(G)$. Since $K(G)$ is dense in $L^{1}(G)$, the latter is $w^{*}$-dense.

We equip $V N(G)$ with the so-called Plancherel weight

$$
\varphi_{G}: V N(G)^{+} \longrightarrow[0, \infty],
$$

for which we refer to [21, Section 2] (see also [42, Section VII.3]). For simplicity we let

$$
\sigma^{G}:=\sigma^{\varphi_{G}} \quad \text { and } \quad D_{G}:=D_{\varphi_{G}}
$$

denote the modular automorphism group and the density of $\varphi_{G}$, respectively.
We record for later use that for any $f \in L^{1}(G) \cap L^{2}(G), \lambda(f) \in \mathcal{N}_{\varphi_{G}}$ and

$$
\begin{equation*}
\varphi_{G}\left(\lambda(f)^{*} \lambda(f)\right)=\|f\|_{L^{2}(G)}^{2}, \quad f \in L^{1}(G) \cap L^{2}(G) . \tag{3.1}
\end{equation*}
$$

Moreover if $f \in K(G)$ is such that $\lambda(f) \geq 0$, then $\lambda(f) \in \mathcal{M}_{\varphi_{G}}$ and

$$
\begin{equation*}
\varphi_{G}(\lambda(f))=f(\epsilon) \tag{3.2}
\end{equation*}
$$

We also note that by the last but one line of [21, p. 125], we have

$$
\begin{equation*}
\sigma_{r}^{G}(\lambda(g))=\Delta_{G}(g)^{i r} \lambda(g), \quad g \in G, r \in \mathbb{R} . \tag{3.3}
\end{equation*}
$$

This readily implies

$$
\begin{equation*}
\sigma_{r}^{G}(\lambda(f))=\lambda\left(\Delta_{G}^{i r} f\right), \quad f \in L^{1}(G), r \in \mathbb{R} \tag{3.4}
\end{equation*}
$$

Consequently, $\lambda(K(G))$ is $\sigma^{G}$-invariant.
Let $C_{b}(G)$ be the space of all bounded continuous functions $u: G \rightarrow \mathbb{C}$. Following [14], we say that $u \in C_{b}(G)$ is a bounded Fourier multiplier on $V N(G)$ if there exists a $w^{*}$-continuous operator $M_{u}: V N(G) \rightarrow V N(G)$ such that

$$
M_{u}(\lambda(g))=u(g) \lambda(g), \quad g \in G
$$

In this case, the operator $M_{u}$ is necessarily unique. Furthermore, we have

$$
M_{u}(\lambda(f))=\lambda(u f), \quad f \in L^{1}(G),
$$

see [14, Proposition 1.2] and its proof.
Lemma 3.1. Assume that $u$ is a bounded Fourier multiplier on $\operatorname{VN}(G)$.
(1) For all $r \in \mathbb{R}$, we have $\sigma_{r}^{G} \circ M_{u}=M_{u} \circ \sigma_{r}^{G}$.
(2) The operator $M_{u}$ is unital if and only if $u(\epsilon)=1$.
(3) If $M_{u}$ is both unital and positive, then $\varphi_{G} \circ M_{u}=\varphi_{G}$.

Proof. According to (3.3), we have

$$
\left(\sigma_{r}^{G} \circ M_{u}\right)(\lambda(g))=\Delta_{G}(g)^{i r} u(g) \lambda(g)=\left(M_{u} \circ \sigma_{r}^{G}\right)(\lambda(g)),
$$

for all $g \in G$ and all $r \in \mathbb{R}$. Since $M_{u}$ is $w^{*}$-continuous, (1) follows at once.
Part (2) is clear, since $\lambda(\epsilon)$ is the unit of $V N(G)$.
To prove (3), assume that $M_{u}$ is both unital and positive. Let $f \in K(G)$ such that $\lambda(f) \geq 0$. Then $u f \in K(G)$ and $\lambda(u f)=M_{u}(\lambda(f)) \geq 0$. Hence by (3.2),

$$
\varphi_{G}\left(M_{u}(\lambda(f))\right)=(u f)(\epsilon)=f(\epsilon)=\varphi_{G}(\lambda(f)) .
$$

This implies that for all $f_{1} \in K(G)$, we have $\left(\varphi_{G} \circ M_{u}\right)\left(\lambda\left(f_{1}\right)^{*} \lambda\left(f_{1}\right)\right)=\varphi_{G}\left(\lambda\left(f_{1}\right)^{*} \lambda\left(f_{1}\right)\right)$. Using part (1), the $\sigma^{G}$-invariance of $\lambda(K)(G)$, the $w^{*}$-density of $\lambda(K(G))$ and Lemma 2.3, we deduce that $\varphi_{G} \circ M_{u}=\varphi_{G}$.

It follows from (3.4) that

$$
\lambda(K(G)) \subset V N(G)_{a}, \quad \text { with } \sigma_{z}^{G}(\lambda(f))=\lambda\left(\Delta_{G}^{i z} f\right)
$$

for all $f \in K(G)$ and all $z \in \mathbb{C}$. This identity further implies that $\lambda(f) \in \mathcal{N}_{\varphi_{G}}^{\infty}$. Let $K(G) * K(G)$ denote the linear span of all functions $f_{1} * f_{2}$, with $f_{1}, f_{2} \in K(G)$. We deduce from above that

$$
\begin{equation*}
\lambda(K(G) * K(G)) \subset \mathcal{M}_{\varphi_{G}}^{\infty} . \tag{3.5}
\end{equation*}
$$

We will use the Haagerup non-commutative $L^{p}$-spaces $L^{p}\left(V N(G), \varphi_{G}\right)$ associated with the Plancherel weight of $G$. If $u$ is a bounded Fourier multiplier on $V N(G)$ and $M_{u}$ is both unital and positive, then $\left\|M_{u}\right\| \leq 1$, and hence

$$
\begin{equation*}
|u(g)| \leq 1, \quad g \in G \tag{3.6}
\end{equation*}
$$

It further follows from Lemma [3.1, (3) and Proposition 2.4 that for any $1 \leq p<\infty, M_{u}$ gives rise to a contraction $M_{u, p}: L^{p}\left(V N(G), \varphi_{G}\right) \rightarrow L^{p}\left(V N(G), \varphi_{G}\right)$ taking $D_{G}^{\frac{1}{2 p}} x D_{G}^{\frac{1}{2 p}}$ to $D_{G}^{\frac{1}{2 p}} M_{u}(x) D_{G}^{\frac{1}{2 p}}$ for all $x \in \mathcal{M}_{\varphi_{G}}$.
Lemma 3.2. Assume that u is a bounded Fourier multiplier on $V N(G)$ such that $M_{u}$ is both unital and positive. The following assertions are equivalent.
(i) The function $u$ is real-valued.
(ii) The operator $M_{u, 2}: L^{2}\left(V N(G), \varphi_{G}\right) \rightarrow L^{2}\left(V N(G), \varphi_{G}\right)$ is self-adjoint.

In this case, $M_{u, 2}$ is positive in the Hilbertian sense, that is, $\left(M_{u, 2}(h) \mid h\right)_{L^{2}(V N(G))} \geq 0$ for all $h \in L^{2}\left(V N(G), \varphi_{G}\right)$, if and only if $u$ is valued in $[0,1]$.
Proof. We first note that $\varphi_{G}\left(\lambda\left(f^{\prime}\right)^{*} \lambda(f)\right)=\left(f \mid f^{\prime}\right)_{L^{2}(V N(G))}$ for all $f, f^{\prime} \in L^{1}(G) \cap L^{2}(G)$, by polarisation of the identity (3.1). We use this identity twice below.

Let $f, f^{\prime} \in K(G) * K(G)$ and recall (3.5). By Lemma 2.9 and the fact that $M_{u}$ commutes with $\sigma^{G}$, see Lemma 3.1, (1), we have

$$
\begin{aligned}
M_{u, 2}\left(\lambda(f) D_{G}^{\frac{1}{2}}\right) & =M_{u, 2}\left(D_{G}^{\frac{1}{4}} \sigma_{\frac{i}{4}}^{G}(\lambda(f)) D_{G}^{\frac{1}{4}}\right) \\
& =D_{G}^{\frac{1}{4}} M_{u}\left(\sigma_{\frac{i}{4}}^{G}(\lambda(f))\right) D_{G}^{\frac{1}{4}} \\
& =D_{G}^{\frac{1}{4}} \sigma_{\frac{i}{4}}^{G}(\lambda(u f)) D_{G}^{\frac{1}{4}} \\
& =\lambda(u f) D_{G}^{\frac{1}{2}} .
\end{aligned}
$$

Hence by (2.5), we have

$$
\left(\left.M_{u, 2}\left(\lambda(f) D_{G}^{\frac{1}{2}}\right) \right\rvert\, \lambda\left(f^{\prime}\right) D_{G}^{\frac{1}{2}}\right)_{L^{2}(V N(G))}=\operatorname{Tr}_{\varphi_{G}}\left(D_{G}^{\frac{1}{2}} \lambda\left(f^{\prime}\right)^{*} \lambda(u f) D_{G}^{\frac{1}{2}}\right)=\varphi_{G}\left(\lambda\left(f^{\prime}\right)^{*} \lambda(u f)\right)
$$

Therefore,

$$
\begin{equation*}
\left(\left.M_{u, 2}\left(\lambda(f) D_{G}^{\frac{1}{2}}\right) \right\rvert\, \lambda\left(f^{\prime}\right) D_{G}^{\frac{1}{2}}\right)_{L^{2}(V N(G))}=\int_{G} \overline{f^{\prime}} u f \tag{3.7}
\end{equation*}
$$

Likewise,

$$
\left(\lambda(f) D_{G}^{\frac{1}{2}} \left\lvert\, M_{u, 2}\left(\lambda\left(f^{\prime}\right) D_{G}^{\frac{1}{2}}\right)\right.\right)_{L^{2}(V N(G))}=\int_{G} \overline{u f^{\prime}} f
$$

We deduce that $u$ is real-valued if and only if

$$
\left(\left.M_{u, 2}\left(\lambda(f) D_{G}^{\frac{1}{2}}\right) \right\rvert\, \lambda\left(f^{\prime}\right) D_{G}^{\frac{1}{2}}\right)_{L^{2}(V N(G))}=\left(\lambda(f) D_{G}^{\frac{1}{2}} \left\lvert\, M_{u, 2}\left(\lambda\left(f^{\prime}\right) D_{G}^{\frac{1}{2}}\right)\right.\right)_{L^{2}(V N(G))}
$$

for all $f, f^{\prime} \in K(G) * K(G)$.
It follows from [18, Theorem 2.4,(b)] that $\mathcal{N}_{\varphi_{G}}^{\infty} D_{G}^{\frac{1}{2}}$ is dense in $L^{2}\left(V N(G), \varphi_{G}\right)$. The proof of this theorem shows as well that $\lambda(K(G) * K(G)) D_{G}^{\frac{1}{2}}$ is dense in $L^{2}\left(V N(G), \varphi_{G}\right)$. We therefore deduce the equivalence " $(i) \Leftrightarrow(i i)$ " from above.

By (3.6), the function $u$ is valued in $[-1,1]$. Hence the last assertion is obtained by applying (3.7) with $f^{\prime}=f$.

## 4. Dilation result

The main result of this paper is the following theorem. In the case when $G$ is discrete, this result was established in [4, Theorem 4.6], see also [38]. Next, it was proved in [16, Theorem (B)] for any unimodular group $G$. The approach for the non-unimodular case is similar, however significant difficulties arise from the fact that the Plancherel weight may be non tracial.

Theorem 4.1. Let $G$ be a locally compact group and let $u \in C_{b}(G)$ such that $M_{u}: V N(G) \rightarrow$ $V N(G)$ is unital and completely positive. If $u$ is real valued, then $M_{u}$ admits an absolute dilation.
Proof. We let $\ell_{G}^{1, \mathbb{R}}$ be the real $\ell^{1}$-space over $G$, with standard basis $\left(e_{t}\right)_{t \in G}$. Define a bilinear form $[\cdot, \cdot]_{u}: \ell_{G}^{1, \mathbb{R}} \times \ell_{G}^{1, \mathbb{R}} \rightarrow \mathbb{R}$ by

$$
[\alpha, \beta]_{u}=\sum_{s, t \in G} u\left(t^{-1} s\right) \alpha_{t} \beta_{s}, \quad \alpha=\left(\alpha_{t}\right)_{t \in G}, \beta=\left(\beta_{s}\right)_{s \in G} \in \ell_{G}^{1, \mathbb{R}}
$$

According to [14, Proposition 4.2], the complete positivity of $M_{u}: V N(G) \rightarrow V N(G)$ implies that the function $u$ is positive definite. Hence $[\cdot, \cdot]_{u}$ is positive semi-definite. Let $E_{u}=\{\alpha \in$ $\left.\ell_{G}^{1, \mathbb{R}}:[\alpha, \alpha]_{u}=0\right\}$ and let $H_{u}$ be the real Hilbert space obtained by completing the space $\ell_{G}^{1, \mathbb{R}} / E_{u}$ equipped with the norm induced by $[\alpha, \alpha]_{u}(\alpha, \alpha)^{\frac{1}{2}}$. In the sequel, we let $h_{t} \in H_{u}$ denote the class of $e_{t} \in \ell_{G}^{1}(\mathbb{R})$, for all $t \in G$. We let $(\cdot \mid \cdot)_{H_{u}}$ denote the inner product on $H_{u}$.

Let $N$ be the Clifford von Neumann algebra over $H_{u}$ and let $\tau$ denote its standard trace. Let $N_{s a}$ be the self-adjoint part of $N$. We recall that there exists an $\mathbb{R}$-linear map

$$
w: H_{u} \longrightarrow N_{s a}
$$

such that $w(\xi)$ is a unitary for all $\xi \in H_{u}$ with $\|\xi\|_{H_{u}}=1$,

$$
\begin{equation*}
\tau\left(w(h) w\left(h^{\prime}\right)\right)=\left(h \mid h^{\prime}\right)_{H_{u}}, \quad h, h^{\prime} \in H_{u} \tag{4.1}
\end{equation*}
$$

and $N$ is generated (as a von Neumann algebra) by the range of $w$. We refer to [11, 12, 38] for the construction of the Clifford von Neumann algebra and more information.

Fix some $g \in G$. For any $\left(\alpha_{t}\right)_{t \in G} \in \ell_{G}^{1, \mathbb{R}}$, we have

$$
\begin{aligned}
\left\|\sum_{t} \alpha_{g^{-1} t} h_{t}\right\|_{H_{u}}^{2} & =\sum_{s, t \in G} u\left(t^{-1} s\right) \alpha_{g^{-1} t} \alpha_{g^{-1} s}=\sum_{s, t \in G} u\left((g t)^{-1}(g s)\right) \alpha_{t} \alpha_{s} \\
& =\sum_{s, t \in G} u\left(t^{-1} s\right) \alpha_{t} \alpha_{s}=\left\|\sum_{t} \alpha_{t} h_{t}\right\|_{H_{u}}^{2}
\end{aligned}
$$

Hence there exists a (necessarily unique) orthogonal map $\theta_{g} \in B\left(H_{u}\right)$ such that

$$
\theta_{g}\left(h_{t}\right)=h_{g t}, \quad t \in G
$$

Let $\widetilde{\theta_{g}}: N \rightarrow N$ be the second quantization of $\theta_{g}$. By [11, Theorem 2.11], $\widetilde{\theta_{g}}$ is a tracepreserving *-automorphism and we have

$$
\begin{equation*}
\widetilde{\theta_{g}}(w(h))=w\left(\theta_{g}(h)\right), \quad h \in H_{u} \tag{4.2}
\end{equation*}
$$

Recall that $\tau$ is normalized. Let

$$
N^{\otimes}=\underset{\mathbb{Z}}{\bar{\otimes}} N
$$

be the infinite tensor product of $(N, \tau)$ over the index set $\mathbb{Z}$, as considered in 43, Definition XIV.1.6]. Note that the associated state $\tau_{\otimes}:=\bar{\otimes}_{\mathbb{Z}} \tau_{N}$ on $N^{\otimes}$ is a normal faithful tracial state. In the sequel, we let 1 denote the unit of $N$ and we let $1_{\otimes}$ denote the unit of $N^{\otimes}$.

For any integer $m \geq 1$ and for any finite family $\left(x_{k}\right)_{k=-m}^{m}$ in $N$, set

$$
\underset{k}{\otimes} x_{k}=\cdots 1 \otimes 1 \otimes x_{-m} \otimes \cdots \otimes x_{0} \otimes x_{1} \otimes \ldots \otimes x_{m} \otimes 1 \otimes 1 \cdots,
$$

where each $x_{k}$ is in position $k$. For any $g \in G$, we let $\rho(g): N^{\otimes} \rightarrow N^{\otimes}$ be the $*$-automorphism such that

$$
[\rho(g)]\left(\underset{k}{\otimes} x_{k}\right)=\underset{k}{\otimes} \widetilde{\theta}_{g}\left(x_{k}\right)
$$

for all finite families $\left(x_{k}\right)_{k}$ in $N$. Since $\widetilde{\theta_{g}}$ is trace-preserving, $\rho(g)$ is trace-preserving. The mapping $G \rightarrow \operatorname{Aut}(N)$ taking any $g \in G$ to $\widetilde{\theta}_{g}$ is a group homomorphism and it follows from [16, Lemma 5.4] that it is continuous in the sense of [42, Proposition X.1.2]. We easily deduce that $\rho: G \rightarrow \operatorname{Aut}\left(N^{\otimes}\right)$ is a continuous group homomorphism as well.

We are going to use crossed products, for which we refer again to either [39, Chapter IV] or [42, Chapter X]. We let

$$
M=N^{\otimes} \rtimes_{\rho} G \subset B\left(L^{2}(G)\right) \bar{\otimes} N^{\otimes}
$$

be the crossed product associated with $\rho$. We regard $N^{\otimes} \subset M$ in the usual way. We recall that $V N(G) \otimes 1_{\otimes} \subset M$ and that $M$ is generated (as a von Neumann algebra) by $N^{\otimes}$ and $V N(G) \otimes 1_{\otimes}$. We also recall (see e.g. [39, 19.1.(2)]) that

$$
\begin{equation*}
\rho(g) x=\left(\lambda(g) \otimes 1_{\otimes}\right) x\left(\lambda\left(g^{-1}\right) \otimes 1_{\otimes}\right), \quad x \in N^{\otimes}, g \in G \tag{4.3}
\end{equation*}
$$

This implies that the linear span of $\left\{x\left(y \otimes 1_{\otimes}\right): x \in N^{\otimes}, y \in V N(G)\right\}$ is $w^{*}$-dense in $M$. We will use it in the sequel without any further reference.

Let $K\left(G, N^{\otimes}\right)$ be the space of all $\sigma$-strong*-continuous functions $G \rightarrow N^{\otimes}$ with compact support. For any $F \in K\left(G, N^{\otimes}\right)$, we define $T_{F} \in M$ by

$$
T_{F}=\int_{G} F(g)\left(\lambda(g) \otimes 1_{\otimes}\right) d g
$$

where the integral is defined in the $w^{*}$-sense. Following [42, pp. 242-243], given any $F_{1}, F_{2} \in$ $K\left(G, N^{\otimes}\right)$, we may define $F_{1} * F_{2} \in K\left(G, N^{\otimes}\right)$ by

$$
\left(F_{1} * F_{2}\right)(g)=\int_{G} F_{1}(t) \rho(t)\left(F_{2}\left(t^{-1} g\right)\right) d t, \quad g \in G
$$

and we have

$$
T_{F_{1}} * T_{F_{2}}=T_{F_{1} * F_{2}}
$$

Similarly, given any $F \in K\left(G, N^{\otimes}\right)$, we may define $F^{*} \in K\left(G, N^{\otimes}\right)$ by

$$
F^{*}(g)=\Delta_{G}(g)^{-1} \rho(g)\left(F\left(g^{-1}\right)^{*}\right), \quad g \in G,
$$

and we have

$$
T_{F}^{*}=T_{F^{*}} .
$$

Using these definitions, we see that

$$
\begin{equation*}
\left(F^{*} * F\right)(g)=\int_{G} \Delta_{G}(t)^{-1} \rho(t)\left(F\left(t^{-1}\right)^{*} F\left(t^{-1} g\right)\right) d t, \quad g \in G \tag{4.4}
\end{equation*}
$$

It actually follows from [42, Lemma X.1.8] that

$$
\mathcal{B}:=\left\{T_{F}: F \in K\left(G, N^{\otimes}\right)\right\}
$$

is a $w^{*}$-dense $*$-subalgebra of $M$.
We let $\psi$ be the dual weight of $\tau_{\otimes}$ on $M$. This weight is normal, semi-finite and faithful [42, Lemma X.1.18], so that $(M, \psi)$ is a weighted von Neumann algebra. Moreover

$$
\mathcal{B} \subset \mathcal{N}_{\psi}
$$

and for any $F \in K\left(G, N^{\otimes}\right)$, we have

$$
\psi\left(T_{F}^{*} T_{F}\right)=\tau_{\otimes}\left(\left(F^{*} * F\right)(\epsilon)\right)
$$

see [42, Theorem X.1.17,(i)]. This is an analogue of (3.2). According to [42, Theorem X.1.17,(ii)] and (3.3), the modular automorphism group $\sigma^{\psi}$ satisfies:

$$
\begin{equation*}
\forall x \in N^{\otimes}, \quad \sigma_{r}^{\psi}(x)=x \quad \text { and } \quad \forall y \in V N(G), \quad \sigma_{r}^{\psi}\left(y \otimes 1_{\otimes}\right)=\sigma_{r}^{G}(y) \otimes 1_{\otimes} \tag{4.5}
\end{equation*}
$$

for all $r \in \mathbb{R}$.
We define a $w^{*}$-continuous unital $*$-homomorphism

$$
J: V N(G) \longrightarrow M, \quad J(y)=y \otimes 1_{\otimes} \quad \text { for all } y \in V N(G)
$$

It follows from the second part of (4.5) that

$$
\begin{equation*}
\sigma^{\psi} \circ J=J \circ \sigma^{G} \tag{4.6}
\end{equation*}
$$

Let $f \in K(G)$ and let $F=f \otimes 1_{\otimes} \in K\left(G, N^{\otimes}\right)$. Then $J(\lambda(f))=T_{F}$ and we both have $F^{*} * F=\left(f^{*} * f\right) \otimes 1_{\otimes}$ and $J\left(\lambda(f)^{*} \lambda(f)\right)=T_{F^{*} * F}$. Therefore,

$$
\psi\left(J\left(\lambda(f)^{*} \lambda(f)\right)\right)=\tau_{\otimes}\left(\left(F^{*} * F\right)(\epsilon)\right)=\left(f^{*} * f\right)(\epsilon)=\varphi_{G}\left(\lambda(f)^{*} \lambda(f)\right)
$$

by (3.2). We deduce, using (4.6) and Lemma 2.3, that $J$ is weight-preserving.
Let us record two remarkable properties of $J$. First, we have

$$
\begin{equation*}
\psi(x J(y))=\tau_{\otimes}(x) \varphi_{G}(y), \quad x \in N^{\otimes}, y \in \mathcal{M}_{\varphi_{G}} \tag{4.7}
\end{equation*}
$$

To prove this, consider $x \in N^{\otimes} \backslash\{0\}$ and define

$$
\gamma: V N(G)^{+} \longrightarrow[0, \infty], \quad \gamma(y)=\tau_{\otimes}\left(x^{*} x\right)^{-1} \psi\left(x J(y) x^{*}\right)
$$

This is a normal semi-finite weight.
Given any $f \in K(G)$, let $F \in K\left(G, N^{\otimes}\right)$ be defined by

$$
F(g)=\Delta_{G}(g)^{-1} \overline{f\left(g^{-1}\right)} \rho(g)\left(x^{*}\right), \quad g \in G
$$

This function is chosen in such a way that $F^{*}=f \otimes x$. Thus, we have $T_{F}^{*}=T_{F^{*}}=x J(\lambda(f))$. Consequently,

$$
\gamma\left(\lambda(f) \lambda(f)^{*}\right)=\tau_{\otimes}\left(x^{*} x\right)^{-1} \psi\left(T_{F}^{*} T_{F}\right)=\tau_{\otimes}\left(x^{*} x\right)^{-1} \tau_{\otimes}\left(\left(F^{*} * F\right)(\epsilon)\right)
$$

Using (4.4), we compute

$$
\left(F^{*} * F\right)(\epsilon)=\|f\|_{2} x x^{*}
$$

We deduce that

$$
\gamma\left(\lambda(f) \lambda(f)^{*}\right)=\varphi_{G}\left(\lambda(f) \lambda(f)^{*}\right)
$$

By the first part of (4.5), $x$ belongs to the centralizer of $\psi$, hence

$$
\gamma(\cdot)=\tau_{\otimes}\left(x^{*} x\right)^{-1} \psi\left(J(\cdot) x^{*} x\right)
$$

by [42, Theorem VIII.2.6]. Applying (4.6), we deduce that $\gamma \circ \sigma^{G}=\gamma$. Then arguing as in the proof of Lemma 3.1, (3), we infer that $\gamma=\varphi_{G}$. Using the fact that $x^{*}$ belongs to the centralizer of $\psi$, this yields $\psi\left(x^{*} x J(y)\right)=\tau_{\otimes}\left(x^{*} x\right) \varphi_{G}(y)$ for all $y \in \mathcal{M}_{\varphi_{G}}$. The identity (4.7) follows at once.

Let us now show that

$$
\begin{equation*}
\mathbb{E}_{J}(x J(y))=\tau_{\otimes}(x) y, \quad x \in N^{\otimes}, y \in V N(G) \tag{4.8}
\end{equation*}
$$

Since $J$ and $\mathbb{E}_{J}$ are $w^{*}$-continuous, we may assume in the proof of (4.8) that $y \in \mathcal{M}_{\varphi_{G}}$. Let $m \in \mathcal{M}_{\varphi_{G}}^{\infty}$. Since $J$ is a weight-preserving $*$-homomorphism and $J$ satisfies (4.6), we easily obtain, as in the proof of Lemma 2.12, that

$$
J(y) \in \mathcal{M}_{\psi} \quad \text { and } \quad J(m) \in \mathcal{M}_{\psi}^{\infty}
$$

Since $x$ belongs to the centralizer of $\psi$, the product $x J(y)$ belongs to $\mathcal{M}_{\psi}$, by [42, Theorem VIII.2.6]. Using Lemmas 2.12 and 2.10, we deduce that

$$
\begin{aligned}
\left\langle\mathbb{E}_{J}(x J(y)), D_{G}^{\frac{1}{2}} m D_{G}^{\frac{1}{2}}\right\rangle_{V N(G), L^{1}(V N(G))} & =\left\langle x J(y), J_{1}\left(D_{G}^{\frac{1}{2}} m D_{G}^{\frac{1}{2}}\right)\right\rangle_{M, L^{1}(M)} \\
& \left.=\left\langle x J(y), D_{\psi}^{\frac{1}{2}} J(m) D_{\psi}^{\frac{1}{2}}\right)\right\rangle_{M, L^{1}(M)} \\
& =\operatorname{Tr}_{\psi}\left(x J(y) D_{\psi}^{\frac{1}{2}} J(m) D_{\psi}^{\frac{1}{2}}\right) \\
& =\psi\left(x J(y) \sigma_{-\frac{i}{2}}^{\psi}(J(m))\right)
\end{aligned}
$$

Using (4.6) again and (4.7), we have

$$
\psi\left(x J(y) \sigma_{-\frac{i}{2}}^{\psi}(J(m))\right)=\psi\left(x J\left(y \sigma_{-\frac{i}{2}}^{G}(m)\right)\right)=\tau_{\otimes}(x) \varphi_{G}\left(y \sigma_{-\frac{i}{2}}^{G}(m)\right)
$$

By Lemmas 2.12 and 2.10 again,

$$
\varphi_{G}\left(y \sigma_{-\frac{i}{2}}^{\psi}(m)\right)=\operatorname{Tr}_{\varphi_{G}}\left(y D_{G}^{\frac{1}{2}} m D_{G}^{\frac{1}{2}}\right)=\left\langle\mathbb{E}_{J}(y), D_{G}^{\frac{1}{2}} m D_{G}^{\frac{1}{2}}\right\rangle_{V N(G), L^{1}(V N(G))}
$$

Altogether, we obtain that

$$
\left\langle\mathbb{E}_{J}(x J(y)), D_{G}^{\frac{1}{2}} m D_{G}^{\frac{1}{2}}\right\rangle_{V N(G), L^{1}(V N(G))}=\tau_{\otimes}(x)\left\langle\mathbb{E}_{J}(y), D_{G}^{\frac{1}{2}} m D_{G}^{\frac{1}{2}}\right\rangle_{V N(G), L^{1}(V N(G))}
$$

Since $D_{G}^{\frac{1}{2}} \mathcal{M}_{\varphi_{G}}^{\infty} D_{G}^{\frac{1}{2}}$ is dense in $L^{1}(V N(G))$, see Lemma 2.8, we deduce (4.8).
We now aim at constructing a suitable $U: M \rightarrow M$. We proceed in two steps.
We let $\mathfrak{s}: N^{\otimes} \rightarrow N^{\otimes}$ be the $*$-automorphism such that

$$
\mathfrak{s}\left(\underset{k}{\otimes} x_{k}\right)=\underset{k}{\otimes} x_{k-1}
$$

for all finite families $\left(x_{k}\right)_{k}$ in $N$. Clearly $\mathfrak{s}$ is trace-preserving, i.e.

$$
\begin{equation*}
\tau_{\otimes} \circ \mathfrak{s}=\tau_{\otimes} \tag{4.9}
\end{equation*}
$$

Moreover $\rho(g) \circ \mathfrak{s}=\mathfrak{s} \circ \rho(g)$ for all $g \in G$. This commutation property ensures, by 40, Theorem 4.4.4], that there exists a (necessarily unique) $*$-automorphism $\widetilde{\mathfrak{s}}: M \rightarrow M$ such that

$$
\forall x \in N^{\otimes}, \quad \widetilde{\mathfrak{s}}(x)=\mathfrak{s}(x) \quad \text { and } \quad \forall y \in V N(G), \quad \widetilde{\mathfrak{s}}\left(y \otimes 1_{\otimes}\right)=y \otimes 1_{\otimes}
$$

It follows from these identities and (4.5) that

$$
\begin{equation*}
\sigma^{\psi} \circ \widetilde{\mathfrak{s}}=\widetilde{\mathfrak{s}} \circ \sigma^{\psi} \tag{4.10}
\end{equation*}
$$

Let us show that $\widetilde{\mathfrak{s}}$ is weight-preserving. Let $F \in K\left(G, N^{\otimes}\right)$ and let $r \in \mathbb{R}$. Then

$$
\sigma_{r}^{\psi}\left(T_{F}\right)=\int_{G} \sigma_{r}^{\psi}(F(g)) \sigma_{r}^{\psi}\left(\lambda(g) \otimes 1_{\otimes}\right) d g=\int_{G} F(g) \Delta_{G}(g)^{i r}\left(\lambda(g) \otimes 1_{\otimes}\right) d g=T_{\Delta_{G}^{i r} F} .
$$

Hence $\mathcal{B}$ is $\sigma^{\psi}$-invariant. Using Lemma [2.3, (4.10), and the fact that $\mathcal{B}$ is a $w^{*}$-dense $*-$ subalgebra of $M$, it therefore suffices to show that

$$
\begin{equation*}
(\psi \circ \widetilde{\mathfrak{s}})\left(T_{F}^{*} T_{F}\right)=\psi\left(T_{F}^{*} T_{F}\right), \quad F \in K\left(G, N^{\otimes}\right) \tag{4.11}
\end{equation*}
$$

to obtain that $\psi \circ \widetilde{\mathfrak{s}}=\psi$. To prove this, consider $F \in K\left(G, N^{\otimes}\right)$ and write

$$
\widetilde{\mathfrak{s}}\left(T_{F}^{*} T_{F}\right)=\widetilde{\mathfrak{s}}\left(\int_{G}\left(F^{*} * F\right)(g)\left(\lambda(g) \otimes 1_{\otimes}\right) d g\right)=\int_{G} \mathfrak{s}\left(\left(F^{*} * F\right)(g)\right)\left(\lambda(g) \otimes 1_{\otimes}\right) d g
$$

Since $\mathfrak{s} \circ \rho(t)=\rho(t) \circ \mathfrak{s}$, we deduce, using (4.4), that

$$
\begin{aligned}
\mathfrak{s}\left(\left(F^{*} * F\right)(g)\right) & =\int_{G} \Delta_{G}(t)^{-1} \rho(t)\left(\mathfrak{s}\left(F\left(t^{-1}\right)^{*}\right) \mathfrak{s}\left(F\left(t^{-1} g\right)\right)\right) d t \\
& =\left[(\mathfrak{s} \circ F)^{*} *(\mathfrak{s} \circ F)\right](g), \quad g \in G .
\end{aligned}
$$

Consequently,

$$
\begin{equation*}
\widetilde{\mathfrak{s}}\left(T_{F}^{*} T_{F}\right)=T_{\mathfrak{s} \circ F}^{*} T_{\mathfrak{s} \circ F} . \tag{4.12}
\end{equation*}
$$

We deduce, using (4.9), that

$$
\begin{aligned}
(\psi \circ \widetilde{\mathfrak{s}})\left(T_{F}^{*} T_{F}\right) & \left.=\tau_{\otimes}\left([\mathfrak{s} \circ F)^{*} *(\mathfrak{s} \circ F)\right](\epsilon)\right) \\
& =\tau_{\otimes}\left(\mathfrak{s}\left(\left(F^{*} * F\right)(\epsilon)\right)\right) \\
& =\tau_{\otimes}\left(\left(F^{*} * F\right)(\epsilon)\right) \\
& =\psi\left(T_{F}^{*} T_{F}\right),
\end{aligned}
$$

which proves (4.11).
For any $g \in G$, let $\delta_{g} \in N^{\otimes}$ be defined by

$$
\delta_{g}=\cdots 1 \otimes \cdots \otimes 1 \otimes w\left(h_{g}\right) \otimes 1 \otimes \cdots \otimes 1 \otimes \cdots
$$

where $w\left(h_{g}\right)$ is in position 0 . By assumption, $M_{u}$ is unital hence $\left\|h_{\epsilon}\right\|_{H_{u}}=u(\epsilon)=1$, see Lemma 3.1, (2). Consequently, $w\left(h_{\epsilon}\right)$ is a unitary of $N$ hence $\delta_{\epsilon}$ is a self-adjoint unitary of $N^{\otimes} \subset M$. Let $U: M \rightarrow M$ be defined by

$$
U(z)=\delta_{\epsilon} \widetilde{\mathfrak{s}}(z) \delta_{\epsilon}, \quad z \in M
$$

Then $U$ is a $*$-automorphism. By the first part of (4.5), $\delta_{\epsilon}$ belongs to the centralizer of $\psi$, hence we may write $\psi(U(y))=\psi\left(\widetilde{\mathfrak{s}}(y) \delta_{\epsilon}^{2}\right)=\psi(\widetilde{\mathfrak{s}}(y))=\psi(y)$. Thus we have

$$
\psi \circ U=\psi
$$

Let us now check that $T=M_{u}$ satisfies (2.2). We observe that by (4.2), we have

$$
\rho(g)\left(\delta_{t}\right)=\delta_{g t}, \quad g, t \in G
$$

Applying (4.3), we deduce that

$$
\begin{equation*}
\left(\lambda(g) \otimes 1_{\otimes}\right) \delta_{\epsilon}=\delta_{g}\left(\lambda(g) \otimes 1_{\otimes}\right), \quad g \in G . \tag{4.13}
\end{equation*}
$$

Let $g \in G$. Then $\widetilde{\mathfrak{s}}\left(\lambda(g) \otimes 1_{\otimes}\right)=\lambda(g) \otimes 1_{\otimes}$, hence by (4.13), we have

$$
U J(\lambda(g))=\delta_{\epsilon} \delta_{g}\left(\lambda(g) \otimes 1_{\otimes}\right)
$$

Next,

$$
\widetilde{\mathfrak{s}}\left(\delta_{\epsilon} \delta_{g}\right)=\cdots 1 \otimes \cdots \otimes 1 \otimes w\left(h_{\epsilon}\right) w\left(h_{g}\right) \otimes 1 \otimes \cdots \otimes 1 \otimes \cdots,
$$

where $w\left(h_{\epsilon}\right) w\left(h_{g}\right)$ is in position 1 . Hence $\delta_{\epsilon}$ commutes with $\widetilde{\mathfrak{s}}\left(\delta_{\epsilon} \delta_{g}\right)$ and using (4.13) again, we obtain

$$
U^{2} J(\lambda(g))=\delta_{\epsilon} \widetilde{\mathfrak{s}}\left(\delta_{\epsilon} \delta_{g}\right)\left(\lambda(g) \otimes 1_{\otimes}\right) \delta_{\epsilon}=\widetilde{\mathfrak{s}}\left(\delta_{\epsilon} \delta_{g}\right) \delta_{\epsilon} \delta_{g}\left(\lambda(g) \otimes 1_{\otimes}\right) .
$$

More explicitly,

$$
U^{2} J(\lambda(g))=\left(\cdots \otimes 1 \otimes w\left(h_{\epsilon}\right) w\left(h_{g}\right) \otimes w\left(h_{\epsilon}\right) w\left(h_{g}\right) \otimes 1 \otimes \cdots\right)\left(\lambda(g) \otimes 1_{\otimes}\right)
$$

with $w\left(h_{\epsilon}\right) w\left(e_{g}\right)$ in positions 0 and 1 . Then we obtain by induction that for all integer $k \geq 0$, we have

$$
U^{k} J(\lambda(g))=\left(\cdots \otimes 1 \otimes w\left(h_{\epsilon}\right) w\left(e_{g}\right) \otimes \cdots \otimes w\left(h_{\epsilon}\right) w\left(e_{g}\right) \otimes 1 \otimes \cdots\right)\left(\lambda(g) \otimes 1_{\otimes}\right)
$$

with $w\left(h_{\epsilon}\right) w\left(e_{g}\right)$ in positions $0, \ldots, k-1$. According to (4.8) and (4.1), this implies that

$$
\begin{aligned}
\mathbb{E}_{J} U^{k} J(\lambda(g)) & =\tau_{\otimes}\left(\cdots \otimes 1 \otimes w\left(h_{\epsilon}\right) w\left(e_{g}\right) \otimes \cdots \otimes w\left(h_{\epsilon}\right) w\left(e_{g}\right) \otimes 1 \otimes \cdots\right) \lambda(g) \\
& =\tau\left(w\left(h_{\epsilon}\right) w\left(h_{g}\right)\right)^{k} \lambda(g) \\
& =\left(h_{\epsilon} \mid h_{g}\right)_{H_{u}}^{k} \lambda(g) \\
& =u(g)^{k} \lambda(g)
\end{aligned}
$$

Thus, $\mathbb{E}_{J} U^{k} J(\lambda(g))=M_{u}^{k}(\lambda(g))$ for all $k \geq 0$ and all $g \in G$. Since the operators $M_{u}, J, U$ and $\mathbb{E}_{J}$ are all $w^{*}$-continuous and $\operatorname{Span}\{\lambda(g): g \in G\}$ is $w^{*}$-dense in $V N(G)$, we deduce (2.2) for all $k \geq 0$.

If we restrict to the case when $G$ is unimodular, the above proof is different and somewhat simpler than the one in [16] or [4]. Indeed, we do not use [16, Lemma 2.7].

Remark 4.2. We observe (as in [16, Theorem 6.3]) that we can simulteously dilate any finite family of Fourier multipliers satisfying the assumptions of Theorem 4.1. More explicitly, let $u_{1}, \ldots, u_{n} \in C_{b}(G)$ such that $M_{u_{j}}: V N(G) \rightarrow V N(G)$ is unital and completely positive and $u_{j}$ is real valued, for all $j=1, \ldots, n$. Then there exist a weighted von Neumann algebra $(M, \psi)$, a $w^{*}$-continuous, unital and weight-preserving $*$-homomorphism $J: V N(G) \rightarrow M$
such that $\sigma^{\psi} \circ J=J \circ \sigma^{\varphi}$, as well as a commuting family $\left(U_{1}, \ldots, U_{n}\right)$ of weight-preserving *-automorphisms on $M$, such that

$$
\forall k_{1}, \ldots, k_{n} \geq 0, \quad M_{u_{1}}^{k_{1}} \cdots M_{u_{n}}^{k_{n}}=\mathbb{E}_{J} U_{1}^{k_{1}} \cdots U_{n}^{k_{n}} J .
$$

## 5. An application to functional calculus

The aim of this section is to establish a functional calculus property of the $L^{p}$-realization of certain Fourier multipliers $M_{u}: V N(G) \rightarrow V N(G)$.

Let $\mathbb{D}=\{z \in \mathbb{C}:|z|<1\}$ be the open unit disc. Let $X$ be a Banach space and let $T \in B(X)$. We say that $T$ is power bounded if there exists a constant $C_{0} \geq 1$ such that $\left\|T^{k}\right\| \leq C_{0}$ for all integer $k \geq 0$. Let $\sigma(T)$ denote the spectrum of $T$. We say that $T$ is a Ritt operator if $\sigma(T) \subset \overline{\mathbb{D}}$ and there exists a constant $C>0$ such that

$$
\left\|(z-T)^{-1}\right\| \leq \frac{C}{|z-1|}, \quad z \in \mathbb{C} \backslash \overline{\mathbb{D}}
$$

A classical result (see e.g. [46]) asserts that $T$ is a Ritt operator if and only if $T$ is power bounded and there exists a constant $C_{1} \geq 1$ such that

$$
n\left\|T^{n}-T^{n-1}\right\| \leq C_{1}, \quad n \geq 1
$$

For any $\gamma \in\left(0, \frac{\pi}{2}\right)$, let $B_{\gamma}$ be the interior of the convex hull of 1 and the disc $\{|z|<\sin \gamma\}$, see Figure 1 below. It is well-known that the spectrum of any Ritt operator $T$ is included in the closure of one of the $B_{\gamma}$.


Figure 1. Stolz domain
Let $\mathcal{P}$ be the algebra of complex polynomials and let $T \in B(X)$ be a Ritt operator. For any $\gamma \in\left(0, \frac{\pi}{2}\right)$, we say that $T$ admits a bounded $H^{\infty}\left(B_{\gamma}\right)$-functional calculus if there exists a constant $K \geq 1$ such that

$$
\|F(T)\| \leq K \sup \left\{|F(z)|: z \in B_{\gamma}\right\}, \quad F \in \mathcal{P}
$$

Then we simply say that $T$ admits a bounded $H^{\infty}$-functional calculus if it admits a bounded $H^{\infty}\left(B_{\gamma}\right)$-functional calculus for some $\gamma \in\left(0, \frac{\pi}{2}\right)$. This implies that $T$ is polynomially bounded, that is, $T$ satisfies an estimate $\|F(T)\| \leq K \sup \{|F(z)|: z \in \mathbb{D}\}$ for all $F \in \mathcal{P}$.

Ritt operator and their $H^{\infty}$-functional calculus have attracted a lot of attention in the last twenty years. We refer the reader to [7, 8, 10, 15, 19, 24, 25, 35, 46] and the reference therein for more information.

The main result of this section is the following theorem. Note that in this statement, the multiplier $u$ is not only a real valued function but a nonnegative one.

Theorem 5.1. Let $G$ be a locally compact group, let $u: G \rightarrow[0,1]$ be a continuous function, and assume that $M_{u}: V N(G) \rightarrow V N(G)$ is unital and completely positive. Then for all $1<p<\infty, M_{u, p}: L^{p}\left(V N(G), \varphi_{G}\right) \rightarrow L^{p}\left(V N(G), \varphi_{G}\right)$ is a Ritt operator which admits a bounded $H^{\infty}$-functional calculus.

We need sectorial operators and their $H^{\infty}$ functional calculus. We refer to [28, Chapter 10] for background and undefined terminology on this topic. As in this reference, we set

$$
\Sigma_{\theta}=\{z \in \mathbb{C} \backslash\{0\}:|\operatorname{Arg}(z)|<\theta\}
$$

for any $\theta \in(0, \pi)$. The following was proved in [35, Proposition 4.1].
Proposition 5.2. Let $T \in B(X)$ be a Ritt operator. Then $I_{X}-T$ is a sectorial operator. If there exists $\theta \in\left(0, \frac{\pi}{2}\right)$ such that $I_{X}-T$ admits a bounded $H^{\infty}\left(\Sigma_{\theta}\right)$ functional calculus, then $T$ admits a bounded $H^{\infty}$-functional calculus.

The proof of Theorem 5.1 will also rely on interpolation. Given any interpolation couple $\left(X_{0}, X_{1}\right)$ of Banach spaces and $\alpha \in[0,1]$, we let $\left[X_{0}, X_{1}\right]_{\alpha}$ denote the Banach space obtained by the complex interpolation method. We refer to [9, Chapter 4] for background.

Proposition 5.3. Let $\left(X_{0}, X_{1}\right)$ be an interpolation couple of Banach spaces and consider an operator $T: X_{0}+X_{1} \rightarrow X_{0}+X_{1}$ such that

$$
T: X_{0} \longrightarrow X_{0} \quad \text { and } \quad T: X_{1} \longrightarrow X_{1}
$$

are bounded. If $T: X_{0} \rightarrow X_{0}$ is a Ritt operator and $T: X_{1} \rightarrow X_{1}$ is power bounded, then for all $\alpha \in[0,1), T:\left[X_{0}, X_{1}\right]_{\alpha} \rightarrow\left[X_{0}, X_{1}\right]_{\alpha}$ is a Ritt operator.
Proof. This result was proved by Blunck in the case when $X_{0}=L^{p}(\Omega)$ and $X_{1}=L^{q}(\Omega)$ for a measure space $(\Omega, \mu)$ and $1 \leq p, q \leq \infty$, see [10, Theorem 1.1]. His arguments apply as well in this abstract setting.
Proof of Theorem 5.1. We set $A=V N(G), \varphi=\varphi_{G}$ and $D=D_{G}$ for simplcity. We use complex interpolation for the spaces $L^{p}(A, \varphi)$. Following [45] (see also [13, Section 6], [32] and [26, Chapter 9]), we regard $\left(A, L^{1}(A, \varphi)\right)$ as an interpolation couple of Banach spaces, using the embedding $\mathcal{M}_{\varphi} \rightarrow L^{1}(A, \varphi)$ which takes $x$ to $D^{\frac{1}{2}} x D^{\frac{1}{2}}$ for any $x \in \mathcal{M}_{\varphi}$. Then for any $1 \leq p \leq \infty$, the mapping $D^{\frac{1}{2 p}} \mathcal{M}_{\varphi} D^{\frac{1}{2 p}} \rightarrow L^{1}(A, \varphi)$ which takes $D^{\frac{1}{2 p}} x D^{\frac{1}{2 p}}$ to $D^{\frac{1}{2}} x D^{\frac{1}{2}}$ for any $x \in \mathcal{M}_{\varphi}$ extends to an isometric isomorphism

$$
\begin{equation*}
L^{p}(A, \varphi) \simeq\left[A, L^{1}(A, \varphi)\right]_{\frac{1}{p}} \tag{5.1}
\end{equation*}
$$

Furthermore, if $V: A \rightarrow A$ is a weight-preserving positive map, we can define $T: A+$ $L^{1}(A, \varphi) \rightarrow A+L^{1}(A, \varphi)$ by $T(x+y)=V(x)+V_{1}(y)$ for all $(x, y) \in A \times L^{1}(A, \varphi)$ and the interpolation operator on $\left[A, L^{1}(A, \varphi)\right]_{\frac{1}{p}}$ induced by $T$ coincides with $V_{p}$ though the identification (5.1).

Let $u: G \rightarrow[0,1]$ be a continuous function such that $M_{u}: V N(G) \rightarrow V N(G)$ is unital and completely positive and let us apply the above properties with $V=M_{u}$. We fix some $p \in[2, \infty)$, the case when $p \in(1,2)$ being similar.

According to Lemma [3.2, $M_{u, 2}$ is positive in the Hilbertian sense. Hence $\sigma\left(M_{u, 2}\right) \subset[0,1]$. Then, by the functional calculus of self-adjoint operators, $M_{u, 2}$ is a Ritt operator. Indeed, for any $z \in \mathbb{C} \backslash \overline{\mathbb{D}}$, we have an estimate

$$
\left\|\left(z-M_{u, 2}\right)^{-1}\right\| \leq \sup \left\{|z-t|^{-1}: t \in[0,1]\right\} \lesssim|z-1|^{-1}
$$

By (5.1) and the reiteration theorem for complex interpolation (see [9, Theorem 4.6.1]), we have

$$
L^{p}(A, \varphi) \simeq\left[A, L^{2}(A, \varphi)\right]_{\frac{2}{p}} .
$$

Hence by Proposition 5.3, $M_{u, p}$ is a Ritt operator.
The rest of the proof is similar to the one of [5, Theorem 7.1]. Let $q \in(p, \infty)$ and let $\theta_{0} \in\left(\frac{\pi}{2}, \pi\right)$. By Theorem 4.1 and Proposition [2.7, the operator $M_{u, q}$ admits an isometric $q$-dilation. Hence by [7, Proposition 6.2], the sectorial operator $I_{L^{q}}-M_{u, q}$ admits a bounded $H^{\infty}\left(\Sigma_{\theta_{0}}\right)$ functional calculus. (The non-commutative $L^{q}$-spaces considered in [7, Section 6] are the tracial ones. However the results contained therein extend verbatim to the framework of Haagerup non-commutative $L^{q}$-spaces, using the fact that for $1<q<\infty$, these spaces satisfy the UMD property, see [37, Corollary 7.7].)

Let $\theta_{1} \in\left(0, \frac{\pi}{2}\right)$. The operator $I_{L^{2}}-M_{u, 2}$ is self-adjoint and $\sigma\left(I_{L^{2}}-M_{u, 2}\right) \subset[0,1]$. Hence using again the functional calculus of self-adjoint operators, we see that $I_{L^{2}}-M_{u, 2}$ admits a bounded $H^{\infty}\left(\Sigma_{\theta_{0}}\right)$ functional calculus. Applying again the reiteration theorem for complex interpolation, we obtain that

$$
L^{p}(A, \varphi) \simeq\left[L^{q}(A, \varphi), L^{2}(A, \varphi)\right]_{\alpha}, \quad \text { with } \frac{1-\alpha}{q}+\frac{\alpha}{2}=\frac{1}{p}
$$

Now applying the interpolation theorem for the $H^{\infty}$-functional calculus of sectorial operators [31, Proposition 4.9] (see also [30, Proposition 5.8]), we deduce that $I_{L^{p}}-M_{u, p}$ admits a bounded $H^{\infty}\left(\Sigma_{\theta}\right)$ functional calculus, with $\theta=(1-\alpha) \theta_{0}+\alpha \theta_{1}$. We can choose $q, \theta_{0}, \theta_{1}$ so that $\theta \in\left(0, \frac{\pi}{2}\right)$. (We can actually obtain bounded $H^{\infty}\left(\Sigma_{\theta}\right)$ functional calculus for any $\theta>\left(\frac{1}{2}-\frac{1}{p}\right) \pi$.) By Proposition 5.2, this implies that $M_{u, p}$ admits a bounded $H^{\infty}$-functional calculus.
