# Solutions to some problems on unique representation bases 

Yuchen Ding*


#### Abstract

In this note, three 2003 problems of Nathanson and two 2007 problems of Chen on unique representation bases for the integers are resolved.


## 1. Introduction

Let $\mathbb{N}$ be the set of natural numbers and $A$ a subset of $\mathbb{N}$. For any $n \in \mathbb{N}$, let

$$
r_{A}(n)=\#\left\{\left(a, a^{\prime}\right): n=a+a^{\prime}, a \leq a^{\prime}, a, a^{\prime} \in A\right\} .
$$

One of the most attractive unsloved problems in additive combinatorics is the ErdősTurán conjecture on additive bases [2] posed in 1941, which states that if $r_{A}(n) \geq 1$ for all sufficiently large $n$, then $r_{A}(n)$ cannot be unbounded.

However, things get changed if one replaces the natural set $\mathbb{N}$ by the integer set $\mathbb{Z}$. A set $A$ is called a unique representation basis of $\mathbb{Z}$ if $r_{A}(n)=1$ for all $n \in \mathbb{Z}$. In a fairly original article, Nathanson [4] showed that there is a unique representation basis of $\mathbb{Z}$. Nathanson further proved that a unique representation basis can be arbitrarily sparse. In addition, Nathanson proved that every unique representation basis $A$ for the integers satisfies $A(-x, x) \leq \sqrt{8 x}$, where $A(y, x)=|A \cap[y, x]|$. Nathanson himself constructed a unique representation basis $A$ such that

$$
A(-x, x) \geq(2 / \log 5) \log x+0.63
$$

Based on the results above, Nathanson asked whether there exists a number $\theta<1 / 2$ so that $A(-x, x) \leq x^{\theta}$ for every unique representation basis $A$ and for all sufficiently large $x$ ? Nathanson [4] also posed the following three open problems:

Problem 1. For each number $c>2 / \log 5$, does there exist a unique representation basis $A$ such that $A(-x, x)>c \log x$ for all sufficiently large $x$ ?

Problem 2. Does there exist a unique representation basis $A$ such that

$$
\lim _{x \rightarrow \infty} \frac{A(-x, x)}{\log x}=\infty ?
$$

Problem 3. Does there exist a number $\theta>0$ and a unique representation $A$ such that $A(-x, x) \geq x^{\theta}$ for all sufficiently large $x$ ?

As was already shown by Chen [1], the classical results on finite Sidon sets (see e.g. [5]) can be used to construct unique representation basis $A$ with large growth of the number of its elements infinitely often. Precisely, Chen proved that for any $\varepsilon>0$ there is a unique representation basis $A$ for the integers such that $A(-x, x) \geq x^{1 / 2-\varepsilon}$ for infinitely many positive integers $x$, which gave a negative answer to the problem of

[^0]Nathanson mentioned above. Chen [1] then posed some open problems. Two of them are as follows:

Problem 4. Does there exist a real number $c>0$ and a unique representation basis $A$ such that $A(-x, x) \geq c \sqrt{x}$ for infinitely many positive integers $x$ ?
Problem 5. Does there exist a real number $c>0$ and a unique representation basis $A$ such that $A(-x, x) \geq c \sqrt{x}$ for all real numbers $x \geq 1$ ?

In this article, we shall solve the Problems 1 to 5 above.
Theorem 1. There exists a unique representation $A$ such that $A(-x, x) \geq \frac{1}{8} x^{1 / 3}$ for all sufficiently large $x$.

Theorem 1 answers affirmatively Problems 1, 2 and 3 from Nathanson.
Theorem 2. Let $\varepsilon>0$ be an arbitraily small number. Then there is a unique representation basis $A$ such that $A(-x, x) \geq\left(\frac{\sqrt{2}}{2}-\varepsilon\right) \sqrt{x}$ for infinitely many $x$.

Theorem 2 answers affirmatively Problem 4 of Chen.
Theorem 3. Let $A$ be a unique representation basis. Then

$$
\liminf _{x \rightarrow \infty} \frac{A(-x, x)}{\sqrt{x / \log x}} \leq 4 \sqrt{7}
$$

Theorem 3 answers negatively Problem 5 of Chen.
At present, I cannot solve the following problem of Chen [1].
Does there exist a real number $\theta<1 / 2$ such that for any unique representation basis A there are infinitely many positive integers $x$ with $A(-x, x) \leq x^{\theta}$ ?

Now, let $\mathscr{A}$ be set of all unique representation bases $A$ such that there exists some real number $c>0$ so that $A(-x, x)>c x^{1 / 2}$ for infinitely many $x$. For any $A \in \mathscr{A}$, let

$$
c_{A}:=\limsup _{x \rightarrow \infty} \frac{A(-x, x)}{\sqrt{x}} \quad \text { and } \quad c_{\mathscr{A}}:=\sup _{A \in \mathscr{A}} c_{A}
$$

It is clear from Theorem 2 that $\mathscr{A}$ is nonempty and

$$
c_{\mathscr{A}} \geq \frac{\sqrt{2}}{2}
$$

As we mentioned above, Nathanson's result implies that

$$
c_{\mathscr{A}} \leq 2 \sqrt{2}
$$

Thus, it would be of some interests to ask 'what is the exact value of $c_{\mathscr{A}}$ '? It seems safe to guess $c_{\mathscr{A}} \geq 1$.

## 2. Proofs

The idea leading to the solutions of Nathanson's problems benefits from an application of the greedy algorithm together with the inductive process of Chen [1].

Proof of Theorem 1. Firstly, we will construct by inductive process a series of sets

$$
A_{1} \subset A_{2} \subset \cdots \subset A_{i} \subset \cdots
$$

satisfying the following five requirements
I. $r_{A_{h}}(n) \leq 1$ for any $n \in \mathbb{Z}$,
II. $r_{A_{h}}(n)=1$ for any $n \in \mathbb{Z}$ with $|n| \leq h-1$,
III. $\left|a_{h}^{*}\right|<\left|a_{h+1}^{*}\right| \leq 64\left|a_{h}^{*}\right|$,
IV. $A_{h}\left(-\left|a_{h}^{*}\right|,\left|a_{h}^{*}\right|\right) \geq \frac{1}{2}\left(\left|a_{h}^{*}\right|\right)^{1 / 3}$,
V. $0 \notin A_{h}$
for any positive integer $h$, where $a_{h}^{*}$ is the element of $A_{h}$ with maximum absolute value.
Let $A_{1}=\{-1,1\}$ and $x_{1}=1$. Clearly, $A_{1}$ satisfies I, II, IV, V. Assume that we have already constructed the sets $A_{1} \subset A_{2} \subset \cdots \subset A_{h}$ satisfying conditions I to V. Let $m$ be the integer with minimum absolute value so that $r_{A_{h}}(m)=0$. Then by inductive hypothesis II and the definition of $m$ we have

$$
\begin{equation*}
h \leq|m| \leq 2\left|a_{h}^{*}\right|+1 . \tag{1}
\end{equation*}
$$

Take

$$
\begin{equation*}
b=4\left|a_{h}^{*}\right|+|m| \tag{2}
\end{equation*}
$$

and

$$
B=A_{h} \cup\{-b, b+m\} .
$$

Note that $m=(b+m)+(-b) \in B+B$ and the following four sets

$$
2 A_{h}, \quad A_{h}-b, \quad A_{h}+b+m, \quad\{m,-2 b, 2 b+2 m\}
$$

are disjoint, where

$$
A_{h}-b:=\left\{a-b: a \in A_{h}\right\}
$$

and

$$
A_{h}+b+m:=\left\{a+b+m: a \in A_{h}\right\} .
$$

So, we have $r_{B}(n) \leq 1$ for all $n \in \mathbb{Z}, r_{B}(m)=1$ and $0 \notin B$. If $r_{B}(-m)=0$, then take

$$
\begin{equation*}
\widetilde{b}=4 b+5|m| \tag{3}
\end{equation*}
$$

and

$$
\widetilde{B}=B \cup\{-\widetilde{b}, \widetilde{b}-m\} .
$$

It can be seen that $r_{\widetilde{B}}(n) \leq 1$ for all $n \in \mathbb{Z}, r_{\widetilde{B}}(-m)=1$ and $0 \notin \widetilde{B}$ via similar discussions above. Let

$$
D_{h+1}= \begin{cases}B, & \text { if } r_{B}(-m)=1 \\ \widetilde{B}, & \text { otherwise }\end{cases}
$$

Then we know that $\left|a_{h}^{*}\right|<\left|d_{h+1}^{*}\right| \leq 64\left|a_{h}^{*}\right|$ from (1), (2) and (3), where $d_{h}^{*}$ is the element of $D_{h+1}$ with maximum absolute value. Now, we will add a few new elements into $D_{h+1}$ to form $A_{h+1}$, making it satisfied with the dense condition, i.e., inductive hypothesis IV. This can be done via a greedy algorithm which will be put in the next paragraph. If

$$
\begin{equation*}
\left|D_{h+1}\right| \geq \frac{1}{2}\left(\left|d_{h+1}^{*}\right|\right)^{1 / 3} \tag{4}
\end{equation*}
$$

then we stop here and let $A_{h+1}=D_{h+1}$. Clearly, we have

$$
\left|a_{h}^{*}\right|<\left|a_{h+1}^{*}\right|=\left|d_{h+1}^{*}\right| \leq 64\left|a_{h}^{*}\right|
$$

and hence

$$
A_{h+1}\left(-\left|a_{h}^{*}\right|,\left|a_{h}^{*}\right|\right)=\left|D_{h+1}\right| \geq \frac{1}{2}\left(\left|a_{h}^{*}\right|\right)^{1 / 3}
$$

Therefore, the inductive hypotheses I to V are satisfied with this $A_{h+1}$. Now, suppose the contrary of (4), we consider the following set

$$
W_{h+1}:=\left\{d_{1}+d_{2}-d_{3}, \frac{d_{4}+d_{5}}{2}: d_{j} \in D_{h+1}, 1 \leq j \leq 5\right\} .
$$

We add integers $|n| \leq\left|d_{h+1}^{*}\right| / 2$ step by step. First, we choose a nonzero integer $n_{1}$ with minimum absolute value which does not belong to $W_{h+1}$ and add it into $D_{h+1}$ to form a new set $D_{h+1}^{1}$. We claim that $D_{h+1}^{1}$ satisfies $r_{D_{h+1}^{1}}(n) \leq 1$ for any $n \in \mathbb{Z}$. Actually, if $r_{D_{h+1}^{1}}(n) \geq 2$ for some $n$, then we must have

$$
n_{1}+d_{3}=d_{1}+d_{2} \quad \text { or } \quad 2 n_{1}=d_{4}+d_{5}
$$

for some $d_{j} \in D_{h+1}(1 \leq j \leq 5)$ which contradicts the selection of $n_{1}$. Next, we consider the following set

$$
W_{h+1}^{1}:=\left\{d_{1}+d_{2}-d_{3}, \frac{d_{4}+d_{5}}{2}: d_{j} \in D_{h+1}^{1}, 1 \leq j \leq 5\right\} .
$$

Again, we choose a nonzero integer $n_{2}$ with minimum absolute value which does not belong to $W_{h+1}^{1}$ and add it into $D_{h+1}^{1}$ to form a new set $D_{h+1}^{2}$. We continue this process and stop it until the $g$-th step when we have

$$
\left|D_{h+1}^{g}\right| \geq \frac{1}{2}\left(\left|d_{h+1}^{*}\right|\right)^{1 / 3}
$$

This can be done because otherwise

$$
\left|W_{h+1}^{g}\right| \leq\left|D_{h+1}^{g}\right|^{3}+\left|D_{h+1}^{g}\right|^{2} \leq \frac{1}{8}\left|d_{h+1}^{*}\right|+\frac{1}{4}\left|d_{h+1}^{*}\right|^{2 / 3}<\frac{1}{2}\left|d_{h+1}^{*}\right|,
$$

which can be continued again by the process above. Suppose now that the process stops at the $g$-th step, then we take $A_{h+1}=D_{h+1}^{g}$. We still have

$$
\left|a_{h}^{*}\right|<\left|a_{h+1}^{*}\right|=\left|d_{h+1}^{*}\right| \leq 64\left|a_{h}^{*}\right| .
$$

Moreover, we have

$$
\left|A_{h+1}\right|=\left|D_{h+1}^{g}\right| \geq \frac{1}{2}\left(\left|d_{h+1}^{*}\right|\right)^{1 / 3}
$$

It is clear from the constructions above that the new set $A_{h+1}$ satisfies the inductive hypotheses I to V.

Let

$$
A=\bigcup_{h=1}^{\infty} A_{h}
$$

By the inductive hypothesis I and II, we have $r_{A_{h}}(n)=1$ for any $n \in \mathbb{Z}$, which means that $A$ is a unique representation basis for the integers. Let $x$ be a sufficiently large number. Then there exists some $h$ so that

$$
\left|a_{h}^{*}\right| \leq x<\left|a_{h+1}^{*}\right|<64\left|a_{h}^{*}\right|,
$$

from which it follows that

$$
A(-x, x) \geq A_{h}(-x, x) \geq A_{h}\left(-\left|a_{h}^{*}\right|,\left|a_{h}^{*}\right|\right) \geq \frac{1}{2}\left(\left|a_{h}^{*}\right|\right)^{1 / 3} \geq \frac{1}{8} x^{1 / 3}
$$

where the last but one inequality comes from inductive hypothesis IV.

Before presenting the proof of Theorem 2, we introduce an important object from additive combinatorics.

A set

$$
S=\left\{s_{1}<s_{2}<\cdots<s_{t}\right\} \subset\{1,2, \cdots, n\}
$$

is called a Sidon set if all the sums

$$
s_{i}+s_{j}(i \leq j)
$$

are different. Let $F_{2}(n)$ be the largest cardinality of a Sidon set in $\{1,2, \cdots, n\}$. The second lemma is a standard result involving Sidon sets [5, Theorem 7, page 88].

Lemma 1. We have

$$
F_{2}(n)=n^{1 / 2}+O\left(n^{1 / 3}\right) .
$$

The error term in Lemma 1 is not the best known one at present (see e.g. [3]), but the relation $F_{2}(n) \sim n^{1 / 2}$ is actually applicable enough for our purpose.

Proof of Theorem 2. We will firstly construct by inductive process a series of sets

$$
A_{1} \subset A_{2} \subset \cdots \subset A_{i} \subset \cdots
$$

and a series of positive integers

$$
x_{1}<x_{2}<\cdots<x_{i}<\cdots
$$

satisfying the following four constraints
I. $r_{A_{h}}(n) \leq 1$ for any $n \in \mathbb{Z}$,
II. $r_{A_{2 h}}(n)=1$ for any $n \in \mathbb{Z}$ with $|n| \leq h$,
III. $A_{2 h-1}\left(-x_{h}, x_{h}\right) \geq\left(\frac{\sqrt{2}}{2}-\varepsilon\right) \sqrt{x_{h}}$,
IV. $0 \notin A_{h}$
for any positive integer $h$.
Let $A_{1}=\{-1,1\}$ and $x_{1}=1$. Assume that we have already constructed the sets $A_{1} \subset A_{2} \subset \cdots \subset A_{2 h-1}$ and $x_{1}<x_{2}<\cdots<x_{h}$ satisfying conditions I to IV. Let $m$ be the integer with minimum absolute value so that $r_{A_{2 h-1}}(m)=0$. We claim that $|m| \geq h$. In fact, if $h=1$, then $|m|=1=h$. For $h>1$, we have $r_{A_{2 h-2}}(m)=0$ since $A_{2 h-2} \subset A_{2 h-1}$. Then by inductive hypothesis II we have $|m| \geq h$. Similarly to the constructions of $B$ and $\widetilde{B}$ in the proof of Theorem 1, we let

$$
B=A_{2 h-1} \cup\{-b, b+m\} \quad \text { and } \quad \widetilde{B}=B \cup\{-\widetilde{b}, \widetilde{b}-m\}
$$

where $b=4\left|a_{2 h-1}^{*}\right|+|m|$ and $\widetilde{b}=4 b+5|m|$. Next, we let

$$
A_{2 h}= \begin{cases}B, & \text { if } r_{B}(-m)=1 \\ \widetilde{B}, & \text { otherwise }\end{cases}
$$

Then, the set $A_{2 h}$ satisfies inductive hypotheses I, II and IV. It remains to construct a set $A_{2 h+1}$ and an integer $x_{h+1}>x_{h}$ so that $A_{2 h} \subset A_{2 h+1}$ and the hypotheses I, III, IV hold. Improving the former one given by Chen [1, Lemma 2], we shall make use of the full strength of Lemma 1 and we will put it in the next paragraph.

Denote by $a_{2 h}^{*}$ the element of $A_{2 h}$ with maximum absolute value. Now, let $y$ be a (positive) parameter to be decided later. By Lemma 1 there is a set $S \subset[0,(1 / 2-\varepsilon / 2) y)$
with

$$
\begin{equation*}
|S| \geq \sqrt{(1 / 2-\varepsilon / 2) y}+O\left(y^{1 / 3}\right)>\left(\frac{\sqrt{2}}{2}-\frac{\varepsilon}{2}\right) \sqrt{y}+O\left(y^{1 / 3}\right) \tag{5}
\end{equation*}
$$

such that $r_{S}(n) \leq 1$ for all $n \in \mathbb{Z}$, where $\varepsilon$ is a sufficiently small number. Let

$$
\widetilde{S}=S+y / 2:=\{s+y / 2: s \in S\} .
$$

Then $\widetilde{S} \subset[y / 2,(1-\varepsilon / 2) y)$ satisfies $r_{\widetilde{S}}(n) \leq 1$ for all $n \in \mathbb{Z}$ and

$$
\begin{equation*}
|\widetilde{S}|=|S| \geq\left(\frac{\sqrt{2}}{2}-\frac{\varepsilon}{2}\right) \sqrt{y}+O\left(y^{1 / 3}\right) \tag{6}
\end{equation*}
$$

from (5). Noting that

$$
A_{2 h}-A_{2 h} \subset\left[-2\left|a_{2 h}^{*}\right|, 2\left|a_{2 h}^{*}\right|\right],
$$

we know that the number of pairs $s_{1} \neq s_{2} \in \widetilde{S}$ so that

$$
s_{1}-s_{2} \in A_{2 h}-A_{2 h}
$$

is not exceeding $4\left|a_{2 h}^{*}\right|$ since $r_{\widetilde{S}}(n) \leq 1$ for all $n \in \mathbb{Z}$. Now, we remove all such pairs $s_{1}, s_{2}$ from $\widetilde{S}$ to form a new subset $S^{*} \subset[y / 2,(1-\varepsilon / 2) y)$. Clearly, from (6) we have

$$
\begin{equation*}
\left|S^{*}\right| \geq\left(\frac{\sqrt{2}}{2}-\frac{\varepsilon}{2}\right) \sqrt{y}+O\left(y^{1 / 3}\right)-8 a_{2 h}^{*} \geq\left(\frac{\sqrt{2}}{2}-\varepsilon\right) \sqrt{y}, \tag{7}
\end{equation*}
$$

provided that $y$ is sufficiently large (in terms of $\varepsilon$ and $a_{2 h}^{*}$ ). From now on, suppose that $y>x_{h}$ is a sufficiently large given number (in terms of $\varepsilon$ and $a_{2 h}^{*}$ ), then both of the following two equations

$$
a_{1}+a_{2}=s_{1}+s_{2}, \quad\left(a_{1}, a_{2} \in A_{2 h}, s_{1}, s_{2} \in S^{*}\right)
$$

and

$$
a_{1}+a_{2}=a_{3}+s_{1}, \quad\left(a_{1}, a_{2}, a_{3} \in A_{2 h}, s_{1} \in S^{*}\right)
$$

have no solutions. Note further that we have

$$
s_{1}+s_{2}-s_{3} \geq y / 2+y / 2-(1-\varepsilon / 2) y=\varepsilon y / 2>a
$$

for any $s_{1}, s_{2}, s_{3} \in S^{*}$ and any $a \in A_{2 h}$, which clearly means that

$$
s_{1}+s_{2}=s_{3}+a, \quad\left(a \in A_{2 h}, s_{1}, s_{2}, s_{3} \in S^{*}\right)
$$

has no solutions. Now, let

$$
A_{2 h+1}=A_{2 h} \cup S^{*} \quad \text { and } \quad x_{h+1}=y
$$

Then we have $r_{A_{2 h+1}}(n) \leq 1$ for all $n \in \mathbb{Z}$ and $x_{h+1}>x_{h}$ from the discussions above. Moreover, from (7) we have

$$
\frac{A_{2 h+1}\left(-x_{h+1}, x_{h+1}\right)}{\sqrt{x_{h+1}}}>\frac{\left|S^{*}\right|}{\sqrt{y}} \geq \frac{\sqrt{2}}{2}-\varepsilon .
$$

Thus, so far we have finished the constructions of $\left\{A_{h}\right\}$ and $\left\{x_{h}\right\}$.
Let

$$
A=\bigcup_{h=1}^{\infty} A_{h}
$$

By the inductive hypotheses I and II, we have $r_{A_{h}}(n)=1$ for any $n \in \mathbb{Z}$. Hence, $A$ is a unique representation basis for the integers. By inductive hypothesis III, we have

$$
A\left(-x_{h}, x_{h}\right) \geq A_{h}\left(-x_{h}, x_{h}\right) \geq\left(\frac{\sqrt{2}}{2}-\varepsilon\right) \sqrt{x_{h}}
$$

which completes the proof of Theorem 2.
The proof of Theorem 3 is motivated by the idea of Erdős [6], where he communicated to Stöhr the argument for an old claim of Erdős and Turán [2] on infinite Sidon sets.
Proof of Theorem 3. Let $n$ be a sufficiently large integer. For any positive integer $\ell$, let $N_{\ell}\left(\right.$ resp. $\left.M_{\ell}\right)$ be the number of elements of $A$ in the interval

$$
((\ell-1) n, \ell n] \quad(\text { resp. }[-\ell n,(-\ell+1) n)) .
$$

Suppose that $N_{\ell} \geq 2$ and $a, a^{\prime} \in A \cap((\ell-1) n, \ell n]$ with $a<a^{\prime}$, then

$$
0<a^{\prime}-a<n .
$$

Since $A$ is a unique basis, the differences $a^{\prime}-a$ are all different. Thus,

$$
\sum_{1 \leq \ell \leq n, N_{\ell} \geq 2}\binom{N_{\ell}}{2}<n
$$

which means that

$$
\begin{equation*}
\sum_{1 \leq \ell \leq n, N_{\ell} \geq 2} N_{\ell}^{2} \leq 4 \sum_{1 \leq \ell \leq n, N_{\ell} \geq 2}\binom{N_{\ell}}{2}<4 n \tag{8}
\end{equation*}
$$

Moreover, we clearly have

$$
\begin{equation*}
\sum_{1 \leq \ell \leq n, N_{\ell}=1} N_{\ell}^{2}=\sum_{1 \leq \ell \leq n, N_{\ell}=1} 1 \leq n . \tag{9}
\end{equation*}
$$

Hence, from (8) and (9) we get

$$
\begin{equation*}
\sum_{1 \leq \ell \leq n} N_{\ell}^{2}<5 n \tag{10}
\end{equation*}
$$

Similarly to the proof of (10), we have

$$
\begin{equation*}
\sum_{1 \leq \ell \leq n} M_{\ell}^{2}<5 n \tag{11}
\end{equation*}
$$

Now, we make a further observation which would be the main novelty of the proof. For

$$
a \in A \cap((\ell-1) n, \ell n] \quad \text { and } \quad b \in A \cap[-\ell n,(-\ell+1) n),
$$

we have

$$
-n<a+b<n .
$$

Since $A$ is a unique basis, the sums $a+b$ are all different. So we obtain

$$
\begin{equation*}
N_{\ell} M_{\ell}<2 n \tag{12}
\end{equation*}
$$

Collecting together (10), (11) and (12), we get

$$
\begin{equation*}
\sum_{1 \leq \ell \leq n}\left(N_{\ell}+M_{\ell}\right)^{2}<14 n \tag{13}
\end{equation*}
$$

It is clear that

$$
\begin{equation*}
\left(\sum_{1 \leq \ell \leq n} \frac{N_{\ell}+M_{\ell}}{\ell^{1 / 2}}\right)^{2} \leq\left(\sum_{1 \leq \ell \leq n} \frac{1}{\ell}\right)\left(\sum_{1 \leq \ell \leq n}\left(N_{\ell}+M_{\ell}\right)^{2}\right)<(1+\log n) 14 n \tag{14}
\end{equation*}
$$

from the Cauchy-Schwarz inequality. By partial summations, we have

$$
\begin{align*}
\sum_{1 \leq \ell \leq n} \frac{N_{\ell}+M_{\ell}}{\ell^{1 / 2}} & =\sum_{1 \leq \ell \leq n}(A(-\ell n, \ell n)-A(-(\ell-1) n,(\ell-1) n)) \frac{1}{\ell^{1 / 2}} \\
& =\sum_{1 \leq \ell \leq n} A(-\ell n, \ell n)\left(\frac{1}{\ell^{1 / 2}}-\frac{1}{(\ell+1)^{1 / 2}}\right)+\frac{A\left(-n^{2}, n^{2}\right)}{(n+1)^{1 / 2}} \\
& \geq \min _{1 \leq \ell \leq n} \frac{A(-\ell n, \ell n)}{\sqrt{\ell n / \log (\ell n)}} \sum_{1 \leq \ell \leq n} \sqrt{\frac{\ell n}{\log (\ell n)}}\left(\frac{1}{\ell^{1 / 2}}-\frac{1}{(\ell+1)^{1 / 2}}\right) \\
& >\min _{1 \leq \ell \leq n} \frac{A(-\ell n, \ell n)}{\sqrt{\ell n / \log (\ell n)}} \sqrt{\frac{n}{2 \log n}} \sum_{1 \leq \ell \leq n} \frac{1}{2(\ell+1)}, \tag{15}
\end{align*}
$$

where we used the estimates

$$
\sqrt{\ell}\left(\frac{1}{\ell^{1 / 2}}-\frac{1}{(\ell+1)^{1 / 2}}\right)=\frac{\sqrt{\ell+1}-\sqrt{\ell}}{\sqrt{\ell+1}}=\frac{1}{\sqrt{\ell+1}(\sqrt{\ell+1}+\sqrt{\ell})}>\frac{1}{2(\ell+1)}
$$

in the last inequality. Inserting (15) into (14), we clearly have

$$
\begin{equation*}
\min _{1 \leq \ell \leq n} \frac{A(-\ell n, \ell n)}{\sqrt{\ell n / \log (\ell n)}}<\frac{4 \sqrt{7} \sqrt{(1+\log n) \log n}}{\sum_{1 \leq \ell \leq n} \frac{1}{\ell+1}}<4 \sqrt{7}+\delta \tag{16}
\end{equation*}
$$

for any $\delta>0$ providing that $n>n_{\delta}$, from which our theorem clearly follows.
