# DECOMPOSITION OF HIGHER DELIGNE-LUSZTIG REPRESENTATIONS

#### Abstract

A higher Deligne-Lusztig representation is a virtual smooth representation of a parahoric subgroup in a $p$-adic group, which is constructed from the Deligne-Lusztig induction. In this note, under a mild condition on $p$ we provide a decomposition of higher Deligne-Lusztig representations, attached to an unramified elliptic maximal torus, into irreducible representations obtained in a similar way as those used in Yu's construction of supercuspidal representations of $p$-adic groups. As a consequence, we show that all the unramified supercuspidal representations are direct summands of inductions of higher Deligne-Lusztig representations.


## 1. Introduction

Let $k$ be a non-archimedean local field with a finite residue field $\mathbb{F}_{q}$ of characteristic $p$. Denote by $\breve{k}$ the completion of a maximal unramified extension of $k$. Let $F$ be the Frobenius automorphism of $\breve{k}$ over $k$.

Let $G$ be a reductive group over $k$, and $T$ a maximal torus over $k$ splitting over $\breve{k}$. Fix a point x in the apartment of $T$. For any closed subgroup $H \subseteq G$ and $r \in \mathbb{R}_{\geqslant 0}$ we can define the $r$ th jet group $H_{r}:=H_{x, r}$, which is a smooth affine group over $\overline{\mathbb{F}}_{q}$.

Let $B=T U$ be a Borel subgroup over $\breve{k}$ with $U$ the unipotent radical. Following [13] and [2], we can define the parahoric Deligne-Lusztig variety

$$
X_{U, r}=\left\{g \in G_{r} ; g^{-1} F(g) \in U_{r}\right\} .
$$

The $F$-fixed point group $G_{r}^{F} \times T_{r}^{F}$ acts by left/right multiplication, and hence acts on the $\ell$-adic cohomology $H_{c}^{*}\left(X_{U, r}, \overline{\mathbb{Q}}_{\ell}\right)$ with $\ell \neq p$. Thus, given a character $\phi: T^{F} \rightarrow \overline{\mathbb{Q}}_{\ell}^{\times}$of depth $r \geqslant 0$, the corresponding isotropic subspace

$$
R_{T, U, r}^{G}(\phi)=\sum_{i}(-1)^{i} H_{c}^{i}\left(X_{U, r}, \overline{\mathbb{Q}}_{\ell}\right)[\phi],
$$

gives a virtual representation of $G_{r}^{F}$, which is referred to a higher DeligneLusztig representation.

If $r=0, R_{T, U, r}^{G}(\phi)$ is the usual Deligne-Lusztig representation for the finite reductive group $G_{r}^{F}$ constructed in [7. In [12] Lusztig initiated the study of $R_{T, U, r}^{G}(\phi)$ for arbitrary $r$, and expected that their inductions would give rise to supercuspidal representations of the $p$-adic group $G^{F}$. This expectation
and its application in local Langlands correspondence have recently been established in [4] and 3] for toral characters $\phi$. A key ingredient of these works is the the inner product formula for higher Deligne-Lusztig representations. If $\phi$ is generic, this formula is proved in [13], [16] and [2]. If $T$ is of Coxeter type, it is proved by [8] and [10] when $q$ is not too small. Recently, under a mild assumption on $p$, Chan [1] proved that it holds for all $R_{T, U, r}^{G}(\phi)$ attached to split-generic pairs $(T, \phi)$, including the most interesting case that $T$ is elliptic.

On the other hand, there is an purely algebraic construction of tame suprecuspical representations due to Yu [18]. In the process, it produces a family of irreducible representations of $G_{r}^{F}$ in a non-cohomological way. It is a natural question to compare the higher Deligne-Lusztig representations and Yu's representations. When $\phi$ is toral and in general position, Chan and Oi established an explicit identification between these two kinds of representations. When $G_{X}$ is hyperspecial and $\phi$ is generic, a similar comparison result is also obtained by Chen and Stasinski in [5] and 6.

In this paper, we give an explicit decomposition of higher Deligne-Lusztig representations attached to elliptic tori into irreducible ones of Yu's type, under a mild assumption on $p$.

Theorem 1.1. Assume that $p$ is not a bad prime for $G$ and does not divide $\left|\pi_{1}\left(G_{\text {der }}\right)\right|$. Suppose $T$ is elliptic. Then there is an irreducible decomposition of $G_{r}^{F}$-modules

$$
\left|R_{T, U, r}^{G}(\phi)\right|=\bigoplus_{\rho} \operatorname{ind}_{K_{\phi, r}^{F}}^{G_{r}^{F}} \kappa(\phi)_{U} \otimes \rho
$$

where $\rho$ ranges over irreducible summands (with multiplicities) of some classical Deligne-Lusztig representation attached to $\phi$.

We refer to Theorem 6.4 for the precise statement. When $\left|R_{T, U, r}^{G}(\phi)\right|$ is irreducible, similar results were obtained by Chen-Stasinski [5] [6] and Chan-Oi 4], under certain conditions on $\phi$. Note that the group $K_{\phi}^{F}$ and the irreducible $K_{\phi}^{F}$-modules

$$
\operatorname{ind}_{K_{\phi, r}^{F}}^{G_{r}^{F}} \kappa(\phi)_{U} \otimes \rho
$$

are constructed in the same spirit of Yu [18]. The only different is that the Weil representation $\kappa(\phi)_{\text {Weil }}$ used in Yu's construction is replaced by a representation $\kappa(\phi)_{U}$ arising from geometry.

To prove the main result, we employ a strategy inspired by Chen-Stasinski [6] and the work 9 in progress. The key is to introduce a new variety (following Yu's construction)

$$
Z_{\phi, U, r} \subseteq G_{r}
$$

which also admits a natural action by $G_{r}^{F} \times T_{r}^{F}$. Then using the DeligneLusztig induction, one obtains another (virtual) $G_{r}^{F}$-module

$$
\mathcal{R}_{T, U, r}^{G}(\phi)=\sum_{i}(-1)^{i} H_{c}^{i}\left(Z_{\phi, U, r}, \overline{\mathbb{Q}}_{\ell}\right)[\phi] .
$$

Compared with $X_{U, r}$, the variety $Z_{\phi, U, r}$ has simpler structure and it follows that $\left|\mathcal{R}_{T, U, r}^{G}(\phi)\right|$ is a geometric realization of right hand side of Theorem 1.1. Thus, it remains to show $\mathcal{R}_{T, U, r}^{G}(\phi)=R_{T, U, r}^{G}(\phi)$, that is,

$$
\left\langle R_{T, U, r}^{G}(\phi), R_{T, U, r}^{G}(\phi)\right\rangle_{G_{r}^{F}}=\left\langle\mathcal{R}_{T, U, r}^{G}(\phi), R_{T, U, r}^{G}(\phi)\right\rangle_{G_{r}^{F}}=\left\langle\mathcal{R}_{T, U, r}^{G}(\phi), \mathcal{R}_{T, U, r}^{G}(\phi)\right\rangle_{G_{r}^{F}} .
$$

The first inner product is obtained in [1]. We compute the last two based on the Howe factorization of $\phi$, which exists under our assumption on $p$. It turns out that all the three inner products are the same. Hence the main result follows.

Let $Z$ be the center of $G$. We can extend $R_{T, U, r}^{G}(\phi)$ to a $Z^{F} G_{\mathrm{x}}^{F}$-module, on which $Z^{F}$ acts via $\phi$. Then we have the following consequence.

Corollary 1.2. Let $p$ be as in Theorem 1.1. Then any supercuspical representation of $G^{F}$ attached to an elliptic unramified torus $T$ is a direct summand of

$$
\operatorname{ind}_{Z^{F}}^{G_{G_{\mathbf{x}}^{F}}^{F}} R_{T, U, r}^{G}(\phi)
$$

for some character $\phi$ of depth $r$.
The paper is organized as follows. In $\$ 2$ we recall the inner product formula and the degeneracy property of higher Deligne-Lusztig representations due to Chan [1], which will play an essential role in our computation. In $\$ 3$, we introduce the variety $Z_{\phi, U, r}$ and the associated representation $\mathcal{R}_{T, U, r}^{G}(\phi)$. In 雨, we compute the inner product between $\mathcal{R}_{T, U, r}^{G}(\phi)$ and $R_{T, U, r}^{G}(\phi)$. This is achieved by extending methods from [13], [5] and [5]. In \$5, we compute the self inner product of $\mathcal{R}_{T, U, r}^{G}(\phi)$, which completes the proof of the equality $\mathcal{R}_{T, U, r}^{G}(\phi)=R_{T, U, r}^{G}(\phi)$. In $\S \sqrt[6]{6}$ we decompose $\mathcal{R}_{T, U, r}^{G}(\phi)$ in to irreducible representations of Yu's type and finishes the proof of Theorem 1.1. In the last section, we prove the Corollary 1.2,

## 2. The representations $R_{T, U, r}^{G}(\phi)$

Let $k, \breve{k}, F, \mathbb{F}_{q}, p$ and $G$ be as in $\mathbb{1} \mathbb{1}$ In the rest of the paper, we assume that $p$ is not a bad prime for $G$ and does not divide $\left|\pi_{1}\left(G_{\text {der }}\right)\right|$.

Let $T$ be an elliptic maximal torus over $k$ which splits over $\breve{k}$. We choose a point x in the apartment of $T$. We denote by $G_{\mathrm{X}}$ the parahoric subgroup
of $G(\breve{k})$. For $r \in \mathbb{R}_{\geqslant 0}$ let $G_{x}^{r}$ be the $r$ th Moy-Prasad subgroup of $G_{X}$, and denote by

$$
G_{r}=G_{X, r}=G_{X} / G_{X}^{r+}
$$

the quotient group with $G_{\mathrm{x}}^{r+}=\cup_{s>r} G_{\mathrm{X}}^{s}$. Note that $G_{r}$ is a smooth affine group over $\mathbb{F}$. For any closed subgroup $H \subseteq G$, we identity $H$ with $H(\breve{k})$ and set

$$
H_{r}=H_{\mathrm{X}, r}=\left(H \cap G_{\mathrm{X}}\right) /\left(H \cap G_{\mathrm{x}}^{r+}\right) .
$$

We will write $H_{r}=H_{r}^{s}$ if $s=0$. Note that $G_{0}=G_{x, 0}$ is the reductive quotient of the parahoric subgroup $G_{\mathrm{X}}$.

Let $B=T U \subseteq G$ be a Borel subgroup with $U$ the unipotent radical. The associated higher/parahoric Deligne-Lusztig variety for $r \geqslant 0$ is

$$
X_{U, r}=X_{U, r}^{G}=\left\{g \in G_{r} ; g^{-1} F(g) \in F U_{r}\right\}
$$

which admits a natural action of $G_{r}^{F} \times T_{r}^{F}$ given by $(g, t): x \mapsto g x t$.
Let $\phi: T^{F} \rightarrow \overline{\mathbb{Q}}_{\ell}^{\times}$be a smooth character of depth $r_{\phi} \leqslant r$. The attached higher Deligne-Lusztig representation is

$$
R_{T, U, r}^{G}(\phi)=\sum_{i}(-1)^{i} H_{c}^{i}\left(X_{U, r}, \overline{\mathbb{Q}}_{\ell}\right)[\phi],
$$

where $H_{c}^{i}\left(X_{U, r}, \overline{\mathbb{Q}}_{\ell}\right)[\phi]$ denote the $\phi$-isotropic subspace of $H_{c}^{i}\left(X_{U, r}, \overline{\mathbb{Q}}_{\ell}\right)$. Note that $R_{T, U, r}^{G}(\phi)$ is a virtual representation of $G_{r}^{F}$.
$W_{G_{r}}\left(T_{r}\right)=N_{r} / T_{r}$ be the Weyl group, where $N$ denotes the normalizer of $T$ in $G$. The following results will play a key role in the paper.

Theorem 2.1. [1, Theorem 6.2] Let notation be as above. Then we have

$$
\left\langle R_{T, U, r}^{G}(\phi), R_{T, U, r}^{G}(\phi)\right\rangle_{G_{r}^{F}}=\sharp\left\{w \in W_{G_{r}}\left(T_{r}\right)^{F} ; \phi={ }^{w} \phi\right\} .
$$

Moreover, $R_{T, U, r}^{G}(\phi)$ is independent of the choice of $B=T U$.
We will write $R_{T, r}^{G}(\phi)=R_{T, V, r}^{G}(\phi)$ for any Borel subgroup of the form $T V$ with $V$ the unipotent radical.

Theorem 2.2. [1, Theorem 5.2] Let notation be as above. For each $i \in \mathbb{Z}$ there is a natural isomorphism of $G_{r}^{F} \times T_{r}^{F}$-modules

$$
H_{c}^{i}\left(X_{U, r}, \overline{\mathbb{Q}}_{\ell}\right)[\phi] \cong H_{c}^{i+m}\left(X_{U, r_{\phi}}, \overline{\mathbb{Q}}_{\ell}\right)[\phi]
$$

for some integer $m$ depending on $r_{\phi} \leqslant r$.
In particular, there is a natural isomorphism $R_{T, U, r}^{G}(\phi) \cong R_{T, U, r_{\phi}}^{G}(\phi)$ of $G_{r}^{F}$-modules.

## 3. The representations $\mathcal{R}_{T, U, r}^{G}(\phi)$

In this section, we introduce the main objects $Z_{\phi, U, r}$ and $\mathcal{R}_{T, U, r}^{G}(\phi)$, and discuss some basic properties.

Let $B=T U \subseteq G$ be as in 82 Let $\bar{B}=T \bar{U}$ be the opposite Borel subgroup to $B$ with $\bar{U}$ its unipotent radical. We denote by $\Phi(G, T)$ the root system of
$T$ in $G$. For $\alpha \in \Phi(G, T)$ let $G^{\alpha}$ be the corresponding root subgroup, and let $T^{\alpha} \subseteq T$ be the (one-dimensional) maximal torus of the subgroup generated by $G^{\alpha}$ and $G^{-\alpha}$.

Let $M \supseteq T$ be a Levi subgroup of $G$. Let $\theta$ be a character of $M^{F}$ of depth $r_{\theta} \geqslant 0$. We say $\theta$ is $(M, G)$-generic if for any $\alpha \in \Phi(G, T) \backslash \Phi(M, T)$ and $n \in \mathbb{Z}_{\geqslant 1}$ such that $F^{n}\left(T^{\alpha}\right)=T^{\alpha}$, the restriction of $\theta \circ N_{F}^{F^{n}}$ to $\left(\left(T^{\alpha}\right)_{r_{\theta}}^{r_{\theta}}\right)^{F^{n}}$ is nontrivial. Here $N_{F}^{F^{n}}: T \rightarrow T$ is give by $t \mapsto t F(t) \cdots F^{n-1}(t)$. By [11, Lemma 3.6.8], this definition of genericity coincides with the one given in [18, §9], under our global assumption on $p$ given in \$2

Let $\phi$ be a character of $T^{F}$ of depth $r_{\phi} \geqslant 0$. A Howe factorization of $\phi$ is a triple of sequences $\left(G^{i}, \phi_{i}, r_{i}\right)_{-1 \leqslant i \leqslant d_{\phi}}$ such that

- $T=G^{-1} \subseteq G^{0} \subsetneq G^{1} \subsetneq G^{d-1} \subsetneq G^{d}=G$ are Levi subgroups with $d=d_{\phi}$;
- $\phi_{i}$ is a character of $\left(G^{i}\right)^{F}$ of depth $r_{i}$ for $0 \leqslant i \leqslant d-1$;
- $\phi=\left.\prod_{i=-1}^{d} \phi_{i}\right|_{T^{F}}$;
- $\phi_{i}$ is $\left(G^{i}, G^{i+1}\right)$-generic for $0 \leqslant i \leqslant d-1$;
- $0=r_{-1}<r_{0}<\cdots<r_{d-1} \leqslant r_{d}=r_{\phi}$;
- $\phi_{d}=1$ if $r_{d-1}=r_{d}$ and has depth $r_{d}$ otherwise;
- $\phi_{-1}=1$ if $G^{0}=T$ and has depth 0 otherwise.

In this case, we consider the following $F$-stable subgroups

$$
\begin{aligned}
& K_{\phi}=\left(G^{0}\right)_{X}\left(G^{1}\right)_{x}^{r_{0} / 2} \cdots\left(G^{d}\right)_{X}^{r_{d-1} / 2} ; \\
& H_{\phi}=\left(G^{0}\right)_{\mathrm{x}}^{0+}\left(G^{1}\right)_{\mathrm{x}}^{r_{0} / 2} \cdots\left(G^{d}\right)_{\mathrm{x}}^{r_{d-1} / 2} \text {; } \\
& K_{\phi}^{+}=\left(G^{0}\right)_{x}^{0+}\left(G^{1}\right)_{x}^{r_{0} / 2+} \cdots\left(G^{d}\right)_{x}^{r_{d-1} / 2+} ; \\
& E_{\phi}=\left(G_{\text {der }}^{0}\right)_{\mathrm{x}}^{0+, 0+}\left(G_{\text {der }}^{1}\right)_{\mathrm{X}}^{r_{0}+, r_{0} / 2+} \ldots\left(G_{\text {der }}^{d}\right)^{r_{d-1}+, r_{d-1} / 2+} .
\end{aligned}
$$

Here $\left(G_{\mathrm{der}}^{i}\right)_{X}^{r_{i-1}+, r_{i-1} / 2+} \subseteq G_{X}$ is the subgroup generated by $\left(G_{\mathrm{der}}^{i}\right)_{\mathrm{X}}^{r_{i-1}+}$ and $\left(G^{\alpha}\right)_{x}^{r_{i-1} / 2+}$ for $\alpha \in \Phi_{i} \backslash \Phi_{i-1}$. Here $\Phi_{i}=\Phi\left(G^{i}, T\right)$ is the root system of $G^{i}$.

Lemma 3.1. The subgroups $\left[K_{\phi}, K_{\phi}^{+}\right] \subseteq E_{\phi} \subseteq K_{\phi}^{+}$are normalized by $K_{\phi}$.
Proof. It follows directly by definition.
Recall that $\bar{B}=T \bar{U}$ is the opposite of $B=T U$. Consider the following subgroup

$$
\mathcal{I}_{\phi, U}=\left(K_{\phi} \cap U\right)\left(E_{\phi} \cap T\right)\left(K_{\phi}^{+} \cap \bar{U}\right) \subseteq K_{\phi}
$$

Let $r \geqslant r_{\phi}$. We denote by $K_{\phi, r}$ the image of $K_{\phi}$ under the quotient map $G_{X} \rightarrow G_{r}$. We can define $H_{\phi, r}, E_{\phi, r}, K_{\phi, r}^{+}$and $\mathcal{I}_{\phi, U, r}$ in a similar way. Now we define

$$
Z_{\phi, U, r}=Z_{\phi, U, r}^{G}=\left\{g \in G_{r} ; g^{-1} F(g) \in F \mathcal{I}_{\phi, U, r}\right\},
$$

which admits a natural action of $G_{r}^{F} \times T_{r}^{F}$ by left/right multiplication. We denote by

$$
\mathcal{R}_{T, U, r}^{G}(\phi)=\sum_{i}(-1)^{i} H_{c}^{i}\left(Z_{\phi, U, r}, \overline{\mathbb{Q}}_{\ell}\right)[\phi]
$$

the virtual representation of $G_{r}^{F}$.
Proposition 3.2. There is a natural isomorphism $\mathcal{R}_{T, U, r}^{G}(\phi) \cong \mathcal{R}_{T, U, r_{\phi}}^{G}(\phi)$ of $G_{r}^{F}$-modules .

Proof. We can assume that $r>s \geqslant r_{\phi}$ with $r=s+$. Let $\pi_{r}: Z_{\phi, U, r} \rightarrow Z_{\phi, U, s}$ be the natural projection. Let $x \in Z_{\phi, U, s}$. It suffices to show

$$
H_{c}^{i}\left(\pi_{r}^{-1}(x), \overline{\mathbb{Q}}_{\ell}\right)^{\left(T_{r}^{r}\right)^{F}}= \begin{cases}\overline{\mathbb{Q}}_{\ell}, & \text { if } i=2 \operatorname{dim} G_{\mathrm{der}} \\ 0, & \text { otherwise }\end{cases}
$$

Since $r>r_{\phi}$, we have $\left(G_{\text {der }}\right)_{r}^{r} \subseteq \mathcal{I}_{\phi, U, r}$. Hence

$$
\pi_{r}^{-1}(x) \cong\left\{y \in G_{r}^{r} ; y^{-1} F(y) \in\left(G_{\mathrm{der}}\right)_{r}^{r}\right\}=\left(T_{r}^{r}\right)^{F}\left(G_{\mathrm{der}}\right)_{r}^{r}
$$

from which the statement follows directly.
Lemma 3.3. We have $Z_{\phi, U, r} \cong \bigsqcup_{\tau \in T_{r}^{F} /\left(T \cap G_{\text {der }}\right)_{r}^{F}}\left(Z_{\phi, U, r} \cap\left(G_{\text {der }}\right)_{r}\right) \tau$.
Proof. It follows from the inclusion $\mathcal{I}_{\phi, U, r} \subseteq\left(G_{\text {der }}\right)_{r}$ and natural isomor$\operatorname{phism} G_{r}^{F} /\left(G_{\text {der }}\right)_{r}^{F} \cong T_{r}^{F} /\left(T \cap G_{\text {der }}\right)_{r}^{F}$.

Proposition 3.4. For any character $\theta$ of $G^{F}$ there is a natural isomorphism of $G_{r}^{F}$-modules $\mathcal{R}_{T, U, r}^{G}(\phi) \otimes \theta=\mathcal{R}_{T, U, r}^{G}\left(\left.\phi \otimes \theta\right|_{T^{F}}\right)$.

Proof. It follows similarly as [1, Proposition 3.7] by using Lemma 3.3.
Note that $K_{\phi}^{+}=E_{\phi} T_{\mathrm{x}}^{0+}$ and hence $\left(K_{\phi}^{+}\right)^{F}=E_{\phi}^{F}\left(T_{\mathrm{x}}^{0+}\right)^{F}$. As $\phi$ is trivial over $E_{\phi}^{F} \cap T^{F}$, it inflates to a character of $\left(K_{\phi}^{+}\right)^{F}$ which is trivial on $E_{\phi}^{F}$. We denote this character by $\phi^{\natural}$.

Proposition 3.5. We have $\left(Z_{\phi, U, r} \cap K_{\phi, r}\right) E_{\phi, r}=Z_{\phi, r} \cap K_{\phi, r}$, and for each $i \in \mathbb{Z}$ the quotient map $Z_{\phi, U, r} \cap K_{\phi, r} \rightarrow\left(Z_{\phi, U, r} \cap K_{\phi, r}\right) / E_{\phi, r}$ induces an isomorphism of $G_{r}^{F}$-modules

$$
H_{c}^{i+\operatorname{dim} E_{\phi, r}\left(Z_{\phi, r}, \overline{\mathbb{Q}}_{\ell}\right)[\phi] \cong H_{c}^{i}\left(Z_{\phi, r} / E_{\phi, r}, \overline{\mathbb{Q}}_{\ell}\right)[\phi] . . . . . .}
$$

In particular, $\left(K_{\phi, r}^{+}\right)^{F}$ acts on $H_{c}^{i}\left(Z_{\phi, U, r} \cap K_{\phi, r}, \overline{\mathbb{Q}}_{\ell}\right)[\phi]$ via the character $\phi^{\natural}$.
Proof. The first statement follows by definition. The second follows from that $E_{\phi, r}$ is isomorphic to an affine spaces. The last one follows from that $E_{\phi, r}$ is normalized by $K_{\phi, r}$ and that $\left[K_{\phi, r}, K_{\phi, r}^{+}\right] \subseteq E_{\phi, r}$.

## 4. A INNER PRODUCT FORMULA

We keep notations in §3, Let $S$ be another maximal torus over $k$ which is conjugate to $T$ by $G_{X}$. We fix two smooth characters $\phi$ and $\psi$ of $T^{F}$ and $S^{F}$ respectively. Let $\left(G^{i}, \phi_{i}, r_{i}\right)_{-1 \leqslant i \leqslant d_{\phi}}$ and $\left(M^{i}, \psi_{i}, s_{i}\right)_{-1 \leqslant i \leqslant d_{\psi}}$ be Howe factorizations of $\phi$ and $\psi$ respectively. Fix $r \geqslant \max \left\{r_{\phi}, r_{\psi}\right\}$.

Let $(U, \bar{U})$ and $(V, \bar{V})$ be two pairs of opposite maximal unipotent subgroups of $G$, which are normalized by $T$ and $S$ respectively. Moreover, we assume that $\left(M^{i}\right)_{-1 \leqslant i \leqslant d}$ is standard for $V$, that is, for each $-1 \leqslant i \leqslant d_{\psi}$, $M^{i}$ and $V$ generate a parabolic subgroup $P^{i}=M^{i} N^{i}$ of $G$, where $M^{i}$ is the Levi part and $N^{i} \subseteq V$ is the unipotent radical.

Let $N_{G_{r}}\left(T_{r}, S_{r}\right)=\left\{x \in G_{r} ; x^{-1} T x=S\right\}$ and $W_{G_{r}}\left(T_{r}, S_{r}\right)=N_{G_{r}}\left(T_{r}, S_{r}\right) / S_{r}$.
4.1. Set $M=M^{d_{\psi}-1}$ and $N=N^{d_{\psi}-1}$. Let $\bar{N}$ be the opposite of $N$. Note that

Consider the variety

\Sigma=\Sigma_{\phi, \psi}^{G}=\left\{\left(x, x^{\prime}, y\right) \in F \mathcal{I}_{\phi, U, r} \times F V_{r} \times G_{r} ; x F(y)=y x^{\prime}\right\}
$$

There is a decomposition

\Sigma=\bigsqcup_{w \in W_{G_{r}}\left(T_{r}, S_{r}\right) M_{r} / M_{r}} \Sigma_{w}
$$

where $\Sigma_{w}=\left\{\left(x, x^{\prime}, y\right) \in \Sigma ; y \in G_{w, r}\right\}$.
We define
$\hat{\Sigma}_{w}=\left\{\left(x, x^{\prime}, z, m, n\right) \in F \mathcal{I}_{\phi, U, r} \times F V_{r} \times \mathcal{Z}_{w, r} \times M_{r} \times N_{r} ; x F(z \dot{w} m n)=z \dot{w} m n x^{\prime}\right\}$.
By the substitution $x^{\prime} F(n) \mapsto x^{\prime}$ we can write $\hat{\Sigma}_{w}$ as
$\hat{\Sigma}_{w}=\left\{\left(x, x^{\prime}, z, m, n\right) \in F \mathcal{I}_{\phi, U, r} \times F V_{r} \times \mathcal{Z}_{w, r} \times M_{r} \times N_{r} ; x F(z \dot{w} m)=z \dot{w} m n x^{\prime}\right\}$.
There is partition $\hat{\Sigma}_{w}=\hat{\Sigma}_{w}^{\prime} \sqcup \hat{\Sigma}_{w}^{\prime \prime}$ of locally closed subsets, where

$$
\begin{aligned}
& \hat{\Sigma}_{w}^{\prime}=\left\{\left(x, x^{\prime}, z, m, n\right) \in \hat{\Sigma}_{w} ; z \in \mathcal{Z}_{w, r} \backslash \mathcal{I}_{\phi, U, r}\right\} \\
& \hat{\Sigma}_{w}^{\prime \prime}=\left\{\left(x, x^{\prime}, z, m, n\right) \in \hat{\Sigma}_{w} ; z \in \mathcal{I}_{\phi, U, r}\right\}
\end{aligned}
$$

Note that $T_{r}^{F} \times S_{r}^{F}$ acts on $\hat{\Sigma}_{w}$ by

(t, s):\left(x, x^{\prime}, z, m, n\right) \longmapsto\left(t x t^{-1}, s x^{\prime} s^{-1}, t z t^{-1}, w^{-1}(t) m s^{-1}, s n s^{-1}\right)
$$

We denote by $\hat{H}_{c}^{*}\left(\hat{\Sigma}_{w}, \overline{\mathbb{Q}}_{\ell}\right)_{\phi, \psi^{-1}}=\sum_{i}(-1)^{i} H_{c}^{i}\left(\hat{\Sigma}_{w}, \overline{\mathbb{Q}}_{\ell}\right)_{\phi, \psi^{-1}}$ the corresponding isotropic subspace.

Lemma 4.1. We have $H_{c}^{*}\left(\hat{\Sigma}_{w}^{\prime \prime}, \overline{\mathbb{Q}}_{\ell}\right)_{\phi, \psi^{-1}} \neq 0$ only if $w^{-1} F(w) \in W_{M_{r}}\left(T_{r}\right)$. In this case,

$$
\operatorname{dim} H_{c}^{*}\left(\hat{\Sigma}_{w}^{\prime \prime}, \overline{\mathbb{Q}}_{\ell}\right)_{\psi^{-1}, \phi}=\left\langle\mathcal{R}_{T^{\dot{w}}, U^{\dot{w}} \cap M, r}^{M}\left(\phi^{\dot{w}}\right), R_{S, V \cap M}^{M}(\psi)\right\rangle_{M_{r}^{F}}
$$

where $\dot{w} \in G_{r}^{F}$ is a lift of $w, T^{\dot{w}}=\dot{w}^{-1} T \dot{w}, U^{\dot{w}}=\dot{w}^{-1} U \dot{w}$ and $\phi^{\dot{w}}$ is the natural pull-back of $\phi$ to $\left(T^{\dot{w}}\right)^{F}$.

Proof. By the substitution $x F(z) \mapsto x$ we can write $\hat{\Sigma}_{w}^{\prime \prime}$ as
$\hat{\Sigma}_{w}^{\prime \prime}=\left\{\left(x, x^{\prime}, z, m, n\right) \in F \mathcal{I}_{\phi, U, r} \times F V_{r} \times \mathcal{Z}_{w, r} \times M_{r} \times N_{r} ; x F(\dot{w} m)=z \dot{w} m n x^{\prime}\right\}$.
Consider the algebraic group

D_{w}=\left\{(t, s) \in T_{r, \text { red }} \times S_{r, \text { red }} ; \dot{w}^{-1} t^{-1} F(t) \dot{w}=s^{-1} F(s) \in Z(M)^{\circ}\right\}
$$

where $Z(M)$ is the center of $M$, and $T_{r, \text { red }}, S_{r, \text { red }}$ are the reductive subgroups of $T_{r}$ and $S_{r}$ respectively. The action of $D_{w}$ on $\hat{\Sigma}_{w}^{\prime \prime}$ is given by

Since the actions of $D_{w}$ and $T_{r}^{F} \times S_{r}^{F}$ on $\hat{\Sigma}_{w}^{\prime \prime}$ commute with each other, we have

As $F$ preserves $Z(M)^{\circ}$, the image of the natural projection $D_{w}^{\circ} \rightarrow S_{r, \text { red }}$ is $Z(M)_{r, \text { red }}^{\circ}$. It follows that

& =\left\langle\mathcal{R}_{T^{w}, U^{w} \cap M, r}^{M}\left(\phi^{\dot{w}}\right), R_{T, V \cap M, r}^{M}(\psi)\right\rangle_{M_{r}^{F}} .
\end{aligned}
$$

The proof is finished.

### 4.2. Let $\Phi=\Phi(G, T)$ and $\Psi=\Phi(G, S)$. Let $\Psi_{\bar{N}} \subseteq \Psi$ be the set of roots

 appearing in $\bar{N}$. Let $\Phi^{+}$be the set of (positive) roots appearing in $U$. Let $\preceq$ be the natural partial order on $\Phi$ induced from $\Phi^{+}$.Let $z \in{ }^{\dot{w}} \bar{N}_{r}=\prod_{\gamma \in \dot{w} \Psi_{\bar{N}}}\left(G^{\gamma}\right)_{r}$. We define $x_{\gamma}^{z} \in\left(G^{\gamma}\right)_{r}$ such that $z=$ $\prod_{\gamma \in \Psi_{N}} x_{\gamma}^{z}$. There is a decomposition

$$
\mathcal{Z}_{w, r} \backslash \mathcal{I}_{\phi, U, r}=\bigsqcup_{I \subseteq \dot{w} \Psi_{\bar{N}}, v \in \mathbb{R}_{\geqslant 0}^{I}}\left(\mathcal{Z}_{w, r} \cap \mathcal{I}_{\phi, U, r}\right) \cdot \mathcal{K}_{r}^{I, v},
$$

where $\mathcal{K}_{r}^{I, v}$ consists of elements $y \in \mathcal{Z}_{w, r} \cap \prod_{\gamma \in I}\left(G^{\gamma}\right)_{r}$ such that $x_{\gamma}^{y} \in$ $\left(G^{\gamma}\right)_{r}^{v(\gamma), *} \backslash \mathcal{I}_{\phi, U, r}$ for $\gamma \in I$. Here $\left(G^{\gamma}\right)^{s, *}=\left(G^{\gamma}\right)_{r}^{s} \backslash\left(G^{\gamma}\right)^{s+}$ for $0 \leqslant s \leqslant r$.

Recall that $\Phi_{i}=\Phi\left(G^{i}, T\right)$ for $0 \leqslant i \leqslant d_{\phi}$. Let $\alpha \in \Phi$. We denote by $i(\alpha)=i_{\phi}(\alpha)$ be the integer $0 \leqslant i \leqslant d_{\phi}$ such that $\alpha \in \Phi_{i} \backslash \Phi_{i-1}$. Define $r(\alpha)=r_{\phi}(\alpha)=r_{i_{\phi}(\alpha)-1}$.

Let $I \subseteq{ }^{\dot{w}} \Psi \bar{N}$ and $v \in \mathbb{R}_{\geqslant 0}^{I}$. Set $\delta(I, v)=\max \{r(\gamma)-v(\gamma) ; \alpha \in I\}$ and

$$
c(I, v)=\{\gamma \in I ; r(\gamma)-v(\gamma)=\delta(I, v)\}
$$

Lemma 4.2. Let $I, v$ be as above. Let $\alpha \in \min _{\preceq} c(I, v)$. Let $y \in \mathcal{K}_{r}^{I, v}$ and let $\zeta \in\left(G^{-\alpha}\right)_{r}^{r(\alpha)-v(\alpha)}$. Then there exist $\omega_{y, \zeta} \in \mathcal{I}_{\phi, U, r}$, and $\tau_{\zeta, y} \in\left(T^{\alpha}\right)_{r}^{r(\alpha)}$ such that

$$
y \zeta=\omega_{\zeta, y} \tau_{\zeta, y} y
$$

Moreover, the map $\zeta \mapsto \tau_{\zeta, y}$ induces an isomorphism of algebraic groups $\lambda_{y}:\left(G^{-\alpha}\right)_{r}^{r(\alpha)-v(\alpha)} /\left(G^{-\alpha}\right)_{r}^{(r(\alpha)-v(\alpha))+} \xrightarrow{\sim}\left(T^{\alpha}\right)_{r}^{r(\alpha)} /\left(T^{\alpha}\right)_{r}^{r(\alpha)+}$.

Proof. For $\gamma \in \Phi$ and $s \in \mathbb{R}_{\geqslant 0}$ we have
(a) $\left(G^{\gamma}\right)_{r}^{s} \subseteq \mathcal{I}_{\phi, U, r}$ if and only if either $\gamma \in \Phi^{+}$and $s \geqslant r(\gamma) / 2$ or $\gamma \in$ $\Phi^{-}:=-\Phi^{+}$and $s>r(\gamma) / 2$.

By definition we also have
(a') $\gamma \in \Phi^{+}$if $v(\gamma)=0$.
By the choice of $(I, v)$, we have $\left(G^{\gamma}\right)_{r}^{v(\gamma), *} \cap \mathcal{I}_{\phi, U, r}=\emptyset$ for $\gamma \in I$. It follows from (a) that $\left(G^{-\gamma}\right)_{r}^{r(\gamma)-v(\gamma)} \subseteq \mathcal{I}_{\phi, U, r}$ for $\gamma \in I$. In particular, we have
(b) $\zeta \in\left(G^{-\alpha}\right)_{r}^{r(\alpha)-v(\alpha)} \subseteq \mathcal{I}_{\phi, U, r}$.

Note that $y \zeta y^{-1}$ is a product of elements $x_{\beta, m}$, where for each pair $(\beta, m) \in \Phi \times \mathbb{R}_{>0}$ there exist an integer $n \in \mathbb{Z}_{\geqslant 1}$ and roots $\gamma_{i} \in I$ for $1 \leqslant i \leqslant e$ with $e \in \mathbb{Z}_{\geqslant 0}$ such that

- $i\left(\gamma_{1}\right) \geqslant i\left(\gamma_{2}\right) \geqslant \cdots \geqslant i\left(\gamma_{1}\right)$;
- $m=n(r(\alpha)-v(\alpha))+\sum_{i=1}^{e} v\left(\gamma_{i}\right)$;
- either (i) $\beta=-n \alpha+\sum_{i=1}^{e} \gamma_{i} \in \Phi$ and $x_{\beta, m} \in\left(G^{\beta}\right)_{r}^{m, *}$ or (ii) $-n \alpha+$ $\sum_{i=1}^{e} \gamma_{i}=0$ and $x_{\beta, m} \in\left(T^{\beta}\right)_{r}^{m, *}$, where $\beta=-n_{1} \alpha+\gamma_{i_{1}}+\cdots+\gamma_{i_{j}} \in \Phi$ for some $0 \leqslant n_{1} \leqslant n, 0 \leqslant j \leqslant e$ and $0<i_{1}<\cdots<i_{j} \leqslant e$.
To show the first statement, it suffices to show $x_{\beta, m} \in \mathcal{I}_{\phi, U, r}$ unless $n=1$, $e=1$ and $\gamma_{1}=\alpha$. Indeed, suppose that $x_{\beta, m} \notin \mathcal{I}_{\phi, U, r}$. Note that
(c) $v(\gamma)>0$ if $i(\alpha)<i(\gamma)$ for $\gamma \in I$.

By the choice of $\alpha$ we have $r(\gamma)-v(\gamma) \leqslant r(\alpha)-v(\alpha)$ and hence (c) is proved.

First we claim that
(d) $i\left(\gamma_{1}\right) \leqslant i(\alpha)$ and hence $\beta \in \Phi_{i(\alpha)}$.

Assume that $i\left(\gamma_{1}\right)>i(\alpha)$. Then $\beta \in \Phi_{i\left(\gamma_{1}\right)}$ and

m=n(r(\alpha)-v(\alpha))+\sum_{i=1}^{e} v\left(\gamma_{i}\right) \geqslant r\left(\gamma_{1}\right)-v\left(\gamma_{1}\right)+v\left(\gamma_{1}\right)=r\left(\gamma_{1}\right) .
$$

As $x_{\beta, m} \notin \mathcal{I}_{\phi, U, r}$, we have $-n \alpha+\sum_{i=1}^{e} \gamma_{i}=0$ and $m=r\left(\gamma_{1}\right)$, which implies that $e \geqslant 2$ and $i\left(\gamma_{2}\right)=i\left(\gamma_{1}\right)>i(\alpha)$. By (c) we have $m>s\left(\gamma_{1}\right)$, a contradiction. So (d) is proved.

Second we claim that
(e) $n=1$.

Assume $n \geqslant 2$. By (b) and (a) we have $m \geqslant 2(r(\alpha)-v(\alpha)) \geqslant r(\gamma)$. As $x_{\beta, m} \notin \mathcal{I}_{\phi, U, r}$, we have $m=2$ and $-n \alpha+\sum_{i=1}^{e} \gamma_{i}=0$, that is, $n=2$, $r(\alpha)-v(\alpha)=r(\alpha) / 2$ and $v\left(\gamma_{i}\right)=0$ for $1 \leqslant i \leqslant e$. By (a), (b) and (a') this implies that $-\alpha, \gamma_{i} \in \Phi^{+}$, contradicting that $-n \alpha+\sum_{i=1}^{e} \gamma_{i}=0$. So (e) is proved.

Third we claim that
(f) $i\left(\gamma_{1}\right)=i(\alpha)$.

Otherwise, by (d) we have $i\left(\gamma_{i}\right)<i(\alpha)$ for $1 \leqslant i \leqslant e$. Hence $-n \alpha+$ $\sum_{i=1}^{e} \gamma_{i} \in \Phi_{i(\alpha)}$ and $x_{\beta, m} \in\left(G^{\beta}\right)_{r}^{m}$. By (b), (a) and (a') we have $x_{\beta, m} \in$ $\mathcal{I}_{\phi, U, r}$, a contradiction. So (f) is proved.

By (f) we have $m \geqslant(r(\alpha)-v(\alpha))+v\left(\gamma_{1}\right) \geqslant r\left(\gamma_{1}\right)=r(\alpha)$. Again, since $\beta \in \Phi_{i(\alpha)}$ and $x_{\beta, m} \notin \mathcal{I}_{\phi, U, r}$, we have $m=s(\alpha)$ and $-n \alpha+\sum_{i=1}^{e} \gamma_{i}=0$. This implies that $\gamma_{1} \in c(I, v)$, and moreover, $v\left(\gamma_{i}\right)=0$ and hence $\gamma_{i} \in \Phi^{+}$ for $2 \leqslant i \leqslant e$. Note we have

\alpha-\gamma_{1}=\sum_{i=2}^{e} \gamma_{i} \in \mathbb{Z}_{\geqslant 0} \Phi^{+}
$$

As $\alpha \in \min _{\preceq} c(I, v)$, it follows that $\gamma_{1}=\alpha$ and $e=1$. So the first statement is proved. The second one follows by direct computation.
Lemma 4.3. We have $H_{c}^{*}\left(\hat{\Sigma}_{w}^{\prime}, \overline{\mathbb{Q}}_{\ell}\right)_{\phi, \psi^{-1}}=0$.
Proof. We have a decomposition

\hat{\Sigma}_{w}^{\prime}=\bigsqcup_{I \subseteq \dot{w} \Phi \bar{N}, v \in \mathbb{R}_{\geqslant 0}^{I}} \hat{\Sigma}_{w}^{I, v}
$$

where $\hat{\Sigma}_{w}^{I, v}$ consists of $\left(x, x^{\prime}, z, m, n\right) \in \hat{\Sigma}_{w}^{\prime}$ with $z \in\left(\mathcal{Z}_{w, r} \cap \mathcal{I}_{\phi, U, r}\right) \cdot \mathcal{K}_{r}^{I, v}$.
It suffices to show $H_{c}^{*}\left(\hat{\Sigma}_{w}^{I, v}, \overline{\mathbb{Q}}_{\ell}\right)_{\phi, \psi^{-1}}=0$. Write $z=z_{1} y$ such that $z_{1} \in$ $\mathcal{I}_{\phi, U, r} \cap \mathcal{Z}_{w, r}$ and $y \in \mathcal{K}_{r}^{I, v}$. Then by the substitution $x F\left(z_{1}\right) \mapsto x$, the set $\hat{\Sigma}_{w}^{v, I}$ consists of elements $\left(x, x^{\prime}, z_{1}, y, m, n\right)$ such that

$$
x F(y \dot{w} m)=z_{1} y \dot{w} m n x^{\prime} .
$$

Then action of $T_{r}^{F} \cong T_{r}^{F} \times\{1\} \subseteq T_{r}^{F} \times S_{r}^{F}$ on $\hat{\Sigma}_{w}^{I, v}$ is given by

s:\left(x, x^{\prime}, z_{1}, y, m, n\right) \longmapsto\left(t x t^{-1}, x^{\prime}, t z_{1} t^{-1}, t y t^{-1}, w^{-1}(t) m, n\right)
$$

It suffices to show the $\phi$-isotropic subspace $H_{c}^{*}\left(\hat{\Sigma}_{w}^{I, v}, \overline{\mathbb{Q}}_{\ell}\right)_{\phi}$ for $T_{r}^{F}$ is trivial. Let $\alpha \in \min _{\preceq} c(I, v)$. By Lemma 4.2, for $y \in \mathcal{K}_{r}^{I, v}$ and $\zeta \in\left(G^{-\alpha}\right)_{r}^{r(\alpha)-v(\alpha)}$, there exist $\tau_{\zeta, y} \in\left(T^{\alpha}\right)_{r}^{r(\alpha)}$ and $\omega_{\zeta, y} \in \mathcal{I}_{\phi, U, r}$ such that

Let $\vartheta_{1}$ be a section of $\theta_{1}$ such that $\theta_{1} \circ \vartheta_{1}=\mathrm{id}$ and $\vartheta_{1}(1)=1$.

Let

\mathcal{H}=\left\{t \in T_{r}^{r(\alpha)} ; t^{-1} F^{-1}(t) \in\left(T^{\alpha}\right)_{r}^{r(\alpha)}\right\} .
$$

For $t \in \mathcal{H}$ we define $f_{t}: \hat{\Sigma}_{w}^{I, v} \rightarrow \hat{\Sigma}_{w}^{I, v}$ by

f_{t}\left(x, x^{\prime}, z_{1}, y, m, n\right)=\left(x_{t}, x^{\prime} F\left(\zeta^{\dot{w} m}\right), t z_{1} t^{-1}, t y t^{-1}, \dot{w}^{-1}(t) m, n\right),

where $\zeta^{\dot{u} m}=m^{-1} \dot{w}^{-1} \zeta \dot{w} m, \zeta=\vartheta_{1} \lambda_{y}^{-1} \theta_{2}\left(t F^{-1}(t)^{-1}\right) \in\left(G^{-\alpha}\right)_{r}^{r(\alpha)-v(\alpha)}, \lambda_{y}$ is as in Lemma 4.2, and $x_{s} \in F \mathcal{I}_{\phi, U, r}$ is determined by the equality

x_{t} F(t y \dot{w} m)=t z_{1} y \dot{w} m n x^{\prime} F\left(\zeta^{\dot{w} m}\right)
$$

Note that $\dot{w}^{-1} \zeta \dot{w} \in N_{r}$ and hence $f_{t}$ is well defined.
Now we see that the induced map of $f_{t}$ on each $H_{c}^{i}\left(\hat{\Sigma}_{w}^{I, v}, \overline{\mathbb{Q}}_{\ell}\right)$ is trivial for $t \in N_{F}^{F^{n}}\left(\left(\left(T^{\alpha}\right)_{r}^{r(\alpha)}\right)^{F^{n}}\right) \subseteq \mathcal{H}^{\circ}$, where $n \in \mathbb{Z} \geqslant 1$ such that $F^{n}\left(T^{\alpha}\right)=T^{\alpha}$. On the other hand, by definition we have $i(\alpha) \geqslant 1$ and

$$
\left.\phi\right|_{N_{F}^{F^{n}}\left(\left(\left(T^{\alpha}\right)_{r}^{r(\alpha)}\right)_{F^{N}}\right)}=\left.\phi_{i(\alpha)-1}\right|_{N_{F}^{F^{n}}}\left(\left(\left(T^{\alpha}\right)_{r}^{r(\alpha)}\right)_{F^{n}}\right),
$$

which is nontrivial since $\phi_{i(\alpha)-1}$ is $\left(G_{i(\alpha)-1}, G_{i(\alpha)}\right)$-generic. Thus it follows that $H_{c}^{*}\left(\hat{\Sigma}_{w}^{I, v}, \overline{\mathbb{Q}}_{\ell}\right)_{\phi}=0$ as desired.
4.3. Now we are ready to show the main results of this section.

Theorem 4.4. Let notation be as above. Then

$$
\left\langle\mathcal{R}_{T, U, r}^{G}(\phi), R_{S, V, r}^{G}(\psi)\right\rangle_{G_{r}^{F}}=\sharp\left\{w \in W_{G_{r}}\left(T_{r}, S_{r}\right)^{F} ; \phi^{w}=\psi\right\} .
$$

Proof. By [1, Proposition 3.7] and Proposition [3.4, by replacing $\phi$ and $\psi$ with $\left.\psi_{s_{\psi}}^{-1}\right|_{T^{F}} \otimes \phi$ and $\left.\psi_{s_{\psi}}^{-1}\right|_{S^{F}} \otimes \psi$ respectively, we can assume further that $\psi$ has depth $s_{d_{\psi}-1}$. By Proposition 3.5, $\mathcal{R}_{T, U, r}^{G}(\psi)$ is a linear combination of irreducible $G_{r}^{F}$-modules on which $\left(G_{r}^{r_{\phi}}\right)^{F}$ acts via nontrivial characters.

We use induction on $d_{\psi}$ and the semisimple rank of $G$. If $G=T$, the statement is trivial. If $d_{\psi}=0$, then $\psi$ has depth 0 and by Theorem [2.2,

$$
R_{S, V, r}^{G}(\psi) \cong R_{S, V, 0}^{G}(\psi)
$$

In particular, $R_{S, V, r}^{G}(\psi)$ is a linear combination of irreducible $G_{r}^{F}$-modules on which $\left(G_{r}^{0+}\right)^{F}$ acts trivially. Therefore, if $r_{\phi}>0$, by Proposition 3.2 we have

$$
\left\langle\mathcal{R}_{T, U, r}^{G}(\phi), R_{S, V, r}^{G}(\psi)\right\rangle_{G_{r}^{F}}=0=\sharp\left\{w \in W_{G_{r}}\left(T_{r}, S_{r}\right)^{F} ; \phi^{w}=\psi\right\} .
$$

Assume $r_{\phi}=0$. Then it follows from Proposition 3.2 that

$$
\mathcal{R}_{T, U, r}^{G}(\phi)=R_{T, U, 0}^{G}(\phi),
$$

and the statement follows from [7, Theorem 6.8].

Now assume that $d_{\psi} \geqslant 1$. Let $M=M^{d_{\psi}-1}$. By Lemma 4.1 and Lemma 4.3 we have

$$
\begin{aligned}
& \left\langle\mathcal{R}_{T, U, r}^{G}(\phi), R_{S, V, r}^{G}(\psi)\right\rangle_{G_{r}^{F}} \\
= & \sum_{w \in\left(N_{G_{r}}\left(T_{r}, S_{r}\right) M_{r} / M_{r}\right)^{F}}\left\langle\mathcal{R}_{T^{\dot{w}}, U^{\dot{w}} \cap M, r}^{M}\left(\phi^{\dot{w}}\right), R_{S, V \cap M, r}^{M}(\psi)\right\rangle_{M_{r}^{F}} \\
= & \sum_{w \in\left(N_{G_{r}}\left(T_{r}, S_{r}\right) M_{r} / M_{r}\right)^{F}} \sharp\left\{u \in W_{M_{r}}\left(T_{r}^{\dot{w}}, S_{r}\right)^{F} ; \phi^{\dot{w} \dot{u}}=\psi\right\} \\
= & \sharp\left\{w \in W_{G_{r}}\left(T_{r}, S_{r}\right)^{F} ; \phi^{w}=\psi\right\},
\end{aligned}
$$

where the second equality follows by induction hypothesis for $M$. The proof is finished.

## 5. Coincidence of the two representations

Let $T, \phi,\left(G^{i}, \phi_{i}, r_{i}\right)_{-1 \leqslant i \leqslant d_{\phi}}$ and $(U, \bar{U})$ be as in $\S 4$. Let $r \geqslant r_{\phi}$ and let $K_{\phi, r}, H_{\phi, r}, K_{\phi, r}^{+}$and $E_{\phi, r}$ be defined in \{3, We set $L=G^{0}$.

Let $0 \leqslant i \leqslant d_{\phi}-1$. Since $\phi_{i}$ is $\left(G^{i}, G^{i+1}\right)$-generic in the sense of [18, §9], the stabilizer of $\left.\phi_{i}\right|_{\left(T_{r}^{r_{i}}\right)^{F}}$ in $W_{\left(G^{i+1}\right)_{r}}\left(T_{r}\right)^{F}$ is precisely $W_{\left(G^{i}\right)_{r}}\left(T_{r}\right)^{F}$.

Lemma 5.1. We have

$$
\operatorname{Stab}_{W_{G_{r}}\left(T_{r}\right)^{F}}(\phi)=\operatorname{Stab}_{W_{L_{r}}\left(T_{r}\right)}(\phi)=\operatorname{Stab}_{W_{L_{r}}\left(T_{r}\right)^{F}}\left(\phi_{-1}\right) .
$$

Proof. Let $w \in \operatorname{Stab}_{W_{G_{r}}\left(T_{r}\right)^{F}}(\phi)$ which stabilizes $\phi$. Suppose that $w \in$ $W_{\left(G^{i+1}\right)_{r}}\left(T_{r}\right)^{F}$ for some $0 \leqslant i \leqslant d-1$. Let $\dot{w} \in\left(G^{i+1}\right)_{r}^{F}$ be a lift of $w$. Let $t \in\left(T_{r}^{r_{i}}\right)^{F}$. Then $\phi_{j}\left(t^{-1} \dot{w} t \dot{w}^{-1}\right)=1$ for $-1 \leqslant j \leqslant i-1$. On the other hand, as $t^{-1} d w t \dot{w}^{-1} \in\left(G_{\text {der }}^{i+1}\right)^{F}$, we have $\phi_{j}\left(t^{-1} \dot{w} t \dot{w}^{-1}\right)=1$ for $i+1 \leqslant j \leqslant d_{\phi}$. Hence we also have $\phi_{i}\left(t^{-1} \dot{w} t \dot{w}^{-1}\right)=1$. As $\phi$ is generic, it follows by definition that $w \in W_{\left(G^{i}\right)_{r}}\left(T_{r}\right)^{F}$. Therefore, we deduce that $w \in \operatorname{Stab}_{W_{\left(G^{0}\right)_{r}}\left(T_{r}\right)^{F}}(\phi)=\operatorname{Stab}_{W_{L_{r}}\left(T_{r}\right)^{F}}(\phi)$.

Now we can assume $\dot{w} \in L^{F}$. As $t^{-1} \dot{w} t \dot{w}^{-1} \in\left(L_{\text {der }}\right)^{F}$ for $t \in T^{F}$, $\phi_{i}\left(t^{-1} \dot{w} t \dot{w}^{-1}\right)=1$ for $0 \leqslant i \leqslant d_{\phi}$. Thus $\operatorname{Stab}_{W_{L_{r}}\left(T_{r}\right)}(\phi)=\operatorname{Stab}_{W_{L_{r}}\left(T_{r}\right)^{F}}\left(\phi_{-1}\right)$ as desired.

We set $Z_{\phi, U, r}^{K}=Z_{\phi, U, r} \cap K_{\phi, r}$ and $Z_{\phi, U, r}^{H}=Z_{\phi, U, r} \cap H_{\phi, r}$.
Lemma 5.2. Let $\rho, \rho^{\prime}$ be two irreducible summands of $H_{c}^{*}\left(Z_{\phi, U, r}^{K}, \overline{\mathbb{Q}}_{\ell}\right)[\phi]$. Let $g \in G_{r}^{F}$ such that

$$
\operatorname{hom}_{K_{\phi, r}^{F} \cap g K_{\phi, r}^{F}}\left(\left.g\right|_{K_{\phi, r}^{F} \cap g K_{\phi, r}^{F}},\left.\rho^{\prime}\right|_{K_{\phi, r}^{F} \cap g K_{\phi, r}^{F}}\right) \neq\{0\} .
$$

Then $g \in K_{\phi, r}^{F}$. Here ${ }^{g} \rho(x)=\rho\left(g^{-1} x g\right)$.
Proof. By Lemma 3.5, $\left.\rho\right|_{\left(K_{\phi, r}^{+}\right)^{F}},\left.\rho^{\prime}\right|_{\left(K_{\phi, r}\right)^{F}}$ are direct sums of one-dimensional representations $\phi^{\natural}$. In particular, $g$ intertwines $\phi^{\natural}$. Note that $\phi^{\natural}=\left.\prod_{i=0}^{d_{\phi}} \hat{\phi}_{i}\right|_{K_{\phi}^{F}}$,
where each $\hat{\phi}_{i}$ is the character associated to $\phi_{i}$ defined in [18, §4]. Then the statement follows as in the first part of the proof of [14, Theorem 3.1], by noticing that $\phi_{i}$ is $\left(G^{i}, G^{i+1}\right)$-generic for $0 \leqslant i \leqslant d-1$.

Lemma 5.3. We have

$$
\left\langle\mathcal{R}_{T, U, r}^{G}(\phi), \mathcal{R}_{T, U, r}^{G}(\phi)\right\rangle_{G_{r}^{F}}=\left\langle H_{c}^{*}\left(Z_{\phi, U, r}^{K}, \overline{\mathbb{Q}}_{\ell}\right)[\phi], H_{c}^{*}\left(Z_{\phi, U, r}^{K}, \overline{\mathbb{Q}}_{\ell}\right)[\phi]\right\rangle_{K_{\phi, r}^{F}} .
$$

Here $H_{c}^{*}\left(Z, \overline{\mathbb{Q}}_{\ell}\right)=\sum_{i}(-1)^{i} H_{c}^{i}\left(Z, \overline{\mathbb{Q}}_{\ell}\right)$ for any variety $Z$.
Proof. As $Z_{\phi, U, r}=\sqcup_{g \in G_{r}^{F} / K_{\phi, r}^{F}} g Z_{\phi, U, r}^{K}$, we have

$$
\mathcal{R}_{T, U, r}^{G}(\phi)=\operatorname{ind}_{K_{\phi, r}^{F}}^{G_{c}^{F}} H_{c}^{*}\left(Z_{\phi, U, r}^{K}, \overline{\mathbb{Q}}_{\ell}\right)[\phi] .
$$

Then the statement follows from Lemma 5.2,
5.1. Let $\bar{K}=K_{\phi, r} / E_{\phi, r}, \bar{H}=H_{\phi, r} / E_{\phi, r}$ and $\bar{L}=L_{r} /\left(L_{r} \cap E_{\phi, r}\right)$. Then we have

$$
\bar{K}=\bar{H} \bar{L}=\bar{L} \bar{H}=\bar{H}_{U} \bar{L} \bar{H}_{\bar{U}}
$$

whee $\bar{H}_{U}=\left(H_{\phi, r} \cap U_{r}\right) /\left(E_{\phi, r} \cap U_{r}\right)$ and $\bar{H}_{\bar{U}}$ is defined similarly.
Note that

$$
\bar{H}_{U} \cong \bigoplus_{\alpha \in \Phi^{+}} L_{\alpha}, \quad \bar{H}_{\bar{U}} \cong \bigoplus_{\alpha \in \Phi^{-}} L_{\alpha}
$$

where $L_{\alpha}=\left(G^{\alpha}\right)_{r}^{r(\alpha) / 2} /\left(G^{\alpha}\right)_{r}^{r(\alpha) / 2+}$ for $\alpha \in \Phi$. Moreover, $\left[L_{\alpha}, L_{\beta}\right]=0$ if $\alpha \neq-\beta$ and $\left[L_{\alpha}, L_{\beta}\right]=\left(T^{\alpha}\right)_{r}^{r(\alpha)} \subseteq \bar{L}$ otherwise.

We set

$$
\bar{Z}^{K}=Z_{\phi, U, r}^{K} / E_{\phi, r}=\left\{g \in \bar{K}, g^{-1} F(g) \in \bar{K}_{U}\right\}
$$

where $\bar{K}_{U}=\left(K_{\phi, r} \cap U_{r}\right) /\left(E_{\phi, r} \cap U_{r}\right)$. Consider the following variety

$$
\begin{aligned}
\bar{\Sigma}_{K} & =\left\{\left(x, x^{\prime}, y\right) \in F \bar{K}_{U} \times F \bar{K}_{U} \times \bar{K} ; x F(y)=y x^{\prime}\right\} \\
& \cong\left\{\left(x, x^{\prime}, u, v, \tau\right) \in F \bar{K}_{U} \times F \bar{K}_{U} \times \bar{H}_{U} \times \bar{H}_{\bar{U}} \times \bar{L} ; x F(v \tau)=u v \tau x^{\prime}\right\} .
\end{aligned}
$$

Then $\left\langle H_{c}^{*}\left(Z_{\phi, U, r}^{K}, \overline{\mathbb{Q}}_{\ell}\right)[\phi], H_{c}^{*}\left(Z_{\phi, U, r}^{K}, \overline{\mathbb{Q}}_{\ell}\right)[\phi]\right\rangle_{K_{\phi, r}^{F}}=\operatorname{dim} H_{c}^{*}\left(\bar{\Sigma}_{K}, \overline{\mathbb{Q}}_{\ell}\right)_{\phi, \phi^{-1}}$.
Proposition 5.4. We have

$$
\operatorname{dim} H_{c}^{*}\left(\bar{\Sigma}_{K}, \overline{\mathbb{Q}}_{\ell}\right)_{\phi, \phi^{-1}}=\sharp\left\{w \in W_{L_{r}}\left(T_{r}\right)^{F} ; \phi^{w}=\phi\right\} .
$$

In particular, $\left\langle\mathcal{R}_{T, U, r}^{G}(\phi), \mathcal{R}_{T, U, r}^{G}(\phi)\right\rangle_{G_{r}^{F}}=\sharp\left\{w \in W_{L_{r}}\left(T_{r}\right)^{F} ; \phi^{w}=\phi\right\}$.
Proof. There is a decomposition $\bar{\Sigma}_{K}=\bar{\Sigma}_{K}^{\prime} \sqcup \bar{\Sigma}_{K}^{\prime \prime}$, where $\Sigma_{K}^{\prime \prime}$ is defined by the condition $v=0$.

Note that the commutative group

$$
D=\left\{\left(t, t^{\prime}\right) \in T_{r} \times T_{r} ; t^{-1} F(t)=t^{\prime-1} F\left(t^{\prime}\right) \in Z(L)^{\circ}\right\}
$$

acts on $\bar{\Sigma}^{\prime \prime}$ in the usual way. Moreover,

$$
\left(\bar{\Sigma}_{K}^{\prime \prime}\right)^{D_{\mathrm{red}}^{\circ}} \cong\left\{\left(x^{\prime}, x^{\prime}, y\right) \in F \bar{L}_{U} \times F \bar{L}_{U} \times \bar{L} ; x F(y)=y x^{\prime}\right\}
$$

Hence we have

$$
\begin{aligned}
\operatorname{dim}\left(\bar{\Sigma}_{K}^{\prime \prime}, \overline{\mathbb{Q}}_{\ell}\right)_{\phi, \phi^{-1}} & =\operatorname{dim}\left(\left(\bar{\Sigma}_{K}^{\prime \prime}\right)^{D_{\mathrm{red}}^{\circ}}, \overline{\mathbb{Q}}_{\ell}\right)_{\phi, \phi^{-1}}=\left\langle R_{T, L \cap U, r}(\phi), R_{T, L \cap U, r}(\phi)\right\rangle_{L_{r}^{F}} \\
& =\sharp\left\{w \in W_{L_{r}}\left(T_{r}\right)^{F} ; \phi^{w}=\phi\right\} .
\end{aligned}
$$

It remains to show $H_{c}^{*}\left(\bar{\Sigma}_{K}^{\prime}, \overline{\mathbb{Q}}_{\ell}\right)_{\phi, \phi^{-1}}=0$. Note that the action of $\left(T_{r}^{0+}\right)^{F} \cong$ $\left(T_{r}^{0+}\right)^{F} \times\{1\} \subseteq\left(T_{r}^{0+}\right)^{F} \times\left(T_{r}^{0+}\right)^{F}$ on $\bar{\Sigma}_{K}^{\prime}$ is given by

$$
t:\left(x, x^{\prime}, u, v, \tau\right) \longmapsto\left(t x t^{-1}, x^{\prime}, t u t^{-1}, t v t^{-1}, t \tau\right)
$$

Let $H_{c}^{i}\left(\bar{\Sigma}_{K}^{\prime}, \overline{\mathbb{Q}}_{\ell}\right)_{\phi}$ be the subspace on which $\left(T_{r}^{0+}\right)^{F}$ acts via $\phi$. It suffices to show $H_{c}^{i}\left(\bar{\Sigma}_{K}^{\prime}, \overline{\mathbb{Q}}_{\ell}\right)_{\phi}=0$. For $v \in \bar{H}_{\bar{U}}$ and $\alpha \in \Phi^{-}$let $v_{\alpha} \in L_{\alpha}$ be such that $v=\sum_{\alpha \in \Phi^{-}} v_{\alpha}$. We fix a total order $\preceq$ on $\Phi^{-}$. Then there is a decomposition

$$
\bar{H}_{\bar{U}}=\bigsqcup_{\alpha \in \Phi^{-}} \bar{H}_{\bar{U}}^{\alpha},
$$

where $\bar{H} \frac{\alpha}{\bar{U}}$ is defined by the condition that $v_{\alpha} \neq 0$ and $v_{\beta}=0$ for $\beta \prec$ $\alpha$. This induces a decomposition $\bar{\Sigma}_{K}^{\prime}=\sqcup_{\alpha \in \Phi^{-}} \bar{\Sigma}_{K}^{\alpha}$, and it suffices to show $H_{c}^{*}\left(\bar{\Sigma}_{K}^{\alpha}, \overline{\mathbb{Q}}_{\ell}\right)_{\phi}=0$ for $\alpha \in \Phi^{-}$.

Fix $\alpha \in \Phi^{-}$. Let $v \in \bar{H}_{\bar{U}}^{\alpha}$ and $\xi \in L_{-\alpha} \subseteq \bar{H}_{U}$. Then $v \xi=\tau_{v, \xi} \xi v$, where $\tau_{v, \xi} \in\left(T^{\alpha}\right)_{r}^{r(\alpha)} /\left(T^{\alpha}\right)_{r}^{r(\alpha)+} \subseteq \bar{L}$. Moreover, the map $\xi \mapsto \tau_{v, \xi}$ induces an isomorphism $L_{-\alpha} \cong\left(T^{\alpha}\right)_{r}^{r(\alpha)} /\left(T^{\alpha}\right)_{r}^{r(\alpha)+}$. Then using a similar argument as in Lemma 4.3, we deduce that $H_{c}^{*}\left(\bar{\Sigma}_{K}^{\alpha}, \overline{\mathbb{Q}}_{\ell}\right)_{\phi}=0$ as desired.

The second statement follows from Lemma 5.3, and the proof is finished.

Theorem 5.5. We have $R_{T, r}^{G}(\phi)=R_{T, U, r}^{G}(\phi) \mathcal{R}_{T, U, r}^{G}(\phi)$.
Proof. By Theorem 4.4, Lemma 5.1 and Proposition 5.4, we have

$$
\left\langle R_{T, r}^{G}(\phi)-\mathcal{R}_{T, U, r}^{G}(\phi), R_{T, r}^{G}(\phi)-\mathcal{R}_{T, U, r}^{G}(\phi)\right\rangle_{G_{r}^{F}}=0 .
$$

So the statements follows.

## 6. A DECOMPOSITION

Let notation be as in $\$ 5$ Moreover, we assume that $\left(G^{i}\right)_{-1 \leqslant i \leqslant d_{\phi}}$ is standard for $U$. In this section we give a more precise description of $R_{T, r}^{G}(\phi)=$ $\mathcal{R}_{T, U, r}^{G}(\phi)$.

Let $\phi^{\natural}$ be the character of $\left(K_{\phi}^{+}\right)^{F}$ defined in \$3. Denote by $N_{\phi}$ the kernel of $\phi^{\natural}$. The following lemma is proved in [17, Proposition 18.1].

Proposition 6.1. The quotient $H_{\phi, r}^{F} / N_{\phi}$ is a Heisenberg p-group whose center is $\left(K_{\phi, r}^{+}\right)^{F} / N_{\phi}$.

Let $\phi^{+}$be the restriction of $\phi$ to $\left(T_{r}^{0+}\right)^{F}$.

Proposition 6.2. The genuine $H_{\phi, r}^{F}$-module

$$
\pm H_{c}^{*}\left(Z_{\phi, U, r}^{H}, \overline{\mathbb{Q}}_{\ell}\right)\left[\phi^{+}\right]
$$

is the inflation of the unique irreducible representation $\kappa(\phi)$ of the Heisenberg p-group $H_{\phi, r}^{F} / N_{\phi}$ with the nontrivial central character $\left.\phi^{\natural}\right|_{\left(K_{\phi, r}^{+}\right)^{F} / N_{\phi}}$.

Proof. By a similar but simpler argument in Proposition 5.4, we have

$$
\left\langle H_{c}^{*}\left(\bar{Z}_{\phi, U, r}^{H}, \overline{\mathbb{Q}}_{\ell}\right)\left[\phi^{+}\right], H_{c}^{*}\left(\bar{Z}_{\phi, U, r}^{H}, \overline{\mathbb{Q}}_{\ell}\right)\left[\phi^{+}\right]\right\rangle_{H_{\phi, r}^{F}}=1
$$

Hence $\pm H_{c}^{*}\left(\bar{Z}_{\phi, U, r}^{H}, \overline{\mathbb{Q}}_{\ell}\right)\left[\phi^{+}\right]$is an irreducible $H_{\phi, r}^{F}$-module. By Lemma 3.5, $\left(K_{\phi, r}^{+}\right)^{F}$ acts on $H_{c}^{*}\left(\bar{Z}_{\phi, U, r}^{H}, \overline{\mathbb{Q}}_{\ell}\right)\left[\phi^{+}\right]$via the character $\phi^{\natural}$. Therefore, it is an irreducible module of the Heisenberg group $H_{\phi, U, r}^{F} / N$ with the non-trivial central character $\left.\phi^{\natural}\right|_{\left(K_{\phi, r}^{+}\right)^{F} / N}$. Such representation is unique by the representation theory of Heisenberg groups.

Note that $K_{\phi, r}^{F}=H_{\phi, r}^{F} L_{r}^{F}$. We view the (inflated) $L_{r}^{F}$-module

$$
R_{T, 0}^{L}\left(\phi_{-1}\right)
$$

as a $K_{\phi, r}^{F}$-module on which $H_{\phi, r}^{F}$ acts trivially.
On the other hand, $L_{r}^{F} \times\left(T_{r}^{0+}\right)^{F}$ acts on $\bar{Z}_{\phi, U, r}^{H}$ by $(y, t): z \mapsto y z t y^{-1}$. This induces an action $c_{L_{r}^{F}}$ of $L_{r}^{F}$ on the space

$$
\kappa(\phi)= \pm H_{c}^{*}\left(\bar{Z}_{\phi, U, r}^{H}, \overline{\mathbb{Q}}_{\ell}\right)\left[\phi^{+}\right] .
$$

Note that $c_{L_{r}^{F}}$ factors through the quotient $L_{0}^{F}$. So we can extend $\kappa(\phi)$ to a $K_{\phi, r^{\prime}}^{F}$-module on which $L_{r}^{F}$ acts by $c_{L_{r}^{F}}$ times the character $\left.\left.\left.\phi_{0}\right|_{T^{F}} \phi_{1}\right|_{T^{F}} \cdots \phi_{d}\right|_{T^{F}}$. We denote it by $\kappa(\phi)_{U}$.

Let $Z_{\phi, U, r}^{L_{\text {der }}}=Z_{\phi, U, r} \cap\left(L_{\text {der }}\right)_{r}$ and $Z_{\phi, U, r}^{H L_{\text {der }}}=Z_{\phi, U, r} \cap H_{\phi, r}\left(L_{\text {der }}\right)_{r}$. We denote by $\phi_{T+L_{\mathrm{der}}}$ and $\phi_{L_{\mathrm{der}}}$ the restrictions of $\phi$ to $\left(T_{r}^{0+}\right)^{F}\left(T \cap L_{\mathrm{der}}\right)_{r}^{F}$ and $\left(T \cap L_{\text {der }}\right)_{r}^{F}$ respectively.

Lemma 6.3. The map $(x, y) \rightarrow x y$ gives a fiber bundle

$$
Z_{\phi, U, r}^{H} \times Z_{\phi, U, r}^{L_{\mathrm{der}}} \longrightarrow Z_{\phi, U, r}^{H L_{\text {der }}}
$$

whose fiber are isomorphic to the affine space $\left(L_{\text {der }}\right)_{r}^{0+}$.
In particular, there is an isomorphism of $H_{\phi, r}^{F}\left(L_{\mathrm{der}}\right)_{r}^{F}$-modules

$$
\pm H_{c}^{*}\left(Z_{\phi, U, r}^{H L_{\mathrm{der}}}, \overline{\mathbb{Q}}_{\ell}\right)\left[\phi_{T^{+} L_{\mathrm{der}}}\right] \cong \kappa(\phi)_{U} \otimes R_{T \cap L_{\mathrm{der}}, 0}^{L_{\mathrm{der}}}\left(\phi_{L_{\mathrm{der}}}\right)
$$

Proof. Since $\left.G^{i}\right)_{-1 \leqslant i \leqslant d_{\phi}}$ is standard for $U, L_{r}$ normalizes $H_{\phi, r} \cap \mathcal{I}_{\phi, U, r}$. Hence the first statement follows by noticing that $H_{\phi, r} \cap\left(L_{\text {der }}\right)_{r}=\left(L_{\text {der }}\right)_{r}^{0+} \subseteq \mathcal{I}_{\phi, U, r}$. Moreover, by definition the natural quotient map $L_{\text {der }} \rightarrow\left(L_{\text {der }}\right)_{0}$ restricts to a fiber bundle

$$
Z_{\phi, U, r}^{L_{\mathrm{der}}} \longrightarrow X_{U \cap L_{\mathrm{der}}, 0}^{L_{\mathrm{der}}}
$$

whose fibers are isomorphic to an affine space. Hence

$$
\begin{aligned}
& \pm H_{c}^{*}\left(Z_{\phi, U, r}^{H L_{\mathrm{der}}}, \overline{\mathbb{Q}}_{\ell}\right)\left[\phi_{T^{+} L_{\mathrm{der}}}\right] \\
\cong & \left(H_{c}^{*}\left(Z_{\phi, U, r}^{H}, \overline{\mathbb{Q}}_{\ell}\right) \otimes H_{c}^{*}\left(Z_{\phi, U, r}^{L_{\mathrm{der}}}, \overline{\mathbb{Q}}_{\ell}\right)\right)\left[\phi_{T^{+} L_{\mathrm{der}}}\right] \\
\cong & \left(H_{c}^{*}\left(Z_{\phi, U, r}^{H}, \overline{\mathbb{Q}}_{\ell}\right)\left[\phi^{+}\right] \otimes H_{c}^{*}\left(X_{U \cap L_{\mathrm{der}}, 0}^{L_{\mathrm{der}}}, \overline{\mathbb{Q}}_{\ell}\right)\right)\left[\phi_{L_{\mathrm{der}}}\right] \\
\cong & \kappa(\phi)_{U} \otimes R_{T \cap L_{\mathrm{der}}, 0}^{L_{\mathrm{der}}}\left(\phi_{L_{\mathrm{der}}}\right),
\end{aligned}
$$

where the second equivalence is due to the triviality of the conjugation action of $\left(T_{r}^{0+}\right)^{F}$ on $X_{U \cap L_{\text {der }}, r}^{L_{\text {der }}}$.

Theorem 6.4. We have an isomorphism of $K_{\phi, r}^{F}$-modules

$$
\pm H_{c}^{*}\left(Z_{\phi, U, r}^{K}, \overline{\mathbb{Q}}_{\ell}\right)[\phi] \cong \kappa(\phi)_{U} \otimes R_{T, 0}^{L}\left(\phi_{-1}\right)
$$

As a consequence, $\mathcal{R}_{T, U, r}^{G}(\phi) \cong \operatorname{ind}_{K_{\phi, r}^{F}}^{G_{r}^{F}} \kappa(\phi)_{U} \otimes R_{T, 0}^{L}\left(\phi_{-1}\right)$.
Proof. Note that $K_{\phi, r}=H_{\phi, r}\left(L_{\text {der }}\right)_{r} T_{r}$ and $\mathcal{I}_{\phi, U, r} \subseteq H_{\phi, r}\left(L_{\text {der }}\right)_{r}$. Hence

$$
Z_{\phi, U, r}^{K}=\bigsqcup_{\tau \in T_{r}^{F} /\left(T_{r}^{0+}\right)^{F}\left(T \cap L_{\mathrm{der}}\right)_{r}^{F}} Z_{\phi, U, r}^{H L_{\mathrm{der}}} \tau
$$

By Lemma 6.3 we have

$$
\begin{aligned}
\pm H_{c}^{*}\left(Z_{\phi, U, r}^{K}, \overline{\mathbb{Q}}_{\ell}\right)[\phi] & \cong\left(\operatorname{ind}_{\left(T_{r}^{0+}\right)^{F}\left(T \cap L_{\mathrm{der}}\right)_{r}^{F}}^{T_{r}^{F}} H_{c}^{*}\left(Z_{\phi, U, r}^{H L_{\mathrm{der}}}, \overline{\mathbb{Q}}_{\ell}\right)\left[\phi_{T^{+} L_{\mathrm{der}}}\right]\right)[\phi] \\
& \cong\left(\operatorname{ind}_{\left(T_{r}^{0+}\right)^{F}\left(T \cap L_{\mathrm{der}}\right)_{r}^{F}}^{T_{r}^{F}}\left(\kappa(\phi)_{U} \otimes R_{T \cap L_{\mathrm{der}}, 0}^{L_{\mathrm{der}}}\left(\phi_{L_{\mathrm{der}}}\right)\right)[\phi]\right. \\
& \cong \kappa(\phi)_{U} \otimes\left(\operatorname{ind}_{\left(T \cap L_{\mathrm{der}}\right)_{0}^{F}}^{T_{0}^{F}}\left(\phi_{L_{\mathrm{der}}}\right)\right)\left[\phi_{-1}\right] \\
& \cong \kappa(\phi)_{U} \otimes R_{T, 0}^{L}\left(\phi_{-1}\right)
\end{aligned}
$$

where the in induced functor is taken with respect to the right multiplication by $T_{r}^{F}$, the third equivalent follows from that $\phi=\left.\left.\left.\phi_{-1}\right|_{T_{r}^{F}} \phi_{0}\right|_{T_{r}^{F}} \cdots \phi_{d}\right|_{T_{r}^{F}}$.

## 7. Relation with supercuspidal Representations

Recall that $T \subseteq G$ is an elliptic maxima torus, and $x$ is an $F$-fixed point in the apartment of $T$. We fix a generic cuspidal datum of $G$

$$
\Xi=\left(\left(G^{i}, \phi_{i}, r_{i}\right)_{0 \leqslant i \leqslant d}, x, \rho\right)
$$

in the sense of [18], that is,

- $\left(\left(G^{i}, \phi_{i}, r_{i}\right)_{-1 \leqslant i \leqslant d}\right.$ is a Howe factorization of $\phi:=\left.\left.\left.\phi_{-1}\right|_{T^{F}} \phi_{0}\right|_{T^{F}} \cdots \phi_{d}\right|_{T^{F}}$ with $\phi_{-1}$ the trivial character of $G^{-1}=T$;
- $\rho$ is a simple $L_{\overline{\bar{x}}}^{F}$-module whose restriction to $L_{0}^{F}$ contains the inflation of a supercuspical representation of the reductive quotient of $L_{0}^{F}$, where $L=G^{0}$ and $L_{\bar{x}}$ denotes the stabilizer of $x$ in $L$.

Let $Z$ be the center of $G$. Let $\omega_{\rho}=\left.\rho\right|_{Z^{F}}$ be the central character of $\rho$.
Then we may define $K_{\phi}$ and $H_{\phi}$ as in $\S 3$, Let $\tilde{K}=H_{\phi} L_{\bar{x}}$.
Let $\kappa(\phi)$ be the Heisenberg representation of $H_{\phi}^{F}$ defined in Proposition 6.2. We extend $\kappa(\phi)$ to a $\tilde{K}^{F}$-module $\kappa(\phi)_{\text {Weil }}$ such that $\kappa(\phi)_{\text {Weil }} \cong \kappa(\phi)$ as $H_{\phi}^{F}$-modules, and $L_{\overline{\mathrm{X}}}^{F}$ acts on $\kappa(\phi)_{\text {Weil }}$ by the character $\left.\left.\left.\phi_{0}\right|_{L^{F}} \phi_{1}\right|_{L^{F}} \cdots \phi_{d}\right|_{L^{F}}$ times the Weil representation, see [14, §2.5]. On the other hand, we can view $\rho$ to a $\tilde{K}^{F}$-module on which $H_{\phi}^{F}$ acts trivially.

The following result is proved in [18] and [14]
Theorem 7.1. The induced module

$$
\pi_{\Sigma}:=c-\operatorname{ind}_{\tilde{K}^{F}}^{G^{F}} \kappa(\phi)_{\text {Weil }} \otimes \rho,
$$

is a supercuspical representation of $G^{F}$.
Let $\rho_{0}$ be an irreducible representation of $Z^{F} L_{x}^{F}$ which appears in $\left.\rho\right|_{Z^{F} L_{x}^{F}}$. In other words, $\rho$ is a direct summand of $\operatorname{ind}_{Z^{F} L_{x}^{F}}^{L_{x}^{F}} \rho_{0}$. Similarly, we view $\rho_{0}$ as a representation of $Z^{F} K_{\phi}^{F}=Z^{F} L_{\mathrm{x}}^{F} H_{\phi}^{F}$ such that $H_{\phi}^{F}$ acts trivially.
Lemma 7.2. The representation $\kappa(\phi)_{\text {Weil }} \otimes \rho$ of $\tilde{K}^{F}$ is a direct summand of $\operatorname{ind}_{Z^{F} K_{\phi}^{F}}^{\tilde{K}^{F}} \kappa(\phi)_{\text {Weil }} \otimes \rho_{0}$. As a consequence, $\pi_{\Sigma}$ is a direct summand of $c-\operatorname{ind}_{Z^{F} K_{\phi}^{F}}^{G^{F}} \kappa(\phi)_{\text {Weil }} \otimes \rho_{0}$.
7.1. Let $B=T U$ be a Borel subgroup such that $\left(G^{i}\right)_{-1 \leqslant i \leqslant d}$ is standard for $U$. Let $\kappa(\phi)_{U}$ be the $K_{\phi}^{F}$-module constructed in ${ }^{66}$. We view $\kappa(\phi)_{U}$ as a $Z^{F} K_{\phi}^{F}$-module on which $Z^{F}$ acts via the character $\phi$.
Lemma 7.3. There exists an irreducible module $\rho_{0}^{b}$ of $Z^{F} K_{\phi}^{F}$ such that

$$
\kappa(\phi)_{\text {Weil }} \otimes \rho_{0} \cong \kappa(\phi)_{U} \otimes \rho_{0}^{b}
$$

as $Z^{F} K_{\phi}^{F}$-modules. Moreover, $\left.\rho_{0}^{b}\right|_{Z^{F}}=\left.\rho_{0}\right|_{Z^{F}}=\left.\rho\right|_{Z^{F}}$ and the restriction of $\rho_{0}^{b}$ to $H_{\phi}^{F}$ is trivial.
Proof. Let $\kappa$ be the irreducible $Z^{F} H_{\phi}^{F}$-module such that $\kappa \cong \kappa(\phi)$ as $H_{\phi}^{F}$ module, and $\left.\kappa\right|_{Z^{F}}=\phi \omega$, where $\omega=\left.\rho_{0}\right|_{Z^{F}}$ is the central character of $\rho$ or $\rho_{0}$. By construction, $\kappa$ appears in the $Z^{F} H_{\phi}^{F}$-module $\kappa(\phi)_{\text {Weil }} \otimes \rho_{0}$, that is,

$$
\kappa(\phi)_{\mathrm{Weil}} \otimes \rho_{0} \subseteq \theta:=\operatorname{ind}_{Z^{F} H_{\phi}^{F}}^{Z^{F} K_{\phi}^{F}} \kappa .
$$

On the other hand, consider

$$
\vartheta:=\kappa(\phi)_{U} \otimes \operatorname{ind}_{Z^{F} H_{\phi}^{F}}^{Z^{F} K_{\phi}^{F}} \omega,
$$

where $\omega$ is the character such that $\omega(z h)=\omega(z)$ for $z \in Z^{F}$ and $h \in H_{\phi}^{F}$. Note that $Z^{F} H_{\phi}^{F}$ is a normal subgroup of $Z^{F} K_{\phi}^{F}$. Thus $\theta(g)=\vartheta(g)=0$ if
$g \in Z^{F} K_{\phi}^{F} \backslash Z^{F} H_{\phi}^{F}$, and

$$
\theta(g)=\vartheta(g)=\sum_{x \in Z^{F} K_{\phi}^{F} / Z^{F} H_{\phi}^{F}} \kappa\left(x^{-1} g x\right), \text { if } g \in Z^{F} H_{\phi}^{F} .
$$

Thus $\theta=\theta^{\prime}$ and the statement follows.
By [7, there exists a character $\lambda$ of $T_{\mathrm{x}}^{F}$ of depth zero such that $\left.\rho^{b}\right|_{L_{x}^{F}}$ appears in $R_{T, 0}^{L}(\lambda)$. As $T$ is unramified and elliptic, $T^{F}=Z^{F} T_{\mathrm{x}}^{F}$, and we can extend $\lambda$ to a character of $T^{F}$ whose restriction to $Z^{F}$ is $\left.\rho^{b}\right|_{Z^{F}}$. We still denote it by $\lambda$. Let $\psi=\lambda \phi$. Now we view $R_{T, r_{\psi}}^{G}(\psi)$ as a representation of $Z^{F} G_{x}^{F}=T^{F} G_{x}^{F}$ such $Z^{F}$ acts by the central character $\left.\rho\right|_{Z^{F}}=\left.\rho_{0}^{b}\right|_{Z^{F}}$.

Corollary 7.4. The supercuspidal representation $\pi_{\Sigma}$ is a direct summand of $c-\mathrm{ind}_{Z^{F}}^{G_{G_{x}^{F}}^{F}} R_{T, r_{\psi}}^{G}(\psi)$.
Proof. Let $\psi_{i}=\phi_{i}$ for $1 \leqslant i \leqslant d$. Let $\psi_{-1}=\lambda, \psi_{0}=\phi_{0}$ if $L=G^{0} \neq$ $T$ and $\psi_{-1}=1, \psi_{0}=\lambda \phi_{0}$ otherwise. Then $\left(G^{i}, \psi_{i}, r_{i}\right)_{-1 \leqslant i \leqslant d}$ is a Howe decomposition of $\psi$. Combined with Lemma [7.2, Lemma 7.3 and Theorem 6.4. we deduce that

$$
\begin{aligned}
\pi_{\Sigma} & =\operatorname{c-ind}_{\tilde{K}^{F}}^{G^{F}} \kappa(\phi)_{\text {Weil }} \otimes \rho \\
& \subseteq \operatorname{c-ind}_{Z^{F}}^{G^{F}} K_{\phi}^{F} \kappa(\phi)_{\text {Weil }} \otimes \rho_{0} \\
& \cong \operatorname{c-ind}_{Z^{F}}^{G^{F}} K_{\phi}^{F} \\
& \subseteq \operatorname{c-ind}_{Z^{F}}^{G^{F}} K_{\phi}^{F}
\end{aligned} \phi_{U} \otimes \rho_{0}^{b}(\phi)_{U} \otimes R_{T, 0}^{L}(\lambda), \operatorname{c-ind}_{Z^{F} K_{\phi}^{F}}^{G^{F}} \kappa(\psi)_{U} \otimes R_{T, 0}^{L}\left(\psi_{-1}\right) .
$$

The proof is finished.
