# ON SIEGEL RESULTS ABOUT THE ZEROS OF THE AUXILIARY FUNCTION OF RIEMANN. 

J. ARIAS DE REYNA


#### Abstract

We state and give complete proof of the results of Siegel about the zeros of the auxiliary function of Riemann $\mathcal{R}(s)$. We point out the importance of the determination of the limit to the left of the zeros of $\mathcal{R}(s)$ with positive imaginary part, obtaining the term $-\sqrt{T / 2 \pi} P(\sqrt{T / 2 \pi})$ that would explain the periodic behaviour observed with the statistical study of the zeros of $\mathcal{R}(s)$.

We precise also the connection of the position on the zeros of $\mathcal{R}(s)$ with the zeros of $\zeta(s)$ in the critical line.


## 1. Introduction

In his paper [14] Riemann asserts to have proved that all but an infinitesimal proportion of zeros of zeta are in the critical line. This is repeated in a letter to Weierstrass [15, p. 823-825], where he says that the difficult proof depends on a new development of $\Xi(t)$ that he has not simplified sufficiently to communicate. The Riemann-Siegel expansion for $\zeta(s)$ were recovered by Siegel from Riemann's papers. Siegel in his publication [17] concluded that in Riemann's Nachlass there is no approach to the proof of his assertion on the real zeros of $\Xi(t)$. However, Siegel connected the zeros of the new function $\mathcal{R}(s)$, found in Riemann's papers, with the zeros of $\zeta(s)$. The main objective of this paper is to expose and give a complete proof of the results of Siegel on the zeros of $\mathcal{R}(s)$.

Siegel [17] proved an asymptotic expression (16) valid for $1-\sigma \geq t^{a}$ with $a=\frac{3}{7}$. He claims that we may prove this with $a=\varepsilon$ for any $\varepsilon>0$. In [4, Th. 11] we proved it for $1-\sigma \geq t^{2 / 5} \log t$. In this paper, it will be desirable to have proved the claim with $a<\frac{1}{3}$ so that the term in $|\sigma|^{3 / 2}=\boldsymbol{o}\left(t^{1 / 2}\right)$. For this reason we will keep $a$ undetermined, to see the possible consequences of the hypothesis of being $a<\frac{1}{3}$. On the other hand, we may assume in all our results that $a=\frac{3}{7}$ as done by Siegel (see also [7, Th. 9]).

The paper contains many computations that Siegel does not detail. First, we state three main Theorems in Section 2. We postpone its proof, and in Section 3 we give the main applications to the zeros of $\mathcal{R}(s)$. We note that in [9] we have given a better result about the number of zeros than the one obtained by Siegel methods (see Remark 5). Our corollary 11 slightly improves on Siegel's results. This corollary implies that $\mathcal{R}(s)$ contains at least $>c T$ zeros to the left of the critical line, with $c=35 / 198 \pi$. This constant is a slight improvement over the one in Siegel, in any case it is a very poor result, as it only shows that the number of zeros of $\zeta(s)$ on the critical line $N_{0}(T)$ is greater than $c T$. Our computation of the zeros of $\mathcal{R}(s)$ [2] makes plausible that $\frac{2}{3}$ of the zeros of $\mathcal{R}(s)$ are on the left of the critical line, this would imply that $2 / 3$ of the zeros of $\zeta(s)$ will be simple zeros on the critical line.

[^0]In Section 5 we prove Theorem 3. It is in Siegel only implicitly. In Section 7 we prove Theorem 1. We make a modification of Siegel's reasoning. He uses a function $g(s)=\pi^{-(s+1) / 2} e^{-\pi i s / 4} \Gamma\left(\frac{s+1}{2}\right) \mathcal{R}(s)$, while we use $F(s)=s \pi^{-s / 2} \Gamma(s / 2) \mathcal{R}(s)$. The main advantage is that our function is entire, while $g(s)$ has poles and zeros at the negative real axis, making the Siegel reasoning difficult. We postpone for section 8 the proof of propositions 20 and 21 that are mere computations.
1.1. Notations. We use $N(\beta \leq \sigma, T)$ and $N(\beta>\sigma, T)$ to denote the count of zeros $\rho=\beta+i \gamma$ of $\mathcal{R}(s)$ contained in $(-\infty, \sigma] \times(0, T]$ and $(\sigma,+\infty) \times(0, T]$ respectively counting with multiplicities. The sum of the two is denoted by $N_{\mathcal{R}}(T) . N(T)$ and $N_{0}(T)$ denote the number of zeros of $\zeta(s)$ on the critical strip and in the critical line, respectively, as usual. We use $\mathcal{O}^{*}(h)$ to denote a quantity $R$ bounded by $|R| \leq|h|$.

## 2. Main Results.

Applying Littlewood's lemma to $\mathcal{R}(s)$ in the rectangle $[\sigma, 4] \times\left[t_{0}, T\right]$ yields
Theorem 1. Let $1 \leq t_{0}$ and $\sigma \leq 1$ be fixed, then for $T \rightarrow+\infty$

$$
\begin{equation*}
\int_{t_{0}}^{T} \log |\mathcal{R}(\sigma+i t)| d t=2 \pi \sum_{\substack{\beta>\sigma \\ 0<\gamma \leq T}}(\beta-\sigma)+\mathcal{O}_{\sigma}(\log T) . \tag{1}
\end{equation*}
$$

With the combed function $s \pi^{-s / 2} \Gamma(s / 2) \mathcal{R}(s)$, we can apply Littlewood's lemma on the rectangle $\left[\sigma_{0}, \sigma\right] \times\left[t_{0}, T\right]$ to get
Theorem 2. Let $1 \leq t_{0}$ and $\sigma \leq 10$ fixed, then for $T \rightarrow+\infty$ we have
(2) $2 \pi \sum_{\substack{\beta \leq \sigma \\ 0<\gamma \leq T}}(\sigma-\beta)=\sigma\left(\frac{T}{2} \log \frac{T}{2 \pi}-\frac{T}{2}\right)+\frac{T}{2} \log 2+\int_{t_{0}}^{T} \log |\mathcal{R}(\sigma+i t)| d t+\mathcal{O}_{\sigma}\left(T^{20 / 21}\right)$.

In some cases, we have independent information on the integral of $\log |\mathcal{R}(\sigma+t)|$ :
Theorem 3. Given $\sigma_{1}>3$, there is a constant $C$ such that for $\sigma \geq \sigma_{1}$ and $1 \leq t_{0}<T$ we have

\begin{equation*}
\left|\int_{t_{0}}^{T} \log \right| \mathcal{R}(\sigma+i t)|d t| \leq C 2^{-\sigma} \tag{3}
\end{equation*}
$$

## 3. Applications of the main Theorems

Proposition 4. The number of zeros $\rho=\beta+i \gamma$ of $\mathcal{R}(s)$ with $0<\gamma<T$ is

$$
\begin{equation*}
N_{\mathcal{R}}(T)=\frac{T}{4 \pi} \log \frac{T}{2 \pi}-\frac{T}{4 \pi}+\boldsymbol{\mathcal { O }}\left(T^{20 / 21}\right) \tag{4}
\end{equation*}
$$

Proof. By Theorems 2 and 3 we have for $\sigma=4$ and $\sigma=5$ for $T \rightarrow+\infty$

$$
\begin{equation*}
2 \pi \sum_{\substack{\beta \leq \sigma \\ 0<\gamma \leq T}}(\sigma-\beta)=\sigma\left(\frac{T}{2} \log \frac{T}{2 \pi}-\frac{T}{2}\right)+\frac{T}{2} \log 2+\boldsymbol{\mathcal { O }}\left(T^{20 / 21}\right) . \tag{5}
\end{equation*}
$$

Except for a finite number, the zeros of $\mathcal{R}(s)$ with $\gamma>0$ satisfies $\beta \leq 3$ as shown in [5, Cor. 14]. Hence

$$
N_{\mathcal{R}}(T)=\sum_{\substack{\beta \leq 5 \\ 0<\gamma \leq T}}(5-\beta)-\sum_{\substack{\beta \leq 4 \\ 0<\gamma \leq T}}(4-\beta)+\boldsymbol{\mathcal { O }}(1) .
$$

The result is obtained by subtracting the above results.
Remark 5. By a different and more direct reasoning, we have proved in [9] the more precise result

$$
N_{\mathcal{R}}(T)=\frac{T}{4 \pi} \log \frac{T}{2 \pi}-\frac{T}{4 \pi}-\frac{1}{2} \sqrt{\frac{T}{2 \pi}}+\boldsymbol{\mathcal { O }}\left(T^{2 / 5} \log T\right)
$$

Proposition 6. For $T \rightarrow+\infty$ and denoting by $\rho=\beta+i \gamma$ the zeros of $\mathcal{R}(s)$, we have

$$
\begin{equation*}
\sum_{0<\gamma \leq T} \beta=-\frac{T}{4 \pi} \log 2+\boldsymbol{\mathcal { O }}\left(T^{20 / 21}\right) . \tag{6}
\end{equation*}
$$

Proof. For $\sigma=4$, for example, we have

$$
\sum_{\substack{\beta \leq 4 \\ 0<\gamma \leq T}}(\sigma-\beta)=\sigma N_{\mathcal{R}}(T)-\sum_{0<\gamma \leq T} \beta=\sigma\left(\frac{T}{4 \pi} \log \frac{T}{2 \pi}-\frac{T}{4 \pi}\right)-\sum_{0<\gamma \leq T} \beta+\boldsymbol{\mathcal { O }}\left(T^{20 / 21}\right) .
$$

Comparing with (5) we get our result.
Lemma 7. Let $\sigma^{\prime}<\sigma \leq 10$ then

$$
\begin{align*}
\left(\sigma-\sigma^{\prime}\right) N(\beta \leq \sigma, T) & \geq\left(\sigma-\sigma^{\prime}\right)\left(\frac{T}{4 \pi} \log \frac{T}{2 \pi}-\frac{T}{4 \pi}\right)+  \tag{7}\\
& +\frac{1}{2 \pi} \int_{t_{0}}^{T} \log |\mathcal{R}(\sigma+i t)| d t-\frac{1}{2 \pi} \int_{t_{0}}^{T} \log \left|\mathcal{R}\left(\sigma^{\prime}+i t\right)\right| d t+\boldsymbol{o}(T)
\end{align*}
$$

Proof. by Theorem 2 we have

$$
\begin{aligned}
& \sum_{\substack{\beta \leq \sigma \\
0<\gamma \leq T}}(\sigma-\beta)=\sigma\left(\frac{T}{4 \pi} \log \frac{T}{2 \pi}-\frac{T}{4 \pi}\right)+\frac{T \log 2}{4 \pi}+\frac{1}{2 \pi} \int_{t_{0}}^{T} \log |\mathcal{R}(\sigma+i t)| d t+\boldsymbol{o}(T), \\
& \sum_{\substack{\beta \leq \sigma^{\prime} \\
0<\gamma \leq T}}\left(\sigma^{\prime}-\beta\right)=\sigma^{\prime}\left(\frac{T}{4 \pi} \log \frac{T}{2 \pi}-\frac{T}{4 \pi}\right)+\frac{T \log 2}{4 \pi}+\frac{1}{2 \pi} \int_{t_{0}}^{T} \log \left|\mathcal{R}\left(\sigma^{\prime}+i t\right)\right| d t+\boldsymbol{o}(T) .
\end{aligned}
$$

We subtract the two equations. Since $\sigma^{\prime}<\sigma$ we have

$$
\begin{gathered}
\sum_{\substack{\beta \leq \sigma \\
0<\gamma \leq T}}(\sigma-\beta)-\sum_{\substack{\beta \leq \sigma^{\prime} \\
0<\gamma \leq T}}\left(\sigma^{\prime}-\beta\right)=\sum_{\substack{\beta \leq \sigma \\
0<\gamma \leq T}}(\sigma-\beta)-\sum_{\substack{\beta \leq \sigma \\
0<\gamma \leq T}}\left(\sigma^{\prime}-\beta\right)+\sum_{\substack{\sigma^{\prime}<\beta \leq \sigma \\
0<\gamma \leq T}}\left(\sigma^{\prime}-\beta\right) \\
=\left(\sigma-\sigma^{\prime}\right) N(\beta \leq \sigma, T)+\sum_{\substack{\sigma^{\prime}<\beta \leq \sigma \\
0<\gamma \leq T}}\left(\sigma^{\prime}-\beta\right) \leq\left(\sigma-\sigma^{\prime}\right) N(\beta \leq \sigma, T) .
\end{gathered}
$$

Therefore,

$$
\begin{aligned}
\left(\sigma-\sigma^{\prime}\right) N(\beta \leq \sigma, T) & \geq\left(\sigma-\sigma^{\prime}\right)\left(\frac{T}{4 \pi} \log \frac{T}{2 \pi}-\frac{T}{4 \pi}\right)+\frac{1}{2 \pi} \int_{t_{0}}^{T} \log |\mathcal{R}(\sigma+i t)| d t \\
& -\frac{1}{2 \pi} \int_{t_{0}}^{T} \log \left|\mathcal{R}\left(\sigma^{\prime}+i t\right)\right| d t+\boldsymbol{o}(T)
\end{aligned}
$$

Lemma 8. For $\sigma^{\prime}<\sigma \leq 10$ we have
(8) $\left(\sigma-\sigma^{\prime}\right) N(\beta \leq \sigma, T) \geq\left(\sigma-\sigma^{\prime}\right)\left(\frac{T}{4 \pi} \log \frac{T}{2 \pi}-\frac{T}{4 \pi}\right)-\frac{1}{2 \pi} \int_{t_{0}}^{T} \log \left|\mathcal{R}\left(\sigma^{\prime}+i t\right)\right| d t+\boldsymbol{o}(T)$.

Proof. By Lemma 7 and Theorem 1 we have for any $\sigma^{\prime \prime}$ with $\sigma>\sigma^{\prime \prime}>\sigma^{\prime}$

$$
\begin{aligned}
\left(\sigma^{\prime \prime}-\sigma^{\prime}\right) N(\beta \leq \sigma, T) & \geq\left(\sigma^{\prime \prime}-\sigma^{\prime}\right)\left(\frac{T}{4 \pi} \log \frac{T}{2 \pi}-\frac{T}{4 \pi}\right)+\sum_{\substack{\beta>\sigma^{\prime \prime} \\
0<\gamma \leq T}}\left(\beta-\sigma^{\prime \prime}\right) \\
& -\frac{1}{2 \pi} \int_{t_{0}}^{T} \log \left|\mathcal{R}\left(\sigma^{\prime}+i t\right)\right| d t+o(T)
\end{aligned}
$$

We have (by Proposition 4)

$$
\begin{aligned}
& \sum_{\substack{\beta>\sigma^{\prime \prime} \\
0<\gamma \leq T}}\left(\beta-\sigma^{\prime \prime}\right) \geq \sum_{\substack{\beta>\sigma \\
0<\gamma \leq T}}\left(\beta-\sigma^{\prime \prime}\right) \geq\left(\sigma-\sigma^{\prime \prime}\right) N(\beta>\sigma, T) \\
& =\left(\sigma-\sigma^{\prime \prime}\right)\left(\frac{T}{4 \pi} \log \frac{T}{2 \pi}-\frac{T}{4 \pi}-N(\beta \leq \sigma, T)+o(T)\right)
\end{aligned}
$$

Therefore,

$$
\begin{aligned}
\left(\sigma^{\prime \prime}-\sigma^{\prime}\right) N(\beta \leq \sigma, T) & +\left(\sigma-\sigma^{\prime \prime}\right) N(\beta \leq \sigma, T) \\
& \geq\left(\sigma-\sigma^{\prime}\right)\left(\frac{T}{4 \pi} \log \frac{T}{2 \pi}-\frac{T}{4 \pi}\right)-\frac{1}{2 \pi} \int_{t_{0}}^{T} \log \left|\mathcal{R}\left(\sigma^{\prime}+i t\right)\right| d t+\boldsymbol{o}(T) .
\end{aligned}
$$

Lemma 9. Let $f:[0,+\infty) \rightarrow \mathbf{C}$ integrable on any compact set and such that

$$
\lim _{T \rightarrow+\infty} \frac{1}{T} \int_{0}^{T}|f(t)|^{2} d t=+\infty
$$

Given $t_{0}$ there is some $T_{0}$ such that for $T \geq T_{0}$ we have

$$
\begin{equation*}
\int_{t_{0}}^{T} \log |f(t)| d t \leq \frac{T}{2} \log \left(\frac{1}{T} \int_{0}^{T}|f(t)|^{2} d t\right) \tag{9}
\end{equation*}
$$

Proof. Since $\log x$ is a concave function by Jensen's inequality [16, p. 61] for $T>t_{0}$ we have

$$
\frac{1}{T-t_{0}} \int_{t_{0}}^{T} \log |f(t)|^{2} d t \leq \log \left(\frac{1}{T-t_{0}} \int_{t_{0}}^{T}|f(t)|^{2} d t\right)
$$

Let us define

$$
A:=\int_{t_{0}}^{T}|f(t)|^{2} d t \leq B:=\int_{0}^{T}|f(t)|^{2} d t
$$

The function $x \mapsto \frac{x}{2} \log \frac{B}{x}$ is increasing for $x \in\left[T-t_{0}, T\right]$, since the derivative is $\frac{1}{2} \log \frac{B}{x}-\frac{1}{2}$, which is positive for $B>e x$. So, we only need that $B>e T$ and this happens for $T \geq T_{0}$ by hypothesis. Then

$$
\int_{t_{0}}^{T} \log |f(t)| d t \leq \frac{T-t_{0}}{2} \log \frac{A}{T-t_{0}} \leq \frac{T-t_{0}}{2} \log \frac{B}{T-t_{0}} \leq \frac{T}{2} \log \frac{B}{T}
$$

This is our inequality.
Proposition 10. There is some $T_{0}$ such that for $T>T_{0}$ we have

$$
\begin{equation*}
N\left(\beta \leq \frac{1}{2}, T\right) \geq \frac{35 T}{396 \pi}+\frac{5}{11 \pi} \int_{t_{0}}^{T} \log \left|\mathcal{R}\left(\frac{1}{2}+i t\right)\right| d t \tag{10}
\end{equation*}
$$

Proof. Applying Lemma 7 with $\sigma=1 / 2$ and $\sigma^{\prime}<1 / 2$ yields

$$
\begin{aligned}
\left(\frac{1}{2}-\sigma^{\prime}\right) N\left(\beta \leq \frac{1}{2}, T\right) & \geq\left(\frac{1}{2}-\sigma^{\prime}\right)\left(\frac{T}{4 \pi} \log \frac{T}{2 \pi}-\frac{T}{4 \pi}\right)+ \\
& +\frac{1}{2 \pi} \int_{t_{0}}^{T} \log \left|\mathcal{R}\left(\frac{1}{2}+i t\right)\right| d t-\frac{1}{2 \pi} \int_{t_{0}}^{T} \log \left|\mathcal{R}\left(\sigma^{\prime}+i t\right)\right| d t+\boldsymbol{o}(T)
\end{aligned}
$$

In [8] we proved that for $\sigma^{\prime} \leq 1 / 4$ we have

$$
\frac{1}{T} \int_{0}^{T}\left|\mathcal{R}\left(\sigma^{\prime}+i t\right)\right|^{2} d t=\frac{2}{\left(1-2 \sigma^{\prime}\right)\left(3-2 \sigma^{\prime}\right)}\left(\frac{T}{2 \pi}\right)^{\frac{1}{2}-\sigma^{\prime}}+\boldsymbol{\mathcal { O }}\left(T^{\frac{1}{4}-\sigma^{\prime}}\right)
$$

This and Lemma 9 yields for $\sigma \leq 1 / 4$ and $T$ big enough

$$
\int_{t_{0}}^{T} \log \left|\mathcal{R}\left(\sigma^{\prime}+i t\right)\right| d t \leq\left(\frac{1}{2}-\sigma^{\prime}\right) \frac{T}{2} \log \frac{T}{2 \pi}-\frac{T}{2} \log \frac{\left(1-2 \sigma^{\prime}\right)\left(3-2 \sigma^{\prime}\right)}{2}+\boldsymbol{\mathcal { O }}\left(T^{3 / 4}\right)
$$

Hence,

$$
\begin{aligned}
\left(\frac{1}{2}-\sigma^{\prime}\right) N\left(\beta \leq \frac{1}{2}, T\right) & \geq-\left(\frac{1}{2}-\sigma^{\prime}\right) \frac{T}{4 \pi}+ \\
& +\frac{1}{2 \pi} \int_{t_{0}}^{T} \log \left|\mathcal{R}\left(\frac{1}{2}+i t\right)\right| d t+\frac{T}{4 \pi} \log \frac{\left(1-2 \sigma^{\prime}\right)\left(3-2 \sigma^{\prime}\right)}{2}+\boldsymbol{o}(T) .
\end{aligned}
$$

The function

$$
f\left(\sigma^{\prime}\right)=-1+\frac{1}{\frac{1}{2}-\sigma^{\prime}} \log \frac{\left(1-2 \sigma^{\prime}\right)\left(3-2 \sigma^{\prime}\right)}{2},
$$

has a maximum near $\sigma^{\prime}=-3 / 5$ where $f(-3 / 5)>7 / 18$. Therefore, taking $\sigma^{\prime}=-3 / 5$ we get

$$
\frac{11}{10} N\left(\beta \leq \frac{1}{2}, T\right) \geq \frac{7 T}{72 \pi}+\frac{1}{2 \pi} \int_{t_{0}}^{T} \log \left|\mathcal{R}\left(\frac{1}{2}+i t\right)\right| d t+\boldsymbol{o}(T) .
$$

Since $f(-3 / 5)>7 / 18$ the term $\boldsymbol{o}(T)$ can be eliminated for $T \geq T_{0}$, taking $T_{0}$ big enough.

Corollary 11. There exists some $T_{0}$ such that for $T \geq T_{0}$ we have

$$
N\left(\beta \leq \frac{1}{2}, T\right) \geq \frac{35 T}{396 \pi}+\frac{5}{11} \sum_{\substack{\beta>1 / 2 \\ 0<\gamma \leq T}}\left(\beta-\frac{1}{2}\right) .
$$

Proof. In Proposition 10 substitute the integral by its value in Theorem 1. The error term $\mathcal{O}(\log T)$ is eliminated due to the strict inequality $f(-3 / 5)>7 / 18$.

## 4. Connection with the zeros of $\zeta(s)$

We have $\zeta\left(\frac{1}{2}+i t\right)=e^{-i \vartheta(t)} Z(t)$ where $\vartheta(t)$ and $Z(t)$ are real analytic functions. These are connected to $\mathcal{R}(s)$ by

$$
Z(t)=2 \operatorname{Re}\left\{e^{i \vartheta(t)} \mathcal{R}\left(\frac{1}{2}+i t\right)\right\},
$$

(see [1]). In [10] we show that $\mathcal{R}\left(\frac{1}{2}+i t\right)=e^{-i \omega(t)} g(t)$ where $\omega(t)$ and $g(t)$ are real analytic functions. It follows that a point $\frac{1}{2}+i t$ with $t \in \mathbf{R}$ is a zero of $\zeta(s)$ if and only if it is a zero of $\mathcal{R}(s)$ or if

$$
\cos (\vartheta(t)-\omega(t))=0
$$

Also, it is shown in [10] that for $T>0$ we have

$$
\omega(T)=2 \pi N(\beta \geq 1 / 2, T)+\boldsymbol{\mathcal { O }}(\log T)
$$

If there were no zeros to the right of the critical line, $N(\beta \geq 1 / 2, T)=0$, then the function $\vartheta(t)-\omega(t)$ will increase for $t \in[0, T]$ from 0 to $\approx \vartheta(T)$ and the number of zeros of $\zeta(s)$ in the critical line from $t=0$ to $t=T$ will be $\vartheta(T) / \pi$. Almost all zeros of the zeta function will be on the critical line. But this does not appear to be true, our (limited) computation of zeros [2] points to the approximate equality $N(\beta \geq 1 / 2, T) \approx \vartheta(T) / 6 \pi$.

## 5. Proof of Theorem 3

Lemma 12. For $s=\sigma+$ it with $\sigma \geq 2, t \geq 0$ and $|s|>2 \pi e^{2}$ we have

$$
\begin{equation*}
\mathcal{R}(s)=\zeta(s)(1+W(s)), \quad|W(s)| \leq C\left(\frac{|s|}{2 \pi e}\right)^{\frac{1-\sigma}{2}} \tag{11}
\end{equation*}
$$

where $C$ is an absolute constant.
Proof. In [5, Thm. 12] it is proved that for $s=\sigma+i t$ with $t>0, \sigma>0$ and such that $|s|>2 \pi e^{2}$ we have

$$
\mathcal{R}(s)=\sum_{n=1}^{\ell} \frac{1}{n^{s}}+R(s), \quad|R(s)| \leq C|s / 2 \pi e|^{-\sigma / 2}
$$

where, $\xi=\sqrt{\frac{s}{2 \pi i}}=\xi_{1}+i \xi_{2}$ with $0<-\xi_{2}<\xi_{1}$ and $\ell=\left\lfloor\xi_{1}-\xi_{2}\right\rfloor$, and $C$ is an absolute constant.

Therefore, under these conditions, but assuming $\sigma>1$

$$
\mathcal{R}(s)=\zeta(s)-\sum_{n=\ell+1}^{\infty} \frac{1}{n^{s}}+R(s) .
$$

Notice that $\left|\xi_{1}\right|=\xi_{1}$ and $\left|\xi_{2}\right|=-\xi_{2}$, so that

$$
|\xi|-1 \leq\left|\xi_{1}\right|+\left|\xi_{2}\right|-1<\ell=\left\lfloor\xi_{1}-\xi_{2}\right\rfloor \leq\left|\xi_{1}\right|+\left|\xi_{2}\right| \leq \sqrt{2}|\xi|=\sqrt{|s| / \pi}
$$

Therefore,

$$
\left|\sum_{n=\ell+1}^{\infty} \frac{1}{n^{s}}\right| \leq \sum_{n>|\xi|} \frac{1}{n^{\sigma}} \leq|\xi|^{-\sigma}+\int_{|\xi|}^{\infty} x^{-\sigma} d x=(|s| / 2 \pi)^{-\sigma / 2}+\frac{1}{\sigma-1}(|s| / 2 \pi)^{(1-\sigma) / 2}
$$

It follows that for $\sigma \geq 2$

$$
\left|R(s)-\sum_{n=\ell+1}^{\infty} \frac{1}{n^{s}}\right| \leq C|s / 2 \pi e|^{-\sigma / 2}+(|s| / 2 \pi)^{-\sigma / 2}+\frac{1}{\sigma-1}(|s| / 2 \pi)^{(1-\sigma) / 2} \leq C|s / 2 \pi e|^{(1-\sigma) / 2}
$$

Therefore,

$$
\mathcal{R}(s)=\zeta(s)+V(s)=\zeta(s)(1+W(s)), \quad|W(s)| \leq C \zeta(2)|s / 2 \pi e|^{(1-\sigma) / 2}
$$

Proposition 13. There exist $\sigma_{0}>3, t_{0}>1$ and a constant $C$ such that for $T>t_{0}$ and $\sigma>\sigma_{0}$, we have

$$
\begin{equation*}
\left|\int_{t_{0}}^{T} \log \right| \mathcal{R}(\sigma+i t)|d t| \leq C 2^{-\sigma}, \tag{12}
\end{equation*}
$$

Proof. We have

$$
\int_{t_{0}}^{T} \log |\mathcal{R}(\sigma+i t)| d t=\int_{t_{0}}^{T} \log |\zeta(\sigma+i t)| d t+\int_{t_{0}}^{T}|\log (1+W(\sigma+i t))| d t
$$

The integral in the zeta function is treated easily

$$
\begin{aligned}
\int_{t_{0}}^{T} \log |\zeta(\sigma+i t)| d t & =\operatorname{Re} \int_{t_{0}}^{T} \sum_{n=2}^{\infty} \frac{\Lambda(n)}{\log n} \frac{1}{n^{s}} d t=\int_{t_{0}}^{T} \sum_{n=2}^{\infty} \frac{\Lambda(n)}{\log n} \frac{\cos (t \log n)}{n^{\sigma}} d t \\
& =\sum_{n=2}^{\infty} \frac{\Lambda(n)}{\log n} \frac{\sin (T \log n)-\sin \left(t_{0} \log n\right)}{n^{\sigma} \log n} .
\end{aligned}
$$

So, in absolute value

$$
\left|\int_{t_{0}}^{T} \log \right| \zeta(\sigma+i t)|d t| \leq 2^{-\sigma} \sum_{n=2}^{\infty} \frac{2 \Lambda(n)}{(n / 2)^{\sigma} \log ^{2} n} \leq 2^{-\sigma} \sum_{n=2}^{\infty} \frac{2 \Lambda(n)}{(n / 2)^{3} \log ^{2} n} .
$$

The function $1+W(s)$ defined by $\mathcal{R}(s)=\zeta(s)(1+W(s))$ is analytic and is not equal to 0 on the line $\sigma+i t$ with $\sigma>3$ fixed and $t \geq t_{0}$. Since $|W(s)| \leq C(|s| / 2 \pi e)^{(1-\sigma) / 2}$, there is some $t_{1}$ such that for $t>t_{1}$ we have $|W(s)| \leq 1 / 4$. The function $\log (1+W(s))$ is well defined, with the imaginary part $\leq \pi / 2$ in absolute value for $t>t_{1}$. We also have for $t \geq t_{1}$ that

$$
|\log (1+W(s))| \leq 2 C(|s| / 2 \pi e)^{(1-\sigma) / 2}
$$

Then this inequality is also true for any $t \geq t_{0}$, substituting, if needed, $C$ by a large constant.

Hence,

$$
\begin{aligned}
& \left|\int_{t_{0}}^{T} \log (1+W(t)) d t\right| \leq C^{\prime} \int_{t_{0}}^{T}|s / 2 \pi e|^{\frac{1-\sigma}{2}} d t=C^{\prime}(2 \pi e)^{\frac{\sigma-1}{2}} \int_{1}^{T}\left(\sigma^{2}+t^{2}\right)^{\frac{1-\sigma}{4}} d t \\
& \leq C^{\prime} \sigma^{1+\frac{1-\sigma}{2}}(2 \pi e)^{\frac{\sigma-1}{2}} \int_{1 / \sigma}^{T / \sigma}\left(1+u^{2}\right)^{\frac{1-\sigma}{4}} d u \leq C^{\prime} \sigma\left(\frac{2 \pi e}{\sigma}\right)^{\frac{\sigma-1}{2}} \int_{0}^{\infty}\left(1+u^{2}\right)^{\frac{1-\sigma}{4}} d u
\end{aligned}
$$

Elementary computations and Euler-MacLaurin approximation to the Gamma function yields for $\sigma>3$

$$
=C^{\prime} \sigma\left(\frac{2 \pi e}{\sigma}\right)^{\frac{\sigma-1}{2}} \frac{\sqrt{\pi} \Gamma\left(\frac{\sigma-3}{4}\right)}{2 \Gamma\left(\frac{\sigma-1}{4}\right)} \leq C^{\prime \prime} \frac{\sigma^{3 / 2}}{\sigma-3}\left(\frac{2 \pi e}{\sigma}\right)^{\frac{\sigma-1}{2}}
$$

We end noticing that for $\sigma>\sigma_{0}>3$, there is a constant $C$ only depending on $\sigma_{0}$ such that

$$
2^{-\sigma}+\frac{\sigma^{3 / 2}}{\sigma-3}\left(\frac{2 \pi e}{\sigma}\right)^{\frac{\sigma-1}{2}} \leq C 2^{-\sigma}
$$

## 6. Proof of Theorem 1

We will use Littlewood and Backlund's lemmas, which we state as reference.
Lemma 14 (Littlewood). Let $f: \Omega \rightarrow \mathbf{C}$ be a holomorphic function, $R=[a, b] \times[c, d] \subset \Omega$ a closed rectangle contained in $\Omega$, let us denote by $A=a+i c, B=b+i c, C=b+i d$,
and $D=a+i d$ its vertices. Assume that $f$ do not vanish on the sides $A B, B C$ and $C D$. Define $\arg f(z)$ continuously along this three sides then

$$
\begin{align*}
2 \pi \sum_{\substack{\beta \geq a \\
c<\gamma \leq d}}(\beta-a) & =\int_{c}^{d} \log |f(a+i y)| d y-\int_{c}^{d} \log |f(b+i y)| d y  \tag{13}\\
& -\int_{a}^{b} \arg f(x+i c) d x+\int_{a}^{b} \arg f(x+i d) d x
\end{align*}
$$

where $\rho=\beta+i \gamma$ run through the zeros of $f(z)$ in the rectangle counted with multiplicities.
Lemma 15 (Backlund). Let $f$ be holomorphic in the disc $|z-a| \leq R$. Let $|f(z)| \leq M$ for $|z-a| \leq R$. Let $b$ be a point in the interior of the disc $0<|b-a|<R$. Assume that $f$ does not vanish on the segment $[a, b]$, then

$$
\begin{equation*}
\left|\operatorname{Re} \frac{1}{2 \pi i} \int_{a}^{b} \frac{f^{\prime}(z)}{f(z)} d z\right| \leq \frac{1}{2}\left(\log \frac{M}{|f(a)|}\right)\left(\log \frac{R}{|b-a|}\right)^{-1} . \tag{14}
\end{equation*}
$$

Remark 16. Littlewood's lemma can be found in many sources, for example [19, section 9.9] or the original [13]. Backlund's lemma is applied without explicit mention in Backlund [11]. When stated, an extra term $1 / 2$ is frequently added on the right side. It is proved by means of the Jensen formula [16, section 15.16]. An independent complete proof is given in [9].

Proof of Theorem 1. The truth of (1) does not depend on the particular value of $t_{0}$. Changing $t_{0}$ to some other value changes the left-hand side of (1) into a constant that is absorbed into the error term. So we can assume that $\mathcal{R}(s) \neq 0$ for $\operatorname{Im}(s)=t_{0}$, and that $t_{0}>32 \pi$.

We can also assume that $\mathcal{R}(s) \neq 0$ for $\operatorname{Im}(s)=T$. In the other case, we may prove the proposition for $T_{n}>T$ with $\lim _{n} T_{n}=T$, and obtain the proposition in the general case by taking the limits of the resulting equation for $n \rightarrow \infty$.

For $\operatorname{Re}(s)=4$ and $t \geq 32 \pi$ we have $|\mathcal{R}(s)-1|<\frac{1}{2}$ by Proposition 6 in [6]. Therefore, $\mathcal{R}(4+i t)$ do not vanish for $t \geq 32 \pi$, and we are in a condition to apply Littlewood's lemma to $\mathcal{R}(s)$ in the rectangle $[\sigma, 4] \times\left[t_{0}, T\right]$.
This yields

$$
\begin{aligned}
2 \pi \sum_{\substack{\beta>\sigma \\
t_{0}<\gamma \leq T}}(\beta-\sigma) & =\int_{t_{0}}^{T} \log |\mathcal{R}(\sigma+i t)| d t-\int_{t_{0}}^{T} \log |\mathcal{R}(4+i t)| d t \\
& -\int_{\sigma}^{4} \arg \mathcal{R}\left(x+i t_{0}\right) d x+\int_{\sigma}^{4} \arg \mathcal{R}(x+i T) d x
\end{aligned}
$$

where $\arg \mathcal{R}\left(x+i t_{0}\right)$ and $\arg \mathcal{R}(x+i T)$ are continuous extensions of $\arg \mathcal{R}(4+i t)$. Since $|\mathcal{R}(4+i t)-1|<1 / 2$, we may take $\arg \mathcal{R}(4+i t)$ continuous and with absolute value $<\pi / 2$.

On the upper side $\operatorname{Im}(s)=T$ we have

$$
\arg \mathcal{R}(x+i T)-\arg \mathcal{R}(4+i T)=\operatorname{Re} \frac{1}{i} \int_{4+i T}^{x+i T} \frac{\mathcal{R}^{\prime}(z)}{\mathcal{R}(z)} d z
$$

The absolute value of this integral can be bounded as usual with Backlund's lemma 15. Let $D$ be the disc with center at $4+i T$ and radius $2(4-\sigma)$. The maximum of
$|\mathcal{R}(s)|$ on this disc is determined by Propositions 12 and 13 in [3], it is $\leq C_{\sigma} T^{r}$ where $r=\max (1 / 2,3 / 2-\sigma)$. Since we assume $\sigma \leq 1$, we have $r \leq 3 / 2-\sigma$. [In this argument $\sigma$ is fixed and we assume $T>1-\sigma$, for example]. Note also that $|\mathcal{R}(4+i T)|>1 / 2$. It follows that $|\arg \mathcal{R}(x+i T)| \leq C_{\sigma}^{\prime} \log T$ so that

$$
\left|\int_{\sigma}^{4} \arg \mathcal{R}(x+i T) d x\right| \leq C_{\sigma}^{\prime \prime} \log T .
$$

The integral of $\arg \mathcal{R}\left(x+i t_{0}\right)$ is a constant, depending on $\sigma$.
By proposition 13 the integral of $\mathcal{R}(4+i t)$ is bounded by an absolute constant. Joining all this, Littlewood's lemma yields (1)

## 7. Proof of Theorem 2



Figure 1. x-ray of $F(s)=s \pi^{-s / 2} \Gamma(s / 2) \mathcal{R}(s)$ on $(-105,105)^{2}$
To prove Theorem 2 Siegel [17] consider a function

$$
g(s)=\pi^{-\frac{s+1}{2}} e^{-\frac{\pi i s}{4}} \Gamma\left(\frac{s+1}{2}\right) \mathcal{R}(s) .
$$

The election of the factor of $\mathcal{R}(s)$ is to make the behavior of $g\left(\sigma_{0}+i t\right)$ the simplest possible, for our election of $\sigma_{0}$. Here $\sigma_{0}$ is selected so that all zeros to height $T$ of $\mathcal{R}(s)$ satisfies $\operatorname{Re}(\rho)>\sigma_{0}$. Nevertheless, this election makes $g$ meromorphic with poles at $-(2 n+1)$. This is a problem to apply Littlewood's lemma. Therefore, we prefer to instead consider the entire function

$$
\begin{equation*}
F(s)=s \pi^{-s / 2} \Gamma\left(\frac{s}{2}\right) \mathcal{R}(s) \tag{15}
\end{equation*}
$$

Remark 17. The x-ray of Siegel's function $g(s)$ is very nice.


Figure 2. x-ray of $g(s)=\pi^{-\frac{s+1}{2}} e^{-\frac{\pi i s}{4}} \Gamma\left(\frac{s+1}{2}\right) \mathcal{R}(s)$ on $(-105,105)^{2}$
Since it has poles at $-1,-3, \ldots$ and zeros at $-2,-4, \ldots$ the x-rays contains cycles. We can see their delicate game in the attached detail figure.


Figure 3. xray of $g(s)$ details

Notation: In this section, we will consider the values of $\mathcal{R}(s)$ at the points $s=\sigma+i t$ with $\sigma \leq 10$ and $t \geq 0$. For such values of $s$, we consider $\eta=\sqrt{\frac{s-1}{2 \pi i}}$, selecting the root $\eta=\eta_{1}+i \eta_{2}$ with $\eta_{1}+\eta_{2} \geq 0$. When $\sigma \leq 1$ this means $0 \leq \eta_{2} \leq \eta_{1}$. In this case $\left|e^{2 \pi i \eta}\right| \leq 1$, with strict inequality for $\sigma<1$.

We want a value of $\sigma$ such that all zeros of $\mathcal{R}(s)$ to height $T$ satisfies $\sigma \leq \operatorname{Re}(\rho)$. This is obtained by means of the next Theorem proved in [7, Th. 9].

Theorem 18. There exist constants $A$ and $t_{0}>1$ such that for $s$ in the closed set

$$
\Omega=\left\{s \in \mathbf{C}: t \geq t_{0}, \quad 1-\sigma \geq t^{3 / 7}\right\}
$$

we have

$$
\begin{equation*}
\mathcal{R}(s)=-\chi(s) \eta^{s-1} e^{-\pi i \eta^{2}} \frac{\sqrt{2} e^{3 \pi i / 8} \sin \pi \eta}{2 \cos 2 \pi \eta}(1+U(s)), \quad|U(s)| \leq A t^{-\frac{1}{21}} \tag{16}
\end{equation*}
$$

where $\eta=\sqrt{(s-1) / 2 \pi i}$ satisfies $\operatorname{Re}(\eta)+\operatorname{Im}(\eta)>0$.
Lemma 19. Let $t_{0}$ be a constant greater than the constant appearing in Theorem 18. For $s=\sigma+$ it with $t \geq t_{0}$ and $1-\sigma \geq t^{3 / 7}$, we have

$$
F(s):=s \pi^{-s / 2} \Gamma(s / 2) \mathcal{R}(s)=J(s)(1+U(s)),
$$

where

$$
\begin{equation*}
\log J(s)=\frac{\pi i s}{4}+\log s-\frac{1}{2} \log \frac{1-s}{2 \pi}-\frac{3 \pi i}{8}+\pi i \eta+\log \frac{1-e^{2 \pi i \eta}}{1+e^{4 \pi i \eta}}+\boldsymbol{\mathcal { O }}\left(|s|^{-1}\right) \tag{17}
\end{equation*}
$$

Proof. Since we assume that $s$ satisfies the conditions in Theorem 18 we have (16). Therefore, by definition, $F(s)=J(s)(1+U(s))$, where

$$
\begin{aligned}
J(s) & =-s \pi^{-s / 2} \Gamma(s / 2) \chi(s) \eta^{s-1} e^{-\pi i \eta^{2}} \frac{\sqrt{2} e^{3 \pi i / 8} \sin \pi \eta}{2 \cos 2 \pi \eta} \\
& =-s \pi^{(s-1) / 2} \Gamma\left(\frac{1-s}{2}\right) \eta^{s-1} e^{-\pi i \eta^{2}} \frac{\sqrt{2} e^{3 \pi i / 8} \sin \pi \eta}{2 \cos 2 \pi \eta} \\
& =2^{-1 / 2} e^{-\pi i / 8} s \pi^{(s-1) / 2} \Gamma\left(\frac{1-s}{2}\right) \eta^{s-1} e^{-\pi i \eta^{2}+\pi i \eta} \frac{1-e^{2 \pi i \eta}}{1+e^{4 \pi i \eta}} .
\end{aligned}
$$

We may define a continuous logarithm of $J(s)$ for these values of $s$ by noticing that $\left|e^{2 \pi i \eta}\right|<1$ and therefore we may use

$$
\log \frac{1-e^{2 \pi i \eta}}{1+e^{4 \pi i \eta}}=-\sum_{n=1}^{\infty} \frac{z^{n}}{n}+\sum_{n=1}^{\infty}(-1)^{n} \frac{z^{2 n}}{n}, \quad z=e^{2 \pi i \eta}
$$

That is, it is equal to $\log \left(1-e^{2 \pi i \eta}\right)-\log \left(1+e^{4 \pi i \eta}\right)$, using in both cases the main branch of the logarithm. It follows that the imaginary part of $\log \frac{1-e^{2 \pi i \eta}}{1+e^{4 \pi i \eta}}$ is bounded by $\pi$. By the usual Euler-MacLaurin expansion, which is applicable since $\sigma<0$,

$$
\begin{aligned}
\log J(s)=-\frac{1}{2} \log 2- & \frac{\pi i}{8}+\log s+\frac{s-1}{2} \log \pi-\frac{s}{2} \log \frac{1-s}{2}-\frac{1-s}{2}+\frac{1}{2} \log 2 \pi \\
& +\frac{s-1}{2} \log \frac{s-1}{2 \pi i}-\pi i \frac{s-1}{2 \pi i}+\pi i \eta+\log \frac{1-e^{2 \pi i \eta}}{1+e^{4 \pi i \eta}}+\boldsymbol{\mathcal { O }}\left(|s|^{-1}\right)
\end{aligned}
$$

Simplifying this yields

$$
\log J(s)=\frac{\pi i s}{4}+\log s-\frac{1}{2} \log (1-s)+\frac{1}{2} \log 2 \pi-\frac{3 \pi i}{8}+\pi i \eta+\log \frac{1-e^{2 \pi i \eta}}{1+e^{4 \pi i \eta}}+\boldsymbol{\mathcal { O }}\left(|s|^{-1}\right)
$$

The next propositions will be proved later in Section 8.
Proposition 20. Let $t_{0}>1$ and $0<a<\frac{1}{2}$ be fixed real numbers. There is a function $f:[0,+\infty) \rightarrow[0,+\infty)$ such that $f(T)=\boldsymbol{o}\left(T^{1 / 2}\right)$ and such that for $T>t_{0}, \sigma \leq 10$ and $1-\sigma \leq T^{a}$ we have

$$
\begin{align*}
\int_{t_{0}}^{T} \log |F(\sigma+i t)| d t & =-\frac{\pi T^{2}}{8}+(\sigma+1)\left(\frac{T}{2} \log \frac{T}{2 \pi}-\frac{T}{2}\right)+\frac{T}{2}(\log 2+2 \log (2 \pi))  \tag{18}\\
& -\frac{\pi \sigma^{2}}{8}+\int_{t_{0}}^{T} \log |\mathcal{R}(\sigma+i t)| d t+\boldsymbol{\mathcal { O }}(f(T))
\end{align*}
$$

Proposition 21. Let $1 \leq t_{0}<T$ with $t_{0}$ bigger than the constant appearing in Theorem 18 and let $1-\sigma_{0}=T^{a}$ with $a=3 / 7$. Then we have

$$
\begin{equation*}
\int_{t_{0}}^{T} \log \left|F\left(\sigma_{0}+i t\right)\right| d t=-\frac{\pi T^{2}}{8}+\frac{T}{2} \log T-\frac{T}{2}+\frac{T}{2} \log 2 \pi+\boldsymbol{\mathcal { O }}\left(T^{20 / 21}\right) \tag{19}
\end{equation*}
$$

Lemma 22. Let $t_{0}$ and $\sigma_{0}$ be fixed real numbers satisfying $t_{0}>1$ and $\sigma_{0}<-1$. Assume that $F(s)$ does not vanish for $\operatorname{Im}(s)=t_{0}$ and denote by $\arg F\left(\sigma+i t_{0}\right)$ a continuous determination of the argument, defined for $\sigma_{0} \leq \sigma \leq \sigma_{1} \leq 10$, and such that $\mid \arg F\left(\sigma_{0}+\right.$ $\left.i t_{0}\right)|\leq C| \sigma_{0} \mid$. Then there is a constant $C_{0}$ (depending on $t_{0}$, and $C$ such that

$$
\left|\int_{\sigma_{0}}^{\sigma_{1}} \arg F\left(\sigma+i t_{0}\right) d \sigma\right| \leq C_{0}\left|\sigma_{0}\right|^{2} \log \left|\sigma_{0}\right| .
$$

Proof. We have

$$
\left|\arg F\left(\sigma+i t_{0}\right)-\arg F\left(\sigma_{0}+i t_{0}\right)\right|=\left|\operatorname{Re} \frac{1}{i} \int_{\sigma_{0}+i t_{0}}^{\sigma+i t_{0}} \frac{F^{\prime}(z)}{F(z)} d z\right|
$$

we may bound the integral by Backlund's lemma. We take a disc $D$ with center at $10+i t_{0}$ and radius $2\left(10-\sigma_{0}\right)$. To bound $F$ on $D$, notice that $D$ is contained in a disc of center 0 and radius $C\left|\sigma_{0}\right|$ (where the constant $C$ here depends only on $t_{0}$ ). In [10, eq.(3)] we have proved that $|F(s)| \leq A e^{B|s| \log |s|}$. So that $|F(s)| \leq A e^{c\left(t_{0}\right)\left|\sigma_{0}\right| \log \left|\sigma_{0}\right|}$. Also, we have $\left|F\left(10+i t_{0}\right)\right|>0$ is a constant depending only on $t_{0}$. Therefore,

$$
\left|\arg F\left(\sigma+i t_{0}\right)-\arg F\left(\sigma_{0}+i t_{0}\right)\right| \leq C\left|\sigma_{0}\right| \log \left|\sigma_{0}\right|
$$

It follows that $\left|F\left(\sigma+i t_{0}\right)\right| \leq C\left|\sigma_{0}\right| \log \left|\sigma_{0}\right|$. Then

$$
\left|\int_{\sigma_{0}}^{\sigma_{1}} \arg F\left(\sigma+i t_{0}\right) d \sigma\right| \leq C\left|\sigma_{0}\right|^{2} \log \left|\sigma_{0}\right|
$$

Lemma 23. Let $0<a<\frac{1}{2}$ a fixed real number and for $T>1$ let $1-\sigma_{0}=T^{a}$ and $\sigma_{0}<\sigma_{1} \leq 10$. Then we have

$$
\operatorname{Im} \int_{\sigma_{0}+i T}^{\sigma_{1}+i T} \log \left(s \pi^{-s / 2} \Gamma(s / 2)\right) d s=\boldsymbol{\mathcal { O }}\left(T^{2 a}\right)
$$

when we take a continuous branch of the logarithm where $\operatorname{Im} \log \left(s \pi^{-s / 2} \Gamma(s / 2)\right)$ at the point $s=s_{0}+i T$ is $\boldsymbol{\mathcal { O }}\left(T^{a}\right)$.

Proof. By Euler-MacLaurin expansion we have

$$
\operatorname{Im} \log \Gamma((\sigma+i T) / 2)=\frac{T}{2} \log \frac{T}{2}-\frac{T}{2}+\frac{\pi}{4}(\sigma-1)+\frac{2 \sigma-\sigma^{2}}{4 T}+\boldsymbol{\mathcal { O }}\left(T^{-1}\right)
$$

For $\sigma_{0} \leq \sigma \leq \sigma_{1} \leq 10$ we have $\sigma^{2} / T^{2}=\boldsymbol{\mathcal { O }}\left(T^{-1}\right)$ so that

$$
\operatorname{Im} \log (\sigma+i T)=\frac{\pi}{2}-\arctan \frac{\sigma}{T}=\frac{\pi}{2}-\frac{\sigma}{T}+\boldsymbol{\mathcal { O }}\left(T^{-1}\right)
$$

After some simplifications, we obtain for $s=\sigma+i T$

$$
\operatorname{Im} \log \left(s \pi^{-s / 2} \Gamma(s / 2)\right)=\frac{T}{2} \log \frac{T}{2 \pi}-\frac{T}{2}-\frac{\sigma^{2}+2 \sigma}{4 T}+\frac{\pi}{4}+\frac{\pi \sigma}{4}+\boldsymbol{\mathcal { O }}\left(T^{-1}\right)
$$

After subtracting the multiple of $2 \pi$ nearest to $\frac{T}{2} \log \frac{T}{2 \pi}-\frac{T}{2}$, we get a branch of the logarithm equal to

$$
\operatorname{Im} \log \left(s \pi^{-s / 2} \Gamma(s / 2)\right)=-\frac{\sigma^{2}+\sigma}{2 T}+\frac{\pi}{4}+\frac{\pi \sigma}{4}+\boldsymbol{\mathcal { O }}(1)=\frac{\pi \sigma}{4}+\boldsymbol{\mathcal { O }}(1)
$$

Therefore,

$$
\left|\operatorname{Im} \int_{\sigma_{0}+i T}^{\sigma_{1}+i T} \log \left(s \pi^{-s / 2} \Gamma(s / 2)\right) d s\right| \leq \frac{\pi}{8}\left(\sigma_{1}^{2}-\sigma_{0}^{2}\right)+C\left(\sigma_{1}-\sigma_{0}\right) \leq C T^{2 a}
$$

Proof of Theorem 2. For a given $T>t_{0}$ define $\sigma_{0}$ such that $1-\sigma_{0}=T^{a}$ with $a=3 / 7$. For $T \geq T_{0}$ we will have $\sigma_{0}<\sigma$. We apply Littlewood's lemma in the rectangle $R=$ $\left[\sigma_{0}, \sigma\right] \times\left[t_{0}, T\right]$ to the function $F(s)=s \pi^{-s / 2} \Gamma(s / 2) \mathcal{R}(s)$. As we have seen in the proof of Theorem 1 we may assume that there is no zero of $F(s)$ on the lines $\operatorname{Re}(s)=t_{0}$ and $\operatorname{Re}(s)=T$. We take $t_{0}$ large enough so that Theorem 18 applies with $A t_{0}^{-1 / 21}<1$. This implies that $F(s)$ do not vanish on the left-hand side of the rectangle $R$. Note that the zeros of $F(s)$ and $\mathcal{R}(s)$ on $t>0$ are the same with the same multiplicities.

Here, it is in line $\operatorname{Re}(s)=\sigma$ where we do not know the argument of $F(s)$. Hence we have

$$
\begin{align*}
2 \pi \sum_{\substack{\beta<\sigma \\
t_{0}<\gamma \leq T}}(\sigma-\beta) & =\int_{t_{0}}^{T} \log |F(\sigma+i t)| d t-\int_{t_{0}}^{T} \log \left|F\left(\sigma_{0}+i t\right)\right| d t  \tag{20}\\
& +\int_{\sigma_{0}}^{\sigma} \arg F\left(x+i t_{0}\right) d x-\int_{\sigma_{0}}^{\sigma} \arg F(x+i T) d x
\end{align*}
$$

where $\arg F(s)$ should be taken continuously in the broken line with vertices at $\sigma+i t_{0}$, $\sigma_{0}+i t_{0}, \sigma_{0}+i T, \sigma+i T$.

By Lemma 19 we have $\arg F(s)=\arg J(s)+\arg (1+U(s))$, with $s=\sigma_{0}+i t$. By the election of $\sigma_{0}$, the function $\arg \left(1+U\left(\sigma_{0}+i t\right)\right)$ for $t_{0} \leq t \leq T$ is always between $-\pi / 2$ and $\pi / 2$. By (17) we easily see that $\arg F(\sigma+i t)$ for $1-\sigma \geq t^{a}, t \geq t_{0}$ is equal to

$$
\begin{aligned}
\arg F(\sigma+i t)=\frac{\pi \sigma}{4}+\frac{\pi}{2}-\arctan & \frac{\sigma}{t}
\end{aligned}+\frac{1}{2}\left(\frac{\pi}{2}-\arctan \frac{1-\sigma}{t}\right)-\frac{3 \pi}{8} .
$$

Since $1-\sigma_{0}=T^{a}$ it follows that $\arg F\left(\sigma_{0}+i t\right)$ varies continuously between the extreme values

$$
\arg F\left(\sigma_{0}+i T\right)=\pi \sqrt{\frac{T}{2 \pi}}+\boldsymbol{\mathcal { O }}\left(T^{a}\right) \quad \arg F\left(\sigma_{0}+i t_{0}\right)=\frac{\pi \sigma_{0}}{4}+\boldsymbol{\mathcal { O }}\left(T^{a / 2}\right)
$$

Therefore, $\arg F\left(\sigma_{0}+i t_{0}\right)=\boldsymbol{\mathcal { O }}\left(T^{a}\right)$ and the lemma 22 apply to show that

$$
\begin{equation*}
\int_{\sigma_{0}}^{\sigma} \arg F\left(x+i t_{0}\right) d x=\boldsymbol{\mathcal { O }}\left(T^{2 a} \log T\right) \tag{21}
\end{equation*}
$$

On the upper side for $s=x+i T$ with $\sigma_{0} \leq x \leq \sigma$ we have

$$
\arg F(s)=\arg \left(s \pi^{-s / 2} \Gamma(s / 2)\right)+\arg \mathcal{R}(s)
$$

where the arguments on the right-hand side should be taken continuous and such that at the point $s_{0}=\sigma_{0}+i T$ we have

$$
\arg \left(s_{0} \pi^{-s_{0} / 2} \Gamma\left(s_{0} / 2\right)\right)+\arg \mathcal{R}\left(s_{0}\right)=\arg F\left(s_{0}\right)=\pi \sqrt{T / 2 \pi}+\boldsymbol{\mathcal { O }}\left(T^{a}\right)
$$

We have some freedom here; we may pick $\arg \left(s_{0} \pi^{-s_{0} / 2} \Gamma\left(s_{0} / 2\right)\right)=\boldsymbol{\mathcal { O }}\left(T^{a}\right)$ so that Lemma 23 applies, and

$$
\begin{equation*}
\int_{\sigma_{0}+i T}^{\sigma+i T} \arg \left(s \pi^{-s / 2} \Gamma(s / 2)\right) d s=\boldsymbol{\mathcal { O }}\left(T^{2 a}\right) \tag{22}
\end{equation*}
$$

Then we must take $\arg \mathcal{R}\left(s_{0}\right)=\boldsymbol{\mathcal { O }}\left(T^{1 / 2}\right)$. We apply the Backlund lemma to bound the integral of $\arg \mathcal{R}(x+i T)$. We have

$$
\left|\arg \mathcal{R}(x+i T)-\arg \mathcal{R}\left(\sigma_{0}+i T\right)\right|=\left|\operatorname{Re} \frac{1}{i} \int_{\sigma_{0}+i T}^{x+i T} \frac{\mathcal{R}^{\prime}(z)}{\mathcal{R}(z)} d z\right|
$$

To determine the value of $\arg \mathcal{R}(x+i T)$, we apply Backlund's lemma. Take a disc with center at $10+i T$ and radius $R=2\left(10-\sigma_{0}\right)$. On this disc $|\mathcal{R}(s)|$ is bounded, according to Proposition 12 and 13 in [3] by

$$
\leq C \max \left(T^{1 / 2}, T^{c T^{a}}\right)
$$

The value in the center of the disc $|\mathcal{R}(10+i T)| \geq 1 / 2$ by by Proposition 6 in [6]. Hence, we get

$$
\left|\arg \mathcal{R}(x+i T)-\arg \mathcal{R}\left(\sigma_{0}+i T\right)\right| \leq C T^{a} \log T
$$

It follows that

$$
|\arg \mathcal{R}(x+i T)| \leq C T^{a} \log T+C T^{1 / 2} \leq C T^{1 / 2}
$$

From which we obtain

$$
\begin{equation*}
\int_{\sigma_{0}+i T}^{\sigma+i T} \arg \mathcal{R}(s) d s=C T^{1 / 2+a} \tag{23}
\end{equation*}
$$

Putting the results of Propositions 20, 21 and equations (21), (22) and (23) into equation (20) yields

$$
\begin{aligned}
2 \pi \sum_{\substack{\beta \leq \sigma \\
t_{0}<\gamma \leq T}}(\sigma-\beta) & =-\frac{\pi T^{2}}{8}+(\sigma+1)\left(\frac{T}{2} \log \frac{T}{2 \pi}-\frac{T}{2}\right)+\frac{T}{2}(\log 2+2 \log (2 \pi))-\frac{\pi \sigma^{2}}{8} \\
& +\int_{t_{0}}^{T} \log |\mathcal{R}(\sigma+i t)| d t+\boldsymbol{o}\left(T^{1 / 2}\right)+\frac{\pi T^{2}}{8}-\frac{T}{2} \log T+\frac{T}{2}-\frac{T}{2} \log 2 \pi \\
& +\boldsymbol{\mathcal { O } ( T ^ { 2 0 / 2 1 } ) + \boldsymbol { O } ( T ^ { 2 a } \operatorname { l o g } T ) + \boldsymbol { \mathcal { O } } ( T ^ { \frac { 1 } { 2 } + a } ) ,}
\end{aligned}
$$

Since $a=3 / 7$ the largest error term is $\mathcal{O}\left(T^{20 / 21}\right)$. The term with $\sigma^{2}$ is less than this error term. Simplifying yields (2).

Remark 24. We can not apply Backlund's lemma in order to bound the integral of $\arg g\left(x+i t_{0}\right)$ in Siegel's exposition [17]. To use $g(s)$ we also have the extra difficulty that the Euler-MacLaurin approximation to the gamma function is not valid near the negative real axis. This is the main reason to use our $F(s)$ function instead of the $g(s)$ function of Siegel.

## 8. Proof of Propositions 20 and 21

8.1. Mean value of $\log |\Gamma(s)|$. We denote by $B_{n}(x)$ the Bernoulli polynomial and by $\widetilde{B_{n}}(x)$ the periodic function with period 1 and such that $\widetilde{B_{n}}(x)=B_{n}(x)$ for $0<x<$ 1. They satisfy $B_{n}(x)=(-1)^{n} B_{n}(1-x)$. For an odd index greater than 1 we have $B_{2 n+1}(0)=B_{2 n+1}(1 / 2)=B_{2 n+1}(1)=0$, and these are the only zeros of $B_{2 n+1}(x)$ on the interval $[0,1]$.

Lemma 25. Let $f:(a, b) \rightarrow[0,+\infty)$ be a positive and monotonous function, then

$$
\left|\int_{a}^{b} f(x) \widetilde{B_{3}}(x) d x\right| \leq \frac{3}{64} \max (f(a), f(b)) .
$$

Proof. Assume that $f$ is not increasing, the proof in the other case is similar. We have $B_{3}(x)=x\left(x-\frac{1}{2}\right)(x-1)$, so $B_{3}(x)$ is positive in $(0,1 / 2)$ and negative in $(1 / 2,1)$. Define

$$
a_{n}=\left|\int_{n / 2}^{(n+1) / 2} f(x) \widetilde{B_{3}}(x) d x\right|=(-1)^{n} \int_{n / 2}^{(n+1) / 2} f(x) \widetilde{B_{3}}(x) d x .
$$

For any integer $k$, since $f(x+k) \geq f(1-x+k)$ for $0<x<\frac{1}{2}$
$a_{2 k}=\int_{k}^{k+1 / 2} f(x) \widetilde{B_{3}}(x) d x=\int_{0}^{1 / 2} f(x+k) \widetilde{B_{3}}(x) d x \geq \int_{0}^{1 / 2} f(1-x+k) x\left(x-\frac{1}{2}\right)(x-1) d x$ changing variables $y=1-x$

$$
\begin{aligned}
& =\int_{1 / 2}^{1} f(y+k)(1-y)\left(\frac{1}{2}-y\right)(-y) d y=-\int_{1 / 2}^{1} f(y+k) \widetilde{B_{3}}(y) d y= \\
& \quad-\int_{k+1 / 2}^{k+1} f(y) \widetilde{B_{3}}(y) d y=a_{2 k+1} .
\end{aligned}
$$

In the same way, we prove $a_{2 k+1} \geq a_{2 k+2}$.
Suppose first that there exist $n<m$ such that

$$
(n-1) / 2<a \leq n / 2 \leq m / 2 \leq b<(m+1) / 2 .
$$

If $n<m$ we will have

$$
\int_{a}^{b}=\int_{a}^{n / 2}+\int_{n / 2}^{m / 2}+\int_{m / 2}^{b}=\int_{a}^{n / 2}+\sum_{n \leq k<m}(-1)^{k} a_{k}+\int_{m / 2}^{b}
$$

the omitted integrand being $f(x) \widetilde{B_{3}}(x)$, and with $a_{n} \geq a_{n+1} \geq \cdots \geq a_{m} \geq 0$. Therefore, we have

$$
\left|\sum_{n \leq k<m}(-1)^{k} a_{k}\right|=a_{n}-a_{n+1}+a_{n+2}-\cdots \pm a_{m-1} \leq a_{n}
$$

Therefore,

$$
\left|\int_{a}^{b}\right| \leq\left|\int_{a}^{n / 2}\right|+a_{n}+\left|\int_{m / 2}^{b}\right| \leq 3 \int_{(n-1) / 2}^{n / 2} f(a)\left|\widetilde{B_{3}}(x)\right| d x=\frac{3 f(a)}{64} .
$$

When $n=m$ or there is no fraction $n / 2$ between $a$ and $b$, the inequality is easier to prove. If we assume that $f$ is increasing, we must substitute $f(a)$ by $f(b)$. So, in general, the inequality is true with the maximum between $f(a)$ and $f(b)$.
With the same procedure, we may prove this Proposition.
Proposition 26. Let $f:(a, b) \rightarrow[0,+\infty)$ be a positive and monotonous function, then for all $n \geq 0$

$$
\left|\int_{a}^{b} f(x) \widetilde{B_{2 n+1}}(x) d x\right| \leq(-1)^{n} 3\left(1-\frac{1}{2^{2 n+2}}\right) \frac{B_{2 n+2}}{n+1} \max (f(a), f(b)) .
$$

Proposition 27. For $\sigma \in \mathbf{R}$ and $T>1$ we have

$$
\begin{equation*}
\int_{1}^{T} \log \left|\Gamma\left(\frac{\sigma+i t}{2}\right)\right| d t=\operatorname{Im} \int_{\sigma+i}^{\sigma+i T}\left(\left(\frac{s-1}{2}\right) \log \frac{s}{2}-\frac{s}{2}+\frac{1}{2} \log 2 \pi+\frac{1}{6 s}\right) d s+\mathcal{O}^{*}\left(\frac{3 \sqrt{3}}{16}\right) \tag{24}
\end{equation*}
$$

Proof. Since $\sigma$ and $T>0$ are arbitrary, we cannot directly use the Euler-MacLaurin expansion. Instead, we use an intermediate expression obtained in the course of the proof of the Euler-MacLaurin expansion [12, p. 109]. We have

$$
\log \Gamma(s)=\left(s-\frac{1}{2}\right) \log s-s+\frac{1}{2} \log 2 \pi+\frac{B_{2}}{2 s}-\int_{0}^{\infty} \frac{\widetilde{B}_{3}(x) d x}{3(s+x)^{3}}, \quad s+|s| \neq 0
$$

Since

$$
\int_{1}^{T} \log \left|\Gamma\left(\frac{\sigma+i t}{2}\right)\right| d t=\operatorname{Im} \int_{\sigma+i}^{\sigma+i T} \log \Gamma\left(\frac{s}{2}\right) d s
$$

we proceed to bound

$$
R:=\operatorname{Im} \int_{\sigma+i}^{\sigma+i T} \int_{0}^{\infty} \frac{\widetilde{B}_{3}(x) d x}{3(s / 2+x)^{3}} d s
$$

The integral converge absolutely, so we may apply Fubini's Theorem. And we have

$$
\begin{aligned}
R & =\operatorname{Im} \int_{0}^{\infty} \widetilde{B}_{3}(x)\left(\int_{\sigma+i}^{\sigma+i T} \frac{d s}{3(s / 2+x)^{3}}\right) d x \\
& =\operatorname{Im} \frac{4}{3} \int_{0}^{\infty} \widetilde{B}_{3}(x)\left(\frac{1}{(\sigma+i+2 x)^{2}}-\frac{1}{(\sigma+i T+2 x)^{2}}\right) d x \\
& =\frac{4}{3} \int_{0}^{\infty} \widetilde{B}_{3}(x)\left(-\frac{2(\sigma+2 x)}{\left((\sigma+2 x)^{2}+1\right)^{2}}+\frac{2 T(\sigma+2 x)}{\left((\sigma+2 x)^{2}+T^{2}\right)^{2}}\right) d x
\end{aligned}
$$

Note that $\sigma \in \mathbf{R}$ may be negative. The function $\frac{2 T y}{\left(y^{2}+T^{2}\right)^{2}}$ is negative and decreases in $(-\infty,-T / \sqrt{3})$, negative and increases in $(-T / \sqrt{3}, 0)$, positive and increasing in $(0, T / \sqrt{3})$ and decreasing and positive in $(T / \sqrt{3},+\infty)$ Its maximum value is achieved at $y=T / \sqrt{3}$ when it takes the value $\frac{3 \sqrt{3}}{8 T^{2}}$. At $-T / \sqrt{3}$ it has a minimum value of $-\frac{3 \sqrt{3}}{8 T^{2}}$. Hence, we may separate the integral into at most four integrals where Lemma 25 applies and

$$
\left|\frac{4}{3} \int_{0}^{\infty} \frac{2 T(\sigma+2 x) \widetilde{B}_{3}(x)}{\left((\sigma+2 x)^{2}+T^{2}\right)^{2}} d x\right| \leq \frac{4}{3} \cdot 4 \cdot \frac{3}{64} \cdot \frac{3 \sqrt{3}}{8 T^{2}}=\frac{3 \sqrt{3}}{32 T^{2}}
$$

This is also valid for $T=1$, so we get $|R| \leq \frac{3 \sqrt{3}}{16}$.
Then

$$
\int_{1}^{T} \log \left|\Gamma\left(\frac{\sigma+i t}{2}\right)\right| d t=\operatorname{Im} \int_{\sigma+i}^{\sigma+i T}\left(\left(\frac{s-1}{2}\right) \log \frac{s}{2}-\frac{s}{2}+\frac{1}{2} \log 2 \pi+\frac{1}{6 s}\right) d s+\mathcal{O}^{*}\left(\frac{3 \sqrt{3}}{16}\right)
$$

The same is true if we take the lower limit of the integrals equal to $t_{0} \geq 1$.
A computation of this integral gives us

$$
\begin{align*}
& \int_{t_{0}}^{T} \log \left|\Gamma\left(\frac{\sigma+i t}{2}\right)\right| d t=\left(-\frac{T^{2}}{4}+\frac{\sigma^{2}}{4}-\frac{\sigma}{2}+\frac{1}{6}\right) \arg (\sigma+i T) \\
& \quad+\left(\frac{\sigma T}{4}-\frac{T}{4}\right) \log \left(\sigma^{2}+T^{2}\right)-\sigma\left(\frac{3 T}{4}+\frac{T \log 2}{2}\right)+\frac{T}{2}+\frac{T}{2} \log 2+\frac{T}{2} \log 2 \pi  \tag{25}\\
& \quad+\left(\frac{t_{0}^{2}}{4}-\frac{\sigma^{2}}{4}+\frac{\sigma}{2}-\frac{1}{6}\right) \arg \left(\sigma+i t_{0}\right)+\left(\frac{t_{0}}{4}-\frac{\sigma t_{0}}{4}\right) \log \left(\sigma^{2}+t_{0}^{2}\right)+ \\
& \quad+\sigma\left(\frac{3 t_{0}}{4}+\frac{t_{0} \log 2}{2}\right)-\frac{t_{0}}{2}-\frac{t_{0}}{2} \log 2-\frac{t_{0}}{2} \log 2 \pi+\mathcal{O}^{*}(3 \sqrt{3} / 16)
\end{align*}
$$

where the argument always refers to the main argument, since $t_{0}$ and $T>0$ for us $0<\arg (\sigma+i t)<\pi$.
Proposition 28. Let $t_{0} \geq 1$ and $0<a<\frac{1}{2}$ be fixed real numbers. There is a positive function $f:[0,+\infty) \rightarrow[0,+\infty)$ such that $f(T)=\boldsymbol{o}\left(T^{1 / 2}\right)$ and such that given real numbers $\sigma \leq 10$ and $T>t_{0}$, connected by $1-\sigma \leq T^{a}$, then

$$
\begin{align*}
\int_{t_{0}}^{T} \log \left|\Gamma\left(\frac{\sigma+i t}{2}\right)\right| d t & =-\frac{\pi T^{2}}{8}+(\sigma-1)\left(\frac{T}{2} \log \frac{T}{2}-\frac{T}{2}\right)+\frac{T}{2} \log (2 \pi)-\frac{\pi \sigma^{2}}{8}  \tag{26}\\
& +\boldsymbol{\mathcal { O }}(f(T))
\end{align*}
$$

Proof. The value of the integral is given in (25). Assume first that $-2 t_{0}<\sigma \leq 10$. In this case, many terms in (25) are bounded by a constant only depending on $t_{0}$. Eliminating these terms, we get

$$
\begin{aligned}
& \int_{t_{0}}^{T} \log \left|\Gamma\left(\frac{\sigma+i t}{2}\right)\right| d t=-\frac{T^{2}}{4} \arg (\sigma+i T)+\left(\frac{\sigma T}{4}-\frac{T}{4}\right) \log \left(\sigma^{2}+T^{2}\right) \\
& \quad-\sigma\left(\frac{3 T}{4}+\frac{T \log 2}{2}\right)+\frac{T}{2}+\frac{T}{2} \log 2+\frac{T}{2} \log 2 \pi+\boldsymbol{O}\left(t_{0}^{2} \log \left(1+t_{0}\right)\right)
\end{aligned}
$$

We have $\arg (\sigma+i T)=\frac{\pi}{2}-\arctan \frac{\sigma}{T}$ and $\log \left(\sigma^{2}+T^{2}\right)=2 \log T+\log \left(1+\sigma^{2} / T^{2}\right)=$ $2 \log T+\mathcal{O}\left(T^{-2}\right)$. Expanding the arctan, we get (with constants only depending on $t_{0}$ )

$$
\begin{aligned}
\int_{t_{0}}^{T} \log \left|\Gamma\left(\frac{\sigma+i t}{2}\right)\right| d t & =-\frac{\pi T^{2}}{8}+\frac{T^{2}}{4}\left(\frac{\sigma}{T}+\boldsymbol{\mathcal { O }}\left(T^{-3}\right)\right)+\left(\frac{\sigma T}{4}-\frac{T}{4}\right)\left(2 \log T+\boldsymbol{\mathcal { O }}\left(T^{-2}\right)\right) \\
& -\sigma\left(\frac{3 T}{4}+\frac{T \log 2}{2}\right)+\frac{T}{2}+\frac{T}{2} \log 2+\frac{T}{2} \log 2 \pi+\boldsymbol{\mathcal { O }}(1)
\end{aligned}
$$

This is (26) except for the term $-\sigma^{2} / 8$, that in this case is contained in the error term.
In the other case, when $\sigma_{0} \leq \sigma \leq-2 t_{0}$, eliminating terms that are $\boldsymbol{o}\left(T^{a}\right)$ we get

$$
\begin{aligned}
& \int_{t_{0}}^{T} \log \left|\Gamma\left(\frac{\sigma+i t}{2}\right)\right| d t=\left(-\frac{T^{2}}{4}+\frac{\sigma^{2}}{4}\right) \arg (\sigma+i T)+\left(\frac{\sigma T}{4}-\frac{T}{4}\right) \log \left(\sigma^{2}+T^{2}\right) \\
& \quad-\sigma\left(\frac{3 T}{4}+\frac{T \log 2}{2}\right)+\frac{T}{2}+\frac{T}{2} \log 2+\frac{T}{2} \log 2 \pi-\frac{\sigma^{2}}{4} \arg \left(\sigma+i t_{0}\right)+\boldsymbol{o}\left(T^{1 / 2}\right)
\end{aligned}
$$

since $\sigma<0$ we have

$$
\begin{aligned}
\arg (\sigma+i T)=\frac{\pi}{2}-\arctan \frac{\sigma}{T}, & \arg \left(\sigma+i t_{0}\right)=\pi+\arctan \frac{t_{0}}{\sigma} \\
\log \left(\sigma^{2}+T^{2}\right)=2 \log T+\log \left(1+\sigma^{2} / T^{2}\right), & \log \left(\sigma^{2}+t_{0}^{2}\right)=2 \log |\sigma|+\log \left(1+t_{0}^{2} / \sigma^{2}\right)
\end{aligned}
$$

which we may expand in convergent power series since $\sigma / T$ and $t_{0} / \sigma$ are in absolute value $<1$. Removing terms less than $\boldsymbol{o}\left(T^{1 / 2}\right)$ yields (26).

### 8.2. Proof of Proposition 20.

Proof of Proposition 20. By the definition of $F$ we have

$$
\begin{aligned}
& \int_{t_{0}}^{T} \log |F(\sigma+i t)| d t=\int_{t_{0}}^{T} \log \left|(\sigma+i t) \pi^{-\sigma / 2}\right| d t+\int_{t_{0}}^{T} \log \left|\Gamma\left(\frac{\sigma+i t}{2}\right)\right| d t+\int_{t_{0}}^{T} \log |\mathcal{R}(\sigma+i t)| d t \\
& \int_{t_{0}}^{T} \log \left|(\sigma+i t) \pi^{-\sigma / 2}\right| d t=-\sigma \frac{T-t_{0}}{2} \log \pi+\frac{T}{2} \log \left(\sigma^{2}+T^{2}\right)-T+\sigma \arctan \frac{T}{\sigma} \\
&-\frac{t_{0}}{2} \log \left(\sigma^{2}+t_{0}^{2}\right)+t_{0}-\sigma \arctan \frac{t_{0}}{\sigma} .
\end{aligned}
$$

After some simplifications

$$
\int_{t_{0}}^{T} \log \left|(\sigma+i t) \pi^{-\sigma / 2}\right| d t=T \log T-T-\sigma \frac{T}{2} \log \pi+\boldsymbol{o}\left(T^{1 / 2}\right) .
$$

Combining this with (26) yields

$$
\begin{aligned}
\int_{t_{0}}^{T} \log |F(\sigma+i t)| d t & =-\frac{\pi T^{2}}{8}+(\sigma+1)\left(\frac{T}{2} \log \frac{T}{2 \pi}-\frac{T}{2}\right)+\frac{T}{2}(\log 2+2 \log (2 \pi))-\frac{\pi \sigma^{2}}{8} \\
& +\int_{t_{0}}^{T} \log |\mathcal{R}(\sigma+i t)| d t+\boldsymbol{o}\left(T^{1 / 2}\right) .
\end{aligned}
$$

8.3. Proof of Proposition 21. Here we will assume that the exponent $a=3 / 7$. The error term we will obtain is determined by the error in Theorem 18 for $U(t) \ll t^{-1 / 21}$. This is not the best exponent, and its relation to $a=3 / 7$ is not as direct, as seen in [7]. Therefore, we will not be able to obtain in Proposition 21 an error better than $\mathcal{O}\left(T^{20 / 21}\right)$. We suspect that Proposition 21 can be improved. Therefore, we will retain in our equations some terms less than the final error $\mathcal{O}\left(T^{20 / 21}\right)$, always assuming that $a \leq 3 / 7$. In this way, we will get a conjecture about further terms in Proposition 6.
Definition 29. We define a periodic function $\mathrm{P}: \mathbf{R} \rightarrow \mathbf{R}$ by

$$
\begin{equation*}
\mathrm{P}(x)=\sum_{n=1}^{\infty} \frac{2 \sin (2 \pi n x)}{n^{2}}-\sum_{n=1}^{\infty}(-1)^{n} \frac{\sin (4 \pi n x)}{n^{2}} \tag{27}
\end{equation*}
$$

Recall that for a given $s$ we define $\eta=\sqrt{(s-1) / 2 \pi i}$, taking the root such that $\operatorname{Re} \eta+\operatorname{Im} \eta>0$.
Lemma 30. Let $t_{0}>1$ be a fixed real number. For $T \rightarrow+\infty$ we have

$$
\begin{equation*}
\operatorname{Im} \int_{1+i t_{0}}^{1+i T} \log \frac{1-e^{2 \pi i \eta}}{1+e^{4 \pi i \eta}} d s=-\sqrt{T / 2 \pi} \mathrm{P}(\sqrt{T / 2 \pi})+\boldsymbol{O}(1) \tag{28}
\end{equation*}
$$

where the implicit constant only depends on $t_{0}$.

Proof. Here $s=1+i t$ with $t_{0}<t<T$ and $\eta=\sqrt{t / 2 \pi}$, hence

$$
J:=\operatorname{Im} \int_{1+i t_{0}}^{1+i T} \log \frac{1-e^{2 \pi i \eta}}{1+e^{4 \pi i \eta}} d s=\operatorname{Im} i \int_{t_{0}}^{T} \log \frac{1-e^{2 \pi i \eta}}{1+e^{4 \pi i \eta}} d t=\operatorname{Re} \int_{t_{0}}^{T} \log \frac{1-e^{2 \pi i \eta}}{1+e^{4 \pi i \eta}} d t
$$

Change variables $t=2 \pi \eta^{2}$, and let $\tau_{0}=\sqrt{t_{0} / 2 \pi}$ and $\tau=\sqrt{T / 2 \pi}$, then

$$
J=\operatorname{Re} 4 \pi \int_{\tau_{0}}^{\tau} \eta \log \frac{1-e^{2 \pi i \eta}}{1+e^{4 \pi i \eta}} d \eta
$$

Now we use the expansion

$$
\begin{equation*}
\log \frac{1-z}{1+z^{2}}=-\sum_{n=1}^{\infty} \frac{z^{n}}{n}+\sum_{n=1}^{\infty}(-1)^{n} \frac{z^{2 n}}{n} \tag{29}
\end{equation*}
$$

Then we have (it is not difficult to justify the integration term by term)

$$
\begin{aligned}
J & =4 \pi \operatorname{Re}\left\{-\sum_{n=1}^{\infty} \frac{1}{n} \int_{\tau_{0}}^{\tau} \eta e^{2 \pi i n \eta} d \eta+\sum_{n=1}^{\infty} \frac{(-1)^{n}}{n} \int_{\tau_{0}}^{\tau} \eta e^{4 \pi i n \eta} d \eta\right\} \\
& =4 \pi \operatorname{Re}\left\{\left.\sum_{n=1}^{\infty}\left(-\frac{e^{2 \pi i n \eta}}{4 \pi^{2} n^{3}}+\frac{i \eta e^{2 \pi i n \eta}}{2 \pi n^{2}}+(-1)^{n} \frac{e^{4 \pi i n \eta}}{16 \pi^{2} n^{3}}-(-1)^{n} \frac{i \eta e^{4 \pi i n \eta}}{4 \pi n^{2}}\right)\right|_{\tau_{0}} ^{\tau}\right\}
\end{aligned}
$$

All terms in $\tau_{0}$ will contribute only to a term $\mathcal{O}(1)$ (with a constant dependent on $t_{0}$ ). Analogously, the term in $\tau$ and $n^{3}$, which do not have the factor $\eta$ also contributes to a term $\mathcal{O}(1)$ (this time with absolute constants). So, we get

$$
\begin{gathered}
J=\operatorname{Re} \sum_{n=1}^{\infty}\left(\frac{2 i \tau e^{2 \pi i n \tau}}{n^{2}}-(-1)^{n} \frac{i \tau e^{4 \pi i n \tau}}{n^{2}}\right)+\boldsymbol{\mathcal { O }}(1)=\operatorname{Re} i \tau \sum_{n=1}^{\infty}\left(\frac{2 e^{2 \pi i n \tau}}{n^{2}}-(-1)^{n} \frac{e^{4 \pi i n \tau}}{n^{2}}\right)+\boldsymbol{\mathcal { O }}(1) \\
=\tau \sum_{n=1}^{\infty}\left(-\frac{2 \sin (2 \pi n \tau)}{n^{2}}+(-1)^{n} \frac{\sin (4 \pi n \tau)}{n^{2}}\right)+\boldsymbol{\mathcal { O }}(1)=-\tau \mathrm{P}(\tau)+\boldsymbol{\mathcal { O }}(1) .
\end{gathered}
$$

The previous lemma considers the integral with limits $1+i t_{0}$ and $1+i T$, but we are interested in this integral with limits $\sigma_{0}+i t_{0}$ and $\sigma_{0}+i T$. The difference between the two is bounded in the next lemma.
Lemma 31. Let $0<a \leq 3 / 7$ and $1-\sigma \leq T^{a}$, then for $T \rightarrow+\infty$ we have

$$
\begin{equation*}
\operatorname{Im} \int_{\sigma+i t_{0}}^{1+i t_{0}} \log \frac{1-e^{2 \pi i \eta}}{1+e^{4 \pi i \eta}} d s-\operatorname{Im} \int_{\sigma+i T}^{1+i T} \log \frac{1-e^{2 \pi i \eta}}{1+e^{4 \pi i \eta}} d s=\boldsymbol{O}\left(T^{a}\right) \tag{30}
\end{equation*}
$$

Proof. The two integrals are treated in the same way. For the second, for example, we have $s=x+i T$, with $\sigma<x<1$. Then as we noticed before $\left|e^{2 \pi i \eta}\right|<1$ and the logarithm is defined by means of (29) with $z=e^{2 \pi i \eta}$. Both series in (29) have imaginary parts in $(-\pi / 2, \pi / 2)$ so that

$$
\left|\operatorname{Im} \int_{\sigma+i T}^{1+i T} \log \frac{1-e^{2 \pi i \eta}}{1+e^{4 \pi i \eta}} d s\right|=\left|\int_{\sigma}^{1} \operatorname{Im} \log \frac{1-e^{2 \pi i \eta}}{1+e^{4 \pi i \eta}} d x\right| \leq \int_{\sigma}^{1} \pi d x=\pi(1-\sigma)=\boldsymbol{\mathcal { O }}\left(T^{a}\right)
$$

Lemma 32. Let $1 \leq t_{0}$ and $a \leq \frac{3}{7}$ be fixed real numbers and $1-\sigma_{0}=T^{a}$.
Then for $T \rightarrow+\infty$ we have

$$
\begin{equation*}
\int_{t_{0}}^{T} \log \left|e^{\pi i \eta}\right| d t=-\pi\left(1-\sigma_{0}\right)\left(\frac{T}{2 \pi}\right)^{1 / 2}+\frac{\sqrt{\pi}}{3}\left(1-\sigma_{0}\right)^{3 / 2}+\boldsymbol{\mathcal { O }}\left(T^{a / 2}\right) \tag{31}
\end{equation*}
$$

Proof. Put $s=\sigma_{0}+i t$, then

$$
\begin{aligned}
& \int_{t_{0}}^{T} \log \left|e^{\pi i \eta}\right| d t=\operatorname{Im} \int_{\sigma+i t_{0}}^{\sigma+i T} \log e^{\pi i \eta} d s=\operatorname{Im} \int_{\sigma+i t_{0}}^{\sigma+i T} \pi i \sqrt{\frac{s-1}{2 \pi i}} d s \\
= & -\operatorname{Im} \int_{\sigma+i t_{0}}^{\sigma+i T} 2 \pi^{2} \sqrt{\frac{s-1}{2 \pi i}} d \frac{s-1}{2 \pi i}=-\left.2 \pi^{2} \operatorname{Im} \frac{1}{3 / 2}\left(\frac{s-1}{2 \pi i}\right)^{3 / 2}\right|_{s=\sigma+i t_{0}} ^{\sigma+i T} \\
= & -\frac{4 \pi^{2}}{3} \operatorname{Im}\left\{\left(\frac{T}{2 \pi}+i \frac{1-\sigma}{2 \pi}\right)^{3 / 2}-\left(\frac{t_{0}}{2 \pi}+i \frac{1-\sigma}{2 \pi}\right)^{3 / 2}\right\} \\
= & \operatorname{Im}\left\{-\frac{4 \pi^{2}}{3}\left(\frac{T}{2 \pi}\right)^{3 / 2}\left(1+i \frac{1-\sigma}{T}\right)^{3 / 2}+\frac{4 \pi^{2}}{3}\left(i \frac{1-\sigma}{2 \pi}\right)^{3 / 2}\left(1-i \frac{t_{0}}{1-\sigma}\right)^{3 / 2}\right\} .
\end{aligned}
$$

According to the hypothesis, both $(1-\sigma) / T$ and $t_{0} /(1-\sigma)$ are less than $\frac{1}{2}$, say. So, we may expand both parenthesis in convergent power series. If I want to get this with an error $\boldsymbol{o}(1)$ we must retain the terms until $((1-\sigma) / T)^{3}$ and $\left(t_{0} /(1-\sigma)\right)^{2}$. Therefore, the result is the imaginary part of

$$
\begin{gathered}
\operatorname{Im}\left\{-\frac{4 \pi^{2}}{3}\left(\frac{T}{2 \pi}\right)^{3 / 2}\left(1+\frac{3 i}{2} \frac{1-\sigma}{T}-\frac{3}{8} \frac{(1-\sigma)^{2}}{T^{2}}\right)+\boldsymbol{\mathcal { O }}\left((1-\sigma)^{3} T^{-3 / 2}\right)\right. \\
\left.+(-1+i) \frac{4 \pi^{2}}{3 \sqrt{2}}\left(\frac{1-\sigma}{2 \pi}\right)^{3 / 2}\left(1-\frac{3 i}{2} \frac{t_{0}}{1-\sigma}\right)+\boldsymbol{\mathcal { O }}\left((1-\sigma)^{-1 / 2}\right)\right\} \\
\int_{t_{0}}^{T} \log \left|e^{\pi i \eta}\right| d t=-\frac{4 \pi^{2}}{3}\left(\frac{T}{2 \pi}\right)^{3 / 2} \frac{3}{2} \frac{1-\sigma}{T}+\frac{4 \pi^{2}}{3 \sqrt{2}}\left(\frac{1-\sigma}{2 \pi}\right)^{3 / 2} \\
+\frac{4 \pi^{2}}{3 \sqrt{2}} \frac{3}{2}\left(\frac{1-\sigma}{2 \pi}\right)^{3 / 2} \frac{t_{0}}{1-\sigma}+\boldsymbol{\mathcal { O }}\left((1-\sigma)^{3} T^{-3 / 2}\right)+\boldsymbol{\mathcal { O }}\left((1-\sigma)^{-1 / 2}\right) \\
=-\pi(1-\sigma)\left(\frac{T}{2 \pi}\right)^{1 / 2}+\frac{\sqrt{\pi}}{3}(1-\sigma)^{3 / 2}+\frac{t_{0}}{2}(\pi(1-\sigma))^{1 / 2}+\boldsymbol{\mathcal { O }}\left((1-\sigma)^{-1 / 2}\right)
\end{gathered}
$$

assuming that $a \leq \frac{3}{7}$ so that the exponent $3 a-3 / 2 \leq-a / 2$.
Proposition 33. Let $t_{0}>1$ greater than the constant in Theorem 18 and $1-\sigma_{0}=T^{a}$ with $0<a<1 / 2$. Then, for $T \rightarrow+\infty$

$$
\begin{equation*}
\int_{t_{0}}^{T} \log \left|J\left(\sigma_{0}+i t\right)\right| d t=-\frac{\pi T^{2}}{8}+\frac{T}{2} \log T-\frac{T}{2}+\frac{T}{2} \log (2 \pi)+\boldsymbol{\mathcal { O }}\left(T^{a+\frac{1}{2}}\right) \tag{32}
\end{equation*}
$$

Proof. By Lemmas 19, 30, 31 and 32, it remains to compute

$$
\begin{gathered}
A=\operatorname{Im} \int_{\sigma_{0}+i t_{0}}^{\sigma_{0}+i T}\left(\frac{\pi i s}{4}+\log s-\frac{1}{2} \log \frac{1-s}{2 \pi}-\frac{3 \pi i}{8}\right) d s \\
A=\operatorname{Im}\left\{\frac{\pi i s^{2}}{8}+s \log s-\frac{1}{2} s-\frac{3 \pi i s}{8}+\left.\frac{1-s}{2} \log \frac{1-s}{2 \pi}\right|_{\sigma_{0}+i t_{0}} ^{\sigma_{0}+i T}\right\} \\
=-\frac{\pi T^{2}}{8}-\frac{T}{2}+\mathcal{O}_{t_{0}}(1)+\operatorname{Im}\left\{\left(\sigma_{0}+i T\right) \log \left(\sigma_{0}+i T\right)-\left(\sigma_{0}+i t_{0}\right) \log \left(\sigma_{0}+i t_{0}\right)\right. \\
\left.+\frac{1-\sigma_{0}-i T}{2} \log \frac{1-\sigma_{0}-i T}{2 \pi}-\frac{1-\sigma_{0}-i t_{0}}{2} \log \frac{1-\sigma_{0}-i t_{0}}{2 \pi}\right\}
\end{gathered}
$$

Simple computations yields (I have written here $\sigma$ instead of $\sigma_{0}$ )

$$
\begin{aligned}
& \operatorname{Im}(\sigma+i T) \log (\sigma+i T)=T \log T-T \sum_{n=1}^{\infty} \frac{(-1)^{n}}{2 n}\left(\frac{\sigma}{T}\right)^{2 n}+\frac{\pi \sigma}{2}+\sigma \sum_{n=1}^{\infty} \frac{(-1)^{n}}{2 n-1}\left(\frac{\sigma}{T}\right)^{2 n-1} . \\
& \operatorname{Im}\left(\sigma+i t_{0}\right) \log \left(\sigma+i t_{0}\right)=t_{0} \log |\sigma|-t_{0} \sum_{n=1}^{\infty} \frac{(-1)^{n}}{2 n}\left(\frac{t_{0}}{\sigma}\right)^{2 n}+\pi \sigma-\sigma \sum_{n=1}^{\infty} \frac{(-1)^{n}}{2 n-1}\left(\frac{t_{0}}{\sigma}\right)^{2 n-1} . \\
& \operatorname{Im}\left(\frac{1-\sigma}{2}-\frac{i T}{2}\right) \log \frac{1-\sigma-i T}{2 \pi} \\
& =-\frac{T}{2} \log \frac{T}{2 \pi}+\frac{T}{2} \sum_{n=1}^{\infty} \frac{(-1)^{n}}{2 n}\left(\frac{1-\sigma}{T}\right)^{2 n}-\frac{\pi(1-\sigma)}{4}-\frac{1-\sigma}{2} \sum_{n=1}^{\infty} \frac{(-1)^{n}}{2 n-1}\left(\frac{1-\sigma}{T}\right)^{2 n-1} . \\
& \operatorname{Im}\left(\frac{1-\sigma}{2}-\frac{i t_{0}}{2}\right) \log \frac{1-\sigma-i t_{0}}{2 \pi} \\
& \left.\quad=-\frac{t_{0}}{2} \log \frac{1-\sigma}{2 \pi}+\frac{t_{0}}{2} \sum_{n=1}^{\infty} \frac{(-1)^{n}}{2 n}\left(\frac{t_{0}}{1-\sigma}\right)^{2 n}+\frac{1-\sigma}{2} \sum_{n=1}^{\infty} \frac{(-1)^{n}}{2 n-1}\left(\frac{t_{0}}{1-\sigma}\right)^{2 n-1}\right) .
\end{aligned}
$$

Substituting these values, we obtain

$$
\begin{aligned}
& A=-\frac{\pi T^{2}}{8}-\frac{T}{2}+T \log T-\frac{T}{2} \log \frac{T}{2 \pi}+\boldsymbol{\mathcal { O }}\left(T^{a}\right) . \\
& A=-\frac{\pi T^{2}}{8}+\frac{T}{2} \log T-\frac{T}{2}+\frac{T}{2} \log 2 \pi+\boldsymbol{\mathcal { O }}\left(T^{a}\right)
\end{aligned}
$$

By the above lemmas 19, 30, 31 and 32 we get then

$$
\begin{aligned}
& \int_{t_{0}}^{T} \log \left|J\left(\sigma_{0}+i t\right)\right| d t=-\frac{\pi T^{2}}{8}+\frac{T}{2} \log T-\frac{T}{2}+\frac{T}{2} \log 2 \pi+\boldsymbol{\mathcal { O }}\left(T^{a}\right) \\
& \quad-\pi\left(1-\sigma_{0}\right)\left(\frac{T}{2 \pi}\right)^{1 / 2}+\frac{\sqrt{\pi}}{3}\left(1-\sigma_{0}\right)^{3 / 2}+\boldsymbol{\mathcal { O }}\left(T^{a / 2}\right) \\
& \quad-\left(\frac{T}{2 \pi}\right)^{1 / 2} \mathrm{P}(\sqrt{T / 2 \pi})+\boldsymbol{\mathcal { O }}(1)
\end{aligned}
$$

Therefore,

$$
\begin{align*}
\int_{t_{0}}^{T} \log \left|J\left(\sigma_{0}+i t\right)\right| d t & =-\frac{\pi T^{2}}{8}+\frac{T}{2} \log T-\frac{T}{2}+\frac{T}{2} \log 2 \pi+\pi \sigma_{0}\left(\frac{T}{2 \pi}\right)^{1 / 2}  \tag{33}\\
- & (\pi+\mathrm{P}(\sqrt{T / 2 \pi}))\left(\frac{T}{2 \pi}\right)^{1 / 2}+\frac{\sqrt{\pi}}{3}\left(1-\sigma_{0}\right)^{3 / 2}+\boldsymbol{\mathcal { O }}\left(T^{a}\right)
\end{align*}
$$

Remark 34. Siegel [17, p. 304] asserts that he can prove his theorems with $a=\varepsilon$. This would imply that the term containing the function $P$ in equation (33) would make sense. In [2] we saw that this term appears in the experimental data obtained with the zeros of $\mathcal{R}(s)$.

Proof of Proposition 21. Since $t_{0}$ is chosen adequately, we have by Theorem 18 that $F(s)=J(s)(1+U(s))$, with $|U(s)| \leq A t^{-1 / 21}$. It follows that

$$
\int_{t_{0}}^{T} \log \left|1+U\left(\sigma_{0}+i t\right)\right| d t=\boldsymbol{\mathcal { O }}\left(T^{20 / 21}\right) .
$$

Combining this with Proposition 33 proves Proposition 21.
