# The points of space are not points: their wavefunctions remove the ultraviolet divergences of quantum field theory

The points $p(x)$ of space are observables that obey quantum mechanics with average values $\langle p(x)\rangle$ that obey general relativity. In empty flat 3 -space, a point $p(x)$ may be represented as the sum $\boldsymbol{p}(x)=\langle\boldsymbol{p}(x)\rangle+\boldsymbol{\epsilon}(x)$ of its average value $\langle\boldsymbol{p}(x)\rangle=\boldsymbol{x}$ and its quantum remainder $\boldsymbol{\epsilon}(x)$. The ubiquitous Fourier exponential $\exp (i \boldsymbol{k} \cdot \boldsymbol{p}(x))$ is then $\exp (i \boldsymbol{k} \cdot(\boldsymbol{x}+\boldsymbol{\epsilon}))$. If the probability distribution of the quantum remainders $\boldsymbol{\epsilon}(x)$ is normal and of width $\sigma$, then the average of the exponential $\langle\exp (i \boldsymbol{k}(\boldsymbol{x}+\boldsymbol{\epsilon})\rangle$ contains a gaussian factor $\exp \left(-\sigma^{2} \boldsymbol{k}^{2} / 2\right)$ which makes self-energies, Feynman diagrams and dark energy ultraviolet finite. This complex of ideas requires new bosons and suggests that supersymmetry is softly broken.

## INTRODUCTION

Einstein's equations $G_{i k}=8 \pi G T_{i k}$ relate the energy-momentum tensor $T_{i k}$ to the Einstein tensor $G_{i k}$ which is a sum of products of the metric $g_{i k}$, its inverse and its derivatives. The metric $g_{i k}(x)$ itself is quadratic in the derivatives

$$
\begin{equation*}
g_{i k}(x)=\frac{\partial p(x)}{\partial x^{i}} \cdot \frac{\partial p(x)}{\partial x^{k}} \equiv-\frac{\partial p^{0}(x)}{\partial x^{i}} \frac{\partial p^{0}(x)}{\partial x^{k}}+\sum_{\alpha=1}^{s} \frac{\partial p^{\alpha}(x)}{\partial x^{i}} \frac{\partial p^{\alpha}(x)}{\partial x^{k}} \tag{1}
\end{equation*}
$$

of the point $p(x)$ which lies in a flat semi-euclidian embedding space of one dimension of time and $s \leq 19$ dimensions of space [1-4]. Einstein's equations therefore relate derivatives of the points $p(x)$ of our 4-dimensional curved space to the energy-momentum tensor $T_{i k}$ which is a sum of products of hermitian operators. It follows that the points $p(x)$ are themselves hermitian operators. Their average values $\langle p(x)\rangle$ obey general relativity, and their remainders $\epsilon(x)=p(x)-\langle p(x)\rangle$ obey quantum mechanics. Their coordinates $x$ are merely labels.

## EMPTY, FLAT SPACE

In empty flat space $\mathcal{E}$, the average $\langle\mathcal{E}| \boldsymbol{p}(x)|\mathcal{E}\rangle \equiv\langle\boldsymbol{p}(x)\rangle$ of the spatial components of a point $\boldsymbol{p}(\boldsymbol{x})$ is its position $\langle\boldsymbol{p}(x)\rangle=\boldsymbol{x}$ in the rest frame of the CMB. A point $\boldsymbol{p}(x)$ of space is the sum of its position $\boldsymbol{x}$ and its quantum-mechanical remainder $\boldsymbol{\epsilon}(x)$

$$
\begin{equation*}
\boldsymbol{p}(x)=\langle\mathcal{E}| \boldsymbol{p}(x)|\mathcal{E}\rangle+\boldsymbol{\epsilon}(x)=\boldsymbol{x}+\boldsymbol{\epsilon}(x) . \tag{2}
\end{equation*}
$$

In empty flat space $\mathcal{E}$ and in the rest frame of the CMB , the probability distribution $P(\boldsymbol{\epsilon})=$ $|\langle\boldsymbol{\epsilon} \mid \mathcal{E}\rangle|^{2}$ of the three components $\boldsymbol{\epsilon}(x)$ should depend only upon $\boldsymbol{\epsilon}^{2}$ and not upon $\boldsymbol{x}$ and be tightly concentrated about $\boldsymbol{\epsilon}=0$. For simplicity I will assume that the components $\boldsymbol{\epsilon}(x)$ are normally distributed

$$
\begin{equation*}
P(\boldsymbol{\epsilon}) \equiv|\langle\boldsymbol{\epsilon} \mid \mathcal{E}\rangle|^{2}=\frac{1}{(2 \pi)^{3 / 2} \sigma^{3}} \exp \left(-\frac{\boldsymbol{\epsilon}^{2}}{2 \sigma^{2}}\right) \tag{3}
\end{equation*}
$$

in which $\sigma$ is a length of the order of $M_{\text {Planck }}^{-1}$. The present formalism may entail violations of Lorentz invariance on scales of the order of the inverse of the Planck mass.

The average value of the exponential $\exp ( \pm i \boldsymbol{k} \cdot(\boldsymbol{x}+\boldsymbol{\epsilon}(x)))$ in flat space $\mathcal{E}$ is then

$$
\begin{align*}
\langle\mathcal{E}| \exp ( & \pm i \boldsymbol{k} \cdot(\boldsymbol{x}+\boldsymbol{\epsilon}(x)))|\mathcal{E}\rangle=\int d^{3} \boldsymbol{\epsilon}(\boldsymbol{x}) P(\boldsymbol{\epsilon}(x)) \exp ( \pm i \boldsymbol{k} \cdot(\boldsymbol{x}+\boldsymbol{\epsilon}(x))) \\
& =\int d^{3} \boldsymbol{\epsilon}(\boldsymbol{x})|\langle\boldsymbol{\epsilon}(\boldsymbol{x}) \mid \mathcal{E}\rangle|^{2} \exp ( \pm i \boldsymbol{k} \cdot(\boldsymbol{x}+\boldsymbol{\epsilon}(x))) \\
& =\int \frac{d^{3} \boldsymbol{\epsilon}}{\sigma^{3}(2 \pi)^{3 / 2}} e^{ \pm i \boldsymbol{k} \cdot(\boldsymbol{x}+\boldsymbol{\epsilon})-\boldsymbol{\epsilon}^{2} / 2 \sigma^{2}}=\exp \left( \pm i \boldsymbol{k} \cdot \boldsymbol{x}-\sigma^{2} \boldsymbol{k}^{2} / 2\right) \tag{4}
\end{align*}
$$

which is the original exponential $\exp ( \pm i \boldsymbol{k} \cdot \boldsymbol{x})$ multiplied by the damping factor $\exp \left(-\sigma^{2} \boldsymbol{k}^{2} / 2\right)$.

## FIELDS IN FLAT SPACE

The usual Fourier decomposition of a scalar field in flat space is

$$
\begin{equation*}
\phi(x)=\int \frac{d^{3} k}{\sqrt{(2 \pi)^{3} 2 \omega_{k}}}\left[e^{i k x} a(k)+e^{-i k x} a^{\dagger}(k)\right] \tag{5}
\end{equation*}
$$

in which $k x=\boldsymbol{k} \cdot \boldsymbol{x}-\omega_{k} x^{0}$ and $\omega_{k}=\sqrt{\boldsymbol{k}^{2}+m^{2}}$. Replacing the exponentials $e^{ \pm i k x}$ by their average values (4) in empty flat space, we find for the averaged field

$$
\begin{equation*}
\langle\mathcal{E}| \phi(x)|\mathcal{E}\rangle=\int \frac{d^{3} k}{\sqrt{(2 \pi)^{3} 2 \omega_{k}}}\left[e^{i k x} a(k)+e^{-i k x} a^{\dagger}(k)\right] e^{-\sigma^{2} k^{2} / 2} \tag{6}
\end{equation*}
$$

As $\sigma \rightarrow 0$, the averaged field $\langle\phi(x)\rangle$ becomes the usual field (5), but as long as $\sigma \neq 0$, the factor $e^{-\sigma^{2} \boldsymbol{k}^{2} / 2}$ makes Feynman diagrams finite.

## BASIC COMMUTATION RELATION

The equal-time commutation relation for a scalar field with $\boldsymbol{x}$ and $\boldsymbol{y}$ replaced by $\boldsymbol{x}+\boldsymbol{\epsilon}(x)$ and $\boldsymbol{y}+\boldsymbol{\epsilon}(y)$ is

$$
\begin{equation*}
[\phi(t, \boldsymbol{x}+\boldsymbol{\epsilon}(x)), \pi(t, \boldsymbol{y}+\boldsymbol{\epsilon}(y))]=i \int \frac{d^{3} k}{(2 \pi)^{3}} \exp (i \boldsymbol{k} \cdot(\boldsymbol{x}+\boldsymbol{\epsilon}(x)-\boldsymbol{y}-\boldsymbol{\epsilon}(y))) . \tag{7}
\end{equation*}
$$

Its average in empty flat space $\mathcal{E}$ is

$$
\begin{align*}
\langle\mathcal{E}|[\phi(t, \boldsymbol{x}), \pi(t, \boldsymbol{y})]|\mathcal{E}\rangle & =i \int \frac{d^{3} k d^{3} \boldsymbol{\epsilon}(x) d^{3} \boldsymbol{\epsilon}(y)}{(2 \pi \sigma)^{6}} e^{i \boldsymbol{k}(\boldsymbol{x}+\boldsymbol{\epsilon}(x)-\boldsymbol{y}-\boldsymbol{\epsilon}(y))-\left(\boldsymbol{\epsilon}^{2}(x)+\boldsymbol{\epsilon}^{2}(y)\right) / 2 \sigma^{2}} \\
& =i \int \frac{d^{3} k}{(2 \pi)^{3}} e^{i \boldsymbol{k} \cdot(\boldsymbol{x}-\boldsymbol{y})-\sigma^{2} \boldsymbol{k}^{2}}=\frac{i}{(2 \sqrt{\pi} \sigma)^{3}} e^{-(\boldsymbol{x}-\boldsymbol{y})^{2} / 4 \sigma^{2}} \tag{8}
\end{align*}
$$

which approaches the usual expression as $\sigma \rightarrow 0$ but is finite for all $\boldsymbol{x}$ and $\boldsymbol{y}$.

## FEYNMAN'S PROPAGATOR

For scalar fields, the Feynman propagator is

$$
\begin{equation*}
\Delta_{\mathrm{F}}(x-y)=\int \frac{d^{4} q}{(2 \pi)^{4}} \frac{e^{i q(x-y)}}{q^{2}+m^{2}-i \epsilon} \tag{9}
\end{equation*}
$$

With $\boldsymbol{x} \rightarrow \boldsymbol{x}+\boldsymbol{\epsilon}(x)$ and $\boldsymbol{y} \rightarrow \boldsymbol{y}+\boldsymbol{\epsilon}(y)$, it is

$$
\begin{equation*}
\Delta_{\mathrm{F}}(x-y)=\int \frac{d^{4} q}{(2 \pi)^{4}} \frac{e^{i q(x+\epsilon(x)-y-\epsilon(y))}}{q^{2}+m^{2}-i \epsilon} . \tag{10}
\end{equation*}
$$

This expression averaged over the normal distribution (3) is

$$
\begin{align*}
\langle\mathcal{E}| \Delta_{\mathrm{F}}(x-y)|\mathcal{E}\rangle & =\int \frac{d^{4} q d^{3} \boldsymbol{\epsilon}(x) d^{3} \boldsymbol{\epsilon}(y)}{(2 \pi)^{4}} \frac{e^{i q(x+\boldsymbol{\epsilon}(x)-y-\boldsymbol{\epsilon}(y))}}{q^{2}+m^{2}-i \epsilon} P(\boldsymbol{\epsilon}(x)) P(\boldsymbol{\epsilon}(y)) \\
& =\int \frac{d^{4} q d^{3} \boldsymbol{\epsilon}_{x} d^{3} \boldsymbol{\epsilon}_{y}}{(2 \pi)^{6} \sigma^{6}} \frac{e^{i q(x+\boldsymbol{\epsilon}(x)-y-\boldsymbol{\epsilon}(y))-\left(\boldsymbol{\epsilon}^{2}(x)+\boldsymbol{\epsilon}^{2}(y)\right) / 2 \sigma^{2}}}{q^{2}+m^{2}-i \epsilon}  \tag{11}\\
& =\int \frac{d^{4} q}{(2 \pi)^{4}} \frac{e^{i q(x-y)-\sigma^{2} \boldsymbol{q}^{2}}}{q^{2}+m^{2}-i \epsilon} \equiv \Delta_{\mathrm{F}, \sigma}(x-y)
\end{align*}
$$

which reduces to the usual propagator as $\sigma \rightarrow 0$ but is finite even at $x=y$.

## SELF-ENERGY

In second-order $\phi^{3}$ theory with action density

$$
\begin{equation*}
\mathcal{L}=-\frac{1}{2} \partial_{i} \phi \partial^{i} \phi-\frac{1}{2} m^{2} \phi^{2}-\frac{\lambda}{3!} \phi^{3} \tag{12}
\end{equation*}
$$

( $i=0$ to 3 ), the self-energy amplitude

$$
\begin{equation*}
A\left(k, k^{\prime}\right)=\frac{\lambda^{2} \delta\left(k-k^{\prime}\right)}{2(2 \pi)^{3} \sqrt{2 k^{0} 2 k^{\prime 0}}} \int \frac{d^{4} q}{\left(q^{2}+m^{2}-i \epsilon\right)\left((q-k)^{2}+m^{2}-i \epsilon\right)} \tag{13}
\end{equation*}
$$

is quadratically divergent.
If the propagators (11) averaged over fluctuations $\Delta_{\mathrm{F}, \sigma}(x-y)$ are used, then the amplitude $A\left(k, k^{\prime}\right)$ becomes a convergent integral

$$
\begin{equation*}
A_{\sigma}\left(k, k^{\prime}\right)=\frac{\lambda^{2} \delta\left(k-k^{\prime}\right)}{2(2 \pi)^{3} \sqrt{2 k^{0} 2 k^{\prime 0}}} \int d^{4} q \frac{e^{-\sigma^{2}\left(\boldsymbol{q}^{2}+(\boldsymbol{q}-\boldsymbol{k})^{2}\right)}}{\left(q^{2}+m^{2}-i \epsilon\right)\left((q-k)^{2}+m^{2}-i \epsilon\right)} \tag{14}
\end{equation*}
$$

which at $\sigma=0$ is the usual formula (13) and at $k=0$ is

$$
\begin{equation*}
A_{\sigma}\left(0, k^{\prime}\right)=\frac{\lambda^{2} \delta\left(k^{\prime}\right)}{4(2 \pi)^{3} m} \int d^{4} q \frac{e^{-2 \sigma^{2} \boldsymbol{q}^{2}}}{\left(q^{2}+m^{2}-i \epsilon\right)^{2}}=-\frac{i m \lambda^{2} \delta\left(k^{\prime}\right)}{4 \pi \sigma^{2}} e^{\sigma^{2} m^{2}} K_{1}\left(\sigma^{2} m^{2}\right) \tag{15}
\end{equation*}
$$

## VACUUM ENERGY

The hamiltonian for a single scalar field is

$$
\begin{equation*}
H=\frac{1}{2} \int\left(\dot{\phi}^{2}(x)+(\nabla \phi(x))^{2}+m^{2} \phi^{2}(x)\right) d^{3} x \tag{16}
\end{equation*}
$$

Its average value in the flat-space vacuum $|\mathcal{E}\rangle$ is

$$
\begin{equation*}
\langle\mathcal{E}| H|\mathcal{E}\rangle=\frac{1}{2} \int\langle\mathcal{E}| \dot{\phi}^{2}(x)+(\nabla \phi(x))^{2}+m^{2} \phi^{2}(x)|\mathcal{E}\rangle d^{3} x \tag{17}
\end{equation*}
$$

in which, for instance, $\phi^{2}(x)$ is the limit of $\phi(x) \phi(y)$ as $y \rightarrow x$. Using the averaged field (6), we find for the energy density

$$
\begin{equation*}
\rho_{m}=\int \frac{d^{3} k}{2(2 \pi)^{3}} \sqrt{m^{2}+\boldsymbol{k}^{2}} e^{-\sigma^{2} \boldsymbol{k}^{2}}=\frac{m^{2}}{16 \pi^{2} \sigma^{2}} e^{\sigma^{2} m^{2} / 2} K_{1}\left(\sigma^{2} m^{2} / 2\right) . \tag{18}
\end{equation*}
$$

The energy density due to a single fermionic mode of mass $m_{f}$ is $-\rho_{m_{f}}$.

## DARK ENERGY, DARK MATTER AND SUPERSYMMETRY

So if there are $B$ bosonic modes each of mass $m_{b}$ and $F$ fermionic modes each of mass $m_{f}$, then the density of dark energy is an alternating sum of the densities $\rho_{m_{b}}$ and $\rho_{m_{f}}$

$$
\begin{equation*}
\rho_{\mathrm{de}}^{\mathrm{th}}=\frac{1}{16 \pi^{2} \sigma^{2}}\left(\sum_{b=1}^{B} m_{b}^{2} e^{\sigma^{2} m_{b}^{2} / 2} K_{1}\left(\sigma^{2} m_{b}^{2} / 2\right)-\sum_{f=1}^{F} m_{f}^{2} e^{\sigma^{2} m_{f}^{2} / 2} K_{1}\left(\sigma^{2} m_{f}^{2} / 2\right)\right) \tag{19}
\end{equation*}
$$

There are $B=30$ known bosonic modes and $F=96$ known fermionic modes if the three neutrinos are nearly massless Dirac neutrinos.

The fundamental length $\sigma$ is assumed to be very short, perhaps of the order of the Planck length, so in the formula (19) for the density of dark energy $\rho_{\mathrm{de}}^{\text {th }}$, the first two terms in the expansion of the modified Bessel function

$$
\begin{equation*}
K_{1}\left(\frac{1}{2} \sigma^{2} m^{2}\right)=\frac{2}{\sigma^{2} m^{2}}+\frac{\sigma^{2} m^{2}}{8}\left(2 \gamma-1+2 \log \left(\frac{1}{4} \sigma^{2} m^{2}\right)\right)+\ldots \tag{20}
\end{equation*}
$$

are the most important. Here $\gamma=0.5772156649$ is the Euler-Mascheroni constant.
Keeping only the first term in this expansion (20), we get for the density of dark energy

$$
\begin{equation*}
\rho_{\mathrm{de}}^{\mathrm{th}} \approx \frac{B-F}{8 \pi^{2} \sigma^{4}}=-\frac{33}{4 \pi^{2} \sigma^{4}} \tag{21}
\end{equation*}
$$

which is negative and too great by many orders of magnitude. So if the theoretical density of dark energy $\rho_{\mathrm{de}}^{\text {th }}$ is approximately equal to the observed density of dark energy $\rho_{\mathrm{de}}^{\text {obs }}$, then we must have $B=F$ as in supersymmetry. Thus there must be at least 66 bosonic modes. These modes must be very heavy, dark or both.

If $B=F$, then the estimate (19) for $\rho_{\mathrm{de}}^{\mathrm{th}}$ and the approximation (20) give

$$
\begin{equation*}
\rho_{\mathrm{de}}^{\mathrm{th}} \approx \frac{1}{16 \pi^{2}} \sum_{\alpha}(-1)^{2 j_{\alpha}}\left[\frac{m_{\alpha}^{2}}{\sigma^{2}}+\left(\frac{m_{\alpha}^{4}}{8}+\frac{\sigma^{2} m_{\alpha}^{6}}{16}\right)\left(2 \gamma-1+2 \log \left(\frac{1}{4} \sigma^{2} m_{\alpha}^{2}\right)\right)\right] . \tag{22}
\end{equation*}
$$

In models with softly broken supersymmetry, the alternating sum of squared masses vanishes $\sum_{\alpha}(-1)^{2 j} m_{\alpha}^{2}=0$ at tree level leaving

$$
\begin{equation*}
\rho_{\mathrm{de}}^{\mathrm{th}} \approx \frac{1}{128 \pi^{2}} \sum_{\alpha}(-1)^{2 j_{\alpha}}\left[m_{\alpha}^{4}\left(2 \gamma-1+2 \log \left(\frac{1}{4} \sigma^{2} m_{\alpha}^{2}\right)\right)+\sigma^{2} m_{\alpha}^{6} \log \left(\frac{1}{4} \sigma^{2} m_{\alpha}^{2}\right)\right] . \tag{23}
\end{equation*}
$$

This estimate $\rho_{\mathrm{de}}^{\text {th }}$ is generically orders of magnitude greater than the observed darkenergy density $\rho_{\mathrm{de}}^{\mathrm{obs}}=2.74 \times 10^{-47}(\mathrm{GeV})^{4}$ unless the alternating sum of quartic masses $\sum_{\alpha}(-1)^{2 j} m_{\alpha}^{4}=0$ vanishes.

## CONCLUSION

Einstein's equation $G_{i k}=8 \pi G T_{i k}$ relates derivatives of points $p(x)$ to the energymomentum tensor which is a quantum-mechanical operator. The points $p(x)$ of space therefore are quantum-mechanical operators. Their average values $\langle p(x)\rangle$ obey general relativity, and their remainders $\epsilon(x)=p(x)-\langle p(x)\rangle$ obey quantum mechanics.
