# Combinatorial properties of Circulant Hadamard matrices

#### Abstract

We describe combinatorial properties of the defining row of a circulant Hadamard matrix by exploiting its orthogonality to subsequent rows, and show how to exclude several particular forms of these matrices.


## 1 Introduction and basic definitions

Throughout this paper, the $i$-row of a matrix $H$ of size $n \times n$ is denoted by $H_{i}, 1 \leq i \leq n$. A $( \pm 1)$-matrix $H$ of size $n \times n$ is called Hadamard matrix if its rows are mutually orthogonal. It is a circulant matrix if for $H_{1}=\left(h_{1}, \ldots, h_{n}\right)$, its $i$-row is given by $H_{i}=\left(h_{1-i+1}, \ldots, h_{n-i+1}\right)$, the subscripts being taken modulo $n$. In this case, the first row $H_{1}$ will be called the defining row of $H$.

An example of a $4 \times 4$ circulant Hadamard matrix is the following:

H=\left(\begin{array}{rrrr}
-1 & 1 & 1 & 1 \\
1 & -1 & 1 & 1 \\
1 & 1 & -1 & 1 \\
1 & 1 & 1 & -1
\end{array}\right)
$$

A conjecture of Ryser (cf. [2, pp.97]) states that there is no circulant Hadamard matrix unless $n=1$ or $n=4$. This conjecture is still open although many partial results have been obtained. For recent results and further details, we refer to [1], [3] and [4].

The objective of this paper is to exhibit some combinatorial properties of the defining row $H_{1}$ of such a matrix $H$ that we obtained by exploiting the orthogonality of $H_{1}$ to some of its subsequent rows. It turns out that these properties allow to exclude several particular forms for circulant Hadamard matrices. We think that a further development of this "combinatorial approach" may contribute to exclude other cases of such matrices and help to determine the maximum number $k$ for which the first $k$ rows of a circulant $( \pm 1)$-matrix are mutually orthogonal.

The order $n$ (for $n>1$ ) of a circulant Hadamard matrix $H$ is well known to be of the form $n=4 m=4 h^{2}$, where $h$ is an odd integer. Also, by orthogonality, the entries of any two different rows have the same sign in exactly $2 m$ columns, and a different sign in the other $2 m$ ones.

Finally, the property of being circulant allows any row of $H$ to be represented as a circular sequence of "+" and "-".

Some further definitions are required. Let us consider the first row $H_{1}$ of a circulant Hadamard matrix $H$. A maximal sequence of consecutive +1 's (respectively -1 's) will be called a positive block (respectively negative block), denoted by $B$. If the size of such a block equals $k$, for some positive integer $k$, we will speak of a positive (respectively negative)
$k$-block. The family of all blocks is denoted by $\mathcal{B}$, that of all $k$-blocks by $\mathcal{B}_{k}$ and that of all $k$-blocks with $k \geq i$, for a given positive integer $i$, by $\mathcal{B}_{\geq i}$. Thus, $H_{1}$ decomposes into a sequence of alternating, positive or negative blocks. For convenience, we suppose the first and last block of $H_{1}$ to be of opposite sign. Finally, a maximal alternating sequence of blocks in $\mathcal{B}_{k}$ (in $\mathcal{B}_{\geq k}$ ) will be called a $k$-alternating sequence ( $\geq k$-alternating sequence, respectively), the length of which is given by the number of blocks forming it.

## 2 Our results

Lemma 2.1 The total number of blocks in the first row $H_{1}$ of a circulant Hadamard matrix $H$ equals $2 m$.

Proof: We consider $H_{1}$ and $H_{2}$ of $H$ and observe that the number of columns with entries of different sign equals the total number of blocks. Hence, $|\mathcal{B}|=2 m$.

Alternatively, if we count the number of columns whose entries have equal sign, we obtain $\sum_{B \in \mathcal{B}}(|B|-1)$, which equals $4 m-|\mathcal{B}|$ and which by orthogonality, gives $2 m$. Again, $|\mathcal{B}|=2 m$.

Lemma 2.2 The total number of 1-blocks in $H_{1}$ equals $m$.
Proof: We consider $H_{1}$ and $H_{3}$ of $H$ and count the number of columns with entries of equal sign. We observe that:

- in a 1-alternating sequence, this number equals the length of the sequence minus 1 , plus 1 arising from the $\geq 2$-block preceding the sequence,
- a block $B \in \mathcal{B}_{\geq 3}$ contributes with $|B|-2$,
- no block $B \in \mathcal{B}_{2}$ contributes to this number (except those preceding a 1 -alternating path, whose contribution is already taken into account).

By orthogonality of $H_{1}$ and $H_{3}$, we obtain:

$$
\begin{aligned}
2 m & =\left|\mathcal{B}_{1}\right|+\sum_{B \in \mathcal{B}_{\geq 3}}(|B|-2) \\
& =\left|\mathcal{B}_{1}\right|+\sum_{B \in \mathcal{B}_{\geq 2}}(|B|-2) \\
& =\left|\mathcal{B}_{1}\right|+\left(\sum_{B \in \mathcal{B}_{\geq 2}}|B|\right)-2\left|\mathcal{B}_{\geq 2}\right| \\
& =\left|\mathcal{B}_{1}\right|+\left(4 m-\left|\mathcal{B}_{1}\right|\right)-2\left(|\mathcal{B}|-\left|\mathcal{B}_{1}\right|\right) \\
& =4 m-4 m+2\left|\mathcal{B}_{1}\right| .
\end{aligned}
$$

Hence, $\left|\mathcal{B}_{1}\right|=m$.
Alternatively, we may count the number of columns of $H_{1}$ and $H_{3}$, with entries of different signs. We denote by $\alpha_{1}$ the number of 1 -alternating sequences, by $\alpha \geq 2$ the number of $\geq 2$-alternating sequences, by $\Lambda$ the set of all $\geq 2$-alternating sequences, and by $|\ell|$ the length of an element $\ell$ of $\Lambda$. We observe that:

- any 1 -alternating sequence contributes with 2 ,
- any $\geq 2$-alternating sequence $\ell$ contributes with $2(|\ell|-1)$.

Thus, we obtain:

$$
\begin{equation*}
2 m=2 \alpha_{1}+2\left(\sum_{\ell \in \Lambda}(|\ell|-1)\right) . \tag{1}
\end{equation*}
$$

Since 1-alternating sequences and $\geq 2$-alternating sequences are themselves alternating within $H_{1}, \alpha_{1}=\alpha_{\geq 2}$, and we get from (11):

$$
m=\alpha_{1}+\left|\mathcal{B}_{\geq 2}\right|-\alpha_{\geq 2}=\left|\mathcal{B}_{\geq 2}\right|=|\mathcal{B}|-\left|\mathcal{B}_{1}\right|=2 m-\left|\mathcal{B}_{1}\right| \text { by Lemma }
$$

Hence, $\left|\mathcal{B}_{1}\right|=m$.
Lemma 2.3 The number of blocks of size 2 and the number of 1-alternating sequences add up to $m$ :

$$
\left|\mathcal{B}_{2}\right|+\alpha_{1}=m .
$$

Proof: We consider $H_{1}$ and $H_{4}$ of $H$ and count the number of columns with entries of equal sign. We observe that:

- any 1- alternating sequence is preceded and followed by a block of size $\geq 2$, - a block $B \in \mathcal{B}_{\geq 3}$ contributes with $|B|-3$,
- any 2 -block $B \in \mathcal{B}_{2}$ is preceded and followed by an element of opposite sign.

By orthogonality of $H_{1}$ and $H_{4}$ and by Lemmata 2.1) and 2.2, we obtain:

$$
\begin{aligned}
2 m & =\sum_{B \in \mathcal{B}_{\geq 3}}(|B|-3)+\left|\mathcal{B}_{2}\right|+2 \alpha_{1} \\
& =4 m-\left|\mathcal{B}_{1}\right|-2\left|\mathcal{B}_{2}\right|-3\left|\mathcal{B}_{\geq 3}\right|+\left|\mathcal{B}_{2}\right|+2 \alpha_{1} \\
& =3 m-\left|\mathcal{B}_{2}\right|-3\left(|\mathcal{B}|-m-\left|\mathcal{B}_{2}\right|\right)+2 \alpha_{1} \\
& =2\left|\mathcal{B}_{2}\right|+2 \alpha_{1} .
\end{aligned}
$$

Hence, $\left|\mathcal{B}_{2}\right|+\alpha_{1}=m$.
Remark 2.4 It would be interesting to know whether counting the number of columns with entries of different sign provides the same condition on $\left|\mathcal{B}_{2}\right|$, similar to that obtained for $\left|\mathcal{B}_{1}\right|$. For the sake of completeness and to make the reader more familiar with our approach, we have included such a condition at this place.

For given $n$, let $\alpha_{1}, \alpha_{2}$ and $\alpha_{\geq 3}$ be the number of 1 -, 2 - and $\geq 3$ alternating sequences, and let $\alpha_{2, \geq 3}$ denote the number of pairs of blocks $B, B^{\prime}$ with $B \in \mathcal{B}_{2}, B^{\prime} \in \mathcal{B}_{\geq 3}$ or vice versa. We obtain the following:

## Lemma 2.5

$$
\alpha_{1}+\alpha_{2, \geq 3}=\alpha_{2}+\alpha_{\geq 3}
$$

Proof: Any 1-, 2- or $\geq 3$-alternating sequence is preceded (followed) by a 2 - or 3 -, 1 - or $\geq 3$-, 1 - or 2 -alternating sequence, respectively.
Let us examine the first case, i.e. that of a 1-alternating sequence. Counting the number of columns with entries of different signs gives us a contribution of $(\ell-1)$ for such a sequence, if $\ell$ denotes the length of it.

For a 2-alternating sequence preceded and followed by a 1-alternating one, the total contribution will be $(\ell-1)$ again. If, however, such a sequence is preceded or followed by $\mathrm{a} \geq 3$-alternating sequence (see Figure 3 ), one or two consecutive pairs of blocks $B, B^{\prime}$ with $B \in \mathcal{B}_{2}, B^{\prime} \in \mathcal{B}_{\geq 3}$ or vice versa, will appear and contribute by an additional value of 1 .

In that case, there is another contribution of 1 , that will be included in the contribution of the $\geq 3$-alternating sequence.

Finally, for $\geq 3$-alternating sequences: The overall contribution of such $\mathrm{a} \geq 3$-alternating sequence is $3 \ell-1$. Also, observe that the pair of blocks $B, B^{\prime}$ with $B \in \mathcal{B}_{\geq 3}$, the last block of this sequence, and $B^{\prime} \in \mathcal{B}_{2}$, the first of the following 2 -alternating one, again contribute by 1 to the value $\alpha_{2, \geq 3}$.

Altogether, counting the number of columns with entries of different signs in $H_{1}$ and $H_{4}$ gives the condition:

$$
\sum_{i \in I}\left(\ell_{i}-1\right)+\sum_{j \in J}\left(\ell_{j}-1\right)+\sum_{k \in K}\left(3 \ell_{k}-1\right)+\alpha_{2, \geq 3}=2 m
$$

where $I, J, K$, denote the sets of $1-2$ - and $\geq 3$-alternating sequences, respectively, and $\ell$ their length.

We obtain:

$$
\left|\mathcal{B}_{1}\right|-\alpha_{1}+\left|\mathcal{B}_{2}\right|-\alpha_{2}+3\left|\mathcal{B}_{\geq 3}\right|-\alpha_{\geq 3}+\alpha_{2, \geq 3}=2 m
$$

Since, by Lemma 2.1,

$$
\left|\mathcal{B}_{1}\right|+\left|\mathcal{B}_{2}\right|+3\left|\mathcal{B}_{\geq 3}\right|=4 m-2\left|\mathcal{B}_{1}\right|-2\left|\mathcal{B}_{2}\right|
$$

$$
4 m-\alpha_{1}-\alpha_{2}-\alpha_{\geq 3}+\alpha_{2, \geq 3}=2\left|\mathcal{B}_{1}\right|+2\left|\mathcal{B}_{2}\right|
$$

By Lemma 2.2, we obtain:

$$
2 m-\alpha_{1}-\alpha_{2}-\alpha_{\geq 3}+\alpha_{2, \geq 3}=2\left|\mathcal{B}_{2}\right|
$$

Since, by Lemma 2.3,

$$
2 m-2\left|\mathcal{B}_{2}\right|=2 \alpha_{1}
$$

we obtain as stated

$$
\alpha_{1}+\alpha_{2, \geq 3}=\alpha_{2}+\alpha_{\geq 3}
$$

We are now ready to show the nonexistence of a circulant Hadamard matrix for the following four particular situations:

$$
\text { i) } \alpha_{1}=1, \text { ii) } \alpha_{1}=m, \text { iii) } \alpha_{1}=m-1, \text { iv) } \alpha_{1}=2
$$

Theorem 2.6 If in $H_{1}$, there is only one 1-alternating sequence (of length $m$ ), or if there are $m$ such sequences (all of length 1 ), or if the number of 1-alternating sequences is $m-1$, then there is no circulant Hadamard matrix $H$ with $H_{1}$ as first row.

Proof: We consider the three cases.

$$
\underline{\text { Case } \alpha_{1}=1}
$$

We know already, from Lemmata 2.1, 2.2 and 2.3, that:

- the total number of blocks is $2 m$,
- that of 1-blocks is $m$,
$-\left|\mathcal{B}_{2}\right|+\alpha_{1}=m$.
Therefore, since $n=4 m$, there is exactly one more block of size $m+2$, and if we suppose that this particular block precedes the 1-alternating sequence (clockwise), we obtain a first representation of $H_{1}$ for $\alpha_{1}=1$

Evaluation of the scalar product of $H_{1}$ and $H_{5}$ gives:

$$
(m-4)+0+2(m-3)+0+(m-2)+0=4 m-12
$$

which allows for orthogonality only if $m=3$, contradicting the condition on $m$ to be an odd square integer.

By symmetry, we obtain the same result if the particular $(m+2)$-block follows the 1-alternating sequence.

If, now, the $(m+2)$-block is situated "in between" the sequence of 2 blocks,
we may suppose that

$$
m-1=k_{1}+k_{2}, \text { with } k_{1}, k_{2} \text { both even or both odd. }
$$

Evaluating the scalar product of $H_{1}$ and $H_{5}$ gives:

$$
(m-4)+0+2\left(k_{1}-2\right)+0+(m-2)+2\left(k_{2}-2\right)+0=4 m-16
$$

Orthogonality implies $m=4$, contradicting the condition on $m$ to be odd. We obtain the same result for the case $k_{1}=1$ or $k_{2}=1$, so that altogether, $H_{1}$ cannot be the defining row of a circulant Hadamard matrix.

## Case $\alpha_{1}=m:$

By Lemma 2.3, there is no 2-block in $H_{1}$ and $m$ blocks remain to cover $3 m$ elements, i.e. besides the $m$ 1-blocks, there are exactly $m$ 3-blocks, and both types alternate in $H_{1}$. But then the scalar product of $H_{1}$ and $H_{5}$ gives $4 m>0$ and $H_{1}$ cannot define a circulant Hadamard matrix either.
$\underline{\text { Case } \alpha_{1}=m-1}:$
In this case there is exactly one consecutive pair of 1-blocks, and by Lemma 2.3, there is exactly one 2 -block, so that $3 m-2$ elements have to be covered by $m-1$ blocks of size $\geq 3$. This is only possible with $(m-2)$ 3 -blocks and one 4 -block. Moreover, the unique 2-block, say $B$, cannot be preceded and followed by $\mathrm{a} \geq 3$-block. Therefore, we come up with two possibilities:
a) $B$ is preceded and followed by a 1-alternating sequence.
b) $B$ is preceded or followed (but not both) by a $\geq 3$-block.

Just observe, that in situation a) exactly two $\geq 3$-blocks follow each other. We count the number of columns with different signs in $H_{1}$ and $H_{5}$ and observe that a contribution (of 2 ) to this number is given only by

- the two consecutive 1-blocks;
- the unique 2-block;
- the unique 4 -block;
- exactly one of the 3 -blocks.

By orthogonality,

$$
2 m=8 \text {, }
$$

a contradiction to the condition on $m$ to be odd.
In situation (b), no 3-block contributes any more, and orthogonality of $H_{1}$ and $H_{5}$ gives

$$
2 m=6,
$$

a contradiction to the condition that $m$ has to be an odd square integer.
In the following, we will show how the orthogonality of $H_{1}$ and $H_{5}$ can be exploited to obtain a further condition involving $\left|\mathcal{B}_{2}\right|$ and $\left|\mathcal{B}_{3}\right|$, which we will use afterwards to exclude the situation where $\alpha_{1}=2$.

For this, we need to describe the possible types of 1-alternating and 2alternating sequences (up to symmetry)

It is not difficult to verify that if we count the columns of $H_{1}$ and $H_{5}$ with equal sign, the contribution of these 6 types will be $3,2,1$ and $\ell, \ell-1, \ell-2$, respectively.

For 2-alternating sequences, we obtain 3 similar types, whose contributions will be $2 \ell, 2 \ell-1,2 \ell-2$, respectively:
with the properties that

- type 1 is preceded and followed by a $\geq 3$-block;
- type 2 is preceded by a 1 -alternating sequence and followed by a $\geq 3$ block (or vice versa);
- type 3 is preceded and followed by a 1 -alternating sequence.

If now $\alpha_{1}^{i}$ denotes the number of 1 -alternating sequences of type $i$, for $i=1, \ldots, 6$, and $\alpha_{2}^{j}$ the number of 2-alternating sequences of type $j$, for $j=1, \ldots, 3$, we get

Lemma 2.7 If $H$ is a circulant Hadamard matrix, then one has

$$
2\left|\mathcal{B}_{2}\right|+2\left|\mathcal{B}_{3}\right|=\left(\alpha_{1}^{2}+2 \alpha_{1}^{3}\right)+\left(2 \alpha_{1}^{4}+3 \alpha_{1}^{5}+4 \alpha_{1}^{6}\right)+\left(\alpha_{2}^{2}+2 \alpha_{2}^{3}\right) .
$$

## Proof:

We can describe the total number of columns of $H_{1}$ and $H_{5}$, whose entries have equal sign, by the following expression

$$
L:=3 \alpha_{1}^{1}+2 \alpha_{1}^{2}+\alpha_{1}^{3}+C+D,
$$

where

$$
C:=\sum_{i \in I} \ell_{i}+\sum_{j \in J}\left(\ell_{j}-1\right)+\sum_{k \in K}\left(\ell_{k}-2\right),
$$

and

$$
D:=\sum_{p \in P} 2 \ell_{p}+\sum_{q \in Q}\left(2 \ell_{q}-1\right)+\sum_{r \in R}\left(2 \ell_{r}-2\right)+\sum_{B \in \mathcal{B}_{\geq 4}}(|B|-4)+\left|\mathcal{B}_{3}\right|,
$$

expression in which $\sum_{j \in J}\left(\ell_{j}-1\right)$, for instance, relates to all 1-alternating sequences $S_{j}, j \in J$, whose contribution equals $\ell_{j}-1$, i.e., which are of type 5 .

We know the following:
i) $\alpha_{1}^{1}+\alpha_{1}^{2}+\alpha_{1}^{3}+\sum_{i \in I} \ell_{i}+\sum_{j \in J} \ell_{j}+\sum_{k \in K} \ell_{k}=\left|\mathcal{B}_{1}\right|=m$, by Lemma 2.2,
ii) $\sum_{p \in P} \ell_{p}+\sum_{q \in Q} \ell_{q}+\sum_{r \in R} \ell_{r}=\left|\mathcal{B}_{2}\right|, \quad$ and
iii) $\alpha_{1}^{1}+\alpha_{1}^{2}+\alpha_{1}^{3}+\alpha_{1}^{4}+\alpha_{1}^{5}+\alpha_{1}^{6}=\alpha_{1}$.

Therefore,

$$
\begin{aligned}
3 \alpha_{1}^{1}+2 \alpha_{1}^{2}+\alpha_{1}^{3}+C & =2 \alpha_{1}^{1}+\alpha_{1}^{2}+\left|\mathcal{B}_{1}\right|-\alpha_{1}^{5}-2 \alpha_{1}^{6} \\
& =\alpha_{1}+m+\alpha_{1}^{1}-\alpha_{1}^{3}-\alpha_{1}^{4}-2 \alpha_{1}^{5}-3 \alpha_{1}^{6}
\end{aligned}
$$

We also have

$$
\sum_{p \in P} 2 \ell_{p}+\sum_{q \in Q}\left(2 \ell_{q}-1\right)+\sum_{r \in R}\left(2 \ell_{r}-2\right)=2\left|\mathcal{B}_{2}\right|-\alpha_{2}^{2}-2 \alpha_{2}^{3} .
$$

Thus, if we put

$$
\delta:=\alpha_{1}+m+\alpha_{1}^{1}-\alpha_{1}^{3}-\alpha_{1}^{4}-2 \alpha_{1}^{5}-3 \alpha_{1}^{6}+2\left|\mathcal{B}_{2}\right|-\alpha_{2}^{2}-2 \alpha_{2}^{3},
$$

then

$$
\begin{aligned}
L & =\delta+\sum_{B \in \mathcal{B}_{\geq 4}}|B|-4\left|\mathcal{B}_{\geq 4}\right|+\left|\mathcal{B}_{3}\right| \\
& =\delta+4 m-\left|\mathcal{B}_{1}\right|-2\left|\mathcal{B}_{2}\right|-3\left|\mathcal{B}_{3}\right|-4\left(|\mathcal{B}|-\left|\mathcal{B}_{1}\right|-\left|\mathcal{B}_{2}\right|-\left|\mathcal{B}_{3}\right|\right)+\left|\mathcal{B}_{3}\right| \\
& =\delta-m+2\left|\mathcal{B}_{2}\right|+2\left|\mathcal{B}_{3}\right|, \text { by Lemmata } 2.1 \text { and } 2.2 \\
& =\delta-\alpha_{1}+\left|\mathcal{B}_{2}\right|+2\left|\mathcal{B}_{3}\right|, \text { by Lemma } 2.3 \\
& =m+\left(\alpha_{1}^{1}-\alpha_{1}^{3}-\alpha_{1}^{4}-2 \alpha_{1}^{5}-3 \alpha_{1}^{6}\right)+3\left|\mathcal{B}_{2}\right|+2\left|\mathcal{B}_{3}\right|-\alpha_{2}^{2}-2 \alpha_{2}^{3} .
\end{aligned}
$$

This last expression, by orthogonality, has to be equal to $2 m$.
So, by Lemma 2.3 and by iii) above, we get

$$
\left(\alpha_{1}^{1}-\alpha_{1}^{3}-\alpha_{1}^{4}-2 \alpha_{1}^{5}-3 \alpha_{1}^{6}\right)=\left(\alpha_{1}-\alpha_{1}^{2}-2 \alpha_{1}^{3}-2 \alpha_{1}^{4}-3 \alpha_{1}^{5}-4 \alpha_{1}^{6}\right)
$$

and

$$
\left|\mathcal{B}_{2}\right|+\alpha_{1}=m=\alpha_{1}-\alpha_{1}^{2}-2 \alpha_{1}^{3}-2 \alpha_{1}^{4}-3 \alpha_{1}^{5}-4 \alpha_{1}^{6}+3\left|\mathcal{B}_{2}\right|+2\left|\mathcal{B}_{3}\right|-\alpha_{2}^{2}-2 \alpha_{2}^{3},
$$

which gives our result:

$$
2\left|\mathcal{B}_{2}\right|+2\left|\mathcal{B}_{3}\right|=\left(\alpha_{1}^{2}+2 \alpha_{1}^{3}\right)+\left(2 \alpha_{1}^{4}+3 \alpha_{1}^{5}+4 \alpha_{1}^{6}\right)+\left(\alpha_{2}^{2}+2 \alpha_{2}^{3}\right) .
$$

Lemma 2.7 can now be used to exclude another situation:
Theorem 2.8 If $H_{1}$ contains exactly two 1-alternating sequences, i.e. if $\alpha_{1}=2$, then $H$ is not a circulant Hadamard matrix.

## Proof:

Lemma 2.3 implies that $\left|\mathcal{B}_{2}\right|=m-\alpha_{1}=m-2$. There are two blocks left, by Lemma 2.1, to cover the remaining $m+4$ elements. Hence $\left|\mathcal{B}_{3}\right| \in\{0,1\}$ for $m \geq 3$. Also, $\alpha_{2}^{1}+\alpha_{2}^{2}+\alpha_{2}^{3} \leq 4$, with equality if the two 1 -alternating sequences and the two remaining blocks from $\mathcal{B}_{\geq 3}$ are all alternating with a 2 -alternating sequence.

Since

$$
\left(\alpha_{1}^{2}+2 \alpha_{1}^{3}\right)+\left(2 \alpha_{1}^{4}+3 \alpha_{1}^{5}+4 \alpha_{1}^{6}\right)+\left(\alpha_{2}^{2}+2 \alpha_{2}^{3}\right) \leq 4+4+8=16,
$$

we get by Lemma 2.7

$$
m-2+\left|\mathcal{B}_{3}\right|=\left|\mathcal{B}_{2}\right|+\left|\mathcal{B}_{3}\right| \leq 8, \text { with }\left|\mathcal{B}_{3}\right| \in\{0,1\} .
$$

Hence $m \leq 10$ or $m \leq 9$, both cases for which no circulant Hadamard matrix exists.

## 3 Conclusion and further work

Future work should include an analysis of further rows of $H$ along the same line. This is what we are currently doing.
