INEQUALITIES FOR *k***-REGULAR PARTITIONS**

ABSTRACT. We build upon the work by Bessenrodt and Ono, as well as Beckwith and Bessenrodt concerning the combined additive and multiplicative behavior of the k-regular partition functions $p_k(n)$. Our focus is on addressing the solutions of the Bessenrodt–Ono inequality

$$p_k(a) p_k(b) > p_k(a+b).$$

We determine the sets E_k and F_k consisting of all pairs (a, b), where we have equality or the opposite inequality. Bessenrodt and Ono previously determined the exception sets E_{∞} and F_{∞} for the partition function p(n). We prove by induction that $E_k = E_{\infty}$ and $F_k = F_{\infty}$ if and only if $k \ge 10$. Beckwith and Bessenrodt used analytic methods to consider $2 \le k \le 6$, while Alanazi, Gagola, and Munagi studied the case k = 2 using combinatorial methods. Finally, we present a precise and comprehensive conjecture on the log-concavity of the kregular partition function extending previous speculations by Craig and Pun. The case k = 2 was recently proven by Dong and Ji.

1. INTRODUCTION

In this paper we investigate partition functions [An98, On04] and provide a complete solution for the Bessenrodt–Ono inequality [BO16] for k-regular partition functions $p_k(n)$ [Ha71]. We extend the previous results for $2 \le k \le 6$ by Beckwith and Bessenrodt [BB16] to $k \ge 2$, proving that for $k \ge 10$, the solutions coincide with the solutions of the partition function p(n).

Let $\{\alpha(n)\}_n$ denote a sequence of positive integers. The sequence satisfies the Bessenrodt–Ono inequality for a pair (a, b) of positive integers if

(1.1)
$$\Delta(a,b) := \alpha(a)\,\alpha(b) - \alpha(a+b) > 0.$$

For partitions $\alpha(0) = \alpha(1) = 1$ and due to symmetry, we only consider pairs with $1 < a \leq b$. Let *E* denote the set of pairs where $\Delta(a, b) = 0$ and *F* the set, where $\Delta(a, b) < 0$. For *k*-regular partition functions, we use the symbols $\Delta_k(a, b)$, E_k and F_k , where $k \in \{2, 3, 4, \ldots\} \cup \{\infty\}$.

Let us recall the definition of the k-regular partition function $p_k(n)$. A partition of a positive integer n is a finite nonincreasing sequence of positive integers that sum to n. These integers are called the parts of the partition. The partition function p(n) is the number of partitions of n ([An98], Section 1.1). Let $k \ge 2$. The k-regular partition function $p_k(n)$ is the number of partitions of n in which none of the parts is a multiple of k. Note, that $p_k(n)$ is also equal to the number of partitions with each part appearing at most k - 1 times. Therefore, the number of partitions of n with odd parts is equal to the number of partitions with different parts. Based on the results of this paper and the fact that $p_k(n) = p(n)$ for k > n, we define $p_{\infty}(n) := p(n)$.

In 2016, Bessenrodt and Ono [BO16] discovered the following property of the partition function $p_{\infty}(n)$.

Theorem 1.1 (Bessenrodt, Ono 2016). Let $1 < a \leq b$. Then the Bessenrodt–Ono inequality (1.1) is satisfied for the partition function $p_{\infty}(n)$, except for the pairs

$$E_{\infty} = \{(2,6), (2,7), (3,4)\},\$$

$$F_{\infty} = \{(2,2), (2,3), (2,4), (2,5), (3,3), (3,5)\}$$

Bessenrodt and Ono provided an analytic proof ([BO16], Section 2) utilizing deep results by Lehmer [Le39] and Rademacher [Ra37] for the partition function, built on the circle method by Hardy and Ramanujan. A second combinatorial proof was found by Alanazi, Gagola, and Munagi [AGM17]. Their sophisticated proof involved an injective map and an induction. A third algebraic proof was provided in [HN22] using induction, and was also generalized to plane partitions [HNT23].

Beckwith and Bessenrodt [BB16] demonstrated that k-regular partition functions for $2 \le k \le 6$ also fulfill the Bessenrodt–Ono inequality (see Section 2 for their result).

Moreover, many more sequences turned out to satisfy (1.1). Chern, Fu, and Tang [CFT18] generalized and proved the Bessenrodt–Ono inequality (BO) for k-colored partitions. Hou and Jagadeesan [HJ18] extended on the numbers of partitions with ranks in a given residue class modulo 3 and Males [Ma20] did so for general modulus. A modified BO was presented in [HN19]. Dawsey and Masri [DM19] proved BO for the Andrews *spt*-function, and Gajdzica did so for A-partitions. In [HNT20], the polynomization of the k-colored partitions [CFT18] was initiated, leading to a continous version of the Chern, Fu, Tang result [CFT18] for k-regular partitions. The proof is utilizing an Euler-type recursion formula for the involved polynomials and their derivatives. This polynomization approach and the underlying proof

strategy were also successfully applied by Li [Li23] for the overpartition function and by Gajdzica et al. ([GHN24], Theorem 1.3) for A-partition functions.

Recently, several interesting and important papers have explored the asymptotic behavior leading to log-concavity properties and the Bessenrodt–Ono inequality, as well as their relations. We refer to Bringmann, Franke, and Heim ([BFH24], Theorem 1.3 and Theorem 1.5), Benfield and Roy ([BR24], Theorem 1.1) and Gajdzica, Miska, and Ulas ([GMU24], Theorem 2.1 and Theorem 3.1).

2. Results on k-regular partitions

Let $k \geq 2$. The generating function for the number of k-regular partitions is given by

$$\sum_{n=0}^{\infty} p_k(n) q^n = \prod_{n=1}^{\infty} \frac{\left(1 - q^{kn}\right)}{\left(1 - q^n\right)}.$$

Note that

$$\prod_{n=1}^{\infty} \frac{(1-q^{2n})}{(1-q^n)} = \prod_{n=1}^{\infty} \left(1-q^{2n-1}\right)^{-1},$$

which implies that the number of 2-regular partitions of n is equal to the number of partitions of n with odd parts. We also refer to Glaisher's generalization for arbitrary k ([An98], Corollary 1.3).

Let
$$g_k(n) := \sigma(n) - k\sigma(n/k)$$
, where $\sigma(n) := \sum_{d|n} d$ and $\sigma(x) = 0$ if $x \notin \mathbb{N}$. Then

$$\sum_{n=0}^{\infty} p_k(n) q^n = \exp\left(\sum_{n=1}^{\infty} g_k(n) \frac{q^n}{n}\right).$$

This follows from the identity $\prod_{n=1}^{\infty} (1-q^n) = \exp\left(-\sum_{n=1}^{\infty} \sigma(n) q^n/n\right)$ and implies

$$n p_k(n) = \sum_{\ell=1}^n g_k(\ell) p_k(n-\ell),$$

with initial value $p_k(0) = 1$. Beckwith and Bessenrodt proved, in the same spirit as [BO16], that the k-regular partition function for $2 \le k \le 6$ satisfies (1.1). They utilized a Rademacher-type formula for $p_k(n)$ given by Hagis [Ha71] and determined for each k the exception sets E_k and F_k . We recall the following: Let a, b, k be positive integers with $1 < a \le b$ and let $k \ge 2$. Then we denote by E_k the set of all pairs (a, b) with equality in (1.1) and F_k the set of all pairs (a, b) with

$$p_k(a) p_k(b) < p_k(a+b).$$

Theorem 2.1 (Beckwith, Bessenroth 2016). Let a, b, k be integers with $1 < a \le b$ and $2 \le k \le 6$. Then the Bessenrodt–Ono inequality

(2.1)
$$p_k(a) p_k(b) > p_k(a+b)$$

is satisfied for all pairs, except for the pairs presented in Table 1 for E_k and F_k . Therefore, let n_k and m_k be given by the following table:

k	2	3	4	5	6

Then for any $a, b \ge n_k$ and $a + b \ge m_k$, the Bessenrodt-Ono inequality (2.1) is valid.

Further, Alanzi, Gagola, and Munagi [AGM17] demonstrated that their combinatorial proof of the Bessenrodt–Ono inequality can, in principle, be adapted to the k-regular case. They provided a proof for k = 2 and indicated that the number of cases increase rapidly for larger k.

We extend the table of Beckwith and Bessenrodt for E_k and F_k to $7 \le k \le 10$. This leads to Table 2.

We observe that $E_k = E_{\infty}$ and $F_k = F_{\infty}$ for k = 10 and prove that this even holds true for all $k \ge 10$.

Theorem 2.2. Let $a, b, k \ge 2$ be integers, and $p_k(n)$ be the k-regular partition function. Then the Bessenrodt-Ono inequality

$$p_k(a) p_k(b) > p_k(a+b)$$

holds true for all pairs (a,b) except for pairs in E_k , where equality is in place and F_k , where $p_k(a) p_k(b) < p_k(a+b)$. For $2 \le k \le 10$, the sets E_k and F_k are given by Tables 1 and 2. For all $k \ge 10$ we have

$$E_k = E_\infty$$
 and $F_k = F_\infty$.

3. Proof of Theorem 2.2

We closely follow the proof scheme ([HN22], Section 2) proposed to prove Bessenrodt– Ono inequalities.

First, we estimate the arithmetic function $g_k(n)$ and the k-regular partition function $p_k(n)$ with the following upper and lower bounds, independent of k.

Lemma. Let $k \ge 2$. Then

(3.1)
$$g_k(n) \leq n \left(1 + \ln(n)\right), \\ p_k(n) > 2^{\sqrt{2n/3 + 1/4} - 3/2}.$$

Proof. The upper bound for $g_k(n) \leq \sigma(n)$ follows easily by integral comparison with the bound for n > 1. The lower bound of $p_k(n)$ cannot be directly related to p(n) as given in ([HN22], equation (2.2)), and requires some additional investigation.

The lower bound of $p_k(n)$ follows from

$$p_k(n) \ge 4^{\left\lfloor \sqrt{2n/3 + 1/2} - 1/2 \right\rfloor - \left\lfloor \left\lfloor \sqrt{2n/3 + 1/4} - 1/2 \right\rfloor / k \right\rfloor} > 4^{(k-1)\left(\sqrt{2n/3 + 1/4} - 3/2\right) / k}.$$

Here $\lfloor x \rfloor$ denotes the usual floor symbol. Consider partitions of n using only parts from $\{1, 2, \ldots, \lfloor \sqrt{n/3} \rfloor\} \setminus k \mathbb{N}$ with multiplicity at most 3. To any admissible submultiset, we can assign a partition. The largest value we obtain is

$$3 \sum_{m=1}^{\lfloor \sqrt{2n/3 + 1/4} - 1/2 \rfloor} m \leq \frac{3}{2} \left(\sqrt{2n/3 + 1/4} - 1/2 + 1 \right) \left(\sqrt{2n/3 + 1/4} - 1/2 \right)$$
$$= 3 \frac{2n/3 + 1/4 - 1/4}{2} = n.$$

Also, we have removed $\left\lfloor \frac{1}{k} \left\lfloor \sqrt{\frac{2n}{3} + \frac{1}{4} - \frac{3}{2}} \right\rfloor \right\rfloor$ elements from the set. This demonstrates the claim.

Remark. Note that the proof shows that we could even choose as a lower bound

$$p_k(n) \ge 2^{\left\lfloor \sqrt{2n/3 + 1/4} - 1/2 \right\rfloor}.$$

3.1. Proof of Theorem 2.2 for k > 3. Let A := 2 and B := 10. Let $n \ge B$. We say the statement S(n) holds true if for all partitions n = a + b with $a, b \ge A$:

$$\Delta_k(a,b) := p_k(a) \, p_k(b) - p_k(a+b) > 0.$$

We assume that $n > N_0 > 1$ and S(m) hold true for all $B \le m \le n - 1$. For $B \le m \le N_0$, we demonstrate S(m) through a direct computer calculation with PARI/GP. It will turn out that we can choose $N_0 = 2938$.

We obtain the following expressions for $\Delta_k(a, b) = L + R$:

$$L := -\sum_{\ell=1}^{b} \frac{g_k(\ell+a)}{a+b} p_k(b-\ell),$$

$$R := \sum_{\ell=1}^{a} \left(\frac{g_k(\ell)}{a} p_k(a-\ell) p_k(b) - \frac{g_k(\ell)}{a+b} p_k(a+b-\ell) \right)$$

Further, we will refine the right sum R into

$$R = R_1 + R_2 + R_3.$$

3.1.1. Left sum L. We have $L > -b p_k(b) (1 + \ln(a+b))$.

3.1.2. Right sum R. Let

$$\ell_0 := a - \max\{B - b, A\} + 1.$$

Therefore, $\ell_0 = a - \max\{9 - b, 1\}$. Let

$$R_1 := \sum_{\ell=1}^{1} f_\ell(a,b), \ R_2 := \sum_{\ell=2}^{\ell_0-1} f_\ell(a,b), \ R_3 := \sum_{\ell=\ell_0}^{a} f_\ell(a,b),$$
$$f_\ell(a,b) := \frac{g_k(\ell)}{a} p_k(a-\ell) p_k(b) - \frac{g_k(\ell)}{a+b} p_k(a+b-\ell).$$

The sum R_1 . We obtain the lower bound:

$$R_1 > \frac{b}{2a^2} p_k (a-1) p_k (b)$$
.

The sum R_2 . The second sum: $R_2 > 0$. The sum R_3 .

We split the third sum again into three parts: $R_3 = R_{31} + R_{32} + R_{33}$, where

(3.2)
$$R_{31} := \sum_{\ell=\ell_0}^{a-A} f_{\ell}(a,b) > 5 (4 - p_{\infty}(8)) (1 + \ln(a)),$$
$$R_{32} := \sum_{\ell=a-A+1}^{a-1} f_{\ell}(a,b) > -p_k(b) (1 + \ln(a)),$$
$$R_{33} := \sum_{\ell=a}^{a} f_{\ell}(a,b) \ge 0.$$

We first use that $p_k (9 - b) p_k (b) \ge p_k (9)$, which leads to at most 5 summands. The estimation in (3.2) follows from $p_k(a - \ell) \ge p_k(2)$. For the estimation, we use that

$$p_k(b) \ge p_k(2) = 2, \ \frac{1}{a+b} < \frac{1}{a}, \ \text{and} \ p_k(a+b-\ell) \le p_k(8) \le p_\infty(8).$$

We obtain

$$R_3 > -23 b p_k(b) (1 + \ln (a + b)).$$

3.1.3. Final step. Putting everything together leads to:

(3.3)
$$\Delta_k(a,b) > \frac{b \, p_k(b)}{2 \, a^2} \left(-48 \, a^2 \, \left(1 + \ln\left(2a\right)\right) + 2\sqrt{2(a-1)/3 + 1/4} - 3/2 \right).$$

As the final step, we used the property (3.1). For $a \to \infty$ we can immediately observe that this is positive since the second term grows in *a* faster than $a \mapsto a^2 (1 + \ln (2a))$. In fact, the expression (3.3) is positive for all $a \ge 1470$. Note that if a < 1470, then $a + b \le 2a \le N_0$.

Note that for $k > N_0$, we have $p_k(n) = p_{\infty}(n)$ for all $n \le N_0$. Therefore, we only have to check the inequality for $k \le N_0$ and $n \le N_0$. Hence, $\Delta_k(a, b) > 0$, which proves the Theorem.

Remark. Note that we can also prove the cases $k \in \{2, 3\}$ directly with our method from [HN22], but then more adjustments are necessary as we cannot directly use ([HN22], (2.8)) anymore. For k = 2, we can choose A = 3 and B = 22 with $N_0 = 3662$, and for k = 3, we can choose A = 2 and B = 17 with $N_0 = 3776$. The crucial step is to adjust the estimate of R_{31} in (3.2) for these cases.

4. Log-concavity

In this final section, we provide further evidence, that the k-regular partition function and the partition function $p_{\infty}(n)$ share similar properties up to small ks. We indicate that, as in the case of the Bessenrodt–Ono inequality, this may also apply to the log-concave property. Nicolas [Ni78] and DeSalvo and Pak [DP15] proved that the partition function $p_{\infty}(n)$ is log-concave at n:

$$p(n)_{\infty}^2 \ge p_{\infty}(n-1) \, p_{\infty}(n+1)$$

if and only if $n \geq 25$ or n is even. For k-regular partitions, building on Hagis' Rademacher-type formula and a new method developed by Griffin, Ono, Rolen, and Zagier [GORZ19], Craig and Pun [CP20] proved that the k-regular partition functions $p_k(n)$ satisfy higher-order Turán inequalities for sufficiently large n dependent on k. Let N_k be the smallest number, such that $\{p_k(n)\}_n$ is log-concave at n

$$p_k(n)^2 \ge p_k(n-1) p_k(n+1)$$

for all $n \ge N_k$. We calculated all exceptions for $2 \le k \le 100$ and $1 \le n \le 1000$. For $2 \le k \le 20$, we have provided them in Table 3, where for k = 3, the exceptions are all odd $1 \le n \le 57$. This is compatible with the numbers conjectured by Craig and Pun ([CP21], Remark 1.3) for $2 \le k \le 4$. Recently, Dong and Ji [DJ24] proved the conjecture for k = 2.

Similar to the Bessenrodt–Ono inequality, we believe that the set of exceptions stabilizes for large k and is the same as the one of $p_{\infty}(n)$. This set is given by all odd numbers $1 \le n \le 25$. We put $N_{\infty} := 26$.

Conjecture. Let $k \ge 2$. Let N_k be the smallest integer, such that $\{p_k(n)\}_n$ is log-concave at every $n \ge N_k$. Then $N_k = N_\infty$ if $k \ge 30$.

This is in accordance with Remark 1.3 given by Craig and Pun [CP21]. Since $p_k(n) = p_{\infty}(n)$ for k > n we also have:

Corollary. Let the conjecture hold true. Let $k \ge 30$. Then the exceptions n are the same as for $\{p_{\infty}(n)\}_{n}$.
