### K-STABILITY OF Z-STABLE C\*-ALGEBRAS

ABSTRACT. We provide a shorter new proof of the fact that  $Z$ -stable C\*-algebras are  $K_1$ -surjective using the Rørdam-Winter picture of the Jiang-Su algebra  $\mathcal Z$ . Consequently, we recapture the K-stability of  $Z$ -stable C\*-algebras.

### 1. INTRODUCTION

Operator algebraic  $K$ -theory is defined using equivalence classes of unitaries and projections in matrix amplifications over a  $C^*$ -algebra. By Bott periodicity, the K-theory of a unital C<sup>\*</sup>-algebra A is given by the higher homotopy groups of  $\mathcal{U}_{\infty}(A)$ , where  $\pi_{2n}(\mathcal{U}_{\infty}(A)) \cong$  $K_1(A)$  and  $\pi_{2n+1}(\mathcal{U}_{\infty}(A)) \cong K_0(A)$  for  $n \in \mathbb{N}$ , see [\[12,](#page-5-0) Proposition 11.4.1] for instance. On the other hand, non-stable K-theory studies the homology theory given by the higher homotopy groups of the unitary group  $\mathcal{U}(A)$  based at  $1_A$ . The K-theory of stable C<sup>\*</sup>algebras can be computed without taking matrix amplications and thus coincides with their non-stable K-theory. However, K-theory and non-stable K-theory are different in general, even in the case of commutative C<sup>\*</sup>-algebras. Take  $C(S^3)$  as an example, where we have  $K_1(C(S^3)) = \mathbb{Z}$ , but  $\pi_0(\mathcal{U}(C(S^3))) = 0$ .

In many important cases, even without stability, the  $K$ -theory and non-stable  $K$ -theory agree, see [\[9\]](#page-5-1) for noncommutative irrational tori and [\[21\]](#page-6-0) for simple C\*-algebras with real rank zero and stable rank one. In general, exact characterisations of when stable and nonstable K-theory coincide are not known, even at the level of  $\pi_0$ . Blackadar raised a question in [\[1\]](#page-5-2) of when a C<sup>\*</sup>-algebra is  $K_1$ -injective or  $K_1$ -surjective, namely when the canonical homomorphism from  $\pi_0(\mathcal{U}(A))$  to  $K_1(A)$  is injective or surjective. A stronger notion called K-stability is defined by Thomsen in [\[16\]](#page-5-3), which means that for any  $n \in \mathbb{N}$ , the canonical inclusion  $\mathcal{U}(M_m \otimes A) \to \mathcal{U}_{\infty}(A)$  induces isomorphisms between higher homotopy groups of  $\mathcal{U}(M_m \otimes A)$  and the K-theory of A. C<sup>\*</sup>-algebras are K-stable under certain structural conditions, such as having stable rank one in [\[9\]](#page-5-1) or being simple and purely infinite in [\[21\]](#page-6-0). However, it remains open whether simple  $C^*$ -algebras are automatically K-stable or  $K_1$ -isomorphic.

Recently, non-stable K-theory has shown its importance in the new abstract approach of classification for C\*-algebras initiated in [\[14\]](#page-5-4). In the history of the Elliot classification program, a central object is the Jiang-Su algebra  $Z$ , which was originally constructed in [\[8\]](#page-5-5) as the inductive limit of dimension drop algebras, with explicitly defined connecting maps. Tensorial absorption of  $\mathcal Z$  excludes the exotic C\*-algebras constructed in [\[19\]](#page-6-1), [\[10\]](#page-5-6), [\[17\]](#page-5-7) and is needed to obtain a satisfying classification theorem for simple separable nuclear  $C^*$ -algebras by K-theory and traces. Though this is a different tensorial absorption property from stability, it does imply similar nice K-theoretical properties. For simple  $\mathcal{Z}\text{-stable}$  exact  $C^*$ -algebras, a dichotomy in [\[4\]](#page-5-8) shows that they are either purely infinite or stably finite.

Rørdam proved in 2004 in [\[11\]](#page-5-9) that simple stably finite  $Z$ -stable C<sup>\*</sup>-algebras necessarily have stable rank one, by extensively studying structural properties of  $Z$ -stable  $C^*$ -algebras. Then combining results in [\[21\]](#page-6-0) and [\[9\]](#page-5-1), one can conclude that  $Z$ -stability implies K-stability for simple C\*-algebras.

The result that  $\mathcal Z$ -stable C\*-algebras are K-stable in the general setting is actually proven ealier by Jiang in his unpublished paper  $[7]$ , which in particular implies  $K_1$ -injectivity and  $K_1$ -surjectivity for  $\mathcal{Z}$ -stable C\*-algebras. In the new abstract approach to the classification theorem in [\[2\]](#page-5-11),  $K_1$ -injectivity for certain non-simple  $\mathcal Z$ -stable C\*-algebras plays an important role in [\[2,](#page-5-11) Section 5.4] to obtain the uniqueness theorem for maps. Since the result in [\[7\]](#page-5-10) remains unpublished, a short and self-contained new proof for  $K_1$ -injectivity of  $\mathcal{Z}\text{-stable}$ <sup>\*</sup>algebras was provided in [\[2,](#page-5-11) Section 4.2]. The proof takes advantage of a modern description of  $Z$ , given by Rørdam and Winter in [\[13\]](#page-5-12), around ten years after its introduction. They realize  $\mathcal Z$  as a stationary inductive limit of the so-called generalized dimension drop algebras, whose fibres are UHF-algebras instead of finite matrix algebras. This should be seen as an alternative definition for  $\mathcal{Z}$ , since many fundamental properties of  $\mathcal{Z}$  can be readily obtained from this viewpoint, for instance in reproving strong self-absorption of  $\mathcal Z$  in [\[15\]](#page-5-13) and Winter's localization of the Elliott conjecture in [\[20\]](#page-6-2), which is vital in the Gong-Lin-Niu theorem [\[5\]](#page-5-14).

In this paper, we will recapture the rest of Jiang's K-stability results. Jiang's proof relies on explicit constructions of homomorphisms to produce inverse maps between higher homotopy groups when proving K-stability, which then implies  $K_1$ -injectivity and  $K_1$ -surjectivity of Z-stable C<sup>\*</sup>-algebras. In comparison, we first provide a short new proof for  $K_1$ -surjectivity of  $\mathcal Z$ -stable C<sup>\*</sup>-algebras in Section 3, using the Rørdam-Winter picture in the spirit of the  $K_1$ -injectivity proof of [\[2\]](#page-5-11). The extra flexibility is given by UHF-fibers of generalized dimension drop algebras, since  $M_n \sim$ -stable C\*-algebras are shown to have nice K-theoretical properties in Lemma [3.1](#page-2-0) and [\[2,](#page-5-11) Lemma 4.9], which is not true in general when tensoring by finite matrix algebras. With  $K_1$ -injectivity and  $K_1$ -surjectivity of  $\mathcal{Z}$ -stable C<sup>\*</sup>-algebras, we are able to recapture  $K$ -stability in Theorem [4.2,](#page-4-0) without needing to construct explicit maps.

The result in the paper is becoming increasingly important. For instance, in Toms' recent work [\[18\]](#page-5-15) on higher homotopy groups of Cuntz classes for simple approximately divisible  $C^*$ -algebras of real rank zero,  $K_1$ -surjectivity plays an important role, and it is likely that this will continue to be the case in further work in this direction.

# 2. Preliminaries

For a unital C<sup>\*</sup>-algebra A, we will denote the set of untaries in A by  $U(A)$ . For  $n \geq 1$ , we will use the notation  $1_n$  for the unit of  $M_n \otimes A$  and  $\mathcal{U}_n(A)$  for the set of unitaries in  $M_n \otimes A$ . The set of unitaries in  $\mathcal{U}_n(A)$  that are homotopic to  $1_n$  is denoted by  $\mathcal{U}_n^0(A)$ . If A is a non-unital C<sup>\*</sup>-algebra, we denote by  $\tilde{A}$  the unitization of A, with canonically associated maps  $\iota : A \to \tilde{A}$  and  $q : \tilde{A} \to \mathbb{C}$ .

**Definition 2.1.** A unital C<sup>\*</sup>-algebra A is called  $K_1$ -surjective ( $K_1$ -injective) if the group homomorphism  $\mathcal{U}(A)/\mathcal{U}^0(A) \to K_1(A), [u] \mapsto [u]_1$ , is surjective (injective).

In the non-unital case, a C\*-algebra A is called  $K_1$ -surjective  $(K_1$ -injective) if A is  $K_1$ surjective  $(K_1$ -injective).

We will also describe briefly the different descriptions of  $Z$ . For coprime integers  $p, q$ , the prime dimension drop algebra is defined to be

$$
(2.1) \t\t Z_{p,q} = \{ f \in C([0,1], M_p \otimes M_q) : f(0) \in M_p \otimes 1_q, f(1) \in 1_p \otimes M_q \}.
$$

The Jiang-Su algebra  $\mathcal Z$  was originally constructed in [\[8\]](#page-5-5) as an inductive limit of such  $\mathcal Z_{p,q}$ , together with delicately defined connecting maps. In fact, it is the unique inductive limit of prime dimension drop algebras that is unital, simple, monotracial and  $K_*(A) \cong K_*(\mathbb{C})$  by [\[8,](#page-5-5) Theorem 6.2].

The Rørdam-Winter picture of  $\mathcal Z$  uses the *generalized prime dimension drop algebra* corresponding to infinite coprime supernatural numbers  $\mathfrak p$  and  $\mathfrak q$ , which is defined by

$$
(2.2) \qquad \mathcal{Z}_{\mathfrak{p},\mathfrak{q}} = \left\{ f \in C([0,1], M_{\mathfrak{p}} \otimes M_{\mathfrak{q}}) : f(0) \in M_{\mathfrak{p}} \otimes 1_{\mathfrak{q}}, f(1) \in 1_{\mathfrak{p}} \otimes M_{\mathfrak{q}} \right\}.
$$

A unital endomorphism  $\varphi$  on a unital C<sup>\*</sup>-algebra A is said to be *trace-collapsing* if  $\tau \circ \varphi = \tau' \circ \varphi$  for any  $\tau, \tau' \in T(A)$ . Then the following theorem is proven.

<span id="page-2-2"></span>**Theorem 2.2.** ([\[13,](#page-5-12) Theorem 3.4]) Let  $\mathfrak{p}, \mathfrak{q}$  be infinite coprime supernatural numbers. Then there exists a trace-collapsing unital endomorphism  $\varphi$  on  $\mathcal{Z}_{p,q}$ . For any such  $\varphi$ , the Jiang-Su algebra  $\mathcal Z$  is isomorphic to the stationary inductive limit of the sequence

$$
\mathcal{Z}_{\mathfrak{p},\mathfrak{q}} \xrightarrow{\ \varphi \ } \mathcal{Z}_{\mathfrak{p},\mathfrak{q}} \xrightarrow{\ \varphi \ } \mathcal{Z}_{\mathfrak{p},\mathfrak{q}} \xrightarrow{\ \varphi \ } \cdots.
$$

As noted in the introduction, this viewpoint for  $\mathcal Z$  is used to reprove  $K_1$ -injectivity of unital  $Z$ -stable C<sup>\*</sup>-algebras in [\[2,](#page-5-11) Theorem 4.8]. This quickly extends to the non-unital case, which recaptures Jiang's  $K_1$ -injectivity result in [\[7,](#page-5-10) Theorem 2].

<span id="page-2-1"></span>**Theorem 2.3.** If A is a C\*-algebra, then  $A \otimes \mathcal{Z}$  is  $K_1$ -injective.

*Proof.* The unital case is proven in [\[2,](#page-5-11) Theorem 4.8]. When A is non-unital, take  $u \in$  $\mathcal{U}((A\otimes \mathcal{Z})^{\sim})$  with  $[u]_1 = 0 \in K_1(A\otimes \mathcal{Z})$ . Then  $[u]_1 = 0 \in K_1(\tilde{A}\otimes \mathcal{Z})$  and  $(q\otimes id_{\mathcal{Z}}(u)) = \lambda 1_{\mathcal{Z}}$ for some  $\lambda \in \mathbb{T}$ . Since  $\tilde{A} \otimes \mathcal{Z}$  is  $K_1$ -injective, there is a path of unitaries  $(u_t)_{t\in[0,1]} \subseteq \mathcal{U}(\tilde{A} \otimes \mathcal{Z})$ such that  $u_0 = 1_{\tilde{A}\otimes \mathcal{Z}}$  and  $u_1 = u$ . For  $t \in [0,1]$ , take  $v_t = (1_{\tilde{A}} \otimes (q \otimes id_{\mathcal{Z}})(u_t))^* u_t$ , then  $(v_t)_{t\in[0,1]}$  is a path of unitaries in  $\mathcal{U}(\tilde{A}\otimes\mathcal{Z})$  with  $v_0 = 1_{\tilde{A}\otimes\mathcal{Z}}$  and  $v_1 = \overline{\lambda}u$ . Since  $(q \otimes id_{\mathcal{Z}})(v_t) = 1_{\mathcal{Z}}$  for  $t \in [0,1]$ , then  $(v_t)_{t \in [0,1]} \subseteq \mathcal{U}((A \otimes \mathcal{Z})^{\sim})$ , which implies  $1_{(A \otimes \mathcal{Z})^{\sim}} \sim_h$  $\overline{\lambda}u \sim_h u$  in  $(A \otimes \mathcal{Z})^{\sim}$ . <sup>∼</sup>.

Since the approach in [\[2,](#page-5-11) Theorem 4.8] inspires the results of this paper, we will use Theorem [2.3](#page-2-1) freely in later sections.

## 3.  $K_1$ -SURJECTIVITY OF  $Z$ -STABLE C<sup>\*</sup>-ALGEBRAS

<span id="page-2-0"></span>We start by proving  $K_1$ -surjectivity of UHF-absorbing  $C^*$ -algebras.

### **Lemma 3.1.** If A is a unital C\*-algebra and  $n \geq 2$ , then  $A \otimes M_{n^{\infty}}$  is  $K_1$ -surjective.

*Proof.* Take  $B = A \otimes M_{n^{\infty}}$  and  $[u]_1 \in K_1(B)$ , where  $u \in U_m(B)$  for some  $m \in \mathbb{N}$ . By enlarging m if necessary, we may assume that  $m = n^k$  for some  $k \in \mathbb{N}$ . Since there exists an an isomorphism between  $M_{n^{\infty}}$  and  $M_{n^{\infty}} \otimes M_{n^k}$  that is approximately unitarily equivalent to the first-factor embedding, there exists a ∗-isomorphism  $\theta : B \to B \otimes M_{n^k}$  such that  $\theta$  is approximately unitarily equivalent to  $id_B \otimes 1_{n^k}$ .

Take  $v = \theta^{-1}(u) \in \mathcal{U}(B)$ , then there exists  $w \in \mathcal{U}_{n^k}(B)$  such that

(3.1) 
$$
||u - w(v \otimes 1^{n^k})w^*|| = ||\theta(v) - w(v \otimes 1^{n^k})w^*|| < 1.
$$

Then u is homotopic to  $w(v \otimes 1^{n^k})w^*$  in  $\mathcal{U}_{n^k}(B)$  and thus  $[u]_1 = [v^{n^k}]_1 \in K_1(B)$ .

Lemma [3.1](#page-2-0) extends to non-unital UHF-absorbing  $C^*$ -algebras by a direct application of the following lemma, which will also be applied to non-unital  $Z$ -stable  $C^*$ -algebras later. The proof is standard and we include it for completeness.

**Lemma 3.2.** Let A, B be C\*-algebras with A non-unital and B unital. If  $\tilde{A} \otimes B$  is K<sub>1</sub>surjective and B is K<sub>1</sub>-injective, then  $A \otimes B$  is K<sub>1</sub>-surjective, where  $\otimes$  is the minimal tensor product.

Proof. By [\[3,](#page-5-16) Lemma 1] for example, we have the following split short exact sequence,

(3.2) 
$$
0 \longrightarrow A \otimes B \xrightarrow{\iota \otimes id_B} \tilde{A} \otimes B \xrightarrow{q \otimes id_B} B \longrightarrow 0,
$$

which induces a split short exact sequence for  $K_1$ -groups by split-exactness of  $K_1$ , see [\[12,](#page-5-0) Proposition 8.2.5]. Then  $(\iota \otimes id_B)^\sim$  is injective and for any  $u \in \mathcal{U}(\tilde{A} \otimes B)$ , it is in  $\mathcal{U}((A \otimes B)^\sim)$ if and only if  $(q \otimes id_B)(u) \in \mathbb{C}1_B$ .

Take any  $x \in K_1(A \otimes B) \subseteq K_1(A \otimes B)$ , then there exists  $v_0 \in \mathcal{U}(A \otimes B)$  such that  $x = [v_0]_1$  since  $A \otimes B$  is assumed to be  $K_1$ -surjective. Then

(3.3) 
$$
[(q \otimes id_B)(v_0)]_1 = K_1(q \otimes id_B)(x) = 0 \in K_1(B),
$$

which implies  $(q \otimes id_B)(v_0) \in \mathcal{U}^0(B)$  by K<sub>1</sub>-injectivity of B. Therefore there exists  $v_1 \in$  $\mathcal{U}^0(\tilde{A}\otimes B)$  with  $(q\otimes id_B)(v_0) = (q\otimes id_B)(v_1)$ . We take  $u = v_1^*v_0 \in \mathcal{U}(\tilde{A}\otimes B)$  so that  $[u]_1 = x$  and  $(q \otimes id_B)(u) = 1_B$ , which implies that  $u \in \mathcal{U}((A \otimes B)^{\sim}).$ 

<span id="page-3-1"></span>Corollary 3.3. If A is a C\*-algebra and  $n \geq 2$ , then  $A \otimes M_{n^{\infty}}$  is  $K_1$ -surjective.

*Proof.* In the unital case, the result follows from Lemma [3.1.](#page-2-0) If  $A$  is non-unital, since  $A \otimes M_{n^{\infty}}$  is K<sub>1</sub>-surjective and  $M_{n^{\infty}}$  is unital and K<sub>1</sub>-injective, by Lemma [3.2,](#page-3-0) we get  $K_1$ -surjectivity of  $A \otimes M_{n^{\infty}}$ .

Now we prove the following main result of the section. We will denote the *suspension* of a C<sup>\*</sup>-algebra A by  $SA = C_0((0, 1)) \otimes A$ .

<span id="page-3-2"></span>**Lemma 3.4.** If A is a unital C\*-algebra, then  $A \otimes \mathcal{Z}_{2^{\infty},3^{\infty}}$  is  $K_1$ -surjective.

*Proof.* We view  $A \otimes \mathcal{Z}_{2^{\infty},3^{\infty}}$  as a C\*-subalgebra of  $C([0,1], A \otimes M_{6^{\infty}})$ , where

$$
(3.4) \qquad A\otimes \mathcal{Z}_{2^{\infty},3^{\infty}} = \{f \in C([0,1], A\otimes M_{6^{\infty}}) : f(0) \in A\otimes M_{2^{\infty}}, f(1) \in A\otimes M_{3^{\infty}}\}.
$$

Then we have the following short exact sequence,

$$
(3.5) \t 0 \to A\otimes SM_{6^{\infty}} \xrightarrow{\iota} A\otimes \mathcal{Z}_{2^{\infty},3^{\infty}} \xrightarrow{q} (A\otimes M_{2^{\infty}}) \oplus (A\otimes M_{3^{\infty}}) \to 0,
$$

where  $q(f) = (f(0), f(1))$  for any  $f \in A \otimes \mathcal{Z}_{2^{\infty}, 3^{\infty}}$ .

Take  $u \in \mathcal{U}_m(A \otimes \mathcal{Z}_{2^{\infty},3^{\infty}})$  for some  $m \in \mathbb{N}$  so that  $u(0) \in \mathcal{U}_m(A \otimes M_{2^{\infty}})$  and  $u(1) \in$  $\mathcal{U}_m(A\otimes M_{3\infty})$ . By Theorem [3.1,](#page-2-0) both  $A\otimes M_{2\infty}$  and  $A\otimes M_{3\infty}$  are K<sub>1</sub>-surjective. Then there exists  $w_0 \in \mathcal{U}(A \otimes M_{2^{\infty}})$  and  $w_1 \in \mathcal{U}(A \otimes M_{3^{\infty}})$  such that  $[u(0)]_1 = [w_0]_1 \in K_1(A \otimes M_{2^{\infty}})$ and  $[u(1)]_1 = [w_1]_1 \in K_1(A \otimes M_{3^{\infty}}).$ 

Since u is a continuous path in  $\mathcal{U}_m(A \otimes M_{6^{\infty}})$  connecting  $u(0)$  and  $u(1)$ , then

$$
(3.6) \t\t [w_0]_1 = [u(0)]_1 = [u(1)]_1 = [w_1]_1 \in K_1(A \otimes M_{6^{\infty}}),
$$

where we regard  $A \otimes M_{2^{\infty}}$  and  $A \otimes M_{3^{\infty}}$  as C\*-subalgebras of  $A \otimes M_{6^{\infty}}$ . Since  $A \otimes M_{6^{\infty}}$ is unital and UHF-absorbing, then it is  $K_1$ -injective by [\[2,](#page-5-11) Lemma 4.9]. Thus there exists a unitary path  $w \in C([0, 1]) \otimes A \otimes M_{6^{\infty}}$  with  $w(0) = w_0 \in A \otimes M_{2^{\infty}}$  and  $w(1) = w_1 \in A \otimes M_{3^{\infty}}$ . Thus  $w \in \mathcal{U}(A \otimes \mathcal{Z}_{2^{\infty},3^{\infty}})$  with  $q(w) = (w_0, w_1)$  and we have

$$
(3.7) \qquad [q(u)]_1 = [q(w)]_1 \in K_1(A \otimes M_{2^{\infty}}) \oplus K_1(A \otimes M_{3^{\infty}}).
$$

Then  $[u(w \oplus 1_{m-1})^+]_1 \in \text{ker}(K_1(q)) = \text{Im}(K_1(t))$  by half-exactness of  $K_1$ , see [\[12,](#page-5-0) Proposition 8.2.4. Since  $A \otimes SM_{6^{\infty}}$  is  $K_1$ -surjective by Corollary [3.3,](#page-3-1) there exists  $z \in \mathcal{U}((A \otimes SM_{6^{\infty}})^{\sim}) \subseteq$ 

$$
A \otimes \mathcal{Z}_{2^{\infty},3^{\infty}} \text{ such that } [u(w \oplus 1_{m-1})^*]_1 = K_1(\iota)([z]_1). \text{ Thus } [u]_1 = [zw]_1 \in K_1(A \otimes \mathcal{Z}_{2^{\infty},3^{\infty}}).
$$

For infinite coprime supernatural numbers  $\mathfrak{p}$ ,  $\mathfrak{q}$ , then  $\mathcal{Z}_{\mathfrak{p},\mathfrak{q}}$  is  $\mathcal{Z}$ -stable by [\[6,](#page-5-17) Theorem 4.6], since fibers of  $\mathcal{Z}_{p,q}$  are  $\mathcal{Z}\text{-stable}$ . Then a direct application of Jiang's result shows that  $A \otimes \mathcal{Z}_{2^{\infty},3^{\infty}}$  is K<sub>1</sub>-surjective. Whereas in our approach, Lemma [3.4](#page-3-2) is the last ingredient needed to reprove  $K_1$ -surjectivity of  $\mathcal Z$ -stable C<sup>\*</sup>-algebras.

<span id="page-4-1"></span>**Theorem 3.5.** ([\[7,](#page-5-10) Theorem 2]) If A is a  $C^*$ -algebra, then  $A \otimes \mathcal{Z}$  is  $K_1$ -surjective.

Proof. In the unital case, this follows from Theorem [2.2,](#page-2-2) Theorem [3.4](#page-3-2) and the fact that  $K_1$ -surjectivity is preserved by inductive limits. For non-unital A, since  $\mathcal Z$  is  $K_1$ -injective by Theorem [2.3,](#page-2-1) then  $A \otimes \mathcal{Z}$  is  $K_1$ -surjective by Lemma [3.2.](#page-3-0)

In fact, all we need in the proof is that  $\mathcal Z$  is an inductive limit of generalized dimension drop algebras, regardless of the specific connecting maps.

### 4. Homotopy groups for Z-stable C\*-algebras

In this section, we prove K-stability for both unital and non-unital  $\mathcal{Z}\text{-stable}$  C\*-algebras. In order to cover the non-unital case, we need to extend the definition for unitary groups. For any C<sup>\*</sup>-algebra A, we denote the minimal proper unitization of A by A, where  $A = A \oplus \mathbb{C}$ if A is unital. The canonical maps associated to  $\tilde{A}$  are  $\iota : A \to \tilde{A}$  and  $q : \tilde{A} \to \mathbb{C}$ . Then the generalized unitary group  $\mathcal{V}(A) = \{u \in \mathcal{U}(A) : q(u) = 1\}$  is a topological group and  $\mathcal{V}(A) \cong \mathcal{U}(A)$  as topological groups when A is unital. We use the notation  $\mathcal{V}_m(A)$  for  $\mathcal{V}(M_m \otimes A)$ , where  $m \geq 1$ .

In the unital case, we define  $\mathcal{U}_{\infty}(A)$  to be the inductive limit of groups  $\mathcal{U}_{m}(A)$  with metric preserving connecting maps. Thus  $\mathcal{U}_{\infty}(A)$  is equipped with a well-defined metric from finite stages. For a general C\*-algebra, take  $\mathcal{V}_{\infty}(A) = \{u \in \mathcal{U}_{\infty}(A) : q(u) = 1\}$ , where q is the matrix amplification of  $q : \tilde{A} \to \mathbb{C}$ . Then there are embeddings  $i_{m,m'} : \mathcal{V}_m(A) \to \mathcal{V}_{m'}(A)$  for  $1 \leq m \leq m' \leq \infty$  and it is standard to check that maps  $\pi_n(\mathcal{V}_m(A)) \to \pi_n(\mathcal{U}_m(A))$  induced by inclusions  $\iota_m : \mathcal{V}_m(A) \to \mathcal{U}_m(\tilde{A})$  are isomorphisms for  $n \geq 1$  and  $m \in \mathbb{N} \cup \{\infty\}.$ 

By Bott periodicity of K-theory (see [\[12,](#page-5-0) Proposition 11.4.1] for example), for any  $n \geq 0$ , the canonical maps induce the following isomorphisms,

<span id="page-4-2"></span>(4.1) 
$$
\pi_n(\mathcal{V}_{\infty}(A)) \cong \begin{cases} K_0(A) & \text{if } n \text{ is odd,} \\ K_1(A) & \text{if } n \text{ is even.} \end{cases}
$$

The definition for K-stability is given by Thomsen using quasi-unitaries in  $[16]$ . Since  $\mathcal{V}(A)$  is homeomorphic to the topological group of quasi-unitaries in A defined in [\[16\]](#page-5-3), the following definition for K-stability indeed coincides with Thomsen's.

**Definition 4.1.** ([\[16,](#page-5-3) Definition 3.1]) Let A be a C\*-algebra, then it is called K-stable if for any  $m \ge 1$  and  $n \ge 0$ , the induced maps  $\pi_n(i_{m,m+1})$  are isomorphisms.

Now we prove the main theorem of the section.

<span id="page-4-0"></span>**Theorem 4.2.** ([\[7,](#page-5-10) Theorem 2.8 and Theorem 3]) Let A be a Z-stable  $C^*$ -algebra, then A is K-stable. Moreover, for any integer  $n \geq 0$ , the following isomorphisms are induced by the canonical embedding  $i_{1,\infty} : \mathcal{V}(A) \to \mathcal{V}_{\infty}(A)$ ,

<span id="page-4-3"></span>(4.2) 
$$
\pi_n(\mathcal{V}(A)) \cong \begin{cases} K_0(A) & \text{if } n \text{ is odd,} \\ K_1(A) & \text{if } n \text{ is even.} \end{cases}
$$

*Proof.* When A is Z-stable, then A is  $K_1$ -injective and  $K_1$ -surjective by Theorem [2.3](#page-2-1) and Theorem [3.5,](#page-4-1) which implies  $\pi_0(\mathcal{U}(\tilde{A})) \cong K_1(\tilde{A}) \cong \pi_0(\mathcal{U}_{\infty}(\tilde{A}))$  by [\(4.1\)](#page-4-2). Since  $\pi_0(\iota_0)$  and  $\pi_0(\iota_{\infty})$  are isomorphisms, then  $i_{1,\infty}$  induces an isomorphism through

<span id="page-5-18"></span>(4.3) 
$$
\pi_0(\mathcal{V}(A)) \cong \pi_0(\mathcal{U}(\tilde{A})) \cong \pi_0(\mathcal{U}_{\infty}(\tilde{A})) \cong \pi_0(\mathcal{V}_{\infty}(A)) = K_1(A).
$$

Since Z-stability of A implies that of  $M_m \otimes A$ , then the maps  $i_{m,\infty}$  induce  $\pi_0(\mathcal{V}_m(A)) \cong$  $K_1(A)$  for  $m \geq 1$  by the argument above and thus all the maps  $\pi_0(i_{m,m+1})$  are isomorphisms.

For  $n \geq 1$ , there is a canonical identification between  $\pi_n(\mathcal{V}(A))$  and  $\pi_0(\mathcal{V}(S^nA))$  by [\[16,](#page-5-3) Lemma 2.3, where  $S^n A = C_0((0,1)^n) \otimes A$  is the  $n^{th}$  suspension of A. When A is Z-stable, then  $S<sup>n</sup>(M<sub>m</sub>(A))$  is Z-stable for any  $m, n \ge 1$ . Thus by [\(4.3\)](#page-5-18), the maps  $i_{m,\infty}$  induce the following isomorphisms for  $m \geq 1$ ,

(4.4) 
$$
\pi_n(\mathcal{V}_m(A)) = \pi_0(\mathcal{V}(S^n(M_m(A)))) \cong K_1((S^n(M_m(A))) \cong K_{n+1}(A).
$$

Thus  $\pi_n(i_{m,m+1})$  are isomorphisms for  $m \geq 1$  and  $n \geq 0$ , which implies K-stability of A. Further by Bott periodicity of K-theory, for  $m \ge 1$  and  $n \ge 0$ ,

(4.5) 
$$
\pi_n(\mathcal{V}_m(A)) \cong \begin{cases} K_0(A) & \text{if } n \text{ is odd,} \\ K_1(A) & \text{if } n \text{ is even.} \end{cases}
$$

In particular, we get  $(4.2)$ .
