# Precompactness in matrix weighted Bourgain-Morrey spaces

#### Abstract

In this paper, we introduce matrix weighted Bourgain-Morrey spaces and obtain two sufficient conditions for precompact sets in matrix weighted Bourgain-Morrey spaces. We prove that the dyadic average operator is bounded on some matrix weighted Bourgain-Morrey spaces. With this result, we obtain the necessity for precompact sets in some matrix weighted Bourgain-Morrey spaces.


## 1. Introduction

In 1931, Kolmogorov 20 first discovered the characterization of precompact sets in $L^{p}([0,1])$ for $p \in(1, \infty)$. After that, there are many criteria for compactness of sets in Lebesgue spaces, which are called the Kolmogorov-Riesz compactness theorems on the Lebesgue spaces. More details and the history, we refer the reader to [14].

Inspired by [14, Clop-Cruz [7] obtained a compactness criterion in scalar weighted Lebesgue spaces $L^{p}(\omega)$ for $1<p<\infty$ with a scalar wight $\omega$ in Muckenhoupt class $A_{p}$. In [13], Guo and Zhao improved the result in [7] and obtained a compactness criterion in $L^{p}(\omega)$ for $p \in(0, \infty)$ with locally integrable weight $\omega$. In [21], Liu, Yang and Zhuo proved the Kolmogorov-Riesz compactness theorem in matrix weighted Lebesgue spaces $L^{p}(W)$ with $1<p<\infty$.

The theory of matrix weighted function spaces goes back to 32. Indeed, in 1958, Wiener and Masani [32, Section 4] studied the matrix weighted $L^{2}(W)$ for the prediction theory for multivariate stochastic processes. In [29, Treil and Volberg introduced matrix class $\mathcal{A}_{2}$. Nazarov and Treil [23] and Volberg [30] extended $\mathcal{A}_{2}$ to $\mathcal{A}_{p}$ with $p \in(1, \infty)$. In [11], Goldberg showed that the matrix $\mathcal{A}_{p}$ condition leads to $L^{p}$ boundedness of a Hardy-Littlewood maximal function and obtained the boundedness of matrix weighted singular integral operators in Lebesgue spaces $L^{p}, 1<$ $p<\infty$. In [24, 25, 26], Roudenko introduced the matrix-weighted homogeneous Besov spaces $\dot{B}_{p}^{s, q}(W)$ and matrix-weighted sequence Besov spaces $\dot{b}_{p}^{s, q}(W)$ and showed their equivalence via $\varphi$-transform and wavelets. In [9], Frazier and Roudenko introduced the

[^0]matrix class $\mathcal{A}_{p},(0<p \leq 1)$ and studied the continuous and discrete matrix-weighted Besov spaces $\dot{B}_{p}^{s, q}(W)$ and $\dot{b}_{p}^{s, q}(W)$ with $0<p \leq 1$. In [10], Frazier and Roudenko introduced the homogeneous matrix-weighted Triebel-Lizorkin spaces $\dot{F}_{p}^{s, q}(W)$ for $s \in$ $\mathbb{R}, 0<p<\infty, 0<q \leq \infty$ and obtained the Littlewood-Paley characterizations of matrix-weighted Lebesgue spaces $L^{p}(W)$ and matrix-weighted Sobolev space $L_{k}^{p}(W)$ for $k \in \mathbb{N}, 1<p<\infty$. In [30], Volberg also introduced an analogue condition for the matrix class $\mathcal{A}_{\infty}$. In [3, 4, [5], Bu, Hytönen, Yang, Yuan studied the matrix weighted Besov-type and Triebel-Lizorkin-type spaces. Specifically, they introduced a new concept of the $\mathcal{A}_{p}$-dimension $\tilde{d}$, which is useful to the proof of main results of this paper. In [2], Bu, Hytönen, Yang, Yuan obtained several new characterizations of $\mathcal{A}_{p, \infty}$-matrix weights. For many other results on the matrix class $\mathcal{A}_{p}$ and matrix weighted function spaces, we refer the reader to [6, 8, 9, 10, 11, 24, 25, 31].

Bourgain [1 introduced a special case of Bourgain-Morrey spaces to study the Stein-Tomas (Strichartz) estimate. In [16], Hatano, Nogayama, Sawano, and Hakim researched the Bourgain-Morrey spaces from the viewpoints of harmonic analysis and functional analysis. In [19], $\mathrm{Hu}, \mathrm{Li}$ and Yang introduced the Triebel-Lizorkin-Bourgain-Morrey spaces which connect Bourgain-Morrey spaces and global Morrey spaces.

Motivated by above literature, we will introduce matrix weighted BourgainMorrey spaces and research precompact sets in these spaces. The paper is organized as follows. In Section 2, dyadic cubes, the matrix class $\mathcal{A}_{p}, \mathcal{A}_{p}$-dimension $\tilde{d}$, matrix weighted Bourgain-Morrey spaces are given. The first result lies in Section 3, Specifically, a sufficient condition for totally bounded set in matrix weighted spaces $M_{p}^{t, r}(W)$ with $1 \leq p<r<\infty$ or $1 \leq p \leq t<r=\infty$ is obtained in Theorem 3.2. As a application, we get a criterion for totally bounded set in degenerate Bourgain-Morrey spaces with matrix weight. The second result (Theorem4.1) is replacing the translation operator by the average operator. Note that the translation operator is not bounded on $L^{p}(W)$ and $M_{p}^{t, r}(W)$ in general. We prove that dyadic average operator is bounded on matrix weighted Bourgain-Morrey spaces with some conditions in Theorem4.5. Using this result, we obtain the Kolmogorov-Riesz compactness theorem in matrix weighted Bourgain-Morrey spaces.

Throughout this paper, we let $c, C$ denote constants that are independent of the main parameters involved but whose value may differ from line to line. Let $\mathbb{N}=$ $\{1,2,3, \ldots\}$ and $\mathbb{N}_{0}=\{0,1,2,3, \ldots\}$. Let $\mathbb{Z}$ be the set of integers. Let $\chi_{E}$ be the characteristic function of the set $E \subset \mathbb{R}^{n}$. By $A \lesssim B$ we mean that $A \leq C B$ with some positive constant $C$ independent of appropriate quantities. By $A \approx B$, we mean that $A \lesssim B$ and $B \lesssim A$.

## 2. Preliminaries

For $j \in \mathbb{Z}, m \in \mathbb{Z}^{n}$, let $Q_{j, m}:=\prod_{i=1}^{n}\left[2^{-j} m_{i}, 2^{-j}\left(m_{i}+1\right)\right)$. For a cube $Q, \ell(Q)$ stands for the length of cube $Q$. We denote by $\mathcal{D}$ the the family of all dyadic cubes in $\mathbb{R}^{n}$, while $\mathcal{D}_{j}$ is the set of all dyadic cubes with $\ell(Q)=2^{-j}, j \in \mathbb{Z}$. Let $x_{Q}$ be the left corner of $Q \in \mathcal{D}$. For $\lambda>0$, let $\lambda Q$ be the cube with the same center of $Q$ and the edge length $\lambda \ell(Q)$. For $k \in \mathbb{N}$, let $k_{\mathrm{pa}} Q$ be the $k$-th dyadic parent of $Q$, which is the dyadic cube in $\mathcal{D}$ satisfying $Q \subset k_{\mathrm{pa}} Q$ and $\ell\left(k_{\mathrm{pa}} Q\right)=2^{k} \ell(Q)$.
2.1. Matrix weights First, we recall some basic concepts and results from the theory of matrix weights.

For any $d, n \in \mathbb{N}$, denote by $M_{d, n}(\mathbb{C})$ the set of all $d \times n$ complex-valued matrices. $M_{d, d}(\mathbb{C})$ is simply denoted by $M_{d}(\mathbb{C})$. The zero matrix in $M_{d, n}(\mathbb{C})$ (or $M_{d}(\mathbb{C})$ ) is denoted by $O_{d, n}\left(\right.$ or $\left.O_{d}\right)$. Denote by $A^{*}$ the conjugate transpose of $A \in M_{d, n}(\mathbb{C})$. A matrix $A \in M_{d}(\mathbb{C})$ is called a Hermitian matrix if $A=A^{*}$ and is called a unitary matrix if $A^{*} A=I_{d}$ where $I_{d}$ is the identity matrix. We denote a diagonal matrix by $\operatorname{diag}\left(\lambda_{1}, \ldots, \lambda_{d}\right)=\operatorname{diag}\left(\lambda_{i}\right)$.

For a vector $x \in \mathbb{C}^{d}$, let $|x|=\left(\sum_{i=1}^{d}\left|x_{i}\right|^{2}\right)^{1 / 2}$. For $1 \leq p<\infty$, let $|x|_{p}=$ $\left(\sum_{i=1}^{d}\left|x_{i}\right|^{p}\right)^{1 / p}$. For $p=\infty$, let $|x|_{\infty}=\max \left(x_{1}, \ldots, x_{d}\right)$. In the finite dimension space, the norms are equivalent. That is, for $1 \leq p<q \leq \infty$,

|x|_{q} \leq|x|_{p} \leq d^{1 / p}|x|_{\infty} \leq d^{1 / p}|x|_{q} \tag{2.1}
\end{equation*}
$$

For $A \in M_{d}(\mathbb{C})$, let

$$
\|A\|:=\sup _{\vec{z} \in \mathbb{C}^{d},|\vec{z}|=1}|A \vec{z}| .
$$

We say that a matrix $A \in M_{d}(\mathbb{C})$ is positive definite if, for any $\vec{x} \in \mathbb{C}^{d} \backslash\{\overrightarrow{0}\}$, $\vec{z}^{*} A \vec{z}>0$. And a matrix $A \in M_{d}(\mathbb{C})$ is called nonnegative definite if, for any $\vec{x} \in \mathbb{C}^{d}$, $\vec{z}^{*} A \vec{z} \geq 0$.

From [18, Theorem 4.1.4], any nonnegative definite matrix is always Hermitian. Hence any nonnegative definite matrix is self-adjoint.

Let $A \in M_{d}(\mathbb{C})$ be a positive definite matrix and have eigenvalues $\left\{\lambda_{i}\right\}_{i=1}^{d}$. From [18, Theorem 2.5.6(c)], there exists a unitary matrix $U \in M_{d}(\mathbb{C})$ such that

$$
\begin{equation*}
A=U \operatorname{diag}\left(\lambda_{1}, \ldots, \lambda_{d}\right) U^{*} \tag{2.2}
\end{equation*}
$$

Moreover, by [18, Theorem 4.1.8], we find $\left\{\lambda_{i}\right\}_{i=1}^{d} \subset(0, \infty)^{d}$. The following definition is based on these conclusions.

Definition 2.1. Let $A \in M_{d}(\mathbb{C})$ be a positive definite matrix with positive eigenvalues $\left\{\lambda_{i}\right\}_{i=1}^{d}$. For any $\alpha \in \mathbb{R}$, define

$$
\begin{equation*}
A^{\alpha}:=U \operatorname{diag}\left(\lambda_{1}^{\alpha}, \ldots, \lambda_{m}^{\alpha}\right) U^{*} \tag{2.3}
\end{equation*}
$$

where $U$ is the same as in (2.2).
Remark 2.2. From [17, p. 408], we obtain that $A^{\alpha}$ is independent of the choices of the order of $\left\{\lambda_{i}\right\}_{i=1}^{m}$ and $U$, and hence $A^{\alpha}$ is well defined.

Now, we recall some concepts of matrix wights.
Definition 2.3. A matrix-valued function $W: \mathbb{R}^{n} \rightarrow M_{d}(\mathbb{C})$ is called a matrix weight if $W$ satisfies that
(i) for any $x \in \mathbb{R}^{n}, W(x)$ is nonnegative definite;
(ii) for almost every $x \in \mathbb{R}^{n}, W(x)$ is invertible;
(iii) the entries of $W$ is locally integrable;

Definition 2.4. Let $p \in(0, \infty), W$ be a matrix weight. Suppose that $E \subset \mathbb{R}^{n}$ is a bounded measurable set satisfying $0<|E|<\infty$. Then the matrix $A_{E} \in M_{d}(\mathbb{C})$ is called a reducing operator of order $p$ for $W$ if $A_{E}$ is positive definite and, for any $\vec{z} \in \mathbb{C}^{d}$,

$$
\begin{equation*}
\left|A_{E} \vec{z}\right| \approx\left(\frac{1}{|E|} \int_{E}\left|W^{\frac{1}{p}}(x) \vec{z}\right|^{p} \mathrm{~d} x\right)^{\frac{1}{p}}, \tag{2.4}
\end{equation*}
$$

where the positive equivalence constants depend only on $d$ and $p$.
Next we recall the concepts of scalar weight class $A_{p}$ (see 12, Definitions 7.1.1, 7.1.3]) and matrix weight class $\mathcal{A}_{p}$ (see [26] for $1<p<\infty$, 9 for $0<p \leq 1$ ).

Definition 2.5. A weight $\omega$ is a nonnegative locally integrable function on $\mathbb{R}^{n}$ such that $0<\omega(x)<\infty$ for almost all $x \in \mathbb{R}^{n}$.

A weight $\omega$ is called an $A_{1}$ weight if $\mathcal{M}(\omega)(x) \leq c \omega(x)$ for almost all $x \in \mathbb{R}^{n}$ where $\mathcal{M}$ is the Hardy-Littlewood maximal operator.

For $1<p<\infty$, a weight $\omega$ is said to be of class $A_{p}$ if

$$
\sup _{Q \text { cubes in } \mathbb{R}^{n}}\left(\frac{1}{|Q|} \int_{Q} \omega(x) \mathrm{d} x\right)\left(\frac{1}{|Q|} \int_{Q} \omega(x)^{-1 /(p-1)} \mathrm{d} x\right)^{p-1}<\infty .
$$

For $1<p<\infty$, a matrix weight $W \in \mathcal{A}_{p}\left(\mathbb{R}^{n}\right)$ if and only if

$$
\sup _{Q} \frac{1}{|Q|} \int_{Q}\left(\frac{1}{|Q|} \int_{Q}\left\|W^{1 / p}(x) W^{-1 / p}(y)\right\|^{p^{\prime}} \mathrm{d} y\right)^{p / p^{\prime}} \mathrm{d} x<\infty
$$

where $p^{\prime}=p /(p-1)$ is the conjugate index of $p$, and the supremum is taken over all cubes $Q \subset \mathbb{R}^{n}$.

For $0<p \leq 1$, a matrix weight $W \in \mathcal{A}_{p}\left(\mathbb{R}^{n}\right)$ if and only if

$$
\left.\sup _{Q}^{\operatorname{ess} \sup } \frac{1}{y \in Q} \right\rvert\, \int_{Q}\left\|W^{1 / p}(x) W^{-1 / p}(y)\right\|^{p} \mathrm{~d} x<\infty .
$$

We write $\mathcal{A}_{p}:=\mathcal{A}_{p}\left(\mathbb{R}^{n}\right)$ for brevity.
Given any matrix weight $W$ and $0<p<\infty$, there exists (see e.g., 11, Proposition 1.2]) for $p>1$ and [9, p.1237] for $0<p \leq 1$ ) a sequence $\left\{A_{Q}\right\}_{Q \in \mathcal{D}}$ of positive definite $d \times d$ matrices such that

$$
c_{1}\left|A_{Q} \vec{y}\right| \leq\left(\frac{1}{|Q|} \int_{Q}\left|W^{1 / p}(x) \vec{y}\right|^{p} \mathrm{~d} x\right)^{1 / p} \leq c_{2}\left|A_{Q} \vec{y}\right|,
$$

with positive constants $c_{1}, c_{2}$ independent of $\vec{y} \in \mathbb{C}^{d}$ and $Q \in \mathcal{D}$. In this case, we call $\left\{A_{Q}\right\}_{Q \in \mathcal{D}}$ a sequence of reducing operators of order $p$ for $W$.

Definition 2.6. A matrix weight $W$ is called a doubling matrix weight of order $p>0$ if the scalar measures $w_{\vec{y}}(x)=\left|W^{1 / p}(x) \vec{y}\right|^{p}$, for $\vec{y} \in \mathbb{C}^{d}$, are uniformly doubling: there exists $c>0$ such that for all cubes $Q \subset \mathbb{R}^{n}$ and all $\vec{y} \in \mathbb{C}^{d}$,

$$
\int_{2 Q} w_{\vec{y}}(x) d x \leq c \int_{Q} w_{\vec{y}}(x) \mathrm{d} x
$$

If $c=2^{\beta}$ is the smallest constant for which this inequality holds, we say that $\beta$ is the doubling exponent of $W$.

From [15, Proposition 2.10], we know that $\beta$ is always not less than $n$.
In [3], Bu , Hytönen, Yang and Yuan introduced the $\mathcal{A}_{p}$-dimension of matrix weights, which will be used in Theorems 4.5 and 4.6 .

Definition 2.7. Let $0<p<\infty, \tilde{d} \in \mathbb{R}$. A matrix weight $W$ has the $\mathcal{A}_{p^{-}}$ dimension $\tilde{d}$, denoted by $W \in \mathbb{D}_{p, \tilde{d}}\left(\mathbb{R}^{n}, \mathbb{C}^{n}\right)$, if there exists a positive constant $C$ such that for any cube $Q \subset \mathbb{R}^{n}$ and any $i \in \mathbb{N}_{0}$,

$$
\begin{equation*}
\underset{y \in 2^{i} Q}{\operatorname{ess} \sup } \frac{1}{|Q|} \int_{Q}\left\|W^{1 / p}(x) W^{-1 / p}(y)\right\|^{p} \mathrm{~d} x \leq C 2^{i \tilde{d}}, \quad \text { for } 0<p \leq 1 \tag{2.5}
\end{equation*}
$$

or,

$$
\frac{1}{|Q|} \int_{Q}\left(\frac{1}{\left|2^{i} Q\right|} \int_{2^{i} Q}\left\|W^{1 / p}(x) W^{-1 / p}(y)\right\|^{p^{\prime}} \mathrm{d} y\right)^{p / p^{\prime}} \mathrm{d} x \leq C 2^{i \tilde{d}}, \quad \text { for } 1<p<\infty
$$

where $1 / p+1 / p^{\prime}=1$.
We denote $\mathbb{D}_{p, \tilde{d}}\left(\mathbb{R}^{n}, \mathbb{C}^{n}\right)$ simply by $\mathbb{D}_{p, \tilde{d}}$.
Lemma 2.8 (Corollary 2.32, [3]). Let $0<p<\infty$, let $W \in \mathcal{A}_{p}$ have the $\mathcal{A}_{p}$ dimension $\tilde{d} \in[0, n)$, and let $\left\{A_{Q}\right\}_{\text {cube } Q}$ be the reducing operator of order $p$ for $W$. (i) If $1<p<\infty$, let $\widetilde{W}:=W^{-1 /(p-1)}$ (which belongs to $\mathcal{A}_{p^{\prime}}$ ) have the $\mathcal{A}_{p^{\prime}}$-dimension
$\tilde{\tilde{d}}$. Then there exists a positive constant $C$ such that, for any cubes $Q$ and $R$ of $\mathbb{R}^{n}$,

$$
\left\|A_{Q} A_{R}^{-1}\right\| \leq C \max \left(\left[\frac{\ell(R)}{\ell(Q)}\right]^{\tilde{d} / p},\left[\frac{\ell(Q)}{\ell(R)}\right]^{\tilde{d} / p^{\prime}}\right)\left[1+\frac{\left|x_{Q}-x_{R}\right|}{\max (\ell(Q), \ell(R))}\right]^{\tilde{d} / p+\tilde{\tilde{d} / p^{\prime}}}
$$

(ii) If $0<p \leq 1$, then there exists a positive constant $C$ such that, for any cubes $Q$ and $R$ of $\mathbb{R}^{n}$,

$$
\left\|A_{Q} A_{R}^{-1}\right\| \leq C \max \left(\left[\frac{\ell(R)}{\ell(Q)}\right]^{\tilde{d} / p}, 1\right)\left[1+\frac{\left|x_{Q}-x_{R}\right|}{\max (\ell(Q), \ell(R))}\right]^{\tilde{d} / p}
$$

### 2.2. Matrix weighted Bourgain-Morrey spaces

DEfinition 2.9. Let $0<p<\infty, d \in \mathbb{N}$ and $W: \mathbb{R}^{n} \rightarrow M_{d}(\mathbb{C})$ be a matrix weight. The space $L_{\mathrm{loc}}^{p}(W)$ collects all measurable functions $\vec{f}: \mathbb{R}^{n} \rightarrow \mathbb{C}^{d}$ such that for each compact set $K$,

$$
\left\|\vec{f} \chi_{K}\right\|_{L^{p}(W)}=\left(\int_{K}\left|W^{1 / p}(x) \vec{f}(x)\right|^{p} \mathrm{~d} x\right)^{1 / p}<\infty
$$

Let $\Omega \subset \mathbb{R}^{n}$ be an open set. The space $L^{p}(W, \Omega)$ collects all measurable functions $\vec{f}: \Omega \rightarrow \mathbb{C}^{d}$ such that

$$
\|\vec{f}\|_{L^{p}(W, \Omega)}=\left(\int_{\Omega}\left|W^{1 / p}(x) \vec{f}(x)\right|^{p} \mathrm{~d} x\right)^{1 / p}<\infty
$$

Definition 2.10. Let $\mathcal{D}=\left\{Q_{j, k}\right\}_{j \in \mathbb{Z}, k \in \mathbb{Z}^{n}}$ be the standard dyadic system. Let $0<p<t<r<\infty$ or $0<p \leq t<r=\infty$. Let $W: \mathbb{R}^{n} \rightarrow M_{d}(\mathbb{C})$ be a matrix weight. Define $M_{p}^{t, r}(W)$ as the set of all $\vec{f} \in L_{\mathrm{loc}}^{p}(W)$ such that

$$
\|\vec{f}\|_{M_{p}^{t, r}(W)}:=\left\|\left\{W\left(Q_{j, k}\right)^{1 / t-1 / p}\left(\int_{Q_{j, k}}\left|W^{1 / p}(y) \vec{f}(y)\right|^{p} \mathrm{~d} y\right)^{1 / p}\right\}_{j \in \mathbb{Z}, k \in \mathbb{Z}^{n}}\right\|_{\ell^{r}}<\infty
$$

where $W\left(Q_{j, k}\right)=\int_{Q_{j, k}}\|W(y)\| \mathrm{d} y$.
Let $\left\{A_{Q}\right\}_{Q \in \mathcal{D}}$ be the reducing operator of order $p$ for $W$. Define $M_{p}^{t, r}\left(\left\{A_{Q}\right\}\right)$ as the set of all $\vec{f} \in L_{\mathrm{loc}}^{p}(\{W\})$ such that

$$
\begin{aligned}
& \|\vec{f}\|_{M_{p}^{t, r}\left(\left\{A_{Q}\right\}\right)} \\
& :=\left\|\left\{\left(\left\|A_{Q_{j, k}}\right\|^{p}\left|Q_{j, k}\right|\right)^{1 / t-1 / p}\left(\int_{Q_{j, k}}\left|W^{1 / p}(x) \vec{f}(y)\right|^{p} \mathrm{~d} y\right)^{1 / p}\right\}_{j \in \mathbb{Z}, k \in \mathbb{Z}^{n}}\right\|_{\ell^{r}}<\infty .
\end{aligned}
$$

REmARK 2.11. Let $\left\{\vec{e}_{i}\right\}_{i=1}^{d}$ be the standard unit basis for $\mathbb{C}^{d}$. Since $W$ is a matrix weight, then for each $x \in \mathbb{R}^{n}, W(x)$ is a nonnegative matrix and self-adjoint. Hence we have

$$
\begin{aligned}
\|W(x)\| & =\left\|W^{2 / p}(x)\right\|^{p / 2} \approx\left[\operatorname{tr}\left(W^{2 / p}(x)\right)\right]^{p / 2} \\
& =\left(\sum_{i=1}^{d}\left|W^{1 / p}(x) \vec{e}_{i}\right|^{2}\right)^{p / 2} \approx \sum_{i=1}^{d}\left|W^{1 / p}(x) \vec{e}_{i}\right|^{p}
\end{aligned}
$$

From this and (2.4), we obtain

$$
\begin{aligned}
W\left(Q_{j, k}\right) & =\int_{Q_{j, k}}\|W(y)\| \mathrm{d} y \approx \int_{Q_{j, k}} \sum_{i=1}^{d}\left|W^{1 / p}(x) \vec{e}_{i}\right|^{p} \mathrm{~d} y \\
& \approx \sum_{i=1}^{d}\left|A_{Q_{j, k}} \vec{e}_{i}\right|^{p}\left|Q_{j, k}\right| \approx\left\|A_{Q_{j, k}}\right\|^{p}\left|Q_{j, k}\right| .
\end{aligned}
$$

Thus $M_{p}^{t, r}(W)$ is same with $M_{p}^{t, r}\left(\left\{A_{Q}\right\}\right)$ in meaning of the equivalent quasi-norms.
If $d=1, W \equiv 1, M_{p}^{t, r}(W)$ is the classical Bourgain-Morrey space $M_{p}^{t, r}$ in 16 . We define the scalar weighted Bourgain-Morrey space $M_{p}^{t, r}(\omega)$ by

$$
\begin{equation*}
\|f\|_{M_{p}^{t, r}(\omega)}:=\left\|\left\{\left(\omega\left(Q_{j, k}\right)\right)^{1 / t-1 / p}\left(\int_{Q_{j, k}}|f(y)|^{p} \omega(y) \mathrm{d} y\right)^{1 / p}\right\}_{j \in \mathbb{Z}, k \in \mathbb{Z}^{n}}\right\|_{\ell^{r}}<\infty \tag{2.6}
\end{equation*}
$$

That is $M_{p}^{t, r}(\omega)$ is the case $d=1$ of matrix weighted Bourgain-Morrey space $M_{p}^{t, r}(W)$.
The following Lemma is proved in [22, 28].
LEMMA 2.12. Let $1 \leq p<\infty$ and $W: \mathbb{R}^{n} \rightarrow M_{d}(\mathbb{C})$ be a matrix weight. Let $\Omega \subset \mathbb{R}^{n}$ be an open set. Then matrix weighted Lebesgue space $L^{p}(W, \Omega)$ is a Banach space.

THEOREM 2.13. Let $1 \leq p<\infty$ and $W: \mathbb{R}^{n} \rightarrow M_{d}(\mathbb{C})$ be a matrix weight. Then the space $L_{\text {loc }}^{p}(W)$ is complete.

Proof. Let $\left\{\vec{f}_{k}\right\}_{k=1}^{\infty}$ be a Cauchy sequence in $L_{\mathrm{loc}}^{p}(W)$. That is, for any compact set $K$, any $\varepsilon>0$, there exists $N>0$ such that if $j, k>N,\left\|\left(\vec{f}_{j}-\overrightarrow{f_{k}}\right) \chi_{K}\right\|_{L^{p}(W)}<\varepsilon$. Then for any compact set $K,\left\{\vec{f}_{k} \chi_{K}\right\}_{k=1}^{\infty}$ is a Cauchy sequence in $L^{p}(W)$. Since $L^{p}(W)$ is complete (Lemma 2.12), there exists $\vec{f} \chi_{K}$ in $L^{p}(W)$ such that $\vec{f}_{k} \chi_{K} \rightarrow \vec{f} \chi_{K}$. By the Fatou lemma, we have

$$
\left\|\vec{f} \chi_{K}\right\|_{L^{p}(W)} \leq \liminf _{k \rightarrow \infty}\left\|\vec{f}_{k} \chi_{K}\right\|_{L^{p}(W)}<\infty
$$

By the dominated convergence theorem, for $j, k>N$, we obtain

$$
\left\|\left(\vec{f}-\overrightarrow{f_{k}}\right) \chi_{K}\right\|_{L^{p}(W)}=\lim _{j \rightarrow \infty}\left\|\left(\vec{f}_{j}-\vec{f}_{k}\right) \chi_{K}\right\|_{L^{p}(W)}<\varepsilon
$$

Hence $\vec{f}_{k} \rightarrow \vec{f}$ in $L_{\mathrm{loc}}^{p}(W)$ and the space $L_{\mathrm{loc}}^{p}(W)$ is complete.
In what follows, the symbol $\hookrightarrow$ always stands for continuous embedding.
Proposition 1. Let $W: \mathbb{R}^{n} \rightarrow M_{d}(\mathbb{C})$ be a matrix weight.
(i) If $0<p<t<r_{1}<r_{2} \leq \infty$, then

$$
M_{p}^{t, r_{1}}(W) \hookrightarrow M_{p}^{t, r_{2}}(W)
$$

(ii) If $0<p_{1}<p_{2}<t<r<\infty$ or $0<p_{1}<p_{2} \leq t<r=\infty$, then

$$
M_{p_{2}}^{t, r}(W) \hookrightarrow M_{p_{1}}^{t, r}(W)
$$

(iii) If $0<p \leq t<r=\infty$, then

$$
L^{t}(W) \hookrightarrow M_{p}^{t, r}(W) \hookrightarrow L_{\mathrm{loc}}^{p}(W)
$$

Proof. (i) It comes from $\ell^{r_{1}} \hookrightarrow \ell^{r_{2}}$ since $0<r_{1}<r_{2} \leq \infty$.
(ii) It comes from the Hölder inequality. Indeed, for each $Q \in \mathcal{D}$,

$$
\begin{aligned}
&\left(\frac{1}{W(Q)} \int_{Q}\left|W^{1 / p_{1}}(y) \vec{f}(y)\right|^{p_{1}} \mathrm{~d} y\right)^{1 / p_{1}} \\
&=\left(\frac{1}{W(Q)} \int_{Q}\left|W^{1 / p_{1}-1 / p_{2}}(y) W^{1 / p_{2}}(y) \vec{f}(y)\right|^{p_{1}} \mathrm{~d} y\right)^{1 / p_{1}} \\
& \leq\left(\frac{1}{W(Q)} \int_{Q}\left\|W^{1 / p_{1}-1 / p_{2}}(y)\right\|^{p_{1}}\left|W^{1 / p_{2}}(y) \vec{f}(y)\right|^{p_{1}} \mathrm{~d} y\right)^{1 / p_{1}} \\
& \leq\left(\frac{1}{W(Q)} \int_{Q}\left\|W^{1 / p_{1}-1 / p_{2}}(y)\right\|^{p_{1} p_{2} /\left(p_{2}-p_{1}\right)} \mathrm{d} y\right)^{1 / p_{1}-1 / p_{2}} \\
& \times\left(\frac{1}{W(Q)} \int_{Q}\left|W^{1 / p_{2}}(y) \vec{f}(y)\right|^{p_{2}} \mathrm{~d} y\right)^{1 / p_{2}} \\
&=\left(\frac{1}{W(Q)} \int_{Q}\|W(y)\| \mathrm{d} y\right)^{1 / p_{1}-1 / p_{2}}\left(\frac{1}{W(Q)} \int_{Q}^{\left.\left|W^{1 / p_{2}}(y) \vec{f}(y)\right|^{p_{2}} \mathrm{~d} y\right)^{1 / p_{2}}}\right. \\
&=\left(\frac{1}{W(Q)} \int_{Q}\left|W^{1 / p_{2}}(y) \vec{f}(y)\right|^{p_{2}} \mathrm{~d} y\right)^{1 / p_{2}}
\end{aligned}
$$

Hence,

$$
\|\vec{f}\|_{M_{p_{1}}^{t, r}(W)} \leq\|\vec{f}\|_{M_{p_{2}}^{t, r}(W)}
$$

Thus we prove (ii).
(iii) The first embedding comes from the fact that

$$
L^{t}(W)=M_{t}^{t, \infty}(W) \hookrightarrow M_{p}^{t, \infty}(W) .
$$

For any compact set $K \subset \mathbb{R}^{n}$, there exist at most $2^{n}$ dyadic cubes $Q_{j}$ such that $K \subset \cup_{j=1}^{2 n} Q_{j}$. Hence

$$
\begin{aligned}
\left\|\vec{f} \chi_{K}\right\|_{L^{p}(W)} & \leq \sum_{j=1}^{2^{n}} \frac{\left|Q_{j}\right|^{1 / t-1 / p}}{\left|Q_{j}\right|^{1 / t-1 / p}}\left\|\vec{f} \chi_{Q_{j}}\right\|_{L^{p}(W)} \\
& \leq\|\vec{f}\|_{M_{P}^{t, \infty}(W)} \sum_{j=1}^{2^{n}} \frac{1}{\left|Q_{j}\right|^{1 / t-1 / p}}<\infty .
\end{aligned}
$$

This shows that $M_{p}^{t, r}(W) \hookrightarrow L_{\mathrm{loc}}^{p}(W)$.

Proposition 2. The matrix weighted Bourgain-Morrey space $M_{p}^{t, r}(W)$ is a Banach space when $1 \leq p<t<r<\infty$ or $1 \leq p \leq t<r=\infty$.

Proof. The argument are standard, see, for example, [27, Theorem 2.4]. We only show that $M_{p}^{t, r}(W)$ is complete since others are simple.

Let $\left\{\vec{f}_{j}\right\}_{j=1}^{\infty}$ be a Cauchy sequence in $M_{p}^{t, r}(W)$. By Proposition 1 we have that $\left\{\vec{f}_{j}\right\}_{j=1}^{\infty}$ is also a Cauchy sequence in $L_{\mathrm{loc}}^{p}(W)$. Since $L_{\mathrm{loc}}^{p}(W)$ is complete, there exists a vector function $\vec{f}$ in $L_{\mathrm{loc}}^{p}(W)$ such that $\vec{f} \rightarrow \vec{f}$. By the Fatou lemma,

$$
\|\vec{f}\|_{M_{p}^{t, r}(W)}=\left\|\liminf _{j \rightarrow \infty} \vec{f}_{j}\right\|_{M_{p}^{t, r}(W)} \leq \liminf _{j \rightarrow \infty}\left\|\vec{f}_{j}\right\|_{M_{p}^{t, r}(W)}<\infty
$$

Thus $\vec{f} \in M_{p}^{t, r}(W)$. Therefore,

$$
\limsup _{j \rightarrow \infty}\left\|\vec{f}-\vec{f}_{j}\right\|_{M_{p}^{t, r}(W)} \leq \limsup _{j \rightarrow \infty}\left(\liminf _{k \rightarrow \infty}\left\|\overrightarrow{f_{k}}-\vec{f}_{j}\right\|_{M_{p}^{t, r}(W)}\right)=0
$$

Thus, the sequence $\left\{\vec{f}_{j}\right\}_{j=1}^{\infty}$ is convergent to $\vec{f}$ in $M_{p}^{t, r}(W)$.
Recall that a matrix weight $W$ is almost everywhere invertible. Hereafter, we define $w(x):=\left\|W^{-1}(x)\right\|^{-1}$ when a matrix weight $W$ is invertible at $x \in \mathbb{R}^{n}$.

Lemma 2.14 (Proposition 3.2,[8]). For a matrix weight $W: \mathbb{R}^{n} \rightarrow M_{d}(\mathbb{C})$, we have $0<w(x) \leq\|W(x)\|<\infty$ for a.e. $x \in \mathbb{R}^{n}$. Furthermore, $W$ satisfies a two weight, degenerate ellipticity condition: for $\xi \in \mathbb{R}^{d}$,

$$
\begin{equation*}
w(x)|\xi|^{p} \leq\left|W^{1 / p}(x) \xi\right|^{p} \leq\|W(x)\||\xi|^{p} . \tag{2.7}
\end{equation*}
$$

Remark 2.15. In [8, Proposition 3.2], it is assumed that $\xi \in \mathbb{R}^{d}$ but it also works for $\xi \in \mathbb{C}^{d}$.

Proposition 3. Let $1 \leq p<t<r<\infty$ or $1 \leq p \leq t<r=\infty$. Let $W$ be a matrix weight and $\vec{f}, \vec{g} \in M_{p}^{t, r}(W)$. Then $\|\vec{f}-\vec{g}\|_{M_{p}^{t, r}(W)}=0$ if and only if $\vec{f}(x)=\vec{g}(x)$ a.e..

Proof. Clearly, if $\vec{f}(x)=\vec{g}(x)$ a.e., then $\|\vec{f}-\vec{g}\|_{M_{p}^{t, r}(W)}=0$. Then we apply Lemma 2.14 to prove the converse. By the degenerate ellipticity condition (2.7), we have

$$
\begin{aligned}
0 & =\|\vec{f}-\vec{g}\|_{M_{p}^{t, r}(W)} \\
& \geq\left\|\left\{W\left(Q_{j, k}\right)^{1 / t-1 / p}\left(\int_{Q_{j, k}}|\vec{f}(y)-\vec{g}(y)|^{p} w(y) \mathrm{d} y\right)^{1 / p}\right\}_{j \in \mathbb{Z}, k \in \mathbb{Z}^{n}}\right\|_{\ell^{r}}
\end{aligned}
$$

Since $w(y)>0$ a.e., it follows that $\vec{f}(y)-\vec{g}(y)=0$ a.e..

## 3. Sufficient conditions for precompact sets

Definition 3.1. (i) Suppose that $(X, \rho)$ is a metric space. Let $A$ be a set of $X$ and let $\varepsilon>0$. A set $E \subset X$ is called an $\varepsilon$-net for $A$ if every point $a \in A$, there exists a point $e \in E$ such that $\rho(a, e)<\varepsilon$.
(ii) A set $A$ is called totally bounded if, for each $\varepsilon>0$, it possesses a finite $\varepsilon$-net.
(iii) A subset in a topological space is precompact if its closure is compact.

It is well known that in a complete metric space, a set is precompact if and only if it is totally bounded.

ThEOREM 3.2. Let $1 \leq p<t<r<\infty$ or $1 \leq p \leq t<r=\infty$. Let $W: \mathbb{R}^{n} \rightarrow$ $M_{d}(\mathbb{C})$ be a matrix weight. A subset $\mathcal{F} \subset M_{p}^{t, r}(W)$ is totally bounded if the following conditions are valid:
(i) $\mathcal{F}$ uniformly vanishes at infinity, that is,

$$
\lim _{R \rightarrow \infty} \sup _{\vec{f} \in \mathcal{F}}\left\|\vec{f} \chi_{B^{c}(0, R)}\right\|_{M_{p}^{t, r}(W)}=0
$$

(ii) $\mathcal{F}$ is equicontinuous, that is,

$$
\begin{equation*}
\lim _{b \rightarrow 0} \sup _{\vec{f} \in \mathcal{F}} \sup _{y \in B(0, b)}\left\|\vec{f}-\tau_{y} \vec{f}\right\|_{M_{p}^{t, r}(W)}=0 \tag{3.1}
\end{equation*}
$$

Here and what follows, $\tau_{y}$ denotes the translation operator: $\tau_{y} \vec{f}(x):=\vec{f}(x-y)$.
Remark 3.3. In this Remark, we will prove that the conditions (i) and (ii) in Theorem 3.2 together imply that the set $\mathcal{F}$ is bounded. Indeed, choose $b>0$ such
that for all $h \in \mathbb{R}^{n},|h| \leq b$, all $\vec{f} \in \mathcal{F}$,

$$
\left\|\vec{f}-\tau_{y} \vec{f}\right\|_{M_{p}^{t, r}(W)} \leq 1
$$

Choose $R>0$ such that for all $\vec{f} \in \mathcal{F}$,

$$
\left\|\vec{f} \chi_{B^{c}(0, R)}\right\|_{M_{p}^{t, r}(W)} \leq 1
$$

Fix $h$ with $|h|=b$. Then for all $\vec{f} \in \mathcal{F}, x \in \mathbb{R}^{n}$, we have

$$
\begin{aligned}
\left\|\vec{f} \chi_{B(x, R)}\right\|_{M_{p}^{t, r}(W)} & \leq\left\|\left(\vec{f}-\tau_{h} \vec{f}\right) \chi_{B(x, R)}\right\|_{M_{p}^{t, r}(W)}+\left\|\tau_{h} \vec{f} \chi_{B(x, R)}\right\|_{M_{p}^{t, r}(W)} \\
& =\left\|\left(\vec{f}-\tau_{h} \vec{f}\right) \chi_{B(x, R)}\right\|_{M_{p}^{t, r}(W)}+\left\|\vec{f} \chi_{B(x+h, R)}\right\|_{M_{p}^{t, r}(W)} \\
& \leq 1+\left\|\vec{f} \chi_{B(x+h, R)}\right\|_{M_{p}^{t, r}(W)}
\end{aligned}
$$

Hence, by induction,

$$
\left\|\vec{f} \chi_{B(0, R)}\right\|_{M_{p}^{t, r}(W)} \leq N+\left\|\vec{f} \chi_{B(N h, R)}\right\|_{M_{p}^{t, r}(W)}
$$

Now choose $N \geq 1$ such that $N b=N|h|>2 R$. Then $B(N h, R) \subset B^{c}(0, R)$. Hence

$$
\begin{aligned}
\|\vec{f}\|_{M_{p}^{t, r}(W)} & \leq\left\|\vec{f} \chi_{B(0, R)}\right\|_{M_{p}^{t, r}(W)}+\left\|\vec{f} \chi_{B^{c}(0, R)}\right\|_{M_{p}^{t, r}(W)} \\
& \leq N+\left\|\vec{f} \chi_{B(N h, R)}\right\|_{M_{p}^{t, r}(W)}+\left\|\vec{f} \chi_{B^{c}(0, R)}\right\|_{M_{p}^{t, r}(W)} \leq N+2
\end{aligned}
$$

This proves that $\mathcal{F}$ is bounded.
Proof of Theorem 3.2. Assume that $\mathcal{F} \subset M_{p}^{t, r}(W)$ satisfies (i) and (ii). Given $\varepsilon>0$ small enough, to prove the total boundedness of $\mathcal{F}$, it suffices to find a finite $\varepsilon$-net of $\mathcal{F}$. Denote by $R_{i}:=\left[-2^{i}, 2^{i}\right)^{n}$ for $i \in \mathbb{Z}$. Then from condition (i), there exist a positive integer $m$ large enough such that

$$
\begin{equation*}
\sup _{\vec{f} \in \mathcal{F}}\left\|\vec{f}-\vec{f} \chi_{R_{m}}\right\|_{M_{p}^{t, r}(W)}<\varepsilon . \tag{3.2}
\end{equation*}
$$

Moreover, by condition (ii), there exists a negative integer $a$ such that

$$
\begin{equation*}
\sup _{\vec{f} \in \mathcal{F}} \sup _{y \in R_{a}}\left\|\vec{f}-\tau_{y} \vec{f}\right\|_{M_{p}^{t, r}(W)}<\varepsilon . \tag{3.3}
\end{equation*}
$$

There exists a sequence $\left\{Q_{j}\right\}_{j=1}^{N}$ of disjoint cubes in $\mathcal{D}_{-a}$ such that $R_{m}=\cup_{i=1}^{N} Q_{j}$, where $N=2^{(m+1-a) n}$.

For any $\vec{f} \in \mathcal{F}$ and $x \in \mathbb{R}^{n}$, let

$$
\Phi(\vec{f})(x):= \begin{cases}\vec{f}_{Q_{j}}:=\frac{1}{\left|Q_{j}\right|} \int_{Q_{j}} \vec{f}(y) \mathrm{d} y, & x \in Q_{j}, j=1,2, \ldots, N \\ \overrightarrow{0}, & \text { otherwise }\end{cases}
$$

Then for each fixed $x \in \mathbb{R}^{n}$, we have

$$
\begin{align*}
\left|W(x)\left(\vec{f}(x)-\vec{f}_{Q_{j}}\right)\right| \chi_{Q_{j}}(x) & =\left|\frac{1}{\left|Q_{j}\right|} \int_{Q_{j}} W(x)(\vec{f}(x)-\vec{f}(y)) \mathrm{d} y\right| \chi_{Q_{j}}(x) \\
& \leq \frac{1}{\left|Q_{j}\right|} \int_{Q_{j}}|W(x)(\vec{f}(x)-\vec{f}(y))| \mathrm{d} y \chi_{Q_{j}}(x) . \tag{3.4}
\end{align*}
$$

We split $\left\|(\vec{f}-\Phi(\vec{f})) \chi_{R_{m}}\right\|_{M_{p}^{t, r}(W)}$ into three parts:

$$
\begin{aligned}
& \left\{\sum_{k \in \mathbb{Z}} \sum_{Q \in \mathcal{D}_{k}} W(Q)^{r / t-r / p}\left(\int_{Q}\left|W(x)\left(\vec{f}(x) \chi_{R_{m}}-\Phi(\vec{f})(x)\right)\right|^{p} \mathrm{~d} x\right)^{r / p}\right\}^{1 / r} \\
& \leq\left\{\sum_{k>-a} \sum_{Q \in \mathcal{D}_{k}} W(Q)^{r / t-r / p}\left(\int_{Q}\left|W(x)\left(\vec{f}(x) \chi_{R_{m}}-\vec{f}_{Q_{j}}\right)\right|^{p} \mathrm{~d} x\right)^{r / p}\right\}^{1 / r} \\
& \quad+\left\{\sum_{k=-m}^{-a} \sum_{Q \in \mathcal{D}_{k}} W(Q)^{r / t-r / p}\left(\int_{Q}\left|W(x)\left(\vec{f}(x) \chi_{R_{m}}-\Phi(\vec{f})(x)\right)\right|^{p} \mathrm{~d} x\right)^{r / p}\right\}^{1 / r} \\
& \quad+\left\{\sum_{k<-m} \sum_{Q \in \mathcal{D}_{k}} W(Q)^{r / t-r / p}\left(\int_{Q}\left|W(x)\left(\vec{f}(x) \chi_{R_{m}}-\Phi(\vec{f})(x)\right)\right|^{p} \mathrm{~d} x\right)^{r / p}\right\}^{1 / r} \\
& =:
\end{aligned}
$$

We first estimate $S_{1}$. By (3.4), Jensen's inequality $(p \geq 1)$, the Fubini theorem, we have

$$
\begin{aligned}
S_{1} \leq & \left\{\sum_{k>-a} \sum_{Q \in \mathcal{D}_{k}, Q \subset R_{m}} W(Q)^{r / t-r / p}\right. \\
& \left.\times\left(\int_{Q}\left|\frac{1}{\left|Q_{j}\right|} \int_{Q_{j}}\right| W(x)(\vec{f}(x)-\vec{f}(y))\left|\mathrm{d} y \chi_{Q_{j}}(x)\right|^{p} \mathrm{~d} x\right)^{r / p}\right\}^{1 / r} \\
\leq & \left\{\sum_{k>-a} \sum_{Q \in \mathcal{D}_{k}, Q \subset R_{m}} W(Q)^{r / t-r / p}\right. \\
& \left.\times\left(\frac{1}{\left|Q_{j}\right|} \int_{Q_{j}} \int_{Q}|W(x)(\vec{f}(x)-\vec{f}(y))|^{p} \mathrm{~d} x \mathrm{~d} y\right)^{r / p}\right\}^{1 / r}
\end{aligned}
$$

$$
\begin{align*}
= & \left\{\sum_{k>-a} \sum_{Q \in \mathcal{D}_{k}, Q \subset R_{m}} W(Q)^{r / t-r / p}\right. \\
& \left.\times\left(\frac{1}{\left|Q_{j}\right|} \int_{Q} \int_{Q_{j}}|W(x)(\vec{f}(x)-\vec{f}(y))|^{p} \mathrm{~d} y \mathrm{~d} x\right)^{r / p}\right\}^{1 / r} \\
= & 2^{-a n / p}\left\{\sum_{k>-a} \sum_{Q \in \mathcal{D}_{k}, Q \subset R_{m}} W(Q)^{r / t-r / p}\right. \\
& \left.\times\left(\int_{Q} \int_{x-Q_{j}}|W(x)(\vec{f}(x)-\vec{f}(x-y))|^{p} \mathrm{~d} y \mathrm{~d} x\right)^{r / p}\right\}^{1 / r} \tag{3.5}
\end{align*}
$$

where $x-Q_{j}:=\left\{x-y: y \in Q_{j}\right\}$. Since $x \in Q \subset Q_{j}$ for some $j \in\{1,2, \ldots, N\}$, we have $x-Q_{j} \subset R_{a}$. Hence by (3.3), we obtain

$$
\begin{aligned}
(3.5) \leq & 2^{-a n / p}\left|Q_{j}\right|^{1 / p} \sup _{y \in R_{a}}\left\{\sum_{k>-a} \sum_{Q \in \mathcal{D}_{k}, Q \subset R_{m}} W(Q)^{r / t-r / p}\right. \\
& \left.\times\left(\int_{Q}|W(x)(\vec{f}(x)-\vec{f}(x-y))|^{p} \mathrm{~d} x\right)^{r / p}\right\}^{1 / r} \\
\leq & \varepsilon .
\end{aligned}
$$

As for $S_{2}$, for each $Q \in \mathcal{D}_{k}$ where $k=-m,-m+1, \ldots,-a$, there are $2^{(-k-a) n}$ cubes $Q_{j} \in \mathcal{D}_{-a}$ such that $\cup Q_{j}=Q$. Denote by $Q_{j_{\ell}}, \ell=1,2, \ldots, 2^{(-k-a) n}$ these cubes. Then by (3.4), Jensen's inequality ( $p \geq 1$ ), the Fubini theorem, we obtain

$$
\begin{aligned}
S_{2}= & \left\{\sum_{k=-m}^{-a} \sum_{Q \in \mathcal{D}_{k}, Q \subset R_{m}} W(Q)^{r / t-r / p}\right. \\
& \left.\times\left(\sum_{\ell=1}^{2^{(-k-a) n}} \int_{Q_{j_{\ell}}}\left|W(x)\left(\vec{f}(x) \chi_{R_{m}}-\vec{f}_{Q_{j_{\ell}}}\right)\right|^{p} \mathrm{~d} x\right)^{r / p}\right\}^{1 / r} \\
\leq & \left\{\sum_{k=-m}^{-a} \sum_{Q \in \mathcal{D}_{k}, Q \subset R_{m}} W(Q)^{r / t-r / p}\right. \\
& \left.\times\left(\sum_{\ell=1}^{2(-k-a) n} \int_{Q_{j_{\ell}}}\left|\frac{1}{\left|Q_{j_{\ell}}\right|} \int_{Q_{j_{\ell}}}\right| W(x)(\vec{f}(x)-\vec{f}(y))|\mathrm{d} y|^{p} \mathrm{~d} x\right)^{r / p}\right\}^{1 / r}
\end{aligned}
$$

$$
\begin{align*}
\leq & \left\{\sum_{k=-m}^{-a} \sum_{Q \in \mathcal{D}_{k}, Q \subset R_{m}} W(Q)^{r / t-r / p}\right. \\
& \left.\times\left(\sum_{\ell=1}^{2^{(-k-a) n}} \frac{1}{\left|Q_{j_{\ell} \ell}\right|} \int_{Q_{j_{\ell}}} \int_{Q_{j_{\ell}}}|W(x)(\vec{f}(x)-\vec{f}(y))|^{p} \mathrm{~d} x \mathrm{~d} y\right)^{r / p}\right\}^{1 / r} \\
= & 2^{-a n / p}\left\{\sum_{k=-m}^{-a} \sum_{Q \in \mathcal{D}_{k}, Q \subset R_{m}} W(Q)^{r / t-r / p}\right. \\
& \left.\times\left(\sum_{\ell=1}^{2^{(-k-a) n}} \int_{Q_{j_{\ell}}} \int_{Q_{j_{\ell}}}|W(x)(\vec{f}(x)-\vec{f}(y))|^{p} \mathrm{~d} y \mathrm{~d} x\right)^{r / p}\right\}^{1 / r} \\
= & 2^{-a n / p}\left\{\sum_{k=-m}^{-a} \sum_{Q \in \mathcal{D}_{k}, Q \subset R_{m}} W(Q)^{r / t-r / p}\right.  \tag{3.6}\\
& \left.\times\left(\sum_{\ell=1}^{2(-k-a) n} \int_{Q_{j_{\ell}}} \int_{x-Q_{j_{\ell}}}|W(x)(\vec{f}(x)-\vec{f}(x-y))|^{p} \mathrm{~d} y \mathrm{~d} x\right)^{r / p}\right\}^{1 / r}
\end{align*}
$$

where $x-Q_{j_{\ell}}:=\left\{x-y: y \in Q_{j_{\ell}}\right\}$. Note that $x-Q_{j_{\ell}} \subset R_{a}$ when $x \in Q_{j_{\ell}}$. By (3.3), we have

& \left.\times\left(\sum_{\ell=1}^{2^{(-k-a) n}} \int_{Q_{j_{\ell}}}|W(x)(\vec{f}(x)-\vec{f}(x-y))|^{p} \mathrm{~d} x\right)^{r / p}\right\}^{1 / r} \\
\leq & \varepsilon
\end{aligned}
$$

As for $S_{3}$, for each set $\mathcal{D}_{k}$, there are only $2^{n}$ cubes $Q \in \mathcal{D}_{k}$ such that $Q \cap R_{m} \neq \emptyset$. We denote by $Q_{\ell}, \ell=1,2, \ldots, 2^{n}$ these cubes. And for each cube $Q_{\ell}$, there are $2^{(m-a) n}$ cubes $Q_{j} \in \mathcal{D}_{-a}$ such that $\cup_{j} Q_{j}=Q_{\ell}$. Then
$S_{3}=\left\{\sum_{k<-m} \sum_{\ell=1}^{2^{n}} W\left(Q_{\ell}\right)^{r / t-r / p}\left(\int_{Q_{\ell}}\left|W(x)\left(\vec{f}(x) \chi_{R_{m}}-\Phi(\vec{f})(x)\right)\right|^{p} \mathrm{~d} x\right)^{r / p}\right\}^{1 / r}$

$$
=\left\{\sum_{k<-m} \sum_{\ell=1}^{2^{n}} W\left(Q_{\ell}\right)^{r / t-r / p}\left(\sum_{j=1}^{2^{(m-a) n}} \int_{Q_{j}}\left|W(x)\left(\vec{f}(x) \chi_{R_{m}}-\vec{f}_{Q_{j}}\right)\right|^{p} \mathrm{~d} x\right)^{r / p}\right\}^{1 / r} .
$$

Similarly as $S_{2}$, from (3.4), Jensen's inequality ( $p \geq 1$ ), the Fubini theorem, and (3.3), we get that $S_{3} \leq \varepsilon$. Together with the estimates of $S_{1}, S_{2}, S_{3}$, we obtain

\left\{\sum_{k \in \mathbb{Z}} \sum_{Q \in \mathcal{D}_{k}} W(Q)^{r / t-r / p}\left(\int_{Q}\left|W(x)\left(\vec{f}(x) \chi_{R_{m}}-\Phi(\vec{f})(x)\right)\right|^{p} \mathrm{~d} x\right)^{r / p}\right\}^{1 / r} \leq 3 \varepsilon . \tag{3.7}
\end{equation*}
$$

Note that

\begin{aligned}
\|\vec{f}-\Phi(\vec{f})\|_{M_{p}^{t, r}(W)} & \leq\left\|(\vec{f}-\Phi(\vec{f})) \chi_{R_{m}}\right\|_{M_{p}^{t, r}(W)}+\left\|(\vec{f}-\Phi(\vec{f})) \chi_{R_{m}^{c}}\right\|_{M_{p}^{t, r}(W)} \\
& =\left\|(\vec{f}-\Phi(\vec{f})) \chi_{R_{m}}\right\|_{M_{p}^{t, r}(W)}+\left\|\vec{f} \chi_{R_{m}^{c}}\right\|_{M_{p}^{t, r}(W)} .
\end{aligned}
$$

Thus via (3.2) and (3.7), we have

\sup _{\vec{f} \in \mathcal{F}}\|\vec{f}-\Phi(\vec{f})\|_{M_{p}^{t, r}(W)} \leq 4 \varepsilon . \tag{3.8}
\end{equation*}
$$

From (3.8), it suffices to show that $\Phi(\mathcal{F})$ is totally bounded in $M_{p}^{t, r}(W)$.
From Remark 3.3 we have

$$
\sup _{\vec{f} \in \mathcal{F}}\|\Phi(\vec{f})\|_{M_{p}^{t, r}(W)} \leq \sup _{\vec{f} \in \mathcal{F}}\|\Phi(\vec{f})-\vec{f}\|_{M_{p}^{t, r}(W)}+\sup _{\vec{f} \in \mathcal{F}}\|\vec{f}\|_{M_{p}^{t, r}(W)}<\infty .
$$

Thus, for any $\vec{f} \in \mathcal{F}$,

$$
\begin{equation*}
\left|W^{1 / p}(x) \Phi(\vec{f})(x)\right|<\infty \quad \text { a.e. } \quad x \in \mathbb{R}^{n} \tag{3.9}
\end{equation*}
$$

Since $W$ is a matrix weight, by (i), (ii) of Definition [2.3, we have for almost everywhere $x \in \mathbb{R}^{n}, W(x)$ is a positive definite matrix. Therefore, we obtain

$$
\begin{equation*}
|\Phi(\vec{f})(x)|<\infty \quad \text { a.e. } \quad x \in \mathbb{R}^{n} . \tag{3.10}
\end{equation*}
$$

which implies $\left|\vec{f}_{Q_{j}}\right|<\infty, j=1,2, \ldots, N$. From this and the entries of $W$ is locally integrable, we see that $\Phi$ is a map from $\mathcal{F}$ to $\mathcal{B}$, a finite dimensional Banach subspace of $M_{p}^{t, r}(W)$. Note that $\Phi(\mathcal{F}) \subset \mathcal{B}$ is bounded, and hence is totally bounded. The proof of Theorem 3.2 is complete.

Then we give an application in degenerate Bourgain-Morrey-Sobolev spaces with matrix weights.

Definition 3.4. Let $1 \leq p<t<r<\infty$ or $1 \leq p \leq t<r=\infty$. Let $W: \mathbb{R}^{n} \rightarrow M_{n}(\mathbb{C})$ be a matrix weight and set the scalar weight $\omega:=\|W\|$. We
define the degenerate Bourgain-Morrey-Sobolev spaces $\mathcal{W}^{1, p, t, r}(W)$ by the set of all Lebesgue measurable functions on $\mathbb{R}^{n}$ such that

$$
\|f\|_{\mathcal{W}^{1, p, t, r}(W)}:=\|f\|_{M_{p}^{t, r}(\omega)}+\|\nabla f\|_{M_{p}^{t, r}(W)}<\infty
$$

where $\nabla f=\left(\partial_{x_{1}} f, \ldots, \partial_{x_{n}} f\right)^{T}$ is the gradient of $f$ and

$$
\|f\|_{M_{p}^{t, r}(\omega)}:=\left\|\left\{\omega\left(Q_{j, k}\right)^{1 / t-1 / p}\left(\int_{Q_{j, k}}|f(y)|^{p} \omega(y) \mathrm{d} y\right)^{1 / p}\right\}_{j \in \mathbb{Z}, k \in \mathbb{Z}^{n}}\right\|_{\ell^{r}}
$$

is the norm of the scalar weighted Bourgain-Morrey space in (2.6).
Lemma 3.5 (p. 262, [33). A set $\mathcal{F}$ in metric space $X$ is totally bounded if and only if it is Cauchy-precompact, that is, every sequence has a Cauchy subsequence.

Corollary 3.6. Let $1 \leq p<t<r<\infty$ or $1 \leq p \leq t<r=\infty$. Let $W: \mathbb{R}^{n} \rightarrow M_{n}(\mathbb{C})$ be a matrix weight. A subset $\mathcal{F} \subset \mathcal{W}^{1, p, t, r}(W)$ is totally bounded if the following conditions are valid:
(i) $\mathcal{F}$ uniformly vanishes at infinity, that is,

$$
\lim _{R \rightarrow \infty} \sup _{\vec{f} \in \mathcal{F}}\left\|\vec{f} \chi_{B^{c}(0, R)}\right\|_{\mathcal{W}^{1, p, t, r}(W)}=0
$$

(ii) $\mathcal{F}$ is equicontinuous, that is,

$$
\lim _{a \rightarrow 0} \sup _{\vec{f} \in \mathcal{F}} \sup _{y \in B(0, a)}\left\|\vec{f}-\tau_{y} \vec{f}\right\|_{\mathcal{W}^{1, p, t, r}(W)}=0
$$

Proof. Note that $\mathcal{F} \subset \mathcal{W}^{1, p, t, r}(W)$ satisfies conditions (i)-(ii) if and only if $\mathcal{F} \subset M_{p}^{t, r}(\omega)$ satisfies conditions (i)-(ii) of Theorem 3.2 $(d=1)$ and $\nabla \mathcal{F}:=\{\nabla f:$ $f \in \mathcal{F}\} \subset M_{p}^{t, r}(W)$ satisfies (i)-(ii) of Theorem $3.2(d=n)$. Hence by Theorem 3.2, we obtain that both $\mathcal{F} \subset M_{p}^{t, r}(\omega)$ and $\nabla \mathcal{F} \subset M_{p}^{t, r}(W)$ are totally bounded. Then Corollary 3.6 follows from Lemma 3.5.

## 4. Dyadic average operator conditions for precompact sets

In this section, we give a criterion for precompactness by dyadic average operator. Let $\mathcal{F}$ be a subset of $M_{p}^{t, r}(W) . \mathcal{F}$ is equicontinuous by means of the dyadic average operator if

$$
\begin{equation*}
\lim _{a \rightarrow-\infty, a \in \mathbb{Z}} \sup _{\vec{f} \in \mathcal{F}}\left\|\vec{f}-E_{d, a} \vec{f}\right\|_{M_{p}^{t, r}(W)}=0 \tag{4.1}
\end{equation*}
$$

where

$$
\begin{equation*}
E_{d, a} \vec{f}(x):=\sum_{Q \in \mathcal{D}_{-a}} \frac{\chi_{Q}(x)}{|Q|} \int_{Q} \vec{f}(y) \mathrm{d} y \tag{4.2}
\end{equation*}
$$

Recall that $x_{Q}$ is the left corner of $Q \in \mathcal{D}$. Then for $x \in Q \in \mathcal{D}_{-a}$

$$
E_{d, a} \vec{f}(x)=\frac{\chi_{Q_{-a, 0}}\left(x-x_{Q}\right)}{\left|Q_{-a, 0}\right|} \int_{Q_{-a, 0}} \vec{f}\left(y-x_{Q}\right) \mathrm{d} y .
$$

Then we will prove that (3.1) is stronger than (4.1). Indeed, suppose that condition (3.1) holds. For any $\varepsilon>0$, there exists a cube $R$ with center 0 and side length $2^{a+1}>0$ such that

$$
\begin{equation*}
\sup _{\vec{f} \in \mathcal{F}} \sup _{y \in R}\left\|\vec{f}-\tau_{y} \vec{f}\right\|_{M_{p}^{t, r}(W)}<\varepsilon \tag{4.3}
\end{equation*}
$$

If $x, y \in Q \in \mathcal{D}_{-a}$, then $x-y \in R$. By Jensen's inequality $(p \geq 1)$, Hölder's inequality $(r / p \geq 1)$, (4.3), we obtain

$$
\begin{aligned}
\| \vec{f} & -E_{d, a} \vec{f} \|_{M_{p}^{t, r}(W)}=\left(\sum _ { Q \in \mathcal { D } } W ( Q ) ^ { r / t - r / p } \left(\int_{Q} \left\lvert\, \frac{1}{\left|Q_{-a, 0}\right|}\right.\right.\right. \\
& \left.\left.\times\left.\int_{Q_{-a, 0}} W^{1 / p}(x)\left(\vec{f}(x)-\chi_{Q_{-a, 0}}\left(x-x_{Q}\right) \vec{f}\left(y-x_{Q}\right)\right) \mathrm{d} y\right|^{p} \mathrm{~d} x\right)^{r / p}\right)^{1 / r} \\
\leq & \left(\sum _ { Q \in \mathcal { D } } W ( Q ) ^ { r / t - r / p } \left(\frac{1}{\left|Q_{-a, 0}\right|} \int_{Q_{-a, 0}}\right.\right. \\
& \left.\left.\times \int_{Q}\left|W^{1 / p}(x)\left(\vec{f}(x)-\chi_{Q_{-a, 0}}\left(x-x_{Q}\right) \vec{f}\left(y-x_{Q}\right)\right)\right|^{p} \mathrm{~d} x \mathrm{~d} y\right)^{r / p}\right)^{1 / r} \\
\leq & \left(\sum_{Q \in \mathcal{D}} W^{1 / r}\right)^{r / t-r / p} \frac{1}{\left|Q_{-a, 0}\right|} \int_{Q_{-a, 0}} \\
& \left.\times\left(\int_{Q}\left|W^{1 / p}(x)\left(\vec{f}(x)-\chi_{Q-a, 0}\left(x-x_{Q}\right) \vec{f}\left(y-x_{Q}\right)\right)\right|^{p} \mathrm{~d} x\right)^{r / p} \mathrm{~d} y\right)^{1 / r} \\
\leq & \frac{1}{\left|Q_{-a, 0}\right|^{1 / r}}\left|Q_{-a, 0}\right|^{1 / r} \sup _{y \in R}\left(\sum_{Q \in \mathcal{D}} W(Q)^{r / t-r / p}\right. \\
& \left.\times\left(\int_{Q}\left|W^{1 / p}(x)(\vec{f}(x)-\vec{f}(x-y))\right|^{p} \mathrm{~d} x\right)^{r / p}\right)^{1 / r} \\
\leq & \varepsilon
\end{aligned}
$$

modified when $r=\infty$. Hence we prove that (3.1) is stronger than (4.1).

Replacing the translation operator by the average operator, we have the following result.

THEOREM 4.1. Let $1 \leq p<t<r<\infty$ or $1 \leq p \leq t<r=\infty$. Let $W: \mathbb{R}^{n} \rightarrow$ $M_{d}(\mathbb{C})$ be a matrix weight. A subset $\mathcal{F} \subset M_{p}^{t, r}(W)$ is totally bounded if the following conditions are valid:
(i) $\mathcal{F}$ is bounded, that is,

$$
\sup _{\vec{f} \in \mathcal{F}}\|\vec{f}\|_{M_{p}^{t, r}(W)}<\infty ;
$$

(ii) $\mathcal{F}$ uniformly vanishes at infinity, that is,

$$
\lim _{R \rightarrow \infty} \sup _{\vec{f} \in \mathcal{F}}\left\|\vec{f} \chi_{B^{c}(0, R)}\right\|_{M_{p}^{t, r}(W)}=0
$$

(iii) $\mathcal{F}$ is equicontinuous by means of the dyadic average operator, that is, for any

$$
\lim _{a \rightarrow-\infty, a \in \mathbb{Z}} \sup _{\vec{f} \in \mathcal{F}}\left\|\vec{f}-E_{d, a} \vec{f}\right\|_{M_{p}^{t, r}(W)}=0
$$

where $E_{d, a}$ is same as (4.2).
Proof. Assume that $\mathcal{F} \subset M_{p}^{t, r}(W)$ satisfies (i)-(iii). Given $\varepsilon>0$ small enough, to prove the total boundedness of $\mathcal{F}$, it suffices to find a finite $\varepsilon$-net of $\mathcal{F}$. Denote by $R_{i}:=\left[-2^{i}, 2^{i}\right)^{n}$ for $i \in \mathbb{Z}$. Then from condition (ii), there exists a positive integer $m$ large enough such that

$$
\begin{equation*}
\sup _{\vec{f} \in \mathcal{F}}\left\|\vec{f}-\vec{f} \chi_{R_{m}}\right\|_{M_{p}^{t, r}(W)}<\varepsilon \tag{4.4}
\end{equation*}
$$

Moreover, by condition (iii), there exists an integer $a<0$ such that

$$
\begin{equation*}
\sup _{\vec{f} \in \mathcal{F}}\left\|\vec{f}-E_{d, a} \vec{f}\right\|_{M_{p}^{t, r}(W)}<\varepsilon . \tag{4.5}
\end{equation*}
$$

There exists a sequence $\left\{Q_{j}\right\}_{j=1}^{N}$ of disjoint cubes in $\mathcal{D}_{-a}$ such that $R_{m}=\cup_{i=1}^{N} Q_{j}$, where $N=2^{(m+1-a) n}$.

For any $\vec{f} \in \mathcal{F}$ and $x \in \mathbb{R}^{n}$, let

$$
\Phi(\vec{f})(x):= \begin{cases}\overrightarrow{f_{Q_{j}}}:=\frac{1}{\left|Q_{j}\right|} \int_{Q_{j}} \vec{f}(y) \mathrm{d} y, & x \in Q_{j}, j=1,2, \ldots, N \\ \overrightarrow{0}, & \text { otherwise }\end{cases}
$$

Note that for $x \in R_{m}$,

$$
\Phi(\vec{f})(x)=E_{d, a} \vec{f}(x)
$$

Hence via (4.4) and (4.5), we have

$$
\begin{align*}
\|\vec{f}-\Phi(\vec{f})\|_{M_{p}^{t, r}(W)} & \leq\left\|(\vec{f}-\Phi(\vec{f})) \chi_{R_{m}}\right\|_{M_{p}^{t, r}(W)}+\left\|(\vec{f}-\Phi(\vec{f})) \chi_{R_{m}^{c}}\right\|_{M_{p}^{t, r}(W)} \\
& =\left\|\left(\vec{f}-E_{d, a} \vec{f}\right) \chi_{R_{m}}\right\|_{M_{p}^{t, r}(W)}+\left\|\vec{f} \chi_{R_{m}^{c}}\right\|_{M_{p}^{t, r}(W)} \\
& \leq\left\|\left(\vec{f}-E_{d, a} \vec{f}\right)\right\|_{M_{p}^{t, r}(W)}+\varepsilon \\
& \leq 2 \varepsilon . \tag{4.6}
\end{align*}
$$

From (4.6), it suffices to show that $\Phi(\mathcal{F})$ is totally bounded in $M_{p}^{t, r}(W)$. And we have proved that $\Phi(\mathcal{F})$ is totally bounded in $M_{p}^{t, r}(W)$ in Theorem 3.2. Thus the proof of Theorem 4.1 is complete.

Lemma 4.2 (Lemma 4.5, [8]). Let $1 \leq p<\infty$ and $W \in \mathcal{A}_{p}$. Then $\|W\|$ and $\left\|W^{-1}\right\|^{-1}$ are scalar $A_{p}$ weights.

The following is a vector-valued extension of the Lebesgue differentiation theorem on matrix weighted spaces $M_{p}^{t, r}(W)$. For any cube $Q, \vec{f} \in L_{\mathrm{loc}}^{1}\left(\mathbb{R}^{n}\right)$, define

$$
E_{Q}(\vec{f})(x)=\frac{1}{|Q|} \int_{Q} \vec{f}(y) \mathrm{d} y
$$

ThEOREM 4.3. Let $1 \leq p<t<r<\infty$ or $1 \leq p \leq t<r=\infty$. If $W \in \mathcal{A}_{p}$, then for any $\vec{f} \in M_{p}^{t, r}(W)$,

$$
\lim _{\ell(Q) \rightarrow 0}\left|E_{Q} \vec{f}(x)-\vec{f}(x)\right|=0 \quad \text { a.e. } \quad x \in \mathbb{R}^{n}
$$

Proof. First, for any $\vec{f}=\left(f_{1}, f_{2}, \ldots, f_{d}\right)^{T} \in M_{p}^{t, r}(W)$, it suffices to show that $f_{i} \in L_{\mathrm{loc}}^{1}\left(\mathbb{R}^{n}\right)$ for each $i=1,2, \ldots, d$. Since $W \in \mathcal{A}_{p}$, then by (2.3)

$$
|\vec{f}|^{p}=\left|W^{-1 / p} W^{1 / p} \vec{f}\right|^{p} \leq\left\|W^{-1 / p}\right\|^{p}\left|W^{1 / p} \vec{f}\right|^{p}=\left\|W^{-1}\right\|\left|W^{1 / p} \vec{f}\right|^{p}
$$

It follows that

$$
|\vec{f}|^{p}\left\|W^{-1}\right\|^{-1} \leq\left|W^{1 / p} \vec{f}\right|^{p}
$$

From Lemma 4.2, we conclude that $\left\|W^{-1}\right\|^{-1}$ is a scalar $A_{p}$ weight, hence $|\vec{f}| \in$ $L_{\mathrm{loc}}^{1}\left(\mathbb{R}^{n}\right)$. Indeed, since any compact set $K \subset \mathbb{R}^{n}$ can be contained in a finite set of dyadic cubes, it suffices to show that for any $Q \in \mathcal{D},|\vec{f}| \in L^{1}(Q)$. By Hölder's inequality, we have

$$
\begin{aligned}
\int_{Q}|\vec{f}| \mathrm{d} x & =\int_{Q}|\vec{f}|\left\|W^{-1}\right\|^{-1 / p}\left\|W^{-1}\right\|^{1 / p} \mathrm{~d} x \\
& \leq\left(\int_{Q}|\vec{f}|^{p}\left\|W^{-1}\right\|^{-1} \mathrm{~d} x\right)^{1 / p}\left(\int_{Q}\left\|W^{-1}\right\|^{p^{\prime} / p} \mathrm{~d} x\right)^{1 / p^{\prime}}
\end{aligned}
$$

$$
\begin{aligned}
& \leq C_{Q, W, p}\left(\int_{Q}\left|W^{1 / p} \vec{f}\right|^{p} \mathrm{~d} x\right)^{1 / p} \\
& \lesssim\|\vec{f}\|_{M_{p}^{t, r}(W)}<\infty
\end{aligned}
$$

Hence, $f_{i} \in L_{\text {loc }}^{1}\left(\mathbb{R}^{n}\right)$ for each $i=1,2, \ldots, d$. By the classical Lebesgue differentiation theorem, for each $1 \leq i \leq d$, we have

$$
\lim _{\ell(Q) \rightarrow 0}\left|E_{Q} f_{i}(x)-f_{i}(x)\right|=0 \quad \text { a.e. } \quad x \in \mathbb{R}^{n}
$$

Theorem 4.3 comes from the fact that for any $x \in \mathbb{R}^{n}$,

$$
\left|E_{Q} \vec{f}(x)-\vec{f}(x)\right| \leq d^{1 / 2} \max _{i}\left|E_{Q} f_{i}(x)-f_{i}(x)\right|
$$

Next we need the boundedness of dyadic average operator. Given any collection $\mathcal{Q}$ of pairwise disjoint cubes $Q \subset \mathbb{R}^{n}$, define the averaging operator $A_{\mathcal{Q}}$ by

$$
A_{\mathcal{Q}} \vec{f}(x)=\sum_{Q \in \mathcal{Q}} \frac{\chi_{Q}(x)}{|Q|} \int_{Q} \vec{f}(y) \mathrm{d} y
$$

Lemma 4.4 (Proposition $4.7,[8])$. Let $1 \leq p<\infty$. Let $W: \mathbb{R}^{n} \rightarrow M_{d}(\mathbb{C})$ be a matrix weight. Then $W \in \mathcal{A}_{p}$ if and only it satisfies

$$
\left\|A_{\mathcal{Q}} \vec{f}\right\|_{L^{p}(W)} \leq C_{n, d, p, W}\|\vec{f}\|_{L^{p}(W)}
$$

ThEOREM 4.5. Let $W \in \mathcal{A}_{p}$ has the $\mathcal{A}_{p}$-dimension $\tilde{d} \in[0, n)$ with the doubling exponent $\beta$.
(i) Let $1 \leq p<t<r<\infty$. If $(\tilde{d}-n+\beta) r / p+n-\beta r / t<0$, then for each $a \in \mathbb{Z}$, $E_{d, a}$ is a bounded operator on matrix weighted Bourgain-Morrey spaces $M_{p}^{t, r}(W)$.
(ii) Let $1 \leq p \leq t<r=\infty$. If $\tilde{d} / p-n / p-\beta(1 / t-1 / p) \leq 0$, then for each $a \in \mathbb{Z}$, $E_{d, a}$ is a bounded operator on matrix weighted Bourgain-Morrey spaces $M_{p}^{t, r}(W)$.

Proof. (i) For a fixed $a \in \mathbb{Z}$, we have

$$
\begin{aligned}
\left\|E_{d, a} \vec{f}\right\|_{M_{p}^{t, r}(W)} & \leq\left(\sum_{j \leq-a} \sum_{Q \in \mathcal{D}_{j}} W(Q)^{r / t-r / p}\left(\int_{Q}\left|W^{1 / p}(x) E_{d, a} \vec{f}(x)\right|^{p} \mathrm{~d} x\right)^{r / p}\right)^{1 / r} \\
& +\left(\sum_{j>-a} \sum_{Q \in \mathcal{D}_{j}} W(Q)^{r / t-r / p}\left(\int_{Q}\left|W^{1 / p}(x) E_{d, a} \vec{f}(x)\right|^{p} \mathrm{~d} x\right)^{r / p}\right)^{1 / r} \\
& =: S_{1}+S_{2}
\end{aligned}
$$

By Lemma 4.4, we obtain

$$
\begin{aligned}
S_{1} & \leq C_{n, d, p, W}\left(\sum_{j \leq-a} \sum_{Q \in \mathcal{D}_{j}} W(Q)^{r / t-r / p}\left(\int_{Q}\left|W^{1 / p}(x) \vec{f}(x)\right|^{p} \mathrm{~d} x\right)^{r / p}\right)^{1 / r} \\
& \lesssim\|\vec{f}\|_{M_{p}^{t, r}(W)}
\end{aligned}
$$

When $j>-a$, we denote by $(j+a)_{\mathrm{pa}} Q \in \mathcal{D}_{-a}$ the $(j+a)$-th dyadic parent of $Q \in \mathcal{D}_{j}$. Let $\left\{A_{Q}\right\}_{Q \in \mathcal{D}}$ be the reducing operator of order $p$ for $W$. By Lemmas 2.8, we have

$$
\begin{equation*}
\left\|A_{Q} A_{(j+a)_{\mathrm{pa}} Q}^{-1}\right\| \leq c 2^{(j+a) \tilde{d} / p} \tag{4.7}
\end{equation*}
$$

In $S_{2}$, using (2.5) and (4.7), we have

$$
\begin{aligned}
S_{2}^{r}= & \sum_{j>-a} \sum_{Q \in \mathcal{D}_{j}} W(Q)^{r / t-r / p}\left(\int_{Q}\left|W^{1 / p}(x) E_{d, a} \vec{f}(x)\right|^{p} \mathrm{~d} x\right)^{r / p} \\
= & \sum_{j>-a} \sum_{Q \in \mathcal{D}_{j}} W(Q)^{r / t-r / p} \\
& \times\left(\frac{|Q|}{|Q|} \int_{Q}\left|W^{1 / p}(x) \frac{1}{\left|(j+a)_{\mathrm{pa}} Q\right|} \int_{(j+a)_{\mathrm{pa}} Q} \vec{f}(y) \mathrm{d} y\right|^{p} \mathrm{~d} x\right)^{r / p} \\
\approx & \sum_{j>-a} \sum_{Q \in \mathcal{D}_{j}} W(Q)^{r / t-r / p}|Q|^{r / p}\left(\left|A_{Q} \frac{1}{\left|(j+a)_{\mathrm{pa}} Q\right|} \int_{(j+a)_{\mathrm{pa}} Q} \vec{f}(y) \mathrm{d} y\right|\right)^{r} \\
\lesssim & \sum_{j>-a} \sum_{Q \in \mathcal{D}_{j}} W(Q)^{r / t-r / p}|Q|^{r / p} \\
& \times\left(2^{\left.(j+a) \tilde{d} / p\left|A_{(j+a)_{\mathrm{pa}} Q} \frac{1}{\left|(j+a)_{\mathrm{pa}} Q\right|} \int_{(j+a)_{\mathrm{pa}} Q} \vec{f}(y) \mathrm{d} y\right|\right)^{r}}\right. \\
\approx & \sum_{j>-a} \sum_{Q \in \mathcal{D}_{j}} W(Q)^{r / t-r / p}|Q|^{r / p} 2^{(j+a) \tilde{d} r / p} \\
& \times\left(\frac{1}{\left|(j+a)_{\mathrm{pa}} Q\right|} \int_{(j+a)_{\mathrm{pa}} Q}^{\left.\left|W^{1 / p}(x) \frac{1}{\left|(j+a)_{\mathrm{pa}} Q\right|} \int_{(j+a)_{\mathrm{pa}} Q} \vec{f}(y) \mathrm{d} y\right|^{p} \mathrm{~d} x\right)^{r / p}}\right. \\
= & \sum_{j>-a} \sum_{Q \in \mathcal{D}_{j}} W(Q)^{r / t-r / p} 2^{-j n r / p} 2^{(j+a) \tilde{d} r / p} \\
& \times\left(\frac{1}{\left|(j+a)_{\mathrm{pa} Q} Q\right|} \int_{(j+a)_{\mathrm{pa}} Q}^{\left.\left|W^{1 / p}(x) E_{d, a} \vec{f}(x)\right|^{p} \mathrm{~d} x\right)^{r / p}}\right.
\end{aligned}
$$

$$
\begin{aligned}
= & \sum_{j>-a} \sum_{Q \in \mathcal{D}_{j}} W(Q)^{r / t-r / p} 2^{-j n r / p} 2^{(j+a) \tilde{d} r / p} 2^{-a n r / p} \\
& \times\left(\int_{(j+a)_{\mathrm{pa}} Q}\left|W^{1 / p}(x) E_{d, a} \vec{f}(x)\right|^{p} \mathrm{~d} x\right)^{r / p}
\end{aligned}
$$

Remark that given $S \in \mathcal{D}_{-a}$, there are $2^{(j+a) n}$ cubes $R$ such that $(j+a) R=S$. Hence, by Lemma 4.4 and $(\tilde{d}-n+\beta) r / p+n-\beta r / t<0$, we have

$$
\begin{aligned}
& \sum_{j>-a} \sum_{Q \in \mathcal{D}_{j}} W(Q)^{r / t-r / p} 2^{-j n r / p} 2^{(j+a) \tilde{d} r / p} 2^{-a n r / p} \\
& \times\left(\int_{(j+a)_{\mathrm{pa}} Q}\left|W^{1 / p}(x) E_{d, a} \vec{f}(x)\right|^{p} \mathrm{~d} x\right)^{r / p} \\
&= \sum_{j>-a} 2^{-j n r / p} 2^{(j+a) \tilde{d} r / p} 2^{-a n r / p} \\
& \times \sum_{Q \in \mathcal{D}_{j}} W(Q)^{r / t-r / p}\left(\int_{(j+a)_{\mathrm{pa}} Q}\left|W^{1 / p}(x) E_{d, a} \vec{f}(x)\right|^{p} \mathrm{~d} x\right)^{r / p} \\
& \leq \sum_{j>-a} 2^{-j n r / p} 2^{(j+a) \tilde{d} r / p} 2^{-a n r / p} 2^{(j+a) n} 2^{-(j+a) \beta(r / t-r / p)} \\
& \times \sum_{S \in \mathcal{D}_{-a}} W(S)^{r / t-r / p}\left(\int_{S}\left|W^{1 / p}(x) E_{d, a} \vec{f}(x)\right|^{p} \mathrm{~d} x\right)^{r / p} \\
& \lesssim\|\vec{f}\|_{M_{p}^{t, r}(W)}^{r},
\end{aligned}
$$

where in the second step we use the following fact. Since $W\left((j+a)_{\mathrm{pa}} Q\right) \leq$ $2^{(j+a) \beta} W(Q)$ and $1 / t-1 / p<0$, we have

$$
W(Q)^{1 / t-1 / p} \leq 2^{-(j+a) \beta(1 / t-1 / p)} W\left((j+a)_{\mathrm{pa}} Q\right)^{1 / t-1 / p}
$$

(ii) Fix $Q_{j, k} \in \mathcal{D}$. If $j \leq-a$, then by Lemma 4.4, we have

$$
\begin{aligned}
& W\left(Q_{j, k}\right)^{1 / t-1 / p}\left(\int_{Q_{j, k}}\left|W^{1 / p}(x) E_{d, a} \vec{f}(x)\right|^{p} \mathrm{~d} x\right)^{1 / p} \\
& \lesssim W\left(Q_{j, k}\right)^{1 / t-1 / p}\left(\int_{Q_{j, k}}\left|W^{1 / p}(x) \vec{f}(x)\right|^{p} \mathrm{~d} x\right)^{1 / p} .
\end{aligned}
$$

If $j>-a$, we denote by $(j+a)_{\mathrm{pa}} Q_{j, k} \in \mathcal{D}_{-a}$ the $(j+a)$-th dyadic parent of $Q_{j, k} \in \mathcal{D}_{j}$.

$$
\begin{aligned}
& W\left(Q_{j, k}\right)^{1 / t-1 / p}\left(\int_{Q_{j, k}}\left|W^{1 / p}(x) E_{d, a} \vec{f}(x)\right|^{p} \mathrm{~d} x\right)^{1 / p} \\
& =W\left(Q_{j, k}\right)^{1 / t-1 / p}\left(\frac{\left|Q_{j, k}\right|}{\left|Q_{j, k}\right|} \int_{Q_{j, k}}\left|W^{1 / p}(x) \frac{1}{\left|(j+a)_{\mathrm{pa}} Q_{j, k}\right|} \int_{(j+a)_{\mathrm{pa}} Q_{j, k}} \vec{f}(y) \mathrm{d} y\right|^{p} \mathrm{~d} x\right)^{1 / p} \\
& \approx W\left(Q_{j, k}\right)^{1 / t-1 / p}\left|Q_{j, k}\right|^{1 / p}\left|A_{Q_{j, k}} \frac{1}{\left|(j+a)_{\mathrm{pa}} Q_{j, k}\right|} \int_{(j+a)_{\mathrm{pa}} Q_{j, k}} \vec{f}(y) \mathrm{d} y\right| \\
& \lesssim W\left(Q_{j, k}\right)^{1 / t-1 / p}\left|Q_{j, k}\right|^{1 / p} 2^{(j+a) \tilde{d} / p}\left|A_{(j+a)_{\mathrm{pa}} Q_{j, k}} \frac{1}{\left|(j+a)_{\mathrm{pa}} Q_{j, k}\right|} \int_{(j+a)_{\mathrm{pa}} Q_{j, k}} \vec{f}(y) \mathrm{d} y\right| \\
& \approx W\left(Q_{j, k}\right)^{1 / t-1 / p} 2^{-j n / p} 2^{(j+a) \tilde{d} / p}\left(\frac{1}{\left|(j+a)_{\mathrm{pa}} Q_{j, k}\right|}\right. \\
& \left.\quad \times\left.\left.\int_{(j+a)_{\mathrm{pa}} Q_{j, k}}\right|^{1 / p}(x) \frac{1}{\left|(j+a)_{\mathrm{pa}} Q_{j, k}\right|} \int_{(j+a)_{\mathrm{pa}} Q_{j, k}} \vec{f}(y) \mathrm{d} y\right|^{p} \mathrm{~d} x\right)^{1 / p} .
\end{aligned}
$$

Then by Lemma 4.4 and $\tilde{d} / p-n / p-\beta(1 / t-1 / p) \leq 0$, we obtain

$$
\begin{aligned}
& W\left(Q_{j, k}\right)^{1 / t-1 / p}\left(\int_{Q_{j, k}}\left|W^{1 / p}(x) E_{d, a} \vec{f}(x)\right|^{p} \mathrm{~d} x\right)^{1 / p} \\
& \lesssim W\left(Q_{j, k}\right)^{1 / t-1 / p} 2^{-j n / p} 2^{(j+a) \tilde{d} / p} \\
& \times\left(\frac{1}{\left|(j+a)_{\mathrm{pa}} Q_{j, k}\right|} \int_{(j+a)_{\mathrm{pa}} Q_{j, k}}\left|W^{1 / p}(x) \vec{f}(x)\right|^{p} \mathrm{~d} x\right)^{1 / p} \\
&=W\left(Q_{j, k}\right)^{1 / t-1 / p} 2^{-j n / p} 2^{(j+a) \tilde{d} / p} 2^{-a n / p}\left(\int_{(j+a)_{\mathrm{pa}} Q_{j, k}}\left|W^{1 / p}(x) \vec{f}(x)\right|^{p} \mathrm{~d} x\right)^{1 / p} \\
& \lesssim 2^{(j+a)(\tilde{d} / p-n / p)} 2^{-(j+a) \beta(1 / t-1 / p)} W\left((j+a)_{\mathrm{pa}} Q_{j, k}\right)^{1 / t-1 / p} \\
& \quad \times\left(\int_{(j+a)_{\mathrm{pa}} Q_{j, k}}\left|W^{1 / p}(x) \vec{f}(x)\right|^{p} \mathrm{~d} x\right)^{1 / p} \\
& \lesssim W\left((j+a)_{\mathrm{pa}} Q_{j, k}\right)^{1 / t-1 / p}\left(\int_{(j+a)_{\mathrm{pa}} Q_{j, k}}\left|W^{1 / p}(x) \vec{f}(x)\right|^{p} \mathrm{~d} x\right)^{1 / p}
\end{aligned}
$$

where in the third step we use the following fact. Since $W\left((j+a)_{\mathrm{pa}} Q\right) \leq 2^{(j+a) \beta} W(Q)$
and $1 / t-1 / p \leq 0$, we have

$$
W(Q)^{1 / t-1 / p} \leq 2^{-(j+a) \beta(1 / t-1 / p)} W\left((j+a)_{\mathrm{pa}} Q\right)^{1 / t-1 / p}
$$

Finally, take the supremum over the cubes $Q_{j, k} \in D$, we obtain

$$
\left\|E_{d, a} \vec{f}\right\|_{M_{p}^{t, \infty}(W)} \lesssim\|\vec{f}\|_{M_{p}^{t, \infty}(W)} .
$$

Finally, we have the following Kolmogorov-Riesz compactness theorem for matrix weighted Bourgain-Morrey spaces.

Theorem 4.6. Let $1 \leq p<t<r<\infty$. Let $W \in \mathcal{A}_{p}$ has the $\mathcal{A}_{p}$-dimension $\tilde{d} \in[0, n)$ with the doubling exponent $\beta$. Let $(\tilde{d}-n+\beta) r / p+n-\beta r / t<0$. A subset $\mathcal{F}$ of $M_{p}^{t, r}(W)$ is totally bounded if and only if the following conditions hold:
(i) $\mathcal{F}$ is bounded, that is,

$$
\sup _{\vec{f} \in \mathcal{F}}\|\vec{f}\|_{M_{p}^{t, r}(W)}<\infty
$$

(ii) $\mathcal{F}$ uniformly vanishes at infinity, that is,

$$
\lim _{R \rightarrow \infty} \sup _{\vec{f} \in \mathcal{F}}\left\|\vec{f} \chi_{B^{c}(0, R)}\right\|_{M_{p}^{t, r}(W)}=0
$$

(iii) $\mathcal{F}$ is equicontinuous by means of the dyadic average operator, that is, for any

$$
\lim _{a \rightarrow-\infty, a \in \mathbb{Z}} \sup _{\vec{f} \in \mathcal{F}}\left\|\vec{f}-E_{d, a} \vec{f}\right\|_{M_{p}^{t, r}(W)}=0
$$

where $E_{d, a}$ is same as (4.2).
Proof. The sufficiency is due to Theorem 4.1. Now we prove the necessity. Assume that $\mathcal{F}$ of $M_{p}^{t, r}(W)$ is totally bounded. For any given $\varepsilon>0$, there exists $\left\{\vec{f}_{k}\right\}_{k=1}^{N_{0}} \subset \mathcal{F}$ such that $\left\{\vec{f}_{k}\right\}_{k=1}^{N_{0}}$ is an $\varepsilon$-net of $\mathcal{F}$, that is, for any $\vec{f} \in \mathcal{F}$, there exists $\vec{f}_{k}, k \in\left\{1,2, \ldots, N_{0}\right\}$ such that $\left\|\vec{f}-\vec{f}_{k}\right\|_{M_{p}^{t, r}(W)}<\varepsilon$.

Clearly, (i) is true.
For any $\varepsilon>0$ and $k \in\left\{1,2, \ldots, N_{0}\right\}$, since $r<\infty$, there exists $R_{k}>0$ such that

$$
\left\|\overrightarrow{f_{k}} \chi_{B^{c}\left(0, R_{k}\right)}\right\|_{M_{p}^{t, r}(W)}<\varepsilon
$$

Taking $R=\max _{k \in 1, \ldots, N_{0}}\left\{R_{k}\right\}$, we have $\left\|\vec{f}_{k} \chi_{B^{c}(0, R)}\right\|_{M_{p}^{t, r}(W)}<\varepsilon$. Then for any $\vec{f} \in \mathcal{F}$,

$$
\left\|\vec{f} \chi_{B^{c}(0, R)}\right\|_{M_{p}^{t, r}(W)} \leq\left\|\left(\vec{f}-\vec{f}_{k}\right) \chi_{B^{c}(0, R)}\right\|_{M_{p}^{t, r}(W)}+\left\|\overrightarrow{f_{k}} \chi_{B^{c}(0, R)}\right\|_{M_{p}^{t, r}(W)}<2 \varepsilon
$$

Thus we prove that

$$
\lim _{R \rightarrow \infty} \sup _{\vec{f} \in \mathcal{F}}\left\|\vec{f} \chi_{B^{c}(0, R)}\right\|_{M_{p}^{t, r}(W)}=0
$$

Therefore, we prove that $\mathcal{F}$ satisfies condition (ii).
As for (iii), for each $1 \leq k \leq N_{0}$, by Theorem 4.5, we have for each $a \in \mathbb{Z}$,

$$
\left\|\overrightarrow{f_{k}}-E_{d, a} \vec{f}_{k}\right\|_{M_{p}^{t, r}(W)} \leq(1+c)\left\|\overrightarrow{f_{k}}\right\|_{M_{p}^{t, r}(W)}
$$

Thus using the dominated convergence theorem to obtain that there exists $a_{0} \in \mathbb{Z}$ such that for any $a \leq a_{0}$,

$$
\max _{1 \leq k \leq N_{0}}\left\|\vec{f}_{k}-E_{d, a} \overrightarrow{f_{k}}\right\|_{M_{p}^{t, r}(W)}<\varepsilon
$$

Now if $a \leq a_{0}$, then

$$
\begin{aligned}
& \left\|\vec{f}-E_{d, a} \vec{f}\right\|_{M_{p}^{t, r}(W)} \\
& \leq\left\|E_{d, a} \vec{f}-E_{d, a} \vec{f}_{k}\right\|_{M_{p}^{t, r}(W)}+\left\|E_{d, a} \overrightarrow{f_{k}}-\vec{f}_{k}\right\|_{M_{p}^{t, r}(W)}+\left\|\overrightarrow{f_{k}}-\vec{f}\right\|_{M_{p}^{t, r}(W)} \\
& \leq c\left\|\vec{f}-\overrightarrow{f_{k}}\right\|_{M_{p}^{t, r}(W)}+\varepsilon+\varepsilon \\
& \lesssim \varepsilon
\end{aligned}
$$

Remark 4.7. Theorem 4.6 is not true for $1<p<t<r=\infty$. Indeed, let $d=1, W \equiv 1,0<p<t<r=\infty$. Let $f(x)=|x|^{-n / t}$. Then

$$
\|f\|_{M_{p}^{t, \infty}}=\sup _{Q \in \mathcal{D}}|Q|^{1 / t-1 / p}\left(\int_{Q}|y|^{-n p / t} \mathrm{~d} y\right)^{1 / p} \approx 1
$$

Let $f_{j}=\chi_{B\left(0,2^{j}\right)} f$ for $j \in \mathbb{N}$. Note that $f$ and $f_{j}$ are radial and symmetric functions. Let $x=\left(x_{1}, 0, \ldots, 0\right)$ where $x_{1}=2^{j}+2 \times 2^{j}$. Let $s=x_{1} / 10$. Then $B(x, s) \subset B\left(0,2^{j}\right)^{c}$. Then

$$
\begin{aligned}
& \left\|f-f_{j}\right\|_{M_{p}^{t, \infty}} \\
& \geq c s^{-n(1 / t-1 / p)}\left(\int_{B(x, s)}|y|^{-n p / t} \mathrm{~d} y\right)^{1 / p} \\
& \geq c s^{-n(1 / t-1 / p)}\left(\int_{|x|-|s|}^{|x|+|s|} \eta^{-n p / t} \eta^{n-1} \mathrm{~d} \eta\right)^{1 / p} \\
& =c\left(\frac{|x|}{10}\right)^{-n(1 / t-1 / p)}\left(\left(1+\frac{1}{10}\right)^{n-n p / t}-\left(1-\frac{1}{10}\right)^{n-n p / t}\right)^{1 / p}|x|^{n(1 / t-1 / p)} \\
& =c>0
\end{aligned}
$$

This shows that the totally bounded set $\mathcal{F}=\{f\}$ of $M_{p}^{t, \infty}$ is not uniformly vanishes at infinity.
