# Algebraic depletion interactions in two-temperature mixtures

#### Abstract

The phase separation that occurs in two-temperature mixtures, which are driven out of equilibrium at the local scale, has been thoroughly characterized, but much less is known about the depletion interactions that drive it Using numerical simulations in dimension 2, we show that the depletion interactions extend beyond two particle diameters in dilute systems, as expected at equilibrium, and decay algebraically with an exponent -4 . Solving for the $N$-particle distribution function in the stationary state, perturbatively in the interaction potential, we show that the algebraic correlations arise from triplets of particles at different temperatures, and recover the exponent -4 .


At equilibrium, coupling two objects to a critical field induces an algebraic effective interaction between these objects. The field may be the electromagnetic field, as in the Casimir effect [1, 2], or the density fluctuations in a binary mixture close to its critical point [3-5]. In the latter case, inducing such interactions requires the fine tuning of the temperature [5]. Out of equilibrium, algebraic correlations and the effective interactions that they induce are much more frequent and usually do not require fine tuning. They arise for instance in driven systems, such as an electrolyte or a binary colloidal mixture under an electric field [6-10]. Transient algebraic interactions can also arise during the relaxation following a temperature quench [11, 12]. Finally, active systems can induce interactions [13], which may decay algebraically for asymmetric bodies [14, 15]. Here, we show that algebraic interactions spontaneously appear in mixtures of particles connected to different thermostats, an out of equilibrium system known to exhibit phase separation [16-18]. This algebraic depletion interaction thus does not require self-propulsion and act between spherical bodies.

Two temperature mixtures are now a paradigmatic model to study non-equilibrium phenomena. They are driven out of equilibrium locally, such as active systems, but do not involve self-propulsion; they are thus simpler that the active-passive mixture that they may represent [19, 20]. Two temperature mixtures can also be mapped to systems with non-reciprocal interactions [21, 22], which have gained attention recently [23]. The hot and cold particles may phase separate even when the interactions between the particles are purely repulsive and identical, provided that the temperature ratio is large enough [17, 18, 24], resulting in dense droplets of cold particles coexisting with a dilute gas of hot particles. Grosberg and Joanny provided an analytical prediction for the instability threshold in a dilute system [17], showing that denser systems are easier to phase separate. Recently, McCarthy et al found that the two species may mix again at high density [25].

[^0]To understand the phase separation mechanism, it is instructive to consider the depletion interaction between the cold particles that is induced by the hot particles, which is encoded in the pair correlation of the cold particles [18]. In the approach of Grosberg and Joanny, the free energy of the system can be minimized with respect to the density of the hot particles to get an effective free energy functional for the cold particles only [17]. However, this free energy contains only a coarse-grained description of the interaction between the particles, namely the integral of the Mayer function, and does not provide the shape of the effective interaction. An explicit expression of the effective interaction has been obtained in Ref. [24] using the potential of mean force; however, the application of this approach to an out-of-equilibrium system is questionable. Indeed, we will see that generalizing different equilibrium methods to compute the effective interactions in this out-of-equilibrium system lead to different results, similarly to the situation observed with the pressure in a gas of active particles [26].

In this Letter, we compute the depletion interaction between cold particles that is due to the hot particles analytically, in the dilute limit and perturbatively in the interaction strength $\epsilon$. Restricting ourselves to the dilute limit amounts to consider a system of two cold particles and a single hot one. Contrary to two-body problems [17, 21], this three-body system cannot be mapped onto an effective equilibrium system [27]. At order $\epsilon^{2}$, we show that the potential of mean force argument should be corrected by a purely non-equilibrium three-body potential. At order $\epsilon^{3}$, we find that the three-body potential gives rise to algebraic interactions decaying as $r^{-4}$ in spatial dimension $d=2$. Our results are supported by numerical simulations.

We consider harmonic spheres with positions $\boldsymbol{x}_{i}(t)$, connected to thermostats with temperature $T_{i}$ and obeying an overdamped Langevin dynamics:

where $V(r)=\epsilon(1-r)^{2} \theta(1-r), \theta$ being the Heaviside function. The vectorial Gaussian white noises $\boldsymbol{\eta}_{i}$ have a
unit variance and are uncorrelated. The particles diameter and mobility and the Boltzmann constant have been set to unity. We consider only two species $\alpha \in\{A, B\}$ connected to thermostats $T_{\alpha}$. To focus on the interactions induced by the particles $B$ on the particles $A$, we assume that there are only two $A$ particles $i \in\{1,2\}$ and a small density $\rho$ of $B$ particles. We expand the pair distribution function of the two $A$ particles $g(r)$ as $g(r)=\exp \left(-V(r) / T_{A}\right)\left[1+\sum_{n=1}^{\infty} \rho^{n} g_{n}(r)\right][28]$. We focus on the first term of the expansion, $g_{1}(r)$; for simplicity, we denote it $\hat{g}(r)$ and refer to it as the "correlation":

At equilibrium, here when $T_{A}=T_{B}=T$, the interaction induced by the $B$ particles can be obtained by integrating the three body distribution $f\left(\boldsymbol{x}_{1}, \boldsymbol{x}_{2}, \boldsymbol{x}_{3}\right)$ over the coordinate of the third particle, leading to (App. B 1 a)

where the star denotes the convolution product. In the weak interaction limit $\epsilon \ll T$ it reduces to

\end{equation*}

Both the full expression (3) and its weak interaction limit (4) are zero beyond two particle diameters, here corresponding to $r=2$. The same expressions can be recovered using the potential of mean force [28] (App. B 1 b).

These arguments can be transposed out of equilibrium, using the fact that an isolated pair of particles $(i, j)$ is in an effective equilibrium at temperature $T_{i j}=\left(T_{i}+T_{j}\right) / 2$ so that its pair correlation is $g_{i j}(r)=\exp \left(-v_{i j}(r)\right)$, where $v_{i j}(r)=V(r) / T_{i j}[17]$. Using the potential of mean force, Ilker and Joanny obtained [24] (App. B 2 b)

& =\frac{T_{B}}{T_{A} T_{A B}^{2}} V * V(r)+\mathcal{O}\left(\epsilon^{3}\right) \tag{6}
\end{align*}

Alternatively, assuming that the $N$-particle distribution function is given by $f(\boldsymbol{X})=\exp \left(-\sum_{\langle i j\rangle} v_{i j}\left(\boldsymbol{x}_{i}-\boldsymbol{x}_{j}\right)\right)$, where $\boldsymbol{X}=\left(\boldsymbol{x}_{i}\right)_{1 \leq i \leq N}$, we find (App. B 2 a)

\hat{g}(r) & =\left(e^{-V / T_{A B}}-1\right) *\left(e^{-V / T_{A B}}-1\right)(r)  \tag{7}\\
& =\frac{V * V(r)}{T_{A B}^{2}}+\mathcal{O}\left(\epsilon^{3}\right) \tag{8}
\end{align*}

The temperatures enter differently into the predictions (5) and (7), pointing to the fact that these approaches may not apply out of equilibrium. However, they agree on the form of the depletion interaction, which is the same as the equilibrium one; in particular its range is limited to two particle diameters.

We simulated Eq. (1) numerically [29] (App. A). In order to improve the statistics, we used the same small density $\rho$ of $A$ and $B$ particles. In this situation, an additional depletion interaction is induced by the particles $A$ themselves, so that $\hat{g}(r)=\hat{g}^{A}(r)+\hat{g}^{B}(r)$, where $\hat{g}^{A}(r)=\hat{g}_{\text {eq }}(r)$ (Eq. (3)). The correlations $\hat{g}(r)$ calculated from simulations with $\epsilon=10, \rho=0.05, T_{A}=1$ and different values of $T_{B}$ are presented in Fig. 1(a). As expected, we observe an increase of the correlation at contact $\hat{g}(1)$ due to the depletion interaction. This increase scales as $\epsilon^{2}$ with the interaction strength $\epsilon$, as expected from the different theoretical predictions (Fig. 1(b)). However, in contradiction with the predictions, the depletion interaction extends beyond two diameters as soon as the system departs from equilibrium $\left(T_{A}=T_{B}\right)$. Beyond two particle diameters, the radial dependence of the depletion interaction is compatible with an algebraic decay, $\hat{g}(r) \sim G / r^{4}$. The prefactor $G$ of the algebraic decay increases with the interaction strength as $\epsilon^{3}$ for small $\epsilon$ and saturates for large values of $\epsilon$, corresponding to the hard sphere limit (Fig. 1(b)). The effect of the temperature $T_{B}$ is non-monotonic: $G$ first increases and then decreases at large temperatures (Fig. 1(c)). The temperature where the effect is maximal increases with the interaction strength $\epsilon$. We now return to theory to (i) elucidate the discrepancy between the two arguments adapted out of equilibrium and (ii) find the origin and the characteristics of the algebraic decay.

We use two theoretical approaches. First, we use Stochastic Density Field Theory [30] to turn the microscopic dynamics (1) into exact Langevin equations for the density fields $\hat{\rho}_{\alpha}(\boldsymbol{x}, t)=\sum_{i \in I_{\alpha}} \delta\left(\boldsymbol{x}-\boldsymbol{x}_{i}(t)\right)$, where $\alpha \in\{A, B\}$ indicate the species and $I_{\alpha}$ is the set of indices of the particles of species $\alpha$. SDFT applies in equilibrium as well as in out-of-equilibrium situations [10, 31, 32]. The exact dynamics of the density fields is non-linear due to pair interactions, and contains multiplicative noise, which makes it intractable in practical situations. In the limit of a dense system with weak interactions, SDFT can be linearized and the density fluctuations around the average densities $\rho_{\alpha}$ become Gaussian [33, 34]; this approximation corresponds to the random phase approximation in liquid theory [28]. The correlation, which corresponds to the correlations of the fluctuations of the density fields, can be calculated in Fourier space (App. C). In the dilute limit that we consider here $\left(\rho_{A}=0, \rho_{B} \rightarrow 0\right)$, it reduces to

This expression is in quantitative agreement with the numerical simulations for $r \lesssim 2$ (Fig. 2 and 1 (b)). It takes a similar form as the results obtained by adapting equilibrium arguments (Eqs. $(6,8)$ ), but the temperatures enter differently in the prefactor. As the expression (9) is exact at the order $\epsilon^{2}$, we conclude that none of the two equilibrium calculations can be adapted out of equilibrium.

Yet, the expression (9) vanishes at two particle diam-

eters and cannot explain the algebraic decay observed in the simulations (Fig. 1(a)). This is not surprising as it is correct at order $\epsilon^{2}$ while the simulations indicate an $\epsilon^{3}$ dependence of the algebraic decay. We now turn to a small density expansion that is valid for any interaction strength. The $N$-particle distribution $f(\boldsymbol{X})$ is stationnary under the Smoluchowski equation describing the microscopic dynamics (1). To isolate the many-body effects from the pair correlation obtained by Grosberg
and Joanny [17], we write it as

where now $v_{i j}=V\left(\boldsymbol{x}_{i}-\boldsymbol{x}_{j}\right) / T_{i j}$. The resulting equation for the many-body potential $\phi(\boldsymbol{X})$ is (App. D 1)

& +\sum_{\langle i j\rangle} \nabla v_{i j} \cdot\left[\left(T_{i j}+\tau_{i j}\right) \nabla_{i} \phi-\left(T_{i j}-\tau_{i j}\right) \nabla_{j} \phi\right] \\
& +\sum_{\langle i j k\rangle}\left(\tau_{i j k} \nabla v_{i j} \cdot \nabla v_{i k}+\text { perm. }\right), \tag{11}
\end{align*}

where we have defined the temperature differences $\tau_{i j}=$ $T_{i}-T_{j}$ and $\tau_{i j k}=T_{i}-T_{j k}$ and "perm" indicates the two terms in the last sum obtained from the first by cyclic permutations. The third term is the source term: it is a sum over triplets, underlining the fact that $\phi$ originate from three-body effects. Moreover, it involves temperature differences so that it is zero at equilibrium. While this is expected, it stresses the fact that the $N$-particle distribution can be written as a product of pair terms only at equilibrium, and that three-body effects arise as soon as the system is put out of equilibrium, as evidenced for particles attached by linear springs [27]. The equation (11) for $\phi$ is a nonlinear PDE with multiplicative terms, and we solve it perturbatively in the interaction strength $\epsilon$ : we write $\phi=\sum_{k=2}^{\infty} \phi^{(k)}$, with $\phi^{(k)} \propto \epsilon^{k}$.

The depletion interaction encoded in $\hat{g}(r)$ can be computed from the three-body distribution $f_{3}\left(\boldsymbol{x}_{1}, \boldsymbol{x}_{2}, \boldsymbol{x}_{3}\right)$. Expanding $f_{3}$ in powers of $\epsilon$ and integrating over $\boldsymbol{x}_{3}$,
we find (App. D 3 a)

\hat{g}= & \int \mathrm{d} \boldsymbol{x}_{3}\left[v_{13} v_{23}-\phi^{(2)}\right. \\
& \left.-\frac{1}{2}\left(v_{13}^{2} v_{23}+v_{13} v_{23}^{2}\right)+\left(v_{13}+v_{23}\right) \phi^{(2)}-\phi^{(3)}\right] \\
& +\mathcal{O}\left(\epsilon^{4}\right) \tag{12}
\end{align*}
$$

The first two terms in the integrand are of order $\epsilon^{2}$, while the last three are of order $\epsilon^{3}$.

At order $\epsilon^{2}$, the Laplacian in the first term balances the source term, and the solution is given by $\phi^{(2)}(\boldsymbol{X})=$ $\sum_{\langle i j k\rangle} \tau_{i j k} \omega_{i j k}^{(2)}\left(\boldsymbol{x}_{j}-\boldsymbol{x}_{i}, \boldsymbol{x}_{k}-\boldsymbol{x}_{i}\right)+$ perm., where $\omega_{i j k}^{(2)}$ is given in Fourier space by (App. D 2 a)

$$
\begin{equation*}
\tilde{\omega}_{i j k}^{(2)}\left(\boldsymbol{k}, \boldsymbol{k}^{\prime}\right)=\frac{\boldsymbol{k} \cdot \boldsymbol{k}^{\prime} \tilde{v}_{i j}(\boldsymbol{k}) \tilde{v}_{i k}\left(\boldsymbol{k}^{\prime}\right)}{2\left(T_{i j} k^{2}+T_{i k} k^{\prime 2}+T_{i} \boldsymbol{k} \cdot \boldsymbol{k}^{\prime}\right)} . \tag{13}
\end{equation*}

Using $\phi^{(2)}$ to compute $\hat{g}(r)$ at order $\epsilon^{2}$, the expression (9) obtained from SDFT is recovered (App. D 3 b ). This result shows that the three-body effects are important to get the correct depletion interaction at order $\epsilon^{2}$, and that these effects are included in the SDFT calculation.

To compute $\phi^{(3)}$, we plug $\phi^{(2)}$ into the second term of Eq. (11), and balance it with the Laplacian in the first term (App. D 2 b). Using $\phi^{(2)}$ and $\phi^{(3)}$ in the correction (12) leads the depletion interaction at order $\epsilon^{3}$ (App. D 3 c). The resulting expression contains many terms involving double integrals in Fourier space, which can be performed numerically, yielding a good agreement with the $\hat{g}(r)$ obtained from simulations (Fig. 2). In particular, the algebraic decay is recovered. The small wavevector behavior in Fourier space points to an algebraic decay with exponent $-2 d$ in spatial dimension $d$ (App. D4a). The prefactor can be obtained numerically and is in quantitative agreement with the simulations for weak interactions (Fig. 1(b)). The nonmonotonic dependence of the prefactor on $T_{B}$ is also recovered; more precisely, the theory predicts an increase as $\left(T_{B}-T_{A}\right)$ followed by a decrease as $T_{B}^{-2}$, which are compatible with the results from the simulations (Fig. 1(c)). In contrast, the order $\epsilon^{2}$ decays monotonously with $T_{B}$ (Eq. (9)).

We have shown that a species $B$ at temperature $T_{B}$ induces a depletion interaction decaying as $r^{-4}$ between particles of a species $A$ at temperature $T_{A} \neq T_{B}$ in the dilute limit. We have found that the correction originates from a three-body contribution $\phi$ (Eq. (11)) to the $N$ particle distribution that arises from triplets of particles that are not at the same temperature. Our calculation of $\phi$ is pertubative, but the algebraic decay is observed
from weak to strong interactions in our simulations. This suggests that pushing the perturbative computation to higher orders would modify the numerical prefactor of the algebraic decay, but not the exponent.

The depletion interaction that we have unveiled is the driving force behind the formation of dense droplets of cold particles when they separate from the hot particles. As the algebraic tail of the interaction originates from temperature differences ( $\tau_{i j k}$ in Eq. (11)) , this effect is reversed if one considers the depletion interaction induced by the cold particles on the hot ones, so that the algebraic tail is repulsive in this case. This repulsion between hot particles may work with the attraction between cold particles to trigger the phase separation.

## Appendix A: Details of the numerical simulations

The simulations were performed with the LAMMPS package [29]. The systems consist in $N=20000$ particles with $N / 2$ thermalized at $T_{A}$ and $N / 2$ thermalized at $T_{B}$. We follow the Brownian Dynamics time integration to update the positions. This integration scheme solves a system of $N$ overdamped Langevin equations,

where all friction coefficients $\gamma_{i}$ are set to unity. The $\mathrm{d} W_{i, t}$ represent Wiener processes mimicked by discrete sequences of Gaussian random numbers with zero mean and unit variance.

The timestep was adjusted to ensure the stability and reproducibility of the simulations. The interaction between all particles were described with the pair style command and a purely repulsive harmonic-cut potential, $E=\epsilon\left(r_{c}-r\right)^{2}$ for $r<r_{c}$ and 0 everywhere else. The particle size was set equal to $r_{c}=1$ and various potential strengths were used and are indicated in the manuscript. This repulsive potential ensures a optimal stability of the simulations. Finally, to improve the accuracy of the data, the $g(r)$ were averaged on a large number of simulations (1000 to 10000 ). This was mandatory to have reliable results for the algebraic decay of the correlations.

## Appendix B: Equilibrium calculation and attempts to generalize out-of-equilbrium

## 1. Equilibrium

## a. Integration of the equilibrium distribution

The equilibrium distribution of three particles interacting via the potential $V(r)=T v(r)$ is given by

where we denote $v_{i j}=v\left(\boldsymbol{x}_{i}-\boldsymbol{x}_{j}\right)$. Integrating over $\boldsymbol{x}_{3}$, we obtain the pair correlation up to a constant

g\left(\boldsymbol{x}_{1}-\boldsymbol{x}_{2}\right) \propto \int f\left(\boldsymbol{x}_{1}, \boldsymbol{x}_{2}, \boldsymbol{x}_{3}\right) \mathrm{d} \boldsymbol{x}_{3} \propto \exp \left(-v_{12}\right) \int \exp \left(-v_{13}-v_{23}\right) \mathrm{d} \boldsymbol{x}_{3} \tag{B2}
\end{equation*}

The normalisation factor $Z^{-1}$ should be set such that $g(r) \rightarrow 1$ as $r \rightarrow \infty$. When the particles 1 and 2 are far appart,

\exp \left(-v_{13}-v_{23}\right)=\exp \left(-v_{13}\right)+\exp \left(-v_{23}\right)-1 \tag{B3}

hence the normalisation factor is

Z=\int\left[1+\exp \left(-v_{13}\right)-1+\exp \left(-v_{23}\right)-1\right] \mathrm{d} \boldsymbol{x}_{3} \tag{B4}
\end{equation*}

Dividing the numerator and denominator by the volume $\mathcal{V}$ of the system and using brackets $\langle\cdot\rangle$ for the volume average over $\boldsymbol{x}_{3}$, we find, in the large volume limit

\mathrm{e}^{v_{12}} g\left(\boldsymbol{x}_{1}-\boldsymbol{x}_{2}\right) & =\frac{1+\mathcal{V}^{-1} \int\left(\mathrm{e}^{-v_{13}-v_{23}}-1\right) \mathrm{d} \boldsymbol{x}_{3}}{1+\mathcal{V}^{-1} \int\left(\mathrm{e}^{-v_{13}}-1\right) \mathrm{d} \boldsymbol{x}_{3}+\mathcal{V}^{-1} \int\left(\mathrm{e}^{-v_{23}}-1\right) \mathrm{d} \boldsymbol{x}_{3}}  \tag{B5}\\
& =1+\mathcal{V}^{-1} \int\left(\mathrm{e}^{-v_{13}-v_{23}}-\mathrm{e}^{-v_{13}}-\mathrm{e}^{-v_{23}}+1\right) \mathrm{d} \boldsymbol{x}_{3}  \tag{B6}\\
& =1+\mathcal{V}^{-1} \int\left(\mathrm{e}^{-v_{13}}-1\right)\left(\mathrm{e}^{-v_{23}}-1\right) \mathrm{d} \boldsymbol{x}_{3}  \tag{B7}\\
& =1+\mathcal{V}^{-1}\left[\left(\mathrm{e}^{-v}-1\right) *\left(\mathrm{e}^{-v}-1\right)\right]\left(\boldsymbol{x}_{1}-\boldsymbol{x}_{2}\right) . \tag{B8}
\end{align*}
$$

If there are $N$ particles in the system, corresponding to a density $\rho=N / V$, summing the effect of the particles leads to the correction

\hat{g}(\boldsymbol{x})=\frac{\mathrm{e}^{v_{12}(\boldsymbol{x})} g(\boldsymbol{x})-1}{\rho}=\left[\left(\mathrm{e}^{-v}-1\right) *\left(\mathrm{e}^{-v}-1\right)\right](\boldsymbol{x}) \tag{B9}
\end{equation*}
$$

This equation is valid up to the first order in the density.

## b. Potential of mean force

Another way to derive the same result is to consider the partition function of the particle 3 given the position of the particles 1 and 2 :

Z_{3}\left(\boldsymbol{x}_{1}, \boldsymbol{x}_{2}\right)=\int \mathrm{e}^{-v_{13}-v_{23}} \mathrm{~d} \boldsymbol{x}_{3}=\mathcal{V}\left[1+\mathcal{V}^{-1} \int\left(\mathrm{e}^{-v_{13}-v_{23}}-1\right) \mathrm{d} \boldsymbol{x}_{3}\right] \tag{B10}
\end{equation*}
$$

The associated free energy is

\begin{equation*}
F_{3}\left(\boldsymbol{x}_{1}, \boldsymbol{x}_{2}\right)=-T \log \left(Z_{3}\left(\boldsymbol{x}_{1}, \boldsymbol{x}_{2}\right)\right) \simeq-T \mathcal{V}^{-1} \int\left(\mathrm{e}^{-v_{13}-v_{23}}-1\right) \mathrm{d} \boldsymbol{x}_{3} \tag{B11}
\end{equation*}
$$

where we have taken the large volume limit and discarded the constant term. Removing the constant part when $\left|x_{1}-x_{2}\right| \rightarrow \infty$, we get

\begin{equation*}
F_{3}\left(\boldsymbol{x}_{1}, \boldsymbol{x}_{2}\right)=-\frac{T}{\mathcal{V}}\left[\left(\mathrm{e}^{-v}-1\right) *\left(\mathrm{e}^{-v}-1\right)\right]\left(\boldsymbol{x}_{1}-\boldsymbol{x}_{2}\right) \tag{B12}
\end{equation*}
$$

which is the effective potential created by the third particle. Summing over the particles, we get the potential of mean force to the first order in the density,

F\left(\boldsymbol{x}_{1}-\boldsymbol{x}_{2}\right)=-\rho T\left[\left(\mathrm{e}^{-v}-1\right) *\left(\mathrm{e}^{-v}-1\right)\right]\left(\boldsymbol{x}_{1}-\boldsymbol{x}_{2}\right) \tag{B13}
\end{equation*}
$$

The pair correlation of the particles 1 and 2 is now given by

\hat{g}(\boldsymbol{x})=\rho^{-1}\left[\exp \left(-\frac{F(\boldsymbol{x})}{T}\right)-1\right] \simeq\left[\left(\mathrm{e}^{-v}-1\right) *\left(\mathrm{e}^{-v}-1\right)\right](\boldsymbol{x}) \tag{B14}
\end{equation*}
$$

where the last equality corresponds to the dilute limit where the correction is small. The previous result, Eq. (B9), is recovered.

## 2. Out of equilibrium tentative generalizations

In this section, we try to give the "natural" generalizations of the two arguments above to the situation where the particles 1 and 2 are connected to a thermostat with temperature $T_{A}$ while the other particles are connected to a different thermostat with temperature $T_{B}$.

## a. Integration of the many-body distribution

The pair correlation of two particles $i$ and $j$ is an effective equilibrium distribution at temperature $T_{i j}=\left(T_{i}+\right.$ $\left.T_{j}\right) / 2$ [17]. It seems natural to assume that the three-body distribution is given by

Using this distribution in the derivation presented in Sec. B 1 a leads to

\hat{g}(\boldsymbol{x})=\left[\left(\mathrm{e}^{-V / T_{A B}}-1\right) *\left(\mathrm{e}^{-V / T_{A B}}-1\right)\right](\boldsymbol{x}) \tag{B16}

## b. Potential of mean force

Using again the two-body effective equilibrium, the partition function of the particle 3 given the position of the particles 1 and 2 is

Z_{3}\left(\boldsymbol{x}_{1}, \boldsymbol{x}_{2}\right)=\int \mathrm{e}^{-\left(V_{13}+V_{23}\right) / T_{A B}} \mathrm{~d} \boldsymbol{x}_{3} \tag{B17}
\end{equation*}
$$

Following the derivation of $\mathrm{Sec} . \mathrm{B} 1 \mathrm{~b}$ with this expression, we can consider that the potential of mean force generated by the particles connected to a thermostat with temperature $T_{B}$ is

F\left(\boldsymbol{x}_{1}-\boldsymbol{x}_{2}\right)=-\rho T_{B}\left[\left(\mathrm{e}^{-V / T_{A B}}-1\right) *\left(\mathrm{e}^{-V / T_{A B}}-1\right)\right]\left(\boldsymbol{x}_{1}-\boldsymbol{x}_{2}\right) \tag{B18}
\end{equation*}
$$

Finally, the correction is

\begin{equation*}
\hat{g}(\boldsymbol{x})=\frac{T_{B}}{T_{A}}\left[\left(\mathrm{e}^{-V / T_{A B}}-1\right) *\left(\mathrm{e}^{-V / T_{A B}}-1\right)\right](\boldsymbol{x}) . \tag{B19}
\end{equation*}
$$

This result is different from Eq. (B16).

## Appendix C: Linearized Stochastic Density Field Theory

## 1. From populations of particles to Gaussian fields

a. Dean equation for the density fields

The density fields are defined by $\hat{\rho}_{\alpha}(\boldsymbol{x}, t)=\sum_{x \in I_{\alpha}} \delta\left(\boldsymbol{x}-\boldsymbol{x}_{i}(t)\right)$, where $I_{\alpha}$ are the indices of the particles of the species $\alpha$. The density fields follow the Dean equation:

\end{equation*}
$$

where $\boldsymbol{\eta}_{\alpha}(\boldsymbol{x}, t)$ is a Gaussian white noise:

\end{equation*}

## b. Linearized Dean equation

To linearize the Dean equation around the average densities $\rho_{\alpha}$, we introduce the rescaled density fluctuations $\phi_{\alpha}(\boldsymbol{x}, t)=\left(\hat{\rho}_{\alpha}(\boldsymbol{x}, t)-\rho_{\alpha}\right) / \sqrt{\rho_{\alpha}}$ and $v_{\alpha \beta}(\boldsymbol{x})=\sqrt{\rho_{\alpha} \rho_{\beta}} V_{\alpha \beta}(\boldsymbol{x})$. Then we take the limit $\rho_{\alpha} \rightarrow \infty$ while keeping $v_{\alpha \beta}$ constant; the density fluctuations $\phi_{\alpha}(\boldsymbol{x}, t)$ follow

\dot{\phi}_{\alpha}=\nabla \cdot\left[T_{\alpha} \nabla \phi_{\alpha}+\sum_{\beta} \nabla v_{\alpha \beta} * \phi_{\beta}+\sqrt{2 T_{\alpha}} \boldsymbol{\eta}_{\alpha}\right] \tag{C3}
\end{equation*}
$$

## c. Mapping to a general Gaussian field model

We map the model above to a more general model with two Gaussian fields $\phi_{\alpha}(\boldsymbol{x}, t)$ with energy

H\left[\phi_{1}, \phi_{2}\right]=\frac{1}{2} \int\left[\phi_{1}(\boldsymbol{x}) A_{1} \phi_{1}(\boldsymbol{x})+\phi_{2}(\boldsymbol{x}) A_{2} \phi_{2}(\boldsymbol{x})+2 \phi_{1}(\boldsymbol{x}) B \phi_{2}(\boldsymbol{x})\right] \mathrm{d} \boldsymbol{x} \tag{C4}
\end{equation*}
$$

where $A_{\alpha}(\boldsymbol{x})$ and $B(\boldsymbol{x})$ are operators. In this section, it is more convenient to use 1 and 2 instead of $A$ and $B$ to denote the species. The overdamped dynamics deriving from this energy is

& \dot{\phi}_{2}(\boldsymbol{x}, t)=-R_{2}\left[A_{2} \phi_{2}(\boldsymbol{x}, t)+B \phi_{1}(\boldsymbol{x}, t)\right]+\xi_{2}(\boldsymbol{x}, t), \tag{C6}
\end{align*}
$$

where $R_{\alpha}(\boldsymbol{x})$ are the mobility tensors and the noises $\xi_{\alpha}(\boldsymbol{x}, t)$ have correlations

\left\langle\xi_{\alpha}(\boldsymbol{x}, t) \xi_{\beta}\left(\boldsymbol{x}^{\prime}, t^{\prime}\right)\right\rangle=2 \delta_{\alpha \beta} T_{\alpha} R_{\alpha}\left(\boldsymbol{x}-\boldsymbol{x}^{\prime}\right) \delta\left(t-t^{\prime}\right) \tag{C7}
\end{equation*}
$$

where $T_{\alpha}$ is the temperature of the field $\alpha$.
The linearized Dean equation (C3) corresponds to the following operators in Fourier space,

The pair correlation of the particles is related to the correlation of the fields $\phi_{\alpha}$ :

h_{\alpha \beta}(\boldsymbol{x})=g_{\alpha \beta}(\boldsymbol{x})-1=\left\langle\left(\frac{\hat{\rho}_{\alpha}(\boldsymbol{x})}{\rho_{\beta}}-1\right)\left(\frac{\hat{\rho}_{\beta}(0)}{\rho_{j}}-1\right)\right\rangle=\frac{C_{\alpha \beta}(\boldsymbol{x})}{\sqrt{\rho_{\alpha} \rho_{\beta}}} \tag{C11}
\end{equation*}
$$

where

$$
\begin{equation*}
C_{\alpha \beta}(\boldsymbol{x})=\left\langle\phi_{\alpha}(\boldsymbol{x}) \phi_{\beta}(0)\right\rangle \tag{C12}
\end{equation*}
$$

## 2. Calculation of the correlations

a. Equations

The computations are done in Fourier space, and we define

\end{array}\right)  \tag{C15}\\
\mathcal{A} & =\left(\begin{array}{cc}
A_{1} & B \\
B & A_{2}
\end{array}\right) . \tag{C16}
\end{align*}
$$

The correlation $C=\left\langle\Phi \Phi^{\mathrm{T}}\right\rangle$ satisfies in the stationnary state

R A C+C A(-\boldsymbol{k})^{\mathrm{T}} R(-\boldsymbol{k})^{\mathrm{T}}=2 T R \tag{C17}
\end{equation*}
$$

with $T=\left(\begin{array}{cc}T_{1} & 0 \\ 0 & T_{2}\end{array}\right)$.

## b. Solution

We expand Eq. (C17) and get

A_{2} C_{2}+\frac{B}{2}\left(C_{12}+C_{21}\right) & =T_{2} \tag{C21}
\end{align*}
$$

where we have defined

\Gamma=R_{1} A_{1}+R_{2} A_{2} \tag{C22}
\end{equation*}
$$

From Eqs. (C18, C21), we get

\end{equation*}
$$

hence

C_{2}=\frac{T_{2}-T_{1}}{A_{2}}+\frac{A_{1}}{A_{2}} C_{1} \tag{C24}
\end{equation*}
$$

From Eqs. (C19, C20), we have

\end{equation*}

where we have used Eq. (C24). Using this relation in Eq. (C18), we get

Using this relation in Eq. (C24), we get

## c. Equilibrium

If the system is at equilibrium, $T_{1}=T_{2}=T$, the correlations are

which is the expected result.

## 3. Application

## a. Pair potential in Fourier space

In our case, we use harmonic spheres, corresponding to $V(r)=\epsilon(1-r)^{2} \theta(1-r), \theta$ being the Heaviside function. The Fourier transform of the potential reads

\end{equation*}

where $J_{n}(z)$ is the Bessel function of the first kind and $H_{n}(z)$ is the Struve function.

## b. Low density

In the low density limit, we find

\end{equation*}
$$

where $T_{\alpha \beta}=\left(T_{\alpha}+T_{\beta}\right) / 2$.
Going back to real space, denoting the species $A$ and $B$ and setting $\rho_{A}=0, \rho_{B}=\rho$, this relation reads

h(r)=-\frac{V(r)}{T_{A}}+\frac{\rho}{T_{A} T_{A B}} V * V(r) \tag{C33}
\end{equation*}

The correlation $\hat{g}(r)$ that we focus on is

\hat{g}(r) & =\frac{e^{V(r) / T_{A}}[1+h(r)]-1}{\rho}  \tag{C34}\\
& =\frac{1}{\rho}\left(e^{V(r) / T_{A}}\left[1-\frac{V(r)}{T_{A}}+\frac{\rho}{T_{A} T_{A B}} V * V(r)\right]-1\right)  \tag{C35}\\
& =\frac{V * V(r)}{T_{A} T_{A B}} \tag{C36}
\end{align*}
$$

To obtain the last line, we have eliminated the terms of order $\epsilon^{2}$ that do not involve the density $\rho$. This is justified by the fact that the linearization of SDFT amounts to take $\epsilon \rightarrow 0$ while keeping $\rho \epsilon$ constant.

## Appendix D: Low density expansion

## 1. Smoluchowski equation and many-body potential

The $N$-particle distribution $f(\boldsymbol{X}, t)$, where $\boldsymbol{X}=\left(\boldsymbol{x}_{1}, \ldots \boldsymbol{x}_{N}\right)$, evolves according to the Smoluchowski equation $\partial_{t} f=\mathcal{L} f$, where $\mathcal{L}$ is the Liouville operator:

We write the distribution under the form

Using that $\nabla_{i} f=-f \nabla_{i} \psi$ and $\nabla_{i}^{2} f=f\left[\left(\nabla_{i} \psi\right)^{2}-\nabla_{i}^{2} \psi\right]$, we find

\frac{\mathcal{L} f(\boldsymbol{X})}{f(\boldsymbol{X})}=\sum_{i} T_{i}\left[\left(\nabla_{i} \psi\right)^{2}-\nabla_{i}^{2} \psi\right]+\sum_{\langle i j\rangle} T_{i j}\left[2 \nabla^{2} v_{i j}-\nabla v_{i j} \cdot\left(\nabla_{i} \psi-\nabla_{j} \psi\right)\right] \tag{D3}
\end{equation*}
$$

where $v_{i j}=V_{i j} / T_{i j}$.
We separate the two-particle contribution, which defines the many-body potential $\phi(\boldsymbol{X})$ :

Using that

\left(\nabla_{i} \psi\right)^{2} & =\sum_{j, k \neq i} \nabla v_{i j} \cdot \nabla v_{i k}+2 \sum_{j \neq i} \nabla v_{i j} \cdot \nabla_{i} \phi+\left(\nabla_{i} \phi\right)^{2}  \tag{D6}\\
\nabla_{i}^{2} \psi & =\sum_{j \neq i} \nabla^{2} v_{i j}+\nabla_{i}^{2} \phi \tag{D7}
\end{align*}
$$

the general expression (D3) becomes

& \frac{\mathcal{L} f(\boldsymbol{X})}{f(\boldsymbol{X})}=\sum_{i} T_{i}\left[\sum_{j, k \neq i} \nabla v_{i j} \cdot \nabla v_{i k}+2 \sum_{j \neq i} \nabla v_{i j} \cdot \nabla_{i} \phi+\left(\nabla_{i} \phi\right)^{2}-\sum_{j \neq i} \nabla^{2} v_{i j}-\nabla_{i}^{2} \phi\right] \\
&+\sum_{\langle i j\rangle} T_{i j}\left[2 \nabla^{2} v_{i j}-\nabla v_{i j} \cdot\left(\sum_{k \neq i} \nabla v_{i k}-\sum_{l \neq j} \nabla v_{j l}+\nabla_{i} \phi-\nabla_{j} \phi\right)\right] \tag{D8}
\end{align*}
$$

The terms in $\nabla^{2} v_{i j}$ cancel. Moreover, the terms in $\nabla v_{i j} \cdot \nabla v_{i k}$ and $\nabla v_{i j} \cdot \nabla v_{j l}$ cancel if $k=j$ and $l=i$ : only the terms involving three different particles remain:

&+\sum_{\langle i j\rangle} T_{i j}\left[-\nabla v_{i j} \cdot\left(\sum_{k \notin\langle i j\rangle} \nabla v_{i k}-\sum_{k \notin\langle i j\rangle} \nabla v_{j k}+\nabla_{i} \phi-\nabla_{j} \phi\right)\right] . \tag{D9}

This can be written as a sum over the particles, a sum over the pairs and a sum over the triplets:

The triplets terms can be rearranged:

We solve Eq. (D16) perturbatively in the pair interaction $v \propto \epsilon$ : we write $\phi=\sum_{k=2}^{\infty} \phi^{(k)}$, where $\phi^{(k)} \propto \epsilon^{k}$. The lowest order is $\phi^{(2)}$, which is the solution of

The next order is $\phi^{(3)}$, which is the solution of

If only $i$ or $j$ belongs to $\langle k l m\rangle$, the correction to the pair correlation will be of order $\rho^{2}$ and will not contribute to $g_{1}(r)$. At order $\rho$, we only have to consider three particles, so that there is only one triplet and three pairs. We write again

Fourier transforming, we arrive at

&\left(\left(\boldsymbol{k}-\boldsymbol{k}^{\prime \prime}\right) \cdot\left[T_{12}\left(2 \boldsymbol{k}^{\prime \prime}+\boldsymbol{k}^{\prime}\right)+\tau_{12} \boldsymbol{k}^{\prime}\right] \tilde{v}_{12}\left(\boldsymbol{k}-\boldsymbol{k}^{\prime \prime}\right) \tilde{\omega}_{123}^{(2)}\left(\boldsymbol{k}^{\prime \prime}, \boldsymbol{k}^{\prime}\right)\right. \\
&+\left(\boldsymbol{k}^{\prime}-\boldsymbol{k}^{\prime \prime}\right) \cdot\left[T_{13}\left(\boldsymbol{k}+2 \boldsymbol{k}^{\prime \prime}\right)+\tau_{13} \boldsymbol{k}\right] \tilde{v}_{13}\left(\boldsymbol{k}^{\prime}-\boldsymbol{k}^{\prime \prime}\right) \tilde{\omega}_{123}^{(2)}\left(\boldsymbol{k}, \boldsymbol{k}^{\prime \prime}\right) \\
&\left.+\boldsymbol{k}^{\prime \prime} \cdot\left[T_{23}\left(\boldsymbol{k}-\boldsymbol{k}^{\prime}-2 \boldsymbol{k}^{\prime \prime}\right)+\tau_{23}\left(\boldsymbol{k}+\boldsymbol{k}^{\prime}\right)\right] \tilde{v}_{23}\left(\boldsymbol{k}^{\prime \prime}\right) \tilde{\omega}_{123}^{(2)}\left(\boldsymbol{k}-\boldsymbol{k}^{\prime \prime}, \boldsymbol{k}^{\prime}+\boldsymbol{k}^{\prime \prime}\right)\right) . \tag{D30}

## 3. Correction to the 2-body pair correlation

## a. General expression

The pair correlation between particles 1 and 2 is given by

We can take out the direct interaction $v_{12}$ to get the cavity distribution function [28]. Moreover, assuming that all the particles for $i>2$ are identical and with a density $\rho$, at first order in the density it suffices to consider a 3 particles system and

& =\frac{\left\langle e^{-v_{13}-v_{23}-\phi}\right\rangle}{1+\left\langle e^{-v_{13}}-1\right\rangle+\left\langle e^{-v_{23}}-1\right\rangle}  \tag{D35}\\
& =\left\langle e^{-v_{13}-v_{23}-\phi}\right\rangle-\left\langle e^{-v_{13}}-1\right\rangle-\left\langle e^{-v_{23}}-1\right\rangle . \tag{D36}
\end{align*}

We see that the two negative terms cancel the terms where only one of the two particles appears in the first term. Finally, summing over the particles with a density $\rho$ leads to

a. First term. The first term contributes

Using the decomposition (D18), we have to determine the integral of the six terms $v_{13} w_{123}^{(2)}$, etc. over $\boldsymbol{x}_{3}$. They are (we omit the superscript "(2)" and use $\boldsymbol{x}=\boldsymbol{x}_{1}-\boldsymbol{x}_{2}$ )

## 4. Scaling relations and numerical integration

## a. Scaling relation

All the terms that involve the many-body potential $\phi$ at order $\epsilon^{3}$ consist of a double integral in Fourier space, three interaction potentials and a scale-invariant combi-
nation of the wavevectors (which scales as $k^{0}$ ). While the prefactor is difficult to obtain analytically, this form suggests an algebraic decay as $r^{-2 d}$, where $d$ is the spatial dimension, and a prefactor scaling as $\tilde{V}(0)^{3}$, where $\tilde{V}(0)=\int V(\boldsymbol{x}) \mathrm{d} \boldsymbol{x}$.

The last point can be made rigorous if the potential $V(r)$ is rescaled by a factor $\lambda$, which we denote $V_{\lambda}(r)=$

$\lambda^{d} V(\lambda r)$, such that $\tilde{V}_{\lambda}(k)=\tilde{V}(\lambda k)$. It can be proven
from the relations above that if the potential $V(r)$ leads to the correction $f(r)$, then the potential $V_{\lambda}(r)$ leads to the correction $f_{\lambda}(r)=\lambda^{-2 d} f(r / \lambda)$. As a consequence, if $f(r) \sim a r^{-2 d}$, then $f_{\lambda}(r) \sim \lambda^{-2 d} a(r / \lambda)^{-2 d}=a r^{-2 d}$ : the prefactor of the algebraic decay is the same for the initial potential and the rescaled potential.

## b. Numerical integration

The induced interaction at order $\epsilon^{2}$, Eq. (D55), involves an integral in real space, which can be evaluated numerically. The same applies to the first term at order $\epsilon^{3}$, Eq. (D56). The two other terms at order $\epsilon^{3}$ (D 3 cb and D 3 cc ) require a double numerical integration in Fourier space and a numerical integration in real space to invert the Fourier transform, which take much more time.

We compare the order $\epsilon^{3}$ of the induced interaction obtained from the harmonic potential and a Gaussian potential with the same integral in Fig. 3, showing that they share the same prefactor for the algebraic decay.

As the numerical integration is much faster with a Gaussian potential, we use a Gaussian potential to compute the prefactor as a function of the temperature $T_{B}$.
