# $\mathbb{Z}_{2}$ - homology of the orbit spaces $G_{n, 2} / T^{n}$

#### Abstract

We study the $\mathbb{Z}_{2}$-homology groups of the orbit space $X_{n}=G_{n, 2} / T^{n}$ for the canonical action of the compact torus $T^{n}$ on a complex Grassmann manifold $G_{n, 2}$. Our starting point is the $\operatorname{model}\left(U_{n}, p_{n}\right)$ for $X_{n}$ constructed in [2], where $U_{n}=\Delta_{n, 2} \times \mathcal{F}_{n}$ for a hypersimplex $\Delta_{n, 2}$ and an universal space of parameters $\mathcal{F}_{n}$ defined in [3], [2]. It is proved in [7] that $\mathcal{F}_{n}$ is diffeomorphic to the moduli space $\mathcal{M}_{0, n}$ of stable $n$-pointed genus zero curves. We exploit the results from [16], [8] on homology groups of $\mathcal{M}_{0, n}$ and express them in terms of the stratification of $\mathcal{F}_{n}$ which are incorporated in the model $\left(U_{n}, p_{n}\right)$.

In the result we provide the description of cycles in $X_{n}$, inductively on $n$. We obtain as well explicit formulas for $\mathbb{Z}_{2}$-homology groups for $X_{5}$ and $X_{6}$. The results for $X_{5}$ recover by different method the results from [7] and [19] . The results for $X_{6}$ we consider to be new. Keywords: Torus action, Grassmann manifold,spaces of parameters 1

## 1 Introduction

The study of the orbit space $X_{n}=G_{n, 2} / T^{n}$ of a complex Grassmann manifold $G_{n, 2}$, which represents the two-dimensional complex subspaces in $\mathbb{C}^{n}$ under the canonical action of the compact torus $T^{n}$, has garnered considerable mathematical interest from various perspectives including algebraic topology, algebraic geometry, group actions theory, matroid theory and combinatorics.

The investigation of orbit spaces $X_{n}$ together with the canonical moment map $\hat{\mu}: X_{n} \rightarrow$ $\Delta_{n, 2}$, where $\Delta_{n, 2}$ denotes a hypersimplex, has been motivated by the challenge of extending toric topology methods to torus actions of positive complexity, as discussed by Goresky-MacPherson [12], Gelfand-Serganova [11], Buchstaber-Terzić [3], Ayzenberg-Masuda [1].

In recent works, such as those by Süess [19] and Buchstaber-Terzić [6] , the integral homology groups of $X_{5}$ are described using advanced algebraic topology theories and geometric invariant theory, respectively.

We study the homology with $\mathbb{Z}_{2}$-coefficients of the orbit space $X_{n}$. Our starting point is the model $\left(U_{n}, p_{n}\right)$ for $G_{n, 2} / T^{n}$ constructed in [2], where $U_{n}=\Delta_{n, 2} \times \mathcal{F}_{n}$ for the smooth manifold $\mathcal{F}_{n}$, called the universal space of parameters, and $p_{n}: U_{n} \rightarrow X_{n}$ a continuous projection. The space $X_{n}$ is the quotient space of $U_{n}$ by the map $p_{n}$.

The basic input in the construction of this model is the result from [2], which states that $X_{n}$ can be represented as the disjoint union of spaces $\left\{C_{\omega} \times F_{\omega}\right\}$. Here, $\mathbb{C}_{\omega}$ are the chambers in the hypersimplex $\Delta_{n, 2}$ which correspond to its decomposition given by all possible intersections of matroids, that is admissible polytopes. The spaces $F_{\omega}$ are the orbit spaces of $\hat{\mu}^{-1}\left(C_{\omega}\right)$ by the canonical action of the algebraic torus $\left(\mathbb{C}^{*}\right)^{n}$, where $\hat{\mu}: G_{n, 2} / T^{n} \rightarrow \Delta_{n, 2}$ is the map induced by the standard moment map $\mu: G_{n, 2} \rightarrow \Delta_{n, 2}$. The corresponding cell decomposition of $X_{n}$ is given by the cell decomposition of each $F_{\omega}$. The characteristic maps are given by the characteristic maps for the cell decomposition of $\Delta_{n, 2}$ into $C_{\omega}$ 's, by the characteristic maps of the cell decomposition of $F_{\omega}$ 's and by the maps which define the closure of a strata in $G_{n, 2}$. Namely, in [11], it is shown that the closure of a stratum $W_{\sigma}$ is the union of strata $W_{\sigma^{\prime}}$ for some $\sigma^{\prime} \subset \sigma$. On the other hand, it follows from [6] that $\mu\left(W_{\sigma}\right)=\stackrel{\circ}{P}_{\sigma}$ which is the relative interior of polytope of $P_{\sigma} \subset \Delta_{n, 2}$, called an admissible polytope. In particular, if $P_{\bar{\sigma}}$ is a facet of admissible polytope $P_{\sigma}$, then the stratum $W_{\bar{\sigma}}$ such that $\mu\left(W_{\bar{\sigma}}\right)=\stackrel{\circ}{P} \bar{\sigma}$, belongs to the boundary of $W_{\sigma}$. In addition, it is proved in [3] that there exists continuous surjection $\eta_{\sigma, \bar{\sigma}}: F_{\sigma} \rightarrow F_{\bar{\sigma}}$. We prove that this map induce the continuous surjection $\eta_{\omega, \bar{\omega}}: F_{\omega} \rightarrow F_{\bar{\omega}}$.

The universal space of parameters $\mathcal{F}_{n}$ is defined in [3] for general $T^{k}$-action on a smooth manifold $M^{2 n}$ and studied in detail for $T^{n}$-action on $G_{n, 2}$ in [6], [2], [7]. In particular, it is proved in [7] that $\mathcal{F}_{n}$ is a smooth manifold diffeomorphic to the moduli space $\mathcal{M}_{0 n}$ of stable genus zero curves with $n$ marked ordered distinct points. Moreover, it is proved in [2] that for any $\omega$ there exists continuous surjection $p_{\omega}: \mathcal{F}_{n} \rightarrow F_{\omega}$. This map induces the relations from homology groups generators of $\mathcal{F}_{n}$ to those for homology groups of $F_{\omega}$. The homology groups generators for $\mathcal{F}_{n}$, as well as their relations, are determined by Keel in [16] and his results are further generalized in [18] and [8].

The complexity of the study of the orbit spaces $M^{2 n} / T^{k}$ and their homology structure shows up to follow the complexity of torus action. The homology of quasitoric manifolds $M^{2 n} / T^{n}$, which belong to the class of manifolds with complexity zero torus action, is determined by the combinatorics of the moment polytope $P^{k}$. It si proved in [4] that the orbit space $X_{4}$ is homeomorphic to $S^{5}$, Later on, more general result is proved in [15] stating that the orbit space of a Hamiltonian complexity one torus action in general position is homeomorphic to a sphere. This is improved in [1]
by showing that a manifold $M^{2 n}$ with complexity one torus action in general position and finite nonempty set of fixed points, is a homology $(n+1)$-sphere if its odd homology are trivial. In [1] this result is developed further by introducing the notion of $j$-generality of weights for $T^{k}$-action on $M^{2 n}$. Precisely, it is proved that if $X$ is equivariantly formal and the action is with isolated fixed points, then $j$-generality of weights implies $(j+1)$-acyclicity of the orbit space $M^{2 n} / T^{k}$.

The integral homology of orbit space $X_{5}$, which is an example of complexity 2 torus action, are computed in [7] and [19].

We recover the computation of homology groups with $\mathbb{Z}_{2}$ coefficients for $X_{5}$ by the method different from those used in [7] and [19]. In addition, we compute the homology groups with $\mathbb{Z}_{2}$ coefficients for $X_{6}$ which are, to our knowledge, not previously known. The space $X_{6}$ is an example of complexity 3 torus action.

We believe that the general results obtained in Section 4 describing inductively the structure of cycles in $X_{n}$, may lead to successful application of the presented method for the explicit computation of homology groups for $X_{n}$ with $\mathbb{Z}_{2}$-coefficients for higher $n$ as well.

The context of the paper is as follows: In Section 2, we provide a summary of the relevant combinatorial structure and algebraic topology of the orbit space $X_{n}$, following the descriptions from [6] and [2]. We particularly focus on the quotient space nature of $X_{n}$, obtained from a manifold with generalized corners $\Delta_{n, 2} \times \mathcal{F}_{n}$ via an explicitly described equivalence relation involving the chamber decomposition of $\Delta_{n, 2}$ and corresponding stratifications of the manifold $\mathcal{F}_{n}$.

In Section 4 , we study in detail the homology groups $H_{k}\left(X_{n} ; \mathbb{Z}_{2}\right)$ for arbitrary $k$, by making use of the model $\left(\Delta_{n, 2} \times \mathcal{F}_{n}, p_{n}\right)$ for $X_{n}$. The structural insight that $X_{n}$ decomposes into specific subspaces $\left\{C_{\omega} \times F_{\omega}\right\}$ facilitates an inductive study of $\mathbb{Z}_{2}$-cycles within $X_{n}$. Using diffeomorphism established in [7] between $\mathcal{F}_{n}$ and $\mathcal{M}_{0, n}$ and the results from [16], [8] on homology of $\mathcal{M}_{0, n}$, we deduce that the homology groups for $\mathcal{F}_{n}$ are spanned by the divisors outgrowing in the compactification of $F_{n}$ to $\mathcal{F}_{n}$. Moreover, for any $F_{\omega}$ being compactification of $F_{n}$, we show that the homology groups of $F_{\omega}$ are spanned as well by the divisors outgrowing in the compactification of $F_{n}$ to $F_{\omega}$. This is in the line with the results from [5] which relate $F_{\omega}$ with moduli spaces of weighted stables genus zero curves and the results from [8] on homology groups of such moduli spaces.

Section 3 builds upon the diffeomorphism between the universal space $\mathcal{F}_{n}$ and the moduli space $\mathcal{M}_{0, n}$ established in [7].

We exploit the knowledge of the homology groups of $\mathcal{M}_{0, n}$ generated by divisors $D_{I}$ as outlined in [16], and explicitly relate it for $n=5,6$ to the stratifications of $\mathcal{F}_{n}$ into virtual space of parameters which correspond to the chambers $C_{\omega}$ of $\Delta_{n, 2}$, which is established in [2].

We obtain the following results:

- $\mathbb{Z}_{2}$ - homology groups of $X_{5}$ are:

H_{k}\left(X_{5} ; \mathbb{Z}_{2}\right) \begin{cases}\mathbb{Z}_{2}, & \text { if } k=0,5,6,8 \\ 0, & \text { otherwise }\end{cases}
$$

- $\mathbb{Z}_{2^{-}}$homology groups of $X_{6}$ are:

$$
H_{k}\left(X_{6} ; \mathbb{Z}_{2}\right) \begin{cases}\mathbb{Z}_{2}, & \text { if } k=0,5,8,9,11 \\ \mathbb{Z}_{2}^{11}, & \text { if } k=7 \\ \mathbb{Z}_{2}^{3}, & \text { if } k=6 \\ 0, & \text { otherwise }\end{cases}
$$

## 2 Grassmann manifolds $G_{n, 2}$

For the convenience of a reader we recall the relevant description of the combinatorial structure and algebraic topology of the orbit space $G_{n, 2} / T^{n}$ from [6] and [2] without proofs, thus making our exposition self-contained.

We denote by $G_{n, 2}$ the complex Grassmann manifold of the two-dimensional complex subspaces in $\mathbb{C}^{n}$. The coordinate-wise action of the compact torus $T^{n}$ on $\mathbb{C}^{n}$ induces the canonical action of $T^{n}$ on $G_{n, 2}$. The standard Plücker charts on $G_{n, 2}$ are defined by $M_{I}=\left\{L \in G_{n, 2}: P^{I}(L) \neq\right.$ $0\}$, where $I \subset\{1, \ldots, n\},|I|=2$ and $P^{I}$ are the Plücker coordinates. Let $Y_{i j}=G_{n, 2} \backslash M_{i j}$, a stratum is defined by non-empty set

$$
W_{\sigma}=\left(\bigcap_{\{i, j\} \in \sigma} M_{i j}\right) \cap\left(\bigcap_{\{i, j\} \notin \sigma} Y_{i j}\right),
$$

where $\sigma \subset\binom{n}{2}$. For simplicity the elements of $\sigma$ we further denote just by $i j$ assuming that $i<j$. The stratum $W:=\bigcap_{\text {all }} M_{i j}$ is said to be the main stratum.

Let $\mu_{n}: G_{n, 2} \rightarrow \Delta_{n, 2}$ be the standard moment map, that is

$$
\mu_{n}(L)=\frac{1}{\sum\left|P^{I}(L)\right|} \sum\left|P^{I}(L)\right|^{2} \Lambda_{I},
$$

where $\Lambda_{I} \in \mathbb{R}^{n}, \Lambda_{i}=1$ for $i \in I$, while $\Lambda_{i}=0$ for $i \notin I$. The image of $G_{n, 2}$ by the moment map $\mu_{n}$ is the hypersimplex $\Delta_{n, 2}$, which is $(n-1)$-dimensional polytope that belongs to the hyperplane $x_{1}+\cdots+x_{n}=2$ and is defined as the convex hull of the points $\Lambda_{i j}, 1 \leq i<j \leq n$.

The action of $T^{n}$ on $G_{n, 2}$ is not effective, but the quotient torus $T^{n-1}=T^{n} / S^{1}$ by the diagonal circle $S^{1}$, acts effectively on $G_{n, 2}$. Note that the dimension of $\Delta_{n, 2}$ is equal to the dimension of the effectively acting torus. It follows that $\operatorname{dim} X_{n}=\operatorname{dim} G_{n, 2}-(n-1)=4(n-2)-(n-1)=$ $3 n-7$.

It holds that $\mu_{n}\left(W_{\sigma}\right)=\stackrel{\circ}{P}_{\sigma}$, where $P_{\sigma}$ is convex hull of the vertices $\Lambda_{i j}$ such that $i j \in \sigma$. A polytope $P_{\sigma}$ is called an admissible polytope for $G_{n, 2}$.

The strata $W_{\sigma}$ are invariant under the algebraic torus $\left(\mathbb{C}^{*}\right)^{n}$-action and $G_{n, 2}=\bigcup W_{\sigma}$. Therefore, they induce the stratification of the orbit space $X_{n}=G_{n, 2} / T^{n}$ by

$$
\begin{equation*}
X_{n}=\bigcup_{\sigma} W_{\sigma} / T^{n} \tag{1}
\end{equation*}
$$

The orbit space $F_{\sigma}=W_{\sigma} \backslash\left(\mathbb{C}^{*}\right)^{n}$ is called the spaces of parameters of a stratum $W_{\sigma}$.
Since the boundary $\partial \Delta_{n, 2}$ consists of $n$ copies of the hypersimplex $\Delta_{n-1,2}$ and $n$ copies of the simplex $\Delta_{n-1,1}$, see also [21], we have
$\mu^{-1}\left(\partial \Delta_{n, 2}\right)=\bigcup_{1 \leq i \leq n} \mu^{-1}\left(\Delta_{n-1,2}(i)\right) \cup \bigcup_{1 \leq i \leq n} \mu^{-1}\left(\Delta_{n-1,1}(i)\right)=\bigcup_{1 \leq i \leq n} G_{n-1,2}(i) \cup \bigcup_{1 \leq i \leq n} \mathbb{C} P^{n-2}(i)$,
where $\Delta_{n-1,2}(i)=\Delta_{n, 2} \cap\left\{x_{i}=0\right\}$ and $\Delta_{n-1,1}(i)=\Delta_{n, 2} \cap\left\{x_{i}=1\right\}$. Thus, the admissible polytopes for $G_{n, 2}$ can be described inductively. The results on admissible polytope from [2] can be summarized as follows:

Theorem 2.1. - Any admissible polytope for $G_{n, 2}$ of dimension less or equal than $n-3$ belongs to the boundary $\partial \Delta_{n, 2}$.

- The admissible polytopes $P_{\sigma}$ for $G_{n, 2}$ of dimension $n-2$ which have non-empty intersection with $\Delta_{n, 2}^{\circ}$ are given by the intersection of $\Delta_{n, 2}$ with the planes of the form:

$$
\sum_{i \in S,\|S\|=p} x_{i}=1
$$

where $S \subset\{1, \ldots, n\}, 2 \leq p \leq\left[\frac{n}{2}\right]$.

- The admissible polytopes $P_{\sigma}$ for $G_{n, 2}$ of the maximal dimension are $\Delta_{n, 2}$ and the intersections with $\Delta_{n, 2}$ of all collections of the half-spaces of the form

$$
\begin{equation*}
H_{S}: \sum_{i \in S} x_{i} \leq 1 \tag{2}
\end{equation*}
$$

for $S \subset\{1, \ldots, n\},\|S\|=k, k \in\{2, \ldots, n-2\}$ such that if $H_{S_{1}}, H_{S_{2}}$ belong to a collection then $S_{1} \cap S_{2}=\varnothing$.

The space of parameters of the main stratum $W$ is denoted by $F_{n}$ or $F$. If we want to emphasize a chart $M_{i j}$ in which the record of a space of parameters $F_{\sigma}$ or a stratum $W_{\sigma}$ is written, we denote it by $F_{\sigma, i j}$ or $W_{\sigma, i j}$.

### 2.1 The universal space of parameters and virtual spaces of parameters for $G_{n, 2}$

The main stratum $W$, in the chart $M_{12}$, is given by the equations

$$
\begin{equation*}
c_{i j}^{\prime} a_{i} b_{j}=c_{i j} a_{j} b_{i}, \quad 3 \leq i<j \leq n, \tag{3}
\end{equation*}
$$

where $c_{i j}, c_{i j}^{\prime} \neq 0, c_{i j} \neq c_{i j}^{\prime},\left(c_{i j}: c_{i j}^{\prime}\right) \in \mathbb{C} P^{1}$. It follows that the parameters $c_{i j}$ satisfy the equations

$$
\begin{equation*}
c_{i j}^{\prime} c_{i k} c_{j k}^{\prime}=c_{i j} c_{i k}^{\prime} c_{j k} . \tag{4}
\end{equation*}
$$

The space of parameters $F_{n}$ is an open algebraic manifold in $\left(\mathbb{C} P^{1}\right)^{N}$, for $N=\binom{n-2}{2}$, given by the intersection of cubics (4) and the condition $\left(c_{i j}^{\prime}: c_{i j}\right) \in \mathbb{C} P_{A}^{1}$, where $\mathbb{C} P_{A}^{1}=\mathbb{C} P^{1} \backslash A$ and $A=\{(1: 0),(0: 1),(1: 1)\}$. The dimension of $F_{n}$ is $2(n-3)$.
Remark 1. It follows from [5] that $F_{n}$ is homeomorphic to $\left(\mathbb{C} P_{A}^{1}\right)^{n-3}$. The cell decomposition of $\mathbb{C} P_{A}^{1}$ is given 2-dimensional and 1-dimensional cells, which produces the cell decomposition of $F_{n}$. This implies that $F_{n}$ has a cell decomposition without cells in dimensions $\leq n-4$ which further gives that

$$
\begin{equation*}
H_{k}\left(F_{n}\right)=0, \text { for } 0<k \leq n-4 . \tag{5}
\end{equation*}
$$

It is not difficult to verify, see [7], that any $F_{\sigma}$ is either a point or it is homeomorphic to $F_{m}, 4 \leq$ $m \leq n-1$, which gives the cell decomposition for $F_{\sigma}$ and an analogue result to (5)for its homology groups.

Proposition 2.2. ([6]) A stratum $W_{\sigma}$ is defined in the chart $M_{12}$ by $P^{1 i}=0, P^{2 j}=0$ or $P^{p q}=0$, for some $3 \leq i, j, p, q \leq n$ or in the local coordinates by $a_{i}=b_{j}=0$ and $a_{p} b_{q}=a_{q} b_{p}$. The space of parameters $F_{\sigma}=W_{\sigma} /\left(\mathbb{C}^{*}\right)^{n}$ that is not a point is given by restriction of the equations (4) to some factors $\mathbb{C} P^{1} \backslash B$ in $\left(\mathbb{C} P^{1}\right)^{N}$ where $B=\{(1: 0),(0: 1)\}$.

The closure of $F_{n}$ in $\left(\mathbb{C} P^{1}\right)^{N}$ is denoted by $\bar{F}_{n}$. It is given by intersection of cubics (4) in $\left(\mathbb{C} P^{1}\right)^{N}$. The space $\bar{F}_{n}$ is proved in [6] to be a smooth manifold. The points from the boundary of $F_{n}$ in $\left(\mathbb{C} P^{1}\right)^{N}$ are obtained if in (4) is allowed that some $c_{l m}=0, c_{l m}^{\prime}=0$ or $c_{l m}=c_{l m}^{\prime}$ for $3 \leq l<m \leq n$.

The universal space of parameters $\mathcal{F}_{n}$ is a compactification of the space of parameters $F_{n}$ of the main stratum, see [2] and the references given there.

It is defined as a wonderful compactification of the space $\bar{F}_{n}$. This compactification requires that the homeomorphisms of $F_{n}$ defined by transition functions between the charts for $G_{n, 2}$ extend to the homeomorphisms for $\mathcal{F}_{n}$ in an arbitrary chart.

Theorem 2.3. ([7] and [2]) Let the manifold $\mathcal{F}_{n}$ is obtained by the wonderful compactification of $\bar{F}_{n}$ with the generating set of subvarieties $\bar{F}_{I} \subset \bar{F}_{n}$, defined by $\left(c_{i k}: c_{i k}^{\prime}\right)=\left(c_{i l}: c_{i l}^{\prime}\right)=\left(c_{k l}\right.$ : $\left.c_{k l}^{\prime}\right)=(1: 1)$ for $i k l \in I$, where $I \subset\{i k l \mid 3 \leq i<k<l \leq n\}$. Then any homeomorphism $f_{i j, k l}: F_{n} \rightarrow F_{n}$ induced by the transition functions between the charts $M_{i j}$ and $M_{k l}$ extends to the homeomorphism of $\mathcal{F}_{n}$.

The main stratum $W$ is a dense set in $G_{n, 2}$ and according to [2] and [3] to any stratum can be assigned the virtual space of parameters $\tilde{F}_{\sigma} \subset \mathcal{F}_{n}$, in a fixed chart $M_{12}$, on the following way:

1. If $W_{\sigma} \subset M_{12}$, the virtual space $\tilde{F}_{\sigma}$ is assigned using the description (4) of the main stratum
2. If $W_{\sigma} \cap M_{12}=\varnothing$, we first find a chart $M_{i j}$ such that $W_{\sigma} \subset M_{i j}$ and then we assign to $W_{\sigma}$ the space $\tilde{F}_{\sigma, i j}$ using description (4). Finally, using homeomorphism $f_{i j, 12}$ for $\mathcal{F}_{n}$ defined in Theorem 2.3 we assign to $W_{\sigma}$ the subspace $\tilde{F}_{\sigma, 12}$.

Theorem 2.4. For a chart $M_{i j}$ it holds:

1. $\bigcup_{\sigma} \tilde{F}_{\sigma, i j}=\mathcal{F}_{n}$
2. There exists a canonical projection $p_{\sigma, i j}: \tilde{F}_{\sigma, i j} \rightarrow F_{\sigma}$ for any admissible set $\sigma$.

### 2.2 The model for $X_{n}=G_{n, 2} / T^{n}$

Let the hyperplane arrangement $\mathcal{G}_{n}$ in $\mathbb{R}^{n}$ be defined by

$$
\begin{equation*}
\Pi \cup\left\{x_{i}=0,1 \mid 1 \leq i \leq n\right\}, \tag{6}
\end{equation*}
$$

where $\Pi$ is the set of hyperplanes given by

$$
\sum_{i \in S,\|S\|=p} x_{i}=1
$$

for $S \subset\{1, \ldots, n\}, 2 \leq p \leq\left[\frac{n}{2}\right]$. Let $L\left(\mathcal{G}_{n}\right)$ be its intersection poset. In what follows we consider the hyperplane arrangement induced by this arrangement in $\mathbb{R}^{n-1}=\left\{\left(x_{1}, \ldots, x_{n}\right) \in\right.$ $\left.\mathbb{R}^{n} \mid x_{1}+\cdots+x_{n}=2\right\}$.

If restrict the poset $L\left(\mathcal{G}_{n}\right)$ to $\Delta_{n, 2}$ we get the poset $L(\mathcal{G}(n, 2))=L\left(\mathcal{G}_{n}\right) \cap \Delta_{n, 2}$. From now on, we call an element $C$ of the poset $L(\mathcal{G}(n, 2))$ a chamber and the decomposition $L(\mathcal{G}(n, 2))$ of $\Delta_{n, 2}$ the chamber decomposition.

In [2] it is proved:

Lemma 2.5. Any chamber $C \in L(\mathcal{G}(n, 2))$ can be obtained as the intersection of the relative interiors of all admissible polytopes which contain $C$.

Thus, a chamber from $L(\mathcal{G}(n, 2))$ is defined by

$$
C_{\omega}:=\bigcap_{\sigma \subset \omega} \stackrel{\circ}{P}_{\sigma} \quad \text { and } C_{\omega} \cap \stackrel{\circ}{P}_{\sigma}=\varnothing \text { if } \sigma \notin \omega .
$$

According to [2] the orbit space $X_{n}=G_{n, 2} / T^{n}$ can be represented by

$$
\begin{equation*}
X_{n}=\bigcup_{1 \leq i \leq n} X_{n-1}(i) \cup \bigcup_{1 \leq i \leq n} \Delta_{n-1,1}(i) \cup \hat{\mu}^{-1}\left(\Delta_{n, 2}^{\circ}\right), \tag{7}
\end{equation*}
$$

where

$$
\begin{equation*}
\hat{\mu}^{-1}\left(\Delta_{n, 2}^{\circ}\right)=\bigcup \hat{C}_{\omega}, \hat{C}_{\omega}=\hat{\mu}^{-1}\left(C_{\omega}\right) \tag{8}
\end{equation*}
$$

for a chamber $C_{\omega} \subset \stackrel{\circ}{\Delta}, 2^{2}$. In [6] it is showed that there exists the canonical homeomorphism

$$
h_{\sigma}: W_{\sigma} / T^{\sigma} \rightarrow \stackrel{\circ}{P}_{\sigma} \times F_{\sigma} \text { given by } h_{\sigma}=\left(\hat{\mu}, p_{\sigma}\right)
$$

where $\hat{\mu}_{\sigma}: W_{\sigma} / T^{\sigma} \rightarrow \stackrel{\circ}{P_{\sigma}}$ is induced by the moment map $\hat{\mu}: G_{n, 2} / T^{n} \rightarrow \Delta_{n, 2}$ and $p_{\sigma}: W_{\sigma} / T^{\sigma} \rightarrow$ $F_{\sigma}$ is induced by the natural projection $G_{n, 2} \rightarrow G_{n, 2} /\left(\mathbb{C}^{\star}\right)^{n}$. In particular, $W / T^{n} \simeq \Delta_{n, 2} \times F$ for the main stratum $W$.

Lemma 2.6. ([2]]) For any $C_{\omega} \in L(\mathcal{G}(n, 2))$ such that $\operatorname{dim} C_{\omega}=n-1$ there exists canonical homeomorphism

$$
h_{\omega}: \hat{C}_{\omega} \rightarrow C_{\omega} \times F_{\omega},
$$

where the manifold $F_{\omega}$ is a compactification of $F_{n}$ given by the spaces $F_{\sigma}$ such that $C_{\omega} \subset P_{\sigma}$,

$$
F_{\omega}=\bigcup_{\substack{C_{\omega} \subset \perp_{\sigma}}} F_{\sigma} .
$$

Lemma 2.7. For any $C_{\omega} \in L(\mathcal{G}(n, 2))$ such that $\operatorname{dim} C_{\omega}=n-2$ there exists canonical homeomorphism

$$
h_{\omega}: \hat{C}_{\omega} \rightarrow C_{\omega} \times F_{\omega},
$$

where the manifold $F_{\omega}$ is a compactification of the space $F_{n}$ given by the spaces $F_{\sigma}$ such that $C_{\omega} \subset \stackrel{\circ}{P}_{\sigma}$, where $\operatorname{dim} P_{\sigma}=n-1$ and a point $F_{\sigma}$ such that $C_{\omega} \subset \stackrel{\circ}{P}_{\sigma}$, where $\operatorname{dim} P_{\sigma}=n-2$.

Similar result is proved in [2] for a chambers $C_{\omega}$ where $\operatorname{dim} C_{\omega} \leq n-3$.
Lemma 2.8. For any $C_{\omega} \in L(\mathcal{G}(n, 2))$ such that $\operatorname{dim} C_{\omega} \leq n-3$ there exists canonical homeomorphism

$$
h_{\omega}: \hat{C}_{\omega} \rightarrow C_{\omega} \times F_{\omega},
$$

where the manifold $F_{\omega}$ is a compactification of the space $F_{n}$ given by the spaces $F_{\sigma}$ such that $C_{\omega} \subset \stackrel{\circ}{P}_{\sigma}$, where $\operatorname{dim} P_{\sigma}=n-1$ and $q$ points, where $q \geq 2$ is the number of polytopes $P_{\sigma}$ such that $C_{\omega} \subset \stackrel{\circ}{P}_{\sigma}$ and $\operatorname{dim} P_{\sigma}=n-2$.

In particular, $\operatorname{dim} F_{\omega}=\operatorname{dim} F_{n}$ for any $\omega$ and $\operatorname{dim} F_{\sigma}<\operatorname{dim} F_{n}$ for any $\sigma$ such that $F_{\sigma} \neq F_{n}$.
Let $\mathcal{F}_{n}$ be an universal space of parameters for $G_{n, 2}$ and fix a chart $M_{i j}$. By Theorem 2.4 to any stratum $W_{\sigma}$ is assigned the virtual space of parameters $\tilde{F}_{\sigma}=\tilde{F}_{\sigma, i j}$ and the projection $p_{\sigma, i j}: \tilde{F}_{\sigma, i j} \rightarrow$ $F_{\sigma}$.

Theorem 2.9. ([2]]) For any chamber $C_{\omega}$ and a chart $M_{i j}$ it holds that

$$
\mathcal{F}_{n}=\bigcup_{C_{\omega} \circ_{\sigma}} \tilde{F}_{\sigma}
$$

and this union is disjoint. Moreover, it is defined the projection $p_{\omega, i j}: \mathcal{F}_{n} \rightarrow F_{\omega}$ by $p_{\omega, i j}(y)=$ $p_{\sigma, i j}(y)$ where $y \in \tilde{F}_{\sigma, i j}$.

Altogether, this leads to the model for the orbit space $X_{n}$. Let us denote

$$
\begin{equation*}
U_{n}=\Delta_{n, 2} \times \mathcal{F}_{n} . \tag{9}
\end{equation*}
$$

Theorem 2.10. ([2]) For any chart $M_{i j} \subset G_{n, 2}$ the map

$$
p_{n}: U_{n} \rightarrow G_{n, 2} / T^{n}, p_{n}(x, y)=h_{\omega}^{-1}\left(x, p_{\omega, i j}(y)\right)
$$

if and only if $x \in C_{\omega}$ is correctly defined. In addition, the map $p_{n}$ is a continuous surjection and the orbit space $G_{n, 2} / T^{n}$ is homeomorphic to the quotient of the space $U_{n}$ by the map $p_{n}$.

## 3 The moduli space $\mathcal{M}_{0, n}$ and the universal space of parameters $\mathcal{F}_{n}$

We denote by $\mathcal{M}_{0, n}$ the moduli space of stable genus zero curves with $n$ marked ordered pairwise distinct points. In [20] it is presented the construction of the moduli space $\mathcal{M}_{0, n}$ based on the iterated blowing-up of the space $\left(\mathbb{C} P^{1}\right)^{n-3}$. We recall the basic facts about this construction and demonstrate it for the cases $n=5,6$.

Let $X=\left(\mathbb{C} P^{1}\right)^{n-3}$ and $I=\left\{i_{1}, \ldots, i_{k}\right\}$ be a subset of the set $\{1, \ldots, n\}$ such that

$$
|I \cap\{n-2, n-1, n\}| \leq 1 \quad \text { and } 2 \leq k \leq n-2 .
$$

The subvariety $X_{I}$ of $X$ is given as follows: if the set $I \cap\{n-2, n-1, n\}$ is empty, then $X_{I}$ is the set of all points $\left(x_{1}, \ldots, x_{n-3}\right)$ in $X$ such that coordinates with indices $i_{j}$ are equal to each other, where $1 \leq j \leq k$. Otherwise, elements $n-2, n-1, n$ are considered to be special elements with the following correspondence:

$$
n-2 \leftrightarrow 0, \quad n-1 \leftrightarrow 1, \quad n \leftrightarrow \infty .
$$

In the case $|I \cap\{n-2, n-1, n\}|=1$ the subvariety $X_{I}$ of $X$ is the set of all points $\left(x_{1}, \ldots, x_{n-3}\right)$ in $X$ such that coordinates with non-special indices $i_{j}$ are equal to the special value coordinate as defined above, where $1 \leq j \leq k$.

For any other subset $I \subset\{1, \ldots, n\}$ the subvariety $X_{I}$ is defined following the rule $X_{I}=X_{I^{\complement}}$, where $I^{\complement}=\{1, \ldots, n\} \backslash I$.

Example 1. For $n=5$, we get $X_{12}=\left\{(x, x) \mid x \in \mathbb{C} P^{1}\right\}$, $X_{34}=X_{125}=\{(\infty, \infty)\}$.

The moduli space of curves of genus 0 with $n$ marked distinct points, denoted by $M_{0, n}$, is identified in [20] with the subset of $X$ :

$$
M_{0, n}=\left\{\left(x_{1}, \ldots, x_{n-3}\right) \in\left(\mathbb{C} P^{1}\right)^{n-3} \mid x_{i} \neq\{0,1, \infty\}, x_{i} \neq x_{j}\right\}
$$

where $0=(0: 1), 1=(1: 1)$ and $\infty=(1: 0)$.
The moduli space $M_{0, n}$ coincides by [7] with the space of parameters of the main stratum $F_{n}$. In the paper [20] Tavakol described the space $\mathcal{M}_{0, n}$ which is the compactification of $M_{0, n}$, similarly as Keel did in [16], starting from $X$ by the sequence of blow-ups. First one blows-up three points $X_{1, \ldots, n-3, n-2}, X_{1, \ldots, n-3, n-1}, X_{1, \ldots, n-3, n}$. This blow-up separates all lines $X_{I}$ for which $|I|=n-3$. Second, one blows-up the proper transform of all these lines. The process continues for $|I| \geq 2$. We note that $X_{I}$ for $|I|=2$ is a complex $(n-4)$-dimensional submanifold in the manifold obtained by the previous blow-up construction on $X$, so the further blowing up at $X_{I}$ does not change anything.

The exceptional divisor of the blow-up along the subvariety $X_{I}$ is denoted by $D_{I}$.
Keel in [16] showed that the Chow ring of $\mathcal{M}_{0, n}$ is generated by all divisor classes $D_{I}$ and they satisfy following relations:

$$
\begin{equation*}
\sum_{\substack{i, j \in I \\ p, q \notin I}} D_{I}=\sum_{\substack{i, p \in I \\ j, q \notin I}} D_{I}=\sum_{\substack{i, q \in I \\ j, p \notin I}} D_{I} \tag{10}
\end{equation*}
$$

for any four distinct elements $\{i, j, p, q\} \subset\{1, \ldots, n\}$ an it d holds

$$
D_{I}=D_{I^{\complement}}, \quad D_{I} D_{J}=0 \text { unless } I \subset J, I \subset J, I^{\complement} \subset J \text { or } J^{\complement} \subset I .
$$

In addition, he proved that the canonical map from Chow groups to homology induces an isomorphism $A_{\star}\left(\mathcal{M}_{0, n}\right) \rightarrow H_{\star}\left(\mathcal{M}_{0, n}\right)$.

In [8] Ceyhan proved this isomorphism for the moduli spaces $\mathcal{M}_{\mathcal{A}}$ of weighted pointed stable curves of genus zero generalizing Keel's result, but using significantly different method which appeals on the construction of the stratification for $\mathcal{M}_{\mathcal{A}}$. More precisely, he proved that the Chow groups $A_{i}\left(\mathcal{M}_{\mathcal{A}}\right)$ and the homology groups $H_{2 i}\left(\mathcal{M}_{\mathcal{A}}\right)$ are isomorphic. We note that for some special weights $\mathcal{A}$ similar results are proved by Losev and Manin as well in [17], [18].

In the next examples we describe the divisors $D_{I}$ in $\mathcal{M}_{0, n}$ for $n=5,6$.
Example 2. The moduli space $\mathcal{M}_{0,5}$ is obtained as the blow-up of $X=\mathbb{C} P^{1} \times \mathbb{C} P^{1}$ at the points $X_{123}=(0,0), X_{124}=(1,1)$ and $X_{125}=(\infty, \infty)$. Let $U$ be a neighborhood of the point $((0$ : $1),(0: 1))$ defined by $\left\{\left(c_{1}: 1\right),\left(c_{2}: 1\right)\right\}$. We can take $\left(c_{1}, c_{2}\right) \in U(0,0) \subset \mathbb{C}^{2}$ as coordinates in $U$. The blow-up $b l_{X_{123}} X$ of the variety $X$ in the neighborhood $U$ belongs to $U \times \mathbb{C} P^{1}$. Let $\left\{\left(c_{1}, c_{2}\right),\left(x_{1}: x_{2}\right)\right\}$ be coordinates in $U \times \mathbb{C} P^{1}$ and $\pi: b l_{X_{123}} X \rightarrow X$ a natural projection morphism. Then the coordinates of points in $\pi^{-1}\left(U-X_{123}\right)$ are given by the equation

$$
c_{1} x_{2}=c_{2} x_{1} .
$$

The exceptional set satisfies $\pi^{-1}\left(X_{123}\right) \simeq \mathbb{C} P^{1}$ and we put $D_{123}=X_{123} \times \mathbb{C} P^{1}=0 \times 0 \times X_{123}$. Similarly, we construct blow-ups for points $X_{124}$ and $X_{125}$.

Example 3. The moduli space $\mathcal{M}_{0,6}$ is obtained first as blow-up of $X=\mathbb{C} P^{1} \times \mathbb{C} P^{1} \times \mathbb{C} P^{1}$ at three points $X_{1234}, X_{1235}, X_{1236}$ and then by blowing-up of proper transform of lines $X_{I}$ where $|I|=3$.

The blow-up of $X$ at the point $X_{1235}=(1,1,1)$ is similar to the case $n=5$. Let $U$ be a neighborhood of the point $X_{1235}$ defined by $\left\{\left(c_{1}: 1\right),\left(c_{2}: 1\right),\left(c_{3}: 1\right)\right\}$. The coordinates of the neighborhood $U$ are given by $\left(c_{1}, c_{2}, c_{3}\right) \in U(1,1,1) \subset \mathbb{C}^{3}$ and the coordinates of the points in $\pi^{-1}\left(U-X_{1235}\right)$ satisfy

$$
\left(1-c_{i}\right) x_{j}=\left(1-c_{j}\right) x_{i}, \text { for } 1 \leq i, j \leq 3 .
$$

The exceptional set satisfies $\pi^{-1}\left(X_{1235}\right)=X_{1235} \times \mathbb{C} P^{2}$.
Similarly, we construct blow-up at the point $X_{1234}$. Let a neighborhood of the point $X_{1234}$ be defined by $\left\{\left(c_{1}: 1\right),\left(c_{2}: 1\right),\left(c_{3}: 1\right)\right\}$. The coordinates of points in $\pi^{-1}\left(U-X_{1234}\right)$ satisfy

$$
c_{i} x_{j}=c_{j} x_{i}, \text { for } 1 \leq i, j \leq 3 .
$$

After blowing-up $X$ at these points, we proceed with blow-up of the lines $X_{I}$, where $|I|=3$. In doing that we consider, for example, the proper transform of $X_{124}$ denoted by $X_{124}^{\prime}$. By classical definition, we obtain $X_{124}^{\prime}=\overline{\pi^{-1}\left(X_{123}-X_{1234}\right)}$, which is the closure of $\pi^{-1}\left(X_{123}-X_{1234}\right)$. Since $\pi^{-1}\left(X_{124}-X_{1234}\right)=\left\{(0: 1),(0: 1),\left(c: c^{\prime}\right),(0: 0: 1) \mid c \neq 0\right\}$, its closure is $\{(0: 1),(0:$ $\left.1),\left(c: c^{\prime}\right),(0: 0: 1)\right\}$. We continue with blow-up at $X_{124}^{\prime}$. Let $U$ be a neighborhood of $X_{124}^{\prime}$ defined by $\left\{\left(c_{1}: 1\right),\left(c_{2}: 1\right),\left(c: c^{\prime},(0: 0: 1)\right)\right\}$. Blowing-up further at $X_{124}^{\prime}$ in the neighborhood $U$ we add the coordinates $\left(x_{1}: x_{2}\right) \in \mathbb{C} P^{1}$ and the points from $\pi^{-1}\left(U-X_{124}\right)$ satisfy

$$
c_{i} x_{j}=c_{j} x_{i}, \text { for } 1 \leq i, j \leq 2 .
$$

The exceptional set is $\pi^{-1}\left(X_{124}\right)=X_{124} \times \mathbb{C} P^{1}$. Thus, the divisors $D_{I},|I|=3$ are disjoint and each of them is isomorphic to $\mathbb{C} P^{1}$.

The divisors are:

- $D_{I} \simeq X_{I} \times \mathbb{C} P^{2} \times\left(\mathbb{C} P^{1}\right)^{4}$ for $|I|=4$. The term $\mathbb{C} P^{2}$ corresponds to the blow-up $b l_{X_{I}}$ and the terms $\left(\mathbb{C} P^{1}\right)^{4}$ to the blow-ups at $X_{J},|J|=3$ such that $X_{I} \subset X_{J}$.
- $D_{I} \simeq X_{I} \times \mathbb{C} P^{1}$ for $|I|=3$. The term $\mathbb{C} P^{1}$ corresponds to the blow-up at the $X_{I}$.
- $D_{I}$ for $|I|=2$ is the proper transform of $X_{I}$ after final blow-up.

There exists the correlation between divisors $D_{I}$ and a virtual spaces of parameters $\tilde{F}_{\sigma}$. We will describe this correlation explicitly for $n=5,6$ in Sections 5and In establishing this correlation we use the next important result proved in [7].

Theorem 3.1. The universal space of parameters $\mathcal{F}_{n}$ is diffeomorphic to the space $\mathcal{M}_{0, n}$.
We explicitly demonstrate this diffeomorphism for the cases $n=5$ and $n=6$, see also [7], in the next examples.

Example 4. We follow notations from the example 2 Let us consider map $f:\left(\mathbb{C} P^{1}\right)^{2} \rightarrow\left(\mathbb{C} P^{1}\right)^{3}$ given by

$$
f\left(\left(c_{34}: c_{34}^{\prime}\right),\left(c_{35}: c_{35}^{\prime}\right)\right)=\left(\left(c_{34}: c_{34}^{\prime}\right),\left(c_{35}: c_{35}^{\prime}\right),\left(c_{34}^{\prime} c_{35}: c_{34} c_{35}^{\prime}\right)\right) .
$$

This map is not defined at the points $X_{124}, X_{126}$. After we blow-up $\left(\mathbb{C} P^{1}\right)^{2}$ at the points $X_{124}, X_{126}$ as in Example 2 we obtain the variety denoted by $Y=b l_{126} b l_{X_{124}}$. The map $f$ extends to the homeomorphism $\bar{f}$ between $Y$ and $\bar{F}_{5}$. The divisor $D_{124} \simeq X_{124} \times\left\{\left(x_{1}: x_{2}\right) \subset \mathbb{C} P^{1}\right\}$ maps to $\left((0: 1),(0: 1),\left(x_{1}: x_{2}\right)\right)$ and similar for the divisor $D_{126}$. Now we blow-up $Y$ at $X_{125}$ and $\bar{F}_{5}$ at $(1: 1)^{3}$ and conclude the homeomorphism between $\mathcal{F}_{5}$ and $\mathcal{M}_{0,5}$.

Example 5. Let us consider the map $f:\left(\mathbb{C} P^{1}\right)^{3} \rightarrow\left(\mathbb{C} P^{1}\right)^{6}$ given by

$$
\begin{aligned}
& f\left(\left(c_{34}: c_{34}^{\prime}\right),\left(c_{35}: c_{35}^{\prime}\right),\left(c_{36}: c_{36}^{\prime}\right)\right)= \\
& =\left(\left(c_{34}: c_{34}^{\prime}\right),\left(c_{35}: c_{35}^{\prime}\right),\left(c_{36}: c_{36}^{\prime}\right),\left(c_{34}^{\prime} c_{35}: c_{34} c_{35}^{\prime}\right),\left(c_{34}^{\prime} c_{36}: c_{34} c_{36}^{\prime}\right),\left(c_{35}^{\prime} c_{36}: c_{35} c_{36}^{\prime}\right)\right)
\end{aligned}
$$

This map is not defined at the sub-varieties $\left\{X_{I} \mid I \in S\right\}$ where $S=\{124,134,234,126,136,236\}$ neither at the points $X_{1234}, X_{1236}$. We denote by $Y$ the blow-up of $\left(\mathbb{C} P^{1}\right)^{3}$ at this sub-varieties according to Example 3 The extension $\bar{f}$ of the map $f$ between $Y$ and $\bar{F}_{6}$ can be defined as follows:

- The points of the divisors $D_{1234}$ and $D_{1236}$, apart from the points for which the corresponding $\mathbb{C} P^{2}$ component is $(1: 0: 0)$ or $(0: 1: 0)$ or $(0: 0: 1)$ and which are blown-up by blowing up the lines $X_{I}^{\prime}$, we map by

$$
\begin{aligned}
& D_{1234}=\left((0: 1),(0: 1),(0: 1),\left(x_{1}: x_{2}: x_{3}\right)\right) \rightarrow\left((0: 1),(0: 1),(0: 1),\left(x_{1}: x_{2}\right),\left(x_{1}: x_{3}\right),\left(x_{2}: x_{3}\right)\right), \\
& D_{1236}=\left((1: 0),(1: 0),(1: 0),\left(x_{1}: x_{2}: x_{3}\right)\right) \rightarrow\left((1: 0),(1: 0),(1: 0),\left(x_{1}: x_{2}\right),\left(x_{1}: x_{3}\right),\left(x_{2}: x_{3}\right)\right) . \\
& \text { It follows from Example } 3 \text { that the points of } \bar{f}\left(D_{1234}\right) \text { belong to } \bar{F}_{6} .
\end{aligned}
$$

- The divisor $D_{I}$, for example if $I=124$ maps by

$$
D_{124}=\left((0: 1),(0: 1),\left(c: c^{\prime}\right),\left(x_{1}: x_{2}\right)\right) \rightarrow\left((0: 1),(0: 1),\left(c: c^{\prime}\right),\left(x_{1}: x_{2}\right),(1: 0),(1: 0)\right) .
$$

It is left to sequentially blow-up the variety $Y$ at $X_{1235}$ and than at $X_{125}, X_{135}, X_{235}, X_{123}$ and in the result we obtain the space $\mathcal{M}_{0,6}$. On the other side, the blow-up of the space $\bar{F}_{6}$ at the varieties $(1: 1)^{6}$ and $\bar{F}_{345}, \bar{F}_{346}, \bar{F}_{356}, \bar{F}_{456}$ gives $\mathcal{F}_{6}$.

## 4 On $\mathbb{Z}_{2}$-homology of $G_{n, 2} / T^{n}$

Using the theory presented in previous sections on description of topology of the orbit space $G_{n, 2} / T^{n}$ and in particular the model (9), we prove some general results on description of $\mathbb{Z}_{2^{-}}$ homology of $G_{n, 2} / T^{n}$. It follows from (7) that the $\mathbb{Z}_{2}$-cycles in $G_{n, 2} / T^{n}$ can be studied inductively on $n$.

We consider the cell decomposition of $F_{\omega}$ given by a cell decomposition of $F_{\sigma}$ 's, $\sigma \in \omega$ obtained following Remark 1 We denote further by $P_{\sigma^{\prime}}$ a facet in $\stackrel{\circ}{n, 2}$ of an admissible polytope $P_{\sigma}$ and by
 $C_{\omega} \times e_{\omega}^{\sigma}$, where $e_{\omega}^{\sigma} \subset F_{\sigma}, \sigma \in \omega$ we first emphasize the following.
Remark 2. If $C_{\omega^{\prime}} \subset \stackrel{\circ}{P}_{\sigma}$ is a facet of $C_{\omega}$, than only the cell $C_{\omega^{\prime}} \times e_{\omega}^{\sigma}$ which belongs to $W_{\sigma} / T^{n}$ contributes to the boundary of $C_{\omega}^{\sigma} \times e_{\omega}^{\sigma}$. This is because of the following: if a cell $C_{\omega^{\prime}} \times e_{\omega^{\prime}}^{\tilde{\sigma}}$ is in the closure of $C_{\omega}^{\sigma} \times e_{\omega}^{\sigma}$, then the points from $W_{\tilde{\sigma}}$ have zero all Pücker coordinates which are zero for the points from $W_{\sigma}$, and some more. In particular, $P_{\tilde{\sigma}} \subset P_{\sigma}$. Thus, taking into account the cell decompositions for $F_{\sigma}$ and $F_{\tilde{\sigma}}$ from Remark 1 this implies that if a cell $C_{\tilde{\omega}} \times e_{\tilde{\omega}}^{\tilde{\omega}}$ is in the closure of a cell $C_{\omega} \times e_{\sigma}^{\omega}$, then $\operatorname{dim} e_{\tilde{\omega}}^{\tilde{\sigma}}<\operatorname{dim} e_{\omega}^{\sigma}$. It follows that $C_{\omega^{\prime}} \times e_{\omega^{\prime}}^{\tilde{\sigma}}$ can not contribute to $\partial\left(C_{\omega} \times e_{\omega}^{\sigma}\right)$.

Therefore, the boundary operator for $\mathrm{C}_{\omega}^{\sigma} \times e_{\omega}^{\sigma}$ is defined by differentiating the following cases.

- If $C_{\omega}$ has no facet on $\partial \Delta_{n, 2}$ and either has no facets on $\partial P_{\sigma}$ or $e_{\omega}^{\sigma}$ is a point, then

$$
\partial\left(C_{\omega} \times e_{\omega}^{\sigma}\right)=C_{\omega} \times \partial^{\omega} e_{\omega}^{\sigma}+\sum_{C_{\omega^{\prime}} \text { facet of } C_{\omega}} C_{\omega^{\prime}} \times e_{\omega}^{\sigma},
$$

- If $C_{\omega}$ has no facet on $\partial \Delta_{n, 2}$, but is has a facet $C_{\omega^{\prime}}^{\sigma}$ on $\partial P_{\sigma}$ then

$$
\partial\left(C_{\omega} \times e_{\omega}^{\sigma}\right)=C_{\omega} \times \partial^{\omega} e_{\omega}^{\sigma}+\sum_{\substack{C_{\omega^{\prime}} \text { facet of } C_{\omega} \\ C_{\omega^{\prime}} \neq C_{\omega^{\prime}}^{\sigma}}} C_{\omega} \times e_{\omega}^{\sigma} .
$$

Remark 3. If $C_{\omega}$ has a facet $C_{\bar{\omega}}$ on $\partial \Delta_{n, 2}$ then $C_{\bar{\omega}}=\cap P_{\bar{\sigma}}$ for the facets $P_{\bar{\sigma}}$ of $P_{\sigma}$, where $\sigma \in$ $\omega$. In addition, in [3], page 618, it is defined the continuous surjective map $\eta_{\sigma, \bar{\sigma}}: F_{\sigma} \rightarrow F_{\bar{\sigma}}$, which gives continuous surjection $\eta_{\omega, \bar{\omega}}: F_{\omega} \rightarrow F_{\bar{\omega}}$. Thus, the chain map $\eta_{\omega, \bar{\omega}}^{\#}: C_{\#}\left(F_{\omega}\right) \rightarrow$ $C_{\#}\left(F_{\bar{\omega}}\right)$ induced by $\eta_{\omega, \bar{\omega}}: F_{\omega} \rightarrow F_{\bar{\omega}}$ is surjective by Remark 1

- If $C_{\omega}$ has a facet on $\partial \Delta_{n, 2}$ we obtain that

$$
\partial\left(C_{\omega} \times e_{\omega}^{\sigma}\right)=\partial^{0}\left(C_{\omega} \times e_{\omega}^{\sigma}\right)+\sum_{C_{\bar{\omega}} \text { facet of } C_{\omega}} C_{\bar{\omega}} \times \eta_{\omega, \bar{\omega}}\left(e_{\omega}^{\sigma}\right),
$$

where $\partial^{0}$ denotes the boundary component indicated in the previous two cases.
For the space of parameters $F_{\omega}$ we note the following.
Theorem 4.1. The homology groups of non-maximal dimension of the space of parameters $F_{\omega}$ are spanned by the outgrows $F_{\sigma}, \sigma \in \omega$ in the compactification of $F_{n}$ to $F_{\omega}$.
Proof. As we pointed out the space of parameters of a chamber $C_{\omega}$ is a compactification of the space of parameters of the main stratum $F_{n}$ by the spaces of parameters $F_{\sigma}$ of the strata $W_{\sigma}$, where $\sigma \in \omega$. By Theorem 2.9 there exists continuous projection $p_{\omega}: \mathcal{F}_{n} \rightarrow F_{\omega}$ defined by the projections $p_{\sigma}: \tilde{F}_{\sigma} \rightarrow F_{\sigma}$. It follows from [2], proof of Proposition 6.1 or [6] that $\tilde{F}_{\sigma}=\bar{F}_{l} \times \bar{F}_{s} \times F_{m}$, where $F_{m} \cong F_{\sigma}$ and $l+s+m \leq n+4,0 \leq l, s, m \leq n-1$. It implies that the the induced homomorphism between the cycles on $\mathcal{F}_{n}$ and the cycles on $F_{\omega}$ is surjective. Since by [16], the homology groups for $\mathcal{F}_{n}$ are spanned by the divisors outgrowing in the compactification of $F_{n}$ to $\mathcal{F}_{n}$, it follows that the homology groups for $F_{\omega}$ are spanned by the outgrows in the compactification of $F_{n}$ to $F_{\omega}$.

Remark 4. In [5] it is proved that $F_{\omega} \cong \mathcal{M}_{\mathcal{A}}=\mathcal{M}_{0, \mathcal{A}}$, which is a moduli space of weighted stable genus zero curves with $n$ marked distinct points with a set of weights $\mathcal{A}$, defined in [13] in general setting. It is also showed that the projection $p_{\omega}: \mathcal{F}_{n} \cong \mathcal{M}_{0, n} \rightarrow F_{\omega}$ coincides with the reduction morphism $\rho_{\mathcal{A}}: \mathcal{M}_{0, n} \rightarrow \mathcal{M}_{\mathcal{A}}$, defined in [13].

On the other side, in [8] it is obtained the description of the homology groups $H_{*}\left(\mathcal{M}_{\mathcal{A}}\right)$ in terms of a stratification for $\mathcal{M}_{\mathcal{A}}$. Moreover, it is pointed that the generators and relations in $H_{*}\left(\mathcal{M}_{A}\right)$ are induced from those in $H_{*}\left(\mathcal{M}_{0, n}\right)$ by the reduction morphism $\rho_{\mathcal{A}}$.

Therefore, Theorem 4.1 provides the formulation and the proof of this result in terms of the topological ingredients of the model $\left(U_{n}, p_{n}\right)$ for $X_{n}$.

In what follows we consider $\mathbb{Z}_{2}$-chains in $G_{n, 2} / T^{n}$ which map by the induced moment map $\hat{\mu}$ to the interior $\Delta_{n, 2}^{\circ}$. Any such chain has the form

$$
c=\sum_{\omega} C_{\omega} \times l_{\omega}, \quad C_{\omega} \subset \Delta_{n, 2}^{\circ}
$$

and $l_{\omega}$ is a chain in $F_{\omega}$. The chain $l_{\omega}$ can be represented by $l_{\omega}=\sum_{\sigma \in \omega} l_{\omega}^{\sigma}$ for a chain $l_{\omega}^{\sigma}$ in $F_{\sigma}$. For $F_{\sigma}=F$ we put $l_{\omega}^{\sigma}=l_{\omega}^{F}$.

For the boundary of a chain $c$ we note that $\partial_{p} c=\partial_{p}^{\circ} c+\partial_{p}^{\prime} c$, where $\hat{\mu}\left(\partial_{p}^{\circ} c\right) \subset \Delta_{n, 2}$ and $\hat{\mu}\left(\partial_{p}^{\prime} c\right) \subset$ $\partial \Delta_{n, 2}$ and $p=\operatorname{dim} c-1$. We describe this decomposition of $\partial_{p} c$ more explicitly using Remark 2,

Lemma 4.2. The boundary component

- $\partial_{p}^{\prime}$ c of c has the form

$$
\begin{equation*}
\partial_{p}^{\prime} c=\sum_{\bar{\omega}} C_{\bar{\omega}} \times \eta_{\omega, \bar{\omega}}^{\#}\left(l_{\omega}\right) \tag{11}
\end{equation*}
$$

- $\partial_{p}^{\circ}$ c has the form

$$
\begin{equation*}
\partial_{p}^{\circ} c=\sum_{\omega} \sum_{\substack{\omega^{\prime} \\ C_{\omega^{\prime}}^{\prime} \subset \Delta_{n, 2} C_{\omega^{\prime}}^{\prime} \subset P_{\sigma}}} \sum_{\substack{\sigma \in \omega \\ \omega^{\prime}}} \times l_{\omega}^{\sigma}+\sum_{\omega} C_{\omega} \times \partial^{\omega} l_{\omega} \tag{12}
\end{equation*}
$$

where $\partial^{\omega} l_{\omega}$ denotes the boundary of $l_{\omega}$ in $F_{\omega}$.
Remark 5. Note that $H_{0}\left(X_{n} ; \mathbb{Z}_{2}\right) \cong \mathbb{Z}_{2}$ as $X_{n}$ is path connected.
The following known result [6] is easy to deduce:

## Lemma 4.3.

$$
H_{3 n-7}\left(X_{n}, \mathbb{Z}_{2}\right) \cong \mathbb{Z}_{2}
$$

Proof. The top degree chain in $X_{n}$ is of the form $c=\sum C_{\omega} \times l_{\omega}$, where $C_{\omega}$ is a chamber of maximal dimension $n-1$ and $l_{\omega}$ is a chain in $F_{\omega}$ of maximal dimension $2 n-6$. Since $\operatorname{dim} F_{\sigma}<$ $\operatorname{dim} F_{\omega}$ for any $\sigma \in \omega$ and $F_{\sigma} \neq F$, it follows that $l_{\omega}=l_{\omega}^{F}$ is a chain in $F$. Using (12) we obtain that

$$
\partial_{3 n-8}^{\circ} c=\sum_{\omega} \sum_{\omega^{\prime} \subset \omega, C_{\omega^{\prime}} \subset \Delta_{n, 2}^{\circ}} C_{\omega^{\prime}} \times l_{\omega}^{F}+\sum_{\omega} C_{\omega} \times \partial_{2 n-7}^{\omega} l_{\omega}^{F}
$$

Note that the space of parameters of any chamber from the boundary of $\Delta_{n, 2}$ has the dimension less then $2 n-6$, which implies that $\partial_{3 n-8}^{\prime} c=0$. Thus, $c$ is a cycle if and only if the following conditions are satisfied:

1. $\partial_{2 n-7}^{\omega} l_{\omega}^{F}=0$ for any $\omega$;
2. $l_{\omega}^{F}=l^{F}$, that is $l_{\omega}$ does not depend on $\omega$ since any $C_{\omega}^{\prime}$ contributes twice in $\partial_{3 n-8} C$ as the chambers $C_{\omega}$ are of maximal dimension;
3. chambers $C_{\omega}$ which contribute to $c$ give all chambers in $\Delta_{n, 2}$ of dimension $n-1$.

It follows that $c=\left(\sum_{\omega} C_{\omega}\right) \times l^{F}$. We have that $\partial^{\mathcal{F}_{n}} l^{F} \subset \bar{F}$ as $\mathcal{F}_{n}$ is a wonderful compactification of $\bar{F}$. Since $\operatorname{dim} l^{F}=\operatorname{dim} F$ and $\operatorname{dim}(\bar{F} \backslash F)=\operatorname{dim} F-2$ it follows that $\partial^{\mathcal{F}_{n}} l^{F}=\partial^{F} l^{F}$. The fact that $F \subset F_{\omega}$ and $H_{2 n-6}\left(\mathcal{F}_{n}, \mathbb{Z}_{2}\right) \cong \mathbb{Z}_{2}$ concludes the proof.

We further omit an index $p$ in $\partial_{p} c$, as well as $\omega$ in $\partial^{\omega} l_{\omega}$ to simplify notation.

## $4.1 \mathbb{Z}_{2}$ - cycles over ${\stackrel{\circ}{\Delta_{n, 2}}}$

Theorem 4.4. Any $\mathbb{Z}_{2}$-cycle $c=\sum C_{\omega} \times l_{\omega}$ in $G_{n, 2} / T^{n}$ such that $\hat{\mu}(c) \subset \stackrel{\circ}{\Delta}_{n, 2}$ is homologous to a cycle which does not contain a summand for which either one of the following conditions is satisfied

1. $\operatorname{dim} C_{\omega}<n-1$;
2. $l_{\omega}^{F}$ is a chain in $F$ and $\operatorname{dim} l_{\omega}^{F}<\operatorname{dim} F$;
3. $l_{\omega}^{\sigma}$ is a chain in some $F_{\sigma}$ and $\operatorname{dim} l_{\omega}^{\sigma}<\operatorname{dim} F_{\sigma}$.

Proof. (1) Let $\operatorname{dim} C_{\omega}<n-1$ and consider such $C_{\omega}$ of lowest degree assuming it is not zero. Let $l_{\omega}=\sum_{\sigma \in \omega} l_{\omega}^{\sigma}$, and consider $\sigma \in \omega$ such that $l_{\omega}^{\sigma} \neq 0$ for $\operatorname{dim} P_{\sigma}=n-1$. Then $C_{\omega} \subset \stackrel{\circ}{P}_{\sigma}$ and there exists a facet $C_{\omega^{\prime}}$ of $C_{\omega}$ such that $C_{\omega^{\prime}} \subset \stackrel{\circ}{P}_{\sigma}$. It follows that it is defined $C_{\omega^{\prime}} \times l_{\omega}^{\sigma}$ and it is a summand in $\partial c=0$. So, there exists a chamber $C_{\tilde{\omega}} \subset \stackrel{\circ}{P}_{\sigma}$ such that $C_{\omega^{\prime}}$ is a facet of $C_{\tilde{\omega}}$ and $C_{\tilde{\omega}} \times l_{\omega}^{\sigma}$ is a summand in $c$. If $C_{\omega}$ is a point and by Remark $\left[5\right.$ we can assume that $l_{\omega}^{\sigma}$ is not a point, then there obviously exists an 1-dimensional chamber $C_{\tilde{\omega}} \subset \stackrel{\circ}{P}_{\sigma}$ such that $C_{\omega}$ is its vertex. Continuing for the other vertex of $C_{\tilde{\omega}}$ and so on we can achieve to obtain a chain $\sum C_{\tilde{\omega}}$ whose other vertex is from $P_{\sigma^{\prime}} \subset \stackrel{\Delta}{\Delta}, 2^{\circ}$ that is a facet of $P_{\sigma}$. Then $\partial\left(\sum C_{\tilde{\omega}} \times l_{\omega}^{\sigma}\right)=C_{\omega} \times l_{\omega}^{\sigma}+\sum C_{\tilde{\omega}} \times \partial l_{\omega}^{\sigma}$. So the lowest dimension of chambers in $c$ can be assumed to be $\geq 1$.

If we continue in this way we obtain that $c$ contains the chain $d_{\omega, \sigma}=c_{\omega, \sigma} \times l_{\omega}^{\sigma}$, where $c_{\omega, \sigma}=$ $\sum C_{\tilde{\omega}} \subset \stackrel{\circ}{P}_{\sigma}$ and $\partial c_{\omega, \sigma}=0$ either $\partial c_{\omega, \sigma} \subset \partial P_{\sigma}$. Thus, $c_{\omega, \sigma}^{\prime}=\partial c_{\omega, \sigma}$ is a cycle in $\partial P_{\sigma} \cong S^{n-2}$, while $\operatorname{dim}{c_{\omega, \sigma}^{\prime}}_{\prime}^{n} n-2$. It follows that there exist a chain $\tilde{c}_{\omega, \sigma}$ on $\partial P_{\sigma}$ such that $\partial \tilde{c}_{\omega, \sigma}=c_{\omega, \sigma}^{\prime}$. Thus, $c_{\omega, \sigma}+\tilde{c}_{\omega, \sigma}=\partial \hat{c}_{\omega, \sigma}$ for some chain $\hat{c}_{\omega, \sigma}$ in $P_{\sigma}$. For $c_{\omega, \sigma}$ being a cycle we have that $\tilde{c}_{\omega, \sigma}=0$. If $l_{\omega}^{\sigma} \neq 0$ only for $\operatorname{dim} P_{\sigma}=n-2$, then $l_{\omega}^{\sigma}$ is a point. For $\operatorname{dim} C_{\omega}<n-2$ the same argument can be applied. For $\operatorname{dim} C_{\omega}=n-2$ we obtain the chain $d_{\omega, \sigma}=\sum C_{\omega}$ which contains all chambers of dimension $n-2$ in $\stackrel{\circ}{P}_{\sigma}$ and $\partial d_{\omega, \sigma} \subset \partial P_{\sigma} \subset \partial \Delta_{n, 2} \simeq S^{n-2}$, where the last inclusion follows from the description of $P_{\sigma}$ given in Theorem [2.1] so the same argument applies.

If $\partial^{\prime} d_{\omega, \sigma} \neq 0$, then there exists $C_{\omega}^{\prime}$ in a facet $P_{\sigma^{\prime}}$ of $P_{\sigma}$ such that $C_{\omega}^{\prime} \times l_{\omega^{\prime}}^{\sigma^{\prime}}$, is contained in $\partial^{\prime} d_{\omega, \sigma}$. Thus, there exists summand $C_{\hat{\omega}} \times l_{\hat{\omega}}^{\hat{\sigma}}$ in $c$ which contains $C_{\omega}^{\prime} \times l_{\omega^{\prime}}^{\sigma^{\prime}}$ in its boundary. Repeating the same argument for $C_{\hat{\omega}} \times l_{\hat{\omega}}^{\hat{\sigma}}$ we obtain the chain $d_{\hat{\omega}, \hat{\sigma}}$ and the chains $\tilde{c}_{\hat{\omega}, \hat{\sigma}}, \hat{c}_{\hat{\omega}, \hat{\sigma}}$. Continuing this procedure for all non zero boundary summands for $d_{\omega, \sigma}$ and then the same for the chain $d_{\omega, \sigma}+$ $\sum_{\hat{\omega}, \hat{\sigma}} d_{\hat{\omega}, \hat{\sigma}}$ until we obtain a chain $d=\sum_{\omega, \sigma} d_{\omega, \sigma}$ such that $\partial^{\prime} d=0$.

Consider the chain $\hat{C}=\sum_{\omega, \sigma} \hat{c}_{\omega, \sigma}^{0} \times l_{\omega}^{\sigma}$, where $\hat{c}_{\omega, \sigma}^{0}$ means that we consider only those chambers from the chain $\hat{c}_{\omega, \sigma}$ which belong to $\stackrel{\circ}{P}_{\sigma}$. Then $\partial^{0} \hat{C}=d+\sum_{\omega, \sigma} \hat{c}_{\omega, \sigma} \times \partial l_{\omega}^{\sigma}$. Note also that $\partial^{\prime} \hat{\mathrm{C}}=0$ since in the second repeating step of the previous procedure we can always choose a chain $\tilde{c}_{\omega, \hat{\sigma}}$ such that in $P_{\sigma^{\prime}}$ it overlaps with $\tilde{c}_{\omega, \sigma}$.

Altogether we obtain that $\partial \hat{C}=d+\sum_{\omega, \sigma} \hat{C}_{\omega, \sigma} \times l_{\omega}^{\sigma}$, which means that $d$ is homologous to a chain whose chambers have dimension greater by one. In the case $\partial^{\prime} d_{\omega, \sigma}=0$ we note that the chain $\hat{c}_{\omega, \sigma}$ place the role of $\hat{C}$. Repeating this argument we prove the statement.
(2) Let us consider a cycle $c=\sum C_{\omega} \times l_{\omega}$, where $\operatorname{dim} C_{\omega}=n-1$. It follows from (12) that $\partial l_{\omega}=0$ for any $\omega$. If $l_{\omega}^{F} \neq 0$ then $c$ contains all $(n-1)$-dimensional chambers and $l_{\omega}^{F}=l^{F}$ for all $\omega$, that is $c$ contains the chain $d=\sum_{\omega} C_{\omega} \times l^{F}$.

Assume that $\operatorname{dim} l^{F}<\operatorname{dim} F$. By Theorem 4.1]we have that $l_{\omega}=\tilde{l}_{\omega}+\partial \bar{l}_{\omega}$, where $\tilde{l}_{\omega}$ is a chain of fundamental cycles determined by divisors. It follows that $l_{\omega}^{F} \subset \partial \bar{l}_{\omega}$. Now, $\bar{l}_{\omega}=\bar{l}_{\omega}^{F}+\sum_{\sigma} \bar{l}_{\omega}^{\sigma}$, so $\partial \bar{l}_{\omega}=\left(\partial \bar{t}_{\omega}^{F}\right)^{F}+\sum_{\sigma} \partial\left(\bar{l}_{\omega}^{F}\right)^{\sigma}+\partial\left(\sum_{\sigma} \bar{l}_{\omega}^{\sigma}\right)$. Thus, $l_{\omega}^{F}=\left(\partial \bar{l}_{\omega}^{F}\right)^{F}$.

For the chain $\bar{d}=\sum_{\omega} C_{\omega} \times \bar{l}_{\omega}^{F}$, we obtain that

$$
\partial \bar{d}=d+\sum_{\sigma \in \omega} C_{\omega} \times\left(\partial \bar{l}_{\omega}^{F}\right)^{\sigma}=d+\tilde{d},
$$

where the chain $\tilde{d}$ does not contain a summand from the main stratum. It follows that $c$ is homologous to the chain $c+d+\tilde{d}$ which does not contain a chain from the main stratum.
(3) We again consider a cycle $c=\sum C_{\omega} \times l_{\omega}, \operatorname{dim} C_{\omega}=n-1$, which implies that $\partial^{\omega} l_{\omega}=0$ for any $\omega$. Assume that there exists $l_{\omega}^{\sigma} \neq 0$ such that $\operatorname{dim} l_{\omega}^{\sigma}<\operatorname{dim} F_{\sigma}$ and consider such $\sigma_{0}$ for which $\operatorname{dim} F_{\sigma_{0}}$ is maximal among all $\omega$ 's. It follows that $l_{\omega}$ is a chain in $F_{\left.<\sigma_{0}\right\rangle}=\cup_{\sigma \in \omega} F_{\sigma}$, where $\operatorname{dim} F_{\sigma} \leq \operatorname{dim} F_{\left.<\sigma_{0}\right\rangle}$. Note that $F_{\left.<\sigma_{0}\right\rangle}$ is a compact space which is a compactification of all $F_{\sigma}, \sigma \in \omega$ and $\operatorname{dim} F_{\sigma}=\operatorname{dim} F_{<\sigma_{0}>}$. Since by [5] any $F_{\sigma}$ is homeomorphic to some $F_{m}$, it follows by Theorem4.1 that the homology groups of $F_{\left.<\sigma_{0}\right\rangle}$ are spanned by the fundamental cycles of contributing $F_{\sigma}$. Thus, $l_{\omega}=\tilde{l}_{\omega}+\partial \bar{l}_{\omega}$, where $\tilde{l}_{\omega}$ are a chain of the fundamental cycles spanning homology of $F_{<\sigma_{0}>}$ and $\bar{l}_{\omega}$ is a chain in $F_{<\sigma_{0}>}$. We deduce that $l_{\omega}^{\sigma_{0}} \subset \partial \bar{l}_{\omega}$, that is $l_{\omega}^{\sigma_{0}}=\left(\partial \bar{l}_{\omega}^{\sigma_{0}}\right)^{\sigma_{0}}$.

On the other hand, for the summand $C_{\omega} \times l_{\omega}^{\sigma_{0}}$ in the cycle $c$, there must exist a facet, so we obtain the chain $d_{\sigma_{0}}=\sum_{\omega} C_{\omega} \times l_{\omega}^{\sigma_{0}}$, where $C_{\omega}$ 's give all chambers of dimension $(n-1)$ in $P_{\sigma_{0}}$ and $l_{\omega}^{\sigma_{0}}$ does not depend on $\omega$, that is $d_{\sigma_{0}}=P_{\sigma_{0}, n-1} \times l_{\omega}^{\sigma_{0}}$.

For the chain $\bar{d}_{\sigma_{0}}=P_{\sigma_{0}, n-1} \times \bar{l}_{\omega}^{\sigma_{0}}$, we obtain that

$$
\partial \bar{d}_{\sigma_{0}}=d_{\sigma_{0}}+\sum_{\sigma \in \omega} C_{\omega} \times\left(\partial \bar{l}_{\omega}^{\sigma_{0}}\right)^{\sigma}+\sum_{C_{\bar{\omega}} \in P_{\bar{\sigma}_{0}}} C_{\bar{\omega}} \times \eta_{\sigma_{0}, \bar{\sigma}_{0}}^{\#}\left(\bar{l}_{\omega}^{\sigma_{0}}\right)=d_{\sigma_{0}}+d_{\sigma_{0}}^{\prime}+\bar{d}_{\sigma_{0}},
$$

Therefore $c$ is homologous to the chain $c+d_{\sigma_{0}}+d_{\sigma_{0}}^{\prime}+\bar{d}_{\sigma_{0}}$, which does not have a summand with a chain from $F_{\sigma_{0}}$. Moreover, if $l_{\omega}^{\sigma}$ contributes to $d_{\sigma_{0}}^{\prime}$ then $\operatorname{dim} F_{\sigma}<\operatorname{dim} F_{\sigma_{0}}$, while $\hat{\mu}\left(\bar{d}_{\sigma_{0}}\right) \subset \partial \Delta_{n, 2}$.

Note that $\partial d_{\sigma_{0}}=\sum_{\bar{\sigma}_{0}} P_{\overline{\sigma_{0}}, n-2} \times \eta_{\sigma_{0}, \bar{\sigma}_{0}}^{\#}\left(l_{\omega}^{\sigma_{0}}\right)$, where $P_{\bar{\sigma}, n-2} \subset \partial \Delta_{n, 2}$ is determined by a facet $P_{\bar{\sigma}}$ of $P_{\sigma}$. Since $\partial d_{\sigma_{0}} \subset \partial c=0$, it follows that for any $\overline{\sigma_{0}}$ there exists a chain $d_{\tilde{\sigma}}=P_{\tilde{\sigma}, n-1} \times l_{\tilde{\tilde{\omega}}}^{\tilde{\tilde{\sigma}}}$ where $\tilde{\omega}$ is arbitrary such that $C_{\tilde{\omega}} \subset P_{\tilde{\sigma}, n-1}, \operatorname{dim}\left(C_{\tilde{\omega}}\right)=n-1$, then $P_{\sigma_{0}}$ is a facet of $P_{\tilde{\sigma}}$ and $\partial^{\prime} d_{\tilde{\sigma}}=\partial^{\prime} d_{\sigma_{0}}$ on $P_{\bar{\sigma}_{0}}$. If continue in this way we obtain the cycle $d=\sum_{\sigma} d_{\sigma}$.

Note further the following: a facet $P_{\bar{\sigma}}$ belongs to some hypersimplex $\Delta_{n-1,2}$ on $\partial \Delta_{n, 2}$ as its space of parameters is not a point. Therefore, $P_{\bar{\sigma}}$ is the intersection of $P_{\sigma}$ and a hyperplane $x_{i}=0$ for some $i$. The stratum $W_{\bar{\sigma}}$ is a common boundary stratum for $W_{\sigma}$ and $W_{\tilde{\sigma}}$ and it is obtained from them by removing the $i$-th row from their matrix record. This gives that $F_{\sigma} \cong F_{\tilde{\sigma}}$. Therefore, we can take $l_{\omega}^{\sigma_{0}}=l_{\tilde{\omega}}^{\tilde{\sigma}}$ and $\bar{l}_{\omega}^{\sigma_{0}}=\bar{l}_{\tilde{\omega}}^{\widetilde{\sigma}}$, which implies that $\eta_{\sigma_{0}, \bar{\sigma}_{0}}^{\#}\left(\bar{l}_{\omega}^{\sigma_{0}^{0}}\right)=\eta_{\tilde{\sigma}_{0}, \bar{\sigma}_{0}}^{\#}\left(\bar{l}_{\tilde{\omega}}^{\widetilde{\sigma}}\right)$.

Consider the chain $\bar{d}=\sum_{\sigma} d_{\sigma}=\sum_{\sigma} P_{\sigma, n-1} \times \bar{l}_{\omega}^{\sigma}$. Then

$$
\begin{equation*}
\partial \bar{d}=d+\sum_{\sigma} \sum_{\bar{\sigma}} P_{\bar{\sigma}, n-2} \times \eta_{\sigma, \bar{\sigma}}^{\#}\left(\bar{l}_{\omega}^{\sigma}\right)=d . \tag{13}
\end{equation*}
$$

We emphasize that the proofs of the second and third statements in Theorem 4.4 imply :
Corollary 4.4.1. Any chain $c=\sum C_{\omega} \times l_{\omega}$ in $X_{n}$ such that $\operatorname{dim} C_{\omega}=n-1$ for any $\omega$ and $\partial^{0} c=0$ is homologous to a chain which does not contain a summand for which $l_{\omega}^{F} \neq 0$ and $\operatorname{dim} l_{\omega}^{F}<\operatorname{dim} F$.

Corollary 4.4.2. Any chain $c=\sum C_{\omega} \times l_{\omega}$ in $X_{n}$ such that $\operatorname{dim} C_{\omega}=n-1$ for any $\omega$ and $\partial^{0} c=0$ is homologous to a chain $c^{\prime}+c_{0}$, where $\hat{\mu}\left(c^{\prime}\right) \subset \partial \Delta_{n, 2}$ and $\hat{\mu}\left(c_{0}\right) \subset \dot{\Delta}_{n, 2}$ and $c_{0}$ does not contain a summand for which $l_{\omega}^{\sigma} \neq 0$ and $\operatorname{dim} l_{\omega}<\operatorname{dim} F_{\sigma}$.

Theorem4.4 leads to the following explicit result.
Corollary 4.4.3.

$$
H_{3 n-8}\left(X_{n}, \mathbb{Z}_{2}\right)=0
$$

Proof. The cycles of dimension $3 n-8$ are of the form $c=\sum_{\omega} C_{\omega} \times l_{\omega}$, where $\operatorname{dim} C_{\omega}=n-1$ and $l_{\omega}$ is a chain in $F_{\omega}$ and $\operatorname{dim} l_{\omega}=2 n-7$. Since $\operatorname{dim} F_{\sigma} \leq 2 n-6$ it follows that $l_{\omega}=l_{\omega}^{F}$ is a chain in $F$. As $\operatorname{dim} l_{\omega}^{F}<\operatorname{dim} F$ we deduce from Theorem 4.4 that $c$ is homologous to zero.

Using Theorem4.4 we deduce more explicit expressions for the cycles in $X_{n}$.
Corollary 4.4.4. Any cycle $c$ in $X_{n}$ such that $\hat{\mu}(c) \subset \stackrel{\circ}{n, 2}^{2}$ is homologous to

$$
c=\sum_{\sigma} P_{\sigma, n-1} \times l^{\sigma},
$$

where $P_{\sigma, n-1}$ is the union of the chambers of dimension $n-1$ from $\stackrel{\circ}{P}_{\sigma}$ of an admissible polytope $P_{\sigma}, \operatorname{dim} P_{\sigma}=n-1$ and $l^{\sigma}$ is a chain in $F_{\sigma}$ of maximal dimension $\operatorname{dim} F_{\sigma}$.
Proof. By Theorem4.4we can assume that $c=\sum C_{\omega} \times l_{\omega}^{\sigma}$, where $\operatorname{dim} C_{\omega}=n-1$ and $\operatorname{dim} l_{\omega}^{\sigma}=$ $\operatorname{dim} F_{\sigma}$. Then $C_{\omega} \subset \stackrel{\circ}{P}_{\sigma}$ for $\sigma \in \omega$ and since $\partial C_{\omega}$ has at least one facet $C_{\omega^{\prime}}$ which belongs to $\stackrel{\circ}{P}_{\sigma}$ we obtain the chain $P_{\sigma, n-1} \times l^{\sigma}$, where $l^{\sigma}=l_{\omega}^{\sigma}$. This chain contains all summands from $c$ of the form $C_{\omega} \times l_{\omega}^{\sigma}$. Repeating the argument with left summands in $c$, we prove the statement.

Remark 6. We further use notation $l^{\sigma}=F_{\sigma}$ since $\operatorname{dim} l^{\sigma}=\operatorname{dim} F_{\sigma}$.
The following result is in the line with the result of [6] for $n=5$.
Corollary 4.4.5. The group of cycles in $X_{n}$ of dimension $3 n-9$ has a basis of the from

$$
\begin{equation*}
K_{m i, n-1} \times F_{m i}+K_{m j, n-1} \times F_{m j}+K_{i j, n-1} \times F_{i j}, \tag{14}
\end{equation*}
$$

where $1 \leq m \leq n-2$ and $m+1 \leq i<j \leq n$ and $K_{i j}$ is an admissible polytope which does not contain just one vertex $\Lambda_{i j}$ of $\Delta_{n, 2}$, while $F_{i j}$ it the chain of maximal dimension in the space of parameters $F_{i j}$ of the corresponding stratum $W_{i j}$.
Proof. A cycle $c$ in $X_{n}$ of dimension $3 n-9$ maps by the induced moment map to ${\stackrel{\circ}{\Delta_{n, 2}}}$ since $\operatorname{dim} \hat{\mu}^{-1}\left(\partial \Delta_{n, 2}\right)=3 n-10$. Thus, by Corollary 4.4.4 it is of the form $c=\sum_{\sigma} P_{\sigma, n-1} \times l^{\sigma}$, where $\operatorname{dim} l^{\sigma}=2 n-8$. The only strata whose spaces of parameters are of this dimension are the strata whose admissible polytopes are $K_{i j}$. In addition, the spaces of parameters $F_{i j}$ are all homeomorphic to $F_{n-1}$, see [6]. There are two facets $K_{i j}(i)$ and $K_{i j}(j)$ of type $\Delta_{n-1,2}$ of $K_{i j}$ and they are given by $x_{i}=0$ and $x_{j}=0$ respectively. The strata corresponding to these facets are the main strata for $G_{n-1,2}(i)$ and $G_{n-1,2}(j)$ and they are in the boundary of the strata in $G_{n, 2}$ whose admissible polytope is $K_{i j}$. Therefore,

$$
\partial\left(K_{i j} \times F_{i j}\right)=K_{i j}(i) \times F_{i j}(i)+K_{i j}(j) \times F_{i j}(j)=S_{i}+S_{j},
$$

where $F_{i j}(i) \cong F_{i j}(j) \cong F_{i j}$ and $S_{i}$ and $S_{j}$ are chains of maximal dimension in $G_{n-1,2}(i) / T^{n-1}$ and $G_{n-1,2}(j) / T^{n-1}$ Therefore, $c=\sum_{1 \leq i<j \leq n} a_{i j}\left(K_{i j} \times F_{i j}\right)$ is a cycle if and only if

$$
\sum_{1 \leq i<j \leq n} a_{i j}\left(S_{i}+S_{j}\right)=0,
$$

Since $S_{i}, 1 \leq i \leq n$ are linearly independent, this is equivalent to

$$
\sum_{1 \leq j \leq n, j \neq i} a_{i j}=0, \quad 1 \leq i \leq n .
$$

The solution space is of dimension $\frac{(n-2)(n-1)}{2}$, that is the basis for the cycles is given by (14).

We formulate as well the following results, the first one is direct generalization of Corollary 4.4.4 while the second one is the direct generalization of the third statement in Theorem 4.4 and can be proved in the analogous way using the fact that the homology groups of any $F_{\omega}$ are evenly generated.
Corollary 4.4.6. Let $\mathcal{C}=\sum C_{\omega} \times l_{\omega}$ be a chain in $X_{n}$ such that $\operatorname{dim} C_{\omega}=n-1$ and $\partial^{0} c=0$. Then

$$
c=\sum_{\sigma} P_{\sigma, n-1} \times l^{\sigma}
$$

where $P_{\sigma, n-1}$ is the union of the chambers of dimension $n-1$ from $\stackrel{\circ}{P}_{\sigma}$ of an admissible polytope $P_{\sigma}, \operatorname{dim} P_{\sigma}=n-1$ and $l^{\sigma}$ is a chain in $F_{\sigma}$ of maximal dimension $\operatorname{dim} F_{\sigma}$.
Corollary 4.4.7. Let $c=\sum C_{\omega} \times l_{\omega}$ be a chain in $X_{n}$ such that $\operatorname{dim} C_{\omega}=n-1, \partial^{0} c=0$ and $\operatorname{dim} l_{\omega}$ is odd. Then $c$ is homologous to zero.

## $4.2 \mathbb{Z}_{2}$-chains over ${\stackrel{\circ}{\Delta_{n, 2}}}$ with boundary on $\partial \Delta_{n, 2}$

We first prove few preparatory statements by considering chains for which all contributing chambers have the same dimension.

Lemma 4.5. Let $c=\sum_{\omega} C_{\omega} \times l_{\omega}$ be a chain in $X_{n}$, such that the following is satisfied:

- all chambers $C_{\omega}$ which contribute to $c$ have the same dimension $p \leq n-2$,
- $\hat{\mu}(c) \subset \grave{\Delta}_{n, 2}$,
- $\partial c$ does not contain a chamber $C_{\omega^{\prime}} \subset \stackrel{\circ}{n}, 2$ of dimension $p-1$.

Let $([\omega], \sigma)$ denotes the set of all $\tilde{\omega}$ which contributes to $c$ such that $\sigma \in \tilde{\omega}$ and $l_{\omega}^{\sigma}=l_{\tilde{\omega}}^{\sigma}$. Then $c$ can be written in the form

$$
c=\sum_{([\omega], \sigma)} c_{([\omega], \sigma)} \text {, where } \hat{\mu}\left(\partial c_{([\omega], \sigma)}\right) \subset \partial P_{\sigma} .
$$

Proof. The boundary of the chain $c$ is given by $\partial c=\sum_{\omega} C_{\omega} \times \partial l_{\omega}+\bar{c}$, where all chambers which contribute to $\bar{c}$ have dimension $\leq p-1$. The third condition implies that $\hat{\mu}(\bar{c}) \subset \partial \Delta_{n, 2}$.

Let us fix a chamber $C_{\omega}$ in $c$ and an admissible polytope $P_{\sigma}$ such that $\sigma \in \omega$ and $C_{\omega} \in \stackrel{\circ}{P}_{\sigma}$ and $l_{\omega}^{\sigma} \neq 0$. There exists a facet $C_{\omega^{\prime}}$ of $C_{\omega}$ such that $C_{\omega^{\prime}} \subset \stackrel{\circ}{P}_{\sigma}$, so $C_{\omega^{\prime}} \times l_{\omega}^{\sigma}$ contributes to $\partial c$, so we obtain the chain

$$
c_{([\omega], \sigma)}=\left(\sum_{\tilde{\omega}} C_{\tilde{\omega}}\right) \times l_{\omega}^{\sigma},
$$

where $\sigma \in \tilde{\omega}$ and $l_{\tilde{\omega}}^{\sigma}=l_{\omega}^{\sigma}$ and it holds $\partial\left(\sum_{\tilde{\omega}} C_{\tilde{\omega}}\right) \subset \partial \stackrel{\circ}{P}_{\sigma}$.
For another choice of $\sigma \in \omega$ or a chamber $\omega$ we obtain another such chain.
Lemma 4.6. Let $c=\sum_{\omega} C_{\omega} \times l_{\omega}$ be a chain in $X_{n}$, such that the following is satisfied:

- all chambers $C_{\omega}$ which contributes to $c$ have the same dimension $p \leq n-2$,
- $\hat{\mu}(c) \subset \stackrel{\circ}{n, 2}$,
- $\partial c$ does not contain a a chamber $C_{\omega^{\prime}} \subset \stackrel{\circ}{\Delta} n, 2^{\text {of dimension } p-1 .}$

Then $c$ is homologous to a chain $c_{p+1}+c^{\prime}$ such that all chambers in $c_{p+1}$ have dimension $p+1$ and $\hat{\mu}\left(c^{\prime}\right) \subset \partial \Delta_{n, 2}$.

Proof. By Lemma 4.5 we have that $c$ is the sum of the chains $c_{([\omega], \sigma)}=C_{([\omega], \sigma)} \times l_{\omega}^{\sigma}$, where $C_{([\omega], \sigma)}=\sum C_{\tilde{\omega}}$, the sum goes over those $\tilde{\omega}$ such that $C_{\tilde{\omega}} \subset \stackrel{\circ}{P}_{\sigma}$ and $l_{\tilde{\omega}}^{\sigma}=l_{\omega}^{\sigma}$. It holds $\partial C_{([\omega], \sigma)} \subset$ $\partial P_{\sigma}$. For $\operatorname{dim}\left(P_{\sigma}\right)=n-1$, we have that $\partial C_{([\omega], \sigma)}$ is a cycle of dimension $p-1 \leq n-3$ on $S^{n-2}$, so there exists a chain $\tilde{C}_{([\omega], \sigma)}$ on $\partial P_{\sigma}$ such that $\partial \tilde{C}_{([\omega], \sigma)}=\partial C_{([\omega], \sigma)}$. We obtain the cycle $\tilde{C}_{([\omega], \sigma)}+C_{([\omega], \sigma)}$ in $P_{\sigma}$, so there exists a chain $\hat{C}_{([\omega], \sigma)}$ in $P_{\sigma}$ such that $\partial \hat{C}_{([\omega], \sigma)}=\tilde{C}_{([\omega], \sigma)}+$ $\mathrm{C}_{([\omega], \sigma)}$. Consider the chain $\hat{\mathrm{C}}_{([\omega], \sigma)}^{0}$ containing those chambers from $\hat{\mathrm{C}}_{([\omega], \sigma)}$ which belong to ${ }^{\circ}{ }_{\sigma}$. Let $\hat{d}_{([\omega], \sigma)}=\hat{C}_{([\omega], \sigma)}^{0} \times l_{\omega}^{\sigma}$. Then

$$
\partial \hat{d}_{([\omega], \sigma)}=c_{([\omega], \sigma)}+\tilde{C}_{([\omega], \sigma)}^{0} \times l_{\omega}^{\sigma}+\hat{C}_{[[\omega], \sigma)}^{0} \times \partial l_{\omega}^{\sigma},
$$

where $\tilde{C}_{([\omega], \sigma)}^{0}$ contains those chambers from $\tilde{C}_{([\omega], \sigma)}$ for which the product with $l_{\omega}^{\sigma}$ exists. Obviously, such chambers must belong to $\partial \Delta_{n, 2}$, that is the chain $\tilde{C}_{([\omega], \sigma)}^{0}$ belongs to $\partial \Delta_{n, 2}$. If $\operatorname{dim}\left(P_{\sigma}\right)=$ $n-2$ then $l_{\omega}^{\sigma}$ is a point and $\partial C_{([\omega], \sigma)} \subset \partial P_{\sigma} \subset \partial \Delta_{n, 2}$ by Theorem [2.1, so the previous argument can be applied.

It follows that

$$
c_{([\omega], \sigma)}=\partial \hat{d}_{([\omega], \sigma)}+\tilde{C}_{([\omega], \sigma)}^{0} \times l_{\omega}^{\sigma}+\hat{C}_{([\omega], \sigma)}^{0} \times \partial l_{\omega}^{\sigma},
$$

so $c$ can be written as

$$
c=\partial \sum \hat{d}_{([\omega], \sigma)}+\sum \tilde{C}_{([\omega], \sigma)}^{0} \times l_{\omega}^{\sigma}+\sum \hat{C}_{([\omega], \sigma)}^{0} \times \partial l_{\omega}^{\sigma}=\partial d+c^{\prime}+c_{p+1}
$$

where $\hat{\mu}\left(c^{\prime}\right) \subset \partial \Delta_{n, 2}$ and $\hat{\mu}\left(c_{p+1}\right) \subset \dot{\Delta}_{n, 2}$ and all chambers in $c_{p+1}$ have dimension $p+1$.

By successive application of Lemma 4.6 we obtain :
Proposition 4.7. Let $\mathcal{c}=\sum_{\omega} C_{\omega} \times l_{\omega}$ be a chain in $X_{n}$, such that the following is satisfied:

- all chambers $C_{\omega}$ which contributes to $c$ have the same dimension $p \leq n-2$,
- $\hat{\mu}(c) \subset \stackrel{\circ}{\Delta}, 2$ and $\partial^{0} c=0$.

Then $c$ is homologous to a chain $c_{n-1}+c^{\prime}$ such that all chambers in $c_{n-1}$ have dimension $n-1$ and $\hat{\mu}\left(c^{\prime}\right) \subset \partial \Delta_{n, 2}$.

A chain $c$ on $X_{n}$ can be written as $c=c_{0}+c_{1}$, where $\hat{\mu}\left(c_{0}\right) \subset \Delta_{n, 2}^{\circ}$ and $\hat{\mu}\left(c_{1}\right) \subset \partial \Delta_{n, 2}$.
Corollary 4.7.1. Let c be a chain in $X_{n}$, such that all chambers which contributes to $c_{0}$ have the same dimension $p \leq n-2$ and $\partial c$ does not contain a chamber $C_{\omega^{\prime}} \subset \AA_{n, 2}$ such that $\operatorname{dim} C_{\omega^{\prime}}=$ $p-1$. Then $c$ is homologous to a chain $c_{n-1}+c$ such that $\hat{\mu}\left(c^{\prime}\right) \subset \partial \Delta_{n, 2}$ and $c_{n-1}$ contains just chambers of dimension $n-1$.

Proposition 4.8. Let $c_{0} \subset \hat{\mu}^{-1}\left(\Delta_{n, 2}^{\circ}\right)$ be a chain, such that $\partial c_{0}$ does not contain a chamber $C_{\omega^{\prime}} \subset \dot{\Delta}_{n, 2}$ such that $\operatorname{dim} C_{\omega^{\prime}} \leq p-1$, for some $p \leq n-2$. Then $c_{0}$ is homologous to a chain $c_{\geq p+1}+c^{\prime}$ such that $\hat{\mu}\left(c^{\prime}\right) \subset \partial \Delta_{n, 2}$ and $c_{\geq p+1}$ contains just chambers of dimension $\geq p+1$.

Proof. Let $q \leq d$ be the lowest dimension of $C_{\omega}$ that contributes to $c_{0}$. We can write $c_{0}=$ $\sum_{q \leq i \leq n-1} c_{0}^{i}$, where all chambers from $c_{0}^{i}$ are of the dimension $i$. The chain $c_{0}^{q}$ satisfies conditions of Lemma 4.6 and it follows that $c_{0}^{q}=\tilde{c}_{0}^{q+1}+\bar{c}_{1}+\partial d$. Thus,

$$
c_{0}=\sum_{q+2 \leq i \leq n-1} c_{0}^{i}+c_{0}^{q+1}+\tilde{c}_{0}^{q+1}+\bar{c}_{1}+\partial d .
$$

By abuse of notation, we denote $\tilde{c}_{0}^{q+1}+c_{0}^{q+1}$ by $c_{0}^{q+1}$. It follows that $c_{0}^{q+1}$ satisfies the conditions of Lemma4.6. We prove the statement repeating the argument.

Corollary 4.8.1. Let $c=c_{0}+c_{1}$ be a chain in $X_{n}$, such that there exists a chamber in $c_{0}$ which has the dimension $\leq n-2$ and $\partial^{0} c=0$. Then $c$ is homologous to a chain $c_{n-1}+c^{\prime}$ such that $\hat{\mu}\left(c^{\prime}\right) \subset \partial \Delta_{n, 2}$ and all chambers in $c_{n-1}$ have dimension $n-1$.

Let $Y_{n}=\hat{\mu}^{-1}\left(\partial \Delta_{n, 2}\right)$. We now relate the homology groups of $X_{n}$ and $Y_{n}$ in some dimensions.
Theorem 4.9. $H_{k}\left(X_{n} ; \mathbb{Z}_{2}\right) \simeq H_{k}\left(Y_{n} ; \mathbb{Z}_{2}\right)$ for $k \leq n-3$.
Proof. A cycle $c$ in $X_{n}$ such that $\operatorname{dim} c \leq n-3$ is by Corollary 4.8.1 homologous to a cycle $c^{\prime}$ such that $\hat{\mu}\left(c^{\prime}\right) \subset \partial \Delta_{n, 2}$. In addition, if $c=\partial d$ then $\operatorname{dim} d \leq n-2$, so again by Corollary 4.8.1 we have that $d$ is homologous to a cycle $d^{\prime}$ such that $\hat{\mu}\left(d^{\prime}\right) \subset \bar{\partial} \Delta_{n, 2}$. Therefore, the homology groups in dimensions $\leq n-3$ of $X_{n}$ and $Y_{n}$ are isomorphic.

Remark 7. We demonstrate that Theorem 4.9 does not hold for $k=n-2$. Namely, any cycle of dimension $n-2$ is homologous to a cycle $c^{\prime}$ in $Y_{n}$. Consider the chain $c=\sum_{\forall \omega} C_{\omega}$ and $\operatorname{dim} C_{\omega}=$ $n-1$. Then $\partial c=\sum_{\forall C_{\omega} \in \partial \Delta_{n, 2}} C_{\omega}, \quad \operatorname{dim}\left(C_{\omega}\right)=n-2$. There is no $(n-1)$-dimensional chain $\tilde{c} \in$ $Y_{n}$ such that $\partial \tilde{c}=\partial c$. Such chain $\tilde{c}$ should contain the summand of the form $\tilde{c}=\sum_{\operatorname{dim} C_{\omega}=n-2}^{\forall C_{\omega} \in \partial \Delta_{n, 2}} C_{\omega} \times$ $l_{\omega}$, where $\operatorname{dim} l_{\omega}=1$. But for $C_{\omega}={\stackrel{\circ}{{ }_{n}}}$.1,1$\in \partial \tilde{c}$, we have that $F_{\omega}$ is a point so an 1-dimensional chain $\tilde{I}_{\omega}$ does not exist.

We extended the previous results for the cycles of dimensions $k=n-1$ and $k=n$.
Proposition 4.10. Let c be a cycle $c=\sum_{\omega} C_{\omega} \times l_{\omega}$ on $X_{n}$ such that $\operatorname{dim} c=n-1$ or $\operatorname{dim} c=n$. Then the cycle $c$ is homologous to the cycle $c^{\prime}$ such that $\hat{\mu}\left(c^{\prime}\right) \subset \partial \Delta_{n, 2}$.

Proof. Let us write a cycle $c$ as $c_{0}+c_{1}$ such that $\hat{\mu}\left(c_{0}\right) \subset \dot{\Delta}_{n, 2}$ and $\hat{\mu}\left(c_{1}\right) \subset \partial \Delta_{n, 2}$. Let $\operatorname{dim} c=$ $n-1$. If all chambers $C_{\omega}$ in $c_{0}$ have dimension $n-1$ then $c_{0}=\sum_{\omega} C_{\omega}$ is the sum of all chambers of the dimension $n-1$. It follows that $\partial c_{0}$ consists of all chambers of top dimension $n-2$ on $\partial \Delta_{n, 2}$. Since $\partial c_{0}=\partial c_{1}$ and $\Delta_{n-1,1} \in \partial c_{0}$ it follows that $\Delta_{n-1,1}$ should be a chamber in $\partial c_{1}$. Since the corresponding space of parameters for simplex $\Delta_{n-1,1}$ is a point, there does not exist a $(n-1)$ dimensional chain $\tilde{c} \in \partial \Delta_{n, 2}$ such that $\Delta_{n-1,1}$ contributes to $\partial \tilde{c}$. Thus, there should exist $C_{\omega}$ of dimension $\leq n-2$ contributing to $c_{0}$. Now, by Corollary 4.8.1 we have that $c$ is homologous to a cycle $c_{n-1}+c^{\prime}$, so the previous implies that $c_{n-1}=0$. For $\operatorname{dim} c=n$, by Corollary 4.8.1 we can assume that $c_{0}=\sum_{\omega} C_{\omega} \times l_{\omega}$ such that $\operatorname{dim} C_{\omega}=n-1$ for all $\omega$. Then $\operatorname{dim} l_{\omega}=1$, so Corollary 4.4.7 gives the $c_{0}$ is homologous to zero, which concludes the proof.

Theorem 4.11. $H_{n-1}\left(X_{n} ; \mathbb{Z}_{2}\right) \cong H_{n-1}\left(Y_{n} ; \mathbb{Z}_{2}\right)$ and $H_{n-2}\left(Y_{n} ; \mathbb{Z}_{2}\right) \cong \mathbb{Z}_{2} \oplus H_{n-2}\left(X_{n} ; \mathbb{Z}_{2}\right)$.
Proof. Let $c$ be a cycle in $Y_{n}$ of dimension $n-1$. If $\hat{c}$ is a chain in $X_{n}$ such that $\partial \hat{c}=c$ then $\hat{c}$ is by Corollary 4.8.1 homologous to a chain $\hat{c}_{n-1}+\hat{c}^{\prime}$. If $\hat{c}_{n-1} \neq 0$ then $\hat{c}_{n-1}=\sum C_{\omega} \times l_{\omega}$, where $\operatorname{dim} l_{\omega}=1$ and $\partial^{0} \hat{c}_{n-1}=0$. It follows from Corollary 4.4.7 that $\hat{c}_{n-1}$ is homologous to zero. Thus, $\hat{c}$ is homologous to a chain from $Y_{n}$. Let $\operatorname{dim} c=n-2$ and assume that $c$ contains a chamber of dimension $n-2$. Then $c$ contains the chain $d=\sum_{\forall C_{\omega}} C_{\omega}, C_{\omega} \subset \partial \Delta_{n, 2}$ and $\operatorname{dim} C_{\omega}=n-2$. Since $d=\partial \hat{d}, \hat{d}=\sum_{\forall C_{\omega}} C_{\omega}$, $\operatorname{dim} C_{\omega}=n-1$ it follows that $c$ is homologous in $X_{n}$ to a cycle $c^{\prime}$ from $\hat{\mu}^{-1}\left(\cup_{1 \leq m \leq n} \partial O_{m}\right)$ not containing chambers of dimension $n-2$. Using Remark 7 the second statement follows.

Proposition 4.12. Let $c$ be a chain on $X_{n}$ such that $\operatorname{dim} c=n-1+2 k+1$ where $\partial^{0} c=0$ and $1 \leq k<n-3$. Then the chain $c$ is homologous to a chain $c^{\prime}$ such that $\hat{\mu}\left(c^{\prime}\right) \subset \partial \Delta_{n, 2}$.

Proof. Let $c=c_{0}+c_{1}$, where $\hat{\mu}\left(c_{0}\right) \subset \stackrel{\circ}{\Delta n}_{n, 2}$ and $\hat{\mu}\left(c_{1}\right) \subset \partial \Delta_{n, 2}$. The chain $c_{0}$ cannot be a cycle, since by Corollary 4.4.4 all chambers $C_{\omega}$ must be of the dimension $n-1$ and the dimension of $l_{\omega}$ has to be even. Since $\partial^{0} c_{0}=0$, by Corollary 4.8.1 we can write $c_{0}=c_{n-1}+c^{\prime}$ where $c^{\prime} \in$ $\hat{\mu}^{-1}\left(\partial \Delta_{n, 2}\right)$ and $c_{n-1}=\sum C_{\omega} \times l_{\omega}, \operatorname{dim}\left(C_{\omega}\right)=n-1$. It follows that $\partial^{0} c_{n-1}=0$ and $\operatorname{dim}\left(l_{\omega}\right)=$ $2 k+1$ for any $\omega$. By Corollary 4.4.7 we have that the chain $c_{n-1}$ is homologous to zero.

Proposition 4.13. Let c be a cycle on $X_{n}$ of the dimension $\operatorname{dim} c=n-1+2 k, 1 \leq k \leq n-3$. Then $c$ is homologous to a cycle $c^{\prime}$ of the form

$$
c^{\prime}=c_{0}^{\prime}+c_{1}^{\prime} \text {, where } c_{0}^{\prime} \text { and } c_{1}^{\prime} \text { are cycles }
$$

such that $c_{0}^{\prime} \in \hat{\mu}^{-1}\left(\Delta_{n, 2}^{\circ}\right)$ and $c_{1}^{\prime} \in \hat{\mu}^{-1}\left(\partial \Delta_{n, 2}\right)$.
For the proof we will make us of the following result.
Lemma 4.14. Let $C_{\omega} \subset \stackrel{\circ}{\Delta}_{n, 2}$ and $C_{\bar{\omega}}$ a facet of $C_{\omega}$ such that $C_{\bar{\omega}} \subset \Delta_{n-1,2}(i)$ for some $1 \leq i \leq n$. Then $F_{\omega} \backslash F$ is homeomorphic to $F_{\bar{\omega}}$.

Proof. We first note that for any $P_{\bar{\sigma}} \subset \partial \Delta_{n, 2}, \operatorname{dim} P_{\bar{\sigma}}=n-2$, there exists $P_{\sigma} \neq \Delta_{n, 2}$ such that $P_{\bar{\sigma}}$ is a facet of $P_{\sigma}$. Now, the chamber $C_{\omega}$ must belong to some halfspace $x_{i}+x_{j}<1,1 \leq j \leq$ $n, j \neq i$. Otherwise, $C_{\omega}$ would belong to all halfspaces $x_{i}+x_{j} \geq 1$ for $1 \leq j \leq n, j \neq i$. If $C_{\omega} \subset \stackrel{\circ}{P}_{\sigma} \neq \Delta_{n, 2}$ then Plücker coordinates $P^{k l}=0$ on the stratum $W_{\sigma}$ for all $1 \leq k<l \leq n$, $k, l \neq i$, so $P_{\sigma} \subset \Delta_{n-1,1}(i) \subset \partial \Delta_{n, 2}$, which is not the case.

Let $C_{\omega}$ belongs to a halfspace $x_{i}+x_{j}<1$. If $C_{\omega} \subset \stackrel{\circ}{P}_{\sigma} \neq \stackrel{\circ}{\Delta}_{n, 2}$, then $P^{i j}=0$ on the stratum $W_{\sigma}$. In addition $W_{\sigma}$ belongs to a chart $M_{j l}$, otherwise $P^{j l}=0$ for all $j \neq l$, so $P_{\sigma} \subset \partial \Delta_{n, 2}$. Let us take $j=1, i=3, l=2$. In the chart $M_{12}$ the stratum $W_{\sigma}$ is represented by the matrix

$$
\left(\begin{array}{cccccc}
1 & 0 & b_{3} & a_{4} & \ldots & a_{n}  \tag{15}\\
0 & 1 & 0 & b_{4} & \ldots & b_{n},
\end{array}\right)
$$

which implies $F_{\sigma} \cong F_{\bar{\sigma}}$, where $P_{\bar{\sigma}} \subset \partial \Delta_{n-1,2}(i)$ is a facet of $P_{\sigma}$. This proves the statement.
Proof. (Proposition4.13) Let $c=c_{0}+c_{1}+c_{2}$, where $\hat{\mu}\left(c_{0}\right) \subset{ }_{\Delta_{n, 2}}, \hat{\mu}\left(c_{1}\right) \subset \bigcup_{1 \leq m \leq n}{\stackrel{\circ}{\Delta_{n-1,2}}}(m)$ and $\hat{\mu}\left(c_{2}\right) \subset \bigcup_{1 \leq m \leq n} \partial \Delta_{n-1,2}(m)$. By Corollary 4.8.1 the chain $c_{0}$ is homologous to a chain $c_{n-1}+c^{\prime}$, that is we can write $c=c_{0}^{n-1}+c_{1}+c_{2}$.

Assume that $c_{0}^{n-1}=\sum C_{\omega} \times l_{\omega}$ is not a cycle. It implies that $\partial c_{0}^{n-1}=\sum C_{\bar{\omega}} \times \eta_{\omega, \bar{\omega}}^{\#}\left(l_{\omega}\right) \neq 0$, so $\operatorname{dim} l_{\omega} \leq 2 n-8$.

By Proposition 4.8, the chain $c_{1}$ contains only chambers of dimension $n-2$, since it can be written as

$$
\begin{equation*}
c_{1}=\sum_{1 \leq m \leq n} c_{1}^{m} \tag{16}
\end{equation*}
$$

where $c_{1}^{m} \subset \hat{\mu}^{-1}\left({\stackrel{\circ}{\Delta_{n-1,2}}}(m)\right)$ and $\partial c_{1}^{m}$ does not contain chambers of dimension $\leq n-3$.
Thus, $c_{1}=c_{1}^{n-2}=\sum C_{\bar{\omega}} \times l_{\bar{\omega}}$. Obviously, $\partial c_{0}^{n-1} \subset \partial c_{1}^{n-2}$. If there would exist $C_{\bar{\omega}} \times l_{\bar{\omega}}$ in $c_{1}^{n-2}$ such that $C_{\bar{\omega}} \times \partial^{\bar{\omega}} l_{\bar{\omega}}$ does not belong to $\partial c_{0}^{n-1}$, we would have that $\partial^{\bar{\omega}} l_{\bar{\omega}}=0$. Since $l_{\bar{\omega}}$ is of odd degree we have $l_{\bar{\omega}}=\partial{ }_{\bar{\omega}} \tilde{l}_{\bar{\omega}}$. Then $\partial\left(C_{\bar{\omega}} \times \tilde{l}_{\bar{\omega}}\right)=C_{\bar{\omega}} \times l_{\bar{\omega}}+c_{\bar{\omega}, n-3}$, where the second chain contains only the chambers of dimension $n-3$. Again using Proposition 4.8, $c_{1}^{n-2}$ is homologous to a chain for which it does not contain such chambers and it holds $\eta_{\omega, \bar{\omega}}^{\#}\left(l_{\omega}\right)=\partial^{\bar{\omega}} l_{\bar{\omega}}$.

By Lemma. 44 we deduce that $\left(\eta_{\omega, \bar{\omega}}^{\#}\right)^{-1}\left(l_{\bar{\omega}}\right)=l_{\bar{\omega}}$ and $l_{\omega}=\partial^{\bar{\omega}} l_{\bar{\omega}}=\partial^{\omega} l_{\bar{\omega}}$.
For the chain $\bar{d}=\sum C_{\omega} \times l_{\bar{\omega}}$ we have $\partial \bar{d}=\sum C_{\omega} \times \partial^{\omega} l_{\bar{\omega}}+\sum C_{\omega^{\prime}} \times l_{\bar{\omega}^{\prime}}+\sum C_{\bar{\omega}} \times l_{\bar{\omega}}=$ $c_{0}^{n-1}+c_{0}^{n-2}+c_{1}^{n-2}$. We can write $c=c_{0}^{n-2}+c_{2}^{\leq n-3}$, where all chambers in the second summand are belong to $\bigcup_{1 \leq m \leq n} \partial \Delta_{n-1,2}(m)$ and are of dimension $\leq n-3$.

We write $c_{2}^{\leq n-3}=c_{2}+c_{3}+c_{4}$, where $c_{2}$ is the chain from the union of all ${\stackrel{\circ}{\Delta_{n-3,2}}}(i j)$, the chain $c_{3}$ is from the union of all ${\stackrel{\circ}{\Delta_{n-3,2}}}(i j k)$ and $c_{4}$ is the rest. The claims that $c_{2}$ contains only chambers of dimension $n-3$ and $c_{3}$ contains only chambers of $n-4$ follow in the same way as for $c_{1}$. We denote them by $c_{2}^{n-3}=\sum C_{\omega} \times l_{\omega}$ and $c_{3}^{n-4}=\sum C_{\hat{\omega}} \times l_{\hat{\omega}}$ resp. Then :

$$
\partial c_{2}^{n-3}=\partial c_{0}^{n-2}+\sum C_{\hat{\omega}} \times l_{\hat{\omega}}, \quad \partial c_{3}^{n-4}=\sum C_{\hat{\omega}} \times \partial l_{\hat{\omega}}+\tilde{c}_{4}^{n-5}
$$

where $\tilde{c}_{4}^{n-5}$ is a chain of dimension $n-5$. It follows that $\sum C_{\hat{\omega}} \times l_{\hat{\omega}}=\sum C_{\hat{\omega}} \times \partial l_{\hat{\omega}}$, so $C_{\bar{\omega}}=C_{\hat{\omega}}$ and $l_{\omega}=\partial \hat{l}_{\bar{\omega}}$. We consider the chain:

$$
\tilde{c}_{2}^{n-3}=\sum C_{\omega} \times \hat{l}_{\bar{\omega}} .
$$

It holds:

$$
\begin{aligned}
\partial \tilde{c}_{2}^{n-3} & =\sum C_{\omega} \times \partial \hat{l}_{\bar{\omega}}+\sum C_{\bar{\omega}} \times \hat{l}_{\bar{\omega}}+\sum C_{\omega}^{\prime} \times \hat{l}_{\bar{\omega}}^{\prime}= \\
& =c_{2}^{n-3}+c_{3}^{n-4}+\tilde{c}_{2}^{n-4}
\end{aligned}
$$

where $\tilde{c}_{2}^{n-4}$ is a chain whose chambers are of dimension $n-4$ and from the union of ${\stackrel{\circ}{\Delta_{n-3,2}}}(i j)$. We obtain that the cycle $c=c_{0}^{n-2}+c_{2}^{n-3}+c_{3}^{n-4}+c_{4}$ is homologous to:

$$
\begin{equation*}
c^{\prime}=c_{0}^{n-2}+\tilde{c}_{2}^{n-4}+c^{\leq n-5}, \tag{17}
\end{equation*}
$$

where a chain $c^{\leq n-5} \subset \hat{\mu}^{-1}\left(\partial \Delta_{n, 2}\right)$ contains chambers of dimension $\leq n-5$. We conclude the proof if we set $c_{0}^{\prime}=c_{0}^{n-2}$.

Corollary 4.14.1. Let c be a cycle of dimension $q$ in $Y_{n} \subset X_{n}$.

- If $q=n-2+2 k+1, k \geq 0$ or $q \leq n-2$, then $c$ is homologous to a cycle from $\hat{\mu}^{-1}\left(\bigcup_{1 \leq m \leq n} \partial \Delta_{n-1,2}(m)\right)$.
- If $q=n-2+2 k, k \geq 1$ then $c$ is homologous to a cycle $c^{\prime}$ of the following form:

$$
c^{\prime}=\sum_{1 \leq m \leq n} c^{m}+c_{2}, \text { for } c^{m} \in \hat{\mu}^{-1}\left(\stackrel{\circ}{\Delta}_{n-1,2}(m)\right) \text { and } c_{2} \in \hat{\mu}^{-1}\left(\bigcup_{1 \leq m \leq n} \partial \Delta_{n-1,2}(m)\right),
$$

where:

$$
c^{m}=\sum_{\sigma_{m}} \stackrel{\circ}{P}_{\sigma_{m}, n-2} \times l^{\sigma_{m}}, \text { where } \operatorname{dim}\left(l_{\sigma_{m}}^{n-2}\right)=\operatorname{dim}\left(F_{\sigma}^{m}\right) \text { and } \stackrel{\circ}{P}_{\sigma_{m}, n-2} \subset \stackrel{\circ}{\Delta}_{n-1,2}(m) \text {. }
$$

Proof. Assume first that $q \neq n-2$. Then

$$
c=\sum_{1 \leq m \leq n} c^{m}+c_{2}, \text { where } c^{m} \subset \hat{\mu}^{-1}\left({\stackrel{\circ}{\Delta_{n-1,2}}}(m)\right) \text { and } c_{2} \subset \hat{\mu}^{-1}\left(\bigcup_{1 \leq m \leq n} \partial \Delta_{n-1,2}(m)\right)
$$

By Corollary 4.8.1 we can assume that $c^{m}$ contains only chambers of the dimension $n-2$.
Obviously for $q \leq n-3$ the statement follows. Let $q=n-2+2 k+1, k \geq 0$, so the dimension of $l_{\omega}$ is odd. By Corollary 4.4.7 a chain $c^{m}$ is homologous to a chain from $\hat{\mu}^{-1}\left(\partial \Delta_{n-1,2}(m)\right)$.

Let $q=n-2+2 k, k \geq 1$. If $c^{m}$ is cycle then by Theorem4.13 it is of the form:

$$
\sum_{\sigma_{m}} \stackrel{\circ}{P}_{\sigma_{m}, n-2} \times l_{\sigma_{m}}^{n-2}
$$

with the desired properties. If $c^{m}$ is not a cycle, then by Corollary 4.4 .6 the statement follows. Finally, we consider the case $q=n-2$. We can write $c$ as

$$
c=\sum_{1 \leq m \leq n} c^{m}+c_{1}+c_{2}, \text { where } c_{1} \in \hat{\mu}^{-1}\left(\bigcup_{1 \leq m \leq n} \Delta_{n-1,1}(m)\right)
$$

and $c_{2}$ and $c^{m}$ are as in the first case. If some $c^{m} \neq 0$, it follows that

$$
c^{m}=\sum_{\forall C_{\omega}} C_{\omega}, \quad \operatorname{dim}\left(C_{\omega}\right)=n-2 .
$$

Since a simplex $\Delta_{n-2,1}(m r) \subset \partial c^{m}, 1 \leq r, m \leq n$ and $r \neq m$ cannot be canceled by some boundary of $(n-2)$-dimensional chain from $c_{2}$, it follows that the chain $\tilde{c}_{1}=\sum_{\forall s \neq m} C_{s}$, where $C_{s}$ is a $(n-2)$-dimensional chamber of the simplex $\Delta_{n-1,1}(s)$ satisfies $\tilde{c_{1}} \subset c_{1}$. Similarly, any boundary $C_{s l} l \neq m$ of $C_{s}$ can only be canceled by the boundary of chain

$$
c^{l}=\sum_{\forall C_{\omega}} C_{\omega}, \quad \operatorname{dim}\left(C_{\omega}\right)=n-2
$$

We get the cycle

$$
d=\sum_{\forall C_{\omega} \in \partial \Delta_{n, 2}} C_{\omega}, \quad \operatorname{dim}\left(C_{\omega}\right)=n-2
$$

in $c$. But the cycle $d$ is homologous to zero on $X_{n}$.

## $5 \mathbb{Z}_{2}$-homology groups of $X_{5}$

The integral homology groups of $X_{5}$ are calculated both in [6] using the stratification of $X_{5}$ given by (1) and in [19] using Geometric invariant theory. We present here the calculations for $\mathbb{Z}_{2}$-homology of $X_{5}$ in different way, applying the model from Theorem 2.10 the existence of diffeomorphisam between $\mathcal{M}_{0,5}$ and the universal space of parameters $\mathcal{F}_{5}$ and relaying on the homology of $\mathcal{M}_{0,5}$ from [16].

By Lemma 4.3 and Corollary 4.4.3, $\mathbb{Z}_{2}$-homology groups in dimensions 8 and 7 are given by

$$
H_{8}\left(X_{5} ; \mathbb{Z}_{2}\right) \simeq \mathbb{Z}_{2}, \quad H_{7}\left(X_{5} ; \mathbb{Z}_{2}\right) \simeq 0
$$

Let $c=\sum C_{\omega} \times l_{\omega}$ be a cycle on $X_{5}$ of the dimension $k, 0 \leq k \leq 4$. By Proposition 4.10 and Theorem 4.9 we have that $c$ is homologous to a cycle from $Y_{5}$. Then Corollary 4.14.1 gives that $c$ is homologous to a cycle from $\hat{\mu}^{-1}\left(\bigcup_{1 \leq m \leq 5} \partial \Delta_{4,2}(m)\right)$. For $k=3$ or $k=4$ it holds $\operatorname{dim}\left(l_{\omega}\right) \geq 1$ and since the space of parameters of $\partial \Delta_{4,2}(m)$ is a point, it follows

$$
H_{k}\left(X_{5} ; \mathbb{Z}_{2}\right) \simeq 0 \text { for } k=3,4
$$

For $k \leq 2$, we have $c=\sum C_{\omega}$. But $\partial c \subset \partial \Delta_{5,2} \simeq S^{3}$, so

$$
H_{k}\left(X_{5} ; \mathbb{Z}_{2}\right) \simeq 0 \quad \text { for } 1 \leq k \leq 2, \quad H_{0}\left(X_{5} ; \mathbb{Z}_{2}\right) \simeq \mathbb{Z}_{2}
$$

We recall the description of an admissible polytopes, the spaces of parameters and the virtual spaces of parameters for $X_{5}$ from [6]. An admissible polytopes for $X_{5}$ are:

- 4-dimensional
- $\Delta_{5,2}$
- $K_{i j}$ or $K_{i j}(9):\left\{\mathbf{x} \in \Delta_{5,2} \mid x_{i}+x_{j} \leq 1\right\}$
- $\underline{K}_{r p q}$ or $K_{i j}(7): \quad\left\{\mathbf{x} \in \Delta_{5,2} \mid x_{i}+x_{j} \geq 1\right\}=\left\{\mathbf{x} \in \Delta_{5,2} \mid x_{r}+x_{p}+x_{q} \leq 1\right\}$, where $\overline{i j}=\{1, \ldots, 5\} \backslash r p q$
$-K_{i j, p q}:=\left\{\mathbf{x} \in \Delta_{5,2} \mid x_{i}+x_{j} \leq 1, x_{p}+x_{q} \leq 1,\{i, j\} \cap\{p, q\}=\varnothing\right\}$
- 3-dimensional

$$
-O_{i}:\left\{\mathbf{x} \in \Delta_{5,2} \mid x_{i}=0\right\}, P_{i j}:\left\{\mathbf{x} \in \Delta_{5,2} \mid x_{i}+x_{j}=1\right\}, T_{i}:\left\{\mathbf{x} \in \Delta_{5,2} \mid x_{i}=1\right\}
$$

According to (4) in Section 2
Corollary 5.0.1. The space of parameters $F_{5}$ of the main stratum $W$ is homeomorphic to

$$
\left\{\left(\left(c_{12}: c_{12}^{\prime}\right),\left(c_{13}: c_{13}^{\prime}\right),\left(c_{23}: c_{23}^{\prime}\right)\right) \in \mathbb{C} P_{A}^{1} \times \mathbb{C} P_{A}^{1} \times \mathbb{C} P_{A}^{1} \mid c_{12}^{\prime} c_{13} c_{23}^{\prime}=c_{12} c_{13}^{\prime} c_{23}\right\}
$$

Theorem 2.3 for $n=5$ gives, see also [6]
Corollary 5.0.2. The universal space of parameters $\mathcal{F}_{5}$ for $G_{5,2}$ is defined as the blowup of $\bar{F}$ at the point $((1: 1),(1: 1),(1: 1))$.

The virtual spaces of parameters are collected, see also Chapter 11 in [6], as follows:

Corollary 5.0.3. For admissible polytopes $P_{\sigma}$ mentioned above the spaces of parameters $F_{\sigma}$ and virtual spaces of parameters $\tilde{F}_{\sigma}$ are:

1. $P_{\sigma}=\Delta_{5,2} \Rightarrow F_{\sigma} \simeq \tilde{F}_{\sigma} \simeq F ; \quad P_{\sigma}=K_{i j} \Rightarrow F_{\sigma} \simeq \tilde{F}_{\sigma} \simeq \mathbb{C} P_{A}^{1}$,
2. $P_{\sigma}=O_{i} \Rightarrow F_{\sigma} \simeq \mathbb{C} P_{A}^{1}$ and $\tilde{F}_{\sigma} \simeq\left(\mathbb{C} P_{A}^{1} \times \mathbb{C} P^{1} \times \mathbb{C} P^{1}\right) \cap \mathcal{F}_{5}$;
3. $P_{\sigma}=K_{i j, p q} \Rightarrow F_{\sigma}=\tilde{F}_{\sigma}$ is a point; $P_{\sigma}=K_{i j k} \Rightarrow F_{\sigma}$ is a point and $\tilde{F}_{\sigma} \simeq \mathbb{C} P^{1}$;
4. for others $P_{\sigma} \Rightarrow F_{\sigma}$ is a point and $\tilde{F}_{\sigma}$ is not a point.

Following notation above of $P_{\sigma}$ by $K_{J}$ we further denote $F_{\sigma}$ and $\tilde{F}_{\sigma}$ by $F_{J}$ and $\tilde{F}_{J}$ as well.

## 5.1 $H_{6}\left(X_{5} ; \mathbb{Z}_{2}\right)$ and $H_{5}\left(X_{5} ; \mathbb{Z}_{2}\right)$

We want to write relations (10) in the terms of the virtual spaces of parameters for $X_{5}$.
Lemma 5.1. The homology group $H_{2}\left(\mathcal{F}_{5}\right)$ is generated by the classes determined by the virtual spaces of parameters $\tilde{F}_{i j}$ and the following relations hold:

$$
\begin{equation*}
\tilde{F}_{i j}+\tilde{F}_{\overline{p q}}=\tilde{F}_{i p}+\tilde{F}_{\overline{j q}}=\tilde{F}_{\overline{i q}}+\tilde{F}_{\overline{j p}} \tag{18}
\end{equation*}
$$

for every distinct $\{i, j, p, q\} \subset\{1, \ldots, 5\}$, where $\overline{i j}=\{1, \ldots, 5\} \backslash\{i, j\}$
Proof. We demonstrate the proof for the particular indices $\{1,3,4,5\}$. Let us fix the chart $M_{12}$ and use the map $\tilde{f}: \mathcal{M}_{0,5} \rightarrow \mathcal{F}_{5}$ from Example 4 We need to find the image by $\tilde{f}$ of a divisor $D_{I}$ from (10). For example, the element $D_{12}$ maps to $\left\{\left(\left(c: c^{\prime}\right),\left(c: c^{\prime}\right),(1: 1)\right)\right\}$. We need to find a stratum $W_{\sigma}$ for which this is virtual space of parameters in $M_{12}$. By (3) such stratum $W_{\sigma}$ satisfies $c^{\prime} a_{1} b_{2}=c b_{1} a_{2}, c^{\prime} a_{1} b_{3}=c b_{1} a_{3}, a_{2} b_{3}=b_{2} a_{3}$, where $\left(c: c^{\prime}\right) \in \mathbb{C} P^{1}$. It follows that $P^{45}=(1: 1)$ for the points from $W_{\sigma}$. The virtual space of parameters $\tilde{F}_{123}$ is, in the chart $M_{14}$, written as $(1: 0) \times(1: 0) \times \mathbb{C} P^{1}$. Using the homeomorphism $\tilde{f}_{12,14}^{-1}$, defined in Theorem 2.3, we obtain the record $\tilde{F}_{123}$ in the chart $M_{12}$ to be $\left\{\left(\left(c: c^{\prime}\right),\left(c: c^{\prime}\right),(1: 1)\right)\right\}$. This proves that $\tilde{f}\left(D_{12}\right)$ maps to $\tilde{F}_{123}$.

The divisor $D_{124}$ maps to the exceptional set $\left.\left\{((1: 1),(1: 1),(1: 1)),\left(c: c^{\prime}\right)\right)\right\}$. We need to find the corresponding stratum $W_{\sigma}$ that is defined by $P^{34}=P^{35}=P^{45}=0$. If we write down the stratum whose admissible polytope is $K_{12}(7)=K_{345}$, in the chart $M_{13}$ we obtain that its coordinates are $a_{1}, a_{2}=a_{3}=0, b_{1}, b_{2}, b_{3}$. Therefore, we have that $\tilde{F}_{345} \simeq(1: 0) \times(1: 0) \times \mathbb{C} P^{1} \simeq \mathbb{C} P^{1}$ in the chart $M_{13}$. Using the homeomorphism $\tilde{f}_{12,13}: \mathcal{F}_{12} \rightarrow \mathcal{F}_{13}$, defined in Theorem [2.3] we deduce that $D_{124}$ maps to $\tilde{F}_{345} \simeq \mathbb{C} P^{1}$. Similarly, we proceed in other cases and obtain:

$$
\begin{align*}
D_{12} & \rightarrow\left\{\left(\left(c: c^{\prime}\right),\left(c: c^{\prime}\right),(1: 1)\right)\right\} \simeq \tilde{F}_{\overline{45}} \quad D_{23} \rightarrow\left\{\left(\left(c: c^{\prime}\right),(0: 1),(0: 1)\right)\right\} \simeq \tilde{F}_{\overline{15}} \\
D_{13} \rightarrow\left\{\left((0: 1),\left(c: c^{\prime}\right),(1: 0)\right)\right\} \simeq \tilde{F}_{\overline{14}} & D_{24} \rightarrow\left\{\left(\left(c: c^{\prime}\right),(1: 1),\left(c^{\prime}: c\right),\right)\right\} \simeq \tilde{F}_{\overline{35}} \\
D_{14} \rightarrow\left\{\left((1: 1),\left(c: c^{\prime}\right),\left(c: c^{\prime}\right)\right)\right\} \simeq \tilde{F}_{\overline{34}} & D_{25} \rightarrow\left\{\left(\left(c: c^{\prime}\right),(1: 0),(1: 0)\right)\right\} \simeq \tilde{F}_{\overline{25}} \\
D_{15} \rightarrow\left\{\left((1: 0),\left(c: c^{\prime}\right),(0: 1)\right)\right\} \simeq \tilde{F}_{24} & D_{125} \rightarrow\left\{\left((1: 0),(1: 0),\left(c: c^{\prime}\right)\right)\right\} \simeq \tilde{F}_{\overline{13}} \\
D_{123} \rightarrow\left\{\left((0: 1),(0: 1),\left(c: c^{\prime}\right)\right)\right\} \simeq \tilde{F}_{\overline{23}} & D_{124} \rightarrow\left\{((1: 1),(1: 1),(1: 1)),\left(c: c^{\prime}\right)\right\} \simeq \tilde{F}_{\overline{12}} \tag{19}
\end{align*}
$$

where $\left(c: c^{\prime}\right) \in \mathbb{C} P^{1}$. Finally, using relations (10) we get that in $H_{2}\left(\mathcal{F}_{5}\right)$ for indices $\{1,3,4,5\}$ it holds:

$$
\tilde{F}_{\overline{45}}+\tilde{F}_{\overline{13}}=\tilde{F}_{\overline{14}}+\tilde{F}_{\overline{35}}=\tilde{F}_{\overline{15}}+\tilde{F}_{\overline{34}} .
$$

We first consider the chamber $C_{\omega_{0}}$ defined by the intersections of all admissible polytopes $\stackrel{\circ}{K}_{i j}$. The union

$$
\mathcal{F}_{\omega_{0}}=\bigcup_{C_{\omega_{0}} \in P_{\sigma}} \tilde{F}_{\sigma}
$$

represents a subdivision of the space $\mathcal{F}_{5}$. We can express this union as:

$$
\mathcal{F}_{\omega_{0}}=\bigcup_{i j} \tilde{F}_{i j} \cup \bigcup_{i j, p q} \tilde{F}_{i j, p q}
$$

where the notation $\tilde{F}_{i j, p q}$ here and further on assumes that $i j \cap p q=\varnothing$.
Note that every virtual space of parameters $\tilde{F}_{i j}$ is the disjoint union of $\mathbb{C} P_{A}^{1}$ and three points:

$$
\begin{equation*}
\tilde{F}_{\overline{i j}}=\tilde{F}_{i j} \cup \bigcup_{p q} \tilde{F}_{i j, p q} \quad \text { where } \overline{i j}=\{1, \ldots, 5\} \backslash\{i, j\} \tag{20}
\end{equation*}
$$

Now, we use the projection $p_{\omega_{0}, 12}: \mathcal{F}_{\omega_{0}} \rightarrow F_{\omega_{0}}$ defined in Lemma 2.9 to map the virtual spaces of parameters from relations (18) to the space $F_{\omega_{0}}$. It directly follows from (20),

Lemma 5.2. The homology group $H_{2}\left(F_{\omega_{0}}\right)$ is generated by the classes determined by the virtual spaces of parameters $F_{i j}^{\prime}$ and the following relations hold:

$$
F_{i j}^{\prime}+F_{p q}^{\prime}=F_{i p}^{\prime}+F_{j q}^{\prime}=F_{i q}^{\prime}+F_{j p}^{\prime}
$$

for $\{i, j, p, q\} \subset\{1, \ldots, 5\}$ where

$$
F_{i j}^{\prime}:=F_{i j} \cup \bigcup_{p q} F_{i j, p q}
$$

Let $C_{\omega_{1}}$ be a chamber of the dimension 4 which differs from $C_{\omega_{0}}$ by one $K_{l m}$, that is $C_{\omega_{1}} \subset \stackrel{\circ}{K}_{i j}$, for $i j \neq l m$ and $C_{\omega_{1}} \nsubseteq \stackrel{\circ}{K}_{l m}$. We write $\mathcal{F}_{\omega_{1}}$ as:

$$
\mathcal{F}_{\omega_{1}}=\tilde{F}_{\overline{l m}} \cup \bigcup_{i j \neq l m} \tilde{F}_{i j} \cup \bigcup_{i j, p q \neq l m} \tilde{F}_{i j, p q} .
$$

- If $\tilde{F}_{\overline{i j}}$ is such that $i j \neq l m$ and $i j \nsubseteq \overline{l m}$ then $p_{\omega_{1}, 12}\left(\tilde{F}_{\overline{i j}}\right)=p_{\omega_{0,12}}\left(\tilde{F}_{\overline{i j}}\right)$.
- If $i j \subset \overline{l m}$ then $\tilde{F}_{\overline{i j}}$ is represented in $\mathcal{F}_{\omega_{1}}$ as

$$
\tilde{F}_{i j} \cup \bigcup_{p q \neq l m} \tilde{F}_{i j, p q} \cup \tilde{F}_{\overline{l m}}
$$

and

$$
p_{\omega_{1}, 12}\left(\tilde{F}_{\overline{i j}}\right)=F_{i j} \cup \bigcup_{p q \neq l m} F_{i j, p q} \cup F_{\overline{l m}} \simeq \mathbb{C} P^{1}
$$

For simplicity, we write $F_{i j}^{\prime}$ for this last union.
A virtual space of parameters $\tilde{F}_{\overline{l m}}$ projects to the space $F_{\bar{l}}$ and it is a point by Corollary 5.0 .3 , Therefore, the relations in the homology group $H_{2}\left(F_{\omega_{1}}\right)$ are as in the homology group $H_{2}\left(F_{\omega_{0}}\right)$, where we replace the space of parameters $F_{l m}^{\prime}$ by the zero class. In this way we get relations in any $H_{2}\left(F_{\omega}\right)$ by substituting $F_{i j}^{\prime}$ with the zero class in relations for $H_{2}\left(F_{\omega_{0}}\right)$ where $C_{\omega} \notin K_{i j}$.

Thus, we obtain the result analogous to that of Lemma 5.2 for an arbitrary chamber.

Lemma 5.3. Let $C_{\omega}=\bigcap_{i j \notin S} K_{i j} \cap \bigcap_{i j \in S} K_{i j}$ where $S \subset\{i j \mid 1 \leq i<j \leq 5\}$. The homology group $\mathrm{H}_{2}\left(F_{\omega}\right)$ is generated by the classes determined by the spaces of parameters $F_{i j}$ and the following relations hold:

$$
F_{i j}+F_{p q}=F_{i p}+F_{j q}=F_{i q}+F_{j p}
$$

for distinct $\{i, j, p, q\} \subset\{1, \ldots, 5\}$, where if any two indices of $i, j, p, q$ are in $S$ then we replace the corresponding class by the zero class.

Definition 5.1. The projection $p_{\omega_{0}, \omega}: C_{2}\left(F_{\omega_{0}}\right) \rightarrow C_{2}\left(F_{\omega}\right)$ is defined by:

$$
\begin{equation*}
p_{\omega_{0}, \omega}(c)=\sum_{i j \in \hat{\omega} \cap \omega} F_{i j} \tag{21}
\end{equation*}
$$

where $c=\sum_{i j \in \omega} F_{i j}$ for $\hat{\omega} \subset \omega_{0}$.
Lemma 5.4. If a cycle $l$ is the zero class in $H_{2}\left(F_{\omega_{0}}\right)$, then $p_{\omega_{0}, \omega}(l)$ is the zero class in $H_{2}\left(F_{\omega}\right)$ for a chamber $C_{\omega}$ of maximal dimension.

Proof. Let a cycle $l=\sum_{i j \in \omega} F_{i j}^{\prime}$ be zero in $H_{2}\left(F_{\omega_{0}}\right)$ for some $\hat{\omega} \subset \omega_{0}$. Let $C_{\omega}$ be a chamber such that $\omega \neq \omega_{0}$, that is $C_{\omega} \nsubseteq \stackrel{\circ}{K}_{p q}$ for some $p, q \in\{1, \ldots, 5\}$. Let $p q \notin \hat{\omega}$, by Lemma 5.2 and 5.3 we get that the cycle $p_{\omega_{0}, \omega}(l)$ is zero in $H_{2}\left(F_{\omega}\right)$. If $p q \in \hat{\omega}$, then by Lemma 5.3 we obtain that $p_{\omega_{0}, \omega}(l)=\sum_{\substack{i j \in \hat{\omega} \\ i j \neq p q}} F_{i j}$, so it is zero $H_{2}\left(F_{\omega}\right)$.

Theorem 5.5. $H_{6}\left(X_{5} ; \mathbb{Z}_{2}\right) \simeq \mathbb{Z}_{2}$.
Proof. By Corollary 4.4 .5 cycles of dimension 6 are generated by the cycles

$$
c_{m i}:=e_{m i}+e_{m 5}+e_{i 5}
$$

where $e_{i j}=K_{i j, 4} \times F_{i j}$ and $1 \leq m \leq 3$ and $m+1 \leq i<5$.
Let $c=\sum c_{m i}=\sum e_{p q}$. On the other hand, we can write the cycle $c$

$$
c=\sum_{\omega} \sum_{i j \in \omega} C_{\omega} \times F_{i j}=\sum_{\omega} C_{\omega} \times\left(\sum_{i j \in \omega} F_{i j}\right) .
$$

If there exists a chain $\tilde{c}=\sum C_{\tilde{\omega}} \times l_{\tilde{\omega}}$ such that $\partial \tilde{c}=c$ we have that

$$
\partial \tilde{l}_{\omega}=\sum_{i j \in \omega} F_{i j}, \text { for all } \omega .
$$

Thus, a cycle $c$ is homologically zero if $\sum_{i j \in \omega} F_{i j}=0$ in $H_{2}\left(F_{\omega}\right)$ for all $\omega$ appearing in $c$.
In particular, consider $c$ defined by

$$
c=c_{12}+c_{13}=e_{12}+e_{13}+e_{25}+e_{35}=\sum_{\omega} C_{\omega} \times\left(F_{12}+F_{13}+F_{25}+F_{35}\right) .
$$

We have that $C_{\omega} \in K_{i j, 4}$ for at least one $i j \in\{12,13,25,35\}$ and observe that $C_{\omega_{0}}$ participates in this sum. To prove that $c$ is zero in $H_{6}\left(X_{5} ; \mathbb{Z}_{2}\right)$, it is sufficient by Lemma 5.4 to prove that $C_{\omega_{0}} \times\left(F_{12}+F_{13}+F_{25}+F_{35}\right)$ is zero in $H_{6}\left(X_{5} ; \mathbb{Z}_{2}\right)$, that is $F_{12}+F_{13}+F_{25}+F_{35}=0$ in $H_{2}\left(F_{\omega_{0}}\right)$. This is true by Lemma 5.2 taking indices $\{1,2,3,5\}$, so $c_{12}=c_{13}$ in $H_{6}\left(X_{5} ; \mathbb{Z}_{2}\right)$. Similarly, using other choices of indices in Lemma 5.2] we deduce that $c_{13}=c_{14}, c_{13}=c_{23}, c_{23}=c_{24}$ and $c_{24}=c_{34}$ in $H_{6}\left(X_{5} ; \mathbb{Z}_{2}\right)$.

Theorem 5.6. $H_{5}\left(X_{5} ; \mathbb{Z}_{2}\right) \simeq \mathbb{Z}_{2}$.
Proof. By Proposition 4.10 cycles of the dimension 5 are homologous to cycles from $Y_{5}$. By Corollary 4.14.1 only possible cycles of dimension 5 are:

$$
c=\sum_{\sigma_{m}} O_{m, 3} \times l^{m}
$$

where $l^{m}$ is a chain on $\hat{\mu}^{-1}\left(O_{m}\right)$ that is a top dimensional cycle in $F_{4}$ for $1 \leq m \leq 5$. Thus, the potential generators are:

$$
g_{m}=O_{m, 3} \times l
$$

for $1 \leq m \leq 5$.
Let $\tilde{c}$ be a chain of dimension 6 such that $\partial \tilde{c}=\sum g_{m}$. By Corollary 4.8.1 we can assume that every $C_{\omega}$ is of the dimension 4. By Corollary 4.4.6 the chain $\tilde{c}$ is of the form $e_{i j}=K_{i j, 4}^{\circ} \times F_{i j}$ and $\partial e_{i j}=g_{i}+g_{j}$. We conclude that the sum of every two generators $g_{i}$ is homologically equals to zero.

## $6 \mathbb{Z}_{2}$-homology groups of $X_{6}$

The $\mathbb{Z}_{2}$-homology groups of $X_{6}$ are not known up to our knowledge. By Lemma 4.3 and Corollary 4.4.3, $\mathbb{Z}_{2}$-homology groups in dimensions 11 and 10 are :

$$
H_{11}\left(X_{6} ; \mathbb{Z}_{2}\right) \simeq \mathbb{Z}_{2}, H_{10}\left(X_{6} ; \mathbb{Z}_{2}\right) \simeq 0
$$

Theorem 4.9 implies that $H_{k}\left(X_{6} ; \mathbb{Z}_{2}\right) \simeq H_{k}\left(Y_{6} ; \mathbb{Z}_{2}\right)$, for $1 \leq k \leq 3$. By Corollary 4.14.1 a cycle $c$ of this dimension $k$ is homologous to a cycle from $\hat{\mu}^{-1}\left(\bigcup_{1 \leq m \leq 6} \partial \Delta_{5,2}(m)\right)$. We write $c$ as:

$$
c=c_{1}+c_{2}+c_{3}
$$

where
$c_{1} \in \hat{\mu}^{-1}\left(\bigcup_{1 \leq p<q \leq 6} \stackrel{\circ}{\Delta}_{4,2}(p q)\right), c_{2} \in \hat{\mu}^{-1}\left(\bigcup_{\substack{1 \leq p \leq 6 \\ 1 \leq q \leq 6}} \stackrel{\circ}{\Delta}+q_{\Delta_{4,1}}(p q)\right)$ and $c_{3} \in \hat{\mu}^{-1}\left(\bigcup_{1 \leq p<q \leq 6} \partial_{4,2}(p q)\right)$.
By Corollary 4.8.1 we can assume that $l_{\omega}$ is a point for every $C_{\omega}$ in $c$. In this case $c$ is a cycle on $\partial \Delta_{6,2}=S^{4}$, so

$$
H_{k}\left(X_{6} ; \mathbb{Z}_{2}\right) \simeq 0 \quad \text { for } 1 \leq k \leq 3
$$

We give the admissible polytopes, the space of parameters and the virtual space of parameters, defined in Section 2, for $X_{6}$.

For a non-orbit strata the admissible polytopes are given by:

$-K_{i j p q}:\left\{\mathbf{x} \in \Delta_{6,2} \mid x_{i}+x_{j}+x_{p}+x_{q} \leq 1\right\}$
$-K_{i j, p q}:\left\{\mathbf{x} \in \Delta_{6,2} \mid x_{i}+x_{j} \leq 1, x_{p}+x_{q} \leq 1\right\}$ where $\{i, j\} \cap\{p, q\}=\varnothing$

$$
\begin{aligned}
& -K_{i j, p q, l m}:\left\{\mathbf{x} \in \Delta_{6,2} \mid x_{i}+x_{j} \leq 1, x_{p}+x_{q} \leq 1, x_{l}+x_{m} \leq 1\right\} \text { where } \\
& \quad\{i, j\} \cap\{p, q\}=\varnothing,\{i, j\} \cap\{l, m\}=\varnothing,\{p, q\} \cap\{l, m\}=\varnothing \\
& -K_{i j, p q r}:\left\{\mathbf{x} \in \Delta_{6,2} \mid x_{i}+x_{j} \leq 1, x_{p}+x_{q}+x_{r} \leq 1,\{i, j\} \cap\{p, q, r\}=\varnothing\right\}
\end{aligned}
$$

- 4-dimensional

$$
-O_{m}:\left\{\mathbf{x} \in \Delta_{6,2} \mid x_{m}=0\right\}
$$

According to Subsection 2.1 we have:
Corollary 6.0.1. The space of parameters $F_{6}$ of the main stratum $W$ is homeomorphic to

$$
\begin{array}{r}

\left.c_{i j}^{\prime} c_{i k} c_{j k}^{\prime}=c_{i j} c_{i k}^{\prime} c_{j k}, \text { for } i j k \in\{123,124,134,234\}\right\}
\end{array}

The spaces of parameters of the strata we obtain by straightforward calculations.
Lemma 6.1. The spaces of parameters $F_{\sigma}$ for the strata $W_{\sigma}$ are:

- $P_{\sigma}=\Delta_{6,2} \Rightarrow F_{\sigma} \simeq F_{6} ;$
- $P_{\sigma}=K_{i j} \Rightarrow F_{\sigma} \simeq F_{5} ; \quad P_{\sigma}=K_{i j p} \Rightarrow F_{\sigma} \simeq \mathbb{C} P_{A}^{1}$
- $P_{\sigma}=K_{i j, p q} \Rightarrow F_{\sigma} \simeq \mathbb{C} P_{A}^{1} ; \quad P_{\sigma}=O_{i} \Rightarrow F_{\sigma} \simeq F_{5}$
- $P_{\sigma}=K_{i j k l} \Rightarrow F_{\sigma}$ is a point; $P_{\sigma}=K_{i j, p q, l m} \Rightarrow F_{\sigma}$ is a point
- for others $P_{\sigma} \Rightarrow F_{\sigma}$ is a point

According to Theorem [2.3] see also [6] it holds:
Theorem 6.2. The universal space of parameters $\mathcal{F}_{6}$ is the blowup of $\overline{F_{6}}$ firstly at the point ( $(1$ : $1)^{6}$ ) and then at the submanifolds $\bar{F}_{345}, \bar{F}_{346}, \bar{F}_{356}, \bar{F}_{456}$

The virtual spaces of parameters for the strata we obtain using the definitions from Subsection 2.1 by direct computations:

Lemma 6.3. The virtual spaces of parameters are given by:

1. $P_{\sigma}=\Delta_{6,2} \Rightarrow F_{\sigma} \simeq \tilde{F}_{\sigma} \simeq F_{6} ; \quad P_{\sigma}=K_{i j} \Rightarrow F_{\sigma} \simeq \tilde{F}_{\sigma} \simeq F_{5}$,
2. $P_{\sigma}=K_{i j p} \Rightarrow \tilde{F}_{\sigma} \simeq \mathbb{C} P^{1} \times \mathbb{C} P_{A}^{1} ; \quad P_{\sigma}=K_{i j p q} \Rightarrow \tilde{F}_{\sigma} \simeq \mathcal{F}_{5}$
3. $P_{\sigma}=K_{i j, p q} \Rightarrow F_{\sigma}=\tilde{F}_{\sigma} \simeq \mathbb{C} P_{A}^{1} ; \quad P_{\sigma}=K_{i j, p q, l m} \Rightarrow F_{\sigma}=\tilde{F}_{\sigma}$ is a point,
4. $P_{\sigma}=K_{i j, p q r} \Rightarrow \tilde{F}_{\sigma} \simeq \mathbb{C} P^{1}$,
5. $P_{\sigma}=O_{i} \Rightarrow \tilde{F}_{\sigma} \simeq \pi^{-1}\left(\left(F_{5} \times \mathbb{C} P^{1} \times \mathbb{C} P^{1} \times \mathbb{C} P^{1}\right) \cap \bar{F}_{6}\right) \subset \mathcal{F}_{6}$, where $\pi: \mathcal{F}_{6} \rightarrow \bar{F}_{6}$ is a natural projection morphism.
6. for others $P_{\sigma} \Rightarrow F_{\sigma}$ is a point and $\tilde{F}_{\sigma}$ is not a point.

Proof. The proof for 2. and 5. follows from the description of $\mathcal{F}_{6}$ as iterated blow ups given by Theorem 6.2

Following notation above of $P_{\sigma}$ by $K_{J}$ we further denote $F_{\sigma}$ and $\tilde{F}_{\sigma}$ by $F_{J}$ and $\tilde{F}_{J}$ as well.
We establish the generators and relations in the homology group of $\mathcal{F}_{6}$ using the map defined in Example 55, and the description of homology for $\mathcal{M}_{0,6}$
Lemma 6.4. The homology group $H_{4}\left(\mathcal{F}_{6}\right)$ is generated by $\tilde{f}\left(D_{I}\right)$ and the following relations hold:

\sum_{\substack{i, j \in I \\ p, q \notin I}} \tilde{f}\left(D_{I}\right)=\sum_{\substack{i, p \in I \\ j, q \notin I}} \tilde{f}\left(D_{I}\right)=\sum_{\substack{i, q \in I \\ j, p \notin I}} \tilde{f}\left(D_{I}\right) \tag{22}
\end{equation*}
$$

where $\{i, j, p, q\} \subset\{1, \ldots, 6\}$, the map $\tilde{f}: \mathcal{M}_{0,6} \rightarrow \mathcal{F}_{6}$ is given in Example 5 and $\tilde{f}\left(D_{I}\right)$ are given by:

Proof. Let us fix chart $M_{12}$. We consider the image $\tilde{f}\left(D_{I}\right)$ and we want to write it down as the union of a virtual spaces of parameters.

For example, the divisor $D_{12}$ maps to the subset

\end{align*}

If $\tilde{F}_{\sigma} \subseteq \tilde{f}\left(D_{12}\right)$ the points of its stratum $W_{\sigma}$ satisfies $P^{45}=0$. On the other hand, the virtual space of parameters $\tilde{F}_{1236}$ in the chart $M_{14}$ is written as

$$
\left(\left(c_{1}: c_{1}^{\prime}\right),(1: 0),\left(c_{2}: c_{2}^{\prime}\right),(1: 0),\left(c_{3}: c_{3}^{\prime}\right),(0: 1)\right)
$$

Then by the homeomorphism $\tilde{f}_{14,12}: \mathcal{F}_{14} \rightarrow \mathcal{F}_{12}$ we get $\tilde{F}_{1236}=\tilde{f}\left(D_{12}\right)$.
The divisor $D_{124}$ is defined as

We determine the virtual spaces of parameters $\tilde{F}_{\sigma} \subseteq \tilde{f}\left(D_{124}\right)$ for different value of $\left(c: c^{\prime}\right)$ as:

- If $\left(c: c^{\prime}\right) \notin A$ then we have

\left((0: 1),(0: 1),\left(c: c^{\prime}\right),\left(x_{1}: x_{2}\right)\right) \rightarrow\left((0: 1),(0: 1),\left(c: c^{\prime}\right),\left(x_{1}: x_{2}\right),(1: 0),(1: 0)\right)
$$

as described in Example [5, By (3), we get $\tilde{F}_{145}$.

- If $\left(c: c^{\prime}\right)=(1: 0)$ we get $\tilde{F}_{145,26}$.
- If $\left(c: c^{\prime}\right)=(1: 1)$ we get $\tilde{F}_{145,36}$.
- If $\left(c: c^{\prime}\right)=(0: 1)$ we get $\tilde{F}_{145,23}$.

Altogether, $\tilde{f}\left(D_{124}\right)=\tilde{F}_{145} \cup \tilde{F}_{145,26} \cup \tilde{F}_{145,36} \cup \tilde{F}_{145,23}$. We deduce the rules for mapping the divisors:

- divisor $D_{I}$, where $|I|=2$ or $|I|=4$ maps to the corresponding virtual space of parameters $\tilde{F}_{J} \simeq \mathbb{C} P^{1} \times \mathbb{C} P^{1}$ such that $|J|=4$ according to table (23),
- divisor $D_{I}$, where $|I|=3$ maps to

\tilde{F}_{J} \cup \bigcup_{k l} \tilde{F}_{J, k l} \simeq\left(\mathbb{C} P^{1} \times \mathbb{C} P_{A}^{1}\right) \cup\left(\mathbb{C} P^{1} \times A\right) \simeq \mathbb{C} P^{1} \times \mathbb{C} P^{1}
$$

where we determine the set of indices $J,|J|=3$ similarly as for $D_{124}$.
The relations follow from the relations in homology of $\mathcal{M}_{0,6}$ given by (10).
A chamber $C_{\omega}$ of the maximal dimension in $\Delta_{6,2}$ is obtained as $C_{\omega}=\cap \stackrel{\circ}{K}_{1 i j} \cap \cap \stackrel{\circ}{K}_{p q}$ for all $1 i j \in \omega$ and $p q \in \omega$. Let us denote by $C_{\omega_{0}}=\bigcap_{i j} \stackrel{\circ}{K}_{1 i j}$. We have disjoint union

\mathcal{F}_{6}=\mathcal{F}_{\omega_{0}}=\bigcup_{\substack{C_{\omega_{0}} \in P_{\sigma}}} \tilde{F}_{\sigma} .

It can be expressed in more details by

where all indices in each union are distinct according to the description of admissible polytopes from the beginnings of this section.

Therefore, in $\mathcal{F}_{\omega_{0}}$ we can decompose any $\tilde{F}_{\sigma}$ contributing to (22), and then, using the projection $p_{\omega_{0}, 12}: \mathcal{F}_{\omega_{0}} \rightarrow F_{\omega_{0}}$ in the chart $M_{12}$, we determine the relations in a homology group of $F_{\omega_{0}}$.

Proposition 6.5. The homology group $H_{4}\left(F_{\omega_{0}}\right)$ is generated by the homology classes $F_{i j}$ and the following relations hold:

\end{equation*}

The homology group $H_{2}\left(F_{\omega_{0}}\right)$ is generated by the homology classes $F_{i j, k l}, F_{1 k l}$ and the following relations hold:

\sum_{s m} F_{i j, s m}+\sum_{s m} F_{p q, s m}=\sum_{s m} F_{i p, s m}+\sum_{s m} F_{j q, s m}=\sum_{s m} F_{i q, s m}+\sum_{s m} F_{j p, s m} \tag{27}
\end{equation*}
$$

for distinct $\{i, j, p, q\} \subset\{1, \ldots, 6\}$.
Proof. Homology generators from relations (23) decompose in $\mathcal{F}_{\omega_{0}}$ as follows:

- $\tilde{F}_{1 j k}$ is an element of $\mathcal{F}_{\omega_{0}}$,
- For $\tilde{F}_{i j k}, i, j, k \neq 1$ it holds:

\tilde{F}_{i j k}=\tilde{F}_{i j k} \cup \tilde{F}_{i j k, i j} \cup \tilde{F}_{i j k, i k} \cup \tilde{F}_{i j k, j k}
$$

- For $\tilde{F}_{1 j p q}$ it holds

\tilde{F}_{1 j p q}=\tilde{F}_{1 j p q} \cup \tilde{F}_{11 j p q} \cup \bigcup_{k l} \tilde{F}_{\overline{1 j p q}, k l} \cup \bigcup_{k l} \tilde{F}_{\overline{1 j p q}, 1 k l} \cup \bigcup_{k l} \tilde{F}_{11 \overline{1 j p q}, k l} \cup \bigcup_{k l, m n} \tilde{F}_{\overline{1 j p q}, k l, m n}
$$

- For $\tilde{F}_{i j p q}$ it holds

\tilde{F}_{i j p q}=\tilde{F}_{i j p q} \cup \bigcup_{k \in\{i, j, p, q\}} \tilde{F}_{k \overline{i j p q}} \cup \bigcup_{k l} \tilde{F}_{i i j p q, k l} \cup \bigcup_{k, l m} \tilde{F}_{k \overline{i j p q}, l m} \cup \bigcup_{k l, m n} \tilde{F}_{\overline{i j p q}, k l, m n}
$$

By Lemma 6.3 an element $\tilde{F}_{i j}$ projects to the 4-dimensional space of parameters $F_{i j}$ and $\tilde{F}_{i j, p q}, \tilde{F}_{i j p}$ project to the 2-dimensional space of parameters $F_{i j, p q}, F_{i j p}$ respectively. Any other virtual space of parameters projects to a point. Substituting this in (22) and grouping by dimension we deduce the result. We demonstrate calculations for $I=\{2,3,5,6\}$ :

& \tilde{F}_{1346}+\left(\tilde{F}_{346} \cup \tilde{F}_{346,15} \cup \tilde{F}_{346,25} \cup \tilde{F}_{346,12}\right)+\left(\tilde{F}_{245} \cup \tilde{F}_{245,16} \cup \tilde{F}_{245,36} \cup \tilde{F}_{245,13}\right)+\tilde{F}_{1245}= \\
& \tilde{F}_{1246}+\left(\tilde{F}_{345} \cup \tilde{F}_{345,16} \cup \tilde{F}_{345,26} \cup \tilde{F}_{345,12}\right)+\left(\tilde{F}_{246} \cup \tilde{F}_{246,15} \cup \tilde{F}_{246,35} \cup \tilde{F}_{246,13}\right)+\tilde{F}_{1345} .
\end{align*}
$$

For example, $p_{\omega_{0}, 12}\left(\tilde{F}_{1456}\right)$ is the union of the $4=$ dimensional cell $F_{23}$, 2-dimensional cells $F_{23, k l}, F_{123}$ and points $F_{123, k l}, F_{23,1 k l}, F_{23, k l, m n}$ for all possible indices $k l, m n$. We can denote this union as $F_{23}^{\prime} \simeq \mathbb{C} P^{1} \times \mathbb{C} P^{1}$. We do the same for each element from (28),

Taking only the 4 -dimensional chains, that are obtained only by the spaces $\tilde{F}_{J},|J|=4$, we get:

The 2-dimensional chains $F_{i j k}$ cancel out as it can be seen from relations:

\end{aligned}
$$

It follows:

\sum_{k l} F_{23, k l}+\sum_{k l} F_{56, k l}=\sum_{k l} F_{25, k l}+\sum_{k l} F_{36, k l}=\sum_{k l} F_{35, k l}+\sum_{k l} F_{26, k l} .
$$

Similarly, we proceed for any indices $\{i, j, p, q\} \subset\{1, \ldots, 6\}$.

Let now $C_{\omega}$ be an arbitrary chamber. We note that every chamber of the maximal dimension is determined by the choice of $K_{i j k}$ and $K_{p q}$ where $i$ is fixed. Let us generalize the notation for $C_{\omega_{0}}$ by $C_{\omega_{s}}$ to denote the chamber given by $\bigcap_{i j} K_{(s+1) i j}$ for fixed $s \in\{1, \ldots, 5\}$.

Consider a chamber $C_{\omega_{s}}$ and the decomposition of $\mathcal{F}_{6}$ given by

\mathcal{F}_{6}=\mathcal{F}_{\omega_{s}}=\bigcup_{i j} \tilde{F}_{i j} \cup \bigcup_{p q, i j} \tilde{F}_{i j, p q} \cup \bigcup_{p q} \tilde{F}_{(s+1) p q} \cup \bigcup_{i j, p q} \tilde{F}_{i j,(s+1) p q} \cup \bigcup_{i j, p q, l m} \tilde{F}_{i j, p q, l m} \tag{29}
\end{equation*}
$$

The relations from Corollary 6.5 for $F_{\omega_{0}}$ are true for the space $F_{\omega_{s}}$ as well. This can be proved similarly if we replace index 1 by $s+1$.

Now, it is enough to take the chamber $C_{\omega}=\bigcap_{i j \notin S} K_{1 i j} \cap \bigcap_{p q \notin D} K_{p q}$ where $S, D \subset\{i j \mid 1 \leq$ $i<j \leq 6\}$ are chosen such that $C_{\omega} \neq \varnothing$. Then $\mathcal{F}_{\omega}$ is equal to

i \notin D}} \tilde{F}_{i j, p q} \cup \bigcup_{i j, p q, l m \notin D} \tilde{F}_{i j, p q, l m} \cup \\
& \cup \bigcup_{\substack{p q \notin S \\
i j \notin D}} \tilde{F}_{i j, 1 p q} \cup \bigcup_{\substack{p q \in S \\
i j \notin D}} \tilde{F}_{i j, \overline{1 p q}} \cup \bigcup_{p q \notin S} \tilde{F}_{1 p q} \cup \bigcup_{p q \in S} \tilde{F}_{1 p q} .
\end{aligned}
$$

We consider relations in $H_{4}\left(F_{\omega}\right)$. By Corollary 6.3, we can get a 4-dimensional elements $F_{i j}$ only as projection of the virtual spaces of parameters $\tilde{F}_{i j}$. Since $\tilde{F}_{i j} \in \mathcal{F}_{\omega}$ if $i j \notin D$, it follows that $F_{i j}$ will participate in the relations for $H_{4}\left(F_{\omega}\right)$ if $i j \notin D$. Then the relations in $H_{4}\left(F_{\omega}\right)$ are the same as (26), where we replace the space of parameters $F_{i j}$ by the zero class for $i j \in D$.

The relations in $H_{2}\left(F_{\omega}\right)$ are affected by the projection of the virtual spaces of parameters of the form $\tilde{F}_{i j p}$ and $\tilde{F}_{i j, p q}$. Applying previous procedure we also have that every element $F_{i j k}$ cancels out. If $\tilde{F}_{(1 p q} \in \mathcal{F}_{\omega}$ it will be canceled out as in the calculations proceeding (27). If $\tilde{F}_{1 p q} \notin \mathcal{F}_{\omega}$ then $\tilde{F}_{1 p q} \in \mathcal{F}_{\omega}$ and the element $F_{\overline{1 p q}}$ stands in the relations of $H_{2}\left(F_{\omega}\right)$ exactly as the element $F_{1 p q}$ stands in the relations of $H_{2}\left(F_{\omega_{0}}\right)$. We demonstrate calculations in a particular example as the general calculation requires a cumbersome using of indices.

Consider the chamber $C_{\omega}=\bigcap_{i j \notin S} K_{1 i j} \cap \bigcap_{i j \notin S} K_{i j}$, for the set $S=\{26,46\}$. By decomposing any element from in $\mathcal{F}_{\omega}$ and projecting it to $F_{\omega}$, we obtain:

- the relation in $H_{4}\left(F_{\omega}\right)$ :

F_{23}+F_{56}=F_{25}+F_{36}=F_{35}
$$

where the element $F_{26}$ is missing out since $\tilde{F}_{1345}$ is an element of $\mathcal{F}_{\omega}$ and it is projected to a a point,

- the relation in $H_{2}\left(F_{\omega}\right)$ :

\begin{gathered}
F_{123}+F_{235}+\sum_{k l \notin S} F_{23, k l}+F_{123}+F_{156}+F_{156}+\sum_{k l \notin S} F_{56, k l}= \\
=F_{125}+F_{235}+\sum_{k l \notin S} F_{25, k l}+F_{125}+F_{136}+F_{136}+\sum_{k l \notin S} F_{36, k l}= \\
=F_{135}+F_{345}+F_{235}+\sum_{k l \notin S} F_{35, k l}+F_{345}+F_{135} .
\end{gathered}
$$

It follows:

\sum_{k l \notin S} F_{23, k l}+\sum_{k l \notin S} F_{56, k l}=\sum_{k l \notin S} F_{25, k l}+\sum_{k l \notin S} F_{36, k l}=\sum_{k l \notin S} F_{35, k l} .
$$

Therefore, an analogous result to those for $C_{\omega_{0}}$ can be obtained for arbitrary chamber $C_{w}$.
Proposition 6.6. Let $s \in\{0, \ldots, 5\}$ and let $C_{\omega}$ be the chamber defined by $C_{\omega}=\bigcap_{i j \notin S} K_{(s+1) i j} \cap$ $\bigcap_{p q \notin D} K_{p q}$ for $S, D \subset\{i j \mid 1 \leq i<j \leq 6\}$. The homology group $H_{4}\left(F_{\omega}\right)$ is generated by the homology classes $F_{i j}, i j \in \omega \backslash D$ and the following relations hold:

$$
\begin{equation*}
F_{i j}+F_{p q}=F_{i p}+F_{j q}=F_{i q}+F_{j p} \tag{30}
\end{equation*}
$$

for $\{i, j, p, q\} \subset\{1, \ldots, 6\}$, where we substitute for any element from $D$ the corresponding class by the zero class.

The homology group $H_{2}\left(F_{\omega}\right)$ is generated by the homology classes $F_{(s+1) i j}$ for $(s+1) i j \in$ $\omega, i j \notin S$ and $F_{i j, s m}$ for $i j, s m \in \omega \backslash D$ and the following relations hold:

$$
\begin{equation*}
\sum_{s m \notin D} F_{i j, s m}+\sum_{s m \notin D} F_{p q, s m}=\sum_{s m \notin D} F_{i p, s m}+\sum_{s m \notin D} F_{j q, s m}=\sum_{s m \notin D} F_{i q, s m}+\sum_{s m \notin D} F_{j p, s m} \tag{31}
\end{equation*}
$$

for $\{i, j, p, q\} \subset\{1, \ldots, 6\}$, where $\sum_{s m \notin D} F_{r l, s m}$ is substituted by the zero class for any rl such that $r, l \in\{i, j, p, q\}$ and $r l \in D$.

Definition 6.1. Let c be a chain of the form $\sum_{i j \in \hat{\omega}} F_{i j}$ or $\sum_{\{i j, p q\} \in \hat{\omega}} F_{i j, p q}$ in $F_{\omega_{0}}$ where $\hat{\omega} \subset \omega_{0}$ and let us fix a chamber $C_{\omega}=\bigcap_{i j \notin S} K_{s i j} \cap \bigcap_{i j \notin D} K_{i j}$ for fixed $s \in\{1,2,3,4,5,6\}$. The projection $p_{\omega_{0}, \omega}: H_{k}\left(F_{\omega_{0}}\right) \rightarrow H_{k}\left(F_{\omega}\right)$ is defined by

- if $\mathcal{c}=\sum_{i j \in \hat{\omega}} F_{i j}$ and $k=4$ then

$$
\begin{equation*}
p_{\omega_{0}, \omega}(c)=\sum_{i j \in \hat{\omega} \backslash D} F_{i j} \tag{32}
\end{equation*}
$$

- if $c=\sum_{\{i j, p q\} \in \hat{\omega}} F_{i j, p q}$ and $k=2$ then

$$
\begin{equation*}
p_{\omega_{0}, \omega}(c)=\sum_{i j, p q \in \hat{\omega} \backslash D} F_{i j, p q} . \tag{33}
\end{equation*}
$$

By Proposition 6.6 this projection is well defined and satisfies the following:
Lemma 6.7. If a cycle l is the zero class in $H_{4}\left(F_{\omega_{0}}\right)$ or $H_{2}\left(F_{\omega_{0}}\right)$ then the cycle $p_{\omega_{0}, \omega}(l)$ is the zero class in $H_{4}\left(F_{\omega}\right)$ or $H_{2}\left(F_{\omega}\right)$ for any chamber $C_{\omega}$ respectively.

Proof. By Proposition6.6 if $l$ is the zero class in $H_{4}\left(F_{\omega_{0}}\right)$ then it is also the zero class in $H_{4}\left(F_{\omega_{k}}\right), k \in$ $\{1, \ldots, 5\}$. Thus, we can assume that $C_{\omega}=\bigcap_{i j \notin S} K_{1 i j} \cap \bigcap_{p q \notin D} K_{p q}$. We note that $p_{\omega_{0}, \omega}(l)$ does not contain an element $F_{\sigma}$ for $\sigma \in D$ and $F_{\sigma}$ neither participates in relations (30) in $H_{4}\left(F_{\omega}\right)$. Then by Corollary 6.6 the cycle $p_{\omega_{0}, \omega}(l)$ can be spanned by relations 30 and therefore it is the zero in $H_{4}\left(F_{\omega}\right)$.

### 6.1 Homology groups $H_{k}\left(X_{6} ; \mathbb{Z}_{2}\right)$ for $4 \leq k \leq 9$

Theorem 6.8. $H_{9}\left(X_{6} ; \mathbb{Z}_{2}\right) \simeq \mathbb{Z}_{2}$.
Proof. By Corollary 4.4.5 the group of cycles of dimension 9 has basis of the form

$$
c_{m i}:=e_{m i}+e_{m 6}+e_{i 6},
$$

where $e_{i j}=K_{i j, 5} \times F_{i j}, 1 \leq m \leq 4$ and $m+1 \leq i<6$.
Let $\tilde{c}=\sum C_{\omega} \times l_{\omega}$ be a 10-dimensional chain such that $\partial \tilde{c}=c$ for some cycle $c=\sum c_{m i}=$ $\sum_{\omega} C_{\omega} \times\left(\sum F_{i j}\right)$. A chain $l_{\omega}$ must be of the dimension 5 , so it is a chain in $F_{6}$. We get that $\partial \tilde{c}=\sum C_{\omega}^{\prime} \times l_{\omega}+\sum C_{\omega} \times \partial l_{\omega}$. Since the first sum must be zero we have that $l_{\omega}=l, \forall \omega$ and $\cup C_{\omega}=\Delta_{6,2,5}$. Thus, $\partial l=\sum F_{i j}$, so it is homology zero $H_{4}\left(F_{\omega}\right)$.

We consider the sum $c_{12}+c_{13}=e_{12}+e_{13}+e_{26}+e_{36}=\sum C_{\omega} \times\left(F_{12}+F_{13}+F_{26}+F_{36}\right)$. By (26) for the indices $\{1,2,3,6\}$ we get that $F_{12}+F_{13}+F_{26}+F_{36}$ is zero in $H_{4}\left(F_{\omega_{0}}\right)$. We get by Lemma 6.7 that the chain $p_{\omega_{0}, \omega}\left(F_{12}+F_{13}+F_{26}+F_{36}\right)$ is zero in $H_{4}\left(F_{\omega}\right)$ for all $C_{\omega}$. Therefore, the sum $c_{12}+c_{13}$ is zero in $H_{9}\left(X_{6} ; \mathbb{Z}_{2}\right)$. Similarly, we prove for every sum $c_{i j}+c_{i k}$ to be zero class.

Theorem 6.9. $H_{8}\left(X_{6} ; \mathbb{Z}_{2}\right) \simeq \mathbb{Z}_{2}$.
Proof. By Theorem 4.12 a cycle $c$ of dimension 8 is homologous to a cycle from $Y_{6}$. Since there are no chains of dimension 8 in $\hat{\mu}^{-1}\left(\partial O_{m}\right)$, by Corollary 4.14.1 it follows that the cycle $c$ is of the form:

$$
c=\sum_{1 \leq m \leq 6} a_{m}\left(O_{m, 4} \times F_{5}^{m}\right), a_{m} \in \mathbb{Z}_{2}
$$

Every chain $O_{m, 4} \times F_{5}^{m}$ is a cycle that we denote by $g_{m}$.
Let $p=\sum C_{\omega} \times l_{\omega}$ be a chain of the dimension 9 such that $\partial p=l$ where $l=\sum g_{m}$. It follows that $C_{\omega}$ is a 5 -dimensional and $l_{\omega}$ is a 4-dimensional chain. Following Corollary 4.4.6 we consider the chains $e_{i j}=K_{i j, 5} \times F_{i j}$. It follows that

$$
\partial e_{i j}=O_{i, 4} \times F_{5}^{i}+O_{j, 4} \times F_{5}^{j}=g_{i}+g_{j} .
$$

We conclude that the sum of every two generators $g_{i}$ is zero in $H_{8}\left(X_{6} ; \mathbb{Z}_{2}\right)$.
Lemma 6.10. Generators of $H_{7}\left(X_{6} ; \mathbb{Z}_{2}\right)$ are from the following set of 7 -dimensional cycles:

$$
g_{i j k l}=e_{i j k}+e_{i j l}+e_{i k l}+e_{j k l}+e_{i j, k l}+e_{i k, j l}+e_{i l, j k}
$$

where $e_{i j k}=K_{i j k, 5} \times F_{i j k}$ and $e_{i j, k l}=K_{i j, k l, 5} \times F_{i j, k l}$ for distinct $i, j, k, l \in\{1, \ldots, 6\}$.
Proof. By Theorem 4.13 a cycle $c$ of the dimension 7 is homologous to cycle $c_{0}^{\prime}+c_{1}^{\prime}$ where $c_{0}$ is a cycle in $\hat{\mu}^{-1}\left(\Delta_{6,2}^{\circ}\right)$ and $c_{1}$ is a cycle in $\hat{\mu}^{-1}\left(\partial \Delta_{6,2}\right)$.. By Corollary 4.14.1 a cycle $c_{1}^{\prime}$ is in $\hat{\mu}^{-1}\left(\bigcup_{1 \leq m \leq 6} \partial O_{m}\right)$. Since there are no 7 dimensional chains on $\partial O_{m}$, a cycle $c=c_{0}^{\prime}$. In addition, by Corollary 4.14.1 and Lemma6.1 any cycle must be written in the form $\sum e_{i j, k l}+\sum e_{i j k}$. We get

$$
\partial_{5} e_{i j, k l}=e_{i j}^{k}+e_{i j}^{l}+e_{k l}^{i}+e_{k l}^{j} \quad \partial_{5} e_{i j k}=e_{i j}^{k}+e_{i k}^{j}+e_{j k}^{i}
$$

where $e_{i j}^{k}$ denotes the chain $e_{i j}=K_{i j, 4}(k) \times F_{i j}(k)$ for $K_{i j}(k) \subset O_{k}$. We check at once that a chain $g_{i j k l}$ is the cycle and cannot be obtained as the sum of some cycles of less number of summands and it follows that every cycle is generated by the set of $g_{i j k l}$. A summand $e_{i j, k l}$ appears just in one element $g_{i j k l}$, therefore the set of $g_{i j k l}$ is linearly independent.

Theorem 6.11. $H_{7}\left(X_{6} ; \mathbb{Z}_{2}\right) \simeq\left(\mathbb{Z}_{2}\right)^{11}$.
Proof. Let $c=\sum g_{i j k l}=\sum_{\omega} C_{\omega} \times\left(\sum_{\sigma \in \omega} F_{\sigma}\right)$ be a cycle. It will be the zero class in $H_{7}\left(X_{6} ; \mathbb{Z}_{2}\right)$ only if $\sum F_{\sigma}$ is zero in $H_{2}\left(F_{\omega}, \mathbb{Z}_{2}\right)$ for every $C_{\omega}$. It follows from Relations 31 that the cycle $c$ is zero class only if it is of the form $\sum e_{i j, k l}$.

Let us consider the cycles

$$
\begin{equation*}
g_{s}=\sum_{\substack{i j k l \\ s \notin i j k l}} g_{i j k l}=\sum_{\substack{i j k l \\ s \notin i j k l}} e_{i j, k l} . \tag{34}
\end{equation*}
$$

for $s \in\{1, \ldots, 6\}$. Note that if we remove a summand $g_{i j k l}$ from the sum (34), what is left cannot be expressed in terms of $e_{i j, k l}$. We show that $g_{6}$ is homologically equal to $g_{5}$. The chamber $C_{\omega_{0}}$ participates in the cycles $g_{6}$ and $g_{5}$. Firstly we show that

$$
\sum_{i j k l \neq 6} F_{i j, k l}=\sum_{i j k l \neq 5} F_{i j, k l} \quad \text { in } H_{2}\left(F_{\omega_{0}}, \mathbb{Z}_{2}\right)
$$

It holds in $H_{2}\left(F_{\omega_{0}}, \mathbb{Z}_{2}\right)$ :

$$
\begin{aligned}
& \sum_{i j k l \neq 6} F_{i j, k l}=\sum_{k l \in\{34,35,45\}} F_{12, k l}+\sum_{k l \in\{24,25,45\}} F_{13, k l}+\sum_{k l \in\{15,35\}} F_{24, k l}+\sum_{k l \in\{15,25\}} F_{34, k l}+\sum_{k l \in\{25,35\}} F_{14, k l}+ \\
& +\sum_{k l \in\{15,14,45\}} F_{23, k l}= \\
& =\sum_{k l \in\{36,46,56\}} F_{12, k l}+\sum_{k l \in\{26,46,56\}} F_{13, k l}+\sum_{k l \in\{13,16,36,56\}} F_{24, k l}+\sum_{k l \in\{12,16,26,56\}} F_{34, k l}+\sum_{k l \in\{25,35\}} F_{14, k l}+ \\
& +\sum_{k l \in\{15,14,45\}} F_{23, k l}= \\
& =\sum_{k l \in\{36,46\}} F_{12, k l}+\sum_{k l \in\{26,46\}} F_{13, k l}+\sum_{k l \in\{13,16,36\}} F_{24, k l}+\sum_{k l \in\{12,16,26\}} F_{34, k l}+\sum_{k l \in\{25,35\}} F_{14, k l}+ \\
& +\sum_{k l \in\{15,14,45\}} F_{23, k l}+\sum_{k l \in\{12,13,24,34\}} F_{56, k l}= \\
& =\sum_{k l \in\{36,46\}} F_{12, k l}+\sum_{k l \in\{26,46\}} F_{13, k l}+\sum_{k l \in\{13,16,36\}} F_{24, k l}+\sum_{k l \in\{12,16,26\}} F_{34, k l}+\sum_{k l \in\{26,36\}} F_{14, k l}+ \\
& +\sum_{k l \in\{14,16,46\}} F_{23, k l}= \\
& =\sum_{k l \in\{23,24,34\}} F_{16, k l}+\sum_{k l \in\{13,14,34\}} F_{26, k l}+\sum_{k l \in\{12,14,24\}} F_{36, k l}+\sum_{k l \in\{12,13,23\}} F_{46, k l}+F_{12,34}+F_{13,24}+F_{14,23}= \\
& =\sum_{i j k l \neq 5} F_{i j, k l},
\end{aligned}
$$

where the third and the fifth equality are obtained just regrouping of a summands, the second equality follows from the relation

$$
\sum_{k l} F_{12, k l}+\sum_{k l} F_{34, k l}=\sum_{k l} F_{13, k l}+\sum_{k l} F_{24, k l}
$$

and the fourth equality follows from the relation

$$
\sum_{k l \in\{25,26,35,36\}} F_{14, k l}+\sum_{k l \in\{14,15,16,45,46\}} F_{23, k l}+\sum_{k l \in\{12,13,24,34\}} F_{56, k l}=0
$$

By Lemma6.7 it follows that $g_{6}=g_{5}$ in $H_{7}\left(X_{6} ; \mathbb{Z}_{2}\right)$. Similarly, we can show that any two $g_{s}$ and $g_{r}$ are homologous.

Next, we want to eliminate linearly dependent generators among $g_{i j k l}$ :

$$
\begin{gathered}
g_{6}=g_{5} \Longrightarrow \quad g_{2345}=g_{1235}+g_{1245}+g_{1345}+g_{1236}+g_{1246}+g_{1346}+g_{2346}:=T_{1}+g_{2346} \\
g_{5}=g_{4} \Longrightarrow \quad g_{2356}=g_{1234}+g_{1246}+g_{1346}+g_{2346}+g_{1235}+g_{1256}+g_{1356}:=T_{2}+g_{2346} \\
g_{4}=g_{3} \Longrightarrow \quad g_{2456}=g_{1235}+g_{1236}+g_{1356}+g_{2356}+g_{1245}+g_{1246}+g_{1456}:=T_{3}+g_{2356}= \\
\\
\quad=T_{3}+T_{2}+g_{2346}=T_{3}+T_{2}+T_{1}+g_{2345} \\
g_{3}=g_{2} \Longrightarrow \quad g_{3456}=g_{1245}+g_{1246}+g_{2456}+g_{1256}+g_{1345}+g_{1346}+g_{1356}:=T_{4}+g_{2456} \\
g_{2}=g_{1} \Longrightarrow \quad g_{1345}+g_{1346}+g_{1356}+g_{1456}=g_{2345}+g_{2346}+g_{2356}+g_{2456}= \\
\\
=g_{2345}+g_{2346}+T_{2}+g_{2346}+T_{3}+T_{2}+T_{1}+g_{2345}=T_{3}+T_{1} \\
\\
=g_{1345}+g_{1346}+g_{1356}+g_{1456},
\end{gathered}
$$

where it can be seen that the last implication follows from the previous ones. We get that $g_{2345}, g_{2356}, g_{2456}$ and $g_{3456}$ are linearly dependent.

Theorem 6.12. $H_{6}\left(X_{6} ; \mathbb{Z}_{2}\right) \simeq\left(\mathbb{Z}_{2}\right)^{3}$.
Proof. By Proposition 4.10 a cycle of dimension 6 is homologous to a cycle in $Y_{6}$. Such cycle is by Corollary 4.14.1 homologous to a cycle

$$
c^{\prime}=\sum_{1 \leq m \leq 6} c^{m}+c_{2}, \text { where } c_{m} \in \hat{\mu}^{-1}\left(\stackrel{\circ}{O}_{m}\right) \text { and } c_{2} \in \hat{\mu}^{-1}\left(\bigcup_{1 \leq m \leq 6} \partial O_{m}\right) .
$$

Since there are no 6 -dimensional chains on $\hat{\mu}^{-1}\left(\partial O_{m}\right)$ we have that $c_{2}=0$. A chain $c^{m}$ has to be of the form:

$$
c^{m}=\sum_{p q} e_{p q}^{m}
$$

where $e_{p q}^{m}$ is a chain in $\hat{\mu}^{-1}\left(\stackrel{\circ}{O}_{m}\right)$ defined in Theorem 5.5. If $c^{m}$ is a cycle, by Theorem5.5 we get $c^{m}=e_{12}^{m}+e_{13}^{m}+e_{23}^{m}$.

If $c^{m}$ is not a cycle, then $\partial c^{m} \in \hat{\mu}^{-1}\left(\partial O_{m}\right)$, which must be canceled by some chain $\partial \sum_{r \neq m} c^{r}$. It holds $\partial e_{p q}^{m}=O_{p m, 3} \times l_{p m}+O_{q m, 3} \times l_{q m}$, where $O_{i j}=\left(O_{i} \cap O_{j}\right) \simeq \Delta_{4,2}$ for $1 \leq i<j \leq 6$. It can be easily seen that the only cycles of this type are:

$$
\begin{equation*}
e_{i j}^{k}+e_{i j}^{l}+e_{k l}^{i}+e_{k l}^{j}=\partial_{5} e_{i j, k l,} \quad e_{i j}^{k}+e_{i k}^{j}+e_{j k}^{i}=\partial_{5} e_{i j k} . \tag{35}
\end{equation*}
$$

They are homologous to zero. It follows that there are six potentially generators for $H_{6}\left(X_{6} ; \mathbb{Z}_{2}\right)$ :

$$
g_{i}=e_{12}^{i}+e_{13}^{i}+e_{23}^{i} \text { for each complex } O_{i}, 1 \leq i \leq 6
$$

We need to check if a combination of $g_{i}$ is homologous to zero. Let $c=\sum C_{\omega} \times l_{\omega}$ such that $c \in \hat{\mu}^{-1}\left(\Delta_{6,2}^{\circ}\right)$ and $\partial^{0} c=0$ be a 7 -dimensional chain, where $\partial c$ is a combination of $g_{i}$. By Corollary 4.8.1 every $C_{\omega}$ of $c$ is a chamber of maximal dimension and by Corollary 4.4.6 a chain $l_{\omega}$ is a combination of $F_{i j, k l}$ and $F_{i j k}$. It follows that $c$ is a sum of $e_{i j, k l}$ and $e_{i j k}$. For example, by (35) we obtain:

$$
\partial\left(e_{12,36}+e_{13,26}+e_{16,23}\right)=g_{6}+g_{3}+g_{1}+g_{2}=\partial\left(e_{123}+e_{126}+e_{136}+e_{236}\right) .
$$

In this way we deduce that the sum of every four $g_{i}$ 's is linearly dependent in $H_{6}\left(X_{6} ; \mathbb{Z}_{2}\right)$.

Theorem 6.13. $H_{5}\left(X_{6} ; \mathbb{Z}_{2}\right) \simeq \mathbb{Z}_{2}$.
Proof. By Proposition 4.10 a cycle $c$ of dimension 5 is homologous to a cycle in $Y_{6}$, so by Corollary 4.14.1 it is homologous to a cycle from $\hat{\mu}^{-1}\left(\bigcup_{1 \leq m \leq 6} \partial O_{m}\right)$. It follows that $\operatorname{dim}\left(l_{\omega}\right) \geq 1$ for all $\omega$ and we can write $c$ as:

$$
c=\sum c_{i j} \text { where } c_{i j} \in \hat{\mu}^{-1}\left(\stackrel{\circ}{O}_{i j}\right)
$$

and $O_{i j}=O_{i} \cap O_{j} \simeq \Delta_{4,2}$ for $1 \leq i<j \leq 6$. By Theorem5.6 we have that $H_{5}\left(X_{5}(j), \mathbb{Z}_{2}\right) \simeq \mathbb{Z}_{2}$ is spanned by any of $g_{i}^{j}=O_{i j, 3} \times l_{i j}, 1 \leq i \leq 6$ and $i \neq j$ for $1 \leq j \leq 6$. Since $g_{i}^{j}=g_{j}^{i}$ we are left with one generator that we denote by $g$. Such generator cannot be obtained as the boundary of some 6-dimensional chain $\tilde{c} \in \hat{\mu}^{-1}\left(\Delta_{6,2}^{\circ}\right), \tilde{c}=\sum C_{\omega} \times l_{\omega}$, where $\operatorname{dim}\left(C_{\omega}\right)=4$ and $\operatorname{dim}\left(l_{\omega}\right)=2$. Since $\partial^{0} \tilde{c}=0$, by Corollary 4.8.1 the chain $\tilde{c}$ is homologous to a chain from $Y_{6}$ and $\tilde{c}$ cannot be a chain in $\hat{\mu}^{-1}\left(O_{m}\right)$ for any $1 \leq m \leq 6$. Only possibility is that it is the sum of two chains from $\stackrel{\circ}{O}_{i}$ and $\stackrel{\circ}{O}_{j}$, that is $\tilde{c}=\tilde{c}_{i}+\tilde{c}_{j}$. Since $\partial \tilde{c}=g$ by Corollary 4.4.6 the chain $\tilde{c}_{i}=e_{p q}^{i}$, where $e_{p q}^{i}$ is the chain from $\hat{\mu}^{-1}\left(O_{i}\right)$ defined in Theorem 5.5. We conclude that such chain $\tilde{c}$ does not exist.

Theorem 6.14. $H_{4}\left(X_{6} ; \mathbb{Z}_{2}\right) \simeq 0$.
Proof. By Corollary 4.8 .1 cycles $c$ of the dimension 4 are homologous to cycles from $Y_{6}$. By Corollary 4.14.1 a cycle of the dimension 4 is homologous to a cycle from $\hat{\mu}^{-1}\left(\cup_{1 \leq m \leq 6} \partial O_{m}\right)$. It follows that $\operatorname{dim}\left(l_{\omega}\right) \geq 1$ for all $\omega$ and we can write a cycle $c$ as:

$$
c=\sum c_{i j} \text { where } c_{i j} \in \hat{\mu}^{-1}\left(\stackrel{\circ}{O}_{i j}\right)
$$

and $O_{i j}=O_{i} \cap O_{j} \simeq \Delta_{4,2}$ for $1 \leq i<j \leq 6$. It holds $\partial c_{i j} \in \hat{\mu}^{-1}\left(\partial O_{i j}\right)$ and by Corollary 4.8.1 it follows that $c_{i j}$ is homologous to a chain from $\hat{\mu}\left(\partial O_{i j}\right)$ which has to be zero.
