# RELATIVE ROTA-BAXTER OPERATORS, MODULES AND PROJECTIONS

#### Abstract

The present article is devoted to introduce, in a braided monoidal setting, the notion of module over a relative Rota-Baxter operator. It is proved that there exists an adjunction between the category of modules associated to an invertible relative Rota-Baxter operator and the category of modules associated to a Hopf brace, which induces an equivalence by assuming certain additional hypothesis. Moreover, the notion of projection between relative Rota-Baxter operators is defined, and it is proved that those which are called "strong" give rise to a module according to the previous definition in the cocommutative setting.

## Introduction

An important issue in the field of mathematical physics consists on finding solutions of the Quantum Yang-Baxter Equation (QYBE). The QYBE appeared in the 1970s in the field of quantum and statistical mechanics (see [24] and [3]), and a complete classification of its solutions has not yet been obtained at this stage. A solution of such equation is an automorphism $c: V \otimes V \rightarrow V \otimes V$, where $V$ is a vector space over the field $\mathbb{F}$ and $\otimes$ denotes the tensor product of vector spaces over $\mathbb{F}$, which satisfies the following equality:
(QYBE)

\left(c \otimes i d_{V}\right) \circ\left(i d_{V} \otimes c\right) \circ\left(c \otimes i d_{V}\right)=\left(i d_{V} \otimes c\right) \circ\left(c \otimes i d_{V}\right) \circ\left(i d_{V} \otimes c\right)

Applications of the QYBE are diverse and cover different areas of mathematics and physics (to mention a few: knot theory, non-commutative geometry or quantum groups, between others), what implies that its solutions have been studied hardly and from different points of view.

The first method to obtain solutions sistematically of the QYBE was proposed by Drinfeld in [7]. He introduced the notion of quasitriangular Hopf algebra and proved that their associated modules give rise to solutions of the QYBE. It is an important result that, if $H$ is a Hopf algebra, the category of modules over its Drinfeld's double, $D(H)$, which is a quasitriangular Hopf algebra, is equivalent to the category of

Yetter-Drinfeld modules over $H$ (see [17, Theorem IX.5.2. and Section XIII.5]). So, as a consequence of these facts, every Yetter-Drinfeld module over a Hopf algebra $H$ induce a solution of such equation.

Later, Radford, Majid and Bespalov in [20], [19] and 4], respectively, stated that, given a Hopf algebra $H$ such that its antipode is an isomorphism, there exists a categorical equivalence between the category of Hopf algebras in ${ }_{H}^{H} \mathrm{YD}$ and the category of Hopf algebra projections over $H$, where ${ }_{H}^{H} \mathrm{YD}$ denotes the category of Yetter-Drinfeld modules over $H$ and a Hopf algebra projection over $H$ is a pair of Hopf algebra morphisms, $f: H \rightarrow B$ and $g: B \rightarrow H$, satisfying that $g \circ f=i d_{H}$. Therefore, taking into account the above mentioned results, to construct a solution of the QYBE it is enough to have a Hopf algebra projection.

On the other hand, in [8] Drinfeld proposed to focus on the task of obtained set-theoretical solutions of the QYBE, which are those where a solution $c$ is a linear map induced by a mapping $\bar{c}: X \times X \rightarrow X \times X$, where $X$ is a set (in this situation, $V$ is the $\mathbb{F}$-vector space spanned by $X$ ). The study of this kind of solutions was pursued subsequently by several authors, for example, Etingof, Schedler and Soloviev in 9 or Gateva-Ivanova in [12]. With this aim, the notion of brace was introduced by Rump in [21] and then generalized by Guarnieri and Vendramin in [16] for the non-abelian setting obtaining the concept of skew brace. A skew brace is a pair of groups $(G, \star)$ and $(G, \circ)$ which satisfies the following compatibility condition:

\end{equation*}

for all $g, h, t \in G$ and where $g^{-1}$ denotes the inverse of $g$ with regard to the group structure $(G, \star)$. In such paper the authors obtain that every skew brace induce a set-theoretical solution of the QYBE not always involutive, i.e., the inverse of such solution $c$ is not necessarily $c$.

The quantum version of a skew brace is what is known by a Hopf brace, objects introduced by Angiono, Galindo and Vendramin in [2]. Then, a Hopf brace is a pair of Hopf algebras sharing the underlying coalgebra structure, $H_{1}=(H, 1, \cdot, \epsilon, \Delta, \lambda)$ and $H_{2}=\left(H, 1_{\circ}, \circ, \epsilon, \Delta, S\right)$, which satisfy the following compatibility condition between the products:

g \circ(h \cdot t)=\left(g_{1} \circ h\right) \cdot \lambda\left(g_{2}\right) \cdot\left(g_{3} \circ t\right) \tag{2}
\end{equation*}

for all $g, h, t \in H$. As it occurs with skew braces, the subclass of the cocommutative Hopf braces also induce solutions of the QYBE (see [2, Corollary 2.4]).

Recently, by combining the two previously mentioned approaches to obtaining solutions for the QYBE, Fernández Vilaboa et al. in [11] studied the theory of projections in the Hopf brace setting, introducing the notion of Hopf brace projection, a suitable definition for the category of Yetter-Drinfeld modules over a Hopf brace and extending the correspondence of Radford-Majid-Bespalov to this framework.

Since the appearence of Hopf braces, another structures related with them have emerged. The first we will mention are invertible 1-cocycles, which appeared initially in Angiono's et al. article [2]. Mixing [2, Theorem 1.12] and [15, Theorem 3.2], it was proved that the categories of invertible 1-cocycles and Hopf braces are equivalent. Also, Brzeziński in [6] generalized the Hopf brace structure by modifying (22) using a cocycle, what gave rise to the notion of Hopf truss. Besides, recently in [18], Li, Sheng and Tang introduced the categories of post-Hopf algebras and relative Rota-Baxter operators. Regarding post-Hopf algebras, Fernández Vilaboa, González Rodríguez and Ramos Pérez proved in [10] that the category of Hopf braces and a certain subcategory of post-Hopf algebras are isomorphic in the cocommutative setting. On the other hand, relative Rota-Baxter operators are a generalization of the notion of Rota-Baxter operator given by Goncharov in [13] for cocommutative Hopf algebras. In [18, Theorem 3.3] it was proved that there exists an adjunction between the category of post-Hopf algebras and the category of relative Rota-Baxter operators in a cocommutative context and, as a consequence of the above mentioned isomorphism between Hopf braces and post-Hopf algebras, this adjunction also holds between the category of Hopf braces and the category of relative Rota-Baxter operators under cocommutativity.

Looking at all the background, it is not unreasonable to tackle the study of projections for the objects mentioned in the previous paragraphs and whose connection with Hopf braces is strong. So, this paper is devoted to study the theory of modules and projections for relative Rota-Baxter operators.

The paper is organized as follows: After an initial preliminary section, where we are going to fix the notation and remember the basic necessary notions for the development of the article, Section 2 is devoted to introduce the concept of module over a relative Rota-Baxter operator (Definition 2.8). In this section, first
we will prove that such category is symmetric monoidal under cocommutativity conditions and assuming that the base category is symmetric (Theorem 2.10). Then, some functorial results are proved in order to state a correspondence between the category of modules over a certain Hopf brace and the category of modules over a relative Rota-Baxter operator. Using such correspondence, in Theorem 2.18 it is shown that there exists an adjunction between the category of modules over an invertible relative Rota-Baxter operator and the category of modules over such Hopf brace, which induce an equivalence by assuming some additional conditions (see Theorem 2.20). Section 3 is devoted to introduce the category of projections for relative RotaBaxter operators (Definition 3.3). As happens between the category of Hopf braces and relative Rota-Baxter operators (see Theorem [2.7), in Thereom 3.13 we will see that there also exists an adjunction between their respective projection categories. To conclude the paper, we will define what a strong projection of relative Rota-Baxter operators is and we will prove that every such projection in the cocommutative setting gives rise to a module in the sense of Definition 2.8, as happens in the classical theory of Hopf algebra projections.

## 1. Preliminaries

From now on $C$ denotes a strict braided monoidal category with tensor product $\otimes$, unit object $K$ and braiding $c$. Considering that it is well known that every non-strict monoidal category is monoidal equivalent to a strict one, we can assume without loss of generality that the category $C$ is strict and then we omit explicitly the associativity and unit constraints. Thus, the results proved in this paper for objects and morphisms in C remain valid for every non-strict braided monoidal category which would include, for example, the category $\mathbb{F}$-Vect of vector spaces over a field $\mathbb{F}$, the category $R$-Mod of left modules over a commutative ring $R$, or the category Set of sets. If for all $M, N \in \mathrm{C}$ the braiding satisfies that $c_{N, M} \circ c_{M, N}=i d_{M \otimes N}$, where $i d$ denotes the identity morphism, we will say that $C$ is symmetric. In what follows, for simplicity of notation, given objects $M, N, P$ in C and a morphism $f: M \rightarrow N$, we write $P \otimes f$ for $i d_{P} \otimes f$ and $f \otimes P$ for $f \otimes i d_{P}$.

Definition 1.1. An algebra in C is a triple $A=\left(A, \eta_{A}, \mu_{A}\right)$ where $A$ is an object in the category C and $\eta_{A}: K \rightarrow A$ (unit), $\mu_{A}: A \otimes A \rightarrow A$ (product) are morphisms in $C$ such that $\mu_{A} \circ\left(A \otimes \eta_{A}\right)=i d_{A}=$ $\mu_{A} \circ\left(\eta_{A} \otimes A\right), \mu_{A} \circ\left(A \otimes \mu_{A}\right)=\mu_{A} \circ\left(\mu_{A} \otimes A\right)$. Given two algebras $A=\left(A, \eta_{A}, \mu_{A}\right)$ and $B=\left(B, \eta_{B}, \mu_{B}\right)$, a morphism $f: A \rightarrow B$ in C is an algebra morphism if $\mu_{B} \circ(f \otimes f)=f \circ \mu_{A}, f \circ \eta_{A}=\eta_{B}$.

If $A, B$ are algebras in C , the tensor product $A \otimes B$ is also an algebra in C where $\eta_{A \otimes B}:=\eta_{A} \otimes \eta_{B}$ and $\mu_{A \otimes B}:=\left(\mu_{A} \otimes \mu_{B}\right) \circ\left(A \otimes c_{B, A} \otimes B\right)$.

A coalgebra in C is a triple $D=\left(D, \varepsilon_{D}, \delta_{D}\right)$ where $D$ is an object in C and $\varepsilon_{D}: D \rightarrow K$ (counit), $\delta_{D}: D \rightarrow D \otimes D$ (coproduct) are morphisms in C such that $\left(\varepsilon_{D} \otimes D\right) \circ \delta_{D}=i d_{D}=\left(D \otimes \varepsilon_{D}\right) \circ \delta_{D}$, $\left(\delta_{D} \otimes D\right) \circ \delta_{D}=\left(D \otimes \delta_{D}\right) \circ \delta_{D}$. If $D=\left(D, \varepsilon_{D}, \delta_{D}\right)$ and $E=\left(E, \varepsilon_{E}, \delta_{E}\right)$ are coalgebras, a morphism $f: D \rightarrow E$ in $C$ is a coalgebra morphism if $(f \otimes f) \circ \delta_{D}=\delta_{E} \circ f, \varepsilon_{E} \circ f=\varepsilon_{D}$.

Given $D, E$ coalgebras in $C$, the tensor product $D \otimes E$ is a coalgebra in $C$ where $\varepsilon_{D \otimes E}:=\varepsilon_{D} \otimes \varepsilon_{E}$ and $\delta_{D \otimes E}:=\left(D \otimes c_{D, E} \otimes E\right) \circ\left(\delta_{D} \otimes \delta_{E}\right)$.

Definition 1.2. Let $D=\left(D, \varepsilon_{D}, \delta_{D}\right)$ be a coalgebra and $A=\left(A, \eta_{A}, \mu_{A}\right)$ an algebra in C. By $\operatorname{Hom}(D, A)$ we denote the set of morphisms $f: D \rightarrow A$ in C. With the convolution operation $f * g=\mu_{A} \circ(f \otimes g) \circ \delta_{D}$, $\operatorname{Hom}(D, A)$ is an algebra where the unit element is $\eta_{A} \circ \varepsilon_{D}=\varepsilon_{D} \otimes \eta_{A}$.

Definition 1.3. Let $A$ be an algebra. The pair $\left(M, \varphi_{M}\right)$ is a left $A$-module if $M$ is an object in $C$ and $\varphi_{M}$ : $A \otimes M \rightarrow M$ is a morphism in C satisfying $\varphi_{M} \circ\left(\eta_{A} \otimes M\right)=i d_{M}, \varphi_{M} \circ\left(A \otimes \varphi_{M}\right)=\varphi_{M} \circ\left(\mu_{A} \otimes M\right)$. Given two left $A$-modules $\left(M, \varphi_{M}\right)$ and $\left(N, \varphi_{N}\right), f: M \rightarrow N$ is a morphism of left $A$-modules if $\varphi_{N} \circ(A \otimes f)=f \circ \varphi_{M}$. We will denote the category of left $A$-modules by ${ }_{A} \mathrm{Mod}$.

Let $D$ be a coalgebra. The pair $\left(M, \rho_{M}\right)$ is a left $D$-comodule if $M$ is an object in C and $\rho_{M}: M \rightarrow D \otimes M$ is a morphism in C satisfying $\left(\varepsilon_{D} \otimes M\right) \circ \rho_{M}=i d_{M},\left(D \otimes \rho_{M}\right) \circ \rho_{M}=\left(\delta_{D} \otimes M\right) \circ \rho_{M}$. Given two left $D$-comodules $\left(M, \rho_{M}\right)$ and $\left(N, \rho_{N}\right), f: M \rightarrow N$ is a morphism of left $D$-comodules if $(D \otimes f) \circ \rho_{M}=\rho_{N} \circ f$. We will denote the category of left $D$-comodules by ${ }^{D}$ Comod.

In a similar way we can define the notions of right $A$-module and right $D$-comodule.
Definition 1.4. We say that $X$ is a bialgebra in C if $\left(X, \eta_{X}, \mu_{X}\right)$ is an algebra, $\left(X, \varepsilon_{X}, \delta_{X}\right)$ is a coalgebra, and $\varepsilon_{X}$ and $\delta_{X}$ are algebra morphisms (equivalently, $\eta_{X}$ and $\mu_{X}$ are coalgebra morphisms). Moreover, if
there exists a morphism $\lambda_{X}: X \rightarrow X$ in C, called the antipode of $X$, satisfying that $\lambda_{X}$ is the inverse of $i d_{X}$ in $\operatorname{Hom}(X, X)$, i.e.,

$$
\begin{equation*}
i d_{X} * \lambda_{X}=\eta_{X} \circ \varepsilon_{X}=\lambda_{X} * i d_{X} \tag{3}
\end{equation*}
$$

we say that $X$ is a Hopf algebra. A morphism of Hopf algebras is an algebra-coalgebra morphism. Note that, if $f: X \rightarrow Y$ is a Hopf algebra morphism the following equality holds:

$$
\begin{equation*}
\lambda_{Y} \circ f=f \circ \lambda_{X} \tag{4}
\end{equation*}

With the composition of morphisms in C we can define a category whose objects are Hopf algebras and whose morphisms are morphisms of Hopf algebras. We denote this category by Hopf.

A Hopf algebra is commutative if $\mu_{X} \circ c_{X, X}=\mu_{X}$ and cocommutative if $c_{X, X} \circ \delta_{X}=\delta_{X}$. In both cases $\lambda_{X} \circ \lambda_{X}=i d_{X}$ and also, by [22, Corollary 5], the identity

holds.
If $X$ is a Hopf algebra, we have the following relevant properties of its antipode $\lambda_{X}$ : It is antimultiplicative and anticomultiplicative

\lambda_{X} \circ \mu_{X} & =\mu_{X} \circ\left(\lambda_{X} \otimes \lambda_{X}\right) \circ c_{X, X}  \tag{6}\\
\delta_{X} \circ \lambda_{X} & =c_{X, X} \circ\left(\lambda_{X} \otimes \lambda_{X}\right) \circ \delta_{X} \tag{7}
\end{align*}
$$

and leaves the unit and counit invariant, i.e.,

$$
\begin{align*}
& \lambda_{X} \circ \eta_{X}=\eta_{X}  \tag{8}\\
& \varepsilon_{X} \circ \lambda_{X}=\varepsilon_{X} \tag{9}
\end{align*}
$$

So, it is a direct consequence of these identities that, if $X$ is commutative, then $\lambda_{X}$ is an algebra morphism and, if $X$ is cocommutative, then $\lambda_{X}$ is a coalgebra morphism.

In the following definitions we recall the notion of left (co)module (co)algebra.
Definition 1.5. Let $X$ be a Hopf algebra. An algebra $A$ is said to be a left $X$-module algebra if $\left(A, \varphi_{A}\right)$ is a left $X$-module and $\eta_{A}, \mu_{A}$ are morphisms of left $X$-modules, i.e.,

\begin{array}{r}
\varphi_{A} \circ\left(X \otimes \eta_{A}\right)=\varepsilon_{X} \otimes \eta_{A} \\
\varphi_{A} \circ\left(X \otimes \mu_{A}\right)=\mu_{A} \circ \varphi_{A \otimes A} \tag{11}
\end{array}
$$

where $\varphi_{A \otimes A}:=\left(\varphi_{A} \otimes \varphi_{A}\right) \circ\left(X \otimes c_{X, A} \otimes A\right) \circ\left(\delta_{X} \otimes A \otimes A\right)$ is the left action on $A \otimes A$.
On the other hand, $A$ is said to be a left $X$-comodule algebra if $\left(A, \rho_{A}\right)$ is a left $X$-comodule and $\eta_{A}$ and $\mu_{A}$ are morphisms of left $X$-comodules, i.e.,

\begin{gather*}
\rho_{A} \circ \eta_{A}=\eta_{X} \otimes \eta_{A}  \tag{12}\\
\rho_{A} \circ \mu_{A}=\left(X \otimes \mu_{A}\right) \circ \rho_{A \otimes A} \tag{13}
\end{gather*}

where $\rho_{A \otimes A}:=\left(\mu_{X} \otimes A \otimes A\right) \circ\left(H \otimes c_{A, X} \otimes A\right) \circ\left(\rho_{A} \otimes \rho_{A}\right)$ is the coaction on $A \otimes A$. Equivalently, $\left(A, \rho_{A}\right)$ is a left $X$-comodule algebra if and only if $\rho_{A}$ is an algebra morphism.
Definition 1.6. Let $X$ be a Hopf algebra. A coalgebra $D$ is said to be a left $X$-module coalgebra if ( $D, \varphi_{D}$ ) is a left $X$-module and $\varepsilon_{D}, \delta_{D}$ are morphisms of left $X$-modules, in other words, the following equalities hold:

\varepsilon_{D} \circ \varphi_{D}=\varepsilon_{X} \otimes \varepsilon_{D}  \tag{14}\\
\delta_{D} \circ \varphi_{D}=\varphi_{D \otimes D} \circ\left(X \otimes \delta_{D}\right) \tag{15}
\end{gather*}
$$

Equivalently, $\left(D, \varphi_{D}\right)$ is a left $X$-module coalgebra if and only if $\varphi_{D}$ is a coalgebra morphism.
Finally, a coalgebra $D$ is said to be a left $X$-comodule coalgebra if $\left(D, \rho_{D}\right)$ is a left $X$-comodule and $\varepsilon_{D}$ and $\delta_{D}$ are morphisms of left $X$-comodules, i.e.,

\begin{gather*}
\left(X \otimes \varepsilon_{D}\right) \circ \rho_{D}=\eta_{X} \otimes \varepsilon_{D}  \tag{16}\\
\left(X \otimes \delta_{D}\right) \circ \rho_{D}=\rho_{D \otimes D} \circ \delta_{D} \tag{17}
\end{gather*}
$$

Example 1.7. Every Hopf algebra $X$ in $C$ has a structure of left module algebra over itself with the so called adjoint action

$$
\varphi_{X}^{a d}:=\mu_{X} \circ\left(\mu_{X} \otimes \lambda_{X}\right) \circ\left(X \otimes c_{X, X}\right) \circ\left(\delta_{X} \otimes X\right)
$$

If $X$ is also cocommutative, then $\left(X, \varphi_{X}^{a d}\right)$ is a left $X$-module algebra-coalgebra. Moreover, $X$ is a left $X$-comodule coalgebra with the adjoint coaction $\rho_{X}^{a d}:=\left(\mu_{X} \otimes X\right) \circ\left(X \otimes c_{X, X}\right) \circ\left(\delta_{X} \otimes \lambda_{X}\right) \circ \delta_{X}$.

## 2. Relative Rota-Baxter operators and their modules

The present section of this paper is devoted to introduce what a module over a relative Rota-Baxter operator is. Relative Rota-Baxter operators have been introduced considering the underlying category $C=\mathbb{F}$-Vect by Li, Sheng and Tang in [18] as a generalization of Rota-Baxter operators defined by Goncharov in 13 for cocommutative Hopf algebras.

First of all we start by remembering the notion and basic properties of relative Rota-Baxter operators, as well as the strong relationship between these structures and Hopf braces, and we show that the category formed by this objects is symmetric monoidal.

After that we will focus on the study of modules over a relative Rota-Baxter operator, giving a definition that allow us to show that there exists an adjunction between the category of modules over a Hopf brace (using the definition of these objects introduced by González in [14) and the category of modules over an invertible relative Rota-Baxter operator assuming cocommutativity. The section will finish by proving that, under certain additional hypothesis, the previous adjunction gives rise to an equivalence of categories.

Definition 2.1. Let $H=\left(H, \eta_{H}, \mu_{H}, \varepsilon_{H}, \delta_{H}, \lambda_{H}\right)$ and $B=\left(B, \eta_{B}, \mu_{B}, \varepsilon_{B}, \delta_{B}, \lambda_{B}\right)$ be Hopf algebras in C such that $\left(H, \varphi_{H}\right)$ is a left $B$-module algebra-coalgebra. We will say that a coalgebra morphism $T: H \rightarrow B$ is a relative Rota-Baxter operator if the following condition holds:

\begin{equation*}
\mu_{B} \circ(T \otimes T)=T \circ \mu_{H} \circ\left(H \otimes\left(\varphi_{H} \circ(T \otimes H)\right)\right) \circ\left(\delta_{H} \otimes H\right) . \tag{18}
\end{equation*}
$$

In what follows we will denote relative Rota-Baxter operators by $\left.\left(\begin{array}{c}H \\ T \\ \downarrow \\ \\ B\end{array}\right), \varphi_{H}\right)$. If $\left.\left(\begin{array}{c}H \\ T \\ \\ \\ B\end{array}\right), \varphi_{H}\right)$ and $\left.\left(\begin{array}{c}A \\ L \\ \downarrow \\ D\end{array}\right), \varphi_{A}\right)$ are relative Rota-Baxter operators, a morphism between them is a pair $(f, h)$ where $f: H \rightarrow A$ and $h: B \rightarrow D$ are Hopf algebra morphisms and the following conditions hold:

Considering the natural composition of morphisms, relative Rota-Baxter operators give rise to a category that we will denote by $r$ RB. Moreover, we will denote by $r \mathrm{RB}^{\star}$ to the full subcategory of $r$ RB whose objects are relative Rota-Baxter operators $\left(\begin{array}{c}H \\ T \\ \\ \\ B\end{array},, \varphi_{H}\right)$ such that $H$ is cocommutative, and by coc-rRB to the full subcategory of $r \mathrm{RB}^{\star}$ satisfying that both Hopf algebras involved, $H$ and $B$, are cocommutative.

An important property of relative Rota-Baxter operators is that they preserve the unit. This will be proven in the following result.

Moreover, $\left(H \otimes A, \varphi_{H \otimes A}\right)$ is a left $B \otimes D$-module algebra-coalgebra. Indeed, on the one side, the left module axioms are straightforward thanks to naturality of $c$. After proving these general properties which relative Rota-Baxter operators satisfy, we will see that under suitable conditions there exists a functorial link between relative Rota-Baxter operators and Hopf braces. First we will remember the definition of Hopf brace and its main properties.
Definition 2.4. Let $H=\left(H, \varepsilon_{H}, \delta_{H}\right)$ be a coalgebra in C. Let's assume that there are two algebra structures $\left(H, \eta_{H}^{1}, \mu_{H}^{1}\right),\left(H, \eta_{H}^{2}, \mu_{H}^{2}\right)$ defined on $H$ and suppose that there exist two endomorphism of $H$ denoted by $\lambda_{H}^{1}$ and $\lambda_{H}^{2}$. Definition 2.5. If $\mathbb{H}$ is a Hopf brace in $C$, we will say that $\mathbb{H}$ is cocommutative if $\delta_{H}=c_{H, H} \circ \delta_{H}$, i.e., if $H_{1}$ and $H_{2}$ are cocommutative Hopf algebras in C.

Definition 2.6. Given two Hopf braces $\mathbb{H}$ and $\mathbb{D}$ in C , a morphism $x$ in C between the two underlying objects is called a morphism of Hopf braces if both $x: H_{1} \rightarrow D_{1}$ and $x: H_{2} \rightarrow D_{2}$ are Hopf algebra morphisms.

Hopf braces together with morphisms of Hopf braces form a category which we denote by HBr . Moreover, cocommutative Hopf braces constitute a full subcategory of HBr which we will denote by coc- HBr .

Moreover, in our braided context [2, Lemma 1.8] and [2, Remark 1.9] hold and then we have that the algebra $\left(H, \eta_{H}, \mu_{H}^{1}\right)$ is a left $H_{2}$-module algebra with action $\Gamma_{H_{1}}$ and $\mu_{H}^{2}$ admits the following expression:

We do the proof in detail to clarify certain properties and notations that will be very useful in the rest of the paper.

Theorem 2.7. There exists a functor $\mathrm{F}:$ coc $-\mathrm{HBr} \longrightarrow \mathrm{rRB}$ defined on objects by

If $\mathbb{H}=\left(H_{1}, H_{2}\right)$ is a cocommutative Hopf brace in C, then we already know that $\left(H_{1}, \Gamma_{H_{1}}\right)$ is a left $H_{2}$-module algebra and, thanks to the cocommutativity, $\Gamma_{H_{1}}$ is a coalgebra morphism, i.e., $\left(H_{1}, \Gamma_{H_{1}}\right)$ is a left $H_{2}$-module algebra-coalgebra. Moreover, (23) implies that (18) holds. Therefore, $\left(\begin{array}{cc} & H_{1} \\ i d_{H} & \downarrow \\ & H_{2}\end{array}, \Gamma_{H_{1}}\right)$ is a relative Rota-Baxter operator. In addition, if $\mathbb{D}$ is another cocommutative Hopf brace and $x: \mathbb{H} \rightarrow \mathbb{D}$ is a morphism of Hopf braces, then the pair $(x, x)$ is a morphism of relative Rota-Baxter operators between $\left(\begin{array}{ccc} & H_{1} & \\ i d_{H} & \downarrow \\ & H_{2}\end{array}, \Gamma_{H_{1}}\right)$ and $\left(\begin{array}{ccc} & D_{1} \\ i d_{D} & \downarrow & \\ & D_{2}\end{array}, \Gamma_{D_{1}}\right)$. Therefore, with the obvious composition of morphisms, left modules over the relative Rota-Baxter operator $\left(\begin{array}{cc}H \\ T & \downarrow \\ B\end{array}, \varphi_{H}\right)$ constitute a category that we will denote by ${ }_{\left(T, \varphi_{H}\right)} \operatorname{Mod}$.

Let's recall the notion of module over a Hopf brace introduced in [14] and some results related with this concept which can be consulted in [11].

Definition 2.12. Let $\mathbb{H}=\left(H_{1}, H_{2}\right)$ be a Hopf brace. We will say that a triple $\left(M, \psi_{M}^{1}, \psi_{M}^{2}\right)$ is a left module over $\mathbb{H}$ if $\left(M, \psi_{M}^{1}\right)$ is a left $H_{1}$-module, $\left(M, \psi_{M}^{2}\right)$ is a left $H_{2}$-module and the following compatibility condition holds:

If $\left(M, \psi_{M}^{1}, \psi_{M}^{2}\right)$ and $\left(N, \psi_{N}^{1}, \psi_{N}^{2}\right)$ are modules over the Hopf brace $\mathbb{H}$ and $f: M \rightarrow N$ is a morphism between them, we will say that $f$ is a morphism of left $\mathbb{H}$-modules if $f$ is a morphism of left $H_{1}$-modules and left $H_{2}$-modules.

Then, with the obvious composition of morphisms, modules over $\mathbb{H}$ constitute a category that we will denote by ${ }_{\mathbb{H}}$ Mod.

Remark 2.13. Let $\left(M, \psi_{M}^{1}, \psi_{M}^{2}\right)$ be a left module over a Hopf brace $\mathbb{H}$. Composing on the right hand side of (27) with $H \otimes \eta_{H} \otimes M$ we obtain that the equality

Proof. At first we are going to prove that if $\left(M, \psi_{M}^{1}, \psi_{M}^{2}\right)$ is a left module the Hopf brace $\mathbb{H}$, then the 6 -tuple $\left(M, M, \psi_{M}^{1}, \Gamma_{M}, \psi_{M}^{2}, i d_{M}\right)$ is a left module over the relative Rota-Baxter operator $\mathrm{F}(\mathbb{H})$. Indeed, on the one hand, (25) follows by (29) and, on the other hand, (26) follows by (28). Therefore, W is well-defined on objects.

On the other hand, if $f:\left(M, \psi_{M}^{1}, \psi_{M}^{2}\right) \rightarrow\left(N, \psi_{N}^{1}, \psi_{N}^{2}\right)$ is a morphism of left $\mathbb{H}$-modules, then $(f, f)$ is a morphism in ${ }_{\left(i d_{H}, \Gamma_{H_{1}}\right)} \operatorname{Mod}$ between $\left(M, M, \psi_{M}^{1}, \Gamma_{M}, \psi_{M}^{2}, i d_{M}\right)$ and $\left(N, N, \psi_{N}^{1}, \Gamma_{N}, \psi_{N}^{2}, i d_{N}\right)$, what follows by the fact that $f:\left(M, \Gamma_{M}\right) \rightarrow\left(N, \Gamma_{N}\right)$ is a morphism of left $H_{2}$-modules, which is straightforward to show.

Corollary 2.16. Let $\left(\begin{array}{c}H \\ T \\ \downarrow \\ B\end{array}, \varphi_{H}\right)$ be a relative Rota-Baxter operator in $\mathrm{rRB}^{\star}$. If $T: H \rightarrow B$ is an isomorphism, then there exists a functor

Definition 2.19. Let $\left(\begin{array}{c}H \\ T \\ \\ \\ B\end{array}, \varphi_{H}\right)$ be a relative Rota-Baxter operator. We will define ${ }_{\left(T, \varphi_{H}\right)}$ Mod $^{\text {iso }}$ as the full subcategory of ${ }_{\left(T, \varphi_{H}\right)}$ Mod whose objects, $\left(M, N, \phi_{M}, \varphi_{M}, \varphi_{N}, \gamma\right)$, satisfy that $\gamma: M \rightarrow N$ is an isomorphism in C.

Theorem 2.20. Let $\left(\begin{array}{c}H \\ T \\ \downarrow \\ B\end{array}, \varphi_{H}\right)$ be a relative Rota-Baxter operator in $\mathrm{rRB}^{\star}$ such that $T: H \rightarrow B$ is an isomorphism. The categories ${ }_{\left(T, \varphi_{H}\right)}$ Mod $^{\text {iso }}$ and $\overline{\mathbb{H}}^{\operatorname{Mod}}$ are equivalent.

Proof. Define the functor $\mathrm{U}^{\prime}$ as the restriction of U to ${ }_{\left(T, \varphi_{H}\right)} \mathrm{Mod}^{\text {iso }}$. It result straightforward to show that

On the other hand, consider $\left(M, N, \phi_{M}, \varphi_{M}, \varphi_{N}, \gamma\right)$ in $_{\left(T, \varphi_{H}\right)}$ Mod $^{\text {iso }}$. We have that

Indeed, to show that $\left(i d_{M}, \gamma^{-1}\right)$ is a morphism in $_{\left(T, \varphi_{H}\right)}$ Mod it is enough to see that $\gamma^{-1}:\left(N, \varphi_{N}\right) \rightarrow\left(M, \bar{\varphi}_{M} \circ\left(T^{-1} \otimes M\right)\right)$ is a morphism of left $B$-modules,
what follows by

Corollary 2.21. Let $\mathbb{H}$ be a cocommutative Hopf brace. The category $\left(_{\left(i d_{H}, \Gamma_{H_{1}}\right)} \operatorname{Mod}^{\text {iso }}\right.$ is equivalent to $\mathbb{H}_{\mathbb{H}} \operatorname{Mod}$.
Proof. The proof is a direct consequence of previous theorem taking into account that $(G \circ F)(\mathbb{H})=\mathbb{H}$, where F and G are the functors introduced in Theorem 2.7.

## 3. Projections of relative Rota-Baxter operators

This section is devoted to the study of projections between relative Rota-Baxter operators. A projection between this kind of objects involves projections of Hopf algebras. Then, at the beginning of this section we will make a brief summary of the basic theory linked to projections of Hopf algebras including the Yetter-Drinfeld modules following [1], [19] and [20].
Definition 3.1. Let $X$ be a Hopf algebra in C. We shall denote by ${ }_{X}^{X} Y D$ the category of left Yetter-Dinfeld modules over $X$. More concretely, a triple $M=\left(M, \varphi_{M}, \rho_{M}\right)$ is an object in ${ }_{\mathrm{X}} \mathrm{YD}$ if $\left(M, \varphi_{M}\right)$ is a left $X$-module, $\left(M, \rho_{M}\right)$ is a left $X$-comodule and the following identity

$$
\begin{align*}
\left(\mu_{X} \otimes M\right) & \circ\left(X \otimes c_{M, X}\right) \circ\left(\left(\rho_{M} \circ \varphi_{M}\right) \otimes X\right) \circ\left(X \otimes c_{X, M}\right) \circ\left(\delta_{X} \otimes M\right)  \tag{31}\\
& =\left(\mu_{X} \otimes \varphi_{M}\right) \circ\left(X \otimes c_{X, X} \otimes M\right) \circ\left(\delta_{X} \otimes \rho_{M}\right) .
\end{align*}
$$

holds. The morphisms in ${ }_{\mathrm{X}}^{\mathrm{X}} \mathrm{YD}$ are morphisms of left $X$-modules and left $X$-comodules.
For example, for any Hopf algebra $X,\left(X, \varphi_{X}^{a d}, \rho_{X}=\delta_{X}\right)$ and $\left(X, \varphi_{X}=\mu_{X}, \rho_{X}^{a d}\right)$ are left Yetter-Drinfeld modules over $X$. Also, any left $X$-module $\left(M, \varphi_{M}\right)$ over a cocommutative Hopf algebra $X$ is a Yetter-Drinfeld module with the trivial left coaction $\rho_{M}=\eta_{X} \otimes M$. Finally, the triple $\left(M, \varphi_{M}=\varepsilon_{X} \otimes M, \rho_{M}=\eta_{X} \otimes M\right)$ is a left Yetter-Drinfeld module for all Hopf algebra $X$.

The category ${ }_{X}^{\mathrm{X}} \mathrm{YD}$ is strict monoidal with the usual tensor product in C , that is to say, for $M, N$ in ${ }_{\mathrm{X}}^{\mathrm{X}} \mathrm{YD}$, $M \otimes N$ is a left Yetter-Drinfeld module over $X$ with the tensor module and comodule structures given by

$$

\varphi_{M \otimes N} & =\left(\varphi_{M} \otimes \varphi_{N}\right) \circ\left(X \otimes c_{X, M} \otimes N\right) \circ\left(\delta_{X} \otimes M \otimes N\right), \\
\rho_{M \otimes N} & =\left(\mu_{X} \otimes M \otimes N\right) \circ\left(X \otimes c_{M, X} \otimes N\right) \circ\left(\rho_{M} \otimes \rho_{N}\right) .
\end{aligned}
$$

If the antipode of $X$ is an isomorphism, ${ }_{\mathrm{X}}^{\mathrm{X}} \mathrm{YD}$ is a braided monoidal category category where the braiding $t_{M, N}: M \otimes N \rightarrow N \otimes N$ is given by $t_{M, N}=\left(\varphi_{N} \otimes M\right) \circ\left(X \otimes c_{M, N}\right) \circ\left(\rho_{M} \otimes N\right)$. It is immediate to see that $t_{M, N}$ is natural and it is an isomorphism with inverse

t_{M, N}^{-1}=c_{M, N}^{-1} \circ\left(\varphi_{N} \otimes M\right) \circ\left(\lambda_{X}^{-1} \otimes N \otimes M\right) \circ\left(c_{X, N}^{-1} \otimes M\right) \circ\left(N \otimes \rho_{M}\right)
$$

Definition 3.2. A projection of Hopf algebras in C is a 4-tuple $(X, Y, f, g)$ where $X, Y$ are Hopf algebras, and $f: X \rightarrow Y, g: Y \rightarrow X$ are Hopf algebra morphisms such that $g \circ f=i d_{X}$.

A morphism between projections of Hopf algebras $(X, Y, f, g)$ and $\left(X^{\prime}, Y^{\prime}, f^{\prime}, g^{\prime}\right)$ is a pair $(x, y)$, where $x: X \rightarrow X^{\prime}, y: Y \rightarrow Y^{\prime}$ are Hopf algebra morphisms such that

$$
\begin{equation*}
y \circ f=f^{\prime} \circ x, \quad x \circ g=g^{\prime} \circ y \tag{32}
\end{equation*}
$$

With the obvious composition of morphisms we can define a category whose objects are Hopf algebra projections and whose morphisms are morphisms of Hopf algebra projections. We denote this category by P(Hopf).

It is obvious that there exists a functor $\mathrm{P}_{\text {triv }}$ : Hopf $\rightarrow \mathrm{P}($ Hopf $)$ defined on objects by $\mathrm{P}_{\text {triv }}(X)=$ $\left(X, X, i d_{X}, i d_{X}\right)$ and on morphisms by $\mathrm{P}(f)=(f, f)$.

Let $(X, Y, f, g)$ be an object in $\mathrm{P}($ Hopf $)$. The morphism $q_{Y}:=i d_{Y} *\left(f \circ \lambda_{X} \circ g\right)$ is idempotent and, as a consequence, there exists an object $I\left(q_{Y}\right)$, called the object of coinvariants, an epimorphism $p_{Y}$ and a monomorphism $i_{Y}$ such that $q_{Y}=i_{Y} \circ p_{Y}$ and $p_{Y} \circ i_{Y}=i d_{I\left(q_{Y}\right)}$. As a consequence,

$$
I\left(q_{Y}\right) \xrightarrow{i_{Y}} Y \underset{Y \otimes \eta_{X}}{\stackrel{(Y \otimes g) \circ \delta_{Y}}{\longrightarrow}} Y \otimes X
$$

is an equalizer diagram and $I\left(q_{Y}\right)$ is a left $X$-module algebra where the algebra structure is defined by

i.e., $\eta_{I\left(q_{Y}\right)}$ is the unique morphism such that $i_{Y} \circ \eta_{I\left(q_{Y}\right)}=\eta_{Y}$ and $\mu_{I\left(q_{Y}\right)}$ is the unique morphism such that

The action $\psi_{I\left(q_{Y}\right)}: X \otimes I\left(q_{Y}\right) \rightarrow I\left(q_{Y}\right)$ is $\psi_{I\left(q_{Y}\right)}=p_{Y} \circ \mu_{Y} \circ\left(f \otimes i_{Y}\right)$, and then $\psi_{I\left(q_{Y}\right)}$ is the unique morphism such that

is a coequalizer diagram and, as a consequence, $I\left(q_{Y}\right)$ is a left $X$-comodule coalgebra with

and coaction $\rho_{I\left(q_{Y}\right)}: I\left(q_{Y}\right) \rightarrow X \otimes I\left(q_{Y}\right)$ defined by

In this case $\varepsilon_{I\left(q_{Y}\right)}$ is the unique morphism such that $\varepsilon_{I\left(q_{Y}\right)} \circ p_{Y}=\varepsilon_{Y}, \delta_{I\left(q_{Y}\right)}$ is the unique morphism such that

\delta_{I\left(q_{Y}\right)} \circ p_{Y}=\left(p_{Y} \otimes p_{Y}\right) \circ \delta_{Y} \tag{37}

and the coaction $\rho_{I\left(q_{Y}\right)}$ is the unique morphism satisfying

The algebra-coalgebra $I\left(q_{Y}\right)$, with the action $\psi_{I\left(q_{Y}\right)}$ and the coaction $\rho_{I\left(q_{Y}\right)}$, is a Hopf algebra in $X_{X}^{X}$ with antipode

$$
\lambda_{I\left(q_{Y}\right)}=\psi_{I\left(q_{Y}\right)} \circ\left(X \otimes\left(p_{Y} \circ \lambda_{Y} \circ i_{Y}\right)\right) \circ \rho_{I\left(q_{Y}\right)}
$$

Also, using that $i_{Y}$ is an equalizer morphism and $p_{Y}$ is a coequalizer, we obtain the following identities:

Note that $i_{Y}$ is a coalgebra morphism iff

If $Y$ is cocommutative, condition (40) always holds. This fact was proved by Sweedler in [23] for projections of Hopf algebras in a category of vector spaces. On the other hand, there exist examples where $i_{Y}$ is not a coalgebra morphism (see [5] for the complete details). In any case, if $i_{Y}$ is a coalgebra morphism, then we have that $I\left(q_{Y}\right)$ is a Hopf algebra in C because $\rho_{I\left(q_{Y}\right)}$ is trivial.

Similarly, $p_{Y}$ is an algebra morphism iff

$$
\begin{equation*}
p_{Y} \circ \mu_{Y} \circ\left(q_{Y} \otimes Y\right)=p_{Y} \circ \mu_{Y} \tag{41}
\end{equation*}
$$

Equivalently, $p_{Y}$ is an algebra morphism iff $\psi_{I\left(q_{Y}\right)}=\varepsilon_{X} \otimes I\left(q_{Y}\right)$ (see [1]). Therefore, if $p_{Y}$ is an algebra morphism, then we have that $I\left(q_{Y}\right)$ is a Hopf algebra in C because $\psi_{I\left(q_{Y}\right)}$ is trivial.

Finally, if $(X, Y, f, g)$ is in P (Hopf) and $Y$ is cocommutative, then the morphism $q_{Y}$ is a coalgebra morphism. Also, under these conditions, $i_{Y}$ is a coalgebra morphism and the following equality

$$
\begin{equation*}
i_{Y} \circ \lambda_{I\left(q_{Y}\right)}=\lambda_{Y} \circ i_{Y} \tag{42}
\end{equation*}
$$

holds (see [11]).
In the following definition the notion of projection between Hopf algebras is extended in order to introduce what a projection between relative Rota-Baxter operators is.
Definition 3.3. Let $\left(\begin{array}{c}H \\ T \\ \downarrow \\ B\end{array}, \varphi_{H}\right)$ and $\left(\begin{array}{c}A \\ L \\ \downarrow \\ D\end{array}, \varphi_{A}\right)$ be relative Rota-Baxter operators. We will say that a 6-tuple

hold. This category will be denoted by $\mathrm{P}(\mathrm{rRB})$.
By $P\left(r R B^{\star}\right)$ we will denote to the full subcategory of $P(r R B)$ where the involved relative Rota-Baxter operators are objects in $r$ RB $^{\star}$. Finally $P($ coc-rRB $)$ denotes the full subcategory of $P\left(r R B^{\star}\right)$ where the involved objects are cocommutative relative Rota-Baxter operators.

Let

Due to being $(H, A, f, g)$ and $(B, D, h, l)$ objects in P (Hopf) with $A$ and $D$ cocommutative, we know that the respective objects of coinvariants, $I\left(q_{A}\right)$ and $I\left(q_{D}\right)$, are Hopf algebras in $C$ and also the equalizers, $i_{A}$ and $i_{D}$, are coalgebra morphisms. Moreover, the morphism $L \circ i_{A}$ factors through the equalizer $i_{D}$ because

\end{aligned}
$$

Therefore, there exists an unique $\varphi_{I\left(q_{A}\right)}: I\left(q_{D}\right) \otimes I\left(q_{A}\right) \rightarrow I\left(q_{A}\right)$ satisfying that

Indeed, module axioms are straightforward thanks to (45) and module axioms for $\left(A, \varphi_{A}\right)$. Moreover, it is direct to compute that $\eta_{I\left(q_{A}\right)}$ is a morphism of left $I\left(q_{D}\right)$-modules and

Example 3.6. In [13, Goncharov proved that if $X$ is a cocommutative Hopf algebra, then

Note that, due to being $A$ cocommutative, by (42),

Proof. Functor P is well-defined on objects thanks to Theorem 3.4. Consider $(x, y, z, t)$ a morphism in $\mathrm{P}($ coc-rRB $)$ between

Then, P is also well-defined on morphisms.

In what follows we recall the notion of projection of Hopf braces introduced in [11].

Definition 3.8. A projection of Hopf braces in $C$ is a 4 -tuple $(\mathbb{H}, \mathbb{D}, x, y)$, where $\mathbb{H}, \mathbb{D}$ are Hopf braces in $C$, $x: \mathbb{H} \rightarrow \mathbb{D}, y: \mathbb{D} \rightarrow \mathbb{H}$ are morphisms of Hopf braces in C and the following equality $y \circ x=i d_{\mathbb{H}}$ holds.

A morphism between two projections of Hopf braces $(\mathbb{H}, \mathbb{D}, x, y)$ and $\left(\mathbb{H}^{\prime}, \mathbb{D}^{\prime}, x^{\prime}, y^{\prime}\right)$ is a pair $(z, t)$ where $z: \mathbb{H} \rightarrow \mathbb{H}^{\prime}, t: \mathbb{D} \rightarrow \mathbb{D}^{\prime}$ are morphisms in HBr and the following equalities hold:

With these morphisms and the previous objects we can define the category of projections of Hopf braces. We will denote this category by $\mathrm{P}(\mathrm{HBr})$. With $\mathrm{P}($ coc- HBr$)$ we will denote the category of projections between cocommutative Hopf braces.

Remark 3.9. Following [11], if $(\mathbb{H}, \mathbb{D}, x, y)$ is a projection of Hopf braces in C , then we have two projections of Hopf algebras $\left(H_{1}, D_{1}, x, y\right)$ and $\left(H_{2}, D_{2}, x, y\right)$. Then, with $q_{D}^{1}$ and $q_{D}^{2}$ we will denote the associated idempotent morphisms. Note that, if $q_{D}^{1}=i_{D}^{1} \circ p_{D}^{1}$ and $q_{D}^{2}=i_{D}^{2} \circ p_{D}^{2}$, with $p_{D}^{1} \circ i_{D}^{1}=i d_{I\left(q_{D}^{1}\right)}$ and $p_{D}^{2} \circ i_{D}^{2}=i d_{I\left(q_{D}^{2}\right)}$, we have that

is an equalizer diagram for $k \in\{1,2\}$ and, as a consequence, we can assume that $i_{D}^{1}=i_{D}^{2}=i_{D}$ and $I\left(q_{D}^{1}\right)=I\left(q_{D}^{2}\right)=I\left(q_{D}\right)$. Then, $p_{D}^{1} \circ i_{D}=i d_{I\left(q_{D}\right)}=p_{D}^{2} \circ i_{D}$ holds.

Just as there exists an adjunction between the category of relative Rota-Baxter operators, rRB*, and the category of cocommutative Hopf braces, coc- HBr (see Theorem 2.7), it seems reasonable to ask whether this adjunction carries over to their respective projection categories.

Theorem 3.10. There exists a functor

Proof. It follows by the fact that functor $\mathrm{F}:$ coc $-\mathrm{HBr} \longrightarrow \mathrm{rRB}$ * introduced in Theorem 2.7 is well-defined.
Remark 3.11. Note that the image of Q is in $\mathrm{P}($ coc-rRB $)$. Then if $I^{\star}: \mathrm{P}($ coc-rRB $) \longrightarrow \mathrm{P}\left(r \mathrm{RB}^{\star}\right)$ denotes the inclusion functor, we have that $\mathrm{Q}=I^{\star} \circ \mathrm{Q}^{\prime}$ where

Take $(z, t):(\mathbb{H}, \mathbb{D}, x, y) \rightarrow\left(\mathbb{H}^{\prime}, \mathbb{D}^{\prime}, x^{\prime}, y^{\prime}\right)$ a morphism of projections of Hopf braces and note that $t \circ i_{D}$ factors through the equalizer $i_{D^{\prime}}$ :

Proof. We only detail that the previous diagram is commutative on objects because the commutativity on morphisms is straightforward. where $\eta_{I\left(q_{\bar{A}}\right)}=\eta_{I\left(q_{A}\right)}, \mu_{I\left(q_{\bar{A}}\right)}^{1}=\mu_{I\left(q_{A}\right)}, \varepsilon_{I\left(q_{\bar{A}}\right)}=\varepsilon_{I\left(q_{A}\right)}, \delta_{I\left(q_{\bar{A}}\right)}=\delta_{I\left(q_{A}\right)}$ and $\lambda_{I\left(q_{\bar{A}}\right)}^{1}=\lambda_{I\left(q_{\bar{A}}\right)}$, while $\mu_{I\left(q_{\bar{A}}\right)}^{2}$ is the unique product satisfying that

Thus, to conclude the proof it is enough to show that $\bar{\mu}_{I\left(q_{A}\right)}=\mu_{I\left(q_{\bar{A}}\right)}^{2}$ what implies that $\bar{\lambda}_{I\left(q_{A}\right)}=\lambda_{I\left(q_{\bar{A}}\right)}^{2}$ due the uniqueness of the antipode for a bialgebra structure. Indeed,

As a conclusion, due to the fact that $i_{A}$ is a monomorphism, $\bar{\mu}_{I\left(q_{A}\right)}=\mu_{I\left(q_{\bar{A}}\right)}^{2}$.
Theorem 3.17. The diagram of functors

is commutative.
Proof. Let $(\mathbb{H}, \mathbb{D}, x, y) \in \mathrm{P}($ coc- HBr$)$. We have to show that the relative Rota-Baxter operator

To finish the proof it is enough to see that $\varphi_{I\left(q_{D}\right)}=\Gamma_{I\left(q_{D}\right)_{1}}$, what follows by (64), by the equality $i_{D} \circ \Gamma_{I\left(q_{D}\right)_{1}}=\Gamma_{D_{1}} \circ\left(i_{D} \otimes i_{D}\right)$ and by the fact that $i_{D}$ is a monomorphism.

To finish the article we will introduce the notion of strong projection of relative Rota-Baxter operators in order to prove that any such projection gives rise to a module in the sense of Definition 2.8 in a cocommutative setting.

Definition 3.18. A projection of relative Rota-Baxter operators

where $\bar{A}$ is the Hopf algebra introduced in Theorem 2.7.
Strong projections of relative Rota-Baxter operators constitute a full subcategory of $P(r R B)$ which we will denote by $\mathrm{SP}(\mathrm{rRB})$. When the relative Rota-Baxter operators involved in the strong projection are cocommutative, they constitute a full subcategory of $\mathrm{SP}(\mathrm{rRB})$ denoted by $\mathrm{SP}($ coc-rRB $)$.

Theorem 3.19. If

is a module over the relative Rota-Baxter operator $\left(\begin{array}{c}H \\ T \\ \\ \\ \hline\end{array}, \varphi_{H}\right)$, where $L_{0}: I\left(q_{A}\right) \rightarrow I\left(q_{D}\right)$ is the morphism defined by (43) and the actions are defined as follows:

By the general theory of Hopf algebra projections, it is well-known that $\left(I\left(q_{A}\right), \psi_{I\left(q_{A}\right)}\right)$ is a left $H-$ module and $\left(I\left(q_{D}\right), \psi_{I\left(q_{D}\right)}\right)$ is a left $B$-module. Let's show that $\left(I\left(q_{A}\right), \varphi_{I\left(q_{A}\right)}\right)$ is also a left $B$-module. Indeed, on the one hand it is straightforward to compute that $\varphi_{I\left(q_{A}\right)} \circ\left(\eta_{B} \otimes I\left(q_{A}\right)\right)=i d_{I\left(q_{A}\right)}$ and, on the other hand, we have that

what implies that (26) holds and the proof is concluded due to the fact that $i_{D}$ is a monomorphism.
