# An extension of Gauss's arithmetic-geometric mean (AGM) to three variables iteration scheme

Gauss's arithmetic-geometric mean (AGM) which is described by two variables iteration $\left(a_{n}, b_{n}\right) \rightarrow\left(a_{n+1}, b_{n+1}\right)$ by $a_{n+1}=\left(a_{n}+b_{n}\right) / 2, b_{n+1}=\sqrt{a_{n} b_{n}}$. We extend it to three variables iteration $\left(a_{n}, b_{n}, c_{n}\right) \rightarrow\left(a_{n+1}, b_{n+1}, c_{n+1}\right)$ which reduces to Gauss's AGM when $c_{0}=0$. Our iteration starting from $a_{0}>b_{0}>c_{0}>0$ with further restriction $a_{0}>b_{0}+c_{0}$ converges to $a_{\infty}=b_{\infty}=M\left(a_{0}, b_{0}, c_{0}\right)$ and $c_{\infty}=0$. The limit $M\left(a_{0}, b_{0}, c_{0}\right)$ is expressed by Appell's hyper-geometric function $F_{1}(1 / 2,\{1 / 2,1 / 2\}, 1 ; \kappa, \lambda)$ of two variables $(\kappa, \lambda)$ which are determined by $\left(a_{0}, b_{0}, c_{0}\right)$. A relation between two hyper-geometric functions (Gauss's and Appell's) is found as a by-product.

Keywords: Gauss's arithmetic-geometric mean, three variables iteration, Appell's hyper-geometric function

## 1. INTRODUCTION

The theory of arithmetic-geometric mean (AGM) by Gauss was published posthumously in his Werke. ${ }^{1}$ Gauss observed that the iteration

$$
\begin{equation*}
a_{n+1}=\frac{1}{2}\left(a_{n}+b_{n}\right), \quad b_{n+1}=\sqrt{a_{n} b_{n}}, \quad\left(a_{0}>b_{0}>0\right) \tag{1.1}
\end{equation*}
$$

gives converging series $a_{0}>a_{1}>\cdots>a_{\infty}=b_{\infty}>\cdots>b_{1}>b_{0}$. We write the limit $a_{\infty}=b_{\infty}=\operatorname{agM}\left(a_{0}, b_{0}\right)$ and call it arithmetic-geometric mean (AGM), which satisfies a functional equation

\operatorname{agM}(a, b)=\operatorname{agM}((a+b) / 2, \sqrt{a b}) \tag{1.2}
\end{equation*}
$$

The amazing discovery ${ }^{2}$ by Gauss is the equality

$$
\begin{equation*}
\frac{a_{0}}{\operatorname{agM}\left(a_{0}, b_{0}\right)}=\frac{1}{\pi} \int_{0}^{1} \frac{d u}{\sqrt{u(1-u)(1-\kappa u)}}, \quad \kappa=1-\left(\frac{b_{0}}{a_{0}}\right)^{2} \tag{1.3}
\end{equation*}
$$

where the right hand side integral $(0 \leq \kappa<1)$ is a special case of Gauss's hyper-geometric function

$$
\begin{equation*}
\frac{1}{\pi} \int_{0}^{1} \frac{d u}{\sqrt{u(1-u)(1-\kappa u)}}={ }_{2} F_{1}\left(\frac{1}{2}, \frac{1}{2}, 1 ; \kappa\right) \tag{1.4}
\end{equation*}
$$

which is generally defined by

$$
\begin{align*}
{ }_{2} F_{1}(\alpha, \beta, \gamma ; \kappa) & =\frac{\Gamma(\gamma)}{\Gamma(\alpha) \Gamma(\gamma-\alpha)} \int_{0}^{1} u^{\alpha-1}(1-u)^{\gamma-\alpha-1}(1-\kappa u)^{-\beta} d u  \tag{1.5}\\
& =\sum_{n=0}^{\infty} \frac{(\alpha)_{n}(\beta)_{n}}{(\gamma)_{n}} \cdot \frac{\kappa^{n}}{n!}, \quad(|\kappa|<1) \tag{1.6}
\end{align*}
$$

where $\gamma>\alpha>0$ is assumed, and Pochhammer's symbol $(\alpha)_{0}=1,(\alpha)_{1}=\alpha,(\alpha)_{n}=$ $\alpha(\alpha+1) \cdots(\alpha+n-1)=\Gamma(\alpha+n) / \Gamma(\alpha)$ is used. To derive this series expansion, the following Newton's expansion formula is used

$$

(1-\kappa u)^{-\beta}=\sum_{m=0}^{\infty}\left(\frac{(\beta)_{n}}{n!} \kappa^{n}\right) \cdot u^{n} . \tag{1.7}
\end{equation*}
$$

To extend the above results, we start by considering the integral with an additional new parameter $\lambda$

$$
\begin{equation*}
\frac{1}{\pi} \int_{0}^{1} \frac{d u}{\sqrt{u(1-u)(1-\kappa u)(1-\lambda u)}}, \quad(0<\lambda<\kappa<1) \tag{1.8}
\end{equation*}
$$

which reduces to (1.4) when $\lambda=0$. In the next section we construct a model with the iteration rule $\left(a_{n}, b_{n}, c_{n}\right) \rightarrow\left(a_{n+1}, b_{n+1}, c_{n+1}\right)$ and show the converging limit $M\left(a_{0}, b_{0}, c_{0}\right)$ is given by

\frac{a_{0}}{M\left(a_{0}, b_{0}, c_{0}\right)}=\frac{1}{\pi} \int_{0}^{1} \frac{d u}{\sqrt{u(1-u)(1-\kappa u)(1-\lambda u)}}, \tag{1.9}
\end{equation*}
$$

where the relations of $(\kappa, \lambda)$ with $\left(a_{0}, b_{0}, c_{0}\right)$ are given by

$$
\begin{equation*}
\left(\frac{b_{0}}{a_{0}}\right)^{2}=(1-\kappa)(1-\lambda), \quad\left(\frac{c_{0}}{a_{0}}\right)^{2}=\kappa \lambda, \tag{1.10}
\end{equation*}
$$

which will be derived in the next section.

## 2. EXTENSION OF GAUSS'S AGM

## A. Iteration rule

Let us begin to observe that the integral (1.4) of Gauss is rewritten, by setting $u=\sin ^{2} \theta$,

\frac{2 a_{0}}{\pi} \int_{0}^{\pi / 2} \frac{d \theta}{\sqrt{a_{0}^{2} \cos ^{2} \theta+b_{0}^{2} \sin ^{2} \theta}}=\frac{1}{\pi} \int_{0}^{1} \frac{d u}{\sqrt{u(1-u)(1-\kappa u)}}, \quad \kappa=1-\left(\frac{b_{0}}{a_{0}}\right)^{2} \tag{2.1}
\end{equation*}
$$

which can be extended to

$$
\begin{gather*}
\frac{2 a_{0}}{\pi} \int_{0}^{\pi / 2} \frac{d \theta}{\sqrt{a_{0}^{2} \cos ^{2} \theta+b_{0}^{2} \sin ^{2} \theta-c_{0}^{2} \cos ^{2} \theta \sin ^{2} \theta}} \\
\quad=\frac{1}{\pi} \int_{0}^{1} \frac{d u}{\sqrt{u(1-u)(1-\kappa u)(1-\lambda u)}}, \tag{2.2}
\end{gather*}
$$

by introducing a new variable $c_{0}$. Here we have, by substituting $\sin ^{2} \theta=u$,

$$
\begin{align*}
& a_{0}^{2} \cos ^{2} \theta+b_{0}^{2} \sin ^{2} \theta-c_{0}^{2} \cos ^{2} \theta \sin ^{2} \theta=a_{0}^{2}-\left(a_{0}^{2}-b_{0}^{2}+c_{0}^{2}\right) u+c_{0}^{2} u^{2} \\
& \quad=a_{0}^{2}(1-\kappa u)(1-\lambda u) \quad \Longrightarrow \quad(1-\kappa)(1-\lambda)=\left(\frac{b_{0}}{a_{0}}\right)^{2}, \quad \kappa \lambda=\left(\frac{c_{0}}{a_{0}}\right)^{2} \tag{2.3}
\end{align*}
$$

from which we can express $\kappa, \lambda$ in terms of $a_{0}, b_{0}, c_{0}$ as follows

$$
\begin{align*}
& \kappa=\frac{1}{2}\left\{1-\frac{b_{0}^{2}-c_{0}^{2}}{a_{0}^{2}}+\sqrt{\left(1-\frac{\left(b_{0}+c_{0}\right)^{2}}{a_{0}^{2}}\right)\left(1-\frac{\left(b_{0}-c_{0}\right)^{2}}{a_{0}^{2}}\right)}\right\}, \\
& \lambda=\frac{1}{2}\left\{1-\frac{b_{0}^{2}-c_{0}^{2}}{a_{0}^{2}}-\sqrt{\left(1-\frac{\left(b_{0}+c_{0}\right)^{2}}{a_{0}^{2}}\right)\left(1-\frac{\left(b_{0}-c_{0}\right)^{2}}{a_{0}^{2}}\right)}\right\}, \tag{2.4}
\end{align*}
$$

and

$$
\begin{align*}
& 1-\kappa=\frac{1}{2}\left\{1+\frac{b_{0}^{2}-c_{0}^{2}}{a_{0}^{2}}-\sqrt{\left(1-\frac{\left(b_{0}+c_{0}\right)^{2}}{a_{0}^{2}}\right)\left(1-\frac{\left(b_{0}-c_{0}\right)^{2}}{a_{0}^{2}}\right)}\right\} \\
& 1-\lambda=\frac{1}{2}\left\{1+\frac{b_{0}^{2}-c_{0}^{2}}{a_{0}^{2}}+\sqrt{\left(1-\frac{\left(b_{0}+c_{0}\right)^{2}}{a_{0}^{2}}\right)\left(1-\frac{\left(b_{0}-c_{0}\right)^{2}}{a_{0}^{2}}\right)}\right\} \tag{2.5}
\end{align*}
$$

where conditions $a_{0}>b_{0}>c_{0}>0$ and $a_{0}>b_{0}+c_{0}$ are assumed to guarantee $\kappa$ and $\lambda$ take real values $(0<\lambda<\kappa<1)$. If we introduce $\xi, \eta$ by

\xi=\frac{b_{0}+c_{0}}{a_{0}}, \quad \eta=\frac{b_{0}-c_{0}}{a_{0}} \tag{2.6}
\end{equation*}
$$

eqs. (2.4) and (2.5) are written in much simpler forms by

$$
\begin{align*}
\kappa & =\frac{1}{2}\left(1-\xi \eta+\sqrt{\left(1-\xi^{2}\right)\left(1-\eta^{2}\right)}\right), \\
\lambda & =\frac{1}{2}\left(1-\xi \eta-\sqrt{\left(1-\xi^{2}\right)\left(1-\eta^{2}\right)}\right),  \tag{2.7}\\
1-\kappa & =\frac{1}{2}\left(1+\xi \eta-\sqrt{\left(1-\xi^{2}\right)\left(1-\eta^{2}\right)}\right), \\
1-\lambda & =\frac{1}{2}\left(1+\xi \eta+\sqrt{\left(1-\xi^{2}\right)\left(1-\eta^{2}\right)}\right) . \tag{2.8}
\end{align*}
$$

Therefore $\kappa$, $\lambda$, which are $\kappa_{0}, \lambda_{0}$ actually, are determined by $\left(a_{0}, b_{0}, c_{0}\right)$ through $\xi, \eta$.
To construct the iteration rule, we notice, when $0 \leq \lambda<\kappa<1$,

\begin{equation*}
\frac{1}{\pi} \int_{0}^{1} \frac{d u}{\sqrt{u(1-u)(1-\kappa u)(1-\lambda u)}}=\frac{2}{\pi \sqrt{1-\lambda}} \cdot K\left(k_{0}\right), \quad k_{0}^{2}=1-\frac{1-\kappa}{1-\lambda} \tag{2.9}
\end{equation*}
$$

where $K(k)$ is the complete elliptic integral of the first kind

$$
\begin{equation*}
K(k)=\int_{0}^{\pi / 2} \frac{d \phi}{\sqrt{1-k^{2} \sin ^{2} \phi}}=\frac{1}{2} \int_{0}^{1} \frac{d u}{\sqrt{u(1-u)\left(1-k^{2} u\right)}} . \tag{2.10}
\end{equation*}
$$

We use here the Landen transformation formula ${ }^{2}$

$$
\begin{equation*}
K\left(k_{0}\right)=\left(1+k_{1}\right) \cdot K\left(k_{1}\right), \quad k_{1}=\frac{1-\sqrt{1-k_{0}^{2}}}{1+\sqrt{1-k_{0}^{2}}} \tag{2.11}
\end{equation*}
$$

which can be rewritten such as

\begin{equation*}
K\left(k_{1}\right)=\frac{1+\sqrt{1-k_{0}^{2}}}{2} \cdot K\left(k_{0}\right), \tag{2.12}
\end{equation*}
$$

because we have

$$
\begin{equation*}
1+k_{1}=\frac{2}{1+\sqrt{1-k_{0}^{2}}} \tag{2.13}
\end{equation*}
$$

Therefore our iteration rule, $\left(\kappa_{0}, \lambda_{0}\right) \rightarrow\left(\kappa_{1}, \lambda_{1}\right)$, is

$$
\begin{align*}
& \frac{1}{a_{0} \pi} \int_{0}^{1} \frac{d u}{\sqrt{u(1-u)\left(1-\kappa_{0} u\right)\left(1-\lambda_{0} u\right)}}=\frac{1}{a_{1} \pi} \int_{0}^{1} \frac{d u}{\sqrt{u(1-u)\left(1-\kappa_{1} u\right)\left(1-\lambda_{1} u\right)}} \\
& \Longrightarrow \frac{1}{a_{0} \sqrt{1-\lambda_{0}}} \cdot K\left(k_{0}=\sqrt{1-\frac{1-\kappa_{0}}{1-\lambda_{0}}}\right)=\frac{1}{a_{1} \sqrt{1-\lambda_{1}}} \cdot K\left(k_{1}=\sqrt{1-\frac{1-\kappa_{1}}{1-\lambda_{1}}}\right) \\
& \Longrightarrow \frac{1}{a_{0} \sqrt{1-\lambda_{0}}} \cdot \frac{2}{1+\sqrt{1-k_{0}^{2}}}=\frac{1}{a_{1} \sqrt{1-\lambda_{1}}} \tag{2.14}
\end{align*}
$$

which is rewritten into

$$
\begin{align*}
\frac{a_{1}}{a_{0}} & =\frac{1+\sqrt{1-k_{0}^{2}}}{2} \cdot \sqrt{\frac{1-\lambda_{0}}{1-\lambda_{1}}}, \quad k_{0}^{2}=1-\frac{1-\kappa_{0}}{1-\lambda_{0}} \\
& =\frac{\sqrt{1-\lambda_{0}}+\sqrt{1-\kappa_{0}}}{2 \sqrt{1-\lambda_{1}}} \tag{2.15}
\end{align*}
$$

Now it is convenient to introduce parameters $\alpha$ and $\varepsilon(0<\varepsilon<\alpha<\pi / 2)$ by

\begin{equation*}
\kappa=\sin ^{2} \alpha, \quad \lambda=\sin ^{2} \varepsilon \tag{2.16}
\end{equation*}
$$

which imply

$$
\begin{align*}
& \frac{b}{a}=\cos \alpha \cos \varepsilon, \quad \frac{c}{a}=\sin \alpha \sin \varepsilon  \tag{2.17}\\
& \frac{b+c}{a}=\cos (\alpha-\varepsilon), \quad \frac{b-c}{a}=\cos (\alpha+\varepsilon) .
\end{align*}
$$

By use of these parameters, we have

\begin{equation*}
k_{0}^{2}=1-\frac{1-\kappa_{0}}{1-\lambda_{0}}=1-\frac{\cos ^{2} \alpha_{0}}{\cos ^{2} \varepsilon_{0}}=\frac{\sin \left(\alpha_{0}+\varepsilon_{0}\right) \sin \left(\alpha_{0}-\varepsilon_{0}\right)}{\cos ^{2} \varepsilon_{0}} \tag{2.18}
\end{equation*}
$$

and similarly

$$
\begin{equation*}
k_{1}^{2}=1-\frac{1-\kappa_{1}}{1-\lambda_{1}}=\frac{\sin \left(\alpha_{1}+\varepsilon_{1}\right) \sin \left(\alpha_{1}-\varepsilon_{1}\right)}{\cos ^{2} \varepsilon_{1}} \tag{2.19}
\end{equation*}
$$

Substituting these into (2.13), we have

$$
\begin{align*}
& \tan ^{2}\left(\frac{\alpha_{0}+\varepsilon_{0}}{2}\right)=\frac{\sin \left(\alpha_{1}+\varepsilon_{1}\right)}{\cos \varepsilon_{1}}=\sin \alpha_{1}+\cos \alpha_{1} \tan \varepsilon_{1}  \tag{2.20}\\
& \tan ^{2}\left(\frac{\alpha_{0}-\varepsilon_{0}}{2}\right)=\frac{\sin \left(\alpha_{1}-\varepsilon_{1}\right)}{\cos \varepsilon_{1}}=\sin \alpha_{1}-\cos \alpha_{1} \tan \varepsilon_{1}
\end{align*}
$$

from which we obtain

$$
\begin{align*}
& \sin \alpha_{1}=\frac{1}{2}\left\{\tan ^{2}\left(\frac{\alpha_{0}+\varepsilon_{0}}{2}\right)+\tan ^{2}\left(\frac{\alpha_{0}-\varepsilon_{0}}{2}\right)\right\}  \tag{2.21}\\
& \tan ^{2} \varepsilon_{1}=\tan ^{2} \alpha_{1}-\sec ^{2} \alpha_{1} \cdot \tan ^{2}\left(\frac{\alpha_{0}+\varepsilon_{0}}{2}\right) \cdot \tan ^{2}\left(\frac{\alpha_{0}-\varepsilon_{0}}{2}\right)
\end{align*}
$$

which gives $\kappa_{1}=\sin ^{2} \alpha_{1}$ and $\lambda_{1}=\sin ^{2} \varepsilon_{1}$ in terms of $\left(\alpha_{0}, \varepsilon_{0}\right)$. These are the iteration scheme what we are looking for.

Here we can rewrite these quantities in terms of $\xi, \eta$. Since

\begin{equation*}
\cos \left(\alpha_{0}-\varepsilon_{0}\right)=\frac{b_{0}+c_{0}}{a_{0}}=\xi, \quad \cos \left(\alpha_{0}+\varepsilon_{0}\right)=\frac{b_{0}-c_{0}}{a_{0}}=\eta \tag{2.22}
\end{equation*}
$$

we have at first

$$
\begin{align*}
\tan ^{2}\left(\frac{\alpha_{0}-\varepsilon_{0}}{2}\right) & =\frac{1-\xi}{1+\xi}, \quad \tan ^{2}\left(\frac{\alpha_{0}+\varepsilon_{0}}{2}\right)=\frac{1-\eta}{1+\eta}  \tag{2.23}\\
\Longrightarrow \quad \sin \alpha_{1} & =\frac{1}{2}\left(\frac{1-\xi}{1+\xi}+\frac{1-\eta}{1+\eta}\right)=\frac{1-\xi \eta}{(1+\xi)(1+\eta)} \tag{2.24}
\end{align*}
$$

therefore we obtain

$$
\begin{equation*}
\kappa_{1}=\sin ^{2} \alpha_{1}=\left(\frac{1-\xi \eta}{(1+\xi)(1+\eta)}\right)^{2} \tag{2.25}
\end{equation*}
$$

We have next, after some calculations

$$
\begin{align*}
\tan ^{2} \varepsilon_{1} & =\frac{\sin ^{2} \alpha_{1}}{1-\sin ^{2} \alpha_{1}}-\frac{1}{1-\sin ^{2} \alpha_{1}} \cdot \frac{(1-\xi)(1-\eta)}{(1+\xi)(1+\eta)} \\
& =\frac{(\xi-\eta)^{2}}{(2+\xi+\eta)(\xi+\eta+2 \xi \eta)} \tag{2.26}
\end{align*}
$$

therefore we obtain

$$
\begin{equation*}
\lambda_{1}=\sin ^{2} \varepsilon_{1}=\frac{\tan ^{2} \varepsilon_{1}}{1+\tan ^{2} \varepsilon_{1}}=\frac{(\xi-\eta)^{2}}{2(1+\xi)(1+\eta)(\xi+\eta)} \tag{2.27}
\end{equation*}
$$

In conclusion, the procedure of iteration is described as follows.
(1) Compute $\kappa_{0}, \lambda_{0}$ by using $\xi=\left(b_{0}+c_{0}\right) / a_{0}, \eta=\left(b_{0}-c_{0}\right) / a_{0}$,

$$
\begin{align*}
& \kappa_{0}=\frac{1}{2}\left(1-\xi \eta+\sqrt{\left(1-\xi^{2}\right)\left(1-\eta^{2}\right)}\right) \\
& \lambda_{0}=\frac{1}{2}\left(1-\xi \eta-\sqrt{\left(1-\xi^{2}\right)\left(1-\eta^{2}\right)}\right) \tag{2.28}
\end{align*}
$$

(2) Compute $\kappa_{1}, \lambda_{1}$ by using the same $\xi, \eta$,

$$
\begin{align*}
\kappa_{1} & =\left(\frac{1-\xi \eta}{(1+\xi)(1+\eta)}\right)^{2}  \tag{2.29}\\
\lambda_{1} & =\frac{(\xi-\eta)^{2}}{2(1+\xi)(1+\eta)(\xi+\eta)}
\end{align*}
$$

(3) Compute $\left(a_{1}, b_{1}, c_{1}\right)$ by using $\kappa_{0}, \lambda_{0}$ and $\kappa_{1}, \lambda_{1}$

$$
\begin{align*}
& a_{1}=a_{0}\left(\sqrt{1-\lambda_{0}}+\sqrt{1-\kappa_{0}}\right) / 2 \sqrt{1-\lambda_{1}}, \\
& b_{1}=a_{1} \sqrt{\left(1-\kappa_{1}\right)\left(1-\lambda_{1}\right)},  \tag{2.30}\\
& c_{1}=a_{1} \sqrt{\kappa_{1} \lambda_{1}} .
\end{align*}
$$

We perform these sequences repeatedly, regarding the sub-indices $(0,1)$ as $(n, n+1)$. The result of iterations is $a_{\infty}=b_{\infty}=M\left(a_{0}, b_{0}, c_{0}\right)$ and $c_{\infty}=0$ as was announced before.

Let us give an example of numerical computation by Python, whose code is given in Appendix. For the case of $a_{0}=1.0, b_{0}=0.5, c_{0}=0.2$, after ten iterations we get $a_{10}=$ $b_{10}=0.7250921711406717$ and $c_{10}=0.0$, as is expected. On the other hand, the numerical integration of (1.9) gives $M\left(a_{0}, b_{0}, c_{0}\right)=0.725092$, which can be regarded as the same value.

## B. Appell's hyper-geometric function

Our integration (1.8) is expressed by

$$
\begin{equation*}
\frac{1}{\pi} \int_{0}^{1} \frac{d u}{\sqrt{u(1-u)(1-\kappa u)(1-\lambda u)}}=F_{1}\left(\frac{1}{2},\left\{\frac{1}{2}, \frac{1}{2}\right\}, 1 ; \kappa, \lambda\right) \tag{2.31}
\end{equation*}
$$

which is a special case of Appell's hyper-geometric function of two variables defined by ${ }^{3}$

$$
\begin{align*}
F_{1}\left(\alpha,\left\{\beta, \beta^{\prime}\right\}, \gamma ; x, y\right) & =\frac{\Gamma(\gamma)}{\Gamma(\alpha) \Gamma(\gamma-\alpha)} \int_{0}^{1} u^{\alpha-1}(1-u)^{\gamma-\alpha-1}(1-x u)^{-\beta}(1-y u)^{-\beta^{\prime}} d u \\
& =\sum_{m=0}^{\infty} \sum_{n=0}^{\infty} \frac{(\alpha)_{m+n}(\beta)_{m}\left(\beta^{\prime}\right)_{n}}{(\gamma)_{m+n}} \cdot \frac{x^{m} y^{n}}{m!n!} \tag{2.32}
\end{align*}
$$

where is used Newton's expansion formula (1.7) twice. Appell's function $F_{1}$ satisfies the differential equations ${ }^{3}$

$$
\begin{align*}
& x(1-x) \frac{\partial^{2} F_{1}}{\partial x^{2}}+y(1-x) \frac{\partial^{2} F_{1}}{\partial x \partial y}+[\gamma-(\alpha+\beta+1) x] \frac{\partial F_{1}}{\partial x}-\beta y \frac{\partial F_{1}}{\partial y}-\alpha \beta F_{1}=0 \\
& y(1-y) \frac{\partial^{2} F_{1}}{\partial y^{2}}+x(1-y) \frac{\partial^{2} F_{1}}{\partial y \partial x}+\left[\gamma-\left(\alpha+\beta^{\prime}+1\right) y\right] \frac{\partial F_{1}}{\partial y}-\beta^{\prime} x \frac{\partial F_{1}}{\partial x}-\alpha \beta^{\prime} F_{1}=0 \tag{2.33}
\end{align*}
$$

From the equality (2.9) we have an interesting relation

$$
F_{1}\left(\frac{1}{2},\left\{\frac{1}{2}, \frac{1}{2}\right\}, 1 ; x, y\right)=\begin{array}{ll}
\frac{1}{\sqrt{1-y}} \cdot{ }_{2} F_{1}\left(\frac{1}{2}, \frac{1}{2}, 1 ; \frac{x-y}{1-y}\right), & (0<y \leq x<1)  \tag{2.34}\\
\frac{1}{\sqrt{1-x}} \cdot{ }_{2} F_{1}\left(\frac{1}{2}, \frac{1}{2}, 1 ; \frac{y-x}{1-x}\right), & (0<x \leq y<1)
\end{array}
$$

between Appell's and Gauss's hyper-geometric functions. Especially when we set $y=x$, the right hand side becomes $1 / \sqrt{1-x}$, which is verified by calculating the left hand side integral.

In general such kind of relationship can be derived at least under the condition $\gamma=\beta+\beta^{\prime}$, which is satisfied in our case $(1=1 / 2+1 / 2)$. Such formula is given by

$$
F_{1}\left(\alpha,\left\{\beta, \beta^{\prime}\right\}, \gamma ; x, y\right)=\begin{array}{ll}
(1-y)^{-\alpha} \cdot{ }_{2} F_{1}\left(\alpha, \beta, \gamma ; \frac{x-y}{1-y}\right), & (0<y \leq x<1)  \tag{2.35}\\
(1-x)^{-\alpha} \cdot{ }_{2} F_{1}\left(\alpha, \beta^{\prime}, \gamma ; \frac{y-x}{1-x}\right), & (0<x \leq y<1)
\end{array}
$$

which is derived for $0<y \leq x<1$ case by the change of integration variable $u \rightarrow v=$ $(1-y) u /(1-y u)$, under the condition $\gamma=\beta+\beta^{\prime}$.

It should be noted here that general transformation formulas are known ${ }^{4}$ for much wider class of multi-variable hyper-geometric functions, where the above relation (2.35) is a special case of such formulas.

## 3. SUMMARY

The arithmetic-geometric mean by Gauss is extended to three variables iteration $\left(a_{n}, b_{n}, c_{n}\right) \rightarrow$ $\left(a_{n+1}, b_{n+1}, c_{n+1}\right)$, with $a_{\infty}=b_{\infty}=M\left(a_{0}, b_{0}, c_{0}\right), c_{\infty}=0$. Our main result is expressed by the equalities such as

$$
\begin{align*}
\frac{a_{0}}{M\left(a_{0}, b_{0}, c_{0}\right)} & =\frac{2 a_{0}}{\pi} \int_{0}^{\pi / 2} \frac{d \theta}{\sqrt{a_{0}^{2} \cos ^{2} \theta+b_{0}^{2} \sin ^{2} \theta-c_{0}^{2} \cos ^{2} \theta \sin ^{2} \theta}}  \tag{3.1}\\
& =\frac{1}{\pi} \int_{0}^{1} \frac{d u}{\sqrt{u(1-u)(1-\kappa u)(1-\lambda u)}}  \tag{3.2}\\
& =F_{1}\left(\frac{1}{2},\left\{\frac{1}{2}, \frac{1}{2}\right\}, 1 ; \kappa, \lambda\right)  \tag{3.3}\\
& =\frac{1}{\sqrt{1-\lambda}} \cdot{ }_{2} F_{1}\left(\frac{1}{2}, \frac{1}{2}, 1 ; \frac{\kappa-\lambda}{1-\lambda}\right), \quad(0<\lambda<\kappa<1) \tag{3.4}
\end{align*}
$$

where the relations among $(\kappa, \lambda)$ and $\left(a_{0}, b_{0}, c_{0}\right)$ are given by

$$
\begin{equation*}
(1-\kappa)(1-\lambda)=\left(\frac{b_{0}}{a_{0}}\right)^{2}, \quad \kappa \lambda=\left(\frac{c_{0}}{a_{0}}\right)^{2} . \tag{3.5}
\end{equation*}
$$

It should be noted that the conditions $a_{0}>b_{0}>c_{0}>0$ and $a_{0}>b_{0}+c_{0}$ are assumed.
