Model structure arising from one hereditary cotorsion pair on extriangulated categories

Abstract

Let $\mathcal C$ be a weakly idempotent complete extriangulated category. In contrast with the Hovey correspondence of admissible model structures on weakly idempotent complete exact categories from two complete cotorsion pairs, we give a construction of model structures on $\mathcal C$ from only one complete cotorsion pair. Our main result not only generalizes the work by Beligiannis-Reiten and Cui-Lu-Zhang, but also provides methods to construct model structures from silting objects of $\mathcal C$ and co-t-structures in triangulated categories.

1. Introduction

The Hovey correspondence [\[10,](#page-22-0) [11,](#page-22-1) [7,](#page-22-2) [17\]](#page-22-3) is a tool for constructing model structures on abelian categories, exact categories or triangulated categories. It is inspired by the somewhat canonical model structure on a Frobenius category, but with two cotorsion pairs mimicking the role played by the projectives and the injectives. Extriangulated category, introduced in [\[14\]](#page-22-4), can be viewed as a simultaneous generalization of exact categories and triangulated categories. Hovey's correspondence has been generalized by Nakaoka and Palu in [\[14\]](#page-22-4) as a bijective correspondence between admissible model structures and some pairs of cotorsion pairs which they called Hovey twin cotorsion pairs on a weakly idempotent complete extriangulated category.

A similar, but weaker correspondence, is obtained by Beligiannis and Reiten in [\[4\]](#page-22-5). More precisely, they give a construction of weakly projective model structures on abelian categories A from only one complete cotorsion pair. Recenty, it has been extended by Cui, Lu and Zhang $[6]$ to weakly idempotent complete exact categories \mathcal{E} , by adding the condition of hereditary of the complete cotorsion pair. These weakly projective model structures are not necessarily exact. The two approaches get the same result if and only if $\mathcal E$ has enough projective objects and the model structure is projective, i.e., it is exact and each object is fibrant (see [\[6,](#page-22-6) Corollary 5.4]).

The aim of this paper is to extend the results of Cui, Lu and Zhang to weakly idempotent complete extriangulated categories. But our proof method is far different from the exact category because we cannot use the properties of monomorphism and epimorphism. To state our results, we first introduce some notation and definitions.

Assume that $(C, \mathbb{E}, \mathfrak{s})$ is an extriangulated category, where C is an additive category, \mathbb{E} : $\mathcal{C}^{\text{op}} \times \mathcal{C} \to A\text{b}$ is an additive bifunctor and \mathfrak{s} assigns to each $\delta \in \mathbb{E}(C, A)$ a class of 3-term sequences with end terms A and C as in $[14,$ Definition 2.10. If there is no confusion, we also write $\mathcal{C} := (\mathcal{C}, \mathbb{E}, \mathfrak{s}).$

A sequence $A \xrightarrow{x} B \xrightarrow{y} C$ in C is called a *conflation* if it realizes some E-extension $\delta \in$ $\mathbb{E}(C, A)$. In this case, x is called an *inflation*, y is called a *deflation*, and we write it as

$$
A \xrightarrow{x} B \xrightarrow{y} C - \xrightarrow{\delta}.
$$

For an inflation $f \in \mathcal{C}(A, B)$, take a conflation $A \xrightarrow{f} B \longrightarrow C$, and denote this C by Cone(f). Similarly, for a deflation $f \in \mathcal{C}(A, B)$, we take a conflation $L \longrightarrow A \stackrel{f}{\longrightarrow} B$, and denote this L by $CoCone(f)$.

Let $\mathcal X$ and $\mathcal Y$ be full subcategories of $\mathcal C$ which are closed under direct summands and isomorphisms. Put $\omega := \mathcal{X} \cap \mathcal{Y}$.

• Denote by CoFib_{ω} the class of inflations f with $\text{Cone}(f) \in \mathcal{X}$.

• Denote by Fib_{ω} the class of morphisms $f : A \to B$ such that f is ω -epic, that is, $\mathcal{C}(W, f)$: $\mathcal{C}(W, A) \to \mathcal{C}(W, B)$ is surjective for any $W \in \omega$.

- Denote by $TCoFib_{\omega}$ the class of splitting inflations f with $Cone(f) \in \omega$.
- Denote by TFib_ω the class of deflations f with $CoCone(f) \in \mathcal{Y}$.

• Denote by Weq_{ω} the class of morphisms $f : A \to B$ such that there is a deflation (f, t) : $A \oplus W \to B$ with $W \in \omega$ and $\text{CoCone}(f, t) \in \mathcal{Y}$. Therefore, a morphism $f : A \to B$ is in Weq_{ω} if and only if there is a commutative diagram

such that $W \in \omega$, (f, t) is a deflation, and CoCone $(f, t) \in \mathcal{Y}$. Since $\begin{pmatrix} 1 & 0 \\ 0 & 0 \end{pmatrix}$ $\begin{bmatrix} 1 \\ 0 \end{bmatrix} \in \text{TCofib}_{\omega}, \text{ Weq}_{\omega} \text{ can}$ be reformulated as

$$
Weq_{\omega} = \{gf|g \in TFib_{\omega}, f \in TCoFib_{\omega}\}.
$$

Now, our main result can be stated as follows.

Theorem 1.1. Keep the notations above. Then $(CoFib_{\omega}, Fib_{\omega}, Weq_{\omega})$ is a model structure if and only if $(\mathcal{X}, \mathcal{Y})$ is a hereditary cotorsion pair in C, and ω is contravariantly finite in C. In this case, the class \mathcal{C}_{ω} of cofibrant objects is X, the class \mathcal{F}_{ω} of fibrant objects is C, the class \mathcal{W}_{ω} of trivial objects is \mathcal{Y} ; and the homotopy category $Ho(\mathcal{C})$ is \mathcal{X}/\mathcal{W} .

A few comments on Theorem [1.1](#page-1-0) are in order. First, the originality of Theorem [1.1](#page-1-0) is due to Beligiannis and Reiten $[4]$ for abelian categories. If C is a weakly idempotent complete exact

category, Theorem [1.1](#page-1-0) also recovers the weakly projective model structure established by Cui, Lu and Zhang in [\[6,](#page-22-6) Theorem 1.1].

Second, thanks to the the bijection between bounded hereditary cotorsion pairs and silting subcategories in extriangulated categories established by Adachi and Tsukamoto in [\[2\]](#page-22-7), a direct consequence of Theorem [1.1](#page-1-0) yields that any silting object in a weakly idempotent complete extriangulated category induces a model structure (see Corollary [4.7\)](#page-21-0). We provided some examples (see Examples [4.3](#page-20-0)[-4.5\)](#page-20-1) to illustrate this result.

Last, assume that $\mathcal C$ is a triangulated category (it can be regarded as an extriangulated category). Specializing $\mathcal C$ to a triangulated category, we give a construction of model structures from co-t-structures under some certain conditions (see Corollary [4.9\)](#page-21-1).

The contents of this paper are as follows. In Section 2, we fix notations and recall some definitions and basic facts. Section 3 contributes to showing Theorem [1.1.](#page-1-0) Some applications of Theorem [1.1](#page-1-0) are given in the final section.

2. Preliminaries

Let us briefly recall some definitions and basic properties of extriangulated categories from [\[14\]](#page-22-4). Throughout this paper, we assume that $\mathcal C$ is an additive category.

2.1 Extriangulated categories.

Definition 2.1. [\[14,](#page-22-4) Definition 2.1] Suppose that \mathcal{C} is equipped with an additive bifunctor

$$
\mathbb{E}: \mathcal{C}^{op} \times \mathcal{C} \to \text{Ab},
$$

where Ab is the category of abelian groups. For any objects $A, C \in \mathcal{C}$, an element $\delta \in \mathbb{E}(C, A)$ is called an E-extension. Thus formally, an E-extension is a triple (A, δ, C) . For any $A, C \in \mathcal{C}$, the zero element $0 \in \mathbb{E}(C, A)$ is called the split E-extension.

Let $\delta \in \mathbb{E}(C, A)$ be any E-extension. By the functoriality, for any $a \in \mathcal{C}(A, A')$ and $c \in$ $\mathcal{C}(C', C)$, we have E-extensions

$$
\mathbb{E}(C, a)(\delta) \in \mathbb{E}(C, A') \text{ and } \mathbb{E}(c, A)(\delta) \in \mathbb{E}(C', A).
$$

We simply denote them by $a_*\delta$ and $c^*\delta$ respectively. In this terminology, we have

$$
\mathbb{E}(c,a)(\delta) = c^* a_* \delta = a_* c^* \delta
$$

in $\mathbb{E}(C', A')$. In the following, we always assume that the bifunctor \mathbb{E} exists.

Definition 2.2. [\[14,](#page-22-4) Definition 2.3] Let $\delta \in \mathbb{E}(C, A)$ and $\delta' \in \mathbb{E}(C', A')$ be any pair of \mathbb{E} extensions. A morphism $(a, c) : \delta \to \delta'$ of E-extensions is a pair of morphisms $a \in C(A, A')$ and $c \in \mathcal{C}(C, C')$ in C satisfying the equality

$$
a_*\delta=c^*\delta'.
$$

Definition 2.3. [\[14,](#page-22-4) Definition 2.6] Let $\delta = (A, \delta, C)$ and $\delta' = (A', \delta', C')$ be any pair of \mathbb{E} extensions. Let

$$
C \xrightarrow{\iota_C} C \oplus C' \xleftarrow{\iota_{C'}} C' \text{ and } A \xleftarrow{p_A} A \oplus A' \xrightarrow{p_{A'}} A'
$$

be coproduct and product in \mathcal{C} , respectively. Remark that, by the additivity of \mathbb{E} , we have a natural isomorphism

$$
\mathbb{E}(C \oplus C', A \oplus A') \simeq \mathbb{E}(C, A) \oplus \mathbb{E}(C, A') \oplus \mathbb{E}(C', A) \oplus \mathbb{E}(C', A').
$$

Let $\delta \oplus \delta' \in \mathbb{E}(C \oplus C', A \oplus A')$ be the element corresponding to $(\delta, 0, 0, \delta')$ through this isomorphism. This is the unique element which satisfies

$$
\mathbb{E}(\iota_C, p_A)(\delta \oplus \delta') = \delta, \ \mathbb{E}(\iota_C, p_{A'}) (\delta \oplus \delta') = 0, \ \mathbb{E}(\iota_{C'}, p_A)(\delta \oplus \delta') = 0, \ \mathbb{E}(\iota_{C'}, p_{A'}) (\delta \oplus \delta') = \delta'.
$$

Definition 2.4. [\[14,](#page-22-4) Definition 2.7] Let $A, C \in \mathcal{C}$ be any pair of objects. Two sequences of morphisms in $\mathcal C$

$$
A \xrightarrow{x} B \xrightarrow{y} C \text{ and } A \xrightarrow{x'} B' \xrightarrow{y'} C
$$

are said to be equivalent if there exists an isomorphism $b \in C(B, B')$ which makes the following diagram commutative.

We denote the equivalence class of $A \xrightarrow{x} B \xrightarrow{y} C$ by $[A \xrightarrow{x} B \xrightarrow{y} C]$.

Definition 2.5. [\[14,](#page-22-4) Definition 2.8] (1) For any $A, C \in \mathcal{C}$, we denote as

$$
0 = [A \xrightarrow{\begin{bmatrix} 1 \\ 0 \end{bmatrix}} A \oplus C \xrightarrow{\begin{bmatrix} 0 & 1 \end{bmatrix}} C].
$$

(2) For any $[A \xrightarrow{x} B \xrightarrow{y} C]$ and $[A' \xrightarrow{x'} B' \xrightarrow{y'}$ C' , we denote as

$$
[A \xrightarrow{x} B \xrightarrow{y} C] \oplus [A' \xrightarrow{x'} B' \xrightarrow{y'} C'] = [A \oplus A' \xrightarrow{x \oplus x'} B \oplus B' \xrightarrow{y \oplus y'} C \oplus C'].
$$

Definition 2.6. [\[14,](#page-22-4) Definition 2.9] Let \mathfrak{s} be a correspondence which associates an equivalence class

$$
\mathfrak{s}(\delta) = [A \xrightarrow{x} B \xrightarrow{y} C]
$$

to any E-extension $\delta \in \mathbb{E}(C, A)$. This s is called a *realization* of E, if it satisfies the following condition (\star). In this case, we say that the sequence $A \xrightarrow{x} B \xrightarrow{y} C$ realizes δ , whenever it satisfies $\mathfrak{s}(\delta) = [A \xrightarrow{x} B \xrightarrow{y} C].$

(*) Let $\delta \in \mathbb{E}(C, A)$ and $\delta' \in \mathbb{E}(C', A')$ be any pair of E-extensions, with

$$
\mathfrak{s}(\delta) = [A \xrightarrow{x} B \xrightarrow{y} C]
$$
 and $\mathfrak{s}(\delta') = [A' \xrightarrow{x'} B' \xrightarrow{y'} C']$.

Then, for any morphism $(a, c) : \delta \to \delta'$, there exists $b \in C(B, B')$ which makes the following diagram commutative

$$
A \xrightarrow{x} B \xrightarrow{y} C
$$

In the above situation, we say that the triplet (a, b, c) realizes (a, c) .

Definition 2.7. [\[14,](#page-22-4) Definition 2.10] Let \mathcal{C}, \mathbb{E} be as above. A realization of \mathbb{E} is said to be additive, if it satisfies the following conditions.

(i) For any $A, C \in \mathcal{C}$, the split E-extension $0 \in \mathbb{E}(C, A)$ satisfies $\mathfrak{s}(0) = 0$.

(ii) For any pair of E-extensions $\delta \in \mathbb{E}(C, A)$ and $\delta' \in \mathbb{E}(C', A')$, we have

$$
\mathfrak{s}(\delta\oplus\delta')=\mathfrak{s}(\delta)\oplus\mathfrak{s}(\delta').
$$

Definition 2.8. [\[14,](#page-22-4) Definition 2.12] A triplet $(C, \mathbb{E}, \mathfrak{s})$ is called an *extriangulated category* if it satisfies the following conditions.

(ET1) $\mathbb{E}: \mathcal{C}^{op} \times \mathcal{C} \to Ab$ is an additive bifunctor.

 $(ET2)$ s is an additive realization of E.

(ET3) Let $\delta \in \mathbb{E}(C, A)$ and $\delta' \in \mathbb{E}(C', A')$ be any pair of E-extensions, realized as

$$
\mathfrak{s}(\delta) = [A \xrightarrow{x} B \xrightarrow{y} C] \text{ and } \mathfrak{s}(\delta') = [A' \xrightarrow{x'} B' \xrightarrow{y'} C'].
$$

For any commutative square

$$
A \xrightarrow{x} B \xrightarrow{y} C
$$

\n

a \downarrow \qquad b \downarrow \qquad \qquad b'

A' \xrightarrow{x'} B' \xrightarrow{y'} C'

in C, there exists a morphism $(a, c) : \delta \to \delta'$ satisfying $cy = y'b$.

 $(ET3)$ ^{op} Dual of $(ET3)$.

(ET4) Let $\delta \in \mathbb{E}(D, A)$ and $\delta' \in \mathbb{E}(F, B)$ be E-extensions realized by

$$
A \xrightarrow{f} B \xrightarrow{f'} D \text{ and } B \xrightarrow{g} C \xrightarrow{g'} F
$$

respectively. Then there exist an object $E \in \mathcal{C}$, a commutative diagram

$$

$$

in C, and an E-extension $\delta'' \in E(E, A)$ realized by $A \xrightarrow{h} C \xrightarrow{h'} E$, which satisfy the following compatibilities.

(i) $D \xrightarrow{d} E \xrightarrow{e} F$ realizes $f'_* \delta'$, (ii) $d^*\delta'' = \delta$, (iii) $f_*\delta'' = e^*\delta'.$ $(ET4)$ ^{op} Dual of $(ET4)$.

We will use the following terminology in the sequel.

Definition 2.9. [\[14,](#page-22-4) Definitions 2.15, 2.19 and 3.9] Let $(C, \mathbb{E}, \mathfrak{s})$ be an extriangulated category.

(1) A sequence $A \xrightarrow{x} B \xrightarrow{y} C$ is called a *conflation* if it realizes some E-extension $\delta \in \mathbb{E}(C, A)$. In this case, x is called an *inflation* and y is called a *deflation*.

(2) If a conflation $A \xrightarrow{x} B \xrightarrow{y} C$ realizes $\delta \in \mathbb{E}(C, A)$, we call the pair $(A \xrightarrow{x} B \xrightarrow{y} C, \delta)$ an E-triangle, and write it in the following way.

$$
A \xrightarrow{x} B \xrightarrow{y} C - \xrightarrow{\delta}
$$

We usually do not write this " δ " if it is not used in the argument.

(3) Let $A \xrightarrow{x} B \xrightarrow{y} C - \xrightarrow{\delta}$ and $A' \xrightarrow{x'} B' \xrightarrow{y'}$ $C' - \frac{\delta'}{\delta}$ be any pair of E-triangles. If a triplet (a, b, c) realizes $(a, c) : \delta \to \delta'$, then we write it as

$$
A \xrightarrow{x} B \xrightarrow{y} C - \xrightarrow{\delta} \rightarrow

and call (a, b, c) a morphism of E-triangles.

(4) (i) For an inflation $f \in \mathcal{C}(A, B)$, take a conflation $A \xrightarrow{f} B \longrightarrow C$, and denote this C by $Cone(f).$

(ii) For a deflation $f \in \mathcal{C}(A, B)$, take a conflation $L \longrightarrow A \stackrel{f}{\longrightarrow} B$, and denote this L by $CoCone(f)$.

Assume that $(C, \mathbb{E}, \mathfrak{s})$ is an extriangulated category. By Yoneda's Lemma, any E-extension $\delta \in \mathbb{E}(C, A)$ induces natural transformations

$$
\delta_{\sharp}: \mathcal{C}(-, C) \Rightarrow \mathbb{E}(-, A)
$$
 and $\delta^{\sharp}: \mathcal{C}(A, -) \Rightarrow \mathbb{E}(C, -)$.

For any $X \in \mathcal{C}$, these $(\delta_{\sharp})_X$ and δ_X^{\sharp} are given as follows:

- (1) $(\delta_{\sharp})_X : C(X, C) \Rightarrow \mathbb{E}(X, A); f \mapsto f^* \delta.$
- (2) $\delta_X^{\sharp}: \mathcal{C}(A, X) \Rightarrow \mathbb{E}(C, X); g \mapsto g_* \delta.$

Lemma 2.10. [\[14,](#page-22-4) Corollary 3.12] Let $(C, \mathbb{E}, \mathfrak{s})$ be an extriangulated category, and

$$
A \xrightarrow{x} B \xrightarrow{y} C \xrightarrow{-\delta}
$$

an E-triangle. Then we have the following long exact sequences:

$$
\mathcal{C}(C,-) \xrightarrow{\mathcal{C}(y,-)} \mathcal{C}(B,-) \xrightarrow{\mathcal{C}(x,-)} \mathcal{C}(A,-) \xrightarrow{\delta^{\sharp}} \mathbb{E}(C,-) \xrightarrow{\mathbb{E}(y,-)} \mathbb{E}(B,-) \xrightarrow{\mathbb{E}(x,-)} \mathbb{E}(A,-);
$$

$$
\mathcal{C}(-,A) \xrightarrow{\mathcal{C}(-,x)} \mathcal{C}(-,B) \xrightarrow{\mathcal{C}(-,y)} \mathcal{C}(-,C) \xrightarrow{\delta_{\sharp}} \mathbb{E}(-,A) \xrightarrow{\mathbb{E}(-,x)} \mathbb{E}(-,B) \xrightarrow{\mathbb{E}(-,y)} \mathbb{E}(-,C).
$$

By $(ET4)$ and $(ET)^{op}$, we can directly obtain the following results.

- **Lemma 2.11.** Let $(C, \mathbb{E}, \mathfrak{s})$ be an extriangulated category. Then the following statements hold. (1) If f and g are inflations, then gf is an inflation, and there exists a conflation $Cone(f) \longrightarrow Cone(gf) \longrightarrow Cone(g)$ in C.
	- (2) If f and g are deflations, then gf is a deflation, and there exists a conflation $\text{CoCone}(f) \longrightarrow \text{CoCone}(gf) \longrightarrow \text{CoCone}(g) \text{ in } \mathcal{C}.$

Lemma 2.12. Let $(C, \mathbb{E}, \mathfrak{s})$ be an extriangulated category and $f : A \rightarrow B, q : B \rightarrow C$ are morphisms in \mathcal{C} . Then the following statements hold.

(1) If f is an inflation, gf is a deflation, then g is a deflation, and there exists a conflation

 $\text{CoCone}(gf) \longrightarrow \text{CoCone}(g) \longrightarrow \text{Cone}(f) \text{ in } \mathcal{C}.$ (2) If g is a deflation, gf is an inflation, then f is an inflation, and there exists a conflation $\text{CoCone}(g) \longrightarrow \text{Cone}(f) \longrightarrow \text{Cone}(gf) \text{ in } \mathcal{C}.$

Proof. By duality, we only prove (1). Assume there are E-triangles $A \xrightarrow{f} B \xrightarrow{f'}$ Cone (f) ^{δ_f} \rightarrow and $CoCone(gf) \xrightarrow{h} A \xrightarrow{gf} C \xrightarrow{\delta_h} S$ So there exist morphisms of E-triangles which make the following diagram commutative

by (ET4). It follows from [\[14,](#page-22-4) Lemma 3.13] that the upper right square of above diagram is a weak pushout, then there exists a commutative diagram

Hence t is a splitting deflation. Since k' is a deflation, $g = tk'$ is a deflation.

Assume that $CoCone(g)$ ^{g'} $B \xrightarrow{g} C - \xrightarrow{\delta_{g'}}$ is an E-triangle. Then there exist morphisms of E-triangles which make the following diagram commutative

\begin{array}{ccc}\n\text{CoCone}(gf) & \xrightarrow{h} & A & \xrightarrow{gf} & C & \xrightarrow{\delta_h} & \\

by [\[14,](#page-22-4) Proposition 3.17]. So we have a conflation $\text{CoCone}(gf) \longrightarrow \text{CoCone}(g) \longrightarrow \text{Cone}(f)$ in C.

(Extension-Lifting Lemma) The Extension-Lifting Lemma will play important roles. It has been proved for abelian categories and for exact categories.

Lemma 2.13. Let $(C, \mathbb{E}, \mathfrak{s})$ be an extriangulated category and $X, Y \in \mathcal{C}$. Then $\mathbb{E}(X, Y) = 0$ if and only for any commutative diagram with E-triangles

there exists a morphism $h : B \to C$ such that $f = hi$ and $g = ph$.

Proof. " \Leftarrow ". Let $\delta \in \mathbb{E}(X, Y)$. Then there exists a conflation $Y \xrightarrow{c} C \xrightarrow{p} X$ which realizes δ , so we have a commutative diagram with E-triangles

Therefore, there exists a morphism $h: X \to C$ such that $ph = 1_X$, which implies $\delta = 0$, and so $\mathbb{E}(X, Y) = 0$.

" \Rightarrow ". Assume that $\mathbb{E}(X, Y) = 0$. For any commutative diagram with E-triangles

such that the right square is a weak pullback by the dual of $[14, \text{ Corallary } 3.16]$. There exists a morphism $t : A \to K$ such that $f = kt$ and $i = yt$ since $pf = gi$. Note that i is an inflation and y is a deflation. It follows from Lemma $2.12(2)$ $2.12(2)$ that t is an inflation. Assume that $A \longrightarrow K \longrightarrow' L - \rightarrow$ is an E-triangle. Since $i = yt$, there exists a commutative diagram with E-triangles

with $\theta = s^* \eta$ and $d^* \rho = g^* \delta$ by the dual of [\[14,](#page-22-4) Proposition 3.17]. Hence $\rho = 0$ because $\mathbb{E}(X,Y) = 0$, which implies $g^*\delta = 0$. So there exists a morphism $r : B \to K$ such that $yr = 1_B$. Then $p(f - kri) = 0$, there exists a morphism $m : A \rightarrow Y$ such that $f - kri = cm$. By exactness of the sequence $\mathcal{C}(B, Y) \xrightarrow{\mathcal{C}(i,Y)} \mathcal{C}(A, Y) \longrightarrow \mathbb{E}(X, Y) = 0$, there is a morphism $n : B \to Y$ such that $m = ni$. Put $h = cn + kr$, then $f = hi$ and $ph = g$, as desired.

Definition 2.14. [\[14,](#page-22-4) Condition 5.8] An extriangulated category $(C, \mathbb{E}, \mathfrak{s})$ satisfies *Condition* (WIC) if the following two conditions hold:

(a) If $f \in C(A, B)$ and $g \in C(B, C)$ is a pair of composable morphisms in C and gf is an inflation, then so is f .

(b) If $f \in C(A, B)$ and $g \in C(B, C)$ is a pair of composable morphisms in C and gf is a deflation, then so is q .

Remark 2.15. (i) If the category C is exact, then $(C, \mathbb{E}, \mathfrak{s})$ satisfies Condition (WIC) if and only if $\mathcal C$ is weakly idempotent complete.

(ii) If C is a triangulated category, then Condition (WIC) is automatically satisfied.

It is worth nothing that an extrianglated category $\mathcal C$ satisfies Condition (WIC) if and only if $\mathcal C$ is weakly idempotent complete, see [\[13,](#page-22-8) Proposition C]. In this paper, we always assume that any extrianglated category is weakly idempotent complete.

2.2 Cotorsion pairs in extriangulated categories.

Definition 2.16. Let $(C, \mathbb{E}, \mathfrak{s})$ be an extriangulated category and W a class of objects in C.

(1) W is closed under cocones of deflations if for any E-triangle $A \xrightarrow{x} B \xrightarrow{y} C - \xrightarrow{\delta}$ which satisfies $B, C \in \mathcal{W}$, we have $A \in \mathcal{W}$.

(2) W is closed under cones of inflations if for any E-triangle $A \xrightarrow{x} B \xrightarrow{y} C - \xrightarrow{\delta}$ which satisfies $A, B \in \mathcal{W}$, we have $C \in \mathcal{W}$.

(3) W is closed under extensions if for any E-triangle $A \xrightarrow{x} B \xrightarrow{y} C - \xrightarrow{\delta}$ which satisfies $A, C \in \mathcal{W}$, we have $B \in \mathcal{W}$.

Definition 2.17. [\[14,](#page-22-4) Dfinition 4.1] Assume that $(C, \mathbb{E}, \mathfrak{s})$ is an extriangulated category and \mathcal{X}, \mathcal{Y} are two classes of objects in C. We call $(\mathcal{X}, \mathcal{Y})$ a *cotorsion pair* if it satisfies the following conditions:

(a) $\mathbb{E}(\mathcal{X}, \mathcal{Y}) = 0.$

(b) For any $C \in \mathcal{C}$, there are E-triangles

 $Y_C \longrightarrow X_C \longrightarrow C \longrightarrow$ and $C \longrightarrow Y^C \longrightarrow X^C \longrightarrow$ satisfying $X_C, X^C \in \mathcal{X}$ and $Y_C, Y^C \in \mathcal{Y}$.

We say that a cotorsion pair $(\mathcal{X}, \mathcal{Y})$ is *hereditary* if X is closed under cocones of deflations and Y is closed under cones of inflations. The following result gives several equivalent conditions of a cotorsion pair being hereditary.

Proposition 2.18. Let $(C, \mathbb{E}, \mathfrak{s})$ be an extriangulated category and $(\mathcal{X}, \mathcal{Y})$ a cotorsion pair. Consider the following conditions:

- (1) $\mathbb{E}^i(X,Y) = 0$ for each $i \geq 2$ and all $X \in \mathcal{X}$ and $Y \in \mathcal{Y}$.
- (2) Y is closed under cones of inflations.
- (3) X is closed under cocones of deflations.
- (4) (X, Y) is hereditary.

Then $(1) \Rightarrow (2) \Leftrightarrow (3) \Leftrightarrow (4)$. The converses hold if C has enough projectives and injectives.

Proof. (1) \Rightarrow (2) is trivial.

 $(2) \Rightarrow (3)$. Assume that $A \xrightarrow{x} X_1 \xrightarrow{y} X_2 --\n \Rightarrow$ is an E-triangle with $X_1, X_2 \in \mathcal{X}$. Next we claim that any morphism $f : A \to Y$ with $Y \in Y$ can factor through ω . Since $\mathbb{E}(X_2, Y) = 0$, it is easy to see that there is a morphism $g: X_1 \to Y$ such that $f = gx$. As (X, Y) is a cotorsion pair, there is an E-triangle $X_1 \longrightarrow Y' \longrightarrow X -- \rightarrow \text{ with } X \in \mathcal{X}$, and $Y' \in \omega$ because X is closed under extensions. So g can factor through Y' as $\mathbb{E}(X,Y) = 0$, hence f factors through ω .

Since $(\mathcal{X}, \mathcal{Y})$ is a cotorsion pair, there are E-triangles

$$
Y_1 \longrightarrow X_3 \longrightarrow A -- \succ \text{ and } X_3 \longrightarrow W \longrightarrow X_4 -- \succ
$$

with $X_3, X_4 \in \mathcal{X}, Y_1 \in \mathcal{Y},$ and $W \in \omega$ because X is closed under extensions. Hence there is a commutative diagram with E-triangles

by (ET4). Note that $Y_1, W \in \mathcal{Y}$, we have $Y'' \in \mathcal{Y}$ since \mathcal{Y} is closed under cones of inflations. Then f factors through ω by above argument, it is easy to check that f factors through W. Therefore, 1_{Y_1} factors through g by [\[14,](#page-22-4) Corollary 3.5], which implies that A is isomorphism a direct summand of X_3 . So we have $A \in \mathcal{X}$.

- $(3) \Rightarrow (2)$. The proof is similar to that of $(2) \Rightarrow (3)$.
- $(3) \Rightarrow (4)$ is clear because of the equivalence of (2) and (3) .
- $(4) \Rightarrow (1)$ follows from [\[12,](#page-22-9) Lemma 4.3].

Remark 2.19. It should be noted that the notion of hereditary cotorsion pairs introduced here is different from that of [\[2,](#page-22-7) Definition 3.1], where the authors call a cotorsion pair $(\mathcal{X}, \mathcal{Y})$ hereditary if it satisfies the condition (1) of Proposition [2.18.](#page-9-0)

2.3 Model structures.

Definition 2.20. A *closed model structure* on a category M is a triple (CoFib,Fib,Weq) of classes of morphisms, where the morphisms in the three classes are respectively called cofibration, fibrations, and weak equivalences, satisfying the following axioms:

(Two out of three axiom) Let $f : A \rightarrow B$ and $g : B \rightarrow C$ be a pair of composable morphisms in M. If two of the morphisms f, g, gf are weak equivalences, then so is the third one.

(Retract axiom) If g is a retract of f, and f is a cofibration (a fibration, a weak equivalence, respectively), then so is q .

(Lifting axiom) Cofibrations have the left lifting property with respect to all morphisms in Fib ∩ Weq, and fibrations have the right lifting property with respect to all morphisms in $CoFib \cap Weq$. That is, given a commutative diagram

If either $i \in \text{CoFib}$ and $p \in \text{Fib} \cap \text{Weq}$, or $i \in \text{CoFib} \cap \text{Weq}$ and $p \in \text{Fib}$, then there exists a morphism $h : B \to X$ such that $a = hi, b = ph$.

(Factorization axiom) Any morphism $f : A \rightarrow B$ admits factorizations $f = pi$ and $f = qj$, where $i \in \text{CoFib} \cap \text{Weq}, p \in \text{Fib}, j \in \text{CoFib} \text{ and } q \in \text{Fib} \cap \text{Weq}.$

The morphisms in CoFib∩ Weq (respectively, Fib∩ Weq) are called *trivial cofibrations* (respectively, trivial fibrations). Put TCoFib := CoFib ∩ Weq and TFib := Fib ∩ Weq.

For a model structure (CoFib, Fib, Weq) on category $\mathcal M$ with zero object, an object X is trivial if $0 \to X$ is a weak equivalence, or, $X \to 0$ is a weak equivalence. It is *cofibrant* if $0 \to X$ is a cofibration, and it is *fibrant* if $X \to 0$ is a fibration. An object is *trivial cofibrant* (respectively, trivial fibrant) if it is both trivial and cofibrant (respectively, fibrant).

3. Proof of Theorem [1.1](#page-1-0)

Throughtout this section, we always assume that $\mathcal{C} := (\mathcal{C}, \mathbb{E}, \mathfrak{s})$ is a weakly idempotent complete extriangulated category.

3.1. Model structures induces by a hereditary cotorsion pair. The aim of this subsection is to prove the "if" part of Theorem [1.1.](#page-1-0) Thus, we must check that these structures in Theorem [1.1](#page-1-0) satisfy the factorization, two-out-of-three, retract and lifting axioms for a model structure. We first make some preliminary observations. First of all, we give a description of trivial cofibrations $TCoFib_{\omega}$ and trivial fibrations $TFib_{\omega}$. Since $1_X \in TFib_{\omega}$ and $1_X \in TCoFib_{\omega}$ for any object $X \in \mathcal{C}$, we have $TCoFib_{\omega} \subseteq Weq_{\omega}$ and $TFib_{\omega} \subseteq Weq_{\omega}$.

We begin the proof with the descriptions of $\mathrm{CoFib}_{\omega} \cap \mathrm{Weq}_{\omega}$ and $\mathrm{Fib}_{\omega} \cap \mathrm{Weq}_{\omega}$.

Proposition 3.1. Let \mathcal{X}, \mathcal{Y} be full subcategories of C which are closed under direct summands and isomorphisms, and $\omega := \mathcal{X} \cap \mathcal{Y}$. If $\mathbb{E}(\mathcal{X}, \mathcal{Y}) = 0$, then we have

$$
\mathrm{TCoFib}_{\omega} = \mathrm{CoFib}_{\omega} \cap \mathrm{Weq}_{\omega}, \quad \mathrm{TFib}_{\omega} = \mathrm{Fib}_{\omega} \cap \mathrm{Weq}_{\omega}.
$$

Proof. We first prove $TCoFib_{\omega} = CoFib_{\omega} \cap Weq_{\omega}$. It is to see that $TCoFib_{\omega} \subseteq CoFib_{\omega} \cap Weq_{\omega}$. Conversely, if $f : A \to B \in \mathrm{CoFib}_{\omega} \cap \mathrm{Weq}_{\omega}$, then f is an inflation with $\mathrm{Cone}(f) \in \mathcal{X}$ and there is an E-triangle $Y \xrightarrow{x} A \oplus W \xrightarrow{(f,t)} B - \rightarrow \infty$ with $W \in \omega$ and $Y \in \mathcal{Y}$. Suppose $A \longrightarrow B \longrightarrow \text{Cone}(f) \longrightarrow^{\eta}$ is an E-triangle with $\text{Cone}(f) \in \mathcal{X}$. Since $f = (f, t) \begin{pmatrix} 1 & 0 \\ 0 & 1 \end{pmatrix}$ $\binom{1}{0}$, there exists a commutative diagram of E-triangles

with $\delta = g^*\rho$ by the dual of [\[14,](#page-22-4) Proposition 3.17]. Since $\mathbb{E}(\mathcal{X}, \mathcal{Y}) = 0$, we have $\rho = 0$, which implies that $Cone(f) \in \omega$ as $Cone(f)$ is a direct summand of W. Meanwhile, we have $\delta = g^*\rho = 0$. It is easy to check that $\mathcal{C}(\text{Cone}(f), g)$ is surjective by applying the functor $\mathcal{C}(\text{Cone}(f),-)$ to above commutative diagram. Therefore, f is a splitting inflation, and so $f \in \text{TCoFib}_{\omega}$ by definition. This proves $\text{TCoFib}_{\omega} = \text{CoFib}_{\omega} \cap \text{Weq}_{\omega}$.

Next we prove $TFib_{\omega} = Fib_{\omega} \cap Weq_{\omega}$. It is easy to check that $TFib_{\omega} \subseteq Fib_{\omega}$, and so $\text{TFib}_{\omega} \subseteq \text{Fib}_{\omega} \cap \text{Weq}_{\omega}$ since $\text{TFib}_{\omega} \subseteq \text{Weq}_{\omega}$. Conversely, if $f \in \text{Fib}_{\omega} \cap \text{Weq}_{\omega}$, there is an \mathbb{E}_{ω} triangle $\text{CoCone}(f, t) \xrightarrow{x} A \oplus W \xrightarrow{(f, t)} B - \rightarrow \infty$ with $W \in \omega$ and $\text{CoCone}(f, t) \in \mathcal{Y}$. Since f is ω -epic, there is a morphism $s: W \to A$ such that $t = fs$. Then $(f, t) = f(1, s)$. Note that $(C, \mathbb{E}, \mathfrak{s})$ is an extriangulated category satisfies Condition (WIC) and (f, t) is a deflation. It follows that f is a deflation. So we have a commutative diagram with $\mathbb{E}\text{-triangles}$

by $(ET3)^{op}$. So we have a commutative diagram with E-triangles

Hence, hg is an isomorphism, which implies that $\mathrm{CoCone}(f)$ is a direct summand of $\mathrm{CoCone}(f, t)$, thus $CoCone(f) \in \mathcal{Y}$. So $f \in \text{TFib}_{\omega}$. This completes the proof.

The following is the Factorization axiom.

Proposition 3.2. Let (X, Y) be a hereditary cotorsion pair, and $\omega := X \cap Y$. Then we have $\text{Mor}(\mathcal{C}) = \text{TFib}_{\omega} \circ \text{CoFib}_{\omega} = \text{Fib}_{\omega} \circ \text{TCoFib}_{\omega}.$

To prove Proposition [3.2,](#page-12-0) we need the following lemma.

Lemma 3.3. Let $(\mathcal{X}, \mathcal{Y})$ be a hereditary cotorsion pair, and $\omega := \mathcal{X} \cap \mathcal{Y}$. Then the following classes of morphisms

$$
\mathrm{CoFib}_\omega,\ \mathrm{Fib}_\omega,\ \mathrm{TCoFib}_\omega,\ \mathrm{TFib}_\omega
$$

are closed under compositions.

Proof. For TCoFib_{ω}, this follows from splitting inflations are closed under compositions, the extension-closedness of ω and Lemma [2.11.](#page-5-1) Similarly for the others.

Proof of Proposition [3.2](#page-12-0). We can prove $\text{Mor}(\mathcal{C}) = \text{Fib}_{\omega} \circ \text{TCoFib}_{\omega}$ by a similar proof of [\[6,](#page-22-6) The first factorization]. Next we prove $\text{Mor}(\mathcal{C}) = \text{TFib}_{\omega} \circ \text{CoFib}_{\omega}$. For any morphism $f : A \to B$, there exists an E-triangle $Y_B \longrightarrow X_B \xrightarrow{t} B -- \rightarrow \text{ with } X_B \in \mathcal{X}$ and $Y_B \in \mathcal{Y}$. Hence there is a deflation $(f, t) : A \oplus X_B \to B$ by the dual of [\[14,](#page-22-4) Corollary 3.16]. Assume that $K \longrightarrow A \oplus X_B \stackrel{(f, t)}{\longrightarrow} B -- \succ$ is an E-triangle. There exists an E-triangle $K \longrightarrow Y^K \longrightarrow X^K --\rightarrow$ with $X^K \in \mathcal{X}$ and $Y^K \in \mathcal{Y}$. It follows from [\[14,](#page-22-4) Proposition 3.15] that there is a commutative diagram of E-triangles

Then $i \in \text{CoFib}_{\omega}$ and $h \in \text{TFib}_{\omega}$ by definition.

Note that $\begin{pmatrix} 1 \\ 0 \end{pmatrix}$ $\binom{1}{0}$: $A \to A \oplus X_B \in \mathrm{CoFib}_{\omega}$, one has $i \circ \binom{1}{0}$ $\binom{1}{0}$ \in CoFib_{ω} by Lemma [3.3.](#page-12-1) Thus $f = h(i \circ \int_0^1$ $\binom{1}{0}$ \in TFib_ω \circ CoFib_ω, as desired. **Lemma 3.4.** Let $(\mathcal{X}, \mathcal{Y})$ be a hereditary cotorsion pair, and $\omega := \mathcal{X} \cap \mathcal{Y}$. Then we have

$$
\mathrm{TCoFib}_{\omega}\circ\mathrm{TFib}_{\omega}\subseteq \mathrm{Weq}_{\omega}.
$$

Moreover, the class Weq_{ω} is closed under compositions.

Proof. Let $a \in \text{TFib}_{\omega}$ and $x' \in \text{TCoFib}_{\omega}$. Hence there are some $x \in \text{CoFib}_{\omega}$ and $b \in \text{TFib}_{\omega}$ such that $x'a = bx$ by Proposition [3.2.](#page-12-0) It suffices to show that $x \in \text{TCoFib}_{\omega}$. There are Etriangles $A' \xrightarrow{x'} B' \xrightarrow{y'}$ $W \xrightarrow{\delta'}$ > , $A \xrightarrow{x} B \xrightarrow{y} X \xrightarrow{\delta}$ > , $Y \xrightarrow{k} A \xrightarrow{a} A' \xrightarrow{\eta}$ > and $Y' \xrightarrow{k'} B' \xrightarrow{b} B' \xrightarrow{\theta} \ast$ with $Y, Y' \in \mathcal{Y}, X \in \mathcal{X}, W \in \omega$ and x' is a splitting inflation by definition. Therefore there is a commutative diagram with E-triangles

such that (k, k', k'') , (m, x, x') and (m', y, y') are morphisms of E-triangles by [\[14,](#page-22-4) Lemma 5.9]. Note that $Y, Y' \in \mathcal{Y}$ and \mathcal{Y} is closed under cones of inflations. Then we have $Y'' \in \mathcal{Y}$. It is easy to see that $X \in \omega$ as $\mathcal Y$ is closed under extensions. Since $\mathbb E(\mathcal X, \mathcal Y) = 0$, one has $\rho = 0$, which implies $Y'' \in \omega$ because Y'' is a direct summand of X. So we have $\delta'' = 0$ as $\delta'' \in \mathbb{E}(\mathcal{X}, \mathcal{Y})$. Applying the functor $C(X, -)$ to above commutative diagram, it is easy to check that $C(X, y)$: $\mathcal{C}(X, B) \to \mathcal{C}(X, X)$ is surjective by Snake Lemma. Therefore, x is a splitting inflation, and one has $x \in \mathrm{TCoFib}_{\omega}$.

It is easy to check that the class Weq_{ω} is closed under compositions by Lemma [3.3.](#page-12-1)

Lemma 3.5. Let $(\mathcal{X}, \mathcal{Y})$ be a hereditary cotorsion pair, and $\omega := \mathcal{X} \cap \mathcal{Y}$. If $f : A \to B$ is a morphism in Weq_{ω} , then the morphism $(f, t) : A \oplus W \to B$ is in $TFib_{\omega}$ for an arbitrary right ω -approximation morphism $t: W \to B$.

Proof. By the assumption, there is a morphism $(f, t') : A \oplus W' \to B$ in TFib_{ω} with $W' \in \omega$ and $CoCone(f, t') \in \mathcal{Y}$. Let $t : W \to B$ be any right ω -approximation. Then there is a morphism $s: W' \to W$ such that $t' = ts$. Since (f, t') is a deflation and $(f, t') = (f, t) \begin{pmatrix} 1 & 0 \\ 0 & s \end{pmatrix}$ $\begin{pmatrix} 1 & 0 \\ 0 & s \end{pmatrix}$ $(f, t) : A \oplus W \to B$ is also a deflation. It remains to prove that $\text{CoCone}(f, t) \in \mathcal{Y}$.

Since $\begin{pmatrix} 1 & 0 \\ 0 & 1 \end{pmatrix}$ $\begin{pmatrix} 1 & 0 \\ 0 & 1 \\ 0 & 0 \end{pmatrix}$: $A \oplus W' \rightarrow A \oplus W' \oplus W$ is a splitting inflation with Cone $\begin{pmatrix} 1 & 0 \\ 0 & 1 \\ 0 & 0 \end{pmatrix}$ $\begin{pmatrix} 1 & 0 \\ 0 & 1 \\ 0 & 0 \end{pmatrix}$ = $W \in \omega$. Note that $\begin{pmatrix} 1 & 0 \\ 0 & 1 \\ 0 & 0 \end{pmatrix}$ is an inflation and $(f, t') = (f, t', t) \begin{pmatrix} 1 & 0 \\ 0 & 1 \\ 0 & 0 \end{pmatrix}$ is a deflation, it follows from Lemma [2.12\(](#page-5-0)2) that (f, t', t) is a deflation. Therefore, there is a commutative diagram with E-triangles

by [\[14,](#page-22-4) Proposition 3.17]. Hence $\text{CoCone}(f, t', t) \in \mathcal{Y}$ because \mathcal{Y} is closed under extensions. Since $(f, t) = (f, t', t) \begin{pmatrix} 1 & 0 \\ 0 & 0 \end{pmatrix}$ $\begin{pmatrix} 1 & 0 \\ 0 & 0 \\ 0 & 1 \end{pmatrix}$ and $(f, t', t) = (f, t) \begin{pmatrix} 1 & 0 & 0 \\ 0 & s & 1 \end{pmatrix}$ $\begin{pmatrix} 1 & 0 & 0 \\ 0 & s & 1 \end{pmatrix}$, there is a commutative diagram of E-triangles

Note that $\begin{pmatrix} 1 & 0 & 0 \\ 0 & s & 1 \end{pmatrix}$ $\begin{pmatrix} 1 & 0 & 0 \\ 0 & s & 1 \end{pmatrix} \begin{pmatrix} 1 & 0 \\ 0 & 0 \end{pmatrix}$ $\begin{pmatrix} 1 & 0 \\ 0 & 0 \\ 0 & 1 \end{pmatrix} = \begin{pmatrix} 1 & 0 \\ 0 & 1 \end{pmatrix}$, so we have a commutative diagram of \mathbb{E} triangles

Therefore, hg is an isomorphism, which implies that $CoCone(f, t)$ is a direct summand of $CoCone(f, t', t)$, thus $CoCone(f, t) \in \mathcal{Y}$. This completes the proof.

Lemma 3.6. Let $f : A \to B$ and $g : B \to C$ be morphisms in C with $f \in \text{TFib}_{\omega}$ and $gf \in \text{Weq}_{\omega}$. Then $g \in \text{Weq}_{\omega}$.

Proof. Let $t : W \to C$ be a right ω -approximation of C. It follows from Lemma [3.5](#page-13-0) that (qf, t) : $A \oplus W \to C$ is in TFib_{ω} as $gf \in \text{Weq}_{\omega}$, that is, (gf, t) is a deflation with $\text{CoCone}(gf, t) \in \mathcal{Y}$. Note that $(gf, t) = (g, t) \begin{pmatrix} f & 0 \\ 0 & 1 \end{pmatrix}$, which implies that $(g, t) : B \oplus W \to C$ is a deflation. Then

there is a commutative diagram of E-triangles

by [\[14,](#page-22-4) Remark 2.2]. Since $\text{CoCone}\begin{pmatrix} f & 0 \\ 0 & 1 \end{pmatrix} = \text{CoCone}(f) \in \mathcal{Y}$, which implies that $\text{CoCone}(g, t) \in$ y because y is closed under cones of inflations. So $(g, t) \in \text{TFib}_{\omega}$, and we have $g \in \text{Weq}_{\omega}$ by definition. \Box

Lemma 3.7. Let $f : A \to B$ and $g : B \to C$ be morphisms in C such that $f, gf \in Weq_{\omega}$. Then $g \in \text{Weq}_{\omega}$.

Proof. Since $f \in \text{Weq}_{\omega}$, there is a morphism $(f, t) : A \oplus W \to B$ with $W \in \omega$ such that $(f, t) \in \text{TFib}_{\omega}$. To prove $g \in \text{Weq}_{\omega}$, it suffices to prove $(gf, gt) \in \text{Weq}_{\omega}$ by the the commutative diagram

and Lemma [3.6.](#page-14-0)

Let $t': W' \to C$ be a right ω -approximation of C. It follows from Lemma [3.5](#page-13-0) that (gf, t') : $A \oplus W' \to C$ is in TFib_{ω} as $gf \in \text{Weq}_{\omega}$, that is, (gf, t') is a deflation with $\text{CoCone}(gf, t') \in \mathcal{Y}$. Since $\begin{pmatrix} 1 & 0 \\ 0 & 1 \end{pmatrix}$ $\begin{pmatrix} 1 & 0 \\ 0 & 1 \\ 0 & 0 \end{pmatrix}$: $A \oplus W' \rightarrow A \oplus W' \oplus W$ is a splitting inflation with Cone $\begin{pmatrix} 1 & 0 \\ 0 & 1 \\ 0 & 0 \end{pmatrix}$ $\left(\begin{smallmatrix} 1 & 0 \ 0 & 1 \ 0 & 0 \end{smallmatrix}\right) = W \in \omega.$ Note that $\begin{pmatrix} 1 & 0 \\ 0 & 1 \\ 0 & 0 \end{pmatrix}$ is an inflation and $(gf, t') = (gf, t', gt) \begin{pmatrix} 1 & 0 \\ 0 & 1 \\ 0 & 0 \end{pmatrix}$ is a deflation, where (gf, t', gt) : $A \oplus W' \oplus W \to C$. It follows from Lemma [2.12\(](#page-5-0)2) that (gf, t', gt) is a deflation. Therefore, there is a commutative diagram with E-triangles

by [\[14,](#page-22-4) Proposition 3.17]. Since $\text{CoCone}(gf, t') \in \mathcal{Y}$ and $W \in \mathcal{Y}$, which implies $\text{CoCone}(gf, t', gt) \in \mathcal{Y}$ \mathcal{Y} , and hence $(gf, t', gt) \in \text{TFib}_{\omega}$. Therefore, $(gf, gt) \in \text{Weq}_{\omega}$ by the commutative diagram

This completes the proof. \Box

Lemma 3.8. Let Let $f : A \to B$ and $g : B \to C$ be morphisms in C with $gf \in \text{Weq}_\omega$, $f \in \text{CoFib}_\omega$ and $g \in \text{TFib}_{\omega}$. Then $f \in \text{Weq}_{\omega}$.

Proof. We first show that f is a splitting inflation. Since $f \in \text{CoFib}_{\omega}$, f is an inflation with Cone(f) $\in \mathcal{X}$. Since $h := gf \in \text{Weq}_{\omega}$, there is a deflation $(h, t) : A \oplus W \to C$ with $W \in \omega$ and $CoCone(h, t) \in \mathcal{Y}$. Consider the commutative diagram with E-triangles

Since $\mathbb{E}(\text{Cone}(f), \text{CoCone}(h, t)) = 0$, there exists a morphism $\binom{s_1}{s_2}$ $S_{s_2}^{s_1}$: $B \to A \oplus W$ such that $1_A = sf$ by Lemma [2.13,](#page-7-0) which implies that f is a splitting inflation. It remains to prove that $Cone(f) \in \mathcal{Y}$.

Since f is a splitting inflation, one can write $h = pi$ as

Note that $(h, t') = (h, t, t') \begin{pmatrix} 1 & 0 \\ 0 & 0 \end{pmatrix}$ $\begin{pmatrix} 1 & 0 \\ 0 & 0 \\ 0 & 1 \end{pmatrix}$ is a deflation where $(h, t, t') : A \oplus W \oplus X \rightarrow C$, and $\begin{pmatrix} 1 & 0 \\ 0 & 0 \\ 0 & 1 \end{pmatrix}$: $A \oplus X \to A \oplus W \oplus X$ is an inflation. It follows from Lemma [2.12\(](#page-5-0)2) that (h, t, t') is a deflation. Therefore, there is a commutative diagram with E-triangles

by [\[14,](#page-22-4) Proposition 3.17]. Since $CocOne(h, t') \in \mathcal{Y}$ and $W \in \omega$, we have $CocOne(h, t, t') \in \mathcal{Y}$. The commutative square

by the dual of [\[8,](#page-22-10) Lemma 3.1(2)]. Since $CoCone(h, t)$, $CoCone(h, t, t') \in \mathcal{Y}$, we have $X \in \mathcal{Y}$ as (X, Y) is a hereditary cotorsion pair. This completes the proof.

Lemma 3.9. Let $f : A \to B$ and $g : B \to C$ be morphisms in C with $gf, g \in W$ eq_{ω}. Then $f \in \text{Weq}_{\omega}.$

Proof. The proof is similar to [\[6,](#page-22-6) Lemma 3.10].

Now, Lemmas [3.4,](#page-13-1) [3.7](#page-15-0) and [3.9](#page-17-0) yield the Two out of three axiom.

Proposition 3.10. Let $f : A \to B$ and $g : B \to C$ be morphisms in C. If two of three morphisms f, g, gf in Weq_ω , then so is the third.

In the following, we prove that CoFib_ω , Fib_ω and Weq_ω are closed under retracts. Suppose that $g: A \to B$ is a retract of $f: C \to D$, i.e., one has a commutative diagram of morphisms

with $ca = 1_A$ and $db = 1_B$.

Lemma 3.11. CoFib_{ω}, TCoFib_{ω}, and TFib_{ω} are closed under retracts.

Proof. Let $f \in \text{CoFib}_{\omega}$, i.e., f is an inflation with $\text{Cone}(f) \in \mathcal{X}$. Since $bg = fa$ is an inflation, g is an inflation. So there exist morphisms m and n which make the following diagram commutative

where all columns are E-triangles by $(ET3)$. Hence there is a commutative diagram with Etriangles

Therefore nm is an isomorphism, which implies that m is a splitting inflation. So Cone(q) is a direct summand of $Cone(f)$. Hence $Cone(g) \in \mathcal{X}$, and one has $g \in \text{CoFib}_{\omega}$.

Similarly for the others. \Box

Lemma 3.12. Fib_ω is closed under retracts.

Proof. The proof is similar to that of Fib_ω is closed under retracts in [\[6\]](#page-22-6).

Lemma 3.13. Weq_{ω} is closed under retracts.

Proof. Let $g = g_1 \oplus g_2 : A_1 \oplus A_2 \to B_1 \oplus B_2$ and suppose that $g \in \text{Weq}_{\omega}$. Then g_i factor as $g_n = p_n i_n$, $i_n \in \text{Cofib}_\omega, p_n \in \text{TFib}_\omega$ for $n = 1, 2$ by Proposition [3.2.](#page-12-0) Therefore, $g = g_1 \oplus g_2 =$ $(p_1 \oplus p_2) \circ (i_1 \oplus i_2)$. Since $p_1, p_2 \in \text{TFib}_{\omega}$, one has $p_1 \oplus p_2 \in \text{TFib}_{\omega} \subseteq \text{Weq}_{\omega}$. So we have $i_1 \oplus i_2 \in \text{Weq}_{\omega}$ by Lemma [3.9.](#page-17-0) Since $i_1, i_2 \in \text{CoFib}_{\omega}$, we have $i_1 \oplus i_2 \in \text{CoFib}_{\omega}$. Therefore, $i_1 \oplus i_2 \in \text{CoFib}_{\omega} \cap \text{Weq}_{\omega} = \text{TCoFib}_{\omega}$ by Proposition [3.1,](#page-11-0) which implies that $i_1, i_2 \in \text{TCoFib}_{\omega}$ by Lemma [3.11](#page-17-1) for $n = 1, 2$. Therefore, we have $g_1, g_2 \in W_{\text{eq}}\omega$, i.e. $W_{\text{eq}}\omega$ is closed under retracts. \Box

Proof of the Retract axiom. Now, the Retract axiom follows from Lemmas [3.11](#page-17-1)[-3.13.](#page-18-0) \Box

Finally, we have the following Lifting axiom and its proof is similar to that of Lifting axiom in $[6,$ Subsection 3.5].

Proposition 3.14. We have the following.

- (1) $TCoFib_{\omega}$ satisfies the left lifting property against Fib_{ω} .
- (2) TFib_{ω} satisfies the left lifting property against CoFib $_{\omega}$.

Up to now the "if" part of Theorem [1.1](#page-1-0) is proved.

3.2. Hereditary cotorsion pair arising from a model structure. The aim of this subsection is to prove the "only if" part of Theorem [1.1](#page-1-0) as follows.

Theorem 3.15. Let A be a weakly idempotent complete extriangulated category, \mathcal{X}, \mathcal{Y} full subcategories of C which are closed under direct summands and isomorphisms, and $\omega = \mathcal{X} \cap \mathcal{Y}$. If $(\mathrm{CoFib}_\omega,\mathrm{Fib}_\omega,\mathrm{Weq}_\omega)$ is a model structure, then $(\mathcal{X},\mathcal{Y})$ is a hereditary cotorsion pair in \mathcal{C} , and ω is contravariantly finite in C; and the class \mathcal{C}_{ω} of cofibrant objects is X, the class \mathcal{F}_{ω} of fibrant objects is C, the class W_{ω} of trivial objects is Y; and the homotopy category Ho(C) is \mathcal{X}/\mathcal{W} .

To prove Theorem [3.15,](#page-19-0) we need some preparations. Remark that, a model category $\mathcal M$ induces an equivalence

$$
\mathcal{M}_{cf}/\!\!\sim \stackrel{\simeq}{\longrightarrow} \mathrm{Ho}(\mathcal{M}).
$$

Here, the right hand side is the localization $\mathcal{M}[\text{Weq}^{-1}]$. The left hand side is the category of cofibrant-fibrant objects modulo homotopies. We refer to $[16, 9]$ $[16, 9]$ for a detailed discussion on this matter.

The following lemma is essentially taken from [\[6,](#page-22-6) Section 4.2], where a variation of it appears. The proof given there carries over to the present situation.

Lemma 3.16. Keep the notations as in Theorem [3.15.](#page-19-0) Assume that $(CoFib_{\omega}, Fib_{\omega}, Weq_{\omega})$ is a model structure on C. For any $X, Y \in \mathcal{C}$, morphisms $f, g \in \mathcal{C}(X, Y)$ satisfy $f \sim g$ if and only if $f-g$ factors through some object $W \in \omega$.

Proof of Theorem [3.15.](#page-19-0) By definition one easily sees that $\mathcal{C}_{\omega} = \mathcal{X}$ and $\mathcal{F}_{\omega} = \mathcal{C}$. Next we claim that $W_{\omega} = \mathcal{Y}$. If $Y \in \mathcal{Y}$, since $(0,0) : Y \oplus 0 \to 0$ is a deflation with $0 \in \omega$ and $CoCone(0,0) = Y \in \mathcal{Y}$, hence $0: Y \to 0$ is a weak equivalence by definition, i.e., $Y \in \mathcal{W}_{\omega}$. Conversely, if $Y \in \mathcal{W}_{\omega}$, then $0: Y \to 0$ is a weak equivalence. Hence there is a deflation $(0,0) : Y \oplus W \to 0$ with $CoCone(0,0) = Y \oplus W \in \mathcal{Y}$, which implies $Y \in \mathcal{Y}$. So we have $W_{\omega} = \mathcal{Y}$. Thus $T\mathcal{C}_{\omega} = \mathcal{C}_{\omega} \cap \mathcal{Y} = \omega$ and $T\mathcal{F}_{\omega} = \mathcal{F}_{\omega} \cap \mathcal{W}_{\omega} = \mathcal{Y}$. Thanks to Lemma [3.16,](#page-19-1) we have $\text{Ho}(\mathcal{C}) \cong \mathcal{X}/\mathcal{W}.$

Next we prove that $(\mathcal{X}, \mathcal{Y})$ is a hereditary cotorsion pair. Let $\delta \in \mathbb{E}(X, Y)$ with $X \in \mathcal{X}$ and $Y \in \mathcal{Y}$. Realize it as an E-triangle $Y \xrightarrow{x} A \xrightarrow{y} X - \rightarrow X$. Since Y is in \mathcal{Y} , it follows that y is a trivial fibration. Note that $X \in \mathcal{X} = \mathcal{C}_{\omega}$. Then the morphism $1_X : X \to X$ factors through y by [\[6,](#page-22-6) Lemma 4.2]. Thus δ splits by [\[14,](#page-22-4) Corollary 3.5], and so $\mathbb{E}(X, Y) = 0$.

Let $C \in \mathcal{C}$ be any object, and let $0 \longrightarrow X_C \stackrel{f}{\longrightarrow} C$ be a factorization of $0:0 \to C$ into a cofibration followed by a trivial fibration. Then $X_C \in \mathcal{C}_{\omega} = \mathcal{X}$ by definition. Since f is a trivial fibration, there exists an E-triangle $Y_C \longrightarrow X_C \stackrel{f}{\longrightarrow} C \longrightarrow$ with $Y_C \in \mathcal{Y}$. Dually, there exists an E-triangle $C \longrightarrow Y^C \longrightarrow X^C$ - \rightarrow with $X^C \in \mathcal{X}$ and $Y^C \in \mathcal{Y}$.

We can prove that $\mathcal Y$ is closed under cones of inflations by a similar argument of [\[6,](#page-22-6) Proposition] 1.2], hence $(\mathcal{X}, \mathcal{Y})$ is a hereditary cotorsion pair by Proposition [2.18.](#page-9-0)

Finally, we claim that ω is contravariantly finite. For any object $C \in \mathcal{C}$, there exists an Etriangle $Y_C \longrightarrow X_C \stackrel{f}{\longrightarrow} C \longrightarrow$ with $X_C \in \mathcal{X}$ and $Y_C \in \mathcal{Y}$. Hence f is a trivial fibration by definition. Let $0 \longrightarrow F_C \longrightarrow X_C$ be a factorization of $0: 0 \to X_C$ into a trivial cofibration followed by a fibration. Then $F_C \in \mathcal{T}C_\omega = \omega$. Next claim that $fg : F_C \to C$ is a right ω -approximation of C. Since fibrations are closed under compositions, fg is a fibration. Let $t: W \to C$ be a morphism with $W \in \omega$. Consider the following diagram

Since $0 \to W$ is a trivial cofibration, by the Lifting axiom, t factors through fg. Hence fg : $F_C \to C$ is a right ω -approximation of C.

4. Applications

We begin this section with the following definitions.

Definition 4.1. [\[2,](#page-22-7) Definition 4.1] Let C be an extriangulated category and X a subcategory of C. For each $n \geq 0$, we inductively define subcategories \mathcal{X}_n^{\wedge} and \mathcal{X}_n^{\vee} of C as $\mathcal{X}_n^{\wedge} := \text{Cone}(\mathcal{X}_{n-1}^{\wedge}, \mathcal{X})$ and $\mathcal{X}_n^{\vee} := \text{CoCone}(\mathcal{X}, \mathcal{X}_{n-1}^{\vee}),$ where $\mathcal{X}_{-1}^{\wedge} := \{0\}$ and $\mathcal{X}_{-1}^{\vee} := \{0\}.$ Put

$$
\mathcal{X}^{\wedge} := \bigcup_{n \geq 0} \mathcal{X}_n^{\wedge} \text{ and } \mathcal{X}^{\vee} := \bigcup_{n \geq 0} \mathcal{X}_n^{\vee}.
$$

Let X be a subcategory of C. Recall from [\[18\]](#page-22-13) that X is called a *thick subcategory* of C if it is closed under extensions, cones of inflations, cocones of deflations and direct summands. Denote by add χ the smallest subcategory of C containing χ and closed under finite direct sums and direct summands.

Definition 4.2. [\[2,](#page-22-7) Definition 5.1] Let C be an extriangulated category. A subcategory M of C is called a silting subcategory if it satisfies the following conditions.

(a) M is a presilting subcategory, that is, $\mathbb{E}^k(\mathcal{M}, \mathcal{M}) = 0$ for all $k \geq 1$.

(b) $\mathcal C$ is the smallest thick subcategory containing $\mathcal M$.

We say that an object $M \in \mathcal{C}$ is *silting* if so is add M.

We give some examples of silting subcategories.

Example 4.3. This example comes from [\[1,](#page-22-14) Example 2.2].

(1) Let A be a ring. Then A regarded as a stalk complex is a tilting object in K^b (proj-A). More generally, any tilting complex of A is a tilting object in K^b (proj-A). By definition, any tilting object is silting object in triangulated categories.

(2) Let A be a differential graded ring and let $D(A)$ be the derived category of A. If $H^{i}(A) = 0$ for any $i > 0$, then the thick subcategory thick(A) of $D(A)$ generated by A has a silting object A.

Example 4.4. Let Λ be an artin algebra. We denote by $\mathcal{P}^{\infty}(\Lambda)$ the category of finitely generated right Λ-modules of finite projective dimension. Since $\mathcal{P}^{\infty}(\Lambda)$ is closed under extensions, it is an extriangulated category. By $[2, \text{Example } 5.2]$, we know that add A is a silting subcategory of $\mathcal{P}^{\infty}(\Lambda)$. Moreover, addA is functorially finite.

Example 4.5. (1) Let Λ be a finite dimensional k-algebra. If gl.dim $\Lambda < \infty$, then any tilting object in mod Λ is also a silting object.

 (2) Let Q be the following infinite quiver:

 \cdots $\stackrel{x-5}{\longrightarrow}$ -4 $\stackrel{x-4}{\longrightarrow}$ -3 $\stackrel{x-3}{\longrightarrow}$ -2 $\stackrel{x-2}{\longrightarrow}$ -1 $\stackrel{x-1}{\longrightarrow}$ 0 $\stackrel{x_0}{\longrightarrow}$ 1 $\stackrel{x_1}{\longrightarrow}$ 2 $\stackrel{x_2}{\longrightarrow}$ 3 $\stackrel{x_3}{\longrightarrow}$ 4 $\stackrel{x_4}{\longrightarrow}$ \cdots

Let $\Lambda = kQ/[x_ix_{i+1}x_{i+2}, x_{4k}x_{4k+1}](i \neq 4k)$. Then the Auslander-Reiten quiver of mod Λ is the following.

The indecomposable objects denoted by \star consist a silting subcategory in mod Λ .

Adachi and Tsukamoto [\[2\]](#page-22-7) establish a bijection between bounded hereditary cotorsion pairs and silting subcategories in extriangulated categories.

Lemma 4.6. [\[2,](#page-22-7) Theorem 5.7] Let C be an extriangulated category. Then there exists a bijection between the following sets:

(1) The set of bounded cotorsion pairs (X, Y) satisfying $\mathbb{E}^{i}(X, Y) = 0$ for each $i \geq 2$ and all $X \in \mathcal{X}$ and $Y \in \mathcal{Y}$.

(2) The set of silting subcategories of \mathcal{C} .

In particular, if M is a silting subcategory of C, then $(\mathcal{M}^{\vee}, \mathcal{M}^{\wedge})$ is a bounded hereditary cotorsion pair in C satisfying $\mathcal{M} = \mathcal{M}^{\vee} \cap \mathcal{M}^{\wedge}$.

A direct consequence of Theorem [1.1](#page-1-0) and Lemma [4.6](#page-21-2) yields the following corollary.

Corollary 4.7. Let \mathcal{C} be a weakly idempotent complete extriangulated category. Then any silting object M of C induces the model structure $(\text{CoFib}_\mathcal{M}, \text{Fib}_\mathcal{M}, \text{Weq}_\mathcal{M})$ on C, where $\mathcal{M} = \text{add}M$ is a silting subcategory of C.

We introduce the following notion of co-t-structures, which was independently introduced by Bondarko [\[5\]](#page-22-15) and Pauksztello [\[15\]](#page-22-16) as an analog of t-structures defined in [\[3\]](#page-22-17).

Definition 4.8. [\[5,](#page-22-15) [15\]](#page-22-16) Let C be a triangulated category with the shift functor [1]. A co-tstructure on $\mathcal T$ is a pair $(\mathcal A,\mathcal B)$ of subcategories of $\mathcal C$ such that

- (1) $\mathcal{A}[-1] \subseteq \mathcal{A}$ and $\mathcal{B}[1] \subseteq \mathcal{B}$.
- (2) Hom_C($\mathcal{A}[-1], \mathcal{B}$) = 0.
- (3) Any object $T \in \mathcal{T}$ has a distinguished triangle $X \longrightarrow T \longrightarrow Y \longrightarrow X[1]$ in C with $X \in \mathcal{A}[-1]$ and $Y \in \mathcal{B}$.

Note that hereditary cotorsion pairs on $\mathcal C$ are exactly co-t-structures. In combination this with Theorem [1.1,](#page-1-0) we have the following result.

Corollary 4.9. Let C be a triangulated category, and $\mathcal X$ and $\mathcal Y$ additive full subcategories of C which are closed under direct summands and isomorphisms, and $\omega = \mathcal{X} \cap \mathcal{Y}$. Then $(\mathrm{CoFib}_{\omega}, \mathrm{Fib}_{\omega}, \mathrm{Weq}_{\omega})$ is a model structure if and only if $(\mathcal{X}, \mathcal{Y})$ is a co-t-structure in \mathcal{C} , and ω is contravariantly finite in C. In this case, the class \mathcal{C}_{ω} of cofibrant objects is X, the class \mathcal{F}_{ω} of fibrant objects is C, the class W_{ω} of trivial objects is Y; and the homotopy category Ho(C) is \mathcal{X}/\mathcal{W} .
