# COMPUTATIONS REGARDING THE TORSION HOMOLOGY OF OELJEKLAUS-TOMA MANIFOLDS

#### Abstract

This article investigates the torsion homology behaviour in towers of Oeljeklaus-Toma (OT) manifolds. This adapts an idea of Silver-Williams from knot theory to OT manifolds and extends it to higher degree homology groups. In the case of surfaces, i.e. Inoue surfaces of type $S^{0}$, the torsion grows exponentially in both $H_{1}$ and $H_{2}$ according to a parameters which already plays a role in Inoue's classical paper. This motivates running example calculations in all homological degrees.


## 1. Introduction

In order to motivate the computations in this paper, let us for a moment look at an idea from knot theory. Suppose

K \hookrightarrow S^{3}
$$

is a tame knot. Then one can put a tubular neighbourhood $T$ around $K$ and the knot complement is the space

$$
X_{K}=S^{3}-(\text { interior of } T)
$$

This makes sense not just as a topological space, but indeed gives a compact connected 3-manifold. By a standard computation, one always has

$$
\begin{equation*}
H_{1}\left(X_{K}, \mathbb{Z}\right) \simeq \mathbb{Z} \tag{1}
\end{equation*}
$$

see for example [6, Remark 18.4], independently of the choice of the knot. By the Hurewicz theorem, this means that the quotient of the fundamental group to its abelianization, i.e. the first homology group of $X_{K}$, is given by

\begin{equation*}
q: \pi_{1}\left(X_{K}, *\right) \rightarrow \mathbb{Z} \tag{2}
\end{equation*}
$$

This map is almost canonical. Really, in both Equation 1 and 2 one just gets infinite cyclic groups canonically, so for identifying them with $\mathbb{Z}$ one needs to choose a generator of this infinite cyclic group, and changing this would change the maps by multiplication with -1 .

Consider the subgroups

q^{-1}(n \mathbb{Z}) \subseteq \pi_{1}\left(X_{K}, *\right)
$$

[^0]for integers $n \geq 1$, where $q$ is as in Equation 2. These subgroups are well-defined, since multiplication by -1 preserves them. By covering space theory, each such subgroup corresponds to a finite covering

of degree $n$. Now, one can study the torsion homology of the spaces $X_{K, n}$, depending on $n$. Gonzáles-Acuña-Short [5] and Riley [9] have independently proven in the early 1990 s that
\[

\lim _{n \longrightarrow+\infty} \frac{\log \left|H_{1}\left(X_{K, n}, \mathbb{Z}\right)_{t o r}\right|}{n}=\log M\left(\Delta_{K}\right), \tag{4}
\end{equation*}
$$

\]

where $\Delta_{K}$ denotes the Alexander polynomial of the knot, and $M(-)$ the Mahler measure. So, loosely speaking, this shows that the amount of torsion first homology classes of the spaces $X_{K, n}$ grows in a very controlled way along $n$. For example, in the case $\left|M\left(\Delta_{K}\right)\right|>1$ one obtains the asymptotic exponential growth

$$
\left|H_{1}\left(X_{K, n}, \mathbb{Z}\right)_{t o r}\right| \sim M\left(\Delta_{K}\right)^{n} \quad \text { as } \quad n \longrightarrow+\infty
$$

Note that this is just an asymptotic; for small $n$ this is a bad heuristic. The case $\left|M\left(\Delta_{K}\right)\right|>1$ is fairly common, so one sees that the spaces $X_{K, n}$ for large $n$ will have a tremendous amount of torsion classes in $H_{1}$. More qualitatively, one can also say that once the torsion homology is not bounded in $n$, it must already grow exponentially, and if Lehmer's conjecture is true, there is even a lower bound on the minimal possible exponential growth.

As a brief comment on the literature, we note that many articles instead discuss the first homology of the branched covering spaces $\widehat{X}_{K, n}$ instead (e.g., [5]), but one just has $H_{1}\left(X_{K, n}, \mathbb{Z}\right)_{t o r} \cong H_{1}\left(\widehat{X}_{K, n}, \mathbb{Z}\right)$, so these considerations are just a different viewpoint, but equivalent, see [3, Chapter 8].

In 2002 Daniel Silver and Susan Williams have pointed out in their article [10] that many of the above considerations do not need to be restricted to knot complements. Instead, they point out that whenever one has a connected manifold $X$ with a surjection

q: \pi_{1}(X, *) \rightarrow \mathbb{Z}
$$

imitating Equation 2 one can run the analogous analysis for any such $X$. One has the corresponding covering spaces, call them $X_{n}$, and can study the limit

$$
\lim _{n \longrightarrow+\infty} \frac{\log \left|H_{1}\left(X_{n}, \mathbb{Z}\right)_{t o r}\right|}{n} .
$$

This note is about a special type of complex manifolds where this idea can be implemented:

Concretely, the situation envisioned by Silver-Williams is met for Inoue surfaces [7]; and in this note we only look at Inoue surfaces of so-called type $S^{0}$ (these are the ones discussed in $\S 2$ loc. cit.). These are compact non-Kähler complex surfaces (so instead of dimension 3, we now move to compact 4-dimensional real manifolds with rich extra structure. While the knot complements are frequently hyperbolic, the Inoue surfaces carry at least a locally conformal Kähler metric. This plays no role here though).

Inoue surfaces $X$ are one of the types appearing in Kodaira's classification of minimal compact complex surfaces. They occur in the not fully understood Class
$\mathrm{VII}_{0}$. They satisfy $H_{1}(X, \mathbb{Q}) \simeq \mathbb{Q}$, vaguely analogous to Equation and one can set up a surjection

$$
q: \pi_{1}(X, *) \rightarrow \mathbb{Z}
$$

as in Equation 2 again canonical up to multiplication with -1 in $\mathbb{Z}$. As is pointed out in [2], one obtains

$$
\begin{equation*}
\lim _{n \rightarrow+\infty} \frac{\log \left|H_{1}\left(X_{n}, \mathbb{Z}\right)_{t o r}\right|}{n}=\log M(f) \tag{5}
\end{equation*}
$$

where $M(f)$ is the Mahler measure of a polynomial $f$ which in the setting of Inoue's paper is the minimal polynomial of the matrix he denotes by " $M$ " in $[7, \S 2]$, or, in the setting of [2] the minimal polynomial of a unit in a certain number field (this translation follows the philosophy of [8]).

This result is entirely in line with the philosophy laid out by Silver and Williams in [10]. This motivates the question to investigate the remaining torsion homology

$$
\left|H_{r}\left(X_{n}, \mathbb{Z}\right)_{t o r}\right|
$$

for $r \neq 1$.
Theorem 1. For Inoue surfaces of type $S^{0}$ (resp. Oeljeklaus-Toma manifolds with $r_{1}, r_{2}=1$ ), the torsion homology growth satisfies

$$
\log \left|H_{r}\left(X_{n}, \mathbb{Z}\right)_{t o r}\right| \sim \begin{cases}n \log M(f) & \text { for } r=1,2 \\ 0 & \text { for } r=0,3,4\end{cases}
$$

as $n \longrightarrow+\infty$, where $M(f)$ is the Mahler measure of the minimal polynomial as described above in the text. This is $>1$, so the orders of the torsion part of both $H_{1}$ and $H_{2}$ grow exponentially with $n$.

We refer to $\$ 2$ for the proof. However, Inoue surfaces of type $S^{0}$ admit a generalization to higher dimensions due to Oeljeklaus and Toma [8]. Given a number field $K$ with $r_{1} \geq 1$ real places and $r_{2}=1$ complex places, and any torsion-free finite-index subgroup

$$
U \subseteq \mathcal{O}_{K}^{\times,+}
$$

of the totally positive units (i.e. the units which are positive under any homomorphism $\mathcal{O}_{K}^{\times} \rightarrow \mathbb{R}$ ), they attach a complex manifold

$$
X(K, U)
$$

which is

- connected compact of complex dimension $r_{1}+1$,
- real dimension $2 r_{1}+2$,
- non-Kähler (but carries a locally conformal Kähler metric),
- and whose underlying real manifold is a locally symmetric space for a solvable Lie group.
For any such manifold $X(K, U)$ the fundamental group sits in a canonical exact sequence

$$
1 \longrightarrow G \longrightarrow \pi_{1}(X(K, U), *) \xrightarrow{q} U \longrightarrow 1
$$

see [1,Prop. 6]. In the special case of $r_{1}=1$, Dirichlet's Unit Theorem implies that $\mathcal{O}_{K}^{\times,+} \simeq \mathbb{Z}$, canonical up to multiplication with -1 , and $X(K, U)$ is merely an Inoue surface. So, this is just the case as discussed above. However, for $r_{1}=2$, we have

$$
\mathcal{O}_{K}^{\times,+} \simeq \mathbb{Z}^{2}
$$

canonical up to the action of $\mathrm{GL}_{2}(\mathbb{Z})$.
A good source of examples stems from fourth roots. Consider the number field

$$
K=\mathbb{Q}(\sqrt[4]{p})
$$

for a prime $p$. The polynomial $X^{4}-p$ is irreducible by the Eisenstein criterion, it has two real roots $\pm \sqrt[4]{p}$ and a pair of complex conjugate roots $\pm i \sqrt[4]{p}$, so that $K$ indeed satisfies $r_{1}=2$ and $r_{2}=1$. Hence, this is a great source for OT threefolds.

Let $\sigma_{1}$ and $\sigma_{2}$ be the real embeddings and $\sigma_{3}$ be a complex embedding of $K$ respectively.

The ring of integers can be determined by a general result of Gassert [4, Theorem 1.1]. As soon as $p$ satisfies

$$
p^{2} \neq p \bmod 4
$$

the ring of integers is

$$
\mathcal{O}_{K}=\mathbb{Z}[\sqrt[4]{p}]
$$

(the theorem is stated in Gassert's paper only as claiming that the ring of integers is monogenic, but the proof explicitly shows that the index $\left[\mathcal{O}_{K}: \mathbb{Z}[\sqrt[4]{p}]\right]$, using our notation, is one, so this shows that $\sqrt[4]{p}$ is a concrete generator). The totally multiplicative units of $O_{K}$ is

$$
\mathcal{O}_{K}^{\times} \simeq \mathbb{Z}\langle u, v\rangle
$$

for generating units $u, v$.
Let

$$
\begin{aligned}
& i=\min \left\{k \in \mathbb{N}^{*}: \sigma_{1}\left(u^{k}\right)>0, \quad \sigma_{2}\left(u^{k}\right)>0\right\}, \\
& j=\min \left\{k \in \mathbb{N}^{*}: \sigma_{1}\left(v^{k}\right)>0, \quad \sigma_{2}\left(v^{k}\right)>0\right\}
\end{aligned}
$$

then $O_{K}^{\times,+}=\mathbb{Z}<u^{i}, v^{j}>$.
For each $m, n \geq 1$, define the monomorphism $\varphi:<u^{i m}, v^{j n}>\rightarrow \operatorname{Aut}\left(O_{K}\right)$, $x \mapsto \varphi(x)$ such that $\varphi(x)(y)=x y$, for all $y \in O_{K}$. With this monomorphism, the semidirect product $O_{K} \rtimes_{\varphi} \mathbb{Z}<u^{i m}, v^{j n}>$ is defined with the product

$$
\left(h_{1}, u^{i m_{1}} v^{j n_{1}}\right) \cdot\left(h_{2}, u^{i m_{2}} v^{j n_{2}}\right)=\left(h_{1}+u^{i m_{1}} v^{j n_{1}} h_{2}, u^{i\left(m_{1}+m_{2}\right)} v^{j\left(n_{1}+n_{2}\right)}\right)
$$ for all $h_{1}, h_{2} \in O_{K}, u^{i m_{1}} v^{j n_{1}}, u^{i m_{2}} v^{j n_{2}} \in \mathbb{Z}<u^{i m}, v^{j n}>$.

The action

$$
\begin{array}{r}
*:\left(O_{K} \rtimes_{\varphi} \mathbb{Z}<u^{i m}, v^{j n}>\right) \times\left(\mathbb{H}^{2} \times \mathbb{C}\right) \rightarrow\left(\mathbb{H}^{2} \times \mathbb{C}\right) \\
\left((h, k),\left(z_{1}, z_{2}, z_{3}\right)\right) \mapsto\left(\sigma_{1}(h)+\sigma_{1}(k) z_{1}, \sigma_{2}(h)+\sigma_{2}(k) z_{2}, \sigma_{3}(h)+\sigma_{3}(k) z_{3}\right)
\end{array}
$$

is a properly discontinuous action of $O_{K} \rtimes_{\varphi}<u^{i m}, v^{j n}>$ on $\mathbb{H}^{2} \times \mathbb{C}$. Then

$$
X_{m, n}=X\left(K, \mathbb{Z}<u^{i m}, v^{j n}>\right):=\left(\mathbb{H}^{2} \times \mathbb{C}\right) /\left(O_{K} \rtimes_{\varphi} \mathbb{Z}<u^{i m}, v^{j n}>\right)
$$

is itself an Oeljeklaus-Toma threefold (or "OT threefold").
In §3, we describe an algorithm to find the homology of an OT manifold $X_{m, n}$.
Next, a detailed algorithm for the case $p=2$ will be described in $\$ 4$ and a GAP program which implements this algorithm will be distributed online [11].

Proposition 2. Our algorithm produces the following results for the $r$-th degree homology of $X_{m, n}$ when $p=2$ :

Finally, in Section 5. we determine explicitly the first homology of some classes of the manifolds $X_{m, n}$ in the case $K=\mathbb{Q}(\sqrt[4]{2})$ and obtain the following tow propositions.

Proposition 3. For Oeljeklaus-Toma manifolds with $r_{1}=2, r_{2}=1$ when $p=2$, the first homology is of isomorphism type

$$
H_{1}\left(X_{m, 1}\right) \cong\left\{\begin{array}{lll}
\mathbb{Z} / 2 \mathbb{Z} \oplus \mathbb{Z} / 2 \mathbb{Z} \oplus \mathbb{Z} \oplus \mathbb{Z} & \text { for } & m \nmid 6 \\
\mathbb{Z} / 2 \mathbb{Z} \oplus \mathbb{Z} / 14 \mathbb{Z} \oplus \mathbb{Z} \oplus \mathbb{Z} & \text { for } & m \mid 6
\end{array}\right.
$$

Proposition 4. For Oeljeklaus-Toma manifolds with $r_{1}=2, r_{2}=1$ when $p=2$, the first homology is of isomorphism type $H_{1}\left(X_{m, n}\right) \cong \mathbb{Z} / 2 \mathbb{Z} \oplus \mathbb{Z} / 2 \mathbb{Z} \oplus \mathbb{Z} \oplus \mathbb{Z}$ for all $n \in \mathbb{N}^{*}$ when $m$ is odd.

For the proof of Propositions 3 and 4, see Section 5
Proposition 5. Our computational results on the isomorphism type of the first homology of some $X_{m, n}$ are the following:

## 2. Proof of Theorem 1

Let $X_{n}=X\left(K, \mathbb{Z}<v^{n}>\right)$. As OT manifold $X_{n}$ of dimension 4 is oriented closed, according to Poincaré duality,

With $k=3, H^{3}(X) \cong H_{1}(X)$, so the torsion of $H^{3}(X)$ is isomorphic to the torsion of $H_{1}(X)$. On the other hand, by the Universal Coefficient Theorem,

Usage of Equation (5), stated above, completes the proof of the theorem.

## 3. An algorithm computing the homology of $X_{m, n}$

3.1. A resolution of $\mathbb{Z}$ over $\mathbb{Z}^{2}$. Consider the topological space $\mathbb{R}^{2}$ and the multiplicative group

Let $C_{k}\left(\mathbb{R}^{2} / G\right)$ be the free abelian group generated by all k-cells in $\mathbb{R}^{2} / G$, then the cellular chain complex

3.3. The isomorphism from $O_{K} \rtimes_{\varphi} \mathbb{Z}<u^{i m}, v^{j n}>$ to $\mathbb{Z}^{4} \rtimes_{\bar{\varphi}} \mathbb{Z}^{2}$. The multiplicative group $\mathbb{Z}<u^{i m}, v^{j n}>$ is isomorphic to the additive group $\mathbb{Z}^{2}$ by the isomorphism $\alpha:\left(u^{i m}\right)^{p}\left(v^{j n}\right)^{q} \mapsto(p, q)$. The additive group of the ring of integers

of $K$ is isomorphic to $\mathbb{Z}^{4}$ by the isomorphism $\psi: a+b w+c w^{2}+d w^{3} \mapsto(a, b, c, d)$. Using $\alpha$ and $\psi$, we define $\bar{\varphi}: \mathbb{Z}^{2} \rightarrow \operatorname{Aut}\left(\mathbb{Z}^{4}\right),(s, t) \mapsto \bar{\varphi}(s, t)$, where

This homomorphism helps us to form the semidirect product $\mathbb{Z}^{4} \rtimes_{\bar{\varphi}} \mathbb{Z}^{2}$ which is isomorphic to $O_{K} \rtimes_{\varphi} \mathbb{Z}<u^{i m}, v^{j n}>$.
Since two groups which are isomorphic have the same homology groups, to find the homology groups of $O_{K} \rtimes_{\varphi} \mathbb{Z}<u^{i m}, v^{j n}>$, we just need to find the homology groups of $\mathbb{Z}^{4} \rtimes \bar{\varphi} \mathbb{Z}^{2}$. The following is the algorithm to find the homologies of $\mathbb{Z}^{4} \rtimes \bar{\varphi} \mathbb{Z}^{2}$.

### 3.4. An algorithm for computing the homology of $\mathbb{Z}^{4} \rtimes_{\bar{\varphi}} \mathbb{Z}^{2}$.

Step 1. Construct $\bar{\varphi}: \mathbb{Z}^{2} \rightarrow \operatorname{Aut}\left(\mathbb{Z}^{4}\right),(s, t) \mapsto \bar{\varphi}(s, t)$, with $\bar{\varphi}(s, t):(a, b, c, d) \mapsto$ $\left(A_{s, t}, B_{s, t}, C_{s, t}, D_{s, t}\right)$, where $A_{s, t}, B_{s, t}, C_{s, t}, D_{s, t}$ are defined by the following formula:

Then construct the semidirect product $E=\mathbb{Z}^{4} \rtimes_{\bar{\varphi}} \mathbb{Z}^{2}$ with this $\bar{\varphi}$.
Step 2. The projection $p: E \rightarrow \mathbb{Z}^{2},(a, b, c, d, e, f) \mapsto(e, f)$, for all $(a, b, c, d, e, f) \in E$ has $\operatorname{ker}(p)=\mathbb{Z}^{4}$. So $E$ is a group extension of its normal subgroup $\mathbb{Z}^{4}$ and the quotient group $\mathbb{Z}^{2}$. Let $R$ and $S$ be the free resolution of $\mathbb{Z}$ over $\mathbb{Z}^{4}$ and $\mathbb{Z}^{2}$ respectively. The twisted tensor product of these resolutions, which we obtain using C.T.C Wall's method, gives us a free resolution for the semidirect product $E$.
Step 3. Compute the desired homology groups using the above resolution.

## 4. An EXPLICIT EXAMPLE WHEN $p=2$

In this case, the field $K$ is $\mathbb{Q}(\sqrt[4]{2})$. Two generators of the free part of $O_{K}^{\times}$are $u=w^{2}-1, v=w+1$, with $w=\sqrt[4]{2}$, and $O_{K}^{\times}=\mathbb{Z}<u, v>$. Since $\sigma_{1}(u)>0, \sigma_{2}(u)>0, \sigma_{1}(v)>0, \sigma_{2}(v)<0, O_{K}^{\times,+}=\mathbb{Z}<u, v^{2}>$.

We observe that

So, $O_{K} \rtimes_{\varphi} \mathbb{Z}<u^{m}, v^{2 n}>$ is isomorphic to $\mathbb{Z}^{4} \rtimes_{\bar{\varphi}} \mathbb{Z}^{2}$ by the isomorphism $\bar{\varphi}(s, t)(y)=$ $\psi\left(\varphi\left(\alpha^{-1}(s, t)\right)\right) \psi^{-1}(y)=\left(A_{s, t}, B_{s, t}, C_{s, t}, D_{s, t}\right)$ with

## 5. Proof of Propositions 3 and 4

Let us now provide the proofs of Propositions 3 and 4 stated in the Introduction.
Proposition 3. For Oeljeklaus-Toma manifolds with $r_{1}=2, r_{2}=1$ when $p=2$, the first homology is of isomorphism type

We can see $H_{1}(E) \cong E /[E, E]$.
To find $[E, E]$, we consider the system of equations

{\overline{f_{1}}}^{a_{i j}-e_{1 j}}{\overline{f_{2}}}^{b_{i j}-e_{2 j}}{\overline{f_{3}}}^{c_{i j}-e_{3 j}}{\overline{f_{4}}}^{d_{i j}-e_{4 j}}=\overline{1}, \quad i=\overline{1,2}, \quad j=\overline{1,4}
$$

where $e_{k j}=\left\{\begin{array}{lll}1 & \text { if } & k=j \\ 0 & \text { if } & k \neq j\end{array}\right.$
Picking up the power of $\left\{\overline{f_{i}}\right\}$ in each equation, we obtain a matrix of order $8 \times 4$.

In the case $m$ is arbitrary and $n=1$, the matrix has the form

$$
\left(\begin{array}{cccc}
a_{m}-1 & 0 & b_{m} & 0 \\
0 & a_{m}-1 & 0 & b_{m} \\
2 b_{m} & 0 & a_{m}-1 & 0 \\
0 & 2 b_{m} & 0 & a_{m}-1 \\
0 & 2 & 1 & 0 \\
0 & 0 & 2 & 1 \\
2 & 0 & 0 & 2 \\
4 & 2 & 0 & 0
\end{array}\right)
$$

where

$$
\begin{aligned}
a_{m} & =\frac{1}{2}(-1+\sqrt{2})^{m}+\frac{1}{2}(-1-\sqrt{2})^{m} \\
b_{m}=\frac{1}{4}(-1+\sqrt{2})^{m+1}+\frac{1}{4}(-1-\sqrt{2})^{m+1} & +\frac{1}{4}(-1+\sqrt{2})^{m}+\frac{1}{4}(-1-\sqrt{2})^{m}
\end{aligned}
$$

Applying the row transformations, we change this matrix into the matrix (*) as below

$$
\left(\begin{array}{cccc}
2 & 0 & 0 & 2  \tag{*}\\
0 & 2 & 1 & 0 \\
0 & 0 & 1 & 4 \\
0 & 0 & 0 & 7 \\
0 & 0 & 0 & a_{m}+4 b_{m}-1 \\
0 & 0 & 0 & 2\left(a_{m}-1\right)+b_{m}
\end{array}\right)
$$

Now, when $m=6 k, k \in \mathbb{N}^{*}, \operatorname{gcd}\left(7, a_{m}+4 b m-1,2\left(a_{m}-1\right)+b_{m}\right)=7$, then the matrix $\left(^{*}\right)$ is row equivalent to the matrix

$$
\left(\begin{array}{llll}
2 & 0 & 0 & 2 \\
0 & 2 & 1 & 0 \\
0 & 0 & 1 & 4 \\
0 & 0 & 0 & 7 \\
0 & 0 & 0 & 0 \\
0 & 0 & 0 & 0
\end{array}\right)
$$

In this case, $H_{1}\left(X_{m, 1}\right)=\mathbb{Z} / 2 \mathbb{Z} \oplus \mathbb{Z} / 2 \mathbb{Z} \oplus \mathbb{Z} / 7 \mathbb{Z} \oplus \mathbb{Z} \oplus \mathbb{Z}$.
On the other hand, when $m \neq 6 k, k \in \mathbb{N}^{*}$,

$$
\operatorname{gcd}\left(7, a_{m}+4 b m-1,2\left(a_{m}-1\right)+b_{m}\right)=1
$$

then the matrix $\left(^{*}\right)$ is row equivalent to the matrix

$$
\left(\begin{array}{llll}
2 & 0 & 0 & 2 \\
0 & 2 & 1 & 0 \\
0 & 0 & 1 & 4 \\
0 & 0 & 0 & 1 \\
0 & 0 & 0 & 0 \\
0 & 0 & 0 & 0
\end{array}\right)
$$

In this case, $H_{1}\left(X_{m, 1}\right)=\mathbb{Z} / 2 \mathbb{Z} \oplus \mathbb{Z} / 2 \mathbb{Z} \oplus \mathbb{Z} \oplus \mathbb{Z}$.
Proposition 4. For Oeljeklaus-Toma manifolds with $r_{1}=2, r_{2}=1$ when $p=2$, the first homology is of isomorphism type $H_{1}\left(X_{m, n}\right) \cong \mathbb{Z} / 2 \mathbb{Z} \oplus \mathbb{Z} / 2 \mathbb{Z} \oplus \mathbb{Z} \oplus \mathbb{Z}$ for all $n \in \mathbb{N}^{*}$ when $m$ is odd.

Proof. Apply an analogous procedure as in the proof of Proposition 2 for the case $m$ is odd and $n$ is arbitrarily, we obtain the matrix of powers of $\left\{\overline{f_{i}}\right\}$ of the form

$$
\left(\begin{array}{cccc}
a_{m}-1 & 0 & b_{m} & 0 \\
0 & a_{m}-1 & 0 & b_{m} \\
2 b_{m} & 0 & a_{m}-1 & 0 \\
0 & 2 b_{m} & 0 & a_{m}-1 \\
2 a_{n} & 2 b_{n} & c_{n} & d_{n} \\
2 d_{n} & 2 a_{n} & 2 b_{n} & c_{n} \\
2 c_{n} & 2 d_{n} & 2 a_{n} & 2 b_{n} \\
4 b_{n} & 2 c_{n} & 2 d_{n} & 2 a_{n}
\end{array}\right)
$$

By applying some row operations $\alpha r_{i}+r_{j} \rightarrow r_{j}$, this matrix turns into the matrix

$$
\left(\begin{array}{cccc}
2 & 0 & 0 & 0 \\
0 & 2 & 0 & 0 \\
0 & 0 & -a_{m} & 0 \\
0 & 0 & 0 & -a_{m} \\
0 & 0 & -a_{n} c_{m}+c_{n} & -b_{n} c_{m}+d_{n} \\
0 & 0 & -d_{n} c_{m}+2 b_{n} & -a_{n} c_{m}+c_{n} \\
0 & 0 & -c_{n} c_{m}+2 a_{n} & -d_{n} c_{m}+2 b_{n} \\
0 & 0 & -2 b_{n} c_{m}+2 d_{n} & -c_{n} c_{m}+2 a_{n}
\end{array}\right)
$$

Let

$$
\begin{aligned}
& \alpha=\operatorname{gcd}\left(-a_{m},-a_{n} c_{m}+c_{n},-d_{n} c_{m}+2 b_{n},-c_{n} c_{m}+2 a_{n},-2 b_{n} c_{m}+2 d_{n}\right), \\
& \beta=\operatorname{gcd}\left(-a m,-b_{n} c_{m}+d_{n},-a_{n} c_{m}+c_{n},-d_{n} c_{m}+2 b_{n},-c_{n} c_{m}+2 a_{n}\right)
\end{aligned}
$$

then the homology is of isomorphism type

$$
H_{1}\left(X_{m, n}\right) \cong \mathbb{Z} / 2 \mathbb{Z} \oplus \mathbb{Z} / 2 \mathbb{Z} \oplus \mathbb{Z} / \alpha \mathbb{Z} \oplus \mathbb{Z} / \beta \mathbb{Z} \oplus \mathbb{Z} \oplus \mathbb{Z}
$$
