# Laplacian coflows of $\mathrm{G}_{2}$-structures on contact Calabi-Yau 7-manifolds

#### Abstract

We explore three versions of the Laplacian coflow of $\mathrm{G}_{2}$-structures on circle fibrations over Calabi-Yau 3 -folds, interpreting their dimensional reductions to the Kähler geometry of the base. Precisely, we reduce Ansätze for the Laplacian coflow, modified or not by de Turck's trick, both on trivial products $C Y^{3} \times S^{1}$ and on contact Calabi-Yau 7-manifolds, obtaining in each case a natural modification of the Kähler-Ricci flow.

## 1 Introduction

### 1.1 Context

We propose an investigation of co-evolving geometric flows, respectively in complex 3-dimensional Kähler geometry and real 7 -dimensional $\mathrm{G}_{2}$-geometry, mediated by dimensional reduction. Similar approaches in various special geometric contexts can be found in a substantial number of recent works, eg. [FY18, HWY18, FR20, LL21, KL23, AMP24], with specific interests spanning over diverse areas of differential geometry, such as minimal submanifold theory, Yang-Mills theory, and generalized geometry. This article extends in a natural way two previous works by the authors and their collaborators, namely [PS22] and [LSES22], exploring geometric flows of $\mathrm{G}_{2}$-structures on circle fibrations over Calabi-Yau 3-folds and their repercussions on the Kähler geometry of the base. Concretely, we examine particular Ansätze for the Laplacian coflow, modified by a de Turck trick, on Riemannian products $C Y^{3} \times S^{1}$, and for Laplacian coflows, modified or not, on contact Calabi-Yau 7-manifolds. We then interpret their counterparts 'downstairs' as modified Kähler-Ricci flows.

On an oriented and spin 7 -manifold $M$, geometric flows provide a method to deform a $\mathrm{G}_{2}$-structure, given by a non-degenerate form $\varphi \in \Omega^{3}(M)$, towards 'better' structures with special torsion and ultimately metrics with $\mathrm{G}_{2}$ holonomy, which are then Ricci-flat. A $\mathrm{G}_{2}$-structure $\varphi$ determines a metric $g_{\varphi}$ and orientation with Riemannian volume form $\operatorname{vol}_{\varphi}$, and its torsion $T$ is a 2 -tensor which is equivalent to $\nabla^{g_{\varphi}} \varphi$, see $\S 1.3$ below. Pairs $\left(M^{7}, \varphi\right)$ such that $T \equiv 0$ are called $\mathrm{G}_{2}$-manifolds and are of particular interest, since the holonomy group of $g_{\varphi}$ is then contained in $\mathrm{G}_{2}$. However, complete examples of $\mathrm{G}_{2}$-manifolds are very difficult to construct, especially when $M$ is compact. Fernandez and Gray [FG82] showed that the torsion-free condition is equivalent to $\varphi$ being both closed and coclosed, i.e, $\mathrm{d} \varphi=0$ and $\mathrm{d} *_{\varphi} \varphi=0$, where $*_{\varphi}$ is the Hodge star. This alternative viewpoint on the torsion-free condition as a system of nonlinear PDE is fundamental to several trending methods in $\mathrm{G}_{2}$-geometry.

Our prototypical goal is to study the Laplacian coflow of $\mathrm{G}_{2}$-structures, introduced in [KMT12]:

where $*_{t}$ is the Hodge star of $g_{t}:=g_{\varphi_{t}}$, the 4 -form $\psi_{t}:=*_{t} \varphi_{t}$ is the dual of the $\mathrm{G}_{2}$-structure, and $\Delta_{t}$ is the Hodge Laplacian; and the modified Laplacian coflow introduced by Grigorian in [Gri13]:

\frac{\partial}{\partial t} \psi_{t}=\Delta_{t} \psi_{t}+\mathrm{d}\left(\left(A-\frac{7}{2}\left(\tau_{0}\right)_{t}\right) \varphi_{t}\right), \quad \text { for } \quad A \in \mathbb{R} \tag{2}
\end{equation*}
$$

If $M$ is compact, stationary points of (1) would be (dual to) torsion-free $\mathrm{G}_{2}$-structures. Moreover, when an initial condition $\psi_{0}$ is closed, ie. the $\mathrm{G}_{2}$-structure $\varphi_{0}$ is coclosed, solutions of (1) preserve the cohomology class $\left[\psi_{t}\right]=\left[\psi_{0}\right] \in H^{4}(M)$, for as long as they exist. Indeed (1) can be interpreted as the gradient flow of Hitchin's volume functional [Hit01] and so the volume of $M$ increases monotonically along the flow, see eg. [Gri13], however it is not even weakly parabolic; coflows of $\mathrm{G}_{2}$-structures have been studied eg. by [KMT12, Gri13, BF18, BFF20, Gri20, KL23]. On the other hand, the modified Laplacian coflow (2) also preserves the coclosed condition and stays within the initial cohomology class, and it does have short-time existence and uniqueness, but the extra term added as a 'de Turck trick' introduces stationary points which are not torsion-free.

In [PS22], a thorough analysis is presented on the dynamics of $\mathrm{G}_{2}$-flows, in particular relating the Laplacian coflow of $\mathrm{G}_{2}$-structures on a trivial product $N^{3} \times S^{1}$ of a Calabi-Yau 3 -fold $N$, to Kähler-Ricci flow on the base. On yet another hand, [LSES22] explores a convenient Ansatz for the Laplacian coflow of $\mathrm{G}_{2}$-structures on contact Calabi-Yau (cCY) 7-manifolds, which are nontrivial such products. That investigation unravels the behavior of $\mathrm{G}_{2}$-structures under these flows, revealing findings on existence, uniqueness, and the development of singularities. It is therefore natural to consider what flows would emerge on the base 3 -folds under the classical modification by a de Turck trick. Thus with this paper we exhaust in total the four cases of Laplacian coflows to consider: whether the circle fibration over the Calabi-Yau 3 -fold is trivial or not, and whether the coflow is modified by de Turck or not.

Adopting a concise review of pertinent literature, we presume the reader's familiarity with $\mathrm{G}_{2}$ - and KählerRicci flows, aiming to present a short paper where we compute the behavior of $\mathrm{G}_{2}$-structures under similar Ansätze for the Laplacian coflow, as well as their induced modified versions of the Kähler-Ricci flow on the Calabi-Yau 3 -fold. While we will introduce the immediately necessary concepts and notation, we refer the reader to those two articles and references therein for further background and context.

### 1.2 Overview and main results

- In §2 we follow [PS22] and look at solutions to the modified coflow on the product $M^{7}=N \times S^{1}$, where $N$ is a Calabi-Yau 3 -fold. Specifically, in Theorem 2.3, we consider a family of $\mathrm{SU}(3)$-structures $\left(\omega_{t}, \Upsilon_{t}\right) \in\left(\Omega^{1,1} \times \Omega^{3,0}\right)(N)$ satisfying the system of differential equations

$$
\begin{align*}
& \frac{\partial}{\partial t} \omega_{t}=-\mathcal{L}_{\nabla_{t}\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right)} \omega_{t}+\beta_{t}, \\
& \frac{\partial}{\partial t} \Upsilon_{t}=\mathcal{L}_{\nabla_{t}\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right)} \Upsilon_{t}+\gamma_{t} . \tag{3}
\end{align*}
$$

Pulling back the $\mathrm{SU}(3)$-structure to $M$, the family of $\mathrm{G}_{2}$-structures given by

$$
\varphi_{t}=\operatorname{Re}\left(\frac{1}{|\Upsilon|_{\omega_{t}}} \Upsilon\right)+|\Upsilon|_{\omega_{t}} \mathrm{~d} r \wedge \omega_{t}
$$

is a solution of the modified Laplacian coflow with constant $A$ if, and only if,

$$
\begin{aligned}
& \beta_{t} \wedge \omega_{t}=-A \frac{1}{|\Upsilon|_{\omega}} \mathrm{d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right) \wedge \operatorname{Re}\left(\Upsilon_{t}\right), \\
& \operatorname{Im}\left(\gamma_{t}\right)=A\left|\Upsilon_{t}\right|_{\omega_{t}} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right) \wedge \omega_{t} .
\end{aligned}
$$

If moreover the complex structure on $N$ is fixed along the flow, then $\beta_{t}^{(1,1)}=0$ and $\operatorname{Im}\left(\gamma_{t}\right)^{(0,3) \oplus(3,0)}=0$.

- In $\S 3$, we consider families of coclosed $\mathrm{G}_{2}$-structures on contact Calabi-Yau (cCY) 7-manifolds and explore solutions to both the standard and the modified Laplacian coflows. Sasakian deformations that fix the Reeb vector field $\xi$ are characterized by a basic function, in the sense that the contact 1 -form and the transverse Kähler form are given respectively by

$$
\eta_{t}=\eta+\mathrm{d}^{c} f_{t} \quad \text { and } \quad \omega_{t}=\omega+\operatorname{dd}^{c} f_{t}
$$

Obtaining from this Ansatz the natural family of $\mathrm{G}_{2}$-structures given by $\varphi_{t}=\operatorname{Re}\left(\frac{1}{|\Upsilon| \omega_{t}} \Upsilon\right)+|\Upsilon|_{\omega_{t}} \eta \wedge \omega_{t}$, we conclude in Theorem 3.6 that they are solutions of the Laplacian flow if, and only if,

$$
\begin{aligned}
\beta_{t} \wedge \omega_{t} & =2\left|\Upsilon_{t}\right|_{\omega_{t}}^{2} \omega_{t}^{2}-\left(\mathcal{L}_{\nabla\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right)} \mathrm{d}^{c} f_{t}\right) \wedge \operatorname{Im} \Upsilon_{t} \\
& \left.-\left(\nabla\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right)\right\lrcorner \omega\right) \wedge \operatorname{Im} \Upsilon_{t}+\left(\frac{\partial}{\partial t} \mathrm{~d}^{c} f_{t}\right) \wedge \operatorname{Im} \Upsilon_{t}, \\
\operatorname{Im}\left(\gamma_{t}\right) & =4|\Upsilon|_{\omega_{t}}^{2} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right) \wedge \omega_{t} .
\end{aligned}
$$

Moreover, in Theorem 3.7, $\left\{\varphi_{t}\right\}$ will be a solution of the modified Laplacian coflow if, and only if,

$$
\begin{aligned}
\beta_{t} \wedge \omega_{t}= & -\left|\Upsilon_{t}\right|_{\omega_{t}}^{2} \omega_{t}^{2}+A\left|\Upsilon_{t}\right| \omega_{t} \omega_{t}^{2}-\frac{A}{\left|\Upsilon_{t}\right| \omega_{t}} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right) \wedge \operatorname{Re} \Upsilon_{t} \\
& \left.-\left(\mathcal{L}_{\nabla_{t}\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right)} \mathrm{d}^{c} f_{t}\right) \wedge \operatorname{Im} \Upsilon_{t}-\left(\nabla_{t}\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right)\right\lrcorner \omega\right) \wedge \operatorname{Im} \Upsilon_{t}+\left(\frac{\partial}{\partial t} \mathrm{~d}^{c} f_{t}\right) \wedge \operatorname{Im} \Upsilon_{t}, \\
\operatorname{Im}\left(\gamma_{t}\right)=- & -2\left|\Upsilon_{t}\right|_{\omega_{t}}^{2} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right) \wedge \omega_{t}+A\left|\Upsilon_{t}\right| \omega_{t} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right) \wedge \omega_{t} .
\end{aligned}
$$

- In $\S 4$, we explore solutions to the modified coflow on a contact Calabi-Yau 7-manifold ( $M^{7}, \eta, \Phi, \Upsilon$ ), based on the Ansatz studied in [LSES22]:

$$
\varphi_{t}=b_{t}^{3} \operatorname{Re} \Upsilon+a_{t} b_{t}^{2} \eta \wedge \omega, \quad \varphi_{0}=\operatorname{Re} \Upsilon+\varepsilon \eta \wedge \omega
$$

In particular, Theorem 4.2, Corollary 4.3, and $\S 4.2$ exhibit the dynamics of such solutions, including singularity formation, for various regimes of the constant $A$ and Sasakian fiber radius $\varepsilon$, cf. Table 1 .
In the $A=0$ case, we obtain an explicit expression for the solution of the modified coflow

$$
\varphi_{t}=\left(1-5 \varepsilon^{2} t\right)^{\frac{3}{10}} \operatorname{Re} \Upsilon+\varepsilon\left(1-5 \varepsilon^{2} t\right)^{-\frac{1}{10}} \eta \wedge \omega .
$$

Using this, we also analyze the asymptotic behaviour of the Ansatz solution in the $A=0$ case near its finite-time singularity.

- In $\S 5$ we explore solutions on a $c C Y^{7}$ manifold $\left(M^{7}, \eta, \Phi, \Upsilon\right)$ that vary from the initial Sasakian structure by a transverse $\operatorname{SU}(3)$-structure $\left(\omega_{t}^{\prime}, \Upsilon_{t}\right)$ and contact 1-form $\eta_{t}$, where $\omega_{t}^{\prime} \in\left[\mathrm{d} \eta_{t}\right]_{B}$ :

$$
\begin{aligned}
& \frac{\partial}{\partial t} \eta_{t}=\mathcal{L}_{\nabla_{t}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}}\right.} \eta_{t}+\alpha_{t}, \\
& \frac{\partial}{\partial t} \omega_{t}^{\prime}=-\mathcal{L}_{\nabla_{t}\left(\log \mid \Upsilon_{t \mid \omega_{t}^{\prime}}\right)} \omega_{t}^{\prime}+\beta_{t}, \\
& \frac{\partial}{\partial t} \Upsilon_{t}=\mathcal{L}_{\nabla_{t}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}}^{\prime}\right)} \Upsilon_{t}+\gamma_{t} .
\end{aligned}
$$

Defining a $\mathrm{G}_{2}$-structure in a similar way as before, Theorem 5.3 gives a solution to the Laplacian coflow if, and only if, those degrees of freedom satisfy

$$
\begin{aligned}
\alpha_{t} & =0 \\
-\eta_{t} \wedge \gamma_{t}-\omega_{t}^{\prime} \wedge \beta_{t} & =2|\Upsilon|_{\omega^{\prime}} \mathrm{d}\left(\log |\Upsilon|_{\omega^{\prime}}\right) \wedge \eta_{t} \wedge\left[3 \omega_{t}^{\prime}-\mathrm{d} \eta_{t}\right]+|\Upsilon|_{\omega^{\prime}}^{2} \mathrm{~d} \eta \wedge\left[3 \omega_{t}^{\prime}-\mathrm{d} \eta_{t}\right] .
\end{aligned}
$$

In the case of the modified Laplacian coflow, Theorem 5.4 identifies the constraints

$$
\begin{aligned}
\alpha_{t} & =\frac{A}{\left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}}} \mathrm{d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}}\right), \\
-\eta_{t} \wedge \gamma_{t}-\omega_{t}^{\prime} \wedge \beta_{t} & =2|\Upsilon|_{\omega^{\prime}} \mathrm{d}\left(\log |\Upsilon|_{\omega^{\prime}}\right) \wedge \eta_{t} \wedge\left[3 \omega_{t}^{\prime}-\mathrm{d} \eta_{t}\right]+|\Upsilon|_{\omega^{\prime}}^{2} \mathrm{~d} \eta \wedge\left[3 \omega_{t}^{\prime}-\mathrm{d} \eta_{t}\right] \\
& +A\left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}} \mathrm{d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}}^{\prime}\right) \wedge \eta_{t} \wedge \omega_{t}^{\prime}+A\left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}}^{\prime} d \eta_{t} \wedge \omega_{t}^{\prime} \\
& -6\left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}}^{2}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}}^{\prime}\right) \wedge \eta_{t} \wedge \omega_{t}^{\prime}-3\left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}}^{\prime} \mathrm{d} \eta_{t} \wedge \omega_{t}^{\prime} .
\end{aligned}
$$

Finally, a discussion on potentially solving these equations follows in §5.3.

### 1.3 Notation and conventions in $\mathrm{G}_{2}$-geometry

Let $\left(M^{7}, \varphi\right)$ be a smooth orientable $\mathrm{G}_{2}$-structure manifold. It determines a Riemannian metric $g_{\varphi}$ and volume $\operatorname{vol}_{\varphi}$ by

$$
(X\lrcorner \varphi) \wedge(Y\lrcorner \varphi) \wedge \varphi=6 g_{\varphi}(X, Y) \operatorname{vol}_{\varphi}, \quad \text { for } \quad X, Y \in \Gamma(T M),
$$

where $\lrcorner$ denotes the interior product. A $\mathrm{G}_{2}$-structure gives rise to a $g_{\varphi}$-orthogonal decomposition of differential forms corresponding to irreducible $\mathrm{G}_{2}$-representations:

$$
\begin{equation*}
\Omega^{2}=\Omega_{7}^{2} \oplus \Omega_{14}^{2} \quad \text { and } \quad \Omega^{3}=\Omega_{1}^{3} \oplus \Omega_{7}^{3} \oplus \Omega_{27}^{3}, \tag{4}
\end{equation*}
$$

where $\Omega_{l}^{k}$ has (pointwise) dimension $l$. Via the Hodge star, this defines isomorphic decompositions of $\Omega^{5}$ and $\Omega^{4}$, respectively. Given a $\mathrm{G}_{2}$-structure $\varphi$, there exist unique torsion forms $\tau_{0} \in \Omega^{0}, \tau_{1} \in \Omega^{1}, \tau_{2} \in \Omega_{14}^{2}$ and $\tau_{3} \in \Omega_{27}^{3}$, such that

$$
\begin{align*}
& \mathrm{d} \varphi=\tau_{0} \psi+3 \tau_{1} \wedge \varphi+* \tau_{3}  \tag{5}\\
& \mathrm{~d} \psi=4 \tau_{1} \wedge \psi+\tau_{2} \wedge \varphi \tag{6}
\end{align*}
$$

see e.g. [Bry06, Proposition 1]. The intrinsic torsion is defined with respect to the Levi-Civita connection of the $\mathrm{G}_{2}$-metric by $\nabla \varphi:=\nabla^{g_{\varphi}} \varphi$. Then, the full torsion tensor of $\varphi$ is the 2 -tensor $T$ defined by

$$
\begin{equation*}
\nabla_{i} \varphi_{j k l}=T_{i}^{m} \psi_{m j k l}, \quad T_{i}^{j}=\frac{1}{24} \nabla_{i} \varphi_{l m n} \psi^{j l m n} \tag{7}
\end{equation*}
$$

see [Kar07], and $T_{i j}=T\left(\partial_{i}, \partial_{j}\right)$ and $T_{i}^{j}=T_{i k} g^{j k}$ and may be expressed in terms of the torsion forms by

$$
\begin{equation*}
\left.T=\frac{\tau_{0}}{4} g-\tau_{1}^{\sharp}\right\lrcorner \varphi-\frac{1}{2} \tau_{2}-\frac{1}{4} \mathrm{j}_{\varphi}\left(\tau_{3}\right), \tag{8}
\end{equation*}
$$

where $j_{\varphi}$ is a linear operator $\mathrm{j}_{\varphi}: \Omega^{3} \rightarrow S^{2}$ by

$$
\begin{equation*}
\left.\left.\mathrm{j}_{\varphi}(\gamma)(X, Y)=*_{\varphi}((X\lrcorner \varphi) \wedge(Y\lrcorner \varphi\right) \wedge \gamma\right) \tag{9}
\end{equation*}
$$

see e.g. [Kar07, Theorem 2.27].

## 2 The modified Laplacian coflow on $M^{7}=N^{3} \times S^{1}$

We apply the methods from [PS22] to the modified Laplacian coflow [Gri13]. We note that the sign convention and orientation here are opposite to those chosen in [PS22].

Let $M^{7}=N^{3} \times S^{1}$, where $N$ is a smooth compact Calabi-Yau 3-manifold. Let $\omega$ be a Kähler metric and $\Upsilon$ be a nowhere-vanishing holomorphic (3,0)-form on $N$. Both $\omega$ and $\Upsilon$ are closed and, in local Darboux coordinates, we may write

$$
\begin{align*}
& \omega=\frac{i}{2}\left(g_{6}\right)_{p \bar{q}} \mathrm{~d} z^{p} \wedge \mathrm{~d} \bar{z}^{q}  \tag{10}\\
& \Upsilon=u \mathrm{~d} z^{1} \wedge \mathrm{~d} z^{2} \wedge \mathrm{~d} z^{3} \tag{11}
\end{align*}
$$

where $g_{6}=\left(g_{6}\right)_{p \bar{q}}$ is the metric associated to $\omega$ and $u$ is a local holomorphic function. The norm of $\Upsilon$ with respect to $\omega$ is given by

$$
\begin{equation*}
|\Upsilon|_{\omega}^{2}=\frac{|u|^{2}}{\operatorname{det}\left(g_{6}\right)_{p \bar{q}}} \tag{12}
\end{equation*}
$$

and it is constant when $\omega$ is Ricci-flat. The pair $(\omega, \Upsilon)$ satisfies the following relations:

\begin{equation*}
\frac{\omega^{3}}{3!}=\operatorname{vol}_{6}=\frac{i}{8} \frac{1}{|\Upsilon|_{\omega}^{2}} \Upsilon \wedge \bar{\Upsilon}=\frac{1}{4} \operatorname{Re}\left(\frac{1}{|\Upsilon|_{\omega}} \Upsilon\right) \wedge \operatorname{Im}\left(\frac{1}{|\Upsilon|_{\omega}} \Upsilon\right) \tag{13}
\end{equation*}
$$

where $\mathrm{vol}_{6}$ is the volume form on $\left(N, g_{6}\right)$. The Hodge star operator $*_{6}$ on $N$ has the foowing properties:

$$
\begin{equation*}
\left(*_{6}\right)^{2} \alpha=(-1)^{k} \alpha, \quad *_{6} \operatorname{Re}(\Upsilon)=\operatorname{Im} \Upsilon, \quad *_{6} \omega=\frac{1}{2} \omega^{2}, \quad \text { for } \quad \alpha \in \Omega^{k}(N) \tag{14}
\end{equation*}
$$

Let $r$ denote the angle coordinate on $S^{1}$, so $\mathrm{d} r \in \Omega^{1}\left(S^{1}\right)$ is the globally defined (volume) form on $S^{1}$ with respect to its standard round metric.

Now, we consider the natural $\mathrm{G}_{2}$-structure on $M$ given by the positive 3-form

$$
\begin{equation*}
\varphi=\operatorname{Re}\left(\frac{1}{|\Upsilon|_{\omega}} \Upsilon\right)+|\Upsilon|_{\omega} \mathrm{d} r \wedge \omega \tag{15}
\end{equation*}
$$

cf [KMT12]. The 3-form (15) induces the metric $g_{7}$, volume form and dual 4 -form $\psi=* \varphi$ given by

$$
\begin{align*}
g & =|\Upsilon|_{\omega} \mathrm{d} r^{2}+g_{6}  \tag{16}\\
\operatorname{vol} & =|\Upsilon|_{\omega} \mathrm{d} r \wedge \operatorname{vol}_{6}  \tag{17}\\
\psi & =-\mathrm{d} r \wedge \operatorname{Im} \Upsilon+\frac{1}{2} \omega^{2} . \tag{18}
\end{align*}
$$

The 7 -dimensional Hodge star operator $*$ of $g_{\varphi}$ has the following properties acting on $\alpha \in \Omega^{k}(N)$ :

$$
\begin{align*}
* \alpha & =(-1)^{k}|\Upsilon|_{\omega} \mathrm{d} r \wedge *_{6} \alpha  \tag{19}\\
*(\mathrm{~d} r \wedge \alpha) & =\frac{1}{|\Upsilon|_{\omega}} *_{6} \alpha \tag{20}
\end{align*}
$$

Since both $\omega$ and $\Upsilon$ are closed, $\varphi$ is a coclosed $\mathrm{G}_{2}$-structure. Moreover, Picard-Suan [PS22] compute

$$
\begin{align*}
\mathrm{d} \varphi & =-\frac{1}{|\Upsilon|_{\omega}} \mathrm{d}\left(\log |\Upsilon|_{\omega}\right) \wedge \operatorname{Re}(\Upsilon)+|\Upsilon|_{\omega} \mathrm{d}\left(\log |\Upsilon|_{\omega}\right) \wedge \mathrm{d} r \wedge \omega  \tag{21}\\
* \mathrm{~d} \varphi & \left.=\left(\nabla_{g_{6}}\left(\log |\Upsilon|_{\omega}\right)\right)\right\lrcorner\left(-\mathrm{d} r \wedge \operatorname{Im} \Upsilon-\frac{1}{2} \omega^{2}\right) \tag{22}
\end{align*}
$$

From those formulae, one easily derives:
Lemma 2.1. [PS22] Let $\varphi$ be the $\mathrm{G}_{2}$-structure defined by (15) on $M=N \times S^{1}$ with $N$ a Calabi-Yau 3-manifold, then the torsion forms are given by

$$
\begin{equation*}
\left.\tau_{0}=0, \quad \tau_{1}=0, \quad \tau_{2}=0, \quad \tau_{3}=\left(\nabla_{g_{6}}\left(\log |\Upsilon|_{\omega}\right)\right)\right\lrcorner\left(-\mathrm{d} r \wedge \operatorname{Im} \Upsilon-\frac{1}{2} \omega^{2}\right) \tag{23}
\end{equation*}
$$

The Hodge Laplacian of the 4 -form is given by

$$
\begin{equation*}
\Delta \psi=\mathcal{L}_{\nabla\left(\log |\Upsilon|_{\omega)}\right.}\left(-\mathrm{d} r \wedge \operatorname{Im} \Upsilon-\frac{1}{2} \omega^{2}\right) \tag{24}
\end{equation*}
$$

Applying Lemma 2.1 to the Laplacian coflow (1) of the above $\mathrm{G}_{2}$-structures yields the evolution equation

$$
\frac{\partial}{\partial t}\left(-\mathrm{d} r \wedge \operatorname{Im} \Upsilon+\frac{1}{2} \omega^{2}\right)=\mathcal{L}_{\nabla\left(\log |\Upsilon|_{\omega)}\right.}\left(-\mathrm{d} r \wedge \operatorname{Im} \Upsilon-\frac{1}{2} \omega^{2}\right)
$$

The terms involving $\omega$ and $\Upsilon$ can be considered separately. Noting time dependencies, one can consider Ansätze of the form $\left(\omega_{t}, \Upsilon_{t}\right)$ on $N$, satisfiying

$$
\begin{align*}
& \frac{\partial}{\partial t} \omega_{t}=-\mathcal{L}_{\nabla_{t}\left(\log \mid \Upsilon_{\left.t \mid \omega_{t}\right)} \omega_{t}\right.},  \tag{25}\\
& \frac{\partial}{\partial t} \Upsilon_{t}=\mathcal{L}_{\nabla_{t}\left(\log \mid \Upsilon_{t \mid \omega_{t}}\right)} \Upsilon_{t} \tag{26}
\end{align*}
$$

On the other hand, using properties of Kähler manifolds, we see that

$$
\begin{equation*}
\mathcal{L}_{\nabla\left(\log |\Upsilon|_{\omega}\right)} \omega=2 i \partial \bar{\partial}\left(\log |\Upsilon|_{\omega}\right)=\operatorname{Ric}(\omega, J), \tag{27}
\end{equation*}
$$

which ultimately relates the Laplacian coflow to the Kähler-Ricci flow.
Remark 2.2. A priori, the structures $\left(\omega_{t}, \Upsilon_{t}\right)$ along the flow may not remain compatible and integrable for all time. However, the solution presented in [PS22] satisfy the required compatibility conditions, as they are obtained by pulling back compatible structures via diffeomorphisms.

We now consider the modified coflow in this setting. A similar treatment using ideas from [FPPZ20] and [PS22] yields the following result.
Theorem 2.3. Let $N^{3}$ be a Calabi-Yau 3-manifold with Kähler form $\omega$ and holomorphic ( 3,0 )-form $\Upsilon$. Suppose we have a family of compatible $\mathrm{SU}(3)$-structures $\left(\omega_{t}, \Upsilon_{t}\right)$ satisfying the coupled differential equations

$$
\begin{align*}
& \frac{\partial}{\partial t} \omega_{t}=-\mathcal{L}_{\nabla_{t}\left(\log \mid \Upsilon_{t \mid \omega_{t} t}\right) \omega_{t}+\beta_{t}}^{\frac{\partial}{\partial t} \Upsilon_{t}=\mathcal{L}_{\nabla_{t}\left(\log \mid \Upsilon_{\left.t \mid \omega_{t}\right)}\right.} \Upsilon_{t}+\gamma_{t}} \tag{28}
\end{align*}
$$

where $\beta_{t} \in \Omega^{2}(N), \gamma_{t} \in \Omega^{3}(N)$ with initial conditions $\omega_{0}=\omega, \Upsilon_{0}=\Upsilon$, and let $\left\{\varphi_{t}\right\}$ be the family $\mathrm{G}_{2}$ structures given by

$$
\begin{equation*}
\varphi_{t}=\operatorname{Re}\left(\frac{1}{|\Upsilon|_{\omega_{t}}} \Upsilon\right)+|\Upsilon|_{\omega_{t}} \mathrm{~d} r \wedge \omega_{t} \tag{30}
\end{equation*}
$$

Then $\left\{\varphi_{t}\right\}$ is a solution of the modified Laplacian coflow (2) with constant $A$ if, and only if,

$$
\begin{align*}
& \beta_{t} \wedge \omega_{t}=-A \frac{1}{|\Upsilon| \omega} \mathrm{d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right) \wedge \operatorname{Re}\left(\Upsilon_{t}\right)  \tag{31}\\
& \operatorname{Im}\left(\gamma_{t}\right)=A\left|\Upsilon_{t}\right|_{\omega_{t}} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right) \wedge \omega_{t} \tag{32}
\end{align*}
$$

Proof. The family of $\mathrm{G}_{2}$-structures defined by (30) has dual 4-forms $\psi_{t}$ given by (18). Since the radial coordinate $r$ on $S^{1}$ does not depend on $t$, its evolution equation is

$$
\begin{equation*}
\frac{\partial}{\partial t} \psi_{t}=\frac{\partial}{\partial t}\left(-\mathrm{d} r \wedge \operatorname{Im} \Upsilon_{t}+\frac{1}{2} \omega_{t}^{2}\right)=-\mathrm{d} r \wedge\left(\frac{\partial}{\partial t} \operatorname{Im} \Upsilon_{t}\right)+\frac{1}{2}\left(\frac{\partial}{\partial t} \omega_{t}^{2}\right) \tag{33}
\end{equation*}
$$

Next, applying Lemma 2.1, (21) and the fact that $\left(\tau_{0}\right)_{t}=0$ to the modified Laplacian coflow (2), we obtain

$$
\begin{align*}
\frac{\partial}{\partial t}\left(-\mathrm{d} r \wedge \operatorname{Im} \Upsilon_{t}+\frac{1}{2} \omega_{t}^{2}\right) & =\mathcal{L}_{\nabla_{t}\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right)}\left(-\mathrm{d} r \wedge \operatorname{Im} \Upsilon_{t}-\frac{1}{2} \omega_{t}^{2}\right)  \tag{34}\\
& -A \frac{1}{\left|\Upsilon_{t}\right|_{\omega_{t}}} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right) \wedge \operatorname{Re}\left(\Upsilon_{t}\right)+A\left|\Upsilon_{t}\right|_{\omega_{t}} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right) \wedge \mathrm{d} r \wedge \omega_{t}
\end{align*}
$$

where the terms in blue correspond to the additional term stemming from the de Turck modification. Equating (33) and (34), we have

$$
\begin{align*}
-\mathrm{d} r \wedge\left(\frac{\partial}{\partial t} \operatorname{Im} \Upsilon_{t}\right)-\frac{1}{2}\left(\frac{\partial}{\partial t} \omega_{t}^{2}\right) & =\mathcal{L}_{\nabla\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right)}\left(-\mathrm{d} r \wedge \operatorname{Im} \Upsilon_{t}-\frac{1}{2} \omega_{t}^{2}\right) \\
& -A \frac{1}{\left|\Upsilon_{t}\right|_{\omega_{t}}} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right) \wedge \operatorname{Re}\left(\Upsilon_{t}\right)+A\left|\Upsilon_{t}\right|_{\omega_{t}} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right) \wedge \mathrm{d} r \wedge \omega_{t} \tag{35}
\end{align*}
$$

Now, assuming that the system (28) and (29) is satisfied and substituting into (35), we get

$$
-\mathrm{d} r \wedge \operatorname{Im}\left(\gamma_{t}\right)+\beta_{t} \wedge \omega_{t}=-A \frac{1}{\left|\Upsilon_{t}\right|_{\omega_{t}}} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right) \wedge \operatorname{Re}\left(\Upsilon_{t}\right)+A\left|\Upsilon_{t}\right|_{\omega_{t}} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right) \wedge d r \wedge \omega_{t}
$$

Since the radial coordinate is independent of $t$, we can contract by $\partial_{r}$, which yields (32). Using (32) and the above equation, we get (31).

As a corollary, we obtain restrictions on the forms $\beta_{t}$ and $\gamma_{t}$, assuming that the complex structure $J$ is to stay fixed along the flow.

Corollary 2.4. Let $\left\{\varphi_{t}\right\}$ of the form (30) be a solution to the modified Laplacian coflow, such that the associated $\mathrm{SU}(3)$-structures satisfy (28) and (29). If the complex structure $J$ on $N$ remains fixed along the flow, then

$$
\begin{align*}
\beta_{t}^{(1,1)} & =0  \tag{36}\\
\operatorname{Im}\left(\gamma_{t}\right)^{(0,3) \oplus(3,0)} & =0 \tag{37}
\end{align*}
$$

Proof. Since $\left\{\varphi_{t}\right\}$ is a solution, we must have that $\omega_{t}$ and $\Upsilon_{t}$ satisfy (28) and (29). If the complex structure $J$ is fixed, we must have $\frac{\partial}{\partial t} \omega_{t} \in \Omega^{1,1}$. We see that the RHS of (28) has bidegree $(1,3) \oplus(3,1)$. Since $\omega_{t} \in \Omega^{1,1}$ it follows that the $(1,1)$-part of $\beta_{t}$ must vanish. A similar analysis shows that the $(3,0) \oplus(0,3)$-part of $\operatorname{Im}\left(\gamma_{t}\right)$ must also vanish.

## 3 Flows on contact Calabi-Yau 7-Manifolds

We now extend the ideas of [PS22] to contact Calabi-Yau (cCY) manifolds, and investigate both the Laplacian coflow and the modified coflow on those spaces. We employ the approach of Tomassini-Vezzoni [TV08] and Habib-Vezzoni [HV15] for the geometry of Sasakian manifolds satisfying $\operatorname{Hol}(\nabla) \subseteq \operatorname{SU}(n)$ in $\mathrm{G}_{2}$-geometry; see also [CARSE20].

Definition 3.1. A contact Calabi-Yau ( $c C Y^{7}$ ) 7 -manifold is a quadruple $\left(M^{7}, \eta, \Phi, \Upsilon\right)$ such that

- $(M, \xi, \eta, \Phi, g)$ is a 7 -dimensional Sasakian manifold with Reeb vector field $\xi$ and contact form $\eta$ and vanishing first basic Chern class $c_{1}^{B}(M)=0$, see Appendix A;
- $\Upsilon$ is a nowhere vanishing transverse form on $\mathcal{D}=$ ker $\eta$ of type $(3,0)$, with

$$
\frac{\omega^{3}}{3!}=\operatorname{vol}_{\mathcal{D}}=\frac{i}{8} \frac{1}{|\Upsilon|_{\omega}^{2}} \Upsilon \wedge \bar{\Upsilon}, \quad \mathrm{~d} \Upsilon=0
$$

where $\omega=\mathrm{d} \eta$. We also define

$$
\operatorname{Re} \Upsilon:=\frac{\Upsilon+\bar{\Upsilon}}{2}, \quad \operatorname{Im} \Upsilon:=\frac{\Upsilon-\bar{\Upsilon}}{2 i}
$$

We refer to $(\omega, \Upsilon)$ as a transverse $\mathrm{SU}(3)$-structure and the norm $|\Upsilon|_{\omega}$ is constant when $\omega$ is transverse Ricci-flat.

Remark 3.2. A contact Calabi-Yau manifold $(M, g, \eta, \Upsilon)$ has transverse Calabi-Yau geometry on the distribution $\mathcal{D}=\operatorname{ker} \eta$, in the sense of foliations, given by $\left.g\right|_{\mathcal{D}}, \omega$ and $\Upsilon$. When the Sasakian structure is regular or quasi-regular, $M$ is an $S^{1}$-(orbi)bundle over a Calabi-Yau orbifold $\mathcal{Z}=M / \mathcal{F}_{\xi}$ where $\mathcal{F}_{\xi}$ is the foliation obtained from the Reeb vector field $\xi$. The Sasakian geometry can also be irregular, and in this case there is no $S^{1}$-fibration structure on $M$ compatible with the contact Calabi-Yau geometry.

### 3.1 Preliminaries on $c C Y^{7}$

We recall how to relate the cCY geometry in 7 dimensions to $\mathrm{G}_{2}$-geometry, cf. [HV15, Corollary 6.8] and [LSE21].

Proposition 3.3. Let $\left(M^{7}, \eta, \Phi, \Upsilon\right)$ be a contact Calabi-Yau 7-manifold. Then $M$ carries a 1-parameter of coclosed $\mathrm{G}_{2}$-structures defined by

$$
\begin{equation*}
\varphi=\operatorname{Re} \Upsilon+\varepsilon \eta \wedge \omega \tag{38}
\end{equation*}
$$

for $\varepsilon>0$, where $\omega=\mathrm{d} \eta$ is transverse Ricci-flat. Furthermore, $\mathrm{d} \varphi=\varepsilon \omega^{2}$ and $\varphi$ is coclosed, ie. $\mathrm{d} \psi=0$.
The metric $g$ and the transverse symplectic form $\omega=\mathrm{d} \eta$ on $(M, \eta, \Phi, \Upsilon)$ can be written locally as

$$
\begin{equation*}
g=\eta^{2}+g_{p \bar{q}} \mathrm{~d} z^{p} \mathrm{~d} \bar{z}^{q}, \quad \mathrm{~d} \eta=2 i g_{p \bar{q}} \mathrm{~d} z^{p} \wedge \mathrm{~d} \bar{z}^{q}, \quad \Upsilon=u \mathrm{~d} z^{1} \wedge \mathrm{~d} z^{2} \wedge \mathrm{~d} z^{3} \tag{39}
\end{equation*}
$$

where the $g_{p \bar{q}}$ and $u$ are all basic functions. Moreover, we obtain a basic function defined by

$$
\begin{equation*}
|\Upsilon|_{\omega}^{2}=\frac{|u|^{2}}{\operatorname{det}(g)_{p \bar{q}}} \tag{40}
\end{equation*}
$$

We obtain a coclosed $\mathrm{G}_{2}$-structure given by

$$
\begin{equation*}
\varphi=\operatorname{Re}\left(\frac{1}{|\Upsilon|_{\omega}} \Upsilon\right)+|\Upsilon|_{\omega} \eta \wedge \omega \tag{41}
\end{equation*}
$$

In this case, the associated metric on $M$ is

$$
\begin{equation*}
g=|\Upsilon|_{\omega}^{2} \eta^{2}+\left.g\right|_{\mathcal{D}} \tag{42}
\end{equation*}
$$

the volume form is

$$
\begin{equation*}
\operatorname{vol}=\left.|\Upsilon|_{\omega} \eta \wedge \operatorname{vol}\right|_{\mathcal{D}}, \quad \text { with }\left.\quad \operatorname{vol}\right|_{\mathcal{D}}=\frac{\omega^{3}}{3!} \tag{43}
\end{equation*}
$$

and the dual 4 -form $\psi$ is

$$
\begin{equation*}
\psi=-\eta \wedge \operatorname{Im} \Upsilon+\frac{1}{2} \omega^{2} \tag{44}
\end{equation*}
$$

We recall that $\omega$ and $\Upsilon$ are closed, and the contact form $\eta$ satisfies $d \eta=\omega$. It follows that $\psi$ is closed, ie. $\varphi$ is coclosed. The Reeb vector field $\xi$ generates a 1-dimensional foliation $\mathcal{F}_{\xi}$, whose orientation induces a basic Hodge operator

$$
\begin{equation*}
*_{B}: \Lambda_{B}^{k}(M) \rightarrow \Lambda_{B}^{6-k}(M) \tag{45}
\end{equation*}
$$

in the usual way. Then, for $\alpha \in \Omega_{B}^{k}(M)$,

$$
\begin{equation*}
\left(*_{B}\right)^{2} \alpha=(-1)^{k} \alpha, \quad *_{B} \operatorname{Re}(\Upsilon)=\operatorname{Im} \Upsilon, \quad *_{B} \omega=\frac{1}{2} \omega^{2}, \tag{46}
\end{equation*}
$$

This relates to the standard Hodge operator of the 7-dimensional metric (42), acting on $\alpha \in \Omega_{B}^{k}(M) \hookrightarrow \Omega^{k}(M)$, by

$$
\begin{align*}
* \alpha & =(-1)^{k}|\Upsilon|_{\omega} \eta \wedge *_{B} \alpha  \tag{47}\\
*(\eta \wedge \alpha) & =\frac{1}{|\Upsilon|_{\omega}} *_{B} \alpha \tag{48}
\end{align*}
$$

We compute the torsion forms of the $\mathrm{G}_{2}$-structure (41), distinguishing in red terms that arise from the nontrivial topology of the $c C Y^{7}$, compared to the product $C Y^{3} \times S^{1}$.

Proposition 3.4. Let $\left(M^{7}, \eta, \Phi, \Upsilon\right)$ be a contact Calabi-Yau 7-manifold, with $\mathrm{G}_{2}$-structure $\varphi$ defined by (41). Then the torsion forms of $\varphi$ are given by

$$
\begin{equation*}
\tau_{0}=\frac{6}{7}|\Upsilon|_{\omega}, \quad \tau_{1}=0, \quad \tau_{2}=0 \tag{49}
\end{equation*}
$$

and

$$
\begin{equation*}
\left.\tau_{3}=\left(\nabla \log |\Upsilon|_{\omega}\right)\right\lrcorner\left(-\eta \wedge \operatorname{Im} \Upsilon+\frac{1}{2} \omega^{2}\right)-\frac{6}{7} \operatorname{Re} \Upsilon+\frac{8}{7}|\Upsilon|_{\omega}^{2} \eta \wedge \omega . \tag{50}
\end{equation*}
$$

Proof. Since $\varphi$ is coclosed, we have $\tau_{1}=0$ and $\tau_{2}=0$. We now compute $\tau_{0}$, as follows.

$$
\begin{align*}
\mathrm{d} \varphi & =\mathrm{d}\left(\operatorname{Re}\left(\frac{1}{|\Upsilon|_{\omega}} \Upsilon\right)+|\Upsilon|_{\omega} \eta \wedge \omega\right) \\
& =-\frac{1}{|\Upsilon|_{\omega}} \mathrm{d}\left(\log |\Upsilon|_{\omega}\right) \wedge \operatorname{Re}(\Upsilon)+|\Upsilon|_{\omega} \mathrm{d}\left(\log |\Upsilon|_{\omega}\right) \wedge \eta \wedge \omega+|\Upsilon|_{\omega} \omega^{2} \tag{51}
\end{align*}
$$

Taking the Hodge star of both sides we obtain

$$
\begin{align*}
* \mathrm{~d} \varphi & =-\frac{1}{|\Upsilon|_{\omega}} *\left(\log |\Upsilon|_{\omega} \wedge \operatorname{Re}(\Upsilon)\right)+|\Upsilon|_{\omega} *\left(\mathrm{~d}\left(\log |\Upsilon|_{\omega}\right) \wedge \eta \wedge \omega\right)+|\Upsilon|_{\omega} * \omega^{2} \\
& \left.\left.=\frac{1}{|\Upsilon|_{\omega}}\left(\mathrm{d} \log |\Upsilon|_{\omega}\right)^{\sharp}\right\lrcorner *(\operatorname{Re}(\Upsilon))-|\Upsilon|_{\omega}\left(\mathrm{d} \log |\Upsilon|_{\omega}\right)^{\sharp}\right\lrcorner *(\eta \wedge \omega)+|\Upsilon|_{\omega} * \omega^{2} \\
& \left.=\left(\nabla \log |\Upsilon|_{\omega}\right)\right\lrcorner\left(-\eta \wedge \operatorname{Im} \Upsilon-\frac{1}{2} \omega^{2}\right)+2|\Upsilon|_{\omega}^{2} \eta \wedge \omega . \tag{52}
\end{align*}
$$

Using (51), we find

$$
\tau_{0}=\frac{1}{7} *(\varphi \wedge d \varphi)=\frac{6}{7} *\left(|\Upsilon|_{\omega}^{2} \eta \wedge \frac{\omega^{3}}{3!}\right)=\frac{6}{7}|\Upsilon|_{\omega}
$$

Finally, we compute $\tau_{3}$, from (52):

$$
\begin{aligned}
\tau_{3} & =* d \varphi-\tau_{0} \varphi \\
& \left.=\left(\nabla \log |\Upsilon|_{\omega}\right)\right\lrcorner\left(-\eta \wedge \operatorname{Im} \Upsilon-\frac{1}{2} \omega^{2}\right)+2|\Upsilon|_{\omega}^{2} \eta \wedge \omega-\frac{6}{7}|\Upsilon|_{\omega}\left(\operatorname{Re} \frac{1}{|\Upsilon|_{\omega}} \Upsilon\right)-\frac{6}{7}|\Upsilon|_{\omega}^{2} \eta \wedge \omega \\
& \left.=\left(\nabla \log |\Upsilon|_{\omega}\right)\right\lrcorner\left(-\eta \wedge \operatorname{Im} \Upsilon-\frac{1}{2} \omega^{2}\right)-\frac{6}{7} \operatorname{Re} \Upsilon+\frac{8}{7}|\Upsilon|_{\omega}^{2} \eta \wedge \omega .
\end{aligned}
$$

Proposition 3.5. Let $\left(M^{7}, \eta, \Phi, \Upsilon\right)$ be a contact Calabi-Yau 7-manifold, with $\mathrm{G}_{2}$-structure $\varphi$ defined by (41). Then the Hodge Laplacian of $\psi=* \varphi$ is

$$
\begin{equation*}
\Delta \psi=\mathcal{L}_{\nabla(\log |\Upsilon| \omega)}\left(-\eta \wedge \operatorname{Im} \Upsilon-\frac{1}{2} \omega^{2}\right)+4|\Upsilon|_{\omega}^{2} \mathrm{~d}\left(\log |\Upsilon|_{\omega}\right) \eta \wedge \omega+2|\Upsilon|_{\omega}^{2} \omega^{2} \tag{53}
\end{equation*}
$$

Proof. Since $\varphi$ is coclosed, the Hodge Laplacian is given by $\Delta \psi=\mathrm{dd}^{*} \psi=\mathrm{d} * \mathrm{~d} \varphi$. We recall Cartan's formula $\left.\left.\mathcal{L}_{Y} \alpha=\mathrm{d}(Y\lrcorner \alpha\right)+Y\right\lrcorner(\mathrm{d} \alpha)$, for $\alpha \in \Omega^{k}(M)$ and $Y \in \mathfrak{X}(M)$. Using the fact that $\omega$ and $\Upsilon$ are closed, together with (51) and (52), we get

$$

\Delta \psi & =\mathrm{d} * \mathrm{~d} \varphi=\mathcal{L}_{\nabla\left(\log |\Upsilon|_{\omega}\right)}\left(-\eta \wedge \operatorname{Im} \Upsilon-\frac{1}{2} \omega^{2}\right)+2 \mathrm{~d}\left(|\Upsilon|_{\omega}^{2} \eta \wedge \omega\right) \\
& =\mathcal{L}_{\nabla\left(\log |\Upsilon|_{\omega)}\right.}\left(-\eta \wedge \operatorname{Im} \Upsilon-\frac{1}{2} \omega^{2}\right)+4|\Upsilon|_{\omega}^{2} \mathrm{~d}\left(\log |\Upsilon|_{\omega}\right) \wedge \eta \wedge \omega+2|\Upsilon|_{\omega}^{2} \omega^{2}
\end{aligned}
$$

### 3.2 The Laplacian coflow

Let $(M, \eta, \Phi, \Upsilon)$ be a contact Calabi-Yau 7 -manifold with $\mathrm{G}_{2}$-structure $\varphi$ defined by (41). We now consider the Laplacian coflow in this setting. Define a family of contact forms by $\eta_{t}=\eta+\mathrm{d}^{c} f_{t}$, where each $f_{t}$ is a basic function. This in turn defines a family of transverse Kähler structures

$$
\omega_{t}=\mathrm{d} \eta_{t}=\omega+\mathrm{dd}^{c} f_{t}
$$

We note that the endomorphism $\Phi_{t}$ varies, but the Reeb vector field $\xi$, the space of basic forms $\Omega_{B}^{\bullet}(M)$, and the transverse complex structure $J$ remain constant under these deformations (see Appendix A).

We have the following result, analogous to Corollary 2.4, describing the effects of fixing the transverse complex structure $J$.

Theorem 3.6. Let $(M, \eta, \Phi, \Upsilon)$ be a contact Calabi-Yau 7 -manifold with transverse Kähler form $\omega=\mathrm{d} \eta$ and transverse holomorphic (3,0)-form $\Upsilon$. Suppose we have a family of compatible transverse $\mathrm{SU}(3)$-structures $\left(\omega_{t}, \Upsilon_{t}\right)$ on $M$ satisfying the coupled differential equations

$$
\begin{align*}
\frac{\partial}{\partial t} \omega_{t} & =-\mathcal{L}_{\nabla_{t}\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right)} \omega_{t}+\beta_{t}  \tag{54}\\
\frac{\partial}{\partial t} \Upsilon_{t} & =\mathcal{L}_{\nabla_{t}\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right)} \Upsilon_{t}+\gamma_{t} \tag{55}
\end{align*}
$$

where $\beta_{t} \in \Omega_{B}^{2}(M)$, $\gamma_{t} \in \Omega_{B}^{3}(M)$ with initial conditions $\omega_{0}=\omega, \Upsilon_{0}=\Upsilon$. Suppose further that there exists $a$ family of basic functions $\left\{f_{t}\right\}$ such that $\omega_{t}=\omega+\operatorname{dd}^{c} f_{t}$, and let $\eta_{t}:=\eta+\mathrm{d}^{c} f_{t}$.

Then, the family of $\mathrm{G}_{2}$-structures given by

$$
\begin{equation*}
\varphi_{t}=\operatorname{Re}\left(\frac{1}{\left|\Upsilon_{t}\right|_{\omega_{t}}} \Upsilon_{t}\right)+|\Upsilon|_{\omega_{t}} \eta_{t} \wedge \omega_{t} \tag{56}
\end{equation*}
$$

is a solution of the Laplacian coflow (1) if, and only if,

$$
\begin{align*}
& \beta_{t} \wedge \omega_{t}= 2\left|\Upsilon_{t}\right|_{\omega_{t}}^{2} \omega_{t}^{2}-\left(\mathcal{L}_{\nabla\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right)} \mathrm{d}^{c} f_{t}\right) \wedge \operatorname{Im} \Upsilon_{t} \\
&\left.\quad-\left(\nabla\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right)\right\lrcorner \omega\right) \wedge \operatorname{Im} \Upsilon_{t}+\left(\frac{\partial}{\partial t} \mathrm{~d}^{c} f_{t}\right) \wedge \operatorname{Im} \Upsilon_{t}  \tag{57}\\
& \operatorname{Im}\left(\gamma_{t}\right)=4|\Upsilon|_{\omega_{t}}^{2} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right) \wedge \omega_{t} \tag{58}
\end{align*}
$$

Proof. The family of $\mathrm{G}_{2}$-structures defined by (56) has associated 4-form $\psi_{t}=*_{t} \varphi_{t}$ given by (44), whose evolution equation is

$$
\begin{equation*}
\frac{\partial}{\partial t} \psi_{t}=\frac{\partial}{\partial t}\left(-\eta_{t} \wedge \operatorname{Im} \Upsilon_{t}+\frac{1}{2} \omega_{t}^{2}\right)=-\eta_{t} \wedge\left(\frac{\partial}{\partial t} \operatorname{Im} \Upsilon\right)+\frac{1}{2}\left(\frac{\partial}{\partial t} \omega_{t}^{2}\right)-\left(\frac{\partial}{\partial t} \eta_{t}\right) \wedge \operatorname{Im} \Upsilon_{t} \tag{59}
\end{equation*}
$$

Thus, applying Proposition 3.5 to the Laplacian coflow (53), we obtain

$$
\begin{align*}
& \frac{\partial}{\partial t}\left(-\eta_{t} \wedge \operatorname{Im} \Upsilon_{t}+\frac{1}{2} \omega_{t}^{2}\right) \\
& =\mathcal{L}_{\nabla_{t}\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right)}\left(-\eta_{t} \wedge \operatorname{Im} \Upsilon_{t}-\frac{1}{2} \omega_{t}^{2}\right)+4\left|\Upsilon_{t}\right|_{\omega_{t}}^{2} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right) \eta_{t} \wedge \omega_{t}+2|\Upsilon|_{\omega_{t}}^{2} \omega_{t}^{2} \tag{60}
\end{align*}
$$

Substituting (59) into (60), we have

$$
\begin{align*}
& -\eta_{t} \wedge\left(\frac{\partial}{\partial t} \operatorname{Im} \Upsilon_{t}\right)-\left(\frac{\partial}{\partial t} \eta_{t}\right) \wedge \operatorname{Im} \Upsilon_{t}+\frac{1}{2}\left(\frac{\partial}{\partial t} \omega^{2}\right) \\
& =\mathcal{L}_{\nabla_{t}\left(\log \mid \Upsilon_{\left.t \mid \omega_{t}\right)}\right.}\left(-\eta_{t} \wedge \operatorname{Im} \Upsilon_{t}-\frac{1}{2} \omega^{2}\right)+4\left|\Upsilon_{t}\right|_{\omega_{t}}^{2} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right) \eta_{t} \wedge \omega_{t}+2\left|\Upsilon_{t}\right|_{\omega_{t}}^{2} \omega_{t}^{2} \tag{61}
\end{align*}
$$

Applying Cartan's magic formula to the Lie derivative term, we obtain

$$
\begin{align*}
& \mathcal{L}_{\nabla_{t}\left(\log \mid \Upsilon_{t \mid \omega_{t}}\right)}\left(\eta_{t} \wedge \operatorname{Im} \Upsilon\right) \\
& =\left(\mathcal{L}_{\nabla_{t}\left(\log \mid \Upsilon_{t \mid \omega_{t}}\right)} \eta_{t}\right) \wedge \operatorname{Im} \Upsilon_{t}+\eta_{t} \wedge\left(\mathcal{L}_{\nabla\left(\log \mid \Upsilon_{t \mid \omega_{t}}\right)} \operatorname{Im} \Upsilon\right) \\
& \left.\left.=\mathrm{d}\left(\nabla_{t}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right)\right\lrcorner \eta_{t}\right) \wedge \operatorname{Im} \Upsilon_{t}+\left(\nabla_{t}\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right)\right\lrcorner \omega_{t}\right) \wedge \operatorname{Im} \Upsilon_{t}+\eta_{t} \wedge\left(\mathcal{L}_{\nabla_{t}\left(\log \mid \Upsilon_{t \mid \omega_{t}}\right)} \operatorname{Im} \Upsilon_{t}\right) . \tag{62}
\end{align*}
$$

Since $\mathrm{d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right)$ is a basic function (recall that the Reeb vector field $\xi$ is fixed along these deformations) and $\eta_{t}=\eta+\mathrm{d}^{c} f_{t}$, the above expression becomes

$$
\begin{align*}
& \left.\left.\mathcal{L}_{\nabla_{t}\left(\log \mid \Upsilon_{\left.t \mid \omega_{t}\right)}\left(\eta_{t} \wedge \operatorname{Im} \Upsilon_{t}\right)\right.}=\mathrm{d}\left(\nabla_{t}\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right)\right\lrcorner \mathrm{d}^{c} f_{t}\right) \wedge \operatorname{Im} \Upsilon_{t}+\left(\nabla_{t}\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right)\right\lrcorner \omega_{t}\right) \wedge \operatorname{Im} \Upsilon_{t}+\eta_{t} \wedge\left(\mathcal{L}_{\nabla_{t}\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right)} \operatorname{Im} \Upsilon_{t}\right) \\
& \left.=\left(\mathcal{L}_{\nabla_{t}\left(\log \mid \Upsilon_{t \mid \omega_{t}}\right)} \mathrm{d}^{c} f_{t}\right) \wedge \operatorname{Im} \Upsilon_{t}+\left(\nabla_{t}\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right)\right\lrcorner \omega\right) \wedge \operatorname{Im} \Upsilon_{t}+\eta_{t} \wedge\left(\mathcal{L}_{\nabla_{t}\left(\log \mid \Upsilon_{t \mid \omega_{t}}\right)} \operatorname{Im} \Upsilon_{t}\right) .
\end{align*}
$$

Now, assuming that the system (54) and (55) is satisfied, substituting into (61), and using (63), we get

$$
\begin{align*}
&-\left(\frac{\partial}{\partial t} \eta_{t}\right) \wedge \operatorname{Im} \Upsilon_{t}-\eta_{t} \wedge \operatorname{Im}\left(\gamma_{t}\right)+\beta_{t} \wedge \omega_{t} \\
&=4\left|\Upsilon_{t}\right|_{\omega_{t}}^{2} d\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right) \wedge \eta_{t} \wedge \omega_{t}+2\left|\Upsilon_{t}\right|_{\omega_{t}}^{2} \omega_{t}^{2} \\
&\left.\quad-\left(\mathcal{L}_{\nabla_{t}\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right)} \mathrm{d}^{c} f_{t}\right) \wedge \operatorname{Im} \Upsilon_{t}-\left(\nabla_{t}\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right)\right\lrcorner \omega\right) \wedge \operatorname{Im} \Upsilon_{t} . \tag{64}
\end{align*}
$$

Since the Reeb vector field $\xi$ is constant with respect to $t$, we can contract by $\xi$ and obtain

$$
\begin{equation*}
\left.\left.\left.-[\xi\lrcorner\left(\frac{\partial}{\partial t} \eta_{t}\right)\right] \wedge \operatorname{Im} \Upsilon_{t}-(\xi\lrcorner \eta_{t}\right) \wedge \operatorname{Im}\left(\gamma_{t}\right)=-4\left|\Upsilon_{t}\right|_{\omega_{t}}^{2}(\xi\lrcorner \eta_{t}\right) \wedge \mathrm{d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right) \wedge \omega_{t} \tag{65}
\end{equation*}
$$

Using $\eta_{t}=\eta+\mathrm{d}^{c} f_{t}$, this simplifies to

$$
\operatorname{Im}\left(\gamma_{t}\right)=4|\Upsilon|_{\omega_{t}}^{2} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right) \wedge \omega_{t}
$$

Plugging this back into into (64), we obtain

$$
\begin{equation*}
\left.\beta_{t} \wedge \omega_{t}=2\left|\Upsilon_{t}\right|_{\omega_{t}}^{2} \omega_{t}^{2}-\left(\mathcal{L}_{\nabla_{t}\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right)} \mathrm{d}^{c} f_{t}\right) \wedge \operatorname{Im} \Upsilon_{t}-\left(\nabla_{t}\left(\log \left|\Upsilon_{t}\right| \omega_{\omega_{t}}\right)\right\lrcorner \omega\right) \wedge \operatorname{Im} \Upsilon_{t}+\left(\frac{\partial}{\partial t} \mathrm{~d}^{c} f_{t}\right) \wedge \operatorname{Im} \Upsilon_{t} \tag{66}
\end{equation*}
$$

which concludes the proof.

### 3.3 The modified Laplacian coflow

We now turn our attention to the modified Laplacian coflow (2). Recall that if $(\omega, \Upsilon)$ is a transverse $\operatorname{SU}(3)$ structure on a contact Calabi-Yau 7 -manifold $\left(M^{7}, \eta, \Phi, \Upsilon\right)$, we can define a coclosed $\mathrm{G}_{2}$-structure by

$$
\varphi=\operatorname{Re}\left(\frac{1}{|\Upsilon|_{\omega}} \Upsilon\right)+|\Upsilon|_{\omega} \eta \wedge \omega
$$

Such a $\mathrm{G}_{2}$-structure has $\tau_{0}=\frac{6}{7}|\Upsilon|_{\omega}$, hence the added term in the modified coflow with constant $A$ would be

$$
\mathrm{d}\left(\left(A-\frac{7}{2} \tau_{0}\right) \varphi\right)=-\frac{A}{|\Upsilon|_{\omega}} \mathrm{d}\left(\log |\Upsilon|_{\omega}\right) \wedge \operatorname{Re}(\Upsilon)+A|\Upsilon|_{\omega} \mathrm{d}\left(\log |\Upsilon|_{\omega}\right) \wedge \eta \wedge \omega+A|\Upsilon|_{\omega} \omega^{2}
$$

$$
\begin{equation*}
-6|\Upsilon|_{\omega}^{2} \mathrm{~d}\left(\log |\Upsilon|_{\omega}\right) \wedge \eta \wedge \omega-3|\Upsilon|_{\omega}^{2} \omega^{2} \tag{67}
\end{equation*}
$$

Let $\eta_{t}$ and $\omega_{t}$ evolve as in the previous subsection, via (54) and (55). As before, the Reeb vector field $\xi$ and transverse complex structure stay fixed. We now obtain a similar result to Theorem 3.6 for the modified coflow. As before, the red terms are from the non-trivial topology. We shall also denote terms derived from the de Turck modification in blue, and terms coming from a combination of both the topology and the modification in purple.

Theorem 3.7. Let $\left(M^{7}, \eta, \Phi, \Upsilon\right)$ be a contact Calabi-Yau 7 -manifold, with transverse Kähler form $\omega=\mathrm{d} \eta$ and transverse holomorphic $(3,0)$-form $\Upsilon$. Suppose we have a family of compatible transverse $\mathrm{SU}(3)$-structures $\left(\omega_{t}, \Upsilon_{t}\right)$ on $M$ satisfying the coupled differential equations:

$$
\begin{align*}
\frac{\partial}{\partial t} \omega_{t} & =-\mathcal{L}_{\nabla_{t}\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right)} \omega_{t}+\beta_{t}  \tag{68}\\
\frac{\partial}{\partial t} \Upsilon_{t} & =\mathcal{L}_{\nabla_{t}\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right)} \Upsilon_{t}+\gamma_{t} \tag{69}
\end{align*}
$$

where $\beta_{t} \in \Omega_{B}^{2}(M), \gamma_{t} \in \Omega_{B}^{3}(M)$, with initial conditions $\omega_{0}=\omega, \Upsilon_{0}=\Upsilon$. Suppose further that there exists $a$ family of basic functions $f_{t}$ such that $\omega_{t}=\omega+\mathrm{dd}^{c} f_{t}$, and let $\eta_{t}:=\eta+\mathrm{d}^{c} f_{t}$.

Then the family of $\mathrm{G}_{2}$-structures given by

$$
\begin{equation*}
\varphi_{t}=\operatorname{Re}\left(\frac{1}{\left|\Upsilon_{t}\right|_{\omega_{t}}} \Upsilon_{t}\right)+|\Upsilon|_{\omega_{t}} \eta_{t} \wedge \omega_{t} \tag{70}
\end{equation*}
$$

is a solution of the modified Laplacian coflow (2) if, and only if,

$$
\begin{align*}
\beta_{t} \wedge \omega_{t}= & -\left|\Upsilon_{t}\right|_{\omega_{t}}^{2} \omega_{t}^{2}+A\left|\Upsilon_{t}\right|_{\omega_{t}} \omega_{t}^{2}-\frac{A}{\left|\Upsilon_{t}\right|_{\omega_{t}}} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right) \wedge \operatorname{Re} \Upsilon_{t} \\
& \left.-\left(\mathcal{L}_{\nabla_{t}\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right)} \mathrm{d}^{c} f_{t}\right) \wedge \operatorname{Im} \Upsilon_{t}-\left(\nabla_{t}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right)\right\lrcorner \omega\right) \wedge \operatorname{Im} \Upsilon_{t}+\left(\frac{\partial}{\partial t} \mathrm{~d}^{c} f_{t}\right) \wedge \operatorname{Im} \Upsilon_{t},  \tag{71}\\
\operatorname{Im}\left(\gamma_{t}\right)= & -2\left|\Upsilon_{t}\right|_{\omega_{t}}^{2} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right) \wedge \omega_{t}+A\left|\Upsilon_{t}\right|_{\omega_{t}} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right) \wedge \omega_{t} \tag{72}
\end{align*}
$$

Sketch of Proof. The proof is similar to that of Theorem 3.6, one just has to incorporate the extra terms computed in (67). Recall that the dual 4 -form $\psi_{t}$ given by the expression

$$
\begin{equation*}
\psi_{t}=-\eta_{t} \wedge \operatorname{Im} \Upsilon_{t}+\frac{1}{2} \omega_{t}^{2} \tag{73}
\end{equation*}
$$

and so

$$
\begin{equation*}
\frac{\partial}{\partial t} \psi_{t}=-\eta_{t} \wedge\left(\frac{\partial}{\partial t} \operatorname{Im} \Upsilon\right)+\frac{1}{2}\left(\frac{\partial}{\partial t} \omega_{t}^{2}\right)-\left(\frac{\partial}{\partial t} \eta_{t}\right) \wedge \operatorname{Im} \Upsilon_{t} \tag{74}
\end{equation*}
$$

Applying Proposition 3.5 and (67), the modified coflow implies the evolution equation

$$
\begin{aligned}
& \frac{\partial}{\partial t}\left(-\eta_{t} \wedge \operatorname{Im} \Upsilon_{t}+\frac{1}{2} \omega_{t}^{2}\right) \\
& =\mathcal{L}_{\nabla_{t}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right)}\left(-\eta_{t} \wedge \operatorname{Im} \Upsilon_{t}-\frac{1}{2} \omega_{t}^{2}\right)+4\left|\Upsilon_{t}\right|_{\omega_{t}}^{2} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right) \eta_{t} \wedge \omega_{t}+2|\Upsilon|_{\omega_{t}}^{2} \omega_{t}^{2} \\
& \quad-\frac{A}{\left|\Upsilon_{t}\right|_{\omega_{t}}} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right) \wedge \operatorname{Re}\left(\Upsilon_{t}\right)+A\left|\Upsilon_{t}\right|_{\omega_{t}} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right) \wedge \eta_{t} \wedge \omega_{t}+A\left|\Upsilon_{t}\right|_{\omega_{t}} \omega_{t}^{2} \\
& \quad-6\left|\Upsilon_{t}\right|_{\omega_{t}}^{2} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right) \wedge \eta_{t} \wedge \omega_{t}-3\left|\Upsilon_{t}\right|_{\omega_{t}}^{2} \omega_{t}^{2} \\
& =\mathcal{L}_{\nabla_{t}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right)}\left(-\eta_{t} \wedge \operatorname{Im} \Upsilon_{t}-\frac{1}{2} \omega_{t}^{2}\right)-2\left|\Upsilon_{t}\right|_{\omega_{t}}^{2} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right) \eta_{t} \wedge \omega_{t}-|\Upsilon|_{\omega_{t}}^{2} \omega_{t}^{2} \\
& \quad-\frac{A}{\left|\Upsilon_{t}\right|_{\omega_{t}}} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right) \wedge \operatorname{Re}\left(\Upsilon_{t}\right)+A\left|\Upsilon_{t}\right|_{\omega_{t}} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right) \wedge \eta_{t} \wedge \omega_{t}+A\left|\Upsilon_{t}\right|_{\omega_{t}} \omega_{t}^{2}
\end{aligned}
$$

By the proof of Theorem 3.6, we have

$$
\mathcal{L}_{\nabla_{t}\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right)}\left(\eta_{t} \wedge \operatorname{Im} \Upsilon_{t}\right)
$$

$$
\begin{equation*}
\left.=\left(\mathcal{L}_{\nabla_{t}\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right)} \mathrm{d}^{c} f_{t}\right) \wedge \operatorname{Im} \Upsilon_{t}+\left(\nabla_{t}\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right)\right\lrcorner \omega\right) \wedge \operatorname{Im} \Upsilon_{t}+\eta_{t} \wedge\left(\mathcal{L}_{\nabla_{t}\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right)} \operatorname{Im} \Upsilon_{t}\right) \tag{75}
\end{equation*}
$$

Applying the Ansätze (68) and (69), we are left with

$$
\begin{align*}
& -\left(\frac{\partial}{\partial t} \eta_{t}\right) \wedge \operatorname{Im} \Upsilon_{t}-\eta_{t} \wedge \operatorname{Im}\left(\gamma_{t}\right)+\beta_{t} \wedge \omega_{t} \\
& =-2\left|\Upsilon_{t}\right|_{\omega_{t}}^{2} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right) \wedge \eta_{t} \wedge \omega_{t}-\left|\Upsilon_{t}\right|_{\omega_{t}}^{2} \omega_{t}^{2} \\
& \quad-\frac{A}{\left|\Upsilon_{t}\right|_{\omega_{t}}} d\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right) \wedge \operatorname{Re}\left(\Upsilon_{t}\right)+A\left|\Upsilon_{t}\right|_{\omega_{t}} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right) \wedge \eta_{t} \wedge \omega_{t}+A\left|\Upsilon_{t}\right|_{\omega_{t}} \omega_{t}^{2} \\
& \left.\left.\quad-\left(\mathcal{L}_{\nabla_{t}\left(\log \left|\Upsilon_{t}\right| \omega_{t}\right)}\right)^{c} f_{t}\right) \wedge \operatorname{Im} \Upsilon_{t}-\left(\nabla_{t}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right)\right\lrcorner \omega\right) \wedge \operatorname{Im} \Upsilon_{t} \tag{76}
\end{align*}
$$

Contracting with the Reeb vector field $\xi$, we get

$$
\begin{equation*}
\operatorname{Im}\left(\gamma_{t}\right)=-2\left|\Upsilon_{t}\right|_{\omega_{t}}^{2} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right) \wedge \omega_{t}+A\left|\Upsilon_{t}\right|_{\omega_{t}} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}}\right) \wedge \omega_{t} \tag{77}
\end{equation*}
$$

The other equation is obtained by substituting the above into (76).

## 4 Solutions from a particular initial condition

We now study a particular solution of the modified Laplacian coflow (2) analogous to that obtained in [LSES22].
Let $\left(M^{7}, \eta, \Phi, \Upsilon\right)$ be a contact Calabi-Yau 7-manifold and suppose that ( $\omega, \Upsilon$ ) is a transverse Calabi-Yau structure, that is, $\omega=\mathrm{d} \eta$ is transverse Ricci-flat and $\Upsilon$ is a nowhere-vanishing transverse holomorphic (3,0)form. Recall that in this case, the norm $|\Upsilon|_{\omega}$ is constant and can be scaled to be 1 . Consider a family of $\mathrm{G}_{2}$-structures on $M$ defined by

$$
\begin{equation*}
\varphi_{t}=b_{t}^{3} \operatorname{Re} \Upsilon+a_{t} b_{t}^{2} \eta \wedge \omega \tag{78}
\end{equation*}
$$

where the functions $a_{t}, b_{t}$ depend only on $t$ and are constant on $M$. The induced metrics $g_{t}$ and volume forms $\mathrm{vol}_{t}$ can be checked to be

$$
\begin{equation*}
g_{t}=a_{t}^{2} \eta^{2}+\left.b_{t}^{2} g\right|_{\mathcal{D}} \quad \text { and } \quad \operatorname{vol}_{t}=\left.a_{t} b_{t}^{6} \eta \wedge \operatorname{vol}\right|_{\mathcal{D}} \tag{79}
\end{equation*}
$$

It follows that the dual 4-form $\psi_{t}$ is

$$
\begin{equation*}
\psi_{t}=-a_{t} b_{t}^{3} \eta \wedge \operatorname{Im} \Upsilon+\frac{1}{2} b_{t}^{4} \omega^{2} \tag{80}
\end{equation*}
$$

We set initial conditions for the fibre radius $a_{0}=\varepsilon$ and basic scale $b_{0}=1$, so that

$$
\begin{equation*}
\varphi_{0}=\operatorname{Re} \Upsilon+\varepsilon \eta \wedge \omega \quad \text { and } \quad \psi_{0}=-\varepsilon \eta \wedge \operatorname{Im} \Upsilon+\frac{1}{2} \omega^{2} \tag{81}
\end{equation*}
$$

We have the following expressions for exterior derivatives and torsion forms along the family $\left\{\varphi_{t}\right\}$.
Lemma 4.1 ([LSES22]). Let $\varphi_{t}$ be defined by (78), then

$$
\begin{equation*}
\mathrm{d} \varphi_{t}=a_{t} b_{t}^{2} \omega^{2}, \quad \mathrm{~d} \psi_{t}=0, \quad *_{t} \mathrm{~d} \varphi_{t}=2 a_{t}^{2} \eta \wedge \omega \tag{82}
\end{equation*}
$$

As such, the torsion forms are

$$
\begin{equation*}
\left(\tau_{0}\right)_{t}=\frac{6 a_{t}}{7 b_{t}^{2}}, \quad\left(\tau_{1}\right)_{t}=0, \quad\left(\tau_{2}\right)_{t}=0, \quad\left(\tau_{3}\right)_{t}=-\frac{6}{7} a_{t} b_{t} \operatorname{Re} \Upsilon+\frac{8}{7} a_{t}^{2} \eta \wedge \omega \tag{83}
\end{equation*}
$$

Moreover, the full torsion 2-tensor $T_{t}$ is given by

$$
\begin{equation*}
T_{t}=-\frac{3}{2} a_{t}^{3} b_{t}^{-2} \eta^{2}+\left.\frac{1}{2} a_{t} g\right|_{\mathcal{D}}=-2 a_{t}^{3} b_{t}^{-2} \eta^{2}+\frac{1}{2} a_{t} b_{t}^{-2} g_{t} \tag{84}
\end{equation*}
$$

and it has the following derived quantities:

$$
\begin{equation*}
\left|T_{t}\right|_{g_{t}}^{2}=\frac{15}{4} a_{t}^{2} b_{t}^{-4}, \quad \operatorname{div} T_{t}=0, \quad\left|\nabla_{t} T_{t}\right|_{g_{t}}^{2}=c_{0} a_{t}^{4} b_{t}^{-8} \tag{85}
\end{equation*}
$$

for some constant $c_{0} \in \mathbb{R}$.

### 4.1 Solving the modified Laplacian coflow

We now proceed in a similar way to [LSES22], obtaining an ODE in terms of $a_{t}$ and $b_{t}$ such that the family $\left\{\varphi_{t}\right\}$ satisfies the modified coflow.

Theorem 4.2. The family of $\mathrm{G}_{2}$-structures $\left\{\varphi_{t}\right\}$ defined by (78) solves the modified Laplacian coflow with initial condition (81) if, and only if, the functions $a_{t}$ and $b_{t}$ satisfy:

$$
\begin{align*}
a_{t} & =\varepsilon b_{t}^{-3}  \tag{86}\\
\frac{d}{d t} b_{t} & =\frac{1}{2} \varepsilon b_{t}^{-9}\left(A b_{t}^{5}-\varepsilon\right) \tag{87}
\end{align*}
$$

with $a_{0}=\varepsilon$ and $b_{0}=1$.
Proof. One can readily check that

$$
\begin{equation*}
\Delta_{t} \psi_{t}=\mathrm{d} *_{t} \mathrm{~d} \varphi_{t}=\mathrm{d}\left(2 a_{t}^{2} \eta \wedge \omega\right)=2 a_{t}^{2} \omega^{2} \tag{88}
\end{equation*}
$$

Additionally from Lemma 4.1, we have

$$
\begin{equation*}
\mathrm{d}\left(\left(A-\frac{7}{2}\left(\tau_{0}\right)_{t}\right) \varphi_{t}\right)=\left(A-3 \frac{a_{t}}{b_{t}^{2}}\right) a_{t} b_{t}^{2} \omega^{2}=a_{t}\left(A b_{t}^{2}-3 a_{t}\right) \omega^{2} . \tag{89}
\end{equation*}
$$

Assuming our Ansatz along the flow, we have

$$
\begin{equation*}
\frac{\partial}{\partial t} \psi_{t}=\frac{1}{2} \frac{d}{d t}\left(b_{t}^{4}\right) \omega^{2}-\frac{d}{d t}\left(a_{t} b_{t}^{3}\right) \eta \wedge \operatorname{Im} \Upsilon, \tag{90}
\end{equation*}
$$

hence the modified coflow results in the evolution equations

$$
\begin{equation*}
\frac{d}{d t}\left(b_{t}^{4}\right)=2 a_{t}\left(A b_{t}^{2}-a_{t}\right) \quad \text { and } \quad \frac{d}{d t}\left(a_{t} b_{t}^{3}\right)=0 \tag{91}
\end{equation*}
$$

The latter equation and initial conditions imply that $a_{t}=\varepsilon b_{t}^{-3}$. Plugging this back into the former equation yields

$$
\begin{equation*}
\frac{d}{d t}\left(b_{t}^{4}\right)=2 \varepsilon b_{t}^{-6}\left(A b_{t}^{5}-\varepsilon\right) \tag{92}
\end{equation*}
$$

or, equivalently,

$$
\begin{equation*}
\frac{d}{d t} b_{t}=\frac{1}{2} \varepsilon b_{t}^{-9}\left(A b_{t}^{5}-\varepsilon\right), \tag{93}
\end{equation*}
$$

as claimed.
In particular, when $A=0$, substituting $a_{t}=\varepsilon b_{t}^{-3}$ into (87) gives:
Corollary 4.3. Consider the functions

$$
\begin{align*}
& a_{t}=\varepsilon\left(1-5 \varepsilon^{2} t\right)^{-\frac{3}{10}},  \tag{94}\\
& b_{t}=\left(1-5 \varepsilon^{2} t\right)^{\frac{1}{10}} . \tag{95}
\end{align*}
$$

Then the family $\left\{\varphi_{t}\right\}$ of $\mathrm{G}_{2}$-structures defined by (78) satisfies the modified Laplacian coflow with constant $A=0$.

### 4.2 Singularity analysis

Since $a_{t}$ is an explicit function of $b_{t}$, then $\varphi_{t}$ depends only on $b_{t}$. Consequently, the Riemannian tensors relevant to the modified Laplacian coflow are derived from and measured by the $\mathrm{G}_{2}$-metric (79) induced by $\varphi_{t}$. Therefore, we are particularly interested in the behavior of the system:

$$
\begin{equation*}
\frac{d}{d t} b_{t}=\frac{1}{2} \varepsilon b_{t}^{-9}\left(A b_{t}^{5}-\varepsilon\right) . \tag{96}
\end{equation*}
$$

Understanding the dynamics of $b_{t}$ will provide insight into the evolution of the $\mathrm{G}_{2}$-structure and the associated geometric quantities under the modified Laplacian coflow.

| Condition | Steady State | Solution Behavior |
| :---: | :---: | :---: |
| $A<0$ | $\left(\frac{\varepsilon}{A}\right)^{\frac{1}{5}}<0$ (stable) | $b_{t}$ with $b_{0}=1$ monotonically decreasing |

Table 1: Summary of steady state and solution behaviour for various regimes of $A$ and $\varepsilon$.
The ODE (96) is separable, and it can be checked that if $A \neq 0, \varepsilon$, then the solution with $b_{0}=1$ satisfies

$$
\begin{equation*}
\frac{b^{5}}{5 A}+\frac{\varepsilon}{5 A^{2}} \ln \left|A b^{5}-\varepsilon\right|=\frac{1}{2} \varepsilon t+\frac{1}{5 A}+\frac{\varepsilon}{5 A^{2}} \ln |A-\varepsilon| \tag{97}
\end{equation*}
$$

If $A<\varepsilon$, then the solution $b \rightarrow 0$ as

$$
\begin{equation*}
t \rightarrow \frac{2}{5 \varepsilon A}\left[\frac{\varepsilon}{A} \ln \left|\frac{\varepsilon}{\varepsilon-A}\right|-1\right] \tag{98}
\end{equation*}
$$

and $A>\varepsilon$ then the solution $b \rightarrow \infty$ as $t \rightarrow \infty$.
Following the approach in [LSES22], we can use a similar quantity to characterize the formation of finitetime singularities when $A=0$ using the explicit expression for $b_{t}$. Define

$$
\Lambda(x, t)=\left(|R m(x, t)|_{g_{t}}^{2}+|T(x, t)|_{g_{t}}^{4}+\left|\nabla^{g_{t}} T(x, t)\right|_{g_{t}}^{2}\right)^{\frac{1}{2}}
$$

for $x \in M$ and time $t$. We then let

$$
\begin{equation*}
\Lambda(t)=\sup _{x \in M} \Lambda(x, t) \tag{99}
\end{equation*}
$$

As a direct consequence of [LSES22, Proposition 3.5], we find that the norm of the Riemann curvature tensor associated with the metric $g_{t}$, related to the solution of the modified Laplacian coflow $\varphi_{t}$, is given by

$$
\begin{equation*}
\left|R m_{t}\right|_{g_{t}}^{2}=b_{t}^{-4}\left|R m_{0}^{\mathcal{D}_{0}}\right|_{g_{0}}^{2}+b_{t}^{-20} c_{0} \varepsilon^{4} \tag{100}
\end{equation*}
$$

We can plug in the quantities from Lemma 4.1 to compute $\Lambda$ of the family of $\mathrm{G}_{2}$-structures $\left\{\varphi_{t}\right\}$ defined by (78), which solves the modified Laplacian coflow with initial condition (81) and satisfies the system (86) and (87). In particular, we get

$$
\Lambda(x, t)=b_{t}^{-10}\left(b_{t}^{16}\left|R m(x)_{0}^{\mathcal{D}_{0}}\right|_{g_{0}}^{2}+2 c_{0} \varepsilon^{4}+\left(\frac{15}{4}\right)^{2} \varepsilon^{4}\right)^{\frac{1}{2}}
$$

Definition 4.4. Suppose that $\left(M^{7}, \varphi_{t}, \psi_{t}, g_{t}\right)$ is a solution to a flow of $\mathrm{G}_{2}$-structures on a closed manifold on a maximal time interval $[0, T)$ and let $\Lambda(t)$ be as in (99).

If we have a finite-time singularity, i.e. $T<\infty$, we say that the solution forms

- a Type I singularity (rapidly forming) if $\sup _{t \in[0, T)}(T-t) \Lambda(t)<\infty$; and otherwise
- a Type IIa singularity (slowly forming) if $\sup _{t \in[0, T)}(T-t) \Lambda(t)=\infty$.

If $A=0$, as indicated by Corollary 4.3, the solutions take the form $a_{t}=\varepsilon\left(1-5 \varepsilon^{2} t\right)^{-3 / 10}$ and $b_{t}=$ $\left(1-5 \varepsilon^{2} t\right)^{1 / 10}$. In this context, we can analyze the asymptotic behavior of the solutions of the modified Laplacian coflow, akin to the approach outlined in [LSES22]. Specifically, we explore how the solutions behave as $t$ approaches the maximal time $\frac{1}{5 \varepsilon^{2}}$, drawing parallels to the conclusions drawn in the study of the Laplacian flow in [LSES22].

Proposition 4.5. Let $\left(M^{7}, \eta, \Phi, \Upsilon\right)$ be a compact contact Calabi-Yau 7 -manifold with transverse Ricci-flat Kähler form $\omega=d \eta$ and transverse holomorphic $(3,0)$-form $\Upsilon$. The solution to the modified Laplacian coflow with $A=0$ and initial condition (81) has a Type I finite-time singularity at $T=\frac{1}{5 \varepsilon^{2}}$. Further, after normalising $\left(M, g_{t}\right)$ to a fixed volume, the solution collapses to $\mathbb{R}$, as $t \rightarrow T$.

## 5 Breaking the Sasakian structure on a $c C Y^{7}$

We now revisit the setup from $\S 3$, on a contact Calabi-Yau 7 -manifold ( $M^{7}, \eta, \Phi, \Upsilon$ ). Recall that we considered deformations of type II, given by a 1-parameter family of basic functions $\left\{f_{t}\right\}$, which determines at each $t$ the contact form $\eta_{t}$, and transverse Kähler form $\omega_{t}$ by

$$
\begin{align*}
\eta_{t} & =\eta+\mathrm{d}^{c} f_{t}  \tag{101}\\
\omega_{t} & =d \eta+\mathrm{dd}^{c} f_{t} \tag{102}
\end{align*}
$$

Using ideas from [PS22] and the transverse $\partial \bar{\partial}$-lemma of [EKA90] (see Appendix A), we now allow the transverse Kähler structure to vary within the basic cohomology class $[\mathrm{d} \eta]_{B}$. This added freedom does not change the transverse complex structure $J$, and so $\Upsilon$ remains a transverse holomorphic volume form throughout.

In other words, we consider on $(M, \eta, \Phi, \Upsilon)$ a transverse $\mathrm{SU}(3)$-structure $\left(\omega^{\prime}, \Upsilon\right)$, where $\omega^{\prime} \in[\mathrm{d} \eta]_{B}$. By El Kacimi-Alaoui's transverse $\partial \bar{\partial}$-lemma, we can write

$$
\begin{equation*}
\omega^{\prime}=\mathrm{d} \eta+\operatorname{dd}^{c} h, \tag{103}
\end{equation*}
$$

where $h$ is a basic function. Note that we are determining the function $h$ (up to addition of a constant) from our choice of $\omega^{\prime}$ and not vice versa. In some sense, we can consider this a breaking of the Sasakian structure, since the transverse Kähler form $\omega^{\prime}$ is no longer determined by the contact form $\eta$.

In a similar manner to $\S 3$, we define a $\mathrm{G}_{2}$-structure by

$$
\begin{equation*}
\varphi=\operatorname{Re}\left(\frac{1}{|\Upsilon|_{\omega^{\prime}}} \Upsilon\right)+|\Upsilon|_{\omega^{\prime}} \eta \wedge \omega^{\prime} \tag{104}
\end{equation*}
$$

One can verify that the induced metric and volume form on $M$ are

$$
\begin{equation*}
g=|\Upsilon|_{\omega^{\prime}}^{2} \eta^{2}+\left.g^{\prime}\right|_{\mathcal{D}}, \quad \text { and } \quad \operatorname{vol}=\left.|\Upsilon|_{\omega^{\prime}} \eta \wedge \operatorname{vol}^{\prime}\right|_{\mathcal{D}} \tag{105}
\end{equation*}
$$

Furthermore, the Hodge star operator acts on a basic $k$-form $\alpha$ by

$$
\begin{align*}
* \alpha & =(-1)^{k}|\Upsilon|_{\omega^{\prime}}\left(\eta \wedge *_{B} \alpha\right)  \tag{106}\\
*(\eta \wedge \alpha) & =\frac{1}{|\Upsilon|_{\omega^{\prime}}} * \alpha \tag{107}
\end{align*}
$$

Hence the dual 4-form is

$$
\begin{equation*}
\psi=* \varphi=\eta \wedge \operatorname{Im} \Upsilon+\frac{1}{2} \omega^{\prime 2} \tag{108}
\end{equation*}
$$

It is easy to see that $\mathrm{d} \psi=0$ and so $\varphi$ is a coclosed $\mathrm{G}_{2}$-structure. As in $\S 3$, we compute the torsion forms and the Hodge Laplacian of this $\mathrm{G}_{2}$-structure.

Proposition 5.1. Let $(M, \eta, \Phi, \Upsilon)$ be a contact Calabi-Yau 7-manifold. Let $\omega^{\prime} \in[\mathrm{d} \eta]_{B}$ be a transverse Kähler structure and $\varphi$ be the $\mathrm{G}_{2}$-structure defined by (104). Then the torsion forms of $\varphi$ are given by

$$
\begin{equation*}
\tau_{0}=\frac{6}{7}|\Upsilon|_{\omega^{\prime}}, \quad \tau_{1}=0, \quad \tau_{2}=0 \tag{109}
\end{equation*}
$$

and

$$
\begin{equation*}
\left.\tau_{3}=\left(\nabla \log |\Upsilon|_{\omega^{\prime}}\right)\right\lrcorner\left(-\eta \wedge \operatorname{Im} \Upsilon-\frac{1}{2} \omega^{\prime 2}\right)-\frac{6}{7} \operatorname{Re} \Upsilon+\frac{8}{7}|\Upsilon|_{\omega^{\prime}}^{2} \eta \wedge d \eta \tag{110}
\end{equation*}
$$

The proof is similar to that of Proposition 3.4, however Kähler identities are invoked to deal with the extra terms. Analogous methods yield the Hodge Laplacian:

Proposition 5.2. Let $(M, \eta, \Phi, \Upsilon)$ be a contact Calabi-Yau 7 -manifold Let $\omega^{\prime} \in[\mathrm{d} \eta]_{B}$ be a transverse Kähler structure and $\varphi$ be the $\mathrm{G}_{2}$-structure defined by (104). Then we have

$$
\begin{align*}
\Delta \psi & =\mathcal{L}_{\nabla\left(\log |\Upsilon|_{\omega^{\prime}}\right)}\left(-\eta \wedge \operatorname{Im} \Upsilon-\frac{1}{2} \omega^{\prime 2}\right)  \tag{111}\\
& +2|\Upsilon|_{\omega^{\prime}}^{2} \mathrm{~d}\left(\log |\Upsilon|_{\omega^{\prime}}\right) \wedge \eta \wedge\left[3 \omega^{\prime}-\mathrm{d} \eta\right]+|\Upsilon|_{\omega^{\prime}}^{2} d \eta \wedge\left[3 \omega^{\prime}-\mathrm{d} \eta\right]
\end{align*}
$$

### 5.1 The Laplacian coflow

We now apply the Laplacian coflow equation to a family of such structures and consider Ansätze on our choices of $\eta_{t}$, $\omega_{t}^{\prime}$ and $\Upsilon_{t}$. We recall that our construction of $\mathrm{G}_{2}$-structures previously required certain compatibility conditions to hold.

Theorem 5.3. Let $\left(M^{7}, \eta, \Phi, \Upsilon\right)$ be a contact Calabi-Yau 7 -manifold and let $\omega^{\prime} \in[\mathrm{d} \eta]_{B}$ be a transverse Kähler form. Suppose we have a family of contact forms $\eta_{t}$ and a family of compatible transverse $\mathrm{SU}(3)$-structure $\left(\omega_{t}^{\prime}, \Upsilon_{t}\right)$ on $M$ with initial conditions $\eta_{0}=\eta, \omega_{0}^{\prime}=\omega^{\prime}$ and $\Upsilon_{0}=\Upsilon$ satisfying the coupled differential equations:

$$
\begin{align*}
\frac{\partial}{\partial t} \eta_{t} & =\mathcal{L}_{\nabla_{t}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}}\right)} \eta_{t}+\alpha_{t}  \tag{112}\\
\frac{\partial}{\partial t} \omega_{t}^{\prime} & =-\mathcal{L}_{\nabla_{t}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}}\right)} \omega_{t}^{\prime}+\beta_{t}  \tag{113}\\
\frac{\partial}{\partial t} \Upsilon_{t} & =\mathcal{L}_{\nabla_{t}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}}\right)} \Upsilon_{t}+\gamma_{t} \tag{114}
\end{align*}
$$

Then the family of $\mathrm{G}_{2}$-structures given by

$$
\begin{equation*}
\varphi_{t}=\operatorname{Re}\left(\frac{1}{|\Upsilon|_{\omega^{\prime}}} \Upsilon\right)+|\Upsilon|_{\omega^{\prime}} \eta_{t} \wedge \omega_{t}^{\prime} \tag{115}
\end{equation*}
$$

is a solution to the Laplacian coflow (1) if, and only if,

$$
\begin{align*}
\alpha_{t} & =0  \tag{116}\\
-\eta_{t} \wedge \gamma_{t}-\omega_{t}^{\prime} \wedge \beta_{t} & =2|\Upsilon|_{\omega^{\prime}} \mathrm{d}\left(\log |\Upsilon|_{\omega^{\prime}}\right) \wedge \eta_{t} \wedge\left[3 \omega_{t}^{\prime}-\mathrm{d} \eta_{t}\right]+|\Upsilon|_{\omega^{\prime}}^{2} \mathrm{~d} \eta \wedge\left[3 \omega_{t}^{\prime}-\mathrm{d} \eta_{t}\right] \tag{117}
\end{align*}
$$

Proof. We see that the associated 4-form is given by

$$
\begin{equation*}
\psi_{t}=-\eta_{t} \wedge \operatorname{Im} \Upsilon_{t}+\frac{1}{2}\left(\omega_{t}^{\prime}\right)^{2} \tag{118}
\end{equation*}
$$

Differentiating with respect to time, we get

$$
\frac{\partial}{\partial t} \psi_{t}=-\eta_{t} \wedge\left(\frac{\partial}{\partial t} \operatorname{Im} \Upsilon_{t}\right)-\frac{1}{2}\left(\frac{\partial}{\partial t}\left(\omega_{t}^{\prime}\right)^{2}\right)-\left(\frac{\partial}{\partial t} \eta_{t}\right) \wedge \operatorname{Im} \Upsilon_{t}
$$

Applying Proposition 5.2 we get

$$
-\eta_{t} \wedge\left(\frac{\partial}{\partial t} \operatorname{Im} \Upsilon_{t}\right)-\left(\frac{\partial}{\partial t} \eta_{t}\right) \wedge \operatorname{Im} \Upsilon_{t}-\frac{1}{2}\left(\frac{\partial}{\partial t}\left(\omega_{t}^{\prime}\right)^{2}\right)
$$

$$
\begin{aligned}
= & \mathcal{L}_{\nabla_{t}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}}\right.}\left(-\eta_{t} \wedge \operatorname{Im} \Upsilon_{t}-\frac{1}{2}\left(\omega_{t}^{\prime}\right)^{2}\right) \\
& +2\left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}}^{2} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}}\right) \wedge \eta_{t} \wedge\left[3 \omega_{t}^{\prime}-\mathrm{d} \eta_{t}\right]+\left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}}^{2} \mathrm{~d} \eta_{t} \wedge\left[3 \omega_{t}^{\prime}-\mathrm{d} \eta_{t}\right]
\end{aligned}
$$

Substituting in the systems (112)-(114), we obtain

$$
-\eta_{t} \wedge \gamma_{t}-\alpha_{t} \wedge \operatorname{Im} \Upsilon_{t}-\omega_{t}^{\prime} \wedge \beta_{t}=2\left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}}^{2} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}}\right) \wedge \eta_{t} \wedge\left[3 \omega_{t}^{\prime}-\mathrm{d} \eta_{t}\right]+\left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}}^{2} \mathrm{~d} \eta_{t} \wedge\left[3 \omega_{t}^{\prime}-d \eta_{t}\right]
$$

We now consider the type decomposition of each term in the above expression with respect to the transverse complex structure $J_{t}$. On the RHS, the first term is of type $\eta_{t} \wedge[(1,2) \oplus(2,1)]$ and the second term is of type (2,2). On the other hand, term $\operatorname{Im} \Upsilon_{t}$ is of type $(0,3) \oplus(3,0)$ and $\omega_{t}^{\prime}$ is of type $(1,1)$. We conclude that $\alpha_{t}=0$, and we obtain the desired expression relating $\beta_{t}$ and $\gamma_{t}$. In addition, we see that $\beta_{t}$ is of type $\eta_{t} \wedge[(0,1) \oplus(1,0)] \oplus(1,1)$ and $\gamma_{t}$ is of type $(1,2) \oplus(2,1)$.

### 5.2 The modified Laplacian coflow

We perform a similar analysis of the modified Laplacian coflow as that of $\S 3.3$, for this new Ansatz. Once again, we note that the torsion form $\tau_{0}=\frac{6}{7}|\Upsilon|_{\omega^{\prime}}$, hence the extra terms with constant $A$ are given by

$$
\begin{align*}
\mathrm{d}\left(\left(A-\frac{7}{2} \tau_{0}\right) \varphi\right)=- & \frac{A}{|\Upsilon|_{\omega^{\prime}}} d\left(\log |\Upsilon|_{\omega^{\prime}}\right) \wedge \operatorname{Re}(\Upsilon)+A|\Upsilon|_{\omega^{\prime}} d\left(\log |\Upsilon|_{\omega^{\prime}}\right) \wedge \eta \wedge \omega^{\prime}+A|\Upsilon|_{\omega^{\prime}} d \eta \wedge \omega^{\prime} \\
& -6|\Upsilon|_{\omega^{\prime}}^{2} d\left(\log |\Upsilon|_{\omega^{\prime}}\right) \wedge \eta \wedge \omega^{\prime}-3|\Upsilon|_{\omega^{\prime}}^{2} d \eta \wedge \omega^{\prime} \tag{119}
\end{align*}
$$

Taking into account these extra terms, we get the analogous result for the modified coflow.
Theorem 5.4. Let $\left(M^{7}, \eta, \Phi, \Upsilon\right)$ be a contact Calabi-Yau 7 -manifold and let $\omega^{\prime} \in[d \eta]_{B}$ be a transverse Kähler form. Suppose we have a family of contact forms $\left\{\eta_{t}\right\}$ and a family of compatible transverse $\mathrm{SU}(3)$-structure $\left(\omega_{t}^{\prime}, \Upsilon_{t}\right)$ on $M$, with initial conditions $\eta_{0}=\eta, \omega_{0}^{\prime}=\omega^{\prime}$ and $\Upsilon_{0}=\Upsilon$, satisfying the coupled differential equations

$$
\begin{align*}
\frac{\partial}{\partial t} \eta_{t} & =\mathcal{L}_{\nabla_{t}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}}\right)} \eta_{t}+\alpha_{t}  \tag{120}\\
\frac{\partial}{\partial t} \omega_{t}^{\prime} & =-\mathcal{L}_{\nabla_{t}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}}\right)} \omega_{t}^{\prime}+\beta_{t},  \tag{121}\\
\frac{\partial}{\partial t} \Upsilon_{t} & =\mathcal{L}_{\nabla_{t}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}}\right.} \Upsilon_{t}+\gamma_{t} . \tag{122}
\end{align*}
$$

Then the family of $\mathrm{G}_{2}$-structures given by

$$
\begin{equation*}
\varphi_{t}=\operatorname{Re}\left(\frac{1}{|\Upsilon|_{\omega^{\prime}}} \Upsilon\right)+|\Upsilon|_{\omega^{\prime}} \eta_{t} \wedge \omega_{t}^{\prime} \tag{123}
\end{equation*}
$$

is a solution to the modified coflow (2) if, and only if,

$$
\begin{align*}
\alpha_{t} & =\frac{A}{\left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}}} \mathrm{d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}}\right)  \tag{124}\\
-\eta_{t} \wedge \gamma_{t}-\omega_{t}^{\prime} \wedge \beta_{t} & =2|\Upsilon|_{\omega^{\prime}} \mathrm{d}\left(\log |\Upsilon|_{\omega^{\prime}}\right) \wedge \eta_{t} \wedge\left[3 \omega_{t}^{\prime}-\mathrm{d} \eta_{t}\right]+|\Upsilon|_{\omega^{\prime}}^{2} \mathrm{~d} \eta \wedge\left[3 \omega_{t}^{\prime}-\mathrm{d} \eta_{t}\right] \\
& +A\left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}} \mathrm{d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}}\right) \wedge \eta_{t} \wedge \omega_{t}^{\prime}+A\left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}} \mathrm{d} \eta_{t} \wedge \omega_{t}^{\prime}  \tag{125}\\
& -6\left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}}^{2} \mathrm{~d}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}}\right) \wedge \eta_{t} \wedge \omega_{t}^{\prime}-3\left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}}^{2} \mathrm{~d} \eta_{t} \wedge \omega_{t}^{\prime}
\end{align*}
$$

### 5.3 Possible Further Directions

We speculate how to obtain solutions to the Laplacian coflows from this setup. To do this, we continue from the previous section and follow [PS22], by considering pullback via a family of diffeomorphisms. Suppose $\widetilde{\omega}_{t}{ }^{\prime}$ is the solution to some perturbed Sasaki-Ricci (transverse Kähler-Ricci) flow (see [SWZ10])

$$
\begin{equation*}
\frac{\partial}{\partial t} \widetilde{\omega}_{t}^{\prime}=-2 \operatorname{Ric}^{T}\left(\widetilde{\omega}_{t}^{\prime}, J\right)+\widetilde{\beta}_{t} \tag{126}
\end{equation*}
$$

where $\operatorname{Ric}^{T}$ denotes the transverse Ricci form. We can use these transverse Kähler forms to define a timedependent vector field

$$
\begin{equation*}
Y_{t}={\widetilde{\nabla_{t}}}_{t}^{\prime}\left(\log |\Upsilon|_{\widetilde{\omega_{t}}}\right) \tag{127}
\end{equation*}
$$

where $\widetilde{\nabla}_{t}^{\prime}$ denotes the Levi-Civita connection of $\widetilde{\omega}_{t}^{\prime}$. In turn, we can use this time-dependent vector field to obtain a family of diffeomorphisms $\Theta_{t}$ satisfying

$$
\begin{equation*}
\frac{\partial}{\partial t} \Theta_{t}(p)=Y_{t}(p), \quad \Theta_{0}=i d \tag{128}
\end{equation*}
$$

Suppose further that $\widetilde{\eta}_{t}$ and $\widetilde{\Upsilon}_{t}$ are flows of contact forms and transverse holomorphic volume forms, respectively, satisfying appropriate compatibility conditions:

- $\left(\widetilde{\omega}_{t}^{\prime}, \widetilde{\Upsilon}_{t}\right)$ is a transverse $\mathrm{SU}(3)$-structure with respect to $\widetilde{\eta_{t}}$, and
- $\widetilde{\omega}_{t}^{\prime} \in\left[\mathrm{d} \widetilde{\eta}_{t}\right]_{B}$.

Writing $\frac{\partial}{\partial t} \widetilde{\eta}_{t}=\widetilde{\alpha}_{t}$ and $\frac{\partial}{\partial t} \widetilde{\Upsilon_{t}}=\widetilde{\gamma_{t}}$, and pulling back by the diffeomorphisms $\Theta_{t}$, we can define structures

$$
\eta_{t}=\Theta_{t}^{*} \widetilde{\eta}_{t}, \quad \omega_{t}^{\prime}=\Theta_{t}^{*} \widetilde{\omega}_{t}^{\prime}, \quad \Upsilon_{t}=\Theta_{t}^{*} \widetilde{\Upsilon_{t}}
$$

A computation shows that

$$
\begin{aligned}
\frac{\partial}{\partial t} \eta_{t} & =\mathcal{L}_{\nabla_{t}\left(\left.\log \left|\Upsilon_{t}\right|\right|_{\omega_{t}^{\prime}}\right)} \eta_{t}+\Theta_{t}^{*} \widetilde{\alpha_{t}} \\
\frac{\partial}{\partial t} \omega_{t}^{\prime} & =-\mathcal{L}_{\nabla_{t}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}}\right.} \omega_{t}^{\prime}+\Theta_{t}^{*} \widetilde{\beta}_{t} \\
\frac{\partial}{\partial t} \Upsilon_{t} & =\mathcal{L}_{\nabla_{t}\left(\log \left|\Upsilon_{t}\right|_{\omega_{t}^{\prime}}\right)} \Upsilon_{t}+\Theta_{t}^{*} \widetilde{\gamma_{t}}
\end{aligned}
$$

We thus see that if the auxiliary flows are chosen appropriately, then the pullback yields solutions to the Laplacian coflows.

Remark 5.5. Of course, one does not a priori know if such a choice can be made. Furthermore, the way in which $\widetilde{\Upsilon_{t}}$ can vary is quite restricted, because the transverse complex structure is fixed along the Sasaki-Ricci flow. As such, $\widetilde{\Upsilon_{t}}$ can only vary by phase shifts.
Remark 5.6. This method of obtaining potential solutions also does not encompass the solutions of the Laplacian coflow in [LSES22] and those of the modified coflow discuss in $\S 4$. This is because the functions $a_{t}$ and $b_{t}$ scale the transverse Kähler class. One can instead include similar scaling functions $a_{t}$ and $b_{t}$ depending on time to match those solutions, however these introduce more freedoms in how the parameters interact with one another.

The solutions in [LSES22] and §4 take advantage of starting with a transverse Ricci-flat Kähler structure, which greatly simplifies the evolution equations, as $\left|\Upsilon_{t}\right|_{\omega_{t}}$ is just a constant in that case. Altogether, these two methods suggest that a more general transverse flow should be considered, where $\widetilde{\omega}_{t}^{\prime}$ can be allowed to move freely through the transverse Kähler cone.

This pullback idea can be applied to the earlier cases in $\S 2$ and in $\S 3$ by adapting the equations accordingly. In those cases, we keep the $S^{1}$-invariance along the flow, and thus cannot even optimistically expect to obtain torsion-free $\mathrm{G}_{2}$ metrics with holonomy $\mathrm{G}_{2}$.

## A Sasakian manifolds

We briefly review Sasakian manifolds and discuss some useful results involving deformations of Sasakian structures. These occur at the beginning of $\S 3$ and $\S 5$, defining certain families of $\mathrm{G}_{2}$-structures on contact Calabi-Yau 7-manifolds.

Definition A.1. A contact structure on a $(2 n+1)$-manifold $M^{2 n+1}$ is a triple $(\xi, \eta, \Phi)$ where $\xi$ is a vector field (called the Reeb vector field), $\eta$ is a 1 -form (called the contact form), and $\Phi$ is a ( 1,1 )-tensor such that

$$
\begin{equation*}
\eta(\xi)=1, \quad \Phi^{2}=-1+\xi \otimes \eta \tag{129}
\end{equation*}
$$

and

$$
\begin{equation*}
\eta \wedge(\mathrm{d} \eta)^{n} \neq 0 \tag{130}
\end{equation*}
$$

Using the Reeb vector field $\xi$, we obtain a 1-foliation $\mathcal{F}_{\xi}$, and its dual 1-form $\eta$ determines a codimension 1 subbundle $\mathcal{D}=\operatorname{ker} \eta$ of $T M$. We have a canonical splitting

$$
\begin{equation*}
T M=\mathcal{D} \oplus L \xi \tag{131}
\end{equation*}
$$

where $L \xi$ is the line bundle spanned by $\xi$. The second condition in (129) implies that the restriction of $\Phi$ to $\mathcal{D}$ results in an almost-complex structure $J=\left.\Phi\right|_{\mathcal{D}}$. We can also consider the quotient bundle $\nu\left(\mathcal{F}_{\xi}\right)=T M / L \xi$ of the canonical foliation $\mathcal{F}_{\xi}$. This space can be identified with $\mathcal{D}$, however it is convenient to distinguish them, as we aim to deform Sasakian structures by varying one, while keeping the other one fixed.

A Riemannian metric $g$ on $M$ is compatible with the contact structure if

$$
\begin{equation*}
g(\Phi(X), \Phi(Y))=g(X, Y)-\eta(X) \eta(Y) \tag{132}
\end{equation*}
$$

for any vector fields $X, Y$ on $M$. Such a metric induces an almost-Hermitian metric on $\mathcal{D}$ and makes the decomposition in (131) orthogonal. In this case, the quadruple $(\xi, \eta, \Phi, g)$ is called a contact metric structure. If the metric cone $(C(M), \bar{g})=\left(\mathbb{R}_{>0} \times M, d r^{2}+r^{2} g\right)$ is Kähler, then we call the quadruple $(\xi, \eta, \Phi, g)$ a Sasakian structure. Since the Reeb vector field $\xi$ of a Sasakian structure defines several important spaces and bundles, we will define some properties related to basic $k$-forms.

Definition A.2. A $k$-form $\alpha$ on a contact manifold is called basic if

$$
\begin{equation*}
\xi\lrcorner \alpha=0, \quad \mathcal{L}_{\xi} \alpha=0 . \tag{133}
\end{equation*}
$$

Using Cartan's magic formula, one can see that the Lie derivative condition is equivalent to $\xi\lrcorner(d \alpha)=0$, and so the exterior derivative preserves basic forms. Basic cohomology classes, denoted by $[\cdot]_{B}$, can be defined in the usual way with the appropriate restrictions.

Given a Sasakian structure $\mathcal{S}=(\xi, \eta, \Phi, g)$ on $M^{2 n+1}$, we wish to deform it and obtain Sasakian structures that preserve the Reed vector field $\xi$. We denote this set by

$$
\begin{equation*}
\mathfrak{F}(\xi)=\left\{\text { Sasakian structures } \mathcal{S}^{\prime}=\left(\xi^{\prime}, \eta^{\prime}, \Phi^{\prime}, g^{\prime}\right): \xi^{\prime}=\xi\right\} \tag{134}
\end{equation*}
$$

Given two Sasakian structures $\mathcal{S}, \mathcal{S}^{\prime} \in \mathfrak{F}(\xi)$ with contact forms $\eta$ and $\eta^{\prime}$ respectively, one can check that $\zeta=$ $\eta-\eta^{\prime}$ is basic. As such $\left[\mathrm{d} \eta^{\prime}\right]_{B}=[\mathrm{d} \eta]_{B}$ and hence all Sasakian structures in $\mathfrak{F}(\xi)$ correspond to the same basic cohomology class.

Let $\bar{J}$ denote the induced complex structure on $\nu\left(\mathcal{F}_{\xi}\right)$ and let $\pi_{\nu} T M \rightarrow \nu\left(\mathcal{F}_{\xi}\right)$ be the quotient map. We define the subset $\mathfrak{F}(\xi, \bar{J}) \subseteq \mathfrak{F}(\xi)$ to be the subset of all Sasakian structures $\left(\xi^{\prime}, \eta^{\prime}, \Phi^{\prime}, g^{\prime}\right) \in \mathfrak{F}(\xi)$ such that the diagram

commutes. The elements of $\mathfrak{F}(\xi, \bar{J})$ are the Sasakian structures with the same transverse holomorphic structure $\bar{J}$.

We can now give an alternative description of $\mathfrak{F}(\xi, \bar{J})$, but first we need the transverse $\partial \bar{\partial}$ Lemma due to El Kacimi-Alaoui:

Proposition A. 3 ([EKA90]). Let $(M, \mathcal{S})$ be a compact Sasakian manifold, and $\omega$, $\omega^{\prime}$ be basic real closed $(1,1)$ forms such that $[\omega]_{B}=\left[\omega^{\prime}\right]_{B}$. Then there exists a smooth basic function $h$ such that

$$
\begin{equation*}
\omega^{\prime}=\omega+\sqrt{-1} \partial \bar{\partial} \phi=\omega+\operatorname{dd}^{c} h \tag{135}
\end{equation*}
$$

where $\mathrm{d}^{c}=\frac{\sqrt{-1}}{2}(\bar{\partial}-\partial)$.
As in the Kähler case, the basic 2 -form $\mathrm{d} \eta$ can be written locally in terms of a basic potential function $h$, ie. $\mathrm{d} \eta=\sqrt{-1} \partial \bar{\partial} h$, so Sasakian geometry is locally determined by a basic potential. There exists a characterization of the space of Sasakian metrics on $M$ whose Reeb vector field is $\xi$ and whose transverse holomorphic structure is $J$ as an affine space. We will not require the full description but will use the following:

Definition A.4. Given a Sasakian structure $\mathcal{S}=(\xi, \eta, \Phi, g) \in \mathfrak{F}(\xi, \bar{J})$, a transformation of the form $\eta \mapsto \eta^{\prime}=$ $\eta+\mathrm{d}^{c} h$ where $h$ is a basic function is an instance of a deformation of type II. Such a transformation induces a $(1,1)$-tensor $\Phi^{\prime}$ and Riemannian metric $g^{\prime}$ by

$$
\begin{aligned}
& \Phi^{\prime}=\Phi-\left(\xi \otimes\left(\mathrm{d}^{c} h\right)\right) \circ \Phi \\
& g^{\prime}=\mathrm{d} \eta^{\prime} \circ\left(1 \otimes \Phi^{\prime}\right)+\eta^{\prime} \otimes \eta^{\prime}
\end{aligned}
$$

The ensuing Sasakian structure $\mathcal{S}^{\prime}=\left(\xi, \eta^{\prime}, \Phi^{\prime}, g^{\prime}\right)$ also lies in $\mathfrak{F}(\xi, \bar{J})$.
Remark A.5. The definition of a deformation of type II is broader than what is stated above. We only make use of the specific case mentioned and refer the reader to [BG08, BGS08] for the broader context.
